# Uniqueness of ground states for combined power-type nonlinear scalar field equations involving the Sobolev critical exponent and a large frequency parameter in three and four dimensions

#### Abstract

We prove the uniqueness of ground states for combined power-type nonlinear scalar field equations involving the Sobolev critical exponent and a large frequency parameter. This study is motivated by the paper [2] and aims to remove the restriction on dimension imposed there. In this paper, we employ the fixed-point argument developed in [7] to prove the uniquness. Hence, the linearization around the AubinTalenti function plays a key role. Furthermore, we need some estimates for the associated perturbed resolvents (see Proposition 3.1).

## 1 Introduction

In this paper, we consider the following equation:

$$
\begin{equation*}
-\Delta u+\omega u-|u|^{p-1} u-|u|^{\frac{4}{d-2}} u=0 \quad \text { in } \mathbb{R}^{d} \tag{1.1}
\end{equation*}
$$

where $d \geq 3,1<p<\frac{d+2}{d-2}$ and $\omega>0$.
This study is motivated by the paper [2] and aims to remove the restriction on dimension imposed there. More precisely, our aim is to prove the uniqueness of ground states to (1.1) when $d=3,4$ and $\omega$ is large (see Theorem 1.1). We remark that when $\omega$ is small, the uniqueness had been proved in [3] for all $d \geq 3$. We also remark that the properties of ground states to (1.1) are important in the study of the following nonlinear Schrödinger and Klein-Gordon equations (see [3, 4, 13]):

i \frac{\partial u}{\partial t}+\Delta u+|u|^{p-1} u+|u|^{\frac{4}{d-2}} u=0 \\
\frac{\partial^{2} u}{\partial t^{2}}-\Delta u+u-|u|^{p-1} u-|u|^{\frac{4}{d-2}} u=0 \tag{1.3}
\end{array}
$$

In order to describe our main result, we introduce a few symbols:
Notation 1.1. 1. For each $d \geq 3$, we use $2^{*}$ to denote the Sobolev critical exponent, namely

$$
\begin{equation*}
2^{*}:=\frac{2 d}{d-2} \tag{1.4}
\end{equation*}
$$

2. For $d \geq 3,1<p<\frac{d+2}{d-2}$ and $\omega>0$, we define functionals $\mathcal{S}_{\omega}$ and $\mathcal{N}_{\omega}$ on $H^{1}\left(\mathbb{R}^{d}\right)$ by

$$
\begin{align*}
& \mathcal{S}_{\omega}(u):=\frac{\omega}{2}\|u\|_{L^{2}}^{2}+\frac{1}{2}\|\nabla u\|_{L^{2}}^{2}-\frac{1}{p+1}\|u\|_{L^{p+1}}^{p+1}-\frac{1}{2^{*}}\|u\|_{L^{2^{*}}}^{2^{*}},  \tag{1.5}\\
& \mathcal{N}_{\omega}(u):=\omega\|u\|_{L^{2}}^{2}+\|\nabla u\|_{L^{2}}^{2}-\|u\|_{L^{p+1}}^{p+1}-\|u\|_{L^{2^{*}}}^{2^{*}} \tag{1.6}
\end{align*}
$$

Next, we clarify terminology:
Definition 1.1. 1. Let $d \geq 3,1<p<\frac{d+2}{d-2}$ and $\omega>0$. Then, by a ground state to (1.1), we mean a minimizer for the following variational problem:

$$
\begin{equation*}
\inf \left\{\mathcal{S}_{\omega}(u): u \in H^{1}\left(\mathbb{R}^{d}\right) \backslash\{0\}, \mathcal{N}_{\omega}(u)=0\right\} \tag{1.7}
\end{equation*}
$$

2. We use the term "radial" to mean radially symmetric about $0 \in \mathbb{R}^{d}$.

We refer to a known result for the existence of a ground state to (1.1) (see, e.g., [2]):
Proposition 1.1. Assume either $d=3$ and $3<p<5$, or else $d \geq 4$ and $1<p<\frac{d+2}{d-2}$. Then, for any $\omega>0$, there exists a ground state to (1.1). Furthermore, for any $\omega>0$, the following hold:

1. A ground state to (1.1) becomes a solution to (1.1) and is in $C^{2}\left(\mathbb{R}^{d}\right)$.
2. For any ground state $Q_{\omega}$ to (1.1), there exist $y \in \mathbb{R}^{d}, \theta \in \mathbb{R}$ and a positive radial function $\Phi_{\omega}$ such that $Q_{\omega}(x)=e^{i \theta} \Phi_{\omega}(x-y)$; In particular, $\Phi_{\omega}$ is a positive radial ground state to (1.1).
3. Let $\Phi_{\omega}$ be a positive radial ground state to (1.1). Then, $\Phi_{\omega}=\Phi_{\omega}(x)$ is strictly decreasing as a function of $|x|$. In particular, $\left\|\Phi_{\omega}\right\|_{L^{\infty}}=\Phi_{\omega}(0)$.
4. For any positive radial ground state $\Phi_{\omega}$ to (1.1), there exist $\nu>0$ and $C>0$ such that for any $x \in \mathbb{R}^{d}$,

$$
\begin{equation*}
\left|\Phi_{\omega}(x)\right|+\left|\nabla \Phi_{\omega}(x)\right|+\left|\Delta \Phi_{\omega}(x)\right| \leq C e^{-\nu|x|} \tag{1.8}
\end{equation*}
$$

In particular, $\Phi_{\omega} \in H^{2}\left(\mathbb{R}^{d}\right)$.
Remark 1.1. In [5], it is proved that if $d=3$ and $1<p \leq 3$, then there exists $\omega_{c}>0$ such that for any $\omega>\omega_{c}$, there is no ground state to (1.1).

By Proposition 1.1, we may assume that a ground state to (1.1) is positive and radial. Now, we state the main result of this paper:

Theorem 1.1. Assume $d=3,4$ and $\frac{4}{d-2}-1<p<\frac{d+2}{d-2}$; namely either $d=3$ and $3<p<5$, or $d=4$ and $1<p<3$. Then, there exists $\omega_{*}>0$ such that for any $\omega>\omega_{*}$, a positive radial ground state to (1.1) is unique.

Remark 1.2. 1. By the result of Pucci and Serrin 17 (see also Appendix $C$ of [2]), we find that if $3 \leq d \leq 6$ and $\frac{4}{d-2} \leq p<\frac{d+2}{d-2}$, then for any $\omega>0$, a positive radial solution to (1.1) is unique; in particular, a positive radial ground state is unique.
2. In [2], it had been proved that if $d \geq 5$ and $1<p<\frac{d+2}{d-2}$, then there exists $\omega_{*}>0$ such that for any $\omega \geq \omega_{*}$, a positive radial ground state to (1.1) is unique.

We give a proof of Theorem 1.1 in Section 4.

## 2 Preliminaries

We collect symbols used in this paper, with auxiliary results:

1. For $d \geq 3,1<p<\frac{d-2}{d+2}$ and $\omega>0$, the symbol $\mathcal{G}_{\omega}$ denotes the set of positive radial ground states to (1.1).
2. $L_{\text {real }}^{2}\left(\mathbb{R}^{d}\right)$ denotes the real Hilbert space of complex-valued $L^{2}$-functions equipped with the inner product

$$
\langle f, g\rangle:=\Re \int_{\mathbb{R}^{d}} f(x) \overline{g(x)} d x
$$

3. For $u, v \in L^{2}\left(\mathbb{R}^{d}\right)$, we define

$$
\begin{equation*}
(u, v):=\int_{\mathbb{R}^{d}} u(x) \overline{v(x)} d x \tag{2.1}
\end{equation*}
$$

4. We define the Fourier and inverse Fourier transformations to be that for $u \in L^{1}\left(\mathbb{R}^{d}\right)$,

$$
\begin{equation*}
\mathcal{F}[u](\xi):=\int_{\mathbb{R}^{d}} e^{-i \xi \cdot x} u(x) d x, \quad \mathcal{F}^{-1}[u](\xi):=\frac{1}{(2 \pi)^{d}} \int_{\mathbb{R}^{d}} e^{i \xi \cdot x} u(x) d x . \tag{2.2}
\end{equation*}
$$

Then, the relationship between Fourier transformation and convolution (see Theorem 0.1.8 of [18]), and Parsevarl's identity (see Theorem 0.1.11 of [18]) are stated as

$$
\begin{align*}
\mathcal{F}\left[\int_{\mathbb{R}^{d}} u(\cdot-y) v(y) d y\right] & =\mathcal{F}[u] \mathcal{F}[v],  \tag{2.3}\\
(u, v) & =\frac{1}{(2 \pi)^{d}}(\mathcal{F}[u], \mathcal{F}[v]) . \tag{2.4}
\end{align*}
$$

Furthermore, it is known (see, e.g., Theorem 2.4.6 of [10, or Theorem 5.9 of [16]) that for any $0<r<d$,

$$
\begin{equation*}
\mathcal{F}\left[|x|^{-r}\right](\xi)=C_{r}|\xi|^{-(d-r)}, \quad \text { with } \quad C_{r}:=\frac{2^{d-r} \pi^{\frac{d}{2}} \Gamma\left(\frac{d-r}{2}\right)}{\Gamma\left(\frac{r}{2}\right)} . \tag{2.5}
\end{equation*}
$$

5. We use $W$ to denote the Aubin-Talenti function with $W(0)=1$, namely

$$
\begin{equation*}
W(x):=\left(1+\frac{|x|^{2}}{d(d-2)}\right)^{-\frac{d-2}{2}} . \tag{2.6}
\end{equation*}
$$

Note that

$$
\begin{equation*}
W(x) \sim(1+|x|)^{-(d-2)}, \quad\|W\|_{L_{\text {weak }}^{\frac{d}{d-2}}}<\infty \tag{2.7}
\end{equation*}
$$

where the implicit constant depends only on $d$; in particular, if $d=3,4$, then $W \notin L^{2}\left(\mathbb{R}^{d}\right)$. It is known that for $d \geq 3, W$ is a solution to the following equation:

$$
\begin{equation*}
\Delta u+|u|^{\frac{4}{d-2}} u=0 . \tag{2.8}
\end{equation*}
$$

6. For $d \geq 3$, we define a potential function $V$ as

$$
\begin{equation*}
V:=-\frac{d+2}{d-2} W^{\frac{4}{d-2}} . \tag{2.9}
\end{equation*}
$$

Note that $V$ is negative. Observe from (2.7) that for any $d \geq 3$,

$$
\begin{equation*}
|V(x)| \lesssim(1+|x|)^{-4}, \tag{2.10}
\end{equation*}
$$

where the implicit constant depends only on $d$.
7. Let $\lambda>0$. Then, we define the $H^{1}$-scaling operator $T_{\lambda}$ by

$$
\begin{equation*}
T_{\lambda}[v](x):=\lambda^{-1} v\left(\lambda^{\left.-\frac{2}{d-2} x\right) .}\right. \tag{2.11}
\end{equation*}
$$

[^1]8. We use $\Lambda W$ to denote the function defined as
\[

$$
\begin{equation*}
\Lambda W:=\frac{d-2}{2} W+x \cdot \nabla W=\left(\frac{d-2}{2}-\frac{|x|^{2}}{2 d}\right)\left(1+\frac{|x|^{2}}{d(d-2)}\right)^{-\frac{d}{2}} . \tag{2.12}
\end{equation*}
$$

\]

Observe that

$$
\begin{align*}
& (-\Delta+V) \Lambda W=0  \tag{2.13}\\
& |\Lambda W(x)| \lesssim(1+|x|)^{-(d-2)} \tag{2.14}
\end{align*}
$$

where the implicit constant depends only on $d$. In particular, (2.14) shows that if $d=3,4$, then $\Lambda W \notin L^{2}\left(\mathbb{R}^{d}\right)$. A computation involving integration by parts shows that for any $\max \left\{1, \frac{2}{d-2}\right\}<r<\frac{d+2}{d-2}$,

$$
\begin{equation*}
\left\langle W^{r}, \Lambda W\right\rangle=\frac{-\{4-(d-2)(r-1)\}}{2(r+1)}\|W\|_{L^{r+1}}^{r+1}<0 . \tag{2.15}
\end{equation*}
$$

The function $\Lambda W$ can be obtaind from the $H^{1}$-scaling of $W$; Precisely, we see that for any $\lambda>0$,

$$
\begin{equation*}
\frac{d}{d \lambda} T_{\lambda}[W]=-\lambda^{-1} T_{\lambda}[W]-\frac{2}{d-2} T_{\lambda}[x \cdot \nabla W]=-\frac{2}{d-2} \lambda^{-1} T_{\lambda}[\Lambda W], \tag{2.16}
\end{equation*}
$$

so that $\Lambda W=-\left.\frac{2}{d-2} \frac{d}{d \lambda} T_{\lambda}[W]\right|_{\lambda=1}$.
Observe from the fundamental theorem of calculus and (2.16) that for any $\mu>0$,

$$
\begin{equation*}
T_{\mu}[W]-W=\int_{1}^{\mu} \frac{d}{d \lambda} T_{\lambda}[W] d \lambda=-\frac{2}{d-2} \int_{1}^{\mu} \lambda^{-1} T_{\lambda}[\Lambda W] d \lambda . \tag{2.17}
\end{equation*}
$$

Furthermore, by (2.17) and the fundamental theorem of calculus, we see that for any $\mu>0$,

$$
\begin{align*}
& T_{\mu}[W]-W+\frac{2}{d-2}(\mu-1) \Lambda W \\
& =-\frac{2}{d-2} \int_{1}^{\mu} \int_{1}^{\nu} \frac{d}{d \lambda}\left(\lambda^{-1} T_{\lambda}[\Lambda W]\right) d \lambda d \nu  \tag{2.18}\\
& =\frac{2}{d-2} \int_{1}^{\mu} \int_{1}^{\nu} \lambda^{-2} T_{\lambda}\left[2 \Lambda W+\frac{2}{d-2} x \cdot \nabla \Lambda W\right] d \lambda d \nu
\end{align*}
$$

9. We use $\Gamma$ to denote the gamma function. Recall that $\Gamma\left(\frac{5}{2}\right)=\frac{3 \sqrt{\pi}}{4}$ and $\Gamma(3)=2$.
10. For $d \geq 3$, we use $(-\Delta)^{-1}$ to denote the operator defined to be that for any function $f$ satisfying $(1+|x|)^{-(d-2)} f \in L^{1}\left(\mathbb{R}^{d}\right)$,

$$
\begin{equation*}
(-\Delta)^{-1} f(x) g a:=\int_{\mathbb{R}^{d}} \frac{\Gamma\left(\frac{d}{2}\right)}{(d-2) 2 \pi^{\frac{d}{2}}}|x-y|^{-(d-2)} f(y) d y . \tag{2.19}
\end{equation*}
$$

Note that Hölder's ineqaultiy shows that if $1 \leq r<\frac{d}{2}$ and $f \in L^{r}\left(\mathbb{R}^{d}\right)$, then $(1+|x|)^{-(d-2)} f \in L^{1}\left(\mathbb{R}^{d}\right)$. The Hardy-Littlewood-Sobolev inequality shows that for any $1<r<\frac{d}{2}(r \neq 1)$ and $f \in L^{r}\left(\mathbb{R}^{d}\right)$,

$$
\begin{equation*}
\left\|(-\Delta)^{-1} f\right\|_{L^{\frac{d r}{d-2 r}}} \lesssim\|f\|_{L^{r}} \tag{2.20}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $r$. Furthermore, the standard theory for Poisson's equation (see, e.g., Theorem 6.21 of [16]) shows that for any $1 \leq r<\frac{d}{2}$ and $f \in L^{r}\left(\mathbb{R}^{d}\right)$,

$$
\begin{equation*}
(-\Delta)(-\Delta)^{-1} f=f \quad \text { in the distribution sense. } \tag{2.21}
\end{equation*}
$$

By (2.21) and $(-\Delta+V) \Lambda W=0$ (see (2.13)), we see that

$$
\begin{equation*}
(-\Delta)(-\Delta)^{-1} V \Lambda W=V \Lambda W=\Delta \Lambda W \quad \text { in the distribution sense, } \tag{2.22}
\end{equation*}
$$

which implies that there exists a harmonic function $h$ on $\mathbb{R}^{d}$ such that

$$
\begin{equation*}
(-\Delta)^{-1} V \Lambda W=-\Lambda W+h \tag{2.23}
\end{equation*}
$$

Note here that (2.20) shows that

$$
\begin{equation*}
\left\|(\Delta)^{-1} V \Lambda W\right\|_{L^{2^{*}}} \lesssim\|V \Lambda W\|_{L^{\frac{2 d}{d+2}}} \lesssim 1 \tag{2.24}
\end{equation*}
$$

whereas the maximum principle shows that a non-trivial harmonic function does not belong to $L^{2^{*}}\left(\mathbb{R}^{d}\right)$. Thus, $h \equiv 0$ in (2.23) and therefore

$$
\begin{equation*}
(-\Delta)^{-1} V \Lambda W=-\Lambda W \tag{2.25}
\end{equation*}
$$

11. For $1 \leq q \leq \infty$, we use $L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ to denote the set of radially symmetric functions about $0 \in \mathbb{R}^{d}$ in $L^{q}\left(\mathbb{R}^{d}\right)$.
12. For $1 \leq q \leq \infty$, we define a set $X_{q}$ as

$$
\begin{equation*}
X_{q}:=\left\{f \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right):\langle f, V \Lambda W\rangle=0\right\} . \tag{2.26}
\end{equation*}
$$

We can verify that $X_{q}$ is a closed subspace of $L^{q}\left(\mathbb{R}^{d}\right)$. Hence, $X_{q}$ is a Banach space.
13. We define a function $\delta$ on $(0, \infty)$ by

$$
\delta(s):=\left\{\begin{array}{cl}
s^{\frac{1}{2}} & \text { if } d=3  \tag{2.27}\\
\frac{1}{\log \left(1+s^{-1}\right)} & \text { if } d=4
\end{array}\right.
$$

A computation involving the spherical coordinates shows that for any $s>0$,

$$
\int_{|\xi| \leq 1} \frac{1}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi=\frac{d \pi^{\frac{d}{2}}}{\Gamma\left(\frac{d}{2}+1\right)} \begin{cases}s^{-\frac{1}{2}} \arctan \left(s^{-\frac{1}{2}}\right) & \text { if } d=3  \tag{2.28}\\ \frac{1}{2} \log \left(1+s^{-1}\right) & \text { if } d=4\end{cases}
$$

Note here that $\frac{d \pi^{\frac{d}{2}}}{\Gamma\left(\frac{d}{2}+1\right)}$ is the surface area of unit sphere in $\mathbb{R}^{d}$. Furthermore, we see that for any $s>0$,

$$
\begin{equation*}
\left|\frac{\pi}{2}-\arctan \left(s^{-\frac{1}{2}}\right)\right| \leq \int_{s^{-\frac{1}{2}}}^{\infty} \frac{1}{1+t^{2}} d t \leq \int_{s^{-\frac{1}{2}}}^{\infty} t^{-2} d t \leq s^{\frac{1}{2}} \tag{2.29}
\end{equation*}
$$

Observe from (2.28) and (2.29) that for $d=3,4$ and any $s>0$,

$$
\begin{equation*}
\left|\int_{|\xi| \leq 1} \frac{1}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi-(5-d) \pi^{2} \delta(s)^{-1}\right| \lesssim 1 \tag{2.30}
\end{equation*}
$$

where the implicit constant depends only on $d$.
14. We define a function $\beta$ on $(0, \infty)$ by

$$
\begin{equation*}
\beta(s):=\delta(s)^{-1} s \tag{2.31}
\end{equation*}
$$

where $\delta$ is the function given in (2.27).
Note that $\beta$ is strictly increasing on $(0, \infty)$, so that the inverse exists.
15. We use $\alpha$ to denote the inverse function of $\beta$.

When $d=3, \beta(s)=s^{\frac{1}{2}}$; Hence, the domain of $\alpha$ is $(0, \infty)$.
When $d=4$, the image of $(0, \infty)$ by $\beta$ is $(0,1)$ (see LemmaC.1); Hence, the domain of $\alpha$ is $(0,1)$.
Note that for any $t$ in the domain of $\alpha$,

$$
\begin{equation*}
t=\beta(\alpha(t))=\delta(\alpha(t))^{-1} \alpha(t) ; \quad \text { or equivalently, } \quad \delta(\alpha(t))=t^{-1} \alpha(t) . \tag{2.32}
\end{equation*}
$$

Since $\beta$ is strictly increasing and $\lim _{s \rightarrow 0} \beta(s)=0$, we see that $\alpha$ is strictly increasing and

$$
\begin{equation*}
\lim _{t \rightarrow 0} \alpha(t)=0, \quad \lim _{t \rightarrow 0} \delta(\alpha(t))=0 \tag{2.33}
\end{equation*}
$$

Furthermore, the following holds (see Lemma C.1):

$$
\alpha(t) \begin{cases}=t^{2} & \text { for } d=3 \text { and } 0<t<\infty,  \tag{2.34}\\ \sim \delta(t) t & \text { for } d=4 \text { and } 0<t \leq T_{0}\end{cases}
$$

where $T_{0}>0$ is some constant.
16. Let $d \geq 3$ and $p>1$. Furthermore, let $t \geq 0, s \geq 0$, and let $\eta$ be a function on $\mathbb{R}^{d}$. Then, we define $N(\eta ; t)$ and $F(\eta ; s, t)$ as

$$
\begin{align*}
N(\eta ; t):= & |W+\eta|^{\frac{4}{d-2}}(W+\eta)-W^{\frac{d+2}{d-2}}-\frac{d+2}{d-2} W^{\frac{4}{d-2}} \eta  \tag{2.35}\\
& +t\left\{|W+\eta|^{p-1}(W+\eta)-W^{p}\right\}, \\
F(\eta ; s, t):= & -s W+t W^{p}+N(\eta ; t) . \tag{2.36}
\end{align*}
$$

17. For $d \geq 3$ and functions $\eta_{1}, \eta_{2}$ on $\mathbb{R}^{d}$, we define $D\left(\eta_{1}, \eta_{2}\right)$ as

$$
\begin{equation*}
D\left(\eta_{1}, \eta_{2}\right):=\left|W+\eta_{1}\right|^{\frac{4}{d-2}}\left(W+\eta_{1}\right)-\left|W+\eta_{2}\right|^{\frac{4}{d-2}}\left(W+\eta_{2}\right)-\frac{d+2}{d-2} W^{\frac{4}{d-2}}\left(\eta_{1}-\eta_{2}\right) \tag{2.37}
\end{equation*}
$$

18. For $d \geq 3, p>1$ and functions $\eta_{1}, \eta_{2}$ on $\mathbb{R}^{d}$, we define $E\left(\eta_{1}, \eta_{2}\right)$ as

$$
\begin{equation*}
E\left(\eta_{1}, \eta_{2}\right):=\left|W+\eta_{1}\right|^{p-1}\left(W+\eta_{1}\right)-\left|W+\eta_{2}\right|^{p-1}\left(W+\eta_{2}\right) . \tag{2.38}
\end{equation*}
$$

Next, we make some remarks about $N(\eta ; t), D\left(\eta_{1}, \eta_{2}\right)$ and $E\left(\eta_{1}, \eta_{2}\right)$ (see (2.35), (2.37) and (2.38)). Let $d \geq 3, p>1, t_{1}, t_{2} \geq 0$, and let $\eta_{1}, \eta_{2}$ be functions on $\mathbb{R}^{d}$. Then, the following hold:
1.

$$
\begin{equation*}
N\left(\eta_{1} ; t_{1}\right)-N\left(\eta_{2} ; t_{2}\right)=D\left(\eta_{1}, \eta_{2}\right)+t_{2} E\left(\eta_{1}, \eta_{2}\right)+\left(t_{1}-t_{2}\right) E\left(\eta_{1}, 0\right) \tag{2.39}
\end{equation*}
$$

Note that $D(\eta, \eta)=0$ and $E(\eta, \eta)=0$.
Observe from $N(0 ; 0)=0$ that

$$
\begin{equation*}
N\left(\eta_{1} ; t_{1}\right)=D\left(\eta_{1}, 0\right)+t_{1} E\left(\eta_{1}, 0\right) \tag{2.40}
\end{equation*}
$$

Furthermore, observe from the fundamental theorem of calculus that

$$
\begin{align*}
& \left|D\left(\eta_{1}, \eta_{2}\right)\right| \lesssim\left(W+\left|\eta_{1}\right|+\left|\eta_{2}\right|\right)^{\frac{6-d}{d-2}}\left(\left|\eta_{1}\right|+\left|\eta_{2}\right|\right)\left|\eta_{1}-\eta_{2}\right|  \tag{2.41}\\
& \left|E\left(\eta_{1}, \eta_{2}\right)\right| \lesssim\left(W+\left|\eta_{1}\right|+\left|\eta_{2}\right|\right)^{p-1}\left|\eta_{1}-\eta_{2}\right| \tag{2.42}
\end{align*}
$$

where the first implicit constant depends only on $d$, and the second one does only on $d$ and $p$.

We record well-known results for the resolvent of the Laplace operator. The standard theory for Yukawa's equation (see, e.g., Theorem 6.23 and Lemma 9.11 of [16]) shows the following:

1. For any $d \geq 1, s>0,1 \leq q \leq \infty$ and $f \in L^{q}\left(\mathbb{R}^{d}\right)$,

$$
\begin{equation*}
(-\Delta+s)^{-1} f(x)=\int_{\mathbb{R}^{d}} \int_{0}^{\infty}(4 \pi t)^{-\frac{d}{2}} e^{-\frac{|x-y|^{2}}{4 t}} e^{-s t} d t f(y) d y \tag{2.43}
\end{equation*}
$$

Observe from (2.43) that if $|f| \leq|g|$, then

$$
\begin{equation*}
\left|(-\Delta+s)^{-1} f\right| \leq(-\Delta+s)^{-1}|g| \tag{2.44}
\end{equation*}
$$

Using integration by substitution, we see that for each $x \in \mathbb{R}^{d} \backslash\{0\}$,

$$
\begin{equation*}
\int_{0}^{\infty}(4 \pi t)^{-\frac{d}{2}} e^{-\frac{|x|^{2}}{4 t}} e^{-s t} d t \leq \int_{0}^{\infty}(4 \pi t)^{-\frac{d}{2}} e^{-\frac{|x|^{2}}{4 t}} d t \lesssim|x|^{-(d-2)} \tag{2.45}
\end{equation*}
$$

where the implicit constant depends only on $d$.
2. For any $d \geq 1, s>0,1 \leq q \leq \infty$ and $f \in L^{q}\left(\mathbb{R}^{d}\right)$,

$$
\begin{align*}
& (-\Delta+s)^{-1} f \in L^{q}\left(\mathbb{R}^{d}\right)  \tag{2.46}\\
& (-\Delta+s)(-\Delta+s)^{-1} f=f \quad \text { in the distribution sense. } \tag{2.47}
\end{align*}
$$

Observe from (2.46) and (2.47) that $(-\Delta+s)^{-1} f \in W^{2, q}\left(\mathbb{R}^{d}\right)$.
3. For any $d \geq 1, s>0,1 \leq q \leq \infty$ and $f \in W^{2, q}\left(\mathbb{R}^{d}\right)$,

$$
\begin{equation*}
(-\Delta+s)^{-1}(-\Delta+s) f=f \tag{2.48}
\end{equation*}
$$

4. For any $s>0$ and $\xi \in \mathbb{R}^{d}$,

$$
\begin{equation*}
\mathcal{F}\left[\int_{0}^{\infty}(4 \pi t)^{-\frac{d}{2}} e^{-\frac{|x|^{2}}{4 t}} e^{-s t} d t\right](\xi)=\left(|\xi|^{2}+s\right)^{-1} \tag{2.49}
\end{equation*}
$$

At the end of this section, we collect known results about ground states:
Lemma 2.1 (Lemma 2.3 of [2]). Assume either $d=3$ and $3<p<5$, or else $d \geq 4$ and $1<p<\frac{d+2}{d-2}$. Then, we have

$$
\begin{align*}
& \lim _{\omega \rightarrow \infty} \inf _{\omega \in \mathcal{G}_{\omega}} \Phi_{\omega}(0)=\infty  \tag{2.50}\\
& \lim _{\omega \rightarrow \infty} \sup _{\Phi_{\omega} \in \mathcal{G}_{\omega}} \omega \Phi_{\omega}(0)^{-\left(2^{*}-2\right)}=\lim _{\omega \rightarrow \infty} \sup _{\Phi_{\omega} \in \mathcal{G}_{\omega}} \Phi_{\omega}(0)^{-\left\{2^{*}-(p+1)\right\}}=0 . \tag{2.51}
\end{align*}
$$

Lemma 2.2 (Proposition 2.1 and Corollary 3.1 of [2]). Assume either $d=3$ and $3<$ $p<5$, or else $d \geq 4$ and $1<p<\frac{d+2}{d-2}$. Then, the following hold:

$$
\begin{align*}
& \lim _{\omega \rightarrow \infty} \sup _{\Phi_{\omega} \in \mathcal{G}_{\omega}}\left\|T_{\Phi_{\omega}(0)}\left[\Phi_{\omega}\right]-W\right\|_{\dot{H}^{1}}=0  \tag{2.52}\\
& \lim _{\omega \rightarrow \infty} \sup _{\Phi_{\omega} \in \mathcal{G}_{\omega}}\left\|T_{\Phi_{\omega}(0)}\left[\Phi_{\omega}\right]-W\right\|_{L^{r}}=0 \quad \text { for all } \frac{d}{d-2}<r<\infty . \tag{2.53}
\end{align*}
$$

Lemma 2.3 (Proposition 3.1 of [2]). Assume either $d=3$ and $3<p<5$, or else $d \geq 4$. Let $1<p<\frac{d+2}{d-2}$. Then, for any sufficiently large $\omega$, and any $x \in \mathbb{R}^{d}$,

$$
\begin{equation*}
\sup _{\Phi_{\omega} \in \mathcal{G}_{\omega}} T_{\Phi_{\omega}(0)}\left[\Phi_{\omega}\right](x) \lesssim(1+|x|)^{-(d-2)}, \tag{2.54}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $p$.

## 3 Uniform estimates for perturbed resolvents

Our aim in this section is to prove the following proposition which plays a vital role for the proof of Theorem 1.1

Proposition 3.1. Assume $d=3,4$, and let $\frac{d}{d-2}<q<\infty$. If $s>0$ is sufficiently small dependently on $d$ and $q$, then the inverse of the operator $1+(-\Delta+s)^{-1} V: L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow$ $L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ exists; and the following estimates hold:

1. If $f \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$, then

$$
\begin{equation*}
\left\|\left\{1+(-\Delta+s)^{-1} V\right\}^{-1} f\right\|_{L^{q}} \lesssim \delta(s) s^{-1}\|f\|_{L^{q}} \tag{3.1}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$.
2. If $f \in X_{q}$, then

$$
\begin{equation*}
\left\|\left\{1+(-\Delta+s)^{-1} V\right\}^{-1} f\right\|_{L^{q}} \lesssim\|f\|_{L^{q}}, \tag{3.2}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$.
Remark 3.1. 1. When $d=3$, the case $q=\infty$ can be included in Proposition 3.1 (see Lemma 2.4 of (77). On the other hand, from the point of view of Remark 3.5 below, when $d=4$, it seems difficult to include the case $q=\infty$.
2. By the substitution of variables $\tau=\beta(s):=\delta(s)^{-1} s$, we may write (3.1) as

$$
\begin{equation*}
\left\|\left\{1+(-\Delta+\alpha(\tau))^{-1} V\right\}^{-1} f\right\|_{L^{q}} \lesssim \tau^{-1}\|f\|_{L^{q}} \tag{3.3}
\end{equation*}
$$

3. Observe from $V=-\frac{d+2}{d-2} W^{\frac{4}{d-2}}, W^{\frac{d+2}{d-2}}=(-\Delta) W$ and $\Delta \Lambda W=V \Lambda W$ that

$$
\begin{equation*}
\langle W, V \Lambda W\rangle=-\frac{d+2}{d-2}\left\langle W^{\frac{d+2}{d-2}}, \Lambda W\right\rangle=\frac{d+2}{d-2}\langle\Delta W, \Lambda W\rangle=\frac{d+2}{d-2}\langle W, V \Lambda W\rangle \tag{3.4}
\end{equation*}
$$

which implies $\langle W, V \Lambda W\rangle=0$. Thus, we see that $W \in X_{q}$ for all $\frac{d}{d-2}<q \leq \infty$.
We will prove Proposition 3.1 in Section 3.2.

### 3.1 Preliminaries

In this subsection, we give basic estimates for free and perturbed resolvents.
Let us begin by recalling the following fact (see, e.g., Section 5.2 of [9], and Proposition 2.2 of [8]):

Lemma 3.1. Assume $d \geq 3$. Then, there exists $e_{0}>0$ such that $-e_{0}$ is the only one negative eigenvalue of the operator $-\Delta+V: H^{2}\left(\mathbb{R}^{d}\right) \rightarrow L^{2}\left(\mathbb{R}^{d}\right)$. Furthermore, the essential spectrum of $-\Delta+V$ equals $[0, \infty)$ (hence $\sigma(-\Delta+V)=\left\{-e_{0}\right\} \cup[0, \infty)$ ), and $\left\{u \in \dot{H}^{1}\left(\mathbb{R}^{d}\right):(-\Delta+V) u=0\right.$ in the distribution sense $\}=\operatorname{span}\left\{\Lambda W, \partial_{1} W, \ldots, \partial_{d} W\right\}$,
where $\partial_{1} W, \ldots \partial_{d} W$ denote the partial derivatives of $W$.
Lemma 3.2. Assume $d=3,4$. Let $\frac{d}{d-2}<r \leq \infty$. Then,

$$
\begin{equation*}
\left\{u \in L_{\mathrm{rad}}^{r}\left(\mathbb{R}^{d}\right):(-\Delta+V) u=0 \text { in the distribution sense }\right\}=\operatorname{span}\{\Lambda W\} \tag{3.6}
\end{equation*}
$$

Proof of Lemma 3.2. Let $u \in L^{r}\left(\mathbb{R}^{d}\right)$ be a function such that $\Delta u=V u$ in the distribution sense. Notice that $(1+|x|)^{-(d-2)} V u \in L^{1}\left(\mathbb{R}^{d}\right)$. Hence, the formula (2.21) is available. Furthermore, we see from (2.21), (2.19), the Hardy-Littlewood-Sobolev inequality and Hölder's inequality that

$$
\begin{align*}
\|\nabla u\|_{L^{2}} & =\left\|\nabla(-\Delta)^{-1} V u\right\|_{L^{2}} \\
& \lesssim\left\|\int_{\mathbb{R}^{d}} \frac{x-y}{|x-y|^{d}} V(y) u(y) d y\right\|_{L^{2}} \leq\left\|\int_{\mathbb{R}^{d}}|x-y|^{-(d-1)} V(y)|u(y)| d y\right\|_{L^{2}}  \tag{3.7}\\
& \lesssim\|V u\|_{L^{\frac{2 d}{d+2}}} \lesssim\|u\|_{L^{r}}
\end{align*}
$$

so that $u \in \dot{H}^{1}\left(\mathbb{R}^{d}\right)$. Thus, we find from Lemma 3.1 that the claim (3.6) is true.
We record well-known inequalities for radial functions (see [19]):
Lemma 3.3. Assume $d \geq 3$, and let $g$ be a radial function on $\mathbb{R}^{d}$. Then, we have

$$
\begin{align*}
&|x|^{\frac{d-2}{2}}|g(x)| \lesssim \nabla g \|_{L^{2}},  \tag{3.8}\\
&|x|^{\frac{d-1}{2}}|g(x)| \lesssim\|g\|_{L^{2}}^{\frac{1}{2}}\|\nabla g\|_{L^{2}}^{\frac{1}{2}} . \tag{3.9}
\end{align*}
$$

Remark 3.2. We see from Lemma 3.3 that for $d=3,4$,

$$
\begin{equation*}
|x||g(x)| \lesssim\|g\|_{L^{2}}^{\frac{4-d}{2}}\|\nabla g\|_{L^{2}}^{\frac{d-2}{2}} \tag{3.10}
\end{equation*}
$$

## Lemma 3.4. Assume $d \geq 1$.

1. Let $1 \leq q_{1} \leq q_{2} \leq \infty$ and $d\left(\frac{1}{q_{1}}-\frac{1}{q_{2}}\right)<2$. Then, the following holds for all $s>0$ :

$$
\begin{equation*}
\left\|(-\Delta+s)^{-1}\right\|_{L^{q_{1}}\left(\mathbb{R}^{d}\right) \rightarrow L^{q_{2}}\left(\mathbb{R}^{d}\right)} \lesssim s^{\frac{d}{2}\left(\frac{1}{q_{1}}-\frac{1}{q_{2}}\right)-1} \tag{3.11}
\end{equation*}
$$

where the implicit constant depends only on $d, q_{1}$ and $q_{2}$.
2. Let $1<q_{1} \leq q_{2}<\infty$ and $d\left(\frac{1}{q_{1}}-\frac{1}{q_{2}}\right)<2$. Then, the following holds for all $s>0$ :

$$
\begin{equation*}
\left\|(-\Delta+s)^{-1}\right\|_{L_{\text {weak }}^{q_{1}}\left(\mathbb{R}^{d}\right) \rightarrow L^{q_{2}}\left(\mathbb{R}^{d}\right)} \lesssim s^{\frac{d}{2}\left(\frac{1}{q_{1}}-\frac{1}{q_{2}}\right)-1} \tag{3.12}
\end{equation*}
$$

where the implicit constant depends only on $d, q_{1}$ and $q_{2}$.
Proof of Lemma 3.4. First, we prove (3.11). Let $1 \leq q_{1} \leq q_{2} \leq \infty$ and $f \in L^{q_{1}}\left(\mathbb{R}^{d}\right)$. Then, it follows from Young's inequality and elementary computations that

$$
\begin{align*}
\left\|(-\Delta+s)^{-1} f\right\|_{L^{q_{2}}} & \lesssim\left\|\int_{0}^{\infty}(4 \pi t)^{-\frac{d}{2}} e^{-\frac{|x|^{2}}{4 t}} e^{-s t} d t\right\|_{L^{\frac{q_{1} q_{2}}{q_{1} q_{2}-\left(q_{2}-q_{1}\right)}}}\|f\|_{L^{q_{1}}} \\
& \lesssim \int_{0}^{\infty} t^{-\frac{d}{2}+\frac{d}{2}\left(1+\frac{1}{q_{2}}-\frac{1}{q_{1}}\right)} e^{-s t} d t\|f\|_{L^{q_{1}}}  \tag{3.13}\\
& =s^{\frac{d}{2}\left(\frac{1}{q_{1}}-\frac{1}{q_{2}}\right)-1} \int_{0}^{\infty} r^{-\frac{d}{2}\left(\frac{1}{q_{1}}-\frac{1}{q_{2}}\right)} e^{-r} d r\|f\|_{L^{q_{1}}}
\end{align*}
$$

where the implicit constants depend only on $d, q_{1}$ and $q_{2}$. The above right-hand side is finite if and only if $\frac{d}{2}\left(\frac{1}{q_{1}}-\frac{1}{q_{2}}\right)<1$. Hence, we see that (3.11) holds. Similarly, by the weak Young inequality (see, e.g., (9) in Section 4.3 of [16]), we see that if $1<q_{1}<q_{2}<\infty$ and $\frac{d}{2}\left(\frac{1}{q_{1}}-\frac{1}{q_{2}}\right)<1$, then (3.12) holds.

Note that Lemma 3.4 does not deal with the case $d\left(\frac{1}{q_{1}}-\frac{1}{q_{2}}\right)=2$. The following lemma compensates for Lemma 3.4:
Lemma 3.5. Assume $d \geq 3$, and let $s_{0} \geq 0$. If $\frac{d}{d-2}<q<\infty$, then

$$
\begin{equation*}
\left\|\left(-\Delta+s_{0}\right)^{-1}\right\|_{L^{d+2 q}\left(\mathbb{R}^{d}\right) \rightarrow L^{q}\left(\mathbb{R}^{d}\right)} \lesssim 1 \tag{3.14}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$.
Remark 3.3. Put $r:=\frac{d q}{d+2 q}$. Then, $q=\frac{d r}{d-2 r}$; and the condition $\frac{d}{d-2}<q<\infty$ is equivalent to $1<r<\frac{d}{2}$.
Proof of Lemma 3.5. When $s_{0}=0$, the claim is identical to (3.14). Assume $s_{0}>0$. Then, by (2.45) and Hardy-Littlewood-Sobolev's inequality (see (2.20)), we see that

$$
\begin{equation*}
\left\|\left(-\Delta+s_{0}\right)^{-1} f\right\|_{L^{q}} \lesssim\left\||x|^{-(d-2)} * \mid f\right\|_{L^{q}} \lesssim\|f\|_{L^{\frac{d q}{d+2 q}}} \tag{3.15}
\end{equation*}
$$

where the implicit constants depend only on $d$ and $q$. Thus, we have proved the lemma.

Lemma 3.6. Assume $d \geq 3$. Let $s_{0} \geq 0$ and $0<\varepsilon \leq d-2$. Then, the following inequality hods:

$$
\begin{equation*}
\left\|\left(-\Delta+s_{0}\right)^{-1}\right\|_{L^{\frac{d+\varepsilon}{2}} \cap L^{\frac{d-\varepsilon}{2}} \rightarrow L^{\infty}} \lesssim 1 \tag{3.16}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $\varepsilon$.
Proof of Lemma 3.6. Let $f \in L^{\frac{d+\varepsilon}{2}}\left(\mathbb{R}^{d}\right) \cap L^{\frac{d-\varepsilon}{2}}\left(\mathbb{R}^{d}\right)$. Then, by (2.45) and Hölder's inequality, we see that

$$
\begin{align*}
& \left\|\left(-\Delta+s_{0}\right)^{-1} f\right\|_{L^{\infty}} \lesssim\left\||x|^{-(d-2)} * f\right\|_{L^{\infty}} \\
& \leq \sup _{x \in \mathbb{R}^{d}} \int_{|y| \leq 1}|y|^{-(d-2)}|f(x-y)| d y+\sup _{x \in \mathbb{R}^{d}} \int_{1 \leq|y|}|y|^{-(d-2)}|f(x-y)| d y  \tag{3.17}\\
& \lesssim\|f\|_{L^{\frac{d+\varepsilon}{2}}}+\|f\|_{L^{\frac{d-\varepsilon}{2}}} \lesssim\|f\|_{L^{\frac{d+\varepsilon}{2}} \cap \frac{d-\varepsilon}{2}},
\end{align*}
$$

where the implicit constant depends only on $d$ and $\varepsilon$. Thus, the claim is true.
Let us recall the resolvent equation:

$$
\begin{equation*}
(-\Delta+s)^{-1}-\left(-\Delta+s_{0}\right)^{-1}=-\left(s-s_{0}\right)(-\Delta+s)^{-1}\left(-\Delta+s_{0}\right)^{-1} \tag{3.18}
\end{equation*}
$$

This identity holds in the following sense:
Lemma 3.7. Assume $d \geq 3$. Let $s>0$ and $s_{0} \geq 0$.

1. Let $\frac{d}{d-2}<q<\infty$. Then, the resolvent identity (3.18) holds as an operator from $L^{\frac{d q}{d+2 q}}\left(\mathbb{R}^{d}\right)$ to $L^{q}\left(\mathbb{R}^{d}\right)$.
2. Let $0<\varepsilon \leq d-2$. Then, the resovlent identity (3.18) holds as an operator from $L^{\frac{d+\varepsilon}{2}}\left(\mathbb{R}^{d}\right) \cap L^{\frac{d-\varepsilon}{2}}\left(\mathbb{R}^{d}\right)$ to $L^{\infty}\left(\mathbb{R}^{d}\right)$.
Remark 3.4. Let $\frac{d}{d-2}<q \leq \infty$. Then, Lemma 3.7 together with $|V(x)| \lesssim(1+|x|)^{-4}$ shows that the following identity holds as an operator from $L^{q}\left(\mathbb{R}^{d}\right)$ to $L^{q}\left(\mathbb{R}^{d}\right)$ :

$$
\begin{equation*}
1+(-\Delta+s)^{-1} V=1+(-\Delta)^{-1} V-s(-\Delta+s)^{-1}(-\Delta)^{-1} V \tag{3.19}
\end{equation*}
$$

Proof of Lemma 3.7. By (2.21), (2.47) and (2.48), we see that

$$
\begin{align*}
& (-\Delta+s)^{-1}-\left(-\Delta+s_{0}\right)^{-1} \\
& =\left\{(-\Delta+s)^{-1}\left(-\Delta+s_{0}\right)-1\right\}\left(-\Delta+s_{0}\right)^{-1} \\
& =\left\{(-\Delta+s)^{-1}(-\Delta+s)-\left(s-s_{0}\right)(-\Delta+s)^{-1}-1\right\}\left(-\Delta+s_{0}\right)^{-1}  \tag{3.20}\\
& =-\left(s-s_{0}\right)(-\Delta+s)^{-1}\left(-\Delta+s_{0}\right)^{-1}
\end{align*}
$$

Note that each identity in (3.20) can be justified by Lemma 3.4, Lemma 3.5 and Lemma 3.6. Thus, the clamis of the lemma are true.

Lemma 3.8. Assume $3 \leq d \leq 7$. Let $2 \leq q \leq \infty$ and $s>0$. Then, the following inequality hods:

$$
\begin{equation*}
\left\|(1-\Delta)(-\Delta+s)^{-1} V\right\|_{L^{q} \rightarrow L^{2} \cap L^{q}} \lesssim 1+|1-s| s^{-1} \tag{3.21}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$. In particular, if $f \in L^{q}\left(\mathbb{R}^{d}\right)$, then

$$
\begin{equation*}
(-\Delta+s)^{-1} V f \in H^{2}\left(\mathbb{R}^{d}\right) \tag{3.22}
\end{equation*}
$$

Proof of Lemma 3.8. Let $f \in L^{q}\left(\mathbb{R}^{d}\right)$. Observe from $|V(x)| \lesssim(1+|x|)^{-4}$ (see (2.10)) that if $3 \leq d \leq 7$, then

$$
\begin{equation*}
\|V f\|_{L^{2} \cap L^{q}} \lesssim\|f\|_{L^{q}}, \tag{3.23}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$. Then, by (2.47), Lemma 3.4 and (3.23), we see that

$$
\begin{align*}
& \left\|(1-\Delta)(-\Delta+s)^{-1} V f\right\|_{L^{2} \cap L^{q}}=\left\|\{(-\Delta+s)+(1-s)\}(-\Delta+s)^{-1} V f\right\|_{L^{2} \cap L^{q}} \\
& \leq\|V f\|_{L^{2} \cap L^{q}}+|1-s|\left\|(-\Delta+s)^{-1} V f\right\|_{L^{2} \cap L^{q}}  \tag{3.24}\\
& \lesssim\|V f\|_{L^{2} \cap L^{q}}+|1-s| s^{-1}\|V f\|_{L^{2} \cap L^{q}} \lesssim\left(1+|1-s| s^{-1}\right)\|f\|_{L^{q}},
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$. Thus, we have obtained the desired estimate.

Lemma 3.9. Assume $3 \leq d \leq 5$, and let $\frac{d}{d-2}<q \leq \infty$. Then, $(-\Delta)^{-1} V$ is a compact operator from $X_{q}$ to itself. In particular, $(-\Delta)^{-1} V: X_{q} \rightarrow X_{q}$ is bounded.

Proof of Lemma 3.9. We prove the lemma in two steps.
Step 1. We shall show that for any $f \in L^{q}\left(\mathbb{R}^{d}\right)$,

\begin{align*}
\left\|(-\Delta)^{-1} V f\right\|_{L^{q}} & \lesssim\|f\|_{L^{q}},  \tag{3.25}\\
\left\|\nabla(-\Delta)^{-1} V f\right\|_{L^{q}} & \lesssim\|f\|_{L^{q}}, \tag{3.26}
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$.
Assume $\frac{d}{d-2}<q<\infty$, and let $f \in L^{q}\left(\mathbb{R}^{d}\right)$. Then, applying (2.20) as $r=\frac{d q}{2 q+d}$, we see that that

\left\|(-\Delta)^{-1} V f\right\|_{L^{q}} \lesssim\|V f\|_{L^{\frac{d q}{2 q+d}}} \lesssim\|f\|_{L^{q}}, \tag{3.27}
\end{equation*}

where the implicit constants depend only on $d$ and $q$. Furthermore, by (2.19) and the Hardy-Littlewood-Sobolev inequality, we see that

\left\|\nabla(-\Delta)^{-1} V f\right\|_{L^{q}} \lesssim\left\|\int_{\mathbb{R}^{d}}|x-y|^{-(d-1)} V(y)|f(y)| d y\right\|_{L^{q}} \lesssim\|V f\|_{L^{\frac{d q}{q+d}}} \lesssim\|f\|_{L^{q}} \tag{3.28}
\end{equation*}
$$

where the implicit constants depend only on $d$ and $q$.
Next, assume $q=\infty$, and let $f \in L^{\infty}\left(\mathbb{R}^{d}\right)$. Then, Lemma 3.6] shows that

\left\|(-\Delta)^{-1} V f\right\|_{L^{\infty}} \lesssim\|V f\|_{L^{\frac{d-1}{2}} \cap L^{\frac{d+1}{2}}} \lesssim\|V\|_{L^{\frac{d-1}{2}} \cap L^{\frac{d+1}{2}}}\|f\|_{L^{\infty}} \lesssim\|f\|_{L^{\infty}}, \tag{3.29}
\end{equation*}
$$

where the implicit constants depend only on $d$. Furthermore, by (2.19) and Hödler's inequality, we see that

& \left\|\nabla(-\Delta)^{-1} V f\right\|_{L^{\infty}} \lesssim\left\|\int_{\mathbb{R}^{d}}|y|^{-(d-1)} V(x-y) d y\right\|_{L^{\infty}}\|f\|_{L^{\infty}} \\
& \lesssim\left\{\int_{|y| \leq 1}|y|^{-(d-1)} d y+\left(\int_{1 \leq|y|}|y|^{-\frac{d(d-1)}{d-2}} d y\right)^{\frac{d-2}{d}}\|V\|_{L^{\frac{d}{2}}}\right\}\|f\|_{L^{\infty}} \lesssim\|f\|_{L^{\infty}}, \tag{3.30}
\end{align*}
$$

where the implicit constants depend only on $d$. Thus, we have proved (3.25) and (3.26).
Step 2. We shall finish the proof of the lemma.

We will use Lemma A.1. Let $\left\{f_{n}\right\}$ be a bounded sequence in $X_{q}$.
Observe from (3.25) that

& =\lim _{y \rightarrow 0} \sup _{n \geq 1}\left\|\int_{0}^{1} \frac{d}{d \theta}(-\Delta)^{-1} V f_{n}(\cdot+\theta y) d \theta\right\|_{L^{q}} \\
& =\lim _{y \rightarrow 0} \sup _{n \geq 1}\left\|\int_{0}^{1}\left[y \cdot \nabla(-\Delta)^{-1} V f_{n}\right](\cdot+\theta y) d \theta\right\|_{L^{q}}  \tag{3.32}\\
& \leq \lim _{y \rightarrow 0} \sup _{n \geq 1}|y|\left\|\nabla(-\Delta)^{-1} V f_{n}\right\|_{L^{q}} \lesssim \lim _{y \rightarrow 0}|y| \sup _{n \geq 1}\left\|f_{n}\right\|_{L^{q}}=0 .
\end{align*}
$$

Note that $(-\Delta)^{-1} V f_{n}$ is radial, as so is $f_{n}$. Let $\varepsilon_{0}:=\min \left\{\frac{1}{2}\left(q-\frac{d}{d-2}\right), 1\right\}$. When $q \neq \infty$, Lemma 3.3 shows that

& \leq \lim _{R \rightarrow \infty} \sup _{n \geq 1} R^{-\frac{d-2}{2} \frac{\varepsilon_{0}}{d+\varepsilon_{0}}}\left\||x|^{\frac{d-2}{2}}(-\Delta)^{-1} V f_{n}\right\|_{L^{\infty}}^{\frac{\varepsilon_{0}}{d+\varepsilon_{0}}}\left\|(-\Delta)^{-1} V f_{n}\right\|_{L^{\frac{d q}{d+2}}}^{\frac{d}{d+\varepsilon_{0}}}{ }^{\frac{d q}{d+2}}  \tag{3.33}\\
& \lesssim \lim _{R \rightarrow \infty} \sup _{n \geq 1} R^{-\frac{(d-2) \varepsilon_{0}}{2\left(d+\varepsilon_{0}\right)}}\left\|\nabla(-\Delta)^{-1} V f_{n}\right\|_{L^{2}}^{\frac{\varepsilon_{0}}{d+\varepsilon_{0}}}\left\|(-\Delta)^{-1} V f_{n}\right\|_{L^{\frac{d}{d+\varepsilon_{0}}}}^{\frac{d q}{d+\varepsilon_{0}}}
\end{align*}
$$

where the implicit constant depends only on $d$ and $q$. Similarly, when $q=\infty$, we see that

$$
\begin{align*}
& \lim _{R \rightarrow \infty} \sup _{n \geq 1}\left\|(-\Delta)^{-1} V f_{n}(x)\right\|_{L^{\infty}(|x| \geq R)} \\
& \leq \lim _{R \rightarrow \infty} \sup _{n \geq 1} R^{-\frac{d-2}{2}}\left\||x|^{\frac{d-2}{2}}(-\Delta)^{-1} V f_{n}\right\|_{L^{\infty}}  \tag{3.34}\\
& \lesssim \lim _{R \rightarrow \infty} \sup _{n \geq 1} R^{-\frac{d-2}{2}}\left\|\nabla(-\Delta)^{-1} V f_{n}\right\|_{L^{2}}
\end{align*}
$$

where the implicit constant depends only on $d$.
Observe from $3 \leq d \leq 5$ and $\frac{d}{d-2}<q \leq \infty$ that $\frac{2 d}{d+2}<q$ and $\frac{2 d q}{(d+2) q-2 d}>\frac{d}{4}\left(\frac{2 d}{d+2}>\frac{d}{4}\right.$ if $q=\infty$ ). Hence, by (2.19), the Hardy-Littlewood-Sobolev inequality, Hölder's one, and $V(x) \sim(1+|x|)^{-4}$, we see that

\left\|\nabla(-\Delta)^{-1} V f_{n}\right\|_{L^{2}} & \lesssim\left\||x|^{-(d-1)} * V f_{n}\right\|_{L^{2}} \lesssim\left\|V f_{n}\right\|_{L^{\frac{2 d}{d+2}}}  \tag{3.35}\\
& \leq\|V\|_{L^{\frac{2 d q}{(d+2) q-2 d}}}\left\|f_{n}\right\|_{L^{q}} \lesssim\left\|f_{n}\right\|_{L^{q}}
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$. Similarly, if $q \neq \infty$, then

$$
\begin{equation*}
\left\|(-\Delta)^{-1} V f_{n}\right\|_{L^{\frac{d q}{d+\varepsilon_{0}}}} \lesssim\left\|V f_{n}\right\|_{L^{d+2 q+\varepsilon_{0}}} \leq\|V\|_{L^{\frac{d q}{2 q+\varepsilon_{0}}}}\left\|f_{n}\right\|_{L^{q}} \lesssim\left\|f_{n}\right\|_{L^{q}} \tag{3.36}
\end{equation*}
$$

where the implicit constants depend only on $d$ and $q$.
Plugging the estimates (3.35) and (3.36) into (3.33) ((3.35) into (3.34) if $q=\infty$ ), we find that

\lim _{R \rightarrow \infty} \sup _{n \geq 1}\left\|(-\Delta)^{-1} V f_{n}(x)\right\|_{L^{q}(|x| \geq R)}=0 . \tag{3.37}

Thus, it follows from Lemma A. 1 that $\left\{(-\Delta)^{-1} V f_{n}\right\}$ contains a convergent subsequence in $L^{q}\left(\mathbb{R}^{d}\right)$. We denote the convergent subsequence by the same symbol as the original one, and the limit by $g$. Note that $g \in L_{\text {rad }}^{q}\left(\mathbb{R}^{d}\right)$.

It remains to prove that the limit $g$ satisfies the orthogonality condition $\langle g, V \Lambda W\rangle=$ 0 . Since $V \Lambda W=\Delta \Lambda W$ and $\left\langle f_{n}, V \Lambda W\right\rangle=0$, we can verify that for any $n \geq 1$,

\left\langle(-\Delta)^{-1} V f_{n}, V \Lambda W\right\rangle=\left\langle(-\Delta)^{-1} V f_{n},-(-\Delta) \Lambda W\right\rangle=-\left\langle V f_{n}, \Lambda W\right\rangle=0, \tag{3.38}
\end{equation*}
$$

which together with $V \Lambda W \in L^{1}\left(\mathbb{R}^{d}\right) \cap L^{\infty}\left(\mathbb{R}^{d}\right)$ yields

\begin{equation*}
\langle g, V \Lambda W\rangle=\lim _{n \rightarrow \infty}\left\langle(-\Delta)^{-1} V f_{n}, V \Lambda W\right\rangle=0 . \tag{3.39}
\end{equation*}
$$

Thus, we have completed the proof.
Lemma 3.10. Assume $3 \leq d \leq 5$ and $\frac{d}{d-2}<q \leq \infty$. Then, the inverse of $1+(-\Delta)^{-1} V$ exists as a bounded operator from $X_{q}$ to itself.

Proof of Lemma 3.10. We see from Lemma 3.9 that $(-\Delta)^{-1} V$ is a compact operator from $X_{q}$ to itself. Furthermore, by a standard theory of compact operators, if $z \in \mathbb{C}$ is neither zero nor an eigenvalue of $(-\Delta)^{-1} V$, then $z$ belongs to the resolvent. In particular, if -1 is not an eigenvalue of $(-\Delta)^{-1} V$, then the inverse of $1+(-\Delta)^{-1} V$ exists as a bounded operator from $X_{q}$ to itself. Hence, what we need to prove is that -1 is not an eigenvalue. Suppose for contradiction that there exists $f \in X_{q}$ such that $(-\Delta)^{-1} V f=-f$. Then, we can verify that for any $\phi \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$,

$$
\begin{equation*}
\langle(-\Delta+V) f, \phi\rangle=\left\langle(-\Delta)\left\{f+(-\Delta)^{-1} V f\right\}, \phi\right\rangle=\left\langle f+(-\Delta)^{-1} V f,-\Delta \phi\right\rangle=0 . \tag{3.40}
\end{equation*}
$$

Lemma 3.2 together with (3.40) implies that $f=\kappa \Lambda W$ for some $\kappa \in \mathbb{R}$. Furthermore, it follows from $\langle f, V \Lambda W\rangle=0$ and $\langle\Lambda W, V \Lambda W\rangle \neq 0$ that $\kappa=0$. Thus, $f$ is trivial and therefore -1 is not an eigenvalue of $(-\Delta)^{-1} V$.

Lemma 3.11. Assume $d=3,4$. Then, the following holds for all $\frac{d}{d-2}<q<\infty$, $f \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ and $s>0$ :

\left.\left|\left\langle(-\Delta+s)^{-1} V f,\right| x\right|^{-(d-2)}\right\rangle \left.-\frac{(5-d) \pi^{2-\frac{d}{2}}}{2^{d-2} \Gamma\left(\frac{d-2}{2}\right)} \Re \mathcal{F}[V f](0) \delta(s)^{-1} \right\rvert\, \lesssim\|f\|_{L^{q}}, \tag{3.41}
\end{equation*}
$$

where the implicit contant depends only on $d$ and $q$.
Remark 3.5. When $d=4$, it is essential that $q<\infty$ in Lemma 3.11; More precisely, since $V \notin L^{1}\left(\mathbb{R}^{4}\right), \mathcal{F}[V f](0)$ makes no sense for $f \in L_{\mathrm{rad}}^{\infty}\left(\mathbb{R}^{d}\right)$.

Proof of Lemma 3.11. Let $\frac{d}{d-2}<q<\infty, f \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ and $s>0$. Then, by (2.4), (2.5), (2.3), (2.43) and (2.49), we see that

& \left.\left.\left.\left\langle(-\Delta+s)^{-1} V f,\right| x\right|^{-(d-2)}\right\rangle=\left.\frac{1}{(2 \pi)^{d}} \frac{4 \pi^{\frac{d}{2}}}{\Gamma\left(\frac{d-2}{2}\right)}\left\langle\left(|\xi|^{2}+s\right)^{-1} \mathcal{F}[V f],\right| \xi\right|^{-2}\right\rangle \\
& =  \tag{3.42}\\
& C_{d} \Re \int_{|\xi| \leq 1} \frac{\mathcal{F}[V f](0)}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi+C_{d} \Re \int_{|\xi| \leq 1} \frac{\mathcal{F}[V f](\xi)-\mathcal{F}[V f](0)}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi \\
& \quad+C_{d} \Re \int_{1 \leq|\xi|} \frac{\mathcal{F}[V f](\xi)}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi,
\end{align*}
$$

where $C_{d}:=\left\{2^{d-2} \pi^{\frac{d}{2}} \Gamma\left(\frac{d-2}{2}\right)\right\}^{-1}$.
Consider the first term on the right-hand side of (3.42). By (2.30) and $|V(x)| \lesssim$ $(1+|x|)^{-4}($ see (2.10)), we see that

& \left|C_{d} \Re \int_{|\xi| \leq 1} \frac{\mathcal{F}[V f](0)}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi-C_{d}(5-d) \pi^{2} \Re \mathcal{F}[V f](0) \delta(s)^{-1}\right|  \tag{3.43}\\
& \lesssim|\mathcal{F}[V f](0)| \leq\|V f\|_{L^{1}} \lesssim\|f\|_{L^{q}},
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$. Next, consider the second term on the right-hand side of (3.42). Observe that

\int_{|\xi| \leq 1} \frac{\xi}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi=0 \tag{3.44}
\end{equation*}

Furthermore, observe that for any $x \in \mathbb{R}^{d}$ and $\xi \in \mathbb{R}^{d}$,

Fix a number $\varepsilon_{0}$ such that $4-d<\varepsilon_{0}<4-\frac{d(q-1)}{q}$; The dependence of a constant on $\varepsilon_{0}$ is absorbed into than on $d$ and $q$. Observe from $d=3,4$ and $\frac{d}{d-2}<q<\infty$ that $0<\varepsilon_{0}<2$. Then, by (3.45), $|V(x)| \lesssim(1+|x|)^{-4}$, Hölder's inequality, and $\frac{q\left(4-\varepsilon_{0}\right)}{q-1}>d$, we see that

& |\mathcal{F}[V f](\xi)-\mathcal{F}[V f](0)-\xi \cdot \nabla \mathcal{F}[V f](0)| \\
& =\left|\int_{\mathbb{R}^{d}}\left(e^{-i x \cdot \xi}-1+i x \cdot \xi\right) V(x) f(x) d x\right| \\
& \lesssim|\xi|^{\varepsilon_{0}} \int_{\mathbb{R}^{d}}|x|^{\varepsilon_{0}}(1+|x|)^{-4}|f(x)| d x  \tag{3.46}\\
& \lesssim|\xi|^{\varepsilon_{0}}\left\|(1+|x|)^{-\left(4-\varepsilon_{0}\right)}\right\|_{L^{\frac{q}{q-1}}}\|f\|_{L^{q}} \lesssim|\xi|^{\varepsilon_{0}}\|f\|_{L^{q}}
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$. Hence, by (3.44), (3.46) and $d-\varepsilon_{0}<d$, we see that

& \left|\int_{|\xi| \leq 1} \frac{\mathcal{F}[V f](\xi)-\mathcal{F}[V f](0)}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi\right| \\
& =\left|\int_{|\xi| \leq 1} \frac{\mathcal{F}[V f](\xi)-\mathcal{F}[V f](0)-\xi \cdot \nabla \mathcal{F}[V f](0)}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi\right|  \tag{3.47}\\
& \lesssim\|f\|_{L^{q}} \int_{|\xi| \leq 1} \frac{|\xi| \varepsilon^{\varepsilon_{0}}}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi \leq\|f\|_{L^{q}} \int_{|\xi| \leq 1}|\xi|^{-\left(4-\varepsilon_{0}\right)} d \xi \lesssim\|f\|_{L^{q}},
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$.
Consider the last term on the right-hand side of (3.42). By (3.10), Plancherel's theorem, $|V(x)| \lesssim(1+|x|)^{-4}$ and $q>2$, we see that

& \lesssim\|V f\|_{L^{2}}^{\frac{4-d}{2}}\||x| V f\|_{L^{2}}^{\frac{d-2}{2}} \lesssim\|f\|_{L^{q}},
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$. Using (3.48), we see that

\left|\int_{1 \leq|\xi|} \frac{\mathcal{F}[V f](\xi)}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi\right| \lesssim\|f\|_{L^{q}} \int_{1 \leq|\xi|} \frac{1}{|\xi|^{5}} d \xi \lesssim\|f\|_{L^{q}} \tag{3.49}
\end{equation*}
$$

where the implicit constants depend only on $d$ and $q$.
Now, combining (3.42), (3.43), (3.47) and (3.49), we find that (3.41) holds.
Lemma 3.12. Assume $d=3,4$. Then, the following holds for all $s>0$ :

\left\|(-\Delta+s)^{-1} \Lambda W\right\|_{L^{\infty}} \lesssim 1+\delta(s)^{-1} \tag{3.50}

where the implicit constant depends only on $d$.
Proof of Lemma 3.12. Observe from (2.49) and $-\Lambda W=(-\Delta)^{-1} V \Lambda W$ (see (2.25)) that

& \left\|(-\Delta+s)^{-1} \Lambda W\right\|_{L^{\infty}} \sim\left\|\int_{\mathbb{R}^{d}} e^{i x \cdot \xi} \frac{\mathcal{F}[V \Lambda W](\xi)}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi\right\|_{L_{x}^{\infty}} \\
& \leq \int_{|\xi| \leq 1} \frac{|\mathcal{F}[V \Lambda W](\xi)|}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi+\int_{1 \leq|\xi|} \frac{|\mathcal{F}[V \Lambda W](\xi)|}{\left(|\xi|^{2}+s\right)|\xi|^{2}} d \xi \tag{3.51}
\end{align*}
$$

where the implicit constant depends only on $d$.
Consider the first term on the right-hand side of (3.51). By (2.30), we see that

\end{equation*}

where the implicit constants depend only on $d$. Move on to the second term on the right-hand side of (3.51). By (3.10) and Plancherel's theorem, we see that

& \||\xi| \mathcal{F}[V \Lambda W]\|_{L^{\infty}} \lesssim\|\mathcal{F}[V \Lambda W]\|_{L^{2}}^{\frac{4-d}{2}}\|\nabla \mathcal{F}[V \Lambda W]\|_{L^{2}}^{\frac{d-2}{2}} \\
& =\|\mathcal{F}[V \Lambda W]\|_{L^{2}}^{\frac{4-d}{2}}\|\mathcal{F}[x V \Lambda W]\|_{L^{2}}^{\frac{d-2}{2}} \lesssim\|V \Lambda W\|_{L^{2}}^{\frac{4-d}{2}}\||x| V \Lambda W\|_{L^{2}}^{\frac{d-2}{2}} \lesssim 1, \tag{3.53}
\end{align*}

where the implicit constants depend only on $d$. Hence, we find from (3.53) and $d=3,4$ that

where the implicit constants depend only on $d$. Plugging (3.52) and (3.54) into (3.51), we obtain the desired estimate (3.50).

Lemma 3.13. Assume $d=3,4$. Then, there exists a constant $\mathcal{C}>0$ depending only on $d$ such that the following holds for all $\frac{d}{d-2}<q<\infty, g \in L_{\text {rad }}^{q}\left(\mathbb{R}^{d}\right)$ and $s>0$ :

\begin{equation*}
\mid\left\langle(-\Delta+s)^{-1} V g, \Lambda W\right\rangle+\operatorname{C\Re \mathcal {F}[Vg](0)\delta (s)^{-1}|\lesssim \| g\| _{L^{q}},~} \tag{3.55}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$.
Proof of Lemma 3.13. Decompose $\Lambda W$ as

$$
\begin{equation*}
\Lambda W(x)=-\frac{|x|^{2}}{2 d}\left(\frac{|x|^{2}}{d(d-2)}\right)^{-\frac{d}{2}}+\frac{d-2}{2}\left(1+\frac{|x|^{2}}{d(d-2)}\right)^{-\frac{d}{2}}+Z(x), \tag{3.56}
\end{equation*}
$$

where

$$
\begin{equation*}
Z(x):=-\frac{|x|^{2}}{2 d}\left(1+\frac{|x|^{2}}{d(d-2)}\right)^{-\frac{d}{2}}+\frac{|x|^{2}}{2 d}\left(\frac{|x|^{2}}{d(d-2)}\right)^{-\frac{d}{2}} \tag{3.57}
\end{equation*}
$$

Let $\frac{d}{d-2}<q<\infty, g \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ and $s>0$. Then, it follows from (3.56) that

$$
\begin{align*}
\left\langle(-\Delta+s)^{-1} V g, \Lambda W\right\rangle= & \left.-\left.\frac{\{d(d-2)\}^{\frac{d}{2}}}{2 d}\left\langle(-\Delta+s)^{-1} V g,\right| x\right|^{-(d-2)}\right\rangle \\
& +\frac{d-2}{2}\left\langle(-\Delta+s)^{-1} V g,\left(1+\frac{|x|^{2}}{d(d-2)}\right)^{-\frac{d}{2}}\right\rangle  \tag{3.58}\\
& +\left\langle(-\Delta+s)^{-1} V g, Z\right\rangle .
\end{align*}
$$

Consider the first term on the right-hand side of (3.58). Lemma 3.11 shows that there exists $A>0$ depending only on $d$ such that

$$
\begin{equation*}
\left.\left|-\frac{\{d(d-2)\}^{\frac{d}{2}}}{2 d}\left\langle(-\Delta+s)^{-1} V g,\right| x\right|^{-(d-2)}\right\rangle+A \Re \mathcal{F}[V g](0) \delta(s)^{-1} \mid \lesssim\|g\|_{L^{q}}, \tag{3.59}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$. Consider the second term on the right-hand side of (3.58). Observe from $d=3,4$ that $\frac{4 d}{2 d-5}>\frac{d}{d-2}, \frac{4 d}{2 d+5}>1$ and $\frac{4 d}{2 d+3}<\frac{d}{d-2}<q$. Then, by Hölder's inequality and Lemma 3.5, we see that

\begin{align*}
& \left|\frac{d-2}{2}\left\langle(-\Delta+s)^{-1} V g,\left(1+\frac{|x|^{2}}{d(d-2)}\right)^{-\frac{d}{2}}\right\rangle\right|  \tag{3.60}\\
& \lesssim\left\|(-\Delta+s)^{-1} V g\right\|_{L^{\frac{4 d}{2 d-5}}}\left\|(1+|x|)^{-d}\right\|_{L^{\frac{4 d}{2 d+5}}} \lesssim\|V g\|_{L^{\frac{4 d}{2 d+3}}} \lesssim\|g\|_{L^{q}},
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$. It remains to estimate the last term on the right-hand side of (3.58). Observe from the fundamental theorem of calculus, $\frac{4 d}{2 d+5}(d-1)<d$ and $\frac{4 d}{2 d+5}>1$ that

\begin{align*}
\|Z\|_{L^{\frac{4 d}{2 d+5}}} & =\left\|\frac{|x|^{2}}{4} \int_{0}^{1}\left(\theta+\frac{|x|^{2}}{d(d-2)}\right)^{-\frac{d}{2}-1} d \theta\right\|_{L^{\frac{4 d}{2 d+5}}}  \tag{3.61}\\
& \lesssim \int_{0}^{1} \theta^{-\frac{1}{2}} d \theta\left\||x|^{-(d-1)}\right\|_{L^{\frac{4 d}{2 d+5}(|x| \leq 1)}}+\left\||x|^{-d}\right\|_{L^{\frac{4 d}{2 d+5}}(1 \leq|x|)} \lesssim 1
\end{align*}
$$

where the implicit constants depend only on $d$. Then, by (3.61) and the same computation as (3.60), we see that

$$
\begin{equation*}
\left|\left\langle(-\Delta+s)^{-1} V g, Z\right\rangle\right| \lesssim\left\|(-\Delta+s)^{-1} V g\right\|_{L^{\frac{4 d}{2 d-5}}}\|Z\|_{L^{\frac{4 d}{2 d+5}}} \lesssim\|g\|_{L^{q}}, \tag{3.62}
\end{equation*}
$$

where the implicit constants depend only on $d$ and $q$.
Putting (3.58), (3.59), (3.60) and (3.62) together, we find that (3.55) holds.

The following lemma can be proved in a way similar to Lemma 3.13:
Lemma 3.14 (cf. Lemma 2.5 of 7). Assume $d=3,4$. Then, there exists a constant $\mathcal{C}>0$ dependeing only on $d$ such that the following holds for all $\frac{d}{d-2}<q<\infty, g \in$ $L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ and $s>0$ :

\left|\left\langle(-\Delta+s)^{-1} V g, W\right\rangle-\operatorname{e} \Re \mathcal{F}[V g](0) \delta(s)^{-1}\right| \lesssim\|g\|_{L^{q}}, \tag{3.63}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$.
Proof of Lemma 3.14. Rewrite $W$ as

$$
\begin{equation*}
W(x)=\left(\frac{|x|^{2}}{d(d-2)}\right)^{\frac{-(d-2)}{2}}+Z(x), \tag{3.64}
\end{equation*}
$$

where

$$
\begin{equation*}
Z(x):=\left(1+\frac{|x|^{2}}{d(d-2)}\right)^{\frac{-(d-2)}{2}}-\left(\frac{|x|^{2}}{d(d-2)}\right)^{\frac{-(d-2)}{2}} . \tag{3.65}
\end{equation*}
$$

Then, it is easy to see that the same proof as Lemma 3.13 is applicable.
Lemma 3.15. Assume $d=3,4$. Then, there exists a constant $A_{1}>0$ depending only on $d$ such that the following holds for all $s>0$ :

\left|\left\langle(-\Delta+s)^{-1} W, V \Lambda W\right\rangle-A_{1} \delta(s)^{-1}\right| \lesssim 1, \tag{3.66}
\end{equation*}
$$

where the implicit constant depends only on $d$.
Proof of Lemma 3.15. Observe from (2.15) that

$$
\begin{equation*}
\Re \mathcal{F}[V \Lambda W](0)=-\frac{d+2}{d-2}\left\langle W^{\frac{4}{d-2}}, \Lambda W\right\rangle=\frac{d-2}{2}\|W\|_{L^{\frac{d+2}{d-2}}}^{\frac{d+2}{d-2}} . \tag{3.67}
\end{equation*}
$$

Then, applying Lemma 3.14 as $g=\Lambda W$ and $q=2^{*}$, we find that the claim of the lemma is true.

Lemma 3.16 (cf. Lemma 2.5 of [7). Assume $d=3,4$ and $\frac{2}{d-2}<p<\frac{d+2}{d-2}$. Then, the following holds for all $s>0$ and $\max \left\{1, \frac{d}{(d-2) p}\right\}<r<\frac{d}{2}$ :

\begin{equation*}
\left|\left\langle(-\Delta+s)^{-1} W^{p}, V \Lambda W\right\rangle-K_{p}\right| \lesssim s^{\frac{d}{2 r}-1}, \tag{3.68}
\end{equation*}
$$

where the implicit constant depends only on $d$, $p$ and $r$, and

$$
\begin{equation*}
K_{p}:=-\left\langle W^{p}, \Lambda W\right\rangle=\frac{4-(d-2)(p-1)}{2(p+1)}\|W\|_{L^{p+1}}^{p+1} . \tag{3.69}
\end{equation*}
$$

Proof of Lemma 3.16. Let $s>0$. Observe from $V \Lambda W=\Delta W$ (see (2.13)) that

$$
\begin{align*}
\left\langle(-\Delta+s)^{-1} W^{p}, V \Lambda W\right\rangle & =\left\langle W^{p},(-\Delta+s)^{-1}\{-(-\Delta+s)+s\} \Lambda W\right\rangle \\
& =-\left\langle W^{p}, \Lambda W\right\rangle+s\left\langle W^{p},(-\Delta+s)^{-1} \Lambda W\right\rangle . \tag{3.70}
\end{align*}
$$

Furthermore, by Hölder's inequality and Lemma[3.4, we see that for any $\max \left\{1, \frac{d}{(d-2) p}\right\}<$ $r<\frac{d}{2}$,

\begin{align*}
& s\left|\left\langle W^{p},(-\Delta+s)^{-1} \Lambda W\right\rangle\right| \leq s\left\|W^{p}\right\|_{L^{r}}\left\|(-\Delta+s)^{-1} \Lambda W\right\|_{L^{\frac{r}{r-1}}} \\
& \lesssim s^{\frac{d-2}{2}-\frac{d(r-1)}{2 r}}\|\Lambda W\|_{L_{\text {weak }}^{\frac{d}{d-2}}} \lesssim s^{\frac{d}{2 r}-1}, \tag{3.71}
\end{align*}
$$

where the implicit constants depend only on $d, p$ and $r$. Putting (3.70) and (3.71) together, and using (2.15), we obtain the desired estimate (3.68).

### 3.2 Proof of Proposition 3.1

In this section, we give a proof of Proposition 3.1. Assume $d=3,4$, and let $\frac{d}{d-2}<q \leq \infty$.
We introduce operators $Q$ and $\Pi$ from $L^{q}\left(\mathbb{R}^{d}\right)$ to itself as

\end{equation*}
$$

Observe that $Q^{2}=Q, \Pi^{2}=\Pi$, and

\begin{equation*}
\|Q\|_{L^{q} \rightarrow L^{q}} \lesssim 1, \tag{3.73}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$. Furthermore, it follows from $(-\Delta) \Lambda W=-V \Lambda W$ that

$$
\begin{align*}
& \left\{1+(-\Delta)^{-1} V\right\} Q=0,  \tag{3.74}\\
& \Pi\left\{1+(-\Delta)^{-1} V\right\}=0 . \tag{3.75}
\end{align*}
$$

Lemma 3.17. Assume $d=3,4$, and let $\frac{d}{d-2}<q \leq \infty$. Then, the following hold:

$$
\begin{aligned}
& X_{q}=(1-Q) L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right):=\left\{(1-Q) f: f \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)\right\}, \\
& X_{q}=(1-\Pi) L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right):=\left\{(1-\Pi) f: f \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)\right\} .
\end{aligned}
$$

Furthermore, $\left.(1-Q)\right|_{X_{q}}$ and $\left.(1-\Pi)\right|_{X_{q}}$ are the identity maps, namely

(1-Q) f=(1-\Pi) f=f \quad \text { for all } f \in X_{q} . \tag{3.76}
\end{equation*}
$$

Proof of Lemma 3.17. Observe that for any $f \in L^{q}\left(\mathbb{R}^{d}\right)$,

\langle(1-Q) f, V \Lambda W\rangle=0 . \tag{3.77}
\end{equation*}
$$

Hence, $(1-Q) L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \subset X_{r}$. On the other hand, if $f \in X_{q}$, then $\langle f, V \Lambda W\rangle=0$ and therefore $f=Q f+(1-Q) f=(1-Q) f$. Thus, $X_{q} \subset(1-Q) L_{\text {rad }}^{q}\left(\mathbb{R}^{d}\right)$. Similarly, we can prove $(1-\Pi) L_{\text {rad }}^{q}\left(\mathbb{R}^{d}\right)=X_{q}$.

Next, for $d \geq 3$ and $\frac{d}{d-2}<q \leq \infty$, we introduce linear subspaces $\mathbf{X}_{q}$ and $\mathbf{Y}_{q}$ of $L^{q}\left(\mathbb{R}^{d}\right) \times L^{q}\left(\mathbb{R}^{d}\right)$ equipped with the norms $\|\cdot\|_{\mathbf{X}_{q}}$ and $\|\cdot\|_{\mathbf{Y}_{q}}$ as

\begin{array}{ll}
\mathbf{X}_{q}:=X_{q} \times Q L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right), & \left\|\left(f_{1}, f_{2}\right)\right\|_{\mathbf{x}_{q}}:=\left\|f_{1}\right\|_{L^{q}}+\left\|f_{2}\right\|_{L^{q}}, \\
\mathbf{Y}_{q}:=X_{q} \times \Pi L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right), & \left\|\left(f_{1}, f_{2}\right)\right\|_{\mathbf{Y}_{q}}:=\left\|f_{1}\right\|_{L^{q}}+\left\|f_{2}\right\|_{L^{q}} . \tag{3.79}
\end{array}
$$

Furthermore, for $\varepsilon>0$, we define operators $B_{\varepsilon}: \mathbf{X}_{q} \rightarrow L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ and $\mathbf{C}: L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow \mathbf{Y}_{q}$ by

$$
\begin{align*}
B_{\varepsilon}\left(f_{1}, f_{2}\right) & :=\varepsilon f_{1}+f_{2}, \quad \text { for all }\left(f_{1}, f_{2}\right) \in \mathbf{X}_{q},  \tag{3.80}\\
\mathbf{C} f & :=((1-Q) f, \Pi f) \quad \text { for all } f \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) . \tag{3.81}
\end{align*}
$$

Lemma 3.18. Assume $d=3,4$. Let $\frac{d}{d-2}<q \leq \infty$. Then, the following hold:

1. For any $\varepsilon>0, B_{\varepsilon}: \mathbf{X}_{q} \rightarrow L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ is surjective.
2. $\mathrm{C}: L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow \mathbf{Y}_{q}$ is injective.

Proof of Lemma 3.18. Let $g \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$, and define $f_{1}:=\varepsilon^{-1}(1-Q) g$ and $f_{2}:=Q g$. Then, Lemma 3.17 shows that $\left(f_{1}, f_{2}\right) \in \mathbf{X}_{q}$. Furthermore, it is obvious that $B_{\varepsilon}\left(f_{1}, f_{2}\right)=$ $g$. Hence, $B_{\varepsilon}$ is surjective.

Let $f \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$. Suppose $\mathbf{C} f=0$, so that $(1-Q) f=0$ and $\Pi f=0$. In particular, we have $f=Q f=c \Lambda W$ for some $c \in \mathbb{R}$. Furthermore, this together with $\Pi f=0$ implies $c=0$. Thus, $f=0$ and $\mathbf{C}$ is injective.

Lemma 3.19. Assume $d=3,4$. Then, all of the following hold:

1. For any $\frac{d}{d-2}<q<\infty$ and $s>0$,

$$
\begin{equation*}
s\left\|(-\Delta+s)^{-1}(-\Delta)^{-1} V Q\right\|_{L^{q} \rightarrow L^{q}} \lesssim s^{\frac{d-2}{2}-\frac{d}{2 q}} \tag{3.82}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$.
2. For any $0<s \leq 1$,

$$
\begin{equation*}
s\left\|(-\Delta+s)^{-1}(-\Delta)^{-1} V Q\right\|_{L^{\infty} \rightarrow L^{\infty}} \lesssim \delta(s)^{-1} s \tag{3.83}
\end{equation*}
$$

where the implicit constant depends only on $d$.
3. For any $\frac{d}{d-2}<q \leq \infty, \frac{d}{d-2}<r<\infty$ and $0<s \leq 1$,

$$
\begin{equation*}
s\left\|\Pi(-\Delta+s)^{-1}(-\Delta)^{-1} V\right\|_{L_{\mathrm{rad}}^{r} \rightarrow \Pi L_{\mathrm{rad}}^{q}} \lesssim \delta(s)^{-1} s \tag{3.84}
\end{equation*}
$$

where the implicit constant depends only on $d, q$ and $r$ (independent of $s$ ); If $d=3$, then (3.84) still holds for $r=\infty$.
Proof of Lemma 3.19. We shall prove (3.82) and (3.83). Let $\frac{d}{d-2}<q \leq \infty, f \in L^{q}\left(\mathbb{R}^{d}\right)$ and $s>0$. Observe from $(-\Delta)^{-1} V \Lambda W=-\Lambda W$ (see (2.25)) and Hölder's inequality that

\begin{align*}
& s\left\|(-\Delta+s)^{-1}(-\Delta)^{-1} V Q f\right\|_{L^{q}}=s \frac{|\langle f, V \Lambda W\rangle|}{|\langle\Lambda W, V \Lambda W\rangle|}\left\|(-\Delta+s)^{-1}(-\Delta)^{-1} V \Lambda W\right\|_{L^{q}}  \tag{3.85}\\
& \lesssim s\|f\|_{L^{q}}\left\|(-\Delta+\alpha)^{-1} \Lambda W\right\|_{L^{q}},
\end{align*}
$$

where the implicit constant depends only on $d$ and $q$. Assume $q \neq \infty$. Then, applying Lemma 3.4 to the right-hand side of (3.85), we see that

$$
\begin{equation*}
s\left\|(-\Delta+s)^{-1}(-\Delta)^{-1} V Q f\right\|_{L^{q}} \lesssim s^{\frac{d}{2}\left(\frac{d-2}{d}-\frac{1}{q}\right)}\|f\|_{L^{q}}\|\Lambda W\|_{L_{\text {weak }}^{\frac{d}{d-2}}} \lesssim s^{\frac{d-2}{2}-\frac{d}{2 q}}\|f\|_{L^{q}} \tag{3.86}
\end{equation*}
$$

where the implicit constants depend only on $d$ and $q$. Thus, (3.82) holds. When $q=\infty$ and $0<s \leq 1$, applying Lemma 3.12 to the right-hand side of (3.85), we see that

s\left\|(-\Delta+s)^{-1}(-\Delta)^{-1} V Q f\right\|_{L^{\infty}} \lesssim s \delta(s)^{-1}\|f\|_{L^{\infty}} \tag{3.87}
\end{equation*}
$$

where the implicit constant depends only on $d$. Thus, (3.83) holds.

Next, we shall prove (3.84). Let $g \in L_{\text {rad }}^{r}\left(\mathbb{R}^{d}\right)$. Observe from $|V(x)| \lesssim(1+|x|)^{-4}$ and $r<\infty$ that

|\mathcal{F}[V g](0)| \leq\|V g\|_{L^{1}} \lesssim\|g\|_{L^{r}} \tag{3.88}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $r$; Note here that when $d=3$, (3.88) still holds for $r=\infty$. Then, by $(-\Delta)^{-1} V \Lambda W=-\Lambda W$, Lemma 3.13 and (3.88), we see that

\begin{align*}
& s\left\|\Pi(-\Delta+s)^{-1}(-\Delta)^{-1} V g\right\|_{L^{q}}=s\left\|\Pi(-\Delta)^{-1}(-\Delta+s)^{-1} V g\right\|_{L^{q}} \\
& =s \frac{\left|\left\langle(-\Delta)^{-1}(-\Delta+s)^{-1} V g, V \Lambda W\right\rangle\right|}{\|V \Lambda W\|_{L^{2}}^{2}}\|V \Lambda W\|_{L^{q}}  \tag{3.89}\\
& =s \frac{\left|\left\langle(-\Delta+s)^{-1} V g, \Lambda W\right\rangle\right|}{\|V \Lambda W\|_{L^{2}}^{2}}\|V \Lambda W\|_{L^{q}} \lesssim s \delta(s)^{-1}\|g\|_{L^{r}},
\end{align*}
$$

where the implicit constant depends only on $d, q$ and $r$. Thus, (3.84) holds.
Now, we are in a position to prove Proposition 3.1:
Proof of Proposition 3.1. Assume $d=3,4$. Let $\frac{d}{d-2}<q<\infty$, and let $0<s<1$ be a small number to be specified later. Furthermore, let $\varepsilon>0$ be a small constant to be chosen later dependently only on $d$ and $q$.

Observe from Lemma 3.4 that $1+(-\Delta+s)^{-1} V \operatorname{maps} L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ to itself. Recall from Lemma 3.18 that $B_{\varepsilon}: \mathbf{X}_{q} \rightarrow L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ is surjective, and $\mathbf{C}: L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow \mathbf{Y}_{q}$ is injective. Then, we define an operator $\mathbf{A}_{\varepsilon}(s)$ from $\mathbf{X}_{q}$ to $\mathbf{Y}_{q}$ as

$$
\begin{equation*}
\mathbf{A}_{\varepsilon}(s):=\mathbf{C}\left\{1+(-\Delta+s)^{-1} V\right\} B_{\varepsilon} \tag{3.90}
\end{equation*}
$$

By Lemma 3.12 of [14] (see Lemma C. 3 in Appendix C), we see that if the inverse of $\mathbf{A}_{\varepsilon}(s)$ exists, then the operator $1+(-\Delta+s)^{-1} V: L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ has the inverse and

$$
\begin{equation*}
\left\{1+(-\Delta+s)^{-1} V\right\}^{-1}=B_{\varepsilon}\left\{\mathbf{A}_{\varepsilon}(s)\right\}^{-1} \mathbf{C} \tag{3.91}
\end{equation*}
$$

This fact is the main point of the proof.
Let $\left(f_{1}, f_{2}\right) \in \mathbf{X}_{q}$. We may write $\mathbf{A}_{\varepsilon}(s)\left(f_{1}, f_{2}\right)$ as follows (we do not care about the distinction between column and row vectors):

$$
\mathbf{A}_{\varepsilon}(s)\left(f_{1}, f_{2}\right)=\left(A_{11} f_{1}+A_{12} f_{2}, A_{21} f_{1}+A_{22} f_{2}\right)=\left(\begin{array}{cc}
A_{11} & A_{12}  \tag{3.92}\\
A_{21} & A_{22}
\end{array}\right)\binom{f_{1}}{f_{2}}
$$

where

$$
\begin{align*}
& A_{11}:=\left.\varepsilon(1-Q)\left\{1+(-\Delta+s)^{-1} V\right\}\right|_{X_{q}}  \tag{3.93}\\
& A_{12}:=(1-Q)\left\{1+(-\Delta+s)^{-1} V\right\} Q  \tag{3.94}\\
& A_{21}:=\left.\varepsilon \Pi\left\{1+(-\Delta+s)^{-1} V\right\}\right|_{X_{q}},  \tag{3.95}\\
& A_{22}:=\Pi\left\{1+(-\Delta+s)^{-1} V\right\} Q . \tag{3.96}
\end{align*}
$$

Recall that $1+(-\Delta+s)^{-1} V: L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$. Then, observe from Lemma 3.17 and (3.73) that

A_{21}: X_{q} \rightarrow \Pi L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right), \quad A_{22}: Q L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow \Pi L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \tag{3.98}
\end{equation*}
$$

We divide the proof into several steps:
Step 1. We consider the operator $A_{11}: X_{q} \rightarrow X_{q}$ (see (3.93)).
Observe from Lemma 3.10 that $\left.\left\{1+(-\Delta)^{-1} V\right\}\right|_{X_{q}}: X_{q} \rightarrow X_{q}$ has the inverse, say $K_{1}$, such that

where the implicit constant depends only on $d$ and $q$. Furthermore, (3.76) in Lemma 3.17 shows that

\left.(1-Q)\left\{1+(-\Delta)^{-1} V\right\}\right|_{X_{q}}=\left.\left\{1+(-\Delta)^{-1} V\right\}\right|_{X_{q}} . \tag{3.100}

Then, by (3.19) and (3.100) we may rewrite $A_{11}$ as

\end{equation*}

S_{11}:=-\left.s(1-Q)(-\Delta+s)^{-1}(-\Delta)^{-1} V\right|_{X_{q}} . \tag{3.102}

Now, fix $1<r_{0}<\frac{d q}{d+2 q}$; The dependence of a constant on $r_{0}$ can be absorbed into that on $d$ and $q$. Note that $q>\frac{d r_{0}}{d-2 r_{0}}$. Then, by (3.99), (3.73), Lemma 3.4 and (2.20), we see that for any $f \in X_{q}$,

& \lesssim s^{\frac{d}{2}\left(\frac{d-2 r_{0}}{d r_{0}}-\frac{1}{q}\right)}\|V f\|_{L^{r_{0}}} \lesssim s^{\frac{d}{2}\left(\frac{d-2 r_{0}}{d r_{0}}-\frac{1}{q}\right)}\|f\|_{L^{q}},
\end{align*}
$$

where the implicit constants depend only on $d$ and $p$. Observe from the computations in (3.103) and Lemma 3.17 that $S_{11}: X_{q} \rightarrow X_{q}$. Hence, the Neumann series shows that if $s$ is sufficiently small dependently only on $d$ and $q$, then the operator $1+K_{1} S_{11}: X_{q} \rightarrow X_{q}$ has the inverse, say $K_{2}$, which satisfies

\left\|K_{2}\right\|_{X_{q} \rightarrow X_{q}} \leq\left(1-\left\|K_{1} S_{11}\right\|_{X_{q} \rightarrow X_{q}}\right)^{-1} \lesssim 1 \tag{3.104}

where the implicit constant depends only on $d$ and $q$. We summarize:

A_{11}^{-1}=\varepsilon^{-1} K_{2} K_{1}, \quad\left\|A_{11}^{-1}\right\|_{X_{q} \rightarrow X_{q}} \lesssim \varepsilon^{-1} \tag{3.105}
\end{equation*}

where $K_{1}$ and $K_{2}$ are the inverses of $\left.\left(1+(-\Delta)^{-1} V\right)\right|_{X_{q}}: X_{q} \rightarrow X_{q}$, and $1+K_{1} S_{11}: X_{q} \rightarrow$ $X_{q}$, respectively, and the implicit constant depends only on $d$ and $q$.
Step 2. We consider the operator $A_{12}: Q L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow X_{q}$ (see (3.94)). Our aim is to show that

\left\|A_{12}\right\|_{Q L_{\mathrm{rad}}^{q} \rightarrow X_{q}} \lesssim s^{\frac{d-2}{2}-\frac{d}{2 q}}, \tag{3.106}
\end{equation*}

where the implicit constant depends only on $d$ and $q$.
Let $f \in Q L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$. Then, by (3.19), (3.74) and (3.73), we see that

& =\left\|(1-Q)\left\{s(-\Delta+s)^{-1}(-\Delta)^{-1} V\right\} Q f\right\|_{L^{q}}  \tag{3.107}\\
& \lesssim s\left\|(-\Delta+s)^{-1}(-\Delta)^{-1} V Q f\right\|_{L^{q}},
\end{align*}
$$

where the implicit constant depends only on $d$ and $q$. Applying (3.82) in Lemma 3.19 to the right-hand side of (3.107), we obtain (3.106).
Step 3. We consider the operator $A_{21}: X_{q} \rightarrow \Pi L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ (see (3.95)). By (3.19), (3.75), and (3.84) in Lemma 3.19 with $r=q$, we see that

where the implicit constant depends only on $d$ and $q$.
Step 4. We consider the operator $A_{22}: Q L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow \Pi L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ (see (3.96)).
Let $f \in Q L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$. Observe from (3.19), (3.74) and $(-\Delta)^{-1} V \Lambda W=-\Lambda W$ (see (2.25)) that

A_{22} f & =-s \Pi(-\Delta+s)^{-1}(-\Delta)^{-1} V Q f \\
& =-s \frac{\langle f, V \Lambda W\rangle}{\langle\Lambda W, V \Lambda W\rangle\|V \Lambda W\|_{L^{2}}^{2}}\left\langle(-\Delta+s)^{-1}(-\Delta)^{-1} V \Lambda W, V \Lambda W\right\rangle V \Lambda W \\
& =s \frac{\langle f, V \Lambda W\rangle}{\langle\Lambda W, V \Lambda W\rangle\|V \Lambda W\|_{L^{2}}^{2}}\left\langle\Lambda W,(-\Delta+s)^{-1} V \Lambda W\right\rangle V \Lambda W  \tag{3.109}\\
& =s \frac{\left\langle\Lambda W,(-\Delta+s)^{-1} V \Lambda W\right\rangle}{\langle\Lambda W, V \Lambda W\rangle} \Pi f .
\end{align*}
$$

Furthermore, applying Lemma 3.13 to the right-hand side of (3.109) as $g=\Lambda W$, we find that $A_{22} f$ can be written as follows:

where $\mathcal{C}_{0}$ and $\mathcal{C}_{1}$ are some constants depending only on $d$. Define the operator $G$ with domain $Q L_{\text {rad }}^{q}\left(\mathbb{R}^{d}\right)$ as

Observe that $G: Q L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow \Pi L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ is bijective, and the inverse $G^{-1}: \Pi L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow$ $Q L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ is given by

\left\|s \mathfrak{C}_{1} G^{-1} \Pi f\right\|_{L^{q}} \lesssim \delta(s)|\langle\Pi f, \Lambda W\rangle|\|\Lambda W\|_{L^{q}} \lesssim \delta(s)|\langle f, V \Lambda W\rangle| \lesssim \delta(s)\|f\|_{L^{q}} \tag{3.114}
\end{equation*}
$$

where the implicit constants depend only on $d$ and $q$. Hence, the Neumann series shows that if $s$ is sufficiently small dependently only on $d$ and $q$, then the operator $1+s \mathcal{C}_{1} G^{-1} \Pi: Q L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right) \rightarrow Q L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ has the inverse, say $L$, such that

\|L\|_{Q L_{\mathrm{rad}}^{q} \rightarrow Q L_{\mathrm{rad}}^{q}} \lesssim 1 \tag{3.115}
\end{equation*}

where the implicit constant depends only on $d$ and $q$. Then, we see that

A_{22}^{-1}=L G^{-1}, \quad\left\|A_{22}^{-1}\right\|_{\Pi L_{\mathrm{rad}}^{q} \rightarrow Q L_{\mathrm{rad}}^{q}} \lesssim \delta(s) s^{-1}, \tag{3.116}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$.
Step 5. We shall finish the proof. To this end, we define

1 & A_{11}^{-1} A_{12}  \tag{3.117}\\
A_{22}^{-1} A_{21} & 1

1 & 0 \\
0 & 1
\end{array}\right) .

Note that $\widetilde{\mathbf{A}}_{\varepsilon}: \mathbf{X}_{q} \rightarrow \mathbf{X}_{q}$. Observe from (3.92) that

\end{array}\right) \widetilde{\mathbf{A}}_{\varepsilon}\binom{f_{1}}{f_{2}} \quad \text { for all }\left(f_{1}, f_{2}\right) \in \mathbf{X}_{q}
$$

By (3.105), (3.116), (3.106) and (3.108), we see that if $s$ is sufficiently small depending only on $d$ and $q$,

\left\|\mathbf{I}-\widetilde{\mathbf{A}}_{\varepsilon}\right\|_{\mathbf{X}_{q} \rightarrow \mathbf{X}_{q}} & \leq\left\|A_{11}^{-1} A_{12}\right\|_{Q L_{\mathrm{rad}}^{q} \rightarrow X_{q}}+\left\|A_{22}^{-1} A_{21}\right\|_{X_{q} \rightarrow Q L_{\mathrm{rad}}^{q}} \\
& \lesssim \varepsilon^{-1}\left\|A_{12}\right\|_{Q L_{\mathrm{rad}}^{q} \rightarrow X_{q}}+\delta(s) s^{-1}\left\|A_{21}\right\|_{X_{q} \rightarrow \Pi L_{\mathrm{rad}}^{q}}  \tag{3.119}\\
& \lesssim \varepsilon^{-1} s^{\frac{d-2}{2}-\frac{d}{2 q}}+\varepsilon,
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$. Thus, we find that there exist $s_{0}>0$ and $\varepsilon_{0}>0$, both depending only on $d$ and $q$, such that for any $0<s<s_{0}$,

\left\|\mathbf{I}-\widetilde{\mathbf{A}}_{\varepsilon_{0}}\right\|_{\mathbf{X}_{q} \rightarrow \mathbf{X}_{q}} \leq \frac{1}{2} \tag{3.120}

and $\widetilde{\mathbf{A}}_{\varepsilon_{0}}$ has the inverse $\mathbf{D}:=\widetilde{\mathbf{A}}_{\varepsilon_{0}}^{-1}$ satisfying

$$
\begin{equation*}
\|\mathbf{D}\|_{\mathbf{X}_{q} \rightarrow \mathbf{x}_{q}} \leq 2 . \tag{3.121}
\end{equation*}
$$

The dependence of a constant on $\varepsilon_{0}$ can be absorbed into that on $d$ and $q$. Furthermore, we may assume that $\varepsilon_{0} \leq \delta\left(s_{0}\right) s_{0}^{-1}$. Then, for any $0<s<s_{0}$, the inverse of $\mathbf{A}_{\varepsilon_{0}}(s)$ exists and is given by

\mathbf{A}_{\varepsilon_{0}}(s)^{-1}=\left(\begin{array}{ll}
D_{11} & D_{12}  \tag{3.122}\\
D_{21} & D_{22}
\end{array}\right)\left(\begin{array}{cc}
A_{11}^{-1} & 0 \\
0 & A_{22}^{-1}
\end{array}\right),
$$

where $D_{j k}$ is the $(j, k)$-entry of $\mathbf{D}$. Furthermore, we see from (3.105), (3.116) and (3.121) that for any $0<s<s_{0}$,

\left\|\mathbf{A}_{\varepsilon_{0}}(s)^{-1}\right\|_{\mathbf{Y} \rightarrow \mathbf{X}} \lesssim\left\|A_{11}^{-1}\right\|_{X_{q} \rightarrow X_{q}}+\left\|A_{22}^{-1}\right\|_{\Pi L_{\mathrm{rad}}^{q} \rightarrow Q L_{\mathrm{rad}}^{q}} \lesssim \delta(s) s^{-1} \tag{3.123}
\end{equation*}
$$

where the implicit constants depend only on $d$ and $q$. Thus, Lemma 3.12 of [14] (see Lemma C.3 in Appendix C) shows that for any $0<s<s_{0}$, the inverse of $1+(-\Delta+s)^{-1} V$ exists as an operator from $L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right)$ to itself and

\left\{1+(-\Delta+s)^{-1} V\right\}^{-1}=B_{\varepsilon_{0}} \mathbf{A}_{\varepsilon_{0}}(s)^{-1} \mathbf{C} . \tag{3.124}
\end{equation*}

Observe that

\left\|B_{\varepsilon_{0}}\right\|_{\mathbf{X}_{q} \rightarrow L_{\mathrm{rad}}^{q}} \lesssim 1, \quad\|\mathbf{C}\|_{L_{\mathrm{rad}}^{q} \rightarrow \mathbf{Y}} \lesssim 1 . \tag{3.125}
\end{equation*}
$$

Hence, we see from (3.123) through (3.125) that for any $0<s<s_{0}$,

\left\|\left\{1+(-\Delta+s)^{-1} V\right\}^{-1}\right\|_{L_{\mathrm{rad}}^{q} \rightarrow L_{\mathrm{rad}}^{q}} \lesssim \delta(s) s^{-1}, \tag{3.126}
\end{equation*}
$$

which proves (3.1).
In remains to prove (3.2). Assume $f \in X_{q}$. Then, $\Pi f=0$ and therefore

\left\{1+(-\Delta+s)^{-1} V\right\}^{-1} f & =B_{\varepsilon_{0}}\left(\begin{array}{ll}
D_{11} & D_{12} \\
D_{21} & D_{22}
\end{array}\right)\left(\begin{array}{cc}
A_{11}^{-1} & 0 \\
0 & A_{22}^{-1}
\end{array}\right) \mathbf{C} f  \tag{3.127}\\
& =D_{11} A_{11}^{-1}(1-Q) f+D_{21} A_{11}^{-1}(1-Q) f .
\end{align*}
$$

Then, (3.2) follows from (3.127), (3.105) with $\varepsilon=\varepsilon_{0}$, and (3.121). Thus, we have completed the proof.

## 4 Uniqueness

In this section, we give a proof of Theorem 1.1. Our proof is based on the scaling argument and the fixed-point argument developed in [7]. We will see that "the uniqueness provided by the fixed-point argument" is helpful in proving the uniqueness of ground states to (1.1).

First, observe that if $\Phi$ is a solution to (1.1) and $\lambda>0$, then $u:=T_{\lambda}[\Phi]$ satisfies

$$
\begin{equation*}
-\Delta u+\omega \lambda^{-2^{*}+2} u-\lambda^{-2^{*}+p+1}|u|^{p-1} u-|u|^{\frac{4}{-2}} u=0 . \tag{4.1}
\end{equation*}
$$

For $s>0$ and $t>0$, we consider a general form of (4.1):

$$
\begin{equation*}
-\Delta u+s u-t|u|^{p-1} u-|u|^{\frac{4}{d-2}} u=0 . \tag{4.2}
\end{equation*}
$$

When $s=t=0$, (4.2) agrees with the equation (2.8). Hence, we may expect that (4.2) admits a ground state asymptotically looks like $W$ as $s, t \rightarrow 0$.

We look for a radial solution to (4.2) of the form $W+\eta$, which leads us to

(-\Delta+V+s) \eta=-s W+t W^{p}+N(\eta ; t), \tag{4.3}
\end{equation*}
$$

where $N(\eta ; t)$ is the function defined by (2.35). By the decomposition $-\Delta+V+s=$ $(-\Delta+s)\left\{1+(-\Delta+s)^{-1} V\right\}$, and the substitution $s=\alpha(\tau)$, we can rewrite (4.3) as

$$
\begin{equation*}
\eta=\left\{1+(-\Delta+\alpha(\tau))^{-1} V\right\}^{-1}(-\Delta+\alpha(\tau))^{-1} F(\eta ; \alpha(\tau), t), \tag{4.4}
\end{equation*}
$$

where $F(\eta ; \alpha(\tau), t):=-\alpha(\tau) W+t W^{p}+N(\eta ; t)$ (see (2.36)). The significance of the substitution $s=\alpha(\tau)$ is that $\alpha(\tau)$ is written as $\tau \delta(\alpha(\tau))$ (see (2.32)); We will use this fact later (see (4.7) below). Note that a solution to (4.2) which asymptotically looks like $W$ corresponds to a solution to (4.4) which vanishes as $\tau \rightarrow 0$ (in $L^{q}\left(\mathbb{R}^{d}\right)$ for all $q>\frac{d}{d-2}$ ). Furthermore, recall from Proposition 3.1 (see also (3.3) in Remark (3.1) that for any $\frac{d}{d-2}<q<\infty$,

\begin{equation*}
\left\|\left\{1+(-\Delta+\alpha(\tau))^{-1} V\right\}^{-1}\right\|_{L_{\mathrm{rad}}^{q} \rightarrow L_{\mathrm{rad}}^{q}} \lesssim \tau^{-1} \tag{4.5}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$. From these point of view, we need to eliminate the singular behavior of a solution to (4.4) arising from (4.5). To this end, we require the following condition, as well as [7]:

\left\langle(-\Delta+\alpha(\tau))^{-1} F(\eta ; \alpha(\tau), t), V \Lambda W\right\rangle=0 \tag{4.6}
\end{equation*}
$$

As a result, we consider the system of (4.4) and (4.6). We will find a solution by using Banach fixed-point theorem, as in [7]. To this end, using (2.36) and $\alpha(\tau)=\tau \delta(\alpha(\tau))$ (see (2.32), we rewrite (4.6) as

\tau=\frac{t\left\langle(-\Delta+\alpha(\tau))^{-1} W^{p}, V \Lambda W\right\rangle+\left\langle(-\Delta+\alpha(\tau))^{-1} N(\eta ; t), V \Lambda W\right\rangle}{\delta(\alpha(\tau))\left\langle(-\Delta+\alpha(\tau))^{-1} W, V \Lambda W\right\rangle} \tag{4.7}
\end{equation*}
$$

Here, we introduce several symbols:
Notation 4.1. 1. For $t>0,0<\tau<1$, and $\eta \in H^{1}\left(\mathbb{R}^{d}\right)$, we define $\mathcal{X}(\tau)$, $\mathcal{W}_{p}(\tau)$ and $\mathcal{N}(t, \tau, \eta)$ as

\mathcal{X}(\tau) & :=\delta(\alpha(\tau))\left\langle(-\Delta+\alpha(\tau))^{-1} W, V \Lambda W\right\rangle,  \tag{4.8}\\
\mathcal{W}_{p}(\tau) & :=\left\langle(-\Delta+\alpha(\tau))^{-1} W^{p}, V \Lambda W\right\rangle,  \tag{4.9}\\
\mathcal{N}(t, \tau, \eta) & :=\left\langle(-\Delta+\alpha(\tau))^{-1} N(\eta ; t), V \Lambda W\right\rangle . \tag{4.10}
\end{align*}
$$

2. For $t>0,0<\tau<1$ and $\eta \in H^{1}\left(\mathbb{R}^{d}\right)$, we define $\mathfrak{s}(t ; \tau, \eta)$ as

$$
\begin{equation*}
\mathfrak{s}(t ; \tau, \eta):=\frac{t \mathcal{W}_{p}(\tau)+\mathcal{N}(t, \tau, \eta)}{X(\tau)} \tag{4.11}
\end{equation*}
$$

3. For $t>0,0<\tau<1$ and $\eta \in H^{1}\left(\mathbb{R}^{d}\right)$, we define $\mathfrak{g}(t ; \tau, \eta)$ as

$$
\begin{equation*}
\mathfrak{g}(t ; \tau, \eta):=\left\{1+(-\Delta+\alpha(\tau))^{-1} V\right\}^{-1}(-\Delta+\alpha(\tau))^{-1} F(\eta ; \alpha(\tau), t) \tag{4.12}
\end{equation*}
$$

4. We use $A_{1}$ and $K_{p}$ to denote the constants given in Lemma 3.15 and Lemma 3.16, respectively.
5. For $t>0$, we define an interval $I(t)$ as

\begin{equation*}
I(t):=\left[\frac{K_{p}}{2 A_{1}} t, \frac{3 K_{p}}{2 A_{1}} t\right] . \tag{4.13}
\end{equation*}
$$

In stead of $I(t)$, we may use any interval which contains $\frac{K_{p}}{A_{1}} t$ and whose length is comparable to $t$.
6. For $\frac{d}{d-2}<q<\infty$ we define a number $\Theta_{q}$ as

\Theta_{q}:=\frac{d-2}{2}-\frac{d}{2 q} . \tag{4.14}
\end{equation*}
$$

7. For $\frac{d}{d-2}<q<\infty, R>0$ and $0<t<1$, we define $Y_{q}(R, t)$ as

\begin{equation*}
Y_{q}(R, t):=\left\{\eta \in L_{\mathrm{rad}}^{q}\left(\mathbb{R}^{d}\right):\|\eta\|_{L^{q}} \leq R \alpha(t)^{\Theta_{q}}\right\} \tag{4.15}
\end{equation*}
$$

Note here that when $d=4, \alpha$ is defined only on $(0,1)$ (see Lemma C.1).

Remark 4.1. Observe from $s=\alpha(\beta(s))$ that

\begin{align*}
\delta(s)\left\langle(-\Delta+s)^{-1} W, V \Lambda W\right\rangle & =\mathcal{X}(\beta(s))  \tag{4.16}\\
\left\langle(-\Delta+s)^{-1} W^{p}, V \Lambda W\right\rangle & =\mathcal{W}_{p}(\beta(s))  \tag{4.17}\\
\left\langle(-\Delta+s)^{-1} N(\eta ; t), V \Lambda W\right\rangle & =\mathcal{N}(t, \beta(s), \eta) \tag{4.18}
\end{align*}
$$

Remark 4.2. 1. We can verify that for any $\frac{d}{d-2}<q<\infty, R>0$ and $0<t<1$, the set $Y_{q}(R, t)$ is complete as a subspace of $L^{q}\left(\mathbb{R}^{d}\right)$ with the induced metric (see Section (B).
2. Since $\alpha(t)$ is strictly increasing on $(0,1)$ and $\lim _{t \rightarrow 0} \alpha(t)=0$ (see Section 圆), we find that: for any $\theta>0$ and $R>0$, there exists $T(\theta, R)>0$ depending only on $d$, $\theta$ and $R$ such that

$$
\begin{equation*}
(1+R)^{\frac{d+2}{d-2}} \alpha(t)^{\theta} \leq 1 \quad \text { for all } 0<t \leq T(\theta, R) \tag{4.19}
\end{equation*}
$$

Now, we use the symbols (4.11) and (4.12) to rewrite the system of the equations (4.4) and (4.6) as follows:

(\tau, \eta)=(\mathfrak{s}(t ; \tau, \eta), \mathfrak{g}(t ; \tau, \eta)) \tag{4.20}
\end{equation*}
$$

We can find a solution to (4.20):
Proposition 4.1. Assume $d=3,4$ and $\frac{4}{d-2}-1<p<\frac{d+2}{d-2}$. Let $\max \left\{2^{*}, \frac{2^{*}}{p-1}\right\}<q<\infty$ and $R>0$. Then, there exists $0<T_{1}(q, R)<1$ depending only on $d, p, q$ and $R$ with the following property: for any $0<t<T_{1}(q, R)$, the product metric space $I(t) \times Y_{q}(R, t)$ admits one and only one solution $\left(\tau_{t}, \eta_{t}\right)$ to (4.20). Furthermore, $\tau_{t}$ is continuous and strictly increasing with respect to $t$ on $\left(0, T_{1}(q, R)\right)$.

Observe that if $\left(\tau_{t}, \eta_{t}\right)$ is a solution to (4.20), then $W+\eta_{t}$ is one to the following equation:

$$
\begin{equation*}
-\Delta u+\alpha\left(\tau_{t}\right) u-t|u|^{p-1} u-|u|^{\frac{4}{d-2}} u=0 . \tag{4.21}
\end{equation*}
$$

We denote the action and Nehari functional associated with (4.21) by

\begin{align*}
& \widetilde{\mathcal{S}}_{t}(u):=\frac{\alpha\left(\tau_{t}\right)}{2}\|u\|_{L^{2}}^{2}+\frac{1}{2}\|\nabla u\|_{L^{2}}^{2}-\frac{t}{p+1}\|u\|_{L^{p+1}}^{p+1}-\frac{1}{2^{*}}\|u\|_{L^{2^{*}}}^{2^{*}},  \tag{4.22}\\
& \widetilde{\mathcal{N}}_{t}(u):=\alpha\left(\tau_{t}\right)\|u\|_{L^{2}}^{2}+\|\nabla u\|_{L^{2}}^{2}-t\|u\|_{L^{p+1}}^{p+1}-\|u\|_{L^{2^{*}}}^{\|^{*}} \tag{4.23}
\end{align*}
$$

Furthermore, we define $\widetilde{\mathcal{G}}_{t}$ as the set of all positive radial ground states to (4.21), namely, $\widetilde{\mathcal{G}_{t}}$ denotes the set of positive radial minimizers for the following variational problem:

$$
\begin{equation*}
\inf \left\{\widetilde{\mathcal{S}}_{t}(u): u \in H^{1}\left(\mathbb{R}^{d}\right) \backslash\{0\}, \widetilde{\mathcal{N}}_{t}(u)=0\right\} . \tag{4.24}
\end{equation*}
$$

The following proposition is a key to proving the uniqueness of ground states to (1.1):
Proposition 4.2 (cf. Lemma 3.11 of [7). Assume $d=3,4$ and $\frac{4}{d-2}-1<p<\frac{d+2}{d-2}$. Let $\max \left\{2^{*}, \frac{2^{*}}{p+3-2^{*}}\right\}<q<\infty$. Furthermore, for $R>0$, let $T_{1}(q, R)$ denote the number given in Proposition 4.1. Then, there exist $R_{*}>0$ and $0<T_{*}<T_{1}\left(q, R_{*}\right)$, both depending only on $d, p$ and $q$, with the following property: Let $0<t<T_{*}$, and let $\left(\tau_{t}, \eta_{t}\right)$ be a unique solution to (4.20) in $I(t) \times Y_{q}\left(R_{*}, t\right)$ (see Proposition 4.1). Then, $W+\eta_{t}$ is a unique positive radial ground state to (4.21); in other words, $\widetilde{\mathcal{G}_{t}}=\left\{W+\eta_{t}\right\}$.

We give a proof of Proposition 4.2 in Section 4.3 .
Now, we are in a position to prove Theorem 1.1.
Proof of Theorem 1.1. Let $d=3,4$ and $\frac{4}{d-2}-1<p<\frac{d+2}{d-2}$. Fix $\max \left\{2^{*}, \frac{2^{*}}{p+3-2^{*}}\right\}<$ $q<\infty$, so that the dependence of a constant on $q$ can be absorbed into that on $d$ and $p$. Then, by Proposition 4.1 and Proposition 4.2, we see that there exist $R_{*}>0$ and $0<T_{*}<1$ depending only on $d$ and $p$ such that for any $0<t \leq T_{*}, I(t) \times Y_{q}\left(R_{*}, t\right)$ admits a unique solution $\left(\tau_{t}, \eta_{t}\right)$ to (4.20), and $\widetilde{\mathcal{G}}_{t}=\left\{W+\eta_{t}\right\}$.

We shall show that there exists $\omega_{*}>0$ with the following property: for any $\omega>\omega_{*}$, there exists $0<t(\omega)<T_{*}$ such that

$$
\begin{equation*}
\alpha\left(\tau_{t(\omega)}\right)=\omega t(\omega)^{\frac{2^{*}-2}{2^{*}-(p+1)}} . \tag{4.25}
\end{equation*}
$$

Observe from $\beta(s)=\delta(s)^{-1} s$ (see (2.31)) that for any $0<t<T_{*}$,

$$
\beta\left(\omega t^{\frac{2^{*}-2}{2^{*}-(p+1)}}\right)=\left\{\begin{array}{cl}
\sqrt{\omega} t^{\frac{2}{5-p}} & \text { if } d=3  \tag{4.26}\\
\log \left(1+\omega^{-1} t^{\frac{-2}{3-p}}\right) \omega t^{\frac{2}{3-p}} & \text { if } d=4
\end{array}\right.
$$

Then, by $\tau_{t} \in I(t):=\left[\frac{K_{p}}{2 A_{1}} t, \frac{3 K_{p}}{2 A_{1}} t\right]$ and (4.26), we find (see Figure (4) that there exists $\omega_{*}>0$ with the following property: for any $\omega>\omega_{*}$, there exists $0<t(\omega)<T_{*}$ such that

$$
\begin{equation*}
\tau_{t(\omega)}=\beta\left(\omega t(\omega)^{\frac{2^{*}-2}{2^{*}-(p+1)}}\right) \tag{4.27}
\end{equation*}
$$



Since $\alpha$ is the inverse function of $\beta$, (4.27) implies (4.25).
Now, we shall finish the proof of Theorem 1.1. Let $\omega_{*}$ be a frequency found in the above, so that for any $\omega>\omega_{*}$, there exists $0<t(\omega)<T_{*}$ such that (4.25) holds. Suppose for contradiction that there exists $\omega>\omega_{*}$ for which the equation (1.1) admits two distinct positive ground states, say $\Phi_{\omega}$ and $\Psi_{\omega}$. Then, we define $\lambda(\omega)>0$ by

\lambda(\omega)^{-\left\{2^{*}-(p+1)\right\}}=t(\omega) \tag{4.28}
\end{equation*}
$$

Furthermore, we define $\widetilde{\Phi}_{\omega}$ and $\widetilde{\Psi}_{\omega}$ as

\begin{equation*}
\widetilde{\Phi}_{\omega}:=T_{\lambda(\omega)}\left[\Phi_{\omega}\right], \quad \widetilde{\Psi}_{\omega}:=T_{\lambda(\omega)}\left[\Psi_{\omega}\right] \tag{4.29}
\end{equation*}
$$

where $T_{\lambda(\omega)}$ is the scaling operator defined by (2.11). We shall derive a contradiction by showing that

$$
\begin{equation*}
\widetilde{\Phi}_{\omega}, \widetilde{\Psi}_{\omega} \in \widetilde{\mathcal{G}}_{t(\omega)} . \tag{4.30}
\end{equation*}
$$

Indeed, (4.30) contradicts Proposition 4.2, Thus, the claim of Theorem 1.1 is true.
Let us prove (4.30). Observe from $\mathcal{N}_{\omega}\left(\Phi_{\omega}\right)=0$, a computation involving the scaling, and (4.25) that

\begin{equation*}
\widetilde{\mathcal{N}}_{t(\omega)}\left(\widetilde{\Phi}_{\omega}\right)=0, \tag{4.31}
\end{equation*}
$$

where $\mathcal{N}_{\omega}$ and $\widetilde{\mathcal{N}}_{t(\omega)}$ are the functionals defined by (1.6) and (4.23), respectively. Furthermore, (4.31) implies

$$
\begin{equation*}
\widetilde{\mathcal{S}}_{t(\omega)}\left(\widetilde{\Phi}_{\omega}\right) \geq \inf \left\{\widetilde{\mathcal{S}}_{t(\omega)}(u): u \in H^{1}\left(\mathbb{R}^{d}\right) \backslash\{0\}, \widetilde{\mathcal{N}}_{t(\omega)}(u)=0\right\} . \tag{4.32}
\end{equation*}
$$

If $\widetilde{\Phi}_{\omega}$ were not in $\widetilde{\mathcal{G}}_{t(\omega)}$, then the equality failed in (4.32) and there existed a function $u \in H^{1}\left(\mathbb{R}^{d}\right) \backslash\{0\}$ such that

$$
\begin{align*}
& \widetilde{\mathcal{S}}_{t(\omega)}(u)<\widetilde{\mathcal{S}}_{t(\omega)}\left(\widetilde{\Phi}_{\omega}\right),  \tag{4.33}\\
& \widetilde{\mathcal{N}}_{t(\omega)}(u)=0 . \tag{4.34}
\end{align*}
$$

Then, define $U_{\omega}$ by $U_{\omega}(x):=T_{\lambda(\omega)^{-1}}[u](x)=\lambda(\omega) u\left(\lambda(\omega)^{\frac{2}{d-2}} x\right)$. By (4.25), (4.33), (4.34) and a computation involving the scaling, we see that

$$
\begin{equation*}
\mathcal{S}_{\omega}\left(U_{\omega}\right)<\mathcal{S}_{\omega}\left(\Phi_{\omega}\right), \quad \mathcal{N}_{\omega}\left(U_{\omega}\right)=0 . \tag{4.35}
\end{equation*}
$$

However, (4.35) contradicts that $\Phi$ is a ground state to (1.1). Thus, it must hold that $\widetilde{\Phi}_{\omega} \in \widetilde{\mathcal{G}}_{t(\omega)}$. Similarly, we can verify that $\widetilde{\Psi}_{\omega} \in \widetilde{\mathcal{G}}_{t(\omega)}$. Thus, we have proved (4.30), which completes the proof.

### 4.1 Basic estimates

In this section, we prepare several estimates for the proof of Proposition 4.1. In order to describe them, we use the following symbols:

Notation 4.2. 1. For $d=3,4, p>1$ and $q>1$, define a number $\nu_{q}$ as

\nu_{q}:=\left\{\begin{array}{cl}
\frac{d}{2 q} & \text { if } d=3,4 \text { and } \frac{d}{d-2} \leq p<\frac{d+2}{d-2},  \tag{4.36}\\
1-\frac{(d-2)(p-1)}{4} & \text { if } d=3,4 \text { and } 1<p<\frac{d}{d-2} .
\end{array}\right.
$$

Note that

$$
\begin{equation*}
\frac{(d-2) p-2}{2}>\frac{d-2}{2}-\nu_{q} . \tag{4.37}
\end{equation*}
$$

Furthermore, if $p>\frac{4}{d-2}-1$ and $q>\max \left\{2^{*}, \frac{2^{*}}{p-1}\right\}$, then

$$
\begin{equation*}
\Theta_{q}-\nu_{q}>0, \quad \Theta_{q}+\frac{(d-2)(p-1)}{2}-1>0 . \tag{4.38}
\end{equation*}
$$

2. For $d=3,4, p>\frac{4}{d-2}-1$ and $q>\max \left\{2^{*}, \frac{2^{*}}{p-1}\right\}$, define $\theta_{q}>0$ as

$$
\begin{equation*}
\theta_{q}:=\frac{1}{2} \min \left\{\Theta_{q}-\nu_{q}, \Theta_{q}+\frac{(d-2)(p-1)}{2}-1\right\} . \tag{4.39}
\end{equation*}
$$

Remark 4.3. Assume $d=3,4$ and $p>\frac{4}{d-2}-1$, and let $q>\max \left\{2^{*}, \frac{2^{*}}{p-1}\right\}$. Then, we see from (2.34) that if $t>0$ is sufficiently small depending only on $d$, $p$ and $q$, then

\begin{align*}
t & \leq \alpha(t)^{\Theta_{q}}  \tag{4.40}\\
t^{-1} \alpha(t)^{2 \Theta_{q}} & \leq \alpha(t)^{\Theta_{q}-\nu_{q}} \tag{4.41}
\end{align*}
$$

Lemma 4.1. Assume $d=3,4$. Let $2^{*}<q<\infty$. Then, for any $R>0, s>0$, $0<t_{1} \leq t_{2}<1, \eta_{1} \in Y_{q}\left(R, t_{1}\right)$ and $\eta_{2} \in Y_{q}\left(R, t_{2}\right)$, the following holds:

\begin{equation*}
\left\|(-\Delta+s)^{-1} D\left(\eta_{1}, \eta_{2}\right)\right\|_{L^{q}} \lesssim\left\{R \alpha\left(t_{2}\right)^{\Theta_{q}}+s^{\frac{2^{*}}{q}-1} R^{\frac{4}{d-2}} \alpha\left(t_{2}\right)^{\frac{4}{d-2} \Theta_{q}}\right\}\left\|\eta_{1}-\eta_{2}\right\|_{L^{q}} \tag{4.42}
\end{equation*}
$$

where the implicit constant depends only on $d$ and $q$.
Proof of Lemma 4.1. Note that $\frac{(6-d) d q}{(d-2)(2 q-d)}>\frac{d}{d-2}$. Hence, we see from (2.7) that

W \in L^{\frac{(6-d) d q}{(d-2)(2 q-d)}}\left(\mathbb{R}^{d}\right) \tag{4.43}
\end{equation*}
$$

Furthermore, observe from $0<t_{1} \leq t_{2}$ that

\max _{j=1,2}\left\|\eta_{j}\right\|_{L^{q}} \leq R \alpha\left(t_{2}\right)^{\Theta_{q}} \tag{4.44}
\end{equation*}
$$

Then, by (2.44), (2.41), Lemma 3.5, Lemma 3.4, Hölder's inequality, (4.43) and (4.44), we see that

\begin{align*}
& \left\|(-\Delta+s)^{-1} D\left(\eta_{1}, \eta_{2}\right)\right\|_{L^{q}} \\
& \lesssim\left\|(-\Delta+s)^{-1}\left\{W^{\frac{6-d}{d-2}}\left(\left|\eta_{1}\right|+\left|\eta_{2}\right|\right)+\left(\left|\eta_{1}\right|+\left|\eta_{2}\right|\right)^{\frac{4}{d-2}}\right\}\left|\eta_{1}-\eta_{2}\right|\right\|_{L^{q}} \\
& \lesssim\left\|W^{\frac{6-d}{d-2}}\left(\left|\eta_{1}\right|+\left|\eta_{2}\right|\right)\left|\eta_{1}-\eta_{2}\right|\right\|_{L^{\frac{d q}{d+2 q}}}+s^{\frac{2^{*}}{q}-1}\left\|\left(\left|\eta_{1}\right|+\left|\eta_{2}\right|\right)^{\frac{4}{d-2}}\left|\eta_{1}-\eta_{2}\right|\right\|_{L^{\left(\frac{d-2) q}{d+2}\right.}}^{d+2}  \tag{4.45}\\
& \lesssim\|W\|_{L^{\frac{6-d}{d-2}}}^{\frac{(6-d) d q}{d-2)(2 q-d)}}\left\|\left|\eta_{1}\right|+\left|\eta_{2}\right|\right\|_{L^{q}}\left\|\eta_{1}-\eta_{2}\right\|_{L^{q}}+s^{\frac{2^{*}}{q}-1}\left\|\left|\eta_{1}\right|+\left|\eta_{2}\right|\right\|_{L^{q}}^{\frac{4}{d-2}}\left\|\eta_{1}-\eta_{2}\right\|_{L^{q}} \\
& \lesssim\left\{R \alpha\left(t_{2}\right)^{\Theta_{q}}+s^{\frac{2}{}^{*}-1} R^{\frac{4}{d-2}} \alpha\left(t_{2}\right)^{\frac{4}{d-2}} \Theta_{q}\right\}\left\|\eta_{1}-\eta_{2}\right\|_{L^{q}},
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$. This proves the lemma.
Lemma 4.2. Assume $d=3,4$ and $1<p<\frac{d+2}{d-2}$. Let $2^{*} \leq q<\infty$. Then, for any $R>0$, $s>0,0<t_{1} \leq t_{2}<1, \eta_{1} \in Y_{q}\left(R, t_{1}\right)$ and $\eta_{2} \in Y_{q}\left(R, t_{2}\right)$, the following holds:

$$
\begin{equation*}
\left\|(-\Delta+s)^{-1} E\left(\eta_{1}, \eta_{2}\right)\right\|_{L^{q}} \lesssim\left\{s^{-\nu_{q}}+s^{\frac{d(p-1)}{2 q}-1} R^{p-1} \alpha\left(t_{2}\right)^{(p-1) \Theta_{q}}\right\}\left\|\eta_{1}-\eta_{2}\right\|_{L^{q}} \tag{4.46}
\end{equation*}
$$

where the implicit constant depends only on $d, p$ and $q$.
Proof of Lemma 4.2. First, assume that $1<p<\frac{d}{d-2}$. Let $0<\varepsilon_{0}<\frac{(d-2)(p-1)}{2}$, and define $q_{0}$ as

q_{0}:=\frac{d q}{d+(d-2)(p-1) q-2 q \varepsilon_{0}} \tag{4.47}
\end{equation*}

Observe that $1<q_{0}<q$ and $\frac{d}{d-2}<\frac{(p-1) q_{0} q}{q-q_{0}}$. Furthermore, by (2.7), we see that

W \in L^{\frac{(p-1) q_{0} q}{q-q_{0}}}\left(\mathbb{R}^{d}\right) \tag{4.48}
\end{equation*}
$$

Then, by (2.44), (2.42), Lemma 3.4, Hölder's inequality, (4.48) and $\alpha\left(t_{1}\right) \leq \alpha\left(t_{2}\right)$, we see that

& \left\|(-\Delta+s)^{-1} E\left(\eta_{1}, \eta_{2}\right)\right\|_{L^{q}} \\
& \lesssim s^{\frac{d}{2}\left(\frac{1}{q_{0}}-\frac{1}{q}\right)-1}\left\|W^{p-1}\left|\eta_{1}-\eta_{2}\right|\right\|_{L^{q} q_{0}}+s^{\frac{d(p-1)}{2 q}-1}\left\|\left\{\left|\eta_{1}\right|+\left|\eta_{2}\right|\right\}^{p-1}\left|\eta_{1}-\eta_{2}\right|\right\|_{L^{\frac{q}{p}}} \\
& \lesssim s^{\frac{(d-2)(p-1)}{2}-\varepsilon_{0}-1}\|W\|_{L^{p-1}}^{p-1) q_{q} q}\left\|^{\left(\frac{\left(p-q_{0}\right.}{q}\right.}\right\| \eta_{1}-\eta_{2}\left\|_{L^{q}}+s^{\frac{d(p-1)}{2 q}-1}\right\|\left|\eta_{1}\right|+\left|\eta_{2}\right|\left\|_{L^{q}}^{p-1}\right\| \eta_{1}-\eta_{2} \|_{L^{q}} \\
& \lesssim s^{-1}\left\{s^{\frac{(d-2)(p-1)}{2}-\varepsilon_{0}}+s^{\frac{d(p-1)}{2 q}} R^{p-1} \alpha\left(t_{2}\right)^{(p-1) \Theta_{q}}\right\}\left\|\eta_{1}-\eta_{2}\right\|_{L^{q}}, \tag{4.49}
\end{align*}
$$

where the implicit constants depend only on $d, p, q$ and $\varepsilon_{0}$. Note that we may choose $\varepsilon_{0}=\frac{(d-2)(p-1)}{4}$ in (4.49).

Next, assume that $\frac{d}{d-2} \leq p<\frac{d+2}{d-2}$. Observe from the assumptions about $p$ and $q$ that

& \lesssim s^{-\frac{d}{2 q}}\|W\|_{L^{\frac{p(p-1) d q}{2 q-d}}\left\|\eta_{1}-\eta_{2}\right\|_{L^{q}}+s^{\frac{d(p-1)}{2 q}-1}\left\|\left|\eta_{1}\right|+\left|\eta_{2}\right|\right\|_{L^{q}}^{p-1}\left\|\eta_{1}-\eta_{2}\right\|_{L^{q}}}^{\lesssim s^{-1}\left\{s^{1-\frac{d}{2 q}}+s^{\frac{d(p-1)}{2 q}} R^{p-1} \alpha\left(t_{2}\right)^{(p-1) \Theta_{q}}\right\}\left\|\eta_{1}-\eta_{2}\right\|_{L^{q}},} \tag{4.51}

where the implicit constant depends only on $d, p$ and $q$.

& \lesssim\left|\int_{\mathbb{R}^{d}}\left\{\frac{\delta\left(s_{1}\right)}{\left(|\xi|^{2}+s_{1}\right)|\xi|^{2}}-\frac{\delta\left(s_{2}\right)}{\left(|\xi|^{2}+s_{2}\right)|\xi|^{2}}\right\} g(\xi) d \xi\right| \\
& \lesssim \delta\left(s_{1}\right)\left|\int_{|\xi| \leq 1}\left\{\frac{g(\xi)-g(0)}{\left(|\xi|^{2}+s_{1}\right)|\xi|^{2}}-\frac{g(\xi)-g(0)}{\left(|\xi|^{2}+s_{2}\right)|\xi|^{2}}\right\} d \xi\right|+\left|\delta\left(s_{1}\right)-\delta\left(s_{2}\right)\right||g(0)|  \tag{4.68}\\
& \quad+\left|\delta\left(s_{1}\right)-\delta\left(s_{2}\right)\right|\left|\int_{|\xi| \leq 1} \frac{g(\xi)-g(0)}{\left(|\xi|^{2}+s_{2}\right)|\xi|^{2}} d \xi\right| \\

& \lesssim \delta\left(s_{1}\right)\left|s_{1}-s_{2}\right| \int_{\mathbb{R}^{d}} \int_{|\xi| \leq 1} \frac{\min \left\{|x||\xi|,|x|^{2}|\xi|^{2}\right\}}{\left(|\xi|^{2}+s_{1}\right)\left(|\xi|^{2}+s_{2}\right)|\xi|^{2}}(1+|x|)^{-(d+2)} d \xi d x \\
& \lesssim\left|s_{1}-s_{2}\right| \log \left(1+s_{2}^{-2}\right) .

Next, we consider the second term on the right-hand side of (4.68). We see from (4.66) that

We move on to the third term on the right-hand side of (4.68). We see from (3.44) and (4.67) that

& \quad+\left|\delta\left(s_{1}\right)-\delta\left(s_{2}\right)\right| \int_{1 \leq|\xi|} \frac{|g(\xi)|}{\left(|\xi|^{2}+s_{2}\right)|\xi|^{2}} d \xi  \tag{4.73}\\
& \leq \delta\left(s_{1}\right)\left|s_{1}-s_{2}\right| \int_{1 \leq|\xi|} \frac{1}{|\xi|^{6}} d \xi+\left|\delta\left(s_{1}\right)-\delta\left(s_{2}\right)\right| \int_{1 \leq|\xi|} \frac{1}{|\xi|^{5}} d \xi \\
& \lesssim \delta\left(s_{1}\right)\left|s_{1}-s_{2}\right|+\left|\delta\left(s_{1}\right)-\delta\left(s_{2}\right)\right| .

&+\left|s_{1}-s_{2}\right|\left|\left\langle W^{p},\left(-\Delta+s_{2}\right)^{-1} \Lambda W\right\rangle\right|^{\leq} s_{1}\left|s_{1}-s_{2}\right|\left\|\left(-\Delta+s_{2}\right)^{-1} W^{p}\right\|_{L^{\frac{d}{2}}}\left\|\left(-\Delta+s_{1}\right)^{-1} \Lambda W\right\|_{L^{\frac{d}{d-2}}} \\

& =\left|\tau_{1}-\tau_{2}\right|\left\{t_{1}^{-1}+\delta\left(\alpha\left(t_{1}\right)\right) t_{1}^{-1} \alpha\left(t_{1}\right)^{\frac{d-2}{2}-1}\right\}\left\|\mathfrak{g}_{2}\right\|_{L^{q}} \lesssim\left|\tau_{1}-\tau_{2}\right| t_{1}^{-1}\left\|\mathfrak{g}_{2}\right\|_{L^{q}},
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$.
Move on to the second term on the right-hand side of (4.128). Observe from the definition of $\Pi$ (see (3.72)) that

where the implicit constant depends only on $d$ and $q$. Note that the functions appear in what follows are radial, and recall from Lemma 3.17that $X_{q}=(1-\Pi) L_{\text {rad }}^{q}\left(\mathbb{R}^{d}\right)$. Then, by (3.2) in Proposition 3.1, (4.134), Lemma 3.5, Lemma 3.4, (4.107) and $\delta\left(\alpha\left(t_{1}\right)\right)=t_{1}^{-1} \alpha\left(t_{1}\right)$ (see (2.32)), we see that

& \lesssim \delta\left(\alpha\left(t_{1}\right)\right)\left|\tau_{1}-\tau_{2}\right|\left\|\left(-\Delta+\alpha\left(\tau_{2}\right)\right)^{-1}\left(-\Delta+\alpha\left(\tau_{1}\right)\right)^{-1} V \mathfrak{g}_{2}\right\|_{L^{q}} \\
& \lesssim \delta\left(\alpha\left(t_{1}\right)\right)\left|\tau_{1}-\tau_{2}\right|\left\|\left(-\Delta+\alpha\left(\tau_{1}\right)\right)^{-1} V \mathfrak{g}_{2}\right\|_{L^{\frac{d q}{d+2 q}}}  \tag{4.135}\\
& \lesssim \delta\left(\alpha\left(t_{1}\right)\right)\left|\tau_{1}-\tau_{2}\right| \alpha\left(\tau_{1}\right)^{\frac{d-2}{2}-\frac{d}{2 q}-1}\left\|V \mathfrak{g}_{2}\right\|_{L^{1}} \\
& \lesssim \delta\left(\alpha\left(t_{1}\right)\right)\left|\tau_{1}-\tau_{2}\right| \alpha\left(t_{1}\right)^{\Theta_{q}-1}\left\|\mathfrak{g}_{2}\right\|_{L^{q}}=\left|\tau_{1}-\tau_{2}\right| t_{1}^{-1} \alpha\left(t_{1}\right)^{\Theta_{q}}\left\|\mathfrak{g}_{2}\right\|_{L^{q}}
\end{align*}
$$

where the implicit constants depend only on $d$ and $q$.
Plugging (4.133) and (4.135) into (4.128), and using (4.109) and (4.106), we see that

& \lesssim\left|\tau_{1}-\tau_{2}\right| t_{1}^{-1}\left\|\mathfrak{g}_{2}\right\|_{L^{q}}+\left|\tau_{1}-\tau_{2}\right| t_{1}^{-1} \alpha\left(t_{1}\right)^{\Theta_{q}}\left\|\mathfrak{g}_{2}\right\|_{L^{q}} \lesssim\left|\tau_{1}-\tau_{2}\right| t_{1}^{-1}\left\|\mathfrak{g}_{2}\right\|_{L^{q}} \\
& \lesssim\left\{o_{t_{1}}(1)\left|t_{2}-t_{1}\right|+t_{1} \alpha\left(t_{1}\right)^{-\Theta_{q}+\theta_{q}}\left\|\eta_{2}-\eta_{1}\right\|_{L^{q}}\right\} t_{1}^{-1}\left\|\mathfrak{g}_{2}\right\|_{L^{q}}  \tag{4.136}\\
& \lesssim o_{t_{1}}(1) t_{1}^{-1} \alpha\left(t_{1}\right)^{\Theta_{q}}\left|t_{2}-t_{1}\right|+\alpha\left(t_{1}\right)^{\theta_{q}}\left\|\eta_{2}-\eta_{1}\right\|_{L^{q}}

where the implicit constant depends only on $d, p$ and $q$. Thus, we have proved (4.113) and completed the proof of the lemma.

Now, we are in a position to prove Proposition 4.1:
Proof of Proposition 4.1. First, we claim that if $t>0$ is sufficiently small depending only on $d, p, q$ and $R$, then for any $\eta \in Y_{q}(R, t)$, the interval $I(t)$ admits one and only one element $\tau(t ; \eta)$ such that

By Lemma 4.8 (see also Remark 4.4), we see that if $t$ is sufficiently small depending only on $d, p, q$ and $R$, then for any $\eta \in Y_{q}(R, t)$ and $\tau \in I(t)$, $\mathfrak{s}(t ; \tau, \eta) \in I(t)$. Furthermore, applying Lemma 4.9 as $t_{1}=t_{2}=t$ and $\eta_{1}=\eta_{2}=\eta$ (see also Remark 4.5), we see that if $t$ is sufficiently small depending only on $d, p, q$ and $R$, then for any $\eta \in Y_{q}(R, t)$ and $\tau_{1}, \tau_{2} \in I(t)$,

where the implicit constant depends only on $d, p$ and $q$. Then, the Banach fixed-point theorem shows that the claim is true.

Next, we claim that if $t>0$ is sufficiently small depending only on $d, p, q$ and $R$, then $Y_{q}(R, t)$ admits one and only one element $\eta_{t}$ such that

where $\tau(t ; \eta)$ denotes the unique number in $I(t)$ satisfying (4.137). Indeed, applying Lemma 4.10 (use (4.101) as $t_{j}=t$ and $\tau_{j}=\tau\left(t ; \eta_{j}\right)$ ), we see that the mapping $\eta \in$ $Y_{q}(R, t) \mapsto \mathfrak{g}(t ; \tau(t ; \eta), \eta)$ is contraction in the metric induced from $L^{q}\left(\mathbb{R}^{d}\right)$. Hence, the claim follows from the Banach fixed-point theorem.

By the above claims, we conclude that if $t>0$ is sufficiently small depending only on $d, p, q$ and $R$, then $I(t) \times Y_{q}(R, t)$ admits at least one solution to (4.20). Furthermore, the uniqueness of such a solution follows from Lemma 4.9 and Lemma 4.10 indeed, by these lemmas and (4.40), we see that if $\left(\tau_{t}, \eta_{t}\right)$ and $\left(\widetilde{\tau}_{t}, \widetilde{\eta}_{t}\right)$ are solutions to (4.20) in $I(t) \times Y_{q}(R, t)$, then

& \lesssim o_{t}(1)\left|\tau_{t}-\widetilde{\tau}_{t}\right|+\alpha(t)^{\theta_{q}}\left\|\eta_{t}-\widetilde{\eta}_{t}\right\|_{L^{q}},
\end{align*}
$$

where the implicit constants depend only on $d, p$ and $q$. This estimate implies that if $t>0$ is sufficiently small depending only on $d, p, q$ and $R$, then the uniqueness holds.

Now, for a sufficiently small $t>0$, we use $\left(\tau_{t}, \eta_{t}\right)$ to denote the unique solution to (4.20) in $I(t) \times Y_{q}(R, t)$.

We shall show that $\tau_{t}$ and $\eta_{t}$ are continuous with respect to $t$. Let $t_{0}, t>0$ be sufficiently small numbers with $\frac{1}{2} t \leq t_{0} \leq 2 t$. Then, by Lemma 4.9 (see also Remark 4.5), (4.40) and Lemma 4.10, we see that

& \lesssim o_{t_{0}}(1)\left|\tau_{t}-\tau_{t_{0}}\right|+\left\{1+o_{t_{0}}(1) t_{0}^{-1} \alpha\left(t_{0}\right)^{\Theta_{q}}\right\}\left|t-t_{0}\right|+\alpha\left(t_{0}\right)^{\theta_{q}}\left\|\eta_{t}-\eta_{t_{0}}\right\|_{L^{q}},
\end{align*}
$$

where the implicit constant depends only on $d, p$ and $q$. Note that if $t_{0}$ is sufficiently small, then the first and last terms on the right-hand side of (4.141) can be absorbed into the left-hand side. Thus, (4.141) implies the continuity of $\tau_{t}$ and $\eta_{t}$.

It remains to prove that $\tau_{t}$ is strictly increasing with respect to $t$. Let $0<t_{1}<t_{2}$ be sufficiently small numbers to be specified later, dependently on $d, p, q$ and $R$. By the continuity of $\tau_{t}$ with respect to $t$, we may assume that $t_{1}$ and $t_{2}$ are sufficiently close; In particular, we may assume $t_{2} \leq 2 t_{1}$. Then, by $\tau_{t_{j}}=\mathfrak{s}\left(t_{j} ; \tau_{t_{j}}, \eta_{t_{j}}\right)$, Lemma 4.9 (see also Remark (4.5), (4.40), we see that

\end{align*}

where $C_{0}>0$ is some constant depending only on $d, p$ and $q$. Furthermore, we find from Lemma 4.10 and $\eta_{t_{j}}=\mathfrak{g}\left(t_{j} ; \tau_{t_{j}}, \eta_{t_{j}}\right)$ that

\end{align*}

where the implicit constant depends only on $d, p$ and $q$. This implies that $\tau_{t}$ is strictly increasing with respect to $t$. Thus, we have completed the proof of the proposition.

### 4.3 Proof of Proposition 4.2

In this section, we prove Proposition 4.2.
Recall that $\widetilde{\mathcal{S}}_{t}$ and $\widetilde{\mathcal{N}}_{t}$ denote the action and Nehari functional associated with (4.24), respectively (see (4.22) and (4.23)). Furthermore, recall that $\widetilde{\mathcal{G}_{t}}$ denotes the set of positive radial minimizers for (4.24).

The existence of a minimizer for (4.24) follows from that for (1.1) via the $H^{1}$-scaling (see (4.1)); Precisely, we have:
Lemma 4.11. Assume $d=3,4$ and $\frac{4}{d-2}-1<p<\frac{d+2}{d-2}$. Let $\max \left\{2^{*}, \frac{2^{*}}{p-1}\right\}<q<\infty$ and $R>0$, and let $T_{1}(q, R)$ be the number given in Proposition 4.1] hence for any $0<t<$ $T_{1}(q, R), I(t) \times Y_{q}(R, t)$ admits a unique solution to (4.20), say $\left(\tau_{t}, \eta_{t}\right)$. Furthermore, let $0<t<T_{1}(q, R)$, and define $\lambda(t)$ and $\omega(t)$ by

Then, the following hold:

1. Let $\Phi \in \mathcal{G}_{\omega(t)} ;$ Note that by Proposition [1.1, $\mathcal{G}_{\omega(t)} \neq \emptyset$. Then, $T_{\lambda(t)}[\Phi] \in \widetilde{\mathcal{G}_{t}} ;$ Hence, $\widetilde{\mathcal{G}}_{t} \neq \emptyset$.
2. Let $u \in \widetilde{\mathcal{G}}_{t}$. Then, $T_{\lambda(t)^{-1}}[u] \in \mathcal{G}_{\omega(t)}$, and

Proof of Lemma 4.11. We shall prove the first claim. Observe from a computation involving the scaling that

If the equality failed in (4.148), then we could take a function $u_{0} \in H^{1}\left(\mathbb{R}^{d}\right) \backslash\{0\}$ such that

Furthermore, (4.149) together with computations involving the scaling shows that

& \mathcal{N}_{\omega(t)}\left(T_{\lambda(t)^{-1}}\left[u_{0}\right]\right)=\widetilde{\mathcal{N}}_{t}\left(u_{0}\right)=0 \tag{4.151}
\end{align*}
$$

However, (4.150) together with (4.151) contradicts $\Phi \in \mathcal{G}_{\omega(t)}$. Thus, the equality must hold in (4.148), which together with (4.147) shows that $T_{\lambda(t)}[\Phi] \in \widetilde{\mathcal{G}_{t}}$.

Move on to the second claim. As well as the first claim, we can verify that $T_{\lambda(t)^{-1}}[u] \in$ $\mathcal{G}_{\omega(t)}$. It remains to prove (4.146). Observe from computations involving the scaling that

The following fact follows from the second claim in Lemma 4.11 (cf. Proposition 1.1):
Corollary 4.1. Assume $d=3,4$ and $\frac{4}{d-2}-1<p<\frac{d+2}{d-2}$. Let $\max \left\{2^{*}, \frac{2^{*}}{p-1}\right\}<q<\infty$, $R>0$ and let $T_{1}(q, R)$ be the number given in Proposition 4.1; hence for any $0<t<$ $T_{1}(q, R), I(t) \times Y_{q}(R, t)$ admits a unique solution to (4.20), say $\left(\tau_{t}, \eta_{t}\right)$. Furthermore, let $0<t<T_{1}(q, R)$ and $u_{t} \in \widetilde{\mathcal{G}}_{t}$. Then, $u_{t}$ is a positive radial solution to (4.21). Furthermore, $u_{t} \in C^{2}\left(\mathbb{R}^{d}\right) \cap H^{2}\left(\mathbb{R}^{d}\right)$, and $u_{t}(x)$ is strictly decreasing as a function of $|x|$.

Next, we give properties of ground states to (4.21) (Lemma 4.12 and Lemma 4.13):
Lemma 4.12. Assume $d=3,4$ and $\frac{4}{d-2}-1<p<\frac{d+2}{d-2}$. Let $\max \left\{2^{*}, \frac{2^{*}}{p-1}\right\}<q<\infty, R>$ 0 and let $T_{1}(q, R)$ be the number given in Proposition 4.1; hence for any $0<t<T_{1}(q, R)$, $I(t) \times Y_{q}(R, t)$ admits a unique solution to (4.20), say $\left(\tau_{t}, \eta_{t}\right)$. Then, the following hold:

& \lim _{t \rightarrow 0} \alpha\left(\tau_{t}\right) \frac{-\left\{2^{*}-(p+1)\right\}}{2^{*}-2} t=0,  \tag{4.153}\\
& \lim _{t \rightarrow 0} \sup _{u \in \overline{\mathcal{G}}_{t}} t\|u\|_{L^{p+1}}^{p+1}=\lim _{t \rightarrow 0} \sup _{u \in \overline{\mathcal{G}}_{t}} \alpha\left(\tau_{t}\right)\|u\|_{L^{2}}^{2}=0 . \tag{4.154}
\end{align*}
$$

Proof of Lemma 4.12. By (2.34), the assumption about $p$ and $\tau_{t} \in I(t)$ (hence $\tau_{t} \sim t$ ), we see that (4.153) holds.

We shall prove (4.154). Let $0<t<T_{1}(q, R)$ be a number to be taken $t \rightarrow 0$, and let $u_{t} \in \widetilde{\mathcal{G}_{t}}$. Note that $\widetilde{\mathcal{N}_{t}}\left(u_{t}\right)=0$. Then, by (4.146) in Lemma 4.11, we see that

& =\frac{p-1}{2(p+1)} \alpha\left(\tau_{t}\right)\left\|u_{t}\right\|_{L^{2}}^{2}+\frac{p-1}{2(p+1)}\left\|\nabla u_{t}\right\|_{L^{2}}^{2}+\frac{2^{*}-(p+1)}{2^{*}(p+1)}\left\|u_{t}\right\|_{L^{2^{*}}}^{2^{*}} . \tag{4.155}
\end{align*}

Furthermore, by Hölder's inequality, we see that

& =\alpha\left(\tau_{t}\right)^{\frac{-\left\{2^{*}-(p+1)\right\}}{2^{*}-2}} t\left\{\alpha\left(\tau_{t}\right)\left\|u_{t}\right\|_{L^{2}}^{2}\right\}^{\frac{2^{*}-(p+1)}{2^{*}-2}}\left\|u_{t}\right\|_{L^{2^{*}}}^{\frac{2^{*}(p-1)}{2^{*}-2}} \tag{4.156}
\end{align*}

Then, we find from (4.153), (4.155) and (4.156) that

Furthermore, by (4.196), (4.159) in Lemma 4.13 and $\lim _{t \rightarrow 0} \delta\left(\alpha_{t}(\mu)\right)=0$ (see (4.179)), we see that there exists $T_{2}>0$ depending only on $d$ and $p$ such that for any $0<t<T_{2}, u_{t} \in \widetilde{\mathcal{G}_{t}}$ and $\frac{1}{2}<\mu<\frac{3}{2}$,

which together with the intermediate value theorem implies that for any $0<t<T_{2}$ and $u_{t} \in \widetilde{\mathcal{G}}_{t}$, there exists $\mu(t)>0$ with $|\mu(t)-1| \leq \frac{\min \left\{\mathcal{C}_{0}, 1\right\}}{4\left(1+C_{1}\right)}$ such that

Define $\mu^{\dagger}(t), t^{\dagger}, \alpha^{\dagger}(t)$ and $\eta_{t}^{\dagger}$ as in (4.170) through (4.172). Then, the claims (4.174) and (4.175)) follows from (4.179) and (4.180); We remark that $\lim _{t \rightarrow 0} \sup _{u_{t} \in \widetilde{\mathcal{G}}_{t}} t^{\dagger}=0$ follows from $\lim _{t \rightarrow 0} \sup _{u_{t} \in \widetilde{\mathcal{G}}_{t}} \alpha^{\dagger}(t)=0$ and (4.175).

Proof of Proposition [4.2. We employ the idea from [7] (see the proof of Lemma 3.10 in [7]). For $R>0$, let $T_{1}(q, R)$ denote the number given by Proposition 4.1. Furthermore, for $0<t<T_{1}(q, R)$ and $0<\lambda<\frac{T_{1}(q, R)}{t}$, let $\left(\tau_{\lambda t}, \eta_{\lambda t}\right)$ denote a unique solution to (4.20) with $t=\lambda t$ in $I(\lambda t) \times Y_{q}(R, \lambda t)$ (see Proposition 4.1). Then, for $0<t<T_{1}(q, R)$, we define a function $\Omega_{t}:\left(0, \frac{T_{1}(q, R)}{t}\right) \rightarrow(0, \infty)$ by

Claim. Let $R>0$, and let $0<t<T_{1}(q, R)$; We may choose $T_{1}(q, R)$ even smaller, dependently on $d, p, q$ and $R$, if necessary. Then, $\Omega_{t}(\lambda)$ is injective on $\left(0, \frac{T_{1}(q, R)}{t}\right)$.

To prove this claim, it suffices to show that $\Omega_{t}(\lambda)$ is strictly decreasing with respect to $\lambda$ on $\left(0, \frac{T_{1}(q, R)}{t}\right)$. In addition, by the continuity of $\Omega_{t}(\lambda)$, it suffices to prove the following: There exists $0<\varepsilon<1$ depending only on $d, p$ and $q$ such that if $0<\lambda_{1}<\lambda_{2}<\frac{T_{1}(q, R)}{t}$ and $\lambda_{2}<(1+\varepsilon) \lambda_{1}$, then

Note that for each $j=1,2,\left(\tau_{\lambda_{j} t}, \eta_{\lambda_{j} t}\right)$ is a unique solution to (4.20) with $t=\lambda_{j} t$ in $I\left(\lambda_{j} t\right) \times Y_{q}\left(R, \lambda_{j} t\right)$; in particular, we have

\tau_{\lambda_{j} t}=\mathfrak{s}\left(\lambda_{j} t ; \tau_{\lambda_{j} t}, \eta_{\lambda_{j} t}\right), \quad \eta_{\lambda_{j} t}=\mathfrak{g}\left(\lambda_{j} t ; \tau_{\lambda_{j} t}, \eta_{\lambda_{j} t}\right) . \tag{4.227}
\end{equation*}
$$

Furthermore, observe from $\tau_{\lambda_{j} t} \in I\left(\lambda_{j} t\right)$ and $\lambda_{1} \leq \lambda_{2} \leq 2 \lambda_{1}(0<\varepsilon<1)$ that

where the implicit constants depend only on $d$ and $p$.
We consider the first term on the right-hand side of (4.226). By an elementary computation, we see that

& =-\lambda_{2}^{\frac{-\left(2^{*}-2\right)}{2^{*}-(p+1)}} \frac{2^{*}-2}{2^{*}-(p+1)} \lambda_{1}^{-1}\left(\lambda_{2}-\lambda_{1}\right)+\lambda_{2}^{\frac{-\left(2^{*}-2\right)}{2^{*}-(p+1)}} o\left(\lambda_{1}^{-1}\left|\lambda_{2}-\lambda_{1}\right|\right)
\end{align*}

Furthermore, by $\alpha(t)=\delta(\alpha(t)) t$ (see (2.32) ), (4.227) and Lemma 4.8, we see that

& -\delta\left(\alpha\left(\tau_{\lambda_{1} t}\right)\right) \lambda_{2}^{\frac{-\left(2^{*}-2\right)}{2^{*}-(p+1)}} \frac{2^{*}-2}{2^{*}-(p+1)}\left\{\frac{K_{p}}{A_{1}} \lambda_{1} t+o\left(\lambda_{1} t\right)\right\} \lambda_{1}^{-1}\left(\lambda_{2}-\lambda_{1}\right) \\
& \quad+\delta\left(\alpha\left(\tau_{\lambda_{1} t}\right)\right) \lambda_{2}^{\frac{-\left(2^{*}-2\right)}{2^{*}-(p+1)}}\left\{\frac{K_{p}}{A_{1}} \lambda_{1} t+o\left(\lambda_{1} t\right)\right\} o\left(\lambda_{1}^{-1}\left|\lambda_{2}-\lambda_{1}\right|\right)
\end{align*}
$$

Next, we consider the second term on the right-hand side of (4.226). Since $\tau_{t}$ is strictly increasing with respect to $t$ (see Proposition 4.1), $\tau_{\lambda_{2} t}-\tau_{\lambda_{1} t}=\left|\tau_{\lambda_{2} t}-\tau_{\lambda_{1} t}\right|$. Hence, by $\alpha(t)=\delta(\alpha(t)) t($ see (2.32) $), ~(4.55)$ in Lemma 4.4, we see that

Here, observe from $\tau_{\lambda_{j} t}=\mathfrak{s}\left(\lambda_{j} t ; \tau_{\lambda_{j} t}, \eta_{\lambda_{j} t}\right)$ (see (4.227)) and Lemma 4.9 (see Remark 4.5) that

where the implicit constant depends only on $d$, $p$ and $q$. Observe from $\eta_{\lambda_{j} t}=\mathfrak{g}\left(\lambda_{j} t ; \tau_{\lambda_{j} t}, \eta_{\lambda_{j} t}\right)$ (see (4.227) ), and (4.101) in Lemma 4.10 that

& \quad \times\left\{\frac{K_{p}}{A_{1}}+o_{\lambda_{1} t}(1)\right\}\left(\lambda_{2}-\lambda_{1}\right) t .
\end{align*}

Now, plugging (4.232) and (4.240) into (4.226), and making a simple computation, we see that

&+\delta\left(\alpha\left(\tau_{\lambda_{1} t}\right)\right) \lambda_{2}^{\frac{-\left(2^{*}-2\right)}{*-(p+1)}} o\left(\left|\lambda_{2}-\lambda_{1}\right| t\right)  \tag{4.241}\\
&+\delta\left(\alpha\left(\tau_{\lambda_{1} t}\right)\right) \lambda_{2}^{\frac{-\left(2^{*}-2\right)}{2^{*}-(p+1)}}\left\{\delta\left(\alpha\left(\tau_{\lambda_{2} t}\right)\right)^{d-3}+1\right\} \frac{K_{p}}{A_{1}}\left(\lambda_{2}-\lambda_{1}\right) t \\
&+\delta\left(\alpha\left(\tau_{\lambda_{1} t}\right)\right) \lambda_{2}^{\frac{-\left(2^{*}-2\right)}{*^{-(p+1)}}}\left\{o_{\lambda_{1} t}(1)+O(\varepsilon) \delta\left(\alpha\left(\tau_{\lambda_{2}} t\right)\right)^{d-3}\right\}\left|\lambda_{2}-\lambda_{1}\right| t
\end{align*}

We find from (4.241) that if $t$ and $\varepsilon$ are sufficiently small depending only on $d, p$ and $q$, then $\Omega_{t}\left(\lambda_{2}\right)-\Omega_{t}\left(\lambda_{1}\right)<0$. Thus, we have proved that $\Omega_{t}(\lambda)$ is strictly decreasing with respect to $\lambda$, which implies that $\Omega_{t}$ is injective.

Now, we shall finish the proof of the proposition:
End of the proof. Let $R_{*}$ and $T_{*}$ be the numbers given in Lemma 4.14. Furthermore, let $0<t<T_{*}$, and let $\left(\tau_{t}, \eta_{t}\right)$ be a unique solution to (4.20) in $I(t) \times Y_{q}\left(R_{*}, t\right)$ (see Proposition (4.1). Then, what we need to prove is that if $u_{t} \in \widetilde{\mathcal{G}}_{t}$, then $u_{t}=W+\eta_{t}$.

Let $u_{t} \in \widetilde{\mathcal{G}}_{t}$. Then, Lemma 4.14 shows that there exists $\mu(t)=1+o_{t}(1)$ such that, defining $t^{\dagger}, \alpha^{\dagger}(t)$ and $\eta_{t}^{\dagger}$ as

& \lim _{t \rightarrow 0} \alpha^{\dagger}(t)=0, \quad \lim _{t \rightarrow 0} t^{\dagger}=0  \tag{4.244}\\
& \left(\tau_{t^{\dagger}}, \eta_{t^{\dagger}}\right)=\left(\beta\left(\alpha^{\dagger}(t)\right), \eta_{t}^{\dagger}\right) \in I\left(t^{\dagger}\right) \times Y_{q}\left(R_{*}, t^{\dagger}\right) \tag{4.245}
\end{align*}
$$

where $\left(\tau_{t^{\dagger}}, \eta_{t^{\dagger}}\right)$ denotes a unique solution to (4.20) with $t=t^{\dagger}$ in $I\left(t^{\dagger}\right) \times Y_{q}\left(R_{*}, t^{\dagger}\right)$. Since $\alpha$ is the inverse function of $\beta$, (4.245) shows that

Furthermore, by $t^{\dagger}=t, \mu(t) u_{t}(0)=1$, (4.243) and (4.245), we see that $\eta_{t}=\eta_{t^{\dagger}}=u_{t}-W$. Thus, we have completed the proof.

## A Compactness in Lebesgue spaces

We record a compactness theorem in Lebesgue spaces (see Proposition A. 1 of [15):
Lemma A.1. Assume $d \geq 1$, and let $1 \leq q \leq \infty$. A sequence $\left\{f_{n}\right\}$ in $L^{q}\left(\mathbb{R}^{d}\right)$ has a convergent subsequence if and only if it satisfies the following properties:

\end{equation*}

3.

\begin{equation*}
\lim _{R \rightarrow \infty} \sup _{n \geq 1}\left\|f_{n}\right\|_{L^{q}(|x| \geq R)}=0 \tag{A.3}
\end{equation*}
$$

Remark A.1. Although Proposition A. 1 of [15] does not refer to the case $q=\infty$, we may include this case in the statement. Note that when $q=\infty$, (A.2) implies that the sequence $\left\{f_{n}\right\}$ is continuous; hence the limit along the subsequence is also continuous.

## B Completeness of $\boldsymbol{Y}_{\boldsymbol{q}}(\boldsymbol{R}, \boldsymbol{t})$

Let $\frac{d}{d-2}<q<\infty, R>0,0<t<1$, and let $Y_{q}(R, t)$ be a set defined by (4.15). Then, we shall show that $Y_{q}(R, t)$ is complete with the metric induced from $L^{q}\left(\mathbb{R}^{d}\right)$.

Let $\left\{\eta_{n}\right\}$ be a Cauchy sequence in $Y_{q}(R, t)$. Since $L_{\text {rad }}^{q}\left(\mathbb{R}^{d}\right)$ is complete, there exists a radial function $\eta_{\infty} \in L^{q}\left(\mathbb{R}^{d}\right)$ such that

Furthermore, we see that

\left\|\eta_{\infty}\right\|_{L^{q}}=\lim _{n \rightarrow \infty}\left\|\eta_{n}\right\|_{L^{q}} \leq R \alpha(t)^{\frac{d-2}{2}-\frac{d}{2 q}}, \tag{B.2}
\end{equation*}
$$

so that $\eta_{\infty} \in Y_{q}(R, t)$. Thus, we have proved the completeness.

## C Elementary computations

Lemma C.1. Define a function $\beta$ on $(0, \infty)$ by $\beta(s):=s \log \left(1+s^{-1}\right)$. Then, $\beta$ is strictly increasing on $(0, \infty)$, and the image of $(0, \infty)$ by $\beta$ is $(0,1)$; hence the inverse is defined on $(0,1)$, say $\alpha:(0,1) \rightarrow(0, \infty)$. Furthermore, there exists $0<T_{0}<1$ such that if $0<t \leq T_{0}$, then

This formula shows that $\beta$ is strictly increasing on $(0, \infty), \lim _{s \rightarrow 0} \beta(s)=0$, and $\lim _{s \rightarrow \infty} \beta(s)=$ 1. In particular, the image of $(0, \infty)$ by $\beta$ is $(0,1)$.

Next, let $\alpha:(0,1) \rightarrow(0, \infty)$ be the inverse of $\beta$. Note that $\alpha$ is strictly increasing, continuous, and $\lim _{t \rightarrow 0} \alpha(t)=0$. Hence, there exists $0<T_{0}<1$ such that $\alpha(t) \leq e^{-1}$ for all $0<t \leq T_{0}$. Let $0<t \leq T_{0}$, and put $s:=\alpha(t)$. Note that $0<s \leq e^{-1}$ and $\beta(s)=t$. Then, observe from $\beta(s):=s \log \left(1+s^{-1}\right)$ that $s \leq t \leq s^{\frac{1}{2}}$, which implies that

& \quad+\int_{1}^{\infty} \int_{0}^{\frac{1}{r}} \frac{r^{d+1} \lambda^{d-1}}{(1+r)^{d+2}\left(\lambda^{2}+s_{1}\right)\left(\lambda^{2}+s_{2}\right)} d \lambda d r  \tag{C.6}\\
& \quad+\int_{1}^{\infty} \int_{\frac{1}{r}}^{1} \frac{r^{d} \lambda^{d-2}}{(1+r)^{d+2}\left(\lambda^{2}+s_{1}\right)\left(\lambda^{2}+s_{2}\right)} d \lambda d r
\end{align*}
$$

where the implicit constant depends only on $d$. Consider the first term on the right-hand side of (C.6). By an elementary computation, and (2.29) (only for $d=3$ ), we see that

where the implicit constant depends only on $d$. Next, consider the second term on the right-hand side of (C.6). By integration by substitution $\left(\lambda=\sqrt{s_{2}} \mu\right)$, elementary computations, and (2.29) (only for $d=3$ ), we see that

& \int_{1}^{\infty} \int_{0}^{\frac{1}{r}} \frac{r^{d+1} \lambda^{d-1}}{(1+r)^{d+2}\left(\lambda^{2}+s_{1}\right)\left(\lambda^{2}+s_{2}\right)} d \lambda d r \\
& \leq \int_{1}^{\infty} \int_{0}^{\frac{1}{\sqrt{s_{2} r}}} \frac{s_{2}^{\frac{d-4}{2}} \mu^{d-1}}{r\left(\mu^{2}+\frac{s_{1}}{s_{2}}\right)\left(\mu^{2}+1\right)} d \mu d r \\
& =\int_{1}^{\frac{1}{\sqrt{s_{2}}}} \int_{0}^{1} \frac{s_{2}^{\frac{d-4}{2}} \mu^{d-1}}{r\left(\mu^{2}+\frac{s_{1}}{s_{2}}\right)\left(\mu^{2}+1\right)} d \mu d r+\int_{1}^{\frac{1}{\sqrt{s_{2}}}} \int_{1}^{\frac{1}{\sqrt{s_{2} r}}} \frac{s_{2}^{\frac{d-4}{2}} \mu^{d-1}}{r\left(\mu^{2}+\frac{s_{1}}{s_{2}}\right)\left(\mu^{2}+1\right)} d \mu d r  \tag{C.8}\\
& \quad+\int_{\frac{1}{\sqrt{s_{2}}}}^{\infty} \int_{0}^{\frac{1}{\sqrt{s_{2} r}}} \frac{s_{2}^{\frac{d-4}{2}} \mu^{d-1}}{r\left(\mu^{2}+\frac{s_{1}}{s_{2}}\right)\left(\mu^{2}+1\right)} d \mu d r \\
& \left.\leq \int_{1}^{\frac{1}{\sqrt{s_{2}}}} \frac{s_{2}^{\frac{d-4}{2}}}{r} d r+\int_{1}^{\frac{1}{\sqrt{s_{2}}}} \int_{1}^{\frac{1}{\sqrt{s_{2}}}} \frac{\frac{d-4}{2}}{s_{2}} \mu^{d-3} \mu^{2}+1\right) \\
& \\
& \lesssim \delta\left(s_{2}\right)^{-1} \log \left(1+s_{2}^{-1}\right),
\end{align*}
$$

where the implicit constant depends only on $d$. Finally, we consider the last term on the right-hand side of (C.6). By change of the order of integrals, and (2.29) (only for $d=3$ ), we see that

\begin{align*}
& \int_{1}^{\infty} \int_{\frac{1}{r}}^{1} \frac{r^{d} \lambda^{d-2}}{(1+r)^{d+2}\left(\lambda^{2}+s_{1}\right)\left(\lambda^{2}+s_{2}\right)} d \lambda d r \\
& \leq \int_{1}^{\infty} \int_{\frac{1}{r}}^{1} \frac{\lambda^{d-2}}{r^{2}\left(\lambda^{2}+s_{1}\right)\left(\lambda^{2}+s_{2}\right)} d \lambda d r=\int_{0}^{1} \frac{\lambda^{d-2}}{\left(\lambda^{2}+s_{1}\right)\left(\lambda^{2}+s_{2}\right)} \int_{\frac{1}{\lambda}}^{\infty} \frac{1}{r^{2}} d r d \lambda  \tag{C.9}\\
& =\int_{0}^{1} \frac{\lambda^{d-1}}{\left(\lambda^{2}+s_{1}\right)\left(\lambda^{2}+s_{2}\right)} d \lambda \leq \int_{0}^{1} \frac{\lambda^{d-3}}{\lambda^{2}+s_{2}} d \lambda \lesssim \delta\left(s_{2}\right)^{-1}
\end{align*}
$$

where the implicit constant depends only on $d$.
Putting (C.6) through (C.9) together, we find that (C.5) holds.
The following lemma is quoted from [14]:
Lemma C. 3 (Lemma 3.12 of [14]). Let $\mathcal{X}, \mathcal{y}, \mathbf{X}, \mathbf{Y}$ be vector spaces. Let $\mathcal{A}: \mathcal{X} \rightarrow \mathcal{y}$, $B: \mathbf{X} \rightarrow X, C: \mathcal{y} \rightarrow \mathbf{Y}$ be linear operators. Define $\mathbf{A}:=C \mathcal{A} B$. If $\mathbf{A}^{-1}$ exists, then $\mathcal{A}^{-1}=B \mathbf{A}^{-1} C$ provided $B$ is surjective and $C$ is injective.
