# On the local well-posedness of the two component $b$-family of equations

#### Abstract

In this paper we consider the two component $b$-family of equations on $\mathbb{R}$. We write the equations on a Sobolev type diffeomorphism group. As an application of this formulation we show that the dependence on the initial data is nowhere locally uniformly continuous. In particular it is nowhere locally Lipschitz and nowhere locally Hölder continuous.


## 1 Introduction

The initial value problem for the two component $b$-family of equations on $\mathbb{R}$ is given by

$$
\begin{align*}
& u_{t}-u_{t x x}+(b+1) u u_{x}=b u_{x} u_{x x}+u u_{x x x}+\rho \rho_{x}, \quad t>0, x \in \mathbb{R} \\
& \rho_{t}+(\rho u)_{x}=0, \quad t>0, x \in \mathbb{R}  \tag{1}\\
& u(t=0)=u_{0}, \rho(t=0)=\rho_{0}
\end{align*}
$$

which is a generalization of the $b$-family of equations - see [3] for the $b$-family of equations corresponding to (11) in the case $\rho \equiv 0$. For $b=2$ we get the two component Camassa-Holm equation and for $b=3$ the two component Degasperis-Procesi equation.
Using Kato's semigroup theory it was shown in [4] that (1) is locally wellposed in $(u, \rho) \in H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}), s \geq 2$. Later this was improved to $(u, \rho) \in H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}), s>3 / 2$, in [4], where local well posedness in a range of Besov spaces was established. As a by-product of our diffeomorphism group formulation we will get the same local well-posedness result in Sobolev spaces as in [4], i.e.

Theorem 1.1. Let $s>3 / 2$. For every $\left(u_{0}, \rho_{0}\right) \in H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})$ there is a $T>0$ s.t. there is a unique pair

$$
(u, \rho) \in C\left([0, T] ; H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})\right) \cap C^{1}\left([0, T] ; H^{s-1}(\mathbb{R}) \times H^{s-2}(\mathbb{R})\right)
$$

satisfying (1). For $T>0$ we denote by $U_{T} \subset H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})$ the set of initial values $\left(u_{0}, \rho_{0}\right)$ for which the solution to (1) exists longer than time $T$. Then the time $T$ solution map

$$
\Phi_{T}: U_{T} \rightarrow H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}), \quad\left(u_{0}, \rho_{0}\right) \mapsto(u(T), \rho(T))
$$

is continuous. Here $(u(T), \rho(T))$ is the time $T$ value of the solution $(u, \rho)$ corresponding to the initial value $\left(u_{0}, \rho_{0}\right)$.

A natural question is how regular the solution map $\Phi_{T}$ is, e.g. whether $\Phi_{T}$ is $C^{1}$ or at least locally Lipschitz. In 5 it was shown that there is a bounded set in $H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}), s>5 / 2$, on which $\Phi_{T}$ is not uniformly continuous. We will improve this both w.r.t $s$ and w.r.t. to the non uniformity. Our main result reads as

Theorem 1.2. Let $s>3 / 2$ and $T>0$. Then

$$
\begin{aligned}
& \Phi_{T}: U_{T} \subset H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}) \rightarrow H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}) \\
& \left(u_{0}, \rho_{0}\right) \mapsto \Phi_{T}\left(\left(u_{0}, \rho_{0}\right)\right)=(u(T), \rho(T))
\end{aligned}
$$

is nowhere locally uniformly continuous.
Theorem 1.2 tells us that $\Phi_{T}$ fails to be uniformly continuous on any ball $B \subset U_{T}$ regardless of how small the ball is. In particular $\Phi_{T}$ is nowhere locally Lipschitz, nowhere locally Hölder continuous and hence nowhere $C^{1}$.

Our strategy to prove Theorem 1.2 is similar to the procedure in [3] and consists of two steps. In a first step we will write (1) in Lagrangian coordinates as an equation on a diffeomorphism group, i.e. we consider the flow $\operatorname{map} \varphi$ of $u$

$$
\varphi_{t}(t, x)=u(t, \varphi(t, x)), \quad \varphi(0, x)=x
$$

and write (1) in terms of $\varphi$. The second equation in (1) reads as

$$
\frac{d}{d t}\left(\varphi_{x} \cdot \rho \circ \varphi\right)=0
$$

or

$$
\rho(t)=\left(\frac{\rho_{0}}{\varphi_{x}}\right) \circ \varphi(t)^{-1} .
$$

In the second step we will use this composite expression for a "moving hump" argument to produce non uniformity.

## 2 Lagrangian formulation

The goal of this section is to write the equations (1) in terms of the flow map of $u$, i.e. in terms of $\varphi$ given by

$$
\varphi_{t}(t)=u(t) \circ \varphi(t), t \geq 0, \quad \varphi(0)=\mathrm{id} .
$$

Here id : $\mathbb{R} \rightarrow \mathbb{R}, x \mapsto x$, is the identity map. We introduced in [1] the diffeomorphism group $\mathcal{D}^{s}$ based on Sobolev spaces. This space will be the configuration space for $\varphi$. More precisely for $s>3 / 2$ we define

$$
\mathcal{D}^{s}(\mathbb{R}):=\left\{\varphi: \mathbb{R} \rightarrow \mathbb{R} \mid \varphi-\mathrm{id} \in H^{s}(\mathbb{R}), \operatorname{det}\left(d_{x} \varphi\right)>0 \forall x \in \mathbb{R}\right\} .
$$

Here $H^{s}(\mathbb{R})$ is the Sobolev space of order $s$, i.e.

$$
H^{s}(\mathbb{R}):=\left\{f \in L^{2}(\mathbb{R}) \mid\|f\|_{H^{s}}:=\left(\int_{\mathbb{R}}\left(1+|\xi|^{2}\right)^{s}|\hat{f}(\xi)|^{2} d \xi\right)^{1 / 2}<\infty\right\}
$$

where $\hat{f}$ is the Fourier transform of $f$. By the Sobolev Imbedding Theorem the function space $\mathcal{D}^{s}(\mathbb{R}), s>3 / 2$, consists of $C^{1}$ diffeomorphisms. By the imbedding

$$
\mathcal{D}^{s}(\mathbb{R}) \rightarrow H^{s}(\mathbb{R}), \quad \varphi \mapsto \varphi-\mathrm{id}
$$

we can identify $\mathcal{D}^{s}(\mathbb{R})$ with an open subset of $H^{s}(\mathbb{R})$, thus we get a differential structure on $\mathcal{D}^{s}(\mathbb{R})$. In [1] it was shown that the space $\mathcal{D}^{s}(\mathbb{R}), s>3 / 2$, is a topological group under composition. That $\mathcal{D}^{s}(\mathbb{R})$ is the right space follows from a result in [2], that says that for every $u \in C\left([0, T] ; H^{s}(\mathbb{R})\right), T>0$, there is a unique $\varphi \in C^{1}\left([0, T] ; \mathcal{D}^{s}(\mathbb{R})\right)$ satisfying

$$
\varphi_{t}(t)=u(t) \circ \varphi(t), t \in[0, T], \quad \varphi(0)=\mathrm{id} .
$$

To get a Lagrangian formulation of (1) we write the first equation in (1) in non local form

$$
\begin{equation*}
u_{t}+u u_{x}=\left(1-\partial_{x}^{2}\right)^{-1}\left(-b u u_{x}+(b-3) u_{x} u_{x x}+\rho \rho_{x}\right) \tag{2}
\end{equation*}
$$

Now let $\varphi$ be the flow map of $u$. By differentiating $\varphi_{t}=u \circ \varphi$ w.r.t. $t$ we get

$$
\varphi_{t t}=\left(u_{t}+u u_{x}\right) \circ \varphi .
$$

Using (2) we get

$$
\varphi_{t t}=\left(\left(1-\partial_{x}^{2}\right)^{-1}\left(-b u u_{x}+(b-3) u_{x} u_{x x}+\rho \rho_{x}\right)\right) \circ \varphi .
$$

As noted in the introduction we have

$$
\rho=\left(\frac{\rho_{0}}{\varphi_{x}}\right) \circ \varphi^{-1} .
$$

If we use this expression for $\rho$ and $u=\varphi_{t} \circ \varphi^{-1}$ we get

$$
\begin{aligned}
\varphi_{t t} & =\left(( 1 - \partial _ { x } ^ { 2 } ) ^ { - 1 } \left(-b \varphi_{t} \circ \varphi^{-1} \cdot \partial_{x}\left(\varphi_{t} \circ \varphi^{-1}\right)+(b-3) \partial_{x}\left(\varphi_{t} \circ \varphi^{-1}\right) \partial_{x}^{2}\left(\varphi_{t} \circ \varphi^{-1}\right)\right.\right. \\
& \left.\left.+\left(\frac{\rho_{0}}{\varphi_{x}}\right) \circ \varphi^{-1} \cdot \partial_{x}\left(\left(\frac{\rho_{0}}{\varphi_{x}}\right) \circ \varphi^{-1}\right)\right)\right) \circ \varphi=: F\left(\varphi, \varphi_{t}, \rho_{0}\right) .
\end{aligned}
$$

We've proved in [3] that the expressions appearing in $F\left(\varphi, \varphi_{t}, \rho_{0}\right)$ are analytic in $\left(\varphi, \varphi_{t}, \rho_{0}\right)$. More precisely

$$
\begin{aligned}
\mathcal{D}^{s}(\mathbb{R}) \times H^{s}(\mathbb{R}) & \rightarrow H^{s}(\mathbb{R}), \\
\left(\varphi, \varphi_{t}\right) & \mapsto\left(\left(1-\partial_{x}^{2}\right)^{-1}\left(\varphi_{t} \circ \varphi^{-1} \cdot \partial_{x}\left(\varphi_{t} \circ \varphi^{-1}\right)\right)\right) \circ \varphi,
\end{aligned}
$$

and

$$
\begin{aligned}
\mathcal{D}^{s}(\mathbb{R}) \times H^{s}(\mathbb{R}) & \rightarrow H^{s}(\mathbb{R}), \\
\left(\varphi, \varphi_{t}\right) & \mapsto\left(\left(1-\partial_{x}^{2}\right)^{-1}\left(\partial_{x}\left(\varphi_{t} \circ \varphi^{-1}\right) \partial_{x}^{2}\left(\varphi_{t} \circ \varphi^{-1}\right)\right)\right) \circ \varphi,
\end{aligned}
$$

and

$$
\begin{aligned}
\mathcal{D}^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}) & \rightarrow H^{s}(\mathbb{R}), \\
\left(\varphi, \rho_{0}\right) & \mapsto\left(\left(1-\partial_{x}^{2}\right)^{-1}\left(\left(\frac{\rho_{0}}{\varphi_{x}}\right) \circ \varphi^{-1} \cdot \partial_{x}\left(\left(\frac{\rho_{0}}{\varphi_{x}}\right) \circ \varphi^{-1}\right)\right)\right) \circ \varphi
\end{aligned}
$$

are analytic maps. Consult [3] for detailed computations. Let us just point out here that the mechanism underlying analyticity is that conjugation with $\varphi^{-1}$ in combination with $\partial_{x}$

$$
\partial_{x}\left(w \circ \varphi^{-1}\right) \circ \varphi=\frac{w_{x}}{\varphi_{x}}
$$

gives an expression involving only derivatives and multiplication. So we get

Proposition 2.1. Let $s>3 / 2$. Then the map

$$
\mathcal{D}^{s}(\mathbb{R}) \times H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}) \rightarrow H^{s}(\mathbb{R}), \quad\left(\varphi, \varphi_{t}, \rho_{0}\right) \mapsto F\left(\varphi, \varphi_{t}, \rho_{0}\right)
$$

is analytic.
By applying the Picard-Lindelöf Theorem we get local in time existence for solutions of (11).

Lemma 2.2. Let $s>3 / 2$. Then for every initial value $\left(u_{0}, \rho_{0}\right) \in H^{s}(\mathbb{R}) \times$ $H^{s-1}(\mathbb{R})$ there is $T>0$ and

$$
(u, \rho) \in C\left([0, T] ; H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})\right) \cap C^{1}\left([0, T] ; H^{s-1}(\mathbb{R}) \times H^{s-2}(\mathbb{R})\right)
$$

satisfying

$$
\begin{align*}
& u_{t}+u u_{x}=\left(1-\partial_{x}^{2}\right)^{-1}\left(-b u u_{x}+(b-3) u_{x} u_{x x}+\rho \rho_{x}\right), \\
& \rho_{t}+(\rho u)_{x}=0,  \tag{3}\\
& u(0)=u_{0}, \rho(0)=\rho_{0}
\end{align*}
$$

on $[0, T]$.
Proof. Consider the analytic second order ODE on $\mathcal{D}^{s}(\mathbb{R})$

$$
\begin{equation*}
\varphi_{t t}=F\left(\varphi, \varphi_{t}, \rho_{0}\right), \varphi(0)=\mathrm{id}, \varphi_{t}(0)=u_{0} \tag{4}
\end{equation*}
$$

By Picard-Lindelöf there is $T>0$ and a solution $\varphi \in \mathcal{D}^{s}(\mathbb{R})$ to (4) on $[0, T]$. For $t \in[0, T]$ we define

$$
u(t):=\varphi_{t}(t) \circ \varphi(t)^{-1}, \quad \rho(t):=\left(\frac{\rho_{0}}{\varphi_{x}(t)}\right) \circ \varphi(t)^{-1} .
$$

From the regularity properties of composition established in [1] we know

$$
(u, \rho) \in C\left([0, T] ; H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})\right) \cap C^{1}\left([0, T] ; H^{s-1}(\mathbb{R}) \times H^{s-2}(\mathbb{R})\right)
$$

and from the derivation above we see that $(u, \rho)$ solves (3).
By the Picard-Lindelöf Theorem we also get uniqueness.
Lemma 2.3. Let $s>3 / 2$ and $T>0$. Suppose that $(u, \rho),(\tilde{u}, \tilde{\rho}) \in C\left([0, T] ; H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})\right) \cap C^{1}\left([0, T] ; H^{s-1}(\mathbb{R}) \times H^{s-2}(\mathbb{R})\right)$ are two solutions to (3). Then $(u, \rho)=(\tilde{u}, \tilde{\rho})$ on $[0, T]$.

Proof. We know by [2] that there is a unique $\varphi \in C^{1}\left([0, T] ; \mathcal{D}^{s}(\mathbb{R})\right)$ s.t.

$$
\varphi_{t}(t)=u(t) \circ \varphi(t), t \in[0, T], \quad \varphi(0)=\mathrm{id} .
$$

Taking the derivative in $\varphi_{t}=u \circ \varphi$ w.r.t. $t$ we get pointwise the identity

$$
\varphi_{t t}=\left(u_{t}+u u_{x}\right) \circ \varphi .
$$

By using (3) we get pointwise

$$
\varphi_{t t}=\left(1-\partial_{x}^{2}\right)^{-1}\left(-b u u_{x}+(b-3) u_{x} u_{x x}+\rho \rho_{x}\right) \circ \varphi .
$$

The right hand side is in $C\left([0, T] ; H^{s}(\mathbb{R})\right)$. This means that $\varphi \in C^{2}\left([0, T] ; \mathcal{D}^{s}(\mathbb{R})\right)$ and it solves (4). The solution $(\tilde{u}, \tilde{\rho})$ generates in a similar fashion a $\tilde{\varphi} \in$ $C^{2}\left([0, T] ; \mathcal{D}^{s}(\mathbb{R})\right)$ solving (4). By Picard-Lindelöf we get $\varphi=\tilde{\varphi}$ on $[0, T]$. Therefore we have $u=\tilde{u}$ on $[0, T]$. This proves uniqueness.

Combining Lemma 2.2 and 2.3 we can prove Theorem 1.1.
Proof of Theorem [1.1. By solving (4) as in Lemma 2.2 we get for $T>0$ an open set $U_{T} \subset H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})$ as in the statement of the theorem. The solution map is given by

$$
\begin{aligned}
\Phi_{T}: U_{T} & \rightarrow H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}) \\
\left(u_{0}, \rho_{0}\right) & \mapsto\left(\varphi_{t}(T) \circ \varphi(T)^{-1},\left(\frac{\rho_{0}}{\varphi_{x}(T)}\right) \circ \varphi(T)^{-1}\right)
\end{aligned}
$$

where $\varphi=\varphi\left(\cdot ; u_{0}, \rho_{0}\right) \in C^{2}\left([0, T] ; \mathcal{D}^{s}(\mathbb{R})\right)$ is the solution of (4). We get from the regularity of the composition that this is continuous. Together with the uniqueness of Lemma 2.3 this finishes the proof.

## 3 Nonuniform dependence

In this section we will prove Theorem 1.2. Throughout this section we assume $s>3 / 2$. Note that (11) admits the scale invariance

$$
u_{\lambda}(t, x):=\lambda u(\lambda t, x), \quad \rho_{\lambda}(t, x):=\lambda \rho(\lambda t, x), \quad \lambda>0,
$$

in the sense that $\left(u_{\lambda}, \rho_{\lambda}\right)$ is a solution to (1) whenever $(u, \rho)$ is. This scaling shows that $U_{T} \subset H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})$ is star shaped w.r.t. $(0,0) \in H^{s}(\mathbb{R}) \times$
$H^{s-1}(\mathbb{R})$. Let us denote $U=\left.U_{T}\right|_{T=1}$ and $\Phi=\left.\Phi_{T}\right|_{T=1}$. The scaling $\left(u_{\lambda}, \rho_{\lambda}\right)$ implies for $T>0$ and $\left(u_{0}, \rho_{0}\right) \in U_{T}$ that $\left(T u_{0}, T \rho_{0}\right) \in U$ and for the solution map that

$$
\begin{equation*}
\Phi_{T}\left(\left(u_{0}, \rho_{0}\right)\right)=(u(T), \rho(T))=\left(\frac{1}{T} u_{T}(1), \frac{1}{T} \rho_{T}(1)\right)=\frac{1}{T} \Phi\left(T u_{0}, T \rho_{0}\right) \tag{5}
\end{equation*}
$$

for $\left(u_{0}, \rho_{0}\right) \in U_{T}$. Using (5) Theorem (1.2) will follow from
Proposition 3.1. The map

$$
\Phi: U \subset H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}) \rightarrow H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})
$$

is nowhere uniformly continuous.
Let us also introduce the time $T=1$ solution map in Lagrangian coordinates, i.e.

$$
\Psi: U \subset H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}) \rightarrow \mathcal{D}^{s}(\mathbb{R}),\left(u_{0}, \rho_{0}\right) \mapsto \varphi\left(1 ; u_{0}, \rho_{0}\right)
$$

where $\varphi\left(1 ; u_{0}, \rho_{0}\right)$ is the time $T=1$ value of the solution to (4) with initial values $\left(u_{0}, \rho_{0}\right)$. We know by analytic dependence on the initial data that $\Psi$ is an analytic map. Moreover a simple computation shows that

$$
\begin{equation*}
\varphi\left(t ; u_{0}, \rho_{0}\right)=\Psi\left(t\left(u_{0}, \rho_{0}\right)\right) \tag{6}
\end{equation*}
$$

Before we prove Proposition 3.1 we need the following technical lemma about the map $\Psi$

Lemma 3.2. There is a dense subset $S \subset U$ consisting of smooth compactly supported $\left(u_{\bullet}, \rho_{\bullet}\right)$ s.t. for every $\left(u_{\bullet}, \rho_{\bullet}\right) \in S$ there is $w_{\bullet}=\left(w_{1}, 0\right) \in H^{s}(\mathbb{R}) \times$ $H^{s-1}(\mathbb{R})$ and $a_{\bullet} \in \mathbb{R}$ with $\operatorname{dist}\left(a_{\bullet}, \operatorname{supp} \rho_{\bullet}\right) \geq 2$ satisfying

$$
\left(d_{\left(u_{\bullet}, \rho_{\bullet}\right)} \Psi\left(w_{\bullet}\right)\right)\left(a_{\bullet}\right) \neq 0
$$

Here $\operatorname{supp} \rho_{\bullet} \subset \mathbb{R}$ is the support of $\rho_{\bullet}, \operatorname{dist}\left(a_{\bullet}, \operatorname{supp} \rho_{\bullet}\right)$ is the distance of $a_{\bullet}$ to the support of $\rho_{\bullet}$ and $d_{\left(u_{\bullet}, \rho_{\bullet}\right)} \Psi$ is the differential of $\Psi$ at $\left(u_{\bullet}, \rho_{\bullet}\right)$, i.e

$$
\begin{aligned}
& d_{\left(u_{\bullet}, \rho_{\bullet}\right)} \Psi: H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}) \rightarrow H^{s}(\mathbb{R}), \\
& v=\left(v_{1}, v_{2}\right) \mapsto d_{\left(u_{0}, \rho_{0}\right)} \Psi(v)=\lim _{t \rightarrow 0} \frac{\Psi\left(u_{\bullet}+t v_{1}, \rho_{\bullet}+t v_{2}\right)-\Psi\left(u_{\bullet}, \rho_{\bullet}\right)}{t}
\end{aligned}
$$

Proof. For $v=\left(v_{1}, v_{2}\right) \in H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})$ we get from (6)

$$
d_{(0,0)} \Psi(v)=\left.\frac{d}{d t}\right|_{t=0} \Psi(t v)=\left.\frac{d}{d t}\right|_{t=0} \varphi\left(t ; v_{1}, v_{2}\right)=v_{1}
$$

We know that $C_{c}^{\infty}(\mathbb{R}) \times C_{c}^{\infty}(\mathbb{R})$ is dense in $U$. Let $\left(u_{\bullet}, \rho_{\bullet}\right) \in C_{c}^{\infty}(\mathbb{R}) \times C_{c}^{\infty}(\mathbb{R})$ be arbitrary. We take $a_{\bullet} \in \mathbb{R}$ with $\operatorname{dist}\left(a_{\bullet}, \operatorname{supp} \rho_{\bullet}\right) \geq 2$ and choose $w_{\bullet}=$ $\left(w_{1}, 0\right) \in H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R})$ s.t. $w_{1}\left(a_{\bullet}\right) \neq 0$. Now consider the analytic function

$$
[0,1] \rightarrow \mathbb{R}, \quad t \mapsto\left(d_{t\left(u_{\bullet}, \rho_{\bullet}\right)} \Psi\left(w_{\bullet}\right)\right)\left(a_{\bullet}\right)
$$

which for $t=0$ is equal to $w_{1}\left(a_{\bullet}\right) \neq 0$. Since the function is analytic this means that there is a sequence $t_{n} \uparrow 1$ s.t.

$$
\left(d_{t_{n}\left(u_{\bullet}, \rho_{\bullet}\right)} \Psi\left(w_{\bullet}\right)\right)\left(a_{\bullet}\right) \neq 0, \quad n \geq 1
$$

So we can put $\left\{t_{n}\left(u_{\bullet}, \rho_{\bullet}\right) \mid n \geq 1\right\}$ into $S$. By doing this for all $\left(u_{\bullet}, \rho_{\bullet}\right) \in$ $C_{c}^{\infty}(\mathbb{R}) \times C_{c}^{\infty}(\mathbb{R})$ we get a dense $S \subset U$ with the desired properties.

Now we can prove Proposition 3.1.
Proof of Proposition 3.1. & \left\|\left(\frac{\rho_{n}}{\partial_{x} \varphi_{n}}\right) \circ \varphi_{n}^{-1}-\left(\frac{\rho_{n}}{\partial_{x} \tilde{\varphi}_{n}}\right) \circ \tilde{\varphi}_{n}^{-1}\right\|_{H^{s-1}} \\
& \geq \tilde{C}\left(\left\|\left(\frac{\rho_{n}}{\partial_{x} \varphi_{n}}\right) \circ \varphi_{n}^{-1}\right\|_{H^{s-1}}+\left\|\left(\frac{\rho_{n}}{\partial_{x} \tilde{\varphi}_{n}}\right) \circ \tilde{\varphi}_{n}^{-1}\right\|_{H^{s-1}}\right)
\end{aligned}
$$

for large $n$. Using this and (8) we can estimate

$$
\begin{aligned}
& \limsup _{n \rightarrow \infty}\left(\left\|\left(\frac{\rho_{n}}{\partial_{x} \varphi_{n}}\right) \circ \varphi_{n}^{-1}-\left(\frac{\rho_{n}}{\partial_{x} \tilde{\varphi}_{n}}\right) \circ \tilde{\varphi}_{n}^{-1}\right\|_{H^{s-1}}\right) \\
& \geq \frac{2 \tilde{C}}{C_{2}}\left\|\rho_{n}\right\|_{H^{s-1}}=\frac{2 \tilde{C}}{C_{2}} R / 4>0
\end{aligned}
$$

In summary, we constructed for an arbitrary $R \in\left(0, R_{*}\right]$ a pair of sequences

$$
\left(u_{0}^{(n)}, \rho_{0}^{(n)}\right),\left(\tilde{u}_{0}^{(n)}, \tilde{\rho}_{0}^{(n)}\right) \in B_{R}\left(\left(u_{\bullet}, \rho_{\bullet}\right)\right)
$$

with

$$
\lim _{n \rightarrow 0}\left(\left\|u_{0}^{(n)}-\tilde{u}_{0}^{(n)}\right\|_{H^{s}}+\left\|\rho_{0}^{(n)}-\tilde{\rho}_{0}^{(n)}\right\|_{H^{s-1}}\right)=0
$$

whereas

$$
\limsup _{n \rightarrow \infty}\left\|\Phi\left(u_{0}^{(n)}, \rho_{0}^{(n)}\right)-\Phi\left(\tilde{u}_{0}^{(n)}, \tilde{\rho}_{0}^{(n)}\right)\right\|_{H^{s} \times H^{s-1}}>0 .
$$

This shows that $\left.\Phi\right|_{B_{R}\left(\left(u_{\bullet}, \rho_{\bullet}\right)\right)}$ is not uniformly continuous. This finishes the proof.

Using Proposition 3.1 we can proof Theorem 1.2,
Proof of Theorem [1.2. By (5) We have for $T>0$

$$
\Phi_{T}: U_{T} \rightarrow H^{s}(\mathbb{R}) \times H^{s-1}(\mathbb{R}), \quad\left(u_{0}, \rho_{0}\right) \mapsto \Phi_{T}\left(u_{0}, \rho_{0}\right)=\frac{1}{T} \Phi\left(T u_{0}, T \rho_{0}\right)
$$

Thus Proposition 3.1 shows that $\Phi_{T}$ is nowhere uniformly continuous.
