# TRACES ON IWAHORI-HECKE ALGEBRAS AND COUNTING RATIONAL POINTS 

G. Lusztig

## Introduction

0.1. Let $W$ be a Weyl group with length function $w \mapsto|w|$ and let $\mathcal{H}$ be the Iwahori-Hecke algebra over $\mathbf{Q}(\mathbf{q})$ ( $\mathbf{q}$ is an indeterminate) attached to $W$. Recall that $\mathcal{H}$ is the $\mathbf{Q}(\mathbf{q})$-vector space with basis $\left\{T_{w} ; w \in W\right\}$ with multiplication given by $T_{w} T_{w^{\prime}}=T_{w w^{\prime}}$ if $w, w^{\prime} \in W$ satisfy $\left|w w^{\prime}\right|=|w|+\left|w^{\prime}\right|$ and $\left(T_{t}-\mathbf{q}\right)\left(T_{t}+1\right)=0$ if $t \in W,|t|=1$. For $w \in W$ let $\tau(w, \mathbf{q}) \in \mathbf{Z}[\mathbf{q}]$ be the trace of the linear map $\mathcal{H} \rightarrow \mathcal{H}$ given by $h \mapsto T_{w} h$. The "trace polynomials" $\tau(w, \mathbf{q})$ appear in relation with counting $\mathbf{F}_{q}$-rational points in certain algebraic varieties; three apparitions are in [L78],[L21],[L85], see 0.2(a), 0.3(a), 0.4(a); the fourth one is new, see 0.5. (We denote by $\mathbf{F}_{q}$ the subfield with $q$ elements of an algebraic closure $\mathbf{k}$ of $\mathbf{F}_{p} ; q$ is a power of a prime number $p$.)
0.2. Let $G$ be a connected, reductive group over $\mathbf{k}$ whose Weyl group is $W$. We fix a split $\mathbf{F}_{p}$-rational structure on $G$ with Frobenius map $F: G \rightarrow G$. Let $\mathcal{B}$ the variety of Borel subgroups of $G$. Then $W$ can be viewed as the set of orbits on $\mathcal{B} \times \mathcal{B}$ for the diagonal conjugation $G$-action. For any $w \in W$ let $\mathcal{O}_{w} \subset \mathcal{B} \times \mathcal{B}$ be the corresponding $G$-orbit. Let $F: \mathcal{B} \rightarrow \mathcal{B}$ be the map induced by $F: G \rightarrow G$. For any $B \in \mathcal{B}$ let $U_{B}$ be the unipotent radical of $B$. We fix $B^{+} \in B$ such that $F\left(B^{+}\right)=B^{+}$. We set $\nu=\operatorname{dim} \mathcal{B}$. Let $r$ be the rank of $G$.

For $w \in W, s \geq 1$ let $X_{w, s}=\left\{B \in \mathcal{B} ;\left(B, F^{s}(B)\right) \in \mathcal{O}_{w}\right\}$ (see [DL]). This is a subvariety of $\mathcal{B}$ on which $G^{F^{s}}$ acts by conjugation; hence there is an induced action of $G^{F^{s}}$ on the $\overline{\mathbf{Q}}_{l}$-cohomology space $H_{c}^{i}\left(X_{w, s}\right)$ so that the virtual representation $R_{w, s}^{1}=\sum_{i}(-1)^{i} H_{c}^{i}\left(X_{w, s}\right)$ of $G^{F^{s}}$ is defined. (For a set $Z$ and a map $F: Z \rightarrow Z$ we write $Z^{F}=\{z \in Z ; F(z)=z\}$.)

Let $s^{\prime} \geq 1$. The following result is obtained from of $[\mathrm{L} 78,3.8]$ with $w^{\prime}=1$.
(a) The number of $\mathbf{F}_{p^{s s^{\prime}}}$-rational points of $\left(B^{+}\right)^{F^{s}} \backslash X_{w, s}$ (where $\left(B^{+}\right)^{F^{s}}$ acts by conjugation) is equal to $\tau\left(w, p^{s s^{\prime}}\right)$. Moreover, we have $H_{c}^{i}\left(\left(B^{+}\right)^{F^{s}} \backslash X_{w, s}\right)_{j}=0$ for $j$ odd and $\sum_{i, j}(-1)^{i} \operatorname{dim} H_{c}^{i}\left(\left(B^{+}\right)^{F^{s}} \backslash X_{w, s}\right)_{j} \mathbf{q}^{j / 2}=\tau(w, \mathbf{q})$. (Here ()$_{j}$ is the part of pure weight $j$.)

0.3. For $w \in W, g \in G$ let $\left.Y_{g, w}=\left\{B \in \mathcal{B} ;\left(B, g B g^{-1}\right)\right) \in \mathcal{O}_{w}\right\}$. Let $s \geq 1$ and let $g \in\left(B^{+}\right)^{F^{s}}$ be regular semisimple in $G$. Then $Y_{g, w}$ is defined over $\mathbf{F}_{p^{s}}$. The following result can be found in [L21, 0.7(a),0.8(a)], see also [L79, 1.2].
(a) The number of $\mathbf{F}_{p^{s}}$-rational points of $Y_{g, w}$ is equal to $\tau\left(w, p^{s}\right)$. Moreover, we have $H_{c}^{i}\left(Y_{g, w}\right)_{j}=0$ for $j$ odd and $\sum_{i, j}(-1)^{i} \operatorname{dim} H_{c}^{i}\left(Y_{g, w}\right)_{j} \mathbf{q}^{j / 2}=\tau(w, \mathbf{q})$.
0.4. Let $w \in W, s \geq 1$. Let

$$
\begin{equation*}
\tilde{\mathfrak{B}}_{w}=\left\{\left(g, B, B^{\prime}\right) \in G \times \mathcal{B} \times \mathcal{B} ; g \in B,\left(B^{\prime}, g B^{\prime} g^{-1}\right) \in \mathcal{O}_{w}\right\} \tag{a}
\end{equation*}
$$

This variety is naturally defined over $\mathbf{F}_{p^{s}}$. The following statement is a special case of $[\mathrm{L} 85,13.5]$ with $\mathcal{L}=\overline{\mathbf{Q}}_{l}, w^{\prime}=1$ :
(b) $\left(\tilde{\mathfrak{B}}_{w}\right)^{F^{s}}=\sharp\left(G^{F^{s}}\right) \tau\left(w, p^{s}\right)$.
0.5. Let $\mathcal{T}$ be "the maximal torus" of $G$ identified with $B / U_{B}$ for any $B \in \mathcal{B}$. Let $w \in W$. We define a morphism $\pi: \tilde{\mathfrak{B}}_{w} \rightarrow \mathcal{T}$ by $\pi\left(g, B, B^{\prime}\right)=$ image of $g$ in $B / U_{B}=\mathcal{T}$. For $\delta \in \mathcal{T}$ we set

$$
\tilde{\mathfrak{B}}_{w}^{\delta}=\pi^{-1}(\delta)=\left\{\left(g, B, B^{\prime}\right) \in \tilde{\mathfrak{B}}_{w} ; g \in B_{\delta}\right\}
$$

where $B_{\delta}$ is the inverse image under $B \rightarrow B / U_{B}$ of the element $\delta_{B} \in B / U_{B}$ defined by $\delta$. The following refinement of $0.4(\mathrm{~b})$ will be proved in 1.2 .
(a) If $s \geq 1$ and $\delta \in \mathcal{T}^{F_{s}}$ then $\sharp\left(\left(\tilde{\mathfrak{B}}_{w}^{\delta}\right)^{F^{s}}\right)=p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right) \tau\left(w, p^{s}\right)$.
0.6. Specializing $\delta=1$, we have

$$
\tilde{\mathfrak{B}}_{w}^{1}=\left\{\left(g, B, B^{\prime}\right) \in \tilde{\mathfrak{B}}_{w} ; g \text { unipotent }\right\} .
$$

The variety $\tilde{\mathfrak{B}}_{w}^{1}$ is closely related to the main theme of [LY] (see below); it has been been considered independently by M.-T. Trinh.

Let $\operatorname{Irr}(W)$ be the set of irreducible representations of $W$ (up to isomorphism). For $w \in W$ we set
$B^{+} w B^{+}=\left\{g \in G ;\left(B^{+}, g B^{+} g^{-1}\right) \in \mathcal{O}_{w}\right\}$,
$\left(B^{+} w B^{+}\right)^{1}=\left\{g \in B^{+} w B^{+} ; g\right.$ unipotent $\}$.
In $[\mathrm{LY}, 1.3(\mathrm{~b})]$ for any $w \in W, s \geq 1$ and $E \in \operatorname{Irr}(W)$ we have defined

$$
\begin{equation*}
\zeta_{w, p^{s}, E}=\sum_{g \in\left(\left(B^{+} w B^{+}\right)^{1}\right)^{F^{s}}} \sum_{i}(-1)^{i} \operatorname{tr}\left(F^{s}, H^{i}\left(\mathcal{B}_{g}\right)_{E}\right) . \tag{a}
\end{equation*}
$$

Here $\mathcal{B}_{g}=\{B \in \mathcal{B} ; g \in B\}$ and $H^{i}\left(\mathcal{B}_{g}\right)_{E}=\operatorname{Hom}_{W}\left(E, H^{i}\left(\mathcal{B}_{g}\right)\right)$ where the Springer action of $W$ on $H^{i}\left(\mathcal{B}_{g}\right)$ is used. We have $\zeta_{w, p^{s}, E} \in \mathbf{Z}$, see [LY, 1.3(c)]. Let

$$
\left(\widetilde{B^{+} w B^{+}}\right)^{1}=\left\{(g, B) \in\left(B^{+} w B^{+}\right)^{1} \times \mathcal{B} ; g \in B\right\}
$$

From the definition we see that
(b) $\left.\sharp\left(\left(\widetilde{B^{+w B^{+}}}\right)^{1}\right)^{F^{s}}\right)=\sum_{E \in \operatorname{Irr}(W)} \zeta_{w, p^{s} ; E} \operatorname{dim}(E)$.

We have
(c) $\left.\sharp\left(\left(\tilde{\mathfrak{B}}_{w}^{1}\right)^{F^{s}}\right)=\sharp\left(\mathcal{B}^{F^{s}}\right) \sharp\left(\left(\widetilde{B^{+w B^{+}}}\right)^{1}\right)^{F^{s}}\right)=\sharp\left(\mathcal{B}^{F^{s}}\right) \sum_{E \in \operatorname{Irr}(W)} \zeta_{w, p^{s} ; E} \operatorname{dim}(E)$.

Indeed, we have a fibration $\tilde{\mathfrak{B}}_{w}^{1} \rightarrow \mathcal{B},\left(g, B, B^{\prime}\right) \mapsto B^{\prime}$ whose fibre at $B^{+}$is $\left(\widetilde{B^{+} w B^{+}}\right)^{1}$.

Now the numbers $\zeta_{w, p^{s} ; E}$ are described in $[\mathrm{LY}]$ so that (c) gives a way to compute $\sharp\left(\left(\tilde{\mathfrak{B}}_{w}^{1}\right)^{F^{s}}\right)$ other than (and more complicated than) that given by $0.5(\mathrm{a})$.
0.7. Let $w \in W$. The variety

$$
\mathfrak{B}_{w}=\left\{\left(g, B^{\prime}\right) \in G \times \mathcal{B} ;\left(B^{\prime}, g B^{\prime} g^{-1}\right) \in \mathcal{O}_{w}\right\}
$$

appeared in the theory of character sheaves. There is a unique map $\bar{\pi}: \mathfrak{B}_{w} \rightarrow$ $W \backslash \mathcal{T}$ such that the diagram

is commutative. (Here the left vertical map is $\left(g, B, B^{\prime}\right) \mapsto\left(g, B^{\prime}\right)$ and the right vertical map is the obvious one.) For $\delta \in \mathcal{T}$ we denote by $(\delta)$ the $W$-orbit of $\delta$ and we set $\mathfrak{B}_{w}^{(\delta)}=\bar{\pi}^{-1}((\delta))$. In particular we have

$$
\mathfrak{B}_{w}^{(1)}=\left\{\left(g, B^{\prime}\right) \in G \times \mathcal{B} ;\left(B^{\prime}, g B^{\prime} g^{-1}\right) \in \mathcal{O}_{w}, g \text { unipotent }\right\} .
$$

This variety is studied in $\S 2$.
0.8. In $\S 3$ we show that, in the case where $w \in W$ is elliptic and of minimal length in its conjugacy class, the varieties $\tilde{\mathfrak{B}}_{w}, \tilde{\mathfrak{B}}_{w}^{\delta}$ (with $\delta \in \mathcal{T}$ ) are smooth, irreducible. In $\S 4$ we study the space of orbits of the natural $G$-action on $\tilde{\mathfrak{B}}_{w}, \mathfrak{B}_{w}$ with $w$ as above. In $\S 5$ we prove a symmetry property of the polynomial $\tau(w, \mathbf{q})$.

## 1. Counting RAtional points of $\tilde{\mathfrak{B}}_{w}^{1}$

1.1. In this section we fix $s \geq 1$. Let $\mathcal{H}_{s}$ be the $\overline{\mathbf{Q}}_{l}$-algebra obtained by replacing $\mathbf{q}, \mathbf{Q}[\mathbf{q}]$ by $p^{s}, \overline{\mathbf{Q}}_{l}$ in the definition of $\mathcal{H}$ in 0.1 . It is known that $\mathcal{H}_{s}$ is canonically isomorphic to the group algebra $\overline{\mathbf{Q}}_{l}[W]$ provided a square root of $p$ is chosen. Hence any $E \in \operatorname{Irr}(W)$ can be regarded as an irreducible $\mathcal{H}_{s}$-module $E_{s}$. Let $\mathcal{F}$ be the vector space of functions $\mathcal{B}^{F^{s}} \rightarrow \overline{\mathbf{Q}}_{l}$. This is naturally a $G^{F^{s}}$-module and we can identify $\mathcal{H}_{s}=\operatorname{End}_{G^{F^{s}}} \mathcal{F}$. For $E \in \operatorname{Irr}(W)$ we set $\mathcal{F}_{E, s}=\operatorname{Hom}_{\mathcal{H}_{s}}\left(E_{s}, \mathcal{F}\right)$. This is naturally an irreducible representation of $G^{F^{s}}$.
1.2. We fix $w \in W$ and $\delta \in \mathcal{T}^{F^{s}}$. Let $\left.N=\sharp\left(\left(\tilde{\mathfrak{B}}_{w}^{\delta}\right)\right)^{F^{s}}\right)$.

We have $N=\sum_{B \in \mathcal{B}^{F^{s}}} \sum_{g \in\left(B_{\delta}\right)^{s}} \sharp\left(Y_{g, w}^{F^{s}}\right)$. By the argument in [L11, 1.3(a)] for any $g \in G^{F^{s}}$ we have

$$
\begin{equation*}
\sharp\left(Y_{g, w}^{F^{s}}\right)=\sum_{E \in \operatorname{Irr}(W)} \operatorname{tr}\left(T_{w}, E_{s}\right) \operatorname{tr}\left(g, \mathcal{F}_{E, s}\right) . \tag{a}
\end{equation*}
$$

It follows that

$$
N=\sum_{B \in \mathcal{B}^{F^{s}}} \sum_{E \in \operatorname{Irr}(W)} \operatorname{tr}\left(T_{w}, E_{s}\right) \sum_{g \in\left(B_{\delta}\right)^{F^{s}}} \operatorname{tr}\left(g, \mathcal{F}_{E, s}\right)
$$

For $B \in \mathcal{B}^{F^{s}}$ let

$$
\mathcal{F}_{E, s}^{U_{B}^{F^{s}}}=\left\{\xi \in \mathcal{F}_{E, s} ; u \xi=\xi \quad \forall u \in U_{B}^{F^{s}}\right\}
$$

Note that $\mathcal{F}_{E, s}^{U_{B}^{F^{s}}}$ is stable under the action of $B^{F^{s}}$ and is a direct sum of one dimensional representations of $B^{F^{s}}$ (on which $U_{B}^{F^{s}}$ acts trivially. If $\lambda$ is one of these one dimensional representations we see that $\mathcal{F}_{E, s}$ appears in $\operatorname{Ind}_{B^{F^{s}}}^{F^{s}}(\lambda)$ and also in $\operatorname{Ind}_{B^{F^{s}}}^{G^{s}}(1)$; but these two induced representations are disjoint unless $\lambda=1$. We see that $B^{F^{s}}$ acts trivially on $\mathcal{F}_{E, s}^{U_{B}^{F^{s}}}$. It follows that for any $g_{0} \in B^{F^{s}}$ we have

$$
\sum_{u \in U_{B}^{F^{s}}} \operatorname{tr}\left(g_{0} u, \mathcal{F}_{E, s}\right)=\sharp\left(U_{B}^{F^{s}}\right) \operatorname{dim}\left(\mathcal{F}_{E, s}^{U_{B}^{F^{s}}}\right) .
$$

It is well known that

$$
\operatorname{dim}\left(\rho_{E, p^{s}}^{U_{F^{s}}^{s}}\right)=\operatorname{dim} E
$$

It follows that

$$
\sum_{u \in U_{B}^{F^{s}}} \operatorname{tr}\left(g_{0} u, \mathcal{F}_{E, s}\right)=\sharp\left(U_{B}^{F^{s}}\right) \operatorname{dim}(E) .
$$

In particular we have

$$
\sum_{g \in\left(B_{\delta}\right)^{F^{s}}} \operatorname{tr}\left(g, \mathcal{F}_{E, s}\right)=p^{\nu s} \operatorname{dim}(E)
$$

We see that

$$
N=p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right) \sum_{E \in \operatorname{Irr}(W)} \operatorname{tr}\left(T_{w}, E_{p^{s}}\right) \operatorname{dim}(E) .
$$

Note that $\sum_{E \in \operatorname{Irr}(W)} \operatorname{tr}\left(T_{w}, E_{s}\right) \operatorname{dim}(E)=\tau\left(w, p^{s}\right)$. (The trace defining $\tau\left(w, p^{s}\right)$ can be computed by decomposing the left regular representation of $\mathcal{H}_{s}$ into irreducible submodules.) We see that

$$
N=p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right) \tau\left(w, p^{s}\right) .
$$

This completes the proof of $0.5(\mathrm{a})$.

## 2. Counting RAtional points of $\mathfrak{B}{ }_{w}^{(1)}$

2.1. In this section we fix $w \in W$ and $s \geq 1$. Let $1 \in \operatorname{Irr}(W)$ be the unit representation. It is known that if $g \in G$ is unipotent then $H^{i}\left(\mathcal{B}_{g}\right)_{\mathbf{1}}$ is 0 if $i \neq 0$ and is $\overline{\mathbf{Q}}_{l}$ if $i=0$. Using this and the definition $0.6(\mathrm{a})$, we see that $\sharp\left(\left(\left(B^{+} w B^{+}\right)^{1}\right)^{F^{s}}\right)=$ $\zeta_{w, p^{s}, \mathbf{1}}$. Hence
(a) $\sharp\left(\left(\mathfrak{B}_{w}^{(1)}\right) F^{s}\right)=\sharp\left(\mathcal{B}^{F^{s}}\right) \zeta_{w, p^{s}, \mathbf{1}}$.

We now write (in $\mathcal{H}):(-\mathbf{q})^{|w|} T_{w^{-1}}^{-1}=\sum_{z \in W}(-1)^{|z|} R_{z, w, \mathbf{q}} T_{z}$ where $R_{z, w, \mathbf{q}} \in \mathbf{Z}[\mathbf{q}]$. Note that $R_{z, w, \mathbf{q}}$ is the same as $R_{z, w}$ in [KL, (2.0.a)] (we use [KL, 2.1(i)]). The following result could be deduced from [KA] (I thank Minh-Tam Trinh for this remark); but our proof gives additional information, see 2.6(a).

Proposition 2.2. We have $\zeta_{w, p^{s} ; \mathbf{1}}=p^{\nu s} R_{1, w, p^{s}}$. Hence

$$
\sharp\left(\left(\mathfrak{B}_{w}^{(1)}\right)^{F^{s}}\right)=\sharp\left(\mathcal{B}^{F^{s}}\right) p^{\nu s} R_{1, w, p^{s}} .
$$

2.3. For $y \in W$ we write, as in [LY, 1.3]:

$$
a_{w, y}=\sum_{E \in \operatorname{Irr}(W)} \zeta_{w, p^{s} ; E} \operatorname{tr}(y, E) \in \mathbf{Z} .
$$

From [LY, 2.7] we have:
Proposition 2.4. For any $y \in W$ we have
(a) $\quad a_{w, y}=\sum_{\mathcal{E} \in \operatorname{Irr}(W)}(-1)^{|y|}\left(\mathcal{F}_{\mathcal{E}, s}: \operatorname{dim}\left(R_{y, s}^{1}\right) R_{y, s}^{1}\right) \operatorname{tr}\left(T_{w}, \mathcal{E}_{s}\right) p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right)^{-1}$.

Here $\left(\mathcal{F}_{\mathcal{E}, s}: ?\right)$ is the multiplicity of $\mathcal{F}_{\mathcal{E}, s}$ in the virtual representation ? of $G^{F^{s}}$.
2.5. We have

$$
\begin{equation*}
\sum_{y \in W} a_{w, y}=\sharp(W) \zeta_{w, p^{s} ; \mathbf{1}} \tag{a}
\end{equation*}
$$

hence

$$
\begin{aligned}
& \zeta_{w, p^{s} ; \mathbf{1}}=\sharp(W)^{-1} \sum_{\mathcal{E} \in \operatorname{Irr}(W)} \\
& \left(\mathcal{F}_{\mathcal{E}, s}: \sum_{y \in W} \operatorname{dim}\left(R_{y, s}^{1}\right) D\left(R_{y, s}^{1}\right)\right) \operatorname{tr}\left(T_{w}, \mathcal{E}_{s}\right) p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right)^{-1},
\end{aligned}
$$

where $D$ is the duality homomorphism from the group of virtual representations of $G^{F^{s}}$ to itself (see $[\mathrm{L} 84,6.8]$ ); recall that $D\left(R_{y, s}^{1}\right)=(-1)^{|y|} R_{y, s}^{1}$. We now
replace $\left(\mathcal{F}_{\mathcal{E}, s}: \sum_{y \in W} \operatorname{dim}\left(R_{y, s}^{1}\right) D\left(R_{y, s}^{1}\right)\right)$ by $\left(D\left(\mathcal{F}_{\mathcal{E}, s}\right): \sum_{y \in W} \operatorname{dim}\left(R_{y, s}^{1}\right) R_{y, s}^{1}\right)$ and then by $\left(\mathcal{F}_{\mathcal{E} \otimes \operatorname{sgn}, s}: \sum_{y \in W} \operatorname{dim}\left(R_{y, s}^{1}\right) R_{y, s}^{1}\right)$ where sgn is the sign representation of $W$. By [DL, 7.5], $\left.\sharp(W)^{-1} \sum_{y \in W} \operatorname{dim}\left(R_{y, s}^{1}\right) R_{y, s}^{1}\right)$ is the projection of the regular representation Reg of $G^{F^{s}}$ onto the space spanned by unipotent representations. It follows that

$$
\begin{aligned}
& \zeta_{w, p^{s} ; \mathbf{1}}=\sum_{\mathcal{E} \text { in } \operatorname{Irr}(W)}\left(\mathcal{F}_{\mathcal{E} \otimes \mathrm{sgn}, s}: \operatorname{Reg}\right) \operatorname{tr}\left(T_{w}, \mathcal{E}_{s}\right) p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right)^{-1} \\
& =\sum_{\mathcal{E} \text { in } \operatorname{Irr}(W)} \operatorname{dim}\left(\mathcal{F}_{\mathcal{E} \otimes \mathrm{sgn}, s}\right) \operatorname{tr}\left(T_{w}, \mathcal{E}_{s}\right) p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right)^{-1} .
\end{aligned}
$$

It is known that $\operatorname{tr}\left(T_{w}, \mathcal{E}_{s}\right)=\operatorname{tr}\left(\left(-p^{s}\right)^{|w|} T_{w^{-1}}^{-1},(\mathcal{E} \otimes \operatorname{sgn})_{s}\right)$. It follows that

$$
\begin{aligned}
& \zeta_{w, p^{s} ; \mathbf{1}}=\sum_{\mathcal{E} \text { in } \operatorname{Irr}(W)} \operatorname{dim}\left(\mathcal{F}_{\mathcal{E} \otimes \operatorname{sgn}, s}\right) \operatorname{tr}\left(\left(-p^{s}\right)^{|w|} T_{w^{-1}}^{-1},(\mathcal{E} \otimes \operatorname{sgn})_{s}\right) p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right)^{-1} \\
& =\sum_{\mathcal{E}^{\prime} \text { in } \operatorname{Irr}(W)} \operatorname{dim}\left(\mathcal{F}_{\mathcal{E}^{\prime}, s}\right) \operatorname{tr}\left(\left(-p^{s}\right)^{|w|} T_{w^{-1}}^{-1}, \mathcal{E}_{s}^{\prime}\right) p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right)^{-1} \\
& =\operatorname{tr}\left(\left(-p^{s}\right)^{|w|} T_{w^{-1}}^{-1}, \mathcal{F}_{s}\right) p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right)^{-1} \\
& =\sum_{z \in W}(-1)^{|z|} R_{z, w, p^{s}} \operatorname{tr}\left(T_{z} ; \mathcal{F}_{s}\right) p^{\nu s} \sharp\left(\mathcal{B}^{F^{s}}\right)^{-1} .
\end{aligned}
$$

We have $\operatorname{tr}\left(T_{z}, \mathcal{F}_{s}\right)=0$ if $z \neq 1$ and $\operatorname{tr}\left(T_{1}, \mathcal{F}_{s}\right)=\sharp\left(\mathcal{B}^{F^{s}}\right)$ hence $\zeta_{w, p^{s} ; \mathbf{1}}=$ $p^{\nu s} R_{1, w, p^{s}}$. This completes the proof of 2.2 .
2.6. For any $y \in W$ we set

$$
\tau_{y}\left(w, p^{s}\right)=\sum_{E \in \operatorname{Irr}(W)} \operatorname{tr}\left(T_{w}, E_{s}\right)\left(\mathcal{F}_{E, s}: R_{y, s}^{1}\right) \in \mathbf{Z}
$$

Note that $\tau_{1}\left(w, p^{s}\right)=\tau\left(w, p^{s}\right)$. (We use that

$$
\left.\tau_{1}\left(w, p^{s}\right)=\sum_{E \in \operatorname{Irr}(W)} \operatorname{tr}\left(T_{w}, E_{s}\right) \operatorname{dim}(E)=\tau\left(w, p^{s}\right) .\right)
$$

We have

$$
\begin{equation*}
R_{1, w, p^{s}}\left(p^{s}-1\right)^{\operatorname{dim} \rho}=\sharp(W)^{-1} \sum_{y \in W} \tau_{y}\left(w, p^{s}\right) \operatorname{det}\left(p^{s}-y, \rho\right)^{-1} . \tag{a}
\end{equation*}
$$

Using 2.2, 2.5(a), 2.4 we have

$$
\begin{aligned}
& R_{1, w, p^{s}}=\sharp(W)^{-1} \sum_{y \in W} \sum_{\mathcal{E} \in \operatorname{Irr}(W)}(-1)^{|y|}\left(\mathcal{F}_{\mathcal{E}, s}: \operatorname{dim}\left(R_{y, s}^{1}\right) R_{y, s}^{1}\right) \operatorname{tr}\left(T_{w}, \mathcal{E}_{s}\right) \sharp\left(\mathcal{B}^{F^{s}}\right)^{-1} \\
& =\sharp(W)^{-1} \sum_{y \in W} \sum_{\mathcal{E} \in \operatorname{Irr}(W)}(-1)^{|y|} \operatorname{dim}\left(R_{y, s}^{1}\right) \tau_{y}\left(w, p^{s}\right) \sharp\left(\mathcal{B}^{F^{s}}\right)^{-1} .
\end{aligned}
$$

It remains to use the known formula

$$
\operatorname{dim}\left(R_{y, s}^{1}\right)=(-1)^{|y|} \sharp\left(\mathcal{B}^{F^{s}}\right)\left(p^{s}-1\right)^{\operatorname{dim} \rho} \operatorname{det}\left(p^{s}-y, \rho\right)^{-1} .
$$

## 3. Smoothness

## 3.1.

In this section we fix $w \in W$ which is elliptic and of minimal length in its conjugacy class.
Proposition 3.2. (a) $\tilde{\mathfrak{B}}_{w}$ is smooth, irreducible, of dimension $r+2 \nu+|w|$.
(b) Let $\delta \in \mathcal{T}$. Then $\tilde{\mathfrak{B}}_{w}^{\delta}$ is smooth, irreducible, of dimension $2 \nu+|w|$.
3.3. For a point $x$ of a smooth variety $V$ let $T_{x}(V)$ be the tangent space of $V$ at $x$.

Let $E$ be $\{(g, B) \in G \times \mathcal{B} ; g \in B\}$ (in case 3.2(a)) or $\left\{(g, B) \in G \times \mathcal{B} ; g \in B_{\delta}\right\}$ (in case 3.2(b)). Then $E$ is a smooth variety of dimension $e$ where $e=r+2 \nu$ (in case $3.2(\mathrm{a}))$ or $e=2 \nu($ in case $3.2(\mathrm{~b}))$. Let $\tilde{\mathfrak{B}}_{w}(E)=\left\{\left(g, B, B^{\prime}\right) \in \tilde{\mathfrak{B}}_{w} ;(g, B) \in E\right\}$. This equals $\tilde{\mathfrak{B}}_{w}$ (in case $3.2(\mathrm{a})$ ) and $\tilde{\mathfrak{B}}_{w}^{\delta}$ (in case $3.2(\mathrm{~b})$ ). We can identify $\tilde{\mathfrak{B}}_{w}(E)$ with the intersection
(a) ${ }^{\prime} \tilde{\mathfrak{B}}_{w}(E) \cap " \tilde{\mathfrak{B}}(E)$
where

$$
\begin{aligned}
& \prime \tilde{\mathfrak{B}}_{w}(E)=\left\{\left(g, B, B^{\prime}, B^{\prime \prime}\right) \in G \times \mathcal{B} \times \mathcal{B} \times \mathcal{B} ;(g, B) \in E,\left(B^{\prime}, B^{\prime \prime}\right) \in \mathcal{O}_{w}\right\} \\
& \prime \prime \tilde{\mathfrak{B}}(E)=\left\{\left(g, B, B^{\prime}, B^{\prime \prime}\right) \in G \times \mathcal{B} \times \mathcal{B} \times \mathcal{B} ;(g, B) \in E, g B^{\prime} g^{-1}=B^{\prime \prime}\right\}
\end{aligned}
$$

are smooth subvarieties of pure dimension $e+\nu+l(w), e+\nu$ of the smooth variety $\tilde{\mathfrak{B}}(E)=\left\{\left(g, B, B^{\prime}, B^{\prime \prime}\right) \in G \times \mathcal{B} \times \mathcal{B} \times \mathcal{B} ;(g, B) \in E\right\}$ of pure dimension $e+2 \nu$. We show that
(b) the intersection (a) is transversal; hence $\tilde{\mathfrak{B}}_{w}(E)$ is smooth of pure dimension $e+l(w)$.
Let $x=\left(g, B, B^{\prime}, B^{\prime \prime}\right) \in \tilde{\mathfrak{B}}_{w}(E)$ (viewed as a subset of $\left.\tilde{\mathfrak{B}}(E)\right)$. Let $V_{g}=$ $\left\{\left(B^{\prime}, B^{\prime \prime}\right) \in \mathcal{B} \times \mathcal{B} ; g B^{\prime} g^{-1}=B^{\prime \prime}\right\}$. From $[\mathrm{L} 11,5.6]$ we have
(c) $T_{\left(B^{\prime}, B^{\prime \prime}\right)}\left(V_{g}\right)+T_{\left(B^{\prime}, B^{\prime \prime}\right)}\left(\mathcal{O}_{w}\right)=T_{\left(B^{\prime}, B^{\prime \prime}\right)}(\mathcal{B} \times \mathcal{B})$.

We have

$$
\begin{aligned}
& T_{x}(\tilde{\mathfrak{B}}(E))=T_{g, B}(E) \times T_{\left(B^{\prime}, B^{\prime \prime}\right)}(\mathcal{B} \times \mathcal{B}), \\
& T_{x}\left({ }^{\prime} \tilde{\mathfrak{B}}_{w}(E)\right)=T_{g, B}(E) \times T_{\left(B^{\prime}, B^{\prime \prime}\right)}\left(\mathcal{O}_{w}\right), \\
& T_{x}\left({ }^{\prime \prime} \tilde{\mathfrak{B}}(E)\right)=T_{g, B}(E) \times T_{\left(B^{\prime}, B^{\prime \prime}\right)}\left(V_{g}\right),
\end{aligned}
$$

hence using (c) we have

$$
\begin{aligned}
& T_{x}\left({ }^{\prime} \tilde{\mathfrak{B}}_{w}(E)\right)+T_{x}\left({ }^{\prime \prime} \tilde{\mathfrak{B}}(E)\right)=T_{g, B}(E) \times\left(T_{\left(B^{\prime}, B^{\prime \prime}\right)}\left(V_{g}\right)+T_{\left(B^{\prime}, B^{\prime \prime}\right)}\left(\mathcal{O}_{w}\right)\right) \\
& =T_{g, B}(E) \times T_{\left(B^{\prime}, B^{\prime \prime}\right)}(\mathcal{B} \times \mathcal{B})=T_{x}(\tilde{\mathfrak{B}}(E)) .
\end{aligned}
$$

This proves (b).
The argument above shows also that
(d) the map $\pi: \tilde{\mathfrak{B}}_{w} \rightarrow \mathcal{T}$ in 0.5 is smooth.
(I thank Zhiwei Yun for this remark.)
3.4. It is known that for $w$ elliptic, $\tau(w, \mathbf{q})$ is a monic polynomial in $\mathbf{q}$ of degree $|w|$. (This was stated without proof in [L78, p.27, line 2-4]; a proof is given in
[L20].) Using this and $0.4(\mathrm{~b})$ we see that for $s=1,2, \ldots$, the number of $\mathbf{F}_{p^{s-}}$ rational points of $\tilde{\mathfrak{B}}_{w}$ is a monic polynomial in $p^{s}$ of degree equal to $r+2 \nu+|w|$. Using instead 0.5(a) for $s$ such that $\delta$ in $3.2(\mathrm{~b})$ is defined over $\mathbf{F}_{p^{s}}$ we see that for such $s$, the number of $\mathbf{F}_{p^{s}}$-rational points of $\tilde{\mathfrak{B}}_{w}^{\delta}$ is a monic polynomial in $p^{s}$ of degree equal to $2 \nu+|w|$. From this the irreducibility statements in 3.2 follow (we use $3.3(\mathrm{~b})$ ). This completes the proof of 3.2.

## 4. Quotient by the $G$-action

4.1. In this section we assume that $G$ is semisimple and that $w \in W$ is as in 0.8. Let $s \geq 1$. Now $G$ acts on $\tilde{\mathfrak{B}}_{w}$ by $x:\left(g, B, B^{\prime}\right) \mapsto\left(x g x^{-1}, x B x^{-1}, x B^{\prime} x^{-1}\right)$ and on $\mathfrak{B}_{w}$ by $x:\left(g, B^{\prime}\right) \mapsto\left(x g x^{-1}, x B^{\prime} x^{-1}\right)$. Let $G \backslash \tilde{\mathfrak{B}}_{w}, G \backslash \mathfrak{B}_{w}$ be the set of $G$-orbits on $\tilde{\mathfrak{B}}_{w}, \mathfrak{B}_{w}$. Now $F^{s}: \tilde{\mathfrak{B}}_{w} \rightarrow \tilde{\mathfrak{B}}_{w}, F^{s}: \mathfrak{B}_{w} \rightarrow \mathfrak{B}_{w}$ induce bijections $F^{s}: G \backslash \tilde{\mathfrak{B}}_{w} \rightarrow G \backslash \tilde{\mathfrak{B}}_{w}, F^{s}: G \backslash \mathfrak{B}_{w} \rightarrow G \backslash \mathfrak{B}_{w}$. We show:
(a) $\sharp\left(\left(G \backslash \tilde{\mathfrak{B}}_{w}\right)^{F^{s}}\right)=\sharp\left(\left(\tilde{\mathfrak{B}}_{w}\right)^{F^{s}}\right) \sharp\left(G^{F^{s}}\right)^{-1}$,
(b) $\sharp\left(\left(G \backslash \mathfrak{B}_{w}\right)^{F^{s}}\right)=\sharp\left(\left(\mathfrak{B}_{w}\right)^{F^{s}}\right) \sharp\left(G^{F^{s}}\right)^{-1}$.

It is enough to show that
(c) if $E$ is any $G$-orbit on $\tilde{\mathfrak{B}}_{w}$ such that $F^{s}(E)=E$ then $\sharp\left(E^{F^{s}}\right)=\sharp\left(G^{F^{s}}\right)$;
(d) if $E^{\prime}$ is any $G$-orbit on $\mathfrak{B}_{w}$ such that $F^{s}\left(E^{\prime}\right)=E^{\prime}$ then $\sharp\left(E^{\prime} F^{s}\right)=\sharp\left(G^{F^{s}}\right)$.

Now from [L11, 5.2] we see that the isotropy group in $G$ of any point in $E^{\prime}$ is finite and hence the isotropy group in $G$ of any point in $E$ is finite. By Lang's theorem $E$ and $E^{\prime}$ are of the form $G / \Gamma$ with $\Gamma$ a finite subgroup of $G$ stable under $F^{s}$. We must show that $\sharp\left((G / \Gamma)^{F^{s}}\right)=\sharp\left(G^{F^{s}}\right)$ or that $\sum_{i}(-1)^{i} \operatorname{tr}\left(F^{s}, H_{c}^{i}(G / \Gamma)\right)=$ $\sum_{i}(-1)^{i} \operatorname{tr}\left(F^{s}, H_{c}^{i}(G)\right)$. It is enough to show that $H_{c}^{i}(G / \Gamma)=H_{c}^{i}(G)$ for each $i$. This follows from the fact that $\Gamma$ acts trivially on $H_{c}^{i}(G)$ (the $\Gamma$-action on $G$ by right translations is part of an action of a connected group).
4.2. We show that
(a) $\sharp\left(\left(G \backslash \mathfrak{B}_{w}\right)^{F^{s}}\right)=p^{s|w|}$.

By [HL] there exists an $F$-stable subvariety $V$ of $G$ stable under conjugation by elements in a finite abelian $F$-stable subgroup $\Delta$ of $G$ such that any $G$-orbit in $\mathfrak{B}_{w}$ meets $V$ in exactly one $\Delta$-orbit and such that $V$ is isomorphic to $\mathbf{k}^{|w|}$. It follows that $\left.\sharp\left(\left(G \backslash \mathfrak{B}_{w}\right)^{F^{s}}\right)\right)$ is equal to the number of $F^{s}$-stable $\Delta$-orbits in $V$ hence is equal to $\sum_{i}(-1)^{i} \operatorname{tr}\left(F^{s}, H_{c}^{i}(\Delta \backslash V)\right)$. But $H_{c}^{i}(\Delta \backslash V)$ is the $\Delta$-invariant part of $H_{c}^{i}(V)$ which is 0 if $i \neq 2|w|$ and is one dimensional with trivial action of $\Delta$ and with $F^{s}$ acting as $p^{s|w|}$ if $i=2|w|$. This proves (a).
4.3. From $0.4(\mathrm{~b})$ and 4.1 (a) we see that
(a) $\left.\sharp\left(\left(G \backslash \tilde{\mathfrak{B}}_{w}\right)\right)^{s}\right)=\tau\left(w, p^{s}\right)$.
4.4. Let $\delta \in \mathcal{T}^{F^{s}}$. Let $G \backslash \tilde{\mathfrak{B}}_{w}^{\delta}$ be the set of $G$-orbits on $\tilde{\mathfrak{B}}_{w}^{\delta}$. This is a subset of $G \backslash \tilde{\mathfrak{B}}_{w}$ stable under $F^{s}: G \backslash \tilde{\mathfrak{B}}_{w} \rightarrow G \backslash \tilde{\mathfrak{B}}_{w}$. Using 4.1(c) we see that
(a) $\left.\sharp\left(\left(G \backslash \tilde{\mathfrak{B}}_{w}^{\delta}\right)\right)^{s}\right)=\sharp\left(\left(\tilde{\mathfrak{B}}_{w}^{\delta}\right)^{F^{s}}\right) \sharp\left(G^{F^{s}}\right)^{-1}$.

Combining this with 0.5 (a) we see that
(b) $\sharp\left(\left(G \backslash \tilde{\mathfrak{B}}_{w}^{\delta}\right)^{F^{s}}\right)=\tau\left(w, p^{s}\right)\left(p^{s}-1\right)^{-r}$
4.5. Let $(\delta) \in(W \backslash \mathcal{T})^{F^{s}}$. Let $G \backslash \mathfrak{B}_{w}^{(\delta)}$ be the set of $G$-orbits on $\mathfrak{B}_{w}^{(\delta)}$. This is a subset of $G \backslash \mathfrak{B}_{w}$ stable under $F^{s}: G \backslash \mathfrak{B}_{w} \rightarrow G \backslash \mathfrak{B}_{w}$. Using 4.1(d) we see that
(a) $\sharp\left(\left(G \backslash \mathfrak{B}_{w}^{(\delta)}\right)^{s}\right)=\sharp\left(\left(\mathfrak{B}_{w}^{(\delta)}\right) F^{s}\right) \sharp\left(G^{F^{s}}\right)^{-1}$.

Combining (a) (with $(\delta)=(1)$ ) and 2.2 we see that
(b) $\sharp\left(\left(G \backslash \mathfrak{B}_{w}^{(1)}\right)^{F^{s}}\right)=R_{1, w, p^{s}}\left(p^{s}-1\right)^{-r}$.
4.6. Let $H$ be the a regular semisimple conjugacy class in $G$ such that $F^{s}(H)=H$. There is a unique conjugacy class $C$ in $W$ such that for any $g \in H^{F^{s}}$ the following holds: for some/any $B \in \mathcal{B}$ containing $g$ we have $\left(B, F^{s}(B)\right) \in \mathcal{O}_{y}$ for some $y \in C$. Let $\delta \in \mathcal{T}$ be the image of $g \in H$ in $B / U_{B}$ where $B \in \mathcal{B}$ contains $g$. The $W$-orbit ( $\delta$ ) of $\delta$ is independent of the choice of $g, B$ and is $F^{s}$-stable. We have $\sharp\left(H^{F^{s}}\right)=\sharp\left(G^{F^{s}}\right) \operatorname{det}\left(p^{s}-y, \rho\right)^{-1}$ where $y \in C$ and $\rho$ is as in 2.3. Let $g \in H^{F^{s}}$. Replacing $\operatorname{tr}\left(g, \mathcal{F}_{E, s}\right)$ by $\left(\mathcal{F}_{E, s}: R_{y, s}^{1}\right)$ in $1.2($ a) (with $y$ as above) we obtain

$$
\sharp\left(Y_{g, w}^{F^{s}}\right)=\tau_{y}\left(w, p^{s}\right)
$$

(notation of 2.6). We have
(a)
$\sharp\left(\left(\mathfrak{B}_{w}^{(\delta)}\right)^{F^{s}}\right)=\sum_{g \in H^{F^{s}}} \sharp\left(Y_{g, w}^{F^{s}}\right)=\sharp\left(H^{F^{s}}\right) \tau_{y}\left(w, p^{s}\right)=\sharp\left(G^{F^{s}}\right) \operatorname{det}\left(p^{s}-y, \rho\right)^{-1} \tau_{y}\left(w, p^{s}\right)$.
Using 4.5(a) we deduce

$$
\begin{equation*}
\sharp\left(\left(G \backslash \mathfrak{B}_{w}^{(\delta)}\right)^{F^{s}}\right)=\operatorname{det}\left(p^{s}-y, \rho\right)^{-1} \tau_{y}\left(w, p^{s}\right) . \tag{b}
\end{equation*}
$$

In particular if $H$ is such that $C=\{1\}$ then

$$
\begin{equation*}
\sharp\left(\left(G \backslash \mathfrak{B}_{w}^{(\delta)}\right)^{F^{s}}\right)=\left(p^{s}-1\right)^{-r} \tau\left(w, p^{s}\right) . \tag{c}
\end{equation*}
$$

## 5. Symmetry

5.1. In this section we assume that $G$ is semisimple. Let $v$ be an indeterminate. Let $\tilde{\mathcal{H}}=\mathbf{Q}(v) \otimes_{\mathbf{Q}(\mathbf{q})} \mathcal{H}$ where $\mathbf{Q}(\mathbf{q})$ is viewed as a subfield of $\mathbf{Q}(v)$ by $\mathbf{q} \mapsto v^{2}$. We view $\mathcal{H}$ as a subset $\tilde{\mathcal{H}}$ by $h \mapsto 1 \otimes h$. For any $w \in W$ we set $\tilde{T}_{w}=v^{-|w|} T_{w} \in \tilde{\mathcal{H}}$ and $\tilde{\tau}(w)=v^{-|w|} \tau(w, \mathbf{q}) \in \mathbf{Q}(v), \tilde{R}_{z, w}=v^{-|w|+|z|} R_{z, w, \mathbf{q}} \in \mathbf{Q}(v)$. Let $\xi \mapsto \bar{\xi}$ be the field automorphism of $\mathbf{Q}(\mathbf{q})$ given by $\mathbf{q} \mapsto \mathbf{q}^{-1}$. This extends to a field automorphism $\xi \mapsto \bar{\xi}$ of $\mathbf{Q}(v)$ given by $v \mapsto-v^{-1}$. Let $w \in W$. We have the following symmetry property.

Proposition 5.2. (a) $\tilde{\tau}(w)$ is a polynomial with coefficients in $\mathbf{N}$ in $\left(v-v^{-1}\right)$ hence is invariant under ${ }^{-}$.
(b) For any $z \in W, \tilde{R}_{z, w}$ is a polynomial with coefficients in $\mathbf{N}$ in $\left(v-v^{-1}\right)$ hence is invariant under ${ }^{-}$.

We prove (a). For any $y, z \in W$ we have

$$
\tilde{T}_{y} \tilde{T}_{z}=\sum_{z^{\prime} \in W} c_{y, z}^{z^{\prime}} \tilde{T}_{z^{\prime}}
$$

If $y=1$ we have $c_{y, z}^{z^{\prime}}=1$ if $z=z^{\prime}, c_{y, z}^{z^{\prime}}=0$ if $z \neq z^{\prime}$. If $y \neq 1$ we write $y=s y^{\prime}$ with $|s|=1,|y|=\left|y^{\prime}\right|+1$; we have

$$
c_{y, z}^{z^{\prime}}=c_{y^{\prime}, z}^{s z^{\prime}}+\left(v-v^{-1}\right) d c_{y^{\prime}, z}^{z^{\prime}} \text { where } d=1 \text { if }\left|s z^{\prime}\right|<\left|z^{\prime}\right|, d=0 \text { if }\left|s z^{\prime}\right|>\left|z^{\prime}\right| .
$$

We now see (using induction on $|y|$ ) that $c_{y, z}^{z^{\prime}}$ is a polynomial with coefficients in $\mathbf{N}$ in $\left(v-v^{-1}\right)$. Since $\tilde{\tau}(w)=\sum_{z \in W} c_{w, z}^{z}$ we see that (a) holds.

We prove (b). From [KL, (2.0.b), (2.0.c)] we have
$\tilde{R}_{z, y}=\tilde{R}_{s z, s y}$ if $|s z|<|z|,|s y|<|y|$
$\tilde{R}_{z, y}=\left(v-v^{-1}\right) \tilde{R}_{s z, y}+\tilde{R}_{s z, s y}$ if $|s z|>|z|,|s y|<|y|$.
We now see (using induction on $|y|$ ) that $\tilde{R}_{z, y}$ is a polynomial with coefficients in $\mathbf{N}$ in $\left(v-v^{-1}\right)$ so that (b) holds.
Corollary 5.3. (a) For $w \in W$ we have $\overline{\tau(w, \mathbf{q})}=(-\mathbf{q})^{-|w|} \tau(w, \mathbf{q})$.
(b) For $w, z$ in $W$ we have $\overline{R_{z, w, \mathbf{q}}}=(-\mathbf{q})^{-|w|+|z|} R_{z, w, \mathbf{q}}$.

Note that (b) is contained in [KL, 2.1(i)].
5.4. In this subsection we assume that $w$ is as in 3.1. We set

$$
\underline{\tau(w, \mathbf{q})}=\tau(w, \mathbf{q})(\mathbf{q}-1)^{-r}, \underline{R_{1, w, \mathbf{q}}}=R_{1, w, \mathbf{q}}(\mathbf{q}-1)^{-r} .
$$

The rational functions $\tau(w, \mathbf{q}), \overline{R_{1, w, \mathbf{q}}}$ take integer values when $\mathbf{q}$ is specialized to
 that in $[\mathrm{LY}, 1.9])$ that
(a) $\frac{\tau(w, \mathbf{q})}{5} \in \mathbf{Z}[\mathbf{q}], R_{1, w, \mathbf{q}} \in \mathbf{Z}[\mathbf{q}]$.

From 5.3 we deduce the following symmetry property of the polynomials in $\mathbf{q}$ which calculate $\sharp\left(\left(G \backslash \tilde{\mathfrak{B}}_{w}^{1}\right)^{F^{s}}\right), \sharp\left(\left(G \backslash \mathfrak{B}_{w}^{(1)}\right)^{F^{s}}\right)$ :
(b) $\overline{\tau(w, \mathbf{q})}=\mathbf{q}^{-|w|+r} \underline{\tau(w, \mathbf{q})} ; \overline{R_{z, w, \mathbf{q}}}=\mathbf{q}^{-|w|+r} \underline{R_{z, w, \mathbf{q}}}$.
(We use that $|w|=r \bmod 2$.)
