# Global Solutions of Three-dimensional Inviscid MHD Fluids with Velocity Damping in Horizontally Periodic Domains

#### Abstract

The two-dimensional (2D) existence result of global(-in-time) solutions for the motion equations of incompressible, inviscid, non-resistive magnetohydrodynamic (MHD) fluids with velocity damping had been established in [Wu-Wu-Xu, SIAM J. Math. Anal. 47 (2013), 2630-2656]. This paper further studies the existence of global solutions for the three-dimensional (a dimension of real world) initial-boundary value problem in a horizontally periodic domain with finite height. Motivated by the multi-layers energy method introduced in [Guo-Tice, Arch. Ration. Mech. Anal. 207 (2013), 459-531], we develop a new type of two-layer energy structure to overcome the difficulty arising from three-dimensional nonlinear terms in the MHD equations, and thus prove the initial-boundary value problem admits a unique global solution. Moreover the solution has the exponential decay-in-time around some rest state. Our two-layer energy structure enjoys two features: (1) the lower-order energy (functional) can not be controlled by the higher-order energy. (2) under the a priori smallness assumption of lower-order energy, we first close the higher-order energy estimates, and then further close the lower-energy estimates in turn.


Keywords: non-resistive MHD fluids; incompressible; inviscid; damping; global well-posedness; exponential decay-in-time.

## 1. Introduction

In this paper, we investigate the global(-in-time) well-posdedness of the following threedimensional initial-boundary value problem for the incompressible, inviscid, non-resistive magnetohydrodynamic (MHD) fluid with velocity damping in a horizontally periodic domain $\Omega$ with finite height:

Next we shall explain the mathematical notations appearing in the problem above.

[^0]The unknowns $v:=v(x, t), M:=M(x, t)$ and $P:=P(x, t)$ denotes the velocity and magnetic field and kinetic pressure of incompressible MHD fluids, resp., where $(x, t) \in \mathbb{R}^{3} \times \mathbb{R}_{0}^{+}$and $\mathbb{R}_{0}^{+}:=[0, \infty)$. The positive constants $\rho, a$ and $\lambda$ stands for the density of fluids, damping coefficient and permeability of the vacuum, resp. The horizontally periodic domain $\Omega$ with finite height is defined as follows:

where $\mathbb{T}=\left(l_{1} \mathbb{R} / \mathbb{Z}\right) \times\left(l_{2} \mathbb{R} / \mathbb{Z}\right), \mathbb{R} / \mathbb{Z}$ represents the usual 1-torus, and the superscript $T$ denotes the transposition. Since $\Omega$ is horizontally periodic, the set $\mathbb{T} \times\{0, h\}$, denoted by $\partial \Omega$, customarily represents the boundary of $\Omega$. Without loss of generality, we assume that $l_{1}=l_{2}=h=1$ for the sake of simplicity.

For the the viscous case, i.e. the equations (1.1) $)_{1}-(1.1)_{3}$ with the viscous term $-\nu \Delta v$ in place of the velocity damping term $a \rho v$, the global well-posedness, in which the initial data is a small perturbation around a non-zero trivial stationary state (i.e., $(v, M)=(0, \bar{M})$, where $\bar{M}$ is a non-zero constant vector and $\bar{M}$ often called the impressive magnetic field), has been widely investigated, see [23, 35, 36] and [1, 34] for the 2D and 3D Cauchy problems resp., and see [26] and [29] for the 2D and 3D initial-boundary value problems resp.. The existence of global solutions to the 2D Cauchy problem with large initial perturbations was obtained by Zhang under a strong impressive magnetic field [36]. As for the well-poseness of the 3D Cauchy and initial-boundary value problems with large initial perturbations, to our best knowledge, all available results are about the local(-in-time) existence, see [5, 9,10$]$ for examples. We mention here that the corresponding compressible case has been also widely studied, see [21, 22, 32] and the references cited therein.

For the the inviscid case, Bardos-Sulem-Sulem used hyperbolicity of (1.1) $1_{1}-(1.1)_{3}$ with $\mu=0$ to establish an interesting global existence result of classical solutions of the Cauchy problem with small initial data in the Hölder space $H^{s}\left(\mathbb{R}^{3}\right)$ [3]; also see [4, 13] for the case of Sobolev spaces). We remark that such a result is not known in the 3D incompressible Euler equations (i.e. the case of the absence of magnetic field).

For the inviscid case with a velocity damping term, $\mathrm{Wu}-\mathrm{Wu}-\mathrm{Xu}$ first given the existence of a unique global solution with algebraic decay-in-time for the 2 D Cauchy problem of (1.1) $)_{1}-(1.1)_{4}$ with small initial perturbation [33]. Recently, Du-Yang-Zhou also obtained the existence of a unique global solution with exponential decay-in-time for the initial-boundary value problem in a 2D slab domain with small initial perturbation around some non-trivial equilibrium [8]. To our best knowledge, there are not any available result for the 3D case, thought the 3D wellposedness problem of inviscid fluids with velocity damping had been widely investigated, see [14, 25, 27, 28, 30] for examples. The goal of this paper is devoted to further providing the first 3D result by developing a new type of two-layer energy structure to overcome the difficulty arising from three-dimensional nonlinear terms in the MHD equations. It should be noted that the mathematical methods adopted in [8, 33] for the well-posedness problem in Eulerian coordinates cannot be applied to our 3D problem, therefore next we shall reformulate the initial-boundary value problem (1.1) in Lagrangian coordinates as in 16, 19, 31].

### 1.1. Reformulation in Lagrangian coordinates.

Let the flow map $\zeta$ to be the solution to the initial-value problem

Here and in what follows det denotes a determinant of matrix, and $f^{0}$ with the superscript 0 represents the initial data of $f$. Sometimes we also use $f_{0}$ with the subscript 0 to represent the initial data of $f$.

We denote the Eulerian coordinates by $(x, t)$ with $x=\zeta(y, t)$ and the Lagrangian coordinates by $(y, t) \in \Omega \times \mathbb{R}_{0}^{+}$. We further assume that, for each fixed $t>0$,

where $\bar{\Omega}:=\mathbb{R}^{2} \times[0,1]$.
Since $v$ satisfies the divergence-free condition, and slip boundary condition (1.1) $)_{5}$, we can deduce from (1.3)-(1.4) that

We introduce the matrix $\mathcal{A}=\left(\mathcal{A}_{i j}\right)_{3 \times 3}$, which is defined via

Then we further define the differential operators $\nabla_{\mathcal{A}}, \operatorname{div}_{\mathcal{A}}$ and $\operatorname{curl}_{\mathcal{A}}$ as follows: for a given scalar function $f$ and a given vector function $X:=\left(X_{1}, X_{2}, X_{3}\right)^{\mathrm{T}}$,

where we have used the Einstein convention of summation over repeated indices, and $\partial_{k}=\partial_{y_{k}}$. In particular, $\operatorname{curl} X:=\operatorname{curl}_{I} X$, where $I$ is a $3 \times 3$ identity matrix. In addition, we will denote $\left(\operatorname{curl}_{\mathcal{A}} X^{1}, \ldots, \operatorname{curl}_{\mathcal{A}} X^{n}\right)$ by $\operatorname{curl}_{\mathcal{A}}\left(X^{1}, \ldots X^{n}\right)$ for simplicity, where $X^{i}=\left(X_{1}^{i}, X_{2}^{i}, X_{3}^{i}\right)^{\mathrm{T}}$ is a vector function for $1 \leqslant i \leqslant n$.

Defining the Lagrangian unknowns

then in Lagrangian coordinates, the initial-boundary value problem (1.1) reads as follows:

We can derive from (1.7) 3 the differential version of magnetic flux conservation [18]:

It should be noted that $B$ given by (1.10) automatically satisfies (1.7) $)_{3}$ and (1.7) 4 . Moreover, we see from (1.10) that the magnetic tension in Lagrangian coordinates has the relation

### 1.2. Main results.

Before stating our main result, we introduce some notations which will be frequently used throughout this paper.
(1) Simplified basic notations: $I_{a}:=(0, a)$, in particular, $I_{\infty}=\mathbb{R}^{+}$. $\bar{S}$ denotes the closure of the set $S \subset \mathbb{R}^{n}$ with $n \geqslant 1$, in particular $\overline{I_{T}}:=[0, T] . \Omega_{a}:=\Omega \times I_{a} . \overrightarrow{\mathbf{n}}:=\left(\mathbf{n}_{1}, \mathbf{n}_{2}, \mathbf{n}_{3}\right)^{\mathrm{T}}$ denotes the outward unit normal vector on $\partial \Omega . \int:=\int_{\Omega}=\int_{(0,1)^{3}} .(u)_{\Omega}=\int u \mathrm{~d} y$.
$a \lesssim b$ means that $a \leqslant c b$. If not stated explicitly, the positive constant $c$ may depend on $a$, $m$ and $\Omega$, and may vary from one place to other place. Sometimes we use $c_{i}$ for $i \geqslant 1$ to replace $c$ in order to emphasize that $c_{i}$ is fixed value.
$\alpha$ always denotes the multiindex with respect to the variable $y,|\alpha|=\alpha_{1}+\alpha_{2}+\alpha_{3}$ is called the order of multiindex and $\partial^{\alpha}:=\partial_{1}^{\alpha_{1}} \partial_{2}^{\alpha_{2}} \partial_{3}^{\alpha_{3}}$. " $\nabla^{i} f \in \mathbb{X}$ " represents that $\partial^{\alpha} f \in \mathbb{X}$ for any multiindex $\alpha$ satisfying $|\alpha|=i$, where $\mathbb{X}$ denotes some set of functions.

We call $\mathcal{E}^{L}$, resp. $\mathcal{D}^{L}$ the lower energy, resp. dissipation functionals, and $\mathcal{E}^{H}$, resp. $\mathcal{D}^{H}$ the higher energy, resp. dissipation functionals.

Now we state the existence result of unique global solutions for the initial-boundary value problem (1.11) with small initial data.
Theorem 1.1. Let $\left(u^{0}, \eta^{0}\right) \in H_{\mathrm{s}}^{1,3} \times\left(H_{1, \mathrm{~s}}^{2,3} \cap H_{*}^{3}\right)$ satisfy the incompressible condition

where $\mathcal{A}^{0}:=\left(\nabla \eta^{0}+I\right)^{-\mathrm{T}}$. Then there exist a sufficiently small constant $\delta>0$ and a positive constant $c$, such that, for any $\left(u^{0}, \eta^{0}\right)$ satisfying

the initial-boundary problem (1.11) admits a unique global classical solution $(u, \eta, q) \in \mathfrak{U}_{\mathrm{s}, \infty}^{1,3} \times$ $\underline{\mathfrak{H}}_{1, s, \infty}^{2,3, *} \times C\left(\mathbb{R}_{0}^{+}, \underline{H}^{3}\right)$. Moreover the solution enjoys the following stability estimates:

where $\eta^{\infty}$ only depends on $y_{2}$ and $y_{3}$. In addition, $\nabla_{\mathcal{A}} q \in L_{\infty}^{\infty} H^{3}$.
Remark 1.1. In this paper, we only consider the impressive horizontal magnetic field $\bar{M}$. However it is not clear to the authors that whether there exists a global well-posdness result for non-horizontal magnetic field.

Remark 1.2. For the case $\Omega=\mathbb{R}^{2} \times(0,1)$, we also obtain similar result, where the exponential stability estimates (1.14) and (1.15) should be replaced by algebraic stability estimates. We will verify this assertion in a forthcoming paper.

Remark 1.3. For each fixed $t \in \mathbb{R}_{0}^{+}$, the solution $\eta(y, t)$ in Theorem 1.1 belongs to $H_{*}^{3}$. Let $\zeta=$ $\eta+y$, then $\zeta$ satisfies (1.5) and (1.6) for each fixed $t \in \mathbb{R}_{0}^{+}$. We denote the inverse transformation of $\zeta$ by $\zeta^{-1}$, and then define that

Consequently $(v, M, P)$ is a global solution for (1.1); moreover, making use of (1.13), (1.14) and the fifth conclusion in Lemma A.5, $(v, N, Q)$ enjoys stability estimates, which are similar to (1.13) and (1.14).

Next we briefly sketch the proof of Theorem 1.1, and the details will be presented in Section 2.

The key proof for the existence of global small solutions is to derive an a priori energy inequalities (1.13) and (1.14). To this purpose, let $(\eta, u)$ be a solution to (1.11) and satisfy

where $\delta$ is sufficiently small.
Under the a priori assumption (1.16) of lower-order energy, we first derive the both energy inequalities of horizontal-type and vorticity-type, see (2.27) and (2.41). Summing up the two energy inequalities, we can arrive at the lower-order energy inequality

for some energy functional $\tilde{\mathcal{E}}^{L}$, which is equivalent to $\mathcal{E}^{L}$.
Obviously we can not directly close the lower-order energy by using (1.18), unless the term $"\|u\|_{3}+\|\nabla q\|_{0} "$ decays in time. It should be noted that the term " $\left(\|u\|_{3}+\|\nabla q\|_{0}\right)\|\eta\|_{3}^{2 "}$ (arising from nonlinear terms, see (2.25) and (2.39)) does not appear in (1.18) for the two dimensional cases. Motivated by the multi-layers energy method introduced in [12], in which Guo-Tice investigated the global well-posdedness of surface wave problem, we naturally look for another energy inequality, which includes the decay-in-time of $\|u\|_{3}$.

By careful analysis of energy estimates, we find that, if $\left(u^{0}, \eta^{0}\right)$ additionally satisfies the regularity

Thus the higher-order energy inequality (1.19), together with the above equivalence, immediately implies the exponential stability of higher-order energy (1.14), which particularly presents the exponential decay-in-timely of $\|u\|_{3}$ and $\|\nabla q\|_{0}$. Hence the a priori stability estimate (1.13) further follows from (1.18).

Thanks to the a priori stability estimates (1.13)-(1.14) and the unique local solvability of the initial-boundary problem (1.11), we immediately get the unique global solvability of the initialboundary problem (1.11). Finally, (1.15) can be deduced from (1.14) by an asymptotic analysis method.

The rest of this paper is organized as follows. In Sections 2, we will provide the proof of Theorem 1.1. In Section 3, we will establish the local well-posdedness result for the initialboundary problem (1.11). Finally, in Appendix A, we will list some well-known mathematical results, which will be used in Sections 2 3.

## 2. Proof of Theorem 1.1

This section is devoted to the proof of Theorem 1.1. The key step is to derive the a priori stability estimates (1.13)-(1.14) for the initial-boundary value problem (1.11). To this end, let $(u, \eta, q)$ be a solution to the problem (1.11), and satisfy (1.16) and (1.17) with sufficiently small $\delta$. Next we proceed the derivation of a priori estimates.

### 2.1. Preliminary estimates

To begin with, we shall establish some preliminary estimates.
Lemma 2.1. Let $0 \leqslant i \leqslant 2$ and $1 \leqslant j \leqslant 2$. Under the assumptions (1.16) and (1.17), we have
(1) the estimates for $\mathcal{A}$ and $\tilde{\mathcal{A}}$ :

In addition, we easily derive (2.6) and (2.7) from the incompressible condition $\operatorname{div}_{\mathcal{A}} u=0$ by (A.2). Similarly, we easily get (2.8)-(2.10) from the relation (1.17). Interesting readers can refer to [15] for the detailed derivation.

### 2.2. Horizontal spatial estimates

Now we derive the estimates of horizontally spatial derivatives of $(u, \eta)$.

- for any $\tau \in I_{T^{\max }}$, the solution $(u, \eta, q)$ belongs to $\mathfrak{U}_{\tau}^{1,3} \times \mathfrak{H}_{1, *, \tau}^{2,3} \times C^{0}\left(\overline{I_{\tau}}, \underline{H}^{3}\right)$,

We easily see that the definition of $T^{*}$ makes sense and $T^{*}>0$. Thus, to obtain the existence of global solutions, it suffices to verify $T^{*}=\infty$. Next we shall prove this fact by contradiction.

We assume that $T^{*}<\infty$. Then, for any given $T^{* *} \in I_{T^{*}}$,

We take $\left(u\left(T^{* *}, \eta\left(T^{* *}\right)\right)\right)$ as a initial data. Noting that

In view of the existence result of $\left(u^{*}, \eta^{*}, q^{*}\right)$, the uniqueness conclusion in Proposition 2.3 and the fact that $T^{\max }$ denotes the maximal existence time, we immediately see that $T^{\max }>T^{*}+T / 2$ and $\sup _{t \in\left[0, T^{*}+T / 2\right]}\left\|\left(u, \eta, \partial_{1} \eta\right)\right\|_{3} \leqslant c_{2} c_{3}^{2} \delta$. This contradicts with the definition of $T^{*}$. Hence $T^{*}=\infty$ and thus $T^{\max }=\infty$. This completes the proof of the existence of global solutions. The uniqueness of global solution is obvious due to the uniqueness of local solutions in Proposition 2.3 and the fact $\sup _{t \geqslant 0}\|\eta\|_{1,3} \leqslant 2 \delta_{2}$. In addition, it is obvious that $(\eta, u)$ indeed enjoys (1.13) and (1.14) by the derivation of (2.65) and (2.66).

Finally, we derive (1.15). By (1.14), we easily see that

## 3. Local well-posedness

This section is devoted to the proof of local well-posedness of the initial-boundary value problem (1.11). Next we roughly sketch the proof frame to establish the local well-posedness result.

Similarly to 11], in which the authors investigated the well-posdeness problem of incompressible inviscid MHD fluid equations with free boundary, we first alternatively use an iteration
method to establish the existence result of the unique local solution $(u, \eta, q)$ of the linear $\kappa$ approximate problem

where $\kappa>0, \mathcal{B}:=(\nabla \varsigma+I)^{-\mathrm{T}}$, and the given function $\varsigma$ belongs to some proper function space, see Proposition 3.4 in Section 3.1 for details. It should be noted that the Neumann boundary-value condition $(3.1)_{6}$ makes sure the solvability of $q$.

Then we derive the $\kappa$-independent estimates of the solutions, denoted by ( $u^{\kappa}, \eta^{\kappa}, q^{\kappa}$ ) for $\kappa \in \mathbb{R}^{+}$, of the $\kappa$-approximate problem above, and then take the limit of $\left(u^{\kappa}, \eta^{\kappa}, q^{\kappa}\right)$ with respect to $\kappa \rightarrow 0$ in a common definition domain. In particular, the limit function, denoted by $(u, \eta, q)$, is the unique local solution to the linearized problem

see Proposition 3.5 in Section 3.2 for details. It should be noted that the solution $q$ of (3.2) automatically satisfies (3.1) ${ }_{6}$ due to $u_{3}$ satisfying $\left.\partial_{t} u_{3}\right|_{\partial \Omega}=0$.

Finally, since the linearized problem (3.2) admits a unique local solution for any given $\varsigma$, thus we easily arrive at Proposition 2.3 by a standard iteration method as in [6, 7], in which the authors investigated the well-posdeness problem of incompressible Euler equations with free boundary.

Now we turn to introducing some new notations appearing in this section. $P\left(x_{1}, \ldots, x_{n}\right)$ and $\dot{P}\left(x_{1}, \ldots, x_{n}\right)$ represent the generic polynomials with respect to the parameters $x_{1}, \ldots, x_{n}$, where all the coefficients in $P$ and $\dot{P}$ are equal one, and $\dot{P}$ satisfies $\dot{P}(0, \ldots, 0)=0 ; a \lesssim_{\kappa} b$ means that $a \leqslant c^{\kappa} b$, where $c^{\kappa}$ denotes a generic positive constant, which may depend on $\kappa, a, m$ and $\Omega$. It should be noted that $P\left(x_{1}, \ldots, x_{n}\right), \dot{P}\left(x_{1}, \ldots, x_{n}\right)$ and $c^{\kappa}$ may vary from line to line.

We define the difference quotient with respect variable $y_{1}$ as follows:

We always use the notations $\mathcal{B}$, resp. $\mathcal{J}$ to represent $(\nabla \varsigma+I)^{-\mathrm{T}}$, resp. $\operatorname{det}(\nabla \varsigma+I)$, where $\varsigma$ at least satisfies

In this section, we construct the unique local solution of the linear $\kappa$-approximate problem (3.1). To this purpose, we shall rewrite the linear $\kappa$-approximate problem (3.1) as the following equivalent problem (in the sense of classical solutions):

Thus the solvability of the linear problem (3.13) reduces to the solvability of the three subproblems above. Next we establish the global well-posedness results for the above three subproblems in sequence.

Proposition 3.1. Let $\kappa>0, T>0, w \in L_{T}^{2} H_{\mathrm{s}}^{3}$ and $\eta^{0} \in H_{\mathrm{s}}^{1,3}$. Then the initial-boundary value problem (3.14) admits a unique solution $\eta \in C^{0}\left(\overline{I_{T}}, H_{\mathrm{s}}^{3}\right)$, which satisfies $\partial_{1}^{2} \eta \in C^{0}\left(\overline{I_{T}}, H_{\mathrm{s}}^{2}\right)$, $\nabla^{3} \partial_{1} \eta \in C_{B, \text { weak }}^{0}\left(\overline{I_{T}}, L^{2}\right)$, and enjoys the estimates

In particular, $L \in C^{0}\left(\overline{I_{T}}, \mathcal{L}\left(H_{\mathrm{s}}^{1,3}\right)\right)$. By existence theory of the initial-value problem of a abstract ODE equation (see [24, Proposition 2.17]), there exists a unique solution $\eta^{\tau} \in C^{0}\left(\overline{I_{T}}, H_{\mathrm{s}}^{1,3}\right) \cap C^{1}\left(\overline{I_{T}}, H_{\mathrm{s}}^{1,3}\right)$ to (3.20). Obviously $\eta^{\tau}, \eta_{t}^{\tau}$ automatically belong to $L_{T}^{2} H_{\mathrm{s}}^{1,3}$ by the second conclusion in Lemma A.5 and the separability of $H_{\mathrm{s}}^{1,3}$.

Let $\alpha$ satisfy $0 \leqslant|\alpha| \leqslant 3$. Applying $\partial^{\alpha}$ to (3.20) $)_{1}$, and then multiplying the resulting identity by $\partial^{\alpha} \eta^{\tau}$ in $L^{2}$, we have

Hence there exists one limit function $\left(u^{\kappa}, \eta^{\kappa}, q^{\kappa}\right)$, which is the unique local solution of the linear $\kappa$ approximate problem (3.11) with $\left(u^{\kappa}, \eta^{\kappa}, q^{\kappa}\right)$ in place of $(\eta, u, q)$, and also the unique local solution of the linear $\kappa$-approximate problem (3.1). In addition, it is easy to see that the solution $\left(u^{\kappa}, \eta^{\kappa}, q^{\kappa}\right) \in \mathbb{S}_{T}$ by further using Propositions 3.1 and 3.3.

Noting that the local time $T_{1}$ is independent of the initial data and the local solution constructed above satisfies $\left.(u, \eta)\right|_{t=T} \in H_{\mathrm{s}}^{3} \times \underline{H_{\mathrm{s}}^{1,3}}$, thus, if $T<\alpha$, we can further extend the local solution to be a global solution defined on $\overline{I_{\alpha}}$ by finite steps; moreover the obtained global solution is the unique solution of of the linear $\kappa$-approximate problem (3.1) and belongs to $\mathbb{S}_{\alpha}$. This completes the proof of Proposition 3.4.

### 3.2. Solvability of linearized problem (3.1)

To investigate the solvability of linearized problem (3.2), we shall first $\kappa$-independent estimates of the solutions of the $\kappa$-approximate problem.

Lemma 3.2. ## Appendix A. Analytic tools

(b) Let $p=\infty$. If additionally $\partial^{\alpha} f \in C^{0}\left(\overline{I_{T}}, L_{\text {weak }}^{2}\right)$ and $D_{1}^{\tau} \partial^{\alpha} f$ is uniformly continuous in $H^{-1}$, where the multiindex $\alpha$ satisfying $|\alpha|=i$, then

\begin{equation*}
D_{1}^{\tau} \partial^{\alpha} f \rightarrow \partial^{\alpha} \partial_{1} f \text { in } C^{0}\left(\overline{I_{T}}, L_{\text {weak }}^{2}\right) \text { (some sequence). } \tag{A.8}
\end{equation*}
$$

(c) We additionally assume $f \in L_{T}^{p} H^{i}$ and $\left\{D_{1}^{-\tau} D_{1}^{\tau} f\right\}_{|\tau| \in(0,1)}$ is uniformly bounded in $L_{T}^{p} H^{i}$ with $1<p<\infty$, then (some sequence)

D_{1}^{-\tau}\left(D_{1}^{\tau} f\right) \rightharpoonup \partial_{1}^{2} f \text { weakly in } L_{T}^{p} H^{i} \text { (some sequence). } \tag{A.9}
\end{equation*}

(5) Let $\varphi=\varsigma+y$ and $\varsigma \in \mathbb{A}_{T}^{3,1 / 4}$ defined by (3.5).
(a) If $C^{0}\left(\overline{I_{T}}, H^{i}\right)$ or $f \in L_{T}^{2} H^{i}$ with $0 \leqslant i \leqslant 3$, then

F:=f(\varphi, t) \in C^{0}\left(\overline{I_{T}}, H^{i}\right) \text { or } L_{T}^{p} H^{i} \tag{A.10}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathcal{F}:=f\left(\varphi^{-1}, t\right) \in C^{0}\left(\overline{I_{T}}, H^{i}\right) \text { or } L_{T}^{p} H^{i} . \tag{A.11}
\end{equation*}
$$

Moreover,

\begin{align*}
\|F\|_{L_{T}^{p} H^{i}} & \lesssim P\left(\|\varsigma\|_{L_{T}^{\infty} H^{3}}\right)\|f\|_{L_{T}^{p} H^{i}},  \tag{A.12}\\
\|\mathcal{F}\|_{L_{T}^{p} H^{i}} & \lesssim P\left(\|\varsigma\|_{L_{T}^{\infty} H^{3}}\right)\|f\|_{L_{T}^{p} H^{i}} . \tag{A.13}
\end{align*}

(b) If $\varsigma$ additionally satisfies $\varsigma_{t} \in L_{T}^{\infty} H^{2}$, then for any $f$ satisfying $f \in L^{p}\left(I_{T}, H^{i}\right)$ and $f_{t} \in L^{p}\left(I_{T}, H^{i-1}\right)$, where $1 \leqslant i \leqslant 3$, then

F_{t}=\left.\left(f_{t}(x, t)+\varsigma_{t} \cdot \nabla f(y, t)\right)\right|_{x=\varphi} \in L_{T}^{p} H^{i-1}
$$

and

$$
\mathcal{F}_{t}=\left.\left(f_{t}(y, t)-(\nabla \varphi)^{-1} \varsigma_{t} \cdot \nabla f(y, t)\right)\right|_{y=\varphi^{-1}} \in L_{T}^{p} H^{i-1}
$$

Proof. Please refer to [20, Lemma A.10] for the proof.
Lemma A.6. Elliptic estimates for Neumann boundary-value problem: Let $i \geqslant 2$ be an integer. We further assume $A$ is a $3 \times 3$ matrix function, each element of which belongs to $W^{i-1, \infty}(\Omega)$, and satisfies positivity condition, i.e., there exists a positive constant $\theta$ such that $(A \xi) \cdot \xi \geqslant \theta|\xi|$ for a.e. $y \in \Omega$ and all $\xi \in \mathbb{R}^{3}$. If $f_{1} \in H^{i-2}$ and $f_{2} \in H^{i-1}$ satisfy the following compatibility condition

$$
\begin{equation*}
\int f_{1} \mathrm{~d} y+\int_{\partial \Omega} f_{2} \overrightarrow{\mathbf{n}}_{3} \mathrm{~d} y_{\mathrm{h}}=0 \tag{A.14}
\end{equation*}
$$

where $\overrightarrow{\mathbf{n}}_{3}$ denotes the outward unit normal vector $\overrightarrow{\mathbf{n}}$ on the boundary $\partial \Omega$, there exists a unique strong solution $p \in \underline{H}^{j}$ to the Neumann boundary-value problem of elliptic equations:

\begin{cases}-\operatorname{div}(A \nabla p)=f_{1} & \text { in } \Omega  \tag{A.15}\\ A_{3 k} \partial_{k} p=f_{2} & \text { on } \partial \Omega\end{cases}
$$

Moreover p satisfies

\|p\|_{i} \lesssim\left(1+\|A\|_{W^{i-1, \infty}(\Omega)}\right)\left(\left\|f_{1}\right\|_{i-2}+\left\|f_{2}\right\|_{i-1}\right) \tag{A.16}
\end{equation*}
$$
