# THE REPETENDS OF REDUCED FRACTIONS a/b ${ }^{k}$ APPROACH FULL COMPLEXITY WITH AN INCREASING $k$

#### Abstract

In this paper, we prove a criterion for complexity in $g$-ary expansions of a rational fraction $a / b<1$ with $\operatorname{gcd}(a, b)=1$. We prove that for any purely periodic proper fraction $a / b$ and all $j \geq 1$, each sequence of $j$ digits occurs in the $g$-ary repetend of $a / b^{k}$ with a relative frequency that approaches $1 / g^{j}$ with an increasing $k$. The absolute frequencies can be calculated by means of a simple transition matrix. Let $\left(a_{k}\right)$ be a sequence of positive integers relatively prime to $b$. We prove that each sequence of $j$ digits occurs in the $g$-ary repetend of $a_{k} / b^{k}$ with a relative frequency that approaches $1 / g^{j}$ with an increasing $k$, unless all prime factors of $b$ divide the base $g \geq 2$.


## 1. Introduction

A proper fraction is a rational number $a / b \in \mathbb{Q}$ such that $0<a / b<1$, where $a \in \mathbb{N}$, $b \in \mathbb{N} \backslash\{1\}$, and $\operatorname{gcd}(a, b)=1$. Let $g \geq 2$ be a positive integer. Any proper fraction $a / b$ with a denominator $b$ relatively prime to $g$ has a unique $g$-ary expansion

$$
a / b=x_{1} g^{-1}+x_{2} g^{-2}+x_{3} g^{-3}+\cdots,
$$

where the digits $x_{i}$ for $i \in \mathbb{N}$ belong to the set $\{0,1, \ldots, g-1\}$. We write this expansion

$$
\text { 0. } x_{1} x_{2} x_{3} \cdots .
$$

This $g$-ary expansion is purely periodic since $\operatorname{gcd}(b, g)=1$. The smallest positive integer $n \in \mathbb{N}$ such that $x_{i}=x_{i+n}$ for all $\mathrm{i} \in \mathbb{N}$ is the period, and the word $x_{1} x_{2} \cdots x_{n}$ is the repetend of the expansion.

[^0]Conversely, a purely periodic $g$-ary expansion $0 . x_{1} x_{2} x_{3} \cdots$ represents a proper fraction $a / b$ with a denominator $b$ relatively prime to $g$, with the only exceptions $0=0.000 \cdots$ and $1=0 .(g-1)(g-1)(g-1) \cdots$.
The period of a purely periodic proper fraction $a / b$ is given by

$$
\operatorname{ord}_{g}(b):=\min \left\{n \in \mathbb{N} \mid g^{n} \equiv 1 \quad(\bmod b)\right\} .^{2}
$$

Definition 1. (Lothaire [5]). A word $f$ is called a factor of a word $x$ if there exist words $u, v$ such that $x=u f v$.

Definition 2. Let $j \geq 1$ be a positive integer. The enlarged repetend of a purely periodic proper fraction $a / b$ is the finite word

$$
F_{g}\left(\frac{a}{b}, j\right):=\left(x_{1} x_{2} \cdots x_{\operatorname{ord}_{g}(b)}\right)\left(x_{1} x_{2} \cdots x_{j-1}\right)
$$

For $j=1$, the second factor is the empty word.
Since the $g$-ary expansion is purely periodic, any factor (subword) of length $j$ in the expansion is already a factor of $F_{g}(a / b, j)$.

Definition 3. A word of length $j \geq 1$ is called a $j$-word. The $j$-word at $i$ is the word

$$
x_{i-j+1} x_{i-j+2} \cdots x_{i}, \quad \text { where } 1 \leq j \leq i
$$

The sequence of $j$-words at $i$ in the $g$-ary expansion of the purely periodic proper fraction $a / b$ is the sequence

$$
\left(x_{i-j+1} x_{i-j+2} \cdots x_{i}\right)_{i=j}^{\infty} .
$$

However, any of its $j$-words can already be found in the finite sequence

$$
S_{g}\left(\frac{a}{b}, j\right):=\left(x_{i-j+1} x_{i-j+2} \cdots x_{i}\right)_{i=j}^{\operatorname{ord}_{g}(b)+j-1}
$$

Each $j$-word of $S_{g}(a / b, j)$ can be interpreted as a base $g$ integer with $j$ digits:

$$
x_{i-j+1} x_{i-j+2} \cdots x_{i}=x_{i-j+1} g^{j-1}+x_{i-j+2} g^{j-2}+\cdots+x_{i} g^{0}
$$

where $x_{i}$ is the least significant digit and where the leading digits are allowed to be zeros.

It is convenient to use base 10 numbers when referring to $j$-words of $S_{g}(a / b, j)$. Each $j$-word receives a list number $s$ from 0 to $g^{j}-1$ which is its value when read as a base $g$ integer. The $j$-word at $i$ receives the list number

$$
s=\sum_{m=0}^{j-1} x_{i-m} g^{m}
$$

[^1]For instance, if $g=2$ and $j=3$, the list number of the word 110 is 6 , and the list number of 011 is 3 .

We denote the set of list numbers by

$$
J_{g}:=\left\{0,1, \ldots, g^{j}-1\right\} .
$$

Throughout this paper we shall use the letter $s$ to represent either $j$-words or their respective list numbers. When translating a list number back into a word, we take care of eventually leading zeros. For instance, if $g=2$ and $j=4$, the list number 5 is the word 0101.

The absolute frequency $\nu(s)^{3}$ is a function

$$
\nu: J_{g} \longmapsto \mathbb{N} \cup\{0\}
$$

that counts the number of times a $j$-word with list number $s \in J_{g}$ occurs as a factor in the enlarged repetend $F_{g}(a / b, j)$. There are exactly $\operatorname{ord}_{g}(b)$ factors of length $j$ in $F_{g}(a / b, j)$ and therefore,

$$
\sum_{s \in J_{g}} \nu(s)=\operatorname{ord}_{g}(b)
$$

The oscillation of absolute frequencies is a nonnegative integer defined by

$$
\sigma_{g}(a / b, j):=\max \left\{\left|\nu(s)-\nu\left(s^{\prime}\right)\right| \mid s, s^{\prime} \in J_{g}\right\}
$$

The relative frequency of a $j$-word in $F_{g}(a / b, j)$ is defined by

$$
\nu_{\mathrm{rel}}(s):=\frac{\nu(s)}{\operatorname{ord}_{g}(b)}
$$

Of course,

$$
\sum_{s \in J_{g}} \nu_{\mathrm{rel}}(s)=1
$$

Definition 4. Let $x_{1} x_{2} x_{3} \cdots$ be the binary expansion of $x$. The complexity function of $x$ counts the number $P(x, m)$ of different factors of length $m$ in $x$ for each nonnegative integer $m \geq 0$.

The number $P(x, 1)$ counts the different letters appearing in $x$. In our case, the alphabet is $\{0,1\}$, so if $x$ is nonperiodic, $P(x, 1)=2$. On the other hand, if $x$ is purely periodic with a repetend of length $m$, we have $P(x, m)=m$.

In a former paper [4], we studied the effect of successive divisions by 3 on the complexity of the binary expansion of $1 / 3^{k}$. We generalize these results for all reduced fractions of the form $a / b^{k}$ in any integer base $g \geq 2$.

[^2]Following Waldschmidt [12], a real number $\xi$ is called simply normal in base $g$ if each digit occurs with (well-defined limiting relative) frequency $1 / g$ in its $g$-ary expansion. Furthermore, a real number $\xi$ is called normal in base $g$ if it is simply normal in base $g^{j}$ for all $j \geq 1$. Hence a real number $\xi$ is normal in base $g$ if and only if, for all $j \geq 1$, each sequence of $j$ digits occurs with (limiting relative) frequency $1 / g^{j}$ in its $g$-ary expansion.

Our issue is far simpler. The fractions have an eventually periodic $g$-ary expansion. Nevertheless, we borrow the concept of normality for our purpose since it describes exactly the digits structure of an increasingly long repetend under successive divisions by $b$. With an increasing $k$, larger than an initial constant $c_{g}(b)$, which depends only on $b$ and $g$, the $g$-ary period $\operatorname{ord}_{g}\left(b^{k}\right)$ is strictly increasing unless all prime factors of $b$ divide $g$.

We prove that for any purely periodic proper fraction $a / b$ and all $j \geq 1$, each sequence of $j$ digits occurs in the $g$-ary repetend of $a / b^{k}$ with a relative frequency that approaches $1 / g^{j}$ with an increasing $k$ (Theorem 2). This proof is given in Sections 2 and 4.

Also, in Section 2, we prove that the set of (distinct) $j$-words in $F_{g}\left(a / b^{k+t}, j\right)$ is completely determined by the corresponding set of $j$-words in $F_{g}\left(a / b^{k}, j\right)$ for all sufficiently large $k$ and $t \in \mathbb{N}$ (Proposition 1). Next, in Section 3, we prove a criterion for complexity in g-ary expansions of rational fractions (Theorem 1). Further, in Section 4, we show that the absolute frequencies can be calculated by means of a simple transition matrix (Proposition 2 and Example 1), which guarantees that the oscillation of absolute frequencies of $j$-words in $F_{g}\left(a / b^{k}, j\right)$ is bounded for all $k \in \mathbb{N}$ (Proposition 5 and Example 2). Finally, in Section 5, we generalize Theorem 2 for all reduced fractions of the form $a_{k} / b^{k}$ (Proposition 7 and Theorem 3).

## 2. Sequences of Words and Remainders

Lemma 1. Let 0. $x_{1} x_{2} \cdots$ be the g-ary expansion of a purely periodic proper fraction $a / b$. For all $i \in \mathbb{N}$, the quotient $q_{i}=\left\lfloor a g^{i} / b\right\rfloor$ is the $g$-ary integer $q_{i}=x_{1} x_{2} \cdots x_{i}$.

Proof. (a) We have $a / b=x_{1} g^{-1}+x_{2} g^{-2}+\cdots$. Thus

$$
\begin{aligned}
\frac{a g^{i}}{b} & =x_{1} g^{i-1}+x_{2} g^{i-2}+x_{3} g^{i-3}+\cdots+x_{i} g^{i-i}+x_{i+1} 3 g^{i-(i+1)}+\cdots \\
& <x_{1} g^{i-1}+x_{2} g^{i-2}+\cdots+x_{i} g^{i-i}+(g-1) g^{-1}+(g-1) g^{-2}+\cdots \\
& =x_{1} g^{i-1}+x_{2} g^{i-2}+\cdots+x_{i} g^{0}+1
\end{aligned}
$$

imply that

$$
q_{i}=\left\lfloor\frac{a g^{i}}{b}\right\rfloor
$$

Hence $q_{i}=x_{1} x_{2} \cdots x_{i}$.
Lemma 2. The sequence of $j$-words at $i$ in the enlarged $g$-ary repetend $F_{g}(a / b, j)$ of a purely periodic proper fraction is given by the following sequence of list numbers:

$$
S_{g}\left(\frac{a}{b}, j\right)=\left(\left\lfloor\frac{a g^{i}}{b}\right\rfloor \bmod g^{j}\right)_{i=j}^{\operatorname{ord}_{g}(b)+j-1}
$$

Proof. By Lemma 1, the integer quotient $q_{i}=\left\lfloor a g^{i} / b\right\rfloor$ is the $g$-ary integer $x_{1} x_{2} \cdots x_{i}$. If $i \geq j$, then

$$
\left(x_{1} x_{2} \cdots x_{i}\right) \bmod g^{j}=x_{i-j+1} x_{i-j+2} \cdots x_{i} .
$$

Note that $S_{g}(a / b, 1)$ is the repetend of $a / b$.
For a fixed $b \neq 1$ relatively prime to $g$, the set of purely periodic proper fractions with denominator $b$ splits in exactly $\varphi(b) / \operatorname{ord}_{g}(b)$ equivalence classes, where $\varphi$ is Euler's totient function: any two of these fractions are $g$-equivalent if their numerators belong to the same coset of the cyclic subgroup $D \subset(\mathbb{Z} / b \mathbb{Z})^{\times}$generated by $g$ modulo $b$. Indeed, each numerator $a$ relatively prime to $b$ defines the coset

$$
a D=\left\{a g^{i} \mid a \in(\mathbb{Z} / b \mathbb{Z})^{\times}, g^{i} \in D \quad \text { for all } i \in\left\{1,2, \ldots, \operatorname{ord}_{g}(b)\right\}\right\} .
$$

We define the rotate left operator $\rho$ by

$$
\rho\left(s_{1} s_{2} s_{3} \cdots s_{t}\right):=s_{2} s_{3} \cdots s_{t} s_{1}
$$

The following lemma shows that $g$-equivalent purely periodic proper fractions have up to successive left rotations the same $j$-words in the enlarged repetend.

Lemma 3. Let $a / b$ be a purely periodic proper fraction and $j, n \in \mathbb{N}$. Then we have

$$
S_{g}\left(\frac{\left(a g^{n}\right) \bmod b}{b}, j\right)=\rho^{n}\left(S_{g}\left(\frac{a}{b}, j\right)\right) .
$$

Proof. For $n=1$, we have $a / b=x_{1} x_{2} \cdots$. Hence $a g / b=x_{1} \cdot x_{2} x_{3} \cdots$. Therefore,

$$
\frac{(a g) \bmod b}{b}=0 . x_{2} x_{3} \cdots .
$$

By comparing the two sequences

$$
\begin{aligned}
S_{g}(a / b, j) & =\left(x_{1} x_{2} \cdots x_{j}, x_{2} x_{3} \cdots x_{j+1}, \ldots, x_{\operatorname{ord}_{g}(b)} x_{1} x_{2} \cdots x_{j-1}\right) \\
S_{g}(((a g) \bmod b) / b, j) & =\left(x_{2} x_{3} \cdots x_{j+1}, \ldots, x_{\operatorname{ord}_{g}(b)} x_{1} x_{2} \cdots x_{j-1}, x_{1} x_{2} \cdots x_{j}\right)
\end{aligned}
$$

we get the statement for $n=1$. For any other $n \in\left\{2,3, \ldots, \operatorname{ord}_{g}(b)\right\}$ a similar argument holds by comparing the following expansions:

$$
\begin{aligned}
\left(\left(a g^{n-1}\right) \bmod b\right) / b & =0 \cdot x_{n} x_{n+1} \cdots \\
\left(\left(a g^{n}\right) \bmod b\right) / b & =0 \cdot x_{n+1} x_{n+2} \cdots
\end{aligned}
$$

Lemma 4. Let $a / b$ be a purely periodic proper fraction, $i \in \mathbb{N}, j \in \mathbb{N}$ and $r_{i}:=$ $\left(a g^{i}\right) \bmod b$. For all $i \geq j$, the $(i-j)$-th remainder

$$
r_{i-j}:=\left(a g^{i-j}\right) \bmod b
$$

of the long division $a$ by $b$ determines the list number $s_{i}$ of the $j$-word at $i$ by the equation

$$
r_{i-j} \frac{g^{j}}{b}=s_{i}+\frac{r_{i}}{b},
$$

and consequently,

$$
\left\lfloor r_{i-j} \frac{g^{j}}{b}\right\rfloor=s_{i} .
$$

Proof. For $i \geq j$, let

$$
\begin{align*}
a g^{i} & =q_{i} b+r_{i} \quad\left(0<r_{i}<b\right)  \tag{1}\\
a g^{i-j} & =q_{i-j} b+r_{i-j} \quad\left(0<r_{i-j}<b\right)  \tag{2}\\
q_{i} & =c_{i} g^{j}+s_{i} \quad\left(0<s_{i}<g^{j}\right) . \tag{3}
\end{align*}
$$

Note that $r_{0} \equiv a \bmod b=a$ by Equation (2), hence $r_{0}=a$.
By Lemma 2 and Equation (1), $s_{i}$ is the list number of the $j$-word at $i$. We multiply Equation (2) by $g^{j}$ and substitute this expression together with Equation (3) into Equation (1). We get

$$
\begin{equation*}
g^{j}\left(q_{i-j} b+r_{i-j}\right)=\left(c_{i} g^{j}+s_{i}\right) b+r_{i} . \tag{4}
\end{equation*}
$$

Furthermore, for $i>j$, we have the $g$-ary integers

$$
\begin{aligned}
q_{i-j} g^{j} & =x_{1} x_{2} \cdots x_{i-j} 00 \cdots 0 \quad(j \text { zeros }) \\
s_{i} & =x_{i-j+1} x_{i-j+2} \cdots x_{i}
\end{aligned}
$$

Hence $q_{i-j} g^{j}+s_{i}=x_{1} x_{2} \cdots x_{i}=q_{i}$. Comparing this expression with Equation (3), we get

$$
\begin{equation*}
c_{i}=q_{i-j} \tag{5}
\end{equation*}
$$

This is even true for $i=j$, having now the $g$-ary integers

$$
\begin{aligned}
q_{i-j} g^{j} & =00 \cdots 0 \quad(j \text { zeros }) \\
s_{i} & =x_{1} x_{2} \cdots x_{j}
\end{aligned}
$$

since $q_{i-j}=q_{0}=0$ by Equation (2).
Finally, we substitute Equation (5) into Equation (4). After dividing by b, we obtain the claimed relation.

Lemma 5. Let $a / b$ be a purely periodic proper fraction and $j \in \mathbb{N}$. The remainders of the sequence

$$
R_{g}\left(\frac{a}{b}, j\right):=\left(\left(a g^{i-j}\right) \bmod b\right)_{i=j}^{\operatorname{ord}_{g}(b)+j-1}
$$

are all different from each other.
Proof. Let

$$
R=\left(\left(a g^{i}\right) \bmod b\right)_{i=0}^{\operatorname{ord}_{g}(b)-1}
$$

Of course, $R_{g}(a / b, j)$ and $R$ are the same sequence. The sequence $R$ gives the successive remainders of the long division $a$ by $b$, and $\operatorname{ord}_{g}(b)$ is the period of the $g$-ary expansion.

Lemma 6. Let $b>1$ be an integer relatively prime to $g \geq 2$ and $k \in \mathbb{N}$. Define

$$
h:=\frac{g^{\operatorname{ord}_{g}\left(b^{k}\right)}-1}{b^{k}}
$$

If $d=\operatorname{gcd}(h, b)$, then $\operatorname{ord}_{g}\left(b^{k+1}\right)=\frac{b}{d} \operatorname{ord}_{g}\left(b^{k}\right)$.
Proof. The integer $h$ is well-defined since

$$
g^{\operatorname{ord}_{g}\left(b^{k}\right)} \equiv 1 \quad\left(\bmod b^{k}\right)
$$

We consider two cases.
(a) If $b=d$, then

$$
g^{\operatorname{ord}_{g}\left(b^{k}\right)}-1=h b^{k}=n b^{k+1} \quad \text { for some } n \in \mathbb{N} .
$$

Thus

$$
g^{\operatorname{ord}_{g}\left(b^{k}\right)} \equiv 1 \quad\left(\bmod b^{k+1}\right)
$$

implying that $\operatorname{ord}_{g}\left(b^{k}\right)$ is a multiple of $\operatorname{ord}_{g}\left(b^{k+1}\right)$. However, $\operatorname{ord}_{g}\left(b^{k+1}\right)$ is a multiple of $\operatorname{ord}_{g}\left(b^{k}\right)$ since

$$
g^{\operatorname{ord}_{g}\left(b^{k+1}\right)} \equiv 1 \quad\left(\bmod b^{k+1}\right) \quad \text { implies that } \quad g^{\operatorname{ord}_{g}\left(b^{k+1}\right)} \equiv 1 \quad\left(\bmod b^{k}\right)
$$

Hence $\operatorname{ord}_{g}\left(b^{k+1}\right)=\operatorname{ord}_{g}\left(b^{k}\right)$.
(b) If

$$
g^{n \cdot \operatorname{ord}_{g}\left(b^{k}\right)} \equiv 1 \quad\left(\bmod b^{k+1}\right)
$$

for some integer $n>1$, then we get ${ }^{4}$

$$
g^{n \cdot \operatorname{ord}_{g}\left(b^{k}\right)}=1+n\left(h b^{k}\right)+\mathbf{O}\left(h b^{k+1}\right)
$$

[^3]by raising both sides of
$$
g^{\operatorname{ord}_{g}\left(b^{k}\right)}=1+h b^{k}
$$
to the $n$-th power. It follows that $b^{k+1}$ must divide $n h b^{k}$. So we have
$$
b \mid n h \quad \text { and } \quad \operatorname{gcd}(h, b)=d
$$

Hence $b / d$ divides $n$. The smallest of such $n$ is $n=b / d$ and furthermore,

$$
g^{\frac{b}{d} \operatorname{ord}_{g}\left(b^{k}\right)} \equiv 1 \quad\left(\bmod b^{k+1}\right)
$$

since

$$
\frac{b}{d} h b^{k}=\frac{h}{d} b^{k+1}
$$

is an integer divisible by $b^{k+1}$.
The following lemma about the period of $a / b^{k}$ in base $g \geq 2$ is well-known. A sketched proof for $g=10$ can be found in Wikipedia. ${ }^{5}$

Lemma 7. Let $b>1$ be an integer relatively prime to $g \geq 2$. There is some $c \in \mathbb{N}$ such that

$$
\operatorname{ord}_{g}\left(b^{c+t}\right)=b^{t} \operatorname{ord}_{g}\left(b^{c}\right)
$$

for all positive integers $t$.
Proof. The assertion follows from a lemma of Korobov [9], available as Lemma 4.3 in Bailey and Crandall [1].

Definition 5. Let $b>1$ be an integer relatively prime to $g \geq 2$. The integer $c_{g}(b)$ denotes the smallest $c \in \mathbb{N}$ satisfying Lemma 7 ; that is,

$$
c_{g}(b):=\min \left\{c \in \mathbb{N} \mid \operatorname{ord}_{g}\left(b^{c+t}\right)=b^{t} \operatorname{ord}_{g}\left(b^{c}\right) \quad \text { for all } t \in \mathbb{N}\right\}
$$

Lemma 8. Let $a / b^{k}$ be a purely periodic proper fraction and $k \geq c_{g}(b)$. The remainders $r_{v}^{\prime}$ in the sequence

$$
R_{g}\left(\frac{a}{b^{k+1}}, j\right)=\left(\left(a g^{v}\right) \bmod b^{k+1}\right)_{v=0}^{\operatorname{ord}_{g}\left(b^{k+1}\right)-1}
$$

have the form

$$
r_{v}^{\prime}=r_{i+m \cdot \operatorname{ord}_{g}\left(b^{k}\right)}=r_{i}+n b^{k} \quad(m, n \in\{0,1, \ldots, b-1\})
$$

where $r_{i} \in R_{g}\left(a / b^{k}, j\right)$. This representation is unique.

Table 1: Function $c_{g}(b)$ (Definition 5) for $g \in\{2,3,5,7,10\}, 2 \leq b \leq 100$ and $\operatorname{gcd}(g, b)=1$.

Proof. (a) By Lemma 7,

$$
\begin{equation*}
h=\frac{g^{\operatorname{ord}_{g}\left(b^{k}\right)}-1}{b^{k}} \tag{6}
\end{equation*}
$$

is relatively prime to $b$ since $k \geq c_{g}(b)$ and $\operatorname{ord}_{g}\left(b^{k+1}\right)=b \operatorname{ord}_{g}\left(b^{k}\right)$.
(b) For $0 \leq i<\operatorname{ord}_{g}\left(b^{k}\right)$, we have

$$
\begin{align*}
a g^{i} & =q_{i} b^{k}+r_{i} \quad\left(0<r_{i}<b^{k}\right) \\
a g^{i} & =q_{i}^{\prime} b^{k+1}+r_{i}^{\prime} \quad\left(0<r_{i}^{\prime}<b^{k+1}\right) \tag{7}
\end{align*}
$$

We write $a g^{i}$ as a $b$-adic sum; that is,

$$
a g^{i}=y_{0} b^{0}+y_{1} b^{1}+\cdots+y_{k} b^{k}+\cdots,
$$

where the $y$ 's belong to the set $\{0,1, \ldots, b-1\}$. Of course, only finitely many terms in this sum are not equal to zero. ${ }^{6}$ So we have

$$
\begin{aligned}
r_{i} & \equiv\left(a g^{i}\right) \bmod b^{k}=y_{0} b^{0}+\cdots+y_{k-1} b^{k-1} \\
r_{i}^{\prime} & \equiv\left(a g^{i}\right) \bmod b^{k+1}=y_{0} b^{0}+\cdots+y_{k-1} b^{k-1}+y_{k} b^{k}
\end{aligned}
$$

Hence

$$
\begin{equation*}
r_{i}^{\prime}=r_{i}+y_{k} b^{k} . \tag{8}
\end{equation*}
$$

(c) Applying Equations (6), (7) and (8), we get

$$
\begin{aligned}
a g^{i+\operatorname{ord}_{g}\left(b^{k}\right)} & =\left(q_{i}^{\prime} b^{k+1}+r_{i}+y_{k} b^{k}\right)\left(h b^{k}+1\right) \\
& =r_{i}+\left(r_{i} h+y_{k}\right) b^{k}+\mathbf{O}\left(b^{k+1}\right)
\end{aligned}
$$

We substitute $r_{i} h+y_{k}$ with the $b$-adic sum

$$
r_{i} h+y_{k}:=z_{0} b^{0}+z_{1} b^{1}+\cdots \quad\left(z_{i} \in\{0,1, \ldots, b-1\}\right)
$$

Since $z_{0} \equiv\left(r_{i} h+y_{k}\right) \bmod b$ we get

$$
a g^{i+\operatorname{ord}_{g}\left(b^{k}\right)}=r_{i}+\left(\left(r_{i} h+y_{k}\right) \bmod b\right) b^{k}+\mathbf{O}\left(b^{k+1}\right)
$$

Hence

$$
\begin{equation*}
r_{i+\operatorname{ord}_{g}\left(b^{k}\right)}^{\prime}=r_{i}+\left(\left(r_{i} h+y_{k}\right) \bmod b\right) b^{k} \tag{9}
\end{equation*}
$$

(d) The method used in (b) and (c) leads to the following generalization of Equations (8) and (9):

$$
\begin{equation*}
r_{i+m \cdot \operatorname{ord}_{g}\left(b^{k}\right)}^{\prime}=r_{i}+\left(\left(m r_{i} h+y_{k}\right) \bmod b\right) b^{k} \tag{10}
\end{equation*}
$$

for all $m \in\{0,1, \ldots, b-1\}$.
The integers $r_{i}$ and $h$ are relatively prime to $b$ and therefore,

$$
\left(\left(m r_{i} h+y_{k}\right) \bmod b\right)_{m=0}^{b-1}
$$

is a permutation of $(0,1, \cdots, b-1)$. It follows that there are $b \cdot \operatorname{ord}_{g}\left(b^{k}\right)$ integers on both sides of (10). The remainders on the left are all different from each other by Lemma 5.

[^5]Lemma 9. Let $a / b^{k}$ be a purely periodic proper fraction, $t \in \mathbb{N}$ and $k \geq c_{g}(b)$. The remainders $r_{v}^{\prime}$ in the sequence

$$
R_{g}\left(\frac{a}{b^{k+t}}, j\right)=\left(\left(a g^{v}\right) \bmod b^{k+t}\right)_{v=0}^{\operatorname{ord}_{g}\left(b^{k+t}\right)-1}
$$

have the form

$$
r_{v}^{\prime}=r_{i+m \cdot \operatorname{ord}_{g}\left(b^{k}\right)}=r_{i}+n b^{k} \quad\left(m, n \in\left\{0,1, \ldots, b^{t}-1\right\}\right)
$$

where $r_{i} \in R_{g}\left(a / b^{k}, j\right)$. This representation is unique.
Proof. Since $k \geq c_{g}(b)$ we have $\operatorname{ord}_{g}\left(b^{k+t}\right)=b^{t} \operatorname{ord}_{g}\left(b^{k}\right)$. We apply Lemma 8 successively. The exponent in the brackets of $i^{(k)}$ denotes the level at which the index $i$ is taken. For instance, the statement of Lemma 8 now looks like this:

v:=i^{(k+1)}=i^{(k)}+m_{0} \cdot \operatorname{ord}_{g}\left(b^{k}\right) \quad\left(0 \leq i^{(k)}<\operatorname{ord}_{g}\left(b^{k}\right) ; 0 \leq m_{0}<b\right)
$$

and

$$
r_{i(k)+m_{0} \cdot \operatorname{ord}_{g}\left(b^{k}\right)}=r_{i(k)}+n_{0} b^{k} \quad\left(m_{0}, n_{0} \in\{0,1, \ldots, b-1\}\right),
$$

where $r_{i^{(k)}} \in R_{g}\left(a / b^{k}, j\right)$.
For the index $i^{(k+t)}$, we get the following:

$$
\begin{aligned}
& i^{(k+2)}=i^{(k+1)}+m_{1} \cdot \operatorname{ord}_{g}\left(b^{k+1}\right) \quad\left(0 \leq i^{(k+1)}<b \cdot \operatorname{ord}_{g}\left(b^{k}\right) ; 0 \leq m_{1}<b\right) \\
&=i^{(k)}+\left(m_{0}+m_{1} b\right) \cdot \operatorname{ord}_{g}\left(b^{k}\right) \\
& i^{(k+3)}=i^{(k+2)}+m_{2} \cdot \operatorname{ord}_{g}\left(b^{k+2}\right) \quad\left(0 \leq i^{(k+2)}<b^{2} \cdot \operatorname{ord}_{g}\left(b^{k}\right) ; 0 \leq m_{2}<b\right) \\
&=i^{(k)}+\left(m_{0}+m_{1} b+m_{2} b^{2}\right) \cdot \operatorname{ord}_{g}\left(b^{k}\right) \\
& \vdots \\
& i^{(k+t)}=i^{(k)}+\left(\sum_{x=0}^{t-1} m_{x} b^{x}\right) \operatorname{ord}_{g}\left(b^{k}\right) \quad\left(0 \leq i^{(k+t-1)}<b^{t-1} \cdot \operatorname{ord}_{g}\left(b^{k}\right) ; 0 \leq m_{x}<b\right)
\end{aligned}
$$

Let $m:=\sum_{x=0}^{t-1} m_{x} b^{x}$. Then we have $0 \leq m \leq b^{t}-1$ since this $b$-adic sum yields exactly $t$ different nonnegative integers less than $b^{t}$.

For the remainder $r_{i^{(k+t)}}$, we get the following:

$$
\begin{aligned}
r_{i^{(k+1)}} & =r_{i^{(k)}}+n_{0} b^{k} \quad\left(0 \leq n_{0}<b\right) \\
r_{i^{(k+2)}} & =r_{i^{(k+1)}}+n_{1} b^{k+1} \quad\left(0 \leq n_{1}<b\right) \\
& =r_{i^{(k)}}+\left(n_{0}+n_{1} b\right) b^{k} \\
& \vdots \\
r_{i^{(k+t)}} & =r_{i^{(k)}}+\left(\sum_{x=0}^{t-1} n_{x} b^{x}\right) b^{k} \quad\left(0 \leq n_{x}<b\right) .
\end{aligned}
$$

Hence $n:=\sum_{x=0}^{t-1} n_{x} b^{x}$ is the claimed $n$.

Definition 6. Let $X_{g}\left(a / b^{k}, j\right)$ denote the set of (distinct) list numbers of $j$-words occurring in the enlarged $g$-ary repetend $F_{g}\left(a / b^{k}, j\right)$.

Proposition 1. Let $a / b^{k}$ be a purely periodic proper fraction, $k \geq c_{g}(b)$ and $j, t \in \mathbb{N}$. We have

$$
X_{g}\left(\frac{a}{b^{k+t}}, j\right)=\left\{\left.\left(\frac{1}{b^{t}}(s-n)\right) \bmod g^{j} \right\rvert\, s \in X_{g}\left(\frac{a}{b^{k}}, j\right) \text { and } n \in\left\{0,1, \ldots, b^{t}-1\right\}\right\}
$$

where $c_{g}(b)$ is the integer of Definition 5.
Proof. Let

$$
\begin{aligned}
R_{g}\left(\frac{a}{b^{k+t}}, j\right) & =\left(\left(a g^{v-j}\right) \bmod b^{k+t}\right)_{v=j}^{\operatorname{ord}_{g}\left(b^{k+t}\right)+j-1} \\
R_{g}\left(\frac{a}{b^{k}}, j\right) & =\left(\left(a g^{i-j}\right) \bmod b^{k}\right)_{i=j}^{\operatorname{ord}_{g}\left(b^{k}\right)+j-1}
\end{aligned}
$$

Of course, the first sequence is the same sequence as in Lemma 9, and the second one is given in Lemma 5.

Each $r_{v}^{\prime} \in R_{g}\left(a / b^{k+t}, j\right)$ has the form

$$
\begin{equation*}
r_{v}^{\prime}=r_{i-j}+n b^{k} \tag{11}
\end{equation*}
$$

where $v=i-j+m \cdot \operatorname{ord}_{g}\left(b^{k}\right), j \leq i \leq \operatorname{ord}_{g}\left(b^{k}\right)+j-1$ and $m, n \in\left\{0,1, \ldots, b^{t}-1\right\}$.
By Lemma 4, we have

$$
r_{v-j}^{\prime} \frac{g^{j}}{b^{k+t}}=s_{v}^{\prime}+\frac{r_{v}^{\prime}}{b^{k+t}} \quad\left(s_{v}^{\prime} \in S_{g}\left(a / b^{k+t}, j\right)\right)
$$

Hence

$$
\begin{equation*}
-\frac{1}{b^{k+t}} r_{v}^{\prime} \equiv s_{v}^{\prime} \quad\left(\bmod g^{j}\right) \tag{12}
\end{equation*}
$$

Equations (11) and (12) yield

$$
-\frac{1}{b^{k+t}}\left(r_{i-j}+n b^{k}\right) \equiv s_{v}^{\prime} \quad\left(\bmod g^{j}\right)
$$

But by Lemma 4,

$$
-\frac{1}{b^{k}} r_{i-j} \equiv s_{i-j} \quad\left(\bmod g^{j}\right) \quad\left(s_{i-j} \in S_{g}\left(a / b^{k}, j\right)\right)
$$

and therefore,

$$
\begin{equation*}
\frac{1}{b^{t}}\left(s_{i-j}-n\right) \equiv s_{v}^{\prime} \quad\left(\bmod g^{j}\right) \tag{13}
\end{equation*}
$$

For any $s_{v}^{\prime} \in S_{g}\left(a / b^{k+t}, j\right)$ - and hence for any $j$-word of $X_{g}\left(a / b^{k+t}, j\right)$ - there is a $s_{i-j} \in S_{g}\left(a / b^{k}, j\right)$ such that Equation (13) holds. Indeed, $v=i-j+m \cdot \operatorname{ord}_{g}\left(b^{k}\right)$ implies that $i-j$ is equal to $v$ modulo $^{\operatorname{ord}_{g}}\left(b^{k}\right)$.

## 3. A Criterion for Complexity

Definition 7. Let $a / b<1$ be a rational fraction in the lowest terms and $j \geq 1$. The set of $j$-words occurring in the expansion of $a / b$ is the finite set

$$
S_{R}\left(\frac{a}{b}, j\right):=\left\{\left\lfloor r_{i} g^{j} / b\right\rfloor \mid i=0,1,2, \ldots\right\}
$$

where $r_{i}$ is a power residue.
Let $a / b$ be a rational fraction in lowest terms. If

- $b=b^{\prime} \prod_{p_{i} \mid g} p_{i}^{b_{i}}$ is such that $\operatorname{gcd}\left(g, b^{\prime}\right)=1$,
- $N$ is the number of digits in the non-periodic part,
we define

$$
d r:= \begin{cases}N+1 & \text { if } b^{\prime}=1 \\ N+\operatorname{ord}_{g}\left(b^{\prime}\right) & \text { else }\end{cases}
$$

This definition guarantees that for a fixed $j \geq 1$, the words $s \in S_{R}\left(\frac{a}{b}, j\right)$ have their first digit $x_{i-j+1}$ somewhere in

$$
. x_{1} x_{2} \cdots x_{N} x_{N+1} \cdots x_{d r}
$$

and any other $j$-word in the $g$-ary expansion of $a / b$ is equal to some $s \in S_{R}\left(\frac{a}{b}, j\right)$.
Definition 8. Let $g \geq 2$ and $j \geq 1$ be fixed integers such that $0<g^{j} / b \leq 1$, and let

$$
J_{g}=\left\{0,1, \ldots, g^{j}-1\right\}, \quad B=\{0,1, \ldots, b-1\} . .^{7}
$$

For every fixed $s \in J_{g}$, we define

$$
\left.t_{s}:=\min \left\{t \in B| | t \cdot \frac{g^{j}}{b}\right\rfloor=s\right\}
$$

and say that

$$
T:=\left(\left(t_{s}\right)_{s=0}^{g^{j}-1}, b\right):=\left(t_{s}\right)_{s=0}^{g^{j}}
$$

is the master sequence.
By Lemma 16, the master sequence is well-defined. It is a strictly increasing sequence which gives the position $t_{s} \in(0,1, \ldots, b-1, b)$ of the first $s$ in a block of $\left\lceil b / g^{j}\right\rceil$ or $\left\lfloor b / g^{j}\right\rfloor$ repeating integers $s$ in $\left(\left\lfloor t g^{j} / b\right\rfloor\right)_{t=0}^{b-1}$. For all $s \in J_{g}$, we have

$$
\left\lfloor b / g^{j}\right\rfloor \leq t_{s+1}-t_{s} \leq\left\lceil b / g^{j}\right\rceil
$$

From the inequality above, and since $s=\left\lfloor r_{i-j} g^{j} / b\right\rfloor$ if and only if $t_{s} \leq r_{i-j}<$ $t_{s+1}$, with $i \geq j$, it follows that any given $j$-word $s=x_{i-j+1} \cdots x_{i}$ occurs in the first $d+j-1$ digits of the $g$-ary expansion not more than $\left\lceil b / g^{j}\right\rceil$ times. The master sequence depends on $g, b$ and $j$. Luckily, its terms can be explicitly calculated.

[^6]Lemma 10. Let $g \geq 2$ and $j \geq 1$ be fixed integers such that $0<g^{j} / b \leq 1$. The master sequence is given by

$$
\begin{aligned}
& T=\left(\frac{s b+\left(\left(s h_{1}\right) \bmod g^{j}\right)}{g^{j}}\right)_{s=0}^{g^{j}} \\
& \text { where } \quad h_{1}:=\left(\left\lceil\frac{b}{g^{j}}\right\rceil g^{j}\right) \bmod b
\end{aligned}
$$

Proof. Of course, $t_{0}=0$ and $t_{g^{j}}=b$. By Lemma 16, the number 0 occurs $\left\lceil b / g^{j}\right\rceil$ times. Therefore, $t_{1}=\left\lceil b / g^{j}\right\rceil$. Let us write

$$
t_{s} g^{j}=\left\lfloor t_{s} g^{j} / b\right\rfloor b+h_{s} \quad\left(0 \leq h_{s}<b\right)
$$

Thus

$$
t_{s} g^{j}=s b+h_{s} \quad \text { and } \quad t_{1} g^{j}=b+h_{1}
$$

But $s t_{1} g^{j}=s b+s h_{1}$ yields $h_{s} \equiv\left(s h_{1}\right) \bmod g^{j}$, and hence $t_{s} g^{j}=s b+h_{s}=$ $s b+\left(s h_{1}\right) \bmod g^{j}$.

Let us say that a $g$-ary expansion has complexity $g^{j}$ if all the $g^{j}$-words of fixed length $j \geq 1$ are factors (sub-words) of the expansion.

Lemma 11. The g-ary expansion of a rational fraction $a / b<1$ in lowest terms has complexity $g^{j}$ if and only if the following two conditions hold:

- $0<g^{j} / b \leq 1$,
- every interval $\left[t_{s}, t_{s+1}\right)$ contains some $r_{i} \in R$.

Proof. By Lemma 16, $\left\{\left\lfloor t g^{j} / b\right\rfloor \mid t \in B\right\}=J_{g}$ if and only if $0<g^{j} / b \leq 1$, and by Definition $8,\left\lfloor r_{i} g^{j} / b\right\rfloor=s$ if and only if $r_{i} \in\left[t_{s}, t_{s+1}\right)$.

Definition 9. Let $r_{0}^{\prime}<r_{1}^{\prime}<\cdots<r_{d r-1}^{\prime}$ be the sorted set of power residues $r_{i} \in R$ generated by $a g^{i} \equiv r_{i}(\bmod b)$, and let

$$
R^{\prime}:=\left(-1,\left(r_{0}^{\prime}, r_{1}^{\prime}, \ldots, r_{d r-1}^{\prime}\right), b\right)
$$

The gap of the strictly increasing sequence $R^{\prime}$ is given by

$$
G:=\max \left\{r_{i}^{\prime}-r_{i-1}^{\prime} \mid i=0,1, \ldots, d r\right\}, \quad \text { where } r_{-1}^{\prime}:=-1, r_{d r}^{\prime}:=b
$$

The function gap depends on $g, a$ and $b$, where $a / b<1$ is a rational fraction in the lowest terms. For instance, if $g=2$ and $b=43$, we have

$$
1 / 43, \text { then } R^{\prime}=\{-1,1,2,4,8,11,16,21,22,27,32,35,39,41,42,43\}, \text { thus } G=5
$$

$3 / 43$, then $R^{\prime}=\{-1,3,5,6,10,12,19,20,23,24,31,33,37,38,40,43\}$, thus $G=7$;
$7 / 43$, then $R^{\prime}=\{-1,7,9,13,14,15,17,18,25,26,28,29,30,34,36,43\}$, thus $G=8$. Since $\varphi(43)=42$ and $\operatorname{ord}_{2}(43)=14$, we have 3 classes of numerators $a$, i.e., $10 / 43$ and $3 / 43$ have the same $R^{\prime}$. If $g=2$ and $a / b=1 / 2$, then $G=1$ since $R^{\prime}=(-1,0,1,2)$.

Theorem 1. The determination of whether a g-ary expansion of a rational fraction $a / b<1$ in the lowest terms has or does not have complexity $g^{j}$ can be made with the following criterion:

$$
\begin{gathered}
\text { If }\left\lfloor b / g^{j}\right\rfloor \geq G \text {, then complexity } g^{j} ; \\
\text { If } G / 2-1<\left\lfloor b / g^{j}\right\rfloor<G \text {, then no decision yet; } \\
\text { If }\left\lfloor b / g^{j}\right\rfloor \leq G / 2-1 \text {, then no complexity } g^{j} \text {. }
\end{gathered}
$$

The determination in the second case depends on Lemma 11.
Proof. We apply Lemma 11 to the sequence $R^{\prime}$.
(a) Let $\left\lfloor b / g^{j}\right\rfloor \geq G$. The first condition of Lemma 11 is fulfilled since $G \geq 1$. Concerning the second condition, we have

$$
1 \leq r_{i}^{\prime}-r_{i-1}^{\prime} \leq G \leq\left\lfloor b / g^{j}\right\rfloor \leq t_{s+1}-t_{s} \leq\left\lceil b / g^{j}\right\rceil
$$

and therefore,

$$
r_{i}^{\prime}-r_{i-1}^{\prime} \leq t_{s+1}-t_{s} \text { for all } i=0, \ldots, d r \text { and all } s \in J_{g}
$$

We choose some fixed $s \in J_{g}$. The set $\left\{r_{i-1}^{\prime} \mid r_{i-1}^{\prime}<t_{s}\right\}$, with $i=0, \ldots, d r$, is a non-empty proper subset of $R^{\prime}$. We define $r_{k}^{\prime}:=\max \left\{r_{i-1}^{\prime} \mid r_{i-1}^{\prime}<t_{s}\right\}$. For the adjacent $r_{k+1}^{\prime} \in R^{\prime}$, the following relation holds:

$$
r_{k}^{\prime}<t_{s} \leq r_{k+1}^{\prime}<t_{s+1}
$$

Because, if we assume that $r_{k}^{\prime}<t_{s}<t_{s+1} \leq r_{k+1}^{\prime}$, then we obtain that $r_{k+1}^{\prime}-r_{k}^{\prime}>$ $t_{s+1}-t_{s}$ which is impossible. Hence $r_{k+1}^{\prime} \in\left[t_{s}, t_{s+1}\right)$.
(b) We prove that $\left\lfloor b / g^{j}\right\rfloor>G / 2-1$ is a necessary condition for $a / b$ to have complexity $g^{j}$. We assume complexity $g^{j}$ and therefore, both conditions of Lemma 11 are fulfilled.

The master sequence $\left(t_{s}\right)_{s=0}^{g^{j}}$ has at least three elements since $g \geq 2$ and $j \geq 1$, and we may write

$$
t_{s-1} \leq r_{i-1}^{\prime}<t_{s} \leq r_{i}^{\prime}<t_{s+1}
$$

It follows that $t_{s+1}-t_{s-1}>r_{i}^{\prime}-r_{i-1}^{\prime}$ and therefore,

$$
\begin{equation*}
t_{s+1}-t_{s-1}=\left(t_{s+1}-t_{s}\right)+\left(t_{s}-t_{s-1}\right)>G \quad\left(s \in J_{g}\right) \tag{14}
\end{equation*}
$$

Since $1 \leq\left\lfloor b / g^{j}\right\rfloor \leq t_{s+1}-t_{s} \leq\left\lceil b / g^{j}\right\rceil$ for all $s \in J_{g}$, the left-hand side of the inequality (14) can take only three values, namely: $2\left\lfloor b / g^{j}\right\rfloor, 2\left\lfloor b / g^{j}\right\rfloor+1$ or $2\left\lfloor b / g^{j}\right\rfloor+$ 2. The least bound for $\left\lfloor b / g^{j}\right\rfloor$ is given by $2\left\lfloor b / g^{j}\right\rfloor+2>G$, and hence $\left\lfloor b / g^{j}\right\rfloor>$ $G / 2-1 .{ }^{8}$

## 4. Frequencies and Transition Matrix

Definition 10. The frequency vector for $k \in \mathbb{N}$ is defined by

$$
V_{k}:=\left(\nu_{k}(0), \nu_{k}(1), \ldots, \nu_{k}(s), \ldots, \nu_{k}\left(g^{j}-1\right)\right)
$$

where $\nu_{k}(s)$ denotes the absolute frequency of the $j$-word $s \in J_{g}$ in the enlarged repetend $F_{g}\left(a / b^{k}, j\right)$. If $\nu_{k}(s) \neq 0$ for all $s \in J_{g}$, we say that $F_{g}\left(a / b^{k}, j\right)$ has full complexity $g^{j}$. Of course, $\sum_{s \in J_{g}} \nu_{k}(s)=\operatorname{ord}_{g}\left(b^{k}\right)$ since each of the $d i=\operatorname{ord}_{g}\left(b^{k}\right)$ digits in the period is the first digit of some $j$-word in $F_{g}\left(a / b^{k}, j\right)$.
Proposition 2. Let $a / b^{k}$ be a rational fraction in lowest terms, where $\operatorname{gcd}(g, b)=1$ and $k \geq c_{g}(b)$. Let $j \geq 1$ be a fixed integer and $t \in \mathbb{N}$. Then it holds that

$$
V_{k+t}=V_{k} \cdot W_{t}
$$

where $W_{t}=\left(w_{s, s^{\prime}}\right)$ is a $g^{j} \times g^{j}$ matrix - the transition matrix - defined by

$$
w_{s, s^{\prime}}:= \begin{cases}\left\lfloor b^{t} / g^{j}\right\rfloor+1 & \text { for all } s \text { in the sequence } \\ & \left(s^{\prime} u_{t}, s^{\prime} u_{t}+1, s^{\prime} u_{t}+2, \ldots, s^{\prime} u_{t}+u_{t}-1\right) \\ \left\lfloor b^{t} / g^{j}\right\rfloor & \text { for any other } s \in J_{g} ;\end{cases}
$$

where $u_{t}$ is defined by $u_{t}:=b^{t} \bmod g^{j}$ and $s^{\prime} \in\left\{0,1, \ldots, g^{j}-1\right\}=J_{g}$.
Proof. By Proposition 1, the list numbers $s^{\prime}$ of $j$-words in $F_{g}\left(a / b^{k+t}, j\right)$ are generated by the expression

$$
\left(\frac{1}{b^{t}}(s-n)\right) \bmod g^{j}
$$

where $s$ is a list number of some $j$-word in $F_{g}\left(a / b^{k}, j\right)$ and $n \in\left\{0,1, \ldots, b^{t}-1\right\}$. We summarize all possibilities in a $g^{j} \times b^{t}$ matrix

$$
E=\left(e_{s, n}\right)_{s=0,1, \ldots, g^{j}-1 ; n=0,1, \ldots, b^{t}-1}
$$

defined by

$$
e_{s, n}:=\left(\frac{1}{b^{t}}(s-n)\right) \bmod g^{j}
$$

The entries of $E$ are all the $s^{\prime} \in J_{g}$ that can be generated by Proposition 1 regardless of whether we have $\nu_{k}(s)=0$ or $\nu_{k}(s) \neq 0$ (see an example in Table 2). The following properties of $E$ are easy to prove:

1. $e_{(s+1) \bmod g^{j}, n}-e_{s, n} \equiv 1 / b^{t}\left(\bmod g^{j}\right)$;
2. $e_{(s+1)} \bmod g^{j}, n+1 \equiv e_{s, n}\left(\bmod g^{j}\right) \quad$ for $0 \leq n<b^{t}-1$,
$e_{(s+1) \bmod g^{j}, u_{t}} \equiv e_{s, b^{t}-1}\left(\bmod g^{j}\right) ;$
3. $e_{s, n+1}-e_{s, n} \equiv-1 / b^{t}\left(\bmod g^{j}\right)$ for $0 \leq n<b^{t}-1$,

$$
e_{s, u_{t}}-e_{s, b^{t}-1} \equiv-1 / b^{t}\left(\bmod g^{j}\right)
$$

4. $e_{\left(s+u_{t}\right) \bmod g^{j}, n}-e_{s, n} \equiv 1\left(\bmod g^{j}\right)$.

By Property 1, each column is a certain permutation of $\left(0,1, \ldots, g^{j}-1\right)$. By Property 2, the entries of any diagonal Northwest-Southeast are all the same number. Such a diagonal can be extended by jumping from the bottom of $E$ to row 0 of the next column, or from the right margin of $E$ to the next row at column $u_{t}$. By Property 2, Property 3 and because of

$$
\frac{b^{t}}{g^{j}}=\left\lfloor\frac{b^{t}}{g^{j}}\right\rfloor+\frac{u_{t}}{g^{j}},
$$

in each row, a certain permutation of $\left(0,1, \ldots, g^{j}-1\right)$ is repeated $\left\lfloor b^{t} / g^{j}\right\rfloor$ times; the remaining $u_{t}$ numbers appear exactly $\left(\left\lfloor b^{t} / g^{j}\right\rfloor+1\right)$ times in that row. In particular, we have that any $s^{\prime} \in J_{g}$ appears exactly $b^{t}$ times as an entry of $E$.

Let $\mu\left(s, s^{\prime}\right)$ denote the number of times a $j$-word $s^{\prime} \in J_{g}$ appears in row $s$ of the matrix. This leads to a $g^{j} \times g^{j}$ matrix of absolute frequencies $\mu\left(s, s^{\prime}\right)$ which will be the claimed transition matrix $W_{t}$.

Starting with $e_{0,0}=0$ and applying Property 3 several times, we have the following:
since $e_{0,0}=0$,

$$
\mu(s, 0)= \begin{cases}\left\lfloor b^{t} / g^{j}\right\rfloor+1 & \text { for } 0 \leq s<u_{t} \\ \left\lfloor b^{t} / g^{j}\right\rfloor & \text { else } ;\end{cases}
$$

since $e_{u_{t}, 0}=1$,

$$
\mu(s, 1)= \begin{cases}\left\lfloor b^{t} / g^{j}\right\rfloor+1 & \text { for } u_{t} \leq s<\left(2 u_{t}\right) \bmod g^{j}, \\ \left\lfloor b^{t} / g^{j}\right\rfloor & \text { else }\end{cases}
$$

finally, since $e_{\left(s^{\prime} u_{t}\right) \bmod g^{j}, 0}=s^{\prime}$ for all $s^{\prime} \in J_{g}$,

$$
\mu\left(s, s^{\prime}\right)= \begin{cases}\left\lfloor b^{t} / g^{j}\right\rfloor+1 & \text { for }\left(s^{\prime} u_{t}\right) \bmod g^{j} \leq s<\left(\left(s^{\prime}+1\right) u_{t}\right) \bmod g^{j}, \\ \left\lfloor b^{t} / g^{j}\right\rfloor & \text { else. }\end{cases}
$$

Hence the values $\left\lfloor b^{t} / g^{j}\right\rfloor+1$ form blocks of $u_{t}$ adjacent numbers in each column $s^{\prime}$, starting at row $\left(s^{\prime} u_{t}\right)$ modulo $g^{j}$ of the matrix $W_{t}=\mu\left(s, s^{\prime}\right)$.

Finally, the multiplication of the vector $V_{k}$ - a $1 \times g^{j}$ matrix - by column $s^{\prime}$ of $W_{t}$ yields $\nu_{k+t}\left(s^{\prime}\right)$ and therefore, $V_{k+t}=V_{k} \cdot W_{t}$ as claimed.

Example 1. We calculate the transition matrix $W_{t}$ of the sequence

$$
\left(\frac{7}{13^{k}}\right)_{k=1}^{\infty}
$$

in base $g=3$ for $j=2$ and $t=1$. Of course, $a=7$ and $b=13$.
In this case, we have $c_{g}(b)=c_{3}(13)=1$. Indeed, we see that ${ }^{9}$

$$
\operatorname{ord}_{3}(13)=3, \quad \operatorname{ord}_{3}\left(13^{2}\right)=3 \cdot 13, \quad \operatorname{ord}_{3}\left(13^{3}\right)=3 \cdot 13^{2}, \quad \ldots \text { etc. }
$$

Furthermore $u_{t}=u_{1} \equiv 13 \bmod 3^{2} \equiv 4$. Hence the index $s$ goes through the sequence

$$
\left(4 s^{\prime}, 4 s^{\prime}+1,4 s^{\prime}+2,4 s^{\prime}+3\right) \bmod 3^{2} \quad \text { for } s^{\prime}=0,1, \ldots, 8
$$

For these $s$ we have $\left\lfloor b^{t} / g^{j}\right\rfloor+1=\lfloor 13 / 9\rfloor+1=2$. So we obtain

$$
W_{1}=\left(\begin{array}{lllllllll}
2 & 1 & 2 & 1 & 2 & 1 & 2 & 1 & 1 \\
2 & 1 & 2 & 1 & 2 & 1 & 1 & 2 & 1 \\
2 & 1 & 2 & 1 & 1 & 2 & 1 & 2 & 1 \\
2 & 1 & 1 & 2 & 1 & 2 & 1 & 2 & 1 \\
1 & 2 & 1 & 2 & 1 & 2 & 1 & 2 & 1 \\
1 & 2 & 1 & 2 & 1 & 2 & 1 & 1 & 2 \\
1 & 2 & 1 & 2 & 1 & 1 & 2 & 1 & 2 \\
1 & 2 & 1 & 1 & 2 & 1 & 2 & 1 & 2 \\
1 & 1 & 2 & 1 & 2 & 1 & 2 & 1 & 2
\end{array}\right)
$$

The repetend of $7 / 13$ in base 3 can be calculated with Lemma 2 by choosing $j=1$. We obtain the word 112. Actually, we have

$$
7 / 13=0.112112112112 \ldots
$$

[^8]Hence $F_{3}(7 / 13,2)=1121$ is the enlarged repetend. The two-words have the list numbers 4,5 and 7 . Since each of these numbers occurs only once and $J_{3}=$ $\{0,1,2,3,4,5,6,7,8\}$, we obtain the following frequency vector for $k=1$ :

$$
V_{1}=(0,0,0,0,1,1,0,1,0)
$$

We apply Proposition 2 and get

$$
V_{1} \cdot W_{1}=(0,0,0,0,1,1,0,1,0) \cdot W_{1}=(3,6,3,5,4,5,4,4,5)=V_{2}
$$

Indeed, applying Lemma 2 we have

$$
F_{3}\left(7 / 13^{2}, 2\right)=0010100120211001021111201222012102122220
$$

the corresponding list numbers of two-words are the following:

$$
S_{3}\left(7 / 13^{2}, 2\right)=(0,1,3,1,3,0,1,5,6,2,7,4,3,0,1,3,2,7,4,4,4,5,6,1,5,8,8,6,1,5,7,3,2,7,5,8,8,8,6)
$$

Actually, we have the word 0 , three times; the word 1, six times; the word 2, three times; etc. and the word 8, five times.

Proposition 3. Let $W_{t}$ be as in Proposition 2. Then

$$
W_{t}=\left(W_{1}\right)^{t}
$$

Proof. By Proposition 2, we have

$$
V_{k+1}=V_{k} W_{1}, \quad V_{k+2}=V_{k+1} W_{1}, \quad V_{k+3}=V_{k+2} W_{1}, \ldots
$$

Hence $V_{k+t}=V_{k}\left(W_{1}\right)^{t}$. By Proposition 2, also $V_{k+t}=V_{k} W_{t}$. Therefore, $W_{t}=$ $\left(W_{1}\right)^{t}$.

The sequence

$$
\left(u_{t}\right)_{t=1}^{\infty}=\left(b^{t} \bmod g^{j}\right)_{t=1}^{\infty}
$$

is a purely periodic sequence since $b$ and $g$ are relatively prime. Of course, the period length is the order of $b$ modulo $g^{j}$, that is,

$$
\begin{equation*}
t_{0}:=\operatorname{ord}_{b}\left(g^{j}\right) \tag{15}
\end{equation*}
$$

The transition matrix $W_{t}$ can be written as sum

$$
\begin{equation*}
W_{t}=H+W_{t}^{\prime} \tag{16}
\end{equation*}
$$

where H has all its entries equal to $\left\lfloor b^{t} / g^{j}\right\rfloor$, whereas $W_{t}^{\prime}$ has only entries 0 or 1 . Since $b^{t_{0}} \equiv 1\left(\bmod g^{j}\right)$, we have $u_{t_{0}}=1$. The entries of the main diagonal NorthwestSoutheast of $W_{t_{0}}$ are all the same number $\left\lfloor b^{t_{0}} / g^{j}\right\rfloor+1$, and the matrix $W_{t_{0}}^{\prime}$ defined by (16) is the identity matrix. Hence $\left(W_{1}^{\prime}, W_{2}^{\prime}, \ldots\right)$ is a periodic sequence with finitely many distinct terms, namely $\left(W_{1}^{\prime}, W_{2}^{\prime}, \ldots, W_{t_{0}}^{\prime}\right)$.

Proposition 4. Let $a / b^{k}<1$ be a rational fraction in lowest terms, $\operatorname{gcd}(g, b)=1$ and $k \geq c_{g}(b)$. Let $j \geq 1$ be a fixed integer and $t \in \mathbb{N}$. The frequency vector $V_{k+t}$ is determined by $V_{k}$ and $t$ (see an example in Table 3):

$$
\nu_{k+t}\left(s^{\prime}\right)=\left\lfloor\frac{b^{t}}{g^{j}}\right\rfloor \operatorname{ord}_{g}\left(b^{k}\right)+\sum_{s} \nu_{k}(s)
$$

where $s^{\prime} \in J_{g}$ is the list number of some $j$-word in $F_{g}\left(a / b^{k+t}, j\right)$, whereas the summation index $s$ goes through the sequence

$$
\left(s^{\prime} u_{t}, s^{\prime} u_{t}+1, s^{\prime} u_{t}+2, \ldots, s^{\prime} u_{t}+u_{t}-1\right) \bmod g^{j}
$$

for $u_{t}:=b^{t} \bmod g^{j}$. Clearly,

$$
0 \leq \sum_{s} \nu_{k}(s) \leq \operatorname{ord}_{g}\left(b^{t}\right)
$$

Proof. We have $V_{k+t}=V_{k}\left(H+W_{t}^{\prime}\right)=V_{k} H+V_{k} W_{t}^{\prime}$. The first term of this sum is given by

$$
V_{k} H=\left(\left\lfloor b^{t} / g^{j}\right\rfloor \operatorname{ord}_{g}\left(b^{k}\right), \ldots,\left\lfloor b^{t} / g^{j}\right\rfloor \operatorname{ord}_{g}\left(b^{k}\right)\right),
$$

since $\sum_{s \in J_{g}} \nu_{k}(s)=\operatorname{ord}_{g}\left(b^{k}\right)$, and the second term by

$$
V_{k} W_{t}^{\prime}=\left(\sum_{s=0}^{u_{t}-1} \nu_{k}(s), \ldots, \sum_{s=\left(s^{\prime} u_{t}\right) \bmod g^{j}}^{\left(s^{\prime} u_{t}+u_{t}-1\right) \bmod g^{j}} \nu_{k}(s), \ldots, \sum_{s=\left(\left(g^{j}-1\right) u_{t}\right) \bmod g^{j}}^{g^{j}-1} \nu_{k}(s)\right),
$$

since the entries 1 (respectively 0 ) of $W_{t}^{\prime}$ correspond to the entries $\left\lfloor b^{t} / g^{j}\right\rfloor+1$ (respectively $\left\lfloor b^{t} / g^{j}\right\rfloor$ ) of $W_{t}$. Finally, we add the two preceding vectors.

Lemma 12. Let $t_{0}=\operatorname{ord}_{b}\left(g^{j}\right)$. If $k \geq c_{g}(b)$, then

$$
\nu_{k}(s)-\nu_{k}\left(s^{\prime}\right)=\nu_{k+t_{0}}(s)-\nu_{k+t_{0}}\left(s^{\prime}\right)
$$

for all $s, s^{\prime} \in J_{g}$.
Proof. Since

$$
b^{t_{0}} \equiv 1 \quad\left(\bmod g^{j}\right)
$$

we have $u_{t_{0}}=1$. The entries of the main diagonal Northwest-Southeast of $W_{t_{0}}$ are all the same number $\left\lfloor b^{t_{0}} / g^{j}\right\rfloor+1$, and the matrix $W_{t_{0}}^{\prime}$ of Equation (16) is the identity matrix. By Proposition 4, we have

$$
\nu_{k+t_{0}}(s)=\left\lfloor\frac{b^{t_{0}}}{g^{j}}\right\rfloor \operatorname{ord}_{g}\left(b^{k}\right)+\nu_{k}(s),
$$

and the same holds for $s^{\prime}$ instead of $s$.
The following proposition shows that the oscillation of absolute frequencies of $j$-words in $F_{g}\left(a / b^{k}, j\right)$ is bounded for all $k \in \mathbb{N}$.

Proposition 5. Let $a / b$ be a purely periodic proper fraction, $t_{0}=\operatorname{ord}_{b}\left(g^{j}\right)$ and $j, k \in \mathbb{N}$. There is a nonnegative integer $C_{g}(a / b, j)$ such that

$$
\left|\nu_{k}(s)-\nu_{k}\left(s^{\prime}\right)\right| \leq C_{g}(a / b, j)
$$

for all $s, s^{\prime} \in J_{g}$ and all $k \geq c_{g}(b)$, where $c_{g}(b)$ is the integer of Definition 5.
Proof. Indeed, by Lemma 12,

$$
C_{g}(a / b, j):=\max \left\{\left|\nu_{c_{g}(b)+t}(s)-\nu_{c_{g}(b)+t}\left(s^{\prime}\right)\right| \mid s, s^{\prime} \in J_{g}, t \in\left\{0,1, \ldots, t_{0}-1\right\}\right\}
$$

is the claimed $C_{g}(a / b, j)$.
Note that $C_{g}(a / b, j)$ is a bound for all $k \geq c_{g}(b)$. The oscillation corresponding to the finitely many $k<c_{g}(b)$ might exceed this bound.

Example 2. We compute $C_{3}(7 / 13,2)$ and, as shown in example 1 , the transition matrix is $W_{1}$. In Table 3 we have the frequency vectors for $k \in\{1,2,3,4,5\}$.

Table 3: Frequency vectors of $7 / 13^{k}$ in base $g=3$ for $j=2$ and $k \in\{1,2,3,4,5\}$.

For instance, in the enlarged repetend $F_{3}\left(7 / 13^{3}, 2\right)$ (third row), the two-word 11 (having list number 4) occurs 57 times, and the two-word 12 occurs 56 times, meaning that we will have the following oscillations of absolute frequencies: $\sigma_{3}(7 / 13,2)=$ $1, \sigma_{3}\left(7 / 13^{2}, 2\right)=3$ and $\sigma_{3}\left(7 / 13^{3}, 2\right)=2$, with all other oscillations for $k>3$ being a repetition of these values. Hence $C_{3}(7 / 13,2)=3$.

Proposition 6. Let $a / b^{k+t}<1$ be a rational fraction in lowest terms, $\operatorname{gcd}(g, b)=1$ and $t \in \mathbb{N}$. If $k \geq c_{g}(b)$, then

$$
\left|\nu_{k+t}(s)-\frac{b^{t}}{g^{j}} \operatorname{ord}_{g}\left(b^{k}\right)\right|<\operatorname{ord}_{g}\left(b^{k}\right)
$$

for any $j$-word $s$ in the enlarged period $F_{g}\left(a / b^{k+t}, j\right)$.
Proof. Let $\mu:=\operatorname{ord}_{g}\left(b^{k}\right)$. By Proposition 4, we have

$$
b^{t} \mu / g^{j}-\mu<\left\lfloor b^{t} / g^{j}\right\rfloor \mu+0 \leq \nu_{k+t}(s) \leq\left\lfloor b^{t} / g^{j}\right\rfloor \mu+\mu<b^{t} \mu / g^{j}+\mu
$$

Theorem 2. For any purely periodic proper fraction $a / b^{k+t}$ with $k \geq c_{g}(b), t \in \mathbb{N}$, for all $j \geq 1$ each sequence of $j$ digits occurs in the $g$-ary repetend of $a / b^{k+t}$ with $a$ relative frequency that approaches $1 / g^{j}$ for an increasing $t$.

Proof. By Proposition 6 and Definition 5 (definition of $c_{g}(b)$ ), the statement holds for the enlarged repetend of $a / b^{k+t}$. Indeed,

$$
\left|\frac{\nu_{k+t}(s)}{\operatorname{ord}_{g}\left(b^{k+t}\right)}-\frac{1}{g^{j}}\right| \leq \frac{1}{b^{t}} .
$$

When leaving out the last $j-1$ digits of $F_{g}\left(a / b^{k+t}, j\right)$, the new absolute frequencies will be

$$
\nu_{k+t}^{\prime}(s)=\nu_{k+t}(s)-i \quad \text { for some } i \in\{0,1, \ldots, j-1\}
$$

Furthermore,

$$
\sum_{s \in J_{g}} \nu_{k+t}^{\prime}(s)=\operatorname{ord}_{g}\left(b^{k+t}\right)-(j-1)
$$

The new relative frequency

$$
\nu_{\mathrm{rel}}^{\prime}(s)=\frac{\nu_{k+t}(s)-i}{\operatorname{ord}_{g}\left(b^{k+t}\right)-(j-1)}
$$

approaches $\nu_{k+t}(s) / \operatorname{ord}_{g}\left(b^{k+t}\right)$ for increasing $t .{ }^{10}$

## 5. Generalization for Proper Fractions

A $g$-ary expansion of a rational number

$$
a / b=x_{-\ell} \cdots x_{-1} x_{0} \cdot x_{1} x_{2} \cdots \quad(\ell \in \mathbb{N} \cup\{0\})
$$

is eventually periodic. There is a positive integer $n \in \mathbb{N}$ and an index $i_{0} \in \mathbb{N}$ such that

$$
x_{i}=x_{i+n} \quad \text { for all } i \geq i_{0} .
$$

If $n$ and $i_{0}$ are the smallest positive integers with this property, we say that

- $n \in \mathbb{N}$ is the period;
- the word $x_{1} x_{2} \cdots x_{i_{0}-1}$ is the transient; ${ }^{11}$
- the word $x_{i_{0}} x_{i_{0}+1} \cdots x_{i_{0}+n-1}$ is the repetend;

[^9]- the word $\left(x_{i_{0}} x_{i_{0}+1} \cdots x_{i_{0}+n-1}\right)\left(x_{i_{0}} x_{i_{0}+1} \cdots x_{i_{0}+j-2}\right)$ is the enlarged repetend, where $j \geq 1$ is an integer. ${ }^{12}$
P. Bundschuh [2] has shown that in the $g$-adic expansion of a rational number $a / b$ in the lowest terms, the length of the transient and the length of the repetend depend only on $b$ and $g$, but not on $a$. This is what our following lemma proves.

Lemma 13. Let $a / b$ be a proper fraction in lowest terms and $\left\{p_{1}, p_{2}, \ldots, p_{i}, \ldots, p_{t}\right\}$ the non-empty set of primes dividing simultaneously the base $g \geq 2$ and the denominator $b \in \mathbb{N} \backslash\{1\}$. Define

$$
g=g^{\prime} \prod_{i=1}^{t} p_{i}^{g_{i}} \quad \text { and } \quad b=b^{\prime} \prod_{i=1}^{t} p_{i}^{b_{i}},
$$

where $\operatorname{gcd}\left(g, b^{\prime}\right)=1$, and where $g_{i}$ and $b_{i}$ are the highest exponents of $p_{i}$ in the prime factorizations of $g$ and $b$. The length $f$ of the transient in $a / b=0 . x_{1} x_{2} \ldots$ is given by

$$
f=\min \left\{m \in \mathbb{N} \mid m g_{i} \geq b_{i} \quad \text { for all } i \in\{1,2, \ldots, t\}\right\} .^{13}
$$

The repetend of $a / b$ is that of the purely periodic proper fraction

$$
\frac{\left(a\left(g^{\prime}\right)^{f} \prod_{i=1}^{t} p_{i}^{f g_{i}-b_{i}}\right) \bmod b^{\prime}}{b^{\prime}}
$$

provided that $b^{\prime} \neq 1$.
Proof. Indeed, we have

$$
\begin{equation*}
\frac{a}{b}=\frac{a}{b^{\prime} \prod p_{i}^{b_{i}}} \cdot \frac{\left(g^{\prime}\right)^{f} \prod p_{i}^{f g_{i}-b_{i}}}{\left(g^{\prime}\right)^{f} \prod p_{i}^{f g_{i}-b_{i}}}=\frac{1}{g^{f}} \cdot \frac{a\left(g^{\prime}\right)^{f} \prod p_{i}^{f g_{i}-b_{i}}}{b^{\prime}} \tag{17}
\end{equation*}
$$

and therefore,

$$
\frac{a\left(g^{\prime}\right)^{f} \prod p_{i}^{f g_{i}-b_{i}}}{b^{\prime}}=x_{1} x_{2} \cdots x_{f} \cdot x_{f+1} x_{f+2} \cdots
$$

where the leading digits $x_{1}, x_{2}, \ldots$ may be zeros. Because of $\operatorname{gcd}\left(g, b^{\prime}\right)=1$ and $b^{\prime} \neq 1$, the expansion $0 . x_{f+1} x_{f+2} \cdots$ is purely periodic with period $\operatorname{ord}_{g}\left(b^{\prime}\right)$, and the word $x_{1} x_{2} \cdots x_{f}$ is the transient of $a / b$.

If $b^{\prime}=1$, then all prime factors of $b$ divide $g$. In this case, the $g$-ary expansion of $a / b$ is eventually constant and equal to 0 or $g-1$.

[^10]Lemma 14. Let $a / b$ be a proper fraction in the lowest terms, $k \in \mathbb{N}$ and $b^{\prime} \neq 1$ as in Lemma 13. The repetend of $a / b^{k}$ is that of the purely periodic proper fraction

$$
\frac{\left(a\left(g^{\prime}\right)^{k f} \prod_{i=1}^{t} p_{i}^{k\left(f g_{i}-b_{i}\right)}\right) \bmod \left(b^{\prime}\right)^{k}}{\left(b^{\prime}\right)^{k}}
$$

Proof. Apply Equation (17).
Lemma 14 shows that the repetends of proper fractions $a / b^{k}$ are the repetends of purely periodic proper fractions of the form

$$
\frac{a_{k}^{\prime}}{\left(b^{\prime}\right)^{k}}
$$

where the numerators $a_{k}^{\prime}$ depend on $k$, and where $b^{\prime} \neq 1$ is the $g$-free part of the denominator $b$.

Proposition 7. Let b be a positive integer with at least one prime factor that does not divide the base $g \geq 2$. Let $\left(a_{k}\right)_{k=1}^{\infty}$ be a sequence of positive integers relatively prime to $b$.

For all $j \geq 1$, each sequence of $j$ digits occurs in the enlarged repetend of $a_{k} / b^{k}$ with a relative frequency that approaches $1 / g^{j}$ for an increasing $k$.

Proof. The difference $a_{k} / b^{k}-\left(a_{k} \bmod b^{k}\right) / b^{k}$ is a nonnegative integer. Hence $a_{k} / b^{k}$ and $\left(a_{k} \bmod b^{k}\right) / b^{k}$ have the same transient and also the same repetend. Without loss of generality, we assume that $a_{k} / b^{k}$ are already proper fractions and consider the sequence

$$
P:=\left(\frac{a_{k}}{b^{k}}\right)_{k=1}^{\infty}
$$

Of course, the $g$-free part $b^{\prime}$ of $b$ is not 1 . We apply Lemma 14 on each term of $P$. We get a sequence

$$
P^{\prime}:=\left(\frac{a_{k}^{\prime}}{\left(b^{\prime}\right)^{k}}\right)_{k=1}^{\infty}
$$

of purely periodic proper fractions. The corresponding terms of $P$ and $P^{\prime}$ have the same repetends.

We now consider the new sequence

$$
P^{\prime \prime}:=\left(\frac{a_{k}^{\prime} \bmod \left(\left(b^{\prime}\right)^{c_{g}\left(b^{\prime}\right)}\right)}{\left(b^{\prime}\right)^{k}}\right)_{k=1}^{\infty}:=\left(\frac{a_{k}^{\prime \prime}}{\left(b^{\prime}\right)^{k}}\right)_{k=1}^{\infty}
$$

The first $d n=c_{g}\left(b^{\prime}\right)$ numerators of $P^{\prime}$ remain unchanged. Let $k=c_{g}\left(b^{\prime}\right)+t(t \in \mathbb{N})$. We claim that sequences

$$
R_{g}\left(\frac{a_{k}^{\prime}}{\left(b^{\prime}\right)^{k}}, j\right)=\left(r_{v}^{\prime}\right)_{v=0}^{\operatorname{ord}_{g}\left(\left(b^{\prime}\right)^{k}\right)-1} \quad \text { and } \quad R_{g}\left(\frac{a_{k}^{\prime \prime}}{\left(b^{\prime}\right)^{k}}, j\right)=\left(r_{u}^{\prime \prime}\right)_{u=0}^{\operatorname{ord}_{g}\left(\left(b^{\prime}\right)^{k}\right)-1}
$$

except for left rotations, have the same remainders.
Indeed, the two sequences share the remainder $a_{k}^{\prime \prime}$. Of course, $a_{k}^{\prime \prime}=r_{0}^{\prime \prime}$. Furthermore we have

$$
R_{g}\left(\frac{a_{c_{g}\left(b^{\prime}\right)+t}^{\prime}}{\left(b^{\prime}\right)^{c_{g}\left(b^{\prime}\right)}}, j\right)=R_{g}\left(\frac{a_{c_{g}\left(b^{\prime}\right)+t}^{\prime \prime}}{\left(b^{\prime}\right)^{c_{g}\left(b^{\prime}\right)}}, j\right):=\left(r_{i}\right)
$$

Note that this equality holds even if $a_{c_{g}\left(b^{\prime}\right)+t}^{\prime}>\left(b^{\prime}\right)^{c_{g}\left(b^{\prime}\right)}$. We apply Lemma 9 and get the representation

$$
a_{c_{g}\left(b^{\prime}\right)+t}^{\prime}=r_{0}^{\prime}=r_{i_{0}}+n_{0}\left(b^{\prime}\right)^{c_{g}\left(b^{\prime}\right)}
$$

for an appropriate $r_{i_{0}} \in\left(r_{i}\right)$ and some $n_{0} \in\left\{0,1, \ldots,\left(b^{\prime}\right)^{t}-1\right\}$. Since $a_{c_{g}\left(b^{\prime}\right)+t}^{\prime \prime} \equiv$ $a_{c_{g}\left(b^{\prime}\right)+t}^{\prime}\left(\bmod \left(b^{\prime}\right)^{c_{g}\left(b^{\prime}\right)}\right)$, we have $r_{i_{0}}=a_{c_{g}\left(b^{\prime}\right)+t}^{\prime \prime}$. Therefore,

$$
r_{0}^{\prime}=a_{c_{g}\left(b^{\prime}\right)+t}^{\prime \prime}+n_{0}\left(b^{\prime}\right)^{c_{g}\left(b^{\prime}\right)}
$$

By Lemma 9, there is a remainder $r_{v_{0}}^{\prime} \in\left(r_{v}^{\prime}\right)$ such that

$$
r_{v_{0}}^{\prime}=a_{c_{g}\left(b^{\prime}\right)+t}^{\prime \prime}+0 \cdot\left(b^{\prime}\right)^{c_{g}\left(b^{\prime}\right)}=a_{c_{g}\left(b^{\prime}\right)+t}^{\prime \prime} .
$$

Hence $a_{k}^{\prime \prime}$ also belongs to the sequence $\left(r_{v}^{\prime}\right)$.
Since $\left(r_{v}^{\prime}\right)$ and $\left(r_{u}^{\prime \prime}\right)$ are left rotations of the same sequence, the corresponding sequences of $j$-words also are left rotations of the same sequence by Lemma 4. It follows that the corresponding terms of $P^{\prime}$ and $P^{\prime \prime}$, except for left rotations, have the same repetends.

Let $D_{c_{g}\left(b^{\prime}\right)}$ be the cyclic subgroup of $\left(\mathbb{Z} /\left(b^{\prime}\right)^{c_{g}\left(b^{\prime}\right)} \mathbb{Z}\right)^{\times}$generated by $g$ modulo $\left(b^{\prime}\right)^{c_{g}\left(b^{\prime}\right)}$. Furthermore, let $\left\{z_{1}, \ldots, z_{h}, \ldots, z_{\ell}\right\}$ be representatives of the

$$
\ell=\frac{\varphi\left(\left(b^{\prime}\right)^{\operatorname{ord}_{g}\left(b^{\prime}\right)}\right)}{\operatorname{ord}_{g}\left(\left(b^{\prime}\right)^{\operatorname{ord}_{g}\left(b^{\prime}\right)}\right)}
$$

cosets of $D_{c_{g}\left(b^{\prime}\right)}$.
Starting at $k=c_{g}\left(b^{\prime}\right)$, we replace each numerator $a_{k}^{\prime \prime}$ of $P^{\prime \prime}$ by the representative $z_{h}$ of the corresponding coset $z_{h} D_{c_{g}\left(b^{\prime}\right)}$ and get the sequence

$$
P^{\prime \prime \prime}:=\left(\frac{y_{k}}{\left(b^{\prime}\right)^{k}}\right)_{k=c_{g}\left(b^{\prime}\right)}^{\infty},
$$

where $y_{k} \in\left\{z_{1}, \ldots, z_{\ell}\right\}$. The corresponding terms of $P$ and $P^{\prime \prime \prime}$ have left rotations of the same repetends.

The sequence $P^{\prime \prime \prime}$ splits into finitely many subsequences $\left(z_{h} /\left(b^{\prime}\right)^{k_{i}}\right)_{k_{i}}$ of terms with equal numerator $z_{h}$. Any such subsequence is also a subsequence of

$$
Z_{h}:=\left(\frac{z_{h}}{\left(b^{\prime}\right)^{k}}\right)_{k=c_{g}\left(b^{\prime}\right)}^{\infty},
$$

and the statements of Section 4 hold for this sequence.
In particular, the oscillation of absolute frequencies of $j$-words in $F_{g}\left(z_{h} /\left(b^{\prime}\right)^{k}, j\right)$ is bounded by $C_{g}\left(z_{h} / b^{\prime}, j\right)$ for all $k \geq c_{g}\left(b^{\prime}\right)$ (see Proposition 5). Since there are only finitely many sequences $Z_{h}$,

$$
c:=\max \left\{C_{g}\left(z_{h} / b^{\prime}, j\right) \mid z_{h} \in\left\{z_{1}, \ldots, z_{\ell}\right\}\right\}
$$

is a bound for all $Z_{h}$. Hence the oscillation of absolute frequencies of $j$-words in the enlarged repetend of the proper fractions $a_{k} / b^{k}$ is bounded too for all $k \in \mathbb{N}$.

Theorem 3. Let $b>1$ be a positive integer and $\left(a_{k}\right)_{k=1}^{\infty}$ a sequence of positive integers relatively prime to $b$. For all $j \geq 1$, each sequence of $j$ digits occurs in the $g$-ary repetend of $a_{k} / b^{k}$ with a relative frequency that approaches $1 / g^{j}$ for an increasing $k$, unless all prime factors of $b$ divide the base $g \geq 2$.

Proof. The statement holds for the enlarged repetend by Proposition 7. It also holds for the repetend by the same arguments as in the proof of Theorem 2.

If all prime factors of $b$ divide $g$, then the $g$-ary expansion of $a / b^{k}$ is eventually constant and equal to 0 or $g-1$ for all $k \in \mathbb{N}$.

## 6. A Helpful Sequence

Lemma 15. Let $a / b \in \mathbb{Q}$ be a positive fraction in lowest terms: $a \in \mathbb{N}, b \in \mathbb{N} \backslash\{1\}$, and $\operatorname{gcd}(a, b)=1$. Let $A:=\{0,1,2, \ldots, a-1\}$ and $B:=\{0,1,2, \ldots, b-1\}$. Then the following statements hold.

1. $\left\{\left.\left\lfloor t \cdot \frac{a}{b}\right\rfloor \right\rvert\, t \in B\right\}=A \quad$ if and only if $\quad 0<\frac{a}{b}<1$.
2. Let $0<\frac{a}{b}<1$ and $u:=b \bmod a$. In the sequence

$$
\left(\left\lfloor t \cdot \frac{a}{b}\right\rfloor\right)_{t=0}^{b-1}
$$

each element of $A$ occurs either $\lceil b / a\rceil$ or $\lfloor b / a\rfloor$ times. There are exactly $u$ elements of $A$ occurring $\lceil b / a\rceil$ times; each of the remaining $a-u$ elements occurs $\lfloor b / a\rfloor$ times.

Proof. Lemma 15 is a simplified version of Proposition 23 in [4].
Lemma 16. Let $z / m>0$ be a rational fraction such that $\operatorname{gcd}(z, m)=d$. Let $Z=\{0,1, \ldots, z-1\}$ and $M=\{0,1, \ldots, m-1\}$. Then the following statements hold.

1. $\left\{\left.\left\lfloor t \cdot \frac{z}{m}\right\rfloor \right\rvert\, t \in M\right\}=Z \quad$ if and only if $\quad 0<\frac{z}{m} \leq 1$;
2. Let $0<\frac{z}{m}<1$ be and $u:=\frac{m}{d} \bmod \frac{z}{d}$. In the sequence

$$
S:=\left(\left\lfloor t \cdot \frac{z}{m}\right\rfloor\right)_{t=0}^{m-1}
$$

each element of $Z$ occurs either $\lceil m / z\rceil$ or $\lfloor m / z\rfloor$ times. There are exactly ud elements of $Z$ occurring $\lceil m / z\rceil$ times, and 0 is one of them; each of the remaining $z-u d$ elements occurs $\lfloor m / z\rfloor$ times.

Proof. Since $z=d a, m=d b$ and $\operatorname{gcd}(a, b)=1$, we have

$$
Z=\bigcup_{x=0}^{d-1}\{x a, x a+1, \ldots, x a+a-1\}, \quad M=\bigcup_{x=0}^{d-1}\{x b, x b+1, \ldots, x b+b-1\}
$$

Each $t \in M$ has a unique representation

$$
t=x b+y, \quad \text { where } \quad 0 \leq y \leq b-1 \quad \text { and } \quad 0 \leq x \leq d-1
$$

It follows that

$$
\left\lfloor t \cdot \frac{z}{m}\right\rfloor=x a+\left\lfloor y \cdot \frac{a}{b}\right\rfloor .
$$

Hence

$$
S=\left(S^{\prime}, a+S^{\prime}, 2 a+S^{\prime}, \ldots,(d-1) a+S^{\prime}\right), \quad \text { where } \quad S^{\prime}:=\left(\left\lfloor y \cdot \frac{a}{b}\right\rfloor\right)_{y=0}^{b-1}
$$

Of course, $a+S^{\prime}$ means that we add $a$ to each term of $S^{\prime}$.
We apply Lemma 15 to the sequence $S^{\prime}$. The set of integers in $S^{\prime}$ is $A:=$ $\{0,1, \ldots, a-1\}$ if and only if $0<a / b<1$, and $u$ elements of $A$ occur $\lceil b / a\rceil$ times and $a-u$ elements $\lfloor b / a\rfloor$ times in $S^{\prime}$. The number 0 occurs $\lceil b / a\rceil$ times, because it is the only integer in the sequence $(y a / b)_{y=0}^{b-1}$. If $A$ is the set of integers in $S^{\prime}$, with $0<a / b<1$, then $S$ is a sequence of consecutive integers from 0 to $d a-1$, wherein $u d$ integers are repeated $\lceil m / z\rceil$ times and $z-u d$ elements $\lfloor m / z\rfloor$ times. Therefore, $Z$ is the set of integers in $S$, and this is also true for $z / m=1$ since then $Z=M$.

Conversely, if we have complexity $g^{j}$ for some fixed $j=j_{0} \geq 1$, then every $B_{j}$ occurs at least once, and we have $(j, \varepsilon)$-normality for $j=j_{0}$ and for all $\varepsilon$ larger than each of the finitely many $\left|N\left(B_{j}, g\right) / \omega(b)-1 / g^{j}\right|$.
