# Sublinear Least-Squares Value Iteration via Locality Sensitive Hashing

#### Abstract

We present the first provable Least-Squares Value Iteration (LSVI) algorithms that achieves runtime complexity sublinear in the number of actions. We formulate the value function estimation procedure in value iteration as an approximate maximum inner product search problem and propose a locality sensitive hashing (LSH) [Indyk and Motwani STOC'98, Andoni and Razenshteyn STOC'15, Andoni, Laarhoven, Razenshteyn and Waingarten SODA'17] type data structure to solve this problem with sublinear time complexity. Moreover, we build the connections between the theory of approximate maximum inner product search and the regret analysis of reinforcement learning. We prove that, with our choice of approximation factor, our Sublinear LSVI algorithms maintain the same regret as the original LSVI algorithms while reducing the runtime complexity to sublinear in the number of actions. To the best of our knowledge, this is the first work that combines LSH with reinforcement learning resulting in provable improvements. We hope that our novel way of combining data structures and iterative algorithm will open the door for further study into cost reduction in optimization.

## 1 Introduction

Reinforcement learning (RL) is an essential problem in machine learning that targets maximizing the cumulative reward when an agent is taking actions within an unknown environment [SB18]. RL is a trending topic over the last few years. We have seen a remarkable growth of RL applications in Go $\left[\mathrm{SHM}^{+} 16\right]$, robotics [KBP13], dialogue systems [LMR $\left.{ }^{+} 16\right]$ and recommendation $\left[\mathrm{ZZZ}^{+} 18\right]$. In practical RL, most approaches [WD92, SLH ${ }^{+}$14, JAZBJ18] perform iterative-type algorithms that modify the choice of actions at each step based on the agent iteration with the environment. This iterative natural causes the training of RL algorithms to be expensive. For instance, it takes around three weeks to train the agent in AlphaGo [ $\mathrm{SHM}^{+}$16]. Moreover, the training is conducted on 50 GPUs, which means the training of RL on limited computational resources is almost infeasible. Given the efficiency bottleneck of RL algorithms, it is natural to ask the following question.

Are there some TCS techniques that could apply to iterative-type RL algorithms and improve their running time efficiency?

The practical success of a typical TCS technique, Locality sensitive hashing (LSH), shed lights on answering the question. LSH is a randomized data structure with provable efficiency in approximate nearest neighbor search (ANN) [IM98, Cha02, DIIM04, SDI05, AI08, And09, AINR14, AR15, AIL ${ }^{+} 15$, ARN17, Chr17, Raz17, AIR18, Wei19, DIRW20]. Meanwhile, LSH could also be extended to maximum inner product search (Max-IP) [SL14]. Moreover, in practical machine learning (ML), LSH has been widely used in many fundamental learning problems to improve the practical running time of iterative-type algorithms such as gradient descents [CXS19], backpropagation $\left[\mathrm{CMF}^{+} 20\right.$, DMZS21, $\left.\mathrm{CLP}^{+} 21\right]$ and MCMC sampling [LS19]. However, the current empirical combination of LSH with iterative-type algorithms does not have theoretical support. It is unknown to give a provable guarantee for the impact of LSH over the total number of iterations and per cost iteration of iterative-type algorithms.

Inspired by a large number of successes about using LSH to tackle efficiency bottlenecks in practice, it is natural to ask the following question.

## Is there an interesting regime (e.g., some iterative-type algorithms) where we can apply LSH to give provable improvement?

In this work, we answer both questions by proposing a theoretical framework that combines LSH with RL. We focus on Q-learning [WD92], a simple and flexible type of RL framework that directly optimizes the maximum expected reward based on the outcome of actions that the agent taken at each step. Theoretical analysis also suggests that Q-learning is proved to be sample efficient [JAZBJ18]. However, the running time efficiency of Q-learning requires improvement in practical scenarios. We identify that the runtime complexity of Q -learning is dominated by the value function estimation procedure. Value function estimation requires a linear scan over all the actions at each step, which is unscalable in real RL tasks. For instance, in news recommendation systems, the action of an RL agent is recommending an article to the users. The iterative-type Q-learning algorithm scan over all articles at each iteration to find the action that maximizes the expected reward. In practice, this search space is too large so that linear scan is prohibitive. Therefore, reducing the enormous overhead in value function estimation over the large action space becomes a significant research problem in Q-learning.

We focus on applying LSH techniques to reduce this value function estimation overhead in the iterative-type Q-learning algorithm. However, combing LSH with any iterative-type algorithm in Q-learning is challenging due to four major reasons: (1) It remains unknown whether the linear scan
over all possible actions in Q-learning could be formulated as an ANN or Max-IP problem (2) LSH accelerate this linear scan by introducing an error in estimating value function. This approximation error would accumulate in the value iteration and break the current upper bound for regret. (3) Although LSH has demonstrated success in practical ML, its theoretical efficiency guarantee in RL remains unknown. (4) The Q-learning algorithm would query LSH at each step. As the query in each step depends on the previous step, the total failure probability of LSH over this adaptive query sequence could not be union bounded due to correlations.

In this work, we solve these challenges affirmatively by presenting a Q-learning algorithm that uses LSH type approximate Max-IP data structure. We focus on the Least-Squares Value Iteration (LSVI) [BB96] and its extensions with UCB exploration (LSVI-UCB [JYWJ20]). We also discuss LSVI-UCB under policy switch limitation [GXDY21] or model-free setting [WDYS20]. We connect the theory of Max-IP with reinforcement learning by formulating the value function estimation in LSVI and LSVI-UCB as an approximate Max-IP problem. Then, we propose Sublinear LSVI and Sublinear LSVI-UCB, two algorithms with LSH that have value iteration running time sublinear in the number of actions. For LSVI-UCB, we extend the LSH type Max-IP data structure to approximate maximum matrix norm search so that Sublinear LSVI-UCB could also enjoy the sublinear value iteration complexity over actions. Moreover, we theoretically prove that, with our choice of approximation factor, both Sublinear LSVI and Sublinear LSVI-UCB achieve the same regret with their original versions. Furthermore, we identify the potential risks of LSH type approximate Max-IP data structure in iterative-type algorithm and proposes a series of techniques to reduce them.

## 2 Related Work

Approximate Maximum Inner Product Search Maximum Inner Product Search (Max-IP) is a fundamental yet challenging problem in theoretical computer science [Wil05, ARW17, Che18, CW19, Wil18]. Given a query $x \in \mathbb{R}^{d}$ and a dataset $Y \subset \mathbb{R}^{d}$ with $n$ vectors, the goal of Max-IP is to retrieve a $z \in Y$ so that $x^{\top} z=\arg \max _{z \in Y} x^{\top} y$. The brute-force algorithm solves Max-IP in $O(d n)$ time for $x$ by linear scanning over all elements in $Y$. To improve the Max-IP efficiency in practice, approximation methods are proposed to achieve sublinear query time complexity by returning point with a multiplicative approximation ratio to the Max-IP solution.

Chen [Che18] show that for bichromatic Max-IP ${ }^{i}$ with two set of $n$ vectors from $\{0,1\}^{d}$, there is a $n^{2-\Omega(1)}$ time algorithm with $(d / \log n)^{\Omega(1)}$ approximation ratio. Moreover, Chen [Che18] show that this algorithm is conditional optimal as such a $(d / \log n)^{o(1)}$ approximation algorithm would refute Strong Exponential Time Hypothesis (SETH) [IP01] ${ }^{\text {ii }}$.

Most previous approximate Max-IP approaches reduce the Max-IP to nearest neighbor (NN) search problem and apply approximate nearest neighbor (ANN) data structures such as locality sensitive hashing (LSH) [SL14, SL15b, NS15, SL15a, YLD $\left.{ }^{+} 18\right]$. Given a query $x \in \mathbb{R}^{d}$ and a dataset $Y \subset \mathbb{R}^{d}$ with $n$ vectors, the goal of $(\bar{c}, r)$-ANN with $\bar{c}>1$ is to retrieve a $z \in Y$ so that $\|x-z\|_{2} \leq \bar{c} \cdot r$ if there $\min _{y \in Y}\|x-y\|_{2} \leq r$. The LSH solves this problem with query time in $O\left(d \cdot n^{\rho+o(1)}\right)$. Here, $\rho<1$ and it depends on $\bar{c}$. For randomized LSH that is independent of data, Antoni, Indyk and Razenshteyn [AIR18] show that $\rho \geq 1 / \bar{c}^{2}$. To further reduce $\rho$, Antoni and Razenshteyn [AR15] proposes a data-dependent LSH that achieves $\rho=1 /\left(2 \bar{c}^{2}-1\right)$ with preprocessing time and space in $O\left(n^{1+\rho}+d n\right)$. Andoni, Laarhoven, Razenshteyn and Waingarten [ALRW17]

[^1]propose a improved proposes a data-dependent LSH that solves $(\bar{c}, r)$-ANN with query time $O(d$. $\left.n^{\rho_{q}+o(1)}\right)$, space $O\left(n^{1+\rho_{u}+o(1)}+d n\right)$ and preprocessing time $O\left(d n^{1+\rho_{u}+o(1)}\right)$. Andoni, Laarhoven, Razenshteyn and Waingarten [ALRW17] also states that for $\bar{c}>1, r>0, \rho_{u} \geq 0$ and $\rho_{q} \geq 0$, we have $\bar{c}^{2} \sqrt{\rho_{q}}+\left(\bar{c}^{2}-1\right) \sqrt{\rho_{u}} \geq \sqrt{2 \bar{c}^{2}-1}$. Moreover, if we achieve $\rho_{u}=0$, we could reduce the preprocessing overhead to $O\left(n^{1+o(1)}+d n\right)$ while achieving $\rho_{q}=\frac{2}{\bar{c}^{2}}-\frac{1}{\bar{c}^{4}}$. These LSH approaches have concise theoretical guarantees on the trade-off between search quality and query time. Thus, they could solve approximate Max-IP efficiently.

Meanwhile, other non-reduction approximate Max-IP approaches build efficient data structures such as quantization codebooks [GKCS16, GSL ${ }^{+}$20], alias tables [YHLD17, DYH19], trees [RG12] and graphs [MB18, ZTXL19, TZXL19]. However, there exists no theoretical guarantee on these non-reduction approaches so that their evaluation is totally empirical.

Locality Sensitive Hashing Applications In practice, well-implemented LSH algorithms are developed $\left[\mathrm{LJW}{ }^{+} 07, \mathrm{AIL}^{+} 15\right]$ and have demonstrated their superiority in tackling efficiency bottlenecks in practical applications. In optimization, [CXS19] proposes a LSH based approach to estimate gradients in large scale linear models. Moreover, this idea has been extended to neural network training [CMF ${ }^{+}$20, CLP ${ }^{+}$21]. Further more, Besides deep learning, [LS19] also proposes a LSH method for efficient MCMC sampling. [CS17, BCIS18, SRB ${ }^{+}$19, BIW19, CKNS20] use LSH for efficient kernel density estimation. [ZNV $\left.{ }^{+} 20\right]$ proposes a LSH based approach for kernel ridge regression. [YRS ${ }^{+}$21] proposes an LSH algorithm for efficient linear bandits.

Provable Efficient Reinforcement Learning The theoretical analysis on the efficiency of modern reinforcement learning (RL) approaches has drawn a lot of attention recently [JAZBJ18, BXJW19, SS19, JYWJ20, YW20, CYJW20, WZD ${ }^{+} 20$, ZZJ20, WDYS20, DKWY20, FWY ${ }^{+} 20$, DKL ${ }^{+}$21, XSD21]. [JAZBJ18] presents the first Q-learning with UCB exploration algorithm with provable sublinear regret. [JYWJ20] proposes a provable RL algorithm with linear function approximation that achieves both polynomial runtime and polynomial sample complexity. There also exist other works that benefit the community with theoretical analysis on efficient RL [DKWY20, YW20, CYJW20].

Speedup Cost Per Iteration Recently, there have been many works discussing how to improve the cost per iteration for optimization problems (e.g., linear programming, cutting plane method, maximum matching, training neural networks) while maintaining the total number of iterations in achieving the same final error guarantees. However, all of these algorithms are built on sketching [LSZ19, JLSW20, JSWZ21, SY21, BPSW21], sampling [CLS19, BLSS20, DLY21], vectormaintenance [Bra20, JSWZ21], sparse recovery [BLSS20, BLN ${ }^{+}$20] techniques, none of them have used LSH. We hope that our novel combination of data structures and iterative algorithms will open the door for further study into cost reduction in optimization.

## 3 Background

### 3.1 Locality Sensitive Hashing

We present a well-known data structure called locality sensitive hashing [IM98] for approximate nearest neighbor search and approximate maximum inner produce search.

Definition 3.1 (Locality Sensitive Hashing). Let $\bar{c}$ denote a parameter such that $\bar{c}>1$. Let $r$ denote a parameter. Let $p_{1}, p_{2}$ denote two parameters such that $0<p_{2}<p_{1}<1$. A family $\mathcal{H}$ is
called $\left(r, \bar{c} \cdot r, p_{1}, p_{2}\right)$-sensitive if and only if, for any two point $x, y \in \mathbb{R}^{d}$, $h$ chosen uniformly from $\mathcal{H}$ satisfies the following: (1) if $\|x-y\|_{2} \leq r$, then $\operatorname{Pr}_{h \sim \mathcal{H}}[h(x)=h(y)] \geq p_{1}$, (2) if $\|x-y\|_{2} \geq \bar{c} \cdot r$, then $\operatorname{Pr}_{h \sim \mathcal{H}}[h(x)=h(y)] \leq p_{2}$.

We want to remark that the original LSH definition supports more general distance function than $\ell_{2}$ distance. In our application, $\ell_{2}$ distance is sufficient, therefore we only define LSH based on $\ell_{2}$ distance. It is well-known that an efficient LSH family implies data structure ( $\bar{c}, r$ )-ANN which can be defined as

Definition 3.2 (Approximate Near Neighbor (ANN)). Let $\bar{c}>1$ and $r \in(0,2)$. Given an n-point dataset $P \subset \mathbb{S}^{d-1}$ on the sphere, the goal of the $(\bar{c}, r)$-Approximate Near Neighbor (ANN) problem is to build a data structure that, given a query $q \in \mathbb{S}^{d-1}$ with the promise that there exists a datapoint $p \in P$ with $\|p-q\|_{2} \leq r$ reports a datapoint $p^{\prime} \in P$ within distance $\bar{c} \cdot r$ from $q$.

In the iterative-type reinforcement learning algorithm, we care about the dual version of the problem (Definition 3.3),

Definition 3.3 (Approximate Max-IP). Let $c \in(0,1)$ and $\tau \in(0,1)$. Given an n-point dataset $P \subset \mathbb{S}^{d-1}$ on the sphere, the goal of the ( $c, \tau$ )-Maximum Inner Product Search (Max-IP) is to build a data structure that, given a query $q \in \mathbb{S}^{d-1}$ with the promise that there exists a datapoint $p \in P$ with $\langle p, q\rangle \geq \tau$, it reports a datapoint $p^{\prime} \in P$ with similarity $\left\langle p^{\prime}, q\right\rangle \geq c \cdot \tau$.

We briefly discuss the connection. Let us consider the distance function as Euclidean distance and similarity function as inner product. We also assume all the points are from unit sphere. In this setting, the relationship between two problems are primal vs dual. For any two points $x, y$ with $\|x\|_{2}=\|y\|_{2}=1$, we have $\|x-y\|_{2}^{2}=2-2\langle x, y\rangle$. This implies that $r^{2}=2-2 \tau$. Further, if we have a data structure for $(\bar{c}, r)$-ANN, it automatically becomes a data structure for $(c, \tau)$-Max-IP with parameters $\tau=1-0.5 r^{2}$ and $c=\frac{1-0.5 \bar{c}^{2} r^{2}}{1-0.5 r^{2}}$. This implies that $\bar{c}^{2}=\frac{1-c\left(1-0.5 r^{2}\right)}{0.5 r^{2}}=\frac{1-c \tau}{1-\tau}$.

Our algorithmic result is mainly built on this data structure.
Theorem 3.4 (Andoni and Razenshteyn [AR15]). Let $\bar{c}>1$ and $r \in(0,2)$. Let $\rho=\frac{1}{2 \bar{c}^{2}-1}+o(1)$. The ( $\bar{c}, r$ )-ANN (see Definition 3.2) on a unit sphere $\mathbb{S}^{d-1}$ can be solved in space $O\left(n^{1+\rho}+d n\right)$ and query time $O\left(d \cdot n^{\rho}\right)$.

Using the standard reduction, we can derive the following.
Corollary 3.5. Let $c \in(0,1)$ and $\tau \in(0,1)$. The ( $c, \tau)$-Max-IP (see Definition 3.3) on a unit sphere $\mathbb{S}^{d-1}$ can be solved in preprocessing time/space $O\left(n^{1+\rho}+d n\right)$ and query time $O\left(d \cdot n^{\rho}\right)$, where $\rho=\frac{1-\tau}{1-2 c \tau+\tau}+o(1)$.

Using [ALRW17], we can improve the preprocessing time and space to $n^{1+o(1)}+d n$ while having a slightly weaker $\rho$ in query. We provide a detailed and formal version of Corollary 3.5 in Theorem 8.2. We present our main result based on that. Moreover, it is reasonable for us to regard $d=n^{o(1)}$ using Johnson-Lindenstrauss Lemma [JL84].

Finally, to combine the maximum inner product search with reinforcement algorithm to get sublinear time cost, we still need to deal with many issues, such as the inner product can be negative, $\tau$ is arbitrarily close to 0 , and $\tau$ can arbitrarily close to 1 . We will explain how to handle these challenges in later section.

### 3.2 Reinforcement Learning

In this section, we introduce some backgrounds about reinforcement learning. We start with defining the episodic Markov decision process. Let $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ denotes the episodic Markov decision process, where $\mathcal{S}$ denotes the set of available states, $\mathcal{A}$ denotes the set of available actions, $H \in$ $\mathbb{N}$ denotes the total number of steps in each episode, $\mathbb{P}=\left\{\mathbb{P}_{h}\right\}_{h=1}^{H}$ with $\mathbb{P}_{h}\left[s^{\prime} \mid s, a\right]$ denotes the probability of transition from state $s \in \mathcal{S}$ to state $s^{\prime} \in \mathcal{S}$ when take actions $a \in \mathcal{A}$ at step $h$, $r=\left\{r_{h}\right\}_{h=1}^{H}$ denotes the reward obtained at each step. Here the reward $r_{h}$ is a function that maps $\mathcal{S} \times \mathcal{A}$ to $[0.55,1]^{\text {iii }}$ In practice, we build an agent in $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ and play $K$ episodes.

In this work, we focus on the linear Markov decision process (linear MDP). In this setting, each pair of state and action is represented as an embedding vector $\phi(s, a)$, where $\phi: \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}^{d}$. Moreover, the probability $\mathbb{P}_{h}\left[s^{\prime} \mid s, a\right]$ for state transition and function $r_{h}$ for reward are linear in this embedding vector.

In the MDP framework, a policy $\pi=\left\{\pi_{1}, \cdots, \pi_{H}\right\}$ is defined as sequence such that $\pi_{h}: \mathcal{S} \rightarrow \mathcal{A}$ for each step $h . \pi_{h}(s)=a$ represents the action taken when we are at step $h$ and state $s$. Next, we represent the Bellman equation with policy $\pi$ as

$$
Q_{h}^{\pi}(s, a)=\left[r_{h}+\mathbb{P}_{h} V_{h+1}^{\pi}\right](s, a), \quad V_{h}^{\pi}(s)=Q_{h}^{\pi}\left(s, \pi_{h}(s)\right), \quad V_{H+1}^{\pi}(s)=0 .
$$

where $Q^{\pi}(s, a)$ denotes the Q function for policy $\pi$ when taking action $a$ at state $s$ and step $h$ and $V^{\pi}(s)$ denotes the value function of state $s$ at step $h$. We use $\left[\mathbb{P}_{h} V_{h+1}\right](s, a)$ to represent the expect value functions when aking action $a$ at state $s$ at step $h$. For more detailed definitions, please refer to Section 7.

## 4 Our Results

We present the results in this section. We start with summarizing all of our main results in Table 1. According to Table 1, we reduce the value iteration complexity of LSVI [BB96], LSVIUCB [JYWJ20], LSVI-UCB under policy switch limitation [GXDY21] and model-free version of LSVI-UCB [WDYS20] from linear to sublinear in action space. Meanwhile, the total regret is preserved as same as before. To achieve this, we pay tolerable time to preprocess pairs of state-action into LSH type approximate Max-IP data structure. In the following section, we would elaborate on the details for these main results.

### 4.1 Sublinear Least-Squares Value Iteration

In LSVI [BB96] with large action space, the runtime in each value iteration step is dominated by computing the estimated value function as below:

$$

\widehat{V}_{h}(s)=\max _{a \in \mathcal{A}_{\text {core }}}\left\langle\widehat{w}_{h}, \phi(s, a)\right\rangle \tag{1}
\end{equation*}
$$

where $\widehat{w}_{h}$ is computed by solving the least-squares problem and $\phi(s, a)$ is the embedding for stateaction pair. Eq. (1) is a standard Max-IP problem and thus, takes $O(A d)$ to obtain the exact solution. In this work, we relax Eq. (1) into an $(c, \tau)$-Max-IP problem, where $c \in(0,1)$ is the approximation parameter and $\tau$ is close to the $\max _{a \in \mathcal{A}_{\text {core }}}\left\langle\widehat{w}_{h}, \phi(s, a)\right\rangle$. Then, we apply LSH type data structure to retrieve $\widehat{V}_{h}(s) \geq c \cdot \max _{a \in \mathcal{A}_{\text {core }}}\left\langle\widehat{w}_{h}, \phi(s, a)\right\rangle$ in $o(A) \cdot O(d)$ time complexity.

Table 1: Comparison between our algorithms with previous results such as LSVI, LSVI-UCB, LGSC and MF. We compare our algorithm with: (1) LSVI denotes the Least-Square Value Iteration algorithm [BB96] (2) LSVI-UCB denotes the Least-Square Value Iteration algorithm with UCB in [JYWJ20]. (3) LGSC denotes the LSVI-UCB with low global switching cost [GXDY21]. (4) MF denotes the model free LSVIUCB presented in [WDYS20]. Note that "V. Iter. C." denotes the Value iteration complexity. Let $S$ denotes the number of available states. Let $A$ denote the number of available actions. Let $d$ denotes the dimension of $\phi(s, a)$. Let $H$ denotes the number of steps per episode. Let $K$ denotes the total number of episodes. Let $n$ be the quantity of times played for each core pair of state-action. Let $\iota=\log (H d / p)$ and $p$ is the failure probability. We ignore the big-Oh notation " $O$ " in the table. Let $\rho \in(0,1)$ denote a parameter determined by data structure. In fact, the preprocessing time for Sublinear LSVI-UCB is $O\left(S A^{1+o(1)}+S d^{2} A\right)$. Since $K>S$, we write the preprocessing time as $O\left(K A^{1+o(1)}+K d^{2} A\right)$. This table is a union of simplified version of Table 3 (both our algorithm and LSVI have the exact dependence on another $L$, we omit here and discuss this dependence in Section 9.), Table 4 and Table 5.

Next, we present our main theorem for Sublinear LSVI in Theorem 4.1, which gives the same $O\left(L H^{2} \sqrt{\iota / n}\right)$ regret as LSVI [BB96] and reduce the value iteration complexity from $O(H S d A)$ to $O(H S d) \cdot o(A)$.

Theorem 4.1 (Main result, convergence result of Sublinear Least-Squares Value Iteration (Sublinear LSVI), an informal version of Theorem 9.2). Let $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ denotes a linear MDP. Let $p$ denotes a fixed probability. Let $\iota=\log (H d / p)$. If we set approximate Max-IP parameter $c=1-\Theta(\sqrt{\iota / n})$, then Sublinear LSVI has regret at most $O\left(H^{2} \sqrt{\iota / n}\right)$ with probability at least $1-p$. Moreover, with $S A^{1+o(1)}+S d A$ preprocessing time and space, the value iteration complexity of Sublinear LSVI is $O\left(H S d A^{\rho}\right)$ where $\rho=1-\Theta(\iota / n)$.

Note that we could improve the value iteration complexity to with $\rho=1-\Theta(\sqrt{\iota / n})$ by increasing the preprocessing time and space to $O\left(S A^{1+\rho}+S d A\right.$ ) using Theorem 7.14. We provide a detailed and formal version of Theorem 4.1 in Theorem 9.2.

### 4.2 Sublinear Least-Squares Value Iteration with UCB

We extend the Sublinear LSVI with UCB exploration in this section. In LSVI-UCB [JYWJ20] with large action space, the runtime in each value iteration step is dominated by by computing the estimated value function as below:

$$
\begin{equation*}
\widehat{V}_{h}\left(s_{h+1}^{\tau}\right)=\max _{a \in \mathcal{A}} \min \left\{\left\langle w_{h}^{k}, \phi\left(s_{h+1}^{\tau}, a\right)\right\rangle+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}, H\right\} \tag{2}
\end{equation*}
$$

where $w_{h}^{k}$ is computed by solving the least-squares problem, $\phi\left(s_{h+1}^{\tau}, a\right)$ is the embedding for stateaction pair and $\Lambda_{h}=\sum_{\tau=1}^{k-1} \phi\left(s_{h}^{\tau}, a_{h}^{\tau}\right) \phi\left(s_{h}^{\tau}, a_{h}^{\tau}\right)^{\top}+\lambda \cdot \mathbf{I}_{d}$. The complexity for Eq. (2) is $O\left(A d^{2}\right)$

The key challenge of Sublinear LSVI-UCB here is that Eq. (2) cannot be formulated as a Max-IP problem. First, to deal with this issue, we propose a value function estimation approach as below:

$$
\begin{equation*}
\widehat{V}_{h}\left(s_{h+1}^{\tau}\right)=\max _{a \in \mathcal{A}} \min \left\{\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{2 \beta^{2} \Lambda_{h}^{-1}+2 w_{h}^{k} w_{h}^{k \top}}, H\right\} \tag{3}
\end{equation*}
$$

where $\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{2 \beta^{2} \Lambda_{h}^{-1}+2 w_{h}^{k} w_{h}^{k \top}}$ is the upper bound of $\left\langle w_{h}^{k}, \phi\left(s_{h+1}^{\tau}, a\right)\right\rangle+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}$.
Next, we relax this maximum matrix norm search as a $(c, \tau)$-Max-IP problem, where $c \in(0,1)$ is the approximation parameter and $\tau$ is the maximum inner product for Eq. (3). Then, we apply LSH type data structure to retrieve $\widehat{V}_{h}\left(s_{h+1}^{\tau}\right) \geq c \cdot \max _{a \in \mathcal{A}} \min \left\{\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{2 \beta^{2} \Lambda_{h}^{-1}+2 w_{h}^{k} w_{h}^{k \top}}, H\right\}$ in $o(A) \cdot O\left(d^{2}\right)$ time complexity.

Using LSH data structure for maximum matrix norm search, we present our main theorem for Sublinear LSVI-UCB in Theorem 4.3, which gives the same $O\left(\sqrt{d^{3} H^{4} K \iota^{2}}\right)$ regret as LSVIUCB [JYWJ20] and reduce the value iteration complexity from $O\left(H K d^{2} A\right)$ to $O\left(H K d^{2} A\right) \cdot o(A)$. We start with the setting up the parameters for our algorithm.

Definition 4.2 (Sublinear LSVI-UCB Parameteres). $\operatorname{Let} \operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ denotes a linear MDP. For this MDP, we set LSVI-UCB parameter $\lambda=1$. Let $c=1-\frac{1}{\sqrt{K}}$ denotes the approximate Max-IP parameter. Let $p$ denotes a fixed probability. Let $\iota=\log (2 d T / p)$.

Then, we present the Theorem.
Theorem 4.3 (Main result, convergence result of Sublinear Least-Squares Value Iteration with UCB (Sublinear LSVI-UCB), an informal version of Theorem 10.12). With parameters defined in Definition 4.2, Sublinear LSVI-UCB (Algorithm 4) has total regret at most $O\left(\sqrt{d^{3} H^{4} K \iota^{2}}\right)$ with probability at least $1-p$. Moreover, with $O\left(K A^{1+o(1)}+K d^{2} A\right)$ preprocessing time and space, the value iteration complexity of Sublinear LSVI-UCB is $O\left(H K d^{2} A^{\rho}\right)$, where $\rho=1-1 / K$.

Similarly, we could improve the value iteration complexity to with $\rho=1-\frac{1}{\sqrt{K}}$ by increasing the preprocessing time and space to $O\left(K A^{1+\rho}+K d A\right)$ using Theorem 7.14. We provide a detailed and formal version of Theorem 4.3 in Theorem 10.12.

Next, we extend the results in Theorem 4.3 to two LSVI-UCB variations. The first algorithm is the LSVI-UCB under constraints on the switch of the policy [GXDY21]. We denote this algorithm as LGSC. The second algorithm is the model-free version of LSVI-UCB [WDYS20]. We denote this algorithm as $\mathrm{MF}^{\mathrm{iv}}$. We propose sublinear version of two algorithms with statement as:

Corollary 4.4 (Main result, informal versions of Corollary 11.2 and Corollary 11.1). With parameters defined in Definition 4.2, LGSC and MF have total regret at most $O\left(\sqrt{d^{3} H^{4} K \iota^{2}}\right)$ with probability at least $1-p$. Further more, with $O\left(K A^{1+o(1)}+K d^{2} A\right)$ preprocessing time and space, the value iteration complexity of LGSC and MF is $O\left(H K d^{2} A^{\rho}\right)$, where $\rho=1-1 / K$.

## 5 Our Techniques

As mentioned in Section 3.1, we need to tackle five major issues to use LSH based approximate Max-IP algorithm for sublinear runtime time LSVI and LSVI-UCB in RL.

- How to prevent the maximum inner product between query and data from being negative or arbitrary close to 0 ? If the maximum inner product is negative, Max-IP data structures cannot be applied to solve this problem with theoretical guarantee. If the maximum inner product is arbitrary close to 0 , the query time of $(c, \tau)$-Max-IP would be close to $O(d n)$.

[^3]- How to prevent the maximum inner product between query and data from being close to one? If $\tau$ is close to one, the time cost would also be $O(d n)$ so that $(c, \tau)$-Max-IP cannot reduce the time cost from linear to sublinear.
- How to apply $(c, \tau)$-Max-IP for LSVI with UCB exploration? The estimated value function with an additional UCB bonus term could not be written as an inner product, which prevents Max-IP techniques from accelerating the runtime efficiency.
- How to generalize the Max-IP data structure to support maximum matrix norm search? Is Max-IP equivalent to maximum matrix norm search?
- How to improve the running time while preserving the regret? Although approximate Max-IP could accelerate the computation for estimated value function, it brings errors to the value function estimation and thus, affects the total regret. Therefore, a key challenge is quantifying the relationship between regret and the approximation factor $c$ in $(c, \tau)$-Max-IP.
- How to handle the adaptive queries? The weight $\widehat{w}_{h}$ in Eq. (1) and $w_{h}^{k}$ in Eq. (2) are dependent to $h-1$ step. Therefore, the queries for $(c, \tau)$-Max-IP during the Q-learning are adaptive but not arbitrary. Thus, we could not union bound the failure probability of LSH for $(c, \tau)$-Max-IP.

Next, we provide details on how we handle these problems.

### 5.1 Avoid Negative Inner Product or Inner Product Close to 0

In our setting, we assume the reward function $r$ lies in $[0.55,1]^{\mathrm{v}}$. This shift on the reward function would not affect the convergence results of our Sublinear LSVI and Sublinear LSVI-UCB. Moreover, it would benefits the Max-IP by generating acceptable maximum inner product. For Sublinear LSVI, as $r_{h}(s, a) \in[0.55,1]$, the optimal value function $V_{h}^{*}(s) \geq 0.55$. Then according to Theorem 4.1 the estimated $\widehat{V}_{h}(s)=\max _{a \in \mathcal{A}}\left\langle w_{h}, \psi(s, a)\right\rangle$ satisfies $\left|V_{h}^{*}(s)-V_{h}^{*}(s)\right| \leq \epsilon$ if we query each pair of state-action from span matrix for $n=O\left(\epsilon^{-2} L^{2} H^{4} \iota\right)$ times. In this way, we could assure the maximum inner product is greater than 0.5 if we set $\epsilon \leq 0.05$. For Sublinear LSVI-UCB, the Max-IP is applied on $\widehat{V}_{h}(s)=\max _{a \in \mathcal{A}} Q_{h}^{k}(s, a)$, where $Q_{h}^{k}(s, a)$ is a Q function with additional UCB term. From [JYWJ20], we know that for all pair of state-action , $Q_{h}^{k}(s, a) \geq Q_{h}^{*}(s, a)$. Therefore, the maximum inner product for Sublinear LSVI-UCB is always greater than 0.5.

### 5.2 Avoid Inner Product Close to 1

In the optimization problem that could be accelerated by Max-IP, the query and data vectors are usually not unit vectors. To apply results in Section 3.1, we demonstrate how to transform both query and data vectors into unit vectors. Moreover, we also modify the transformation to avoid the inner product from being too close to 1 .

Given two vector $x, y \in \mathbb{R}^{d}$ with $\|y\|_{2} \leq 1$ and $\|x\|_{2} \leq D_{x}$, we apply the following transformations

$$
P(y)=\left[\begin{array}{lll}
y^{\top} & \sqrt{1-\|y\|_{2}^{2}} & 0
\end{array}\right]^{\top} \quad Q(x)=\left[\begin{array}{ccc}
\frac{0.8 \cdot x^{\top}}{D_{x}} & 0 & \sqrt{1-\frac{0.64 \cdot\|x\|_{2}^{2}}{D_{x}^{2}}} \tag{4}
\end{array}\right]^{\top}
$$

Using this transformations, we transform $x, y$ into unit vectors $P(y)$ and $Q(x)$. Therefore, the Max-IP of $Q(x)$ with respect to $P(Y)$ is equivalent to the ANN problem of $Q(x)$ with respect to $P(Y)$,

[^4]which could be solved via LSH. Moreover, we show that $Q(x)^{\top} P(y)=\frac{0.8 x^{\top} y}{D_{x}} \leq \frac{0.8 \cdot\|x\|_{2}\|y\|_{2}}{D_{x}}=0.8$. Further more, it is sufficient to show that $\arg \max _{y} Q(x)^{\top} P(y)=\arg \max _{y} \frac{0.8 \cdot x^{\top} y}{D_{x}}=\arg \max _{y} x^{\top} y$.

If we perform maximum inner product search on $Q(x)$ and $P(y)$ using the LSH data structures described in Section 3.1, we have $\tau=\max _{y} Q(x)^{\top} P(y) \leq 0.8$. In this way, we could assure $\tau$ is not close to 1 so that we could reduce the runtime complexity of value function estimation to be sublinear over actions.

### 5.3 Approximate Max-IP Data Structure for LSVI-UCB

As shown in Section 4.2, Eq. (2) cannot be formulated as a Max-IP problem. To overcome this barrier, we bound the term $Q_{h}\left(s_{h+1}^{\tau}, a\right)=\left\{w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}, H\right\}$ by matrix norms. Then, we perform the maximum matrix norm search for value function estimation.

We start with the upper bound of $w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}$. As both $\left\langle w_{h}^{k}, \phi\left(s_{h+1}^{\tau}, a\right)\right\rangle$ and $\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}$ are non-negative, we have

$$
\begin{aligned}
\left\langle w_{h}^{k}, \phi\left(s_{h+1}^{\tau}, a\right)\right\rangle+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}} & \leq \sqrt{2\left(w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)\right)^{2}+2 \beta^{2} \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}^{2}} \\
& =\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{2 \beta^{2} \Lambda_{h}^{-1}+2 w_{h}^{k}\left(w_{h}^{k}\right)^{\top}}
\end{aligned}
$$

where the first step follows from $a+b \leq \sqrt{2 a^{2}+2 b^{2}}$.
Next, we lower bound the $w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}$ as

$$
\begin{aligned}
w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}} & \geq \sqrt{\left(w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)\right)^{2}+\beta^{2} \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}^{2}} \\
& =\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\beta^{2} \Lambda_{h}^{-1}+w_{h}^{k}\left(w_{h}^{k}\right)^{\top}}
\end{aligned}
$$

where the first step follows from the fact that both $w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)$ and $\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}$ are nonnegative and $a+b \geq \sqrt{a^{2}+b^{2}}$ if $a, b \geq 0$, the second step is an reorganization.

After we obtain the lower and upper bound of $w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}$, we could also lower bound the term $\left\{w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}, H\right\}$ with $\min \left\{\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\beta^{2} \Lambda_{h}^{-1}+w_{h}^{k}\left(w_{h}^{k}\right)^{\top}}, H\right\}$ and upper bound it with $\min \left\{\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{2 \beta^{2} \Lambda_{h}^{-1}+2 w_{h}^{k}\left(w_{h}^{k}\right)^{\top}}, H\right\}$.

Next we use this lower and upper bound and propose a modified value function estimation shown in Eq. (3). Therefore, our problem becomes designing an approximate maximum matrix norm search data structure. We will discuss this in the following section and propose our Sublinear LSVI-UCB algorithm.

### 5.4 Generalize the Approximate Max-IP Data Structure for Max-MatNorm

We demonstrate how to extend Max-IP to maximum matrix norm search for Sublinear LSVI-UCB in this section. We first define the approximate Maximum Matrix Norm. Let $c \in(0,1)$ and $\tau \in(0,1)$. Given an $n$-point dataset $Y \subset \mathbb{R}^{d}$, the goal of the $(c, \tau)$-Maximum Matrix Norm (Max-MatNorm) is to construct a data structure that, given a query matrix $x \in \mathbb{R}^{d \times d}$ with the promise that there exists a datapoint $y \in Y$ with $\|y\|_{x} \geq \tau$, it reports a datapoint $z \in Y$ with $\|z\|_{x} \geq c \cdot \tau$.

We solve the approximate maximum matrix norm by transform it into a Max-IP problem. We start with showing the relationship between Max-MatNorm and Max-IP as

$$
\operatorname{Max}-\operatorname{MatNorm}(X, Y)^{2}=\max _{y \in Y} y^{\top} x y=\max _{y \in Y}\left\langle\operatorname{vec}(x), \operatorname{vec}\left(y y^{\top}\right)\right.
$$

where vec vectorizes $d \times d$ matrix $x$ into a $d^{2}$ vector.
Next, we show that if we obtain $z \in Y$ by $\left(c^{2}, \tau^{2}\right)$-Max-IP so that $\left\langle\operatorname{vec}(x), \operatorname{vec}\left(z z^{\top}\right)\right\rangle \geq c^{2} \tau^{2}$, we use $z$ and obtain $\|z\|_{x}=\sqrt{\left\langle\operatorname{vec}(x), \operatorname{vec}\left(z z^{\top}\right)\right\rangle} \geq c \tau$. In other words, $z$ is the candidate for $(c, \tau)$ -Max-MatNorm. In this way, we could build an efficient data-structure for $\left(c^{2}, \tau^{2}\right)$-Max-IP to solve $(c, \tau)$-Max-MatNorm. In this way, we summarize our approach for Max-MatNorm as three steps: (1) transform matrix $x$ into $\operatorname{vec}(x)$ and $y$ into $\operatorname{vec}\left(y y^{\top}\right)$, (2) transform $\operatorname{vec}(x)$ and $\operatorname{vec}\left(y y^{\top}\right)$ into unit vectors following Eq. (4), (3) use LSH to solve the Max-IP with respect to dataset on the unit sphere.

### 5.5 Preserving Regret While Reducing the Runtime

In our work, we maintain the same regret with LSVI [BB96] and LSVI-UCB [JYWJ20] by carefully setting the approximation parameter $c \in(0,1)$ in Max-IP. For Sublinear LSVI, we set $c=1-$ $\Theta(\sqrt{\iota / n})$ so that the final regret is as same as LSVI [BB96]. In Sublinear LSVI-UCB, we set $c=1-\frac{1}{\sqrt{K}}$ so that the final regret is as same as LSVI-UCB [JYWJ20]. Because $K, \iota$ and $n$ are global parameter, we could set $c$ in the preprocessing step before value iteration. In this way, we show that our two algorithms are novel demonstration of combining LSH with reinforcement learning without losing on the regret.

### 5.6 Handle Adaptive Queries in $(c, \tau)$-Max-IP

We use a quantization method to handle adaptive queries. We denote $Q$ as the convex hull of all queries for $(c, \tau)$-Max-IP. Our method contains two steps: (1) Preprocessing: we quantize $Q$ to a lattice $\widehat{Q}$ with quantization error $\lambda / d$. In this way, each coordinate would be quantized into the multiples of $\lambda / d$. (2) Query: given a query $q$ in the adaptive sequence $X \subset Q$, we first quantize it to the nearest $\widehat{q} \in \widehat{Q}$ and perform $(c, \tau)$-Max-IP. As each $\widehat{q} \in \widehat{Q}$ is independent, we could union bound the failure probability of adaptive queries. On the other hand, this would generate an $\lambda$ additive error in the returned inner product. Our analysis indicates that the additive error $\lambda$ could be handled without breaking the regret.

## 6 Future Data Structure Design

In this paper, we show that LSH type data structures could accelerate Q-learning with linear function approximation [JYWJ20, GXDY21]. In this setting, the Q function is formulated as the inner product of state-action embedding and weight. However, in the literature of theoretical RL, the Q function is in a more general form. [JAZBJ18, BXJW19, WZD ${ }^{+} 20$, ZZJ20, DKL ${ }^{+} 21$ ] present the theoretical analysis on general Q function. [SS19] assumes the Lipschitz continuous of optimal $Q$ function and show how to upper bound it. [YW20] assumes the existence of a non-linear mapping in the computation of Q function.

To extend our results in general Q functions, an efficient similarity search data structure is required. We provide its form as: Let $f(x, y): \mathbb{R}^{d} \times \mathbb{R}^{d} \rightarrow \mathbb{R}$ denotes a similarity measure. Let $c \in(0,1)$. Given a $n$-point dataset $P \subset \mathbb{R}^{d}$, a data structure is an sublinear similarity search data structure if given a query $q \in \mathbb{R}^{d}$, it reports a datapoint $p^{\prime} \in P$ with similarity $f\left(q, p^{\prime}\right) \geq$ $c \cdot \max _{p \in P} f(q, p)$ with query complexity sublinear in $n$.

It is clear to extend LSH for general norms [ANN ${ }^{+} 17$, ANN ${ }^{+} 18 \mathrm{~b}$, $\mathrm{ANN}^{+} 18 \mathrm{a}$ ]. However, it remains unclear to extend LSH for more general functions that are widely used in RL. We believe that our work gives a strong motivation on designing novel data structures for more general similarity measures and apply it to solve efficiency bottlenecks in RL and other ML tasks.

### 7.1 Basic Notations

We use $\operatorname{Pr}[]$ to denote probability and $\mathbb{E}[]$ to denote expectation if it exists.
For a matrix $A$, we use $\|A\|_{F}:=\left(\sum_{i, j} A_{i, j}^{2}\right)^{1 / 2}$ to denote the Frobenius norm of $A$, we use $\|A\|_{1}:=\sum_{i, j}\left|A_{i, j}\right|$ to denote the entry-wise $\ell_{1}$ norm of $A$, we use $\|A\|$ to denote the spectral norm of $A$. We say matrix $A \in \mathbb{R}^{d \times d}$ is a positive semidefinite matrix if for all $x \in \mathbb{R}^{d}, x^{\top} A x \geq 0$. We say matrix $A \in \mathbb{R}^{d \times d}$ is a positive definite matrix if for all $x \in \mathbb{R}^{d}, x^{\top} A x>0$.

For a vector $x$, we use $\|x\|_{2}:=\left(\sum_{i} x_{i}^{2}\right)^{1 / 2}$ to denote the $\ell_{2}$ norm of $x$, we use $\|x\|_{1}:=\sum_{i}\left|x_{i}\right|$ to denote the $\ell_{1}$ norm of $x$, we use $\|x\|_{\infty}$ to denote the $\ell_{\infty}$ norm.

For a vector $x \in \mathbb{R}^{d}$ and a psd matrix $A \in \mathbb{R}^{d \times d}$, we use $\|x\|_{A}:=\left(x^{\top} A x\right)^{1 / 2}$ to denote the matrix norm of $x$ over $A$.

We use $\mathbb{S}^{d-1}$ to denote the unit sphere.

We start with the definition of the Episodic Markov decision process.
Definition 7.1 (Episodic Markov decision process (episodic MDP)). Let $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ denotes the episodic Markov decision process, where $\mathcal{S}$ denotes the set of available states, $\mathcal{A}$ denotes the set of available actions, $H \in \mathbb{N}$ denotes the total number of steps in each episode, $\mathbb{P}=\left\{\mathbb{P}_{h}\right\}_{h=1}^{H}$ with $\mathbb{P}_{h}\left[s^{\prime} \mid s, a\right]$ denotes the probability of transition from state $s \in \mathcal{S}$ to state $s^{\prime} \in \mathcal{S}$ when take actions $a \in \mathcal{A}$ at step $h, r=\left\{r_{h}\right\}_{h=1}^{H}$ denotes the reward obtained at each step. Here the reward $r_{h}$ is a function that maps $\mathcal{S} \times \mathcal{A}$ to $[0.55,1]^{\mathrm{vi}}$

Note that for any reward range $[a, b]$, there exists a shift $c$ and scaling $\alpha$ so that $(a+c) / \alpha=0.55$ and $(b+c) / \alpha=1$ The shift in reward is designed for sublinear runtime in maximum inner product search. We will provide more discussion in Section 8.5.

In this work, we focus on linear Markov decision process (linear MDP). In this setting, each pair of state-action is represented as an embedding vector. Moreover, the transition probability $\mathbb{P}_{h}\left[s^{\prime} \mid s, a\right]$ and reward function $r_{h}$ are linear in this embedding vector.

Definition 7.2 (Linear MDP [BB96, MR07]). The $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ becomes a linear MDP if there exists a function $\phi: \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}^{d}$ and an unknown signed measure set $\mu_{h}=\left(\mu_{h}^{(1)}, \ldots, \mu_{h}^{(d)}\right)$ over $\mathcal{S}$ such that the transition probability $\mathbb{P}_{h}\left[s^{\prime} \mid s, a\right]=\left\langle\phi(s, a), \mu_{h}\left(s^{\prime}\right)\right\rangle$ at any step any $h \in[H]$. Here we assume $\max _{(s, a) \in \mathcal{S} \times \mathcal{A}}\|\phi(s, a)\|_{2} \leq 1$. Moreover, there exists a hidden vector $\theta_{h} \in \mathbb{R}^{d}$ so that $r_{h}(s, a)=\left\langle\phi(s, a), \theta_{h}\right\rangle$. Here we assume $\max _{h \in[H]}\left\{\left\|\mu_{h}(\mathcal{S})\right\|_{2},\left\|\theta_{h}\right\|_{2}\right\} \leq \sqrt{d}$.

In the MDP framework, we define the policy $\pi$ as a sequence of functions that map state to actions.

[^5]Definition 7.3 (Policy). Given a MDP with form $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$, a policy $\pi=\left\{\pi_{1}, \cdots, \pi_{H}\right\}$ is defined as sequence such that $\pi_{h}: \mathcal{S} \rightarrow \mathcal{A}$ for each step $h . \pi_{h}(s)=a$ represents the action taken when we are at state $s$ and step $h$.

Moreover, we use $V_{h}^{\pi}(s): \mathcal{S} \rightarrow \mathbb{R}$ to define the value of cumulative rewards in expectation if the agent follows received under a given policy $\pi$ when the start state is $s$ and the start step is $h$.
Definition 7.4 (Value function). Given a $M D P$ with form $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$, we let the value function be:

$$
V_{h}^{\pi}(s):=\mathbb{E}\left[\sum_{h^{\prime}=h}^{H} r_{h}\left(s_{h}^{\prime}, \pi_{h}\left(s_{h}^{\prime}\right)\right) \mid s_{h}=s\right], \quad \forall s \in \mathcal{S}, h \in[H] .
$$

Further more, we define the Q function $Q_{h}^{\pi}(s, a): \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}$ as the expected cumulative rewards if a agent follows policy $\pi$ and starts from takeing action $a$ at state $s$ and step $h$. This representation of $Q_{h}^{\pi}(s, a)$ is also associated with the well-known Bellman equation [SB18].
Definition 7.5 (Q-Learning). Let $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ denotes an episodic MDP. We use a simplified notation $\left[\mathbb{P}_{h} V_{h+1}\right](s, a):=\mathbb{E}_{s^{\prime} \sim \mathbb{P}_{h}\left[s^{\prime} \mid s, a\right]}\left[V_{h+1}\left(s^{\prime}\right)\right]$. Then, we represent the Bellman equation with policy $\pi$ as

$$
Q_{h}^{\pi}(s, a)=\left[r_{h}+\mathbb{P}_{h} V_{h+1}^{\pi}\right](s, a), \quad V_{h}^{\pi}(s)=Q_{h}^{\pi}\left(s, \pi_{h}(s)\right), \quad V_{H+1}^{\pi}(s)=0 .
$$

Similarly, for optimal policy $\pi^{*}$, we have

$$
\begin{equation*}
Q_{h}^{*}(s, a)=\left[r_{h}+\mathbb{P}_{h} V_{h+1}^{*}\right](s, a), \quad V_{h}^{*}(s)=\max _{a \in \mathcal{A}} Q_{h}^{*}(s, a), \quad V_{H+1}^{*}(s)=0 . \tag{5}
\end{equation*}
$$

Note that as $r_{h} \in[0,1]$. All $Q_{h}^{\pi}$ and $V_{h}^{\pi}$ are upper bounded by $H+1-h$.
After formulate the MDP and its value functions, we start listing conditions on the space of state and action for the convenience of our Sublinear LSVI and Sublinear LSVI-UCB. We first present the definition for the convex hull.
Definition 7.6 (Convex hull). Given a set $\left\{x_{1}, x_{2}, \cdots, x_{n}\right\} \subset \mathbb{R}^{d}$ that denotes as a matrix $A \in$ $\mathbb{R}^{d \times n}$, we define its convex hull $\mathcal{B}(A)$ to be the collection of all finite linear combinations $y$ that satisfies $y=\sum_{i=1}^{n} a_{i} \cdot x_{i}$, where $a_{i} \in[0,1]$ for all $i \in[n]$ and $\sum_{i \in[n]} a_{i}=1$.

In this work, we focus on the Sublinear LSVI under continuous state and action space. Given the action space $\mathcal{A}$ and state space $\mathcal{S}$, we formulate $\phi((\mathcal{S} \times \mathcal{A}))$ as the convex hull of $\phi\left(\mathcal{S}_{\text {core }} \times \mathcal{A}_{\text {core }}\right)$, where $\mathcal{S}_{\text {core }}$ is core state set and $\mathcal{A}_{\text {core }}$ is core action set.

Definition 7.7 (Core state and core action sets). Given a linear MDP with form $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$, we define set $\mathcal{S}_{\text {core }} \subset \mathcal{S}$ as the core states set and $\mathcal{A}_{\text {core }} \subset \mathcal{A}$ as the core action set. We denotes cardinality of $\mathcal{S}_{\text {core }}$ and $\mathcal{A}_{\text {core }}$ as $S$ and $A$. Specifically, we have $\mathcal{B}\left(\phi\left(\mathcal{S}_{\text {core }} \times \mathcal{A}_{\text {core }}\right)\right)=\phi(\mathcal{S} \times \mathcal{A})$. Without loss of generality, we let $A \geq d$.

In LSVI [BB96], the value iteration procedure requires a span matrix that contains state-action embeddings. Moreover, there also exists a series of assumptions on the span matrix. We provide these assumptions as below:

Definition 7.8 (Span matrix). Given a linear MDP with form $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$, we define the span matrix $\Phi \in \mathbb{R}^{d \times M}$ as follows: in total $M \leq d$ columns, the $j$ th column is denoted as $\phi_{j}=$ $\phi\left(s_{j}, a_{j}\right)$, where $\left(s_{j}, a_{j}\right) \in \mathcal{S} \times \mathcal{A}$. Moreover, $\left\{\phi_{1}, \phi_{2}, \cdots, \phi_{M}\right\}$ is the linear span of $\phi(S \times A)$. Specifically, $\Phi$ satisfies:

- $\phi(s, a)=\sum_{j=1}^{M} w_{j} \phi_{j}, w_{j} \in \mathbb{R}$ for all $(s, a) \in \mathcal{S} \times \mathcal{A}$,
- $\operatorname{rank}(\Phi)=M$,
- $\max _{(s, a) \in \mathcal{S} \times \mathcal{A}}\left\|\Phi^{-1} \phi(s, a)\right\|_{1} \leq L$.

Next, we follow [JYWJ20] and making assumptions for Sublinear LSVI-UCB. Given a linear $\operatorname{MDP}$ with form $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$, we assume $\mathcal{S}$ is finite with cardinally $S$ and $\mathcal{A}$ is finite with cardinally $A$.

### 7.3 Standard Proprieties of Linear MDP

We list the tools for analyzing linear MDPs properties from [JSWZ21] in this section.
Lemma 7.9 (Proposition 2.3 [JYWJ20]). The $Q$ function with form $Q_{h}^{\pi}(s, a)$ in linear MDP could be represented it as a inner product $Q_{h}^{\pi}(s, a)=\left\langle\phi(s, a), w_{h}^{\pi}\right\rangle$, where $w_{h}^{\pi} \in \mathbb{R}^{d}$ is a weight vector.

Next, we show the upper bound of weight $w_{h}^{\pi}$ for any policy $\pi$.
Lemma 7.10 (Lemma B. 2 [JYWJ20]). Given a linear MDP, let w $w_{h}^{\pi}$ denotes the weight that achieves $Q_{h}^{\pi}(s, a)=\left\langle\phi(s, a), w_{h}^{\pi}\right\rangle$ for all $(s, a) \in \mathcal{S} \times \mathcal{A}$ at step $h \in[H]$. We show that for $\left\|w_{h}^{\pi}\right\|_{2} \leq 2 H \sqrt{d}$ for any $h \in[H]$,

### 7.4 Locality Sensitive Hashing

We define locality sensitive hashing (LSH). These definitions are very standard, e.g., see Indyk and Motwani [IM98].

Definition 7.11 (Locality Sensitive Hashing). Let dist denotes a metric distance. Let $\bar{c}$ denote $a$ parameter such that $\bar{c}>1$. Let $p_{1}, p_{2}$ denote two parameters such that $0<p_{2}<p_{1}<1$. A family $\mathcal{H}$ is called $\left(r, \bar{c} \cdot r, p_{1}, p_{2}\right)$-sensitive if and only if, for any two point $x, y \in \mathbb{R}^{d}$, $h$ chosen uniformly from $\mathcal{H}$ satisfies the following:

- if $\operatorname{dist}(x, y) \leq r$, then $\operatorname{Pr}_{h \sim \mathcal{H}}[h(x)=h(y)] \geq p_{1}$,
- if $\operatorname{dist}(x, y) \geq \bar{c} \cdot r$, then $\operatorname{Pr}_{h \sim \mathcal{H}}[h(x)=h(y)] \leq p_{2}$.

We focus on situations where dist is $\ell_{2}$ or cosine distance.
LSH is designed to accelerate the runtime of the Approximate Nearest Neighbor (ANN) problem. We start with define the exact NN problem as:

Definition 7.12 (Exact Nearest Neighbor (NN)). Given an n-point dataset $Y \subset \mathbb{S}^{d-1}$ on the sphere, the goal of the Nearest Neighbor (NN) problem is to find a datapoint $y \in Y$ for a query $x \in \mathbb{S}^{d-1}$ such that

$$
\mathrm{NN}(x, Y):=\min _{y \in Y}\|x-y\|_{2} .
$$

[IM98] relax the NN problem in Definition 7.12 as with approximation and define the Approximate Nearest Neighbor (ANN) problem.

Definition 7.13 (Approximate Nearest Neighbor (ANN)). Let $\bar{c}>1$ and $r \in(0,2)$. Given an $n$-point dataset $P \subset \mathbb{S}^{d-1}$ on the sphere, the goal of the $(\bar{c}, r)$-Approximate Near Neighbor problem (ANN) is to build a data structure that, given a query $q \in \mathbb{S}^{d-1}$ with the promise that there exists a datapoint $p \in P$ with $\|p-q\|_{2} \leq r$ reports a datapoint $p^{\prime} \in P$ within distance $\bar{c} \cdot r$ from $q$.

Then, the query complexity of ANN is reduced to sublinear by LSH following Theorem 7.14 and Theorem 7.15. Note that here we write $O(1 / \sqrt{\log n})$ as $o(1)$.

Theorem 7.14 (Andoni and Razenshteyn [AR15]). Let $\bar{c}>1$ and $r \in(0,2)$. The ( $\bar{c}, r)$-ANN on a unit sphere $\mathbb{S}^{d-1}$ can be solved with query time $O\left(d \cdot n^{\rho}\right)$, space $O\left(n^{1+\rho}+d n\right)$ and preprocessing time $O\left(d n^{1+\rho}\right)$, where $\rho=\frac{1}{2 \bar{c}^{2}-1}+o(1)$.

Theorem 7.15 (Andoni, Laarhoven, Razenshteyn and Waingarten [ALRW17]). Let $\bar{c}>1$ and $r \in(0,2)$. The ( $\bar{c}, r)$-ANN on a unit sphere $\mathbb{S}^{d-1}$ can be solved with query time $O\left(d \cdot n^{\rho}\right)$, space $O\left(n^{1+o(1)}+d n\right)$ and preprocessing time $O\left(d n^{1+o(1)}\right)$, where $\rho=\frac{2}{\bar{c}^{2}}-\frac{1}{\bar{c}^{4}}+o(1)$.

In this work, we focus on the Max-IP, which is a well-known problem in the field of computational complexity, we follow the standard notation in this work [Che18]. We define the exact and approximate Max-IP problem as follows:

Definition 7.16 (Exact Max-IP). Given a data set $Y \subseteq \mathbb{R}^{d}$, we define Max-IP for a query point $x \in \mathbb{R}^{d}$ with respect to $Y$ as follows:

$$
\operatorname{Max}-\operatorname{IP}(x, Y):=\max _{y \in Y}\langle x, y\rangle .
$$

Definition 7.17 (Approximate Max-IP). Let $c \in(0,1)$ and $\tau \in(0,1)$. Given an n-point dataset $Y \subset \mathbb{S}^{d-1}$, the goal of the $(c, \tau)$-Max-IP is to build a data structure that, given a query $x \in \mathbb{S}^{d-1}$ with the promise that there exists a datapoint $y \in Y$ with $\langle x, y\rangle \geq \tau$, it reports a datapoint $z \in Y$ with similarity $\langle x, z\rangle \geq c \cdot \operatorname{Max}-\operatorname{IP}(x, Y)$.

To solve $(c, \tau)$-Max-IP, we define a dual version of LSH data structure (Shrivastava and Li [SL14] call it asymmetric LSH):

Definition 7.18 (Asymmetric Locality Sensitive Hashing). Let $c$ denotes a parameter such that $c \in(0,1)$. Let $\tau$ denotes a parameter such that $\tau>0$. Let $p_{1}, p_{2}$ denote two parameters such that $0<p_{2}<p_{1}<1$. Let $\operatorname{sim}(x, y)$ denote a binary similarity function between $x, y \in \mathbb{R}^{d}$. A family $\mathcal{H}$ is called $\left(\tau, c \cdot \tau, p_{1}, p_{2}\right)$-sensitive if and only if, for any query point $x \in \mathbb{R}^{d}$ and a data point $y \in \mathbb{R}^{d}$, $h$ chosen uniformly from $\mathcal{H}$ satisfies the following:

- if $\operatorname{sim}(x, y) \geq \tau$ then $\operatorname{Pr}_{h \sim \mathcal{H}}[h(x)=h(y)] \geq p_{1}$,
- if $\operatorname{sim}(x, y) \leq c \cdot \tau$ then $\operatorname{Pr}_{h \sim \mathcal{H}}[h(x)=h(y)] \leq p_{2}$.

It is shown from [SL14] that LSH type data structure with asymmetric transformations could achieve sublinear runtime complexity of $(c, \tau)$-Max-IP.

### 7.5 Probabilistic Tools

Lemma 7.19 (Hoeffding bound [Hoe63]). Let $x_{1}, \cdots, x_{n}$ be $n$ independent bounded variables in $\left[a_{i}, b_{i}\right]$. Let, then we show the Hoeffding bound over $x=\sum_{i=1}^{n} x_{i}$ as:

$$
\operatorname{Pr}[|x-\mathbb{E}[x]| \geq t] \leq 2 \exp \left(-\frac{2 t^{2}}{\sum_{i=1}^{n}\left(b_{i}-a_{i}\right)^{2}}\right)
$$

### 7.6 Inequalities

In this sections, we present the supporting inequalities for our work.
Fact 7.20 (Lemma D. 1 in [JYWJ20]). Given a matrix $\Lambda_{t}=\lambda \mathbf{I}_{d}+\sum_{i=1}^{t} \phi_{i} \phi_{i}^{\top}$ with $\phi_{i} \in \mathbb{R}^{d}$ and $\lambda>0$, we show that:

$$
\sum_{i=1}^{t} \phi_{i}^{\top}\left(\Lambda_{t}\right)^{-1} \phi_{i} \leq d
$$

Lemma 7.21 (Lemma D. 4 in [JYWJ20]). Let $\mathcal{V}$ denotes a function family that $\max _{V \in \mathcal{V}, x \in \mathcal{S}}|V(x)| \leq$ $H$. Let $G$ denotes the $\epsilon$-covering number of $\mathcal{V}$. Let $\mathcal{S}$ denotes a state space. Let $\left\{\mathcal{F}_{\tau}\right\}_{\tau=0}^{\infty}$ denotes the filtration of $\mathcal{S}$. Let $\left\{x_{\tau}\right\}_{\tau=1}^{\infty}$ denotes a random process defined on $\mathcal{S}$. Let $\left\{\phi_{\tau}\right\}_{\tau=0}^{\infty}$ denotes a real valued random process in $\mathbb{R}^{d}$. Moreover, $\phi_{\tau} \in \mathcal{F}_{\tau-1}$ and we have upper bound $\left\|\phi_{\tau}\right\|_{2} \leq 1$. Given a matrix $\Lambda_{k} \in \mathbb{R}^{d \times d}$ so that $\Lambda_{k}=\lambda I_{d}+\sum_{\tau=1}^{k} \phi_{\tau} \phi_{\tau}^{\top}$, for any $\delta>0$, for any $k \geq 0$, for any $V \in \mathcal{V}$, we have

$$
\left\|\sum_{\tau=1}^{k} \phi_{\tau}\left(V\left(x_{\tau}\right)-\mathbb{E}\left[V\left(x_{\tau}\right) \mid \mathcal{F}_{\tau-1}\right]\right)\right\|_{\Lambda_{k}^{-1}}^{2} \leq 4 H^{2}\left(d \log (1+k / \lambda)+\log \left(G_{\epsilon} / \delta\right)\right)+8 k^{2} \epsilon^{2} / \lambda,
$$

## 8 Data Structures

This section presents the data Structures for our work.

- In Section 8.1, we introduce the transformations that build primal-dual connections between approximate Max-IP and ANN.
- In Section 8.2, we present our data structure that achieves sublinear query time in approximate Max-IP.
- In Section 8.3, we show how to perform approximate Max-MatNorm via approximate Max-IP data structure.
- In Section 8.4, we present our efficient transformations for Max-IP in optimization.
- In Section 8.5, we formally provide the theoretical results of sublinear approximate Max-IP using one LSH data structure.
- In Section 8.6, we provide the theoretical results of sublinear approximate Max-IP using another LSH data structure.


### 8.1 Existing Transformation from Primal to Dual

In this section, we show a transformation that builds the connection between Max-IP and NN. Under this asymmetric transformation, NN is formulated as a dual problem of Max-IP.

We start with presenting the asymmetric transformation.
Definition 8.1 (Asymmetric transformation [NS15]). Let $Y \in \mathbb{R}^{d}$ and $\|y\|_{2} \leq 1$ for all $y \in Y$. Let $x \in \mathbb{R}^{d}$ and $\|x\|_{2} \leq D_{x}$. We define the following asymmetric transform:

$$
P(y)=\left[\begin{array}{lll}
y^{\top} & \sqrt{1-\|y\|_{2}^{2}} & 0 \tag{6}
\end{array}\right]^{\top}
$$

$$
Q(x)=\left[\begin{array}{lll}
\left(x D_{x}^{-1}\right)^{\top} & 0 & \sqrt{1-\left\|x D_{x}^{-1}\right\|_{2}^{2}}
\end{array}\right]^{\top}
$$

Therefore, we have

$$
\|Q(x)-P(y)\|_{2}^{2}=2-2 D_{x}^{-1}\langle x, y\rangle, \quad \arg \max _{y \in Y}\langle x, y\rangle=\arg \min _{y \in Y}\|Q(x)-P(y)\|^{2}
$$

In this way, we regard Max-IP as the primal problem and NN as a dual problem.

### 8.2 Sublinear Max-IP Data Structure

In this section, we show the theorem that provides sublinear query time for Max-IP problem using LSH type data structure.
Theorem 8.2 (Formal statement of Corollary 3.5). Let $c \in(0,1)$ and $\tau \in(0,1)$. Given a set of $n$-points $Y \subset \mathcal{S}^{d-1}$ on the sphere, one can construct a data structure with $\mathcal{T}_{\text {init }}$ preprocessing time and $\mathcal{S}_{\text {space }}$ space so that for any query $x \in \mathcal{S}^{d-1}$, we take query time complexity $O\left(d \cdot n^{\rho}\right)$ :

- if $\operatorname{Max-IP}(x, Y) \geq \tau$, then we output a vector in $Y$ which is a $(c, \tau)$-Max-IP with respect to $(x, Y)$ with probability at least $0.9^{\text {vii }}$, where $\rho:=f(c, \tau)+o(1)$.
- otherwise, we output fail.


## Further,

- If $\mathcal{T}_{\text {init }}=O\left(d n^{1+\rho}\right)$ and $\mathcal{S}_{\text {space }}=O\left(n^{1+\rho}+d n\right)$, then $f(c, \tau)=\frac{1-\tau}{1-2 c \tau+\tau}$.
- If $\mathcal{T}_{\text {init }}=O\left(d n^{1+o(1)}\right)$ and $\mathcal{S}_{\text {space }}=O\left(n^{1+o(1)}+d n\right)$, then $f(c, \tau)=\frac{2(1-\tau)^{2}}{(1-c \tau)^{2}}-\frac{(1-\tau)^{4}}{(1-c \tau)^{4}}$.

Proof. We start with showing that for any two points $x, y$ with $\|x\|_{2}=\|y\|_{2}=1$, we have $\|x-y\|_{2}^{2}=$ $2-2\langle x, y\rangle$. This implies that $r^{2}=2-2 \tau$ for a $(\bar{c}, r)$-ANN and a $(c, \tau)$-Max-IP on $x, Y$.

Further, if we have a data structure for $(\bar{c}, r)$-ANN, it automatically becomes a data structure for $(c, \tau)$-Max-IP with parameters $\tau=1-0.5 r^{2}$ and $c=\frac{1-0.5 \bar{c}^{2} r^{2}}{1-0.5 r^{2}}$. This implies that

$$
\bar{c}^{2}=\frac{1-c\left(1-0.5 r^{2}\right)}{0.5 r^{2}}=\frac{1-c \tau}{1-\tau} .
$$

Next, we show how to solve $(c, \tau)$-Max-IP by solving $(\bar{c}, r)$-ANN using two different data structures.

Part 1. If we initialize the data-structure following Theorem 7.14, we show that the $(c, \tau)$ -Max-IP on a unit sphere $\mathcal{S}^{d-1}$ can be solved by solving ( $\bar{c}, r$ )-ANN with query time $O\left(d \cdot n^{\rho}\right)$, space $O\left(n^{1+\rho}+d n\right)$ and preprocessing time $O\left(d n^{1+\rho}\right)$, where

$$
\rho=\frac{1}{2 \bar{c}^{2}-1}+o(1)=\frac{1}{2 \frac{1-c \tau}{1-\tau}-1}+o(1)=\frac{1-\tau}{1-2 c \tau+\tau}+o(1) .
$$

Thus, $f(c, \tau)=\frac{1-\tau}{1-2 c \tau+\tau}$.
Part 2. If we initialize the data-structure following Theorem 7.15, we show that the $(c, \tau)$ -Max-IP on a unit sphere $\mathcal{S}^{d-1}$ can be solved by solving ( $\left.\bar{c}, r\right)$-ANN with query time $O\left(d \cdot n^{\rho}\right)$, space $O\left(n^{1+o(1)}+d n\right)$ and preprocessing time $O\left(d n^{1+o(1)}\right)$, where

$$
\rho=\frac{2}{\bar{c}^{2}}-\frac{1}{\bar{c}^{4}}+o(1)=\frac{2(1-\tau)^{2}}{(1-c \tau)^{2}}-\frac{(1-\tau)^{4}}{(1-c \tau)^{4}}+o(1) .
$$

[^6]Thus, $f(c, \tau)=\frac{2(1-\tau)^{2}}{(1-c \tau)^{2}}-\frac{(1-\tau)^{4}}{(1-c \tau)^{4}}$.

In practice, we tune parameter $\tau$ close to $\operatorname{Max}-\operatorname{IP}(x, Y)$ to achieve higher $c$. Moreover, Theorem 8.2 could be applied to general Max-IP problem. To do this, we first apply asymmetric transformation in Definition 8.1 and transfer it to a $(c, \tau)$-Max-IP problem over $Q(x)$ and $Q(Y)$. Then, we solve this $(c, \tau)$-Max-IP problem by solving its dual problem, which is $(\bar{c}, r)$-ANN. Finally, the solution to the $(\bar{c}, r)$-ANN would be the approximate solution to the original Max-IP $(x, Y)$. Meanwhile, it is reasonable for us to regard $d=n^{o(1)}$ using Johnson-Lindenstrauss Lemma [JL84].

### 8.3 Sublinear Max-IP Data Structure for Maximum Matrix Norm Search

In this section, we extend LSH type Max-IP data structure for maximum matrix norm search.
Definition 8.3 (Exact Maximum Matrix Norm (Max-MatNorm)). Given a data set $Y \subseteq \mathbb{R}^{d}$ and a query matrix $x \in \mathbb{R}^{d \times d}$, we define Maximum Matrix Norm as follows:

$$
\operatorname{Max-MatNorm}(x, Y):=\max _{y \in Y}\|y\|_{x}
$$

Next, we define the approximate version of the Maximum Matrix Norm.
Definition 8.4 (Approximate Max-MatNorm). Let $c \in(0,1)$ and $\tau \in(0,1)$. Let vec denotes the vectorization of $d \times d$ matrix into a $d^{2}$ vector. Given an $n$-point dataset $Y \subset \mathbb{R}^{d}$ and $y y^{\top} \in \mathbb{S}^{d^{2}-1}$ for all $y \in Y$, the goal of the $(c, \tau)$-Max-MatNorm is to cosntruct a data structure that, given a query matrix $x \in \mathbb{R}^{d \times d}$ and $\operatorname{vec}(x) \in \mathbb{S}^{d^{2}-1}$ with the promise that there exists a datapoint $y \in Y$ with $\|y\|_{x} \geq \tau$, it reports a datapoint $z \in Y$ with $\|z\|_{x} \geq c \cdot \operatorname{Max-MatNorm}(x, Y)$.

Next, we show the relationship between Max-MatNorm and Max-IP
Lemma 8.5 (Relation between Max-MatNorm and Max-IP). We show that

$$
\operatorname{Max}-\operatorname{Mat} \operatorname{Norm}(X, Y)^{2}=\max _{y \in Y}\left\langle\operatorname{vec}(x), \operatorname{vec}\left(y y^{\top}\right)\right.
$$

where vec vectorizes $d \times d$ matrix $x$ into a $d^{2}$ vector.
Proof. We show that

$$
\begin{aligned}
\operatorname{Max-MatNorm}(x, Y)^{2} & =\max _{y \in Y}\|y\|_{x}^{2} \\
& =\max _{y \in Y} y^{\top} x y \\
& =\max _{y \in Y}\left\langle\operatorname{vec}(x), \operatorname{vec}\left(y y^{\top}\right)\right\rangle
\end{aligned}
$$

where the first step follows the definition of Max-MatNorm, the second step follows from the definition of $\|y\|_{x}^{2}$, the third step decomposes the quadratic form into a inner product.

Next, we present our main theorem for Max-MatNorm $(x, Y)$.
Theorem 8.6. Let $c$ denote a parameter such that $c \in(0,1)$. Let $\tau$ denote a parameter such that $\tau \in(0,1)$. Let vec denotes the vectorization of $d \times d$ matrix into a $d^{2}$ vector. Given a n-points set $Y \subseteq \mathbb{R}^{d}$ and $y y^{\top} \in \mathbb{S}^{d^{2}-1}$ for all $y \in Y$, one can construct a data structure with $\mathcal{T}_{\text {init }}$ preprocessing time and $\mathcal{S}_{\text {space }}$ so that for any query matrix $x \in \mathbb{R}^{d \times d}$ with $\operatorname{vec}(x) \in \mathbb{S}^{d^{2}-1}$, we take query time complexity $O\left(d^{2} n^{\rho} \cdot \log (1 / \delta)\right)$ :

- if $\operatorname{Max}-\operatorname{MatNorm}(x, Y) \geq \tau$, then we output a vector in $Y$ which is a $(c, \tau)$-Max-MatNorm with respect to $(x, Y)$ with probability at least $1-\delta$, where $\rho:=f(c, \tau)+o(1)$.
- otherwise, we output fail.

Further,

- If $\mathcal{T}_{\text {init }}=O\left(d^{2} n^{1+\rho} \cdot \log (1 / \delta)\right)$ and $\mathcal{S}_{\text {space }}=O\left(\left(n^{1+\rho}+d^{2} n\right) \cdot \log (1 / \delta)\right)$, then $f(c, \tau)=\frac{1-\tau^{2}}{1-c^{2} \tau^{2}+\tau^{2}}$.
- If $\mathcal{T}_{\text {init }}=O\left(d^{2} n^{1+o(1)} \cdot \log (1 / \delta)\right)$ and $\mathcal{S}_{\text {space }}=O\left(\left(n^{1+o(1)}+d^{2} n\right) \cdot \log (1 / \delta)\right)$, then $f(c, \tau)=$ $\frac{2\left(1-\tau^{2}\right)^{2}}{\left(1-c^{2} \tau^{2}\right)^{2}}-\frac{\left(1-\tau^{2}\right)^{4}}{\left(1-c^{2} \tau^{2}\right)^{4}}$.
Proof. We start with showing that if we have a $\left(c^{2}, \tau^{2}\right)$-Max-IP data structure over vec $(x)$ and every $\operatorname{vec}\left(y y^{\top}\right), y \in Y$, we would obtain a $z \in Y$ such that

$$
\begin{equation*}
\left\langle\operatorname{vec}(x), \operatorname{vec}\left(z z^{\top}\right)\right\rangle \geq c^{2} \max _{y \in Y}\left\langle\operatorname{vec}(x), \operatorname{vec}\left(y y^{\top}\right)\right\rangle, \tag{7}
\end{equation*}
$$

we could use it and derive the following propriety for $z$ :

$$
\begin{aligned}
\|z\|_{x} & =\sqrt{\left\langle\operatorname{vec}(x), \operatorname{vec}\left(z z^{\top}\right)\right\rangle} \\
& \geq \sqrt{c^{2} \max _{y \in Y}\left\langle\operatorname{vec}(x), \operatorname{vec}\left(y y^{\top}\right)\right\rangle} \\
& =c \max _{y \in Y} \sqrt{\left\langle\operatorname{vec}(x), \operatorname{vec}\left(y y^{\top}\right)\right\rangle} \\
& =c \max _{y \in Y}\|y\|_{x}
\end{aligned}
$$

where the second step follows from Eq. (7).
Therefore, $z$ is the solution for $(c, \tau)$-Max-MatNorm $(x, Y)$.
Next, we show how to retrieve $z$ via two data structures used for $(c, \tau)-\operatorname{Max}-\operatorname{IP}(x, Y)$ in Theorem 8.2.

Part 1. If we initialize the data structure following Theorem 7.14, we can construct a data structure with $O\left(\left(n^{1+\rho}+d^{2} n\right) \cdot \log (1 / \delta)\right)$ preprocessing time and $O\left(\left(n^{1+\rho}+d^{2} n\right) \cdot \log (1 / \delta)\right)$ space so that for any query matrix $x \in \mathbb{R}^{d \times d}$ with $\operatorname{vec}(x) \in \mathbb{S}^{d^{2}-1}$, we take query time complexity $O\left(d^{2} n^{\rho} \cdot \log (1 / \delta)\right)$ to retrieve $z$. Here $\rho=\frac{1-\tau^{2}}{1-c^{2} \tau^{2}+\tau^{2}}+o(1)$ and we are able to improve the failure probability to $\delta$ by repeating the LSH for $\log (1 / \delta)$ times.

Part 2. If we initialize the data structure following Theorem 7.15, we can construct a data structure with $O\left(\left(n^{1+o(1)}+d^{2} n\right) \cdot \log (1 / \delta)\right)$ preprocessing time and $O\left(\left(n^{1+o(1)}+d n\right) \cdot \log (1 / \delta)\right)$ space so that for any query matrix $x \in \mathbb{R}^{d \times d}$ with $\operatorname{vec}(x) \in \mathbb{S}^{d^{2}-1}$, we take query time complexity $O\left(d^{2} n^{\rho} \cdot \log (1 / \delta)\right)$ to retrieve $z$. Here $\rho=\frac{2\left(1-\tau^{2}\right)^{2}}{\left(1-c^{2} \tau^{2}\right)^{2}}-\frac{\left(1-\tau^{2}\right)^{4}}{\left(1-c^{2} \tau^{2}\right)^{4}}+o(1)$ and we also improve the failure probability to $\delta$ by repeating the LSH for $\log (1 / \delta)$ times.

Moreover, Theorem 8.6 could be applied to general Max-MatNorm problem. To do this, we first apply transform $(c, \tau)$-Max-MatNorm problem into a $\left(c^{2}, \tau^{2}\right)$-Max-IP problem using Lemma 8.5. Next, we apply transformations in Definition 8.1 and transfer the $\left(c^{2}, \tau^{2}\right)$-Max-IP problem to a $\left(c^{2}, \tau^{2}\right)$-Max-IP problem over $Q(x)$ and $Q(Y)$. Then, we solve this $\left(c^{2}, \tau^{2}\right)$-Max-IP problem by solving its dual problem, which is $(\bar{c}, r)$-ANN. Finally, the solution to the $(\bar{c}, r)$-ANN would be the approximate solution to the original Max-MatNorm $(x, Y)$.

### 8.4 Transformation for Efficient Query

In the optimization problem that could be accelerated by $(c, \tau)$-Max-IP, the query and data vectors are usually not unit vectors so that we apply transformations in Definition 8.1 to map both query and data vectors into unit vectors. However, if the mapped inner product is too close to 1 . The formulation of $\rho$ would break and the time complexity would be linear. To avoid this, we propose a new set of asymmetric transformations:

Definition 8.7 (Efficient asymmetric transformation). Let $Y \in \mathbb{R}^{d}$ and $\|y\|_{2} \leq 1$ for all $y \in Y$. Let $x \in \mathbb{R}^{d}$ and $\|x\|_{2} \leq D_{x}$. We define the following asymmetric transform:

$$
P(y)=\left[\begin{array}{lll}
y^{\top} & \sqrt{1-\|y\|_{2}^{2}} & 0
\end{array}\right]^{\top}, \quad Q(x)=\left[\begin{array}{lll}
\frac{0.8 \cdot x^{\top}}{D_{x}} & 0 & \sqrt{1-\frac{0.64 \cdot\|x\|_{2}^{2}}{D_{x}^{2}}}
\end{array}\right]^{\top} .
$$

Next, we use Lemma 8.8 to show how to enforce $\tau$ to be away from 1 via our efficient asymmetric transformation.

Lemma 8.8. Given the transformation $P$ and $Q$ defined in Definition 8.7, we show that both $\operatorname{Max}-\operatorname{IP}(Q(x), P(Y))$ and $\mathrm{NN}(Q(x), P(Y))$ are equivalent to $\operatorname{Max}-\operatorname{IP}(x, Y)$. Moreover,

$$
\operatorname{Max}-\operatorname{IP}(Q(x), P(Y)) \leq 0.8 .
$$

Proof. Using transformations in Definition 8.7, for all $y \in Y$, we have

$$
Q(x)^{\top} P(y)=\frac{0.8 \cdot x^{\top} y}{D_{x}} \leq 0.8 \cdot \frac{\|x\|_{2}\|y\|_{2}}{D_{x}} \leq 0.8
$$

where the third step follows from $\|x\|_{2} \leq D_{x}$ and $\|y\|_{2} \leq 1$.
Next, we show that $\operatorname{Max}-\operatorname{IP}(Q(x), P(Y))$ is equivalent to $\operatorname{Max}-\operatorname{IP}(x, Y)$.

$$
\arg \max _{y \in Y} Q(x)^{\top} P(y)=\arg \max _{y \in Y} \frac{0.8 \cdot\langle x, y\rangle}{D_{x}}=\arg \max _{y \in Y}\langle x, y\rangle .
$$

Further more, $\mathrm{NN}(Q(x), P(Y))$ (see Definition 7.12) is equivalent to $\operatorname{Max}-\operatorname{IP}(x, Y)$.

$$
\|Q(x)-P(y)\|_{2}^{2}=2-1.6 D_{x}^{-1}\langle x, y\rangle, \quad \arg \min _{y \in Y}\|Q(x)-P(y)\|^{2}=\arg \max _{y \in Y}\langle x, y\rangle .
$$

### 8.5 Sublinear Query Time: Part 1

In this section, we show that $\rho$ is strictly less than 1 using LSH in [AR15].
Lemma 8.9. If LSH data structure's parameters $c$ and $\tau$ satisfy that $c \in[0.5,1)$ and $\tau \in[0.5,1)$ then, we could upper bound $\rho$ as:

$$
\rho<1-\frac{\gamma}{2}+O(1 / \sqrt{\log n})
$$

where $\gamma=1-c$.

Proof. We can upper bound $\rho$ as follows:

$$
\begin{array}{rlr}
\rho & =\frac{1-\tau}{1-2 c \tau+\tau}+O(1 / \sqrt{\log n}) & \\
& =1-\frac{2 \tau-2 c \tau}{1-2 c \tau+\tau}+O(1 / \sqrt{\log n}) & \\
& =1-(1-c) \cdot \frac{2 \tau}{1-2 c \tau+\tau}+O(1 / \sqrt{\log n}) & \text { by } \tau \geq 0.5 \\
& \leq 1-(1-c) \cdot \frac{1}{1-2 c \tau+\tau}+O(1 / \sqrt{\log n}) & \text { by } \tau<1 \\
& <1-(1-c) \cdot \frac{1}{2}+O(1 / \sqrt{\log n}) &
\end{array}
$$

where the second and third steps are reorganizations, the forth step follows from $\tau \geq 0.5$, the fifth step follows from $\tau<1$ and $c \geq 0.5$, the last step is a reorganization.

Therefore, we complete the proof.
For Sublinear LSVI, we set $c=1-C_{0} L \sqrt{\iota / n}$ and and $\tau \geq 0.5$ by shifting the reward function. In this way, we have

$$
\begin{equation*}
\rho<1-\frac{C_{0} L \sqrt{\iota / n}}{2}+O\left(\frac{1}{\sqrt{\log A}}\right)<1-\frac{1}{4} C_{0} L \sqrt{\iota / n} \tag{8}
\end{equation*}
$$

where the first step follows from $\gamma=1-c=C_{0} L \sqrt{\iota / n}$, the second step follows from $\frac{1}{4} C_{0} L \sqrt{\iota / n}>$ $\Omega\left(\frac{1}{\sqrt{\log A}}\right)$.

For Sublinear LSVI-UCB, we set $c=1-\frac{1}{\sqrt{K}}$ and $\tau \geq 0.5$ by shifting the reward function. In this way, we have

$$
\begin{equation*}
\rho<1-\frac{1}{2 \sqrt{K}}+O\left(\frac{1}{\sqrt{\log A}}\right)<1-\frac{1}{4 \sqrt{K}} \tag{9}
\end{equation*}
$$

where the first step follows from $\gamma=1-c=\frac{1}{\sqrt{K}}$, the second step follows from $\frac{1}{4 \sqrt{K}}>\Omega\left(\frac{1}{\sqrt{\log A}}\right)$.
Therefore, we show that sublinear value iteration can be achieved while preserving the same regret.

### 8.6 Sublinear Query Time: Part 2

In this section, we show that $\rho$ is strictly less than 1 using LSH in [ALRW17].
Using [ALRW17], the $\rho$ for LSH based Max-IP data structure with parameters $c$ and $\tau$ becomes

$$
\rho=\frac{2(1-\tau)^{2}}{(1-c \tau)^{2}}-\frac{(1-\tau)^{4}}{(1-c \tau)^{4}}+o(1)
$$

where is a function over $c$ and $\tau$.
To upper bound the $\rho$, we start with showing that it is decreasing as $\tau$ increase when $c \in[0.5,1)$ and $\tau \in[0.5,1)$.

Lemma 8.10. Let $c \in[0.5,1)$ and $\tau \in[0.5,1)$. We show that function

$$
f(c, \tau):=\frac{2(1-\tau)^{2}}{(1-c \tau)^{2}}-\frac{(1-\tau)^{4}}{(1-c \tau)^{4}}
$$

is decreasing as $\tau$ increase.

Proof. We take the derivative of $f(c, \tau)$ in $\tau$ and get

$$
\frac{\partial}{\partial \tau} f(c, \tau)=-\frac{4(c-1)^{2}(\tau-1) \tau(c \tau+\tau-2)}{(1-c \tau)^{5}}<0
$$

where the second step follows from $c \in[0.5,1)$ and $\tau \in[0.5,1)$.
Thus, $f(c, \tau)$ is decreasing as $\tau$ increase when $c \in[0.5,1)$ and $\tau \in[0.5,1)$.

Next, we have our results in upper bounding $\rho$.
Lemma 8.11. If LSH data structure's parameters $c$ and $\tau$ satisfy that $c \in[0.5,1)$ and $\tau \in[0.5,1)$ then, we could upper bound $\rho$ as:

$$
\rho<1-\frac{\gamma^{2}}{4}+O(1 / \sqrt{\log n})
$$

where $\gamma=1-c$.
Proof. Let $\gamma=1-c$, we have

$$
\begin{array}{rlr}
\rho & =\frac{2}{\bar{c}^{2}}-\frac{1}{\bar{c}^{4}}+O(1 / \sqrt{\log n}) \\
& =\frac{2(1-\tau)^{2}}{(1-c \tau)^{2}}-\frac{(1-\tau)^{4}}{(1-c \tau)^{4}}+O(1 / \sqrt{\log n)} \\
& \leq \frac{0.5}{(1-0.5 c)^{2}}-\frac{0.0625}{(1-0.5 c)^{4}}+O(1 / \sqrt{\log n}) \\
& =\frac{0.5}{(0.5+0.5 \gamma)^{2}}-\frac{0.0625}{(0.5+0.5 \gamma)^{4}}+O(1 / \sqrt{\log n)} \\
& =\frac{2}{(1+\gamma)^{2}}-\frac{1}{(1+\gamma)^{4}}+O(1 / \sqrt{\log n)} \\
& =\frac{2+4 \gamma+2 \gamma^{2}-1}{(1+\gamma)^{4}}+O(1 / \sqrt{\log n)} & \\
& =\frac{1+4 \gamma+2 \gamma^{2}}{(1+\gamma)^{4}}+O(1 / \sqrt{\log n)} & \\
& =1-\frac{4 \gamma^{2}+4 \gamma^{3}+\gamma^{4}}{(1+\gamma)^{4}}+O(1 / \sqrt{\log n)} & \text { by } \gamma>0 \\
& <1-\frac{4 \gamma^{2}}{(1+\gamma)^{4}}+O(1 / \sqrt{\log n)} & \text { by } \gamma<1
\end{array}
$$

where the second step follows from $\bar{c}^{2}=\frac{1-c \tau}{1-\tau}$, the third step follows from that $\rho$ is monotonic decrease as $\tau$ increase and $\tau \geq 0.5$, the forth to eighth steps are reorganizations, the ninth step follows from $\gamma=1-c>0$, the tenth step follows from $\gamma=1-c<1$.

For Sublinear LSVI, we set $c=1-C_{0} L \sqrt{\iota / n}$ and and $\tau \geq 0.5$ by shifting the reward function. In this way, we have

\rho<1-\frac{C_{0}^{2} L^{2} \iota}{4 n}+O\left(\frac{1}{\sqrt{\log A}}\right)<1-\frac{1}{8} C_{0}^{2} L^{2} \iota / n \tag{10}
\end{equation*}

where the first step follows from $\gamma=1-c=C_{0} L \sqrt{\iota / n}$, the second step follows from $\frac{1}{8} C_{0}^{2} L^{2} \iota / n>$ $\Omega\left(\frac{1}{\sqrt{\log A}}\right)$.

For Sublinear LSVI-UCB, we set $c=1-\frac{1}{\sqrt{K}}$ and $\tau \geq 0.5$ by shifting the reward function. In this way, we have

\rho<1-\frac{1}{4 K}+O\left(\frac{1}{\sqrt{\log A}}\right)<1-\frac{1}{8 K} \tag{11}
\end{equation*}
$$

where the first step follows from $\gamma=1-c=\frac{1}{\sqrt{K}}$, the second step follows from $\frac{1}{8 K}>\Omega\left(\frac{1}{\sqrt{\log A}}\right)$.
Therefore, we show that sublinear value iteration can be achieved while preserving the same regret.

## 9 Sublinear Least-Squares Value Iteration

This section presents the Sublinear Least-Squares Value Iteration (Sublinear LSVI)

- In Section 9.1, we introduce the Sublinear LSVI algorithm.
- In Section 9.2, we provide the upper bound of the difference between the optimal value function and the estimated value function.
- In Section 9.3, we present the regret analysis of Sublinear LSVI.
- In Section 9.4, we perform a runtime analysis on the building blocks of Sublinear LSVI to analyze its efficiency.
- In Section 9.5, we compare Sublinear LSVI with LSVI [BB96] in regret and value iteration complexity.


### 9.1 Algorithm

We present our Sublinear LSVI algorithm in Algorithm 1. We summarize our algorithm as several steps: (1) sample collection: we query a pair of state and action in the span matrix for $n$ times at each step and observe its reward and next state, (2) data structure construction, we preprocess the embeddings for state and action pairs and build a nearest neighbor data structure, (3) we perform least-squares solver to estimate the weight in the linear MDP model, (4) we use LSH for value function estimation, (5) we construct policy based on the estimated value function.

### 9.2 Value Difference

In this section, we provide the tools for regret analysis. The goal of this section is to prove Lemma 9.1.

Lemma 9.1. Let $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ denotes a linear $\operatorname{MDP}$. Let $V_{1}^{*}(s)$ be the optimal value function defined in Definition 7.5. Let $\widehat{V}_{1}(s)$ be the estimated value function defined in Definition 7.5. We show that via Algorithm 1, the difference $V_{1}^{*}(s)-\widehat{V}_{1}(s)$ is upper bounded by:

V_{1}^{*}(s)-\widehat{V}_{1}(s) \leq \underset{\pi^{*}}{\mathbb{E}}\left[\sum_{h=1}^{H}\left[\left(\mathbb{P}_{h}-\widehat{\mathbb{P}}_{h}\right) \widehat{V}_{h+1}\right]\left(s_{h}, a_{h}\right) \mid s_{1}=s\right]+\frac{1-c}{2} \cdot H(H+1) \tag{12}
\end{equation*}
$$

where $c$ is the parameter for Max-IP.
Proof. We start with lower bounding $\widehat{V}_{h}(s)$ as

where the first step follows from Theorem 8.2, the second step follows from the definition of $\widehat{Q}_{h}(s, a)$ in Definition 7.5 and the definition of convex hull.

Next, we upper bound $V_{h}^{*}(s)-\widehat{V}_{h}(s)$ as

Next, we can write the difference $Q_{h}^{*}(s, a)-\widehat{Q}_{h}(s, a)$ as,

Combining Eq. (14) and Eq. (15), we have

where the first step follows the Eq. (14), the second step follows the Eq. (15), the third step rewrites both terms into an expectation over $\pi^{*}$, and the last step follows the definition of $V_{h+1}^{*}$ and $\widehat{V}_{h+1}$.

Using induction from 1 to $H$, we have

where the second step is a reorganization.

### 9.3 Regret Analysis

The goal of this section is to prove Theorem 9.2.
Theorem 9.2 (Convergence Result of Sublinear Least-Squares Value Iteration (Sublinear LSVI), a formal version of Theorem 4.1). Given a linear MDP with form $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ with core sets $\mathcal{S}_{\text {core }}, \mathcal{A}_{\text {core }}$ defined in Definition 7.7, if we chose $n=O\left(C_{0}^{2} \cdot \epsilon^{-2} L^{2} H^{4} \iota\right)$, where $\iota=\log (H d / p)$ and $C_{0}$ is a constant, the Sublinear LSVI (Algorithm 1) with approximate Max-IP parameter $c=$ $1-\Theta(L \cdot \sqrt{\iota / n})$ has regret at most $O\left(L H^{2} \sqrt{\iota / n}\right)$ with probability at least $1-p$.

Proof. We have two definitions for $\widehat{Q}_{h}(s, a)$. The first definition is given by Definition 7.1, it says

= & \phi(s, a)^{\top} \theta_{h}+\int\left(\phi(s, a)^{\top} \Lambda^{-1} \sum_{\left(\dot{s}, \dot{a}, \dot{s}_{l}^{\prime}\right) \in \mathcal{D}_{h}} \phi(\dot{s}, \dot{a}) \delta\left(s^{\prime}, \dot{s}_{l}^{\prime}\right)\right) \widehat{V}_{h+1}\left(s^{\prime}\right) \mathrm{d} s^{\prime} \\
= & r_{h}(s, a)+\int\left(\phi(s, a)^{\top} \Lambda^{-1} \sum_{\left(\dot{s}, \dot{a}, \dot{s} \dot{l}_{l}^{\prime}\right) \in \mathcal{D}_{h}} \phi(\dot{s}, \dot{a}) \delta\left(s^{\prime}, \dot{s}_{l}^{\prime}\right)\right) \widehat{V}_{h+1}\left(s^{\prime}\right) \mathrm{d} s^{\prime} \tag{18}

where the first step follows the definition of $\widehat{Q}_{h}(s, a)$ in Definition 7.5, the second step follows the definition of $\widehat{w}_{h}$ in Algorithm 4, the third step follows the definition of reward $r_{h}$ in Definition 7.2, the forth step is an reorganization, the fifth step follows from $\Lambda^{-1} \sum_{\left(\dot{s}, \dot{a}, \dot{s}_{l}{ }^{\prime}\right) \in \mathcal{D}_{h}} \phi(\dot{s}, \dot{a}) \phi(\dot{s}, \dot{a})^{\top}=\mathbf{I}_{d}$, the sixth step rewrites the second term in a integral format, where $\delta(x, y)$ is a Dirichlet function, the last step follows the definition of reward $r_{h}$ in Definition 7.2.

By comparing Eq. (18) with Eq. (16), we should define $\widehat{\mathbb{P}}_{h}\left(s^{\prime} \mid s, a\right)$ as

### 9.4 Running Time Analysis

Lemma 9.3. The running time of pre-computing $\Lambda^{-1}$ takes

Computing the inverse matrix of $\Lambda$ takes $O\left(d^{\omega}\right)$. Combining the complexity together, we obtain the pre-computing complexity $O\left(M d^{2}+d^{\omega}\right)$.

Lemma 9.4. The running time of updating value takes

- It takes $O\left(S d A^{\rho}\right)$ to compute $\widehat{V}_{h}\left(s_{j l}^{\prime}\right)$ for each state $s_{j} \in \mathcal{S}_{\text {core. }}$. If we initialize the LSH datastructure using Theorem 7.14, we determine $\rho=1-\frac{1}{4} C_{0} L \sqrt{\iota / n}$ using Lemma 8.9. If we initialize the LSH data-structure using Theorem 7.15, we determine $\rho=1-\frac{1}{8} C_{0}^{2} L^{2} \iota / n$ using Lemma 8.10.
- It takes $O(M n)$ to compute $r_{h}\left(s_{j}, a_{j}\right)+\frac{1}{n} \sum_{l=1}^{n} \widehat{V}_{h+1}\left(s_{j l}^{\prime}\right)$ for the total $n$ number of $s_{j l}^{\prime}$ observed by $\left(s_{j}, a_{j}\right)$.
- It takes $O(M d)$ to sum up the $M$ dimensional vector $\phi\left(s_{j}, a_{j}\right)\left(r_{h}\left(s_{j}, a_{j}\right)+\frac{1}{n} \sum_{l=1}^{n} \widehat{V}_{h+1}\left(s_{j l}^{\prime}\right)\right)$.
- It takes $O\left(d^{2}\right)$ to multiply $\Lambda$ with the sum of vectors.
- All other operations take $O(d)$.

Combining the complexity together and multiply by $H$ steps, we finish the proof.

Lemma 9.5. The running time of constructing policy takes

O(H S d A)

Proof. For each step, it takes $O(S d A)$ to find the optimal action. Thus, it takes $O(H S d A)$ for inference.

### 9.5 Comparison

In this section, we show the comparison between our Sublinear LSVI with LSVI [BB96].
We start with presenting the LSVI algorithm in Algorithm 2.
Next, we show the comparison results in Table 3.

Let $d$ denotes the dimension of $\phi(s, a)$. Let $H$ be the number of steps played in each episode. Let $n$ denotes the quantity of times played for each pair of core state-action. Let $L$ denotes the constant in Definition 7.8. Let $\iota=\log (H d / p)$ and $p$ is the failure probability. ## 10 Sublinear Least-Squares Value Iteration with UCB

This section extend the Sublinear LSVI with UCB exploration.

- In Section 10.1, we present the Sublinear LSVI-UCB algorithm.
- In Section 10.2, we define several simplified notations for the convenience of proof.
- In Section 10.3, we provide the upper bound of weight estimated by Sublinear LSVI-UCB.
- In Section 10.4, we introduce a modified version of net argument for Sublinear LSVI-UCB.
- In Section 10.5, we upper bound the fluctuation on the value function when performing Sublinear LSVI-UCB Algorithm.
- In Section 10.6, we provide the upper bound on the difference between the estimated Q function and the actual Q function.
- In Section 10.7, we given the upper bound on the difference between the estimated $Q$ function and the actual Q function at the first step using induction.
- In Section 10.8, we introduce the recursion formula for the regret analysis.
- In Section 10.9, we formally provide the regret analysis of LSVI-UCB.
- In Section 10.10 , we analyze the runtime Sublinear LSVI-UCB by calculating the time complexity for each block.
- In Section 10.11, we compare Sublinear LSVI-UCB with LSVI-UCB [JYWJ20] in terms of regret and value iteration complexity.

In the following sections we show how to tackle the problem and provide our Sublinear LSVIUCB. Moreover, we provide the regret analysis of our Sublinear LSVI-UCB.

### 10.1 Algorithm

In LSVI-UCB [JYWJ20] with large action space, the runtime in each value iteration step is dominated by by computing the estimated value function as below:

$$
\begin{equation*}
\widehat{V}_{h}\left(s_{h+1}^{\tau}\right)=\max _{a \in \mathcal{A}} \min \left\{\left\langle w_{h}^{k}, \phi\left(s_{h+1}^{\tau}, a\right)\right\rangle+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}, H\right\} \tag{26}
\end{equation*}
$$

where $w_{h}^{k}$ is computed by solving the least-squares problem and $\phi\left(s_{h+1}^{\tau}, a\right)$ is the embedding for a pair of state-action. The complexity for Eq. (26) is $O\left(d^{2} A\right)$

The key challenge of Sublinear LSVI-UCB here is that Eq. (2) cannot be formulated as a Max-IP problem.

To handle this, we demonstrate how to develop Sublinear LSVI-UCB algorithm. We start with bounding the Q function in [JYWJ20] as

Lemma 10.1. We show that

Proof. We start with rewriting $Q_{h}\left(s_{h+1}^{\tau}, a\right)$,

Q_{h}\left(s_{h+1}^{\tau}, a\right)=\min \left\{w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}, H\right\} .
$$

Next, we show that

$$
\begin{aligned}
w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}} & \leq \sqrt{2\left(w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)\right)^{2}+2 \beta^{2} \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}^{2}} \\
& =\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{2 \beta^{2} \Lambda_{h}^{-1}+2 w_{h}^{k}\left(w_{h}^{k}\right)^{\top}}
\end{aligned}
$$

where the first step follows from Cauchy-Schwartz inequality, the second step is an reorganization.
Next, we show that

$$
\begin{aligned}
w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}} & \geq \sqrt{\left(w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)\right)^{2}+\beta^{2} \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}^{2}} \\
& =\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\beta^{2} \Lambda_{h}^{-1}+w_{h}^{k}\left(w_{h}^{k}\right)^{\top}}
\end{aligned}
$$

where the first step follows from the fact that both $w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)$ and $\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}$ are nonnegative, the second step is an reorganization.

Finally, consider the propriety of min function, we finish the proof of the lemma.

Next, we present a modified version of LSVI-UCB in Algorithm 3. The major difference between our modified version of LSVI-UCB and [JYWJ20] lies in in Line 11 of Algorithm 3. Here we choose $Q_{h}\left(s_{h+1}^{\tau}, a\right) \leftarrow \min \left\{\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{2 \beta^{2} \Lambda_{h}^{-1}+2 w_{h}^{k}\left(w_{h}^{k}\right)^{\top}}, H\right\}$, which is the upper bound of $\min \left\{w_{h}^{\top} \phi\left(s_{h+1}^{\tau}, a\right)+\beta \cdot\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\Lambda_{h}^{-1}}, H\right\}$ according to Lemma 10.1.

Based on Algorithm 3, we propose our Sublinear LSVI-UCB in Algorithm 4, which reduce the value iteration complexity to sublinear in actions. Note that to let $\rho$ strict less than 1 , we set $c^{2} \in[0.5,0.8]$ and $\left.\tau^{2} \in[0.5,0.8]\right)$ following Lemma 8.9.

### 10.2 Notations for Proof of Convergence

Next, we start the regret analysis of our Sublinear LSVI-UCB. We first define a series of notations. At episode $k$, we first estimate the weight $w_{h}^{k}$ and matrix $\Lambda_{h}^{k}$. Next, we use them to estimate Q function $Q_{h}^{k}$. Then, using our LSH data structures, we obtain the value function $V_{h}^{k}(s)$ following
line 13 of Algorithm 1. We also obtain the corresponding action associated with the value function and form the polity $\pi_{k}$ following Line 14 of Algorithm 1 . We also simplify $\phi\left(s_{h}^{k}, a_{h}^{k}\right)$ as $\phi_{h}^{k}$.

### 10.3 Upper Bound on Weights in Sublinear LSVI-UCB

In this section, we show how to bound the weights $w_{h}^{k}$ in Algorithm 4 using Lemma 10.2. The weight we would like to bound is different from [JYWJ20]. But the bound inequalities is very standard and similar to the proof in [JYWJ20].
Lemma 10.2. The weight $w_{h}^{k}$ in Algorithm 4 at episode $k \in[K]$ and step $h \in[H]$ satisfies:

\left\|w_{h}^{k}\right\|_{2} \leq 2 H \sqrt{d k / \lambda}
$$

Proof. If we perform $v^{\top} w_{h}^{k}$ where $v \in \mathbb{R}^{d}$ could be any vector in $\mathbb{R}^{d}$, we could bound $\left|v^{\top} w_{h}^{k}\right|$ as

\left|v^{\top} w_{h}^{k}\right| & =\left|v^{\top}\left(\Lambda_{h}^{k}\right)^{-1} \sum_{\tau=1}^{k-1} \phi_{h}^{\tau}\left(r\left(s_{h}^{\tau}, a_{h}^{\tau}\right)+\widehat{V}_{h+1}\left(s_{h+1}^{\tau}\right)\right)\right| \\
& \leq\left|v^{\top}\left(\Lambda_{h}^{k}\right)^{-1} \sum_{\tau=1}^{k-1} \phi_{h}^{\tau}\left(r\left(s_{h}^{\tau}, a_{h}^{\tau}\right)+\max _{a \in \mathcal{A}} Q_{h+1}\left(s_{h+1}^{\tau}, a\right)\right)\right| \\
& \leq 2 H \cdot\left|v^{\top}\left(\Lambda_{h}^{k}\right)^{-1} \sum_{\tau=1}^{k-1} \phi_{h}^{\tau}\right| \\
& =2 H \cdot \sum_{\tau=1}^{k-1}\left|v^{\top}\left(\Lambda_{h}^{k}\right)^{-1} \phi_{h}^{\tau}\right| \\
& \leq 2 H \cdot\left(\left(\sum_{\tau=1}^{k-1} v^{\top}\left(\Lambda_{h}^{k}\right)^{-1} v\right) \cdot\left(\sum_{\tau=1}^{k-1}\left(\phi_{h}^{\tau}\right)^{\top}\left(\Lambda_{h}^{k}\right)^{-1} \phi_{h}^{\tau}\right)\right)^{1 / 2} \\
& \leq 2 H\|v\|_{2} \sqrt{d k / \lambda},
\end{aligned}
$$

where the first step follows from the definition of $w_{h}^{k}$ in Algorithm 4, the second step follows from the definition of $\widehat{V}_{h+1}$ in Algorithm 4, the third step follows from Definition 7.2 that $r(s, a)+\widehat{V}_{h+1}(s) \leq$ $2 H$ for all $s \in \mathcal{S}$ and $a \in \mathcal{A}$, the forth step is a reorganization, the fifth step follows Cauchy-Schwarz inequality, the last step follows from Lemma 7.20.

Next, we rewrite $\left\|w_{h}^{k}\right\|_{2}=\max _{v:\|v\|_{2}=1}\left|v^{\top} w_{h}^{k}\right|$, in this way,

\left\|w_{h}^{k}\right\|_{2}=\max _{v:\|v\|_{2}=1}\left|v^{\top} w_{h}^{k}\right| \leq 2 H \sqrt{d k / \lambda}
$$

where the last step follows from $\left|v^{\top} w_{h}^{k}\right| \leq 2 H \sqrt{d k / \lambda}$.

### 10.4 Our Net Argument

We present our net argument to support the proof in the this section. We start with defining the covering number of euclidean ball.

Lemma 10.3. Let $\mathcal{B}$ denotes a Euclidean ball in $\mathbb{R}^{d}$. $\mathcal{B}$ has radius greater than 0 . For any $\epsilon>0$, we upper bound the $\epsilon$-covering number of $\mathcal{B}$ by $(1+2 R / \epsilon)^{d}$.

This is a standard statement. We reder readers to [Ver10] for more details.
Next, we upper bound the covering number of a function $\mathcal{V}(s)=\min \left\{\|\phi(s, a)\|_{\beta^{2} \Lambda^{-1}+w w^{\top}}, H\right\}$. The $\mathcal{V}$ we would like to bound is is different from [JYWJ20]. But the net argument is very standard and similar to proof in [JYWJ20].
Lemma 10.4 (Our Net Argument). Let $\Lambda \in \mathbb{R}^{d \times d}$ denotes a invertible matrix whose minimum eigenvalue is greater than a constant $\lambda$. Let $w$ denotes a vector such that $\|w\|_{2} \leq L$. Let $\beta \in[0, B]$. Let $\max _{(s, a) \in \mathcal{S} \times \mathcal{A}}\|\phi(s, a)\|_{2} \leq 1$. Let $\mathcal{V}$ denotes a famility of functions such that $V: \mathcal{S} \rightarrow \mathbb{R}$ for any $V \in \mathcal{V}$ Let $\mathcal{N}_{\epsilon}$ denotes the $\epsilon$-covering number of $\mathcal{V}$. The $\epsilon$-covering number is defined on distance $\operatorname{dist}\left(V, V^{\prime}\right)=\max _{s \in \mathcal{S}}\left|V(s)-V^{\prime}(s)\right|$. If for any $V \in \mathcal{V}$, we have the form

$$
\begin{equation*}
V(s)=\min \left\{\|\phi(s, a)\|_{\beta^{2} \Lambda^{-1}+w w^{\top}}, H\right\} \tag{27}
\end{equation*}
$$

Then we have

$$
\log \mathcal{N}_{\epsilon} \leq d \log (1+4 L / \epsilon)+d^{2} \log \left(1+8 d^{1 / 2} B^{2} /\left(\lambda \epsilon^{2}\right)\right)
$$

Proof. For given two arbitrary functions $V_{1}, V_{2} \in \mathcal{V}$, we have

$$
\begin{align*}
\operatorname{dist}\left(V_{1}, V_{2}\right) & \leq \sup _{s, a}\left(\|\phi(s, a)\|_{\beta_{1}^{2} \Lambda_{1}^{-1} w_{1} w_{1}^{\top}}-\|\phi(s, a)\|_{\beta_{2}^{2} \Lambda_{2}^{-1}+w_{2} w_{2}^{\top}}\right) \\
& \leq \sup _{\phi:\|\phi\|_{2} \leq 1}\left(\|\phi\|_{\beta_{1}^{2} \Lambda_{1}^{-1}+w_{1} w_{1}^{\top}}-\|\phi\|_{\beta_{2}^{2} \Lambda_{2}^{-1}+w_{2} w_{2}^{\top}}\right) \\
& \leq \sup _{\phi:\|\phi\|_{2} \leq 1} \sqrt{\left|\phi^{\top}\left(\beta_{1}^{2} \Lambda_{1}^{-1}+w_{1} w_{1}^{\top}-\beta_{2}^{2} \Lambda_{2}^{-1}-w_{2} w_{2}\right) \phi\right|} \\
& \leq \sup _{\phi:\|\phi\|_{2} \leq 1}\left(\left(w_{1}-w_{2}\right)^{\top} \phi\right)+\sup _{\phi:\|\phi\|_{2} \leq 1} \sqrt{\left|\phi^{\top}\left(\beta_{1}^{2} \Lambda_{1}^{-1}-\beta_{2}^{2} \Lambda_{2}^{-1}\right) \phi\right|} \\
& =\left\|w_{1}-w_{2}\right\|+\sqrt{\left\|\beta_{1}^{2} \Lambda_{1}^{-1}-\beta_{2}^{2} \Lambda_{2}^{-1}\right\|_{2}} \\
& \leq\left\|w_{1}-w_{2}\right\|+\sqrt{\left\|\beta_{1}^{2} \Lambda_{1}^{-1}-\beta_{2}^{2} \Lambda_{2}^{-1}\right\|_{F}}, \tag{28}
\end{align*}
$$

where the first step follows the definition of $V_{1}$ and $V_{2}$ in Eq. (27), the second step follows from the fact that $\|\phi(s, a)\|_{2} \leq 1$ in Definition 7.2, the third step step follows from the fact that for any $x, y \geq 0$, we have $|\sqrt{x}-\sqrt{y}| \leq \sqrt{|x-y|}$, the forth step follows from $\sqrt{x+y} \leq \sqrt{x}+\sqrt{y}$ for any $x, y \geq 0$, the fifth step follows from the fact that the Frobenius norm of matrix is greater than the $\ell_{2}$ norm.

Next, we denote $\mathcal{C}_{w}$ as the $(\epsilon / 2)$-cover of a ball $\left\{w \in \mathbb{R}^{d} \mid\|w\|_{2} \leq L\right\}$. Using Lemma 10.3, we show that it can be upper bound as: $\left|\mathcal{C}_{w}\right| \leq(1+4 L / \epsilon)^{d}$.

Similarly, we denote $\mathcal{C}_{\Lambda}$ as the $\left(\epsilon^{2} / 4\right)$-cover of a ball $\left\{\beta^{2} \Lambda^{-1} \in \mathbb{R}^{d \times d} \mid\left\|\beta^{2} \Lambda^{-1}\right\|_{F} \leq d^{1 / 2} B^{2} \lambda^{-1}\right\}$. Here we define the ball in $\|\cdot\|_{F}$. Using Lemma 10.3, we show that it can be upper bound as: $\left|\mathcal{C}_{\Lambda}\right| \leq\left(1+8 d^{1 / 2} B^{2} /\left(\lambda \epsilon^{2}\right)\right)^{d^{2}}$.

Using, Eq. (28), we know that given any $V_{1} \in \mathcal{V}$, we could find a $V_{2} \in \mathcal{V}$ with form $V_{2}(s)=$ $\min \left\{\|\phi(s, a)\|_{\beta_{2}^{2} \Lambda_{2}^{-1}+w_{2} w_{2}^{\top}}, H\right\}$ where $w_{2} \in \mathcal{C}_{w}$ and $\beta_{2}^{2} \Lambda_{2}^{-1} \in \mathcal{C}_{\Lambda}$, such that $\operatorname{dist}\left(V_{1}, V_{2}\right) \leq \epsilon$. Therefore, $\mathcal{N}_{\epsilon} \leq\left|\mathcal{C}_{w}\right| \cdot\left|\mathcal{C}_{\mathcal{A}}\right|$. Using this inequality, we have

$$
\begin{aligned}
\log \mathcal{N}_{\epsilon} & \leq \log \left|\mathcal{C}_{\mathcal{A}}\right|+\log \left|\mathcal{C}_{w}\right| \\
& \leq d \log (1+4 L / \epsilon)+d^{2} \log \left(1+8 d^{1 / 2} B^{2} /\left(\lambda \epsilon^{2}\right)\right)
\end{aligned}
$$

Thus, we conclude the proof.

### 10.5 Upper Bound on Fluctuations

We present a concentration lemma so that the fluctuations in LSVI-UCB is upper bounded in this section. The analysis is very standard and similar to proof in [JYWJ20]. However, we improve the proof of [JYWJ20] with more detailed constant dependence.

Lemma 10.5. Let $C_{\beta}>1$ denote a fixed constant. Let $\beta=C_{\beta} \cdot d H \sqrt{\iota}$. Let $\iota=\log (2 d T / p)$. We show that for any probability $p \in[0,1]$ that is fixed, if we have an $\xi$ event satisfying that for all $k \in[K]$ and $h \in[H]:$

\left\|\sum_{\tau=1}^{k-1} \phi_{h}^{\tau}\left(V_{h+1}^{k}\left(s_{h+1}^{\tau}\right)-\left[\mathbb{P}_{h} V_{h+1}^{k}\right]\left(s_{h}^{\tau}, a_{h}^{\tau}\right)\right)\right\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \leq 30 \cdot d H \sqrt{\iota+\log \left(5 C_{\beta}\right)},
$$

Then, we have

$$
\operatorname{Pr}[\xi] \geq 1-p / 2
$$

Proof. We show that any fixed $\epsilon>0$, we have

$$
\begin{align*}
& \left\|\sum_{\tau=1}^{k-1} \phi_{h}^{\tau}\left(V_{h+1}^{k}\left(s_{h+1}^{\tau}\right)-\left[\mathbb{P}_{h} V_{h+1}^{k}\right]\left(s_{h}^{\tau}, a_{h}^{\tau}\right)\right)\right\|_{\left(\Lambda_{h}^{k}\right)^{-1}}^{2} \\
\leq & 4 H^{2}\left(d \log (1+k / \lambda)+d \log \left(1+\frac{8 H \sqrt{d k}}{\epsilon \sqrt{\lambda}}\right)+d^{2} \log \left(1+\frac{8 d^{1 / 2} \beta^{2}}{\epsilon^{2} \lambda}\right)+\log (2 / p)\right)+\frac{8 k^{2} \epsilon^{2}}{\lambda} \\
\leq & 4 H^{2}\left(d \log (1+k)+d \log \left(1+8 \sqrt{k^{3} / d}\right)+d^{2} \log \left(1+8 C_{\beta}^{2} d^{0.5} K^{2} \iota\right)+\log (2 / p)\right)+8 d^{2} H^{2} \\
\leq & 30 \cdot d^{2} H^{2} \log \left(10 C_{\beta} d T / p\right) \\
= & 30 \cdot d^{2} H^{2}\left(\iota+\log \left(5 C_{\beta}\right)\right) \tag{29}
\end{align*}
$$

where the first step follows from combining Lemmas 7.21 and 10.4 , the second step follows from $\lambda=1, \epsilon=d H / K$, and $\beta=C_{\beta} \cdot d H \sqrt{\iota}$, the third step follows from $C_{\beta} \geq 1$ and $\iota=\log (2 d T / p)$, the last step follows from $\iota=\log (2 d T / p)$.

Thus, we complete the proof.

### 10.6 Upper Bound of Difference of Q Function

In this section, we bound like to bound the difference between the $Q$ function $Q_{h}^{k}$ (see Section 7.1) selected by Algorithm 4 and the value function $Q_{h}^{\pi}$ (see Definition 7.4) of any policy $\pi$. We bound the their difference by bounding $\left\langle\phi(s, a), w_{h}^{k}\right\rangle-Q_{h}^{\pi}(s, a)$. The analysis is very standard and similar to proof in [JYWJ20]. However, we improve the proof of [JYWJ20] with more detailed constant dependence.

Lemma 10.6. Let $\lambda=1$ in Algorithm 4. Let $\iota=\log (2 d T / p)$. We show that for any policy $\pi$ that is fixed, for all $s \in \mathcal{S}, a \in \mathcal{A}, h \in[H]$ and $k \in[K]$, on the event $\xi$ defined in Lemma 10.5, we show that exists an absolute constant $C_{\beta} \geq 100$ such that

\left\langle\phi(s, a), w_{h}^{k}\right\rangle-Q_{h}^{\pi}(s, a)-\left[\mathbb{P}_{h}\left(V_{h+1}^{k}-V_{h+1}^{\pi}\right)\right](s, a) \leq C_{\beta} d H \sqrt{\iota} \cdot\|\phi(s, a)\|_{\left(\Lambda_{h}^{k}\right)^{-1}}
$$

Proof. We start with rewriting $Q_{h}^{\pi}(s, a)$ as

where the first step follows from Proposition 7.9, and the second step follows from Eq. (5).
Next, we show that

& =\left(\Lambda_{h}^{k}\right)^{-1}\left(-\lambda w_{h}^{\pi}+\sum_{\tau=1}^{k-1} \phi_{h}^{\tau}\left(V_{h+1}^{k}\left(s_{h+1}^{\tau}\right)-\left[\mathbb{P}_{h} V_{\pi}^{h+1}\right]\left(s_{h}^{\tau}, a_{h}^{\tau}\right)\right)\right) \\
& =p_{1}+p_{2}+p_{3} .
\end{aligned}
$$

where the first step follows from the definition of $w_{h}^{k}$, the second step follows from the definition of $w_{h}^{\pi}$. the last step follows from

$$
\begin{aligned}
& p_{1}:=-\lambda\left(\Lambda_{h}^{k}\right)^{-1} w_{h}^{\pi} \\
& p_{2}:=\left(\Lambda_{h}^{k}\right)^{-1} \sum_{\tau=1}^{k-1} \phi_{h}^{\tau}\left(V_{h+1}^{k}\left(s_{h+1}^{\tau}\right)-\left[\mathbb{P}_{h} V_{h+1}^{k}\right]\left(s_{h}^{\tau}, a_{h}^{\tau}\right)\right) \\
& p_{3}:=\left(\Lambda_{h}^{k}\right)^{-1} \sum_{\tau=1}^{k-1} \phi_{h}^{\tau}\left[\mathbb{P}_{h}\left(V_{h+1}^{k}-V_{h+1}^{\pi}\right)\right]\left(s_{h}^{\tau}, a_{h}^{\tau}\right)
\end{aligned}
$$

Next, we upper bound $p_{1}, p_{2}$ and $p_{3}$ separately.
We upper bound $p_{1}$ as,

\left|\left\langle\phi(s, a), q_{1}\right\rangle\right| & =\lambda \cdot\left|\left\langle\phi(s, a),\left(\Lambda_{h}^{k}\right)^{-1} w_{h}^{\pi}\right\rangle\right| \\
& \leq \lambda \cdot\left\|w_{h}^{\pi}\right\|_{2} \cdot\|\phi(s, a)\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \\
& \leq 2 H \sqrt{d \lambda} \cdot\|\phi(s, a)\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \\
& \leq 2 H \sqrt{d} \cdot\|\phi(s, a)\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \tag{30}
\end{align*}
$$

where the second step follows from $|\langle a, b\rangle| \leq\|a\|_{2} \cdot\|b\|_{2}$, and the third step follows from $\left\|w_{h}^{\pi}\right\|_{2} \leq$ $2 H \sqrt{d / \lambda}$ (see Lemma 10.2), and the last step follows from $\lambda=1$.

We upper bound $p_{2}$ as,

\left|\left\langle\phi(s, a), q_{2}\right\rangle\right| \leq 30 \cdot d H \sqrt{\iota+\log \left(5 C_{\beta}\right)}\|\phi(s, a)\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \tag{31}
\end{equation*}
$$

where the first step follows from Lemma 10.5 on the event $\xi$.
We upper bound $q_{3}$ as,

\begin{aligned}
\left\langle\phi(s, a), p_{3}\right\rangle & =\left\langle\phi(s, a),\left(\Lambda_{h}^{k}\right)^{-1} \sum_{\tau=1}^{k-1} \phi_{h}^{\tau}\left[\mathbb{P}_{h}\left(V_{h+1}^{k}-V_{h+1}^{\pi}\right)\right]\left(s_{h}^{\tau}, a_{h}^{\tau}\right)\right\rangle \\
& =\left\langle\phi(s, a),\left(\Lambda_{h}^{k}\right)^{-1} \sum_{\tau=1}^{k-1} \phi_{h}^{\tau}\left(\phi_{h}^{\tau}\right)^{\top} \int\left(V_{h+1}^{k}-V_{h+1}^{\pi}\right)\left(s^{\prime}\right) \mathrm{d} \mu_{h}\left(s^{\prime}\right)\right\rangle \\
& =q_{1}+q_{2}
\end{aligned}
$$

where the first step is a reorganization, the second step decomposes the right hand side as:

\begin{aligned}
& q_{1}:=\left\langle\phi(s, a), \int\left(V_{h+1}^{k}-V_{h+1}^{\pi}\right)\left(s^{\prime}\right) \mathrm{d} \mu_{h}\left(s^{\prime}\right)\right\rangle \\
& q_{2}:=-\lambda\left\langle\phi(s, a),\left(\Lambda_{h}^{k}\right)^{-1} \int\left(V_{h+1}^{k}-V_{h+1}^{\pi}\right)\left(s^{\prime}\right) \mathrm{d} \mu_{h}\left(s^{\prime}\right)\right\rangle
\end{aligned}
$$

Then, we rewrite $q_{1}=\mathbb{P}_{h}\left(V_{h+1}^{k}-V_{h+1}^{\pi}\right)(s, a)$ following Definition 7.2.
Next, we upper bound $q_{2}$ as

where the first step follows from Lemma 10.2.
Finally, because $\left\langle\phi(s, a), w_{h}^{k}\right\rangle-Q_{h}^{\pi}(s, a)=\left\langle\phi(s, a), p_{1}+p_{2}+p_{3}\right\rangle$, we have

\leq & \left(2 H \sqrt{d}+30 \cdot d H \sqrt{\iota+\log \left(5 C_{\beta}\right)}+2 H \sqrt{d}\right) \cdot\|\phi(s, a)\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \\
\leq & d H\left(30 \sqrt{\iota+\log \left(5 C_{\beta}\right)}+4\right) \cdot\|\phi(s, a)\|_{\left(\Lambda_{h}^{k}\right)^{-1}},
\end{aligned}
$$

where the second step follows from combining Eq. (30), Eq. (31) and Eq. (32), the third step follows from $d \geq 1, H \geq 1$.

Finally, we choose an absolute constant $C_{\beta}$ that satisfies:

Note that $\iota=\log (2 d T / p) \geq 4$, as long as $C_{\beta} \geq 100$ the above inequality holds
Finally, with this choice of $C_{\beta}$, we finish the proof.

### 10.7 Q Function Difference by Induction

In this section, we build a connection between $Q_{1}^{k}(s, a)$ selected by Algorithm 4 and $Q_{1}^{*}(s, a)$. We show in Lemma 10.7 that $Q_{1}^{*}(s, a)$ is upper bounded by $Q_{1}^{k}(s, a)$ plus an error term related to the parameter $c$ for approximate Max-MatNorm in Algorithm 4.

Lemma 10.7. Let $Q_{1}^{k}(s, a)$ denotes the estimated $Q$ function for state $s$ when taking action a at the first step. Let $Q_{1}^{*}(s, a)$ denotes the optimal $Q$ function for state $s$ when taking action a at the first step. Let $H$ denotes the total steps. Let $c$ is the parameter for approximate Max-MatNorm. We show that using Sublinear LSVI-UCB (see Algorithm 4), we have

Q_{1}^{*}(s, a)-Q_{1}^{k}(s, a) \leq H-c \frac{1-c^{H}}{1-c}
$$

Proof. We start with bounding on the relationship between $Q_{h}^{k}(s, a)$ and $Q_{h}^{*}(s, a)$.

\left\langle\phi(s, a), w_{h}^{k}\right\rangle+\beta\|\phi(s, a)\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \geq Q_{h}^{*}(s, a)+\left[\mathbb{P}_{h}\left(V_{h+1}^{k}-V_{h+1}^{*}\right)\right](s, a) \tag{34}
\end{equation*}
$$

where the first step follows Lemma 10.5.

Next, when $h=H$, as the value functions are all zero in $H+1$ step, we have

Q_{H}^{k}(s, a) & \geq\left\langle\phi(s, a), w_{H}^{k}\right\rangle+\beta\|\phi(s, a)\|_{\left(\Lambda_{H}^{k}\right)^{-1}} \\
& \geq Q_{H}^{*}(s, a) \tag{35}
\end{align*}
$$

where the first step follows from Lemma 10.1, the second step follows from Lemma 10.6.
Next, we have

\max _{a \in \mathcal{A}} Q_{H}^{k}(s, a) & \geq \max _{a \in \mathcal{A}} Q_{H}^{*}(s, a) \\
& \geq V_{H}^{*}(s) \tag{36}
\end{align*}
$$

where the first step follows from Eq. (35), the second step follows from the definition of $V_{H}^{*}(s)$ in Definition 7.4.

Next, when $h=H-1$, we bound $\left[\mathbb{P}_{h}\left(V_{H}^{k}-V_{H}^{*}\right)\right](s, a)$ as

{\left[\mathbb{P}_{h}\left(V_{H}^{k}-V_{H}^{*}\right)\right](s, a) } & \geq\left[\mathbb{P}_{h}\left(c \max _{a \in \mathcal{A}} Q_{H}^{k}(s, a)-V_{H}^{*}\right)\right](s, a) \\
& \geq c\left[\mathbb{P}_{h}\left(\max _{a \in \mathcal{A}} Q_{H}^{k}(s, a)-V_{H}^{*}\right)\right](s, a)-(1-c)\left[\mathbb{P}_{h} V_{H}^{*}\right](s, a) \\
& \geq c\left[\mathbb{P}_{h}\left(\max _{a \in \mathcal{A}} Q_{H}^{k}(s, a)-V_{H}^{*}\right)\right](s, a)-(1-c) \cdot 1 \\
& \geq-(1-c) \cdot 1 \tag{37}
\end{align*}
$$

where the first step comes from the property of data structure MatrixLSH in Algorithm 4, the second step is an reorganization, the third step follows the definition of $V_{H}^{*}(s)$ in Definition 7.4, the last step follows the Eq. (36).

Next, we have

Q_{H-1}^{k}(s, a) & \geq\left\langle\phi(s, a), w_{H-1}^{k}\right\rangle+\beta\|\phi(s, a)\|_{\left(\Lambda_{H-1}^{k}\right)^{-1}} \\
& \geq Q_{H-1}^{*}(s, a)+\left[\mathbb{P}_{h}\left(V_{H}^{k}-V_{H}^{*}\right)\right](s, a) \\
& \geq Q_{H-1}^{*}(s, a)-(1-c) \cdot 1 \tag{38}
\end{align*}
$$

where the first step follows from the Lemma 10.1, the second step follows from Eq. (34) ,and the third step follows Eq. (37).

Next, we have

\max _{a \in \mathcal{A}} Q_{H-1}^{k}(s, a) & \geq \max _{a \in \mathcal{A}} Q_{H-1}^{*}(s, a)-(1-c) \cdot 1 \\
& \geq V_{H-1}^{*}(s)-(1-c) \cdot 1 \tag{39}
\end{align*}
$$

where the first step follows from Eq. (38), and the second step follows the definition of $Q_{H-1}^{*}(s, a)$ in section 7.1.

Next, when $h=H-2$, we lower bound $\left[\mathbb{P}_{h}\left(V_{H-1}^{\widehat{k}}-V_{H-1}^{*}\right)\right](s, a)$ as

& \left.\geq c\left[\mathbb{P}_{h}\left(\max _{a \in \mathcal{A}} Q_{H-1}^{k}(s, a)-V_{H-1}^{*}\right)\right](s, a)-(1-c) \cdot\left[\mathbb{P}_{h} V_{H-1}^{*}\right)\right](s, a) \\
& \geq c\left[\mathbb{P}_{h}\left(\max _{a \in \mathcal{A}} Q_{H-1}^{k}(s, a)-V_{H-1}^{*}\right)\right](s, a)-(1-c) \cdot 2
\end{aligned}
$$

$$
\begin{equation*}
\geq-c(1-c) \cdot 1-(1-c) \cdot 2 \tag{40}
\end{equation*}
$$

where the first step comes from the MatrixLSH in Algoritm 4, the second step is an reorganization, the third step follows the definition of $V_{H}^{*}(s)$ in section 7.1, the last step follows the Eq. (39).

Next, we have

\begin{align*}
Q_{H-2}^{k}(s, a) & \geq\left\langle\phi(s, a), w_{H-2}^{k}\right\rangle+\beta\|\phi(s, a)\|_{\left(\Lambda_{H-2}^{k}\right)^{-1}} \\
& \geq Q_{H-2}^{*}(s, a)+\left[\mathbb{P}_{h}\left(V_{H-1}^{k}-V_{H-1}^{*}\right)\right](s, a) \\
& \geq Q_{H-2}^{*}(s, a)-c(1-c) \cdot 1-(1-c) \cdot 2 \tag{41}
\end{align*}
$$

where the first step follows from the Lemma 10.1, the second step follows from Eq. (34) , and the third step follows Eq. (40).
using induction from $H$ to 1 , we have

\begin{align*}
Q_{1}^{k}(s, a) & \geq Q_{1}^{*}(s, a)-(1-c) \sum_{h=1}^{H} c^{h-1}(H+1-h) \\
& =Q_{1}^{*}(s, a)-(1-c) \frac{H-c H-c+c^{H+1}}{(1-c)^{2}} \\
& =Q_{1}^{*}(s, a)-\frac{H-c H-c+c^{H+1}}{1-c} \\
& =Q_{1}^{*}(s, a)-\frac{H-c H}{1-c}+\frac{-c+c^{H+1}}{1-c} \\
& =Q_{1}^{*}(s, a)-\left(H-\frac{c-c^{H+1}}{1-c}\right) \\
& =Q_{1}^{*}(s, a)-\left(H-c \frac{1-c^{H}}{1-c}\right) \tag{42}
\end{align*}
$$

where the first step follows the induction rule, the remain steps are reorganizations.

We notice from Lemma 10.7 that there exists a term $H-c \frac{1-c^{H}}{1-c}$. Here we use Fact 10.8 to bound this term.

Fact 10.8. Let $H \in \mathbb{N}$. Let $c=1-\gamma$, for any $\gamma \in(0,1 /(10 H))$, then we have

H-c \frac{1-c^{H}}{1-c} \leq 2 \gamma H^{2}
$$

Proof. First, by definition $\gamma=1-c \in(0,1)$, then we can rewrite LHS as

& \leq H-(1-\gamma)\left(1-e^{-H \gamma}\right) / \gamma \\
& \leq H-(1-\gamma)\left(H-0.5\left(H^{2} \gamma\right)\right) \\
& =H(1-(1-\gamma)(1-0.5(H \gamma))) \\
& \leq H \cdot(2 H \gamma)=2 \gamma H^{2}
\end{aligned}
$$

where the second step follows from $(1-\gamma)^{1 / \gamma} \leq e^{-1}$, the third step follows from $1-e^{-x} \geq x-0.5 x^{2}$, $\forall x \in[0,1 / 10]$.

### 10.8 Recursive Formula

In this section, we bound the difference between $Q_{h}^{k}\left(s_{h}^{k}, a\right)$ and $Q_{h}^{\pi_{k}}\left(s_{h}^{k}, a\right)$ in a recursive formula.
Lemma 10.9 (Recursion). Let $\delta_{h}^{k}$ denotes the difference $Q_{h}^{k}\left(s_{h}^{k}, a\right)-Q_{h}^{\pi_{k}}\left(s_{h}^{k}, a\right) . \quad$ Let $\zeta_{h+1}^{k}=$ $\mathbb{E}\left[\delta_{h+1}^{k} \mid s_{h}^{k}, a\right]-\delta_{h+1}^{k}$ denotes the error between expectation and observed difference. Let $\beta=C_{\beta} d H \sqrt{\iota}$. Given the event $\xi$ defined in Lemma 10.5, we bound $\delta_{h}^{k}-\delta_{h+1}^{k}$ for any $k \in[K]$ and $h \in[H]$ as

$$
\delta_{h}^{k}-\delta_{h+1}^{k} \leq \zeta_{h+1}^{k}+2 \beta\left\|\phi\left(s_{h}^{k}, a\right)\right\|_{\left(\Lambda_{h}^{k}\right)^{-1}} .
$$

Proof. We bound the $\delta_{h}^{k}$ as

$$
\begin{aligned}
\delta_{h}^{k} & =Q_{h}^{k}(s, a)-Q_{h}^{\pi_{k}}(s, a) \\
& \leq\left[\mathbb{P}_{h}\left(V_{h+1}^{k}-V_{h+1}^{\pi_{k}}\right)\right](s, a)+2 C_{\beta} d H \sqrt{\iota}\|\phi(s, a)\|_{\left(\Lambda_{h}^{k}\right)^{-1}} . \\
& =\zeta_{h+1}^{k}+\delta_{h+1}^{k}+2 \beta\|\phi(s, a)\|_{\left(\Lambda_{h}^{k}\right)^{-1}}
\end{aligned}
$$

where the second step follows from Lemma 10.6, the third step follows from $\left[\mathbb{P}_{h}\left(V_{h+1}^{k}-V_{h+1}^{\pi_{k}}\right)\right](s, a)=$ $\zeta_{h+1}^{k}+\delta_{h+1}^{k}$.

Thus, we finish the proof.

As our algorithm have the same upper bound on recursion with [JYWJ20], the upper bound on $\zeta_{h+1}^{k}$ in [JYWJ20] could also be used in our analysis. We state the bound as

Lemma 10.10 ([JYWJ20]). Let $\zeta_{h+1}^{k}=\mathbb{E}\left[\delta_{h+1}^{k} \mid s_{h}^{k}, a\right]-\delta_{h+1}^{k}$. With probability at least $1-p / 2$, we show that

$$
\sum_{k=1}^{K} \sum_{h=1}^{H} \zeta_{h}^{k} \leq 2 H \sqrt{T \iota}
$$

We could also upper bound $\sum_{k=1}^{K} \sum_{h=1}^{H}\left\|\phi\left(s_{1}^{k}, a_{1}^{k *}\right)\right\|_{\left(\Lambda_{h}^{k}\right)^{-1}}$ following [JYWJ20].
Lemma 10.11 ([JYWJ20]). Let $a_{1}^{k *} \in \mathcal{A}$ denotes the optimal action at state $s_{1}^{k} \in \mathcal{S}$. Given, $\Lambda_{h}^{k}$ estimated in each step, we have

$$
\sum_{k=1}^{K} \sum_{h=1}^{H}\left\|\phi\left(s_{1}^{k}, a_{1}^{k *}\right)\right\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \leq H \cdot \sqrt{2 d K \iota}
$$

### 10.9 Regret Analysis

In this section, we prove main theorem in Theorem 10.12.
Theorem 10.12 (Convergence Result of Sublinear Least-Squares Value Iteration with UCB (Sublinear LSVI-UCB), a formal version of Theorem 4.3). In a linear MDP in Definition 7.2, we set $\lambda=1$. Let $C_{\beta} \geq 100$ denotes a fixed constant and $\iota=\log (2 d T / p)$. If we set approximate Max-MatNorm parameter $c=1-\frac{\iota}{\sqrt{K}}$, then for any $p \in(0,1)$ that is fixed, with probability $1-p$, Sublinear LSVI-UCB (Algorithm 4) has the cumulative regret at most $O\left(C_{\beta} \cdot \sqrt{d^{3} H^{3} T \iota^{2}}\right)$.

Proof. We start with upper bounding the regret as:

$$
\begin{align*}
\operatorname{Regret}(K) & =\sum_{k=1}^{K}\left(V_{1}^{*}\left(s_{1}^{k}\right)-V_{1}^{\pi_{k}}\left(s_{1}^{k}\right)\right) \\
& =\sum_{k=1}^{K}\left(\max _{a \in \mathcal{A}} Q_{1}^{*}\left(s_{1}^{k}, a\right)-\max _{a \in \mathcal{A}} Q_{1}^{\pi_{k}}\left(s_{1}^{k}, a\right)\right) \\
& \leq \sum_{k=1}^{K}\left(\max _{a \in \mathcal{A}} Q_{1}^{*}\left(s_{1}^{k}, a_{1}^{k *}\right)-Q_{1}^{\pi_{k}}\left(s_{1}^{k}, a_{1}^{k *}\right)\right) \\
& \leq \sum_{k=1}^{K}\left(Q_{1}^{k}\left(s_{1}^{k}, a_{1}^{k *}\right)-Q_{1}^{\pi_{k}}\left(s_{1}^{k}, a_{1}^{k *}\right)+2 \gamma H^{2}\right) \\
& =2 \gamma K H^{2}+\sum_{k=1}^{K} \delta_{1}^{k} \\
& \leq 2 \gamma K H^{2}+\sum_{k=1}^{K} \sum_{h=1}^{H} \zeta_{h}^{k}+2 \beta \sum_{k=1}^{K} \sum_{h=1}^{H}\left\|\phi\left(s_{1}^{k}, a_{1}^{k *}\right)\right\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \tag{43}
\end{align*}
$$

where the first step follows the definition of regret, the second steps follows from the definition of value function in Definition 7.4, the third step follows from that $\max _{a \in \mathcal{A}} Q_{1}^{\pi_{k}}\left(s_{1}^{k}, a\right) \geq Q_{1}^{\pi_{k}}\left(s_{1}^{k}, a_{1}^{k *}\right)$, where $a_{1}^{k *}$ is the optimal action chosen at state $s_{1}^{k}$, the forth step follows from Lemma 10.7, the fifth step is a follows the definition of $\delta_{h}^{k}$ and $\zeta_{h}^{k}$ as in Lemma 10.9, the sixth step follows from Lemma 10.9.

Next, with probability $1-p$, we show that

$$
\begin{align*}
\operatorname{Regret}(K) & \leq 2 \gamma K H^{2}+\sum_{k=1}^{K} \sum_{h=1}^{H} \zeta_{h}^{k}+2 \beta \sum_{k=1}^{K} \sum_{h=1}^{H}\left\|\phi\left(s_{1}^{k}, a_{1}^{k *}\right)\right\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \\
& \leq 2 \gamma K H^{2}+2 H \sqrt{T \iota}+2 \beta \sum_{k=1}^{K} \sum_{h=1}^{H}\left\|\phi\left(s_{1}^{k}, a_{1}^{k *}\right)\right\|_{\left(\Lambda_{h}^{k}\right)^{-1}} \\
& \leq 2 K \gamma H^{2}+2 H \sqrt{T \iota}+\beta H \sqrt{2 d K \iota} \\
& =2 K \gamma H^{2}+2 H \sqrt{T \iota}+C_{\beta} \cdot \sqrt{2 d^{3} H^{4} K \iota^{2}} \\
& \leq 2 \sqrt{H^{4} K \iota^{2}}+2 \sqrt{H^{3} K \iota}+C_{\beta} \cdot \sqrt{2 d^{3} H^{4} K \iota^{2}} \\
& \leq 2 C_{\beta} \sqrt{d^{3} H^{4} K \iota^{2}} \tag{44}
\end{align*}
$$

where the second step follows from Lemma 10.10, the third step follows from Lemma 10.11, the forth step from $\beta=C_{\beta} \cdot d H \sqrt{\iota}$, the fifth step follows from $\gamma=\frac{1}{\sqrt{K}}$, the sixth step is a reorganizationm the seventh step follows from $C_{\beta} \geq 100$.

Thus, we finish our proof.

### 10.10 Running Time Analysis

We present the running time analysis of our Sublinear LSVI-UCB. We first introduce the running time of each procedure of LSVI-UCB in Section 10.10.1. Next, we introduce the running time of Sublinear LSVI-UCB in Section 10.10.2. Therefore, we could compare their efficiency in the next section.

### 10.10.1 LSVI-UCB

First, we show the LSVI-UCB algorithm in Algorithm 5

Lemma 10.13. The running time of pre-computing $\Lambda^{-1}$ in Algorithm 5 takes time

O\left(K d^{2}+d^{\omega}\right)
$$

where $\omega \approx 2.373$ is the exponent of matrix multiplication [Wil12, LG14].
Proof. It takes $O\left(K d^{2}\right)$ to compute and sum up every $\phi\left(s_{h}^{\tau}, a_{h}^{\tau}\right) \phi\left(s_{h}^{\tau}, a_{h}^{\tau}\right)^{\top}$. Computing the inverse matrix of $\Lambda$ takes $O\left(d^{\omega}\right)$. All other operations take $O(d)$. Combining the complexity together, we obtain the pre-computing complexity $O\left(K d^{2}+d^{\omega}\right)$.

Lemma 10.14. The running time of value iteration in Algorithm 5 takes

$$
O\left(H K d^{2} A\right)
$$

Proof. For each of the $H$ step,

- It takes $O\left(K d^{2} A\right)$ to compute $\widehat{V}_{h+1}\left(s_{h+1}^{\tau}\right)$ for each state $s_{h+1}^{\tau}$.
- It takes $O(K d)$ to sum up $\phi\left(s_{h}^{\tau}, a_{h}^{\tau}\right) \cdot\left(r_{h}\left(s_{h}^{\tau}, a_{h}^{\tau}\right)+\widehat{V}_{h+1}\left(s_{h+1}^{\tau}\right)\right)$.
- It takes $O\left(d^{2}\right)$ to multiply $\Lambda$ with the sum of vectors.
- All other operations take $O(d)$.

Combining them together, we have $O\left(H K d^{2} A\right)$.

### 10.10.2 Sublinear LSVI-UCB

In this section, we show the runtime analysis of our Sublinear LSVI-UCB in Algorithm 4.
Lemma 10.15. The running time of pre-computing $\Lambda^{-1}$ in Algorithm 4 takes

$$
O\left(K d^{2}+d^{\omega}\right)
$$

where $\omega \approx 2.373$ is the exponent of matrix multiplication [Wil12, LG14].
Proof. It takes $O\left(K d^{2}\right)$ to compute and sum up every $\phi\left(s_{h}^{\tau}, a_{h}^{\tau}\right) \phi\left(s_{h}^{\tau}, a_{h}^{\tau}\right)^{\top}$. Computing the inverse matrix of $\Lambda$ takes $O\left(d^{\omega}\right)$. All other operations take $O(d)$. Combining the complexity together, we obtain the pre-computing complexity $O\left(K d^{2}+d^{\omega}\right)$.

Lemma 10.16. The running time of value iteration in Algorithm 4 takes

$$
O\left(H K d^{2} A^{\rho}\right)
$$

Further more,

- If initialize the LSH data-structure using Theorem 7.14, $\rho=1-\frac{1}{4 \sqrt{K}}$.
- If initialize the LSH data-structure using Theorem 7.15, $\rho=1-\frac{1}{8 K}$.

Proof. For each of the $H$ step,

- It takes $O\left(K d^{2} A^{\rho}\right)$ to compute $\widehat{V}_{h+1}\left(s_{h+1}^{\tau}\right)$ for each state $s_{h+1}^{\tau}$. If we initialize the LSH datastructure using Theorem 7.14, we determine $\rho=1-\frac{1}{4 \sqrt{K}}$ using Lemma 8.9. If we initialize the LSH data-structure using Theorem 7.15, we determine $\rho=1-\frac{1}{8 K}$ using Lemma 8.10.
- It takes $O(K d)$ to sum up $\phi\left(s_{h}^{\tau}, a_{h}^{\tau}\right) \cdot\left(r_{h}\left(s_{h}^{\tau}, a_{h}^{\tau}\right)+\widehat{V}_{h+1}\left(s_{h+1}^{\tau}\right)\right)$.
- It takes $O\left(d^{2}\right)$ to multiply $\Lambda$ with the sum of vectors.
- All other operations take $O(d)$.


### 10.11 Comparison

In this section, we show the comparison between our Sublinear LSVI-UCB with LSVI-UCB [JYWJ20]. We show the comparison results in Table 4.

## 11 Extension of Sublinear LSVI-UCB

This section extends the Sublinear LSVI-UCB with different settings.

- In Section 11.1, we introduce our Sublinear LSVI-UCB algorithm in the setting that the policy switch is limited.
- In Section 11.2, we present the model-free version of Sublinear LSVI-UCB algorithm.
- In Section 11.3, we show that comparison of our algorithm with two LSVI-UCB extensions in terms of regret and value iteration complexity.


### 11.1 LSVI-UCB Under Switch Limitation

In the limited switch setting, the number of modifications on the policy in reinforment learning should not exceed a certain threshold. Therefore, we are required to bound the number of switches to achieve the optimal policy. [GXDY21] proposes an approach to do it via LSVI-UCB. We denote this variantion as LGSC. The only different between the LGSC algorithm in [GXDY21] and the LSVI-UCB algorithm in [JYWJ20] is that is rejects the updated policy if the change $\Lambda_{h}^{k}$ is below a threshold. Therefore, we could directly modify LGSC using the same way in Algorithm 4 and propose Sublinear LGSC. Moreover, we obtain the statement as follows:

Corollary 11.1 (Convergence result of Sublinear LSVI-UCB-LGSC, an formal version of Corollary 4.4). Let $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ denotes a linear MDP. Given a fixed probability $p \in(0,1)$, if we set LSVI-UCB parameter $\lambda=1$, approximate Max-IP parameter $c=1-\frac{1}{\sqrt{K}}$ and $\iota=\log (2 d T / p)$, Sublinear LGSC cost has regret at most $O\left(\sqrt{d^{3} H^{3} T \iota^{2}}\right)$ in total then with probability at least $1-p$. Moreover, with $O\left(K A^{1+o(1)}+K d^{2} A\right)$ preprocessing time and space, the value iteration complexity of Sublinear LGSC is $O\left(H K d^{2} A^{\rho}\right)$, where $\rho=1-1 / K$. Moreover, the cost of global switching is at most $O(d H \log K)$.

Proof. As the limitation on the policy switch does not affect the upper bound of regret, Sublinear LGSC have the same upper bound of regret as Sublinear LSVI-UCB. We write the regret of LGSC following Eq. (44) in $O\left(\sqrt{d^{3} H^{4} K \iota^{2}}\right)$. Meanwhile, the upper bound the cost of global switching is independent of the LSH based Max-IP data structure. Therefore, Sublinear LGSC have the same upper bound in the cost of global switching, which is $O(d H \log K)$. Moreover, as the value iteration of Sublinear LGSC is indentical to Sublinear LSVI-UCB, the query time, preprocessing time and space complexity could be determined.

### 11.2 Model-free LSVI-UCB

The major difference of model-free LSVI-UCB and model based LSVI-UCB is that the reward function $r$ remains to be estimated. We denote this method as MF. Therefore, MF in [WDYS20] contains two procedures. In the first procedure, MF performs the similar algorithm as Algorithm 5 except the reward function at each step of each episode is estimated by $\min \left\{\left\|\phi\left(s_{h+1}^{\tau}, a\right)\right\|_{\left(\lambda_{h}^{h}\right)^{-1}}, H\right\}$. Then, in the second procedure, the MF performs the same algorithm as LSVI-UCB based on the estimated reward. Accordingly, we could also propose a Sublinear MF. The Sublinear MF alternates the LSVI-UCB algorithm in the second procedure with the Sublinear LSVI-UCB. Threfore, we have the following statement.

Corollary 11.2 (Main result, convergence result of Model-free Sublinear LSVI-UCB (MF), an formal version of Corollary 4.4). Let $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ denotes a linear MDP. Given a fixed probability $p \in(0,1)$, if we set LSVI-UCB parameter $\lambda=1$, approximate Max-IP parameter $c=1-\frac{1}{\sqrt{K}}$ and $\beta=\Theta(d H \sqrt{\iota})$ with $\iota=\log (2 d T / p)$, then using $O\left(K H^{2} \log \left(\sqrt{d^{-3} H^{-4} K}\right) / \iota^{2}\right)$ episodes for exploration, MF has regret at most $O\left(\sqrt{d^{3} H^{4} K l^{2}}\right)$ in total with probability at least $1-p$. Further more, with $O\left(K A^{1+o(1)}+K d^{2} A\right)$ preprocessing time and space, the value iteration complexity of MF is $O\left(H K d^{2} A^{\rho}\right)$, where $\rho=1-1 / K$.

Proof. We start with several definitions. We denote $r^{*}: \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}$ as the original reward function. We denote $r^{1}: \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}$ as the reward function estimated by the in the exploration phase of MF. Let $V_{1}^{*}\left(s_{1}, r^{*}\right)$ denotes the optimal value function $\pi$ using reward $r^{*}$. Let $V_{1}^{*}\left(s_{1}, r^{1}\right)$ denotes the optimal value function $\pi$ using reward $r^{1}$. From [WDYS20], we know that for any error $\epsilon>0$, with $O\left(d^{3} H^{6} \log \left(d H p^{-1} \epsilon^{-1}\right) / \epsilon^{2}\right)$ episodes in exploration, $V_{1}^{*}\left(s_{1}^{k}, r^{*}\right)-V_{1}^{*}\left(s_{1}^{k}, r^{1}\right) \leq \epsilon$ for any episode $k$. Therefore if we pay $O\left(K H^{2} \log \left(\sqrt{d^{-3} H^{-4} K}\right) / \iota^{2}\right)$ episodes, the would have $\epsilon \leq C_{\beta} \sqrt{d^{3} H^{4} \iota^{2}} / \sqrt{K}$, where $C_{\beta} \geq 100$.

Next, we upper bound the regret as:

$$
\begin{align*}
\operatorname{Regret}(K) & =\sum_{k=1}^{K}\left(V_{1}^{*}\left(s_{1}^{k}\right)-V_{1}^{\pi_{k}}\left(s_{1}^{k}\right)\right) \\
& =\sum_{k=1}^{K}\left(V_{1}^{*}\left(s_{1}^{k}, r^{*}\right)-V_{1}^{*}\left(s_{1}^{k}, r^{1}\right)+V_{1}^{*}\left(s_{1}^{k}, r^{1}\right)-V_{1}^{\pi_{k}}\left(s_{1}^{k}\right)\right) \\
& =\sum_{k=1}^{K}\left(V_{1}^{*}\left(s_{1}^{k}, r^{1}\right)-V_{1}^{\pi_{k}}\left(s_{1}^{k}\right)\right)+\sum_{k=1}^{K}\left(V_{1}^{*}\left(s_{1}^{k}, r^{*}\right)-V_{1}^{*}\left(s_{1}^{k}, r^{1}\right)\right) \\
& =2 C_{\beta} \sqrt{d^{3} H^{4} K \iota^{2}}+\sum_{k=1}^{K}\left(V_{1}^{*}\left(s_{1}^{k}, r^{*}\right)-V_{1}^{*}\left(s_{1}^{k}, r^{1}\right)\right) \\
& =2 C_{\beta} \sqrt{d^{3} H^{4} K \iota^{2}}+K \epsilon \\
& =3 C_{\beta} \sqrt{d^{3} H^{4} K \iota^{2}} \tag{45}
\end{align*}
$$

where the second and third step are reorganizations, the forth step follows from Eq. (44), the fifth step follows from $V_{1}^{*}\left(s_{1}^{k}, r^{*}\right)-V_{1}^{*}\left(s_{1}^{k}, r^{1}\right) \leq \epsilon$, the last step follows from $\epsilon \leq C_{\beta} \sqrt{d^{3} H^{4} \iota^{2}} / \sqrt{K}$.

Therefore, we show that Sublinear MF achieves the same regret as LSVI-UCB and MF. Moreover, the preprocessing time, space and value iteration complexity of MF is as same as LSVI-UCB.

### 11.3 Comparison

In this section, we show the comparison between our Sublinear LSVI-UCB with LGSC [GXDY21] and MF [WDYS20]. We show the comparison results in Table 5.

## 12 More Data Structures: Adaptive Max-IP Queries

In this section, we show how to tackle the adaptive Max-IP queries in RL. In both Sublinear LSVI and Sublinear LSVI-UCB, the queries for $(c, \tau)$-Max-IP during the value iteration are adaptive but not arbitrary. Thus, we could not union bound the failure probability of LSH for $(c, \tau)$-Max-IP. In this work, we present a quantization method to union bound the failure probability of adaptive Max-IP queries. This section is organized as:

- In Section 12.1, we introduce the LSH data structure for adaptive Max-IP queries and theoretical guarantee of Sublinear LSVI with this data structure.
- In Section 12.2, we present the LSH data structure for adaptive Max-MatNorm queries and theoretical guarantee of Sublinear LSVI-UCB with this data structure.


### 12.1 Sublinear LSVI with Adaptive Max-IP Queries

In this section, we show how to tackle adaptive Max-IP queries in Sublinear LSVI. We start with defining the quantized approximate Max-IP.

Definition 12.1 (Quantized approximate Max-IP). Let $c \in(0,1)$ and $\tau \in(0,1)$. Let $\lambda \geq 0$. Given an $n$-point dataset $Y \subset \mathbb{S}^{d-1}$, the goal of the $(c, \tau, \lambda)$-Max-IP is to build a data structure that, given a query $x \in \mathbb{S}^{d-1}$ with the promise that there exists a datapoint $y \in Y$ with $\langle x, y\rangle \geq \tau$, it reports a datapoint $z \in Y$ with similarity $\langle x, z\rangle \geq c \cdot \operatorname{Max}-\operatorname{IP}(x, Y)-\lambda$.

Next, we show a standard way of performing approximate Max-IP via LSH. We denote $Q$ as the convex hull of all queries for $(c, \tau)$-Max-IP and denote its maximum diameter in $\ell_{2}$ distance as $D_{X}$. Our quantization method ${ }^{\text {viii }}$ contains two steps: (1) Preprocessing: we quantize $Q$ to a lattice $\widehat{Q}$ with quantization error $\lambda / d$. In this way, each coordinate would be quantized into the

[^7]multiples of $\lambda / d$. (2) Query: given a query $x \in Q$, we first quantize it to the nearest $\widehat{q} \in \widehat{Q}$ and perform $(c, \tau)$-Max-IP. As each $\widehat{q} \in \widehat{Q}$ is independent, we could union bound the failure probability of adaptive queries. On the other hand, this would generate an $\lambda$ additive error in the returned inner product.

Next, we show our theorem for $(c, \tau, \lambda)$-Max-IP over adaptive queries in Theorem 12.2.
Theorem 12.2 (A modified version of Theorem 8.2). Let $c \in(0,1), \tau \in(0,1)$ and $\lambda \in(0,1)$. Given a set of $n$-points $Y \subset \mathbb{S}^{d-1}$ on the sphere, one can construct a data structure with $\mathcal{T}_{\text {init }} \cdot \kappa$ preprocessing time and $\mathcal{S}_{\text {space }} \cdot \kappa$ space so that for every query $x \in \mathbb{S}^{d-1}$ in an adaptive sequence $X=\left\{x_{1}, x_{2}, \cdots, x_{T}\right\}$, we take query time complexity $O\left(d n^{\rho} \cdot \kappa\right)$ :

- if $\operatorname{Max-IP}(x, Y) \geq \tau$, then we output a vector in $Y$ which is a $(c, \tau, \lambda)$-Max-IP with respect to $(x, Y)$ with probability at least $1-\delta$, where $\rho=f(c, \tau)+o(1)$.
- otherwise, we output fail.
where $\kappa:=d \log \left(n d D_{X} /(\lambda \delta)\right)$ and $\rho \in(0,1)$. We use $D_{X}$ to represent maximum diameter in $\ell_{2}$ distance of all queries in $X$.

Further more,

- If $\mathcal{T}_{\text {init }}=O\left(d n^{1+\rho}\right)$ and $\mathcal{S}_{\text {space }}=O\left(n^{1+\rho}+d n\right)$, then $f(c, \tau)=\frac{1-\tau}{1-2 c \tau+\tau}$.
- If $\mathcal{T}_{\text {init }}=O\left(d n^{1+o(1)}\right)$ and $\mathcal{S}_{\text {space }}=O\left(n^{1+o(1)}+d n\right)$, then $f(c, \tau)=\frac{2(1-\tau)^{2}}{(1-c \tau)^{2}}-\frac{(1-\tau)^{4}}{(1-c \tau)^{4}}$.

Proof. The failure probability for an adaptive sequence $X$ is equivalent to the probability that at least one query $\widehat{q} \in \widehat{Q}$ fail in solving all $\kappa$ number of $(c, \tau)$-Max-IP. We bound this failure probability as

$$
\operatorname{Pr}[\exists \widehat{q} \in \widehat{Q} \quad \text { s.t all }(c, \tau) \text {-Max-IP fail }]=n \cdot\left(\frac{d D_{X}}{\lambda}\right)^{d} \cdot(1 / 10)^{\kappa} \leq \delta
$$

where the last step follows from $\kappa:=d \log \left(n d D_{X} /(\lambda \delta)\right)$.
For the success queries, it introduces a $\lambda$ error in the inner product. Thus, the results is $(c, \tau, \lambda)$ -Max-IP.

Then, following Theorem 8.2, we finish the proof.
Next, we show a modified Version of Theorem 9.2 with $(c, \tau, \lambda)$-Max-IP.
Theorem 12.3 (Modified Version of Theorem 9.2). Let $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ denotes a linear MDP with core sets $\mathcal{S}_{\text {core }}, \mathcal{A}_{\text {core }}$ (see Definition 7.7) and span matrix $\Phi$ (see Definition 7.8). If we query each $\phi\left(s_{j}, a_{j}\right)$ in the $j$ th row of $\Phi$ for $n=O\left(\epsilon^{-2} L^{2} H^{4} \iota\right)$ times, where $\iota=\log (H d / p)$, the output policy of Sublinear LSVI with $(c, \tau, \lambda)$-Max-IP parameter $c=1-C_{0} L \cdot \sqrt{\iota / n}$ and $\lambda=C_{0} L H \cdot \sqrt{\iota / n}$ would be $\epsilon$-optimal with probability at least $1-p$. In other words, the regret of Sublinear LSVI is at most $O\left(C_{0} L H^{2} \sqrt{\iota / n}\right)$. Moreover, with $\mathcal{T}_{\text {init }} \cdot \kappa$ preprocessing time and $\mathcal{S}_{\text {space }} \cdot \kappa$ space, the value iteration complexity of Sublinear LSVI is $O\left(H S d A^{\rho} \cdot \kappa\right)$, where $\kappa:=d \log \left(n d D_{X} /(\lambda \delta)\right), D_{X}$ is the maximum diameter of weight.

Further more,

- If $\mathcal{T}_{\text {init }}=O\left(S d A^{1+\rho}\right)$ and $\mathcal{S}_{\text {space }}=O\left(S A^{1+\rho}+S d A\right)$, then $\rho=1-\frac{C_{0} L \sqrt{\iota / n}}{4}$.
- If $\mathcal{T}_{\text {init }}=O\left(S d A^{1+o(1)}\right)$ and $\mathcal{S}_{\text {space }}=O\left(S A^{1+o(1)}+S d A\right)$, then $\rho=1-\frac{C_{0}^{2} L^{2} \iota}{8 n}$.

Proof. We start with showing the modified version of value difference. Because the quantization transforms $(c, \tau)$-Max-IP into a $(c, \tau, \lambda)$-Max-IP with a $\lambda$ additive error, we rewrite the value difference as:

$$
\begin{align*}
V_{1}^{*}(s)-\widehat{V}_{1}(s) & \leq \underset{\pi^{*}}{\mathbb{E}}\left[\sum_{h=1}^{H}\left[\left(\mathbb{P}_{h}-\widehat{\mathbb{P}}_{h}\right) \widehat{V}_{h+1}\right]\left(s_{h}, a_{h}\right) \mid s_{1}=s\right]+(1-c) \sum_{h=1}^{H}(H+1-h)+\lambda \cdot H \\
& =\underset{\pi^{*}}{\mathbb{E}}\left[\sum_{h=1}^{H}\left[\left(\mathbb{P}_{h}-\widehat{\mathbb{P}}_{h}\right) \widehat{V}_{h+1}\right]\left(s_{h}, a_{h}\right) \mid s_{1}=s\right]+\frac{1-c}{2} \cdot H(H+1)+\lambda \cdot H \tag{46}
\end{align*}
$$

where the first step adds $\lambda$ error over each step based on Lemma 9.1, and the second step is a reorganization.

Next, we bound the $V_{1}^{*}(s)-\widehat{V}_{1}(s)$ as:

$$
\begin{aligned}
V_{1}^{*}(s)-\widehat{V}_{1}(s) & \leq \underset{\pi^{*}}{\mathbb{E}}\left[\sum_{h=1}^{H}\left[\left(\mathbb{P}_{h}-\widehat{\mathbb{P}}_{h}\right) \widehat{V}_{h+1}\right]\left(s_{h}, a_{h}\right) \mid s_{1}=s\right]+\frac{1-c}{2} \cdot H(H+1)+\lambda \cdot H \\
& \leq H \cdot L \cdot C_{0} \cdot H \cdot \sqrt{\iota / n}+\frac{1-c}{2} \cdot H(H+1)+\lambda \cdot H \\
& =L \cdot C_{0} \cdot H^{2} \cdot \sqrt{\iota / n}+\frac{1-c}{2} \cdot H(H+1)+\lambda \cdot H \\
& \leq L \cdot C_{0} \cdot H^{2} \cdot \sqrt{\iota / n}+(1-c) H^{2}+\lambda \cdot H \\
& \leq 2 C_{0} L H^{2} \sqrt{\iota / n}+\lambda \cdot H \\
& \leq 3 C_{0} L H^{2} \sqrt{\iota / n} \\
& \leq \epsilon
\end{aligned}
$$

where the first step follows from Eq. (46), the second step follows the upper bound of [ $\left(\mathbb{P}_{h}-\right.$ $\left.\left.\widehat{\mathbb{P}}_{h}\right) \widehat{V}_{h+1}\right](s, a)$ in Eq. (25), the third step is an reorganization, the forth step follows from $H \geq 1$ so that $H^{2} \geq H$, the fifth step follows from $1-c=C_{0} L \sqrt{\iota / n}$, the sixth step follows from $\lambda=$ $C_{0} L H \cdot \sqrt{\iota / n}$, the seventh step follows from $n=O\left(C_{0}^{2} \cdot \epsilon^{-2} L^{2} H^{4} \iota\right)$.

Using Theorem 12.2, we derive the preprocessing time, space and query time for value iteration in Sublinear LSVI. Because the value iteration complexity dominates Sublinear LSVI, the final runtime complexity is $O\left(H S d A^{\rho} \cdot \kappa\right)$ with $\rho$ strictly smaller than 1 .

### 12.2 Sublinear LSVI-UCB with Adaptive Max-MatNorm Queries

In this section, we show how to tackle adaptive Max-MatNorm queries in sublinear LSVI-UCB.
We start with defining the quantized approximate Max-MatNorm.
Definition 12.4 (Quantized Approximate Max-MatNorm). Let $c \in(0,1)$ and $\tau \in(0,1)$. Let $\lambda \geq 0$. Given an n-point dataset $Y \subset \mathbb{S}^{d-1}$, the goal of the ( $c, \tau, \lambda$ )-Max-MatNorm is to build a data structure that, given a query $x \in \mathbb{S}^{d-1}$ with the promise that there exists a datapoint $y \in Y$ with $\langle x, y\rangle \geq \tau$, it reports a datapoint $z \in Y$ with similarity $\langle x, z\rangle \geq c \cdot \operatorname{Max-MatNorm}(x, Y)-\lambda$.

Next, we present how to extend quantized approximate Max-IP to approximate Max-MatNorm.
Theorem 12.5 (A modified version of Theorem 8.6). Let $c \in(0,1), \tau \in(0,1)$ and $\lambda \in(0,1)$. Let vec denotes the vectorization of $d \times d$ matrix into a $d^{2}$ vector. Given a set of $n$-points $Y$ and $y y^{\top} \in \mathbb{S}^{d^{2}-1}$ for all $y \in Y$, one can construct a data structure with with $\mathcal{T}_{\text {init }} \cdot \kappa$ preprocessing time and $\mathcal{S}_{\text {space }} \cdot \kappa$ space so that for every query $x \in \mathbb{R}^{d \times d}$ with $\operatorname{vec}(x) \in \mathbb{S}^{d^{2}-1}$ in an adaptive sequence $X=\left\{x_{1}, x_{2}, \cdots, x_{T}\right\}$, we take query time $O\left(d^{2} n^{\rho} \cdot \kappa\right)$ :

- if Max-MatNorm $(x, Y) \geq \tau$, then we output a vector in $Y$ which is a $(c, \tau, \lambda)$-Max-MatNorm with respect to $(x, Y)$ with probability at least $\delta$, where $\rho:=f(c, \tau)+o(1)$.
- otherwise, we output fail.
where $\kappa:=d \log \left(n d D_{X} /(\lambda \delta)\right)$ and $\rho \in(0,1)$. We use $D_{X}$ to represent maximum diameter in $\ell_{2}$ distance of all queries in $X$ after vectorization.

Further more,

- If $\mathcal{T}_{\text {init }}=O\left(d^{2} n^{1+\rho}\right)$ and $\mathcal{S}_{\text {space }}=O\left(n^{1+\rho}+d^{2} n\right)$, then $f(c, \tau)=\frac{1-\tau^{2}}{1-c^{2} \tau^{2}+\tau^{2}}$.
- If $\mathcal{T}_{\text {init }}=O\left(d^{2} n^{1+o(1)}\right)$ and $\mathcal{S}_{\text {space }}=O\left(n^{1+o(1)}+d^{2} n\right)$, then $f(c, \tau)=\frac{2\left(1-\tau^{2}\right)^{2}}{\left(1-c^{2} \tau^{2}\right)^{2}}-\frac{\left(1-\tau^{2}\right)^{4}}{\left(1-c^{2} \tau^{2}\right)^{4}}$.

Proof. We start with applying $\left(c^{2}, \tau^{2}, \lambda\right)$-Max-IP data structure over $\operatorname{vec}(x)$ and $\operatorname{vec}\left(Y Y^{\top}\right)$. Then, we would obtain a $z \in Y$ that

$$
\begin{equation*}
\left\langle\operatorname{vec}(x), \operatorname{vec}\left(z z^{\top}\right)\right\rangle \geq c^{2} \max _{y \in Y}\left\langle\operatorname{vec}(x), \operatorname{vec}\left(y y^{\top}\right)-\lambda\right\rangle \tag{47}
\end{equation*}
$$

we could use it and derive the following propriety for $z$ :

$$
\begin{aligned}
\|z\|_{x} & =\sqrt{\left\langle\operatorname{vec}(x), \operatorname{vec}\left(z z^{\top}\right)\right\rangle} \\
& \geq \sqrt{c^{2} \max _{y \in Y}\left\langle\operatorname{vec}(x), \operatorname{vec}\left(y y^{\top}\right)\right\rangle-\lambda} \\
& \geq \sqrt{c^{2} \max _{y \in Y}\left\langle\operatorname{vec}(x), \operatorname{vec}\left(y y^{\top}\right)\right\rangle}-\sqrt{\lambda} \\
& \geq c \max _{y \in Y} \sqrt{\left\langle\operatorname{vec}(x), \operatorname{vec}\left(y y^{\top}\right)\right\rangle}-\lambda \\
& =c \max _{y \in Y}\|y\|_{x}-\lambda
\end{aligned}
$$

where the second step follows from Eq. (47), the third step follows from Cauchy-Schwartz inequality, the forth follows from $\lambda \in(0,1)$, the last step is a reorganization.

Thus, $z$ is the solution for $(c, \tau, \lambda)$-Max-MatNorm $(x, Y)$. Next, applying Theorem 12.2 , we finish the proof.

Theorem 12.6 (Modified Version of Theorem 10.12). Let $\operatorname{MDP}(\mathcal{S}, \mathcal{A}, H, \mathbb{P}, r)$ denotes a linear MDP. For any probability $p \in(0,1)$ that is fixed, if we set approximate Max-MatNorm parameter $c=1-\frac{\iota}{\sqrt{K}}$, quantization error $\lambda \leq \sqrt{H^{2} K}$ and Sublinear LSVI-UCB parameter $\beta=\Theta(d H \sqrt{\iota})$ with $\iota=\log (2 d T / p)$, then the Sublinear LSVI-UCB (Algorithm 4) has regret at most $O\left(C_{\beta} \cdot \sqrt{d^{3} H^{4} K \iota^{2}}\right)$ with probability $1-p$. Moreover, with $\mathcal{T}_{\text {init }} \cdot \kappa$ preprocessing time and $\mathcal{S}_{\text {space }} \cdot \kappa$ space, the value iteration complexity of Sublinear LSVI-UCB is $O\left(H K d^{2} A^{\rho} \cdot \kappa\right)$, where $\kappa:=d \log \left(n d D_{X} /(\lambda \delta)\right), D_{X}$ is the maximum diameter of weight.

Further more

- If $\mathcal{T}_{\text {init }}=O\left(K d^{2} A^{1+\rho}\right)$ and $\mathcal{S}_{\text {space }}=O\left(K A^{1+\rho}+K d^{2} A\right)$, then $\rho=1-\frac{1}{4 \sqrt{K}}$.
- If $\mathcal{T}_{\text {init }}=O\left(K d^{2} A^{1+o(1)}\right)$ and $\mathcal{S}_{\text {space }}=O\left(K A^{1+o(1)}+K d^{2} A\right)$, then $\rho=1-\frac{1}{8 K}$.

Proof. We start with showing the modified version of Q -function difference $Q_{1}^{*}(s, a)-Q_{1}^{k}(s, a)$. Because the quantization transforms $(c, \tau)$-Max-IP into a $(c, \tau, \lambda)$-Max-IP with a $\lambda$ additive error, we rewrite the $Q_{1}^{*}(s, a)-Q_{1}^{k}(s, a)$ as:

$$
Q_{1}^{*}(s, a)-Q_{1}^{k}(s, a) \leq\left(H-c \frac{1-c^{H}}{1-c}\right)+H \lambda
$$

Next, we could upper bound the regret with probability $1-p$ as:

$$
\begin{aligned}
\operatorname{Regret}(K) & \leq 2 K \gamma H^{2}+2 H \sqrt{T \iota}+\beta H \sqrt{2 d K \iota}+H \lambda \\
& =2 K \gamma H^{2}+2 H \sqrt{T \iota}+C_{\beta} \cdot \sqrt{2 d^{3} H^{4} K \iota^{2}}+H \lambda \\
& =2 \sqrt{H^{4} K \iota^{2}}+2 \sqrt{H^{3} K \iota}+C_{\beta} \cdot \sqrt{2 d^{3} H^{4} K \iota}+H \lambda \\
& =3 \sqrt{H^{4} K}+2 \sqrt{H^{3} K \iota}+C_{\beta} \cdot \sqrt{2 d^{3} H^{4} K \iota} \\
& \leq 2 C_{\beta} \sqrt{d^{3} H^{4} K \iota}
\end{aligned}
$$

where the first step follows from Eq. (44), the second step follows from $\beta=C_{\beta} \cdot d H \sqrt{\iota}$, the third step follows from $\gamma=\frac{1}{\sqrt{K}}$, the forth step is a reorganization follows from $\lambda \leq \sqrt{H^{2} K}$, the last step follows from $C_{\beta} \geq 100$.

Using Theorem 12.5, we derive the preprocessing time, space and query time for value iteration in Sublinear LSVI-UCB. Because the value iteration complexity dominates LSVI-UCB, the final runtime complexity is $O\left(H K d^{2} A^{\rho} \cdot \kappa\right)$ with $\rho$ strictly smaller than 1 . We alternate the $S$ in preprocessing and space by $K$ since $K>S$. Note that to let $\rho$ strict less than 1 . We set $c^{2} \in[0.5,1$ ) and $\tau^{2} \in[0.5,1)$.
