# THE DIRICHLET PROBLEM FOR A CLASS OF HESSIAN QUOTIENT EQUATIONS ON RIEMANNIAN MANIFOLDS

#### Abstract

In this paper, we consider the Dirichlet problem for a class of Hessian quotient equations on Riemannian manifolds. Under the assumption of an admissible subsolution, we solve the existence and the uniquness for the Dirichlet problem in a domain without any geometric restrictions on the boundary, based on the a priori estimates for the solutions to the Hessian quotient type equations.


## 1. Introduction

Let $(M, g)$ be a compact Riemannian manifold of dimension $n \geq 3$ with smooth boundary $\partial M$ and $\bar{M}:=M \cup \partial M$. In this paper, we study the Dirichlet problem for a class of Hessian quotient equations

$$
\begin{cases}\left(\frac{\sigma_{k}}{\sigma_{l}}\right)^{\frac{1}{k-l}}(\lambda[U])=\psi(x, u, \nabla u) & \text { in } M  \tag{1.1}\\ u=\varphi & \text { on } \partial M\end{cases}
$$

where $U=\tau(\Delta u) g-\nabla^{2} u$ with $\tau \geq 1, \nabla^{2} u$ denotes the Hessian of $u, \lambda[U]=$ $\left(\lambda_{1}, \cdots, \lambda_{n}\right)$ are the eigenvalues of $U$ with respect to the metric $g$ and $\psi$ is a positive $C^{\infty}$ function with respect to $(x, z, p) \in \bar{M} \times \mathbb{R} \times T_{x} M$, where $T_{x} M$ denotes the tangent space of $M$ at $x$.

Our interest on the solvability of equation (1.1) is motivated from the complex Monge-Ampère type equations. Recently, Harvey-Lawson [18, 19 introduced a class of functions $u \in C^{2}\left(\mathbb{C}^{n}\right)$, named $(n-1)$-plurisubharmonic, such that the complex Hessian matrix

[^0]is nonnegative definite. For $(n-1)$-plurisubharmonic functions, one can consider the following complex Monge-Ampère equations
\[

If $\psi$ does not depend on $\nabla u$, the Dirichlet problem for (1.3) on strict pseudo-convex domains in $\mathbb{C}^{n}$ was solved by Li [24], who also considered a general class of operators. Tosatti-Weinkove [32, 33] showed that the associated complex Monge-Ampère equation can be solved on any compact Kähler manifold. Harvey-Lawson [17, 18] investigated the corresponding complex Monge-Ampère equation and sloved the Dirichlet problem with $\psi=0$ on suitable domains. Then Han-Ma-Wu [20] considered $k$-convex solutions of complex Laplace equation. Moreover, the complex Hessian equation involving a gradient term on the left hand sides has attracted the interest of many authors due to its geometric applications such as the Gauduchon conjecture, which was solved by Székelyhidi-Tosatti-Weinkove in their work [30], and also see Guan-Nie [11]. For more references, we refer the readers to [15, 4, 5, 31] and references therein.

If the complex Hessian matrix is replaced by the real Hessian matrix in (1.2), a natural question is whether we can study the regularity and solvability to the Dirichlet boundary problem for this kind of fully nonlinear equation (such as (1.1)). This work is a further study on the Dirichlet problem for (1.1) with gradient terms on the right sides of the equation following a recent work by Chu-Jiao [3]. To ensure the ellipticity of (1.1), we need $\lambda[U] \in \Gamma_{k}$. Hence we introduce the following definition.

Definition 1.1. A function $u \in C^{2}(M)$ is called admissible (i.e. $(\eta, k)$-convex) if $\lambda[U] \in \Gamma_{k}$ for any $x \in M$, where $\Gamma_{k}$ is the Garding cone

$$
\Gamma_{k}=\left\{\lambda \in \mathbb{R}^{n}: \sigma_{j}(\lambda)>0, \forall 1 \leq j \leq k\right\}
$$

The main theorem is as follows.
Theorem 1.2. Let $l+2 \leq k \leq n, \varphi \in C^{\infty}(\partial M), \psi \in C^{\infty}\left(\bar{M} \times \mathbb{R} \times T_{x} M\right)$ with $\psi, \psi_{z}>0$. Assume that there exists an admissible subsolution $\underline{u} \in C^{2}(\bar{M})$ satisfying

$$
\begin{cases}\left(\frac{\sigma_{k}}{\sigma_{l}}\right)^{\frac{1}{k-l}}(\lambda[\underline{U}]) \geq \psi(x, \underline{u}, \nabla \underline{u}) & \text { in } M  \tag{1.4}\\ \underline{u}=\varphi & \text { on } \partial M\end{cases}
$$

where $\underline{U}=\tau(\Delta \underline{u}) g-\nabla^{2} \underline{u}$. Then the Dirichlet problem (1.1) is uniquely solvable for $u \in C^{\infty}(\bar{M})$ with $\lambda[U] \in \Gamma_{k}$.

In order to prove Theorem 1.2, a major challenge comes from second order estimates for a domain with arbitrary boundary shape except being smooth. We establish the following global second order estimates.

Theorem 1.3. Let $l+2 \leq k \leq n, \varphi \in C^{2}(\partial M), \psi \in C^{2}\left(\bar{M} \times \mathbb{R} \times T_{x} M\right)$ with $\psi, \psi_{z}>0$, $u \in C^{4}(M) \cap C^{2}(\bar{M})$ be an admissible solution of Dirichlet problem (1.1). Assume that there exists an admissible subsolution $\underline{u} \in C^{2}(\bar{M})$ satisfying (1.4). There exists $C$ depending on $n, k, l,\|u\|_{C^{1}},\|\underline{u}\|_{C^{2}}, \inf \psi,\|\psi\|_{C^{2}}$ and the curvature tensor $R$ such that

$$
\sup _{\bar{M}}\left|\nabla^{2} u\right| \leq C
$$

If $U=\tau(\Delta u) g-\nabla^{2} u$ is replaced by the Hessian matrix $\nabla^{2} u$, equation (1.1) becomes the classical Hessian quotient equation

$$
\begin{equation*}
\left(\frac{\sigma_{k}}{\sigma_{l}}\right)^{\frac{1}{k-l}}\left(\lambda\left[\nabla^{2} u\right]\right)=\psi(x, u, \nabla u) \quad \text { in } M \tag{1.5}
\end{equation*}
$$

which has been widely studied in the past decades for the Euclidean case. When $\psi=\psi(x), C^{2}$ estimates were treated by Caffarelli-Nirenberg-Spruck [1] for $l=0$, where they treated a general class of fully nonlinear equations under conditions on the geometry of $\partial M$, followed by [6, 26]. Then such estimates for (1.5) have been established by Trudinger [35], Ivochkina-Trudinger-Wang [22] who considered the degenerate case, Guan [9] who considered to treat a general class of fully nonlinear equations on Riemannian manifolds, without geometric restrictions to the boundary. When $\psi=\psi(x, u, \nabla u)$, equation (1.5) falls into the setup of Guan-Jiao [10] (see also [7]), and the $C^{2}$ estimate was obtained under the concavity assumption of $\psi$ on $\nabla u$. In Theorem 1.3, we remove this concavity assumption for equation (1.1).

It would be worthwhile to note that this type of equation (1.1) arise naturally from many other important geometric problems. Another example is a class of prescribed curvature problems. A $(0,2)$-tensor on a hypersurface $M \subset \mathbb{R}^{n+1}$ is defined by

$$
\eta_{i j}=H g_{i j}-h_{i j}
$$

where $g_{i j}$ is the induced metric of $M$ from $\mathbb{R}^{n+1}, h_{i j}$ and $H$ are the second fundamental form and the mean curvature of $M$ respectively. The $(n-1)$-convex hypersurface (i.e. $\eta_{i j}$ is nonnegative definite) has been studied intensively by Sha [27, 28], Wu [37], and Harvey-Lawson [16]. Recently, Chu-Jiao [3] considered the following prescribed curvature problem

$$
\sigma_{k}\left(\eta_{i j}(X)\right)=\psi(X, \nu(X)), \quad X \in M
$$

where $\nu$ was the unit outer normal vector of $M$. Later on, The authors [2] studied the corresponding Hessian quotient type prescribed curvature problem. Moreover, an analogue of equation (1.1) on compact manifolds also appeared naturally in conformal geometry, see Gursky-Viaclovsky [14], Li-Sheng [23] and Sheng-Zhang [29].

The organization of the paper is as follows. In Section 2 we start with some preliminaries. Our proof of the estimates heavily depends on results in Section 3 and 4. $C^{1}$ estimates are given in Section 3. In Section 4 we derive the global estimates for second derivatives, and finish the proof of Theorem 1.2 and Theorem [1.3,

## 2. Preliminaries

Let $\lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right) \in \mathbb{R}^{n}$, we recall the definition of elementary symmetric function for $1 \leq k \leq n$

$$
\sigma_{k}(\lambda)=\sum_{1 \leq i_{1}<i_{2}<\cdots<i_{k} \leq n} \lambda_{i_{1}} \lambda_{i_{2}} \cdots \lambda_{i_{k}} .
$$

We also set $\sigma_{0}=1$ and $\sigma_{k}=0$ for $k>n$ or $k<0$. The Garding cone is defined by

$$
\Gamma_{k}=\left\{\lambda \in \mathbb{R}^{n}: \sigma_{i}(\lambda)>0, \forall 1 \leq i \leq k\right\}
$$

We denote $\sigma_{k-1}(\lambda \mid i)=\frac{\partial \sigma_{k}}{\partial \lambda_{i}}$ and $\sigma_{k-2}(\lambda \mid i j)=\frac{\partial^{2} \sigma_{k}}{\partial \lambda_{i} \partial \lambda_{j}}$. Next, we list some properties of $\sigma_{k}$ which will be used later.

Proposition 2.1. Let $\lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right) \in \mathbb{R}^{n}$ and $1 \leq k \leq n$, then we have
(1) $\Gamma_{1} \supset \Gamma_{2} \supset \cdots \supset \Gamma_{n}$;
(2) $\sigma_{k-1}(\lambda \mid i)>0$ for $\lambda \in \Gamma_{k}$ and $1 \leq i \leq n$;
(3) $\sigma_{k}(\lambda)=\sigma_{k}(\lambda \mid i)+\lambda_{i} \sigma_{k-1}(\lambda \mid i)$ for $1 \leq i \leq n$;
(4) $\sum_{i=1}^{n} \frac{\partial\left[\frac{\sigma_{k}}{\sigma_{l}}\right]^{\frac{1}{k-t}}}{\partial \lambda_{i}} \geq\left[\frac{C_{n}^{k}}{C_{n}^{n}}\right]^{\frac{1}{k-l}}$ for $\lambda \in \Gamma_{k}$ and $0 \leq l<k$;
(5) $\left[\frac{\sigma_{k}}{\sigma_{l}}\right]^{\frac{1}{k-l}}$ are concave in $\Gamma_{k}$ for $0 \leq l<k$;
(6) If $\lambda_{1} \geq \lambda_{2} \geq \cdots \geq \lambda_{n}$, then $\sigma_{k-1}(\lambda \mid 1) \leq \sigma_{k-1}(\lambda \mid 2) \leq \cdots \leq \sigma_{k-1}(\lambda \mid n)$ for $\lambda \in \Gamma_{k} ;$
(7) $\sum_{i=1}^{n} \sigma_{k-1}(\lambda \mid i)=(n-k+1) \sigma_{k-1}(\lambda)$.

Proof. All the properties are well known. For example, see Chapter XV in [25] or [21] for proofs of (1), (2), (3), (6) and (7); see Lemma 2.2.19 in [13] for the proof of (4); see [1] and [25] for the proof of (5).

The generalized Newton-MacLaurin inequality is as follows, which will be used later.

Proposition 2.2. For $\lambda \in \Gamma_{m}$ and $m>l \geq 0, r>s \geq 0, m \geq r, l \geq s$, we have

$$
\left[\frac{\sigma_{m}(\lambda) / C_{n}^{m}}{\sigma_{l}(\lambda) / C_{n}^{l}}\right]^{\frac{1}{m-l}} \leq\left[\frac{\sigma_{r}(\lambda) / C_{n}^{r}}{\sigma_{s}(\lambda) / C_{n}^{s}}\right]^{\frac{1}{r-s}}
$$

Proof. See [34.
In this paper, $\nabla$ denotes the Levi-Civita connection on $(M, g)$ and the curvature tensor is defined by

$$
R(X, Y) Z=-\nabla_{X} \nabla_{Y} Z+\nabla_{Y} \nabla_{X} Z+\nabla_{[X, Y]} Z
$$

Let $e_{1}, e_{2}, \cdots, e_{n}$ be local frames on $M$ and denote $g_{i j}=g\left(e_{i}, e_{j}\right),\left\{g^{i j}\right\}=\left\{g_{i j}\right\}^{-1}$, while the Christoffel symbols $\Gamma_{i j}^{k}$ and curvature coefficients are given respectively by
$\nabla_{e_{i}} e_{j}=\Gamma_{i j}^{k} e_{k}$ and

$$
R_{i j k l}=g\left(R\left(e_{k}, e_{l}\right) e_{j}, e_{i}\right), \quad R_{j k l}^{i}=g^{i m} R_{m j k l} .
$$

We shall write $\nabla_{i}=\nabla_{e_{i}}, \nabla_{i j}=\nabla_{i} \nabla_{j}-\Gamma_{i j}^{k} \nabla_{k}$, etc. For a differentiable function $u$ defined on $M$, we usually identify $\nabla u$ with its gradient, and use $\nabla^{2} u$ to denote its Hessian which is locally given by $\nabla_{i j} u=\nabla_{i}\left(\nabla_{j} u\right)-\Gamma_{i j}^{k} \nabla_{k} u$. We note that $\nabla_{i j} u=\nabla_{j i} u$ and

$$
\begin{gather*}
\nabla_{i j k} u-\nabla_{j i k} u=R_{k i j}^{l} \nabla_{l} u,  \tag{2.1}\\
\nabla_{i j}\left(\nabla_{k} u\right)=\nabla_{i j k} u+\Gamma_{i k}^{l} \nabla_{j l} u+\Gamma_{j k}^{l} \nabla_{i l} u+\nabla_{\nabla_{i j} e_{k}} u,  \tag{2.2}\\
\nabla_{i j k l} u-\nabla_{i k j l} u=R_{l j k}^{m} \nabla_{i m} u+\nabla_{i} R_{l j k}^{m} \nabla_{m} u,  \tag{2.3}\\
\nabla_{i j k l} u-\nabla_{j i k l} u=R_{k i j}^{m} \nabla_{m l} u+R_{l i j}^{m} \nabla_{k m} u . \tag{2.4}
\end{gather*}
$$

From (2.3) and (2.4), we obtain

$$
\begin{align*}
\nabla_{i j k l} u-\nabla_{k l i j} u= & R_{l j k}^{m} \nabla_{i m} u+\nabla_{i} R_{l j k}^{m} \nabla_{m} u+R_{l i k}^{m} \nabla_{j m} u \\
& +R_{j i k}^{m} \nabla_{l m} u+R_{j i l}^{m} \nabla_{k m} u+\nabla_{k} R_{j i l}^{m} \nabla_{m} u . \tag{2.5}
\end{align*}
$$

For convenience, we introduce the following notations
$F(U)=\left[\frac{\sigma_{k}(\lambda[U])}{\sigma_{l}(\lambda[U])}\right]^{\frac{1}{k-l}}, \quad F^{i j}=\frac{\partial F}{\partial U_{i j}}, \quad F^{i j, r s}=\frac{\partial^{2} F}{\partial U_{i j} \partial U_{r s}}, \quad Q^{i j}=\frac{\partial F}{\partial u_{i j}}, \quad Q^{i j, r s}=\frac{\partial^{2} F}{\partial u_{i j} \partial u_{r s}}$.
Let $u \in C^{\infty}(\bar{M})$ be an admissible solution of equation (1.1). Under orthonormal local frames $e_{1}, \cdots, e_{n}$, equation (1.1) is expressed in the form

$$
\begin{equation*}
F(U):=f(\lambda[U])=\psi \tag{2.6}
\end{equation*}
$$

For simplicity, we shall still write equation (1.1) in the form (2.6) even if $e_{1}, \cdots, e_{n}$ are not necessarily orthonormal, although more precisely it should be

$$
F\left(\left[\gamma^{i k} U_{k l} \gamma^{l j}\right]\right)=\psi,
$$

where $\gamma^{i j}$ is the square root of $g^{i j}: \gamma^{i k} \gamma^{k j}=g^{i j}$. Whenever we differentiate the equation, it will make no difference as long as we use covariant derivatives. Assume that $\bar{A}$ is an $n \times n$ matrix and $T: \bar{A} \rightarrow T(\bar{A})$ is defined as $T(\bar{A})=\tau(\operatorname{tr}(\bar{A})) I-\bar{A}$.
Let $Q=F \circ T$, then equation (1.1) can also be written as

$$
Q\left(\nabla^{2} u\right):=\widetilde{f}\left(\widetilde{\lambda}\left[\nabla^{2} u\right]\right)=\psi
$$

Hence $Q^{i j}=\frac{\partial Q}{\partial u_{i j}}=\frac{\partial F}{\partial u_{i j}}=\tau \sum_{l} F^{l l} \delta_{i j}-F^{i j}$ and then

$$
\begin{equation*}
Q^{i j} u_{i j}=F^{i j} U_{i j}=f_{i} \lambda_{i}=\tilde{f}_{i} \widetilde{\lambda}_{i}=\psi . \tag{2.7}
\end{equation*}
$$

Differentiating (2.6), we get

$$
\begin{equation*}
Q^{i j} \nabla_{k} u_{i j}=F^{i j} \nabla_{k} U_{i j}=\psi_{k}+\psi_{z} u_{k}+\psi_{p_{i}} u_{i k} \tag{2.8}
\end{equation*}
$$

The following propositions are essential which will be used later. More details can be seen in [2].

Proposition 2.3. Let $M$ be a smooth ( $\eta, k)$-convex closed hypersurface in $\mathbb{R}^{n+1}$ and $0 \leq l<k-1$. Then the operator

$$
F(U)=\left(\frac{\sigma_{k}(\lambda[U])}{\sigma_{l}(\lambda[U])}\right)^{\frac{1}{k-l}}
$$

is elliptic and concave with respect to $U$. Moreover we have

$$
\sum F^{i i} \geq\left(\frac{C_{n}^{k}}{C_{n}^{l}}\right)^{\frac{1}{k-l}}
$$

Proposition 2.4. Let $U$ be a diagonal matrix with $\lambda[U] \in \Gamma_{k}, 0 \leq l \leq k-2$ and $k \geq 3$. Then

$$
-F^{1 i, i 1}(U)=\frac{F^{11}-F^{i i}}{U_{i i}-U_{11}}, \quad \forall i \geq 2
$$

## 3. $C^{1}$ Estimates

In this section, we consider the lower and upper bounds, gradient estimates for the admissible solution to equation (1.1).
Lemma 3.1. Let $u \in C^{\infty}(\bar{M})$ be an admissible solution for equation (1.1). Under the assumptions mentioned in Theorem 1.2, then there exists a positive constant $C$ depending only on $\sup _{\partial M} \varphi$ and the subsolution $\underline{u}$ such that

$$
\sup _{x \in \bar{M}}|u(x)| \leq C .
$$

Proof. On the one hand, according to Definition 1.1, it is easy to see that $\lambda[U] \in \Gamma_{k} \subset$ $\Gamma_{1}$, which implies that $\operatorname{tr}(\lambda[U])=(\tau n-1) \Delta u>0$. Combined with the maximum principle, we have

$$
\sup _{\bar{M}} u \leq \sup _{\partial M} \varphi .
$$

On the other hand, we know that there exists an admissible subsolution $\underline{u} \in C^{2}(\bar{M})$ satisfying (1.4). By the fact $\psi_{z}>0$ and the comparison principle,

$$
u \geq \underline{u}, \quad \forall x \in \bar{M} .
$$

Lemma 3.2. Let $l+2 \leq k \leq n, \varphi \in C^{\infty}(\partial M), \psi \in C^{\infty}\left(\bar{M} \times \mathbb{R} \times T_{x} M\right)$ with $\psi, \psi_{z}>0$. If $u \in C^{2}(\bar{M})$ is the solution of equation (1.1), then

$$
\sup _{M}|\nabla u| \leq C\left(1+\sup _{\partial M}|\nabla u|\right),
$$

where $C$ is a constant depending on $n, k, l,\|u\|_{C^{0}},\|\psi\|_{C^{1}}$ and the curvature tensor $R$.

Proof. Consider the auxiliary function

$$
P(x)=v e^{\phi(u)}
$$

where $v=1+\frac{1}{2}|\nabla u|^{2}, \phi(u): \mathbb{R} \longrightarrow \mathbb{R}$ is a function satisfying

$$
\phi^{\prime}(u)>0, \quad \phi^{\prime \prime}(u)-\left(\phi^{\prime}(u)\right)^{2} \geq \varepsilon
$$

for some positive constant $\varepsilon$ depending on $\|u\|_{C^{0}}$.
Suppose that $P$ attains its maximum at $x_{0} \in M$. By rotating the coordinates, we diagonal the matrix $\nabla^{2} u$. In the following, we write simply $u_{i}=\nabla_{i} u, u_{i j}=\nabla_{i j} u$ and $u_{i j k}=\nabla_{k} u_{i j}$, then at $x_{0}$,

$$
\begin{equation*}
0=P_{i}=\left(u_{i i} u_{i}+v \phi^{\prime} u_{i}\right) e^{\phi(u)} \tag{3.1}
\end{equation*}
$$

and

$$
\begin{equation*}
0 \geq P_{i i}=\left(u_{i i}^{2}+u_{k} u_{k i i}+2 u_{i}^{2} u_{i i} \phi^{\prime}+u_{i}^{2} v\left(\phi^{\prime \prime}+\left(\phi^{\prime}\right)^{2}\right)+v \phi^{\prime} u_{i i}\right) e^{\phi(u)} \tag{3.2}
\end{equation*}
$$

We assume that $v \leq|\nabla u|^{2}$, i.e., $|\nabla u|^{2} \geq 2$. Otherwise our result holds. Let

$$
\mathcal{S}=\left\{i \in(1, \cdots, n) \mid u_{i} \neq 0\right\}
$$

Obviously $\mathcal{S} \neq \emptyset$ and we derive

$$
u_{i i}=-v \phi^{\prime}<0, \quad i \in \mathcal{S}
$$

by (3.1). From the mean curvature $H>0$, we have

$$
Q^{i i} \geq \sum_{l \neq i} F^{l l} \geq \frac{1}{2} \sum_{l} F^{l l}
$$

which implies

$$
\begin{align*}
Q^{i i} u_{i}^{2} & =\sum_{i \in S} Q^{i i} u_{i}^{2} \geq \sum_{i \in S}\left(\frac{1}{2} \sum_{l} F^{l l}\right) u_{i}^{2} \\
& =\left(\frac{1}{2} \sum_{l} F^{l l}\right)|\nabla u|^{2}=\frac{1}{2(\tau n-1)}\left(\sum_{l} Q^{l l}\right)|\nabla u|^{2} . \tag{3.3}
\end{align*}
$$

Since $Q^{i i} \geq 0$ and by Ricci identity, we have $u_{k i j}=u_{i j k}+R_{j k i}^{l} u_{l}$, then

$$
\begin{align*}
0 \geq & Q^{i i}\left(u_{k} u_{k i i}+2 u_{i}^{2} u_{i i} \phi^{\prime}+u_{i}^{2} v\left(\phi^{\prime \prime}+\left(\phi^{\prime}\right)^{2}\right)+v \phi^{\prime} u_{i i}\right) \\
= & \psi_{k} u_{k}+\psi_{z} u_{k}^{2}+\psi_{p_{k}} u_{k} u_{k k}+R_{i k i}^{l} Q^{i i} u_{k} u_{l}+2 \phi^{\prime} Q^{i i} u_{i}^{2} u_{i i} \\
& +v\left(\phi^{\prime \prime}+\left(\phi^{\prime}\right)^{2}\right) Q^{i i} u_{i}^{2}+v \phi^{\prime} Q^{i i} u_{i i} \\
\geq & \psi_{k} u_{k}-v \phi^{\prime} \psi_{p_{k}} u_{k}+R_{i k i}^{l} Q^{i i} u_{k} u_{l}+v\left(\phi^{\prime \prime}-\left(\phi^{\prime}\right)^{2}\right) Q^{i i} u_{i}^{2}+v \phi^{\prime} \psi \\
4) \geq & \sum_{l} Q^{l l}\left(\frac{\varepsilon}{4(\tau n-1)}|\nabla u|^{4}-\bar{C}|\nabla u|^{2}\right)-\bar{C} \phi^{\prime}|\nabla u|^{3}-\bar{C} \phi^{\prime}|\nabla u|^{2}-\bar{C}|\nabla u|, \tag{3.4}
\end{align*}
$$

where $\bar{C}$ is a constant depending on $\|\psi\|_{C^{1}}$ and the curvature tensor $R$.
On the one hand, if $\frac{\varepsilon}{4(\tau n-1)}|\nabla u|^{4}-\bar{C}|\nabla u|^{2} \leq 0$, then $|\nabla u| \leq C$. Otherwise by (3.4) and the fact $\sum_{l} Q^{l l} \geq(\tau n-1)\left(\frac{C_{n}^{k}}{C_{n}^{n}}\right)^{\frac{1}{k-l}}$, we derive
$(\tau n-1)\left(\frac{C_{n}^{k}}{C_{n}^{l}}\right)^{\frac{1}{k-l}}\left(\frac{\varepsilon}{4(\tau n-1)}|\nabla u|^{4}-\bar{C}|\nabla u|^{2}\right)-\bar{C} \phi^{\prime}|\nabla u|^{3}-\bar{C} \phi^{\prime}|\nabla u|^{2}-\bar{C}|\nabla u| \leq 0$, then $|\nabla u| \leq C$, the lemma is proved.

Next, we derive the global $C^{1}$ estimates for the solution of equation (1.1).
Theorem 3.3. Let $u \in C^{\infty}(\bar{M})$ be an admissible solution for equation (1.1). Under the assumptions mentioned in Theorem 1.2. then

where $C$ is a constant depending on $n, k, l,\|u\|_{C^{0}},\|\underline{u}\|_{C^{1}},\|\varphi\|_{C^{1}},\|\psi\|_{C^{1}}$ and the curvature tensor $R$.
Proof. From Lemma 3.2, we are left with the task of estimating the exterior normal derivative of $u$ on $\partial M$. Let $h$ be the harmonic function in $M$ which equals $\varphi$ on $\partial M$, then we derive

## 4. Global Estimates for Second derivatives

In this section, we prove the global second order estimates and give the proof of Theorem 1.2 and 1.3. Firstly, we need to derive the following theorem.
Theorem 4.1. Let $u \in C^{\infty}(M)$ be an admissible solution for equation (1.1). Then there exists a constant $C$ depending only on $n, k, l,\|u\|_{C^{1}},\|\underline{u}\|_{C^{2}},\|\psi\|_{C^{2}}$ and the curvature tensor $R$ such that

$$

Proof. Taking the auxiliary function

where $\tilde{\lambda}_{\max }\left(\nabla^{2} u\right)$ is the largest eigenvalue of $\nabla^{2} u, a \leq 1$ and $A \geq 1$ are constants to be determined later, $x_{0}$ is the maximum point of $\widehat{H}$. We choose a local orthonormal frame $\left\{e_{1}, e_{2}, \cdots, e_{n}\right\}$ near $x_{0}$ such that $\nabla_{e_{i}} e_{j}=0$, i.e. $\Gamma_{i j}^{k}=0$ at $x_{0}$ for any $1 \leq$ $i, j, k \leq n$. For convenience, we write $u_{i}=\nabla_{i} u, u_{i j}=\nabla_{i j} u, u_{i j l}=\nabla_{l} u_{i j}, u_{i j r s}=$ $\nabla_{r s} u_{i j}$ and $R_{i j s ; l}^{m}=\nabla_{l} R_{i j s}^{m}$. Assume that

at $x_{0}$. Recalling that $U_{i i}=\tau \Delta u-u_{i i}$, we have

where $C_{0}$ depends on $\|\psi\|_{C^{2}},\|u\|_{C^{1}},\|\underline{u}\|_{C^{2}}$ and the curvature tensor $R$.

& -\frac{Q^{i i} u_{11 i}^{2}}{u_{11}^{2}}+a Q^{i i} u_{i i}^{2}+a u_{k} Q^{i i} u_{k i i}+A Q^{i i}(\underline{u}-u)_{i i} \\
\geq & \frac{Q^{i i} u_{i i 11}}{u_{11}}-\frac{Q^{i i} u_{11 i}^{2}}{u_{11}^{2}}+a Q^{i i} u_{i i}^{2}+a Q^{i i} u_{k} u_{k i i}+A Q^{i i}(\underline{u}-u)_{i i} \\
& -C_{1} \sum_{i} Q^{i i}-\frac{C_{1} Q^{i i}\left|u_{i i}\right|}{u_{11}}-\frac{C_{1} \sum_{i} Q^{i i}}{u_{11}}, \tag{4.4}

where $C_{1}$ is a constant depending only on $\|u\|_{C^{1}}$ and the curvature tensor $R$.

& \geq \frac{C_{n}^{k}}{C_{n}^{k-1}} \psi^{1-k+l} \frac{C_{n-1}^{k-1}(\tau-\tau(n-2) \delta)^{k-1}+(\tau-1-\tau(n-1) \delta) C_{n-1}^{k-2}(\tau+\tau(n-2) \delta)^{k-2}}{C_{n}^{l}(\tau+\tau(n-2) \delta)^{l}} u_{11} \\

\sum_{i} \widetilde{f}_{i}\left|\widetilde{\lambda}_{i}\right| \leq \varepsilon \sum_{i \neq r} \widetilde{f}_{i} \widetilde{\lambda}_{i}^{2}+\frac{C}{\varepsilon} \sum_{i} \widetilde{f}_{i}+Q(r) \tag{4.33}
\end{equation*}
$$

where $Q(r)=\widetilde{f}(\widetilde{\lambda})-\widetilde{f}(\mathbf{1})$ if $\lambda_{r} \geq 0, \mathbf{1}=(1, \cdots, 1)$ and for some constant $K_{0} \geq 0$,

$$
Q(r)=\varepsilon n K_{0}^{2} \min _{1 \leq i \leq n} \frac{1}{\widetilde{f}_{i}}, \quad \text { if } \lambda_{r}<0
$$

Hence (4.30)-(4.33) yield that

$$
\begin{aligned}
& A_{3} \sum_{\beta<n} L\left|\nabla_{\beta}(u-\underline{u})\right|^{2} \pm L\left(\nabla_{\alpha}(u-\underline{u})\right) \\
\geq & 2 A_{3} \sum_{\beta<n} Q^{i j} u_{i \beta} u_{j \beta}-\widehat{C}_{1}\left(1+\sum_{i} \widetilde{f}_{i}\left|\widetilde{\lambda}_{i}\right|+\sum_{i} \widetilde{f}_{i}\right) \\
& -A_{3} \widehat{C}_{2}(n-1)\left(1+\sum_{i} \tilde{f}_{i}\left|\widetilde{\lambda}_{i}\right|+\sum_{i} \widetilde{f}_{i}\right) \\
\geq & A_{3} \sum_{i \neq r} \widetilde{f}_{i} \widetilde{\lambda}_{i}^{2}-\left(A_{3} \widehat{C}_{2}(n-1)+\widehat{C}_{1}\right)\left(1+\varepsilon \sum_{i \neq r} \widetilde{f}_{i} \widetilde{\lambda}_{i}^{2}+\frac{C}{\varepsilon} \sum_{i} \widetilde{f}_{i}+\sum_{i} \widetilde{f}_{i}+Q(r)\right) \\
\geq & \left(A_{3}-A_{3} \widehat{C}_{2}(n-1) \varepsilon-\widehat{C}_{1} \varepsilon\right) \sum_{i \neq r} \widetilde{f}_{i} \widetilde{\lambda}_{i}^{2}-A_{3} \widehat{C}_{3}\left(1+\sum_{i} \widetilde{f}_{i}\right) \\
\geq & -A_{3} \widehat{C}_{3}\left(1+\sum_{i} \widetilde{f}_{i}\right),
\end{aligned}
$$

by choosing $0<\varepsilon<\min \left\{\frac{1}{C_{2}(n-1)}, 1\right\}$ and $A_{3}>\max \left\{\frac{\widehat{C}_{1} \varepsilon}{1-\widehat{C}_{2}(n-1) \varepsilon}, 1\right\}$. Combine with Lemma 4.2 and choose $A_{1} \gg A_{2} \gg A_{3} \gg 1$, then

$$
\begin{cases}L\left(\Phi \pm \nabla_{\alpha}(u-\underline{u})\right) \leq 0 & \text { in } M_{\delta} \\ \Phi \pm \nabla_{\alpha}(u-\underline{u}) \geq 0 & \text { on } \partial M_{\delta}\end{cases}
$$

Therefore by the maximum principle, we have

$$
\Phi \pm \nabla_{\alpha}(u-\underline{u}) \geq 0 \quad \text { in } M_{\delta} .
$$

Thus we obtain

$$
\left|\nabla_{n \alpha} u\left(x_{0}\right)\right| \leq \nabla_{n} \Phi\left(x_{0}\right)+\left|\nabla_{n \alpha} \underline{u}\left(x_{0}\right)\right| \leq C, \quad \alpha=1, \cdots, n-1 .
$$

Case 3 : Estimates of $\nabla_{n n} u$ on $\partial M$.
We only need to show the uniform upper bound

$$
\nabla_{n n} u\left(x_{0}\right) \leq C, \quad \forall x_{0} \in \partial M
$$

since $\Gamma_{k} \subset \Gamma_{1}$ implies $\Delta u \geq 0$ and the lower bound for $\nabla_{n n} u$ follows from the estimate of $\nabla_{\alpha \beta} u$ and $\nabla_{\alpha n} u$. We will divide the proof into two conditions. The case $\tau=1$ is more complicated and need classified discussion.

When $\tau>1$, we have

$$
\begin{aligned}
{\left[U\left(x_{0}\right)\right] } & =\tau \Delta u\left(x_{0}\right) I-\nabla^{2} u\left(x_{0}\right) \\
& \geq \operatorname{diag}\left(\tau \nabla_{n n} u\left(x_{0}\right), \cdots, \tau \nabla_{n n} u\left(x_{0}\right),(\tau-1) \nabla_{n n} u\left(x_{0}\right)\right)-\bar{C}_{0} I \\
& \geq\left((\tau-1) \nabla_{n n} u\left(x_{0}\right)-\bar{C}_{0}\right) I,
\end{aligned}
$$

where $\bar{C}_{0}$ depends on $\left\|\nabla_{\alpha \beta} u\right\|_{C^{0}}$ and $\left\|\nabla_{\alpha n} u\right\|_{C^{0}}$. It is clear that

$$
\begin{aligned}
\psi\left(x_{0}, u\left(x_{0}\right), \nabla u\left(x_{0}\right)\right)=F(U)\left(x_{0}\right) & =F^{i j}\left(x_{0}\right) U_{i j}\left(x_{0}\right) \\
& \geq\left((\tau-1) \nabla_{n n} u\left(x_{0}\right)-\bar{C}_{0}\right) \sum_{l} F^{l l}
\end{aligned}
$$

Thus we obtain the upper bound as desired.
When $\tau=1$. By lemma 1.2 of [1] and the estimates of $\nabla_{\alpha \beta} u, \nabla_{\alpha n} u$, we can choose $R_{1}>0$ sufficiently large such that if $\nabla_{n n} u\left(x_{0}\right)>R_{1}$,

$$
\left\{\begin{array}{l}
\widetilde{\lambda}_{i}\left[\nabla_{i j} u\left(x_{0}\right)\right]=\widetilde{\lambda}_{i}^{\prime}\left[\nabla_{\alpha \beta} u\left(x_{0}\right)\right]+o(1), \quad i=1, \cdots, n-1, \\
\widetilde{\lambda}_{n}\left[\nabla_{i j} u\left(x_{0}\right)\right]=\nabla_{n n} u\left(x_{0}\right)\left(1+O\left(\frac{1}{\nabla_{n n} u\left(x_{0}\right)}\right)\right) .
\end{array}\right.
$$

Here $\widetilde{\lambda}\left[\nabla_{i j} u\right]=\left(\widetilde{\lambda}_{1}\left[\nabla_{i j} u\right], \cdots, \widetilde{\lambda}_{n}\left[\nabla_{i j} u\right]\right)$ denotes the eigenvalues of the $n \times n$ matrix $\nabla^{2} u$ and $\widetilde{\lambda}^{\prime}\left[\nabla_{\alpha \beta} u\right]=\left(\widetilde{\lambda}_{1}^{\prime}\left[\nabla_{\alpha \beta} u\right], \cdots, \widetilde{\lambda}_{n-1}^{\prime}\left[\nabla_{\alpha \beta} u\right]\right)$ denotes the eigenvalues of the ( $n-$ $1) \times(n-1)$ matrix $\left[\nabla_{\alpha \beta} u\right]_{1 \leq \alpha, \beta \leq n-1}$. For convenience, we denote

$$
\widetilde{\lambda}_{i}=\widetilde{\lambda}_{i}\left[\nabla_{i j} u\right], \quad \widetilde{\lambda}_{\alpha}^{\prime}=\widetilde{\lambda}_{\alpha}^{\prime}\left[\nabla_{\alpha \beta} u\right], \quad \widehat{\lambda}_{i}=\sum_{l=1}^{n} \widetilde{\lambda}_{l}-\widetilde{\lambda}_{i}, \quad \widehat{\lambda}_{\alpha}^{\prime}=\sum_{i=1}^{n-1} \widetilde{\lambda}_{i}^{\prime}-\widetilde{\lambda}_{\alpha}^{\prime} .
$$

If $k<n$,

$$
\begin{aligned}
& F^{k-l}(U)\left(x_{0}\right) \\
= & \frac{\sigma_{k}}{\sigma_{l}}\left(\sum_{i} \widetilde{\lambda}_{i}\left(x_{0}\right)-\widetilde{\lambda}_{1}\left(x_{0}\right), \cdots, \sum_{i} \widetilde{\lambda}_{i}\left(x_{0}\right)-\widetilde{\lambda}_{n}\left(x_{0}\right)\right) \\
= & \frac{\sigma_{k}}{\sigma_{l}}\left(\widetilde{\lambda}_{n}\left(x_{0}\right)+\widehat{\lambda}_{1}^{\prime}\left(x_{0}\right)+o(1), \cdots, \widetilde{\lambda}_{n}\left(x_{0}\right)+\widehat{\lambda}_{n-1}^{\prime}\left(x_{0}\right)+o(1), \sum_{i=1}^{n-1} \widetilde{\lambda}_{i}^{\prime}\left(x_{0}\right)+o(1)\right) \\
\geq & \frac{\widetilde{\lambda}_{n}^{k}\left(x_{0}\right)+o\left(\widetilde{\lambda}_{n}^{k-1}\left(x_{0}\right)\right)}{C_{n}^{l} \widetilde{\lambda}_{n}^{l}\left(x_{0}\right)+O\left(\widetilde{\lambda}_{n}^{l-1}\left(x_{0}\right)\right)},
\end{aligned}
$$

which implies the uniform upper bound of $\nabla_{n n} u\left(x_{0}\right)$.
If $k=n$, we show the uniform upper bound of $\nabla_{n n} u\left(x_{0}\right)$ by proving that there are uniform constants $\bar{C}_{1}$ such that

$$
\begin{equation*}
\min _{x \in \partial M} \operatorname{tr}\left(\left[\nabla_{\alpha \beta} u\right]\right) \geq \bar{C}_{1}>0 \tag{4.34}
\end{equation*}
$$

Suppose we have found such $\bar{C}_{1}$, then

$$
\begin{aligned}
& F^{n-l}(U)\left(x_{0}\right) \\
= & \frac{\sigma_{n}}{\sigma_{l}}\left(\widetilde{\lambda}_{n}\left(x_{0}\right)+\widehat{\lambda}_{1}^{\prime}\left(x_{0}\right)+o(1), \cdots, \widetilde{\lambda}_{n}\left(x_{0}\right)+\widehat{\lambda}_{n-1}^{\prime}\left(x_{0}\right)+o(1), \sum_{i=1}^{n-1} \widetilde{\lambda}_{i}^{\prime}\left(x_{0}\right)+o(1)\right) \\
\geq & \frac{\bar{C}_{1} \widetilde{\lambda}_{n}^{n-1}\left(x_{0}\right)+o\left(\widetilde{\lambda}_{n}^{n-1}\left(x_{0}\right)\right)}{C_{n}^{l} \widetilde{\lambda}_{n}^{l}\left(x_{0}\right)+O\left(\widetilde{\lambda}_{n}^{l-1}\left(x_{0}\right)\right)},
\end{aligned}
$$

which implies the uniform upper bound of $\nabla_{n n} u\left(x_{0}\right)$. Hence we only need to prove (4.34).

Suppose that $\operatorname{tr}\left(\left[\nabla_{\alpha \beta} u\right]\right)$ attains its minimum at $x_{1} \in \partial M$. To show (4.34), we may assume $\operatorname{tr}\left(\left[\nabla_{\alpha \beta} u\left(x_{1}\right)\right]\right)<\frac{1}{2} \operatorname{tr}\left(\left[\nabla_{\alpha \beta} \underline{u}\left(x_{1}\right)\right]\right)$, since otherwise we are done as $\operatorname{tr}\left(\left[\nabla_{\alpha \beta} \underline{u}\left(x_{1}\right)\right]\right)=\sum_{i} \widetilde{\lambda}_{i}\left[\nabla_{i j} \underline{u}\right]-\widetilde{\lambda}_{n}\left[\nabla_{i j} \underline{u}\right]>\bar{C}_{2}$. Let us compute

$$
\nabla_{\alpha \alpha} u=\nabla_{\alpha \alpha} \underline{u}-\nabla_{n}(u-\underline{u}) B_{\alpha \alpha} \quad \text { on } \partial M .
$$

It follows that

$$
\begin{align*}
\nabla_{n}(u-\underline{u})\left(x_{1}\right) \sum_{\alpha} B_{\alpha \alpha}\left(x_{1}\right) & =\operatorname{tr}\left(\left[\nabla_{\alpha \beta} \underline{u}\left(x_{1}\right)\right]\right)-\operatorname{tr}\left(\left[\nabla_{\alpha \beta} u\left(x_{1}\right)\right]\right) \\
& \geq \frac{1}{2} \operatorname{tr}\left(\left[\nabla_{\alpha \beta} \underline{u}\left(x_{1}\right)\right]\right)>\frac{\bar{C}_{2}}{2} \tag{4.35}
\end{align*}
$$

For any $x \in \partial M$ near $x_{0}$, applying that $\left.\operatorname{tr}\left(\left[\nabla_{\alpha \beta} u\right]\right)\right|_{\partial M}$ is minimized at $x_{1}$ yields, $\nabla_{n}(u-\underline{u})(x) \sum_{\alpha} B_{\alpha \alpha}(x) \leq \operatorname{tr}\left(\left[\nabla_{\alpha \beta} \underline{u}(x)\right]\right)-\operatorname{tr}\left(\left[\nabla_{\alpha \beta} \underline{u}\left(x_{1}\right)\right]\right)+\nabla_{n}(u-\underline{u})\left(x_{1}\right) \sum_{\alpha} B_{\alpha \alpha}\left(x_{1}\right)$.
Note that $B_{\alpha \alpha}$ is smooth near $\partial M$ and $0<u-\underline{u} \leq C$, adding (4.35), we can choose a constant $\delta$ sufficiently small such that

$$
\sum_{\alpha} B_{\alpha \alpha} \geq \bar{C}_{3}>0 \quad \text { in } M \cap B_{\delta}\left(x_{1}\right)
$$

for some uniform constant $\bar{C}_{3}>0$. Therefore

$$
\nabla_{n}(u-\underline{u})\left(x_{1}\right)=\Psi\left(x_{1}\right), \quad \nabla_{n}(u-\underline{u})(x) \leq \Psi(x) \quad \text { on } B_{\delta}\left(x_{1}\right) \cap \partial M
$$

where $\Psi=\left(\sum_{\alpha} B_{\alpha \alpha}(x)\right)^{-1}\left(\operatorname{tr}\left(\left[\nabla_{\alpha \beta} \underline{u}(x)\right]\right)-\operatorname{tr}\left(\left[\nabla_{\alpha \beta} \underline{u}\left(x_{1}\right)\right]\right)+\nabla_{n}(u-\underline{u})\left(x_{1}\right) \sum_{\alpha} B_{\alpha \alpha}\left(x_{1}\right)\right)$ is smooth in $M \cap B_{\delta}\left(x_{1}\right)$.

We now apply the argument of $\nabla_{\alpha n}$ again. For $A_{1} \gg A_{2} \gg A_{3} \gg 1$, it remains to prove that

$$
\begin{cases}L\left(\Phi+\Psi-\nabla_{n}(u-\underline{u})\right) \leq 0 & \text { in } M \cap B_{\delta}\left(x_{1}\right) \\ \Phi+\Psi-\nabla_{n}(u-\underline{u}) \geq 0 & \text { on } \partial\left(M \cap B_{\delta}\left(x_{1}\right)\right)\end{cases}
$$

According to the maximum principle, we have

$$
\Phi+\Psi-\nabla_{n}(u-\underline{u}) \geq 0 \quad \text { in } M \cap B_{\delta}\left(x_{1}\right) .
$$

Thus $\nabla_{n} \Psi\left(x_{1}\right)-\nabla_{n n}(u-\underline{u})\left(x_{1}\right) \geq-\nabla_{n} \Phi\left(x_{1}\right) \geq-C$, which implies that $\nabla_{n n} u\left(x_{1}\right) \leq$ $C$. Therefore,

$$
\widetilde{\lambda}_{i}\left(x_{1}\right) \leq C, \quad i=1, \cdots, n
$$

It is clear that $\widehat{\lambda}=\left(\widehat{\lambda}_{1}, \cdots, \widehat{\lambda}_{n}\right) \in \Gamma_{n}$. Hence

$$
\psi^{n-l}\left(x_{1}, u\left(x_{1}\right), \nabla u\left(x_{1}\right)\right)=\frac{\sigma_{n}(\widehat{\lambda})}{\sigma_{l}(\widehat{\lambda})} \leq \frac{\sigma_{n}(\widehat{\lambda})}{C_{n}^{l} \sigma_{n}^{\frac{l}{n}}(\widehat{\lambda})}=\frac{\sigma_{n}^{1-\frac{l}{n}}(\widehat{\lambda})}{C_{n}^{l}} .
$$

It follows that

$$
\widehat{\lambda}_{i}\left(x_{1}\right) \geq \bar{C}_{4} .
$$

We assume without loss of generality that the eigenvalue $\widehat{\lambda}_{i}\left(x_{1}\right)$ satisfy $\widehat{\lambda}_{1}\left(x_{1}\right) \leq$ $\widehat{\lambda}_{2}\left(x_{1}\right) \leq \cdots \leq \widehat{\lambda}_{n}\left(x_{1}\right)$. According to the Cauchy interlacing inequalities (see e.g. 36], p. 103-104),

$$
\widehat{\lambda}_{\alpha}\left(x_{1}\right) \leq \widehat{\lambda}_{\alpha}^{\prime}\left(x_{1}\right) \leq \widehat{\lambda}_{\alpha+1}\left(x_{1}\right)
$$

Hence the claim (4.34) holds and we obtian the upper bound of $\nabla_{n n} u\left(x_{0}\right)$ as desired.

Proof of Theorem 1.3. The theorem can be easily obtained by Lemma 3.1, Theorem 3.3, 4.1 and 4.3.

Proof of Theorem 1.2. From Theorem 1.3, we have uniform estimates in $C^{2}(\bar{M})$ for classical elliptic solutions of the Dirichlet problems:

$$
\begin{cases}\left(\frac{\sigma_{k}}{\sigma_{l}}\right)^{\frac{1}{k-l}}(U)=t f(x, u, \nabla u)+(1-t)\left(\frac{\sigma_{k}}{\sigma_{l}}\right)^{\frac{1}{k-l}}(\underline{U}) & \text { in } M \\ u=\varphi & \text { on } \partial M\end{cases}
$$

for $0 \leq t \leq 1$. Theorem 1.2 then follows from the Evans-Krylov second derivative Hölder estimates of Evans, Krylov and Caffarelli-Nirenberg-Spruck, and the method of continuity, for more details see [12]. The uniqueness assertion is immediate from the maximum principle.
