Positive least energy solutions for k-coupled Schrödinger system with critical exponent: the higher dimension and cooperative case*

Abstract

In this paper, we study the following k-coupled nonlinear Schrödinger system with Sobolev critical exponent:

$$\begin{cases} -\Delta u_i + \lambda_i u_i = \mu_i u_i^{2^* - 1} + \sum_{j=1, j \neq i}^k \beta_{ij} u_i^{\frac{2^*}{2} - 1} u_j^{\frac{2^*}{2}} & \text{in } \Omega, \\ u_i > 0 & \text{in } \Omega & \text{and} & u_i = 0 & \text{on } \partial\Omega, \quad i = 1, 2, \cdots, k. \end{cases}$$

Here $\Omega \subset \mathbb{R}^N$ is a smooth bounded domain, $2^* = \frac{2N}{N-2}$ is the Sobolev critical exponent, $-\lambda_1(\Omega) < \lambda_i < 0, \mu_i > 0$ and $\beta_{ij} = \beta_{ji} \neq 0$, where $\lambda_1(\Omega)$ is the first eigenvalue of $-\Delta$ with the Dirichlet boundary condition. We characterize the positive least energy solution of the k-coupled system for the purely cooperative case $\beta_{ij} > 0$, in higher dimension $N \geq 5$. Since the k-coupled case is much more delicated, we shall introduce *the idea of induction*. We point out that *the key idea* is to give a more accurate upper bound of the least energy. It's interesting to see that the least energy of the k-coupled system in \mathbb{R}^N , as well as classification results.

1 Introduction

In this paper we consider the following k-coupled nonlinear Schrödinger system:

$$\begin{cases} -\Delta u_i + \lambda_i u_i = \mu_i u_i^{2p-1} + \sum_{j=1, j \neq i}^k \beta_{ij} u_i^{p-1} u_j^p & \text{in } \Omega, \\ u_i > 0 & \text{in } \Omega & \text{and} & u_i = 0 & \text{on } \partial\Omega, \quad i = 1, 2, \cdots, k, \end{cases}$$
(1.1)

where $\Omega = \mathbb{R}^N$ or $\Omega \subset \mathbb{R}^N$ is a smooth bounded domain, p > 1 and $p \le 2^*/2$ if $N \ge 3$, $\mu_i > 0$ and $\beta_{ij} = \beta_{ji} \ne 0$ is a coupling constant.

System (1.1) arises when we consider the standing wave solutions to the following time-depending coupled nonlinear Schrödinger system:

$$\begin{cases} -i\frac{\partial}{\partial t}\Phi_1 = \Delta\Phi_1 + \mu_1|\Phi_1|^2\Phi_1 + \beta|\Phi_2|^2\Phi_1, \\ -i\frac{\partial}{\partial t}\Phi_2 = \Delta\Phi_2 + \mu_2|\Phi_2|^2\Phi_1 + \beta|\Phi_1|^2\Phi_2, \quad (x,t) \in \mathbb{R}^N \times \mathbb{R}, \\ \Phi_j = \Phi_j(x,t) \in \mathbb{C}, \quad j = 1, 2, \ N \le 3, \end{cases}$$
(1.2)

where *i* is the imaginary unit, $\mu_1, \mu_2 > 0$ and $\beta \neq 0$ is a coupling constant. The system (1.2) has many applications in physics, such as the occurrence of phase separation in Bose–Einstein condensates with multiple states, or the propagation of mutuary in coherent wave packets in nonlinear optics, see e.g. [2, 25, 26, 44].

From the physical aspect, the solution Φ_j denotes the *j*th component of the beam in Kerr-like photorefractive media (see [2]), μ_j represents self-focusing in the *j*th component, and the coupling constant β represents the interaction between the two components of the beam.

To study the solitary wave solutions of system (1.2), we set $\Phi_j(x,t) = e^{i\lambda_j t} u_j(x)$ for j = 1, 2. Then, it is reduced to system (1.1) with k = 2 and p = 2.

For the subcritical case, that is, $N \le 3$, the existence of least energy solutions were studied in [3, 8, 9, 18, 21, 22, 23, 29, 35, 38, 40, 43, 45] and the references therein. The existence and multiplicity of positive and sign-changing solutions were studied by [3, 7, 9, 14, 15, 18, 29, 30, 32, 33, 34, 38, 41] and the references therein.

For the critical case p = 2 and N = 4, Chen and Zou [17] proved that there exists $0 < \beta_1 < \beta_2$ (β_1 and β_2 depend on λ_i and β), such that (1.1) has a positive least energy solution if $\beta < \beta_1$ or $\beta > \beta_2$, while (1.1) has no positive least energy solution if $\beta_1 \le \beta \le \beta_2$.

Later in [19], Chen and Zou considered the critical case $2p = 2^* := \frac{2N}{N-2}$ of system (1.1) in higher dimension $N \ge 5$. It turns out that different phenomena happen from the special case N = 4. Indeed, the authors showed that system (1.1) has a positive least energy solution for any $\beta \ne 0$. When $\beta = 0$, the system is reduced to the well-known Brézis-Nirenberg problem[11]

$$-\Delta u + \lambda_i u = \mu_i |u|^{2^* - 2} u, \quad u \in H^1_0(\Omega).$$
(1.3)

The Brézis-Nirenberg problem (1.3) has been studied intensively, and we refer the reader to [13, 16, 24, 39] and references therein.

From then on, many results corresponding to the coupled system with critical Sobolev exponent have been studied. See [31, 37, 50, 52, 51] and references therein.

For the more general case where $k \ge 2$, physically the coefficient $\beta_{ii} = \mu_i$ represents self-focusing within the *i*th component, while β_{ij} $(i \ne j)$ illustrates interaction between two different components. If $\beta_{ij} > 0$, the interaction between the *i*th and *j*th components is of cooperative type; while $\beta_{ij} < 0$ means that the interaction is of competitive type. The relation $\beta_{ij} = \beta_{ji}$ illustrates the symmetry in the interaction between different components.

Let $\lambda_1(\Omega)$ be the first eigenvalue of $-\Delta$ with the Dirichlet boundary condition.

For the purely cooperative case, where $\beta_{ij} > 0$ for i, j = 1, 2, ..., k, Guo, Luo and Zou [27] obtained the existence and classification of positive least energy solutions to (1.1) under $-\lambda_1(\Omega) < \lambda_1 = \cdots = \lambda_k < 0$ in case of a bounded smooth domain $\Omega \subset \mathbb{R}^4$ with some additional conditions on the coefficients. In the same paper, the authors treated the system with $\lambda_1 = \cdots = \lambda_k = 0$ and $\Omega = \mathbb{R}^4$, which can be seen as the limit problem corresponding to the previous problem. Wu [49] also obtained the existence of positive least energy solution in \mathbb{R}^N with $N \ge 4$ and $\beta_{ij} = \beta$, $i \ne j$ via variational arguments.

Meanwhile, for the purely competitive case $\beta_{ij} < 0$, [20, 42, 48] studied the existence of positive least energy solutions and phase separation phenomena respectively for N = 4 and $N \ge 5$. And some results are obtained for mixed cooperative and competitive case when N = 4. See [42, 46] and references therein.

To the best our knowledge, there is no paper considering (1.1) with arbitrary purely cooperative coefficients $\beta_{ij} > 0$ in higher dimension $N \ge 5$. It is natural to ask whether the more general k-coupled system (1.1) admits a positive least energy solution similarly as the 2-coupled system proved in [19]. In the sequel we assume that

$$2p = 2^*.$$
 (1.4)

We shall see that the k-coupled case are more delicate than the 2-coupled case. The key reason is that $k \ge 2$ and $1 when <math>N \ge 5$. The fact that $k \ge 2$ and $1 make the problem more complicated comparing to the cases <math>p = 2, k \ge 2$ and 1 . Some more ideas and techniques are needed.

First, we obtained the following results.

Theorem 1.1. Assume that $N \ge 3$ and (1.4). Then system (1.1) has no positive solutions if one of the following conditions holds.

- (1) $\lambda_i \leq -\lambda_1(\Omega), \ \mu_i > 0 \ and \ \beta_{ij} > 0 \ for \ i, j = 1, 2, \dots, k.$
- (2) $\mu_i, \beta_{ij} \in \mathbb{R}, \lambda_i \geq 0$ for i = 1, 2, ..., k, and Ω is star-shaped.

If $\Omega = \mathbb{R}^N$, and (u_1, \ldots, u_k) is any a solution of (1.1), by the Pohozaev identity (2.1), it is easy to get that $\int_{\mathbb{R}^N} \sum \lambda_i u_i^2 \, dx = 0$, so $(u_1, \ldots, u_k) \equiv (0, \ldots, 0)$ if $\lambda_1, \ldots, \lambda_k$ are of the same sign. Therefore, in the sequel we assume that $\Omega \subset \mathbb{R}^N$ is a smooth bounded domain. Some non-existence results also have been attained in Theorem 1.1. In order to study the existence of positive least energy solution of (1.1), we assume that $-\lambda_1(\Omega) < \lambda_i < 0$, $\mu_i > 0$ and $\beta_{ij} > 0$ for $i, j = 1, 2, \ldots, k$.

We call a solution (u_1, \ldots, u_k) is nontrivial if $u_i \neq 0$ for all $i = 1, 2, \ldots, k$, while a solution (u_1, \ldots, u_k) is semi-trivial if $u_i \equiv 0$ for some $i = 1, 2, \ldots, k$. We only study the nontrivial solutions of (1.1) in this paper.

Denote $H := (H_0^1(\Omega))^k$ and $\vec{\mathbf{u}} = (u_1, u_2, \dots, u_k) \in H$ is a vector function. It is well known that solutions of (1.1) correspond to the critical points of C^1 functional $E : H \to \mathbb{R}$ given by

$$E(\vec{\mathbf{u}}) = \frac{1}{2} \int_{\Omega} \sum_{i=1}^{k} (|\nabla u_i|^2 + \lambda_i u_i^2) - \frac{1}{2p} \int_{\Omega} (\sum_{i=1}^{k} \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^{k} 2\beta_{ij} |u_i|^p |u_j|^p).$$
(1.5)

We say a solution \vec{u} of (1.1) is a least energy solution, if \vec{u} is nontrivial and

$$E(\vec{\mathbf{u}}) \leq E(\vec{\mathbf{v}})$$

for any other nontrivial solution \vec{v} of (1.1). As in [29], we define a Nehari type manifold

$$\mathcal{M} = \{ \vec{\mathbf{u}} \in H \mid u_i \neq 0, \ E'(\vec{\mathbf{u}})(0, \dots, u_i, \dots, 0) = 0 \text{ for } i = 1, 2, \dots, k \}.$$

Then any nontrivial solutions of (1.1) belong to \mathcal{M} . Take $\varphi_1, \varphi_2, \ldots, \varphi_k \in C_0^{\infty}(\Omega)$ with $\varphi_i \neq 0$ and $\operatorname{supp}(\varphi_i) \cap \operatorname{supp}(\varphi_j) = \emptyset$ for $\forall i, j = 1, 2, \ldots, k$; then there exists $c_1, c_2, \ldots, c_k > 0$ such that $(\sqrt{c_1}\varphi_1, \sqrt{c_2}\varphi_2, \ldots, \sqrt{c_k}\varphi_k) \in \mathcal{M}$, so $\mathcal{M} \neq \emptyset$.

Define the least energy

$$B := \inf_{\vec{\mathbf{u}} \in \mathcal{M}} E(\vec{\mathbf{u}}) = \inf_{\vec{\mathbf{u}} \in \mathcal{M}} \frac{1}{N} \int_{\Omega} \sum_{i=1}^{k} (|\nabla u_i|^2 + \lambda_i u_i^2).$$
(1.6)

Now we consider the special case $-\lambda_1(\Omega) < \lambda_1 = \lambda_2 = \cdots = \lambda_k = \lambda < 0$. It is well known that the Brézis-Nirenberg problem [11]

$$-\Delta u + \lambda u = |u|^{2^* - 2} u, \quad u \in H^1_0(\Omega)$$

$$(1.7)$$

has a positive least energy solution ω with energy

$$B_1 := \frac{1}{N} \int_{\Omega} (|\nabla \omega|^2 + \lambda \omega^2) \, \mathrm{d}x = \frac{1}{N} \int_{\Omega} \omega^{2^*} \, \mathrm{d}x.$$
(1.8)

Consider the following nonlinear algebric problem

$$\begin{cases} \mu_i t_i^{2p-2} + \sum_{j=1, j \neq i}^k \beta_{ij} t_i^{p-2} t_j^p = 1, \text{ for } i = 1, 2, \dots, k, \\ t_i > 0, \text{ for } i = 1, 2, \dots, k. \end{cases}$$
(1.9)

In [17, 19], Chen and Zou proved the exsitece of solution to (1.9) in the case k = 2. Recently, Wu [49] proved that (1.9) has a solution for $k \ge 2$ with $\beta_{ij} = \beta$, by applying the variational argument to the related system. We generalize the existence result of the algebric system (1.9) to arbitrary $\beta_{ij} > 0$ and give a more minute and geometric proof in Lemma 2.2. Moreover, we will prove in Lemma 2.2 that there exists $\vec{t} = (\tilde{t}_1, \tilde{t}_2, \dots, \tilde{t}_k)$ such that

$$\vec{\mathbf{t}}$$
 satisfies (1.9) and $\vec{\mathbf{t}}$ attains d_k . (1.10)

Here, $d_k := \inf_{\vec{t} \in \mathcal{P}_k} \mathcal{G}_k(\vec{t})$, where

$$\mathcal{G}_{k}(\vec{\mathbf{t}}) := \sum_{i=1}^{k} \left(\frac{t_{i}^{2}}{2} - \frac{\mu_{i}|t_{i}|^{2p}}{2p}\right) - \frac{1}{2p} \left(\sum_{i=1,j>i}^{k} 2\beta_{ij}|t_{i}|^{p}|t_{j}|^{p}\right),$$
$$\mathcal{P}_{k} := \{\vec{\mathbf{t}} \in \mathbb{R}^{k} \setminus \{\vec{\mathbf{0}}\} \mid P_{k}(\vec{\mathbf{t}}) := \sum_{i=1}^{k} (t_{i}^{2} - \mu_{i}|t_{i}|^{2p}) - \sum_{i=1,j>i}^{k} 2\beta_{ij}|t_{i}|^{p}|t_{j}|^{p} = 0\}.$$

We will see that d_k has a similar form as the minimizing problem (1.23) and d_k plays an important role in this paper.

Our second result also deals with the special case $\lambda_1 = \lambda_2 = \cdots = \lambda_k := \lambda$.

Theorem 1.2. Assume that $N \ge 5$ and (1.4), $-\lambda_1(\Omega) < \lambda_1 = \lambda_2 = \cdots = \lambda_k := \lambda < 0$ and $\mu_i, \beta_{ij} > 0$. Then system (1.1) has a positive solution of the synchronized form

$$(t_1\omega, t_2\omega, \dots, t_k\omega), \tag{1.11}$$

where ω is the positive least energy solution of (1.7) and (t_1, t_2, \ldots, t_k) solves (1.9).

Remark 1.1.

(1) Denote $\mathcal{R} = (\beta_{ij})_{k \times k}$ as the coupling matrix, where $\beta_{ij} = \beta_{ji}$ and $\beta_{ii} = \mu_i$. For the special case N = 4, Guo, Luo and Zou [27] proved that the least energy *B* is attained by a symmetrized form solution (1.11), under the assumptions that

$$\mathcal{R} = (\beta_{ij})_{k \times k}$$
 is invertible and $\sum_{j=1}^{k} (\mathcal{R}^{-1})_{ij} > 0, \quad i = 1, 2, \dots, k.$ (1.12)

Actually, under these assumptions, the algebric system has pairs of solutions $(\pm t_1, \pm t_2, \ldots, \pm t_k)$, then the signed solutions $(\pm t_1\omega, \ldots, \pm t_k\omega)$ are nontrivial signed solutions of (1.1).

(2) If $\lambda \leq -\lambda_1(\Omega)$, we can obtain sign-changing solutions of synchronized form.

We shall give a classification result of the positive least energy solution of the (1.1).

Theorem 1.3. Assume that $N \ge 5$, $-\lambda_1(\Omega) < \lambda_1 = \lambda_2 = \cdots = \lambda_k := \lambda < 0$ and $\mu_i, \beta_{ij} > 0$. Then the positive least energy solution of the system (1.1) must be of the synchronized form

$$(\tilde{t}_1\omega, \tilde{t}_2\omega, \ldots, \tilde{t}_k\omega),$$

where ω is a positive least energy solution of (1.7) and $(\tilde{t}_1, \tilde{t}_2, \dots, \tilde{t}_k)$ is defined in (1.10).

Moreover, assume additionally that $\beta_{ij} := \beta > 0$ and $\Omega \subset \mathbb{R}^N$ is a ball, then there exists $\beta_k > 0$, such that the positive least energy solution of the system (1.1) is unique for $\beta > \beta_k$.

Remark 1.2.

- (1) For the special case N = 4, Guo, Luo and Zou [27] classified the positive least energy solution of the synchronized form (1.11), under the assumptions (1.12) and \mathcal{R} is positively or negatively definite. In particular, the positive least energy solution is unique if Ω is a ball in \mathbb{R}^4 .
- (2) Recently, Tavares and You [42] also obtained the classification result for the special case N = 4, under the same assumption as our result. But the uniqueness problem was not covered in [42].

Now let us consider the general case $-\lambda_1(\Omega) < \lambda_1, \lambda_2, \cdots, \lambda_k < 0$.

Theorem 1.4. Assume that $N \ge 5$ and (1.4). Suppose that $-\lambda_1(\Omega) < \lambda_1, \lambda_2, \ldots, \lambda_k < 0$ and $\mu_i > 0$. Then system (1.1) has a positive least energy solution \vec{u} with $E(\vec{u}) = B$ for any $\beta_{ij} > 0$.

Remark 1.3. In [20, 48], the authors obtained the existence of positive least energy solutions of the system (1.1) for the purely competitive case $\beta_{ij} < 0$.

For each $\Theta \subsetneq \{1, ..., k\}$, we obtain the following $(k - |\Theta|)$ -coupled system

$$\begin{cases} -\Delta u_i + \lambda_i u_i = \mu_i u_i^{2p-1} + \sum_{j=1, j \neq i}^k \beta_{ij} u_i^{p-1} u_j^p & \text{in } \Omega, \\ u_i > 0 & \text{in } \Omega & \text{and} & u_i = 0 & \text{on } \partial\Omega, \quad i, j \in \{1, 2, \cdots, k\} \backslash \Theta, \end{cases}$$
(1.13)

by replacing $\lambda_i, \mu_i, \beta_{ij}, \beta_{ji}$ with 0 if $i \in \Theta$, where $|\Theta|$ is the cardinality of Θ .

Note that the nontrivial solutions of (1.13) can be extended to the semi-trivial solutions of k-coupled system (1.1).

Denote $\tau = k - |\Theta|$. Indeed, we can establish C_k^{τ} different τ -coupled systems from (1.1). For every fixed Θ , we denote $\{i_1, \ldots, i_{\tau}\} = \{1, 2, \ldots, k\} \setminus \Theta$ and $B_{\mu_{i_1} \ldots \mu_{i_{\tau}}}$ as

the least energy of the τ -coupled system (4.3) with coefficients $(\mu_{i_1}, \ldots, \mu_{i_{\tau}})$, that is,

$$B_{\mu_{i_1}\dots\mu_{i_{\tau}}} := \inf\{E(\vec{\mathbf{u}}) : \vec{\mathbf{u}} = (u_1,\dots,u_k) \text{ solves (1.1) and } u_i = 0 \text{ iff } i \in \Theta\}.$$
(1.14)

Denote

$$\bar{B}_{\tau} := \min_{\forall \{l_1, \dots, l_{\tau}\} \subsetneq \{1, 2, \dots, k\}} \{B_{\mu_{l_1} \dots \mu_{l_{\tau}}}\}.$$
(1.15)

Next we need to obtain a more refined estimates on the least energy of the k-coupled system.

Theorem 1.5. Assume that $N \ge 5$ and (1.4). Suppose that $-\lambda_1(\Omega) < \lambda_1, \lambda_2, \ldots, \lambda_k < 0$ and $\mu_i, \beta_{ij} > 0$. Then the least energy of (1.1) has an upper bound

$$B < \min\{\bar{B}_1, \bar{B}_2, \dots, \bar{B}_{k-1}\}.$$
(1.16)

To be more specific,

$$B < \bar{B}_{k-1} < \dots < \bar{B}_1.$$

Moreover,

$$B := B_{\mu_1 \mu_2 \dots \mu_k} < B_{\mu_1 \mu_2 \dots \mu_{k-1}} < B_{\mu_1 \mu_2 \dots \mu_{k-2}} < \dots < B_{\mu_1 \mu_2} < B_{\mu_1}$$

By Theorem 1.5, it's interesting to see that the least energy of the k-coupled system may decrease as k grows.

Since the nonlinearity and the coupling term are both critical in (1.1), the existence of nontrivial solutions of (1.1) depends heavily on the existence of the least energy solution of the following limit problem

$$\begin{cases} -\Delta u_i = \mu_i u^{2p-1} + \sum_{j=1, j \neq i}^k \beta_{ij} u_i^{p-1} u_j^p, & x \in \mathbb{R}^N, \\ u_i \in D^{1,2}(\mathbb{R}^N), & i = 1, 2, \cdots, k, \end{cases}$$
(1.17)

where $D^{1,2}(\mathbb{R}^N) := \{ u \in L^{2^*}(\mathbb{R}^N) : |\nabla u| \in L^2(\mathbb{R}^N) \}$ with norm $||u||_{D^{1,2}} := (\int_{\mathbb{R}^N} |\nabla u|^2 dx)^{1/2}$. Let S be the sharp constant of $D^{1,2}(\mathbb{R}^N) \hookrightarrow L^{2^*}(\mathbb{R}^N)$

$$\int_{\mathbb{R}^N} |\nabla u|^2 \mathrm{d}x \ge S \left(\int_{\mathbb{R}^N} |u|^{2^*} \mathrm{d}x \right)^{\frac{2}{2^*}}.$$
(1.18)

For $\varepsilon > 0$ and $y \in \mathbb{R}^N$, we consider the Aubin-Talenti instanton [6, 47] $U_{\varepsilon,y} \in D^{1,2}(\mathbb{R}^N)$ defined by

$$U_{\varepsilon,y}(x) := [N(N-2)]^{\frac{N-2}{4}} \left(\frac{\varepsilon}{\varepsilon^2 + |x-y|^2}\right)^{\frac{N-2}{2}}.$$
 (1.19)

Then $U_{\varepsilon,y}$ satisfies $-\Delta u = |u|^{2^*-2}u$ in \mathbb{R}^N and

$$\int_{\mathbb{R}^N} |\nabla U_{\varepsilon,y}|^2 \mathrm{d}x = \int_{\mathbb{R}^N} |U_{\varepsilon,y}|^{2^*} \mathrm{d}x = S^{N/2}.$$
(1.20)

Clearly (1.17) has semi-trivial solutions

$$(\mu_1^{\frac{2-N}{4}}U_{\varepsilon,y},0,\ldots,0), (0,\mu_2^{\frac{2-N}{4}}U_{\varepsilon,y},0,\ldots,0), \ldots, (0,\ldots,0,\mu_k^{\frac{2-N}{4}}U_{\varepsilon,y}).$$

Here, we are only concerned with nontrivial solutions of (1.17). Define $D := (D^{1,2}(\mathbb{R}^N))^k$ and a C^1 functional $I : D \to \mathbb{R}$ given by

$$I(\vec{\mathbf{u}}) := \frac{1}{2} \int_{\mathbb{R}^N} \sum_{i=1}^k |\nabla u_i|^2 - \frac{1}{2p} \int_{\mathbb{R}^N} (\sum_{i=1}^k \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^k 2\beta_{ij} |u_i|^p |u_j|^p).$$
(1.21)

We consider the following set as in [29]:

$$\mathcal{N} = \{ \vec{\mathbf{u}} \in D : u_i \neq 0, I'(\vec{\mathbf{u}})(0, \dots, 0, u_i, 0, \dots, 0) = 0, \ i = 1, 2, \dots, k \}.$$
(1.22)

Then any nontrivial solution of (1.17) belongs to \mathcal{N} . Similarly $\mathcal{N} \neq \emptyset$. We set

$$A := \inf_{\vec{\mathbf{u}} \in \mathcal{N}} I(\vec{\mathbf{u}}) = \inf_{\vec{\mathbf{u}} \in \mathcal{N}} \frac{1}{N} \int_{\mathbb{R}^N} \sum_{i=1}^k |\nabla u_i|^2.$$
(1.23)

Then we have the following theorem, which plays an important role in the proof of Theorem 1.4.

Theorem 1.6. Assume that $N \ge 5$ and (1.4). If $\mu_i > 0$ and $\beta_{ij} > 0$, then system (1.17) has a positive least energy solution \vec{U} with $I(\vec{U}) = A$, which is radially symmetric decreasing. Moreover,

- (1) the positive least energy solution of (1.17) must be the least energy synchronized type solution of the form $(\tilde{t}_1 U_{\varepsilon,y}, \tilde{t}_2 U_{\varepsilon,y}, \dots, \tilde{t}_k U_{\varepsilon,y})$, where $(\tilde{t}_1, \tilde{t}_2, \dots, \tilde{t}_k)$ is defined in (1.10).
- (2) there exists $\beta_1 > 0$, and for any $0 < \beta_{ij} = \beta < \beta_1$, there exists a solution $(t_1(\beta), t_2(\beta), \dots, t_k(\beta))$ of (1.9), such that

$$I(t_1(\beta)U_{\varepsilon,y}, t_2(\beta)U_{\varepsilon,y}, \dots, t_k(\beta)U_{\varepsilon,y}) > A = I(\vec{U}).$$

That is, $(t_1(\beta)U_{\varepsilon,y}, t_2(\beta)U_{\varepsilon,y}, \dots, t_k(\beta)U_{\varepsilon,y})$ is a different positive solution of (1.17) with respect to \vec{U} .

Remark 1.4.

(1) The multiplicity of solution of algebric system (1.9) arises much more difficulty when dealing with the classification problem.

For the special case $\beta_{ij} = \beta > 0$, Wu proved that the positive least energy solution of (1.17) must be of synchronized type $(t_1U_{\varepsilon,y}, t_2U_{\varepsilon,y}, \ldots, t_kU_{\varepsilon,y})$ where (t_1, t_2, \ldots, t_k) is solves (1.9). (See [49, Theorem 1.2, Proposition 3.2].)

We point out that the solution $(t_1, t_2, ..., t_k)$ of (1.9) might not attain d_k , then $(t_1U_{\varepsilon,y}, t_2U_{\varepsilon,y}, ..., t_kU_{\varepsilon,y})$ might not be of the least energy, since the method of Lagrange multiplier yields only a necessary condition for constrained problems.

It is interesting that Theorem 1.6 (2) coincides with the multiplicity of solution of algebric system (1.9), and admits the existence of another positive solution of (1.17) which is not of the least energy.

- (2) Theorem 1.6 (1) generalizes [19, Theorem 1.6] in the sense that it asserts that the positive least energy of (1.17) must be the synchronized type solution for the purely cooperative case $\beta_{ij} > 0$.
- (3) We note that a similar existence result of ground state (which seems probably to be semi-trivial) is obtained by He and Yang [28] via concentration-compactness lemma. We remark that our method is quite different from that. We illustrate the positive least energy of synchronized type and any other result concerning (1.17) cannot be found in [28].

In rest of this paper we prove these theorems. In Sect. 2, we obtain the fundamental Lemma 2.2 on the existence of positive solution of the algebric system (1.9) with arbitrary $\beta_{ij} > 0$, which generalizes [49, Proposition 3.2] and gives out a detailed and geometric explanation. Theorem 1.1 and 1.2 are proved subsequently. Since the *k*-coupled case is much more delicated than 2-couple case, we shall introduce *the idea of induction* in the proof of Theorem 1.4 and 1.6, respectively in Sect. 3 and 4. *The key idea* is to give a more accurate upper bound of the least energy, which is inspired by [19, 29]. See Lemma 3.2 and 4.2. We mention that the idea of induction is also introduced in [20, 42, 48] to obtain the positive least energy solution of the purely competitive system. Theorem 1.5 is a byproduct of Lemma 4.2 and Theorem 1.4. Theorem 1.3 is proved in Sect. 4.

2 Preliminaries

In this section, we introduce some fundamental results and prove Theorem 1.1 and Theorem 1.2.

Lemma 2.1. (the Pohozaev identity)

If Ω is star-shaped with respect to some point $y_0 \in \mathbb{R}^N$ and $\vec{u} \in H$ be a solution of (1.1), then \vec{u} satisfies

$$\frac{1}{2p} \int_{\Omega} \sum_{i=1}^{k} |\nabla u_i|^2 \, \mathrm{d}x + \frac{1}{2N} \int_{\partial\Omega} \sum_{i=1}^{k} \left| \frac{\partial u_i}{\partial \vec{n}} \right|^2 (x - y_0) \cdot \vec{n} \, \mathrm{d}S \\
= \frac{1}{2p} \int_{\Omega} (\sum_{i=1}^{k} \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^{k} 2\beta_{ij} |u_i|^p |u_j|^p) \, \mathrm{d}x - \frac{1}{2} \int_{\Omega} \sum_{i=1}^{k} \lambda_i u_i^2 \, \mathrm{d}x,$$
(2.1)

where \vec{n} denotes the unit outward normal.

Proof. The Pohozaev identity (2.1) follows by multiplying *i*th equation

$$-\Delta u_i + \lambda_i u_i = \mu_i u_i^{2p-1} + \sum_{j=1, j \neq i}^k \beta_{ij} u_i^{p-1} u_j^p$$

by $x \cdot \nabla u_i$ and integrating by parts.

First we prove Theorm 1.1, which shows the nonexistence of positive solution of system (1.1) under some assumptions.

Proof of Theorem 1.1 (1) Let ϕ_1 be the first eigenfunction of $-\Delta$ with the Dirichlet boundary condition with respect to $\lambda_1(\Omega)$.

By multiplying each equations in (1.1) with ϕ_1 and integrating over Ω , we obtain

$$(\lambda_1(\Omega) + \lambda_i) \int_{\Omega} u_i \phi_1 \mathrm{d}x = \int_{\Omega} (\mu_i u_i^{2p-1} \phi_1 + \sum_{j=1, j \neq i}^{\kappa} \beta_{ij} u_i^{p-1} u_j^p \phi_1) \,\mathrm{d}x.$$

It is easy to see that when $\lambda_i \leq -\lambda_1(\Omega)$, $\mu_i > 0$ and $\beta_{ij} > 0$ for i, j = 1, 2, ..., k, system (1.1) has no positive solutions.

(2) Assume that Ω is star-shaped with respect to some point $y_0 \in \mathbb{R}^N$ and $\vec{\mathbf{u}} = (u_1, u_2, \dots, u_k)$ be a solution of (1.1), then $\vec{\mathbf{u}}$ satisfies

$$\int_{\Omega} \sum_{i=1}^{k} (|\nabla u_i|^2 + \lambda_i u_i^2) \, \mathrm{d}x = \int_{\Omega} (\sum_{i=1}^{k} \mu_i |u_i|^{2p} + \sum_{i,j=1,i< j}^{k} 2\beta_{ij} |u_i|^p |u_j|^p) \, \mathrm{d}x.$$

If $\lambda_i \ge 0$, combined with the Pohozaev identity (2.1) we have

$$0 \le \frac{1}{2N} \int_{\partial\Omega} \sum_{i=1}^{k} \left| \frac{\partial u_i}{\partial \vec{\mathbf{n}}} \right|^2 (x - y_0) \cdot \vec{\mathbf{n}} \, \mathrm{d}S = \left(\frac{1}{2p} - \frac{1}{2}\right) \int_{\Omega} \sum_{i=1}^{k} \lambda_i u_i^2 \, \mathrm{d}x \le 0,$$

then system (1.1) has no positive solutions.

Now we turn to study the existence of solution to the algebric system (1.9), which may play a fundamental role in the subsequent research. We generalize [49, Proposition 3.2] to arbitrary $\beta_{ij} > 0$. Our proof is more specific and gives out a geometric explanation.

Lemma 2.2. Assume $\mu_i > 0$ and $\beta_{ij} > 0$, then algebric system

$$\begin{cases} \mu_i t_i^{2p-1} + \sum_{j=1, j \neq i}^k \beta_{ij} t_i^{p-1} t_j^p = t_i, \text{ for } i = 1, 2, \dots, k, \\ t_i \in \mathbb{R}, \text{ for } i = 1, 2, \dots, k. \end{cases}$$

has a nontrivial positive solution.

Proof. Let

$$d_k := \inf_{\vec{\mathbf{t}} \in \mathcal{P}_k} \mathcal{G}_k(\vec{\mathbf{t}}), \tag{2.2}$$

where

$$\mathcal{G}_k(\vec{\mathbf{t}}) = \sum_{i=1}^k \left(\frac{t_i^2}{2} - \frac{\mu_i |t_i|^{2p}}{2p}\right) - \frac{1}{2p} \left(\sum_{i=1,j>i}^k 2\beta_{ij} |t_i|^p |t_j|^p\right),$$

10

$$\mathcal{P}_{k} = \{ \vec{\mathbf{t}} \in \mathbb{R}^{k} \setminus \{ \vec{\mathbf{0}} \} \mid P_{k}(\vec{\mathbf{t}}) := \sum_{i=1}^{k} (t_{i}^{2} - \mu_{i} |t_{i}|^{2p}) - \sum_{i=1,j>i}^{k} 2\beta_{ij} |t_{i}|^{p} |t_{j}|^{p} = 0 \}.$$

Denote $\vec{\mathbf{e}}_i = (0, \dots, 0, \mu_i^{-\frac{1}{2p-2}}, 0, \dots, 0)$, it is easy to check that $\vec{\mathbf{e}}_i \in \mathcal{P}_k$ for all $i = 1, 2, \dots, k$, which implies $\mathcal{P}_k \neq \emptyset$ and the minimizing problem (2.2) is well defined. Notice that

$$d_{k} = \inf_{\vec{\mathbf{t}} \in \mathcal{P}_{k}} \mathcal{G}_{k}(\vec{\mathbf{t}}) = \inf_{\vec{\mathbf{t}} \in \mathcal{P}_{k}} \frac{1}{N} \sum_{i=1}^{k} t_{i}^{2}$$
$$= \inf_{\vec{\mathbf{t}} \in \mathcal{P}_{k}} \frac{1}{N} \left(\operatorname{dist}\left(\vec{\mathbf{0}}, \ \vec{\mathbf{t}}\right) \right)^{2}.$$

Since $\mathcal{P}_k \neq \emptyset$ and symmetric, the minimizing problem (2.2) is reduced to a geometric problem, that is, to find the closest point to original point $\vec{0}$ in a nonempty set \mathcal{P}_k . Then d_k can be attained by some $\tilde{\mathbf{t}}$ with $\tilde{t}_i \ge 0$ for all $i = 1, 2, \dots, k$, and $\tilde{t}_i > 0$ for some i. By the method of Lagrange's multiplier, there exists a Lagrange multiplier $\gamma \in \mathbb{R}$

such that

$$\nabla \mathcal{G}_k(\vec{\mathbf{t}}) - \gamma \nabla P_k(\vec{\mathbf{t}}) = 0, \qquad (2.3)$$

then $\vec{\tilde{t}}$ satisfies the system

$$\begin{cases} \mu_{i}\tilde{t}_{i}^{2p-1} + \sum_{j=1, j\neq i}^{k} \beta_{ij}\tilde{t}_{i}^{p-1}\tilde{t}_{j}^{p} = \tilde{t}_{i}, \text{ for } i = 1, 2, \dots, k, \\ \tilde{t}_{i} \ge 0, \text{ and } \sum_{i=1}^{k} \tilde{t}_{i} > 0, \text{ for } i = 1, 2, \dots, k. \end{cases}$$

$$(2.4)$$

In fact, for any nonzero $\vec{\mathbf{t}} \in \mathcal{P}_k$, we assume that $\vec{\mathbf{t}} = (t_1, \ldots, t_k)$ with $t_s \neq 0$ for $1 \le s \le k$, we see that

$$t_i \partial_i P_k(\vec{\mathbf{t}}) = 2t_i^2 - 2p\mu_i t_i^{2p} - p \sum_{j=1, j\neq i}^k 2\beta_{ij} t_i^p t_j^p,$$

then we have

$$\sum_{i=1}^{s} t_i \partial_i P_k(\vec{\mathbf{t}}) = 2 \sum_{i=1}^{s} t_i^2 - 2p \sum_{i=1}^{s} \mu_i t_i^{2p} - p \sum_{i=1}^{s} \sum_{j=1, j \neq i}^{k} 2\beta_{ij} t_i^p t_j^p$$
$$= 2 \sum_{i=1}^{s} t_i^2 - 2p \sum_{i=1}^{s} \mu_i t_i^{2p} - 2p \sum_{i=1, j > i}^{s} 2\beta_{ij} t_i^p t_j^p$$
$$= (2 - 2p) \sum_{i=1}^{s} t_i^2 \neq 0,$$

which implies that if $\vec{t} \in \mathcal{P}_k$ then $\nabla P_k(\vec{t}) \neq \vec{0}$. Then by (2.3), we have

$$\partial_i \mathcal{G}_k(\vec{\tilde{\mathbf{t}}}) - \gamma \partial_i P_k(\vec{\tilde{\mathbf{t}}}) = 0.$$

Thus $\partial_i \mathcal{G}_k(\vec{\mathbf{t}}) = 0$ if $\tilde{t}_i = 0$, while

$$0 = P_k(\vec{\mathbf{t}}) = \sum_{i=1}^s \tilde{t}_i \partial_i \mathcal{G}_k(\vec{\mathbf{t}}) = \gamma \sum_{i=1}^s \tilde{t}_i \partial_i P_k(\vec{\mathbf{t}}),$$

if $\tilde{t}_1, \ldots, \tilde{t}_s \neq 0$, that is

$$(2-2p)\gamma \sum_{i=1}^{s} \tilde{t}_i^2 = 0,$$

which implies that $\gamma = 0$ and $\partial_i \mathcal{G}_k(\vec{t}) = 0$ for $\tilde{t}_i \neq 0$. Hence, \vec{t} satisfies (2.4).

We claim that if $\beta_{ij} > 0$, then $d_k < \min\{d_1, d_2, \ldots, d_{k-1}\}$.

Our proof is inspired by [1]. By the method of induction, it suffices to prove that $d_k < d_{k-1}$. Assume that d_{k-1} is attained by (t_1, \ldots, t_{k-1}) , then

$$d_{k-1} = \frac{1}{N} \sum_{i=1}^{k-1} t_i^2 = \frac{1}{N} \left(\sum_{i=1}^{k-1} \mu_i |t_i|^{2p} + \sum_{i=1,j>i}^{k-1} 2\beta_{ij} |t_i|^p |t_j|^p \right).$$

Note that for any $s \in \mathbb{R}$, there exists f(s) > 0 such that $f(s)(t_1, \ldots, t_{k-1}, sl) \in \mathcal{P}_k$, where $l \in \mathbb{R} \setminus \{0\}$. In fact,

$$f(s)^{2p-2} = \frac{Nd_{k-1} + s^2l^2}{Nd_{k-1} + \mu_k |sl|^{2p} + \sum_{i=1}^{k-1} 2\beta_{ik} |t_i|^p |sl|^p}$$

By direct computations we have

$$\lim_{s \to 0} \frac{f'(s)}{|s|^{p-2}s} = -\frac{p}{(p-1)Nd_{k-1}} \sum_{i=1}^{k-1} \beta_{ik} |t_i|^p |l|^p,$$

that is,

$$f'(s) = -\frac{p}{(p-1)Nd_{k-1}} \left(\sum_{i=1}^{k-1} \beta_{ik} |t_i|^p |l|^p\right) |s|^{p-2} s \ (1+o(1)), \quad \text{as } s \to 0.$$

Note that f(0) = 1, then

$$f(s) = 1 - \frac{1}{(p-1)Nd_{k-1}} \left(\sum_{i=1}^{k-1} \beta_{ik} |t_i|^p |l|^p\right) |s|^p (1+o(1)), \quad \text{as } s \to 0.$$

This implies that

$$f(s)^{2p} = 1 - \frac{2p}{(p-1)Nd_{k-1}} \left(\sum_{i=1}^{k-1} \beta_{ik} |t_i|^p |l|^p\right) |s|^p (1+o(1))$$
$$= 1 - \frac{1}{d_{k-1}} \left(\sum_{i=1}^{k-1} \beta_{ik} |t_i|^p |l|^p\right) |s|^p (1+o(1)) \quad \text{as } s \to 0,$$

then we see that

$$\begin{split} d_k &\leq \mathcal{G}_k(f(s)t_1, \dots, f(s)t_{k-1}, f(s)sl) \\ &= \frac{1}{N}f(s)^{2p} \bigg(Nd_{k-1} + \mu_k |sl|^{2p} + \sum_{i=1}^{k-1} 2\beta_{ik} |t_i|^p |sl|^p \bigg) \\ &= d_{k-1} - (\frac{1}{2} - \frac{1}{N}) \bigg(\sum_{i=1}^{k-1} 2\beta_{ik} |t_i|^p |l|^p \bigg) |s|^p + o(|s|^p) \\ &< d_{k-1} \quad \text{as } |s| > 0 \text{ small enough.} \end{split}$$

By the idea of induction, we see that $d_k < \min\{d_1, d_2, \dots, d_{k-1}\}$. Next we prove that if $\beta_{ij} > 0$, then d_k is attained by $(\tilde{t}_1, \tilde{t}_2, \dots, \tilde{t}_k)$, where $\tilde{t}_i > 0$ for all $i = 1, 2, \dots, k$. Without loss of genrality, we assume by contradiction that $\tilde{t}_1, \tilde{t}_2, \dots, \tilde{t}_{k-1} > 0$, and $\tilde{t}_k = 0$. Denote

$$\vec{\mathbf{t}}_k = (\tilde{t}_1, \tilde{t}_2, \dots, \tilde{t}_{k-1}, 0), \quad \vec{\mathbf{t}}_{k-1} = (\tilde{t}_1, \tilde{t}_2, \dots, \tilde{t}_{k-1}),$$

then $\vec{ ilde{t}}_{k-1} \in \mathcal{P}_{k-1}$. Notice that

$$d_{k} = \inf_{\vec{\mathbf{t}} \in \mathcal{P}_{k}} \mathcal{G}_{k}(\vec{\mathbf{t}}) = \mathcal{G}_{k}(\vec{\mathbf{t}}_{k})$$

$$= \mathcal{G}_{k-1}(\vec{\mathbf{t}}_{k-1}) \ge \inf_{\vec{\mathbf{t}} \in \mathcal{P}_{k-1}} \mathcal{G}_{k-1}(\vec{\mathbf{t}}) = d_{k-1},$$
(2.5)

while we see that

$$d_k < \min\{d_1, d_2, \dots, d_{k-1}\},\$$

a contradiction. Hence we conclude that all $\tilde{t}_i > 0$.

Now assume that $N \ge 4$, $-\lambda_1(\Omega) < \lambda_1 = \lambda_2 = \cdots = \lambda_k := \lambda < 0$. We shall start to prove Theorem 1.2.

Proof of Theorem 1.2 In the special case N = 4, where $2p = 2^* = 4$, the nonlinear algebric problem (1.9) reduces to

$$\mu_i t_i^2 + \sum_{j=1, j \neq i}^k \beta_{ij} t_j^2 = 1, \text{ for } i = 1, 2, \dots, k,$$

which can be seen as

$$\mathcal{R}\begin{pmatrix} t_1^2\\ t_2^2\\ \vdots\\ t_k^2 \end{pmatrix} = \begin{pmatrix} 1\\ 1\\ \vdots\\ 1 \end{pmatrix}, \qquad (2.6)$$

where $\mathcal{R} = (\beta_{ij})_{k \times k}$ is the coupling matrix.

It is easy to check that if \mathcal{R} is invertible and the sum of each column of \mathcal{R}^{-1} is greater than 0, then (2.6) has solutions $(\pm t_1, \pm t_2, \dots, \pm t_k)$.

We can construct nontrivial solutions of (1.1) as

$$(\pm t_1\omega, \pm t_2\omega, \dots, \pm t_k\omega), \tag{2.7}$$

where ω is the positive least energy solution of (1.7). Remark that these solutions are signed solutions and $(t_1\omega, t_2\omega, \ldots, t_k\omega)$ is a positive solution of (1.1). Moreover, it's proved in [27, Theorem 1.1] that $(t_1\omega, t_2\omega, \ldots, t_k\omega)$ is a positive least energy solution.

In the general case $N \ge 5$, Lemma 2.2 admits a positive solution of the nonlinear algebric problem (1.9), we can also construct a positive solution of (1.1) as

$$(t_1\omega, t_2\omega, \ldots, t_k\omega),$$

where ω is the positive least energy solution of (1.7) and (t_1, t_2, \ldots, t_k) solves (1.9).

Moreover, we recall that in [5, 12], the authors obtained a nontrivial solution for the Brézis-Nirenberg problem (1.7) if $N \ge 4$ and $\lambda < 0$. Note that (1.7) has a positive least energy solution if $-\lambda_1(\Omega) < \lambda < 0$. While any nontrivial solution of (1.7) is sign-changing if $\lambda \le -\lambda_1(\Omega)$ (See [39].) Thus, we observe that if $\lambda \le -\lambda_1(\Omega)$, we can also construct a sign-changing solution of (1.1) as

$$(t_1\bar{u}, t_2\bar{u}, \ldots, t_k\bar{u}),$$

where \bar{u} is a nontrivial solution of (1.7) and (t_1, t_2, \ldots, t_k) solves (1.9).

3 Proof of Theorem 1.6

Recall that

$$A := \inf_{\vec{\mathbf{u}} \in \mathcal{N}} I(\vec{\mathbf{u}}) = \inf_{\vec{\mathbf{u}} \in \mathcal{N}} \frac{1}{N} \int_{\mathbb{R}^N} \sum_{i=1}^k |\nabla u_i|^2,$$

where

$$\mathcal{N} = \{ \vec{\mathbf{u}} \in D : u_i \neq 0, I'(\vec{\mathbf{u}})(0, \dots, 0, u_i, 0, \dots, 0) = 0, \ i = 1, 2, \dots, k \}.$$

Define

$$A' := \inf_{\vec{\mathbf{u}} \in \mathcal{N}'} I(\vec{\mathbf{u}}), \tag{3.1}$$

where

$$\mathcal{N}' = \{ \vec{\mathbf{u}} \in D \setminus \{ \vec{\mathbf{0}} \} : I'(\vec{\mathbf{u}}) \ \vec{\mathbf{u}} = 0 \}.$$
(3.2)

Note that $\mathcal{N} \subset \mathcal{N}'$, one has that $A' \leq A$. By Sobolev inequality (1.18), we have A, A' > 0.

Define $B(0,R) := \{x \in \mathbb{R}^N : |x| < R\}$ and $H(0,R) := (H_0^1(B(0,R)))^k$. Consider

$$\begin{cases} -\Delta u_i = \mu_i |u_i|^{2p-2} u_i + \sum_{\substack{j=1, j \neq i}}^k \beta_{ij} |u_i|^{p-2} u_i |u_j|^p, \quad x \in B(0, R), \\ u_i \in H_0^1(B(0, R)), \quad i = 1, 2, \cdots, k, \end{cases}$$
(3.3)

and define

$$A'(R) := \inf_{\vec{\mathbf{u}} \in \mathcal{N}'(R)} I(\vec{\mathbf{u}}), \tag{3.4}$$

where

$$\mathcal{N}'(R) = \left\{ \vec{\mathbf{u}} \in H(0,R) \setminus \{\vec{\mathbf{0}}\} : \int_{B(0,R)} \sum_{i=1}^{k} |\nabla u_i|^2 \, \mathrm{d}x - \int_{B(0,R)} (\sum_{i=1}^{k} \mu_i |u_i|^{2p} + \sum_{i,j=1,i < j}^{k} 2\beta_{ij} |u_i|^p |u_j|^p) \, \mathrm{d}x = 0 \right\}.$$
(3.5)

We need the following lemma from [19], which still holds in our case.

Lemma 3.1. $A'(R) \equiv A'$ for all R > 0.

Proof. Take any $R_1 > R_2$. By $\mathcal{N}'(R_2) \subset \mathcal{N}'(R_1)$, we have $A'(R_1) \leq A'(R_2)$. On the other hand, for any $(u_1, u_2, \ldots, u_k) \in \mathcal{N}'(R_1)$, we define

$$u'_i(x) := \left(\frac{R_1}{R_2}\right)^{\frac{N-2}{2}} u_i\left(\frac{R_1}{R_2}x\right),$$

then it is standard to see that $(u_1', u_2', \dots, u_k') \in \mathcal{N}'(R_2)$, and we have

$$A'(R_2) \le I(u'_1, u'_2, \dots, u'_k) = I(u_1, u_2, \dots, u_k), \quad \forall (u_1, u_2, \dots, u_k) \in \mathcal{N}'(R_1).$$

That is, $A'(R_2) \le A'(R_1)$ and so $A'(R_1) = A'(R_2)$.

Clearly $A' \leq A'(R)$. Let $(u_{1n}, u_{2n}, \ldots, u_{kn})$ be a minimizing sequence of A'. We may assume that $u_{1n}, u_{2n}, \ldots, u_{kn} \in H^1_0(B(0, R_n))$ for some $R_n > 0$. Then $u_{1n}, u_{2n}, \ldots, u_{kn} \in \mathcal{N}'(R_n)$, and

$$A' = \lim_{n \to \infty} I(u_{1n}, u_{2n}, \dots, u_{kn}) \ge \lim_{n \to \infty} A'(R_n) \equiv A'(R).$$

Therefore, $A'(R) \equiv A'$ for all R > 0.

Let $0 \le \varepsilon . Consider$

$$\begin{cases} -\Delta u_i = \mu_i |u_i|^{2p-2-2\varepsilon} u_i + \sum_{j=1, j \neq i}^k \beta_{ij} |u_i|^{p-2-\varepsilon} u_i |u_j|^{p-\varepsilon}, \quad x \in B(0,1), \\ u_i \in H_0^1(B(0,1)), \quad i = 1, 2, \cdots, k, \end{cases}$$
(3.6)

and define

$$A_{\varepsilon} := \inf_{\vec{\mathbf{u}} \in \mathcal{N}_{\varepsilon}'} I_{\varepsilon}(\vec{\mathbf{u}}), \tag{3.7}$$

where

$$I_{\varepsilon}(\vec{\mathbf{u}}) := \frac{1}{2} \int_{B(0,1)} \sum_{i=1}^{k} |\nabla u_i|^2 \, \mathrm{d}x - \frac{1}{2p - 2\varepsilon} \int_{B(0,1)} (\sum_{i=1}^{k} \mu_i |u_i|^{2p - 2\varepsilon} + \sum_{i,j=1,i < j}^{k} 2\beta_{ij} |u_i|^{p - \varepsilon} |u_j|^{p - \varepsilon}) \, \mathrm{d}x,$$

$$\mathcal{N}'_{\varepsilon} = \{ \vec{\mathbf{u}} \in H(0,1) \setminus \{ \vec{\mathbf{0}} \} : H_{\varepsilon}(\vec{\mathbf{u}}) := I'_{\varepsilon}(\vec{\mathbf{u}}) \, \vec{\mathbf{u}} = 0 \}.$$

$$(3.9)$$

We shall introduce **the idea of induction**. We notice that the proof of Lemma 3.2 depends on the existence result Theorem 3.1 for the (k - 1)-coupled system case.

From now on, we assume that Lemma 3.2 and Theorem 3.1 hold true for (k - 1)coupled system. We shall give out the proof of Lemma 3.2 and Theorem 3.1 for kcoupled system in the sequel. Then by idea of induction, these results hold true for
arbitrary k-coupled system.

Denote $\hat{\mathbf{u}}_i \in H(0, 1)$ as an vector, where the number of nonzero components of $\hat{\mathbf{u}}_i$ is *i* for i = 1, 2, ..., k. Denote

$$C_{\varepsilon}(i) := \min\{\inf_{\hat{\mathbf{u}}_{i} \in \mathcal{N}_{\varepsilon}'} I_{\varepsilon}(\hat{\mathbf{u}}_{i})\}$$

= min
$$\left\{\inf_{\substack{(u_{1}, \dots, u_{i}, 0, \dots, 0) \in \mathcal{N}_{\varepsilon}'}} I_{\varepsilon}(u_{1}, \dots, u_{i}, 0, \dots, 0), \dots, \right.$$
$$\inf_{\substack{(0, \dots, 0, u_{1}, \dots, u_{i}) \in \mathcal{N}_{\varepsilon}'}} I_{\varepsilon}(0, \dots, 0, u_{1}, \dots, u_{i})\right\}.$$

 $\text{For the case } k=2, C_{\varepsilon}(1)=\min\{\inf_{(u,0)\in\mathcal{N}_{\varepsilon}'}I_{\varepsilon}(u,0), \inf_{(0,v)\in\mathcal{N}_{\varepsilon}'}I_{\varepsilon}(0,v)\}, C_{\varepsilon}(2)=A_{\varepsilon}.$

Lemma 3.2. For any $0 < \varepsilon < p - 1$, there holds

$$A_{\varepsilon} < \min\left\{C_{\varepsilon}(1), C_{\varepsilon}(2), \dots, C_{\varepsilon}(k-1)\right\}.$$
(3.10)

Proof. Fix any $0 < \varepsilon < p - 1$. By the idea of induction, we only need to prove

$$A_{\varepsilon} := C_{\varepsilon}(k) < C_{\varepsilon}(k-1)$$

Recall that $2 < 2p - 2\varepsilon < 2^*$, we may let $(u_1, u_2, \ldots, u_{k-1})$ be a least energy solution of the (k-1)-coupled system (3.6) with energy

$$c_{k-1} := \inf_{(u_1, u_2, \dots, u_{k-1}, 0) \in \mathcal{N}'_{\varepsilon}} I_{\varepsilon}(u_1, u_2, \dots, u_{k-1}, 0).$$

We note that for any $s \in \mathbb{R}$, there exists a unique t(s) > 0 such that

$$(t(s)u_1, t(s)u_2, \dots, t(s)u_{k-1}, t(s)s\phi) \in \mathcal{N}'_{\varepsilon}.$$

where $\phi \in H_0^1(\Omega) \setminus \{0\}$. In fact,

$$\begin{split} t(s)^{2p-2\varepsilon-2} \bigg(\int\limits_{B(0,1)} (\sum_{i=1}^{k-1} \mu_i |u_i|^{2p-2\varepsilon} + \sum_{i,j=1,i< j}^{k-1} 2\beta_{ij} |u_i|^{p-\varepsilon} |u_j|^{p-\varepsilon} \\ + \mu_k |s\phi|^{2p-2\varepsilon} + \sum_{i=1}^{k-1} 2\beta_{ik} |u_i|^{p-\varepsilon} |s\phi|^{p-\varepsilon}) \bigg) \\ &= \int\limits_{B(0,1)} (\sum_{i=1}^{k-1} |\nabla u_i|^2 + s^2 |\nabla \phi|^2), \end{split}$$

Note that t(0) = 1. Recall that 0 , by direct computations we have

$$\lim_{s \to 0} \frac{t'(s)}{|s|^{p-2-\varepsilon}s} = -\frac{p-\varepsilon}{(p-\varepsilon-1)p'c_{k-1}} \int\limits_{B(0,1)} \sum_{i=1}^{k-1} \beta_{ik} |u_i|^{p-\varepsilon} |\phi|^{p-\varepsilon},$$

where $p'=\frac{2p-2\varepsilon}{p-1-\varepsilon}.$ That is,

$$t'(s) = -\frac{p-\varepsilon}{(p-\varepsilon-1)p'c_{k-1}} \left(\int\limits_{B(0,1)} \sum_{i=1}^{k-1} \beta_{ik} |u_i|^{p-\varepsilon} |\phi|^{p-\varepsilon} \right) |s|^{p-\varepsilon-2} s \ (1+o(1)),$$

as $s \to 0$ and so

$$t(s) = 1 - \frac{1}{(p - \varepsilon - 1)p'c_{k-1}} \left(\int_{B(0,1)} \sum_{i=1}^{k-1} \beta_{ik} |u_i|^{p-\varepsilon} |\phi|^{p-\varepsilon} \right) |s|^{p-\varepsilon} (1 + o(1)), \quad \text{as } s \to 0.$$

This implies that

$$\begin{split} t(s)^{2p-2\varepsilon} &= 1 - \frac{2p - 2\varepsilon}{(p - \varepsilon - 1)p'c_{k-1}} \left(\int\limits_{B(0,1)} \sum_{i=1}^{k-1} \beta_{ik} |u_i|^{p-\varepsilon} |\phi|^{p-\varepsilon} \right) |s|^{p-\varepsilon} \left(1 + o(1) \right), \\ &= 1 - \frac{1}{c_{k-1}} \left(\int\limits_{B(0,1)} \sum_{i=1}^{k-1} \beta_{ik} |u_i|^{p-\varepsilon} |\phi|^{p-\varepsilon} \right) |s|^{p-\varepsilon} \left(1 + o(1) \right) \quad \text{as} \ s \to 0, \end{split}$$

then we see that

$$\begin{aligned} A_{\varepsilon} &\leq I_{\varepsilon}(t(s)u_{1}, \dots, t(s)u_{k-1}, t(s)s\phi) \\ &= \frac{1}{p'}t(s)^{2p-2\varepsilon} \left(p'c_{k-1} + \int_{B(0,1)} (\mu_{k}|s\phi|^{2p-2\varepsilon} + \sum_{i=1}^{k-1} 2\beta_{ik}|u_{i}|^{p-\varepsilon}|s\phi|^{p-\varepsilon} \right) \\ &= c_{k-1} - (\frac{1}{2} - \frac{1}{p'})|s|^{p-\varepsilon} \int_{B(0,1)} \sum_{i=1}^{k-1} 2\beta_{ik}|u_{i}|^{p-\varepsilon}|\phi|^{p-\varepsilon} + o(|s|^{p-\varepsilon}) \end{aligned}$$

 $< c_{k-1}$ as |s| > 0 small enough.

Then by similar arguments, we have

$$A_{\varepsilon} < C_{\varepsilon}(k-1).$$

By the idea of induction, we have $C_{\varepsilon}(k-1) < C_{\varepsilon}(k-2) < \cdots < C_{\varepsilon}(1)$. This completes the proof.

Denote

$$C(i) := \min \{ \inf_{\hat{\mathbf{u}}_i \in \mathcal{N}'} I(\hat{\mathbf{u}}_i) \}$$

= min $\left\{ \inf_{\substack{(u_1, \dots, u_i, 0, \dots, 0) \in \mathcal{N}'}} I(u_1, \dots, u_i, 0, \dots, 0), \dots, \right.$
$$\inf_{\substack{(0, \dots, 0, u_1, \dots, u_i) \in \mathcal{N}'}} I(0, \dots, 0, u_1, \dots, u_i) \right\}.$$

Similarly as Lemma 3.2, we have

$$A' < \min\{C(1), C(2), \dots, C(k-1)\} < C(1) = \min\{I(\omega_{\mu_1}, 0, \dots, 0), \dots, I(0, \dots, 0, \omega_{\mu_k})\} = \min\{\frac{1}{N}\mu_1^{-\frac{N-2}{2}}S^{N/2}, \dots, \frac{1}{N}\mu_k^{-\frac{N-2}{2}}S^{N/2}\}.$$
(3.11)

Theorem 3.1. For any $0 < \varepsilon < p - 1$, (3.6)has a classical least energy solution $\vec{u}_{\varepsilon} = (u_1^{\varepsilon}, u_2^{\varepsilon}, \dots, u_k^{\varepsilon})$, and $u_1^{\varepsilon}, u_2^{\varepsilon}, \dots, u_k^{\varepsilon} \in C^2(B(0,1))$ are all positive radially symmetric decreasing.

Proof. Fix any $0 < \varepsilon < p-1$, it is easy to see that $A_{\varepsilon} > 0$. For $(u_1, u_2, \ldots, u_k) \in \mathcal{N}'_{\varepsilon}$ with $u_1, u_2, \ldots, u_k \ge 0$, we donote by $(u_1^*, u_2^*, \ldots, u_k^*)$ as its Schwarz symmetrization. Then by the properties of Schwarz symmetrization and $\beta_{ij} > 0$, we have

$$\begin{split} \int_{B(0,1)} \sum_{i=1}^{k} |\nabla u_{i}^{*}|^{2} \, \mathrm{d}x &\leq \int_{B(0,1)} \sum_{i=1}^{k} |\nabla u_{i}|^{2} \, \mathrm{d}x \\ &= \int_{B(0,1)} (\sum_{i=1}^{k} \mu_{i} |u_{i}|^{2p-2\varepsilon} + \sum_{i,j=1,i < j}^{k} 2\beta_{ij} |u_{i}|^{p-\varepsilon} |u_{j}|^{p-\varepsilon}) \, \mathrm{d}x \\ &\leq \int_{B(0,1)} (\sum_{i=1}^{k} \mu_{i} |u_{i}^{*}|^{2p-2\varepsilon} + \sum_{i,j=1,i < j}^{k} 2\beta_{ij} |u_{i}^{*}|^{p-\varepsilon} |u_{j}^{*}|^{p-\varepsilon}) \, \mathrm{d}x. \end{split}$$

$$(3.12)$$

Recall (3.9) , there exists $t^* > 0$ such that $(t^*u_1^*, t^*u_2^*, \dots, t^*u_k^*) \in \mathcal{N}'_{\varepsilon}$ with

$$(t^*)^{2p-2\varepsilon-2} = \frac{\int_{B(0,1)} \sum_{i=1}^k |\nabla u_i^*|^2 \,\mathrm{d}x}{\int_{B(0,1)} (\sum_{i=1}^k \mu_i |u_i^*|^{2p-2\varepsilon} + \sum_{i,j=1,i< j}^k 2\beta_{ij} |u_i^*|^{p-\varepsilon} |u_j^*|^{p-\varepsilon}) \,\mathrm{d}x} \le 1,$$

and then

$$I_{\varepsilon}(t^*u_1^*, t^*u_2^*, \dots, t^*u_k^*) = \left(\frac{1}{2} - \frac{1}{2p - 2\varepsilon}\right)(t^*)^2 \int_{B(0,1)} \sum_{i=1}^k |\nabla u_i^*|^2 \, \mathrm{d}x$$

$$\leq \left(\frac{1}{2} - \frac{1}{2p - 2\varepsilon}\right) \int_{B(0,1)} \sum_{i=1}^k |\nabla u_i|^2 \, \mathrm{d}x$$

$$= I_{\varepsilon}(u_1, u_2, \dots, u_k).$$

(3.13)

Therefore, we may take a minimizing sequence $\vec{\mathbf{u}}_n = (u_{1n}, u_{2n}, \dots, u_{kn}) \in \mathcal{N}_{\varepsilon}'$ such that $(u_{1n}, u_{2n}, \dots, u_{kn}) = (u_{1n}^*, u_{2n}^*, \dots, u_{kn}^*)$ and $I_{\varepsilon}(\vec{\mathbf{u}}_n) \to A_{\varepsilon}$. We see from (3.13) $u_{1n}, u_{2n}, \dots, u_{kn}$ are uniformly bounded in $H_0^1(B(0, 1))$. Passing to a subsequence, we may assume that $u_{in} \to u_i^{\varepsilon}$ weakly in $H_0^1(B(0, 1))$. By the compactness of the embedding $H_0^1(B(0, 1)) \hookrightarrow L^{2p-2\varepsilon}(B(0, 1))$ we have

$$\int_{B(0,1)} (\sum_{i=1}^{k} \mu_i |u_i^{\varepsilon}|^{2p-2\varepsilon} + \sum_{i,j=1,i< j}^{k} 2\beta_{ij} |u_i^{\varepsilon}|^{p-\varepsilon} |u_j^{\varepsilon}|^{p-\varepsilon}) dx$$
$$= \lim_{n \to \infty} \int_{B(0,1)} (\sum_{i=1}^{k} \mu_i |u_{in}|^{2p-2\varepsilon} + \sum_{i,j=1,i< j}^{k} 2\beta_{ij} |u_{in}|^{p-\varepsilon} |u_{jn}|^{p-\varepsilon}) dx$$
$$= \frac{2p-2\varepsilon}{p-1-\varepsilon} \lim_{n \to \infty} I_{\varepsilon}(\vec{\mathbf{u}}_n) = \frac{2p-2\varepsilon}{p-1-\varepsilon} A_{\varepsilon} > 0,$$

which implies $(u_1^{\varepsilon}, u_2^{\varepsilon}, \dots, u_k^{\varepsilon}) \neq (0, 0, \dots, 0)$. Moreover, $u_1^{\varepsilon}, u_2^{\varepsilon}, \dots, u_k^{\varepsilon} \geq 0$ are radially symmetric. Meanwhile,

$$\int_{B(0,1)} \sum_{i=1}^{k} |\nabla u_i^{\varepsilon}|^2 \, \mathrm{d}x \le \lim_{n \to \infty} \int_{B(0,1)} \sum_{i=1}^{k} |\nabla u_{in}|^2 \, \mathrm{d}x,$$

 $\int\limits_{B(0,1)} \sum_{i=1}^k |\nabla u_i^\varepsilon|^2 \,\mathrm{d}x \le \int\limits_{B(0,1)} (\sum_{i=1}^k \mu_i |u_i^\varepsilon|^{2p-2\varepsilon} + \sum_{i,j=1,i< j}^k 2\beta_{ij} |u_i^\varepsilon|^{p-\varepsilon} |u_j^\varepsilon|^{p-\varepsilon}) \,\mathrm{d}x.$

Therefore, there exists $0 < t_{\varepsilon} \leq 1$ such that $t_{\varepsilon} \vec{\mathbf{u}}_{\varepsilon} = (t_{\varepsilon} u_1^{\varepsilon}, t_{\varepsilon} u_2^{\varepsilon}, \dots, t_{\varepsilon} u_k^{\varepsilon}) \in \mathcal{N}_{\varepsilon}'$, and then $A_{\varepsilon} \leq I_{\varepsilon}(t_{\varepsilon} \vec{\mathbf{u}}_{\varepsilon})$

$$\begin{aligned} \mathbf{A}_{\varepsilon} &\leq I_{\varepsilon}(t_{\varepsilon}\mathbf{u}_{\varepsilon}) \\ &= \left(\frac{1}{2} - \frac{1}{2p - 2\varepsilon}\right)(t_{\varepsilon})^{2} \int_{B(0,1)} \sum_{i=1}^{k} |\nabla u_{i}^{\varepsilon}|^{2} \,\mathrm{d}x \\ &\leq \lim_{n \to \infty} \left(\frac{1}{2} - \frac{1}{2p - 2\varepsilon}\right) \int_{B(0,1)} \sum_{i=1}^{k} |\nabla u_{in}|^{2} \,\mathrm{d}x \\ &= \lim_{v \to \infty} I_{\varepsilon}(\vec{\mathbf{u}}_{n}) = A_{\varepsilon}. \end{aligned}$$

Therefore, $t_{\varepsilon} = 1$ and $\vec{\mathbf{u}}_{\varepsilon} \in \mathcal{N}'_{\varepsilon}$ with $I(\vec{\mathbf{u}}_{\varepsilon}) = A_{\varepsilon}$. Moreover,

$$\int\limits_{B(0,1)} \sum_{i=1}^{k} |\nabla u_i^{\varepsilon}|^2 \, \mathrm{d}x = \lim_{n \to \infty} \int\limits_{B(0,1)} \sum_{i=1}^{k} |\nabla u_{in}|^2 \, \mathrm{d}x,$$

that is, $u_{in} \to u_i^{\varepsilon}$ strongly in $H_0^1(B(0,1))$. There exists a Lagrange multiplier $\gamma \in \mathbb{R}$ such that

$$I_{\varepsilon}'(\vec{\mathbf{u}}_{\varepsilon}) - \gamma H_{\varepsilon}'(\vec{\mathbf{u}}_{\varepsilon}) = 0.$$

Since $I'_{\varepsilon}(\vec{\mathbf{u}}_{\varepsilon}) \ \vec{\mathbf{u}}_{\varepsilon} = H_{\varepsilon}(\vec{\mathbf{u}}_{\varepsilon}) = 0$ and

$$H_{\varepsilon}'(\vec{\mathbf{u}}_{\varepsilon})\,\vec{\mathbf{u}}_{\varepsilon} = (2+2\varepsilon-2p)\int\limits_{B(0,1)} (\sum_{i=1}^{k} \mu_{i}|u_{i}^{\varepsilon}|^{2p-2\varepsilon} + \sum_{i,j=1,i< j}^{k} 2\beta_{ij}|u_{i}^{\varepsilon}|^{p-\varepsilon}|u_{j}^{\varepsilon}|^{p-\varepsilon})\,\mathrm{d}x < 0$$

we get that $\gamma = 0$ and so $I_{\varepsilon}'(\vec{\mathbf{u}}_{\varepsilon}) = 0$. By Lemma 3.2, we see that $u_i^{\varepsilon} \neq 0$, otherwise $\vec{\mathbf{u}}_{\varepsilon}$ cannot minimize $I_{\varepsilon}(\vec{\mathbf{u}})$. This means that $\vec{\mathbf{u}}_{\varepsilon}$ is a least energy solution of (3.6). Recall that $u_1^{\varepsilon}, u_2^{\varepsilon}, \ldots, u_k^{\varepsilon} \geq 0$ are radially symmetric non-increasing. By regularity theory and the maximum principle, we see that $u_1^{\varepsilon}, u_2^{\varepsilon}, \ldots, u_k^{\varepsilon} > 0$ in B(0, 1) and $u_1^{\varepsilon}, u_2^{\varepsilon}, \ldots, u_k^{\varepsilon} \in C^2(B(0, 1))$ are radially symmetric decreasing.

Now we start to prove Theorem 1.6.

Proof of Theorem 1.6 Recall the definition of $\mathcal{N}'(R)$, for any $\vec{\mathbf{u}} \in \mathcal{N}'(1)$, there exists $t_{\varepsilon} > 0$ such that $t_{\varepsilon}\vec{\mathbf{u}} = (t_{\varepsilon}u_1, t_{\varepsilon}u_2, \dots, t_{\varepsilon}u_k) \in \mathcal{N}'_{\varepsilon}$ with $t_{\varepsilon} \to 1$ as $\varepsilon \to 0$. Then we have

$$\limsup_{\varepsilon \to 0} A_{\varepsilon} \le \limsup_{\varepsilon \to 0} I_{\varepsilon}(t_{\varepsilon} \vec{\mathbf{u}}) = I(\vec{\mathbf{u}}), \quad \forall \ \vec{\mathbf{u}} \in \mathcal{N}'(1).$$

then

By Lemma 3.1 we have

$$\limsup_{\varepsilon \to 0} A_{\varepsilon} \le A'(1) = A'. \tag{3.14}$$

By Theorem 3.1, let $\vec{\mathbf{u}}_{\varepsilon} = (u_1^{\varepsilon}, u_2^{\varepsilon}, \dots, u_k^{\varepsilon})$ be a positive least energy solution of (3.6), which is radially symmetric decreasing. Fix $0 < \varepsilon \leq \frac{p-1}{2}$. Then by $I'_{\varepsilon}(\vec{\mathbf{u}}_{\varepsilon}) \vec{\mathbf{u}}_{\varepsilon} = 0$ and Sobolev inequality, we see that

$$\frac{2p-2\varepsilon}{p-\varepsilon-1}A_{\varepsilon} = \int_{B(0,1)} \sum_{i=1}^{k} |\nabla u_{i}^{\varepsilon}|^{2} \,\mathrm{d}x \ge C_{0}, \quad \forall \ 0 < \varepsilon \le \frac{p-1}{2}, \tag{3.15}$$

where C_0 is a positive constant independent of ε . Then $u_1^{\varepsilon}, u_2^{\varepsilon}, \ldots, u_k^{\varepsilon}$ are uniformly bound in $H^1_0(B(0,1))$. Passing to a subsequence, we assume that $u_i^{\varepsilon} \rightharpoonup u_i^0$ weakly in $H_0^1(B(0,1))$ for i = 1, 2, ..., k. Then $\vec{\mathbf{u}}_0 = (u_1^0, u_2^0, ..., u_k^0)$ is a solution of

$$\begin{cases} -\Delta u_i = \mu_i |u_i|^{2p-2} u_i + \sum_{j=1, j \neq i}^k \beta_{ij} |u_i|^{p-2} u_i |u_j|^p, & x \in B(0, 1), \\ u_i \in H_0^1(B(0, 1)), & i = 1, 2, \cdots, k. \end{cases}$$
(3.16)

Assume by contradiction that $\sum_{i=1}^{k} \|u_i^{\varepsilon}\|_{\infty}$ is uniformly bounded, then by the Dominated Convergence Theorem, we get that

$$\lim_{\varepsilon \to 0} \int_{B(0,1)} |u_i^{\varepsilon}|^{2p-2\varepsilon} \mathrm{d}x = \int_{B(0,1)} |u_i^{0}|^{2p} \mathrm{d}x,$$
$$\lim_{\varepsilon \to 0} \int_{B(0,1)} |u_i^{\varepsilon}|^{p-\varepsilon} |u_j^{\varepsilon}|^{p-\varepsilon} \mathrm{d}x = \int_{B(0,1)} |u_i^{0}|^p |u_j^{0}|^p \mathrm{d}x$$

Combining these with $I'_{\varepsilon}(\vec{\mathbf{u}}_{\varepsilon}) = I'(\vec{\mathbf{u}}_0) = 0$, we have that $u^{\varepsilon}_i \to u^0_i$ strongly in $H_0^1(B(0,1))$ for $i = 1, 2, \dots, k$.

Then by (3.15), we see that $\vec{\mathbf{u}}_0 \neq \vec{\mathbf{0}}$. Moreover $u_1^0, u_2^0, \ldots, u_k^0 \ge 0$. We may assume $u_1^0 \neq 0$. By the strong maximum principle, $u_1^0 > 0$ in B(0,1). Note that $2p = 2^*$. Combining these with the Pohozaev identity (2.1), we have

$$0 < \int_{\partial B(0,1)} \sum_{i=1}^{k} |\nabla u_i|^2 (x \cdot \vec{\mathbf{n}}) \, \mathrm{d}S = 0,$$

a contradiction. Here, \vec{n} denotes the outward unit normal vector on $\partial B(0, 1)$. Therefore, we deduce that $\sum_{i=1}^{k} ||u_i^{\varepsilon}||_{\infty} \to +\infty$ as $\varepsilon \to 0$. Next we will use a blow up analysis. Note that $u_1^{\varepsilon}, u_2^{\varepsilon}, \dots, u_k^{\varepsilon}$ are radially symmetric decreasing, then $u_i^{\varepsilon}(0) = \max_{B(0,1)} u_i^{\varepsilon}(x)$.

We define $K_{\varepsilon} := \max_{i} \{u_{i}^{\varepsilon}(0)\}$, then $K_{\varepsilon} \to +\infty$ as $\varepsilon \to 0$. Define

$$U_i^{\varepsilon}(x) = K_{\varepsilon}^{-1} u_i^{\varepsilon} (K_{\varepsilon}^{-\alpha_{\varepsilon}} x)$$

where $\alpha_{\varepsilon} = p - 1 - \varepsilon$. Then

$$1 = \max_{i} \{ U_{i}^{\varepsilon}(0) \} = \max_{i} \left\{ \max_{x \in B(0, K_{\varepsilon}^{\alpha \varepsilon})} U_{i}^{\varepsilon}(x) \right\},$$
(3.17)

and $U_1^{\varepsilon}, U_2^{\varepsilon}, \ldots, U_k^{\varepsilon}$ satisfy the following system:

$$-\Delta U_i^{\varepsilon} = \mu_i (U_i^{\varepsilon})^{2p-2\varepsilon-1} + \sum_{j=1, j \neq i}^{\kappa} \beta_{ij} (U_i^{\varepsilon})^{p-1-\varepsilon} (U_j^{\varepsilon})^{p-\varepsilon}, \quad x \in B(0, K_{\varepsilon}^{\alpha_{\varepsilon}}).$$
(3.18)

Note that $0 < \varepsilon \leq \frac{p-1}{2}$, then

$$\int_{\mathbb{R}^N} |\nabla U_i^{\varepsilon}|^2 \, \mathrm{d}x = K_{\varepsilon}^{-(N-2)\varepsilon} \int_{\mathbb{R}^N} |\nabla u_i^{\varepsilon}|^2 \, \mathrm{d}x \le \int_{\mathbb{R}^N} |\nabla u_i^{\varepsilon}|^2 \, \mathrm{d}x$$

then $\{(U_1^{\varepsilon}, U_2^{\varepsilon}, \ldots, U_k^{\varepsilon})\}_{n\geq 1}$ is bounded in D. By elliptic estimates, for a subsequence we have $(U_1^{\varepsilon}, U_2^{\varepsilon}, \ldots, U_k^{\varepsilon}) \rightarrow (U_1, U_2, \ldots, U_k) \in D$ uniformly in every compact subset of \mathbb{R}^N as $\varepsilon \rightarrow 0$, and (U_1, U_2, \ldots, U_k) satisfies (1.17). Then we see that $I'(U_1, U_2, \ldots, U_k) = 0$. Moreover, $U_1, U_2, \ldots, U_k \geq 0$ are radially symmetric decreasing.

By (3.17) we have $(U_1, U_2, \ldots, U_k) \neq (0, \ldots, 0)$, and so $(U_1, U_2, \ldots, U_k) \in \mathcal{N}'$. Then we deduce from (3.14) that

$$\begin{aligned} A' &\leq I(U_1, U_2, \dots, U_k) = \left(\frac{1}{2} - \frac{1}{2p}\right) \int_{\mathbb{R}^N} \sum_{i=1}^k |\nabla U_i|^2 \, \mathrm{d}x \\ &\leq \liminf_{\varepsilon \to 0} \left(\frac{1}{2} - \frac{1}{2p - 2\varepsilon}\right) \int_{B(0, K_\varepsilon^{\alpha_\varepsilon})} \sum_{i=1}^k |\nabla U_i^\varepsilon|^2 \, \mathrm{d}x \\ &\leq \liminf_{\varepsilon \to 0} \left(\frac{1}{2} - \frac{1}{2p - 2\varepsilon}\right) \int_{B(0, 1)} \sum_{i=1}^k |\nabla u_i^\varepsilon|^2 \, \mathrm{d}x \\ &= \liminf_{\varepsilon \to 0} A_\varepsilon \leq A'. \end{aligned}$$

This implies that $I(U_1, U_2, \ldots, U_k) = A'$. By (3.11) we have that $U_i \neq 0$ for all $i = 1, 2, \ldots, k$. By strong maximum principle, $U_1, U_2, \ldots, U_k > 0$ are radially symmetric decreasing. Notice that $(U_1, U_2, \ldots, U_k) \in \mathcal{N}$ and so $I(U_1, U_2, \ldots, U_k) \geq A \geq A'$, that is,

$$I(U_1, U_2, \dots, U_k) = A' = A,$$
 (3.19)

and (U_1, U_2, \ldots, U_k) is a positive least energy solution of (1.17), which is radially symmetric decreasing.

Now we shall prove that the positive least energy solution of (1.17) must be the least energy synchronized type solution of the form $(t_1\omega, t_2\omega, \ldots, t_k\omega)$. Recall the minimizing problem

$$A' := \inf_{\vec{\mathbf{u}} \in \mathcal{N}'} I(\vec{\mathbf{u}}),$$

where

$$\mathcal{N}' = \{ \vec{\mathbf{u}} \in D \setminus \{ \vec{\mathbf{0}} \} : I'(\vec{\mathbf{u}}) \ \vec{\mathbf{u}} = 0 \},\$$

and the minimizing problem introducd in the proof of Lemma 2.2:

$$d_k := \inf_{\vec{\mathbf{t}} \in \mathcal{P}_k} \mathcal{G}_k(\vec{\mathbf{t}}),$$

where

$$\mathcal{G}_{k}(\vec{\mathbf{t}}) = \sum_{i=1}^{k} \left(\frac{t_{i}^{2}}{2} - \frac{\mu_{i}|t_{i}|^{2p}}{2p}\right) - \frac{1}{2p} \left(\sum_{i=1,j>i}^{k} 2\beta_{ij}|t_{i}|^{p}|t_{j}|^{p}\right),$$
$$\mathcal{P}_{k} = \{\vec{\mathbf{t}} \in \mathbb{R}^{k} \setminus \{\vec{\mathbf{0}}\} \mid P_{k}(\vec{\mathbf{t}}) := \sum_{i=1}^{k} (t_{i}^{2} - \mu_{i}|t_{i}|^{2p}) - \sum_{i=1,j>i}^{k} 2\beta_{ij}|t_{i}|^{p}|t_{j}|^{p} = 0\}.$$

By standard argument (cf. [36]), we see that

$$d_{k} = \inf_{\vec{\mathbf{t}} \in \mathbb{R}^{k} \setminus \{\vec{\mathbf{0}}\}} \frac{\left(\sum_{i=1}^{k} t_{i}^{2}\right)^{\frac{N}{2}}}{N\left(\sum_{i=1}^{k} \mu_{i} |t_{i}|^{2p} - \sum_{i=1, j > i}^{k} 2\beta_{ij} |t_{i}|^{p} |t_{j}|^{p}\right)^{\frac{N-2}{2}}},$$

and by (3.19) we have

$$A = A' = \inf_{\vec{\mathbf{u}} \in D \setminus \{\vec{\mathbf{0}}\}} \frac{\left(\sum_{i=1}^{k} \|\nabla u_i\|_2^2\right)^{\frac{N}{2}}}{N\left(\sum_{i=1}^{k} \mu_i \|u_i\|_{2p}^{2p} + \sum_{i,j=1,i< j}^{k} 2\beta_{ij} \|u_i u_j\|_p^p\right)^{\frac{N-2}{2}}}, \quad (3.20)$$

then by Sobolev inequality (1.18), we have

$$A' \ge \inf_{\vec{\mathbf{u}} \in D \setminus \{\vec{\mathbf{0}}\}} \frac{\left(\sum_{i=1}^{k} \|u_i\|_{2p}^2\right)^{\frac{N}{2}}}{N\left(\sum_{i=1}^{k} \mu_i \|u_i\|_{2p}^{2p} + \sum_{i,j=1,i< j}^{k} 2\beta_{ij} \|u_i\|_{2p}^p \|u_j\|_{2p}^p\right)^{\frac{N-2}{2}}} S^{\frac{N}{2}},$$

where $\|\cdot\|_q$ denotes the norm on $L^q(\mathbb{R}^N)$ and $2p = 2^* = \frac{2N}{N-2}$. Recall Lemma 2.2, then we see that

$$A' = d_k S^{\frac{N}{2}}$$

is attained by

$$(t_1U_{\varepsilon,y}, t_2U_{\varepsilon,y}, \ldots, t_kU_{\varepsilon,y})$$

where (t_1, t_2, \ldots, t_k) is the positive solution of (1.9) that attains d_k , and $U_{\varepsilon,y}$ is the Aubin-Talenti instanton given by (1.19).

In fact, we deduce that

$$A' = \inf_{\vec{\mathbf{u}} \in D \setminus \{\vec{\mathbf{0}}\}} \frac{\left(\sum_{i=1}^{k} \|u_i\|_{2p}^2\right)^{\frac{N}{2}}}{N\left(\sum_{i=1}^{k} \mu_i \|u_i\|_{2p}^{2p} + \sum_{i,j=1,i< j}^{k} 2\beta_{ij} \|u_i\|_{2p}^p \|u_j\|_{2p}^p\right)^{\frac{N-2}{2}}} S^{\frac{N}{2}}.$$
(3.21)

Suppose that A' is attained by some nonzero $\vec{\mathbf{v}} = (v_1, v_2, \dots, v_k)$. Then by Hölder inequality and Sobolev inequality, we see from (3.20) and (3.21) that

$$\|\nabla v_i\|_2^2 = S\|v_i\|_{2p}^2$$

for all i = 1, 2, ..., k, which implies $v_i = c_i U_{\varepsilon,y}$ for some $c_i \neq 0, \varepsilon > 0$ and $y \in \mathbb{R}^N$, or $v_i = 0$. Redenote all $v_i = c_i U_{\varepsilon,y}$ for all *i* where $c_i = 0$ or $c_i \neq 0$.

By (3.21), we have that $(||v_1||_{2p}, ||v_2||_{2p}, \ldots, ||v_k||_{2p})$ attains d_k . It is easy to see that (c_1, c_2, \ldots, c_k) attains d_k . Recall Lemma 2.2 that d_k is attained by a positive solution if $\beta_{ij} > 0$. Then $c_i > 0$ for all $i = 1, 2, \ldots, k$.

That is, A' is attained by $\vec{\mathbf{u}}$ if and only if

$$\vec{\mathbf{u}} = (\tilde{t}_1 U_{\varepsilon,y}, \tilde{t}_2 U_{\varepsilon,y}, \dots, \tilde{t}_k U_{\varepsilon,y}),$$

where $(\tilde{t}_1, \tilde{t}_2, \dots, \tilde{t}_k)$ is defined in (1.10). We see that, if $\vec{v} \in \mathcal{N}$ attains A, then $\vec{v} \in \mathcal{N}'$ and by (3.19) we have

$$I(\vec{\mathbf{v}}) = A = A',$$

which means $\vec{\mathbf{v}}$ attains A'. Since A' is attained only by $\vec{\mathbf{u}} = (\tilde{t}_1 U_{\varepsilon,y}, \tilde{t}_2 U_{\varepsilon,y}, \dots, \tilde{t}_k U_{\varepsilon,y})$, which solves (1.17), then $\vec{\mathbf{u}} \in \mathcal{N}$, by

$$I(\vec{\mathbf{u}}) = A = A',$$

we see that $\vec{\mathbf{u}}$ also attains A. Hence, the positive least energy solution of (1.17) must be the least energy synchronized type $(\tilde{t}_1 U_{\varepsilon,y}, \tilde{t}_2 U_{\varepsilon,y}, \dots, \tilde{t}_k U_{\varepsilon,y})$, where $(\tilde{t}_1, \tilde{t}_2, \dots, \tilde{t}_k)$ is defined in (1.10).

Finally, we show the existence of $(t_1(\beta), t_2(\beta), \dots, t_k(\beta))$ for $\beta_{ij} = \beta > 0$ small. Denote functions

$$f_i(t_1, t_2, \dots, t_k, \beta) := \mu_i t_i^{2p-2} + \sum_{j=1, j \neq i}^k \beta t_i^{p-2} t_j^p - 1, \quad t_i > 0, \text{ and } t_j \ge 0 \text{ for } j \neq i,$$
(3.22)

and define $t_i(0) = \mu_i^{-\frac{1}{2p-2}}$, then $f_i(t_1(0), t_2(0), \dots, t_k(0), 0) = 0$ for all $i = 1, 2, \dots, k$. Note that

$$\partial_i f_i(t_1(0), t_2(0), \dots, t_k(0), 0) = (2p - 2)\mu_i(t_i(0))^{2p - 3} > 0,$$

$$\partial_j f_i(t_1(0), t_2(0), \dots, t_k(0), 0) = 0, \quad \text{if } j \neq i \text{ and } j = 1, 2, \dots, k,$$

which implies that

$$\det(F_{ij})_{k \times k} := \det(\partial_j f_i(t_1(0), t_2(0), \dots, t_k(0), 0))_{k \times k} > 0.$$

Therefore, by the implicit function theorem, $(t_1(\beta), t_2(\beta), \ldots, t_k(\beta))$ are well defined and class C^1 on $(-\beta_2, \beta_2)$ for some $\beta_2 > 0$, and

$$f_i(t_1(\beta), t_2(\beta), \dots, t_k(\beta), \beta) \equiv 0, \quad i = 1, 2, \dots, k.$$

This implies that $(t_1(\beta), t_2(\beta), \dots, t_k(\beta))$ solves (1.9). Moreover, we notice that $(t_1(\beta)U_{\varepsilon,y}, t_2(\beta)U_{\varepsilon,y}, \dots, t_k(\beta)U_{\varepsilon,y})$ is a positive solution of (1.17) and

$$\lim_{\beta \to 0} \sum_{i=1}^{k} t_i^2(\beta) = \sum_{i=1}^{k} t_i^2(0) = \sum_{i=1}^{k} \mu_i^{-\frac{1}{p-1}},$$

that is, there exists $0 < \beta_1 \leq \beta_2$, such that

$$\sum_{i=1}^{k} t_i^2(\beta) > \min_i \{\mu_i^{-\frac{1}{p-1}}\}, \quad \forall \beta \in (0, \beta_1).$$

Combining this with (3.11), we have

$$I(\vec{\mathbf{U}}) = A' = A < I(t_1(\beta)U_{\varepsilon,y}, t_2(\beta)U_{\varepsilon,y}, \dots, t_k(\beta)U_{\varepsilon,y}), \quad \forall \beta \in (0,\beta_1),$$

that is, $(t_1(\beta)U_{\varepsilon,y}, t_2(\beta)U_{\varepsilon,y}, \dots, t_k(\beta)U_{\varepsilon,y})$ is a different positive solution of (1.17) with respect to $\vec{\mathbf{U}}$. This completes the proof.

Similarly to [19, Proposition 2.1], the following properties still hold in our case.

Proposition 3.1. Assume that $\mu_i > 0$ and $\beta_{ij} > 0$. Let $\vec{U} = (U_1, U_2, \dots, U_k)$ be a positive radially symmetric least energy solution of (1.17) obtained in Theorem 1.6. Then there exists C > 0 such that

$$\sum_{i=1}^{k} U_i(x) \le C(1+|x|)^{2-N}, \quad \sum_{i=1}^{k} |\nabla U_i(x)| \le C(1+|x|)^{2-N}.$$

Proof. Define the Kelvin transformation:

$$U_i^*(x) := |x|^{2-N} U_i(x^*), \quad x^* = \frac{x}{|x|^2},$$

then $U_1^*, \ldots, U_k^* \in D^{1,2}(\mathbb{R}^N)$ and (U_1^*, \ldots, U_k^*) satisfies the same system (1.17). By a standard Brézis-Kato argument [10], we see that $U_1^*, \ldots, U_k^* \in L^{\infty}(\mathbb{R}^N)$. Therefore, there exists C > 0 such that

$$U_i^*(x^*) = |x|^{N-2} U_i(x) \le C,$$

then

$$\sum_{i=1}^{k} U_i(x) \le C|x|^{2-N}.$$
(3.23)

On the other hand, we note that U_1, U_2, \ldots, U_k are radially symmetric decreasing. We also have $U_1, U_2, \ldots, U_k \in L^{\infty}(\mathbb{R}^N)$, and then

$$\sum_{i=1}^{k} U_i(x) \le C(1+|x|)^{2-N}.$$

Moreover, by standard elliptic regularity theory, we have that $U_1, U_2, \ldots, U_k \in C^2(\mathbb{R}^N)$. We write $U_i(|x|) = U_i(x)$ for convinience. Then

$$(r^{N-1}(U_i)_r)_r = -r^{N-1}(\mu_i U_i^{2^*-1} + \sum_{j=1, j \neq i}^k \beta_{ij} U_i^{\frac{2^*}{2}-1} U_j^{\frac{2^*}{2}}),$$

and so for any $R \ge 1$, we see from (3.23) that

$$\begin{aligned} R^{N-1}|(U_i)_r(R)| &\leq |(U_i)_r(1)| + \int_1^R r^{N-1}(\mu_i U_i^{2^*-1} + \sum_{j=1, j \neq i}^k \beta_{ij} U_i^{\frac{2^*}{2}-1} U_j^{\frac{2^*}{2}}) \,\mathrm{d}r \\ &\leq C + C \int_1^{+\infty} r^{N-1} r^{-N-2} \,\mathrm{d}r \leq C. \end{aligned}$$

Therefore, it is easy to see that $|\nabla U_i(x)| \leq C(1+|x|)^{2-N}$ for some C > 0. Then there exists C > 0 such that

$$\sum_{i=1}^{k} |\nabla U_i(x)| \le C(1+|x|)^{2-N}.$$

4 **Proof of Theorem 1.4**

In this section, without loss of genrality, we assume that

$$-\lambda_1(\Omega) < \lambda_1 \le \lambda_2 \le \dots \le \lambda_k < 0.$$

Recall the definition of B in (1.6), since

$$\int_{\Omega} (|\nabla u|^2 + \lambda_i u^2) \, \mathrm{d}x \ge (1 + \frac{\lambda_i}{\lambda_1(\Omega)}) \int_{\Omega} |\nabla u|^2 \, \mathrm{d}x, \quad i = 1, 2, \dots, k,$$

it is standard to see that B > 0. Recall [11] that the Brézis-Nirenberg problem

$$-\Delta u + \lambda_i u = \mu_i |u|^{2^* - 2} u, \quad u \in H_0^1(\Omega)$$

$$(4.1)$$

has a positive least energy solution $u_{\mu_i} \in C^2(\Omega) \cap C(\overline{\Omega})$ with energy

$$B_{\mu_{i}} := \frac{1}{2} \int_{\Omega} (|\nabla u_{\mu_{i}}|^{2} + \lambda_{i} u_{\mu_{i}}^{2}) \, \mathrm{d}x - \frac{\mu_{i}}{2^{*}} \int_{\Omega} u_{\mu_{i}}^{2^{*}} \, \mathrm{d}x,$$

$$< \frac{1}{N} \mu_{i}^{-\frac{N-2}{2}} S^{N/2}, \quad i = 1, 2, \dots, k.$$
(4.2)

We need the following lemma from [19].

Lemma 4.1. Let $u_n \rightharpoonup u, v_n \rightharpoonup v$ in $H^1_0(\Omega)$ as $n \rightarrow \infty$, then passing to a subsequence, there holds

$$\lim_{n \to \infty} \int_{\Omega} (|u_n|^p |v_n|^p - |u_n - u|^p |v_n - v|^p - |u|^p |v|^p) \, \mathrm{d}x = 0.$$

Remark 4.1. Similar to the proof of Theorem 1.6 in Sect. 3, before starting the proof, we shall introduce **the idea of induction** again. From now on, we assume that Theorem 1.4 hold true for (k - 1)-coupled system, that is,

the (k-1)-coupled system has a positive least energy solution. We shall give out the proof of these results for k-coupled system in the sequel. Then by the idea of induction, these theorems hold true for arbitrary k-coupled system.

For convinience, here are some notations. Consider the k-coupled system (1.1), where the coefficients $\lambda_i, \mu_i, \beta_{ij}$ are fixed. For each $\Theta \subsetneq \{1, ..., k\}$, we obtain the following $(k - |\Theta|)$ -coupled system

$$\begin{cases} -\Delta u_i + \lambda_i u_i = \mu_i u_i^{2p-1} + \sum_{j=1, j \neq i}^k \beta_{ij} u_i^{p-1} u_j^p & \text{in } \Omega, \\ u_i > 0 & \text{in } \Omega & \text{and} & u_i = 0 & \text{on } \partial\Omega, \quad i, j \in \{1, 2, \cdots, k\} \backslash \Theta, \end{cases}$$
(4.3)

by replacing $\lambda_i, \mu_i, \beta_{ij}, \beta_{ji}$ with 0 if $i \in \Theta$, where $|\Theta|$ is the cardinality of Θ . Note that the nontrivial solutions of (4.3) can be extended to the semi-trivial solutions of *k*-coupled system (1.1).

Denote $\tau = k - |\Theta|$. Indeed, we can establish C_k^{τ} different τ -coupled systems from (1.1). For every fixed Θ , we denote $\{i_1, \ldots, i_{\tau}\} = \{1, 2, \ldots, k\} \setminus \Theta$ and $B_{\mu_{i_1} \ldots \mu_{i_{\tau}}}$ as the least energy of the τ -coupled system (4.3) with coefficients $(\mu_{i_1}, \ldots, \mu_{i_{\tau}})$, that is,

 $B_{\mu_{i_1}...\mu_{i_\tau}} := \inf\{E(\vec{\mathbf{u}}) : \vec{\mathbf{u}} = (u_1, \dots, u_k) \text{ solves (1.1) and } u_i = 0 \text{ iff } i \in \Theta\}.$ (4.4)

Denote

$$\bar{B}_{\tau} := \min_{\forall \{l_1, \dots, l_{\tau}\} \subsetneqq \{1, 2, \dots, k\}} \{B_{\mu_{l_1} \dots \mu_{l_{\tau}}}\}.$$
(4.5)

Define

$$\mathcal{B} := \inf_{h \in \Gamma} \max_{t \in [0,1]} E(h(t)), \tag{4.6}$$

where $\Gamma = \{h \in C([0, 1], H) : h(0) = \vec{0}, E(h(1)) < 0\}$. By (1.5), we see that for any $\vec{u} \in H, \vec{u} \neq \vec{0}$,

$$\begin{aligned} \max_{t>0} E(t\vec{\mathbf{u}}) &= E(t_{\vec{\mathbf{u}}}\vec{\mathbf{u}}) \\ &= \frac{1}{N} t_{\vec{\mathbf{u}}}^2 \int_{\Omega} \sum_{i=1}^k (|\nabla u_i|^2 + \lambda_i u_i^2) \\ &= \frac{1}{N} t_{\vec{\mathbf{u}}}^{2^*} \int_{\Omega} (\sum_{i=1}^k \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^k 2\beta_{ij} |u_i|^p |u_j|^p), \end{aligned}$$
(4.7)

where $t_{\vec{u}} > 0$ satisfies

$$t_{\vec{\mathbf{u}}}^{2p-2} = \frac{\int_{\Omega} \sum_{i=1}^{k} (|\nabla u_i|^2 + \lambda_i u_i^2)}{\int_{\Omega} (\sum_{i=1}^{k} \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^{k} 2\beta_{ij} |u_i|^p |u_j|^p)}.$$
(4.8)

Note that $t_{\vec{u}} \in \mathcal{M}'$, where

$$\mathcal{M}' := \left\{ \vec{\mathbf{u}} \in H \setminus \{\vec{\mathbf{0}}\} : G(\vec{\mathbf{u}}) := \int_{\Omega} \sum_{i=1}^{k} (|\nabla u_i|^2 + \lambda_i u_i^2) - \int_{\Omega} (\sum_{i=1}^{k} \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^{k} 2\beta_{ij} |u_i|^p |u_j|^p) = 0 \right\}.$$
(4.9)

Note that $\mathcal{M} \subset \mathcal{M}'$, one has that $0 < \mathcal{B} \leq B$. It is easy to check that

$$\mathcal{B} = \inf_{\vec{\mathbf{0}} \neq \vec{\mathbf{u}} \in H} \max_{t > 0} E(t\vec{\mathbf{u}}) = \inf_{\vec{\mathbf{u}} \in \mathcal{M}'} E(\vec{\mathbf{u}}).$$
(4.10)

In fact, by (4.7) we have that

$$\inf_{\vec{\mathbf{0}}\neq\vec{\mathbf{u}}\in H}\max_{t>0}E(t\vec{\mathbf{u}})=\inf_{\vec{\mathbf{u}}\in\mathcal{M}'}E(\vec{\mathbf{u}}),$$

and

$$E'(t\vec{\mathbf{u}})(t\vec{\mathbf{u}}) = t^2 \int_{\Omega} \sum_{i=1}^{k} (|\nabla u_i|^2 + \lambda_i u_i^2) - t^{2p} \int_{\Omega} (\sum_{i=1}^{k} \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^{k} 2\beta_{ij} |u_i|^p |u_j|^p)$$

$$\geq 0 \quad \text{if} \quad 0 \le t \le t_{\vec{\mathbf{u}}} \,.$$

On the one hand, we see that $E(t\vec{\mathbf{u}}) < 0$ for $\vec{\mathbf{u}} \in H \setminus \{\vec{\mathbf{0}}\}$ and t > 0 large enough. Then by the definition of \mathcal{B} , we have

$$\mathcal{B} \leq \inf_{\vec{\mathbf{0}} \neq \vec{\mathbf{u}} \in H} \max_{t>0} E(t\vec{\mathbf{u}}).$$

On the other hand, \mathcal{M}' separates H into two components

$$\mathcal{M}'_1 = \{ \vec{\mathbf{u}} \in H \setminus \{ \vec{\mathbf{0}} \} : E'(\vec{\mathbf{u}})\vec{\mathbf{u}} > 0 \} \cup \{ \vec{\mathbf{0}} \},$$
$$\mathcal{M}'_2 = \{ \vec{\mathbf{u}} \in H \setminus \{ \vec{\mathbf{0}} \} : E'(\vec{\mathbf{u}})\vec{\mathbf{u}} < 0 \}.$$

Since $E'(t\vec{\mathbf{u}})(t\vec{\mathbf{u}}) \ge 0$ if $0 \le t \le t_{\vec{\mathbf{u}}}$, we have

$$\mathcal{M}'_1 = \{ t \vec{\mathbf{u}} : \vec{\mathbf{u}} \in H \setminus \{ \vec{\mathbf{0}} \}, \ 0 \le t < t_{\vec{\mathbf{u}}} \}, \quad \mathcal{M}'_2 = \{ t \vec{\mathbf{u}} : \vec{\mathbf{u}} \in H \setminus \{ \vec{\mathbf{0}} \}, \ t > t_{\vec{\mathbf{u}}} \}.$$

Note that for any $\vec{\mathbf{0}} \neq t\vec{\mathbf{u}} \in \mathcal{M}'_1$,

$$\begin{split} E(t\vec{\mathbf{u}}) &= \frac{t^2}{2} \int_{\Omega} \sum_{i=1}^k (|\nabla u_i|^2 + \lambda_i u_i^2) - \frac{t^{2p}}{2p} \int_{\Omega} (\sum_{i=1}^k \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^k 2\beta_{ij} |u_i|^p |u_j|^p) \\ &> \frac{1}{2p} \bigg[t^2 \int_{\Omega} \sum_{i=1}^k (|\nabla u_i|^2 + \lambda_i u_i^2) - t^{2p} \int_{\Omega} (\sum_{i=1}^k \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^k 2\beta_{ij} |u_i|^p |u_j|^p) \bigg] \\ &= \frac{1}{2p} E'(t\vec{\mathbf{u}})(t\vec{\mathbf{u}}) > 0, \quad \text{if } 0 < t < t_{\vec{\mathbf{u}}}, \end{split}$$

then every $h \in \Gamma$ has to cross \mathcal{M}' and $\inf_{\vec{\mathbf{u}} \in \mathcal{M}'} E(\vec{\mathbf{u}}) \leq \mathcal{B}$. It follows that (4.10) holds.

Next we introduce the key lemma in the proof of Theorem 1.4 which gives out an estimate of \mathcal{B} .

Lemma 4.2. (the comparison lemma) Let $\beta_{ij} > 0$, then

$$\mathcal{B} < \min\{\bar{B}_1, \bar{B}_2, \dots, \bar{B}_{k-1}, A\}.$$

Proof. We will prove the lemma in three steps.

Step 1 ($\mathcal{B} < A$)

Without loss of genrality, we may assume that $0 \in \Omega$. Then there exists $\rho > 0$ such that $B(0, 2\rho) := \{x : |x| \le 2\rho\} \subset \Omega$. Let $\psi \in C_0^1(B(0, 2\rho))$ be a nonnegative function with $0 \le \psi \le 1$ and $\psi \equiv 1$ for $|x| \le \rho$. Recall that $\vec{\mathbf{U}} = (U_1, U_2, \ldots, U_k)$ in Theorem 1.6. We define

$$U_i^{\varepsilon}(x) := \varepsilon^{-\frac{N-2}{2}} U_i(x/\varepsilon), \quad u_i^{\varepsilon} := \psi U_i^{\varepsilon}, \quad i = 1, 2, \dots, k$$

Then it is easy to see that

$$\int_{\mathbb{R}^N} |\nabla U_i^{\varepsilon}|^2 = \int_{\mathbb{R}^N} |\nabla U_i|^2, \quad \int_{\mathbb{R}^N} |U_i^{\varepsilon}|^{2^*} = \int_{\mathbb{R}^N} |U_i|^{2^*}, \quad i = 1, 2, \dots, k.$$

It's proved in [19] that

$$\int_{\Omega} |\nabla u_i^{\varepsilon}|^2 \le \int_{\mathbb{R}^N} |\nabla U_i|^2 + O(\varepsilon^{N-2}), \tag{4.11}$$

$$\int_{\Omega} |u_i^{\varepsilon}|^{2^*} \ge \int_{\mathbb{R}^N} |U_i|^{2^*} + O(\varepsilon^N), \qquad (4.12)$$

$$\int_{\Omega} |u_i^{\varepsilon}|^{\frac{2^*}{2}} |u_j^{\varepsilon}|^{\frac{2^*}{2}} \ge \int_{\mathbb{R}^N} |U_i|^{\frac{2^*}{2}} |U_j|^{\frac{2^*}{2}} + O(\varepsilon^N),$$
(4.13)

$$\int_{\Omega} |u_i^{\varepsilon}|^2 \ge C\varepsilon^2 + O(\varepsilon^{N-2}), \tag{4.14}$$

where C is a positive constant. Recall that $I(U_1, U_2, \dots, U_k) = A$, we have

$$NA = \int_{\mathbb{R}^N} \sum_{i=1}^k |\nabla U_i|^2 = \int_{\mathbb{R}^N} (\sum_{i=1}^k \mu_i |U_i|^{2^*} + \sum_{i=1,j>i}^k 2\beta_{ij} |U_i|^{\frac{2^*}{2}} |U_j|^{\frac{2^*}{2}}).$$

Combining this with (4.11)-(4.14) and recalling that $\lambda_i < 0, \ 2p = 2^*, \ N \ge 5$, we have for any t > 0 that

$$\begin{split} E(tu_1^{\varepsilon},\ldots,tu_k^{\varepsilon}) &= \frac{1}{2}t^2 \int_{\Omega} \sum_{i=1}^k (|\nabla u_i^{\varepsilon}|^2 + \lambda_i (u_i^{\varepsilon})^2) \\ &\quad - \frac{1}{2p}t^{2p} \int_{\Omega} (\sum_{i=1}^k \mu_i |u_i^{\varepsilon}|^{2p} + \sum_{i=1,j>i}^k 2\beta_{ij} |u_i^{\varepsilon}|^p |u_j^{\varepsilon}|^p) \\ &\leq \frac{1}{2} \bigg(\int_{\mathbb{R}^N} \sum_{i=1}^k |\nabla U_i|^2 - C\varepsilon^2 + O(\varepsilon^{N-2}) \bigg) t^2 \\ &\quad - \frac{1}{2^*} \bigg(\int_{\mathbb{R}^N} (\sum_{i=1}^k \mu_i |U_i|^{2^*} + \sum_{i=1,j>i}^k 2\beta_{ij} |U_i|^{\frac{2^*}{2}} |U_j|^{\frac{2^*}{2}}) + O(\varepsilon^N) \bigg) t^{2^*} \\ &= \frac{1}{2} \bigg(NA - C\varepsilon^2 + O(\varepsilon^{N-2}) \bigg) t^2 - \frac{1}{2^*} \bigg(NA + O(\varepsilon^N) \bigg) t^{2^*} \\ &\leq \frac{1}{N} \bigg(NA - C\varepsilon^2 + O(\varepsilon^{N-2}) \bigg) \bigg(\frac{NA - C\varepsilon^2 + O(\varepsilon^{N-2})}{NA + O(\varepsilon^N)} \bigg)^{\frac{N-2}{2}} \\ &< A \quad \text{for } \varepsilon > 0 \text{ small enough.} \end{split}$$

Hence, for $\varepsilon > 0$ small enough, there holds

$$\mathcal{B} \le \max_{t>0} E(tu_1^{\varepsilon}, \dots, tu_k^{\varepsilon}) < A.$$
(4.15)

From now on, we redenote $\mathcal{B}_k := \mathcal{B}$ as the minimax value defined in (4.6) for the *k*-coupled system.

Step 2 $(k = 3 \text{ and } \mathcal{B}_3 < \min\{\bar{B}_1, \bar{B}_2\})$

In [19], it's proved that the 2-coupled system

$$\begin{cases} -\Delta u + \lambda_i u = \mu_i u^{2p-1} + \beta_{ij} u^{p-1} v^p, & x \in \Omega, \\ -\Delta v + \lambda_j v = \mu_j v^{2p-1} + \beta_{ij} v^{p-1} u^p, & x \in \Omega, \\ u, v \ge 0 \text{ in } \Omega \text{ and } u = v = 0 \text{ on } \partial\Omega, \end{cases}$$

$$(4.16)$$

has a positive least energy solution (u_{ij}, v_{ij}) with energy $B_{\mu_i \mu_j}$ and

$$B_{\mu_i \mu_j} < \min\{B_{\mu_i}, B_{\mu_j}\},\tag{4.17}$$

then $\bar{B}_2 = \min\{B_{\mu_1\mu_2}, B_{\mu_1\mu_3}, B_{\mu_2\mu_3}\} < \bar{B}_1$, it remains to prove $\mathcal{B}_3 < \bar{B}_2$.

We shall prove $\mathcal{B}_3 < B_{\mu_1\mu_2}$.

Recall (4.8), we note that for any $s \in \mathbb{R}$, there exists a unique $t(s) := t_{u_{12},v_{12},s\phi}$

such that $(t(s)u_{12},t(s)v_{12},t(s)s\phi)\in \mathcal{M}'$ and

$$\begin{split} t(s)^{2p-2} & \left(\int\limits_{\Omega} (\mu_1 u_{12}^{2p} + \mu_2 v_{12}^{2p} + \mu_3 |s|^{2p} \phi^{2p} \\ & + 2\beta_{12} u_{12}^p v_{12}^p + 2\beta_{13} |s|^p u_{12}^p \phi^p + 2\beta_{23} |s|^p v_{12}^p \phi^p) \right) \\ & = \int\limits_{\Omega} (|\nabla u_{12}|^2 + \lambda_1 u_{12}^2 + |\nabla v_{12}|^2 + \lambda_2 v_{12}^2 + s^2 |\nabla \phi|^2 + \lambda_3 s^2 \phi^2), \end{split}$$

where (u_{12}, v_{12}) is a positive least energy solution of (4.16) and $\phi \in H_0^1(\Omega)$ is a positive function. Recall that

$$NB_{\mu_{1}\mu_{2}} = \int_{\Omega} (\mu_{1}u_{12}^{2p} + 2\beta_{12}u_{12}^{p}v_{12}^{p} + \mu_{2}v_{12}^{2p})$$
$$= \int_{\Omega} (|\nabla u_{12}|^{2} + \lambda_{1}u_{12}^{2} + |\nabla v_{12}|^{2} + \lambda_{2}v_{12}^{2}) := c_{12},$$

and we denote

$$g(s) := t(s)^{2p-2}$$

= $\frac{c_{12} + s^2 \int_{\Omega} (|\nabla \phi|^2 + \lambda_3 \phi^2)}{c_{12} + \int_{\Omega} (\mu_3 |s|^{2p} \phi^{2p} + 2\beta_{13} |s|^p u_{12}^p \phi^p + 2\beta_{23} |s|^p v_{12}^p \phi^p)} := \frac{A(s)}{B(s)}.$ (4.18)

Note that $t'(s) = \frac{1}{2p-2}g(s)^{\frac{3-2p}{2p-2}}g'(s)$ and

$$\lim_{s \to 0} g(s) = g(0) = t(0) = 1, \quad \lim_{s \to 0} A(s) = \lim_{s \to 0} B(s) = c_{12}.$$
 (4.19)

By direct computations we have

$$g'(s) = \frac{A'(s)}{B(s)} - \frac{A(s)B'(s)}{B^2(s)} := F_1(s) - F_2(s).$$

Note that 1 , then

$$\lim_{s \to 0} \frac{F_1(s)}{|s|^{p-2}s} = \lim_{s \to 0} \frac{2s^{2-p} \int (|\nabla \phi|^2 + \lambda_3 \phi^2)}{c_{12} + \int (\mu_3 |s|^{2p} \phi^{2p} + 2\beta_{13} |s|^p u_{12}^p \phi^p + 2\beta_{23} |s|^p v_{12}^p \phi^p)} = 0.$$
(4.20)

On the other hand, we see that

$$F_{2}(s) = \frac{2p|s|^{p-2}s}{B^{2}(s)} \left[c_{12} + s^{2} (\int_{\Omega} |\nabla \phi|^{2} + \lambda_{3} \phi^{2}) \right] \\ \cdot \left(|s|^{p} \int_{\Omega} \mu_{3} \phi^{2p} + \int_{\Omega} \beta_{13} u_{12}^{p} \phi^{p} + \beta_{23} v_{12}^{p} \phi^{p} \right),$$

then

$$\lim_{s \to 0} \frac{F_2(s)}{|s|^{p-2}s} = \frac{2p}{c_{12}} \int_{\Omega} \beta_{13} u_{12}^p \phi^p + \beta_{23} v_{12}^p \phi^p.$$
(4.21)

Then we have

$$\lim_{s \to 0} \frac{t'(s)}{|s|^{p-2}s} = -\frac{p}{(p-1)c_{12}} \int_{\Omega} \beta_{13} u_{12}^p \phi^p + \beta_{23} v_{12}^p \phi^p,$$

that is,

$$t'(s) = -\frac{p}{(p-1)c_{12}} \Big(\int_{\Omega} \beta_{13} u_{12}^p \phi^p + \beta_{23} v_{12}^p \phi^p \Big) \ |s|^{p-2} s \ (1+o(1)), \quad \text{as} \ s \to 0,$$

and so

$$t(s) = 1 - \frac{1}{(p-1)c_{12}} \left(\int_{\Omega} \beta_{13} u_{12}^p \phi^p + \beta_{23} v_{12}^p \phi^p\right) |s|^p (1+o(1)), \quad \text{as } s \to 0$$

This implies that

$$t(s)^{2p} = 1 - \frac{2p}{(p-1)c_{12}} \left(\int_{\Omega} \beta_{13} u_{12}^p \phi^p + \beta_{23} v_{12}^p \phi^p \right) |s|^p (1+o(1)), \quad \text{as } s \to 0.$$

Therefore, we deduce from (4.7) that

$$\begin{split} \mathcal{B}_{3} &\leq E(t(s)u_{12}, t(s)v_{12}, t(s)s\phi) \\ &= \frac{1}{N}t(s)^{2p}\int_{\Omega} \left(\mu_{1}u_{12}^{2p} + \mu_{2}v_{12}^{2p} + \mu_{3}|s|^{2p}\phi^{2p} \\ &+ 2\beta_{12}u_{12}^{p}v_{12}^{p} + 2\beta_{13}|s|^{p}u_{12}^{p}\phi^{p} + 2\beta_{23}|s|^{p}v_{12}^{p}\phi^{p}) \\ &= t(s)^{2p} \left[B_{\mu_{1}\mu_{2}} + \frac{1}{N}\int_{\Omega} \mu_{3}|s|^{2p}\phi^{2p} + 2\beta_{13}|s|^{p}u_{12}^{p}\phi^{p} + 2\beta_{23}|s|^{p}v_{12}^{p}\phi^{p} \right] \\ &= B_{\mu_{1}\mu_{2}} + \frac{1}{N}\int_{\Omega} \mu_{3}|s|^{2p}\phi^{2p} + 2\beta_{13}|s|^{p}u_{12}^{p}\phi^{p} + 2\beta_{23}|s|^{p}v_{12}^{p}\phi^{p} + o(|s|^{p}) \\ &- \frac{1}{N}\frac{2p}{p-1}|s|^{p}\int_{\Omega} \beta_{13}u_{12}^{p}\phi^{p} + \beta_{23}v_{12}^{p}\phi^{p} \\ &- \frac{1}{N}\frac{2p}{(p-1)c_{12}}|s|^{2p}(\int_{\Omega} \beta_{13}u_{12}^{p}\phi^{p} + \beta_{23}v_{12}^{p}\phi^{p})(\int_{\Omega} \mu_{3}|s|^{p}\phi^{2p} + 2\beta_{13}u_{12}^{p}\phi^{p} + 2\beta_{23}v_{12}^{p}\phi^{p}) \\ &= B_{\mu_{1}\mu_{2}} - (\frac{1}{2} - \frac{1}{N})|s|^{p}\int_{\Omega} 2\beta_{13}u_{12}^{p}\phi^{p} + 2\beta_{23}v_{12}^{p}\phi^{p} + o(|s|^{p}) \\ &< B_{\mu_{1}\mu_{2}} \quad \text{as } |s| > 0 \text{ small enough.} \end{split}$$

That is $\mathcal{B}_3 < B_{\mu_1\mu_2}$. By a similar argument, we can prove that $\mathcal{B}_3 < B_{\mu_i\mu_j}$, then $\mathcal{B}_3 < \overline{B}_2$, which implies that

$$\mathcal{B}_3 < \min\{\bar{B}_1, \bar{B}_2\}.$$

This completes the proof of the case k = 3.

Step 3 (for general $k \ge 3$)

Suppose that the (k - i)-coupled system (4.3) with coefficients $(\mu_1, \mu_2, \ldots, \mu_{k-i})$ has a positive least energy solution $\mathbf{w}_{k-i} = (\omega_1, \omega_2, \ldots, \omega_{k-i})$ with energy $B_{\mu_1 \ldots \mu_{k-i}}$. Denote

$$\mathcal{W} := (\omega_1, \omega_2, \dots, \omega_{k-i}, s\phi, s^2\phi, \dots, s^i\phi)$$

where $\phi \in H_0^1(\Omega)$ and $\phi \neq 0$.

Recall (4.8), we note that for any $s \in \mathbb{R}$, there exists a unique $t(s) := t_W$ such that $t(s)(W) \in \mathcal{M}'$. Then by similar argument as in **Step 2**, we have

$$\mathcal{B}_{k} \leq E(t(s)(\omega_{1}, \dots, \omega_{k-i}, s\phi, s^{2}\phi, \dots, s^{i}\phi))$$

= $B_{\mu_{1}\dots\mu_{k-i}} - (\frac{1}{2} - \frac{1}{N})|s|^{p} \int_{\Omega} \sum_{j=1}^{k-i} 2\beta_{j,k-i+1}|\omega_{j}|^{p}|\phi|^{p} + o(|s|^{p})$
 $< B_{\mu_{1}\dots\mu_{k-i}},$

which implies that $\mathcal{B}_k < \overline{B}_{k-i}$. This completes the proof.

Let's begin to prove Theorem 1.4.

Proof of Theorem 1.4. Assume that $\beta_{ij} > 0$. Since the functional E has a mountain pass structure, by the mountain pass theorem [4, 47] there exists $\{\vec{\mathbf{u}}_n\} \in H$, such that

$$\lim_{n \to +\infty} E(\vec{\mathbf{u}}_n) = \mathcal{B}, \quad \lim_{n \to +\infty} E'(\vec{\mathbf{u}}_n) = 0,$$

where $\vec{\mathbf{u}}_n = (u_{1n}, u_{2n}, \ldots, u_{kn})$. By standard argument it is easy to see that $\{\vec{\mathbf{u}}_n\}$ is bounded in H, and so we may assume that $(u_{1n}, \ldots, u_{kn}) \rightharpoonup (u_1, \ldots, u_k)$ weakly in H. Passing to a subsequence, we may assume that $u_{in} \rightharpoonup u_i$ weakly in $L^{2p}(\Omega)$, $|u_{in}|^{q-1}u_{in} \rightharpoonup |u_i|^{q-1}u_i$ weakly in $L^{2p/q}(\Omega)$ if 1 < q < 2p, and $u_{in} \rightarrow u_i$ strongly in $L^2(\Omega)$. Since $E'(\vec{\mathbf{u}}_n) \rightarrow 0$, then we have $E'(u_1, \ldots, u_k) = 0$.

Set $\sigma_{in} = u_{in} - u_i$, then by Brézis-Lieb Lemma, there holds

$$|u_{in}|_{2p}^{2p} = |u_i|_{2p}^{2p} + |\sigma_{in}|_{2p}^{2p} + o(1), \quad i = 1, 2, \dots, k.$$
(4.22)

Note that $\vec{\mathbf{u}}_n \in \mathcal{M}$ and $E'(\vec{\mathbf{u}}_n) = 0$. Then combined with Lemma 4.1, we have

$$\int_{\Omega} |\nabla \sigma_{in}|^2 - \int_{\Omega} (\mu_i |\sigma_{in}|^{2p} + \sum_{j=1, j \neq i}^k \beta_{ij} |\sigma_{in}|^p |\sigma_{jn}|^p) = o(1), \quad (4.23)$$

$$E(u_{1n}, \dots, u_{kn}) = E(u_1, \dots, u_k) + I(\sigma_{1n}, \dots, \sigma_{kn}) + o(1),$$
(4.24)

for i = 1, 2, ..., k.

Passing to a subsequence, we may assume that

$$\lim_{n \to +\infty} \int_{\Omega} |\nabla \sigma_{in}|^2 = b_i, \quad i = 1, 2, \dots, k,$$

then by (4.23) we have

$$I(\sigma_{1n},...,\sigma_{kn}) = \frac{1}{N}(b_1 + \dots + b_k) + o(1).$$

Letting $n \to +\infty$ in (4.24), we get that

$$0 \le E(u_1, \dots, u_k) \le E(u_1, \dots, u_k) + \frac{1}{N}(b_1 + \dots + b_k)$$

=
$$\lim_{n \to +\infty} E(\vec{\mathbf{u}}_n) = \mathcal{B}.$$
 (4.25)

Case 1. $u_1, u_2, ..., u_k \equiv 0$.

By (4.25), we have $b_1 + b_2 + \cdots + b_k > 0$. Then we assume that $(\sigma_{1n}, \ldots, \sigma_{kn}) \neq (0, \ldots, 0)$ for *n* large. Recall the definition of \mathcal{N}' , and by (4.23), it is easy to check that there exists t_n such that $(t_n \sigma_{1n}, \ldots, t_n \sigma_{kn}) \in \mathcal{N}'$ and $t_n \to 1$ as $n \to +\infty$. Then by (3.19) and (4.25), we have

$$\mathcal{B} = \frac{1}{N} \sum_{i=1}^{k} b_i = \lim_{n \to +\infty} I(\sigma_{1n}, \dots, \sigma_{kn})$$
$$= \lim_{n \to +\infty} I(t_n \sigma_{1n}, \dots, t_n \sigma_{kn})$$
$$\ge A' = A,$$

a contradiction with Lemma 4.2. Therefore, Case 1 is impossible.

Case 2. $u_i \neq 0$ and $u_j \equiv 0$ for $i \in I \subsetneq \{1, 2, \dots, k\}$ and $j \in \{1, 2, \dots, k\} \setminus I$.

Without loss of genrality, we may assume that $u_1, \ldots, u_\tau \neq 0, u_{\tau+1}, \ldots, u_k \equiv 0$. Then (u_1, \ldots, u_τ) is a nontrivial solution of the τ -coupled system, and so

$$\mathcal{B} \ge E(u_1, \dots, u_\tau, 0, \dots, 0) \ge B_{\mu_1 \dots \mu_\tau} \ge \bar{B}_\tau,$$

a contradiction with Lemma 4.2. Therefore, Case 2 is also impossible.

Therefore, $u_1, \ldots, u_k \not\equiv 0$.

Since $E'(u_1, \ldots, u_k) = 0$, we have $(u_1, \ldots, u_k) \in \mathcal{M}$, by $\mathcal{B} \leq B$ and (4.25) we have

$$E(u_1,\ldots,u_k) = \mathcal{B} = B. \tag{4.26}$$

This means $(|u_1|, \ldots, |u_k|) \in \mathcal{M} \subset \mathcal{M}'$ and $E(|u_1|, \ldots, |u_k|) = \mathcal{B} = B$. By (4.9) and (4.10), there exists a Lagrange multiplier $\gamma \in \mathbb{R}$ such that

$$E'(|u_1|,\ldots,|u_k|) - \gamma G'(|u_1|,\ldots,|u_k|) = 0.$$

Since $E'(|u_1|, \ldots, |u_k|)(|u_1|, \ldots, |u_k|) = G(|u_1|, \ldots, |u_k|) = 0$ and

$$G'(|u_1|, \dots, |u_k|)(|u_1|, \dots, |u_k|)$$

= $(2 - 2p) \int_{\Omega} (\sum_{i=1}^k \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^k 2\beta_{ij} |u_i|^p |u_j|^p) < 0,$

we get that $\gamma = 0$ and $E'(|u_1|, \ldots, |u_k|) = 0$. This means $(|u_1|, \ldots, |u_k|)$ is a least energy solution of (1.1). Then by the maximum principle, we see that $|u_1|, \ldots, |u_k| > 0$ in Ω . Therefore, $(|u_1|, \ldots, |u_k|)$ is a positive least energy solution of (1.1). \Box

Proof of Theorem 1.3 Assume that $N \ge 5, -\lambda_1(\Omega) < \lambda_1 = \cdots = \lambda_k := \lambda < 0$ and $\mu_i, \beta_{ij} > 0$. The following proof is similar to the proof of Theorem 1.6 (1). It is well known that the Brézis-Nirenberg problem [11]

$$-\Delta u + \lambda u = |u|^{2^* - 2} u, \quad u \in H^1_0(\Omega)$$

has a positive least energy solution ω that attains

$$S_{\lambda} := \inf_{u \in H_0^1(\Omega) \setminus \{0\}} \frac{\int (|\nabla u|^2 + \lambda u^2) \, \mathrm{d}x}{(\int |u|^{2^*} \, \mathrm{d}x)^{\frac{2}{2^*}}}.$$

By (4.10) and (4.26), we have

$$B := \inf_{\vec{\mathbf{u}} \in \mathcal{M}} E(\vec{\mathbf{u}}) = \inf_{\vec{\mathbf{u}} \in \mathcal{M}'} E(\vec{\mathbf{u}}),$$

where

$$E(\vec{\mathbf{u}}) = \frac{1}{2} \int_{\Omega} \sum_{i=1}^{k} (|\nabla u_i|^2 + \lambda u_i^2) - \frac{1}{2p} \int_{\Omega} (\sum_{i=1}^{k} \mu_i |u_i|^{2p} + \sum_{i=1,j>i}^{k} 2\beta_{ij} |u_i|^p |u_j|^p),$$

$$\mathcal{M} = \{ \vec{\mathbf{u}} \in H \mid u_i \neq 0, \ E'(\vec{\mathbf{u}})(0, \dots, u_i, \dots, 0) = 0 \text{ for } i = 1, 2, \dots, k \},$$

$$\mathcal{M}' = \{ \vec{\mathbf{u}} \in H \setminus \{ \vec{\mathbf{0}} \} \mid E'(\vec{\mathbf{u}}) \ \vec{\mathbf{u}} = 0 \text{ for } i = 1, 2, \dots, k \}.$$

Then by standard argument(cf. [36]), we have

$$B = \inf_{\vec{\mathbf{u}} \in H \setminus \{\vec{\mathbf{0}}\}} \frac{\left(\sum_{i=1}^{k} \int (|\nabla u_i|^2 + \lambda u_i^2)\right)^{\frac{N}{2}}}{N\left(\sum_{i=1}^{k} \mu_i \int |u_i|^{2p} + \sum_{i,j=1, i < j}^{k} 2\beta_{ij} \int |u_i u_j|^p\right)^{\frac{N-2}{2}}}.$$
 (4.27)

Recall the minimizing problem introducd in the proof of Lemma 2.2:

$$d_k := \inf_{\vec{\mathbf{t}} \in \mathcal{P}_k} \mathcal{G}_k(\vec{\mathbf{t}}),$$

where

$$\mathcal{G}_k(\vec{\mathbf{t}}) = \sum_{i=1}^k \left(\frac{t_i^2}{2} - \frac{\mu_i |t_i|^{2p}}{2p}\right) - \frac{1}{2p} \left(\sum_{i=1,j>i}^k 2\beta_{ij} |t_i|^p |t_j|^p\right),$$

$$\mathcal{P}_{k} = \{ \vec{\mathbf{t}} \in \mathbb{R}^{k} \setminus \{ \vec{\mathbf{0}} \} \mid P_{k}(\vec{\mathbf{t}}) := \sum_{i=1}^{k} (t_{i}^{2} - \mu_{i} | t_{i} |^{2p}) - \sum_{i=1, j > i}^{k} 2\beta_{ij} | t_{i} |^{p} | t_{j} |^{p} = 0 \}.$$

By standard argument (cf. [36]), we see that

$$d_{k} = \inf_{\vec{\mathbf{i}} \in \mathbb{R}^{k} \setminus \{\vec{\mathbf{0}}\}} \frac{\left(\sum_{i=1}^{k} \mu_{i}|t_{i}|^{2p} - \sum_{i=1,j>i}^{k} 2\beta_{ij}|t_{i}|^{p}|t_{j}|^{p}\right)^{\frac{N-2}{2}}}{N\left(\sum_{i=1}^{k} \mu_{i}|t_{i}|^{2p} - \sum_{i=1,j>i}^{k} 2\beta_{ij}|t_{i}|^{p}|t_{j}|^{p}\right)^{\frac{N-2}{2}}}$$

then by Sobolev inequality

$$\int_{\Omega} (|\nabla u|^2 + \lambda u^2) \, \mathrm{d}x \ge S_\lambda \left(\int_{\Omega} |u|^{2p} \, \mathrm{d}x \right)^{\frac{2}{2p}},$$

we have

$$B \ge \inf_{\vec{\mathbf{u}} \in H \setminus \{\vec{\mathbf{0}}\}} \frac{\left(\sum_{i=1}^{k} \|u_i\|_{2p}^2\right)^{\frac{N}{2}}}{N\left(\sum_{i=1}^{k} \mu_i \|u_i\|_{2p}^{2p} + \sum_{i,j=1,i< j}^{k} 2\beta_{ij} \|u_i\|_{2p}^p \|u_j\|_{2p}^p\right)^{\frac{N-2}{2}}} S_{\lambda}^{\frac{N}{2}}$$

where $\|\cdot\|_q$ denotes the norm on $L^q(\Omega)$ and $2p = 2^* = \frac{2N}{N-2}$. Recall Lemma 2.2, then we see that

$$B = d_k S_{\lambda}^{\frac{1}{2}}$$

is attained by

$$t_1\omega, t_2\omega, \ldots, t_k\omega),$$

(

where $(t_1, t_2, ..., t_k)$ is the positive solution of (1.9) that attains d_k . In fact, we deduce that

$$B = \inf_{\vec{\mathbf{u}} \in D \setminus \{\vec{\mathbf{0}}\}} \frac{\left(\sum_{i=1}^{k} \|u_i\|_{2p}^2\right)^{\frac{N}{2}}}{N\left(\sum_{i=1}^{k} \mu_i \|u_i\|_{2p}^{2p} + \sum_{i,j=1,i< j}^{k} 2\beta_{ij} \|u_i\|_{2p}^p \|u_j\|_{2p}^p\right)^{\frac{N-2}{2}}} S_{\lambda}^{\frac{N}{2}}.$$
(4.28)

Suppose that B is attained by some nonzero $\vec{\mathbf{v}} = (v_1, v_2, \dots, v_k)$. Then by Hölder inequality and Sobolev inequality, we see from (4.27) and (4.28) that

$$\int_{\Omega} (|\nabla v_i|^2 + \lambda v_i^2) \, \mathrm{d}x = S_\lambda \Big(\int_{\Omega} |v_i|^{2p} \, \mathrm{d}x \Big)^{\frac{2}{2p}},$$
$$\Big(\int_{\Omega} |v_i v_j|^p \, \mathrm{d}x \Big)^2 = \int_{\Omega} |v_i|^{2p} \, \mathrm{d}x \int_{\Omega} |v_j|^{2p} \, \mathrm{d}x$$

for all i, j = 1, 2, ..., k, which implies $v_i = 0$ or $v_i = c_i \omega_i$ for some $c_i \neq 0$, where ω_i is a positive least energy solution of Brézis-Nirenberg problem (1.7).

Moreover, for $v_i = c_i \omega_i \neq 0$, Hölder's inequality implies that there exists $k_i, k_j > 0$, such that $k_i (c_i w_i)^2 = k_j (c_j w_j)^2$. Thus we can redenote all $v_i = c_i \omega$ for all *i* where $c_i = 0$ or $c_i \neq 0$.

By (4.28), we have that $(||v_1||_{2p}, ||v_2||_{2p}, \ldots, ||v_k||_{2p})$ attains d_k . It is easy to see that (c_1, c_2, \ldots, c_k) attains d_k . Recall Lemma 2.2 that d_k is attained by a positive solution if $\beta_{ij} > 0$. Then $c_i > 0$ for all $i = 1, 2, \ldots, k$.

That is, B is attained by $\vec{\mathbf{u}}$ if and only if

$$\vec{\mathbf{u}} = (\tilde{t}_1 \omega, \tilde{t}_2 \omega, \dots, \tilde{t}_k \omega),$$

where $(\tilde{t}_1, \tilde{t}_2, \dots, \tilde{t}_k)$ is defined in (1.10). Then the positive least energy solution of the system (1.1) must be of the synchronized form $(\tilde{t}_1\omega, \tilde{t}_2\omega, \dots, \tilde{t}_k\omega)$.

Now we assume that $\beta_{ij} := \beta > 0, i \neq j, i, j = 1, 2, ..., k$. Assume that $\Omega \subset \mathbb{R}^N$ is a ball, then the positive least energy solution of the Brézis-Nirenberg problem (1.7) is unique (cf. [11]). Recall [49, Proposition 3.3] that there exists $\beta_k > 0$, such that the algebric system (1.9) has a unique solution that attains d_k for $\beta > \beta_k$. Therefore, the positive least energy solution of (1.1) is unique under these assumptions.
