Homogenization problems for the compressible Navier-Stokes system in 2D perforated domains

Abstract

In this paper, we study the homogenization problems for the stationary compressible Navier-Stokes system in a bounded 2D domain, where the domain is perforated with very tiny holes (or obstacles) whose diameters are much smaller than their mutual distances. We obtain that the process of homogenization doesn't change the motion of the fluids. From another point of view, we obtain the same system of equations in the asymptotic limit. It is the first result of homogenization problem in the compressible case in 2 dimension.

1 Introduction

Homogenization of colorblue the Newtonian fluid in physical domains perforated by a large number of tiny holes plays an important role in fluid mechanics and has gain lots of interest. Viscous fluid flows passing a great many fixed solid obstacles is a situation frequently occurring in real applications referring to [27]. Based on these applications, the models like stationary, viscous fluid flows represented by the the standard Stokes or Navier-Stokes system of equations in porous medium could be of vital importance.

The typical diameter and mutual distance of these holes become the main factors in the asymptotic behavior of fluid flows in the regime where the number of holes tends to infinity and their size tends to zero. With the increasing number of holes, the limit motion of fluid flow approaches a state governed by certain *homogenized* equations which are homogeneous in form of different cases (without obstacles).

Allaire [3], [4] (or earlier results by Tartar [28]) provided a systematical study of Stokes and/or Navier-Stokes system for three different circumstances where the holes are periodically distributed with different size. Roughly speaking, the asymptotic limit behavior is governed by Darcy's law when the holes are of supercritical size; when the holes are of the critical size, the asymptotic limit behavior gives rise to Brinkman's law; the subcritical size of holes makes no differences in the motion of the asymptotic limit the limit problem coincides with the original system of equations.

Moreover, relevant results has been extended to the evolutionary (time-dependent) incompressible Navire-Stokes system by Mikelić [23] and Allaire [2], and more recently in [14]. For the evolutionary barotropic (compressible) Navier-Stokes system, Masmoudi [22] obtained that the homogenization limit was governed by porous medium equation (Darcy's law) where the diameter of the holes is comparable to their mutual distance (critical size), and similar results for the full Navier-Stokes-Fourier system were obtained in [15]. In [10, 11, 20], the authors considered the case of small holes for the compressible Navier-Stokes equations and in [21], steady compressible Navier–Stokes–Fourier system is considered, homogenized equations mentioned above remain the same asymptotic limit as the original ones. Let us also mention the case when the hole is the moving rigid body. In the case of the compressible fluid with the moving rigid body the homogenization was study by Bravin and Nečasová [5].

1.1 Problem formulation

Similar to the case in [10] and [11], where the homogenization of 3D steady compressible Navier-Stokes equations is considered, here we concentrated on homogenization of the compressible (isentropic) stationary Navier-Stokes system in two spatial dimensions of the subcritical case and we show that the asymptotic limit coincides with the original one, where ε denotes the mutual distance between the holes and the diameter of the holes is taken as $a_{\varepsilon} = e^{-\sigma \varepsilon^{-\alpha}}$ with $\alpha > 2$. Considering a bounded domain $\Omega \subset \mathbb{R}^2$ of class \mathbb{C}^2 , we introduce a family of ε -dependent perforated domains $\{\Omega_{\varepsilon}\}_{\varepsilon>0}$,

where the sets $T_{\varepsilon,k}$ represent *holes* or *obstacles*. We suppose the following property concerning the distribution of the holes:

with

Here $x_{\varepsilon,k} \in T_{\varepsilon,k}$, $b_0 > 0$ and σ is positive constant independent of ε , for each $k, T_k \subset R^2$ is a simply connected bounded domain of class C^2 , B(x,r) denotes the open ball centered at x with radius r in R^2 . The diameter of each $T_{\varepsilon,k}$ is of size $O(a_{\varepsilon})$ and their mutual distance is $O(\varepsilon)$, where their total number $|K_{\varepsilon}|$ can be estimated as

For convenience, we use the symbol $L_0^q(\Omega)$ to denote the space of functions in $L^q(\Omega)$ with zero integral mean

$$L_0^q(\Omega) := \left\{ f \in L^q(\Omega) : \int_{\Omega} f \, \mathrm{d}x = 0 \right\}.$$

Then, we consider the following stationary (compressible) Navier-Stokes system in Ω_{ε}

$$\operatorname{div}\left(\boldsymbol{\varrho}\mathbf{u}\right) = 0,\tag{1.5}$$

$$\operatorname{div}\left(\varrho \mathbf{u} \otimes \mathbf{u}\right) + \nabla p(\varrho) = \operatorname{div} \mathbb{S}(\nabla \mathbf{u}) + \varrho \mathbf{f} + \mathbf{g},\tag{1.6}$$

$$\mathbb{S}(\nabla \mathbf{u}) = \mu \left(\nabla \mathbf{u} + \nabla^t \mathbf{u} - \frac{2}{3} (\operatorname{div} \mathbf{u}) \mathbb{I} \right) + \eta (\operatorname{div} \mathbf{u}) \mathbb{I}, \ \mu > 0, \ \eta \ge 0.$$

Here ρ is the fluid mass density, **u** is the velocity field, $p = p(\rho)$ is the pressure, $\mathbb{S}(\nabla \mathbf{u})$ stands for the Newtonian viscous stress tensor with constant viscosity coefficients μ, η .

In the spatial domain Ω_{ε} , the system is supplemented with the standard no-slip boundary condition

For the sake of simplicity, we concentrate on the *isentropic* pressure-density state relationship

$$p(\varrho) = a\varrho^{\gamma}, \ a > 0, \tag{1.9}$$

with the adiabatic exponent γ , which will be specified as follows.

The motion of the fluid is driven by the volume force **f** and nonvolume force **g**, defined on the whole domain Ω and independent of ε , those are supposed to be uniformly bounded,

Specifically, we use the symbol C to denote a generic bounded constant that may vary from line to line in the following contents but it is independent of the parameters of the problem, in particular of ε . Furthermore, we use the symbol \tilde{h} to denote the zero – extension of h in \mathbb{R}^2 , which means

$$\tilde{h} = h \text{ in } \Omega_{\varepsilon}, \quad \tilde{h} = 0 \text{ in } R^2 \setminus \Omega_{\varepsilon}.$$

To be consistent with its physical interpretation, the density ρ is non-negative and we fix the total mass of the fluid to be

$$0 < \inf_{0 < \varepsilon < 1} M_{\varepsilon} \le M_{\varepsilon} = \int_{\Omega_{\varepsilon}} \rho \, \mathrm{d}x \le \sup_{0 < \varepsilon < 1} M_{\varepsilon} < \infty.$$

In particular, the *Restriction operator* introduced by Allaire [3] can be used in a compatible way in 2D to construct the inverse of the divergence - the so-called Bogovskii's operator (see Bogovskii [6], Galdi [17, Chapter 3]).

The paper is organized as follows. In Section 1.1 to Section 1.3, we introduce the formulation of the problem, the definition of weak solutions and state our main results. Then in section 1.4, we introduce the Restriction operator and construct the inverse of the divergence - a Bogovskii's type operator which plays a crucial role in the proof of the uniform bound to the solution $[\rho, u]$. After that, uniform estimates are obtained via this operator in Section 2.1 to identify the asymptotic limit for the Navier-Stokes system in perforated domains. In Section 2.2 to Section 2.4, we give the convergence (or homogenization) process of 2D compressible Navier-Stokes system in perforated domains, which shows the homogenization process for the stationary compressible Navier-Stokes equations in a perforated domain is not affected by obstacles and the limit problem coincides with the original one. Finally, we obtain the main results listed in Section 1.3.

1.2 Weak solutions

We recall the definition of finite energy weak solutions to (1.5)-(1.8), see [24, Definition 4.1].

Definition 1.1. A couple of functions $[\varrho, \mathbf{u}]$ is said to be a finite energy weak solution of the Navier-Stokes system (1.5)-(1.7) supplemented with the conditions (1.8)-(1.12) in Ω_{ε} provided:

$$\varrho \ge 0 \quad a.e. \ in \ \Omega_{\varepsilon}, \int_{\Omega_{\varepsilon}} \varrho \ \mathrm{d}x = M_{\varepsilon}, \ \varrho \in L^{\beta(\gamma)}(\Omega_{\varepsilon}) \ for \ some \ \beta(\gamma) > \gamma, \ \mathbf{u} \in W_0^{1,2}(\Omega_{\varepsilon}; \mathbb{R}^2); \tag{1.13}$$

for any test functions $\psi \in C^{\infty}(\overline{\Omega}_{\varepsilon})$ and $\varphi \in C_{c}^{\infty}(\Omega_{\varepsilon}; \mathbb{R}^{2})$:

$$\int_{\Omega_{\varepsilon}} \rho \mathbf{u} \cdot \nabla \psi \, \mathrm{d}x = 0; \tag{1.14}$$

and the energy inequality

$$\int_{\Omega_{\varepsilon}} \mathbb{S}(\nabla \mathbf{u}) : \nabla \mathbf{u} \, \mathrm{d}x \le \int_{\Omega_{\varepsilon}} (\varrho \mathbf{f} + \mathbf{g}) \cdot \mathbf{u} \, \mathrm{d}x \tag{1.16}$$

holds.

Remark 1.2. A finite energy weak solution of the Navier-Stokes system (1.5)-(1.7) in Ω is similar to it in Ω_{ε} .

Definition 1.3. A finite energy weak solution $[\varrho, \mathbf{u}]$ (see [24]) is said to be a renormalized weak solution if

$$\int_{R^2} b(\varrho) \mathbf{u} \cdot \nabla_x \psi + \left(b(\varrho) - b'(\varrho) \varrho \right) \operatorname{div} \mathbf{u} \ \psi \ \mathrm{d}x = 0 \tag{1.17}$$

for any $\psi \in C_c^{\infty}(\mathbb{R}^2)$, where $[\varrho, \mathbf{u}]$ were extended to be zero outside Ω_{ε} , and any $b \in C^0([0, \infty)) \cap C^1((0, \infty))$ such that

$$b'(s) \le c \, s^{-\lambda_0} \text{ for } s \in (0,1], \quad b'(s) \le c \, s^{\lambda_1} \text{ for } s \in [1,\infty),$$
 (1.18)

with

$$c > 0, \quad \lambda_0 < 1, \quad -1 < \lambda_1 \le \frac{\beta(\gamma)}{2} - 1.$$

Lemma 1.4. By DiPerna-Lions' transport theory (see [9, Section II.3] and the modification in [24, Lemma 3.3]), for any $r \in L^{\beta}(\Omega)$, $\beta \geq 2$, $\mathbf{v} \in W_0^{1,2}(\Omega)$, where $\Omega \subset R^2$ is a bounded domain of class C^2 , such that

$$\operatorname{div}\left(r\mathbf{v}\right) = 0 \quad in \quad \mathcal{D}'(\Omega),\tag{1.20}$$

the renormalized equation

$$\operatorname{div}(b(r)\mathbf{v}) + (rb'(r) - b(r))\operatorname{div}\mathbf{v} = 0, \quad holds \text{ in } \mathcal{D}'(R^2), \tag{1.21}$$

for any $b \in C^0([0,\infty)) \cap C^1((0,\infty))$ satisfying (1.18)-(1.19) provided r and \mathbf{v} have been extended to be zero outside Ω .

Remark 1.5. Recall that the relevant values of the adiabatic exponent are $1 \le \gamma \le 5/3$, where the case $\gamma = 1$ corresponds to the isothermal case while $\gamma = 5/3$ is the adiabatic exponent of the monoatomic gas. Based on energy type arguments combined with the refined pressure estimates, Lions [19] proved the existence of weak solutions in the range $\gamma > 5/3$ in 3D. Lions' theory for the existence of weak solutions to homogeneous Dirichlet (no-slip) boundary conditions has been extended to the physical range $\gamma \le 5/3$ by several authors, see Březina and Novotný [7], Plotnikov and Sokolowski [25] for $\gamma > 3/2$, Frehse, Steinhauer and Waigant [16] for $\gamma > 4/3$, Plotnikov and Weigant [26] for $\gamma > 1$. While in two spatial dimensions with $\gamma > 1$, Lions ([19], Chapter 6) has given the existence of the weak solution $[\rho, u]$ in Ω . Then, we need to show that the asymptotic limit of solutions $[\rho_{\varepsilon}, \mathbf{u}_{\varepsilon}]$ of the compressible Navier-Stokes system (1.5)-(1.8) in Ω_{ε} coincides with a solution of the same system on the homogeneous domain Ω .

1.3 Main results

In this paper, we consider the case of optimal adiabatic exponent $\gamma > 1$ in the pressure law (1.9), which is also an innovation in this article.

Theorem 1.6. Suppose the conditions (1.9), (1.10), (1.12) are satisfied. Let $\gamma > 1$ and $\alpha > 2$ be given and $[\varrho_{\varepsilon}, \mathbf{u}_{\varepsilon}]_{0 < \varepsilon < 1}$ be a family of finite energy weak solutions to (1.5)-(1.8) in Ω_{ε} , where **f** and **g** satisfy (1.10). Then we have uniform estimates

$$\sup_{0<\varepsilon<1} \left(\|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})} + \|\mathbf{u}_{\varepsilon}\|_{W_{0}^{1,2}(\Omega_{\varepsilon};R^{2})} \right) \le C < \infty.$$
(1.22)

Moreover, up to a substraction of subsequence, the zero-extentsions $[\tilde{\varrho_{\varepsilon}}, \tilde{\mathbf{u}}_{\varepsilon}]$ to outside Ω_{ε} satisfy

$$\tilde{\varrho}_{\varepsilon} \to \varrho \text{ weakly in } L^{2\gamma}(\Omega), \quad \tilde{\mathbf{u}}_{\varepsilon} \to \mathbf{u} \text{ weakly in } W_0^{1,2}(\Omega; \mathbb{R}^2),$$

where $[\varrho, \mathbf{u}]$ is a finite energy weak solution to the same system of equations (1.5)-(1.8) in the limit domain Ω .

1.4 Preliminaries

1.4.1 Bogovskii's operator

Our principal result concerns the construction of the inverse of the divergence operator on the family of perforated domains $\{\Omega_{\varepsilon}\}_{\varepsilon>0}$.

Proposition 1.7. Let $\{\Omega_{\varepsilon}\}_{\varepsilon>0}$ be a family of domains with the properties specified in Section 1.1. Then there exists a linear operator

$$\mathcal{B}_{\varepsilon}: L^2_0(\Omega_{\varepsilon}) \to W^{1,2}_0(\Omega_{\varepsilon}; R^2),$$

such that for any $f \in L^2_0(\Omega_{\varepsilon})$,

$$\operatorname{div} \left(\mathcal{B}_{\varepsilon}(f) \right) = f \ in \ \Omega_{\varepsilon}, \left\| \mathcal{B}_{\varepsilon}(f) \right\|_{W_{0}^{1,2}(\Omega_{\varepsilon}; R^{2})} \leq C \| f \|_{L^{2}(\Omega_{\varepsilon})},$$

$$(1.24)$$

for some constant C independent of ε .

The existence of Bogovskii's operator on a *fixed* Lipschitz domain has been shown by several authors, such as Galdi [17] or Acosta, Durán and Muschietti [1] and Diening, Růžička and Schumacher [8], especially by Bogovskii [6], Pileckas and Kapitanskii [18]. Here, we need to establish the uniform estimate (1.24), where the constant C is independent of ε . For the sake of readers, we briefly give a proof of Proposition 1.7. Referring to [10] and [11], such a Bogovskii's operator is established in 3D case. Considering the significance of the Restriction operator in proving the existence of Bogovskii's operator and therefore, we introduce the following Restriction operator R_{ε} analogously by employing the Restriction operator constructed by Allaire ([3], Section 2.2).

Lemma 1.8. For Ω_{ε} defined in Section 1.1, there exists a linear bounded Restriction operator R_{ε} : $W_0^{1,2}(\Omega; R^2) \to W_0^{1,2}(\Omega_{\varepsilon}; R^2)$ such that

This Restriction operator is constructed in the proof of [[3], Lemma 2.1] in the following way

Let us introduce the following decomposition of the cube εC with $k \in K_{\varepsilon}$:

where $b_1 > 0$. For any $\mathbf{u} \in W_0^{1,2}(\Omega; \mathbb{R}^2)$, we can define \mathbb{R}_{ε} by

where $\mathbf{v}_{\varepsilon,k} \in W_0^{1,2}(\varepsilon C_k; \mathbb{R}^2)$ satisfies

Proof of Proposition 1.7. For $f \in L^2_0(\Omega_{\varepsilon})$, we consider the following zero-extension of f

By classical Bogovskii's operator (see Bogovskii [6]) defined on domain Ω , we obtain $\mathbf{u} := \mathcal{B}(f) \in W_0^{1,2}(\Omega; \mathbb{R}^2)$ satisfying

div

 in Ω_{ε} , $\|\mathbf{u}\|_{W_0^{1,2}(\Omega; R^2)} \le C \|\tilde{f}\|_{L^2(\Omega; R^2)} = C \|f\|_{L^2(\Omega_{\varepsilon}; R^2)}$ (1.35)

where C depends only on Ω . Furthermore, by (1.34) we have

Applying the Restriction operator constructed in (1.30)-(1.33), we obtain

whenever **u** satisfies (1.35). Moreover, we have $R_{\varepsilon}(\mathbf{u}) = \mathbf{u}$ in $\Omega \setminus \bigcup_{k \in K_{\varepsilon}} E_{\varepsilon,k}$. Combined with (1.30) and (1.37), we conclude that

where \mathcal{B} is the classical Bogovskii's operator on Ω . It's easy to check that

$\mathbf{2}$ Proof of Theorem 1.6

This section deals with the proof of Theorem 1.6. By Lemma 1.4, let us stress that the solution $[\rho_{\varepsilon}, \mathbf{u}_{\varepsilon}]$ is also a renormalized weak solution as follows.

Lemma 2.1. We have

$$\operatorname{div}\left(b(\tilde{\varrho}_{\varepsilon})\tilde{\mathbf{u}}_{\varepsilon}\right) + \left(\tilde{\varrho}_{\varepsilon}b'(\tilde{\varrho}_{\varepsilon}) - b(\tilde{\varrho}_{\varepsilon})\right)\operatorname{div}\tilde{\mathbf{u}}_{\varepsilon} = 0, \quad in \ \mathcal{D}'(R^2),$$

for any $b \in C^0([0,\infty)) \cap C^1((0,\infty))$ satisfying (1.18)-(1.19), where $[\tilde{\varrho}_{\varepsilon}, \tilde{\mathbf{u}}_{\varepsilon}]$ denotes the functions $[\varrho_{\varepsilon}, \mathbf{u}_{\varepsilon}]$ extended to be zero outside Ω_{ε} .

Uniform bounds $\mathbf{2.1}$

As shown in Lions ([19], Chapter 6) with $N = 2, \gamma > 1$, we have the existence of solution $[\varrho_{\varepsilon}, \mathbf{u}_{\varepsilon}] \in$ $[L^{2\gamma}(\Omega_{\varepsilon})] \times [H_0^1(\Omega_{\varepsilon})]^2$ for any fixed ε . However, the classical estimates of their norms depend on the Lipschitz character of domain Ω_{ε} , which goes to infinity as $\varepsilon \to 0$. In order to show the uniform estimates (1.22), we employ the uniform Bogovskii type operator $\mathcal{B}_{\varepsilon}$ constructed in Section 1.4 to establish the independence of $\varepsilon \in (0, 1)$ in (1.22).

By the Korn's inequality and the Hölder's inequality, the energy inequality (1.16) implies

$$\|\nabla \mathbf{u}_{\varepsilon}\|_{L^{2}(\Omega_{\varepsilon};R^{2\times2})}^{2} \leq C \left(\|\mathbf{f}\|_{L^{\infty}(\Omega_{\varepsilon};R^{2})} \|\varrho_{\varepsilon}\|_{L^{s}(\Omega_{\varepsilon})} \|\mathbf{u}_{\varepsilon}\|_{L^{t}(\Omega_{\varepsilon};R^{2})} + \|\mathbf{g}\|_{L^{\infty}(\Omega_{\varepsilon};R^{2})} \|\mathbf{u}_{\varepsilon}\|_{L^{1}(\Omega_{\varepsilon};R^{2})} \right),$$

$$(2.1)$$

where $\frac{1}{s} + \frac{1}{t} = 1$ and $s \to 1+, t \to \infty-$.

Remark 2.2. In Section 2.1 and Section 2.2, we frequently use ∞ - to denote a bounded real number arbitrarily close to positive infinity and x + (x-) denotes the real number arbitrarily close to x on the right (left) side.

Since $\mathbf{u}_{\varepsilon} \in W_0^{1,2}(\Omega_{\varepsilon}; \mathbb{R}^2)$ has zero trace on the boundary, the Sobolev embedding and the Poincaré inequality imply

$$\|\mathbf{u}_{\varepsilon}\|_{L^{1}(\Omega_{\varepsilon};R^{2})} \leq \|\mathbf{u}_{\varepsilon}\|_{W^{1,2}_{0}(\Omega_{\varepsilon};R^{2})} \leq C \|\nabla\mathbf{u}_{\varepsilon}\|_{L^{2}(\Omega_{\varepsilon};R^{2\times2})},$$
(2.3)

for some constant C independent of the domain Ω_{ε} .

By the above estimates (2.1)-(2.3), we deduce

(2.4)

Let $\mathcal{B}_{\varepsilon}$ be the operator introduced in Proposition 1.7, we introduce the test function

$$\varphi := \mathcal{B}_{\varepsilon} \left(\varrho_{\varepsilon}^{\gamma} - \frac{1}{|\Omega_{\varepsilon}|} \int_{\Omega_{\varepsilon}} \varrho_{\varepsilon}^{\gamma} \, \mathrm{d}x \right).$$

By Remark 1.5, we notice that

$$\varrho_{\varepsilon} \in L^{2\gamma}(\Omega_{\varepsilon}), \quad \mathbf{u}_{\varepsilon} \in W_0^{1,2}(\Omega_{\varepsilon}; \mathbb{R}^2), \text{ for any fixed } \varepsilon.$$

Then by Proposition 1.7 and (2.5), we have

$$\operatorname{div} \varphi = \varrho_{\varepsilon}^{\gamma} - \frac{1}{|\Omega_{\varepsilon}|} \int_{\Omega_{\varepsilon}} \varrho_{\varepsilon}^{\gamma} \, \mathrm{d}x \quad \text{in } \Omega_{\varepsilon}$$

$$(2.7)$$

and

$$\begin{aligned} |\varphi\|_{W_0^{1,2}(\Omega_{\varepsilon};R^2)} &\leq C \|\varrho_{\varepsilon}^{\gamma} - \frac{1}{|\Omega_{\varepsilon}|} \int_{\Omega_{\varepsilon}} \varrho_{\varepsilon}^{\gamma} \, \mathrm{d}x\|_{L^2(\Omega_{\varepsilon})} \\ &\leq C \, \left(\|\varrho_{\varepsilon}^{\gamma}\|_{L^2(\Omega_{\varepsilon})} + \|\varrho_{\varepsilon}^{\gamma}\|_{L^1(\Omega_{\varepsilon})}\right) \\ &\leq C \, \|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})}^{\gamma}. \end{aligned} \tag{2.8}$$

Taking φ as a test function in the weak formulation of the momentum equation (1.15) gives

$$I_{3} := -\int_{\Omega_{\varepsilon}} \varrho_{\varepsilon} \mathbf{u}_{\varepsilon} \otimes \mathbf{u}_{\varepsilon} : \nabla \varphi \, \mathrm{d}x,$$

$$I_{4} := -\int_{\Omega_{\varepsilon}} (\varrho_{\varepsilon} \mathbf{f} + \mathbf{g}) \cdot \varphi \, \mathrm{d}x.$$

$$I_{1} := \int p(\varrho_{\varepsilon}) \, \mathrm{d}x \, \frac{1}{|\Omega_{\varepsilon}|} \int \varrho_{\varepsilon}^{\gamma} \, \mathrm{d}x = \frac{a}{|\Omega_{\varepsilon}|} \|\varrho_{\varepsilon}\|_{L^{\gamma}(\Omega_{\varepsilon})}^{2\gamma}$$

For I_1 :

$$I_{1} := \int_{\Omega_{\varepsilon}} p(\varrho_{\varepsilon}) \, \mathrm{d}x \, \frac{1}{|\Omega_{\varepsilon}|} \int_{\Omega_{\varepsilon}} \varrho_{\varepsilon}^{\gamma} \, \mathrm{d}x = \frac{a}{|\Omega_{\varepsilon}|} \|\varrho_{\varepsilon}\|_{L^{\gamma}(\Omega_{\varepsilon})}^{2\gamma}$$

$$\leq \frac{a}{|\Omega_{\varepsilon}|} \|\varrho_{\varepsilon}\|_{L^{1}(\Omega_{\varepsilon})}^{2\gamma\theta_{1}} \|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})}^{2\gamma(1-\theta_{1})} = \frac{aM_{\varepsilon}^{2\gamma\theta_{1}}}{|\Omega_{\varepsilon}|} \|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})}^{2\gamma(1-\theta_{1})}, \qquad (2.10)$$

where we used (1.12), Young's inequality, and interpolations between Lebesgue spaces. M_{ε} is the total mass and the number θ_1 satisfies

 s.t. $\frac{1}{\gamma} = \frac{\theta_1}{1} + \frac{1 - \theta_1}{2\gamma}$. (2.11)

For I_2 :

$$I_{2} \leq C \|\nabla \mathbf{u}_{\varepsilon}\|_{L^{2}(\Omega_{\varepsilon}; R^{2\times2})} \|\nabla \varphi\|_{L^{2}(\Omega_{\varepsilon}; R^{2\times2})} \leq C \left(\|\varrho_{\varepsilon}\|_{L^{s}(\Omega_{\varepsilon})} + 1\right) \|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})}^{\gamma}$$

$$\leq C \left(\|\varrho_{\varepsilon}\|_{L^{1}(\Omega_{\varepsilon})}^{\theta_{2}}\|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})}^{1-\theta_{2}} + 1\right) \|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})}^{\gamma}$$

$$\leq C \left(M_{\varepsilon}^{\theta_{2}}\|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})}^{\gamma+1-\theta_{2}} + \|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})}^{\gamma}\right), \qquad (2.12)$$

where we used (1.12), (2.4) and (2.8). The number $0 < \theta_2 < 1$ is determined by

$$\frac{1}{s} = \frac{\theta_2}{1} + \frac{1 - \theta_2}{2\gamma}, \quad \frac{1}{s} + \frac{1}{t} = 1, \quad s \to 1+, \ t \to \infty-$$
(2.13)

which implies $\theta_2 = \frac{\frac{1}{s} - \frac{1}{2\gamma}}{1 - \frac{1}{2\gamma}} \to 1^{(1 - \theta_2 \to 0+)}$ for $s \to 1+$ and any $\gamma \in (1, +\infty)$. For I_3 :

where the estimates are similar to I_1, I_2 and

$$0 < \theta_2, \theta_3 < 1$$
 s.t. $\frac{1}{s} = \frac{\theta_2}{1} + \frac{1 - \theta_2}{2\gamma}$ and $\frac{1}{s_1} = \frac{\theta_3}{1} + \frac{1 - \theta_3}{2\gamma}$. (2.15)

This implies

$$\theta_3 = \frac{\frac{1}{s_1} - \frac{1}{2\gamma}}{1 - \frac{1}{2\gamma}} \to 0 + (1 - \theta_3 \to 1 -) \text{ as } s_1 \to 2 +, \ \gamma \to 1 +.$$

$$\leq C \|\varrho_{\varepsilon}\|_{L^{s}(\Omega_{\varepsilon})} \|\mathbf{f}\|_{L^{\infty}(\Omega_{\varepsilon};R^{2})} \|\varphi\|_{L^{t}(\Omega_{\varepsilon};R^{2})} + \|\mathbf{f}\|_{L^{\infty}(\Omega_{\varepsilon};R^{2})} \|\varphi\|_{L^{2}(\Omega_{\varepsilon};R^{2})}$$

$$\leq C (1 + \|\varrho_{\varepsilon}\|_{L^{s}(\Omega_{\varepsilon})}) \|\varphi\|_{W^{1,2}(\Omega_{\varepsilon};R^{2})}$$

$$\leq C (1 + M_{\varepsilon}^{\theta_{2}} \|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})}^{1-\theta_{2}}) \|\varrho_{\varepsilon}\|_{L^{2\gamma}(\Omega_{\varepsilon})}^{\gamma}, \qquad (2.17)$$

where s, t and θ_2 are the same as above. Summing up the estimates for I_1 to I_4 implies

Once $\gamma > 1$ fixed, we can always find $s \to 1+$ smaller than γ s.t. $1 - \theta_2 \to 0+$ (for any $\gamma \in (1, +\infty)$). At the same time, $1 - \theta_3$ goes down with the increase of γ and there exists $s_1 \to 2+$ s.t. $1 - \theta_3 \to 1-$ (for any $\gamma \to 1+$) to obtain $\beta_1(\gamma) < 2\gamma$ in (2.18).

Then we deduce

Let $[\tilde{\varrho}_{\varepsilon}, \tilde{\mathbf{u}}_{\varepsilon}]$ be the zero extension of $[\varrho_{\varepsilon}, \mathbf{u}_{\varepsilon}]$ in Ω . Then by (2.19) and (2.20) we have

We obtained the uniform estimate (1.22) and the weak convergence in (1.23).

2.2 Equations in homogeneous domain

Now, we show that the couple $[\tilde{\varrho}_{\varepsilon}, \tilde{\mathbf{u}}_{\varepsilon}]$ solves the momentum equations as (1.6) in Ω up to a small remainder.

Lemma 2.3. Under the assumptions in Theorem 1.6, there holds

where the distribution \mathbf{r}_{ε} is small and satisfies:

$$\langle \mathbf{r}_{\varepsilon}, \varphi \rangle_{\mathcal{D}'(\Omega; R^2), \mathcal{D}(\Omega; R^2)} | \leq C \varepsilon^{\delta_1} (\|\nabla \varphi\|_{L^t(\Omega_{\varepsilon}; R^{2 \times 2})} + \|\varphi\|_{L^{\infty}(\Omega_{\varepsilon}; R^2)}),$$
(2.24)

for any $\varphi \in C_c^{\infty}(\Omega; \mathbb{R}^2)$ and $\delta_1 := \frac{1}{2}\alpha - 1 > 0, t \to 2+$, bounded constant C > 0.

Proof of Lemma 2.3. By the assumptions on the distribution and the size of the holes in (1.2), there exists cut-off function $g_{\varepsilon} \in C_c^{\infty}(\Omega)$ satisfying $0 \le g_{\varepsilon} \le 1$ and

Then for any $\varphi \in C_c^{\infty}(\Omega; \mathbb{R}^2)$, we have

where we used the fact that $(1 - g_{\varepsilon})\varphi \in C_c^{\infty}(\Omega_{\varepsilon}; \mathbb{R}^2)$ is a good test function for the momentum equations (1.6) in Ω_{ε} , and the quantity I_{ε} is of the form

$$I_{3,\varepsilon} := -\int_{\Omega} \mathbb{S}(\nabla \tilde{\mathbf{u}}_{\varepsilon}) : (g_{\varepsilon} \nabla \varphi) + \mathbb{S}(\nabla \tilde{\mathbf{u}}_{\varepsilon}) : (\nabla g_{\varepsilon} \otimes \varphi) \, \mathrm{d}x,$$

$$I_{4,\varepsilon} := \int_{\Omega} \tilde{\varrho}_{\varepsilon} \mathbf{f} \cdot g_{\varepsilon} \varphi + \mathbf{g} \cdot g_{\varepsilon} \varphi \, \mathrm{d}x.$$

We now estimate $I_{j,\varepsilon}$ (j = 1, 2, 3, 4) one by one. For $I_{1,\varepsilon}$, direct calculation gives

Here, we introduce $p(\varrho) - (\frac{4\mu}{3} + \eta)$ div **u** called effective viscous flux, which possesses some weak compactness property specified in the following lemma, which take up great significance in the existence theory of weak solutions for the compressible Navier-Stokes equations.

 if $d(x, \partial\Omega) < \frac{1}{n}$, $\psi_n(x) = 1$ if $d(x, \partial\Omega) > \frac{2}{n}$, $\|\nabla\psi_n\|_{L^{\infty}(\Omega; \mathbb{R}^2)} \le 2n$.

Then for any $q \in [1, \infty]$:

$$\|1 - \psi_n\|_{L^q(\Omega)} \le C n^{-\frac{1}{q}}, \quad \|\nabla \psi_n\|_{L^q(\Omega; R^2)} \le C n^{1-\frac{1}{q}},$$

and consequently

$$\|d(x,\partial\Omega)\nabla\psi_n\|_{L^q(\Omega;R^2)} \le C n^{-\frac{1}{q}}$$

Here, by Hardy's inequality, the velocity $\mathbf{u} \in W^{1,2}_0(\Omega;R^2)$ implies

$$\|[d(x,\partial\Omega)]^{-1}\mathbf{u}\|_{L^{2}(\Omega;R^{2})} \le C\|\mathbf{u}\|_{W^{1,2}(\Omega;R^{2})} \le C.$$

Therefore,

$$\int_{\Omega} \nabla \psi_{n} \cdot \overline{(\rho \log \rho)} \mathbf{u} \, dx$$

$$\leq \| d(x, \partial \Omega) \nabla \psi_{n} \|_{L^{10}(\Omega; \mathbb{R}^{2})} \| \overline{(\rho \log \rho)} \|_{L^{5/2}(\Omega)} \| [d(x, \partial \Omega)]^{-1} \mathbf{u} \|_{L^{2}(\Omega; \mathbb{R}^{2})}$$

$$\leq C n^{-1/10}.$$
(2.53)

Similarly,

$$\int_{\Omega} \nabla \psi_n \cdot (\rho \log \rho) \mathbf{u} \, \mathrm{d}x \le C \, n^{-1/10}.$$
(2.54)

Take $\psi = \psi_n$ in (2.39) and pass to the limit $n \to \infty$. By using (2.51)-(2.54), we deduce

$$\int_{\Omega} \overline{p(\varrho)\varrho} - \overline{p(\varrho)}\varrho \, \mathrm{d}x = 0.$$
(2.55)

By the strict monotonicity of the mapping $\rho \mapsto p(\rho)$, applying Theorem 10.19 in [12] or Lemma 3.35 in [24] implies

$$\overline{p(\varrho)\varrho} \ge \overline{p(\varrho)}\varrho$$
, a.e. in Ω .

Together with (2.55), we deduce

$$\overline{p(\varrho)\varrho} = \overline{p(\varrho)}\varrho$$
, a.e. in Ω .

Thus we complete the proof of Lemma 2.6.

By virtue of the monotonicity of $p(\cdot)$, and using Theorem 10.19 in [12] again, we obtain $\overline{p(\varrho)} = p(\varrho)$. Hence, we finish the proof of Theorem 1.6.

For convenience, we recall Theorem 10.19 in [12]: Let $I \subset R$ be an interval, $Q \subset R^d$ be a domain, P and G be non-decreasing functions in C(I). Let $\{\varrho_n\}_{n\in\mathbb{N}}$ be a sequence in $L^1(Q;I)$ such that

$$P(\varrho_n) \to \overline{P(\varrho)}, \quad G(\varrho_n) \to \overline{G(\varrho)}, \quad P(\varrho_n)G(\varrho_n) \to \overline{P(\varrho)G(\varrho)}, \quad \text{weakly in } L^1(Q).$$

Then the following properties hold:

- (i). $\overline{P(\varrho)} \ \overline{G(\varrho)} \le \overline{P(\varrho)G(\varrho)}$.
- (ii). If $P \in C(R)$, $G \in C(R)$, G(R) = R, G is strictly increasing, and $\overline{P(\varrho)} \ \overline{G(\varrho)} = \overline{P(\varrho)G(\varrho)}$, then $\overline{P(\varrho)} = P \circ G^{-1}\overline{G(\varrho)}$. If, in particular, G(z) = z be the identity function, there holds $\overline{P(\varrho)} = P(\varrho)$.
