# MINIMAL EXTENSIONS OF TANNAKIAN CATEGORIES IN POSITIVE CHARACTERISTIC

#### Abstract

We extend DGNO1, Theorem 4.5] and LKW, Theorem 4.22] to positive characteristic (i.e., to the finite, not necessarily fusion, case). Namely, we prove that if $\mathscr{D}$ is a finite nondegenerate braided tensor category over an algebraically closed field $k$ of characteristic $p>0$, containing a Tannakian Lagrangian subcategory $\operatorname{Rep}(G)$, where $G$ is a finite $k$-group scheme, then $\mathscr{D}$ is braided tensor equivalent to $\operatorname{Rep}\left(D^{\omega}(G)\right)$ for some $\omega \in H^{3}\left(G, \mathbb{G}_{m}\right)$, where $D^{\omega}(G)$ denotes the twisted double of $G$ (G]. We then prove that the group $\mathcal{M}_{\text {ext }}(\operatorname{Rep}(G))$ of minimal extensions of $\operatorname{Rep}(G)$ is isomorphic to the group $H^{3}\left(G, \mathbb{G}_{m}\right)$. In particular, we use [EG2, FP] to show that $\mathcal{M}_{\text {ext }}\left(\operatorname{Rep}\left(\mu_{p}\right)\right)=1, \mathcal{M}_{\text {ext }}\left(\operatorname{Rep}\left(\alpha_{p}\right)\right)$ is infinite, and if $\mathscr{O}(\Gamma)^{*}=u(\mathfrak{g})$ for a semisimple restricted $p$-Lie algebra $\mathfrak{g}$, then $\mathcal{M}_{\text {ext }}(\operatorname{Rep}(\Gamma))=1$ and $\mathcal{M}_{\operatorname{ext}}\left(\operatorname{Rep}\left(\Gamma \times \alpha_{p}\right)\right) \cong \mathfrak{g}^{*(1)}$.

## 1. Introduction

Let $\mathscr{E}$ be a finite symmetric tensor category over an algebraically closed field $k$ with characteristic 0 . A minimal extension of $\mathscr{E}$ is, by definition, a finite non-degenerate braided tensor category $\mathscr{D}$ over $k$, containing $\mathscr{E}$ as a Lagrangian subcategory (see 2.4 below). Given $\mathscr{E}$ as above, it is natural to try to classify its minimal extensions. Indeed, this problem was studied in several papers, e.g., DN, DGNO1, DGNO2, DMNO, GS, GVR, JFR, LKW, VR, OY.

In particular, in the papers [DGNO1, DGNO2, LKW] the authors classify the minimal extensions of Tannakian categories $\mathscr{E}=\operatorname{Rep}(G)$ over $k$ ( $G$ a finite group). Note that in this case, $\mathscr{E}$ and all its minimal extensions are fusion categories. More explicitly, in DGNO1, Theorem 4.5], [DGNO2, Theorem 4.64], it is proved that $\mathscr{D}$ is a minimal extension of $\operatorname{Rep}(G)$ if and only if $\mathscr{D}$ is braided tensor equivalent to the representation category $\operatorname{Rep}\left(D^{\omega}(G)\right)$ of a certain quasi-Hopf algebra $D^{\omega}(G)$ for some $\omega \in H^{3}\left(G, k^{\times}\right)$. Then in [LKW, Theorem 4.22], it is shown that minimal extensions of $\operatorname{Rep}(G)$ carry a natural structure of a commutative group, denoted by $\mathcal{M}_{\text {ext }}(\operatorname{Rep}(G))$, and that $\mathcal{M}_{\text {ext }}(\operatorname{Rep}(G)) \cong H^{3}\left(G, k^{\times}\right)$as groups.

Our goal in this paper is to extend the above mentioned results of DGNO1, DGNO2, LKW] to minimal extensions of Tannakian categories in positive characteristic.

Namely, assume from now on that $k$ is an algebraically closed field with characteristic $p>0$, and let $G$ be a finite $k$-group scheme. Then our goal is to relate minimal extensions of $\operatorname{Rep}(G)$ over $k$, and representation categories of twisted doubles $D^{\omega}(G), \omega \in H^{3}\left(G, \mathbb{G}_{m}\right)$ [G].

More precisely, we first prove the following result.
Theorem 1.1. Assume $\mathscr{D}$ is a finite non-degenerate braided tensor category over $k$ containing a Tannakian Lagrangian subcategory $\operatorname{Rep}(G)$, where $G$ is a finite group scheme over $k$. Then there exists an element $\omega \in H^{3}\left(G, \mathbb{G}_{m}\right)$ such that $\mathscr{D} \cong \mathscr{Z}(\operatorname{Coh}(G, \omega))$ as braided tensor categories (equivalently, $\mathscr{D}$ is braided tensor equivalent to the representation category $\operatorname{Rep}\left(D^{\omega}(G)\right)$ of a twisted double $D^{\omega}(G)$ of $\left.G\right)$.

Fix a finite non-degenerate braided tensor category $\mathscr{D}$ over $k$, and consider the set of all triples $(G, \omega, \mathrm{~F})$, where $G$ is a finite group scheme over $k, \omega \in H^{3}\left(G, \mathbb{G}_{m}\right)$, and $\mathrm{F}: \mathscr{D} \xrightarrow{\cong} \mathscr{Z}(\operatorname{Coh}(G, \omega))$ is a braided tensor equivalence. We say that $\left(G_{1}, \omega_{1}, \mathrm{~F}_{1}\right),\left(G_{2}, \omega_{2}, \mathrm{~F}_{2}\right)$ are equivalent, if there exists a tensor equivalence $\varphi: \operatorname{Coh}\left(G_{1}, \omega_{1}\right) \xrightarrow{\cong} \operatorname{Coh}\left(G_{2}, \omega_{2}\right)$ such that $\mathcal{F}_{2} \circ \mathrm{~F}_{2}=\varphi \circ \mathcal{F}_{1} \circ \mathrm{~F}_{1}$, where $\mathcal{F}_{i}: \mathscr{Z}\left(\operatorname{Coh}\left(G_{i}, \omega_{i}\right)\right) \rightarrow \operatorname{Coh}\left(G_{i}, \omega_{i}\right)$ are the canonical forgetful functors, $i=1,2$. Let $[(G, \omega, \mathrm{~F})]$ denote the equivalence class of $(G, \omega, \mathrm{~F})$.

Then using Theorem 1.1, we obtain the following corollary.
Corollary 1.2. Let $\mathscr{D}$ be a finite non-degenerate braided tensor category over $k$. Then the following sets are in natural one to one correspondence with each other:
(1) Equivalence classes $[(G, \omega, F)]$.
(2) Tannakian Lagrangian subcategories of $\mathscr{D}$.

Next we fix a finite group scheme $G$ over $k$, and consider the set of pairs $(\mathscr{D}, \iota)$, where $\mathscr{D}$ is a non-degenerate braided tensor category over $k$, and $\iota: \operatorname{Rep}(G) \xrightarrow{1: 1} \mathscr{D}$ is an injective braided tensor functor. We say that two pairs $\left(\mathscr{D}_{1}, \iota_{1}\right)$ and $\left(\mathscr{D}_{2}, \iota_{2}\right)$ are equivalent, if there exists a braided tensor equivalence $\psi: \mathscr{D}_{1} \xrightarrow{\cong} \mathscr{D}_{2}$ such that $\psi \circ \iota_{1}=\iota_{2}$. Let $\mathcal{M}_{\text {ext }}(\operatorname{Rep}(G))$ denote the set of all equivalence classes of pairs $(\mathscr{D}, \iota)$. Recall that $\mathcal{M}_{\text {ext }}(\operatorname{Rep}(G))$ has a natural structure of a commutative group [LKW].

Then using Theorem 1.1, we obtain the following corollary, which extends [LKW, Theorem 4.22] to positive characteristic.

Corollary 1.3. Let $G$ be a finite group scheme over $k$. There is a group isomorphism

$$
\mathcal{M}_{\mathrm{ext}}(\operatorname{Rep}(G)) \cong H^{3}\left(G, \mathbb{G}_{m}\right)
$$

The structure of the paper is as follows. In Section 2 we recall some necessary background on finite tensor categories and their exact module categories (2.1, (2.2), exact sequences of finite tensor categories (2.3), non-degenerate braided tensor categories and exact commutative algebras in finite braided tensor categories (2.4, 2.5), finite group schemes, de-equivariantization, the finite tensor categories $\operatorname{Coh}(G, \omega)$ and their centers $\mathscr{Z}(\operatorname{Coh}(G, \omega))$, and the group $\mathcal{M}_{\text {ext }}(\operatorname{Rep}(G))$ (2.6- 2.9).

Sections 3, 4 and 5 are devoted to the proofs of Theorem 1.1, Corollary 1.2 and Corollary 1.3, respectively.

Finally, in Section 6e give some examples. In particular, we use the results of [EG2] to show that the group $\mathcal{M}_{\text {ext }}\left(\operatorname{Rep}\left(\mu_{p}\right)\right)$ is trivial (see

Example 6.1) and the group $\mathcal{M}_{\text {ext }}\left(\operatorname{Rep}\left(\alpha_{p}\right)\right)$ is infinite (see Example 6.2), and use [FP] to conclude that if $\mathscr{O}(\Gamma)^{*}=u(\mathfrak{g})$ for a semisimple restricted $p$-Lie algebra $\mathfrak{g}$, then $\mathcal{M}_{\text {ext }}(\operatorname{Rep}(\Gamma))$ is the trivial group and $\mathcal{M}_{\text {ext }}\left(\operatorname{Rep}\left(\Gamma \times \alpha_{p}\right)\right) \cong \mathfrak{g}^{*(1)}($ see Examples 6.3 and 6.4).

## 2. Preliminaries

Let $k$ be an algebraically closed field with positive characteristic $p>0$, and let Vec denote the category of finite dimensional $k$-vector spaces.

Let $\mathscr{B}$ be any $k$-linear category. Recall that for every $V \in \mathrm{Vec}$, we have a natural functor

$$
V \otimes-: \mathscr{B} \rightarrow \mathscr{B}, \quad X \mapsto V \otimes X .
$$

Namely, for $X \in \mathscr{B}$, the object $V \otimes X$ is uniquely defined through the Yoneda lemma by the formula

$$
\operatorname{Hom}_{\mathscr{B}}(Y, V \otimes X) \cong V \otimes_{k} \operatorname{Hom}_{\mathscr{B}}(Y, X)
$$

(and the existence of this object is checked by choosing a basis in $V$ ).
2.1. Finite tensor categories. (See [EGNO, Chapter 6].) Let $\mathscr{B}$ be a finite tensor category over $k$. Let $\mathcal{O}(\mathscr{B})$ denote the complete set of isomorphism classes of simple objects of $\mathscr{B}$. Let $\operatorname{Gr}(\mathscr{B})$ denote the Grothendieck ring of $\mathscr{B}$, and let $\operatorname{Pr}(\mathscr{B})$ denote the group of isomorphism classes of projective objects in $\mathscr{B}$. Recall that $\operatorname{Pr}(\mathscr{B})$ is a bimodule over $\operatorname{Gr}(\mathscr{B})$, and we have a natural homomorphism $\tau: \operatorname{Pr}(\mathscr{B}) \rightarrow \operatorname{Gr}(\mathscr{B})$.

Recall [EO1, Subsection 2.4] that we have a character

$$
\operatorname{FPdim}: \operatorname{Gr}(\mathscr{B}) \rightarrow \mathbb{R}, \quad X \mapsto \operatorname{FPdim}(X)
$$

attaching to $X \in \mathscr{B}$ its Frobenius-Perron dimension. Recall also that

$$
\operatorname{FPdim}(\mathscr{B}):=\sum_{X \in \mathcal{O}(\mathscr{B})} \mathrm{FPdim}(X) \mathrm{FPdim}(P(X)),
$$

where $P(X)$ denotes the projective cover of $X$ and $\operatorname{FPdim}(P(X))$ is defined to be $\operatorname{FPdim}(\tau(P(X)))$.

Finally, recall that $\mathscr{A}$ is a tensor subcategory of $\mathscr{B}$ if $\mathscr{A}$ is a full subcategory of $\mathscr{B}$, closed under taking subquotients, tensor products, and duality [EGNO, Definition 4.11.1].
2.2. Exact module categories. Retain the notation from 2.1. Recall that a left $\mathscr{B}$-module category $\mathscr{M}$ is said to be indecomposable if it is not a direct sum of two nonzero module categories, and exact if $P \otimes M$ is projective in $\mathscr{M}$, for every $P \in \operatorname{Pr}(\mathscr{B})$ and $M \in \mathscr{M}$.

Let $\mathscr{M}$ be an indecomposable exact $\mathscr{B}$-module category ${ }^{11}$ (such a category is always finite [EO1, Lemma 3.4]). Let $\operatorname{End}(\mathscr{M})$ be the abelian category of right exact endofunctors of $\mathscr{M}$, and let $\mathscr{B}_{\mathscr{M}}^{*}:=\operatorname{End}_{\mathscr{B}}(\mathscr{M})$ be the dual category of $\mathscr{B}$ with respect to $\mathscr{M}$, i.e., the category of $\mathscr{B}$ linear (necessarily exact) endofunctors of $\mathscr{M}$. Recall that composition of functors turns $\operatorname{End}(\mathscr{M})$ into a monoidal category, and $\mathscr{B}_{\mathscr{M}}^{*}$ into a finite tensor category.

Let $A$ be an algebra object in $\mathscr{B}$, and let $\mathscr{M}:=\operatorname{Mod}(A)_{\mathscr{B}}$ denote the category of right $A$-modules in $\mathscr{B}$. Recall that $\mathscr{M}$ has a natural structure of a left $\mathscr{B}$-module category, and $A$ is called exact if $\mathscr{M}$ is indecomposable and exact over $\mathscr{B}$ (see [EGNO, Section 7.5]). Recall [EGNO, Proposition 7.11.6] that in this case, $\mathscr{B}_{\mathscr{M}}^{*} \cong \operatorname{Bimod}_{\mathscr{B}}(A)^{\mathrm{op}}$ is a finite tensor category $\left(\right.$ where $\operatorname{Bimod}_{\mathscr{B}}(A)^{\text {op }}$ is $\operatorname{Bimod}_{\mathscr{B}}(A)$ equipped with the opposite tensor product).

The following result will be crucial for us.
Theorem 2.1. [EO2, Corollary 12.4] If $\mathscr{C}$ is a tensor subcategory of $\mathscr{B}$, and $A$ is an exact algebra in $\mathscr{C}$, then $A$ is an exact algebra in $\mathscr{B}$.

Let $\mathscr{M}$ be an exact indecomposable module category over $\mathscr{B}$. Fix a nonzero object $M \in \mathscr{M}$, and let $A:=\operatorname{End}_{\mathscr{B}}(M)$ be the internal Hom from $M$ to $M$ in the $\mathscr{B}$-module category $\mathscr{M}$. Recall that $A$ is an exact algebra in $\mathscr{B}$, and there is a canonical equivalence of $\mathscr{B}$-module categories $\mathscr{M} \cong \operatorname{Mod}(A)_{\mathscr{B}}$ (see, e.g., [EGNO, Theorem 7.10.1]).
2.3. Exact sequences of finite tensor categories. Let $\mathscr{A}, \mathscr{B}$ and $\mathscr{C}$ be finite tensor categories, and let $\iota: \mathscr{A} \xrightarrow{1: 1} \mathscr{B}$ be an injective tensor functor. Let $\mathscr{M}$ be an indecomposable exact module category over $\mathscr{A}$, fix a nonzero object $M \in \mathscr{M}$, and consider the algebrta $A:=\operatorname{End}_{\mathscr{A}}(M)$ (see 2.1, (2.2). We have $\mathscr{M}=\operatorname{Mod}(A)_{\mathscr{A}}$, and $\mathscr{B} \boxtimes_{\mathscr{A}} \mathscr{M}=\operatorname{Mod}(A)_{\mathscr{B}}$.

Let $F: \mathscr{B} \rightarrow \mathscr{C} \boxtimes \operatorname{End}(\mathscr{M})$ be a surjective $\mathbb{Z}^{2}$ monoidal functor, such that $\iota(\mathscr{A}) \subset \mathscr{B}$ is the subcategory consisting of all objects $X \in \mathscr{B}$ such that $F(X) \in \operatorname{End}(\mathscr{M})$. Recall [EG1] that $F$ defines an exact sequence of tensor categories

$$
\begin{equation*}
\mathscr{A} \xrightarrow{\iota} \mathscr{B} \xrightarrow{F} \mathscr{C} \boxtimes \operatorname{End}(\mathscr{M}) \tag{2.1}
\end{equation*}
$$

[^0]with respect to $\mathscr{M}$, if for every object $X \in \mathscr{B}$ there exists a subobject $X_{0} \subset X$ such that $F\left(X_{0}\right)$ is the largest subobject of $F(X)$ contained in $\operatorname{End}(\mathscr{M}) \subset \mathscr{C} \boxtimes \operatorname{End}(\mathscr{M})$. Recall [EG1, Theorem 2.9] that the functor $F$ induces on $\mathscr{C} \boxtimes \mathscr{M}$ a structure of an exact $\mathscr{B}$-module category.

Theorem 2.2. [EG1, Theorems 3.4, 3.6] The following are equivalent:
(1) (2.1) defines an exact sequence of finite tensor categories.
(2) $\operatorname{FPdim}(\mathscr{B})=\operatorname{FPdim}(\mathscr{A}) \operatorname{FPdim}(\mathscr{C})$.
(3) The natural functor $T: \mathscr{B} \boxtimes_{\mathscr{A}} \mathscr{M} \rightarrow \mathscr{C} \boxtimes \mathscr{M}$, given by
$\mathscr{B} \boxtimes_{\mathscr{A}} \mathscr{M} \xrightarrow{F \boxtimes_{\mathscr{A}} \mathrm{Id} \mathscr{M}^{\prime}} \mathscr{C} \boxtimes \operatorname{End}(\mathscr{M}) \boxtimes_{\mathscr{A}} \mathscr{M}=\mathscr{C} \boxtimes \mathscr{M} \boxtimes \mathscr{A}_{\mathscr{M}}^{* \mathrm{op}} \xrightarrow{\mathrm{Id}_{\mathscr{C}} \boxtimes \rho} \mathscr{C} \boxtimes \mathscr{M}$, is an equivalence (where $\rho: \mathscr{M} \boxtimes \mathscr{A}_{\mathscr{M}}^{* \mathrm{op}} \rightarrow \mathscr{M}$ is the right action of $\mathscr{A}_{\mathscr{M}}^{* o p}$ on $\left.\mathscr{M}\right)$.
Let $\mathscr{N}$ be an indecomposable exact module category over $\mathscr{C}$. Then $\mathscr{N} \boxtimes \mathscr{M}$ is an exact module category over $\mathscr{C} \boxtimes \operatorname{End}(\mathscr{M})$, and we have $(\mathscr{C} \boxtimes \operatorname{End}(\mathscr{M}))_{\mathcal{N} \boxtimes \mathscr{M}}^{*} \cong \mathscr{C}_{\mathscr{N}}^{*}$. By [EG1, Theorem 4.1], the dual sequence to (2.1) with respect to $\mathscr{N} \boxtimes \mathscr{M}$

$$
\begin{equation*}
\mathscr{A}_{\mathscr{M}}^{*} \boxtimes \operatorname{End}(\mathscr{N}) \stackrel{\iota^{*}}{\leftarrow} \mathscr{B}_{\mathcal{N} \boxtimes \mathscr{M}}^{*} \stackrel{F^{*}}{\leftarrow} \mathscr{C}_{\mathscr{N}}^{*} \tag{2.2}
\end{equation*}
$$

is exact with respect to $\mathscr{N}$.
2.4. Lagrangian subcategories. Let $\mathscr{D}$ be a finite braided tensor category with braiding c (see, e.g., [EGNO, Chapter 8]), and let $\mathscr{E} \subset \mathscr{D}$ be a tensor subcategory of $\mathscr{D}$. Recall that two objects $X, Y \in \mathscr{D}$ centralize each other if

$$
\begin{equation*}
\mathrm{c}_{Y, X} \circ \mathrm{c}_{X, Y}=\mathrm{Id}_{X \otimes Y}, \tag{2.3}
\end{equation*}
$$

and the (Müger) centralizer of $\mathscr{E}$ is the tensor subcategory $\mathscr{E}^{\prime} \subset \mathscr{D}$ consisting of all objects which centralize every object of $\mathscr{E}$ (see, e.g., [DGNO1]). The category $\mathscr{D}$ is called non-degenerate if $\mathscr{D}^{\prime}=$ Vec.

By [S, Theorem 4.9], we have

$$
\begin{equation*}
\mathrm{FPdim}(\mathscr{E}) \mathrm{FP} \operatorname{dim}\left(\mathscr{E}^{\prime}\right)=\mathrm{FPdim}(\mathscr{D}) \mathrm{FP} \operatorname{dim}\left(\mathscr{D}^{\prime} \cap \mathscr{E}\right) \tag{2.4}
\end{equation*}
$$

If $\mathscr{D}$ is non-degenerate and $\mathscr{E}^{\prime}=\mathscr{E}$, then $\mathscr{E}$ is called a Lagrangian subcategory of $\mathscr{D}$. Thus, a Lagrangian subcategory of $\mathscr{D}$ is a maximal symmetric tensor subcategory of $\mathscr{D}$.
2.5. Exact commutative algebras. Retain the notation from 2.4. Let $A$ be an exact algebra in $\mathscr{D}$ (see 2.2), with multiplication and unit morphisms $\mathrm{m}_{A}$ and $u_{A}$, respectively. Recall that $A$ is commutative if $\mathrm{m}_{A}=\mathrm{m}_{A} \circ \mathrm{c}_{A, A}$.

Assume from now on that $A$ is an exact commutative algebra in $\mathscr{D}$. Consider the category $\mathscr{C}:=\operatorname{Mod}(A)_{\mathscr{D}}\left(\right.$ see 2.2). Let $\left(X, \mathrm{~m}_{X}\right) \in \mathscr{C}$,
where $X \in \mathscr{D}$ and $\mathrm{m}_{X}: X \otimes A \rightarrow X$ is the $A$-module structure morphism. Recall that the braiding on $\mathscr{D}$ defines on $X$ two structures of a left $A$-module as follows:

$$
A \otimes X \xrightarrow{\mathrm{c}_{A, X}} X \otimes A \xrightarrow{\mathrm{~m}_{X}} X, \quad A \otimes X \xrightarrow{\mathrm{c}_{X, A}^{-1}} X \otimes A \xrightarrow{\mathrm{~m}_{X}} X .
$$

Both structures make ( $X, \mathrm{~m}_{X}$ ) into an $A$-bimodule, denoted by $X_{+}$and $X_{-}$, respectively. By identifying $\mathscr{C}$ with a subcategory of the finite tensor category $\operatorname{Bimod}_{\mathscr{D}}(A)$ (see 2.2) via the full embedding functor

$$
\mathscr{C} \xrightarrow{1: 1} \operatorname{Bimod}_{\mathscr{D}}(A), \quad\left(X, \mathrm{~m}_{X}\right) \mapsto X_{-},
$$

(see [EGNO, Section 8.8]), we see that $\mathscr{C}$ is a finite tensor category, with the tensor product $\otimes_{A}$. Namely, the tensor product of $X, Y \in \mathscr{C}$, denoted by $X \otimes_{A} Y$, is given by $X \otimes_{A} Y_{-}$endowed with the structure $\operatorname{map} \operatorname{Id}_{X} \otimes \mathrm{~m}_{Y}: X \otimes_{A} Y_{-} \otimes A \rightarrow X \otimes_{A} Y_{-}$.

Now let

$$
\begin{equation*}
F: \mathscr{D} \rightarrow \mathscr{C}, \quad X \mapsto\left(X \otimes A, \operatorname{Id}_{X} \otimes \mathrm{~m}_{A}\right) \tag{2.5}
\end{equation*}
$$

be the free $A$-module functor, and let

$$
\begin{equation*}
I: \mathscr{C} \rightarrow \mathscr{D}, \quad\left(X, \mathrm{~m}_{X}\right) \mapsto X \tag{2.6}
\end{equation*}
$$

be the forgetful functor. Recall that $F, I$ are adjoint functors EGNO, Lemma 7.8.12], i.e., we have natural isomorphisms

$$
\operatorname{Hom}_{\mathscr{C}}(F(X), Y) \cong \operatorname{Hom}_{\mathscr{D}}(X, I(Y)), \quad X \in \mathscr{D}, Y \in \mathscr{C}
$$

Recall that $F$ is a surjective tensor functor [EGNO], with tensor structure $J=\left\{J_{X, Y} \mid X, Y \in \mathscr{D}\right\}$, where

$$
J_{X, Y}: F(X \otimes Y) \stackrel{\cong}{\rightrightarrows} F(X) \otimes_{A} F(Y)
$$

is the $\mathscr{C}$-isomorphism given by the composition

$$
\begin{equation*}
X \otimes Y \otimes A \xrightarrow{\mathrm{Id}_{X} \otimes u_{A} \otimes \mathrm{Id}_{A}} X \otimes A \otimes_{A} Y \otimes A \tag{2.7}
\end{equation*}
$$

Lemma 2.3. We have $\operatorname{FPdim}(\mathscr{C})=\operatorname{FPdim}(\mathscr{D}) / \operatorname{FPdim}(A)$.
Proof. Follows from EGNO, Lemma 6.2.4].
2.6. Finite group schemes. (See, e.g., W .) Let $G$ be a finite group scheme over $k$, with coordinate algebra $\mathscr{O}(G)$. Then $\mathscr{O}(G)$ is a finite dimensional commutative Hopf algebra, and its representation category $\operatorname{Coh}(G)$ is a finite tensor category over $k$.

We will denote the dimension of $\mathscr{O}(G)$ by $|G|$.
Let $\operatorname{Rep}(G)=\operatorname{Corep}(\mathscr{O}(\mathrm{G}))$ denote the representation category of $G$ over $k$. Recall that $\operatorname{Rep}(G)$ is a finite Tannakian category, that
is, a finite symmetric tensor category such that the forgetful functor $\operatorname{Rep}(G) \rightarrow$ Vec is symmetric.

Set $\mathscr{E}:=\operatorname{Rep}(G)$. Let I $: \mathscr{E} \rightarrow \mathscr{E} \boxtimes \mathscr{E}$ be the adjoint functor of the tensor functor $\mathscr{E} \boxtimes \mathscr{E} \xrightarrow{\otimes} \mathscr{E}$. Recall that $\mathrm{I}(\mathbf{1})$ is an exact commutative algebra in $\mathscr{E} \boxtimes \mathscr{E}$, and $\mathscr{E} \cong \operatorname{Mod}(\mathrm{I}(\mathbf{1}))_{\mathscr{E} \boxtimes \mathscr{E}}$.

Let $\Delta: G \xrightarrow{1: 1} G \times G$ be the diagonal morphism.
Lemma 2.4. We have $\mathrm{I}(\mathbf{1})=\mathscr{O}(G \times G / \Delta(G))$.
Proof. Since the tensor functor $\mathscr{E} \boxtimes \mathscr{E} \xrightarrow{\otimes} \mathscr{E}$ coincides with the functor

$$
\mathscr{E} \boxtimes \mathscr{E}=\operatorname{Rep}(G \times G) \xrightarrow{\Delta^{*}} \operatorname{Rep}(G)=\mathscr{E},
$$

the claim follows.
2.7. De-equivariantization. Retain the notation of 2.4 [2.6. Assume $\mathscr{D}$ contains $\mathscr{E}:=\operatorname{Rep}(G)$ as a Tannakian subcategory.

Let $A:=\mathscr{O}(G)$. The group scheme $G$ acts on $A$ via left translations, making $A$ a commutative algebra in $\mathscr{E}$. Thus, $A$ is a commutative algebra in $\mathscr{D}$, with $\operatorname{FPdim}(A)=|G|$.

Recall that $\operatorname{Mod}(A)_{\mathscr{E}}$ is equivalent to the standard $\mathscr{E}$-module category Vec. Thus, $\operatorname{Mod}(A)_{\mathscr{E}}$ is exact, so $A$ is exact in $\mathscr{E}$. Thus by Theorem [2.1, $A$ is exact in $\mathscr{D}$, so $\mathscr{C}:=\operatorname{Mod}(A)_{\mathscr{D}}$ and $\mathscr{D}_{\mathscr{C}}^{*}=\operatorname{Bimod}_{\mathscr{D}}(A)^{\mathrm{op}}$ are finite tensor categories (see 2.2).

Let $\mathscr{C}^{0}=\operatorname{Mod}^{0}(A)_{\mathscr{D}}$ denote the subcategory of $\mathscr{C}$ consisting of all objects $\left(X, \mathrm{~m}_{X}\right)$ such that $\mathrm{m}_{X}=\mathrm{m}_{X} \circ \mathrm{c}_{A, X} \circ \mathrm{c}_{X, A}$ (i.e., dyslectic, or local, $A$-modules). Recall that $\mathscr{C}^{0}$ is a tensor subcategory of $\mathscr{C}$, which is moreover braided with the braiding inhereted from $\mathscr{D}$.
2.8. The categories $\operatorname{Coh}(G, \omega)$ and $\mathscr{Z}(\operatorname{Coh}(G, \omega))$. Retain the notation of [2.6, and let $\omega \in H^{3}\left(G, \mathbb{G}_{m}\right)$ be a normalized 3-cocycle. That is, $\omega \in \mathscr{O}(G)^{\otimes 3}$ is an invertible element satisfying the equations

$$
\begin{gathered}
(\operatorname{Id} \otimes \operatorname{Id} \otimes \Delta)(\omega)(\Delta \otimes \operatorname{Id} \otimes \operatorname{Id})(\omega)=(1 \otimes \omega)(\operatorname{Id} \otimes \Delta \otimes \operatorname{Id})(\omega)(\omega \otimes 1) \\
\quad(\varepsilon \otimes \operatorname{Id} \otimes \operatorname{Id})(\omega)=(\operatorname{Id} \otimes \varepsilon \otimes \operatorname{Id})(\omega)=(\operatorname{Id} \otimes \operatorname{Id} \otimes \varepsilon)(\omega)=1
\end{gathered}
$$

Recall [G, Section 5] that the category $\operatorname{Coh}(G, \omega)$ is just $\operatorname{Coh}(G)$ as abelian categories, equipped with the same tensor product, but with associativity constraint given by the action of $\omega$. Then $\operatorname{Coh}(G, \omega)$ is a finite pointed (i.e., every simple object is invertible) tensor category, and the group of its invertible objects is isomorphic to $G(k)$.

Let $\mathscr{Z}(\operatorname{Coh}(G, \omega))$ denote the center of $\operatorname{Coh}(G, \omega)$ (see, e.g., [EGNO], [G, Section 5]). By [S, Theorem 4.2], $\mathscr{Z}(\operatorname{Coh}(G, \omega))$ is a finite nondegenerate braided tensor category (see 2.4). Recall moreover that
$\mathscr{Z}(\operatorname{Coh}(G, \omega)) \cong \operatorname{Rep}\left(D^{\omega}(G)\right)$ as braided tensor categories, where $D^{\omega}(G)$ is a quasi-Hopf algebra, called the twisted double of $G$.

Note that for every $\omega_{1}, \omega_{2} \in H^{3}\left(G, \mathbb{G}_{m}\right)$, we have

$$
\begin{equation*}
\mathscr{Z}\left(\operatorname{Coh}\left(G, \omega_{1}\right)\right) \boxtimes \mathscr{Z}\left(\operatorname{Coh}\left(G, \omega_{2}\right)\right) \cong \mathscr{Z}\left(\operatorname{Coh}\left(G \times G, \omega_{1} \times \omega_{2}\right)\right) \tag{2.8}
\end{equation*}
$$

as braided tensor categories.
Let

$$
\mathcal{F}: \mathscr{Z}(\operatorname{Coh}(G, \omega)) \rightarrow \operatorname{Coh}(G, \omega)
$$

be the forgetful functor. The following lemma is well known.
Lemma 2.5. The tensor subcategory of $\mathscr{Z}(\operatorname{Coh}(G, \omega))$ consisting of all objects mapped to Vec under $\mathcal{F}$ is tensor equivalent to $\operatorname{Rep}(G)$. Thus, $\mathscr{Z}(\operatorname{Coh}(G, \omega))$ canonically contains $\operatorname{Rep}(G)$ as a Tannakian Lagrangian subcategory.

Now let

$$
\mathcal{I}: \operatorname{Coh}(G, \omega) \rightarrow \mathscr{Z}(\operatorname{Coh}(G, \omega))
$$

be the adjoint functor of $\mathcal{F}$.
Lemma 2.6. The following hold:
(1) $\mathcal{I}(\mathbf{1})=\mathscr{O}(G)$ as objects of $\operatorname{Rep}(G)$.
(2) $\mathcal{I}(\mathbf{1})=\mathscr{O}(G)$ is an exact commutative algebra in $\mathscr{Z}(\operatorname{Coh}(G, \omega))$.
(3) $\mathcal{I}$ induces a tensor equivalence

$$
\mathcal{I}: \operatorname{Coh}(G, \omega) \xrightarrow{\cong} \operatorname{Mod}(\mathscr{O}(G))_{\mathscr{L}(\operatorname{Coh}(G, \omega))} .
$$

(4) $\mathcal{I} \circ \mathcal{F}$ coincides with the free $\mathscr{O}(G)$-module functor

$$
F: \mathscr{Z}(\operatorname{Coh}(G, \omega)) \rightarrow \operatorname{Mod}(\mathscr{O}(G))_{\mathscr{L}(\operatorname{Coh}(G, \omega))}, \quad X \mapsto X \otimes \mathscr{O}(G) .
$$

Proof. (1) is clear, and since $\mathscr{O}(G)$ is an exact commutative algebra in $\operatorname{Rep}(G)$ (see 2.7), (2) follows from Theorem [2.1. The proof of (3), (4) is now similar to [EGNO, Lemma 8.12.2].
2.9. The group $\mathcal{M}_{\text {ext }}(\operatorname{Rep}(G))$. Fix a finite group scheme $G$ over $k$. Set $\mathscr{E}:=\operatorname{Rep}(G)$, and let $\mathrm{I}(\mathbf{1}) \in \mathscr{E} \boxtimes \mathscr{E}$ be as in Lemma 2.4.

Consider the set of pairs $(\mathscr{D}, \iota)$, where $\mathscr{D}$ is a non-degenerate braided tensor category over $k$, and $\iota: \mathscr{E} \xrightarrow{1: 1} \mathscr{D}$ is an injective braided tensor functor. We say that $\left(\mathscr{D}_{1}, \iota_{1}\right),\left(\mathscr{D}_{2}, \iota_{2}\right)$ are equivalent, if there exists a braided tensor equivalence $\psi: \mathscr{D}_{1} \xrightarrow{\cong} \mathscr{D}_{2}$ such that $\psi \circ \iota_{1}=\iota_{2}$. Let $\mathcal{M}_{\text {ext }}(\mathscr{E})$ denote the set of all equivalence classes of pairs $(\mathscr{D}, \iota)$.

Now for $\left(\mathscr{D}_{1}, \iota_{1}\right),\left(\mathscr{D}_{2}, \iota_{2}\right)$ in $\mathcal{M}_{\text {ext }}(\mathscr{E})$, let $B:=\left(\iota_{1} \boxtimes \iota_{2}\right)(\mathrm{I}(\mathbf{1}))$. Then $B$ is an exact commutative algebra in $\mathscr{D}_{1} \boxtimes \mathscr{D}_{2}$. Consider the braided
tensor category $\mathscr{D}:=\operatorname{Mod}^{0}(B)_{\mathscr{1}_{1} \boxtimes \mathscr{O}_{2}}($ see 2.7), and let $\iota: \mathscr{E} \xrightarrow{1: 1} \mathscr{D}$ be the injective functor

$$
\mathscr{E}=\operatorname{Mod}(I(\mathbf{1}))_{\mathscr{E} \boxtimes \mathscr{E}} \xrightarrow{\iota_{1} \boxtimes \iota_{2}} \operatorname{Mod}^{0}(B)_{\mathscr{O}_{1} \boxtimes \mathscr{D}_{2}}=\mathscr{D} .
$$

Recall [LKW] that the product rule

$$
\left(\mathscr{D}_{1}, \iota_{1}\right) \widetilde{\boxtimes}\left(\mathscr{D}_{2}, \iota_{2}\right)=(\mathscr{D}, \iota)
$$

determines a commutative group structure on $\mathcal{M}_{\text {ext }}(\mathscr{E})$, with unit element $\left(\mathscr{Z}(\operatorname{Coh}(G)), \iota_{0}\right)$, where $\iota_{0}: \mathscr{E} \rightarrow \mathscr{Z}(\operatorname{Coh}(G))$ is the inclusion functor (see Lemma 2.5).

## 3. The proof of Theorem 1.1

Let $G$ be a finite $k$-group scheme, and let $\mathscr{E}:=\operatorname{Rep}(G)$ (see 2.6).
Let $\mathscr{D}$ be a finite non-degenerate braided tensor category over $k$, containing $\mathscr{E}$ as a Lagrangian Tannakian subcategory (see 2.4). By (2.4), we have $\operatorname{FPdim}(\mathscr{D})=|G|^{2}$ (see 2.1).
3.1. The free module functor $F$. Let $A:=\mathscr{O}(G)$, and consider the $G$-de-equivariantization category $\mathscr{C}:=\operatorname{Mod}(A)_{\mathscr{D}}($ see 2.7). Since $A$ is exact in $\mathscr{D}, \mathscr{C}$ is a finite tensor category. By Lemma 2.3, we have

$$
\begin{equation*}
\operatorname{FPdim}(\mathscr{C})=\mathrm{FPdim}(\mathscr{D}) / \mathrm{FPdim}(A)=|G|^{2} /|G|=|G| \tag{3.1}
\end{equation*}
$$

Let $F: \mathscr{D} \rightarrow \mathscr{C}$ be the free $A$-module functor (2.5), and let $\mathscr{E} \xrightarrow{\iota} \mathscr{D}$ be the inclusion functor.

## Proposition 3.1. We have an exact sequence of tensor categories

$$
\begin{equation*}
\mathscr{E} \xrightarrow{\iota} \mathscr{D} \xrightarrow{F} \mathscr{C} \tag{3.2}
\end{equation*}
$$

with respect to the standard $\mathscr{E}$-module category $\operatorname{Vec}$ (see 2.3).
Proof. For every $\mathbf{V}=(V, \rho) \in \mathscr{E}$, we have $\mathbf{V} \otimes A \cong V \otimes A$ in $\mathscr{E}$. Thus, $F(\mathbf{V}) \cong V \otimes A$ lies in $\operatorname{Vec} \subset \mathscr{C}$ (as $A$ is the unit object of $\mathscr{C})$, so $F$ maps $\mathscr{E}$ to Vec. Since by (3.1), $\operatorname{FPdim}(\mathscr{D})=\operatorname{FPdim}(\mathscr{E}) \operatorname{FPdim}(\mathscr{C})$, the claim follows from Theorem 2.2.

Recall that $\mathscr{C}_{\mathscr{C}}^{*} \cong \mathscr{C}^{\text {op }}$ as tensor categories. Thus, dualizing (3.2) with respect to the exact indecomposable $\mathscr{D}$-module category $\mathscr{C}$ EG1, Theorem 4.1] (see (2.21)), we obtain an exact sequence

$$
\mathscr{C}^{\mathrm{op}} \xrightarrow{F^{*}} \mathscr{D}_{\mathscr{C}}^{*} \xrightarrow{\iota^{*}} \mathscr{E}_{\mathrm{Vec}}^{*} \boxtimes \operatorname{End}(\mathscr{C})
$$

of finite tensor categories with respect to the indecomposable exact $\mathscr{C}{ }^{\text {op }}$-module category $\mathscr{C}$. Since $\operatorname{End}(\mathscr{C}) \cong \operatorname{End}(\mathscr{C})^{\text {op }}$ as monoidal categories, and $\left(\mathscr{E}_{\text {Vec }}^{*}\right)^{\text {op }}=\mathscr{E}_{\text {Vec }}^{*} \cong \operatorname{Coh}(G)$ as tensor categories (see, e.g.,
[EGNO, Example 7.9.11]), we get an exact sequence

$$
\begin{equation*}
\mathscr{C} \xrightarrow{F^{*}} \mathscr{D}_{\mathscr{C}}^{* o p} \xrightarrow{\iota^{*}} \operatorname{Coh}(G) \boxtimes \operatorname{End}(\mathscr{C}) \tag{3.3}
\end{equation*}
$$

of finite tensor categories with respect to the indecomposable exact $\mathscr{C}$ module category $\mathscr{C}$. In particular, $\mathscr{C}$ can be identified with a tensor subcategory of $\mathscr{D}_{\mathscr{C}}^{* \mathrm{op}}$ via $F^{*}$. Also, since $\mathscr{D}_{\mathscr{C}}^{* o \mathrm{p}} \cong \operatorname{Bimod}_{\mathscr{D}}(A)$ as tensor categories (see [2.2), $\mathscr{D}_{\mathscr{C}}^{* o p}$ contains $\operatorname{Coh}(G)=\mathscr{E}_{\text {Vec }}^{*}=\operatorname{Bimod}_{\mathscr{E}}(A)$ as a tensor subcategory.

Lemma 3.2. We have an equivalence of abelian categories

$$
\Psi: \mathscr{D}_{\mathscr{C}}^{* o p} \xlongequal{\cong} \operatorname{Coh}(G) \boxtimes \mathscr{C}
$$

such that

$$
\Psi(X \otimes Y)=X \boxtimes Y, \quad X \in \operatorname{Coh}(G), Y \in \mathscr{C}
$$

In particular, $P_{\mathscr{D}_{\mathscr{G}}^{*}}(\mathbf{1})=P_{\operatorname{Coh}(G)}(\mathbf{1}) \otimes P_{\mathscr{C}}(\mathbf{1})$.
Proof. Applying Theorem [2.2(3) to the exact sequence (3.3) provides the natural equivalence of abelian categories

$$
T: \mathscr{D}_{\mathscr{C}}^{* o \mathrm{p}} \boxtimes_{\mathscr{C}} \mathscr{C} \cong \operatorname{Coh}(G) \boxtimes \mathscr{C},
$$

and it is straightforward to verify that composing the natural equivalence $\mathscr{D}_{\mathscr{C}}^{* o p} \xrightarrow{\cong} \mathscr{D}_{\mathscr{C}}^{* o p} \boxtimes_{\mathscr{C}} \mathscr{C}$ with $T$ yields an abelian equivalence $\Psi$ with the stated property, as claimed.

In particular, it follows from the above that for every simple objects $X \in \operatorname{Coh}(G)$ and $Y \in \mathscr{C}$, the object $X \otimes Y$ is simple in $\mathscr{D}_{\mathscr{C}}^{* o p}$, and that every simple object in $\mathscr{D}_{\mathscr{C}}^{* * p}$ is of this form. Furthermore, since $P_{\operatorname{Coh}(G)}(X) \boxtimes P_{\mathscr{C}}(Y)$ is the projective cover of $X \boxtimes Y$ in $\operatorname{Coh}(G) \boxtimes \mathscr{C}$, and

$$
\Psi\left(P_{\operatorname{Coh}(G)}(X) \otimes P_{\mathscr{C}}(Y)\right)=P_{\operatorname{Coh}(G)}(X) \boxtimes P_{\mathscr{C}}(Y),
$$

it follows that $P_{\operatorname{Coh}(G)}(X) \otimes P_{\mathscr{C}}(Y)$ is the projective cover of $X \otimes Y$ in $\mathscr{D}_{\mathscr{C}}^{* o p}$. Thus, we get the last statement for $X=Y=1$.
3.2. The central structure on $F$. For every $X \in \mathscr{D},\left(Y, \mathrm{~m}_{Y}\right) \in \mathscr{C}$, consider the morphism

$$
\begin{equation*}
\Phi_{X, Y}: F(X) \otimes_{A} Y \cong Y \otimes_{A} F(X) \tag{3.4}
\end{equation*}
$$

given by the composition

$$
\begin{aligned}
& F(X) \otimes_{A} Y=(X \otimes A) \otimes_{A} Y \xrightarrow{\operatorname{Id}_{X} \otimes\left(\mathrm{~m}_{Y} \circ c_{Y, A}^{-1}\right)} X \otimes Y \\
& \quad \xrightarrow{\mathrm{cc}_{X, Y}} Y \otimes X \xrightarrow{\mathrm{Id}_{Y} \otimes u_{A} \otimes \operatorname{Id}_{X}} Y \otimes A \otimes X \xrightarrow{\mathrm{Id}_{Y} \otimes c_{A, X}} Y \otimes(X \otimes A) \\
& \quad \rightarrow \otimes_{A} F(X) .
\end{aligned}
$$

Using that $A$ is commutative, the following lemma can be verified in a straightforward manner.

Lemma 3.3. The following hold:
(1) $\left\{\Phi_{X, Y} \mid X \in \mathscr{D}, Y \in \mathscr{C}\right\}$ is a natural family of $\mathscr{C}$-isomorphisms.
(2) For every $X, Z \in \mathscr{D}$ and $Y \in \mathscr{C}$, we have
$\Phi_{X \otimes Z, Y}=\left(\operatorname{Id}_{Y} \otimes J_{X, Z}^{-1}\right) \circ\left(\Phi_{X, Y} \otimes \operatorname{Id}_{F(Z)}\right) \circ\left(\operatorname{Id}_{F(X)} \otimes \Phi_{Z, Y}\right) \circ\left(J_{X, Z} \otimes \operatorname{Id}_{Y}\right)$
(see 2.7)).
(3) For every $X \in \mathscr{D}$ and $Y, Z \in \mathscr{C}$, we have
$\Phi_{X, Y \otimes_{A} Z}=\left(\operatorname{Id}_{Y} \otimes \Phi_{X, Z}\right) \circ\left(\Phi_{X, Y} \otimes \operatorname{Id}_{Z}\right)$.
In particular, Lemma 3.3 implies the following corollary.
Corollary 3.4. The free $A$-module functor $F$ (2.5) extends to a braided tensor functor

$$
\begin{equation*}
\mathrm{F}: \mathscr{D} \rightarrow \mathscr{Z}(\mathscr{C}) \tag{3.5}
\end{equation*}
$$

such that $F$ coincides with the composition of F and the forgetful tensor functor $\mathscr{Z}(\mathscr{C}) \rightarrow \mathscr{C}$.

Recall that $\mathscr{C}$ is an indecomposable exact module category over $\mathscr{Z}(\mathscr{C})$ via the forgetful functor $\mathscr{Z}(\mathscr{C}) \rightarrow \mathscr{C}$, and $\mathscr{Z}(\mathscr{C})_{\mathscr{C}}^{*} \cong \mathscr{C} \boxtimes \mathscr{C}^{\text {op }}$ as tensor categories (see, e.g., [EGNO, Theorem 7.16.1]).

Recall that since $\mathscr{D}$ is non-degenerate, $\mathscr{D} \boxtimes \mathscr{D}^{\mathrm{op}} \cong \mathscr{Z}(\mathscr{D})$ as braided tensor categories. Recall also, that $\mathscr{Z}(\mathscr{D}) \cong \mathscr{Z}\left(\mathscr{D}_{\mathscr{C}}^{*}\right)$ as braided tensor categories [EGNO, Corollary 7.16.2].

Proposition 3.5. [DGNO1, Proposition 4.2] The functor F (3.5) is an equivalence of braided tensor categories.

Proof. Consider $\mathscr{C}$ as a module category over $\mathscr{D}$ and $\mathscr{Z}(\mathscr{C})$ via $F$ and the forgetful functor $\mathscr{Z}(\mathscr{C}) \rightarrow \mathscr{C}$, respectively. In both cases, $\mathscr{C}$ is indecomposable and exact. Let

$$
\begin{equation*}
\mathrm{F}^{*}: \mathscr{C} \boxtimes \mathscr{C}^{\mathrm{op}} \rightarrow \mathscr{D}_{\mathscr{C}}^{*} \tag{3.6}
\end{equation*}
$$

be the dual functor to F . Recall that $\mathscr{D}_{\mathscr{C}}^{*} \cong \operatorname{Bimod}_{\mathscr{D}}(A)^{\mathrm{op}}$ as tensor categories (see 2.2). Then it is straightforward to verify that we have

$$
\begin{equation*}
\mathrm{F}^{*}(X \boxtimes Y)=X_{+} \otimes_{A} Y_{-}, \quad X, Y \in \mathscr{C} \tag{3.7}
\end{equation*}
$$

(see 2.5).
In particular, we see that the functor

$$
\mathscr{D} \boxtimes \mathscr{D}^{\mathrm{op}} \xrightarrow{F \boxtimes F} \mathscr{C} \boxtimes \mathscr{C}^{\mathrm{op}} \xrightarrow{\mathrm{~F}^{*}} \mathscr{D}_{\mathscr{C}}^{*}=\operatorname{Bimod}_{\mathscr{D}}(A)^{\mathrm{op}}
$$

coincides with the functor

$$
\mathscr{D} \boxtimes \mathscr{D}^{\mathrm{op}} \cong \mathscr{Z}(\mathscr{D}) \cong \mathscr{Z}\left(\mathscr{D}_{\mathscr{C}}^{*}\right) \rightarrow \mathscr{D}_{\mathscr{C}}^{*} .
$$

Since the forgetful functor $\mathscr{Z}\left(\mathscr{D}_{\mathscr{C}}^{*}\right) \rightarrow \mathscr{D}_{\mathscr{C}}^{*}$ is surjective, we see that the functor $\mathrm{F}^{*}$ is surjective. Thus, F is injective [EGNO, Theorem 7.17.4].

Finally, since F is an injective tensor functor between categories of equal Frobenius-Perron dimension (see (3.1)), it is necessarily an equivalence [EGNO, Proposition 6.3.4], as claimed.

Following Proposition 3.5, we now aim to prove that there exists $\omega \in H^{3}\left(G, \mathbb{G}_{m}\right)$ such that $\mathscr{C} \cong \operatorname{Coh}(G, \omega)$ as tensor categories.
3.3. $\mathcal{O}(\mathscr{C})=G(k)$. In this section we show that $\mathscr{C}$ is pointed, and its group of invertible objects is isomorphic to $G(k)$.

Recall that $\operatorname{Bimod}_{\mathscr{E}}(A)=\mathscr{E}_{\text {Vec }}^{*} \cong \operatorname{Coh}(G)$ as tensor categories, and $\mathcal{O}(\operatorname{Coh}(G)) \cong G(k)$. Let $A_{g}, g \in G(k)$, with $A_{e}=A=1$, denote the invertible objects of $\operatorname{Coh}(G)=\operatorname{Bimod}_{\mathscr{E}}(A) \subset \operatorname{Bimod}_{\mathscr{D}}(A)$. Namely, $A_{g}=A$ as right $A$-modules, and the left $A$-action is determined by $g \in G(k)$.

Let $G(\mathscr{C})$ denote the group of invertible objects of $\mathscr{C}$.
Proposition 3.6. The following hold:
(1) The category $\mathscr{C}$ is pointed (i.e., $\mathcal{O}(\mathscr{C})=G(\mathscr{C})$ ).
(2) For every $X \in G(\mathscr{C})$, we have

$$
\operatorname{FPdim}_{\mathscr{C}}\left(P_{\mathscr{C}}(X)\right)=\operatorname{FPdim}_{\operatorname{Coh}(G)}\left(P_{\operatorname{Coh}(G)}(\mathbf{1})\right)
$$

(See 2.1.)
(3) The tensor equivalence $\mathrm{F}^{*}$ (3.6) induces a group isomorphism

$$
G(k) \stackrel{\cong}{\rightrightarrows} G(\mathscr{C}), \quad g \mapsto X_{g} .
$$

(4) The universal faithful group grading of $\mathscr{C}$ is given by

$$
\mathscr{C}=\bigoplus_{g \in G(k)} \mathscr{C}_{g}
$$

where $\mathscr{C}_{g} \subset \mathscr{C}$ denotes the smallest Serre subcategory of $\mathscr{C}$ containing the invertible object $X_{g}$ (see [EGNO, Section 4.14]).
Proof. (1) Let $X$ be simple in $\mathscr{C}$. By [EGNO, Proposition 6.3.1], $X_{+}$ is simple in $\mathscr{D}_{\mathscr{C}}^{*}$ (see 2.5). Since $X^{*}$ is simple in $\mathscr{C}$, and $\mathrm{F}^{*}$ (3.6) is an equivalence, it follows from (3.7) that $\mathrm{F}^{*}\left(X \boxtimes X^{*}\right)=X_{+} \otimes_{A}\left(X^{*}\right)_{-}$is simple in $\mathscr{D}_{\mathscr{C}}^{*}$. Since

$$
\operatorname{Hom}_{\mathscr{D}_{\mathscr{C}}^{*}}^{*}\left(X_{+} \otimes_{A}\left(X^{*}\right)_{-}, A\right)=\operatorname{Hom}_{\mathscr{D}_{\mathscr{C}}^{*}}^{*}\left(X_{+}, X_{+}\right)=k,
$$

it follows that $X_{+} \otimes_{A}\left(X^{*}\right)_{-}=A$ in $\mathscr{D}_{\mathscr{C}}^{*}$, hence $X \otimes_{A} X^{*}=A$ in $\mathscr{C}$. Thus, $X$ is invertible in $\mathscr{C}$, as claimed.
(2) Since the equivalence F* (3.6) maps $P_{\mathscr{Q}_{\mathscr{C}}^{*}}(\mathbf{1})$ to $P_{\mathscr{C}}(\mathbf{1}) \boxtimes P_{\mathscr{C}}(\mathbf{1})$, it follows that

$$
\operatorname{FPdim}_{\mathscr{D}_{\mathscr{C}}^{*}}\left(P_{\mathscr{D}_{\mathscr{C}}^{*}}(\mathbf{1})\right)=\operatorname{FPdim}_{\mathscr{C}}\left(P_{\mathscr{C}}(\mathbf{1})\right)^{2} .
$$

On the other hand, by Lemma 3.2, we have

$$
\operatorname{FPdim}_{\mathscr{D}_{\mathscr{C}}^{*}}\left(P_{\mathscr{D}_{\mathscr{C}}^{*}}(\mathbf{1})\right)=\operatorname{FPdim}_{\operatorname{Coh}(G)}\left(P_{\operatorname{Coh}(G)}(\mathbf{1})\right) \operatorname{FPdim}_{\mathscr{C}}\left(P_{\mathscr{C}}(\mathbf{1})\right) .
$$

Therefore, we get $\operatorname{FPdim}_{\mathscr{C}}\left(P_{\mathscr{C}}(\mathbf{1})\right)=\operatorname{FPdim}_{\operatorname{Coh}(G)}\left(P_{\operatorname{Coh}(G)}(\mathbf{1})\right)$.
Finally, since for every invertible object $X \in G(\mathscr{C})$,

$$
\operatorname{FPdim}_{\mathscr{G}}\left(P_{\mathscr{C}}(X)\right)=\operatorname{FPdim}_{\mathscr{G}}\left(\left(P_{\mathscr{C}}(\mathbf{1})\right),\right.
$$

the claim follows.
(3) Since $F^{*}$ (3.6) is an equivalence, there exist unique simple objects $X_{g}, Y_{g} \in \mathscr{C}$ such that

$$
\left(X_{g}\right)_{+} \otimes_{A}\left(Y_{g}\right)_{-}=\mathrm{F}^{*}\left(X_{g} \boxtimes Y_{g}\right)=A_{g}
$$

Since $X_{g}, Y_{g} \in G(\mathscr{C})$ by (1), it follows that $\left(X_{g}\right)_{+}=A_{g} \otimes_{A}\left(Y_{g}\right)_{+}^{*}$, so forgetting the left $A$-module structure yields $X_{g}=Y_{g}^{*}$. Thus, the functor $\mathrm{F}^{*}$ (3.6) induces an injective group homomorphism

$$
\begin{equation*}
G(k) \xrightarrow{1: 1} G(\mathscr{C}), \quad g \mapsto X_{g} \tag{3.8}
\end{equation*}
$$

Now it follows from (1), (2) and 3.1 that

$$
\begin{aligned}
|G| & =\operatorname{FPdim}(\mathscr{C}) \\
& =\sum_{X \in G(\mathscr{C})} \operatorname{FPdim}\left(P_{\mathscr{C}}(X)\right) \geq \sum_{X_{g} \in G(\mathscr{C})} \operatorname{FPdim}\left(P_{\mathscr{C}}\left(X_{g}\right)\right) \\
& =\sum_{g \in G(k)} \operatorname{FPdim}\left(P_{\operatorname{Coh}(G)}(\mathbf{1})\right)=\operatorname{FPdim}(\operatorname{Coh}(G))=|G| .
\end{aligned}
$$

Therefore, we have an equality

$$
\operatorname{FPdim}(\mathscr{C})=\sum_{X_{g} \in G(\mathscr{C})} \mathrm{FPdim}\left(P_{\mathscr{C}}\left(X_{g}\right)\right)
$$

which implies that the map (3.8) is also surjective, as claimed.
(4) By (1), $\mathscr{C}_{\text {ad }}$ is the smallest Serre tensor subcategory of $\mathscr{C}$ containing 1 (see [EGNO, Section 4.14]). Thus, (3) implies that $G(k)$ is the universal group of $\mathscr{C}$, as claimed.

Remark 3.7. Note that if $G$ is an abstract group such that $p$ does not divide $|G|$, then Theorem 1.1, and hence Corollaries 1.2 and 1.3, follow already from Proposition 3.6 (see [DGNO1, Theorem 4.5] and [LKW, Theorem 4.22]).
3.4. $\mathscr{C} \cong \operatorname{Coh}(G, \omega)$. In this section we show that $\mathscr{C} \cong \operatorname{Coh}(G, \omega)$ as tensor categories.

For every $\left(X, \mathrm{~m}_{X}\right) \in \mathscr{C}, \mathbf{V}=(V, \rho) \in \operatorname{Rep}(G) \subset \mathscr{D}$, consider the $\mathscr{C}$-isomorphism

$$
\Phi_{\mathbf{V}, X}: F(\mathbf{V}) \otimes_{A} X \xrightarrow{\cong} X \otimes_{A} F(\mathbf{V})
$$

given by the central structure on $F$ (3.4):

$$
\begin{equation*}
\Phi_{\mathbf{V}, X}=\left(\operatorname{Id}_{X} \otimes \mathrm{c}_{A, \mathbf{V}}\right) \circ\left(\operatorname{Id}_{X} \otimes u_{A} \otimes \operatorname{Id}_{V}\right) \circ \mathrm{c}_{\mathbf{V}, X} \circ\left(\operatorname{Id}_{V} \otimes\left(\mathrm{~m}_{X} \circ \mathrm{c}_{X, A}^{-1}\right)\right) \tag{3.9}
\end{equation*}
$$

Since by Proposition 3.1, $F(\mathbf{V})=V$, we obtain a family of $\mathscr{C}$-isomorphisms

$$
\Phi_{V, X}: V \otimes X \xrightarrow{\cong} V \otimes X, \quad V \in \mathrm{Vec},
$$

given by

$$
\begin{equation*}
V \otimes X=\mathbf{V} \otimes A \otimes_{A} X \xrightarrow{\Phi_{\mathbf{V}, X}} X \otimes_{A} \mathbf{V} \otimes A=X \otimes V=V \otimes X \tag{3.10}
\end{equation*}
$$

Thus by (3.10), we can view $\Phi_{V, X}$ as an element of

$$
\operatorname{Hom}_{\mathscr{C}}\left(X,\left(V^{*} \otimes_{k} V\right) \otimes X\right) \cong \operatorname{Hom}_{\mathscr{G}}\left(X, \operatorname{End}_{k}(V) \otimes X\right)
$$

so by Lemma 3.3, and the fact that $\operatorname{End}\left(F_{\mid \mathscr{E}}\right)=k G$ as Hopf algebras, we obtain a natural family $\Phi:=\left\{\Phi_{X} \mid X \in \mathscr{C}\right\}$ of $\mathscr{C}$-morphisms

$$
\begin{equation*}
\Phi_{X}:\left(X, \mathrm{~m}_{X}\right) \rightarrow\left(k G \otimes X, \operatorname{Id}_{k G} \otimes \mathrm{~m}_{X}\right) \tag{3.11}
\end{equation*}
$$

or equivalently, $k$-algebra maps

$$
\begin{equation*}
\Phi_{X}: \mathscr{O}(G) \rightarrow \operatorname{End}_{\mathscr{C}}(X) \tag{3.12}
\end{equation*}
$$

Lemma 3.8. For every $X \in \mathscr{C}$, the morphism $\Phi_{X}$ (3.11) equips $X$ with a structure of a $k G$-comodule in $\mathscr{C}$ (equivalently, an $\mathscr{O}(G)$-module in $\mathscr{C}$ ).

Proof. By Proposition 3.1 and Lemma3.3.3(2), for every $V, U \in \mathrm{Vec}$ and $X \in \mathscr{C}$, we have

$$
\Phi_{V \otimes U, X}=\left(\Phi_{V, X} \otimes \operatorname{Id}_{U}\right) \circ\left(\operatorname{Id}_{V} \otimes \Phi_{U, X}\right)
$$

Now it is straightforward to verify that this translates to the claim.
Now by Proposition [3.6(1) and [EO1, Proposition 2.6], $\mathscr{C}$ admits a quasi-tensor functor to Vec. Let $Q: \mathscr{C} \rightarrow$ Vec be such a functor. Then by Lemma 3.8, for every $X \in \mathscr{C}$, we get a $k$-algebra map

$$
\widetilde{\Phi}_{X}: \mathscr{O}(G) \xrightarrow{\Phi_{X}} \operatorname{End}_{\mathscr{E}}(X) \xrightarrow{Q} \operatorname{End}_{k}(Q(X)),
$$

so we see that we have defined a functor

$$
\begin{equation*}
\widetilde{\Phi}: \mathscr{C} \rightarrow \operatorname{Coh}(G), \quad X \mapsto\left(Q(X), \widetilde{\Phi}_{X}\right) \tag{3.13}
\end{equation*}
$$

Lemma 3.9. For every $g \in G(k), \widetilde{\Phi}_{X_{g}}=g$ (where $g$ is viewed as an $\mathscr{O}(G)$-module). Thus, $\widetilde{\Phi}$ induces an injective group homomorphism $G(\mathscr{C}) \xrightarrow{1: 1} G(k)$.

Proof. The first claim follows from Proposition 3.6 and Lemma 3.8 . Also, it is straightforward to verify that for every $g \in G(k)$, the map $\Phi_{V, X_{g}} \in$ Aut $_{\mathscr{C}}\left(V \otimes X_{g}\right)$ is given by $\rho(g) \otimes \operatorname{Id}_{X_{g}}$ for every $V \in$ Vec, which proves the second claim.
Corollary 3.10. The functor $\widetilde{\Phi}$ (3.13) is a quasi-tensor equivalence.
Proof. By Lemma 3.3(3), we have

$$
\Phi_{V, X \otimes_{A} Y}=\left(\operatorname{Id}_{X} \otimes \Phi_{V, Y}\right) \circ\left(\Phi_{V, X} \otimes \operatorname{Id}_{Y}\right)
$$

for every $V \in \operatorname{Vec}$ and $X, Y \in \mathscr{C}$. Now it is straightforward to verify that this implies that $\widetilde{\Phi}(A)=\left(k, \widetilde{\Phi}_{A}\right)$ is the unit object (since $\operatorname{End}_{\mathscr{C}}(A)=k$, so $\widetilde{\Phi}_{A}: \mathscr{O}(G) \rightarrow k$ is the trivial homomorphism), and we have an isomorphism

$$
\Phi(X \otimes Y)=\left(X \otimes Y, \Phi_{X \otimes Y}\right) \cong\left(X, \Phi_{X}\right) \otimes\left(Y, \Phi_{Y}\right)=\Phi(X) \otimes \Phi(Y)
$$

for every $X, Y \in \mathscr{C}$. Thus, $\Phi$ is a quasi-tensor functor, and hence so is $\widetilde{\Phi}$.

Moreover, by Proposition 3.6(3) and Lemma 3.8, $\widetilde{\Phi}$ induces a group isomorphism $G(\mathscr{C}) \xrightarrow{\cong} G(k)$, which implies it is an equivalence.

Finally, by Corollary 3.10, the associativity structure on $\mathscr{C}$ determines an associativity structure on $\operatorname{Coh}(G)$, i.e., a class $\omega \in H^{3}\left(G, \mathbb{G}_{m}\right)$, such that $\widetilde{\Phi}: \mathscr{C} \rightarrow \operatorname{Coh}(G, \omega)$ is a tensor equivalence, as desired.

This completes the proof of Theorem 1.1.

## 4. The proof of Corollary 1.2

Consider a braided tensor equivalence $\mathrm{F}: \mathscr{D} \stackrel{\cong}{\Longrightarrow} \mathscr{Z}(\operatorname{Coh}(G, \omega))$, and let $\mathcal{F}: \mathscr{Z}(\operatorname{Coh}(G, \omega)) \rightarrow \operatorname{Coh}(G, \omega)$ be the forgetful functor. Let $f(G, \omega, \mathrm{~F})$ denote the subcategory of $\mathscr{D}$ consisting of all objects sent to Vec under $\mathcal{F} \circ \mathrm{F}$. In other words, $f(G, \omega, \mathrm{~F})$ is the preimage of $\operatorname{Rep}(G)$ under F (see Lemma 2.5). Then $f(G, \omega, \mathrm{~F})$ is a Tannakian Lagrangian subcategory of $\mathscr{D}$, which is clearly independent of the equivalence class of $(G, \omega, F)$. Thus, every equivalence class $[(G, \omega, F)]$ gives rise to a Tannakian Lagrangian subcategory $\mathrm{f}([G, \omega, \mathrm{~F}]):=f(G, \omega, \mathrm{~F})$ of $\mathscr{D}$.

Conversely, assume $\operatorname{Rep}(G) \subset \mathscr{D}$ is a Tannakian Lagrangian subcategory of $\mathscr{D}$ for some finite group scheme $G$ over $k$. Then by Theorem 1.1. we have a braided tensor equivalence $\mathrm{F}: \mathscr{D} \cong \mathscr{Z}(\operatorname{Coh}(G, \omega))$ for
some $\omega \in H^{3}\left(G, \mathbb{G}_{m}\right)$. Thus, every Tannakian Lagrangian subcategory $\operatorname{Rep}(G)$ of $\mathscr{D}$ gives rise to an equivalence class $[(G, \omega, F)]$. Set $\mathrm{h}(\operatorname{Rep}(G)):=[(G, \omega, F)]$.

We claim that the assignments $\mathrm{f}, \mathrm{h}$ constructed above are inverse to each other.

Given a Tannakian Lagrangian subcategory $\mathscr{E}=\operatorname{Rep}(G)$ of $\mathscr{D}$, let $A:=\mathscr{O}(G)$ and $\mathscr{C}:=\operatorname{Mod}(A)_{\mathscr{D}}($ see 2.5). Since by Corollary 3.4, the functor $\mathscr{D} \xrightarrow{\mathrm{F}} \mathscr{Z}(\mathscr{C}) \xrightarrow{\text { Forget }} \mathscr{C}$ coincides with the free $A$-module functor, it follows that the category $\mathrm{f}(\mathrm{h}(\mathscr{E}))=f(G, \omega, \mathrm{~F})$ consists of all objects $X$ in $\mathscr{D}$ such that $X \otimes A$ is a multiple of $A$. Since $A$ is the regular object of $\mathscr{E}$, it follows that $\mathscr{E} \subset \mathrm{f}(\mathrm{h}(\mathscr{E}))$, so $\mathscr{E}=\mathrm{f}(\mathrm{h}(\mathscr{E}))$ (as both categories have FP dimension $|G|)$. Thus, $\mathrm{f} \circ \mathrm{h}=\mathrm{Id}$, as desired.

Given an equivalence class $\left[\left(G_{1}, \omega_{1}, \mathrm{~F}_{1}\right)\right]$, we have to show now that $(\mathrm{h} \circ \mathrm{f})\left(\left[G_{1}, \omega_{1}, \mathrm{~F}_{1}\right]\right)=\left[\left(G_{1}, \omega_{1}, \mathrm{~F}_{1}\right)\right]$. Since $f\left(G_{1}, \omega_{1}, \mathrm{~F}_{1}\right) \cong \operatorname{Rep}\left(G_{1}\right)$ as symmetric tensor categories (via $\mathrm{F}_{1}$ ), it follows from [DM] that there exist a finite group scheme $G_{2}$ over $k$, and a group scheme isomorphism $\phi: G_{1} \cong G_{2}$, such that $f\left(G_{1}, \omega_{1}, \mathrm{~F}_{1}\right)=\operatorname{Rep}\left(G_{2}\right)$ and the restriction of $\mathrm{F}_{1}$ to $f\left(G_{1}, \omega_{1}, \mathrm{~F}_{1}\right)$ coincides with $\phi^{*}: \operatorname{Rep}\left(G_{2}\right) \xrightarrow{\cong} \operatorname{Rep}\left(G_{1}\right)$. Thus, we have

$$
(\mathrm{h} \circ \mathrm{f})\left(\left[G_{1}, \omega_{1}, \mathrm{~F}_{1}\right]\right)=\mathrm{h}\left(\operatorname{Rep}\left(G_{2}\right)\right)=\left[\left(G_{2}, \omega_{2}, \mathrm{~F}_{2}\right)\right],
$$

where $\mathrm{F}_{2}: \mathscr{D} \cong \mathscr{Z}\left(\operatorname{Coh}\left(G_{2}, \omega_{2}\right)\right)$ is a braided tensor equivalence for some $\omega_{2} \in H^{3}\left(G_{2}, \mathbb{G}_{m}\right)$. Since $\mathrm{F}_{1}\left(\mathscr{O}\left(G_{2}\right)\right)=\phi^{*}\left(\mathscr{O}\left(G_{2}\right)\right)=\mathscr{O}\left(G_{1}\right)$, it follows that $\mathrm{F}_{1}$ induces a tensor equivalence

$$
\mathrm{F}_{1}: \operatorname{Mod}\left(\mathscr{O}\left(G_{2}\right)\right)_{\mathscr{D}} \xrightarrow{\cong} \operatorname{Mod}\left(\mathscr{O}\left(G_{1}\right)\right)_{\mathscr{Z}\left(\operatorname{Coh}\left(G_{1}, \omega_{1}\right)\right)} .
$$

Also, $\mathrm{F}_{2}$ induces a tensor equivalence

$$
\mathrm{F}_{2}: \operatorname{Mod}\left(\mathscr{O}\left(G_{2}\right)\right)_{\mathscr{D}} \xrightarrow{\cong} \operatorname{Mod}\left(\mathscr{O}\left(G_{2}\right)\right)_{\mathscr{L}\left(\operatorname{Coh}\left(G_{2}, \omega_{2}\right)\right)} .
$$

Now, let

$$
\mathcal{I}_{i}: \operatorname{Coh}\left(G_{i}, \omega_{i}\right) \xrightarrow{\rightrightarrows} \operatorname{Mod}\left(\mathscr{O}\left(G_{i}\right)\right)_{\mathscr{Z}\left(\operatorname{Coh}\left(G_{i}, \omega_{i}\right)\right)}, \quad i=1,2
$$

be the tensor equivalences given by Lemma 2.6(3), and consider the tensor equivalence

$$
\varphi:=\mathcal{I}_{2}^{-1} \circ \mathrm{~F}_{2} \circ \mathrm{~F}_{1}^{-1} \circ \mathcal{I}_{1}: \operatorname{Coh}\left(G_{1}, \omega_{1}\right) \xrightarrow{\cong} \operatorname{Coh}\left(G_{2}, \omega_{2}\right) .
$$

Then we have $\mathcal{F}_{2} \circ \mathrm{~F}_{2}=\varphi \circ \mathcal{F}_{1} \circ \mathrm{~F}_{1}$, where

$$
\mathcal{F}_{i}: \mathscr{Z}\left(\operatorname{Coh}\left(G_{i}, \omega_{i}\right)\right) \rightarrow \operatorname{Coh}\left(G_{i}, \omega_{i}\right), \quad i=1,2
$$

are the forgetful functors. Thus, $\left[\left(G_{1}, \omega_{1}, \mathrm{~F}_{1}\right)\right]=\left[\left(G_{2}, \omega_{2}, \mathrm{~F}_{2}\right)\right]$, so we have $\mathrm{h} \circ \mathrm{f}=\mathrm{Id}$, as desired.

The proof of Corollary 1.2 is complete.

## 5. The proof of Corollary 1.3

Fix a finite group scheme $G$ over $k$. Set $\mathscr{E}:=\operatorname{Rep}(G)$, and retain the notation of 2.9 .

By Theorem 1.1, we have a surjective map of sets

$$
\alpha: \mathcal{M}_{\mathrm{ext}}(\mathscr{E}) \cong H^{3}\left(G, \mathbb{G}_{m}\right), \quad(\mathscr{D}, \iota) \mapsto \omega
$$

where $\omega \in H^{3}\left(G, \mathbb{G}_{m}\right)$ is such that $\mathscr{D} \cong \mathscr{Z}(\operatorname{Coh}(G, \omega))$ as braided tensor categories. Moreover, it is clear that $\alpha(\mathscr{D}, \iota)=1$ if and only if $\mathscr{D} \cong \mathscr{Z}(\operatorname{Coh}(G))$ as braided tensor categories. Thus, it remains to show that $\alpha$ is a group homomorphism.

Set $A:=\mathscr{O}(G \times G)$ and $B:=\mathscr{O}(G \times G / \Delta(G))$ (see Lemma 2.4). Then $B \subset A$ are exact commutative algebras in the Tannakian category $\operatorname{Rep}(G \times G)=\operatorname{Rep}(G) \boxtimes \operatorname{Rep}(G)$, and we have to prove that

$$
\operatorname{Mod}^{0}(B)_{\mathscr{Z}\left(\operatorname{Coh}\left(G, \omega_{1}\right)\right) \boxtimes \mathscr{Z}\left(\operatorname{Coh}\left(G, \omega_{2}\right)\right)} \cong \mathscr{Z}\left(\operatorname{Coh}\left(G, \omega_{1} \omega_{2}\right)\right)
$$

as braided tensor categories. By (2.8), it suffices to prove that

$$
\operatorname{Mod}^{0}(B)_{\mathscr{Z}\left(\operatorname{Coh}\left(G \times G, \omega_{1} \times \omega_{2}\right)\right)} \cong \mathscr{Z}\left(\operatorname{Coh}\left(G, \omega_{1} \omega_{2}\right)\right)
$$

as braided tensor categories.
To this end, note that similarly to DMNO, Example 4.11(ii)], one shows that exact subalgebras $B$ of $A$ are in one to one correspondence with tensor subcategories of $\mathscr{Z}\left(\operatorname{Coh}\left(G \times G, \omega_{1} \times \omega_{2}\right)\right)$, such that $B$ corresponds to the image of the functor

$$
\begin{equation*}
\operatorname{Mod}^{0}(B)_{\mathscr{Z}\left(\operatorname{Coh}\left(G \times G, \omega_{1} \times \omega_{2}\right)\right)} \xrightarrow{-\otimes_{B} A} \operatorname{Coh}\left(G \times G, \omega_{1} \times \omega_{2}\right) . \tag{5.1}
\end{equation*}
$$

Since the image of the functor (5.1) is

$$
\operatorname{Coh}\left(\Delta(G),\left(\omega_{1} \times \omega_{2}\right)_{\mid \Delta(G)}\right) \cong \operatorname{Coh}\left(G, \omega_{1} \omega_{2}\right),
$$

we are done.

## 6. Examples

Recall that a finite group scheme $G$ over $k$ is commutative if and only if $\mathscr{O}(G)$ is a finite dimensional commutative and cocommutative Hopf algebra. Thus, if $G$ is a finite commutative group scheme over $k$ then its group algebra $k G:=\mathscr{O}(G)^{*}$ is also a finite dimensional commutative and cocommutative Hopf algebra, so it represents a finite commutative group scheme $G^{D}$ over $k$, which is called the Cartier dual of $G$.

Example 6.1. Let $G$ be a finite abelian p-group. Then by [EG2, Corollary 5.8], $H^{3}\left(G^{D}, \mathbb{G}_{m}\right)=1$, thus by Corollary 1.3, $\mathcal{M}_{\text {ext }}\left(\operatorname{Rep}\left(G^{D}\right)\right)=1$ is the trivial group. For example, if $G=\mathbb{Z} / p \mathbb{Z}$ then $G^{D}=\mu_{p}$ is the Frobenius kernel of the multiplicative group $\mathbb{G}_{m}$ (see, e.g., [G], Section $2.2])$, so $\mathcal{M}_{\text {ext }}\left(\operatorname{Rep}\left(\mu_{p}\right)\right)=1$.

Example 6.2. Let $\alpha_{p, r}$ denote the $r$-th Frobenius kernel of the additive group $\mathbb{G}_{a}$ (see, e.g., [EG2, Section 2.6]). Let $G:=\prod_{i=1}^{n} \alpha_{p, r_{i}}$. Then by [EG2, Corollary 5.10], we have $H^{3}\left(G^{D}, \mathbb{G}_{m}\right)=H^{3}\left(G^{D}, \mathbb{G}_{a}\right)$. Thus by Corollary 1.3, we have a group isomorphism

$$
\mathcal{M}_{\mathrm{ext}}\left(\operatorname{Rep}\left(G^{D}\right)\right)=H^{3}\left(G^{D}, \mathbb{G}_{a}\right) .
$$

For example, if $G=\alpha_{p}^{n}$ then $\left(\alpha_{p}^{n}\right)^{D}=\alpha_{p}^{n}$, so we have

$$
\mathcal{M}_{\text {ext }}\left(\operatorname{Rep}\left(\alpha_{p}^{n}\right)\right)=H^{3}\left(\alpha_{p}^{n}, \mathbb{G}_{a}\right)
$$

Thus by [EG2, Proposition 2.2], we have

$$
\mathcal{M}_{\mathrm{ext}}\left(\operatorname{Rep}\left(\alpha_{p}^{n}\right)\right) \cong \wedge^{3} \mathfrak{g} \oplus\left(\mathfrak{g} \otimes \mathfrak{g}^{(1)}\right), \quad p>2
$$

and

$$
\mathcal{M}_{\mathrm{ext}}\left(\operatorname{Rep}\left(\alpha_{2}^{n}\right)\right) \cong S^{3} \mathfrak{g}
$$

where $\mathfrak{g}:=\operatorname{Lie}\left(\alpha_{p}^{n}\right)$ and $\mathfrak{g}^{(1)}$ is the Frobenius twist of $\mathfrak{g} 3^{3}$.
Example 6.3. Let $\mathfrak{g}$ be a finite dimensional restricted p-Lie algebra over $k$, and let $u(\mathfrak{g})$ be its restricted universal enveloping algebra (see, e.g., [G, Section 2.2]). Since $u(\mathfrak{g})^{*}$ is a finite dimensional commutative Hopf algebra over $k, u(\mathfrak{g})^{*}=\mathscr{O}(\Gamma)$ is the coordinate algebra of a finite group scheme $\Gamma$ over $k$. Recall that $\mathfrak{g}$ is the Lie algebra of $\Gamma$, and $\operatorname{Rep}(\Gamma) \cong \operatorname{Rep}(u(\mathfrak{g}))$ as symmetric tensor categories.

Now by [EG2, Theorem 5.4], we have $H^{3}\left(\Gamma, \mathbb{G}_{m}\right)=H^{3}\left(\Gamma, \mathbb{G}_{a}\right)$. Thus by Corollary 1.3, we have a group isomorphism

$$
\begin{equation*}
\mathcal{M}_{\mathrm{ext}}(\operatorname{Rep}(\Gamma))=H^{3}\left(\Gamma, \mathbb{G}_{a}\right) \tag{6.1}
\end{equation*}
$$

For example, if $\mathfrak{g}$ is semisimple (i.e., $\mathfrak{g}$ is the Lie algebra of a simple, simply connected algebraic group defined and split over $\left.\mathbb{F}_{p}\right)$ then by [FP, Corollary 1.6], $H^{\bullet}\left(\Gamma, \mathbb{G}_{a}\right)$ is zero in odd degrees. Thus, by (6.1), we have $\mathcal{M}_{\text {ext }}(\operatorname{Rep}(\Gamma))=H^{3}\left(\Gamma, \mathbb{G}_{a}\right)=1$ is trivial in this case.

Example 6.4. Let $\mathfrak{g}$ be a semisimple restricted $p$-Lie algebra over $k$ (see Example 6.3). Let $\mathfrak{k}$ be the 1-dimensional abelian restricted $p$-Lie algebra over $k$ with $u(\mathfrak{k})^{*}=\mathscr{O}\left(\alpha_{p}\right)=k[x] / x^{p}$, where $x$ is a primitive element $4^{4}$. Recall that $H^{1}\left(\alpha_{p}, \mathbb{G}_{a}\right)=\operatorname{sp}_{k}\{x\}$.

Consider now the restricted $p$-Lie algebra $\tilde{\mathfrak{g}}:=\mathfrak{g} \oplus \mathfrak{k}$, and let $\widetilde{\Gamma}$ be the finite group scheme over $k$ such that $u(\tilde{\mathfrak{g}})^{*}=\mathscr{O}(\widetilde{\Gamma})$. Then $\widetilde{\Gamma}=\Gamma \times \alpha_{p}$, and the cup product induces an isomorphism

$$
H^{2}\left(\Gamma, \mathbb{G}_{a}\right) \otimes H^{1}\left(\alpha_{p}, \mathbb{G}_{a}\right) \xrightarrow{\cong} H^{3}\left(\widetilde{\Gamma}, \mathbb{G}_{a}\right) .
$$

[^1]Equivalently, since $x$ is a basis of $H^{1}\left(\alpha_{p}, \mathbb{G}_{a}\right)$, we have an isomorphism

$$
H^{2}\left(\Gamma, \mathbb{G}_{a}\right) \xrightarrow{\rightrightarrows} H^{3}\left(\widetilde{\Gamma}, \mathbb{G}_{a}\right), \quad \xi \mapsto \xi \otimes x .
$$

Now recall (see, e.g., [FP]) that for $p \neq 2,3$, we have an isomorphism

$$
\tau: \mathfrak{g}^{*(1)} \xlongequal{\cong} H^{2}\left(\Gamma, \mathbb{G}_{a}\right), \quad f \mapsto \mathfrak{g}_{f}
$$

where $\mathfrak{g}^{*(1)}$ is the Frobenius twist of $\mathfrak{g}^{*} 5$, and $\mathfrak{g}_{f}=\mathfrak{g} \oplus k$ (as an abstract Lie algebra) with $[p]$-operator defined by $(v, a)^{[p]}:=\left(v^{[p]}, f(v)\right)$. Thus, we obtain an isomorphism

$$
\Omega: \mathfrak{g}^{*(1)} \xlongequal{\cong} H^{3}\left(\widetilde{\Gamma}, \mathbb{G}_{a}\right), \quad f \mapsto \tau(f) \otimes x .
$$

In particular, by (6.1), we have

$$
\mathcal{M}_{\mathrm{ext}}(\operatorname{Rep}(\widetilde{\Gamma})) \cong \mathfrak{g}^{*(1)}
$$
