# A DEFORMED HERMITIAN YANG-MILLS FLOW 

JIXIANG FU, SHING-TUNG YAU, AND DEKAI ZHANG


#### Abstract

We study a new deformed Hermitian Yang-Mills flow on a compact Kähler manifold. We first show the existence of the longtime solution of the flow. We then show that under the Collins-Jacob-Yau's condition on the subsolution, the longtime solution converges to the solution of the deformed Hermitian Yang-Mills equation, which was solved by Collins-Jacob-Yau [5] by the continuity method. Moreover, as an application of the flow, we show that on a compact Kähler surface, if there exists a semi-subsolution of the deformed Hermitian Yang-Mills equation, then the flow converges smoothly to a singular solution to the deformed Hermitian Yang-Mills equation away from a finite number of curves of negative self-intersection. Such a solution can be viewed as a boundary point of the moduli space of the deformed Hermitian Yang-Mills solutions for a given Kähler metric.


## 1. Introduction

Let $(M, \omega)$ be a compact Kähler manifold of dimension $n$ and $\chi$ be a real closed $(1,1)$ form. Motivated by mirror symmetry [24], Jacob-Yau [22] initiated to study the deformed Hermitian Yang-Mills (dHYM) equation:

\operatorname{Re}\left(\chi_{u}+\sqrt{-1} \omega\right)^{n}=\cot \theta_{0} \operatorname{Im}\left(\chi_{u}+\sqrt{-1} \omega\right)^{n}, \tag{1.1}
\end{equation*}
$$

where $\theta_{0}$ is the argument of the complex number $\int_{M}(\chi+\sqrt{-1} \omega)^{n}$ and $\chi_{u}=\chi+\sqrt{-1} \partial \bar{\partial} u$ for a real smooth function $u$ on $M$.

Let $\lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right)$ be the eigenvalues of $\chi_{u}$ with respect to $\omega$, and if necessary we denote $\lambda$ by $\lambda\left(\chi_{u}\right)$ and $\lambda_{i}$ by $\lambda_{i}\left(\chi_{u}\right)$ for each $1 \leq i \leq n$. Then by Jacob-Yau [22] the dHYM equation has an equivalent form

\theta_{\omega}\left(\chi_{u}\right):=\sum_{i=1}^{n} \operatorname{arccot} \lambda_{i}=\theta_{0} . \tag{1.2}
\end{equation*}
$$

It is called supercritical if $\theta_{0} \in(0, \pi)$ and hypercritical if $\theta_{0} \in\left(0, \frac{\pi}{2}\right)$.
1.1. Previous results. The dHYM equation has been extensively studied by many mathematicians ([2], [3], [5], [4], [6], [7], [16], [17], [18], [20], [22], [25], [26], [28]).

We first introduce the related results in the elliptic case. When $n=2$, Jacob-Yau [22] solved the equation by translating it into the complex Monge-Ampère equation which was solved by Yau [36]. When $n \geq 3$, Collins-Jacob-Yau [5] solved the dHYM equation for
the supercritical case by assuming the existence of a subsolution $\underline{u}$ and an extra condition on $\underline{u}$. For convenience, for a smooth function $v$ on $M$ we define

A_{0}(v):=\max _{M} \max _{1 \leq j \leq n} \sum_{i \neq j} \operatorname{arccot} \lambda_{i}\left(\chi_{v}\right)
$$

and

$$
B_{0}(v)=\max _{M} \theta_{\omega}\left(\chi_{v}\right)
$$

A smooth function $\underline{u}$ on $M$ is called a subsolution of dHYM equation (1.2) if $\underline{u}$ satisfies the inequality

\begin{equation*}
A_{0}(\underline{u})<\theta_{0} . \tag{1.3}
\end{equation*}
$$

The extra condition on $\underline{u}$ is

$$
\begin{equation*}
B_{0}(\underline{u})<\pi . \tag{1.4}
\end{equation*}
$$

To be precise, Collins, Jacob and Yau proved the following
Theorem 1.1 (Collins-Jacob-Yau [5]). Let $(M, \omega)$ be a compact Kähler manifold of dimension $n$ and $\chi$ a closed real $(1,1)$ form on $M$ with $\theta_{0} \in(0, \pi)$. Suppose there exists a subsolution $\underline{u}$ of $d H Y M$ equation (1.2) in the sense of (1.3) and $\underline{u}$ also satisfies inequality (1.4). Then there exists a unique smooth soluion of dHYM equation (1.2).

Without condition (1.4) Pingali [28] then solved the equation for $n=3$ and Lin [26] solved it for $n=3,4$. On the other hand, Lin [25] generalized Collins-Jacob-Yau's result to the Hermitian case $(M, \omega)$ with $\partial \bar{\partial} \omega=\partial \bar{\partial} \omega^{2}=0$; Huang-Zhang-Zhang [20] also considered the solution on a compact almost Hermitian manifold for the hypercritical case.

For the parabolic flow method, there are also several results. More precisely, Jacob-Yau [22] and Collins-Jacob-Yau [5] solved the line bundle mean curvature flow (LBMCF)

u_{t}=\theta_{0}-\theta_{\omega}\left(\chi_{u}\right)  \tag{1.5}\\
u(0)=u_{0}
\end{array}\right.
$$

under the assumptions:
(1) $\theta_{0} \in\left(0, \frac{\pi}{2}\right)$;
(2) the existence of a subsolution $\underline{u}$ in the sense of (1.3); and
(3) $\theta_{\omega}\left(\chi_{u_{0}}\right) \in\left(0, \frac{\pi}{2}\right)$.

Takahashi [32] proved the existence and convergence of the tangent Lagrangian phase flow (TLPF)

$$
\left\{\begin{array}{l}
u_{t}=\tan \left(\theta_{0}-\theta_{\omega}\left(\chi_{u}\right)\right)  \tag{1.6}\\
u(0)=u_{0}
\end{array}\right.
$$

under the same assumptions (1) and (2) of flow (1.5) and the assumption:
(3') $\theta_{\omega}\left(\chi_{u_{0}}\right)-\theta_{0} \in\left(-\frac{\pi}{2}, \frac{\pi}{2}\right)$.

Another important problem raised by Collins-Jacob-Yau [5] is to find a sufficient and necessary geometric condition on the existence of a solution of the dHYM equation. There are some important progresses made by Chen [2] and Chu-Lee-Takahashi [4].
1.2. Our results. Motivated by the concavity of $\cot \theta_{\omega}\left(\chi_{u}\right)$ by Chen [2], we consider a dHYM flow:

\left\{\begin{array}{l}
u_{t}=\cot \theta_{\omega}\left(\chi_{u}\right)-\cot \theta_{0},  \tag{1.7}\\
u(x, 0)=u_{0}(x) .
\end{array}\right.
$$

Assume $u_{0}$ satisfies

$$
\begin{equation*}
B_{0}\left(u_{0}\right)<\pi . \tag{1.8}
\end{equation*}
$$

This condition is the same as (1.4) if $u_{0}=\underline{u}$.
We first prove an existence theorem of the longtime solution of flow (1.7).
Theorem 1.2. Let $(M, \omega)$ be a compact Kähler manifold and $\chi$ a closed real $(1,1)$ form with $\theta_{0} \in(0, \pi)$. If $u_{0}$ satisfies inequality (1.8), then dHYM flow (1.7) has a unique smooth longtime solution $u$.

Next we consider the convergence of longtime solution of flow (1.7). Now we need to assume the dHYM equation has a subsolution $\underline{u}$ which also satisfies inequality (1.4). The first main result of this paper is

Theorem 1.3. Let $(M, \omega)$ be a compact Kähler manifold of dimension $n$ and $\chi$ a closed real $(1,1)$ form with $\theta_{0} \in(0, \pi)$. Suppose dHYM equation (1.2) has a subsolution $\underline{u}$ in the sense of (1.3) which also satisfies (1.4). If $u_{0}$ satisfies (1.8), then the longtime solution $u(x, t)$ of dHYM flow (1.7) converges to a smooth solution $u^{\infty}$ to the dHYM equation:

$$
\theta_{\omega}\left(\chi_{u^{\infty}}\right)=\theta_{0} .
$$

The extra condition (1.4) in our result is the same as the one in Theorem 1.1 which is therefore reproved. Our proof here looks like simpler than the one in [5]. On the other hand, compared with the results in [22] and [32], we only need $\theta_{0} \in(0, \pi)$. Moreover, condition (3) of flow (1.5) or (3') of flow (1.6) is stronger than condition (1.4).

In addition to the concavity of $\cot \theta_{\omega}\left(\chi_{u}\right)$, our flow has two advantages: The first one is the imaginary part of the Calabi-Yau functional (see the definition in Section 2) is constant along the flow, which is the key to do the $C^{0}$ estimate; The second one is a subsolution $\underline{u}$ of equation (1.2) satisfying (1.4) is also a subsolution of flow (1.7), which allows us to use Lemma 3 in Phong-Tô [27] to do higher order estimates. If we can establish the similar lemma without extra condition (1.4) of $\underline{u}$, we then can relax condition (1.4).

The second motivation of this paper is to look for applications of flow (1.7). A smooth function $\underline{u}$ is called a semi-subsolution of the dHYM equation if

A_{0}(\underline{u}) \leq \theta_{0} . \tag{1.9}
\end{equation*}
$$

In the 2-dimensional case, this condition is equivalent to

$$
\begin{equation*}
\chi_{\underline{u}} \geq \cot \theta_{0} \omega . \tag{1.10}
\end{equation*}
$$

Now we restrict ourselves to this case.
Assume there exists a semi-subsolution $\underline{u}$ of the dHYM equation and replace $\chi_{\underline{u}}$ by $\chi$, i.e., assume that $\underline{u}=0$ is a semi-subsolution. For any $B_{1} \in(0, \pi)$, define the set

\begin{equation*}
\mathcal{H}_{B_{1}}=\left\{v \in C^{\infty}(M, \mathbb{R}): \theta_{\omega}\left(\chi_{v}\right) \in\left(0, B_{1}\right)\right\} \tag{1.11}
\end{equation*}
$$

Then if $\theta_{0} \in\left(0, \frac{\pi}{2}\right)$, the set $\mathcal{H}_{B_{1}}$ for any $B_{1} \in\left(2 \theta_{0}, \pi\right)$ is non-empty, for example, $0 \in \mathcal{H}_{B_{1}}$; if $\theta_{0} \in\left[\frac{\pi}{2}, \pi\right)$, we can prove that the set $\mathcal{H}_{B_{1}}$ for any $B_{1} \in\left(\theta_{0}, \pi\right)$ is also non-empty, see Lemma 5.2.

We take a function in $\mathcal{H}_{B_{1}}$ for any $B_{1} \in\left(\theta_{0}, \pi\right)$ as $u_{0}$ in flow (1.7). We can state the second main theorem of the paper.

Theorem 1.4. Let $(M, \omega)$ be a compact Kähler surface and $\chi$ a closed real $(1,1)$ form. Assume $\theta_{0} \in(0, \pi)$ and $\chi \geq \cot \theta_{0} \omega$. Then there exist a finite number of curves $E_{i}$ of negative self-intersection on $M$ such that the solution $u(x, t)$ of dHYM flow (1.7) converges to a bounded function $u^{\infty}$ in $C_{l o c}^{\infty}\left(M \backslash \cup_{i} E_{i}\right)$ as tends to $\infty$ with the following properties.
(1) $\chi+\sqrt{-1} \partial \bar{\partial} u^{\infty}-\cot B_{1} \omega$ is a Kähler current which is smooth on $M \backslash \cup_{i} E_{i}$;
(2) $u^{\infty}$ satisfies the dHYM equation on $M \backslash \cup_{i} E_{i}$

$$
\begin{equation*}
\operatorname{Re}\left(\chi_{u^{\infty}}+\sqrt{-1} \omega\right)^{2}=\cot \theta_{0} \operatorname{Im}\left(\chi_{u^{\infty}}+\sqrt{-1} \omega\right)^{2} \tag{1.12}
\end{equation*}
$$

(3) $\chi_{u(x, t)}$ converges to $\chi_{u^{\infty}}$ and $u^{\infty}$ satisfies (1.12) on $M$ in the sense of currents .

We note that by assuming $\theta_{0} \in\left(0, \frac{\pi}{2}\right)$ and $B_{1} \leq \frac{\pi}{2}$, Takahashi [33] proved the same convergence result of the LBMCF. A similar result of the J-flow was studied in Fang-Lai-Song-Weinkove[12]. As done by [12, 33], we need the singular solution of the degenerate complex Monge-Ampère equation (5.4) by Eyssidieux-Guedj-Zeriahi [10], which will be used in the $C^{0}$ estimate. We establish a similar lemma, i.e., Lemma 5.7 as Lemma 3 in [27] by the semi-subsolution condition to do the gradient estimate and the second order estimate. As to the convergence of $u_{t}$, the key point is that along the dHYM flow the real part of the Calabi-Yau functional is uniformly bounded. In this way we can prove Theorem 1.4.

As an application of Theorem 1.4, we have the lower bound of the $\mathcal{J}$-functional on certain spaces, see the definition in Section 2.

Corollary 1.5. Let $(M, \omega)$ be a compact Kähler surface and $\chi$ a closed real $(1,1)$ form. Assume that $\theta_{0} \in(0, \pi)$ and $\chi \geq \cot \theta_{0} \omega$. The $\mathcal{J}$-functional is bounded from below in $\mathcal{H}_{B_{1}}$ for any $B_{1} \in\left(\theta_{0}, \pi\right)$.

If $\theta_{0} \in\left(0, \frac{\pi}{2}\right)$, Takahashi proved that $\mathcal{J}$ is bounded from below in $\mathcal{H}_{\frac{\pi}{2}}$.
We have mentioned that for 2 dimensional case, along the dHYM flow the real part of the Calabi-Yau functional is uniformly bounded. We believe that the same conclusion for
the higher dimension also holds. Hence the real part of the Calabi-Yau functional plays the similar role as the Donaldson functional defined on the space of Hermitian metrics on a holomorphic vector bundle. We expect that we can use our flow to study the moduli space of solutions of the dHYM equation on a compact Kähler manifold $(M, \omega)$.

The rest of this paper is arranged as follows. In Section 2, we give some preliminary results on the linearized operator on the dHYM flow, the concavity of $\cot \theta(\lambda)$, the parabolic subsolution, and the Calabi-Yau functional. In Section 3, we prove Theorem 1.2. In Section 4, we prove Theorem 1.3, including the $C^{0}$ estimate, the gradient estimate and the second order estimate. In Section 5, we prove Theorem 1.4 and Corollary 1.5.

Notations: In this paper a closed real $(1,1)$ form $\chi$ is fixed. We will use the constant $C$ in the generic sense which is dependent on $\omega, \chi, \underline{u}, u_{0}$ and $n$. If necessary, we will use $C_{i}$ as a specific constant.

Notations of covariant derivatives are used. For example, $u_{i j k}$ represents the third order covariant derivative of function $u, \alpha_{i \bar{j}, k}$ represents the covariant derivative of $(1,1)$ form $\alpha$.

We use Einstein summation convention if there is no confusion.

## 2. Preliminary results

### 2.1. The linearized operator. Note

$$
\begin{equation*}
\cot \theta_{\omega}\left(\chi_{u}\right)=\frac{\operatorname{Re}\left(\chi_{u}+\sqrt{-1} \omega\right)^{n}}{\operatorname{Im}\left(\chi_{u}+\sqrt{-1} \omega\right)^{n}} \tag{2.1}
\end{equation*}
$$

We manipulate the linearized operator $\mathcal{P}$ of dHYM flow (1.7) in the following lemma.
Lemma 2.1. The operator $\mathcal{P}$ has the form:

$$
\mathcal{P}(v)=v_{t}-\csc ^{2} \theta_{\omega}\left(\chi_{u}\right)\left(w g^{-1} w+g\right)^{i \bar{j}} v_{i \bar{j}},
$$

where $g=\left(g_{i \bar{j}}\right)_{n \times n}, w=\left(w_{i \bar{j}}\right)_{n \times n}$ for $w_{i \bar{j}}=\chi_{i \bar{j}}+u_{i \bar{j}}$, and $D^{i \bar{j}}:=\left(D^{-1}\right)_{i \bar{j}}$ for an invertible Hermitian symmetric matrix D.

Proof. We only need to deal with the variation of $\cot \theta_{\omega}\left(\chi_{u}\right)$. Indeed, let $u(s)$ be a variation of the function $u$ and $\left.\frac{d u(s)}{d s}\right|_{s=0}=v$. Let $A(s):=g^{-1} w(s)+\sqrt{-1} I$ with $w(s)$ being the local matrix of $\chi_{u(s)}$. Then

\begin{equation*}
A(s)^{-1}=\left(g^{-1} w(s)-\sqrt{-1} I\right)\left(\left(g^{-1} w(s)\right)^{2}+I\right)^{-1} \tag{2.2}
\end{equation*}
$$

For simplicity, we write $A$ instead of $A(s)$. By (2.1) we have

$$
\delta\left(\cot \theta_{\omega}\left(\chi_{u}\right)\right)=\frac{\operatorname{Re}(\delta \operatorname{det} A)}{\operatorname{Im}(\operatorname{det} A)}-\frac{\operatorname{Re}(\operatorname{det} A) \operatorname{Im}(\delta \operatorname{det} A)}{(\operatorname{Im}(\operatorname{det} A))^{2}}
$$

Since $\delta(\operatorname{det} A)=(\operatorname{det} A) \delta(\log \operatorname{det} A)$, if we write $\operatorname{det} A=a_{1}+\sqrt{-1} a_{2}$ and $\delta(\log \operatorname{det} A)=$ $b_{1}+\sqrt{-1} b_{2}$, then

$$
\begin{aligned}
\delta\left(\cot \theta_{\omega}\left(\chi_{u}\right)\right) & =\frac{a_{1} b_{1}-a_{2} b_{2}}{a_{2}}-\frac{a_{1}\left(a_{1} b_{2}+a_{2} b_{1}\right)}{a_{2}^{2}} \\
& =\frac{-a_{1}^{2}-a_{2}^{2}}{a_{2}^{2}} b_{2}=-\csc ^{2} \theta_{\omega}\left(\chi_{u}\right) b_{2} .
\end{aligned}
$$

On the other hand, by (2.2) we have

$$
b_{2}=\operatorname{Im} \delta(\log \operatorname{det} A)=-\operatorname{tr}\left(\left.\left(w g^{-1} w+g\right)^{-1} \delta w(s)\right|_{s=0}\right)=-\left(w g^{-1} w+g\right)^{i \bar{j}} v_{i \bar{j}} .
$$

Hence

$$
\begin{equation*}
\delta\left(\cot \theta_{\omega}\left(\chi_{u}\right)\right)=\csc ^{2} \theta_{\omega}\left(\chi_{u}\right)\left(w g^{-1} w+g\right)^{i \bar{j}} v_{i \bar{j}} . \tag{2.3}
\end{equation*}
$$

We denote

$$
\begin{equation*}
F^{i \bar{j}}:=\csc ^{2} \theta_{\omega}\left(\chi_{u}\right)\left(w g^{-1} w+g\right)^{i \bar{j}} \tag{2.4}
\end{equation*}
$$

and hence

$$
\mathcal{P}(v)=v_{t}-F^{i \bar{j}} v_{i \bar{j}} .
$$

The following lemma is useful in the gradient and second order estimates.
Lemma 2.2. Let u be a solution of dHYM flow (1.7). Then

$$
\begin{equation*}
u_{t p}-F^{i \bar{j}} w_{i \bar{j}, p}=0 \tag{2.5}
\end{equation*}
$$

and

$$
\begin{align*}
u_{t p \bar{p}}-F^{i \bar{j}} w_{i \bar{j}, p \bar{p}}= & -F^{i \bar{l}}\left(w g^{-1} w+g\right)^{k \bar{j}} w_{i \bar{j}, p}\left(w_{k \bar{m}, \bar{p}} g^{r \bar{m}} w_{r \bar{l}}+w_{k \bar{m}} g^{r \bar{m}} w_{r \bar{l}, \bar{p}}\right) \\
& +2 \cot \theta_{\omega}\left(\chi_{u}\right) F^{i \bar{j}} w_{i \bar{j}, p}\left(w g^{-1} w+g\right)^{k \bar{l}} w_{k l \bar{p}, \bar{p}} . \tag{2.6}
\end{align*}
$$

Proof. Similar as the proof of (2.3), differentiating equation (1.7) leads to (2.5) directly:

u_{t p}=\csc ^{2} \theta_{\omega}\left(\chi_{u}\right)\left(w g^{-1} w+g\right)^{i \bar{j}} w_{i \bar{j}, p}=F^{i \bar{j}} w_{i \bar{j}, p} .
$$

Differentiating the equation twice, we have

\begin{align*}
u_{t p \bar{p}}= & \csc ^{2} \theta_{\omega}\left(\chi_{u}\right)\left(w g^{-1} w+g\right)^{i \bar{j}} w_{i \bar{j}, p \bar{p}}+\left(\csc ^{2} \theta_{\omega}\left(\chi_{u}\right)\right)_{\bar{p}}\left(w g^{-1} w+g\right)^{i \bar{j}} w_{i \bar{j}, p} \\
& -\csc ^{2} \theta_{\omega}\left(\chi_{u}\right)\left(w g^{-1} w+g\right)^{i \bar{l}}\left(w g^{-1} w+g\right)^{k \bar{j}} w_{i \bar{j}, p}\left(w g^{-1} w+g\right)_{k \bar{l} \bar{p}} \tag{2.7}
\end{align*}
$$

where

$$
\left(\csc ^{2} \theta_{\omega}\left(\chi_{u}\right)\right)_{\bar{p}}=2 \cot \theta_{\omega}\left(\chi_{u}\right)\left(\cot \theta_{\omega}\left(\chi_{u}\right)\right)_{\bar{p}}=2 \cot \theta_{\omega}\left(\chi_{u}\right) F^{k \bar{l}} w_{k \bar{l}, \bar{p}}
$$

and

$$
\left(w g^{-1} w+g\right)_{k \bar{l}, \bar{p}}=\left(w_{k \bar{m}} g^{r \bar{m}} w_{r \bar{l}}+g_{k \bar{l}}\right)_{\bar{p}}=w_{k \bar{m}, \bar{p}} g^{r \bar{m}} w_{r \bar{l}}+w_{k \bar{m}} g^{r \bar{m}} w_{r \bar{l}, \bar{p}} .
$$

Hence identity (2.6) follows.
2.2. The concavity of $\cot \theta(\lambda)$ in $\Gamma_{\tau}$ for $\tau \in(0, \pi)$. Here

$$
\begin{equation*}
\theta(\lambda):=\sum_{i=1}^{n} \operatorname{arccot} \lambda_{i} \quad \text { for } \lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right) \in \mathbb{R}^{n} \tag{2.8}
\end{equation*}
$$

and

$$
\Gamma_{\tau}:=\left\{\lambda \in \mathbb{R}^{n} \mid \theta(\lambda)<\tau\right\} \subset \mathbb{R}^{n} \quad \text { for } \tau \in(0, \pi)
$$

We have the following useful facts.
Lemma 2.3 (Yuan [37], Wang-Yuan [35]). If $\theta(\lambda) \leq \tau \in(0, \pi)$ for $\lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right)$ with $\lambda_{1} \geq \lambda_{2} \geq \cdots \geq \lambda_{n}$, then the following inequalities holds.
(1) $\lambda_{1} \geq \lambda_{2} \geq \cdots \geq \lambda_{n-1} \geq \cot \frac{\tau}{2}>0$, and $\lambda_{n-1} \geq\left|\lambda_{n}\right|$;
(2) $\lambda_{1}+(n-1) \lambda_{n} \geq 0$.

Moreover, $\Gamma_{\tau}$ is convex for any $\tau \in(0, \pi)$.
Lemma 2.4 (Chen [2]). For any $\tau \in(0, \pi)$, the function $\cot \theta(\lambda)$ on $\Gamma_{\tau}$ is concave.
Proof. For completeness, we give an elementary proof here. When $n=1, \cot \theta(\lambda)=\lambda_{1}$ is obviously concave. We now assume $n \geq 2$. By definition (2.8) we have

\frac{\partial^{2} \cot \theta(\lambda)}{\partial \lambda_{i} \partial \lambda_{j}} & =-\frac{\partial}{\partial \lambda_{j}}\left(\csc ^{2} \theta(\lambda) \frac{\partial \theta(\lambda)}{\partial \lambda_{i}}\right)=\frac{\partial}{\partial \lambda_{j}}\left(\frac{\csc ^{2} \theta(\lambda)}{1+\lambda_{i}^{2}}\right) \\
& =-2 \csc ^{2} \theta(\lambda)\left(\frac{\lambda_{i} \delta_{i j}}{\left(1+\lambda_{i}^{2}\right)^{2}}-\frac{\cot \theta(\lambda)}{\left(1+\lambda_{i}^{2}\right)\left(1+\lambda_{j}^{2}\right)}\right) \tag{2.9}
\end{align*}
$$

Hence the function $\cot \theta(\lambda)$ on $\Gamma_{\tau}$ is concave if and only if the matrix

$$
\Lambda=\left(\lambda_{i} \delta_{i j}-\cot \theta(\lambda)\right)_{n \times n}
$$

is positive definite. Without loss of generality, we assume $\lambda_{1} \geq \lambda_{2} \geq \cdots \geq \lambda_{n}$. Since $\theta(\lambda) \in(0, \pi)$, by Lemma 2.3 (1), we have $\lambda_{n-1}>0$.

By the definition of $\theta(\lambda)$, for any $1 \leq j_{1}<j_{2}<\cdots<j_{k}, 1 \leq k \leq n-1$, we have $\sum_{l=1}^{k} \operatorname{arccot} \lambda_{j_{l}}<\theta(\lambda)$. Hence

$$
\begin{equation*}
\operatorname{Re}\left(\prod_{l=1}^{k}\left(\lambda_{j_{l}}+\sqrt{-1}\right)\right)-\cot \theta(\lambda) \operatorname{Im}\left(\prod_{l=1}^{k}\left(\lambda_{j_{l}}+\sqrt{-1}\right)\right)>0 . \tag{2.10}
\end{equation*}
$$

Let $\sigma_{i}\left(\lambda_{j_{1} j_{2} \ldots j_{k}}\right)$ for $1 \leq i \leq k$ be the $i$-th elementary symmetric polynomial of $\lambda_{j_{1}}, \lambda_{j_{2}}, \ldots, \lambda_{j_{k}}$. Then (2.10) can be written as

$$
\begin{equation*}
\sum_{i=0}^{[k / 2]}(-1)^{i} \sigma_{k-2 i}\left(\lambda_{j_{1} j_{2} \ldots j_{k}}\right)-\cot \theta(\lambda) \sum_{i=0}^{[(k-1) / 2]}(-1)^{i} \sigma_{k-1-2 i}\left(\lambda_{j_{1} j_{2} \ldots j_{k}}\right)>0 \tag{2.11}
\end{equation*}
$$

Denote by $D_{k}$ the $k$-th leading principal minor of the matrix $\Lambda$. We need to prove $D_{k}>0$ for any $1 \leq k \leq n$. When $k=1, D_{1}=\lambda_{1}-\cot \theta(\lambda)>0$. When $2 \leq k \leq n$, by direct computation, we have

$$
D_{k}=\sigma_{k}\left(\lambda_{12 \ldots k}\right)-\cot \theta(\lambda) \sigma_{k-1}\left(\lambda_{12 \ldots k}\right) .
$$

Hence by (2.11), we have

$$
\begin{aligned}
D_{k} & >-\sum_{i=1}^{[k / 2]}(-1)^{i} \sigma_{k-2 i}\left(\lambda_{12 \ldots k}\right)+\cot \theta(\lambda) \sum_{i=1}^{[(k-1) / 2]}(-1)^{i} \sigma_{k-1-2 i}\left(\lambda_{12 \ldots k}\right) \\
& =: E_{k-2}\left(\lambda_{12 \ldots k}\right)
\end{aligned}
$$

We prove $E_{k-2}\left(\lambda_{12 \ldots k}\right)>0$ for any $2 \leq k \leq n$.
We use the well-known formula

$$
\begin{equation*}
\sigma_{i}\left(\lambda_{12 \ldots k}\right)=\sigma_{i}\left(\lambda_{2 \ldots k}\right)+\lambda_{1} \sigma_{i-1}\left(\lambda_{2 \ldots k}\right) \tag{2.12}
\end{equation*}
$$

for $1 \leq i \leq k-1$ to deduce that

$$
\begin{equation*}
E_{k-2}\left(\lambda_{12 \ldots k}\right)=F_{k-2}\left(\lambda_{2 \ldots k}\right)+\lambda_{1} E_{k-3}\left(\lambda_{2 \ldots k}\right) \tag{2.13}
\end{equation*}
$$

where

$$
\begin{aligned}
F_{k-2}\left(\lambda_{2 \ldots k}\right) & =-\sum_{i=1}^{[k / 2]}(-1)^{i} \sigma_{k-2 i}\left(\lambda_{2 \ldots k}\right)+\cot \theta(\lambda) \sum_{i=1}^{[(k-1) / 2]}(-1)^{i} \sigma_{k-1-2 i}\left(\lambda_{2 \ldots k}\right) \\
& =\sum_{j=0}^{[(k-2) / 2]}(-1)^{j} \sigma_{k-2-2 j}\left(\lambda_{2 \ldots k}\right)-\cot \theta(\lambda) \sum_{j=0}^{[(k-3) / 2]}(-1)^{j} \sigma_{k-3-2 j}\left(\lambda_{2 \ldots k}\right)
\end{aligned}
$$

and

$$
\begin{aligned}
E_{k-3}\left(\lambda_{2 \ldots k}\right) & =-\sum_{i=1}^{[k / 2]}(-1)^{i} \sigma_{k-2 i-1}\left(\lambda_{2 \ldots k}\right)+\cot \theta(\lambda) \sum_{i=1}^{[(k-1) / 2]}(-1)^{i} \sigma_{k-2-2 i}\left(\lambda_{2 \ldots k}\right) \\
& =\sum_{j=0}^{[(k-2) / 2]}(-1)^{j} \sigma_{k-3-2 j}\left(\lambda_{2 \ldots k}\right)-\cot \theta(\lambda) \sum_{j=0}^{[(k-3) / 2]}(-1)^{j} \sigma_{k-4-2 j}\left(\lambda_{2 \ldots k}\right) .
\end{aligned}
$$

By (2.12) we compute directly to get

$$
F_{k-2}\left(\lambda_{2 \ldots k}\right)=\operatorname{Re}\left(\prod_{j=3}^{k}\left(\lambda_{j}+\sqrt{-1}\right)\right)-\cot \theta(\lambda) \operatorname{Im}\left(\prod_{j=3}^{k}\left(\lambda_{j}+\sqrt{-1}\right)\right)+\lambda_{2} F_{k-3}\left(\lambda_{3 \ldots k}\right) .
$$

Hence

$$
F_{k-2}\left(\lambda_{2 \ldots k}\right)>\lambda_{2} F_{k-3}\left(\lambda_{3 \ldots k}\right) .
$$

From this we deduce that

$$
F_{k-2}\left(\lambda_{2 \ldots k}\right)>\lambda_{2} \lambda_{3} \cdots \lambda_{k-2} F_{1}\left(\lambda_{(k-1) k}\right)=\lambda_{2} \lambda_{3} \cdots \lambda_{k-2}\left(\lambda_{k-1}+\lambda_{k}-\cot \theta(\lambda)\right)>0
$$

Combined with (2.13), we have

$$
E_{k-2}\left(\lambda_{12 \ldots k}\right)>\lambda_{1} E_{k-3}\left(\lambda_{2 \ldots k}\right)
$$

Hence for any $2 \leq k \leq n$ we have

$$
\begin{aligned}
E_{k-2}\left(\lambda_{12 \ldots k}\right) & >\lambda_{1} \lambda_{2} \cdots \lambda_{k-3} E_{1}\left(\lambda_{(k-2)(k-1) k}\right) \\
& =\lambda_{1} \lambda_{2} \cdots \lambda_{k-3}\left(\lambda_{k-2}+\lambda_{k-1}+\lambda_{k}-\cot \theta(\lambda)\right)>0 .
\end{aligned}
$$

In summary, we finish the proof of the lemma.
2.3. Parabolic subsolution. B. Guan [14] introduced the definition of a subsolution of fully non-linear equations. G. Székelyhidi [31] gave a weaker version of a subsolution and Collins-Jacob-Yau [5] used it to the dHYM equation which is equivalent to (1.3). These two notions are equivalent for the type 1 cones by the appendix in [15]. On the other hand, Phong-Tô [27] modified the definition in [14] and [31] to the parabolic case. We use their definition to the parabolic dHYM equation.

Definition 2.5. A smooth function $\underline{u}(x, t)$ on $M \times[0, T)$ is called a subsolution of parabolic $d H Y M$ equation (1.7) if there exists a constant $\delta>0$ such that for any $(x, t) \in M \times[0, T)$, the subset of $\mathbb{R}^{n+1}$

$$
\begin{gathered}
S_{\delta}(x, t):=\left\{(\mu, \tau) \in \mathbb{R}^{n} \times \mathbb{R} \mid \cot \theta\left(\lambda\left(\chi_{\underline{u}(x, t)}\right)+\mu\right)-\underline{u}_{t}(x, t)+\tau=\cot \theta_{0},\right. \\
\left.\mu_{i}>-\delta \text { for } 1 \leq i \leq n \text { and } \tau>-\delta\right\}
\end{gathered}
$$

is uniformly bounded, i.e., it is contained in the ball $B_{K}^{n+1}(0)$ in $\mathbb{R}^{n+1}$ with radius $K$, a uniform constant.

We have the following observation.
Lemma 2.6. If $\underline{u}$ is a subsolution of $d H Y M$ equation (1.1) with $B_{0}(\underline{u})<\pi$, then the function $\underline{u}(x, t)=\underline{u}(x)$ on $M \times[0, \infty)$ is also a subsolution of parabolic dHYM equation (1.7).

Proof. We want to find a constant $\delta$ in Definition 2.5. If such a $\delta$ exists, we let $(\mu, \tau) \in$ $S_{\delta}(x, t)$ for $(x, t) \in M \times[0, \infty)$. Since $\mu_{i}>-\delta$ for each $1 \leq i \leq n$, by the definition of $B_{0}(\underline{u})$ in (1.4) we have

$$
0<\theta\left(\lambda\left(\chi_{\underline{u}(x)}\right)+\mu\right) \leq \theta_{\omega}\left(\chi_{\underline{u}(x)}\right)+n \delta \leq B_{0}(\underline{u})+n \delta .
$$

Hence if $0<\delta \leq \frac{\pi-B_{0}(\underline{u})}{2 n}$, then

$$
0<\theta\left(\lambda\left(\chi_{\underline{u}(x)}\right)+\mu\right)<\frac{\pi+B_{0}(\underline{u})}{2}<\pi
$$

and by the definition of $S_{\delta}(x, t), \tau$ is bounded from above:

$$
\tau=\cot \theta_{0}-\cot \theta\left(\lambda\left(\chi_{\underline{u}(x)}\right)+\mu\right) \leq \cot \theta_{0}-\cot \left(\frac{\pi+B_{0}(\underline{u})}{2}\right) .
$$

Since also $\mu_{i}>-\delta$ for each $1 \leq i \leq n$, by subsolution condition (1.3) we have

$$
\sum_{i \neq j} \operatorname{arccot}\left(\lambda_{i}\left(\chi_{\underline{u}(x)}\right)+\mu_{i}\right) \leq \sum_{i \neq j} \operatorname{arccot}_{i}\left(\chi_{\underline{u}(x)}\right)+(n-1) \delta \leq A_{0}(\underline{u})+(n-1) \delta .
$$

If $0<\delta \leq \frac{\theta_{0}-A_{0}(\underline{u})}{2(n+1)}$, then

$$
\sum_{i \neq j} \operatorname{arccot}\left(\lambda_{i}\left(\chi_{\underline{u}(x)}\right)+\mu_{i}\right) \leq \frac{\theta_{0}+A_{0}(\underline{u})}{2}
$$

Since $\tau>-\delta$, by the definition of $S_{\delta}(x, t)$ we have for each $j$

$$
\begin{aligned}
\operatorname{arccot}\left(\lambda_{j}\left(\chi_{\underline{u}}\right)+\mu_{j}\right) & =\operatorname{arccot}\left(\cot \theta_{0}-\tau\right)-\sum_{i \neq j} \operatorname{arccot}\left(\lambda_{i}\left(\chi_{\underline{u}}\right)+\mu_{i}\right) \\
& \geq \operatorname{arccot}\left(\cot \theta_{0}+\delta\right)-\sum_{i \neq j} \operatorname{arccot}\left(\lambda_{i}\left(\chi_{\underline{u}}\right)+\mu_{i}\right) \\
& \geq \theta_{0}-\delta-\frac{\theta_{0}+A_{0}(\underline{u})}{2} \geq \frac{n\left(\theta_{0}-A_{0}(\underline{u})\right)}{2(n+1)}>0 .
\end{aligned}
$$

Hence we have

$$
\mu_{j} \leq \max _{M}\left|\lambda\left(\chi_{\underline{u}(x)}\right)\right|+\cot \left(\frac{n\left(\theta_{0}-A_{0}(\underline{u})\right)}{2(n+1)}\right) .
$$

Therefore, if we choose $\delta=\min \left\{\frac{\pi-B_{0}(\underline{u})}{2 n}, \frac{\theta_{0}-A_{0}(\underline{u})}{2(n+2)}\right\}$, then for any $(x, t) \in M \times[0, \infty)$ and $(\mu, \tau) \in S_{\delta}(x, t)$, we have

$$
|\mu|+|\tau| \leq K:=2 n\left(\delta+\max _{M}\left|\lambda\left(\chi_{\underline{u}}\right)\right|+\cot \theta_{0}-\cot \left(\frac{\pi+B_{0}(\underline{u})}{2}\right)+\cot \left(\frac{n\left(\theta_{0}-A_{0}(\underline{u})\right)}{2(n+1)}\right)\right) .
$$

2.4. The Calabi-Yau Functional. Recall the definition of the Calabi-Yau functional by Collins-Yau [8]: for any $v \in C^{2}(M, \mathbb{R})$,

\mathrm{CY}_{\mathbb{C}}(v):=\frac{1}{n+1} \sum_{i=0}^{n} \int_{M} v\left(\chi_{v}+\sqrt{-1} \omega\right)^{i} \wedge(\chi+\sqrt{-1} \omega)^{n-i}
$$

The $\mathcal{J}$-functional is defined by

$$
\mathcal{J}(v):=\operatorname{Im}\left(e^{-\sqrt{-1} \theta_{0}} \mathrm{CY}_{\mathbb{C}}(v)\right)
$$

Let $v(s) \in C^{2,1}(M \times[0, T], \mathbb{R})$ be a variation of the function $v$, i.e., $v(0)=v$. The integration by parts gives

$$
\begin{align*}
\frac{d}{d s} \mathrm{CY}_{\mathbb{C}}(v(s)) & =\int_{M} \frac{\partial v(s)}{\partial s}\left(\chi_{v(s)}+\sqrt{-1} \omega\right)^{n},  \tag{2.14}\\
\frac{d}{d s} \mathcal{J}(v(s)) & =\int_{M} \frac{\partial v(s)}{\partial s} \operatorname{Im}\left(e^{-\sqrt{-1} \theta_{0}}\left(\chi_{v(s)}+\sqrt{-1} \omega\right)^{n}\right) . \tag{2.15}
\end{align*}
$$

Lemma 2.7. Let $u(x, t)$ be a solution of dHYM flow (1.7). Then

$$
\begin{align*}
& \operatorname{Im}\left(\mathrm{CY}_{\mathbb{C}}(u(\cdot, t))\right)=\operatorname{Im}\left(\mathrm{CY}_{\mathbb{C}}\left(u_{0}\right)\right)  \tag{2.16}\\
& \frac{d}{d t} \operatorname{Re}\left(\mathrm{CY}_{\mathbb{C}}(u(\cdot, t))\right)=\int_{M}\left(\frac{\partial u(t)}{\partial t}\right)^{2} \operatorname{Im}\left(\chi_{u}+\sqrt{-1} \omega\right)^{n},  \tag{2.17}\\
& \left.\frac{d}{d t} \mathcal{J}(u(\cdot, t))\right) \leq 0 \tag{2.18}
\end{align*}
$$

Proof. Denote by $u(t):=u(x, t)$ for simplicity. Then we have

$$
\begin{aligned}
& \frac{d}{d t} \operatorname{Im}\left(\operatorname{CY}_{\mathbb{C}}(u(t))\right) \\
= & \int_{M} \frac{\partial u(t)}{\partial t} \operatorname{Im}\left(\chi_{u(t)}+\sqrt{-1} \omega\right)^{n} \\
= & \int_{M}\left(\frac{\operatorname{Re}\left(\chi_{u(t)}+\sqrt{-1} \omega\right)^{n}}{\operatorname{Im}\left(\chi_{u(t)}+\sqrt{-1} \omega\right)^{n}}-\cot \theta_{0}\right) \operatorname{Im}\left(\chi_{u(t)}+\sqrt{-1} \omega\right)^{n} \\
= & \int_{M} \operatorname{Re}(\chi+\sqrt{-1} \omega)^{n}-\cot \theta_{0} \int_{M} \operatorname{Im}(\chi+\sqrt{-1} \omega)^{n} \\
= & 0
\end{aligned}
$$

where each equality is successively by (2.14), (1.7) and (2.1), Stokes' theorem, and the definition of $\theta_{0}$. Hence (2.16) holds as $u(0)=u_{0}$.

Then we can also prove (2.17).

$$
\begin{aligned}
& \frac{d}{d t} \operatorname{Re}(\operatorname{CY} \\
= & \int_{M} \frac{\partial u(t)}{\partial t} \operatorname{Re}\left(\chi_{u(t)}+\sqrt{-1} \omega\right)^{n} \\
= & \int_{M} \frac{\partial u(t)}{\partial t} \cot \theta_{\omega}\left(\chi_{u(t)}\right) \operatorname{Im}\left(\chi_{u(t)}+\sqrt{-1} \omega\right)^{n} \\
= & \int_{M} \frac{\partial u(t)}{\partial t}\left(\frac{\partial u(t)}{\partial t}+\cot \theta_{0}\right) \operatorname{Im}\left(\chi_{u(t)}+\sqrt{-1} \omega\right)^{n} \\
= & \int_{M}\left(\frac{\partial u(t)}{\partial t}\right)^{2} \operatorname{Im}\left(\chi_{u(t)}+\sqrt{-1} \omega\right)^{n},
\end{aligned}
$$

where the last equality follows from (2.16).

Locally

$$
\begin{aligned}
& \frac{\partial u(t)}{\partial t} \operatorname{Im}\left(e^{-\sqrt{-1} \theta_{0}}\left(\chi_{u}+\sqrt{-1} \omega\right)^{n}\right) \\
= & \prod_{i=1}^{n}\left(1+\lambda_{i}^{2}\right)\left(\cot \theta_{\omega}\left(\chi_{u(t)}\right)-\cot \theta_{0}\right) \sin \left(\theta_{\omega}\left(\chi_{u(t)}\right)-\theta_{0}\right) \omega^{n} \\
= & -\prod_{i=1}^{n}\left(1+\lambda_{i}^{2}\right) \frac{\sin ^{2}\left(\theta_{\omega}\left(\chi_{u(t)}\right)-\theta_{0}\right)}{\sin \theta_{\omega}\left(\chi_{u(t)}\right) \sin \theta_{0}} \omega^{n} \leq 0,
\end{aligned}
$$

where the last inequality follows from $\theta_{\omega}\left(\chi_{u(t)}\right) \in(0, \pi)$ by (3.2). Hence $\mathcal{J}$ is decreasing and (2.18) follows.

Next we prove that along the dHYM flow the real part of the Calabi-Yau functional can be controlled by $|u|_{L^{\infty}}$ without the subsolution condition.

Proposition 2.8. Let $u(x, t)$ be a solution of $d H Y M$ flow (1.7) with the initial data satisfying (1.8). Then there exists a uniform constant $C$ such that

$$
\begin{equation*}
\operatorname{Re}\left(\mathrm{CY}_{\mathbb{C}}(u)\right) \leq C|u|_{L^{\infty}} . \tag{2.19}
\end{equation*}
$$

Proof. By the definition of the Calabi-Yau functional, we only need to prove that for any $0 \leq k, l \leq n$ with $0 \leq k+l \leq n$

$$
\begin{equation*}
\left|\int_{M} u \chi_{u}^{k} \wedge \chi^{l} \wedge \omega^{n-k-l}\right| \leq C|u|_{L^{\infty}} \tag{2.20}
\end{equation*}
$$

We prove the above estimates by inductive argument on $k$. When $k=0$, it obviously holds. Now assume inequality (2.20) holds for $k \leq m$ with $0 \leq k+l \leq n$. We prove inequality (2.20) holds for $k=m+1$. Indeed, since along the flow by (3.2) $\chi_{u} \geq-\cot B_{0}\left(u_{0}\right) \omega$, there exists a constant $C_{0}>0$ such that $\chi_{u}+C_{0} \omega>0$ and $\chi+C_{0} \omega>0$. We write

$$
\begin{aligned}
\int_{M} u \chi_{u}^{m+1} \wedge \chi^{l} \wedge \omega^{n-m-l-1}= & \int_{M} u\left(\chi_{u}+C_{0} \omega\right)^{m+1} \wedge\left(\chi+C_{0} \omega\right)^{l} \wedge \omega^{n-m-l-1} \\
& -\sum_{p=0}^{m} \sum_{q=0}^{l} C_{p q} \int_{M} u \chi_{u}^{p} \wedge \chi^{q} \wedge \omega^{n-p-q}
\end{aligned}
$$

for some constants $C_{p q}$. Now

$$
\begin{align*}
& \left|\int_{M} u\left(\chi_{u}+C_{0} \omega\right)^{m+1} \wedge\left(\chi+C_{0} \omega\right)^{l} \wedge \omega^{n-m-1-l}\right| \\
\leq & |u|_{L^{\infty}}\left|\int_{M}\left(\chi_{u}+C_{0} \omega\right)^{m+1} \wedge\left(\chi+C_{0} \omega\right)^{l} \wedge \omega^{n-m-l-1}\right| \\
= & |u|_{L^{\infty}}\left|\int_{M}\left(\chi+C_{0} \omega\right)^{m+l+1} \wedge \omega^{n-m-l-1}\right| \\
\leq & C_{1}|u|_{L^{\infty}} \tag{2.21}
\end{align*}
$$

and then by inductive assumption, inequality (2.20) follows.
3. The existence of the longtime solution and proof of Theorem 1.2

In this section we prove Theorem 1.2, i.e. the following
Theorem 3.1. Let $(M, \omega)$ be a compact Kähler manifold and $\chi$ a closed real $(1,1)$ form with $\theta_{0} \in(0, \pi)$. If $u_{0}$ satisfies inequality (1.8), then dHYM flow (1.7) has a unique smooth longtime solution $u$.

We assume that $u$ is the solution of dHYM flow (1.7) in $M \times[0, T)$, where $T$ is the maximal existence time. By showing the uniform a priori estimates in the following subsections, we can prove $T=\infty$.

### 3.1. The $u_{t}$ estimate.

Lemma 3.2. Let $u(x, t)$ be a solution of $d H Y M$ flow (1.7) with the initial data satisfying (1.8). For any $(x, t) \in M \times[0, T)$,

$$
\begin{equation*}
\left.\min _{M} u_{t}\right|_{t=0} \leq u_{t}(x, t) \leq \max _{M} u_{t \mid t=0} \tag{3.1}
\end{equation*}
$$

in particular,

$$
\begin{equation*}
0<\min _{M} \theta_{\omega}\left(\chi_{u_{0}(x)}\right) \leq \theta_{\omega}\left(\chi_{u(x, t)}\right) \leq B_{0}\left(u_{0}\right)<\pi \tag{3.2}
\end{equation*}
$$

Proof. The $u_{t}$ satisfies the equation:

$$
\left(u_{t}\right)_{t}=F^{i \bar{j}}\left(u_{t}\right)_{i \bar{j}}
$$

By the maximum principle, $u_{t}$ attains its maximum and minimum on the initial time, i.e., inequality (3.1) holds, i.e.,

$$
\min _{M} \cot \theta_{\omega}\left(\chi_{u_{0}}\right) \leq u_{t}(x, t)+\cot \theta_{0} \leq \max _{M} \cot \theta_{\omega}\left(\chi_{u_{0}}\right),
$$

or

$$
\min _{M} \cot \theta_{\omega}\left(\chi_{u_{0}}\right) \leq \cot \theta_{\omega}\left(\chi_{u(x, t)}\right) \leq \max _{M} \cot \theta_{\omega}\left(\chi_{u_{0}}\right) .
$$

Thus we obtain

0<\min _{M} \theta_{\omega}\left(\chi_{u_{0}}\right) \leq \theta_{\omega}\left(\chi_{u(x, t)}\right) \leq \max _{M} \theta_{\omega}\left(\chi_{u_{0}}\right)=B_{0}\left(u_{0}\right)

We have a useful corollary of the above lemma.
Corollary 3.3. Let $\lambda_{n}(x, t)$ be the smallest eigenvalue of $\chi_{u}$ with respect to the metric $\omega$ at $(x, t)$. Then

3.2. The complex Hessian estimate. For any $T_{0}<T$, we have proved $u_{t}$ is uniformly bounded and thus $|u| \leq C T_{0}+\left|u_{0}\right|_{C^{0}}$ in $M \times\left[0, T_{0}\right]$. We next prove the complex Hessian estimate.

Proposition 3.4. Let $u(x, t)$ be a solution of $d H Y M$ flow (1.7) with the initial data satisfying (1.8). There exists a uniform constant $C$ such that

Proof. Denote $w_{i \bar{j}}:=\chi_{i \bar{j}}+u_{i \bar{j}}$ as before. Denote $S\left(T^{1,0} M\right):=\bigcup_{x \in M}\left\{\left.\xi \in T_{x}^{1,0} M| | \xi\right|_{\omega}=1\right\}$. Consider on $S\left(T^{1,0} M\right) \times\left[0, T_{0}\right]$ the auxiliary function

where $K_{0}$ is a uniformly large constant to be chosen later.
Suppose the function $\tilde{Q}$ attains its maximum at $\left(x_{0}, t_{0}\right)$ along the direction $\xi_{0}=\xi\left(x_{0}\right)$. We will prove that $t_{0}=0$ and thus the estimate follows. If $t_{0}>0$, we choose holomorphic coordinates near $x_{0}$ such that

which forces $\xi_{0}=\frac{\partial}{\partial z_{1}}$. We extend $\xi_{0}$ near $x_{0}$ as $\tilde{\xi}_{0}(x)=\left(g_{1 \overline{1}}\right)^{-\frac{1}{2}} \frac{\partial}{\partial z_{1}}$. Then the function $Q(x, t)=\tilde{Q}\left(x, t, \tilde{\xi}_{0}(x)\right)$ on $M \times\left[0, T_{0}\right]$ attains its maximum at $\left(x_{0}, t_{0}\right)$.

By the maximum principle, we have at $\left(x_{0}, t_{0}\right)$

= & -\sum_{i \neq j} F^{\bar{i}}\left(1+\lambda_{j}^{2}\right)^{-1}\left(\lambda_{i}+\lambda_{j}\right)\left|w_{i \bar{j}, 1}\right|^{2}-2 F^{\bar{i}} \lambda_{i}\left(1+\lambda_{i}^{2}\right)^{-1}\left|w_{i, \bar{i}, 1}\right|^{2} \\
& +2 \cot \theta_{\omega}\left(\chi_{u}\right) \csc ^{2} \theta_{\omega}\left(\chi_{u}\right)\left(1+\lambda_{i}^{2}\right)^{-1}\left(1+\lambda_{j}^{2}\right)^{-1} w_{\bar{i}, 1} w_{j \bar{j}, \overline{1}} . \tag{3.6}
\end{align*}

However since $\cot \theta(\lambda)$ is concave, by (2.9)

Inserting the above into (3.8) and choosing $K_{0}=2 n A_{2}|R m|_{C^{0}}+1$, we have

3.3. Proof of Theorem 3.1. Since we have proved the $u_{t}$ estimate, the $C^{0}$ estimate and the complex Hessian estimate, by the concavity of the flow (1.7), we can apply the EvansKrylov theory to get the higher order estimates of the solution.

If the maximal existence time $T<\infty$, then $u$ is uniformly $C^{k}$-bounded (for any $k \geq 0$ ) in $M \times[0, T]$ and then there exists $\epsilon>0$ such that the flow exists on $M \times\left[0, T+\epsilon_{0}\right]$, which is a contradiction since $T$ is the maximal existence time. Thus $T=\infty$.

## 4. Convergence of longtime solution and proof of Theorem 1.3

In this section, we prove Theorem 1.3, i.e., the following
Theorem 4.1. Let $(M, \omega)$ be a compact Kähler manifold of dimension $n$ and $\chi$ a closed real $(1,1)$ form with $\theta_{0} \in(0, \pi)$. Suppose dHYM equation (1.2) has a subsolution $\underline{u}$ in the sense of (1.3) which also satisfies (1.4). If $u_{0}$ satisfies (1.8), then the longtime solution $u(x, t)$ of dHYM flow (1.7) converges to a smooth solution $u^{\infty}$ to the dHYM equation:

$$

4.1. The $C^{0}$ estimate. We first prove a Harnack type inequality along the dHYM flow.

Lemma 4.2. Let $u$ be the solution of the $d H Y M$ flow on $M \times[0, \infty)$. Then for any $T_{0}<\infty$ we have the following Harnack type inequality:

Then by the convexity of $\Gamma_{\omega, B_{0}\left(u_{0}\right)}:=\left\{\alpha \in \Lambda^{1,1}(M, \mathbb{R}) \mid \theta_{\omega}(\alpha)<B_{0}\left(u_{0}\right)\right\}$ in Lemma 2.4, we have

\geq & \left\{\begin{array}{l}
\sin \eta_{0}, \text { if } \theta_{\omega}\left(\chi_{s u(t)+(1-s) u_{0}}\right) \geq \frac{\pi}{6} \\
\sqrt{1+\lambda_{1}^{2}} \sin \operatorname{arccot} \lambda_{1}
\end{array}\right. \\
\geq 1, \text { if } \theta_{\omega}\left(\chi_{s u(t)+(1-s) u_{0}}\right)<\frac{\pi}{6} \tag{4.1}
\end{array}\right]
$$

By Lemma 2.7, the imaginary part of the Calabi-Yau functional is constant along the flow. Hence,

& =\int_{M}\left(u(t)-u_{0}\right)\left(\int_{0}^{1} \operatorname{Im}\left(\chi_{s u(t)+(1-s) u_{0}}+\sqrt{-1} \omega\right)^{n} d s\right) . \tag{4.2}

&= \frac{1}{c_{0}} \int_{M}-\left(u-u_{0}\right) \underbrace{\left(-c_{0} \omega^{n}+\int_{0}^{1} \operatorname{Im}\left(\chi_{s u(t)+(1-s) u_{0}}+\sqrt{-1} \omega\right)^{n} d s\right)}_{\text {This term is nonnegative by }(4.1)} \\
&-\inf _{M \times\left[0, T_{0}\right]}\left(u-u_{0}\right) \\
& c_{0} \int_{M}\left(-c_{0} \omega^{n}+\int_{0}^{1} \operatorname{Im}\left(\chi_{s u(t)+(1-s) u_{0}}+\sqrt{-1} \omega\right)^{n} d s\right) \\
&-\inf _{M \times\left[0, T_{0}\right]}\left(u-u_{0}\right) \\
& c_{0} \\
&\left.-c_{0} \int_{M} \omega^{n}+\int_{0}^{1} \operatorname{Im} \int_{M}\left(\chi_{s u(t)+(1-s) u_{0}}+\sqrt{-1} \omega\right)^{n} d s\right) \\
&= \frac{\inf _{\left.M \times 0, T_{0}\right]}\left(u-u_{0}\right)}{c_{0}}\left(-c_{0} \int_{M} \omega^{n}+\operatorname{Im} \int_{M}(\chi+\sqrt{-1} \omega)^{n}\right) \\
& \leq c_{0}^{-1} \operatorname{Im} \int_{M}(\chi+\sqrt{-1} \omega)^{n}\left(-\inf _{M \times\left[0, T_{0}\right]}\left(u-u_{0}\right)\right) \\
&= C\left(-\inf _{M \times\left[0, T_{0}\right]}\left(u-u_{0}\right)\right),
\end{aligned}

where $C=c_{0}^{-1} \operatorname{Im} \int_{M}(\chi+\sqrt{-1} \omega)^{n}$. Therefore we have

4.2. The gradient estimate. We can use the following lemma by Phong-Tô which plays an important role in the gradient and second order estimates. In fact, it follows from the concavity of the function $\cot \theta\left(\chi_{u}\right)$.

Lemma 4.4. [27] Let $\delta$ and $K$ be two constants in Definition 2.5. There exists a constant $\kappa_{0}$ depending only on $\delta, K, \underline{u},(M, \omega)$, and $\chi$ such that if

We prove the gradient estimate following the argument in the elliptic case by CollinsYau [8].

Proposition 4.5. Let u be the solution of dHYM flow (1.7). There exists a uniform constant $M_{1}$ such that

We consider the function

For any fixed time $T_{0}<\infty$, assume the function $\tilde{G}$ on $M \times\left[0, T_{0}\right]$ attains its maximum at $\left(x_{0}, t_{0}\right)$. If $t_{0}=0$, we have the desired estimate directly. Hence we assume $t_{0}>0$.

The function $G:=\log \tilde{G}=\log |\nabla u|^{2}+\psi(u)$ also attains its maximum at $\left(x_{0}, t_{0}\right)$. By the maximum principle, we have $\mathcal{P} G\left(x_{0}, t_{0}\right) \geq 0$.

Take the holomorphic coordinates (3.3) near $x_{0}$. By (2.4)

& -\frac{\left(u_{k i} u_{\bar{k}}+u_{k} u_{\bar{k} i}\right)\left(u_{\bar{j}} u_{\bar{l}}+u_{l} u_{\bar{l} \bar{j}}\right)}{|\nabla u|^{4}}+\psi^{\prime} u_{i \bar{j}}+\psi^{\prime \prime} u_{i} u_{\bar{j}} .
\end{aligned}

& -\frac{F^{\bar{i}}\left(u_{k i} u_{\bar{k} \bar{i}}+u_{k \bar{i}} \overline{\bar{k}}\right)|\nabla u|^{2}-\left.\left.F^{\bar{i}}\left|\nabla \nabla_{i}\right| \nabla u\right|^{2}\right|^{2}}{|\nabla u|^{4}} \text { (denoted by (II)) } \\
& +\psi^{\prime}\left(u_{t}-F^{\bar{i} \bar{i}} u_{\bar{i}}\right)-\psi^{\prime \prime} F^{i \bar{i}}\left|u_{i}\right|^{2} .

& =\frac{\left.F^{\bar{i}}(|\nabla \chi|+2|R m||\nabla u|)\right)}{|\nabla u|} \leq C_{2} .
\end{aligned}
$$

We then deal with term (II). Since $G_{i}=0$ for each $1 \leq i \leq n$, we have

& =\left|\sum u_{k i} u_{\bar{k}}\right|^{2}+\left|\sum u_{k} u_{\bar{k} i}\right|^{2}+2 \operatorname{Re}\left(-\left(\sum u_{k} u_{\bar{k} i}+|\nabla u|^{2} \psi^{\prime} u_{i}\right) \sum u_{\bar{k}} u_{\bar{k} \bar{i}}\right) \\
& =\left|\sum u_{k i} u_{\bar{k}}\right|^{2}-\left|\sum u_{k} u_{\bar{k} i}\right|^{2}-2|\nabla u|^{2} \psi^{\prime} \operatorname{Re}\left(u_{i} \sum u_{\bar{k}} u_{\bar{k} \bar{i}}\right) .
\end{aligned}

Hence

& -|\nabla u|^{-4} F^{\bar{i}}\left|\sum u_{k} u_{\bar{k} i}\right|^{2}-2|\nabla u|^{-2} \psi^{\prime} F^{i \bar{i}} \operatorname{Re}\left(u_{i} \sum u_{\bar{k}} u_{\bar{k}}\right) \\
\leq & -2|\nabla u|^{-2} \psi^{\prime} F^{\bar{i}} \operatorname{Re}\left(u_{i} \sum u_{\bar{k}} u_{\bar{k} \bar{i}}\right)
\end{aligned}

where the last inequality holds by the Cauchy-Schwarz inequality:

\end{aligned}

Clearly $\max \left\{\sum F^{\bar{i}}, \sum F^{\bar{i}} \lambda_{i}^{2}\right\} \leq n \max _{M} \csc ^{2} \theta_{\omega}\left(\chi_{u_{0}}\right)$ by (3.2). If we take

We use the argument of Collins-Yau [8] and consider the two cases. Let $\epsilon_{0}$ be a positive constant satisfying

Case 1: $\sum_{i=1}^{n} F^{\bar{i}}\left|u_{i}\right|^{2} \geq \epsilon_{0}^{2}|\nabla u|^{2}$. By the definition of $\psi, D_{0} \leq-\psi^{\prime} \leq D_{0}+1$ and $\psi^{\prime \prime}=$ $2\left(u-\inf _{M} u+1\right)^{-3}$. Hence, by (4.8)

Hence if we choose $D_{0}>2 \kappa_{0}^{-1} C_{2}\left(1+A_{1}^{2}\right)$, we obtain the following contradiction.

4.3. Second order estimates. In the elliptic case, Collins-Jacob-Yau [5] used an auxiliary function containing the gradient term which modifies the one in Hou-Ma-Wu [19]. Here our auxiliary function does not contain the gradient term.

Proposition 4.6. There exists a uniform constant $M_{2}$ such that

Proof. Without loss of generality, we assume that $\underline{u}=0$. Denote $w_{i \bar{j}}:=\chi_{i \bar{j}}+u_{i \bar{j}}$ as before. For any fixed $T_{0}<\infty$, we consider the auxiliary function on $S\left(T^{1,0} M\right) \times\left[0, T_{0}\right]$ :

Hence we assume $t_{0}>0$. Take holomorphic coordinates (3.3) near $x_{0}$ which forces $\xi_{0}=\frac{\partial}{\partial z_{1}}$. Extend $\xi_{0}$ near $x_{0}$ as $\tilde{\xi}_{0}(x)=\left(g_{11}\right)^{-\frac{1}{2}} \frac{\partial}{\partial z_{1}}$. Then the function $H(x, t)=\tilde{H}\left(x, t, \tilde{\xi}_{0}(x)\right)$ on $M \times\left[0, T_{0}\right]$ attains its maximum at $\left(x_{0}, t_{0}\right)$.

By the maximum principle, we have at $\left(x_{0}, t_{0}\right)$

& 0 \leq-H_{i \bar{i}}=-\frac{w_{1 \overline{1}, \bar{i}}}{w_{1 \overline{1}}}+\frac{\left|w_{1 \overline{1}, i}\right|^{2}}{w_{1 \overline{1}}^{2}}-\psi^{\prime} u_{\bar{i} \bar{i}}-\left|u_{i}\right|^{2} .
\end{align*}

Hence we have

We begin to deal with term (I). By (3.5), we have

& =\lambda_{1}^{-2} \sum_{i=2}^{n} F^{i \bar{i}}\left|w_{1 \overline{1}, i}\right|^{2} \frac{1-\lambda_{1} \lambda_{i}}{1+\lambda_{1}^{2}}+\lambda_{1}^{-2} F^{1 \overline{1}}\left|w_{1 \overline{1}, 1}\right|^{2}+C_{4} \\
& =\psi^{\prime 2} \sum_{i=2}^{n} F^{i \bar{i}}\left|u_{i}\right|^{2} \frac{1-\lambda_{1} \lambda_{i}}{1+\lambda_{1}^{2}}+\psi^{\prime 2} F^{1 \overline{1}}\left|u_{1}\right|^{2}+C_{4} .
\end{aligned}
$$

By Lemma 2.3, we have $\lambda_{1} \geq \cdots \geq \lambda_{n-1} \geq \cot \left(B_{0}\left(u_{0}\right) / 2\right)$, and without loss of generality we assume $\lambda_{1}>1 / \cot \left(B_{0}\left(u_{0}\right) / 2\right)$. Hence for $2 \leq i \leq n-1,1-\lambda_{1} \lambda_{i}<0$. For $i=n$, since

\leq & \left(-1+\left(1+A_{1}\right)\left(D_{1}+M_{0}\right)^{2} \lambda_{1}^{-1}\right) F^{n \bar{n}}\left|u_{n}\right|^{2} \\
& +\left(D_{1}+M_{0}\right)^{2} M_{1}^{2} \csc ^{2} \theta(\lambda)\left(1+\lambda_{1}^{2}\right)^{-1}+\psi^{\prime}\left(u_{t}-F^{\bar{i}} u_{\bar{i}}\right)+C_{4} . \tag{4.20}
\end{align*}
$$

The first term is negative if we assume

We further assume

4.4. Proof of Theorem 4.1. The proof is the similar as the one in Phong-Tô [27]. We sketch it for completeness. We have proved the uniform a priori estimates up to the second order. By the concavity of $\theta_{\omega}\left(\chi_{u}\right)$, we have the uniform $C^{2, \alpha}$ estimates and then the higher estimates hold.

Since $u_{t}$ is uniformly bounded, there exists a constant $C$ such that $v(x, t):=u_{t}(x, t)+C>$ 0 . Since $v$ satisfies $v_{t}=\left(u_{t}\right)_{t}=F^{i \bar{j}}\left(u_{t}\right)_{i \bar{j}}=F^{i \bar{j}} v_{i \bar{j}}$ and $F^{i \bar{j}}$ is uniformly elliptic, we can apply the differential Harnack inequality (Cao [1] and Gill [13]) to get the following estimates

By Lamma 2.7 and inequality (4.1) we know that for any $t \in(0, \infty)$, there exists a point $x_{0}(t)$ such that $u_{t}\left(x_{0}(t), t\right)=0$. Therefore, for any $(x, t) \in M \times(0, \infty)$, by (4.24), we have

## 5. The convergence result on Kähler surface with the semi-subsolution condition

In this section, we consider the compact Kähler surface case when $\chi$ satisfies the semisubsolution condition i.e. $\chi-\cot \theta_{0} \omega \geq 0$. We prove Theorem 1.4, i.e.,

Theorem 5.1. Let $(M, \omega)$ be a compact Kähler surface and $\chi$ a closed real $(1,1)$ form. Assume $\theta_{0} \in(0, \pi)$ and $\chi \geq \cot \theta_{0} \omega$. Then there exist a finite number of curves $E_{i}$ of negative self-intersection on $M$ such that the solution $u(x, t)$ of dHYM flow (1.7) converges to a bounded function $u^{\infty}$ in $C_{l o c}^{\infty}\left(M \backslash \cup_{i} E_{i}\right)$ as t tends to $\infty$ with the following properties.
(1) $\chi+\sqrt{-1} \partial \bar{\partial} u^{\infty}-\cot B_{1} \omega$ is a Kähler current which is smooth on $M \backslash \cup_{i} E_{i}$;
(2) $u^{\infty}$ satisfies the $d H Y M$ equation on $M \backslash \cup_{i} E_{i}$

$$
\begin{equation*}
\operatorname{Re}\left(\chi_{u^{\infty}}+\sqrt{-1} \omega\right)^{2}=\cot \theta_{0} \operatorname{Im}\left(\chi_{u^{\infty}}+\sqrt{-1} \omega\right)^{2} \tag{5.1}
\end{equation*}
$$

(3) $\chi_{u(x, t)}$ converges to $\chi_{u^{\infty}}$ and $u^{\infty}$ satisfies (5.1) on $M$ in the sense of currents .

Here $u_{0}$ is a function in $\mathcal{H}_{B_{1}}$ for any $B_{1} \in\left(\theta_{0}, \pi\right)$. If $\theta_{0} \in\left(0, \frac{\pi}{2}\right)$, we have $0 \in \mathcal{H}_{B_{1}}$ for any $B_{1} \in\left(2 \theta_{0}, \pi\right)$. If $\theta_{0} \in\left[\frac{\pi}{2}, \pi\right)$, we first show that the semi-subsolution condition implies the non-empty of $\mathcal{H}_{B_{1}}$ for any $B_{1} \in\left(\theta_{0}, \pi\right)$.

Lemma 5.2. Let $(M, \omega)$ be a compact Kähler surface. Assume $\chi \geq \cot \theta_{0} \omega$ and $\theta_{0} \in\left[\frac{\pi}{2}, \pi\right)$. Then for any $B_{1} \in\left(\theta_{0}, \pi\right)$, there exists a smooth function $u$ such that $u \in \mathcal{H}_{B_{1}}$.

Proof. Let $\chi_{\epsilon}:=\chi-\epsilon \omega$ with $\epsilon>0$ sufficiently small. Define $\theta_{0}(\epsilon)$ as the principal argument of $\int_{M}\left(\chi_{\epsilon}+\sqrt{-1} \omega\right)^{2}$. Then by definition,

$$
\cot \theta_{0}(\epsilon)=\frac{\int_{M} \operatorname{Re}\left(\chi_{\epsilon}+\sqrt{-1} \omega\right)^{2}}{\int_{M} \operatorname{Im}\left(\chi_{\epsilon}+\sqrt{-1} \omega\right)^{2}}
$$

Since $\theta_{0} \in(0, \pi)$, for any $\epsilon>0$ sufficiently small we have $\theta_{0}(\epsilon) \in(0, \pi)$ and thus Im $\int_{M}\left(\chi_{\epsilon}+\sqrt{-1} \omega\right)^{2}=2 \int_{M} \chi_{\epsilon} \wedge \omega>0$. By direct manipulation, we have

$$
\begin{aligned}
\cot \theta_{0}(\epsilon) & =\frac{\int_{M}\left(\chi^{2}-\omega^{2}+\epsilon^{2} \omega^{2}-2 \epsilon \chi \wedge \omega\right)}{2 \int_{M}\left(\chi \wedge \omega-\epsilon \omega^{2}\right)} \\
& =\cot \theta_{0}-\epsilon+\epsilon\left(\cot \theta_{0}-\frac{\epsilon}{2}\right) \frac{\int_{M} \omega^{2}}{\int_{M}\left(\chi \wedge \omega-\epsilon \omega^{2}\right)} \\
& <\cot \theta_{0}-\epsilon
\end{aligned}
$$

This shows $\chi_{\epsilon} \geq \cot \theta_{0} \omega-\epsilon \omega>\cot \theta_{0}(\epsilon) \omega$. Hence by Jacob-Yau [22] there exists a smooth function $u_{\epsilon}$ solving

$$
\operatorname{Re}\left(\chi_{\epsilon}+\sqrt{-1} \partial \bar{\partial} u_{\epsilon}+\sqrt{-1} \omega\right)^{2}=\cot \theta_{0}(\epsilon) \operatorname{Im}\left(\chi_{\epsilon}+\sqrt{-1} \partial \bar{\partial} u_{\epsilon}+\sqrt{-1} \omega\right)^{2}
$$

Thus for any $B_{1} \in\left(\theta_{0}, \pi\right)$, we have

$$
\theta_{\omega}\left(\chi_{u_{\epsilon}}\right)<\theta_{\omega}\left(\chi_{\epsilon}+\sqrt{-1} \partial \bar{\partial} u_{\epsilon}\right)=\theta_{0}(\epsilon)<B_{1}
$$

when $\epsilon$ is sufficiently small since $\theta_{0}(\epsilon)$ attends to $\theta_{0}$ as $\epsilon$ goes to 0 .
We will use the following proposition proved by Song-Weinkove [29].
Proposition 5.3 (Song-Weinkove [29]). Let M be a Kähler surface with a Kähler class $\beta \in H^{1,1}(M, \mathbb{R})$. If $\alpha \in H^{1,1}(M, \mathbb{R})$ satisfies $\alpha^{2}>0$ and $\alpha \cdot \beta>0$, then either $\alpha$ is Kähler or there exists a positive integer $m$, curves of negative self-intersection $E_{i}, 1 \leq i \leq m$ and positive numbers $a_{i}, 1 \leq i \leq m$ such that

$$
\alpha-\sum_{i=1}^{m} a_{i}\left[E_{i}\right]
$$

is a Kähler class.
Since $2 \cot \theta_{0}[\chi] \cdot[\omega]=[\chi]^{2}-[\omega]^{2}$, if we let $\tilde{\chi}=\chi-\cot \theta_{0} \omega$, then we have

$$
\begin{equation*}
[\tilde{\chi}]^{2}=[\chi]^{2}-2 \cot \theta_{0}[\chi] \cdot[\omega]+\cot ^{2} \theta_{0}[\omega]^{2}=\left(1+\cot ^{2} \theta_{0}\right)[\omega]^{2}>0 \tag{5.2}
\end{equation*}
$$

Since $\tilde{\chi} \geq 0$, we also have

$$
[\tilde{\chi}] \cdot[\omega]>0,
$$

otherwise $\tilde{\chi} \equiv 0$ which contradicts with (5.2). Hence we can apply Proposition 5.3 to get that there exists a finite number $m \geq 0$, curves of negative self-intesection $E_{i}, 1 \leq i \leq m$ and positive numbers $a_{i}, 1 \leq i \leq m$ such that $[\tilde{\chi}]-\sum_{i=1}^{m} a_{i}\left[E_{i}\right]$ is a Kähler class.

Let $h_{i}$ be the hermitian metric on $\left[E_{i}\right]$ and $s_{i}$ be a holomorphic section of $\left[E_{i}\right]$ which vanishes along $E_{i}$ to order 1. Define

$$
S:=\sum_{i=1}^{m} a_{i} \log \left|s_{i}\right|_{h_{i}}^{2},
$$

then

$$
\begin{equation*}
\tilde{\chi}+\sqrt{-1} \partial \bar{\partial} S>0 \tag{5.3}
\end{equation*}
$$

Similar as the argument in Section 2 in [12] which is based on [10], [34] and [38], we get the following result.

Lemma 5.4. Let $(M, \omega)$ be a compact Kähler surface. Assume $\tilde{\chi}:=\chi-\cot \theta_{0} \omega \geq 0$ and $\theta_{0} \in(0, \pi)$. Then there exists a unique (up to adding a constant ) bounded $\tilde{\chi}$-PSH function $v$ on $M$ and $v \in C_{l o c}^{\infty}\left(M \backslash \cup_{i} E_{i}\right)$ satisfying

$$
\begin{equation*}
(\tilde{\chi}+\sqrt{-1} \partial \bar{\partial} v)^{2}=\csc ^{2} \theta_{0} \omega^{2} \tag{5.4}
\end{equation*}
$$

in the sense of currents.
5.1. The uniform $C^{0}$-estimate. We have proved the uniform $u_{t}$ estimate and thus along the flow we have $\theta_{\omega}\left(\chi_{u}\right) \in\left(\min _{M} \theta_{\omega}\left(\chi_{u(0)}\right), B_{1}\right)$.

Proposition 5.5. Assume the same conditions hold as in Theorem 1.4. Then there exists a uniform constant $M_{0}$ such that for any $(x, t) \in M \times[0, \infty)$

$$
\begin{equation*}
|u(x, t)| \leq M_{0} . \tag{5.5}
\end{equation*}
$$

Proof. For any $T_{0}$, we will prove $\sup _{M \times\left[0, T_{0}\right]}|u(x, t)| \leq M_{0}$. We use similar auxiliary functions by Fang-Lai-Song-Weinkove [12] for the J-flow and Takahashi [33] for the LBMCF.

We first prove the upper bound of $u$ using the solution $v$ in Lemma 5.4. Consider

w_{\varepsilon}(x, t):=u-(1+\varepsilon) v+\varepsilon S-C_{0} \varepsilon t,
$$

where $C_{0}$ is a large constant to be determined later. Since $w_{\varepsilon}(x, t)$ is upper semi-continuous on $M \times\left[0, T_{0}\right]$ with $w_{\varepsilon}=-\infty$ in $\cup_{i} E_{i}, w_{\varepsilon}$ attains its maximum on $M \times\left[0, T_{0}\right]$ at $\left(x_{0}, t_{0}\right)$ with $x_{0} \in M \backslash \cup_{i} E_{i}$. Our goal is to show $t_{0}=0$.

At $\left(x_{0}, t_{0}\right)$, we have

$$
\begin{align*}
0 \geq \sqrt{-1} \partial \bar{\partial} w_{\varepsilon} & =\sqrt{-1} \partial \bar{\partial} u-(1+\varepsilon) \sqrt{-1} \partial \bar{\partial} v+\varepsilon \sqrt{-1} \partial \bar{\partial} S \\
& =\tilde{\chi}_{u}-(1+\varepsilon) \tilde{\chi}_{v}+\varepsilon(\tilde{\chi}+\sqrt{-1} \partial \bar{\partial} S) \\
& \geq \tilde{\chi}_{u}-(1+\varepsilon) \tilde{\chi}_{v}, \tag{5.6}
\end{align*}
$$

where in the last inequality we use inequality (5.3). Let $\lambda=\left(\lambda_{1}, \lambda_{2}\right)$ and $\mu=\left(\mu_{1}, \mu_{2}\right)$ be the eigenvalues of $\chi_{u}\left(x_{0}, t_{0}\right)$ and $\tilde{\chi}_{u}\left(x_{0}, t_{0}\right)$ with respect to the metric $\omega$ respectively. Then $\lambda_{i}=\mu_{i}+\cot \theta_{0}$. Without loss of generality, we assume $\lambda_{1} \geq \lambda_{2}$. By direct manipulation, we have

$$
\begin{align*}
\frac{d w_{\varepsilon}}{d t}\left(x_{0}, t_{0}\right) & =\frac{d u}{d t}\left(x_{0}, t_{0}\right)-C_{0} \varepsilon=\cot \theta\left(\chi_{u}\left(x_{0}, t_{0}\right)\right)-\cot \theta_{0}-C_{0} \varepsilon  \tag{5.7}\\
& =\frac{\lambda_{1} \lambda_{2}-1}{\lambda_{1}+\lambda_{2}}-\cot \theta_{0}-C_{0} \varepsilon \\
& =\frac{\mu_{1} \mu_{2}-\csc ^{2} \theta_{0}}{\lambda_{1}+\lambda_{2}}-C_{0} \varepsilon . \tag{5.8}
\end{align*}
$$

Case 1: $\mu_{1} \geq 0$ and $\mu_{2} \geq 0$. By (5.6) and (5.4), we have

$$
\begin{equation*}
\mu_{1} \mu_{2} \leq(1+\varepsilon) \frac{\tilde{\chi}_{v}^{2}}{\omega^{2}}=(1+\varepsilon) \csc ^{2} \theta_{0} \tag{5.9}
\end{equation*}
$$

Inserting (5.9) into (5.8), we obtain

$$
\begin{align*}
\frac{d w_{\varepsilon}}{d t}\left(x_{0}, t_{0}\right) & \leq \frac{\csc ^{2} \theta_{0}}{\lambda_{1}+\lambda_{2}} \varepsilon-C_{0} \varepsilon \\
& \leq \frac{\csc ^{2} \theta_{0}}{\cot \frac{B_{1}}{2}-\cot B_{1}} \varepsilon-C_{0} \varepsilon \\
& =-\varepsilon<0, \tag{5.10}
\end{align*}
$$

where we use $\lambda_{1}+\lambda_{2} \geq \cot \frac{B_{1}}{2}-\cot B_{1}>0$ and choose $C_{0}=\frac{\csc ^{2} \theta_{0}}{\cot \frac{B_{1}}{2}-\cot B_{1}}+1$.
Case 2: $\mu_{1} \geq 0$ and $\mu_{2} \leq 0$. By (5.8), $\frac{d w_{\varepsilon}}{d t}\left(x_{0}, t_{0}\right)<-C_{0} \varepsilon<0$.
Case 3: $\mu_{1} \leq 0$ and $\mu_{2} \leq 0$. Then $\lambda_{1}=\mu_{1}+\cot \theta_{0} \leq \cot \theta_{0}$ and we get $\cot \theta\left(\chi_{u}\left(x_{0}, t_{0}\right)\right)=$ $\lambda_{1}-\frac{1+\lambda_{1}^{2}}{\lambda_{1}+\lambda_{2}}<\cot \theta_{0}$. Thus by (5.7), we have $\frac{d w_{s}}{d t}\left(x_{0}, t_{0}\right)=\frac{d u}{d t}\left(x_{0}, t_{0}\right)-C_{0} \varepsilon<0$.

From the above three cases, we conclude $\frac{d w_{s}}{d t}\left(x_{0}, t_{0}\right)<0$ and thus $t_{0}=0$. Thus for any $\varepsilon>0$ and $(x, t) \in\left(M \backslash \cup_{i} E_{i}\right) \times\left[0, T_{0}\right]$, we have

$$
u(x, t) \leq u_{0}\left(x_{0}\right)-(1+\varepsilon) v\left(x_{0}\right)+\varepsilon S\left(x_{0}\right)+(1+\varepsilon) v(x)-\varepsilon S(x)+C_{0} \varepsilon t .
$$

Fix $(x, t) \in\left(M \backslash \cup_{i} E_{i}\right) \times\left[0, T_{0}\right]$ and let $\varepsilon$ tend to 0 , since $S$ is upper bounded, we have $u(x, t) \leq \max u_{0}+2 \max |v|$, which also holds for any $(x, t) \in M \times\left[0, T_{0}\right]$ by continuity of $u(x, t)$. Since $T_{0}$ is arbitrary, $u \leq \max u_{0}+2 \max |v|$ in $M \times[0, \infty]$.

Next we prove the lower bound of $u$. Consider

$$
\tilde{w}_{\varepsilon}:=u-(1-\varepsilon) v-\varepsilon S+C_{0} \varepsilon t,
$$

where $C_{0}$ is a constant as above. Since $\tilde{w}_{\varepsilon}(x, t)$ is lower semi-continuous with $\tilde{w}_{\varepsilon}=+\infty$ in $\cup_{i} E_{i}, \tilde{w}_{\varepsilon}$ attains its minimum in $M \times\left[0, T_{0}\right]$ at $\left(x_{1}, t_{1}\right)$ with $x_{1} \in M \backslash \cup_{i} E_{i}$.

At $\left(x_{1}, t_{1}\right)$, we have

$$
\begin{align*}
0 \leq \sqrt{-1} \partial \bar{\partial} \tilde{w}_{\varepsilon} & =\sqrt{-1} \partial \bar{\partial} u-(1-\varepsilon) \sqrt{-1} \partial \bar{\partial} v-\varepsilon \sqrt{-1} \partial \bar{\partial} S \\
& =\tilde{\chi}_{u}-(1-\varepsilon) \tilde{\chi}_{v}-\varepsilon(\tilde{\chi}+\sqrt{-1} \partial \bar{\partial} S) \\
& \leq \tilde{\chi}_{u}-(1-\varepsilon) \tilde{\chi}_{v} . \tag{5.11}
\end{align*}
$$

This implies

$$
\mu_{1} \mu_{2} \geq(1-\varepsilon) \frac{\tilde{\chi}_{v}^{2}}{\omega^{2}}=(1-\varepsilon) \csc ^{2} \theta_{0}
$$

Hence

$$
\begin{aligned}
\frac{d \tilde{w}_{\varepsilon}}{d t}\left(x_{1}, t_{1}\right) & =\frac{\mu_{1} \mu_{2}-\csc ^{2} \theta_{0}}{\lambda_{1}+\lambda_{2}}+C_{0} \varepsilon \\
& \geq-\frac{\csc ^{2} \theta_{0}}{\lambda_{1}+\lambda_{2}} \varepsilon+C_{0} \varepsilon>0
\end{aligned}
$$

Thus $\tilde{w}_{\varepsilon}$ attains its minimum at $t_{1}=0$ and the lower bound of $u$ follows.
Combining the above uniform estimate and Proposition 2.8 yields
Corollary 5.6. Along the $d H Y M$ flow, there exists a uniform constant $C$ such that

$$
\begin{equation*}
\operatorname{Re}\left(\mathrm{CY}_{\mathbb{C}}(u)\right) \leq C \tag{5.12}
\end{equation*}
$$

5.2. $C^{k}$-estimate in compact set $K \subset M \backslash \cup_{i} E_{i}$. Since $\chi-\cot \theta_{0} \omega_{0}$ is only nonnegative, we could not apply Lemma 4.4 directly. But we can prove a similar type inequality as in Lemma 4.4. In fact, we consider $\tilde{u}=u-S$. Since $\chi-\cot \theta_{0} \omega \geq 0$ and all $E_{i}, 1 \leq i \leq m$ are negative self-intersection, we have $\chi-\cot \theta_{0} \omega+\sqrt{-1} \partial \bar{\partial} S>0$, and thus there exists a small constant $\delta>0$ such that

$$
\begin{equation*}
\chi+\sqrt{-1} \partial \bar{\partial} S \geq\left(\cot \theta_{0}+\delta\right) \omega \tag{5.13}
\end{equation*}
$$

We can prove the following useful inequality which is the key for us to prove the gradient estimate and the complex Hessian estimate.

Lemma 5.7. Assume the same conditions hold as in Theorem 5.1. There exist uniform constants $K_{0}>0$ and $c_{0}>0$ such that if $\left|\lambda\left(\chi_{u}\right)\right|>K_{0}$, then

$$
u_{t}-F^{i \bar{j}}\left(u_{i \bar{j}}-S_{i \bar{j}}\right) \geq c_{0} .
$$

Proof. Choose the normal coordinates at $(x, t)$ as before. By (5.13) we have

\begin{align*}
u_{t}-F^{i \bar{j}}\left(u_{i \bar{j}}-S_{i \bar{j}}\right) & =\cot \theta_{\omega}\left(\chi_{u}\right)-\cot \theta_{0}-F^{\bar{i}}\left(w_{\bar{i}}-\chi_{\bar{i}}-S_{\bar{i}}\right) \\
& \geq \cot \theta_{\omega}\left(\chi_{u}\right)-\cot \theta_{0}-F^{\bar{i}} w_{i \bar{i}}+\left(\delta+\cot \theta_{0}\right) \sum_{i=1}^{2} F^{\bar{i}} . \tag{5.14}
\end{align*}
$$

By (3.3), we have $\left|\lambda_{2}\right| \leq A_{1}$. Recall that $\cot \theta_{\omega}\left(\chi_{u}\right)=\frac{\lambda_{1} \lambda_{2}-1}{\lambda_{1}+\lambda_{2}}$ and $\csc ^{2} \theta_{\omega}\left(\chi_{u}\right)=1+$ $\cot ^{2} \theta_{\omega}\left(\chi_{u}\right)=\frac{\left(1+\lambda_{1}^{2}\right)\left(1+\lambda_{2}^{2}\right)}{\left(\lambda_{1}+\lambda_{2}\right)^{2}}$. Hence we have

$$
\begin{align*}
\cot \theta_{\omega}\left(\chi_{u}\right)-F^{i \bar{i}} w_{\bar{i}} & =\frac{\lambda_{1} \lambda_{2}-1}{\lambda_{1}+\lambda_{2}}-\frac{\left(1+\lambda_{1}^{2}\right) \lambda_{2}}{\left(\lambda_{1}+\lambda_{2}\right)^{2}}-\frac{\left(1+\lambda_{2}^{2}\right) \lambda_{1}}{\left(\lambda_{1}+\lambda_{2}\right)^{2}} \\
& =\frac{-2}{\lambda_{1}+\lambda_{2}} \geq-C \lambda_{1}^{-1} . \tag{5.15}
\end{align*}
$$

For the other terms in (5.14), we have

$$
\begin{align*}
-\cot \theta_{0}+\left(\delta+\cot \theta_{0}\right) \sum_{i=1}^{2} F^{\bar{i}} & \geq \cot \theta_{0}\left(\frac{\csc ^{2} \theta_{\omega}\left(\chi_{u}\right)}{1+\lambda_{2}^{2}}-1\right)+\delta \sum_{i=1}^{2} F^{\bar{i}}-C \lambda_{1}^{-1} \\
& =\cot \theta_{0}\left(\frac{1+\lambda_{1}^{2}}{\left(\lambda_{1}+\lambda_{2}\right)^{2}}-1\right)+\delta \sum_{i=1}^{2} F^{\bar{i}}-C \lambda_{1}^{-1} \\
& \geq-C \lambda_{1}^{-1}+\delta \sum_{i=1}^{2} F^{\bar{i}} \\
& \geq-C \lambda_{1}^{-1}+\delta \frac{\left(1+\lambda_{1}^{2}\right)}{\left(\lambda_{1}+\lambda_{2}\right)^{2}} \\
& \geq \frac{\delta}{2} \tag{5.16}
\end{align*}
$$

where we assume $\lambda_{1} \geq K_{0}$ and choose $K_{0}$ sufficiently large.
Inserting (5.15) and (5.16) into (5.14), we obtain

$$
u_{t}-F^{i \bar{j}}\left(u_{i \bar{j}}-S_{i \bar{j}}\right) \geq \frac{\delta}{2}-C \lambda_{1}^{-1} \geq \frac{\delta}{4}
$$

The following lemma is useful for us to prove the gradient estimate and the complex Hessian estimate.

Lemma 5.8. There exist uniform positive constants $\Lambda_{0}:=\min _{i}\left\{a_{i}^{-1}\right\}$ and $\Lambda_{1}$ such that for any $x \in M \backslash \cup_{i} E_{i}$, it holds

$$
\begin{equation*}
e^{\Lambda_{0} S(x)}\left(|S(x)|^{3}+|\nabla S|^{2}(x)\right) \leq \Lambda_{1} \tag{5.17}
\end{equation*}
$$

Proof. Since $S=\sum_{i=1}^{m} a_{i} \log \left|s_{i}\right|_{h_{i}}^{2}$, there exists a uniform constant $C>0$ such that

$$
\begin{equation*}
|\nabla S|^{2} \leq C\left(1+\sum_{i=1}^{m}\left|s_{i}\right|^{-2}\right) \tag{5.18}
\end{equation*}
$$

Then we have (5.17) .

Proposition 5.9. There exist uniform constants $D_{0}$ and $M_{1}$ such that for any $(x, t) \in$ $M \backslash \cup_{i} E_{i} \times[0, \infty)$

$$
\begin{equation*}
|\nabla u|_{\omega}(x, t) \leq M_{1} \prod_{i}\left|s_{i}\right|_{h_{i}}^{-D_{0} a_{i}}(x) \tag{5.19}
\end{equation*}
$$

Proof. Since $S$ is upper semi-continuous, there exists a uniform constant $S_{0}$ such that $\sup _{M} S \leq S_{0}$. We consider the function

$$
G=\log |\nabla u|^{2}+\psi(\tilde{u}),
$$

where $\tilde{u}=u-S$ and

$$
\psi(\tilde{u})=-D_{0} \tilde{u}+\left(\tilde{u}+S_{0}+M_{0}+1\right)^{-1}
$$

where $D_{0}>\Lambda_{0}:=\min _{i}\left\{a_{i}^{-1}\right\}$ is a uniform constant to be determined later.
Since $S$ is upper semi-continuous, we know that $G$ is also upper semi-continuous. Suppose that $\max _{M \times\left[0, T_{0}\right]} G(x, t)=G\left(x_{0}, t_{0}\right)$. Since $S=-\infty$ on $\cup_{i} E_{i}$, we have $G(x, t)=-\infty$ on $\cup_{i} E_{i}$ and then $x_{0} \in M \backslash \cup_{i} E_{i}$.

If $t_{0}=0$, we have for any $(x, t) \in M \backslash \cup_{i} E_{i} \times\left[0, T_{0}\right]$

$$
\begin{equation*}
e^{G(x, t)} \leq e^{G\left(x_{0}, 0\right)} \leq\left|\nabla u_{0}\right|^{2} e^{D_{0} S_{0}+D_{0} M_{0}+S_{0}+M_{0}+1} \leq M_{1,0}, \tag{5.20}
\end{equation*}
$$

where we used $S \leq S_{0}$ and $M_{1,0}:=\max _{M}\left|\nabla u_{0}\right|^{2} e^{\left(D_{0}+1\right)\left(S_{0}+M_{0}\right)+1}$. This gives the estimate (5.9).

In the following, we always assume $t_{0}>0$.

Assume that $u_{i}$ converges to $u^{\infty}$ in $C_{l o c}^{\infty}(M \backslash Y)$ as $j \rightarrow \infty$. Then $C Y_{\mathbb{C}}\left(u^{\infty}\right)$ and $\mathcal{J}\left(u^{\infty}\right)$ are well-defined. Moreover,

Proof of Theorem 5.1. By the $C^{0}$ estimate proved in Proposition 5.5, there exists a sequence $\left\{t_{i}\right\}$ such that $u\left(, t_{i}\right)$ converges to a function $u^{\infty} \in L^{\infty}(M)$. By the $C^{k}$ estimates in Proposition 5.11, by passing a subsequence (for convenience we still denote by $t_{i}$ ), $u\left(, t_{i}\right)$ smoothly converges to $u^{\infty}$ in any compact subset of $M \backslash \cup_{i} E_{i}$ and thus $u^{\infty} \in C^{\infty}\left(M \backslash \cup_{i} E_{i}\right)$. Since $\chi_{u}>\cot B_{1} \omega$, then $\chi_{u^{\infty}}-\cot B_{1} \omega$ is a Kähler current and is smooth in $M \backslash \cup_{i} E_{i}$. By Lemma 5.13 and Lemma 2.7, we have $\operatorname{Im}\left(\mathrm{CY}_{\mathbb{C}}\left(u^{\infty}\right)\right)=\operatorname{Im}\left(\mathrm{CY}_{\mathbb{C}}\left(u_{0}\right)\right)$.

By Proposition 5.12, $u^{\infty}$ satisfies (5.1) in $M \backslash \cup_{i} E_{i}$ and then $\theta_{\omega}\left(\chi_{u^{\infty}}\right)=\theta_{0}$ on $M \backslash \cup_{i} E_{i}$. We can define $\chi_{u^{\infty}}^{2}$ and $\chi_{u^{\infty}} \wedge \omega$ as finite measures on $M$ such that they do not charge pluripolar subsets. Thus $\left(\chi_{u^{\infty}}+\sqrt{-1} \omega\right)^{2}$ is well-defined and $u^{\infty}$ satisfies the equation (5.1) on $M$ in the sense of currents. Moreover, $u^{\infty}$ is $\tilde{\chi}$-PSH on $M$ and satisfies the equation (5.4) in the sense of currents.

Finally, by the $C_{l o c}^{\infty}\left(M \backslash \cup_{i} E_{i}\right)$ uniform estimate of $u(t)$ and the uniqueness of the equation (5.4), similar as the argument in [12], we have $u(t)$ converges smoothly to $u^{\infty}$ on $M \backslash$ $\cup_{i} E_{i}$.
5.4. $\mathcal{J}$ functional. As an application of our dHYM flow, we prove the lower bound of the $\mathcal{J}$-functional in the following set.

$$
\mathcal{H}_{B_{1}}=\left\{w \in C^{\infty}(M, \mathbb{R}): \theta_{\omega}\left(\chi_{w}\right) \in\left(0, B_{1}\right)\right\} .
$$

Corollary 5.14. Let $(M, \omega)$ be a compact Kähler surface and $\chi$ a closed real $(1,1)$ form. Assume that $\theta_{0} \in(0, \pi)$ and $\chi \geq \cot \theta_{0} \omega$, the $\mathcal{J}$-functional is bounded from below in $\mathcal{H}_{B_{1}}$ for any $B_{1} \in\left(\theta_{0}, \pi\right)$.

Proof. For $u_{0} \in \mathcal{H}_{B_{1}}$, let $u(t)$ be the solution of the dHYM flow $u_{t}=\cot \theta_{\omega}\left(\chi_{u}\right)-\cot \theta_{0}$ with $u(0)=u_{0}$. By Theorem 5.1, $u(t)$ converges to a bounded function $u^{\infty}$ solving (5.4). Since $\mathcal{J}$ is decreasing along the flow, we have

$$
\mathcal{J}\left(u_{0}\right) \geq \lim _{t \rightarrow \infty} \mathcal{J}(u(t))=\mathcal{J}\left(u^{\infty}\right)
$$

Let $v$ be a weak solution of (5.4) in Lemma 5.4. By the uniqueness, there exists a constant $c_{0}$ such that $u^{\infty}=v+c_{0}$. Since $\mathcal{J}\left(u^{\infty}\right)=\mathcal{J}(v)$, we have

$$
\mathcal{J}\left(u_{0}\right) \geq \mathcal{J}(v)
$$
