# DISPERSIVE ESTIMATES FOR LINEARIZED WATER WAVE TYPE EQUATIONS IN $\mathbb{R}^{\text {d }}$

#### Abstract

We derive a $L_{x}^{1}\left(\mathbb{R}^{d}\right)-L_{x}^{\infty}\left(\mathbb{R}^{d}\right)$ decay estimate of order $\mathcal{O}\left(t^{-d / 2}\right)$ for the linear propagators $$
\exp \left( \pm i t \sqrt{|D|\left(1+\beta|D|^{2}\right) \tanh |D|}\right), \quad \beta \in\{0,1\} . \quad D=-i \nabla
$$ with a loss of $3 \mathrm{~d} / 4$ or $\mathrm{d} / 4$ - derivatives in the case $\beta=0$ or $\beta=1$, respectively. These linear propagators are known to be associated with the linearized water wave equations, where the parameter $\beta$ measures surface tension effects. As an application we prove low regularity well-posedness for a Whitham-Boussinesq type system in $\mathbb{R}^{d}, d \geqslant 2$. This generalizes a recent result by Dinvay, Selberg and the third author where they proved low regularity well-posedness in $\mathbb{R}$ and $\mathbb{R}^{2}$.


## 1. Introduction

In this paper, we derive a $L_{x}^{1}\left(\mathbb{R}^{d}\right)-L_{x}^{\infty}\left(\mathbb{R}^{d}\right)$ time-decay estimate for the linear propagators

$$
\mathcal{S}_{\mathrm{m}_{\beta}}( \pm \mathrm{t}):=\exp \left(\mp \mathrm{itm}_{\beta}(\mathrm{D})\right),
$$

where

$$
m_{\beta}(D)=\sqrt{|D|\left(1+\beta|D|^{2}\right) \tanh |D|}
$$

with $\beta \in\{0,1\}$ and $D=-i \nabla$. The pseudo-differential operator $m_{\beta}(D)$ appears in linearized water wave type equations. The cases $\beta=0$ and $\beta=1$ correspond respectively to purely gravity waves and capillary-gravity waves.

For instance, consider the Whitham equation without or with surface tension (see e.g., [9, 12])

\begin{equation*}
u_{t}+L_{\beta} u_{x}+u u_{x}=0, \quad(\beta \geqslant 0) \tag{1.1}
\end{equation*}
$$

where $u: \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}$, and the non-local operator $L_{\beta}$ is related to the dispersion relation of the (linearized) water waves system and is defined by

$$
\mathrm{L}_{\beta}:=\mathrm{L}_{\beta}(\mathrm{D})=\sqrt{\left(1+\beta|\mathrm{D}|^{2}\right) \mathrm{K}(\mathrm{D})}
$$

with

$$
K(D)=\frac{\tanh |D|}{|D|} \quad\left(D=-i \nabla=-i \partial_{x}\right)
$$

The linear part of (1.1) can be written as

$$
\begin{equation*}
i u_{t}-\widetilde{m}_{\beta}(D) u=0, \tag{1.2}
\end{equation*}
$$

$$
\widetilde{m}_{\beta}(D)=D L_{\beta}(D)=\frac{D}{|D|} m_{\beta}(D)
$$

In terms of Fourier symbols we have $\widetilde{m}_{\beta}(\xi)=\operatorname{sgn}(\xi) m_{\beta}(\xi)$. So the solution propagator for (1.2) is given by $\mathcal{S}_{\widetilde{m}_{\beta}}(t)=\exp \left(-i t \widetilde{m}_{\beta}(D)\right)$. In fact, both $\mathcal{S}_{\widetilde{m}_{\beta}}(t)$ and $\mathcal{S}_{m_{\beta}}(t)$ satisfy the same $L_{x}^{1}(\mathbb{R})-L_{x}^{\infty}(\mathbb{R})$ time-decay estimate.

As another example, consider the full dispersion Boussinesq system (see e.g., [8, 10])

$$
\left\{\begin{array}{l}
\eta_{\mathrm{t}}+\mathrm{L}_{\beta}^{2} \nabla \cdot \mathbf{v}+\nabla \cdot(\eta \mathbf{v})=0  \tag{1.3}\\
\mathbf{v}_{\mathrm{t}}+\nabla \eta+\nabla|\mathbf{v}|^{2}=0
\end{array}\right.
$$

where

$$
\eta: \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}, \quad \mathbf{v}: \mathbb{R}^{\mathrm{d}} \times \mathbb{R} \rightarrow \mathbb{R}^{\mathrm{d}}
$$

This system describes the evolution with time of surface waves of a liquid layer, where $\eta$ and $\mathbf{v}$ denote the surface elevation and the fluid velocity, respectively. One can derive an equivalent system of (1.3), by diagonalizing its linear part. Indeed, define

$$
w_{ \pm}=\frac{\eta \mp i L_{\beta} \mathcal{R} \cdot \mathbf{v}}{2 \mathrm{~L}_{\beta}}
$$

where $(\eta, \mathbf{v})$ is a solution to (1.3), and $\mathcal{R}=|D|^{-1} \nabla$ is the Riesz transform. Then the linear part of the system (1.3) transforms to

$$
\begin{equation*}
i \partial_{\mathrm{t}} w_{ \pm} \mp \mathrm{m}_{\beta}(\mathrm{D}) w_{ \pm}=0 \tag{1.4}
\end{equation*}
$$

whose corresponding solution propagators are $\mathcal{S}_{\mathfrak{m}_{\beta}}( \pm t)=\exp \left(\mp i t m_{\beta}(D)\right)$.
As a third example, consider the Whitham-Boussinesq type system (see e.g., $[1,2,3,4]$ )

$$
\left\{\begin{align*}
\partial_{\mathrm{t}} \eta+\nabla \cdot \mathbf{v} & =-\mathrm{K} \nabla \cdot(\eta \mathbf{v})  \tag{1.5}\\
\partial_{\mathrm{t}} \mathbf{v}+\mathrm{L}_{\beta}^{2} \nabla \eta & =-\mathrm{K} \nabla\left(|\mathbf{v}|^{2} / 2\right)
\end{align*}\right.
$$

Again, by defining the new variables

$$
\begin{equation*}
u_{ \pm}=\frac{L_{\beta} \eta \mp i \mathcal{R} \cdot \mathbf{v}}{2 L_{\beta}} \tag{1.6}
\end{equation*}
$$

we see that the linear part of (1.5) transforms to

$$
\begin{equation*}
i \partial_{t} u_{ \pm} \mp m_{\beta}(D) u_{ \pm}=0 \tag{1.7}
\end{equation*}
$$

whose solution propagators are again $\mathcal{S}_{m_{\beta}}( \pm t)=\exp \left(\mp \operatorname{itm}_{\beta}(D)\right)$.
So the linear propagators $\mathcal{S}_{m_{\beta}}( \pm \mathrm{t})$ appear in all of the equations (1.1), (1.3) and (1.5). Since the symbol $m_{\beta}$ is non-homogeneous, we will derive a time-decay estimate from

$$
\mathcal{S}_{m_{\beta}}( \pm t): L_{x}^{1}\left(\mathbb{R}^{d}\right) \rightarrow L_{x}^{\infty}\left(\mathbb{R}^{d}\right)
$$

for frequency localised functions. To this end, we fix a smooth cutoff function $\chi$ such that

$$
x \in C_{0}^{\infty}(\mathbb{R}), \quad 0 \leqslant x \leqslant 1, \quad x_{[-1,1]}=1 \quad \text { and } \quad \operatorname{supp}(x) \subset[-2,2]
$$

Set

$$
\rho(s)=\chi(s)-\chi(2 s)
$$

Thus, $\operatorname{supp} \rho=\{s \in \mathbb{R}: 1 / 2 \leqslant|s| \leqslant 2\}$. For $\lambda \in 2^{\mathbb{Z}}$ we set $\rho_{\lambda}(s):=\rho(s / \lambda)$ and define the frequency projection $P_{\lambda}$ by

$$
\widehat{P_{\lambda} f}(\xi)=\rho_{\lambda}(|\xi|) \widehat{f}(\xi) .
$$

Sometimes, we write $f_{\lambda}:=P_{\lambda} f$.
Notation. For any positive numbers $a$ and $b$, the notation $a \lesssim b$ stands for $a \leqslant c b$, where $c$ is a positive constant that may change from line to line. Moreover, we denote $\mathrm{a} \sim \mathrm{b}$ when $\mathrm{a} \lesssim \mathrm{b}$ and $\mathrm{b} \lesssim \mathrm{a}$. We also set $\langle\mathrm{x}\rangle:=\left(1+|\mathrm{x}|^{2}\right)^{1 / 2}$.

For $1 \leqslant p \leqslant \infty, L_{x}^{p}\left(\mathbb{R}^{d}\right)$ denotes the usual Lebesgue space and for $s \in \mathbb{R}$, $H^{s}\left(\mathbb{R}^{d}\right)$ is the $L^{2}$-based Sobolev space with norm $\|f\|_{H^{s}}=\left\|\langle D\rangle^{s} f\right\|_{L^{2}}$. If $T>0$ and $1 \leqslant q \leqslant \infty$, we define the spaces $L^{q}\left((0, T): L^{r}\left(\mathbb{R}^{d}\right)\right)$ and $L^{q}\left(\mathbb{R}: L^{r}\left(\mathbb{R}^{d}\right)\right)$ respectively through the norms

$$
\|f\|_{L_{T}^{q} L_{x}^{r}}=\left(\int_{0}^{T}\|f(\cdot, t)\|_{L_{x}^{r}}^{q} d t\right)^{\frac{1}{q}} \quad \text { and } \quad\|f\|_{L_{t}^{q} L_{x}^{r}}=\left(\int_{\mathbb{R}}\|f(\cdot, t)\|_{L_{x}^{r}}^{p} d t\right)^{\frac{1}{q}}
$$

when $1 \leqslant \mathrm{q}<\infty$, with the usual modifications when $\mathrm{q}=+\infty$.
Our first result is as follows:
Theorem 1 (Localised dispersive estimate). Let $\beta \in\{0,1\}, d \geqslant 1$ and $\lambda \in 2^{\mathbb{Z}}$. Then

$$
\begin{equation*}
\left\|\mathcal{S}_{\mathfrak{m}_{\beta}}( \pm t) \mathrm{f}_{\lambda}\right\|_{\mathrm{L}_{\mathrm{x}}^{\infty}\left(\mathbb{R}^{\mathrm{d}}\right)} \lesssim \mathrm{c}_{\beta, \mathrm{d}}(\lambda)|\mathrm{t}|^{-\frac{\mathrm{d}}{2}}\|\mathrm{f}\|_{\mathrm{L}_{\mathrm{x}}^{1}\left(\mathbb{R}^{\mathrm{d}}\right)} \tag{1.8}
\end{equation*}
$$

for all $\mathrm{f} \in \mathcal{S}\left(\mathbb{R}^{\mathrm{d}}\right)$, where

$$
\begin{equation*}
c_{\beta, d}(\lambda)=\lambda^{\frac{d}{2}-1}\langle\sqrt{\beta} \lambda\rangle^{-\frac{d}{2}}\langle\lambda\rangle^{\frac{d}{4}+1} \tag{1.9}
\end{equation*}
$$

Remark 1. In view of (1.9) the loss of derivatives (this corresponds to the exponent of $\lambda$ ) is $3 d / 4$ in the case $\beta=0$, whereas the loss is $d / 4$ when $\beta=1$.

Once Theorem 1 is proved, the corresponding Strichartz estimates are deduced from a classical $\mathrm{TT}^{\star}$ argument.

Theorem 2 (Localised Strichartz estimate). Let $\beta \in\{0,1\}, d \geqslant 1$ and $\lambda \in 2^{\mathbb{Z}}$. Assume that the pair $(\mathbf{q}, \mathrm{r})$ satisfies the following conditions:

$$
\begin{equation*}
2<q \leqslant \infty, \quad 2 \leqslant r \leqslant \infty, \quad \frac{2}{q}+\frac{d}{r}=\frac{d}{2} \tag{1.10}
\end{equation*}
$$

Then

$$
\begin{array}{r}
\left\|\mathcal{S}_{\mathfrak{m}_{\beta}}( \pm t) f_{\lambda}\right\|_{L_{t}^{q} L_{x}^{r}\left(\mathbb{R}^{d+1}\right)} \\
\left\|\left[c_{\beta, d}(\lambda)\right]^{\frac{2}{q d}}\right\| f_{\lambda} \|_{L_{x}^{2}\left(\mathbb{R}^{d}\right)},  \tag{1.12}\\
\left\|\int_{0}^{t} \mathcal{S}_{m_{\beta}}( \pm(t-s)) F_{\lambda}(s) d s\right\|_{L_{t}^{q} L_{x}^{r}\left(\mathbb{R}^{d+1}\right)} \lesssim\left[c_{\beta, d}(\lambda)\right]^{\frac{2}{q d}}\left\|F_{\lambda}\right\|_{L_{t}^{1} L_{x}^{2}\left(\mathbb{R}^{d+1}\right)}
\end{array}
$$

for all $\mathrm{f} \in \mathcal{S}\left(\mathbb{R}^{\mathrm{d}}\right)$ and $\mathrm{F} \in \mathcal{S}\left(\mathbb{R}^{\mathrm{d}+1}\right)$, where $\mathrm{c}_{\beta, \mathrm{d}}(\lambda)$ is as in (1.9).
As an application of Theorem 2 we prove low regularity well-posedness for the system (1.5) with $\beta=0$ (i.e., for purely gravity waves) in $\mathbb{R}^{d}, d \geqslant 2$. To this end, we complement the system (1.5) with initial data

$$
\begin{equation*}
\eta(0)=\eta_{0} \in H^{s}\left(\mathbb{R}^{d}\right), \quad \mathbf{v}(0)=\mathbf{v}_{0} \in\left(H^{s+1 / 2}\left(\mathbb{R}^{d}\right)\right)^{d} \tag{1.13}
\end{equation*}
$$

Theorem 3. Let $\beta=0, \mathrm{~d} \geqslant 2$ and $\mathrm{s}>\frac{\mathrm{d}}{2}-\frac{3}{4}$. Suppose that $\mathbf{v}_{0}$ is a curl-free vector field, i.e., $\nabla \times \mathbf{v}_{0}=0$, and

$$
\left[\left\|\eta_{0}\right\|_{H^{s}\left(\mathbb{R}^{d}\right)}+\left\|\mathbf{v}_{0}\right\|_{\left(H^{s+1 / 2}\left(\mathbb{R}^{d}\right)\right)}\right] \leqslant \mathcal{D}_{0}
$$

Then there exists a solution

$$
(\eta, \mathbf{v}) \in C\left([0, T] ; H^{s}\left(\mathbb{R}^{d}\right) \times\left(H^{s+1 / 2}\left(\mathbb{R}^{d}\right)\right)^{d}\right)
$$

of the Cauchy problem (1.5), (1.13), with existence time ${ }^{1} \mathrm{~T} \sim \mathcal{D}_{0}^{-2-}$.
Moreover, the solution is unique in some subspace of the above solution space and the solution depends continuously on the initial data.

Remark 2. The following are known results:
(i) Theorem 1 and Theorem 2 are proved in [5] when $\beta=0, d \in\{1,2\}$ and $\lambda \gtrsim 1$.
(ii) Theorem 3 is proved in [5] when $d=2$. In the case $d=1$ local wellposedness for $s>-1 / 10$ and global well-posedness for small initial data in $L^{2}(\mathbb{R})$ is also established in [5]. Long-time existence of solution in the case $\mathrm{d}=2$ is also obtained in [14].

Van der Corput's Lemma will be useful in the proof of Theorem 1.
Lemma 1 (Van der Corput's Lemma, [13] ). Assume $g \in C^{1}(a, b), \psi \in C^{2}(a, b)$ and $\left|\psi^{\prime \prime}(r)\right| \geqslant A$ for all $r \in(a, b)$. Then

$$
\begin{equation*}
\left|\int_{a}^{b} e^{i t \psi(r)} g(r) d r\right| \leqslant C(A t)^{-1 / 2}\left[|g(b)|+\int_{a}^{b}\left|g^{\prime}(r)\right| d r\right] \tag{1.14}
\end{equation*}
$$

for some constant $\mathrm{C}>0$ that is independent of $\mathrm{a}, \mathrm{b}$ and t .
Lemma 1 holds even if $\psi^{\prime}(r)=0$ for some $r \in(a, b)$. However, if $\left|\psi^{\prime}(r)\right|>0$ for all $r \in(a, b)$, one can use integration by parts to obtain the following Lemma. The proof may be found elsewhere but we include it here for the reader's convenience.

Lemma 2. Suppose that $g \in C_{0}^{\infty}(a, b)$ and $\psi \in C^{\infty}(a, b)$ with $\left|\psi^{\prime}(r)\right|>0$ for all $r \in(a, b)$. If

$$
\begin{equation*}
\max _{a \leqslant r \leqslant b}\left|\partial_{r}^{j} g(r)\right| \leqslant A, \quad \max _{a \leqslant r \leqslant b}\left|\partial_{r}^{j}\left(\frac{1}{\psi^{\prime}(r)}\right)\right| \leqslant B \tag{1.15}
\end{equation*}
$$

for all $0 \leqslant \mathfrak{j} \leqslant \mathrm{~N} \in \mathbb{N}_{0}$, then

$$
\begin{equation*}
\left|\int_{a}^{b} e^{i t \psi(r)} g(r) d r\right| \lesssim A B^{N}|t|^{-N} \tag{1.16}
\end{equation*}
$$

Proof. Let

$$
I(t)=\int_{a}^{b} e^{i t \psi(r)} g(r) d r
$$

For $m, N \in \mathbb{N}_{0}$, define

$$
S_{m, N}:=\left\{\left(k_{1}, \cdots, k_{N}\right) \in \mathbb{N}_{0}: k_{1}<\cdots<k_{N} \leqslant N \& k_{1}+\cdots+k_{N}=m\right\}
$$

[^1]Integration by parts yields

$$
\begin{aligned}
I(t) & =I_{1}(t)=-i t^{-1} \int_{a}^{b} \partial_{r}\left(e^{i t \psi(r)}\right) \frac{1}{\psi^{\prime}(r)} g(r) d r \\
& =(-i t)^{-1} \int_{a}^{b} e^{i t \psi(r)}\left\{\frac{1}{\psi^{\prime}(r)} g^{\prime}(r)+\partial_{r}\left(\frac{1}{\psi^{\prime}(r)}\right) g(r)\right\} d r .
\end{aligned}
$$

Repeating the integration by parts N -times we get

$$
I(t)=I_{N}(t)=(-i t)^{-N} \sum_{m=0}^{N} \sum_{\left(k_{1}, \cdots, k_{N}\right) \in S_{m, N}} C_{k, m, N} \int_{a}^{b} e^{i t \psi(r)} E_{k, m, N}(r) d r
$$

where $C_{k, m, N}$ are constants and

$$
E_{k, m, N}(r)=\Pi_{j=1}^{N} \partial_{r}^{k_{j}}\left(\frac{1}{\psi^{\prime}(r)}\right) \cdot g^{(N-m)}(r)
$$

Applying (1.15) we obtain

$$
\left|E_{k, m, N}\right| \leqslant\left(\Pi_{j=1}^{N} B\right) A=A B^{N}
$$

and hence

$$
|\mathrm{I}(\mathrm{t})|=\left|\mathrm{I}_{\mathrm{N}}(\mathrm{t})\right| \lesssim A B^{\mathrm{N}}|\mathrm{t}|^{-\mathrm{N}}
$$

as desired.

## 2. Proof of Theorem 1

Without loss of generality we may assume $\pm=-$ and $t>0$. Now we can write

$$
\left[\mathcal{S}_{\mathfrak{m}_{\beta}}(-t) f_{\lambda}\right](x)=\left(I_{\lambda}(\cdot, t) * f\right)(x),
$$

where

$$
\begin{equation*}
I_{\lambda}(x, t)=\lambda^{d} \int_{\mathbb{R}^{\mathrm{d}}} e^{i \lambda x \cdot \xi+i t m_{\beta}(\lambda \xi)} \rho(|\xi|) d \xi \tag{2.1}
\end{equation*}
$$

By Young's inequality

$$
\begin{equation*}
\left\|\mathcal{S}_{\mathfrak{m}_{\beta}}(-t) f_{\lambda}\right\|_{L_{\chi}^{\infty}\left(\mathbb{R}^{d}\right)} \leqslant\left\|I_{\lambda(\cdot, t)}\right\|_{L_{\chi}^{\infty}\left(\mathbb{R}^{d}\right)}\|f\|_{L_{x}^{1}\left(\mathbb{R}^{d}\right)} \tag{2.2}
\end{equation*}
$$

and therefore, (1.8) reduces to proving

$$
\begin{equation*}
\left\|\mathrm{I}_{\lambda}(\cdot, \mathrm{t})\right\|_{\mathrm{L}_{x}^{\infty}\left(\mathbb{R}^{\mathrm{d}}\right)} \lesssim \mathrm{c}_{\beta, \mathrm{d}}(\lambda) \mathrm{t}^{-\frac{\mathrm{d}}{2}} \tag{2.3}
\end{equation*}
$$

Observe that

$$
\mathrm{t} \lesssim \lambda^{-1 / 2}\langle\sqrt{\beta} \lambda\rangle^{-1} \Rightarrow \mathrm{c}_{\beta, \mathrm{d}}(\lambda) \mathrm{t}^{-\frac{d}{2}} \gtrsim \lambda^{\mathrm{d}}
$$

in which case (2.3) follows from the simple estimate

$$
\left\|\mathrm{I}_{\lambda}(\cdot, \mathrm{t})\right\|_{\mathrm{L}_{\mathrm{x}}^{\infty}\left(\mathbb{R}^{\mathrm{d}}\right)} \lesssim \lambda^{\mathrm{d}} .
$$

We may therefore assume from now on

$$
\begin{equation*}
t \gg \lambda^{-1 / 2}\langle\sqrt{\beta} \lambda\rangle^{-1} \tag{2.4}
\end{equation*}
$$

2.1. Proof of (2.3) when $d=1$. In the case $d=1$ we have

$$
I_{\lambda}(x, t)=\lambda \int_{\mathbb{R}} e^{i t \phi_{\lambda}(\xi)} \rho(|\xi|) d \xi
$$

where

$$
\phi_{\lambda}(\xi):=\lambda \xi x / t+m_{\beta}(\lambda \xi) .
$$

We want to prove

$$
\begin{equation*}
\left\|\mathrm{I}_{\lambda}(\cdot, \mathrm{t})\right\|_{\mathrm{L}_{\chi}^{\infty}(\mathbb{R})} \lesssim \underbrace{\lambda^{-\frac{1}{2}}\langle\sqrt{\beta} \lambda\rangle^{-\frac{1}{2}}\langle\lambda\rangle^{\frac{5}{4}}}_{=\boldsymbol{c}_{\beta, 1}} t^{-\frac{1}{2}} \tag{2.5}
\end{equation*}
$$

under condition (2.4).
Since supp $\rho=\{\xi \in \mathbb{R}: 1 / 2 \leqslant|\xi| \leqslant 2\}$, we can write

$$
\mathrm{I}_{\lambda}(x, \mathrm{t})=\underbrace{\lambda \int_{1 / 2}^{2} e^{i t \phi_{\lambda}(\xi)} \rho(\xi) \mathrm{d} \xi}_{:=\mathrm{I}_{\lambda}^{+}(x, \mathrm{t})}+\underbrace{\lambda \int_{1 / 2}^{2} e^{i t \phi_{\lambda}(-\xi)} \rho(\xi) \mathrm{d} \xi}_{:=\mathrm{I}_{\lambda}^{-}(x, \mathrm{t})}
$$

We estimate only $I_{\lambda}^{+}(x, t)$ as the estimate for $I_{\lambda}^{-}(x, t)$ can be derived in exactly the same way. Since

$$
\begin{equation*}
\phi_{\lambda}^{\prime}(\xi)=\lambda\left[x / t+m_{\beta}^{\prime}(\lambda \xi)\right], \quad \phi_{\lambda}^{\prime \prime}(\xi)=\lambda^{2} m_{\beta}^{\prime \prime}(\lambda \xi) \tag{2.6}
\end{equation*}
$$

it follows from Lemma 5 that

$$
\begin{equation*}
\left|\phi_{\lambda}^{\prime \prime}(\xi)\right| \sim \lambda^{3}\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-5 / 2} \quad \text { for all } \xi \in[1 / 2,2] . \tag{2.7}
\end{equation*}
$$

Now we prove (2.5) by dividing the region of integration into sets of nonstationary contribution: $\left\{\xi: \phi_{\lambda}^{\prime}(\xi) \neq 0\right\}$ and stationary contribution: $\left\{\xi: \phi_{\lambda}^{\prime}(\xi)=\right.$ $0\}$.
2.1.1. Non-stationary contribution. Since $m_{\beta}^{\prime}$ is positive, the non-stationary contribution occurs if either

$$
x \geqslant 0 \quad \text { or } \quad 0<-x \ll\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-\frac{1}{2}} t \quad \text { or }-x \gg\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-\frac{1}{2}} t
$$

In this case we have

\left|\phi_{\lambda}^{\prime}(\xi)\right| \gtrsim \lambda\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-\frac{1}{2}} \quad \text { for all } \xi \in[1 / 2,2]
$$

where Lemma 5 is also used. Combining this estimate with (2.7) we get

\max _{1 / 2 \leqslant \xi \leqslant 1}\left|\partial_{\xi}\left(\frac{1}{\phi_{\lambda}^{\prime}(\xi)}\right)\right| \lesssim \lambda\langle\sqrt{\beta} \lambda\rangle^{-1}\langle\lambda\rangle^{-\frac{3}{2}} .
$$

Now this estimate can be combined with Lemma 2 for $N=1$ to estimate $I_{\lambda}(x, t)$ as

\left|\mathrm{I}_{\lambda}^{+}(x, \mathrm{t})\right| & \lesssim \lambda \cdot \lambda\langle\sqrt{\beta} \lambda\rangle^{-1}\langle\lambda\rangle^{-\frac{3}{2}} \mathrm{t}^{-1} \\
& \lesssim \lambda^{-\frac{1}{2}}\langle\sqrt{\beta} \lambda\rangle^{-\frac{1}{2}}\langle\lambda\rangle^{\frac{5}{4}} \mathrm{t}^{-\frac{1}{2}} \tag{2.8}
\end{align*}
$$

where to get the second line we used (2.4).
2.1.2. Stationary contribution. This occurs if

0<-x \sim\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-\frac{1}{2}} \mathrm{t} .
$$

In this case we use Lemma 1 and (2.7) to obtain

\left|\mathrm{I}_{\lambda}^{+}(x, \mathrm{t})\right| & \lesssim \lambda \cdot\left(\lambda^{3}\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-5 / 2} \mathrm{t}\right)^{-\frac{1}{2}}\left[|\rho(2)|+\int_{1 / 2}^{2}\left|\rho^{\prime}(\xi)\right| \mathrm{d} \xi\right]  \tag{2.9}\\
& \lesssim \lambda^{-\frac{1}{2}}\langle\sqrt{\beta} \lambda\rangle^{-\frac{1}{2}}\langle\lambda\rangle^{\frac{5}{4}} \mathrm{t}^{-\frac{1}{2}}
\end{align*}
$$

2.2. Proof of (2.3) when $d \geqslant 2$. To prove (2.3) first observe that $I_{\lambda}(x, t)$ is radially symmetric w.r.t $x$, as it is the inverse Fourier transform of the radial function $e^{\mathfrak{i t m}}{ }_{\beta}(\lambda \xi) \rho(\xi)$. So we can write (see [6, B.5])

I_{\lambda}(x, t)=\lambda^{d} \int_{1 / 2}^{2} e^{i t m_{\beta}(\lambda r)}(\lambda r|x|)^{-\frac{d-2}{2}} J_{\frac{d-2}{2}}(\lambda r|x|) r^{d-1} \rho(r) d r \tag{2.10}
\end{equation*}
$$

where $\mathrm{J}_{\alpha}(\mathrm{r})$ is the Bessel function:

\mathrm{J}_{\alpha}(\mathrm{r})=\frac{(\mathrm{r} / 2)^{\alpha}}{\Gamma(\alpha+1 / 2) \sqrt{\pi}} \int_{-1}^{1} e^{\mathrm{irs}}\left(1-s^{2}\right)^{\alpha-1 / 2} \mathrm{ds} \quad \text { for } \alpha>-1 / 2
$$

The Bessel function $\mathrm{J}_{\alpha}(\mathrm{r})$ satisfies the following properties for $\alpha>-1 / 2$ and $\mathrm{r}>0$ (See [6, Appendix B] and [13]):

\begin{align*}
\mathrm{J}_{\alpha}(\mathrm{r}) & \leqslant \mathrm{Cr}^{\alpha}  \tag{2.11}\\
\mathrm{J}_{\alpha}(\mathrm{r}) & \leqslant \mathrm{Cr}^{-1 / 2},  \tag{2.12}\\
\partial_{\mathrm{r}}\left[\mathrm{r}^{-\alpha} \mathrm{J}_{\alpha}(\mathrm{r})\right] & =-\mathrm{r}^{-\alpha} \mathrm{J}_{\alpha+1}(\mathrm{r}) \tag{2.13}
\end{align*}
$$

Moreover, it is known that (see [7, Chapter 1, Eq. (1.5)]),

r^{-\frac{d-2}{2}} J_{\frac{d-2}{2}}(s)=e^{i s} h(s)+e^{-i s} \bar{h}(s) \tag{2.14}
\end{equation*}
$$

for some function $h$ satisfying the decay estimate

\begin{equation*}
\left|\partial_{r}^{k} h(r)\right| \leqslant C_{k}\langle r\rangle^{-\frac{d-1}{2}-k} \quad(k \geqslant 0) \tag{2.15}
\end{equation*}
$$

We use the short hand

$$
m_{\beta, \lambda}(r)=m_{\beta}(\lambda r), \quad \tilde{J}_{a}(r)=r^{-a} J_{a}(r), \quad \tilde{\rho}(r)=r^{d-1} \rho(r)
$$

Hence

$$
\begin{equation*}
I_{\lambda}(x, t)=\lambda^{d} \int_{1 / 2}^{2} e^{i t m_{\beta, \lambda}(r)} \tilde{J}_{\frac{d-2}{2}}(\lambda r|x|) \tilde{\rho}(r) d r \tag{2.16}
\end{equation*}
$$

We prove (2.3) by treating the cases $|x| \lesssim \lambda^{-1}$ and $|x| \gg \lambda^{-1}$ separately.
2.2.1. Case 1: $|x| \lesssim \lambda^{-1}$. By (2.11) and (2.13) we have for all $r \in(1 / 2,2)$ the estimate

\max _{1 / 2 \leqslant r \leqslant 1}\left|\partial_{r}^{k}\left(\frac{1}{m_{\beta, \lambda}^{\prime}(r)}\right)\right| \underset{\kappa}{\lesssim} \lambda^{-1}\langle\sqrt{\beta} \lambda\rangle^{-1}\langle\lambda\rangle^{\frac{1}{2}} \quad(k \geqslant 0) . \tag{2.18}
\end{equation*}
$$

Applying Lemma 2 with (2.17)-(2.18) and $\mathrm{N}=\mathrm{d} / 2$ to (2.16) we obtain

\begin{align*}
\left|\mathrm{I}_{\lambda}(x, \mathrm{t})\right| & \lesssim \lambda^{\mathrm{d}} \cdot\left(\lambda^{-1}\langle\sqrt{\beta} \lambda\rangle^{-1}\langle\lambda\rangle^{\frac{1}{2}}\right)^{\mathrm{d} / 2} \mathrm{t}^{-\mathrm{d} / 2}  \tag{2.19}\\
& \lesssim \mathrm{c}_{\beta, \mathrm{d}}(\lambda) \mathrm{t}^{-\frac{\mathrm{d}}{2}}
\end{align*}
$$

where to get the second line we used (2.4).
2.2.2. Case $2:|x| \gg \lambda^{-1}$. Using (2.14) in (2.16) we write

I_{\lambda}(x, t)=\lambda^{d}\left[\int_{1 / 2}^{2} e^{i t \phi_{\lambda}^{+}(r)} h(\lambda r|x|) \tilde{\rho}(r) d r+\int_{1 / 2}^{2} e^{-i t \phi_{\lambda}^{-}(r)} \bar{h}(\lambda r|x|) \tilde{\rho}(r) d r\right]
$$

where

$$
\phi_{\lambda}^{ \pm}(r)=\lambda r|x| / t \pm m_{\beta, \lambda}(r)
$$

Set $H_{\lambda}(|x|, r):=h(\lambda r|x|) \tilde{\rho}(r)$. In view of (2.15) we have

$$
\begin{equation*}
\max _{1 / 2 \leqslant r \leqslant 2}\left|\partial_{r}^{k} H_{\lambda}(|x|, r)\right| \lesssim(\lambda|x|)^{-\frac{d-1}{2}} \quad(k \geqslant 0) \tag{2.20}
\end{equation*}
$$

where we also used the fact $\lambda|x| \gg 1$.
Now we write

$$
\mathrm{I}_{\lambda}(\mathrm{x}, \mathrm{t})=\mathrm{I}_{\lambda}^{+}(\mathrm{x}, \mathrm{t})+\mathrm{I}_{\lambda}^{-}(\mathrm{x}, \mathrm{t})
$$

where

$$
\begin{aligned}
& I_{\lambda}^{+}(x, t)=\lambda^{d} \int_{1 / 2}^{2} e^{i t \phi_{\lambda}^{+}(r)} H_{\lambda}(|x|, r) d r \\
& I_{\lambda}^{-}(x, t)=\lambda^{d} \int_{1 / 2}^{2} e^{-i t \phi_{\lambda}^{-}(r)} \bar{H}_{\lambda}(|x|, r) d r .
\end{aligned}
$$

Observe that

$$
\partial_{r} \phi_{\lambda}^{ \pm}(r)=\lambda\left[|x| / t \pm m_{\beta}^{\prime}(\lambda r)\right], \quad \partial_{r}^{2} \phi_{\lambda}^{ \pm}(r)= \pm \lambda^{2} m_{\beta}^{\prime \prime}(\lambda r),
$$

and hence by Lemma 5,

$$
\begin{equation*}
\left|\partial_{\mathrm{r}} \phi_{\lambda}^{+}(\mathrm{r})\right| \gtrsim \lambda\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-1 / 2}, \quad\left|\partial_{\mathrm{r}}^{2} \phi_{\lambda}^{ \pm}(\mathrm{r})\right| \sim \lambda^{3}\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-5 / 2} \tag{2.21}
\end{equation*}
$$

for all $r \in(1 / 2,2)$, where we also used the fact that $m_{\beta}^{\prime}$ is positive.
Estimate for $\mathrm{I}_{\lambda}^{+}(\mathrm{x}, \mathrm{t})$. Following as in the proof of Corollary 2, we have

$$
\begin{equation*}
\max _{1 / 2 \leqslant r \leqslant 2}\left|\partial_{r}^{k}\left(\left[\partial_{r} \phi_{\lambda}^{+}(r)\right]^{-1}\right)\right| \underset{\kappa}{\lesssim} \lambda^{-1}\langle\sqrt{\beta} \lambda\rangle^{-1}\langle\lambda\rangle^{\frac{1}{2}} \quad(k \geqslant 0) \tag{2.22}
\end{equation*}
$$

Applying Lemma 2 with (2.20), (2.22) and $N=d / 2$ to $I_{\lambda}^{+}(x, t)$ we obtain

$$
\begin{align*}
\left|I_{\lambda}^{+}(x, t)\right| & \lesssim \lambda^{d} \cdot(\lambda|x|)^{-\frac{d-1}{2}} \cdot\left(\lambda^{-1}\langle\sqrt{\beta} \lambda\rangle^{-1}\langle\lambda\rangle^{\frac{1}{2}}\right)^{d / 2} t^{-d / 2}  \tag{2.23}\\
& \lesssim c_{\beta, d}(\lambda) t^{-\frac{d}{2}},
\end{align*}
$$

where to get the second line we used the fact that $\lambda|x| \gg 1$, and the condition in (2.4).

Estimate for $\mathrm{I}_{\lambda}^{-}(\mathrm{x}, \mathrm{t})$. We treat the the non-stationary and stationary cases separately. In the non-stationary case, where

|x| \ll\langle\beta \lambda\rangle\langle\lambda\rangle^{-1 / 2} \mathrm{t} \quad \text { or } \quad|x| \gg\langle\beta \lambda\rangle\langle\lambda\rangle^{-1 / 2} \mathrm{t}
$$

\left|\partial_{\mathrm{r}} \phi_{\lambda}^{-}(\mathrm{r})\right| \gtrsim \lambda\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-1 / 2},

and hence $I_{\lambda}^{-}(x, t)$ can be estimated in exactly the same way as $I_{\lambda}^{+}(x, t)$ above, and satisfies the same bound as in (2.23).

So it remains to treat the stationary case:

In this case, we use Lemma 1, (2.21) and(2.20) to obtain

\mid \mathrm{I}_{\lambda}^{-}(\mathrm{x}, \mathrm{t}) & \lesssim \lambda^{\mathrm{d}} \cdot\left(\lambda^{3}\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-5 / 2} \mathrm{t}\right)^{-\frac{1}{2}}\left[\left|\mathrm{H}_{\lambda}^{-}(\mathrm{x}, 2)\right|+\int_{1 / 2}^{2}\left|\partial_{\mathrm{r}} \mathrm{H}_{\lambda}^{-}(\mathrm{x}, \mathrm{r})\right| \mathrm{dr}\right] \\
& \lesssim \lambda^{\mathrm{d}-\frac{3}{2}}\langle\sqrt{\beta} \lambda\rangle^{-\frac{1}{2}}\langle\lambda\rangle^{\frac{5}{4}} \mathrm{t}^{-\frac{1}{2}} \cdot(\lambda|x|)^{-\frac{\mathrm{d}-1}{2}}  \tag{2.24}\\
& \lesssim \mathrm{c}_{\beta, \mathrm{d}}(\lambda) \mathrm{t}^{-\frac{\mathrm{d}}{2}}
\end{align*}
$$

where we also used the fact that $H_{\lambda}^{-}(x, 2)=0$ and $|x| \sim\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-1 / 2} t$.

## 3. Proof of Theorem 2

We shall use the Hardy-Littlewood-Sobolev inequality which asserts that

We prove only (1.11) since (1.12) follows from (1.11) by the standard TT*argument. First note that (1.11) holds true for the pair $(q, r)=(\infty, 2)$ as this is just the energy inequality. So we may assume $2<q<\infty$ and $r>2$.

Let $q^{\prime}$ and $r^{\prime}$ be the conjugates of $q$ and $r$, respectively, i.e., $q^{\prime}=\frac{q}{q-1}$ and $r^{\prime}=\frac{r}{r-1}$. By the standard $\mathrm{TT}^{*}$-argument, (1.11) is equivalent to the estimate

\left\|\mathrm{TT}^{*} \mathrm{~F}\right\|_{\mathrm{L}_{\mathrm{t}}^{q} \mathrm{~L}_{x}^{r}\left(\mathbb{R}^{d+1}\right)} \lesssim\left[\mathrm{c}_{\beta, \mathrm{d}}(\lambda)\right]^{1-\frac{2}{r}}\|\mathrm{~F}\|_{\mathrm{L}_{\mathrm{t}}^{q^{\prime}} \mathrm{L}_{x}^{\mathrm{r}^{\prime}}\left(\mathbb{R}^{\mathrm{d}+1}\right)^{\prime}} \tag{3.2}
\end{equation*}
$$

where

$$
\begin{align*}
\mathrm{TT}^{*} \mathrm{~F}(\mathrm{x}, \mathrm{t}) & =\int_{\mathbb{R}^{\mathrm{d}}} \int_{\mathbb{R}} e^{i x \xi-\mathfrak{i}(\mathrm{t}-\mathrm{s}) \mathfrak{m}(\xi)} \rho_{\lambda}^{2}(\xi) \widehat{\mathrm{F}}(\xi, s) \mathrm{dsd} \xi  \tag{3.3}\\
& =\int_{\mathbb{R}} K_{\lambda, \mathrm{t}-\mathrm{s}} * \mathrm{~F}(\cdot, \mathrm{~s}) \mathrm{ds}
\end{align*}
$$

with

$$
K_{\lambda, \mathrm{t}}(x)=\int_{\mathbb{R}^{\mathrm{d}}} e^{i x \xi-i \operatorname{tm}(\xi)} \rho_{\lambda}^{2}(\xi) \mathrm{d} \xi
$$

Since

$$
K_{\lambda, t} * g(x)=e^{i t m(D)} P_{\lambda} g_{\lambda}(x)
$$

it follows from (1.8) that

\begin{equation*}
\left\|K_{\lambda, t} * g\right\|_{L_{\chi}^{\infty}\left(\mathbb{R}^{d}\right)} \lesssim c_{\beta, d}(\lambda)|t|^{-\frac{d}{2}}\|g\|_{L_{\chi}^{1}\left(\mathbb{R}^{d}\right)} \tag{3.4}
\end{equation*}
$$

On the other hand, we have by Plancherel

\begin{equation*}
\left\|\mathrm{K}_{\lambda, \mathrm{t}} * \mathrm{~g}\right\|_{\mathrm{L}_{\mathrm{x}}^{2}\left(\mathbb{R}^{\mathrm{d}}\right)} \lesssim\|\mathrm{g}\|_{\mathrm{L}_{x}^{2}\left(\mathbb{R}^{\mathrm{d}}\right)} \tag{3.5}
\end{equation*}
$$

So interpolation between (3.4) and (3.5) yields

\begin{equation*}
\left\|\mathrm{K}_{\lambda, \mathrm{t}} * \mathrm{~g}\right\|_{\mathrm{L}_{\mathrm{x}}^{\mathrm{r}}\left(\mathbb{R}^{\mathrm{d}}\right)} \lesssim\left[\mathrm{c}_{\beta, \mathrm{d}}(\lambda)\right]^{1-\frac{2}{r}}|\mathrm{t}|^{-\mathrm{d}\left(\frac{1}{2}-\frac{1}{r}\right)}\|\mathrm{g}\|_{\mathrm{L}_{\mathrm{x}}^{\mathrm{r}^{\prime}}\left(\mathbb{R}^{\mathrm{d}}\right)} \tag{3.6}
\end{equation*}
$$

for all $r \in[2, \infty]$.
Applying Minkowski's inequality to (3.3), and then use (3.6) and (3.1) with

$$
(a, b)=\left(q, q^{\prime}\right), \quad \gamma=\frac{d}{2}-\frac{d}{r}=\frac{2}{q}
$$

we obtain

$$
\begin{aligned}
\left\|T^{*} F\right\|_{L_{t}^{q} L_{x}^{r}\left(\mathbb{R}^{d+1}\right)} & \leqslant\left\|\int_{\mathbb{R}}\right\| K_{\lambda, t-s,} * F(s, \cdot)\left\|_{L_{x}^{r}\left(\mathbb{R}^{d}\right)} d s\right\|_{L_{t}^{q}(\mathbb{R})} \\
& \lesssim\left[c_{\beta, d}(\lambda)\right]^{1-\frac{2}{r}}\left\|\int_{\mathbb{R}}|t-s|^{-d\left(\frac{1}{2}-\frac{1}{r}\right)}\right\| F(s, \cdot)\left\|_{L_{x}^{r^{\prime}}\left(\mathbb{R}^{d}\right)} d s\right\|_{L_{t}^{q}(\mathbb{R})} \\
& \lesssim\left[c_{\beta, d}(\lambda)\right]^{1-\frac{2}{r}}\| \| F\left\|_{L_{x}^{r^{\prime}}\left(\mathbb{R}^{d}\right)}\right\|_{L_{t}^{q^{\prime}}(\mathbb{R})} \\
& =\left[c_{\beta, d}(\lambda)\right]^{1-\frac{2}{r}}\|F\|_{L_{t}^{q^{\prime}}} L_{x}^{\prime^{\prime}}\left(\mathbb{R}^{d+1}\right)
\end{aligned}
$$

which is the desired estimate (3.2).

## 4. Proof of Theorem 3

We consider the system (1.5) with $\beta=0$ and a curl-free vector field $\mathbf{v}$, i.e., $\nabla \times \mathbf{v}=0$. Observe that

where we have used the fact that $\mathbf{v}$ is curl-free, in which case,

\nabla(\nabla \cdot \mathbf{v})=\Delta \mathbf{v}=-|\mathrm{D}|^{2} \mathbf{v} \quad \Rightarrow \quad \mathbf{v}=-\mathcal{R}(\mathcal{R} \cdot \mathbf{v})
$$

Consequently, the Cauchy problem (1.5), (1.13) transforms to

\left(i \partial_{t} \mp m_{0}(D)\right) u_{ \pm} & =\mathcal{B}^{ \pm}\left(u_{+}, u_{-}\right)  \tag{4.1}\\
u_{ \pm}(0) & =f_{ \pm}
\end{align*}\right.
$$

where

$$
\begin{gather*}
\mathcal{B}^{ \pm}\left(u_{+}, u_{-}\right)=2^{-1}|\mathrm{D}| \mathrm{K} \mathcal{R} \cdot\left\{\left(u_{+}+u_{-}\right) \mathcal{R} \sqrt{\mathrm{K}}\left(\mathbf{u}_{+}-u_{-}\right)\right\} \\
\pm 4^{-1}|\mathrm{D}| \sqrt{\mathrm{K}}\left|\mathcal{R} \sqrt{\mathrm{~K}}\left(\mathbf{u}_{+}-\mathrm{u}_{-}\right)\right|^{2} \tag{4.2}
\end{gather*}
$$

and

$$
\begin{equation*}
f_{ \pm}=\frac{\sqrt{\mathrm{K}} \eta_{0} \mp i \mathcal{R} \cdot \mathbf{v}_{0}}{2 \sqrt{\mathrm{~K}}} \in \mathrm{H}^{\mathrm{s}}\left(\mathbb{R}^{\mathrm{d}}\right) \tag{4.3}
\end{equation*}
$$

Thus, Theorem 3 redues to the following:
Theorem 4. Let $\mathrm{d} \geqslant 3$ and $\mathrm{s}>\frac{\mathrm{d}}{2}-\frac{3}{4}$. If the initial data has size

\mathrm{u}_{ \pm} \in \mathrm{C}\left([0, \mathrm{~T}] ; \mathrm{H}^{\mathrm{s}}\left(\mathbb{R}^{\mathrm{d}}\right) \times \mathrm{H}^{\mathrm{s}}\left(\mathbb{R}^{\mathrm{d}}\right)\right)
$$

of the Cauchy problem (4.1)-(4.3) with existence time $\mathrm{T} \sim \mathcal{D}_{0}^{-2}$.
Moreover, the solution is unique in some subspace of $\mathrm{C}\left([0, \mathrm{~T}] ; \mathrm{H}^{\mathrm{s}}\left(\mathbb{R}^{\mathrm{d}}\right) \times \mathrm{H}^{\mathrm{s}}\left(\mathbb{R}^{\mathrm{d}}\right)\right)$ and the solution depends continuously on the initial data.
4.1. Reduction of Theorem 4 to bilinear estimates. The bilinear terms in (4.2) can be written as

\end{aligned}
$$

where $\pm_{1}$ and $\pm_{2}$ are independent signs. Then the Duhamel's representation of (4.1) is given by

& \mp \frac{i}{4} \sum_{ \pm_{1}, \pm_{2}}\left( \pm_{1}\right)\left( \pm_{2}\right) \mathcal{B}_{2}^{ \pm}\left(u_{ \pm_{1}}, u_{ \pm_{2}}\right)(t) \tag{4.4}
\end{align*}
$$

where $\mathcal{S}_{m_{0}}(\mathrm{t})=\mathrm{e}^{\mathrm{itm}(\mathrm{m})}$ and

& \mathcal{B}_{2}^{ \pm}(u, v)(\mathrm{t}):=\int_{0}^{\mathrm{t}} \mathcal{S}_{\mathfrak{m}_{0}}\left( \pm\left(\mathrm{t}-\mathrm{t}^{\prime}\right) \mathrm{D} \sqrt{\mathrm{~K}}(\mathcal{R} \sqrt{\mathrm{~K}} u \cdot \mathcal{R} \sqrt{\mathrm{~K}} v)\left(\mathrm{t}^{\prime}\right) d \mathrm{t}^{\prime}\right.
\end{align*}
$$

Setting $\beta=0$ in Theorem 2 we obtain the following.
Corollary 1. Let $\lambda \in 2^{\mathbb{Z}}$ and $\mathrm{d} \geqslant 2$. Assume that the pair $(\mathrm{q}, \mathrm{r})$ satisfies

\left\|\int_{0}^{t} \mathcal{S}_{m_{0}}( \pm(t-s)) F_{\lambda}(s) d s\right\|_{L_{t}^{q} L_{x}^{r}\left(\mathbb{R}^{d+1}\right)} \lesssim\langle\lambda\rangle^{\frac{3}{2 q}}\left\|F_{\lambda}\right\|_{L_{t}^{1} L_{\chi}^{2}\left(\mathbb{R}^{d+1}\right)} \tag{4.7}
\end{array}
$$

for all $\mathrm{f} \in \mathcal{S}\left(\mathbb{R}^{\mathrm{d}}\right)$ and $\mathrm{F} \in \mathcal{S}\left(\mathbb{R}^{\mathrm{d}+1}\right)$.

Now, define the contraction space, $X_{T}^{s}$ via the norm

with

2<\mathrm{q}<\infty, \quad \mathrm{r}=\frac{2 \mathrm{qd}}{\mathrm{qd}-4}, \quad \mathrm{~d} \geqslant 2 \tag{4.8}
\end{equation*}

In view of Corollary 1 the pair ( $q, r$ ) satisfying (4.8) is an admissible pair.
Observe that

& \sim\left\|f_{ \pm}\right\|_{\mathrm{H}^{s}}
\end{align*}

So Theorem 4 reduces to proving bilinear estimates on the terms $\mathcal{B}_{1}^{ \pm}(u, v)$ and $\mathcal{B}_{2}^{ \pm}(u, v)$ that are defined in (4.5). The proof of the following Lemma will be given in the next section.
Lemma 3. Let $\mathrm{d} \geqslant 2, \mathrm{~s}>\frac{\mathrm{d}}{2}-\frac{1}{2}-\frac{1}{2 \mathrm{q}}$ for $\mathrm{q}>2$, and $\mathrm{T}>0$. Then

for all $u, v \in X_{T}^{s}$, where $\mathcal{B}_{1}^{ \pm}$and $\mathcal{B}_{2}^{ \pm}$are as in (4.5).
4.2. Proof of Theorem 4. Given that Lemma 3 holds, we solve the integral equations (4.4) by contraction mapping techniques. We shall apply Lemma 3 with

By (4.10) and Lemma 3 we have

& \leqslant C D_{0}+C^{\frac{1}{2}+\varepsilon}\left(2 C D_{0}\right)^{2} \\
& \leqslant 2 C D_{0}
\end{aligned}
$$

provided that

T \leqslant\left(8 C^{2} \mathcal{D}_{0}\right)^{-\frac{2}{1+2 \varepsilon}} \tag{4.13}
\end{equation*}
$$

Similarly, for two pair of solutions $\left(u_{+}, u_{-}\right)$and $\left(v_{+}, v_{-}\right)$in $E_{T}$ with the same data, one can derive the difference estimate

& \quad \leqslant 4 C^{2} T^{\frac{1}{2}+\varepsilon} \mathcal{D}_{0}\left(\sum_{ \pm}\left\|u_{ \pm}-v_{ \pm}\right\|_{X_{T}^{s}}\right) \\
& \quad \leqslant \frac{1}{2}\left(\sum_{ \pm}\left\|u_{ \pm}-v_{ \pm}\right\|_{X_{T}^{s}}\right)
\end{aligned}
$$

where in the last inequality we used (4.13).
Therefore, $\left(\Phi^{+}, \Phi^{-}\right)$is a contraction on $E_{T}$ and therefore it has a unique fixed point $\left(u_{+}, u_{-}\right) \in E_{T}$ solving the integral equation (4.4)-(4.5) on $\mathbb{R}^{d} \times[0, T]$, where $\mathrm{T} \sim \mathcal{D}_{0}^{-2-}$. Uniqueness in the space $X_{T}^{s} \times X_{T}^{s}$ and continuous dependence on the initial data can be shown in a similar way, by the difference estimates. This concludes the proof of Theorems 4.

## 5. Proof of Lemma 3

First we prove some bilinear estimates in Lemma 4 below that will be crucial in the proof of Lemma 3. To do so, we need the following Bernstein inequality, which is valid for $1 \leqslant a \leqslant b \leqslant \infty$ (see, for instance, [15, Appendix A]).

where we used $K(\xi) \sim\langle\xi\rangle^{-1}$.
Lemma 4. Let $d \geqslant 2, q>2, T>0$ and $\lambda_{j} \in 2^{\mathbb{Z}}(j=0,1,2)$. Then

\lesssim \frac{\mathrm{~T}^{1-\frac{1}{q}} \min \left(\left\langle\lambda_{1}\right\rangle,\left\langle\lambda_{2}\right\rangle\right)^{\frac{d}{2}-\frac{1}{2 q}}}{\left\langle\lambda_{2}\right\rangle^{\frac{1}{2}}}\|u\|_{\mathrm{X}_{\lambda_{1}}}\|v\|_{{X_{\lambda_{2}}}},  \tag{5.4}\\
\left\||\mathrm{D}| \sqrt{\mathrm{K}} \mathrm{P}_{\lambda_{0}}\left(\mathcal{R} \sqrt{\mathrm{~K}} u_{\lambda_{1}} \cdot \mathcal{R} \sqrt{\mathrm{~K}} v_{\lambda_{2}}\right)\right\|_{\mathrm{L}_{\mathrm{T}}^{1} \mathrm{~L}_{x}^{2}}
\end{gather*}
$$

for all $u \in X_{\lambda_{1}}$ and $v \in X_{\lambda_{2}}$.
Proof. We only prove (5.3) since the proof for (5.4) is similar. To prove (5.3), by symmetry, we may assume $\lambda_{1} \lesssim \lambda_{2}$. Let

& \lesssim \mathrm{~T}^{\frac{1}{2}}\left\langle\lambda_{2}\right\rangle^{-\frac{1}{2}}\left\|u_{\lambda_{1}}\right\|_{\mathrm{L}_{\mathrm{T}}^{2} \mathrm{~L}_{x}^{\infty}}\left\|v_{\lambda_{2}}\right\|_{\mathrm{L}_{\mathrm{T}}^{\infty} \mathrm{L}_{x}^{2}} \\
& \lesssim \mathrm{~T}^{1-\frac{1}{q}}\left\langle\lambda_{2}\right\rangle^{-\frac{1}{2}} \lambda_{1}^{\frac{d}{2}-\frac{2}{q}}\left\|u_{\lambda_{1}}\right\|_{\mathrm{L}_{\mathrm{T}}^{\frac{q}{2}} \mathrm{~L}_{x}^{\mathrm{x}}}\left\|v_{\lambda_{2}}\right\|_{\mathrm{L}_{\mathrm{T}}^{\infty} \mathrm{L}_{x}^{2}} \\
& \lesssim \mathrm{~T}^{1-\frac{1}{q}}\left\langle\lambda_{2}\right\rangle^{-\frac{1}{2}} \lambda_{1}^{\frac{d}{2}-\frac{2}{q}}\left\langle\lambda_{1}\right\rangle^{\frac{3}{2 q}}\|u\|_{X_{\lambda_{1}}}\|v\|_{X_{\lambda_{2}}} \\
& \lesssim \mathrm{~T}^{\frac{1}{2}}\left\langle\lambda_{2}\right\rangle^{-\frac{1}{2}}\left\langle\lambda_{1}\right\rangle^{\frac{d}{2}-\frac{1}{2 q}}\|u\|_{X_{\lambda_{1}}}\|v\|_{X_{\lambda_{2}}}
\end{aligned}
$$

which proves (5.3).
Now we are ready to prove Lemma 3. To this end, we decompose $u=\sum_{\lambda} u_{\lambda}$ and $v=\sum_{\lambda} v_{\lambda}$. Note that by denoting

where (4.9) is also used. By the dyadic decomposition

\left\||\mathrm{D}| \mathrm{K} \mathcal{R} \cdot \mathrm{P}_{\lambda_{0}}(u \mathcal{R} \sqrt{\mathrm{~K}} v)\right\|_{\mathrm{L}_{\mathrm{T}}^{1} \mathrm{~L}_{\mathrm{x}}^{2}} \lesssim \sum_{\lambda_{1}, \lambda_{2}}\left\||\mathrm{D}| \mathrm{K} \mathcal{R} \cdot \mathrm{P}_{\lambda_{0}}\left(u_{\lambda_{1}} \mathcal{R} \sqrt{\mathrm{~K}} v_{\lambda_{2}}\right)\right\|_{\mathrm{L}_{\mathrm{T}}^{1} \mathrm{~L}_{\mathrm{x}}^{2}} \tag{5.6}
\end{equation*}
$$

Now let $\lambda_{\min }, \lambda_{\text {med }}$ and $\lambda_{\max }$ denote the minimum, median and the maximum of $\left\{\lambda_{0}, \lambda_{1}, \lambda_{2}\right\}$, respectively. By checking the support properties in Fourier space of the bilinear term on the right hand side of (5.6) one can see that this term vanishes unless $\boldsymbol{\lambda}=\left(\lambda_{0}, \lambda_{1}, \lambda_{2}\right) \in \Lambda$, where

By using these facts, and applying (5.3) to the right hand side of (5.6), we get

\mathcal{J}_{j}=\sum_{\lambda_{0}}\left\langle\lambda_{0}\right\rangle^{2 s}\left[\sum_{\lambda_{1}, \lambda_{2}: \lambda \in \Lambda_{j}} \frac{\min \left(\left\langle\lambda_{1}\right\rangle,\left\langle\lambda_{2}\right\rangle\right)^{\frac{d}{2}-\frac{1}{2 q}}}{\left\langle\lambda_{2}\right\rangle^{\frac{1}{2}}} a_{\lambda_{1}} b_{\lambda_{2}}\right]^{2} \tag{5.7}
\end{equation*}
$$

So (4.11) reduces to proving

These are shown to hold as follows:

\mathcal{J}_{0} & \lesssim \sum_{\lambda_{0}}\left\langle\lambda_{0}\right\rangle^{2 s}\left(\sum_{\lambda_{1} \sim \lambda_{2} \gtrsim \lambda_{0}} a_{\lambda_{1}} \cdot\left\langle\lambda_{2}\right\rangle^{\frac{d}{2}-\frac{1}{2}-\frac{1}{2 q}} b_{\lambda_{2}}\right)^{2} \\
& \lesssim \sum_{\lambda_{0}}\left\langle\lambda_{0}\right\rangle^{-2\left(s-\frac{d}{2}+\frac{1}{2}+\frac{1}{2 q}\right)}\left(\sum_{\lambda_{1} \sim \lambda_{2} \gtrsim \lambda_{0}}\left\langle\lambda_{1}\right\rangle^{s} a_{\lambda_{1}} \cdot\left\langle\lambda_{2}\right\rangle^{s} b_{\lambda_{2}}\right)^{2} \\
& \lesssim\|u\|_{X_{\mathrm{T}}^{s}}^{2}\|v\|_{X_{\mathrm{T}}^{s}}^{2},
\end{aligned}
$$

where to obtain the last line we used Cauchy Schwarz inequality in $\lambda_{1} \sim \lambda_{2}$ and (5.5).

Similarly,

$$
\begin{aligned}
\mathcal{J}_{1} & \lesssim \sum_{\lambda_{0}}\left\langle\lambda_{0}\right\rangle^{2 s}\left(\sum_{\lambda_{2}<\lambda_{1} \sim \lambda_{0}} a_{\lambda_{1}} \cdot\left\langle\lambda_{2}\right\rangle^{\frac{d}{2}-\frac{1}{2}-\frac{1}{2 q}} b_{\lambda_{2}}\right)^{2} \\
& \lesssim \sum_{\lambda_{0}}\left\langle\lambda_{0}\right\rangle^{2 s} a_{\lambda_{0}}^{2}\left(\sum_{\lambda_{2}}\left\langle\lambda_{2}\right\rangle^{\frac{d}{2}-\frac{1}{2}-\frac{1}{2 q}} b_{\lambda_{2}}\right)^{2} \\
& \lesssim\|u\|_{X_{\mathrm{T}}^{s}}^{2}\|v\|_{X_{\mathrm{T}}^{s}}^{2}
\end{aligned}
$$

where to get the last two inequalities we used $\sum_{\lambda_{1} \sim \lambda_{0}} a_{\lambda_{1}} \sim a_{\lambda_{0}}$ and by Cauchy Schwarz

$$
\begin{aligned}
\sum_{\lambda_{2}}\left\langle\lambda_{2}\right\rangle^{\frac{\mathrm{d}}{2}-\frac{1}{2}-\frac{1}{2 q}} \mathrm{~b}_{\lambda_{2}} & =\sum_{\lambda_{2}}\left\langle\lambda_{2}\right\rangle^{\frac{\mathrm{d}}{2}-\frac{1}{2}-\frac{1}{2 q}-s} \cdot\left\langle\lambda_{2}\right\rangle^{s} \mathrm{~b}_{\lambda_{2}} \\
& \lesssim\left\|\left(\left\langle\lambda_{2}\right\rangle^{s} \mathrm{~b}_{\lambda_{2}}\right)\right\|_{\mathrm{l}_{\lambda_{2}}^{2}} \lesssim\|v\|_{\mathrm{X}_{\mathrm{T}}^{\mathrm{s}}}
\end{aligned}
$$

Finally,

$$
\begin{aligned}
\mathrm{J}_{2} & \lesssim \sum_{\lambda_{0}}\left\langle\lambda_{0}\right\rangle^{2 s}\left(\sum_{\lambda_{1} \ll \lambda_{2} \sim \lambda_{0}}\left\langle\lambda_{1}\right\rangle^{\frac{\mathrm{d}}{2}-\frac{1}{2}-\frac{1}{2 q}} \mathrm{a}_{\lambda_{1}} \cdot \mathrm{~b}_{\lambda_{2}}\right)^{2} \\
& \lesssim \sum_{\lambda_{0}}\left\langle\lambda_{0}\right\rangle^{2 s} \mathrm{~b}_{\lambda_{0}}^{2}\left(\sum_{\lambda_{1}}\left\langle\lambda_{1}\right\rangle^{\frac{\mathrm{d}}{2}-\frac{1}{2}-\frac{1}{2 q}} \mathrm{a}_{\lambda_{1}}\right)^{2} \\
& \lesssim\|u\|_{\mathrm{X}_{\mathrm{T}}^{s}}^{2}\|v\|_{\mathrm{X}_{\mathrm{T}}}^{2} .
\end{aligned}
$$

5.2. Proof of (4.12). Arguing as in the preseding subsection we apply (4.7) to $\mathcal{B}_{2}^{ \pm}(u, v)$ in (4.5) and then use (5.4) to obtain

$$
\left\|\mathcal{B}_{2}^{ \pm}(u, v)\right\|_{X_{T}^{s}}^{2} \lesssim T^{2-\frac{2}{q}} \sum_{j=0}^{2} \widetilde{\mathcal{J}}_{j}
$$

where

$$
\widetilde{\mathcal{J}}_{\mathfrak{j}}=\sum_{\lambda_{0}}\left\langle\lambda_{0}\right\rangle^{2 s}\left[\sum_{\lambda_{1}, \lambda_{2} \in \Lambda_{j}} C\left(\lambda_{0}, \lambda_{1}, \lambda_{2}\right) a_{\lambda_{1}} b_{\lambda_{2}}\right]^{2}
$$

with

$$
\mathrm{C}\left(\lambda_{0}, \lambda_{1}, \lambda_{2}\right)=\frac{\left\langle\lambda_{0}\right\rangle^{\frac{1}{2}} \min \left(\left\langle\lambda_{1}\right\rangle,\left\langle\lambda_{2}\right\rangle\right)^{\frac{d}{2}-\frac{1}{2 q}}}{\left\langle\lambda_{1}\right\rangle^{\frac{1}{2}}\left\langle\lambda_{2}\right\rangle \cdot \frac{1}{2}}
$$

So (4.12) reduces to proving

$$
\widetilde{\mathcal{J}}_{\mathfrak{j}} \lesssim\|u\|_{X_{T}^{s}}^{2}\|v\|_{X_{T}^{s}}^{2} \quad(j=0,1,2) .
$$

These can be proved following the argument of the preceding subsection by using the fact that

$$
\mathrm{C}\left(\lambda_{0}, \lambda_{1}, \lambda_{2}\right) \lesssim \min \left(\left\langle\lambda_{1}\right\rangle,\left\langle\lambda_{2}\right\rangle\right)^{\frac{d}{2}-\frac{1}{2}-\frac{1}{2 q}}
$$

for all $\lambda_{0}, \lambda_{1}, \lambda_{2} \in \Lambda$.

## 6. Appendix

In this appendix, we derive some useful estimates on the derivatives of all order for the function

$$
m_{\beta}(r)=\sqrt{r\left(1+\beta r^{2}\right) \tanh (r)}, \quad \beta \in\{0,1\}
$$

Estimates for the first and second order derivatives of this function is derived recently in [11].

Clearly,

$$
\begin{equation*}
m_{\beta}(r) \sim r\langle\sqrt{\beta} r\rangle\langle r\rangle^{-1 / 2} \tag{6.1}
\end{equation*}
$$

Lemma 5. Let $\beta \in\{0,1\}$ and $r>0$. Then

$$
\begin{align*}
m_{\beta}^{\prime}(r) & \sim\langle\sqrt{\beta} r\rangle\langle r\rangle^{-1 / 2}  \tag{6.2}\\
\left|m_{\beta}^{\prime \prime}(r)\right| & \sim r\langle\sqrt{\beta} r\rangle\langle r\rangle^{-5 / 2} . \tag{6.3}
\end{align*}
$$

Moreover,

$$
\begin{equation*}
\left|m_{\beta}^{(k)}(r)\right| \underset{k}{\lesssim} r^{1-k}\langle\sqrt{\beta} r\rangle\langle r\rangle^{-1 / 2} \quad(k \geqslant 3) . \tag{6.4}
\end{equation*}
$$

Proof. The estimates (6.2) and (6.3) are proved in [11, Lemma 3.2, see its proof in Section 5]. So we only prove (6.4).

Let

$$
\mathrm{T}(\mathrm{r})=\tanh \mathrm{r}, \quad \mathrm{~S}(\mathrm{r})=\operatorname{sech} \mathrm{r}
$$

Then

$$
\mathrm{T}^{\prime}=\mathrm{S}^{2}, \quad \mathrm{~S}^{\prime}=-\mathrm{TS}, \quad \mathrm{~T}^{\prime \prime}=-2 \mathrm{TS}^{2}
$$

In general, we have

$$
\mathrm{T}^{(j)}(\mathrm{r})=\mathrm{S}^{2} \cdot \mathrm{P}_{\mathrm{j}-1}(\mathrm{~S}, \mathrm{~T}) \quad(\mathrm{j} \geqslant 1)
$$

for some polynomial $P_{j-1}$ of degree $j-1$.
Clearly,

$$
T(r) \sim r\langle r\rangle^{-1} \quad \text { and } \quad S(r) \sim e^{-r} .
$$

So $\left|P_{j-1}(S, T)\right| \lesssim 1$, and hence

$$
\begin{equation*}
\left|T^{(j)}(r)\right| \lesssim e^{-2 r} \quad(j \geqslant 1) \tag{6.5}
\end{equation*}
$$

Write

$$
m_{\beta}(r)=f_{\beta}(r) \cdot T_{0}(r),
$$

where $f_{\beta}(r)=\sqrt{r}\langle\sqrt{\beta} r\rangle$ and $T_{0}(r)=\sqrt{T(r)}$. One can show that

$$
\begin{equation*}
\left|f_{\beta}^{(j)}(r)\right| \lesssim r^{\frac{1}{2}-j}\langle\sqrt{\beta} r\rangle \quad(j \geqslant 0) \tag{6.6}
\end{equation*}
$$

Combining (6.5) with $\mathrm{T}(\mathrm{r}) \sim \mathrm{r}\langle\mathrm{r}\rangle^{-1}$ we obtain

$$
\begin{equation*}
T_{0}(r) \sim r^{\frac{1}{2}}\langle r\rangle^{-\frac{1}{2}}, \quad\left|T_{0}^{(j)}(r)\right| \lesssim r^{\frac{1}{2}-j}\langle r\rangle^{j-\frac{1}{2}} e^{-2 r} \quad(j \geqslant 1) \tag{6.7}
\end{equation*}
$$

Finally, we use (6.6) and (6.7) to obtain for all $k \geqslant 3$,

$$
\begin{aligned}
\left|m_{\beta}^{(k)}(r)\right| & =\left|f_{\beta}^{(k)}(r) T_{0}(r)+\sum_{j=1}^{k}\binom{k}{j} f_{\beta}^{(k-j)}(r) T_{0}^{(j)}(r)\right| \\
& \lesssim r^{1-k}\langle\sqrt{\beta} r\rangle\langle r\rangle^{-\frac{1}{2}}+\sum_{j=1}^{k}\binom{k}{j} r^{\frac{1}{2}-(k-j)}\langle\sqrt{\beta} r\rangle \cdot r^{\frac{1}{2}-j}\langle r\rangle^{j-\frac{1}{2}} e^{-2 r} \\
& \lesssim r^{1-k}\langle\sqrt{\beta} r\rangle\langle r\rangle^{-\frac{1}{2}}
\end{aligned}
$$

Corollary 2. For $\lambda, r>0$, define $m_{\beta, \lambda}(r)=m_{\beta}(\lambda r)$. Then

$$
\begin{equation*}
\max _{r \sim 1}\left|\partial_{r}^{k}\left(\frac{1}{m_{\beta, \lambda}^{\prime}(r)}\right)\right| \underset{k}{\lesssim} \lambda^{-1}\langle\sqrt{\beta} \lambda\rangle^{-1}\langle\lambda\rangle^{\frac{1}{2}} \quad(k \geqslant 0) . \tag{6.8}
\end{equation*}
$$

Proof. Observe that

$$
m_{\beta, \lambda}^{(k)}(r)=\lambda^{k} m_{\beta}^{(k)}(\lambda r) \quad(k \geqslant 1)
$$

By (6.2) we have, for $r \sim 1$,

$$
\left|m_{\beta, \lambda}^{\prime}(r)\right| \sim \lambda\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-\frac{1}{2}}
$$

and by (6.3)- (6.4)

$$
\left|m_{\beta, \lambda}^{(k)}(r)\right| \underset{\mathrm{k}}{\lesssim} \lambda\langle\sqrt{\beta} \lambda\rangle\langle\lambda\rangle^{-\frac{1}{2}} \quad(\mathrm{k} \geqslant 2)
$$

Finally, one can combine these two estimates with the differentiation formula

$$
\partial_{r}^{k}\left(\frac{1}{f}\right)=\sum_{p=1}^{k} \sum_{\substack{k_{1}, \cdots, k_{p} \in \mathbb{N} \\ k_{1}+\cdots+k_{p}=k}} c_{p, k_{1}, \cdots, k_{p}} \frac{\partial_{r}^{k_{1}} f \cdots \partial_{r}^{k_{p}} f}{f^{p+1}}
$$

to obtain the desired estimate (6.8).
