DISPERSIVE ESTIMATES FOR LINEARIZED WATER WAVE TYPE EQUATIONS IN $\mathbb{R}^{\rm d}$

Abstract. We derive a $L^1_x(\mathbb{R}^d)-L^\infty_x(\mathbb{R}^d)$ decay estimate of order $\mathfrak{O}\left(t^{-d/2}\right)$ for the linear propagators

$$\exp\left(\pm it\sqrt{|D|\left(1+\beta|D|^2\right)\tanh|D|}\right), \qquad \beta \in \{0,1\}. \quad D=-i\nabla,$$

with a loss of 3d/4 or d/4 – derivatives in the case $\beta=0$ or $\beta=1$, respectively. These linear propagators are known to be associated with the linearized water wave equations, where the parameter β measures surface tension effects. As an application we prove low regularity well-posedness for a Whitham–Boussinesq type system in \mathbb{R}^d , $d\geqslant 2$. This generalizes a recent result by Dinvay, Selberg and the third author where they proved low regularity well-posedness in \mathbb{R} and \mathbb{R}^2 .

1. Introduction

In this paper, we derive a $L^1_x(\mathbb{R}^d)-L^\infty_x(\mathbb{R}^d)$ time-decay estimate for the linear propagators

$$S_{\mathfrak{m}_{\beta}}(\pm t) := \exp(\mp i t \mathfrak{m}_{\beta}(D)),$$

where

$$\mathfrak{m}_{\beta}(D) = \sqrt{|D|(1+\beta|D|^2)\tanh|D|}$$

with $\beta \in \{0,1\}$ and $D=-i\nabla$. The pseudo-differential operator $\mathfrak{m}_{\beta}(D)$ appears in linearized water wave type equations. The cases $\beta=0$ and $\beta=1$ correspond respectively to purely gravity waves and capillary-gravity waves.

For instance, consider the Whitham equation without or with surface tension (see e.g., [9, 12])

$$u_t + L_\beta u_x + u u_x = 0, \qquad (\beta \geqslant 0), \tag{1.1}$$

where $u: \mathbb{R} \times \mathbb{R} \to \mathbb{R}$, and the non-local operator L_{β} is related to the dispersion relation of the (linearized) water waves system and is defined by

$$L_{\beta} := L_{\beta}(D) = \sqrt{(1+\beta|D|^2)\,K(D)}$$

with

$$K(D) = \frac{tanh \, |D|}{|D|} \qquad (D = -i \nabla = -i \vartheta_x).$$

The linear part of (1.1) can be written as

$$iu_t - \widetilde{\mathfrak{m}}_{\beta}(D)u = 0,$$
 (1.2)

where

$$\widetilde{\mathfrak{m}}_{\beta}(D) = DL_{\beta}(D) = \frac{D}{|D|} \mathfrak{m}_{\beta}(D).$$

In terms of Fourier symbols we have $\widetilde{\mathfrak{m}}_{\beta}(\xi) = sgn(\xi)\mathfrak{m}_{\beta}(\xi)$. So the solution propagator for (1.2) is given by $\mathfrak{S}_{\widetilde{\mathfrak{m}}_{\beta}}(t) = exp\left(-it\widetilde{\mathfrak{m}}_{\beta}(D)\right)$. In fact, both $\mathfrak{S}_{\widetilde{\mathfrak{m}}_{\beta}}(t)$ and $\mathfrak{S}_{\mathfrak{m}_{\beta}}(t)$ satisfy the same $L^1_x(\mathbb{R}) - L^\infty_x(\mathbb{R})$ time-decay estimate.

As another example, consider the full dispersion Boussinesq system (see e.g., [8, 10])

$$\begin{cases}
\eta_{t} + L_{\beta}^{2} \nabla \cdot \mathbf{v} + \nabla \cdot (\eta \mathbf{v}) = 0 \\
\mathbf{v}_{t} + \nabla \eta + \nabla |\mathbf{v}|^{2} = 0,
\end{cases}$$
(1.3)

where

$$\eta: \mathbb{R} \times \mathbb{R} \to \mathbb{R}, \qquad \mathbf{v}: \mathbb{R}^d \times \mathbb{R} \to \mathbb{R}^d.$$

This system describes the evolution with time of surface waves of a liquid layer, where η and v denote the surface elevation and the fluid velocity, respectively. One can derive an equivalent system of (1.3), by diagonalizing its linear part. Indeed, define

$$w_{\pm} = \frac{\eta \mp i L_{\beta} \mathcal{R} \cdot \mathbf{v}}{2L_{\beta}},$$

where (η, \mathbf{v}) is a solution to (1.3), and $\mathcal{R} = |D|^{-1}\nabla$ is the Riesz transform. Then the linear part of the system (1.3) transforms to

$$i\partial_{t}w_{\pm} \mp m_{\beta}(D)w_{\pm} = 0 \tag{1.4}$$

whose corresponding solution propagators are $\mathcal{S}_{m_{\beta}}(\pm t) = \exp(\mp i t m_{\beta}(D))$.

As a third example, consider the Whitham–Boussinesq type system (see e.g., [1, 2, 3, 4])

$$\begin{cases} \partial_{t} \eta + \nabla \cdot \mathbf{v} = -K \nabla \cdot (\eta \mathbf{v}), \\ \partial_{t} \mathbf{v} + L_{\beta}^{2} \nabla \eta = -K \nabla (|\mathbf{v}|^{2}/2). \end{cases}$$
 (1.5)

Again, by defining the new variables

$$u_{\pm} = \frac{L_{\beta} \eta \mp i \mathcal{R} \cdot \mathbf{v}}{2L_{\beta}},\tag{1.6}$$

we see that the linear part of (1.5) transforms to

$$i\partial_t u_{\pm} \mp m_{\beta}(D)u_{\pm} = 0 \tag{1.7}$$

whose solution propagators are again $S_{\mathfrak{m}_{\beta}}(\pm t) = \exp(\mp i t \mathfrak{m}_{\beta}(D))$.

So the linear propagators $\delta_{m_{\beta}}(\pm t)$ appear in all of the equations (1.1), (1.3) and (1.5). Since the symbol m_{β} is non-homogeneous, we will derive a time-decay estimate from

$$\mathbb{S}_{\mathfrak{m}_{\beta}}(\pm t): L^{1}_{x}(\mathbb{R}^{d}) \rightarrow L^{\infty}_{x}(\mathbb{R}^{d})$$

for frequency localised functions. To this end, we fix a smooth cutoff function $\boldsymbol{\chi}$ such that

$$\chi \in C_0^\infty(\mathbb{R}), \quad 0 \leqslant \chi \leqslant 1, \quad \chi_{|_{[-1,1]}} = 1 \quad \text{and} \quad supp(\chi) \subset [-2,2].$$

Set

$$\rho(s) = \chi(s) - \chi(2s).$$

Thus, supp $\rho = \{s \in \mathbb{R} : 1/2 \le |s| \le 2\}$. For $\lambda \in 2^{\mathbb{Z}}$ we set $\rho_{\lambda}(s) := \rho(s/\lambda)$ and define the frequency projection P_{λ} by

$$\widehat{P_{\lambda}f}(\xi) = \rho_{\lambda}(|\xi|)\widehat{f}(\xi).$$

Sometimes, we write $f_{\lambda} := P_{\lambda}f$.

Notation. For any positive numbers a and b, the notation $a \lesssim b$ stands for $a \leqslant cb$, where c is a positive constant that may change from line to line. Moreover, we denote $a \sim b$ when $a \lesssim b$ and $b \lesssim a$. We also set $\langle x \rangle := \left(1 + |x|^2\right)^{1/2}$.

For $1\leqslant p\leqslant \infty$, $L^p_x(\mathbb{R}^d)$ denotes the usual Lebesgue space and for $s\in \mathbb{R}$, $H^s(\mathbb{R}^d)$ is the L^2 -based Sobolev space with norm $\|f\|_{H^s}=\|\langle D\rangle^s f\|_{L^2}$. If T>0 and $1\leqslant q\leqslant \infty$, we define the spaces $L^q\left((0,T):L^r(\mathbb{R}^d)\right)$ and $L^q\left(\mathbb{R}:L^r(\mathbb{R}^d)\right)$ respectively through the norms

$$\|f\|_{L^q_T L^r_x} = \left(\int_0^T \|f(\cdot,t)\|_{L^r_x}^q dt \right)^{\frac{1}{q}} \quad \text{and} \quad \|f\|_{L^q_t L^r_x} = \left(\int_{\mathbb{R}} \|f(\cdot,t)\|_{L^r_x}^p dt \right)^{\frac{1}{q}},$$

when $1 \le q < \infty$, with the usual modifications when $q = +\infty$.

Our first result is as follows:

Theorem 1 (Localised dispersive estimate). *Let* $\beta \in \{0,1\}$, $d \ge 1$ *and* $\lambda \in 2^{\mathbb{Z}}$. *Then*

$$\|\mathcal{S}_{\mathfrak{m}_{\beta}}(\pm t)f_{\lambda}\|_{L_{x}^{\infty}(\mathbb{R}^{d})} \lesssim c_{\beta,d}(\lambda) |t|^{-\frac{d}{2}} \|f\|_{L_{x}^{1}(\mathbb{R}^{d})}$$

$$\tag{1.8}$$

for all $f \in S(\mathbb{R}^d)$, where

$$c_{\beta,d}(\lambda) = \lambda^{\frac{d}{2} - 1} \langle \sqrt{\beta \lambda} \rangle^{-\frac{d}{2}} \langle \lambda \rangle^{\frac{d}{4} + 1}. \tag{1.9}$$

Remark 1. In view of (1.9) the loss of derivatives (this corresponds to the exponent of λ) is 3d/4 in the case $\beta = 0$, whereas the loss is d/4 when $\beta = 1$.

Once Theorem 1 is proved, the corresponding Strichartz estimates are deduced from a classical TT* argument.

Theorem 2 (Localised Strichartz estimate). Let $\beta \in \{0,1\}$, $d \geqslant 1$ and $\lambda \in 2^{\mathbb{Z}}$. Assume that the pair (q,r) satisfies the following conditions:

$$2 < q \leqslant \infty, \quad 2 \leqslant r \leqslant \infty, \qquad \frac{2}{q} + \frac{d}{r} = \frac{d}{2}.$$
 (1.10)

Then

$$\left\| \mathcal{S}_{\mathfrak{m}_{\beta}}(\pm t) f_{\lambda} \right\|_{L_{t}^{q} L_{x}^{r}(\mathbb{R}^{d+1})} \lesssim \left[c_{\beta,d}(\lambda) \right]^{\frac{2}{qd}} \| f_{\lambda} \|_{L_{x}^{2}(\mathbb{R}^{d})}, \quad (1.11)$$

$$\left\|\int_0^t \mathcal{S}_{\mathfrak{m}_{\beta}}(\pm(t-s))\mathsf{F}_{\lambda}(s)\,ds\right\|_{L_t^qL_x^r(\mathbb{R}^{d+1})} \lesssim \left[c_{\beta,d}(\lambda)\right]^{\frac{2}{qd}}\left\|\mathsf{F}_{\lambda}\right\|_{L_t^1L_x^2(\mathbb{R}^{d+1})} \tag{1.12}$$

for all $f \in S(\mathbb{R}^d)$ and $F \in S(\mathbb{R}^{d+1})$, where $c_{\beta,d}(\lambda)$ is as in (1.9).

As an application of Theorem 2 we prove low regularity well-posedness for the system (1.5) with $\beta=0$ (i.e., for purely gravity waves) in \mathbb{R}^d , $d\geqslant 2$. To this end, we complement the system (1.5) with initial data

$$\eta(0) = \eta_0 \in \mathsf{H}^s(\mathbb{R}^d), \qquad \mathbf{v}(0) = \mathbf{v}_0 \in \left(\mathsf{H}^{s+1/2}\left(\mathbb{R}^d\right)\right)^d.$$
(1.13)

Theorem 3. Let $\beta = 0$, $d \ge 2$ and $s > \frac{d}{2} - \frac{3}{4}$. Suppose that \mathbf{v}_0 is a curl-free vector field, i.e., $\nabla \times \mathbf{v}_0 = 0$, and

$$\left[\left\|\eta_0\right\|_{H^s(\mathbb{R}^d)}+\left\|\textbf{v}_0\right\|_{(H^{s+1/2}(\mathbb{R}^d))}\right]\leqslant \mathfrak{D}_0.$$

Then there exists a solution

$$(\eta, \boldsymbol{v}) \in C\left([0, T]; H^s(\mathbb{R}^d) \times \left(H^{s+1/2}\left(\mathbb{R}^d\right)\right)^d\right)$$

of the Cauchy problem (1.5), (1.13), with existence time 1 T $\sim \mathcal{D}_{0}^{-2-}$.

Moreover, the solution is unique in some subspace of the above solution space and the solution depends continuously on the initial data.

Remark 2. The following are known results:

- (i) Theorem 1 and Theorem 2 are proved in [5] when $\beta=0,$ d $\in\{1,2\}$ and $\lambda\geq 1.$
- (ii) Theorem 3 is proved in [5] when d = 2. In the case d = 1 local well-posedness for s > -1/10 and global well-posedness for small initial data in $L^2(\mathbb{R})$ is also established in [5]. Long-time existence of solution in the case d = 2 is also obtained in [14].

Van der Corput's Lemma will be useful in the proof of Theorem 1.

Lemma 1 (Van der Corput's Lemma, [13]). *Assume* $g \in C^1(\mathfrak{a},\mathfrak{b}), \psi \in C^2(\mathfrak{a},\mathfrak{b})$ *and* $|\psi''(r)| \geqslant A$ *for all* $r \in (\mathfrak{a},\mathfrak{b})$. *Then*

$$\left| \int_{a}^{b} e^{it\psi(r)} g(r) dr \right| \leq C(At)^{-1/2} \left[|g(b)| + \int_{a}^{b} |g'(r)| dr \right], \tag{1.14}$$

for some constant C > 0 that is independent of a, b and t.

Lemma 1 holds even if $\psi'(r)=0$ for some $r\in(a,b)$. However, if $|\psi'(r)|>0$ for all $r\in(a,b)$, one can use integration by parts to obtain the following Lemma. The proof may be found elsewhere but we include it here for the reader's convenience.

Lemma 2. Suppose that $g \in C_0^\infty(\mathfrak{a},\mathfrak{b})$ and $\psi \in C^\infty(\mathfrak{a},\mathfrak{b})$ with $|\psi'(r)| > 0$ for all $r \in (\mathfrak{a},\mathfrak{b})$. If

$$\max_{\alpha \leqslant r \leqslant b} |\partial_r^j g(r)| \leqslant A, \qquad \max_{\alpha \leqslant r \leqslant b} \left| \partial_r^j \left(\frac{1}{\psi'(r)} \right) \right| \leqslant B \tag{1.15}$$

for all $0 \le j \le N \in \mathbb{N}_0$, then

$$\left| \int_{a}^{b} e^{it\psi(r)} g(r) dr \right| \lesssim AB^{N} |t|^{-N}. \tag{1.16}$$

Proof. Let

$$I(t) = \int_{a}^{b} e^{it\psi(r)} g(r) dr.$$

For $m, N \in \mathbb{N}_0$, define

$$S_{m,N} := \{ (k_1, \cdots, k_N) \in \mathbb{N}_0 : \ k_1 < \cdots < k_N \leqslant N \ \& \ k_1 + \cdots + k_N = m \}.$$

¹Here we used the notation $a \pm := a \pm \epsilon$ for sufficiently small $\epsilon > 0$.

Integration by parts yields

$$\begin{split} I(t) &= I_1(t) = -it^{-1} \int_a^b \vartheta_r \left(e^{it\psi(r)} \right) \frac{1}{\psi'(r)} g(r) \, dr \\ &= (-it)^{-1} \int_a^b e^{it\psi(r)} \left\{ \frac{1}{\psi'(r)} g'(r) + \vartheta_r \left(\frac{1}{\psi'(r)} \right) g(r) \right\} \, dr. \end{split}$$

Repeating the integration by parts N-times we get

$$I(t) = I_{N}(t) = (-it)^{-N} \sum_{m=0}^{N} \sum_{(k_{1}, \dots, k_{N}) \in S_{m,N}} C_{k,m,N} \int_{a}^{b} e^{it\psi(r)} E_{k,m,N}(r) dr,$$

where $C_{k,m,N}$ are constants and

$$E_{k,m,N}(r) = \Pi_{j=1}^N \vartheta_r^{k_j} \left(\frac{1}{\psi'(r)}\right) \cdot g^{(N-m)}(r).$$

Applying (1.15) we obtain

$$|E_{k,m,N}| \leqslant \left(\Pi_{j=1}^N B\right) A = AB^N$$

and hence

$$|I(t)| = |I_N(t)| \lesssim AB^N |t|^{-N}$$

as desired.

2. Proof of Theorem 1

Without loss of generality we may assume $\pm = -$ and t > 0. Now we can write

$$\left[\mathcal{S}_{\mathfrak{m}_{\beta}}(-t)f_{\lambda}\right] (x) = (I_{\lambda}(\cdot,t)*f)(x),$$

where

$$I_{\lambda}(x,t) = \lambda^{d} \int_{\mathbb{R}^{d}} e^{i\lambda x \cdot \xi + it \, m_{\beta}(\lambda \xi)} \rho(|\xi|) \, d\xi. \tag{2.1}$$

By Young's inequality

$$\|\mathfrak{S}_{\mathfrak{m}_{\beta}}(-t)f_{\lambda}\|_{L_{\infty}^{\infty}(\mathbb{R}^{d})} \leqslant \|I_{\lambda(\cdot,t)}\|_{L_{\infty}^{\infty}(\mathbb{R}^{d})}\|f\|_{L_{\omega}^{1}(\mathbb{R}^{d})},\tag{2.2}$$

and therefore, (1.8) reduces to proving

$$\|I_{\lambda}(\cdot,t)\|_{L_{\infty}^{\infty}(\mathbb{R}^{d})} \lesssim c_{\beta,d}(\lambda)t^{-\frac{d}{2}}.$$
 (2.3)

Observe that

$$t \lesssim \lambda^{-1/2} \langle \sqrt{\beta} \lambda \rangle^{-1} \quad \Rightarrow \quad c_{\beta,d}(\lambda) t^{-\frac{d}{2}} \gtrsim \lambda^d$$

in which case (2.3) follows from the simple estimate

$$\|I_{\lambda}(\cdot,t)\|_{L_{x}^{\infty}(\mathbb{R}^{d})} \lesssim \lambda^{d}.$$

We may therefore assume from now on

$$t \gg \lambda^{-1/2} \langle \sqrt{\beta} \lambda \rangle^{-1}. \tag{2.4}$$

2.1. **Proof of** (2.3) **when** d = 1. In the case d = 1 we have

$$I_{\lambda}(x,t) = \lambda \int_{\mathbb{R}} e^{it\phi_{\lambda}(\xi)} \rho(|\xi|) d\xi,$$

where

$$\phi_{\lambda}(\xi) := \lambda \xi x/t + m_{\beta}(\lambda \xi).$$

We want to prove

$$\|I_{\lambda}(\cdot,t)\|_{L_{x}^{\infty}(\mathbb{R})} \lesssim \underbrace{\lambda^{-\frac{1}{2}} \langle \sqrt{\beta} \lambda \rangle^{-\frac{1}{2}} \langle \lambda \rangle^{\frac{5}{4}}}_{=c_{\beta,1}} t^{-\frac{1}{2}}$$
(2.5)

under condition (2.4).

Since supp $\rho = \{\xi \in \mathbb{R} : 1/2 \le |\xi| \le 2\}$, we can write

$$I_{\lambda}(x,t) = \underbrace{\lambda \int_{1/2}^2 e^{it\varphi_{\lambda}(\xi)} \rho(\xi) \, d\xi}_{:=I_{\lambda}^+(x,t)} + \underbrace{\lambda \int_{1/2}^2 e^{it\varphi_{\lambda}(-\xi)} \rho(\xi) \, d\xi}_{:=I_{\lambda}^-(x,t)}.$$

We estimate only $I_{\lambda}^+(x,t)$ as the estimate for $I_{\lambda}^-(x,t)$ can be derived in exactly the same way. Since

$$\phi_{\lambda}'(\xi) = \lambda \left[x/t + m_{\beta}'(\lambda \xi) \right], \qquad \phi_{\lambda}''(\xi) = \lambda^2 m_{\beta}''(\lambda \xi) \tag{2.6}$$

it follows from Lemma 5 that

$$|\varphi_{\lambda}''(\xi)| \sim \lambda^3 \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-5/2} \quad \text{for all } \xi \in [1/2,2]. \tag{2.7}$$

Now we prove (2.5) by dividing the region of integration into sets of non-stationary contribution: $\{\xi: \varphi_{\lambda}'(\xi) \neq 0\}$ and stationary contribution: $\{\xi: \varphi_{\lambda}'(\xi) = 0\}$.

2.1.1. Non-stationary contribution. Since \mathfrak{m}'_{β} is positive, the non-stationary contribution occurs if either

$$x\geqslant 0\quad\text{or}\quad 0<-x\ll \langle\sqrt{\beta}\lambda\rangle\langle\lambda\rangle^{-\frac{1}{2}}t\quad\text{or}\ -x\gg \langle\sqrt{\beta}\lambda\rangle\langle\lambda\rangle^{-\frac{1}{2}}t$$

In this case we have

$$|\phi_{\lambda}'(\xi)| \gtrsim \lambda \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-\frac{1}{2}}$$
 for all $\xi \in [1/2, 2]$,

where Lemma 5 is also used. Combining this estimate with (2.7) we get

$$\max_{1/2\leqslant\xi\leqslant 1} \left| \vartheta_\xi \left(\frac{1}{\varphi_\lambda'(\xi)} \right) \right| \lesssim \lambda \langle \sqrt{\beta} \lambda \rangle^{-1} \langle \lambda \rangle^{-\frac{3}{2}}.$$

Now this estimate can be combined with Lemma 2 for N=1 to estimate $I_{\lambda}(x,t)$ as

$$|I_{\lambda}^{+}(x,t)| \lesssim \lambda \cdot \lambda \langle \sqrt{\beta} \lambda \rangle^{-1} \langle \lambda \rangle^{-\frac{3}{2}} t^{-1}$$

$$\lesssim \lambda^{-\frac{1}{2}} \langle \sqrt{\beta} \lambda \rangle^{-\frac{1}{2}} \langle \lambda \rangle^{\frac{5}{4}} t^{-\frac{1}{2}}$$
(2.8)

where to get the second line we used (2.4).

2.1.2. Stationary contribution. This occurs if

$$0<-x \sim \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-\frac{1}{2}} t.$$

In this case we use Lemma 1 and (2.7) to obtain

$$|I_{\lambda}^{+}(x,t)| \lesssim \lambda \cdot \left(\lambda^{3} \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-5/2} t\right)^{-\frac{1}{2}} \left[|\rho(2)| + \int_{1/2}^{2} |\rho'(\xi)| \, d\xi \right]$$

$$\lesssim \lambda^{-\frac{1}{2}} \langle \sqrt{\beta} \lambda \rangle^{-\frac{1}{2}} \langle \lambda \rangle^{\frac{5}{4}} t^{-\frac{1}{2}}.$$
(2.9)

2.2. **Proof of** (2.3) **when** $d \ge 2$. To prove (2.3) first observe that $I_{\lambda}(x,t)$ is radially symmetric w.r.t x, as it is the inverse Fourier transform of the radial function $e^{itm_{\beta}(\lambda\xi)}\rho(\xi)$. So we can write (see [6, B.5])

$$I_{\lambda}(x,t) = \lambda^{d} \int_{1/2}^{2} e^{itm_{\beta}(\lambda r)} (\lambda r|x|)^{-\frac{d-2}{2}} J_{\frac{d-2}{2}}(\lambda r|x|) r^{d-1} \rho(r) dr, \qquad (2.10)$$

where $J_{\alpha}(r)$ is the Bessel function:

$$J_{\alpha}(r) = \frac{(r/2)^{\alpha}}{\Gamma(\alpha+1/2)\sqrt{\pi}} \int_{-1}^{1} e^{\mathrm{i} r s} \left(1-s^2\right)^{\alpha-1/2} \, \mathrm{d}s \quad \text{for } \alpha > -1/2.$$

The Bessel function $J_{\alpha}(r)$ satisfies the following properties for $\alpha > -1/2$ and r > 0 (See [6, Appendix B] and [13]):

$$J_{\alpha}(r) \leqslant Cr^{\alpha}, \tag{2.11}$$

$$J_{\alpha}(r) \leqslant Cr^{-1/2},\tag{2.12}$$

$$\partial_{r} \left[r^{-\alpha} J_{\alpha}(r) \right] = -r^{-\alpha} J_{\alpha+1}(r) \tag{2.13}$$

Moreover, it is known that (see [7, Chapter 1, Eq. (1.5)]),

$$r^{-\frac{d-2}{2}}J_{\frac{d-2}{2}}(s) = e^{is}h(s) + e^{-is}\bar{h}(s)$$
 (2.14)

for some function h satisfying the decay estimate

$$|\partial_r^k h(r)| \leqslant C_k \langle r \rangle^{-\frac{d-1}{2}-k} \qquad (k \geqslant 0). \tag{2.15}$$

We use the short hand

$$m_{\beta,\lambda}(r)=m_{\beta}(\lambda r), \qquad \tilde{J}_{\alpha}(r)=r^{-\alpha}J_{\alpha}(r), \qquad \tilde{\rho}(r)=r^{d-1}\rho(r).$$

Hence

$$I_{\lambda}(x,t) = \lambda^{d} \int_{1/2}^{2} e^{it \, m_{\beta,\lambda}(r)} \tilde{J}_{\frac{d-2}{2}}(\lambda r|x|) \tilde{\rho}(r) \, dr, \tag{2.16}$$

We prove (2.3) by treating the cases $|x| \lesssim \lambda^{-1}$ and $|x| \gg \lambda^{-1}$ separately.

2.2.1. Case 1: $|x| \lesssim \lambda^{-1}$. By (2.11) and (2.13) we have for all $r \in (1/2,2)$ the estimate

$$\left| \partial_{r}^{k} \left[\tilde{J}_{\frac{d-2}{2}}(\lambda r|x|)\tilde{\rho}(r) \right] \right| \lesssim 1 \qquad (k \geqslant 0). \tag{2.17}$$

From Corollary 2 we have

$$\max_{1/2 \leqslant r \leqslant 1} \left| \vartheta_r^k \left(\frac{1}{\mathfrak{m}_{\beta,\lambda}'(r)} \right) \right| \lesssim \lambda^{-1} \langle \sqrt{\beta} \lambda \rangle^{-1} \langle \lambda \rangle^{\frac{1}{2}} \qquad (k \geqslant 0). \tag{2.18}$$

Applying Lemma 2 with (2.17)-(2.18) and N = d/2 to (2.16) we obtain

$$|I_{\lambda}(x,t)| \lesssim \lambda^{d} \cdot \left(\lambda^{-1} \langle \sqrt{\beta} \lambda \rangle^{-1} \langle \lambda \rangle^{\frac{1}{2}}\right)^{d/2} t^{-d/2}$$

$$\lesssim c_{\beta,d}(\lambda) t^{-\frac{d}{2}},$$
(2.19)

where to get the second line we used (2.4).

2.2.2. Case 2: $|x| \gg \lambda^{-1}$. Using (2.14) in (2.16) we write

$$I_{\lambda}(x,t) = \lambda^d \left[\int_{1/2}^2 e^{it\varphi_{\lambda}^+(r)} h(\lambda r|x|) \tilde{\rho}(r) dr + \int_{1/2}^2 e^{-it\varphi_{\lambda}^-(r)} \bar{h}(\lambda r|x|) \tilde{\rho}(r) dr \right],$$

where

$$\varphi_{\lambda}^{\pm}(r) = \lambda r |x|/t \pm m_{\beta,\lambda}(r).$$

Set $H_{\lambda}(|x|,r) := h(\lambda r|x|)\tilde{\rho}(r)$. In view of (2.15) we have

$$\max_{1/2\leqslant r\leqslant 2}\left|\vartheta_r^kH_\lambda(|x|,r)\right|\lesssim (\lambda|x|)^{-\frac{d-1}{2}}\qquad (k\geqslant 0), \tag{2.20}$$

where we also used the fact $\lambda |x| \gg 1$.

Now we write

$$I_{\lambda}(x,t) = I_{\lambda}^{+}(x,t) + I_{\lambda}^{-}(x,t),$$

where

$$\begin{split} I_{\lambda}^{+}(x,t) &= \lambda^{d} \int_{1/2}^{2} e^{it\varphi_{\lambda}^{+}(r)} H_{\lambda}(|x|,r) \, dr, \\ I_{\lambda}^{-}(x,t) &= \lambda^{d} \int_{1/2}^{2} e^{-it\varphi_{\lambda}^{-}(r)} \bar{H}_{\lambda}(|x|,r) \, dr. \end{split}$$

Observe that

$$\label{eq:delta_phi} \vartheta_r \varphi_\lambda^\pm(r) = \lambda \left[|x|/t \pm m_\beta'(\lambda r) \right], \qquad \vartheta_r^2 \varphi_\lambda^\pm(r) = \pm \lambda^2 m_\beta''(\lambda r),$$

and hence by Lemma 5,

$$|\partial_r \varphi_\lambda^+(r)| \gtrsim \lambda \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-1/2}, \qquad |\partial_r^2 \varphi_\lambda^\pm(r)| \sim \lambda^3 \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-5/2} \tag{2.21}$$

for all $r\in(1/2,2),$ where we also used the fact that \mathfrak{m}_{β}' is positive.

Estimate for $I_{\lambda}^{+}(x,t)$. Following as in the proof of Corollary 2, we have

$$\max_{1/2\leqslant r\leqslant 2} \left| \vartheta_r^k \left(\left[\vartheta_r \varphi_\lambda^+(r) \right]^{-1} \right) \right| \lesssim \lambda^{-1} \langle \sqrt{\beta} \lambda \rangle^{-1} \langle \lambda \rangle^{\frac{1}{2}} \qquad (k\geqslant 0). \tag{2.22}$$

Applying Lemma 2 with (2.20), (2.22) and N = d/2 to $I_{\lambda}^{+}(x,t)$ we obtain

$$\begin{split} |I_{\lambda}^{+}(x,t)| &\lesssim \lambda^{d} \cdot (\lambda|x|)^{-\frac{d-1}{2}} \cdot \left(\lambda^{-1} \langle \sqrt{\beta} \lambda \rangle^{-1} \langle \lambda \rangle^{\frac{1}{2}}\right)^{d/2} t^{-d/2} \\ &\lesssim c_{\beta,d}(\lambda) t^{-\frac{d}{2}}, \end{split} \tag{2.23}$$

where to get the second line we used the fact that $\lambda |x| \gg 1$, and the condition in (2.4).

Estimate for $I_{\lambda}^{-}(x,t)$. We treat the non-stationary and stationary cases separately. In the non-stationary case, where

$$|x| \ll \langle \beta \lambda \rangle \langle \lambda \rangle^{-1/2} t$$
 or $|x| \gg \langle \beta \lambda \rangle \langle \lambda \rangle^{-1/2} t$,

we have

$$|\vartheta_r \varphi_\lambda^-(r)| \gtrsim \lambda \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-1/2} \text{,}$$

and hence $I_{\lambda}^{-}(x,t)$ can be estimated in exactly the same way as $I_{\lambda}^{+}(x,t)$ above, and satisfies the same bound as in (2.23).

So it remains to treat the stationary case:

$$|x| \sim \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-1/2} t.$$

In this case, we use Lemma 1, (2.21) and(2.20) to obtain

$$\begin{split} |I_{\lambda}^{-}(x,t) &\lesssim \lambda^{d} \cdot \left(\lambda^{3} \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-5/2} t\right)^{-\frac{1}{2}} \left[|H_{\lambda}^{-}(x,2)| + \int_{1/2}^{2} |\partial_{\tau} H_{\lambda}^{-}(x,r)| \, dr \right] \\ &\lesssim \lambda^{d-\frac{3}{2}} \langle \sqrt{\beta} \lambda \rangle^{-\frac{1}{2}} \langle \lambda \rangle^{\frac{5}{4}} t^{-\frac{1}{2}} \cdot (\lambda |x|)^{-\frac{d-1}{2}} \\ &\lesssim c_{\beta,d}(\lambda) t^{-\frac{d}{2}}, \end{split} \tag{2.24}$$

where we also used the fact that $H_{\lambda}^{-}(x,2) = 0$ and $|x| \sim \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-1/2} t$.

3. Proof of Theorem 2

We shall use the Hardy-Littlewood-Sobolev inequality which asserts that

$$\||\cdot|^{-\gamma} * f\|_{L^{\mathfrak{a}}(\mathbb{R})} \lesssim \|f\|_{L^{\mathfrak{b}}(\mathbb{R})} \tag{3.1}$$

whenever $1 < b < \alpha < \infty$ and $0 < \gamma < 1$ obey the scaling condition

$$\frac{1}{h} = \frac{1}{a} + 1 - \gamma.$$

We prove only (1.11) since (1.12) follows from (1.11) by the standard TT^* -argument. First note that (1.11) holds true for the pair $(q,r)=(\infty,2)$ as this is just the energy inequality. So we may assume $2 < q < \infty$ and r > 2.

Let q' and r' be the conjugates of q and r, respectively, i.e., $q' = \frac{q}{q-1}$ and $r' = \frac{r}{r-1}$. By the standard TT*-argument, (1.11) is equivalent to the estimate

$$\|\mathsf{T}\mathsf{T}^*\mathsf{F}\|_{\mathsf{L}^q_t\mathsf{L}^r_x(\mathbb{R}^{d+1})} \lesssim \left[c_{\beta,d}(\lambda)\right]^{1-\frac{2}{r}} \|\mathsf{F}\|_{\mathsf{L}^{q'}_t\mathsf{L}^r_x(\mathbb{R}^{d+1})},\tag{3.2}$$

where

$$TT^*F(x,t) = \int_{\mathbb{R}^d} \int_{\mathbb{R}} e^{ix\xi - i(t-s)m(\xi)} \rho_{\lambda}^2(\xi) \widehat{F}(\xi,s) \, ds d\xi$$

$$= \int_{\mathbb{R}} K_{\lambda,t-s} * F(\cdot,s) \, ds$$
(3.3)

with

$$K_{\lambda,t}(x) = \int_{\mathbb{R}^d} e^{ix\xi - itm(\xi)} \rho_{\lambda}^2(\xi) d\xi.$$

Since

$$K_{\lambda,t} * g(x) = e^{itm(D)} P_{\lambda} g_{\lambda}(x)$$

it follows from (1.8) that

$$\|\mathsf{K}_{\lambda,\mathsf{t}} * \mathsf{g}\|_{\mathsf{L}^{\infty}_{\mathsf{s}}(\mathbb{R}^{\mathsf{d}})} \lesssim c_{\beta,\mathsf{d}}(\lambda)|\mathsf{t}|^{-\frac{\mathsf{d}}{2}}\|\mathsf{g}\|_{\mathsf{L}^{1}_{\mathsf{s}}(\mathbb{R}^{\mathsf{d}})}. \tag{3.4}$$

On the other hand, we have by Plancherel

$$\|K_{\lambda,t} * g\|_{L^2_{\nu}(\mathbb{R}^d)} \lesssim \|g\|_{L^2_{\nu}(\mathbb{R}^d)}.$$
 (3.5)

So interpolation between (3.4) and (3.5) yields

$$\|K_{\lambda,t} * g\|_{L^{r}_{x}(\mathbb{R}^{d})} \lesssim \left[c_{\beta,d}(\lambda)\right]^{1-\frac{2}{r}} |t|^{-d\left(\frac{1}{2}-\frac{1}{r}\right)} \|g\|_{L^{r'}_{x}(\mathbb{R}^{d})}$$
(3.6)

for all $r \in [2, \infty]$.

Applying Minkowski's inequality to (3.3), and then use (3.6) and (3.1) with

$$(a,b) = (q,q'), \qquad \gamma = \frac{d}{2} - \frac{d}{r} = \frac{2}{q}$$

we obtain

$$\begin{split} \|TT^*F\|_{L^q_tL^r_x(\mathbb{R}^{d+1})} &\leqslant \left\| \int_{\mathbb{R}} \|K_{\lambda,t-s,} * F(s,\cdot)\|_{L^r_x(\mathbb{R}^d)} \ ds \right\|_{L^q_t(\mathbb{R})} \\ &\lesssim \left[c_{\beta,d}(\lambda) \right]^{1-\frac{2}{r}} \left\| \int_{\mathbb{R}} |t-s|^{-d\left(\frac{1}{2}-\frac{1}{r}\right)} \left\| F(s,\cdot) \right\|_{L^{r'}_x(\mathbb{R}^d)} \ ds \right\|_{L^q_t(\mathbb{R})} \\ &\lesssim \left[c_{\beta,d}(\lambda) \right]^{1-\frac{2}{r}} \left\| \|F\|_{L^{r'}_x(\mathbb{R}^d)} \right\|_{L^{q'}_t(\mathbb{R})} \\ &= \left[c_{\beta,d}(\lambda) \right]^{1-\frac{2}{r}} \left\| F\|_{L^{q'}_x(L^{r'}_x(\mathbb{R}^{d+1}))} \right. \end{split}$$

which is the desired estimate (3.2).

4. Proof of Theorem 3

We consider the system (1.5) with $\beta=0$ and a curl-free vector field $\bm{v},$ i.e., $\nabla\times\bm{v}=0.$ Observe that

$$L_0(D) = \sqrt{K(D)}, \qquad \mathfrak{m}_0(D) = |D| \sqrt{K(D)}.$$

The transformation (1.6) (with $\beta = 0$) yields

$$\eta = u_{+} + u_{-}, \quad \mathbf{v} = -i\sqrt{K}\Re(u_{+} - u_{-}),$$

where we have used the fact that \mathbf{v} is curl-free, in which case,

$$\nabla(\nabla \cdot \mathbf{v}) = \Delta \mathbf{v} = -|\mathbf{D}|^2 \mathbf{v} \quad \Rightarrow \quad \mathbf{v} = -\Re(\Re \cdot \mathbf{v}).$$

Consequently, the Cauchy problem (1.5), (1.13) transforms to

$$\begin{cases} (i\partial_{t} \mp m_{0}(D))u_{\pm} = \mathcal{B}^{\pm}(u_{+}, u_{-}), \\ u_{\pm}(0) = f_{\pm}, \end{cases}$$
(4.1)

where

$$\begin{split} \mathcal{B}^{\pm}(u_{+},u_{-}) &= 2^{-1}|D|K\mathcal{R}\cdot\left\{(u_{+}+u_{-})\mathcal{R}\sqrt{K}(u_{+}-u_{-})\right\} \\ &\pm 4^{-1}|D|\sqrt{K}\left|\mathcal{R}\sqrt{K}(u_{+}-u_{-})\right|^{2} \end{split} \tag{4.2}$$

and

$$f_{\pm} = \frac{\sqrt{K}\eta_0 \mp i\mathcal{R} \cdot \mathbf{v}_0}{2\sqrt{K}} \in H^s(\mathbb{R}^d). \tag{4.3}$$

Thus, Theorem 3 redues to the following:

Theorem 4. Let $d \ge 3$ and $s > \frac{d}{2} - \frac{3}{4}$. If the initial data has size

$$\sum_{\pm} \|f_{\pm}\|_{H^s} \leqslant \mathfrak{D}_0,$$

then there exists a solution

$$\mathfrak{u}_{\pm}\in C\left([0,T];H^s(\mathbb{R}^d)\times H^s(\mathbb{R}^d)\right)$$

of the Cauchy problem (4.1)–(4.3) with existence time $T\sim \mathcal{D}_0^{-2}.$

Moreover, the solution is unique in some subspace of $C\left([0,T];H^s(\mathbb{R}^d)\times H^s(\mathbb{R}^d)\right)$ and the solution depends continuously on the initial data.

4.1. **Reduction of Theorem 4 to bilinear estimates.** The bilinear terms in (4.2) can be written as

$$\begin{split} \mathcal{B}^{\pm}(u_+,u_-) &= \frac{1}{2} \sum_{\pm_1,\pm_2} \pm_2 D K \mathcal{R} \cdot \left(u_{\pm_1} \mathcal{R} \sqrt{K} u_{\pm_2} \right) \\ &\pm \frac{1}{4} \sum_{\pm_1,\pm_2} (\pm_1) (\pm_2) D \sqrt{K} \left(\mathcal{R} \sqrt{K} u_{\pm_1} \cdot \mathcal{R} \sqrt{K} u_{\pm_2} \right), \end{split}$$

where \pm_1 and \pm_2 are independent signs. Then the Duhamel's representation of (4.1) is given by

$$\begin{split} u_{\pm}(t) &= \mathcal{S}_{m_0}(\pm t) f_{\pm} \mp \frac{i}{2} \sum_{\pm_1, \pm_2} (\pm_2) \mathcal{B}_1^{\pm}(u_{\pm_1}, u_{\pm_2})(t) \\ &\mp \frac{i}{4} \sum_{\pm_1, \pm_2} (\pm_1)(\pm_2) \mathcal{B}_2^{\pm}(u_{\pm_1}, u_{\pm_2})(t), \end{split} \tag{4.4}$$

where $S_{m_0}(t) = e^{it m_0(D)}$ and

$$\begin{split} \mathcal{B}_{1}^{\pm}(\mathfrak{u},\mathfrak{v})(t) &:= \int_{0}^{t} \mathcal{S}_{\mathfrak{m}_{0}}(\pm(t-t')\mathsf{D}\mathsf{K}\mathcal{R}\cdot\left(\mathfrak{u}\mathcal{R}\sqrt{\mathsf{K}}\mathfrak{v}\right)(t')\,\mathsf{d}t',\\ \mathcal{B}_{2}^{\pm}(\mathfrak{u},\mathfrak{v})(t) &:= \int_{0}^{t} \mathcal{S}_{\mathfrak{m}_{0}}(\pm(t-t')\mathsf{D}\sqrt{\mathsf{K}}\left(\mathcal{R}\sqrt{\mathsf{K}}\mathfrak{u}\cdot\mathcal{R}\sqrt{\mathsf{K}}\mathfrak{v}\right)(t')\,\mathsf{d}t'. \end{split} \tag{4.5}$$

Setting $\beta = 0$ in Theorem 2 we obtain the following.

Corollary 1. Let $\lambda \in 2^{\mathbb{Z}}$ and $d \geqslant 2$. Assume that the pair (q,r) satisfies

$$2 < q \leqslant \infty$$
, $2 \leqslant r \leqslant \infty$, $\frac{2}{q} + \frac{d}{r} = \frac{d}{2}$.

Then

$$\left\| \mathcal{S}_{m_0}(\pm t) f_{\lambda} \right\|_{L_t^q L_x^r(\mathbb{R}^{d+1})} \lesssim \langle \lambda \rangle^{\frac{3}{2q}} \left\| f_{\lambda} \right\|_{L_x^2(\mathbb{R}^d)}, \tag{4.6}$$

$$\left\| \int_0^t S_{m_0}(\pm(t-s)) F_{\lambda}(s) \, ds \right\|_{L_t^q L_x^r(\mathbb{R}^{d+1})} \lesssim \langle \lambda \rangle^{\frac{3}{2q}} \, \|F_{\lambda}\|_{L_t^1 L_x^2(\mathbb{R}^{d+1})} \tag{4.7}$$

for all $f \in S(\mathbb{R}^d)$ and $F \in S(\mathbb{R}^{d+1})$.

Now, define the contraction space, X_T^s via the norm

$$\|\mathbf{u}\|_{X_T^s} = \left[\sum_{\lambda} \langle \lambda \rangle^{2s} \|\mathbf{u}\|_{X_{\lambda}}^2\right]^{\frac{1}{2}},$$

where

$$\left\|u\right\|_{X_{\lambda}}=\left[\left\|P_{\lambda}u\right\|_{L_{T}^{\infty}L_{x}^{2}}^{2}+\left\langle\lambda\right\rangle^{-\frac{3}{q}}\left\|P_{\lambda}u\right\|_{L_{T}^{q}L_{x}^{r}}^{2}\right]^{\frac{1}{2}}$$

with

$$2 < q < \infty, \qquad r = \frac{2qd}{qd-4}, \quad d \geqslant 2. \tag{4.8} \label{eq:4.8}$$

In view of Corollary 1 the pair (q, r) satisfying (4.8) is an admissible pair. Observe that

$$\|P_{\lambda}u\|_{L^{\infty}_{1}L^{2}_{x}} \leq \|u\|_{X_{\lambda}}, \qquad \|P_{\lambda}u\|_{L^{2}_{1}L^{r}_{x}} \leq \langle \lambda \rangle^{\frac{3}{2q}} \|u\|_{X_{\lambda}}. \tag{4.9}$$

Moreover,

$$X_T^s \subset L_T^\infty H^s$$
.

We estimate the linear part of (4.4) using (4.6) as

$$\begin{split} \left\| \mathcal{S}_{m_0}(\pm t) f_{\pm} \right\|_{X_T^s} &= \left[\sum_{\lambda} \langle \lambda \rangle^{2s} \left\| \mathcal{S}_{m_0}(\pm t) f_{\pm} \right\|_{X_{\lambda}}^2 \right]^{\frac{1}{2}} \\ &\lesssim \left[\sum_{\lambda} \langle \lambda \rangle^{2s} \left\| P_{\lambda} f_{\pm} \right\|_{L_x^2}^2 \right]^{\frac{1}{2}} \\ &\sim \left\| f_{\pm} \right\|_{H^s}. \end{split} \tag{4.10}$$

So Theorem 4 reduces to proving bilinear estimates on the terms $\mathcal{B}_1^{\pm}(\mathfrak{u},\nu)$ and $\mathcal{B}_2^{\pm}(\mathfrak{u},\nu)$ that are defined in (4.5). The proof of the following Lemma will be given in the next section.

Lemma 3. Let $d\geqslant 2$, $s>\frac{d}{2}-\frac{1}{2}-\frac{1}{2q}$ for q>2 , and T>0. Then

$$\|\mathcal{B}_{1}^{\pm}(\mathbf{u}, \mathbf{v})\|_{X_{T}^{s}} \lesssim \mathsf{T}^{1 - \frac{1}{q}} \|\mathbf{u}\|_{X_{T}^{s}} \|\mathbf{v}\|_{X_{T}^{s}},$$
 (4.11)

$$\left\| \mathcal{B}_{2}^{\pm}(u,\nu) \right\|_{X_{T}^{s}} \lesssim \mathsf{T}^{1-\frac{1}{q}} \left\| u \right\|_{X_{T}^{s}} \left\| \nu \right\|_{X_{T}^{s}} \tag{4.12}$$

for all $u, v \in X_T^s$, where \mathcal{B}_1^\pm and \mathcal{B}_2^\pm are as in (4.5).

4.2. **Proof of Theorem 4.** Given that Lemma 3 holds, we solve the integral equations (4.4) by contraction mapping techniques. We shall apply Lemma 3 with

$$q=\frac{2}{1-2\epsilon}\quad \text{for } \ 0<\epsilon\ll 1.$$

Consequently, the exponent s will be restricted to

$$s > \frac{d}{2} - \frac{3}{4} + \frac{\varepsilon}{2}.$$

Define the mapping

$$(u_+, u_-) \mapsto (\Phi^+(u_+, u_-), \Phi^-(u_+, u_-)),$$

where $\Phi^{\pm}(\mathfrak{u}_+,\mathfrak{u}_-)$ is given by the right hand side of (4.4). Now given initial data with norm

$$\sum_{\pm}\|f_{\pm}\|_{H^s}\leqslant \mathcal{D}_0,$$

we look for a solution in the set

$$E_T = \left\{ (u_\pm \in X_T^s \colon \sum_\pm \|u_\pm\|_{X_T^s} \leqslant 2C\mathcal{D}_0 \right\}.$$

By (4.10) and Lemma 3 we have

$$\sum_{\pm} \|\Phi^{\pm}(\mathbf{u}_{+}, \mathbf{u}_{-})\|_{X_{T}^{s}} \leqslant C \sum_{\pm} \|f_{\pm}\|_{H^{s}} + CT^{\frac{1}{2} + \varepsilon} \left(\sum_{\pm} \|\mathbf{u}_{\pm}\|_{X_{T}^{s}}\right)^{2}$$

$$\leqslant C\mathcal{D}_{0} + CT^{\frac{1}{2} + \varepsilon} (2C\mathcal{D}_{0})^{2}$$

$$\leqslant 2C\mathcal{D}_{0},$$

provided that

$$\mathsf{T} \leqslant \left(8\mathsf{C}^2\mathcal{D}_0\right)^{-\frac{2}{1+2\varepsilon}}.\tag{4.13}$$

Similarly, for two pair of solutions (u_+, u_-) and (v_+, v_-) in E_T with the same data, one can derive the difference estimate

$$\begin{split} &\sum_{\pm} \left\| \Phi^{\pm}(u_{+},u_{-}) - \Phi^{\pm}(\nu_{+},\nu_{-}) \right\|_{X_{T}^{s}} \\ &\leqslant C T^{\frac{1}{2} + \epsilon} \left(\sum_{\pm} \left\| u_{\pm} \right\|_{X_{T}^{s}} + \left\| \nu_{\pm} \right\|_{X_{T}^{s}} \right) \left(\sum_{\pm} \left\| u_{\pm} - \nu_{\pm} \right\|_{X_{T}^{s}} \right) \\ &\leqslant 4 C^{2} T^{\frac{1}{2} + \epsilon} \mathcal{D}_{0} \left(\sum_{\pm} \left\| u_{\pm} - \nu_{\pm} \right\|_{X_{T}^{s}} \right) \\ &\leqslant \frac{1}{2} \left(\sum_{\pm} \left\| u_{\pm} - \nu_{\pm} \right\|_{X_{T}^{s}} \right), \end{split}$$

where in the last inequality we used (4.13).

Therefore, (Φ^+, Φ^-) is a contraction on E_T and therefore it has a unique fixed point $(\mathfrak{u}_+,\mathfrak{u}_-)\in E_T$ solving the integral equation (4.4)–(4.5) on $\mathbb{R}^d\times [0,T]$, where $T\sim \mathcal{D}_0^{-2-}$. Uniqueness in the space $X_T^s\times X_T^s$ and continuous dependence on the initial data can be shown in a similar way, by the difference estimates. This concludes the proof of Theorems 4.

5. Proof of Lemma 3

First we prove some bilinear estimates in Lemma 4 below that will be crucial in the proof of Lemma 3. To do so, we need the following Bernstein inequality, which is valid for $1 \le a \le b \le \infty$ (see, for instance, [15, Appendix A]).

$$\|f_{\lambda}\|_{L_{\nu}^{b}} \lesssim \lambda^{\frac{d}{\alpha} - \frac{d}{b}} \|f_{\lambda}\|_{L_{x}^{\alpha}},\tag{5.1}$$

Moreover, we have for all $s_1, s_2 \in \mathbb{R}$ and $\mathfrak{p} \geqslant 1$,

$$\||D|^{s_1}K^{s_2}\mathcal{R}f_{\lambda}\|_{L^p} \lesssim \lambda^{s_1}\langle\lambda\rangle^{-s_2}\|f_{\lambda}\|_{L^p},\tag{5.2}$$

where we used $K(\xi) \sim \langle \xi \rangle^{-1}$.

Lemma 4. Let $d \geqslant 2$, q > 2, T > 0 and $\lambda_j \in 2^{\mathbb{Z}}$ (j = 0, 1, 2). Then

$$\left\| |\mathsf{D}|\mathsf{KP}_{\lambda_0} \mathcal{R} \cdot \left(\mathsf{u}_{\lambda_1} \mathcal{R} \sqrt{\mathsf{K}} \mathsf{v}_{\lambda_2} \right) \right\|_{\mathsf{L}^1_\mathsf{T} \mathsf{L}^2_\mathsf{x}} \lesssim \frac{\mathsf{T}^{1 - \frac{1}{q}} \min \left(\langle \lambda_1 \rangle, \langle \lambda_2 \rangle \right)^{\frac{d}{2} - \frac{1}{2q}}}{\langle \lambda_2 \rangle^{\frac{1}{2}}} \left\| \mathsf{u} \right\|_{\mathsf{X}_{\lambda_1}} \left\| \mathsf{v} \right\|_{\mathsf{X}_{\lambda_2}}, \tag{5.3}$$

$$\left\| |\mathsf{D}| \sqrt{\mathsf{K}} \mathsf{P}_{\lambda_0} \left(\mathcal{R} \sqrt{\mathsf{K}} \mathsf{u}_{\lambda_1} \cdot \mathcal{R} \sqrt{\mathsf{K}} \mathsf{v}_{\lambda_2} \right) \right\|_{\mathsf{L}^1_\mathsf{T} \mathsf{L}^2_\mathsf{x}} \lesssim \frac{\mathsf{T}^{1 - \frac{1}{q}} \langle \lambda_0 \rangle^{\frac{1}{2}} \min \left(\langle \lambda_1 \rangle, \langle \lambda_2 \rangle \right)^{\frac{d}{2} - \frac{1}{2q}}}{\langle \lambda_1 \rangle^{\frac{1}{2}} \langle \lambda_2 \rangle^{\frac{1}{2}}} \left\| \mathsf{u} \right\|_{\mathsf{X}_{\lambda_1}} \left\| \mathsf{v} \right\|_{\mathsf{X}_{\lambda_2}} \tag{5.4}$$

for all $u \in X_{\lambda_1}$ and $v \in X_{\lambda_2}$.

Proof. We only prove (5.3) since the proof for (5.4) is similar. To prove (5.3) , by symmetry, we may assume $\lambda_1 \leq \lambda_2$. Let

$$q=2^+, \qquad r=rac{2qd}{qd-4}, \qquad d\geqslant 2$$

Then by Hölder, (5.2), (5.1) and (4.9) we obtain

$$\begin{split} LHS \text{ (5.3)} &\lesssim T^{\frac{1}{2}} \lambda_0 \langle \lambda_0 \rangle^{-1} \left\| \mathcal{R} \cdot (u_{\lambda_1} \mathcal{R} \sqrt{K} \nu_{\lambda_2}) \right\|_{L^2_{T,x}} \\ &\lesssim T^{\frac{1}{2}} \langle \lambda_2 \rangle^{-\frac{1}{2}} \left\| u_{\lambda_1} \right\|_{L^2_T L^\infty_x} \left\| \nu_{\lambda_2} \right\|_{L^\infty_T L^2_x} \\ &\lesssim T^{1-\frac{1}{q}} \langle \lambda_2 \rangle^{-\frac{1}{2}} \lambda_1^{\frac{d}{2}-\frac{2}{q}} \left\| u_{\lambda_1} \right\|_{L^q_T L^\tau_x} \left\| \nu_{\lambda_2} \right\|_{L^\infty_T L^2_x} \\ &\lesssim T^{1-\frac{1}{q}} \langle \lambda_2 \rangle^{-\frac{1}{2}} \lambda_1^{\frac{d}{2}-\frac{2}{q}} \langle \lambda_1 \rangle^{\frac{3}{2q}} \left\| u \right\|_{X_{\lambda_1}} \left\| \nu \right\|_{X_{\lambda_2}} \\ &\lesssim T^{\frac{1}{2}} \langle \lambda_2 \rangle^{-\frac{1}{2}} \langle \lambda_1 \rangle^{\frac{d}{2}-\frac{1}{2q}} \left\| u \right\|_{X_{\lambda_1}} \left\| \nu \right\|_{X_{\lambda_2}} \end{split}$$

which proves (5.3).

Now we are ready to prove Lemma 3. To this end, we decompose $u=\sum_{\lambda}u_{\lambda}$ and $v=\sum_{\lambda}v_{\lambda}$. Note that by denoting

$$\mathfrak{a}_{\lambda} := \|\mathfrak{u}\|_{X_{\lambda}} \,, \quad \mathfrak{b}_{\lambda} := \|\mathfrak{v}\|_{X_{\lambda}}$$

we can write

$$\|\mathbf{u}\|_{X_{\tau}^{s}} = \|(\langle \lambda \rangle^{s} a_{\lambda})\|_{l_{2}^{s}}, \quad \|\nu\|_{X_{\tau}^{s}} = \|(\langle \lambda \rangle^{s} b_{\lambda})\|_{l_{2}^{s}}.$$
 (5.5)

We shall make a frequent use of of the following dyadic summation estimate, for $\mu, \lambda \in 2^{\mathbb{Z}}$ and $c_1, c_2, p > 0$:

$$\sum_{\mu \sim \lambda} \alpha_{\mu} \sim \alpha_{\lambda}, \qquad \sum_{\substack{c_1 \lesssim \lambda \lesssim c_2}} \lambda^{p} \lesssim \left\{ \begin{array}{cc} c_2^p & \text{if } p > 0, \\ c_1^p & \text{if } p < 0. \end{array} \right.$$

5.1. **Proof of** (4.11). Applying (4.7) to $\mathcal{B}_{1}^{\pm}(u, v)$ in (4.5) we get

$$\left\| \mathcal{B}_1^{\pm}(u,\nu) \right\|_{X_T^s}^2 \lesssim \sum_{\lambda_0} \langle \lambda_0 \rangle^{2s} \left\| |D| K \mathcal{R} \cdot P_{\lambda_0} \left(u \mathcal{R} \sqrt{K} \nu \right) \right\|_{L_T^1 L_x^2}^2,$$

where (4.9) is also used. By the dyadic decomposition

$$\left\| |D| K \mathcal{R} \cdot P_{\lambda_0} \left(u \mathcal{R} \sqrt{K} v \right) \right\|_{L^1_T L^2_x} \lesssim \sum_{\lambda_1, \lambda_2} \left\| |D| K \mathcal{R} \cdot P_{\lambda_0} \left(u_{\lambda_1} \mathcal{R} \sqrt{K} v_{\lambda_2} \right) \right\|_{L^1_T L^2_x}. \tag{5.6}$$

Now let λ_{min} , λ_{med} and λ_{max} denote the minimum, median and the maximum of $\{\lambda_0, \lambda_1, \lambda_2\}$, respectively. By checking the support properties in Fourier space of the bilinear term on the right hand side of (5.6) one can see that this term vanishes unless $\lambda = (\lambda_0, \lambda_1, \lambda_2) \in \Lambda$, where

$$\Lambda = \{ \lambda : \lambda_{med} \sim \lambda_{max} \}.$$

Thus, we have a non-trivial contribution in (5.6) only if $\lambda \in \cup_{j=0}^2 \Lambda_j$, where

$$\Lambda_0 = \{ \boldsymbol{\lambda} : \ \lambda_0 \lesssim \lambda_1 \sim \lambda_2 \},$$

$$\Lambda_1 = \{ \boldsymbol{\lambda} : \ \lambda_2 \ll \lambda_1 \sim \lambda_0 \},$$

$$\Lambda_2 = \{ \boldsymbol{\lambda} : \ \lambda_1 \ll \lambda_2 \sim \lambda_0 \}.$$

By using these facts, and applying (5.3) to the right hand side of (5.6), we get

$$\|\mathfrak{B}_{1}^{\pm}(\mathfrak{u},\mathfrak{v})\|_{X_{T}^{s}}^{2} \lesssim T^{2-\frac{2}{q}} \sum_{j=0}^{2} \mathfrak{I}_{j}$$

where

$$J_{j} = \sum_{\lambda_{0}} \langle \lambda_{0} \rangle^{2s} \left[\sum_{\lambda_{1}, \lambda_{2} : \boldsymbol{\lambda} \in \Lambda_{j}} \frac{\min(\langle \lambda_{1} \rangle, \langle \lambda_{2} \rangle)^{\frac{d}{2} - \frac{1}{2q}}}{\langle \lambda_{2} \rangle^{\frac{1}{2}}} a_{\lambda_{1}} b_{\lambda_{2}} \right]^{2}$$
(5.7)

So (4.11) reduces to proving

$$J_{j} \lesssim \|u\|_{X_{T}^{s}}^{2} \|v\|_{X_{T}^{s}}^{2} \quad \text{if } s > \frac{d}{2} - \frac{1}{2} - \frac{1}{2g}$$
 (5.8)

for j = 0, 1, 2.

These are shown to hold as follows:

$$\begin{split} & \mathbb{J}_0 \lesssim \sum_{\lambda_0} \langle \lambda_0 \rangle^{2s} \left(\sum_{\lambda_1 \sim \lambda_2 \gtrsim \lambda_0} \alpha_{\lambda_1} \cdot \langle \lambda_2 \rangle^{\frac{d}{2} - \frac{1}{2} - \frac{1}{2q}} b_{\lambda_2} \right)^2 \\ & \lesssim \sum_{\lambda_0} \langle \lambda_0 \rangle^{-2 \left(s - \frac{d}{2} + \frac{1}{2} + \frac{1}{2q}\right)} \left(\sum_{\lambda_1 \sim \lambda_2 \gtrsim \lambda_0} \langle \lambda_1 \rangle^s \alpha_{\lambda_1} \cdot \langle \lambda_2 \rangle^s b_{\lambda_2} \right)^2 \\ & \lesssim \|u\|_{X_1^s}^2 \|v\|_{X_1^s}^2 \,, \end{split}$$

where to obtain the last line we used Cauchy Schwarz inequality in $\lambda_1 \sim \lambda_2$ and (5.5).

Similarly,

$$\begin{split} & \mathfrak{I}_1 \lesssim \sum_{\lambda_0} \langle \lambda_0 \rangle^{2s} \left(\sum_{\lambda_2 \ll \lambda_1 \sim \lambda_0} \alpha_{\lambda_1} \cdot \langle \lambda_2 \rangle^{\frac{d}{2} - \frac{1}{2} - \frac{1}{2q}} b_{\lambda_2} \right)^2 \\ & \lesssim \sum_{\lambda_0} \langle \lambda_0 \rangle^{2s} \alpha_{\lambda_0}^2 \left(\sum_{\lambda_2} \langle \lambda_2 \rangle^{\frac{d}{2} - \frac{1}{2} - \frac{1}{2q}} b_{\lambda_2} \right)^2 \\ & \lesssim \| \mathbf{u} \|_{\mathbf{X}^s_{\mathbf{T}}}^2 \| \boldsymbol{\nu} \|_{\mathbf{X}^s_{\mathbf{T}}}^2 \,, \end{split}$$

where to get the last two inequalities we used $\sum_{\lambda_1\sim\lambda_0}a_{\lambda_1}\sim a_{\lambda_0}$ and by Cauchy Schwarz

$$\begin{split} \sum_{\lambda_2} \langle \lambda_2 \rangle^{\frac{d}{2} - \frac{1}{2} - \frac{1}{2q}} b_{\lambda_2} &= \sum_{\lambda_2} \langle \lambda_2 \rangle^{\frac{d}{2} - \frac{1}{2} - \frac{1}{2q} - s} \cdot \langle \lambda_2 \rangle^s b_{\lambda_2} \\ &\lesssim \ \big\| \big(\langle \lambda_2 \rangle^s b_{\lambda_2} \big) \big\|_{l^2_{\lambda_2}} \lesssim \| \nu \|_{X^s_T} \,. \end{split}$$

Finally,

$$\begin{split} & \mathbb{J}_2 \lesssim \sum_{\lambda_0} \langle \lambda_0 \rangle^{2s} \left(\sum_{\lambda_1 \ll \lambda_2 \sim \lambda_0} \langle \lambda_1 \rangle^{\frac{d}{2} - \frac{1}{2} - \frac{1}{2q}} a_{\lambda_1} \cdot b_{\lambda_2} \right)^2 \\ & \lesssim \sum_{\lambda_0} \langle \lambda_0 \rangle^{2s} b_{\lambda_0}^2 \left(\sum_{\lambda_1} \langle \lambda_1 \rangle^{\frac{d}{2} - \frac{1}{2} - \frac{1}{2q}} a_{\lambda_1} \right)^2 \\ & \lesssim \| \mathbf{u} \|_{\mathbf{X}_2^s}^2 \| \mathbf{v} \|_{\mathbf{X}_2^s}^2 \,. \end{split}$$

5.2. **Proof of** (4.12). Arguing as in the preseding subsection we apply (4.7) to $\mathcal{B}_2^{\pm}(u,v)$ in (4.5) and then use (5.4) to obtain

$$\left\|\mathbb{B}_2^{\pm}(\mathfrak{u},\mathfrak{v})\right\|_{X_T^s}^2 \lesssim \mathsf{T}^{2-\frac{2}{q}} \sum_{j=0}^2 \widetilde{\mathfrak{I}}_j$$

where

$$\widetilde{J}_{j} = \sum_{\lambda_{0}} \langle \lambda_{0} \rangle^{2s} \left[\sum_{\lambda_{1}, \lambda_{2} \in \Lambda_{j}} C(\lambda_{0}, \lambda_{1}, \lambda_{2}) a_{\lambda_{1}} b_{\lambda_{2}} \right]^{2}$$

with

$$C(\lambda_0, \lambda_1, \lambda_2) = \frac{\langle \lambda_0 \rangle^{\frac{1}{2}} \min \left(\langle \lambda_1 \rangle, \langle \lambda_2 \rangle \right)^{\frac{d}{2} - \frac{1}{2q}}}{\langle \lambda_1 \rangle^{\frac{1}{2}} \langle \lambda_2 \rangle^{\frac{1}{2}}}$$

So (4.12) reduces to proving

$$\widetilde{\mathbb{J}}_{j} \lesssim \|u\|_{X^{\underline{s}}_{\mathtt{T}}}^{2} \, \|\nu\|_{X^{\underline{s}}_{\mathtt{T}}}^{2} \quad (\mathfrak{j}=0,1,2).$$

These can be proved following the argument of the preceding subsection by using the fact that

$$C(\lambda_0, \lambda_1, \lambda_2) \lesssim \min(\langle \lambda_1 \rangle, \langle \lambda_2 \rangle)^{\frac{d}{2} - \frac{1}{2} - \frac{1}{2q}}$$

for all $\lambda_0, \lambda_1, \lambda_2 \in \Lambda$.

6. Appendix

In this appendix, we derive some useful estimates on the derivatives of all order for the function

$$m_{\beta}\left(r\right)=\sqrt{r\left(1+\beta r^{2}\right)tanh(r)},\qquad\beta\in\{0,1\}.$$

Estimates for the first and second order derivatives of this function is derived recently in [11].

Clearly,

$$m_{\beta}(r) \sim r \langle \sqrt{\beta}r \rangle \langle r \rangle^{-1/2}.$$
 (6.1)

Lemma 5. Let $\beta \in \{0,1\}$ and r > 0. Then

$$m'_{\beta}(r) \sim \langle \sqrt{\beta}r \rangle \langle r \rangle^{-1/2},$$
 (6.2)

$$|\mathfrak{m}_{\beta}^{"}(r)| \sim r \langle \sqrt{\beta} r \rangle \langle r \rangle^{-5/2}.$$
 (6.3)

Moreover,

$$|\mathfrak{m}_{\beta}^{(k)}(r)| \underset{k}{\lesssim} r^{1-k} \langle \sqrt{\beta} r \rangle \langle r \rangle^{-1/2} \qquad (k \geqslant 3). \tag{6.4}$$

Proof. The estimates (6.2) and (6.3) are proved in [11, Lemma 3.2, see its proof in Section 5]. So we only prove (6.4).

Let

$$T(r) = \tanh r$$
, $S(r) = \operatorname{sech} r$.

Then

$$T' = S^2$$
, $S' = -TS$, $T'' = -2TS^2$.

In general, we have

$$T^{(j)}(r) = S^2 \cdot P_{j-1}(S, T)$$
 $(j \ge 1)$

for some polynomial P_{j-1} of degree j-1.

Clearly,

$$T(r) \sim r \langle r \rangle^{-1} \qquad \text{and} \qquad S(r) \sim e^{-r}.$$

So $|P_{i-1}(S,T)| \lesssim 1$, and hence

$$|T^{(j)}(r)| \lesssim e^{-2r}$$
 $(j \ge 1)$. (6.5)

Write

$$m_{\beta}(r) = f_{\beta}(r) \cdot T_0(r),$$

where $f_{\beta}(r)=\sqrt{r}\langle\sqrt{\beta}r\rangle$ and $T_{0}(r)=\sqrt{T(r)}.$ One can show that

$$\left|f_{\beta}^{(j)}(r)\right| \lesssim r^{\frac{1}{2}-j} \langle \sqrt{\beta}r \rangle \qquad (j \geqslant 0).$$
 (6.6)

Combining (6.5) with $T(r) \sim r \langle r \rangle^{-1}$ we obtain

$$T_0(r) \sim r^{\frac{1}{2}} \langle r \rangle^{-\frac{1}{2}}, \qquad \left| T_0^{(j)}(r) \right| \lesssim r^{\frac{1}{2}-j} \langle r \rangle^{j-\frac{1}{2}} e^{-2r} \qquad (j \geqslant 1). \tag{6.7}$$

Finally, we use (6.6) and (6.7) to obtain for all $k \ge 3$,

$$\begin{split} \left| \mathfrak{m}_{\beta}^{(k)}(r) \right| &= \left| f_{\beta}^{(k)}(r) \mathsf{T}_{0}(r) + \sum_{j=1}^{k} \binom{k}{j} \, f_{\beta}^{(k-j)}(r) \mathsf{T}_{0}^{(j)}(r) \right| \\ &\lesssim r^{1-k} \langle \sqrt{\beta} r \rangle \langle r \rangle^{-\frac{1}{2}} + \sum_{j=1}^{k} \binom{k}{j} \, r^{\frac{1}{2} - (k-j)} \langle \sqrt{\beta} r \rangle \cdot r^{\frac{1}{2} - j} \langle r \rangle^{j - \frac{1}{2}} e^{-2r} \\ &\lesssim r^{1-k} \langle \sqrt{\beta} r \rangle \langle r \rangle^{-\frac{1}{2}}. \end{split}$$

Corollary 2. For λ , r > 0, define $\mathfrak{m}_{\beta,\lambda}(r) = \mathfrak{m}_{\beta}(\lambda r)$. Then

$$\max_{r \sim 1} \left| \vartheta_r^k \left(\frac{1}{\mathfrak{m}_{\beta,\lambda}'(r)} \right) \right| \lesssim \lambda^{-1} \langle \sqrt{\beta} \lambda \rangle^{-1} \langle \lambda \rangle^{\frac{1}{2}} \qquad (k \geqslant 0). \tag{6.8}$$

Proof. Observe that

$$\mathfrak{m}_{\beta,\lambda}^{(k)}(r) = \lambda^k \mathfrak{m}_{\beta}^{(k)}(\lambda r) \qquad (k \geqslant 1).$$

By (6.2) we have, for $r \sim 1$,

$$|m_{\beta,\lambda}'(r)| \sim \lambda \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-\frac{1}{2}}$$

and by (6.3)- (6.4)

$$|\mathfrak{m}_{\beta,\lambda}^{(k)}(r)| \underset{k}{\lesssim} \lambda \langle \sqrt{\beta} \lambda \rangle \langle \lambda \rangle^{-\frac{1}{2}} \qquad (k \geqslant 2).$$

Finally, one can combine these two estimates with the differentiation formula

$$\vartheta_r^k\left(\frac{1}{f}\right) = \sum_{p=1}^k \sum_{\substack{k_1,\cdots,k_p \in \mathbb{N} \\ k_1+\cdots+k_n=k}} c_{p,k_1,\cdots,k_p} \frac{\vartheta_r^{k_1} f \cdots \vartheta_r^{k_p} f}{f^{p+1}}$$

to obtain the desired estimate (6.8).
