# KLEIN FOUR 2-SLICES AND THE SLICES OF $\Sigma^{ \pm n} H \underline{Z}$

#### Abstract

We determine a characterization of all 2 -slices of equivariant spectra over the Klein four-group $C_{2} \times C_{2}$. We then describe all slices of integral suspensions of the equivariant EilenbergMacLane spectrum $H \underline{Z}$ for the constant Mackey functor over $C_{2} \times$ $C_{2}$.

## 1. Introduction

The slice filtration, a filtration of genuine $G$-spectra, was developed by Hill, Hopkins, and Ravenel in their solution to the Kervaire invariantone problem [HHR1] and is a generalization of Dugger's filtration [D]. It was modeled after Voevodsky's motivic slice filtration [V] and is an equivariant generalization of the Postnikov tower. Rather than decomposing a $G$-spectrum into Eilenberg-Mac Lane specra, as does the Postnikov tower, instead the slice filtration decomposes a $G$-spectrum into " $n$-slices".

There is a complete characterization of all $n$-slices where $-1 \leq n \leq 1$, listed in Proposition 2.4. This, combined with Proposition 2.5, characterizes all slices in degrees congruent to $-1,0$, or 1 , modulo the order of $G$. For $G=C_{2} \times C_{2}$, we are then only missing the ( $4 k+2$ )-slices. In Section 5 we finish this characterization with the following result.

Theorem 5.9: Suppose the only nontrivial homotopy Mackey functors of a $\left(C_{2} \times C_{2}\right)$-spectrum $X$ are $\underline{\pi}_{1}(X)$ and $\underline{\pi}_{2}(X)$ where certain maps in each Mackey functor are injective. Then $X$ is a 2-slice. Conversely, if $X$ is a 2-slice, then its only nontrivial homotopy Mackey functors are $\underline{\pi}_{1}(X)$ and $\underline{\pi}_{2}(X)$ where $\Sigma^{2} H \underline{\pi}_{2}(X)$ is a 2 -slice and $\Sigma^{1} H \underline{\pi}_{1}(X) \in[2,4]$.
Much work has been done computing the slices of certain $R O(G)$-graded suspensions of $H_{G} \mathbb{Z}$ including $G=C_{p^{n}}$ by [HHR2] and [Y], and $G=D_{2 p}$ by [Z2]. [GY] computes the slices of $\Sigma^{n} H_{K} \underline{\mathbb{F}_{2}}$ where $K=C_{2} \times C_{2}$. Most of these slices are $R O(K)$-graded suspensions of $H_{\pi_{-i}}\left(\Sigma^{-k \rho_{K}} H_{K} \mathbb{F}_{2}\right)$ for $i$ in the range $[k+3,4 k]$. We primarily focus on the slices of $\Sigma^{ \pm n} \bar{H}_{K} \underline{Z}$. Although we have cofiber sequences relating $\Sigma^{n} H_{K} \underline{\mathbb{Z}}$ to $\Sigma^{n} H_{K} \underline{\mathbb{F}_{2}}$, we can only recover some information about the former from the latter.
As for the slices of $\Sigma^{ \pm n} H_{K} \underline{Z}$, the main result can be summarized as follows:
Main Result: For $n<0$, all nontrivial slices of $\Sigma^{n} H_{K} \underline{\mathbb{Z}}$ are given by:

$$
P_{i}^{i}\left(\Sigma^{n} H_{K} \underline{\mathbb{Z}}\right) \simeq \Sigma^{-V} H_{K} \underline{M}
$$

where $i$ is in the range $[4 n, n]$. For $0 \leq n \leq 5, \Sigma^{n} H \underline{\mathbb{Z}}$ is an $n$-slice. Finally, for $n>5$,

$$
P_{i}^{i}\left(\Sigma^{n} H_{K} \underline{\mathbb{Z}}\right) \simeq \Sigma^{V} H_{K} \underline{M}
$$

where $i$ is in the range $[n, 4(n-4)]$. The representations $V$ and Mackey functors $\underline{M}$ are given in Proposition 7.3, Proposition 7.4, Proposition 7.8, Proposition 8.5, Proposition 8.6, and Proposition 8.7.
The paper is organized as follows. In Section 2, we review the slice filtration and relevant dualities. The story for $K$ must restrict to the corresponding results for $C_{2}$, so we review these results in Section 3. Section 4 provides us with the main Mackey functors for $K$ and some pertinent results for Section 5 , in which we characterize all 2 -slices over $K$. We provide some slice towers in Section 6 and describe the slices of $\Sigma^{-n} H_{K} \underline{\mathbb{Z}}$ in Section 7.1. In Section 8, we use Brown-Comenetz duality and the slices of $\Sigma^{-n} H \underline{\mathbb{Z}}$ to obtain the slices of $\Sigma^{n} H_{K} \mathbb{Z}$. We then compute the homotopy Mackey functors of the slices of $\Sigma^{ \pm n} H_{K} \underline{\mathbb{Z}}$ in Section 9. Finally, we provide some examples of the slice spectral sequence for $\Sigma^{ \pm n} H_{K} \underline{\mathbb{Z}}$ in Section 10.
The author is grateful for the guidance of Bert Guillou and some helpful conversations with Vigleik Angelveit. Figures 10.10, 10.11, 10.12, 10.13, 10.14, and 10.15 were created using Hood Chatham's spectralsequences package.

## 2. BACKGROUND

In this section we give background for the slice filtration as well as Brown-Comenetz and Anderson duality, and $K$-representations. Here, except for Section 2.3, $G$ is any finite group.

### 2.1. The Slice Filtration.

We start with a brief review of the equivariant slice filtration. For more details see [HHR1, Section 4].
Definition 2.1. Let $\mathrm{Sp}^{G}$ be the category of genuine $G$-spectra. Let $\tau_{\geqq n}^{G} \subseteq \mathrm{Sp}^{G}$ be the localizing subcategory generated by $G$-spectra of the form $\Sigma_{G}^{\infty} G_{+} \wedge_{H} S^{k \rho_{H}}$ where $H \leq G, \rho_{H}$ is the regular representation of $H$, and $k|H| \geq n$. We write $X \geq n$ to mean that $X \in \tau_{\geq n}^{G}$.

Definition 2.2. We say that $X<n$ if

$$
\left[S^{k \rho_{H}+r}, X\right]^{H}=0
$$

for all $r \geq 0$ and all subgroups $H \leq G$ such that $k|H| \geq n$.

Theorem 2.3. [HY, Corollary 2.9, Theorem 2.10] Let $n \geq 0$. Then $X \geq n$ if and only if

$$
\pi_{k}\left(X^{H}\right)=0 \quad \text { for } \quad k<\frac{n}{|H|} .
$$

## Proposition 2.4.

(1) [HHR1, Proposition 4.50] $X$ is a 0 -slice if and only if $X \simeq H \underline{M}$ for some $\underline{M} \in \operatorname{Mack}(G)$.
(2) [HHR1, Proposition 4.50] $X$ is a 1 -slice if and only if $X \simeq \Sigma^{1} H \underline{M}$ for some $\underline{M} \in \operatorname{Mack}(G)$ with injective restrictions.
(3) [U1, Theorem 6-4] $\Sigma^{-1} H \underline{M}$ is a $(-n)$-slice iff $\underline{M}$ has surjective transfers for $|H| \geq n$ and $M(G / H)=0$ for $|H|<n$.

It is important to note that [HHR1] uses the original slice filtration whereas we employ the regular slice filtration from [U1]. Except for an indexing difference of one, the results are the same.

Proposition 2.5. [HHR1, Corollary 4.25] For any $k \in \mathbb{Z}$,

$$
\left.P_{k+|G|}^{k+|G|} \mid \Sigma^{\rho} X\right) \simeq \Sigma^{\rho} P_{k}^{k}(X) .
$$

That is, suspension by the regular representation commutes with the slice filtration.

Given some surjection of groups $\phi_{N}: G \rightarrow G / N$ where $N \unlhd G$, there is a geometric pullback functor $\phi_{N}^{*}: \mathrm{Sp}^{G / N} \rightarrow \mathrm{Sp}^{G}[\mathrm{H}$, Definition 4.1].

Proposition 2.6. [H, Conjecture 4.11], [U1, Corollary 4-5] Let $N \unlhd G$. If the $(G / N)$-spectrum $X$ is a $k$-slice over $G / N$, then $\phi_{N}^{*} X$ is a $k[G: N]-$ slice over $G$.

### 2.2. Brown-Comenetz and Anderson Duality.

As in [HS], we write $I_{\mathbb{Q} / \mathbb{Z}}$ to indicate the representing $G$-spectrum of the cohomology theory $X \mapsto \operatorname{Hom}\left(\pi_{-*}^{G} X, \mathbb{Q} / \mathbb{Z}\right)$. The Brown-Comenetz dual of $X$ is then defined to be the function $G$-spectrum $F\left(X, I_{\mathbb{Q} / \mathbb{Z}}\right)$. Similarly, $I_{\mathbb{Q}}$ represents $X \mapsto \operatorname{Hom}\left(\pi_{-*} X, \mathbb{Q}\right)$ and $I_{\mathbb{Q}} X=F\left(X, I_{\mathbb{Q}}\right)$. Finally, the Anderson dual of $X$ is $I_{\mathbb{Z}} X=F\left(X, I_{\mathbb{Z}}\right)$, where $I_{\mathbb{Z}}$ is the fiber of the natural map $I_{\mathbb{Q}} \rightarrow I_{\mathbb{Q} / \mathbb{Z}}$.
Example 2.7. [GM, Section 3A], [HS] For a torsion Eilenberg-MacLane spectrum $H \underline{M}$,

$$
I_{\mathbb{Z}} H \underline{M} \simeq \Sigma^{-1} H \underline{M}^{*}
$$

and

$$
I_{\mathbb{Q} / \mathbb{Z}} H \underline{M} \simeq H \underline{M}^{*} .
$$

One should note that [HS] deals with non-equivariant spectra and [GM, Section 3A] refers specifically to $H \underline{M}$ as an $\mathbb{F}_{2}$-torsion spectrum. This example, however, follows easily from their work and [U2, Corollary I.7.3]. See [GM, Section 3A, Section 3B] for a more detailed discussion of equivariant Anderson duality.

Proposition 2.8. ([U2, Theorem I.7.7, Theorem I.7.8]) For a spectrum $X$,

$$
X \geq n \Leftrightarrow I_{\mathbb{Q} / \mathbb{Z}} X \leq-n
$$

In particular,

$$
P_{k}^{n} I_{\mathbb{Q} / \mathbb{Z}} X \cong I_{\mathbb{Q} / \mathbb{Z}} P_{-n}^{-k} X .
$$

That is, the Brown-Comenetz dualization functor dualizes slice status.

## 2.3. $K$-Representations.

Recall that $\sigma$ is the one-dimensional sign representation of $C_{2}$. The sign representations of $K$ are then the pullbacks $p_{1}^{*} \sigma, m^{*} \sigma$, and $p_{2}^{*} \sigma$ where $p_{1}, m$, and $p_{2}$ are


As in [GY], we will write

$$
\alpha=p_{1}^{*} \sigma, \quad \beta=p_{2}^{*} \sigma, \quad \text { and } \quad \gamma=m^{*} \sigma
$$

The regular representation of $K$ is then $\rho_{K}=1+\alpha+\beta+\gamma$.

## 3. REVIEW OF $C_{2}$

The Lewis diagram for a $C_{2}$-Mackey functor takes the form

where $\underline{M}(e)$ has a $C_{2} / e$ action. Arrows going down the diagram are called restrictions and arrows going up are called transfers.

For the sake of clarity in large diagrams, in a general Mackey functor $\underline{M}$ we will henceforward denote $\underline{M}(H)$ by $M_{H}$.
Proposition 3.1. A $C_{2}$-spectrum $Y$ is a 2 -slice over $C_{2}$ if and only if the only nontrivial homotopy Mackey functors are $\underline{\pi}_{1}(Y)$ and $\underline{\pi}_{2}(Y)$, where
(1) The restriction map $\mathbf{r}_{e}^{C_{2}}: \pi_{2}^{C_{2}}(Y) \rightarrow \pi_{2}^{e}(Y)$ is injective
(2) $\pi_{1}^{e}(Y)=0$.

That is, both $\Sigma^{2} H \underline{\pi}_{2}(Y)$ and $\Sigma^{1} \underline{\pi}_{1}(Y)$ are 2 -slices.
Proof. Let $\underline{M}=\underline{\pi}_{2}(Y)$ and $\underline{N}=\underline{\pi}_{1}(Y)$ and suppose that they are the only nontrivial homotopy Mackey functors of $Y$. We show that $\Sigma^{2} H \underline{M}$ and $\Sigma^{1} H \underline{N}$ are 2 -slices if and only if Item 1 and Item 2 hold.
First, consider $\Sigma^{2} H \underline{M}$. We immediately see that this spectrum is at least two. As for $\Sigma^{2} \underline{H M} \leq 2$, the cofiber sequence

$$
\left(S^{-\sigma} \rightarrow S^{0} \rightarrow C_{2} / e_{+}\right) \wedge \Sigma^{2} H \underline{M}
$$

provides the homotopy


Then the cofiber sequences

$$
\left(S^{-k \sigma} \rightarrow S^{-(k-1) \sigma} \rightarrow C_{2} / e_{+} \wedge S^{-(k-1) \sigma}\right) \wedge \Sigma^{2} H \underline{M}
$$

reveal that $\underline{\pi}_{2}^{C_{2}}\left(\Sigma^{-k \sigma} \Sigma^{2} H \underline{M}\right)=\operatorname{ker}\left(\mathbf{r}_{e}^{C_{2}}\right)$ for all $k \geq 2$.
By definition, $\Sigma^{2} H \underline{M} \leq 2$ if and only if $\underline{\pi}_{2}^{C_{2}}\left(\Sigma^{-k \sigma} \Sigma^{2} H \underline{M}\right)=0$ for all $k \geq 2$. Consequently, $\Sigma^{2} H \underline{M}$ is a 2 -slice if and only if $\mathbf{r}_{e}^{C_{2}}$ is injective .

As for $\Sigma^{1} H \underline{N}$, by Theorem 2.3, we find that $Y \geq 2$ if and only if $N_{e}=0$. But then $\Sigma^{\overline{1}} H \underline{N}$ is the pullback $\phi_{K}^{*} \Sigma^{1} H N_{e}$ and consequently, a 2 -slice by Proposition 2.6.
Conversely, assume $Y$ is a 2 -slice. By Theorem 2.3, we know $\underline{\pi}_{1}^{e}(Y)=0$ and $\underline{\pi}_{k}(Y)=\underline{0}$ for $k \leq 0$. For $k \geq 3$, the slice status of $Y$ and Definition 2.2 dictate that $\underline{\pi}_{k}(Y)=\underline{0}$. Consequently, the only nontrivial
homotopy Mackey functors of $Y$ and $\underline{\pi}_{1}(Y)=\underline{N}$ and $\underline{\pi}_{2}(Y)=\underline{M}$. Thus, we have a fiber sequence $\Sigma^{2} H \underline{M} \rightarrow Y \rightarrow \Sigma^{1} H \underline{N}$.
If either $\Sigma^{2} H \underline{M}$ or $\Sigma^{1} H \underline{N}$ is trivial, the result follows from above. So assume that both are nontrivial. Because $N_{e}=0, \Sigma^{1} H \underline{N}$ is a 2 -slice. In particular, $\Sigma^{1} H \underline{N} \leq 2$, and since $Y \leq 2$, we have that $\Sigma^{2} H \underline{M} \leq 2$. Consequently, as $\Sigma^{\overline{2}} H \underline{M} \geq 2$, we have that $\Sigma^{2} H \underline{M}$ is a 2 -slice.

From [GY], we will see the $C_{2}$-Mackey functors in Table 1.

Proposition 3.2 ([GY]). There are equivalences
(1) $\Sigma^{4} H_{C_{2}} \underline{\mathbb{Z}} \simeq \Sigma^{2 \rho} H_{C_{2}} \underline{\mathbb{Z}}^{*}$
(2) $\Sigma^{2} H_{C_{2}} \underline{f} \simeq \Sigma^{\rho} H_{C_{2}} \underline{\mathbb{F}}_{2}{ }^{*}$
(3) $\Sigma^{1} H_{C_{2}} \underline{g} \simeq \Sigma^{\rho} H_{C_{2}} \underline{g}$

Note, in particular, that Item 3 makes $\Sigma^{n} H_{C_{2}} \underline{g}$ a $2 n$-slice for any $n \in \mathbb{Z}$.

Proposition 3.3. For $k, r \geq 0$,

$$
\underline{\pi}_{i}\left(\sum^{k \sigma+r} H_{C_{2}} \underline{\mathbb{Z}}\right)= \begin{cases}\underline{\mathbb{Z}} & i=k+r, k \text { even } \\ \widehat{\widehat{f}} & i=k+r, k \text { odd } \\ \underline{g} & i \in[r, k+r-1], i \equiv r \quad(\bmod 2)\end{cases}
$$

Proof. We calculate $\underline{\pi}_{i}\left(\sum^{k \sigma} H_{C_{2}} \underline{\mathbb{Z}}\right)$ and then shift the degrees by $r$. The result follows by induction on $j \geq 1$ using the cofiber sequence

$$
\Sigma^{(j-1) \sigma+2} H \underline{\mathbb{Z}} \simeq \Sigma^{j \sigma} H \underline{\mathbb{Z}^{*}} \rightarrow \Sigma^{j \sigma} H \underline{\mathbb{Z}} \rightarrow \Sigma^{j \sigma} H \underline{g} \simeq H \underline{g} .
$$

### 3.1. Slices of $\Sigma^{ \pm n} H_{C_{2}} \underline{Z}$.

Because the slices for $\Sigma^{ \pm n} H_{K} \underline{\mathbb{Z}}$ over $K$ restrict to the corresponding slices over $C_{2}$, we must know these slices over $C_{2}$. They are as follows.

Proposition 3.4. $\Sigma^{n} H_{C_{2}} \underline{Z}$ is an $n$-slice for $0 \leq n \leq 6$.
Proof. For $0 \leq n \leq 2$, this follows from Proposition 2.4 and Proposition 3.1. By the same results, $\Sigma^{n} H \underline{\mathbb{Z}}^{*}$ is an $n$-slice for $0 \leq n \leq 2$. Furthermore, $\Sigma^{-1} H \mathbb{Z}^{*}$ is a ( -1 )-slice by Proposition 2.4. Then, by Proposition 3.1 and Proposition 2.5, $\Sigma^{n} H \underline{\mathbb{Z}} \simeq \Sigma^{n-4+2 \rho} H \underline{\mathbb{Z}}^{*}$ is a $n$-slice for $3 \leq n \leq 6$.

Proposition 3.5. Let $n \geq 7$ and take $r \equiv n(\bmod 4)$ with $3 \leq r \leq 6$. The slice tower of $\Sigma^{n} H_{C_{2}} \underline{Z}$ is


Proof. The exact sequence $\underline{\mathbb{Z}}^{*} \rightarrow \underline{\mathbb{Z}} \rightarrow \underline{g}$ and the homotopy equivalence $\Sigma^{n} H \underline{\mathbb{Z}} \simeq \Sigma^{n-4+2 \rho} H \underline{\mathbb{Z}}^{*}$ provide the fiber sequence

$$
\Sigma^{n-3} H \underline{g} \rightarrow \Sigma^{n} H \underline{\mathbb{Z}} \rightarrow \Sigma^{2 \rho+(n-4)} H \underline{\mathbb{Z}}
$$

We then augment this sequence with its appropriate $2 \rho$ suspensions until $\sum^{\frac{n-r}{2} \rho+r} H \underline{Z}$, a slice, is reached.

Corollary 3.6. Let $n \geq 7$ and take $r \equiv n(\bmod 4)$ with $3 \leq r \leq 6$. The (2k)-slices of $\Sigma^{n} H_{C_{2}} \underline{Z}$ are

$$
P_{2 k}^{2 k}\left(\Sigma^{n} H_{C_{2}} \underline{\mathbb{Z}}\right) \simeq \Sigma^{k} H_{C_{2}} \underline{g}
$$

for $k \equiv n+1(\bmod 2)$ and $k \in\left[\frac{n+r}{2}-1, \ldots, n-3\right]$.
Proposition 3.7. Let $n \geq 1$ and take $r \equiv n(\bmod 4)$ with $1 \leq r \leq 4$. The slice cotower of $\Sigma^{-n} H_{C_{2}} \underline{Z}$ is


Proof. The exact sequence $\underline{\mathbb{Z}}^{*} \rightarrow \underline{\mathbb{Z}} \rightarrow \underline{g}$ and the homotopy equivalence $\Sigma^{-n} H \underline{Z} \simeq \Sigma^{2 \rho-n-4} H \underline{\mathbb{Z}}$ provide the cofiber sequence

$$
\Sigma^{-2 \rho-n+4} H \underline{\mathbb{Z}} \rightarrow \Sigma^{-n} H \underline{\mathbb{Z}} \rightarrow \Sigma^{-n} H \underline{g} .
$$

We then augment this sequence with its appropriate $-2 \rho$ suspensions until $\Sigma^{-\frac{n-r}{2} \rho-r} H \underline{Z}$, a slice, is reached.

Corollary 3.8. Let $n \geq 1$ and take $r \equiv n(\bmod 4)$ with $1 \leq r \leq 4$. The ( $-2 k$ )-slices of $\Sigma^{-n} H_{C_{2}} \underline{Z}$ are

$$
P_{-2 k}^{-2 k}\left(\Sigma^{-n} H_{C_{2}} \underline{\mathbb{Z}}\right) \simeq \Sigma^{-k} H_{C_{2}} \underline{\underline{g}}
$$

for $k \equiv n(\bmod 2)$ and $k \in\left[\frac{n+r}{2}, n\right]$.

## 4. $K$-Mackey Functors

Recall that $K=C_{2} \times C_{2}$ and let $L, D$, and $R$ be the left, diagonal, and right subgroups of $K$, respectively. The Lewis diagram for a $K$-Mackey functor takes the form

with a Weyl group action $W_{G}(H) \circlearrowright M_{H}$ at each level. If we do not indicate the Weyl group actions for a specific Mackey functor, then they are trivial.

A number of Mackey functors from [GY] will make their appearance.

We will also see the duals of the Mackey functors in Table 2.

Proposition 4.1. ([GY, Proposition 4.8]) There are equivalences

$$

\Sigma^{-\rho} H_{K} \underline{m} & \simeq \Sigma^{-2} H_{K} \underline{m g} g^{*}  \tag{1}\\
\Sigma^{-2} H_{K} \underline{m}^{*} & \simeq \Sigma^{-\rho} H_{K} \underline{m g} \tag{2}
\end{align*}
$$

We will also see the new Mackey functors in Table 3.

In Table 3, $\underline{\mathbb{Z}}^{*}$ is the dual to the constant Mackey functor $\underline{\mathbb{Z}}$ and $\underline{\mathbb{Z}}(2,1)^{*}$ is the dual to $\mathbb{Z}(2,1)$, so named for consistency with [Y]. The Mackey functor $\mathbb{M}$ results from the injection $\underline{\mathbb{Z}}^{*} \hookrightarrow \underline{\mathbb{Z}} \rightarrow \mathbb{\mathbb { M }}$. In each Mackey functor, the blue arrows are multiplication by one and the orange arrows are multiplication by two.

Proposition 4.2. We have the equivalence

$$
\Sigma^{-\rho} H_{K} \underline{\mathbb{Z}} \simeq \Sigma^{-4} H_{K} \underline{\mathbb{Z}}^{*} .
$$

Proof. This follows from Proposition 5.4.

### 4.1. Induced Mackey Functors.

We will now give an explicit description of $K$-Mackey functors induced from the cyclic subgroups.
We recall the following standard result.
Lemma 4.3 (Shearing isomorphism). Let $M$ be a $\mathbb{Z}[G]$-module and $H$ a subgroup of $G$. Then we have an isomorphism of $\mathbb{Z}[G]$-modules,

where $G$ acts on the left of $\mathbb{Z}[G]$ and diagonally on $\mathbb{Z}[G / H] \otimes M$ via the map $g \otimes m \mapsto g H \otimes g \cdot m$.

Let $\underline{N}$ be a $C_{2}$-Mackey functor. Take $h \in K$ and set $\Delta_{h}: N_{e} \rightarrow \mathbb{Z}[K] \otimes_{\mathbb{Z}[L]}$ $N_{e}$ and $\nabla_{h}: \mathbb{Z}[K] \otimes_{\mathbb{Z}[L]} N_{e} \rightarrow N_{e}$ to be $n \mapsto(e+h) \otimes n$ and $e \otimes n, h \otimes n \mapsto n$, respectively.
Then $\uparrow_{L}^{K} \underline{N}$ is


The Weyl group $W_{K}(D)$ acts on $\uparrow_{L}^{K} \underline{N}(D)=N_{e}$ via the isomorphism $W_{K}(D) \cong C_{2}$ and the given action of $\bar{C}_{2}=W_{C_{2}}(e)$ on $N_{e}$. Similarly for the action of $W_{K}(R)$ on $N_{e}$. As for $L, W_{K}(L)$ acts only on $\mathbb{Z}[K / L]$. Finally, $W_{K}(e)=K$ acts on the $\mathbb{Z}[K]$ factor of $\mathbb{Z}[K] \otimes_{\mathbb{Z}[L]} N_{e}$.
We are now going to define the unit $\operatorname{map} \underline{M} \rightarrow \uparrow_{L}^{K} \downarrow_{L}^{K} \underline{M}$. The pullback along $K \rightarrow K / L \cong C_{2}$ of $\mathbb{Z} \hookrightarrow \mathbb{Z}\left[C_{2}\right]$ is an inclusion $\mathbb{Z} \hookrightarrow \mathbb{Z}[K / L]$. Tensoring with $M_{e}$ gives

$$
M_{e} \stackrel{i_{L}}{\longrightarrow} \mathbb{Z}[K / L] \otimes M_{e} .
$$

We will also use $i_{L}$ to denote the inclusion of $K / L$ fixed points

$$
M_{L} \stackrel{i_{L}}{\longrightarrow} \mathbb{Z}[K / L] \otimes M_{L} .
$$

Consider

$$
\nabla^{r}: \mathbb{Z}[K / L] \otimes M_{e} \rightarrow M_{e} \quad \text { and } \quad \Delta^{r}: M_{e} \rightarrow \mathbb{Z}[K / L] \otimes M_{e} .
$$

Let $\nabla^{r}$ be the action map and define $\Delta^{r}$ by $m \mapsto e \otimes m+r \otimes r \cdot m$. Then, for $\underline{M} \in \operatorname{Mack}(K)$, the map $\underline{M} \rightarrow \uparrow_{L}^{K} \downarrow_{L}^{K} \underline{M}$ is


Again, $W_{K}(D)$ acts on $M_{e}$ via the $C_{2}$-action $W_{C_{2}}(e) \circlearrowright M_{e}$. The same applies for $W_{K}(R) \circlearrowright M_{e}$. Note we have used Lemma 4.3 to rewrite the bottom group in $\uparrow_{L}^{K} \downarrow_{L}^{K} \underline{M}$. We now have a diagonal action $K / L$ on $\mathbb{Z}[K / L] \otimes M_{L}$. Similarly, $K / e$ acts diagonally on $\mathbb{Z}[K / L] \otimes M_{e}$.

Example 4.4. For $\underline{M}=\underline{\mathbb{Z}}, \uparrow_{L}^{K} \underline{\mathbb{Z}}$ and $\underline{\mathbb{Z}} \rightarrow \uparrow_{L}^{K} \underline{\mathbb{Z}}$ are as follows.


Again, blue denotes multiplication by one and orange multiplication by two.

## 5. 2-SLice Characterization

Consider a $K$-spectrum $X$. Then by Proposition 2.5,

$$
P_{n}^{n} X \simeq \Sigma^{\frac{n-r}{4} \rho} P_{r}^{r}\left(\Sigma^{-\frac{n-r}{4} \rho} X\right)
$$

where $n \equiv r(\bmod 4)$ and $0 \leq r \leq 3$. Thus, to know the slices of $X$, we need only know the $0-, 1-, 2$-, and 3 -slices of certain suspensions of $X$. Proposition 2.4 and Proposition 2.5 characterize the 0 -, 1 -, and 3 -slices. We now characterize the 2 -slices.

Proposition 5.1. Let $G$ be a finite group, $H$ an index two subgroup of $G$, and $\sigma^{H}$ the sign representation from $G \rightarrow G / H$. For a $G$-spectrum $X$, if $\downarrow_{H}^{G} \underline{\pi}_{n+1}(X)=\underline{0}=\downarrow_{H}^{G} \underline{\pi}_{n}(X)$, the natural map $\Sigma^{-\sigma^{H}} X \rightarrow X$ induces an isomorphism on $\underline{\pi}_{n}$. In particular, if $\pi_{n+1}^{H}(X)=0=\pi_{n}^{G}(X)$, then $\pi_{n}^{G}\left(\Sigma^{-\sigma^{H}} X\right)=0$.

Proof. Because $\sigma^{H}$ is one-dimensional we may construct $\Sigma^{-\sigma^{H}} X$ with the cofiber sequence $\left(S^{-\sigma^{H}} \rightarrow S^{0} \rightarrow G / H_{+}\right) \wedge X$. The resulting long exact sequence in homotopy is

$$
\begin{equation*}
\uparrow_{H}^{G} \downarrow_{H}^{G} \underline{\pi}_{n+1}(X) \rightarrow \underline{\pi}_{n}\left(\Sigma^{-\sigma^{H}} X\right) \rightarrow \underline{\pi}_{n}(X) \rightarrow \uparrow_{H}^{G} \downarrow_{H}^{G} \underline{\pi}_{n}(X) . \tag{3}
\end{equation*}
$$

As $\uparrow_{H}^{G} \downarrow_{H}^{G} \underline{\pi}_{n+1}(X)=\underline{0}=\uparrow_{H}^{G} \downarrow_{H}^{G} \underline{\pi}_{n}(X)$, we find that $\underline{\pi}_{n}\left(\Sigma^{-\sigma^{H}} X\right) \cong \underline{\pi}_{n}(X)$.
Now suppose that $\pi_{n+1}^{H}(X)=0=\pi_{n}^{G}(X)$. Because $\pi_{n+1}^{H}(X)$ is the value of $\uparrow_{H}^{G} \downarrow_{H}^{G} \underline{\pi}_{n+1}(X)$ at the orbit $G / H$, the left three terms of (3) prove the exact sequence

$$
0 \rightarrow \pi_{n}^{G}\left(\Sigma^{-\sigma^{H}} X\right) \rightarrow 0
$$

Consequently, $\pi_{n}^{G}\left(\Sigma^{-\sigma^{H}} X\right)=0$.

Corollary 5.2. Let $H \underline{M}$ be an Eilenberg-MacLane $G$-spectrum and $V \cong \mathbf{s} \oplus \bigoplus_{i=1}^{r} \sigma^{H_{i}}$ be a real representation with $s$ copies of the trivial representation and each $\sigma^{H_{i}}$ the sign representation from $G \rightarrow G / H_{i}$, where $H_{i}$ is an index two subgroup of $G$. Then $\Sigma^{-V} H \underline{M}$ does not have nontrivial homotopy above degree $-s$.

Proof. First apply (3) to $X_{1}:=\Sigma^{-\sigma^{H_{1}}} H \underline{M}$ with $n \geq 1$. Then repeat for $X_{i}:=\Sigma^{-\sigma^{H_{i}}} X_{i-1}$ where $2 \leq i \leq r$. Then $\Sigma^{-V} H \underline{M} \simeq \Sigma^{-s} X_{r}$ has no homotopy above degree $-s$.

Recall from Section 2.3 that $\alpha, \beta$, and $\gamma$ are the sign representations of $K$.

Lemma 5.3. Let $\underline{M}$ be a $K$-Mackey functor. The nontrivial homotopy of $\Sigma^{-\beta} H \underline{M}$ is

Here, $\varphi_{r}^{K L}$ is induced by $\Delta^{r}$ in the square

and is given by $\varphi_{r}^{K L}(m)=m-r \cdot m$. The maps $\varphi_{r}^{D e}: M_{e} / \operatorname{im} \mathbf{r}_{e}^{D} \rightarrow \mathbb{Z}_{\sigma}^{L} \otimes M_{e}$ and $\varphi_{r}^{R e}: M_{e} / \mathrm{im} \mathbf{r}_{e}^{R} \rightarrow \mathbb{Z}_{\sigma}^{L} \otimes M_{e}$ are defined similarly.

Proof. We have the cofiber sequence $\left(S^{-\beta} \rightarrow S^{0} \rightarrow K / L_{+}\right) \wedge H \underline{M}$. The result then follows from the description of the map $\underline{M} \rightarrow \uparrow_{L}^{K} \downarrow_{L}^{K} \underline{M}$ given in Section 4.1.

Proposition 5.4. Let $\underline{M}$ be a $K$-Mackey functor. The nontrivial homotopy of $\Sigma^{-\alpha-\beta-\gamma} H \underline{M}$ is


where $E_{1}, E_{2}$, and $E_{3}$ are extensions

$$
\begin{gathered}
M_{e} / \operatorname{im} \varphi_{r}^{D e} \longrightarrow E_{3} \longrightarrow\left(M_{e} / \mathrm{im} \mathbf{r}_{e}^{R}\right) / \mathrm{im} \mathbf{r}_{e}^{L} \\
\operatorname{ker}_{e}^{D} \longrightarrow E_{1} \longrightarrow E_{1} \longrightarrow M_{L} \longrightarrow \mathrm{im} \mathbf{r}_{L}^{K}
\end{gathered}
$$

Let $\varphi_{h}^{*}: \overline{M_{e}} \rightarrow \overline{M_{e}}$ be one of the maps shown. Then $\varphi_{h}^{*}(m)=m-h \cdot m$. Additionally, $\left(M_{e} / \operatorname{im} \varphi_{r}^{D e}\right) / \mathrm{im} \varphi_{r}^{R, L}$ is the cokernel of the map

$$
\left(M_{e} / \mathrm{im} \mathbf{r}_{e}^{R}\right) / \mathrm{im} \mathbf{r}_{e}^{L} \xrightarrow{\varphi_{r}^{R, L}} M_{e} / \operatorname{im} \varphi_{r}^{D e} .
$$

Proof. Lemma 5.3 supplies the homotopy for $\Sigma^{-\beta} H \underline{M}$. We continue constructing $\Sigma^{-\alpha-\beta-\gamma} H \underline{M}$ iteratively. The cofiber sequence

$$
\left(S^{-\alpha} \rightarrow S^{0} \rightarrow K / R_{+}\right) \wedge \Sigma^{-\beta} H \underline{M}
$$

results in the homotopy of $\Sigma^{-\alpha-\beta} H \underline{M}$



Finally, the cofiber sequence $\left(S^{-\gamma} \rightarrow S^{0} \rightarrow K / D_{+}\right) \wedge \Sigma^{-\alpha-\beta} H \underline{M}$ provides the result.

Lemma 5.5. Let $\phi: G \rightarrow N$ and $\psi: G \rightarrow M$ be group homomorphisms. Then

$$
\operatorname{ker}(\phi, \psi)=\operatorname{ker}(\phi) \cap \operatorname{ker}(\psi)=\operatorname{ker}\left(\left.\phi\right|_{\operatorname{ker}(\psi)}\right)
$$

where $(\phi, \psi): G \rightarrow N \oplus M$ is defined by $g \mapsto \phi(g) \oplus \psi(g)$.
Proposition 5.6. Let $\underline{M}$ be a $K$ Mackey functor where the restrictions $\mathbf{r}_{e}^{L}, \mathbf{r}_{e}^{D}$, and $\mathbf{r}_{e}^{R}$ are injective. The following are equivalent.
(A) The sequence

$$
M_{K} \xrightarrow{\mathbf{r}_{L}^{K}+\mathbf{r}_{D}^{K}+\mathbf{r}_{R}^{K}} M_{L} \oplus M_{D} \oplus M_{R} \xrightarrow{\left(\begin{array}{ccc}
-\mathbf{r}_{e}^{L} & \mathbf{r}_{e}^{L} & 0 \\
\mathbf{r}_{e}^{D} & 0 & -\mathbf{r}_{e}^{D} \\
0 & -\mathbf{r}_{e}^{R} & \mathbf{r}_{e}^{R}
\end{array}\right)} M_{e}^{3}
$$

is exact.
(B) $\operatorname{im} \mathbf{r}_{H_{1}}^{K}=\left(\mathbf{r}_{e}^{H_{1}}\right)^{-1}\left(\operatorname{im} \mathbf{r}_{e}^{H_{2}}\right) \cap\left(\mathbf{r}_{e}^{H_{1}}\right)^{-1}\left(\mathrm{im} \mathbf{r}_{e}^{H_{3}}\right)$ where $H_{1}, H_{2}, H_{3}$ are distinct order two subgroups of $K$. This equality is represented by the diagram below.


Proof. Without loss of generality, let $H_{1}=L, H_{2}=D$, and $H_{3}=R$. For convenience, set $I=\left(\mathbf{r}_{e}^{L}\right)^{-1}\left(\mathrm{im} \mathbf{r}_{e}^{D}\right) \cap\left(\mathbf{r}_{e}^{L}\right)^{-1}\left(\mathrm{im} \mathbf{r}_{e}^{R}\right)$.
Item (A) $\Rightarrow$ Item (B):
Let $x \in \operatorname{im} \mathbf{r}_{L}^{K}$. Then we have $k \in M_{K}$ such that $\mathbf{r}_{L}^{K}(k)=x$. Additionally, $\mathbf{r}_{e}^{L}(x)=\mathbf{r}_{e}^{D} \mathbf{r}_{D}^{K}(k)=\mathbf{r}_{e}^{R} \mathbf{r}_{R}^{K}(k)$. It follows that $x \in I$.

Now suppose $x \in I$. We then have $y \in D$ and $z \in R$ such that

$$
\mathbf{r}_{e}^{L}(x)=\mathbf{r}_{e}^{D}(y)=\mathbf{r}_{e}^{R}(z)
$$

Thus, $(x, y, z) \in \operatorname{ker}\left(\begin{array}{ccc}-\mathbf{r}_{e}^{L} & \mathbf{r}_{e}^{L} & 0 \\ \mathbf{r}_{e}^{D} & 0 & -\mathbf{r}_{e}^{D} \\ 0 & -\mathbf{r}_{e}^{R} & \mathbf{r}_{e}^{R}\end{array}\right)$. Consequently, we have $x=\mathbf{r}_{L}^{K}(k)$ for some $k \in M_{K}$; that is, $x \in \operatorname{im} \mathbf{r}_{L}^{K}$.
Item (B) $\Rightarrow \operatorname{Item}(\mathrm{A}):$
Let $(x, y, z) \in \operatorname{ker}\left(\begin{array}{ccc}-\mathbf{r}_{e}^{L} & \mathbf{r}_{e}^{L} & 0 \\ \mathbf{r}_{e}^{D} & 0 & -\mathbf{r}_{e}^{D} \\ 0 & -\mathbf{r}_{e}^{R} & \mathbf{r}_{e}^{R}\end{array}\right)$. Then $\mathbf{r}_{e}^{L}(x)=\mathbf{r}_{e}^{D}(y)=\mathbf{r}_{e}^{R}(z)$, so $x \in \operatorname{im} \mathbf{r}_{L}^{K}$.
So there is some $k \in M_{K}$ such that $x=\mathbf{r}_{L}^{K}(k)$. Because $\mathbf{r}_{e}^{D}$ and $\mathbf{r}_{e}^{R}$ are injective, it must be that $y=\left(\mathbf{r}_{e}^{D}\right)^{-1}\left(\mathbf{r}_{e}^{L}(x)\right)$ and $z=\left(\mathbf{r}_{e}^{R}\right)^{-1}\left(\mathbf{r}_{e}^{L}(x)\right)$. Hence, Item (A) is exact.

Proposition 5.7. The $K$-spectrum $\Sigma^{1} H \underline{N}$ is a 2 -slice if and only if $N_{e}=0$ and $N_{K} \rightarrow N_{L} \oplus N_{D} \oplus N_{R}$ is injective.

Proof. By Theorem 2.3, we find that $\Sigma^{1} H \underline{N} \geq 2$ if and only if $N_{e}=0$. Consequently, going forward we may assume $N_{e}=0$.
Now $\Sigma^{1} H \underline{N} \leq 2$ if and only if $\left[S^{k \rho_{H}+r}, \Sigma^{2} H \underline{N}\right]^{H}=0$ for all $k \geq \frac{3}{|H|}$ and $r \geq 0$. Because $N_{e}=0$, Proposition 3.1 implies that $i_{H}^{*}\left(\Sigma^{1} H \underline{N}\right)$ is a 2 -slice, where $H$ is an order two subgroup of $K$. Thus, to finish the equivalence, we only need consider

$$
\left[S^{k \rho_{K}+r}, \Sigma^{1} H \underline{N}\right]^{K}=\left[S^{k+r-1}, \Sigma^{-k \bar{\rho}_{K}} H \underline{N}\right]^{K}
$$

for all $k \geq 1$ and $r \geq 0$.
From Corollary 5.2, we need only concern ourselves with $\left[S^{0}, \Sigma^{-k \bar{\rho}_{K}} H \underline{N}\right]$. From Proposition 5.4,

$$
\underline{\pi}_{0}\left(\Sigma^{-\bar{\rho}} H \underline{N}\right)=\phi_{K}^{*}\left(\operatorname{ker} \mathbf{r}_{L}^{K} \cap \operatorname{ker} \mathbf{r}_{D}^{K} \cap \operatorname{ker} \mathbf{r}_{R}^{K}\right) .
$$

Therefore Proposition 5.1 shows that $\underline{\pi}_{0}\left(\Sigma^{-\bar{\rho}} H \underline{N}\right)$ vanishes if and only if $\underline{\pi}_{0}\left(\Sigma^{-k \bar{\rho}} H \underline{N}\right)$ vanishes for all $k \geq 1$. Hence, $\Sigma^{1} H \underline{N} \leq 2$ if and only if $\operatorname{ker} \mathbf{r}_{L}^{K} \cap \operatorname{ker} \mathbf{r}_{D}^{K} \cap \operatorname{ker} \mathbf{r}_{R}^{K}=\{0\}$. By Lemma 5.5 this is equivalent to $N_{K} \rightarrow N_{L} \oplus N_{D} \oplus N_{R}$ being injective.

Proposition 5.8. The spectrum $\Sigma^{2} H \underline{M}$ is a 2 -slice if and only if all restrictions of $\underline{M}$ are injective and the sequence

$$
M_{K} \xrightarrow{\mathbf{r}_{L}^{K}+\mathbf{r}_{D}^{K}+\mathbf{r}_{R}^{K}} M_{L} \oplus M_{D} \oplus M_{R} \xrightarrow{\left(\begin{array}{ccc}
-\mathbf{r}_{e}^{L} & \mathbf{r}_{e}^{L} & 0 \\
\mathbf{r}_{e}^{D} & 0 & -\mathbf{r}_{e}^{D} \\
0 & -\mathbf{r}_{e}^{R} & \mathbf{r}_{e}^{R}
\end{array}\right)} M_{e}^{3}
$$

is exact.
Proof. Note that $\Sigma^{2} H \underline{M} \geq 2$, so we just need to show that $\Sigma^{2} H \underline{M} \leq 2$. Now $\Sigma^{2} H \underline{M} \leq 2$ if and only if $\left[S^{k \rho_{H}+r}, \Sigma^{2} H \underline{M}\right]^{H}=0$ for all $k \geq \frac{\overline{3}}{|H|}$ and $r \geq 0$. For $H$ an order two subgroup of $K, i_{H}^{*} \Sigma^{2} H \underline{M} \leq 2$ if and only if $\mathbf{r}_{e}^{H}$ is injective. Consequently, going forward we may assume $\mathbf{r}_{e}^{L}, \mathbf{r}_{e}^{D}$, and $\mathbf{r}_{e}^{R}$ are injective.
To finish the equivalence, we only need consider

$$
\left[S^{k \rho_{K}+r}, \Sigma^{2} H \underline{M}\right]^{K}=\left[S^{k+r-2}, \Sigma^{-k \bar{\rho}_{K}} H \underline{M}\right]^{K}
$$

for all $k \geq 1$ and $r \geq 0$. By Corollary 5.2, it is enough to examine [ $S^{0}, \Sigma^{-k \bar{\rho}_{K}} H \underline{M}$ ] and $\left[S^{-1}, \Sigma^{-k \bar{\rho}_{K}} H \underline{M}\right]$. From Proposition 5.4,

$$
\underline{\pi}_{0}\left(\Sigma^{-\bar{\rho}} H \underline{M}\right)=\phi_{K}^{*}\left(\operatorname{ker} \mathbf{r}_{L}^{K}\right)
$$

and

$$
\underline{\pi}_{-1}\left(\Sigma^{-\bar{\rho}} H \underline{M}\right)=\phi_{K}^{*}\left(\frac{\left(\mathbf{r}_{e}^{L}\right)^{-1}\left(\mathrm{im} \mathbf{r}_{e}^{D}\right) \cap\left(\mathbf{r}_{e}^{L}\right)^{-1}\left(\mathrm{im} \mathbf{r}_{e}^{R}\right)}{\operatorname{im} \mathbf{r}_{L}^{K}}\right) .
$$

Note that Proposition 5.4 states

$$
\underline{\pi}_{0}\left(\Sigma^{-\bar{\rho}} H \underline{M}\right)=\phi_{K}^{*}\left(\operatorname{ker} \mathbf{r}_{L}^{K} \cap \operatorname{ker} \mathbf{r}_{D}^{K} \cap \operatorname{ker} \mathbf{r}_{R}^{K}\right),
$$

but because the lower restrictions are injective, these kernels coincide. Proposition 5.1 then yields that

$$
\begin{aligned}
& \underline{\pi}_{0}^{G}\left(\Sigma^{-k \bar{\rho}} H \underline{M}\right) \cong \underline{\pi}_{0}^{G}\left(\Sigma^{-\bar{\rho}} H \underline{M}\right)=\operatorname{ker} \mathbf{r}_{L}^{K} \\
& \underline{\pi}_{-1}^{G}\left(\Sigma^{-k \bar{\rho}} H \underline{M}\right) \cong \underline{\pi}_{-1}^{G}\left(\Sigma^{-\bar{\rho}} H \underline{M}\right)=\frac{\left(\mathbf{r}_{e}^{L}\right)^{-1}\left(\operatorname{im} \mathbf{r}_{e}^{D}\right) \cap\left(\mathbf{r}_{e}^{L}\right)^{-1}\left(\operatorname{im} \mathbf{r}_{e}^{R}\right)}{\operatorname{im~} \mathbf{r}_{L}^{K}}
\end{aligned}
$$

for all $k \geq 2$. By Definition 2.2, we find that $\Sigma^{2} H \underline{M} \leq 2$ if and only if these two homotopy groups vanish. Hence, $\Sigma^{2} H \underline{M} \leq 2$ if and only if $\operatorname{ker} \mathbf{r}_{L}^{K}=\{0\}$ and $\operatorname{im} \mathbf{r}_{L}^{K}=\left(\mathbf{r}_{e}^{L}\right)^{-1}\left(\operatorname{im} \mathbf{r}_{e}^{D}\right) \cap\left(\mathbf{r}_{e}^{L}\right)^{-1}\left(\mathrm{im} \mathbf{r}_{e}^{R}\right)$. Because the homotopy of $\Sigma^{-\alpha-\beta-\gamma} H \underline{M}$ is invariant under the order of construction - that is, whether $H \underline{M}$ is suspended by say $-\alpha$ or $-\beta$ first - we find that all upper restrictions must be injective and that Item (B) must hold.

Theorem 5.9. Suppose the only nontrivial homotopy Mackey functors of a $K$-spectrum $X$ are $\underline{\pi}_{1}(X)$ and $\underline{\pi}_{2}(X)$ where
(1) All restrictions of $\underline{\pi}_{2}(X)$ are injective and the sequence

$$
\pi_{2}^{K}(X) \xrightarrow{\mathbf{r}_{L}^{K}+\mathbf{r}_{D}^{K}+\mathbf{r}_{R}^{K}} \pi_{2}^{L}(X) \oplus \pi_{2}^{D}(X) \oplus \pi_{2}^{R}(X) \xrightarrow{\left(\begin{array}{ccc}
-\mathbf{r}_{e}^{L} & \mathbf{r}_{e}^{L} & 0 \\
\mathbf{r}_{e}^{D} & 0 & -\mathbf{r}_{e}^{D} \\
0 & -\mathbf{r}_{e}^{R} & \mathbf{r}_{e}^{R}
\end{array}\right)} \pi_{2}^{e}(X)^{3}
$$

is exact.
(2) $\pi_{1}^{e}(X)=0$.
(3) $\pi_{1}^{K}(X) \rightarrow \pi_{1}^{L}(X) \oplus \pi_{1}^{D}(X) \oplus \pi_{1}^{R}(X)$ is injective.

Then $X$ is a 2 -slice.
Conversely, if a $K$-spectrum $X$ is a 2 -slice, then its only nontrivial homotopy Mackey functors of a $K$-spectrum $X$ are $\underline{\pi}_{1}(X)$ and $\underline{\pi}_{2}(X)$ where $\Sigma^{2} H \underline{\pi}_{2}(X)$ is a 2 -slice and $\Sigma^{1} H \underline{\pi}_{1}(X) \in[2,4]$, i.e., both Item 1 and Item 2 hold.

Proof. Let $\underline{\pi}_{2}(X)=\underline{M}$ and $\underline{\pi}_{1}(X)=\underline{N}$. If these are the only nontrivial homotopy Mackey functors of $X$, we have a fiber sequence

$$
\begin{equation*}
\Sigma^{2} H \underline{M} \rightarrow X \rightarrow \Sigma^{1} H \underline{N} . \tag{4}
\end{equation*}
$$

By Proposition 5.7 and Proposition 5.8, conditions (1) - (3) show that $\Sigma^{2} H \underline{M}$ and $\Sigma^{1} H \underline{N}$ are 2 -slices. Now if $\Sigma^{2} H \underline{M}$ and $\Sigma^{1} H \underline{N}$ are 2 -slices, then $X$ must be a 2 -slice as well.
Conversely, suppose that $X$ is a 2 -slice. We then find that $X$ has no homotopy above degree two and none below degree one; thus, we have the fiber sequence in (4). Because $X \geq 2$ and $\Sigma^{2} H \underline{M} \geq 2$, it follows that $\Sigma^{1} H \underline{N} \geq 2$. So by Theorem 2.3, $N_{e}=0$. That $\Sigma^{1} H \underline{N} \leq 4$ follows from a similar argument as in Proposition 5.7.
Rotating this fiber sequence gives $H \underline{N} \rightarrow \Sigma^{2} H \underline{M} \rightarrow X$. As $H \underline{N}$ is a 0 -slice and $X$ is a 2 -slice, we have $\Sigma^{2} H \underline{M} \in[0, \overline{2]}$, so it must be that $\Sigma^{2} H \underline{M}=2$. Consequently, by Proposition 5.8, Item 1 holds.

It is not necessary for condition (3) to hold for $X$ to be a 2 -slice as we show in the following example.

Example 5.10. Take $X \simeq \Sigma^{1+\beta} H \underline{E}$ where


Then $X$ is a 2 -slice with $\underline{\pi}_{2}(X)=\underline{f}$ and $\underline{\pi}_{1}(X)=\underline{g}$. But $\Sigma^{1} H \underline{g}$ is not a 2 -slice.

Proof. We can construct $\Sigma^{1+\beta} H \underline{E}$ using the cofiber sequence

$$
\left(K / L_{+} \rightarrow S^{0} \rightarrow S^{\beta}\right) \wedge \Sigma^{1} H \underline{E}
$$

The resulting long exact sequence in homotopy is


So $\underline{\pi}_{2}(X)=\underline{f}$ and $\underline{\pi}_{1}(X)=\underline{g}$. From this we see that $X \geq 2$ by Theorem 5.9. Note that $\Sigma^{2} H \underline{f}$ is a 2 -slice and $\Sigma^{1} H \underline{g}$ is a 4 -slice.
To show that $X \leq 2$, we need $\left[S^{k \rho_{H}+r}, \Sigma^{1+\beta} H \underline{E}\right]^{H}=0$ for all $k \geq \frac{3}{|H|}$ and $r \geq 0$. As $i_{H}^{*}(X) \simeq \Sigma^{2} H_{C_{2}} \underline{f}$ is a 2 -slice, where $H$ is an order two subgroup of $K$, we only need to consider

$$
\left[S^{k \rho_{K}+r}, \Sigma^{1+\beta} H \underline{E}\right]^{K}=\left[S^{k+r-1}, \Sigma^{-\alpha-\gamma-(k-1) \bar{\rho}_{K}} H \underline{E}\right]^{K}
$$

for all $k \geq 1$ and $r \geq 0$.
By Corollary 5.2, it is sufficient to examine $\left[S^{0}, \Sigma^{-\alpha-\gamma-(k-1) \bar{\rho}_{K}} H \underline{E}\right]^{K}$ for all $k \geq 1$.

From Lemma 5.3 we find that $\left[S^{0}, \Sigma^{-\alpha-\gamma} H \underline{E}\right]=\underline{0}$. Consequently, given any $k \geq 1$, repeated application of Proposition 5.1 shows that

$$
\left[S^{0}, \Sigma^{-\alpha-\gamma-(k-1) \bar{\rho}_{K}} H \underline{E}\right]=\underline{0} .
$$

That is, $X$ is a 2 -slice.

## 6. Cotowers for $\Sigma^{-n} H \underline{Z}$

We determine the slice towers of $\Sigma^{-n} H \underline{\mathbb{Z}}$ and $\Sigma^{-n} H \underline{m}^{*}$ for $1 \leq n \leq 5$.
Example 6.1. By Proposition 2.4 and Proposition 4.1, $\Sigma^{-1} H \underline{m}^{*}$ is a (-2)-slice and $\Sigma^{-2} H \underline{m}^{*}$ is a ( -4 )-slice.
Alternatively, by Proposition 4.1, $\Sigma^{\rho} \Sigma^{-1} H \underline{m}^{*} \simeq \Sigma^{1} H m g$, which is a 2 slice by Proposition 5.7. Consequently, $\Sigma^{-1} H \underline{m}^{*}$ is a $\overline{(-2)}$-slice.

Example 6.2. By [U1, Theorem 6-4], the cotower for $\Sigma^{-1} H \underline{Z}$ is


Example 6.3. We suspend the cotower in Example 6.2 by -1 to get the cotower for $\Sigma^{-2} H \underline{\mathbb{Z}}$.


Example 6.4. We suspend the cotower in Example 6.3 by -1 to get a partial cotower for $\Sigma^{-3} H \underline{Z}$.


The issue here is that $\Sigma^{-3} H \underline{m}^{*}$ is not a slice.
However, the short exact sequence

$$
\underline{g}^{2} \rightarrow \phi_{L D R}^{*}\left({\underline{\mathbb{F}_{2}}}^{*}\right) \rightarrow \underline{m}^{*}
$$

provides the tower

$$
P_{-6}^{-6}=\Sigma^{-3} H \phi_{L D R}^{*}\left({\underline{F_{2}}}^{*}\right) \rightarrow \Sigma^{-3} H \underline{m}^{*} \rightarrow \Sigma^{-2} H \underline{g}^{2}=P_{-8}^{-8}
$$

Consequently, the remaining slices of $\Sigma^{-3} H \underline{\mathbb{Z}}$ are $P_{-6}^{-6}=\Sigma^{-2 p+1} H \phi_{L D R}^{*}\left(\underline{\mathbb{F}_{2}}\right)$ and $P_{-8}^{-8}=\Sigma^{-2} H \underline{g}^{2}$.

Example 6.5. We suspend the cotower in Example 6.4 by -1 to get a partial cotower for $\Sigma^{-4} H \underline{Z}$.


Again, $\Sigma^{-4} H \underline{m}^{*}$ is not a slice. But suspending the cotower for $\Sigma^{-3} H \underline{m}^{*}$ by -1 provides the missing slices: $P_{-8}^{-8}=\Sigma^{-4} H \phi_{L D R}^{*}\left(\underline{\mathbb{F}}_{2}{ }^{*}\right)$ and $P_{-12}^{-12}=$ $\Sigma^{-3} H \underline{g}^{2}$.

Example 6.6. We suspend the cotower in Example 6.5 by -1 and augment with the $-\rho$ suspension of Example 6.2 to get a partial cotower
for $\Sigma^{-5} H \underline{Z}$.


This time, the cotower for $\Sigma^{-5} H \underline{m}^{*}$ is


The remaining slices of $\Sigma^{-5} H \underline{\mathbb{Z}}$ are then $P_{-10}^{-10}=\Sigma^{-3 \rho+1} H \phi_{L D R}^{*}\left(\underline{\mathbb{F}_{2}}\right)$, $P_{-12}^{-12}=\Sigma^{-3} H \underline{g}^{3}$, and $P_{-16}^{-16}=\Sigma^{-4} H \underline{g}^{2}$.

Example 6.7. The partial cotower for $\Sigma^{-7} H \underline{Z}$ follows by suspending the partial cotower in Example 6.6 by -2 .


We now have a cotower for $\Sigma^{-\rho-3} H \underline{m^{*}}$.

$$
P_{-10}^{-10}=\Sigma^{-\rho-3} H \phi_{L D R}^{*}\left(\underline{\mathbb{F}}_{2}{ }^{*}\right) \rightarrow \Sigma^{-\rho-3} H \underline{m}^{*} \rightarrow \Sigma^{-3} H \underline{g}^{2}=P_{-12}^{-12}
$$

And a cotower for $\Sigma^{-7} \mathrm{Hm}^{*}$.


We now see interference from the cotower for $\Sigma^{-7} H \underline{m^{*}}$. Its (-14)-slice appears below the ( -16 )-slice in the partial cotower for $\Sigma^{-7} H \underline{Z}$. Additionally, both of these (partial) cotowers have a ( -16 )-slice.
Proposition 7.4 and Proposition 7.8 tell us that $P_{-14}^{-14}\left(\Sigma^{-7} H \underline{Z}\right)$ is indeed $\Sigma^{-4 \rho+1} H \phi_{L D R}^{*}\left(\underline{\mathbb{F}_{2}}\right)$ and $P_{-16}^{-16}\left(\Sigma^{-7} H \underline{\mathbb{Z}}\right)$ is $\Sigma^{-4} H \underline{g} \vee \Sigma^{-4} H \underline{g}^{3} \simeq \Sigma^{-4} H \underline{g}^{4}$.

All partial cotowers for $\Sigma^{-n} H \underline{\mathbb{Z}}$ will follow this pattern of utilizing the homotopy equivalence $\Sigma^{-n} H \underline{\mathbb{Z}}^{*} \simeq \Sigma^{-\rho-n+4} H \underline{\mathbb{Z}}$ to augment the bottom of the cotower for $\Sigma^{-n} H \underline{\mathbb{Z}}$ with the cotower for $\Sigma^{-\rho-n+4} H \underline{\mathbb{Z}}$.

## 7. SLICES OF $\Sigma^{-n} H_{K} \underline{Z}$

Here we determine the slices of $\Sigma^{-n} H_{K} \underline{Z}$.
Proposition 7.1. $\Sigma^{n} H \underline{Z}$ is an $n$-slice for $1 \leq n \leq 5$ and $\Sigma^{-n} H \underline{\mathbb{Z}}^{*}$ is a ( $-n$ )-slice for $1 \leq n \leq 4$.

Proof. The $K$-spectra $\Sigma^{1} H \underline{\mathbb{Z}}, \Sigma^{1} H \underline{\mathbb{Z}}^{*}, \Sigma^{2} H \underline{\mathbb{Z}}$, and $\Sigma^{-1} H \underline{\mathbb{Z}^{*}}$ are 1-, 2-, and ( -1 )-slices by Proposition 2.4 and Theorem 5.9. The result then follows from Proposition 4.2 and the resulting equivalences

$$
\Sigma^{5} H \underline{\mathbb{}} \simeq \Sigma^{\rho+1} H \mathbb{Z}^{*}, \quad \Sigma^{4} H \underline{\mathbb{}} \simeq \Sigma^{\rho} H \underline{\mathbb{Z}}^{*}, \quad \text { and } \quad \Sigma^{3} H \underline{\mathbb{Z}} \simeq \Sigma^{\rho-1} H \underline{\mathbb{Z}}^{*} .
$$

7.1. The ( $-n$ )-slice. We first establish a comparison of the slices of $\Sigma^{-n} H \underline{\mathbb{Z}}$ with those of $\Sigma^{-n+4} H \underline{Z}$.

Proposition 7.2. Let $n \geq 5$. Then

$$
P_{-k}^{-k}\left(\Sigma^{-n} H \underline{\mathbb{Z}}\right) \simeq \Sigma^{-\rho} P_{-k+4}^{-k+4}\left(\Sigma^{-n+4} H \underline{Z}\right)
$$

for $k \in[n, 2 n-1]$.
Proof. By Proposition 4.2, we have

$$
\Sigma^{-\rho} P_{-k+4}^{-k+4}\left(\Sigma^{-n+4} H \mathbb{Z}\right) \simeq \Sigma^{\rho} \Sigma^{-\rho} P_{-k}^{-k}\left(\Sigma^{-n+4-\rho} H \mathbb{Z}\right) \simeq P_{-k}^{-k}\left(\Sigma^{-n} H \underline{\mathbb{Z}}^{*}\right) .
$$

Thus, it is sufficient to compare the ( $-k$ )-slices of $\Sigma^{-n} H \underline{\mathbb{Z}}$ and $\Sigma^{-n} H \underline{\mathbb{Z}^{*}}$.
Recall the injection $\underline{\mathbb{Z}}^{*} \rightarrow \underline{\mathbb{Z}} \rightarrow \mathbb{\mathbb { M }}$ from Section 4 . We wish to show that

$$
\begin{equation*}
\Sigma^{-n} H \underline{\mathbb{Z}}^{*} \rightarrow \Sigma^{-n} H \underline{\mathbb{Z}} \xrightarrow{\mu} \Sigma^{-n} \underline{\mathbb{M}} \tag{5}
\end{equation*}
$$

induces an equivalence on slices strictly above level $-2 n$.
We take the Brown-Comenetz dual of (5) to find the fiber sequence

$$
\Sigma^{n} H \mathbb{\mathbb { M }} \xrightarrow{\iota} \Sigma^{n} I_{\mathbb{Q} / \mathbb{Z}} H \underline{\mathbb{Z}} \rightarrow \Sigma^{n} I_{\mathbb{Q} / \mathbb{Z}} H \underline{\mathbb{Z}}^{*}
$$

Now $\Sigma^{n} H \mathbb{M}$ is $n$-connective, and as its underlying spectrum is contractible, when $n \geq 1$, we know $\Sigma^{n} H \mathbb{M} \geq 2 n$ by Theorem 2.3. Then [HHR1, Lemma 4.28] provides that $\iota$ induces an equivalence on slices strictly below level $2 n$. It then follows from Proposition 2.8 that $\mu$ in (5) induces an equivalence on slices strictly above level $-2 n$.

This is an analogous result to [GY, Proposition 5.3]. However, the injection $\underline{\mathbb{Z}}^{*} \hookrightarrow \underline{\mathbb{Z}}$ allows us to simplify the argument.
Proposition 7.3. Let $n \geq 1$ and take $r \equiv n(\bmod 4)$ with $1 \leq r \leq 4$. Then the top slice of $\Sigma^{-n} H \underline{\mathbb{Z}}$ is

$$
P_{-n}^{-n}\left(\Sigma^{-n} H \mathbb{Z}\right)=\Sigma^{-\frac{n-r}{4} \rho-r} H \mathbb{Z}^{*}
$$

Proof. Section 6 gives the result for $1 \leq n \leq 4$, and $n \geq 5$ follows from repeated application of Proposition 7.2.

### 7.2. The ( $-4 k$ )-slices.

Here we determine the ( $-4 k$ )-slices of $\Sigma^{-n} H \underline{Z}$.
Proposition 7.4. For $n \geq 1$,

$$
P_{-4 k}^{-4 k}\left(\Sigma^{-n} H \underline{\mathbb{Z}}\right) \simeq \begin{cases}\Sigma^{-k \rho} H \underline{m g} & 4 k=n+2 \\ \Sigma^{-k} H \underline{g}^{\frac{1}{2}(4 k-n-1)} & 4 k \in[n+1,2 n-2] \\ \Sigma^{-k \rho} H\left(\underline{g}^{\frac{1}{2}(4 k-n+2)-3} \oplus \phi_{L D R}^{*} \underline{F}_{2}\right) & n \equiv 1(\bmod 2) \\ \Sigma^{-k} H \underline{g}^{n-k+1} & 4 k \in(n+3,2 n], \\ (\bmod 2) \\ & 4 k \in[2 n+1,4 n]\end{cases}
$$

Proof. We have the equivalence

$$
P_{-4 k}^{-4 k}\left(\Sigma^{-n} H \underline{\mathbb{Z}}\right) \simeq \Sigma^{-k \rho} H \underline{\pi}_{0}\left(\Sigma^{-n+k \rho} H \underline{\mathbb{Z}}\right) .
$$

The restriction to each cyclic subgroup agrees with the slices found in Proposition 3.7 and Proposition 7.5 gives the fixed points. All that remains is to verify the result for $4 k \in[n+2,2 n]$ with $n$ even. For $4 k \in[n+2,2 n)$, this follows from Example 6.2, Example 6.3, Example 6.4, Example 6.5, and Proposition 7.2.
Now let $4 k=2 n$. The transfer $\mathbf{t}_{L}^{K}$ fits in the cofiber sequence

$$
\left(\Sigma^{-n+k \rho} H \underline{\mathbb{Z}}\right)^{L} \xrightarrow{\mathbf{t}_{L}^{K}}\left(\Sigma^{-n+k \rho} H \underline{\mathbb{Z}}\right)^{K} \longrightarrow\left(\Sigma^{-n+k \rho+\beta} H \underline{\mathbb{Z}}\right)^{K}
$$

This gives the exact sequence

$$
\begin{equation*}
\pi_{n}^{L}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}\right) \xrightarrow{\mathbf{t}_{L}^{K}} \pi_{n}^{K}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}\right) \longrightarrow \pi_{n}^{K}\left(\Sigma^{k \rho+\beta} H \underline{\mathbb{Z}}\right) . \tag{6}
\end{equation*}
$$

We wish to show this transfer is trivial. By Proposition 7.5 and Proposition 7.7, (6) becomes

$$
\mathbb{F}_{2} \xrightarrow{\mathbf{t}_{L}^{K}} \mathbb{F}_{2}^{\frac{1}{2}(n+2)} \longrightarrow \mathbb{F}_{2}^{\frac{1}{2}(n+2)} \longrightarrow 0=\pi_{n-1}^{L}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}\right)
$$

Thus, $\mathbf{t}_{L}^{K}$ must be zero. A similar argument shows that $\mathbf{t}_{R}^{K}$ and $\mathbf{t}_{D}^{K}$ are trivial as well.
The restriction $\mathbf{r}_{L}^{K}$ fits into the cofiber sequence

$$
\left(\Sigma^{-n+k \rho-\beta} H \underline{\mathbb{Z}}\right)^{K} \longrightarrow\left(\Sigma^{-n+k \rho} H \underline{\mathbb{Z}}\right)^{K} \xrightarrow{\mathbf{r}_{L}^{K}}\left(\Sigma^{-n+k \rho} H \underline{\mathbb{Z}}\right)^{L}
$$

This gives the exact sequence

$$
\begin{equation*}
\pi_{n}^{K}\left(\Sigma^{k \rho-\beta} H \underline{\mathbb{Z}}\right) \longrightarrow \pi_{n}^{K}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}\right) \xrightarrow{\mathbf{r}_{L}^{K}} \pi_{n}^{L}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}\right) \tag{7}
\end{equation*}
$$

We wish to show this restriction is surjective. By Proposition 7.5 and Proposition 7.6, (7) becomes

$$
\pi_{n+1}^{L}\left(\Sigma^{k \rho} H \underline{Z}\right)=0 \longrightarrow \mathbb{F}_{2}^{\frac{1}{2}(n)} \longleftrightarrow \mathbb{F}_{2}^{\frac{1}{2}(n)+1} \xrightarrow{\mathbf{r}_{L}^{K}} \mathbb{F}_{2}
$$

Thus, $\mathbf{r}_{L}^{K}$ must be surjective. A similar argument shows that $\mathbf{r}_{R}^{K}$ and $\mathbf{r}_{D}^{K}$ are surjective as well.
All that remains to be shown is that the restrictions have distinct kernels. Consider the cofiber sequence

$$
\Sigma^{-n+k \rho-\beta} H \underline{\mathbb{Z}} \longrightarrow \Sigma^{-n+k \rho} H \underline{\mathbb{Z}} \longrightarrow K / L_{+} \wedge \Sigma^{-n+k \rho} H \underline{\mathbb{Z}} .
$$

This results in the exact sequence

$$
\begin{equation*}
\underline{\pi}_{n}\left(\Sigma^{k \rho-\beta} H \underline{\mathbb{Z}}\right) \longrightarrow \underline{\pi}_{n}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}\right) \longrightarrow \uparrow_{L}^{K} \downarrow_{L}^{K} \underline{\pi}_{n}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}\right) \tag{8}
\end{equation*}
$$

which by Proposition 3.3, Proposition 7.5, and Proposition 7.6 is


Each restriction is surjective with kernel of rank $\frac{n}{2}$. As

$$
\operatorname{dim} \pi_{n}^{K}\left(\sum^{k \rho} H \mathbb{Z}\right)=\frac{n}{2}+1,
$$

it is sufficient to show that the kernels are pairwise distinct.
Because the diagram on the left commutes, we find that

$$
\operatorname{im} \varphi \cap \operatorname{ker}\left(\mathbf{r}_{R}^{K}\right)=\{0\} \quad \text { and } \quad \operatorname{im} \varphi \cap \operatorname{ker}\left(\mathbf{r}_{D}^{K}\right)=\{0\} .
$$

As $\operatorname{im} \varphi=\operatorname{ker}\left(\mathbf{r}_{L}^{K}\right)$, we have that $\operatorname{ker}\left(\mathbf{r}_{L}^{K}\right)$ is distinct from $\operatorname{ker}\left(\mathbf{r}_{R}^{K}\right)$ and $\operatorname{ker}\left(\mathbf{r}_{D}^{K}\right)$. Replacing $\beta$ by $\alpha$ shows that $\operatorname{ker}\left(\mathbf{r}_{R}^{K}\right)$ and $\operatorname{ker}\left(\mathbf{r}_{D}^{K}\right)$ are distinct as well.

Proposition 7.5. For $G=K$ and $k \geq 1$,

$$
\pi_{i}^{K}\left(\Sigma^{k \rho} H \mathbb{Z}\right)= \begin{cases}\mathbb{Z} & i=4 k \\ \mathbb{F}_{2}^{\frac{1}{2}(4 k-1-i)} & i \in[2 k+1,4 k-1] \text { odd } \\ \mathbb{F}_{2}^{\frac{1}{2}(4 k+2-i)} & i \in[2 k+2,4 k-2] \text { even } \\ \mathbb{F}_{2}^{i-k+1} & i \in[k, 2 k]\end{cases}
$$

Proof. Note that

$$
P_{-4 k}^{-4 k}\left(\Sigma^{-4 k} H \underline{\mathbb{Z}}\right) \simeq \Sigma^{-k \rho} H_{4 k}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}\right)
$$

Thus, by Proposition 7.3, $H \underline{\pi}_{4 k}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}\right) \simeq H \underline{Z}$. So the result holds for $i=4 k$ and we only need consider $i \leq 4 k-1$.
We will use the resulting long exact sequences in homotopy resulting from the cofiber sequences

$$
\begin{align*}
& \left(K / L_{+} \rightarrow S^{0} \rightarrow S^{\beta}\right) \wedge \Sigma^{k \rho+1} H \underline{\mathbb{Z}}  \tag{9}\\
& \left(K / R_{+} \rightarrow S^{0} \rightarrow S^{\alpha}\right) \wedge \Sigma^{k \rho+\beta+1} H \underline{\mathbb{Z}}  \tag{10}\\
& \left(K / D_{+} \rightarrow S^{0} \rightarrow S^{\gamma}\right) \wedge \Sigma^{k \rho+\alpha+\beta+1} H \underline{\mathbb{Z}}  \tag{11}\\
& \Sigma^{k \rho} H \underline{\mathbb{Z}} \xrightarrow{2} \Sigma^{k \rho} H \underline{\mathbb{Z}} \rightarrow \Sigma^{k \rho} H \underline{\mathbb{F}_{2}} \tag{12}
\end{align*}
$$

where (12) is induced by the short exact sequence of Mackey functors $\underline{\mathbb{Z}} \stackrel{2}{\longrightarrow} \underline{\mathbb{Z}} \rightarrow \underline{\mathbb{F}_{2}}$.
For $k=0$, (9) - (11) provide that

$$
\underline{\pi}_{n}\left(\Sigma^{\rho} H \underline{\mathbb{Z}}\right)=\left\{\begin{array}{cc}
\underline{\mathbb{Z}} & n=4 \\
\underline{0} & n=3 \\
\frac{m g}{g} & n=2 \\
\underline{g} & n=1
\end{array}\right.
$$

Consequently, the result holds for $k=1$. We now proceed by induction on $k$. Assume the result holds for $k$. By restriction to $L, D$, and $R$, we find that $\underline{\pi}_{i}\left(\Sigma^{(k+1) \rho} H \underline{Z}\right)$ is a pullback over $K$ for $i \leq 4 k+3$ odd, and consequently, 2 -torsion as in [Z1, Remark 2.13].

In the long exact sequence of fixed points resulting from (9) - (11), we have at the $K / K$ level,

$$
\begin{gathered}
\pi_{i}^{C_{2}}\left(\Sigma^{2 k \rho_{C_{2}}+1} H_{C_{2}} \underline{\mathbb{}}\right) \longrightarrow \pi_{i}^{K}\left(\Sigma^{k \rho+1} H \underline{\mathbb{Z}}\right) \longrightarrow \pi_{i}^{K}\left(\Sigma^{k \rho+\beta+1} H \underline{\mathbb{Z}}\right) \\
\pi_{i}^{C_{2}}\left(\Sigma^{(2 k+1) \rho_{C_{2}}} H_{C_{2}} \underline{Z}\right) \longrightarrow \pi_{i}^{K}\left(\Sigma^{k \rho+\beta+1} H \underline{\mathbb{Z}}\right) \longrightarrow \pi_{i}^{K}\left(\Sigma^{k \rho+\alpha+\beta+1} H \underline{\mathbb{Z}}\right) \\
\pi_{i}^{C_{2}}\left(\Sigma^{(2 k+2) \rho_{C_{2}}-1} H_{C_{2}} \underline{\mathbb{Z}}\right) \longrightarrow \pi_{i}^{K}\left(\Sigma^{k \rho+\alpha+\beta+1} H \underline{\mathbb{Z}}\right) \longrightarrow \pi_{i}^{K}\left(\Sigma^{(k+1) \rho} H \underline{\mathbb{Z}}\right)
\end{gathered}
$$

When $2 k+1 \leq i \leq 4 k+1$, by Proposition 3.3,

$$
\pi_{i}^{C_{2}}\left(\Sigma^{2 k \sigma+2 k+1} H_{C_{2}} \underline{Z}\right)= \begin{cases}\mathbb{F}_{2} & i \text { odd } \\ 0 & i \text { even }\end{cases}
$$

Now for $i$ even, we have in our long exact sequence,

$$
\begin{aligned}
& 0 \longrightarrow \pi_{i}^{K}\left(\Sigma^{k \rho+1} H \underline{\mathbb{Z}}\right) \longrightarrow \pi_{i}^{K}\left(\Sigma^{k \rho+\beta+1} H \underline{\mathbb{Z}}\right) \longrightarrow \\
& \mathbb{F}_{2} \longrightarrow \pi_{i-1}^{K}\left(\Sigma^{k \rho+1} H \underline{Z}\right) \longrightarrow \pi_{i-1}^{K}\left(\Sigma^{k \rho+\beta+1} H \underline{\mathbb{Z}}\right) \longrightarrow
\end{aligned}
$$

Consequently, when $i$ is even,

$$
2-\mathrm{rk} \pi_{i}^{K}\left(\Sigma^{k \rho+\beta+1} H \underline{\mathbb{Z}}\right) \leq 2-\mathrm{rk} \pi_{i}^{K}\left(\Sigma^{k \rho+1} H \underline{Z}\right)+1,
$$

where equality occurs if $\pi_{i}^{K}\left(\Sigma^{k \rho+\beta+1} H \underline{\mathbb{Z}}\right)=\pi_{i}^{K}\left(\Sigma^{(k \rho+1} H \underline{Z}\right) \oplus \mathbb{F}_{2}$.
And, when $i$ is odd,

$$
2-\mathrm{rk} \pi_{i}^{K}\left(\Sigma^{k \rho+\beta+1} H \underline{\mathbb{Z}}\right) \leq 2-\mathrm{rk} \pi_{i}^{K}\left(\Sigma^{k \rho+1} H \underline{\mathbb{Z}}\right)
$$

For $i \leq 2 k$ we have

$$
0 \longrightarrow \pi_{i}^{K}\left(\Sigma^{k \rho+1} H \underline{\mathbb{Z}}\right) \longleftrightarrow \pi_{i}^{K}\left(\Sigma^{k \rho+\beta+1} H \underline{\mathbb{Z}}\right) \xrightarrow{0}
$$

Thus, for $i \leq 2 k$,

$$
\pi_{i}^{K}\left(\Sigma^{k \rho+\beta+1} H \underline{\mathbb{Z}}\right) \cong \pi_{i}^{K}\left(\Sigma^{k \rho+1} H \underline{\mathbb{Z}}\right) .
$$

A similar statement holds for

$$
2 \text {-rk } \pi_{i}^{K}\left(\Sigma^{k \rho+\alpha+\beta+1} H \underline{\mathbb{Z}}\right) \quad \text { and } \quad 2 \text {-rk } \pi_{i}^{K}\left(\Sigma^{(k+1) \rho} H \underline{\mathbb{Z}}\right) .
$$

From [GY, Corollary 7.2], in the long exact sequence resulting from (12), we have

$$
\begin{aligned}
\mathbb{F}_{2}^{l} \cong \pi_{2 i+1}^{K}\left(\Sigma^{(i+1) \rho} H \underline{\mathbb{Z}}\right) & \xrightarrow{0} \pi_{2 i+1}^{K}\left(\Sigma^{(i+1) \rho} H \underline{Z}\right) \hookrightarrow \pi_{2 i+1}^{K}\left(\Sigma^{(i+1) \rho} H \underline{\mathbb{F}_{2}}\right) \cong \mathbb{F}_{2}^{2 i+1} \\
& \rightarrow \pi_{2 i}^{K}\left(\Sigma^{(i+1) \rho} H \underline{\mathbb{Z}}\right) \cong \pi_{2 i-1}^{K}\left(\Sigma^{i \rho} H \underline{\mathbb{Z}}\right) \cong \mathbb{F}_{2}^{i}
\end{aligned}
$$

Consequently, $l=i+1$ and $\pi_{2 i+1}^{K}\left(\Sigma^{(i+1) \rho} H \underline{Z}\right) \cong \mathbb{F}_{2}^{i+1}$. We then have in our long exact sequence
$\pi_{2 i+2}^{K}\left(\Sigma^{(i+1) \rho} H \underline{\mathbb{Z}}\right) \rightarrow \pi_{2 i+2}^{K}\left(\Sigma^{(i+1) \rho} H \underline{\mathbb{F}_{2}}\right) \cong \mathbb{F}_{2}^{2 i+3} \rightarrow \mathbb{F}_{2}^{i+1} \cong \pi_{2 i+1}^{K}\left(\Sigma^{(i+1) \rho} H \underline{\mathbb{Z}}\right)$.
Thus,

$$
2 \text {-rk } \pi_{2 i+2}^{K}\left(\Sigma^{(i+1) \rho} H \underline{\mathbb{Z}}\right) \geq i+2=2-\mathrm{rk} \pi_{2 i+1}^{K}\left(\Sigma^{i \rho} H \underline{\mathbb{Z}}\right)+3
$$

We achieve the maximum bound for $2-\mathrm{rk} \pi_{2 i+2}^{K}\left(\Sigma^{(i+1) \rho} H \underline{\mathbb{Z}}\right)$; thus,

$$
\pi_{2 i+2}^{K}\left(\Sigma^{(i+1) \rho} H \underline{\mathbb{Z}}\right) \cong \pi_{2 i+1}^{K}\left(\Sigma^{i \rho} H \underline{\mathbb{Z}}\right) \oplus \mathbb{F}_{2}^{3} \cong \mathbb{F}_{2}^{i+2}
$$

The rest of the result now follows from this long exact sequence in a similar manner.

Proposition 7.6. For $G=K$ and $k \geq 1$,

$$
\pi_{i}^{K}\left(\Sigma^{k \rho-\beta} H \underline{Z}\right)= \begin{cases}\mathbb{F}_{2}^{\frac{1}{2}(4 k-i)} & i \in[2 k, 4 k-2] \text { even } \\ \mathbb{F}_{2}^{\frac{1}{2}(4 k-i-1)} & i \in[2 k-1,4 k-3] \text { odd } \\ \mathbb{F}_{2}^{i-k+1} & i \in[k, 2 k]\end{cases}
$$

Proof. This follows from a similar argument as in Proposition 7.5.

Proposition 7.7. For $G=K$ and $k \geq 1$,

$$
\pi_{i}^{K}\left(\Sigma^{k \rho+\beta} H \underline{Z}\right)= \begin{cases}\mathbb{F}_{2}^{\frac{1}{2}(4 k-i)+1} & i \in[2 k+2,4 k] \text { even } \\ \mathbb{F}_{2}^{\frac{1}{2}(4 k-i+1)} & i \in[2 k+1,4 k-1] \text { odd } \\ \mathbb{F}_{2}^{i-k+1} & i \in[k, 2 k]\end{cases}
$$

Proof. This follows from a similar argument as in Proposition 7.5.

### 7.3. The ( $-4 k-2$ )-slices.

We now determine the $(-4 k-2)$-slices of $\Sigma^{-n} H \underline{Z}$.
Proposition 7.8. For even $n, \Sigma^{-n} H \underline{Z}$ has no ( $-4 k-2$ )-slices, except for possibly the $-n$ slice. For odd $n \geq 1$,

$$
P_{-4 k-2}^{-4 k-2}\left(\Sigma^{-n} H \underline{\mathbb{Z}}\right) \simeq \begin{cases}\Sigma^{-k \rho-1} H \underline{m}^{*} & 4 k+2=n+1 \\ \Sigma^{-k \rho-1} H \phi_{L D R}^{*}{\underline{F_{2}}}^{*} & 4 k+2 \in(n+1,2 n]\end{cases}
$$

Proof. When $n$ is even, the slices in Proposition 7.4 restrict to the all of the appropriate slices for $\Sigma^{-n} H_{C_{2}} \underline{Z}$. If, then, $\Sigma^{-n} H_{K} \underline{Z}$ has a ( $-4 k-2$ )slice, it must be a pullback over $K$. But this is a contradiction as such slices are ( $-4 k$ )-slices. Thus, for $n$ even, $\Sigma^{-n} H_{K} \mathbb{Z}$ has no ( $-4 k-2$ )slices.
Now let $n$ be odd. We first handle the case $4 k+2=2 n$. By Proposition 2.5,

$$
P_{-4 k-2}^{-4 k-2}\left(\Sigma^{-n} H_{K} \underline{\mathbb{Z}}\right) \simeq \Sigma^{-(k+1) \rho} P_{2}^{2}\left(\Sigma^{-n+(k+1) \rho} H_{K} \underline{\mathbb{Z}}\right)
$$

For clarity, let

$$
X:=P_{2}^{2}\left(\Sigma^{-n+(k+1) \rho} H_{K} \mathbb{Z}\right) .
$$

Now from Corollary 3.8,

$$
i_{H}^{*} X \simeq \Sigma^{1} H_{C_{2}} \underline{g} .
$$

where $H$ is $L, D$, or $R$. Thus, by Theorem 5.9,

$$
\underline{\pi}_{2}(X)=\phi_{K}^{*} B \quad \text { and } \quad \underline{\pi}_{1}(X)=\underline{A}
$$

where $B$ is some group and


0
and $A_{K} \rightarrow \mathbb{F}_{2} \oplus \mathbb{F}_{2} \oplus \mathbb{F}_{2}$ is injective. That is, $A_{K}=\mathbb{F}_{2}^{n}$ with $0 \leq n \leq 3$.
If $B \neq 0$, then $X$ cannot be a 2 -slice. Consequently, $X \simeq \Sigma^{1} H \underline{A}$.
Because $\mathbb{Z}$ is invariant under the automorphisms of $K$, the spectrum $\Sigma^{-n} H \underline{Z}$ is as well. Therefore, the slices of $\Sigma^{-n} H \underline{\mathbb{Z}}$ are also invariant under the automorphisms of $K$.

Thus, $\underline{A}$ must be one of the following:

$$
\phi_{L D R}^{*} \underline{f}, \quad \underline{m}, \quad \underline{m g}, \quad \text { or } \quad \phi_{L D R}^{*} \underline{\mathbb{F}_{2}} .
$$

Except for degree $-k-1, \Sigma^{-(k+1) \rho+1} H \underline{A}$ has the same homotopy for each choice of $A$.
For degree $-k-1, \underline{\pi}_{-k-1}\left(\Sigma^{-(k+1) \rho+1} H \underline{A}\right)$ is a pullback over $K$ of dimension 3, 2, 1 , or 0 .
From Proposition 10.4 we find that $\pi_{-k-1}^{K}\left(\Sigma^{-(k+1) \rho+1} H \underline{A}\right)=0$. The only choice of $\underline{A}$ that meets this requirement is $\phi_{L D R}^{*} \underline{\mathbb{F}_{2}}$.
Now let $4 k+2 \in[n+1,2 n-1]$. The base cases are established in Example 6.2, Example 6.4, and Example 6.6. The result then follows from Proposition 7.2.

## 8. SLICES OF $\Sigma^{n} H \underline{Z}$

Recall from Proposition 7.1 that $\Sigma^{n} H \underline{\mathbb{Z}}$ is a slice for $1 \leq n \leq 5$.
Proposition 8.1. Let $n \geq 6$. Then

$$
P_{k}^{k}\left(\Sigma^{n} H \underline{\mathbb{Z}}\right) \simeq \Sigma^{\rho} P_{k-4}^{k-4}\left(\Sigma^{n-4} H \underline{\mathbb{Z}}\right)
$$

for $k \in[n, 2 n-7]$.
Proof. We employ a similar argument as in Proposition 7.2. Note that

$$
P_{k}^{k}\left(\Sigma^{n} H \underline{\mathbb{Z}}\right) \simeq \Sigma^{\rho} P_{k-4}^{k-4}\left(\Sigma^{n-\rho} H \underline{\mathbb{Z}}\right) \simeq \Sigma^{\rho} P_{k-4}^{k-4}\left(\Sigma^{n-4} H \underline{\mathbb{Z}}^{*}\right) .
$$

Consequently, it is sufficient to compare the ( $k-4$ )-slices of $\Sigma^{n-4} H \underline{Z}$ and $\Sigma^{n-4} H \underline{\mathbb{Z}}^{*}$.
The exact sequence $\underline{\mathbb{Z}}^{*} \rightarrow \underline{\mathbb{Z}} \rightarrow \mathbb{\mathbb { M }}$ provides the fiber sequence

$$
\Sigma^{j-1} H \underline{\mathbb{M}} \rightarrow \Sigma^{j} H \underline{\mathbb{Z}}^{*} \xrightarrow{\iota} \Sigma^{j} H \underline{\mathbb{Z}} .
$$

Then, because $\Sigma^{j-1} H \mathbb{M} \geq 2 j-2$, by [HHR1, Lemma 4.28], $\iota$ induces an equivalence on slices strictly below level $2 j-2$. Taking $j=n-4$ gives the result.

Example 8.2. The tower for $\Sigma^{6} H \underline{Z}$ is


Proof. We have the short exact sequence $\underline{\mathbb{Z}}^{*} \rightarrow \underline{\mathbb{Z}}(2,1)^{*} \rightarrow \underline{g}$. This leads to the cofiber sequence

$$
P_{8}^{8}=\Sigma^{2} H \underline{g} \longrightarrow \Sigma^{6} H \underline{\mathbb{Z}} \simeq \Sigma^{\rho+2} H \underline{\mathbb{Z}}^{*} \longrightarrow \Sigma^{\rho+2} H \underline{\mathbb{Z}}(2,1)^{*}=P_{6}^{6} .
$$

Example 8.3. The tower for $\Sigma^{7} H \underline{Z}$ is


Proof. We suspend the tower in Example 8.2 by 1 and augment with the cofiber sequence $\Sigma^{\rho+2} H \underline{m} \rightarrow \Sigma^{\rho+3} H \underline{\mathbb{Z}}(2,1)^{*} \rightarrow \Sigma^{\rho+3} H \underline{\mathbb{Z}}$ which arises from the short exact sequence $\underline{\mathbb{Z}}(2,1)^{*} \rightarrow \underline{\mathbb{Z}} \rightarrow \underline{m}$.

We now determine the slices of $\Sigma^{n} H \underline{Z}$.
Theorem 8.4. Let $n \geq 6$. For $k \geq n+2$,

$$
P_{k}^{k}\left(\Sigma^{n} H \underline{\mathbb{Z}}\right) \simeq \Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} P_{-k+4}^{-k+4} \Sigma^{-n+5} H \underline{\mathbb{Z}} .
$$

Proof. Take $r \equiv n-5(\bmod 4)$ with $1 \leq r \leq 4$. We may map the top slice of $\Sigma^{-n+5} H \underline{Z}$ into it to find the cofiber sequence

$$
\begin{equation*}
P_{-n+5}^{-n+5}=\Sigma^{-\frac{n-5-r}{4} \rho-r} H \underline{\mathbb{Z}}^{*} \rightarrow \Sigma^{-n+5} H \underline{\mathbb{Z}} \rightarrow P^{-n+5-1} \Sigma^{-n+5} H \underline{\mathbb{Z}} . \tag{13}
\end{equation*}
$$

Note that all slices of $P^{-n+4} H \underline{\mathbb{Z}}$ are torsion, so then

$$
I_{\mathbb{Q} / \mathbb{Z}} P^{-n+4} H \underline{\mathbb{Z}}=\Sigma^{1} I_{\mathbb{Z}} P^{-n+4} \Sigma^{-n+5} H \underline{\mathbb{Z}} .
$$

Apply $I_{\mathbb{Z}}$ to (13) and suspend by one to find

$$
\Sigma^{1} I_{\mathbb{Z}} P^{-n+4} \Sigma^{-n+5} H \underline{\mathbb{Z}} \rightarrow \Sigma^{n-4} H \underline{\mathbb{Z}}^{*} \rightarrow \Sigma^{\frac{n-5-r}{4} \rho+r+1} H \underline{\mathbb{Z}} .
$$

We can rewrite this as

$$
I_{\mathbb{Q} / \mathbb{Z}} P^{-n+4} \Sigma^{-n+5} H \underline{\mathbb{Z}} \rightarrow \Sigma^{n-\rho} H \underline{\mathbb{Z}} \rightarrow \Sigma^{\frac{n-5-r}{4} \rho+r+1} H \mathbb{Z}
$$

Finally, suspend by $\rho$ to obtain

$$
\begin{equation*}
\Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} P^{-n+4} \Sigma^{-n+5} H \underline{\mathbb{Z}} \rightarrow \Sigma^{n} H \underline{\mathbb{Z}} \rightarrow \Sigma^{\frac{n-1-r}{4} \rho+r+1} H \underline{\mathbb{Z}} . \tag{14}
\end{equation*}
$$

Note that $\sum^{\frac{n-1-r}{4} \rho+r+1} H \underline{\mathbb{Z}}$ is an $n$-slice and

$$
\Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} P^{-n+4} \Sigma^{-n+5} H \mathbb{Z} \in[n, 4(n-4)] .
$$

Furthermore, if $n \not \equiv 2(\bmod 4)$,

$$
\Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} P^{-n+4} \Sigma^{-n+5} H \underline{\mathbb{Z}} \in[n+1,4(n-4)] .
$$

From Proposition 2.8,

$$
I_{\mathbb{Q} / \mathbb{Z}} P_{-k}^{-k} \Sigma^{-n+5} H \underline{\mathbb{Z}} \simeq P_{k}^{k} I_{\mathbb{Q} / \mathbb{Z}} \Sigma^{-n+5} H \underline{\mathbb{Z}} .
$$

Consequently, $\Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} P^{-n+4} \Sigma^{-n+5} H \underline{\mathbb{Z}}$ provides all slices of $\Sigma^{n} H \underline{\mathbb{Z}}$.
Now suppose $n \equiv 2(\bmod 4)$ so that $r=1$. Then from Proposition 2.8,

$$
\begin{aligned}
P_{n}^{n}\left(\Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} P^{-n+4} \Sigma^{-n+5} H \underline{\mathbb{Z}}\right) & \simeq \Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} P_{-n}^{-n}\left(P^{-n+4} \Sigma^{-n+5} H \underline{\mathbb{Z}}\right) \\
& \simeq \Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} \Sigma^{-\left(\frac{n-6}{4}+1\right) \rho+1} H \underline{m g} \\
& \simeq \Sigma^{\frac{n-2}{4} \rho+1} H \underline{m}
\end{aligned}
$$

Apply $P_{n}^{n}(-)$ to (14) to get the extension

$$
\Sigma^{\frac{n-2}{4} \rho+1} H \underline{m} \rightarrow P_{n}^{n} \Sigma^{n} H \underline{\mathbb{Z}} \rightarrow \Sigma^{\frac{n-2}{4} \rho+2} H \underline{\mathbb{Z}}
$$

and the fiber sequence

$$
\Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} P^{-n+5} H \underline{\mathbb{Z}} \rightarrow \Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} P^{-n+4} H \underline{\mathbb{Z}} \rightarrow P_{n}^{n} \Sigma^{n} H \underline{\mathbb{Z}} .
$$

Now $\Sigma^{\rho} I_{\mathbb{Q} / \mathbb{Z}} P^{-n+5} H \underline{Z} \in[n+1,4(n-4)]$ and thus supplies the remaining slices of $\Sigma^{n} H \underline{Z}$.

Proposition 8.5. Let $n \geq 6$ and set $r \equiv n(\bmod 4)$ with $2 \leq r \leq 5$. The $n$-slice of $\Sigma^{n} H \underline{\mathbb{Z}}$ is

$$
P_{n}^{n} \Sigma^{n} H \underline{\mathbb{Z}} \simeq \begin{cases}\Sigma^{\frac{n-2}{4} \rho+2} H \underline{Z}(2,1)^{*} & n \equiv 2(\bmod 4) \\ \Sigma^{\frac{n-r}{4} \rho+r} H \underline{\mathbb{Z}} & \text { otherwise }\end{cases}
$$

Proof. For $n \not \equiv 2(\bmod 4)$, this follows from (14). When $n \equiv 2(\bmod 4)$ it follows from Example 8.2 and repeated application of Proposition 8.1.

Proposition 8.6. Let $n \geq 6$. The $4 k$-slices of $\Sigma^{n} H \underline{Z}$ are

$$
P_{4 k}^{4 k}\left(\Sigma^{n} H \underline{\mathbb{Z}}\right) \simeq\left\{\begin{array}{lr}
\Sigma^{k \rho} H \underline{m g}^{*} & 4 k=n+1 \\
\Sigma^{k} H \underline{g}^{\frac{1}{2}(4 k-n)} & 4 k \in[n+2,2 n-8], \\
\Sigma^{k \rho} H\left(\underline{g}^{\frac{1}{2}(4 k-n+3)-3} \oplus \varphi_{L D R}^{*} \underline{\mathbb{F}}_{2}{ }^{*}\right) & 4 k \in[n+2,2 n-6], \\
\Sigma^{k} H \underline{g}^{n-k-3} & n \equiv 1(\bmod 2) \\
\underbrace{n} & 4 k \in[2 n-4,4(n-4)]
\end{array}\right.
$$

Proof. This follows from Proposition 7.4 and Theorem 8.4.

Proposition 8.7. For $n \geq 6$, except for possibly the $n$ slice, the nontrivial $(4 k+2)$-slices of $\Sigma^{n} H \underline{\mathbb{Z}}$ are

$$
P_{4 k+2}^{4 k+2}\left(\Sigma^{n} H \underline{\mathbb{Z}}\right) \simeq\left\{\begin{array}{lr}
\Sigma^{k \rho+1} H \phi_{L D R}^{*} \underline{\mathbb{F}_{2}} & 4 k+2 \in[n+2,2 n-6], \\
n \equiv 0 & (\bmod 2)
\end{array}\right.
$$

Proof. By Corollary 3.6, $\Sigma^{n} H_{C_{2}} \underline{\mathbb{Z}}$ has no (4k+2)-slices except in the range $[n+2,2 n-6]$ when $n$ is even. So for $4 k+2$ not in this range, any such slice must be a pullback over $K$. But then it is a $4 k$-slice. For $4 k+2 \in[n+2,2 n-6]$, the result follows from Proposition 7.8 and Theorem 8.4.

### 8.1. Comparison with the Slices of $\Sigma^{n} H \underline{\mathbb{F}_{2}}$.

This work is complementary to [GY], which calculates the slices of $\Sigma^{n} H \mathbb{F}_{2}$ for $n \geq 1$. One would hope that the exact sequence $\underline{\mathbb{Z}} \xrightarrow{2} \underline{\mathbb{Z}} \rightarrow \underline{\mathbb{F}_{2}}$ could play a role in recovering the slices of $\Sigma^{n} H \underline{\mathbb{Z}}$ from the slices of $\Sigma^{n} H \underline{F}_{2}$ or vice versa, but this is not always the case.
When $G=C_{2}$, [GY, Theorem 3.18] shows that the slices of $\Sigma^{n} H_{C_{2}} \mathbb{F}_{2}$ contain both even and odd suspensions of $H_{C_{2}} \underline{g}$, whereas Proposition 3.5 shows that $\sum^{n} H_{C_{2}} \underline{\mathbb{Z}}$ has only even or odd suspensions of $H_{C_{2}} \underline{\underline{g}}$. This is illustrated in Table 4.

The $2 k$-slices of $\Sigma^{n} H_{C_{2}} \underline{Z}$ and $\Sigma^{n+1} H_{C_{2}} \underline{Z}$ only combine to give the slices of $\Sigma^{n} H_{C_{2}} \underline{\mathbb{F}_{2}}$ when $n \equiv 3,4(\bmod 4)$. When $n \equiv 5,6(\bmod 4)$, the $\Sigma^{n} H_{C_{2}} \underline{\mathbb{Z}}$ and $\Sigma^{n+1} H_{C_{2}} \underline{Z}$ slices miss the $(n+r)$-slice of $\Sigma^{n} H_{C_{2}} \underline{\mathbb{F}_{2}}$, where $r=1,2$, respectively. For example, neither $\Sigma^{9} H_{C_{2}} \underline{\mathbb{Z}}$ nor $\Sigma^{10} H_{C_{2}} \underline{Z}$ has a slice equivalent to $\Sigma^{5} H_{C_{2}} \underline{g}$, but $\Sigma^{9} H_{C_{2}} \underline{\mathbb{F}_{2}}$ does.
We can recover the ( $4 k$ )-slices of $\Sigma^{n} H \underline{\mathbb{F}_{2}}$ from the ( $4 k$ )-slices of $\Sigma^{n} H_{K} \underline{\mathbb{Z}}$ and $\Sigma^{n+1} H_{K} \underline{\mathbb{Z}}$. As in Proposition 7.5 , we use the sequence $\underline{\mathbb{Z}} \xrightarrow{2} \underline{\mathbb{Z}} \rightarrow \underline{\mathbb{F}_{2}}$

to get the cofiber sequence $\Sigma^{-k \rho} H_{K} \underline{\mathbb{Z}} \rightarrow \Sigma^{-k \rho} H_{K} \underline{\mathbb{F}_{2}} \rightarrow \Sigma^{1-k \rho} H_{K} \underline{\mathbb{Z}}$. We then have the long exact sequence in homotopy

$$
\begin{align*}
& \underline{\pi}_{-n}\left(\Sigma^{-k \rho} H_{K} \underline{\mathbb{Z}}\right) \xrightarrow{2} \underline{\pi}_{-n}\left(\Sigma^{-k \rho} H_{K} \underline{\mathbb{Z}}\right) \longrightarrow  \tag{15}\\
& \underline{\pi}_{-n}\left(\Sigma^{-k \rho} H_{K} \underline{\mathbb{F}}_{2}\right) \rightarrow \underline{\pi}_{-n-1}\left(\Sigma^{-k \rho} H_{K} \underline{\mathbb{Z}}\right) \xrightarrow{2} \underline{\pi}_{-n-1}\left(\Sigma^{-k \rho} H_{K} \underline{\mathbb{Z}}\right) .
\end{align*}
$$

When $n \leq 4 k-1$, all groups in (15) are 2 -torsion and the middle three terms become the exact sequence

$$
\begin{equation*}
\underline{\pi}_{-n}\left(\Sigma^{-k \rho} H_{K} \underline{\mathbb{Z}}\right) \longleftrightarrow \underline{\pi}_{-n}\left(\Sigma^{-k \rho} H_{K} \underline{\mathbb{F}_{2}}\right) \longrightarrow \underline{\pi}_{-n-1}\left(\Sigma^{-k \rho} H_{K} \underline{\mathbb{Z}}\right) . \tag{16}
\end{equation*}
$$

When $n=4 k$, the left four terms of (15) become the exact sequence

$$
\underline{\mathbb{Z}}^{*} \xrightarrow{2} \underline{\mathbb{Z}}^{*} \xrightarrow{2} \underline{\pi}_{-n-1}\left(\Sigma^{-k \rho} H_{K} \underline{\mathbb{Z}}\right) \longrightarrow \underline{0} .
$$

Consequently, the ( $4 k$ )-slices of $\Sigma^{n} H_{K} \underline{\mathbb{F}_{2}}$ are

$$
P_{4 k}^{4 k}\left(\Sigma ^ { n } H _ { K \underline { \mathbb { F } _ { 2 } } ) } \simeq \left\{\begin{array}{ll}
\Sigma^{k \rho} H_{K}{\underline{\mathbb{F}_{2}}}^{*} & n=4 k \\
\Sigma^{k \rho} \underline{E}_{-n} & n \leq 4 k-1
\end{array}\right.\right.
$$

where $\underline{E}_{-n}$ is the middle Mackey functor in (16). This recovery is illustrated in Table 5.
Except for the $n$-slice, all slices of $\Sigma^{7} H_{K} \underline{\mathbb{F}_{2}}$ are recovered from the slices of $\Sigma^{7} H_{K} \underline{\mathbb{Z}}$ and $\Sigma^{8} H_{K} \underline{\mathbb{Z}}$. It is not always the case, however, that the ( $4 k+2$ )-slices are recovered. For example, $\Sigma^{10} H_{K} \underline{\mathbb{F}_{2}}$ has a 14 -slice ([GY, Example 6.14]), but neither $\Sigma^{10} H_{K} \underline{\mathbb{Z}}$ nor $\Sigma^{11} H_{K} \underline{\mathbb{Z}}$ have 14-slices.

## 9. Homotopy Mackey Functor Computations

Here we compute the homotopy Mackey functors of the slices of $\Sigma^{ \pm n} H \underline{\mathbb{Z}}$.

Proposition 9.1. For $k \geq 1$, the nontrivial homotopy Mackey functors of $\sum^{k \rho} H \underline{Z}$ are

$$
\underline{\pi}_{n}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}\right)= \begin{cases}\underline{\mathbb{Z}} & n=4 k \\ \underline{m g} & n=4 k-2 \\ \underline{g}^{\frac{1}{2}(4 k-n-1)} & n \in[2 k, 4 k-3], \\ \underline{g}^{\frac{1}{2}(4 k-n+2)-3} \oplus \phi_{L D R}^{*} \underline{\mathbb{F}}_{2} & n \equiv 1(\bmod 2) \\ \underline{g}^{n} & n \equiv 0(\bmod 2) \\ \underline{g}^{n-k+1} & n \in[k, 2 k-1]\end{cases}
$$

Proof. For $n \in[k, 4 k-2]$, this is a restatement of Proposition 7.4. For $n=4 k$, the result follows from Proposition 7.3 and repeated application of Proposition 7.2.

Proposition 9.2. For $k \geq 1$, the nontrivial homotopy Mackey functors of $\Sigma^{-k \rho} H \underline{\mathbb{Z}}$ are

$$
\underline{\pi}_{-n}\left(\Sigma^{-k \rho} H \underline{\mathbb{Z}}\right)=\left\{\begin{array}{lr}
\underline{\mathbb{Z}}^{*} & n=4 k \\
m \underline{g}^{*} & n=4 k-1 \\
\underline{g}^{\frac{1}{2}(4 k-n)} & n \in[2 k+4,4 k-3], \\
\underline{g}^{\frac{1}{2}(4 k-n+3)-3} \oplus \phi_{L D R}^{*} \underline{\mathbb{F}}_{2}^{*} & n \in[2 k+3,4 k-2], \\
\underline{g}^{n-k-3} & n \equiv 1(\bmod 2) \\
\underline{g}^{2} & n \in[k+4,2 k+2]
\end{array}\right.
$$

Proof. For $n \in[k+4,4 k-1]$, this is a restatement of Proposition 8.6. For $n=4 k$, the result follows from Proposition 8.5 and repeated application of Proposition 8.1.

Proposition 9.3. For $k \geq 1$, the nontrivial homotopy Mackey functors of $\sum^{k \rho} H \underline{\mathbb{Z}}^{*}$ are

$$
\underline{\pi}_{n}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}^{*}\right)=\left\{\begin{array}{lr}
\underline{\underline{Z}} & n=4 k \\
m g & n=4 k-2 \\
\underline{g} \underline{g}^{\frac{1}{2}(4 k-n-1)} & n \in[2 k+2,4 k-3], \\
\underline{g}^{\frac{1}{2}(4 k-n-2)-3} \oplus \phi_{L D R}^{*} \underline{\mathbb{F}}_{2} & n \in\left[\begin{array}{l}
(\bmod 2) \\
\underline{g}^{n-k+2}
\end{array}\right. \\
\underline{g}^{n \equiv 0}(\bmod 2) \\
& n \in[k+3,2 k+1]
\end{array}\right.
$$

Proof. This follows from the equivalence $\Sigma^{k \rho} H \underline{\mathbb{Z}}^{*} \simeq \Sigma^{(k-1) \rho+4} H \underline{\mathbb{Z}}$ and Proposition 9.1.

Proposition 9.4. For $k \geq 1$, the nontrivial homotopy Mackey functors of $\Sigma^{k \rho} H \underline{Z}(2,1)^{*}$ are

$$
\underline{\pi}_{n}\left(\Sigma^{k \rho} H \underline{\mathbb{Z}}(2,1)^{*}\right)= \begin{cases}\underline{\pi}_{n}\left(\sum^{k \rho} H \underline{\mathbb{Z}}^{*}\right) & n \in[k+3,4 k] \\ \underline{g} & n=k\end{cases}
$$

Proof. The exact sequence $\underline{\mathbb{Z}}^{*} \rightarrow \underline{\mathbb{Z}}(2,1)^{*} \rightarrow \underline{g}$ and corresponding cofiber sequence $\Sigma^{k \rho} H \underline{\mathbb{Z}^{*}} \rightarrow \Sigma^{k \rho} H \underline{\mathbb{Z}}(2,1)^{*} \rightarrow \Sigma^{k} H \underline{g}$ provide us with a long exact sequence in homotopy. We then have that the homotopy of $\Sigma^{k \rho} H \mathbb{Z}(2,1)^{*}$ is the homotopy of $\Sigma^{k \rho} H \underline{\mathbb{Z}}^{*}$ with an additional $\underline{g}$ in degree $k$.

Proposition 9.5. For $k \geq 2$, the nontrivial homotopy Mackey functors of $\sum^{k \rho} H \underline{m} g^{*}$ are

$$
\underline{\pi}_{n}\left(\Sigma^{k \rho} H \underline{m g}^{*}\right)= \begin{cases}\phi_{L D R}^{*} \underline{\mathbb{F}_{2}} & n=2 k \\ \underline{g^{3}} & n \in[k+2,2 k-1] \\ \underline{g} & n=k+1\end{cases}
$$

Proof. We have the equivalence $\Sigma^{k \rho} H m g^{*} \simeq \Sigma^{(k-1) \rho+2} H \underline{m}$. The result then follows from [GY, Proposition 7.3].

Proposition 9.6. For $k \geq 2$, the nontrivial homotopy Mackey functors of $\Sigma^{-k \rho} H \underline{m g}$ are

$$
\underline{\pi}_{-n}\left(\Sigma^{-k \rho} H \underline{m g}\right)= \begin{cases}\phi_{L D R}^{*}{\underline{F_{2}}}^{*} & n=2 k \\ \underline{g}^{3} & n \in[k+2,2 k-1] \\ \underline{g} & n=k+1\end{cases}
$$

Proof. The result follows by taking the Brown-Comenetz dual of each Mackey functor in Proposition 9.5.

Proposition 9.7. For $k \geq 2$, the nontrivial homotopy Mackey functors of $\Sigma^{-k \rho} H \underline{m}$ are

$$
\underline{\pi}_{-n}\left(\Sigma^{-k \rho} H \underline{m}\right)= \begin{cases}\phi_{L D R}^{*}{\underline{F_{2}}}^{*} & n=2 k \\ \underline{g}^{3} & n \in[k+2,2 k-1] \\ \underline{g}^{2} & n=k+1\end{cases}
$$

Proof. First, take the Brown-Comenetz dual of the Mackey functors in [GY, Proposition 7.4]. The result then follows from the equivalence $\Sigma^{-\rho} H \underline{m} \simeq \Sigma^{-2} H \underline{m} g^{*}$.

Proposition 9.8. We have the equivalences

$$
\Sigma^{k \rho} H \phi_{L D R}^{*}{\underline{\mathbb{F}_{2}}}^{*} \simeq \begin{cases}\Sigma^{2} H \phi_{L D R}^{*} \underline{f} & k=1 \\ \Sigma^{4} H \phi_{L D R \underline{\mathbb{F}_{2}}}^{*} & k=2\end{cases}
$$

Then for $k \geq 3$, the nontrivial homotopy Mackey functors of $\Sigma^{k \rho} H \phi_{L D R}^{*} \underline{\mathbb{F}}_{2}{ }^{*}$ are

$$
\underline{\pi}_{n}\left(\sum^{k \rho} H \phi_{L D R}^{*} \underline{\mathbb{F}}_{2}^{*}\right)= \begin{cases}\phi_{L D R}^{*} \underline{\mathbb{F}_{2}} & n=2 k \\ \underline{g}^{3} & n \in[k+2,2 k-1]\end{cases}
$$

Proof. This is the pullback over $L, D$, and $R$ of the Mackey functors in [GY, Proposition 3.6].

Proposition 9.9. We have the equivalences

$$
\Sigma^{-k \rho} H \phi_{L D R \underline{\mathbb{F}_{2}}}^{\sim} \simeq \begin{cases}\Sigma^{-2} H \phi_{L D R}^{*} \underline{f} & k=1 \\ \Sigma^{-4} H \phi_{L D R}^{*}{\underline{\mathbb{F}_{2}}}^{*} & k=2\end{cases}
$$

Then for $k \geq 3$, the nontrivial homotopy Mackey functors of $\Sigma^{-k \rho} H \phi_{L D R}^{*} \underline{\mathbb{F}_{2}}$ are

$$
\underline{\pi}_{-n}\left(\Sigma^{-k \rho} H \phi_{L D R}^{*} \underline{\mathbb{F}_{2}}\right)= \begin{cases}\phi_{L D R}^{*} \underline{\mathbb{F}}_{2} & n=2 k \\ \underline{g}^{3} & n \in[k+2,2 k-1]\end{cases}
$$

Proof. This is the pullback over $L, D$, and $R$ of the Mackey functors in [GY, Proposition 3.7].

## 10. Spectral Sequences

The slice spectral sequence for $\Sigma^{-n} H \underline{\mathbb{Z}}$ and $\Sigma^{n} H \mathbb{Z}$ must recover the homotopy Mackey functors of each spectrum, that is, we must be left with $\underline{\pi}_{-n}\left(\Sigma^{-n} H \underline{\mathbb{Z}}\right)=\underline{\pi}_{n}\left(\Sigma^{n} H \underline{\mathbb{Z}}\right)=\underline{\mathbb{Z}}$ and all other homotopy Mackey functors trivial. For most of the differentials, then, there is only one choice.

We use the indexing convention from [HHR1, Section 4.4.2]. The Mackey functor $\underline{E}_{2}^{t-n, t}$ is $\underline{\pi}_{n} P_{t}^{t}(X)$. We also use the Adams convention, so that $\underline{\pi}_{n} P_{t}^{t}(X)$ has coordinates ( $n, n-t$ ) and the differential,

$$
d_{r}: \underline{E}_{r}^{s, t} \rightarrow \underline{E}_{r}^{s+r, t+r-1},
$$

points left one and up $r$.
The symbols in Table 6 denote the Mackey functors in the slice spectral sequences shown.
Example 10.1. The slices for $\Sigma^{-1} H \underline{Z}$ are all a one-fold desuspension of Eilenberg-MacLane spectra (Example 6.2, Figure 10.10). Because each of these Mackey functors is in the same column, there are no

differentials. Consequently, in the spectral sequence, we find a double extension:


Example 10.2. In the spectral sequence for $\Sigma^{-5} H \underline{Z}$, Figure 10.10, because we can only be left with $\underline{\pi}_{-5}\left(P_{-5}^{-5} \Sigma^{-5} H \underline{Z}\right) \cong \underline{Z}$ and all differentials must go left one and up at least two, all differentials are forced. Once we have evaluated each differential, we once again find ourselves with the double extension in (17).

Example 10.3. In Figure 10.11, most of the differentials for $\Sigma^{-9} H \underline{Z}$ are again forced by the fact that only $\underline{\pi}_{-9}\left(P_{-9}^{-9} \Sigma^{-9} H \underline{Z}\right) \cong \underline{\mathbb{Z}}$ can survive the spectral sequence. For example, we have two choices for a differential from $\pi_{-8} P_{-32}^{-32} \Sigma^{-9} H \underline{\mathbb{Z}} \cong \underline{g}^{2}$. We find it must be

$$
d_{15}: \underline{g}^{2} \rightarrow \phi_{L D R}^{*}{\underline{\mathbb{F}_{2}}}^{*} \cong \underline{\pi}_{-9}\left(P_{-24}^{-24} \Sigma^{-9} H \underline{\mathbb{Z}}\right)
$$

so that we are left with the extension in (17). Indeed, we will always be left with this extension once all differentials have been evaluated. Similarly, for $n \equiv 1(\bmod 4)$, we will always have a

$$
d_{2}: \phi_{L D R}^{*}{\underline{\mathbb{F}_{2}}}^{*} \stackrel{\cong}{\rightrightarrows} \phi_{L D R}^{*}{\underline{\mathbb{F}_{2}}}^{*}
$$

in the upper right corner.
In Proposition 7.8 we claim that for $n$ odd,

$$
P_{-2 n}^{-2 n}\left(\Sigma^{-n} H \underline{\mathbb{Z}}\right) \simeq \Sigma^{-(k+1) \rho+1} H \phi_{L D R}^{*} \underline{\mathbb{F}_{2}} .
$$

We now prove this claim.

Proposition 10.4. Let $n$ be odd and take $\underline{A}$ to be one of the Mackey functors listed in Table 7. The only choice of $\underline{A}$ where the homotopy of $P_{-2 n}^{-2 n}\left(\Sigma^{-n} H \underline{Z}\right) \simeq \Sigma^{-(k+1) \rho+1} H \underline{A}$ fits into the spectral sequence for $\Sigma^{-n} H \underline{\mathbb{Z}}$ is $\phi_{L D R}^{*} \underline{\mathbb{F}_{2}}$.

Proof. Because $\Sigma^{-(k+1) \rho+1} H \underline{A}$ is a $(-4 k-2)$-slice, its $\underline{\pi}_{-k-1}$ is located at ( $-k-1,-3 k-1$ ). We argue that we cannot have a nonzero Mackey functor in this location.

In the spectral sequence for $\Sigma^{-n} H \underline{\mathbb{Z}}$, all slices below level $-2 n$ are $\Sigma^{-k} \mathrm{Hg}^{n-k+1}$ where $4 k \in[2 n+1,4 n]$. These Mackey functors, for $4 k \leq$ $2 n+1$, lie on the line $y=-3 k$. Thus, for the Mackey functors in Table 7 , the source of a differential hitting it must be $(-k,-3 k)$. This is not possible.

We now argue that the Mackey functor located at ( $-k-1,-3 k-1$ ) cannot be the source of a differential. The first value of $n$ for which we must determine the $(-2 n)$-slice is $n=7$. The spectral sequence where $\underline{A}=\phi_{L D R}^{*} \underline{\mathbb{F}_{2}}$ is shown in Figure 10.11. This spectral sequence leaves us with the appropriate homotopy for $\Sigma^{-7} H \underline{Z}$.
Note there is a copy of $\underline{g}^{4}$ located at $(-4,-12)$. For any other choice of $\underline{A}$, we would have a nontrivial $\underline{\pi}_{-4}$ located at $(-4,-10)$. For a differential originating from $(-4,-10)$, there are two possible targets: $\phi_{L D R}^{*} \underline{F}_{2}{ }^{*}$ at $(-5,-5)$ and $g$ at $(-5,-2)$. However, these two Mackey functors must fit into the exact sequences

$$
\underline{g}^{2} \rightarrow \underline{g}^{3} \rightarrow \underline{g} \quad \text { and } \quad \underline{g}^{4} \rightarrow \phi_{L D R}^{*}{\underline{F_{2}}}^{*} \rightarrow \underline{m g} .
$$

Thus, we cannot have a nonzero Mackey functor at ( $-4,-10$ ).
We now consider the spectral sequence for $\Sigma^{-9} H \underline{Z}$, located in Figure 10.11. We again use $\Sigma^{-(l+1) \rho+1} H \phi_{L D R}^{*} \underline{\mathbb{F}_{2}}$ for the $(-2 n)$-slice. The resulting homotopy fits in the spectral sequence. For the other three
choices of $\underline{A}$ we would have a nontrivial $\underline{\pi}_{-5}$ located at $(-5,-13)$. For a differential originating from $(-5,-13)$ there are two possible targets: $\underline{g}^{3}$ at $(-6,-8)$ and $\phi_{L D R}^{*}{\underline{F_{2}}}^{*}$ at $(-6,-3)$.
However, we have a $d_{2}: \phi_{L D R}^{*}{\underline{F_{2}}}^{*} \rightarrow \phi_{L D R}^{*}{\underline{F_{2}}}^{*}$ and a $d_{7}: \underline{g}^{5} \rightarrow \underline{g}^{3}$. Thus, there is no target for a differential from ( $-5,-13$ ). Consequently, the only choice of $\underline{A}$ that works is $\phi_{L D R}^{*} \underline{\mathbb{F}_{2}}$.
There is a similar story for all odd $n>9$. There will always be a $d_{2}$ hitting the $\phi_{L D R}^{*}{\underline{F_{2}}}^{*}$ located at $(-k-2,-n+k+2)$. The only other possible targets for a differential from $(-k-1,-3 k-1)$ are then the $g^{3}$ 's resulting from the homotopy of the other $(-4 j-2)$-slices. All of these will be hit by a differential from the $g^{n-k+1}$ located at $(-k-1,-3 k-3)$. Thus, we cannot have a nonzero Mackey functor located at ( $-k-1,-3 k-1$ ). The only choice of $\underline{A}$ which satisfies this requirement is $\phi_{L D R}^{*} \underline{\mathbb{F}_{2}}$.

Example 10.5. For the positive, trivial suspensions of $H \underline{Z}$, we find that $\Sigma^{6} H \mathbb{Z}$ has the first nontrivial slice tower. In Figure 10.12, we then see that there is only one possible differential. This $d_{3}$ exists because we must be left with only $\underline{\pi}_{6}\left(\Sigma^{6} H \underline{\mathbb{Z}}\right) \cong \underline{\mathbb{Z}}$.

Example 10.6. The spectral sequence for $\Sigma^{7} H \mathbb{Z}$, in Figure 10.12, is more interesting. Here we find the differentials $\bar{d}_{2}: \phi_{L D R}^{*} F \rightarrow m g$ and $d_{5}: m g \rightarrow g$. Indeed, we will always see a $d_{n-7}: \phi_{L D R}^{*} \underline{\mathbb{F}_{2}} \rightarrow m g$ and $d_{2 n-9}: \underline{m g} \xrightarrow{\rightarrow} \underline{g}$ on the right side of the spectral sequence for $\Sigma^{\bar{n} H_{K}} \underline{\underline{Z}}$.

Example 10.7. Except for the homotopy of the $n$-slice of $\Sigma^{7} H_{K} \mathbb{Z}$, $\Sigma^{7} H_{K} \underline{\mathbb{F}_{2}}$, and $\Sigma^{8} H_{K} \underline{\mathbb{Z}}$, the spectral sequences for $\Sigma^{7} H_{K} \underline{\mathbb{Z}}$ and $\Sigma^{8} \bar{H}_{K} \underline{\mathbb{Z}}$ collapse to give the spectral sequence for $\Sigma^{7} H_{K} \underline{\mathbb{F}_{2}}$. We see in Figure 10.12 the $\underline{g}$ in $(3,9)$ and the $\underline{g}^{2}$ in $(3,9)$ in the spectral sequences for $\Sigma^{7} H_{K} \underline{\underline{Z}}$ and $\Sigma^{8} H_{K} \underline{\underline{Z}}$, respectively, combine to give the $\underline{g}^{3}$ in $(3,9)$ in the spectral sequence for $\Sigma^{7} H_{K} \mathbb{F}_{2}$. Off the diagonal for the $n$-slice for $\Sigma^{7} H_{K} \underline{\mathbb{Z}}$ and $\Sigma^{8} H_{K} \underline{\mathbb{Z}}$ we have a single copy of $\phi_{L D R}^{*} \underline{\mathbb{F}_{2}}$. These provide the two copies of $\phi_{L D R}^{*} \underline{\mathbb{F}_{2}}$ off the diagonal for $\Sigma^{7} H_{K} \underline{\mathbb{F}_{2}}$.

Example 10.8. Now, in Figure 10.13, we have some choice of differentials in the spectral sequence for $\Sigma^{11} H \mathbb{Z}$. Once we consider that only $\underline{\pi}_{11}\left(\Sigma^{11} H \underline{Z}\right) \cong \underline{\mathbb{Z}}$ can be left, there is only one choice of each differential that provides the desired result. Analogously to the spectral sequence for $\Sigma^{-n} H \underline{\mathbb{Z}}$ where $n \equiv 1(\bmod 4)$, we will always have a $d_{2}: \phi_{L D R}^{*} \underline{\mathbb{F}_{2}} \stackrel{\cong}{\rightrightarrows} \phi_{L D R}^{*}{\underline{\mathbb{F}_{2}}}^{*}$ in the bottom left corner when $n \equiv 3(\bmod 4)$.

Example 10.9. Again, with the exception of the homotopy of the $n$ slice, the spectral sequences for $\Sigma^{10} H_{K} \underline{Z}$ and ${ }^{11} H_{K} \underline{\mathbb{Z}}$ collapse to give the spectral sequence for $\Sigma^{10} H_{K} \underline{\mathbb{F}_{2}}$ in Figure 10.13. As in Example 10.7, the upper left diagonals in in the spectral sequences for $\Sigma^{10} H_{K} \underline{Z}$ and ${ }^{11} H_{K} \underline{Z}$ combine to even more copies of $\underline{g}$ in the upper left diagonal in the spectral sequence for $\Sigma^{10} H_{K} \underline{\mathbb{F}_{2}}$. This will always be the case.
