# Necessary and sufficient conditions for boundedness of commutators of fractional integral operators on mixed-norm Lebesgue spaces *

#### Abstract

In this paper, the sharp maximal theorem is generalized to mixed-norm ball Banach function spaces, which is defined as Definition 2.7. As an application, we give a characterization of BMO via the boundedness of commutators of fractional integral operators on mixed-norm Lebesgue spaces. Moreover, the characterization of homogeneous Lipschitz space is also given by the boundedness of commutators of fractional integral operators on mixed-norm Lebesgue spaces. Finally, two applications of Corollary 6.4 are given.


Keywords: Ball quasi-Banach function space; Mixed-norm ball quasi-Banach function space; Mixed-norm Lebesgue space; Fractional integral operators; Commutators

## 1 Introduction

In recent years, due to the more precise structure of mixed-norm function spaces than the corresponding classical function spaces, the mixed-norm function spaces are widely used in the partial differential equations [3-6]. In 1961, the mixed Lebesgue spaces $L^{\vec{p}}\left(\mathbb{R}^{n}\right)(0<\vec{p}<\infty)$ were studied by Benedek and Panzone [7]. These spaces were natural generalizations of the classical Lebesgue spaces $L^{p}(0<p<\infty)$. After that, many function spaces with mixed norm were introduced, such as mixed-norm Lorentz spaces [8], mixed-norm Lorentz-Marcinkiewicz spaces [9], mixed-norm Orlicz spaces [10], anisotropic mixed-norm Hardy spaces [11], mixed-norm Triebel-Lizorkin spaces [12], mixed Morrey spaces $[15,16]$ and weak mixed-norm Lebesgue spaces [13]. More information can be found in [14].

[^0]In 2017, ball (quasi-)Banach function spaces were introduced by Sawano et al. [19]. Ball (quasi-)Banach function spaces are the generalizations of the (quasi-)Banach function spaces (see Remark 2.6). In this paper, according to the definitions of the mixed-norm Banach function spaces [43] defined by Blozinski, we introduce the definitions of mixednorm ball (quasi-)Banach function spaces and prove sharp maximal theorem mixed-norm ball Banach function spaces (see Theorem 3.7). we also acquire Corollary 3.8 and corollary 3.9 .

Moreover, we point out that many spaces are ball (quasi-)Banach function spaces, such as variable Lebesgue spaces [31] and Orlicz spaces [32], which also are (quasi-)Banach function spaces, Besides, some spaces are ball (quasi-)Banach function spaces, which are not necessary to be (quasi-)Banach function spaces, such as Morrey spaces [30], mixednorm Lebesgue spaces, weighted Lebesgue spaces, and Orlicz-slice spaces [34].

Particularly, mixed-norm Lebesgue spaces also can be regarded as mixed-norm ball (quasi-)Banach function spaces. In addition, mixed-norm Lorentz spaces, mixed-norm Orlicz spaces, and mixed-norm Lebesgue spaces with variable exponents are also mixednorm ball (quasi-)Banach function spaces. For more studies of ball Banach function spaces, we refer the readers to [36-40].

Given a number $0<\alpha<n$, the fractional integral functions of a measurable function $f$ on $\mathbb{R}^{n}$ is defined by

$$
I_{\alpha} f(x)=\int_{\mathbb{R}^{n}} \frac{f(y)}{|x-y|^{n-\alpha}} d y
$$

These operators $I_{\alpha}$ play an essential role in real and harmonic analysis [1, 2].
For a locally integrable function $b$, the commutator is defined by

$$
\left[b, I_{\alpha}\right] f(x):=b(x) I_{\alpha} f(x)-I_{\alpha}(b f)(x)=\int_{\mathbb{R}^{n}} \frac{(b(x)-b(y)) f(y)}{|x-y|^{n-\alpha}} d y
$$

which are introduced by Chanillo in [17]. It is obvious that

$$
\left|\left[b, I_{\alpha}\right](f)(x)\right| \leq I_{\alpha, b}(|f|)(x),
$$

where

$$
I_{\alpha, b}(f)(x):=I_{\alpha}(|b(x)-b(\cdot)| f)(x)=\int_{\mathbb{R}^{n}} \frac{|b(x)-b(y)| f(y)}{|x-y|^{n-\alpha}} d y .
$$

Many classical works on the characterizations of $B M O\left(\mathbb{R}^{n}\right)$ and homogeneous Lipschitz spaces were studied via the boundedness of $\left[b, I_{\alpha}\right]$ on classical Lebesgue spaces. In 1982, an early characterization of $B M O\left(\mathbb{R}^{n}\right)$ spaces was investigated by Chanillo [41] via the $\left(L^{p}\left(\mathbb{R}^{n}\right), L^{q}\left(\mathbb{R}^{n}\right)\right)$-boundedness of $\left[b, I_{\alpha}\right]$. That is

$$
b \in B M O\left(\mathbb{R}^{n}\right) \Leftrightarrow\left[b, I_{\alpha}\right]: L^{p}\left(\mathbb{R}^{n}\right) \mapsto L^{q}\left(\mathbb{R}^{n}\right)
$$

where $1<p<q<\infty, \frac{1}{p}-\frac{1}{q}=\frac{\alpha}{n}$. the characterization of homogeneous Lipschitz spaces $\operatorname{Lip}_{\beta}\left(\mathbb{R}^{n}\right)(0<\beta<1)$ was given by Paluszynski [42] via $\left(L^{p}\left(\mathbb{R}^{n}\right)\right.$, $\left.L^{q}\left(\mathbb{R}^{n}\right)\right)$-boundedness of
$\left[b, I_{\alpha}\right]$ as:

$$
b \in \operatorname{Lip}_{\beta}\left(\mathbb{R}^{n}\right) \Leftrightarrow\left[b, I_{\alpha}\right]: L^{p}\left(\mathbb{R}^{n}\right) \mapsto L^{q}\left(\mathbb{R}^{n}\right)
$$

where $1<p<q<\infty, \frac{1}{p}-\frac{1}{q}=\frac{\alpha+\beta}{n}$.
In 2019, Nogayama given a characterization of $B M O\left(\mathbb{R}^{n}\right)$ via the boundedness of commutators of fractional integral operators on mixed Morrey spaces [16]. Due to the definitions of mixed Morrey spaces, we know that

$$
b \in B M O\left(\mathbb{R}^{n}\right) \Leftrightarrow\left[b, I_{\alpha}\right]: L^{\vec{p}}\left(\mathbb{R}^{n}\right) \mapsto L^{\vec{q}}\left(\mathbb{R}^{n}\right)
$$

where $1<\vec{p}, \vec{q}<\infty$ and

$$
\alpha=\sum_{i=1}^{n} \frac{1}{p_{i}}-\sum_{i=1}^{n} \frac{1}{q_{i}}, p_{j} \sum_{i=1}^{n} \frac{1}{p_{i}}=q_{j} \sum_{i=1}^{n} \frac{1}{q_{i}}(j=1, \cdots, n) .
$$

In fact, the condition

$$
p_{j} \sum_{i=1}^{n} \frac{1}{p_{i}}=q_{j} \sum_{i=1}^{n} \frac{1}{q_{i}}(j=1, \cdots, n)
$$

is not necessary. In Theorem 4.3, a weaker condition is given. Furthermore, the characterization of homogeneous Lipschitz spaces $\operatorname{Lip}_{\beta}\left(\mathbb{R}^{n}\right)(0<\beta<1)$ was also given in Theorem 5.3 via the boundedness of $\left[b, I_{\alpha}\right]$ on mixed-norm Lebesgue spaces.

The paper is organized as the following. In Section 2, some notations and notions are recalled and we introduce the definitions of mixed-norm ball (quasi-)Banach function spaces. In Section 3, the sharp maximal theorem is investigated on mixed-norm ball Banach function spaces via corresponding extrapolation theorem. As an application, we give a characterization of BMO via the boundedness of commutators of fractional integral operators on Mixed-norm Lebesgue spaces in Section 4. Moreover, the characterization of homogeneous Lipschitz spaces is also given in Section 5. In Section 6, two applications of Corollary 6.4 are given.

## 2 Some notations and notions

In this section, we make some conventions on notation and recall some notions. Let $\vec{p}=\left(p_{1}, p_{2}, \cdots, p_{n}\right), \vec{q}=\left(q_{1}, q_{2}, \cdots, q_{n}\right)$, are n-tuples and $1<p_{i}, q_{i}<\infty, i=1,2, \cdots, n$. We define that if $\varphi(a, b)$ is a relation or equation among numbers, $\varphi(\vec{p}, \vec{q})$ will mean that $\varphi\left(p_{i}, q_{i}\right)$ hords for each $i$. For example, $\vec{p}<\vec{q}$ means that $p_{i}<q_{i}$ holds for each $i$ and $\frac{1}{\vec{p}}+\frac{1}{\vec{p}^{\prime}}=1$ means $\frac{1}{p_{i}}+\frac{1}{p_{i}^{\prime}}=1$ hold for each $i$. The symbol $Q$ denote the cubes whose edges are parallel to the coordinate axes and $Q(x, r)$ denote the open cube centered at $x$ of side length $r$. Let $c Q(x, r)=Q(x, c r)$. Denote by the symbol $\mathfrak{M}\left(\mathbb{R}^{n}\right)$ the set of all measurable function on $\mathbb{R}^{n} . A \approx B$ means that $A$ is equivalent to $B$. That is $A \leq C B$ and $B \leq C A$,
where $C$ is a constant. Through all paper, every constant $C$ is not necessarily equal. Now, let us recall some definitions.

The definitions of some maximal functions and some class of weight functions are given as the following.

Definition 2.1 Given a locally integrable function $f$. The Hardy-Littlewood maximal operators is defined by

M(f)(x):=\sup _{Q \ni x} \frac{1}{|Q|} \int_{Q}|f(y)| d y
$$

where the supremum is taken over all cube $Q \subset \mathbb{R}^{n}$ containing $x$. The sharp maximal operators is defined by

$$
M^{\sharp}(f)(x):=\sup _{Q \ni x} \frac{1}{|Q|} \int_{Q}\left|f(y)-f_{Q}\right| d y,
$$

where $f_{Q}=\frac{1}{|Q|} \int_{Q} f$ and the supremum is taken over all cube $Q \subset \mathbb{R}^{n}$ containing $x$.
Definition 2.2 An $A_{p}\left(\mathbb{R}^{n}\right)$ weight $\omega$, with $1 \leq p<\infty$, is a locally integrable and nonnegative function on $\mathbb{R}^{n}$ satisfying that, when $1<p<\infty$,

$$
[\omega]_{A_{p}\left(\mathbb{R}^{n}\right)}:=\sup _{Q \subset \mathbb{R}^{n}}\left(\frac{1}{|Q|} \int_{Q} \omega(x) d x\right)\left(\frac{1}{|Q|} \int_{Q} \omega(x)^{\frac{1}{1-p}} d x\right)^{p-1}<\infty
$$

and, when $p=1$,

$$
[\omega]_{A_{1}\left(\mathbb{R}^{n}\right)}:=\sup _{Q \subset \mathbb{R}^{n}}\left(\frac{1}{|Q|} \int_{Q} \omega(x) d x \cdot\left\|\omega^{-1}\right\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}\right)<\infty
$$

Define $A_{\infty}\left(\mathbb{R}^{n}\right):=\bigcup_{1 \leq p<\infty} A_{p}\left(\mathbb{R}^{n}\right)$. It is well-know that $A_{p}\left(\mathbb{R}^{n}\right) \subset A_{q}\left(\mathbb{R}^{n}\right)$ for $1 \leq p \leq$ $q \leq \infty$.

The following is the corresponding weight functions for the product domain $\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}$ from Chapter IV of [28].

Definition 2.3 Let $Q_{1} \subset \mathbb{R}^{n_{1}}, Q_{2} \subset \mathbb{R}^{n_{2}}, R=Q_{1} \times Q_{2}$ and $n=n_{1}+n_{2}$. For $1<p<\infty$, a locally integrable and nonnegative function on $\mathbb{R}^{n}$ is said to be an $A_{p}^{*}\left(\mathbb{R}^{n}\right)$ weight if

$$
[\omega]_{A_{p}^{*}\left(\mathbb{R}^{n}\right)}:=\sup _{R \subset \mathbb{R}^{n}}\left(\frac{1}{|R|} \int_{R} \omega(z) d z\right)\left(\frac{1}{|R|} \int_{R} \omega(z)^{\frac{1}{1-p}} d z\right)^{p-1}<\infty
$$

A locally integrable and nonnegative function on $\mathbb{R}^{n}$ is said to be an $A_{1}^{*}\left(\mathbb{R}^{n}\right)$ weight if

$$
[\omega]_{A_{1}^{*}\left(\mathbb{R}^{n}\right)}:=\sup _{R \subset \mathbb{R}^{n}}\left(\frac{1}{|R|} \int_{R} \omega(z) d z \cdot\left\|\omega^{-1}\right\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}\right)<\infty
$$

We write $A_{\infty}^{*}\left(\mathbb{R}^{n}\right):=\bigcup_{1 \leq p<\infty} A_{p}^{*}\left(\mathbb{R}^{n}\right)$.

By the definition of $A_{p}^{*}\left(\mathbb{R}^{n}\right)$ for $1 \leq p<\infty$, it is easy to prove that if $\mu \in A_{p}\left(\mathbb{R}^{n_{1}}\right)$ and $\nu \in A_{p}\left(\mathbb{R}^{n_{2}}\right)$ then

$$
\mu \nu \in A_{p}^{*}\left(\mathbb{R}^{n}\right)
$$

where $n=n_{1}+n_{2}$. Moreover, $[\omega]_{A_{p}\left(\mathbb{R}^{n}\right)} \leq[\omega]_{A_{p}^{*}\left(\mathbb{R}^{n}\right)}$ and $A_{p}^{*}\left(\mathbb{R}^{n}\right) \subset A_{p}\left(\mathbb{R}^{n}\right)$ for $1 \leq p<\infty$.
Definition 2.4 Let $0<p<\infty$ and $\omega \in A_{\infty}\left(\mathbb{R}^{n}\right)$. The weighted Lebesgue space $L_{\omega}^{p}\left(\mathbb{R}^{n}\right)$ is defined to be the set of all measurable functions $f$ on $\mathbb{R}^{n}$ such that

$$
\|f\|_{L_{\omega}^{p}\left(\mathbb{R}^{n}\right)}:=\left(\int_{\mathbb{R}^{n}}|f(x)|^{p} \omega(x) d x\right)^{\frac{1}{p}}<\infty
$$

The definition of ball (quasi-)Banach function spaces is presented as the following, which were introduced by Sawano et al. [19].

Definition 2.5 A (quasi-)Banach space $\mathbf{X} \subset \mathfrak{M}\left(\mathbb{R}^{n}\right)$ with (quasi-)norm $\|\cdot\|_{\mathbf{X}}$ is called a ball (quasi-)Banach function space if it satisfies
(1) $|g| \leq|f|$ almost everywhere implies that $\|g\|_{\mathbf{X}} \leq\|f\|_{\mathbf{X}}$;
(2) $0 \leq f_{m} \uparrow f$ almost everywhere implies that $\left\|f_{m}\right\|_{\mathbf{X}} \uparrow\|f\|_{\mathbf{X}}$;
(3) If $|Q|<\infty$, then $\chi_{Q} \in \mathbf{X}$;
(4) If $f \geq 0$ almost everywhere and $|Q|<\infty$, then

$$
\int_{Q} f(x) d x \leq C_{Q}\|f\|_{\mathbf{x}}
$$

for some constant $C_{Q}, 0<c_{Q}<\infty$, depending on $Q$ but independent of $f$.
Remark 2.6 The definition remains unchanged if we replace "cube" with "ball" in the above. So this definition deserves this name. Particularly, if we replace any cube $Q$ by any measurable set $E$ in Definition 2.5 and add the condition $\|f\|_{\mathbf{x}}=\||f|\|_{\mathbf{x}}$, we obtain the definition of (quasi-)Banach function space (see Definition 1.1 of Chapter 1 of [35]).

Next, we given the definition of mixed-norm ball (quasi-)Banach function spaces.
Definition 2.7 Let $n_{1}, n_{2} \in \mathbb{N}$ and $\mathbf{X}_{1}$ and $\mathbf{X}_{2}$ be ball (quasi-)Banach function spaces on $\mathbb{R}^{n_{1}}$ and $\mathbb{R}^{n_{2}}$, respectively. The mixed-norm ball (quasi-)Banach function spaces $\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)$ consists of Lebesgue measurable function on $\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}, f$ such that

$$
\|f\|_{\left(\mathbf{x}_{1}, \mathbf{x}_{2}\right)}=\| \| f\left\|_{\mathbf{x}_{1}}\right\|_{\mathbf{x}_{2}}<\infty .
$$

It is easy to prove that $\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)$ is also a ball (quasi-)Banach function space. In fact, if $Q=Q_{1} \times Q_{2} \in \mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}$, then

$$
\left.\left\|\left\|\chi_{Q}\right\| \mathbf{x}_{1}\right\|\right|_{\mathbf{x}_{2}}=\left.\left\|\chi_{Q_{1}}\right\| \mathbf{x}_{1}\left\|\chi_{Q_{2}}\right\|\right|_{\mathbf{x}_{2}}<\infty
$$

and

$$
\begin{aligned}
\int_{Q} f(x, y) d x d y & =\int_{Q_{2}} \int_{Q_{1}} f(x, y) d x d y \\
& \leq C_{Q_{1}} \int_{Q_{2}}\|f(\cdot, y)\|_{\mathbf{x}_{1}} d y \\
& \leq C_{Q}\| \| f\left\|_{\mathbf{x}_{1}}\right\|_{\mathbf{x}_{2}}
\end{aligned}
$$

The definition of associate space of a ball Banach function space can be found in chapter 1 of [21]. The definition of associate space of a ball (quasi-)Banach function space is given as the following.

Definition 2.8 For any ball (quasi-)Banach function space $\mathbf{X}$, the associate space (also called the Köthe dual) $\mathbf{X}^{\prime}$ is defined by setting

$$
\mathbf{X}^{\prime}:=\left\{f \in \mathfrak{M}\left(\mathbb{R}^{n}\right):\|f\|_{\mathbf{X}^{\prime}}:=\sup _{g \in \mathbf{X},\|g\|_{\mathbf{X}=1}} \int_{\mathbb{R}^{n}}|f(x) g(x)| d x<\infty\right\}
$$

where $\|\cdot\|_{\mathbf{X}^{\prime}}$ is called the associate norm of $\|\cdot\|_{\mathbf{x}}$.
We still need to recall the notion of the convexity of ball (quasi-)Banach function spaces, which can be found in Definition 4.6 of [19].

Definition 2.9 Let $\mathbf{X}$ be a ball (quasi-)Banach function space and $0<p<\infty$. The p-convexification $\mathbf{X}^{p}$ of $\mathbf{X}$ is defined by setting

$$
\mathbf{X}^{p}:=\left\{f \in \mathfrak{M}\left(\mathbb{R}^{n}\right):|f|^{p} \in \mathbf{X}\right\}
$$

equipped with the (quasi-)norm $\|f\|_{\mathbf{X}^{p}}:=\left\||f|^{p}\right\|_{\mathbf{X}}^{\frac{1}{p}}$.
Remark 2.10 (1) By the definition 2.9, we know that

$$
\|f\|_{\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)^{p}}=\| \|\left\|\left.f\right|^{p}\right\|_{\mathbf{X}_{1}}\left\|_{\mathbf{X}_{2}}^{\frac{1}{p}}=\right\|\|f\|_{\mathbf{X}_{1}^{p}} \|_{\mathbf{X}_{2}^{p} .} .
$$

Thus,

$$
\begin{equation*}
\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)^{p}=\left(\mathbf{X}_{1}^{p}, \mathbf{X}_{2}^{p}\right) \tag{2.1}
\end{equation*}
$$

(2) If $f \in\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)^{\prime}$, then there exist $h_{1} \in \mathbf{X}_{1}, h_{2} \in \mathbf{X}_{2},\left\|h_{1}\right\|_{\mathbf{X}_{1}}=1$ and $\left\|h_{2}\right\|_{\mathbf{X}_{2}}=1$ such that

$$
\begin{aligned}
\|f\|_{\left(\mathbf{X}_{1}^{\prime}, \mathbf{x}_{2}^{\prime}\right)} & =\| \| f\left\|_{\mathbf{X}_{1}^{\prime}}\right\|_{\mathbf{X}_{2}^{\prime}} \\
& \leq 2 \int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}}\left|f(x, y) h_{1}(x) h_{2}(y)\right| d x d y \\
& \leq \sup _{g \in\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right),\|g\|_{\left(\mathbf{x}_{1}, \mathbf{x}_{2}\right)}=1} 2 \int_{\mathbb{R}^{n_{1} \times \mathbb{R}^{n_{2}}}}|f(x, y) g(x, y)| d x d y \\
& \leq\|f\|_{\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)^{\prime}}
\end{aligned}
$$

For another hand, if $f \in\left(\mathbf{X}_{1}^{\prime}, \mathbf{X}_{2}^{\prime}\right)$, then there exist $g \in\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)$,

\begin{aligned}
\|f\|_{\left(\mathbf{x}_{1}, \mathbf{x}_{2}\right)} & \leq 2 \int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}}|f(x, y) g(x, y)| d x d y \\
& \leq 2 \int_{\mathbb{R}^{n_{2}}}\|f(\cdot, y)\|_{\mathbf{x}_{1}^{\prime}}\|g(\cdot, y)\|_{\mathbf{x}_{1}} d x d y \\
& \leq 2\|f\|_{\left(\mathbf{X}_{1}^{\prime}, \mathbf{x}_{2}^{\prime}\right)}\|g\|_{\left(\mathbf{x}_{1}, \mathbf{x}_{2}\right)} \\
& =2\|f\|_{\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)^{\prime}}
\end{aligned}
$$

Hence, $\left(\mathbf{X}_{1}^{\prime}, \mathbf{X}_{2}^{\prime}\right)$ are equivalent to $\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)^{\prime}$.
Obviously, if $\mathbf{X}$ is a ball (quasi-)Banach function space, the $\mathbf{X}^{p}$ and $\mathbf{X}^{\prime}$ are also ball (quasi-)Banach function spaces. Now, the definitions of mixed-norm Lebesgue spaces are given as the following, which were introduced by Benedek and Panzone [7].

Definition 2.11 Let $f$ is a measurable function on $\mathbb{R}^{n}$ and $1<\vec{p}<\infty$. We say that $f$ belongs to the mixed Lebesgue spaces $L^{\vec{p}}\left(\mathbb{R}^{n}\right)$, if the norm

$$
\|f\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right)}=\left(\int_{\mathbb{R}} \cdots\left(\int_{\mathbb{R}}|f(x)|^{p_{1}} d x_{1}\right)^{\frac{p_{2}}{p_{1}}} \cdots d x_{n}\right)^{\frac{1}{p_{n}}}<\infty
$$

Note that if $p_{1}=p_{2}=\cdots=p_{n}=p$, then $L^{\vec{p}}\left(\mathbb{R}^{n}\right)$ are reduced to classical Lebesgue spaces $L^{p}$ and

$$
\|f\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right)}=\left(\int_{\mathbb{R}^{n}}|f(x)|^{p} d x\right)^{\frac{1}{p}}
$$

Remark 2.12 It is easy to calculate that for any cube $Q \subset \mathbb{R}^{n}$ and $|Q|<\infty$,

$$
\left\|\chi_{Q}\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right)}=|Q|^{\frac{1}{n} \sum_{i=1}^{n} \frac{1}{p_{i}}}
$$

and

$$
\int_{Q} f(x) d x \leq|Q|^{\frac{1}{n} \sum_{i=1}^{n} \frac{1}{p_{i}}}\|f\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right)}
$$

By Levi Lemma, (2) also can be proved. Thus $L^{\vec{p}}$ are ball Banach function spaces. But it is uncertain wether mixed-norm Lebesgue spaces are Banach function spaces.

Let us recall the definition of $B M O\left(\mathbb{R}^{n}\right)$ spaces.
Definition 2.13 If $b$ is a measurable function on $\mathbb{R}^{n}$ and satisfies that

$$
\|b\|_{B M O\left(\mathbb{R}^{n}\right)}=\sup _{Q \subset \mathbb{R}^{n}} \frac{1}{|Q|} \int_{Q}\left|b(y)-b_{Q}\right| d y<\infty
$$

then $b \in B M O\left(\mathbb{R}^{n}\right)$ and $\|b\|_{B M O\left(\mathbb{R}^{n}\right)}$ are the norms of $b$ in $B M O\left(\mathbb{R}^{n}\right)$.

## 3 Sharp maximal theorem on mixed-norm ball quasiBanach function spaces

In this section, we will prove an extrapolation theorem on mixed-norm ball quasiBanach function spaces. According to the extrapolation theorem, we prove the sharp maximal theorem on mixed-norm ball quasi-Banach function spaces. The sharp maximal theorem on weighted Lebesgue spaces can be found in Theorem 3.4.5 of [33].

Lemma 3.1 Let $1<p<\infty, \omega \in A_{p}$. Then for any $f \in L_{\omega}^{p}$,

$$
\int_{\mathbb{R}^{n}}(M f(x))^{p} \omega(x) d x \leq C \int_{\mathbb{R}^{n}}\left(M^{\sharp} f(x)\right)^{p} \omega(x) d x
$$

holds.
To prove the sharp maximal theorem on ball (quasi-)Banach function space, we give an assumption and some lemmas.

Assumption 3.2 There exists an $s \in(1, \infty)$ such that $\mathbf{X}$ is a ball Banach function space, and that $M f$ is bounded on $\left(\mathbf{X}^{\frac{1}{s}}\right)^{\prime}$.

The following result can be found in Lemma 4.7 of [20].
Lemma 3.3 Let $\mathbf{X}$ be a ball quasi-Banach function space satisfying Assumption 2.10. Then there exists an $0<\varepsilon<1$ such that $\mathbf{X}$ continuously embeds into $L_{\omega}^{s}\left(\mathbb{R}^{n}\right)$ with $\omega:=\left[M\left(\chi_{Q(0,1)}\right)\right]^{\varepsilon} \in A_{1}\left(\mathbb{R}^{n}\right)$, namely, there exists a positive constant $C$ such that, for any $f \in \mathbf{X}$,

$$
\|f\|_{L_{\omega}^{s}\left(\mathbb{R}^{n}\right)} \leq C\|f\|_{\mathbf{x}}
$$

Due to Lemma 3.3, the following lemma is proved.
Lemma 3.4 Let $\mathbf{X}_{1}$ and $\mathbf{X}_{2}$ be ball quasi-Banach function spaces on $\mathbb{R}^{n_{1}}$ and $\mathbb{R}^{n_{2}}$, and satisfy Assumption 2.10. Then there exists an $0<\varepsilon<1$ such that $\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)$ continuously embeds into $L_{\omega}^{s}\left(\mathbb{R}^{n_{1}+n_{2}}\right)$ with $\omega=\omega_{1} \omega_{2} \in A_{1}^{*}\left(\mathbb{R}^{n}\right)$, where $\omega_{1}:=\left[M\left(\chi_{Q(0,1)}\right)\right]^{\varepsilon} \in A_{1}\left(\mathbb{R}^{n_{1}}\right)$ $\omega_{2}:=\left[M\left(\chi_{Q(0,1)}\right)\right]^{\varepsilon} \in A_{1}\left(\mathbb{R}^{n_{2}}\right)$ and $n=n_{1}+n_{2}$, namely, there exists a positive constant $C$ such that, for any $f \in\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)$,

$$
\|f\|_{L_{\omega}^{s}\left(\mathbb{R}^{n_{1}+n_{2}}\right)} \leq C\|f\|_{\left(\mathbf{x}_{1}, \mathbf{X}_{2}\right)}
$$

Proof If $f \in\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)$, then by Lemma 3.3

$$
\begin{aligned}
\|f\|_{L_{\omega}^{s}\left(\mathbb{R}^{n_{1}+n_{2}}\right)} & =\left(\int_{\mathbb{R}^{n_{2}}}\left(\int_{\mathbb{R}^{n_{1}}}|f(x, y)|^{s} \omega_{1}(x) d x\right)^{\frac{1}{s} \cdot s} \omega_{2}(y) d y\right)^{\frac{1}{s}} \\
& \leq\left(\int_{\mathbb{R}^{n_{2}}}\|f(\cdot, y)\|_{\mathbf{X}_{1}}^{s} \omega_{2}(y) d y\right)^{\frac{1}{s}} \\
& \leq\| \| f\left\|_{\mathbf{X}_{1}}\right\|_{\mathbf{X}_{2}}
\end{aligned}
$$

The proof is completed.
The following extrapolation theorem plays an important role in the proof of Theorem 3.4. The extrapolation theorem is a slight variant of a special case of Theorem 3.2 of [29], via replacing Banach function spaces by ball quasi-Banach function spaces. The proof of Lemma 3.5 is similar to Theorem 3.2 of [29].

Lemma 3.5 Let $\mathbf{X}_{1}$ and $\mathbf{X}_{2}$ be a ball quasi-Banach function spaces and $p_{0} \in(0, \infty)$. Let $\mathcal{F}$ be the set of all pairs of nonnegative measurable functions $(F, G)$ such that, for any given $\omega \in A_{1}^{*}\left(\mathbb{R}^{n}\right)$,

$$
\int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}}(F(x, y))^{p_{0}} \omega(x, y) d x d y \leq C_{\left(p_{0},[\omega]_{A_{1}^{*}\left(\mathbb{R}^{n}\right)}\right)} \int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}}(G(x, y))^{p_{0}} \omega(x, y) d x d y .
$$

where $C_{\left(p_{0},[\omega]_{A_{1}^{*}\left(\mathbb{R}^{n}\right)}\right)}$ is a positive constant independent of $(F, G)$, but dependents on $p_{0}$ and $A_{1}^{*}\left(\mathbb{R}^{n}\right)$. Assume that there exisitive a $q_{0} \in\left[p_{0}, \infty\right)$ such that $\mathbf{X}_{1}^{\frac{1}{q_{0}}}$ and $\mathbf{X}_{2}^{\frac{1}{q_{0}}}$ are ball Banach function spaces and $M f$ is bounded on $\left(\mathbf{X}_{1}^{\frac{1}{q_{0}}}\right)^{\prime}$ and $\left(\mathbf{X}_{2}^{\frac{1}{q_{0}}}\right)^{\prime}$. Then there exists a positive constant $C_{0}$ such that, for any $(F, G) \in \mathcal{F}$,

$$
\|F\|_{\left(\mathbf{x}_{1}, \mathbf{X}_{2}\right)} \leq C_{0}\|G\|_{\left(\mathbf{x}_{1}, \mathbf{X}_{2}\right)} .
$$

For completeness, we will give the proof of Lemma 3.5. Before that, the following lemma is necessary. It can be found in Theorem 3.1 of [29].

Lemma 3.6 Suppose that for $P_{0}$ with $1 \leq p_{0}<\infty$. Let $\mathcal{F}$ be the set of all pairs of nonnegative measurable functions $(F, G)$ such that, for any given $\omega \in A_{1}^{*}\left(\mathbb{R}^{n}\right)$,

$$
\int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}} F(x, y)^{p_{0}} \omega(x, y) d x d y \leq C \int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}} G(x, y)^{p_{0}} \omega(x, y) d x d y \quad(F, G) \in \mathcal{F}
$$

where $n=n_{1}+n_{2}$. Then, for all $1<p<\infty$ and $\omega \in A_{p}^{*}\left(\mathbb{R}^{n}\right)$, we have

$$
\int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}} F(x, y)^{p} \omega(x, y) d x d y \leq C \int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}} G(x, y)^{p} \omega(x, y) d x d y \quad(F, G) \in \mathcal{F}
$$

The proof of Lemma 3.5 According to Theorem 3.6, if let

$$
\mathcal{F}_{0}=\left\{\left(F^{p_{0}}, G^{p_{0}}\right):(F, G) \in \mathcal{F}\right\}
$$

then we find that for any $p \geq 1$ and $\omega \in A_{1}^{*}\left(\mathbb{R}^{n}\right) \subset A_{p}^{*}\left(\mathbb{R}^{n}\right)$,

$$
\int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}} F(x, y)^{p_{0} p} \omega(x, y) d x d y \leq C \int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}} G(x, y)^{p_{0} p} \omega(x, y) d x d y
$$

Let $p=\frac{q_{0}}{q_{0}}$. Then

$$
\begin{equation*}
\int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}} F(x, y)^{q_{0}} \omega(x, y) d x d y \leq C \int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n}} G(x, y)^{q_{0}} \omega(x, y) d x d y \tag{3.1}
\end{equation*}
$$

We write $Y_{1}=\mathbf{X}_{1}^{\frac{1}{q_{0}}}$ and $Y_{2}=\mathbf{X}_{2}^{\frac{1}{q_{0}}}$. For any functions $h_{1}(x) \in \mathbf{Y}_{1}^{\prime}$ and $h_{2}(y) \in \mathbf{Y}_{2}^{\prime}$, let

$$
R_{1} h_{1}(x)=\sum_{k=0}^{\infty} \frac{M^{k} h_{1}(x)}{\left(2 A_{1}\right)^{k}}
$$

and

$$
R_{2} h_{2}(y)=\sum_{k=0}^{\infty} \frac{M^{k} h_{2}(y)}{\left(2 A_{2}\right)^{k}}
$$

where $A_{1}=\|M\|_{\mathbf{Y}_{1}^{\prime} \rightarrow \mathbf{Y}_{1}^{\prime}}, A_{2}=\|M\|_{\mathbf{Y}_{2}^{\prime} \rightarrow \mathbf{Y}_{2}^{\prime}}, M^{0} h=|h|$ and $M^{k} h=M\left(M^{k-1} h\right)$. Obviously, $h_{1}$ and $h_{2}$ satisfy that

$$
\begin{gather*}
\left|h_{i}\right| \leq R_{i} h_{i}  \tag{3.2}\\
\left\|R_{i} h_{i}\right\|_{\mathbf{Y}_{i}^{\prime}} \leq 2\left\|h_{i}\right\|_{\mathbf{Y}_{i}^{\prime}},  \tag{3.3}\\
M\left(R_{i} h_{i}\right) \leq 2 A_{i} R_{i} h_{i}, \tag{3.4}
\end{gather*}
$$

for $i=1,2$. (3.2), (3.3) and (3.4) follow from the definition of $R_{1}$ and $R_{2}$. By (3.4), it is obvious that

$$
R_{1} h_{1}(x) \in A_{1}\left(\mathbb{R}^{n_{1}}\right), R_{2} h_{2}(y) \in A_{1}\left(\mathbb{R}^{n_{2}}\right)
$$

and

$$
\begin{equation*}
R_{1} h_{1}(x) R_{2} h_{2}(y) \in A_{1}^{*}\left(\mathbb{R}^{n_{1}+n_{2}}\right) \tag{3.5}
\end{equation*}
$$

According to the definition of associate spaces and (2.1) there exists measurable functions $h_{1}(x) \in \mathbf{Y}_{1}^{\prime}$ and $h_{2}(y) \in \mathbf{Y}_{2}^{\prime}$ such that $\left\|h_{1}\right\|_{\mathbf{Y}_{1}^{\prime}}=1,\left\|h_{2}\right\|_{\mathbf{Y}_{2}^{\prime}}=1$ and

$$
\begin{aligned}
\|F\|_{\left(\mathbf{X}_{1}, \mathbf{x}_{2}\right)}^{q_{0}} & =\left\||F|^{q_{0}}\right\|_{\left(\mathbf{Y}_{1}, \mathbf{Y}_{2}\right)} \\
& \leq C \int_{\mathbb{R}^{n_{2}}}\left\||F(\cdot, y)|^{q_{0}}\right\|_{\mathbf{Y}_{1}}\left|h_{2}(y)\right| d y \\
& \leq C \int_{\mathbb{R}^{n_{1}} \times \mathbb{R}^{n_{2}}}|F(x, y)|^{q_{0}}\left|h_{1}(x) \| h_{2}(y)\right| d x d y
\end{aligned}
$$

According to (3.2), we have

$$
\|F\|_{\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)}^{q_{0}} \leq C \int_{\mathbb{R}^{n_{1} \times \mathbb{R}^{n_{2}}}}|F(x, y)|^{q_{0}}\left|R_{1} h_{1}(x) \| R_{2} h_{2}(y)\right| d x d y
$$

Due to (3.1) and (3.5), we have

$$
\|F\|_{\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)}^{q_{0}} \leq C \int_{\mathbb{R}^{n_{1} \times \mathbb{R}^{n_{2}}}}|G(x, y)|^{q_{0}}\left|R_{1} h_{1}(x)\right|\left|R_{2} h_{2}(y)\right| d x d y
$$

By the definition of associate spaces, Hölder's inequalities are obtained. That is

$$
\int_{\mathbb{R}^{n}} f(x) g(y) d x d y \leq\|f\|_{\mathbf{x}}\|g\|_{\mathbf{X}^{\prime}}
$$

for $f \in \mathbf{X}$ and $g \in \mathbf{X}^{\prime}$. Thus,

$$
\begin{aligned}
\|F\|_{\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)}^{q_{0}} & \leq C \int_{\mathbb{R}^{n_{2}}}\left\||G(\cdot, y)|^{q_{0}}\right\|_{\mathbf{Y}_{1}}\left\|R_{1} h_{1}\right\|_{\mathbf{Y}_{1}^{\prime}}\left|R_{2} h_{2}(y)\right| d y \\
& \leq C\left\|\left.G\right|^{q_{0}}\right\|_{\left(\mathbf{Y}_{1}, \mathbf{Y}_{2}\right)}\left\|R_{1} h_{1}\right\|_{\mathbf{Y}_{1}^{\prime}}\left\|R_{2} h_{2}\right\|_{\mathbf{Y}_{2}^{\prime}}
\end{aligned}
$$

By (3.3),

$$
\begin{aligned}
\|F\|_{\left(\mathbf{X}_{1}, \mathbf{x}_{2}\right)}^{q_{0}} & \leq C\left\||G|^{q_{0}}\right\|_{\left(\mathbf{Y}_{1}, \mathbf{Y}_{2}\right)}\left\|h_{1}\right\|_{\mathbf{Y}_{1}^{\prime}}\left\|h_{2}\right\|_{\mathbf{Y}_{2}^{\prime}} \\
& =C\left\||G|^{q_{0}}\right\|_{\left(\mathbf{Y}_{1}, \mathbf{Y}_{2}\right)} \\
& =C\|G\|_{\left(\mathbf{X}_{1}, \mathbf{x}_{2}\right)}^{q_{0}} .
\end{aligned}
$$

The proof is completed.
Theorem 3.7 Let $\mathbf{X}_{1}$ and $\mathbf{X}_{2}$ be a ball quasi-Banach function spaces and satisfy Assumption 3.2 for $1<s_{0}<\infty$. Then there exists a positive constant $C_{0}$ such that, for any $f \in\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right)$,

$$
\|M f\|_{\left(\mathbf{x}_{1}, \mathbf{X}_{2}\right)} \leq C\left\|M^{\sharp} f\right\|_{\left(\mathbf{x}_{1}, \mathbf{x}_{2}\right)} .
$$

Proof Let

$$
\mathcal{F}:=\left\{\left(M f, M^{\sharp} f\right): f \in \bigcup_{\omega \in A_{1}^{*}\left(\mathbb{R}^{n}\right)} L_{\omega}^{p}\left(\mathbb{R}^{n}\right)\right\} .
$$

According to Lemma 3.1,

$$
\int_{\mathbb{R}^{n}}(M f(x))^{p} \omega(x) d x \leq C_{\left(p,[\omega]_{A_{1}^{*}\left(\mathbb{R}^{n}\right)}\right.} \int_{\mathbb{R}^{n}}\left(M^{\sharp} f(x)\right)^{p} \omega(x) d x
$$

for $1<p \leq s_{0}$. Then, apply Lemma 3.5,

$$
\|M f\|_{\left(\mathbf{x}_{1}, \mathbf{x}_{2}\right)} \leq C\left\|M^{\sharp} f\right\|_{\left(\mathbf{x}_{1}, \mathbf{X}_{2}\right)}
$$

for $f \in \bigcup_{\omega \in A_{1}\left(\mathbb{R}^{n}\right)} L_{\omega}^{s}\left(\mathbb{R}^{n}\right)$. Hence, by Lemma 3.4

$$
\|M f\|_{\left(\mathbf{x}_{1}, \mathbf{X}_{2}\right)} \leq C\left\|M^{\sharp} f\right\|_{\left(\mathbf{x}_{1}, \mathbf{X}_{2}\right)}, \quad f \in\left(\mathbf{X}_{1}, \mathbf{X}_{2}\right) .
$$

The proof is completed.
In fact, for the mixed-norm ball quasi-Banach function spaces $\left(\mathbf{X}_{1}, \mathbf{X}_{2}, \cdots, \mathbf{X}_{m}\right)$, the above discussions are right. Thus, we obtain the following corollary.

Corollary 3.8 Let $\mathbf{X}_{1}, \mathbf{X}_{2}, \cdots, \mathbf{X}_{m}$ be a ball quasi-Banach function space and satisfy Assumption 3.2 for $1<s_{0}<\infty$. Then there exists a positive constant $C_{0}$ such that, for any $f \in\left(\mathbf{X}_{1}, \mathbf{X}_{2}, \cdots, \mathbf{X}_{m}\right)$,

$$
\begin{equation*}
\|M f\|_{\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \cdots, \mathbf{x}_{m}\right)} \leq C\left\|M^{\sharp} f\right\|_{\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \cdots, \mathbf{x}_{m}\right)} . \tag{3.6}
\end{equation*}
$$

Taking $m=1$, we get the following corollary.
Corollary 3.9 Let $X$ be a ball quasi-Banach function space and satisfying Assumption 3.2 for $1<s_{0}<\infty$. Then there exists a positive constant $C_{0}$ such that, for any $f \in \mathbf{X}$,

$$
\begin{equation*}
\|M f\|_{\mathbf{x}} \leq C\left\|M^{\sharp} f\right\|_{\mathbf{x}} \tag{3.7}
\end{equation*}
$$

If $1<\vec{p}=\left(p_{1}, p_{2}, \cdots, p_{n}\right)<\infty$, we define that $p_{-}=\min \left\{p_{1}, p_{2}, \cdots, p_{n}\right\}$ and $p_{+}=$ $\max \left\{p_{1}, p_{2}, \cdots, p_{n}\right\}$.

By Remark 2.12, we know that mixed-norm Lebesgue spaces are a ball quasi-Banach function spaces. By Lemma 3.5 of [23], the $M f$ is bounded on $L^{\vec{p}}\left(\mathbb{R}^{n}\right)$ with $1<\vec{p}=$ $\left(p_{1}, p_{2}, \cdots, p_{n}\right)<\infty$. According to the dual theorem of Theorem 1.a of [7], there exist $1<s<p_{-}$such that $1<\frac{\vec{p}}{s}<\infty$ and the $M f$ is bounded on $L^{\left(\frac{\vec{p}}{s}\right)^{\prime}}\left(\mathbb{R}^{n}\right)$. Hence, (3.7) holds when $\mathbf{X}=L^{\vec{p}}\left(\mathbb{R}^{n}\right)$. That is the following theorem.

Theorem 3.10 Let $1<\vec{p}<\infty$. Then

$$
\|M f\|_{L^{\bar{p}}\left(\mathbb{R}^{n}\right)} \leq C\left\|M^{\sharp} f\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right)}
$$

hold for any $f \in L^{\vec{p}}\left(\mathbb{R}^{n}\right)$.
Remark 3.11 (1) It is well-known that $M$ is bounded on classical Lebesgue spaces. Thus, by Corollary 3.8, Theorem 3.10 can be obtained more simply.
(2) Comparing Corollary 3.8 and Corollary 3.9, we find that if $Y$ is a mixed-norm ball Banach function space, then using Corollary 3.8 will be more simple. But Corollary 3.9 can be applied in a wider range.

## 4 Application of Theorem 3.10

In this section, a necessary and sufficient conditions of boundedness of commutator of $I_{\alpha}$ is given on mixed-norm Lebesgue spaces. Particularly, we point out that $\vec{p} \neq \vec{q}$ means there exist $i_{0}$ such that $p_{i_{0}} \neq q_{i_{0}}$.

In 2020, Zhang and Zhou gave necessary and sufficient conditions [18]. Their result is stated as the following.

Lemma 4.1 Let $0<\alpha<n, 1<\vec{p}, \vec{q}<\infty$. Then

$$
1<\vec{p} \leq \vec{q}<\infty, \vec{p} \neq \vec{q}, \alpha=\sum_{i=1}^{n} \frac{1}{p_{i}}-\sum_{i=1}^{n} \frac{1}{q_{i}} .
$$

if and only if

$$
\left\|I_{\alpha} f\right\|_{L^{\vec{q}}} \leq C\|f\|_{L^{\vec{p}}}
$$

The following result can be proved by the means of Theorem 1.3 of [22] and the fact $M_{\alpha}(f)(x) \lesssim I_{\alpha}(|f|)(x)$.

Lemma 4.2 Let $0<\alpha<n, 1<r<\infty$ and $b \in B M O\left(\mathbb{R}^{n}\right)$. Then there exists a constant $C>0$ independent of $b$ and $f$ such that

$$
M^{\sharp}\left(\left[b, I_{\alpha}\right](f)\right)(x) \leq C\|b\|_{B M O\left(\mathbb{R}^{n}\right)}\left\{I_{\alpha}(|f|)(x)+I_{r \alpha}\left(|f|^{r}\right)(x)^{\frac{1}{r}}\right\} .
$$

The characterization of $B M O\left(\mathbb{R}^{n}\right)$ is given by the following theorem.
Theorem 4.3 Let $0<\alpha<n, 1<\vec{p}, \vec{q}<\infty$ and

$$
1<\vec{p} \leq \vec{q}<\infty, \vec{p} \neq \vec{q}, \alpha=\sum_{i=1}^{n} \frac{1}{p_{i}}-\sum_{i=1}^{n} \frac{1}{q_{i}} .
$$

Then, the following conditions are equivalent:
(a) $b \in B M O\left(\mathbb{R}^{n}\right)$.
(b) $\left[b, I_{\alpha}\right]$ is bounded from $L^{\vec{p}}$ to $L^{\vec{q}}$.

Proof (1) By theorem 3.10, Lemma 4.2 and Lemma 4.1,

$$
\begin{aligned}
\left\|\left[b, I_{\alpha}\right] f\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)} & \leq C\left\|M\left(\left[b, I_{\alpha}\right](f)\right)\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \\
& \leq C\left\|M^{\sharp}\left(\left[b, I_{\alpha}\right](f)\right)\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \\
& \leq C\|b\|_{B M O\left(\mathbb{R}^{n}\right)}\left(\left\|I_{\alpha}(|f|)\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)}+\left\|I_{r \alpha}\left(|f|^{r}\right)^{\frac{1}{r}}\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)}\right) \\
& =C\|b\|_{B M O\left(\mathbb{R}^{n}\right)}\left(\left\|I_{\alpha}(|f|)\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)}+\left\|I_{r \alpha}\left(|f|^{r}\right)\right\|_{L^{\vec{q} / r}\left(\mathbb{R}^{n}\right)}\right) \\
& \left.\leq C\|b\|_{B M O\left(\mathbb{R}^{n}\right)}\right)\|f\|_{L_{\vec{p}\left(\mathbb{R}^{n}\right)}}
\end{aligned}
$$

(2) Assume that $\left[b, I_{\alpha}\right]$ is bounded from $L^{\vec{p}}$ to $L^{\vec{q}}$. We use the same method as Janson [24]. Choose $0 \neq z_{0} \in \mathbb{R}^{n}$ such that $0 \notin Q\left(z_{0}, 2 \sqrt{n}\right)$. Then for $x \in Q\left(z_{0}, 2 \sqrt{n}\right),|x|^{n-\alpha} \in$ $C^{\infty}\left(Q\left(z_{0}, 2 \sqrt{n}\right)\right)$. Hence, $|x|^{n-\alpha}$ can be written as the absolutely convergent Fourier series:

$$
|x|^{n-\alpha} \chi_{Q\left(z_{0}, 2\right)}(x)=\sum_{m \in \mathbb{Z}^{n}} a_{m} e^{2 i m \cdot x} \chi_{Q\left(z_{0}, 2 \sqrt{n}\right)}(x)
$$

with $\sum_{m \in \mathbb{Z}^{n}}\left|a_{m}\right|<\infty$.
For any $x_{0} \in \mathbb{R}^{n}$ and $t>0$, let $Q=Q\left(x_{0}, t\right)$ and $Q_{z_{0}}=Q\left(x_{0}+z_{0} t, t\right)$. Let $s(x)=$ $\overline{\operatorname{sgn}\left(\int_{Q^{\prime}}(b(x)-b(y)) d y\right)}$. Then

$$
\begin{aligned}
& \frac{1}{|Q|} \int_{Q}\left|b(x)-b_{Q_{z_{0}}}\right| \\
= & \frac{1}{|Q|} \frac{1}{\left|Q_{z_{0}}\right|} \int_{Q}\left|\int_{Q_{z_{0}}}(b(x)-b(y)) d y\right| d x \\
= & \frac{1}{|Q|} \frac{1}{\left|Q_{z_{0}}\right|} \int_{Q} \int_{Q_{z_{0}}} s(x)(b(x)-b(y)) d y d x .
\end{aligned}
$$

If $x \in Q$ and $y \in Q_{z_{0}}$, then $\frac{y-x}{t} \in Q\left(z_{0}, 2 \sqrt{n}\right)$. Thereby,

$$
\begin{aligned}
& \frac{1}{|Q|} \int_{Q}\left|b(x)-b_{Q_{z_{0}}}\right| \\
= & t^{-2 n} \int_{Q} \int_{Q_{z_{0}}} s(x)(b(x)-b(y))|x-y|^{\alpha-n}|x-y|^{n-\alpha} d y d x \\
= & t^{-2 n} \int_{Q} \int_{Q_{z_{0}}} s(x)(b(x)-b(y))|x-y|^{\alpha-n}|x-y|^{n-\alpha} d y d x \\
= & t^{-n-\alpha} \int_{Q} \int_{Q_{z_{0}}} s(x)(b(x)-b(y))|x-y|^{\alpha-n}\left(\frac{|x-y|}{t}\right)^{n-\alpha} d y d x \\
= & t^{-n-\alpha} \sum_{m \in \mathbb{Z}^{n}} a_{m} \int_{Q} \int_{Q_{z_{0}}} s(x)(b(x)-b(y))|x-y|^{\alpha-n} e^{-2 i m \cdot \frac{y}{t}} d y \times e^{2 i m \cdot \frac{x}{t}} d x \\
= & t^{-n-\alpha} \sum_{m \in \mathbb{Z}^{n}} a_{m} \int_{Q}\left[b, I_{\alpha}\right]\left(e^{-2 i m \cdot \cdot \dot{t}} \chi_{Q_{z_{0}}}\right)(x) \times s(x) e^{2 i m \cdot \frac{x}{t}} d x .
\end{aligned}
$$

By Hölder for mixed-norm Lebesgue spaces,

$$
\frac{1}{|Q|} \int_{Q}\left|b(x)-b_{Q_{z_{0}}}\right| \leq t^{-n-\alpha} \sum_{m \in \mathbb{Z}^{n}} a_{m}\left\|\left[b, I_{\alpha}\right]\left(e^{-2 i m \cdot \dot{\bar{t}}} \chi_{Q_{z_{0}}}\right)\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)}\left\|s \cdot e^{-2 i m \cdot \dot{\dot{t}}} \chi_{Q}\right\|_{L^{\vec{q}^{\prime}}\left(\mathbb{R}^{n}\right)}
$$

It is easy to calculate

$$
\left\|s \cdot e^{-2 i m \cdot \dot{\bar{t}}} \chi_{Q}\right\|_{L^{\vec{q}^{\prime}}\left(\mathbb{R}^{n}\right)}=\left\|\chi_{Q}\right\|_{L^{q^{\prime}}\left(\mathbb{R}^{n}\right)}=t^{\sum_{i=1}^{n} \frac{1}{q_{i}^{\prime}}} .
$$

Hence,

$$
\frac{1}{|Q|} \int_{Q}\left|b(x)-b_{Q_{z_{0}}}\right|=t^{-n-\alpha+\sum_{i=1}^{n} \frac{1}{q_{i}}} \sum_{m \in \mathbb{Z}^{n}} a_{m}\left\|\left[b, I_{\alpha}\right]\left(e^{-2 i m \cdot \dot{\bar{t}}} \chi_{Q_{z_{0}}}\right)\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)}
$$

According to the hypothesis

$$
\begin{aligned}
& \frac{1}{|Q|} \int_{Q}\left|b(x)-b_{Q_{z_{0}}}\right| \\
\leq & t^{-n-\alpha+\sum_{i=1}^{n} \frac{1}{q_{i}^{\prime}}} \sum_{m \in \mathbb{Z}^{n}} a_{m}\left\|e^{-2 i m \cdot \dot{\dot{t}}} \chi_{Q_{z_{0}}}\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right)}\left\|\left[b, I_{\alpha}\right]\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right) \rightarrow L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \\
= & t^{-n-\alpha+\sum_{i=1}^{n} \frac{1}{q_{i}}+\sum_{i=1}^{n} \frac{1}{p_{i}}} \sum_{m \in \mathbb{Z}^{n}} a_{m}\left\|\left[b, I_{\alpha}\right]\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right) \rightarrow L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \\
\leq & \sum_{m \in \mathbb{Z}^{n}}\left|a_{m}\right|\left\|\left[b, I_{\alpha}\right]\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right) \rightarrow L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \leq C\left\|\left[b, I_{\alpha}\right]\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right) \rightarrow L^{\vec{q}}\left(\mathbb{R}^{n}\right)} .
\end{aligned}
$$

Thus, we have

$$
\frac{1}{|Q|} \int_{Q}|b(x)-b(y)| d x \leq \frac{2}{|Q|} \int_{Q}\left|b(x)-b_{Q_{z_{0}}}\right| d x \leq C\left\|\left[b, I_{\alpha}\right]\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right) \rightarrow L^{\vec{q}}\left(\mathbb{R}^{n}\right)}
$$

This prove $b \in B M O\left(\mathbb{R}^{n}\right)$.
Remark 4.4 If

$$
\alpha=\sum_{i=1}^{n} \frac{1}{p_{i}}-\sum_{i=1}^{n} \frac{1}{q_{i}}, p_{j} \sum_{i=1}^{n} \frac{1}{p_{i}}=q_{j} \sum_{i=1}^{n} \frac{1}{q_{i}}(j=1, \cdots, n),
$$

it easy to prove

$$
\sum_{i=1}^{n} \frac{1}{p_{i}}>\sum_{i=1}^{n} \frac{1}{q_{i}}, 1<\vec{p}<\vec{q}<\infty
$$

## 5 Characterization of homogeneous Lipschitz space

In this section, a characterization of homogeneous Lipschitz spaces is given. Let us recall the definition of homogeneous Lipschitz spaces.

Definition 5.1 Let $0<\beta<1$. The definition of homogeneous Lipschitz space is defined by

$$
\dot{\Lambda}_{\beta}:=\left\{f:|f(x)-f(y)| \leq C|x-y|^{\beta}\right\} .
$$

The following lemma can be found in Lemma 1.5 of [25].
Lemma 5.2 If $0<\beta<1$ and $1<q \leq \infty$, then

$$
\begin{aligned}
\|f\|_{\dot{\Lambda}_{\beta}} & \approx \sup _{Q \subset \mathbb{R}^{n}} \frac{1}{|Q|^{1+\beta / n}} \int_{Q}\left|f(y)-f_{Q}\right| d y \\
& \approx \sup _{Q \subset \mathbb{R}^{n}} \frac{1}{|Q|^{\beta / n}}\left(\frac{1}{|Q|} \int_{Q}\left|f(y)-f_{Q}\right|^{q} d y\right)^{\frac{1}{q}}
\end{aligned}
$$

for $q=\infty$ the formula should be interpreted appropriately, where the supremum is taken over all cubes $Q$ in $\mathbb{R}^{n}$.

Theorem 5.3 Let $0<\alpha<n, 0<\beta<1,1<\vec{p}, \vec{q}<\infty$ and

$$
1<\vec{p} \leq \vec{q}<\infty, \vec{p} \neq \vec{q}, \alpha+\beta=\sum_{i=1}^{n} \frac{1}{p_{i}}-\sum_{i=1}^{n} \frac{1}{q_{i}} .
$$

Then, the following conditions are equivalent:
(a) $b \in \dot{\Lambda}_{\beta}$.
(b) $\left[b, I_{\alpha}\right]$ is bounded from $L^{\vec{p}}\left(\mathbb{R}^{n}\right)$ to $L^{\vec{q}}\left(\mathbb{R}^{n}\right)$.

Proof (1) Let $b \in \dot{\Lambda}_{\beta}$. Then

$$
\begin{aligned}
\left|\left[b, I_{\alpha}\right] f(x)\right| & =\left|\int_{\mathbb{R}^{n}} \frac{(b(x)-b(y)) f(y)}{|x-y|^{n-\alpha}} d y\right| \\
& \leq \int_{\mathbb{R}^{n}} \frac{|b(x)-b(y)| \cdot|f(y)|}{|x-y|^{n-\alpha}} d y \\
& \leq\|b\|_{\dot{\Lambda}_{\beta}} \int_{\mathbb{R}^{n}} \frac{|f(y)|}{|x-y|^{n-(\alpha+\beta)}} d y \\
& =\|b\|_{\dot{\Lambda}_{\beta}} I_{\alpha+\beta}(|f|)(x) .
\end{aligned}
$$

According to Lemma 4.1,

$$
\left\|\left[b, I_{\alpha}\right] f\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \leq C\|b\|_{\dot{\Lambda}_{\beta}}\left\|I_{\alpha+\beta}(|f|)\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \leq C\|b\|_{\dot{\Lambda}_{\beta}}\|f\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right)}
$$

(2) Let $\left[b, I_{\alpha}\right]$ is bounded from $L^{\vec{p}}\left(\mathbb{R}^{n}\right)$ to $L^{\vec{q}}\left(\mathbb{R}^{n}\right)$. Let $Q, Q_{z_{0}}$ and $s(x)$ is the same as Theorem 4.4. It is easy to calculate that

$$
\begin{aligned}
& \frac{1}{|Q|} \int_{Q}\left|b(x)-b_{Q_{z_{0}}}\right| \\
= & t^{-n-\alpha} \sum_{m \in \mathbb{Z}^{n}} a_{m} \int_{Q}\left[b, I_{\alpha}\right]\left(e^{-2 i m \cdot \dot{t}} \chi_{Q_{0}}\right)(x) \times s(x) e^{2 i m \cdot \frac{x}{t}} d x \\
\leq & t^{-n-\alpha} \sum_{m \in \mathbb{Z}^{n}} a_{m}\left\|\left[b, I_{\alpha}\right]\left(e^{-2 i m \cdot \dot{t}} \chi_{Q_{z_{0}}}\right)\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)}\left\|s \cdot e^{-2 i m \cdot \dot{\dot{t}}} \chi_{Q}\right\|_{L^{\overrightarrow{q^{\prime}}\left(\mathbb{R}^{n}\right)}} \\
= & t^{-n-\alpha+\sum_{i=1}^{n} \frac{1}{q_{i}}+\sum_{i=1}^{n} \frac{1}{p_{i}}} \sum_{m \in \mathbb{Z}^{n}} a_{m}\left\|\left[b, I_{\alpha}\right]\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right) \rightarrow L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \\
\leq & t^{\beta} \sum_{m \in \mathbb{Z}^{n}}\left|a_{m}\right|\left\|\left[b, I_{\alpha}\right]\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right) \rightarrow L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \leq C t^{\beta}\left\|\left[b, I_{\alpha}\right]\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right) \rightarrow L^{\vec{q}}\left(\mathbb{R}^{n}\right)} .
\end{aligned}
$$

Therefore,

$$
\frac{1}{|Q|^{1+\beta / n}} \int_{Q}\left|b(x)-b_{Q}\right| \leq \frac{2}{|Q|^{1+\beta / n}} \int_{Q}\left|b(x)-b_{Q_{z_{0}}}\right| \leq 2 C\left\|\left[b, I_{\alpha}\right]\right\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right) \rightarrow L^{\vec{q}}\left(\mathbb{R}^{n}\right)}
$$

Due to Lemma 5.2, the proof is completed.
By the process of Theorem 5.3, the following corollary holds.
Corollary 5.4 Let $T f$ is a operator and its commutator $[b, T](f)$ satisfies that

$$
|[b, T] f(x)| \leq C I_{\alpha, b}(|f|)(x)
$$

Let $0<\alpha<n, 0<\beta<1,1<\vec{p}, \vec{q}<\infty$. If

$$
1<\vec{p} \leq \vec{q}<\infty, \vec{p} \neq \vec{q}, \alpha+\beta=\sum_{i=1}^{n} \frac{1}{p_{i}}-\sum_{i=1}^{n} \frac{1}{q_{i}}
$$

and $b \in \dot{\Lambda}_{\beta}$, then

$$
\|[b, T] f\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \leq C\|b\|_{\dot{\Lambda}_{\beta}}\|f\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right)} .
$$

Proof Let $b \in \dot{\Lambda}_{\beta}$. Then

$$
\begin{aligned}
|[b, T] f(x)| & \leq C \int_{\mathbb{R}^{n}} \frac{|b(x)-b(y)| \cdot|f(y)|}{|x-y|^{n-\alpha}} d y \\
& \leq C\|b\|_{\dot{\Lambda}_{\beta}} \int_{\mathbb{R}^{n}} \frac{|f(y)|}{|x-y|^{n-(\alpha+\beta)}} d y \\
& =C\|b\|_{\dot{\Lambda}_{\beta}} I_{\alpha+\beta}(|f|)(x) .
\end{aligned}
$$

According to Lemma 4.1,

$$
\left\|\left[b, I_{\alpha}\right] f\right\|_{L^{\vec{q}}\left(\mathbb{R}^{n}\right)} \leq C\|b\|_{\dot{\Lambda}_{\beta}}\left\|I_{\alpha+\beta}(|f|)\right\|_{L^{\vec{q}\left(\mathbb{R}^{n}\right)}} \leq C\|b\|_{\dot{\Lambda}_{\beta}}\|f\|_{L^{\vec{p}}\left(\mathbb{R}^{n}\right)}
$$

The proof is completed.
The corollary is very useful and two examples are given in the following section.

## 6 Two applications of Corollary 5.4

Example 6.1 The fractional maximal function is defined as

$$
M_{\alpha} f(x):=\sup _{Q \ni x} \frac{1}{|Q|^{1-\frac{\alpha}{n}}} \int_{Q}|f(y)| d y
$$

where the supremum is taken over all cube $Q \subset \mathbb{R}^{n}$ containing $x$ and its commutator is defined by

$$
M_{\alpha, b} f(x):=\sup _{Q \ni x} \frac{1}{|Q|^{1-\frac{\alpha}{n}}} \int_{Q}|b(x)-b(y)||f(y)| d y
$$

where $b$ a locally integrable function. It is easy to prove that

$$
\left|M_{\alpha, b} f(x)\right| \leq C I_{\alpha, b}(|f|)(x)
$$

Before the second example, let us recall generalized fractional integral operators.
Suppose that $\mathcal{L}$ is a linear operator which generates an analytic semigroup $\left\{e^{-t \mathcal{L}}\right\}_{t>0}$ on $L^{2}\left(\mathbb{R}^{n}\right)$ with a kernel $p_{t}(x, y)$ satisfying Gaussian upper bound; that is

$$
\left|p_{t}(x, y)\right| \leq \frac{C_{1}}{t^{n / 2}} e^{-C_{2} \frac{|x-y|^{2}}{t}} \quad x, y \in \mathbb{R}^{n}
$$

where $C_{1}, C_{2}>0$ are independent of $x, y$ and $t$.

For any $0<\alpha<n$, the generalized fractional integrals $\mathcal{L}^{-\alpha / 2}$ associated with the operator $\mathcal{L}$ is defined by

$$
\mathcal{L}^{-\alpha / 2} f(x)=\frac{1}{\Gamma(\alpha / 2)} \int_{0}^{\infty} e^{-t \mathcal{L}}(f)(x) \frac{d t}{t^{-\alpha / 2+1}} .
$$

Note that if $\mathcal{L}=-\Delta$ is the Laplacian on $\mathbb{R}^{n}$, then $\mathcal{L}^{-\alpha / 2}$ is the classical fractional intergral operator $I_{\alpha}$. See, for example, Chapter 5 of [26]. Since the semigroup $\mathcal{L}^{-\alpha / 2}$ has a kernel $p_{t}(x, y)$, it is easy to check that for all $x \in \mathbb{R}^{n}$

$$
\left|\mathcal{L}^{-\alpha / 2} f(x)\right| \leq C I_{\alpha}(|f|)(x)
$$

(see [27]). In fact, if we denote the the kernel of $\mathcal{L}^{-\alpha / 2}$ by $K_{\alpha}(x, y)$, it is easy to obtain that

$$
\begin{aligned}
\mathcal{L}^{-\alpha / 2} f(x) & =\frac{1}{\Gamma(\alpha / 2)} \int_{0}^{\infty} e^{-t \mathcal{L}}(f)(x) \frac{d t}{t^{-\alpha / 2+1}} \\
& =\frac{1}{\Gamma(\alpha / 2)} \int_{0}^{\infty} \int_{\mathbb{R}^{n}} p_{t}(x, y) f(y) d y \frac{d t}{t^{-\alpha / 2+1}} \\
& =\int_{\mathbb{R}^{n}} \frac{1}{\Gamma(\alpha / 2)} \int_{0}^{\infty} p_{t}(x, y) \frac{d t}{t^{-\alpha / 2+1}} \cdot f(y) d y \\
& =\int_{\mathbb{R}^{n}} K_{\alpha}(x, y) \cdot f(y) d y
\end{aligned}
$$

Hence, by Gaussian upper bound,

$$
\begin{aligned}
\left|K_{\alpha}(x, y)\right| & =\left|\frac{1}{\Gamma(\alpha / 2)} \int_{0}^{\infty} p_{t}(x, y) \frac{d t}{t^{-\alpha / 2+1}}\right| \\
& \leq \frac{1}{\Gamma(\alpha / 2)} \int_{0}^{\infty}\left|p_{t}(x, y)\right| \frac{d t}{t^{-\alpha / 2+1}} \\
& \leq C \int_{0}^{\infty} e^{-C_{2} \frac{|x-y|^{2}}{t}} \frac{d t}{t^{n / 2-\alpha / 2+1}} \\
& \leq C \cdot \frac{1}{|x-y|^{n-\alpha}}
\end{aligned}
$$

Example 6.2 Let $b$ a locally integrable function. If the commutators of generalized fractional integral operators generated by $b$ and $\mathcal{L}^{-\alpha / 2}$ are defined by

$$
\left[b, \mathcal{L}^{-\alpha / 2}\right]:=b(x) \mathcal{L}^{-\alpha / 2}(f)(x)-\mathcal{L}^{-\alpha / 2}(b f)(x)
$$

It is obvious that

$$
\begin{aligned}
\left|\left[b, \mathcal{L}^{-\alpha / 2}\right] f(x)\right| & =\left|\int_{\mathbb{R}^{n}}(b(x)-b(y)) K_{\alpha}(x, y) f(y) d y\right| \\
& \leq \int_{\mathbb{R}^{n}}|b(x)-b(y)|\left|K_{\alpha}(x, y)\right||f(y)| d y \\
& \leq C \int_{\mathbb{R}^{n}}|b(x)-b(y)| \frac{|f(y)|}{|x-y|^{n-\alpha}} d y \\
& =C I_{\alpha, b}(|f|)(x)
\end{aligned}
$$
