# CONIVEAU FILTRATIONS AND MILNOR OPERATION $Q_{n}$ 

NOBUAKI YAGITA


#### Abstract

Let $B G$ be the classifying space of an algebraic group $G$ over the field $\mathbb{C}$ of complex numbers. We compute a new stable birational invariant defined by the difference of two coniveau filtrations of a smooth projective approximation of $B G \times \mathbb{P}^{\infty}$.


## 1. Introduction

Let $p$ be a prime number and $A=\mathbb{Q}, \mathbb{Z}$ or $\mathbb{Z} / p^{i}$ for $i \geq 1$. Let $X$ be a smooth algebraic variety over $k=\mathbb{C}$. Let us recall the coniveau filtration of the cohomology with coefficients in $A$,

$$
N^{c} H^{i}(X ; A)=\sum_{Z \subset X} \operatorname{ker}\left(j^{*}: H^{i}(X ; A) \rightarrow H^{i}(X-Z, A)\right)
$$

where $Z \subset X$ runs through the closed subvarieties of codimension at least $c$ of $X$, and $j: X-Z \subset X$ is the complementary open immersion.

Similarly, we can define the strong coniveau filtration by

$$
\tilde{N}^{c} H^{i}(X ; A)=\sum_{f: Y \rightarrow X} i m\left(f_{*}: H^{i-2 r}(Y ; A) \rightarrow H^{i}(X, A)\right)
$$

where the sum is over all proper morphism $f: Y \rightarrow X$ from a smooth complex variety $Y$ of $\operatorname{dim}(Y)=\operatorname{dim}(X)-r$ with $r \geq c$, and $f_{*}$ its transfer (Gysin map). It is immediate that $\tilde{N}^{c} H^{*}(X ; A) \subset N^{c} H^{*}(X ; A)$.

It was hoped that when $X$ is proper, the strong coniveau filtration was just the coniveau filtration, i.e., $\tilde{N}^{c} H^{i}(X ; A)=N^{c} H^{i}(X ; A)$. In fact Deligne shows they are the same for $A=\mathbb{Q}$. However, Benoist and Ottem ([1]) recently show that they are not equal for $A=\mathbb{Z}$.

Let $G$ be an algebraic group such that $H^{*}(B G ; \mathbb{Z})$ has $p$-torsion for the classifying space $B G$ defined by Totaro [17. The purpose of this paper is to compute the $\bmod (p)$ stable birational invariant of $X($ Proposition 2.4 in [1])

$$
D H^{*}(X ; A)=N^{1} H^{*}(X ; A) /\left(p, \tilde{N}^{1} H^{*}(X ; A)\right)
$$

for projective approximations $X$ for $B G([4,[17,10])$. In fact, we see that $D H^{*}(X ; \mathbb{Z}) \neq 0$ happen very frequently in the above cases.

Here an approximation (for degree $\leq N$ ) is the projective (smooth) variety $X=X(N)$ such that there is a map $g: X \rightarrow B G \times \mathbb{P}^{\infty}$ with

$$
g^{*}: H^{*}\left(B G \times \mathbb{P}^{\infty} ; A\right) \cong H^{*}(X ; A) \quad \text { for } *<N
$$

(In this paper, we say $X$ is an approximation for $B G$ when it is that of $B G \times \mathbb{P}^{\infty}$ strictly speaking.) Let us write $D H^{*}(X ; \mathbb{Z})$ by $D H^{*}(X)$ simply as usual.

[^0]Here we give an example that we can compute a nonzero $D H^{*}(X)$. For $G=$ $(\mathbb{Z} / p)^{3}$ the elementary abelian $p$-group of rank $=3$, we know (for $p$ odd)

$$
\begin{gathered}
H^{*}(B G ; \mathbb{Z} / p) \cong \mathbb{Z} / p\left[y_{1}, y_{2}, y_{3}\right] \otimes \Lambda\left(x_{1}, x_{2}, x_{3}\right), \quad\left|x_{i}\right|=1, \quad Q_{0}\left(x_{i}\right)=y_{i} \\
H^{*}(B G) / p \cong \mathbb{Z} / p\left[y_{1}, y_{2}, y_{3}\right]\left(1, Q_{0}\left(x_{i} x_{j}\right), Q_{0}\left(x_{1} x_{2} x_{3}\right) \mid 1 \leq i<j \leq 3\right)
\end{gathered}
$$

where $Q_{0}=\beta$ is the Bockstein operation, and the notation $R(a, \ldots, b)$ (resp. $R\{a, \ldots, b\}$ ) means the $R$-submodule (resp. the free $R$-module) generated by $a, \ldots, b$.

Theorem 1.1. Let $G=(\mathbb{Z} / p)^{3}$. Given $N>2 p+3$, there are approximations $X=X(N)$ for $B G$ such that we have for $\alpha_{i j}=Q_{0}\left(x_{i} x_{j}\right), \alpha=Q_{0}\left(x_{1} x_{2} x_{3}\right)$

$$
\begin{gathered}
D H^{*}(X) \cong D H^{3}(X) \oplus D H^{4}(X) \\
\cong \mathbb{Z} / p\left\{\alpha_{i j}, \alpha \mid 1 \leq i<j \leq 3\right\} \quad \text { when } *<N .
\end{gathered}
$$

But we have $D H^{*}(X ; \mathbb{Z} / p)=0$ when $*<N$.
Benoist and Ottem give examples, where the above invariants are nonzero for $A=\mathbb{Z}_{(2)}$ by using the Steenrod squares. We note that some of their arguments can be extended for $A=\mathbb{Z}_{(p)}$ by using the Milnor operation $Q_{n}$ for odd primes $p$. However it seems not so easy to give a nontrivial example for $A=\mathbb{Z} / p$ in the case $X$ is an approximation for $B G$ as the above examples show.

For connected groups we have
Theorem 1.2. Let $G$ be a simply connected group such that $H^{*}(B G)$ has ptorsion. Then there is an approximation $X$ for $B G$ such that $D H^{4}(X) \neq 0$.
Theorem 1.3. Let $p$ be an odd prime number, and $G=P G L_{p}$. Then there is an approximation $X$ for $B G$ such that $D H^{3}(X) \neq 0$.
Theorem 1.4. Let $p=2$ and $X_{n}=X_{n}(N)$ be approximations for $B S O_{n}$ with $n \geq 3$. Then for sufficient large $N$

$$
D H^{*}\left(X_{2 m+1}\right) \supset \mathbb{Z} / 2\left\{w_{3}, w_{5}, \ldots, w_{2 m+1}\right\} \quad \text { for } *<N
$$

where $w_{i}$ is the $i$-th Stiefel-Whiteny class.

## 2. TRANSFER AND $Q_{n}$

The Milnor operation (in $H^{*}(-; \mathbb{Z} / p)$ ) is defined by $Q_{0}=\beta$ and for $n \geq 1$

$$
Q_{n}=P^{\Delta_{n}} \beta-\beta P^{\Delta_{n}}, \quad \Delta_{n}=(0, \ldots, 0, \stackrel{n}{1}, 0, \ldots)
$$

(For details see [8], $\S 3.1$ in [18]) where $\beta$ is the Bockstein operation and $P^{\alpha}$ for $\alpha=\left(\alpha_{1}, \alpha_{2}, \ldots\right)$ is the fundamental base of the module of finite sums of products of reduced powers. .

Lemma 2.1. Let $f_{*}$ be the transfer (Gysin) map (for proper smooth) $f: X \rightarrow Y$. Then $Q_{n} f_{*}(x)=f_{*} Q_{n}(x)$ for $x \in H^{*}(X ; \mathbb{Z} / p)$.

The above lemma is known (see the proof of Lemma 7.1 in [23]). The transfer $f_{*}$ is expressed as $g^{*} f_{*}^{\prime}$ such that

$$
f_{*}^{\prime}(x)=i^{*}(\operatorname{Th}(1) \cdot x), \quad x \in H^{*}(X ; \mathbb{Z} / p)
$$

for some maps $g, f^{\prime}, i$ and the Thom class $T h(1)$. Since $Q_{n}(T h(1))=0$ and $Q_{i}$ is a derivation, we get the lemma. However, we give here the another computational proof.

Proof of Lemma 2.1. Recall the following Grothendieck formula (e.g., [Q1])

$$
\text { (1) } \quad P_{t}\left(f_{*}(x)\right)=f_{*}\left(c_{t} \cdot P_{t}(x)\right)
$$

Here the total reduced powers $P_{t}(x)$ are defined

$$
P_{t}(x)=\sum_{\alpha} P^{\alpha}(x) t^{\alpha} \in H^{*}(X ; \mathbb{Z} / p)\left[t_{1}, t_{2}, \ldots\right] \quad \text { with } t^{\alpha}=t_{1}^{\alpha_{1}} t_{2}^{\alpha_{2}} \ldots
$$

where $\alpha=\left(\alpha_{1}, \alpha_{2}, \ldots\right)$ and degree $\left(t^{\alpha}\right)=\sum_{i} 2 \alpha_{i}\left(p^{i}-1\right)\left(\right.$ each element in $H^{*}(X ; \mathbb{Z} / p)$ is represented as a homogeneous part respective to the above degree). The total Chern class $c_{t}$ is defined similarly, for the Chern classes of the normal bundle of the map $f$.

We consider the above equation with the assumption such that $t_{n}^{2}=0$ and $t_{j}=0$ for $j \neq n$, i.e., $P_{t}(x) \in H^{*}(X ; \mathbb{Z} / p) \otimes \Lambda\left(t_{n}\right)$. That means

$$
\text { (2) } \quad P_{t}\left(f_{*}(x)\right)=\left(1+P^{\Delta_{n}} t_{n}\right)\left(f_{*}(x)\right)
$$

(3) $\quad f_{*}\left(c_{t} \cdot P_{t}(x)\right)=f_{*}\left(\left(1+c_{p^{n}-1} t_{n}\right)\left(x+P^{\Delta_{n}}(x) t_{n}\right)\right)=f_{*}\left(x+\left(c_{p^{n}-1} x+P^{\Delta_{n}}(x)\right) t_{n}\right)$. From (1), we see $(2)=(3)$ and we have

$$
\text { (4) } \quad P^{\Delta_{n}}\left(f_{*}(x)\right)=f_{*}\left(c_{p^{n}-1} x+P^{\Delta_{n}}(x)\right) \text {. }
$$

By the definition, $\beta$ commutes with $f_{*}$, and we have

$$
\text { (5) } \quad P^{\Delta_{n}} \beta\left(f_{*}(x)\right)=P^{\Delta_{n}} f_{*}(\beta x)=f_{*}\left(c_{p^{n}-1} \beta x+P^{\Delta_{n}}(\beta x)\right) \text {. }
$$

On the other hand

$$
\text { (6) } \beta P^{\Delta_{n}} f_{*}(x) \stackrel{(4)}{=} \beta f_{*}\left(c_{p^{n}-1} x+P^{\Delta_{n}}(x)\right)=f_{*}\left(c_{p^{n}-1} \beta x+\beta P^{\Delta_{n}}(x)\right) \text {. }
$$

Then (5) - (6) gives that $\left(P^{\Delta_{n}} \beta-\beta P^{\Delta_{n}}\right) f_{*}(x)=f_{*}\left(P^{\Delta_{n}} \beta-\beta P^{\Delta_{n}}\right)(x)$.
By the definition, each cohomology operation $h$ (i.e., an element in the Steenrod algebra) is written (with $Q^{B}=Q_{0}^{b_{0}} Q_{1}^{b_{1}} \ldots$ ) by

$$
h=\sum_{A, B} P^{A} Q^{B} \quad \text { with } A=\left(a_{1}, \ldots\right), B=\left(b_{0}, \ldots\right) b_{i}=0 \text { or } 1
$$

Corollary 2.2. We have $P_{t} Q^{B}\left(f_{*}(x)\right)=f_{*}\left(c_{t} \cdot P_{t} Q^{B}(x)\right)$.
Hence cohomology operations $h$ (for $H^{*}(-; \mathbb{Z} / p)$ ) which commute with all transfer $f_{*}$ are cases $c_{t}=1$, i.e. $A=0$ which are only products $Q^{B}$ of Milnor operations $Q_{i}$.

## 3. CONIVEAU FILTRATIONS

Bloch-Ogus [2] give a spectral sequence such that its $E_{2}$-term is given by

$$
E(c)_{2}^{c, *-c} \cong H_{Z a r}^{c}\left(X, \mathcal{H}_{A}^{*-c}\right) \Longrightarrow H_{e t}^{*}(X ; A)
$$

where $\mathcal{H}_{A}^{*}$ is the Zariski sheaf induced from the presheaf given by $U \mapsto H_{e t}^{*}(U ; A)$ for an open $U \subset X$.

The filtration for this spectral sequence is defined as the coniveau filtration

$$
N^{c} H_{e t}^{*}(X ; A)=F(c)^{c, *-c}
$$

where the infinite term $E(c)_{\infty}^{c, *-c} \cong F(c)^{c, *-c} / F(c)^{c+1, *-c-1}$ and

$$
N^{c} H_{e t}^{*}(X ; A)=\sum_{Z \subset X ; \operatorname{codim}_{X}(Z) \leq c} \operatorname{ker}\left(j^{*}: H_{e t}^{*}(X ; A) \rightarrow H_{e t}^{*}(X-Z, A)\right) .
$$

Here we recall the motivic cohomology $H^{*, *^{\prime}}(X ; \mathbb{Z} / p)$ defined by Voevodsky and Suslin $([18, ~ 20, ~ 21])$ so that

$$
H^{i, i}(X ; \mathbb{Z} / p) \cong H_{e t}^{i}(X ; \mathbb{Z} / p) \cong H^{i}(X ; \mathbb{Z} / p)
$$

Let us write $H_{e t}^{*}(X ; \mathbb{Z})$ simply by $H_{e t}^{*}(X)$ as usual. Note that we do not assume $H_{e t}^{*}(X) \cong H^{*}(X)$ while we have the natural map $H_{e t}^{*}(X) \rightarrow H^{*}(X)$.

Let $0 \neq \tau \in H^{0,1}(\operatorname{Spec}(\mathbb{C}) ; \mathbb{Z} / p)$. Then by the multiplying by $\tau$, we can define a map $H^{*, *^{\prime}}(X ; \mathbb{Z} / p) \rightarrow H^{*, *^{\prime}+1}(X ; \mathbb{Z} / p)$. By Deligne ( foot note (1) in Remark 6.4 in [2]) and Paranjape (Corollary 4.4 in [9]), it is proven that there is an isomorphism of the coniveau spectral sequence with the $\tau$-Bockstein spectral sequence $E(\tau)_{r}^{*, *^{\prime}}$ (see also [16], [22]).

Theorem 3.1. (Deligne) Let $A=\mathbb{Z} / p$. Then we have the isomorphism of spectral sequence

$$
E(c)_{r}^{c, *-c} \cong E(\tau)_{r-1}^{*, *-c} \quad \text { for } r \geq 2
$$

Hence the filtrations are the same, i.e. $N^{c} H_{e t}^{*}(X ; \mathbb{Z} / p)=F_{\tau}^{*, *-c}$ where

$$
F_{\tau}^{*, *-c}=\operatorname{Im}\left(\times \tau^{c}: H^{*, *-c}(X ; \mathbb{Z} / p) \rightarrow H^{*, *}(X ; \mathbb{Z} / p)\right) .
$$

Lemma 3.2. Let $x \in H^{*, *}(X)$ and also in $N^{c} H^{*}(X ; \mathbb{Z} / p)$. Then if the map $H^{*+1, *-c}(X) \rightarrow H^{*+1, *}(X)$ is injective, then $x \in N^{c} H^{*}(X)$.

Proof. Consider the exact sequences


By the assumption of this lemma, we can take $x^{\prime} \in H^{*, *-c}(X ; \mathbb{Z} / p)$ such that $r_{2}(x)=f_{2}\left(x^{\prime}\right)$. So $\delta_{2} f_{2}\left(x^{\prime}\right)=0$. Since $f_{3}$ is injective, we see $\delta_{1}\left(x^{\prime}\right)=0$, Hence there is $x^{\prime \prime} \in H^{*, *-c^{\prime}}(X)$ such that $r_{1}\left(x^{\prime \prime}\right)=x^{\prime}$.

Let $c l: C H^{*}(X) \otimes A \rightarrow H^{2 *}(X ; A)$ be the cycle map. and $\operatorname{Im}(c l)^{+}$is the positive degree parts of its image.
Lemma 3.3. We see that $\operatorname{Im}(c l)^{+} \subset N^{*} H^{2 *}(X ; A)$.
Proof. Recall that $H^{* . *^{\prime}}(X ; A) \subset N^{*-*^{\prime}} H^{*}(X ; A)$. We have $H^{2 *, *}(X ; A) \cong$ $C H^{*}(X) \otimes A$. Since $2 *>*$ for $* \geq 1$, we see $c l(y) \in N^{1} H^{2 *}(X ; A)$.

Hence $y \in C H^{*}(X) \otimes A$ is represented by closed algebraic set supported $Y$, while $Y$ may be singular.

On the other hand, by Totaro [17], we have the modified cycle map $\bar{c} l$

$$
c l: C H^{*}(X) \otimes A \xrightarrow{\bar{c} l} M U^{2 *}(X) \otimes_{M U^{*}} A \xrightarrow{\rho} H^{2 *}(X ; A)
$$

for the complex cobordism theory $M U^{*}(X)$. It is known [11] that elements in $M U^{2 *}(X)$ is written by a proper map to X from a stable almost complex manifold $Y$. while it does not mean complex manifold.

The following lemma is well known.
Lemma 3.4. If $x \in \operatorname{Im}(\rho)$ for $\rho: M U^{*}(X) / p \rightarrow H^{*}(X ; \mathbb{Z} / p)$, then we have $Q_{i}(x)=0$ for all $i \geq 0$.

Proof. In fact, it is known that $d=Q_{i}$ for the first nonzero differential $d$ of the Atiyah-Hirzebruch spectral sequence converging to the connected Morava K-theory $k(i)^{*}(X)$ with $k(i)^{*}=\mathbb{Z} / p\left[v_{i}\right]$. We have the natural maps

$$
\rho: M U^{*}(X) / p \xrightarrow{\rho_{1}} k(i)^{*}(X) \xrightarrow{\rho_{2}} H^{*}(X: \mathbb{Z} / p)
$$

Hence $Q_{i} \rho_{2}(x)=0$ implies $Q_{i} \rho(x)=0$.
Lemma 3.5. (reciprocity law) If $a \in \tilde{N}^{*} H^{2 *}(X ; A)$, then for each $g \in D H^{*^{\prime}}(X ; A)$ we have ag $\in \tilde{N}^{*} H^{2 *+*^{\prime}}(X ; A)$.

Proof. Suppose we have $f: Y \rightarrow X$ with $f_{*}\left(a^{\prime}\right)=a$. Then

$$
f_{*}\left(a^{\prime} f^{*}(g)\right)=f_{*}\left(a^{\prime}\right) g=a g
$$

by Frobenius reciprocity law.
Let $G$ be an algebraic group (over $\mathbb{C}$ ) and $r$ be a complex representation $r: G \rightarrow U_{n}$ the unitary group. Then we can define the Chern class $c_{i}=r^{*} c_{i}^{U}$. Here the Chern classes $c_{i}^{U}$ in $H^{*}\left(B U_{n}\right) \cong \mathbb{Z}\left[c_{1}^{U}, \ldots, c_{n}^{U}\right]$ are defined by using the Gysin map as $c_{n}^{U}=i_{n, *}(1)$ for

$$
i_{n}^{*}: H^{*}\left(B U_{n}\right) \cong H_{U_{n}}^{*}(p t .) \xrightarrow{i_{n .}} H_{U_{n}}^{*+2 i}\left(\mathbb{C}^{\times i}\right) \cong H^{*+2 i}\left(B U_{n}\right)
$$

where $H_{U_{n}}(X)=H^{*}\left(E U_{n} \times_{U_{n}} X\right)$ is the $U_{n}$-equivaliant cohomology.
Lemma 3.6. For an approximation $X$ of $B G$ and for each $g \in H^{*^{\prime}}(B G ; A)$, we have $g c_{i}=0 \in D H^{*}(X ; A)$.

The following lemma is proved by Colliot Thérène and Voisin [3] by using the affirmative answer of the Bloch-Kato conjecture by Voevodsky. ([20]. [21])
Lemma 3.7. (3]) Let $X$ be a smooth complex variety. Then any torsion element in $H^{*}(X)$ is in $N^{1} H^{*}(X)$.

## 4. THE MAIN LEMMAS

The following lemma is the $Q_{i}$-version of one of results by Benoist and Ottem.
Lemma 4.1. Let $\alpha \in N^{1} H^{s}(X)$ for $s=3$ or 4 . If $Q_{i}(\alpha) \neq 0 \in H^{*}(X ; \mathbb{Z} / p)$ for some $i \geq 1$, then

$$
D H^{s}(X) \supset \mathbb{Z} / p\{\alpha\}, \quad D H^{s}\left(X ; \mathbb{Z} / p^{t}\right) \supset \mathbb{Z} / p\{\alpha\} \quad \text { for } t \geq 2
$$

Proof. Suppose $\alpha \in \tilde{N}^{1} H^{s}(X)$ for $s=3$ or 4, i.e. there is a smooth $Y$ with $f: Y \rightarrow X$ such that the transfer $f_{*}\left(\alpha^{\prime}\right)=\alpha$ for $\alpha^{\prime} \in H^{*}(Y)$. Then for $s=4$

$$
\begin{gathered}
Q_{i}\left(\alpha^{\prime}\right)=\left(P^{\Delta_{i}} \beta-\beta P^{\Delta_{i}}\right)\left(\alpha^{\prime}\right)=\left(-\beta P^{\Delta_{i}}\right)\left(\alpha^{\prime}\right)=-\beta\left(\alpha^{\prime}\right)^{p^{i}} \\
=-p^{i}\left(\beta \alpha^{\prime}\right)\left(\alpha^{\prime}\right)^{p^{i}-1}=0 \quad \text { (by Cartanformula) }
\end{gathered}
$$

since $\beta\left(\alpha^{\prime}\right)=0$ and $P^{\Delta_{i}}(y)=y^{p^{i}}$ for $\operatorname{dim}(y)=2$. (For $s=3$, we get also $Q_{i}\left(\alpha^{\prime}\right)=0$ since $P^{\Delta_{i}}(x)=0$ for $\operatorname{dim}(x)=1$.) This contradicts to the commutativity of $Q_{i}$ and $f_{*}$.

The case $A=\mathbb{Z} / p^{t}, t \geq 2$ is proved similarly, since for $\alpha^{\prime} \in H^{*}(X ; A)$ we see $\beta \alpha^{\prime}=0 \in H^{*}(X ; \mathbb{Z} / p)$.

We will extend Lemma $4.1, s=4$, for the larger $s$, by using $M U$-theory of Eilenberg-MacLane spaces.

Recall that $K=K(\mathbb{Z}, n)$ is the Eilenberg-MacLane space such that the homotopy group $[X, K] \cong H^{n}(X: \mathbb{Z})$, i.e., each element $x \in H^{n}(X ; \mathbb{Z})$ is represented by a homotopy map $x ; X \rightarrow K$. Let $\eta_{n} \in H^{n}(K ; \mathbb{Z})$ corrsponding the identity map. (For $K^{\prime}=K(\mathbb{Z} / p, n)$ define $\eta_{n}^{\prime} \in H^{n}\left(K^{\prime} ; \mathbb{Z} / p\right)$ by the identity element of $K^{\prime}$.) We know the image $\rho\left(M U^{*}(K)\right) \subset H^{*}(K ; \mathbb{Z}) / p$.

Lemma 4.2. (15], [13) We have the isomorphism

$$
\begin{gathered}
\rho: M U^{*}(K) \otimes_{M U^{*}} \mathbb{Z} / p \cong \mathbb{Z} / p\left[Q_{i_{1}} \ldots Q_{i_{n-2}} \eta_{n} \mid 0<i_{1}<\ldots<i_{n-2}\right], \\
\rho: M U^{*}\left(K^{\prime}\right) \otimes_{M U^{*}} \mathbb{Z} / p \cong \mathbb{Z} / p\left[Q_{i_{1}} \ldots Q_{i_{n-1}} Q_{0} \eta_{n}^{\prime} \mid 0<i_{1}<\ldots<i_{n-1}\right],
\end{gathered}
$$

where the notation $\mathbb{Z} / p[a, \ldots]$ exactly means $\mathbb{Z} / p[a, \ldots] /\left(a^{2}| | a \mid=o d d\right)$.
The following lemma is an extension of Lemma 4.1 for $s \geq 4$.
Lemma 4.3. Let $\alpha \in N^{c} H^{n+2 c}(X), n \geq 2, c \geq 1$. Suppose that there is $a$ sequence $0<i_{1}<\ldots<i_{n-1}$ with

$$
Q_{i_{1}} \ldots Q_{i_{n-1}} \alpha \neq 0 \quad \text { in } H^{*}(X ; \mathbb{Z} / p)
$$

Then $D^{c} H^{*}(X)=N^{c} H^{*}(X) /\left(p, \tilde{N}^{c} H^{*}(X)\right) \supset \mathbb{Z} / p\{\alpha\}$.
Proof. Suppose $\alpha \in \tilde{N}^{c} H^{n+2 c}(X)$, i.e. there is a smooth $Y$ of $\operatorname{dim}(Y)=$ $\operatorname{dim}(X)-c$ with $f: Y \rightarrow X$ such that the transfer $f_{*}\left(\alpha^{\prime}\right)=\alpha$ for $\alpha^{\prime} \in H^{n}(Y)$.

Identify the map $\alpha^{\prime}: Y \rightarrow K$ with $\alpha^{\prime}=\left(\alpha^{\prime}\right)^{*} \eta_{n}$. We still see from Lemma 4.2,

$$
Q\left(\alpha^{\prime}\right)=Q_{i_{1} \ldots Q_{i_{n-2}}\left(\left(\alpha^{\prime}\right)^{*} \eta_{n}\right) \in \operatorname{Im}\left(M U^{*}(Y) \rightarrow H^{*}(Y ; \mathbb{Z} / p)\right) . . . . ~}^{\text {. }}
$$

From Lemma 3.4, we see

$$
Q_{i_{n-1}} Q\left(\alpha^{\prime}\right)=Q_{i_{n-1}} Q_{i_{1} \ldots Q_{i_{n-2}}\left(\alpha^{\prime}\right)=0 \in H^{*}(Y ; \mathbb{Z} / p) . . . . ~ . ~}
$$

Therefore $Q_{i_{n-1}} Q(\alpha)$ must be zero by the commutativity of $f_{*}$ and $Q_{i}$.
Remark. For $\alpha \in N^{c} H^{n+2 c}(X ; \mathbb{Z} / p)$, we can give the $A=\mathbb{Z} / p$ version of the above lemma from the second isomorphism in Lemma 4.2. But we can see $Q_{i_{1}} \ldots Q_{i_{n}} Q_{0} \alpha=0$ always, (even if $Q_{i_{1}} \ldots Q_{i_{n-1}} \alpha \neq 0$ ). Hence we do not say about $D^{c} H^{*}(X ; \mathbb{Z} / p)$.

## 5. CLASSIFYING SPACES FOR FINITE GROUPS

Let $G$ be a finite group or an algebraic group, and $B G$ its classifying space. For example, when $G=G_{m}$ is the multiple group, we see

$$
B G_{m}=B S^{1} \cong \mathbb{P}^{\infty}, \quad H^{*}\left(\mathbb{P}^{\infty}\right) \cong \mathbb{Z}[y] \text { with }\left|y=c_{1}\right|=2
$$

for the infinite (complex) projective space $\mathbb{P}^{\infty}$. Note that $B G_{m}$ is a colimit of complex projective spaces. Though $B G$ itself is not a colimit of complex projective varieties, we can take a complex projective variety $X(N)$ (4]) for a given $N \geq 3$ such that there is a map $j: X(N) \rightarrow B G \times \mathbb{P}^{\infty}$ with

$$
H^{*}\left(B G \times \mathbb{P}^{\infty} ; A\right) \stackrel{j^{*}}{\cong} H^{*}(X(N) ; A) \quad \text { for } *<N
$$

Note that the quotient

$$
N^{n} H^{*}(X ; A) /\left(\tilde{N}^{n} H^{*}(X ; A)\right)
$$

is invariant under replacing $X$ with $X \times \mathbb{P}^{m}$ for all $n$ and all abelian groups $A$. In fact, from Künneth formula,

$$
H^{*}\left(X \times \mathbb{P}^{m} ; A\right) \cong H^{*}(X ; A) \otimes \mathbb{Z}[y] /\left(y^{m+1}\right)
$$

where $y \in C H^{1}\left(\mathbb{P}^{m}\right)$. Let $\operatorname{Ideal}(y)$ be the ideal of $H^{*}\left(X \times \mathbb{P}^{m} ; A\right)$ generated by $y$. Then $\operatorname{Ideal}(y) \subset \tilde{N}^{*} H^{*}\left(X \times \mathbb{P}^{m} ; A\right)$ by the Frobenius reciprocity law (Lemma 3.5). Moreover Benoist and Ottem show the above quotient when $n=1$ is a stable birational invariant (Proposition 2.4 in [1]).

In this paper, we say the above $X(N)$ as a (degree $\leq N)$ complex projective approximation for $B G$ (which is an approximation of $B G \times \mathbb{P}^{\infty}$ strictly speaking), and let us write the $(\bmod (p))$ stable rational invariant by

$$
D H^{*}(X ; A)=N^{1} H^{*}(X ; A) /\left(p, \tilde{N}^{1} H^{*}(X ; A)\right)
$$

Hereafter, we consider $D H^{*}(X ; A)$ when $A=\mathbb{Z}$. Let $p$ be an odd prime. ( The case $p=2$ is different but a similar argument works.) Let $G=(\mathbb{Z} / p)^{3}$ the rank $=3$ elementary abelian $p$-group. Then the $\bmod (p)$ cohomology is

$$
H^{*}(B G ; \mathbb{Z} / p) \cong H^{*}(B \mathbb{Z} / p ; \mathbb{Z} / p)^{3 \otimes} \cong \mathbb{Z} / p\left[y_{1}, y_{2}, y_{3}\right] \otimes \Lambda\left(x_{1}, x_{2}, x_{3}\right)
$$

Here $\left|y_{i}\right|=2,\left|x_{i}\right|=1, \beta\left(x_{i}\right)=y_{i}$, and $\Lambda(a, \ldots, b)$ is the $\mathbb{Z} / p$-exterior algebra generated by $a, \ldots, b$.

The integral cohomology (modulo $p$ ) is isomorphic to

$$
H^{*}(B G) / p \cong K e r\left(Q_{0}\right) \cong H\left(H^{*}(B G ; \mathbb{Z} / p) ; Q_{0}\right) \oplus \operatorname{Im}\left(Q_{0}\right)
$$

where $H\left(-; Q_{0}\right)=\operatorname{Ker}\left(Q_{0}\right) / \operatorname{Im}\left(Q_{0}\right)$ is the homology with the differential $Q_{0}$. It is immediate that $H\left(H^{*}(B \mathbb{Z} / p ; \mathbb{Z} / p) ; Q_{0}\right) \cong \mathbb{Z} / p$. By the Künneth formula, we have $H\left(H^{*}\left((B G ; \mathbb{Z} / p) ; Q_{0}\right) \cong(\mathbb{Z} / p)^{3 \otimes} \cong \mathbb{Z} / p\right.$. Hence we have

$$
\begin{gathered}
H^{*}(B G) / p \cong \mathbb{Z} / p\{1\} \oplus \operatorname{Im}\left(Q_{0}\right) \\
\cong \mathbb{Z} / p\left[y_{1}, y_{2}, y_{3}\right]\left(1, Q_{0}\left(x_{i} x_{j}\right), Q_{0}\left(x_{1} x_{2} x_{3}\right) \mid i<j\right)
\end{gathered}
$$

where the notation $R(a, \ldots, b)$ (resp. $R\{a, \ldots, b\}$ ) means the $R$-submodule (resp. the free $R$-module) generated by $a, \ldots, b$. Here we note $H^{+}(B G)$ is just $p$-torsion.

Also note that $y_{1}, y_{2}, y_{3}$ are represented by the Chern classes $c_{1}$. From Lemma 3.6, we see

$$
\operatorname{Ideal}\left(y_{1}, y_{2}, y_{3}\right)=0 \in D H^{*}(X)
$$

We know $Q_{i}\left(y_{j}\right)=y_{j}^{p^{i}}$ and $Q_{j}$ is a derivation. Let us write

$$
\alpha=Q_{0}\left(x_{1} x_{2} x_{3}\right)=y_{1} x_{2} x_{3}-y_{2} x_{1} x_{3}+y_{3} x_{1} x_{2} .
$$

Note $\alpha \in H^{4}(X), p \alpha=0$, and $\alpha \in N^{1} H^{*}(X)$ from Lemma 3.7. Moreover

$$
Q_{1}(\alpha)=Q_{1}\left(y_{1} x_{2} x_{3}\right)-\ldots=y_{1} y_{2}^{p} x_{3}-y_{1} y_{3}^{p} x_{2}-\ldots \neq 0 \in H^{*}(X ; \mathbb{Z} / p) .
$$

Similarly, for $\alpha_{i j}=Q_{0}\left(x_{i} x_{j}\right)$, we see $Q_{1}\left(\alpha_{i j}\right) \neq 0$. Hence from Lemma 4.1 and Lemma 3.6, we have

Theorem 5.1. Let $X=X(N)$ with $N>2 p+3$ be an approximation for $B(\mathbb{Z} / p)^{3}$. Then we have

$$
D H^{*}(X) \cong \mathbb{Z} / p\left\{\alpha_{i j}, \alpha \mid 1 \leq i<j \leq 3\right\} \quad \text { for } *<N
$$

Proof. We see $H^{*}(B G) /\left(p, y_{1}, y_{2}, y_{3}\right) \cong \mathbb{Z} / p\left\{1, \alpha_{i j}, \alpha\right\}$. Of course $1 \notin N^{1} H^{*}(X)$, we have the theorem from Lemma 4.1.

Theorem 5.2. Let $X=X(N)_{n}$ be an approximation for $(B \mathbb{Z} / p)^{n}$ with $N>$ $\left|Q_{0} Q_{1} \ldots Q_{n-1}\left(x_{1} \ldots x_{n}\right)\right|$. Then we have for $\alpha_{i_{1}, \ldots, i_{s}}=Q_{0}\left(x_{i_{1}} \ldots x_{i_{s}}\right)$,

$$
D H^{*}(X) \supset \mathbb{Z} / p\left\{\left(\alpha_{i_{1}, \ldots, i_{s}} \mid 2 \leq s, 0<i_{1}<i_{2} \ldots<i_{s} \leq n\right\} \quad \text { for } *<N\right.
$$

Proof. We have the theorem from Lemma 4.3 and $Q_{i_{1} \ldots Q_{i_{s-2}}}\left(\alpha_{i_{1}, \ldots, i_{s}}\right)$ is

$$
Q_{i_{1} \ldots} \ldots Q_{i_{s-2}} Q_{0}\left(x_{i_{1}} \ldots x_{i_{s}}\right)=y_{i_{1}}^{p_{1}} \ldots y_{i_{s-2}}^{p_{s-2}} y_{i_{s-1}} x_{i_{s}}+\ldots \neq 0
$$

(Note the $n=\left|\alpha^{\prime}\right|$ in Lemma 4.3 is written by $s-1$ here.)
Corollary 5.3. If $n \neq m \geq 3$, then $X(N)_{n}$ and $X(N)_{m}$ are not stable birational equivalent.

Next we study small non abelian $p$-groups. Let $G$ be a non abelian group of order $p^{3}$ (see $\S 8$, for details). Then $H^{\text {even }}(B G)$ is generated by Chern classes, and $H^{\text {odd }}(B G)$ is a (just) $p$-torsion. We can identify $H^{\text {odd }}(B G) \subset H^{\text {odd }}(B G ; \mathbb{Z} / p)$. The operation $Q_{1}$ acts on $H^{o d d}(X)$, and induces the injection

$$
Q_{1}: H^{\text {odd }}(B G) \hookrightarrow H^{\text {even }}(B G)
$$

Such groups are four types (see $\S 8$ below), and they are called extraspecial $p$ groups $G=p_{ \pm}^{1+2}$ of order $p^{3}$. When $G=Q_{8}=2_{-}^{1+2}$ the quaternion group of order 8, we know $H^{\text {odd }}(X)=0$. However when $G=D_{8}=2_{+}^{1+2}$ the dihedral group of order 8 , the cohomology $H^{\text {odd }}(B G)$ is generated as an $H^{\text {even }}(B G)$ module by an element $e$ of $\operatorname{deg}(e)=3$. When $G=E=p_{+}^{1+2}$ for $p \geq 3, H^{\text {odd }}(B G)$ is generated by $e_{1}, e_{2}$ with $\operatorname{deg}\left(e_{i}\right)=3$. When $G=M=p_{-}^{1+2}$ for $p \geq 3, H^{\text {odd }}(B G)$ is generated by $e^{\prime}$ but $\operatorname{deg}\left(e^{\prime}\right)=2 p+1$.

From Lemma 3.5 (Frobenius reciprocity) and the main lemma (Lemma 4.1), we have the following theorem.

Theorem 5.4. Let $X=X(N)$ with $N>2 p+3$ be an approximation for an extraspecial p-group $G$ of order $p^{3}$. Then we have for $*<N$

$$
D H^{*}(X) \cong\left\{\begin{array}{l}
0 \quad \text { for } G=Q_{8} \\
\mathbb{Z} / 2\{e\} \quad \text { for } G=D_{8} \\
0 \text { or } \mathbb{Z} / p\left\{e^{\prime}\right\} \quad \text { for } G=M \\
\mathbb{Z} / p\left\{e_{1}, e_{2}\right\} \quad \text { for } G=E
\end{array}\right.
$$

In particular, the above theorem implies that when $G=p_{+}^{1+2}$, there is an $X$ with $D H^{3}(X) \neq 0$ but for all $X=X(N)$ we see $D H^{*}(X)=0$ for $4 \leq *<N$.

## 6. CONNECTED GROUPS

At first, we consider when $G=U_{n}, S U_{n}$ or $S p_{2 n}$ for all $p$, where the cohomology $H^{*}(B G)$ has no torsion. Then $H^{*}(B G)$ is generated by Chern classes, e.g.,

$$
\begin{aligned}
H^{*}\left(B U_{n}\right) \cong C H^{*}\left(B U_{n}\right) & \cong \mathbb{Z}_{(p)}\left[c_{1}, \ldots, c_{n}\right] \\
H^{*}\left(B S p_{2 n}\right) \cong C H^{*}\left(B S p_{2 n}\right) & \cong \mathbb{Z}_{(p)}\left[c_{2}, c_{4}, \ldots, c_{2 n}\right]
\end{aligned}
$$

Hence $D H^{*}(X)=0$ for the approximations $X$ for these groups.
Next we consider the case $G=S O_{3}$ and $p=2$. Then

$$
H^{*}(B G ; \mathbb{Z} / 2) \cong \mathbb{Z} / 2\left[w_{1}, w_{2}, w_{3}\right] /\left(w_{1}\right) \cong \mathbb{Z} / 2\left[w_{2}, w_{3}\right]
$$

where $w_{i}$ is the $i$-th Stiefel-Whitney class for $\mathrm{SO}_{3} \subset O_{3}$ and $w_{i}^{2}=c_{i}$ is the $i$-th Chern class for $\mathrm{SO}_{3} \subset U_{3}$. (Also it is the elementary symmetric polynomial in $\mathbb{Z} / 2\left[y_{1}, \ldots, y_{i}\right]$.) Here we know $Q_{0}\left(w_{2}\right)=w_{3}$, and $Q_{1}\left(w_{3}\right)=w_{3}^{2}=c_{3}$. Therefore we have 22

$$
\begin{aligned}
H^{*}(B G ; \mathbb{Z} / 2) & \cong \mathbb{Z} / 2\left[c_{2}, c_{3}\right]\left\{1, w_{2}, w_{3}=Q_{0}\left(w_{2}\right), w_{2} w_{3}=Q_{1} w_{2}\right\} \\
& \cong \mathbb{Z} / 2\left[c_{2}, c_{3}\right] \otimes \Lambda\left(Q_{0}, Q_{1}\right)\left\{w_{2}\right\} \oplus \mathbb{Z} / 2\left[c_{2}\right]
\end{aligned}
$$

In particular $H^{*}(B G) / 2 \cong \operatorname{Ker}\left(Q_{0}\right) \cong \mathbb{Z} / 2\left[c_{2}, c_{3}\right]\left\{1, w_{3}\right\}$. Then from Lemma 4.1, we have

Theorem 6.1. Let $G=S O_{3}$ and $X$ be an approximation of $B G$ for $6<N$. Then $D H^{*}(X) \cong \mathbb{Z} / 2\left\{w_{3}\right\}$ for $*<N$.

Using Lemma 4.3, we have
Theorem 6.2. Let $X_{n}=X_{n}(N)$ be approximations for $B S O_{n}$ for $n \geq 3$. Moreover let $\left|Q_{1} \ldots Q_{2 m-1}\left(w_{2 m+1}\right)\right|<N$.Then

$$
D H^{*}\left(X_{2 m+1}\right) \supset \mathbb{Z} / 2\left\{w_{3}, w_{5}, \ldots, w_{2 m+1}\right\} \quad \text { for } *<N
$$

Proof. Since $Q_{0} w_{2 i}=w_{2 i+1}$, we see $w_{2 i+1} \in N^{1} H^{2 i+1}(X)$. We have the theorem, from Lemma 4.3 and the restriction to $H^{*}\left(B(\mathbb{Z} / 2)^{2 i} ; \mathbb{Z} / 2\right)$,

$$
Q_{1} \ldots Q_{2 i-2}\left(w_{2 i+1}\right)=Q_{1} \ldots Q_{2 i-2} Q_{0}\left(w_{2 i}\right)=y_{1} y_{2}^{2} \ldots y_{2 i-1}^{2 i-2} x_{2 i}+\ldots \neq 0
$$

We next consider simply connected groups. Let us write by $X$ an approximation of $B G_{2}$ for the exceptional simple group $G_{2}$ of $\operatorname{rank}=2$. The $\bmod (2)$ cohomology is generated by the Stiefel-Whitney classes $w_{i}$ of the real representation $G_{2} \rightarrow S_{7}$

$$
\begin{aligned}
H^{*}\left(B G_{2} ; \mathbb{Z} / 2\right) & \cong \mathbb{Z} / 2\left[w_{4}, w_{6}, w_{7}\right], \quad P^{1}\left(w_{4}\right)=w_{6}, \quad Q_{0}\left(w_{6}\right)=w_{7} \\
H^{*}\left(B G_{2}\right) & \cong\left(D^{\prime} \oplus D^{\prime} / 2\left[w_{7}\right]^{+}\right) \quad \text { where } \quad D^{\prime}=\mathbb{Z}\left[w_{4}, c_{6}\right]
\end{aligned}
$$

Then we have $Q_{1} w_{4}=w_{7}, Q_{2}\left(w_{7}\right)=w_{7}^{2}=c_{7}$ (the Chern class).
The Chow ring of $B G_{2}$ is also known

$$
C H^{*}\left(B G_{2}\right) \cong\left(D\left\{1,2 w_{4}\right\} \oplus D / 2\left[c_{7}\right]^{+}\right) \quad \text { where } D=\mathbb{Z}\left[c_{4}, c_{6}\right] \quad c_{i}=w_{i}^{2}
$$

In particular the cycle map $\mathrm{cl}: C H^{*}(B G) \rightarrow H^{*}(B G)$ is injective.
It is known $w_{4} \in N^{1} H^{*}(X ; \mathbb{Z} / 2)([22])$ and from Lemma 3.2, we see $w_{4} \in$ $N^{1} H^{*}(X)$. Since $Q_{1}\left(w_{4}\right)=w_{7} \neq 0$, from Lemma 4.1, we have $D H^{4}(X) \neq 0$ ([1]). Moreover $H^{*}(B G) /\left(c_{4}, c_{6}, c_{7}\right) \cong \Lambda\left(w_{4}, w_{7}\right)$ implies

Proposition 6.3. For $X$ an approximation for $B G_{2}$, we have the surjection

$$
\Lambda\left(w_{4}, w_{7}\right)^{+} \rightarrow D H^{*}(X) \quad \text { for } *<N
$$

By Voevodsky [18, [19, we have the $Q_{i}$ operation also in the motivic cohomology $H^{*, *^{\prime}}(X ; \mathbb{Z} / p)$ with $\operatorname{deg}\left(Q_{i}\right)=\left(2 p^{i}-1, p-1\right)$. Then we can take

$$
\operatorname{deg}\left(w_{4}\right)=(4,3), \operatorname{deg}\left(w_{6}\right)=(6,4), \operatorname{deg}\left(w_{7}\right)=(7,4), \operatorname{deg}\left(c_{7}\right)=(14,7)
$$

By Theorem 3.1, the above means

$$
w_{7}=Q_{1} w_{4} \in N^{7-4} H^{*}(X ; \mathbb{Z} / 2)=N^{3} H^{*}(X ; \mathbb{Z} / 2)
$$

We can not see here that $0 \neq w_{7} \in D H^{*}(X)$, but see the following proposition.

Proposition 6.4. For $X$ the approximation for $B G_{2}$, we have

$$
\mathbb{Z} / 2\left\{w_{7}\right\} \subset D^{3} H^{*}(X)=N^{3} H^{*}(X) /\left(2, \tilde{N}^{3} H^{*}(X)\right)
$$

Proof. Suppose $w_{7} \in \tilde{N}^{3} H^{*}(X)$. That is, there is $x \in H^{1}(Y)$ with $f_{*}(x)=w_{7}$ for $f: Y \rightarrow X$. Act $Q_{2}$ on $H^{*}(Y ; \mathbb{Z} / 2)$, and

$$
Q_{2}(x)=\left(P^{\Delta_{2}} \beta+\beta P^{\Delta_{2}}\right)(x)=0
$$

since $\beta(x)=0$ and $P^{i}(x)=S q^{2 i}(x)=0$ for $i>0$. But $Q_{2} w_{7}=c_{7} \neq 0$. This contradicts to the commutativity of $f_{*}$ and $Q_{2}$.

Theorem 6.5. Let $G$ be a simply connected group such that $H^{*}(B G)$ has ptorsion. Let $X=X(N)$ be an approximation for $B G$ for $N \geq 2 p+3$. Then $D H^{4}(X) \neq 0$.

Proof. It is only need to prove the theorem when $G$ is a simple group having $p$ torsion in $H^{*}(B G)$. Let $p=2$. It is well known that there is an embedding $j: G_{2} \subset G$ such that (see [10], 25] for details)

$$
H^{4}(B G) \stackrel{j^{*}}{\cong} H^{4}\left(B G_{2}\right) \cong \mathbb{Z}\left\{w_{4}\right\}
$$

Let $x=\left(j^{*}\right)^{-1} w_{4} \in H^{4}(B G)$. From Lemma 3.1 in [25], we see that $2 x$ is represented by Chern classes. Hence $2 x$ is the image from $C H^{*}(X)$, and so $2 x \in$ $N^{1} H^{4}(X)$. This means there is an open set $U \subset X$ such that $2 x=0 \in H^{*}(U)$ that is. $x$ is 2-torsion in $H^{*}(U)$. Hence from Lemma 3.5, we have $x \in N^{1} H^{4}(U)$, and so there is $U^{\prime} \subset U$ such that $x=0 \in H^{4}\left(U^{\prime}\right)$. This implies $x \in N^{1} H^{4}(X)$.

Since $j^{*}\left(Q_{1} x\right)=Q_{1} w_{4}=w_{7} \neq 0$, we see $Q_{1} x \neq 0$. From the main lemma (Lemma 4.1), we see $D H^{4}(X) \neq 0$ for $G$.

For the cases $p=3,5$, we consider the exceptional groups $F_{4}, E_{8}$ respectively. Each simply connected simple group $G$ contains $F_{4}$ for $p=3, E_{8}$ for $p=5$. There is $x \in H^{4}(B G)$ such that $p x$ is a Chern class and $Q_{1}(x) \neq 0 \in H^{*}(B G ; \mathbb{Z} / p)$. In fact, there is embedding $j:(\mathbb{Z} / p)^{3} \subset G$ with $j^{*}(x)=Q_{0}\left(x_{1} x_{2} x_{3}\right)$. Hence we have the theorem.

Corollary 6.6. Let $X$ be an approximation for BSpin $n_{n}$ with $n \geq 7$ or BG for an exceptional group $G$. Then $X$ is not stable rational.

Remark. Kordonskii [6], Merkurjev (Corollary 5.8 in [7]), and ReichsteinScavia show [14] that $B \operatorname{Spin}_{n}$ itself is stably rational when $n \leq 14$. These facts do not mean contradictions. The (Ekedahl) approximation $X$ is not stable rationally equivalent to $G L_{M} / G=B G$ where $M$ is a large number such that $G$ acts freely on $G L_{M}$. On the other hand $X$ is constructed from a quasi projective variety $B G$ as taking intersections of subspaces of $\mathbb{P}^{M^{\prime}}$ for a large $M^{\prime}$. (The author thanks Federico Scavia who pointed out this remark.)

At last of this section, we consider the case $G=P G L_{p}$. We have (for example Theorem 1.5,1.7 in [5]) additively

$$
\begin{aligned}
& H^{*}(B G ; \mathbb{Z} / p) \cong M \oplus N \quad \text { with } \quad M \stackrel{\text { add. }}{\cong} \mathbb{Z} / p\left[x_{4}, x_{6}, \ldots, x_{2 p}\right] \\
& N=S D \otimes \Lambda\left(Q_{0}, Q_{1}\right)\left\{u_{2}\right\} \quad \text { with } \quad S D=\mathbb{Z} / p\left[x_{2 p+2}, x_{2 p^{2}-2 p}\right]
\end{aligned}
$$

where $x_{2 p+2}=Q_{1} Q_{0} u_{2}$ and suffix means its degree. The Chow ring is given as

$$
C H^{*}(B G) / p \cong M \oplus S D\left\{Q_{0} Q_{1}\left(u_{2}\right)\right\}
$$

From Lemma 4.1, we have ;

Theorem 6.7. Let $p$ be odd. For an approximation $X$ for $B P G L_{p}$, we see $\mathbb{Z} / p\left\{Q_{0} u_{2}\right\} \subset D H^{*}(X)$, and moreover there is a surjection

$$
\mathbb{Z} / p\left[x_{2 p^{2}-2 p}\right]\left\{Q_{0} u_{2}\right\} \rightarrow D H^{*}(X) /(\operatorname{Im}(c l)) \quad \text { for } *<N
$$

for the cycle map cl:CH* $\left.(X) \rightarrow H^{2 *}(X)\right)$.

## 7. $\mathbb{Z} / p$-COEFFICIENT COHOMOLOGY FOR ABELIAN GROUPS

In the preceding sections, we have seen that cases $D H^{*}(X ; A) \neq 0$ are not so rare for $A=\mathbb{Z}_{(p)}, \mathbb{Z} / p^{i}, i \geq 2$. However currently it seems difficult to make such example for $A=\mathbb{Z} / p$. (Recall the remark in the last in $\S 4$.)
Question 7.1. $D H^{*}(X ; \mathbb{Z} / p)=0$ for each smooth projective variety $X$ ?
At first, we consider the case $G=(\mathbb{Z} / p)^{3}$. We can take a quasi projective approximation $\bar{X}(N)$ of $B \mathbb{Z} / p$ explicitly by the quotient (the $N$-dimensional lens space)

$$
\bar{X}(N)=\mathbb{C}^{N *} /(\mathbb{Z} / p) \quad \text { where } \mathbb{C}^{N *}=\left(\mathbb{C}^{N}-\{0\}\right)
$$

Next we consider the projective approximation

$$
X(N) \rightarrow \bar{X}(N) \times \mathbb{P}^{N} \rightarrow B \mathbb{Z} / p \times \mathbb{P}^{\infty}
$$

Let us write $X_{i}$ (resp. $X_{i}^{\prime}$ ) the above $\bar{X}(N)$ (resp. $\bar{X}(N-1)$ ) for a sufficient large number $N$. Let

$$
i_{1}: Y_{1}=X_{1}^{\prime} \times X_{2} \times X_{3} \rightarrow X=X_{1} \times X_{2} \times X_{3}
$$

Similarly we define $Y_{2}, Y_{3}$, and the disjoin union $Y=Y_{1} \sqcup Y_{2} \sqcup Y_{3}$.
Recall that for $p: o d d$

$$
H^{*}(X ; \mathbb{Z} / p) \cong \mathbb{Z} / p\left[y_{1}, y_{2}, y_{3}\right] /\left(y_{1}^{N+1}, y_{1}^{N+1}, y_{3}^{N+1}\right) \otimes \Lambda\left(x_{1}, x_{2}, x_{3}\right)
$$

and $H^{*}\left(Y_{i} ; \mathbb{Z} / p\right) \cong H^{*}(X ; \mathbb{Z} / p) /\left(y_{i}^{N}\right)$ for $i=1,2,3$. For $p=2$, some graded ring $\operatorname{gr} H^{*}(X ; \mathbb{Z} / 2)$ is isomorphic to the above ring (in fact $x_{i}^{2}=y_{i}$ ).

For the embedding $f_{i}: X_{i}^{\prime} \rightarrow X_{i}$, it is known $f_{i *}(1)=c_{1}\left(N_{i}\right)$ where $N_{i}$ is the normal bundle for $X_{i}^{\prime} \subset X_{i}$. Hence the transfer is given by

$$
f_{1 *}(1)=y_{1}, \quad f_{2 *}(1)=y_{2}, \quad f_{3 *}(1)=y_{3}
$$

Therefore we have for $x=\left(x_{2} x_{3}+x_{3} x_{1}+x_{1} x_{2}\right) \in H^{*}\left(Y_{1} \sqcup Y_{2} \sqcup Y_{3} ; \mathbb{Z} / p\right)$,

$$
f_{*}(x)=y_{1} x_{2} x_{3}+y_{2} x_{3} x_{1}+y_{3} x_{1} x_{2}=Q_{0}\left(x_{1} x_{2} x_{3}\right)=\alpha .
$$

(Note that the element $x=\left(x_{1} x_{2}+x_{2} x_{3}+x_{3} x_{1}\right)$ is not in the integral cohomology $H^{*}(Y)$.) Thus we see $\alpha \in \tilde{N}^{c} H^{*}(X ; \mathbb{Z} / p)$. More generally, we see

Theorem 7.2. We have the approximation $X=X(N)$ for $(B \mathbb{Z} / p)^{n}$ such that

$$
D H^{*}(X ; \mathbb{Z} / p)=0 \quad *<N
$$

We recall here the motivic cohomology. By Voevodsky [Vo 1], $H^{*, *^{\prime}}(B \mathbb{Z} / p ; \mathbb{Z} / p)$ satisfies the Künneth formula so that (for $p$ odd)

$$
H^{*, *^{\prime}}\left(B(\mathbb{Z} / p)^{n} ; \mathbb{Z} / p\right) \cong \mathbb{Z} / p\left[\tau, y_{1}, \ldots,, y_{n}\right] /\left(y_{1}^{N+1}, \ldots, y_{n}^{N+1}\right) \otimes \Lambda\left(x_{1}, \ldots, x_{n}\right)
$$

Here $0 \neq \tau \in H^{0,1}(\operatorname{Spec}(\mathbb{C}) ; \mathbb{Z} / p)$, and $\operatorname{deg}\left(y_{i}\right)=(2,1)$, $\operatorname{deg}\left(x_{i}\right)=(1,1)$.
From Theorem 3.1, we can identify $N^{c} H_{e t}^{*}(X ; \mathbb{Z} / p)=F_{\tau}^{*, *-c}$ where $F_{\tau}^{*, *-c}=\operatorname{Im}\left(\times \tau^{c}: H^{*, *-c}(X ; \mathbb{Z} / p) \rightarrow H^{*, *}(X ; \mathbb{Z} / p)\right)$.

Corollary 7.3. (Theorem 5.1 in [16]) Let $X=X(N)$ be the approximation for $(B \mathbb{Z} / p)^{n}$ for a sufficient large $N$. Then we have

$$
H^{*}(X: \mathbb{Z} / p) / N^{1} H^{*}(X ; \mathbb{Z} / p) \cong \Lambda\left(x_{1}, \ldots, x_{n}\right)
$$

Proof. Let $x \in \operatorname{Ideal}\left(y_{1}, \ldots, y_{n}\right) \subset H^{*, *^{\prime}}(X ; \mathbb{Z} / p)$. Then $\operatorname{deg}(x)=\left(*, *^{\prime}\right)$ with $*>*^{\prime}$, and $x$ is a multiplying of $\tau$. Hence $x \in N^{1} H^{*}(X ; \mathbb{Z} / p)$.

Proof of Theorem 7.2. Let $x \in N^{1} H^{*}(X ; \mathbb{Z} / p)$. From the above corollary, $x \in$ $\operatorname{Ideal}\left(y_{1}, \ldots, y_{n}\right)$ which is in the image of the transfer (such as $Y_{1}=X_{1}^{\prime} \times X_{2} \times$ $\left.\ldots \times X_{n}\right)$. That is $x \in \tilde{N}^{1} H^{*}(X ; \mathbb{Z} / p)$.

We can extend Lemma 7.3, by using the following lemma. Let us write by $X G$ an approximation for $B G$.

Lemma 7.4. Let $G$ have a Sylow p-subgroup $S$. If $D H^{*}(X S ; \mathbb{Z} / p)=0$, then so for $B G$.

Proof. Let $j: B S \rightarrow B G$ and $i ; Y \rightarrow X S$. We consider maps

$$
H^{*}(Y ; \mathbb{Z} / p) \xrightarrow{i_{*}} H^{*}(X S ; \mathbb{Z} / p) \xrightarrow{j_{*}} H^{*}(X G ; \mathbb{Z} / p) .
$$

Here $j_{*}=\operatorname{cor}_{S}^{G}$ is the transfer for finite groups.
Note $j^{*} N^{1} H^{*}(X G ; \mathbb{Z} / p) \subset N^{1} H^{*}(X S ; \mathbb{Z} / p)$ by the naturality of $j^{*}$. Hence given $x \in N^{1} H^{*}(X G ; \mathbb{Z} / p)$. the element $y=j^{*}(x)$ is in $N^{1} H^{*}(X S ; \mathbb{Z} / p)$.

By the assumption in this lemma, there is $y^{\prime} \in H^{*}(Y ; \mathbb{Z} / p)$ with $i_{*}\left(y^{\prime}\right)=y$. Thus we have $j_{*} i_{*}\left(y^{\prime}\right)=j_{*} y=j_{*} j^{*}(x)=[G ; S] x$.

Similarly, we can prove ;
Corollary 7.5. Let $G$ have an abelian $p$ Sylow subgroup, and $X=X(N)$ be an approximation for $B G$. Then $D H^{*}(X ; \mathbb{Z} / p)=0$ for $*<N$.

## 8. the groups $Q_{8}$ and $D_{8}$

When $|G|=p^{3}$, we have the short exact sequence

$$
0 \rightarrow C \rightarrow G \rightarrow V \rightarrow 0
$$

where $C \cong \mathbb{Z} / p$ is in the center and $V \cong \mathbb{Z} / p \times \mathbb{Z} / p$. Let us take generators such that $C=\langle c\rangle, V=\langle a, b\rangle$. Moreover we can take $[a, b]=c$ when $G$ is non-abelian.

There are two cases, when $p=2$, the quaternion group $Q_{8}$ and the dihedral group $D_{8}$. We will show here

Theorem 8.1. Let $X=X(N)$ be an approximation for $Q_{8}$ or $D_{8}$. Then $D H^{*}(X ; \mathbb{Z} / 2)=0$ for $*<N$.
8.1. The case $G=Q_{8}$. Then $a^{2}=b^{2}=c$. Its cohomologies are well known (see [12])

$$
\begin{gathered}
H^{*}(B G) / 2 \cong \mathbb{Z} / 2\left[y_{1}, y_{2}, c_{2}\right] /\left(y_{i}^{2}, y_{1} y_{2}\right) \quad\left|y_{i}\right|=2 \\
H^{*}(B G ; \mathbb{Z} / 2) \cong \mathbb{Z} / 2\left[x_{1}, x_{2}, c_{2}\right] /\left(x_{1} x_{2}+y_{1}+y_{2}, x_{1} y_{2}+x_{2} y_{1}\right) \\
\cong \mathbb{Z} / 2\left\{1, x_{1}, y_{1}, x_{2}, y_{2}, w\right\} \otimes \mathbb{Z} / 2\left[c_{2}\right]
\end{gathered}
$$

where $x_{i}^{2}=y_{i}\left|x_{i}\right|=1$, and $w=y_{1} x_{2}=y_{2} x_{1},|w|=3$.
Therefore, we see

$$
H^{*}(B G ; \mathbb{Z} / 2) /\left(y_{1}, y_{2}, c_{2}\right) \cong \mathbb{Z} / 2\left\{1, x_{1}, x_{2}\right\}
$$

Of course $\operatorname{deg}\left(x_{i}\right)=(1,1)$ in $H^{*, *^{\prime}}(B G ; \mathbb{Z} / 2)$ and they are not in $N^{1} H^{*}(B G ; \mathbb{Z} / 2)$. Thus we have Theorem 8.1 for $G=Q_{8}$.
8.2. The case $G=D_{8}$. Then $a^{2}=c, b^{2}=1$. It is well known

$$
H^{*}(B G) / 2 \cong \mathbb{Z} / 2\left[y_{1}, y_{2}, c_{2}\right] /\left(y_{1} y_{2}\right)\{1, e\} \quad \text { with }|e|=3
$$

The $\bmod 2$ cohomlogy is written 12 ]

$$
\begin{aligned}
& \left.H^{*}(B G ; \mathbb{Z} / 2) \cong \mathbb{Z} / 2\left[x_{1}, x_{2}, u\right] /\left(x_{1} x_{2}\right) \quad \text { (with }|u|=2\right) \\
\cong & \left(\oplus_{j=1}^{2} \mathbb{Z} / 2\left[y_{j}\right]\left\{y_{j}, x_{j}, y_{j} u, x_{j} u\right\} \oplus \mathbb{Z} / 2\{1, u\}\right) \otimes \mathbb{Z} / 2\left[c_{2}\right]
\end{aligned}
$$

Here $y_{j}=x_{j}^{2}, u^{2}=c_{2}$ and $Q_{0}(u)=\left(x_{1}+x_{2}\right) u=e, Q_{1} Q_{0}(u)=\left(y_{1}+y_{2}\right) c_{2}$.
We note $y_{1}, y_{2}, c_{2} \in C H^{*}(B G) / 2$ and

$$
H^{*}(B G ; \mathbb{Z} / 2) /\left(y_{1}, y_{2}, c_{2}\right) \cong\left(\oplus_{j=1}^{2} \mathbb{Z} / 2\left\{x_{j}, x_{j} u\right\}\right) \oplus \mathbb{Z} / 2\{1, u\}
$$

Moreover, $\operatorname{deg}\left(x_{j}\right)=(1,1), \operatorname{deg}(u)=(2,2)$ in the motivic cohomology $H^{*, *^{\prime}}(B G ; \mathbb{Z} / 2)$ and they are not in $N^{1} H^{*}(B G ; \mathbb{Z} / 2)$. Here we note $\operatorname{deg}\left(x_{j} u\right)=$ $(3,3)$, but there is $u_{j}^{\prime} \in H^{3,2}(B G ; \mathbb{Z} / 2)$ with $x_{j} u=\tau u_{j}^{\prime}$ from Lemma 6.2 in [24] (i.e., $x_{j} u \in N^{1} H^{*}(X ; \mathbb{Z} / 2)$ ).

Hence for the proof of Lemma 8.1 (for $G=D_{8}$ ), it is only need to show
Lemma 8.2. We have $x_{i} u \in \tilde{N}^{1} H^{*}(B G ; \mathbb{Z} / 2)$.
To prove the above lemma, for a $G$-variety $H$, we consider the equivariant cohomology

$$
H_{G}^{*}(H ; \mathbb{Z} / p)=H^{*}\left(E(N) \times_{G} H ; \mathbb{Z} / p\right)
$$

where $E(N)$ is an (approximation of) contractible free $G$-variety. Let us write

$$
X_{G} H=\text { appro. of } E(N) \times_{G} H \text { so that } H_{G}^{*}(H ; \mathbb{Z} / p) \cong H^{*}\left(X_{G} H ; \mathbb{Z} / p\right)
$$

For a closed embedding $i: H \subset K$ of $G$-varieties, we can define the transfer

$$
i_{*}: H_{G}^{*}(H ; \mathbb{Z} / p) \rightarrow H_{G}^{*}(K ; \mathbb{Z} / p) \quad \text { by } i: X_{G} H \xrightarrow{i d \times_{G} i} X_{G} K .
$$

Hereafter in this section, let $G=D_{8}$. We recall arguments in [24]. We define the 2-dimensional representation $\tilde{c}: G \rightarrow U_{2}$ such that $\tilde{c}(a)=\operatorname{diag}(i,-i)$ and $\bar{c}(b)$ is the permutation matrix $(1,2)$. By this representation, we identify that $W=\mathbb{C}^{2 *}=\mathbb{C}^{2}-\{0\}$ is an $G$-variety. Note $G$ acts freely on $W \times \mathbb{C}^{*}$ but it does not so on $W=\mathbb{C}^{2 *}$.

The fixed points set on $W$ under $b$ is

$$
W^{\langle b\rangle}=\left\{(x, x) \mid x \in \mathbb{C}^{*}\right\}=\mathbb{C}^{*}\left\{e^{\prime}\right\}, \quad e^{\prime}=\operatorname{diag}(1,1) \in G L_{2}(\mathbb{C})
$$

Similarly $W^{\langle b c\rangle}=\mathbb{C}^{*}\left\{a^{-1} e^{\prime}\right\}$. Take

$$
H_{0}=\mathbb{C}^{*}\left\{e^{\prime}, a e^{\prime}\right\}, \quad H_{1}=\mathbb{C}^{*}\left\{g^{-1} e^{\prime}, q^{-1} a e^{\prime}\right\}
$$

where $g \in G L_{2}(\mathbb{C})$ with $g^{-1} b g=a b\left(\right.$ note $\left.(a b)^{2}=1\right)$.
Let us write $H=H_{0} \sqcup H_{1}$. Then $G$ acts on $H_{i}$ and acts freely on $\mathbb{C}^{2 *}-H$. In fact it does not contain fixed points of non-trivial stabilizer groups.

We consider the transfer for some $G$-set $H$ in $\mathbb{C}^{2 *}$, and induced equivariant cohomology

$$
i_{*}: H_{G}^{*}(H ; \mathbb{Z} / 2) \rightarrow H_{G}^{*}\left(\mathbb{C}^{2 *} ; \mathbb{Z} / 2\right)
$$

Lemma 8.3. We have

$$
H_{G}^{*}\left(H_{0} ; \mathbb{Z} / 2\right) \cong \mathbb{Z} / 2[y] \otimes \Lambda(x, z) \quad \text { with } y=x^{2},|x|=|z|=1
$$

Proof. We consider the group extension $0 \rightarrow\langle a\rangle \rightarrow G \rightarrow\langle b\rangle \rightarrow 0$ and the induced spectral sequence

$$
E_{2}^{*, *^{\prime}}=H^{*}\left(B\langle b\rangle ; H_{\langle a\rangle}^{*^{\prime}}\left(H_{0} ; \mathbb{Z} / 2\right)\right) \Longrightarrow H_{G}^{*}\left(H_{0} ; \mathbb{Z} / 2\right)
$$

Since $\langle a\rangle \cong \mathbb{Z} / 4$ acts freely on $H_{0}$, we see

$$
H_{0} /\langle a\rangle \cong \mathbb{C}^{*}\left\{e^{\prime}, a e^{\prime}\right\} /\langle a\rangle \cong \mathbb{C}^{*} /\langle a\rangle \cong \mathbb{C}^{*}
$$

Therefore we have

$$
H_{\langle a\rangle}^{*}\left(H_{0} ; \mathbb{Z} / 2\right) \cong H^{*}\left(\mathbb{C}^{*} /\langle a\rangle ; \mathbb{Z} / 2\right) \cong H^{*}\left(\mathbb{C}^{*} ; \mathbb{Z} / 2\right) \cong \Lambda(z) \quad|z|=1
$$

Since $\langle b\rangle$ acts trivially on $\Lambda(z)$ we have $H_{G}^{*}(H ; \mathbb{Z} / 2) \cong H^{*}(B\langle b\rangle ; \mathbb{Z} / 2) \otimes \Lambda(z)$.
Note $H_{G}^{*}\left(H_{0} ; \mathbb{Z} / 2\right) \cong H_{G}^{*}\left(H_{1} ; \mathbb{Z} / 2\right)$ and hence we see

$$
H_{G}^{*}(H ; \mathbb{Z} / 2) \cong \oplus_{j=1}^{2} \mathbb{Z} / 2\left[y_{j}\right]\left\{1_{j}, y_{j}, x_{j}, x_{j} z_{j}, z_{j}\right\}
$$

We consider the long exact sequence

$$
(*) \quad \ldots \rightarrow H_{G}^{*}(\{0\} ; \mathbb{Z} / 2) \xrightarrow{i_{*}=c_{2}} H_{G}^{*+4}\left(\mathbb{C}^{2} ; \mathbb{Z} / 2\right) \rightarrow H_{G}^{*+4}\left(\mathbb{C}^{2 *} ; \mathbb{Z} / 2\right) \rightarrow \ldots
$$

and we have $H_{G}^{*}\left(\mathbb{C}^{2 *} ; \mathbb{Z} / 2\right) \cong H^{*}(B G ; \mathbb{Z} / 2) /\left(c_{2}\right)$. Hence, we get

$$
H_{G}^{*}\left(\mathbb{C}^{2 *} ; \mathbb{Z} / 2\right) \cong\left(\oplus_{j=1}^{2} \mathbb{Z} / 2\left[y_{j}\right]\left\{y_{j}, x_{j}, x_{j} u_{j}^{\prime}, u_{j}^{\prime}\right\}\right) \oplus \mathbb{Z} / 2\{1, u\}
$$

Now we consider the transfer $H_{G}^{*}(H ; \mathbb{Z} / 2) \xrightarrow{i_{*}} H_{G}^{*+2}\left(\mathbb{C}^{2 *} ; \mathbb{Z} / 2\right)$. We have explicitly (page 527 in 24)

$$
i_{*}\left(1_{j}\right)=y_{j}, \quad i_{*}\left(x_{j}\right)=y_{j} x_{j}, \quad i_{*}\left(x_{j} z_{j}\right)=x_{j} u_{j}^{\prime}, \quad i_{*}\left(z_{j}\right)=u_{j}^{\prime} .
$$

Therefore we have Theorem 8.1 for $G=D_{8}$.
To see the above fact we recall the long exact sequence for $i: H \subset \mathbb{C}^{2 *}$

$$
\begin{gathered}
(* *) \quad \ldots \rightarrow H_{G}^{*+1}\left(\mathbb{C}^{2 *}-H ; \mathbb{Z} / 2\right) \xrightarrow{\delta} H_{G}^{*}(H ; \mathbb{Z} / 2) \xrightarrow{i_{*}} H_{G}^{*+2}\left(\mathbb{C}^{2 *} ; \mathbb{Z} / 2\right) \\
\xrightarrow{j^{*}} H_{G}^{*+2}\left(\mathbb{C}^{2 *}-H ; \mathbb{Z} / 2\right) \rightarrow \ldots
\end{gathered}
$$

The transfer $i_{*}$ is determined by the following lemma.
Lemma 8.4. In the above (**), we see $\delta=0$, and hence $i_{*}$ is injective.
Proof. Since $G$ acts freely on $\mathbb{C}^{2 *}-H$, we have

$$
H_{G}^{*}\left(\mathbb{C}^{2 *}-H: \mathbb{Z} / 2\right) \cong H^{*}\left(\left(\mathbb{C}^{2 *}-H\right) / G ; \mathbb{Z} / 2\right)
$$

which is zero when $*>4=2 \operatorname{dim}\left(\left(\mathbb{C}^{2 *}-H\right) / G\right)$. Hence $\delta$ must be zero for $*>4$, and $i_{*}$ is injective for $*>4$. In particular, $i_{*}\left(y_{j}^{2} z_{j}\right)=y_{j}^{2} u_{j}^{\prime}$. Since $H_{G}^{*}(H ; \mathbb{Z} / 2)$ is $\mathbb{Z} / 2\left[y_{1}\right]$-free (or $Z / 2\left[y_{2}\right]$-free, ) we see $i_{*}\left(z_{j}\right)=u_{j}^{\prime}$.
