# INFINITE-TIME BLOWING-UP SOLUTIONS TO SMALL PERTURBATIONS OF THE YAMABE FLOW

#### Abstract

Under the validity of the positive mass theorem, the Yamabe flow on a smooth compact Riemannian manifold of dimension $N \geq 3$ is known to exist for all time $t$ and converges to a solution to the Yamabe problem as $t \rightarrow \infty$. We prove that if a suitable perturbation, which may be smooth and arbitrarily small, is imposed on the Yamabe flow on any given Riemannian manifold $M$ of dimension $N \geq 5$, the resulting flow may blow up at multiple points on $M$ in the infinite time. Our proof is constructive, and indeed we construct such a flow by using solutions of the Yamabe problem on the unit sphere $\mathbb{S}^{N}$ as blow-up profiles. We also examine the stability of the blow-up phenomena under a negativity condition on the Ricci curvature at blow-up points.


## 1. Introduction

1.1. History. Let $\left(M, g_{0}\right)$ be a smooth compact Riemannian manifold of dimension $N \geq 3$. The Yamabe flow on $\left(M, g_{0}\right)$ is defined as

g(0)=g_{0}
\end{array}\right.

where $T$ is the maximal time, $S[g(t)]$ is the scalar curvature of the metric $g(t)$, and $\bar{S}[g(t)]$ is the average value of $S[g(t)]$. If we set $g(t)=u(t)^{\frac{4}{N-2}} g_{0}$ where $u(t)$ is a positive function on $M$ for each $t \in(0, T)$, then (1.1) is reduced to the quasi-linear parabolic equation

\end{equation*}

where $\kappa_{N}:=\frac{4(N-1)}{N-2}$ and $p:=\frac{N+2}{N-2}$.
Let $E_{g_{0}}$ be the energy corresponding to equation (1.2),

E_{g_{0}}(u):=\frac{\int_{M}\left(\kappa_{N}\left|\nabla_{g_{0}} u\right|_{g_{0}}^{2}+S\left[g_{0}\right] u^{2}\right) d v_{g_{0}}}{\left(\int_{M}|u|^{\frac{2 N}{N-2}} d v_{g_{0}}\right)^{\frac{N-2}{N}}}
$$

where $d v_{g_{0}}$ is the volume form on $\left(M, g_{0}\right)$, and $Y\left(M, g_{0}\right)$ is the Yamabe constant on $\left(M, g_{0}\right)$ defined by

Y\left(M, g_{0}\right)=\inf \left\{E_{g_{0}}(u): u \in C^{\infty}(M) \backslash\{0\}\right\} .
$$

If $Y\left(M, g_{0}\right) \leq 0$, a relatively simple argument based on the maximum principle shows that the flow (1.1) exists globally $(T=\infty)$ and converges to a metric of constant scalar curvature as $t \rightarrow \infty$.

However, treating (1.1) in the case $Y\left(M, g_{0}\right)>0$ is challenging, because one has to exclude the possibility of blowing-up phenomena. Thanks to the series of works by Chow [12], Ye [49], Schwetlick and Struwe [44], and Brendle [6, 7], it is now known that (1.1) is always globally welldefined in time and converges to a metric of constant scalar curvature as $t \rightarrow \infty$, under the validity

[^0]of the positive mass theorem; see also [9] in which Carlotto, Chodosh, and Rubinstein showed the existence of a Yamabe flow on a certain manifold converging at a polynomial rate.

One of the main ingredients of the proof by Brendle in [6, 7] is to construct a suitable family $\left\{\bar{u}_{z, \epsilon} \in C^{\infty}(M): z \in M, \epsilon>0\right.$ small $\}$ of test functions satisfying

\end{array}\right.
$$

where $\left(\mathbb{S}^{N}, g_{\mathbb{S}^{N}}\right)$ is the $N$-dimensional unit-sphere in $\mathbb{R}^{N+1}$ with the canonical metric $g_{\mathbb{S}^{N}}$, exp is the exponential map, and $W_{1,0}$ is the standard bubble in $\mathbb{R}^{N}$, that is,

Given a smooth function $h$ on $M$ such that $\max _{M} h>0$, let $E_{g_{0}, h}$ be a perturbed energy of $E_{g_{0}}$ given as

E_{g_{0}, h}(u)=\frac{\int_{M}\left[\kappa_{N}\left|\nabla_{g_{0}} u\right|_{g_{0}}^{2}+\left(S\left[g_{0}\right]+h\right) u^{2}\right] d v_{g_{0}}}{\left(\int_{M}|u|^{\frac{2 N}{N-2}} d v_{g_{0}}\right)^{\frac{N-2}{N}}}
$$

If $h(z)>0$ at some $z \in M$, then there is no test function $\bar{u}_{z, \epsilon}$ satisfying (1.3). For instance, if $N \geq 7, M$ is non-locally conformally flat, and $\bar{u}_{z, \epsilon}$ is a 'bubble-like' function satisfying the second condition in (1.3), then

as $\epsilon \rightarrow 0$, so

E_{g_{0}, h}\left(\bar{u}_{z, \epsilon}\right)>Y\left(\mathbb{S}^{N}, g_{\mathbb{S}^{N}}\right) \quad \text { provided } \epsilon>0 \text { small enough. }
$$

Here, $\tilde{c}_{1}, \tilde{c}_{2}>0$, Weyl $\left[g_{0}\right]$ is the Weyl tensor on $\left(M, g_{0}\right)$, and $\|\cdot\|_{g_{0}}$ is the tensor norm in the metric $g_{0}$.

Now setting

$$
\begin{equation*}
L_{g_{0}, h} u=\kappa_{N} \Delta_{g_{0}}-\left(S\left[g_{0}\right]+h\right) \tag{1.5}
\end{equation*}
$$

so that $L_{g_{0}}:=L_{g_{0}, h}$ is the conformal Laplacian on $\left(M, g_{0}\right)$, we consider a perturbed Yamabe flow

\begin{cases}p u^{p-1} u_{t}=\frac{N+2}{4}\left(L_{g_{0}, h} u+\kappa_{N} u^{p}\right) & \text { on } M \times(0, \infty),  \tag{1.6}\\ u>0 & \text { on } M \times(0, \infty), \\ u(\cdot, 0)=u_{0}>0 & \text { on } M,\end{cases}
$$

corresponding to the energy $E_{g_{0}, h}$. Observe that we replaced the function $\bar{S}[g(t)]$ in (1.1) with the constant $\kappa_{N}>0$, recalling that it tends to a positive constant as $t \rightarrow \infty$ provided $Y\left(M, g_{0}\right)>0$.

A natural question is what is the asymptotic behavior of a solution to (1.6) as $t \rightarrow T$. As we will prove in this paper, (1.6) may exhibit infinite-time blow-up phenomena driven by the bubbles (also known as the Talenti-Aubin instantons)

see (1.4). It is a classical result that the solution set of the Yamabe problem in $\mathbb{R}^{N}$

\begin{equation*}
-\Delta W=W^{p}, \quad W>0 \quad \text { in } \mathbb{R}^{N} \tag{1.8}
\end{equation*}
$$

is precisely $\left\{W_{\mu, \xi}: \mu>0, \xi \in \mathbb{R}^{N}\right\}$, which corresponds to a family of standard metrics on $N$ dimensional spheres in $\mathbb{R}^{N+1}$ via the stereographic projection.
1.2. Main theorems. We now list the main theorems of this paper and some remarks on them.

The following theorem precisely describes the infinite-time blow-up phenomena of the perturbed Yamabe flow (1.6) driven by the bubbles.

Theorem 1.1. Let $\left(M, g_{0}\right)$ be a smooth compact Riemannian manifold of dimension $N \geq 5$ such that

\end{equation*}

Assume that $h$ is a $C^{2}$-function on $M$ such that $\max _{M} h>0$. Given a point $z_{0} \in M$ such that $h\left(z_{0}\right)>0$, there exists an initial datum $u_{z_{0}, 0}$ such that (1.6) has a solution $u_{z_{0}}$ blowing-up at $z_{0}$ as $t \rightarrow \infty$. More precisely, there is a constant $C>0$ depending only on $\left(M, g_{0}\right), N, h$, and $z_{0}$ such that

\begin{cases}u_{z_{0}}(z, t)=\left(1+O\left(\left|\exp _{z_{0}}^{-1}(z)\right|^{2}\right)\right) W_{\mu(t), \xi(t)}\left(\exp _{z_{0}}^{-1}(z)\right) & \text { if } d_{g_{0}}\left(z, z_{0}\right) \leq \delta_{0}  \tag{1.10}\\ u_{z_{0}}(z, t) \leq C \mu^{\frac{N-2}{2}}(t) G\left(z, z_{0}\right) & \text { if } d_{g_{0}}\left(z, z_{0}\right)>\delta_{0}\end{cases}
$$

for $t>0$ large enough, where

- exp is the exponential map on $\left(M, g_{0}\right)$, and $d_{g_{0}}\left(z, z_{0}\right)$ is the geodesic distance between $z$ and $z_{0}$;
- $\delta_{0}>0$ is a sufficiently small number;
$-\mu:[0, \infty) \rightarrow(0, \infty)$ and $\xi:[0, \infty) \rightarrow \mathbb{R}^{N}$ are parameters such that $\mu(t) \simeq t^{-\frac{1}{2}}$ and $|\xi(t)| \lesssim t^{-1+\varepsilon}$ for all $t>0$ large and some $\varepsilon \in(0,1)$ small;
- $G$ is the Green's function of the perturbed conformal Laplacian $L_{g_{0}, h}$ defined in (2.2).

In fact, equation (1.6) also possesses solutions which blow-up at multiple points as $t \rightarrow \infty$.
Theorem 1.2. Let $\left(M, g_{0}\right)$ be a smooth compact Riemannian manifold of dimension $N \geq 5$ such that $Y_{h}\left(M, g_{0}\right)>0$. Assume that $h$ is a $C^{2}$-function on $M$ such that $\max _{M} h>0$. Given any $k \in \mathbb{N}$, choose a $k$-tuple $\mathbf{z}_{0}:=\left\{z_{0}^{(1)}, \ldots, z_{0}^{(k)}\right\}$ of distinct points on $M$ such that $h\left(z_{0}^{(l)}\right)>0$ for $l=1, \ldots, k$. Then there exists an initial datum $u_{\mathbf{z}_{0}, 0}$ such that (1.6) has a solution $u_{\mathbf{z}_{0}}$ blowing-up at each point $z_{0}^{(1)}, \ldots, z_{0}^{(k)}$ as $t \rightarrow \infty$. More precisely, there is a constant $C>0$ depending only on $\left(M, g_{0}\right), N, h, k$, and $\mathbf{z}_{0}$ such that

\begin{cases}u_{\mathbf{z}_{0}}(z, t)=\left(1+O\left(\left|\exp _{z_{0}^{(l)}}^{-1}(z)\right|^{2}\right)\right) W_{\mu^{(l)}(t), \xi^{(l)}(t)}\left(\exp _{z_{0}^{(l)}}^{-1}(z)\right) & \text { if } d_{g_{0}}\left(z, z_{0}^{(l)}\right) \leq \delta_{0}, l=1, \ldots, k, \\ u_{\mathbf{z}_{0}}(z, t) \leq C \mu^{\frac{N-2}{2}}(t) \sum_{l=1}^{k} G\left(z, z_{0}^{(l)}\right) & \text { otherwise }\end{cases}
$$

for $t>0$ large enough, where $\mu^{(l)}:[0, \infty) \rightarrow(0, \infty)$ and $\xi^{(l)}:[0, \infty) \rightarrow \mathbb{R}^{N}$ are parameters such that $\mu^{(l)}(t) \simeq t^{-\frac{1}{2}}$ and $\left|\xi^{(l)}(t)\right| \lesssim t^{-1+\varepsilon}$ for all $t>0$ large and some $\varepsilon \in(0,1)$ small.

Regarding the stability of the solution found above, we have the following result.
Corollary 1.3. In the setting of Theorem 1.2, we further assume that the largest eigenvalue of the Ricci curvature tensor at $z_{0}^{(l)}$ is less than or equal to $-\frac{6}{N-4} h\left(z_{0}^{(l)}\right)$ for each $l=1, \ldots, k$. Let $\sigma \in$ $(0,1)$. There is a $k$-codimensional manifold $\mathcal{M}_{\mathbf{z}_{0}}$ in $C^{2, \sigma}(M)$ containing $u_{\mathbf{z}_{0}}$ such that if $u_{0} \in \mathcal{M}_{\mathbf{z}_{0}}$ is sufficiently close to $u_{\mathbf{z}_{0}, 0}$, then (1.6) has a solution $u$ blowing-up at each point $z_{0}^{(1)}, \ldots, z_{0}^{(k)}$ as $t \rightarrow \infty$.

In the above corollary, the technical condition on the Ricci curvature comes from the ODE system (5.43) that each $\xi^{(l)}$ solves.

Remark 1.4. Theorems 1.1 and 1.2 show that the Yamabe flow is an equation at the borderline guaranteeing the global existence and uniform boundness of solutions. A couple of remarks regarding them are in order.
(1) If $Y\left(M, g_{0}\right)>0$ and $h$ is a function such that $\|h\|_{L^{N / 2}(M)}<Y\left(M, g_{0}\right)$, then a simple application of Hölder's inequality yields that $Y_{h}\left(M, g_{0}\right)>0$. Therefore, if $\left(M, g_{0}\right)$ is a smooth compact Riemannian manifold of dimension $N \geq 5$ such that $Y\left(M, g_{0}\right)>0$, (1.6) exhibits infinite-time blow-up phenomena (with an arbitrary number of blow-up points) provided $h \in C^{2}(M)$ is a sufficiently small and $\max _{M} h>0$.
(2) Our results can be regarded as parabolic analogues of the theorems of Micheletti, Pistoia, and Vétois [36], and of Esposito, Pistoia, and Vétois [21] which assert the existence of blow-up solutions to slightly perturbed (elliptic) Yamabe problems. Their results are related to $C^{2}(M)$-compactness property of the solution set of the Yamabe problem on $\left(M, g_{0}\right)$; see [30, 8] and references therein.

In the elliptic case, the blow-up points must be a critical point of some function involving the function $h$ and a geometric quantity on ( $M, g_{0}$ ); either the Weyl curvature or the $O(1)$-order term of the Green's function of the conformal Laplacian on ( $M, g_{0}$ ). In our evolutionary setting, we only require that $h$ is positive at each blow-up point.

We wonder if there exist non-isolated positive blowing-up solutions (namely, clustering solutions) or isolated non-simple positive blowing-up solutions (namely, bubble-tower solutions) to (1.6) as in the elliptic case [41, 37, 47, 11, 38]. Also, we may ask if (1.6) has a finite-time blowing-up solution. We hope to examine these problems elsewhere.
(3) Our results are in spirit close to the work of Daskalopoulos, del Pino, and Sesum [15] which constructed type II ancient compact solutions to the Yamabe flow on $\mathbb{S}^{N}$, and that of Sire, Wei, and Zheng [46] which built finite-time extinguishing solutions to fast diffusion equations with the critical exponent in smooth bounded domains in $\mathbb{R}^{N}$.

To handle the degeneracy of the equation ( $u^{p-1}$ in (1.6) for our setting), the authors in [46] lifted the spatial domain to a subset of $\mathbb{S}^{N}$ via the stereographic projection so that the equation becomes uniformly parabolic. However, there are limitations in employing their idea directly, because our spatial domain is a general Riemannian manifold $M$ and so it may not be embedded into $\mathbb{S}^{N}$. We will overcome this technical difficulty with the help of a maximum principle adapted to our setting; see Lemma 4.5.
(4) Suppose that $\min _{M} h<0$. In this case, our approach suggests that given a $k$-tuple of points $\mathbf{z}_{0}=\left\{z_{0}^{(1)}, \ldots, z_{0}^{(k)}\right\}$ on $M$ such that $h\left(z_{0}^{(l)}\right)<0$ for $l=1, \ldots, k$, there exist ancient solutions to (1.6) which blow-up at each point $z_{0}^{(1)}, \ldots, z_{0}^{(k)}$ as $t \rightarrow-\infty$. We also suspect the existence of ancient solutions to (1.6) which look like towers of spheres similar to ones found in [15].

There have been extensive studies on type II blow-up solutions to various time-dependent energycritical equations; e.g. the critical nonlinear heat equations [22, 45, 13, 14, 17, 23, 18], the harmonic map heat flows and the nematic liquid crystal flows $[10,2,48,40,16,32]$, the critical wave equations [29, 31, 24, 19, 20, 25, 26], the wave maps equations and the Yang-Mills equations [39, 42], the critical Schrödinger equations and map equations [34, 35], and so on. Our contribution towards this direction is to build solutions to energy-critical degenerate parabolic equations on general Riemannian manifolds, blowing up at an arbitrary number of points. We believe that our method may help construct bubbling solutions to related problems on manifolds, such as the harmonic map heat flow from a smooth closed two-dimensional Riemannian manifold to another provided the target manifold satisfies a certain geometric assumption.

Furthermore, several results on the optimal regularity and sharp extinction rates for fast diffusion equations in bounded domains in $\mathbb{R}^{N}$ were proved recently; refer to [27, 28, 5, 4] among others. In their proofs, Aronson-Bénilan type inequalities (namely, bounds for $u^{-1}\left|u_{t}\right|$; see [1]) appear as one
of the key tools. In our analysis of (1.6), such an inequality is derived in a very specific manner; see (4.4) below and its proof.
1.3. Structure of the paper and comment on the proof. In order to establish Theorems 1.1 and 1.2 as well as Corollary 1.3, we will apply the modulation argument combined with the inner-outer gluing procedure. Our presentation is largely influenced by the paper [14] which studied the existence of infinite-time type II multiple blowing-up solutions to the critical nonlinear heat equations in smooth bounded domains in $\mathbb{R}^{N}$.

From Section 2 to 5 , we only concern the proof of Theorem 1.1. Necessary modifications to prove Theorem 1.2 and the proof of Corollary 1.3 will be provided in Section 6 .

In Section 2, we construct approximate solutions which behave as in (1.10). This is one of the most tricky parts of the proof, because approximate solutions must be sufficiently regular and very close to true solutions for every point on $M$ regardless of its distance from the blow-up point. In particular, the approximate solutions used for the elliptic analogues do not work well in our setting. At points away from the blow-up point, we depict the approximate solution in terms of the Green's function $G$ of the perturbed conformal Laplacian $L_{g_{0}, h}$; cf. [43, 21]. At points near the blow-up point, we deform the bubble by multiplying it by $G$ and then combining the result and a solution to the linear equation (2.30) together. During the refinement, we also determine the main order term of the dilation parameter by solving the ODE (2.36).

In Section 3, we decompose equation (1.6) into the outer problem (3.2) and the inner problem (3.6).

In Section 4, we prove the unique solvability of the outer problem and establish a priori estimates of the solution, by examining the associated inhomogeneous problem (4.1) with the maximum principle for degenerate parabolic equations. A delicate issue is to choose suitable norms to work with. While the authors in [14] worked successfully in a weighted $L^{\infty}$ setting, we cannot do for (1.6) because of its degeneracy $u^{p-1}$. To control the terms resulting from the degeneracy such as $\left(\psi_{\mu, \xi}\right)_{t}$ in (3.4) in a pointwise sense, we will devise various Hölder-type norms; refer to Subsection 1.5. In defining them, we must reflect that the scaling properties in the spatial variable and in the time variable are different from each other, which makes the analysis considerably complicated.

In Section 5, we develop the existence theory for an associated inhomogeneous problem (5.1) to the inner problem. By lifting its spatial domain to $\mathbb{S}^{N}$, we prove that it is solvable whenever the orthogonality condition (5.2) holds. Also, from (5.2), we find a system of ODEs that the dilation and translation parameters satisfy, and solve it. Finally, collecting all the information obtained so far, we find a solution to the inner problem and derive a priori estimate on it, thereby completing the proof of Theorem 1.1.
1.4. Notations. We collect some notations used throughout the paper.

- The Einstein convention is used throughout the paper. Unless otherwise stated, the indices $i, j$, $q, r$, and $s$ take values from 1 to the dimension $N$ of the underlying manifold $M$, and $l$ and $m$ range over values from 1 to the number $k$ of blowing-up points of solutions.
- For a tensor field $T$ on $(M, g)$, a notation such as $T_{; a}$ stands for a covariant derivative of $T$.
- $\mathbb{S}^{N}$ is the standard unit sphere in $\mathbb{R}^{N+1}, g_{\mathbb{S}^{N}}$ is its canonical metric, and $\left|\mathbb{S}^{N}\right|$ is its surface measure.
- $\nabla_{g}, \Delta_{g},\langle\cdot, \cdot\rangle_{g}$, and $|\cdot|_{g}$ are the gradient, the Laplace-Beltrami operator, the inner product, and the norm on $(M, g)$, respectively. On $\left(\mathbb{S}^{N}, g_{\mathbb{S}^{N}}\right)$, we write $\nabla_{\mathbb{S}^{N}}=\nabla_{g_{\mathbb{S}^{N}}}$, etc. In the Euclidean space $\mathbb{R}^{N}$, we write $\nabla=\nabla_{x}, \Delta=\Delta_{x}$, etc, where the subscript $x$ denotes the variable in $\mathbb{R}^{N}$.
- $i\left(M, g_{0}\right)$ is the injectivity radius of $\left(M, g_{0}\right)$.
- For a surface integral, $d S$ denotes the volume form on the domain of integration.
- Given a number $\delta>0$ and a metric $g$ on $M$, let $B^{N}(x, \delta)=\left\{y \in \mathbb{R}^{N}:|y-x|<\delta\right\}$ for $x \in \mathbb{R}^{N}$ and $B_{g}(z, \delta)=\left\{\xi \in M: d_{g}(z, \xi)<\delta\right\}$ for $z \in M$.
- For a function $f$ and $\ell \in \mathbb{N}$, we set $\partial_{i} f=\frac{\partial f}{\partial x_{i}}$ for $i=1, \ldots, N, \dot{f}=f_{t}=\partial_{t} f=\frac{\partial f}{\partial t}$, and

Let also $t_{0}>0$ be a large number, and $\mu=\mu(t)>0$ and $\xi=\xi(t) \in \mathbb{R}^{N}$ be small functions on $\left[t_{0}, \infty\right)$ tending to 0 as $t \rightarrow \infty$. ## 2. Construction of approximate solutions

From Section 2 to Section 5, we will concern the proof of Theorem 1.1, which asserts the existence of solutions to (1.6) blowing-up at a single point $z_{0} \in M$ as $t \rightarrow \infty$. During the proof, we will consider the equation

for $t_{0}>0$ large enough. Clearly, a time translation $u\left(\cdot-t_{0}\right)$ of a solution $u$ to (2.1) solves (1.6).
In this section, we construct approximate solutions through two stages.
In Subsection 2.1, we define the first approximate solution which resembles to a bubble near $z_{0}$ and to the Green's function $G$ of the perturbed conformal Laplacian $L_{g_{0}, h}$ away from $z_{0}$.

In Subsection 2.2, we refine the first approximate solutions in a small neighborhood of $z_{0}$, by attaching solutions of certain linearized equations to the approximate solutions. In order to make the linearized equations solvable, we choose the main order of the dilation factor $\mu(t)>0$ suitably.
2.1. First approximate solutions. Throughout the paper, we always assume that $N \geq 5$.

Let $G$ be the Green's function of $L_{g_{0}, h}$, i.e.,

Given a pair $(\mu, \xi)$ satisfying (2.5)-(2.7), we define

2.2. Second approximation solutions. In this subsection, we refine the approximate solutions to reduce their errors in the ball $B_{g_{0}}\left(z, z_{0}\right)$ significantly. To this end, we introduce a linear equation

This observation turns out to be essential in constructing the refined approximate solution with sufficiently small error.

## 3. InNer-outer gluing procedure

For the sake of brevity, we write $u_{\mu, \xi}=u_{\mu, \xi}^{(2)}$ in the sequel.
In the rest of the paper, we construct a remainder term $\psi_{\mu, \xi}$ such that $u=u_{\mu, \xi}+\psi_{\mu, \xi}$ is a solution to (2.1). To this end, we apply the inner-outer gluing procedure as in [14]. It amounts to decomposing $\psi_{\mu, \xi}$ into two parts

If $\psi_{\mu, \xi}^{\text {out }}$ and $\psi_{\mu, \xi}^{\text {in }}$ solve (3.2) and (3.6), respectively, then $u=u_{\mu, \xi}+\psi_{\mu, \xi}$ will satisfy (2.1) provided it is positive on $M \times\left[t_{0}, \infty\right)$. In Sections 4 and 5 , we will look for solutions to (3.2) and (3.6) with appropriate choices of parameters $(\mu, \xi)$ and initial conditions $u_{0}$, and verify that $u$ is indeed positive.

## 4. Outer problem

This section is devoted to the analysis of the outer problem (3.2).
In Subsections 4.1 and 4.2, we develop existence theory and a priori estimates on a solution to an associated inhomogeneous problem (4.1). The main technical point is to control the degenerate factor $u_{\mu, \xi}^{p-1}$.

In Subsections 4.3 and 4.4, we apply the results for (4.1) and the contraction mapping theorem to derive the unique solvability of (3.2) as well as several a priori estimates on the solution.
4.1. Inhomogeneous problem associated to (3.2): Weighted $H^{2}$ estimate. In this subsection, we will prove the unique existence of a solution to the inhomogeneous problem

We first establish the following version of a priori weighted $H^{2}$ estimate. Refer to Definition 1.7 for the definition of the norms.

&\left.+\mu_{0}^{2}(t)\|\psi\|_{L^{2}\left(M_{\tau}\right)}^{2}+\|f\|_{L^{2}\left(M_{\tau}\right)}^{2}\right]
\end{aligned}

for all $\tau \in\left(t_{0}, s_{0}-1\right]$. Furthermore, we have

\end{aligned}

where Ric $=(N-1) g_{\mathbb{S}^{N}}$ is the Ricci curvature on $\mathbb{S}^{N}$, and we wrote $\bar{\varphi}=\bar{\varphi}_{\infty}, \nabla=\nabla_{\mathbb{S}^{N}}$, etc. Hence, for any $\tau_{0} \in(-\infty, 1)$ fixed and $t>\tau_{0}$,

Then a priori estimate (4.12) with $s_{0}=s_{\ell}$ is true for $\psi_{\ell}$, and the constant $C>0$ in (4.12) is independent of $\ell \in \mathbb{N}$. Thus, passing to a subsequence, $\psi_{\ell}$ converges weakly to a function $\psi_{\infty}$ in a Banach space equipped with the norm $\|\cdot\|_{H_{t_{0}, t}^{2}}$ for each $t>\frac{3 t_{0}}{2}$. As a result, $\psi_{\infty}$ is the only function satisfying (4.1) and (4.27). Setting $\psi=\psi_{\infty}$, we conclude the proof.
4.2. Inhomogeneous problem associated to (3.2): Pointwise estimate. We next derive a pointwise estimate for a solution to the inhomogeneous problem (4.1). A main tool is a version of the maximum principle presented in the following lemma.

Lemma 4.5. Suppose that $\psi$ satisfies

in a weak sense. Then $\psi \geq 0$ on $M \times\left[t_{0}, \infty\right)$.
Proof. Fix $s_{0}>t_{0}$ and let $M\left(s_{0}\right)=M \times\left(t_{0}, s_{0}\right)$. We set

& +p(p-1) \iint_{M\left(s_{0}\right)} u_{\mu, \xi}^{-1}\left(u_{\mu, \xi}\right)_{t} \phi \omega u_{\mu, \xi}^{p-1}-C_{0} p \iint_{M\left(s_{0}\right)} \phi \omega u_{\mu, \xi}^{p-1}+p \iint_{M\left(s_{0}\right)} \phi \omega_{t} u_{\mu, \xi}^{p-1}  \tag{4.28}\\
& -p \int_{M}\left(\phi \omega u_{\mu, \xi}^{p-1}\right)\left(\cdot, s_{0}\right)+p \int_{M}\left(\phi \omega u_{\mu, \xi}^{p-1}\right)\left(\cdot, t_{0}\right)

for any nonnegative regular function $\omega$ on $M\left(s_{0}\right)$, and

Fix a function $\omega_{0} \in C^{\infty}(M)$ such that $\omega_{0} \geq 0$ on $M$. By standard parabolic theory, the backward uniformly parabolic equation

In the rest of this subsection, we will deduce a priori pointwise estimates for (4.1) by means of barrier and rescaling arguments. For the definition of the associated norms, refer to Definition 1.8.

Lemma 4.6. Suppose that $Y_{h}\left(M, g_{0}\right)>0,\|f\|_{L_{t_{0}}^{2}}+\left\|\psi_{0}\right\|_{\mathcal{H}^{1}}<\infty$, and (2.5)-(2.7) hold so that equation (4.1) admits the unique solution $\psi$; refer to Corollary 4.4. Assume further that $\|f\|_{*, \alpha, \rho}+$ $\left\|\psi_{0}\right\|_{* *, \alpha}<\infty$ for some $\alpha \in(0, N-2)$ and $\rho \geq-\frac{N-2}{2}$. Then there exist constants $C>0$ large and $\delta_{1}>0$ small depending only on $\left(M, g_{0}\right), N, h, z_{0}, \alpha$, and $\rho$ such that

Moreover, we write $\psi=\psi\left[f, \psi_{0}\right]$, emphasizing the dependence of $\psi$ on $f$ and $\psi_{0}$. Let $\psi_{1}=\psi\left[0, \psi_{0}\right]$ and $\psi_{2}=\psi[f, 0]$ so that $\psi=\psi_{1}+\psi_{2}$.

Step 1: A bound for $\psi_{1}$. First of all, we assume that $d_{g_{0}}\left(z, z_{0}\right)<\frac{\delta_{0}}{4}$ so that $u(x, t)=(1+$ $P(x)) \mu^{-\frac{N-2}{2}}\left[W_{1,0}(y)+\bar{\mu}^{2} Q_{0}(y)\right]$ for $x=\exp _{z_{0}}^{-1}(z)=\mu y+\xi \in B^{N}\left(0, \frac{\delta_{0}}{4}\right)$ and $t \in\left[t_{0}, \infty\right)$. Given a small number $\delta_{1}>0$, we set

where $C>0$ is a constant depending only on $N$ and $\alpha$. Therefore,

Finally, (4.55) follows directly from (4.64).
4.4. Derivatives of the solution to (3.2) with respect to parameters. In the following proposition, we provide quantitative estimates on the derivatives of $\psi^{\text {out }}$ with respect to its parameters.

Proof. The implicit function theorem implies that the functions $\partial_{\lambda} \psi^{\text {out }}[\bar{\lambda}], \ldots, \partial_{\hat{\psi}}$ in $\psi^{\text {out }}[\bar{\psi}]$ are well-defined in a neighborhood of given data $\left(\lambda, \xi, \dot{\lambda}, \dot{\xi}, \hat{\psi}^{\text {in }}, \psi_{0}\right)$. Examining the equations that the functions solve, we can deduce (4.66). We skip the details, because the necessary computations are similar to those in the proof of Proposition 4.8; refer to [14, Proposition 4.2] where an analogous result was obtained for critical nonlinear heat equation.

## 5. Inner problem and the completion of the proof of Theorem 1.1

This section is devoted to the analysis of the inner problem (3.6), which will allow us to complete the proof of the main theorem.

In Subsection 5.1, we establish the unique solvability and a priori estimate of the non-uniform inhomogeneous parabolic equation

It is clear that $\mathfrak{m}_{0}=p-1$ and $Z_{0}$ is a constant multiple of $W_{1,0}$; refer to [3, Appendix].
Given parameters $(\lambda, \xi)$, and functions $\psi^{\text {in }}$ and $\psi_{0}$ satisfying (2.5)-(2.7) and (4.51), respectively, let $\psi^{\text {out }}=\psi^{\text {out }}\left[\lambda, \xi, \dot{\lambda}, \dot{\xi}, \hat{\psi}^{\text {in }}, \psi_{0}\right]$ be the unique solution to (4.52) found in Proposition 4.8. In Subsection 5.2, we reduce

for $n=1, \ldots, N+1$ and $t \in\left[t_{0}, \infty\right)$ into a system of nonlinear ODEs (5.30) and (5.39) of $(\lambda, \xi)$ and solve it; refer to (1.12), (2.42), (3.1), (3.5), (3.7), (3.8), and Subsection 2.1 for the definition of the notations.

In Subsection 5.3, we solve (3.6) by applying (5.3), the unique solvability of (5.1) under (5.2), and the contraction mapping theorem.

In Subsection 5.4, we complete the proof of Theorem 1.1.
5.1. Linear theory. In this subsection, we examine (5.1) provided $a \in\left(\sigma_{0}, N-2\right)$ and $b \simeq 3$.

Proposition 5.1. Suppose that $\|\mathcal{H}\|_{\sharp, a+2, b ; \sigma_{0}}<\infty$ and (5.2) holds. Then one can find $\psi=\psi[\mathcal{H}]$ and $e_{0}=e_{0}[\mathcal{H}] \in \mathbb{R}$ satisfying (5.1). These $\psi$ and $e_{0}$ are linear in $\mathcal{H}$, and

& \begin{cases}p\left(\varphi_{\ell}\right)_{t}=\frac{\kappa_{N} p}{N}\left(\Delta_{\mathbb{S}^{N}} \varphi_{\ell}+N \varphi_{\ell}\right)+\tilde{\mathcal{H}}_{\ell}-\tilde{c}_{\ell}(t) & \text { on } \mathbb{S}^{N} \times\left(t_{\ell}, s_{\ell}\right) \\
\varphi_{\ell}\left(\tilde{y}, t_{\ell}\right)=0 & \text { on } \mathbb{S}^{N}\end{cases}  \tag{5.13}\\
& \int_{\mathbb{S}^{N}} \widetilde{\mathcal{H}}_{\ell}(\tilde{y}, t) \tilde{y}_{n} d S_{\tilde{y}}=0 \quad \text { for } t \in\left[t_{\ell}, s_{\ell}\right) \text { and } n=1, \ldots, N+1 \tag{5.14}
\end{align*}

Let us check that $\tilde{y}_{\infty}=\tilde{y}_{\text {north }}$. If not, we would have a small number $\delta>0$ such that $d_{\mathbb{S}^{N}}\left(\tilde{y}_{\ell}\right) \geq \delta$ for all large $\ell \in \mathbb{N}$. Let $\chi: \mathbb{S}^{N} \rightarrow[0,1]$ be a smooth function such that $\chi(\tilde{y})=1$ if $d_{\mathbb{S}^{N}}(\tilde{y}) \geq \frac{\delta}{2}$, $\chi(\tilde{y})=0$ if $d_{\mathbb{S}^{N}}(\tilde{y}) \leq \frac{\delta}{4}$, and $|\nabla \chi| \leq \frac{4}{\delta}$ on $\mathbb{S}^{N}$. We test (5.13) against $\chi^{2} \varphi_{\ell}$ for each $\tau \in\left(t_{\ell}, s_{\ell}\right)$, integrate the result over $\left(t_{\ell}, \tau\right)$, and apply (5.11), the initial condition on $\varphi_{\ell},(5.15)$, and Grönwall's inequality. Then we obtain

By the growth condition on $\bar{\varphi}_{\infty}$ in (5.19) and parabolic regularity, $\bar{\varphi}_{\infty}$ is in fact smooth on $\mathbb{S}^{N} \times$ $(-\infty, 0)$ and $\left\|\bar{\varphi}_{\infty}\right\|_{C^{\infty}\left(\mathbb{S}^{N} \times(-\infty, 0)\right)} \leq C$. Also, (5.20) gives

By plugging it into (5.19) and employing (5.20) again, we conclude that $\bar{\varphi}_{\infty}=0$ on $\mathbb{S}^{N} \times(-\infty, 0]$. This is a contradiction, and we must have that $\tilde{y}_{\infty}=\tilde{y}_{\text {north }}$. Especially, $\nu_{\ell}:=d_{\mathbb{S}^{N}}\left(\tilde{y}_{\ell}\right) \rightarrow 0$ and $\left(\tilde{y}_{\ell 1}, \ldots, \tilde{y}_{\ell N}\right) \rightarrow 0 \in \mathbb{R}^{N}$ as $\ell \rightarrow \infty$.

Now, we regard $\varphi_{\ell}$ as the function in $B^{N}\left(0, \frac{1}{2}\right) \times\left(t_{\ell}, s_{\ell}\right)$, abusing the notation

As $\ell \rightarrow \infty, \tilde{\varphi}_{\ell}$ tends to a function $\tilde{\varphi}_{\infty}$ in $\mathbb{R}^{N} \times(-\infty, 0]$ which satsifies

Inequality (5.10) is an immediate consequence of (5.11) and (5.12).

\tilde{d}_{n \ell}(t):=\frac{N+1}{\left|\mathbb{S}^{N}\right|} \int_{\mathbb{S}^{N}} \min \{\tilde{\mathcal{H}}(\tilde{y}, t), \ell\} \tilde{y}_{n} d S_{\tilde{y}} \quad \text { for } t \in\left(t_{0}, s_{\ell}\right) \text { and } n=1, \ldots, N+1,

Clearly, (5.14) holds provided $t_{\ell}=t_{0}$, and $\tilde{d}_{n \ell}(t) \rightarrow 0$ and $\widetilde{\mathcal{H}}_{\ell} \rightarrow \widetilde{\mathcal{H}}$ a.e. as $\ell \rightarrow \infty$.

By applying the Galerkin method, we can construct a solution $\varphi_{\ell}$ to (5.24) such that $\varphi_{\ell}, D_{\tilde{y}} \varphi_{\ell}$, $D_{\tilde{y}}^{2} \varphi_{\ell},\left(\varphi_{\ell}\right)_{t} \in L^{2}\left(\mathbb{S}^{N} \times\left(t_{0}, s_{\ell}\right)\right)$. Lemma 5.2 tells us that such $\varphi_{\ell}$ is unique and

along a subsequence. In particular, $\varphi_{\infty}$ satisfies (5.22) with $\tilde{c}_{0}(t)=\lim _{\ell \rightarrow \infty} \tilde{c}_{\ell}(t)$. Setting $\varphi=\varphi_{\infty}$, we also infer from (5.17) and (5.25) that (5.8)-(5.9) for $s_{0}=\infty$ and (5.23) are valid.

The linear dependence of $\varphi$ and $\tilde{c}_{0}$ in $\widetilde{\mathcal{H}}$ is obvious. This completes the proof.

Also, $\phi=\phi[\mathcal{H}]$ and $c_{0}=c_{0}[\mathcal{H}]$ are linear in $\mathcal{H}$, and

Proof. Let $\Pi: \mathbb{R}^{N} \rightarrow \mathbb{S}_{n}^{N}$ and $\Pi_{*} f: \mathbb{S}_{n}^{N} \rightarrow \mathbb{R}$ be the inverse of the stereographic projection and the weighted push-forward of $f: \mathbb{R}^{N} \rightarrow \mathbb{R}$ in Definition 4.2 , respectively.

We set $\widetilde{\mathcal{H}}=\Pi_{*} \mathcal{H}$ for each fixed $t \in\left[t_{0}, \infty\right)$. If $d_{\mathbb{S}^{N}}(\tilde{y})$ is the geodesic distance on $\mathbb{S}^{N}$ between $\tilde{y}_{\text {north }}=(0, \ldots, 0,1)$ and $\tilde{y}=\Pi(\bar{y})$ for $\bar{y} \in \mathbb{R}^{N}$, then

Given the solution $\left(\varphi, \tilde{c}_{0}\right)$ to (5.22) deduced from Corollary 5.3, we set $\left(\phi, c_{0}\right)$ by

Using this fact and (5.28), one can estimate $\|\phi\|_{\sharp^{\prime}, a, b ; \sigma_{0}\left(\mathbb{R}^{N}\right)}$ as in Step 1 in the proof of Corollary 4.7. We skip the details.

Proof of Proposition 5.1. Let $\phi$ be the solution to (5.26) satisfying (5.27) and (5.29) found in Corollary 5.4. If we set $\psi=\phi+e_{0}(t) Z_{0}$, it satisfies (5.1) provided $e_{0}$ satisfies

Observe that the above estimate on $B_{(N+1) 2}$ has one more term than that on $B_{n 2}$ in (5.37). It is because the integrand of $B_{(N+1) 2}$ decays slower than that of $B_{n 2}$ as $|\bar{y}| \rightarrow \infty$; compare (2.3) and (2.34).

We next solve the system (5.30) and (5.39) of nonlinear ODEs, thereby determining the parameters $(\lambda, \xi)$.

where $C_{73}>0$ is a constant depending only on $\left(M, g_{0}\right), N, h, z_{0}, \alpha$, and $\sigma_{0}$.
Proof. Let us consider the first term of $\mathcal{K}_{2}\left[\psi^{\text {in }}\right]$. Applying the condition $a \in(0, \alpha+2]$, we deduce

$$
\begin{aligned}
& \mu_{0}^{-b}\left(1+|\bar{y}|^{a+2}\right) \eta_{2 \mu_{0}^{\varepsilon_{1}}}(x)\left|\left(\frac{\bar{\mu}}{\mu}\right)^{\frac{N-2}{2}}(1+P)^{-1}(x) W_{1,0}^{p-1}(y) \mu^{\frac{N-2}{2}} \psi_{\mu, \xi}^{\text {out }}(x, t)\right| \\
& \leq C\left\|\psi^{\text {out }}\right\|_{*^{\prime}, \alpha, \rho ; \sigma_{0}} \sup _{(\bar{y}, t) \in \mathcal{B}, \bar{\mu}, \xi \times\left[t_{0}, \infty\right)} \frac{\mu_{0}^{\beta-b}}{1+|\bar{y}|^{\alpha-a+2}} \leq C\left\|\psi^{\text {out }}\right\|_{*^{\prime}, \alpha, \rho ; \sigma_{0}},
\end{aligned}
$$

from which we obtain a weighted $L^{\infty}$-bound. By further inspection, we deduce a weighted Hölder estimate.

Employing the mean value theorem, we can handle the second term of $\mathcal{K}_{1}\left[\psi^{\text {in }}\right]$. Inequality (5.56) then readily follows.
Completion of the proof of Proposition 5.9. Let $\mathcal{T}^{\mathrm{in}}[\mathcal{H}]:=\psi[\mathcal{H}]$ and $e_{0}[\mathcal{H}]$ be the solution to (5.1) found in Proposition 5.1. A function $\psi^{\text {in }}$ solves (5.51) if it satisfies

$$
\psi^{\mathrm{in}}=\mathcal{T}^{\mathrm{in}}\left[f_{\mu, \xi}^{\mathrm{in}}\left[\psi^{\mathrm{in}}, \psi^{\mathrm{out}}\left[\psi^{\mathrm{in}} ; \psi_{0}\right]\right]\right]
$$

where $f_{\mu, \xi}^{\text {in }}$ is the map defined in (5.50), and the notation $\psi^{\text {out }}\left[\psi^{\text {in }} ; \psi_{0}\right]$ emphasizes the dependence of $\psi^{\text {out }}$ on $\psi^{\text {in }}$ and $\psi_{0}$.

We claim that the operator $\mathcal{T}^{\text {in }} \circ f_{\mu, \xi}^{\mathrm{in}}$ has a fixed point on the set

$$
\mathcal{D}^{\text {in }}:=\left\{\psi^{\text {in }}:\left\|\psi^{\text {in }}\right\|_{\mathbb{z}^{\prime}, a, b ; \sigma_{0}\left(\mathbb{R}^{N}\right)} \leq 2 C_{4} C_{71}\right\}
$$

where $C_{4}$ and $C_{71}$ are the numbers appearing in (5.4) and (5.54).

By using (5.4), (5.50), (5.54), (5.55), (5.56), and (4.55), and taking a large $t_{0}>0$ if needed, we get

$$
\begin{align*}
& \left\|\mathcal{T}^{\text {in }}\left[f_{\mu, \xi}^{\text {in }}\left[\psi^{\text {in }}, \psi^{\text {out }}\left[\psi^{\text {in }} ; \psi_{0}\right]\right]\right]\right\|_{\sharp^{\prime}, a, b ; \sigma_{0}\left(\mathbb{R}^{N}\right)} \\
& \leq C_{4}\left\|f_{\mu, \xi}^{\text {in }}\left[\psi^{\text {in }}, \psi^{\text {out }}\left[\psi^{\text {in }} ; \psi_{0}\right]\right]\right\|_{\sharp, a+2, b ; \sigma_{0}}  \tag{5.57}\\
& \leq C_{4}\left[C_{71}+\left(C_{72} \mu_{0}^{2 \varepsilon_{1}}\left(t_{0}\right)+C_{73} \mu_{0}^{2}\left(t_{0}\right)\right)\left\|\psi^{\text {in }}\right\|_{\sharp^{\prime}, a, b ; \sigma_{0}\left(\mathcal{B}_{\bar{\mu}, \xi}\right)}+C_{73}\left\|\psi^{\text {out }}\right\|_{*^{\prime}, \alpha, \rho ; \sigma_{0}}\right] \leq 2 C_{4} C_{71} .
\end{align*}
$$

Moreover, by the linearity of $\mathcal{T}^{\text {in }},(5.4),(4.66)$, and (5.41) (see also the derivation of (5.55)),

$$
\begin{aligned}
& \left\|\mathcal{T}^{\text {in }}\left[f_{(\mu, \xi)\left[\psi_{1}^{\text {in }}\right]}^{\text {in }}\left[\psi_{1}^{\text {in }}, \psi^{\text {out }}\left[\psi_{1}^{\text {in }} ; \psi_{0}\right]\right]\right]-\mathcal{T}^{\text {in }}\left[f_{(\mu, \xi)\left[\psi_{2}^{\text {in }}\right]}^{\text {in }}\left[\psi_{2}^{\text {in }}, \psi^{\text {out }}\left[\psi_{2}^{\text {in }} ; \psi_{0}\right]\right]\right]\right\|_{\sharp^{\prime}, a, b ; \sigma_{0}\left(\mathbb{R}^{N}\right)} \\
& \leq C\left\|f_{(\mu, \xi)\left[\psi_{1}^{\text {in }]}\right.}^{\text {in }}\left[\psi_{1}^{\text {in }}, \psi^{\text {out }}\left[\psi_{1}^{\text {in }} ; \psi_{0}\right]\right]-f_{(\mu, \xi)\left[\psi_{2}^{\text {in }}\right]}^{\text {in }}\left[\psi_{2}^{\text {in }}, \psi^{\text {out }}\left[\psi_{2}^{\text {in }} ; \psi_{0}\right]\right]\right\|_{\sharp, a+2, b ; \sigma_{0}} \\
& \leq C \delta_{0}^{-\zeta} \mu_{0}^{\min \left\{\delta_{4}, 2 \varepsilon_{1}\right\}}\left(t_{0}\right)\left\|\psi_{1}^{\text {in }}-\psi_{2}^{\text {in }}\right\|_{\sharp^{\prime}, a, b ; \sigma_{0}\left(\mathcal{B}_{\bar{\mu}, \xi}\right)} \leq \frac{1}{2}\left\|\psi_{1}^{\text {in }}-\psi_{2}^{\text {in }}\right\|_{\sharp^{\prime}, a, b ; \sigma_{0}\left(\mathcal{B}_{\bar{\mu}, \xi}\right)}
\end{aligned}
$$

where the notation $(\mu, \xi)=(\mu, \xi)\left[\psi^{\text {in }}\right]$ stresses the dependence of $(\mu, \xi)$ in $\psi^{\text {in }}$. By the contraction mapping theorem, the assertion holds.

We now have a unique solution $\psi^{\text {in }}$ to (5.51) with the desired $\sharp^{\prime}$-norm bound given in (5.52). Also, the bound on $e_{0}\left(t_{0}\right)$ in (5.52) immediately follows from (5.4) and (5.57). A further inspection based on (4.67) and (5.42) gives (5.53), concluding the proof.
5.4. Completion of the proof of Theorem 1.1. Let $z_{0}$ be a point on $M$ such that $h\left(z_{0}\right)>0$. In Subsection 2.1, we selected sufficiently small numbers $\varepsilon_{0}, \varepsilon_{1}, \sigma_{0} \in(0,1)$ and set $\nu_{1}=\nu_{2}=2-\varepsilon_{0}$. Take

$$
a=N-4, \quad b=3-\varepsilon_{0}, \quad \alpha=N-5+\varepsilon_{0}, \quad \beta=3-\varepsilon_{0}, \quad \delta_{2}=\varepsilon_{0},
$$

and any $\delta_{4} \in\left(0, \varepsilon_{0}\right]$ satisfying (4.56). Choose also $\psi_{0}=0$ on $M$. From the discussion in Section 3 and Propositions 4.8, 5.8, and 5.9, we find a solution $u_{z_{0}}$ to (1.6) of the form $u_{z_{0}}=u_{\mu, \xi}+\psi_{\mu, \xi}$ on $M \times\left[t_{0}, \infty\right)$ where $u_{\mu, \xi}=u_{\mu, \xi}^{(2)}$ and $\psi_{\mu, \xi}$ are given in (2.39) and (3.1), respectively. Estimates (4.55), (2.7), and (5.52) (or (4.51)) imply that $u_{z_{0}}>0$ on $M \times\left[t_{0}, \infty\right)$ and (1.10) holds. Consequently, the proof of Theorem 1.1 is completed.

Note that we have a freedom to choose the initial value $\psi_{0}=\psi^{\text {out }}\left(\cdot, t_{0}\right)$ on the outer problem (3.2) or (4.52), provided the second inequality of (4.51) holds. In Subsection 6.2, we will further analyze this observation to establish the $k$-codimensional stability stated in Corollary 1.3.

## 6. Proof of Theorem 1.2 and Corollary 1.3

Throughout the section, $k \in \mathbb{N}$ is fixed and $l$ can take any integer between 1 and $k$.
6.1. Proof of Theorem 1.2. In this subsection, we provide the outline of the proof of Theorem 1.2 , pointing out the changes needed with respect to the one bubble case.

By choosing the number $\delta_{0}>0$ sufficiently small, we may assume that $\mathbf{z}_{0}=\left(z_{0}^{(1)}, \ldots, z_{0}^{(k)}\right)$ is an element of the configuration set

$$
\mathcal{C}:=\left\{\left(z_{0}^{(1)}, \ldots, z_{0}^{(k)}\right) \in M^{k}: d_{g_{0}}\left(z_{0}^{(l)}, z_{0}^{(m)}\right) \geq c \delta_{0} \text { for } 1 \leq l \neq m \leq k\right\}
$$

where $c>0$ is a number determined by $\left(M, g_{0}\right), N, h$, and $k$. Given $l=1, \ldots, k$, we write
(6.1) $\quad d^{(l)}:=\frac{1}{\sqrt{h\left(z_{0}^{(l)}\right)}}$ and $\mu^{(l)}(t)=d^{(l)} \mu_{0}(t)+\lambda^{(l)}(t)=: \bar{\mu}^{(l)}(t)+\lambda^{(l)}(t) \quad$ for $t \in\left[t_{0}, \infty\right)$
where $\mu_{0}$ is the function in (2.5), and $\lambda^{(l)}$ is a higher-order term. We assume that (2.7) holds for $(\lambda, \xi)=\left(\lambda^{(l)}, \xi^{(l)}\right)$.

By substituting $z_{0}^{(l)}$ and $\bar{\mu}^{(l)}$ for $z_{0}$ and $\bar{\mu}$, respectively, we define the analogue $P^{(l)}$ of $P$ in (2.14), and the analogue $\Psi_{0}^{(l)}$ of $\Psi_{0}$ in the paragraph after Lemma 2.7. In (2.39)-(2.40), we put $z_{0},(\mu, \xi)$ and $\Psi_{0}$ in place of $z_{0}^{(l)},\left(\mu^{(l)}, \xi^{(l)}\right)$, respectively, to define $u_{\mu^{(l)}, \xi^{(l)}}^{(2)}$ and $v_{\mu^{(l)}, \xi^{(l)}}^{(2)}$. Then we set the refined approximate solution

$$
\begin{equation*}
u_{\boldsymbol{\mu}, \boldsymbol{\xi}}(z, t)=u_{\boldsymbol{\mu}, \boldsymbol{\xi}}^{(2)}(z, t)=\sum_{l=1}^{k} u_{\mu^{(l)}, \boldsymbol{\xi}^{(l)}}^{(2)}(z, t) \quad \text { on } M \times\left[t_{0}, \infty\right) \tag{6.2}
\end{equation*}
$$

where $\boldsymbol{\mu}:=\left(\mu^{(1)}, \ldots, \mu^{(k)}\right) \in(0, \infty)^{k}$ and $\boldsymbol{\xi}:=\left(\xi^{(1)}, \ldots, \xi^{(k)}\right) \in\left(\mathbb{R}^{N}\right)^{k}$. It holds that

$$
\mu^{\frac{N+2}{2} \mathcal{S}}\left(u_{\mu, \boldsymbol{\xi}}^{(2)}\right)(y, t)=\mathcal{E}_{2}\left[\mu^{(l)}, \xi^{(l)}\right](y, t)
$$

for $z=\exp _{z_{0}^{(l)}}(x)=\exp _{z_{0}^{(l)}}\left(\mu^{(l)} y+\xi^{(l)}\right) \in B_{g_{0}}\left(z_{0}^{(l)}, \delta_{0}\right)$ and $t \in\left[t_{0}, \infty\right)$, where $\mathcal{E}_{2}$ is the function in (2.42). Indeed, the interaction between two different bubbles is estimated by

$$
\mathbf{1}_{N=5} \mu_{0}^{3} a^{\{1\}}+\mu_{0}^{N-2} a^{\{N-4\}}\left(\lesssim \mathbf{1}_{N=5} \mu_{0}^{3} a^{\{1\}}+\mu_{0}^{4} a^{\{2\}}\right),
$$

which is smaller than the main order terms of $\mathcal{E}_{2}$. An analogous formula to (2.47) is also true.
The norms in Subsection 1.5 must be adjusted accordingly. For instance, every $u_{\mu, \xi}$ in the norms has to be replaced with $u_{\boldsymbol{\mu}, \boldsymbol{\xi}}$, and the weight $w_{\alpha, \gamma}$ in (1.14) needs to be redefined as

$$
\begin{aligned}
w_{\alpha, \gamma}(z, t)=\max \left\{\sum_{l=1}^{k} \eta_{\delta_{0}}\left(\left|x^{(l)}\right|\right) \frac{\mu_{0}^{-\gamma}}{1+\left|\left(\mu^{(l)}\right)^{-1}\left(x^{(l)}-\xi^{(l)}\right)\right|^{\alpha+\gamma}},\right. \\
\left.2^{3(\alpha+\gamma)} \min \left\{h\left(z_{0}^{(1)}\right), \ldots, h\left(z_{0}^{(k)}\right)\right\}^{-\frac{\alpha+\gamma}{2}} \delta_{0}^{-(\alpha+\gamma)} \mu_{0}^{\alpha}\right\}
\end{aligned}
$$

where $x^{(l)}:=\exp _{z_{0}^{(l)}}^{-1}(z)$.
Let $\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}$ stand for the remainder term such that $u=u_{\boldsymbol{\mu}, \boldsymbol{\xi}}+\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}$ is a solution to (2.1). We assume that it can be written as

$$
\begin{equation*}
\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}=\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}^{\mathrm{out}}+\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}^{\mathrm{in}} \quad \text { on } M \times\left[t_{0}, \infty\right) \tag{6.3}
\end{equation*}
$$

where $\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}^{\mathrm{in}}$ has the form

$$
\begin{equation*}
\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}^{\mathrm{in}}(z, t)=\sum_{l=1}^{k} \eta_{\mu_{0}^{\varepsilon_{1}}}\left(\left|x^{(l)}\right|\right)\left(1+P^{(l)}\left(x^{(l)}\right)\right)\left(\bar{\mu}^{(l)}\right)^{-\frac{N-2}{2}}\left(\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}^{\mathrm{in}}\right)^{(l)}\left(\bar{y}^{(l)}, t\right) \tag{6.4}
\end{equation*}
$$

for $(z, t) \in M \times\left[t_{0}, \infty\right)$ and $x^{(l)}=\bar{\mu}^{(l)} \bar{y}^{(l)}+\xi^{(l)}$. The inner-outer gluing procedure consists of finding a solution $\psi_{\mu, \boldsymbol{\xi}}^{\text {out }}$ to the outer problem on $M \times\left[t_{0}, \infty\right)$ and a solution $\left(\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}^{\text {in }}\right)^{(l)}$ of an inner problem on $B^{N}\left(-\left(\bar{\mu}^{(l)}\right)^{-1} \xi^{(l)}, 2\left(\bar{\mu}^{(l)}\right)^{-1} \mu_{0}^{\varepsilon_{1}}\right) \times\left[t_{0}, \infty\right)$ for $l=1, \ldots, k$.

Minor modifications of the arguments in Sections 4 and 5 yield a priori estimates for inhomogeneous equations associated to the outer and inner problems. For example, the only change required in the proof of Lemma 4.3 is to replace (4.21) with

$$
\int_{0}^{1} \int_{B_{g_{0}}\left(z_{0}^{(m)}, R_{1} \mu_{\ell}^{(m)}\left(\cdot+\tau_{\ell}\right)\right)} \phi_{\ell}^{2} u_{\ell}^{p-1} d v_{g_{0}} d t \geq \frac{1}{4 k}
$$

for some $m \in\{1, \ldots, k\}$. The existence of such $m$ is guaranteed by the pigeonhole principle. To prove Lemma 4.6, we divide the manifold $M$ into $k+1$ subsets $B_{g_{0}}\left(z_{0}^{(1)}, \frac{\delta_{0}}{4}\right), \ldots, B_{g_{0}}\left(z_{0}^{(k)}, \frac{\delta_{0}}{4}\right)$, and $M \backslash \bigcup_{l=1}^{k} B_{g_{0}}\left(z_{0}^{(l)}, \frac{\delta_{0}}{6}\right)$, and then examine the behavior of $\psi$ on each subset.

By employing the a priori estimates for inhomogeneous equations and adopting the arguments in Sections 4 and 5 once again, we establish the existence of $\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}^{\text {out }},\left(\lambda^{(l)}, \xi^{(l)}\right)$, and $\left(\psi_{\mu, \boldsymbol{\xi}}^{\mathrm{in}}\right)^{(l)}$ for $l=1, \ldots, k$ as well as estimates on their respective norms. Combining this information leads us to complete the proof of Theorem 1.2.
6.2. Proof of Corollary 1.3. By modifying the argument in the proof of [14, Corollary 1.1] suitably, one can prove the corollary. Here we give a sketch the proof.

As in the previous subsection, a quantity with the superscript $(l)$ indicates that it is related to the $l$-th blow-up point $z_{0}^{(l)}$.

Fix $l=1, \ldots, k$ and let $\mathcal{M}$ be the matrix in (5.45) with $z_{0}=z_{0}^{(l)}$. If $\varsigma_{1}, \ldots, \varsigma_{N}$ are the eigenvalues of $\mathcal{M}$, then the assumption on the Ricci curvature implies that

$$
\begin{equation*}
\min \left\{\varsigma_{1}, \ldots, \varsigma_{N}\right\} \geq 1>1-\frac{\varepsilon_{0}}{2}=\frac{\nu_{2}+2}{2}-1 . \tag{6.5}
\end{equation*}
$$

Set $\left(\overline{f^{\mathrm{par}}}\right)^{(l)}=\left(\left(f_{1}^{\mathrm{par}}\right)^{(l)}, \ldots,\left(f_{N}^{\mathrm{par}}\right)^{(l)}\right)$ and an orthogonal matrix $\mathcal{Q}$ such that $\mathcal{M}=\mathcal{Q}^{T} \mathcal{D} \mathcal{Q}$ with $\mathcal{D}=\operatorname{diag}\left(\varsigma_{1}, \ldots, \varsigma_{N}\right)$. In light of (6.5), (5.44), (5.46), (5.47), and (5.49), we can select the parameters $\left(\lambda^{(l)}, \xi^{(l)}\right)$ by

$$
\lambda^{(l)}(t)=t^{-\frac{3}{2}} \int_{t_{0}}^{t} s^{\frac{3}{2}}\left(f_{N+1}^{\mathrm{par}}\right)^{(l)}(s) d s
$$

and

$$
\begin{equation*}
\xi^{(l)}(t)=\mathcal{Q}^{T} \tilde{\xi}^{(l)}(t) \quad \text { where } \quad \tilde{\xi}_{i}^{(l)}(t)=t^{-\varsigma_{i}} \int_{t_{0}}^{t} s^{s_{i}}\left[\mathcal{Q}\left(\overline{f^{\mathrm{par}}}\right)^{(l)}\right]_{i}(s) d s \quad \text { for } i=1, \ldots, N . \tag{6.6}
\end{equation*}
$$

They satisfy (2.7), and

$$
\begin{equation*}
\mu^{(l)}\left(t_{0}\right)=d^{(l)} \mu_{0}\left(t_{0}\right), \quad \xi^{(l)}\left(t_{0}\right)=0 \quad \text { and } \quad \xi^{(l)}(t) \rightarrow 0 \quad \text { as } t \rightarrow \infty \tag{6.7}
\end{equation*}
$$

Let $\psi_{0}$ be the initial condition for the outer problem, and $e_{0}^{(l)}\left[\psi_{0}\right] Z_{0}$ the initial condition for the inner problem of $\left(\psi_{\boldsymbol{\mu}, \boldsymbol{\xi}}^{\mathrm{in}}\right)^{(l)}$. Recalling (6.2) and (6.3)-(6.4), we choose the initial datum for (2.1) of the form

$$
\begin{aligned}
u\left(z, t_{0}\right) & =u_{\mu, \boldsymbol{\xi}}\left(z, t_{0}\right)+\sum_{l=1}^{k} \eta_{\mu_{0}^{\varepsilon_{1}}\left(t_{0}\right)}\left(\left|x^{(l)}\right|\right)\left(1+P^{(l)}\left(x^{(l)}\right)\right)\left(\bar{\mu}^{(l)}\left(t_{0}\right)\right)^{-\frac{N-2}{2}} e_{0}^{(l)}[0]\left(t_{0}\right) Z_{0}(z) \\
& +F\left[\psi_{0}\right](z) \quad \text { for } z \in M
\end{aligned}
$$

where

$$
\begin{aligned}
F\left[\psi_{0}\right](z) & :=\psi_{0}(z) \\
& +\sum_{l=1}^{k} \eta_{\mu_{0}^{\varepsilon_{1}}\left(t_{0}\right)}\left(\left|x^{(l)}\right|\right)\left(1+P^{(l)}\left(x^{(l)}\right)\right)\left(\bar{\mu}^{(l)}\left(t_{0}\right)\right)^{-\frac{N-2}{2}}\left[e_{0}^{(l)}\left[\psi_{0}\right]\left(t_{0}\right)-e_{0}^{(l)}[0]\left(t_{0}\right)\right] Z_{0}(z) .
\end{aligned}
$$

According to (6.7), the solution $u(z, t)$ to (2.1) blows up precisely at $z_{0}^{(1)}, \ldots, z_{0}^{(k)}$ on $M$. Besides, $F$ is a $C^{1}$-function on $C^{2, \sigma_{0}}(M)$ (see (5.53)), $F[0]=0$, and $D F\left[\Psi_{0}\right]=I d$ on the subspace $W:=$ $\cap_{l=1}^{k} \operatorname{ker}\left(D_{\psi_{0}} e_{0}^{(l)}[0]\right)$ of $C^{2, \sigma_{0}}(M)$. Hence the inverse function theorem says that there is a manifold of

[^1]codimension $\operatorname{codim}(W) \leq k$ in a neighborhood of $0 \in C^{2, \sigma_{0}}(M)$ such that each element is expressed as $F\left[\psi_{0}\right]$ for some $\psi_{0} \in C^{2, \sigma_{0}}(M)$ near 0 . Calling such a manifold $\mathcal{M}_{\mathbf{z}_{0}}$ and taking $\sigma=\sigma_{0}$, we conclude the proof.
