# HEAT KERNEL ASYMPTOTICS FOR KOHN LAPLACIANS ON CR MANIFOLDS

#### Abstract

Let $X$ be an abstract orientable (not necessarily compact) CR manifold of dimension $2 n+1, n \geq 1$, and let $L^{k}$ be the $k$-th tensor power of a CR complex line bundle $L$ over $X$. Suppose that condition $Y(q)$ holds at each point of $X$, we establish asymptotics of the heat kernel of Kohn Laplacian with values in $L^{k}$. As an application, we give a heat kernel proof of Morse inequalities on compact CR manifolds. When $X$ admits a transversal CR $\mathbb{R}$-action, we also establish asymptotics of the $\mathbb{R}$-equivariant heat kernel of Kohn Laplacian with values in $L^{k}$. As an application, we get $\mathbb{R}$-equivariant Morse inequalities on compact CR manifolds with transversal CR $\mathbb{R}$-action.

## 1. Introduction

Let $X$ be an orientable compact CR manifold of dimension $2 n+1$ and let $L^{k}$ be the $k$-th tensor power of a CR complex line bundle $L$ over $X$. The first author and Marinescu established in [HM12] the Morse inequalities on CR manifolds for $\bar{\partial}_{b}$ complex with values in $L^{k}$. Their approach bases on the study of asymptotic behavior of the Szegő kernels. In complex geometry, Demailly[D91], Bismut[BM87] used the heat kernel asymptotics for Kodaira Laplacians to establish Morse inequalities on complex manifolds (see also [MM07,

Section 1.6]). It is a natural question that if we can also establish Morse inequalities on CR manifolds by using heat kernel asymptotics. On the other hand, the study of the heat kernel asymptotics is interesting in itself because it is closely related to some problems in CR geometry like CR torsion problems, CR geometric quantization, $G$-equivariant CR Morse inequalities, etc. The purpose of this paper is to establish the heat kernel asymptotics of Kohn Laplacian with values in $L^{k}$. When $X$ admits a transversal CR $\mathbb{R}$-action, we also establish asymptotics of the $\mathbb{R}$-equivariant heat kernel of Kohn Laplacian with values in $L^{k}$. As an application, we get $\mathbb{R}$-equivariant Morse inequalities on compact CR manifolds with transversal CR $\mathbb{R}$-action. We will combine the techniques of [HM12] and Ma-Marinescu [MM07, Section 1.6] to get the heat kernel asymptotics of Kohn Laplacian on CR manifolds with values in $L^{k}$.

We now formulate the main results. We refer the reader to Section 2 for some notations and terminology used here. Let $\left(X, T^{1,0} X\right)$ be an abstract orientable (not necessarily compact) CR manifold of dimension $2 n+1, n \geq 1$, and let ( $L^{k}, h^{L^{k}}$ ) be the $k$-th tensor power of a CR complex line bundle ( $L, h^{L}$ ) over $X$, where $h^{L}$ denotes a Hermitian metric of $L$. Fix a Hermitian metric $\langle\cdot \mid \cdot\rangle$ on $\mathbb{C} T X$ so that $T^{1,0} X \perp T^{0,1} X$. Let $(\cdot \mid \cdot)_{h^{L^{k}}}$ be the $L^{2}$ inner product on $\Omega_{c}^{0, q}\left(X, L^{k}\right)$ induced by $\langle\cdot \mid \cdot\rangle$ and $h^{L^{k}}$. Let $L_{(0, q)}^{2}\left(X, L^{k}\right)$ be the completion of $\Omega_{c}^{0, q}\left(X, L^{k}\right)$ with respect to $(\cdot \mid \cdot)_{h^{L^{k}}}$. Let

\square_{b, k}^{q}: \operatorname{Dom} \square_{b, k}^{q} \subset L_{(0, q)}^{2}\left(X, L^{k}\right) \rightarrow L_{(0, q)}^{2}\left(X, L^{k}\right)
$$

be the Gaffney extension of Kohn Laplacian with values in $L^{k}$ (see (2.5)). Then, $\square_{b, k}^{q}$ is a non-negative self-adjoint operator. Let

e^{-t \square_{b, k}^{q}}: L_{(0, q)}^{2}\left(X, L^{k}\right) \rightarrow L_{(0, q)}^{2}\left(X, L^{k}\right)
$$

be the heat operator of $\square_{b, k}^{q}$ and let

$$
e^{-t \square_{b, k}^{q}}(x, y) \in \mathscr{D}^{\prime}\left(\mathbb{R}_{+} \times X \times X,\left(T^{* 0, q} X \otimes L^{k}\right) \boxtimes\left(T^{* 0, q} X \otimes L^{k}\right)^{*}\right)
$$

be the distribution kernel of $e^{-t \square_{b, k}^{q}}$ with respect to $d v_{X}(x)$ (see the discussion after (2.9)), where $d v_{X}(x)$ is the volume form on $X$ induced by $\langle\cdot \mid \cdot\rangle$. Assume that $Y(q)$ holds (see Definition 2.2, for the meaning of condition $Y(q))$. Then,

e^{-t \square_{b, k}^{q}}(x, y) \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times X \times X,\left(T^{* 0, q} X \otimes L^{k}\right) \boxtimes\left(T^{* 0, q} X \otimes L^{k}\right)^{*}\right)
$$

We will use the canonical identification $\operatorname{End}\left(L^{k}\right)=\mathbb{C}$, especially

e^{-t \square_{b, k}^{q}}(x, x) \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times X \times X, T^{* 0, q} X \boxtimes\left(T^{* 0, q} X\right)^{*}\right)
$$

(see (2.14)). The main goal of this work is to study the asymptotic behavior $e^{-\frac{t}{k} \square_{b, k}^{q}}(x, x)$ as $k \rightarrow+\infty$.

To state our main results, we introduce some notations. Let $s$ be a local CR trivializing section of $L$ defined on an open set $D$ of $X,|s|_{h^{L}}^{2}=e^{-\phi}, \phi \in \mathscr{C}^{\infty}(D, \mathbb{R})$. For $x \in D$, let $\mathcal{R}_{x}^{\phi}$ be the Hermitian quadratic form on $T_{x}^{1,0} X$ induced by $\phi$ (see Definition 4.5). Let

& \dot{\mathcal{R}}_{x}^{\phi}: T_{x}^{1,0} X \rightarrow T_{x}^{1,0} X, \\
& \dot{\mathcal{L}}_{x}: T_{x}^{1,0} X \rightarrow T_{x}^{1,0} X, \tag{1.1}
\end{align*}
$$

be the linear maps given by $\left\langle\dot{\mathcal{R}}_{x}^{\phi} U \mid V\right\rangle=\mathcal{R}_{x}^{\phi}(U, \bar{V}),\left\langle\dot{\mathcal{L}}_{x} U \mid V\right\rangle=\mathcal{L}_{x}(U, \bar{V})$, for all $U, V \in T_{x}^{1,0} X$, where $\mathcal{L}_{x}$ is the Levi form of $X$ at $x$ (see Definition 2.1). For every $\eta \in \mathbb{R}$, let

\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)=\mu_{1}(x) \cdots \mu_{n}(x)
$$

where $\mu_{j}(x), j=1, \ldots, n$, are the eigenvalues of $\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}$ with respect to $\langle\cdot \mid \cdot\rangle$, and put

\begin{equation*}
\omega_{x}^{\eta}=\sum_{j, l=1}^{n}\left(\mathcal{R}_{x}^{\phi}-2 \eta \mathcal{L}_{x}\right)\left(U_{l}, \bar{U}_{j}\right) \bar{\omega}^{j} \wedge\left(\bar{\omega}^{l} \wedge\right)^{\star}: T_{x}^{* 0, q} X \rightarrow T_{x}^{* 0, q} X \tag{1.2}
\end{equation*}
$$

where $\left\{U_{j}\right\}_{j=1}^{n}$ is an orthonormal frame of $T_{x}^{1,0} X$ with dual frame $\left\{\omega^{j}\right\}_{j=1}^{n} \subset T_{x}^{* 1,0} X$. It is straightforward to check that if $Y(q)$ holds, the map

\int_{\mathbb{R}} \frac{\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}{\operatorname{det}\left(1-e^{-t\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}\right)} e^{-t \omega_{x}^{\eta}} d \eta: T_{x}^{* 0, q} X \rightarrow T_{x}^{* 0, q} X \tag{1.3}
\end{equation*}
$$

is well-defined as a continuous linear map. It should be mentioned that the definition of $\mathcal{R}_{x}^{\phi}$ depends on the choice of local trivializations (local weight $\phi$ ). From [HM12, Proposition 4.2 ], it is easy to see that for every $x \in X$, the map (1.3) is independent of the choice of local weight $\phi$ and hence globally defined. Let $\mathscr{L}\left(T_{x}^{* 0, q} X, T_{x}^{* 0, q} X\right)$ denotes the linear map from $T_{x}^{* 0, q} X$ to $T_{x}^{* 0, q} X$. For $f(x) \in \mathscr{L}\left(T_{x}^{* 0, q} X, T_{x}^{* 0, q} X\right)$, let

|f(x)|_{\mathscr{L}\left(T_{x}^{\left.* 0, q_{X}, T_{x}^{* 0, q} X\right)}\right.}:=\sum_{j, \ell=1}^{d}\left|\left\langle f(x) v_{j}(x) \mid v_{\ell}(x)\right\rangle\right| \tag{1.4}
\end{equation*}

where $\left\{v_{j}(x)\right\}_{j=1}^{d}$ is an orthonormal basis of $T_{x}^{* 0, q} X$ with respect to $\langle\cdot \mid \cdot\rangle$.
Our first main result is the following
Theorem 1.1. Let $X$ be an orientable (not necessarily compact) $C R$ manifold of dimension $2 n-1, n \geq 1$, and $\left(L^{k}, L^{L^{k}}\right)$ be the $k$-th tensor power of a CR complex line bundle $\left(L, h^{L}\right)$ over $X$. Given $q \in\{0,1, \ldots, n\}$. Suppose that condition $Y(q)$ holds at each point of $X$. With the notations used above, let $I \subset \mathbb{R}_{+}$be a compact interval and let $K \Subset X$ be a compact set. Then, there is a constant $C>0$ independent of $k$ such that

\left|e^{-t \square_{b, k}^{q}}(x, x)\right|_{\mathscr{L}\left(T_{x}^{* 0, q} X, T_{x}^{* 0, q} X\right)} \leq C k^{n+1}, \quad \text { for all } x \in K \text { and } t \in I \text {. } \tag{1.5}
\end{equation*}
$$

Moreover, for every $x \in X$, we have

\lim _{k \rightarrow \infty} k^{-(n+1)} e^{-\frac{t}{k} \square_{b, k}^{q}}(x, x)=\frac{1}{(2 \pi)^{n+1}} \int_{\mathbb{R}} \frac{\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}{\operatorname{det}\left(1-e^{-t\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}\right)} e^{-t \omega_{x}^{\eta}} d \eta \tag{1.6}
\end{equation*}
$$

Consider the following $\bar{\partial}_{b}$-complex:

\cdots \longrightarrow \Omega^{0, q-1}\left(X, L^{k}\right) \xrightarrow{\bar{\partial}_{b}} \Omega^{0, q}\left(X, L^{k}\right) \xrightarrow{\bar{\partial}_{b}} \Omega^{0, q+1}\left(X, L^{k}\right) \longrightarrow \cdots
$$

and put

$$
H_{b}^{q}\left(X, L^{k}\right):=\frac{\operatorname{Ker} \bar{\partial}_{b}: \Omega^{0, q}\left(X, L^{k}\right) \rightarrow \Omega^{0, q+1}\left(X, L^{k}\right)}{\operatorname{Im} \bar{\partial}_{b}: \Omega^{0, q-1}\left(X, L^{k}\right) \rightarrow \Omega^{0, q}\left(X, L^{k}\right)}, \quad 0 \leq q \leq n
$$

Kohn(see $[\mathrm{K} 65, \mathrm{FK} 72])$ showed that if $Y(q)$ holds and $X$ is compact, then

H_{b}^{q}\left(X, L^{k}\right) \cong \operatorname{Ker} \square_{b, k}^{q}, \quad \operatorname{dim} H_{b}^{q}\left(X, L^{k}\right)=\operatorname{dim} \operatorname{Ker} \square_{b, k}^{q}<+\infty
$$

When $X$ is compact and $Y(q)$ holds on $X$, From Theorem 1.1 as well as applying fundamental trace inequalities which depend on $k>0$ (see, e.g., [BM87, Theorem 1.4], [MM07, Section 1.6]), we get the following Hsiao-Marinescu's Morse inequalities on CR manifolds:

Theorem 1.2 (Hsiao-Marinescu). Let $X$ be an orientable compact $C R$ manifold with $\operatorname{dim}_{\mathbb{R}} X=2 n+1, n \geq 1$, and $\left(L^{k}, h^{L^{k}}\right)$ be the $k$-th tensor power of a $C R$ complex line bundle $\left(L, h^{L}\right)$ over $X$. Suppose that condition $Y(j)$ holds at each point of $X$, for all $j=0,1,2, \cdots, q$. With the notations used above, as $k \rightarrow \infty$, we have

\begin{align*}
& \sum_{j=0}^{q}(-1)^{q-j} \operatorname{dim} H_{b}^{j}\left(X, L^{k}\right)  \tag{1.7}\\
& \leq \frac{k^{n+1}}{(2 \pi)^{n+1}} \sum_{j=0}^{q}(-1)^{q-j} \int_{X} \int_{\mathbb{R}_{x}(j)}\left|\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)\right| d \eta d v_{X}(x)+o\left(k^{n+1}\right)
\end{align*}
$$

where

$$
\begin{gathered}
\mathbb{R}_{x}(j)=\left\{\eta \in \mathbb{R} \mid \dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x} \text { has exactly } j\right. \text { negative eigenvalues } \\
\text { and } n-j \text { positive eigenvalues }\} .
\end{gathered}
$$

When $Y(q)$ holds, we have

$$
\begin{equation*}
\operatorname{dim} H_{b}^{q}\left(X, L^{k}\right) \leq \frac{k^{n+1}}{(2 \pi)^{n+1}} \int_{X} \int_{\mathbb{R}_{x}(q)}\left|\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)\right| d \eta d v_{X}(x)+o\left(k^{n+1}\right) \tag{1.8}
\end{equation*}
$$

It is worth to mention that the function

$$
x \in X \rightarrow \int_{\mathbb{R}_{x}(j)}\left|\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)\right| d \eta \in \mathbb{R}
$$

is independent of the choice of local weight $\phi$.
As we see, to establish above theorems, we need the assumptions that the Levi form satisfies condition $Y(q)$. However, in some important problems in CR geometry, we may need to study things without any assumption of the Levi form. Therefore, we consider CR manifolds with group action. Let $X$ be an orientable (not necessarily compact) CR manifold with $\operatorname{dim}_{\mathbb{R}} X=2 n+1, n \geq 1$, Suppose that $X$ admits a transversal and CR $\mathbb{R}$-action $\eta, \eta \in \mathbb{R}: \eta: X \rightarrow X, x \mapsto \eta \circ x$ (see Definition 2.5 for the meaning of transversal and $\mathrm{CR} \mathbb{R}$-action). Let $T \in \mathscr{C}^{\infty}(X, T X)$ be the infinitesimal generator of the $\mathbb{R}$-action (see (2.16)). Suppose that $X$ admits a $\mathbb{R}$-invariant complete Hermitain metric $\langle\cdot \mid \cdot\rangle$ on $\mathbb{C} T X$ so that we have the orthogonal decomposition

\mathbb{C} T X=T^{1,0} X \oplus T^{0,1} X \oplus\{\lambda T: \lambda \in \mathbb{C}\}
$$

and $|T|^{2}=\langle T \mid T\rangle=1$. Let $\left(L, h^{L}\right)$ be a rigid CR line bundle over $X$ with a $\mathbb{R}$-invariant Hermitian metric $h^{L}$ on $L$ (see Definition 2.6 for the meaning of rigid CR line bundles). We will use the same notations as before. Consider the operator

-i T: \Omega_{c}^{0, q}\left(X, L^{k}\right) \rightarrow \Omega_{c}^{0, q}\left(X, L^{k}\right)
$$

and we extend $-i T$ to $L_{(0, q)}^{2}\left(X, L^{k}\right)$ in the standard way (see (2.19)). Fix $\delta>0$, let

& L_{(0, q), \leq k \delta}^{2}\left(X, L^{k}\right):=E_{-i T}([-k \delta, k \delta]), \\
& \Omega_{\leq k \delta}^{0, q}\left(X, L^{k}\right):=\Omega^{0, q}\left(X, L^{k}\right) \bigcap L_{(0, q), \leq k \delta}^{2}\left(X, L^{k}\right),
\end{aligned}
$$

where $E_{-i T}$ denotes the spectral measure of $-i T$. Let

Q_{X, \leq k \delta}: L_{(0, q)}^{2}\left(X, L^{k}\right) \rightarrow L_{(0, q), \leq k \delta}^{2}\left(X, L^{k}\right)
$$

be the orthogonal projection with respect to $(\cdot \mid \cdot)_{h^{L^{k}}}$.
We have the following partial $\bar{\partial}_{b}$-complex:

\cdots \longrightarrow \Omega_{\leq k \delta}^{0, q-1}\left(X, L^{k}\right) \xrightarrow{\bar{\partial}_{b}} \Omega_{\leq k \delta}^{0, q}\left(X, L^{k}\right) \xrightarrow{\bar{\partial}_{b}} \Omega_{\leq k \delta}^{0, q+1}\left(X, L^{k}\right) \longrightarrow \cdots
$$

and put

H_{b, \leq k \delta}^{q}\left(X, L^{k}\right):=\frac{\operatorname{Ker} \bar{\partial}_{b}: \Omega_{\leq k \delta}^{0, q}\left(X, L^{k}\right) \rightarrow \Omega_{\leq k \delta}^{0, q+1}\left(X, L^{k}\right)}{\operatorname{Im} \bar{\partial}_{b}: \Omega_{\leq k \delta}^{0, q-1}\left(X, L^{k}\right) \rightarrow \Omega_{\leq k \delta}^{0, q}\left(X, L^{k}\right)}, \quad 0 \leq q \leq n .
$$

Let

$$
\begin{aligned}
& \square_{b, k, \leq k \delta}^{q}: \operatorname{Dom} \square_{b, k}^{q} \bigcap L_{(0, q), \leq k \delta}^{2}\left(X, L^{k}\right) \rightarrow L_{(0, q), \leq k \delta}^{2}\left(X, L^{k}\right), \\
& \square_{b, k, \leq k \delta}^{q} u=\square_{b, k}^{q} u, \quad u \in \operatorname{Dom} \square_{b, k}^{q} \bigcap L_{(0, q), \leq k \delta}^{2}\left(X, L^{k}\right) .
\end{aligned}
$$

(See also (2.23).) It is not difficult to check that without $Y(q)$ condition,

H_{b, \leq k \delta}^{q}\left(X, L^{k}\right) \cong \operatorname{Ker} \square_{b, k, \leq k \delta}^{q}, \quad \operatorname{dim} H_{b, \leq k \delta}^{q}\left(X, L^{k}\right)<+\infty
$$

Let

e^{-t \square_{b, k, \leq k \delta}^{q}}:=e^{-t \square_{b, k}^{q}} \circ Q_{X, \leq k \delta}: L_{(0, q)}^{2}\left(X, L^{k}\right) \rightarrow \operatorname{Dom} \square_{b, k, \leq k \delta}^{q}, \quad t>0,
$$

and let

$$
e^{-t \square_{b, k, \leq k \delta}^{q}(x, y) \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times X \times X,\left(T^{* 0, q} X \otimes L^{k}\right) \boxtimes\left(T^{* 0, q} X \otimes L^{k}\right)^{*}\right) .}
$$

be the distribution kernel of $e^{-t \square_{b, k, \leq k \delta}^{q}}$ with respect to $d v_{X}(x)$. As before, we will use the canonical identification $\operatorname{End}\left(L^{k}\right)=\mathbb{C}$. Our second main result is the following

Theorem 1.3. Let $X$ be an orientable (not necessarily compact) CR manifold of dimension $2 n-1, n \geq 1$, with a transversal $C R \mathbb{R}$-action. Suppose that $X$ admits a $\mathbb{R}$-invariant complete Hermitian metric $\langle\cdot \mid \cdot\rangle$ on $\mathbb{C} T X$ so that we have the orthogonal decomposition

$$
\mathbb{C} T X=T^{1,0} X \oplus T^{0,1} X \oplus\{\lambda T: \lambda \in \mathbb{C}\}
$$

and $|T|^{2}=\langle T \mid T\rangle=1$, where $T \in \mathscr{C}^{\infty}(X, T X)$ is the infinitesimal generator of the $\mathbb{R}$-action. Let $\left(L^{k}, h^{L^{k}}\right)$ be the $k$-th tensor power of a rigid CR complex line bundle ( $L, h^{L}$ ) over $X$, where $h^{L}$ is a $\mathbb{R}$-invariant Hermitian metric on $L$. Fix any $q \in\{0,1, \ldots, n\}$. With the notations used above, let $I \subset \mathbb{R}_{+}$be a compact interval and let $K \Subset X$ be a compact set. Then, there is a constant $C>0$ independent of $k$ such that

\left|e^{-t \square_{b, k, \leq k \delta}^{q}}(x, x)\right|_{\mathscr{L}\left(T_{x}^{* 0, q} X, T_{x}^{* 0, q} X\right)} \leq C k^{n+1}, \quad \text { for all } x \in K \text { and } t \in I . \tag{1.9}
\end{equation*}
$$

Moreover, for every $x \in X$, we have

\lim _{k \rightarrow \infty} k^{-(n+1)} e^{-\frac{t}{k} \square_{b, k, \leq k \delta}^{q}}(x, x)=\frac{1}{(2 \pi)^{n+1}} \int_{-\delta}^{\delta} \frac{\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}{\operatorname{det}\left(1-e^{-t\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}\right)} e^{-t \omega_{x}^{\eta}} d \eta \tag{1.10}
\end{equation*}
$$

Note that in Theorem 1.3, we do not need any Levi curvature assumption. As an application of Theorem 1.3, we get the following Morse inequalities which generalize the results in [HL18] for CR manifolds with $S^{1}$ action:

Theorem 1.4. With the same assumptions and notations used in Theorem 1.3, suppose that $X$ is compact. As $k \rightarrow \infty$, we have the following Morse inequalities: for every $q \in\{0,1, \ldots, n\}$,

& \leq \frac{k^{n+1}}{(2 \pi)^{n+1}} \sum_{j=0}^{q}(-1)^{q-j} \int_{X} \int_{\mathbb{R}_{x}(j) \cap[-\delta, \delta]}\left|\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)\right| d \eta d v_{X}(x)+o\left(k^{n+1}\right)
\end{align*}
$$

with equality for $q=n$.
For every $q \in\{0,1, \ldots, n\}$, we have

\operatorname{dim} H_{b, \leq k \delta}^{q}\left(X, L^{k}\right) \leq \frac{k^{n+1}}{(2 \pi)^{n+1}} \int_{X} \int_{\mathbb{R}_{x}(q) \cap[-\delta, \delta]}\left|\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)\right| d \eta d v_{X}(x)+o\left(k^{n+1}\right) . \tag{1.12}
\end{equation*}

Our paper is organized in the following way. In Section 2, we collect some standard notations, terminology, definitions, and statements we use throughout. In Section 3, we introduce the Kohn Laplacian $\square_{H_{n}, \Phi}^{q}$ on the Heisenberg group and find the relationship between the smooth kernel of heat operators $e^{-\frac{t}{k} \square_{b, k}^{q}}$ and $e^{-t \square_{H_{n}, \Phi}^{q}}$ in local. This process is achieved by comparing the scaled Kohn Laplacian $\square_{\rho,(k)}^{q}$ and $\square_{H_{n}, \Phi}^{q}$. We then compute $e^{-t \square_{H_{n}, \Phi}^{q}}(0,0)$ explicitly and establish Theorem 1.1 in Section 4. In Section 5, we obtain Morse inequalities on CR manifolds by using Theorem 1.1. In Section 6, we show that the same conclusions can be drawn when $X$ admits a transversal CR $\mathbb{R}$-action, without any assumption of the Levi form.

Throughout this paper, we will use $C\left(C_{t}\right)$ to denote constants(the constants depend on $t$ ) which might not be the same in different appearances.

## 2. Preliminary

2.1. Standard notations. We shall use the following notations: $\mathbb{N}=\{1,2, \ldots\}$ is the set of natural numbers, $\mathbb{N}_{0}=\mathbb{N} \cup\{0\}, \mathbb{R}$ is the set of real numbers, $\mathbb{R}_{+}:=\{x \in \mathbb{R} \mid x>0\}$, $\overline{\mathbb{R}_{+}}:=\{x \in \mathbb{R} \mid x \geq 0\}$. For a multiindex $\alpha=\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in \mathbb{N}_{0}^{n}$ we denote by $|\alpha|=$ $\alpha_{1}+\ldots+\alpha_{n}$ its norm and by $l(\alpha)=n$ its length. For $m \in \mathbb{N}$, write $\alpha \in\{0,1, \ldots, m\}^{n}$ if $\alpha_{j} \in\{0,1, \ldots, m\}, j=1, \ldots, n . \alpha$ is strictly increasing if $\alpha_{1}<\alpha_{2}<\ldots<\alpha_{n}$. For
$x=\left(x_{1}, \ldots, x_{n}\right)$ we write

Let $z=\left(z_{1}, \ldots, z_{n}\right), z_{j}=x_{2 j-1}+i x_{2 j}, j=1, \ldots, n$, be coordinates of $\mathbb{C}^{n}$. We write

For $j, s \in \mathbb{Z}$, set $\delta_{j, s}=1$ if $j=s, \delta_{j, s}=0$ if $j \neq s$.
Let $W$ be a $\mathscr{C}^{\infty}$ paracompact manifold. We let $T W$ and $T^{*} W$ denote the tangent bundle of $W$ and the cotangent bundle of $W$ respectively. The complexified tangent bundle of $W$ and the complexified cotangent bundle of $W$ are denoted by $\mathbb{C} T W$ and $\mathbb{C} T^{*} W$, respectively. Write $\langle\cdot, \cdot\rangle$ to denote the pointwise duality between $T W$ and $T^{*} W$. We extend $\langle\cdot, \cdot\rangle$ bilinearly to $\mathbb{C} T W \times \mathbb{C} T^{*} W$. Let $G$ be a $\mathscr{C}^{\infty}$ vector bundle over $W$. The fiber of $G$ at $x \in W$ will be denoted by $G_{x}$. Let $E$ be another vector bundle over $W$. We write $E \boxtimes G^{*}$ to denote the vector bundle over $W \times W$ with fiber over $(x, y) \in W \times W$ consisting of the linear maps from $G_{y}$ to $E_{x}$. Let $Y \subset W$ be an open set. From now on, the spaces of distribution sections of $G$ over $Y$ and smooth sections of $G$ over $Y$ will be denoted by $\mathscr{D}^{\prime}(Y, G)$ and $\mathscr{C}^{\infty}(Y, G)$ respectively. Let $\mathscr{E}^{\prime}(Y, G)$ be the subspace of $\mathscr{D}^{\prime}(Y, G)$ whose elements have compact support in $Y$ and let $\mathscr{C}_{c}^{\infty}(Y, G)$ be the subspace of $\mathscr{C}^{\infty}(Y, G)$ whose elements have compact support in $Y$.
2.2. Set up. In this section, we introduce the basic notations on CR manifolds. It is worthwhile to mention that most of our notations follow the fundamental setting of [HM12] and [HL18].

Let $\left(X, T^{1,0} X\right)$ be an orientable $2 n+1$-dimensional (possibly non-compact) CR manifold, equipped with a Hermitian metric $\langle\cdot \mid \cdot\rangle$, so that $T^{1,0} X$ is orthogonal to $T^{0,1} X:=$ $\overline{T^{1,0} X}, n \geq 1$. Then there is a real non-vanishing vector field $T$ on $X$ which is pointwise orthogonal to $T^{1,0} X \oplus T^{0,1} X,\|T\|^{2}=\langle T \mid T\rangle=1$. We then have the following orthogonal decompositions:

where $T^{* 1,0} X, T^{* 0,1} X$ and $\left\{\lambda \omega_{0} \mid \lambda \in \mathbb{C}\right\}$ are the dual bundles of $T^{1,0} X, T^{0,1} X$ and $\{\lambda T \mid \lambda \in \mathbb{C}\}$, respectively, $\left\langle\omega_{0}, T\right\rangle=-1$. The Hermitian metric on $\mathbb{C} T^{*} X$ is induced by $\langle\cdot \mid \cdot\rangle$ by duality. Hereafter, we denote all these induced metrics by $\langle\cdot \mid \cdot\rangle$. Note the vector field $T$ here is first choosed locally, then by restriction to the coordinate transformations which preserve $T^{1,0} X$ and orientation, a local choice of sign in the direction of $T$ can extend $T$ to a global one.

Definition 2.1. For $x \in X$, the Hermitian quadratic form $\mathcal{L}_{x}$ on $T_{x}^{1,0} X$ defined by

is called the Levi form associated with $\omega_{0}$, where $U, V \in T_{x}^{1,0} X, \mathcal{U}$ and $\mathcal{V}$ are smooth sections on $T^{1,0} X$ such that $\mathcal{U}(x)=U, \mathcal{V}(x)=V$. Note that the Levi form $\mathcal{L}_{x}$ does not depends on the choices of $\mathcal{U}$ and $\mathcal{V}$.
Let $x \in X$. Locally there is an orthonormal basis $\mathcal{U}_{1}, \cdots, \mathcal{U}_{n}$ of $T^{1,0} X$ such that $\mathcal{L}_{x}$ is diagonal in this basis, $\mathcal{L}_{x}\left(\mathcal{U}_{j}, \mathcal{U}_{l}\right)=\delta_{j, l} \lambda_{j}(x), j, l=1, \ldots, n$. The entries $\left\{\lambda_{1}(x), \cdots, \lambda_{n}(x)\right\}$ are called the eigenvalues of the Levi form at $x \in X$.
Definition 2.2. Let $X$ be an oriented CR manifold of real dimension $2 n+1$ with $n \geq 1$. $X$ is said to satisfy condition $Y(q), 0 \leq q \leq n$, if the Levi form has at least either $\max (n+1-q, q+1)$ eigenvalues of the same $\operatorname{sign}$ or $\min (n+1-q, q+1)$ pairs of eigenvalues of the opposite signs at every point on $X$.

Define by $T^{* 0, q} X:=\Lambda^{q} T^{* 0,1} X$ the bundle of $(0, q)$-forms on $X, 0 \leq q \leq n$. For $u \in T^{* 0, r} X$, let $(u \wedge)^{*}: T^{* 0, q+r} X \rightarrow T^{* 0, q} X$ be the adjoint of $u \wedge: T^{* 0, q} X \rightarrow T^{* 0, q+r} X$ with respect to $\langle\cdot \mid \cdot\rangle$, that is

for all $w \in T^{* 0, q} X$ and $v \in T^{* 0, q+r} X$. We write $|u|^{2}=\langle u \mid u\rangle$.
Let $D \subset X$ be an open set. We let $\Omega^{0, q}(D)$ and $\Omega_{c}^{0, q}(D)$ denote the space of smooth sections of $T^{* 0, q} X$ over $D$ and the subspace of $\Omega^{0, q}(D)$ whose elements have compact support in $D$, respectively. Let

\bar{\partial}_{b}: \Omega^{0, q}(X) \rightarrow \Omega^{0, q+1}(X)
$$

be the tangential Cauchy-Riemann operator. We say that $u \in \mathscr{C}^{\infty}(X)$ is a CR function if $\bar{\partial}_{b} u=0$. Moreover, if $L$ is a complex line bundle over $X, L$ is called a CR line bundle if its transition functions are CR.

Now, we let $\left(L, h^{L}\right)$ be a CR complex line bundle over $X$, where $h^{L}$ is the Hermitian fiber metric on $L$ and its local weight is $\phi$. Namely, let $s$ be a local CR trivializing section of $L$ on $D$, then locally,

For $k>0$, let $L^{k}$ be the $k$-th tensor power of the line bundle $L$ over X , then $h^{L}$ induces a Hermitian fiber metric $h^{L^{k}}$ on $L^{k}$ and $s^{k}$ is a local CR trivializing section of $L^{k}$. For $D \subset X$, let $\Omega^{0, q}\left(D, L^{k}\right)$ denote the space of smooth sections of $T^{* 0, q} X \otimes L^{k}$ over $D$ and $\Omega_{c}^{0, q}\left(D, L^{k}\right)$ be the subspace of $\Omega^{0, q}\left(D, L^{k}\right)$ whose elements have compact support in $D$. For $u \in \Omega^{0, q}\left(D, L^{k}\right)$, we sometimes write $|u(x)|_{h^{L^{k}}}^{2}$ simply as $|u|^{2}$.

Let

be the tangential Cauchy-Riemann operator acting on forms with values in $L^{k}$ such that

where $s$ is a local CR trivializing section of $L$ on an open set $D$ and $u \in \Omega^{0, q}(D)$. Then the $q$-th $\bar{\partial}_{b, k}$-cohomology is given by

We sometimes simply write $\bar{\partial}_{b}$ to denote $\bar{\partial}_{b, k}$.
Let $d v_{X}(x)$ be the volume form on $X$ induced by the fixed Hermitian metric on $\mathbb{C} T X$, then we get natural global $L^{2}$ inner products $(\cdot \mid \cdot)$ and $(\cdot \mid \cdot)_{h^{k}}$ on $\Omega^{0, q}(X)$ and $\Omega^{0, q}\left(X, L^{k}\right)$ respectively. Define by $L_{(0, q)}^{2}(X)$ the completion of $\Omega_{c}^{0, q}(X)$ with respect to $(\cdot \mid \cdot)$ and $L_{(0, q)}^{2}\left(X, L^{k}\right)$ the one of $\Omega_{c}^{0, q}\left(X, L^{k}\right)$ with respect to $(\cdot \mid \cdot)_{h^{L^{k}}}$. The associated norms on $L_{(0, q)}^{2}(X)$ and $L_{(0, q)}^{2}\left(X, L^{k}\right)$ are denoted by $\|\cdot\|$ and $\|\cdot\|_{h^{L^{k}}}$, respectively.

We extend $\bar{\partial}_{b, k}$ to $L_{(0, q)}^{2}\left(X, L^{k}\right)$ :

& \square_{b, k}^{q}=\bar{\partial}_{b, k}^{*} \bar{\partial}_{b, k}+\bar{\partial}_{b, k} \bar{\partial}_{b, k}^{*} \text { on } \operatorname{Dom} \square_{b, k}^{q} .

Let $s \in \mathbb{N}_{0}$, denote by $\|\cdot\|_{s}$ the standard Sobolev norm for sections of $L^{k}$ with respect to $(\cdot \mid \cdot)_{h^{L^{k}}}$ of order $s$. The following subelliptic estimates follow from Kohn's $L^{2}$ estimates[K65, Theorem 8.4.2]:
Theorem 2.3. Let $s \in \mathbb{N}_{0}$. There exists a constant $C_{s, k}>0$ such that

Theorem 2.4. Assume that $Y(q)$ holds on $X$. Let $s \in \mathbb{N}_{0}$. There exists a constant $C_{s, k}>0$ such that

\|u\|_{s+1} \leq C_{s, k}\left(\left\|\square_{b, k}^{q} u\right\|_{s}+\|u\|\right), \quad \text { for every } u \in \Omega^{0, q}\left(X, L^{k}\right) \tag{2.7}

From (2.7), we see that if $Y(q)$ holds, then $\square_{b, k}^{q}$ is hypoelliptic, has compact resolvent and the strong Hodge decomposition holds. We refer the reader to [K65, Theorem 7.6], [FK72, Theorem 5.4.11-12], [CS99, Corollary 8.4.7-8] for relevant material. Write

if $Y(q)$ holds.
Since $\square_{b, k}^{q}$ is non-negative and self-adjoint, the heat operator $e^{-t \square_{b, k}^{q}}: L_{(0, q)}^{2}\left(X, L^{k}\right) \rightarrow$ $\operatorname{Dom} \square_{b, k}^{q}, t>0$, exists. Let

A_{k}(t, x, y)=e^{-t \square_{b, k}^{q}}(x, y) \in \mathscr{D}^{\prime}\left(\mathbb{R}_{+} \times X \times X,\left(T^{* 0, q} X \otimes L^{k}\right) \boxtimes\left(T^{* 0, q} X \otimes L^{k}\right)^{*}\right)
$$

be the distribution kernel of $e^{-t \square_{b, k}^{q}}$ with respect to $d v_{X}(x)$. We also write $A_{k}(t)$ to denote $e^{-t \square_{b, k}^{q}}$. If $Y(q)$ holds, then

A_{k}(t, x, y) \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times X \times X,\left(T^{* 0, q} X \otimes L^{k}\right) \boxtimes\left(T^{* 0, q} X \otimes L^{k}\right)^{*}\right)

One of the main goal of this work is to study the asymptotic behavior of $A_{k}\left(\frac{t}{k}, x, x\right)$ as $k \rightarrow+\infty$ when $Y(q)$ holds. Note that $A_{k}\left(\frac{t}{k}\right)$ satisfies the following

Now, assume that $Y(q)$ holds. We use the canonical identification $\operatorname{End}\left(L^{k}\right)=\mathbb{C}$, especially

There exists $A_{k, s}(t, x, y) \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times D \times D, T^{* 0, q} X \boxtimes\left(T^{* 0, q} X\right)^{*}\right)$ such that
for every $u=s^{k} \otimes \hat{u} \in \Omega_{c}^{0, q}\left(D, L^{k}\right), \hat{u} \in \Omega_{c}^{0, q}(D)$. Note that

2.3. CR manifolds with $\mathbb{R}$-action. Now assume that $X$ admits a $\mathbb{R}$-action $\eta, \eta \in \mathbb{R}$ : $\eta: X \rightarrow X, x \mapsto \eta \circ x$. Let $T \in \mathscr{C}^{\infty}(X, T X)$ be the infinitesimal generator of the $\mathbb{R}$-action which is given by

Assume that $\left(X, T^{1,0} X\right)$ is a CR manifold of dimension $2 n+1, n \geq 1$, with a transversal CR $\mathbb{R}$-action $\eta$ and we let $T$ be the infinitesimal generator of the $\mathbb{R}$-action. Let $\omega_{0} \in$ $\mathscr{C}^{\infty}\left(X, T^{*} X\right)$ be the global real one form determined by

where $\eta^{*}: T_{\eta \circ}^{* 0, q} X \rightarrow T_{x}^{* 0, q} X$ is the pull-back map of $\eta$. Since the $\mathbb{R}$-action is CR, as in the $S^{1}$-action case (see Section 2.4 in [HLM16]), we have

Let $\left(L, h^{L}\right)$ be a rigid CR line bundle over $X$ with a $\mathbb{R}$-invariant Hermitian metric $h^{L}$ on $L$. We refer the reader to Section 2.3 in [HHL20] for the definitions and terminology about rigid CR vector bundles. We recall the following (see Definition 2.9 in [HHL20])

Definition 2.6. A CR vector bundle $E$ of rank $r$ over $X$ with a CR bundle lift $T^{E}$ of $T$ is called rigid CR (with respect to $T^{E}$ ) if for every point $p \in X$ there exists an open neighborhood $U$ around $p$ and a CR frame $\left\{f_{1}, \ldots, f_{r}\right\}$ of $\left.E\right|_{U}$ with $T^{E}\left(f_{j}\right)=0$ for $1 \leq j \leq r$.

A section $s \in \mathscr{C}^{\infty}(X, E)$ is called a rigid CR section if $T^{E} s=0$ and $\bar{\partial}_{b} s=0$. The frame $\left\{f_{j}\right\}_{j=1}^{r}$ in Definition 2.6 is called a rigid CR frame of $\left.E\right|_{U}$. Note that any rigid CR vector bundle is locally CR trivializable.

For every $k \in \mathbb{N}$, we use $T$ to denote the CR lifting $T^{L^{k}}$. For $u \in \Omega^{0, q}\left(X, L^{k}\right)$, we can define $T u$ in the standard way (see Section 2.3 in [HHL20] ) and we have $T u \in \Omega^{0, q}\left(X, L^{k}\right)$.

Consider the operator

It is known that [HMW, Lemma 4.3] $-i T$ is self-adjoint.
Fix $\delta>0$, let

& \square_{b, k, \leq k \delta}^{q}: \operatorname{Dom} \square_{b, k, \leq k \delta}^{q} \subset L_{(0, q), \leq k \delta}^{2}\left(X, L^{k}\right) \rightarrow L_{(0, q), \leq k \delta}^{2}\left(X, L^{k}\right), \\
& \operatorname{Dom} \square_{b, k, \leq k \delta}^{q}=\operatorname{Dom} \square_{b, k}^{q} \bigcap L_{(0, q), \leq k \delta}^{2}\left(X, L^{k}\right),  \tag{2.23}\\
& \square_{b, k, \leq k \delta}^{q}=\bar{\partial}_{b, k}^{*} \bar{\partial}_{b, k}+\bar{\partial}_{b, k} \bar{\partial}_{b, k}^{*} \text { on } \operatorname{Dom} \square_{b, k, \leq k \delta}^{q} .
\end{align*}

It is not difficult to check that without $Y(q)$ condition,

e^{-t \square_{b, k, \leq k \delta}^{q}}:=e^{-t \square_{b, k}^{q}} \circ Q_{X, \leq k \delta}: L_{(0, q)}^{2}\left(X, L^{k}\right) \rightarrow \operatorname{Dom} \square_{b, k, \leq k \delta}^{q}, \quad t>0, \tag{2.25}
\end{equation*}
$$

and let

A_{k, \delta}(t, x, y)=e^{-t \square_{b, k, \leq k \delta}^{q}}(x, y) \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times X \times X,\left(T^{* 0, q} X \otimes L^{k}\right) \boxtimes\left(T^{* 0, q} X \otimes L^{k}\right)^{*}\right)

be the distribution kernel of $e^{-t \square_{b, k, \leq k \delta}^{q}}$ with respect to $d v_{X}(x)$. We also write $A_{k, \delta}(t)$ to denote $e^{-t \square \frac{q}{b, k, \leq k \delta}}$. One of the main goal of this work is to study the asymptotic behavior of $A_{k, \delta}\left(\frac{t}{k}, x, x\right)$ as $k \rightarrow+\infty$. Note that $A_{k, \delta}\left(\frac{t}{k}\right)$ satisfies the following

There exists $A_{k, s, \delta}(t, x, y) \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times D \times D, T^{* 0, q} X \boxtimes\left(T^{* 0, q} X\right)^{*}\right)$ such that
for every $u=s^{k} \otimes \hat{u} \in \Omega_{c}^{0, q}\left(D, L^{k}\right), \hat{u} \in \Omega_{c}^{0, q}(D)$. Note that

A_{k, \delta}(t, x, y)=s^{k}(x) \otimes A_{k, s, \delta}(t, x, y) e^{\frac{k \phi(x)-k \phi(y)}{2}} \otimes\left(s^{k}(y)\right)^{*} \text { on } D \text {. } \tag{2.29}

## 3. The estimate of the heat kernel distribution

We shall first set up the local coordinates. For a given point $p \in X$, let $U_{1}, \cdots, U_{n}$ be a smooth orthonormal frame for $(1,0)$ vector fields in a neighborhood of $p$, for which $\mathcal{L}_{p}\left(U_{j}, \bar{U}_{l}\right)=\delta_{j, l} \lambda_{j}(p), 1 \leq j, l \leq n$. Let $\omega^{1}, \cdots, \omega^{n}$ be an orthonormal basis for $(1,0)$ forms which is dual to the basis $U_{1}, \cdots, U_{n}$. Let $s$ be a local CR trivializing section of $L$ on an open neighborhood $D$ of $p$ with local weight $\phi$, i.e. $|s(x)|_{h^{L}}^{2}=e^{-\phi(x)}$ on $D$.

We take local coordinates $x=\left(x_{1}, \ldots, x_{2 n+1}\right)=(z, \theta)=\left(z_{1}, \cdots, z_{n}, \theta\right)$ on an open set $D$ of $p$, such that

&(z(p), \theta(p))=0, \quad \omega_{0}(p)=d \theta, \quad z_{j}=x_{2 j-1}+i x_{2 j}, \quad \frac{\partial}{\partial z_{j}}=\frac{1}{2}\left(\frac{\partial}{\partial x_{2 j-1}}-i \frac{\partial}{\partial x_{2 j}}\right),  \tag{3.1}\\
&\left\langle\left.\frac{\partial}{\partial x_{j}} \right\rvert\, \frac{\partial}{\partial x_{l}}\right\rangle=2 \delta_{j, l}+O(|x|), \quad\left\langle\left.\frac{\partial}{\partial x_{j}} \right\rvert\, \frac{\partial}{\partial \theta}\right\rangle=O(|x|), \\
&\left|\frac{\partial}{\partial \theta}\right|^{2}=1+O(|x|), \quad\left|\frac{\partial}{\partial z_{j}}\right|^{2}=1+O(|x|), \tag{3.2}
\end{align*}
$$

for $j, l=1, \cdots, 2 n$. Moreover,

U_{j}=\frac{\partial}{\partial z_{j}}-i \lambda_{j} \bar{z}_{j} \frac{\partial}{\partial \theta}-c_{j} \theta \frac{\partial}{\partial \theta}+\sum_{s=1}^{2 n+1} r_{j, s}(z, \theta) \frac{\partial}{\partial x_{s}}, \tag{3.3}
\end{equation*}
$$

where $r_{j, s}(z, \theta) \in \mathscr{C}^{\infty}(D), r_{j, s}(z, \theta)=O\left(|(z, \theta)|^{2}\right), j=1, \ldots, n, s=1, \ldots, 2 n+1$, and

\phi(z, \theta)= & \beta \theta+\sum_{j=1}^{n}\left(a_{j} z_{j}+\bar{a}_{j} \bar{z}_{j}\right)+\sum_{j, l=1}^{n}\left(a_{j, l} z_{j} z_{l}+\bar{a}_{j, l} \bar{z}_{j} \bar{z}_{l}\right)+\sum_{j, l=1}^{n} \mu_{j, l} z_{j} \bar{z}_{l}  \tag{3.4}\\
& +O\left(|\theta|^{2}+|z||\theta|+|(z, \theta)|^{3}\right)
\end{align*}

where $\beta \in \mathbb{R}, c_{j}, a_{j}, a_{j, l}, \mu_{j, l} \in \mathbb{C}$, and $\lambda_{j}$ are the eigenvalues of $\mathcal{L}_{p}, j, l=1, \ldots, n$. We then work with this local coordinates and we identify $D$ with some open set in $\mathbb{R}^{2 n+1}$.

### 3.1. The unitary identification.

For $u, v \in \Omega_{c}^{0, q}(D)$, let

$(\cdot \mid \cdot)_{k \phi}$ is called the inner product on $\Omega_{c}^{0, q}(D)$ with weight $k \phi$. Denote by $L_{(0, q)}^{2}(D, k \phi)$ the completion of $\Omega_{c}^{0, q}(D)$ with respect to $(\cdot \mid \cdot)_{k \phi}$. Let $\bar{\partial}_{b}^{*, k \phi}$ be the formal adjoint of $\bar{\partial}_{b}$ with respect to $(\cdot \mid \cdot)_{k \phi}$. From $\bar{\partial}_{b}=\sum_{j=1}^{n}\left(\bar{\omega}^{j} \wedge \bar{U}_{j}+\left(\bar{\partial}_{b} \bar{\omega}^{j}\right) \wedge\left(\bar{\omega}^{j} \wedge\right)^{*}\right)$, we can check that

where $\beta_{j}(z, \theta)$ is a smooth function on $D$, independent of $k$, for every $j=1, \ldots, n$. Set

For $u \in \Omega^{0, q}\left(D, L^{k}\right)$, there exists a $\check{u} \in \Omega^{0, q}(D)$ such that $u=s^{k} \check{u}$ on $D$. Recall that $\bar{\partial}_{b, k}\left(s^{k} \check{u}\right)=s^{k} \bar{\partial}_{b} \check{u}$ and we have

\bar{\partial}_{\rho}^{*, k \phi_{0}}=\sum_{j=1}^{n}\left(\left(\bar{\omega}^{j} \wedge\right)^{*}\left(-U_{j}+k U_{j} \phi_{0}+k U_{j} \bar{\rho}+\alpha_{j}(z, \theta)\right)+\bar{\omega}^{j} \wedge\left(\bar{\partial}_{b} \bar{\omega}^{j} \wedge\right)^{*}\right) \tag{3.12}
\end{equation*}

where $\alpha_{j}(z, \theta)$ is a smooth function on $D$, independent of $k$, for every $j=1, \ldots, n$. For abbreviation, we write $\bar{U}_{\rho, j}=\bar{U}_{j}+k \bar{U}_{j} \rho$ and $\bar{U}_{\rho, j}^{* k \phi_{0}}=-U_{j}+k U_{j} \phi_{0}+k U_{j} \bar{\rho}+\alpha_{j}(z, \theta)$, $j=1, \ldots, n$. Put

Thorough a straightforward computation, we have

& +\sum_{j=1}^{n}\left(\epsilon_{j}(z, \theta) \bar{U}_{\rho, j}+s_{j}(z, \theta) \bar{U}_{\rho, j}^{*, k \phi_{0}}\right)+\gamma(z, \theta) \tag{3.13}
\end{align*}
$$

where $\epsilon_{j}, s_{j}$ and $\gamma$ are smooth functions on $D$ and independent of $k, j=1, \ldots, n$. We can check that

\square_{b, k \phi}^{q} u=e^{k \rho} \square_{\rho, k \phi_{0}}^{q}\left(e^{-k \rho} u\right), \quad u \in \Omega^{0, q}(D) \tag{3.14}

Until further notice, we assume that $Y(q)$ holds on $X$. Let

### 3.2. The scaling technique.

Kohn $[\mathrm{K} 65]$ proved that if $Y(q)$ holds, then $\square_{\rho,(k)}^{q}$ is hypoelliptic with loss of one derivative. The following proposition is a direct consequence of Theorem 2.3 and Kohn's poof.

Proposition 3.2. Recall that we work with the assumption that $Y(q)$ holds on $X$. Let $s \in \mathbb{N}_{0}$. For $r>0$ with $B_{2 r} \subset B_{\log k}$, there exists a constant $C_{r, s}>0$ which is independent of $k$ such that for all $u \in F_{k}^{*} \Omega^{0, q}\left(B_{\log k}\right)$, we have

Go over Kohn's proof, we see that the constant $C_{r, s}$ only depends on the derivatives of all the coefficients of $\square_{\rho,(k)}^{q}, k F_{k}^{*} \phi_{0}$ and $m\left(F_{k} x\right)$ on $B_{\log k}$. From (3.33), it is clear that all the derivatives of the coefficients of $\square_{\rho,(k)}^{q}, k F_{k}^{*} \phi_{0}$ and $m\left(F_{k} x\right)$ are uniformly bounded in $k$ in $\mathscr{C}^{\infty}$ topology on $B_{\log k}$. Hence $C_{r, s}$ can be taken to be indenpendent of $k$.

Our next objective is to show that if $Y(q)$ holds, $A_{(k)}(t, x, y)$ is uniformly bounded in $k$ in $\mathscr{C}^{\infty}$-topology for some fixed $t>0$. For this purpose, we need to apply the spectral theorem[Da95] for self-adjoint operator. We reproduce it as follows for the reader's convenience.
Theorem 3.3 (spectral theorem for self-adjoint operator). Let $A: \operatorname{Dom} A \subset \mathbb{H} \rightarrow \mathbb{H}$ be $a$ self-adjoint operator on a Hilbert space $\mathbb{H}$. Using the same setting as in (3.1) and (3.2) to denote by $x=(z, \theta)$ the coordinates of $H_{n}, z=\left(z_{1}, \cdots, z_{n}\right) \in \mathbb{C}^{n}, \theta \in \mathbb{R}, x=$ $\left(x_{1}, \ldots, x_{2 n+1}\right), z_{j}=x_{2 j-1}+i x_{2 j}, j=1, \ldots, n, \theta=x_{2 n+1}$. We now prove that $P(t)=e^{-t \square_{H_{n}, \Phi}^{q}}$. Let $u, v \in \Omega_{c}^{0, q}\left(H_{n}\right)$. From (3.61), we have

& \left(u \mid e^{\left.-t \square_{H_{n}, \Phi}^{q} v\right)_{\Phi}-(P(t) u \mid v)_{\Phi}}\right. \\
& =\int_{0}^{t} \frac{\partial}{\partial s}\left(\left(P(t-s) u \mid e^{-s \square_{H_{n}, \Phi}^{q} v}\right)_{\Phi}\right) d s  \tag{3.71}\\
& =\int_{0}^{t}\left(-P^{\prime}(t-s) u \mid e^{-s \square_{H_{n}, \Phi}^{q} v}\right)_{\Phi} d s+\int_{0}^{t}\left(P(t-s) u \mid-\square_{H_{n}, \Phi}^{q}\left(e^{\left.-s \square_{H_{n}, \Phi}^{q} v\right)}\right)_{\Phi} d s .\right.
\end{align*}
$$

Form (3.63), we see that $P(t-s) u \in \operatorname{Dom} \square_{H_{n}, \Phi}^{q}$ and hence

\left(P(t-s) u \mid-\square_{H_{n}, \Phi}^{q}\left(e^{-s \square_{H_{n}, \Phi}^{q} v}\right)\right)_{\Phi}=\left(-\square_{H_{n}, \Phi}^{q} P(t-s) u \mid e^{-s \square_{H_{n}, \Phi}^{q} v}\right)_{\Phi} . \tag{3.72}
\end{equation*}
$$

From (3.62), (3.71) and (3.72), we deduce that

\left(u \mid e^{-t \square_{H_{n}, \Phi}^{q} v}\right)_{\Phi}-(P(t) u \mid v)_{\Phi}=0 .
$$

Since $\left(u \mid e^{-t \square \square_{H_{n}, \Phi}^{q} v}\right)_{\Phi}=\left(e^{-t \square_{H_{n}, \Phi}^{q} u} \mid v\right)_{\Phi}$, we conclude that $P(t)=e^{-t \square_{H_{n}, \Phi}^{q}}$.
We have proved that there is a subsequence $\left\{k_{1}<k_{2}<\cdots\right\}, \lim _{j+\infty} k_{j}=+\infty$, such that $\lim _{j \rightarrow+\infty} A_{\left(k_{j}\right)}(t, x, y)=e^{-t \square_{H_{n}, \Phi}^{q}}(x, y)$ locally uniformly on $\mathbb{R}_{+} \times H_{n} \times H_{n}$ in $\mathscr{C}^{\infty}$ topology. Moreover, for any subsequence $\left\{\hat{k}_{1}<\hat{k}_{2}<\cdots\right\}, \lim _{j+\infty} \hat{k}_{j}=+\infty$, we can repeat the procedure above and deduce that there is a subsequence $\left\{\hat{k}_{j_{1}}<\hat{k}_{j_{2}}<\cdots\right\}$, $\lim _{s+\infty} \hat{k}_{j_{s}}=+\infty$, such that $\lim _{s \rightarrow+\infty} A_{\left(\hat{k}_{\left.j_{s}\right)}\right.}(t, x, y)=e^{-t \square_{H_{n}, \Phi}^{q}(x, y) \text { locally uniformly on }}$ $\mathbb{R}_{+} \times H_{n} \times H_{n}$ in $\mathscr{C}^{\infty}$ topology. Hence, $\lim _{k \rightarrow+\infty} A_{(k)}(t, x, y)=e^{-t \square_{H_{n}, \Phi}^{q}}(x, y)$ locally uniformly on $\mathbb{R}_{+} \times H_{n} \times H_{n}$ in $\mathscr{C}^{\infty}$ topology.

## 4. Asymptotics of the heat kernels

Our main objective of this section is to compute $e^{-t \square_{H_{n}, \Phi}^{q}}(x, y)$ and apply it to prove Theorem 1.1.

### 4.1. The heat kernel on the Heisenberg group $H_{n}$.

Until further notice, we do not assume that $Y(q)$ holds. Consider $\mathbb{C}^{n}$. Let $\langle\cdot \mid \cdot\rangle_{\mathbb{C}^{n}}$ be the Hermitian inner product on $T^{* 0, q} \mathbb{C}^{n}$ so that

$$
\left\{d \bar{z}^{J} \mid J=\left(j_{1}, \ldots, j_{q}\right), 1 \leq j_{1}<\cdots<j_{q} \leq n\right\}
$$

is an orthonormal basis for $T^{* 0, q} \mathbb{C}^{n}$, where $T^{* 0, q} \mathbb{C}^{n}$ denotes the bundle of $(0, q)$ forms of $\mathbb{C}^{n}$. Let $\Omega^{0, q}\left(\mathbb{C}^{n}\right)$ denote the space of smooth $(0, q)$ forms of $\mathbb{C}^{n}$ and put $\Omega_{c}^{0, q}\left(\mathbb{C}^{n}\right):=$ $\Omega^{0, q}\left(\mathbb{C}^{n}\right) \bigcap \mathscr{E}^{\prime}\left(\mathbb{C}^{n}, T^{* 0, q} \mathbb{C}^{n}\right)$. Let $(\cdot \mid \cdot)_{\mathbb{C}^{n}}$ be the $L^{2}$ inner product on $\Omega_{c}^{0, q}\left(\mathbb{C}^{n}\right)$ induced by $\langle\cdot \mid \cdot\rangle_{\mathbb{C}^{n}}$ and let $L_{(0, q)}^{2}\left(\mathbb{C}^{n}\right)$ be the completion of $\Omega_{c}^{0, q}\left(\mathbb{C}^{n}\right)$ with respect to $(\cdot \mid \cdot)_{\mathbb{C}^{n}}$.

For $\eta \in \mathbb{R}, j, l=1, \ldots, n$, put

$$
\begin{equation*}
\Phi_{\eta}=-2 \sum_{j=1}^{n} \eta \lambda_{j}\left|z_{j}\right|^{2}+\sum_{j, l}^{n} \mu_{j, l} \bar{z}_{j} z_{l}, \tag{4.1}
\end{equation*}
$$

where $\lambda_{j}$ and $\mu_{j, l}$ are as in (3.3) and (3.9). In particular, $\Phi_{0}=\sum_{j, l=1}^{n} \mu_{j, l} \bar{z}_{j} z_{l}$. Let

$$
\bar{\partial}_{\eta}=\sum_{j=1}^{n} d \bar{z}_{j} \wedge\left(\frac{\partial}{\partial \bar{z}_{j}}+\frac{1}{2} \frac{\partial \Phi_{\eta}}{\partial \bar{z}_{j}}\right): \Omega^{0, q}\left(\mathbb{C}^{n}\right) \rightarrow \Omega^{0, q}\left(\mathbb{C}^{n}\right)
$$

Let

$$
\bar{\partial}_{\eta}^{*}: \Omega^{0, q+1}\left(\mathbb{C}^{n}\right) \rightarrow \Omega^{0, q}\left(\mathbb{C}^{n}\right)
$$

be the formal adjoint of $\bar{\partial}_{\eta}$ with respect to $(\cdot \mid \cdot)_{\mathbb{C}^{n}}$. It is easy to check that

\bar{\partial}_{\eta}^{*}=\sum_{j=1}^{n}\left(d \bar{z}_{j} \wedge\right)^{*}\left(-\frac{\partial}{\partial z_{j}}+\frac{1}{2} \frac{\partial \Phi_{\eta}}{\partial z_{j}}\right)
$$

where $\left(d \bar{z}_{j} \wedge\right)^{*}$ is the adjoint of $d \bar{z}_{j} \wedge$ with respect to $\langle\cdot \mid \cdot\rangle_{\mathbb{C}^{n}}, j=1, \ldots, n$. Let

$$
\square_{\eta}:=\bar{\partial}_{\eta} \bar{\partial}_{\eta}^{*}+\bar{\partial}_{\eta}^{*} \bar{\partial}_{\eta}: \operatorname{Dom} \square_{\eta} \subset L_{(0, q)}^{2}\left(\mathbb{C}^{n}\right) \rightarrow L_{(0, q)}^{2}\left(\mathbb{C}^{n}\right),
$$

where $\operatorname{Dom} \square_{\eta}=\left\{u \in L_{(0, q)}^{2}\left(\mathbb{C}^{n}\right) \mid \square_{\eta} u \in L_{(0, q)}^{2}\left(\mathbb{C}^{n}\right)\right\}$. It is not difficult to see that $\square_{\eta}$ is a non-negative self-adjoint operator. On $\Omega^{0, q}\left(\mathbb{C}^{n}\right)$, we can check that

\square_{\eta}=\sum_{j=1}^{n}\left(-\frac{\partial}{\partial z_{j}}+\frac{1}{2} \frac{\partial \Phi_{\eta}}{\partial z_{j}}\right)\left(\frac{\partial}{\partial \bar{z}_{j}}+\frac{1}{2} \frac{\partial \Phi_{\eta}}{\partial \bar{z}_{j}}\right)+\sum_{j, l=1}^{n} d \bar{z}_{j} \wedge\left(d \bar{z}_{l} \wedge\right)^{*} \frac{\partial^{2} \Phi_{\eta}}{\partial \bar{z}_{j} \partial z_{l}} . \tag{4.2}
\end{equation*}
$$

Let $\mathcal{S}^{0, q}\left(H_{n}\right)$ be the space of Schwartz test $(0, q)$ forms. Let

$$
\begin{align*}
G: \Omega_{c}^{0, q}\left(H_{n}\right) & \rightarrow \mathcal{S}^{0, q}\left(H_{n}\right), \\
u(z, \theta) & \rightarrow \int_{\mathbb{R}} u(z, \theta) e^{-\frac{\beta\left(\theta-i \lambda|z|^{2}\right)}{2}-i \theta \eta-\frac{\Phi_{0}(z)}{2}} d \theta, \tag{4.3}
\end{align*}
$$

where $\lambda|z|^{2}:=\sum_{j=1}^{n} \lambda_{j}\left|z_{j}\right|^{2}$ and we also use $\eta$ to denote $\theta$. The following follows from some straightforward calculation, we omit the details.
Lemma 4.1. Let $u \in \Omega_{c}^{0, q}\left(H_{n}\right)$. We have

We will construct the heat kernel for $\square_{H_{n}, \Phi}^{q}$ by using Lemma 4.1 and some tricks. We recall now Mehler's formula. Consider $\mathbb{C}^{n}$. We will use the same notations as before. Let

be an invertible self-adjoint complex endomorphism, where $T^{1,0} \mathbb{C}^{n}$ is the holomorphic tangent bundle of $\mathbb{C}^{n}$. We extend $A$ to $\mathbb{C} T \mathbb{C}^{n}$ by defining $A \bar{v}:=-\overline{A v}$, for any $v \in T^{1,0} \mathbb{C}^{n}$, then $i A$ induces an anti-symmetric endomorphism on $T \mathbb{C}^{n}$. We will denote by det the determinant on $T^{1,0} \mathbb{C}^{n}$ with respect to $\langle\cdot \mid \cdot\rangle_{\mathbb{C}^{n}}$. Write $z_{j}=x_{2 j-1}+i x_{2 j}, j=1, \ldots, n$. Let $e_{j}:=\frac{1}{\sqrt{2}} \frac{\partial}{\partial x_{j}}, j=1, \ldots, 2 n$. Then, $\left\{e_{j}\right\}_{j=1}^{2 n}$ is an orthonormal basis of $T \mathbb{C}^{n}$. For every $x \in \mathbb{C}^{n}$, we will identify $x$ with the vector field $\sum_{j=1}^{2 n} x_{j} \frac{\partial}{\partial x_{j}}$. Let

$$
\mathcal{H}=\mathcal{H}(x):=-\sum_{j}^{2 n}\left(e_{j}+\frac{1}{2}\left\langle A x \mid e_{j}\right\rangle_{\mathbb{C}^{n}}\right)^{2}-\operatorname{Tr}_{T^{1,0} \mathbb{C}^{n}}[A] .
$$

Then, $\mathcal{H}(x)$ is a second order P.D.E.. Put

\mathcal{H}: \operatorname{Dom} \mathcal{H} \subset L_{(0, q)}^{2}\left(\mathbb{C}^{n}\right) \rightarrow L_{(0, q)}^{2}\left(\mathbb{C}^{n}\right)
$$

where $\operatorname{Dom} \mathcal{H}=\left\{u \in L_{(0, q)}^{2}\left(\mathbb{C}^{n}\right) \mid \mathcal{H} u \in L_{(0, q)}^{2}\left(\mathbb{C}^{n}\right)\right\}$. It is straightforward to check that $\mathcal{H}$ is self-adjoint. Let $e^{-t \mathcal{H}}$ be the heat operator of $\mathcal{H}$ and let

$$
e^{-t \mathcal{H}}(x, y) \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times \mathbb{C}^{n} \times \mathbb{C}^{n}, T^{* 0, q} \mathbb{C}^{n} \boxtimes\left(T^{* 0, q} \mathbb{C}^{n}\right)^{*}\right)
$$

be the distribution kernel of $e^{-t \mathcal{H}}$ with respect to $(\cdot \mid \cdot)_{\mathbb{C}^{n}}$. Note that

$$
\left(e^{-t \mathcal{H}} u\right)(x)=\int_{\mathbb{C}^{n}} e^{-t \mathcal{H}}(x, y) u(y) d v(y), \quad u \in L_{(0, q)}^{2}\left(\mathbb{C}^{n}\right)
$$

where $d v(y)=2^{n} d y_{1} \cdots d y_{2 n}$. We have the following Mehler's formula (see [MM07, Appendix E.2]):

Theorem 4.2. With the notations used above, we have

e^{-t \mathcal{H}}(x, y)= & \frac{1}{(2 \pi)^{n}} \frac{\operatorname{det} A}{\operatorname{det}\left(1-e^{-2 t A}\right)} \exp \left\{-\frac{1}{2}\left\langle\left.\frac{A / 2}{\tanh (t A)} x \right\rvert\, x\right\rangle_{\mathbb{C}^{n}}\right. \\
& \left.-\frac{1}{2}\left\langle\left.\frac{A / 2}{\tanh (t A)} y \right\rvert\, y\right\rangle_{\mathbb{C}^{n}}+\left\langle\left.\frac{A / 2}{\sinh (t A)} e^{t A} x \right\rvert\, y\right\rangle_{\mathbb{C}^{n}}\right\} \tag{4.4}
\end{align*}
$$

Let $e^{-t \square_{\eta}}$ be the heat operator of $\square_{\eta}$ and let $e^{-t \square_{\eta}}(x, y) \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times \mathbb{C}^{n} \times \mathbb{C}^{n}, T^{* 0, q} \mathbb{C}^{n} \boxtimes\right.$ $\left.\left(T^{* 0, q} \mathbb{C}^{n}\right)^{*}\right)$ be the distribution kernel of $e^{-t \square_{\eta}}$. Let $\dot{R}^{\eta}: T^{1,0} \mathbb{C}^{n} \rightarrow T^{1,0} \mathbb{C}^{n}$ be the linear map defined by

$$
\begin{equation*}
\left\langle\dot{R}^{\eta} U \mid \bar{V}\right\rangle_{\mathbb{C}^{n}}=\partial \bar{\partial} \Phi_{\eta}(U, \bar{V}), \quad U, V \in T^{1,0} \mathbb{C}^{n} \tag{4.5}
\end{equation*}
$$

and let

$$
\begin{equation*}
\omega_{\mathbb{C}^{n}}^{\eta}:=\sum_{j, l=1}^{n} \frac{\partial^{2} \Phi_{\eta}}{\partial \bar{z}_{j} \partial z_{l}} d \bar{z}_{j} \wedge\left(d \bar{z}_{l} \wedge\right)^{*} \tag{4.6}
\end{equation*}
$$

where $\Phi_{\eta}$ is as in (4.1). From(4.2), we can rewrite $\square_{\eta}$ as

\square_{\eta}=\frac{1}{2}\left[-\sum_{j=1}^{2 n}\left(e_{j}+\frac{1}{2}\left\langle\dot{R}^{\eta} x \mid e_{j}\right\rangle_{\mathbb{C}^{n}}\right)^{2}-\operatorname{Tr} \dot{R}^{\eta}\right]+\omega_{\mathbb{C}^{n}}^{\eta} \tag{4.7}
\end{equation*}
$$

From (4.4) and (4.7), we deduce that

\begin{align*}
e^{-t \square_{\eta}}(x, y)= & \frac{1}{(2 \pi)^{n}} \frac{\operatorname{det} \dot{R}^{\eta}}{\operatorname{det}\left(1-e^{-t \dot{R}^{\eta}}\right)} \exp \left\{-t \omega_{\mathbb{C}^{n}}^{\eta}-\frac{1}{2}\left\langle\left.\frac{\dot{R}^{\eta} / 2}{\tanh \left(t \dot{R}^{\eta} / 2\right)} x \right\rvert\, x\right\rangle_{\mathbb{C}^{n}}\right.  \tag{4.8}\\
& \left.-\frac{1}{2}\left\langle\left.\frac{\dot{R}^{\eta} / 2}{\tanh \left(t \dot{R}^{\eta} / 2\right)} y \right\rvert\, y\right\rangle_{\mathbb{C}^{n}}+\left\langle\left.\frac{\dot{R}^{\eta} / 2}{\sinh \left(t \dot{R}^{\eta} / 2\right)} e^{t \dot{R}^{\eta} / 2} x \right\rvert\, y\right\rangle_{\mathbb{C}^{n}}\right\}
\end{align*}
$$

We introduce some notations. As before, on $H_{n}$, let $T_{H_{n}}=-\frac{\partial}{\partial \theta}$ and consider

-i T_{H_{n}}: \operatorname{Dom}\left(-i T_{H_{n}}\right) \subset L_{(0, q)}^{2}\left(H_{n}, \Phi\right) \rightarrow L_{(0, q)}^{2}\left(H_{n}, \Phi\right)
$$

where $\operatorname{Dom}\left(-i T_{H_{n}}\right)=\left\{u \in L_{(0, q)}^{2}\left(H_{n}, \Phi\right) \mid-i T_{H_{n}} u \in L_{(0, q)}^{2}\left(H_{n}, \Phi\right)\right\}$. It is not difficult to see that $-i T_{H_{n}}$ is self-adjoint. For $\delta_{1}<\delta_{2}, \delta_{1}, \delta_{2} \in \mathbb{R}$, let

Q_{\left[\delta_{1}, \delta_{2}\right]}: L_{(0, q)}^{2}\left(H_{n}\right) \rightarrow E_{-i T_{H_{n}}}\left(\left[\delta_{1}, \delta_{2}\right]\right) \tag{4.9}
\end{equation*}
$$

be the orthogonal projection with respect to $(\cdot \mid \cdot)_{H_{n}}$, where $E_{-i T_{H_{n}}}\left(\left[\delta_{1}, \delta_{2}\right]\right)$ denotes the spectral measure of $-i T_{H_{n}}$. It was shown in [HMW, Lemma 4.7] that

\left(Q_{\left[\delta_{1}, \delta_{2}\right]} u\right)(x)=\frac{1}{(2 \pi)^{2 n+1}} \int e^{i<x-y, \eta>} 1_{\left[\delta_{1}, \delta_{2}\right]}\left(\eta_{2 n+1}\right) u(y) d y d \eta \in \Omega^{0, q}\left(H_{n}\right) \bigcap L_{(0, q)}^{2}\left(H_{n}, \Phi\right) \tag{4.10}
\end{equation*}

for every $u \in \Omega_{c}^{0, q}\left(H_{n}\right)$, where $1_{\left[\delta_{1}, \delta_{2}\right]}\left(\eta_{2 n+1}\right)=1$ if $\eta_{2 n+1} \in\left[\delta_{1}, \delta_{2}\right], 1_{\left[\delta_{1}, \delta_{2}\right]}\left(\eta_{2 n+1}\right)=0$ if $\eta_{2 n+1} \notin\left[\delta_{1}, \delta_{2}\right]$. For $\delta>0$, let

e^{-t \square_{H_{n}, \Phi}^{q, \delta}}:=e^{-t \square_{H_{n}, \Phi}^{q}} \circ Q_{[-\delta, \delta]}: L_{(0, q)}^{2}\left(H_{n}, \Phi\right) \rightarrow L_{(0, q)}^{2}\left(H_{n}, \Phi\right) \tag{4.11}
\end{equation*}
$$

and let $e^{-t \square_{H_{n}, \Phi}^{q, \delta}}(x, y) \in \mathscr{D}^{\prime}\left(\mathbb{R}_{+} \times H_{n} \times H_{n}, T^{* 0, q} H_{n} \boxtimes\left(T^{* 0, q} H_{n}\right)^{*}\right)$ be the distribution kernel of $e^{-t \square_{H_{n}, \Phi}^{q, \delta}}$. It is straightforward to check that

$$
\begin{gather*}
\left(\frac{\partial}{\partial t}+\square_{H_{n}, \Phi}^{q}\right) e^{-t \square_{H_{n}, \Phi}^{q, \delta}}=0 \text { on } L_{(0, q)}^{2}\left(H_{n}, \Phi\right),  \tag{4.12}\\
\lim _{t \rightarrow 0} e^{-t \square_{H_{n}, \Phi}^{q, \delta}}=Q_{[-\delta, \delta]} \text { on } L_{(0, q)}^{2}\left(H_{n}, \Phi\right),  \tag{4.13}\\
\lim _{\delta \rightarrow \infty} e^{-t \square_{H_{n}, \Phi}^{q, \delta}} u=e^{-t \square_{H_{n}, \Phi}^{q}} u, \text { for every } u \in L_{(0, q)}^{2}\left(H_{n}, \Phi\right),  \tag{4.14}\\
e^{-t \square_{H_{n}, \Phi}^{q, \delta} u \in E_{-i T_{H_{n}}}^{q}([-\delta, \delta]), \quad \text { for every } u \in L_{(0, q)}^{2}\left(H_{n}, \Phi\right) \text { and every } t>0} . \tag{4.15}
\end{gather*}
$$

We come back to our situation. For every $\delta>0$ and $t>0$, put

& P_{\delta}(t, x, y) \\
& :=\frac{1}{2 \pi} \int e^{i<x_{2 n+1}-y_{2 n+1}, \eta>+\frac{\beta}{2}\left(\left(x_{2 n+1}-y_{2 n+1}\right)+i \lambda\left(-|z|^{2}+|w|^{2}\right)\right)+\frac{-\Phi_{0}(w)+\Phi_{0}(z)}{2}}  \tag{4.16}\\
& \quad \times e^{-t \square_{\eta}}(z, w) 1_{[-\delta, \delta]}(\eta) d \eta \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times H_{n} \times H_{n}, T^{* 0, q} H_{n} \boxtimes\left(T^{* 0, q} H_{n}\right)^{*}\right),
\end{align*}
$$

where $z=\left(x_{1}, \ldots, x_{2 n}\right), w=\left(y_{1}, \ldots, y_{2 n}\right)$. Let

$$
P_{\delta}(t): \Omega_{c}^{0, q}\left(H_{n}\right) \rightarrow \Omega^{0, q}\left(H_{n}\right)
$$

be the continuous operator given by

\begin{equation*}
\left(P_{\delta}(t) u\right)(x)=\int P_{\delta}(t, x, y) u(y) d v_{H_{n}}(y), \quad u \in \Omega_{c}^{0, q}\left(H_{n}\right) \tag{4.17}
\end{equation*}
$$

From Parserval's formula, it is not difficult to see that

\begin{equation*}
P_{\delta}(t) u \in \Omega^{0, q}\left(H_{n}\right) \bigcap L_{(0, q)}^{2}\left(H_{n}, \Phi\right), \text { for every } u \in \Omega_{c}^{0, q}\left(H_{n}\right) \tag{4.18}
\end{equation*}
$$

From Lemma 4.1 and (4.10), we can check that

\begin{align*}
& P_{\delta}^{\prime}(t) u+\square_{H_{n}, \Phi}^{q} P_{\delta}(t) u=0, \quad \text { for every } u \in \Omega_{c}^{0, q}\left(H_{n}\right), \\
& \lim _{t \rightarrow 0} P_{\delta}(t) u=Q_{[-\delta, \delta]} u, \text { for every } u \in \Omega_{c}^{0, q}\left(H_{n}\right),  \tag{4.19}\\
& P_{\delta}(t) u \in E_{-i T_{H_{n}}}([-\delta, \delta]), \quad \text { for every } u \in \Omega_{c}^{0, q}\left(H_{n}\right) .
\end{align*}
$$

From (4.12), (4.13), (4.15) and (4.19), we can repeat the procedure in the final part of the proof of Theorem 3.9 and deduce that

From this observation and (4.14), we deduce

Theorem 4.3. We do not assume that $Y(q)$ holds. With the notations used above, for every $\delta>0$, we have

& =\frac{1}{2 \pi} \int e^{i<x_{2 n+1}-y_{2 n+1}, \eta>+\frac{\beta}{2}\left(\left(x_{2 n+1}-y_{2 n+1}\right)+i \lambda\left(-|z|^{2}+|w|^{2}\right)\right)+\frac{-\Phi_{0}(w)+\Phi_{0}(z)}{2}}  \tag{4.20}\\
& \quad \times e^{-t \square_{\eta}}(z, w) 1_{[-\delta, \delta]}(\eta) d \eta \in \mathscr{C}^{\infty}\left(\mathbb{R}_{+} \times H_{n} \times H_{n}, T^{* 0, q} H_{n} \boxtimes\left(T^{* 0, q} H_{n}\right)^{*}\right)
\end{align*}
$$

where $z=\left(x_{1}, \ldots, x_{2 n}\right), w=\left(y_{1}, \ldots, y_{2 n}\right), e^{-t \square_{\eta}}(z, w)$ is given by (4.8). In particular, we have

e^{-t \square_{H_{n}, \Phi}^{q, \delta}}(0,0)=\frac{1}{(2 \pi)^{n+1}} \int_{\mathbb{R}} \frac{\operatorname{det} \dot{R}^{\eta}}{\operatorname{det}\left(1-e^{-t \dot{R}^{\eta}}\right)} e^{-t \omega_{\mathbb{C}^{n}}^{\eta}} 1_{[-\delta, \delta]}(\eta) d \eta \tag{4.21}
\end{equation*}
$$

where $\dot{R}^{\eta}$ and $\omega_{\mathbb{C}^{n}}^{\eta}$ are as in (4.5) and (4.6) respectively.
Moreover, we have

\lim _{\delta \rightarrow+\infty} \frac{1}{2 \pi} \int e^{i<x_{2 n+1}-y_{2 n+1}, \eta>+\frac{\beta}{2}\left(\left(x_{2 n+1}-y_{2 n+1}\right)+i \lambda\left(-|z|^{2}+|w|^{2}\right)\right)+\frac{-\Phi_{0}(w)+\Phi_{0}(z)}{2}} \\
\quad \times e^{-t \square_{\eta}}(z, w) 1_{[-\delta, \delta]}(\eta) d \eta  \tag{4.22}\\
=e^{-t \square_{H_{n}, \Phi}^{q}}(x, y) \quad \text { in } \mathscr{D}^{\prime}\left(\mathbb{R}_{+} \times H_{n} \times H_{n}, T^{* 0, q} H_{n} \boxtimes\left(T^{* 0, q} H_{n}\right)^{*}\right) .
\end{align*}
$$

Now, assume that $Y(q)$ holds. From (4.8) and (4.16), it is straightforward to check that for every $\ell \in \mathbb{N}$, every compact set $K \subset \mathbb{R}_{+} \times H_{n} \times H_{n}$, there are constants $C>0, \varepsilon>0$, such that

\end{equation*}

From (4.23), we conclude that

& \lim _{\delta \rightarrow+\infty} P_{\delta}(t, x, y) \\
& =\frac{1}{2 \pi} \int e^{i<x_{2 n+1}-y_{2 n+1}, \eta>+\frac{\beta}{2}\left(\left(x_{2 n+1}-y_{2 n+1}\right)+i \lambda\left(-|z|^{2}+|w|^{2}\right)\right)+\frac{-\Phi_{0}(w)+\Phi_{0}(z)}{2}} \\
& \quad \times e^{-t \square_{\eta}}(z, w) d \eta
\end{aligned}
$$

locally uniformly on $\mathbb{R}_{+} \times H_{n} \times H_{n}$ in $\mathscr{C}^{\infty}$ topology.
Summing, we obtain
Theorem 4.4. Assume that $Y(q)$ holds. We have

\begin{align*}
& e^{-t \square_{H_{n}, \Phi}^{q}}(x, y) \\
& =\frac{1}{2 \pi} \int e^{i<x_{2 n+1}-y_{2 n+1}, \eta>+\frac{\beta}{2}\left(\left(x_{2 n+1}-y_{2 n+1}\right)+i \lambda\left(-|z|^{2}+|w|^{2}\right)\right)+\frac{-\Phi_{0}(w)+\Phi_{0}(z)}{2}}  \tag{4.24}\\
& \quad \times e^{-t \square_{\eta}}(z, w) d \eta
\end{align*}
$$

where $z=\left(x_{1}, \ldots, x_{2 n}\right), w=\left(y_{1}, \ldots, y_{2 n}\right), e^{-t \square_{\eta}}(z, w)$ is given by (4.8).
In particular, we have

e^{-t \square_{H_{n}, \Phi}^{q}(0,0)}=\frac{1}{(2 \pi)^{n+1}} \int_{\mathbb{R}} \frac{\operatorname{det} \dot{R}^{\eta}}{\operatorname{det}\left(1-e^{-t \dot{R}^{\eta}}\right)} e^{-t \omega_{\mathbb{C}^{n}}^{\eta}} d \eta \tag{4.25}
\end{equation*}
$$

where $\dot{R}^{\eta}$ and $\omega_{\mathbb{C}^{n}}^{\eta}$ are as in (4.5) and (4.6) respectively.

### 4.2. Heat kernel asymptotics on CR manifolds.

Our main task is to obtain the asymptotics of $e^{-\frac{t}{k} \square_{b, k}^{q}}(x, x)$ as $k \rightarrow \infty$ for all $x \in X$. We assume that $Y(q)$ holds. Before proceeding to do so, we shall digress for the moment to illustrate the relationship between $\dot{R}^{\eta}$, the curvature of $L$ and the Levi form.

Definition 4.5. Let $L$ be a CR line bundle over $X$ and $h^{L}$ be the Hermitian fiber metric on $L$ with local weight $\phi$. The curvature of $\left(L, h^{L}\right)$ at $x \in D$ with respect to $\phi$ is the Hermitian quadratic form $\mathcal{R}_{x}^{\phi}$ on $T_{x}^{1,0} X$ defined by

\mathcal{R}_{x}^{\phi}(U, \bar{V})=\frac{1}{2}\left\langle d\left(\bar{\partial}_{b} \phi-\partial_{b} \phi\right)(x), U \wedge \bar{V}\right\rangle, \quad U, V \in T_{x}^{1,0} X \tag{4.26}
\end{equation*}
$$

where $d$ is the usual exterior derivative.
Let

$$
\begin{align*}
& \dot{\mathcal{R}}_{x}^{\phi}: T_{x}^{1,0} X \rightarrow T_{x}^{1,0} X, \\
& \dot{\mathcal{L}}_{x}: T_{x}^{1,0} X \rightarrow T_{x}^{1,0} X, \tag{4.27}
\end{align*}
$$

be the linear maps given by $\left\langle\dot{\mathcal{R}}_{x}^{\phi} U \mid V\right\rangle=\mathcal{R}_{x}^{\phi}(U, \bar{V}),\left\langle\dot{\mathcal{L}}_{x} U \mid V\right\rangle=\mathcal{L}_{x}(U, \bar{V})$, for all $U, V \in T_{x}^{1,0} X$. For every $\eta \in \mathbb{R}$, let

$$
\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)=\mu_{1}(x) \cdots \mu_{n}(x)
$$

where $\mu_{j}(x), j=1, \ldots, n$, are the eigenvalues of $\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}$ with respect to $\langle\cdot \mid \cdot\rangle$, and put

$$
\begin{equation*}
\omega_{x}^{\eta}=\sum_{j, l=1}^{n}\left(\mathcal{R}_{x}^{\phi}-2 \eta \mathcal{L}_{x}\right)\left(U_{l}, \bar{U}_{j}\right) \bar{\omega}^{j} \wedge\left(\bar{\omega}^{l} \wedge\right)^{\star}: T_{x}^{* 0, q} X \rightarrow T_{x}^{* 0, q} X \tag{4.28}
\end{equation*}
$$

where $\left\{U_{j}\right\}_{j=1}^{n}$ is an orthonormal frame of $T_{x}^{1,0} X$ with dual frame $\left\{\omega^{j}\right\}_{j=1}^{n} \subset T^{* 1,0} X$. It should be mentioned that the definition of $\mathcal{R}_{x}^{\phi}$ depends on the choice of local trivializations (local weight $\phi$ ). From [HM12, Proposition 4.2], it is easy to see that for every $x \in X$, the map

\int_{\mathbb{R}} \frac{\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}{\operatorname{det}\left(1-e^{-t\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}\right)} e^{-t \omega_{x}^{\eta}} d \eta: T_{x}^{* 0, q} X \rightarrow T_{x}^{* 0, q} X
$$

is independent of the choice of local weight $\phi$ and hence globally defined.
We now can prove our first main results:
Proof of Theorem 1.1. For $p \in X$, as above, we choose local coordinates $(z, \theta)$ satisfies (3.1)-(3.4) on some neighborhood of $p$. Note that $(z(p), \theta(p))=(0,0)$. It is straightforward to check that

\int_{\mathbb{R}} \frac{\operatorname{det} \dot{R}^{\eta}}{\operatorname{det}\left(1-e^{-t \dot{R}^{\eta}}\right)} e^{-t \omega_{\mathbb{C}}^{\eta}} d \eta=\int_{\mathbb{R}} \frac{\operatorname{det}\left(\dot{\mathcal{R}}_{p}^{\phi}-2 \eta \dot{\mathcal{L}}_{p}\right)}{\operatorname{det}\left(1-e^{-t\left(\dot{\mathcal{R}}_{p}^{\phi}-2 \eta \dot{\mathcal{L}}_{p}\right)}\right)} e^{-t \omega_{p}^{\eta}} d \eta, \tag{4.29}
\end{equation*}
$$

where $\dot{R}^{\eta}$ and $\omega_{\mathbb{C}^{n}}^{\eta}$ are as in (4.5) and (4.6) respectively. From Theorem 3.9, Theorem 4.4 and (4.29), we have

$$
\begin{aligned}
\lim _{k \rightarrow \infty} k^{-(n+1)} e^{-\frac{t}{k} \square_{b, k}^{q}}(0,0) & =\frac{1}{(2 \pi)^{n+1}} \int_{\mathbb{R}} \frac{\operatorname{det} \dot{R}^{\eta}}{\operatorname{det}\left(1-e^{-t \dot{R}^{\eta}}\right)} e^{-t \omega_{\mathbb{C}^{n}}^{\eta}} d \eta \\
& =\frac{1}{(2 \pi)^{n+1}} \int_{\mathbb{R}} \frac{\operatorname{det}\left(\dot{\mathcal{R}}_{p}^{\phi}-2 \eta \dot{\mathcal{L}}_{p}\right)}{\operatorname{det}\left(1-e^{-t\left(\dot{\mathcal{R}}_{p}^{\phi}-2 \eta \dot{\mathcal{L}}_{p}\right)}\right)} e^{-t \omega_{p}^{\eta}} d \eta .
\end{aligned}
$$

Apply this procedure for each point $x \in X$ with replace 0 by $x$, we obtain the desired result.

## 5. Morse inequalities on CR manifolds

In this section, we will establish the weak and strong Morse inequalities on CR manifolds from our heat kernel asymptotics.

Now, we fix $q \in\{0,1, \ldots, n\}$ and assume that $Y(j)$ holds on $X$, for every $j=0,1, \ldots, q$. Let

$$
\begin{equation*}
\operatorname{Tr}_{q}\left(e^{-\frac{t}{k} \square_{b, k}^{q}}(x, x)\right):=\sum_{j=1}^{d}\left\langle\left. e^{-\frac{t}{k} \square_{b, k}^{q}}(x, x) v_{j}(x) \right\rvert\, v_{j}(x)\right\rangle, \tag{5.1}
\end{equation*}
$$

where $\left\{v_{j}\right\}_{j=1}^{d}$ is an orthonormal basis for $T_{x}^{* 0, q} X$. Let

$$
\begin{equation*}
\operatorname{Tr}_{q}\left(e^{-\frac{t}{k} \square_{b, k}^{q}}\right):=\int_{X} \operatorname{Tr}_{q}\left(e^{-\frac{t}{k} \square_{b, k}^{q}}(x, x)\right) d v_{X}(x) \tag{5.2}
\end{equation*}
$$

It is well-known that

$$

\operatorname{dim} H_{b}^{q}\left(X, L^{k}\right) \leq \operatorname{Tr}_{q}\left(e^{-\frac{t}{k} \square_{b, k}^{q}}\right), \text { for every } t>0 \tag{5.3}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{j=0}^{q}(-1)^{q-j} \operatorname{dim} H_{b}^{j}\left(X, L^{k}\right) \leq \sum_{j=0}^{q}(-1)^{q-j} \operatorname{Tr}_{j}\left(e^{-\frac{t}{k} \square_{b, k}^{j}}\right), \text { for every } t>0 \tag{5.4}
\end{equation*}
$$

For $x \in X$ and every $j=0,1, \ldots, q$, set

$$
\begin{gather*}
\mathbb{R}_{x}(j)=\left\{\eta \in \mathbb{R} \mid \dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x} \text { has exactly } j\right. \text { negative eigenvalues } \\
\text { and } n-j \text { positive eigenvalues }\} . \tag{5.5}
\end{gather*}
$$

Remark that since $Y(j)$ holds at each point of $X, \mathbb{R}_{x}(j)$ is bounded for all local weight of $L$. We are now in position to prove Theorem 1.2.

Proof of Theorem 1.2. From Theorem 1.1, Proposition 3.7, (5.4) and Lebesgue dominate theorem, we have for every $t>0$,

& \lim _{k \rightarrow \infty} k^{-(n+1)} \sum_{j=0}^{q}(-1)^{q-j} \operatorname{dim} H_{b}^{j}\left(X, L^{k}\right) \\
& \leq \lim _{k \rightarrow \infty} k^{-(n+1)} \sum_{j=0}^{q}(-1)^{q-j} \operatorname{Tr}_{j}\left(e^{-\frac{t}{k} \square_{b, k}^{j}}\right)  \tag{5.6}\\
& =\sum_{j=0}^{q}(-1)^{q-j} \int_{X} \lim _{k \rightarrow \infty} k^{-(n+1)} \operatorname{Tr}_{j}\left(e^{-\frac{t}{k} \square_{b, k}^{j}}(x, x)\right) d v_{X}(x) \\
& =\frac{1}{(2 \pi)^{n+1}} \sum_{j=0}^{q}(-1)^{q-j} \int_{X} \int_{\mathbb{R}} \frac{\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}{\operatorname{det}\left(1-e^{-t\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}\right)} \operatorname{Tr}_{j} e^{-t \omega_{x}^{\eta}} d \eta d v_{X}(x) .
\end{align*}
$$

It is straightforward to check that for every $j=0,1, \ldots, q$,

$$
\begin{align*}
& \lim _{t \rightarrow \infty} \frac{\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}{\operatorname{det}\left(1-e^{-t\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}\right)} \operatorname{Tr}_{j} e^{-t \omega_{x}^{\eta}} \\
& =(-1)^{j} 1_{\mathbb{R}_{x}(j)}(\eta) \operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)  \tag{5.7}\\
& =1_{\mathbb{R}_{x}(j)}(\eta)\left|\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)\right|,
\end{align*}
$$

where $1_{\mathbb{R}_{x}(q)}(\eta)$ is the characteristic function of $\mathbb{R}_{x}(q)$. From (5.6) and (5.7), we get

& \lim _{k \rightarrow \infty} k^{-(n+1)} \sum_{j=0}^{q}(-1)^{q-j} \operatorname{dim} H_{b}^{j}\left(X, L^{k}\right) \\
& \leq \lim _{t \rightarrow \infty} \frac{1}{(2 \pi)^{n+1}} \sum_{j=0}^{q}(-1)^{q-j} \int_{X} \int_{\mathbb{R}} \frac{\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}{\operatorname{det}\left(1-e^{-t\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)}\right)} \operatorname{Tr}_{j} e^{-t \omega_{x}^{\eta}} d \eta d v_{X}(x)  \tag{5.8}\\
& =\frac{1}{(2 \pi)^{n+1}} \sum_{j=0}^{q}(-1)^{q-j} \int_{X} \int_{\mathbb{R}_{x}(j)}\left|\operatorname{det}\left(\dot{\mathcal{R}}_{x}^{\phi}-2 \eta \dot{\mathcal{L}}_{x}\right)\right| d \eta d v_{X}(x) .
\end{align*}
$$

From (5.8), we get (1.7).
From (5.3), we can repeat the procedure above and get (1.8).

## 6. With $\mathbb{R}$-action

In the last section, we have established the heat kernel asymptotics of Kohn Laplacian with values in $L^{k}$ when $Y(q)$ holds on each point of CR manifolds $X$. Nevertheless, in some important problems in CR geometry, we may need to study things without any assumption of the Levi form. In this section, our task is to show that the same conclusion can be drawn for a CR manifold $X$ of dimensional $2 n+1, n \geq 1$ with a transversal CR $\mathbb{R}$-action.

We assume that $X$ admits a $\mathbb{R}$-action $\eta, \eta \in \mathbb{R}: \eta: X \rightarrow X, x \mapsto \eta \circ x$. Suppose that $X$ admits a $\mathbb{R}$-invariant complete Hermitian metric $\langle\cdot \mid \cdot\rangle$ on $\mathbb{C} T X$ so that we have the orthogonal decomposition

$$
\mathbb{C} T X=T^{1,0} X \oplus T^{0,1} X \oplus\{\lambda T: \lambda \in \mathbb{C}\}
$$

and $|T|^{2}=\langle T \mid T\rangle=1$, where $T \in \mathscr{C}^{\infty}(X, T X)$ is the infinitesimal generator of the $\mathbb{R}$-action which is given by (2.16). Let $\left(L, h^{L}\right)$ be a rigid CR line bundle over $X$ with a $\mathbb{R}$-invaraint Hermitian metric $h^{L}$ on $X$. We will use the same notations as Section 2.3. The following result due to Baouendi-Rothschild-Treves[BRT85, Proposition I.2] will be used to set up the local coordinates.

Theorem 6.1. For $p \in X$, there exist local coordinates $x=\left(x_{1}, \cdots, x_{2 n+1}\right)=(z, \theta)=$ $\left(z_{1}, \cdots, z_{n}, \theta\right), z_{j}=x_{2 j-1}+i x_{2 j}, j=1, \cdots, n$, defined in some small neighborhood $D=$ $\{(z, \theta):|z|<\varepsilon,|\theta|<\delta\}$ of $p$ such that

$$
\begin{align*}
T & =-\frac{\partial}{\partial \theta} \\
Z_{j} & =\frac{\partial}{\partial z_{j}}-i \frac{\partial \varphi(z)}{\partial z_{j}} \frac{\partial}{\partial \theta} \tag{6.1}
\end{align*}
$$

where $\left\{Z_{j}\right\}_{j=1}^{n}$ form a basis of $T_{x}^{1,0} X$ for each $x \in D, \varphi(z) \in C^{\infty}(D, \mathbb{R})$ is independent of $\theta$. Moreover, we can take $(z, \theta)$ and $\varphi(z)$ such that $(z(p), \theta(p))=(0,0)$ and $\varphi(z)=$ $\sum_{j=1}^{n} \lambda_{j}\left|z_{j}\right|^{2}+O\left(|z|^{3}\right)$ on $D$, where $\left\{\lambda_{j}\right\}_{j=1}^{n}$ are the eigenvalues of Levi form on $p$ with respect to the given $\mathbb{R}$-invariant Hermitian metric. We call $x=\left(x_{1}, \ldots, x_{2 n+1}\right)=(z, \theta)$ canonical local coordinates of $X$.

For $p \in X$, let $s$ be a rigid CR trivializing section of $L$ on an open set $D$ of $p$ and $|s|_{h}^{2}=e^{-\phi}$. We take canonical local coordinates $x$ and rigid CR trivializing section $s$ such that (3.1), (3.2), (3.3) hold and

$$
\begin{equation*}
\phi(z)=\sum_{j, l=1}^{n} \mu_{j, l} z_{j} \bar{z}_{l}+O\left(|z|^{3}\right) \tag{6.2}
\end{equation*}
$$

On $D$, by using $s$, we will identify sections with functions in the natural way. Follow the setting in section 3 , we let

\square_{b,(k)}^{q}:=\square_{\rho,(k)}^{q},
$$

where $\square_{\rho,(k)}^{q}$ is as in (3.27). Note that $\rho=0$ and $\beta=0$ in this case. Let

\begin{equation*}
A_{k \phi, \delta}\left(\frac{t}{k}, x, y\right):=e^{\frac{k \phi(x)}{2}} A_{k, s, \delta}\left(\frac{t}{k}, x, y\right) e^{-\frac{k \phi(y)}{2}}, \tag{6.3}
\end{equation*}
$$

where $A_{k, s, \delta}\left(\frac{t}{k}, x, y\right)$ is as in (2.28). We will also use the same notations as in Section 3. Let

$$
\begin{align*}
& A_{(k), \delta}(t, x, y)  \tag{6.4}\\

& =\int_{0}^{t}\left(B_{\delta}^{\prime}(s) f \mid g\right)_{\Phi} d s \\
& =\left(B_{\delta}(t) f \mid g\right)_{\Phi}-\lim _{t \rightarrow 0}\left(B_{\delta}(t) f \mid g\right)_{\Phi},
\end{align*}
$$

which implies (6.31).
Assume that the $\mathbb{R}$-action is free. Let $f \in \Omega_{c}^{0, q}\left(H_{n}\right)$ and let $f_{k} \in F_{k}^{*} \Omega_{c}^{0, q}\left(B_{\log k}\right)$ be as in (3.65). From (6.30), we can check that

$$
\begin{equation*}
\lim _{k \rightarrow+\infty} A_{(k), \delta}(0) f_{k}=Q_{[-\delta, \delta]} f \text { on every } B_{r}, r>0 \tag{6.34}
\end{equation*}
$$

Repeat the procedure above, we then get (6.31).
We need
Proposition 6.10. We have

$$
B_{\delta}(t) u \in E_{-i T_{H_{n}}}[[-\delta, \delta]), \text { for all } t>0 \text { and all } u \in \Omega_{c}^{0, q}\left(H_{n}\right) .
$$

Proof. Fix $u \in \Omega_{c}^{0, q}\left(H_{n}\right)$ and $t>0$. Let $\varepsilon>0, \varepsilon \ll 1$. The map

$$
-i T_{H_{n}}: E_{-i T_{H_{n}}}\left(\left[-\frac{1}{\varepsilon},-\delta-\varepsilon\right] \bigcup\left[\delta+\varepsilon, \frac{1}{\varepsilon}\right]\right) \rightarrow E_{-i T_{H_{n}}}\left(\left[-\frac{1}{\varepsilon},-\delta-\varepsilon\right] \bigcup\left[\delta+\varepsilon, \frac{1}{\varepsilon}\right]\right)
$$

is one to one and onto.
Write $\left(-i T_{H_{n}}\right)^{-1}$ to denote the inverse of $-i T_{H_{n}}$ on $E_{-i T_{H_{n}}}\left(\left[-\frac{1}{\varepsilon},-\delta-\varepsilon\right] \bigcup\left[\delta+\varepsilon, \frac{1}{\varepsilon}\right]\right)$. It is clear that

$$
\begin{equation*}
\left\|\left(-i T_{H_{n}}\right)^{s} g\right\|_{\Phi} \leq\left(\frac{1}{\delta+\varepsilon}\right)^{s}\|g\|_{\Phi} \tag{6.35}
\end{equation*}
$$

for all $s \in \mathbb{N}$ and every $g \in E_{-i T_{H_{n}}}\left(\left[-\frac{1}{\varepsilon},-\delta-\varepsilon\right] \bigcup\left[\delta+\varepsilon, \frac{1}{\varepsilon}\right]\right)$. Let $v \in E_{-i T_{H_{n}}}\left(\left[-\frac{1}{\varepsilon},-\delta-\right.\right.$ $\left.\varepsilon] \bigcup\left[\delta+\varepsilon, \frac{1}{\varepsilon}\right]\right)$. From (6.16) and (6.35), we have

$$
\begin{align*}
& \left|\left(B_{\delta}(t) u \mid v\right)_{\Phi}\right|=\left|\left(B_{\delta}(t) u \mid\left(-i T_{H_{n}}\right)^{s}\left(-i T_{H_{n}}\right)^{-s} v\right)_{\Phi}\right| \\
& =\left|\left(\left(-i T_{H_{n}}\right)^{s} B_{\delta}(t) u \mid\left(-i T_{H_{n}}\right)^{-s} v\right)_{\Phi}\right| \leq\left(\frac{\delta}{\delta+\varepsilon}\right)^{s}\|u\|_{\Phi}\|v\|_{\Phi}, \tag{6.36}
\end{align*}
$$

for every $s \in \mathbb{N}$. Let $s \rightarrow+\infty$ in (6.36), we get $\left(B_{\delta}(t) u \mid v\right)_{\Phi}=0$. Hence, $B_{\delta}(t) u$ is orthogonal to $E_{-i T_{H_{n}}}\left(\left[-\frac{1}{\varepsilon},-\delta-\varepsilon\right] \bigcup\left[\delta+\varepsilon, \frac{1}{\varepsilon}\right]\right)$, for every $\varepsilon>0, \varepsilon \ll 1$. Hence, $B_{\delta}(t) u \in$ $E_{-i T_{H_{n}}}([-\delta, \delta])$.

Theorem 6.11. We have

$$
B_{\delta}(t)=e^{-t \square \square_{Q, H_{n}}^{q, \delta}}
$$

where $e^{-t \square_{\Phi, H_{n}}^{q, \delta}}$ is given by (4.11).
Proof. Let $u, v \in \Omega_{c}^{0, q}\left(H_{n}\right)$. From Propostion 6.9 and Proposition 6.10, we have

$$
\begin{align*}
& \left(u \mid e^{\left.-t \square_{H_{n}, \Phi}^{q, \delta} v\right)_{\Phi}-\left(B_{\delta}(t) u \mid v\right)_{\Phi}}\right. \\
& =\int_{0}^{t} \frac{\partial}{\partial s}\left(\left(B_{\delta}(t-s) u \mid e^{-s \square_{H_{n}, \Phi}^{q, \delta}} v\right)_{\Phi}\right) d s  \tag{6.37}\\
& =\int_{0}^{t}\left(-B_{\delta}^{\prime}(t-s) u \mid e^{-s \square_{H_{n}, \Phi}^{q, \delta} v}\right)_{\Phi} d s+\int_{0}^{t}\left(B_{\delta}(t-s) u \mid-\square_{H_{n}, \Phi}^{q}\left(e^{-s \square_{H_{n}, \Phi}^{q, \delta} v}\right)\right)_{\Phi} d s .
\end{align*}
$$

Form (6.15), we see that $B_{\delta}(t-s) u \in \operatorname{Dom} \square_{H_{n}, \Phi}^{q}$ and hence

$$
\begin{equation*}
\left(B_{\delta}(t-s) u \mid-\square_{H_{n}, \Phi}^{q}\left(e^{\left.-s \square_{H_{n}, \Phi}^{q, \delta} v\right)}\right)_{\Phi}=\left(-\square_{H_{n}, \Phi}^{q} B_{\delta}(t-s) u \mid e^{\left.-s \square_{H_{n}, \Phi}^{q, \delta} v\right)_{\Phi} .}\right.\right. \tag{6.38}
\end{equation*}
$$

From (6.14), (6.37) and (6.38), we deduce that

$$
\left(u \mid e^{-t \square_{H_{n}, \Phi}^{q, \delta} v}\right)_{\Phi}-\left(B_{\delta}(t) u \mid v\right)_{\Phi}=0
$$

Since $\left(u \mid e^{-t \square_{H_{n}, \Phi}^{q, \delta} v}\right)_{\Phi}=\left(e^{-t \square_{H_{n}, \Phi}^{q, \delta} u} \mid v\right)_{\Phi}$, we conclude that $B_{\delta}(t)=e^{-t \square_{H_{n}, \Phi}^{q, \delta}}$.
From Theorem 4.3 and Theorem 6.11, we can repeat the proofs of Theorem 1.1 and Theorem 1.2 and get Theorem 1.3 and Theorem 1.4.
