# BLOW-UP RESULTS FOR A LOGARITHMIC PSEUDO-PARABOLIC $p($.$) -LAPLACIAN TYPE EQUATION$

#### Abstract

In this paper, we consider an initial-boundary value problem for the following mixed pseudoparabolic $p($.$) -Laplacian type equation with logarithmic nonlinearity:$ $$
u_{t}-\Delta u_{t}-\operatorname{div}\left(|\nabla u|^{p(.)-2} \nabla u\right)=|u|^{q(.)-2} u \ln (|u|), \quad(x, t) \in \Omega \times(0,+\infty)
$$ where $\Omega \subset \mathbb{R}^{n}$ is a bounded and regular domain, and the variable exponents $p($.$) and q($.$) satisfy suitable$ regularity assumptions. By adapting the first-order differential inequality method, we establish a blow-up criterion for the solutions and obtain an upper bound for the blow-up time. Besides, we show that blow-up may be prevented under appropriate smallness conditions on the initial datum, in which case we also establish decay estimates in the $H_{0}^{1}(\Omega)$-norm as $t \rightarrow+\infty$. This decay result is illustrated by a two-dimensional numerical example.


## 1. Introduction

Let $\Omega \subset \mathbb{R}^{n}$ be a bounded domain with smooth boundary $\partial \Omega$. In this paper, we look at the following pseudo-parabolic $p($.$) -Laplacian equation with logarithmic nonlinearity:$

\begin{cases}u_{t}-\Delta u_{t}-\operatorname{div}\left(|\nabla u|^{p(.)-2} \nabla u\right)=|u|^{q(.)-2} u \ln (|u|), & (x, t) \in \Omega \times(0,+\infty)  \tag{1.1}\\ u(x, t)=0, & (x, t) \in \partial \Omega \times(0,+\infty) \\ u(x, 0)=u_{0}(x) \neq 0, & x \in \Omega\end{cases}
$$

In (1.1), $p($.$) and q($.$) are given measurable functions on \bar{\Omega}$ satisfying

2 \leq p_{1} \leq p(x) \leq p_{2}<q_{1} \leq q(x) \leq q_{2}<p^{*}(x)
$$

where we have denoted

p_{1}:=\underset{x \in \Omega}{\operatorname{ess} \inf } p(x), & p_{2}=\underset{x \in \Omega}{\operatorname{ess} \sup } p(x) \\
q_{1}:=\underset{x \in \Omega}{\operatorname{ess} \inf } q(x), & q_{2}=\underset{x \in \Omega}{\operatorname{ess} \sup } q(x) .
\end{array}

and

p^{*}(x):=\left\{\begin{array}{ll}
\frac{n p(x)}{n-p(x)}, & \text { if } n>p_{2},  \tag{1.2}\\
+\infty, & \text { if } n \leq p_{2}
\end{array} .\right.
$$

Moreover, we assume that $p($.$) and q($.$) satisfy the following Zhikov-Fan uniform local continuity condition:$ there exist a constant $M>0$ such that

|q(x)-q(y)| \leq \frac{M}{|\log | x-y| |}, \quad \text { for all }(x, y) \in \Omega \times \Omega \text { with }|x-y|<\frac{1}{2} . \tag{1.3}
\end{equation*}

[^0]Finally, the initial datum in (1.1) is assumed to be any given function $u_{0} \in W_{0}^{1, p(.)}(\Omega)$, where $W_{0}^{1, p(.)}(\Omega)$ denotes the generalization to the variable exponent case of the Sobolev space $W_{0}^{1, p}(\Omega)$. We refer to Section 2 for more detail.

The nonlinear term $\operatorname{div}\left(|\nabla u|^{p(.)-2} \nabla u\right)$ in 1.1 is the so-called $p($.$) -Laplacian operator, which is sometimes$ symbolized by

$$
\Delta_{p(.)} u=\operatorname{div}\left(|\nabla u|^{p(.)-2} \nabla u\right)
$$

and is a generalization of the well-known $p$-Laplacian, that corresponds to taking $p(.) \equiv p \in \mathbb{R}$ constant.
This operator can be prolonged to a monotone operator between the space $W_{0}^{1, p(.)}(\Omega)$ and its dual space $W^{-1, p^{\prime}(.)}(\Omega)$ as follows

-\Delta_{p(.)} u: W_{0}^{1, p(.)}(\Omega) \rightarrow W^{-1, p^{\prime}(.)}(\Omega) \\
\left\langle-\Delta_{p(.)} u, \phi\right\rangle_{p(.)}=\int_{\Omega}|\nabla u|^{p(x)-2} \nabla u \nabla \phi \mathrm{~d} x, \quad 2 \leq p_{1} \leq p(x) \leq p_{2}<+\infty
\end{array}\right.
$$

where $\langle., .\rangle_{p(.)}$ indicates the duality pairing between $W_{0}^{1, p(.)}(\Omega)$ and $W^{-1, p^{\prime}(.)}(\Omega)$, and $p^{\prime}($.$) denotes the$ conjugate exponent such that

$$
\frac{1}{p(x)}+\frac{1}{p^{\prime}(x)}=1
$$

Nonlinear pseudo-parabolic equations like (1.1) arise in the description of several problems in hydrodynamics, thermodynamics, nonlinear elasticity, image processing and filtration theory (see [4, 22, 30, 32, 33). Furthermore, we can mention interesting applications in the study of electrorheological fluids, whose viscosity depends on the electric field in the fluid itself (see [2, 18, 19, 20, 26, 45]).

In the case in which the exponents $p($.$) and q($.$) are constants, that is when p(.) \equiv p \in \mathbb{R}$ and $q(.) \equiv q \in \mathbb{R}$, the corresponding PDE

$$
\begin{equation*}
u_{t}-\Delta u_{t}-\operatorname{div}\left(|\nabla u|^{p-2} \nabla u\right)=|u|^{q-2} u \ln (|u|), \quad(x, t) \in \Omega \times(0,+\infty) \tag{1.4}
\end{equation*}
$$

has been largely studied by the mathematical community.
In [46, 49], the linear version of (1.4) (i.e. with the right-hand side equal to zero) has been considered in the case $p=2$ in which the $p$-Laplacian $-\Delta_{p}$ becomes the standard Laplace operator $-\Delta$. In particular, results of existence, uniqueness and regularity of the solutions were obtained.

Later on, these results have been extended to the general case of (1.4). In several papers, the asymptotic behavior of weak solutions to 1.4 with initial datum $u_{0} \in W_{0}^{1, p}(\Omega)$ has been studied. In more detail,

- The case $p=q>2$ has been considered in [37].
- The case $1<p=q<2$ has been considered in [50].
- The case $2<p<q<p\left(1+\frac{2}{n}\right)$ has been considered in [27.
- The case $1<p \leq q<p^{*}$, with $p^{*}$ as in 1.2), has been considered in [21].

In all the aforementioned references, the global-in-time existence or the finite time blow-up of such solutions has been characterized in terms of the values of the exponents $p$ and $q$. We shall stress, however, that the methodology employed in [27, 37, 50] to prove the blow-up of weak solutions to (1.4) does not allow the authors to address the relevant issue of estimating the blow-up time and rate (we refer to [36, 38, 39, 40, 41, 47, for the analysis of these issues in the case of other interesting non-linear evolution equations). A partial answer to these relevant questions has been recently given in [16] where, under the same conditions as in [27] on the exponents $p, q \in \mathbb{R}$ (that is, $2<p<q<p\left(1+\frac{2}{n}\right)$ ), explicit estimates for the blow-up time are provided.

Finally, we refer to [11, 12, 13, 15, 16, 17, 25, 29, 31, 34, 42, 51 for the study of the asymptotic behavior of weak solutions to (1.4) under high initial energy level conditions.

As for the case of variable exponents $p($.$) and q($.$) , to the best of our knowledge, there are no results in$ the existing literature in the spirit of those that we have just recalled. As a matter of fact, many of the techniques employed in the previous references to deal with 1.4 become unsuccessful to analyze 1.1 when $p($.$) and q($.$) are measurable functions on \bar{\Omega}$.

The goal of this paper is precisely to address this variable measurable coefficients framework. In particular, we shall identify sufficient conditions on $p(),. q($.$) and the initial datum u_{0}$ for which the blow-up and the non-blow-up phenomena of solutions to (1.1) appear, also providing estimates for the blow-up time.

At this regard, we shall mention that this kind of results are already available for the hyperbolic version of (1.1). The interested reader may refer for instance to [1, 5, ,7, 8, 9, 10, 14, 35, 43, 44, 48]. In particular, in [5. 8, the authors have discussed the Dirichlet problem for following equation

u_{t t}=\operatorname{div}\left(a(x, t)|\nabla u|^{p(x, t)-2} \nabla u\right)+\alpha \Delta u_{t}+b(x, t)|u|^{\sigma(x, t)-2} u+f(x, t), \quad(x, t) \in \Omega \times(0,+\infty)
$$

with negative initial energy and, under suitable conditions on the functions $a, b, f, p, \sigma$, they have used Galerkin and energy methods to establish local existence, global existence and blow-up of the solutions.

The present paper is organized as follows: in Section 2 we will introduce some preliminary concepts and notations that will be of use in our further analysis. Secondly, we will study the finite-time blow-up of solutions in Section 3. The global existence of weak solutions to 1.1 is addressed in Section 4 where we also we also establish decay estimates in the $H_{0}^{1}(\Omega)$-norm as $t \rightarrow+\infty$. Finally, in Section 5 this decay result is illustrated by a two-dimensional numerical example.

## 2. Preliminaries

In this section, we present some preliminary concepts and notations that we shall employ in our further analysis. Let us start by introducing the variable-order Lebesque space $L^{p(.)}(\Omega)$, which is defined for all $p: \Omega \rightarrow[1,+\infty]$ a measurable function as

L^{p(.)}(\Omega):=\left\{u: \Omega \rightarrow \mathbb{R} \text { measurable }: \int_{\Omega}|u(x)|^{p(x)} \mathrm{d} x<+\infty\right\}
$$

We then know that $L^{p(.)}(\Omega)$ is a Banach space, equipped with the Luxemburg-type norm

$$
\|u\|_{p(.)}:=\inf \left\{\lambda>0, \quad \int_{\Omega}\left|\frac{u(x)}{\lambda}\right|^{p(x)} \mathrm{d} x \leq 1\right\}
$$

Next, we define the variable-order Sobolev space $W^{1, p(.)}(\Omega)$ as

$$
W^{1, p(.)}(\Omega):=\left\{u \in L^{p(.)}(\Omega): \nabla u \in L^{p(.)}(\Omega)\right\}
$$

equipped with the norm

$$
\begin{equation*}
\|u\|_{W^{1, p(.)}(\Omega)}=\|u\|_{p(.)}^{2}+\|\nabla u\|_{p(.)}^{2} . \tag{2.1}
\end{equation*}
$$

Moreover, in what follows we will need the following embedding result from [19, 23].
Lemma 2.1. Let $\Omega \subset \mathbb{R}^{n}$ be a bounded regular domain. It holds the following.

1. If $p \in C(\bar{\Omega})$ and $q: \Omega \rightarrow[1,+\infty)$ is a measurable function such that

$$
\underset{x \in \Omega}{\operatorname{ess} \inf ^{*}}\left(p^{*}(x)-q(x)\right)>0
$$

with $p^{*}$ defined as in 1.2 , then $W_{0}^{1, p(.)}(\Omega) \hookrightarrow L^{q(.)}(\Omega)$ with continuous and compact embedding.
2. If $p$ satisfy $(1.3)$, then $\|u\|_{p(.)} \leq C\|\nabla u\|_{p(.)}$ for all $u \in W_{0}^{1, p(.)}(\Omega)$. In particular, $\|u\|_{1, p(.)}=\|\nabla u\|_{p(.)}$ defines a norm on $W_{0}^{1, p(.)}(\Omega)$ which is equivalent to 2.1.
Let us now introduce our notion of weak solution to 1.1), and give a first result of local-in-time existence and uniqueness.

Definition 2.2. Let $u_{0} \in W_{0}^{1, p(.)}(\Omega)$ and $T>0$. A function

$$
u \in L^{\infty}\left(0, T ; W_{0}^{1, p(.)}(\Omega)\right) \text { with } u_{t} \in L^{2}\left(0, T ; H_{0}^{1}(\Omega)\right)
$$

is called a weak solution to (1.1) if the identity

$$
\left.\left\langle u_{t}, v\right\rangle+\left\langle\nabla u_{t}, \nabla v\right\rangle+\left.\langle | \nabla u\right|^{p(.)-2} \nabla u, \nabla v\right\rangle=\int_{\Omega}|u|^{q(.)-2} u \ln (|u|) v \mathrm{~d} x
$$

holds for any $v \in W_{0}^{1, p(.)}(\Omega)$, and for a.e. $t \in[0, T]$.
Theorem 2.3. For all $u_{0} \in W_{0}^{1, p(.)}(\Omega)$, there exists $T_{0}>0$ such that the problem (1.1) admits a unique weak solution $u$ on $\left[0, T_{0}\right]$.

Proof. The result can be easily obtained by using the Faedo-Galerkin approach and combining the ideas from [3, 20, 24, 28] with the ones from [6] (see also [50]). We leave the details to the reader.

Let now $\sigma>0$ be a positive constant satisfying

0<\sigma< \begin{cases}p^{*}-q_{2}, & \text { if } p(.)<n  \tag{2.2}\\ +\infty, & \text { if } p(.) \geq n\end{cases}
$$

Then, from Lemma 2.1 we have that $W_{0}^{1, q(.)+\sigma}(\Omega) \hookrightarrow L^{q(.)+\sigma}(\Omega)$, and there exists a positive constant $B_{\sigma}>0$ such that

\|u\|_{q(.)+\sigma} \leq B_{\sigma}\|\nabla u\|_{q(.)+\sigma} \tag{2.3}
\end{equation*}
$$

Finally, let us indicate with $\alpha_{1}, B_{1}$ and $E_{1}$ the following positive constants:

\begin{align*}
& \alpha_{1}=\left(\frac{e \sigma q_{1}}{q_{1}+\sigma} B_{1}^{-\left(q_{1}+\sigma\right)}\right)^{\frac{p_{2}}{q_{1}-p_{2}+\sigma}}  \tag{2.4a}\\
& B_{1}=\max \left(1, B_{\sigma}\right)  \tag{2.4b}\\
& E_{1}=\left(\frac{1}{p_{2}}-\frac{1}{q_{1}+\sigma}\right) \alpha_{1} . \tag{2.4c}
\end{align*}
$$

## 3. Finite-time blow-up of solutions

In this section, we obtain a blow-up criterion for the solutions to 1.1 , also providing an upper bound for the blow-up time. To this end, let us introduce the energy associated with the solution of our problem (1.1), which is defined as follows:

$$
\begin{equation*}
E(t):=\int_{\Omega} \frac{1}{p(.)}|\nabla u|^{p(.)} \mathrm{d} x-\int_{\Omega} \frac{1}{q(.)}|u|^{q(.)} \ln (|u|) \mathrm{d} x+\int_{\Omega} \frac{1}{q^{2}(.)}|u|^{q(.)} \mathrm{d} x \tag{3.1}
\end{equation*}
$$

We have the following result providing upper and lower bounds for $E(t)$.
Lemma 3.1. Let $u_{0} \in W^{1, p(.)}(\Omega)$ and $E(t)$ be the energy associated with the corresponding solution of (1.1), as defined in (3.1). Let $g:[0,+\infty) \rightarrow \mathbb{R}$ be given by

$$
\begin{equation*}
g(\xi):=\frac{1}{p_{2}} \min \left(\xi^{\frac{p_{1}}{p_{2}}}, \xi\right)-\frac{1}{e \sigma q_{1}} \max \left(B_{1}^{q_{2}+\sigma} \xi^{\frac{q_{2}+\sigma}{p_{2}}}, B_{1}^{q_{1}+\sigma} \xi^{\frac{q_{1}+\sigma}{p_{2}}}\right) \tag{3.2}
\end{equation*}
$$

where $\sigma$ and $B_{1}$ are the constants defined in 2.2 and 2.4b, respectively. Let $\alpha:[0,+\infty) \rightarrow[0,+\infty)$ be defined as

$$
\begin{equation*}
\alpha(t)=\|\nabla u(t)\|_{p(.)}^{p_{2}} \tag{3.3}
\end{equation*}
$$

Then, we have

$$
\begin{equation*}
g(\alpha) \leq E(t) \leq E(0) \tag{3.4}
\end{equation*}
$$

Proof. First of all, a direct computation yields that

$$
\begin{equation*}
\frac{d E(t)}{d t}=-\int_{\Omega} u_{t}^{2} \mathrm{~d} x-\int_{\Omega}\left|\nabla u_{t}\right|^{2} \mathrm{~d} x \leq 0 \tag{3.5}
\end{equation*}
$$

Hence, $E$ is decreasing with respect to $t$, and the inequality $E(t) \leq E(0)$ immediately holds for all $t \geq 0$. As for the lower estimate in (3.4, we have that

$$
\begin{equation*}
\int_{\Omega} \frac{1}{q(.)}|u|^{q(.)} \ln (|u|) \mathrm{d} x \leq \frac{1}{q_{1}} \int_{\Omega}|u|^{q(.)} \ln (|u|) \mathrm{d} x \leq \frac{1}{e \sigma q_{1}} \int_{\Omega}|u|^{q(.)+\sigma} \mathrm{d} x \tag{3.6}
\end{equation*}
$$

where we used that

$$
\begin{equation*}
\ln (\xi) \leq \frac{1}{e \sigma} \xi^{\sigma}, \quad \text { for all } \xi, \sigma>0 \tag{3.7}
\end{equation*}
$$

Therefore, we get from (3.1, (3.3), 3.2 and (3.6) that

$$
\begin{align*}
E(t) & \geq \frac{1}{p_{2}} \min \left(\|\nabla u\|_{p(.)}^{p_{1}},\|\nabla u\|_{p(.)}^{p_{2}}\right)-\frac{1}{e \sigma q_{1}} \max \left(\|u\|_{q(.)+\sigma}^{q_{2}+\sigma},\|u\|_{q(.)+\sigma}^{q_{1}+\sigma}\right)  \tag{3.8}\\
& \geq \frac{1}{p_{2}} \min \left(\|\nabla u\|_{p(.)}^{p_{1}},\|\nabla u\|_{p(.)}^{p_{2}}\right)-\frac{1}{e \sigma q_{1}} \max \left(\left(B_{1}\|\nabla u\|_{p(.)}\right)^{q_{2}+\sigma},\left(B_{1}\|\nabla u\|_{p(.)}\right)^{q_{1}+\sigma}\right)=g(\alpha)
\end{align*}
$$

This concludes the proof of 3.4 .
Next, we state some technical lemmas which will be needed in the proof of our main result.
Lemma 3.2. Let $\alpha_{1}, B_{1}$ and $E_{1}$ be given as in 2.4a, 2.4b and 2.4c), respectively. Define the function $h:[0,+\infty) \rightarrow \mathbb{R}$ as

$$
\begin{equation*}
h(\xi)=\frac{1}{p_{2}} \xi-\frac{1}{e \sigma q_{1}} B_{1}^{q_{1}+\sigma} \xi^{\frac{q_{1}+\sigma}{p_{2}}} \tag{3.9}
\end{equation*}
$$

Then, the following assertions hold:

1. $h$ is increasing for $0<\xi \leq \alpha_{1}$ and decreasing for $\xi \geq \alpha_{1}$.
2. $h\left(\alpha_{1}\right)=E_{1}$.
3. $\lim _{\xi \rightarrow+\infty} h(\xi)=-\infty$.

Proof. First of all, from the definition (3.9) of the function $h$ we can easily compute

$$
h^{\prime}(\xi)=\frac{1}{p_{2}}-\frac{q_{1}+\sigma}{p_{2}} \frac{1}{e \sigma q_{1}} B_{1}^{q_{1}+\sigma} \xi^{\frac{q_{1}+\sigma}{p_{2}}-1}
$$

Then, it is straightforward to check that $h^{\prime}(\xi)>0$ for $\xi<\alpha_{1}$ and $h^{\prime}(\xi)<0$ for $\xi>\alpha_{1}$. Besides, the fact that $h\left(\alpha_{1}\right)=E_{1}$ follows directly from 2.4c and 3.9. Finally, since by definition of $p_{2}, q_{1}$ and $\sigma$ we have $q_{1}-p_{2}+\sigma>0$, we get

$$
\lim _{\xi \rightarrow+\infty} h(\xi)=\lim _{\xi \rightarrow+\infty} \xi\left(\frac{1}{p_{2}}-\frac{1}{e \sigma q_{1}} B_{1}^{q_{1}+\sigma} \xi^{\frac{q_{1}-p_{2}+\sigma}{p_{2}}}\right)=-\infty
$$

This concludes our proof.
Lemma 3.3. Let $\sigma, \alpha_{1}, B_{1}$ and $E_{1}$ be given as in 2.2, 2.4a, 2.4b and 2.4c), respectively. Assume that the initial value $u_{0}$ is chosen so that

$$
\begin{equation*}
0 \leq E(0)<\frac{p_{2}}{q_{1}+p_{2}}\left(E_{1}-\frac{\sigma \alpha_{1}}{p_{2}\left(q_{1}+\sigma\right)}\right) \quad \text { and } \quad \alpha_{1}<\left\|\nabla u_{0}\right\|_{p(.)}^{p_{2}} \leq B_{1}^{-p_{2}} \tag{3.10}
\end{equation*}
$$

Then, there exists a positive constant $\alpha_{2}>\alpha_{1}$ such that

$$
\begin{align*}
& \|\nabla u\|_{p(.)}^{p_{2}} \geq \alpha_{2}, \quad \text { for all } t \geq 0  \tag{3.11a}\\
& \int_{\Omega} \frac{1}{q(.)}|u|^{q(.)} \ln (|u|) \mathrm{d} x \geq \frac{1}{e \sigma q_{1}} B_{1}^{q_{1}+\sigma} \alpha_{2}^{\frac{q_{1}+\sigma}{p_{2}}}  \tag{3.11b}\\
& \frac{\alpha_{2}}{\alpha_{1}} \geq\left(\left(q_{1}+\sigma\right)\left(\frac{1}{p_{2}}-\frac{E(0)}{\alpha_{1}}\right)\right)^{\frac{p_{2}}{q_{1}+\sigma-p_{2}}}>1 \tag{3.11c}
\end{align*}
$$

Proof. Since from 3.10 we have

$$
0 \leq E(0)<\frac{p_{2} E_{1}}{q_{1}+p_{2}}<E_{1}
$$

it follows from Lemma 3.2 that there exists a positive constant $\alpha_{2}>\alpha_{1}$ such that the initial energy $E(0)$ satisfies $E(0)=h\left(\alpha_{2}\right)$ (see Figure 11). Moreover, since $B_{1}>1$ (see 2.4b), it follows again from 3.10) that

$$
\alpha_{0}=\left\|\nabla u_{0}\right\|_{p(.)}^{p_{2}} \leq B_{1}^{-p_{2}}<1
$$



Figure 1. Diagram for the proof of Lemma 3.3 We plot the function $h$, highlighting the quantities $\alpha_{1}, \quad \alpha_{2}$ and $\left\|\nabla u\left(t^{*}\right)\right\|_{p(.)}^{p_{2}}$ with the corresponding values of the energy $\left(E_{1}, E(0)\right.$ and $E\left(t^{*}\right)$, respectively).

Therefore, recalling the definitions (3.2) and (3.9) of the functions $g$ and $h$, since $p_{1}<p_{2}$, and using (3.8), we can conclude that

$$
h\left(\alpha_{0}\right)=g\left(\alpha_{0}\right) \leq E(0)=h\left(\alpha_{2}\right)
$$

Hence, it follows from Point 1 in Lemma 3.2 that $\alpha_{0} \geq \alpha_{2}$, and 3.11a holds for $t=0$.
To prove 3.11a) for all $t \geq 0$, we argue by contradiction. Suppose that there exists some strictly positive time $t^{*}>0$ such that $\left\|\nabla u\left(t^{*}\right)\right\|_{p(.)}^{p_{2}}<\alpha_{2}$. Then, by the continuity of the $L^{p(.)}$-norm, and since $\alpha_{2}>\alpha_{1}$, we may take $t^{*}$ such that

$$
\alpha_{2}>\left\|\nabla u\left(t^{*}\right)\right\|_{p(.)}^{p_{2}}>\alpha_{1}
$$

Hence, it follows from Lemma 3.2 and (3.8 that

$$
E(0)=h\left(\alpha_{2}\right)<h\left(\left\|\nabla u\left(t^{*}\right)\right\|_{p(.)}^{p_{2}}\right) \leq E\left(t^{*}\right)
$$

This contradicts the fact that the energy $E(t)$ is decreasing, as we proved in Lemma 3.1 Therefore, 3.11a) holds.

Let us now prove 3.11b). At this regard, from the definition of the energy 3.1 , and since $E(t) \leq E(0)$, we obtain

$$
\begin{align*}
\int_{\Omega} \frac{1}{q(.)}|u|^{q(.)} \ln (|u|) \mathrm{d} x & =\int_{\Omega} \frac{1}{p(.)}|\nabla u|^{p(.)} \mathrm{d} x+\int_{\Omega} \frac{1}{q^{2}(.)}|u|^{q(.)} \mathrm{d} x-E(t) \\
& \geq \int_{\Omega} \frac{1}{p(.)}|\nabla u|^{p(.)} \mathrm{d} x-E(0) \\
& \geq \frac{1}{p_{2}} \min \left(\|\nabla u\|_{p(.)}^{p_{2}},\|\nabla u\|_{p(.)}^{p_{1}}\right)-E(0) \\
& \geq \frac{1}{p_{2}} \min \left(\alpha_{2}^{\frac{p_{1}}{p_{2}}}, \alpha_{2}\right)-E(0) \tag{3.12}
\end{align*}
$$

Moreover, since $\alpha_{2} \leq \alpha_{0}<1$ and $p_{1} \leq p_{2}$, we have

$$
\min \left(\alpha_{2}^{\frac{p_{1}}{p_{2}}}, \alpha_{2}\right)=\alpha_{2}
$$

Hence, it follows from (3.9) and 3.12 that

$$
\int_{\Omega} \frac{1}{q(.)}|u|^{q(.)} \ln (|u|) \mathrm{d} x \geq \frac{1}{p_{2}} \alpha_{2}-E(0)=\frac{1}{p_{2}} \alpha_{2}-h\left(\alpha_{2}\right)=\frac{1}{e \sigma q_{1}} B_{1}^{q_{1}+\sigma} \alpha_{2}^{\frac{q_{1}+\sigma}{p_{2}}}
$$

Finally, let us prove 3.11c). To this end, since $E(0)<E_{1}$, recalling the definition of $E_{1}$ given in 2.4c) we can readily check that

$$
\left(\left(q_{1}+\sigma\right)\left(\frac{1}{p_{2}}-\frac{E(0)}{\alpha_{1}}\right)\right)^{\frac{p_{2}}{q_{1}-p_{2}+\sigma}}>\left(\left(q_{1}+\sigma\right)\left(\frac{1}{p_{2}}-\frac{E_{1}}{\alpha_{1}}\right)\right)^{\frac{p_{2}}{q_{1}-p_{2}+\sigma}}=1
$$

Hence, the second inequality in 3.11 c holds. As for the first inequality, we can easily compute

E(0)=h\left(\alpha_{2}\right)=\alpha_{2}\left(\frac{1}{p_{2}}-\frac{1}{e \sigma q_{1}} B_{1}^{q_{1}+\sigma} \alpha_{2}^{\frac{q_{1}+\sigma}{p_{2}}-1}\right)=\alpha_{1} \frac{\alpha_{2}}{\alpha_{1}}\left(\frac{1}{p_{2}}-\frac{1}{e \sigma q_{1}} B_{1}^{q_{1}+\sigma}\left(\frac{\alpha_{2}}{\alpha_{1}}\right)^{\frac{q_{1}+\sigma}{p_{2}}-1} \alpha_{1}^{\frac{q_{1}+\sigma}{p_{2}}-1}\right) .
$$

Recalling the definition of $\alpha_{1}$ given in 2.4a, and since $\alpha_{2}>\alpha_{1}$ we then have that

$$
E(0)=\alpha_{1} \frac{\alpha_{2}}{\alpha_{1}}\left(\frac{1}{p_{2}}-\frac{1}{q_{1}+\sigma}\left(\frac{\alpha_{2}}{\alpha_{1}}\right)^{\frac{q_{1}+\sigma-p_{2}}{p_{2}}}\right) \geq \alpha_{1}\left(\frac{1}{p_{2}}-\frac{1}{q_{1}+\sigma}\left(\frac{\alpha_{2}}{\alpha_{1}}\right)^{\frac{q_{1}+\sigma-p_{2}}{p_{2}}}\right)
$$

Therefore,

$$
\frac{E(0)}{\alpha_{1}} \geq \frac{1}{p_{2}}-\frac{1}{q_{1}+\sigma}\left(\frac{\alpha_{2}}{\alpha_{1}}\right)^{\frac{q_{1}+\sigma-p_{2}}{p_{2}}}
$$

from which it follows immediately that

$$
\frac{\alpha_{2}}{\alpha_{1}} \geq\left(\left(q_{1}+\sigma\right)\left(\frac{1}{p_{2}}-\frac{E(0)}{\alpha_{1}}\right)\right)^{\frac{p_{2}}{q_{1}+\sigma-p_{2}}}
$$

Our proof is then concluded.
Let us define

$$
\begin{equation*}
H(t):=E_{1}-\frac{\sigma \alpha_{1}}{p_{2}\left(q_{1}+\sigma\right)}-E(t), \quad \text { for } t \geq 0 \tag{3.13}
\end{equation*}
$$

We have the following result.
Lemma 3.4. Let $\sigma, \alpha_{1}, B_{1}$ and $E_{1}$ be given as in 2.2, 2.4a, 2.4b and 2.4c), respectively. Assume that the initial value $u_{0}$ is chosen so that

$$
0 \leq E(0)<\frac{p_{2}}{q_{1}+p_{2}}\left(E_{1}-\frac{\sigma \alpha_{1}}{p_{2}\left(q_{1}+\sigma\right)}\right) \quad \text { and } \quad \alpha_{1}<\left\|\nabla u_{0}\right\|_{p(.)}^{p_{2}} \leq B_{1}^{-p_{2}}
$$

Then, the functional $H(t)$ defined in 3.13 satisfies the following estimates:

$$
\begin{equation*}
0<H(0) \leq H(t) \leq \int_{\Omega} \frac{1}{q(.)}|u|^{q(.)} \ln (|u|) \mathrm{d} x, \quad t \geq 0 \tag{3.14}
\end{equation*}
$$

Proof. By Lemma 3.1. we know that $H(t)$ is non-decreasing for all $t \geq 0$. Hence

$$
\begin{equation*}
H(t) \geq H(0)=E_{1}-\frac{\sigma \alpha_{1}}{p_{2}\left(q_{1}+\sigma\right)}-E(0) \tag{3.15}
\end{equation*}
$$

By the definition 3.1 of $E(t)$, we have

$$
\begin{aligned}
H(t) & -\int_{\Omega} \frac{1}{q(.)}|u|^{q(.)} \ln (|u|) \mathrm{d} x \\
& =E_{1}-\frac{\sigma \alpha_{1}}{p_{2}\left(q_{1}+\sigma\right)}-\int_{\Omega} \frac{1}{p(.)}|\nabla u|^{p(.)} d x-\int_{\Omega} \frac{1}{q^{2}(.)}|u|^{q(.)} \mathrm{d} x \\
& <E_{1}-\int_{\Omega} \frac{1}{p(.)}|\nabla u|^{p(.)} \mathrm{d} x .
\end{aligned}
$$

Hence, using 2.4a, 2.4c), 3.11a) and the fact that $\alpha_{2}>\alpha_{1}$, for all $t \geq 0$ we have

$$
\begin{align*}
H(t)-\int_{\Omega} \frac{1}{q(.)}|u|^{q(.)} \ln (|u|) \mathrm{d} x & <E_{1}-\frac{1}{p_{2}} \min \left(\|\nabla u\|_{p(.)}^{p_{2}},\|\nabla u\|_{p(.)}^{p_{1}}\right)  \tag{3.16}\\
& <\left(\frac{1}{p_{2}}-\frac{1}{q_{1}+1}\right) \alpha_{1}-\frac{1}{p_{2}} \alpha_{1}<0 .
\end{align*}
$$

Thus, 3.14 follows immediately from (3.15 and 3.16.
We are now ready to state and prove our main result of this Section, concerning the blow-up of solutions for (1.1).

Theorem 3.5. Let $\sigma, \alpha_{1}, B_{1}$ and $E_{1}$ be given as in 2.2, 2.4a, 2.4b and 2.4c), respectively. Assume that the initial value $u_{0}$ is chosen so that (3.10) holds. Then, the corresponding solution of problem 1.1) will blow-up in finite time $T^{*}$. Furthermore, we have the following upper estimate for $T^{*}$ :

$$
0<T^{*}<\frac{\left\|u_{0}\right\|_{H_{0}^{1}(\Omega)}^{p_{2}}}{\left(\mathcal{B}+p_{2}-2\right)\left(\frac{q_{1}-p_{2}}{q_{1}+\sigma} \alpha_{1}-\left(\mathcal{B}+p_{2}\right) E(0)\right)}
$$

where we have denoted

$$
\begin{equation*}
\mathcal{B}=\mathcal{B}\left(\alpha_{1}, \alpha_{2}, p_{2}, q_{1}, \sigma\right):=\left(q_{1}-p_{2}\right)\left(1-\left(\frac{\alpha_{1}}{\alpha_{2}}\right)^{\frac{\sigma+q_{1}}{p_{2}}}\right)>0 \tag{3.17}
\end{equation*}
$$

with $\alpha_{2}$ as in Lemma 3.3.
Proof. Let us define the function

$$
\varphi(t)=\frac{1}{2} \int_{\Omega} u^{2} \mathrm{~d} x+\frac{1}{2} \int_{\Omega}|\nabla u|^{2} \mathrm{~d} x=\frac{1}{2}\|u\|_{H_{0}^{1}(\Omega)}^{2} .
$$

Then, using (1.1) and integration by parts, the derivative $\varphi^{\prime}(t)$ satisfies

$$
\begin{aligned}
\varphi^{\prime}(t) & =\int_{\Omega} u u_{t} \mathrm{~d} x+\int_{\Omega} \nabla u \cdot \nabla u_{t} \mathrm{~d} x \\
& =\int_{\Omega} u\left(\Delta u_{t}+\operatorname{div}\left(|\nabla u|^{p(.)-2} \nabla u\right)+|u|^{q(.)-2} u \ln (|u|)\right) \mathrm{d} x-\int_{\Omega} u \Delta u_{t} \mathrm{~d} x \\
& =-\int_{\Omega}|\nabla u|^{p(.)} \mathrm{d} x+\int_{\Omega}|u|^{q(.)} \ln (|u|) \mathrm{d} x
\end{aligned}
$$

Recalling the definitions (3.1) and 3.13 of the energy $E(t)$ and the function $H(t)$, from the above identity we can estimate

$$
\begin{align*}
\varphi^{\prime}(t) & \geq-p_{2} E(t)-p_{2} \int_{\Omega} \frac{1}{q(.)}|u|^{q(.)} \ln (|u|) \mathrm{d} x+\int_{\Omega}|u|^{q(.)} \ln (|u|) \mathrm{d} x \\
& \geq-\left(p_{2} E_{1}-\frac{\sigma \alpha_{1}}{q_{1}+\sigma}\right)+p_{2} H(t)+\frac{q_{1}-p_{2}}{q_{1}} \int_{\Omega}|u|^{q(.)} \ln (|u|) \mathrm{d} x . \tag{3.18}
\end{align*}
$$

Moreover, from 2.4a, 2.4c and 3.11 b we have

$$
\begin{align*}
p_{2} E_{1}-\frac{\sigma \alpha_{1}}{q_{1}+\sigma} & =\frac{q_{1}-p_{2}}{q_{1}+\sigma} \alpha_{1}  \tag{3.19}\\
& =\frac{q_{1}-p_{2}}{q_{1}+\sigma} \alpha_{1}^{\frac{q_{1}+\sigma}{p_{2}}} \alpha_{1}^{-\frac{q_{1}-p_{2}+\sigma}{p_{2}}}=\frac{q_{1}-p_{2}}{q_{1}+\sigma} \alpha_{1}^{\frac{q_{1}+\sigma}{p_{2}}}\left(\frac{e \sigma q_{1}}{q_{1}+\sigma} B_{1}^{-\left(q_{1}+\sigma\right)}\right)^{-1} \\
& =\left(\frac{e \sigma q_{1}}{q_{1}+\sigma}\right)^{-1} \frac{q_{1}-p_{2}}{q_{1}+\sigma} B_{1}^{q_{1}+\sigma} \alpha_{1}^{\frac{q_{1}+\sigma}{p_{2}}}=\frac{q_{1}-p_{2}}{q_{1}}\left(\frac{1}{e \sigma} B_{1}^{q_{1}+\sigma} \alpha_{1}^{\frac{q_{1}+\sigma}{p_{2}}}\right) \\
& =\frac{q_{1}-p_{2}}{q_{1}}\left(\frac{\alpha_{1}}{\alpha_{2}}\right)^{\frac{q_{1}+\sigma}{p_{2}}}\left(\frac{1}{e \sigma q_{1}} B_{1}^{q_{1}+\sigma} \alpha_{2}^{\frac{q_{1}+\sigma}{p_{2}}}\right) \\
& \leq \frac{q_{1}-p_{2}}{q_{1}}\left(\frac{\alpha_{1}}{\alpha_{2}}\right)^{\frac{q_{1}+\sigma}{p_{2}}} \int_{\Omega}|u|^{q(.)} \ln (|u|) \mathrm{d} x .
\end{align*}
$$

Then, it follows (3.18) and 3.19 that

$$
\begin{equation*}
\varphi^{\prime}(t) \geq \frac{q_{1}-p_{2}}{q_{1}}\left(1-\left(\frac{\alpha_{1}}{\alpha_{2}}\right)^{\frac{q_{1}+\sigma}{p_{2}}}\right) \int_{\Omega}|u|^{q(.)} \ln (|u|) \mathrm{d} x+p_{2} H(t) \tag{3.20}
\end{equation*}
$$

Besides, using $(2.2)$, we can readily check that

$$
\begin{equation*}
\zeta:=\frac{q_{1}-p_{2}}{q_{1}}\left(1-\left(\frac{\alpha_{1}}{\alpha_{2}}\right)^{\frac{q_{1}+\sigma}{p_{2}}}\right)>0 \tag{3.21}
\end{equation*}
$$

Now, let us define the function

$$
\begin{equation*}
\psi(t):=-\zeta q_{1} E(t)+p_{2} H(t) \tag{3.22}
\end{equation*}
$$

Then, using (3.5) and (3.13), we have

$$
\begin{align*}
\psi^{\prime}(t) & =-\zeta q_{1} E^{\prime}(t)+p_{2} H^{\prime}(t)  \tag{3.23}\\
& =-\left(\zeta q_{1}+p_{2}\right) E^{\prime}(t)=\left(\zeta q_{1}+p_{2}\right) \int_{\Omega}\left(\left|u_{t}\right|^{2}+\left|\nabla u_{t}\right|^{2}\right) \mathrm{d} x>0
\end{align*}
$$

Hence, using Cauchy-Schwarz's inequality, we obtain

$$
\begin{align*}
\varphi(t) \psi^{\prime}(t) & =\frac{\zeta q_{1}+p_{2}}{2}\left[\int_{\Omega}\left(|u|^{2}+|\nabla u|^{2}\right) \mathrm{d} x\right]\left[\int_{\Omega}\left(\left|u_{t}\right|^{2}+\left|\nabla u_{t}\right|^{2}\right) \mathrm{d} x\right] \\
& \geq \frac{\zeta q_{1}+p_{2}}{2}\left(\int_{\Omega} u u_{t} \mathrm{~d} x+\int_{\Omega} \nabla u \nabla u_{t} \mathrm{~d} x\right)^{2} \\
& =\frac{\zeta q_{1}+p_{2}}{2} \varphi^{\prime}(t)^{2} \tag{3.24}
\end{align*}
$$

Since, by definition, $\zeta<1$, we have from 3.10 that

$$
E(0)<\frac{p_{2}}{q_{1}+p_{2}}\left(E_{1}-\frac{\sigma \alpha_{1}}{p_{2}\left(q_{1}+\sigma\right)}\right)<\frac{p_{2}}{\zeta q_{1}+p_{2}}\left(E_{1}-\frac{\sigma \alpha_{1}}{p_{2}\left(q_{1}+\sigma\right)}\right) .
$$

Hence, we obtain that

$$
\begin{align*}
\psi(0) & =-\zeta q_{1} E(0)+p_{2} H(0)  \tag{3.25}\\
& =-\left(\zeta q_{1}+p_{2}\right) E(0)+p_{2}\left(E_{1}-\frac{\sigma \alpha_{1}}{p_{2}\left(q_{1}+\sigma\right)}\right)>0
\end{align*}
$$

which, thanks to (3.23), yields $\psi(t)>0$ for all $t \geq 0$. Moreover, from 3.20 and (3.22) it is easy to check that $\varphi^{\prime}(t) \geq \psi(t)$. Hence from 3.24 , we get

\varphi(t) \psi^{\prime}(t) \geq \frac{\zeta q_{1}+p_{2}}{2} \varphi^{\prime}(t) \psi(t)
$$

which can be written as

\frac{\psi^{\prime}(t)}{\psi(t)} \geq \frac{\zeta q_{1}+p_{2}}{2} \frac{\varphi^{\prime}(t)}{\varphi(t)} \tag{3.26}
\end{equation*}
$$

Integrating (3.26) from 0 to $t$ and using (3.22), we have

\frac{\varphi^{\prime}(t)}{\varphi(t)^{\frac{\zeta q_{1}+p_{2}}{2}}} \geq \frac{\psi(0)}{\varphi(0)^{\frac{\zeta q_{1}+p_{2}}{2}}} \tag{3.27}
\end{equation*}
$$

Integrating also (3.27) from 0 to $t$, we obtain

$$
-\left.\frac{2}{\zeta q_{1}+p_{2}-2} \varphi(s)^{-\frac{\zeta q_{1}+p_{2}}{2}-1}\right|_{s=0} ^{s=t} \geq \frac{\psi(0)}{\varphi(0)^{\frac{\zeta q_{1}+p_{2}}{2}}} t
$$

that is,

$$
\frac{1}{\varphi(t)^{\frac{\zeta q_{1}+p_{2}-2}{2}}} \leq \frac{1}{\varphi(0)^{\frac{\zeta q_{1}+p_{2}-2}{2}}}-\frac{\zeta q_{1}+p_{2}-2}{2} \frac{\psi(0)}{\varphi(0)^{\frac{\zeta q_{1}+p_{2}}{2}}} t
$$

From the above inequality, by means of some easy algebraic manipulations, we finally get

$$
\varphi(t)^{\frac{\zeta q_{1}+p_{2}-2}{2}} \geq \frac{\varphi(0)^{\frac{\zeta q_{1}+p_{2}}{2}}}{\varphi(0)-\frac{\zeta q_{1}+p_{2}-2}{2} \psi(0) t}
$$

Let

Then

$$
\varphi(0)-\frac{\zeta q_{1}+p_{2}-2}{2} \psi(0) T^{*}=0
$$

yielding the blowing-up of $\varphi(t)$ at time $T^{*}$. By definition of $\varphi$, we can then conclude that $u(x, t)$ blows-up in $H_{0}^{1}(\Omega)$-norm at $t=T^{*}$.

Finally, notice that by means of (3.17), 3.21) and (3.25), and recalling the definition of $\varphi$, we can easily obtain from 3.28

$$
T^{*}=\frac{\left\|u_{0}\right\|_{H_{0}^{1}(\Omega)}^{2}}{\left(\mathcal{B}+p_{2}-2\right)\left(\frac{q_{1}-p_{2}}{q_{1}+\sigma} \alpha_{1}-\left(\mathcal{B}+p_{2}\right) E(0)\right)}
$$

This concludes our proof.

## 4. NON-BLOW-UP CASE

In this section, we present some non blow-up conditions for the solution of 1.1. In particular, we are going to show that, when the initial datum $u_{0}$ is small enough in $H_{0}^{1}(\Omega)$, blow-up cannot manifest at any time $t \geq 0$. In addition to that, we will also provide explicit time-decay estimates for the $H_{0}^{1}(\Omega)$-norm of the solution.

In order to state our main result in this section, let us denote with $\lambda_{1}$ the first eigenvalue of the Dirichlet Laplacian on $\Omega$ and introduce the following constants

$$
\begin{equation*}
\mathrm{A}=|\Omega|^{\frac{2-p_{1}}{2}}\left(\frac{\lambda_{1}}{2\left(\lambda_{1}+1\right)}\right)^{\frac{p_{1}}{2}}, \quad \mathrm{~B}=\frac{4}{e \sigma} B_{\sigma} \mathcal{C}_{1}^{q_{1}+\sigma}, \quad \mathrm{C}=\frac{4}{e \sigma} B_{\sigma} \mathcal{C}_{2}^{q_{2}+\sigma} \tag{4.1}
\end{equation*}
$$

In (4.1), $\mathcal{C}_{1}, \mathcal{C}_{2}>0$, are the best embedding constants of $H_{0}^{1}(\Omega)$ into $W_{0}^{1, q_{1}+\sigma}(\Omega)$ and $W_{0}^{1, q_{2}+\sigma}(\Omega)$, respectively. Moreover, $\sigma$ is defined as in 2.2 and $B_{\sigma}$ is the constant introduced in 2.3) for the embedding $W_{0}^{1, p(.)}(\Omega) \hookrightarrow L^{q(.)+\sigma}(\Omega)$. We then have the following non blow-up result for the weak solutions of 1.1.
Theorem 4.1. Let $u_{0} \in W_{0}^{1, p(.)}(\Omega)$ satisfy

$$
\begin{equation*}
\left\|u_{0}\right\|_{H_{0}^{1}(\Omega)}<\min \left(\left(\frac{\mathrm{A}}{2 \mathrm{~B}}\right)^{\frac{1}{q_{1}-p_{1}+\sigma}},\left(\frac{\mathrm{A}}{2 \mathrm{C}}\right)^{\frac{1}{q_{2}-p_{1}+\sigma}}\right) \tag{4.2}
\end{equation*}
$$

where the constants A, B and C have been defined in 4.1. Then, the corresponding weak solution $u$ of (1.1) cannot blow-up in $H_{0}^{1}(\Omega)$-norm, and the following decay estimates hold

$$
\begin{align*}
& \|u(t)\|_{H_{0}^{1}(\Omega)} \leq\left(\frac{4}{\mathrm{~A}\left(p_{1}-2\right) t+4\left\|u_{0}\right\|_{H_{0}^{1}(\Omega)}^{2-p_{1}}}\right)^{\frac{1}{p_{1}-2}}, \quad \text { if } p_{1}>2  \tag{4.3a}\\
& \|u(t)\|_{H_{0}^{1}(\Omega)} \leq\left(\frac{A\left\|u_{0}\right\|_{H_{0}^{1}(\Omega)}^{q_{1}-2+\sigma}}{\mathrm{A}-B\left\|u_{0}\right\|_{H_{0}^{1}(\Omega)}^{q_{1}-2+\sigma}}\right)^{\frac{1}{q_{1}-2+\sigma}} e^{-\frac{A}{2} t}, \quad \text { if } p_{1}=2 . \tag{4.3b}
\end{align*}
$$

Proof. Define the auxiliary function

$$
\begin{equation*}
\theta(t):=2 \varphi(t)=\int_{\Omega} u^{2} \mathrm{~d} x+\int_{\Omega}|\nabla u|^{2} \mathrm{~d} x=\|u\|_{H_{0}^{1}(\Omega)}^{2} \tag{4.4}
\end{equation*}
$$

We then have from (1.1) and integration by parts that

$$
\begin{equation*}
\theta^{\prime}(t)=2 \int_{\Omega} u u_{t} \mathrm{~d} x+2 \int_{\Omega} \nabla u \nabla u_{t} \mathrm{~d} x=-2 \int_{\Omega}|\nabla u|^{p(.)} \mathrm{d} x+2 \int_{\Omega}|u|^{q(.)} \ln (|u|) \mathrm{d} x . \tag{4.5}
\end{equation*}
$$

For any $t>0$, we split the domain $\Omega$ into $\Omega=\Omega_{1} \cup \Omega_{2}$ with

$$
\Omega_{1}:=\{x \in \Omega:|\nabla u(x, t)|<1\} \quad \text { and } \quad \Omega_{2}=\{x \in \Omega:|\nabla u(x, t)| \geq 1\}
$$

We then have

$$
\begin{align*}
\int_{\Omega}|\nabla u|^{p(.)} \mathrm{d} x & =\int_{\Omega_{1}}|\nabla u|^{p(.)} \mathrm{d} x+\int_{\Omega_{2}}|\nabla u|^{p(.)} \mathrm{d} x \\
& \geq \int_{\Omega_{1}}|\nabla u|^{p_{2}} \mathrm{~d} x+\int_{\Omega_{2}}|\nabla u|^{p_{1}} \mathrm{~d} x \geq \int_{\Omega_{2}}|\nabla u|^{p_{1}} \mathrm{~d} x .  \tag{4.6a}\\
\int_{\Omega}|\nabla u|^{\rho+\sigma} \mathrm{d} x & =\int_{\Omega_{1}}|\nabla u|^{\rho+\sigma} \mathrm{d} x+\int_{\Omega_{2}}|\nabla u|^{\rho+\sigma} \mathrm{d} x \leq 2 \int_{\Omega_{2}}|\nabla u|^{\rho+\sigma} \mathrm{d} x . \tag{4.6b}
\end{align*}
$$

Using (2.3, (3.7), 4.6a and 4.6b, from 4.5 we can then estimate

$$
\begin{align*}
\theta^{\prime}(t) & \leq-2 \int_{\Omega_{2}}|\nabla u|^{p_{1}} \mathrm{~d} x+\frac{2}{e \sigma} \int_{\Omega}|u|^{q(.)+\sigma} \mathrm{d} x  \tag{4.7}\\
& \leq-2 \int_{\Omega_{2}}|\nabla u|^{p_{1}} \mathrm{~d} x+\frac{2}{e \sigma} B_{\sigma} \int_{\Omega}|\nabla u|^{q(.)+\sigma} \mathrm{d} x \\
& \leq-2 \int_{\Omega_{2}}|\nabla u|^{p_{1}} \mathrm{~d} x+\frac{2}{e \sigma} B_{\sigma}\left(\int_{\Omega_{1}}|\nabla u|^{q_{1}+\sigma} \mathrm{d} x+\int_{\Omega_{2}}|\nabla u|^{q_{2}+\sigma} \mathrm{d} x\right) \\
& \leq-2 \int_{\Omega_{2}}|\nabla u|^{p_{1}} \mathrm{~d} x+\frac{4}{e \sigma} B_{\sigma}\left(\int_{\Omega_{2}}|\nabla u|^{q_{1}+\sigma} \mathrm{d} x+\int_{\Omega_{2}}|\nabla u|^{q_{2}+\sigma}, \mathrm{d} x\right)
\end{align*}
$$

By Hölder's inequality, we have

$$
|\Omega|^{\frac{2-p_{1}}{2}}\left(\int_{\Omega_{2}}|\nabla u|^{2} \mathrm{~d} x\right)^{\frac{p_{1}}{2}} \leq \int_{\Omega_{2}}|\nabla u|^{p_{1}} \mathrm{~d} x
$$

while the Poincaré's inequality gives

$$
\int_{\Omega}|\nabla u|^{2} \mathrm{~d} x \geq \lambda_{1} \int_{\Omega}|u|^{2} \mathrm{~d} x
$$

where $\lambda_{1}$ is the first eigenvalue of the Dirichlet Laplacian on $\Omega$. Thus 4.4) satisfies the following inequality

$$
\begin{aligned}
\theta(t) & \leq\left(\frac{1}{\lambda_{1}}+1\right) \int_{\Omega}|\nabla u|^{2} \mathrm{~d} x \\
& =\left(\frac{1}{\lambda_{1}}+1\right) \int_{\Omega_{1}}|\nabla u|^{2} \mathrm{~d} x+\left(\frac{1}{\lambda_{1}}+1\right) \int_{\Omega_{2}}|\nabla u|^{2} \mathrm{~d} x \leq 2 \frac{\lambda_{1}+1}{\lambda_{1}} \int_{\Omega_{2}}|\nabla u|^{2} \mathrm{~d} x
\end{aligned}
$$

Moreover, from the Sobolev embedding we have

$$
\begin{aligned}
\int_{\Omega_{2}}|\nabla u|^{q_{1}+\sigma} \mathrm{d} x+\int_{\Omega_{2}}|\nabla u|^{q_{2}+\sigma} \mathrm{d} x & \leq \int_{\Omega}|\nabla u|^{q_{1}+\sigma} \mathrm{d} x+\int_{\Omega}|\nabla u|^{q_{2}+\sigma} \mathrm{d} x \\
& \leq C_{1}^{q_{1}+\sigma} \theta(t)^{\frac{q_{1}+\sigma}{2}}+C_{2}^{q_{2}+\sigma} \theta(t)^{\frac{q_{2}+\sigma}{2}}
\end{aligned}
$$

Thus, 4.7) gives

$$
\begin{align*}
\theta^{\prime}(t) & \leq-2|\Omega|^{\frac{2-p_{1}}{2}}\left(\frac{\lambda_{1}}{2\left(\lambda_{1}+1\right)}\right)^{\frac{p_{1}}{2}} \theta(t)^{\frac{p_{1}}{2}}+\frac{4}{e \sigma} B_{\sigma}\left(C_{1}^{q_{1}+\sigma} \theta(t)^{\frac{q_{1}+\sigma}{2}}+C_{2}^{q_{2}+\sigma} \theta(t)^{\frac{q_{2}+\sigma}{2}}\right) \\
& =-\theta(t)^{\frac{p_{1}}{2}}\left(\mathrm{~A}-\mathrm{B} \theta(t)^{\frac{q_{1}-p_{1}+\sigma}{2}}\right)-\theta(t)^{\frac{p_{1}}{2}}\left(\mathrm{~A}-\mathrm{C} \theta(t)^{\frac{q_{2}-p_{1}+\sigma}{2}}\right) \tag{4.8}
\end{align*}
$$

We now claim that

$$
\begin{equation*}
\theta(t)<\min \left(\left(\frac{\mathrm{A}}{2 \mathrm{~B}}\right)^{\frac{2}{q_{1}-p_{1}+\sigma}},\left(\frac{\mathrm{A}}{2 \mathrm{C}}\right)^{\frac{2}{q_{2}-p_{1}+\sigma}}\right), \quad \text { for all } t \geq 0 \tag{4.9}
\end{equation*}
$$

Indeed, if we suppose (4.9) is not satisfied, by the continuity of $\theta(t)$ and 4.2 , there exists $t_{0}>0$ such that

$$
\begin{equation*}
\theta\left(t_{0}\right)=\min \left(\left(\frac{\mathrm{A}}{2 \mathrm{~B}}\right)^{\frac{2}{q_{1}-p_{1}+\sigma}},\left(\frac{\mathrm{A}}{2 \mathrm{C}}\right)^{\frac{2}{q_{2}-p_{1}+\sigma}}\right) \tag{4.10}
\end{equation*}
$$

and

$$
\begin{equation*}
\theta(t)<\min \left(\left(\frac{\mathrm{A}}{2 \mathrm{~B}}\right)^{\frac{2}{q_{1}-p_{1}+\sigma}},\left(\frac{\mathrm{A}}{2 \mathrm{C}}\right)^{\frac{2}{q_{2}-p_{1}+\sigma}}\right) \quad \text { for } 0 \leq t<t_{0} \tag{4.11}
\end{equation*}
$$

Since we are assuming in 4.2 that

$$
\theta(0)<\min \left(\left(\frac{\mathrm{A}}{2 \mathrm{~B}}\right)^{\frac{2}{q_{1}-p_{1}+\sigma}},\left(\frac{\mathrm{A}}{2 \mathrm{C}}\right)^{\frac{2}{q_{2}-p_{1}+\sigma}}\right)
$$

we get from 4.10 that $\theta^{\prime}(t)>0$ for $0<t<t_{0}$. On the other hand, 4.8) and 4.11) implies that $\theta^{\prime}(t)<0$ for $0<t<t_{0}$. We then found a contradiction, meaning that 4.9 holds. In particular, we have that $\theta^{\prime}(t)<0$ for all $t \geq 0$. Hence, the $H_{0}^{1}(\Omega)$-norm of the solution to (1.1) decays in time and cannot blow-up.

To obtain the decay estimates 4.3a and 4.3b, without losing generality let us assume that $\theta(t) \neq 0$ for all $t \geq 0$. We are allowed to do that because, if there exists $t_{0} \geq 0$ such that $\theta\left(t_{0}\right)=0$ then, since $\theta(t)$ is non-negative and decreasing for all $t \geq 0$, we would also have

$$
\theta(t)=0 \quad \text { for all } t \geq t_{0}
$$

and 4.3a and 4.3b would be trivially satisfied.
If, on the other hand, $\theta(t) \neq 0$ for all $t \geq 0$, then from the differential inequality 4.8 and 4.9 we can write

$$
\begin{equation*}
1 \leq-\frac{\theta^{\prime}(t)}{\theta(t)^{\frac{p_{1}}{2}}\left(\mathrm{~A}-\mathrm{B} \theta(t)^{\frac{q_{1}-p_{1}+\sigma}{2}}\right)} . \tag{4.12}
\end{equation*}
$$

We shall now distinguish two cases:
Case 1: $p_{1}>2$. Integrating 4.12 over the interval $(0, t)$, and taking into account that $\theta(t) \leq \theta(0)$ for all $t \geq 0$, we obtain

$$
\begin{equation*}
t \leq-\int_{\theta(0)}^{\theta(t)} \frac{d \gamma}{\gamma^{\frac{p_{1}}{2}}\left(\mathrm{~A}-\mathrm{B} \gamma^{\frac{q_{1}-p_{1}+\sigma}{2}}\right)}=\int_{\theta(t)}^{\theta(0)} \frac{d \gamma}{\gamma^{\frac{p_{1}}{2}}\left(\mathrm{~A}-\mathrm{B} \gamma^{\frac{q_{1}-p_{1}+\sigma}{2}}\right)} \tag{4.13}
\end{equation*}
$$

which is equivalent to

$$
\begin{equation*}
t \leq \frac{1}{\mathrm{~A}} \int_{\theta(t)}^{\theta(0)}\left(\frac{1}{\gamma^{\frac{p_{1}}{2}}}+\frac{\mathrm{B} \gamma^{\frac{q_{1}-p_{1}+\sigma}{2}}}{\gamma^{\frac{p_{1}}{2}}\left(\mathrm{~A}-\mathrm{B} \gamma^{\frac{q_{1}-p_{1}+\sigma}{2}}\right)}\right) d \gamma \tag{4.14}
\end{equation*}
$$

Moreover, since by (4.9) we have

$$
\frac{\mathrm{B} \gamma^{\frac{q_{1}-p_{1}+\sigma}{2}}}{\mathrm{~A}-\mathrm{B} \gamma^{\frac{q_{1}-p_{1}+\sigma}{2}}} \leq 1 \quad \text { for all } \gamma \in[\theta(t), \theta(0)]
$$

we obtain from 4.14 that

$$
\begin{aligned}
t & \leq \frac{2}{\mathrm{~A}} \int_{\theta(t)}^{\theta(0)} \frac{d \gamma}{\gamma^{\frac{p_{1}}{2}}}=\frac{4}{A\left(2-p_{1}\right)}\left(\theta(0)^{\frac{2-p_{1}}{2}}-\theta(t)^{\frac{2-p_{1}}{2}}\right) \\
& =\frac{4}{A\left(2-p_{1}\right)}\left(\left\|u_{0}\right\|^{2-p_{1}}-\|u(., t)\|^{2-p_{1}}\right)
\end{aligned}
$$

From the above inequality, 4.3a easily follows by means of simple algebraic manipulations.
Case 2: $p_{1}=2$. When $p_{1}=2$, we obtain from 4.13 that

$$
\begin{equation*}
t \leq \int_{\theta(t)}^{\theta(0)} \frac{d \gamma}{\gamma\left(\mathrm{~A}-\mathrm{B} \gamma^{\frac{q_{1}-2+\sigma}{2}}\right)} \tag{4.15}
\end{equation*}
$$

For simplicity of notation, we shall denote

$$
\begin{equation*}
\varpi:=\frac{q_{1}-2+\sigma}{2} . \tag{4.16}
\end{equation*}
$$

Then if we introduce the change of variables $\xi=\gamma^{\varpi}$, we can compute

$$
\begin{align*}
\int_{\theta(t)}^{\theta(0)} \frac{d \gamma}{\gamma\left(\mathrm{~A}-\mathrm{B} \gamma^{\varpi}\right)} & =\frac{1}{\varpi} \int_{\theta(t)^{\varpi}}^{\theta(0)^{\varpi}} \frac{d \xi}{\xi(\mathrm{~A}-\mathrm{B} \xi)}  \tag{4.17}\\
& =\frac{1}{\mathrm{~A} \varpi} \ln \left(\frac{\theta(0)^{\varpi}}{\mathrm{A}-\mathrm{B} \theta(0)^{\varpi}} \frac{\mathrm{A}-\mathrm{B} \theta(t)^{\varpi}}{\theta(t)^{\varpi}}\right)
\end{align*}
$$

We then get from 4.15 and 4.17 that

$$
\frac{\theta(t)^{\varpi}}{\mathrm{A}-\mathrm{B} \theta(t)^{\varpi}} \leq \frac{\theta(0)^{\varpi}}{\mathrm{A}-\mathrm{B} \theta(0)^{\varpi}} e^{-\mathrm{A} \varpi t}
$$

Since by (4.2) we have

$$
\mathrm{A}-\mathrm{B} \theta(t)^{\varpi}>0
$$

we then obtain that

$$
\theta(t)^{\varpi} \leq\left(\frac{\mathrm{A} \theta(0)^{\varpi}}{\mathrm{A}-\mathrm{B} \theta(0)^{\varpi}}-\frac{\mathrm{B} \theta(0)^{\varpi}}{\mathrm{A}-\mathrm{B} \theta(0)^{\varpi}} \theta(t)^{\varpi}\right) e^{-\mathrm{A} \varpi t} \leq \frac{\mathrm{A} \theta(0)^{\varpi}}{\mathrm{A}-\mathrm{B} \theta(0)^{\varpi}} e^{-\mathrm{A} \varpi t}
$$

Hence

$$
\theta(t) \leq\left(\frac{\mathrm{A} \theta(0)^{\varpi}}{\mathrm{A}-\mathrm{B} \theta(0)^{\varpi}}\right)^{\frac{1}{\varpi}} e^{-\mathrm{A} t}
$$

Since, by definition, $\theta(t)=\|u\|_{H_{0}^{1}(\Omega)}^{2}, 4.3 \mathrm{~b}$ follows immediately from the above estimate and 4.16). Our proof is then concluded.

## 5. Numerical study

In this section, we address a 2D numerical illustration of the problem

$$
\begin{cases}u_{t}-\Delta u_{t}-\operatorname{div}\left(|\nabla u|^{p(x, y)-2} \nabla u\right)=|u|^{q(x, y)-2} u \ln (|u|), & (x, y, t) \in \Omega \times(0, T)  \tag{5.1}\\ u(x, y, t)=0, & (x, y, t) \in \partial \Omega \times(0, T) \\ u(x, y, 0)=u_{0}(x, y) \neq 0, & (x, y) \in \Omega\end{cases}
$$

where $T>0$ and $u$ represents the velocity of a fluid in the domain $\Omega=[-1,1]^{2}$.
Our objective is to represent numerically the decay rate obtained in Theorem4.1 in the case $p>2$. To this end, let us start by introducing the numerical scheme that we will employ for our experiments. First of all, for $n \in \mathbb{N}$, let us consider the uniform time-mesh

$$
t_{n}=n \delta t, \quad \delta t=\frac{T}{n}
$$

and define

$$
\begin{aligned}
& u^{n}=u^{n}(x, y):=u\left(x, y, t_{n}\right) \\
& u_{t}^{n+1}:=\frac{u^{n+1}-u^{n}}{\Delta t}
\end{aligned}
$$

We then approximate (5.1) through

$$
\begin{cases}u_{t}^{n+1}-\Delta u_{t}^{n+1}-\operatorname{div}\left(\left|\nabla u^{n}\right|^{p-2} \nabla u^{n}\right)=\left|u^{n}\right|^{q-2} u^{n} \ln \left(\left|u^{n}\right|\right) & \text { in } \Omega  \tag{5.2}\\ u^{n}=0 & \text { on } \partial \Omega \\ u^{0}=u_{0}, & \text { in } \Omega\end{cases}
$$

For the space-discretization, we use $\mathcal{P}_{1}$ Lagrangian Finite Elements implemented through the software FreeFem++ [52]. To this end, we define a triangular mesh $\mathcal{M}_{h}$ of mesh-size $h$ over the domain $\Omega$, composed by

5000 triangles and 2601 vertices. Let $\mathcal{V}_{h}$ be the corresponding space of piece-wise linear continuous functions. Then, approximating $\left(5.2\right.$ amounts at solving the following fully-discrete problem: find $u_{h}^{n} \in \mathcal{V}_{h}$ such that

$$
\begin{equation*}
\int_{\Omega}\left[u_{h, t}^{n+1} \omega+\nabla u_{h, t}^{n+1} \cdot \nabla \omega+\left|\nabla u_{h}^{n}\right|^{p(x, y)-2} \nabla u_{h}^{n} \cdot \nabla \omega\right] \mathrm{d} x \mathrm{~d} y=\int_{\Omega}\left|u_{h}^{n}\right|^{q(x, y)-2} u_{h}^{n} \ln \left(\left|u_{h}^{n}\right|\right) \omega \mathrm{d} x \mathrm{~d} y \tag{5.3}
\end{equation*}
$$

In what follows, we consider the variable exponents

$$
p(x, y)=0.2 \| x\rfloor \mid+2.5 \quad \text { and } \quad q(x, y)=0.1|\lfloor x\rfloor|+6
$$

where $\lfloor$.$\rfloor denotes the greatest integer function, so that$

1. $2<2.5=p_{1}<p_{2}=2.7<6=q_{1}<q_{2}=6.1<p^{*}(x, y)=+\infty$.
2. Condition 2.2 is verified for all $\sigma>0$. In what follows, we will take $\sigma=0.1$.

Moreover, we select the initial datum

$$
u_{0}(x, y)=0.25 e^{-x^{2}-y^{2}}
$$

whose $H_{0}^{1}(\Omega)$-norm is

$$
\left\|u_{0}\right\|_{H_{0}^{1}(\Omega)}=\left(\left\|u_{0}\right\|_{L^{2}(\Omega)}^{2}+\left\|\nabla u_{0}\right\|_{L^{2}(\Omega)}^{2}\right)^{\frac{1}{2}} \sim 0.477344
$$

Finally, the time horizon for our simulations will be $T=1$.
Let us now present the results of our numerical experiments. First of all, we can see in Table 1 and Figure 2 that, with this particular choice of the initial datum and variable exponents, the condition 4.2), i.e.

$$
\left\|u_{0}\right\|_{H_{0}^{1}(\Omega)}<\min \left(\left(\frac{\mathrm{A}}{2 \mathrm{~B}}\right)^{\frac{1}{q_{1}-p_{1}+\sigma}},\left(\frac{\mathrm{A}}{2 \mathrm{C}}\right)^{\frac{1}{q_{2}-p_{1}+\sigma}}\right)=: \mathrm{M}
$$

is satisfied.

| $t_{n}$ | 0 | 0.1 | 0.2 | 0.3 | 0.4 | 0.5 |
| :---: | :---: | :---: | :---: | :---: | :---: | :---: |
| M | 0.671566 | 0.671906 | 0.672586 | 0.673228 | 0.673835 | 0.674407 |
| $t_{n}$ | 0.6 | 0.7 | 0.8 | 0.9 | 1 |  |
| M | 0.674946 | 0.675454 | 0.675932 | 0.676382 | 0.676804 |  |

Table 1. Values of M for $t \in[0,1]$.

Hence, according to Theorem 4.1 the solution to (5.1) is expected to decay in $H_{0}^{1}(\Omega)$-norm at the rate 4.3a, i.e.

$$
\left\|u_{h}^{n}\right\|_{H_{0}^{1}(\Omega)} \leq\left(\frac{4}{\mathrm{~A}\left(p_{1}-2\right) t_{n}+4\left\|u_{0}\right\|_{H_{0}^{1}(\Omega)}^{2-p_{1}}}\right)^{\frac{1}{p_{1}-2}}=: \delta
$$

This is precisely what we can observe in Table 2 and Figures 3.4.

All this confirms numerically the validity of our theoretical results presented in Section 4
