# REGULARITY FOR ORLICZ PHASE PROBLEMS

Abstract. We provide comprehensive regularity results and optimal conditions for a general class of functionals involving Orlicz multi-phase of the type

$$
\begin{equation*}
v \mapsto \int_{\Omega} F(x, v, D v) d x \tag{0.1}
\end{equation*}
$$

exhibiting non-standard growth conditions and non-uniformly elliptic properties
The model functional under consideration is given by the Orlicz multi-phase integral

$$
\begin{equation*}
v \mapsto \int_{\Omega} f(x, v)\left[G(|D v|)+\sum_{k=1}^{N} a_{k}(x) H_{k}(|D v|)\right] d x, \quad N \geqslant 1 \tag{0.2}
\end{equation*}
$$

where $G, H_{k}$ are $N$-functions and $0 \leqslant a_{k}(\cdot) \in L^{\infty}(\Omega)$ with $0<\nu \leqslant f(\cdot) \leqslant L$. Its ellipticity ratio varies according to the geometry of the level sets $\left\{a_{k}(x)=0\right\}$ of the modulating coefficient functions $a_{k}(\cdot)$ for every $k \in\{1, \ldots, N\}$.

We give a unified treatment to show various regularity results for such multi-phase problems with the coefficient functions $\left\{a_{k}(\cdot)\right\}_{k=1}^{N}$ not necessarily Hölder continuous even for a lower level of the regularity. Moreover, assuming that minima of the functional in (0.2) belong to better spaces such as $C^{0, \gamma}(\Omega)$ or $L^{\kappa}(\Omega)$ for some $\gamma \in(0,1)$ and $\kappa \in(1, \infty]$, we address optimal conditions on nonlinearity for each variant under which we build comprehensive regularity results.

On the other hand, since there is a lack of homogeneity properties in the nonlinearity, we consider an appropriate scaling with keeping the structures of the problems under which we apply Harmonic type approximation in the setting varying on the a priori assumption on minima. We believe that the methods and proofs developed in this paper are suitable to build regularity theorems for a larger class of non-autonomous functionals.

## 1. Introduction

We aim to provide optimal and comprehensive regularity results for minimizers of functionals featuring a non-standard growth and a non-uniform ellipticity. The primary model case in mind under investigation is given by an Orlicz multi-phase functional

$$
\begin{equation*}
W^{1,1}(\Omega) \ni v \mapsto \mathcal{P}(v, \Omega):=\int_{\Omega} \Psi(x,|D v|) d x \tag{1.1}
\end{equation*}
$$

for a bounded open domain $\Omega \subset \mathbb{R}^{n}$ with $n \geqslant 2$, where throughout the paper we shall denote by

$$
\begin{equation*}
\Psi(x, t):=G(t)+a(x) H_{a}(t)+b(x) H_{b}(t) \quad(x \in \Omega, t \geqslant 0) \tag{1.2}
\end{equation*}
$$

for functions $G, H_{a}, H_{b} \in \mathcal{N}$ in the sense of Definition 2.1 and $0 \leqslant a(\cdot), b(\cdot) \in L^{\infty}(\Omega)$. The Orlicz multi-phase functional $\mathcal{P}$ in (1.1) is naturally defined for functions $v \in W^{1,1}(\Omega)$, which is a considerable one including the following examples of functionals for the regularity theory:

1. $p$-growth: $\Psi(x, t):=t^{p}, \quad p>1$, see for instance $[49,52,63,64,66,67,84,85]$.
2. Orlicz growth: $\Psi(x, t):=G(t)$, see for instance $[8,24,42,43,65]$.
3. $(p, q)$-double phase: $\Psi(x, t):=t^{p}+a(x) t^{q}$ for $1<p \leqslant q$, see for instance $[11,13,30,31,32,35]$.
4. Borderline case of double phase: $\Psi(x, t):=t^{p}+a(x) t^{p} \log (1+t)$ for $1<p$, see for instance [12, 21].
5. Multi-phase: $\Psi(x, t):=t^{p}+a(x) t^{q}+b(x) t^{s}$ for $1<p \leqslant q, s$, see for instance [7, 38].
6. Orlicz double phase: $\Psi(x, t):=G(t)+a(x) H_{a}(t)$, see for instance [6, 22].
7. Orlicz multi-phase: $\Psi(x, t):=G(t)+a(x) H_{a}(t)+b(x) H_{b}(t)$, see for instance [7].

Over last several years a systematic analysis of the functionals aforementioned has been an object of intensive studies for the regularity theory. Among them the $(p, q)$-double phase functional is a significant example given by

\begin{equation*}
W^{1,1}(\Omega) \ni v \mapsto \mathcal{P}_{p, q}(v, \Omega):=\int_{\Omega}\left[|D v|^{p}+a(x)|D v|^{q}\right] d x, \quad 1<p \leqslant q \tag{1.3}
\end{equation*}
$$

Another example is the so-called borderline case of double phase defined by

$$
\begin{equation*}
W^{1,1}(\Omega) \ni v \mapsto \mathcal{P}_{\log }(v, \Omega):=\int_{\Omega}\left[|D v|^{p}+a(x)|D v|^{p} \log (1+|D v|)\right] d x, \quad 1<p \tag{1.4}
\end{equation*}
$$

The last functional we would like to single out is the so-called multi-phase functional introduced in [38] is of type

$$
\begin{equation*}
W^{1,1}(\Omega) \ni v \mapsto \mathcal{P}_{p, q, s}(v, \Omega):=\int_{\Omega}\left[|D v|^{p}+a(x)|D v|^{q}+b(x)|D v|^{s}\right] d x, \quad 1<p \leqslant q, s \tag{1.5}
\end{equation*}
$$

The $(p, q)$-double phase functional was initially introduced by Zhikov [86, 87, 90] in order to study the feature of strongly anisotropic materials in the context of homogenization and nonlinear elasticity. A main feature of the functionals $\mathcal{P}_{p, q}, \mathcal{P}_{p, q, s}$ and $\mathcal{P}_{\text {log }}$ in (1.3)-(1.5) is that their integrand changes their growth and ellipticity ration depending on the geometric behavior of the coefficient functions $a(\cdot)$ and $b(\cdot)$, which determines the geometry of the mixture of different materials. As shown in [47, 50, 88, 89], such functionals exhibit Lavrentiev phenomenon which means that minimizers are discontinuous.

Each functional mentioned above belongs to a family of functionals satisfying nonstandard growth conditions of ( $p, q$ )-type. These are functionals of type

$$
W^{1,1}(\Omega) \ni v \mapsto \int_{\Omega} F(x, D v) d x
$$

whose energy density $F(x, z)$ satisfies

$$
|z|^{p} \lesssim F(x, z) \lesssim|z|^{q}+1, \quad 1<p<q
$$

according to Marcellini's terminology [68, 69, 70]. Over the several decades, functionals with nonstandard growth have been extensively investigated, see for instance [18, 45, 46, 47, 50, 51, 80, 81] and the references therein. Those functionals aforementioned give a relevant example of the energy overlying in the so-called Musielak-Orlicz space which will described in Section 2.2 below.

For the regularity theory, the optimal conditions for the gradient of a local minimizer $v$ of the functional $\mathcal{P}_{p, q}$ to be Hölder continuous have been discovered in [13, 30, 31]. They are

$$
\begin{cases}\frac{q}{p} \leqslant 1+\frac{\alpha}{n} \quad \text { and } \quad 0 \leqslant a(\cdot) \in C^{0, \alpha}(\Omega) & \text { if } v \in W^{1, p}(\Omega)  \tag{1.6a}\\ q \leqslant p+\alpha \text { and } \quad 0 \leqslant a(\cdot) \in C^{0, \alpha}(\Omega) & \text { if } v \in W^{1, p}(\Omega) \cap L^{\infty}(\Omega) \\ q<p+\frac{\alpha}{1-\gamma} \quad \text { and } \quad 0 \leqslant a(\cdot) \in C^{0, \alpha}(\Omega) & \text { if } v \in W^{1, p}(\Omega) \cap C^{0, \gamma}(\Omega) \text { for some } \gamma \in(0,1)\end{cases}
$$

Those conditions in (1.6a)-(1.6c) are essentially sharp in the sense of Lavrentiev gap for the functional $\mathcal{P}_{p, q}$. Here we refer to the very recent interesting paper [9] and see also [47, 50]. On the other hand, letting $a(\cdot) \in C^{\omega_{a}}(\Omega)$ with a concave function $\omega_{a}:[0, \infty) \rightarrow[0, \infty)$ vanishing at the origin, the conditions for a local minimizer $v$ of the functional $\mathcal{P}_{\text {log }}$ to be regular have been discovered in [12], which are

$$
\begin{cases}v \text { is Hölder continuous } & \text { if } \limsup _{t \rightarrow 0^{+}} \omega_{a}(t) \log \left(\frac{1}{t}\right)<\infty  \tag{1.7a}\\ v \text { is Hölder continuous with an arbitrary exponent } & \text { if } \limsup _{t \rightarrow 0^{+}} \omega_{a}(t) \log \left(\frac{1}{t}\right)=0 \\ D v \text { is Hölder continuous } & \text { if } \omega_{a}(t) \lesssim t^{\alpha} \text { with some } \alpha \in(0,1)\end{cases}
$$

Furthermore, the optimal condition for a local minimizer of the multi-phase functional $\mathcal{P}_{p, q, s}$ in (1.5) to be gradient Hölder continuous has been obtained in [38], that is

$$
\begin{equation*}
\frac{q}{p} \leqslant 1+\frac{\alpha}{n}, \quad \frac{s}{p} \leqslant 1+\frac{\beta}{n}, \quad 0 \leqslant a(\cdot) \in C^{0, \alpha}(\Omega) \quad \text { and } \quad 0 \leqslant b(\cdot) \in C^{0, \beta}(\Omega) \tag{1.8}
\end{equation*}
$$

for some $\alpha, \beta \in(0,1]$. This condition essentially is a natural outcome of the condition (1.6a) and sharp. So looking at the conditions presented in (1.6a)-(1.6c), (1.8) and the ones (1.7a)-(1.7c), there is a natural question as to whether the coefficient functions $a(\cdot), b(\cdot)$ in (1.3) and (1.5) are necessarily Hölder continuous even for a lower level of the regularity, depending on the a priori assumptions on a local minimizer under consideration. Here in this paper we intend to answer such questions by treating much more general class of functionals with Orlicz multi-phase growth below. Apart from the papers mentioned above, the regularity theory for the double phase problems has been the object of an intensive investigation over the last years, see for instance $[14,20,25,36,37,58,73,74]$ and the references therein.

In this paper we shall deal with a class of general functionals of type

$$
\begin{equation*}
W^{1,1}(\Omega) \ni v \mapsto \mathcal{F}(v, \Omega):=\int_{\Omega} F(x, v, D v) d x \tag{1.9}
\end{equation*}
$$

where $F: \Omega \times \mathbb{R} \times \mathbb{R}^{n} \rightarrow \mathbb{R}$ is a Caratheódory function satisfying the double-sided bound

$$
\begin{equation*}
\nu \Psi(x,|z|) \leqslant F(x, y, z) \leqslant L \Psi(x,|z|) \quad\left(x \in \Omega, y \in \mathbb{R}, z \in \mathbb{R}^{n}\right) \tag{1.10}
\end{equation*}
$$

where $\Psi$ is the same as in (1.2). Under the growth conditions (1.10), local minimizers ( $Q$-minimizers) of the functional $\mathcal{F}$ in (1.9) for some number $Q \geqslant 1$ can be defined as follows:

Definition 1.1. A function $u \in W_{\mathrm{loc}}^{1,1}(\Omega)$ is a local minimizer ( $Q$-minimizer) of the functional $\mathcal{F}$ defined in (1.9) if $\Psi(x,|D u|) \in L^{1}(\Omega)$ and the minimality condition $\mathcal{F}(u, \operatorname{supp}(u-v)) \leqslant \mathcal{F}(v, \operatorname{supp}(u-v))$ $(\mathcal{F}(u, \operatorname{supp}(u-v)) \leqslant Q \mathcal{F}(v, \operatorname{supp}(u-v)))$ is satisfied, whenever $v \in W_{\mathrm{loc}}^{1,1}(\Omega)$ with $\operatorname{supp}(u-v) \Subset \Omega$.

In the rest of the paper we always assume $a(\cdot) \in C^{\omega_{a}}(\Omega)$ and $b(\cdot) \in C^{\omega_{b}}(\Omega)$, where $\omega_{a}, \omega_{b}:[0, \infty) \rightarrow[0, \infty)$ are concave functions such that $\omega_{a}(0)=0$ and $\omega_{b}(0)=0$ unless they are specified. Throughout the paper we define the function $\Lambda:(0, \infty) \times(0, \infty) \rightarrow(0, \infty)$ given by

\begin{equation*}
\Lambda(s, t):=\frac{\omega_{a}(s)}{1+\omega_{a}(s)} \frac{H_{a}(t)}{G(t)}+\frac{\omega_{b}(s)}{1+\omega_{b}(s)} \frac{H_{b}(t)}{G(t)} \quad \text { for any } \quad s, t>0 \tag{1.11}
\end{equation*}
$$

We shall consider a local $Q$-minimizer $u$ of the functional $\mathcal{P}$ in (1.1) or a local minimizer $u$ of the functional $\mathcal{F}$ in (1.9) under one of the following main assumptions:

$$
\begin{align*}

u \in W^{1, \Psi}(\Omega) \\
\lambda_{1}:=\sup _{t>0} \Lambda\left(t, G^{-1}\left(t^{-n}\right)\right)<\infty
\end{array}\right.  \tag{1.12}\\
& \left\{\begin{array}{l}
u \in W^{1, \Psi}(\Omega) \cap L^{\infty}(\Omega), \\
\lambda_{2}:=\sup _{t>0} \Lambda\left(t, \frac{1}{t}\right)<\infty,
\end{array}\right.  \tag{1.13}\\
& \left\{\begin{array}{l}
u \in W^{1, \Psi}(\Omega) \cap C^{0, \gamma}(\Omega) \text { for some } \quad \gamma \in(0,1), \\
\lambda_{3}:=\sup _{t>0} \Lambda\left(t^{\frac{1}{1-\gamma}}, \frac{1}{t}\right)<\infty .
\end{array}\right. \tag{1.14}
\end{align*}
$$

Here $G^{-1}$ is the inverse function of $G$. We straightforwardly check that the conditions (1.12)-(1.14) read as (1.6a)-(1.6c), respectively, when $G(t)=t^{p}, H_{a}(t)=t^{q}, w_{a}(t)=t^{\alpha}$ and $b(\cdot) \equiv 0$ for some $1<p \leqslant q$ and $\alpha \in(0,1]$. Also the condition (1.8) is the same as (1.12) for relevant choices of the functions. Moreover, $(1.12)_{2}$ and $(1.13)_{2}$ are the same as the one in (1.7a) when $G(t)=t^{p}$ and $H_{a}(t)=t^{p} \log (1+t)$ for some $p>1$ and $b(\cdot) \equiv 0$. It has been shown that the assumption (1.10) is not enough already in the special case of $G(t)=t^{p}$ for $p>1$ together with $a(\cdot) \equiv 0$ and $b(\cdot) \equiv 0$ for obtaining higher regularity of minimizers of the functional $\mathcal{F}$ in (1.9). In this regard we consider the energy density $F$ in (1.9) of type

$$
\begin{equation*}
F(x, y, z):=F_{G}(x, y, z)+a(x) F_{H_{a}}(x, y, z)+b(x) F_{H_{b}}(x, y, z) \tag{1.15}
\end{equation*}
$$

for every $x \in \Omega, y \in \mathbb{R}$ and $z \in \mathbb{R}^{n}$, where $F_{G}(\cdot), F_{H_{a}}(\cdot)$ and $F_{H_{b}}(\cdot)$ are continuous functions belonging to $C^{2}\left(\mathbb{R}^{n} \backslash\{0\}\right)$ with respect to $z$-variable and satisfying the following structure assumptions with fixed constants $0<\nu \leqslant L$ :

\left|D_{z} F_{\Phi}\left(x_{1}, y, z\right)-D_{z} F_{\Phi}\left(x_{2}, y, z\right)\right||z| \leqslant L \omega\left(\left|x_{1}-x_{2}\right|\right) \Phi(|z|) \\
\left|F_{\Phi}\left(x, y_{1}, z\right)-F_{\Phi}\left(x, y_{2}, z\right)\right| \leqslant L \omega\left(\left|y_{1}-y_{2}\right|\right) \Phi(|z|)

for every $\Phi \in\left\{G, H_{a}, H_{b}\right\}$, whenever $x, x_{1}, x_{2} \in \Omega, y, y_{1}, y_{2} \in \mathbb{R}, z \in \mathbb{R}^{n} \backslash\{0\}, \xi \in \mathbb{R}^{n}$, here either

$$
\begin{equation*}
\omega(t):=\min \left\{t^{\mu}, 1\right\} \text { with some } \mu \in(0,1) \text { for all } t \geqslant 0 \tag{1.17}
\end{equation*}
$$

or

$$
\begin{equation*}
\omega:[0,+\infty) \rightarrow[0,+\infty) \text { is concave such that } \omega(0)=0 \text { and } \omega(\cdot) \leqslant 1 \tag{1.18}
\end{equation*}
$$

The structure conditions in (1.16) are satisfied for instance by the model functional

$$
W^{1,1}(\Omega) \ni v \mapsto \int_{\Omega} f(x, v) \Psi(x,|D v|) d x
$$

where $0<\nu_{1} \leqslant f(x, y) \leqslant L_{1}$ for some constants $\nu_{1}, L_{1}$ and for some suitable continuous function $f(\cdot)$ satisfying the following inequality

$$
\left|f\left(x_{1}, y_{1}\right)-f\left(x_{2}, y_{2}\right)\right| \leqslant L \omega\left(\left|x_{1}-x_{2}\right|+\left|y_{1}-y_{2}\right|\right)
$$

whenever $x_{1}, x_{2} \in \mathbb{R}^{n}$ and $y_{1}, y_{2} \in \mathbb{R}$, where $\omega$ is the same as defined in (1.17) or (1.18). We also remark that those general functionals mentioned above have not been considered in the present literature for the regularity theory as far as we are concerned, moreover the functionals in (1.9) with structure assumptions (1.10) and (1.16) is not differentiable with respect to the second variable and so it can not be treated by its

Euler-Lagrange equation. In order to shorten the notations in this paper, for a given local minimizer $u$ of the functional $\mathcal{F}$, we shall use a set of various basic parameters which is "data of the problem" depending on which assumption of (1.12)-(1.14) is considered as follows:

where $\lambda_{1}, \lambda_{2}, \lambda_{3}$ are the same numbers as defined in (1.12)-(1.14) and $s(G), s\left(H_{a}\right), s\left(H_{b}\right)$ are indices of the functions $G, H_{a}, H_{b}$ in the sense of Definition 2.1, respectively. For a given local $Q$-minimizer $u$ of the functional $\mathcal{P}$, data is understood by the above set of parameters with the constants $L, \nu$ having been replaced by $Q$ in any case of (1.12)-(1.14) into the consideration. With $\Omega_{0} \Subset \Omega$ being a fixed open subset, we also denote by data $\left(\Omega_{0}\right)$ the set of parameters in (1.19) together with $\operatorname{dist}\left(\Omega_{0}, \partial \Omega\right)$ under one of the assumptions (1.12)-(1.14):

\operatorname{data}\left(\Omega_{0}\right) \equiv \operatorname{data}, \operatorname{dist}\left(\Omega_{0}, \partial \Omega\right) \tag{1.20}
\end{equation*}

Now we are ready to state our main results in this paper.
Theorem 1.1 (Maximal regularity). Let $u \in W^{1, \Psi}(\Omega)$ be a local minimizer of the functional $\mathcal{F}$ defined in (1.9), under the assumptions (1.10), (1.16) and (1.17). Suppose that $\omega_{a}(t)=t^{\alpha}$ and $\omega_{b}(t)=t^{\beta}$ for some $\alpha, \beta \in(0,1]$. If one of the following assumptions

is satisfied, then there exists $\theta \in(0,1)$ depending only on $n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \nu, L, \alpha, \beta$ and $\mu$ such that $D u \in C_{\operatorname{loc}}^{0, \theta}(\Omega)$.

Theorem 1.2 (Morrey decay). Let $u \in W^{1, \Psi}(\Omega)$ be a local minimizer of the functional $\mathcal{F}$ defined in (1.9), under the assumptions (1.10), (1.16) and (1.18). If one of the following assumptions

is satisfied, then

Moreover, for every $\sigma \in(0, n)$, there exists a positive constant $c \equiv c\left(\boldsymbol{d a t a}\left(\Omega_{0}\right), \sigma\right)$ such that the decay estimate

holds for every concentric balls $B_{\rho} \subset B_{R} \subset \Omega_{0} \Subset \Omega$ with $R \leqslant 1$.

First of all we note that the gradient Hölder regularity of a local minimizer in Theorem 1.1 is already optimal in the classical $p$-Laplace case that $G(t)=t^{p}$ and $a(\cdot) \equiv b(\cdot) \equiv 0$ [84, 85]. The assumptions in (1.21a)-(1.21c) are optimal by the counterexamples given in [46, 50], see also [9]. The regularity results reported here complement in a unified way the main results of $[12,13,30,31,38]$, where the functions in (1.3)-(1.5) are considered under the corresponding conditions we have discussed in (1.6a)-(1.6c),(1.7a)-(1.7c) and (1.8), respectively, and the arguments used in those papers are strongly dependent of the number of phases along with the Hölder continuity of the coefficient function in the non-linearity. Our approaches for proving the above theorems are in fact independent of this weakness. The assumptions of the above theorems lead to showing new instances of Lavrantiev phenomenon [86, 87, 88, 89, 90]. According to the classical definition, the Lavrentiev gap for the functional $\mathcal{F}$ defined in (1.9) under the growth assumption (1.10) may appear if

holds for a ball $B \Subset \Omega$ and a function $v_{0} \in W^{1, \infty}(B)$, where $\Psi_{\Omega}^{+}$is defined in (2.3) below. That is, local minimizers of $\mathcal{F}$ do not belong to $W_{\text {loc }}^{1, \Psi_{\Omega}^{+}}(B)$ in general. To see this, let us look at the classical case that $G(t)=t^{p}, H_{a}(t)=t^{q}, \omega_{a}(t)=t^{\alpha}$ and $\omega_{b}(\cdot) \equiv 0$ for $1<p<q$ and $\alpha \in(0,1]$ such that

Under classical double phase setting together with (1.26), the results of [30, Theorem 4.1] and [47, Section 3] provide us the existence of a coefficient function $a(\cdot) \in C^{0, \alpha}(\Omega)$ and a boundary datum $u_{0} \in W^{1, p}(B) \cap L^{\infty}(B)$ such that the Lavrentiev phenomenon (1.25) is occurred. In this regard, we show that there is no Lavrentiev gap for the functional $\mathcal{F}$ in (1.9) satisfying the basic structure assumption (1.10) under the one of assumptions $(1.12)_{2},(1.13)_{2}$ and $(1.14)_{2}$, see Theorem 3.1 below. The approaches we present in this paper lead to avoiding the use of difference quotient methods employed in $[30,31]$ for obtaining various regularity properties of minimizers of the functional $\mathcal{P}$ representing the $(p, q)$-double phase growth. In fact, the difference quotient techniques can deal with the case that the coefficient functions in the nonlinearity are Hölder continuous. On the other hand, we are treating the case of not necessarily having Hölder continuous coefficient functions in the nonlinearity by applying a Harmonic type approximation (see Lemma 6.1 below) for comparing a homogeneous equation with a limiting equation having the lipschitz regularity property (see Lemma 7.3 and 7.4).

Remark 1.1. We would like to point out, in the same spirit as this paper, the results of Theorem 1.1 and Theorem 1.2 can be restated and proved for the functional having a finite number of phases with replacing the function in (1.2) by

where $G, H_{i} \in \mathcal{N}$ in the sense of the Definition 2.1 and $a_{i}(\cdot) \in C^{\omega_{i}}(\Omega)$ with $\omega_{i}:[0, \infty) \rightarrow[0, \infty)$ being a concave function vanishing at the origin for every $i \in\{1, \ldots, N\}$. Under this setting we replace the function in (1.11) by

The coefficient functions in Theorem 1.1 along with (1.22d) and (1.22e) in Theorem 1.2 are understood by letting $\omega_{i}(t)=t^{\alpha_{i}}$ with some $\alpha_{i} \in(0,1]$ for every $i \in\{1, \ldots, N\}$.

The contents in this paper could provide a guideline to deal with a very general class of non-autonomous functionals whose energy density behaves like

for $\Phi$ being a certain Young function as we shall introduce in Definition 2.1 below. The investigation of such problems has been a field of interest for research activities over the decades. In fact, a main difficulty lies in discovering the optimal conditions to be placed on $\Phi(x, t)$ with respect to $(x, t)$-variables. Here we mention a very recent and interesting paper [60] in which the authors give a reasonable answer to such a question
by considering a class of functionals of Uhlenbeck type without any a priori assumption on the minimizers involved. Essensially, the assumption [60, (VA1)] is not comparable with the assumption (1.12) . Moreover, the method used in [60] can not be applicable to treat the regularity of minimizers of the functional $\mathcal{F}$ in (1.9) having the solution dependence. Besides the papers mentioned before, there is a rich literature, see for instance $[3,4,5,16,17,23,25,33,34,48,61,62,76,77,83]$ and reference therein. We also refer to a survey paper [71].

Finally, we close the introduction part with outlining the organization of the paper. In the next section, we introduce our basic settings and some backgrounds. In Section 3 we shall deal with the absence of Lavrentiev phenomenon for the functional $\mathcal{F}$ under our main assumptions $(1.12)_{2},(1.13)_{2}$ and $(1.14)_{2}$. Section 4 is devoted to obtaining Sobolev-Poincaré type inequality. In Section 5 we start with showing basic regularity results of quasi-minimizers of the functional $\mathcal{P}$ introduced in (1.1), while in Section 6 we provide a certain harmonic type approximation fitting in our settings. From Section 7 we start with making the comparison estimates in order to reach a limiting functional and in Section 8 and Section 9 we prove Theorem 1.1 and Theorem 1.2. In Section 10 we shall consider a more general class of functionals having the Orlicz double phase growth. Finally, we shall dealt with our multi-phase problems under some additional integrability condition of Sobolev type and some relevant optimal condition in Section 11.

## 2. Notations and preliminaries

2.1. Notations. In what follows we shall always denote by $c$ to mean a generic positive constant, possibly varying from line to line, while special constants will be denoted by $c_{1}, \bar{c}, c_{*}, c_{\varepsilon}$, and so on. All such constants will be always not smaller than one; moreover relevant dependencies on parameters will be emphasized using parentheses, that is, for example $c \equiv c(n, s(G), \nu, L)$ means that $c$ depends only on $n, s(G), \nu, L$. We denote by $B_{R}\left(x_{0}\right)=\left\{x \in \mathbb{R}^{n}:\left|x-x_{0}\right|<R\right\}$ the open ball in $\mathbb{R}^{n}$ centered at $x_{0} \in \mathbb{R}^{n}$ with a radius $R>0$. If the center is clear in the context, we shall omit the center point by writing $B_{R} \equiv B_{R}\left(x_{0}\right)$. We shall also denote $B_{1} \equiv B_{1}(0) \subset \mathbb{R}^{n}$ unless the center is specified. With $f: \mathcal{B} \rightarrow \mathbb{R}^{N}(N \geqslant 1)$ being a measurable map for a measurable subset $\mathcal{B} \subset \mathbb{R}^{n}$ having finite and positive measure, we denote by

Definition 2.1. A measurable function $\Phi: \Omega \times[0, \infty) \rightarrow[0, \infty)$ is called an Young function if, for any fixed $x \in \Omega$, the function $\Phi(x, \cdot)$ increasing and convex such that

As a direct consequence of the above definition, for any $\Phi \in \mathcal{N}(\Omega)$ with an index $s(\Phi) \geqslant 1$ and any fixed point $x \in \Omega$, we can observe

In particular, for every open subset $\mathcal{B} \subset \Omega$, it holds that $\Psi_{\mathcal{B}}^{+}, \Psi_{\mathcal{B}}^{-} \in \mathcal{N}$ with indices $s\left(\Psi_{\mathcal{B}}^{+}\right)=s(G)+s\left(H_{a}\right)+s\left(H_{b}\right)$ and $s\left(\Psi_{\mathcal{B}}^{-}\right)=s(G)+s\left(H_{a}\right)+s\left(H_{b}\right)$.

Moreover, the maps introduced in (2.8) are very convenient to formulate the monotonicity properties of the vector field $D_{z} F(x, y, z)$ with respect to the gradient variable $z$ and some growth properties of the integrand $F$ defined in (1.9).

Lemma 2.5. Let $F: \Omega \times \mathbb{R} \times \mathbb{R}^{n} \rightarrow \mathbb{R}$ be a function defined in (1.15) satisfying (1.10) and (1.16). 2.2. Musielak-Orlicz and Musielak-Orlicz-Sobolev spaces. We now introduce the Musielak-Orlicz spaces (generalized Orlicz spaces), which generalize the Orlicz spaces. Let $\Phi: \Omega \times[0, \infty) \rightarrow[0, \infty)$ be an Young function. Here we present some definitions and properties associated to Young functions.

Definition 2.2. Let $\Phi$ be a Young function.
(1) $\Phi$ is said to satisfy the $\Delta_{2}$-condition, denoted by $\Phi \in \Delta_{2}$, if there exists a positive number $\Delta_{2}(\Phi)$ such that $\Phi(x, 2 t) \leqslant \Delta_{2}(\Phi) \Phi(x, t)$ for all $x \in \Omega$ and $t \geqslant 0$.
(2) $\Phi$ is said to satisfy the $\nabla_{2}$-condition, denoted by $\Phi \in \nabla_{2}$, if there exists a positive number $\nabla_{2}(\Phi)>1$ such that $\Phi\left(x, \nabla_{2}(\Phi) t\right) \geqslant 2 \nabla_{2}(\Phi) \Phi(x, t)$ for all $x \in \Omega$ and $t \geq 0$.
(3) We write $\Phi \in \Delta_{2} \cap \nabla_{2}$ if $\Phi \in \Delta_{2}$ and $\Phi \in \nabla_{2}$.

For a given Young function $\Phi$, we define the complementary function $\Phi^{*}$ of $\Phi$ by, for each $x \in \Omega$ and $t \geqslant 0$,

Then $\Phi^{*}$ satisfies all the conditions to be a Young function. One can see that $\left(\Phi^{*}\right)^{*}=\Phi$ and that $\Phi \in \nabla_{2}$ if and only if $\Phi^{*} \in \Delta_{2}$ with $2 \nabla_{2}(\Phi)=\Delta_{2}\left(\Phi^{*}\right)$.

For an Young function $\Phi$, the Musielak-Orlicz class $K^{\Phi}\left(\Omega ; \mathbb{R}^{N}\right), N \geqslant 1$, consists of all measurable functions $v: \Omega \rightarrow \mathbb{R}^{N}$ satisfying

The Musielak-Orlicz space $L^{\Phi}\left(\Omega ; \mathbb{R}^{N}\right)$ is the vector space generated by $K^{\Phi}\left(\Omega ; \mathbb{R}^{N}\right)$. If $\Phi \in \Delta_{2}$, then $K^{\Phi}\left(\Omega ; \mathbb{R}^{N}\right)=L^{\Phi}\left(\Omega ; \mathbb{R}^{N}\right)$ and this space is a Banach space under the Luxemburg norm

The Musielak-Orlicz-Sobolev space $W^{1, \Phi}\left(\Omega ; \mathbb{R}^{N}\right)$ is the function space of all measurable functions $v \in$ $L^{\Phi}\left(\Omega ; \mathbb{R}^{N}\right)$ such that its distributional gradient vector $D v$ belongs to $L^{\Phi}\left(\Omega ; \mathbb{R}^{N n}\right)$. For $v \in W^{1, \Phi}\left(\Omega ; \mathbb{R}^{N}\right)$, we define its norm to be

The space $W_{0}^{1, \Phi}\left(\Omega ; \mathbb{R}^{N}\right)$ is defined as the closure of $C_{0}^{\infty}\left(\Omega ; \mathbb{R}^{N}\right)$ in $W^{1, \Phi}\left(\Omega ; \mathbb{R}^{N}\right)$. For $N=1$, we simply write $L^{\Phi}(\Omega):=L^{\Phi}(\Omega ; \mathbb{R})$ and $W^{1, \Phi}(\Omega):=W^{1, \Phi}(\Omega ; \mathbb{R})$. For a detailed discussion of the Musielak-Orlicz spaces and the associated Sobolev spaces, we refer the reader to $[2,15,29,40,55,56,72,79,82]$ and references therein.

We end up this preliminary section with presenting some standard technical lemmas which will be applied later, see for instance $[53,54,63]$.

Lemma 2.6. Let $h:\left[\rho_{1}, \rho_{2}\right] \rightarrow \mathbb{R}$ be a non-negative and bounded function, and $\theta \in(0,1), A_{0} \geqslant 0, \gamma_{0} \geqslant 0$. Assume that

## 3. Absence of Lavrentiev phenomenon

Here we deal with the absence of Lavrantiev phenomenon under the assumptions introduced in $(1.12)_{2}$, $(1.13)_{2}$ and $(1.14)_{2}$. The following theorem widely covers the results of [30, Theorem 4.1], [31, Proposition 3.6], [22, Theorem 3.1], [13, Theorem 4], [6, Theorem 4.1] and [7, Theorem 3.1].

Theorem 3.1. Let $\mathcal{P}$ be the functional defined in (1.1) with the coefficient functions $a(\cdot) \in C^{\omega_{a}}(\Omega)$ and $b(\cdot) \in C^{\omega_{b}}(\Omega)$ for the functions $\omega_{a}, \omega_{b}$ being concave and vanishing at 0.

1. If the condition $(1.12)_{2}$ is satisfied, then for any function $v \in W_{\mathrm{loc}}^{1, \Psi}(\Omega)$ and ball $B_{R} \equiv B_{R}\left(x_{0}\right) \Subset$ $\tilde{B} \Subset \Omega$ with $\mathcal{P}(v, \tilde{B})<\infty$, there exists a sequence of functions $\left\{v_{k}\right\}_{k=1}^{\infty} \subset W^{1, \infty}\left(B_{R}\right)$ such that

3. Let $v \in W^{1, \Psi}(\Omega) \in C^{0, \gamma}(\Omega)$ with some $\gamma \in(0,1)$ be a local $Q$-minimizer of the functional $\mathcal{P}$ under the assumption $(1.14)_{2}$. Then, for every ball $B_{R} \Subset \Omega$, there exists a sequence of functions $\left\{v_{k}\right\}_{k=1}^{\infty} \subset W^{1, \infty}\left(B_{R}\right)$ such that

Proof. Essentially, the proof for the first two parts is similar to the one of [22, Theorem 3.1]. Since our assumptions are weaker than the assumptions considered there, we provide the detailed proof in any case. First we fix $\varepsilon_{0} \in(0,1)$ such that $B_{R} \Subset B_{R+\varepsilon_{0}} \Subset \tilde{B} \Subset \Omega$. Let $\rho \in C_{0}^{\infty}\left(B_{1}\right)$ be a non-negative standard mollifier with $\int_{\mathbb{R}^{n}} \rho d x=1$. Then we set $\rho_{\varepsilon}(x):=\frac{1}{\varepsilon^{n}} \rho\left(\frac{x}{\varepsilon}\right)$ for $x \in B_{\varepsilon}$ with $0<\varepsilon<\varepsilon_{0}$. Clearly $\rho_{\varepsilon} \in C_{0}^{\infty}\left(B_{\varepsilon}\right)$, $\int_{\mathbb{R}^{n}} \rho_{\varepsilon} d x=1,0 \leqslant \rho_{\varepsilon} \leqslant c(n) \varepsilon^{-n}$ and $\left|D \rho_{\varepsilon}\right| \leqslant c(n) \varepsilon^{-(n+1)}$. For every $0<\varepsilon<\varepsilon_{0} / 2$, we consider the following functions:

& \leqslant \lambda_{1}\left(1+\left[\omega_{a}\left(\left[G\left(\left|D v_{\varepsilon}(x)\right|\right)\right]^{-\frac{1}{n}}\right)\right]^{-1}\right) G\left(\left|D v_{\varepsilon}(x)\right|\right)  \tag{3.6}\\
& \leqslant c\left(1+\left[\omega_{a}(\varepsilon)\right]^{-1}\right) G\left(\left|D v_{\varepsilon}(x)\right|\right) \leqslant c\left(1+\left[\omega_{a}(\varepsilon)\right]^{-1}\right) \Psi_{\varepsilon}\left(x,\left|D v_{\varepsilon}(x)\right|\right)
\end{align*}
$$

Similarly as above, we have

& \leqslant c\left(1+\left[\omega_{a}(\varepsilon)\right]^{-1}\right) G\left(\left|D v_{\varepsilon}(x)\right|\right) \leqslant c\left(1+\left[\omega_{a}(\varepsilon)\right]^{-1}\right) \Psi_{\varepsilon}\left(x,\left|D v_{\varepsilon}(x)\right|\right)
\end{align*}

with some constant $c \equiv c\left(n, \lambda_{2},\|v\|_{L^{\infty}(\tilde{B})}\right)$ for every $x \in B_{R}$. Arguing in the same way, for every $x \in B_{R}$, we have

Therefore, taking into account (3.6)-(3.7) when the first case comes into play, and (3.8)-(3.9) when the second case is considered, in any case, it follows from (3.10) that

for some constant $c$ being independent of $\varepsilon$. Therefore, by Jensen's inequality, we get

Since $[\Psi(\cdot,|D v(\cdot)|)]_{\varepsilon} \rightarrow \Psi(\cdot,|D v(\cdot)|)$ strongly in $L^{1}\left(B_{R}\right)$, we are able to apply the general Lebesgue's dominated convergence theorem of [78, Theorem 19] to obtain a sequence of functions $\left\{v_{k}\right\}:=\left\{v_{\varepsilon_{k}}\right\} \subset C_{0}^{\infty}(\tilde{B})$ satisfying (3.1) for the first case and $(3.2)_{1,2}$ for the second case with some suitable choice of $\varepsilon_{k} \rightarrow 0$. Clearly, the assertion (3.2) ${ }_{3}$ comes from the very definition of mollification of $v$ defined in (3.4).
3. Now we turn our attention to proving the last part of the theorem. Applying a Caccioppoli type inequality of Lemma 5.2 under the assumption $(1.14)_{2}$ below, we see that

& \leqslant c\left(\Psi_{\varepsilon}(x, \cdot)\right)_{t}^{-1}\left(f_{B_{2 \varepsilon}(x)} \Psi_{\varepsilon}\left(x,\left|\frac{v(z)-(v)_{B_{2 \varepsilon}(x)}}{\varepsilon}\right|\right) d z\right) \leqslant c \varepsilon^{\gamma-1}
\end{align*}
$$

with some constant $c$ independent of $\varepsilon$, whenever $x \in B_{R}$ and $\varepsilon \in\left(0, \varepsilon_{0} / 4\right)$, where we have also used the assumption $v \in C^{0, \gamma}(\Omega)$ for some $\gamma \in(0,1)$ and Lemma 2.1 together with Remark 2.2. Recalling the definition of $\Psi_{\varepsilon}$ in (3.5), using the modulus of continuity of functions $a(\cdot), b(\cdot)$ and the assumption $(1.14)_{2}$, for every $x \in B_{R}$, we estimate

\leqslant & \Psi_{\varepsilon}\left(x,\left|D v_{\varepsilon}(x)\right|\right)+c \omega_{a}(\varepsilon)\left(1+\left[\omega_{a}\left(\left|D v_{\varepsilon}(x)\right|^{-\frac{1}{1-\gamma}}\right)\right]^{-1}\right) G\left(\left|D v_{\varepsilon}(x)\right|\right) \\
& +c \omega_{b}(\varepsilon)\left(1+\left[\omega_{b}\left(\left|D v_{\varepsilon}(x)\right|^{-\frac{1}{1-\gamma}}\right)\right]^{-1}\right) G\left(\left|D v_{\varepsilon}(x)\right|\right) \\
\leqslant & c \Psi_{\varepsilon}\left(x,\left|D v_{\varepsilon}(x)\right|\right)
\end{aligned}
$$

for a constant $c$ independent of $\varepsilon$, where we have also used (3.15). Then arguing in the same way as in (3.12)-(3.13), we find a sequence of functions $\left\{v_{k}\right\}_{k=1}^{\infty} \subset W^{1, \infty}\left(B_{R}\right)$ satisfying (3.3). The proof is now finished.

## 4. Sobolev-Poincaré TYpe inequalities

In the present section we provide a Sobolev-Poincaré type inequality for functions $v \in W^{1, \Psi}\left(B_{R}\right)$ with some ball $B_{R} \subset \Omega$, which is one of key points for further investigations. For this, first we give a SobolevPoincaré type inequality for functions of $W^{1, \Phi}\left(B_{R}\right)$ with $\Phi \in \mathcal{N}$ and a ball $B_{R} \subset \mathbb{R}^{n}$.
Lemma 4.1. Let $\Phi \in \mathcal{N}$ with an index $s(\Phi) \geqslant 1$. For any $d_{0} \in\left[1, \frac{n}{n-1}\right)$, there exists $\theta \equiv \theta\left(n, s(\Phi), d_{0}\right) \in$ $(0,1)$ such that

\left(f_{B_{R}}\left[\Phi\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{d_{0}} d x\right)^{\frac{1}{d_{0}}} \leqslant c\left(f_{B_{R}}[\Phi(|D v|)]^{\theta} d x\right)^{\frac{1}{\theta}} \tag{4.1}
\end{equation*}
$$

holds for some constant $c \equiv c\left(n, s(\Phi), d_{0}\right)$, whenever $v \in W^{1, \Phi}\left(B_{R}\right)$ and $B_{R} \subset \mathbb{R}^{n}$ is a ball. Moreover, the above estimate still holds with $v-(v)_{B_{R}}$ replaced by $v$ if $v \in W_{0}^{1, \Phi}\left(B_{R}\right)$.
Proof. First note by Lemma $2.2_{4}$ that there exists $\theta \equiv \theta\left(n, s(\Phi), d_{0}\right) \in\left(\frac{(n-1) d_{0}}{n}, 1\right)$ such that $\Phi^{\theta} \in \mathcal{N}$ with an index $s\left(\Phi^{\theta}\right)$ depending on $n, s(\Phi), d_{0}$. Therefore, the following classical formula

holds for a.e $x \in B_{R}$, see for instance [54, Lemma 7.14]. Letting $E:=f_{B_{R}} \Phi^{\theta}(|D v|) d x$, one can assume that $E>0$, otherwise $v$ is constant on $B_{R}$ and the inequality (4.1) is trivial. Using (4.2), the fact that $\Phi$ is
increasing and Lemma 2.1, we have

Since $\int_{B_{R}} \frac{1}{R|x-y|^{n-1}} d y<c(n)$, where this constant is independent of $x \in B_{R}$ and a ball $B_{R}$, we apply Jensen's inequality to the convex function $\Phi^{\theta}$ with respect to the measure $R^{-1}|x-y|^{-(n-1)} d y$ to obtain

& \leqslant c R^{\frac{(n-1) d_{0}}{\theta}} E^{\frac{d_{0}}{\theta}} f_{B_{R}} f_{B_{R}} \frac{[\Phi(|D v(y)|)]^{\theta}}{|x-y|^{\frac{(n-1) d_{0}}{\theta}}} E^{-1} d y d x
\end{align*}
$$

where in the last estimate we have applied again Jensen's inequality to the convex function $t \mapsto t^{\frac{d_{0}}{\theta}}$ with respect to the probability measure $E^{-1} \Phi^{\theta}(|D v(y)|) d y$. We observe that

f_{B_{R}} \frac{1}{|x-y|^{\frac{(n-1) d_{0}}{\theta}}} d x \leqslant \frac{1}{\left|B_{R}\right|} \int_{B_{2 R}(y)} \frac{1}{|x-y|^{\frac{(n-1) d_{0}}{\theta}}} d x \leqslant c(n, s(\Phi), d) R^{-\frac{(n-1) d_{0}}{\theta}}
$$

which is possible since $\frac{(n-1) d_{0}}{\theta}<n$. Inserting the last estimate into (4.3), the inequality (4.1) follows. Finally, if we replace $v-(v)_{B_{R}}$ by $v$ if $v \in W_{0}^{1, \Phi}\left(B_{R}\right)$, then the estimate (4.1) still holds true since the following classical formula

Theorem 4.1. Let $v \in W^{1, \Psi}\left(B_{R}\right)$ for a ball $B_{R} \subset \Omega$ with $R \leqslant 1$ under $a(\cdot) \in C^{\omega_{a}}(\Omega)$ and $b(\cdot) \in$ $C^{\omega_{b}}(\Omega)$. Then, for any $d \in\left[1, \frac{n^{2}}{n^{2}-1}\right)$, there exist constants $\theta \equiv \theta\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), d\right) \in(0,1)$ and $c \equiv c\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \omega_{a}(1), \omega_{b}(1), d\right)$ such that the following Sobolev-Poincaré-type inequality holds:

1+\left([a]_{\omega_{a}}+[b]_{\omega_{b}}\right)\left(\lambda_{2}+\lambda_{2}\|v\|_{L^{\infty}\left(B_{R}\right)}\right) & \text { if } v \in L^{\infty}\left(B_{R}\right) \text { with }(1.13)_{2} \\
1+\left([a]_{\omega_{a}}+[b]_{\omega_{b}}\right)\left(\lambda_{3}+\lambda_{3}\left[R_{\substack{-\gamma \\
B_{R}}}\right]^{\frac{1}{1-\gamma} v}\right) & \text { if } v \in C^{0, \gamma}\left(B_{R}\right) \text { with }(1.14)_{2}

Moreover, the above estimate (4.4) is still valid with $v-(v)_{B_{R}}$ replaced by $v$ depending on which one of $(4.5 \mathrm{a})-(4.5 \mathrm{c})$ comes into play if $v \in W_{0}^{1, \Psi}\left(B_{R}\right)$.

Proof. The above theorem widely covers the results of [6, Theorem 4.2], [7, Theorem 32.] and also the results of [30, Theorem 1.6], which is a special case when $G(t)=t^{p}, H(t)=t^{q}, \omega_{a}(t)=t^{\alpha}$ and $\omega_{b}(\cdot) \equiv 0$ for some
constants $1<p \leqslant q$ and $\alpha \in(0,1]$. Then using the continuity of the coefficient functions $a(\cdot)$ and $b(\cdot)$, we find

where we have used the following elementary inequality

We now estimate the terms $I_{i}$ with $i \in\{1,2,3\}$ in (4.6) depending on which one of $(1.12)_{2},(1.13)_{2}$ and $(1.14)_{2}$ is under consideration. In turn, using $(1.12)_{2}$ and (2.2), we see

& \leqslant \lambda_{1} \omega_{a}(R)\left(f_{B_{R}}\left[\left(1+\left[\omega_{a}\left(\left[G\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{-\frac{1}{n}}\right)\right]^{-1}\right) G\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{d} d x\right)^{\frac{1}{d}} \\
& \leqslant \lambda_{1} \omega_{a}(R)\left(f_{B_{R}}\left[\left(1+\left[\frac{1}{\omega_{a}(R)}+\frac{R}{\omega_{a}(R)}\left(G\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right)^{\frac{1}{n}}\right]\right) G\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{d} d x\right)^{\frac{1}{d}}  \tag{4.7}\\
& \leqslant 9 \lambda_{1}\left(1+\omega_{a}(1)\right)\left(f\left[G\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{d} d x\right)^{\frac{1}{d}} \\
& +9 \lambda_{1} R\left(f_{B_{R}}\left[G\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{\left(1+\frac{1}{n}\right) d} d x\right)^{\frac{1}{d}}
\end{align*}

where we have used also that $\omega_{a}(\cdot)$ is non decreasing and $R \leqslant 1$. In the same way, we have

Adding the estimates coming from the last two displays and applying Lemma 4.1 with $\Phi \equiv G$ for $d_{0} \equiv d$ and $d_{0} \equiv\left(1+\frac{1}{n}\right) d<\frac{n}{n-1}$, there exists $\theta_{1} \equiv \theta_{1}(n, s(G), d) \in(0,1)$ such that

& \leqslant c \lambda_{1}\left[1+\left(\int_{B_{R}} G(|D v|) d x\right)^{\frac{1}{n}}\right]\left[f_{B_{R}} G^{\theta_{1}}(|D v|) d x\right]^{\frac{1}{\theta_{1}}}

for some constant $c \equiv c\left(n, s(G), \omega_{a}(1), \omega_{b}(1), d\right)$, where in the last inequality of the above display we have used Hölder's inequality. Since $\Psi_{B_{R}}^{-} \in \mathcal{N}$ with an index $s(\Psi)=s(G)+s\left(H_{a}\right)+s\left(H_{b}\right)$ by Remark 2.2, we are able to apply Lemma 4.1 with $\Phi \equiv \Psi_{B_{R}}^{-}$for $d_{0} \equiv d$. In turn, there exists $\theta_{2} \equiv \theta_{2}(n, s(\Psi), d)$ such that

In turn, using (2.2) and the assumption $(1.13)_{2}$, we see

## 5. Basic Regularity results

We start this section by stating the following Caccioppoli inequality which is a fundamental result for the further investigations. In what follows let $Q=L / \nu$ for the convenience in the future but in general it could be any number larger than one.

Lemma 5.1 (Caccioppoli Inequality). Let $u \in W^{1, \Psi}(\Omega)$ be a local $Q$-minimizer of the functional $\mathcal{P}$ defined in (1.1) with $0 \leqslant a(\cdot), b(\cdot) \in L^{\infty}(\Omega)$. Then there exists a positive constant $c \equiv c\left(s(G), s\left(H_{a}\right), s\left(H_{b}\right), Q\right)$ such
that the following Caccioppoli inequality

holds, whenever $B_{\rho} \Subset B_{R} \subset \Omega$ are concentric balls and $k \in \mathbb{R}$.
Proof. The proof is elementary as done for [22, Lemma 4.6]. The only difference lies in that we have an additional one phase. But the inequality (5.1) is still valid since $H_{b} \in \mathcal{N}$ with an index $s\left(H_{b}\right) \geqslant 1$.

Remark 5.1. As a direct consequence of Lemma 5.1, with $u \in W^{1, \Psi}\left(B_{R}\right)$ being a local $Q$-minimizer of the functional $\mathcal{P}$ defined in (1.1) under the assumptions of Lemma 5.1, there exists a positive constant $c \equiv c\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), Q\right)$ such that

5.1. Local boundedness. Now we focus on local boundedness of a local $Q$-minimizer $u$ of the functional $\mathcal{P}$ defined in (1.1) with obtaining precise estimates under the assumption $(1.12)_{2}$.

Theorem 5.1. Let $u \in W^{1, \Psi}(\Omega)$ be a local $Q$-minimizer of the functional $\mathcal{P}$ defined in (1.1) under the assumption (1.12). Then there exists a constant $c \equiv c$ (data) such that

Step 1: Sobolev-Poincaré inequality under the scaling. Before going on further, let us consider a Sobolev-Poincaré type inequality under the new scaling introduced in (5.4). So we prove that there exists a positive exponent $\theta \equiv \theta\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right)\right) \in(0,1)$ such that

Let $\eta \in C_{0}^{\infty}\left(B_{t}\right)$ be a standard cut-off function such that $\chi_{B_{\rho}} \leqslant \eta \leqslant \chi_{B_{t}}$ and $|D \eta| \leqslant \frac{2}{t-\rho}=\frac{4}{s-\rho}$. Now we apply inequality (5.5) from Step 1 above in order to have a positive exponent $\theta \equiv \theta\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right)\right)$ such that

for any integer $i \geqslant 0$ and some number $l_{0}>0$ to be chosen in a few lines. Then applying (5.16) with the choices $k \equiv k_{i+1}, h \equiv k_{i}, \rho \equiv \rho_{i+1}$ and $s \equiv \rho_{i}$, we have, for every $i \geqslant 0$,

with $c_{0} \equiv c_{0}$ (data), where in the last inequality of the last display we have used again Lemma 2.1. Now it's turn to apply a standard iteration of Lemma 2.7, which means that if

5.2. Almost standard Caccioppoli inequality. Now we present the primary results, the so-called almost standard Caccioppoli type inequality, for proving Hölder continuity of a local $Q$-minimizer of the functional $\mathcal{P}$.

Lemma 5.2 (Almost standard Caccioppoli inequality). Let $u \in W^{1, \Psi}(\Omega)$ be a local $Q$-minimizer of the functional $\mathcal{P}$ defined in (1.1) under one of the assumptions (1.12), (1.13) and (1.14). Let $B_{2 R} \equiv B_{2 R}\left(x_{0}\right) \subset \Omega$ be a ball with $R \leqslant 1$. Then there exists a constant $c \equiv c($ data) such that

Now we shall estimate each term $I_{i}$ for $i \in\{1,2,3\}$ in the above display. Then using Lemma 2.1, the assumption (1.12) ${ }_{2},(2.2)$ and (5.3) of Lemma 5.1, we see

From now on also in the rest of paper, for a fixed ball $B_{R} \subset \Omega$, we say that

5.3. Hölder continuity. In this subsection we prove some local boundedness and Hölder continuity assertions of a local $Q$-minimizer of the functional $\mathcal{P}$ in (1.1) with various constants having the precise dependencies.

Let $u \in W^{1, \Psi}(\Omega)$ be a local $Q$-minimizer of the functional $\mathcal{P}$ defined in (1.1) under the coefficient functions $a(\cdot) \in C^{\omega_{a}}(\Omega)$ and $b(\cdot) \in C^{\omega_{b}}(\Omega)$ for $\omega_{a}, \omega_{b}$ being non-negative concave functions vanishing at the origin.

1. If the assumption (1.12) is satisfied, then for every open subset $\Omega_{0} \Subset \Omega$, there exists a Hölder continuity exponent $\gamma \equiv \gamma\left(\boldsymbol{\operatorname { d a t a }}\left(\Omega_{0}\right)\right) \in(0,1)$ such that

holds for some $c \equiv c\left(\boldsymbol{d a t a}\left(\Omega_{0}\right)\right)$ and all concentric balls $B_{\rho} \Subset B_{R} \Subset \Omega_{0} \Subset \Omega$ with $R \leqslant 1$.
2. If the assumption (1.13) is satisfied, then there exists a Hölder continuity exponent $\gamma \equiv \gamma(\boldsymbol{d a t a}) \in$ $(0,1)$ such that

holds for some $c \equiv c($ data $)$ and all concentric balls $B_{\rho} \Subset B_{R} \subset \Omega$ with $R \leqslant 1$.
Proof. Basically, we shall use De Giorgi's methods to prove the local Hölder continuity of $u$ based on arguments employed in $[22,30]$. For the convenience of the reader, we give a detailed proof. Note that, for any given ball $B_{R} \Subset \Omega$, either

holds true. It is enough to deal with only the case of (5.35) is valid since $-u$ is a local $Q$-minimizer of the functional $\mathcal{P}$. The proof falls in three steps. In what follows, let $B_{2 R} \equiv B_{2 R}\left(x_{0}\right) \subset \Omega_{0} \Subset \Omega$ be a fixed ball such that $R \leqslant 1$. Let us also denote by

Then in this step we prove that, for any $\varepsilon \in(0,1)$, there exists a natural number $m \equiv m\left(\boldsymbol{d a t a}\left(\Omega_{0}\right), \varepsilon\right) \geqslant 3$ if $(1.12)$ is assumed, and $m \equiv m($ data, $\varepsilon) \geqslant 3$ if (1.13) is assumed, such that

\end{array}\right.
$$

Clearly $w_{i} \in W^{1, \Psi}\left(B_{R / 2}\right)$ with $w_{i} \equiv 0$ in $B_{R / 2} \backslash A\left(k_{1}, R / 2\right)$ for all $i \in\{1, \ldots, m\}$, and also $\mid B_{R / 2} \backslash$ $A\left(k_{1}, R / 2\right)|\geqslant 1 / 2| B_{R / 2} \mid$. Then applying Hölder's inequality, Sobolev's inequality and Lemma 2.4, for every $\tau \in(0,1)$, we have

& \leqslant c R\left(\int_{A\left(k_{i}, R / 2\right)}\left[\Psi_{B_{R}}^{-}\left(\frac{w_{i}}{R}\right)\right]^{\frac{n}{n-1}} d x\right)^{\frac{n-1}{n}}  \tag{5.39}\\
& \leqslant c \int_{\mathcal{D}_{i}} \partial_{t} \Psi_{B_{R}}^{-}\left(\frac{u-k_{i}}{R}\right)|D u| d x \\
& \leqslant \tau \int_{\mathcal{D}_{i}} \Psi_{B_{R}}^{-}(|D u|) d x+\frac{c}{\tau^{s(\Psi)}} \int_{\mathcal{D}_{i}} \Psi_{B_{R}}^{-}\left(\frac{u-k_{i}}{R}\right) d x .
\end{align*}
$$

Now we use a Caccioppoli type inequality of Lemma 5.2 in order to have

& \leqslant c \Psi_{B_{R}}^{-}\left(\frac{k_{i+1}-k_{i}}{R}\right)\left|A\left(k_{i}, R\right)\right| \leqslant c \Psi_{B_{R}}^{-}\left(\frac{k_{i+1}-k_{i}}{R}\right) R^{n}
\end{aligned}
$$

One can see that

Using the estimates coming from the last two displays in (5.39), for every $i \in\{1, \ldots, m-1\}$, we see

But in the case that (1.13) is assumed, we choose small enough $\tau \equiv \tau($ data, $\varepsilon)$ and large enough $m \equiv m$ (data, $\varepsilon$ ) to conclude (5.38).

Step 2. In this step, we prove that there exists a small positive $\varepsilon_{0} \equiv \varepsilon_{0}\left(\boldsymbol{\operatorname { d a t a }}\left(\Omega_{0}\right)\right) \in\left(0,1 / 2^{n+1}\right)$ such that if

$$

Applying Lemma 5.2 together with (5.40), we discover

\end{aligned}

where we have also used the very definition of $k_{i}$ and that $\left(u-k_{i}\right)_{+} \leqslant \nu_{0} \leqslant\|u\|_{L^{\infty}\left(B_{R}\right)}$. The last display and the convexity of $\Psi_{B_{R}}^{-}$imply that

& \leqslant \Psi_{B_{R}}^{-}\left(c 2^{i(s(\Psi)+1)} \frac{\left|A\left(k_{i}, \rho_{i}\right)\right|}{\left|D_{i+1}\right|} \frac{\nu_{0}}{R}\right)
\end{aligned}
$$

Therefore, we have

& \geqslant c 2^{-i} \nu_{0}\left|A\left(k_{i+1}, \rho_{i+1}\right)\right|^{1-\frac{1}{n}}\left(\left|B_{R / 4}\right|-\varepsilon_{0}\left|B_{R / 2}\right|\right) R^{-n} \\
& \geqslant c 2^{-i} \nu_{0}\left|A\left(k_{i+1}, \rho_{i+1}\right)\right|^{1-\frac{1}{n}} \\
& \geqslant c 2^{-i} \nu_{0} R^{n-1} Y_{i+1}^{1-\frac{1}{n}}
\end{aligned}
$$

for some constant $c \equiv c\left(\mathbf{d a t a}\left(\Omega_{0}\right)\right)$. Combining last two displays, we conclude

For this, let $m \geqslant 3$ be the natural number satisfying (5.38) for the choice $\varepsilon \equiv \varepsilon_{0} \in\left(0,1 / 2^{n+1}\right)$, where $\varepsilon_{0}$ is determined via (5.40). Then we have

Clearly, the above display implies that there exists a positive exponent $\gamma \equiv \gamma\left(\boldsymbol{d a t a}\left(\Omega_{0}\right)\right) \in(0,1)$ such that, for any fixed ball $B_{8 R_{0}} \subset \Omega_{0}$ with $8 R_{0} \leqslant 1$, the following oscillation

holds with some constant $c \equiv c\left(\operatorname{data}\left(\Omega_{0}\right)\right)$ for every $R \in\left(0, R_{0}\right]$. Here we note that in the case that the assumption (1.13) is in force, the constants appearing in the above lemma depend only on data, but otherwise are independent of the subset $\Omega_{0}$. Finally, we have shown that

if either the assumption (1.12) or (1.13) is satisfied. Therefore by a standard covering argument, the estimates (5.31) and (5.32) are satisfied. Clearly, if (1.13) is assumed instead of (1.12), $\gamma$ in (5.33) depends only on data since $\|u\|_{L^{\infty}\left(\Omega_{0}\right)} \leqslant\|u\|_{L^{\infty}(\Omega)}$. The proof is complete.
5.4. The Harnack inequality. In this subsection we prove the Harnack inequality for a local $Q$-minimizer $u$ of the functional $\mathcal{P}$ in (1.1) under one of the assumptions (1.12), (1.13) and (1.14). The analysis similar to the one in the Step 1 of the proof of Theorem 5.2 gives the following lemma.
Lemma 5.4. Let $u \in W^{1, \Psi}(\Omega)$ be a non-negative local $Q$-minimizer of the functional $\mathcal{P}$ in (1.1) under the coefficient functions $a(\cdot) \in C^{\omega_{a}}(\Omega)$ and $b(\cdot) \in C^{\omega_{b}}(\Omega)$ for $\omega_{a}, \omega_{b}$ being non-negative concave functions vanishing at the origin. Suppose that one of the assumptions (1.12), (1.13) and (1.14) is satisfied. Let $B_{6 R} \subset \Omega_{0} \Subset \Omega$ be a ball with $6 R \leqslant 1$. Then for any $\tau_{1}, \tau_{2} \in(0,1)$, there exists a large number $m$ depending on data and $\tau_{1}, \tau_{2}$ such that for any $0<k \leqslant\|u\|_{L^{\infty}\left(B_{3 R}\right)}$, if

We observe that $\Psi_{3 R}^{-}\left(w_{i}\right) \in W^{1,1}\left(B_{2 R}\right)$ and $\Psi_{3 R}^{-}\left(w_{i}\right) \equiv 0$ on $B_{2 R} \backslash B\left(k_{0}, 2 R\right)$ for every $i \in\{0,1, \ldots, m\}$ and $\left|B_{2 R} \backslash B\left(k_{0}, 2 R\right)\right| \geqslant \tau_{1}\left|B_{R}\right|$. Then using Hölder's inequality, Sobolev's inequality and Lemma 2.4, we have that

B\left(k_{i+1}, 2 R\right) \Psi_{3 R}^{-}\left(\frac{k_{i}-k_{i+1}}{3 R}\right) & \leqslant \int_{B\left(k_{i}, 2 R\right)} \Psi_{3 R}^{-}\left(\frac{w_{i}}{3 R}\right) d x \\
& \leqslant\left|B\left(k_{i}, 2 R\right)\right|^{\frac{1}{n}}\left(\int_{B\left(k_{i}, 2 R\right)}\left[\Psi_{3 R}^{-}\left(\frac{w_{i}}{3 R}\right)\right]^{\frac{n}{n-1}} d x\right)^{\frac{n-1}{n}} \\
& \leqslant c R\left(\int_{B\left(k_{i}, 2 R\right)}\left[\Psi_{3 R}^{-}\left(\frac{w_{i}}{3 R}\right)\right]^{\frac{n}{n-1}} d x\right)^{\frac{n-1}{n}}  \tag{5.44}\\
& \leqslant c \int_{\mathcal{D}_{i}}\left(\Psi_{3 R}^{-}\right)^{\prime}\left(\frac{u-k_{i+1}}{3 R}\right)|D u| d x \\
& \leqslant \varepsilon \int_{\mathcal{D}_{i}} \Psi_{B_{3 R}}^{-}(|D u|) d x+\frac{c}{\varepsilon^{s(\Psi)}} \int_{\mathcal{D}_{i}} \Psi_{3 R}^{-}\left(\frac{u-k_{i+1}}{3 R}\right) d x
\end{align*}
$$

for every $\varepsilon \in(0,1)$ and some constant $c \equiv c\left(\right.$ data, $\left.\tau_{1}\right)$, where we have used Remark 2.2 that $\Psi_{B_{3 R}}^{-} \in \mathcal{N}$ with an index $s(\Psi)=s(G)+s\left(H_{a}\right)+s\left(H_{b}\right)$. It follows from the almost standard Caccioppoli inequality of Lemma
5.2 that

& \leqslant c\left|B\left(k_{i}, 2 R\right)\right| \Psi_{3 R}^{-}\left(\left|\frac{2\left(k_{i}-k_{i+1}\right)}{3 R}\right|\right) \leqslant c R^{n} \Psi_{3 R}^{-}\left(\left|\frac{k_{i}-k_{i+1}}{3 R}\right|\right)
\end{align*}
$$

where we have also used the assumption that $u$ is non-negative. Clearly, by the very definition of $\mathcal{D}_{i}$, one can see that

for some constant $c_{*} \equiv c_{*}\left(\right.$ data,$\left.\tau_{1}\right)$. Now choosing small enough $\varepsilon \equiv$ (data, $\left.\tau_{1}, \tau_{2}\right)$ and sufficiently large $m \equiv m\left(\right.$ data $\left., \tau_{1}, \tau_{2}\right)$ such that

we arrive at the desired estimate (5.43).

Lemma 5.5. Under the assumptions of Lemma 5.4, let $u \in W^{1, \Psi}(\Omega)$ be a non-negative $Q$-minimizer of the functional $\mathcal{P}$ in (1.1). Suppose that one of the assumptions (1.12), (1.13) and (1.14) is satisfied. Then for any $\tau \in(0,1)$, there exists a small $\delta_{1} \equiv \delta_{1}\left(\boldsymbol{d a t a}\left(\Omega_{0}\right)\right)$ such that for any $0<k \leqslant\|u\|_{L^{\infty}\left(B_{3 R}\right)}$, if

Let $W^{1, \Psi}(\Omega)$ be a local non-negative $Q$-minimizer of the functional $\mathcal{P}$ defined in (1.1) with the coefficient functions $a(\cdot) \in C^{\omega_{a}}(\Omega)$ and $b(\cdot) \in C^{\omega_{b}}(\Omega)$ satisfying $(1.12)_{2}$ for functions $\omega_{a}, \omega_{b}$ being concave which vanish at 0 . Suppose one of the assumptions (1.12), (1.13) and (1.14) is satisfied. Let $B_{9 R} \equiv B_{9 R}\left(x_{0}\right) \subset \Omega_{0} \Subset \Omega$ be a ball with $9 R \leqslant 1$. Then there exist $q_{-}>0$ and $a$ constant $c$ depending on data $\left(\Omega_{0}\right)$ such that

Under the assumptions of Lemma 5.4, let $u \in W^{1, \Psi}(\Omega)$ be a non-negative local $Q$-minimizer of the functional $\mathcal{P}$ in (1.1) with the coefficient functions $a(\cdot) \in C^{\omega_{a}}(\Omega)$ and $b(\cdot) \in C^{\omega_{b}}(\Omega)$ satisfying (1.12) ${ }_{2}$ for functions $\omega_{a}, \omega_{b}$ being concave which vanish at 0 . Suppose that one of the assumptions (1.12), (1.13) and (1.14) is satisfied. Let $B_{9 R} \equiv B_{9 R}\left(x_{0}\right) \subset \Omega_{0} \Subset \Omega$ be a ball with $9 R \leqslant 1$. Then for any $q_{+}>0$, the local estimate holds

& \leqslant c\left|\bar{A}\left(k_{i+1}, \rho_{i}\right)\right|^{\frac{1}{n}} \int_{B_{\bar{p}_{i}}}\left(\Psi_{B_{2 R}}^{-}\right)^{\prime}\left(\left(\bar{u}-k_{i+1}\right)_{+} \eta_{i}\right)\left[\left|D\left(\bar{u}-k_{i+1}\right)_{+}\right| \eta_{i}+\left(\bar{u}-k_{i+1}\right)_{+}\left|D \eta_{i}\right|\right] d x \\
& \leqslant c\left|\bar{A}\left(k_{i+1}, \rho_{i}\right)\right|^{\frac{1}{n}} \int_{\bar{B}_{\bar{p}_{i}}}\left(\Psi_{B_{2 R}}^{-}\right)^{\prime}\left(\left(\bar{u}-k_{i+1}\right)_{+}\right)\left|D\left(\bar{u}-k_{i+1}\right)_{+}\right| d x \\
&+c\left|\bar{A}\left(k_{i+1}, \rho_{i}\right)\right|^{\frac{1}{n}} \frac{2^{i}}{s-t} \int_{B_{\bar{p}_{i}}}\left(\Psi_{B_{2 R}}^{-}\right)^{\prime}\left(\left(\bar{u}-k_{i+1}\right)_{+}\right)\left(\bar{u}-k_{i+1}\right)_{+} d x \\
& \leqslant c\left|\bar{A}\left(k_{i+1}, \rho_{i}\right)\right|^{\frac{1}{n}}\left(\int_{B_{\bar{p}_{i}}} \Psi_{B_{2 R}}^{-}\left(\left|D\left(\bar{u}-k_{i+1}\right)_{+}\right|\right) d x+\frac{2^{i}}{s-t} \int_{\bar{B}_{\bar{p}_{i}}} \Psi_{B_{2 R}}^{-}\left(\left(\bar{u}-k_{i+1}\right)_{+}\right) d x\right) \\

Let $u \in W^{1, \Psi}(\Omega)$ be a non-negative local $Q$-minimizer $u$ of the functional $\mathcal{P}$ defined in (1.1) under the coefficient functions $a(\cdot) \in C^{\omega_{a}}(\Omega)$ and $b(\cdot) \in C^{\omega_{b}}(\Omega)$ for $\omega_{a}, \omega_{b}$ being non-negative concave functions vanishing at the origin. Suppose that one of the assumptions (1.12), (1.13) and (1.14) is satisfied. For every ball $B_{R}$ with $B_{9 R} \subset \Omega_{0}$ with $\Omega_{0} \Subset \Omega$ being an open subset, there exists a positive constant $c \equiv c\left(\boldsymbol{d a t a}\left(\Omega_{0}\right)\right)$ such that

\sup _{B_{R}} u \leqslant c \inf _{B_{R}} u \tag{5.60}
\end{equation*}
$$

holds.
Proof. The proof is essentially based on the results we have obtained so far. In fact, applying Theorem 5.3 and Lemma 5.6 with $q_{-}=q_{+}$, we obtain (5.60).

Remark 5.2. The results of the above theorem refine the results of [58, Theorem 1.3] without any extra term in (5.60) under our multi-phase settings when the assumptions (1.12) and (1.13) come into play, and see also [57, 59].
5.5. Higher integrability results. Next, we provide a higher integrability result for a local minimizer of the functional $\mathcal{F}$ defined in (1.9).

Theorem 5.5 (Higher Integrability). Let $u \in W^{1, \Psi}(\Omega)$ be a local minimizer of the functional $\mathcal{F}$ defined in (1.9) under the assumption (1.10). Assume that one of the assumptions (1.12), (1.13) and (1.14) is satisfied. Then there exists a higher integrability exponent $\delta \equiv \delta(\boldsymbol{d a t a}) \in(0,1)$ such that the following reverse type Hölder inequality

holds for a constant $c \equiv c\left(\right.$ data), where data is clarified in (1.19), whenever $B_{R} \Subset \Omega$ is a ball with $R \leqslant 1$. In particular, for any open subset $\Omega_{0} \Subset \Omega$, it holds that

Proof. Let $B_{R} \Subset \Omega$ be a ball with $R \leqslant 1$ as in the statement. Since $u$ is a local $Q:=L / \nu$-minimizer of the functional $\mathcal{P}$ in (1.1), we are able to apply Lemma 5.1 with the choices $\rho \equiv R / 2, r \equiv R$ and $k \equiv(u)_{B_{R}}$ in order to get

## 6. Harmonic type approximation

Here we discuss some important regularity results for the solution to the following Dirichlet boundary value problem:

where $B_{R} \subset \mathbb{R}^{n}$ is a given ball with $n \geqslant 2, v \in W^{1, \Psi_{0}}\left(B_{R}\right)$ is a given function, and $A_{0}: \mathbb{R}^{n} \rightarrow \mathbb{R}^{n}$ is a vector field belonging to $C^{0}\left(\mathbb{R}^{n}\right) \cap C^{1}\left(\mathbb{R}^{n} \backslash\{0\}\right)$ and satisfies the following ellipticity and coercivity assumptions:

for fixed constants $0<\nu \leqslant L$, whenever $z \in \mathbb{R}^{n} \backslash\{0\}$ and $\xi \in \mathbb{R}^{n}$, in which the function $\Psi_{0}$ is given by

with fixed constants $a_{0}, b_{0} \geqslant 0$ for every $t \geqslant 0$. By Lemma $2.2_{1}$, we get the following

holds with some constant $c \equiv c\left(n, s\left(\Psi_{0}\right), \nu\right)$, whenever $z_{1}, z_{2} \in \mathbb{R}^{n} \backslash\{0\}$, where the map $V_{\Phi}$ for a function $\Phi \in \mathcal{N}$ has been defined in (2.8).

Theorem 6.1. Let $h \in W^{1, \Psi_{0}}\left(B_{R}\right)$ be the weak solution to (6.1) under the assumption (6.2). Suppose that there exists a higher integrability exponent $\delta_{1}>0$ such that

For a fixed ball $B_{2 \rho} \subset B_{R}$, let $\eta \in C_{0}^{1}\left(B_{2 \rho}\right)$ be a standard cutoff function satisfying $\chi_{B_{\rho}} \leqslant \eta \leqslant \chi_{B_{2 \rho}}$ and $|D \eta| \leqslant 4 / \rho$. Let us take the function $\varphi=\eta^{s\left(\Psi_{0}\right)+1}\left(h-(h)_{B_{2 \rho}}\right)$ as a test function in the equation (6.1). Then using the monotonicity property of $A_{0}(\cdot)$ and Lemma 2.4 with $\Psi_{0}$, we have

Choosing $\varepsilon$ sufficiently small in the last display, we conclude that

holds for some constant $c \equiv c\left(n, s\left(\Psi_{0}\right), \nu, L\right)$, whenever $B_{2 \rho} \subset B_{R}$ is a ball. Now we prove a version of the last inequality near the boundary of $B_{R}$. For this, let $B_{2 \rho}(y) \subset \mathbb{R}^{n}$ be a ball such that $y \in B_{R}$ and $\frac{1}{10}<\frac{\left|B_{2 \rho}(y) \backslash B_{R}\right|}{\left|B_{2 \rho}(y)\right|}$. We take a test function by $\varphi \equiv \eta^{s\left(\Psi_{0}\right)+1}(h-v)$, where $\eta \in C_{0}^{1}\left(B_{2 \rho}\right)$ is a standard cut-off function as before so that $\chi_{B_{\rho}} \leqslant \eta \leqslant \chi_{B_{2 \rho}}$ and $|D \eta| \leqslant 4 / \rho$. This choice of $\varphi$ is admissible since $\operatorname{supp} \varphi \Subset B_{R} \cap B_{2 \rho}(y)$. Arguing similarly as we have done above, we have

& \leqslant c \int_{B_{R} \cap B_{2 \rho}} \eta^{s\left(\Psi_{0}\right)}\left((\varepsilon \eta) \Psi_{0}(|D h|)+\frac{1}{(\varepsilon \eta)^{s\left(\Psi_{0}\right)}} \Psi_{0}\left(\left|\frac{h-v}{\rho}\right|\right)\right) d x  \tag{6.12}\\
& \quad+c \int_{B_{R} \cap B_{2_{\rho}}} \eta^{s\left(\Psi_{0}\right)}\left((\varepsilon \eta) \Psi_{0}(|D h|)+\frac{1}{(\varepsilon \eta)^{s\left(\Psi_{0}\right)}} \Psi_{0}(|D v|)\right) d x .
\end{align*}

Again choosing $\varepsilon$ small enough and reabsorbing the terms, we find that
for some constant $c \equiv c\left(n, s\left(\Psi_{0}\right), \nu, L\right)$. Redefining $h-v \equiv 0$ on $B_{2 \rho}(y) \backslash B_{R}$, we are able to apply Lemma 4.1 to $\Phi \equiv \Psi_{0}$ with $d_{0} \equiv 1$. In turn, there exists $\theta_{0} \equiv \theta_{0}\left(n, s\left(\Psi_{0}\right)\right) \in(0,1)$ as appearing in (6.11) such that

& \leqslant\left(f_{B_{R} \cap B_{2 \rho}(y)}\left[\Psi_{0}(|D h|)\right]^{\theta_{0}} d x\right)^{\frac{1}{\theta_{0}}}+c f_{B_{R} \cap B_{2 \rho}(y)}\left[\Psi_{0}(|D v|)\right] d x
\end{aligned}

for some constant $c \equiv c\left(n, s\left(\Psi_{0}\right)\right)$, where for the last inequality we have used (2.6) and Hölder's inequality. Combining the last two displays and (6.11), we have

for every ball $B_{2 \rho}(y) \subset \mathbb{R}^{n}$ satisfying either $B_{2 \rho}(y) \subset B_{R}$ or $\frac{1}{10}<\frac{\left|B_{2 \rho}(y) \backslash B_{R}\right|}{\left|B_{2 \rho}(y)\right|}$ with $y \in B_{R}$. Applying a variant of Gehring's lemma and a standard covering argument, we arrive at the desired estimate (6.7).

Before going on further, we recall a classical truncation lemma due to [1]. The statement involves the Hardy-Littlewood maximal operator, defined as

\text { for some positive } \delta_{0} \equiv \delta_{0}\left(n, s\left(\Psi_{0}\right), \nu, L, \delta_{1}\right), \\
f_{B_{R}}^{f}\left(\left|V_{G}(D v)-V_{G}(D h)\right|^{2}+a_{0}\left|V_{H_{a}}(D v)-V_{H_{a}}(D h)\right|^{2}+b_{0}\left|V_{H_{b}}(D v)-V_{H_{b}}(D h)\right|^{2}\right) d x \leqslant \bar{c} \sigma^{s_{1}} \tag{6.22}
\end{gather*}
$$

and

f_{B_{R}} \Psi_{0}\left(\left|\frac{v-h}{R}\right|\right) d x \leqslant \bar{c} \sigma^{s_{0}} \tag{6.23}
\end{equation*}

for some constants with dependence as $s_{1} \equiv s_{1}\left(n, s\left(\Psi_{0}\right), \delta_{1}, c_{0}\right)>0, s_{0} \equiv s_{0}\left(n, s\left(\Psi_{0}\right), \delta_{1}, c_{0}\right)>0$ and $\bar{c} \equiv \bar{c}\left(n, s\left(\Psi_{0}\right), \nu, L, \delta_{1}, c_{0}, c_{1}\right) \geqslant 1$.

Proof. By the standard approximation argument, if (6.19) holds for all functions $\varphi \in C_{0}^{\infty}\left(B_{R}\right)$, then it also holds for all functions $\varphi \in W_{0}^{1, \infty}\left(B_{R}\right)$. The proof falls in three steps.

Step 1: Truncation. The standard energy estimate and (6.17) give us

which is (6.21). We now set $f:=v-h \in W_{0}^{1, \Psi_{0}}\left(B_{R}\right)$ and let $\lambda \geqslant 1$ to be chosen later. We consider $f_{\lambda} \in W_{0}^{1, \infty}\left(B_{R}\right)$ provided by Theorem 6.2, which satisfies (6.15) and (6.16). By these properties, Chebyshev's inequality and then the maximal function theorem for Orlicz spaces (see for instance [51, Proposition 1.2]), we have

\end{align*}

Next we estimate each term appearing in the last equality. By using (6.5), we have

with some $c \equiv c\left(n, s\left(\Psi_{0}\right), \nu, L, \delta_{1}, c_{0}, c_{1}\right)$, where in the last two inequalities we have used Lemma 2.1 together with (6.15) and (6.24). Merging the estimates for $\Gamma_{1}, \Gamma_{2}$ and $\Gamma_{3}$ with (6.27), we deduce that

for some constant $c_{*} \equiv c_{*}\left(n, s\left(\Psi_{0}\right), \nu, L, \delta_{1}, c_{0}, c_{1}\right)$, where $\varepsilon \in(0,1)$ is still to be chosen later. Now let us use a short notation for the simplicity

Recall that $\theta$ is yet to be chosen.

Step 2: Proof of (6.22). By taking $\theta$ properly, we can deduce (6.22) from (6.32). Hölder's inequality with conjugate exponents $\left(\frac{2\left(1+\delta_{0}\right)}{1+2 \delta_{0}}, 2\left(1+\delta_{0}\right)\right)$ yields

& \leqslant c f_{B_{R}}\left[\Psi_{0}(|D v|)\right]^{1+\delta_{0}} d x+c f_{B_{R}}\left[\Psi_{0}(|D h|)\right]^{1+\delta_{0}} d x \leqslant c\left(n, s\left(\Psi_{0}\right), \nu, L, \delta_{1}, c_{0}, c_{1}\right) .
\end{align*}

for some $c \equiv c\left(n, s\left(\Psi_{0}\right), \nu, L, \delta_{1}, c_{0}, c_{1}\right)$, where in the last display we have applied Hölder's inequality with conjugate exponents $\left(\frac{2}{\theta_{0}}, \frac{2}{2-\theta_{0}}\right)$, and finally used (2.10) with (6.36). This proves (6.23). The proof is complete.

## 7. Comparison estimates

Throughout this section we fix a ball $B_{2 R} \equiv B_{2 R}\left(x_{0}\right) \subset \Omega_{0} \Subset \Omega$ with $R \leqslant 1$ and some open subset $\Omega_{0} \Subset \Omega$. We consider the functional defined by

In the following we shall deal with first comparison estimates in order to remove $u$-dependence in the original functional $\mathcal{F}$ in (1.9).

Let the coefficient functions $a(\cdot) \in C^{\omega_{a}}(\Omega)$ and $b(\cdot) \in C^{\omega_{b}}(\Omega)$ for $\omega_{a}, \omega_{b}$ being non-negative concave functions vanishing at the origin. Assume that one of the assumptions (1.12), (1.13) and (1.14) is satisfied. Then there exists a constant $c \equiv c\left(\boldsymbol{\operatorname { d a t a }}\left(\Omega_{0}\right)\right)$ such that

This choice gives us the dependence as described in (7.111) and yields (7.112).

## 8. Proof of Theorem 1.2

Now we are ready to provide the proof of Theorem 1.2. In fact, it comes from the combination of Lemma 5.3 and Lemma 7.5.

Step 1: Different alternatives. Now we consider the different alternatives depending on which phase of (5.27a)-(5.27d) occurs in some fixed ball $B_{R} \equiv B_{R}\left(x_{0}\right) \subset \Omega_{0} \Subset \Omega$ with $R \leqslant R_{*} \equiv R_{*}\left(\boldsymbol{d a t a}\left(\Omega_{0}\right), \varepsilon_{*}\right)$, which will be determined via Lemma 7.5 depending on $\varepsilon_{*} \in(0,1)$.

Alternative 1. Let $\tau_{a b} \in(0,1 / 64)$ to be chosen in a few lines. Assume that $G$-phase occurs in the ball $B_{\tau_{a b} R}$, which means that (5.27a) happens in $B_{\tau_{a b} R}$. In this situation, we have

Take a ball $B_{R} \subset \Omega_{0} \Subset \Omega$ such that $R \leqslant R_{m}$, where $R_{m}=\min \left\{R_{a b}, R_{a}, R_{b}, R_{0}\right\}$ depends on data $\left(\Omega_{0}\right)$ and $\sigma$. We consider $G$-phase in $B_{\tau_{a b}^{k+1} R}$ for every integer $k \geqslant 0$ and define the exit time index

As we discussed earlier after (8.16), we can proceed the same for the occurrence of ( $G, H_{a}$ )-phase in the ball $B_{\tau_{a b}^{\tau_{a b}+1} R}$ instead of the occurrence of $\left(G, H_{b}\right)$-phase in the ball $B_{\tau_{a b}^{\tau_{a b}+1} R}$. Then we can directly jump to the case that $\left(G, H_{a}, H_{b}\right)$-phase occurs in the ball $B_{\tau_{a b}^{\tau_{a b}+1} R}$, which is trivial by (8.13). Moreover, if we start with the occurrence of $\left(G, H_{a}, H_{b}\right)$-phase in $B_{R}$, then the procedure will be much easier by (8.13). Taking into account all the possible cases that we considered above, we can conclude that, for every $\sigma \in(0,1)$, there exists $c \equiv c\left(\operatorname{data}\left(\Omega_{0}\right), \sigma\right)$ such that

\int_{B_{\rho}} \Psi(x,|D u|) d x & \leqslant c\left(\frac{\rho}{R_{m}}\right)^{n-\sigma} \int_{B_{R_{m}}} \Psi(x,|D u|) d x \\
& \leqslant c\left(\frac{\rho}{R_{m}}\right)^{n-\sigma}\left(\frac{R_{m}}{R}\right)^{n-\sigma} \int_{B_{R}} \Psi(x,|D u|) d x  \tag{8.27}\\
& =c\left(\operatorname{data}\left(\Omega_{0}\right), \sigma\right)\left(\frac{\rho}{R}\right)^{n-\sigma} \int_{B_{R}} \Psi(x,|D u|) d x
\end{align*}
$$

All in all, collecting the estimates obtained in (8.25)-(8.27), we arrive at the validity of the Morrey type inequality (1.24). The proof is complete.

Now we consider a crucial outcome of Theorem 1.2, which plays a crucial role for proving Theorem 1.1 afterwards.

Lemma 8.1. Under the assumptions of Lemma 7.3, let $w_{c} \in W^{1, \Psi}\left(B_{R}\right)$ be the solution to the problem defined in (7.22). Suppose that (1.22c) is satisfied for $\omega_{a}(t)=t^{\alpha}$ and $\omega_{b}(t)=t^{\beta}$ with some $\alpha, \beta \in(0,1]$. Then there exists $h \in w_{c}+W_{0}^{1, \Psi_{B_{R}}^{-}}\left(B_{R / 8}\right)$ being a local minimizer of the functional $\mathcal{F}_{0}$ defined in (7.103) such that

& \leqslant c\left(\omega\left(R^{\gamma}\right)+\left[R^{\left.\frac{\alpha}{2\left(1+s\left(H_{a}\right)\right.}\right)}+R^{\frac{\beta}{2\left(1+s\left(H_{b}\right)\right)}}\right]^{s_{1}}\right) f_{B_{2 R}} \Psi(x,|D u|) d x \tag{8.28}
\end{array}
$$

for some constant $c \equiv c\left(\boldsymbol{d a t a}\left(\Omega_{0}\right)\right)$ and $s_{1} \equiv s_{1}(\boldsymbol{d a t a})$, respectively. Moreover, the energy estimate

f_{B_{R / 8}} \Psi_{B_{R}}^{-}(|D h|) d x \leqslant c f_{B_{2 R}} \Psi(x,|D u|) d x \tag{8.29}
\end{equation*}

holds for some constant $c \equiv c(n, \nu, L)$.
Proof. Essentially, the above lemma is a special case of Lemma 7.4 since we consider a particular case that $\omega_{a}(t)=t^{\alpha}$ and $\omega_{b}(t)=t^{\beta}$ for some $\alpha, \beta \in(0,1)$. But our purpose here is to obtain an estimate such as (8.28) with a different multiplier containing some power of $R$, which will be used for proving Theorem 1.1. Therefore, we are able to apply Theorem 1.2. In turn, for every $\theta \in(0,1)$ and open sunset $\Omega_{0} \Subset \Omega$, there exists a constant $c \equiv c\left(\operatorname{data}\left(\Omega_{0}\right), \theta\right)$ such that

\end{align*}
$$

where we have used (8.30) with the choice of $\theta:=(1+\gamma) / 2$ and $B_{2 R} \subset \Omega_{0}$ with $R \leqslant 1$. In the same way, we show

\end{equation*}

whenever $\varphi \in W_{0}^{1, \infty}\left(B_{1 / 8}\right)$, where

Note that the vector field $\bar{A}_{0}$ has been defined in (7.50). We consider a function $\bar{h} \in \bar{w}_{c}+W_{0}^{1, \bar{\Psi}_{0}}\left(B_{1 / 8}\right)$ satisfying (7.94)-(7.97) with the term $d(\varepsilon, R)$ replaced by $q_{3}(R)$. Let $h$ be the scaled back function of $\bar{h}$ in $B_{R / 8}$ as

which proves (7.106). We write the inequality (7.96) in view of $G, H_{a}, H_{b}, w_{c}$ and $h$ in order to have

& \quad \leqslant c\left[q_{3}(R)\right]^{s_{1}} f_{B_{R / 2}} \Psi_{B_{R}}^{-}\left(\left|\frac{w_{c}-\left(w_{c}\right)_{B_{R / 2}}}{R}\right|\right) d x \leqslant c\left[q_{3}(R)\right]^{s_{1}} f_{B_{R / 2}} \Psi_{B_{R}}^{-}\left(\left|D w_{c}\right|\right) d x  \tag{8.38}\\
& \quad \leqslant c\left[q_{3}(R)\right]^{s_{1}} f_{B_{R / 2}} \Psi(x,|D u|) d x
\end{align*}
$$

for some constant $c \equiv c\left(\mathbf{d a t a}\left(\Omega_{0}\right)\right)$, where we have applied Sobolev-Poincaré inequality and (7.109). Combining this estimate together with (7.3) and (7.23) alongside some elementary computations, we arrive at the desired estimate (8.28).

## 9. Proof of Theorem 1.1.

Finally, we are ready to prove Theorem 1.1. First applying Theorem 1.2 and a standard covering argument, we find that for every open subset $\Omega_{0} \Subset \Omega$ and any number $k>0$, there exists a constant $c \equiv c\left(\operatorname{data}\left(\Omega_{0}\right), k\right)$ such that

for some constant $c \equiv c\left(\operatorname{data}\left(\Omega_{0}\right)\right)$ and $s_{1} \equiv s_{1}($ data $)$, where

q(R):= \begin{cases}R^{\frac{\alpha \delta}{(1+\delta)\left(1+s\left(H_{a}\right)\right)}}+R^{\frac{\beta \delta}{(1+\delta)\left(1+s\left(H_{b}\right)\right)}} & \text { if }(1.21 \mathrm{a}) \text { is assumed }  \tag{9.3}\\ R^{\frac{\alpha \gamma}{1+s\left(H_{a}\right)}}+R^{\frac{\beta \gamma}{1+s\left(H_{b}\right)}} & \text { if }(1.21 \mathrm{~b}) \text { is assumed } \\ R^{\frac{\alpha}{2\left(1+s\left(H_{a}\right)\right)}}+R^{\frac{\beta}{2\left(1+s\left(H_{b}\right)\right)}} & \text { if }(1.21 \mathrm{c}) \text { is assumed }\end{cases}
$$

in which $\gamma$ is the Hölder continuity exponent determined via Theorem 5.2 and $\delta$ is the higher integrability exponent coming from Theorem 5.5. We denote by

and $x_{a}, x_{b} \in \overline{B_{R}}$ are points such that $a\left(x_{a}\right)=\inf _{x \in B_{R}} a(x)$ and $b\left(x_{b}\right)=\inf _{x \in B_{R}} b(x)$. Now choosing $k \equiv d / 4$ in (9.1), the inequality (9.2) can be written as

for some constant $c \equiv c\left(\operatorname{data}\left(\Omega_{0}\right)\right)$, where we again recall that the function $h$ has been defined via Lemma 7.4 and Lemma 8.1. Recalling, (7.106) and (8.29), we have the energy estimate

with a constant $c \equiv c(n, \nu, L)$. Now using repeatedly (2.10), we have

& \quad \leqslant c\left(f_{B_{R / 8}} \Psi_{B_{R}}^{-}(|D u|+|D h|) \frac{|D u-D h|^{2}}{(|D u|+|D h|)^{2}} d x\right)^{\frac{1}{2}}\left(f_{B_{R / 8}} \Psi_{B_{R}}^{-}(|D u|+|D h|) d x\right)^{\frac{1}{2}}  \tag{9.7}\\
& \stackrel{(2.10),(9.5)}{\leqslant} c R^{3 d / 8}\left(f_{B_{R / 8}} \Psi_{B_{R}}^{-}(|D u|+|D h|) d x\right)^{(9.6),(9.1)} \stackrel{\leqslant}{\leqslant} c R^{d / 4}
\end{align*}

with $c \equiv c\left(\boldsymbol{d a t a}\left(\Omega_{0}\right)\right)$, where $d$ has been introduced in (9.3). Since $h$ is a minimizer of functional $\mathcal{F}_{0}$ defined in (7.103), and this functional satisfies the growth and ellipticity conditions (1.16) ${ }_{1,2}$ with $a(x) \equiv a\left(x_{a}\right)$ and $b(x) \equiv b\left(x_{b}\right)$, we are able to apply the theory in [65], which provides the gradient Hölder regularity with the estimates

whenever $0<\rho \leqslant R / 8$, where the constants $c$, $\beta_{1}$ depend only on $n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \nu, L$, but are independent of the values $a\left(x_{a}\right)$ and $b\left(x_{b}\right)$. Therefore, for every $0<\rho \leqslant R / 8$, we have

& \quad \stackrel{(9.1),(9.7)}{\leqslant} c\left(\frac{\rho}{R}\right)^{\beta_{1}} R^{-k}+c\left(\frac{R}{\rho}\right)^{n} R^{d / 4}
\end{align*}
$$

with $c \equiv c\left(\mathbf{d a t a}\left(\Omega_{0}\right), k\right)$. Notice that $k \in(0,1)$ is still arbitrary and $d$ has been defined in (9.3) depending only on data $\left(\Omega_{0}\right)$. Taking $k \equiv d \beta_{1} /(32 n)$ and $\rho \equiv(R / 8)^{1+d /(16 n)}$ in the last display, after some elementary manipulations, we get

By the integral characterization of Hölder continuity due to Campanato and Meyers and a standard covering argument alongside (9.11), $D u \in C_{\mathrm{loc}}^{0, \theta}(\Omega)$ for $\theta \equiv \frac{d \beta_{1}}{64 n}\left(1+\frac{1}{s(G)}\right)$. This proves the local Hölder continuity of $D u$. But the proof is not finished yet, since $\theta$ should be independent of $\Omega_{0}$ as in the statement of Theorem 1.1. In order to obtain the full completeness, we apply some standard perturbation methods. Indeed, once we have that $D u$ is locally bounded, we shall revisit the proof of Lemma 7.4 and Lemma 8.1. We also observe that the functional defined in (7.103) satisfies the bounded slope condition (see for instance [17]). Then there exists a constant $c \equiv c\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \nu, L,\|D u\|_{L^{\infty}\left(B_{R}\right)}\right)$ such that

Since $D u$ is locally bounded, following the proof of Lemma 7.1, Lemma 7.4 and Lemma 8.1, specially the estimate in (7.3) can be modified with $\gamma \equiv 1$. Moreover, the estimates in (8.28) and (7.105) can be upgraded by

with some constant $c \equiv c\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \nu, L,\|a\|_{L^{\infty}\left(\Omega_{0}\right)},\|b\|_{L^{\infty}\left(\Omega_{0}\right)},\|D u\|_{L^{\infty}\left(B_{2 R}\right)}\right)$. In particular, the last estimate via (9.7) implies that

where $\beta_{1}$ depends on $n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \nu, L$ while the constant $c$ depends only on $n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \nu$, $L,\|D u\|_{L^{\infty}\left(\Omega_{0}\right)},\|a\|_{L^{\infty}\left(\Omega_{0}\right)}$ and $\|b\|_{L^{\infty}\left(\Omega_{0}\right)}$. Combining the last two estimates similarly as shown in (9.9), we deduce the gradient Hölder continuity with the exponent depending only on $n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \nu, L, \alpha, \beta$ and $\mu$, which is the desired dependence as described in the statement. The proof is finally complete.

## 10. Orlicz double phase problems

Let us consider a general class of functionals with double phase growth, which is essentially the case when $b(\cdot) \equiv 0$ in (1.2). The functionals we shall deal with is of type

As we introduced before we assume $G, H_{a} \in \mathcal{N}$ with indices $s(G), s\left(H_{a}\right) \geqslant 1$ and $a(\cdot) \in C^{\omega_{a}}(\Omega)$ with $\omega_{a}:[0, \infty) \rightarrow[0, \infty)$ being a concave function such that $\omega_{a}(0)=0$. We shall consider a local minimizer $u$ of the functional $\mathcal{F}_{d}$ in (10.1) under one of the assumptions (1.12), (1.13) and (1.14) with $\omega_{b}(\cdot) \equiv 0$. Since the double sided growth assumption (10.3) is not enough for higher regularity properties of a local minimizer $u$ of the functional $\mathcal{F}_{d}$, we shall assume that $F_{d}$ is a continuous integrand belonging to the space $C^{2}\left(\mathbb{R}^{n} \backslash\{0\}\right)$ with respect to $z$-variable and having the the following structure assumptions:

The reason we consider the double phase case independently is that we have discussed the various regularity properties of the functional $\mathcal{F}$ in (1.9) in the sense of multi-phase of the type defined in (1.15) together with the structure assumptions (1.16), but this one is a special case of (10.1) together with the structure assumptions (10.4) in the sense of the double phase structures. Now we restate and prove Lemma 2.5 in the double phase settings which will be applied later.

The above theorems completely cover the main results of [13], where the special case that $G(t)=t^{p}$, $H_{a}(t)=t^{q}$ and $\omega_{a}(t)=t^{\alpha}$ with some constants $q \geqslant p>1$ and $\alpha \in(0,1]$ is considered. Also the results of [12] can be considered for a general class of functionals not only for the model functional in (1.4). Let us now briefly overview our arguments employed in proving the above theorems comparing with the ones used in $[12,13]$. We do not distinguish between the $G$-phase, where an inequality of the type $a(\cdot) \leqslant M \omega_{a}(R)$ is satisfied, and $\left(G, H_{a}\right)$-phase, where a complementary inequality $a(\cdot) \geqslant M \omega_{a}(R)$ holds in a certain ball $B_{R}$ under consideration for some suitable large constant $M$, which has a drawback to deal with the multi-phase type problems and even double phase type problems that we consider. Instead we consider the function $\left[\Psi_{d}\right]_{B_{R}}^{-}(\cdot)$ defined in (10.29) for a ball $B_{R} \subset \Omega$ under the investigation to obtain various estimates, and the advantage of considering this function is that $\left[\Psi_{d}\right]_{B_{R}}^{-} \in \mathcal{N}$ with an index $s\left(\Psi_{d}\right)=s(G)+s\left(H_{a}\right)$ by Remark 2.2 , which is independent of the considered ball $B_{R}$. Also the approach introduced in this paper may open a gate to study parabolic double phase equations of type

which would be one of attracting topics for the regularity theory in the future, we refer some recent results on this topic [19, 39]. Essentially, the idea of the proofs of Theorem 10.2 and Theorem 10.1 is based on the arguments previously used for proving Theorem 1.2 and Theorem 1.1, but the functional $\mathcal{F}_{d}$ in (10.1) is much more general than the functional $\mathcal{F}$ in (1.9) for the consideration under the double phase settings. In this regard, we need to take care of some points in more detail depending on the structure assumptions (10.4), specially Lemma 10.3 below. Since $u \in W^{1, \Psi_{d}}(\Omega)$ is a local $L / \nu$-minimizer of the functional $\mathcal{P}$ defined in (1.1) with $b(\cdot) \equiv 0$ if $u$ is a minimizer of the functional $\mathcal{F}_{d}$ in (10.1), we are able to rewrite the results
together with their proofs under the double phase settings up to the end of Section 6. Starting by Section 7, we shall investigate in a different way.

holds for some constants $\theta \equiv \theta\left(n, s(G), s\left(H_{a}\right)\right) \in(0,1)$ and $c \equiv c\left(\right.$ data $\left._{d}\right)$. The last display follows (10.23) by applying a variant of Gehring's lemma.

At this stage, we do not need to consider Lemma 7.2 because we shall freeze $x$-variable in the non-linearity at once. For this, let us consider the excess functional given by

\int_{B_{\tau R}}\left[\Psi_{d}\right]_{B_{R}}^{-}\left(\left|\frac{u-(u)_{B_{\tau R}}}{\tau R}\right|\right) d x \leqslant c\left(\tau^{n}+\tau^{-\left(s\left(\Psi_{d}\right)+1\right)} \varepsilon^{*}+\tau^{-\left(s\left(\Psi_{d}\right)+1\right)}\left[\omega\left(R^{\gamma}\right)\right]^{\frac{1}{2}}\right) \int_{B_{2 R}} \Psi_{d}(x,|D u|) d x
$$

for every $\tau \in(0,1 / 16)$ and some $c \equiv c\left(\operatorname{data}_{d}\left(\Omega_{0}\right)\right)$. Then we choose $\varepsilon^{*} \equiv \varepsilon_{*} / 2$ and $R_{*} \leqslant R^{*}$ in such a way that $\left[\omega\left(R_{*}^{\gamma}\right)\right]^{\frac{1}{2}} \leqslant \varepsilon_{*} / 2$. This choice gives us the dependence as described in (10.93) and yields (10.94).

We have now discovered all the necessary tools. They are Lemma 10.2, Lemma 10.3 and Lemma 10.5 in the double phase settings for proving Theorem 10.1 and Theorem 10.2. Applying those lemmas with arguing in a similar manner as in the proofs of Theorem 1.2 and Theorem 1.1, we are able to prove Theorem 10.1 and Theorem 10.2. For the sake of the completeness, we provide a sketch of the proofs.

Proof of Theorem 10.2. The proof of Theorem 10.2 can be done similarly as for the proof of Theorem 1.2. We just combine Lemma 5.3 under the double phase settings and Lemma 10.5, as we already have done in (8.1)-(8.27).

Lemma 10.6. Under the assumptions and notations of Lemma 10.3 and Lemma 10.4, let $w \in W^{1, \Psi_{d}}\left(B_{R}\right)$ be the function defined in (10.17). Suppose that (10.13c) is satisfied for $\omega_{a}(t)=t^{\alpha}$ with some $\alpha \in(0,1]$. Then there exists a function $h \in w+W_{0}^{1,\left[\Psi_{d}\right]_{B_{R}}^{-}}\left(B_{R / 8}\right)$ being a local minimizer of the functional $\mathcal{F}_{0}$ defined in (10.85) such that

for some constant $c \equiv c\left(\boldsymbol{d a t a}_{d}\left(\Omega_{0}\right)\right)$ and $s_{1} \equiv s_{1}\left(\boldsymbol{d a t a}_{d}\right)$, respectively. Moreover, the energy estimate

We consider a function $\bar{h} \in \bar{w}+W_{0}^{1, \bar{\Psi}_{0}}\left(B_{1 / 8}\right)$ satisfying (10.81)-(10.84) with the term $D(\varepsilon, R)$ replaced by $Q_{3}(R)$ defined above. Let $h$ be the scaled back function of $\bar{h}$ in $B_{R / 8}$ as

for some constant $c \equiv c\left(\operatorname{data}_{d}\left(\Omega_{0}\right)\right)$, where we have applied the Sobolev-Poincaré inequality and (10.91). Combining this estimate together with (10.18) via some elementary computations implies (10.96).

Proof of Theorem 10.1. It follows from Theorem 10.2 and a standard covering argument that, for every open subset $\Omega_{0} \Subset \Omega$ and any number $k>0$, there exists a constant $c \equiv c\left(\operatorname{data}_{d}\left(\Omega_{0}\right), k\right)$ such that

in which $\gamma$ is the Hölder continuity exponent determined via Theorem 5.2 under the double phase settings and $\delta_{0}$ is the higher integrability exponent coming from Lemma 10.2. Denoting by

and choosing $k \equiv d / 4$ in (10.106), the inequality (10.107) can be written as

## 11. REGULARITY RESULTS UNDER ADDITIONAL INTEGRABILITY

We turn our attention to studying properties of a local $Q$-minimizer of the functional $\mathcal{P}$ defined in (1.1) under some additional Lebesgue integrability assumption. We shall consider a local $Q$-minimizer $u$ of the functional $\mathcal{P}$ under the following assumptions:

u \in W^{1, \Psi}(\Omega) \cap L^{\kappa}(\Omega) \quad(\kappa \geqslant 1)  \tag{11.1}\\
\lambda_{4}(\kappa):=\sup _{t>0} \Lambda\left(t^{\frac{\kappa}{n+\kappa}}, \frac{1}{t}\right)<\infty
\end{array}\right.
$$

where the function $\Lambda:(0, \infty) \times(0, \infty) \rightarrow(0, \infty)$ has been defined in (1.11) together with $\omega_{a}, \omega_{b}:[0, \infty) \rightarrow$ $[0, \infty)$ being concave functions vanishing at the origin such that $a(\cdot) \in C^{0, \omega_{a}}(\Omega)$ and $b(\cdot) \in C^{0, \omega_{b}}(\Omega)$. To see the meaning of the assumption $(11.1)_{2}$, let us consider the standard double phase that $G(t)=t^{p}, H_{a}(t)=t^{q}$
and $\omega_{a}(t)=t^{\alpha}, \omega_{b} \equiv 0$ for $1<p \leqslant q$ and $\alpha \in(0,1]$. Under these standard double phase settings, the assumption $(11.1)_{2}$ is equivalent to the following one:

A local $Q$-minimizer $u \in W^{1, \Psi}(\Omega)$ implies that $u \in W^{1, p}(\Omega)$. It is clearly interesting point that $p<n$, otherwise we can prove $u \in L_{\text {loc }}^{\infty}(\Omega)$ by using Morrey-Embedding properties for $p>n$ and using a higher integrability for $p=n$. Then, for $1<p<n$, applying Sobolev embedding properties, one can see that $u \in L_{\text {loc }}^{\frac{n p}{n-p}}(\Omega)$. Choosing $\kappa \equiv \frac{n p}{n-p}$, the condition (11.2) is equivalent to the following one

q \leqslant p+\frac{\alpha p}{n}
$$

which generates the same condition as (1.6a), as we have discussed in the introduction part. Now if $\kappa>\frac{n p}{n-p}$, then we would have

which tells us the possible range of $q$ is larger than the one in (1.6a). Considering a local $Q$-minimizers of the functional $\mathcal{P}$ under the assumption (11.1), we shall show that $u \in L_{\mathrm{loc}}^{\infty}(\Omega)$. To do this, we start by proving a Sobolev-Poincaré inequality under the assumption $(11.1)_{2}$.

Theorem 11.1. Let $v \in W^{1, \Psi}\left(B_{R}\right) \cap L^{\kappa}\left(B_{R}\right)$ for a ball $B_{R} \subset \Omega$ with $R \leqslant 1$ under the assumption $(11.1)_{2}$. Then, for any $d \in\left[1, \frac{n(n+\kappa)}{n(n+\kappa)-\kappa}\right)$, there exist constants $\theta \equiv \theta\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \kappa, d\right) \in(0,1)$ and $c \equiv c\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \omega_{a}(1), \omega_{b}(1), \kappa, d\right)$ such that the following Sobolev-Poincaré-type inequality holds:

Moreover, the above estimate (11.3) is still valid with $v-(v)_{B_{R}}$ replaced by $v$ if $v \in W_{0}^{1, \Psi}\left(B_{R}\right) \cap L^{\kappa}\left(B_{R}\right)$.
Proof. Note that the above theorem covers [75, Theorem 3.1], which is a special case when $G(t)=t^{p}$, $H(t)=t^{q}, \omega_{a}(t)=t^{\alpha}$ and $\omega_{b}(\cdot) \equiv 0$ for some constants $1<p \leqslant q$ and $\alpha \in(0,1]$. Also our proof is much more elementary comparing with the approach used there. Using the continuity of the coefficient functions $a(\cdot)$ and $b(\cdot)$ and arguing in the same way as in (4.6), we find

& +3\left(f_{B_{R}}\left[\Psi_{B_{R}}^{-}\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{d} d x\right)^{\frac{1}{d}} \\
= & 6[a]_{\omega_{a}} I_{1}+6[b]_{\omega_{b}} I_{2}+3 I_{3}

We now shall deal with estimating the terms $I_{i}$ with $i \in 1,2,3$ in (11.5) using the additional a priori assumption $u \in L^{\kappa}\left(B_{R}\right)$ under (11.1) $)_{2}$. In turn, using (2.2) and the assumption (11.1) , we see

& \leqslant \lambda_{4}(\kappa) \omega_{a}(R)\left(f_{B_{R}}\left[\left(1+\left[\omega_{a}\left(\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)^{-\frac{\kappa}{n+\kappa}}\right)\right]^{-1}\right) G\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{d} d x\right)^{\frac{1}{d}} \\
& \leqslant \lambda_{4}(\kappa) \omega_{a}(R)\left(f_{B_{R}}\left[\left(1+\left[\frac{1}{\omega_{a}(R)}+\frac{R}{\omega_{a}(R)}\left|\frac{v-(v)_{B_{R}}}{R}\right|^{\frac{\kappa}{n+\kappa}}\right]\right) G\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{d} d x\right)^{\frac{1}{d}} \\
& \leqslant c_{*} \lambda_{4}(\kappa)\left(f_{B_{R}}\left[G\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{d} d x\right)^{\frac{1}{d}} \\

for the constant $c_{*}=2\left(1+\omega_{a}(1)\right)$. Using Hölder's inequality with conjugate exponents $\left(\frac{n+\kappa}{d}, \frac{n+\kappa}{n+\kappa-d}\right)$, we have

& +c \lambda_{4}(\kappa)\left(\int_{B_{R}}|v|^{\kappa} d x\right)^{\frac{1}{n+\kappa}}\left(f_{B_{R}}\left[G\left(\left|\frac{v-(v)_{B_{R}}}{R}\right|\right)\right]^{\frac{(n+\kappa) d}{n+\kappa-d}} d x\right)^{\frac{n+\kappa-d}{(n+\kappa) d}}
\end{aligned}
$$

for some constant $c \equiv c\left(n, \omega_{a}(1), \omega_{b}(1)\right)$. Now we apply Lemma 4.1 to $\Phi \equiv G$ with $d_{0} \equiv d$ and $d_{0} \equiv \frac{n+\kappa-d}{(n+\kappa) d}$ in order to have an exponent $\theta_{1} \equiv \theta_{1}(n, s(G), \kappa, d) \in(0,1)$ such that

holds for some constant $c \equiv c\left(n, s(G), \omega_{a}(1), \omega_{b}(1), \kappa, d\right)$. On the other hand, since $\Psi_{B_{R}}^{-} \in \mathcal{N}$ with an index $s(\Psi)=s(G)+s\left(H_{a}\right)+s\left(H_{b}\right)$ by Remark 2.2, we are able to apply Lemma 4.1 with $\Phi \equiv \Psi_{B_{R}}^{-}$for $d_{0} \equiv d$. In
turn, there exists $\theta_{2} \equiv \theta_{2}(n, s(\Psi), d)$ such that

with some constant $c \equiv c(n, s(\Psi), d)$. Taking into account the estimates obtained in (11.6)-(11.7) into (11.5), recalling the very definition of $\Psi_{B_{R}}^{-}$in (2.3) and setting $\theta:=\max \left\{\theta_{1}, \theta_{2}\right\}$, we arrive at (11.3). The proof is finished.

Remark 11.1. We here remark that choosing $d \equiv 1$ in a Sobolev-Poincaré type inequality of Theorem 11.1, we see that there exists an exponent $\theta \equiv \theta\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \kappa\right)$ such that

holds for some constant $c \equiv c\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \omega_{a}(1), \omega_{b}(1), \kappa\right)$, where $\lambda_{s p}$ is the one same as in (11.4).
Remark 11.2. With $u \in W^{1, \Psi}(\Omega)$ being a local $Q$-minimizer of the functional $\mathcal{P}$, we here point out that it is also possible to suppose a priori $u \in W^{\Phi}(\Omega)$ for some Young function $\Phi$. In this case, discovering a relevant assumption like $(11.1)_{2}$ would be an interesting point to find how it is connected to Embedding properties in Orlicz-Sobolev spaces [26, 27, 28] likewise we have discussed above in Lebesgue settings. Moreover, proving various regularity results under a new relevant condition may generate a different phenomenon even for a Lavrentiev gap. We can also a priori assume that local $Q$-minimizers belong to certain Campanato, BMO, VMO, or some other spaces. Under all those a priori assumptions, it should be necessary to discover out the relevant optimal conditions under which various regularity results are obtainable.

For a local $Q$-minimizer $u$ of the functional $\mathcal{P}$ under the assumption (11.1), the data of the problem is understood by the following set of parameters:

As usual, for any open subset $\Omega_{0} \Subset \Omega$, we denote by $\operatorname{data}_{i}\left(\Omega_{0}\right)$ the set of parameters defined above together with $\operatorname{dist}\left(\Omega_{0}, \partial \Omega\right)$. Now we focus on showing local boundedness estimates of a local $Q$-minimizer $u$ of the functional $\mathcal{P}$ in (1.1) under the assumption (11.1).
Theorem 11.2. Let $u \in W^{1, \Psi}(\Omega)$ be a local $Q$-minimizer of the functional $\mathcal{P}$ in (1.1) under the assumption (11.1). Then there exists a constant $c \equiv c\left(\boldsymbol{d a t a}_{i}\right)$ such that

\end{equation*}

whenever $B_{R} \equiv B_{R}\left(x_{0}\right) \subset \Omega$ is a ball with $R \leqslant 1$. In particular, $u \in L_{\mathrm{loc}}^{\infty}(\Omega)$.
Proof. The meaning of $\operatorname{data}_{i}$ under the assumption (11.1), already has been introduced in (11.9). As in the proof of Theorem 5.1, we consider the following scaled functions as:

& \bar{A}(k, s):=B_{s}(0) \cap\{\bar{u}>k\} \quad \text { and } \quad \bar{B}(k, s):=B_{s}(0) \cap\{\bar{u}<k\}
\end{align*}

for every $x \in B_{1}(0), t \geqslant 0, s \in(0,1)$ and $k \in \mathbb{R}$. The remaining part of the proof consists of 3 steps as in the proof of Theorem 5.1.

Step 1: Sobolev-Poincaré under the scaling in (11.12). In this step, we prove that there exists a positive exponent $\theta \equiv \theta\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \kappa\right) \in(0,1)$ such that

for some constant $c \equiv c\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \omega_{a}(1), \omega_{b}(1), \kappa\right)$, whenever $f \in W_{0}^{1, \bar{\Psi}}\left(B_{1}\right) \cap L^{\kappa}\left(B_{1}\right)$, where

Using the continuity properties of $\bar{a}(\cdot)$ and $\bar{b}(\cdot)$, we see

& \leqslant 2[a]_{\omega_{a}} \omega_{a}(R) \int_{B_{1}} H_{a}(|f|) d x+2[b]_{\omega_{b}} \omega_{b}(R) \int_{B_{1}} H_{b}(|f|) d x+\int_{B_{1}} \bar{\Psi}_{B_{1}}^{-}(|f|) d x \\
& =: 2[a]_{\omega_{a}} I_{1}+2[b]_{\omega_{b}} I_{2}+I_{3},
\end{aligned}
$$

where

\bar{\Psi}_{B_{1}}^{-}(t):=G(t)+\inf _{x \in B_{1}} \bar{a}(x) H_{a}(t)+\inf _{x \in B_{1}} \bar{b}(x) H_{b}(t) \quad \text { for every } \quad t \geqslant 0
$$

Now we estimate the terms $I_{i}$ for $i \in\{1,2,3\}$ similarly as in the proof of Theorem 11.1. In turn, using the assumption (11.1) ${ }_{2}$ and (2.2), we have

& \leqslant \lambda_{4}(\kappa) \omega_{a}(R) \int_{B_{1}}\left(1+\left[\frac{1}{\omega_{a}(R)}+\frac{R}{\omega_{a}(R)}|f|^{\frac{\kappa}{n+\kappa}}\right]\right) G(|f|) d x \\
& \leqslant \lambda_{4}(\kappa)\left(1+\omega_{a}(1)\right) \int_{B_{1}} G(|f|) d x+2 \lambda_{4}(\kappa) R \int_{B_{1}}|f|^{\frac{\kappa}{n+\kappa}} G(|f|) d x
\end{aligned}

Arguing in the same way, we have

Then the inequality (11.13) follows from the arguments used in the proof of Theorem 11.1 and Lemma 4.1.
Step 2. Proof of (11.10). Since $u-(u)_{B_{R}}$ is a local $Q$-minimizer of the functional $\mathcal{P}$ in (1.1), using a Caccioppoli inequality of Lemma 5.1, one can see that

Let us now consider the concentric balls $B_{\rho} \Subset B_{t} \Subset B_{s}$ with $1 / 2 \leqslant \rho<s \leqslant 1$ and $t:=(\rho+s) / 2$. Let $\eta \in C_{0}^{\infty}\left(B_{t}\right)$ be a
standard cut-off function such that $\chi_{B_{\rho}} \leqslant \eta \leqslant \chi_{B_{t}}$ and $|D \eta| \leqslant \frac{2}{t-\rho}=\frac{4}{s-\rho}$. Now we apply inequality (11.13) from Step 1 above in order to have a positive exponent $\theta \equiv \theta\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \kappa\right)$ such that

for some constant $c \equiv c\left(n, s(G), s\left(H_{a}\right), s\left(H_{b}\right), \omega_{a}(1), \omega_{b}(1), \kappa\right)$, where

\left.\bar{\kappa}_{s p}=1+\left([a]_{\omega_{a}}+[b]_{\omega_{b}}\right)\left(\lambda_{4}(\kappa)+\lambda_{4}(\kappa) R\left(\int_{B_{1}}\left[\eta(\bar{u}-k)_{+}\right)\right]^{\kappa} d x\right)^{\frac{1}{n+\kappa}}\right)
$$

By recalling the definition of $\bar{u}$ in (11.12), we have

with a constant $c \equiv c\left(n, \lambda_{4}(\kappa),[a]_{\omega_{a}}+[b]_{\omega_{b}}\right)$. Once we arrive at this stage the rest of the proof can be proceed in the same way as in the proof of Theorem 5.1.

Theorem 11.3. Let $u \in W^{1, \Psi}(\Omega)$ be a local $Q$-minimizer of the functional $\mathcal{P}$ defined in (1.1) under the coefficient functions $a(\cdot) \in C^{\omega_{a}}(\Omega)$ and $b(\cdot) \in C^{\omega_{b}}(\Omega)$ for $\omega_{a}, \omega_{b}$ being non-negative concave functions vanishing at the origin. If the assumption (11.1) is satisfied, then for for every open subset $\Omega_{0} \Subset \Omega$, there exists a Hölder continuity exponent $\gamma \equiv \gamma\left(\boldsymbol{\operatorname { d a t a }}_{i}\left(\Omega_{0}\right)\right) \in(0,1)$ such that

and the oscillation estimate

holds for some $c \equiv c\left(\boldsymbol{d a t a}_{i}\left(\Omega_{0}\right)\right)$ and all concentric balls $B_{\rho} \Subset B_{R} \Subset \Omega_{0} \Subset \Omega$ with $R \leqslant 1$.
Proof. First let us observe that, for every $t \geqslant 1$, we have

& \leqslant 1+\frac{1}{\omega_{a}\left(t^{\frac{\kappa}{n+\kappa}}\right)} \leqslant 1+\frac{1}{\omega_{a}(1)}
\end{aligned}

This same inequality holds true also for $\omega_{b}$. Therefore, for every $t \geqslant 1$, we see that

& \leqslant \lambda_{4}(\kappa)\left(1+\frac{1}{\omega_{a}(1)}+\frac{1}{\omega_{b}(1)}\right)=: \lambda_{2}
\end{aligned}
$$

where we have used the assumption $(11.1)_{2}$. On the other hand, recalling that the functions $\omega_{a}$ and $\omega_{b}$ are increasing, we have

for every $t \in(0,1]$. Recalling that $u \in L_{\mathrm{loc}}^{\infty}(\Omega)$ by Theorem 11.2 and taking into account the last two displays, we are able to apply Theorem 5.2 in order to have (11.15) and (11.16).

Remark 11.3. As a consequence of the last two theorems like we have that if $u \in W^{1, \Psi}(\Omega)$ is a local $Q$-minimizer of the functional $\mathcal{P}$ under the assumption (11.1), then $u \in L_{\mathrm{loc}}^{\infty}(\Omega)$ and $(1.13)_{2}$ is satisfied. Therefore, the results of Theorem 1.1, Theorem 1.2, Theorem 10.1 and Theorem 10.2 are still available under the assumption (11.1). Furthermore, the results of the present section can be considered under multiphase settings, as we have pointed out in Remark 1.1.
