# MULTIPLICITY OF SOLUTIONS FOR A CLASS OF QUASILINEAR PROBLEMS INVOLVING THE 1-LAPLACIAN OPERATOR WITH CRITICAL GROWTH

#### Abstract

The aim of this paper is to establish two results about multiplicity of solutions to problems involving the 1-Laplacian operator, with nonlinearities with critical growth. To be more specific, we study the following problem $$
\left\{\begin{array}{l} -\Delta_{1} u+\xi \frac{u}{u \mid}=\left.\lambda|u|\right|^{q-2} u+|u|^{1^{*}-2} u, \quad \text { in } \Omega, \\ u=0, \quad \text { on } \partial \Omega . \end{array}\right.
$$ where $\Omega$ is a smooth bounded domain in $\mathbb{R}^{N}, N \geq 2$ and $\xi \in\{0,1\}$. Moreover, $\lambda>0, q \in\left(1,1^{*}\right)$ and $1^{*}=\frac{N}{N-1}$. The first main result establishes the existence of many rotationally non-equivalent and nonradial solutions by assuming that $\xi=1$, $\Omega=\left\{x \in \mathbb{R}^{N}: r<|x|<r+1\right\}, N \geq 2, N \neq 3$ and $r>0$. In the second one, $\Omega$ is a smooth bounded domain, $\xi=0$, and the multiplicity of solutions is proved through an abstract result which involves genus theory for functionals which are sum of a $C^{1}$ functional with a convex lower semicontinuous functional.


## 1. Introduction

In this work we are concerned with the existence of multiple solutions for the following class of problem

-\Delta_{1} u+\xi \frac{u}{|u|}=\lambda|u|^{q-2} u+|u|^{1^{*}-2} u, \quad \text { in } \Omega  \tag{1.1}\\
u=0, \quad \text { on } \partial \Omega
\end{array}\right.
$$

where $\Omega$ is a smooth bounded domain in $\mathbb{R}^{N}, q \in\left(1,1^{*}\right), \xi \in\{0,1\}, \lambda>0$ and $1^{*}=\frac{N}{N-1}$ for $N \geq 2$.

Problem (1.1) looks as the formal limit, as $p \rightarrow 1^{+}$, of

-\Delta_{p} u+\xi|u|^{p-2} u=\lambda|u|^{q-2} u+|u|^{p^{*}-2} u, \quad \text { in } \Omega,  \tag{1.2}\\
u=0, \quad \text { on } \partial \Omega,
\end{array}\right.
$$

where $p^{*}=\frac{N p}{N-p}$ for $N \geq p$.
The interest in this sort of problem has started with the celebrated paper of Brézis and Nirenberg [16], in which the authors proved that, for $p=q=2$ and $\xi=0$, (1.2) admits a positive solution for every $\lambda \in\left(0, \lambda_{1}\right)$ and $N \geq 4$. Later, this result has been extended for $p>1$ by Egnell [26], García Azorero and Peral Alonso [31] and Gueda and Veron [32].

[^0]As far as works involving the 1 -Laplacian operator are regarded, some of the pioneering works involving this operator were written by Andreu, Ballesteler, Caselles and Mazón in a series of papers (among them [8-10]), which gave rise to the monograph [11]. Indeed, in [8], the authors characterize the imprecise quotient $\frac{D u}{|D u|}$ (when $D u$ is just a Radon measure, rather than an $L^{1}$ function), through the Pairing Theory of Anzellotti (see [12] and also [11]). This theory allows them to introduce a vector field $\mathbf{z} \in L^{\infty}\left(\Omega, \mathbb{R}^{N}\right)$ which plays the role of $\frac{D u}{|D u|}$. Among the very first works on this issue we could also cite the works of Kawohl [34] and also Demengel [22], where in the later, the author used the symmetry of the domain to get nodal solutions to problems involving the 1-Laplacian operator and a nonlinearity with critical growth.

In [25], Degiovanni and Magrone studied the version of the Brézis-Nirenberg problem to the 1-Laplacian operator, by applying a linking theorem. In that work, for compactness issues, they worked with an extension of the energy functional to the Lebesgue space $L^{1^{*}}(\Omega)$.

In [27], Figueiredo and Pimenta studied a problem related to (1.1), where the nonlinearity has a subcritical growth. In their main result, an approach based on the Nehari method has been developed in order to obtain ground-state solutions.

Regarding quasilinear problems of this type, the natural space to deal with it is the space of functions of bounded variation, $B V(\Omega)$. More specifically, when dealing with this sort of problems through variational methods, some difficulties related to the PalaisSmale condition arise. Moreover, other ones related to the lack of smoothness of the energy functional and to the lack of reflexiveness of $B V(\Omega)$, arise as well.

In this work, we exploit some facts and ideas from the above papers, especially from [22] to show the existence of multiple nontrivial solutions to (1.1). Our goal is twofold. First, we establish the existence of many rotationally non-equivalent and nonradial solutions for the above problem (1.1) with $\xi=1$, involving a nonlinearity with critical growth in the case when

\Omega=\Omega_{r}=\left\{x \in \mathbb{R}^{N}: r<|x|<r+1\right\} . \tag{1.3}
\end{equation*}
$$

Afterwards, we study (1.1) by assuming that $\Omega$ is a smooth bounded domain in $\mathbb{R}^{N}$ and $\xi=0$. In this case, we prove the existence of multiple many solutions, by applying a version of an abstract result in [44].

The existence of many rotationally non-equivalent and nonradial solutions was considered in some problems involving the Laplacian operator. In Brézis and Nirenberg [16], it was proved the existence of a non-radial positive solution for the following problem

-\Delta u+u-u^{p}=0, \quad \text { in } D,  \tag{1.4}\\
u=0, \quad \text { on } \partial D,
\end{array}\right.
$$

where

$$
D=\left\{x \in \mathbb{R}^{N}: r<|x|<r+d\right\}
$$

for some $d>0$. In [21], Coffman proved that, if $p>1$ and $N=2$ or $1<p<N /(N-2)$ and $N \geq 3$, the number of nonradial and rotationally non-equivalent positive solutions of (1.4), tends to $+\infty$ as $r \rightarrow+\infty$.

Motivated by the above papers, some authors have studied this class of problems. For the subcritical case, we can mention the papers of Li [35], Lin [36], Suzuki [45] and references therein. Related to the critical case, Wang and Willem [46] proved the existence of multiple solutions for the following problem

-\Delta u=\lambda u+u^{2^{*}-1}, \quad \text { in } \Omega_{r},  \tag{1.5}\\
u=0, \quad \text { on } \partial \Omega_{r},
\end{array}\right.
$$

where $\Omega_{r}$ is given in (1.3). The authors proved that for $0<\lambda<\pi^{2}$ and $n \in \mathbb{N}$, there exists $R(\lambda, n)$ such that for $r>R(\lambda, n),(1.5)$ has at least $n$ nonradial and rotationally non-equivalent solutions. Inspired by [46], de Figueiredo and Miyagaki [23] considered the following problem

-\Delta u=f(|x|, u)+u^{2^{*}-1}, \quad \text { in } \Omega_{r},  \tag{1.6}\\
u=0, \quad \text { on } \partial \Omega_{r},
\end{array}\right.
$$

where $f$ is a $C^{1}$ function with subcritical growth.
Still related to this class of problem, we would like to cite the papers of Alves and de Freitas [3], Byeon [15], Castro and Finan [17], Catrina and Wang [18], Mizoguchi and Suzuki [39], Hirano and Mizoguchi [33] and references therein.

Motivated by the works previously mentioned and more precisely, by [23], [25] and [46], our first main result is the following.

Theorem 1.1. For each $n \in \mathbb{N}$ there is $r_{0}>0$ and $\lambda_{0}>0$ such that for all $\lambda \geq \lambda_{0}$ and $r \geq r_{0}$, (1.1) for $\xi=1$ has at least $n$ nonradial and rotationally non-equivalent solutions.

In what follows, according to Degiovanni and Magrone [25] and Kawohl and Schuricht [13], we say that $u \in B V\left(\Omega_{r}\right)$ is a solution to (2.1) if there are $z \in L^{\infty}\left(\Omega_{r}, \mathbb{R}^{N}\right)$ and $\gamma \in L^{\infty}\left(\Omega_{r}, \mathbb{R}\right)$ such that

|z|_{\infty} \leq 1, \quad \operatorname{div} z \in L^{N}\left(\Omega_{r}\right), \quad-\int_{\Omega_{r}} u \operatorname{div} z d x=\int_{\Omega_{r}}|D u|+\int_{\partial \Omega_{r}}|u| d \mathcal{H}^{N-1}  \tag{1.7}\\
|\gamma|_{\infty} \leq 1, \quad \gamma|u|=u \quad \text { a.e. in } \quad \Omega_{r}, \\
-\operatorname{div} z+\gamma=\lambda|u|^{q-2} u+|u|^{1^{*}-2} u, \quad \text { a.e. in } \Omega_{r} .
\end{array}\right.
$$

Our second main result was motivated by the study made in Wei and Wu [47], where the authors showed the existence of multiple solution for the following class of problems involving the $p$-Laplacian operator

$$
\left\{\begin{array}{l}
-\Delta_{p} u=f(x, u)+\lambda|u|^{p^{*}-2} u, \quad \text { in } \Omega,  \tag{1.8}\\
u=0, \quad \text { on } \partial \Omega,
\end{array}\right.
$$

where $\Omega$ is a smooth bounded domain, $\lambda$ is a positive parameter and $f$ is continuous, with subcritical growth. In this work, the authors used a version of an abstract theorem due to Ambrosetti and Rabinowitz [7] which involves the genus theory for $C^{1}$ even functionals. Their main result proves that given $n \in \mathbb{N}$, there is $\lambda_{*}=\lambda_{*}(n)>0$ such that problem (1.8) has at least $n$ nontrivial solutions for $\lambda \in\left(0, \lambda_{*}\right)$. In [42], Silva and Xavier improved the main results proved in [47].

Our main second result has the following statement.

Theorem 1.2. Given $n \in \mathbb{N}$, there is $\lambda_{n}>0$ such that (1.1) for $\xi=0$ has at least $n$ nontrivial solutions for $\lambda \geq \lambda_{n}$.

We would like to point out that in the proof of Theorems 1.1 and 1.2 we cannot use the classical variational methods for $C^{1}$ functionals, since problems involving the 1-Laplacian operator have energy functionals which are not $C^{1}$. This, in turn, brings a lot of difficulties for deal with the problem. In order to overcome this difficulty, we use the minimax methods developed by Szulkin in [44], which works well for functionals that can be written as the sum of a $C^{1}$ functional with a convex lower semicontinuous one. Finally, we would like to point out that $\xi=1$ in Theorem 1.1 is very important, because in our approach it was necessary to work with some sequences in $B V\left(\mathbb{R}^{N}\right)$ (see the proof of Lemma 2.5).

Before concluding this introduction, for those readers interested in problems involving the 1-Laplacian operator, we would like to cite Alves [1, 2], Alves and Pimenta [4], Alves, Figueiredo and Pimenta [5], Bellettini, Caselles and Novaga [14], Chang [20], Demengel [24], Figueiredo and Pimenta [29, 30], Mercaldo, Rossi, Segura de León and Trombetti [37], Mercaldo, Segura de León and Trombetti [38], Molino Salas and Segura de León [40], Ortiz Chata and Pimenta [41].

## 2. Existence of nonradial solutions

In this section, we prove Theorem 1.1, which establishes the existence of many rotationally non-equivalent and nonradial solutions for the following problem

$$
\left\{\begin{array}{l}
-\Delta_{1} u+\frac{u}{|u|}=\lambda|u|^{q-2} u+|u|^{*-2} u, \quad \text { in } \Omega_{r},  \tag{2.1}\\
u=0, \quad \text { on } \partial \Omega_{r},
\end{array}\right.
$$

where $\Omega_{r}=\left\{x \in \mathbb{R}^{N}: r<|x|<r+1\right\}, N \geq 2$ and $N \neq 3, r>0, \lambda>0, q \in\left(1,1^{*}\right)$ and $1^{*}=\frac{N}{N-1}$.

Associated with problem (2.1), we have the energy functional $I_{\lambda}: B V\left(\Omega_{r}\right) \rightarrow \mathbb{R}$ given by

I_{\lambda}(u)=\int_{\Omega_{r}}|D u| d x+\int_{\Omega_{r}}|u| d x+\int_{\partial \Omega_{r}}|u| d \mathcal{H}^{N-1}-\frac{\lambda}{q} \int_{\Omega_{r}}|u|^{q} d x-\frac{1}{1^{*}} \int_{\Omega_{r}}|u|^{1^{*}} d x .
$$

In the sequel, we say that $u \in B V\left(\Omega_{r}\right)$ is a solution of (2.1) if $0 \in \partial I_{\lambda}(u)$, where $\partial I_{\lambda}(u)$ denotes the generalized gradient of $I_{\lambda}$ in $u$, as defined in [19]. It is possible to prove that $0 \in \partial I_{\lambda}(u)$ if, and only if,

\|w\|_{r}-\|u\|_{r} \geq \int_{\Omega_{r}}\left(\lambda|u|^{q-2} u+|u|^{1^{*}-2} u\right)(w-u) d x, \quad \forall w \in B V\left(\Omega_{r}\right) \tag{2.2}
\end{equation*}
$$

where $B V\left(\Omega_{r}\right)$ denotes the space of functions of bounded variation.
We say that $u \in B V\left(\Omega_{r}\right)$, or $u$ is a function of bounded variation, if $u \in L^{1}\left(\Omega_{r}\right)$ and its distributional derivative $D u$ is a vectorial Radon measure, i.e.,

B V\left(\Omega_{r}\right)=\left\{u \in L^{1}\left(\Omega_{r}\right) ; D u \in \mathcal{M}\left(\Omega_{r}, \mathbb{R}^{N}\right)\right\}
$$

It can be proved that $u \in B V\left(\Omega_{r}\right)$ is equivalent to $u \in L^{1}\left(\Omega_{r}\right)$ and

$$
\int_{\Omega_{r}}|D u|:=\sup \left\{\int_{\Omega_{r}} u \operatorname{div} \phi d x ; \phi \in C_{c}^{1}\left(\Omega_{r}, \mathbb{R}^{N}\right), \text { s.t. }|\phi|_{\infty} \leq 1\right\}<+\infty .
$$

The space $B V\left(\Omega_{r}\right)$ is a Banach space endowed with the norm

$$
\begin{equation*}
\|u\|:=\int_{\Omega_{r}}|D u|+|u|_{L^{1}\left(\Omega_{r}\right)} . \tag{2.3}
\end{equation*}
$$

Moreover, the Sobolev embeddings hold also for this space and its embedding into $L^{r}(\Omega)$ is continuous for all $r \in\left[1,1^{*}\right]$ and compact for $r \in\left[1,1^{*}\right)$.

In this section, we will consider the following norm on $B V\left(\Omega_{r}\right)$,

$$
\|u\|_{r}=\int_{\Omega_{r}}|D u| d x+\int_{\Omega_{r}}|u| d x+\int_{\partial \Omega_{r}}|u| d \mathcal{H}^{N-1}
$$

which is equivalent to the norm (2.3), where $\mathcal{H}^{N-1}$ denotes the ( $N-1$ )-dimensional Hausdorff measure.

As one can see in [13], the space $B V\left(\Omega_{r}\right)$ has different convergence and density properties when compared with the usual Sobolev spaces. For instance, $C^{\infty}\left(\overline{\Omega_{r}}\right)$ is not dense in $B V\left(\Omega_{r}\right)$ with respect to the strong convergence. However, there is a weaker sense of convergence in $B V\left(\Omega_{r}\right)$, called intermediate convergence (or strict convergence), which makes $C^{\infty}\left(\overline{\Omega_{r}}\right)$ dense on it. We say that $\left(u_{n}\right) \subset B V\left(\Omega_{r}\right)$ converges to $u \in B V\left(\Omega_{r}\right)$ in the sense of the intermediate convergence if

u_{n} \rightarrow u \quad \text { in } \quad L^{1}\left(\Omega_{r}\right)
$$

and

$$
\int_{\Omega_{r}}\left|D u_{n}\right| \rightarrow \int_{\Omega_{r}}|D u| .
$$

In what follows, $O(N)$ denotes the group of $N \times N$ orthogonal matrices. For any integer $k \geq 1$, let us consider the finite rotational subgroup $O_{k}$ of $O(2)$ given by

O_{k}=\left\{g \in O_{2}: \quad g(x)=\left(x_{1} \cos \frac{2 \pi l}{k}+x_{2} \sin \frac{2 \pi l}{k},-x_{1} \sin \frac{2 \pi l}{k}+x_{2} \cos \frac{2 \pi l}{k}\right)\right\}
$$

where $x=\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2}$ and $l \in\{0,1, \ldots, k-1\}$. We also consider the subgroups of $O(N)$

G_{k}=O_{k} \times O(N-2), \quad 1 \leq k<\infty
$$

and

$$
G_{\infty}=O(N)
$$

Now related to the above subgroups, we set the subspaces

$$
B V_{G_{k}}\left(\Omega_{r}\right)=\left\{u \in B V\left(\Omega_{r}\right): \quad u(x)=u\left(g^{-1}(x)\right), \quad \text { for all } g \in G_{k}\right\}
$$

endowed with the norm $\|\cdot\|_{r}$.
From the compact embedding involving the space $B V\left(\Omega_{r}\right)$, it follows that the embedding

B V_{G_{k}}\left(\Omega_{r}\right) \hookrightarrow L^{t}\left(\Omega_{r}\right), \quad t \in\left[1,1^{*}\right) \tag{2.4}
\end{equation*}
$$

is compact for $1 \leq k<+\infty$ and

B V_{G_{\infty}}\left(\Omega_{r}\right) \hookrightarrow L^{t}\left(\Omega_{r}\right), \quad t \in[1,+\infty) \tag{2.5}
\end{equation*}
$$

is compact, see [6, Lemma 2.1].

Moreover, Figueiredo and Pimenta [28] proves that the embedding

B V_{G_{\infty}}\left(\mathbb{R}^{N}\right) \hookrightarrow L^{t}\left(\mathbb{R}^{N}\right), \quad t \in\left(1,1^{*}\right) \tag{2.6}
\end{equation*}

is compact as well.
In the sequel, for each $1 \leq k \leq \infty, J_{\lambda, k, r}$ denotes the following real numbers

J_{\lambda, k, r}=\inf _{\mathcal{N}_{k, r}} I_{\lambda},
$$

with

\mathcal{N}_{k, r}=\left\{B V_{G_{k}}\left(\Omega_{r}\right) \backslash\{0\} ; \quad E_{\lambda}(u)=0\right\},
$$

where

E_{\lambda}(u)=\int_{\Omega_{r}}|D u| d x+\int_{\Omega_{r}}|u| d x+\int_{\partial \Omega_{r}}|u| d \mathcal{H}^{N-1}-\lambda \int_{\Omega_{r}}|u|^{q} d x-\int_{\Omega_{r}}|u|^{1^{*}} d x . \tag{2.7}
\end{equation*}

The set $\mathcal{N}_{k, r}$ is called Nehari set associated with $I_{\lambda}$ (see [27] for a detailed description of this set). It is possible to prove that $J_{\lambda, k, r}$ is the mountain pass levels associated with $I_{\lambda}$ on $B V_{G_{k}}\left(\Omega_{r}\right)$ and $B V_{G_{\infty}}\left(\Omega_{r}\right)$, respectively. Hence, there is a $(P S)$ sequence $\left(u_{n}\right)$ associated to $J_{\lambda, k, r}$, i.e.,

$\|v\|_{r}-\left\|u_{n}\right\|_{r} \geq \int_{\Omega_{r}}\left(\lambda\left|u_{n}\right|^{q-2} u_{n}+\left|u_{n}\right|^{1^{*}-2} u\right)\left(v-u_{n}\right) d x-\tau_{n}\left\|v-u_{n}\right\|_{r}, \quad \forall v \in B V_{G_{k}}\left(\Omega_{r}\right)$.
The last inequality implies that

\left\|u_{n}\right\|_{r}=\int_{\Omega_{r}}\left(\lambda\left|u_{n}\right|^{q}+\left|u_{n}\right|^{1^{*}}\right) d x+o_{n}(1)\left\|u_{n}\right\|_{r} \tag{2.9}

Lemma 2.1. The sequence $\left(u_{n}\right)$ is bounded.
Proof. From (2.8) and (2.9),

J_{\lambda, k, r}+o_{n}(1)=I_{\lambda}\left(u_{n}\right)=I_{\lambda}\left(u_{n}\right)-\frac{1}{q}\left\|u_{n}\right\|_{r}+\frac{1}{q} \int_{\Omega_{r}}\left(\lambda\left|u_{n}\right|^{q}+\left|u_{n}\right|^{1^{*}}\right) d x+o_{n}(1)\left\|u_{n}\right\|_{r} .
$$

Then

J_{\lambda, k, r}+o_{n}(1) \geq \frac{(q-1)}{q}\left\|u_{n}\right\|_{r}-o_{n}(1)\left\|u_{n}\right\|_{r} \geq \frac{(q-1)}{2 q}\left\|u_{n}\right\|_{r}
$$

for $n$ large enough, showing the boundedness of the sequence.
Lemma 2.2. For each $\lambda>0$ fixed, there is $\eta=\eta(\lambda)>0$ that is independent of $k$ and $r>0$ such that $J_{\lambda, k, r} \geq \eta$ for $1 \leq k \leq \infty$.
Proof. For each $u \in \mathcal{N}_{k, r}$ we have that

In what follows, we define the function $\tilde{u}: \mathbb{R}^{N} \rightarrow \mathbb{R}$ given by

0, \quad x \in \Omega_{r}^{c} .

Hence,

\int_{\Omega_{r}}|u|^{q} d x=\int_{\mathbb{R}^{N}}|\tilde{u}|^{q} d x, \quad \int_{\Omega_{r}}|u|^{1^{*}} d x=\int_{\mathbb{R}^{N}}|\tilde{u}|^{1^{*}} d x
$$

and by properties of $B V\left(\mathbb{R}^{N}\right), \tilde{u} \in B V\left(\mathbb{R}^{N}\right)$ and

\int_{\mathbb{R}^{N}}|D \tilde{u}|=\int_{\Omega_{r}}|D u| d x+\int_{\partial \Omega_{r}}|u| d \mathcal{H}^{N-1}
$$

The definition of $\tilde{u}$ combined with (2.10) gives

\int_{\mathbb{R}^{N}}|D \tilde{u}|+\int_{\mathbb{R}^{N}}|\tilde{u}| d x=\lambda \int_{\mathbb{R}^{N}}|\tilde{u}|^{q} d x+\int_{\mathbb{R}^{N}}|\tilde{u}|^{1^{*}} d x \tag{2.12}
\end{equation*}

The function $\|\cdot\|: B V\left(\mathbb{R}^{N}\right) \rightarrow \mathbb{R}$ given by

\|w\|=\int_{\mathbb{R}^{N}}|D w|+|w|_{L^{1}\left(\mathbb{R}^{N}\right)} . \tag{2.13}
\end{equation*}
$$

is a norm in $B V\left(\mathbb{R}^{N}\right)$. Moreover, there are positive constants $C_{1}, C_{2}>0$ such that

2.1. Proof of Theorem 1.1. Given $n \in \mathbb{N}$, by Lemmas 2.4 and 2.5 we know that $J_{\lambda, 2^{n}, r}$ are critical levels of $I_{\lambda}$ with

$$
0<J_{\lambda, 2, r}<J_{\lambda, 2^{2}, r}<\ldots<J_{\lambda, 2^{n}, r}<J_{\lambda, \infty, r} .
$$

Applying the Principle of Symmetric Criticality (see [43]), it follows that they are critical points of $I_{\lambda}$ in $B V\left(\Omega_{r}\right)$. This way, all minimizers of $J_{\lambda, 2^{n}, r}$ for $m=1, \ldots, n$ are nonradial, rotationally non-equivalent and non-negative solutions of (2.1).

## 3. Existence of multiple solutions via genus

In this section we will prove Theorem 1.2, which implies in the existence of multiple solutions for the problem

$$
\left\{\begin{array}{l}
-\Delta_{1} u=\lambda|u|^{q-2} u+|u|^{1^{*}-2} u, \quad \text { in } \Omega,  \tag{3.1}\\
u=0, \quad \text { on } \partial \Omega,
\end{array}\right.
$$

where $\Omega \subset \mathbb{R}^{N}$ is a smooth bounded domain in $\mathbb{R}^{N}$ with $N \geq 2, \lambda>0$ and $q \in\left(1,1^{*}\right)$. Let us recall that $u \in B V(\Omega)$ is a solution of (3.1) if there is $z \in L^{\infty}\left(\Omega, \mathbb{R}^{N}\right)$ such that

$$
\left\{\begin{array}{l}
|z|_{\infty} \leq 1, \quad \operatorname{div} z \in L^{N}(\Omega), \quad-\int_{\Omega} u \operatorname{div} z d x=\int_{\Omega}|D u|+\int_{\partial \Omega}|u| d \mathcal{H}^{N-1}  \tag{3.2}\\
-\operatorname{div} z=\lambda|u|^{q-2} u+|u|^{1^{*}-2} u, \quad \text { a.e. in } \quad \Omega
\end{array}\right.
$$

In this section, we will consider the energy functional $I_{\lambda}: L^{1^{*}}(\Omega) \rightarrow(-\infty,+\infty]$, given by

$$
\begin{equation*}
I_{\lambda}(u)=\int_{\Omega}|D u| d x+\int_{\partial \Omega}|u| d \mathcal{H}^{N-1}-\frac{\lambda}{q} \int_{\Omega}|u|^{q} d x-\frac{1}{1^{*}} \int_{\Omega}|u|^{1^{*}} d x . \tag{3.3}
\end{equation*}
$$

Hereafter, let us consider the functional $f_{0}: L^{1^{*}}(\Omega) \rightarrow[0,+\infty]$ given by

$$
f_{0}(u)=\left\{\begin{array}{l}
\int_{\Omega}|D u| d x+\int_{\partial \Omega}|u| d \mathcal{H}^{N-1}, \quad \text { if } \quad u \in B V(\Omega) \\
+\infty, \quad \text { if } \quad u \in L^{1^{*}}(\Omega) \backslash B V(\Omega)
\end{array}\right.
$$

which is convex and lower semicontinuous in $L^{1^{*}}(\Omega)$. Moreover, let us define $f_{1}: L^{1^{*}}(\Omega) \rightarrow[0,+\infty]$ by

$$
f_{1}(u)=\frac{\lambda}{q} \int_{\Omega}|u|^{q} d x+\frac{1}{1^{*}} \int_{\Omega}|u|^{1^{*}} d x
$$

which is a $C^{1}$ functional.
Then, the functional $I_{\lambda}$ is written as the difference between a convex, proper and lower semicontinuous functional and a $C^{1}$ one. Hence, in the light of [44], we denote by $\partial I_{\lambda}(u)$, the subgradient of $I_{\lambda}$ at $u \in L^{1^{*}}(\Omega)$, which is well defined as a subset of $L^{N}(\Omega)$.

By [34, Proposition 4.23], we have the following result.
Proposition 3.1. Assume that $u \in B V(\Omega)$ is a critical point of $I_{\lambda}$, i.e., $0 \in \partial I_{\lambda}(u)$. Then $u \in L^{\infty}(\Omega)$ and $u$ is a solution of (3.1), in the sense of (3.2).

Proof. Note that

$$
0 \in \partial I_{\lambda}(u)
$$

if and only if

$$
f_{1}^{\prime}(u) \in \partial f_{0}(u)
$$

On the other hand, the last inclusion implies that there exists $w \in \partial f_{0}(u) \subset L^{N}(\Omega)$ such that

f_{1}^{\prime}(u)=w \quad \text { in } L^{N}(\Omega) \tag{3.4}
\end{equation*}
$$

Taking into account the characterization of $\partial f_{0}(u)$ given in [34, Proposition 4.23], there exists $z \in L^{\infty}\left(\Omega, \mathbb{R}^{N}\right)$, such that $|z|_{\infty} \leq 1$ and

$$
\left\{\begin{array}{l}
-\operatorname{div} z=w, \quad \text { a.e. in } \Omega  \tag{3.5}\\
\int_{\Omega} w u d x=\int_{\Omega}|D u|+\int_{\partial \Omega}|u| d \mathcal{H}^{N-1} .
\end{array}\right.
$$

By (3.4) and (3.5), we also have that

$$
-\operatorname{div} z=\lambda|u|^{p-2} u+|u|^{1^{*}-2} u, \quad \text { a.e. in } \quad \Omega .
$$

Hence, $u$ satisfies (3.2). The fact that $u \in L^{\infty}(\Omega)$ is a regularity result which follows as in [25, Proposition3.3].

Now let us define what we mean by a $(P S)$ sequence for $I_{\lambda}$. We say that $\left(u_{k}\right) \subset L^{1^{*}}(\Omega)$ is a $(P S)$ sequence for $I_{\lambda}$ if there exist $d \in \mathbb{R}$ and $\left(z_{k}\right) \subset L^{N}(\Omega)$ such that $\left|z_{k}\right|_{N} \rightarrow 0$ as $k \rightarrow+\infty$,

$$
\begin{equation*}
\lambda\left|u_{k}\right|^{q-2} u_{k}+\left|u_{k}\right|^{1^{*}-2} u_{k}+z_{k} \in \partial f_{0}\left(u_{k}\right) \tag{3.6}
\end{equation*}
$$

and

$$
I_{\lambda}\left(u_{k}\right) \rightarrow d, \quad \text { as } k \rightarrow+\infty .
$$

Next, we state an abstract result, whose proof follows as in Szulkin [44, Theorem 4.4]. Hereafter $X$ denotes a Banach space. We say that a functional $I: X \rightarrow(-\infty,+\infty]$ satisfies the condition $(H)$ if:
(H) $I=\Phi+\psi$, where $\Phi \in C^{1}(X, \mathbb{R})$ and $\psi: X \rightarrow(-\infty,+\infty]$ is convex, proper (i.e. $\psi \not \equiv+\infty)$ and lower semicontinuous.
Moreover, for each $c \in \mathbb{R}$ we denote

I_{c}=\{u \in X: I(u) \leq c\}
$$

and by $\Sigma$ the collection of all symmetric subsets of $X \backslash\{0\}$ which are closed in $X$.
Theorem 3.2. Assume that $I: X \rightarrow(-\infty,+\infty]$ satisfies $(H), I(0)=0$ and $\Phi, \psi$ are even and there is $d>0$ such that I has no critical points in $I_{-d}$. Assume also that
a. there is $M>0$ such that I satisfies $(P S)_{c}$ condition for $0<c<M$.
b. there exist $\alpha, \rho>0$ such that

$$
I(u) \geq \alpha \quad \text { for } \quad\|u\|=\rho
$$

c. given $n \in \mathbb{N}$, there is a finite dimensional subspace $X_{n} \subset X$ and $R_{n}>\rho$ such that

$$
\left.I\right|_{\partial Q_{n}} \leq-d \quad \text { where } \quad Q_{n}=\bar{B}_{R_{n}} \cap X_{n}
$$

Denoting by $\mathcal{F}$ the set

$$
\mathcal{F}=\left\{f \in C\left(Q_{n}, X\right): f \text { is odd and }\left.f\right|_{\partial Q_{n}} \approx i d_{\partial Q_{n}} \text { in } I_{-d} \text { by an odd homotopy }\right\}
$$

we consider for each $j \in \mathbb{N}$ the sets $\Lambda_{j}^{\prime}$ and $\Lambda_{j}$ given by,

$$
\Lambda_{j}^{\prime}=\left\{\begin{array}{l}
f\left(Q_{n}-V\right): f \in \mathcal{F}, V \text { is open in } Q_{n} \text { and symmetric, } V \cap \partial Q_{n}=\emptyset, \\
\text { and for each } Y \subset V \text { such that } Y \in \Sigma, \gamma(Y) \leq k-j
\end{array}\right\}
$$

and

$$
\Lambda_{j}=\left\{\begin{array}{l}
A \subset X: A \text { is compact, symmetric and for each open set } U \supset A \\
\text { there is } A_{0} \in \Lambda_{j}^{\prime} \text { such that } A_{0} \subset U
\end{array}\right\}
$$

Using the above notation, the numbers

$$
c_{j}=\inf _{A \in \Lambda_{j}} \sup _{u \in A} I(u)
$$

are well defined for all $j \in \mathbb{N}$ and $0<\alpha \leq c_{1} \leq c_{2} \leq \ldots . \leq c_{j} \leq c_{j+1} \leq \ldots$ for all $j \in \mathbb{N}$. If $c_{n}<M$, then $c_{j}$ are critical values of $I$ for $j \in\{1,2, \ldots, n\}$. Moreover, if there are $j_{0} \in\{1,2, \ldots, n\}$ and $p \in \mathbb{N}$ such that $c_{j_{0}}=\ldots=c_{j_{0}+p}=c<M$, then $\gamma\left(K_{c}\right) \geq p+1$.

Now, following the approach explored in [25], for each $h>0$ we consider the functions $T_{h}, R_{h}: \mathbb{R} \rightarrow \mathbb{R}$ given by

$$
T_{h}(s)=\min \{\max \{s,-h\}, h\} \quad \text { and } \quad R_{h}(s)=s-T_{h}(s) .
$$

A simple computation shows that for each $u \in L^{1^{*}}(\Omega)$,

\begin{equation*}
T_{h}(u) \rightarrow u \quad \text { in } \quad L^{1^{*}}(\Omega) \quad \text { as } \quad h \rightarrow+\infty, \tag{3.7}
\end{equation*}
$$

and so,

$$
\begin{equation*}
R_{h}(u) \rightarrow 0 \quad \text { in } \quad L^{1^{*}}(\Omega) \quad \text { as } \quad h \rightarrow+\infty . \tag{3.8}
\end{equation*}
$$

Moreover, if $\left(u_{k}\right) \subset L^{1^{*}}(\Omega)$ is a sequence satisfying

u_{k}(x) \rightarrow u(x) \quad \text { a.e. in } \quad \Omega \quad \text { as } \quad k \rightarrow+\infty,
$$

then, for each $h$ fixed, the Lebesgue Dominated Convergence Theorem ensures that

T_{h}\left(u_{k}\right) \rightarrow T_{h}(u) \quad \text { in } \quad L^{1^{*}}(\Omega) \quad \text { as } \quad k \rightarrow+\infty . \tag{3.9}
\end{equation*}

Proposition 3.3. Let $\left(u_{k}\right)$ be a sequence in $B V(\Omega)$ and $\left(w_{k}\right)$ be a sequence in $L^{N}(\Omega)$ such that, for $k \in \mathbb{N}$, $w_{k} \in \partial f_{0}\left(u_{k}\right)$ and, as $k \rightarrow+\infty$,

$$
\begin{aligned}
& u_{k} \rightharpoonup u \quad \text { in } L^{1^{*}}(\Omega), \\
& w_{k} \rightharpoonup w \quad \text { in } L^{N}(\Omega) .
\end{aligned}
$$

Then $u \in B V(\Omega)$ and $w \in \partial f_{0}(u)$.
Proof. See [25, Proposition 3.2].

Lemma 3.4. Let $\left(u_{k}\right)$ be a $(P S)$ sequence for $I_{\lambda}$. Assume that $\left(u_{k}\right)$ is bounded in $B V(\Omega)$ and

u_{k} \rightharpoonup u \quad \text { in } L^{1^{*}}(\Omega) .
$$

Then,

\lim _{k \rightarrow+\infty}\left(f_{0}\left(u_{k}\right)-\left|u_{k}\right|_{1^{*}}^{1^{*}}\right)=f_{0}(u)-|u|_{1^{*}}^{1^{*}} \tag{i}
\end{equation*}
$$

and, for $h>0$ fixed,

\begin{equation*}
\lim _{k \rightarrow+\infty}\left(f_{0}\left(R_{h}\left(u_{k}\right)\right)-\left|R_{h}\left(u_{k}\right)\right|_{1^{*}}^{1^{*}}\right) \leq f_{0}\left(R_{h}(u)\right)-\left|R_{h}(u)\right|_{1^{*}}^{1^{*}} \tag{ii}
\end{equation*}
$$

Proof. Since $\left(u_{k}\right)$ is a $(P S)$ sequence, there is $\left(z_{k}\right) \subset L^{N}(\Omega)$, where $z_{k}=o_{k}(1)$ in $L^{N}(\Omega)$ and

$$
\begin{aligned}
f_{0}(v)-f_{0}\left(u_{k}\right) \geq & \lambda \int_{\Omega}\left|u_{k}\right|^{q-2} u_{k}\left(v-u_{k}\right) d x+\int_{\Omega}\left|u_{k}\right|^{1^{*}-2} u_{k}\left(v-u_{k}\right) d x \\
& +\int_{\Omega} z_{k}\left(v-u_{k}\right) d x
\end{aligned}
$$

for all $v \in L^{1^{*}}(\Omega)$. From this,

$$
\lambda\left|u_{k}\right|^{q-2} u_{k}+\left|u_{k}\right|^{1^{*}-2} u_{k}+z_{k} \in \partial f_{0}\left(u_{k}\right), \quad \forall k \in \mathbb{N},
$$

and then there exists $w_{k} \in \partial f_{0}\left(u_{k}\right)$ such that

$$
\begin{equation*}
w_{k}=\lambda\left|u_{k}\right|^{q-2} u_{k}+\left|u_{k}\right|^{1^{*}-2} u_{k}+z_{k}, \quad \forall k \in \mathbb{N} . \tag{3.10}
\end{equation*}
$$

Moreover, by [34, Proposition 4.23],

$$
\begin{equation*}
\int_{\Omega} w_{k} u_{k} d x=\int_{\Omega}\left|D u_{k}\right| d x+\int_{\partial \Omega}\left|u_{k}\right| d \mathcal{H}^{N-1}, \quad \forall k \in \mathbb{N} \tag{3.11}
\end{equation*}
$$

Thus, from (3.10) and (3.11), for all $k \in \mathbb{N}$,

\begin{align*}
\int_{\Omega}\left|D u_{k}\right| d x+\int_{\partial \Omega}\left|u_{k}\right| d \mathcal{H}^{N-1}= & \lambda \int_{\Omega}\left|u_{k}\right|^{q} d x+\int_{\Omega}\left|u_{k}\right|^{1^{*}} d x \\
& +\int_{\Omega} z_{k} u_{k} d x \tag{3.12}
\end{align*}
$$

Since $q \in\left(1,1^{*}\right)$, Hölder's inequality implies that $\left(\left.\left|u_{k}\right|\right|^{q-2} u_{k}\right)$ and $\left(\left.\left|u_{k}\right|\right|^{1^{*}-2} u_{k}\right)$ are bounded in $L^{N}(\Omega)$. Indeed, it is straightforward to see that

\left|\left|u_{k}\right|^{1^{*}-2} u_{k}\right|_{N}=\left|u_{k}\right|_{1^{*}}^{\frac{1}{N-1}}
$$

and

$$
\begin{aligned}
\left|\left|u_{k}\right|^{q-2} u_{k}\right|_{N}^{N} & =\int_{\Omega}\left|u_{k}\right|^{(q-1) N} d x \\
& \leq\left(\int_{\Omega}\left|u_{k}\right|^{1^{*}} d x\right)^{(N-1)(q-1)}|\Omega|^{1-(N-1)(q-1)},
\end{aligned}
$$

from where it follows that both these sequences are bounded in $L^{N}(\Omega)$. Then

\left|u_{k}\right|^{q-2} u_{k} \rightharpoonup|u|^{q-2} u \tag{3.13}
\end{equation*}

and

\end{equation*}

in $L^{N}(\Omega)$.
Hence, from (3.13) and (3.14),

\end{equation*}

with

w=-\gamma+\lambda|u|^{q-2} u+|u|^{1^{*}-2} u .

Taking into account the hypothesis and (3.15), Proposition 3.3 yields that $u \in B V(\Omega)$,

and then, by (3.11),

& =\lambda \int_{\Omega}|u|^{q} d x
\end{aligned}

Then, from the last equality and (3.16), it follows that

showing (i). The item (ii) follows as in [25, Lemma 5.1].

Lemma 3.5. Each (PS) sequence for $I_{\lambda}$ is bounded in $B V(\Omega)$.
Proof. Let $\left(u_{k}\right)$ be a $(P S)_{d}$ sequence for $I_{\lambda}$, that is,

where $\left(z_{k}\right) \subset L^{N}(\Omega)$, with $z_{k}=o_{k}(1)$ in $L^{N}(\Omega)$, as $k \rightarrow+\infty$.
By Proposition [34, Proposition 4.23], for all $k \in \mathbb{N}$,

\int_{\Omega}\left|D u_{k}\right| d x+\int_{\partial \Omega}\left|u_{k}\right| d \mathcal{H}^{N-1}= & \lambda \int_{\Omega}\left|u_{k}\right|^{q} d x+\int_{\Omega}\left|u_{k}\right|^{1^{*}} d x \\
& +\int_{\Omega} z_{k} u_{k} d x
\end{aligned}
$$

Now, let us denote

\begin{aligned}
\mathcal{Q}\left(u_{k}\right)= & \int_{\Omega}\left|D u_{k}\right| d x+\int_{\Omega}\left|u_{k}\right| d x+\int_{\partial \Omega}\left|u_{k}\right| d \mathcal{H}^{N-1} \\
& -\lambda \int_{\Omega}\left|u_{k}\right|^{q} d x-\int_{\Omega}\left|u_{k}\right|^{1^{*}} d x-\int_{\Omega} z_{k} u_{k} d x
\end{aligned}
$$

and note that

$$
\begin{equation*}
\mathcal{Q}\left(u_{k}\right)=0, \quad \forall k \in \mathbb{N} \tag{3.17}
\end{equation*}
$$

Thus, from (3.17),

\begin{aligned}
d+o_{k}(1) & =I_{\lambda}\left(u_{k}\right) \\
& =I_{\lambda}\left(u_{k}\right)-\frac{1}{q} \mathcal{Q}\left(u_{k}\right) \\
& \geq\left(1-\frac{1}{q}\right) f_{0}\left(u_{k}\right)+\left(1-\frac{1}{q}\right)\left|u_{k}\right|_{1}+\left(\frac{1}{q}-\frac{1}{1^{*}}\right)\left|u_{k}\right|_{1^{*}}^{1^{*}}+\frac{1}{q} \int_{\Omega} z_{k} u_{k} d x \\
& \geq\left(1-\frac{1}{q}\right) f_{0}\left(u_{k}\right)+\left(\frac{1}{q}-\frac{1}{1^{*}}\right)\left|u_{k}\right|_{1^{*}}^{1^{*}}-\frac{1}{q}\left|z_{k}\right|_{N}\left|u_{k}\right|_{1^{*}} \\
& \geq\left(1-\frac{1}{q}\right) f_{0}\left(u_{k}\right)+\left(\frac{1}{q}-\frac{1}{1^{*}}\right)\left(\left|u_{k}\right|_{1^{*}}^{1^{*}}-\left|u_{k}\right|_{1^{*}}\right),
\end{aligned}
$$

for $k$ large enough. Since $g:[0,+\infty) \rightarrow \mathbb{R}$, given by

g(t)=t^{1^{*}}-t
$$

is bounded from below, there exists $K>0$ such that

g(t) \geq-K, \quad \forall t \in[0,+\infty)
$$

Then

d+o_{k}(1) \geq\left(1-\frac{1}{q}\right) f_{0}\left(u_{k}\right)-\left(\frac{1}{q}-\frac{1}{1^{*}}\right) K,
$$

from where it follows that $\left(u_{k}\right)$ is bounded in $B V(\Omega)$.
Lemma 3.6. For each $\lambda>0$, the functional $I_{\lambda}$ satisfies the $(P S)_{c}$ condition, for $c<\frac{1}{N} S^{N}$.

Proof. Let $\left(u_{k}\right)$ be a $(P S)_{c}$ sequence for $I_{\lambda}$ with $c<\frac{1}{N} S^{N}$. Then,

$$

and

f_{0}(v)-f_{0}\left(u_{k}\right) \geq & \lambda \int_{\Omega}\left|u_{k}\right|^{q-2} u_{k}\left(v-u_{k}\right) d x \\
& +\int_{\Omega}\left|u_{k}\right|^{1^{*}-2} u_{k}\left(v-u_{k}\right) d x+\int_{\Omega} w_{k}\left(v-u_{k}\right) d x
\end{aligned}
$$

for some $w_{k} \in L^{N}(\Omega)$ and $w_{k}=o_{k}(1)$ in $L^{N}(\Omega)$. Moreover, we also have

$$
\begin{align*}
\int_{\Omega}\left|D u_{k}\right| d x+\int_{\partial \Omega}\left|u_{k}\right| d \mathcal{H}^{N-1}= & \lambda \int_{\Omega}\left|u_{k}\right|^{q} d x+\int_{\Omega}\left|u_{k}\right|^{1^{*}} d x  \tag{3.18}\\
& +\int_{\Omega} w_{k} u_{k} d x, \quad \forall k \in \mathbb{N}
\end{align*}
$$

Hence, from (3.18), for all $k \in \mathbb{N}$,

I_{\lambda}\left(u_{k}\right)=\lambda\left(1-\frac{1}{q}\right)\left|u_{k}\right|_{q}^{q}+\left(1-\frac{1}{1^{*}}\right)\left|u_{k}\right|_{1^{*}}^{1^{*}}+\int_{\Omega} w_{k} u_{k} d x \tag{3.19}
\end{equation*}
$$

Since $\left(u_{k}\right)$ is bounded and $w_{k}=o_{k}(1)$ in $L^{N}(\Omega)$, (3.19) gives

$$
\lim _{k \rightarrow+\infty}\left|u_{k}\right|_{1^{*}}^{1^{*}} \leq N c<S^{N}
$$

Since $f_{0}$ is lower semicontinuous and

$$
f_{0}(u)=f_{0}\left(T_{h}(u)\right)+f_{0}\left(R_{h}(u)\right),
$$

(3.7) and (3.8) lead us to

$$
\limsup _{h \rightarrow+\infty}\left(f_{0}\left(R_{h}(u)\right)-\left|R_{h}(u)\right|_{1^{*}}^{1^{*}}\right) \leq 0
$$

Therefore, given $\epsilon>0$, there is $h>0$ large enough such that

$$
\begin{equation*}
f_{0}\left(R_{h}(u)\right)-\left|R_{h}(u)\right|_{1^{*}}^{1^{*}}<\epsilon\left(S-(N c)^{\frac{1}{N}}\right) \tag{3.20}
\end{equation*}
$$

For $h$ fixed above, the definition of $R_{h}$ gives

$$
\limsup _{k \rightarrow+\infty}\left|R_{h}\left(u_{k}\right)\right|_{1^{*}}^{1^{*}-1} \leq \limsup _{k \rightarrow+\infty}\left|u_{k}\right|_{1^{*}}^{1^{*}-1} \leq(N c)^{\frac{1}{N}}
$$

Now, the inequality below

$$
\left(S-\left|R_{h}\left(u_{k}\right)\right| 1_{1^{*}}^{1^{*}-1}\right)\left|R_{h}\left(u_{k}\right)\right|_{1^{*}} \leq f_{0}\left(R_{h}\left(u_{k}\right)\right)-\left|R_{h}\left(u_{k}\right)\right|_{1^{*}}^{1^{*}}
$$

together with Lemma 3.4 and (3.20) leads to

$$
\limsup _{k \rightarrow+\infty}\left|R_{h}\left(u_{k}\right)\right|_{1^{*}}<\epsilon
$$

Hence $\left|R_{h}(u)\right|_{1^{*}}<\epsilon$. Moreover, since by (3.9), $\left(T_{h}\left(u_{k}\right)\right)$ is strongly convergent to $T_{h}(u)$, it follows that

$$
\begin{aligned}
\limsup _{k \rightarrow+\infty}\left|u_{k}-u\right|_{1^{*}} \leq & \limsup _{k \rightarrow+\infty}\left|T_{h}\left(u_{k}\right)-T_{h}(u)\right|_{1^{*}} \\
& +\limsup _{k \rightarrow+\infty}\left|R_{h}\left(u_{k}\right)\right|_{1^{*}}+\left|R_{h}(u)\right|_{1^{*}} \\
\leq & 2 \epsilon .
\end{aligned}
$$

Since that $\epsilon$ is arbitrary, the last inequality ensures that $u_{k} \rightarrow u$ in $L^{1^{*}}(\Omega)$.
Lemma 3.7. There are $\alpha, \rho>0$ such that

$$
I_{\lambda}(u) \geq \alpha, \quad \text { for } \quad|u|_{1^{*}}=\rho
$$

Proof. Note that, in order to verify this lemma, it suffices to consider $u \in B V(\Omega)$, since otherwise we would have $I_{\lambda}(u)=+\infty$. Then, if $u \in B V(\Omega)$, from the continuous embedding $B V(\Omega) \hookrightarrow L^{1^{*}}(\Omega)$ and Hölder inequality, we have that

$$
I_{\lambda}(u) \geq C_{1}|u|_{1^{*}}-C_{2}|u|_{1^{*}}^{q}-|u|_{1^{*}}^{1^{*}} .
$$

Since $q>1$, the last inequality allows us to conclude that there are $\alpha, \rho>0$ such that

$$
I_{\lambda}(u) \geq \alpha, \quad \text { for } \quad|u|_{1^{*}}=\rho
$$

3.1. Proof of Theorem 1.2. In what follows, we will assume that there is $d>0$ such that $I_{\lambda}$ has no critical point in $I_{-d}$, otherwise $I_{\lambda}$ has infinitly many critical points and Theorem 1.2 is proved.

Lemma 3.8. For $n \in \mathbb{N}$ and a finite dimensional subspace $X_{n} \subset X$, there exists $R_{n}>\rho$ such that

$$
\left.I_{\lambda}\right|_{\partial Q_{n}} \leq-d \quad \text { where } \quad Q_{n}=\bar{B}_{R_{n}} \cap X_{n} .
$$

Proof. Let $X_{n} \subset L^{1^{*}}(\Omega)$ be a finite dimensional subspace, such that $X_{n} \subset C_{0}^{\infty}(\Omega)$. Since in $X_{n}$, all the norms are equivalent, there are positive constants $a_{n}, d_{n}$ and $b_{n}$ (which depend just on $n \in \mathbb{N}$ ), such that, for $u \in X_{n}$,

$$
I_{\lambda}(u) \leq a_{n}|u|_{1^{*}}-d_{n} \lambda|u|_{1^{*}}^{q}-b_{n}|u|_{1^{*}}^{1^{*}} .
$$

The last inequality, in turn, implies that

$$
I_{\lambda}(u) \rightarrow-\infty \quad \text { as } \quad|u|_{1^{*}} \rightarrow+\infty
$$

This proves the desired result.
Lemma 3.9. For each $n \in \mathbb{N}$, there is $\lambda_{n}>0$ such that if $\lambda \geq \lambda_{n}$, then

$$
\sup _{u \in Q_{n}} I_{\lambda}(u)<\frac{1}{N} S^{N} .
$$

Hence, $c_{n}<\frac{1}{N} S^{N}$.
Proof. Arguing as in the proof of Lemma 3.8, we get

$$
\sup _{u \in Q_{n}} I_{\lambda}(u) \leq \sup _{u \in Q_{n}}\left\{a_{n}|u|_{1^{*}}-d_{n} \lambda|u|_{1^{*}}^{q}-b_{n}|u|_{1^{*}}^{1^{*}}\right\} \leq \sup _{u \in Q_{n}}\left\{a_{n}|u|_{1^{*}}-d_{n} \lambda|u|_{1^{*}}^{q}\right\}
$$

Defining the function $h:[0,+\infty) \rightarrow \mathbb{R}$ as

$$
h(t)=a_{n} t-d_{n} \lambda t^{q},
$$

it is straightforward to see that

$$
\max _{t \geq 0} h(t)=C_{n}\left(\frac{1}{\lambda}\right)^{\frac{1}{q-1}},
$$

for some $C_{n}$ which depends on $n$. Thus, there is $\lambda_{n}>0$ such that

$$
\max _{t \geq 0} h(t)<\frac{1}{N} S^{N}, \quad \forall \lambda \geq \lambda_{n}
$$

This ensures that

$$
\sup _{u \in Q_{n}} I_{\lambda}(u)<\frac{1}{N} S^{N}, \quad \forall \lambda \geq \lambda_{n} .
$$

Since $Q_{n} \in \Lambda_{n}$, we have that

$$
c_{n} \leq \sup _{u \in Q_{n}} I_{\lambda}(u)<\frac{1}{N} S^{N}, \quad \forall \lambda \geq \lambda_{n} .
$$

Therefore, taking into account Lemmas 3.6, 3.7, 3.8 and 3.9, we see that $I_{\lambda}$ satisfies all the conditions of Theorem 3.2, and so, Theorem 1.2 is proved.
