# Spectra of new graph operations based on central graph

#### Abstract

In this paper, we introduce central vertex corona, central edge corona, and central edge neighborhood corona of graphs using central graph. Also, we determine their adjacency spectrum, Laplacian spectrum and signless Laplacian spectrum. From our results, it is possible to obtain infinitely many pairs of adjacency (respectively, Laplacian and signless Laplacian) cospectral graphs. As an application, we calculate the number of spanning trees and the Kirchhoff index of the resulting graphs.

## 1 Introduction

In this paper, we consider only simple connected graphs. Let $G=(V(G), E(G))$ be a graph with vertex set $V(G)=\left\{v_{1}, v_{2}, \ldots, v_{n}\right\}$ and edge set $E(G)=\left\{e_{1}, e_{2}, \ldots, e_{m}\right\}$, and let $d_{i}$ be the degree of the vertex $v_{i}, v_{i} \in V(G)$. The adjacency matrix $A(G)$ of the graph $G$ is a square symmetric matrix of order $n$ whose $(i, j)^{t h}$ entry is equal to unity if the vertices $v_{i}$ and $v_{j}$ are adjacent, and is equal to zero otherwise. The Laplacian matrix of $G$, denoted by $L(G)$ is defined as $L(G)=D(G)-A(G)$ and the signless Laplacian matrix of $G$, denoted by $Q(G)$ is defined as $Q(G)=D(G)+A(G)$, where $D(G)$ is the diagonal matrix whose entries are the degrees of the vertices of $G$. The characteristic polynomial of the $n \times n$ matrix $M$ of $G$ is defined as $f(M, x)=$ $\left|x I_{n}-M\right|$, where $I_{n}$ is identity matrix of order $n$. The matrices $A(G), L(G)$ and $Q(G)$ are real symmetric matrices, its eigenvalues are real. Denote the eigenvalues of $A(G), L(G)$ and $Q(G)$ by $\lambda_{1}(G) \geqslant \lambda_{2}(G) \geqslant \ldots \geqslant \lambda_{n}(G), 0=\mu_{1}(G)<\mu_{2}(G) \leq$ $\ldots \leq \mu_{n}(G)$ and $\gamma_{1}(G) \geq \gamma_{2}(G) \geq \ldots \geq \gamma_{n}(G)$, respectively. The set of all eigenvalues of $A(G)$ (respectively, $L(G), \mathrm{Q}(\mathrm{G})$ ) together with their multiplicities are called $A$ spectrum (respectively, $L$-spectrum, $Q$-spectrum) of $G$. Two non isomorphic graphs are said to be $A$-cospectral (respectively, $L$-cospectral, $Q$-cospectral), if they have the

[^0]same $A$-spectrum (respectively, $L$-spectrum, $Q$-spectrum). Otherwise, they are non $A$-cospectral (respectively, non $L$-cospectral, non $Q$-cospectral) graphs. Let $G$ be a connected graph on $n$ vertices, then the number of spanning trees of $G$ is $t(G)=$ $\frac{\mu_{2}(G) \cdot \mu_{3}(G) \ldots \mu_{n}(G)}{n}$ 1]. In 1993, Klein and Randić 22 introduced the resistance distance $r_{i, j}^{*}$ between two vertices $v_{i}$ and $v_{j}$ in $G$ and is defined as the effective resistance between them when unit resistors are distributed on every edge of G. The Kirchhoff index [3] of a connected graph $G$ is defined as

K f(G)=\sum_{i<j} r_{i, j}^{*},
$$
where $r_{i, j}^{*}$ denotes the resistance distance between vertices $v_{i}$ and $v_{j}$ in $G$. In [4, 5], the authors proved that the Kirchhoff index of a graph $G$ is
$$
K f(G)=n \sum_{i=2}^{n} \frac{1}{\mu_{i}(G)}
$$

In literature, there are many graph operations like, complement, disjoint union, join, cartesian product, direct product, strong product, lexicographic product, corona, edge corona, neighbourhood corona etc. The corona of two graphs first introduced by F.Harary and R.Frucht in [6]. Recently, several variants of corona product of two graphs have been introduced and their spectra are computed. In [7], Liu and Lu introduced subdivision-vertex and subdivision-edge neighbourhood corona of two graphs and provided a complete description of their spectra. In [8], Lan and Zhou introduced $R$-vertex corona, $R$-edge corona, $R$-vertex neighborhood corona and $R$-edge neighborhood corona, and studied their spectra. Recently in [9, 10], Adiga et.al introduced duplication corona, duplication neighborhood corona, duplication edge corona, N -vertex corona and N -edge corona of two regular graphs. Motivated by the above works, we define three new graph operations based on central graph.

The Kronecker product $A \otimes B$ of two matrices $A=\left(a_{i, j}\right)_{m \times n}$ and $B=\left(b_{i, j}\right)_{p \times q}$ is the $m p \times n q$ matrix obtained from A by replacing each entry $a_{i, j}$ by $a_{i, j} B$. For matrices $\mathrm{A}, \mathrm{B}, \mathrm{C}$ and D such that products AC and BD exist then $(A \otimes B)(C \otimes D)=$ $A C \otimes B D$. Also, if $A$ and $B$ are invertible matrices, then $(A \otimes B)^{-1}=A^{-1} \otimes B^{-1}$, $(A \otimes B)^{T}=A^{T} \otimes B^{T}$. If A and B are $n \times n$ and $p \times p$ matrices respectively, then $\operatorname{det}(A \otimes B)=(\operatorname{det} A)^{p}(\operatorname{det} B)^{n}$ [11]. The incidence matrix of a graph $G, I(G)$ is the $n \times m$ matrix whose $(i, j)^{t h}$ entry is 1 if $v_{i}$ is incident to $e_{j}$ and 0 otherwise. It is known [12] that, $I(G) I(G)^{T}=A(G)+D(G)$ and if $G$ is an $r$-regular graph, then $I(G) I(\bar{G})^{T}=A(G)+r I_{n}$. The complement $\bar{G}$ of a graph $G$ is the graph with vertex set $V(G)$ and two vertices are adjacent in $\bar{G}$ if and only if they are not adjacent in $G$. The adjacency matrix of the complement of a graph $G$ is $A(\bar{G})=J_{n}-I_{n}-A(G)$. Throughout this article, $I_{n}$ denote the identity matrix of order $n$. The symbol $O_{m \times n}$ and $J_{n}$ (respectively, $J_{1 \times n}$ ) will stand for $m \times n$ and $n \times n$ matrices (respectively, $1 \times n$ column vector) consisting of 0 's and 1 's. As usual, we denote a complete graph on $n$ vertices by $K_{n}$, a complete bipartite graph on $n=p+q$ vertices by $K_{p, q}$ and a path on $n$ vertices by $P_{n}$.

The rest of the paper is organized as follows. In Section 2, we present some definitions and lemmas that will be used later. In Section 3, we introduce a new graph operation, called central vertex corona and calculate its adjacency (respectively, Laplacian
and signless Laplacian) spectrum. The number of spanning trees and the Kirchhoff index of the resulting graphs are calculated. Also, our results show how to construct non isomorphic cospectral families of graphs. In Section 4, we introduce a new graph operation, called central edge corona and calculate its adjacency (respectively, Laplacian and signless Laplacian) spectrum. Moreover, the formula for the spanning trees and the Kirchhoff index of the resulting graphs are obtained. Further, we obtain some cospectral graphs. In Section 5, we define a new graph operation, called central edge neighborhood corona and calculate its adjacency (respectively, Laplacian and signless Laplacian) spectrum. Also, we formulate the number of spanning trees and the Kirchhoff index of edge neighborhood corona. Finally, as an application of these results we construct many pairs of non isomorphic cospectral graphs.

## 2 Preliminaries

In this section, we recall some definitions and results which will be useful to prove our main results.

Lemma 2.1. 12 Let $U, V, W$ and $X$ be matrices with $U$ invertible. Let

Then $\operatorname{det}(S)=\operatorname{det}(U) \operatorname{det}\left(X-W U^{-1} V\right)$.
If $X$ is invertible, then $\operatorname{det}(S)=\operatorname{det}(X) \operatorname{det}\left(U-V X^{-1} W\right)$.
If $U$ and $W$ are commutes, then $\operatorname{det}(S)=\operatorname{det}(U X-W V)$.
Lemma 2.2. 12] Let $G$ be a connected $r$-regular graph on $n$ vertices with an adjacency matrix $A$ having $t$ distinct eigenvalues $r=\lambda_{1}, \lambda_{2}, \ldots, \lambda_{t}$. Then there exists a polynomial

P(x)=n \frac{\left(x-\lambda_{2}\right)\left(x-\lambda_{3}\right) \ldots\left(x-\lambda_{t}\right)}{\left(r-\lambda_{2}\right)\left(r-\lambda_{3}\right) \ldots\left(r-\lambda_{t}\right)} .
$$

such that $P(A)=J_{n}, P(r)=n$ and $P\left(\lambda_{i}\right)=0$ for $\lambda_{i} \neq r$.
Definition 2.1. 13] The $M$-coronal $\chi_{M}(x)$ of $n \times n$ matrix $M$ is defined as the sum of the entries of the matrix $\left(x I_{n}-M\right)^{-1}$ (if exists), that is,

\chi_{M}(x)=J_{n \times 1}^{T}\left(x I_{n}-M\right)^{-1} J_{n \times 1},
$$

where $J_{n \times 1}$ denotes the column vector of size $n$ with all entries equal to one.
Lemma 2.3. 14 Let $G$ be an $r$-regular graph on $n$ vertices. Then $\chi_{A(G)}(x)=\frac{n}{x-r}$.
For Laplacian matrix each row sum is zero, so

Let $G$ be an $r$-regular graph on $n$ vertices. Then

\chi_{Q(G)}(x)=\frac{n}{x-2 r} . \tag{2.0.2}
\end{equation*}

Lemma 2.4. 14 Let $G$ be a bipartite graph $K_{p, q}$ with $p+q$ vertices. Then $\chi_{A(G)}(x)=$ $\frac{(p+q) x+2 p q}{\left(x^{2}-p q\right)}$.

Lemma 2.5. 15 Let $A$ be an $n \times n$ real matrix. Then $\operatorname{det}\left(A+\alpha J_{n}\right)=\operatorname{det}(A)+$ $\alpha J_{n \times 1}^{T} \operatorname{adj}(A) J_{n \times 1}$, where $\alpha$ is a real number and $\operatorname{adj}(A)$ is the adjoint of $A$.

Corollary 2.6. 15] Let $A$ be an $n \times n$ real matrix. Then

\operatorname{det}\left(x I_{n}-A-\alpha J_{n}\right)=\left(1-\alpha \chi_{A}(x)\right) \operatorname{det}\left(x I_{n}-A\right) .
$$

Definition 2.2. 16
Let $G$ be a simple graph with $n$ vertices and $m$ edges. The central graph of $G$, denoted by $C(G)$ is obtained by sub dividing each edge of $G$ exactly once and joining all the nonadjacent vertices in $G$.
The graph $C(G)$ has $m+n$ vertices and $m+\frac{n(n-1)}{2}$ edges.
Let $\tilde{V}(G)=V(C(G))-V(G)$, be the set of vertices in $C(G)$ corresponding to the edges of $G$.

## 3 Spectra of central vertex corona of graphs

In this section, we define a new corona operation on graphs and calculate their adjacency spectrum, Laplacian spectrum and signless Laplacian spectrum. Moreover, our results allows to construct cospectral graphs. The Kirchhoff index and the number of spanning trees of the resulting graphs are obtained.

Definition 3.1. Let $G_{i}$ be a graph with $n_{i}$ vertices and $m_{i}$ edges for $i=1,2$. Then the central vertex corona $G_{1} \odot G_{2}$ of two graphs $G_{1}$ and $G_{2}$ is the graph obtained by taking one copy of $C\left(G_{1}\right)$ and $\left|V\left(G_{1}\right)\right|$ copies of $G_{2}$ and joining the vertex $v_{i}$ of $G_{1}$ to every vertex in the $i^{\text {th }}$ copy of $G_{2}$.
The adjacency matrix of $G_{1} \odot G_{2}$ can be written as

A\left(G_{1} \odot G_{2}\right)=\left(\begin{array}{ccc}
A\left(\overline{G_{1}}\right) & I\left(G_{1}\right) & I_{n_{1}} \otimes J_{1 \times n_{2}} \\
I\left(G_{1}\right)^{T} & O_{m_{1} \times m_{1}} & O_{m_{1} \times n_{1} n_{2}} \\
I_{n_{1}} \otimes J_{1 \times n_{2}}^{T} & O_{n_{1} n_{2} \times m_{1}} & I_{n_{1}} \otimes A\left(G_{2}\right)
\end{array}\right) .
$$

The graph $G_{1} \odot G_{2}$ has $n_{1}+m_{1}+n_{1} n_{2}$ vertices and $m_{1}+\frac{n_{1}\left(n_{1}-1\right)}{2}+n_{1} m_{2}+n_{1} n_{2}$ edges. Example 3.1. Let $G_{1}=P_{3}$ and $G_{2}=P_{2}$. Then the two central vertex coronas $G_{1} \odot G_{2}$ and $G_{2} \odot G_{1}$ are depicted in Figure:1.

Theorem 3.1. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the adjacency characteristic polynomial of $G_{1} \odot G_{2}$ is

f\left(A\left(G_{1} \odot G_{2}\right), x\right)= & x^{m_{1}-n_{1}} \prod_{j=1}^{n_{2}}\left(x-\lambda_{j}\left(G_{2}\right)\right)^{n_{1}} \\
& \times \prod_{i=1}^{n_{1}}\left(x^{2}+x-x \chi_{A\left(G_{2}\right)}(x)-r_{1}-x P\left(\lambda_{i}\left(G_{1}\right)\right)+(x-1) \lambda_{i}\left(G_{1}\right)\right) .
\end{aligned}

Proof. The characteristic polynomial of $G_{1} \odot G_{2}$ is

-I_{n_{1}} \otimes J_{1 \times n_{2}}^{T} & O_{n_{1} n_{2} \times m_{1}} & I_{n_{1}} \otimes\left(x I_{n_{2}}-A\left(G_{2}\right)\right)

By Lemmas 2.1, 2.2, Definition 2.1 and Corollary 2.6, we have

Therefore the adjacency characteristic polynomial of $G_{1} \odot G_{2}$ is

= & x^{m_{1}-n_{1}} \prod_{j=1}^{n_{2}}\left(x-\lambda_{j}\left(G_{2}\right)\right)^{n_{1}} \\
& \times \prod_{i=1}^{n_{1}}\left(x^{2}+x-x \chi_{A\left(G_{2}\right)}(x)-r_{1}-x P\left(\lambda_{i}\left(G_{1}\right)\right)+(x-1) \lambda_{i}\left(G_{1}\right)\right) .

The following corollary obtained from Theorem 3.1 when $G_{1}$ and $G_{2}$ are both regular graphs.

Corollary 3.2. Let $G_{i}$ be an $r_{i}$-regular graph with $n_{i}$ vertices and $m_{i}$ edges for $i=1,2$. Then the adjacency characteristic polynomial of $G_{1} \odot G_{2}$ is

\prod_{j=2}^{n_{2}}\left(x-\lambda_{j}\left(G_{2}\right)\right)^{n_{1}} \prod_{i=2}^{n_{1}}\left[x^{3}-x^{2}\left(r_{2}-1-\lambda_{i}\left(G_{1}\right)\right)-x\left(r_{2}+n_{2}+r_{1}+\right.\right. \\

The following corollary describes the complete spectrum of $G_{1} \odot G_{2}$, when $G_{1}$ and $G_{2}$ are both regular graphs.

Corollary 3.3. Let $G_{i}$ be an $r_{i}$-regular graph with $n_{i}$ vertices and $m_{i}$ edges for $i=1,2$. Then the adjacency spectrum of $G_{1} \odot G_{2}$ consists of

1. 0 , repeated $m_{1}-n_{1}$ times,
2. $\lambda_{j}\left(G_{2}\right)$, repeated $n_{1}$ times for $j=2,3, \ldots, n_{2}$,
3. three roots of the equation $x^{3}-x^{2}\left(r_{2}-1-\lambda_{i}\left(G_{1}\right)\right)-x\left(r_{2}+n_{2}+r_{1}+r_{2} \lambda_{i}\left(G_{1}\right)+\right.$ $\left.\lambda_{i}\left(G_{1}\right)\right)+r_{1} r_{2}+r_{2} \lambda_{i}\left(G_{1}\right)=0$ for $i=2, \ldots, n_{1}$,
4. three roots of the equation $x^{3}-x^{2}\left(r_{2}-1-r_{1}+n_{1}\right)-x\left(r_{2}+n_{2}+2 r_{1}+r_{1} r_{2}-\right.$ $\left.n_{1} r_{2}\right)+2 r_{1} r_{2}=0$.

Example 3.2. Let $G_{1}=K_{3,3}$ and $G_{2}=K_{2}$. Then the adjacency eigenvalues of $G_{1}$ are 0 (multiplicity 4) $\pm 3$, eigenvalues of $G_{2}$ are $\pm 1$. Therefore, the adjacency eigenvalues of $G_{1} \odot G_{2}$ are 0 (multiplicity 6 ), -1 (multiplicity 3 ), roots of the equation $x^{3}-6 x+3=0$ (each root with multiplicity 4 ), roots of the equation $x^{3}-3 x^{2}=0$ and roots of the equation $x^{3}-3 x^{2}-6 x+6=0$.

Next, we shall consider the adjacency spectrum of $G_{1} \odot G_{2}$ when $G_{1}$ is a regular graph and $G_{2}=K_{p, q}, G_{2}$ is non-regular if $p \neq q$.

Corollary 3.4. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges. Then the adjacency spectrum of $G_{1} \odot K_{p, q}$ consists of

1. 0 , repeated $m_{1}-n_{1}+n_{1}(p+q-2)$ times,
2. four roots of the equation $x^{4}+\left(1+\lambda_{i}\left(G_{1}\right)\right) x^{3}-\left(p q+p+q+r_{1}+\lambda_{i}\left(G_{1}\right)\right) x^{2}+$ $\left(-3 p q-p q \lambda_{i}\left(G_{1}\right)\right) x+p q \lambda_{i}\left(G_{1}\right)+r_{1} p q=0$ for $i=2, \ldots, n_{1}$,
3. four roots of the equation $x^{4}+\left(1+r_{1}-n_{1}\right) x^{3}-\left(p q+p+q+2 r_{1}\right) x^{2}+(-3 p q-$ $\left.p q r_{1}+p q n_{1}\right) x+2 p q r_{1}=0$.

Corollary 3.2 helps us to construct infinitely many pairs of $A$-cospectral graphs.
Corollary 3.5. (a) Let $G_{1}$ and $G_{2}$ be $A$-cospectral regular graphs and $H$ is any regular graph. Then $H \odot G_{1}$ and $H \odot G_{2}$ are $A$-cospectral.
(b) Let $G_{1}$ and $G_{2}$ be $A$-cospectral regular graphs and $H$ is any regular graph. Then $G_{1} \odot H$ and $G_{2} \odot H$ are $A$-cospectral.
(c) Let $G_{1}$ and $G_{2}$ be $A$-cospectral regular graphs, $H_{1}$ and $H_{2}$ are another $A$-cospectral regular graphs. Then $G_{1} \odot H_{1}$ and $G_{2} \odot H_{2}$ are $A$-cospectral.

Example 3.3. Consider the two regular non isomorphic cospectral graphs $G$ and $H$ as in [17. Graphs $C(G)$ and $C(H)$ as shown in Figure:3. Also, $G \odot K_{2}$ and $H \odot K_{2}$ are non isomorphic. If $G$ and $H$ are regular cospectral graphs, then they have the same regularity with same number of vertices and same number of edges. Since the eigenvalues of $C(G)$ [18] depends on number of vertices, regularity and eigenvalues of $G$. So $C(G)$ and $C(H)$ are $A$-cospectral. By applying Theorem 3.1 on the concerned graphs and comparing their characteristic polynomial we get $G \odot K_{2}$ and $H \odot K_{2}$ are $A$-cospectral graphs.

Next, we consider the Laplacian characteristic polynomial of $G_{1} \odot G_{2}$ when $G_{1}$ is regular and $G_{2}$ is an arbitrary graph.

Theorem 3.6. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the Laplacian characteristic polynomial of $G_{1} \odot G_{2}$ is

The following corollary describes the complete Laplacian spectrum of $G_{1} \odot G_{2}$, when $G_{1}$ is a regular graph and $G_{2}$ is an arbitrary graph.
Corollary 3.7. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the Laplacian spectrum of $G_{1} \odot G_{2}$ consists of

1. 2, repeated $m_{1}-n_{1}$ times,
2. $1+\mu_{j}\left(G_{2}\right)$, repeated $n_{1}$ times for $j=2,3, \ldots, n_{2}$,
3. three roots of the equation $x^{3}-x^{2}\left(n_{2}+r_{1}+3\right)+x\left(r_{1}+2 n_{2}+2\right)=0$,
4. three roots of the equation $x^{3}-x^{2}\left(n_{1}+n_{2}+3+\lambda_{i}\left(G_{1}\right)\right)+x\left(2 n_{2}+3 n_{1}+2 \lambda_{i}\left(G_{1}\right)+\right.$ $\left.\left.2-r_{1}\right)-2 n_{1}+r_{1}-\lambda_{i}\left(G_{1}\right)\right)=0$ for $i=2,3, \ldots, n_{1}$.
Corollary 3.8. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the number of spanning trees of $G_{1} \odot G_{2}$ is

Corollary 3.7 helps us to construct infinitely many pairs of $L$-cospectral graphs.
Corollary 3.10. (a) Let $G_{1}$ and $G_{2}$ be $L$-cospectral graphs and $H$ is an arbitarary regular graph. Then $H \odot G_{1}$ and $H \odot G_{2}$ are $L$-cospectral.
(b) Let $G_{1}$ and $G_{2}$ be $L$-cospectral regular graphs and $H$ is an arbitrary graph. Then $G_{1} \odot H$ and $G_{2} \odot H$ are $L$-cospectral.
(c) Let $G_{1}$ and $G_{2}$ be $L$-cospectral regular graphs, $H_{1}$ and $H_{2}$ are another $L$-cospectral regular graphs. Then $G_{1} \odot H_{1}$ and $G_{2} \odot H_{2}$ are $L$-cospectral.

Next, we consider the signless Laplacian characteristic polynomial of $G_{1} \odot G_{2}$ when $G_{1}$ is regular and $G_{2}$ is an arbitrary graph.
Theorem 3.11. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the signless Laplacian characteristic polynomial of $G_{1} \odot G_{2}$ is

Proof. Let $Q\left(G_{2}\right)$ be the signless Laplacian matrix of $G_{2}$. Then by a proper labeling of vertices, the signless Laplacian matrix of $G_{1} \odot G_{2}$ can be written as

The rest of the proof is similar to that of Theorem 3.6 and hence we omit details.
Next, we consider the signless Laplacian characteristic polynomial of $G_{1} \odot G_{2}$ when $G_{1}$ and $G_{2}$ are both regular graphs.

Corollary 3.12. Let $G_{i}$ be an $r_{i}$-regular graph with $n_{i}$ vertices and $m_{i}$ edges for $i=1,2$. Then the signless Laplacian characteristic polynomial of $G_{1} \odot G_{2}$ is

The following corollary illustrates the signless Laplacian spectrum of $G_{1} \odot G_{2}$, when $G_{1}$ and $G_{2}$ are both regular graphs.

Corollary 3.13. Let $G_{i}$ be an $r_{i}$-regular graph with $n_{i}$ vertices and $m_{i}$ edges for $i=1,2$. Then the signless Laplacian spectrum of $G_{1} \odot G_{2}$ consists of

1. 2, repeated $m_{1}-n_{1}$ times,
2. $1+\gamma_{j}\left(G_{2}\right)$, repeated $n_{1}$ times for $j=2,3, \ldots, n_{2}$,
3. three roots of the equation $x^{3}-x^{2}\left(n_{2}+2 n_{1}+2 r_{2}+1-r_{1}\right)+x\left(4 n_{1} r_{2}+2 n_{2} r_{2}+\right.$ $\left.6 n_{1}+2 n_{2}-4-2 r_{2} r_{1}-5 r_{1}\right)-8 n_{1} r_{2}-4 n_{2} r_{2}+2 r_{1} r_{2}+4 r_{1}-4 n_{1}+8 r_{2}+4+6 r_{2} r_{1}=0$,
4. three roots of the equation $x^{3}-x^{2}\left(n_{2}+n_{1}+2 r_{2}+1-\lambda_{i}\left(G_{1}\right)\right)+x\left(2 n_{1} r_{2}+2 n_{2} r_{2}+\right.$ $\left.3 n_{1}+2 n_{2}-r_{1}-4-2 r_{2} \lambda_{i}\left(G_{1}\right)-4 \lambda_{i}\left(G_{1}\right)\right)-4 n_{1} r_{2}-4 n_{2} r_{2}+2 r_{1} r_{2}+3 \lambda_{i}\left(G_{1}\right)+$ $r_{1}+8 r_{2}-2 n_{1}+6 r_{2} \lambda_{i}\left(G_{1}\right)+4=0$ for $i=2,3, \ldots, n_{1}$.

The following corollary helps us to construct infinitely many pairs of $Q$-cospectral graphs.

Corollary 3.14. (a) Let $G_{1}$ and $G_{2}$ be $Q$-cospectral regular graphs and $H$ is any regular graph. Then $H \odot G_{1}$ and $H \odot G_{2}$ are $Q$-cospectral.
(b) Let $G_{1}$ and $G_{2}$ be $Q$-cospectral regular graphs and $H$ is any regular graph. Then $G_{1} \odot H$ and $G_{2} \odot H$ are $Q$-cospectral.
(c) Let $G_{1}$ and $G_{2}$ be $Q$-cospectral regular graphs, $H_{1}$ and $H_{2}$ are another $Q$-cospectral regular graphs. Then $G_{1} \odot H_{1}$ and $G_{2} \odot H_{2}$ are $Q$-cospectral.

## 4 Spectra of central edge corona of graphs

In this section, we define central edge corona of two graphs and calculate their adjacency, Laplacian and signless Laplacian spectrum. Also, we compute the Kirchhoff index and the number of spanning trees of the resulting graphs. Using our results we establish some cospectral graphs.

Definition 4.1. Let $G_{i}$ be a graph with $n_{i}$ vertices and $m_{i}$ edges for $i=1,2$. The central edge corona $G_{1} \odot G_{2}$ of $G_{1}$ and $G_{2}$ is the graph obtained by taking $C\left(G_{1}\right)$ and $\left|\tilde{V}\left(G_{1}\right)\right|$ copies of $G_{2}$ and joining the $i^{t h}$ vertex of $\tilde{V}\left(G_{1}\right)$ to every vertex in the $i^{t h}$ copy of $G_{2}$.
The adjacency matrix of $G_{1} \odot G_{2}$ can be written as

\end{array}\right) .

The graph $G_{1} \odot G_{2}$ has $n_{1}+m_{1}+m_{1} n_{2}$ vertices and $m_{1}+\frac{n_{1}\left(n_{1}-1\right)}{2}+m_{1} m_{2}+m_{1} n_{2}$ edges.
Example 4.1. Let $G_{1}=P_{3}$ and $G_{2}=P_{2}$. Then the two central edge coronas $G_{1} \odot G_{2}$ and $G_{2} \odot G_{1}$ are depicted in Figure:4.


Figure:4 An example of central edge corona graphs

First we consider the adjacency characteristic polynomial of $G_{1} \underset{\odot}{ } G_{2}$.
Theorem 4.1. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the adjacency characteristic polynomial of $G_{1} \odot G_{2}$ is

\left.P\left(\lambda_{i}\left(G_{1}\right)\right)\left(x-\chi_{A\left(G_{2}\right)}(x)\right)+\left(x-\chi_{A\left(G_{2}\right)}(x)-1\right) \lambda_{i}\left(G_{1}\right)\right] .

The following corollary gives the spectrum of $G_{1} \odot G_{2}$, when $G_{1}$ and $G_{2}$ are both regular graphs.

Corollary 4.3. Let $G_{i}$ be an $r_{i}$-regular graph with $n_{i}$ vertices and $m_{i}$ edges for $i=1,2$. Then the adjacency spectrum of $G_{1} \odot G_{2}$ consists of

1. $\lambda_{j}\left(G_{2}\right)$, repeated $m_{1}$ times for $j=2,3, \ldots, n_{2}$,
2. two roots of the equation $x^{2}-x r_{2}-n_{2}=0$, each root repeated $m_{1}-n_{1}$ times,
3. three roots of the equation

4. three roots of the equation $x^{3}-x^{2}\left(r_{2}-\lambda_{i}\left(G_{1}\right)-1\right)-x\left(n_{2}+r_{2}+r_{2} \lambda_{i}\left(G_{1}\right)+r_{1}+\right.$ $\left.\lambda_{i}\left(G_{1}\right)\right)-n_{2} \lambda_{i}\left(G_{1}\right)+r_{2} \lambda_{i}\left(G_{1}\right)+r_{1} r_{2}-n_{2}=0$ for $i=2,3, \ldots, n_{1}$.

Example 4.2. Let $G_{1}=K_{3,3}$ and $G_{2}=K_{2}$. Then the adjacency eigenvalues of $G_{1}$ are 0 (multiplicity 4) and $\pm 3$, eigenvalues of $G_{2}$ are $\pm 1$. Therefore, the adjacency eigenvalues of $G_{1} \odot G_{2}$ are -1 (multiplicity 9 ), roots of the equation $x^{2}-x-2=0$ (each root with multiplicity 3 ), roots of the equation $x^{3}-3 x^{2}-6 x+10=0$, roots of the equation $x^{3}-3 x^{2}+4=0$ and roots of the equation $x^{3}-6 x+1=0$ (each root with multiplicity 4 ).

Next, we shall consider the adjacency spectrum of $G_{1} \odot G_{2}$ when $G_{1}$ is a regular graph and $G_{2}=K_{p, q}, G_{2}$ is non-regular if $p \neq q$.

Corollary 4.4. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges. Then the adjacency spectrum of $G_{1} \odot K_{p, q}$ consists of

1. 0 , repeated $m_{1}(p+q-2)$ times,
2. three roots of the equation $x^{3}-x(p q+p+q)-2 p q=0$, each root repeated $m_{1}-n_{1}$ times,
3. four roots of the equation $x^{4}+\left(1+\lambda_{i}\right) x^{3}-\left(p q+p+q+r_{1}+\lambda_{i}\left(G_{1}\right)\right) x^{2}+(-3 p q-$ $\left.p-q-p \lambda_{i}\left(G_{1}\right)-q \lambda_{i}\left(G_{1}\right)-p q \lambda_{i}\left(G_{1}\right)\right) x-2 p q-\lambda_{i}\left(G_{1}\right) p q+r_{1} p q=0$ for $i=2, \ldots, n_{1}$,
4. four roots of the equation $x^{4}+\left(1+r_{1}-n_{1}\right) x^{3}-\left(p q+p+q+2 r_{1}\right) x^{2}+(-3 p q-$ $\left.p-q+p q n_{1}+p n_{1}+q n_{1}-p q r_{1}-p r_{1}-q r_{1}\right) x-2 p q+2 p q n_{1}=0$.

Corollary 4.3 helps us to construct infinitely many pairs of $A$-cospectral graphs.
Corollary 4.5. (a) Let $G_{1}$ and $G_{2}$ be $A$-cospectral regular graphs and $H$ is any regular graph. Then $H \odot G_{1}$ and $H \odot G_{2}$ are $A$-cospectral.
(b) Let $G_{1}$ and $\bar{G}_{2}$ be $A$-cospectral regular graphs and $H$ is any regular graph. Then $G_{1} \odot H$ and $G_{2} \odot H$ are $A$-cospectral.
(c) Let $G_{1}$ and $G_{2}$ be A-cospectral regular graphs, $H_{1}$ and $H_{2}$ are another $A$-cospectral regular graphs. Then $G_{1} \odot H_{1}$ and $G_{2} \odot H_{2}$ are $A$-cospectral.

Example 4.3. Consider the two regular non isomorphic cospectral graphs $G$ and $H$ as in [17. By similar arguments as in Example 3.3, we have $G \odot K_{2}$ and $H \odot K_{2}$ are $A$-cospectral.


Figure:5 Non-regular non isomorphic $A$-cospectral graphs

Next, we discuss the Laplacian characteristic polynomial of $G_{1} \odot G_{2}$, when $G_{1}$ is a regular graph and $G_{2}$ is an arbitrary graph.

Theorem 4.6. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the Laplacian characteristic polynomial of $G_{1} \odot G_{2}$ is

& \left.+x\left(2+n_{1} n_{2}+3 n_{1}-r_{1}+n_{2} \lambda_{i}\left(G_{1}\right)+4 \lambda_{i}\left(G_{1}\right)\right)-2 n_{1}+r_{1}-\lambda_{i}\left(G_{1}\right)\right] .

The following corollary illustrates the complete Laplacian spectrum of $G_{1} \odot G_{2}$, when $G_{1}$ is a regular graph and $G_{2}$ is an arbitrary graph.
Corollary 4.7. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the Laplacian spectrum of $G_{1} \odot G_{2}$ consists of

1. two roots of the equation $x^{2}-x\left(n_{2}+3\right)+2=0$, each root repeated $m_{1}-n_{1}$ times,
2. $1+\mu_{j}\left(G_{2}\right)$, repeated $m_{1}$ times for $j=2,3, \ldots, n_{2}$,
3. three roots of the equation $x^{3}-x^{2}\left(n_{2}+r_{1}+3\right)+x\left(3 r_{1}+n_{2} r_{1}+2\right)=0$,
4. three roots of the equation $x^{3}-x^{2}\left(n_{2}+n_{1}+3+\lambda_{i}\left(G_{1}\right)\right)+x\left(2+n_{1} n_{2}+3 n_{1}-\right.$ $\left.r_{1}+n_{2} \lambda_{i}\left(G_{1}\right)+4 \lambda_{i}\left(G_{1}\right)\right)-2 n_{1}+r_{1}-\lambda_{i}\left(G_{1}\right)=0$ for $i=2,3, \ldots, n_{1}$.
Corollary 4.8. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the number of spanning trees of $G_{1} \odot G_{2}$ is

The following corollary help us to construct infinitely many pairs of $L$-cospectral graphs.

Corollary 4.10. (a) Let $G_{1}$ and $G_{2}$ be $L$-cospectral regular graphs and $H$ is an arbitarary graph. Then $H \odot G_{1}$ and $H \odot G_{2}$ are $L$-cospectral.
(b) Let $G_{1}$ and $G_{2}$ be $L$-cospectral regular graphs and $H$ is an arbitrary graph. Then $G_{1} \odot H$ and $G_{2} \odot H$ are $L$-cospectral.
(c) Let $G_{1}$ and $G_{2}$ be L-cospectral regular graphs, $H_{1}$ and $H_{2}$ are another $L$-cospectral regular graphs. Then $G_{1} \odot H_{1}$ and $G_{2} \odot H_{2}$ are $L$-cospectral.

Theorem 4.11. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the signless Laplacian characteristic polynomial of $G_{1} \odot G_{2}$ is

2. $1+\gamma_{j}\left(G_{2}\right)$, repeated $m_{1}$ times for $j=2,3, \ldots, n_{2}$,
3. three roots of the equation $x^{3}-x^{2}\left(n_{2}+2 r_{2}+2 n_{1}+1-r_{1}\right)+x\left(n_{1} n_{2}+4 r_{2} n_{1}+\right.$ $\left.2 n_{2} r_{2}+6 n_{1}-2 n_{2}-4-n_{2} r_{1}-2 r_{2}-5 r_{1}+n_{1} n_{2}\right)-4 n_{1} n_{2} r_{2}-8 n_{1} r_{2}+4 n_{2} r_{2}+$ $8 r_{1} r_{2}-4 n_{1}+4 r_{1}+8 r_{2}+4+2 n_{2} r_{2} r_{1}-2 n_{1} n_{2}=0$,

Corollary 4.12 enables us to construct infinitely many pairs of $Q$-cospectral graphs.
Corollary 4.14. (a) Let $G_{1}$ and $G_{2}$ be $Q$-cospectral regular graphs and $H$ is any regular graph. Then $H \odot G_{1}$ and $H \odot G_{2}$ are $Q$-cospectral.
(b) Let $G_{1}$ and $G_{2}$ be $Q$-cospectral regular graphs and $H$ is any regular graph. Then $G_{1} \odot H$ and $G_{2} \odot H$ are $Q$-cospectral.
(c) Let $G_{1}$ and $\bar{G}_{2}$ be Q-cospectral regular graphs, $H_{1}$ and $H_{2}$ are another $Q$-cospectral regular graphs. Then $G_{1} \odot H_{1}$ and $G_{2} \odot H_{2}$ are $Q$-cospectral.

## 5 Spectra of central edge neighborhood corona of graphs

In this section, we define a new graph operation called central edge neighborhood corona of graphs and determine its adjacency spectrum, Laplacian spectrum, and
signless Laplacian spectrum. Also, our results leads us to construct new pairs of cospctral graphs. It is possible to calculate the number of spanning trees and the Kirchhoff index of the resulting graphs.

Operation 5.1. Let $G_{i}$ be a graph with $n_{i}$ vertices and $m_{i}$ edges for $i=1,2$. Then the central edge neighborhood corona $G_{1} \unrhd G_{2}$ of two graphs $G_{1}$ and $G_{2}$ is the graph obtained by taking $C\left(G_{1}\right)$ and $\left|\tilde{V}\left(G_{1}\right)\right|$ copies of $G_{2}$ and joining the neighbors of the $i^{\text {th }}$ vertex of $\tilde{V}\left(G_{1}\right)$ to every vertex in the $i^{\text {th }}$ copy of $G_{2}$.
The adjacency matrix of $G_{1} \unrhd G_{2}$ can be written as

The graph $G_{1} \unrhd G_{2}$ has $n_{1}+m_{1}+m_{1} n_{2}$ vertices and $m_{1}+\frac{n_{1}\left(n_{1}-1\right)}{2}+m_{1} m_{2}+2 m_{1} n_{2}$ edges .

Example 5.1. Let $G_{1}=P_{3}$ and $G_{2}=P_{2}$. Then the two central edge coronas $G_{1} \sqsupseteq G_{2}$ and $G_{2} \unrhd G_{1}$ are depicted in Figure:6.


Figure:6 An example of central edge neighborhood corona graphs

First we calculate the adjacency characteristic polynomial of $G_{1} Ð G_{2}$.
Theorem 5.1. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the adjacency characteristic polynomial of $G_{1} \sqsupseteq G_{2}$ is

2. $r_{2}$, repeated $m_{1}-n_{1}$ times,
3. $\lambda_{j}\left(G_{2}\right)$, repeated $m_{1}$ times for $j=2,3, \ldots, n_{2}$,
4. three roots of the equation $x^{3}+x^{2}\left(1-r_{2}+\lambda_{i}\left(G_{1}\right)\right)-x\left(n_{2} r_{1}+r_{1}+r_{2}+r_{2} \lambda_{i}\left(G_{1}\right)+\right.$ $\left.n_{2} \lambda_{i}\left(G_{1}\right)+\lambda_{i}\left(G_{1}\right)\right)+r_{1} r_{2}+r_{2} \lambda_{i}\left(G_{1}\right)=0$ for $i=2, \ldots, n_{1}$,
5. three roots of the equation $x^{3}+x^{2}\left(1-r_{2}+r_{1}-n_{1}\right)-x\left(2 n_{2} r_{1}+2 r_{1}+r_{2}+r_{2} r_{1}-\right.$ $\left.n_{1} r_{2}\right)+2 r_{1} r_{2}=0$.

Example 5.2. Let $G_{1}=K_{3,3}$ and $G_{2}=K_{2}$. Then the adjacency eigenvalues of $G_{1}$ are 0 (multiplicity 4) and $\pm 3$, eigenvalues of $G_{2}$ are $\pm 1$. Therefore, the adjacency eigenvalues of $G_{1} \unrhd G_{2}$ are 0 (multiplicity 3 ), 1 (multiplicity 3 ), -1 (multiplicity 9), roots of the equation $x^{2}-x-2=0$ (each root with multiplicity 3 ), roots of the equation $x^{3}-3 x^{2}-16 x+6=0$, roots of the equation $x^{3}-3 x^{2}+2 x=0$ and roots of the equation $x^{3}-10 x+3=0$ (each root with multiplicity 4).

Next, we shall consider the adjacency spectrum of $G_{1} \unrhd G_{2}$ when $G_{1}$ is a regular graph and $G_{2}=K_{p, q}, G_{2}$ is non-regular if $p \neq q$.

Corollary 5.4. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges. Then the adjacency spectrum of $G_{1} \sqsupseteq K_{p, q}$ consists of

1. 0 , repeated $m_{1}-n_{1}+m_{1}(p+q-2)$ times,
2. $\pm \sqrt{p q}$, repeated $m_{1}-n_{1}$ times,
3. four roots of the equation $x^{4}+\left(1+r_{1}-n_{1}\right) x^{3}-\left(p q+r_{1} p+r_{1} q+2 r_{1}+p r_{1}+\right.$ $\left.q r_{1}\right) x^{2}+\left(-p q-5 r_{1} p q+n_{1} p q\right) x+2 r_{1} p q=0$,
4. four roots of the equation $x^{4}+\left(1+\lambda_{i}\right) x^{3}-\left(p q+r_{1} p+r_{1} q+r_{1}+(p+q+\right.$ 1) $\left.\lambda_{i}\left(G_{1}\right)\right) x^{2}+\left(-p q-2 r_{1} p q-3 p q \lambda_{i}\left(G_{1}\right)\right) x+r_{1} p q+p q \lambda_{i}\left(G_{1}\right)=0$ for $i=2, \ldots, n_{1}$.

The following corollary enables us to construct infinitely many pairs of $A$-cospectral graphs.

Corollary 5.5. (a) Let $G_{1}$ and $G_{2}$ be $A$-cospectral regular graphs and $H$ is any regular graph. Then $H \bigoplus G_{1}$ and $H \emptyset G_{2}$ are $A$-cospectral.
(b) Let $G_{1}$ and $G_{2}$ be $A$-cospectral regular graphs and $H$ is any regular graph. Then $G_{1} \unrhd H$ and $G_{2} \sqsupseteq H$ are $A$-cospectral.
(c) Let $G_{1}$ and $G_{2}$ be $A$-cospectral regular graphs, $H_{1}$ and $H_{2}$ are another $A$-cospectral regular graphs. Then $G_{1} \unrhd H_{1}$ and $G_{2} \unrhd H_{2}$ are $A$-cospectral.

Next, we consider the Laplacian characteristic polynomial of $G_{1} Ð G_{2}$.
Theorem 5.6. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the Laplacian characteristic polynomial of $G_{1} \sqsupseteq G_{2}$ is

$f\left(L\left(G_{1} \unrhd G_{2}\right), x\right)=\operatorname{det}\left(\begin{array}{ccc}\left(x-n_{1}+1-n_{2} r_{1}\right) I_{n_{1}}+A\left(\bar{G}_{1}\right) & I\left(G_{1}\right) & I\left(G_{1}\right) \otimes J_{1 \times n_{2}} \\ I\left(G_{1}\right)^{T} & (x-2) I_{m_{1}} & O_{m_{1} \times m_{1} n_{2}} \\ I\left(G_{1}\right)^{T} \otimes J_{1 \times n_{2}}^{T} & O_{m_{1} n_{2} \times m_{1}} & I_{m_{1}} \otimes\left((x-2) I_{n_{2}}-L\left(G_{2}\right)\right)\end{array}\right)$.
By Lemmas 2.1, 2.2, Definition 2.1, equation (2.0.1) and Corollary 2.6, we have

\end{array}\right) \\
& \left.=(x-2)^{m_{1}} \operatorname{det}\left(x-n_{1}-n_{2} r_{1}\right) I_{n_{1}}+J_{n_{1}}-A\left(G_{1}\right)-\chi_{L\left(G_{2}\right)}(x-2) I\left(G_{1}\right) I\left(G_{1}\right)^{T}-\frac{I\left(G_{1}\right) I\left(G_{1}\right)^{T}}{x-2}\right) \\

Note that $\mu_{1}\left(G_{2}\right)=0, P\left(\lambda_{1}\left(G_{1}\right)\right)=n_{1}, P\left(\lambda_{i}\left(G_{1}\right)\right)=0, i=2, \ldots, n_{1}$.
Thus the characteristic polynomial of $L\left(G_{1} \unrhd G_{2}\right)$ is

& f\left(L\left(G_{1} \varrho G_{2}\right), x\right)=(x-2)^{m_{1}-n_{1}}\left[x^{2}-x\left(n_{2} r_{1}+r_{1}+2\right)\right] \prod_{j=1}^{n_{2}}\left(x-1-\mu_{j}\left(G_{2}\right)\right)^{m_{1}} \\
& \times \prod_{i=2}^{n_{1}}\left[x^{2}-x\left(2+n_{1}+n_{2} r_{1}+\lambda_{i}\left(G_{1}\right)\right)+2 n_{1}+n_{2} r_{1}-r_{1}+\lambda_{i}\left(G_{1}\right)-n_{2} \lambda_{i}\left(G_{1}\right)\right]
\end{aligned}
$$

The following corollary describes the complete Laplacian spectrum of $G_{1} \unrhd G_{2}$, when $G_{1}$ is a regular graph and $G_{2}$ is an arbitrary graph.

Corollary 5.7. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the Laplacian spectrum of $G_{1} Ð G_{2}$ consists of

1. 2, repeated $m_{1}-n_{1}$ times,
2. $1+\mu_{j}\left(G_{2}\right)$, repeated $m_{1}$ times for $j=1,2,3, \ldots, n_{2}$,
3. two roots of the equation $x^{2}-x\left(n_{2} r_{1}+r_{1}+2\right)=0$,
4. two roots of the equation $x^{2}-x\left(2+n_{1}+n_{2} r_{1}+\lambda_{i}\left(G_{1}\right)\right)+2 n_{1}+n_{2} r_{1}-r_{1}+(1-$ $\left.n_{2}\right) \lambda_{i}\left(G_{1}\right)=0$ for $i=2,3, \ldots, n_{1}$.

Corollary 5.8. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the number of spanning trees of $G_{1} \unrhd G_{2}$ is

t\left(G_{1} \sqsupseteq G_{2}\right)=\frac{2^{m_{1}-n_{1}}\left(n_{2} r_{1}+r_{1}+2\right) \prod_{j=1}^{n_{2}}\left(1+\mu_{j}\left(G_{2}\right)\right)^{m_{1}} \prod_{i=2}^{n_{1}}\left[2 n_{1}+n_{2} r_{1}-r_{1}+\lambda_{i}\left(G_{1}\right)-n_{2} \lambda_{i}\left(G_{1}\right)\right]}{n_{1}+m_{1}+m_{1} n_{2}}
$$

Corollary 5.9. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the Kirchhoff index of $G_{1} \sqsupseteq G_{2}$ is

$$

K f\left(G_{1} Ð G_{2}\right)=\left(n_{1}+m_{1}+m_{1} n_{2}\right)\left[\frac{m_{1}-n_{1}}{2}\right. & +\frac{1}{n_{2} r_{1}+r_{1}+2}+\sum_{j=2}^{n_{2}} \frac{m_{1}}{1+\mu_{j}\left(G_{2}\right)}+ \\
& \left." \sum_{i=2}^{n_{1}} \frac{2+n_{1}+n_{2} r_{1}+\lambda_{i}\left(G_{1}\right)}{2 n_{1}+n_{2} r_{1}-r_{1}+\lambda_{i}\left(G_{1}\right)-n_{2} \lambda_{i}\left(G_{1}\right)}\right] .
\end{aligned}
$$

The following corollary helps us to construct infinitely many pairs of $L$-cospectral graphs.

Corollary 5.10. (a) Let $G_{1}$ and $G_{2}$ be $L$-cospectral regular graphs and $H$ is an arbitarary graph. Then $H \varrho G_{1}$ and $H \varrho G_{2}$ are $L$-cospectral.
(b) Let $G_{1}$ and $G_{2}$ be $L$-cospectral regular graphs and $H$ is an arbitrary graph. Then $G_{1} \unrhd H$ and $G_{2} \sqsupseteq H$ are $L$-cospectral.
(c) Let $G_{1}$ and $G_{2}$ be L-cospectral regular graphs, $H_{1}$ and $H_{2}$ are another $L$-cospectral regular graphs. Then $G_{1} \unrhd H_{1}$ and $G_{2} \unrhd H_{2}$ are $L$-cospectral.

Next we consider the signless Laplacian characteristic polynomial of $G_{1} \odot G_{2}$ when $G_{1}$ is regular and $G_{2}$ is an arbitrary graph.

Theorem 5.11. Let $G_{1}$ be an $r_{1}$-regular graph with $n_{1}$ vertices and $m_{1}$ edges and $G_{2}$ be an arbitrary graph with $n_{2}$ vertices. Then the signless Laplacian characteristic polynomial of $G_{1} Ð G_{2}$ is

$$
\begin{aligned}
f\left(Q\left(G_{1} \sqsupseteq G_{2}\right), x\right)= & (x-2)^{m_{1}-n_{1}} \prod_{j=2}^{n_{2}}\left(x-1-\gamma_{j}\left(G_{2}\right)\right)^{m_{1}} \\
\times & \prod_{i=1}^{n_{1}}\left[\left(x-n_{1}+2-n_{2} r_{1}-r_{1} \chi_{Q\left(G_{2}\right)}(x-2)-\frac{r_{1}}{x-2}\right)-P\left(\lambda_{i}\left(G_{1}\right)\right)+\right. \\
& \left.\left(1-\chi_{Q\left(G_{2}\right)}(x-2)-\frac{1}{x-2}\right) \lambda_{i}\left(G_{1}\right)\right]
\end{aligned}
$$

Proof. Let $Q\left(G_{2}\right)$ be the signless Laplacian matrix of $G_{2}$. Then by a proper labeling of vertices, the Laplacian matrix of $G_{1} \unrhd G_{2}$ can be written as

\left(n_{1}-1+r_{1} n_{2}\right) I_{n_{1}}+A\left(\bar{G}_{1}\right) & I\left(G_{1}\right) & I\left(G_{1}\right) \otimes J_{1 \times n_{2}} \\
I\left(G_{1}\right)^{T} & 2 I_{m_{1}} & O_{m_{1} \times m_{1} n_{2}} \\
I\left(G_{1}\right)^{T} \otimes J_{1 \times n_{2}}^{T} & O_{m_{1} n_{2} \times m_{1}} & I_{m_{1}} \otimes\left(2 I_{n_{2}}+Q\left(G_{2}\right)\right)
\end{array}\right) .
$$

The signless Laplacian characteristic polynomial of $G_{1} \unrhd G_{2}$ is

$$
f\left(Q\left(G_{1} @ G_{2}\right), x\right)=\operatorname{det}\left(\begin{array}{ccc}
\left(x-n_{1}+1-r_{1} n_{2}\right) I_{n_{1}}-A\left(\bar{G}_{1}\right) & -I\left(G_{1}\right) & -I\left(G_{1}\right) \otimes J_{1 \times n_{2}} \\
-I\left(G_{1}\right)^{T} & (x-2) I_{m_{1}} & O_{n_{1} \times m_{1} n_{2}} \\
-I\left(G_{1}\right)^{T} \otimes J_{1 \times n_{2}}^{T} & O_{m_{1} n_{2} \times n_{1}} & I_{m_{1}} \otimes\left((x-2) I_{n_{2}}-Q\left(G_{2}\right)\right)
\end{array}\right) .
$$

The rest of the proof is similar to that of Theorem 5.6 and hence we omit details.
Next we consider the signless Laplacian characteristic polynomial of $G_{1} \odot G_{2}$ when $G_{1}$ and $G_{2}$ are both regular graphs.

Corollary 5.12. Let $G_{i}$ be an $r_{i}$-regular graph with $n_{i}$ vertices and $m_{i}$ edges for $i=1,2$. Then the signless Laplacian characteristic polynomial of $G_{1} \boxminus G_{2}$ is

$$
\begin{aligned}
& f\left(Q\left(G_{1} \unrhd G_{2}\right), x\right) \\
& =(x-2)^{m_{1}-n_{1}}\left[x^{3}-x^{2}\left(n_{2} r_{1}+2 r_{2}+2-r_{1}+2 n_{1}\right)+x\left(2 n_{2} r_{1} r_{2}-n_{2} r_{1}-2 r_{2} r_{1}+4 n_{1} r_{2}+3 n_{2} r_{1}-6 r_{1}+\right.\right. \\
& \left.\left.8 n_{1}-4\right)-4 n_{2} r_{1} r_{2}+6 r_{2} r_{1}-8 n_{1} r_{2}+2 r_{1} r_{2}+6 r_{1}-8 n_{1}+2 r_{1}+8 r_{2}+8\right] \\
& \times \prod_{j=2}^{n_{2}}\left(x-1-\gamma_{j}\left(G_{2}\right)\right)^{m_{1}} \prod_{i=2}^{n_{1}}\left[x^{3}-x^{2}\left(n_{2} r_{1}+2 r_{2}+n_{1}+2-\lambda_{i}\left(G_{1}\right)\right)+x\left(2 n_{2} r_{1} r_{2}-n_{2} \lambda_{i}\left(G_{1}\right)\right.\right. \\
& \left.-2 r_{2} \lambda_{i}\left(G_{1}\right)+2 n_{1} r_{2}+3 n_{2} r_{1}-5 \lambda_{i}\left(G_{1}\right)+4 n_{1}-r_{1}-4\right)+\left(-4 n_{2} r_{1} r_{2}-2 n_{2} \lambda_{i}\left(G_{1}\right)+6 r_{2} \lambda_{i}\left(G_{1}\right)\right) \\
& \left.\quad-4 n_{1} r_{2}-2 n_{2} r_{1}+2 r_{1} r_{2}+6 \lambda_{i}\left(G_{1}\right)-4 n_{1}+2 r_{1}+8 r_{2}+8\right] .

The signless Laplacian spectrum of $G_{1} \emptyset G_{2}$ is obtained from the following corollary.
Corollary 5.13. Let $G_{i}$ be an $r_{i}$-regular graph with $n_{i}$ vertices and $m_{i}$ edges for $i=1,2$. Then the signless Laplacian spectrum of $G_{1} \sqsupseteq G_{2}$ consists of

1. 2, repeated $m_{1}-n_{1}$ times,
2. $1+\gamma_{j}\left(G_{2}\right)$, repeated $m_{1}$ times for $j=2,3, \ldots, n_{2}$,
3. three roots of the equation $x^{3}-x^{2}\left(n_{2} r_{1}+2 r_{2}+2-r_{1}+2 n_{1}\right)+x\left(2 n_{2} r_{1} r_{2}-n_{2} r_{1}-\right.$ $\left.2 r_{2} r_{1}+4 n_{1} r_{2}+3 n_{2} r_{1}-6 r_{1}+8 n_{1}-4\right)-4 n_{2} r_{1} r_{2}+6 r_{2} r_{1}-8 n_{1} r_{2}+2 r_{1} r_{2}+6 r_{1}-$ $8 n_{1}+2 r_{1}+8 r_{2}+8=0$,
4. three roots of the equation $x^{3}-x^{2}\left(n_{2} r_{1}+2 r_{2}+n_{1}+2-\lambda_{i}\left(G_{1}\right)\right)+x\left(2 n_{2} r_{1} r_{2}-\right.$ $\left.n_{2} \lambda_{i}\left(G_{1}\right)-2 r_{2} \lambda_{i}\left(G_{1}\right)+2 n_{1} r_{2}+3 n_{2} r_{1}-5 \lambda_{i}\left(G_{1}\right)+4 n_{1}-r_{1}-4\right)+\left(-4 n_{2} r_{1} r_{2}-\right.$ $\left.2 n_{2} \lambda_{i}\left(G_{1}\right)+6 r_{2} \lambda_{i}\left(G_{1}\right)\right)-4 n_{1} r_{2}-2 n_{2} r_{1}+2 r_{1} r_{2}+6 \lambda_{i}\left(G_{1}\right)-4 n_{1}+2 r_{1}+8 r_{2}+8=0$ for $i=2, \ldots, n_{1}$.

The following corollary helps us to construct infinitely many pairs of $Q$-cospectral graphs.

Corollary 5.14. (a) Let $G_{1}$ and $G_{2}$ be $Q$-cospectral regular graphs and $H$ is any regular graph. Then $H \unrhd G_{1}$ and $H \unrhd G_{2}$ are $Q$-cospectral.
(b) Let $G_{1}$ and $G_{2}$ be $Q$-cospectral regular graphs and $H$ is any regular graph. Then $G_{1} \unrhd H$ and $G_{2} \sqsupseteq H$ are $Q$-cospectral.
(c) Let $G_{1}$ and $G_{2}$ be $Q$-cospectral regular graphs, $H_{1}$ and $H_{2}$ are another $Q$-cospectral regular graphs. Then $G_{1} \unrhd H_{1}$ and $G_{2} \unrhd H_{2}$ are $Q$-cospectral.

## 6 Conclusion

In this paper, we determine the different types of spectra of central vertex corona, central edge corona, and central edge neighborhood corona of regular graphs. As an application of these results we construct infinitely many pairs of $A$-cospectral, $L$ cospectral and $Q$-cospectral graphs. Further, we compute the number of spanning trees and the Kirchhoff index of these graphs.
