# The fractional chromatic number of $K_{\Delta}$-free graphs

#### Abstract

For a simple graph $G$, let $\chi_{f}(G)$ be the fractional chromatic number of $G$. In this paper, we aim to establish upper bounds on $\chi_{f}(G)$ for those graphs $G$ with restrictions on the clique number. Namely, we prove that for $\Delta \geq 4$, if $G$ has maximum degree at most $\Delta$ and is $K_{\Delta}$-free, then $\chi_{f}(G) \leq \Delta-\frac{1}{8}$ unless $G=C_{8}^{2}$ or $G=C_{5} \boxtimes K_{2}$. This improves the result in [King, Lu, and Peng, SIAM J. Discrete Math., 26(2) (2012), pp. 452-471] for $\Delta \geq 4$ and the result in [Katherine and King, SIAM J. Discrete Math., $27(2)$ (2013), pp. 1184-1208] for $\Delta \in\{6,7,8\}$.


## 1 Introduction

In this paper, we use $\chi(G)$ to denote the chromatic number of a simple graph $G$. It is well-known that $\Delta+1$ is a trivial upper bound for $\chi(G)$, where $\Delta$ is the maximum degree of $G$. The famous Brooks' Theorem states that if the maximum degree of a connected graph $G$ is $\Delta$, then $\chi(G) \leq \Delta$ unless $G$ is $K_{\Delta+1}$ or an odd cycle. This seminal result leads to the idea bounding the chromatic number $\chi(G)$ in terms of the maximum degree $\Delta(G)$ and the clique number $\omega(G)$. For $\Delta \geq 3$, Brooks' Theorem asserts that if $G$ is $K_{\Delta+1}$-free (i.e., $\omega(G) \leq \Delta(G)$ ), then $\chi(G) \leq \Delta(G)$. One may ask to show an upper bound for $\chi(G)$ if $G$ is $K_{\Delta}$-free. This is exactly the following conjecture by Borodin and Kostochka [1].

Conjecture 1 For a connected graph $G$, if $\omega(G) \leq \Delta(G)-1$ and $\Delta(G) \geq 9$, then we have $\chi(G) \leq \Delta(G)-1$.

If the conjecture is true, then it is best possible since there is a $K_{8}$-free graph $G=C_{5} \boxtimes K_{3}$ (see Figure (1) with $\Delta(G)=8, \omega(G)=6$, and $\chi(G)=8$.


Figure 1: The graphs $C_{5} \boxtimes K_{3}, C_{8}^{2}$, and $C_{5} \boxtimes K_{2}$.

[^0]Given two graphs $G$ and $H$, the strong product $G \boxtimes H$ is the graph with vertex set $V(G) \times V(H)$, and $(u, x)$ is connected to $(v, y)$ if one of the following holds

1: $u=v$ and $x y \in E(H)$,
2: $u v \in E(G)$ and $x=y$,
3: $u v \in E(G)$ and $x y \in E(H)$.
Using the probabilistic methods, Reed [17] confirmed Conjecture for $\Delta \geq 10^{14}$. In the same paper, Reed claimed that a careful calculation could reduce $10^{14}$ to $10^{3}$. Let us assume that Conjecture 1 is true for $\Delta \geq 10^{3}$. This is the state of the art of Conjecture 1 . King, Lu , and Peng first considered to bound the fractional chromatic number of $K_{\Delta}$-free graphs, which can be viewed as the fractional analog of Conjecture 1 .

The fractional chromatic number $\chi_{f}(G)$ of a graph $G$ can be defined as follows. For positive integers $a$ and $b$ with $b \leq a$, we use $[a]$ to denote the set of first $a$ positive integers and $\binom{[a]}{b}$ to denote the set of $b$-subsets of $[a]$. An (a:b)-coloring of a graph $G$ is a mapping $\psi: V(G) \rightarrow\binom{[a]}{b}$ such that $\psi(u) \cap \psi(v)=\emptyset$ whenever $u v \in E(G)$. The b-fold coloring number of $G$, denoted by $\chi_{b}(G)$, is the smallest integer $a$ such that $G$ has an ( $a: b$ )-coloring. Note that $\chi_{1}(G)=\chi(G)$. The fractional chromatic number $\chi_{f}(G)$ of $G$ is $\lim _{b \rightarrow \infty} \frac{\chi_{b}(G)}{b}$. If $G$ is vertex transitive, then $\chi_{f}(G)=\frac{|V(G)|}{\alpha(G)}$, where $\alpha(G)$ is the independence number of $G$.

For $\Delta \geq 3$, we define

$$
f(\Delta)=\min _{G}\left\{\Delta-\chi_{f}(G): \Delta(G) \leq \Delta, \omega(G) \leq \Delta-1, G \notin\left\{C_{8}^{2}, C_{5} \boxtimes K_{2}\right\}\right\}
$$

The value of $f(3)$ received a great deal of attention. Actually, based on the study of independent sets in triangle-free subcubic graphs 4, 7, 9, 19, Heckman and Thomas 9 conjectured $f(3)=\frac{1}{5}$. Before Dvořák, Sereni, and Volec 2 proved Heckman and Thomas' Conjecture, progress towards this conjecture can be found in [5, 8, 11, 13, 14]. King, Lu, and Peng [12] first proved that $f(\Delta) \geq \frac{2}{67}$ for each $\Delta \geq 4$,. Edwards and King [3] established an improved lower bound on $f(\Delta)$ for all $\Delta \geq 6$. In particular, they showed $f(6) \geq \frac{1}{22.5}$, $f(7) \geq \frac{1}{11.2}, f(8) \geq \frac{1}{8.9}$, and $f(\Delta)>\frac{1}{7.7}$ for each $\Delta \geq 9$.

We prove the following theorem in this paper.
Theorem 1 For each $\Delta \geq 4$, if $G$ has maximum degree at most $\Delta$ and is $K_{\Delta}$-free, then $\chi_{f}(G) \leq \Delta-\frac{1}{8}$ unless $G=C_{8}^{2}$ or $G=C_{5} \boxtimes K_{2}$ (see Figure 1).
By the theorem above, we get $f(\Delta) \geq \frac{1}{8}$ for each $\Delta \geq 4$. Therefore, Theorem 11 improves the result of King, Lu, and Peng [12] for each $\Delta \geq 4$ and the result of Edwards and King [3] for $\Delta \in\{6,7,8\}$.

The rest of this paper is organized as follows. In Section 2, we will prove Theorem 1 , Section 3 is devoted to prove technical lemmas.

## 2 Proof of Theorem 1

Recall the definition of $f(\Delta)$. King, Lu, and Peng [12] proved the following lemma on $f(\Delta)$.
Lemma 1 For each $\Delta \geq 6$, we have $f(\Delta) \geq \min \left\{f(\Delta-1), \frac{1}{2}\right\}$. We also have $f(5) \geq$ $\min \left\{f(4), \frac{1}{3}\right\}$.

In view of Lemman in order to prove Theorem 1 , we need only to show $f(4) \geq \frac{1}{8}$. We define

$$
\mathcal{G}=\left\{G: \Delta(G) \leq 4, \omega(G) \leq 3, \text { and } G \neq C_{8}^{2}\right\}
$$

Equivalently, we have to show $\chi_{f}(G) \leq 4-\frac{1}{8}$ for each $G \in \mathcal{G}$. Actually, we will prove a stronger result. To state our result, we need to introduce some definitions.

Let $G$ be a graph. For $v \in V(G)$, the degree $d_{G}(v)$ of $v$ is the number of edges incident with $v$ in $G$. For two vertices $u$ and $v$ of $G$, let $\operatorname{dist}_{G}(u, v)$ be the length of a shortest path between $u$ and $v$. For $v \in V(G)$ and a positive integer $j$, let $N_{G}^{j}(v)=\left\{u \in V(G): \operatorname{dist}_{G}(u, v)=j\right\}$. If $S$ and $T$ are two disjoint subsets of $V(G)$, then the number of edges between $S$ and $T$ is denoted by $e(S, T)$. A demand function $h_{G}$ is a function from $V(G)$ to $[0,1]$ taking rational values. For positive integers $a$ and $b$ with $a<b$, we use $[a, b]$ to denote the set $\{a, a+1, \ldots, b\}$. If $a=1$, then we write $[b]$ instead of $[1, b]$ for short. Suppose $h_{G}$ is a demand function and $N$ is a positive integer such that $N \cdot h_{G}(v)$ is a positive integer for each $v \in V(G)$. Let $\psi$ be a function from $V(G)$ to the set of all subsets of $[N]$. If $|\psi(v)| \geq N h_{G}(v)$ holds for each $v \in V(G)$, then we say $\psi$ is an $\left(h_{G}, N\right)$-coloring of $G$. We mention a few remarks on these definitions.
(i) If $G$ has an $\left(h_{G}, N\right)$-coloring, then $G$ also has an $\left(h_{G}, M\right)$-coloring provided $M$ is divisible by $N$. Actually, we can duplicate each color from an $\left(h_{G}, N\right)$-coloring $M / N$ times to get an $\left(h_{G}, M\right)$-coloring.
(ii) If $\psi$ is an $\left(h_{G}, N\right)$-coloring of $G$, then we can assume that $|\psi(v)|=N h_{G}(v)$ for each $v \in V(G)$ by deleting colors from $\psi(v)$. We will keep this assumption in the rest of this paper.
(iii) To show $\chi_{f}(G) \leq r$ for a rational number $r$, it is enough to show $G$ has an $\left(h_{G}, N\right)$ coloring such that $h_{G}(v) \geq 1 / r$ for each $v \in V(G)$.

In order to prove $\chi_{f}(G) \leq 4-\frac{1}{8}$ for each $G \in \mathcal{G}$, we define a demand function $h_{G}$ as following:
(i) If $1 \leq d_{G}(v) \leq 4$, then $h_{G}(v)=\frac{12-d_{G}(v)}{31}$;
(ii) If $d_{G}(v)=0$, then $h_{G}(v)=1$.

We will prove the following stronger result.
Theorem 2 For each $G \in \mathcal{G}$, there is a positive integer $N_{G}$ such that $G$ has an $\left(h_{G}, N_{G}\right)$ coloring.

It is easy to see Theorem 2 implies that $\chi_{f}(G) \leq 4-\frac{1}{8}$ for each $G \in \mathcal{G}$. We next prove Theorem 2 by contradiction. Let $G \in \mathcal{G}$ be a counterexample with the smallest number of vertices. The following simple remark follows from the remark (i) on the definition of $\left(h_{G}, N\right)$-coloring.

Remark 1 There exists a positive integer $M$ such that each graph $G^{\prime}$ with $\left|V\left(G^{\prime}\right)\right|<|V(G)|$ has an $\left(h_{G^{\prime}}, M\right)$-coloring.

As $G$ is a minimum counterexample, $G^{\prime}$ has an $\left(h_{G^{\prime}}, N_{G^{\prime}}\right)$-coloring for each $G^{\prime}$ with $\left|V\left(G^{\prime}\right)\right|<$ $\mid V(G)$. Thus we can take $M$ as the least common multiplier of $N_{G^{\prime}}$, where $G^{\prime}$ ranges over all graphs satisfying $\left|V\left(G^{\prime}\right)\right|<|V(G)|$.

We will show that $G$ satisfies the following properties.
Lemma 2 The graph $G$ is 2-connected and satisfies $\delta(G) \geq 3$.
Proof: Clearly, $G$ is connected. If $G$ contains a cut-vertex $v$, then there are two subgraphs $G_{1}$ and $G_{2}$ such that $V\left(G_{1}\right) \cup V\left(G_{2}\right)=V(G)$ and $V\left(G_{1}\right) \cap V\left(G_{2}\right)=\{v\}$. As $G$ is a minimum counterexample, the graph $G_{i}$ has an $\left(h_{G_{i}}, M\right)$-coloring $\psi_{i}$ for $1 \leq i \leq 2$. By deleting colors if it is necessary, we can assume that $\left|\psi_{1}(v)\right|=\left|\psi_{2}(v)\right|=M \cdot h_{G}(v)$, here $h_{G}(v)=\frac{12-d_{G}(v)}{31}$.

By permuting colors in $\psi_{2}$, we can further assume that $\psi_{1}(v)=\psi_{2}(v)$. Thus the union of $\psi_{1}$ and $\psi_{2}$ is an $\left(h_{G}, M\right)$-coloring of $G$. A contradiction.

Since $G$ is 2 -connected, we get $\delta(G) \geq 2$. Suppose that there exists $v \in V(G)$ with $d_{G}(v)=2$. Let $u$ and $w$ be the neighbors of $v$. By the minimality of $G$, the graph $G^{\prime}=G-v$ has an $\left(h_{G^{\prime}}, M\right)$-coloring, say $\psi$. Deleting colors from $\psi(u)$ and $\psi(w)$, we can assume that $|\psi(u)|=M \cdot \frac{12-d_{G}(u)}{31}$ and $|\psi(w)|=M \cdot \frac{12-d_{G}(w)}{31}$. Since $d_{G}(u) \geq 2$ and $d_{G}(w) \geq 2$, it follows that $|\psi(u)| \leq \frac{10}{31} \cdot M$ and $|\psi(w)| \leq \frac{10}{31} \cdot M$. As $|[M] \backslash(\psi(u) \cup \psi(w))| \geq \frac{11}{31} \cdot M \geq h_{G}(v) \cdot M$, we can extend the coloring $\psi$ to $v$ and obtain an $\left(h_{G}, M\right)$-coloring of $G$. A contradiction.

We also need the following lemma on the local structures of $G$.
Lemma 3 For each $v \in V(G)$, if $d_{G}(v)=3$, then we have $e\left(N_{G}(v), N_{G}^{2}(v)\right) \geq 5$; if $d_{G}(v)=$ 4 , then we have e $\left(N_{G}(v), N_{G}^{2}(v)\right) \geq 9$.

The proof of Lemma 3 is quite involved, we postpone it until Section 3 and proceed to prove Theorem 2

Proof of Theorem [2, We will prove that $G$ has an $\left(h_{G}, M^{\prime}\right)$-coloring for some positive integer $M^{\prime}$. This will be a contradiction to the assumption of $G$. For each $v \in V(G)$, let $H_{v}$ be the proper subgraph of $G$ obtained from $G$ by deleting vertices from $N_{G}(v)$. By Remark 1 and the choice of $G$, the graph $H_{v}$ has an $\left(h_{H_{v}}, M\right)$-coloring, say $\psi_{v}$. Let $\psi$ be the union of $\psi_{v}$, where $v$ ranges over all vertices of $G$ and colors used for different $\psi_{v}$ are distinct. Let $n=|V(G)|$. We next show $\psi$ is an $\left(h_{G}, M^{\prime}\right)$-coloring, where $M^{\prime}=n M$. To show this, we have to verify $|\psi(u)| \geq M^{\prime} h_{G}(u)$ for each vertex $u$. By Lemma 2 there are two cases depending on the degree of $u$.

If $d_{G}(u)=3$, then we write $N_{G}^{2}(u)=\cup_{i=1}^{3} A_{i}$, where $w \in A_{i}$ if $w$ has $i$ neighbors in $N_{G}(u)$. We can compute the number of colors $u$ received as follows. In the graph $H_{u}$, the vertex $u$ is an isolated one and it receives $M$ colors from $\psi_{u}$. For each $v \in N_{G}(u)$, the vertex $u$ is not in the graph $H_{v}$ and does not receive any color from $\psi_{v}$. If $v \in N_{G}^{2}(u) \cap A_{1}$, then $u$ has degree two in $H_{v}$ and $u$ receives $10 M / 31$ colors from $\psi_{v}$. Similarly, for $v \in N_{G}^{2}(u) \cap A_{2}$, the coloring $\psi_{v}$ gives $u$ exactly $11 M / 31$ color as $u$ has degree one in $H_{v}$. For $v \in N_{G}^{2}(u) \cap A_{3}$, the vertex $u$ receives $M$ colors from $\psi_{v}$ as $u$ is an isolated vertex in $H_{v}$. If $v \in V(G) \backslash\left(\{u\} \cup N_{G}(u) \cup N_{G}^{2}(u)\right)$, then $u$ has degree three in $H_{v}$ and so it receives $9 M / 31$ colors from $\psi_{v}$. For $1 \leq i \leq 3$, let $a_{i}=\left|A_{i}\right|$. The number of colors for $u$ can be calculated as follows:

$$
\begin{aligned}
\left|\psi_{u}\right|= & M+a_{1} \cdot(10 M) / 31+a_{2} \cdot(11 M) / 31+a_{3} \cdot M \\
& +\left(n-4-a_{1}-a_{2}-a_{3}\right) \cdot(9 M) / 31 \\
= & \left(9 n+a_{1}+2 a_{2}+22 a_{3}-5\right) \cdot M / 31 \\
\geq & \left(9 n+a_{1}+2 a_{2}+3 a_{3}-5\right) \cdot M / 31 \\
\geq & (9 n M) / 31,
\end{aligned}
$$

in the last step, we notice $e\left(N_{G}(u), N_{G}^{2}(u)\right)=a_{1}+2 a_{2}+3 a_{3} \geq 5$ as the first part of Lemma 3.

If $d_{G}(u)=4$, then we write $N_{G}^{2}(u)=\cup_{i=1}^{4} A_{i}$, where $w \in A_{i}$ if $w$ has $i$ neighbors in $N_{G}(u)$. Let $a_{i}=\left|A_{i}\right|$ for each $1 \leq i \leq 4$. As we did in the previous case, we can estimate the size of $\psi_{u}$ as follows:

$$
\begin{aligned}
\left|\psi_{u}\right|= & M+a_{1} \cdot(9 M) / 31+a_{2} \cdot(10 M) / 31+a_{3} \cdot(11 M) / 31+a_{4} \cdot M \\
& +\left(n-5-a_{1}-a_{2}-a_{3}-a_{4}\right) \cdot(8 M) / 31 \\
= & \left(8 n+a_{1}+2 a_{2}+3 a_{3}+23 a_{4}-9\right) \cdot M / 31 \\
\geq & \left(8 n+a_{1}+2 a_{2}+3 a_{3}+4 a_{4}-9\right) \cdot M / 31 \\
\geq & (8 n M) / 31,
\end{aligned}
$$

in the last step, we note that $e\left(N_{G}(u), N_{G}^{2}(u)\right)=a_{1}+2 a_{2}+3 a_{3}+4 a_{4} \geq 9$ by the second part of Lemma 3

Therefore, $\psi$ is an $\left(h_{G}, M^{\prime}\right)$-coloring for $G$. This is a contradiction and the theorem is proved.

## 3 Proof of Lemma 3

We start with some definitions and notations. Let $G$ be a graph. A subset $S \subseteq V(G)$ is called an independent set if there are no edges with both endpoints in $S$. The contraction of $S$ is to replace vertices in $S$ by a single fat vertex, denoted by $\underline{S}$, whose incident edges are all edges that are incident with at least one vertex in $S$, except edges with both endpoints in $S$. The new graph obtained by contracting $S$ is denoted by $G / S$. This operation is also known as identifying vertices of $S$ in the literature. For convenience, if $S=\{u, v\}$, then the fat vertex will be denoted by $\underline{u v}$. We use $G-S$ to denote the subgraph of $G$ induced by $V(G)-S$. For two nonadjacent vertices $u$ and $v$, let $G+u v$ be the graph obtained from $G$ by adding an edge $u v$. The square $G^{2}$ of a graph $G$ is the graph with vertex set $V(G)$ and two vertices are adjacent in $G^{2}$ if and only if their distance in $G$ is at most 2 .

Recall that $G$ is a counterexample with the smallest number of vertices. If $H$ is a subgraph of $G$ with $|V(H)|<|V(G)|$, then $H$ has an $\left(h_{H}, M\right)$-coloring $\psi$ by the definition of $G$. For each $v \in V(G)-V(H)$, we define $L(v)=M \backslash \cup_{u \in N_{H}(v)} \psi(u)$. Since $d_{H}(v) \leq d_{G}(v)$ for any $v \in V(H)$, we get $|\psi(v)|=\left(12-d_{H}(v)\right) / 31 \cdot M \geq\left(12-d_{G}(v)\right) / 31 \cdot M$. If $\psi^{\prime}$ is an $\left(h_{G}, M\right)$ coloring of $H$ such that $\psi^{\prime}(v) \subseteq \psi(v)$ for each $v \in V(H)$, then we say $\psi^{\prime}$ is a limitation of $\psi$ on $H$. Given a limitation $\psi^{\prime}$ and a vertex $v \in V(G)-V(H)$, let $L^{\prime}(v)=M \backslash \cup_{u \in N_{H}(v)} \psi^{\prime}(u)$. Roughly speaking, if we have the partial coloring $\psi^{\prime}$ of $G$ and we wish to color $u$, then $L^{\prime}(u)$ is the set of colors which could be assigned to the vertex $u$. We also have the following simple fact which will be frequently used in our proof. Namely, we are able to prescribe a set of colors for $L^{\prime}(u)$ by defining the limitation carefully.

Fact 1 Let $S \subset V(G)$ and $H$ be the subgraph of $G$ induced by the vertex set $V(G)-S$. Suppose that $\psi$ is an $\left(h_{H}, M\right)$-coloring of $H$. For $v_{1}, v_{2} \in S$, if $A_{1}, A_{2} \subset[1, M]$ with $\left|A_{1}\right| \leq$ $M / 31$ and $\left|A_{2}\right| \leq M / 31$, then there is a limitation $\psi^{\prime}$ of $\psi$ on $H$ such that $A_{1} \subset L^{\prime}\left(v_{1}\right)$ and $A_{2} \subset L^{\prime}\left(v_{2}\right)$. Here, $A_{1}$ and $A_{2}$ are disjoint if $v_{1}$ and $v_{2}$ are adjacent.

Proof: For each $u \in H$, if $N_{G}(u) \cap\left\{v_{1}, v_{2}\right\}=\emptyset$, then to define $\psi^{\prime}(u)$, we delete colors from $\psi(u)$ arbitrarily if it is necessary. If $\left|N_{G}(u) \cap\left\{v_{1}, v_{2}\right\}\right|=1$, say $u$ is adjacent to $v_{1}$, then we note that $h_{H}(u) \geq h_{G}(v)+1 / 31$. In order to define $\psi^{\prime}(u)$, we need to delete at least $M / 31$ colors from $\psi(u)$. Therefore, we can first remove colors of $A_{1}$ from $\psi(u)$ and then delete extra colors if it is necessary. If $\left|N_{G}(u) \cap\left\{v_{1}, v_{2}\right\}\right|=2$, then we have $h_{H}(u) \geq h_{G}(u)+2 / 31$. To define $\psi^{\prime}(u)$, we remove colors of $A_{1} \cup A_{2}$ from $\psi(u)$ first and delete extra colors if it is necessary. It is easy to see that the limitation defined above is a desired one.

We remark that one of $A_{1}$ and $A_{2}$ could be the empty set when we apply Fact 1 Next, we show properties that satisfied by the minimal counterexample $G$.

Fact 2 Suppose that $G$ contains a subgraph consisting of a triangle uvw and two edges $u u^{\prime}, v v^{\prime}$. Let $\psi$ be an $\left(h_{G^{\prime}}, M\right)$-coloring of $G^{\prime}=G-\{u, v, w\}$. If $d_{G}(u)=d_{G}(v)=3$ and $\left|\psi\left(u^{\prime}\right) \backslash \psi\left(v^{\prime}\right)\right| \geq\left(8-d_{G}(w)\right) M / 31$, then any limitation of $\psi$ on $G^{\prime}$ can be extended as an $\left(h_{G}, M\right)$-coloring of $G$.

Proof: We choose $A \subset \psi\left(u^{\prime}\right) \backslash \psi\left(v^{\prime}\right)$ with $|A|=\left(8-d_{G}(w)\right) M / 31$. Let $\psi^{\prime}$ be any limitation of $\psi$ on $G^{\prime}$. Then $A \subseteq L^{\prime}(v)$. Note that $\left|L^{\prime}(w)\right| \geq M-\left(d_{G}(w)-2\right) \cdot 9 M / 31$ and $\left|L^{\prime}(w) \backslash A\right| \geq$ $\left(41-8 d_{G}(w)\right) / 31 \geq\left(12-d_{G}(w)\right) / 31$. We can first extend $\psi^{\prime}$ to $w$ such that $\psi^{\prime}(w) \cap A=\emptyset$, then extend $\psi^{\prime}$ to $v$ such that $A \subseteq \psi^{\prime}(v)$. Notice that $\left|L^{\prime}(u)\right| \geq M-\left(12-d_{G}(w)\right) M / 31-$
$9 M / 31 \times 2+\left(8-d_{G}(w)\right) M / 31=9 M / 31$. Thus we can color $u$ properly and get an $\left(h_{G}, M\right)-$ coloring of $G$, a contradiction.

Claim $1 G+u v$ contains no $C_{8}^{2}$ for any $u v \notin E(G)$.
Proof: Suppose that there exists $u v \notin E(G)$ such that $G+u v$ contains a $C_{8}^{2}$. Then $u v$ must be contained in this $C_{8}^{2}$. Assume that $V\left(C_{8}^{2}\right)=\left\{v_{1}, v_{2}, \ldots, v_{8}\right\}$, where $v_{i} v_{i+1}$ and $v_{i} v_{i+2}$ are edges for each $1 \leq i \leq 8$ while the addition is under module 8. Let $G^{\prime}$ be the graph obtained from $G-\left\{v_{1}, v_{2}, \ldots, v_{8}\right\} \backslash\{u, v\}$ by identifying $u$ and $v$. Note that $\underline{u v}$ has degree at most two in $G^{\prime}$. Therefore, $G^{\prime}$ is $K_{4}$-free and $C_{8}^{2}$-free. Thus $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$ by the definition of $G$ and the fact $\left|V\left(G^{\prime}\right)\right|<|V(G)|$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\left\{v_{1}, v_{2}, \ldots, v_{8}\right\} \backslash\{u, v\}$. Notice that $\min \left\{d_{G}(u), d_{G}(v)\right\} \geq 3$ and $d_{G^{\prime}}(\underline{u v}) \leq 2$. We can suppose that $\psi^{\prime}(u), \psi^{\prime}(v) \subseteq[1,9 M / 31]$. Without loss of generality, we assume that $u=v_{1}$. Then either $v=v_{2}$ or $v=v_{3}$ by the symmetry.

If $v=v_{2}$, then we extend $\psi^{\prime}$ as follows. Let $\psi^{\prime}\left(v_{3}\right)=[1+9 M / 31,17 M / 31], \psi^{\prime}\left(v_{4}\right)=$ $[1+17 M / 31,25 M / 31], \psi^{\prime}\left(v_{5}\right)=[1,2 M / 31] \cup[1+25 M / 31, M], \psi^{\prime}\left(v_{6}\right)=[1+3 M / 31,11 M / 31]$, $\psi^{\prime}\left(v_{7}\right)=[1+11 M / 31,19 M / 31]$, and $\psi^{\prime}\left(v_{8}\right)=[1+19 M / 31,27 M / 31]$. We obtained an $\left(h_{G}, M\right)$-coloring of $G$, which is a contradiction.

If $v=v_{3}$, then we extend $\psi^{\prime}$ as follows. Let $\psi^{\prime}\left(v_{2}\right)=[1+23 M / 31, M], \psi^{\prime}\left(v_{4}\right)=$ $[1+9 M / 31,17 M / 31], \psi^{\prime}\left(v_{5}\right)=[1+17 M / 31,25 M / 31], \psi^{\prime}\left(v_{6}\right)=[1,8 M / 31], \psi^{\prime}\left(v_{7}\right)=[1+$ $26 M / 31, M] \cup[1+9 M / 31,12 M / 31]$, and $\psi^{\prime}\left(v_{8}\right)=[1+14 M / 31,22 M / 31]$. Thus $G$ has an $\left(h_{G}, M\right)$-coloring of $G$, which is a contradiction.

Claim $2 G /\{x, y\}$ contains no $C_{8}^{2}$ for any $x y \notin E(G)$.
Proof: Suppose that $G /\{x, y\}$ contains a $C_{8}^{2}$ for some $x y \notin E(G)$. Then $x \underline{y}$ must be contained in this $C_{8}^{2}$. Assume that $V\left(C_{8}^{2}\right)=\left\{v_{1}, v_{2}, \ldots, v_{8}\right\}$, where $v_{i} v_{i+1}$ and $v_{i} v_{i+2}$ are edges for each $1 \leq i \leq 8$ while the addition is under module 8 . Without loss of generality, we suppose that $x y=v_{8}$ and $\left|N_{G}(x) \cap\left\{v_{1}, v_{2}, v_{6}, v_{7}\right\}\right| \geq\left|N_{G}(y) \cap\left\{v_{1}, v_{2}, v_{6}, v_{7}\right\}\right|$. Let $G^{\prime}=G-\left\{v_{1}, v_{2}, \ldots, v_{7}, x\right\}$. Clearly, $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$ by the definition of $G$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G^{\prime}$. As $x$ has at most two neighbors in $G^{\prime}$, it follows that $\left|L^{\prime}(x)\right| \geq M-18 M / 31=13 M / 31$. Notice that $\left|\psi^{\prime}(y)\right| \leq 9 M / 31$. Thus $\psi^{\prime}$ can be extended to $x$ satisfying $\left|\psi^{\prime}(x) \backslash \psi^{\prime}(y)\right| \geq 4 M / 31$.

For $u \in\left\{v_{1}, v_{2}, v_{6}, v_{7}\right\}$, we get $\left|L^{\prime}(u)\right| \geq M-9 M / 31=22 M / 31$ as $u$ has exactly one neighbor in $\{x, y\}$. Moreover, we may assume that either $\left|L^{\prime}\left(v_{2}\right) \backslash L^{\prime}\left(v_{6}\right)\right| \geq 4 M / 31$ or $\left|L^{\prime}\left(v_{2}\right) \backslash L^{\prime}\left(v_{7}\right)\right| \geq 4 M / 31$ because of $\left|\psi^{\prime}(x) \backslash \psi^{\prime}(y)\right| \geq 4 M / 31$.

If $\left|L^{\prime}\left(v_{2}\right) \backslash L^{\prime}\left(v_{6}\right)\right| \geq 4 M / 31$, then we choose $A \subseteq L^{\prime}\left(v_{2}\right) \backslash L^{\prime}\left(v_{6}\right)$ with $|A|=4 M / 31$ and $B \subseteq L^{\prime}\left(v_{1}\right) \backslash A$ with $|B|=5 M / 31$. To define color sets for remaining vertices, we first set $A \subset \psi^{\prime}\left(v_{2}\right), A \subset \psi^{\prime}\left(v_{5}\right), B \subset \psi^{\prime}\left(v_{1}\right)$, and $B \subset \psi^{\prime}\left(v_{4}\right)$. Then we can complete the extension of $\psi^{\prime}$ by coloring $v_{1}, v_{2}, v_{7}, v_{6}, v_{5}, v_{4}, v_{3}$ one by one greedily. When we color $v_{6}$, note that $\left|L^{\prime}\left(v_{6}\right) \backslash\left(\psi^{\prime}\left(v_{7}\right) \cup A \cup B\right)\right| \geq M-9 M / 31-8 M / 31-5 M / 31=9 M / 31$ as $A \cap L^{\prime}\left(v_{6}\right)=\emptyset$. When we color $v_{3}$, notice that $\left|\cup_{u \in N_{G}\left(v_{3}\right)} \psi^{\prime}(u)\right| \leq 4 \cdot(8 M / 31)-9 M / 31=23 M / 31$. Therefore, we can extend $\psi^{\prime}$ as an $\left(h_{G}, M\right)$-coloring of $G$. This is a contradiction.

If $\left|L^{\prime}\left(v_{2}\right) \backslash L^{\prime}\left(v_{7}\right)\right| \geq 4 M / 31$, then let $A \subseteq L^{\prime}\left(v_{2}\right) \backslash L^{\prime}\left(v_{7}\right)$ with $|A|=4 M / 31$ and $B \subseteq$ $L^{\prime}\left(v_{6}\right) \backslash A$ with $|B|=5 M / 31$. As we did in the previous case, we first set $A \subset \psi^{\prime}\left(v_{2}\right), A \subset$ $\psi^{\prime}\left(v_{5}\right), B \subset \psi^{\prime}\left(v_{3}\right)$, and $B \subset \psi^{\prime}\left(v_{6}\right)$. We are also able to color vertices $v_{1}, v_{2}, v_{3}, v_{7}, v_{6}, v_{5}, v_{4}$ one by one greedily. When we color $v_{7}$, note that $\left|L^{\prime}\left(v_{7}\right) \backslash\left(\psi\left(v_{1}\right) \cup A \cup B\right)\right| \geq M-9 M / 31-$ $8 M / 31-5 M / 31=9 M / 31$ as $A \cap L^{\prime}\left(v_{7}\right)=\emptyset$. Thus $\psi^{\prime}$ can be extended as an $\left(h_{G}, M\right)$-coloring of $G$, which is a contradiction.

Claim $3 G$ is $P_{5}^{2}$-free.


Figure 2: The related graphs in the proof of Claim 3

Proof: Suppose that $G$ contains a $P_{5}^{2}$. Let $v_{1}, v_{2}, \ldots, v_{5}$ be the vertices of this $P_{5}^{2}$. Since $G$ contains no $K_{4}$, we have $v_{1} v_{4}, v_{2} v_{5} \notin E(G)$.
Case 1: $v_{1} v_{5} \in E(G)$. Let $G^{\prime}=G-\left\{v_{1}, v_{2}, v_{3}, v_{4}, v_{5}\right\}$. Clearly, $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$ coloring $\psi$ by the definition of $G$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G^{\prime}$. Note that $\left|L^{\prime}\left(v_{i}\right)\right| \geq$ $M-9 M / 31=22 M / 31$ for $i \in\{1,2,4,5\}$. It follows that $\left|L^{\prime}\left(v_{1}\right) \cap L^{\prime}\left(v_{4}\right)\right| \geq 13 M / 31$ and $\left|L^{\prime}\left(v_{2}\right) \cap L^{\prime}\left(v_{5}\right)\right| \geq 13 M / 31$. Let $A \subseteq L^{\prime}\left(v_{1}\right) \cap L^{\prime}\left(v_{4}\right)$ with $|A|=6 M / 31$ and $B \subseteq$ $\left(L^{\prime}\left(v_{2}\right) \cap L^{\prime}\left(v_{5}\right)\right) \backslash A$ with $|B|=7 M / 31$. We set $A \subset \psi^{\prime}\left(v_{1}\right), A \subset \psi^{\prime}\left(v_{4}\right), B \subset \psi^{\prime}\left(v_{2}\right)$ and $B \subset \psi^{\prime}\left(v_{5}\right)$, which enable us to color vertices $v_{1}, v_{5}, v_{2}, v_{4}$ one by one greedily. When we color $v_{3}$, we note that $\left|\cup_{u \in N_{G}\left(v_{3}\right)} \psi(u)\right| \leq 4 \cdot(9 M / 31)-13 M / 31=23 M / 31$. Therefore, we can define $\psi^{\prime}\left(v_{3}\right)$ properly and extend $\psi^{\prime}$ as an $\left(h_{G}, M\right)$-coloring of $G$. This is a contradiction.
Case 2: $v_{1} v_{5} \notin E(G)$. In this case, we first prove that $d_{G}\left(v_{i}\right)=4$ for each $i \in\{1,2,4,5\}$ step by step. We begin to show $d_{G}\left(v_{2}\right)=d_{G}\left(v_{4}\right)=4$. If $d_{G}\left(v_{2}\right)=3$, then let $G^{\prime}=$ $G-\left\{v_{1}, v_{2}, v_{3}, v_{4}, v_{5}\right\}$. As the definition of $G$, the graph $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G^{\prime}$. Note that $\left|L^{\prime}\left(v_{1}\right)\right| \geq M-9 M / 31 \times 2=13 M / 31$, $\left|L^{\prime}\left(v_{5}\right)\right| \geq M-9 M / 31 \times 2=13 M / 31$, and $\left|L^{\prime}\left(v_{4}\right)\right| \geq M-9 M / 31=22 M / 31$. It follows that $\left|L^{\prime}\left(v_{1}\right) \cap L^{\prime}\left(v_{4}\right)\right| \geq 4 M / 31$. Let $A \subseteq L^{\prime}\left(v_{1}\right) \cap L^{\prime}\left(v_{4}\right)$ with $|A|=4 M / 31$. We first set $A \subset \psi^{\prime}\left(v_{1}\right)$ and $A \subset \psi^{\prime}\left(v_{4}\right)$. Now, we are able to color vertices $v_{5}, v_{1}, v_{4}, v_{3}$ one by one greedily. When we color $v_{2}$, we note that $\left|\cup_{u \in N_{G}\left(v_{2}\right)} \psi^{\prime}(u)\right| \leq 2 \cdot(9 M / 31)+8 M / 31-4 M / 31=22 M / 31$. Therefore, we can define $\psi^{\prime}\left(v_{2}\right)$ properly and extend $\psi^{\prime}$ as an $\left(h_{G}, M\right)$-coloring of $G$. This is a contradiction. Therefore $d_{G}\left(v_{2}\right)=4$. By the symmetry, we can show $d_{G}\left(v_{4}\right)=4$.

We next show $d_{G}\left(v_{1}\right)=d_{G}\left(v_{5}\right)=4$. If $d_{G}\left(v_{1}\right)=3$, then let $u_{1}$ be another neighbor of $v_{1}$ and $u_{2}$ be another neighbor of $v_{2}$. Let $G^{\prime}=G-\left\{v_{1}, v_{2}, v_{3}, v_{4}, v_{5}\right\}$. Then $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$ coloring $\psi$ by the definition of $G$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G^{\prime}$. If $\left|\psi^{\prime}\left(u_{1}\right) \cap \psi^{\prime}\left(u_{2}\right)\right| \geq$ $3 M / 31$, then we define $A \subseteq \psi^{\prime}\left(u_{1}\right) \cap \psi^{\prime}\left(u_{2}\right)$ with $|A|=3 M / 31$. We set $A \subset \psi^{\prime}\left(v_{3}\right)$, which allows us to color vertices $v_{5}, v_{4}, v_{3}, v_{2}, v_{1}$ one by one greedily. This is a contradiction. If $\left|\psi^{\prime}\left(u_{1}\right) \cap \psi^{\prime}\left(u_{2}\right)\right|<3 M / 31$, then there is a set $A \subseteq \psi^{\prime}\left(u_{1}\right) \backslash \psi^{\prime}\left(u_{2}\right)$ with $|A|=3 M / 31$ and a set $B \subseteq \psi^{\prime}\left(u_{2}\right) \backslash A$ with $|B|=2 M / 31$. We first set $A \subset \psi^{\prime}\left(v_{2}\right)$ and $B \subset \psi^{\prime}\left(v_{3}\right)$, then we are able to color vertices $v_{5}, v_{4}, v_{3}, v_{2}, v_{1}$ one by one greedily. This is a contradiction. Therefore, it follows that $d_{G}\left(v_{1}\right)=4$. By the symmetry of $v_{1}$ and $v_{5}$, we have $d_{G}\left(v_{5}\right)=4$. Let us proceed with the assumption $d_{G}\left(v_{i}\right)=4$ for each $i \in\{1,2,4,5\}$.

Let $G^{\prime}$ be the graph obtained from $G$ by deleting $v_{2}, v_{3}$, and $v_{5}$ followed by identifying $v_{1}$ and $v_{4}$. Similarly, let $G^{\prime \prime}$ be the graph obtained from $G$ by deleting $\left\{v_{2}, v_{3}, v_{4}\right\}$ followed by identifying $\left\{v_{1}, v_{5}\right\}$. Claim 2 implies that both $G^{\prime}$ and $G^{\prime \prime}$ are $C_{8}^{2}$-free. We further assert that one of $G^{\prime}$ and $G^{\prime \prime}$ is $K_{4}$-free. If it is not the case, then the existence of a $K_{4}$ in $G^{\prime \prime}$ implies that there is a triangle $x y z$ outside $P_{5}^{2}$ such that $v_{1} x, v_{5} y, v_{5} z \in E(G)$, see the first picture in Figure 2, Similarly, a $K_{4}$ in $G^{\prime}$ indicates that there exists a triangle $x^{\prime} y^{\prime} z^{\prime}$ outside $P_{5}^{2}$ such that $v_{1} x^{\prime}, v_{1} y^{\prime}, v_{4} z^{\prime} \in E(G)$. Since $\Delta(G) \leq 4$, we may assume that $x^{\prime}=x$. Note that $\left\{y, z, v_{1}\right\} \subseteq N_{G}(x)$ and $\left\{y^{\prime}, z^{\prime}, v_{1}\right\} \subseteq N_{G}\left(x^{\prime}\right)=N_{G}(x)$. Thus we have either $y^{\prime}=y$ or $y^{\prime}=z$, say $y^{\prime}=y$. In this case, $z^{\prime}=z$ and $v_{4} z \in E(G)$ (see the second picture in Figure 2), but now $G+v_{2} x$ contains a $C_{8}^{2}$ (see the last picture in Figure 2). This is a contradiction to

Claim 1 and the assertion follows.
If $G^{\prime}$ is $K_{4}$-free, then let $\psi$ be an $\left(h_{G^{\prime}}, M\right)$-coloring of $G^{\prime}$. We may assume that $\psi\left(v_{1}\right)=$ $\psi\left(v_{4}\right)=[1,9 M / 31]$. We will color neighbors of $v_{3}$ carefully such that each color from $[1,9 M / 31]$ appears twice in the neighbors of $v_{3}$. This will ensure that we can color $v_{3}$ properly. By Fact 1, there is a limitation $\psi^{\prime}$ of $\psi$ on $G^{\prime}$ such that $[1, M / 31] \subseteq L^{\prime}\left(v_{2}\right)$ and $[1, M / 31] \subseteq L^{\prime}\left(v_{5}\right)$. If we define $A=L^{\prime}\left(v_{5}\right) \backslash[1,9 M / 31]$, then it is true that $|A| \geq 4 M / 31$ as $\left|L^{\prime}\left(v_{5}\right)\right| \geq 13 M / 31$. To define $\psi^{\prime}\left(v_{5}\right)$, we first put $A \cup[1, M / 31] \subset \psi^{\prime}\left(v_{5}\right)$. In order to make $\left|\psi^{\prime}\left(v_{5}\right)\right|=8 M / 31$, we choose at most $3 M / 31$ colors from $[1+M / 31,9 M / 31]$ and add them to $\psi^{\prime}\left(v_{5}\right)$. To color $v_{4}$, we set $\left([1+M / 31,9 M / 31] \backslash \psi^{\prime}\left(v_{5}\right)\right) \subseteq \psi^{\prime}\left(v_{4}\right)$ and add extra colors greedily such that $[1, M / 31] \cap \psi^{\prime}\left(v_{4}\right)=\emptyset$. Define $\psi^{\prime}\left(v_{1}\right)=[1+M / 31,9 M / 31]$. Note that $\left|\psi^{\prime}\left(v_{1}\right) \cap \psi^{\prime}\left(v_{4}\right)\right| \geq 3 M / 31$. It follows that $\psi^{\prime}$ can be extended to $v_{2}$ such that $[1, M / 31] \subseteq \psi^{\prime}\left(v_{2}\right)$. Since each color in $[1,9 M / 31]$ appears twice in neighbors of $v_{3}$, then $\left|L^{\prime}\left(v_{3}\right)\right| \geq M-(4 \times 8 M / 31-9 M / 31)=8 M / 31$. Therefore, we can define $\psi^{\prime}\left(v_{3}\right)$ properly to get an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

If $G^{\prime \prime}$ is $K_{4}$-free, then we next show that $G$ has an $\left(h_{G}, M\right)$-coloring. Let $\psi$ be an $\left(h_{G^{\prime \prime}}, M\right)$-coloring of $G^{\prime \prime}$. We may assume that $[1,8 M / 31] \subseteq \psi\left(v_{1}\right)=\psi\left(v_{5}\right)$. Consequently, $[1,8 M / 31] \subseteq L\left(v_{1}\right)$ and $[1,8 M / 31] \subseteq L\left(v_{5}\right)$. Note that $\left|L\left(v_{1}\right)\right| \geq 11 M / 31$, which enables us to choose $A \subseteq L\left(v_{1}\right)$ such that $|A|=M / 31$ and $A \cap[1,8 M / 31]=\emptyset$. By Fact 1 , we can define $\psi^{\prime}$ as a limitation of $G-\left\{v_{1}, v_{2}, v_{3}, v_{4}, v_{5}\right\}$ on $\psi$ such that $A \subseteq L^{\prime}\left(v_{4}\right)$. Observe that $\left|L^{\prime}\left(v_{2}\right)\right| \geq M-9 M / 31=22 M / 31$ and $\left|L^{\prime}\left(v_{5}\right)\right| \geq M-2 \times 9 M / 31=13 M / 31$. Thus we get $\left|L^{\prime}\left(v_{2}\right) \cap L^{\prime}\left(v_{5}\right)\right| \geq 4 M / 31$. Let $B \subseteq L^{\prime}\left(v_{2}\right) \cap L^{\prime}\left(v_{5}\right)$ such that $|B|=2 M / 31$ and $A \cap B=\emptyset$. To color $v_{5}$, we first put $B$ in $\psi^{\prime}\left(v_{5}\right)$ and add extra colors from $[1,8 M / 31] \backslash B$ to $\psi^{\prime}\left(v_{5}\right)$ so that $\left|\psi^{\prime}\left(v_{5}\right)\right|=8 M / 31$. To color $v_{1}$, we put $\left(\psi^{\prime}\left(v_{5}\right) \backslash B\right) \cup A$ in $\psi^{\prime}\left(v_{1}\right)$ followed by adding extra colors to $\psi^{\prime}\left(v_{1}\right)$ so that $\left|\psi^{\prime}\left(v_{1}\right)\right|=8 M / 31$ and $\psi^{\prime}\left(v_{1}\right) \cap B=\emptyset$. Extend $\psi^{\prime}$ to $v_{2}$ such that $B \subseteq \psi^{\prime}\left(v_{2}\right)$ and $\psi^{\prime}\left(v_{2}\right) \cap A=\emptyset$. Since $B \subseteq \psi^{\prime}\left(v_{2}\right) \cap \psi^{\prime}\left(v_{5}\right)$, we can define $\psi^{\prime}\left(v_{4}\right)$ properly with $A \subseteq \psi^{\prime}\left(v_{4}\right)$. Since each color in $A \cup \psi^{\prime}\left(v_{5}\right)$ appears twice in neighbors of $v_{3}$, then $\left|L^{\prime}\left(v_{3}\right)\right| \geq M-(4 \times 8 M / 31-9 M / 31)=8 M / 31$. We can extend $\psi^{\prime}$ to $v_{3}$ to get an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

Let $F_{4}$ be a graph consisting of a triangle $u v w$ and a vertex $x$ adjacent to $u$ and $v$. We will keep the labelling of vertices of this graph in the rest of this paper.

Claim $4 G$ contains no $F_{4}$ such that $d_{G}(u)=d_{G}(v)=d_{G}(w)=3$.
Proof: Let $G^{\prime}=G-\{u, v, w, x\}$. Then $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G^{\prime}$. As $\delta(G) \geq 3$, it follows that either $\left|\psi^{\prime}(y)\right|=8 M / 31$ or $\left|\psi^{\prime}(y)\right|=9 M / 31$ for each $y \in V\left(G^{\prime}\right)$. Note that $\left|L^{\prime}(w)\right| \geq 22 M / 31$ and $\left|L^{\prime}(x)\right| \geq M-\left(d_{G}(x)-2\right) \times 9 M / 31=$ $\left(49-9 d_{G}(x)\right) M / 31$. Then $\left|L^{\prime}(w) \cap L^{\prime}(x)\right| \geq 22 M / 31+\left(49-9 d_{G}(x)\right) M / 31-M=(40-$ $\left.9 d_{G}(x)\right) M / 31 \geq\left(8-d_{G}(x)\right) M / 31$. We can first color $w$ and $x$ such that $\left|\psi^{\prime}(x) \cap \psi^{\prime}(w)\right|=$ $\left(8-d_{G}(x)\right) M / 31$. As $\left|\psi^{\prime}(x) \cup \psi^{\prime}(w)\right|=9 M / 31+\left(12-d_{G}(x)\right) M / 31-\left(8-d_{G}(x)\right) M / 31=$ $13 M / 31$, we can define the coloring of $u$ and $v$ greedily. Thus $\psi^{\prime}$ can be extended as an $\left(h_{G}, M\right)$-coloring of $G$, which is a contradiction and the claim follows.

Claim $5 G$ does not contain $F_{7}$ with $d_{G}(u)=3$ as a subgraph, where $F_{7}$ is shown in Figure 3.

Proof: Suppose that $G$ contains $F_{7}$ as a subgraph. By Claim 3, $F_{7}$ is an induced subgraph of $G$, and by Claim [ $d_{G}(a)+d_{G}(b)+d_{G}(c) \geq 3+3+4=10$. We claim that there is a set coloring $\psi^{\prime}$ of $G-\{u, v\}$ such that $\left|\psi^{\prime}(y)\right|=h_{G}(y) M$ for each $y \in V(G)-\{u, v\}$ and $\left|\psi^{\prime}(x) \cap \psi^{\prime}(w)\right| \geq 3 M / 31$.

Let $G^{\prime}=G-\{u, v, w, x\}$. As $G$ is a minimum counterexample, $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$ coloring $\psi$. For each $y \in\{a, b, c\}$, the fact $d_{G^{\prime}}(y) \leq d_{G}(y)-1$ implies that $h_{G^{\prime}}(y) \geq$ $h_{G}(y)+1 / 31$. There are two cases depending on the degree of $w$.

Case 1: $d_{G}(w)=4$. As $\{u, v, c\} \subset N_{G}(w)$, we assume that $w^{\prime}$ is another neighbor of $w$. The assumption $d_{G}(a)+d_{G}(b)+d_{G}(c) \geq 10$ implies that $d_{G^{\prime}}(a)+d_{G^{\prime}}(b)+d_{G^{\prime}}(c) \geq 7$ and $|\psi(a) \cup \psi(b) \cup \psi(c)| \leq 29 M / 31$. Let $A \subseteq M \backslash(\psi(a) \cup \psi(b) \cup \psi(c))$ with $|A|=2 M / 31$. Denote $B=A \cap \psi\left(w^{\prime}\right)$ and $C=A \backslash B$. Note that $\left|(\psi(a) \cup \psi(b)) \backslash \psi\left(w^{\prime}\right)\right| \geq 8 M / 31$.

If $|B| \leq M / 31$, then let $D \subseteq(\psi(a) \cup \psi(b)) \backslash \psi\left(w^{\prime}\right)$ such that $|D|=M / 31$. By Fact 1 we can define a limitation $\psi^{\prime}$ of $\psi$ on $G^{\prime}$ such that $B \subseteq L^{\prime}(w)$ and $D \subseteq L^{\prime}(x)$. Set $(A \cup D) \subset \psi^{\prime}(w)$ and $(A \cup D) \subset \psi^{\prime}(x)$. Then we pick extra colors greedily for $\psi^{\prime}(w)$ and $\psi^{\prime}(x)$ to satisfy $\left|\psi^{\prime}(w)\right|=M h_{G}(w)$ and $\left|\psi^{\prime}(x)\right|=M h_{G}(x)$. We note that $\left|\psi^{\prime}(x) \cap \psi^{\prime}(w)\right| \geq$ $|A|+|D|=3 M / 31$.

If $|B|>M / 31$, then let $B^{\prime} \subseteq B$ such that $\left|B^{\prime}\right|=M / 31$. If there is a vertex $y \in\{a, b\}$ such that $\left|\psi(y) \backslash \psi\left(w^{\prime}\right)\right|<M / 31$, say $y=a$ by the symmetry, then there are sets $C \subset \psi(b) \backslash \psi\left(w^{\prime}\right)$ and $D \subset \psi(c) \backslash \psi\left(w^{\prime}\right)$ with $|C|=|D|=M / 31$ as $\psi(a), \psi(b)$, and $\psi(c)$ are pairwise disjoint. To define a limitation $\psi^{\prime}$ of $\psi$ on $G^{\prime}$, we remove colors of $C$ from $\psi(b)$, colors of $D$ from $\psi(c)$, and colors of $B^{\prime}$ from $\psi\left(w^{\prime}\right)$. Thus we have $B^{\prime} \cup C \cup D \subset L^{\prime}(w)$ and $B^{\prime} \cup C \cup D \subset L^{\prime}(x)$. Set $B^{\prime} \cup C \cup D \subset \psi^{\prime}(w)$ and $B^{\prime} \cup C \cup D \subset \psi^{\prime}(x)$ in this case. If $\left|\psi(a) \backslash \psi\left(w^{\prime}\right)\right| \geq M / 31$ and $\left|\psi(b) \backslash \psi\left(w^{\prime}\right)\right| \geq M / 31$, then let $C \subset \psi(a) \backslash \psi\left(w^{\prime}\right)$ and $D \subset \psi(b) \backslash \psi\left(w^{\prime}\right)$ with $|C|=|D|=$ $M / 31$. We can define a limitation $\psi^{\prime}$ of $\psi$ on $G^{\prime}$ such that $B^{\prime} \subset L^{\prime}(w)$ by Fact Moreover, we can assume that $C \cup D \subset L^{\prime}(x)$ as we can remove colors of $C$ from $\psi(a)$ and colors of $D$ from $\psi(b)$ when we define the limitation. Similarly, set $B^{\prime} \cup C \cup D \subset \psi^{\prime}(w)$ and $B^{\prime} \cup C \cup D \subset \psi^{\prime}(x)$. Then we pick extra colors greedily for $\psi^{\prime}(w)$ and $\psi^{\prime}(x)$ to satisfy $\left|\psi^{\prime}(w)\right|=M h_{G}(w)$ and $\left|\psi^{\prime}(x)\right|=M h_{G}(x)$. We note that $\left|\psi^{\prime}(x) \cap \psi^{\prime}(w)\right| \geq\left|B^{\prime}\right|+|C|+|D|=3 M / 31$.
Case 2: $d_{G}(w)=3$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\{u, v, w, x\}$. As $\left|\psi^{\prime}(a) \cup \psi^{\prime}(b) \cup \psi^{\prime}(c)\right| \leq$ $27 M / 31$, we are able to choose $A \subseteq M \backslash\left(\psi^{\prime}(a) \cup \psi^{\prime}(b) \cup \psi^{\prime}(c)\right)$ with $|A|=3 M / 31$. Set $A \subseteq \psi^{\prime}(w)$ and $A \subseteq \psi^{\prime}(x)$. Then we pick extra colors greedily for $\psi^{\prime}(w)$ and $\psi^{\prime}(x)$ to satisfy $\left|\psi^{\prime}(w)\right|=M h_{G}(w)$ and $\left|\psi^{\prime}(x)\right|=M h_{G}(x)$. We note that $\left|\psi^{\prime}(x) \cap \psi^{\prime}(w)\right| \geq 3 M / 31$.

To finish the coloring, Claim 4 implies that $d_{G}(w)+d_{G}(v) \geq 7$. We first color $v$ greedily. Note that $\left|\psi^{\prime}(x) \cup \psi^{\prime}(v) \cup \psi^{\prime}(w)\right| \leq 2 \cdot 8 M / 31+9 M / 31-3 M / 31=22 M / 31$ in each case. Thus we can color $u$ properly and get an $\left(h_{G}, M\right)$-coloring of $G$, which is a contradiction.

Claim $6 G$ contains no $F_{4}$ such that $d_{G}(u)=3$.
Proof: Suppose that $G$ contains an $F_{4}$ such that $d_{G}(u)=3$. Let $G^{\prime}$ be the graph obtained from $G-\{u, v\}$ by identifying $w$ and $x$. Claim 2 tells us that $G^{\prime}$ contains no $C_{8}^{2}$. If $G^{\prime}$ contains a $K_{4}$, then $G$ contains an $F_{7}$, which is a contradiction to Claim 5. Therefore, $G^{\prime}$ is $K_{4}$-free and $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Note that $\psi(w)=\psi(x)$. We can extend $\psi$ as an ( $h_{G}, M$ )-coloring of $G$ by coloring $v$ and $u$ greedily, which is a contradiction.

Let $F_{5}$ be a graph consisting of an edge $u v$ and three common neighbors $a, b$, and $c$.
Claim $7 G$ contains no $F_{5}$.

Proof: Suppose that $G$ contains an $F_{5}$. As $G$ is $K_{4}$-free, we get that $\{a, b, c\}$ is an independent set. There are three cases depending on the number of three vertices from $\{a, b, c\}$.
Case 1: There are two vertices from $\{a, b, c\}$ having degree three. We can assume that $d_{G}(a)=d_{G}(b)=3$ and $3 \leq d_{G}(c) \leq 4$. Let $G^{\prime}=G-\{u, v, a, b, c\}$. Then $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)-$ coloring $\psi$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\{u, v, a, b, c\}$. Note that $\left|L^{\prime}(a)\right| \geq 22 M / 31$, $\left|L^{\prime}(b)\right| \geq 22 M / 31$, and $\left|L^{\prime}(c)\right| \geq 13 M / 31$. Thus $\left|L^{\prime}(a) \cap L^{\prime}(b)\right| \geq 13 M / 31,\left|L^{\prime}(a) \cap L^{\prime}(c)\right| \geq$ $4 M / 31$, and $\left|L^{\prime}(b) \cap L^{\prime}(c)\right| \geq 4 M / 31$. Let $A \subseteq L^{\prime}(a) \cap L^{\prime}(c)$ with $|A|=4 M / 31$ and $B \subseteq$ $L^{\prime}(b) \cap L^{\prime}(c)$ such that $|B|=4 M / 31$. Moreover, we choose $C \subseteq L(a) \cap L(b)$ such that $|C|=5 M / 31$ and $C \cap(A \cup B)=\emptyset$. Set $A \cup C \subset \psi^{\prime}(a), B \cup C \subset \psi^{\prime}(b)$, and $A \cup B \subset \psi^{\prime}(c)$. Then $\psi^{\prime}$ can be extended as an $\left(h_{G}, M\right)$-coloring of $G$ by choosing colors for $a, b, c, u, v$ one by one greedily, which is a contradiction.
Case 2: There is exactly one vertex of $\{a, b, c\}$ with degree three. Then we assume that $d_{G}(a)=3$ and $d_{G}(b)=d_{G}(c)=4$. Let $G^{\prime}$ (and $G^{\prime \prime}$ ) be the graph obtained from $G-\{u, v, c\}$ (and $\{u, v, b\}$ ) by identifying $a$ and $b$ (by identifying $a$ and $c$ ) respectively. Note that both $G^{\prime}$ and $G^{\prime \prime}$ are $C_{8}^{2}$-free by Claim 2 There are two subcases.
Subcase 2.1: One of $G^{\prime}$ and $G^{\prime \prime}$ is $K_{4}$-free. By the symmetry, we can assume that $G^{\prime}$ is $K_{4}$-free. Thus $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Note that $a b$ is a 3 -vertex of $G^{\prime}$. Then we may assume that $\psi(\underline{a b})=[1,9 M / 31]$. Let $A=[1, M / 31]$. By Fact 1 , we can let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\{u, v, a, b, c\}$ such that $A \subseteq L^{\prime}(c)$. Note that $[1,9 M / 31] \subseteq L^{\prime}(a) \cap L^{\prime}(b)$, $\left|L^{\prime}(a)\right| \geq 22 M / 31$, and $\left|L^{\prime}(c)\right| \geq 13 M / 31$. It follows that $\left|L^{\prime}(a) \cap L^{\prime}(c)\right| \geq 4 M / 31$. Choose $B \subset L^{\prime}(a) \cap L^{\prime}(c)$ such that $|B|=M / 31$ and $A \cap B=\emptyset$. Define $\psi^{\prime}(b)=[1,8 M / 31]$. We put $[1,8 M / 31] \cup B \subseteq \psi^{\prime}(a)$ and $A \cup B \subseteq \psi^{\prime}(c)$ followed by adding extra colors to $\psi^{\prime}(a)$ and $\psi^{\prime}(c)$ greedily. We can construct an $\left(h_{G}, M\right)$-coloring of $G$ by choosing colors for $u$ and $v$ properly. A contradiction.

Subcase 2.2: Both $G^{\prime}$ and $G^{\prime \prime}$ contain a $K_{4}$. In this case, by the symmetry, there are vertices $x, y$, and $z$ outside $F_{5}$ such that $\{x y, x z, y z, a x, y b, y c, z b, z c\} \subset E(G)$. Since $\Delta(G) \leq 4$ and $G$ is 2 -connected, we have $G$ is the graph $F_{8}$ as shown in Figure 4. It is easy to see that $G$ has an $\left(h_{G}, 31\right)$-coloring. A contradiction.

Case 3: $d_{G}(a)=d_{G}(b)=d_{G}(c)=4$. Let $G^{\prime}$ be the graph obtained from $G$ by deleting vertices from $\{u, v, c\}$ followed by identifying vertices from $\{a, b\}$. Similarly, let $G^{\prime \prime}$ (and $G^{\prime \prime \prime}$ ) be the graph obtained from $G$ by deleting vertices from $\{u, v, b\}$ (and $\{u, v, a\}$ ) followed by identifying vertices from $\{a, c\}$ (and vertices from $\{b, c\}$ ) respectively. Note that Claim 2 implies that all of them are $C_{8}^{2}$-free. We proceed to complete the proof with the assumption that one of $G^{\prime}, G^{\prime \prime}$, and $G^{\prime \prime \prime}$ is $K_{4}$-free. By the symmetry, we suppose that $G^{\prime}$ is $K_{4}$-free. Let $\psi$ be an $\left(h_{G^{\prime}}, M\right)$-coloring of $G^{\prime}$. We assume that $\psi^{\prime}(a)=\psi^{\prime}(b)=[1,8 M / 31]$ and fix $C \subset[1,8 M / 31]$ with $|C|=M / 31$. By Fact 1 , we can let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\{u, v, a, b, c\}$ such that $C \subseteq L^{\prime}(c)$. Set $C \subset \psi^{\prime}(c)$ and add extra colors greedily. Now,
$\left|\psi^{\prime}(a) \cup \psi^{\prime}(b) \cup \psi^{\prime}(c)\right| \leq 8 M / 31+7 M / 31=15 M / 31$ and we can choose colors for $u$ and $v$ greedily to get an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

It remains to show the assertion that one of $G^{\prime}, G^{\prime \prime}$, and $G^{\prime \prime \prime}$ is $K_{4}$-free. If $G^{\prime}$ contains a $K_{4}$, then there is a triangle with vertex set $\{x, y, z\}$ outside $F_{5}$. By the symmetry, we can assume that $\{a x, b y, b z\} \subset E(G)$. Since $G[\{a, b, x, y, z\}]$ is not a $P_{5}^{2}$ by Claim 33 we have $a y, a z \notin E(G)$. If $c x \in E(G)$, then $G^{\prime \prime}$ is $K_{4}$-free as $G$ is $P_{5}^{2}$-free. Now we assume that $c x \notin E(G)$. The existence of a $K_{4}$ in $G^{\prime \prime \prime}$ implies that there exists $x^{\prime}$ such that $c x^{\prime}, x^{\prime} y, x^{\prime} z \in$ $E(G)$. Now we can observe that $G^{\prime \prime}$ is $K_{4}$-free. The assertion is proved and the claim follows.

Claim $8 G$ contains no triangle uvw such that $d_{G}(u)=d_{G}(v)=d_{G}(w)=3$.
Proof: Suppose that $G$ contains a triangle $u v w$ with $d_{G}(u)=d_{G}(v)=d_{G}(w)=3$. Let $u^{\prime}, v^{\prime}$, and $w^{\prime}$ be the neighbors of $u, v, w$ which is not on the triangle, respectively. Claim 6 implies that $u^{\prime}, v^{\prime}$, and $w^{\prime}$ are distinct. Let $G^{\prime}=G-\{u, v, w\}$. By Claim 11 $G^{\prime}+u^{\prime} v^{\prime}$, $G^{\prime}+u^{\prime} w^{\prime}$, and $G^{\prime}+v^{\prime} w^{\prime}$ are $C_{8}^{2}$-free. We claim that either $G^{\prime}+u^{\prime} v^{\prime}$, or $G^{\prime}+u^{\prime} w^{\prime}$, or $G^{\prime}+v^{\prime} w^{\prime}$ is $K_{4}$-free. Otherwise, either $G$ contains a $K_{4}$, or there exists $x y \in E\left(G^{\prime}\right)$ such that $\{x, y\}$ together with each of $u^{\prime}, v^{\prime}$, and $w^{\prime}$ form a triangle, which is a contradiction to Claim 7 .

Assume by the symmetry that $G^{\prime}+u^{\prime} v^{\prime}$ is $K_{4}$-free. As the definition of $G$, the graph $G^{\prime}+u^{\prime} v^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Since $\psi\left(u^{\prime}\right) \cap \psi\left(v^{\prime}\right)=\emptyset$, any limitation $\psi^{\prime}$ of $\psi$ on $G^{\prime}$ can be extended as an $\left(h_{G}, M\right)$-coloring of $G$ by Fact 2, a contradiction.

Claim $9 G$ contains no path $u_{1} u_{2} u_{3}$ such that $d_{G}\left(u_{1}\right)=d_{G}\left(u_{2}\right)=d_{G}\left(u_{3}\right)=3$.
Proof: Suppose that $G$ contains a path $u_{1} u_{2} u_{3}$ such that $d_{G}\left(u_{1}\right)=d_{G}\left(u_{2}\right)=d_{G}\left(u_{3}\right)=3$. By Claim 8, we have $u_{1} u_{3} \notin E(G)$. For $i \in\{1,3\}$, we assume that $u_{i}^{\prime}$ and $u_{i}^{\prime \prime}$ are the other two neighbors of $u_{i}$.

If $d_{G}\left(u_{1}^{\prime}\right)+d_{G}\left(u_{1}^{\prime \prime}\right)=d_{G}\left(u_{3}^{\prime}\right)+d_{G}\left(u_{3}^{\prime \prime}\right)=6$, then let $G^{\prime}$ be the graph obtained from $G$ by deleting $u_{2}$ followed by identifying $u_{1}$ and $u_{3}$. As $d_{G}\left(u_{1}^{\prime}\right)+d_{G}\left(u_{1}^{\prime \prime}\right)=d_{G}\left(u_{3}^{\prime}\right)+d_{G}\left(u_{3}^{\prime \prime}\right)=6$ and Claim8, the graph $G^{\prime}$ is $K_{4}$-free. Claim 2implies that $G^{\prime}$ is also $C_{8}^{2}$-free. Thus $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. We can easily extend $\psi$ as an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

If either $d_{G}\left(u_{1}^{\prime}\right)+d_{G}\left(u_{1}^{\prime \prime}\right) \geq 7$ or $d_{G}\left(u_{3}^{\prime}\right)+d_{G}\left(u_{3}^{\prime \prime}\right) \geq 7$, then by the symmetry, we assume that $d_{G}\left(u_{1}^{\prime}\right)+d_{G}\left(u_{1}^{\prime \prime}\right) \geq 7$. Let $G^{\prime}=G-\left\{u_{1}, u_{2}, u_{3}\right\}$. Then $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$ and let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\left\{u_{1}, u_{2}, u_{3}\right\}$. Note that $\left|L^{\prime}\left(u_{1}\right)\right| \geq 14 M / 31,\left|L^{\prime}\left(u_{2}\right)\right| \geq$ $22 M / 31$, and $\left|L^{\prime}\left(u_{3}\right)\right| \geq 13 M / 31$, here we applied the assumption $d_{G}\left(u_{1}^{\prime}\right)+d_{G}\left(u_{1}^{\prime \prime}\right) \geq 7$. Let $A \subseteq L^{\prime}\left(u_{2}\right) \backslash L^{\prime}\left(u_{3}\right)$ such that $|A|=5 M / 31$. We first extend $\psi^{\prime}$ to $u_{1}$ such that $\psi^{\prime}\left(u_{1}\right) \cap A=\emptyset$ followed by extending $\psi^{\prime}$ to $u_{2}$ such that $A \subseteq \psi^{\prime}\left(u_{2}\right)$. Since $\left|L^{\prime}\left(u_{3}\right) \backslash \psi^{\prime}\left(u_{2}\right)\right| \geq 9 M / 31$, we can extend $\psi^{\prime}$ to $u_{3}$ and get an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

Claim $10 G$ contains no triangle uvw such that $d_{G}(u)=d_{G}(v)=3$.
Proof: Suppose that $G$ contains a triangle $u v w$ such that $d_{G}(u)=d_{G}(v)=3$. Then $d_{G}(w)=4$ by Claim 8. Let $u^{\prime}$ and $v^{\prime}$ be the neighbors of $u$ and $v$ not on the triangle, respectively. Claim 6 gives us that $u^{\prime} \neq v^{\prime}$, and $w u^{\prime}, w v^{\prime} \notin E(G)$. Claim 9 implies that $d_{G}\left(u^{\prime}\right)=d_{G}\left(v^{\prime}\right)=4$.

If $u^{\prime} v^{\prime} \in E(G)$, then let $G^{\prime}=G-\{u, v\}$. Clearly, $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$, where $\psi\left(u^{\prime}\right) \cap \psi\left(v^{\prime}\right)=\emptyset$. Thus a limitation of $\psi$ on $G^{\prime}$ can be extended as an $\left(h_{G}, M\right)$-coloring of $G$ by Fact 2 a contradiction. We need only to consider the case where $u^{\prime} v^{\prime} \notin E(G)$. Let $G^{\prime}=G-\{u, v\}+u^{\prime} v^{\prime}$. By Claim 1. $G^{\prime}$ is $C_{8}^{2}$-free. If $G^{\prime}$ is also $K_{4}$-free, then $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Since $\psi\left(u^{\prime}\right) \cap \psi\left(v^{\prime}\right)=\emptyset$, a limitation of $\psi$ on $G^{\prime}$ can be extended as an $\left(h_{G}, M\right)$-coloring of $G$ by Fact 2, a contradiction. Therefore, $G^{\prime}$ contains a $K_{4}$, which implies that there exist $x y \in E(G)$ such that $u^{\prime} x, u^{\prime} y, v^{\prime} x, v^{\prime} y \in E(G)$. If $u^{\prime} w \in E\left(G^{\prime}\right)$, then
$G$ contains $F_{7}$ as a subgraph, which is a contradiction to Claim 5. Thus $u^{\prime} w \notin E\left(G^{\prime}\right)$. By the symmetry, we also have $v^{\prime} w \notin E\left(G^{\prime}\right)$.

We first assume that $w x \in E(G)$. Claim 7 gives that $w y \notin E(G)$. Let $w^{\prime}$ be the other neighbor of $w$. Without raising any confusion, we define $G^{\prime}=G-\{u, v, w\}+v^{\prime} w^{\prime}$. By Claim $1 G^{\prime}$ is $C_{8}^{2}$-free. Note that $G^{\prime}$ is also $K_{4}$-free by checking degrees of neighbors of $v^{\prime}$. Thus $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\{u, v, w\}$. If $\left|\psi^{\prime}\left(u^{\prime}\right) \backslash \psi^{\prime}\left(v^{\prime}\right)\right| \geq 4 M / 31$, then $\psi^{\prime}$ can be extended as an $\left(h_{G}, M\right)$-coloring of $G$ by Fact 2, a contradiction. Therefore $\left|\psi^{\prime}\left(u^{\prime}\right) \backslash \psi^{\prime}\left(v^{\prime}\right)\right|<4 M / 31$, which implies $\left|\psi^{\prime}\left(u^{\prime}\right) \cap \psi^{\prime}\left(v^{\prime}\right)\right|>4 M / 31$. Let $B=\psi^{\prime}\left(u^{\prime}\right) \cap \psi^{\prime}\left(v^{\prime}\right)$ with $|B|=4 M / 31$. We first put $B \subset \psi^{\prime}(w)$ and add extra colors greedily to ensure $\left|\psi^{\prime}(w)\right|=8 M / 31$. This is possible because $u^{\prime} x \in E(G)$ and $w^{\prime} v^{\prime} \in E\left(G^{\prime}\right)$. Then we can define $\psi^{\prime}(u)$ and $\psi^{\prime}(v)$ one by one greedily. In this case, we can construct an $\left(h_{G}, M\right)$-coloring of $G$, which is a contradiction.

Now we can assume that $w x \notin E(G)$. By the symmetry, we have $w y \notin E(G)$. Let $w_{1}$ and $w_{2}$ be the neighbors of $w$ not on the triangle. Define $G^{\prime}=G-\{u, v, w\}+w_{1} u^{\prime}+w_{2} v^{\prime}$. We first claim that $G^{\prime}$ is $K_{4}$-free. Otherwise, this $K_{4}$ must contain exactly one of the edges $\left\{w_{1} u^{\prime}, w_{2} v^{\prime}\right\}$ as $u^{\prime} v^{\prime} \notin E(G)$. We can assume that $K_{4}$ contains the edge $w_{1} u^{\prime}$. As $\Delta(G) \leq 4$, the only possibility for the vertex set of this $K_{4}$ is $\left\{w_{1}, u^{\prime}, x, y\right\}$. Now $x$ and $y$ have three common neighbors $u^{\prime}, v^{\prime}$ and $w_{1}$, which is a contradiction to Claim 7

If $G^{\prime}$ contains no $C_{8}^{2}$, then $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\{u, v, w\}$. If $\left|\psi^{\prime}\left(v^{\prime}\right) \cap \psi^{\prime}\left(u^{\prime}\right)\right| \geq 3 M / 31$, then let $A \subset \psi^{\prime}\left(v^{\prime}\right) \cap \psi^{\prime}\left(u^{\prime}\right)$ with $|A|=3 M / 31$. This is possible as $w_{1} u^{\prime}, w_{2} v^{\prime} \in E\left(G^{\prime}\right)$. We put $A$ in $\psi^{\prime}(w)$ and add extra colors to $\psi^{\prime}(w)$ such that $\left|\psi^{\prime}(w)\right|=8 M / 31$. Then $\psi^{\prime}$ can be extended as an $\left(h_{G}, M\right)$-coloring of $G$ by defining $\psi^{\prime}(u)$ and $\psi^{\prime}(v)$ one by one greedily. If $\left|\psi^{\prime}\left(v^{\prime}\right) \cap \psi^{\prime}\left(u^{\prime}\right)\right|<3 M / 31$, then $\left|\psi^{\prime}\left(v^{\prime}\right) \backslash \psi^{\prime}\left(u^{\prime}\right)\right|>$ $5 M / 31$. By Fact $2 \psi^{\prime}$ can be extended to get an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

Now we assume that $G^{\prime}$ contains a $C_{8}^{2}$. By Claim 1, this $C_{8}^{2}$ must contain edges $w_{1} u^{\prime}$ and $w_{2} v^{\prime}$. We assume that $N_{G}\left(u^{\prime}\right)=\left\{a, w_{1}, x, y\right\}$ and $N_{G}\left(v^{\prime}\right)=\left\{b, w_{2}, x, y\right\}$. The fact that all vertices in $G^{\prime}$ have degree at most four implies that $G^{\prime}$ is the whole graph $C_{8}^{2}$. Since $G\left[\left\{a, u^{\prime}, v^{\prime}, x, y\right\}\right]$ contains no $P_{5}^{2}$ as a subgraph by Claim 3, it follows that ax, ay $\notin E(G)$. Then we get $a w_{1}, a w_{2}, a b \in E(G)$. By the symmetry of $a$ and $b$, we have $b w_{1}, b w_{2} \in E(G)$. Therefore, $G$ must be the graph $F_{11}$ as shown in Figure 5. However, $F_{11}$ has an $\left(h_{F_{11}}, 31\right)$ coloring as shown by Figure 5, a contradiction.

The proof of the claim is complete.


Figure 5: The graph $F_{11}$ and an $\left(h_{F_{11}}, 31\right)$-coloring of $F_{11}$

Claim $11 G$ contains no path $u_{1} u_{2} u_{3} u_{4}$ such that $d_{G}\left(u_{1}\right)=d_{G}\left(u_{2}\right)=d_{G}\left(u_{4}\right)=3$.
Proof: Suppose that $G$ contains a path $u_{1} u_{2} u_{3} u_{4}$ such that $d_{G}\left(u_{1}\right)=d_{G}\left(u_{2}\right)=d_{G}\left(u_{4}\right)=3$. Claim 10 implies that $u_{1} u_{2} u_{3} u_{4}$ is an induced path. By Claim $9 d_{G}\left(u_{3}\right)=4$ while other neighbors of $u_{1}$ and $u_{2}$ not in this path are 4 -vertices.

Let $G^{\prime}=G-\left\{u_{1}, u_{2}\right\}$. Clearly, $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Suppose that $\psi^{\prime}$ is a limitation of $\psi$ on $G-\left\{u_{1}, u_{2}, u_{3}, u_{4}\right\}$. Note that $\left|L^{\prime}\left(u_{1}\right)\right|=15 M / 31,\left|L^{\prime}\left(u_{2}\right)\right|=23 M / 31$, $\left|L^{\prime}\left(u_{3}\right)\right| \geq 13 M / 31$, and $\left|L^{\prime}\left(u_{4}\right)\right| \geq 13 M / 31$. Moreover, $\left|L^{\prime}\left(u_{3}\right) \cup L^{\prime}\left(u_{4}\right)\right| \geq 17 M / 31$ as it contains $\psi\left(u_{3}\right) \cup \psi\left(u_{4}\right)$ as a subset. By deleting colors not in $\psi\left(u_{3}\right) \cup \psi\left(u_{4}\right)$ if it necessary, we may assume that $\left|L^{\prime}\left(u_{3}\right)\right|=\left|L^{\prime}\left(u_{4}\right)\right|=13 M / 31$. Then $\left|L^{\prime}\left(u_{3}\right) \backslash L^{\prime}\left(u_{4}\right)\right| \geq 4 M / 31$ because of $\left|L^{\prime}\left(u_{3}\right) \cup L^{\prime}\left(u_{4}\right)\right| \geq 17 M / 31$. Let $A \subseteq L^{\prime}\left(u_{3}\right) \backslash L^{\prime}\left(u_{4}\right)$ and $B \subseteq L^{\prime}\left(u_{2}\right) \backslash L^{\prime}\left(u_{1}\right)$ such that $|A|=4 M / 31,|B|=3 M / 31$, and $A \cap B=\emptyset$. Put $A \subset \psi^{\prime}\left(u_{3}\right)$ and $B \subset \psi^{\prime}\left(u_{2}\right)$. Choosing extra colors for $u_{3}, u_{2}, u_{1}$ and $u_{4}$ one by one greedily, we obtain an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

Claim $12 G$ contains no $F_{4}$ such that $d_{G}(w)=d_{G}(x)=3$.
Proof: Suppose that $G$ contains an $F_{4}$ such that $d_{G}(w)=d_{G}(x)=3$. Claim 10 indicates that $d_{G}(u)=d_{G}(v)=4$. For each $z \in\{u, v, w, x\}$, let $z^{\prime}$ be the neighbor of $z$ which is not in $F_{4}$. Claim 11 implies that $d_{G}\left(w^{\prime}\right)=d_{G}\left(x^{\prime}\right)=4$. Moreover, $u^{\prime}, v^{\prime}$, and $w^{\prime}$ are all distinct by Claim 3 and Claim 7 Similarly, $u^{\prime}, v^{\prime}$, and $x^{\prime}$ are distinct. Let $G^{\prime}=G-\{u, v, w, x\}$. Then $G^{\prime}$ is $C_{8}^{2}$-free and $K_{4}$-free. Thus $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. There are two cases depending on the size of $\psi\left(w^{\prime}\right) \cap \psi\left(x^{\prime}\right)$.
Case 1: $\left|\psi\left(w^{\prime}\right) \cap \psi\left(x^{\prime}\right)\right| \geq 2 M / 31$. Let $A \subseteq\left(\psi\left(w^{\prime}\right) \cap \psi\left(x^{\prime}\right)\right)$ and $B \subseteq\left(\psi\left(w^{\prime}\right) \cap \psi\left(x^{\prime}\right)\right)$ such that $A \cap B=\emptyset$ and $|A|=|B|=M / 31$. By Fact 1 , there exists a limitation $\psi^{\prime}$ of $\psi$ on $G-\{u, v, w, x\}$ such that $A \subseteq L^{\prime}(u)$ and $B \subseteq L^{\prime}(v)$. Therefore, it is proper to put $A$ in $\psi^{\prime}(u)$ and $B$ in $\psi^{\prime}(v)$. We add extra colors to $\psi^{\prime}(u)$ and $\psi^{\prime}(v)$ such that $\left|\psi^{\prime}(u)\right|=\left|\psi^{\prime}(v)\right|=8 M / 31$. Then $\psi^{\prime}$ can be extended as an $\left(h_{G}, M\right)$-coloring of $G$ by picking colors for $\psi^{\prime}(w)$ and $\psi^{\prime}(x)$ one by one greedily. Thus we get an $\left(h_{G}, M\right)$-coloring of $G$, which is a contradiction.
Case 2: $\left|\psi\left(w^{\prime}\right) \cap \psi\left(x^{\prime}\right)\right|<2 M / 31$. We have $w^{\prime} \neq x^{\prime}$ in this case. Note that $\left|\psi\left(w^{\prime}\right) \cup \psi\left(x^{\prime}\right)\right|>$ $16 M / 31$ and $|L(u)| \geq 21 M / 31$. It follows that $\left|L(u) \cap\left(\psi\left(w^{\prime}\right) \cup \psi\left(x^{\prime}\right)\right)\right|>6 M / 31$. By the symmetry, we may assume that $\left|L(u) \cap \psi\left(w^{\prime}\right)\right|>3 M / 31$. Let $A \subset \psi\left(x^{\prime}\right)$ and $B \subset \psi\left(x^{\prime}\right)$ such that $A \cap B=\emptyset$ and $|A|=|B|=M / 31$. Additionally, we choose $C \subset L(u) \cap \psi\left(w^{\prime}\right)$ with $|C|=3 M / 31$. Fact 1 gives a limitation $\psi^{\prime}$ of $\psi$ on $G-\{u, v, w, x\}$ with the property $A \subset L^{\prime}(u)$ and $B \subset L^{\prime}(v)$. Furthermore, we have $C \subset L^{\prime}(u) \cap \psi^{\prime}\left(w^{\prime}\right)$ by deleting colors from $\psi\left(w^{\prime}\right)$ properly. To color $u$ and $v$, we put $A \cup C$ in $\psi^{\prime}(u)$ and $B$ in $\psi^{\prime}(v)$ followed by adding extra colors greedily. As the selection of sets $A, B$, and $C$, we are able to color $x$ and $w$ one by one, and we obtained an $\left(h_{G}, M\right)$-coloring of $G$. A contradiction.

Claim $13 G$ contains no $F_{4}$ such that $d_{G}(x)=3$.
Proof: Suppose that $G$ contains an $F_{4}$ such that $d_{G}(x)=3$. Claim 10 and Claim 12 yield that $d_{G}(u)=d_{G}(v)=d_{G}(w)=4$. For each $y \in\{u, v, x\}$, let $y^{\prime}$ be another neighbor of $y$ not in $F_{4}$. By Claim 3 and Claim $7 u^{\prime}, v^{\prime}$, and $x^{\prime}$ are distinct. Similarly, if $w^{\prime}$ and $w^{\prime \prime}$ are neighbors of $w$ not in $F_{4}$, then $u^{\prime}, v^{\prime}, w^{\prime}$, and $w^{\prime \prime}$ are distinct.

It is easy to see that either $G-\{u, v, w, x\}+u^{\prime} x^{\prime}$ or $G-\{u, v, w, x\}+v^{\prime} x^{\prime}$ is $K_{4}$-free. Assume that $G^{\prime}=G-\{u, v, w, x\}+u^{\prime} x^{\prime}$ is $K_{4}$-free. Claim 1 implies that $G^{\prime}$ is also $C_{8}^{2}$-free. Thus $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Let $A \subseteq \psi\left(u^{\prime}\right)$ and $B \subseteq \psi\left(u^{\prime}\right)$ such that $A \cap B=\emptyset$ and $|A|=|B|=M / 31$, and let $C \subseteq \psi\left(x^{\prime}\right)$ with $|C|=3 M / 31$. Note that $A, B$, and $C$ are pairwise disjoint. By Fact we may assume that $\psi^{\prime}$ is a limitation of $\psi$ on $G-\{u, v, w, x\}$ such that $A \subseteq L^{\prime}(w)$ and $B \subseteq L^{\prime}(v)$. Put $A$ in $\psi^{\prime}(w), B$ in $\psi^{\prime}(v)$, and $C$ in $\psi^{\prime}(u)$. Choosing extra colors for $w, v, u$ and $x$ one by one greedily, we obtain an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

Claim $14 G$ contains no triangle uvw such that $d_{G}(u)=3$.
Proof: Suppose that $G$ contains a triangle uvw such that $d_{G}(u)=3$. By Claim 10 we have $d_{G}(v)=d_{G}(w)=4$. Let $x$ be the neighbor of $u$ not on the triangle. Claim 6 implies that
$v x, w x \notin E(G)$. Suppose that $N_{G}(w)=\left\{u, v, w_{1}, w_{2}\right\}$ and $N_{G}(v)=\left\{u, w, v_{1}, v_{2}\right\}$. By Claim 13. vertices $v_{1}, v_{2}, w_{1}$ and $w_{2}$ are all distinct.

Case 1: $d_{G}(x)=3$. Claim 11 implies that $d_{G}\left(v_{1}\right)=d_{G}\left(v_{2}\right)=d_{G}\left(w_{1}\right)=d_{G}\left(w_{2}\right)=4$. Denote $N_{G}(x)=\{u, y, z\}$ and $G^{\prime}=G-\{v, w, u, x\}$. Then $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. If $|L(w) \cap L(x)| \geq 2 M / 31$, then we choose $A \subseteq L(w) \cap L(x)$ such that $|A|=2 M / 31$. Let $B \subseteq L(x) \backslash A$ such that $|B|=M / 31$ as well as $C \subset \psi\left(w_{1}\right) \cup \psi\left(w_{2}\right)$ such that $|C|=M / 31$ and $C \cap A=C \cap B=\emptyset$. By Fact 1, there is a limitation $\psi^{\prime}$ of $\psi$ on $G^{\prime}$ such that $B \subset L^{\prime}(w)$ and $C \subset L^{\prime}(v)$. We set $C \subset \psi^{\prime}(v), A \cup B \subset \psi^{\prime}(w)$, and $A \cup B \subset \psi^{\prime}(x)$. Then we add colors to $\psi^{\prime}(v), \psi^{\prime}(w)$, and $\psi^{\prime}(x)$ one by one greedily. Now we can define $\psi^{\prime}(u)$ properly because each color in $A \cup B$ appears at least twice in neighbors of $u$. A contradiction.

Let us assume that $|L(w) \cap L(x)|<2 M / 31$. Note that $|L(w)| \geq 13 M / 31$ and $|L(x)| \geq$ $13 M / 31$. We assert that $y, z, w_{1}$, and $w_{2}$ are distinct. Otherwise, suppose that $y=w_{1}$. Then $L(w) \cup L(x) \subset M \backslash \psi\left(w_{1}\right)$ and $|L(w) \cup L(x)| \leq 22 M / 31$. This implies that $|L(w) \cap L(x)| \geq$ $2 M / 31$, which is a contradiction and the assertion follows. Since $\psi(y) \cup \psi(z) \cup L(x)=M$, we get $|L(w) \cap(\psi(y) \cup \psi(z))|>11 M / 31$. This implies that there are $A_{1} \subseteq L(w) \cap \psi(y)$ and $A_{2} \subseteq L(w) \cap \psi(z)$ such that $\left|A_{1}\right|=\left|A_{2}\right|=M / 31$ and $A_{1} \cap A_{2}=\emptyset$. We fix $B \subseteq L(x)$ such that $|B|=M / 31$ and $B \cap\left(A_{1} \cup A_{2}\right)=\emptyset$. In addition, we choose $C \subset \psi\left(w_{1}\right) \cup \psi\left(w_{2}\right)$ such that $|C|=M / 31$ and $C \cap\left(A_{1} \cup A_{2} \cup B\right)=\emptyset$. By Fact 1, there is a limitation $\psi^{\prime}$ of $\psi$ on $G^{\prime}$ such that $B \subset L^{\prime}(w)$ and $C \subset L^{\prime}(v)$. Deleting colors of $A_{1}$ first for $\psi^{\prime}(y)$ and colors of $A_{2}$ first for $\psi^{\prime}(z)$, we can assume further $A_{1} \cup A_{2} \subset L^{\prime}(x)$. We put $A_{1} \cup A_{2} \cup B \subset \psi^{\prime}(x)$, $A_{1} \cup A_{2} \cup B \subset \psi^{\prime}(w)$, and $C \subset \psi^{\prime}(v)$ followed by adding colors to $\psi^{\prime}(v), \psi^{\prime}(w)$, and $\psi^{\prime}(x)$ one by one greedily. As the choices of $A_{1}, A_{2}$, and $B$, we can color $u$ properly to get an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.
Case 2: $d_{G}(x)=4$. If each vertex from $\left\{v_{1}, v_{2}, w_{1}, w_{2}\right\}$ have degree four, then let $G^{\prime}=G-$ $\{u, v, w\}$. Suppose that $\psi$ is an $\left(h_{G^{\prime}}, M\right)$-coloring of $G^{\prime}$. If $\left|\psi(x) \cap\left(\psi\left(v_{1}\right) \cup \psi\left(v_{2}\right)\right)\right| \geq M / 31$, then let $A \subset \psi(x) \cap\left(\psi\left(v_{1}\right) \cup \psi\left(v_{2}\right)\right)$ with $|A|=M / 31$. We choose $B \subset \psi(x)$ such that $A \cap B=\emptyset$ and $|B|=M / 31$. By Fact [1 there is a limitation $\psi^{\prime}$ of $\psi$ on $G^{\prime}$ such that $A \subset L^{\prime}(w)$ and $B \subset L^{\prime}(v)$. Clearly, $A \cup B \subset \psi^{\prime}(x)$. We set $A \subset \psi^{\prime}(w)$ and $B \subset \psi^{\prime}(v)$ followed by adding colors to $\psi^{\prime}(w), \psi^{\prime}(v)$, and $\psi^{\prime}(u)$ one by one greedily. Then we can define $\psi^{\prime}(u)$ properly because of sets $A$ and $B$. We obtain an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction. Thus we need only to consider the case where $\left|\psi(x) \cap\left(\psi\left(v_{1}\right) \cup \psi\left(v_{2}\right)\right)\right|<M / 31$. In this case, $|L(v) \cap \psi(x)|>8 M / 31$ as $L(v) \cup\left(\psi\left(v_{1}\right) \cup \psi\left(v_{2}\right)\right)=M$. We choose $C \subset\left(\psi\left(w_{1}\right) \cup \psi\left(w_{2}\right)\right)$ such that $|C|=M / 31$. By Fact 1 there is a limitation $\psi^{\prime}$ of $\psi$ on $G^{\prime}$ such that $C \subseteq L^{\prime}(v)$. We define $\psi^{\prime}(v)$ and $\psi^{\prime}(x)$ such that $C \subset \psi^{\prime}(v)$ and $\left|\psi^{\prime}(v) \cap \psi^{\prime}(x)\right| \geq 2 M / 31$. To complete the extension of $\psi^{\prime}$, we pick colors for $w$ and $u$ one by one. Therefore, we can construct an $\left(h_{G}, M\right)$-coloring for $G$, which is a contradiction.

For the case where one of $v_{1}, v_{2}, w_{1}$, and $w_{2}$ has degree three, we suppose that $d_{G}\left(v_{1}\right)=3$. Let $v_{1}^{\prime}$ and $v_{1}^{\prime \prime}$ be the other two neighbors of $v_{1}$. Then $d_{G}\left(v_{1}^{\prime}\right)=d_{G}\left(v_{1}^{\prime \prime}\right)=4$ by Claim 11. Let $G^{\prime}=G-\left\{u, v, w, v_{1}\right\}$ and $\psi$ be an $\left(h_{G^{\prime}}, M\right)$-coloring of $G^{\prime}$. If $\left|\psi\left(v_{1}^{\prime}\right) \cap \psi\left(v_{1}^{\prime \prime}\right)\right| \geq 2 M / 31$, then we fix $A \subset \psi\left(v_{1}^{\prime}\right) \cap \psi\left(v_{1}^{\prime \prime}\right)$ with $|A|=2 M / 31$. Let $B \subset \psi(x)$ and $C \subset \psi(x)$ such that $|B|=|C|=M / 31$ as well as $A, B, C$ are pairwise disjoint. By Fact 1 there is a limitation $\psi^{\prime}$ of $\psi$ on $G-\left\{u, v, w, v_{1}\right\}$ such that $B \subset L^{\prime}(w)$ and $C \subset L^{\prime}(v)$. Furthermore, it satisfies that $B \cup C \subset \psi^{\prime}(x)$ and $A \subset \psi^{\prime}\left(v_{1}^{\prime}\right) \cap \psi^{\prime}\left(v_{1}^{\prime \prime}\right)$. We put $B \subset \psi^{\prime}(w)$ and $C \subset \psi^{\prime}(v)$ followed by adding colors to $\psi^{\prime}(w)$ and $\psi^{\prime}(v)$ one by one greedily. To complete the extension, we color $v_{1}$ and $u$ one by one greedily. We obtain an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

If $\left|\psi\left(v_{1}^{\prime}\right) \cap \psi\left(v_{1}^{\prime \prime}\right)\right|<2 M / 31$, then we choose $B, C \subset \psi(x)$ as above. Additionally, we fix $D \subset\left(\psi\left(v_{1}^{\prime}\right) \cup \psi\left(v_{1}^{\prime \prime}\right)\right) \backslash \psi\left(v_{2}\right)$ such that $|D|=2 M / 31$ as well as $B, C$, and $D$ are pairwise disjoint. As we did above, we can define a limitation $\psi^{\prime}$ of $\psi$ on $G-\left\{u, v, w, v_{1}\right\}$ such that $B \cup C \subset \psi^{\prime}(x), B \subset L(w)$, and $C \cup D \subset L^{\prime}(v)$. We add extra colors to $\psi^{\prime}(w)$ and $\psi^{\prime}(v)$ one by one greedily. Then we can get an $\left(h_{G}, M\right)$-coloring for $G$ by picking colors for $v_{1}$ and $u$ greedily, which is a contradiction.

Claim $15 G$ contains no $F_{4}$ such that $u$ has a 3-neighbor.
Proof: Claim 14 implies that each vertex from $\{u, v, w, x\}$ is a 4 -vertex. Suppose that $N_{G}(u)=\left\{w, v, x, u^{\prime}\right\}$ and $N_{G}(v)=\left\{w, v, x, v^{\prime}\right\}$, where $d_{G}\left(u^{\prime}\right)=3$. Claim 7 gives us that $u^{\prime} \neq v^{\prime}$. Moreover, Claim 3 implies that $w u^{\prime}, w v^{\prime}, x u^{\prime}, x v^{\prime} \notin E(G)$. Let $G^{\prime}$ be the graph obtained from $G-\{u, x, w\}$ by identifying $u^{\prime}$ and $v$. Claim 2 together with Claim 13 yield that $G^{\prime}$ is $C_{8}^{2}$-free and $K_{4}$-free. Therefore, $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$, where we assume $\psi\left(\underline{u^{\prime} v}\right)=[1,9 M / 31]$. We define $A=[1+8 M / 31,9 M / 31]$.

If either $d_{G}\left(v^{\prime}\right)=4$ or $|L(w) \cap L(x)| \geq 2 M / 31$, then in the former case, there is a limitation $\psi^{\prime}$ of $\psi$ on $G-\{u, v, w, x\}$ with $A \subseteq L^{\prime}(w) \cap L^{\prime}(x)$ by Fact [1. Note that $[1,8 M / 31] \subset L^{\prime}(v)$. We put $A$ in $\psi^{\prime}(x)$ and $\psi^{\prime}(w)$ followed by adding extra colors to $\psi^{\prime}(x)$ and $\psi^{\prime}(w)$ greedily. Let $B=[1,8 M / 31] \backslash\left(\psi^{\prime}(x) \cup \psi^{\prime}(w)\right)$. We put $B \subset \psi^{\prime}(v)$ and choose extra colors greedily. This is possible because of $d_{G}\left(v^{\prime}\right)=4$ and the definition of $A$. Now, we are able to color $u$ properly because each color from $[1,9 M / 31]$ appears twice in the neighbors of $u$. In the latter case, let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\{u, v, w, x\}$ such that $A \subseteq L^{\prime}(w) \cap L^{\prime}(x)$ and $\left|L^{\prime}(w) \cap L^{\prime}(x)\right| \geq$ $2 M / 31$. To color $x$ and $w$, we set $A \subset \psi^{\prime}(x)$ and $A \subset \psi^{\prime}(w)$ followed by choosing extra colors satisfying $\left|\psi^{\prime}(x) \cap \psi^{\prime}(w)\right| \geq 2 M / 31$. Similarly, let $B=[1,8 M / 31] \backslash\left(\psi^{\prime}(x) \cup \psi^{\prime}(w)\right)$. We put $B \subset \psi^{\prime}(v)$ and pick additional colors for $\psi^{\prime}(v)$. We are able to construct an $\left(h_{G}, M\right)$-coloring for $G$ by picking colors for $u$ greedily, which is a contradiction.

If $d_{G}\left(v^{\prime}\right)=3$ and $|L(w) \cap L(x)|<2 M / 31$, then let $\psi^{\prime}$ be a limitation of $\psi$ on $G-$ $\{u, v, w, x\}$ such that $A \subseteq L^{\prime}(w) \cap L^{\prime}(x)$. Note that $\left|\left(L^{\prime}(w) \cup L^{\prime}(x)\right) \cap \psi^{\prime}\left(v^{\prime}\right)\right| \geq M / 31$. We choose $B \subseteq\left(L^{\prime}(w) \cup L^{\prime}(x)\right) \cap \psi^{\prime}\left(v^{\prime}\right)$ with $|B|=M / 31$ and denote $B_{1}=B \cap L^{\prime}(x)$ as well as $B_{2}=B \cap L^{\prime}(w)$. We put $A \cup B_{1} \subset \psi^{\prime}(x)$ and $A \cup B_{2} \in \psi^{\prime}(w)$ followed by adding extra colors to $\psi^{\prime}(x)$ and $\psi^{\prime}(w)$ greedily. Similarly, to color $v$, we first put $[1,9 M / 31] \backslash\left(\psi^{\prime}(w) \cup \psi^{\prime}(x)\right)$ in $\psi^{\prime}(v)$ and choose extra colors greedily. This is possible because of sets $A, B_{1}$, and $B_{2}$. Then we can get an $\left(h_{G}, M\right)$-coloring for $G$ by coloring $u$ greedily, which is a contradiction.

Claim 16 The graph $G$ contains no $F_{7}$, see Figure 3.
Proof: Suppose that $G$ contains an $F_{7}$. Claim 3 tells us that $F_{7}$ is an induced subgraph of $G$. Furthermore, each vertex in $F_{7}$ is a 4-vertex by Claim 14. For $z \in\{u, v, a, b\}$, let $z^{\prime}$ be the neighbor of $z$ not in $F_{7}$. Claim 15 gives us that $u^{\prime}, v^{\prime}, a^{\prime}$, and $b^{\prime}$ are 4 -vertices. Moreover, Claim 7 implies that $u^{\prime} \neq v^{\prime}$ and $a^{\prime} \neq b^{\prime}$.

Let $G^{\prime}$ be the graph obtained from $G-\{x, v, b\}$ by identifying $u$ and $a$. Clearly, Claim 22 and Claim 3 tell us that $G^{\prime}$ is $K_{4}$-free and $C_{8}^{2}$-free. Thus $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Suppose that $\psi(\underline{u a})=[1,8 M / 31]$. We define the limitation $\psi^{\prime}$ of $\psi$ on $G-\{x, u, v, a, b\}$ with some restrictions. Through removing extra colors properly, we can assume that $\left|L^{\prime}(u)\right|=$ $\left|L^{\prime}(a)\right|=15 M / 31,[1,8 M / 31] \subset L^{\prime}(u)$, and $[1,8 M / 31] \subset L^{\prime}(a)$. Let $A$ be a set such that $|A|=M / 31$ and $A \cap\left(L^{\prime}(u) \cup L^{\prime}(a)\right)=\emptyset$. We can ensure $A \subseteq L^{\prime}(v) \cap L^{\prime}(b)$ by deleting colors of $A$ from $\psi\left(v^{\prime}\right)$ and $\psi\left(b^{\prime}\right)$ first. Similarly, we can assume that $\left|L^{\prime}(v)\right|=\left|L^{\prime}(b)\right|=15 M / 31$ by removing colors. We first set $A \subset \psi^{\prime}(v)$ and then define $\psi^{\prime}(u)$ and $\psi^{\prime}(v)$ such that $[1,8 M / 31] \subset \psi^{\prime}(u) \cup \psi^{\prime}(v)$. If $\left|[1,8 M / 31] \cap L^{\prime}(v)\right| \leq 7 M / 31$, then we set $A \cup([1,8 M / 31] \cap$ $\left.L^{\prime}(v)\right) \subset \psi^{\prime}(v)$ and choose extra colors for $\psi^{\prime}(v)$ greedily. Note that $\left|L^{\prime}(u) \backslash \psi^{\prime}(v)\right| \geq$ $8 M / 31$ and we can define $\psi^{\prime}(v)$ properly by including colors from $[1,8 M / 31] \backslash \psi^{\prime}(v)$ first. If $\left|[1,8 M / 31] \cap L^{\prime}(v)\right|>7 M / 31$, then let $B \subseteq[1,8 M / 31] \cap L^{\prime}(v)$ such that $|B|=7 M / 31$. Set $\psi^{\prime}(v)=A \cup B$. To define $\psi^{\prime}(u)$, we first put $[1,8 M / 31] \backslash \psi^{\prime}(v)$ in $\psi^{\prime}(u)$ and add extra colors to $\psi^{\prime}(u)$ such that $\left|\psi^{\prime}(u)\right|=8 M / 31$. This is possible because of $\left|L^{\prime}(u) \backslash B\right|=8 M / 31$. We define $\psi^{\prime}(a)$ and $\psi^{\prime}(b)$ similarly. As each color from $[1,8 M / 31] \cup A$ appears twice in the neighbors of $x$, we can color $x$ properly. Therefore, we get an $\left(h_{G}, M\right)$-coloring for $G$, a contradiction.

Claim 17 There are no two triangles sharing an edge.

Proof: Suppose that $G$ contains a subgraph consisting of a triangle uvw and a vertex $x$ adjacent to $u$ and $v$. By Claim [14, each vertex from $\{u, v, w, x\}$ is a 4 -vertex. Let $u^{\prime}$ and $v^{\prime}$ be the other neighbor of $u$ and $v$ respectively. Claim 7 tells us that $u^{\prime} \neq v^{\prime}$ and Claim 15 implies that $d_{G}\left(u^{\prime}\right)=d_{G}\left(v^{\prime}\right)=4$. Let $G^{\prime}$ be a graph obtained from $G$ by deleting $u$ and $v$ followed by identifying $w$ and $x$. Claim 16 together with Claim 2 yield that $G$ is both $K_{4}$-free and $C_{8}^{2}$-free. Thus $G^{\prime}$ has $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Note that $|\psi(\underline{w x})|=8 M / 31$ and $\left|\psi\left(u^{\prime}\right)\right|=9 M / 31$. Let $A \subset \psi\left(u^{\prime}\right) \backslash \psi(\underline{w x})$ such that $|A|=M / 31$. By Fact 1 we may let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\{u, v, w, x\}$ such that $A \subseteq L^{\prime}(v)$. Set $\psi^{\prime}(w)=\psi(\underline{w x})$ and $\psi^{\prime}(x)=\psi(\underline{w x})$. In order to define $\psi^{\prime}(v)$, we first put $A$ in $\psi^{\prime}(v)$ and followed by adding extra colors greedily. As $d_{G}(u)=4$ and the definition of $A$, we can color $u$ properly to get an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

A 4-vertex $v$ is bad if it is contained in a triangle and has two neighbors with degree three.

Claim 18 G contains no bad 4-vertex.
Proof: Suppose that $G$ contains a bad 4-vertex $v$. Denote $N_{G}(v)=\left\{v_{1}, v_{2}, v_{3}, v_{4}\right\}$. Suppose that $d_{G}\left(v_{1}\right)=d_{G}\left(v_{2}\right)=3$. By Claim [14, both $\left\{v_{1}, v_{2}, v_{3}\right\}$ and $\left\{v_{1}, v_{2}, v_{4}\right\}$ are independent sets. Then we have $v_{3} v_{4} \in E(G)$ and $d_{G}\left(v_{3}\right)=d_{G}\left(v_{4}\right)=4$. For each $1 \leq i \leq 4$, let $v_{i}^{\prime}$ and $v_{i}^{\prime \prime}$ be the other neighbors of $v_{i}$. By Claim 11 and Claim 14, we get $d_{G}\left(v_{i}^{\prime}\right)=d_{G}\left(v_{i}^{\prime \prime}\right)=4$ for $1 \leq i \leq 2$. As Claim 17 shows that there are no two triangles sharing an edge, we get that vertices $v_{3}^{\prime}, v_{3}^{\prime \prime}, v_{4}^{\prime}$, and $v_{4}^{\prime \prime}$ are distinct.

Let $G^{\prime}$ be the graph obtained from $G-v$ by identifying $v_{1}$ and $v_{2}$. Then $G^{\prime}$ is $C_{8}^{2}$-free and $K_{4}$-free by Claim 2 and Claim 14 Thus $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Note that $\left|L\left(v_{1}\right)\right| \geq 15 M / 31$ and $\left|L\left(v_{2}\right)\right| \geq 15 M / 31$. We have $\left|L\left(v_{1}\right) \cap\left(\psi\left(v_{3}\right) \cup \psi\left(v_{4}\right)\right)\right| \geq 2 M / 31$ and $\left|L\left(v_{2}\right) \cap\left(\psi\left(v_{3}\right) \cup \psi\left(v_{4}\right)\right)\right| \geq 2 M / 31$. Let $A \subseteq L\left(v_{1}\right) \cap\left(\psi\left(v_{3}\right) \cup \psi\left(v_{4}\right)\right)$ such that $|A|=2 M / 31$. Similarly, let $B \subseteq L\left(v_{2}\right) \cap\left(\psi\left(v_{3}\right) \cup \psi\left(v_{4}\right)\right)$ such that $|B|=2 M / 31$.

Let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\left\{v, v_{1}, v_{2}\right\}$ such that $A \cup B \subseteq \psi^{\prime}\left(v_{3}\right) \cup \psi^{\prime}\left(v_{4}\right)$. We extend $\psi^{\prime}$ to $v_{1}$ and $v_{2}$ such that $A \subseteq \psi^{\prime}\left(v_{1}\right), B \subseteq \psi^{\prime}\left(v_{2}\right)$, and $\left|\psi^{\prime}\left(v_{1}\right) \cap \psi^{\prime}\left(v_{2}\right)\right|$ as large as possible. Note that $\psi\left(\underline{v_{1} v_{2}}\right) \subseteq L^{\prime}\left(v_{1}\right) \cap L^{\prime}\left(v_{2}\right)$ and $\left|\psi^{\prime}\left(v_{1}\right)\right|=\left|\psi^{\prime}\left(v_{2}\right)\right|=9 M / 31$. Then $\left|\psi^{\prime}\left(v_{1}\right) \cap \psi^{\prime}\left(v_{2}\right)\right| \geq 7 M / 31$. Now, $\left|\cup_{i=1}^{4} \psi^{\prime}\left(v_{i}\right)\right| \leq 23 M / 31$ and we can define $\psi^{\prime}(v)$ properly to obtain an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

Claim 19 There are no two triangles in $G$ sharing a vertex.
Proof: Suppose that $G$ contains two triangles $v v_{1} v_{2}$ and $v v_{3} v_{4}$ sharing a vertex $v$. Claim 14 implies that $d_{G}\left(v_{i}\right)=4$ for $1 \leq i \leq 4$. We next show that $G$ has an $\left(h_{G}, M\right)$-coloring. The rough idea is that we will start with a coloring of $G-\left\{v, v_{2}, v_{3}\right\}$, where $v_{1}$ and $v_{4}$ are colored with the same colors. We extend the coloring to $v_{2}, v_{3}$, and $v$ one by one. As each $v_{i}$ has degree four, if there are $9 M / 31$ colors such that each of them appears twice in the neighbors of $v$, then we can color $v$ properly. To achieve this, when we color $v_{3}$, we will choose $M / 31$ colors from the color set of $v_{2}$ and assign them to the color set of $v_{3}$. In the process of coloring, we may need to redefine the color sets of $v_{1}$ and $v_{4}$.

For each $1 \leq i \leq 4$, let $v_{i}^{\prime}$ and $v_{i}^{\prime \prime}$ be the other two neighbors of $v_{i}$. By Claim 17, vertices $v_{1}^{\prime}, v_{1}^{\prime \prime}, v_{2}^{\prime}$, and $v_{2}^{\prime \prime}$ are distinct. Similarly, $v_{3}^{\prime}, v_{3}^{\prime \prime}, v_{4}^{\prime}$, and $v_{4}^{\prime \prime}$ are distinct. For each $1 \leq i \leq 4$, we have $d_{G}\left(v_{i}^{\prime}\right)+d_{G}\left(v_{i}^{\prime \prime}\right) \geq 7$ by Claim 18. There are two cases.
Case 1: There is some $j \in\{1,2\}$ and some $k \in\{3,4\}$ such that $N_{G}\left(v_{j}\right) \cap N_{G}\left(v_{k}\right)=v$. By the symmetry, we can assume that $j=1$ and $k=3$. Let $G^{\prime}$ be the graph obtained from $G-\left\{v, v_{2}, v_{3}\right\}$ by identifying $v_{1}$ and $v_{4}$. Claim 2 and Claim 17 indicate that $G^{\prime}$ is $C_{8}^{2}$-free and $K_{4}$-free. Thus $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\left\{v, v_{2}, v_{3}, v_{2}^{\prime}, v_{2}^{\prime \prime}, v_{3}^{\prime}, v_{3}^{\prime \prime}\right\}$. Without loss of generality, we assume that $\psi^{\prime}\left(v_{1}\right)=\psi^{\prime}\left(v_{4}\right)=$ [1, $8 M / 31]$. There are two subcases.

Subcase 1.1: $\left|N_{G}\left(v_{2}\right) \cap N_{G}\left(v_{3}\right)\right|=1$. It implies that $v$ is the only common neighbor of $v_{2}$ and $v_{3}$. Notice that $v_{2}^{\prime}, v_{2}^{\prime \prime}, v_{3}^{\prime}$, and $v_{3}^{\prime \prime}$ are distinct as well as $d_{G^{\prime}}(u)=d_{G}(u)-1$ for each $u \in\left\{v_{2}^{\prime}, v_{2}^{\prime \prime}, v_{3}^{\prime}, v_{3}^{\prime \prime}\right\}$. Let $A_{2}=[1,8 M / 31] \cap\left(\psi\left(v_{2}^{\prime}\right) \cup \psi\left(v_{2}^{\prime \prime}\right)\right)$ and $B_{2}=\psi\left(v_{2}^{\prime}\right) \cap \psi\left(v_{2}^{\prime \prime}\right)$. Similarly, let $A_{3}=[1,8 M / 31] \cap\left(\psi\left(v_{3}^{\prime}\right) \cup \psi\left(v_{3}^{\prime \prime}\right)\right)$ and $B_{3}=\psi\left(v_{3}^{\prime}\right) \cap \psi\left(v_{3}^{\prime \prime}\right)$. We next color $v_{2}$, $v_{3}$, and $v$ one by one.

Let us start with the case where either $\left|A_{2}\right| \geq\left(9-d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$ or $\left|B_{2}\right| \geq$ $\left(9-d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$. In the former case, we delete $M / 31$ colors from $\psi\left(v_{2}^{\prime}\right)$ and $M / 31$ colors from $\psi\left(v_{2}^{\prime \prime}\right)$ respectively, while keeping $A_{2}$ as large as possible. In the latter case, we delete colors from $\psi\left(v_{2}^{\prime}\right)$ and $\psi\left(v_{2}^{\prime \prime}\right)$ while keeping $B_{2}$ as large as possible. In each case, we can choose colors for $\psi^{\prime}\left(v_{2}\right)$ greedily. We next color $v_{3}$. If either $\left|A_{3}\right| \geq\left(9-d_{G}\left(v_{3}^{\prime}\right)-d_{G}\left(v_{3}^{\prime \prime}\right)\right) M / 31$ or $\left|B_{3}\right| \geq\left(9-d_{G}\left(v_{3}^{\prime}\right)-d_{G}\left(v_{3}^{\prime \prime}\right)\right) M / 31$, then we pick a set $C \subset \psi^{\prime}\left(v_{2}\right)$ such that $|C|=M / 31$. Notice that $C \cap[1,8 M / 31]=\emptyset$. In the latter case, we further require $\left|C \cap B_{3}\right|$ as small as possible. Let us put $C \subset \psi^{\prime}\left(v_{3}\right)$. When we define $\psi^{\prime}\left(v_{3}^{\prime}\right)$ and $\psi^{\prime}\left(v_{3}^{\prime \prime}\right)$, we remove colors from $C$ first while keeping $A_{3}$ (and $B_{3}$ in the latter case) as large as possible. In each case, we can choose extra colors for $\psi^{\prime}\left(v_{3}\right)$ greedily. Note that each color from $[1,8 M / 31] \cup C$ appears twice in the neighbors of $v$, we can color $v$ properly to get an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction. Therefore, we assume that $\left|A_{3}\right|<\left(9-d_{G}\left(v_{3}^{\prime}\right)-d_{G}\left(v_{3}^{\prime \prime}\right)\right) M / 31$ and $\left|B_{3}\right|<\left(9-d_{G}\left(v_{3}^{\prime}\right)-\right.$ $\left.d_{G}\left(v_{3}^{\prime \prime}\right)\right) M / 31$. Notice that $\left|\psi\left(v_{3}^{\prime}\right) \cup \psi\left(v_{3}^{\prime \prime}\right)\right|=\left(26-d_{G}\left(v_{3}^{\prime}\right)-d_{G}\left(v_{3}^{\prime \prime}\right)\right) M / 31-\left|B_{3}\right|$. Recall $d_{G}\left(v_{4}^{\prime}\right)+d_{G}\left(v_{4}^{\prime \prime}\right) \geq 7$. Therefore, $\left|\psi^{\prime}\left(v_{4}^{\prime}\right) \cup \psi^{\prime}\left(v_{4}^{\prime \prime}\right)\right| \leq 17 M / 31$, which yields that there exists a set $D \subset\left(\psi\left(v_{3}^{\prime}\right) \cup \psi\left(v_{3}^{\prime \prime}\right)\right) \backslash\left(\psi^{\prime}\left(v_{4}^{\prime}\right) \cup \psi^{\prime}\left(v_{4}^{\prime \prime}\right)\right)$ with $|D|=\left(9-d_{G}\left(v_{3}^{\prime}\right)-d_{G}\left(v_{3}^{\prime \prime}\right)\right) M / 31-\left|B_{3}\right|$. The fact $d_{G}\left(v_{3}^{\prime}\right)+d_{G}\left(v_{3}^{\prime \prime}\right) \geq 7$ implies that $\left|B_{3}\right|+|D| \leq 2 M / 31$. Note that $\psi^{\prime}\left(v_{2}\right) \cap[1,8 M / 31]=\emptyset$. Now we are able to choose $C \subset \psi^{\prime}\left(v_{2}\right)$ such that $|C|=M / 31$ and $C \cap B_{3}=C \cap D=\emptyset$. Let $E \subset[1,8 M / 31]$ such that $|E|=|D|$ and $E \cap A_{3}=E \cap C=\emptyset$. We redefine $\psi^{\prime}\left(v_{4}\right)$ by removing colors of $E$ and adding colors from $D$. To color $v_{3}$, we put $C \cup E \subset \psi^{\prime}\left(v_{3}\right)$. We next define $\psi^{\prime}\left(v_{3}^{\prime}\right)$ and $\psi^{\prime}\left(v_{3}^{\prime \prime}\right)$ by removing colors from $C$ first and extra colors if it is needed, here we keep colors from $B_{3}$. As sets $B_{3}$ and $D$, we can color $v_{3}$ properly. Since each color from $[1,8 M / 31] \cup C$ appears twice in the neighbors of $v$, we can color $v$ properly to get an ( $h_{G}, M$ )-coloring of $G$, a contradiction.

Now, we consider the case where $\left|A_{2}\right|<\left(9-d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$ and $\left|B_{2}\right|<(9-$ $\left.d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$. In this case, to color $v_{2}$, we can use the idea to color $v_{3}$ when $\left|A_{3}\right|<\left(9-d_{G}\left(v_{3}^{\prime}\right)-d_{G}\left(v_{3}^{\prime \prime}\right)\right) M / 31$ and $\left|B_{3}\right|<\left(9-d_{G}\left(v_{3}^{\prime}\right)-d_{G}\left(v_{3}^{\prime \prime}\right)\right) M / 31$. Namely, we move a set of at most $2 M / 31$ colors from $[1,8 M / 31]$ to $\psi^{\prime}\left(v_{2}\right)$ and replace them by a set of at most $2 M / 31$ from $\left(\psi^{\prime}\left(v_{2}^{\prime}\right) \cup \psi^{\prime}\left(v_{2}^{\prime \prime}\right)\right) \backslash\left(\psi^{\prime}\left(v_{1}^{\prime}\right) \cup \psi^{\prime}\left(v_{1}^{\prime \prime}\right)\right)$. We repeat the argument above to color $v_{3}$ by case analysis according to the sizes of $A_{3}$ and $B_{3}$. No matter whether $\left|A_{3}\right|<\left(9-d_{G}\left(v_{3}^{\prime}\right)-d_{G}\left(v_{3}^{\prime \prime}\right)\right) M / 31$ or $\left|B_{3}\right|<\left(9-d_{G}\left(v_{3}^{\prime}\right)-d_{G}\left(v_{3}^{\prime \prime}\right)\right) M / 31$, the existence of a desired subset $C \subset \psi^{\prime}\left(v_{2}\right) \backslash[1,8 M / 31]$ is ensured by facts $|D|+\left|B_{3}\right| \leq 2 M / 31$ and $\left|\psi^{\prime}\left(v_{2}\right) \backslash[1,8 M / 31]\right| \geq 6 M / 31$. As above, each color from $[1,8 M / 31] \cup C$ appears twice in the neighbors of $v$. Thus we can color $v$ greedily and obtain an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

Subcase 1.2: $\left|N_{G}\left(v_{2}\right) \cap N_{G}\left(v_{3}\right)\right| \geq 2$. We define $A_{2}, B_{2}, A_{3}$, and $B_{3}$ as we did in Subcase 1.1. We can reuse ideas in Subcase 1.1 to extend the coloring $\psi^{\prime}$ to $G$. For the case where $v_{2}^{\prime}=v_{3}^{\prime}$ and $v_{2}^{\prime \prime} \neq v_{3}^{\prime \prime}$, note that $\left|\psi\left(v_{2}^{\prime}\right)\right|=\left(14-d_{G}\left(v_{2}^{\prime}\right)\right) M / 31$ as both $v_{2}$ and $v_{3}$ are adjacent to $v_{2}^{\prime}$. After we finish the coloring of $v_{2}^{\prime}$, if we still use $\psi\left(v_{2}^{\prime}\right)$ to denote the color set of $v_{2}^{\prime}$, then we require $\left|\psi\left(v_{2}^{\prime}\right)\right|=\left(13-d_{G}\left(v_{2}^{\prime}\right)\right) M / 31$. Otherwise, we have troubles to extend the coloring to $v_{3}$. Therefore, to color $v_{2}$, we need to consider cases depending on whether $\left|A_{2}\right| \geq\left(10-d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$ or $\left|B_{2}\right| \geq\left(10-d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$. Note that when $\left|A_{2}\right|<\left(10-d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$ and $\left|B_{2}\right|<\left(10-d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$, it holds $\mid\left(\psi\left(v_{2}^{\prime}\right) \cup\right.$ $\left.\psi\left(v_{2}^{\prime \prime}\right)\right) \backslash\left(\psi\left(v_{1}^{\prime}\right) \cup \psi\left(v_{1}^{\prime \prime}\right)\right)\left|\geq\left(10-d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31-\left|B_{2}\right|\right.$ as $| \psi\left(v_{2}^{\prime}\right) \mid=\left(14-d_{G}\left(v_{2}^{\prime}\right)\right) M / 31$ and $\left|\psi\left(v_{2}^{\prime \prime}\right)\right|=\left(13-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$. For the case where $v_{2}^{\prime}=v_{3}^{\prime}$ and $v_{2}^{\prime \prime}=v_{3}^{\prime \prime}$, to define $\psi^{\prime}\left(v_{2}\right)$, we have to consider cases depending on whether $\left|A_{2}\right| \geq\left(11-d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$ or $\left|B_{2}\right| \geq\left(11-d_{G}\left(v_{2}^{\prime}\right)-d_{G}\left(v_{2}^{\prime \prime}\right)\right) M / 31$ similarly. In each case, we can construct an $\left(h_{G}, M\right)-$
coloring of $G$, a contradiction.
Case 2: For each $j \in\{1,2\}$ and each $k \in\{3,4\}$, we have $\left|N_{G}\left(v_{j}\right) \cap N_{G}\left(v_{k}\right)\right| \geq 2$. Recall Claim 19. In this case, there are distinct vertices $x, y, w, z$ such that $x \in N_{G}\left(v_{1}\right) \cap N_{G}\left(v_{3}\right)$, $y \in N_{G}\left(v_{1}\right) \cap N_{G}\left(v_{4}\right), w \in N_{G}\left(v_{2}\right) \cap N_{G}\left(v_{3}\right)$, and $z \in N_{G}\left(v_{2}\right) \cap N_{G}\left(v_{4}\right)$. By the symmetry, we assume that $d_{G}(x)+d_{G}(y) \geq d_{G}(w)+d_{G}(z)$. Let $G^{\prime}$ be the graph obtained from $G-\left\{v, v_{2}, v_{3}\right\}$ by identifying $v_{1}$ and $v_{4}$. It is easy to check that $G^{\prime}$ is $K_{4}$-free and $C_{8}^{2}$-free. Let $\psi$ be an $\left(h_{G^{\prime}}, M\right)$-coloring of $G^{\prime}$ and $\psi^{\prime}$ be a limitation of $\psi$ on $G-\left\{v, v_{2}, v_{3}, x, w, z\right\}$. We also assume that $\psi^{\prime}\left(v_{1}\right)=\psi^{\prime}\left(v_{4}\right)=[1,8 M / 31]$ and define $A_{2}=[1,8 M / 31] \cap(\psi(w) \cup \psi(z))$ as well as $B_{2}=\psi(w) \cap \psi(z)$. To color $v_{2}$, we reuse ideas in Subcase 1.1 and consider cases depending on whether $\left|A_{2}\right| \geq\left(10-d_{G}(w)-d_{G}(z)\right) M / 31$ or $\left|B_{2}\right| \geq\left(10-d_{G}(w)-d_{G}(z)\right) M / 31$. After the coloring of $\psi^{\prime}\left(v_{2}\right)$, we still use $\psi(w)$ to denote the color set of $w$, here we similarly require $|\psi(w)|=\left(13-d_{G}(w)\right) M / 31$. To define $\psi^{\prime}\left(v_{2}^{\prime}\right)$, when $\left|A_{2}\right|<\left(10-d_{G}(w)-d_{G}(z)\right) M / 31$ and $\left|B_{2}\right|<\left(10-d_{G}(w)-d_{G}(z)\right) M / 31$, it holds $\left|(\psi(w) \cup \psi(z)) \backslash\left(\psi(x) \cup \psi^{\prime}(y)\right)\right| \geq\left(10-d_{G}(w)-\right.$ $\left.d_{G}(z)\right) M / 31-\left|B_{2}\right|$ as the assumption $d_{G}(x)+d_{G}(y) \geq d_{G}(w)+d_{G}(z)$. To color $v_{3}$, we define $A_{3}=[1,8 M / 31] \cap(\psi(x) \cup \psi(w))$ and $B_{3}=\psi(x) \cap \psi(w)$ followed by considering cases depending on $\left|A_{3}\right|$ and $\left|B_{3}\right|$. In each case, we can guarantee that each color of $[1,8 M / 31] \cup C$ appears twice in the neighbors of $v$ for some $C \subset \psi^{\prime}\left(v_{2}\right) \backslash[1,8 M / 31]$ with $|C|=M / 31$. Thus we can color $v$ greedily to get an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

Claim 20 Each 4-vertex has at least one 4-neighbor.
Proof: Let $v$ be a 4-vertex of $G$ with $N_{G}(v)=\left\{v_{1}, v_{2}, v_{3}, v_{4}\right\}$. Suppose that $d_{G}\left(v_{i}\right)=3$ for $1 \leq i \leq 4$. Then $\left\{v_{1}, v_{2}, v_{3}, v_{4}\right\}$ is an independent set and the neighbors of $v_{1}, v_{2}, v_{3}, v_{4}$ are 4 -vertices by Claim 11 and Claim [14]. Let $G^{\prime}$ be the graph obtained from $G-v$ by identifying $v_{1}$ and $v_{2}$. Claim 14 and Claim 2 imply that $G^{\prime}$ is $K_{4}$-free and contains no $C_{8}^{2}$. Then $G^{\prime}$ has an $\left(h_{G^{\prime}}, M\right)$-coloring $\psi$. Note that $\left|\psi\left(\underline{v_{1} v_{2}}\right)\right|=8 M / 31$. Let $\psi^{\prime}$ be a limitation of $\psi$ on $G-\left\{v, v_{1}, v_{2}, v_{3}, v_{4}\right\}$. To define $\psi^{\prime}\left(v_{1}\right)$ and $\psi^{\prime}\left(v_{2}\right)$, we add $M / 31$ extra colors to $\psi\left(\underline{v_{1} v_{2}}\right)$ greedily. We can assume that $\left|L^{\prime}(v)\right|=21 M / 31,\left|L^{\prime}\left(v_{3}\right)\right|=15 M / 31$ and $\left|L^{\prime}\left(v_{4}\right)\right|=15 M / 31$ by deleting colors if it is necessary. Let $A \subseteq L^{\prime}(v) \backslash L^{\prime}\left(v_{3}\right)$ with $|A|=2 M / 31$ and $B \subseteq L^{\prime}(v) \backslash L^{\prime}\left(v_{4}\right)$ with $|B|=2 M / 31$. To color $v$, we put $A \cup B$ in $\psi^{\prime}(v)$ and add extra colors to $\psi^{\prime}(v)$ such that $\left|\psi^{\prime}(v)\right|=8 M / 31$. Now $v_{3}$ and $v_{4}$ can be colored properly because of sets $A$ and $B$. We obtained an $\left(h_{G}, M\right)$-coloring of $G$, a contradiction.

Proof of Lemma 3: Claim 2 implies that $d_{G}(v) \geq 3$ for each $v \in V(G)$. If $d_{G}(v)=3$, then $N_{G}(v)$ is an independent set by Claim 14. Consequently, $e\left(N_{G}(v), N_{G}^{2}(v)\right) \geq 6$. If $d_{G}(v)=4$, then $v$ has at least a 4-neighbor by Claim 20. If $v$ has exactly one 4-neighbor, then $v$ is not in any triangles by Claim 14, which yields $e\left(N_{G}(v), N_{G}^{2}(v)\right) \geq 9$. If $v$ has exactly two 4-neighbors, then $v$ is not in any triangles by Claims 14 and 18 It follows that $e\left(N_{G}(v), N_{G}^{2}(v)\right) \geq 2+2+3+3=10$. If $v$ has at least three 4-neighbors, then $v$ is in at most one triangle by Claim 17 and Claim 19 and we have $e\left(N_{G}(v), N_{G}^{2}(v)\right) \geq 9$. The lemma is proved.
