# A-NUMERICAL RADIUS : NEW INEQUALITIES AND CHARACTERIZATION OF EQUALITIES

#### Abstract

We develope new lower bounds for the $A$-numerical radius of semiHilbertian space operators, and applying these bounds we obtain upper bounds for the $A$-numerical radius of the commutators of operators. The bounds obtained here improve on the existing ones. Further, we provide characterizations for the equality of the existing $A$-numerical radius inequalities of semiHilbertian space operators.


## 1. Introduction

Let $\mathcal{B}(\mathcal{H})$ denote the $\mathbb{C}^{*}$-algebra of all bounded linear operators on a complex Hilbert space $\mathcal{H}$ with inner product $\langle.,$.$\rangle and the corresponding norm \|$.$\| . For$ $T \in \mathcal{B}(\mathcal{H})$, the range and the kernel of $T$ are denoted by $R(T)$ and $N(T)$, respectively. By $\overline{R(T)}$, we denote the norm closure of $R(T)$. The Hilbert-adjoint of $T$ is denoted by $T^{*}$. Let $A \in \mathcal{B}(\mathcal{H})$ be a positive operator, henceforth we reserve the symbol $A$ for positive operator on $\mathcal{H}$. Clearly, $A$ induces a positive semidefinite sesquilinear form $\langle., .\rangle_{A}: \mathcal{H} \times \mathcal{H} \rightarrow \mathbb{C}$, defined by $\langle x, y\rangle_{A}=\langle A x, y\rangle$ for all $x, y \in \mathcal{H}$. This sesquilinear form induces a seminorm $\|\cdot\|_{A}: \mathcal{H} \rightarrow \mathbb{R}^{+}$, defined by $\|x\|_{A}=\sqrt{\langle x, x\rangle_{A}}$ for all $x \in \mathcal{H}$. Clearly, $\|\cdot\|_{A}$ is a norm if and only if $A$ is injective, and $\left(\mathcal{H},\|\cdot\|_{A}\right)$ is complete if and only if $R(A)$ is closed in $\mathcal{H}$. An operator $T \in \mathcal{B}(\mathcal{H})$ is said to be $A$-bounded if there exists $c>0$ such that $\|T x\|_{A} \leq c\|x\|_{A}$ for all $x \in \overline{R(A)}$, and in this case

\|T\|_{A}=\sup _{x \in R(A), x \neq 0} \frac{\|T x\|_{A}}{\|x\|_{A}}=\sup _{x \in \frac{\sup _{R}(A),}{}\|x\|_{A}=1}\|T x\|_{A}<+\infty
$$

Let $\mathcal{B}^{A}(\mathcal{H})$ denote the collection of all $A$-bounded operators, i.e., $\mathcal{B}^{A}(\mathcal{H})=\{T \in$ $\left.\mathcal{B}(\mathcal{H}):\|T\|_{A}<+\infty\right\}$. It is well known that $\mathcal{B}^{A}(\mathcal{H})$ is, in general, not a subalgebra of $\mathcal{B}(\mathcal{H})$. Note that $\|T\|_{A}=0$ if and only if $A T A=0$. The $A$-adjoint of $T$, if it exists, is defined as follows:

Definition 1.1. ([1]) For $T \in \mathcal{B}(\mathcal{H})$, an operator $S \in \mathcal{B}(\mathcal{H})$ is said to be an A-adjoint of $T$ if $\langle T x, y\rangle_{A}=\langle x, S y\rangle_{A}$ for all $x, y \in \mathcal{H}$, i.e, $A S=T^{*} A$.
Let $\mathcal{B}_{A}(\mathcal{H})$ denote the collection of all operators in $\mathcal{B}(\mathcal{H})$, which admit A-adjoint. By Douglas theorem [10], it follows that

$$
\mathcal{B}_{A}(\mathcal{H})=\left\{T \in \mathcal{B}(\mathcal{H}): R\left(T^{*} A\right) \subseteq R(A)\right\} .
$$

[^0]For $T \in \mathcal{B}_{A}(\mathcal{H})$, the operator equation $A X=T^{*} A$ has a unique solution, denoted by $T^{\sharp_{A}}$, satisfying $R\left(T^{\sharp_{A}}\right) \subseteq \overline{R(A)}$. Note that $T^{\sharp} A=A^{\dagger} T^{*} A$, where $A^{\dagger}$ is the Moore-Penrose inverse of $A$. We note that $\mathcal{B}_{A}(\mathcal{H})\left(\subseteq \mathcal{B}^{A}(\mathcal{H})\right)$ is a sub-algebra of $\mathcal{B}(\mathcal{H})$. For $T \in \mathcal{B}_{A}(\mathcal{H})$, we have, $A T^{\sharp_{A}}=T^{*} A$ and $N\left(T^{\sharp_{A}}\right)=N\left(T^{*} A\right)$. If $T \in \mathcal{B}_{A}(\mathcal{H})$, then $T^{\sharp A} \in \mathcal{B}_{A}(\mathcal{H})$ and $\left(T^{\sharp A}\right)^{\sharp A}=P_{\overline{R(A)}} T P_{\overline{R(A)}}$ where $P_{\overline{R(A)}}$ is the orthogonal projection onto $R(A)$. An operator $T \in \mathcal{B}_{A}(\mathcal{H})$ is said to be A-self-adjoint if $A T$ is self-adjoint, i.e., $A T=T^{*} A$. For further study on the Aadjoint operator, we refer to [1]. Note that, for $T, S \in \mathcal{B}_{A}(\mathcal{H}),(T S)^{\sharp_{A}}=S^{\sharp_{A}} T^{\sharp A}$, $\|T S\|_{A} \leq\|T\|_{A}\|S\|_{A}$ and $\|T x\|_{A} \leq\|T\|_{A}\|x\|_{A}$ for all $x \in \mathcal{H}$. Clearly, for $T \in$ $\mathcal{B}_{A}(\mathcal{H}),\left\|T T^{\sharp_{A}}\right\|_{A}=\left\|T^{\sharp_{A}} T\right\|_{A}=\left\|T^{\sharp_{A}}\right\|_{A}^{2}=\|T\|_{A}^{2}$.
For $T \in \mathcal{B}_{A}(\mathcal{H})$, the A-numerical range of $T$, denoted by $W_{A}(T)$, is defined as

$$
W_{A}(T)=\left\{\langle T x, x\rangle_{A}: x \in \mathcal{H},\|x\|_{A}=1\right\}
$$

and the $A$-numerical radius of $T$, denoted by $w_{A}(T)$, is defined as

$$
w_{A}(T)=\sup \left\{\left|\langle T x, x\rangle_{A}\right|: x \in \mathcal{H},\|x\|_{A}=1\right\} .
$$

It was shown in [15] that for $T \in \mathcal{B}_{A}(\mathcal{H}), w_{A}(T)=\sup _{\theta \in \mathbb{R}}\left\|\frac{e^{i \theta} T+\left(e^{i \theta} T\right)^{\sharp} A}{2}\right\|_{A}$. For $T \in \mathcal{B}_{A}(\mathcal{H})$, we have

$$
\|T\|_{A}=\sup \left\{\|T x\|_{A}:\|x\|_{A}=1\right\}=\sup \left\{\left|\langle T x, y\rangle_{A}\right|:\|x\|_{A}=\|y\|_{A}=1\right\}
$$

It is well-known that $w_{A}($.$) and \|.\|_{A}$ are equivalent seminorms on $\mathcal{B}_{A}(\mathcal{H})$ satisfying the inequality (see [2, Prop. 2.5])

$$
\begin{equation*}
\frac{1}{2}\|T\|_{A} \leq w_{A}(T) \leq\|T\|_{A} \tag{1.1}
\end{equation*}
$$

The inequalities in (1.1) are sharp (see [11]), $w_{A}(T)=\frac{1}{2}\|T\|_{A}$ if $A T^{2}=0$ and $w_{A}(T)=\|T\|_{A}$ if $A T=T^{*} A$. An improvement of (1.1) is given in [12, 15], which is

$$
\begin{equation*}
\frac{1}{4}\left\|T^{\sharp A} T+T T^{\sharp A}\right\|_{A} \leq w_{A}^{2}(T) \leq \frac{1}{2}\left\|T^{\sharp A} T+T T^{\sharp A}\right\|_{A} . \tag{1.2}
\end{equation*}
$$

More refinements in this direction are also given in $[3,4,5,6,7,13,14]$. Inspired by the inequalities obtained in the article [8, 9], here we obtain new refinements of the first inequalities in (1.1) and (1.2). By applying the new refinements developed here, we obtain upper bounds for the $A$-numerical radius of the commutators of operators. Also, we obtain characterizations for the equality of first inequalities in (1.1) and (1.2).

## 2. Lower bounds for $A$-numerical radius

We begin with the observation that any $T \in \mathcal{B}_{A}(\mathcal{H})$ can be expressed as $T=$ $\Re_{A}(T)+\mathrm{i} \Im_{A}(T)$, where $\Re_{A}(T)=\frac{T+T^{\sharp} A}{2}$ and $\Im_{A}(T)=\frac{T-T^{\sharp} A}{2 \mathrm{i}}$. It is easy to verify that $\Re_{A}(T)$ and $\Im_{A}(T)$ both are $A$-self-adjoint, i.e., $A \Re_{A}(T)=\left(\Re_{A}(T)\right)^{*} A$ and $A \Im_{A}(T)=\left(\Im_{A}(T)\right)^{*} A$. Therefore, $w_{A}\left(\Re_{A}(T)\right)=\left\|\Re_{A}(T)\right\|_{A}$ and $w_{A}\left(\Im_{A}(T)\right)=$ $\left\|\Im_{A}(T)\right\|_{A}$. Now, we are in a position to prove our first improvement.
Theorem 2.1. If $T \in \mathcal{B}_{A}(\mathcal{H})$, then

$$
w_{A}(T) \geq \frac{\|T\|_{A}}{2}+\frac{\left|\left\|\Re_{A}(T)\right\|_{A}-\left\|\Im_{A}(T)\right\|_{A}\right|}{2} .
$$

Proof. Let $x \in \mathcal{H}$ with $\|x\|_{A}=1$. Then from $T=\Re_{A}(T)+\mathrm{i} \Im_{A}(T)$, we have

$$
\left|\langle T x, x\rangle_{A}\right|^{2}=\left|\left\langle\Re_{A}(T) x, x\right\rangle_{A}\right|^{2}+\left|\left\langle\Re_{A}(T) x, x\right\rangle_{A}\right|^{2} .
$$

This implies that

$$
\left|\langle T x, x\rangle_{A}\right| \geq\left|\left\langle\Re_{A}(T) x, x\right\rangle_{A}\right| \text { and }\left|\langle T x, x\rangle_{A}\right| \geq\left|\left\langle\Im_{A}(T) x, x\right\rangle_{A}\right| .
$$

Considering supremum over $\|x\|_{A}=1$, we get

$$
w_{A}(T) \geq\left\|\Re_{A}(T)\right\|_{A} \text { and } w_{A}(T) \geq\left\|\Im_{A}(T)\right\|_{A}
$$

Hence,

$$
\begin{aligned}
w_{A}(T) & \geq \max \left\{\left\|\Re_{A}(T)\right\|_{A},\left\|\Im_{A}(T)\right\|_{A}\right\} \\
& =\frac{\left\|\Re_{A}(T)\right\|_{A}+\left\|\Im_{A}(T)\right\|_{A}}{2}+\frac{\left|\left\|\Re_{A}(T)\right\|_{A}-\left\|\Im_{A}(T)\right\|_{A}\right|}{2} \\
& \geq \frac{\left\|\Re_{A}(T)+\mathrm{i} \Im_{\mathrm{A}}(\mathrm{~T})\right\|_{\mathrm{A}}}{2}+\frac{\left|\left\|\Re_{A}(T)\right\|_{A}-\left\|\Im_{A}(T)\right\|_{A}\right|}{2} \\
& =\frac{\|T\|_{A}}{2}+\frac{\left|\left\|\Re_{A}(T)\right\|_{A}-\left\|\Im_{A}(T)\right\|_{A}\right|}{2} .
\end{aligned}
$$

Thus, we complete the proof.
Remark 2.2. Clearly, the inequality in Theorem 2.1 is sharper than the first inequality in (1.1), i.e., $w_{A}(T) \geq \frac{\|T\|_{A}}{2}$.

In the next theorem we provide a characterzation for the equality of lower bound of $A$-numerical radius mentioned in (1.1).

Theorem 2.3. Let $T \in \mathcal{B}_{A}(\mathcal{H})$.
(i) If $w_{A}(T)=\frac{\|T\|_{A}}{2}$, then

$$
\left\|\Re_{A}(T)\right\|_{A}=\left\|\Im_{A}(T)\right\|_{A}=\frac{\|T\|_{A}}{2}
$$

but the converse is not necessarliy true.
(ii) $w_{A}(T)=\frac{\|T\|_{A}}{2}$ if and only if $\left\|\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}=\left\|\Im_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}=\frac{\|T\|_{A}}{2}$ for all $\theta \in \mathbb{R}$.

Proof. (i) It follows from Theorem 2.1 that if $w_{A}(T)=\frac{\|T\|_{A}}{2}$, then

$$
\left\|\Re_{A}(T)\right\|_{A}=\left\|\Im_{A}(T)\right\|_{A} .
$$

Also, we get

$$
\begin{aligned}
\left\|\Re_{A}(T)\right\|_{A} \leq w_{A}(T)=\frac{\|T\|_{A}}{2}=\frac{\left\|\Re_{A}(T)+\mathrm{i} \Im_{\mathrm{A}}(\mathrm{~T})\right\|_{\mathrm{A}}}{2} & \leq \frac{\left\|\Re_{A}(T)\right\|_{A}+\left\|\Im_{A}(T)\right\|_{A}}{2} \\
& =\left\|\Re_{A}(T)\right\|_{A} .
\end{aligned}
$$

This implies that $\left\|\Re_{A}(T)\right\|_{A}=\frac{\|T\|_{A}}{2}$, and so $\left\|\Im_{A}(T)\right\|_{A}=\frac{\|T\|_{A}}{2}$.
(ii) The "if" part follows from $w_{A}(T)=\sup _{\theta \in \mathbb{R}}\left\|\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}$, and so we only need to prove the "only if" part. Let $w_{A}(T)=\frac{\|T\|_{A}}{2}$. Clearly $e^{\mathrm{i} \theta} T \in \mathcal{B}_{A}(\mathcal{H})$ for all $\theta \in \mathbb{R}$. Now, $w_{A}\left(e^{\mathrm{i} \theta} T\right)=w_{A}(T)$ and $\left\|e^{\mathrm{i} \theta} T\right\|_{A}=\|T\|_{A}$ for all $\theta \in \mathbb{R}$. Therefore, it follows from (i) that $\left\|\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}=\left\|\Im_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}=\frac{\|T\|_{A}}{2}$ for all $\theta \in \mathbb{R}$.

Our next improvement of the first inequality in (1.2) reads as follows.
Theorem 2.4. If $T \in \mathcal{B}_{A}(\mathcal{H})$, then

$$
w_{A}(T) \geq \sqrt{\frac{1}{4}\left\|T^{\sharp} \sharp_{A} T+T T^{\sharp}\right\|_{A}\left\|_{A}+\frac{1}{2}\left|\left\|\Re_{A}(T)\right\|_{A}^{2}-\left\|\Im_{A}(T)\right\|_{A}^{2}\right|\right.} .
$$

Proof. We have $w_{A}(T) \geq\left\|\Re_{A}(T)\right\|_{A}$ and $w_{A}(T) \geq\left\|\Im_{A}(T)\right\|_{A}$ and so

$$
\begin{aligned}
w_{A}^{2}(T) & \geq \max \left\{\left\|\Re_{A}(T)\right\|_{A}^{2},\left\|\Im_{A}(T)\right\|_{A}^{2}\right\} \\
& =\frac{\left\|\Re_{A}(T)\right\|_{A}^{2}+\left\|\Im_{A}(T)\right\|_{A}^{2}}{2}+\frac{\left\|\Re_{A}(T)\right\|_{A}^{2}-\left\|\Im_{A}(T)\right\|_{A}^{2} \mid}{2} \\
& \geq \frac{\left\|\left(\Re_{A}(T)\right)^{2}\right\|_{A}+\left\|\left(\Im_{A}(T)\right)^{2}\right\|_{A}}{2}+\frac{\left\|\Re_{A}(T)\right\|_{A}^{2}-\left\|\Im_{A}(T)\right\|_{A}^{2} \mid}{2} \\
& \geq \frac{\left\|\left(\Re_{A}(T)\right)^{2}+\left(\Im_{A}(T)\right)^{2}\right\|_{A}}{2}+\frac{\left\|\Re_{A}(T)\right\|_{A}^{2}-\left\|\Im_{A}(T)\right\|_{A}^{2} \mid}{2} \\
& =\frac{1}{4}\left\|T^{\sharp} T+T T^{\sharp}\right\|_{A}+\frac{1}{2}\left|\left\|\Re_{A}(T)\right\|_{A}^{2}-\left\|\Im_{A}(T)\right\|_{A}^{2}\right| .
\end{aligned}
$$

This completes the proof.

Remark 2.5. Clearly, the inequality in Theorem 2.4 is sharper than the first inequality in (1.2), i.e., $w_{A}^{2}(T) \geq \frac{1}{4}\left\|T^{\sharp_{A}} T+T T^{\sharp_{A}}\right\|_{A}$.

Next, we prove an equivalent condition for $w_{A}(T)=\sqrt{\frac{1}{4}\left\|T^{\sharp} A T+T T^{\sharp} A\right\|_{A}}$.
Theorem 2.6. Let $T \in \mathcal{B}_{A}(\mathcal{H})$. Then, $w_{A}(T)=\sqrt{\frac{1}{4}\left\|T^{\sharp} \sharp_{A} T+T T^{\sharp}\right\|_{A}}$ if and only if $\left\|\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}^{2}=\left\|\Im\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}^{2}=\frac{1}{4}\left\|T^{\sharp_{A}} T+T T^{\sharp A}\right\|_{A}$ for all $\theta \in \mathbb{R}$.

Proof. The "if" part is trivial, we only prove the "only if" part. Let $w_{A}^{2}(T)=$ $\frac{1}{4}\left\|T^{\sharp A} T+T T^{\sharp A}\right\|_{A}$. Now, $\left(\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right)^{2}+\left(\Im_{A}\left(e^{\mathrm{i} \theta} T\right)\right)^{2}=\frac{T^{\sharp} A T+T T^{\sharp} A}{2}$ for all $\theta \in \mathbb{R}$. Therefore, we have

$$
\begin{aligned}
\frac{1}{4}\left\|T^{\sharp} A+T T^{\sharp_{A}}\right\|_{A} & =\frac{1}{2}\left\|\left(\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right)^{2}+\left(\Im_{A}\left(e^{\mathrm{i} \theta} T\right)\right)^{2}\right\|_{A} \\
& \leq \frac{1}{2}\left(\left\|\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}^{2}+\left\|\Im_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}^{2}\right) \\
& \leq w_{A}^{2}(T)=\frac{1}{4}\left\|T^{\sharp_{A}} T+T T^{\sharp_{A}}\right\|_{A} .
\end{aligned}
$$

Hence, $\left\|\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}^{2}+\left\|\Im_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}^{2}=\frac{1}{2}\left\|T^{\sharp A} T+T T^{\sharp A}\right\|_{A}$. Now, $\sup _{\theta \in \mathbb{R}}\left\|\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}^{2}=$ $\frac{1}{4}\left\|T^{\sharp} T+T T^{\sharp}\right\|_{A}=\sup _{\theta \in \mathbb{R}}\left\|\Im_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}^{2}$. Therefore, $\left\|\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}^{2}=\left\|\Im_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}^{2}$ $=\frac{1}{4}\left\|T^{\sharp A} T+T T^{\sharp_{A}}\right\|_{A}$ for all $\theta \in \mathbb{R}$.

Now we obtain another characterizations for the equalities $w_{A}(T)=\frac{1}{2}\|T\|_{A}$ and $w_{A}(T)=\sqrt{\frac{1}{4}\left\|T^{\sharp_{A}} T+T T^{\sharp_{A}}\right\|_{A}}$. First we need to prove the following lemma.
Lemma 2.7. Let $T \in \mathcal{B}_{A}(\mathcal{H})$. Then, $\left\|\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}=k$ (i.e., a constant) for all $\theta \in \mathbb{R}$ if and only if $W_{A}(T)$ is a circular disk with center at the origin and radius $k$.

Proof. The "if" part is trivial, we only prove the "only if" part. Let $\left\|\Re_{A}\left(e^{\mathrm{i} \theta} T\right)\right\|_{A}$ $=k$ for all $\theta \in \mathbb{R}$. Then, $\sup _{\|x\|_{A}=1}\left|\left\langle\Re_{A}\left(e^{\mathrm{i} \theta} T\right) x, x\right\rangle_{A}\right|=k$ for all $\theta \in \mathbb{R}$, i.e., $\sup _{\|x\|_{A}=1}\left|\operatorname{Re}\left(e^{\mathrm{i} \theta}\langle T x, x\rangle_{A}\right)\right|=k$ for all $\theta \in \mathbb{R}$. Thus, for each $\theta \in \mathbb{R}$, there exists a sequence $\left\{x_{n}^{\theta}\right\} \subseteq \mathcal{H}$ with $\left\|x_{n}^{\theta}\right\|_{A}=1$ such that $\left|\operatorname{Re}\left(e^{\mathrm{i} \theta}\left\langle T x_{n}^{\theta}, x_{n}^{\theta}\right\rangle_{A}\right)\right| \rightarrow k$. This implies that the boundary of $W_{A}(T)$ must be a circle with center at the origin and radius $k$. Since $W_{A}(T)$ is a convex subset of $\mathbb{C}$ (see in [2, Th. 2.1]), so $W_{A}(T)$ is a circular disk with center at the origin and radius $k$.

Theorem 2.8. Let $T \in \mathcal{B}_{A}(\mathcal{H})$. Then, the following results hold.
(i) $w_{A}(T)=\frac{1}{2}\|T\|_{A}$ if and only if $W_{A}(T)$ is a circular disk with center at the origin and radius $\frac{1}{2}\|T\|_{A}$.
(ii) $w_{A}(T)=\sqrt{\frac{1}{4}\left\|T^{\sharp_{A}} T+T T^{\sharp_{A}}\right\|_{A}}$ if and only if $W_{A}(T)$ is a circular disk with center at the origin and radius $\sqrt{\frac{1}{4}\left\|T^{\sharp_{A}} T+T T^{\sharp_{A}}\right\|_{A}}$.

Proof. The proof of (i) and (ii) follow from Theorems 2.3 and 2.6, respectively, by using Lemma 2.7.

Another improvement of the first inequality in (1.1) reads as:

Theorem 2.9. If $T \in \mathcal{B}_{A}(\mathcal{H})$, then

$$
w_{A}(T) \geq \frac{\|T\|_{A}}{2}+\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}\right|}{2 \sqrt{2}} .
$$

Proof. Let $x \in \mathcal{H}$ with $\|x\|_{A}=1$. Then, we have

$$
\begin{aligned}
\left|\langle T x, x\rangle_{A}\right| & =\sqrt{\left|\left\langle\Re_{A}(T) x, x\right\rangle_{A}\right|^{2}+\left|\left\langle\Im_{A}(T) x, x\right\rangle_{A}\right|^{2}} \\
& \geq \frac{1}{\sqrt{2}}\left(\left|\left\langle\Re_{A}(T) x, x\right\rangle_{A}\right|+\left|\left\langle\Im_{A}(T) x, x\right\rangle\right|\right) \\
& \geq \frac{1}{\sqrt{2}}\left|\left\langle\left(\Re_{A}(T) \pm \Im_{A}(T)\right) x, x\right\rangle_{A}\right| .
\end{aligned}
$$

Taking supremum over $\|x\|_{A}=1$, we get

$$
w_{A}(T) \geq \frac{1}{\sqrt{2}}\left\|\Re_{A}(T) \pm \Im_{A}(T)\right\|_{A}
$$

Therefore, we have

$$
\begin{aligned}
w_{A}(T) \geq & \frac{1}{\sqrt{2}} \max \left\{\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A},\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}\right\} \\
= & \frac{1}{\sqrt{2}}\left\{\frac{\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}+\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}}{2}\right. \\
& \left.+\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}\right|}{2}\right\} \\
\geq & \frac{1}{\sqrt{2}}\left\{\frac{\left\|\left(\Re_{A}(T)+\Im_{A}(T)\right)-\mathrm{i}\left(\Re_{\mathrm{A}}(\mathrm{~T})-\Im_{\mathrm{A}}(\mathrm{~T})\right)\right\|_{\mathrm{A}}}{2}\right. \\
& \left.+\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}\right|}{2}\right\} \\
= & \frac{1}{\sqrt{2}}\left\{\frac{\|(1-\mathrm{i}) \mathrm{T}\|_{\mathrm{A}}}{2}+\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}\right|}{2}\right\} \\
= & \frac{\|T\|_{A}}{2}+\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}\right|}{2 \sqrt{2}},
\end{aligned}
$$

as desired.
Remark 2.10. (i) Clearly, the inequality in Theorem 2.9 is sharper than the first inequality in (1.1), i.e., $w_{A}(T) \geq \frac{\|T\|_{A}}{2}$.
(ii) The inequalities obtained in Theorem 2.1 and Theorem 2.9 are not comparable, in general.

Another refinement of the first inequality in (1.2) reads as follows:
Theorem 2.11. If $T \in \mathcal{B}_{A}(\mathcal{H})$, then

$$
w_{A}(T) \geq \sqrt{\frac{\left\|T^{\sharp} T+T T^{\sharp}\right\|_{A}}{4} \|_{A}}+\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}^{2}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}^{2}\right|}{4} .
$$

Proof. Following the proof of Theorem 2.9, we have

$$
\begin{aligned}
w_{A}^{2}(T) \geq & \frac{1}{2} \max \left\{\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}^{2},\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}^{2}\right\} \\
= & \frac{1}{2}\left\{\frac{\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}^{2}+\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}^{2}}{2}\right. \\
& \left.+\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}^{2}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}^{2}\right|}{2}\right\} \\
\geq & \frac{1}{2}\left\{\frac{\left\|\left(\Re_{A}(T)+\Im_{A}(T)\right)^{2}+\left(\Re_{A}(T)-\Im_{A}(T)\right)^{2}\right\|_{A}}{2}\right. \\
& \left.+\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}^{2}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}^{2}\right|}{2}\right\} \\
= & \frac{\left\|T^{\sharp A} T+T T^{\sharp A}\right\|_{A}}{4}+\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}^{2}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}^{2}\right|}{4} .
\end{aligned}
$$

This completes the proof.

Remark 2.12. (i) Clearly, the inequality in Theorem 2.11 is sharper than the first inequality in (1.2), i.e., $w_{A}^{2}(T) \geq \frac{1}{4}\left\|T^{\sharp_{A}} T+T T^{\sharp_{A}}\right\|_{A}$.
(ii) The inequalities obtained in Theorem 2.4 and Theorem 2.11 are not comparable, in general.

## 3. Applications

In this section we obtain new inequalities for the $A$-numerical radius of the generalized commutators of operators by applying Theorems 2.4 and 2.11. First we prove the following lemma.

Lemma 3.1. If $T, X, Y \in \mathcal{B}_{A}(\mathcal{H})$, then

$$
w_{A}(T X \pm Y T) \leq \max \left\{\|X\|_{A},\|Y\|_{A}\right\} \sqrt{2\left\|T^{\sharp_{A}} T+T T^{\sharp}\right\|_{A}} .
$$

Proof. Let $x \in \mathcal{H}$ with $\|x\|_{A}=1$ and $\max \left\{\|X\|_{A},\|Y\|_{A}\right\} \leq 1$. Then by Cauchy Schwarz inequality, we get

$$
\begin{aligned}
\left|\langle(T X \pm Y T) x, x\rangle_{A}\right| & \leq\left|\left\langle X x, T^{\sharp A} x\right\rangle_{A}\right|+\left|\left\langle T x, Y^{\sharp_{A}} x\right\rangle_{A}\right| \\
& \leq\left\|T^{\sharp_{A}} x\right\|+\|T x\| \\
& \leq \sqrt{2}\left(\left\|T^{\sharp A} x\right\|_{A}^{2}+\|T x\|_{A}^{2}\right)^{\frac{1}{2}} \\
& \leq \sqrt{2}\left\|T^{\sharp_{A}} T+T T^{\sharp A}\right\|_{A}^{\frac{1}{2}} .
\end{aligned}
$$

Therefore, taking supremum over $\|x\|_{A}=1$, we get

$$
w_{A}(T X \pm Y T) \leq \sqrt{2\left\|T^{\sharp_{A}} T+T T^{\sharp_{A}}\right\|_{A}} .
$$

If $X, Y \in \mathcal{B}_{A}(\mathcal{H})$ are arbitrary with $\max \left\{\|X\|_{A},\|Y\|_{A}\right\} \neq 0$, then it follows from the above inequality that

$$
w_{A}(T X \pm Y T) \leq \max \left\{\|X\|_{A},\|Y\|_{A}\right\} \sqrt{2 \| T^{\sharp} A} T+T T^{\sharp} \|_{A} .
$$

Also, if $\max \left\{\|X\|_{A},\|Y\|_{A}\right\}=0$, then the above inequality holds trivially. This completes the proof.

Theorem 3.2. If $T, X, Y \in \mathcal{B}_{A}(\mathcal{H})$, then
(i) $w_{A}(T X \pm Y T) \leq 2 \sqrt{2} \max \left\{\|X\|_{A},\|Y\|_{A}\right\} \sqrt{w_{A}^{2}(T)-\frac{\left|\left\|\Re_{A}(T)\right\|_{A}^{2}-\left\|\Im_{A}(T)\right\|_{A}^{2}\right|}{2}}$.
and
(ii) $w_{A}(T X \pm Y T)$
$\leq 2 \sqrt{2} \max \left\{\|X\|_{A},\|Y\|_{A}\right\} \sqrt{w_{A}^{2}(T)-\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}^{2}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}^{2}\right|}{4}}$.
Proof. By applying the inequalities in Theorem 2.4 and Theorem 2.11 in Lemma 3.1, we have (i) and (ii), respectively.

It should be mentioned here that the inequalities (i) and (ii) in Theorem 3.2 are not comparable, in general.

Considering $X=Y=S$ in Theorem 3.2, we get the following corollary.

Corollary 3.3. If $T, S \in \mathcal{B}_{A}(\mathcal{H})$, then
(i) $w_{A}(T S \pm S T) \leq 2 \sqrt{2}\|S\|_{A} \sqrt{w_{A}^{2}(T)-\frac{\left|\left\|\Re_{A}(T)\right\|_{A}^{2}-\left\|\Im_{A}(T)\right\|_{A}^{2}\right|}{2}}$.
and
(ii) $\quad w_{A}(T S \pm S T)$

$$
\leq 2 \sqrt{2}\|S\|_{A} \sqrt{w_{A}^{2}(T)-\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}^{2}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}^{2}\right|}{4}}
$$

Now, interchanging $T$ and $S$ in Corollary 3.3 (i), we get

$$
\begin{equation*}
w_{A}(T S \pm S T) \leq 2 \sqrt{2} \min \left\{\alpha_{1}, \alpha_{2}\right\} \tag{3.1}
\end{equation*}
$$

where

$$
\begin{aligned}
& \alpha_{1}=\|S\|_{A} \sqrt{w_{A}^{2}(T)-\frac{\left|\left\|\Re_{A}(T)\right\|_{A}^{2}-\left\|\Im_{A}(T)\right\|_{A}^{2}\right|}{2}} \\
& \alpha_{2}=\|T\|_{A} \sqrt{w_{A}^{2}(S)-\frac{\left|\left\|\Re_{A}(S)\right\|_{A}^{2}-\left\|\Im_{A}(S)\right\|_{A}^{2}\right|}{2}}
\end{aligned}
$$

Also, interchanging $T$ and $S$ in Corollary 3.3 (ii), we get

$$
\begin{equation*}
w_{A}(T S \pm S T) \leq 2 \sqrt{2} \min \left\{\beta_{1}, \beta_{2}\right\} \tag{3.2}
\end{equation*}
$$

where

$$
\begin{aligned}
& \beta_{1}=\|S\|_{A} \sqrt{w_{A}^{2}(T)-\frac{\left|\left\|\Re_{A}(T)+\Im_{A}(T)\right\|_{A}^{2}-\left\|\Re_{A}(T)-\Im_{A}(T)\right\|_{A}^{2}\right|}{4}} \\
& \beta_{2}=\|T\|_{A} \sqrt{w_{A}^{2}(S)-\frac{\left|\left\|\Re_{A}(S)+\Im_{A}(S)\right\|_{A}^{2}-\left\|\Re_{A}(S)-\Im_{A}(S)\right\|_{A}^{2}\right|}{4}}
\end{aligned}
$$

Remark 3.4. In [15, Th. 4.2], Zamani proved that if $T, S \in \mathcal{B}_{A}(\mathcal{H})$, then

$$
w_{A}(T S \pm S T) \leq 2 \sqrt{2} \min \left\{\|T\|_{A} w_{A}(S),\|S\|_{A} w_{A}(T)\right\}
$$

Clearly, both the inequalities in (3.1) and (3.2) are stronger than the inequality in [15, Th. 4.2].
