TOEPLITZ OPERATORS ON THE FOCK SPACE WITH QUASI-RADIAL SYMBOLS

ABSTRACT. The Fock space $\mathcal{F}(\mathbb{C}^n)$ is the space of holomorphic functions on \mathbb{C}^n that are squareintegrable with respect to the Gaussian measure on \mathbb{C}^n . This space plays an important role in several subfields of analysis and representation theory. In particular, it has for a long time been a model to study Toeplitz operators. Esmeral and Maximenko showed in 2016 that radial Toeplitz operators on $\mathcal{F}(\mathbb{C})$ generate a commutative C^* -algebra which is isometrically isomorphic to the C^* -algebra $C_{b,u}(\mathbb{N}_0, \rho_1)$. In this article, we extend the result to k-quasi-radial symbols acting on the Fock space $\mathcal{F}(\mathbb{C}^n)$. We calculate the spectra of the said Toeplitz operators and show that the set of all eigenvalue functions is dense in the C^* -algebra $C_{b,u}(\mathbb{N}_0^k, \rho_k)$ of bounded functions on \mathbb{N}_0^k which are uniformly continuous with respect to the square-root metric. In fact, the C^* -algebra generated by Toeplitz operators with quasi-radial symbols is $C_{b,u}(\mathbb{N}_0^k, \rho_k)$.

1. INTRODUCTION

Reproducing kernel Hilbert spaces \mathcal{H} of square integrable holomorphic functions on complex domains plays an important role in several subfields of analysis and representation theory [B61].

Those spaces lead to a very simple form of quantization, [B75a, B75b, EU10, EU11] turning functions into bounded operators on \mathcal{H} , by using Toeplitz operators $T_{\varphi}(f) = P(\varphi f)$, where P is the orthogonal projection onto \mathcal{H} . These operators have been studied for a long time, [BC86, BI12, BL11, BS06, C94].

Since the fundamental work [GV02, GQV06], and then later several authors have studied C^* algebras generated by subclasses of bounded symbols asking the question which of them lead to *commutative* C^* -algebras as in [DÓQ15, DÓQ18, DÓQ21, DQ18, EM16, GMV13, GKV03, QS11, QV07a, QV07b, QV08, V08]. In the case of commutative C^* -algebras, the next natural question is to determine the spectrum and, if possible, determine the Gelfand transform. This is often achieved by constructing a transform that maps Toeplitz operators to multiplier operators on an L^2 space.

In the special case of the unit ball in \mathbb{C}^n , it was shown that Toeplitz operators with radial symbols acting on the Bergman space generate a commutative C^* -algebra as in [GKV03] and the corresponding C^* -algebra is isometrically isomorphic to the space of bounded sequences that are uniformly continuous with respect to the logarithmic metric [GMV13]. Toeplitz operators with radial symbols on the Fock space $\mathcal{F}(\mathbb{C})$ generate a commutative C^* -algebra [GV02] which is isometrically isomorphic to the C^* -algebra $C_{b,u}(\mathbb{N}_0, \rho_1)$ of bounded sequences that are uniformly continuous with respect to the square-root metric [EM16]. Furthermore, a more general theory for weighted Bergman spaces on any bounded symmetric domain was formulated in [DÓQ15], using representation theory.

In this paper, we consider the C^* -algebra generated by Toeplitz operators with k-quasi-radial symbols, discussed in [BV12, MSR16, V10a, V10b, QS14, QS15], acting on the Fock space $\mathcal{F}(\mathbb{C}^n)$. As an instance of the general theory discussed in [DÓQ15], the generated C^* -algebra is commutative. We compute the eigenvalue functions of Toeplitz operators with quasi-radial symbols and then show that they are dense in the space $C_{b,u}(\mathbb{N}^k_0, \rho_k)$ of bounded functions on \mathbb{N}^k_0 that are uniformly continuous with respect to the square-root metric. As a consequence, the C^* -algebra generated by Toeplitz operators with k-quasi-radial symbols is isometrically isomorphic to the C^* -algebra

We now introduce some notations and recall the following well known facts about the Fock space. Denote by $d\lambda_n$ the Gaussian measure $d\lambda_n(z) = \frac{1}{\pi^n} e^{-|z|^2} dz$ for $z \in \mathbb{C}^n$, where dz is the Lebesgue measure on $\mathbb{C}^n \simeq \mathbb{R}^{2n}$. The Fock space $\mathcal{F}(\mathbb{C}^n)$ is the Hilbert space of all holomorphic functions on \mathbb{C}^n that are square integrable with respect to $d\lambda_n$,

$$\mathcal{F}(\mathbb{C}^n) = L^2(\mathbb{C}^n, \lambda_n) \cap \mathcal{O}(\mathbb{C}^n).$$

The point-evalutation maps $f \mapsto f(z)$ are continuous and hence $\mathcal{F}(\mathbb{C}^n)$ is a reproducing kernel Hilbert space with the reproducing kernel K given by $K(w, z) = K_z(w) = e^{w\overline{z}}$, for $(z, w) \in \mathbb{C}^{2n}$ (here $\overline{z}w$ denotes the scalar product $w_1\overline{z}_1 + \cdots + w_k\overline{z}_k$). Thus for $z \in \mathbb{C}^n$ and $f \in \mathcal{F}(\mathbb{C}^n)$ we have

$$f(z) = \langle f, K_z \rangle$$

with the inner product of $L^2(\mathbb{C}^n, \lambda_n)$.

The Bergman projection $P: L^2(\mathbb{C}^n) \to \mathcal{F}(\mathbb{C}^n)$ is given by

$$Pf(z) = \langle f, K_z \rangle.$$

P is a bounded linear operator with ||P|| = 1.

Given $\varphi \in L^{\infty}(\mathbb{C}^n)$, we define the Toeplitz operator $T_{\varphi} : \mathcal{F}(\mathbb{C}^n) \to \mathcal{F}(\mathbb{C}^n)$ by

$$T_{\varphi}f(z) = P(\varphi f)(z) = \int_{\mathbb{C}^n} \varphi(w)f(w)\overline{K_z(w)}d\lambda_n(w).$$

As the multiplier operator $M_{\varphi} : L^2(\mathbb{C}^n, \lambda) \to L^2(\mathbb{C}^n, \lambda)$ is bounded of norm $\|\varphi\|_{\infty}$ and P is bounded, it follows that T_{φ} is bounded and $\|T_{\varphi}\| \leq \|\varphi\|_{\infty}$. The function φ is called the symbol of the Toeplitz operator T_{φ} . Grudsky and Vasilevski [GV02] showed that the eigenvalue sequences of radial Toeplitz operators on $\mathcal{F}(\mathbb{C})$ are of the form

$$\gamma_{1,a}(m) = \frac{1}{m!} \int_0^\infty a(\sqrt{r}) r^m e^{-r} dr.$$

We prove that the Toeplitz operators with k-quasi-radial symbols diagonalize with eigenvalue functions given by

$$\gamma_{\boldsymbol{n},a}(\boldsymbol{m}) = \frac{1}{(\boldsymbol{m}+\boldsymbol{n}-\boldsymbol{1})!} \int_{\mathbb{R}^k_+} a(\sqrt{r_1},\ldots,\sqrt{r_k}) r^{\boldsymbol{m}+\boldsymbol{n}-\boldsymbol{1}} e^{-(r_1+\cdots+r_k)} dr$$

for any $\boldsymbol{m} \in \mathbb{N}_0^k$, where $\boldsymbol{n} = (n_1, \ldots, n_k)$.

As a corollary the eigenvalue sequences of radial Toeplitz operators on $\mathcal{F}(\mathbb{C}^n)$ are of the form

$$\gamma_{n,a}(m) = \frac{1}{(m+n-1)!} \int_0^\infty a(\sqrt{r}) r^{m+n-1} e^{-r} dr$$

which are the $(n-1)^{\text{th}}$ left shift of $\gamma_{1,a}$.

To prove eigenvalue function of Toeplitz operators with k-quasi-radial symbols is dense in the C^* -algebra $C_{b,u}(\mathbb{N}^k_0, \rho_k)$, we follow some of the ideas in the work by Esmeral and Maximenko [EM16].

2. Toeplitz operators with bounded k-quasi-radial symbols

In this section, we introduce quasi-radial symbols and diagonalize the Toeplitz operators with quasi-radial symbols.

We begin with some notations. Let $k \in \mathbb{N}$ and let $\mathbf{n} = \mathbf{n}(k) = (n_1, \ldots, n_k) \in \mathbb{N}^k$ and let $n = n_1 + \cdots + n_k$. Let $\mathbb{C}^n = \mathbb{C}^{n_1} \times \cdots \times \mathbb{C}^{n_k}$. We identify $z \in \mathbb{C}^n$ by $z = (z_{(1)}, \cdots, z_{(k)}) \in \mathbb{C}^n$ where $z_{(j)} \in \mathbb{C}^{n_j}$. Consider the group $G = \bigcup_{n_1} \times \cdots \times \bigcup_{n_k}$ where $\bigcup_{n_i} \text{ are } n_i \times n_i$ unitary matrices. They act on f defined on \mathbb{C}^n by $(A_1, \ldots, A_k)f(z) = (A_1, \ldots, A_k)f(z_{(1)}, \cdots, z_{(k)}) := f(A_1^{-1}z_{(1)}, \ldots, A_k^{-1}z_{(k)})$ which is the usual action of matrices we get by considering G as a subgroup of \bigcup_n . The action leaves the Gaussian measure $d\lambda_n(z) = d\lambda_{n_1}(z_{(1)}) \ldots d\lambda_{n_k}(z_{(k)})$ invariant.

Definition 2.1. Let $\varphi : \mathbb{C}^n \to \mathbb{C}$ be measurable. The function φ is said to be *G*-invariant if for all $(A_1, \ldots A_k) \in G$ and $z \in \mathbb{C}^n$ we have $(A_1, \ldots A_k)\varphi(z) = \varphi(A_1^{-1}z_{(1)}, \ldots A_k^{-1}z_{(k)}) = \varphi(z)$.

Define the set of all k-quasi-radial symbols, denoted by $L^{\infty}(\mathbb{C}^n)^G$, to be the set of all essentially bounded functions on \mathbb{C}^n that are G-invariant. The case k = 1 corresponds to radial symbols and the case n = k corresponds to separately radial symbols. Now we take into consideration the C^* -algebra \mathcal{T}_G generated by Toeplitz operators with symbols in $L^{\infty}(\mathbb{C}^n)^G$. The main objective of this section is to diagonalize the Toeplitz operators with symbols in $L^{\infty}(\mathbb{C}^n)^G$.

2.1. A classification of the class of symbols $L^{\infty}(\mathbb{C}^n)^G$.

Definition 2.2. Let $\varphi : \mathbb{C}^q \to \mathbb{C}$ be measurable. The function φ is said to be,

- (1) radial if there exists a measurable function $a_{\varphi} : \mathbb{R}_+ \to \mathbb{C}$ such that $\varphi(z) = a_{\varphi}(|z|)$ for $z \neq 0$.
- (2) U_q -invariant if for all $A \in U_q$ and $z \in \mathbb{C}^q$ we have $\varphi(Az) = \varphi(z)$.

Following lemma is a well-known fact.

Lemma 2.3. The measurable function $\varphi : \mathbb{C}^q \to \mathbb{C}$ is U_q -invariant if and only if there exists $a : \mathbb{R}_+ \to \mathbb{C}$ such that $\varphi(z) = a(|z|)$.

Proof. As |Az| = |z| for $A \in U_q$, it follows that any function of the form $\varphi(z) = a(|z|)$ is U_q -invariant. As $z \mapsto |z|$ is continuous it follows that φ is measurable if and only if a is measurable.

Assume that φ is U_q -invariant. Define $a_{\varphi}(r) = \varphi(re_1)$. Then a_{φ} is measurable. Let $z \in \mathbb{C}^q$. Then, as U_q acts transitively on the sphere S^{2q-1} , there exist $A \in U_q$ such that $Az = |z|e_1$. Thus

$$\varphi(z) = \varphi(Az) = \varphi(|z|e_1) = a_{\varphi}(|z|).$$

Thus $\varphi(z) = a_{\varphi}(|z|).$

The following lemma is a consequence of Lemma 2.3.

Lemma 2.4. The measurable function $\varphi : \mathbb{C}^n \to \mathbb{C}$ is *G*-invariant if and only if there exists $a : \mathbb{R}^k_+ \to \mathbb{C}$ such that $\varphi(z) = a(|z_{(1)}|, \ldots, |z_{(k)}|).$

2.2. Diagonalization by Schur's lemma. Let π and σ be unitary representations of a topological group H. A continuous linear map $T : V_{\pi} \to V_{\sigma}$ is an *intertwining operator* if for all $A \in H$ commutating relation $T\pi(A) = \sigma(A)T$ holds. π and σ are equivalent if there exists an unitary isomorphism that intertwines π and σ . Finally if π is irreducible and T is an intertwining operator then Schur's lemma says that $T = \lambda$ id for some $\lambda \in \mathbb{C}$.

Since the action of G is defined by the action of U_{n_i} on $\mathcal{F}^2(\mathbb{C}^{n_i}), i = 1, \ldots, k$, first we consider the action of U_q on $\mathcal{F}^2(\mathbb{C}^q), q \in \mathbb{N}$.

Denote by $P^m[\mathbb{C}^q]$ the space of homogeneous holomorphic polynomials on \mathbb{C}^q of degree m. Note that the space of holomorphic polynomials is dense in $\mathcal{F}(\mathbb{C}^q)$ and any holomorphic polynomial can be written in a unique way as a direct sum of homogeneous polynomials. In fact the following is well known and can be found in [Z12].

Lemma 2.5. For $\alpha \in \mathbb{N}^q$ let $p_{\alpha}(z) = z_1^{\alpha_1} \cdots z_q^{\alpha_q}$. Then $\|p_{\alpha}\|_{\mathcal{F}}^2 = \alpha! = \alpha_1! \dots \alpha_q!$

and the collection

$$\{q_{\alpha} = \frac{1}{\sqrt{\alpha!}} p_{\alpha}\}_{\alpha \in \mathbb{N}^q}$$

forms an orthonormal basis for $\mathcal{F}(\mathbb{C}^q)$.

 U_q acts on functions on \mathbb{C}^q by $Af(z) = f(A^{-1}z)$. This action leaves $\mathcal{F}(\mathbb{C}^q)$ invariant and, as the measure λ_q is U_q -invariant, it is a unitary representation denoted by π^q . This representation is reducible. In fact this representation leaves the spaces $\mathbb{P}^m[\mathbb{C}^q]$ invariant. We denote the corresponding representation by π_m^q . The representation π_m^q is irreducible. The torus Tid is the center of U_q and acts by the character $z \mapsto z^{-m}$ id. The representations π_m^q and π_k^q are inequivalent if $m \neq k$ as can easily be seen as the action of the center is different. The same conclusion follows from the fact that $d_m = \dim_{\mathbb{C}} \mathbb{P}^m[\mathbb{C}^q] \neq d_k$ if $m \neq k$ for q > 1 and $d_m = 1$ for q = 1. The decomposition of $\mathcal{F}(\mathbb{C}^q)$ in irreducible U_q representations is given by $\mathcal{F}(\mathbb{C}^q) = \bigoplus_{m=0}^{\infty} \mathbb{P}^m[\mathbb{C}^q]$.

Definition 2.6. Let π^{n_i} be the unitary representations of U_{n_i} , acting on $\mathcal{F}(\mathbb{C}^{n_i})$, $i = 1, \ldots, k$, as in the above discussion. The outer tensor product of the representations π_{p_i} , denoted $\pi^{n_1} \otimes \cdots \otimes \pi^{n_k}$ is defined by

$$\pi^{n_1} \otimes \cdots \otimes \pi^{n_k}(A_1, \dots A_k) = \pi^{n_1}(A_1) \otimes \cdots \otimes \pi^{n_k}(A_k)$$

for all $(A_1, \ldots, A_k) \in U_{n_1} \times \cdots \times U_{n_k} = G$. Here $\pi^{n_1}(A_1) \otimes \cdots \otimes \pi^{n_k}(A_k)$ is the tensor product of the operators $\pi^{n_i}(A_i)$ acting on the Hilbert spaces $\mathcal{F}(\mathbb{C}^{n_i})$.

The outer tensor product $\pi^{n_1} \otimes \cdots \otimes \pi^{n_k}$ is a unitary representation of G acting on $\mathcal{F}(\mathbb{C}^{n_1}) \otimes \cdots \otimes \mathcal{F}(\mathbb{C}^{n_k}) = \mathcal{F}(\mathbb{C}^n)$. For more details see [FÓ14].

Lemma 2.7. Let $\varphi \in L^{\infty}(\mathbb{C}^n)^G$. Then T_{φ} intertwines with $\pi^{n_1} \otimes \cdots \otimes \pi^{n_k}$.

Proof. Let $A_i \in U_{n_i}$ and $f_i \in \mathcal{F}(\mathbb{C}^{n_i}), i = 1, \ldots, m$. Notice that

$$\begin{split} &\Gamma_{\varphi}(\pi^{n_1}\otimes\cdots\otimes\pi^{n_k})(A_1,\ldots A_k)f_1\otimes\cdots\otimes f_k(z)=T_{\varphi}f(A_1^{-1}z_{(1)},\ldots,A_k^{-1}z_{(k)})\\ &=\int_{\mathbb{C}^n}\varphi(w)f(A_1^{-1}z_{(1)})\cdots f(A_k^{-1}z_{(k)})\overline{k_z(w)}d\lambda_n(w)\\ &=\int_{\mathbb{C}^n}\varphi(A_1w_{(1)},\ldots A_kw_{(k)})f_1\otimes\cdots\otimes f_k(w)\overline{k_z(A_1w_{(1)},\ldots A_kw_{(k)})}d\lambda_n(w)\\ &\text{(by the change of variable }(w_{(1)},\ldots w_{(k)})\to (A_1w_{(1)},\ldots,A_kw_{(k)})). \end{split}$$

Since

$$k_{z}(A_{1}w_{(1)}, \dots A_{k}w_{(k)}) = e^{A_{1}w_{(1)}\overline{z_{(1)}} + \dots + A_{k}w_{(k)}\overline{z_{(k)}}}$$

= $e^{w_{(1)}\overline{(A^{*}z_{(1)})} + \dots + w_{(k)}\overline{A_{k}^{*}z_{(k)}}}$
= $e^{w_{(1)}\overline{(A^{-1}z_{(1)})} + \dots + w_{(k)}\overline{A_{k}^{-1}z_{(k)}}}$ (as A_{i} are unitary)
= $k_{(A_{1}^{-1}z_{(1)},\dots A_{k}^{-1}z_{(k)})}(w)$

and φ is *G*-invariant,

$$T_{\varphi}(\pi^{n_1} \times \dots \times \pi^{n_k})(A_1, \dots A_k)f_1 \otimes \dots \otimes f_k(z)$$

= $\int_{\mathbb{C}^n} \varphi(w)f_1 \otimes \dots \otimes f_k(w)\overline{k_{(A_1^{-1}z_{(1)},\dots A_k^{-1}z_{(k)})}(w)}d\lambda_n(w)$
= $(\pi^{n_1} \otimes \dots \otimes \pi^{n_k})(A_1, \dots A_k)T_{\varphi}f(z).$

Since the tensor product of irreducible representations is irreducible (see Proposition 6.75 in [FÓ14] for a proof), $\mathcal{F}(\mathbb{C}^n)$ can be decomposed by irreducible sub-representations of $\pi^{n_1} \otimes \cdots \otimes \pi^{n_k}$ as

$$\mathcal{F}(\mathbb{C}^n) = \bigoplus_{m_1,\dots,m_k=0}^{\infty} \mathbb{P}^{m_1}[\mathbb{C}^{n_1}] \otimes \dots \otimes \mathbb{P}^{m_k}[\mathbb{C}^{n_k}].$$

Hence if $\varphi \in L^{\infty}(\mathbb{C}^n)^G$, $T_{\varphi}|_{\mathbb{P}^{m_1}[\mathbb{C}^{n_1}]\otimes\cdots\otimes\mathbb{P}^{m_k}[\mathbb{C}^{n_k}]} = \gamma_{n,\varphi}(\boldsymbol{m})$ id for some $\gamma_{n,\varphi}(\boldsymbol{m}) \in \mathbb{C}$ for all $\boldsymbol{m} = (m_1, \ldots, m_k) \in \mathbb{N}_0^k$ by Schur's lemma.

As a consequence of Lemma 2.4, we identify the class of symbols $L^{\infty}(\mathbb{C}^n)^G$ with essentially bounded functions $a : \mathbb{R}^k_+ \to \mathbb{C}$ and denote the corresponding Toeplitz operator and its spectrum by $T_{n,a}$ and $\gamma_{n,a}$.

Since the above decomposition of $\mathcal{F}(\mathbb{C}^n)$ is multiplicity free and G is compact, the set of all operators that intertwine with $\pi^{n_1} \otimes \cdots \otimes \pi^{n_k}$, denoted $\operatorname{End}_G(\mathcal{F}(\mathbb{C}^n))$, is commutative (see in particular Proposition 4.1 and Theorem 6.4 in [DÓQ15] for more details). Then as a consequence of Lemma 2.7 we have the following corollary.

Corollary 2.8. The C^* -algebra generated by Toeplitz operators with G-invariant symbols is commutative.

2.3. Computing eigenvalue functions. We denote by $S^q = \{x \in \mathbb{R}^{q+1} \mid |x| = 1\}$ the q-dimensional sphere in \mathbb{R}^{q+1} . We denote by σ the unique U_{q+1} -invariant measure on S^q that satisfy the polar coordinates formula given by

$$\int_{\mathbb{R}^{q+1}} f(x) dx = \int_0^\infty \int_{\mathcal{S}^q} f(r\omega) d\sigma(\omega) r^q dr$$

for any $f \in L^1(\mathbb{R}^{q+1}, dx)$ where dx is the Lebesgue measure on \mathbb{R}^{q+1} . See section 2.7 in [F99] for more details.

Lemma 2.9. Let $f \in L^1(\mathbb{C}^q, dz)$. Then

$$\int_{\mathbb{C}^q} f(z)dz = \int_0^\infty \int_{S^{2q-1}} f(r\omega)d\sigma(\omega)r^{2q-1}dr.$$

In particular if f(z) = a(r) is U(q)-invariant then

$$\int_{\mathbb{C}^q} f(z)dz = \sigma(\mathbf{S}^{2q-1}) \int_0^\infty a(r)r^{2q-1}dr.$$

We recall the following well known fact:

Lemma 2.10. Let $f, g \in \mathcal{F}^2(\mathbb{C}^q)$ and $\varphi \in L^\infty(\mathbb{C}^q)$. Then

$$\langle T_{\varphi}f,g\rangle = \langle \varphi f,g\rangle = \frac{1}{\pi^q} \int_{\mathbb{C}^q} \varphi(z)f(z)\overline{g(z)}e^{-|z|^2}dz.$$

In particular for $f = g = p_{\alpha}$ we get

$$\langle T_{\varphi} p_{\alpha}, p_{\alpha} \rangle = \frac{1}{\pi^q} \int_{\mathbb{C}^q} \varphi(z) \prod_{j=1}^n |z_j|^{2\alpha_j} e^{-|z_j|^2} dz_1 \cdots dz_n.$$

Proof. Let $P: L^2(\mathbb{C}^q) \to \mathcal{F}^2(\mathbb{C}^q)$ be the orthogonal projection. Then, as $g \in \mathcal{F}^2(\mathbb{C}^q)$, we get

$$\langle T_{\varphi}f,g\rangle = \langle P(\varphi f),g\rangle = \langle \varphi f,g\rangle.$$

The following is well known and can be found for more general situations in [FK94] and other places. We also point to [F01] for a general discussion on how to integrate polynomials over spheres:

Lemma 2.11. Let $p_{\alpha} \in \mathbb{P}^m(\mathbb{C}^q)$. Then $\|p_{\alpha}|_{S^{2q-1}}\|^2 = \frac{2\pi^q}{\Gamma(q+m)} \|p_{\alpha}\|_{\mathcal{F}}^2$. In particular $||q_{\alpha}|_{\mathbf{S}^{2q-1}}||^2 = \frac{2\pi^q}{\Gamma(q+m)}.$

Proof. We have $p_{\alpha}(r\omega) = r^m p(\omega), r > 0$. Hence:

$$\begin{split} \|p_{\alpha}\|_{\mathcal{F}}^{2} &= \frac{1}{\pi^{q}} \int_{0}^{\infty} \int_{\mathbf{S}^{2q-1}} |p_{\alpha}(r\omega)|^{2} d\sigma(\omega) e^{-r^{2}} r^{2q-1} dr \\ &= \frac{1}{2\pi^{q}} \left(\int_{\mathbf{S}^{2q-1}} |p_{\alpha}(\omega)|^{2} d\sigma(\omega) \right) \left(\int_{0}^{\infty} r^{2m+2q-2} e^{-r^{2}} (2rdr) \right) \\ &= \frac{1}{2\pi^{q}} \|p_{\alpha}|_{\mathbf{S}^{2q-1}} \|^{2} \int_{0}^{\infty} u^{m+q-1} e^{-u} du \qquad u = r^{2}, \, du = 2rdr \\ &= \frac{1}{2\pi^{q}} \|p_{\alpha}|_{\mathbf{S}^{2q-1}} \|^{2} \Gamma(m+q). \end{split}$$

We recall that the C^{*}-algebra \mathcal{T}_G generated by G-invariant bounded symbols is commutative and acts by scalars on each of the spaces $P^{m_1}[\mathbb{C}^{n_1}] \otimes \cdots \otimes P^{m_k}[\mathbb{C}^{n_k}]$.

Theorem 2.12. Assume $\varphi \in L^{\infty}(\mathbb{C}^n)^G$ let $\boldsymbol{m} = (m_1, \ldots, m_k) \in \mathbb{N}_0^k$. Then (m) id $= \gamma_n a(m)$ id

$$T_{\varphi}|_{\mathrm{P}^{m_1}[\mathbb{C}^{n_1}]\otimes\cdots\otimes\mathrm{P}^{m_k}[\mathbb{C}^{n_k}]}=\gamma_{n,\varphi}(\boldsymbol{m})\mathrm{Id}=\gamma_{n,a}(\boldsymbol{m})\mathrm{Id}$$

where

$$\gamma_{\boldsymbol{n},\boldsymbol{a}}(\boldsymbol{m}) = \frac{1}{(\boldsymbol{m}+\boldsymbol{n}-\boldsymbol{1})!} \int_{\mathbb{R}^k_+} a_{\varphi}(\sqrt{\boldsymbol{r}}) \boldsymbol{r}^{\boldsymbol{m}+\boldsymbol{n}-\boldsymbol{1}} e^{-(r_1+\cdots+r_k)} dr_1 \dots dr_k.$$

where we use the notations $\sqrt{\mathbf{r}} = (\sqrt{r_1}, \dots, \sqrt{r_k})$ and $\mathbf{1} = (1, \dots, 1) \in \mathbb{N}^k$.

Proof. Assume that $\varphi(z) = a(|z_{(1)}|, \ldots, |z_{(k)}|) = a(r_1, \ldots, r_k)$. Let $\alpha_j \in \mathbb{N}_0^{n_j}$ such that $|\alpha_j| = m_j$ and let $q_{\alpha_j} \in \mathbb{P}^{m_j}[\mathbb{C}^{n_j}]$ be the normalized monomials defined in Lemma 2.11. Recall from Lemma 2.11 that

$$||q_{\alpha_j}|_{\mathbf{S}^{2n_j-1}}||^2 = \frac{2\pi^{n_j}}{\Gamma(n_j + m_j)}$$

and hence

$$\prod_{j=1}^{k} \|q_{\alpha_j}\|_{\mathbf{S}^{2n_j-1}}\|^2 = \frac{2^k \pi^n}{(m+n-1)!}$$

Let $\alpha = (\alpha_1, \ldots, \alpha_k)$ and define the normalized monomial q_α by

$$q_{\alpha}(z) = \prod_{j=1}^{k} q_{\alpha_j}(z_{(j)}).$$

Then $q_{\alpha} \in \mathbf{P}^{m_1}[\mathbb{C}^{n_1}] \otimes \cdots \otimes \mathbf{P}^{m_k}[\mathbb{C}^{n_k}]$ and hence

$$\gamma_{n,\varphi}(\boldsymbol{m}) = \langle T_{\varphi}q_{\alpha}, q_{\alpha} \rangle$$

As φ is *G*-invariant and bounded we can use polar-coordinates on \mathbb{C}^{n_j} , Fubini's theorem, Lemma 2.4, Lemma 2.10 and the fact that q_{α_j} are homogeneous of order m_j , to write

$$\begin{split} \langle T_{\varphi}q_{\alpha}, q_{\alpha} \rangle &= \frac{1}{\pi^{n}} \int_{\mathbb{C}^{n}} \varphi(z) |q_{\alpha}(z)|^{2} e^{-|z|^{2}} dz \\ &= \frac{1}{\pi^{n}} \int_{\mathbb{C}^{n_{1}}} \cdots \int_{\mathbb{C}^{n_{k}}} a(|z_{(1)}|, \dots, |z_{(k)}|) \prod_{j=1}^{k} |q_{\alpha_{j}}(z_{(j)})|^{2} e^{-|z_{(j)}|^{2}} dz_{(1)} \dots dz_{(k)} \\ &= \frac{1}{\pi^{n}} \int_{0}^{\infty} \cdots \int_{0}^{\infty} a(r) \prod_{j=1}^{k} r_{j}^{2m_{j}+2n_{j}-1} e^{-r_{j}^{2}} dr_{1} \dots dr_{k} \prod_{j=1}^{k} ||q_{\alpha_{j}}|_{\mathrm{S}^{2n_{j}-1}} ||^{2} \\ &= \frac{2^{k}}{(m+n-1)!} \int_{0}^{\infty} \cdots \int_{0}^{\infty} a(r) \prod_{j=1}^{k} r_{j}^{2m_{j}+2n_{j}-1} e^{-r_{j}^{2}} dr_{1} \dots dr_{k} \\ &= \frac{1}{(m+n-1)!} \int_{0}^{\infty} \cdots \int_{0}^{\infty} a(\sqrt{r}) \prod_{j=1}^{k} r_{j}^{m_{j}+n_{j}-1} e^{-r_{j}} dr_{1} \dots dr_{k}, \end{split}$$

where we in the last line used the substitutions $u = r_j^2$ and hence $du = 2r_j dr_j$.

Corollary 2.13. If $n = (n_1, ..., n_k)$ and $m = (m_1, ..., m_k)$, then

$$\gamma_{n,a}(m) = \gamma_{1,a}(m_1 + n_1 - 1, \dots, m_k + n_k - 1) = \gamma_{1,a}(m + n - 1).$$

Note that eigenvalue functions $\gamma_{1,a}$ given above corresponds to Toeplitz operators with separately radial symbols. In particular we obtain the following special cases:

Corollary 2.14 (Grudsky and Vasilevski [GV02]). Assume that n = 1

$$\gamma_{1,a}(m) = \frac{1}{m!} \int_0^\infty a(\sqrt{r}) r^m e^{-r} dr$$

If k = 1, then $\boldsymbol{n} = (n)$ and we have the following corollary.

Corollary 2.15. If k = 1 (radial symbols) then

$$\gamma_{n,a}(m) = \frac{1}{(m+n-1)!} \int_0^\infty a(\sqrt{r}) r^{m+n-1} e^{-r} dr = \gamma_{1,a}(m+n-1).$$

If n = k, then n = (1, ..., 1) = 1 and we have the following corollary.

Corollary 2.16. If n = k (separately radial symbols) then

$$\gamma_{1,a}(\boldsymbol{m}) = \frac{1}{\boldsymbol{m}!} \int_{\mathbb{R}^k_+} a_{\varphi}(\sqrt{\boldsymbol{r}}) \boldsymbol{r}^{\boldsymbol{m}} e^{-(r_1 + \dots + r_k)} dr_1 \dots dr_k.$$

Corollary 2.17. If $a(r_1, \ldots, r_k) = \prod_{j=1}^k a_j(r_j)$ then

$$\gamma_{n,a}(m_1,\ldots,m_k) = \prod_{j=1}^k \gamma_{1,a_j}(m_j + n_j - 1).$$

3. The space $C_{b,u}(\mathbb{N}_0^k, \rho_k)$

In this section we introduce C*-algebra $C_{b,u}(\mathbb{N}_0^k, \rho_k)$, the set of all bounded functions on $\mathbb{N}_0^k \times \mathbb{N}_0^k$ that are uniformly continuous with respect to the square-root metric. These are sometimes called *Square root-slowly oscillating* functions.

For $k \in \mathbb{N}$, let $\rho_k : \mathbb{N}_0^k \times \mathbb{N}_0^k \to [0, \infty)$ be given by

$$\rho(\boldsymbol{m}, \boldsymbol{m}') = |\sqrt{m_1} - \sqrt{m_1'}| + \dots + |\sqrt{m_k} - \sqrt{m_k'}|$$

for all $\boldsymbol{m} = (m_1, \ldots, m_k), \boldsymbol{m}' = (m'_1, \ldots, m'_k) \in \mathbb{N}_0^k$ Then ρ_k is a metric on \mathbb{N}_0^k . The modulus of continuity with respect to the metric ρ_k of a function $\sigma \in l^{\infty}(\mathbb{N}_0^k)$ is the function $\omega_{\rho_k,\sigma} : [0, \infty) \to [0, \infty)$ given by

$$\omega_{\rho_k,\sigma}(\delta) = \sup\{|\sigma(\boldsymbol{m}) - \sigma(\boldsymbol{m}')| : \rho(\boldsymbol{m}, \boldsymbol{m}') \le \delta\}$$

 $C_{b,u}(\mathbb{N}_0^k, \rho_k)$ is the set of all bounded functions on \mathbb{N}_0^k that are uniformly continuous with respect to the square-root metric ρ_k :

$$\left\{\sigma \in l^{\infty}(\mathbb{N}_{0}^{k}) : \lim_{\delta \to 0} \omega_{\rho_{k},\sigma}(\delta) = 0\right\}$$

 $C_{b,u}(\mathbb{N}_0^k, \rho_k)$ is a closed subalgebra of $l^{\infty}(\mathbb{N}_0^k)$.

Definition 3.1. Let $\sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ and let $\mathbf{s} = (s_1, \ldots, s_k) \in \mathbb{N}_0^k$. We define the left and right shift operators on $C_{b,u}(\mathbb{N}_0^k, \rho_k)$ with respect to \mathbf{s} , denoted $\tau_L^{\mathbf{s}}$ and $\tau_R^{\mathbf{s}}$ respectively, by

$$\tau_L^{\boldsymbol{s}}\sigma(\boldsymbol{m}) = \sigma(\boldsymbol{m} + \boldsymbol{s}) \quad and \quad \tau_R^{\boldsymbol{s}}\sigma(\boldsymbol{m}) = \begin{cases} \sigma(\boldsymbol{m} - \boldsymbol{s}) & ; m_i \ge s_i \ \forall \ i = 1, \dots, k \\ 0 & ; otherwise \end{cases}$$

for all $\boldsymbol{m} = (m_1, \ldots, m_k) \in \mathbb{N}_0^k$.

Now we present the following two lemmas that will be used in section 6.

Lemma 3.2. Let $\sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ and $\mathbf{s} = (s_1 \dots, s_k) \in \mathbb{N}_0^k$. Then $\tau_L^{\mathbf{s}} \sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$.

Proof. Boundedness of $\tau_L^{\mathbf{s}}\sigma$ follows easily from the boundedness of σ . Let $\mathbf{m} = (m_1, \ldots, m_k)$, $\mathbf{m}' = (m'_1, \ldots, m'_k) \in \mathbb{N}_o^k$. By observing the square-root function, we have,

$$\sqrt{m_i + s_i} - \sqrt{m'_i + s_i} \le |\sqrt{m_i} - \sqrt{m'_i}|, \text{ for } i = 1, \dots k.$$

Hence $\omega_{\rho_k,\tau_L^{\mathbf{s}}\sigma}(\delta) \leq \omega_{\rho_k,\sigma}(\delta)$.

Lemma 3.3. Let $\sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ and $\mathbf{s} = (s_1, \dots, s_k) \in \mathbb{N}_0^k$. Then $\tau_R^s \sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$.

Proof. Again boundedness of $\tau_R^{\mathbf{s}}\sigma$ follows from the boundedness of σ . Let $s = \max\{s_1, \ldots, s_k\}$. Assume $\delta < \sqrt{2s} - \sqrt{2s-1}$ and let $\mathbf{m} = (m_1, \dots, m_k), \mathbf{m}' = (m'_1, \dots, m'_k) \in \mathbb{N}_o^k$ such that $\rho_k(\boldsymbol{m}, \boldsymbol{m}') < \delta$. Then $|\sqrt{m_i} - \sqrt{m_i'}| < \sqrt{2s} - \sqrt{2s-1}$ and since

$$\min_{\substack{j,l \in \mathbb{N}_0 \\ i,j \le 2s}} |\sqrt{j} - \sqrt{l}| = \sqrt{2s} - \sqrt{2s - 1},$$

we have $m_i, m'_i > 2s \ge 2s_i$ for all $i = 1, \ldots, k$. Notice that

$$\begin{split} m_i, m_i' > 2s_i &= \frac{s_i}{1 - \frac{1}{2}} \implies \frac{1}{2}m_i < m_i - s_i, \ \frac{1}{2}m_i' < m_i' - s_i \\ &\implies \frac{1}{\sqrt{2}}\sqrt{m_i} < \sqrt{m_i - s_i}, \ \frac{1}{\sqrt{2}}\sqrt{m_i'} < \sqrt{m_i' - s_i} \\ &\implies \frac{1}{\sqrt{2}}(\sqrt{m_i} + \sqrt{m_i'}) < \sqrt{m_i - s_i} + \sqrt{m_i' - s_i} \\ &\implies \frac{|m_i - m_i'|}{\sqrt{m_i - s_i} + \sqrt{m_i' - s_i}} < \sqrt{2}\frac{|m_i - m_i'|}{\sqrt{m_i} + \sqrt{m_i'}} \\ &\implies |\sqrt{m_i - s_i} - \sqrt{m_i' - s_i}| < \sqrt{2}|\sqrt{m_i} - \sqrt{m_i'}|. \end{split}$$

Hence $\omega_{\rho_k,\tau_L^{\mathbf{s}}\sigma}(\delta) \leq \omega_{\rho_k,\sigma}(\sqrt{2\delta})$ for all $\delta < \sqrt{2s} - \sqrt{2s} - 1$.

The metric ρ_k can be extended to \mathbb{R}^k_+ and we denote the set of all functions on \mathbb{R}^k_+ that are uniformly continuous with respect to ρ_k by $C_{b,u}(\mathbb{R}^k_+, \rho_k)$. The following lemma shows that any $\sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ can be extended to some $f \in C_{b,u}(\mathbb{R}_+^k, \rho_k)$. We will use this fact in section 5.

Lemma 3.4. Let $\sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$. Define f on \mathbb{R}_+^k by

$$f(x) = f_{\mathbf{m}}(x) := \sigma(\mathbf{m}) + \sum_{l=1}^{k} \sum_{\substack{i_1, \dots, i_l \in \{1, \dots, k\} \\ i_1 < \dots < i_l}} a_{i_1, \dots, i_l}^l(\mathbf{m}) \prod_{q=1}^l \frac{\sqrt{x_{i_q}} - \sqrt{m_{i_q}}}{\sqrt{m_{i_q} + 1} - \sqrt{m_{i_q}}}$$

where $m_i = \lfloor x_i \rfloor$, i = 1, ..., k and the coefficients $a_{i_1,...,i_l}^l(\boldsymbol{m})$ are given by

$$a_{i_1,\dots,i_l}^l(\boldsymbol{m}) = \sum_{q=0}^l (-1)^{l-q} \sum_{\substack{j_1,\dots,j_q \in \{i_1,\dots,i_l\}\\j_1 < \dots < j_q}} \sigma(\boldsymbol{m} + e_{j_1} + \dots + e_{j_q})$$

where e_i denotes the standard basis of \mathbb{N}_0^k .

Then $f \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ and $f|_{\mathbb{N}_0^k} = \sigma$. Moreover $||f||_{\infty} = ||\sigma||_{\infty}$.

The function f defined above is motivated by the interpolation formula for the case k = 1, given by

$$f(x) = \sigma(m) + (\sigma(m+1) - \sigma(m))\frac{\sqrt{x} - \sqrt{m}}{\sqrt{m+1} - \sqrt{m}}$$

where m = |x| and $x \in \mathbb{R}_+$. The proof of Lemma 3.4 is a generalization of the proof of Lemma 3.3 in [EM16]. However, the proof depends heavily on combinatorics and induction; we have provided the proof in the appendix.

4. UNIFORM CONTINUITY OF EIGENVALUE FUNCTIONS WITH RESPECT TO THE SQUARE-ROOT METRIC

In this section, we show that the set of all eigenvalue functions is a subset of $C_{b,u}(\mathbb{N}_0^k,\rho_k)$.

Definition 4.1. Let \mathfrak{G}_n be the set of all eigenvalue functions:

$$\mathfrak{G}_{\boldsymbol{n}} := \{ \gamma_{\boldsymbol{n},a} \mid \varphi \in L^{\infty}(\mathbb{C}^n)^G \}.$$

Proposition 4.2. The eigenvalue functions $\gamma_{n,a}$ are bounded functions that are uniformly continuous with respect to the square-root metric ρ_k , i.e.,

$$\mathfrak{G}_n \subseteq C_{b,u}(\mathbb{N}_0^k, \rho_k).$$

The boundedness of $\gamma_{n,a}$ follows from the boundedness of the symbol. We proceed to prove the uniform continuity of $\gamma_{n,a}$ with respect to the metric ρ_k . The following lemma is Lemma 4.3 in [EM16] which is used by Esmeral and Maximenko to prove the above theorem for n = 1. Then we prove Lemma 4.4 and Lemma 4.5 which are used to prove Proposition 4.6. Theorem 4.2 follows as a corollary of Proposition 4.6.

Lemma 4.3. For any $m \in \mathbb{N}$,

$$\int_0^\infty \left| \frac{r^m}{m!} - \frac{r^{m-1}}{(m-1)!} \right| e^{-r} dr \le \sqrt{\frac{2}{\pi m}}.$$

As a consequence of the above lemma we prove the following:

Lemma 4.4. For any $m, m' \in \mathbb{N}_0$,

$$\int_0^\infty \left| \frac{r^m}{m!} - \frac{r^{m'}}{m'!} \right| e^{-r} dr \le 2\sqrt{\frac{2}{\pi}} |\sqrt{m} - \sqrt{m'}|.$$

Proof. Let $\underline{m} = \min\{m, m'\}$ and $\overline{m} = \max\{m, m'\}$. Notice that

$$\begin{split} \int_{0}^{\infty} \left| \frac{r^{m}}{m!} - \frac{r^{m'}}{m'!} \right| e^{-r} dr &\leq \sum_{i=\underline{m}+1}^{\overline{m}} \int_{0}^{\infty} \left| \frac{r^{i}}{i!} - \frac{r^{i-1}}{(i-1)!} \right| e^{-r} dr \\ &\leq \sum_{i=\underline{m}+1}^{\overline{m}} \sqrt{\frac{2}{\pi i}} \quad \text{(by Lemma 4.3)} \\ &= \sqrt{\frac{2}{\pi}} \sum_{i=\underline{m}+1}^{\overline{m}} \frac{(\sqrt{i} + \sqrt{i-1})(\sqrt{i} - \sqrt{i-1})}{\sqrt{i}} \\ &\leq \sqrt{\frac{2}{\pi}} \sum_{i=\underline{m}+1}^{\overline{m}} \frac{2\sqrt{i}(\sqrt{i} - \sqrt{i-1})}{\sqrt{i}} = 2\sqrt{\frac{2}{\pi}} |\sqrt{m} - \sqrt{m'}|. \end{split}$$

Lemma 4.5. Suppose $f_i, g_i : \mathbb{N}_0 \times \mathbb{R}_+ \to \mathbb{C}$ satisfy $\int_{\mathbb{R}_+} |f_i(m, r)| dr$, $\int_{\mathbb{R}_+} |g_i(m, r)| dr \leq 1$ for $i = 1, \ldots, k$. Then for all $m_i, m'_i \in \mathbb{N}_0$,

$$\int_{\mathbb{R}^k_+} \Big| \prod_{i=1}^k f_i(m_i, r_i) - \prod_{i=1}^k g_i(m'_i, r_i) \Big| dr_1 \cdots dr_k \le \sum_{i=1}^k \int_{\mathbb{R}_+} |f_i(m_i, r_i) - g_i(m'_i, r_i)| dr_i.$$

Proof. Notice that the statement is true for k = 1. Assume the statement is true for k. Then

$$\begin{split} \int_{\mathbb{R}^{k+1}_{+}} \Big| \prod_{i=1}^{k+1} f_i(m_i, r_i) - \prod_{i=1}^{k+1} g_i(m'_i, r_i) \Big| dr_1 \cdots dr_{k+1} \\ &\leq \int_{\mathbb{R}_{+}} |f_{k+1}(m_{k+1}, r_{k+1}) - g_{k+1}(m_{k+1}, r_{k+1})| dr_{k+1} \Big| \int_{\mathbb{R}^k_{+}} \prod_{i=1}^k f_i(m_i, r_i) dr_1 \cdots dr_k \Big| \\ &+ \int_{\mathbb{R}_{+}} |g_{k+1}(m_{k+1}, r_{k+1})| dr_{k+1} \int_{\mathbb{R}^k_{+}} \Big| \prod_{i=1}^k f_i(m_i, r_i) - \prod_{i=1}^k g_i(m'_i, r_i) \Big| dr_1 \cdots dr_k \\ &\leq \sum_{i=1}^{k+1} \int_{\mathbb{R}_{+}} |f_i(m_i, r_i) - g_i(m'_i, r_i)| dr_i \end{split}$$

by the assumption and because

$$\left| \int_{\mathbb{R}^k_+} \prod_{i=1}^k f_i(m_i, r_i) dr_1 \dots dr_k \right| \leq \prod_{i=1}^k \int_{\mathbb{R}^k_+} |f_i(m_i, r_i)| dr_i$$
$$\leq 1.$$

Hence the result holds by induction on k.

Proposition 4.6. The eigenvalue functions $\gamma_{n,a}$ are Lipchitz with respect to the square-root metric ρ_k : There exists $A_{\varphi} > 0$ such that

$$|\gamma_{\boldsymbol{n},a}(\boldsymbol{m}) - \gamma_{\boldsymbol{n},a}(\boldsymbol{m}')| \leq A_{\varphi}\rho_k(\boldsymbol{m},\boldsymbol{m}')$$

for all $\boldsymbol{m} = (m_1, \dots, m_k), \, \boldsymbol{m}' = (m_1', \dots, m_k') \in \mathbb{N}_0^k.$

Proof. Define $K : \mathbb{N}_0 \times \mathbb{R}_+ \to [0, \infty)$ by $K(m, r) = \frac{r^m}{m!} e^{-r}$. Then $\int_0^\infty K(m, r) dr = 1$ and

$$\gamma_{\mathbf{1},a}(\boldsymbol{m}) = \int_{\mathbb{R}^k_+} a_{\varphi}(\sqrt{r_1}, \dots, \sqrt{r_k}) \prod_{i=1}^k K(m_i, r_i) dr_1 \cdots dr_k$$

where $\mathbf{1} = (1, \dots, 1) \in \mathbb{N}^k$. Notice that

$$\begin{aligned} |\gamma_{\mathbf{1},a}(\boldsymbol{m}) - \gamma_{\mathbf{1},a}(\boldsymbol{m}')| \\ &\leq \|a_{\varphi}\|_{\infty} \int_{\mathbb{R}^{k}_{+}} \Big| \prod_{i=1}^{k} K(m_{i},r_{i}) - \prod_{i=1}^{k} K(m'_{i},r_{i}) \Big| dr_{1} \cdots dr_{k} \\ &\leq \|a_{\varphi}\|_{\infty} \sum_{i=1}^{k} \int_{0}^{\infty} |K(m_{i},r_{i}) - K(m'_{i},r_{i})| dr_{i} \qquad (\text{by Lemma 4.5}) \\ &\leq 2\sqrt{\frac{2}{\pi}} \|a_{\varphi}\|_{\infty} \rho_{k}(\boldsymbol{m},\boldsymbol{m}') \qquad (\text{by Lemma 4.4}). \end{aligned}$$

Hence by Corollary 2.13,

$$\begin{split} |\gamma_{\boldsymbol{n},a}(\boldsymbol{m}) - \gamma_{\boldsymbol{n},a}(\boldsymbol{m}')| &= |\gamma_{\boldsymbol{1},a}(\boldsymbol{m} + \boldsymbol{n} - \boldsymbol{1}) - \gamma_{\boldsymbol{1},a}(\boldsymbol{m}' + \boldsymbol{n} - \boldsymbol{1})| \\ &\leq 2\sqrt{\frac{2}{\pi}} \|a_{\varphi}\|_{\infty} \rho_{k}(\boldsymbol{m} + \boldsymbol{n} - \boldsymbol{1}, \boldsymbol{m}' + \boldsymbol{n} - \boldsymbol{1}) \\ &\leq 2\sqrt{\frac{2}{\pi}} \|a_{\varphi}\|_{\infty} \rho_{k}(\boldsymbol{m}, \boldsymbol{m}'). \end{split}$$

Therefore the function $\gamma_{n,a}$ are uniformly continuous with respect to the metric ρ_k , proving Theorem 4.2.

5. Density of \mathfrak{G}_1 in $C_{b,u}(\mathbb{N}_0^k, \rho_k)$

In the previous section we showed that $\mathfrak{G}_n \subseteq C_{b,u}(\mathbb{N}_0^k, \rho_k)$. To show that the C^* -algebra generated by \mathfrak{G}_n is $C_{b,u}(\mathbb{N}_0^k, \rho_k)$, it is enough to show that \mathfrak{G}_n is dense in $C_{b,u}(\mathbb{N}_0^k, \rho_k)$ which will be proved in all generality in section 6. In this section we focus on the case $\mathbf{n} = \mathbf{1} = (1, \ldots, 1) \in \mathbb{N}^k$. In other words we will show that \mathfrak{G}_1 , the set of eigenvalue functions we get for the case $\mathbf{n} = \mathbf{1}$, is dense in $C_{b,u}(\mathbb{N}_0^k, \rho_k)$. Note that in the above case, the Toeplitz operators under consideration are the Toeplitz operators on $\mathcal{F}(\mathbb{C}^k)$ with seperately radial symbols.

This discussion is a generalization of the proof of density for the case n = (1), presented in [EM16].

5.1. Approximation by convolutions. The main goal of this subsection is to prove Proposition 5.6. For this we present a series of propositions and lemmas.

By a change of variable $(r_1, \ldots, r_k) \to (r_1^2, \ldots, r_k^2)$, we have

$$\gamma_{\mathbf{1},a}(\mathbf{m}) = \int_{\mathbb{R}^k_+} a(r_1, \dots, r_k) \prod_{i=1}^k g(m_i, r_i) dr_1 \dots dr_k$$

where $g(m,r) = \frac{2r^{2m+1}e^{-r^2}}{m!}$. Let $h(x) = \sqrt{\frac{2}{\pi}}e^{-2x^2}$. We have the following lemma from [EM16] (Lemma 6.5).

we have the following lemma from [EM10] (Lemma 0.5).

Lemma 5.1. Let the functions g and h be as above. Then

$$\lim_{m \to \infty} \int_0^\infty |g(m, r) - h(\sqrt{m} - r)| dr = 0.$$

Let $H(x_1, \ldots, x_k) = \prod_{i=1}^k h(x_i) = (\frac{2}{\pi})^{\frac{k}{2}} e^{-2(x_1^2 + \cdots + x_k^2)}.$

Lemma 5.2. Let $\epsilon > 0$. Then there exists N such that for all $m_i > N$, $i = 1, \ldots, k$

$$\int_{\mathbb{R}^k_+} \Big| \prod_{i=1}^k g(m_i, r_i) - H(\sqrt{m_1} - r_1, \dots, \sqrt{m_k} - r_k) \Big| dr_1 \dots dr_k < \epsilon$$

Proof. By Lemma 5.1, there exists N such that for all m > N, $\int_0^\infty |g(m,r) - h(\sqrt{m}-r)|dr < \frac{\epsilon}{k}$. Also notice that $\int_0^\infty g(m,r)dr = 1$ and $\int_0^\infty h(\sqrt{m}-r)dr \le \int_{\mathbb{R}} h(\sqrt{m}-r)dr = \int_{\mathbb{R}} h(r)dr = 1$ for any $m \in \mathbb{N}_0$. Then if $m_i > N$, $i = 1, \ldots, k$,

$$\begin{split} \int_{\mathbb{R}^{k}_{+}} \Big| \prod_{i=1}^{k} g(m_{i}, r_{i}) - H(\sqrt{m_{1}} - r_{1}, \dots, \sqrt{m_{k}} - r_{k}) \Big| dr_{1} \dots dr_{k} \\ &= \int_{\mathbb{R}^{k}_{+}} \Big| \prod_{i=1}^{k} g(m_{i}, r_{i}) - \prod_{i=1}^{k} h(\sqrt{m_{i}} - r_{i}) \Big| dr_{1} \dots dr_{k} \\ &\leq \sum_{i=1}^{k} \int_{0}^{\infty} |g(m_{i}, r_{i}) - h(\sqrt{m_{i}} - r_{i})| dr_{i} \quad \text{(by Lemma 4.5)} \\ &< k \frac{\epsilon}{k} = \epsilon. \end{split}$$

Let $f \in L^1(\mathbb{R}^k, dx)$ and $g \in L^{\infty}(\mathbb{R}^k, dx)$ where dx denotes the Lebesgue measure on \mathbb{R}^k . Recall that the convolution of f and g, denoted f * g, is given by

$$f * g(x) = g * f(x) = \int_{\mathbb{R}^k} f(x-y)g(y)dy, \quad x \in \mathbb{R}^k.$$

The following proposition presents an approximation of the eigenvalue functions by convolutions.

Proposition 5.3. Let $a \in L^{\infty}(\mathbb{R}^k_+)$ and let $\epsilon > 0$. Define H * a, by considering 'a' as a function on \mathbb{R}^k whose support is \mathbb{R}^k_+ . Then there exists N such that for all $m_i > N$, $i = 1, \ldots, k$,

$$|\gamma_{\mathbf{1},a}(m_1,\ldots,m_k) - (H*a)(\sqrt{m_1},\ldots,\sqrt{m_k})| < \epsilon.$$

Proof. Since support of a is \mathbb{R}^k_+ ,

$$\begin{aligned} &|\gamma_{1,a}(m_1,\ldots,m_k) - (H*a)(\sqrt{m_1},\ldots,\sqrt{m_k})| \\ &= \Big| \int_{\mathbb{R}^k_+} \left(\prod_{i=1}^k g(m_i,r_i) - H(\sqrt{m_1} - r_1,\ldots,\sqrt{m_k} - r_k) \right) a(y) dr_1 \ldots dr_k \Big| \\ &\leq \|a\|_{\infty} \int_{\mathbb{R}^k_+} \Big| \prod_{i=1}^k g(m_i,r_i) - H(\sqrt{m_1} - r_1,\ldots,\sqrt{m_k} - r_k) \Big| dr_1 \ldots dr_k. \end{aligned}$$

Hence the result follows from 5.2

Lemma 5.4. Let $b \in L^{\infty}(\mathbb{R}^k)$ and $a = \chi_{\mathbb{R}^k_+}b$. Let $\epsilon > 0$. Then there exists M such that for all $x_i > M$, $i = 1, \ldots, k$,

$$|H * a(x_1,\ldots,x_k) - H * b(x_1,\ldots,x_k)| < \epsilon.$$

Proof. Notice that for $x = (x_1, \ldots, x_k) \in \mathbb{R}^k_+$,

$$\begin{aligned} H * a(x) - H * b(x) &| \leq \int_{\mathbb{R}^k} |a(y) - b(y)| H(x - y) dy \\ &\leq \|b\|_{\infty} \int_{\mathbb{R}^k \setminus \mathbb{R}^k_+} H(x - y) dy \\ &\leq \|b\|_{\infty} \sum_{j=1}^k \int_{\mathbb{R}_-} h(x_j - y_j) dy_j \prod_{\substack{i=1\\i \neq j}}^k \int_{\mathbb{R}} h(x_i - y_i) dy_i \\ &= \|b\|_{\infty} \sum_{j=1}^k \int_{\mathbb{R}_-} h(x_j - y_j) dy_j \\ &= \|b\|_{\infty} \sum_{j=1}^k \int_{x_j}^\infty h(y_j) dy_j \quad \text{(by a change of variable)} \end{aligned}$$

The lemma holds as $\int_{x_i}^{\infty} h(y) dy$ approaches zero as x_j goes to ∞ .

Proposition 5.5. Let $g \in C_{b,u}(\mathbb{R}^k)$ and let $\epsilon > 0$. Then there is $b \in L^{\infty}(\mathbb{R}^k)$ such that

$$\|H * b - g\|_{\infty} < \epsilon.$$

Proof. Let h denote the bump function (any compactly supported smooth function would suffice)

$$\tilde{h}(\zeta) = e^{-\frac{1}{1-|\zeta|^2}}\chi_B(\zeta), \quad \zeta \in \mathbb{R}^k$$

where B is the open unit ball in \mathbb{R}^k . Let h denote the normalized Fourier inverse of \tilde{h} , i.e.,

$$h = \frac{\mathscr{F}^{-1}(\tilde{h})}{C}$$

where $C = \|\mathscr{F}^{-1}(\tilde{h})\|_1$. Define the approximate identity h_t on \mathbb{R}^k by

$$h_t(x) = \frac{h(x/t)}{t}, \ x \in \mathbb{R}^k$$

Notice that $\lim_{t\to 0} \|h_t * g - g\|_{\infty} = 0$. Choose h_{t_0} s.t. $\|h_{t_0} * g - g\|_{\infty} < \epsilon$. Let $\hat{l} := \frac{\mathscr{F}(h_{t_0})}{\mathscr{F}(H)}$. Then

$$\hat{l}(\zeta) = \frac{\tilde{h}(t_0 \zeta) e^{|\zeta^2|/2}}{C}, \quad \zeta \in \mathbb{R}^k.$$

Since \hat{l} is a Schwartz function and $\mathscr{F}(h_{t_0}) = \mathscr{F}(H)\hat{l}$, $h_{t_0} = H * l$ where $l = \mathscr{F}^{-1}(\hat{l})$. Let b = l * g. Then $b \in L^{\infty}(\mathbb{R}^k)$ and $||H * b - g||_{\infty} = ||h_{t_0} * g - g||_{\infty} < \epsilon$.

Proposition 5.5 can also be proved using Wiener's division lemma, as in the proof of Proposition 5.4 in [EM16].

Proposition 5.6. Let $\sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ and let $\epsilon > 0$. Then there exists $a \in L^{\infty}(\mathbb{R}_+^k)$ and N such that for all $\mathbf{m} = (m_1, \ldots, m_k) \in \mathbb{N}_0^k$ with $m_i > N$,

$$|\sigma(\boldsymbol{m}) - \gamma_{\boldsymbol{1},a}(\boldsymbol{m})| < \epsilon.$$

Proof. This proof is similar to the proof of Proposition 6.8 in [EM16].

By Lemma 3.4, there exists $g \in C_{b,u}(\mathbb{R}^k_+)$ such that $g|_{\mathbb{N}^k_0} = \sigma$ and $||g||_{\infty} = ||\sigma||_{\infty}$. Define \tilde{g} on \mathbb{R}^k by $\tilde{g}(x_1, \ldots, x_k) = g(x_1^2, \ldots, x_k^2)$. Then $\tilde{g} \in C_{b,u}(\mathbb{R}^k)$. Then by Proposition 5.5 there exists $b \in L^{\infty}(\mathbb{R}^k)$ such that

$$\|H*b-\tilde{g}\|_{\infty} < \frac{\epsilon}{3}.$$

Define a on \mathbb{R}^k_+ by $a = b|_{\mathbb{R}^k_+}$. Then $a \in L^{\infty}(\mathbb{R}^k_+)$. Then by Proposition 5.3 and Lemma 5.4, there exists N_1, N_2 such that for all $m_i > N_1, i = 1, \ldots, k$

$$|\gamma_{\mathbf{1},a}(m_1,\ldots,m_k) - (H * a(\sqrt{m_1},\ldots,\sqrt{m_k}))| < \frac{\epsilon}{3}$$

and for all $m_i > N_2$,

$$|H * a(\sqrt{m_1}, \dots, \sqrt{m_k}) - H * b(\sqrt{m_1}, \dots, \sqrt{m_k})| < \frac{\epsilon}{3}$$

Then for all $\boldsymbol{m} = (m_1, \dots, m_k)$ with $m_i > N = max\{N_1, N_2\}$

$$\begin{aligned} |\gamma_{1,a}(\boldsymbol{m}) - \sigma(\boldsymbol{m})| &\leq |\gamma_{1,a}(\boldsymbol{m}) - (H * a)(\sqrt{m_1}, \dots, \sqrt{m_k})| \\ &+ |H * a(\sqrt{m_1}, \dots, \sqrt{m_k}) - H * b(\sqrt{m_1}, \dots, \sqrt{m_k})| \\ &+ \|H * b - \tilde{g}\|_{\infty} \\ &< \frac{\epsilon}{3} + \frac{\epsilon}{3} + \frac{\epsilon}{3} = \epsilon. \end{aligned}$$

5.2. The density of \mathfrak{G}_1 in $C_{b,u}(\mathbb{N}_0^k, \rho_k)$. The proof of density (Theorem 5.9) requires induction on k. Hence to indicate dependency on k, we identify \mathfrak{G}_1 by \mathfrak{G}_1^k and $\gamma_{1,a}$ by $\gamma_{1,a}^k$ as needed in this subsection.

Lemma 5.7. Let k > 1 and assume $\mathfrak{G}_{\mathbf{1}}^{k-1}$ is dense in $C_{b,u}(\mathbb{N}_0^{k-1}, \rho_{k-1})$. For $i = 1, \ldots, k$ and $m_o \in \mathbb{N}_0$, define the set $K_i(m_0) \subset \mathbb{N}_0^k$

$$K_i(m_0) = \{ \boldsymbol{m} = (m_1, \dots, m_k) \in \mathbb{N}_0^k \mid m_i = m_0 \}$$

Let $\sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ and let $\epsilon > 0$. Then there exists $a \in L^{\infty}(\mathbb{R}_+^k)$ s.t.

$$\|\sigma\chi_{K_i(m_0)} - \gamma_{\mathbf{1},a}^k\|_{\infty} < \epsilon.$$

Proof. Identify $K_i(m_0)$ with \mathbb{N}_0^{k-1} by the map

$$p_{i,m_0}: (m_1, \dots, m_{i-1}, m_o, m_{i+1}, \dots, m_k) \mapsto (m_1, \dots, m_{i-1}, m_{i+1}, \dots, m_k)$$

Define $\sigma_{m_0}: \mathbb{N}_0^{k-1} \to \mathbb{C}$ by

$$\sigma_{m_0}(m_1,\ldots,m_{k-1}) = \sigma \chi_{K_i(m_0)}(p_{i,m_0}^{-1}(m_1,\ldots,m_{k-1}))$$

Then $\sigma_{m_0} \in C_{b,u}(\mathbb{N}_0^{k-1}, \rho_{k-1})$. By the assumption there is $b \in L^{\infty}(\mathbb{R}_+^{k-1})$ s.t.

$$\|\sigma_{m_0} - \gamma_{\mathbf{1},b}^{k-1}\| < \frac{\epsilon}{2}$$

Since $\chi_{\{m_0\}} \in C_{b,u}(\mathbb{N}_0, \rho_1)$, there is $c \in L^{\infty}(\mathbb{R}_+)$ s.t.

$$\|\chi_{\{m_0\}} - \gamma_{\mathbf{1},c}\| < \|b\|_{\infty} \frac{\epsilon}{2}.$$

Now define $a \in L^{\infty}(\mathbb{R}^k_+)$ by

$$a(\boldsymbol{x}) = b(x_1, \dots, x_{i-1}, x_{i+1}, \dots, x_k)c(x_i) \quad \forall \ \boldsymbol{x} \in \mathbb{R}^k_+$$
15

Then $\gamma_{\mathbf{1},a}^{k}(\boldsymbol{m}) = \gamma_{\mathbf{1},b}^{k-1}(p_{i}(\boldsymbol{m}))\gamma_{\mathbf{1},c}(m_{i})$ for all $\boldsymbol{m} \in \mathbb{N}_{0}^{k}$. Let $\nu \in C_{b,u}(\mathbb{N}_{0}^{k},\rho_{k})$ be defined by $\nu(\boldsymbol{m}) = \gamma_{\mathbf{1},b}^{k-1}(p_{i}(\boldsymbol{m}))\chi_{\{m_{0}\}}(m_{i})$ for all $\boldsymbol{m} \in \mathbb{N}_{0}^{k}$. Then

$$\begin{aligned} \|\sigma\chi_{K_{i}(m_{0})} - \gamma_{\mathbf{1},a}^{k}\|_{\infty} &\leq \|\sigma\chi_{K_{i}(m_{0})} - \nu\|_{\infty} + \|\nu - \gamma_{\mathbf{1},a}^{k}\|_{\infty} \\ &\leq \|\sigma_{m_{0}} - \gamma_{\mathbf{1},b}^{k-1}\|_{\infty} + \|\gamma_{\mathbf{1},b}^{k-1}\|_{\infty}\|\gamma_{\mathbf{1},c} - \chi_{\{m_{0}\}}\|_{\infty} \\ &< \frac{\epsilon}{2} + \|b\|_{\infty} \frac{\epsilon}{2\|b\|_{\infty}} = \epsilon. \end{aligned}$$

Lemma 5.8. Let k > 1 and assume $\mathfrak{G}_{\mathbf{1}}^{k-1}$ is dense in $C_{b,u}(\mathbb{N}_0^{k-1}, \rho_{k-1})$. Let $K_N \subset \mathbb{N}_0^k$ be defined by

 $K_N := \{ \boldsymbol{m} = (m_1, \dots, m_k) \in \mathbb{N}_0^k | m_i \le N \text{ for some } i \}$ and let $\epsilon > 0$. Then there exists $a \in L^{\infty}(\mathbb{R}^k)$ is t

Let $\sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ and let $\epsilon > 0$. Then there exists $a \in L^{\infty}(\mathbb{R}_+^k)$ s.t.

$$\|\sigma\chi_{K_N} - \gamma_{\mathbf{1},a}\|_{\infty} < \epsilon$$

Proof. For i = 1, ..., k and j = 0, 1, ..., N, let the sets $K_i(j)$ be as defined in Lemma 5.7. Then there exists $\sigma_{(i,j)} \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ s.t. $\sigma_{(i,j)}\chi_{K_i(j)} = \sigma_{(i,j)}$ and

$$\sigma \chi_{K_N} = \sum_{i=1}^k \sum_{j=1}^N \sigma_{(i,j)}.$$

The functions $\sigma_{(i,j)}$ can be constructed by considering $\sigma \chi_{K_i(j)}$ and removing up to finitely many points from its support. By Lemma 5.7, there exists $a_{(i,j)} \in L^{\infty}(\mathbb{R}^k_+)$ s.t.

$$\|\sigma_{(i,j)} - \gamma_{\mathbf{1},a_{(i,j)}}\|_{\infty} < \frac{\epsilon}{kN}.$$

Define $a \in L^{\infty}(\mathbb{R}^{k}_{+})$ by $a = \sum_{i=1}^{k} \sum_{j=1}^{N} a_{(i,j)}.$ Then $\gamma_{\mathbf{1},a} = \sum_{i=1}^{k} \sum_{j=1}^{N} \gamma_{\mathbf{1},a_{(i,j)}}$ and
(5.1) $\|\sigma\chi_{K_{N}} - \gamma_{\mathbf{1},a}\|_{\infty} \le \sum_{i=1}^{k} \sum_{j=1}^{N} \|\sigma_{(i,j)} - \gamma_{\mathbf{1},a_{(i,j)}}\|_{\infty}$
 $< kN \frac{\epsilon}{kN} = \epsilon.$

Theorem 5.9. \mathfrak{G}_1 is dense in $C_{b,u}(\mathbb{N}_0^k, \rho_k)$.

Proof. The proof is by induction on k. The result for k = 1 was proved in [EM16]. Assume the result is true for k - 1. Let $\sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ and let $\epsilon > 0$. By Proposition 5.6 there is N and $b \in L^{\infty}(\mathbb{R}^k_+)$ s.t. for all $\mathbf{m} \in \mathbb{N}_0^k$ with $m_i > N$,

$$|\sigma(\boldsymbol{m}) - \gamma_{\boldsymbol{1},b}(\boldsymbol{m})| < \frac{\epsilon}{2}.$$

By the induction hypothesis and Lemma 5.8, there exists $c \in L^{\infty}(\mathbb{R}^k_+)$ s.t.

$$\|(\sigma - \gamma_{\mathbf{1},b})\chi_{K_N} - \gamma_{\mathbf{1},c}\| < \frac{\epsilon}{2}.$$

Let a = b + c. Then $\gamma_{1,a} = \gamma_{1,b} + \gamma_{1,c}$ and

$$\begin{split} \|\sigma - \gamma_{\mathbf{1},a}\|_{\infty} &= \|(\sigma - \gamma_{\mathbf{1},b})\chi_{K_{N}^{c}} + (\sigma - \gamma_{\mathbf{1},b})\chi_{K_{N}} - \gamma_{\mathbf{1},c}\|_{\infty} \\ &\leq \|(\sigma - \gamma_{\mathbf{1},b})\chi_{K_{N}^{c}}\|_{\infty} + \|(\sigma - \gamma_{\mathbf{1},b})\chi_{K_{N}} - \gamma_{\mathbf{1},c}\|_{\infty} \\ &< \sup_{\substack{\boldsymbol{m} \in \mathbb{N}_{0}^{k} \\ m_{i} > N \ \forall i}} |\sigma(\boldsymbol{m}) - \gamma_{\mathbf{1},b}(\boldsymbol{m})| + \frac{\epsilon}{2} \\ &< \frac{\epsilon}{2} + \frac{\epsilon}{2} = \epsilon. \end{split}$$

6. The C^* -algebra generated by \mathfrak{G}_n

In this section we prove the density theorem in all generality: the C^* -algebra generated by \mathfrak{G}_n , where $\mathbf{n} = (n_1, \ldots, n_k)$, is the C^* -algebra $C_{b,u}(\mathbb{N}_0^k, \rho_k)$. We already noticed that $\gamma_{n,a} \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ in Proposition 4.2. Recall the shift operators in definition 3.1. Following lemma is a restatement of Corollary 2.13

Lemma 6.1. The eigenvalue function $\gamma_{n,a}$ is the $(n-1)^{th}$ left shift of $\gamma_{1,a}$, i.e.,

$$\gamma_{\boldsymbol{n},a} = \tau_L^{\boldsymbol{n-1}} \gamma_{\boldsymbol{1},a}.$$

Proposition 6.2. The set of eigenvalue functions \mathfrak{G}_n is dense in the C^* -algebra $C_{b,u}(\mathbb{N}_0^k, \rho_k)$ for any $\mathbf{n} = (n_1, \ldots, n_k) \in \mathbb{N}_0^k$.

Proof. Let $\sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$ and let $\epsilon > 0$. By Lemma 3.3, $\sigma' := \tau_R^{n-1} \sigma \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$. Also \mathfrak{G}_1 is dense in $C_{b,u}(\mathbb{N}_0^k, \rho_k)$ by Theorem 5.9. Hence there exists $a \in L^{\infty}(\mathbb{R}_+^k)$ such that $\|\sigma' - \gamma_{1,a}\|_{\infty} < \epsilon$. Then

$$\|\sigma - \gamma_{n,a}\|_{\infty} = \|\tau_L^{n-1}\sigma' - \tau_L^{n-1}\gamma_{1,a}\|_{\infty}$$
$$= \|\tau_L^{n-1}\|\|\sigma' - \gamma_{1,a}\|_{\infty} < \epsilon.$$

as $\|\tau_L^{n-1}\| < 1$.

It follows that the C^{*}-algebra generated by \mathfrak{G}_n is the C^{*}-algebra $C_{b,u}(\mathbb{N}_0^k,\rho_k)$.

7. A COMPARISON OF $C_{b,u}(\mathbb{N}_0^k, \rho_k)$ with $C_{b,u}(\mathbb{N}_0, \rho_1) \otimes \cdots \otimes C_{b,u}(\mathbb{N}_0, \rho_1)$

In this section we compare the C^* -algebra $C_{b,u}(\mathbb{N}^k_0,\rho_k)$ with the C^* -tensor product $C_{b,u}(\mathbb{N}_0,\rho_1) \otimes \cdots \otimes C_{b,u}(\mathbb{N}_0,\rho_1)$.

By Corollary 2.17 and the density of \mathfrak{G}_1 in $C_{b,u}(\mathbb{N}_0,\rho_1)$, we have the following proposition.

Proposition 7.1. Let

$$\tilde{\mathfrak{G}}_{n} = \{\gamma_{n,a} | a \in L^{\infty}(\mathbb{R}_{+}) \otimes \cdots \otimes L^{\infty}(\mathbb{R}_{+}) \}.$$

Then \mathfrak{G}_n is dense in $C_{b,u}(\mathbb{N}_0,\rho_1) \otimes \cdots \otimes C_{b,u}(\mathbb{N}_0,\rho_1)$.

We have the inclusions

$$C_{b,u}(\mathbb{N}_0^{k-1},\rho_{k-1})\otimes C_{b,u}(\mathbb{N}_0,\rho_1) \stackrel{\iota_k}{\hookrightarrow} C_{b,u}(\mathbb{N}_0^k,\rho_k).$$

In fact

$$C_{b,u}(\mathbb{N}_0,\rho_1)\otimes\cdots\otimes C_{b,u}(\mathbb{N}_0,\rho_1)\hookrightarrow C_{b,u}(\mathbb{N}_0^k,\rho_k).$$

However, the above inclusions are not necessarily isomorphisms. We present a counter example for k = 2.

7.1. A counter example. Here we construct a counter example to show that $C_{b,u}(\mathbb{N}_0^2, \rho_2)$ is strictly larger than $C_{b,u}(\mathbb{N}_0, \rho_1) \otimes C_{b,u}(\mathbb{N}_0, \rho_1)$. Let

$$I_i: [\sqrt{i}, \sqrt{i} + \pi) \ ; \ i \in \mathbb{N}_0.$$

Define $g: \mathbb{N}_0^2 \to \mathbb{C}$ by

$$g(i,j) = \sin(\sqrt{j} - \sqrt{i})\chi_{I_i}(\sqrt{j}) \quad ; \quad (i,j) \in \mathbb{N}_0^2.$$

Lemma 7.2. Let g be the function defined above. Then $g \in C_{b,u}(\mathbb{N}^2_0, \rho_2)$.

Proof. Clearly g is bounded. First we show that if $|\sqrt{j} - \sqrt{j'}| < \pi$,

$$|g(i,j) - g(i,j')| < |\sqrt{j} - \sqrt{j'}|.$$

If $\sqrt{j}, \sqrt{j'} \notin I_i$,

 $\begin{aligned} |g(i,j) - g(i,j')| &= 0 < |\sqrt{j} - \sqrt{j'}|. \end{aligned}$ W.l.o.g. assume $\sqrt{j} \in I_i$. Then $\sqrt{j'} \in (\sqrt{i} - \pi, \sqrt{i} + 2\pi)$ as $|\sqrt{j} - \sqrt{j'}| < \pi$. Note that if $\sqrt{j'} \in I_i$, $\sin(\sqrt{j'} - \sqrt{i}) = g(j',i)$ and if $\sqrt{j'} \in (\sqrt{i} - \pi, \sqrt{i}) \cup (\sqrt{i} + \pi, \sqrt{i} + 2\pi)$, $\sin(\sqrt{j'} - \sqrt{i}) < 0$. Hence $|g(i,j) - g(i,j')| \le |\sin(\sqrt{j} - \sqrt{i}) - \sin(\sqrt{j'} - \sqrt{i})|$ $< |\sqrt{j} - \sqrt{j'}|$

as required. Next we prove that if $|\sqrt{i} - \sqrt{i'}| < \pi$,

$$|g(i,j) - g(i',j)| < |\sqrt{i} - \sqrt{i'}|.$$

If $\sqrt{j} \notin I_i \cup I_{i'}$, $|g(i,j) - g(i',j)| = 0 < |\sqrt{i} - \sqrt{i'}|$. W.l.o.g., assume that $\sqrt{j} \in I_i$. Then $\sqrt{j} \in (\sqrt{i'} - \pi, \sqrt{i'} + 2\pi)$ as $|\sqrt{i} - \sqrt{i'}| < \pi$. Therefore

$$|g(i,j) - g(i',j)| \le |\sin(\sqrt{j} - \sqrt{i}) - \sin(\sqrt{j} - \sqrt{i'})|$$
$$\le |\sqrt{i} - \sqrt{i'}|,$$

proving the inequality.

Now notice that for all $(i, j), (i', j') \in \mathbb{N}_0^2$ such that $\rho_2((i, j), (i', j')) < \pi$,

$$\begin{aligned} |g(i,j) - g(i',j')| &\leq |g(i,j) - g(i',j)| + |g(i',j) - g(i',j')| \\ &\leq |\sqrt{i} - \sqrt{i'}| + |\sqrt{j} - \sqrt{j'}| \\ &< \rho_2((i,j),(i',j')), \end{aligned}$$

proving that $g \in C_{b,u}(\mathbb{N}_0^2, \rho_2)$.

Definition 7.3. If X is a locally compact Hausdorff space and if A is a C^{*}-algebra equipped with $\|\cdot\|_A$, let $C^b(X, A)$ be the set of all continuous bounded functions $f: X \to A$ equipped with the norm $\|\cdot\|_{\infty}$ given by

$$||f||_{\infty} = \sup_{x \in X} ||f(x)||_A$$

It is well known that $C^b(X, A)$ is C^* -algebra. Recall that a subset of a topological space is said to be precompact if its closure is compact. The following theorem from Williams [W03] describes a criterion to check whether an element in the C*-algebra $C^b(X, A)$ belongs to the possibly smaller C*-algebra $C^b(X) \otimes A$. We will use the Theorem 7.4 to show that $g \notin C_{b,u}(\mathbb{N}_0, \rho_1) \otimes C_{b,u}(\mathbb{N}_0, \rho_1)$.

Theorem 7.4 (Williams [W03]). If X is a locally compact Hausdorff space and if A is a C^* -algebra, then $f \in C^b(X, A)$ is in $C^b(X) \otimes A$ if and only if the range of f, $R(f) := \{f(x) : x \in X\}$, is precompact.

In order to use Theorem 7.4 we present several lemmas about g. The proof of Lemma 7.5 is trivial as \mathbb{N}_0 has discrete topology and g is bounded.

Lemma 7.5. Let g be the function defined above. Define $\tilde{g} : \mathbb{N}_0 \to C_{b,u}(\mathbb{N}_0, \rho_1)$ by

$$\tilde{g}(i) = g(i, \cdot)$$

Then $\tilde{g} \in C^b(\mathbb{N}_0, C_{b,u}(\mathbb{N}_0, \rho_1)).$

Lemma 7.6. Let $\tilde{g} : \mathbb{N}_0 \to C_{b,u}(\mathbb{N}_0, \rho_1)$ be defined as in Lemma 7.5. Then $\|\tilde{g}(i)\|_{\infty} \geq \frac{1}{2}$ for all $i \in \mathbb{N}_0$.

Proof. Notice that for all $i \in \mathbb{N}_0$ and for all $p \in \mathbb{N}$,

$$\sqrt{i+p} - \sqrt{i+p-1} \le 1 < \frac{2\pi}{3}$$

because $\sqrt{i+p} - \sqrt{i+p-1}$ attains its maximum when i+p = 1. Fix $i \in \mathbb{N}_0$. Then the sequence $\{\sqrt{i+p}\}_{p=1}^{\infty}$ contains a point in any interval of length $\frac{2\pi}{3}$ and, in particular, it contains a point in $(\sqrt{i} + \frac{\pi}{6}, \sqrt{i} + \frac{5\pi}{6})$. Denote that point by $\sqrt{i+p_0}$. Then $\sqrt{i+p_0} - \sqrt{i} \in (\frac{\pi}{6}, \frac{5\pi}{6})$ and

$$\begin{split} \|\tilde{g}(i)\|_{\infty} &\geq |(\tilde{g}(i))(i+p_0)| \\ &= \sin(\sqrt{i+p_0} - \sqrt{i}) \\ &\geq \frac{1}{2}. \end{split}$$

Lemma 7.7. Let $\tilde{g} : \mathbb{N}_0 \to C_{b,u}(\mathbb{N}_0, \rho_1)$ be defined as in Lemma 7.5. Then the range of \tilde{g} is not precompact.

Proof. Whenever $|\sqrt{i_1} - \sqrt{i_2}| > \pi$, $I_{i_1} \cap I_{i_2} = \emptyset$ and hence

$$\|\tilde{g}(i_1) - \tilde{g}(i_2)\|_{\infty} = \max\{\|\tilde{g}(i_1)\|_{\infty}, \|\tilde{g}(i_2)\|_{\infty}\} \ge \frac{1}{2}.$$

Thus there exits a sequence $\{\tilde{g}(i_s)\}_{s=1}^{\infty}$ s.t. $\|\tilde{g}(i_{s_1}) - \tilde{g}(i_{s_2})\|_{\infty} \geq \frac{1}{2}$ whenever $s_1 \neq s_2$. It follows that the range of \tilde{g} is not totally bounded and hence it is not precompact.

By Lemma 7.5, Lemma 7.7, and Theorem 7.4, we have that $g \notin C_{b,u}(\mathbb{N}_0, \rho_1) \otimes C_{b,u}(\mathbb{N}_0, \rho_1)$. Also by Lemma 7.2, $g \in C_{b,u}(\mathbb{N}_0^2, \rho_2)$. Hence we have the following proposition.

Proposition 7.8. $C_{b,u}(\mathbb{N}_0^2,\rho_2)$ is strictly larger than $C_{b,u}(\mathbb{N}_0,\rho_1) \otimes C_{b,u}(\mathbb{N}_0,\rho_1)$.

8. Appendix: The proof of Lemma 3.4

In this appendix, we present the proof of Lemma 3.4. It is easy to see that $f|_{\mathbb{N}_0^k} = \sigma$, from the definition of f.

8.1. The uniform norm of f. To show that $||f||_{\infty} = ||\sigma||_{\infty}$, we will use the following lemma.

Lemma 8.1. Let $s \in \mathbb{N}$ and let $a_i \in (0, 1)$ for all $i = 1, \ldots, s$ Then

$$1 + \sum_{l=1}^{s} (-1)^{l} \sum_{\substack{i_1, \dots, i_l \in \{1, \dots, s\}\\i_1 < \dots < i_l\\19}} \prod_{q=1}^{l} a_{i_q} \ge 0$$

Proof. Notice that the statement is true for s = 1. Assume the result is true for s. Then

$$1 + \sum_{l=1}^{s+1} (-1)^l \sum_{\substack{i_1, \dots, i_l \in \{1, \dots, s+1\}\\ i_1 < \dots < i_l}} \prod_{q=1}^l a_{i_q} = 1 + \sum_{l=1}^s (-1)^l \sum_{\substack{i_1, \dots, i_l \in \{1, \dots, s\}\\ i_1 < \dots < i_l}} \prod_{q=1}^l a_{i_q}} \prod_{q=1}^l a_{i_q} - a_{s+1} \left(1 + \sum_{l=1}^s (-1)^l \sum_{\substack{i_1, \dots, i_l \in \{1, \dots, s\}\\ i_1 < \dots < i_l}} \prod_{q=1}^l a_{i_q} \right) = (1 - a_{s+1}) \left(1 + \sum_{l=1}^s (-1)^l \sum_{\substack{i_1, \dots, i_l \in \{1, \dots, s\}\\ i_1 < \dots < i_l}} \prod_{q=1}^l a_{i_q} \right) \\ \ge 0.$$

Hence the statement is true by induction on s.

Note that f_m can also be written as

$$f_{m}(\boldsymbol{x}) = \sigma(\boldsymbol{m})B_{0}(\boldsymbol{x}, \boldsymbol{m}) + \sum_{\substack{j_{1}, \dots, j_{s} \in \{1, \dots, k\}\\ j_{1} < \dots < j_{s}}} \sigma(\boldsymbol{m} + e_{j_{1}} + \dots + e_{j_{s}})B_{j_{1}, \dots, j_{s}}(\boldsymbol{x}, \boldsymbol{m})$$

where

$$B_{j_1,\dots,j_s}(\boldsymbol{x},\boldsymbol{m}) = \prod_{p=1}^s \frac{\sqrt{x_{j_p}} - \sqrt{m_{j_p}}}{\sqrt{m_{j_p} + 1} - \sqrt{m_{j_p}}} \left(1 + \sum_{l=1}^{k-s} (-1)^l \sum_{\substack{i_1,\dots,i_l \in \{1,\dots,k\} \setminus \{j_1,\dots,j_s\} \\ i_1 < \dots < i_l}} \prod_{q=1}^l \frac{\sqrt{x_{i_q}} - \sqrt{m_{i_q}}}{\sqrt{m_{i_q} + 1} - \sqrt{m_{i_q}}} \right)$$

and

$$B_0(\boldsymbol{x}, \boldsymbol{m}) = 1 + \sum_{l=1}^k (-1)^l \sum_{\substack{i_1, \dots, i_l \in \{1, \dots, k\} \\ i_1 < \dots < i_l}} \prod_{q=1}^l \frac{\sqrt{x_{i_q}} - \sqrt{m_{i_q}}}{\sqrt{m_{i_q}} + 1 - \sqrt{m_{i_q}}}.$$

The coefficients $B_{j_1,\ldots,j_s}(\boldsymbol{x},\boldsymbol{m})$ are computed by summing the products

$$(-1)^{l-s} \prod_{q=1}^{l} \frac{\sqrt{x_{j_q}} - \sqrt{m_{j_q}}}{\sqrt{m_{j_q} + 1} - \sqrt{m_{j_q}}}$$

over $\{i_1, \ldots, i_l\}$ such that $i_1 < \cdots < i_l$ and $\{j_1, \ldots, j_s\} \subset \{i_1, \ldots, i_l\}$.

Consider the sum

$$B_0(m{x},m{m}) + \sum_{\substack{j_1,...,j_s \in \{1,...,k\} \ j_1 < \cdots < j_s}} B_{j_1,...,j_s}(m{x},m{m}).$$

Let $l \in \mathbb{N}$ and let $i_1, \ldots, i_l \in \{1, \ldots, k\}$ such that $i_1 < \cdots < i_l$. Note that $(-1)^{l-s} \prod_{q=1}^l \frac{\sqrt{x_{i_q}} - \sqrt{m_{i_q}}}{\sqrt{m_{i_q}} + 1 - \sqrt{m_{i_q}}}$ is a term in $B_{j_1,\ldots,j_s}(\boldsymbol{x}, \boldsymbol{m})$ whenever $\{j_1,\ldots,j_s\} \subset \{i_1,\ldots,i_l\}$. Therefore in the above sum, the coefficient of $\prod_{q=1}^l \frac{\sqrt{x_{i_q}} - \sqrt{m_{i_q}}}{\sqrt{m_{i_q}} + 1 - \sqrt{m_{i_q}}}$ is given by

$$\sum_{s=0}^{l} (-1)^{l-s} \binom{l}{s} = (1-1)^{l} = 0.$$
20

Hence

$$B_0(\boldsymbol{x}, \boldsymbol{m}) + \sum_{\substack{j_1, \dots, j_s \in \{1, \dots, k\} \ j_1 < \dots < j_s}} B_{j_1, \dots, j_s}(\boldsymbol{x}, \boldsymbol{m}) = 1.$$

Also, if $\boldsymbol{x} \in \prod_{i=1}^{k} [m_i, m_i + 1), B_{j_1, \dots, j_s}(\boldsymbol{x}, \boldsymbol{m}) \ge 0$ by Lemma 8.1 and hence

$$|f_{\boldsymbol{m}}(\boldsymbol{x})| \leq \|\sigma\|_{\infty} \left(B_0(\boldsymbol{x}, \boldsymbol{m}) + \sum_{\substack{j_1, \dots, j_s \in \{1, \dots, k\}\\ j_1 < \dots j_s}} B_{j_1, \dots, j_s}(\boldsymbol{x}, \boldsymbol{m}) \right)$$
$$= \|\sigma\|_{\infty}.$$

Therefore $||f||_{\infty} = ||\sigma||_{\infty}$ as $f|_{\mathbb{N}_0^k} = \sigma$.

8.2. Some useful lemmas. The following lemma is quite useful in the proofs that follow. Lemma 8.2. Let $l, s \in \{1, ..., k\}$. Suppose $i_1, ..., i_l \in \{1, ..., k\}$ such that $i_1 < \cdots < i_l$. Then $a_{i_1,...,s_l}^{l+1}(\boldsymbol{m}) = a_{i_1,...,i_l}^l(\boldsymbol{m} + e_s) - a_{i_1,...,i_l}^l(\boldsymbol{m})$

Proof. To keep the notations simple, we will assume $s > i_l$ and we label s by i_{l+1} .

$$\begin{split} a_{i_{1},\dots,i_{l+1}}^{l+1}(\boldsymbol{m}) &= \sum_{q=0}^{l+1} (-1)^{l+1-q} \sum_{\substack{j_{1},\dots,j_{q} \in \{i_{1},\dots,i_{l+1}\}\\j_{1} < \dots < j_{q}}} \sigma(\boldsymbol{m} + e_{j_{1}} + \dots + e_{j_{q}}) \\ &= (-1)^{l+1} \sigma(\boldsymbol{m}) + \sum_{q=1}^{l} (-1)^{l+1-q} \left(\sum_{\substack{j_{1},\dots,j_{q} \in \{i_{1},\dots,i_{l}\}\\j_{1} < \dots < j_{q}}} \sigma(\boldsymbol{m} + e_{j_{1}} + \dots + e_{j_{q}}) \right) \\ &+ \sum_{\substack{j_{1},\dots,j_{q-1} \in \{i_{1},\dots,i_{l}\}\\j_{1} < \dots < j_{q-1} \in \{i_{1},\dots,i_{l}\}}} \sigma(\boldsymbol{m} + e_{j_{1}} + \dots + e_{j_{q-1}} + e_{i_{l}}) \right) + \sigma(\boldsymbol{m} + e_{i_{1}} + \dots + e_{i_{l}}) \\ &= -\sum_{q=0}^{l} (-1)^{l-q} \sum_{\substack{j_{1},\dots,j_{q} \in \{i_{1},\dots,i_{l}\}\\j_{1} < \dots < j_{q-1} \in \{i_{1},\dots,i_{l}\}}} \sigma(\boldsymbol{m} + e_{j_{1}} + \dots + e_{j_{q}}) \\ &+ \sum_{q=1}^{l} (-1)^{l+1-q} \sum_{\substack{j_{1},\dots,j_{q-1} \in \{i_{1},\dots,i_{l}\}\\j_{1} < \dots < j_{q-1} \in \{i_{1},\dots,i_{l}\}}} \sigma(\boldsymbol{m} + e_{i_{l}} + e_{j_{1}} + \dots + e_{j_{q-1}}) \\ &= -a_{i_{1},\dots,i_{l}}^{l}(\boldsymbol{m}) + \sum_{q=0}^{l} (-1)^{l-q} \sum_{\substack{j_{1},\dots,j_{q-1} \in \{i_{1},\dots,i_{l}\}\\j_{1} < \dots < j_{q-1} \in \{i_{1},\dots,i_{l}\}}} \sigma((\boldsymbol{m} + e_{i_{l}}) + e_{j_{1}} + \dots + e_{j_{q}}) \\ &= a_{i_{1},\dots,i_{l}}^{l}(\boldsymbol{m} + e_{l+1}) - a_{i_{1},\dots,i_{l}}^{l}(\boldsymbol{m}). \\ \Box$$

Notice that f is defined on $\prod_{i=1}^{k} [m_i, m_i + 1)$ by f_m . But the following lemma allows f to be defined on $\prod_{i=1}^{k} [m_i, m_i + 1]$ by f_m .

Lemma 8.3. Let $\boldsymbol{x} \in \mathbb{R}^k_+$, $\boldsymbol{m} \in \mathbb{N}^k_0$ and let $s \in \{1, \dots, k\}$. Suppose $\lfloor x_i \rfloor = m_i$ for all i. Then $f(\boldsymbol{x} + (1 - x_s)e_s) = f_{\boldsymbol{m}}(\boldsymbol{x} + (1 - x_s)e_s).$

Proof. Note that the s^{th} coordinate of $\boldsymbol{x} + (1 - x_s)e_s$ is $m_s + 1$. Therefore

$$f_{m}(\boldsymbol{x} + (1 - x_{s})e_{s}) = \sigma(\boldsymbol{m}) + \sum_{l=1}^{k-1} \sum_{\substack{i_{1}, \dots, i_{l} \in \{1, \dots, k\} \\ i_{1} < \dots < i_{l}}} a_{i_{1}, \dots, i_{l}}^{l}(\boldsymbol{m}) \prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}} - \sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}} + 1} - \sqrt{m_{i_{q}}}}$$
$$+ a_{s}^{1} + \sum_{l=2}^{k} \sum_{\substack{i_{1}, \dots, i_{l} \in \{1, \dots, k\} \\ i_{1} < \dots < i_{l}}} a_{i_{1}, \dots, i_{l}}^{l}(\boldsymbol{m}) \prod_{\substack{q=1 \\ i_{q} \neq s}}^{l} \frac{\sqrt{x_{i_{q}}} - \sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}} + 1} - \sqrt{m_{i_{q}}}}$$
$$= \sigma(\boldsymbol{m} + e_{s}) + \left(\sum_{\substack{l=1 \\ l=1 \\ i_{1}, \dots, i_{l} \in \{1, \dots, k\} \\ i_{1} < \dots < i_{l}}} \sum_{\substack{(a_{l_{1}, \dots, i_{l}}) \\ i_{1} < \dots < i_{l}}} (a_{i_{1}, \dots, i_{l}}^{l}(\boldsymbol{m}) + a_{i_{1}, \dots, s, \dots, i_{l}}^{l+1}(\boldsymbol{m}))\right)$$
$$\times \prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}} - \sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}} + 1} - \sqrt{m_{i_{q}}}}\right)$$

by reindexing the last summand and because $\sigma(\boldsymbol{m}) + a_s^1 = \sigma(\boldsymbol{m} + e_s)$. Also,

$$a_{i_1,\dots,i_l}^l(\boldsymbol{m}) + a_{i_1,\dots,s,\dots,i_l}^{l+1}(\boldsymbol{m}) = a_{i_1,\dots,i_l}^l(\boldsymbol{m} + e_s)$$

by Lemma 8.2. Then

$$f_{\boldsymbol{m}}(\boldsymbol{x} + (1 - x_{s})e_{s}) = \sigma(\boldsymbol{m} + e_{s}) + \sum_{l=1}^{k-1} \sum_{\substack{i_{1}, \dots, i_{l} \in \{1, \dots, k\} \setminus \{s\}\\i_{1} < \dots < i_{l}}} a_{i_{1}, \dots, i_{l}}^{l}(\boldsymbol{m} + e_{s}) \prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}} - \sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}} + 1} - \sqrt{m_{i_{q}}}}$$
$$= f_{\boldsymbol{m} + e_{s}}(\boldsymbol{x} + (1 - x_{s})e_{s})$$
$$= f(\boldsymbol{x} + (1 - x_{s})e_{s}).$$

The second equality in the above computation holds as the s^{th} coordinate of $\mathbf{x} + (1 - x_s)e_s$ is $m_s + 1$ and hence any term in $f_{m+e_s}(\mathbf{x} + (1 - x_s)e_s)$ indexed by $\{i_1, \ldots, i_l\}$ would vanish if $s \in \{i_1, \ldots, i_l\}$.

As a consequence of above lemma, we have the following corollary.

Corollary 8.4. Let $\boldsymbol{m} \in \mathbb{N}_0^k$ and let $\boldsymbol{x} \in \prod_{i=1}^k [m_i, m_i + 1]$. Then

$$f(\boldsymbol{x}) = f_{\boldsymbol{m}}(\boldsymbol{x}).$$

Lemma 8.5. Let $l \in \mathbb{N}$ and let $a_i, b_i \in \mathbb{C}$ such that $|a_i|, |b_i| \leq 1$ for all $i = 1, \ldots, l$. Then

$$\left| \prod_{i=1}^{l} a_i - \prod_{i=1}^{l} b_i \right| \le \sum_{i=1}^{l} |a_i - b_i|.$$

Proof. Clearly, the result holds for l = 1. Assume that the result is true for l. Then by triangle inequality,

$$\begin{split} \left| \prod_{i=1}^{l+1} a_i - \prod_{i=1}^{l+1} b_i \right| &\leq |a_{l+1} - b_{l+1}| \left| \prod_{i=1}^l a_i \right| + |b_{l+1}| \left| \prod_{i=1}^l a_i - \prod_{i=1}^l b_i \right| \\ &\leq |a_{l+1} - b_{l+1}| + \left| \prod_{i=1}^l a_i - \prod_{i=1}^l b_i \right| \\ &\leq \sum_{i=1}^{l+1} |a_i - b_i|. \end{split}$$

Hence, the result is true by induction on l.

8.3. The uniform continuity of f with respect to the square-root metric. Let $x, x' \in \mathbb{R}^k_+$ s.t. $\rho_k(x, x') < \delta$. Let $m = (m_1, \ldots, m_k)$ and $m' = (m'_1, \ldots, m'_k)$ where $m_i = \lfloor x_i \rfloor$ and $m'_i = \lfloor x'_i \rfloor$ for $i = 1, \ldots, k$. Case I. Assume $x'_i \in [m_i, m_{i+1}]$ for all i. Then by Corollary 8.4

$$\begin{split} |f(\boldsymbol{x}) - f(\boldsymbol{x}')| &\leq \sum_{l=1}^{k} \sum_{\substack{i_1, \dots, i_l \in \{1, \dots, k\} \\ i_1 < \dots < i_l}} |a_{i_1, \dots, i_l}^l(\boldsymbol{m})| \\ &\times \left| \prod_{q=1}^{l} \frac{\sqrt{x_{i_q}} - \sqrt{m_{i_q}}}{\sqrt{m_{i_q} + 1} - \sqrt{m_{i_q}}} - \prod_{q=1}^{l} \frac{\sqrt{x'_{i_q}} - \sqrt{m_{i_q}}}{\sqrt{m_{i_q} + 1} - \sqrt{m_{i_q}}} \right| \\ &\leq \sum_{l=1}^{k} \sum_{\substack{i_1, \dots, i_l \in \{1, \dots, k\} \\ i_1 < \dots < i_l}} |a_{i_1, \dots, i_l}^l(\boldsymbol{m})| \sum_{q=1}^{l} \frac{|\sqrt{x_{i_q}} - \sqrt{x'_{i_q}}|}{\sqrt{m_{i_q} + 1} - \sqrt{m_{i_q}}} \end{split}$$

by Lemma 8.5.

Fix $l \in \{1, \dots, k\}$ and $i_1, \dots, i_l \in \{1, \dots, k\}$ s.t. $i_1 < \dots < i_l$. If $\sqrt{m_{i_q} + 1} - \sqrt{m_{i_q}} \ge \sqrt{\delta}$ for all $q = 1, \dots, l$,

$$\begin{aligned} |a_{i_1,\dots,i_l}^l(\boldsymbol{m})| \sum_{q=1}^l \frac{|\sqrt{x_{i_q}} - \sqrt{x_{i_q}'}|}{\sqrt{m_{i_q} + 1} - \sqrt{m_{i_q}}} &\leq |a_{i_1,\dots,i_l}^l(\boldsymbol{m})| \frac{l\delta}{\sqrt{\delta}} \\ &\leq 2^l l \|\sigma\|_{\infty} \sqrt{\delta} \end{aligned}$$

as $|a_{i_1,\ldots,i_l}^l(\boldsymbol{m})| \leq 2^l \|\sigma\|_{\infty}$. Assume $\sqrt{m_{i_q}+1} - \sqrt{m_{i_q}} < \sqrt{\delta}$ for some $q \in \{1,\ldots,l\}$. W.l.o.g. assume $\sqrt{m_{i_l}+1} - \sqrt{m_{i_l}} < \sqrt{\delta}$.

$$\begin{split} \text{If } l &\geq 2, \\ |a_{i_1,\dots,i_l}^l(\boldsymbol{m})| \\ &= |a_{i_1,\dots,i_l}^{l-1}(\boldsymbol{m} + e_{i_l}) - a_{i_1,\dots,i_l}^{l-1}(\boldsymbol{m})| \\ &\leq \sum_{\substack{j_1,\dots,j_q \in \{i_1,\dots,i_{l-1}\}\\q \in \{0,\dots,l-1\}}} |\sigma(\boldsymbol{m} + e_{j_1} + \dots + e_{j_q} + e_{i_l}) - \sigma(\boldsymbol{m} + e_{j_1} + \dots + e_{j_q})| \\ &\leq 2^{l-1} \omega_{\rho_k,\sigma}(\sqrt{\delta}). \end{split}$$

Hence

$$|f(\boldsymbol{x}) - f(\boldsymbol{x}')| \leq \sum_{l=1}^{k} \sum_{\substack{i_1, \dots, i_l \in \{1, \dots, k\}\\ i_1 < \dots < i_l}} 2^{l-1} l \max\{2 \|\sigma\|_{\infty} \sqrt{\delta}, \omega_{\rho_k, \sigma}(\sqrt{\delta})\}$$
$$= A_k \max\{2 \|\sigma\|_{\infty} \sqrt{\delta}, \omega_{\rho_k, \sigma}(\sqrt{\delta})\}$$

where $A_k = k! \sum_{l=1}^k \frac{2^{l-1}}{(l-1)!(k-l)!}$. Case II. Suppose $x'_i \notin [m_i, m_i + 1]$ for some *i*. Define $\boldsymbol{p} = (p_1, \dots, p_k), \boldsymbol{p}' = (p'_1, \dots, p'_k) \in \mathbb{N}_0^k$ by

$$p_i = m_i + 1, \ p'_i = m'_1 \quad \text{if } x_i < x'_i \\ p_i = m_i, \ p'_i = m'_1 + 1 \quad \text{if } x_i > x'_i \\ p_i = m_i = m'_i = p'_i \quad \text{if } x_i = x'_i \end{cases}$$

for i = 1, ..., k. Then $p_i \in [m_i, m_i + 1]$ and $p'_i \in [m'_i, m'_1 + 1]$ for all i. Hence by case I and because $\rho_k(\boldsymbol{p}, \boldsymbol{p}') \le \rho_k(\boldsymbol{x}, \boldsymbol{x}') < \delta,$

$$\begin{split} |f(\boldsymbol{x}) - f(\boldsymbol{x}')| &\leq |f(\boldsymbol{x}) - f(\boldsymbol{p})| + |\sigma(\boldsymbol{p}) - \sigma(\boldsymbol{p}')| + |f(\boldsymbol{p}') - f(\boldsymbol{x}')| \\ &\leq 2A_k \max\{2\|\sigma\|_{\infty}\sqrt{\delta}, \omega_{\rho_k,\sigma}(\sqrt{\delta})\} + \omega_{\rho_k,\sigma}(\delta). \end{split}$$

In both cases,

$$|f(\boldsymbol{x}) - f(\boldsymbol{x}')| \le 2A_k \max\{2\|\sigma\|_{\infty}\sqrt{\delta}, \omega_{\rho_k,\sigma}(\sqrt{\delta})\} + \omega_{\rho_k,\sigma}(\delta).$$

Therefore $f \in C_{b,u}(\mathbb{N}_0^k, \rho_k)$. This completes the proof of Lemma 3.4.
