# TOEPLITZ OPERATORS ON THE FOCK SPACE WITH QUASI-RADIAL SYMBOLS

#### Abstract

The Fock space $\mathcal{F}\left(\mathbb{C}^{n}\right)$ is the space of holomorphic functions on $\mathbb{C}^{n}$ that are squareintegrable with respect to the Gaussian measure on $\mathbb{C}^{n}$. This space plays an important role in several subfields of analysis and representation theory. In particular, it has for a long time been a model to study Toeplitz operators. Esmeral and Maximenko showed in 2016 that radial Toeplitz operators on $\mathcal{F}(\mathbb{C})$ generate a commutative $C^{*}$-algebra which is isometrically isomorphic to the $C^{*}$-algebra $C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$. In this article, we extend the result to $k$-quasi-radial symbols acting on the Fock space $\mathcal{F}\left(\mathbb{C}^{n}\right)$. We calculate the spectra of the said Toeplitz operators and show that the set of all eigenvalue functions is dense in the $C^{*}$-algebra $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ of bounded functions on $\mathbb{N}_{0}^{k}$ which are uniformly continuous with respect to the square-root metric. In fact, the $C^{*}$-algebra generated by Toeplitz operators with quasi-radial symbols is $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$.

## 1. Introduction

Reproducing kernel Hilbert spaces $\mathcal{H}$ of square integrable holomorphic functions on complex domains plays an important role in several subfields of analysis and representation theory [B61].

[^0]Those spaces lead to a very simple form of quantization, B75a, B75b, EU10, EU11] turning functions into bounded operators on $\mathcal{H}$, by using Toeplitz operators $T_{\varphi}(f)=P(\varphi f)$, where $P$ is the orthogonal projection onto $\mathcal{H}$. These operators have been studied for a long time, [BC86, BI12, BL11, BS06, C94].

Since the fundamental work GV02, GQV06, and then later several authors have studied $C^{*}$ algebras generated by subclasses of bounded symbols asking the question which of them lead to commutative $C^{*}$-algebras as in DÓQ15, DÓQ18, DÓQ21, DQ18, EM16, GMV13, GKV03, QS11, QV07a, QV07b, QV08, V08. In the case of commutative $C^{*}$-algebras, the next natural question is to determine the spectrum and, if possible, determine the Gelfand transform. This is often achieved by constructing a transform that maps Toeplitz operators to multiplier operators on an $L^{2}$ space.

In the special case of the unit ball in $\mathbb{C}^{n}$, it was shown that Toeplitz operators with radial symbols acting on the Bergman space generate a commutative $C^{*}$-algebra as in GKV03 and the corresponding $C^{*}$-algebra is isometrically isomorphic to the space of bounded sequences that are uniformly continuous with respect to the logarithmic metric [GMV13. Toeplitz operators with radial symbols on the Fock space $\mathcal{F}(\mathbb{C})$ generate a commutative $C^{*}$-algebra GV02 which is isometrically isomorphic to the $C^{*}$-algebra $C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$ of bounded sequences that are uniformly continuous with respect to the square-root metric [EM16]. Furthermore, a more general theory for weighted Bergman spaces on any bounded symmetric domain was formulated in [DÓQ15], using representation theory.

In this paper, we consider the $C^{*}$-algebra generated by Toeplitz operators with $k$-quasi-radial symbols, discussed in BV12, MSR16, V10a, V10b, QS14, QS15, acting on the Fock space $\mathcal{F}\left(\mathbb{C}^{n}\right)$. As an instance of the general theory discussed in [DOQ15], the generated $C^{*}$-algebra is commutative. We compute the eigenvalue functions of Toeplitz operators with quasi-radial symbols and then show that they are dense in the space $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ of bounded functions on $\mathbb{N}_{0}^{k}$ that are uniformly continuous with respect to the square-root metric. As a consequence, the $C^{*}$-algebra generated by Toeplitz operators with $k$-quasi-radial symbols is isometrically isomorphic to the $C^{*}$-algebra $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$.

We now introduce some notations and recall the following well known facts about the Fock space. Denote by $d \lambda_{n}$ the Gaussian measure $d \lambda_{n}(z)=\frac{1}{\pi^{n}} e^{-|z|^{2}} d z$ for $z \in \mathbb{C}^{n}$, where $d z$ is the Lebesgue measure on $\mathbb{C}^{n} \simeq \mathbb{R}^{2 n}$. The Fock space $\mathcal{F}\left(\mathbb{C}^{n}\right)$ is the Hilbert space of all holomorphic functions on $\mathbb{C}^{n}$ that are square integrable with respect to $d \lambda_{n}$,

$$
\mathcal{F}\left(\mathbb{C}^{n}\right)=L^{2}\left(\mathbb{C}^{n}, \lambda_{n}\right) \cap \mathcal{O}\left(\mathbb{C}^{n}\right)
$$

The point-evalutation maps $f \mapsto f(z)$ are continuous and hence $\mathcal{F}\left(\mathbb{C}^{n}\right)$ is a reproducing kernel Hilbert space with the reproducing kernel $K$ given by $K(w, z)=K_{z}(w)=e^{w \bar{z}}$, for $(z, w) \in \mathbb{C}^{2 n}$ (here $\bar{z} w$ denotes the scalar product $\left.w_{1} \bar{z}_{1}+\cdots+w_{k} \bar{z}_{k}\right)$. Thus for $z \in \mathbb{C}^{n}$ and $f \in \mathcal{F}\left(\mathbb{C}^{n}\right)$ we have

$$
f(z)=\left\langle f, K_{z}\right\rangle
$$

with the inner product of $L^{2}\left(\mathbb{C}^{n}, \lambda_{n}\right)$.
The Bergman projection $P: L^{2}\left(\mathbb{C}^{n}\right) \rightarrow \mathcal{F}\left(\mathbb{C}^{n}\right)$ is given by

$$
P f(z)=\left\langle f, K_{z}\right\rangle .
$$

$P$ is a bounded linear operator with $\|P\|=1$.
Given $\varphi \in L^{\infty}\left(\mathbb{C}^{n}\right)$, we define the Toeplitz operator $T_{\varphi}: \mathcal{F}\left(\mathbb{C}^{n}\right) \rightarrow \mathcal{F}\left(\mathbb{C}^{n}\right)$ by

$$
T_{\varphi} f(z)=P(\varphi f)(z)=\int_{\mathbb{C}^{n}} \varphi(w) f(w) \overline{K_{z}(w)} d \lambda_{n}(w) .
$$

As the multiplier operator $M_{\varphi}: L^{2}\left(\mathbb{C}^{n}, \lambda\right) \rightarrow L^{2}\left(\mathbb{C}^{n}, \lambda\right)$ is bounded of norm $\|\varphi\|_{\infty}$ and $P$ is bounded, it follows that $T_{\varphi}$ is bounded and $\left\|T_{\varphi}\right\| \leq\|\varphi\|_{\infty}$. The function $\varphi$ is called the symbol of the Toeplitz operator $T_{\varphi}$.

Grudsky and Vasilevski GV02 showed that the eigenvalue sequences of radial Toeplitz operators on $\mathcal{F}(\mathbb{C})$ are of the form

$$
\gamma_{1, a}(m)=\frac{1}{m!} \int_{0}^{\infty} a(\sqrt{r}) r^{m} e^{-r} d r .
$$

We prove that the Toeplitz operators with $k$-quasi-radial symbols diagonalize with eigenvalue functions given by

$$
\gamma_{\boldsymbol{n}, a}(\boldsymbol{m})=\frac{1}{(\boldsymbol{m}+\boldsymbol{n}-\mathbf{1})!} \int_{\mathbb{R}_{+}^{k}} a\left(\sqrt{r_{1}}, \ldots, \sqrt{r_{k}}\right) r^{\boldsymbol{m}+\boldsymbol{n}-\mathbf{1}} e^{-\left(r_{1}+\cdots+r_{k}\right)} d r
$$

for any $\boldsymbol{m} \in \mathbb{N}_{0}^{k}$, where $\boldsymbol{n}=\left(n_{1}, \ldots, n_{k}\right)$.
As a corollary the eigenvalue sequences of radial Toeplitz operators on $\mathcal{F}\left(\mathbb{C}^{n}\right)$ are of the form

$$
\gamma_{n, a}(m)=\frac{1}{(m+n-1)!} \int_{0}^{\infty} a(\sqrt{r}) r^{m+n-1} e^{-r} d r
$$

which are the $(n-1)^{\text {th }}$ left shift of $\gamma_{1, a}$.
To prove eigenvalue function of Toeplitz operators with $k$-quasi-radial symbols is dense in the $C^{*}$-algebra $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$, we follow some of the ideas in the work by Esmeral and Maximenko [EM16].

## 2. Toeplitz operators with bounded $k$-Quasi-Radial symbols

In this section, we introduce quasi-radial symbols and diagonalize the Toeplitz operators with quasi-radial symbols.

We begin with some notations. Let $k \in \mathbb{N}$ and let $\boldsymbol{n}=\boldsymbol{n}(k)=\left(n_{1}, \ldots, n_{k}\right) \in \mathbb{N}^{k}$ and let $n=n_{1}+\cdots+n_{k}$. Let $\mathbb{C}^{n}=\mathbb{C}^{n_{1}} \times \cdots \times \mathbb{C}^{n_{k}}$. We identify $z \in \mathbb{C}^{n}$ by $z=\left(z_{(1)}, \cdots, z_{(k)}\right) \in \mathbb{C}^{n}$ where $z_{(j)} \in \mathbb{C}^{n_{j}}$. Consider the group $G=\mathrm{U}_{n_{1}} \times \cdots \times \mathrm{U}_{n_{k}}$ where $\mathrm{U}_{n_{i}}$ are $n_{i} \times n_{i}$ unitary matrices. They act on $f$ defined on $\mathbb{C}^{n}$ by $\left(A_{1}, \ldots A_{k}\right) f(z)=\left(A_{1}, \ldots, A_{k}\right) f\left(z_{(1)}, \cdots, z_{(k)}\right):=f\left(A_{1}^{-1} z_{(1)}, \ldots A_{k}^{-1} z_{(k)}\right)$ which is the usual action of matrices we get by considering $G$ as a subgroup of $\mathrm{U}_{n}$. The action leaves the Gaussian measure $d \lambda_{n}(z)=d \lambda_{n_{1}}\left(z_{(1)}\right) \ldots d \lambda_{n_{k}}\left(z_{(k)}\right)$ invariant.
Definition 2.1. Let $\varphi: \mathbb{C}^{n} \rightarrow \mathbb{C}$ be measurable. The function $\varphi$ is said to be $G$-invariant if for all $\left(A_{1}, \ldots A_{k}\right) \in G$ and $z \in \mathbb{C}^{n}$ we have $\left(A_{1}, \ldots A_{k}\right) \varphi(z)=\varphi\left(A_{1}^{-1} z_{(1)}, \ldots A_{k}^{-1} z_{(k)}\right)=\varphi(z)$.

Define the set of all $k$-quasi-radial symbols, denoted by $L^{\infty}\left(\mathbb{C}^{n}\right)^{G}$, to be the set of all essentially bounded functions on $\mathbb{C}^{n}$ that are $G$-invariant. The case $k=1$ corresponds to radial symbols and the case $n=k$ corresponds to separately radial symbols. Now we take into consideration the $C^{*}$-algebra $\mathcal{T}_{G}$ generated by Toeplitz operators with symbols in $L^{\infty}\left(\mathbb{C}^{n}\right)^{G}$. The main objective of this section is to diagonalize the Toeplitz operators with symbols in $L^{\infty}\left(\mathbb{C}^{n}\right)^{G}$.

### 2.1. A classification of the class of symbols $L^{\infty}\left(\mathbb{C}^{n}\right)^{G}$.

Definition 2.2. Let $\varphi: \mathbb{C}^{q} \rightarrow \mathbb{C}$ be measurable. The function $\varphi$ is said to be,
(1) radial if there exists a measurable function $a_{\varphi}: \mathbb{R}_{+} \rightarrow \mathbb{C}$ such that $\varphi(z)=a_{\varphi}(|z|)$ for $z \neq 0$.
(2) $\mathrm{U}_{q}$-invariant if for all $A \in \mathrm{U}_{q}$ and $z \in \mathbb{C}^{q}$ we have $\varphi(A z)=\varphi(z)$.

Following lemma is a well-known fact.
Lemma 2.3. The measurable function $\varphi: \mathbb{C}^{q} \rightarrow \mathbb{C}$ is $\mathrm{U}_{q}$-invariant if and only if there exists $a: \mathbb{R}_{+} \rightarrow \mathbb{C}$ such that $\varphi(z)=a(|z|)$.

Proof. As $|A z|=|z|$ for $A \in \mathrm{U}_{q}$, it follows that any function of the form $\varphi(z)=a(|z|)$ is $\mathrm{U}_{q^{-}}$ invariant. As $z \mapsto|z|$ is continuous it follows that $\varphi$ is measurable if and only if $a$ is measurable.

Assume that $\varphi$ is $\mathrm{U}_{q}$-invariant. Define $a_{\varphi}(r)=\varphi\left(r e_{1}\right)$. Then $a_{\varphi}$ is measurable. Let $z \in \mathbb{C}^{q}$. Then, as $\mathrm{U}_{q}$ acts transitively on the sphere $\mathrm{S}^{2 q-1}$, there exist $A \in \mathrm{U}_{q}$ such that $A z=|z| e_{1}$. Thus

$$
\varphi(z)=\varphi(A z)=\varphi\left(|z| e_{1}\right)=a_{\varphi}(|z|)
$$

Thus $\varphi(z)=a_{\varphi}(|z|)$.
The following lemma is a consequence of Lemma 2.3.
Lemma 2.4. The measurable function $\varphi: \mathbb{C}^{n} \rightarrow \mathbb{C}$ is $G$-invariant if and only if there exists $a: \mathbb{R}_{+}^{k} \rightarrow \mathbb{C}$ such that $\varphi(z)=a\left(\left|z_{(1)}\right|, \ldots,\left|z_{(k)}\right|\right)$.
2.2. Diagonalization by Schur's lemma. Let $\pi$ and $\sigma$ be unitary representations of a topological group H. A continuous linear map $T: V_{\pi} \rightarrow V_{\sigma}$ is an intertwining operator if for all $A \in H$ commutating relation $T \pi(A)=\sigma(A) T$ holds. $\pi$ and $\sigma$ are equivalent if there exists an unitary isomorphism that intertwines $\pi$ and $\sigma$. Finally if $\pi$ is irreducible and $T$ is an intertwining operator then Schur's lemma says that $T=\lambda$ id for some $\lambda \in \mathbb{C}$.

Since the action of $G$ is defined by the action of $\mathrm{U}_{n_{i}}$ on $\mathcal{F}^{2}\left(\mathbb{C}^{n_{i}}\right), i=1, \ldots, k$, first we consider the action of $U_{q}$ on $\mathcal{F}^{2}\left(\mathbb{C}^{q}\right), q \in \mathbb{N}$.

Denote by $\mathrm{P}^{m}\left[\mathbb{C}^{q}\right]$ the space of homogeneous holomorphic polynomials on $\mathbb{C}^{q}$ of degree $m$. Note that the space of holomorphic polynomials is dense in $\mathcal{F}\left(\mathbb{C}^{q}\right)$ and any holomorphic polynomial can be written in a unique way as a direct sum of homogeneous polynomials. In fact the following is well known and can be found in Z 12 .

Lemma 2.5. For $\alpha \in \mathbb{N}^{q}$ let $p_{\alpha}(z)=z_{1}^{\alpha_{1}} \cdots z_{q}^{\alpha_{q}}$. Then

$$
\left\|p_{\alpha}\right\|_{\mathcal{F}}^{2}=\alpha!=\alpha_{1}!\ldots \alpha_{q}!
$$

and the collection

$$
\left\{q_{\alpha}=\frac{1}{\sqrt{\alpha!}} p_{\alpha}\right\}_{\alpha \in \mathbb{N}^{q}}
$$

forms an orthonormal basis for $\mathcal{F}\left(\mathbb{C}^{q}\right)$.
$\mathrm{U}_{q}$ acts on functions on $\mathbb{C}^{q}$ by $A f(z)=f\left(A^{-1} z\right)$. This action leaves $\mathcal{F}\left(\mathbb{C}^{q}\right)$ invariant and, as the measure $\lambda_{q}$ is $\mathrm{U}_{q}$-invariant, it is a unitary representation denoted by $\pi^{q}$. This representation is reducible. In fact this representation leaves the spaces $\mathrm{P}^{m}\left[\mathbb{C}^{q}\right]$ invariant. We denote the corresponding representation by $\pi_{m}^{q}$. The representation $\pi_{m}^{q}$ is irreducible. The torus $\mathbb{T} i d$ is the center of $\mathrm{U}_{q}$ and acts by the character $z \mapsto z^{-m} \mathrm{id}$. The representations $\pi_{m}^{q}$ and $\pi_{k}^{q}$ are inequivalent if $m \neq k$ as can easily be seen as the action of the center is different. The same conclusion follows from the fact that $d_{m}=\operatorname{dim}_{\mathbb{C}} \mathrm{P}^{m}\left[\mathbb{C}^{q}\right] \neq d_{k}$ if $m \neq k$ for $q>1$ and $d_{m}=1$ for $q=1$. The decomposition of $\mathcal{F}\left(\mathbb{C}^{q}\right)$ in irreducible $U_{q}$ representations is given by $\mathcal{F}\left(\mathbb{C}^{q}\right)=\bigoplus_{m=0}^{\infty} \mathrm{P}^{m}\left[\mathbb{C}^{q}\right]$.
Definition 2.6. Let $\pi^{n_{i}}$ be the unitary representations of $\mathrm{U}_{n_{i}}$, acting on $\mathcal{F}\left(\mathbb{C}^{n_{i}}\right)$, $i=1, \ldots, k$, as in the above discussion. The outer tensor product of the representations $\pi_{p_{i}}$, denoted $\pi^{n_{1}} \otimes \cdots \otimes \pi^{n_{k}}$ is defined by

$$
\pi^{n_{1}} \otimes \cdots \otimes \pi^{n_{k}}\left(A_{1}, \ldots A_{k}\right)=\pi^{n_{1}}\left(A_{1}\right) \otimes \cdots \otimes \pi^{n_{k}}\left(A_{k}\right)
$$

for all $\left(A_{1}, \ldots A_{k}\right) \in \mathrm{U}_{n_{1}} \times \cdots \times \mathrm{U}_{n_{k}}=G$. Here $\pi^{n_{1}}\left(A_{1}\right) \otimes \cdots \otimes \pi^{n_{k}}\left(A_{k}\right)$ is the tensor product of the operators $\pi^{n_{i}}\left(A_{i}\right)$ acting on the Hilbert spaces $\mathcal{F}\left(\mathbb{C}^{n_{i}}\right)$.

The outer tensor product $\pi^{n_{1}} \otimes \cdots \otimes \pi^{n_{k}}$ is a unitary representation of $G$ acting on $\mathcal{F}\left(\mathbb{C}^{n_{1}}\right) \otimes$ $\cdots \otimes \mathcal{F}\left(\mathbb{C}^{n_{k}}\right)=\mathcal{F}\left(\mathbb{C}^{n}\right)$. For more details see [FÓ14].
Lemma 2.7. Let $\varphi \in L^{\infty}\left(\mathbb{C}^{n}\right)^{G}$. Then $T_{\varphi}$ intertwines with $\pi^{n_{1}} \otimes \cdots \otimes \pi^{n_{k}}$.

Proof. Let $A_{i} \in \mathrm{U}_{n_{i}}$ and $f_{i} \in \mathcal{F}\left(\mathbb{C}^{n_{i}}\right), i=1, \ldots, m$. Notice that

$$
\begin{aligned}
& T_{\varphi}\left(\pi^{n_{1}} \otimes \cdots \otimes \pi^{n_{k}}\right)\left(A_{1}, \ldots A_{k}\right) f_{1} \otimes \cdots \otimes f_{k}(z)=T_{\varphi} f\left(A_{1}^{-1} z_{(1)}, \ldots, A_{k}^{-1} z_{(k)}\right) \\
& \quad=\int_{\mathbb{C}^{n}} \varphi(w) f\left(A_{1}^{-1} z_{(1)}\right) \cdots f\left(A_{k}^{-1} z_{(k)}\right) \overline{k_{z}(w)} d \lambda_{n}(w) \\
& \quad=\int_{\mathbb{C}^{n}} \varphi\left(A_{1} w_{(1)}, \ldots A_{k} w_{(k)}\right) f_{1} \otimes \cdots \otimes f_{k}(w) \overline{k_{z}\left(A_{1} w_{(1)}, \ldots A_{k} w_{(k)}\right)} d \lambda_{n}(w)
\end{aligned}
$$

(by the change of variable $\left.\left(w_{(1)}, \ldots w_{(k)}\right) \rightarrow\left(A_{1} w_{(1)}, \ldots, A_{k} w_{(k)}\right)\right)$.
Since

$$
\begin{aligned}
k_{z}\left(A_{1} w_{(1)}, \ldots A_{k} w_{(k)}\right) & =e^{A_{1} w_{(1)} \overline{z_{(1)}}+\cdots+A_{k} w_{(k)} \overline{z_{(k)}}} \\
& =e^{w_{(1)}} \overline{\left(A^{*} z_{(1)}\right)}+\cdots+w_{(k)} \overline{A_{k}^{*} z_{(k)}} \\
& =e^{w_{(1)} \overline{\left(A^{-1} z_{(1)}\right)}+\cdots+w_{(k)} \overline{A_{k}^{-1} z_{(k)}}} \quad \text { (as } A_{i} \text { are unitary) } \\
& =k_{\left(A_{1}^{-1} z_{(1)}, \ldots A_{k}^{-1} z_{(k)}\right)}(w)
\end{aligned}
$$

and $\varphi$ is $G$-invariant,

$$
\begin{aligned}
T_{\varphi}\left(\pi^{n_{1}} \times \cdots \times\right. & \left.\pi^{n_{k}}\right)\left(A_{1}, \ldots A_{k}\right) f_{1} \otimes \cdots \otimes f_{k}(z) \\
& =\int_{\mathbb{C}^{n}} \varphi(w) f_{1} \otimes \cdots \otimes f_{k}(w) \overline{k_{\left(A_{1}^{-1} z_{(1)}, \ldots A_{k}^{-1} z_{(k)}\right)}(w)} d \lambda_{n}(w) \\
& =\left(\pi^{n_{1}} \otimes \cdots \otimes \pi^{n_{k}}\right)\left(A_{1}, \ldots A_{k}\right) T_{\varphi} f(z) .
\end{aligned}
$$

Since the tensor product of irreducible representations is irreducible (see Proposition 6.75 in FÓ14] for a proof), $\mathcal{F}\left(\mathbb{C}^{n}\right)$ can be decomposed by irreducible sub-representations of $\pi^{n_{1}} \otimes \cdots \otimes \pi^{n_{k}}$ as

$$
\mathcal{F}\left(\mathbb{C}^{n}\right)=\bigoplus_{m_{1}, \ldots, m_{k}=0}^{\infty} \mathrm{P}^{m_{1}}\left[\mathbb{C}^{n_{1}}\right] \otimes \cdots \otimes \mathrm{P}^{m_{k}}\left[\mathbb{C}^{n_{k}}\right]
$$

Hence if $\varphi \in L^{\infty}\left(\mathbb{C}^{n}\right)^{G},\left.T_{\varphi}\right|_{\mathrm{P}^{m_{1}}\left[\mathbb{C}^{n_{1}}\right] \otimes \cdots \otimes \mathrm{P}^{m_{k}}\left[\mathbb{C}^{n_{k}}\right]}=\gamma_{\boldsymbol{n}, \varphi}(\boldsymbol{m})$ id for some $\gamma_{\boldsymbol{n}, \varphi}(\boldsymbol{m}) \in \mathbb{C}$ for all $\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right) \in \mathbb{N}_{0}^{k}$ by Schur's lemma.

As a consequence of Lemma [2.4, we identify the class of symbols $L^{\infty}\left(\mathbb{C}^{n}\right)^{G}$ with essentially bounded functions $a: \mathbb{R}_{+}^{k} \rightarrow \mathbb{C}$ and denote the corresponding Toeplitz operator and its spectrum by $T_{n, a}$ and $\gamma_{n, a}$.

Since the above decomposition of $\mathcal{F}\left(\mathbb{C}^{n}\right)$ is multiplicity free and $G$ is compact, the set of all operators that intertwine with $\pi^{n_{1}} \otimes \cdots \otimes \pi^{n_{k}}$, denoted $\operatorname{End}_{G}\left(\mathcal{F}\left(\mathbb{C}^{n}\right)\right.$ ), is commutative (see in particular Proposition 4.1 and Theorem 6.4 in DÓQ15 for more details). Then as a consequence of Lemma 2.7 we have the following corollary.

Corollary 2.8. The $C^{*}$-algebra generated by Toeplitz operators with $G$-invariant symbols is commutative.
2.3. Computing eigenvalue functions. We denote by $\mathrm{S}^{q}=\left\{x \in \mathbb{R}^{q+1}| | x \mid=1\right\}$ the $q$ dimensional sphere in $\mathbb{R}^{q+1}$. We denote by $\sigma$ the unique $\mathrm{U}_{q+1}$-invariant measure on $\mathrm{S}^{q}$ that satisfy the polar coordinates formula given by

$$
\int_{\mathbb{R}^{q+1}} f(x) d x=\int_{0}^{\infty} \int_{\mathrm{S}^{q}} f(r \omega) d \sigma(\omega) r^{q} d r
$$

for any $f \in L^{1}\left(\mathbb{R}^{q+1}, d x\right)$ where $d x$ is the Lebesgue measure on $\mathbb{R}^{q+1}$. See section 2.7 in [F99] for more details.

Lemma 2.9. Let $f \in L^{1}\left(\mathbb{C}^{q}, d z\right)$. Then

$$
\int_{\mathbb{C}^{q}} f(z) d z=\int_{0}^{\infty} \int_{S^{2 q-1}} f(r \omega) d \sigma(\omega) r^{2 q-1} d r .
$$

In particular if $f(z)=a(r)$ is $\mathrm{U}(q)$-invariant then

$$
\int_{\mathbb{C}^{q}} f(z) d z=\sigma\left(\mathrm{S}^{2 q-1}\right) \int_{0}^{\infty} a(r) r^{2 q-1} d r .
$$

We recall the following well known fact:
Lemma 2.10. Let $f, g \in \mathcal{F}^{2}\left(\mathbb{C}^{q}\right)$ and $\varphi \in L^{\infty}\left(\mathbb{C}^{q}\right)$. Then

$$
\left\langle T_{\varphi} f, g\right\rangle=\langle\varphi f, g\rangle=\frac{1}{\pi^{q}} \int_{\mathbb{C}^{q}} \varphi(z) f(z) \overline{g(z)} e^{-|z|^{2}} d z
$$

In particular for $f=g=p_{\alpha}$ we get

$$
\left\langle T_{\varphi} p_{\alpha}, p_{\alpha}\right\rangle=\frac{1}{\pi^{q}} \int_{\mathbb{C}^{q}} \varphi(z) \prod_{j=1}^{n}\left|z_{j}\right|^{2 \alpha_{j}} e^{-\left|z_{j}\right|^{2}} d z_{1} \cdots d z_{n}
$$

Proof. Let $P: L^{2}\left(\mathbb{C}^{q}\right) \rightarrow \mathcal{F}^{2}\left(\mathbb{C}^{q}\right)$ be the orthogonal projection. Then, as $g \in \mathcal{F}^{2}\left(\mathbb{C}^{q}\right)$, we get

$$
\left\langle T_{\varphi} f, g\right\rangle=\langle P(\varphi f), g\rangle=\langle\varphi f, g\rangle .
$$

The following is well known and can be found for more general situations in [FK94] and other places. We also point to [F01 for a general discussion on how to integrate polynomials over spheres:
Lemma 2.11. Let $p_{\alpha} \in \mathrm{P}^{m}\left(\mathbb{C}^{q}\right)$. Then $\left\|\left.p_{\alpha}\right|_{\mathrm{S}^{2 q-1}}\right\|^{2}=\frac{2 \pi^{q}}{\Gamma(q+m)}\left\|p_{\alpha}\right\|_{\mathcal{F}}^{2}$. In particular

$$
\left\|\left.q_{\alpha}\right|_{\mathbf{S}^{2 q-1}}\right\|^{2}=\frac{2 \pi^{q}}{\Gamma(q+m)}
$$

Proof. We have $p_{\alpha}(r \omega)=r^{m} p(\omega), r>0$. Hence:

$$
\begin{aligned}
\left\|p_{\alpha}\right\|_{\mathcal{F}}^{2} & =\frac{1}{\pi^{q}} \int_{0}^{\infty} \int_{\mathrm{S}^{2 q-1}}\left|p_{\alpha}(r \omega)\right|^{2} d \sigma(\omega) e^{-r^{2}} r^{2 q-1} d r \\
& =\frac{1}{2 \pi^{q}}\left(\int_{\mathrm{S}^{2 q-1}}\left|p_{\alpha}(\omega)\right|^{2} d \sigma(\omega)\right)\left(\int_{0}^{\infty} r^{2 m+2 q-2} e^{-r^{2}}(2 r d r)\right) \\
& =\frac{1}{2 \pi^{q}}\left\|\left.p_{\alpha}\right|_{\mathrm{S}^{2 q-1}}\right\|^{2} \int_{0}^{\infty} u^{m+q-1} e^{-u} d u \quad u=r^{2}, d u=2 r d r \\
& =\frac{1}{2 \pi^{q}}\left\|\left.p_{\alpha}\right|_{\mathrm{S}^{2 q-1}}\right\|^{2} \Gamma(m+q) .
\end{aligned}
$$

We recall that the $C^{*}$-algebra $\mathcal{T}_{G}$ generated by $G$-invariant bounded symbols is commutative and acts by scalars on each of the spaces $\mathrm{P}^{m_{1}}\left[\mathbb{C}^{n_{1}}\right] \otimes \cdots \otimes \mathrm{P}^{m_{k}}\left[\mathbb{C}^{n_{k}}\right]$.
Theorem 2.12. Assume $\varphi \in L^{\infty}\left(\mathbb{C}^{n}\right)^{G}$ let $\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right) \in \mathbb{N}_{0}^{k}$. Then

$$
\left.T_{\varphi}\right|_{\mathrm{P}^{m_{1}}\left[\mathbb{C}^{n_{1}}\right] \otimes \cdots \otimes \mathrm{P}^{m_{k}}\left[\mathbb{C}^{n_{k}}\right]}=\gamma_{n, \varphi}(\boldsymbol{m}) \mathrm{id}=\gamma_{n, a}(\boldsymbol{m}) \mathrm{id}
$$

where

$$
\gamma_{\boldsymbol{n}, a}(\boldsymbol{m})=\frac{1}{(\boldsymbol{m}+\boldsymbol{n}-\mathbf{1})!} \int_{\mathbb{R}_{+}^{k}} a_{\varphi}(\sqrt{\boldsymbol{r}}) \boldsymbol{r}^{\boldsymbol{m}+\boldsymbol{n}-1} e^{-\left(r_{1}+\cdots+r_{k}\right)} d r_{1} \ldots d r_{k}
$$

where we use the notations $\sqrt{\boldsymbol{r}}=\left(\sqrt{r_{1}}, \ldots, \sqrt{r_{k}}\right)$ and $\mathbf{1}=(1, \ldots, 1) \in \mathbb{N}^{k}$.

Proof. Assume that $\varphi(z)=a\left(\left|z_{(1)}\right|, \ldots,\left|z_{(k)}\right|\right)=a\left(r_{1}, \ldots, r_{k}\right)$. Let $\alpha_{j} \in \mathbb{N}_{0}^{n_{j}}$ such that $\left|\alpha_{j}\right|=m_{j}$ and let $q_{\alpha_{j}} \in \mathrm{P}^{m_{j}}\left[\mathbb{C}^{n_{j}}\right]$ be the normalized monomials defined in Lemma 2.11. Recall from Lemma 2.11 that

$$
\left\|\left.q_{\alpha_{j}}\right|_{\mathrm{S}^{2 n_{j}-1}}\right\|^{2}=\frac{2 \pi^{n_{j}}}{\Gamma\left(n_{j}+m_{j}\right)}
$$

and hence

$$
\prod_{j=1}^{k}\left\|\left.q_{\alpha_{j}}\right|_{\mathrm{S}^{2 n_{j}-1}}\right\|^{2}=\frac{2^{k} \pi^{n}}{(\boldsymbol{m}+\boldsymbol{n}-\mathbf{1})!}
$$

Let $\alpha=\left(\alpha_{1}, \ldots, \alpha_{k}\right)$ and define the normalized monomial $q_{\alpha}$ by

$$
q_{\alpha}(z)=\prod_{j=1}^{k} q_{\alpha_{j}}\left(z_{(j)}\right) .
$$

Then $q_{\alpha} \in \mathrm{P}^{m_{1}}\left[\mathbb{C}^{n_{1}}\right] \otimes \cdots \otimes \mathrm{P}^{m_{k}}\left[\mathbb{C}^{n_{k}}\right]$ and hence

$$
\gamma_{n, \varphi}(\boldsymbol{m})=\left\langle T_{\varphi} q_{\alpha}, q_{\alpha}\right\rangle .
$$

As $\varphi$ is $G$-invariant and bounded we can use polar-coordinates on $\mathbb{C}^{n_{j}}$, Fubini's theorem, Lemma 2.4. Lemma 2.10 and the fact that $q_{\alpha_{j}}$ are homogeneous of order $m_{j}$, to write

$$
\begin{aligned}
\left\langle T_{\varphi} q_{\alpha}, q_{\alpha}\right\rangle & =\frac{1}{\pi^{n}} \int_{\mathbb{C}^{n}} \varphi(z)\left|q_{\alpha}(z)\right|^{2} e^{-|z|^{2}} d z \\
& =\frac{1}{\pi^{n}} \int_{\mathbb{C}^{n_{1}}} \cdots \int_{\mathbb{C}^{n_{k}}} a\left(\left|z_{(1)}\right|, \ldots,\left|z_{(k)}\right|\right) \prod_{j=1}^{k}\left|q_{\alpha_{j}}\left(z_{(j)}\right)\right|^{2} e^{-\left|z_{(j)}\right|^{2}} d z_{(1)} \ldots d z_{(k)} \\
& =\frac{1}{\pi^{n}} \int_{0}^{\infty} \cdots \int_{0}^{\infty} a(\boldsymbol{r}) \prod_{j=1}^{k} r_{j}^{2 m_{j}+2 n_{j}-1} e^{-r_{j}^{2}} d r_{1} \ldots d r_{k} \prod_{j=1}^{k}\left\|q_{\alpha_{j}} \mid S_{S^{2 n_{j}-1}}\right\|^{2} \\
& =\frac{2^{k}}{(\boldsymbol{m}+\boldsymbol{n}-\mathbf{1})!} \int_{0}^{\infty} \cdots \int_{0}^{\infty} a(\boldsymbol{r}) \prod_{j=1}^{k} r_{j}^{2 m_{j}+2 n_{j}-1} e^{-r_{j}^{2}} d r_{1} \ldots d r_{k} \\
& =\frac{1}{(\boldsymbol{m}+\boldsymbol{n}-\mathbf{1})!} \int_{0}^{\infty} \cdots \int_{0}^{\infty} a(\sqrt{\boldsymbol{r}}) \prod_{j=1}^{k} r_{j}^{m_{j}+n_{j}-1} e^{-r_{j}} d r_{1} \cdots d r_{k},
\end{aligned}
$$

where we in the last line used the substitutions $u=r_{j}^{2}$ and hence $d u=2 r_{j} d r_{j}$.
Corollary 2.13. If $\boldsymbol{n}=\left(n_{1}, \ldots, n_{k}\right)$ and $\boldsymbol{m}=\left(m_{1}, \ldots m_{k}\right)$, then

$$
\gamma_{\boldsymbol{n}, a}(\boldsymbol{m})=\gamma_{1, a}\left(m_{1}+n_{1}-1, \ldots, m_{k}+n_{k}-1\right)=\gamma_{\mathbf{1}, a}(\boldsymbol{m}+\boldsymbol{n}-\mathbf{1}) .
$$

Note that eigenvalue functions $\gamma_{1, a}$ given above corresponds to Toeplitz operators with separately radial symbols. In particular we obtain the following special cases:
Corollary 2.14 (Grudsky and Vasilevski [GV02]). Assume that $n=1$

$$
\gamma_{1, a}(m)=\frac{1}{m!} \int_{0}^{\infty} a(\sqrt{r}) r^{m} e^{-r} d r .
$$

If $k=1$, then $\boldsymbol{n}=(n)$ and we have the following corollary.
Corollary 2.15. If $k=1$ (radial symbols) then

$$
\gamma_{n, a}(m)=\frac{1}{(m+n-1)!} \int_{0}^{\infty} a(\sqrt{r}) r^{m+n-1} e^{-r} d r=\gamma_{1, a}(m+n-1) .
$$

If $n=k$, then $\boldsymbol{n}=(1, \ldots, 1)=\mathbf{1}$ and we have the following corollary.
Corollary 2.16. If $n=k$ (separately radial symbols) then

$$
\gamma_{1, a}(\boldsymbol{m})=\frac{1}{\boldsymbol{m}!} \int_{\mathbb{R}_{+}^{k}} a_{\varphi}(\sqrt{\boldsymbol{r}}) r^{\boldsymbol{m}} e^{-\left(r_{1}+\cdots+r_{k}\right)} d r_{1} \ldots d r_{k}
$$

Corollary 2.17. If $a\left(r_{1}, \ldots, r_{k}\right)=\prod_{j=1}^{k} a_{j}\left(r_{j}\right)$ then

$$
\gamma_{n, a}\left(m_{1}, \ldots, m_{k}\right)=\prod_{j=1}^{k} \gamma_{1, a_{j}}\left(m_{j}+n_{j}-1\right)
$$

## 3. The Space $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$

In this section we introduce $\mathrm{C}^{*}$-algebra $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$, the set of all bounded functions on $\mathbb{N}_{0}^{k} \times \mathbb{N}_{0}^{k}$ that are uniformly continuous with respect to the square-root metric. These are sometimes called Square root-slowly oscillating functions.

For $k \in \mathbb{N}$, let $\rho_{k}: \mathbb{N}_{0}^{k} \times \mathbb{N}_{0}^{k} \rightarrow[0, \infty)$ be given by

$$
\rho\left(\boldsymbol{m}, \boldsymbol{m}^{\prime}\right)=\left|\sqrt{m_{1}}-\sqrt{m_{1}^{\prime}}\right|+\cdots+\left|\sqrt{m_{k}}-\sqrt{m_{k}^{\prime}}\right| .
$$

for all $\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right), \boldsymbol{m}^{\prime}=\left(m_{1}^{\prime}, \ldots, m_{k}^{\prime}\right) \in \mathbb{N}_{0}^{k}$ Then $\rho_{k}$ is a metric on $\mathbb{N}_{0}^{k}$. The modulus of continuity with respect to the metric $\rho_{k}$ of a function $\sigma \in l^{\infty}\left(\mathbb{N}_{0}^{k}\right)$ is the function $\omega_{\rho_{k}, \sigma}:[0, \infty) \rightarrow$ $[0, \infty)$ given by

$$
\omega_{\rho_{k}, \sigma}(\delta)=\sup \left\{\left|\sigma(\boldsymbol{m})-\sigma\left(\boldsymbol{m}^{\prime}\right)\right|: \rho\left(\boldsymbol{m}, \boldsymbol{m}^{\prime}\right) \leq \delta\right\} .
$$

$C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ is the set of all bounded functions on $\mathbb{N}_{0}^{k}$ that are uniformly continuous with respect to the square-root metric $\rho_{k}$ :

$$
\left\{\sigma \in l^{\infty}\left(\mathbb{N}_{0}^{k}\right): \lim _{\delta \rightarrow 0} \omega_{\rho_{k}, \sigma}(\delta)=0\right\} .
$$

$C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ is a closed subalgebra of $l^{\infty}\left(\mathbb{N}_{0}^{k}\right)$.

Definition 3.1. Let $\sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ and let $s=\left(s_{1} \ldots, s_{k}\right) \in \mathbb{N}_{0}^{k}$. We define the left and right shift operators on $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ with respect to $s$, denoted $\tau_{L}^{s}$ and $\tau_{R}^{s}$ respectively, by

$$
\tau_{L}^{s} \sigma(\boldsymbol{m})=\sigma(\boldsymbol{m}+\boldsymbol{s}) \quad \text { and } \quad \tau_{R}^{s} \sigma(\boldsymbol{m})= \begin{cases}\sigma(\boldsymbol{m}-\boldsymbol{s}) & ; m_{i} \geq s_{i} \forall i=1, \ldots, k \\ 0 & ; \text { otherwise }\end{cases}
$$

for all $\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right) \in \mathbb{N}_{0}^{k}$.
Now we present the following two lemmas that will be used in section 6 .
Lemma 3.2. Let $\sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ and $s=\left(s_{1} \ldots, s_{k}\right) \in \mathbb{N}_{0}^{k}$. Then $\tau_{L}^{s} \sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$.
Proof. Boundedness of $\tau_{L}^{\mathrm{s}} \sigma$ follows easily from the boundedness of $\sigma$. Let $\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right)$, $\boldsymbol{m}^{\prime}=\left(m_{1}^{\prime}, \ldots, m_{k}^{\prime}\right) \in \mathbb{N}_{o}^{k}$. By observing the square-root function, we have,

$$
\left|\sqrt{m_{i}+s_{i}}-\sqrt{m_{i}^{\prime}+s_{i}}\right| \leq\left|\sqrt{m_{i}}-\sqrt{m_{i}^{\prime}}\right|, \text { for } i=1, \ldots k
$$

Hence $\omega_{\rho_{k}, \tau_{L}^{\mathrm{s}} \sigma}(\delta) \leq \omega_{\rho_{k}, \sigma}(\delta)$.
Lemma 3.3. Let $\sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ and $s=\left(s_{1} \ldots, s_{k}\right) \in \mathbb{N}_{0}^{k}$. Then $\tau_{R}^{s} \sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$.

Proof. Again boundedness of $\tau_{R}^{\mathrm{s}} \sigma$ follows from the boundedness of $\sigma$. Let $s=\max \left\{s_{1}, \ldots, s_{k}\right\}$. Assume $\delta<\sqrt{2 s}-\sqrt{2 s-1}$ and let $\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right), \boldsymbol{m}^{\prime}=\left(m_{1}^{\prime}, \ldots, m_{k}^{\prime}\right) \in \mathbb{N}_{o}^{k}$ such that $\rho_{k}\left(\boldsymbol{m}, \boldsymbol{m}^{\prime}\right)<\delta$. Then $\left|\sqrt{m_{i}}-\sqrt{m_{i}^{\prime}}\right|<\sqrt{2 s}-\sqrt{2 s-1}$ and since

$$
\min _{\substack{j, l \in \mathbb{N}_{0} \\ i, j \leq 2 s}}|\sqrt{j}-\sqrt{l}|=\sqrt{2 s}-\sqrt{2 s-1},
$$

we have $m_{i}, m_{i}^{\prime}>2 s \geq 2 s_{i}$ for all $i=1, \ldots, k$. Notice that

$$
\begin{aligned}
m_{i}, m_{i}^{\prime}>2 s_{i}=\frac{s_{i}}{1-\frac{1}{2}} & \Longrightarrow \frac{1}{2} m_{i}<m_{i}-s_{i}, \frac{1}{2} m_{i}^{\prime}<m_{i}^{\prime}-s_{i} \\
& \Longrightarrow \frac{1}{\sqrt{2}} \sqrt{m_{i}}<\sqrt{m_{i}-s_{i}}, \frac{1}{\sqrt{2}} \sqrt{m_{i}^{\prime}}<\sqrt{m_{i}^{\prime}-s_{i}} \\
& \Longrightarrow \frac{1}{\sqrt{2}}\left(\sqrt{m_{i}}+\sqrt{m_{i}^{\prime}}\right)<\sqrt{m_{i}-s_{i}}+\sqrt{m_{i}^{\prime}-s_{i}} \\
& \Longrightarrow \frac{\left|m_{i}-m_{i}^{\prime}\right|}{\sqrt{m_{i}-s_{i}}+\sqrt{m_{i}^{\prime}-s_{i}}}<\sqrt{2} \frac{\left|m_{i}-m_{i}^{\prime}\right|}{\sqrt{m_{i}}+\sqrt{m_{i}^{\prime}}} \\
& \Longrightarrow\left|\sqrt{m_{i}-s_{i}}-\sqrt{m_{i}^{\prime}-s_{i}}\right|<\sqrt{2}\left|\sqrt{m_{i}}-\sqrt{m_{i}^{\prime}}\right| .
\end{aligned}
$$

Hence $\omega_{\rho_{k}, \tau_{L}^{\mathrm{s}} \sigma}(\delta) \leq \omega_{\rho_{k}, \sigma}(\sqrt{2} \delta)$ for all $\delta<\sqrt{2 s}-\sqrt{2 s-1}$.
The metric $\rho_{k}$ can be extended to $\mathbb{R}_{+}^{k}$ and we denote the set of all functions on $\mathbb{R}_{+}^{k}$ that are uniformly continuous with respect to $\rho_{k}$ by $C_{b, u}\left(\mathbb{R}_{+}^{k}, \rho_{k}\right)$. The following lemma shows that any $\sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ can be extended to some $f \in C_{b, u}\left(\mathbb{R}_{+}^{k}, \rho_{k}\right)$. We will use this fact in section 5 ,

Lemma 3.4. Let $\sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$. Define $f$ on $\mathbb{R}_{+}^{k}$ by

$$
f(x)=f_{\boldsymbol{m}}(x):=\sigma(\boldsymbol{m})+\sum_{l=1}^{k} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, k\} \\ i_{1}<\ldots<i_{l}}} a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m}) \prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}}-\sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}}
$$

where $m_{i}=\left\lfloor x_{i}\right\rfloor, i=1, \ldots, k$ and the coefficients $a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m})$ are given by

$$
a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m})=\sum_{q=0}^{l}(-1)^{l-q} \sum_{\substack{j_{1}, \ldots, j_{j} \in\left\{i_{1}, \ldots, i_{l}\right\} \\ j_{1}<\cdots<j_{q}}} \sigma\left(\boldsymbol{m}+e_{j_{1}}+\cdots+e_{j_{q}}\right)
$$

where $e_{i}$ denotes the standard basis of $\mathbb{N}_{0}^{k}$.
Then $f \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ and $\left.f\right|_{\mathbb{N}_{0}^{k}}=\sigma$. Moreover $\|f\|_{\infty}=\|\sigma\|_{\infty}$.
The function $f$ defined above is motivated by the interpolation formula for the case $k=1$, given by

$$
f(x)=\sigma(m)+(\sigma(m+1)-\sigma(m)) \frac{\sqrt{x}-\sqrt{m}}{\sqrt{m+1}-\sqrt{m}}
$$

where $m=\lfloor x\rfloor$ and $x \in \mathbb{R}_{+}$. The proof of Lemma 3.4 is a generalization of the proof of Lemma 3.3 in [EM16]. However, the proof depends heavily on combinatorics and induction; we have provided the proof in the appendix.

## 4. Uniform continuity of eigenvalue functions with respect to the square-root METRIC

In this section, we show that the set of all eigenvalue functions is a subset of $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$.
Definition 4.1. Let $\mathfrak{G}_{n}$ be the set of all eigenvalue functions:

$$
\mathfrak{G}_{n}:=\left\{\gamma_{\boldsymbol{n}, a} \mid \varphi \in L^{\infty}\left(\mathbb{C}^{n}\right)^{G}\right\} .
$$

Proposition 4.2. The eigenvalue functions $\gamma_{n, a}$ are bounded functions that are uniformly continuous with respect to the square-root metric $\rho_{k}$, i.e.,

$$
\mathfrak{G}_{n} \subseteq C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)
$$

The boundedness of $\gamma_{n, a}$ follows from the boundedness of the symbol. We proceed to prove the uniform continuity of $\gamma_{\boldsymbol{n}, a}$ with respect to the metric $\rho_{k}$. The following lemma is Lemma 4.3 in [EM16] which is used by Esmeral and Maximenko to prove the above theorem for $n=1$. Then we prove Lemma 4.4 and Lemma 4.5 which are used to prove Proposition 4.6. Theorem 4.2 follows as a corollary of Proposition 4.6.

Lemma 4.3. For any $m \in \mathbb{N}$,

$$
\int_{0}^{\infty}\left|\frac{r^{m}}{m!}-\frac{r^{m-1}}{(m-1)!}\right| e^{-r} d r \leq \sqrt{\frac{2}{\pi m}}
$$

As a consequence of the above lemma we prove the following:
Lemma 4.4. For any $m, m^{\prime} \in \mathbb{N}_{0}$,

$$
\int_{0}^{\infty}\left|\frac{r^{m}}{m!}-\frac{r^{m^{\prime}}}{m^{\prime}!}\right| e^{-r} d r \leq 2 \sqrt{\frac{2}{\pi}}\left|\sqrt{m}-\sqrt{m^{\prime}}\right|
$$

Proof. Let $\underline{m}=\min \left\{m, m^{\prime}\right\}$ and $\bar{m}=\max \left\{m, m^{\prime}\right\}$. Notice that

$$
\begin{aligned}
\int_{0}^{\infty}\left|\frac{r^{m}}{m!}-\frac{r^{m^{\prime}}}{m^{\prime}!}\right| e^{-r} d r & \leq \sum_{i=\underline{m}+1}^{\bar{m}} \int_{0}^{\infty}\left|\frac{r^{i}}{i!}-\frac{r^{i-1}}{(i-1)!}\right| e^{-r} d r \\
& \leq \sum_{i=\underline{m}+1}^{\bar{m}} \sqrt{\frac{2}{\pi i}} \quad(\text { by Lemma 4.3) }) \\
& =\sqrt{\frac{2}{\pi}} \sum_{i=\underline{m}+1}^{\bar{m}} \frac{(\sqrt{i}+\sqrt{i-1})(\sqrt{i}-\sqrt{i-1})}{\sqrt{i}} \\
& \leq \sqrt{\frac{2}{\pi}} \sum_{i=\underline{m}+1}^{\bar{m}} \frac{2 \sqrt{i}(\sqrt{i}-\sqrt{i-1})}{\sqrt{i}}=2 \sqrt{\frac{2}{\pi}}\left|\sqrt{m}-\sqrt{m^{\prime}}\right| .
\end{aligned}
$$

Lemma 4.5. Suppose $f_{i}, g_{i}: \mathbb{N}_{0} \times \mathbb{R}_{+} \rightarrow \mathbb{C}$ satisfy $\int_{\mathbb{R}_{+}}\left|f_{i}(m, r)\right| d r, \int_{\mathbb{R}_{+}}\left|g_{i}(m, r)\right| d r \leq 1$ for $i=1, \ldots, k$. Then for all $m_{i}, m_{i}^{\prime} \in \mathbb{N}_{0}$,

$$
\int_{\mathbb{R}_{+}^{k}}\left|\prod_{i=1}^{k} f_{i}\left(m_{i}, r_{i}\right)-\prod_{i=1}^{k} g_{i}\left(m_{i}^{\prime}, r_{i}\right)\right| d r_{1} \cdots d r_{k} \leq \sum_{i=1}^{k} \int_{\mathbb{R}_{+}}\left|f_{i}\left(m_{i}, r_{i}\right)-g_{i}\left(m_{i}^{\prime}, r_{i}\right)\right| d r_{i} .
$$

Proof. Notice that the statement is true for $k=1$. Assume the statement is true for $k$. Then

$$
\begin{aligned}
\int_{\mathbb{R}_{+}^{k+1}} \mid & \prod_{i=1}^{k+1} f_{i}\left(m_{i}, r_{i}\right)-\prod_{i=1}^{k+1} g_{i}\left(m_{i}^{\prime}, r_{i}\right) \mid d r_{1} \cdots d r_{k+1} \\
\leq & \int_{\mathbb{R}_{+}}\left|f_{k+1}\left(m_{k+1}, r_{k+1}\right)-g_{k+1}\left(m_{k+1}, r_{k+1}\right)\right| d r_{k+1}\left|\int_{\mathbb{R}_{+}^{k}} \prod_{i=1}^{k} f_{i}\left(m_{i}, r_{i}\right) d r_{1} \ldots d r_{k}\right| \\
& \quad+\int_{\mathbb{R}_{+}}\left|g_{k+1}\left(m_{k+1}, r_{k+1}\right)\right| d r_{k+1} \int_{\mathbb{R}_{+}^{k}}\left|\prod_{i=1}^{k} f_{i}\left(m_{i}, r_{i}\right)-\prod_{i=1}^{k} g_{i}\left(m_{i}^{\prime}, r_{i}\right)\right| d r_{1} \cdots d r_{k} \\
& \quad \leq \sum_{i=1}^{k+1} \int_{\mathbb{R}_{+}}\left|f_{i}\left(m_{i}, r_{i}\right)-g_{i}\left(m_{i}^{\prime}, r_{i}\right)\right| d r_{i}
\end{aligned}
$$

by the assumption and because

$$
\begin{aligned}
\left|\int_{\mathbb{R}_{+}^{k}} \prod_{i=1}^{k} f_{i}\left(m_{i}, r_{i}\right) d r_{1} \ldots d r_{k}\right| & \leq \prod_{i=1}^{k} \int_{\mathbb{R}_{+}}\left|f_{i}\left(m_{i}, r_{i}\right)\right| d r_{i} \\
& \leq 1 .
\end{aligned}
$$

Hence the result holds by induction on $k$.
Proposition 4.6. The eigenvalue functions $\gamma_{n, a}$ are Lipchitz with respect to the square-root metric $\rho_{k}$ : There exists $A_{\varphi}>0$ such that

$$
\left|\gamma_{n, a}(\boldsymbol{m})-\gamma_{\boldsymbol{n}, a}\left(\boldsymbol{m}^{\prime}\right)\right| \leq A_{\varphi} \rho_{k}\left(\boldsymbol{m}, \boldsymbol{m}^{\prime}\right)
$$

for all $\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right), \boldsymbol{m}^{\prime}=\left(m_{1}^{\prime}, \ldots, m_{k}^{\prime}\right) \in \mathbb{N}_{0}^{k}$.
Proof. Define $K: \mathbb{N}_{0} \times \mathbb{R}_{+} \rightarrow[0, \infty)$ by $K(m, r)=\frac{r^{m}}{m!} e^{-r}$. Then $\int_{0}^{\infty} K(m, r) d r=1$ and

$$
\gamma_{\mathbf{1}, a}(\boldsymbol{m})=\int_{\mathbb{R}_{+}^{k}} a_{\varphi}\left(\sqrt{r_{1}}, \ldots, \sqrt{r_{k}}\right) \prod_{i=1}^{k} K\left(m_{i}, r_{i}\right) d r_{1} \cdots d r_{k}
$$

where $\mathbf{1}=(1, \ldots, 1) \in \mathbb{N}^{k}$. Notice that

$$
\begin{aligned}
\mid \gamma_{\mathbf{1}, a}(\boldsymbol{m}) & -\gamma_{\mathbf{1}, a}\left(\boldsymbol{m}^{\prime}\right) \mid \\
& \leq\left\|a_{\varphi}\right\|_{\infty} \int_{\mathbb{R}_{+}^{k}}\left|\prod_{i=1}^{k} K\left(m_{i}, r_{i}\right)-\prod_{i=1}^{k} K\left(m_{i}^{\prime}, r_{i}\right)\right| d r_{1} \cdots d r_{k} \\
& \leq\left\|a_{\varphi}\right\|_{\infty} \sum_{i=1}^{k} \int_{0}^{\infty}\left|K\left(m_{i}, r_{i}\right)-K\left(m_{i}^{\prime}, r_{i}\right)\right| d r_{i} \quad \text { (by Lemma 4.5) } \\
& \leq 2 \sqrt{\frac{2}{\pi}}\left\|a_{\varphi}\right\|_{\infty} \rho_{k}\left(\boldsymbol{m}, \boldsymbol{m}^{\prime}\right) \quad \text { (by Lemma 4.4). }
\end{aligned}
$$

Hence by Corollary 2.13,

$$
\begin{aligned}
\left|\gamma_{\boldsymbol{n}, a}(\boldsymbol{m})-\gamma_{\boldsymbol{n}, a}\left(\boldsymbol{m}^{\prime}\right)\right| & =\left|\gamma_{\mathbf{1}, a}(\boldsymbol{m}+\boldsymbol{n}-\mathbf{1})-\gamma_{\mathbf{1}, a}\left(\boldsymbol{m}^{\prime}+\boldsymbol{n}-\mathbf{1}\right)\right| \\
& \leq 2 \sqrt{\frac{2}{\pi}}\left\|a_{\varphi}\right\|_{\infty} \rho_{k}\left(\boldsymbol{m}+\boldsymbol{n}-\mathbf{1}, \boldsymbol{m}^{\prime}+\boldsymbol{n}-\mathbf{1}\right) \\
& \leq 2 \sqrt{\frac{2}{\pi}}\left\|a_{\varphi}\right\|_{\infty} \rho_{k}\left(\boldsymbol{m}, \boldsymbol{m}^{\prime}\right)
\end{aligned}
$$

Therefore the function $\gamma_{n, a}$ are uniformly continuous with respect to the metric $\rho_{k}$, proving Theorem 4.2.

## 5. Density of $\mathfrak{G}_{1}$ IN $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$

In the previous section we showed that $\mathfrak{G}_{n} \subseteq C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$. To show that the $C^{*}$-algebra generated by $\mathfrak{G}_{n}$ is $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$, it is enough to show that $\mathfrak{G}_{n}$ is dense in $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ which will be proved in all generality in section 6. In this section we focus on the case $\boldsymbol{n}=\mathbf{1}=(1, \ldots, 1) \in \mathbb{N}^{k}$. In other words we will show that $\mathfrak{G}_{1}$, the set of eigenvalue functions we get for the case $\boldsymbol{n}=\mathbf{1}$, is dense in $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$. Note that in the above case, the Toeplitz operators under consideration are the Toeplitz operators on $\mathcal{F}\left(\mathbb{C}^{k}\right)$ with seperately radial symbols.

This discussion is a generalization of the proof of density for the case $\boldsymbol{n}=(1)$, presented in EM16.
5.1. Approximation by convolutions. The main goal of this subsection is to prove Proposition 5.6. For this we present a series of propositions and lemmas.

By a change of variable $\left(r_{1}, \ldots, r_{k}\right) \rightarrow\left(r_{1}^{2}, \ldots, r_{k}^{2}\right)$, we have

$$
\gamma_{\mathbf{1}, a}(\mathbf{m})=\int_{\mathbb{R}_{+}^{k}} a\left(r_{1}, \ldots, r_{k}\right) \prod_{i=1}^{k} g\left(m_{i}, r_{i}\right) d r_{1} \ldots d r_{k}
$$

where $g(m, r)=\frac{2 r^{2 m+1} e^{-r^{2}}}{m!}$. Let $h(x)=\sqrt{\frac{2}{\pi}} e^{-2 x^{2}}$.
We have the following lemma from [EM16] (Lemma 6.5).
Lemma 5.1. Let the functions $g$ and $h$ be as above. Then

$$
\lim _{m \rightarrow \infty} \int_{0}^{\infty}|g(m, r)-h(\sqrt{m}-r)| d r=0
$$

Let $H\left(x_{1}, \ldots, x_{k}\right)=\prod_{i=1}^{k} h\left(x_{i}\right)=\left(\frac{2}{\pi}\right)^{\frac{k}{2}} e^{-2\left(x_{1}^{2}+\cdots+x_{k}^{2}\right)}$.
Lemma 5.2. Let $\epsilon>0$. Then there exists $N$ such that for all $m_{i}>N, i=1, \ldots, k$

$$
\int_{\mathbb{R}_{+}^{k}}\left|\prod_{i=1}^{k} g\left(m_{i}, r_{i}\right)-H\left(\sqrt{m_{1}}-r_{1}, \ldots, \sqrt{m_{k}}-r_{k}\right)\right| d r_{1} \ldots d r_{k}<\epsilon
$$

Proof. By Lemma 5.1, there exists $N$ such that for all $m>N, \int_{0}^{\infty}|g(m, r)-h(\sqrt{m}-r)| d r<\frac{\epsilon}{k}$. Also notice that $\int_{0}^{\infty} g(m, r) d r=1$ and $\int_{0}^{\infty} h(\sqrt{m}-r) d r \leq \int_{\mathbb{R}} h(\sqrt{m}-r) d r=\int_{\mathbb{R}} h(r) d r=1$ for any $m \in \mathbb{N}_{0}$. Then if $m_{i}>N, i=1, \ldots, k$,

$$
\begin{aligned}
\int_{\mathbb{R}_{+}^{k}} \mid \prod_{i=1}^{k} g\left(m_{i}, r_{i}\right)-H & \left(\sqrt{m_{1}}-r_{1}, \ldots, \sqrt{m_{k}}-r_{k}\right) \mid d r_{1} \ldots d r_{k} \\
& =\int_{\mathbb{R}_{+}^{k}}\left|\prod_{i=1}^{k} g\left(m_{i}, r_{i}\right)-\prod_{i=1}^{k} h\left(\sqrt{m_{i}}-r_{i}\right)\right| d r_{1} \ldots d r_{k} \\
& \leq \sum_{i=1}^{k} \int_{0}^{\infty}\left|g\left(m_{i}, r_{i}\right)-h\left(\sqrt{m_{i}}-r_{i}\right)\right| d r_{i} \quad \text { (by Lemma (4.5) } \\
& <k \frac{\epsilon}{k}=\epsilon .
\end{aligned}
$$

Let $f \in L^{1}\left(\mathbb{R}^{k}, d x\right)$ and $g \in L^{\infty}\left(\mathbb{R}^{k}, d x\right)$ where $d x$ denotes the Lebesgue measure on $\mathbb{R}^{k}$. Recall that the convolution of $f$ and $g$, denoted $f * g$, is given by

$$
f * g(x)=g * f(x)=\int_{\mathbb{R}^{k}} f(x-y) g(y) d y, \quad x \in \mathbb{R}^{k}
$$

The following proposition presents an approximation of the eigenvalue functions by convolutions.
Proposition 5.3. Let $a \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$ and let $\epsilon>0$. Define $H * a$, by considering 'a' as a function on $\mathbb{R}^{k}$ whose support is $\mathbb{R}_{+}^{k}$. Then there exists $N$ such that for all $m_{i}>N, i=1, \ldots, k$,

$$
\left|\gamma_{1, a}\left(m_{1}, \ldots, m_{k}\right)-(H * a)\left(\sqrt{m_{1}}, \ldots, \sqrt{m_{k}}\right)\right|<\epsilon
$$

Proof. Since support of $a$ is $\mathbb{R}_{+}^{k}$,

$$
\begin{aligned}
& \left|\gamma_{\mathbf{1}, a}\left(m_{1}, \ldots, m_{k}\right)-(H * a)\left(\sqrt{m_{1}}, \ldots, \sqrt{m_{k}}\right)\right| \\
& =\left|\int_{\mathbb{R}_{+}^{k}}\left(\prod_{i=1}^{k} g\left(m_{i}, r_{i}\right)-H\left(\sqrt{m_{1}}-r_{1}, \ldots, \sqrt{m_{k}}-r_{k}\right)\right) a(y) d r_{1} \ldots d r_{k}\right| \\
& \leq\|a\|_{\infty} \int_{\mathbb{R}_{+}^{k}}\left|\prod_{i=1}^{k} g\left(m_{i}, r_{i}\right)-H\left(\sqrt{m_{1}}-r_{1}, \ldots, \sqrt{m_{k}}-r_{k}\right)\right| d r_{1} \ldots d r_{k} .
\end{aligned}
$$

Hence the result follows from 5.2
Lemma 5.4. Let $b \in L^{\infty}\left(\mathbb{R}^{k}\right)$ and $a=\chi_{\mathbb{R}_{+}^{k}} b$. Let $\epsilon>0$. Then there exists $M$ such that for all $x_{i}>M, i=1, \ldots, k$,

$$
\left|H * a\left(x_{1}, \ldots, x_{k}\right)-H * b\left(x_{1}, \ldots, x_{k}\right)\right|<\epsilon .
$$

Proof. Notice that for $x=\left(x_{1}, \ldots, x_{k}\right) \in \mathbb{R}_{+}^{k}$,

$$
\begin{aligned}
|H * a(x)-H * b(x)| & \leq \int_{\mathbb{R}^{k}}|a(y)-b(y)| H(x-y) d y \\
& \leq\|b\|_{\infty} \int_{\mathbb{R}^{k} \backslash \mathbb{R}_{+}^{k}} H(x-y) d y \\
& \leq\|b\|_{\infty} \sum_{j=1}^{k} \int_{\mathbb{R}_{-}} h\left(x_{j}-y_{j}\right) d y_{j} \prod_{\substack{i=1 \\
i \neq j}}^{k} \int_{\mathbb{R}} h\left(x_{i}-y_{i}\right) d y_{i} \\
& =\|b\|_{\infty} \sum_{j=1}^{k} \int_{\mathbb{R}_{-}} h\left(x_{j}-y_{j}\right) d y_{j} \\
& =\|b\|_{\infty} \sum_{j=1}^{k} \int_{x_{j}}^{\infty} h\left(y_{j}\right) d y_{j} \quad \text { (by a change of variable). }
\end{aligned}
$$

The lemma holds as $\int_{x_{j}}^{\infty} h(y) d y$ approaches zero as $x_{j}$ goes to $\infty$.
Proposition 5.5. Let $g \in C_{b, u}\left(\mathbb{R}^{k}\right)$ and let $\epsilon>0$. Then there is $b \in L^{\infty}\left(\mathbb{R}^{k}\right)$ such that

$$
\|H * b-g\|_{\infty}<\epsilon
$$

Proof. Let $\tilde{h}$ denote the bump function (any compactly supported smooth function would suffice)

$$
\tilde{h}(\zeta)=e^{-\frac{1}{1-|\zeta|^{2}}} \chi_{B}(\zeta), \quad \zeta \in \mathbb{R}^{k}
$$

where $B$ is the open unit ball in $\mathbb{R}^{k}$. Let $h$ denote the normalized Fourier inverse of $\tilde{h}$, i.e.,

$$
h=\frac{\mathscr{F}^{-1}(\tilde{h})}{C}
$$

where $C=\left\|\mathscr{F}^{-1}(\tilde{h})\right\|_{1}$. Define the approximate identity $h_{t}$ on $\mathbb{R}^{k}$ by

$$
h_{t}(x)=\frac{h(x / t)}{t}, \quad x \in \mathbb{R}^{k} .
$$

Notice that $\lim _{t \rightarrow 0}\left\|h_{t} * g-g\right\|_{\infty}=0$. Choose $h_{t_{0}}$ s.t. $\left\|h_{t_{0}} * g-g\right\|_{\infty}<\epsilon$. Let $\hat{l}:=\frac{\mathscr{F}\left(h_{t_{0}}\right)}{\mathscr{F}(H)}$. Then

$$
\hat{l}(\zeta)=\frac{\tilde{h}\left(t_{0} \zeta\right) e^{\left|\zeta^{2}\right| / 2}}{C}, \quad \zeta \in \mathbb{R}^{k}
$$

Since $\hat{l}$ is a Schwartz function and $\mathscr{F}\left(h_{t_{0}}\right)=\mathscr{F}(H) \hat{l}, h_{t_{0}}=H * l$ where $l=\mathscr{F}^{-1}(\hat{l})$. Let $b=l * g$. Then $b \in L^{\infty}\left(\mathbb{R}^{k}\right)$ and $\|H * b-g\|_{\infty}=\left\|h_{t_{0}} * g-g\right\|_{\infty}<\epsilon$.

Proposition 5.5 can also be proved using Wiener's division lemma, as in the proof of Proposition 5.4 in [EM16].

Proposition 5.6. Let $\sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ and let $\epsilon>0$. Then there exists $a \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$ and $N$ such that for all $\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right) \in \mathbb{N}_{0}^{k}$ with $m_{i}>N$,

$$
\left|\sigma(\boldsymbol{m})-\gamma_{1, a}(\boldsymbol{m})\right|<\epsilon .
$$

Proof. This proof is similar to the proof of Proposition 6.8 in [EM16.

By Lemma 3.4, there exists $g \in C_{b, u}\left(\mathbb{R}_{+}^{k}\right)$ such that $\left.g\right|_{\mathbb{N}_{0}^{k}}=\sigma$ and $\|g\|_{\infty}=\|\sigma\|_{\infty}$. Define $\tilde{g}$ on $\mathbb{R}^{k}$ by $\tilde{g}\left(x_{1}, \ldots, x_{k}\right)=g\left(x_{1}^{2}, \ldots, x_{k}^{2}\right)$. Then $\tilde{g} \in C_{b, u}\left(\mathbb{R}^{k}\right)$. Then by Proposition 5.5 there exists $b \in L^{\infty}\left(\mathbb{R}^{k}\right)$ such that

$$
\|H * b-\tilde{g}\|_{\infty}<\frac{\epsilon}{3} .
$$

Define $a$ on $\mathbb{R}_{+}^{k}$ by $a=\left.b\right|_{\mathbb{R}_{+}^{k}}$. Then $a \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$. Then by Proposition 5.3 and Lemma 5.4, there exists $N_{1}, N_{2}$ such that for all $m_{i}>N_{1}, i=1, \ldots, k$

$$
\left\lvert\, \gamma_{\mathbf{1}, a}\left(m_{1}, \ldots, m_{k}\right)-\left(H * a\left(\sqrt{m_{1}}, \ldots, \sqrt{m_{k}}\right) \left\lvert\,<\frac{\epsilon}{3}\right.\right.\right.
$$

and for all $m_{i}>N_{2}$,

$$
\left|H * a\left(\sqrt{m_{1}}, \ldots, \sqrt{m_{k}}\right)-H * b\left(\sqrt{m_{1}}, \ldots, \sqrt{m_{k}}\right)\right|<\frac{\epsilon}{3} .
$$

Then for all $\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right)$ with $m_{i}>N=\max \left\{N_{1}, N_{2}\right\}$

$$
\begin{aligned}
\left|\gamma_{\mathbf{1}, a}(\boldsymbol{m})-\sigma(\boldsymbol{m})\right| & \leq\left|\gamma_{\mathbf{1}, a}(\boldsymbol{m})-(H * a)\left(\sqrt{m_{1}}, \ldots, \sqrt{m_{k}}\right)\right| \\
& +\left|H * a\left(\sqrt{m_{1}}, \ldots, \sqrt{m_{k}}\right)-H * b\left(\sqrt{m_{1}}, \ldots, \sqrt{m_{k}}\right)\right| \\
& \quad+\|H * b-\tilde{g}\|_{\infty} \\
& <\frac{\epsilon}{3}+\frac{\epsilon}{3}+\frac{\epsilon}{3}=\epsilon .
\end{aligned}
$$

5.2. The density of $\mathfrak{G}_{1}$ in $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$. The proof of density (Theorem 5.9) requires induction on $k$. Hence to indicate dependency on $k$, we identify $\mathfrak{G}_{1}$ by $\mathfrak{G}_{1}^{k}$ and $\gamma_{\mathbf{1}, a}$ by $\gamma_{\mathbf{1}, a}^{k}$ as needed in this subsection.
Lemma 5.7. Let $k>1$ and assume $\mathfrak{G}_{1}^{k-1}$ is dense in $C_{b, u}\left(\mathbb{N}_{0}^{k-1}, \rho_{k-1}\right)$. For $i=1, \ldots, k$ and $m_{o} \in \mathbb{N}_{0}$, define the set $K_{i}\left(m_{0}\right) \subset \mathbb{N}_{0}^{k}$

$$
K_{i}\left(m_{0}\right)=\left\{\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right) \in \mathbb{N}_{0}^{k} \mid m_{i}=m_{0}\right\} .
$$

Let $\sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ and let $\epsilon>0$. Then there exists $a \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$ s.t.

$$
\left\|\sigma \chi_{K_{i}\left(m_{0}\right)}-\gamma_{1, a}^{k}\right\|_{\infty}<\epsilon .
$$

Proof. Identify $K_{i}\left(m_{0}\right)$ with $\mathbb{N}_{0}^{k-1}$ by the map

$$
p_{i, m_{0}}:\left(m_{1}, \ldots, m_{i-1}, m_{o}, m_{i+1} \ldots, m_{k}\right) \mapsto\left(m_{1}, \ldots, m_{i-1}, m_{i+1}, \ldots, m_{k}\right) .
$$

Define $\sigma_{m_{0}}: \mathbb{N}_{0}^{k-1} \rightarrow \mathbb{C}$ by

$$
\sigma_{m_{0}}\left(m_{1}, \ldots, m_{k-1}\right)=\sigma \chi_{K_{i}\left(m_{0}\right)}\left(p_{i, m_{0}}^{-1}\left(m_{1}, \ldots, m_{k-1}\right)\right) .
$$

Then $\sigma_{m_{0}} \in C_{b, u}\left(\mathbb{N}_{0}^{k-1}, \rho_{k-1}\right)$. By the assumption there is $b \in L^{\infty}\left(\mathbb{R}_{+}^{k-1}\right)$ s.t.

$$
\left\|\sigma_{m_{0}}-\gamma_{\mathbf{1}, b}^{k-1}\right\|<\frac{\epsilon}{2}
$$

Since $\chi_{\left\{m_{0}\right\}} \in C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$, there is $c \in L^{\infty}\left(\mathbb{R}_{+}\right)$s.t.

$$
\left\|\chi_{\left\{m_{0}\right\}}-\gamma_{\mathbf{1}, c}\right\|<\|b\|_{\infty} \frac{\epsilon}{2} .
$$

Now define $a \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$ by

$$
a(\boldsymbol{x})=b\left(x_{1}, \ldots, x_{i-1}, x_{i+1}, \ldots, x_{k}\right) c\left(x_{i}\right) \quad \forall \boldsymbol{x} \in \mathbb{R}_{+}^{k}
$$

Then $\gamma_{\mathbf{1}, a}^{k}(\boldsymbol{m})=\gamma_{\mathbf{1}, b}^{k-1}\left(p_{i}(\boldsymbol{m})\right) \gamma_{\mathbf{1}, c}\left(m_{i}\right)$ for all $\boldsymbol{m} \in \mathbb{N}_{0}^{k}$. Let $\nu \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ be defined by $\nu(\boldsymbol{m})=$ $\gamma_{\mathbf{1}, b}^{k-1}\left(p_{i}(\boldsymbol{m})\right) \chi_{\left\{m_{0}\right\}}\left(m_{i}\right)$ for all $\boldsymbol{m} \in \mathbb{N}_{0}^{k}$. Then

$$
\begin{aligned}
\left\|\sigma \chi_{K_{i}\left(m_{0}\right)}-\gamma_{\mathbf{1}, a}^{k}\right\|_{\infty} & \leq\left\|\sigma \chi_{K_{i}\left(m_{0}\right)}-\nu\right\|_{\infty}+\left\|\nu-\gamma_{\mathbf{1}, a}^{k}\right\|_{\infty} \\
& \leq\left\|\sigma_{m_{0}}-\gamma_{\mathbf{1}, b}^{k-1}\right\|_{\infty}+\left\|\gamma_{\mathbf{1}, b}^{k-1}\right\|_{\infty}\left\|\gamma_{\mathbf{1}, c}-\chi_{\left\{m_{0}\right\}}\right\|_{\infty} \\
& <\frac{\epsilon}{2}+\|b\|_{\infty} \frac{\epsilon}{2\|b\|_{\infty}}=\epsilon .
\end{aligned}
$$

Lemma 5.8. Let $k>1$ and assume $\mathfrak{G}_{1}^{k-1}$ is dense in $C_{b, u}\left(\mathbb{N}_{0}^{k-1}, \rho_{k-1}\right)$. Let $K_{N} \subset \mathbb{N}_{0}^{k}$ be defined by

$$
K_{N}:=\left\{\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right) \in \mathbb{N}_{0}^{k} \mid m_{i} \leq N \text { for some } i\right\}
$$

Let $\sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ and let $\epsilon>0$. Then there exists $a \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$ s.t.

$$
\left\|\sigma \chi_{K_{N}}-\gamma_{1, a}\right\|_{\infty}<\epsilon .
$$

Proof. For $i=1, \ldots, k$ and $j=0,1, \ldots, N$, let the sets $K_{i}(j)$ be as defined in Lemma 5.7. Then there exists $\sigma_{(i, j)} \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ s.t. $\sigma_{(i, j)} \chi_{K_{i}(j)}=\sigma_{(i, j)}$ and

$$
\sigma \chi_{K_{N}}=\sum_{i=1}^{k} \sum_{j=1}^{N} \sigma_{(i, j)} .
$$

The functions $\sigma_{(i, j)}$ can be constructed by considering $\sigma \chi_{K_{i}(j)}$ and removing up to finitely many points from its support. By Lemma 5.7, there exists $a_{(i, j)} \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$ s.t.

$$
\left\|\sigma_{(i, j)}-\gamma_{\mathbf{1}, a_{(i, j)}}\right\|_{\infty}<\frac{\epsilon}{k N} .
$$

Define $a \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$ by $a=\sum_{i=1}^{k} \sum_{j=1}^{N} a_{(i, j)}$. Then $\gamma_{\mathbf{1}, a}=\sum_{i=1}^{k} \sum_{j=1}^{N} \gamma_{\mathbf{1}, a_{(i, j)}}$ and

$$
\begin{align*}
\left\|\sigma \chi_{K_{N}}-\gamma_{\mathbf{1}, a}\right\|_{\infty} & \leq \sum_{i=1}^{k} \sum_{j=1}^{N}\left\|\sigma_{(i, j)}-\gamma_{\mathbf{1}, a_{(i, j)}}\right\|_{\infty}  \tag{5.1}\\
& <k N \frac{\epsilon}{k N}=\epsilon .
\end{align*}
$$

Theorem 5.9. $\mathfrak{G}_{1}$ is dense in $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$.
Proof. The proof is by induction on $k$. The result for $k=1$ was proved in EM16. Assume the result is true for $k-1$. Let $\sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ and let $\epsilon>0$. By Proposition 5.6 there is $N$ and $b \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$ s.t. for all $\boldsymbol{m} \in \mathbb{N}_{0}^{k}$ with $m_{i}>N$,

$$
\left|\sigma(\boldsymbol{m})-\gamma_{\mathbf{1}, b}(\boldsymbol{m})\right|<\frac{\epsilon}{2} .
$$

By the induction hypothesis and Lemma [5.8, there exists $c \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$ s.t.

$$
\left\|\left(\sigma-\gamma_{\mathbf{1}, b}\right) \chi_{K_{N}}-\gamma_{\mathbf{1}, c}\right\|<\frac{\epsilon}{2} .
$$

Let $a=b+c$. Then $\gamma_{\mathbf{1}, a}=\gamma_{\mathbf{1}, b}+\gamma_{\mathbf{1}, c}$ and

$$
\begin{aligned}
\left\|\sigma-\gamma_{\mathbf{1}, a}\right\|_{\infty} & =\left\|\left(\sigma-\gamma_{\mathbf{1}, b}\right) \chi_{K_{N}^{c}}+\left(\sigma-\gamma_{\mathbf{1}, b}\right) \chi_{K_{N}}-\gamma_{\mathbf{1}, c}\right\|_{\infty} \\
& \leq\left\|\left(\sigma-\gamma_{\mathbf{1}, b}\right) \chi_{K_{N}^{c}}\right\|_{\infty}+\left\|\left(\sigma-\gamma_{\mathbf{1}, b}\right) \chi_{K_{N}}-\gamma_{\mathbf{1}, c}\right\|_{\infty} \\
& <\sup _{\substack{m \in \mathbb{N}_{0}^{k} \\
m_{i}>N \forall i}}\left|\sigma(\boldsymbol{m})-\gamma_{\mathbf{1}, b}(\boldsymbol{m})\right|+\frac{\epsilon}{2} \\
& <\frac{\epsilon}{2}+\frac{\epsilon}{2}=\epsilon .
\end{aligned}
$$

## 6. The $C^{*}$-Algebra generated By $\mathfrak{G}_{n}$

In this section we prove the density theorem in all generality: the $C^{*}$-algebra generated by $\mathfrak{G}_{n}$, where $\boldsymbol{n}=\left(n_{1}, \ldots, n_{k}\right)$, is the $C^{*}$-algebra $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$. We already noticed that $\gamma_{\boldsymbol{n}, a} \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ in Proposition 4.2. Recall the shift operators in definition 3.1. Following lemma is a restatement of Corollary 2.13

Lemma 6.1. The eigenvalue function $\gamma_{n, a}$ is the $(\boldsymbol{n}-\mathbf{1})^{\text {th }}$ left shift of $\gamma_{1, a}$, i.e.,

$$
\gamma_{n, a}=\tau_{L}^{n-1} \gamma_{1, a}
$$

Proposition 6.2. The set of eigenvalue functions $\mathfrak{G}_{n}$ is dense in the $C^{*}$-algebra $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ for any $\boldsymbol{n}=\left(n_{1}, \ldots, n_{k}\right) \in \mathbb{N}_{0}^{k}$.
Proof. Let $\sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ and let $\epsilon>0$. By Lemma 3.3, $\sigma^{\prime}:=\tau_{R}^{n-1} \sigma \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$. Also $\mathfrak{G}_{1}$ is dense in $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ by Theorem 5.9. Hence there exists $a \in L^{\infty}\left(\mathbb{R}_{+}^{k}\right)$ such that $\left\|\sigma^{\prime}-\gamma_{1, a}\right\|_{\infty}<\epsilon$. Then

$$
\begin{aligned}
\left\|\sigma-\gamma_{n, a}\right\|_{\infty} & =\left\|\tau_{L}^{n-1} \sigma^{\prime}-\tau_{L}^{n-1} \gamma_{1, a}\right\|_{\infty} \\
& =\left\|\tau_{L}^{n-\mathbf{1}}\right\|\left\|\sigma^{\prime}-\gamma_{\mathbf{1}, a}\right\|_{\infty}<\epsilon
\end{aligned}
$$

as $\left\|\tau_{L}^{n-1}\right\|<1$.
It follows that the $C^{*}$-algebra generated by $\mathfrak{G}_{n}$ is the $C^{*}$-algebra $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$.

$$
\text { 7. A COMPARISON OF } C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right) \text { WITH } C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right) \otimes \cdots \otimes C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)
$$

In this section we compare the $C^{*}$-algebra $C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$ with the $C^{*}$-tensor product $C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right) \otimes$ $\cdots \otimes C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$.

By Corollary 2.17 and the density of $\mathfrak{G}_{1}$ in $C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$, we have the following proposition.
Proposition 7.1. Let

$$
\tilde{\mathfrak{G}}_{\boldsymbol{n}}=\left\{\gamma_{\boldsymbol{n}, a} \mid a \in L^{\infty}\left(\mathbb{R}_{+}\right) \otimes \cdots \otimes L^{\infty}\left(\mathbb{R}_{+}\right)\right\}
$$

Then $\tilde{\mathfrak{G}}_{n}$ is dense in $C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right) \otimes \cdots \otimes C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$.
We have the inclusions

$$
C_{b, u}\left(\mathbb{N}_{0}^{k-1}, \rho_{k-1}\right) \otimes C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right) \stackrel{i_{k}}{\longleftrightarrow} C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right) .
$$

In fact

$$
C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right) \otimes \cdots \otimes C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right) \hookrightarrow C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)
$$

However, the above inclusions are not necessarily isomorphisms. We present a counter example for $k=2$.
7.1. A counter example. Here we construct a counter example to show that $C_{b, u}\left(\mathbb{N}_{0}^{2}, \rho_{2}\right)$ is strictly larger than $C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right) \otimes C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$. Let

$$
I_{i}:[\sqrt{i}, \sqrt{i}+\pi) ; i \in \mathbb{N}_{0}
$$

Define $g: \mathbb{N}_{0}^{2} \rightarrow \mathbb{C}$ by

$$
g(i, j)=\sin (\sqrt{j}-\sqrt{i}) \chi_{I_{i}}(\sqrt{j}) ;(i, j) \in \mathbb{N}_{0}^{2}
$$

Lemma 7.2. Let $g$ be the function defined above. Then $g \in C_{b, u}\left(\mathbb{N}_{0}^{2}, \rho_{2}\right)$.

Proof. Clearly $g$ is bounded. First we show that if $\left|\sqrt{j}-\sqrt{j^{\prime}}\right|<\pi$,

$$
\left|g(i, j)-g\left(i, j^{\prime}\right)\right|<\left|\sqrt{j}-\sqrt{j^{\prime}}\right| .
$$

If $\sqrt{j}, \sqrt{j^{\prime}} \notin I_{i}$,

$$
\left|g(i, j)-g\left(i, j^{\prime}\right)\right|=0<\left|\sqrt{j}-\sqrt{j^{\prime}}\right|
$$

W.l.o.g. assume $\sqrt{j} \in I_{i}$. Then $\sqrt{j^{\prime}} \in(\sqrt{i}-\pi, \sqrt{i}+2 \pi)$ as $\left|\sqrt{j}-\sqrt{j^{\prime}}\right|<\pi$. Note that if $\sqrt{j^{\prime}} \in I_{i}$, $\sin \left(\sqrt{j^{\prime}}-\sqrt{i}\right)=g\left(j^{\prime}, i\right)$ and if $\sqrt{j^{\prime}} \in(\sqrt{i}-\pi, \sqrt{i}) \cup(\sqrt{i}+\pi, \sqrt{i}+2 \pi), \sin \left(\sqrt{j^{\prime}}-\sqrt{i}\right)<0$. Hence

$$
\begin{aligned}
\left|g(i, j)-g\left(i, j^{\prime}\right)\right| & \leq\left|\sin (\sqrt{j}-\sqrt{i})-\sin \left(\sqrt{j^{\prime}}-\sqrt{i}\right)\right| \\
& \leq\left|\sqrt{j}-\sqrt{j^{\prime}}\right|
\end{aligned}
$$

as required. Next we prove that if $\left|\sqrt{i}-\sqrt{i^{\prime}}\right|<\pi$,

$$
\left|g(i, j)-g\left(i^{\prime}, j\right)\right|<\left|\sqrt{i}-\sqrt{i^{\prime}}\right| .
$$

If $\sqrt{j} \notin I_{i} \cup I_{i^{\prime}},\left|g(i, j)-g\left(i^{\prime}, j\right)\right|=0<\left|\sqrt{i}-\sqrt{i^{\prime}}\right|$. W.l.o.g., assume that $\sqrt{j} \in I_{i}$. Then $\sqrt{j} \in\left(\sqrt{i^{\prime}}-\pi, \sqrt{i^{\prime}}+2 \pi\right)$ as $\left|\sqrt{i}-\sqrt{i^{\prime}}\right|<\pi$. Therefore

$$
\begin{aligned}
\left|g(i, j)-g\left(i^{\prime}, j\right)\right| & \leq\left|\sin (\sqrt{j}-\sqrt{i})-\sin \left(\sqrt{j}-\sqrt{i^{\prime}}\right)\right| \\
& \leq\left|\sqrt{i}-\sqrt{i^{\prime}}\right|,
\end{aligned}
$$

proving the inequality.
Now notice that for all $(i, j),\left(i^{\prime}, j^{\prime}\right) \in \mathbb{N}_{0}^{2}$ such that $\rho_{2}\left((i, j),\left(i^{\prime}, j^{\prime}\right)\right)<\pi$,

$$
\begin{aligned}
\left|g(i, j)-g\left(i^{\prime}, j^{\prime}\right)\right| & \leq\left|g(i, j)-g\left(i^{\prime}, j\right)\right|+\left|g\left(i^{\prime}, j\right)-g\left(i^{\prime}, j^{\prime}\right)\right| \\
& \leq\left|\sqrt{i}-\sqrt{i^{\prime}}\right|+\left|\sqrt{j}-\sqrt{j^{\prime}}\right| \\
& <\rho_{2}\left((i, j),\left(i^{\prime}, j^{\prime}\right)\right),
\end{aligned}
$$

proving that $g \in C_{b, u}\left(\mathbb{N}_{0}^{2}, \rho_{2}\right)$.
Definition 7.3. If $X$ is a locally compact Hausdorff space and if $A$ is a $C^{*}$-algebra equipped with $\|\cdot\|_{A}$, let $C^{b}(X, A)$ be the set of all continuous bounded functions $f: X \rightarrow A$ equipped with the norm $\|\cdot\|_{\infty}$ given by

$$
\|f\|_{\infty}=\sup _{x \in X}\|f(x)\|_{A} .
$$

It is well known that $C^{b}(X, A)$ is $C^{*}$-algebra. Recall that a subset of a topological space is said to be precompact if its closure is compact. The following theorem from Williams [W03] describes a criterion to check whether an element in the $\mathrm{C}^{*}$-algebra $C^{b}(X, A)$ belongs to the possibly smaller $\mathrm{C}^{*}$-algebra $C^{b}(X) \otimes A$. We will use the Theorem [7.4] to show that $g \notin C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right) \otimes C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$.
Theorem 7.4 (Williams W03). If $X$ is a locally compact Hausdorff space and if $A$ is a $C^{*}$ algebra, then $f \in C^{b}(X, A)$ is in $C^{b}(X) \otimes A$ if and only if the range of $f, R(f):=\{f(x): x \in X\}$, is precompact.

In order to use Theorem 7.4 we present several lemmas about $g$. The proof of Lemma 7.5 is trivial as $\mathbb{N}_{0}$ has discrete topology and $g$ is bounded.

Lemma 7.5. Let $g$ be the function defined above. Define $\tilde{g}: \mathbb{N}_{0} \rightarrow C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$ by

$$
\tilde{g}(i)=g(i, \cdot) .
$$

Then $\tilde{g} \in C^{b}\left(\mathbb{N}_{0}, C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)\right)$.
Lemma 7.6. Let $\tilde{g}: \mathbb{N}_{0} \rightarrow C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$ be defined as in Lemma 7.5. Then $\|\tilde{g}(i)\|_{\infty} \geq \frac{1}{2}$ for all $i \in \mathbb{N}_{0}$.

Proof. Notice that for all $i \in \mathbb{N}_{0}$ and for all $p \in \mathbb{N}$,

$$
\sqrt{i+p}-\sqrt{i+p-1} \leq 1<\frac{2 \pi}{3}
$$

because $\sqrt{i+p}-\sqrt{i+p-1}$ attains its maximum when $i+p=1$. Fix $i \in \mathbb{N}_{0}$. Then the sequence $\{\sqrt{i+p}\}_{p=1}^{\infty}$ contains a point in any interval of length $\frac{2 \pi}{3}$ and, in particular, it contains a point in $\left(\sqrt{i}+\frac{\pi}{6}, \sqrt{i}+\frac{5 \pi}{6}\right)$. Denote that point by $\sqrt{i+p_{0}}$. Then $\sqrt{i+p_{0}}-\sqrt{i} \in\left(\frac{\pi}{6}, \frac{5 \pi}{6}\right)$ and

$$
\begin{aligned}
\|\tilde{g}(i)\|_{\infty} & \geq\left|(\tilde{g}(i))\left(i+p_{0}\right)\right| \\
& =\sin \left(\sqrt{i+p_{0}}-\sqrt{i}\right) \\
& \geq \frac{1}{2} .
\end{aligned}
$$

Lemma 7.7. Let $\tilde{g}: \mathbb{N}_{0} \rightarrow C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$ be defined as in Lemma 7.5. Then the range of $\tilde{g}$ is not precompact.

Proof. Whenever $\left|\sqrt{i_{1}}-\sqrt{i_{2}}\right|>\pi, I_{i_{1}} \cap I_{i_{2}}=\emptyset$ and hence

$$
\left\|\tilde{g}\left(i_{1}\right)-\tilde{g}\left(i_{2}\right)\right\|_{\infty}=\max \left\{\left\|\tilde{g}\left(i_{1}\right)\right\|_{\infty},\left\|\tilde{g}\left(i_{2}\right)\right\|_{\infty}\right\} \geq \frac{1}{2} .
$$

Thus there exits a sequence $\left\{\tilde{g}\left(i_{s}\right)\right\}_{s=1}^{\infty}$ s.t. $\left\|\tilde{g}\left(i_{s_{1}}\right)-\tilde{g}\left(i_{s_{2}}\right)\right\|_{\infty} \geq \frac{1}{2}$ whenever $s_{1} \neq s_{2}$. It follows that the range of $\tilde{g}$ is not totally bounded and hence it is not precompact.

By Lemma 7.5, Lemma 7.7, and Therorem 7.4, we have that $g \notin C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right) \otimes C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$. Also by Lemma 7.2, $g \in C_{b, u}\left(\mathbb{N}_{0}^{2}, \rho_{2}\right)$. Hence we have the following proposition.

Proposition 7.8. $C_{b, u}\left(\mathbb{N}_{0}^{2}, \rho_{2}\right)$ is strictly larger than $C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right) \otimes C_{b, u}\left(\mathbb{N}_{0}, \rho_{1}\right)$.

## 8. Appendix: The proof of Lemma 3.4

In this appendix, we present the proof of Lemma [3.4. It is easy to see that $\left.f\right|_{\mathbb{N}_{0}^{k}}=\sigma$, from the definition of $f$.
8.1. The uniform norm of $f$. To show that $\|f\|_{\infty}=\|\sigma\|_{\infty}$, we will use the following lemma.

Lemma 8.1. Let $s \in \mathbb{N}$ and let $a_{i} \in(0,1)$ for all $i=1, \ldots, s$ Then

$$
1+\sum_{l=1}^{s}(-1)^{l} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, s\} \\ i_{1}<\ldots<i_{l}}} \prod_{q=1}^{l} a_{i_{q}} \geq 0
$$

Proof. Notice that the statement is true for $s=1$. Assume the result is true for $s$. Then

$$
\begin{aligned}
1+\sum_{l=1}^{s+1}(-1)^{l} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, s+1\} \\
i_{1}<\ldots<i_{l}}} \prod_{q=1}^{l} a_{i_{q}}= & +\sum_{l=1}^{s}(-1)^{l} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, s\} \\
i_{1}<\cdots<i_{l}}} \prod_{q=1}^{l} a_{i_{q}} \\
& -a_{s+1}\left(1+\sum_{l=1}^{s}(-1)^{l} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, s\} \\
i_{1}<\cdots<i_{l}}} \prod_{q=1}^{l} a_{i_{q}}\right) \\
= & \left(1-a_{s+1}\right)\left(1+\sum_{l=1}^{s}(-1)^{l} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, s\} \\
i_{1}<\cdots<i_{l}}} \prod_{q=1}^{l} a_{i_{q}}\right)
\end{aligned}
$$

$$
\geq 0 .
$$

Hence the statement is true by induction on $s$.
Note that $f_{m}$ can also be written as

$$
f_{\boldsymbol{m}}(\boldsymbol{x})=\sigma(\boldsymbol{m}) B_{0}(\boldsymbol{x}, \boldsymbol{m})+\sum_{\substack{j_{1}, \ldots, j_{s} \in\{1, \ldots, k\} \\ j_{1}<\cdots<j_{s}}} \sigma\left(\boldsymbol{m}+e_{j_{1}}+\cdots+e_{j_{s}}\right) B_{j_{1}, \ldots, j_{s}}(\boldsymbol{x}, \boldsymbol{m})
$$

where

$$
B_{j_{1}, \ldots, j_{s}}(\boldsymbol{x}, \boldsymbol{m})=\prod_{p=1}^{s} \frac{\sqrt{x_{j_{p}}}-\sqrt{m_{j_{p}}}}{\sqrt{m_{j_{p}}+1}-\sqrt{m_{j_{p}}}}\left(1+\sum_{l=1}^{k-s}(-1)^{l} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, k\} \backslash\left\{j_{1}, \ldots, j_{s}\right\} \\ i_{1}<\ldots<i_{l}}} \prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}}-\sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}}\right)
$$

and

$$
B_{0}(\boldsymbol{x}, \boldsymbol{m})=1+\sum_{l=1}^{k}(-1)^{l} \sum_{\substack{i_{1}, \ldots, i_{1} \in\{1, \ldots, k\} \\ i_{1}<\cdots<i_{l}}} \prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}}-\sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}} .
$$

The coefficients $B_{j_{1}, \ldots, j_{s}}(\boldsymbol{x}, \boldsymbol{m})$ are computed by summing the products

$$
(-1)^{l-s} \prod_{q=1}^{l} \frac{\sqrt{x_{j_{q}}}-\sqrt{m_{j_{q}}}}{\sqrt{m_{j_{q}}+1}-\sqrt{m_{j_{q}}}}
$$

over $\left\{i_{1}, \ldots, i_{l}\right\}$ such that $i_{1}<\cdots<i_{l}$ and $\left\{j_{1}, \ldots, j_{s}\right\} \subset\left\{i_{1}, \ldots, i_{l}\right\}$.
Consider the sum

$$
B_{0}(\boldsymbol{x}, \boldsymbol{m})+\sum_{\substack{j_{1}, \ldots, j_{s} \in\{1, \ldots, k\} \\ j_{1}<\ldots<j_{s}}} B_{j_{1}, \ldots, j_{s}}(\boldsymbol{x}, \boldsymbol{m}) .
$$

Let $l \in \mathbb{N}$ and let $i_{1}, \ldots, i_{l} \in\{1, \ldots, k\}$ such that $i_{1}<\cdots<i_{l}$. Note that $(-1)^{l-s} \prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}}-\sqrt{m_{i q}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}}$ is a term in $B_{j_{1}, \ldots, j_{s}}(\boldsymbol{x}, \boldsymbol{m})$ whenever $\left\{j_{1}, \ldots, j_{s}\right\} \subset\left\{i_{1}, \ldots, i_{l}\right\}$. Therefore in the above sum, the coefficient of $\prod_{q=1}^{l} \frac{\sqrt{x i_{q}}-\sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}}$ is given by

$$
\sum_{s=0}^{l}(-1)^{l-s}\binom{l}{s}=(1-1)^{l}=0
$$

Hence

$$
B_{0}(\boldsymbol{x}, \boldsymbol{m})+\sum_{\substack{j_{1}, \ldots, j_{s} \in\{1, \ldots, k\} \\ j_{1}<\cdots<j_{s}}} B_{j_{1}, \ldots, j_{s}}(\boldsymbol{x}, \boldsymbol{m})=1
$$

Also, if $\boldsymbol{x} \in \prod_{i=1}^{k}\left[m_{i}, m_{i}+1\right), B_{j_{1}, \ldots, j_{s}}(\boldsymbol{x}, \boldsymbol{m}) \geq 0$ by Lemma 8.1 and hence

$$
\begin{aligned}
\left|f_{\boldsymbol{m}}(\boldsymbol{x})\right| & \leq\|\sigma\|_{\infty}\left(B_{0}(\boldsymbol{x}, \boldsymbol{m})+\sum_{\substack{j_{1}, \ldots, j_{s} \in\{1, \ldots, k\} \\
j_{1}<\cdots j_{s}}} B_{j_{1}, \ldots, j_{s}}(\boldsymbol{x}, \boldsymbol{m})\right) \\
& =\|\sigma\|_{\infty}
\end{aligned}
$$

Therefore $\|f\|_{\infty}=\|\sigma\|_{\infty}$ as $\left.f\right|_{\mathbb{N}_{0}^{k}}=\sigma$.
8.2. Some useful lemmas. The following lemma is quite useful in the proofs that follow.

Lemma 8.2. Let $l, s \in\{1, \ldots, k\}$. Suppose $i_{1}, \ldots, i_{l} \in\{1, \ldots, k\}$ such that $i_{1}<\cdots<i_{l}$. Then

Proof. To keep the notations simple, we will assume $s>i_{l}$ and we label $s$ by $i_{l+1}$.

& a_{i_{1}, \ldots, i_{l+1}}^{l+1}(\boldsymbol{m})=\sum_{q=0}^{l+1}(-1)^{l+1-q} \sum_{\substack{j_{1}, \ldots, j_{q} \in\left\{i_{1}, \ldots, i_{l+1}\right\} \\
j_{1}<\cdots<j_{q}}} \sigma\left(\boldsymbol{m}+e_{j_{1}}+\cdots+e_{j_{q}}\right) \\
& =(-1)^{l+1} \sigma(\boldsymbol{m})+\sum_{q=1}^{l}(-1)^{l+1-q}\left(\sum_{\substack{j_{1}, \ldots, j_{q} \in\left\{i_{1}, \ldots, i_{l}\right\} \\
j_{1}<\cdots<j_{q}}} \sigma\left(\boldsymbol{m}+e_{j_{1}}+\cdots+e_{j_{q}}\right)\right. \\
& \left.+\sum_{\substack{j_{1}, \ldots, j_{q-1} \in\left\{i_{1}, \ldots, i_{l}\right\} \\
j_{1}<\cdots<j_{q-1}}} \sigma\left(\boldsymbol{m}+e_{j_{1}}+\cdots+e_{j_{q-1}}+e_{i_{l}}\right)\right)+\sigma\left(\boldsymbol{m}+e_{i_{1}}+\cdots+e_{i_{l}}\right) \\
& =-\sum_{q=0}^{l}(-1)^{l-q} \sum_{\substack{j_{1}, \ldots, j_{q} \in\left\{i_{1}, \ldots, i_{l}\right\} \\
j_{1}<\cdots<j_{q}}} \sigma\left(\boldsymbol{m}+e_{j_{1}}+\cdots+e_{j_{q}}\right) \\
& +\sum_{q=1}^{l+1}(-1)^{l+1-q} \sum_{\substack{j_{1}, \ldots, j_{q-1} \in\left\{i_{1}, \ldots, i_{l}\right\} \\
j_{1}<\cdots<j_{q-1}}} \sigma\left(\boldsymbol{m}+e_{i_{l}}+e_{j_{1}}+\cdots+e_{j_{q-1}}\right) \\
& =-a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m})+\sum_{q=0}^{l}(-1)^{l-q} \sum_{\substack{j_{1}, \ldots, j_{q} \in\left\{i_{1}, \ldots, i_{l}\right\} \\
j_{1}<\cdots<j_{q}}} \sigma\left(\left(\boldsymbol{m}+e_{i_{l}}\right)+e_{j_{1}}+\cdots+e_{j_{q}}\right) \\
& =a_{i_{1}, \ldots, i_{l}}^{l}\left(\boldsymbol{m}+e_{l+1}\right)-a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m}) .
\end{aligned}
$$

Notice that $f$ is defined on $\prod_{i=1}^{k}\left[m_{i}, m_{i}+1\right)$ by $f_{m}$. But the following lemma allows $f$ to be defined on $\prod_{i=1}^{k}\left[m_{i}, m_{i}+1\right]$ by $f_{m}$.

Lemma 8.3. Let $\boldsymbol{x} \in \mathbb{R}_{+}^{k}$, $\boldsymbol{m} \in \mathbb{N}_{0}^{k}$ and let $s \in\{1, \ldots, k\}$. Suppose $\left\lfloor x_{i}\right\rfloor=m_{i}$ for all $i$. Then

Proof. Note that the $s^{\text {th }}$ coordinate of $\boldsymbol{x}+\left(1-x_{s}\right) e_{s}$ is $m_{s}+1$. Therefore

& f_{\boldsymbol{m}}\left(\boldsymbol{x}+\left(1-x_{s}\right) e_{s}\right)= \sigma(\boldsymbol{m})+\sum_{l=1}^{k-1} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, k\} \backslash\{s\} \\
i_{1}<\ldots<i_{l}}} a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m}) \prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}}-\sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}} \\
&+a_{s}^{1}+\sum_{\substack{l=2}}^{k} \sum_{\substack{\left.i_{1}, \ldots, i_{1} \in\{1, \ldots, k\} \\
s \in i_{1}, \ldots, i_{k}\right\} \\
i_{1}<\ldots<i_{l}}} a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m}) \prod_{\substack{q=1 \\
i_{q} \neq s}}^{l} \frac{\sqrt{x_{i_{q}}}-\sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}} \\
&=\sigma\left(\boldsymbol{m}+e_{s}\right)+\left(\sum_{l=1}^{k-1} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, k\} \backslash\{s\} \\
i_{1}<\cdots<i_{l}}}\left(a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m})+a_{i_{1}, \ldots, s, \ldots, i_{l}}^{l+1}(\boldsymbol{m})\right)\right. \\
&\left.\times \prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}}-\sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}}\right)
\end{aligned}
$$

by reindexing the last summand and because $\sigma(\boldsymbol{m})+a_{s}^{1}=\sigma\left(\boldsymbol{m}+e_{s}\right)$. Also,

a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m})+a_{i_{1}, \ldots, s, \ldots, i_{l}}^{l+1}(\boldsymbol{m})=a_{i_{1}, \ldots, i_{l}}^{l}\left(\boldsymbol{m}+e_{s}\right)
$$

by Lemma 8.2. Then

\begin{aligned}
f_{\boldsymbol{m}}\left(\boldsymbol{x}+\left(1-x_{s}\right) e_{s}\right) & =\sigma\left(\boldsymbol{m}+e_{s}\right)+\sum_{l=1}^{k-1} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, k\} \backslash\{s\} \\
i_{1}<\cdots<i_{l}}} a_{i_{1}, \ldots, i_{l}}^{l}\left(\boldsymbol{m}+e_{s}\right) \prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}}-\sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}} \\
& =f_{\boldsymbol{m}+e_{s}}\left(\boldsymbol{x}+\left(1-x_{s}\right) e_{s}\right) \\
& =f\left(\boldsymbol{x}+\left(1-x_{s}\right) e_{s}\right) .
\end{aligned}
$$

The second equality in the above computation holds as the $s^{\text {th }}$ coordinate of $\boldsymbol{x}+\left(1-x_{s}\right) e_{s}$ is $m_{s}+1$ and hence any term in $f_{m+e_{s}}\left(\boldsymbol{x}+\left(1-x_{s}\right) e_{s}\right)$ indexed by $\left\{i_{1}, \ldots, i_{l}\right\}$ would vanish if $s \in$ $\left\{i_{1}, \ldots, i_{l}\right\}$.

As a consequence of above lemma, we have the following corollary.
Corollary 8.4. Let $\boldsymbol{m} \in \mathbb{N}_{0}^{k}$ and let $\boldsymbol{x} \in \prod_{i=1}^{k}\left[m_{i}, m_{i}+1\right]$. Then

f(x)=f_{m}(x) .
$$

Lemma 8.5. Let $l \in \mathbb{N}$ and let $a_{i}, b_{i} \in \mathbb{C}$ such that $\left|a_{i}\right|,\left|b_{i}\right| \leq 1$ for all $i=1, \ldots, l$. Then

\left|\prod_{i=1}^{l} a_{i}-\prod_{i=1}^{l} b_{i}\right| \leq \sum_{i=1}^{l}\left|a_{i}-b_{i}\right| .
$$

Proof. Clearly, the result holds for $l=1$. Assume that the result is true for $l$. Then by triangle inequality,

\left|\prod_{i=1}^{l+1} a_{i}-\prod_{i=1}^{l+1} b_{i}\right| & \leq\left|a_{l+1}-b_{l+1}\right|\left|\prod_{i=1}^{l} a_{i}\right|+\left|b_{l+1}\right|\left|\prod_{i=1}^{l} a_{i}-\prod_{i=1}^{l} b_{i}\right| \\
& \leq\left|a_{l+1}-b_{l+1}\right|+\left|\prod_{i=1}^{l} a_{i}-\prod_{i=1}^{l} b_{i}\right| \\
& \leq \sum_{i=1}^{l+1}\left|a_{i}-b_{i}\right| .
\end{aligned}
$$

Hence, the result is true by induction on $l$.
8.3. The uniform continuity of $f$ with respect to the square-root metric. Let $\boldsymbol{x}, \boldsymbol{x}^{\prime} \in \mathbb{R}_{+}^{k}$ s.t. $\rho_{k}\left(\boldsymbol{x}, \boldsymbol{x}^{\prime}\right)<\delta$. Let $\boldsymbol{m}=\left(m_{1}, \ldots, m_{k}\right)$ and $\boldsymbol{m}^{\prime}=\left(m_{1}^{\prime}, \ldots, m_{k}^{\prime}\right)$ where $m_{i}=\left\lfloor x_{i}\right\rfloor$ and $m_{i}^{\prime}=\left\lfloor x_{i}^{\prime}\right\rfloor$ for $i=1, \ldots, k$.
Case I. Assume $x_{i}^{\prime} \in\left[m_{i}, m_{i+1}\right]$ for all $i$. Then by Corollary 8.4

& \times\left|\prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}}-\sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}}-\prod_{q=1}^{l} \frac{\sqrt{x_{i_{q}}^{\prime}}-\sqrt{m_{i_{q}}}}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}}\right| \\
\leq & \sum_{l=1}^{k} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, k\} \\
i_{1}<\cdots<i_{l}}}\left|a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m})\right| \sum_{q=1}^{l} \frac{\left|\sqrt{x_{i_{q}}}-\sqrt{x_{i_{q}}^{\prime}}\right|}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}}
\end{aligned}
$$

by Lemma 8.5
Fix $l \in\{1, \ldots, k\}$ and $i_{1}, \ldots, i_{l} \in\{1, \ldots, k\}$ s.t. $i_{1}<\cdots<i_{l}$.
If $\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}} \geq \sqrt{\delta}$ for all $q=1, \ldots, l$,

$$
\begin{aligned}
\left|a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m})\right| \sum_{q=1}^{l} \frac{\left|\sqrt{x_{i_{q}}}-\sqrt{x_{i_{q}}^{\prime}}\right|}{\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}} & \leq\left|a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m})\right| \frac{l \delta}{\sqrt{\delta}} \\
& \leq 2^{l} l\|\sigma\|_{\infty} \sqrt{\delta}
\end{aligned}
$$

as $\left|a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m})\right| \leq 2^{l}\|\sigma\|_{\infty}$.
Assume $\sqrt{m_{i_{q}}+1}-\sqrt{m_{i_{q}}}<\sqrt{\delta}$ for some $q \in\{1, \ldots, l\}$. W.l.o.g. assume $\sqrt{m_{i_{l}}+1}-\sqrt{m_{i_{l}}}<\sqrt{\delta}$.

If $l \geq 2$,

$$
\begin{aligned}
& \left|a_{i_{1}, \ldots, i_{l}}^{l}(\boldsymbol{m})\right| \\
& \quad=\left|a_{i_{1}, \ldots, i_{l}}^{l-1}\left(\boldsymbol{m}+e_{i_{l}}\right)-a_{i_{1}, \ldots, i_{l}}^{l-1}(\boldsymbol{m})\right| \\
& \quad \leq \sum_{\substack{j_{1}, \ldots, j_{q} \in\left\{i_{1}, \ldots, i_{l-1}\right\} \\
q \in\{0, \ldots, l-1\}}}\left|\sigma\left(\boldsymbol{m}+e_{j_{1}}+\cdots+e_{j_{q}}+e_{i_{l}}\right)-\sigma\left(\boldsymbol{m}+e_{j_{1}}+\cdots+e_{j_{q}}\right)\right| \\
& \quad \leq 2^{l-1} \omega_{\rho_{k}, \sigma}(\sqrt{\delta})
\end{aligned}
$$

Hence

$$
\begin{aligned}
\left|f(\boldsymbol{x})-f\left(\boldsymbol{x}^{\prime}\right)\right| & \leq \sum_{l=1}^{k} \sum_{\substack{i_{1}, \ldots, i_{l} \in\{1, \ldots, k\} \\
i_{1}<\cdots<i_{l}}} 2^{l-1} l \max \left\{2\|\sigma\|_{\infty} \sqrt{\delta}, \omega_{\rho_{k}, \sigma}(\sqrt{\delta})\right\} \\
& =A_{k} \max \left\{2\|\sigma\|_{\infty} \sqrt{\delta}, \omega_{\rho_{k}, \sigma}(\sqrt{\delta})\right\}
\end{aligned}
$$

where $A_{k}=k!\sum_{l=1}^{k} \frac{2^{l-1}}{(l-1)!(k-l)!}$.
Case II. Suppose $x_{i}^{\prime} \notin\left[m_{i}, m_{i}+1\right]$ for some $i$. Define $\boldsymbol{p}=\left(p_{1}, \ldots, p_{k}\right), \boldsymbol{p}^{\prime}=\left(p_{1}^{\prime}, \ldots, p_{k}^{\prime}\right) \in \mathbb{N}_{0}^{k}$ by

\begin{array}{cl}
p_{i}=m_{i}+1, p_{i}^{\prime}=m_{1}^{\prime} & \text { if } x_{i}<x_{i}^{\prime} \\
p_{i}=m_{i}, p_{i}^{\prime}=m_{1}^{\prime}+1 & \text { if } x_{i}>x_{i}^{\prime} \\
p_{i}=m_{i}=m_{i}^{\prime}=p_{i}^{\prime} & \text { if } x_{i}=x_{i}^{\prime}
\end{array}
$$

for $i=1, \ldots k$. Then $p_{i} \in\left[m_{i}, m_{i}+1\right]$ and $p_{i}^{\prime} \in\left[m_{i}^{\prime}, m_{1}^{\prime}+1\right]$ for all $i$. Hence by case $I$ and because $\rho_{k}\left(\boldsymbol{p}, \boldsymbol{p}^{\prime}\right) \leq \rho_{k}\left(\boldsymbol{x}, \boldsymbol{x}^{\prime}\right)<\delta$,

$$
\begin{aligned}
\left|f(\boldsymbol{x})-f\left(\boldsymbol{x}^{\prime}\right)\right| & \leq|f(\boldsymbol{x})-f(\boldsymbol{p})|+\left|\sigma(\boldsymbol{p})-\sigma\left(\boldsymbol{p}^{\prime}\right)\right|+\left|f\left(\boldsymbol{p}^{\prime}\right)-f\left(\boldsymbol{x}^{\prime}\right)\right| \\
& \leq 2 A_{k} \max \left\{2\|\sigma\|_{\infty} \sqrt{\delta}, \omega_{\rho_{k}, \sigma}(\sqrt{\delta})\right\}+\omega_{\rho_{k}, \sigma}(\delta)
\end{aligned}
$$

In both cases,

$$
\left|f(\boldsymbol{x})-f\left(\boldsymbol{x}^{\prime}\right)\right| \leq 2 A_{k} \max \left\{2\|\sigma\|_{\infty} \sqrt{\delta}, \omega_{\rho_{k}, \sigma}(\sqrt{\delta})\right\}+\omega_{\rho_{k}, \sigma}(\delta)
$$

Therefore $f \in C_{b, u}\left(\mathbb{N}_{0}^{k}, \rho_{k}\right)$. This completes the proof of Lemma 3.4.
