# The Landau-Kolmogorov Problem on a Finite Interval in the Taikov Case

#### Abstract

We solve the pointwise Landau-Kolmogorov problem on the interval $\mathbb{I}=[-1,1]$ on finding $\left|f^{(k)}(t)\right| \rightarrow$ sup under constraints $\|f\|_{2} \leqslant \delta$ and $\left\|f^{(r)}\right\|_{2} \leqslant 1$, where $t \in \mathbb{I}$ and $\delta>0$ are fixed. For $r=1$ and $r=2$, we solve the uniform version of the Landau-Kolmogorov problem on the interval $\mathbb{I}$ in the Taikov case by proving the Karlin-type conjecture $\sup _{t \in \mathbb{I}}\left|f^{(k)}(t)\right|=\left|f^{(k)}(-1)\right|$ under above constraints. The proof relies on the analysis of the dependence of the norm of the solution to higherorder Sturm-Liouville equation $(-1)^{r} u^{(2 r)}+\lambda u=-\lambda f$ with boundary conditions $u^{(s)}(-1)=u^{(s)}(1)=0, s=0,1, \ldots, r-1$, on non-negative parameter $\lambda$, where $f$ is some piece-wise polynomial function. Furthermore, we find sharp inequality $\left\|f^{(k)}\right\|_{\infty} \leqslant A\|f\|_{2}+B\left\|f^{(r)}\right\|_{2}$ with the smallest possible constant $A>0$ and the smallest possible constant $B=B(A)$ for $k \in\{r-2, r-1\}$.

## 1 Introduction

The Landau-Kolmogorov problem consists of finding sharp upper bound for the norm of intermediate function derivative in terms of the norm of the function itself and the norm of its higher order derivative.

Let $\mathbb{I}=[-1,1]$. For $1 \leqslant p \leqslant \infty$, let $L_{p}=L_{p}(\mathbb{I})$ be the space of measurable functions $f: \mathbb{I} \rightarrow \mathbb{R}$ having integrable $p$-th power (essentially bounded when $p=\infty$ ) with the standard norm:

Let $L_{p}^{r}, r \in \mathbb{N}$, be the space of functions $f: \mathbb{I} \rightarrow \mathbb{R}$ having absolutely continuous derivative $f^{(r-1)}$ and such that $f^{(r)} \in L_{p}$. By $W_{p}^{r}=\left\{f \in L_{p}^{r}:\|f\|_{p} \leqslant 1\right\}$ we denote the unit ball in space $L_{p}^{r}$.

Let $k, r \in \mathbb{Z}_{+}$be such that $0 \leqslant k \leqslant r-1$ and $1 \leqslant p, q, s \leqslant \infty$. The LandauKolmogorov problem consists of finding the modulus of continuity of operator $D^{k}: L_{p} \rightarrow L_{q}$ on the class $W_{s}^{r}$ :

In the case $q=\infty$ the pointwise Landau-Kolmogorov problem is also considered. It consists of finding the modulus of continuity of functional $D_{t}^{k}: L_{p} \rightarrow \mathbb{R}$, where $t \in \mathbb{I}$, on the class $W_{s}^{r}$ :

 $p=q=s=\infty$. S. Karlin ${ }^{3}$. ${ }^{\text {and }}$. Pinkus found $\Omega_{t}$ for all $t \in \mathbb{I}$ and $k, r \in \mathbb{N}$ with $k \leqslant r-1$. In 3 . Karlin conjectured that, for every $\delta>0$,

Although not fully proved, conjecture (3) is confirmed in many situations (see e.g., 12$]$ ): for $r=2$ by E. Landau 5 $\left(\delta \geqslant \delta_{2}\right)$; for $r=3$ by M. Sato 7$]^{2}$ and AI Zvyagintsev, A. Ya. Lepin independently; for $r=4$ by A.I. Zvyagintsev $\left[9 \geqslant \geqslant \delta_{4}\right)$ and N. Naidenov 10
 B.-O. Eriksson [11] $\left(\delta=\delta_{r}\right)$ and A. Yu. Shadrin $12\left(\delta>\delta_{r}\right)$. Here $\delta_{r}=\frac{1}{2^{r-1} r!}$.

Much less is known for other combinations of parameters $p, q, s$. Moduli of continuity $\Omega$ and $\Omega_{t}$ were found for all $\delta>0$ in the following situations:

3. $r=2, k=1, p=s=\infty, 1 \leqslant q<\infty$ by N. Naidenov $\frac{N a i}{16 ;} ;$
4. $r=3, k=1, p=q=\infty, r=1$ by the author $\frac{\text { Sko } 19}{17 .}$
 $r=3$ and $k=1,2$. For the overview of gher results.in this and closelp related directions we refer the reader to books $[21,[22,23]$ and surveys [24, 25].

In this paper we will study the Landau-Kolmogorov problem in the Taikov case, i.e. for $p=s=2$ and $q=\infty$. The consideration of the Taikov case is motivated by numerous sharp results on the Landau-Kolmogorov problem for functions defined on the real line $\mathbb{R}$ (see L. V. Taikov [26]), on the non-negative half-
 and L. L. Oridoroga 30 ), the period $\mathbb{T}=[0,2 \pi$ ) (see A. Yu. Shadrin [27]) and other domains. These results were generalized in various directions: for integral and fractional derivatives of multivariate functions, for powers of the Laplace-Beltrami operators on manifolds, for powers of infinitesimal generators of semigroups, for powers of self-adjoint operators and abstract linear operators acting in Hilbert (see [3I] and references therein).

Aforementioned advances make it natural to expect that problems (11) and (22) in the Taikov case can be solved in full. Curiously enough it seems no previous results in this setting are known.

### 1.1 Related problems

Additive inequalities for the norms of derivatives. The Landau-Kolmogorov problem can be formulated alternatively as the problem of finding the set $\Gamma=$ $\Gamma\left(D^{k} ; L_{s}^{r}\right)$ of all possible pairs $(A, B)$ of non-negative numbers such that, for every $f \in L_{r}^{s}$, there holds inequality

that is sharp in the sense of minimal possible constant $B$, i.e.

Modulus $\Omega$ and set $\Gamma$ are closely related as the following relations indicate

Hence, once moduli of continuity $\Omega$ and $\Omega_{t}$ are known, one can find the sets $\Gamma$
and $\Gamma_{t}$ immediately. Additional results on sharp additive inequalitiss minequan be
found in 18]. We also refer the reader to the papers for the overview of results on inequalities (174) and (5).

Remark an important relation between additive Landau-Kolmogorov inequalitides, and the Markov-Nikolskii inequalities. It was shown independently in [2, 19] that the minimal constant $A$ in inequality (17) coincides with the sharp constant $M=M\left(D^{k} ; \mathcal{P}_{r-1}\right)$ in the Markov-Nikolskii inequality

where $\mathcal{P}_{r-1}$ is the set of all algebraic polynomials of degree at most $r-1$. In other words, $B(A)$ in is finite if and only if $A \geqslant M$. Similarly, the minimal constant $A$ in inequality 5 coincides with the sharp constant $M_{t}=M\left(D_{t}^{k} ; \mathcal{P}_{r-1}\right)$ in the pointwise version of the Markov-Nikolskii inequality

Let $X$ and $Y$ be Banach spaces, $T: X \rightarrow Y$ be an operator with domain $\mathcal{D}(T)$ and $W \subset \mathcal{D}(T)$ be some set. Define the modulus of continuity of operator $T$ on the class $W$ :

Let $\mathcal{L}=\mathcal{L}(X, Y)$ be the set of all linear functionals $S: X \rightarrow Y$ and define the error of approximation of operator $T$ by operator $S \in \mathcal{L}$ on the class $W$ :

The Stechkin problem on the best approximation of the operator $T$ by linear bounded operators on $W$ consists in finding the quantity and extremal operators (if any exists) delivering inf in the rioht hand part of (111).
S.B. Stechkin (see also [25, 23]) obtained a simple effective lower estimate for $1 \Pi 1$.

Let $X$ and $Y$ be the Banach spaces, $T: X \rightarrow Y$ be an operator with domain $\mathcal{D}(T), W \subset \mathcal{D}(T)$ be some set. By $\mathscr{R}$ we denote either the set $\mathscr{L}$ of all linear operators acting from $X$ to $Y$, or the set of all mappings $\mathscr{O}$ from $X$ to $Y$. For an arbitrary $\delta \geqslant 0$ and $S \in \mathscr{R}$, we set

The detailed survey of known results and further references can be found e.g., in $[25]$. The following corollary from $[25$, Theorem 2.1 . indicates close relations with the Stechkin problem and problem (10).

### 1.2 Contribution and organization of the paper

In this paper we consider the case $p=s=2$ and $q=\infty$. We obtain the following results:

- Find $\Omega_{t}, t \in \mathbb{I}$, for all $r \in \mathbb{N}$ and $k \in \mathbb{Z}_{+}, k \leqslant r-1$;
- Find $\Omega$ for $r \in\{1,2\}$ and $k \in\{0, r-1\}$;
- Solve related problems (in), (47), (II) and (IF) in above cases;
- Find sharp inequality of the form (位) with minimal possible constant $A$ for $r \in \mathbb{N} \backslash\{1\}$ and $k \in\{r-2, r-1\}$.
The paper is organized as follows. In Section we solve pointwise LandauKolmogorov problem in the case $t= \pm 1$, and in Section forntwise_tany general case $-1<t<1$. The Landau-Kolmogorov problem in the case $q=\infty$ is considered in Section

For definiteness, everywhere below with except for Section iuniform assume that $r \in \mathbb{N}$ and $k \in \mathbb{Z}_{+}, k \leqslant r-1$, are arbitrary.

### 1.3 Main ideas of the proof

 intermediate approximation of $f^{(k)}(t), t \in \mathbb{I}$, with the help of bounded functional $S: L_{2} \rightarrow \mathbb{R}$. We consider $S$ of the form

where the function $w=w_{\lambda, t}: \mathbb{I} \rightarrow \mathbb{R}$ is chosen in a way that equation

holds with some $\lambda \geqslant 0$, and

Above choice of $w$ together with the Schwarz inequality leads to sharp inequality

\left|f^{(k)}(t)\right| \leqslant\left\|w^{(r)}\right\|_{2}\|f\|_{2}+\|w\|_{2}\left\|f^{(r)}\right\|_{2},

with extremal function $w^{(r)}$ in the case $\lambda>0$. Following the higher-order Sturm-Liouville theory and Fourier analysis with respect to eigen-functions of operator $\mathcal{A}=(-1)^{r} D^{2 r}$ with boundary conditions $\mathcal{B}: u^{(s)}(-1)=u^{(s)}(1)=0$, $s=0,1, \ldots, r-1$, we will show that the norm $\left\|w^{(r)}\right\|_{2}$ attains all values between the sharp constant $M_{t}$ in the Markov-Nikolskii inequality $\left|Q^{(k)}(t)\right| \leqslant M_{t}\|Q\|_{2}$, $Q \in \mathcal{P}_{r-1}$, and $+\infty$. Remark that operator $S$ above provides the solution to


To solve problems (11) and (4) we conjecture (see ( $100 \mid$ ) that the derivative $\varphi^{(r+k)}$ of every eigen-function of operator $\mathcal{A}$ with boundary conditions $\mathcal{B}$ attains its maximal absolute value at the endpoints $\pm 1$. We prove this conjecture in the figure_4 case $x \in\{1,2\}$ only. For $r \geqslant 3$, conjecture looks also plausible as graphs 1 and 2 indicate. Using this conjecture we can prove that for the same $\lambda \geqslant 0$, $\left\|w_{\lambda, t}\right\|_{2} \leqslant\left\|w_{\lambda,-1}\right\|_{2}$ and $\left\|w_{\lambda, t}^{(r)}\right\|_{2} \leqslant\left\|w_{\lambda,-1}^{(r)}\right\|$, which together with equality (lse)cond_relation_t proves that $\Omega(\delta)=\Omega_{-1}(\delta)$.

## 2 Case $t=-1$

For $\lambda \geqslant 0$, consider boundary value problem

Lemma 1. Let $r \in \mathbb{N}$ and $k \in \mathbb{Z}_{+}, k \leqslant r-1$. Then

1. problem (17) has a unique solution $u=u_{\lambda} \in L_{2}^{2 r}$ for every $\lambda \geqslant 0$;
2. the function $\left\|u_{\lambda}^{(r)}\right\|_{2}$ continuously increases in $\lambda$ and $\left\|u_{0}^{(r)}\right\|_{2}=M_{-1}$;
3. the function $\left\|u_{\lambda}\right\|_{2}$ continuously decreases in $\lambda$ and $\lim _{\lambda \rightarrow+\infty}\left\|u_{\lambda}\right\|_{2}=0$.

Remark that in $\frac{\mathrm{KozMaz}_{2} 97}{35}$ Questions on solvability of boundary value problems close to problem and properties of their solutions were studied.

The following result gives the solution to the Landau-Kolmogorov problem (2) for the functional $D_{-1}^{k}: L_{2} \rightarrow \mathbb{R}$ in the Taikov case and to the problem of the best recovery of $D_{-1}^{k}$ on class $W_{2}^{r}$ whose elements are given with an error.

Theorem 1. Let $r \in \mathbb{N}$ and $k \in \mathbb{Z}_{+}, k \leqslant r-1$, and $\mathscr{R}=\mathscr{O}$ or $\mathscr{R}=\mathscr{L}$. Then, for every $\delta>0$, there exists unique $\lambda=\lambda(\delta)>0$ such that $\delta \lambda \cdot\left\|u_{\lambda}\right\|_{2}=\left\|u_{\lambda}^{(r)}\right\|_{2}$, and there hold equalities

Theorem 2. Let $r \in \mathbb{N}$ and $k \in \mathbb{Z}_{+}, k \leqslant r-1$. Then

The following result delivers the solution to the problem on the best approximation of functional $D_{-1}^{k}: L_{2} \rightarrow \mathbb{R}$ by linear bounded ones on class $W_{2}^{r}$.
Theorem 3. Let $r \in \mathbb{N}$ and $k \in \mathbb{Z}_{+}, k \leqslant r-1$. For $N \geqslant M_{-1}$, let $\lambda=\lambda_{N} \geqslant 0$ be such that $N=\left\|u_{\lambda_{N}}^{(r)}\right\|_{2}$ and consider functional $S_{N,-1}: L_{2} \rightarrow \mathbb{R}$ :

The proof of Lemma 4 Let small_order $r=1$ and $k=0$. Then, for $n \in \mathbb{N}, \lambda_{n}=\frac{\pi^{2} n^{2}}{4}$ and, for $m \in \mathbb{N}, \varphi_{2 m-1}(x)=\cos \left(\pi m-\frac{\pi}{2}\right) x$ and $\varphi_{2 m}(x)=\sin \pi m x, x \in \mathbb{I}$. Clearly,
 which proves 30].

Let $r=2$ and $k \in\{0,1\}$. Assume $\varphi$ satisfies boundary value problem (31) with some $\lambda>0$, and $t_{0} \in(-1,1)$ is the extremum of $\varphi^{(2+k)}$. Clearly, $\varphi^{(3+k)}\left(t_{0}\right)=0$. Then integrating by parts we have

$$
\begin{gathered}
\left(\varphi^{(2+k)}\left(t_{0}\right)\right)^{2}-\left(\varphi^{(2+k)}(-1)\right)^{2}=2 \int_{-1}^{t_{0}} \varphi^{(2+k)}(x) \varphi^{(3+k)}(x) \mathrm{d} x \\
=-2 \int_{-1}^{t_{0}} \varphi^{(1+k)}(x) \varphi^{(4+k)}(x) \mathrm{d} x=-2 \lambda \int_{-1}^{t_{0}} \varphi^{(1+k)}(x) \varphi^{(k)}(x) \mathrm{d} x \\
=-\lambda\left(\left(\varphi^{(k)}\left(t_{0}\right)\right)^{2}-\left(\varphi^{(k)}(-1)\right)^{2}\right)=-\lambda\left(\varphi^{(k)}\left(t_{0}\right)\right)^{2}
\end{gathered}
$$

Hence,

$$
\left(\varphi^{(2+k)}(-1)\right)^{2}=\left(\varphi^{(2+k)}\left(t_{0}\right)\right)^{2}+\lambda\left(\varphi^{(k)}\left(t_{0}\right)\right)^{2} \geqslant\left(\varphi^{(2+k)}\left(t_{0}\right)\right)^{2}
$$

and extremums of $\varphi^{(2+k)}$ inside $\mathbb{I}$ do not exceed in magnitute its values at the end-points of $\mathbb{I}$, which finishes the proof.

The proof of Theorem Thm stechkin Theorems 6 and 8 , we have

$$
\begin{aligned}

& =\sup _{t \in \mathbb{I}}\left\|u_{\lambda_{N, t}, t}\right\|_{2}=\left\|u_{\lambda_{N}}\right\|_{2}
\end{aligned}
$$


The proof of Theorem 10 , Let $t \in(-1,1)$ additive_polynomial the functions $u_{\lambda}$ and $u_{\lambda, t}$ be

 $\left\|u_{0}\right\|_{2}$. Also, due to symmetrical considerations, it is enough to consider the case $t \in(-1,0]$.

First, we consider the case $k=r-1$. Set $p_{-1}:=(-1)^{r} u_{0}$ and $p_{t}:=(-1)^{r} u_{0, t}$. By (17) it is clear that

$$
p_{-1}(\cdot)=1-\frac{1}{\gamma} \int_{-1}^{(\cdot)}\left(1-\tau^{2}\right)^{r-1} \mathrm{~d} \tau, \quad \gamma=\int_{-1}^{1}\left(1-\tau^{2}\right)^{r-1} \mathrm{~d} \tau
$$

By $\frac{\mid \text { Sturm-Liouville_t }}{=} p_{-1}(x)-\chi_{[-1, t)}$, where $\chi_{E}$ is the characteristic (indicator) function of measurable set $E \subset \mathbb{I}$. Since $t \leqslant 0$, for every $x \in[-1, t)$,

$$
p_{-1}(x) \geqslant \frac{1}{2} \geqslant 1-p_{-1}(x)=-p_{t}(x)=\left|p_{t}(x)\right|
$$

and $p_{-1}(x)=p_{t}(x)$, for every $x \in[t, 1]$. Hence, $\left\|p_{-1}\right\|_{2} \leqslant\left\|p_{t}\right\|_{2}$, which finishes the proof in this case.

Consider the case $r \geqslant 2$ and $k=r-2$. Denote $p_{-1}(x)=(-1)^{r-1} u_{0}(x)$, $p_{1}(x)=p_{-1}(-x)$ and $p_{t}(x)=(-1)^{r-1} u_{0, t}(x), x \in \mathbb{I}$. Recall that from the definition of functions $u_{0}$ and $u_{0, t}$, it follows that $p_{-1} \in \mathcal{P}_{2 r-1}, p_{t} \in \mathcal{P}_{2 r-1}(-1, t) \cap$ $\mathcal{P}_{2 r-1}(t, 1)$ and

$$
p_{-1}^{(s)}(-1)=\delta_{1, s}, \quad p_{-1}^{(s)}(1)=0, \quad s=0,1, \ldots, r-1
$$

and

$$
\begin{cases}p_{t}^{(s)}(-1)=p_{t}^{(s)}(1)=0, & s=0,1, \ldots, r-1 \\ p_{t}^{(s)}\left(t^{+}\right)-p_{t}^{(s)}\left(t^{-1}\right)=\delta_{1, s}, & s=0,1, \ldots, 2 r-1\end{cases}
$$

Straightforward calculations show that

$$
p_{t}(x)=\frac{(1-t) \cdot p_{-1}(x)+(1+t) \cdot p_{1}(x)+\delta_{t}(x)}{2}, \quad x \in \mathbb{I}
$$

where

$$
\delta_{t}(x)= \begin{cases}-(1-t)(1+x), & x \in[-1, t] \\ -(1+t)(1-x), & x \in[t, 1]\end{cases}
$$

Clearly, $p_{t} \leqslant \frac{1-t}{2} \cdot p_{-1}+\frac{1+t}{2} \cdot p_{1}$ as $\delta_{t} \leqslant 0$. Let us show that

$$
p_{t}(x) \geqslant-\frac{1-t}{2} \cdot p_{-1}(x)-\frac{1+t}{2} \cdot p_{1}(x), \quad x \in \mathbb{I}
$$

or, equivalently,

$$
\begin{equation*}
4 p_{t}(x) \geqslant \delta_{t}(x), \quad x \in \mathbb{I} . \tag{32}
\end{equation*}
$$

First, we show that $p_{t}(t)<0$. Assume to the contrary that $p_{t}(t) \geqslant 0$. Then there exist points $-1<\xi_{1}<t<\xi_{2}<1$ such that $p_{t}^{\prime}\left(\xi_{1}\right) \geqslant 0$ and $p_{t}^{\prime}\left(\xi_{2}\right) \leqslant 0$. If $p_{t}^{\prime}\left(t^{-}\right)<0$ then there exist three points $-1<\tau_{1}<\xi_{1}<\tau_{2}<t<\xi_{2}<\tau_{2}<1$ such that $p_{t}^{\prime \prime}\left(\tau_{1}\right) \geqslant 0, p_{t}^{\prime \prime}\left(\tau_{2}\right) \leqslant 0$ and $p_{t}^{\prime \prime}\left(\tau_{1}\right) \geqslant 0$. Hence, the continuous extension of $p_{t}^{\prime \prime}$ on the interval $\mathbb{I}$ (also denoted as $p_{t}^{\prime \prime}$ ) has at least 2 zeros inside $\mathbb{I}$, and at least $2(r-2)+2=2 r-2$ zeros (counting multiplicities) on the interval II. However, $p_{t}^{\prime \prime}$ is the algebraic polynomial of degree at most $2 r-3$ and cannot have $2 r-2$ or more zeros. Next, if $p_{t}^{\prime}\left(t^{-}\right) \geqslant 0$ then $p_{t}^{\prime}\left(t^{+}\right)=1+p_{t}^{\prime}\left(t^{-}\right)>0$. Hence, there exist three points $-1<\tau_{1}<\xi_{1}<t<\tau_{2}<\xi_{2}<\tau_{2}<1$ such that $p_{t}^{\prime \prime}\left(\tau_{1}\right) \geqslant 0, p_{t}^{\prime \prime}\left(\tau_{2}\right) \leqslant 0$ and $p_{t}^{\prime \prime}\left(\tau_{1}\right) \geqslant 0$, and following previous arguments we arrive to contradiction.

Next, we observe that $p_{t}(x) \geqslant p_{t}(t) \cdot \frac{1+x}{1+t}, x \in[-1, t]$. Indeed, assume to the contrary that there exists a point $\xi \in(-1, t)$ such that $p_{t}(\xi)=p_{t}(t) \cdot \frac{1+\xi}{1+t}$. Since $p_{t}^{\prime}(-1)=0$, there exist 2 points $-1<\xi_{1}<\xi<\xi_{2}<t$ such that $p_{t}^{\prime \prime}\left(\xi_{1}\right)<0$ and $p_{t}^{\prime \prime}\left(\xi_{2}\right)>0$. Also, since $p_{t}(t)<0$, there exists a point $\xi_{3} \in(t, 1)$ such that $p_{t}^{\prime \prime}\left(\xi_{3}\right)<0$. Hence, $p_{t}^{\prime \prime}$ has at least $2(r-2)+2=2 r-2$ zeros (counting multiplicities), which contradicts to the fact that $p_{t}^{\prime \prime}$ is a polynomial of degree at most $2 r-3$. Using similar arguments we can also prove that $p_{t}(x) \geqslant p_{t}(t) \cdot \frac{1-x}{1-t}$, $x \in[t, 1]$.

Based on the above is sufficient to prove inequality (32) only in the case $x=t$, in which case (32) can be rewritten as

$$
\begin{equation*}
2(1-t) \cdot p_{-1}(t)+2(1+t) \cdot p_{1}(t) \geqslant-\delta_{t}(t)=1-t^{2} \tag{33}
\end{equation*}
$$

Evidently, $p_{-1}(x) \geqslant p_{1}(x)$ on $[-1,0]$ and $p_{-1}(x) \leqslant p_{1}(x)$ on $[0,1]$. Hence, n $_{\text {_inequality_2 }}$ $2(1-t) \cdot p_{-1}(t)+2(1+t) \cdot p_{1}(t) \geqslant 2 p_{-1}(t)+2 p_{1}(t)$. So, to prove inequality (33) it is sufficient to show that

$$
\begin{equation*}
2 p_{-1}(t)+2 p_{1}(t) \geqslant 1-t^{2} . \tag{34}
\end{equation*}
$$

Clearly, the function $f(x)=2 p_{-1}(x)+2 p_{1}(x)$ is even polynomial of degree at most $2 r-2$ such that $f(-1)=f(1)=0, f^{\prime}(-1)=2, f^{\prime}(1)=-2$ and
 turns into equality for $r=2$. For $r \geqslant 3$, the difference $g(x)=f(x)-1+x^{2}$ has the following properties: $g(-1)=g(1)=g^{\prime}(-1)=g^{\prime}(1)=0$ and $g^{\prime \prime}(x)$ is even, has only one zero on $(-1,0)$, and $g^{\prime \prime}(-1)$ adit Hence, inequality follows, which finishes the proof of Theorem 10 .
