# EXISTENCE, STABILITY AND REGULARITY OF PERIODIC SOLUTIONS FOR NONLINEAR FOKKER-PLANCK EQUATIONS 

ERIC LUÇON AND CHRISTOPHE POQUET


#### Abstract

We consider a class of nonlinear Fokker-Planck equations describing the dynamics of an infinite population of units within mean-field interaction. Relying on a slow-fast viewpoint and on the theory of approximately invariant manifolds we obtain the existence of a stable periodic solution for the PDE, consisting of probability measures. Moreover we establish the existence of a smooth isochron map in the neighborhood of this periodic solution.


## 1. Introduction

1.1. The model. We are interested in this paper in the existence, stability and regularity of periodic solutions to the following nonlinear $\operatorname{PDE}$ on $\mathbb{R}^{d}(d \geqslant 1)$ :

\partial_{t} u_{t}=\nabla \cdot\left(\sigma^{2} u_{t}\right)+\nabla \cdot\left(K\left(x-\int_{\mathbb{R}^{d}} y u_{t}(\mathrm{~d} y)\right) u_{t}\right)-\delta \nabla \cdot\left(F(x) u_{t}\right) . \tag{1.1}
\end{equation*}

Here, $t \geqslant 0 \mapsto u_{t}$ is a probability measure-valued process on $\mathbb{R}^{d}, K$ and $\sigma$ and diagonal matrices with positive coefficients and $F: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ is a smooth bounded function with bounded derivatives. Equation (1.1) has a natural probabilistic interpretation: if $u_{0}$ is a probability distribution on $\mathbb{R}^{d}$, it is well known [30, 37] that $u_{t}$ is the law of the McKeanVlasov process $X_{t}$ where $X_{0} \sim u_{0}$ and

The dynamics of the process $\left(X_{t}\right)_{t \geqslant 0}$ is the superposition of a local part $\delta F\left(X_{t}\right) \mathrm{d} t$, where $\delta>0$ is a scaling parameter, a linear interaction term $K\left(X_{t}-\mathbb{E}\left[X_{t}\right]\right) \mathrm{d} t$, modulated by the intensity matrix $K$, and an additive noise given by a standard Brownian motion $\left(B_{t}\right)_{t} \geqslant 0$ on $\mathbb{R}^{d}$. The difficulty in the analysis of (1.2) lies in its nonlinear character: $X_{t}$ interacts with its own law, more precisely its own expectation $\mathbb{E}\left[X_{t}\right]$. The long-time dynamics of (1.2) is a longstanding issue in the literature. In particular, the existence of stable equilibria for (1.1) (that is invariant measures for (1.2)) has been studied for various choices of dynamics, interaction and regimes of parameters $\delta, K, \sigma$, mostly in a context where the corresponding particle dynamics defined in (1.3) below is reversible (see e.g. [39, 7, 11 for further details and references).

The question we address in the present paper concerns the existence of periodic solutions to nonlinear equation such as (1.1). In this case, a major difficulty lies in the fact that the underlying microscopic dynamics is not reversible. From a practical perspective, the emergence of periodicity in such models relates in particular to chemical reactions (Brusselator model [35]), neurosciences [20, 21, 2, 9, 17, [27, 33, 28, 14], and statistical physics (e.g.

[^0]spin-flip models [13, 16], see also to [12], where the model considered is in fact not meanfield, but the Ising model with dissipation). An example of particular interest concerns the FitzHugh-Nagumo model [34, 2] (take $d=2$ and $F(x, y)=\left(x-\frac{x^{3}}{3}-y, \frac{1}{c}(x+a-b y)\right)$ ), commonly used as a prototype for excitability in neuronal models [26] or in physics [3]. Roughly speaking, excitability refers to the ability for a neuron to emit spikes (oscillations) in the presence of perturbations (such as noise and/or external input) whereas this neuron would be at rest (steady state) without perturbation. The long-time dynamics of (1.1) in the FizHugh-Nagumo case has been the subject of several previous works (existence of equilibria [31, 33] or periodic solutions [27, 28]) under various asymptotics of the parameters $(\delta, K, \sigma)$. A crucial feature in this context is the influence of noise and interaction in the emergence and stability of periodic solutions: generically, some balance has to be found in the quantity of noise and interaction that one needs to put in the system in order to observe oscillations (see [26, 27, 28] for further details).

Stability properties and regular isochron map. The purpose of the present paper is to complement the previous results concerning the existence of periodic orbits for (1.1) with accurate stability properties for this periodic solution and with the existence of a sufficiently regular isochron map, properties that are absent in the previous works cited above. We obtain these additional properties by applying a result concerning normally hyperbolic invariant manifolds in Banach spaces proved by Bates, Lu and Zeng 5. The technical counterpart is that we require assumptions on $F$ and $\sigma$ that are somehow stricter than the ones used in [35, 27, 33, 28], in the sense that we are considering a dynamics $F$ that is bounded together with all its derivatives (the Brusselator model and FitzHugh Nagumo model considered in the references given above have polynomial growth) as well as nondegenerate noise on all components (while in [33, 28] the noise is only present in one of the two variables).

Large time asymptotics for the mean-field particle system. Standard propagation of chaos results [37] shows that (1.2) is the natural limit of the following mean-field particle system

\end{equation*}

in the sense that one can easily couple (1.3) and (1.2) by choosing the same realization of the noise, so that the resulting error is of order $\frac{1}{\sqrt{N}}$ as $N \rightarrow \infty$, at least on any $[0, T]$ with $T$ that can be arbitrarily large but fixed independently from $N$. At the level of the whole particle system, this boils down to the convergence as $N \rightarrow \infty$ of the empirical measure $u_{N, t}=\frac{1}{N} \sum_{i=1}^{N} \delta_{X_{i, t}}$ to $u_{t}$, solution to (1.1). Hence, supposing that (1.1) has a periodic solution $\left(\Gamma_{t}^{\delta}\right)_{t \geqslant 0}$, if the empirical measure $u_{N, 0}$ is initially close to $\Gamma_{\theta_{0}}^{\delta}, u_{N, t}$ has, for $N$ large, a behavior close to being periodic, since it stays close to $\Gamma_{\theta_{0}+t}^{\delta}$.

The companion paper [29] of the present work is concerned with the behavior of the empirical measure $u_{N, t}$ on a time scale $T$ that is no longer bounded, but of order $N$. We show in [29] that $u_{N, N t}$ is close to $\Gamma_{\theta_{0}+N t+\beta_{t}^{N}}^{\delta}$, where $\beta_{t}^{N}$ is a random process in $\mathbb{R}$ whose weak limit as $N \rightarrow \infty$ has constant drift and diffusion coefficient. This kind of result was already obtained in [15, 8 ] in the case of the plane rotators model (mean-field noisy interacting oscillators defined on the circle), for which in the scale $N t$ the empirical measure has a diffusive behavior along the curve of stationary points. Our aim in [29] is to get similar results for models like (1.1) that are defined in $\mathbb{R}^{d}$, and are not reversible
(while the plane rotators model is). As we will explain in more details later, the additional stability and regularity results concerning periodic solution to (1.1) obtained in the present paper are crucial for the study of long time behavior of the mean-field particle systems (1.3) made in [29].
1.2. Slow fast viewpoint and application to the FitzHugh-Nagumo model. We give in this paragraph informal intuition on the possibility of emergence of periodic solutions to (1.1). The point of view we adopt here is a slow-fast approach, based on the assumption that the parameter $\delta$ in (1.1) is small, as it was already the case in [27, 28]. More precisely, the linear character of the interaction term in (1.1) allows us to decompose the dynamics of (1.1) into its expectation $m_{t}=\int_{\mathbb{R} d} x u_{t}(x)$ and its centered version $p_{t}(x)=u_{t}\left(x-m_{t}\right)$ : (1.1) is equivalent to the system

\dot{m}_{t} & =\delta \int F_{m_{t}} \mathrm{~d} p_{t}
\end{align*}\right.
$$

where

$$
\begin{equation*}
\mathcal{L} u=\nabla \cdot\left(\sigma^{2} \nabla f\right)+\nabla \cdot(K x f), \tag{1.5}
\end{equation*}

and $F_{m}(x)=F(x+m)$. Remark that $\left(p_{t}, m_{t}\right)$ is the weak limit as $N \rightarrow \infty$ of the process $\left(\frac{1}{N} \sum_{i=1}^{N} \delta_{Y_{i, t}}, m_{N, t}\right)$, where

m_{N, t}=\frac{1}{N} \sum_{i=1}^{N} X_{i, t}, \quad \text { and } \quad Y_{i, t}=X_{i, t}-m_{N, t} . \tag{1.6}

In this set-up, $p_{t}$ is here the fast variable, while $m_{t}$ is the slow one. For $\delta=0$, this system reduces to

so $p_{t}^{0}=e^{t \mathcal{L}} p_{0}$ is the distribution of an Ornstein-Uhlenbeck process, and thus converges exponentially fast to $\rho$, the density of the Gaussian distribution on $\mathbb{R}^{d}$ with mean 0 and variance $\sigma^{2} K^{-1}$ (see Proposition 1.1 for more details on the contraction properties of $\mathcal{L}$ ). So heuristically, taking $\delta$ small, at first approximation $p_{t}$ stays close to $\rho$ while $m_{t}$ satisfies

\dot{m}_{t} \approx \delta \int_{\mathbb{R}^{d}} F_{m_{t}}(x) \rho(x) \mathrm{d} x=\delta \int_{\mathbb{R}^{d}} F(x) \rho\left(m_{t}-x\right) \mathrm{d} x=\delta(F * \rho)\left(m_{t}\right) . \tag{1.8}
\end{equation*}

For the non-centered PDE (1.1) this approximation means that $u_{t}$ is close to a Gaussian distribution with variance variance $\sigma^{2} K^{-1}$ and mean $m_{t}$, where the dynamics of $m_{t}$ is governed at first order by (1.8). Following this heuristic, we expect a periodic behavior for the system (1.4) if the approximate dynamics of $m_{t}$ is itself periodic. In this spirit, the main hypothesis we will adopt below is that the solution $z_{t}$ to

\end{equation*}

admits a stable periodic solution $\left(\alpha_{t}^{\delta}\right)_{t \in\left[0, \frac{T_{\alpha}}{\delta}\right]}$ (more details on this notion of stability, in terms of Floquet exponents, will be given in Section 1.4). In Proposition 1.7 we will show that with these hypotheses, the manifold $\widetilde{\mathcal{M}}^{\delta}=\left(\rho, \alpha_{t}^{\delta}\right)_{t \in\left[0, T_{\alpha} / \delta\right]}$ is approximately invariant for (1.4).

Let us now describe a situation where the above heuristics is true: in [27, 28] we considered the classical FitzHugh-Nagumo model defined by $d=2$ and

A direct calculation shows that in that case, with $K=\operatorname{diag}\left(k_{1}, k_{2}\right)$ and $\sigma=\operatorname{diag}\left(\sigma_{1}, \sigma_{2}\right)$,

\int_{\mathbb{R}^{d}} F_{z_{1}, z_{2}}(x, y) \rho(x, y) \mathrm{d} x \mathrm{~d} y=\left(\left(1-\frac{\sigma_{1}^{2}}{k_{1}}\right) z_{1}-\frac{z_{1}^{3}}{3}-z_{2}, \frac{1}{c}\left(z_{1}+a-b z_{2}\right)\right), \tag{1.11}
\end{equation*}

which defines again a FitzHugh-Nagumo model. The additional factor $\frac{\sigma_{1}^{2}}{k_{1}}$ in (1.11) reflects the influence of noise and interaction in the mean-field system (1.2). For an accurate choice of parameters (take e.g. $a=\frac{1}{3}, b=1$ and $c=10$ ), it can be shown that the dynamics of the mean value (1.9) has a unique steady state when $\frac{\sigma_{1}^{2}}{k_{1}}=0$ whereas it admits a stable periodic solution for $\frac{\sigma_{1}^{2}}{k_{1}}$ not too small and not too large, for example $\frac{\sigma_{1}^{2}}{k_{1}}=0.2$. We refer to [27], § 3.4 for a more details of the corresponding bifurcations). The purpose of [27, 28] was to show that the heuristics developed above is true, i.e. the periodicity of (1.9) propagates to (1.4). This emergence of periodic behavior induced by noise and interaction is a signature of excitability: the system (1.1) exhibits a periodic behavior induced by the combined effect of the noise and the interaction, which is not present in the isolated system $\dot{z}_{t}=F\left(z_{t}\right)$. We refer to [27] for a discussion and references on this phenomenon.

As already said, the point of the present work is to go beyond the existence of oscillations for (1.1), that is to prove regularity for the dynamics around such a limit cycle. Unfortunately the FitzHugh Nagumo model does not satisfy the hypotheses of this present work, since it has polynomial growth at infinity. However it is easy to see that if $\psi: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$ is a smooth non-increasing function that satisfies $\psi(t)=1$ for $t \leqslant 1$ and $\psi(t)=0$ for $t \geqslant 2$, then for any $\varepsilon>0$ the function $x \mapsto F(x) \psi(\varepsilon|x|)$ satisfies our hypotheses, and that $z \mapsto \int_{\mathbb{R}^{d}} F_{z}(x) \psi(\varepsilon|x+z|) \rho(x) d x$ converges to $z \mapsto \int_{\mathbb{R}^{d}} F_{z}(x) \rho(x) d x$ in $C^{1}\left(\mathcal{B}(0, R), \mathbb{R}^{d}\right)$ for any ball $\mathcal{B}(0, R)$ centered at 0 with radius $R$. So, relying on classical results on normally hyperbolic manifolds [18, [19, 40] (a definition of this notion will be provided in Section (1.4), if (1.9) admits a stable limit cycle, then it will also be the case replacing $F$ with $x \mapsto F(x) \psi(\varepsilon|x|)$ for $\varepsilon$ small enough.
1.3. Weighted Sobolev norms. We present in this section the Sobolev spaces that we will use in the paper. Let us denote by $|x|_{A}=(x \cdot A x)^{1 / 2}$ the Euclidean norm twisted by some positive matrix $A$, and, for any $\theta \in \mathbb{R}$, let us define the weight $w_{\theta}$ by

We denote as $L_{\theta}^{2}$ the $L^{2}$-space with weight $w_{\theta}$, that is with norm

For any $\theta>0$ we consider the Ornstein-Uhlenbeck operator

It is well know（see for example［1］）that $\mathcal{L}_{\theta}^{*}$ admits the following decomposition：for all $l \in \mathbb{N}^{d}$ ，

where $h_{n}$ is the $n^{\text {th }}$ renormalized Hermite polynomial：

The family $\left(\psi_{l, \theta}\right)_{l \in \mathbb{N}^{d}}$ is an orthonormal basis of $L_{\theta}^{2}$ ．For $f, g$ with decompositions $f=$ $\sum_{l \in \mathbb{N}^{d}} f_{l} \psi_{l}$ and $g=\sum_{l \in \mathbb{N}^{d}} g_{l} \psi_{l}$ ，we consider the scalar products

where $a_{\theta}=\theta \operatorname{Tr} K$ and denote by $H_{\theta}^{r}$ the completion of the space of smooth function $u$ satisfying $\|u\|_{H_{\theta}^{r}}<\infty$ ．The choice of the constant $a_{\theta}$ is made to simplify some technical proofs given in the Appendix $⿴ 囗 十$（see the proof of Proposition A．2）．Another choice of positive constant would produce an equivalent norm．From Lemma A． 1 it is clear that $\left\|\partial_{x_{i}} f\right\|_{H_{\theta}^{r}} \leqslant\|f\|_{H_{\theta}^{r+1}}$ ，and that，if $n \in \mathbb{N}$ ，the norm $\|f\|_{H_{\theta}^{n}}$ is in fact equivalent to

We denote by $H_{\theta}^{-r}$ the dual of $H_{\theta}^{r}$ ．Relying on a＂pivot＂space structure（for more details，see Appendix（A），the product $\langle u, f\rangle_{H_{\theta}^{-r}, H_{\theta}^{r}}$ can be identified with the flat $L^{2}$ product $\langle u, f\rangle: L_{-\theta}^{2}$ can be seen as a subset of $H_{\theta}^{-r}$ ，and for all $f \in H_{\theta}^{r}$ and $u \in L_{-\theta}^{2}$ we have

This identification allows us to view the operator $\mathcal{L}_{\theta}$ defined by

$$
\begin{equation*}
\mathcal{L}_{\theta} u=\nabla \cdot\left(\sigma^{2} \nabla f\right)+\nabla \cdot(\theta K x f), \tag{1.20}
\end{equation*}
$$

seen as an operator in $H_{\theta}^{-r}$ ，as the adjoint of $\mathcal{L}_{\theta}^{*}$ ，seen as an operator in $H_{\theta}^{r}$ ．This is in particular the case for $\mathcal{L}=\mathcal{L}_{1}$ ，whose contraction properties will be crucial in the results given in this paper．

Our aim in this paper is to give the existence of a periodic solution for（1．4）viewing $p_{t}$ as an element of $H_{\theta}^{-r}$ ．The necessity of considering $H_{\theta}^{-r}$ instead of simply taking $H_{1}^{-r}$ goes back to the companion paper［29］，in which we study the long time behavior of the empirical measure $u_{N, t}$ in the same functional spaces．Since this empirical measure involves a sum of Dirac distributions，it can be seen as an element of $H_{\theta}^{-r}$ for $r>d / 2$ ，and we have $\left\|\delta_{x}\right\|_{H_{\theta}^{-r}} \leqslant C w_{\frac{\theta}{4-\eta}}(x)$ for $\eta>0$（see Lemma 2.1 in［29］）．Some moment estimates lead us in［29］to bound terms of the form $\mathbb{E}\left[w_{\frac{m \theta}{4-\eta}}\left(Y_{i, t}\right)\right]$ with $m$ large and $Y_{i, t}$ defined in （1．6）．Since we consider cases where $Y_{i, t}$ has a distribution close to $\rho$ ，for this expectation to be bounded we need to consider small values of $\theta$ ．We need therefore to work in $H_{\theta}^{-r}$ for general $\theta$ and not only for $\theta=1$ ．

It is well known that the semi-group $e^{t \mathcal{L}}$ satisfies, for $\lambda<\min \left(k_{1}, \ldots, k_{d}\right)$ and $u \in H_{1}^{-r}$ with $\int u=0$, the contraction property

By obtaining similar estimates (see the following Proposition, which is a particular case of the slightly more general Proposition A.3), we will be able to work in the space $H_{\theta}^{-r}$ with any value of $\theta$ smaller than 1 , but with the constraint of considering values of $r$ larger than a $r_{0}>0($ independent from $\theta)$.

Proposition 1.1. For all $0<\theta \leqslant 1$ the operator $\mathcal{L}$ is sectorial and generates an analytical semi-group in $H_{\theta}^{-r}$. Moreover we have the following estimates: for any $\alpha \geqslant 0, r \geqslant 0$ and $\lambda<\min \left(k_{1}, \ldots, k_{d}\right)$ there exists a constant $C_{\mathcal{L}}>0$ such that for all $u \in H_{\theta}^{-(r+\alpha)}$,

and for $r \geqslant 1$,

Moreover for all $r \geqslant 0,0<\varepsilon \leqslant 1$ and $s \geqslant 0$,

\left\|\left(e^{(t+s) \mathcal{L}}-e^{t \mathcal{L}}\right) u\right\|_{H_{\theta}^{-r}} \leqslant C_{\mathcal{L}} s^{\varepsilon} t^{-\frac{1}{2}-\varepsilon} e^{-\lambda t}\|u\|_{H_{\theta}^{-(r+1)}} \tag{1.24}

Finally, there exist $r_{0}>0$ such that for any $0<\theta \leqslant 1$, for all $r>r_{0}, t>0$ and all $u \in H_{\theta}^{-r}$ satisfying $\int u=0$,

We place ourselves on the space $\mathbf{H}_{\theta}^{r}:=H_{\theta}^{r} \times \mathbb{R}^{d}$ endowed with the scalar product

We will denote $\mathbf{H}_{\theta}^{-r}$ the dual of $\mathbf{H}_{\theta}^{r}$. Clearly $\mathbf{H}_{\theta}^{-r}=H_{\theta}^{-r} \times \mathbb{R}$ and, relying as above on a "pivot" space structure, the product $\langle(\nu, h),(\phi, \psi)\rangle_{\mathbf{H}_{\theta}{ }^{-r}, \mathbf{H}_{\theta}^{r}}$ can be identified with the flat scalar product

The following theorem states the existence and uniqueness of mild solutions of (1.26). Its proof, given in Section 2, relies on classical arguments, due to the fact that $G: \mathbf{H}_{\theta}^{-r+1} \rightarrow$ $\mathbf{H}_{\theta}^{-r}$ is locally Lispchitz and $\mathcal{L}$ is sectorial (see [36]).

Theorem 1.2. For any initial condition $\mu=(p, m) \in \mathbf{H}_{\theta}^{-r}$ with $\int_{\mathbb{R}^{d}} p=1$ there exists a unique maximal mild solution $\mu_{t}:=\left(p_{t}, m_{t}\right)=T^{t}(\mu)$ to (1.26) on $\left[0, t_{c}\right]$ for some $t_{c}>0$, which satisfies $t \mapsto T^{t}(\mu) \in \mathcal{C}\left(\left[0, t_{c}\right) ; \mathbf{H}_{\theta}^{-r}\right)$.

Moreover, $\mu \mapsto T^{t}(\mu)$ is $C^{2}$, and for any $R>0$, there exists a $\delta(R)>0$ such that for all $0 \leqslant \delta \leqslant \delta(R)$ and $\mu_{0}=\left(p_{0}, m_{0}\right)$ satisfying $\left\|p_{0}-\rho\right\|_{H_{\theta}^{-r}} \leqslant R$ the solution $T^{t}\left(\mu_{0}\right)$ is well defined for all $t \geqslant 0$ and there exists a $C(R)>0$ such that

Remark 1.3. Since we are interested in the existence of a periodic solution made of probability distributions, we will only consider initial condition $\left(p_{0}, m_{0}\right)$ satisfying $\int p_{0}=1$, and the conservation of mass will induce that $\int_{\mathbb{R}^{d}} p_{t}=1$ for all $t$. In the same spirit, we will only apply the differential of the semi-group $D T^{t}(\mu)$ to elements $\nu=(\eta, n) \in \mathbf{H}_{\theta}^{-r}$ that satisfy $\int_{\mathbb{R}^{d}} \eta=0$.

As it was previously mentioned, we suppose in the following that the ordinary differential equation (1.9) admits a stable periodic solution $\left(\alpha_{t}^{\delta}\right)_{t \in\left[0, \frac{T_{\alpha}}{\delta}\right]}$. To state more precisely this hypothesis we rely on Floquet formalism (see for example [38]): let us denote by $\pi_{u+t, u}^{\delta}$ the principal matrix solution associated to the periodic solution $\alpha$, that it the solution to

The process $\pi_{u+t, u}^{\delta}$ characterizes the linearized dynamics around $\left(\alpha_{t}^{\delta}\right)_{t \in\left[0, \frac{T}{\delta}\right]}$. We will suppose that this linearized dynamics is a contraction on a supplementary space of the tangent space to $\left(\alpha_{t}^{\delta}\right)_{t \in\left[0, \frac{T}{\delta}\right]}$. More precisely, we suppose that there exist projections $P_{u}^{\delta, c}$ and $P_{u}^{\delta, s}$ for all $u \in\left[0, \frac{T}{\delta}\right]$ with $u \mapsto P_{u}^{\delta, c}$ and $u \mapsto P_{u}^{\delta, s}$ smooth, that satisfy $P_{u}^{\delta, s}+P_{u}^{\delta, c}=I\left(P_{u}^{\delta, c}\right.$ being a projection on $\operatorname{vect}\left(\dot{\alpha}_{u}^{\delta}\right)$ ) and that commute with $\pi^{\delta}$, i.e.

We emphasize here the fact that the factor $\delta$ in (1.9) is only responsible for a time-scale of the dynamics (the smaller $\delta$, the slower the dynamics, the period being then $T_{\alpha} / \delta$ ): we have $\alpha_{t}^{\delta}=\alpha_{\delta t}^{1}$. Its effect on the projections is only a change of parametrization: $P_{u}^{\delta, s}$ and $P_{u}^{\delta, c}$ are defined on $[0, T / \delta)$, and $P_{u / \delta}^{\delta, s}=P_{u}^{1, s}, P_{u / \delta}^{\delta, c}=P_{u}^{1, c}$ for $u \in\left[0, T_{\alpha}\right)$.

The stability of the periodic solution $\left(\alpha_{t}^{\delta}\right)_{t \in\left[0, \frac{T_{\alpha}}{\delta}\right]}$ is expressed by the following hypothesis: there exist positive constants $c_{\alpha}, C_{\alpha}$ and $\lambda_{\alpha}$ such that

The factor $\delta$ in the rate of contraction is again due to the fact that the factor $\delta$ in (1.9) slows the dynamics.

With these hypotheses $\left(\alpha_{t}^{\delta}\right)_{t \in\left[0, \frac{T}{\delta}\right]}$ is in fact a simple example of Normally Hyperbolic Invariant Manifold (NHIM). We follow here the definition given in 4 for this concept: on a Banach space $\mathbf{X}$, a smooth compact connected manifold $\mathbf{M}$ is said to be a normally hyperbolic invariant manifold for a continuous semi flow $\mathbf{T}$ (such that $u \mapsto \mathbf{T}^{t}(\mu)$ is $C^{1}$ for all $t \geqslant 0$ ) if
(1) $\mathbf{T}(\mathbf{M}) \subset \mathbf{M}$ for all $t \geqslant 0$,
(2) For each $m \in \mathbf{M}$ there exists a decomposition $\mathbf{X}=\mathbf{X}_{m}^{c}+\mathbf{X}_{m}^{u}+\mathbf{X}_{m}^{s}$ of closed subspaces with $\mathbf{X}_{m}^{c}$ the tangent space to $\mathbf{M}$ at $m$,
(3) For each $m \in \mathbf{M}$ and $t \geqslant 0$, denoting $m_{1}=\mathbf{T}^{t}(m)$, we have $D \mathbf{T}^{t}(m)_{\mid \mathbf{X}_{m}^{\iota}}: \mathbf{X}_{m}^{\iota} \rightarrow$ $\mathbf{X}_{m_{1}}^{\iota}$ for $\iota=c, u, s$, and $D \mathbf{T}^{t}(m)_{\mid \mathbf{X}_{m}^{u}}$ is an isomorphism from $\mathbf{X}_{m}^{u}$ to $\mathbf{X}_{m_{1}}^{u}$.
(4) There exists a $t_{0} \geqslant 0$ and a $\lambda>0$ such that, for all $t \geqslant t_{0}$,

\end{align*}

(1.34) implies that the semi flow $\mathbf{T}^{t}$ is expansive at $m$ in the direction $\mathbf{X}_{m}^{u}$ at a rate strictly larger than on $\mathbf{M}$, while (1.35) shows implies that it is contractive at $m$ in the direction $\mathbf{X}_{m}^{s}$ at a rate greater than on $\mathbf{M}$.

This kind of structure is known to be robust under perturbation of the semi-flow: it has been shown in [18, 19] for flows in $\mathbb{R}^{d}$, and then generalized in [24] in the case of Riemanian manifolds and in [4, 36] in the infinite dimensional setting. An improvement of these classical results has been obtained in [5] by Bates, Lu and Zeng, who showed that if a system admits a manifold that is approximately invariant and approximately normally hyperbolic (a precise definition of these notions will be given in Section 1.5), then the system possesses an actual normally hyperbolic invariant manifold in a neighborhood.

We will rely on this deep result in our work. Here, the slow fast viewpoint described in Section 1.2 suggests that for $\delta$ small the manifold $\widetilde{\mathcal{M}}^{\delta}=\left\{\left(\rho, \alpha_{t}\right): t \in\left[0, T_{\alpha}\right)\right\}$ is an approximately invariant manifold which is approximately normally hyperbolic (without unstable direction). This statement will be written rigorously in Section 1.5, and proved in Section 3. This idea will allow us to prove for $\delta$ small enough the existence of a stable periodic solution to (1.4), as an actual normally hyperbolic invariant manifold in a neighborhood of $\widetilde{\mathcal{M}}^{\delta}$. For a stable periodic solution, conditions (1.34) and (1.35) reduce to the fact that $D T^{t}(m)$ is bounded from above and below in the direction of the tangent space to the invariant manifold defined by the periodic solution, and is contractive on a stable direction.

Theorem 1.4. There exists $\delta_{0}>0$ such that for $r_{0}$ given in Proposition 1.1 and for all $r \geqslant r_{0}, \delta \in\left(0, \delta_{0}\right)$ and $\theta \in(0,1]$ the system (1.4) admits a periodic solution $\left(\Gamma_{t}^{\delta}\right)_{t \in\left[0, T_{\delta}\right]}:=$ $\left(q_{t}^{\delta}, \gamma_{t}^{\delta}\right)_{t \in\left[0, T_{\delta}\right]}$ in $\mathbf{H}_{\theta}^{-r}$ with period $T_{\delta}>0$. Moreover $q_{t}^{\delta}$ is a probability distribution for all $t \geqslant 0$, and $t \mapsto \partial_{t} \Gamma_{t}^{\delta}$ and $t \mapsto \partial_{t}^{2} \Gamma_{t}^{\delta}$ are in $C\left(\left[0, T_{\delta}\right), \mathbf{H}_{\theta}^{-r}\right)$.

Denoting $\mathcal{M}^{\delta}=\left\{\Gamma_{t}^{\delta}: t \in\left[0, T_{\delta}\right)\right\}$ and $\Phi_{u+s, u}(\nu)=D T^{s}\left(\Gamma_{u}^{\delta}\right)[\nu]$, there exists families of projection $\Pi_{u}^{\delta, c}$ and $\Pi_{t}^{\delta, s}$ that commute with $\Phi$, i.e. that satisfy

Moreover $\Pi_{t}^{\delta, c}$ is a projection on the tangent space to $\mathcal{M}^{\delta}$ at $\Gamma_{t}^{\delta}, \Pi_{t}^{\delta, c}+\Pi_{t}^{\delta, s}=I_{d}, t \mapsto$ $\Pi_{t}^{\delta, c} \in C^{1}\left(\left[0, T_{\delta}\right), \mathcal{B}\left(\mathbf{H}_{\theta}^{-r}\right)\right)$, and there exist positive constants $c_{\Phi, \delta}, C_{\Phi, \delta}$ and $\lambda_{\delta}$ such that

c_{\Phi, \delta}\left\|\Pi_{u}^{\delta, c}(\nu)\right\|_{\mathbf{H}_{\theta}^{-r}} \leqslant\left\|\Phi_{u+t, u} \Pi_{u}^{\delta, c}(\nu)\right\|_{\mathbf{H}_{\theta}^{-r}} \leqslant C_{\Phi, \delta}\left\|\Pi_{u}^{\delta, c}(\nu)\right\|_{\mathbf{H}_{\theta}^{-r}}  \tag{1.37}\\
\left\|\Phi_{u+t, u} \Pi_{u}^{\delta, s}(\nu)\right\|_{\mathbf{H}_{\theta}^{-r}} \leqslant C_{\Phi, \delta} t^{-\frac{\alpha}{2}} e^{-\lambda_{\delta} t}\left\|\Pi_{u}^{\delta, s}(\nu)\right\|_{\mathbf{H}_{\theta}^{-(r+\alpha)}} \tag{1.38}
\end{gather*}

and

Remark 1.5. The invariant manifold $\mathcal{M}^{\delta}$ is located at a distance of order $\delta$ from $\widetilde{\mathcal{M}}^{\delta}$ and the period $T_{\delta}$ is close to $T_{\alpha} / \delta$ (the period of the slow system (1.9) ). Moreover $\lambda_{\Phi, \delta}$ is of order $\delta$ due to the fact that $z_{t}$ contracts around $\alpha_{t}$ with rate $\delta \lambda_{\alpha}$.

In [5] it is in addition proven that the stable manifold of the actual NHIM (in our case $\mathcal{M}^{\delta}$ is attractive, the stable manifold is in fact a neighborhood $\mathcal{W}^{\delta}$ of $\mathcal{M}^{\delta}$ ) is foliated by invariant foliations: $\mathcal{W}^{\delta}=\cup_{m \in \mathcal{M}^{\delta}} \mathcal{W}_{m}^{\delta}$, where $\nu \in \mathcal{W}_{m}^{\delta}$ if and only if $T^{t}(\nu)-T^{t}(m)$ converges to 0 exponentially fast. This implies the existence of an isochron map $\Theta^{\delta}$ : $\mathcal{W}^{\delta} \rightarrow \mathbb{R} / T_{\delta} \mathbb{Z}$ that satisfies $\Theta^{\delta}(\nu)=t$ if $\nu \in \mathcal{W}_{\Gamma_{t}^{\delta}}^{\delta}$. The deep general result of [5] ensures that $\Theta^{\delta}$ is Hölder continuous, which is not entirely satisfying in view of the companion paper [29], in which we aim to apply Itô's Lemma to $\Theta^{\delta}\left(u_{N, t}\right)$. However, the fact that in the present case we simply deal with a stable periodic solution allow us to prove that $\Theta^{\delta}$ has in our particular case $C^{2}$ regularity, as stated in the following theorem.
Theorem 1.6. For $r$ and $\delta$ as in Theorem 1.4, there exists neighborhood $\mathcal{W}^{\delta} \in \mathbf{H}_{\theta}^{-r}$ of $\mathcal{M}^{\delta}$ and a $C^{2}$ mapping $\Theta^{\delta}: \mathcal{W}^{\delta} \rightarrow \mathbb{R} / T_{\delta} \mathbb{Z}$ that satisfies, for all $\mu \in \mathcal{W}^{\delta}$, denoting $\mu_{t}=T^{t} \mu$,

and there exists a positive constant $C_{\Theta, \delta}$ such that, for all $\mu \in \mathcal{W}^{\delta}$ with $\mu_{t}=T^{t} \mu$,

Moreover $\Theta^{\delta}$ satisfies, for all $\mu \in \mathcal{W}^{\delta}$,

1.5. An approximately invariant manifold that is approximately normally hyperbolic. In view of the slow fast formalism described in Section 1.2, our aim is to view $\widetilde{\mathcal{M}}^{\delta}=\left\{\left(\rho, \alpha_{t}\right): t \in\left[0, \frac{T}{\delta}\right)\right\}$ as an approximately invariant and approximately normally hyperbolic manifold, in the sense of [5].

In fact the result of [5] is stated for dynamical systems taking values in a Banach space, while we will consider here solutions $\left(p_{t}, m_{t}\right)$ to (1.4) elements of $\mathbf{H}_{\theta}^{-r}$ that satisfy $\int_{\mathbb{R}^{d}} p_{t}=1$ (since we are interested in probability distributions, recall Remark 1.3), so we will rather consider an affine space. It will not pose any problem, since then ( $p_{t}-\rho, m_{t}$ ) is an element of $\left\{(v, m) \in \mathbf{H}_{\theta}^{-r}: \int_{\mathbb{R}^{d}} v=0\right\}$ which is a Banach space.

Following the notations of [5] we set

With this notation we have $\widetilde{\mathcal{M}}^{\delta}=\psi(\mathbb{R} / T \delta \mathbb{Z})$. We will consider the projections $\widetilde{\Pi}_{u}^{\delta, s}$ and $\widetilde{\Pi}_{u}^{\delta, c}$ defined for $(p, m) \in \mathbf{H}_{\theta}^{-r}$ by

where $P_{t}^{\delta, s}$ and $P_{t}^{\delta, c}$ are the projections defined in Section 1.4. The subspaces $\widetilde{\mathbf{X}}_{u}^{\delta, c}=$ $\widetilde{\Pi}_{u}^{\delta, c}\left(\mathbf{H}_{\theta}^{-r}\right)$ and $\widetilde{\mathbf{X}}_{u}^{\delta, s}=\widetilde{\Pi}_{u}^{\delta, s}\left(\mathbf{H}_{\theta}^{-r}\right)$ will correspond to the approximately tangent space and stable space of $\widetilde{\mathcal{M}}^{\delta}$. It is clear that for each $t \in\left[0, \frac{T}{\delta}\right)$ we have

Proposition 1.7. There exists $\delta_{0}>0$ such that for $r_{0}$ given in Proposition 1.1 and for all $r \geqslant r_{0}, \delta \in\left(0, \delta_{0}\right)$ and $\theta \in(0,1)$, the following assertions are true.
(1) (Definition 2.1. in [5]) There exists a positive constant $\kappa_{1}$ such that for all $u \in$ $\mathbb{R} / \frac{T}{\delta} \mathbb{Z}$,

The first five items of Proposition 1.7 focus on properties of the semi-group $\left(T^{\frac{\tau}{\delta}}\right)_{n \geqslant 0}$ discretized in time, showing that $\widetilde{\mathcal{M}}^{\delta}$ is an approximately invariant manifold approximately normally hyperbolic for this semi-group, while the last item is an uniform in time bound that implies that this property is also true for the semi-group $\left(T^{t}\right)_{t \geqslant 0}$. More precisely (1)
shows that $\widetilde{\mathcal{M}}^{\delta}$ is approximately invariant for the discrete semi- group, (2) shows that $\widetilde{\mathbf{X}}_{u}^{\delta, c}$ is an approximation of the tangent space to $\widetilde{\mathcal{M}}^{\delta}$ at $\left(\rho, \alpha_{u}\right)$ and that $\psi$ does not twist too much, (3) implies that $\widetilde{\mathbf{X}}^{\delta, c}$ and $\widetilde{\mathbf{X}}^{\delta, s}$ are approximately invariant under $\left(D T^{n \frac{\tau}{\delta}}\right)_{n \geqslant 0}$, and (4) implies that $\left(D T^{n \frac{\tau}{\delta}}\right)_{n \geqslant 0}$ contracts more in the direction $\widetilde{\mathbf{X}}^{\delta, s}$ than in the direction $\widetilde{\mathbf{X}}^{\delta, c}$, while it does not contract too much in the direction $\widetilde{\mathbf{X}}^{\delta, c}$. (5) is a technical assumption useful in their proof.

Remark that we do not quote here the hypothesis (H1) of [5] in this Proposition, since it is simply (1.45). Moreover in (5] the authors treat first the inflowing invariant case, and then the overflowing invariant case, while we are here interested in an actual invariant manifold (both inflowing and overflowing), which is why we mix hypotheses (Hi) and (C3), as it is done in Theorem 6.5 of [5].
1.6. Structure of the paper. The proof of Theorem 1.2 concerning the well-posedness of (1.4) is carried out in Section 2. Proposition [1.7] is proven in Section 3. The main result of existence of periodic solutions (Theorem (1.4) is proven in Section (4. The question of regularity of the isochron is addressed in Section 5. The Appendix A gathers technical estimates on the Ornstein-Uhlenbeck operator and some Grönwall type lemmas are listed in Appendix B.

## 2. Proof of Theorem 1.2

We give in this section the existence, uniqueness and regularity result of Theorem 1.2., We rely here on classical arguments one can find for example in [36] or [23].

Proof of Theorem 1.2. We first remark that $G: \mathbf{H}_{\theta}^{-r} \rightarrow \mathbf{H}_{\theta}^{-(r+1)}$ is locally Lispchitz. Indeed, for any $(p, m) \in \mathbf{H}_{\theta}^{-r}$ and any $(\varphi, \psi) \in \mathbf{H}_{\theta}^{r+1}$,

Now, since the operator $\mathcal{L}$ is sectorial in $H_{\theta}^{-r}$, it also the case of the operator $\widetilde{\mathcal{L}}$ in $\mathbf{H}_{\theta}^{-r}$ defined by $\widetilde{\mathcal{L}}(p, m)=\mathcal{L} p$, and thus, applying [36, Theorem 47.8], for all initial condition $\mu=(p, m) \in \mathbf{H}_{\theta}^{-r}$ there exists a unique maximal mild solution $\mu_{t}:=\left(p_{t}, m_{t}\right)=T^{t}(\mu)$ to (1.26) defined on some time interval $\left[0, t_{c}\right)$ and which satisfies $t \mapsto T^{t}(\mu) \in \mathcal{C}\left(\left[0, t_{c}\right) ; \mathbf{H}_{\theta}^{-r}\right)$.

In this section we give the proof of Proposition 1.7 which shows that $\widetilde{\mathcal{M}}^{\delta}$ is an approximately invariant approximately normally hyperbolic manifold. We do not prove the assertions in the order they are given in Proposition 1.7.

& \leqslant C_{22} \delta \int_{t}^{t^{\prime}} \frac{e^{-\lambda\left(t^{\prime}-s\right)}}{\sqrt{t^{\prime}-s}}\left\|p_{s}\right\|_{H_{\theta}^{-r}}\left(1+\left\|p_{s}\right\|_{H_{\theta}^{-r}}\right) \mathrm{d} s \\
& \leqslant C_{23} \delta \zeta^{\frac{1}{2}} \tag{3.41}
\end{align*}
$$

Gathering (3.39), (3.40), (3.41) into (3.38) yields

if $\zeta \leqslant 1$ is chosen sufficiently small. We now turn turn to the control of the mean: since $\dot{m}_{t}=\delta \int F_{m_{t}} d p_{t}$ we have that for $t \leqslant t^{\prime} \leqslant t+\zeta$,

Since we have the uniform bound $\sup _{s} \geqslant 0\left\|p_{s}\right\|_{H_{\theta}^{-r}} \leqslant C(1)$ and since $F$ and its derivatives are bounded, the above quantity is easily bounded by some $C \delta\left(t^{\prime}-t\right)$ which can be made smaller than $\xi / 2$, provided $\zeta$ is taken small enough.

## 4. Proof of Theorem 1.4

Proof of Theorem 1.4. From Proposition 1.7 we know that the hypotheses needed in [5] are satisfied for $\delta$ small enough, which means that the system (1.4) admits a stable normally hyperbolic manifold $\mathcal{M}^{\delta}$ that is at distance $\delta$ from $\widetilde{\mathcal{M}}^{\delta}$. Indeed in [5] some constants $\eta, \chi, \sigma$ need to be small for their result to be true, but in our case these constants are of order $\delta$, so we only need to suppose $\delta$ small enough. Moreover $\mathcal{M}^{\delta}$ is contructed at a distance $\delta_{0}$ from $\widetilde{\mathcal{M}}^{\delta}$, with (see [5], Theorem 4.2) $\delta_{0}$ chosen such that $\eta / \varepsilon$ and $\varepsilon / \delta_{0}$ are bounded for some $\varepsilon>0$. Since $\eta$ is in our case of order $\delta$, we can take $\delta_{0}$ of order $\delta$, and $\mathcal{M}^{\delta}$ is indeed at distance $\delta$ from $\widetilde{\mathcal{M}}^{\delta}$.

The invariant manifold $\mathcal{M}^{\delta}$ is one dimensional, since $\widetilde{\mathcal{M}}^{\delta}$ is, so to prove that it corresponds to a periodic solution it is sufficient to prove that it does not possess any invariant point. But for any $\left(p_{0}, m_{0}\right) \in \mathcal{M}^{\delta}$ we have, since $\|p-\rho\|_{H_{\theta}^{-r}}$ and $\left|m_{0}-\alpha_{u}^{\delta}\right|$ are of order $\delta$ for some $u \in\left[0, \frac{T_{\alpha}}{\delta}\right]$,

Since there exists $c>0$ such that $\left|\dot{\alpha}_{u}^{\delta} / \delta\right|>c$ independently from $u$, we have $\dot{m}_{0} \neq 0$ for the solutions starting from any point of $\mathcal{M}^{\delta}$, which means that $\mathcal{M}^{\delta}$ does not possess any fixed-point, and is thus defined by a periodic solution of positive period $T_{\delta}$, that we denote $\Gamma_{t}^{\delta}=\left(q_{t}^{\delta}, \gamma_{t}^{\delta}\right)$ for $t \in\left[0, T_{\delta}\right]$.

Now, by the Herculean Theorem (see [36], Theorem 47.6), since $\mathcal{M}^{\delta}$ is invariant, $\Gamma_{t}^{\delta}$ is in fact an element of $\mathbf{H}_{\theta}^{-r+2}$ and, by [36] Theorem 48.5, $\partial_{t} \Gamma_{s+t}^{\delta}=\left(\partial_{t} q_{s+t}^{\delta}, \dot{\gamma}_{s+t}^{\delta}\right)$ is in $C\left(\left[0, T_{\delta}\right), \mathbf{H}_{\theta}^{-r}\right)$ and is is solution to

\end{align*}\right.
$$

which means in particular that $\partial_{t} \Gamma_{s+t}^{\delta}=\Phi_{s+t, s} \partial_{t} \Gamma_{s}^{\delta}$. Now $\partial_{t} \Gamma_{s+t}^{\delta}$ is a periodic solution to (4.2), and the same arguments induce that $\partial_{t}^{2} \Gamma_{s+t}^{\delta}$ is in $C\left(\left[0, T_{\delta}\right), \mathbf{H}_{\theta}^{-r}\right)$.

In addition, it is proved in [5] that $\mathcal{M}^{\delta}$ is foliated by $C^{1}$ invariant foliations: a neighborhood $\mathcal{W}^{\delta}$ of $\mathcal{M}^{\delta}$ satisfies the decomposition $\mathcal{W}^{\delta}=\cup_{s \in\left[0, T_{\delta}\right)} \mathcal{W}_{s}^{\delta}$, where $\mathcal{W}_{s}^{\delta}$ corresponds to the elements of $\mu \in \mathbf{H}_{\theta}^{-r}$ such that $T^{n T_{\delta}}(\mu)$ converges exponentially fast to $\Gamma_{s}^{\delta}$ as $n$ goes to infinity. The projections $\Pi_{s}^{\delta, c}$ and $\Pi_{s}^{\delta, s}$ correspond then respectively to the projections on the tangent space to $\mathcal{M}^{\delta}$ and to $\mathcal{W}_{s}^{\delta}$ at $\Gamma_{s}^{\delta}$. The linear operator $\Phi_{s+t, s}^{\delta}=D T^{t}\left(\Gamma_{s}^{\delta}\right)$ commutes then with these projections, and is bounded from above and below in the direction of the tangent space to $\mathcal{M}^{\delta}$, while it is contractive in the direction of the tangent space to stable foliations.

In addition to the contractive property, the regularization effect of $\Phi^{\delta}$ given in (1.38) is a consequence of the fact that $\Phi_{t+s, s} \nu=\nu_{t}$ where $\nu_{0}=\nu$ and $\nu_{t}=\left(\eta_{t}, n_{t}\right)$ is solution to

\end{align*}\right.

The operator $\widetilde{\mathcal{L}}(\eta, n)=(\mathcal{L} \eta, 0)$ is sectorial in $\mathbf{H}_{\theta}^{-r}$ and thus induces regularization properties for the solutions to (4.3), and thus for $\Phi^{\delta}$. More precisely we are in fact exactly in the situation of [23], Theorem 7.2.3 and the following remark. Indeed, for $s \in\left[0, T_{\delta}\right)$ we can define the operator $U_{s}^{\delta}=\Phi_{s+T_{\delta}, s}^{\delta}$, and we can deduce from above spectral properties for $U_{t}^{\delta}$. Since $\Gamma^{\delta}$ is a periodic solution $U_{s}^{\delta}$ admits 1 as eigenvalue, with eigenfunction $\partial_{s} \Gamma_{s}^{\delta}$ and corresponding projection $\Pi_{s}^{\delta, c}$, and due to the contractive properties $\Phi^{\delta}$ the rest of the spectrum of $U_{s}^{\delta}$ is located in a disk centered at 0 with radius $e^{-\lambda_{\delta} T_{\delta}}$. We can then apply Theorem 7.2.3 and the following remark to obtain (1.38) (reducing slightly the value of $\left.\lambda_{\delta}\right)$.

The $C^{1}$ regularity of $s \mapsto \Pi_{s}^{\delta, c}$ is not a direct consequence the normally hyperbolic results of 5 (they prove that $\mathcal{W}_{s}^{\delta}$ has a Hölder regularity with respect to $s$ ), but since we are in the case of a periodic solution we have an explicit formula for $\Pi_{s}^{\delta, c}: 1$ is an isolated eigenvalue of $U_{t}^{\delta}$, so for $\mathcal{C}_{\varepsilon}$ the circle centered at 1 with radius $\varepsilon>0$, with $\varepsilon$ small enough, we have

\dot{\zeta}_{t}^{2} & =\delta D G_{2}\left(\Gamma_{s+t}^{\delta}\right)\left[\zeta_{t}\right]+\delta D^{2} G_{2}\left(\Gamma_{s+t}^{\delta}\right)\left[\partial_{t} \Gamma_{s+t}^{\delta}, \zeta_{t}\right]
\end{align*}\right.

and thus $s \mapsto \Pi_{s}^{\delta, c}$ is also $C^{1}$.
It is not immediate that $q_{s}^{\delta}$ is a probability distribution, since we apply the results of 5 considering solutions $p_{t} \in H_{\theta}^{-r}$ satisfying $\int_{\mathbb{R}^{d}} p_{t}=1$ but without any hypotheses on non negativeness. However, $\widetilde{\mathcal{M}}^{\delta}$ is in the basin of attraction of $\mathcal{M}^{\delta}$, so any $\left(q_{s}^{\delta}, m_{s}^{\delta}\right) \in \mathcal{M}^{\delta}$ is the limit in $\mathbf{H}_{\theta}^{-r}$ of $\left(p_{t}, m_{t}\right)=T^{t}\left(\rho, \alpha_{u}^{\delta}\right)$ for some $u \in\left[0, \frac{T_{\alpha}}{\delta}\right)$. So, since in this case $p_{t}$ is a probability distribution (recall that it is the probability distribution of $X_{t}-\mathbb{E}\left[X_{t}\right]$, where $X_{t}$ satisfies (1.2) with initial distribution $\rho$ ), we deduce that $\left\langle q_{s}^{\delta}, \varphi\right\rangle \geqslant 0$ for any smooth function $\varphi$ with compact support, and thus $q_{s}^{\delta}$ is also a probability distribution.

## 5. Proof of Theorem 1.6

As it was already explained in Section 1.4, the existence of the map $\Theta^{\delta}$ is a consequence of the foliation property proved in 55. $\Theta^{\delta}$ satisfies moreover the relation

Our aim in the present section is to prove the $C^{2}$ regularity of $\Theta^{\delta}$. Following ideas of [22], we will prove uniform in time bounds for the first and second derivatives of the flow $T^{t}$, which will induce the regularity of

Proof of Theorem 1.6.

For $\mu_{0}=\left(p_{0}, m_{0}\right) \in \mathcal{V}(\mathcal{M}, \varepsilon)$ and $u=\Theta\left(\mu_{0}\right)$, we have, denoting by $\nu_{t}=\left(\eta_{t}, n_{t}\right)=D T^{t}\left(\mu_{0}\right)\left[\nu_{0}\right]$,

& \quad=\frac{C_{8}\left\|\mu-\Gamma_{u}^{\delta}\right\|_{\mathbf{H}_{\theta}^{-r}}^{-r}\left\|\nu_{0}\right\|_{\mathbf{H}_{\theta}^{-r}}^{-r}}{\lambda_{\delta}} e^{-\lambda_{\delta} m T_{\delta}}\left(1+e^{-\lambda_{\delta}(n-m) T_{\delta}}\left(2 \lambda_{\delta} \sqrt{(n-m) T_{\delta}}-1\right)\right) \\
& \leqslant C_{9}\left\|\mu-\Gamma_{u}^{\delta}\right\|_{\mathbf{H}_{\theta}^{-r}}\left\|\nu_{0}\right\|_{\mathbf{H}_{\theta}^{-r}} e^{-\lambda_{\delta} m T_{\delta}} . \tag{5.21}

& \leqslant C_{10}\left\|\mu-\Gamma_{u}^{\delta}\right\|_{\mathbf{H}_{\theta}^{-r}}\left\|\nu_{0}\right\|_{\mathbf{H}_{\theta}^{-r}} \int_{0}^{m T_{\delta}}\left(m T_{\delta}-s\right)^{-\frac{1}{2}} e^{-\lambda_{\delta}\left(m T_{\delta}-s\right)} e^{-\lambda_{\delta} s} d s \\

& \quad \leqslant C_{23}\left\|\nu_{0}\right\|_{\mathbf{H}_{\theta}^{-r}}\left\|w_{0}\right\|_{\mathbf{H}_{\theta}^{-r}} \int_{0}^{n T_{\delta}}\left(n T_{\delta}-s\right)^{-\frac{1}{2}} e^{-\lambda_{\delta}\left(n T_{\delta}-s\right)} s^{\frac{1}{2}} e^{-\lambda_{\delta} \frac{s}{2}} \mathrm{~d} s \\
& \quad \leqslant C_{24} n^{\frac{1}{2}} e^{-\lambda_{\delta} \frac{T_{\delta}}{2}}\left\|\nu_{0}\right\|_{\mathbf{H}_{\theta}^{-r}}\left\|w_{0}\right\|_{\mathbf{H}_{\theta}^{-r}} . \tag{5.54}
\end{align*}
$$

With all these estimates we are able to tackle the first two lines of (5.47):

\begin{gather*}
\left\|\int_{0}^{n T_{\delta}} \Phi_{u+n T_{\delta}, u+s}^{\delta} D^{2} G\left(\Gamma_{u+s}^{\delta}\right)\left[\nu_{s}, w_{s}\right] \mathrm{d} s-\int_{0}^{m T_{\delta}} \Phi_{u+m T_{\delta}, u+s}^{\delta} D^{2} G\left(\Gamma_{u+s}^{\delta}\right)\left[\nu_{s}, w_{s}\right] \mathrm{d} s\right\|_{\mathbf{H}_{\theta}^{-r}} \\
\leqslant C_{25} n^{\frac{1}{2}} e^{-\lambda_{\delta} n \frac{T_{\delta}}{4}}\left\|\nu_{0}\right\|_{\mathbf{H}_{\theta}^{-r}}\left\|w_{0}\right\|_{\mathbf{H}_{\theta}^{-r}} . \tag{5.55}
\end{gather*}
$$

The other terms can be treated in a straightforward way, with similar estimates as the ones used in Step 2 and Step 3. At the end, one obtains

\end{equation*}

with a constant $C_{25}$ uniform in $\mathcal{V}$. Hence, $\mu \mapsto S(\mu)$ is thus $C^{2}$. Remark that we have in particular

\end{equation*}

Step 5: from the previous steps, and the fact that $t \mapsto \Gamma_{t}^{\delta}$ is a $C^{2}$ bijection from $\mathbb{R} / T_{\delta} \mathbb{Z}$ to $\mathcal{M}^{\delta}$ implies that $\Theta^{\delta}$ is itself $C^{2}$.

For the last estimate of the Theorem, let us denote $\xi_{t}^{2}=D^{2} T^{t}(\mu)[\nu, w], \xi_{t}^{1}=D^{2} T^{t}\left(\Gamma_{u}^{\delta}\right)[\nu, w]$, $\nu_{t}^{2}=D T^{t}(\mu)[\nu], \nu_{t}^{1}=D T^{t}\left(\Gamma_{u}^{\delta}\right)[\nu], w_{t}^{2}=D T^{t}(\mu)[w]$ and $w_{t}^{1}=D T^{t}\left(\Gamma_{u}^{\delta}\right)[w]$. We then have the decomposition

& +\delta \int_{0}^{t} \Phi_{u+t, u+s}^{\delta}\left(D^{2} G\left(\mu_{s}\right)-D^{2} G\left(\Gamma_{u+s}^{\delta}\right)\right)\left[\nu_{s}^{2}, w_{s}^{2}\right] \mathrm{d} s \\
& +\delta \int_{0}^{t} \Phi_{u+t, u+s}^{\delta} D^{2} G\left(\Gamma_{u+s}^{\delta}\right)\left[\nu_{s}^{2}-\nu_{s}^{1}, w_{s}^{2}\right] \mathrm{d} s \\
& +\delta \int_{0}^{t} \Phi_{u+t, u+s}^{\delta} D^{2} G\left(\Gamma_{u+s}^{\delta}\right)\left[\nu_{s}^{1}, w_{s}^{2}-w_{s}^{1}\right] \mathrm{d} s
\end{align*}
$$

Following similar estimates as in the previous steps, relying in particular on (5.32), we obtain

\end{equation*}
$$

which implies indeed that $\left\|D^{2} \Theta^{\delta}(\mu)-D^{2} \Theta^{\delta}\left(\Gamma_{u}^{\delta}\right)\right\|_{\mathcal{B} \mathcal{L}\left(\mathbf{H}_{\theta}^{-r}\right)} \leqslant C_{28}\left\|\mu-\Gamma_{u}^{\delta}\right\|_{\mathbf{H}_{\theta}^{-r}}$.

## Appendix A. Ornstein-Uhlenbeck operators

We first prove the following lemma, which shows the link between the norm $\|f\|_{H_{\theta}^{r}}$ and the space derivatives.

Lemma A.1. For all $\theta>0$, there exists explicit positive constants $C_{1}, C_{2}$ such that for all $r \geqslant 0$ :

Proof. For $u$ with decomposition $u=\sum_{l \in \mathbb{N}^{d}} u_{l} \psi_{l}$, we have $\partial_{x_{i}} u=\sum_{l \in \mathbb{N}^{d}} u_{l} \partial_{x_{i}} \psi_{l}$, and straightforward calculations (recalling (1.15) and using the fact that $h_{n}^{\prime}(x)=\sqrt{n} h_{n-1}(x)$ ) show that

\|u\|_{H_{\theta}^{r}}^{2}+\sum_{i=1}^{d}\left\|\partial_{x_{i}} u\right\|_{H_{\theta}^{r}}^{2}=\sum_{l \in \mathbb{N}^{d}} u_{l}^{2}\left(\left(a_{\theta}+\lambda_{l}\right)^{r}+\sum_{i=1}^{d} l_{i} \mathbf{1}_{l_{i} \geqslant 1} \frac{\theta k_{i}}{\sigma_{i}^{2}}\left(a_{\theta}+\lambda_{l}-\theta k_{i}\right)^{r}\right) \tag{A.4}
\end{equation*}
$$

Let us prove the upper bound in (A.1): note that for $l_{i} \geqslant 1$, we have $\lambda_{l} \geqslant \theta k_{i}$. Hence, since for all $\mu \geqslant 0, r \geqslant 0, \lambda \geqslant \mu,\left(a_{\theta}+\lambda-\mu\right)^{r} \geqslant a_{\theta}^{r}\left(\frac{\left(a_{\theta}+\lambda\right)^{r}}{\left(a_{\theta}+\mu\right)^{r}}\right.$, we deduce that

& \geqslant \sum_{l \in \mathbb{N}^{d}} u_{l}^{2}\left(a_{\theta}+\lambda_{l}\right)^{r}\left(1+\frac{a_{\theta}^{r}}{\sigma_{\max }^{2}\left(a_{\theta}+\theta k_{\max }\right)^{r}} \lambda_{l}\right),
\end{aligned}
$$

so that the upper bound in (A.1) is true for $C_{2}:=\max \left(\frac{\sigma_{\max }^{2}\left(a_{\theta}+\theta k_{\max }\right)^{r}}{a_{\theta}^{r}}, a_{\theta}\right)$. Concerning the lower bound in (A.1), we have from (A.4),

For all $\theta>0$, the operator $-\mathcal{L}_{\theta}^{*}$ (recall its definition (1.14) and its decomposition (1.15)) is sectorial in $L_{\theta}^{2}$ and generates a semigroup $e^{t \mathcal{L}_{\theta}^{*}}$ satisfying (see e.g. [23]) for all $\alpha \geqslant 0$, $r \geqslant 0$, and $\lambda<\theta \min \left(k_{1}, \ldots, k_{d}\right)$, there exists some $C>0$ such that for all $f \in H_{\theta}^{r}$,

Let $\theta^{\prime}>0$. The point of the following result is to state similar contraction results for $\mathcal{L}_{\theta^{\prime}}^{*}$ in $H_{\theta}^{r}$, in the case $\theta^{\prime} \neq \theta$ :

For all $0<\theta \leqslant \theta^{\prime}$ the following is true: the operator $\mathcal{L}_{\theta^{\prime}}^{*}$ generates an analytic semigroup in $H_{\theta}^{r}$ and for all $r \geqslant 0, \alpha \geqslant 0$ and $\lambda<\theta \min \left(k_{1}, \ldots, k_{d}\right)$, there exists a constant $C>0$ such that for all $f \in H_{\theta}^{r}$ and $t>0$

and for all $r \geqslant 1$,

Moreover for all $r \geqslant 0,0<\varepsilon \leqslant 1$ and $s \geqslant 0$,

\left\|\left(e^{(t+s) \mathcal{L}_{\theta^{\prime}}^{*}}-e^{t \mathcal{L}_{\theta^{\prime}}^{*}}\right) f\right\|_{H_{\theta}^{r+1}} \leqslant C s^{\varepsilon} t^{-\frac{1}{2}-\varepsilon} e^{-\lambda t}\|f\|_{H_{\theta}^{r}} . \tag{A.9}

Finally, there exists $r_{0}>0$ such that for all $r>r_{0}, t>0$ and all $f \in H_{\theta}^{r}$,

Proof of Proposition A.2. First remark that for all smooth test function $u$

& =\left(\theta^{\prime}-\theta\right) \sum_{i=1}^{d} k_{i}\left(l_{i} \psi_{\theta, l}+\sqrt{l_{i}\left(l_{i}-1\right)} \psi_{\theta, l_{l_{i}}}\right), \tag{A.13}
\end{align*}
$$

where we used the following notations for the shifts w.r.t. the $i$ th coordinate

and the convention $\psi_{l}=0$ if $l_{i}<0$ for some $i \in\{1, \ldots, d\}$. In particular we have, recalling that $\lambda_{\theta, l}=\theta \sum_{i=1}^{d} k_{i} l_{i}$,

\end{equation*}

So, we deduce that for $f=\sum_{l} f_{l} \psi_{\theta, l}$, with $f_{l} \in \mathbb{C}$ for all $l$,

$$

Setting

\begin{equation*}
I(r, f):=\sum_{l}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r}\left(\sum_{i=1}^{d} \theta k_{i} \sqrt{\left(l_{i}+1\right)\left(l_{i}+2\right)} f_{l_{\Pi_{i}}}\right)^{2} \tag{A.17}
\end{equation*}
$$

Using Jensen's inequality, we obtain (recalling that $a_{\theta}=\theta \operatorname{Tr}(K)$ ),

I(r, f) & \leqslant \sum_{l_{1}, \ldots, l_{d}=0}^{+\infty}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r}\left(\sum_{i=1}^{d} \theta k_{i}\left(l_{i}+1\right)\right)\left(\sum_{i=1}^{d} \theta k_{i}\left(l_{i}+2\right)\left|f_{l_{\pi_{i}}}\right|^{2}\right) \\
& =\sum_{l_{1}, \ldots, l_{d}=0}^{+\infty}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r+1}\left(\sum_{i=1}^{d} \theta k_{i}\left(l_{i}+2\right)\left|f_{l_{\pi_{i}}}\right|^{2}\right) \\
& =\sum_{l_{1}, \ldots, l_{d}=2}^{+\infty}\left(a_{\theta}+\lambda_{\theta, l-2}\right)^{r+1}\left(\sum_{i=1}^{d} \theta k_{i} l_{i}\left|f_{l_{1}-2, \ldots, l_{i}, l_{i+1}-2, l_{d}-2}\right|^{2}\right) \\
& =\sum_{i=1}^{d} \sum_{l_{1}, \ldots, l_{d}=2}^{+\infty}\left(a_{\theta}+\lambda_{\theta, l-2}\right)^{r+1} \theta k_{i} l_{i}\left|f_{l_{1}-2, \ldots, l_{i}, l_{i+1}-2, l_{d}-2}\right|^{2} \\
& =\sum_{i=1}^{d} \sum_{l_{i}=2}^{+\infty} \sum_{l_{p}=0}^{+\infty}\left(a_{\theta}+\lambda_{\theta, l_{l_{i}}}\right)^{r+1} \theta k_{i} l_{i}\left|f_{l}\right|^{2} .
\end{aligned}
$$

Now we use that $\lambda_{\theta, l_{\Perp_{i}}} \leqslant \lambda_{\theta, l}$ for any $l$ and $i$, so that

p \neq i}}^{+\infty}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r+1} \theta k_{i} l_{i}\left|f_{l}\right|^{2}=\sum_{l_{1}=0}^{+\infty} \ldots \sum_{l_{d}=0}^{+\infty}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r+1} \lambda_{\theta, l}\left|f_{l}\right|^{2}, \\
& \leqslant \sum_{l_{1}=0}^{+\infty} \cdots \sum_{l_{d}=0}^{+\infty}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r+2}\left|f_{l}\right|^{2}=\left\|\left(a_{\theta}-\mathcal{L}_{\theta}^{*}\right) f\right\|_{H_{\theta}^{r}}^{2} . \tag{A.19}
\end{align*}

Coming back to (A.17), we obtain

which implies in particular that

\left\|\left(a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}\right) f\right\|_{H_{\theta}^{r}} \leqslant\left(2-\frac{\theta}{\theta^{\prime}}\right)\left\|\left(a_{\theta}-\mathcal{L}_{\theta}^{*}\right) f\right\|_{H_{\theta}^{r}}=\left(2-\frac{\theta}{\theta^{\prime}}\right)\|f\|_{H_{\theta}^{r+2}} . \tag{A.21}

& \left.\quad+\left(1-\frac{\theta}{\theta^{\prime}}\right) \sum_{i=1}^{d} \theta k_{i} \sqrt{\left(l_{i}+1\right)\left(l_{i}+2\right)} f_{l \pi_{i}}\right)^{2} \\
\geqslant & \frac{\varepsilon}{1+\varepsilon} \sum_{l}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r+2} f_{l}^{2}-\varepsilon\left(1-\frac{\theta}{\theta^{\prime}}\right)^{2} I(r, f) . \tag{A.22}
\end{align*}
$$

Hence, recalling (A.19), we obtain

\left\|\left(a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}\right) f\right\|_{H_{\theta}^{r}}^{2} \geqslant \varepsilon\left(\frac{1}{1+\varepsilon}-\left(1-\frac{\theta}{\theta^{\prime}}\right)^{2}\right)\left\|\left(a_{\theta}-\mathcal{L}_{\theta}^{*}\right) f\right\|_{H_{\theta}^{r}}^{2} \tag{A.23}
\end{equation*}
$$

So for $\varepsilon>0$ small enough (depending only on $\theta, \theta^{\prime}$ ), there exists a constant $c_{\theta, \theta^{\prime}}>0$ such that we have $\left\|\left(a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}\right) f\right\|_{H_{\theta}^{r}} \geqslant c_{\theta, \theta^{\prime}}\left\|\left(a_{\theta}-\mathcal{L}_{\theta}^{*}\right) f\right\|_{H_{\theta}^{r}}$. This means, together with (A.21), that

c_{\theta, \theta^{\prime}}\|f\|_{H_{\theta}^{r+2}} \leqslant\left\|\left(a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}\right) f\right\|_{H_{\theta}^{r}} \leqslant\left(2-\frac{\theta}{\theta^{\prime}}\right)\|f\|_{H_{\theta}^{r+2}} . \tag{A.24}
\end{equation*}
$$

In particular 0 is in the resolvent set of $a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}$, and $a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}$ has a compact resolvent, since it is the case for $a_{\theta}-\mathcal{L}_{\theta}^{*}$. So $\mathcal{L}_{\theta^{\prime}}^{*}$ has a discrete spectrum, composed of a sequence of eigenvalues with modulus going to infinity. But any eigenfunction $\psi$ of $\mathcal{L}_{\theta^{\prime}}^{*}$ in $H_{\theta}^{r}$ is also an eigenfunction of $\mathcal{L}_{\theta^{\prime}}^{*}$ in $H_{\theta^{\prime}}^{r}$, and thus the eigenvalues of $\mathcal{L}_{\theta^{\prime}}^{*}$ in $H_{\theta}^{r}$ are the $\lambda_{l, \theta^{\prime}}$ 's, with
associated eigenfunctions the $\psi_{l, \theta^{\prime}}$ 's. So in particular $\mathcal{L}_{\theta^{\prime}}^{*}$ is sectorial, and thus generates an analytic semigroup $e^{t \mathcal{L}_{\theta^{\prime}}^{*}}$ in $H_{\theta}^{r}$.

Let us now prove that the interpolation spaces induced by $\mathcal{L}_{\theta^{\prime}}^{*}$ and $\mathcal{L}_{\theta}^{*}$ in $H_{\theta}^{r}$ are equivalent. Since the operator $\left(\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}-\mathcal{L}_{\theta}^{*}\right)\left(a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}\right)^{-1}\left(\right.$ and thus $\left(1+\left(\theta \mathcal{L}^{*}-\mathcal{L}_{\theta}^{*}\right)\left(a_{\theta}-\theta \mathcal{L}^{*}\right)^{-1}\right)^{\alpha}$ for $\alpha \geqslant 0$ ) is bounded in $H_{\theta}^{r}$, we obtain

\|f\|_{H_{\theta}^{r+\alpha}} & =\left\|\left(a_{\theta}-\mathcal{L}_{\theta}^{*}\right)^{\alpha / 2} f\right\|_{H_{\theta}^{r}} \\
& =\left\|\left(1+\left(\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}-\mathcal{L}_{\theta}^{*}\right)\left(a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}\right)^{-1}\right)^{\alpha / 2}\left(a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}\right)^{\alpha / 2} f\right\|_{H_{\theta}^{r}}  \tag{A.25}\\
& \leqslant C\left\|\left(a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}\right)^{\alpha / 2} f\right\|_{H_{\theta}^{r}} .
\end{align*}
$$

The inverse bound $\left\|\left(a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}\right)^{\alpha / 2} f\right\|_{H_{\theta}^{r}} \leqslant C\|f\|_{H_{\theta}^{r+\alpha}}$ follows from similar arguments.
We are now in condition to prove (A.5), applying [23], Th. 1.4.3. Indeed, $\mathcal{L}_{\theta^{\prime}}^{*}$ has a real spectrum smaller than $-\theta^{\prime} \min \left(k_{1}, \ldots, k_{d}\right)$ on the the subspace of $H_{\theta}^{r}$ generated by the eigenfunctions $\psi_{l, \theta^{\prime}}$ with $l \neq 0$, so applying this Theorem we get, denoting $\mathcal{P}_{\theta^{\prime}} f=$ $f-\frac{\int_{\mathbb{R}^{d}} f w_{\theta^{\prime}}}{\left(\int_{\mathbb{R}^{d}} w_{\theta^{\prime}}\right)^{2}}$ the projection on this subspace (which is an element of $\mathcal{B}\left(H_{\theta}^{r}\right)$ for $0<\theta \leqslant \theta^{\prime}$ ),

$$
\begin{equation*}
\left\|e^{t \mathcal{L}_{\theta^{\prime}}^{*}} \mathcal{P}_{\theta^{\prime}} f\right\|_{H_{\theta}^{r+\alpha}} \leqslant C_{1}\left\|\left(a_{\theta}-\frac{\theta}{\theta^{\prime}} \mathcal{L}_{\theta^{\prime}}^{*}\right)^{\alpha / 2} e^{t \mathcal{L}_{\theta^{\prime}}^{*}} \mathcal{P}_{\theta^{\prime}} f\right\|_{H_{\theta}^{r}} \leqslant C_{2} t^{-\alpha / 2} e^{-\lambda t}\|f\|_{H_{\theta}^{r}} . \tag{A.26}
\end{equation*}
$$

This implies (A.5), since $e^{t \mathcal{L}_{\theta^{\prime}}^{*}}\left(1-\mathcal{P}_{\theta^{\prime}}\right) f=\left(1-\mathcal{P}_{\theta^{\prime}}\right) f$.
The proof of (A.6) relies on the classical identity, valid for $f \in L_{\theta^{\prime}}^{2}$,

where $G_{\theta^{\prime}}$ a gaussian variable on $\mathbb{R}^{d}$ with mean 0 and variance $\left(\theta^{\prime} K\right)^{-1} \sigma^{2}$. This implies directly, for $f \in H_{\theta}^{r}$ with $r \geqslant 1$,

&\left\|\nabla e^{t \mathcal{L}_{N}^{*}} f\right\|_{H_{\theta}^{r}} \leqslant e^{-\theta^{\prime} \underline{K} t}\left\|e^{t \mathcal{L}_{N}^{*}} \nabla f\right\|_{H_{\theta}^{r}} \leqslant C\left(1+t^{-\frac{1}{2}} e^{-\lambda t}\right) e^{-\theta^{\prime} \underline{K} t}\|\nabla f\|_{H_{\theta}^{r-1}} \\
& \leqslant C^{\prime} t^{-\frac{1}{2}} e^{-\lambda t}\|f\|_{H_{\theta}^{r}} \tag{A.29}
\end{align*}
$$

For the proof of the third assertion, since [23], Th. 1.4.3. implies that for $0<\varepsilon \leqslant 1$,

\end{equation*}

we obtain, since $\left(e^{s \mathcal{L}_{\theta^{\prime}}^{*}}-1\right) \mathcal{P}_{\theta^{\prime}} f=\left(e^{s \mathcal{L}_{\theta^{\prime}}^{*}}-1\right) f$ and $\mathcal{P}_{\theta^{\prime}}$ commutes with $e^{t \mathcal{L}_{\theta^{\prime}}^{*}}$,

\left\|\left(e^{(t+s) \mathcal{L}_{\theta^{\prime}}^{*}}-e^{t \mathcal{L}_{\theta^{\prime}}^{*}}\right) f\right\|_{H_{\theta}^{r+1}}=\|\left(e^{s \mathcal{L}_{\theta^{\prime}}^{*}}-1\right) e^{t \mathcal{L}_{\theta^{\prime}}^{*}} \mathcal{P}_{\theta^{\prime}} f
\end{align*}\left\|_{H_{\theta}^{r+1}} \leqslant C_{\varepsilon} s^{\varepsilon}\right\| e^{t \mathcal{L}_{\theta^{\prime}}^{*} \mathcal{P}_{\theta^{\prime}} f} \|_{H_{\theta}^{r+1+2 \varepsilon}}
$$

The last assertion is not a direct consequence of the estimates obtained above, since the hypothesis $\int_{\mathbb{R}^{d}} f w_{\theta}=0$ is not well adapted to the eigenfunctions $\psi_{l, \theta^{\prime}}$ of $\mathcal{L}_{\theta^{\prime}}^{*}$. In particular, having $\int_{\mathbb{R}^{d}} f w_{\theta}=0$ does not imply $\int_{\mathbb{R}^{d}} e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f w_{\theta}=0$, while it is the case when $\theta=\theta^{\prime}$. We will only be able to obtain this estimates for $r$ large enough, via direct calculations. Remark first that

& \frac{1}{2} \frac{d}{d t}\left\|e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f-\frac{\int_{\mathbb{R}^{d}} e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f w_{\theta}}{\int_{\mathbb{R}^{d}} w_{\theta}}\right\|_{H_{\theta}^{r}}^{2} \\
& =\left\langle\mathcal{L}_{\theta^{\prime}}^{*} e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f-\frac{\int_{\mathbb{R}^{d}} \mathcal{L}_{\theta^{\prime}}^{*} e e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f w_{\theta}}{\int_{\mathbb{R}^{d}} w_{\theta}}, e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f-\frac{\int_{\mathbb{R}^{d}} e^{t \mathcal{L}_{\theta^{\prime}}^{*} f w_{\theta}}}{\int_{\mathbb{R}^{d}} w_{\theta}}\right\rangle_{H_{\theta}^{r}} . \tag{A.32}
\end{align*}
$$

Recalling that $\mathcal{L}_{\theta^{\prime}}^{*} a=0$ and remarking that $\left\langle a, e^{t \mathcal{L}_{\theta^{\prime}}^{*} f}-\frac{\int_{\mathbb{R}^{d}} e^{t \mathcal{L}_{\theta^{\prime}}^{*} f w_{\theta}}}{\int_{\mathbb{R}^{d} d} w_{\theta}}\right\rangle_{H_{\theta}^{r}}=0$ for any constant $a$, we get

& \frac{1}{2} \frac{d}{d t} \| e^{t \mathcal{L}_{\theta^{\prime}}^{*} f-\frac{\int_{\mathbb{R}^{d}} e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f w_{\theta}}{\int_{\mathbb{R}^{d}} w_{\theta}} \|_{H_{\theta}^{r}}^{2}} \begin{array}{l}
\quad=\left\langle\mathcal{L}_{\theta^{\prime}}^{*}\left(e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f-\frac{\int_{\mathbb{R}^{d}} e^{t \mathcal{L}_{\theta^{\prime}}^{*} f w_{\theta}}}{\int_{\mathbb{R}^{d}} w_{\theta}}\right), e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f-\frac{\int_{\mathbb{R}^{d}} e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f w_{\theta}}{\int_{\mathbb{R}^{d}} w_{\theta}}\right\rangle_{H_{\theta}^{r}}
\end{array},
\end{align*}
$$

so the proof of the last assertion reduces to the study of $\left\langle\mathcal{L}_{\theta^{\prime}}^{*} f, f\right\rangle_{H_{\theta}^{r}}$ with $\int_{\mathbb{R}^{d}} f w_{\theta}=0$. Now for $f$ satisfying $\int_{\mathbb{R}^{d}} f w_{\theta}=0$, with decomposition $f=\sum_{l \neq 0} f_{l} \psi_{l, \theta}$, we get

& +\left(1-\frac{\theta}{\theta^{\prime}}\right)\left(\sum_{l \neq 0}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r} \sum_{i=1}^{d} \theta k_{i} \sqrt{\left(l_{i}+1\right)\left(l_{i}+2\right)} f_{l} \bar{f}_{l_{\Uparrow_{i}}}\right) . \tag{A.34}
\end{align*}
$$

Now remark that for the second term, using Cauchy Schwarz inequality, we get

& =\left|\sum_{l \neq 0}\left\{\left(a_{\theta}+\lambda_{\theta, l}\right)^{r / 2} \sqrt{\lambda_{\theta, l}} f_{l}\right\}\left\{\frac{\left(a_{\theta}+\lambda_{\theta, l}\right)^{r / 2}}{\sqrt{\lambda_{\theta, l}}} \sum_{i=1}^{d} \theta k_{i} \sqrt{\left(l_{i}+1\right)\left(l_{i}+2\right)} \bar{f}_{l_{\pi_{i}}}\right\}\right| \\
& \leqslant\left.\left.\left|\sum_{l \neq 0}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r} \lambda_{\theta, l}\right| f_{l}\right|^{2}\right|^{\frac{1}{2}}\left|\sum_{l \neq 0} \frac{\left(a_{\theta}+\lambda_{\theta, l}\right)^{r}}{\lambda_{\theta, l}}\left(\sum_{i=1}^{d} \theta k_{i} \sqrt{\left(l_{i}+1\right)\left(l_{i}+2\right)} \bar{f}_{l \pi_{i}}\right)^{2}\right|^{\frac{1}{2}} .
\end{aligned}
$$

Using Jensen's inequality

& \left|\sum_{l \neq 0} \frac{\left(a_{\theta}+\lambda_{\theta, l}\right)^{r}}{\lambda_{\theta, l}}\left(\sum_{i=1}^{d} \theta k_{i} \sqrt{\left(l_{i}+1\right)\left(l_{i}+2\right)} \bar{f}_{l_{\pi_{i}}}\right)^{2}\right| \\
& \leqslant \sum_{l \neq 0} \frac{\left(a_{\theta}+\lambda_{\theta, l}\right)^{r}}{\lambda_{\theta, l}}\left(\sum_{i=1}^{d} \theta k_{i}\left(l_{i}+2\right)\right) \sum_{i=1}^{d} \theta k_{i}\left(l_{i}+2\right)\left|f_{l_{\Pi_{i}}}\right|^{2} \\
& =\sum_{l \neq 0} \frac{\left(a_{\theta}+\lambda_{\theta, l}\right)^{r}}{\lambda_{\theta, l}}\left(2 a_{\theta}+\lambda_{\theta, l}\right) \sum_{i=1}^{d} \theta k_{i}\left(l_{i}+2\right)\left|f_{l_{\Pi_{i}}}\right|^{2}
\end{aligned}
$$

Denoting by $\mathcal{N}_{i}:=\uparrow_{i}\left(\mathbb{N}^{d} \backslash\{0\}\right)=\left\{l \in \mathbb{N}^{d}, l_{i} \geqslant 2, \sum_{j=1}^{d} l_{j} \geqslant 3\right\}$, we obtain

& \left|\sum_{l \neq 0} \frac{\left(a_{\theta}+\lambda_{\theta, l}\right)^{r}}{\lambda_{\theta, l}}\left(\sum_{i=1}^{d} \theta k_{i} \sqrt{\left(l_{i}+1\right)\left(l_{i}+2\right)} \bar{f}_{l_{\pi_{i}}}\right)^{2}\right| \\
& \leqslant 2 \sum_{i=1}^{d} \sum_{l \in \mathcal{N}_{i}} \frac{\left(a_{\theta}+\lambda_{\theta, l_{l_{i}}}\right)^{r}}{\lambda_{\theta, l_{\Perp_{i}}}}\left(2 a_{\theta}+\lambda_{\theta, l_{\Perp_{i}}}\right) \theta k_{i} l_{i}\left|f_{l}\right|^{2} \\
& =\sum_{i=1}^{d} \sum_{l \in \mathcal{N}_{i}} \frac{\left(a_{\theta}+\lambda_{\theta, l}-2 \theta k_{i}\right)^{r}}{\lambda_{\theta, l}-2 \theta k_{i}}\left(2 a_{\theta}+\lambda_{\theta, l}-2 \theta k_{i}\right) \theta k_{i} l_{i}\left|f_{l}\right|^{2} \\
& =\sum_{i=1}^{d} \sum_{l \in \mathcal{N}_{i}} b_{\theta, l, i}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r} \theta k_{i} l_{i}\left|f_{l}\right|^{2},
\end{aligned}
$$

where

$$
\begin{equation*}
b_{\theta, l, i}:=\frac{\left(a_{\theta}+\lambda_{\theta, l}-2 \theta k_{i}\right)^{r}\left(2 a_{\theta}+\lambda_{\theta, l}-2 \theta k_{i}\right)}{\left(a_{\theta}+\lambda_{\theta, l}\right)^{r}\left(\lambda_{\theta, l}-2 \theta k_{i}\right)}=\left(1-\frac{2 \theta k_{i}}{a_{\theta}+\lambda_{\theta, l}}\right)^{r}\left(1+\frac{2 a_{\theta}}{\lambda_{\theta, l}-2 \theta k_{i}}\right) . \tag{A.35}
\end{equation*}

Now, for $l \in \mathcal{N}_{i}$, we have

Now, observe that for $c_{1}, c_{2}>0, x \mapsto\left(1-\frac{c_{1}}{x}\right)^{r}\left(1+\frac{c_{2}}{x}\right)$ is strictly increasing with limit 1 as $x \rightarrow \infty$, provided that $r>\frac{c_{2}}{c_{1}}$. Hence, taking $r$ large enough in (A.38) ( $r$ depending only on $K$ and $d$, not on $l, i$ nor $\theta$ ) we have $\left|b_{\theta, l, i}\right| \leqslant 1$, which means that the second term of the right-hand side of (A.34) is bounded as follows:

\left.\left.\left|-\frac{\theta}{\theta^{\prime}}\left\langle\mathcal{P}_{\theta}^{\perp} \mathcal{L}_{\theta^{\prime}}^{*}, \mathcal{P}_{\theta}^{\perp} f, \bar{f}\right\rangle_{H_{\theta}^{r}}-\sum_{l \neq 0}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r} \lambda_{\theta, l}\right| f_{l}\right|^{2}\left|\leqslant\left(1-\frac{\theta}{\theta^{\prime}}\right) \sum_{l \neq 0}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r} \lambda_{\theta, l}\right| f_{l}\right|^{2}, \tag{A.40}
\end{equation*}
$$

which means that

$$
\begin{equation*}
-\operatorname{Re}\left\langle\mathcal{L}_{\theta^{\prime}}^{*} f, \bar{f}\right\rangle_{H_{\theta}^{r}} \geqslant \sum_{l \neq 0}\left(a_{\theta}+\lambda_{\theta, l}\right)^{r} \lambda_{\theta, l}\left|f_{l}\right|^{2} \geqslant \theta k_{\min }\|f\|_{H_{\theta}^{r}}^{2} . \tag{A.41}
\end{equation*}
$$

As already stated in Section 1.3, we rely in this paper on a "pivot" space structure (see [10], pp.81-82): observe first that for $u \in L_{-\theta}^{2}, v \in L_{\theta}^{2} \mapsto \int_{\mathbb{R}^{d}} u v \mathrm{~d} x$ defines a continuous linear form on $L_{\theta}^{2}$. Respectively, for $u \in\left(L_{\theta}^{2}\right)^{\prime}$, the mapping $\psi \mapsto T u(\psi):=\left\langle u, \psi w_{-\theta}\right\rangle$ defines a continuous linear form on $L^{2}$ (that is the usual $L^{2}$ space without weight, i.e. $w \equiv 1$ in (1.13)). By Riesz Theorem, there exists $v \in L^{2}$, such that $T u(\psi)=\int v \psi=$ $\int \widetilde{v} \widetilde{\psi}, \psi \in L^{2}$, for $\widetilde{v}:=v w_{\theta / 2} \in L_{-\theta}^{2}, \widetilde{\psi}=\psi w_{-\theta / 2} \in L_{\theta}^{2}$. This observation permits the identification of $\left(L_{\theta}^{2}\right)^{\prime}$ with $L_{-\theta}^{2}$ (and hence, $\langle\cdot, \cdot\rangle_{\left(L_{\theta}^{2}\right)^{\prime} \times L_{\theta}^{2}}$ with $\left.\langle\cdot, \cdot\rangle_{L^{2}}=\langle\cdot, \cdot\rangle\right)$. Now, since $H_{\theta}^{r} \rightarrow L_{\theta}^{2}$ is dense, we have a dense injection $\left(L_{\theta}^{2}\right)^{\prime} \rightarrow H_{\theta}^{-r}$. With the identification $\left(L_{\theta}^{2}\right)^{\prime} \approx L_{-\theta}^{2}$, we obtain, for all $u \in L_{-\theta}^{2} \subset H_{\theta}^{-r}$ and all $f \in H_{\theta}^{r}$,

$$
\langle u, f\rangle_{H_{\theta}^{-r} \times H_{\theta}^{r}}=\langle u, f\rangle .
$$

Remark in particular that if $u \in L_{-\theta}^{2}$, then for all $f \in H_{\theta}^{r+1}$ we have

$$
\begin{equation*}
\left|\left\langle\partial_{x_{i}} u, f\right\rangle\right|=\left|-\left\langle u, \partial_{x_{i}} f\right\rangle\right| \leqslant C\|u\|_{H_{\theta}^{-r}}\|f\|_{H_{\theta}^{r+1}} \tag{A.42}
\end{equation*}
$$

so that if $u \in H_{\theta}^{-r}$ then $\nabla u \in H_{\theta}^{-(r+1)}$ with

$$
\begin{equation*}
\|\nabla u\|_{H_{\theta}^{-(r+1)}} \leqslant C\|u\|_{H_{\theta}^{-r}} . \tag{A.43}
\end{equation*}
$$

With this structure, since $L_{\theta}^{2}$ is reflexive the closure of $\mathcal{L}_{\theta^{\prime}}$, seen as an operator on $\left(L_{\theta}^{2}\right)^{\prime}$, is the adjoint of $\mathcal{L}_{\theta^{\prime}}^{*}([25]$, Th. 5.29) and is thus sectorial and defines an analytical semigroup $e^{t \mathcal{L}_{\theta^{\prime}}}$ in $H_{\theta}^{-r}$. In the same way, since $H_{\theta}^{r}$ is reflexive, the adjoint of $e^{t \mathcal{L}_{\theta^{\prime}}^{*}}$ seen as an operator on $H_{\theta}^{r}$ is $e^{t \mathcal{L}_{\theta^{\prime}}}$ seen as an operator on $H_{\theta}^{-r}$ ([32], Cor. 10.6).

From Proposition A. 2 and the structure described above we deduce directly the following estimates for the semi-group induced by $\mathcal{L}_{\theta^{\prime}}\left(\right.$ recall (1.20)) in $H_{\theta}^{-r}$ and $t>0$.

Proposition A.3. For all $0<\theta \leqslant \theta^{\prime}$ the operator $\mathcal{L}_{\theta^{\prime}}$ is sectorial and generates an analytical semi-group in $H_{\theta}^{-r}$. Moreover we have the following estimates: for any $r \geqslant 0$, $\alpha \geqslant 0$ and $\lambda<\theta \min \left(k_{1}, \ldots, k_{d}\right)$ there exists a constant $C>0$ such that for all $u \in$ $H_{\theta}^{-(r+\alpha)}$,

$$
\begin{equation*}
\left\|e^{t \mathcal{L}_{\theta^{\prime}} u}\right\|_{H_{\theta}^{-r}} \leqslant C\left(1+t^{-\alpha / 2} e^{-\lambda t}\right)\|u\|_{H_{\theta}^{-(r+\alpha)}} \tag{A.44}
\end{equation*}
$$

and for all $r \geqslant 1$,

$$
\begin{equation*}
\left\|e^{t \mathcal{L}_{\theta^{\prime}}} \nabla u\right\|_{H_{\theta}^{-r}} \leqslant C t^{-\frac{1}{2}} e^{-\lambda t}\|u\|_{H_{\theta}^{-r}} \tag{A.45}
\end{equation*}
$$

Moreover for all $r \geqslant 0,0<\varepsilon \leqslant 1$ and $s \geqslant 0$,

$$
\begin{equation*}
\left\|\left(e^{(t+s) \mathcal{L}_{\theta^{\prime}}}-e^{t \mathcal{L}_{\theta^{\prime}}}\right) u\right\|_{H_{\theta}^{-r}} \leqslant C s^{\varepsilon} t^{-\frac{1}{2}-\varepsilon} e^{-\lambda t}\|u\|_{H_{\theta}^{-(r+1)}} . \tag{A.46}
\end{equation*}
$$

Finally, there exist $r_{0}>0, C>0$ such that for any $0<\theta \leqslant \theta^{\prime}$, for all $r>r_{0}, t>0$ and all $u \in H_{\theta}^{-r}$ satisfying $\int u=0$,

$$
\begin{equation*}
\left\|e^{t \mathcal{L}_{\theta^{\prime}}} u\right\|_{H_{\theta}^{-r}} \leqslant C e^{-\lambda t}\|u\|_{H_{\theta}^{-r}} \tag{A.47}
\end{equation*}
$$

Proof of Proposition A.3. The spectral structure of $\mathcal{L}_{\theta^{\prime}}$ follows directly from the one of $\mathcal{L}_{\theta^{\prime}}^{*}$. To prove the first estimate of the proposition it is now sufficient to remark that for all $f \in H_{\theta}^{r}, u \in L_{-\theta}^{2}$,

$$
\left|\left\langle e^{t \mathcal{L}_{\theta^{\prime}}} u, f\right\rangle\right|=\left|\left\langle u, e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f\right\rangle\right| \leqslant C\left(1+t^{-\alpha / 2} e^{-\lambda t}\right)\|f\|_{H_{\theta}^{r}}\|u\|_{H_{\theta}^{-(r+\alpha)}} .
$$

For the second point,

$$
\left|\left\langle e^{t \mathcal{L}_{\theta^{\prime}}} \nabla u, f\right\rangle\right|=\left|\left\langle u, \nabla e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f\right\rangle\right| \leqslant C t^{-\alpha / 2} e^{-\lambda t}\|f\|_{H_{\theta}^{r}}\|u\|_{H_{\theta}^{-(r+\alpha)}} .
$$

The third point follows from similar estimates. For the last point, remark that if $\langle u, 1\rangle=$ 0 ,

$$
\begin{align*}
\left|\left\langle e^{t \mathcal{L}_{\theta^{\prime}}} u, f\right\rangle\right|=\left|\left\langle u, e^{t \mathcal{L}_{\theta^{\prime}}^{*}} f\right\rangle\right|=\left|\left\langle u, e^{t \mathcal{L}_{\theta^{\prime}}^{*} f}-\frac{\int_{\mathbb{R}^{d}} e^{t \mathcal{L}_{\theta^{\prime}}^{*} f w_{\theta}}}{\int_{\mathbb{R}^{d}} w_{\theta}}\right\rangle\right| \\
\leqslant C t^{-\alpha / 2} e^{-\lambda t}\left\|f-\int f w_{\theta}\right\|_{H_{\theta}^{r}}\|u\|_{H_{\theta}^{-(r+\alpha)}} \tag{A.48}
\end{align*}
$$

and $\left\|f-\int f w_{\theta}\right\|_{H_{\theta}^{r}} \leqslant 2\|f\|_{H_{\theta}^{r}}$.

## Appendix B. Grönwall Lemma

Lemma B.1. Let $t \mapsto y_{t}$ be a nonnegative and continuous function on $[0, T)$ satisfying, for all $t \in[0, T)$ and some positive constants $c_{0}$ and $c_{1}$,

$$
\begin{equation*}
y_{t} \leqslant c_{0}+c_{1} \int_{0}^{t}\left(1+\frac{1}{\sqrt{t-s}}\right) y_{s} \mathrm{~d} s . \tag{B.1}
\end{equation*}
$$

Then for all $t \in[0, T), y_{t} \leqslant 2 c_{0} e^{\alpha t}$ with $\alpha=2 c_{1}+4 c_{1}^{2}\left(\Gamma\left(\frac{1}{2}\right)\right)^{2}$, where $\Gamma$ is the usual special function $\Gamma(r)=\int_{0}^{\infty} x^{r-1} e^{-x} d x$.

For the proof of this Lemma, see [20], Lemma 5.2.
Lemma B.2. Let $a, b, \lambda>0$ and $\phi$ a nonnegative measurable function on $[0,+\infty)$ such that $\phi$ is integrable on $[0,+\infty)$. Suppose that $t \geqslant 0 \mapsto u_{t}$ is a nonnegative function satisfying

$$
\begin{equation*}
u_{t} \leqslant a+b \int_{0}^{t}(1+\phi(t-s)) e^{-\lambda s} u_{s} \mathrm{~d} s \tag{B.2}
\end{equation*}
$$

Then, there exists some constant $C(b, \phi)>0$ such that

$$
\begin{equation*}
\sup _{t \geqslant 0} u_{t} \leqslant 2 a \exp \left(\frac{C(b, \phi)}{\lambda}\right) . \tag{B.3}
\end{equation*}
$$

Proof of Lemma B.2. Define $A=A(b, \phi) \geqslant 0$ such that $\int_{0}^{+\infty} \phi(u) \mathbf{1}_{\{\phi(u) \geqslant A\}} \mathrm{d} u \leqslant \frac{1}{2 b}$. Then, for all $v \leqslant t$

$$
\begin{aligned}
u_{v} \leqslant & a+b \int_{0}^{v} e^{-\lambda s} u_{s} \mathrm{~d} s+b \int_{0}^{v} \phi(v-s) \mathbf{1}_{\{\phi(v-s) \geqslant A\}} e^{-\lambda s} u_{s} \mathrm{~d} s \\
& +b \int_{0}^{v} \phi(v-s) \mathbf{1}_{\{\phi(v-s) \leqslant A\}} e^{-\lambda s} u_{s} \mathrm{~d} s, \\
\leqslant & a+b \int_{0}^{v} e^{-\lambda s} u_{s} \mathrm{~d} s+b \sup _{s \leqslant v} u_{s} \int_{0}^{v} \phi(v-s) \mathbf{1}_{\{\phi(v-s) \geqslant A\}} \mathrm{d} s+b A \int_{0}^{v} e^{-\lambda s} u_{s} \mathrm{~d} s, \\
\leqslant & a+b(1+A) \int_{0}^{v} e^{-\lambda s} u_{s} \mathrm{~d} s+\frac{1}{2} u_{v}^{*} \leqslant a+b(1+A) \int_{0}^{t} e^{-\lambda s} u_{s}^{*} \mathrm{~d} s+\frac{1}{2} u_{t}^{*},
\end{aligned}
$$

where we have defined $u^{*}(s):=\sup _{r \leqslant s} u_{r}$. Since the last inequality is true for all $v \leqslant t$, we get

$$
u_{t}^{*} \leqslant 2 a+2 b(1+A) \int_{0}^{t} e^{-\lambda s} u_{s}^{*} \mathrm{~d} s
$$

The usual Grönwall lemma applied to $t \mapsto u_{t}^{*}$ gives the conclusion, for $C(b, \phi)=2 b(1+$ $A(b, \phi)$ ).
