# An extension to the complex plane of the Riemann-Siegel Z function.

#### Abstract

The usual Riemann-Siegel $Z(t)$ is a real-valued function linked to the Riemann $\xi(s)$, for $\Re(s)=1 / 2$, by the equation $f(t) \times Z(t) \sim \xi(1 / 2+i t)$, where both terms are real. We show how to construct a complex function $Z(t, \epsilon)$, which is linked to $\xi(s)=\xi(1 / 2+\epsilon+i t)$ through an equation of the type $e^{-i \pi \epsilon / 4} F(t) \times Z(t, \epsilon) \sim \xi(1 / 2+\epsilon+i t)$, where $F(t)$ is a real scaling factor like $f(t)$ and $\epsilon$ is the distance from the line $\Re(s)=1 / 2$. The functions $Z(t, \epsilon)$ and $\xi(1 / 2+\epsilon+i t)$ are complex valued and we obtain a scaled representation of $\xi(s)$ with errors not greater than the Riemann-Siegel $Z(t)$ not only on the critical line but at least in the whole critical strip.

## 1 Introduction

In 1859 Bernhard Riemann in an outstanding paper [9] [3, p. 299] [1] suggested that the non-trivial zeros of the analytic continuation of the function:

$$
\begin{equation*}
\zeta(s)=\sum_{n=1}^{\infty} 1 / n^{s} \quad \Re(s)>1 \tag{1.1}
\end{equation*}
$$

to the so-called critical strip $0<\Re(s)<1$ must all lie on the line $\Re(s)=1 / 2$ (the critical line). The complex argument $s$ is expressed throughout as:

$$
\begin{equation*}
s=\frac{1}{2}+\epsilon+i t \tag{1.2}
\end{equation*}
$$

so that $\epsilon$ is the distance from critical line parallel to the real axis and $t$ is the imaginary coordinate. Until now, this conjecture has remained unproven, and is referred to as the Riemann Hypothesis (RH) [1]. A key finding in this effort has been the introduction of the function $\xi(s)$ [9] [3, p. 16], that is real on the critical line and has the same zeros of $\zeta(s)$ in the critical strip:

$$
\begin{equation*}
\xi(s)=\Gamma\left(\frac{s}{2}+1\right)(s-1) \pi^{-s / 2} \zeta(s) . \tag{1.3}
\end{equation*}
$$

In 1932 C. L. Siegel crucially succeeded in mastering the information contained in Riemann's private notes about the values of the $\xi$ function on the critical line [3, p. 136] [5, p. 3]. His main result was the approximate formula:

$$
\begin{equation*}
Z(t)=2 \sum_{n=1}^{n=N} \frac{\cos \left(t \ln \left(\sqrt{\frac{t}{2 e \pi n^{2}}}\right)-\frac{\pi}{8}\right)}{\sqrt{n}}+R_{0}(t) \sim-\frac{\xi\left(\frac{1}{2}+i t\right)}{f(t)} \quad ; \quad N=\left\lfloor\sqrt{\frac{t}{2 \pi}},\right\rfloor \tag{1.4}
\end{equation*}
$$

where $\sim$ means asymptotically equal for $t \rightarrow \infty$ and $f(t)$ is the scale factor used in [3, p. 176], reported in eq. (3.33). Equation (1.4) has been the core of large scale computations of the zeros of $\zeta(s)$ as described in [4] and [5, p. 4].

The purpose of this paper is to develop an extension of the Riemann-Siegel function (1.4) that provides a means of expressing $\xi\left(\frac{1}{2}+\epsilon+i t\right)$ at least for $-1<\epsilon<1$ using a scale factor defined in eq. (3.31):

$$
F(t)=(\pi / 2)^{0.25} t^{\frac{7}{4}} e^{-\frac{\pi}{4} t}
$$

and hyperbolic functions. For ease of reading, we present our final result, given in eq. 4.8):

$$
\begin{align*}
& Z(t, \epsilon)=2 \sum_{n=1}^{N} \frac{\cosh \left[\epsilon \ln \left(\sqrt{\frac{t}{2 \pi n^{2}}}\right)\right]}{\sqrt{n}} \cos \left(t \ln \left(\sqrt{\frac{t}{2 e \pi n^{2}}}\right)-\frac{\pi}{8}\right)+  \tag{1.5}\\
& +2 i \sum_{n=1}^{N} \frac{\sinh \left[\epsilon \ln \left(\sqrt{\frac{t}{2 \pi n^{2}}}\right)\right]}{\sqrt{n}} \sin \left(t \ln \left(\sqrt{\frac{t}{2 e \pi n^{2}}}\right)-\frac{\pi}{8}\right)+R_{1}(t, \epsilon) \sim \frac{-\xi(1 / 2+\epsilon+i t)}{F(t) e^{i \epsilon \frac{\pi}{4}}}
\end{align*}
$$

where, as above, $N=\left\lfloor\sqrt{\frac{t}{2 \pi}}\right\rfloor$ and $R_{1}(t)$ is given by eq. 4.4 specialized for $M=1$ :

$$
\begin{equation*}
R_{1}(t, \epsilon)=(-1)^{N-1}\left(\frac{2 \pi}{t}\right)^{1 / 4}\left[C_{0}(p)+C_{1}(p, \epsilon)\left(\frac{2 \pi}{t}\right)^{1 / 2}\right] \quad ; \quad p=\sqrt{\frac{t}{2 \pi}}-N \tag{1.6}
\end{equation*}
$$

where $C_{0}(p)=\cos \left(2 \pi\left(p^{2}-p-1 / 16\right) / \cos (2 \pi p)\right.$. Using $C_{1}(p, \epsilon)$ the Z function given in eq. (1.5) is almost holomorphic for $t \gg 1$ and small $\left|\frac{\epsilon}{t}\right|$, as shown in eq. (4.13). From a computational point of view it can be meaningful to use eq. (1.5) with only $C_{0}(p)$, that is disregarding $C_{1}(p, \epsilon)$, since the errors of 1.5 with $R_{0}(t)$ are not higher than the errors of the original Riemann-Siegel (1.4), as shown in Figure 3.

We report in tables 1 and 2 the result of a numerical comparison with Wolfram Mathematica RiemannSiegelZ function, referred to as $Z_{M}(t-i \epsilon)$, evaluated in same points outside critical line. The modulus of the difference decreases as $t$ increases, but our result in eq. (1.5) is usable also for very large values of $t$ where the Mathematica computation fails.

Using (4.8) it is easy, for example, to compute points of a topographical surface defined by $\Re\left[e^{i \epsilon \frac{\pi}{4}} Z(t, \epsilon)\right]$ above the $(t, \epsilon)$ plane, or to plot in the $(t, \epsilon)$ plane the zero-height points (i.e $(t, \epsilon)$ : $\left.\Re\left[e^{i \epsilon \frac{\pi}{4}} Z(t, \epsilon)\right]=0\right)$. The same can be done with $\Im\left[e^{i \epsilon \frac{\pi}{4}} Z(t, \epsilon)\right]$; see Figures 1 and 2 . In fact the real or imaginary zero-condition computed for $e^{i \epsilon \frac{\pi}{4}} Z(t, \epsilon)$, applies to $\xi\left(\frac{1}{2}+\epsilon+i t\right)$ as well. The original reason of the present work was precisely to plot such curves for the $\xi$ function, as is done for the $\zeta$ function in [2, p. 342].

Figure 1: The points of $\Im[Z(t, \epsilon)]=0$ and $\Re[Z(t, \epsilon)]=0$ are computed on equispaced lines at constant $t=\Delta t \times m: m=1,2,3 \ldots$. At the intersection between the curve $\Im[\xi(t, \epsilon)] \sim$ $\Im[Z(t, \epsilon)]=0$ with the critical line, at $\epsilon=0$, the conformality of the $\xi(t, \epsilon)$, seen as a complex transformation, is lost. These points are extremal points for the amplitude of $\xi(1 / 2+i t)$. At low $t$ values this is not true for $Z(t, \epsilon)$ because of the distorting effect of the scale factor $F(t)$. Note the first seven zeros at $t=14.13 \ldots ; 21.02 \ldots ; 25.01 \ldots ; 30.42 \ldots ; 32.93 \ldots \ldots ; 37.58 \ldots ; 40.91 \ldots$.


Figure 2: See [3, p. 176] and [5, p. 6] . First Lehemer phenomenon is at $t \approx 7005$. Note the much simpler plot of $\Re[\xi]=0$ and $\Im[\xi]=0$ curves with respect to the plot of $\Re[\zeta]=0$ and $\Im[\zeta]=0$ curves in $(t, \epsilon)$ plane shown in [2, p. 342].

## 2 Starting point

In [9] [3, p. 137] a contour integral is given for $\zeta(s), s \neq 1, s \in \mathbb{C}$ :

$$
\begin{equation*}
\zeta(s)=\frac{\Gamma(1-s)}{2 \pi i} \int_{C} \frac{(-x)^{s} d x}{\left(e^{x}-1\right) x} \tag{2.1}
\end{equation*}
$$

where $C$ is the contour described in the positive sense starting at $+\infty$, encircling the origin and returning to $+\infty$ without crossing the positive real axis. Afterwards this path $C$ is deformed continuously in $C_{N}$, encircling $2 \mathrm{~N}+1$ poles of the integral in eq. (2.1). Evaluating the integral and putting the result in the definition of $\xi(s)$ in eq. (1.3), one finds (see [3, p. 138], [7, p. 20]):

$$
\begin{align*}
-\xi(s) & =(1-s) \Gamma\left(\frac{s}{2}+1\right) \pi^{\frac{-s}{2}}\left(\sum_{n=1}^{n=N} n^{-s}\right)+(+s) \Gamma\left(\frac{1-s}{2}+1\right) \pi^{-\frac{1-s}{2}}\left(\sum_{n=1}^{n=N} n^{-(1-s)}\right)+ \\
& +\frac{(+s) \Gamma\left(\frac{1-s}{2}+1\right) \pi^{\frac{-(1-s)}{2}}}{(2 \pi)^{s-1} 2 \sin (\pi s / 2) 2 \pi i} \int_{C_{N}} \frac{(-x)^{s-1} e^{-N x} d x}{e^{x}-1} \tag{2.2}
\end{align*}
$$

where the sign has been changed for later convenience and:

$$
\begin{equation*}
N=\left\lfloor\sqrt{\frac{t}{2 \pi}}\right\rfloor . \tag{2.3}
\end{equation*}
$$

We now denote by $L_{N}$ is the usual broken line whose path segments $L_{0}, L_{1}, L_{2}$ and $L_{3}$ are defined in [3, p. 138] [7, p. 20] in order to apply the steepest descent method. In Appendix B it is shown that the dominant contribution to the integral in (2.2) comes from $L_{1}$ which extends from $a+\frac{1}{2} e^{i \frac{\pi}{4}|a|}$ to $a-\frac{1}{2} e^{i \frac{\pi}{4}|a|}$, see B.1) and B.17), where:

$$
\begin{equation*}
a=i \sqrt{2 \pi t} \tag{2.4}
\end{equation*}
$$

is the saddle point for the evaluation of main integral in (2.2), see Appendix A for the details. We also use the notation of [3, p. 139], where:

$$
e^{\phi(x)}=(-x)^{s-1} e^{-N x}
$$

The saddle point occurs when $\phi^{\prime}(x)=0$ with $\phi(x)=\Re[(s-1) \ln (-x)-N x]$ to yield:

$$
\begin{equation*}
\alpha=\frac{-\frac{1}{2}+i t}{N} \approx \frac{-\frac{1}{2}+i t}{\sqrt{\frac{t}{2 \pi}}} \approx 2 \pi i N \approx i \sqrt{2 \pi t}=a \quad \text { for } \quad t \gg 1 \tag{2.5}
\end{equation*}
$$

so that $a$ in (2.4), is an approximation for the value $\alpha$ used in [3, p. 140]. Notice that in (2.5), $N$ comes from the numerator in $\frac{-\frac{1}{2}+i t}{N}$, while in $2 \pi i N$ it comes from intergrand denominator (i.e. $\left.e^{x}-1\right)$.

Nothing changes in the saddle point integral evaluation procedure with the replacement:

$$
-\frac{1}{2}+i t \quad \rightarrow \quad-\frac{1}{2}+\epsilon+i t \quad \text { with } 0<\epsilon<1
$$

as shown in Appendix A. Notice that for $\epsilon=\frac{1}{2}$ the approximation 2.5 becomes exact and we have $\alpha=a$.

We now make use of the Stirling series [8, p. 30] that allows us to write:

$$
\begin{equation*}
\ln (\Gamma(z+1))=\ln \left(e^{-z} z^{z+\frac{1}{2}}(2 \pi)^{\frac{1}{2}}\right)+\left(\sum_{k=1}^{K-1} \frac{B_{2 k}}{2 k(2 k-1) z^{2 k-1}}\right)+R_{2 K}(z) \tag{2.6}
\end{equation*}
$$

Although the expression (2.6) is a non-convergent asymptotic expansion, it can be used to estimate the size of the error $\left|R_{K}(z)\right|$ 3, p. 112]. The $B_{i}$ are the Bernoulli numbers that vanish for odd $i$ while (see for example [6, p. 114]):

$$
B_{2}=\frac{1}{6} \quad ; \quad B_{4}=-\frac{1}{30} \quad ; \quad B_{6}=\frac{1}{42} \quad ; \quad B_{8}=-\frac{1}{30} \quad ; \quad B_{10}=\frac{5}{66} \quad ; \quad B_{12}=-\frac{691}{2730} \quad \ldots
$$

The modulus of the error term $\left|R_{2 K}(z)\right|$ is bounded by:

$$
\begin{equation*}
\left|R_{2 K}(z)\right|<\left(\frac{B_{2 K}}{2 K(2 k-1) z^{2 K-1}}\right) \frac{1}{\left[\cos \left(\frac{\arg (z)}{2}\right)\right]^{2 K}} \tag{2.7}
\end{equation*}
$$

where $\arg (z)$ is taken in the interval: $-\pi<\arg (z)<\pi$ (see [3, p. 112] and theorem 2.3 in [8, p. 40] due to Stieltjes).

## 3 Splitting in simple pieces

To evaluate the expression in $(2.2)$ it is convenient to rewrite $s$ in terms of the variable $z$ defined by:

$$
\begin{equation*}
z=\frac{s}{2}=\frac{1+2 \epsilon}{4}+\frac{i t}{2} \tag{3.1}
\end{equation*}
$$

in the first sum, so that we have:

$$
\pi^{\frac{-s}{2}}(1-s)=\pi^{-z}(1-2 z)
$$

while in the second sum and in the third term we use:

$$
\begin{equation*}
z=\frac{1-s}{2}=\frac{1-2 \epsilon}{4}-\frac{i t}{2} \tag{3.2}
\end{equation*}
$$

so that:

$$
\pi^{\frac{-(1-s)}{2}}(+s)=\pi^{-z}(1-2 z)
$$

In order to manage the computation and also to exploit intermediate results, it has been devised the notation $A_{p}^{s}$ where:
" A " can be: $A=\Re$ or $A=\Im)$,
" $\mathrm{s}=+$ " means substitution (3.1) while " $\mathrm{s}=-$ " means substitution (3.2).
" p " is for part ( $\mathrm{p}=1,2$ or 3 )
Part 1 (i.e $\Re_{1}^{ \pm}$or $\Im_{1}^{ \pm}$) is the asymptotic part (as $t \rightarrow \infty$ ) of $\ln \left(e^{-z} z^{z+\frac{1}{2}}(2 \pi)^{\frac{1}{2}}\right)$

Part 2 ( i.e $\Re_{2}^{ \pm}$or $\Im_{2}^{ \pm}$) refers always to $\ln \left(e^{-z} z^{z+\frac{1}{2}}(2 \pi)^{\frac{1}{2}}\right)$, but as $t \rightarrow \infty$ goes to zero Part 3 (i.e $\Re_{3}^{ \pm}$or $\Im_{3}^{ \pm}$) refers to:

$$
\begin{equation*}
\left(\sum_{k=1}^{K-1} \frac{B_{2 k}}{2 k(2 k-1) z^{2 k-1}}\right) \tag{3.3}
\end{equation*}
$$

For example for $K=3$, setting $\arg (z) \approx \frac{\pi}{2}$ and $B_{2 K}=1 / 42$ as first erased term in (2.6), the error $\left|R_{2 K}(z)\right|$ is bounded by (2.7) and using (3.1) and (3.2) we have, for the error term:

$$
\begin{align*}
\left|R_{2 K}(z)^{ \pm}\right| & =\left|R e_{\text {error }}^{ \pm}+i \quad I m_{\text {error }}^{ \pm}\right|=\left|R_{6}\left(\frac{1 / 2 \pm \epsilon \pm i t}{2}\right)\right|  \tag{3.4}\\
& <\left|\frac{B_{6}}{6 * 5 *\left(\frac{1 / 2 \pm \epsilon \pm i t}{2}\right)^{5} * \cos \left(\arg \left(\frac{1 / 2 \pm \epsilon \pm i t}{2}\right)\right)^{6}}\right|<\left|\frac{1}{157\left(\frac{1 / 2 \pm \epsilon \pm i t}{2}\right)^{5}}\right| \\
& \leq\left|\frac{1}{4.9 t^{5}}\right|
\end{align*}
$$

It is possible to improve the precision by increasing $K$ but, as we will see in the following, if we content ourselves with an error $<t^{-1}$ then we can completely ignore the Bernoulli sum in 2.6.

### 3.1 First substitution

If we take the first case (3.1), to be used in first sum of (2.2), we have for (2.6):

$$
\begin{gather*}
\ln \left(e^{-z} z^{z+\frac{1}{2}}(2 \pi)^{\frac{1}{2}} \pi^{-z}(1-2 z)\right)_{z=\frac{1+2 \epsilon}{4}+\frac{i t}{2}}=\Re_{1}^{+}+i \Im_{1}^{+}+\Re_{2}^{+}+i \Im_{2}^{+} \\
=\left(\frac{3+2 \epsilon}{4}+\frac{i t}{2}\right)\left[\ln \sqrt{\left(\frac{1+2 \epsilon}{4}\right)^{2}+\frac{t^{2}}{4}}+i \quad \arctan \left(\frac{2 t}{1+2 \epsilon}\right)\right]- \\
-\left(\frac{1+2 \epsilon}{4}+\frac{i t}{2}\right)+\frac{\ln (2 \pi)}{2}-\frac{\frac{1}{2}+\epsilon+i t}{2} \ln (\pi)+\ln \sqrt{\left(\epsilon-\frac{1}{2}\right)^{2}+t^{2}}+i \quad \arctan \left(\frac{-t}{+1 / 2-\epsilon}\right) \tag{3.5}
\end{gather*}
$$

We have :
$\arctan \left(\frac{-t}{+1 / 2-\epsilon}\right)=-\frac{\pi}{2}+\arctan \left(\frac{1-2 \epsilon}{2 t}\right) \quad$ and $\quad \arctan \left(\frac{2 t}{1+2 \epsilon}\right)=\frac{\pi}{2}-\arctan \left(\frac{1+2 \epsilon}{2 t}\right)$
so separating real part from imaginary part we have:

$$
\Re\left(\ln \left(e^{-z} z^{z+\frac{1}{2}}(2 \pi)^{\frac{1}{2}} \pi^{-z}(1-2 z)\right)_{z=\frac{1+2 \epsilon}{4}+\frac{i t}{2}}\right)=\Re_{1}^{+}+\Re_{2}^{+}=
$$

$$
\begin{gathered}
=\left(\frac{3+2 \epsilon}{4}\right)\left[\ln \left(\frac{t}{2}\right)+\frac{1}{2} \ln \left(1+\left(\frac{1+2 \epsilon}{2 t}\right)^{2}\right)\right]- \\
-\frac{t}{2}\left[\frac{\pi}{2}-\arctan \left(\frac{1+2 \epsilon}{2 t}\right)\right]-\left(\frac{1+2 \epsilon}{4}\right)+\frac{\ln (2 \pi)}{2}-\frac{\ln (\pi)(1+2 \epsilon)}{4}+\ln (t)+\frac{1}{2} \ln \left[1+\left(\frac{1-2 \epsilon}{2 t}\right)^{2}\right]
\end{gathered}
$$

For $t \gg \epsilon$ we have

$$
\begin{equation*}
-\frac{t}{2}\left[-\arctan \left(\frac{1+2 \epsilon}{2 t}\right)\right]=\frac{1+2 \epsilon}{4} \quad \frac{2 t}{1+2 \epsilon} \arctan \left(\frac{1+2 \epsilon}{2 t}\right) \quad \rightarrow \frac{1}{4}+\frac{\epsilon}{2} ; \quad t \rightarrow \infty \tag{3.7}
\end{equation*}
$$

And we can write the asymptotic part not leading to zero as:

$$
\begin{equation*}
-\frac{t}{2}\left[-\arctan \left(\frac{1+2 \epsilon}{2 t}\right)\right]=\frac{1+2 \epsilon}{4}\left[\frac{2 t}{1+2 \epsilon} \arctan \left(\frac{1+2 \epsilon}{2 t}\right)+1-1\right]=\frac{1+2 \epsilon}{4} \tag{3.8}
\end{equation*}
$$

And we put it in first piece $\Re_{1}^{+}$. While:

$$
\frac{1+2 \epsilon}{4}\left[\frac{2 t}{1+2 \epsilon} \arctan \left(\frac{1+2 \epsilon}{2 t}\right)-1\right]
$$

is put in second piece (i.e. $\Re_{2}^{+}$), because as $t \rightarrow \infty$ it goes to zero .
Using the notation $A_{p}^{s}$ we try afterward to put together all pieces.
$\Re_{2}^{+}+\Re_{3}^{+}$and $\Im_{2}^{-}+\Im_{3}^{-}$are developped in powers of $t^{-1}, t^{-2}, t^{-3} \ldots$ in subsection 3.14, see 3.25).

-\frac{\epsilon}{2}-\frac{\pi}{4} t+\ln (t)=\left(\frac{3}{4} L n\left(\frac{t}{2}\right)+\frac{\ln (2 \pi)}{2}-\frac{\ln (\pi)}{4}-\frac{\pi}{4} t+\ln (t)\right)+\ln \left(\sqrt{\frac{t}{2 \pi}}\right)^{\epsilon} \tag{3.9}
\end{gather*}

### 3.3 Computation of $\Re_{2}^{+}$

While $\Re_{2}^{+}$, second piece of Real part for first substitution (3.1), is:

\begin{gathered}
=\left(\frac{3+2 \epsilon}{4}\right)\left[\frac{1}{2}\left(\frac{1+2 \epsilon}{2 t}\right)^{2}-\frac{1}{4}\left(\frac{1+2 \epsilon}{2 t}\right)^{4}+\ldots\right]+\frac{1+2 \epsilon}{4}\left[1-\frac{1}{3}\left(\frac{1+2 \epsilon}{2 t}\right)^{2}-1+\ldots\right]+ \\
+\frac{1}{2}\left[\left(\frac{1-2 \epsilon}{2 t}\right)^{2}-\frac{1}{2}\left(\frac{1-2 \epsilon}{2 t}\right)^{4}+\ldots\right]=

Note that the most significant powers are $t^{-2}$ so that, up to the terms of order $t^{-2}$

+\left(\frac{3+2 \epsilon}{4}\right)\left[\frac{\pi}{2}-\arctan \left(\frac{1+2 \epsilon}{2 t}\right)\right]-\frac{t}{2}-\frac{t}{2} \ln (\pi)-\frac{\pi}{2}+\arctan \left(\frac{1-2 \epsilon}{2 t}\right) \tag{3.11}
\end{gather*}

For $t \gg \epsilon$

&=\frac{1+2 \epsilon}{12 t^{2}}-\ldots
\end{align*}

and imaginary part:

\Im_{3}^{+}\left(\text {only till } t^{-1} \text { terms }\right)=\Im\left(\sum_{k=1}^{K-1} \frac{B_{2 k}}{2 k(2 k-1) z^{2 k-1}}\right)_{z=\frac{1+2 \epsilon}{4}+\frac{i t}{2}} ; \quad K=3 \\
=-\frac{1}{6 t\left(1+\left(\frac{1+2 \epsilon}{2 t}\right)^{2}\right)}-\frac{1}{45 t^{3}\left(1+\left(\frac{1+2 \epsilon}{2 t}\right)^{2}\right)^{3}}+\frac{(1+2 \epsilon)^{2}}{60 t^{5}\left(1+\left(\frac{1+2 \epsilon}{2 t}\right)^{2}\right)^{3}}=  \tag{3.15}\\
=-\frac{1}{6 t}+\ldots
\end{gather*}

Second substitution (3.2) applies to second sum ant remainder (i.e. 3rd term) in (2.2) . So we have, likewise:

&-\left(\frac{1-2 \epsilon}{4}-\frac{i t}{2}\right)+\frac{\ln (2 \pi)}{2}- \\
&-\frac{\frac{1}{2}-\epsilon-i t}{2} \ln (\pi)+\ln \sqrt{\left(\epsilon+\frac{1}{2}\right)^{2}+t^{2}}+i \arctan \left(\frac{+t}{+1 / 2+\epsilon}\right)

+\frac{t}{2}\left[-\frac{\pi}{2}+\arctan \left(\frac{1-2 \epsilon}{2 t}\right)\right]-\left(\frac{1}{4}-\frac{\epsilon}{2}\right)+\frac{\ln (2 \pi)}{2}-\left(\frac{1}{2}-\epsilon\right) \frac{\ln (\pi)}{2}+ \\
+\ln (t)+\frac{1}{2} \ln \left(1+\left[\frac{1+2 \epsilon}{2 t}\right]^{2}\right)

For $t \gg \epsilon$ we have

&=\frac{1-2 \epsilon}{12 t^{2}}-\ldots

=-\frac{1}{6 t}+\ldots

In $\Im_{3}$ we coud include also the error whose we know only the bound ( 2.7 ).

Let us neglect now $\binom{\Re}{\Im}_{j}^{+}$and $\binom{\Re}{\Im}_{j}^{-}$with $j>1$, namely second and third piece.
It is useful to isolate real terms that depend only on $t$.

F(t)=\Re\left[(s-1) \Gamma\left(\frac{s}{2}+1\right) \pi^{-\frac{s}{2}}\right]_{\epsilon=0}=f(t)
$$

So $F(t)$ used here and $f(t)$ in in [3, p. 176] and in [5, p. 5] are the same.

Note that same scale factor $F(t)$, applies to 3.9 (i.e. $\Re_{1}^{+}$), as well as to 3.21 (i.e. $\Re_{1}^{-}$). Looking at the imaginary terms and we define :
For (3.12)

where $F(t)=(\pi / 2)^{0.25} t^{\frac{7}{4}} e^{-\frac{\pi}{4} t}$, see 3.31 .

. .+F(t) e^{i \frac{\pi}{4} \epsilon} A^{-}\left\{R(t, \epsilon)+\int_{L_{0}, L_{2}, L_{3}} \frac{(-x)^{s} e^{-N x} d x}{\left(e^{x}-1\right) x}-\gamma_{L-L_{1}}\right\} \tag{4.3}

Where $\gamma_{L-L_{1}}$ is evaluated in (B.9), and $R(t)$ is the quantity called R in (6) [3, p. 147] and [3, p. 154].

Here $R(t, \epsilon)$ is the same quantity computed in Appendix A also for $\epsilon \neq 0$.
The overall bound for $\int_{L_{0}, L_{2}, L_{3}}$ is shown in Appendix A, see (B.25) and fig. 3 .
Note however that (4.3) cannot be actually computed because of the errors in (4.2) and in (B.25), we only have an upper bound.
Note that $e^{-i \theta(t)}$, with the same meaning of (1) in [3, p. 120] (see also [3, p. 146] bottom) is just included in R; see in (6) [3, p. 139].
In [3, p. 154]], the remainder $R(t)$, of Riemann Siegel Z for $\epsilon=0$, is computed .
In Appendix A the coefficients $C_{n}(p, \epsilon)$ for $\epsilon>0$ are generalized.

Note that $Z(t, \epsilon) e^{i \frac{\pi}{4} \epsilon}$ has "almost " the same phase of $-\xi\left(\frac{1}{2}+\epsilon+i t\right)$.
So now it is clear why we changed the sign in (2.2) with respect to (5) [3, p. 138].
This choice is congruent with $\theta(t)$ in [3, p. 119-120] where $\theta(t)$ is developped in powers of $1 / t$ and $(1 / t)^{3}$.

as $\omega=\sqrt{\frac{2 \pi}{t}}$; see A.21.
As $\psi^{(1)}(p)=\frac{\partial C_{0}(p)}{\partial p}$; see (A.28). Besides $\frac{\partial\left[\psi^{(3)} \omega\right]}{\partial t} \ll_{t \gg 1} \frac{\partial C_{0}(p)}{\partial p} \frac{1}{2 \sqrt{2 \pi t}}$.
So taking only $C_{1}(p, \epsilon)$, after $C_{0}(p)$, in (4.4):

Note that the second of ( 4.9 ) is identically zero for $\epsilon \rightarrow 0$.
With reminder $R_{1}(t, \epsilon)$ which uses (4.4) with only $C_{0}(p)$, and , $C_{1}(p, \epsilon)$, we can then say that (4.8) , for $t \gg 1$ and for small $\left|\frac{\epsilon}{t}\right|$, is almost holomorphic as the RiemanCauchy (4.9) holds only with small discrepancies that tend to zero as $t \rightarrow \infty$.

## A Main integral in 2.2 along path $L_{1}$ with offset from critical line ( $\epsilon>0$ )

The aim of this appendix is to compute the main integral A.2) following the same logical path of [3, p. 138-155] with the only addition of $\epsilon \neq 0$.
First footnote in [3, p. 138] suggests exactly this. A brief summary shows the path to follow.

## A. 1 Summary of logical path

Let us summarize the logical path of the following evaluation.

- To ignore the integral contribution on $L_{0}, L_{2}, L_{3}$; see A.5).
- To develop $(-x)^{\epsilon-1 / 2+i t} e^{-N x}$ as a power series centered at $a=i \sqrt{2 \pi t}$; see A.9.
- To use a "matching factor" A.11 (rewritten here for easy reading)

to compute the $b_{n}(\omega, \epsilon)$ for a perfect matching of all like powers of $\omega=\sqrt{\frac{2 \pi}{t}}$ obtained by iteration A.23); see also A.22).

- To expand the expression obtained by the matching (i.e. $\sum_{n=0}^{n=\infty} b_{n}(x-a)^{n}$ ), on all $L_{1}$ line, irrespective of the radius of convergence of the power series centered in $a=i \sqrt{2 \pi t}$ A.20) by a wise contour integration [3, p. 147-148] due to Riemann.
This allows us to compute exactly, on complex plane $u=x-2 \pi N i$ [3, p. 147-148], the main integral for $b_{0}$ i.e. $C_{0}(p)=\psi^{(0)}(p)$ A.20. In order to compute $C_{n}(p, \epsilon)$ by formula A.25) we need till $b_{3 n}$ see (A.29).
- through A.29) all pieces are joined to compute $C_{i}(p, \epsilon)$ of (4.4).
- The computation has been actually carried on only for $i=1,2$; see A.30) and A.34.

- From $3.36(+s) \Gamma\left(\frac{1-s}{2}+1\right) \pi^{\frac{-(1-s)}{2}} \approx e^{\Re-+i \Im_{1}^{-}}=F(t) e^{i \frac{\pi}{4} \epsilon} e^{-i \theta_{1}(t)}\left(\sqrt{\frac{2 \pi}{t}}\right)^{\epsilon}$.
- The (-1) factor at the integrand numerator stems for the gathering of $x$, , under $(s-1)$ exponent: $\frac{(-x)^{s} d x}{\left(e^{x}-1\right) x}=\frac{(-1)(-x)^{s-1} d x}{e^{x}-1}$.
- This $(-1)$ at numerator integrand is, afterward, joined to $2 i \sin (\pi s / 2)$ development [3, p. 139] in the denominator of external coefficient:

Besides we have to take into account (B.14) which lowers further the contributions at right. Instead spurious contribution at left are multiplied by $\approx 2$, but , distance from $\operatorname{Boundary}\left(L_{1}, L_{2}\right)$, in worst case $(p=0)$, is, for $t>20:|a|=\sqrt{2 \pi t} \approx \sqrt{t} \times \sigma>4.472 \sigma$. With (B.10) we can appreciate the corresponding $\frac{\Delta R}{R}$ in B.25 and compare with data in fig. 3 .

\arctan \left(\frac{\pi(2 N+1)}{b}\right) \approx \arctan \left(\frac{\pi\left(2 \sqrt{\frac{t}{2 \pi}}+1\right)}{\frac{\sqrt{t 2 \pi}}{r}}\right)>\frac{\pi}{4}
$$

because $|b|=\frac{\sqrt{t \pi}}{r}$ and:

\frac{\pi\left(2 \sqrt{\frac{t}{2 \pi}}+1\right)}{\frac{\sqrt{t 2 \pi}}{r}}=\frac{r}{\sqrt{t \pi}}(\sqrt{2 t \pi}+\pi)=r\left(\sqrt{(2)}+\sqrt{\frac{\pi}{t}}\right)>1 \quad ; \text { because } \quad 1<r \leq 2
$$

So

\left|(-x)^{i t}\right|<e^{-t \frac{\pi}{4}} \tag{B.22}
\end{equation*}
$$

So the module of A.2 on $L_{3} \quad(t>10)$, putting $u=\Re(x)$ and taking off $F(t)$ factor, for B.22 is less then:

= & \left(\frac{\sqrt{2 \pi t}+\pi}{\sqrt{2 \pi t}}\right)^{\epsilon} \frac{e^{-3 t \pi / 4}}{\sqrt{2} \pi \sqrt{2 N+1}} \frac{e^{t /(\sqrt{2} r)}}{N}<\left(\frac{\sqrt{2 \pi t}+\pi}{\sqrt{2 \pi t}}\right)^{\epsilon} \frac{e^{-t}}{\sqrt{\pi t}} \tag{B.23}
\end{align*}

because

\forall t>10 \quad\left(e^{-i \frac{\pi}{2} \epsilon}-i e^{i \frac{\pi}{2} \epsilon} e^{-t \pi}\right) \approx e^{-i \frac{\pi}{2} \epsilon}
$$

And considering that

\left|\frac{e^{i \frac{\pi}{4} \epsilon} e^{-i \theta_{1}(t)}}{(2 \pi)^{+i t} e^{-i \frac{\pi}{4}} e^{-i \frac{\pi}{2} \epsilon}}\right|=1
$$

then we have:

\left|\frac{e^{i \frac{\pi}{4} \epsilon} e^{-\pi t / 2} e^{-i \theta_{1}(t)}}{(2 \pi)^{\frac{1}{2}+\epsilon+i t}\left(e^{-i \frac{\pi}{2} \epsilon}-i e^{i \frac{\pi}{2} \epsilon} e^{-t \pi}\right) e^{-i \frac{\pi}{4}}}\left(\sqrt{\frac{2 \pi}{t}}\right)^{\epsilon}\right|=\frac{e^{-\pi t / 2}}{(2 \pi)^{\frac{1}{2}+\epsilon}}\left(\sqrt{\frac{2 \pi}{t}}\right)^{\epsilon}=\left[\left(\frac{1}{2 \pi t}\right)^{\epsilon / 2} \frac{e^{-t \pi / 2}}{\sqrt{2 \pi}}\right]
$$

While, for B. 22 and B.21:

\left|\int_{L_{3}} \frac{(-x)^{-\frac{1}{2}+\epsilon+i t} e^{-N x} d x}{e^{x}-1}\right|<e^{-t \pi / 4}[(2 N+1) \pi]^{\epsilon-1 / 2} \int_{-b}^{\infty} e^{-N u} d u
$$

besides:

N[-(-b)] \approx \sqrt{\frac{t}{2 \pi}} \frac{\sqrt{t \pi}}{r}=\frac{t}{\sqrt{2} r} \tag{B.24}
\end{equation*}
$$

and:

-3 t \pi / 4+t /(\sqrt{2} r)=t\left(-\frac{3 \pi}{4}+\frac{1}{\sqrt{2} r}\right) \ll-t
$$

Note that upper bound on $L_{3}$ B. 23 e $e^{-t}$ increases with $\epsilon$ but it is irrelevant in front of B.8, and B.20, see fig 3.

## B. 5 Conclusions on Upperbounds

Upper bounds can be summed up and compared with minimum value of $R_{0}(t)$ (i.e. when $p=0.5$, see (4.5) and (4.6) ).
Summarizig results we have:
(B.8) (i.e. A.2 along $L_{0}$ upperbound ) is decreasing if $\epsilon$ grows. $K_{0}(r)$ is defined in B. 4

\frac{\int_{L_{0}} \frac{(-x)^{s-1} e^{-N x} d x}{e^{x}-1}}{R_{0}(t)_{p=0.5}}<\frac{\frac{2 \sqrt{2} K_{0}(r) t}{[\sqrt{2 \pi}]^{(1+e) / 2} \sqrt{\sqrt{2 \pi t}}}}{R_{0}(t)_{p=0.5}}=\text { UpperBound } L_{L_{0}}(t)
$$

B. 20 (i.e. A. 2 along $L_{2}$ upperbound) is decreasing if $\epsilon$ grows. $K_{2}(r)$ is defined in B.19.

$$
\frac{\int_{L_{2}} \frac{(-x)^{s-1} e^{-N x} d x}{e^{x}-1}}{R_{0}(t)_{p=0.5}}<\frac{\left(\frac{1}{r \sqrt{2}}\right)^{\epsilon} e^{K_{2}(r) t} 2 \sqrt{r}(t / \pi)^{\frac{1}{4}}}{R_{0}(t)_{p=0.5}}=\text { UpperBound }_{L_{2}}(t)
$$

B. 23 (i.e. A. 2 along $L_{3}$ upperbound) increases with $\epsilon$ but the factor $e^{-t}$ cancel the contribution .

$$
\frac{\int_{L_{3}} \frac{(-x)^{s-1} e^{-N x} d x}{e^{x}-1}}{R_{0}(t)_{p=0.5}}<\frac{\left(\frac{\sqrt{2 \pi t}+\pi}{\sqrt{2 \pi t}}\right)^{\epsilon} \frac{e^{-t}}{\sqrt{\pi t}}}{R_{0}(t)_{p=0.5}}=\text { UpperBound }_{L_{3}}(t)
$$

Of course the upper bound of the sum is less then the sum of the upper bounds, so we have an overall upperbound ratio of:


Figure 3: Comparison of overall Upperbounds ratio $\frac{\Delta R}{R}(\bar{B} .25)$ with parameters $r$ (B.1) and $\epsilon$. With $(r, \epsilon)=(1.05, \pm 0.5)$ we have the two lower curves,and, $\epsilon=+0.5$ is the lower one between the two.. For upper curves we have $(r, \epsilon)=(2, \pm 0.5)$, and, the lower curve is always with $\epsilon=+0.5$. Of course the case $\epsilon=0$ is midway between found bounds for $\epsilon= \pm 1 / 2$. Due to the conjugate symmetry of $\xi(1 / 2+\epsilon+i t)$ with respect to $\epsilon$, it is the lower UpperBound that applies. So errors in (4.1), and similar formulas, is maximum for $\epsilon=0$. The aim of error upperbounds in extended $Z(t, \epsilon)$ less or equal to the same in $Z(t)$ is so met Here, differently as in [3, p. 141], B.1 and (B.17), in $a \pm \frac{|a|}{r} e^{i \frac{\pi}{4}} \quad$ the parameter $r$ has been left free to change in the interval $1<r \leq 2$. This choice gives a more realistic evaluation of upperbounds error of (4.1) , and similar formulas, at low $t$ values. In [3, p. 144] it is suggested the value $t \geq 100$ to get a practically error free expression. Considering the figure, it appears pessimistic, and, only with $r$ close to 2 ( as chosen in [3]) is justified. The only restriction on $r$ is linked to convergence of (A.8) . The convergence speed is not an issue. By the way this explains the good match noted in [3, p. 155] between $Z(t>18, \epsilon=0)$ and Haselgrove table [3, p. 122] .

Of course the case $\epsilon=0$ is between $\epsilon= \pm 1 / 2$. Here, in (B.1) and in (B.17), differently that in (3, p. 141] the parameter $r$ has been left free to change in the interval $1<r \leq 2$. This choice gives a more realistic evaluation of upperbounds error of (4.1) and similar formulas at low $t$ values. In [3, p. 144] it is suggested the value $t \geq 100$ to get a practically error free expression.
In light of above consideration, this appears pessimistic because only with $r$ close to 2 is justified. The only restriction on $r$ is linked to convergence of A.8. The convergence speed is not an issue. By the way, this explains the good match noted in [3, p. 155] between $Z(t>18, \epsilon=0)$ and Haselgrove table [3, p. 122]. The spurious contribution (B.9) is an insignificant fraction of $R_{0}(t)$ at least for $t>20$.
Besides the bound with $\epsilon>0$ ( and so also for $\epsilon<0$ ) is lower than with $\epsilon=0$.
We can affirm that (4.8) can be used profitably from $t=20$ with $\epsilon$ in critical strip.
