# EUCLIDEAN ALGEBRAS

#### Abstract

We introduce a new example of unital commutative $n$-dimensional group algebra $\mathbb{R}_{n}$ for $n \geq 2$. The algebra $\mathbb{R}_{n}$ and the complex numbers $\mathbb{C}$ are astonishingly alike. The zero divisor set of the algebra has Lebesgue $\mu_{n}$-measure zero. The formula for the Haar measure is established. Also, the analytic function theory in $\mathbb{R}_{n}$, for $n=2 k$ that similar to the classical theory in $\mathbb{C}$ is introduced. This includes the Cauchy-Riemann equations, mean-value theorem and Louisville theorem.


## 1. Introduction

In this paper, we introduce a new example of unital commutative $n$-dimensional group algebra $\mathbb{R}_{n}$ for $n \geq 2$. When $n=2$, the result is the complex numbers system $\mathbb{C}$. The algebra $\mathbb{R}_{n}$ and the complex numbers $\mathbb{C}$ are astonishingly alike. We name $\mathbb{R}_{n}$ the Euclidean algebra because the definition of new multiplication works for all Euclidean space over $\mathbb{R}$ in a natural way. The algebra has zero divisors of Lebesgue $\mu_{n}$-measure zero. The formula for the Haar measure is established. We introduced the analytic function theory in $\mathbb{R}_{n}$, for $n=2 k$ that similar to the classical theory in $\mathbb{C}$. This includes the Cauchy-Riemann equations, mean-value theorem and Louisville theorem. In Section 7 We compare $\mathbb{R}_{n}$ with other commutative hypercomplex number systems in literatures.

## 2. Multiplication in $\mathbb{R}^{n}$

Let $n \in \mathbb{N}, n \geq 2$ and $\mathbb{R}^{n}$ be the $n$-dimensional Euclidean space over $\mathbb{R}$ and $\left\{\vec{e}_{1}, \cdots, \vec{e}_{n}\right\}$ be the standard basis of $\mathbb{R}^{n}$. Define a mapping

Let $I_{n}$ denote the identity mapping (matrix) on the real $n$-dimensional Euclidean space $\mathbb{R}^{n}$. It is clear that $\mathfrak{g}^{n}=-I_{n}$ and $\mathfrak{g}^{2 n}=I_{n}$. The set $\left\{\mathfrak{g}^{\ell} \mid \ell=1,2, \cdots, 2 n\right\}$ is cyclic, hence it is an abelian group of order $2 n$. We write $\mathfrak{g}^{0}=\mathfrak{g}^{2 n}=I_{n}$. For $0<\ell \leq n-1$, the matrix form for the mapping $\mathfrak{g}^{\ell}$ is

O & I_{n-\ell} \\
-I_{\ell} & O^{\prime}
\end{array}\right]
$$

where $I_{n-\ell}$ is the $(n-\ell) \times(n-\ell)$ identity matrix, $I_{\ell}$ is the $\ell \times \ell$ identity matrix and $O$ a zero matrix.

Since $\mathfrak{g}^{n+k}=-\mathfrak{g}^{k}$. The linear span of the group $\mathfrak{G}_{n} \equiv\left\{\mathfrak{g}^{\ell} \mid \ell=\right.$ $1,2, \cdots, 2 n\}$ over $\mathbb{R}$ has dimension $n$. Let $\mathbb{M}_{n}$ denote this linear span. The set $\left\{\mathfrak{g}^{0}, \mathfrak{g}^{1}, \cdots, \mathfrak{g}^{n-1}\right\}$ is a basis for $\mathbb{M}_{n}$, a linear subspace of the $n \times n$ real matrix space. It is clear that $\mathbb{M}_{n}$ is closed under matrix multiplication. Since the group $\left\{\mathfrak{g}^{\ell} \mid \ell=1,2, \cdots, 2 n\right\}$ is abelian, the space $\mathbb{M}_{n}$ with the matrix multiplication is a commutative algebra of dimension $n$ with multiplicative identity $I_{n}$. Let $A$ be an element in $\mathbb{M}_{n}$ with $\operatorname{det} A \neq 0$. The inverse matrix $A^{-1}$ exists. By the Cayley-Hamilton theorem, $A^{-1}$ is a linear combination of $\left\{I_{n}, A, A^{2}, \cdots, A^{n-1}\right\}$, hence $A^{-1}$ is also an element of $\mathbb{M}_{n}$.

Define the mapping $\varsigma$ :

$$
\varsigma: \vec{e}_{\ell} \mapsto \mathfrak{g}^{\ell-1}, \ell=1,2, \cdots, n
$$

The mapping $\varsigma$ is a bijection between bases of $\mathbb{R}^{n}$ and $\mathbb{M}_{n}$. The mapping $\varsigma$ extends to an isomorphism from $\mathbb{R}^{n}$ onto $\mathbb{M}_{n}$ as linear spaces over $\mathbb{R}$. For an element $\vec{u}=\left[u_{1}, u_{2}, \cdots, u_{n-1}, u_{n}\right] \in \mathbb{R}^{n}$, we have

$$
\varsigma(\vec{u})=\varsigma\left(\sum_{\ell=1}^{n} u_{\ell} \vec{e}_{\ell}\right)=\sum_{\ell=1}^{n} u_{\ell} \mathfrak{g}^{\ell-1} \in \mathbb{M}_{n}
$$

For $\vec{u}, \vec{v} \in \mathbb{R}^{n}$, define $\vec{u} \circledast \vec{v}$ as

$$
\vec{u} \circledast \vec{v} \equiv \varsigma^{-1}(\varsigma(\vec{u}) \varsigma(\vec{v}))
$$

Theorem 2.1. The Euclidean space $\mathbb{R}^{n}, n \geq 2$ equipped with the multiplication $\circledast$ is a commutative algebra with multiplicative identity $\vec{e}_{1}$.

Proof. Let $\vec{u}, \vec{v}, \vec{w}$ be elements in $\mathbb{R}^{n}$.

1. Associative Property: By definition we have $\varsigma(\vec{u} \circledast \vec{v})=\varsigma(\vec{u}) \varsigma(\vec{v})$ and $\varsigma(\vec{v} \circledast \vec{w})=\varsigma(\vec{v}) \varsigma(\vec{w})$. Also the multiplication in $\mathbb{M}_{n}$ satisfies the Associative Law. We have

$$
\begin{aligned}
(\vec{u} \circledast \vec{v}) \circledast \vec{w} & =\varsigma^{-1}(\varsigma(\vec{u} \circledast \vec{v}) \varsigma(\vec{w})) \\
& =\varsigma^{-1}((\varsigma(\vec{u}) \varsigma(\vec{v})) \varsigma(\vec{w})) \\
& =\varsigma^{-1}(\varsigma(\vec{u})(\varsigma(\vec{v}) \varsigma(\vec{w}))) \\
& =\varsigma^{-1}(\varsigma(\vec{u}) \varsigma(\vec{v} \circledast \vec{w})) \\
& =\vec{u} \circledast(\vec{v} \circledast \vec{w}) .
\end{aligned}
$$

i.e.

$$
(\vec{u} \circledast \vec{v}) \circledast \vec{w}=\vec{u} \circledast(\vec{v} \circledast \vec{w}) .
$$

2. Commutative Property: Since the multiplication in $\mathbb{M}_{n}$ is commutative, $\varsigma(\vec{u}) \varsigma(\vec{v})=\varsigma(\vec{v}) \varsigma(\vec{u})$, we have

$$
\vec{u} \circledast \vec{v}=\varsigma^{-1}(\varsigma(\vec{u}) \varsigma(\vec{v}))=\varsigma^{-1}(\varsigma(\vec{v}) \varsigma(\vec{u}))=\vec{v} \circledast \vec{u} .
$$

3. Distributive Property: Based on the facts that $\varsigma$ and $\varsigma^{-1}$ are isomorphisms of $\mathbb{R}^{n}$ and $\mathbb{M}_{n}$ as linear spaces over $\mathbb{R}$, also the fact that $\mathbb{M}_{n}$ is an algebra satisfying the Distributive Law, we have

$$
\begin{aligned}
\vec{w} \circledast(\vec{u}+\vec{v}) & =\varsigma^{-1}(\varsigma(\vec{w}) \varsigma(\vec{u}+\vec{v})) \\
& =\varsigma^{-1}(\varsigma(\vec{w})(\varsigma(\vec{u})+\varsigma(\vec{v}))) \\
& =\varsigma^{-1}(\varsigma(\vec{w}) \varsigma(\vec{u})+\varsigma(\vec{w}) \varsigma(\vec{v})) \\
& =\varsigma^{-1}(\varsigma(\vec{w}) \varsigma(\vec{u}))+\varsigma^{-1}(\varsigma(\vec{w}) \varsigma(\vec{v})) \\
& =\vec{w} \circledast \vec{u}+\vec{w} \circledast \vec{v} .
\end{aligned}
$$

i.e.

$$
\vec{w} \circledast(\vec{u}+\vec{v})=\vec{w} \circledast \vec{u}+\vec{w} \circledast \vec{v} .
$$

4. Multiplicative Identity: The multiplicative identity in $\mathbb{M}_{n}$ is $I_{n}=$ $\mathfrak{g}^{0}$ and the corresponding element in $\mathbb{R}^{n}$ is $\varsigma^{-1}\left(\mathfrak{g}^{0}\right)=\vec{e}_{1}=$ $[1,0, \cdots, 0]$. We have

$$
\vec{u} \circledast \vec{e}_{1}=\vec{e}_{1} \circledast \vec{u}=\varsigma^{-1}\left(I_{n} \varsigma(\vec{u})\right)=\varsigma^{-1}(\varsigma(\vec{u}))=\vec{u} .
$$

The Theorem 2.1 is proved.

We call this algebra the Real Euclidian Algebra. It is denoted by $\mathbb{R}_{n}$. The multiplication table for $*$ is

For $\vec{x}, \vec{y} \in \mathbb{R}_{n}$, if there is no confusion in the context, we write $\vec{x} \vec{y}$ for $\vec{x} \circledast \vec{y}$ and $\vec{x}^{m}$ for the product of $m$-multipliers $\vec{x} \circledast \vec{x} \circledast \cdots \circledast \vec{x}$. We reserve the notation $\vec{x} \cdot \vec{y}$ for the dot product. For $\vec{a}_{m}, \cdots \vec{a}_{1}, \vec{a}_{0} \in \mathbb{R}_{n}$ the polynomial is well defined:

$$
p(\vec{x})=\vec{a}_{m} \vec{x}^{m}+\vec{a}_{m-1} \vec{x}^{m-1}+\cdots+\vec{a}_{1} \vec{x}+\vec{a}_{0}
$$

## 3. REMARKS

We have some notes in order.
(1) The algebra $\mathbb{R}_{n}$ is the Euclidean space $\mathbb{R}^{n}$ with the standard basis $\left\{\vec{e}_{k} \mid k=1, \cdots n\right\}$ and the basis follows the multiplication table (2.1). In particular, $\vec{e}_{1}$ is the multiplicative identity 1. As a Euclidean space over $\mathbb{R}$, for $\vec{x}=\left[x_{1}, \cdots, x_{n}\right]$ and $\vec{a}=$ $\left[a_{1}, \cdots, a_{n}\right]$ in $\mathbb{R}_{n}$, the distance is

$$
|\vec{x}-\vec{a}|=\sqrt{\sum_{j=1}^{n}\left(x_{j}-a_{j}\right)^{2}}
$$

Also, the Lebesgue measure $\mu_{n}$ is naturally defined in $\mathbb{R}_{n}$.
(2) Let $\vec{x} \in \mathbb{R}_{n}$, define the norm of $\|\vec{x}\|$ as

$$
\|\vec{x}\| \equiv|\operatorname{det} \varsigma(\vec{x})| .
$$

Then by the matrix multiplication properties, for $\vec{x}, \vec{y} \in \mathbb{R}_{n}$

$$
\|\vec{x} \circledast \vec{y}\|=|\operatorname{det} \varsigma(\vec{x}) \operatorname{det} \varsigma(\vec{y})|=\|\vec{x}\|\|\vec{y}\|
$$

(3) For $n \geq 2$, the group $\mathfrak{G}_{n}$ is

$$
\mathfrak{G}_{n}=\left\{\mathfrak{g}, \mathfrak{g}^{2}, \cdots, \mathfrak{g}^{n}=-1, \mathfrak{g}^{n+1}, \cdots, \mathfrak{g}^{2 n}=1\right\}
$$

When $n=2$, the part between $\mathfrak{g}$ and -1 as well as the part between $\mathfrak{g}^{n+1}$ and 1 reduced into empty set. So $\mathfrak{G}_{2}=\left\{\mathfrak{g}, \mathfrak{g}^{2}, \mathfrak{g}^{3}, \mathfrak{g}^{4}\right\}=$
$\{\mathfrak{g},-1,-\mathfrak{g}, 1\}$. This is the group $\{i,-1,-i, 1\}$ where $i$ is the imaginary unit in $\mathbb{C}$. So $\mathbb{C}$ is a natural member of $\mathbb{R}_{n}$.
(4) Let $\vec{u}=\left[u_{1}, \cdots, u_{n}\right] \in \mathbb{R}_{n}$. Then

$$
\begin{aligned}
\vec{u} & =\left[u_{1}, \cdots, u_{n}\right] \\
& =\|\vec{u}\|\left[\frac{u_{1}}{\|\vec{u}\|}, \cdots, \frac{u_{n}}{\|\vec{u}\|}\right] \\
& =\|\vec{u}\|\left[\cos \theta_{1}, \cdots, \cos \theta_{n}\right],
\end{aligned}
$$

where $\theta_{k}, k=1, \cdots, n$ is the angle between $\vec{u}$ and $\vec{e}_{k}$.
For $n=2$, we have $\varsigma\left(\mathbb{R}_{2}\right)=\mathbb{M}_{2}$.

$$
\mathbb{M}_{2}=\left\{\left.\left[\begin{array}{cc}
a & b \\
-b & a
\end{array}\right] \right\rvert\, a, b \in \mathbb{R}\right\}
$$

Also, $\operatorname{det}\left[\begin{array}{cc}a & b \\ -b & a\end{array}\right]=a^{2}+b^{2}$. So an element $[a, b] \in \mathbb{R}_{2}$ is a zero divisor iff $a=b=0$. i.e. $\mathbb{R}_{2}$ has no non-trivial zero divisors. Hence $\mathbb{R}_{2}$ is a 2-dimensional commutative division algebra. By the Frobenius theorem (1878) [4] the algebra $\mathbb{R}_{2}$ must be isomorphic to $\mathbb{C}$ over $\mathbb{R}$.

We have

$$
\begin{aligned}
\vec{u}=\left[u_{1}, u_{2}\right] & =\sqrt{u_{1}^{2}+u_{2}^{2}}\left[\frac{u_{1}}{\sqrt{u_{1}^{2}+u_{2}^{2}}}, \frac{u_{2}}{\sqrt{u_{1}^{2}+u_{2}^{2}}}\right] \\
& =\sqrt{u_{1}^{2}+u_{2}^{2}}\left[\cos \theta_{1}, \cos \theta_{2}\right],
\end{aligned}
$$

Note that in the case $n=2, \theta_{2}=\frac{\pi}{2}-\theta_{1}$. This is the formula $z=|z|(\cos \theta+i \sin \theta)$ in complex numbers.
(5) Let $\vec{u}, \vec{v} \in \mathbb{R}_{n}$ and $\vec{v}_{1}, \vec{v}_{2}, \cdots, \vec{v}_{n}$ be the $n$ row vectors in the matrix $\varsigma(\vec{v})^{\tau}$, the transpose matrix of $\varsigma(\vec{v})$. It is clear we have

$$
\left|\vec{v}_{j}\right|=|\vec{v}|, \forall j \leq n .
$$

Then by the multiplication table we have

$$
\vec{u} \vec{v}=\vec{u} \circledast \vec{v}=\left[\vec{u} \cdot \vec{v}_{1}, \cdots, \vec{u} \cdot \vec{v}_{n}\right]=\vec{u} \varsigma(\vec{v})=\vec{v} \vec{u},
$$

the $j^{\text {th }}$ component of $\vec{u} \circledast \vec{v}$ is $\vec{u} \cdot \vec{v}_{j}$, where "." is the dot product in $\mathbb{R}^{n}$. Hence we have

Lemma 3.1. Let $\vec{u}, \vec{v} \in \mathbb{R}_{n}$, then

$$
\vec{u} \circledast \vec{v}=\vec{u} \vec{v}=\vec{v} \varsigma(\vec{u}) .
$$

## 4. Zero Divisors

An element $\vec{x} \in \mathbb{R}_{n}$ is a zero divisor if and only if $\varsigma(\vec{x})$ is a zero divisor in $\mathbb{M}_{n}$ if and only if $\operatorname{det}(\varsigma(\vec{x}))$, a homogeneous polynomial in $n$ variables $\left\{x_{1}, \cdots, x_{n}\right\}$ has value zero. Let $\boldsymbol{Z}_{\mathbb{R}_{n}}$ denote the set of zero divisors in $\mathbb{R}_{n}$. For a polynomial $p$, we will write $\mathcal{Z}(p)$ for $\{\vec{x} \mid p(\vec{x})=0\}$.

Lemma 4.1. Let $p(\vec{x}): \mathbb{R}^{n} \rightarrow \mathbb{R}$ be a non-zero polynomial on $\mathbb{R}^{n}$, then $\mu_{n}(\boldsymbol{Z}(p))=0$.

Here $\mu_{n}$ is the Lebesgue measure on $\mathbb{R}^{n}$.
Proof. We prove the Lemma 4.1 by induction on the dimensions $n$.
For $n=1$. Let $p(\vec{x})$ be a polynomial of degree $m \geq 1$ on $\mathbb{R}$. It's clear $\mathfrak{Z}(p)$ is a finite set hence has Lebesgue measure zero.

Assume the statement is true for all $n=1, \cdots, k-1$. Consider $n=k$.

Let $p(\vec{x})=p\left(x_{1}, x_{2}, \cdots, x_{k}\right)$ be a non-zero polynomial of degree $m$ on $\mathbb{R}^{k}$ and let $t \in \mathbb{R}$. Define

$$
p_{\mid x_{1}=t}(\vec{x}) \equiv p\left(t, x_{2}, \cdots, x_{k}\right) .
$$

This is a function in $k-1$ variables $x_{2}, \cdots, x_{k}$. Let $\mathcal{C}$ denote the collection of all points $t$ in $\mathbb{R}$ with the properties that the function $p_{\mid x_{1}=t}(\vec{x})$ is not a zero function. Apply the induction assumption to $p_{\mid x_{1}=t}$, we have

$$
\mu_{k-1}\left(\mathcal{Z}\left(p_{\mid x_{1}=t}\right)\right)=0, \forall t \in \mathcal{C} .
$$

Let $t \in \mathbb{R} \backslash \mathcal{C}$. Then $p_{\mid x_{1}=t}(\vec{x}) \equiv 0$. So $\left(x_{1}-t\right)$ is a factor of $p$. The polynomial has at most finite factors. Hence the set $\mathbb{R} \backslash \mathcal{C}$ is a finite set. So

$$
\mu_{k-1}\left(\mathcal{Z}\left(p_{\mid x_{1}=t}\right)\right)=0 \text {, for } t \in \mathbb{R} \text { a.e. }
$$

By Fubini't theorem

$$
\mu_{k}(\mathcal{Z}(p))=\int_{\mathbb{R}} \mu_{k-1}\left(\mathcal{Z}\left(p_{\mid x_{1}=t}\right)\right) d t=0 .
$$

The induction completes. The Lemma 4.1 is proved.
Theorem 4.1. Let $n \geq 3, n \in \mathbb{N}$ and $\mu_{n}$ be the Lebesgue measure on $\mathbb{R}^{n}$. Then
(1) The set of zero divisors in $\mathbb{R}_{n}, \mathfrak{Z}_{\mathbb{R}_{n}}$, is a closed ideal.
(2) $\mu_{n}\left(\mathfrak{Z}_{\mathbb{R}_{n}}\right)=0$.
(3) The open set $\mathbb{R}_{n} \backslash \boldsymbol{Z}_{\mathbb{R}_{n}}$ is a group.
(4) $\boldsymbol{\beth}_{\mathbb{R}_{n}}$ is star-shaped in the sense that if $\vec{x} \in \mathfrak{Z}_{\mathbb{R}_{n}}$, then $\{t \vec{x} \mid t \in$ $\mathbb{R}\} \subset \mathfrak{Z}_{\mathbb{R}_{n}}$.
Let $\mathbb{G}_{n}$ denote the group $\mathbb{R}_{n} \backslash \mathfrak{Z}_{\mathbb{R}_{n}}$.
Proof. 1. It is clear that $\operatorname{det}(\varsigma(\vec{u}))$ is a polynomial so continuous. Therefore the set $\left\{\vec{u} \left\lvert\, \operatorname{det}(\varsigma(\vec{u})) \leq \frac{1}{n}\right.\right\}$ is closed. This implies that

$$
\mathfrak{Z}_{\mathbb{R}_{n}}=\bigcap_{n=1}^{\infty}\left\{\vec{u} \left\lvert\, \operatorname{det}(\varsigma(\vec{u})) \leq \frac{1}{n}\right.\right\}
$$

is closed.
2. Let $\vec{x} \in \mathfrak{Z}_{\mathbb{R}_{n}}$. Then $\vec{x}=\left[x_{1}, \cdots, x_{n}\right]$ is a zero for the polynomial $\operatorname{det}(\varsigma(\vec{x}))$. By Lemma 4.1, the conclusion follows.
3. The set $\mathfrak{Z}_{\mathbb{R}_{n}}$ is closed. So its complement $\mathbb{G}_{n}$ is open. Let $\vec{a}, \vec{b} \in \mathbb{G}_{n}$. Then $\varsigma(\vec{a}), \varsigma(\vec{b}) \in \mathbb{M}_{n}$, $\operatorname{det} \varsigma(\vec{a}) \neq 0$ and $\operatorname{det} \varsigma(\vec{b}) \neq 0$. This implies $\operatorname{det}(\varsigma(\vec{a}) \varsigma(\vec{b})) \neq 0$, or $\vec{a} \circledast \vec{b} \notin \mathfrak{Z}_{\mathbb{R}_{n}}$. Hence $\mathbb{G}_{n}$ is closed under multiplication $\circledast$. Notice that $\varsigma(\vec{a})^{-1} \in \mathbb{M}_{n}$. Let $\vec{c}$ denote the element $\varsigma^{-1}\left(\varsigma(\vec{a})^{-1}\right)$ in $\mathbb{R}_{n} \backslash \mathfrak{Z}_{\mathbb{R}_{n}}=\mathbb{G}_{n}$. We have

$$
\vec{a} \circledast \vec{c}=\vec{c} \circledast \vec{a}=\varsigma^{-1}\left(\varsigma(\vec{a})^{-1} \varsigma(\vec{a})\right)=\varsigma^{-1}\left(I_{n}\right)=\vec{e}_{n} .
$$

So $\vec{c}$ is the inverse to $\vec{a}$. $\mathbb{G}_{n}$ is a group. Theorem 4.1 is proved.
Example 4.1. Zero divisors $\mathfrak{Z}_{\mathbb{R}_{4}}$ in $\mathbb{R}_{4}$. Let $\vec{u}=\left[u_{1}, u_{2}, u_{3}, u_{4}\right] \in \mathbb{R}^{4}$, then $\vec{u} \in \mathfrak{Z}_{\mathbb{R}_{4}}$ if and only if $\operatorname{det}(\varsigma(\vec{u}))=\left(u_{1}^{2}-u_{3}^{2}+2 u_{2} u_{4}\right)^{2}+\left(u_{4}^{2}-u_{2}^{2}+\right.$ $\left.2 u_{1} u_{3}\right)^{2}=0$ if and only if

$$
\text { (I) }\left\{\begin{array} { l } 
{ u _ { 1 } = s } \\
{ u _ { 2 } = t } \\
{ u _ { 3 } = - s + \sqrt { 2 } t } \\
{ u _ { 4 } = - \sqrt { 2 } s + t }
\end{array} \quad \text { or } ( I I ) \quad \left\{\begin{array}{l}
u_{1}=s \\
u_{2}=t \\
u_{3}=s-\sqrt{2} t \\
u_{4}=\sqrt{2} s-t
\end{array}\right.\right.
$$

where $s$ and $t$ are free real variables.

## 5. The Haar measure on $\mathbb{G}_{n}$

Let $E$ be a Borel subset of $\mathbb{G}_{n}$ and $\mu_{n}$ be the Lebesgue measure on $\mathbb{R}^{n}$. Define $\nu_{n}(E)$ as

$$
\nu_{n}(E) \equiv \int_{E} \frac{1}{|\operatorname{det} \varsigma(\vec{x})|} d \mu_{n}(\vec{x}) .
$$

Theorem 5.1. $\nu_{n}$ is the Haar measure on $\mathbb{G}_{n}$ and it is unique up to a scalar multiplication.

Proof. Let $\vec{a} \in \mathbb{G}_{n}$ and $E$ be a Borel subset of $\mathbb{G}_{n}$, then $\vec{a} E=E \vec{a} \subset \mathbb{G}_{n}$. We will show that $\nu_{n}(\vec{a} E)=\nu_{n}(E)$. By definition,

$$
\begin{aligned}
\nu_{n}(\vec{a} E) & =\int_{\vec{a} E} \frac{1}{|\operatorname{det} \varsigma(\vec{x})|} d \mu_{n}(\vec{x}) \\
& =\int_{E} \frac{1}{|\operatorname{det} \varsigma(\vec{a} \vec{y})|} d \mu_{n}(\vec{a} \vec{y})
\end{aligned}
$$

By Lemma 3.1, we have

$$
\begin{aligned}
\vec{a} \vec{y} & =\vec{y} \varsigma(\vec{a}) \\
d \mu_{n}(\vec{a} \vec{y}) & =|\operatorname{det} \varsigma(\vec{a})| d \mu_{n}(\vec{y})
\end{aligned}
$$

Therefore,

$$
\begin{aligned}
\nu_{n}(\vec{a} E) & =\int_{E} \frac{1}{|\operatorname{det}(\varsigma(\vec{a}) \varsigma(\vec{y}))|} d \mu_{n}(\vec{y} \varsigma(\vec{a})) \\
& =\int_{E} \frac{|\operatorname{det} \varsigma(\vec{a})|}{|\operatorname{det} \varsigma(\vec{a})||\operatorname{det} \varsigma(\vec{y})|} d \mu_{n}(\vec{y}) \\
& =\int_{E} \frac{1}{|\operatorname{det} \varsigma(\vec{y})|} d \mu_{n}(\vec{y})
\end{aligned}
$$

which is

$$
\nu_{n}(\vec{a} E)=\nu_{n}(E)
$$

## 6. Analytic functions in $\mathbb{R}_{2 k}$

In this section we will introduce the analytic function theory in $\mathbb{R}_{2 k}$, which is similar to the analytic function theory in $\mathbb{C}$.

Let $\Omega$ be an open region in $\mathbb{R}_{n}$, and $f$ be a function $f: \Omega \rightarrow \mathbb{R}_{n}$, that is, for a point $\vec{x}=\left[x_{1}, \cdots, x_{n}\right] \in \Omega$,

$$
f(\vec{x})=\left[f_{1}(\vec{x}), \cdots, f_{n}(\vec{x})\right]
$$

where $f_{j}(\vec{x}), j=1, \cdots, n$, are real valued functions in $n$ real variables $x_{j}, j=1, \cdots, n$.

Define $\vec{w}=\vec{e}_{2} \in \mathbb{R}_{n}$ and $\vec{w}^{0}=\vec{e}_{1}$. It is clear $\vec{w} \in \mathbb{G}_{n}$ since $\operatorname{det}(\varsigma(\vec{w})) \neq 0$. By the multiplication table, $\vec{w}^{-j}=-\vec{w}^{n-j}$, for $0 \leq$ $j \leq n$. We have

$$
f(\vec{x})=\sum_{j=1}^{n} f_{j}(\vec{x}) \vec{w}^{j-1}
$$

We say a function $f(\vec{x})$ is differentiable in $\Omega$ if the limit

$$
\lim _{\vec{\delta} \rightarrow 0, \vec{\delta} \in \mathbb{G}_{n}} \frac{f(\vec{a}+\vec{\delta})-f(\vec{a})}{\vec{\delta}}=f^{\prime}(\vec{a})\left(\text { or } \frac{d f}{d \vec{x}}(\vec{a})\right)
$$

exists for each point $\vec{a} \in \Omega$.
In this definition, the variable $\vec{\delta}=\left[x_{1}, x_{2}, \cdots, x_{n}\right]=\sum_{j=1}^{n} x_{j} \vec{w}^{j-1}$ is approaching 0 while remains in $\mathbb{G}_{n}$. Notice that for $x_{j} \neq 0$, the vectors $x_{j} \vec{w}^{j-1}$ are in $\mathbb{G}_{n}$, since $\operatorname{det} \varsigma\left(\vec{w}^{j-1}\right) \neq 0, j=1, \cdots, n$. So in the above definition of differentiation, one can take the special path along $x_{j} \vec{w}^{j-1}$ with $x_{j} \rightarrow 0$ :

$$
\begin{aligned}
f^{\prime}(\vec{a}) & =\lim _{\vec{\delta} \rightarrow 0, \vec{\delta} \in \mathbb{G}_{n}} \frac{f(\vec{a}+\vec{\delta})-f(\vec{a})}{\vec{\delta}}=\lim _{x_{j} \rightarrow 0} \frac{f\left(\vec{a}+x_{j} \vec{w}^{j-1}\right)-f(\vec{a})}{x_{j} \vec{w}^{j-1}} \\
f^{\prime}(\vec{a}) & =\vec{w}^{-j+1} \frac{\partial f}{\partial x_{j}}(\vec{a})
\end{aligned}
$$

Definition 6.1. Let $\Omega \subset \mathbb{R}_{n}$ be an open region and $f$ be a function with domain $\Omega$. We call $f(\vec{x})=\left[f_{1}(\vec{x}), \cdots, f_{n}(\vec{x})\right]$ an analytic function on $\Omega$ if
(1) $f$ is differentiable at each point $\vec{x} \in \Omega$.
(2) The second order partial derivatives of $f_{m}(\vec{x}), \frac{\partial^{2} f_{m}}{\partial x_{i} \partial x_{j}}$ are continuous in $\Omega$.
It is clear $\frac{\partial^{2} f_{m}}{\partial x_{i} \partial x_{j}}=\frac{\partial^{2} f_{m}}{\partial x_{j} \partial x_{i}}$ by the Clairaut's Theorem.
To introduce the next results, we set $n=2 k$. We have:

$$
\begin{equation*}
f^{\prime}(\vec{a})=\vec{w}^{-j+1} \frac{\partial f}{\partial x_{j}}(\vec{a}), j=1, \ldots, 2 k \tag{6.1}
\end{equation*}
$$

where

$$
\frac{\partial f}{\partial x_{j}}(\vec{a})=\left[\frac{\partial f_{1}}{\partial x_{j}}, \cdots, \frac{\partial f_{2 k}}{\partial x_{j}}\right]
$$

For any given $1 \leq i \leq k$, we have

$$
\begin{aligned}
& f^{\prime}(\vec{a})=\vec{w}^{-i+1} \frac{\partial f}{\partial x_{i}}(\vec{a})=\vec{w}^{-i-k+1} \frac{\partial f}{\partial x_{i+k}}(\vec{a}) \\
& -\vec{w}^{k} \frac{\partial f}{\partial x_{i}}(\vec{a})=\frac{\partial f}{\partial x_{i+k}}(\vec{a}) \\
& {\left[\begin{array}{cc}
O & -I_{k} \\
I_{k} & O
\end{array}\right] \frac{\partial f}{\partial x_{i}}(\vec{a})=\frac{\partial f}{\partial x_{i+k}}(\vec{a})}
\end{aligned}
$$

Hence, if $f$ is analytic on $\Omega$, we have

$$
\left\{\begin{array}{rl}
\frac{\partial f_{m}}{\partial i_{i}} & =\frac{\partial f_{m+k}}{\partial x_{+k}}  \tag{6.2}\\
\frac{\partial f_{m+k}}{\partial x_{i}} & =-\frac{\partial f_{m}}{\partial x_{i+k}}
\end{array} \quad \forall m, i, 1 \leq m, i \leq k .\right.
$$

So we have the following theorem:
Theorem 6.1. Given a positive even integer $n=2 k$ and an open set $\Omega \subset \mathbb{R}_{2 k}$. For any analytic function $f=\left[f_{1}, \ldots, f_{2 k}\right]$ on $\Omega$, we have
(1) $f$ satisfies the Cauchy-Riemann equations

$$
\left\{\begin{array}{rl}
\frac{\partial f_{m}}{\partial x_{i}} & =\frac{\partial f_{m+k}}{\partial x_{i+k}} \\
\frac{\partial f_{m+k}}{\partial x_{i}} & =-\frac{\partial f_{m}}{\partial x_{i+k}}
\end{array} \quad \forall 1 \leq m, i \leq k .\right.
$$

(2) For each $f_{m}, f_{m+k}, 1 \leq m, i \leq k$,

$$
\begin{equation*}
\frac{\partial^{2} f_{m}}{\partial x_{i}^{2}}+\frac{\partial^{2} f_{m}}{\partial x_{i+k}^{2}}=0 \tag{6.3}
\end{equation*}
$$

and

$$
\frac{\partial^{2} f_{m+k}}{\partial x_{i}^{2}}+\frac{\partial^{2} f_{m+k}}{\partial x_{i+k}^{2}}=0
$$

(3) Each $f_{m}$ is a harmonic function in the sense that $f_{m}$ has continuous second order partial derivatives and

$$
\sum_{i=1}^{2 k} \frac{\partial^{2} f_{m}}{\partial x_{i}^{2}}=0
$$

Proof. We will prove the Equation (6.3) only. The proof to the Equation (6.4) is similar to this. Let $m \leq k$. By the Cauchy-Riemann Equations (6.2) we have

$$
\left\{\begin{array}{rl}
\frac{\partial f_{m}}{\partial x_{i}} & =\frac{\partial f_{m+k}}{\partial x_{i+k}} \\
\frac{\partial f_{m}}{\partial x_{i+k}} & =-\frac{\partial f_{m+k}}{\partial x_{i}}
\end{array} \quad \forall 1 \leq i \leq k\right.
$$

Hence

$$
\left\{\begin{array}{l}
\frac{\partial^{2} f_{m}}{\partial x_{i}^{2}}=\frac{\partial^{2} f_{m+k}}{\partial x_{i+k} \partial x_{i}} \\
\frac{\partial^{2} f_{m}}{\partial x_{i+k}^{2}}=-\frac{\partial^{2} f_{m+k}}{\partial x_{i} \partial x_{i+k}}
\end{array} \quad \forall 1 \leq i \leq k\right.
$$

Therefore

$$
\frac{\partial^{2} f_{m}}{\partial x_{i}^{2}}+\frac{\partial^{2} f_{m}}{\partial x_{i+k}^{2}}=\frac{\partial^{2} f_{m+k}}{\partial x_{i+k} \partial x_{i}}-\frac{\partial^{2} f_{m+k}}{\partial x_{i} \partial x_{i+k}}=\frac{\partial^{2} f_{m+k}}{\partial x_{i+k} \partial x_{i}}-\frac{\partial^{2} f_{m+k}}{\partial x_{i+k} \partial x_{i}}=0 .
$$

Corollary 6.1. Consider the polynomial function in $\mathbb{R}_{2 k}$

$$
\begin{aligned}
p(\vec{x}) & \equiv \vec{a}_{m} \vec{x}^{m}+\vec{a}_{m-1} \vec{x}^{m-1} \cdots+\vec{a}_{1} \vec{x}+\vec{a}_{0} \\
& =\left[p_{1}(\vec{x}), \cdots, p_{2 k}(\vec{x})\right],
\end{aligned}
$$

where $\vec{a}_{m}, \vec{a}_{m-1}, \cdots, \vec{a}_{1}, \vec{a}_{0} \in \mathbb{R}_{2 k}$. Then each $p_{j}(\vec{x}), j=1, \cdots, 2 k$ is a harmonic polynomial in the sense that they are polynomials and harmonic functions.

The following Example 6.1 shows that, the requirement of an even dimension in Theorem 6.1 is necessary.

Example 6.1. Consider $\mathbb{R}_{2 k-1}, k>1$ and the function $f$ given by

$$
f(\vec{x}) \equiv \vec{x}^{2}
$$

The domain of $f$ is $\mathbb{R}_{2 k-1}$. It is left to the readers to verify that $f$ is analytic and

$$
f^{\prime}(\vec{x})=2 \vec{x} .
$$

We have

$$
\begin{aligned}
& f(\vec{x})=\left[f_{1}, \cdots, f_{2 k-1}\right]=\sum_{m=1}^{2 k-1} f_{m} \vec{w}^{m-1}=\left(\sum_{j=1}^{2 k-1} x_{j} \vec{w}^{j-1}\right)^{2} \\
&=\sum_{i=1}^{2 k-1} x_{i} \vec{w}^{i-1} \sum_{j=1}^{2 k-1} x_{j} \vec{w}^{j-1}=\sum_{i, j=1}^{2 k-1} x_{i} x_{j} \vec{w}^{i+j-2} \\
& f_{m}=\sum_{\substack{i+j-1=m \\
1 \leq i, j \leq 2 k-1}} x_{i} x_{j}-\sum_{\substack{i+j-1=m+2 k-1 \\
1 \leq i, j \leq 2 k-1}} x_{i} x_{j} . \\
&
\end{aligned}
$$

Notice that

$$
\left(\sum_{1 \leq \ell \leq 2 k-1} \frac{\partial^{2}}{\partial x_{\ell}^{2}}\right) x_{i} x_{j}=\left\{\begin{array}{cc}
2 & i=j ; \\
0 & i \neq j .
\end{array}\right.
$$

Thus

$$
\begin{aligned}
& \sum_{1 \leq \ell \leq 2 k-1} \frac{\partial^{2} f_{m}}{\partial x_{\ell}^{2}} \\
= & \sum_{1 \leq \ell \leq 2 k-1} \frac{\partial^{2}}{\partial x_{\ell}^{2}}\left(\sum_{\substack{i+j-1=m \\
1 \leq i, j \leq 2 k-1}} x_{i} x_{j}-\sum_{\substack{i+j-1=m+2 k-1 \\
1 \leq i, j \leq 2 k-1}} x_{i} x_{j}\right) \\
= & \sum_{1 \leq \ell \leq 2 k-1} \frac{\partial^{2}}{\partial x_{\ell}^{2}}\left(\sum_{\substack{2 j-1=m \\
1 \leq j \leq 2 k-1}} x_{j}^{2}-\sum_{\substack{2 j-1=m+2 k-1 \\
1 \leq j \leq 2 k-1}} x_{j}^{2}\right)
\end{aligned}
$$

(Note that the set $\{j \mid 2 j-1=m, 1 \leq j \leq 2 k-1\}$ is empty if $m$ is even.
and $\{j \mid 2 j-1=m+2 k-1,1 \leq j \leq 2 k-1\}$ is empty if $m$ is odd.)
$=\left\{\begin{array}{cc}m+1 & m \text { is odd } ; \\ -m-2 k & m \text { is even } .\end{array}\right.$

Hence we have

$$
\sum_{\ell=1}^{2 k-1} \frac{\partial^{2} f_{m}}{\partial x_{\ell}^{2}}=\left\{\begin{array}{cc}
m+1 & m \text { is odd } \\
-m-2 k & m \text { is even }
\end{array} \neq 0\right.
$$

So $f_{m}$ is not a harmonic function.

Next we introduce an analytic function theory in $\mathbb{R}_{2 k}$, similar to the one in the complex number field $\mathbb{C}$. We show that in two examples (Theorem 6.2 and Theorem 6.3) that such a generalization is valid.

Let $f=\left[f_{1}, \cdots, f_{2 k}\right]$ be an analytic function defined on an open region $\Omega \subset \mathbb{R}_{2 k}$. Let $\vec{a} \in \Omega$ and $r>0$ such that the ball $b(\vec{a}, r) \subset \Omega$. $\partial b(\vec{a}, r)$ is the boundary of the ball. Let $\nu$ be the probability measure for the sphere. By Theorem 6.1 each $f_{m}, m=1, \cdots, 2 k$ is a harmonic function. It is well known that [1] for a harmonic function $u$ on $\mathbb{R}^{n}$ we have

$$
u(\vec{a})=\int_{\partial b(\vec{a}, r)} u(\vec{x}) d \nu
$$

Apply this mean value theorem to each $f_{m}$ we have

$$
\begin{aligned}
f(\vec{a}) & =\left[f_{1}(\vec{a}), \cdots, f_{2 k}(\vec{a})\right] \\
& =\left[\int_{\partial b(\vec{a}, r)} f_{1}(\vec{x}) d \nu, \cdots, \int_{\partial b(\vec{a}, r)} f_{2 k}(\vec{x}) d \nu\right] \\
& =\int_{\partial b(\vec{a}, r)} f(\vec{x}) d \nu
\end{aligned}
$$

So we have Theorem 6.2, which is the Mean Value Theorem for analytic functions in $\mathbb{R}_{2 k}$.

Theorem 6.2. Let $\Omega \subset \mathbb{R}_{2 k}$ be an open region and the ball $b(\vec{a}, r) \subset \Omega$ with center $\vec{a} \in \Omega$ and radius $r>0 . \partial b(\vec{a}, r)$ is the boundary of the ball and $\nu$ is the probability measure for the boundary. For an analytic function $f=\left[f_{1}, \cdots, f_{2 k}\right]$ defined on $\Omega$, we have

$$
f(\vec{a})=\int_{\partial b(\vec{a}, r)} f(\vec{x}) d \nu
$$

We call an analytic function an entire function on $\mathbb{R}_{2 k}$ when it is analytic on $\Omega=\mathbb{R}_{2 k}$. A function $f$ is bounded in $\mathbb{R}_{2 k}$ if there exists a positive number $M$ such that

$$
|f(\vec{x})| \leq M, \forall \vec{x} \in \mathbb{R}_{2 k}
$$

The next Theorem 6.3is the Louisville Theorem for Entire Functions in $\mathbb{R}_{2 k}$.

Theorem 6.3. A bounded entire function in $\mathbb{R}_{2 k}$ is a constant function.
Proof. Let $f=\left[f_{1}, \cdots, f_{2 k}\right]$ be an entire function on $\mathbb{R}_{2 k}$ with a bound $M$.

$$
|f(\vec{x})| \leq M, \forall \vec{x} \in \mathbb{R}_{2 k}
$$

Then for each $m \leq 2 k$

$$
\left|f_{m}(\vec{x})\right| \leq M, \forall \vec{x} \in \mathbb{R}_{2 k}
$$

Notice that $f_{m}$ is harmonics. By the Louisville Theorem for the harmonics functions each $f_{m}$ is a constant function. Therefore $f$ is a constant function. This proves Theorem 6.3,

## 7. Hypercomplex numbers

In this section we will justify $\mathbb{R}_{n}$ in relation to the hypercomplex number system. "A hypercomplex number is a number having properties departing from those of the real and complex numbers." (9), van der Waerden (1985)). For commutative hypercomplex number systems, the most common commutative examples are the abelian group algebra $K[G]$ where $K$ is a field and $G$ a finite abelian group, the Davenport's 4-dimensional commutative hypercomplex number system 3], and the Jacobi's algebra $J_{\circledast}^{3}$. [5]

The algebras $\mathbb{R}_{3}$ and $J_{\circledast}^{3}$ are itentical. Shlomo Jacobi discovered his 3dimensional algebra $J_{\circledast}^{3}$ in 2014 . His colleagues complete the unfinished manuscript after he passed away.

If we take $K=\mathbb{R}$ and $G=\mathfrak{G}_{n}$ as in Section 2, then the real linear span, $\operatorname{span}\left(\mathfrak{G}_{n}\right)$ is the real Euclidean space $\mathbb{R}^{n}$. The group multiplication $\circledast$ will be extended as multiplication in the linear span and the identity $\vec{e}_{1}$ will be the multiplicative identity in the group algebra $\mathbb{R}\left[\mathfrak{G}_{n}\right]$ which is denoted by $\mathbb{R}_{n}$. We name $\mathbb{R}_{n}$ the Euclidean algebra because this definition of multiplication works for all Euclidean space over $\mathbb{R}$ in a natural way. In our notation, the complex number system $\mathbb{C}$ is $\mathbb{R}\left[\mathfrak{G}_{2}\right]=\mathbb{R}_{2}$, where the cyclic group $\mathfrak{G}_{2}$ is $\left\{i, i^{2}=-1, i^{3}=-i, i^{4}=1\right\}$.

Let $A$ be the Davenport's hypercomplex number system [3]. It has a linear basis $\{1, \vec{i}, \vec{j}, \vec{k}\}$. An element $\vec{u}$ in $A$ is in the form

$$
\vec{u}=a+b \vec{i}+c \vec{j}+d \vec{k} .
$$

The multiplication table is described as

$$
\begin{aligned}
& \overrightarrow{i j}=\overrightarrow{j i}=\vec{k} ; \\
& \overrightarrow{j k}=\vec{k} \vec{j}=-\vec{i} ; \\
& \vec{k} \vec{i}=\overrightarrow{i k}=-\vec{j} ; \\
& \vec{i}^{2}=\vec{j}^{2}=-\vec{k}^{2}=-1 .
\end{aligned}
$$

In $A$, one has $\vec{u}^{2}= \pm 1$ for $\vec{u}=1, \vec{i}, \vec{j}, \vec{k}$. An element in $\mathbb{R}_{4}$ has the form

$$
\vec{v}=a_{1} \vec{e}_{1}+a_{2} \vec{e}_{2}+a_{3} \vec{e}_{3}+a_{4} \vec{e}_{4} .
$$

To compare $\mathbb{R}_{4}$ with $A$, we want to find all solutions that satisfies $\vec{v}^{2}= \pm 1$, or equivalently:

$$
\left(a_{1} \vec{e}_{1}+a_{2} \vec{e}_{2}+a_{3} \vec{e}_{3}+a_{4} \vec{e}_{4}\right)^{2}= \pm 1
$$

which is

$$
\left\{\begin{array}{l}
a_{1}^{2}-2 a_{2} a_{4}-a_{3}^{2}= \pm 1 \\
2 a_{1} a_{2}-2 a_{3} a_{4}=0 \\
2 a_{1} a_{3}+a_{2}^{2}-a_{4}^{2}=0 \\
2 a_{1} a_{4}+2 a_{2} a_{3}=0
\end{array}\right.
$$

The solutions to the above system of equations are:

$$
\left\{\begin{array}{l}
a_{1}= \pm 1 \\
a_{2}=a_{3}=a_{4}=0
\end{array}, \quad\left\{\begin{array}{l}
a_{3}= \pm 1 \\
a_{1}=a_{2}=a_{4}=0
\end{array}\right.\right.
$$

which means there are only 4 solutions for $\vec{v}:\left\{ \pm \vec{e}_{1}, \pm \vec{e}_{3}\right\}$. However, they are linearly dependent, hence can not form a basis for $\mathbb{R}_{4}$. So,

Theorem 7.1. It is impossible to find a new basis $\left\{\vec{v}_{1}, \vec{v}_{1}, \vec{v}_{2}, \vec{v}_{4}\right\}$ in $\mathbb{R}_{4}$ such that $\vec{v}_{1}^{2}=\vec{v}_{2}^{2}=\vec{v}_{3}^{2}=\vec{v}_{4}^{2}= \pm 1$. In other words, $\mathbb{R}_{4}$ is not algebraically isomorphic to the Davenport's algebra $A$.

The algebra $\mathbb{R}_{4}$ is a new example of commutative hypercomplex number systerm. We believe the following statement is true. For each natural number $n \geq 3$, it is not possible to find a basis $\left\{\vec{b}_{j} \mid j=1, \cdots, n\right\}$ for the algebra $\mathbb{R}_{n}$ with properties that

$$
\vec{b}_{j}^{2}= \pm 1, j=1, \cdots, n
$$

## 8. The Hypercomplex Number System $\mathbb{R}_{4}$

In this last section we will list the basic facts of the 4-dimensional hypercomplex number system $\mathbb{R}_{4}$.
(1) $\mathbb{R}_{4}$ is a real Euclidean space with basis $\left\{\vec{e}_{1}, \vec{e}_{2}, \vec{e}_{3}, \vec{e}_{4}\right\}$. An element $\vec{v}=\left[v_{1}, v_{2}, v_{3}, v_{4}\right], v_{i} \in \mathbb{R}$ in $\mathbb{R}_{4}$ has the form

$$
\vec{v}=v_{1} \vec{e}_{1}+v_{2} \vec{e}_{2}+v_{3} \vec{e}_{3}+v_{4} \vec{e}_{4}
$$

The distance between $\vec{u}=\left[u_{1}, u_{2}, u_{3}, u_{4}\right]$ and $\vec{v}=\left[v_{1}, v_{2}, v_{3}, v_{4}\right]$ is

$$
|\vec{u}-\vec{v}|=\sqrt{\left(u_{1}-v_{1}\right)^{2}+\left(u_{2}-v_{2}\right)^{2}+\left(u_{3}-v_{3}\right)^{2}+\left(u_{4}-v_{4}\right)^{2}} .
$$

(2) The multiplication table (2.1) for this basis becomes

| $\circledast$ | $\vec{e}_{1}$ | $\vec{e}_{2}$ | $\vec{e}_{3}$ | $\vec{e}_{4}$ |
| :--- | :--- | :--- | :--- | :--- |
| $\vec{e}_{1}$ | $\vec{e}_{1}$ | $\vec{e}_{2}$ | $\vec{e}_{3}$ | $\vec{e}_{4}$ |
| $\vec{e}_{2}$ | $\vec{e}_{2}$ | $\vec{e}_{3}$ | $\vec{e}_{4}$ | $-\vec{e}_{1}$ |
| $\vec{e}_{3}$ | $\vec{e}_{3}$ | $\vec{e}_{4}$ | $-\vec{e}_{1}$ | $-\vec{e}_{2}$ |
| $\vec{e}_{4}$ | $\vec{e}_{4}$ | $-\vec{e}_{1}$ | $-\vec{e}_{2}$ | $-\vec{e}_{3}$ |

(3) By Lemma 3.1

$$
\begin{aligned}
\vec{u} \circledast \vec{v} & =\vec{v} \circledast \vec{u} \\
& =\vec{v} \varsigma(\vec{u})=\vec{u} \varsigma(\vec{v}) \\
& =\left[v_{1}, v_{2}, v_{3}, v_{4}\right]\left[\begin{array}{cccc}
u_{1} & u_{2} & u_{3} & u_{4} \\
-u_{4} & u_{1} & u_{2} & u_{3} \\
-u_{3} & -u_{4} & u_{1} & u_{2} \\
-u_{2} & -u_{3} & -u_{4} & u_{1}
\end{array}\right] \\
& =\left[u_{1}, u_{2}, u_{3}, u_{4}\right]\left[\begin{array}{cccc}
v_{1} & v_{2} & v_{3} & v_{4} \\
-v_{4} & v_{1} & v_{2} & v_{3} \\
-v_{3} & -v_{4} & v_{1} & v_{2} \\
-v_{2} & -v_{3} & -v_{4} & v_{1}
\end{array}\right]
\end{aligned}
$$

(4) Define

$$
\|\vec{u}\|=|\operatorname{det} \varsigma(\vec{u})|
$$

Then

$$
\|\vec{u} \circledast \vec{v}\|=\|\vec{u}\|\|\vec{v}\| .
$$

(5) By Example 4.1, the zero divisors of $\mathbb{R}_{4}$ are the union of 2 planes:

$$
\begin{aligned}
\mathfrak{Z}_{\mathbb{R}_{4}}= & \{[s, t,-s+\sqrt{2} t,-\sqrt{2} s+t] \mid s, t \in \mathbb{R}\} \\
& \cup\{[s, t, s-\sqrt{2} t, \sqrt{2} s-t] \mid s, t \in \mathbb{R}\}
\end{aligned}
$$

(6) Let $E$ be a Borel subset of $\mathbb{G}_{4}=\mathbb{R}_{4} \backslash \mathfrak{Z}_{\mathbb{R}_{4}}$. By Theorem 5.1, up to a constant multiplier, the Haar measure $\nu_{4}$ is,

$$
\begin{aligned}
\nu_{4}(E) & =\int_{E} \frac{1}{|\operatorname{det} \varsigma(\vec{u})|} d \mu_{4}(\vec{u}) \\
& =\int_{E} \frac{1}{\left(u_{1}^{2}-u_{3}^{2}+2 u_{2} u_{4}\right)^{2}+\left(u_{4}^{2}-u_{2}^{2}+2 u_{1} u_{3}\right)^{2}} d \mu_{4}
\end{aligned}
$$

where $\mu_{4}$ is the Lebesgue measure in $\mathbb{R}^{4}$.
