# VLASOV EQUATIONS ON DIGRAPH MEASURES 

CHRISTIAN KUEHN AND CHUANG XU


#### Abstract

Many science phenomena are described as interacting particle systems (IPS). The mean field limit (MFL) of large all-to-all coupled deterministic IPS is given by the solution of a PDE, the Vlasov Equation (VE). Yet, many applications demand IPS coupled on networks/graphs. In this paper, we are interested in IPS on directed graphs, or digraphs for short. It is interesting to know, how the limit of a sequence of digraphs associated with the IPS influences the macroscopic MFL of the IPS. This paper studies VEs on a generalized digraph, regarded as limit of a sequence of digraphs, which we refer to as a digraph measure (DGM) to emphasize that we work with its limit via measures. We provide (i) unique existence of solutions of the VE on continuous DGMs, and (ii) discretization of the solution of the VE by empirical distributions supported on solutions of an IPS via ODEs coupled on a sequence of digraphs converging to the given DGM. The result substantially extends results on one-dimensional Kuramoto-type models and we allow the underlying digraphs to be not necessarily dense. The technical contribution of this paper is a generalization of Neunzert's in-cell-particle approach from a measure-theoretic viewpoint, which is different from the known techniques in $L^{p}$-functions using graphons and their generalization via harmonic analysis of locally compact Abelian groups. Finally, we apply our results to various models in higher-dimensional Euclidean spaces in epidemiology, ecology, and social sciences.

## 1. Introduction

Dynamical systems on networks are ubiquitous with wide applications in epidemiology, ecology, physics, social sciences, engineering, computer science, economics, neuroscience, etc. It is often crucial to understand the influence of the network/graph structure on the dynamics. When the number of nodes of the underlying graph increases to infinity, a dynamical system coupled on a graph may also approach a limit system. If the convergence is pointwise, such a limit system is the so-called continuum limit of the particle system. If the convergence is weak, such a limit system is the so-called mean field limit. Classical mathematical results on mean field theory can be traced back at least to the 1980s [8, 18, 30]. The relevant limit differential equation is the so-called Vlasov Equation (VE). Recently, thanks to the development of limits of graph sequences $[26,1]$, more and more studies, see e.g. [23, 20], have emerged investigating mean field limits of particle systems (deterministic or stochastic) coupled on limits of a sequence of dense graphs, called graphons [26]. This paper is motivated by $[30,23,20]$. In [30], well-posedness and discretization of Vlasov equations on the limit of a sequence of complete graphs were established by constructing a fixed point equation. In [23], the aforementioned two topics for a particular model (Kuramoto oscillator model) coupled on graphons with one-dimensional circular phase space were investigated by extending Neunzert's idea; in [20], the results of [23] were further extended to graphops, which are operator representations of graph limits, which can be dense, sparse, or neither dense nor sparse (for precise definitions, see [1] or Section 3 below). Harmonic analysis on locally compact Abelian groups was used to address the discretization of the graphops by graphons with kernels [20].

In this paper, we aim to generalize Neunzert's approach to study well-posedness and discretization of particle systems on arbitrary finite-dimensional Euclidean space with a compact positively invariant subset coupled on generalized graphs. We point out that systems without compact positive invariant regions are technically impossible to directly apply Neunzert's approach, since respective upper estimates via Gronwall inequalities may not be possible without globally bounded Lipschitz functions in the vector field as assumed in [30, 23, 20]. Nonetheless, most applications, e.g. population models or chemical models of mass-action kinetics are only locally Lipschitz but not globally Lipschitz. In order to cover these biological examples, we utilize the compactness of a positively invariant subset and confine the initial distributions of the mean field equations to be supported on this subset. Another key technical difficulty lies in the generalization from a dense graph (graphon) to a graph limit that is not necessarily dense. Indeed, in [23] due to the existence of a kernel as a graphon, $\mathrm{L}^{p}$-convergence theory applies. Furthermore, if suitable approximations via graphons can be used to obtain more general graph limits, such as certain graphops, one can again study mean-field limits [24, 20]. However, when the graph limits are no longer based on a kernel, graphon-based techniques [23] cannot be extended in a straightforward way [28]. To address this challenge, we consider in this paper graph limits purely from the perspective of measure theory: We regard a graph limit as a measure valued bounded (continuous) function. In doing so, the continuity on the vertex variable of the generalized graphs, the so-called digraph measures (DGMs) (see Section 3 for the precise definition), is sufficient to guarantee well-posedness as well as discretization of Vlasov Equations on the DGMs. For the discretization result, we build upon the recently established results on deterministic empirical approximation of measures on Euclidean spaces [37, 12]. We also point out that the IPS we study allow for distinguishability of particles in terms of a directed generalized graph, whereas indistinguishability seems predominant in the literature where graphs are assumed to be symmetric. It is worth mentioning as well that the approach established in this paper readily adapts to dynamical systems with phase space being Riemannian manifolds such as sphere or torus, and hence apply potentially to e.g., Kuramoto models of high-order interactions [2], or the opinion dynamics model on the sphere [10]. Once we have successfully addressed the two main technical challenges, we carefully demonstrate how to apply our results to a wide variety of models ranging from epidemiology, ecology to social sciences.

## 2. Overview and main results

Here, we first provide an informal overview of the assumptions and the main results of this paper. We also outline the general strategy in a bit more detail. Precise results will be stated in Sections 4-5.

## Summary of main results.

Assumptions. Let $\mathcal{T}=[0, T]$ be the time domain of the dynamics for some $T>0$, and $r_{1}, r_{2}, r \in \mathbb{N}$. Let $\mathfrak{m}$ be the Lebesgue measure on $\mathbb{R}^{r_{2}}$. Let $\mathfrak{B}(X)$ be the Borel sigma algebra of a metric space $X$, and $\mathcal{M}_{+}(X)$ the space of all finite signed Borel measures on $X$. Let $\mathcal{B}\left(X_{1}, X_{2}\right)\left(\mathcal{C}\left(X_{1}, X_{2}\right)\right.$, respectively) the space of bounded measurable (continuous, respectively) $X_{2}$-valued functions on the space $X_{1}$. To provide the basic setup, we need to specify assumptions regarding the vertex space $X$ of the DGM $\eta$,
the vertex dynamics phase space $Y$, the vector field $h$ for the vertex dynamics, the interaction forces $g_{i}$ among different vertices, and the nonlocal mapping $V$ defining the VE. Our goal is to construct a measure-valued solution $\nu_{t}$ to the VE and prove an approximation theorem of the VE via finite-dimensional ODEs. To achieve this, we make the following assumptions.
(A1) $\left(X, \mathfrak{B}(X), \mu_{X}\right)$ is a compact Polish probability space equipped with metric induced by the $\ell_{1}$-norm of $\mathbb{R}^{r_{1}} \supseteq X$.
(A2) $(t, \psi, \phi) \mapsto g_{i}(t, \psi, \phi) \in \mathbb{R}^{r_{2}}$ is continuous in $t \in \mathcal{T}$, and locally Lipschitz continuous in $(\psi, \phi) \in \mathbb{R}^{2 r_{2}}$ uniformly in $t$, i.e., for every $(\psi, \phi) \in \mathbb{R}^{2 r_{2}}$, there exists a neighbourhood $(\psi, \phi) \ni \mathcal{N} \subseteq \mathbb{R}^{2 r_{2}}$ such that

(A3) $(t, x, \phi) \mapsto h(t, x, \phi) \in \mathbb{R}^{r_{2}}$ is continuous in $t \in \mathcal{T}$, and locally Lipschitz continuous in $\phi \in \mathbb{R}^{r_{2}}$ uniformly in $(t, x)$, i.e., for every $\phi \in \mathbb{R}^{r_{2}}$ for some $r_{2} \in \mathbb{N}$, there exists a neighbourhood $\phi \ni \mathcal{N} \subseteq \mathbb{R}^{r_{2}}$ such that

$(\mathbf{A} 4)^{\prime} \eta=\left(\eta^{1}, \ldots, \eta^{r}\right) \in\left(\mathcal{C}\left(X, \mathcal{M}_{+}(X)\right)\right)^{r}$.
(A5) $\nu . \in \mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}\left(\mathbb{R}^{r_{2}}\right)\right)\right)$ is uniformly compactly supported in the sense that there exists a compact set $E_{\nu} \subseteq \mathbb{R}^{r_{2}}$ such that $\cup_{t \in \mathbb{R}} \cup_{x \in X} \operatorname{supp}\left(\nu_{t}\right)_{x} \subseteq E_{\nu .}$.
(A6) There exists a convex compact set $Y \subseteq \mathbb{R}^{r_{2} 1}$ such that for all $\nu$. satisfying (A5) uniformly supported within $Y$, the following inequality holds:

where $\partial Y=Y \cap \overline{\mathbb{R}^{r_{2}} \backslash Y}, v(\phi)$ is the outer normal vector at $\phi$, and

(A7) $(t, x, \phi) \mapsto h(t, x, \phi) \in \mathbb{R}^{r_{2}}$ is is continuous in $x$ uniformly in $\phi$ :

where $Y$ is the compact set given in (A6). Moreover, $h$ is integrable uniformly in $x$ :

Let us provide some intuitive explanation for these assumptions. Assumption (A1) means that the underlying generalized digraphs (DGMs) have the same compact vertex space $X$. Such compactness is used in establishing discretization of DGMs.

[^0]Note that if different DGMs $\eta^{i}$ have different vertex spaces $X^{i} \subseteq \mathbb{R}^{r_{1, i}}$, then one can take $X=\cup_{i=1}^{r} X^{i} \subseteq \mathbb{R}^{r_{1}}$ with the metric induced by the $\ell_{1}$-norm of $\mathbb{R}^{r_{1}}$ with $r_{1}=\max _{1 \leq i \leq r} r_{1, i}$. Assumptions (A2)-(A3) are the standard Lipschitz conditions for the well-posedness of (non-local) ODE models. Assumption (A4) means that we interpret the graphs as measure-valued functions; note that we can think of $\eta_{x}$ as describing the local edge density or connectivity near vertex $x$. Next, we need the assumption for the approximation of the VE (i.e., the mean field equation for the IPS) that the family of graph measures $\eta_{x}$ are continuous in the vertex variable $x$, which is encoded in assumption (A4)'. We would like to remark that (A4)' is indeed not crucial for the approximation results. One can relax this assumption by allowing $x \mapsto \eta_{x}^{i}(i=1, \ldots, r)$ to have finitely many discontinuity points. Nevertheless, for the ease of exposition and to avoid arousing further difficulty in understanding the approximation, we only present the result under the continuity assumption (A4)'. In fact, such regularity condition does not exclude interesting situations, where the graph limits can be sparse, dense, or neither sparse nor dense (see the examples in Sections 3 and 5). Assumption (A5) ensures the uniform boundedness of the time-dependent measures $\nu_{t}$ in total variation norm, which is used to establish the well-posedness of the non-local equation (2.2) of characteristics (see Theorem 4.3 below). Assumption (A6) is Bony's condition [7] (also called Nagumo's condition [29]) for the existence of a compact positively invariant subset $Y$ of the equation of characteristics; for vast research on this classical topic of independent interest, c.f., [ $7,9,38,21,32,17,27,14,11]$ and [36, Chap.10]. The compactness of $Y$ in (A6) is required in (A5) for bounds of $\nu_{t}$. Assumption (A7) is technical, used to establish the continuous dependence of solutions to the VE on $h$ (see Proposition 4.5).

Equation of characteristics. Under (A1)-(A5), the Vlasov operator $V$ given in (2.1) is well defined.

Let $t_{0} \in \mathcal{T}$ and $\phi_{0} \in \mathcal{B}\left(X, \mathbb{R}^{r_{2}}\right)$. For every $x \in X$, consider the following IVP of a measure-induced differential equation

The IVP of (2.2) confined to a finite time interval $\mathcal{T}$ is the so-called equation of characteristics (or characteristic equation). When the underlying space $X$ is finite, and the measures $\left(\nu_{t}\right)_{x}$ and $\eta_{x}^{i}$ for all $x \in X$ are finitely supported, (2.2) becomes a system of ODEs coupled on a finite set of directed graphs in terms of $\left\{\eta^{i}\right\}_{1 \leq i \leq r}$. Hence, the characteristic equation forms an intermediate bridge between a finitedimensional IPS and the Vlasov equation, effectively containing the information about both systems. The well-posedness of (2.2) is standard from ODE theory.

Theorem A. Assume (A1)-(A5). Let $\phi_{0} \in \mathcal{B}\left(X ; \mathbb{R}^{r_{2}}\right)$. Then for every $x \in X$ and $t_{0} \in \mathcal{T}$, there exists a solution $\phi(t, x)$ to the IVP of (2.2) with $\phi\left(t_{0}, x\right)=\phi_{0}(x)$ for all $t \in\left(T_{\min }^{x, t_{0}}, T_{\max }^{x, t_{0}}\right) \cap \mathcal{T}$ with $\left(T_{\min }^{x, t_{0}}, T_{\max }^{x, t_{0}}\right) \subseteq \mathbb{R}$ being a neighbourhood of $t_{0}$ such that
(i) either (i-a) $T_{\max }^{x, t_{0}}>T$ or ( $i$-b) $T_{\max }^{x, t_{0}} \leq T$ and $\lim _{t \uparrow T_{\max }^{x, t_{0}}}|\phi(t, x)|=\infty$ holds, and
(ii) either (ii-a) $T_{\min }^{x, t_{0}}<0$ or (ii-b) $T_{\min }^{x, t_{0}} \geq 0$ and $\lim _{t \downarrow T_{\min }^{x, t_{0}}}|\phi(t, x)|=\infty$ holds. In addition, assume ( $\mathbf{A} \mathbf{6}$ ) and $\nu$. is uniformly supported within $Y$, then $\left(T_{\min }^{x, t_{0}}, T_{\max }^{x, 0}\right) \cap$ $\mathcal{T}=\mathcal{T}$ for all $x \in X$, and there exists a set $\left\{\mathcal{S}_{t, s}^{x}[\eta, \nu, h]\right\}_{t, s \in \mathcal{T}}$ of transformations
forming a group on $Y$ such that

As a next step, we try to link the characteristic equation to the mean-field Vlasov equation. Since $\left\{\mathcal{S}_{t, s}^{x}\right\}_{t, s \in[0,+\infty)}$ is a group, from Theorem 4.3, we have for all $x \in X$,

The pushforward under the flow $\mathcal{S}_{t, 0}^{x}[\eta, \nu, h]$ of an initial measure $\left(\nu_{0}\right)_{x} \in \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)$ defines another time-dependent measure in $\mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)$ via the following fixed point equation

In particular, if $\nu . \in \mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+, \text {abs }}\left(\mathbb{R}^{r_{2}}\right)\right)\right.$, then $\nu . \in \mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+, \text {abs }}(Y)\right)\right)$ by the positive invariance of $Y$. Hence the Vlasov operator can be represented in terms of the density $\rho(t, y, \phi):=\frac{\mathrm{d}\left(\nu_{t}\right)_{y}(\phi)}{\mathrm{d} \mu_{X}(y) \mathrm{d} \phi}$ for every $t \in \mathcal{T}$ :

be the space of densities of probabilities on $X \times Y$. Conversely, for every function $\rho: \mathcal{T} \rightarrow \mathrm{L}_{+}^{1}\left(X \times Y, \mu_{X} \otimes \mathfrak{m}\right)$,

defines $\nu . \in \mathcal{B}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$. Hence (2.3) can be transformed to the Vlasov operator (2.1) in terms of $\nu$.

Let $\rho_{0}: X \times Y \rightarrow \mathbb{R}_{+}$be continuous in $x$ for $\mathfrak{m}$-a.e. $\phi \in Y$, and integrable in $\phi$ for every $x \in X$ such that

With the above assumptions and under appropriate metrics, one can show that the operator $\mathcal{A}=\left(\mathcal{A}^{x}\right)_{x \in X}: \mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right) \rightarrow \mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$ is a contraction. Using the Banach fixed point theorem, it follows that the unique solution $\nu$. to the fixed point equation exists. The fixed point equation was named by Neunzert [30] the generalized VE, since in particular, $\left(\nu_{t}\right)_{x}$ is absolutely continuous for all $x \in X$ with its density solving the $\operatorname{VE}(2.4)$, provided the initial measure $\left(\nu_{0}\right)_{x}$ is so for all $x \in X$. Hence we obtain the well-posedness of the VE (2.4).

Theorem B. Assume (A1)-(A4) and (A6). Assume $\rho_{0}(x, \phi)$ is continuous in $x \in X$ for $\mathfrak{m}$-a.e. $\quad \phi \in Y$ such that $\rho_{0} \in \mathrm{~L}_{+}^{1}\left(X \times Y, \mu_{X} \otimes \mathfrak{m}\right)$, then there exists exists $a$
unique uniformly weak solution ${ }^{2}$ to the IVP of (2.4) with initial condition $\rho(0, x, \phi)=$ $\rho_{0}(x, \phi), x \in X, \phi \in Y$.

Based on (A1)-(A7) with (A4) replaced by (A4)', we also establish continuous dependence of solutions to the fixed point equation on the underlying DGMs $\eta^{i}$ for $i=1, \ldots, m$, on the initial measure $\nu_{0}$, as well as on function $h$ (see Proposition 4.5 in Section 4). Using this result combined with the recently established results on deterministic empirical approximation of positive measures [37, 12] (Lemma 5.4), we establish the discretization of solutions of VE over finite time interval $\mathcal{T}$ by a sequence of discrete ODE systems coupled on finite graphs converging weakly to the DGMs $\eta^{i}$.

Indeed, for any $\nu_{0} \in \mathcal{C}\left(X, \mathcal{M}_{+}(Y)\right)$ and $\eta$ satisfying (A4)', by Lemmas 5.4-5.6 in Section 5, there exists

- a partition $\left\{A_{i}^{m}\right\}_{1 \leq i \leq m}$ of $X$ and points $x_{i}^{m} \in A_{i}^{m}$ for $i=1, \ldots, m$, for every $m \in \mathbb{N}$,

Here we provide some heuristic intuition on how to understand the above approximations. Let us take $\eta$ for an example (the other approximation for $\nu$. is analogous). Note that $\left\{A_{i}^{m}\right\}_{1 \leq i \leq m}$ is a partition of $X$ with uniformly vanishing diameter $\sup _{1 \leq i \leq m} \operatorname{Diam} A_{i}^{m} \rightarrow 0$ as $m \rightarrow \infty$. Since $x \mapsto \eta_{x}$ is continuous, we have $\sup _{1 \leq i \leq m} \sup _{x, x^{\prime} \in A_{i}^{m}} d_{\mathrm{BL}}\left(\eta_{x}, \eta_{x^{\prime}}\right)$ is small for large $m$, and one can choose any point $x_{i}^{m}$ in $A_{i}^{m}$ so that $\eta_{x_{i}^{m}}$ is a representative for all fiber measures $\eta_{x}$ for $x \in A_{i}^{m}$. Then given $m \in \mathbb{N}$, for every $n \in \mathbb{N}$, one can look for uniform $n$-approximations (i.e., the deterministic empirical approximation with at most $n$ atoms) of the finite positive measure $\eta_{x_{i}^{m}}$ for each $i$, which is $\frac{b_{\ell, m, i}}{n} \sum_{j=1}^{n} \delta_{y_{(i-1) n+j}, n}$, where $b_{\ell, m, i}$ is the averaged total mass of $\eta_{x}^{\ell}$ for $x \in A_{i}^{m}$ provided $A_{i}^{m}$ is not a $\mu_{X}$-measure zero set, and is the total mass of $\eta_{x_{i}^{m}}^{\ell}$ otherwise. Equivalently, due to continuity of $\eta, \frac{1}{n} \sum_{j=1}^{n} \delta_{y_{(i-1) n+j}^{\ell, m, n}}$ is a

[^1]deterministic empirical approximation of the probability measure $\frac{1}{b_{\ell, m, i}} \eta_{x_{i}^{m}}^{\ell}$, provided $\eta_{x_{i}^{m}}^{\ell}$ is not degenerate (i.e., $b_{\ell, m, i} \neq 0$ ). The possibility that one can always construct such an approximation for a probability measure in the Euclidean space is guaranteed by recent works on deterministic empirical approximation of probabilities $[12,37]$. This is why the approximation seems different from those in e.g. [23], since all fiber measures $\eta_{x}$ are probabilities therein and the partition of $X=[0,1]$ is uniform (i.e., $\mu_{X}\left(A_{i}^{m}\right)=1 / m$ for all $i=1, \ldots, m$, where $\mu_{X}$ is the Lebesgue measure on $X)$.

Based on the above discretization of measures and functions, consider the following IVP of a coupled ODE system:

Moreover, let $\nu_{0}^{m, n} \in \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right), \eta^{\ell, m, n} \in$ $\mathcal{B}\left(X, \mathcal{M}_{+}(Y)\right)$, and $h^{m} \in \mathcal{C}\left(\mathcal{T} \times X \times Y, \mathbb{R}^{r_{2}}\right)$ be defined in (2.5), and $\nu^{m, n}$ be defined in (2.7). Then

Finally we are going to apply the above main results to models in epidemiology, ecology, and social sciences (see Section 6).

Main challenges. As pointed out in [28], no matter for continuum limit or mean field limit, the absolute continuity of underlying graph measures (i.e., a graphon-type assumption or an approximation by graphons), was crucial for all the previous Vlasov equations derived on graphs. It is believed [28] that results cannot be extended to cases, where absolute continuity fails. The reason for this is that convergence results as in [23] are established based on approximation theory of $L^{p}$-functions, and the existence of an $L^{p}$-integrable kernel is precisely the $L^{p}$-graphon. That means the approach in dealing with the approximation of VEs in [23] fails. To overcome or rather
get round this difficulty, tools from harmonic analysis for operators on locally compact Abelian groups were used in [20]. They successfully reduced the problem for graphops, which may not admit a kernel to the situation dealt with in [23], since under certain assumptions, graphops can be approximated by graphons, and thus the approximation problem can be solved. However, in general situations, the assumptions in [20] are not easy to verify, especially the crucial assumption of continuity of solutions of the VE on the vertex variable.

Here we provide a new perspective from measure theory rather than utilizing operator-theoretic methods from functional analysis. Instead of using the weak topology of the space of measures on the product space, we introduce the so-called uniform weak topology in terms of the uniform metric which induces this slightly stronger topology (than the weak topology). We then define the uniform weak solution to the VE, and show that the solution of a fixed point equation (in the sense of Neunzert [30]), coincides with the solution of the VE, provided the initial distribution is absolutely continuous. Such an approach can be viewed as a generalization of Neunzert's in-cell-method [30]. With this new setup, the additional assumption of continuity of solutions to the VE required in [20] is proved, via the Banach fixed point theorem by confining the contraction operator to the subclass $\mathcal{C}\left(\mathcal{T}, \mathcal{C}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$ of continuous in time measure-valued functions which is continuous in the vertex variable (see Proposition 4.4). We mention that to show this contraction operator from the space $\mathcal{C}\left(\mathcal{T}, \mathcal{C}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$ to itself is technically very challenging, since the pushforward of a given initial measure under the flow of the equation of characteristics may not necessarily define an operator from a space of spatially continuous measure-valued functions to the space itself.

A second difficulty comes from the compactness barrier. On the one hand, the compactness of the underlying phase space is technically crucial in [23, 20], where this compactness condition is automatically fulfilled since the phase space is the unit circle. The technical reason for this assumption is that the arguments require a global bounded Lipschitz condition of the functions appearing in the vector field of the dynamical systems. On the other hand, Neunzert's approach requires that the measure under the pushforward solution map (flow) again lies in the space of measures supported on the same phase space, so that the operator is from one metric space to the same metric space in order for the Banach fixed point theorem to apply. That explains, why Neunzert's method cannot immediately apply to Euclidean spaces, which are not compact. Most importantly, this might explain why Neunzert's approach has rarely been generalized to other models than the Kuramoto type models, since other models e.g., the epidemic models of mass-action kinetics for disease transmission and competition models have local but not global Lipschitz functions in the vector field. We mention that as Neunzert pointed out [30], as long as the functions in the vector field is not globally Lipschitz, the solution to the VE may only exist for a finite maximal time locally (which in general is numerically unknown). We deal with these problems by working on positively invariant compact subsets of the phase space. We then carefully extend the approach in several different arguments, e.g., by showing the absolute continuity of solutions of the generalized VE (i.e., the fixed point equation) via Rademacher's change of variables' formula, which classically also holds only on the entire Euclidean space. Then we construct the fixed point equation by taking initial distributions supported on the positively invariant compact subset. In this way, we overcome the above two difficulties.

In addition, there is another difficulty in the approximation of solutions to the VE. In [23], the martingale convergence theorem is applied to the Hilbert space of $\mathrm{L}^{2}$-integrable functions (graphons). In [20], such approximation relies on certain technical assumptions in harmonic analysis from the viewpoint of operators (existence of summability kernels), which are crucial for approximation of $\mathrm{L}^{1}$-integrable functions on locally compact Abelian groups. However, for graphs which are not dense (with an $\mathrm{L}^{2}$ kernel) or graphops which are not limit of graphons (e.g., when $X$ is not simply the unit interval and $\mu_{X}$ the Lebesgue measure), the two approaches aforementioned fail to help. In this paper, we use the continuity of DGMs as well as the recently established results on uniform approximation of positive measures [12, 37] (Proposition 5.1) combined with partitions of Euclidean space (Lemma 5.4) to derive an approximation of the initial distribution of the VE as well as the DGMs (Lemma 5.5 amd Lemma 5.6).
Comparison with results in the literature. In [23, 13], the model is one dimensional and posed on a single underlying generalized graph, which is symmetric and absolutely continuous (i.e., the graphon case is covered). In [20], the single underlying generalized graph is also symmetric (a certain class of graphops) with uniformly bounded fiber measures. In contrast, the main results in this paper hold for multiple generalized digraphs which potentially are not symmetric. In addition, the topology utilized in [20] which seems not easily metrizable, is also different from the uniform weak topology defined in this paper. Furthermore, the space of solutions $\mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right.$ is larger than those in [23], where all fiber measures $\left(\nu_{t}\right)_{x}$ of the probability solutions of the VE are assumed to be probabilities (with normalized total variation norm) on the state space of the model. Indeed, $\left(\nu_{t}\right)_{x}$ stands for the distribution of particles at a location $x$, and in general particles may not be homogeneously distributed over all locations, e.g., one can even find no particles on certain locations in a sparse graph. Most importantly, the reference probability measure on the vertex space $X$ is the Lebesgue measure on $[0,1][23]$ or the Haar measure on a locally compact Abelian group [20]. In contrast, in our work the reference measure is not necessarily absolutely continuous w.r.t. the Lebesgue measure on the Euclidean space. Instead, the reference measure can be singular and discrete (see the examples in Section 5). This demonstrates yet another advantage of the measure-theoretic viewpoint. Moreover, the local Lipschitz continuity assumptions (A1) and (A2) are weaker than the global ones generally assumed, e.g. in [23, 20], and local Lipschitz assumptions are the only available ones in many applications (see Section 6). In summary, we believe that a measure-theoretic approach can be extremely helpful to study a very large variety of IPS on graphs, as it exploits a natural viewpoint of graph limits [1], namely studying the graph limit purely via fiber measures.

Outline of the paper. In the next section, we introduce notation, recall preliminaries on metric spaces, measure theory, and graph theory, and establish properties of several spaces of measure-valued functions, which play a crucial role in setting up the problem. The results are subsequently used to obtain continuity properties of flows of characteristic equations. In Section 4, we establish continuity and then also Lipschitz continuity of the vector field as well as the flow of the equation of characteristics. In Section 5, we provide specific approximation schemes for measure-valued continuous functions for several underlying vertex spaces, e.g., $[0,1], \mathbb{T}^{1}, \mathbb{S}^{2}$, and $[0,1]^{2}$. Moreover, we provide discretization of VE on DGMs. In Section 6, the main results
are applied to models in epidemiology, ecology, and social sciences. A brief discussion including possible future research topics is presented in Section 7. The proofs of main results are contained in Section 8. Finally, proofs of propositions and lemmas as well as a quadratic Gronwall inequality are appended.

## 3. Preliminaries

Notation. Let $\mathbb{R}_{+}$be the set of nonnegative real numbers. For every $x \in \mathbb{R}$, let $\lfloor x\rfloor$, $\lceil x\rceil$, and $\langle x\rangle \in \mathbb{R} / \mathbb{Z}$ be the largest integer not exceeding $x$, the smallest integer not smaller than $x$, and the fractional part of $x$, respectively. For $i=1,2$, let $X_{i}$ be a complete subspace of a finite dimensional Euclidean space endowed with the metric $d_{i}$ induced by the $\ell_{1}$-norm $|\cdot|$. For instance $X_{i}$ can be a sphere or a torus in which case the metric induced by $|\cdot|$ is equivalent to the standard geodesic distance on $X_{i}$. For $i=1,2$, let $\pi_{i}$ denote the natural projection onto the $i$-th coordinate of the product space $X_{1} \times X_{2}$. For any $k \in \mathbb{N}$ and $x \in \mathbb{R}^{k}$, let $|x|$ denote the 1-norm of $x$, $\delta_{x}$ denote the Dirac measure at $x$, and $\mathfrak{m}$ be the Lebesgue measure on $\mathbb{R}^{k}$; here we omit the dependence of $\mathfrak{m}$ on the dimension $k$. For any set $A \subseteq \mathbb{R}^{k}$, let $\bar{A}$ and $\stackrel{\circ}{A}$ denote its closure and interior, respectively. Let $\operatorname{Diam} A:=\sup _{x, y \in A}|x-y|$ be its diameter (for convention, $\operatorname{Diam} A=0$ if $\# A \leq 1$ ). We use $\lambda \mid A$ to denote the uniform (probability) measure over $A$ whenever appropriate (e.g., when $A$ is either bounded but uncountable or finite and countable). Let $\mathbb{1}_{A}$ be the indicator function on $A$. Let $B \subseteq \mathbb{R}^{k}$. We say $A$ is compactly embedded in $B$ and denoted $A \subset \subset B$ if $\bar{A} \subseteq \stackrel{\circ}{B}$.

Spaces of functions on metric spaces. A function $f: X_{1} \rightarrow X_{2}$ is bounded if $f\left(X_{1}\right) \subseteq X_{2}$ is bounded. Let $\left(\mathcal{B}\left(X_{1}, X_{2}\right), d_{\infty}\right)$ be the space of bounded measurable functions $f: X_{1} \rightarrow X_{2}$ equipped with the uniform metric

Let $\mathcal{C}\left(X_{1}, X_{2}\right)\left(\mathcal{C}_{\mathbf{b}}\left(X_{1}, X_{2}\right), \mathcal{C}_{0}\left(X_{1}, X_{2}\right)\right.$, respectively $)$ be the space of continuous functions (bounded continuous functions, continuous functions with compact support, respectively) from $X_{1}$ to $X_{2}$ equipped with the same uniform metric. Recall that both $\left(\mathcal{B}\left(X_{1}, X_{2}\right), d_{\infty}\right)$ and $\left(\mathcal{C}_{b}\left(X_{1}, X_{2}\right), d_{\infty}\right)$ are complete provided $\left(X_{2}, d^{2}\right)$ is a complete metric space. Hence $\mathcal{C}\left(X_{1}, X_{2}\right)=\mathcal{C}_{b}\left(X_{1}, X_{2}\right)$ is complete provided $X_{1}$ is compact.

Let $\mathcal{L}\left(X_{1}, X_{2}\right):=\left\{g \in \mathcal{C}\left(X_{1}, X_{2}\right): \mathcal{L}(g)=\sup _{x \neq y} \frac{d_{2}(g(x), g(y))}{d_{1}(x, y)}<\infty\right\}$ be the space of Lipschitz continuous functions from $X_{1}$ to $X_{2}$. Hence $\mathcal{B} \mathcal{L}\left(X_{1}, X_{2}\right)=\mathcal{B}\left(X_{1}, X_{2}\right) \cap$ $\mathcal{L}\left(X_{1}, X_{2}\right)$ denotes the space of bounded Lipschitz continuous functions. In particular, when $X_{2}=\mathbb{R}$, we suppress $X_{2}$ in $\mathcal{B}\left(X_{1}, X_{2}\right)$ and simply write $\mathcal{B}\left(X_{1}\right)$. Similarly, we write $\mathcal{C}\left(X_{1}\right)$ for $\mathcal{C}\left(X_{1}, \mathbb{R}\right)$, etc. Let $\mathcal{B}_{1}\left(X_{1}\right)=\left\{g \in \mathcal{B}\left(X_{1}\right):\|g\|_{\infty}=\sup _{x \in X_{1}}|g(x)| \leq\right.$ $1\}, \mathcal{L}_{1}\left(X_{1}\right)=\left\{g \in \mathcal{L}\left(X_{1}\right): \mathcal{L}(g) \leq 1\right\}$, and $\mathcal{B} \mathcal{L}_{1}\left(X_{1}\right)=\left\{g \in \mathcal{B} \mathcal{L}\left(X_{1}\right): \mathcal{B} \mathcal{L}(g)=\right.$ $\left.\|g\|_{\infty}+\mathcal{L}(g) \leq 1\right\}$.

Measure theory. Let $i=1,2$. With a Borel (probability) measure $\mu_{X_{i}}$ on $X_{i}$, $\left(X_{i}, \mathfrak{B}\left(X_{i}\right), \mu_{X_{i}}\right)$ becomes a Polish (probability) measure space. Let $\mathcal{M}_{+}\left(X_{i}\right)$ be the set of all finite positive Borel measures on $X_{i}$ and $\mathcal{P}\left(X_{i}\right)$ the set of all Borel probability measures on $X_{i}$. Let $\mathcal{M}_{+, \text {abs }}\left(X_{i}\right) \subseteq \mathcal{M}_{+}\left(X_{i}\right)$ the set of finite positive absolutely continuous measures w.r.t. $\mu_{X_{i}}$. Let $\mathrm{L}^{1}\left(X_{i}, \mu_{X_{i}}\right)$ denote the set of integrable functions
w.r.t. $\mu_{X_{i}}$. For every $\mu \in \mathcal{M}_{+}\left(X_{i}\right)$, let $\operatorname{supp} \mu$ be the support of $\mu$. For $f \in \mathcal{C}_{b}\left(X_{i}\right)$, denote

\|\eta\|_{\mathrm{TV}}=\sup _{A \in \mathfrak{B}\left(X_{1}\right)} \eta(A)=\eta\left(X_{1}\right)
$$

be the total variation norm of $\eta$. Recall that $\|\cdot\|_{\mathrm{TV}}$ is a norm for the Banach space of all finite signed Borel measures [5].

The total variation norm induces the total variation metric:
$d_{\mathrm{TV}}\left(\eta^{1}, \eta^{2}\right)=\sup _{A \in \mathfrak{B}\left(X_{1}\right)}\left|\eta^{1}(A)-\eta^{2}(A)\right|=\sup _{f \in \mathcal{B}_{1}\left(X_{1}\right)} \int f \mathrm{~d}\left(\eta^{1}-\eta^{2}\right), \quad \eta^{1}, \eta^{2} \in \mathcal{M}_{+}\left(X_{1}\right)$.
For every $\eta \in \mathcal{M}_{+, \text {abs }}\left(X_{1}\right)$, let $\rho_{\eta}:=\frac{\mathrm{d} \eta}{\mathrm{d} \mu_{X_{1}}}$ denote the Radon-Nikodym derivative w.r.t. the reference measure $\mu_{X_{1}}$.

Proposition 3.3. For every $\eta^{1}, \eta^{2} \in \mathcal{M}_{+, \text {abs }}\left(X_{1}\right)$,

$$
d_{\mathrm{TV}}\left(\eta^{1}, \eta^{2}\right)=\frac{1}{2} \sup _{f \in \mathcal{B}_{1}\left(X_{1}\right)}\left|\int_{X_{1}} f(x)\left(\rho_{\eta^{1}}-\rho_{\eta^{2}}\right) \mathrm{d} \mu_{X_{1}}(x)\right|=\frac{1}{2}\left\|\rho_{\eta^{1}}-\rho_{\eta^{2}}\right\|_{L^{1}\left(X_{1}, \mu_{X_{1}}\right)}
$$

Proof. The proof is standard assuming $\eta^{1}$ and $\eta^{2}$ are probabilities [33]. Following a similar argument as in [33], we rigourously prove this conclusion without this assumption. Let $A=\left\{\rho_{\eta^{1}}>\rho_{\eta^{2}}\right\}$. Let $g=\mathbb{1}_{A}-\mathbb{1}_{X_{1} \backslash A}$. By definition, $\|g\|_{\infty} \leq 1$.

$$
\begin{align*}
d_{\mathrm{TV}}\left(\eta^{1}, \eta^{2}\right) & \geq\left|\eta^{1}(A)-\eta^{2}(A)\right|  \tag{3.1}\\
& =\frac{1}{2} \int_{X_{1}}\left(\rho_{\eta^{1}}-\rho_{\eta^{2}}\right) g \mathrm{~d} \mu_{X_{1}} \\
& =\frac{1}{2} \sup _{f \in \mathcal{B}_{1}\left(X_{1}\right)}\left|\int_{X_{1}} f(x)\left(\rho_{\eta^{1}}-\rho_{\eta^{2}}\right) \mathrm{d} \mu_{X_{1}}(x)\right| \\
& \geq \sup _{B \in \mathfrak{B}\left(X_{1}\right)}\left|\eta^{1}(B)-\eta^{2}(B)\right|=d_{\mathrm{TV}}\left(\eta^{1}, \eta^{2}\right), \tag{3.2}
\end{align*}
$$

where (3.2) holds since

$$
\left|\eta^{1}(B)-\eta^{2}(B)\right|=\frac{1}{2}\left|\int_{X_{1}}\left(\mathbb{1}_{B}-\mathbb{1}_{X_{1} \backslash B}\right)\left(\rho_{\eta^{1}}-\rho_{\eta^{2}}\right)\right|
$$

and $\left|\mathbb{1}_{B}-\mathbb{1}_{X_{1} \backslash B}\right| \leq 1$. In summary, we have shown that the two inequalities (3.1) and (3.2) are also equalities.

Define the bounded Lipschitz norm (on the space of all finite signed Borel measures):

$$
\|\nu\|_{\mathrm{BL}}:=\sup _{f \in \mathcal{B} \mathcal{L}_{1}\left(X_{1}\right)} \int_{X_{1}} f \mathrm{~d} \nu, \quad \nu \in \mathcal{M}_{+}\left(X_{1}\right),
$$

which induces the bounded Lipschitz distance: For $\nu^{1}, \nu^{2} \in \mathcal{M}_{+}\left(X_{1}\right)$,

$$
d_{\mathrm{BL}}\left(\nu^{1}, \nu^{2}\right)=\sup _{f \in \mathcal{B} \mathcal{L}_{1}\left(X_{1}\right)} \int f(x) \mathrm{d}\left(\nu^{1}(x)-\nu^{2}(x)\right) .
$$

In particular, if $\nu^{1}\left(X_{1}\right)=\nu^{2}\left(X_{1}\right)$, then $d_{\mathrm{BL}}$ is equivalent to the Kantorovich-Rubinstein metric [5]:

$$
d_{\mathrm{KR}}\left(\nu^{1}, \nu^{2}\right)=\sup _{f \in \mathcal{L}_{1}\left(X_{1}\right)} \int f(x) \mathrm{d}\left(\nu^{1}(x)-\nu^{2}(x)\right)
$$

such that

$$
d_{\mathrm{BL}}\left(\nu^{1}, \nu^{2}\right) \leq \nu^{1}\left(X_{1}\right)^{-1} d_{\mathrm{KR}}\left(\nu^{1}, \nu^{2}\right) \leq 2 \min \left\{d_{\mathrm{BL}}\left(\nu^{1}, \nu^{2}\right), d_{\mathrm{TV}}\left(\nu^{1}, \nu^{2}\right)\right\} .
$$

Moreover, $d_{\mathrm{BL}}$ also metrizes the weak-* topology on $\mathcal{M}_{+}\left(X_{1}\right)$ [5, Theorem 8.3.2] and $\left(\mathcal{M}_{+}\left(X_{1}\right), d_{\mathrm{BL}}\right)$ is a Polish space [5, Theorem 8.9.4].
Relation between measures on product spaces and measure-valued functions. The reference measure of the product space $X_{1} \times X_{2}$ is $\mu_{X_{1}} \otimes \mu_{X_{2}}$ via Carathéodory's extension. For every $\eta \in \mathcal{M}_{+}\left(X_{1} \times X_{2}\right)$ such that its first marginal $\eta \circ \pi_{1}^{-1} \ll \mu_{X_{1}}$,

$$
\eta=\mu_{X_{1}} \otimes \eta_{x}
$$

is understood in the integral sense [6, Chap.1]:

$$
\int_{X_{1} \times X_{2}} f \mathrm{~d} \eta=\int_{X_{1}} \int_{X_{2}} f(x, y) \mathrm{d} \eta_{x}(y) \mathrm{d} \mu_{X_{1}}(x), \quad \forall f \in \mathcal{C}_{b}\left(X_{1} \times X_{2}\right),
$$

where $\eta_{x}$ is called the fiber measure.
When $X_{1}$ is compact, we have $\mathcal{C}_{b}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)=\mathcal{C}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$. Let

$$
\mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)=\left\{\eta \in \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right):\left\|\eta_{x}\left(X_{2}\right)\right\|_{L^{1}\left(X_{1}, \mu_{X_{1}}\right)}=1\right\} .
$$

Analogously, let $\mathcal{C}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)=\mathcal{C}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right) \cap \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$.
By Proposition 3.6 below, one can identify every $\eta \in \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$ with a finite measure $\mu_{X_{1}} \otimes \eta_{x} \in \mathcal{M}_{+}\left(X_{1} \times X_{2}\right)$, and $\eta \in \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$ with a finite measure $\mu_{X_{1}} \otimes \eta_{x} \in \mathcal{P}\left(X_{1} \times X_{2}\right)$. Nevertheless, since the metric $d_{\infty}$ defined in (3.3) below is stronger than $d_{\mathrm{BL}}$ inducing the weak topology on $\mathcal{M}_{+}\left(X_{1} \times X_{2}\right)$, two measurevalued functions $\eta^{1}, \eta^{2} \in \mathcal{B}_{\mu_{X_{1}}}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$ identify with a same finite measure in $\mathcal{M}_{+}\left(X_{1} \times X_{2}\right)$ provided $\mu_{X_{1}}\left(\left\{\eta^{1} \neq \eta^{2}\right\}\right)=0$. Hence, we will slightly abuse any measure-valued function $\eta \in \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$ for a measure $\mu_{X_{1}} \otimes \eta_{x}$ in $\mathcal{M}_{+}\left(X_{1} \times X_{2}\right)$.

Therefore, every function in $\mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$ can be identified with a probability measure in $\mathcal{P}\left(X_{1} \times X_{2}\right)$, i.e., $\mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right) \hookrightarrow \mathcal{P}\left(X_{1} \times X_{2}\right)$. Analogously, we have $\mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right) \hookrightarrow \mathcal{M}_{+}\left(X_{1} \times X_{2}\right)$, etc.

For $\eta \in \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$, let

$$
\|\eta\|=\sup _{x \in X_{1}}\left\|\eta_{x}\right\|_{\mathrm{TV}} .
$$

Hence given $\eta^{1}, \eta^{2} \in \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$, define the uniform bounded Lipschitz metric:

$$
\begin{equation*}
d_{\infty}\left(\eta^{1}, \eta^{2}\right)=\sup _{x \in X} d_{\mathrm{BL}}\left(\eta_{x}^{1}, \eta_{x}^{2}\right) \tag{3.3}
\end{equation*}
$$

Since $\left(\mathcal{M}_{+}\left(X_{2}\right), d_{\mathrm{BL}}\right)$ is complete, both $\mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$ and $\mathcal{C}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$ equipped with the uniform bounded Lipschitz metric are complete.

We simply denote $\eta_{x}^{i}$ for $\left(\eta^{i}\right)_{x}$, and write $d_{\mathrm{BL}}$ for the Lipschitz bounded metric for $\mathcal{M}_{+}\left(X_{1} \times X_{2}\right)$.

In the following proposition, we compare the uniform bounded Lipschitz distance between two measure-valued functions $\eta^{1}, \eta^{2} \in \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$ as well as the bounded Lipschitz distance of the two measures in $\mathcal{M}_{+}\left(X_{1} \times X_{2}\right)$ identified with $\eta^{1}, \eta^{2}$.
Proposition 3.4. Let $\eta^{1}, \eta^{2} \in \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$. Then

$$
d_{\infty}\left(\eta^{1}, \eta^{2}\right) \geq d_{\mathrm{BL}}\left(\eta^{1}, \eta^{2}\right)
$$

In other words, the convergence induced by the uniform bounded Lipschitz metric is no weaker than the weak convergence.
Proof. For any $f \in \mathcal{B} \mathcal{L}\left(X_{1} \times X_{2}\right), x \in X_{1}$, we have $f(x, \cdot) \in \mathcal{B} \mathcal{L}\left(X_{2}\right)$. Note that

$$
\begin{aligned}
d_{\mathrm{BL}}\left(\eta^{1}, \eta^{2}\right) & =\sup _{f \in \mathcal{B} \mathcal{L}\left(X_{1} \times X_{2}\right)} \int_{X_{1} \times X_{2}} f(x, y) \mathrm{d}\left(\eta^{1}(x, y)-\eta^{2}(x, y)\right) \\
& =\sup _{f \in \mathcal{B} \mathcal{L}\left(X_{1} \times X_{2}\right)} \int_{X_{1} \times X_{2}} f(x, y) \mathrm{d}\left(\eta_{x}^{1}(y)-\eta_{x}^{2}(y)\right) \mathrm{d} \mu_{X_{1}}(x) \\
& \leq \sup _{f \in \mathcal{B} \mathcal{L}\left(X_{1} \times X_{2}\right)} \int_{X} d_{\mathrm{BL}}\left(\eta_{x}^{1}, \eta_{x}^{2}\right) \mathrm{d} \mu_{X}(x) \leq \sup _{x \in X_{1}} d_{\mathrm{BL}}\left(\eta_{x}^{1}, \eta_{x}^{2}\right)=d_{\infty}\left(\eta^{1}, \eta^{2}\right) .
\end{aligned}
$$

Indeed, $d_{\infty}$ can induce a stronger topology than the weak topology in $\mathcal{M}_{+}\left(X_{1} \times X_{2}\right)$.
Example 3.5. Let $X_{1}=X_{2}=[0,1]$ with $\mu_{X_{1}}=\mu_{X_{2}}=\left.\lambda\right|_{[0,1]}$. For $n \in \mathbb{N}$, let
$f(x)=1-\sqrt{1-x^{2}}, \quad f_{n}(x)=\left\{\begin{array}{l}x, \quad \text { if } 0 \leq x \leq 1-1 / n, \\ -(n-1)(x-1), \quad \text { if } 1-1 / n<x \leq 1,\end{array} \quad x \in[0,1]\right.$.
Then $f(x), f_{n}(x) \in[0,1]$ and $\left.\left.\left\{x \in X: f_{n}(x) \neq f(x)\right\}=\right] 1-1 / n, 1\right]$. Let $\eta^{n}=$ $\mu_{X} \otimes \delta_{f_{n}(x)}$ and $\eta=\mu_{X} \otimes \delta_{f(x)}$. It is easy to see that $\eta^{n}, \eta \in \mathcal{C}\left(X, \mathcal{M}_{+}(X)\right)$. Moreover,

$$
d_{\infty}\left(\eta, \eta^{n}\right)=d_{\mathrm{BL}}\left(\eta_{1}^{n}, \eta_{1}\right)=1, \quad \text { for } n \in \mathbb{N} .
$$

Hence $\lim _{n \in \mathbb{N}} d_{\infty}\left(\eta^{n}, \eta\right)=1$. On the other hand,

$$
\begin{aligned}
d_{\mathrm{BL}}\left(\eta^{n}, \eta\right) & =\sup _{g \in \mathcal{B} \mathcal{L}_{1}\left([0,1]^{2}\right)} \int_{0}^{1}\left(g(x, f(x))-g\left(x, f_{n}(x)\right)\right) \mathrm{d} x \\
& \leq \int_{0}^{1}\left|f(x)-f_{n}(x)\right| \mathrm{d} x \\
& =\int_{] 1-1 / n, 1]}\left|f(x)-f_{n}(x)\right| \mathrm{d} x \\
& \leq 2 / n \rightarrow 0, \quad \text { as } \quad n \rightarrow \infty,
\end{aligned}
$$

which implies that $\lim _{n \rightarrow \infty} d_{\mathrm{BL}}\left(\eta^{n}, \eta\right)=0$. This shows that $d_{\infty}$ does induce a stronger topology than $d_{\mathrm{BL}}$.

Next, we provide some properties of the above function spaces which play an important role in the proof of the main results in subsequent sections.

Proposition 3.6. For $i=1,2$, let $X_{i}$ be a complete subspace of a finite dimensional Euclidean space. Assume $\left(X_{1}, \mathfrak{B}\left(X_{1}\right), \mu_{X_{1}}\right)$ is a compact probability space.
(i) For every $\eta$. $\in \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$, $\|\eta\|<\infty$.
(ii) $\left(\mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right), d_{\infty}\right)$ and $\left(\mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right), d_{\infty}\right)$ are complete metric spaces. In particular, $\left(\mathcal{C}_{b}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right), d_{\infty}\right)$ and $\left(\mathcal{C}_{\mu_{X_{1}}, 1}\left(X, \mathcal{M}_{+}\left(X_{2}\right)\right), d_{\infty}\right)$ are so.
Proof. (i). Let $x \in X_{1}$. Since $\eta$. $\in \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$,

$$
\sup _{y \in X} \sup _{f \in \mathcal{B} \mathcal{L}_{1}\left(X_{2}\right)}\left|\int_{X_{2}} f \mathrm{~d}\left(\eta_{x}-\eta_{y}\right)\right|=\sup _{y \in X_{1}} d_{\mathrm{BL}}\left(\eta_{x}, \eta_{y}\right)<\infty .
$$

Taking $f=\mathbb{1}_{Z}$ yields

$$
\|\eta\|=\sup _{y \in X_{1}} \eta_{y}\left(X_{2}\right) \leq \eta_{x}\left(X_{2}\right)+\sup _{y \in X_{1}} d_{\mathrm{BL}}\left(\eta_{x}, \eta_{y}\right)<\infty
$$

since $\eta_{x} \in \mathcal{M}_{+}\left(X_{2}\right)$.
(ii). It suffices to show $\left(\mathcal{B}_{\mu_{X}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right), d_{\infty}\right)$ is closed. For any Cauchy sequence $\left(\eta^{n}\right) \subseteq\left(\mathcal{B}_{\mu_{X}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right), d_{\infty}\right)$, since $\mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$ is complete, there exists $\eta \in \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$ such that $d_{\infty}\left(\eta, \eta^{n}\right) \rightarrow 0$ as $n \rightarrow \infty$. Since $\left(\eta^{n}\right)$ is Cauchy, in the light of the proof of case (i), there exists $N^{\prime} \in \mathbb{N}$ such that for all $m, n \geq N^{\prime}$,

$$
\sup _{x \in X_{1}}\left|\eta_{x}^{m}\left(X_{2}\right)-\eta_{x}^{n}\left(X_{2}\right)\right| \leq \sup _{x \in X_{1}} d_{\mathrm{BL}}\left(\eta_{x}^{m}, \eta_{x}^{n}\right)<1
$$

which implies that

$$
0 \leq \eta_{x}^{n}\left(X_{2}\right) \leq \max \left\{\eta_{x}^{N^{\prime}}\left(X_{2}\right)+1, \max _{1 \leq j \leq N^{\prime}-1} \eta_{x}^{j}\left(X_{2}\right)\right\}, \quad \forall x \in X_{1} .
$$

Since $\eta^{j} \in \mathrm{~L}^{1}\left(X_{1}, \mu_{X_{1}}\right)$ for all $1 \leq j \leq N^{\prime}$, and $\int_{X_{1}} \eta_{x}^{n}\left(X_{2}\right) \mu_{X_{1}}(x)=1$ for all $n \in \mathbb{N}$, by Dominated Convergence Theorem,

$$
\int_{X_{1}} \eta_{x}\left(X_{2}\right) \mu_{X_{1}}(x)=\lim _{n \rightarrow \infty} \int_{X_{1}} \eta_{x}^{n}\left(X_{2}\right) \mu_{X_{1}}(x)=1
$$

i.e., $\eta \in \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$.

Since the intersection of closed sets are closed, $\left(\mathcal{C}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right), d_{\infty}\right)$ is also complete.

Definition 3.7. For $i=1,2$, let $X_{i}$ be a complete subspace of a finite dimensional Euclidean space. Assume $\left(X_{1}, \mathfrak{B}\left(X_{1}\right), \mu_{X_{1}}\right)$ is a compact probability space. For

$$
\mathcal{B}_{\mu_{X}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right) \ni \eta:\left\{\begin{array}{l}
X_{1} \rightarrow \mathcal{M}_{+}\left(X_{2}\right), \\
x \mapsto \eta_{x}
\end{array}\right.
$$

$\eta$ is weakly continuous if for every $f \in \mathcal{C}_{\mathbf{b}}\left(X_{2}\right)$,

$$
\mathcal{C}\left(X_{1}\right) \ni \eta(f):\left\{\begin{array}{l}
X_{1} \rightarrow \mathbb{R}, \\
x \mapsto \eta_{x}(f):=\int_{X_{2}} f \mathrm{~d} \eta_{x}
\end{array}\right.
$$

Definition 3.8. For $i=1,2$, let $X_{i}$ be a complete subspace of a finite dimensional Euclidean space. Assume $\left(X_{1}, \mathfrak{B}\left(X_{1}\right), \mu_{X_{1}}\right)$ is a compact probability space. Let $\mathcal{I} \subseteq \mathbb{R}$ be a compact interval. For

$$
\eta .:\left\{\begin{array}{l}
\mathcal{I} \rightarrow \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right), \\
t \mapsto \eta_{t},
\end{array}\right.
$$

$\eta$. is uniformly weakly continuous if for every $f \in \mathcal{C}_{\mathrm{b}}\left(X_{2}\right), t \mapsto\left(\eta_{t}\right)_{x}(f)$ is continuous in $t$ uniformly in $x \in X_{1}$.

By slightly abusing the notation, for $\eta . \in \mathcal{C}\left(\mathcal{I}, \mathcal{B}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)\right)$, let

$$
\|\eta \cdot\|=\sup _{t \in \mathcal{I}} \sup _{x \in X_{1}}\left\|\left(\eta_{t}\right)_{x}\right\|_{\mathrm{TV}} .
$$

The following proposition unveils the relation between continuity and (uniform) weak continuity.

Proposition 3.9. For $i=1,2$, let $X_{i}$ be a complete subspace of a finite dimensional Euclidean space. Assume $\left(X_{1}, \mathfrak{B}\left(X_{1}\right), \mu_{X_{1}}\right)$ is a compact probability space. Let $\mathcal{I} \subseteq \mathbb{R}$ be a compact interval.
(i) Let $\eta$.: $\mathcal{I} \rightarrow \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$. Then $\eta$. is uniformly weakly continuous if and only if $\eta . \in \mathcal{C}\left(\mathcal{I}, \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)\right)$.
(ii) Assume $\eta$., $\xi . \in \mathcal{C}\left(\mathcal{I}, \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)\right)$, then $\| \eta$. $\|<\infty$ and $t \mapsto d_{\infty}\left(\eta_{t}, \xi_{t}\right)$ is continuous.
(iii) Assume $\eta \in \mathcal{C}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$. Then $\eta$ is weakly continuous.

Proof. (i)
Step I. Uniform weak continuity implies continuity. Assume $\eta$. is uniformly weakly continuous. Fix $t \in \mathcal{I}$ and $\mathcal{I} \supseteq t_{j} \rightarrow t$. Since $\eta$. is uniformly weakly continuous, for every $f \in \mathcal{C}_{\mathrm{b}}\left(X_{2}\right)$,

$$
\left(\eta_{t_{j}}\right)_{x}(f) \rightarrow\left(\eta_{t}\right)_{x}(f) \quad \text { uniformly in } x .
$$

Since $X_{2}$ is Polish, $d_{\mathrm{BL}}$ metrizes the weak-* topology of $\mathcal{M}_{+}\left(X_{2}\right)$ [5, Thm. 8.3.2], and we have

$$
\lim _{j \rightarrow \infty} d_{\mathrm{BL}}\left(\left(\eta_{t_{j}}\right)_{x},\left(\eta_{t}\right)_{x}\right)=0,
$$

and the convergence is uniform in $x \in X_{1}$. This means that

$$
\lim _{j \rightarrow \infty} \sup _{x \in X_{1}} d_{\mathrm{BL}}\left(\left(\eta_{t_{j}}\right)_{x},\left(\eta_{t}\right)_{x}\right)=0,
$$

i.e.,

$$
\lim _{j \rightarrow \infty} d_{\infty}\left(\eta_{t_{j}}, \eta_{t}\right)=0
$$

This shows $\eta . \in \mathcal{C}\left(\mathcal{I}, \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)\right)$.
Step II. Continuity implies uniform weak continuity. Assume $\eta$. $\in \mathcal{C}\left(\mathcal{I}, \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)\right)$. For every fixed $t \in \mathcal{I}$ and $\mathcal{I} \supseteq t_{j} \rightarrow t$, we have

$$
\lim _{j \rightarrow \infty} d_{\infty}\left(\eta_{t_{j}}, \eta_{t}\right)=0
$$

Hence

$$
d_{\mathrm{BL}}\left(\left(\eta_{t_{j}}\right)_{x},\left(\eta_{t}\right)_{x}\right) \rightarrow 0, \quad \text { uniformly in } x \in X_{1} .
$$

Since $d_{\mathrm{BL}}$ metrizes the weak-* topology of $\mathcal{M}_{+}\left(X_{2}\right)$,

$$
\left(\eta_{t_{j}}\right)_{x}(f) \rightarrow\left(\eta_{t}\right)_{x}(f) \quad \forall f \in \mathcal{C}_{\mathbf{b}}\left(X_{2}\right),
$$

also uniformly in $x \in X_{1}$. This shows that $\eta$. is uniformly weakly continuous.
(ii) Since $\mathcal{I}$ is compact, and $\left(\mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right), d_{\infty}\right)$ is complete by Proposition 3.6(ii), we have $\eta$. is uniformly bounded:

$$
\sup _{t \in \mathcal{I}} \sup _{x \in X_{1}} \sup _{f \in \mathcal{B} \mathcal{L}_{1}\left(X_{2}\right)}\left|\int_{X_{2}} f \mathrm{~d}\left(\left(\eta_{t}\right)_{x}-\left(\eta_{0}\right)_{x}\right)\right|=\sup _{t \in \mathcal{I}} d_{\infty}\left(\eta_{0}, \eta_{t}\right)<\infty .
$$

Letting $f=\mathbb{1}_{X_{2}}$ yields

$$
\|\eta \cdot\| \leq\left\|\eta_{0}\right\|+\sup _{t \in \mathcal{I}} d_{\infty}\left(\eta_{0}, \eta_{t}\right)<\infty
$$

since $\eta_{0} \in \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)$.
Finally we show $t \mapsto d_{\infty}\left(\eta_{t}, \xi_{t}\right)$ is continuous, which directly follows from the following triangle inequality: For $s, t \in \mathcal{I}$,

$$
\begin{aligned}
\left|d_{\infty}\left(\xi_{t}, \eta_{t}\right)-d_{\infty}\left(\xi_{s}, \eta_{s}\right)\right| & \leq\left|d_{\infty}\left(\xi_{t}, \eta_{t}\right)-d_{\infty}\left(\xi_{t}, \eta_{s}\right)\right|+\left|d_{\infty}\left(\xi_{t}, \eta_{s}\right)-d_{\infty}\left(\xi_{s}, \eta_{s}\right)\right| \\
& \leq d_{\infty}\left(\eta_{t}, \eta_{s}\right)+d_{\infty}\left(\xi_{t}, \xi_{s}\right) \rightarrow 0, \quad \text { as }|t-s| \rightarrow 0,
\end{aligned}
$$

since $\eta ., \quad \xi . \in \mathcal{C}\left(\mathcal{I}, \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)\right)$.
(iii) The argument in Step II in (i) applies by replacing $t$ by $x$ as well as $|t-s|$ by $|x-y|$.
Definition 3.10. For $i=1,2$, let $X_{i}$ be a complete subspace of a finite dimensional Euclidean space. Assume that $\left(X_{1}, \mathfrak{B}\left(X_{1}\right), \mu_{X_{1}}\right)$ is a compact probability space. Let $\mathcal{I} \subseteq \mathbb{R}$ be a compact interval and $\alpha>0$. For $\nu_{.}^{1}, \nu_{.}^{2} \in \mathcal{C}\left(\mathcal{I}, \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)\right.$ ), let

$$
d_{\alpha}\left(\nu_{.}^{1}, \nu_{.}^{2}\right)=\sup _{t \in \mathcal{I}} \mathrm{e}^{-\alpha t} d_{\infty}\left(\nu_{t}^{1}, \nu_{t}^{2}\right)
$$

be a weighted uniform metric.
These metrics are going to be used below to establish the contraction of a mapping used in the unique existence of a fixed point equation.

Proposition 3.11. For $i=1,2$, let $X_{i}$ be a complete subspace of a finite dimensional Euclidean space. Assume that $\left(X_{1}, \mathfrak{B}\left(X_{1}\right), \mu_{X_{1}}\right)$ is a compact probability space. Let $\mathcal{I} \subseteq \mathbb{R}$ be a compact interval and $\alpha>0$. Then $\left(\mathcal{C}\left(\mathcal{I}, \mathcal{B}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)\right), d_{\alpha}\right)$ and $\left(\mathcal{C}\left(\mathcal{I}, \mathcal{C}_{\mu_{X_{1}}, 1}\left(X_{1}, \mathcal{M}_{+}\left(X_{2}\right)\right)\right), d_{\alpha}\right)$ are both complete.
Proof. Since the weighted uniform metric $d_{\alpha}$ is equivalent to the uniform metric $\sup _{t \in \mathcal{I}} \mathrm{e}^{-\alpha t} d_{\infty}\left(\nu_{t}^{1}, \nu_{t}^{2}\right)$ between $\nu_{.}^{1}$ and $\nu_{\cdot}^{2}$, the conclusions yield immediately from Proposition 3.6, since all continuous functions on $\mathcal{I}$ are bounded.

Let $X_{1}=X, X_{2}=X$ or $X_{2}=\mathbb{R}^{r_{2}}$, and $\mathcal{I}=\mathcal{T}$. The spaces $\mathcal{B}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}\left(\mathbb{R}^{r_{2}}\right)\right)\right)$, $\mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}\left(\mathbb{R}^{r_{2}}\right)\right)\right)$ and $\mathcal{C}\left(\mathcal{T}, C_{\mu_{X}, 1}\left(X, \mathcal{M}_{\text {abs }}\left(\mathbb{R}^{r_{2}}\right)\right)\right)$ will serve as the underlying spaces for initial probabilities of the generalized VEs (with the last in the sense of the classical VE), and $\mathcal{B}\left(X, \mathcal{M}_{+}(X)\right)$ and $\mathcal{C}_{\mathrm{b}}\left(X, \mathcal{M}_{+}(X)\right)$ will correspond to the space of generalized digraphs (DGMs), as illuminated below.
Digraph measures. Let $X$ be the vertex space. For any $\eta \in \mathcal{B}\left(X, \mathcal{M}_{+}(X)\right)$, the measure $\eta_{x}$ represents the "edge" from $x$ to other vertices in $X$. For instance, $\sup _{x \in X} \operatorname{supp} \eta_{x}<\infty$ is interpreted as every vertex $x$ has uniformly finitely many outward directed edges while $\inf _{x \in X} \operatorname{supp} \eta_{x}=\infty$ means that every vertex connects infinitely many other vertices. Hence $\eta$ can be viewed as a digraph.

We now classify digraph measures into sub-categories according to their denseness. Similar notions have appeared in the literature, in particular we mention the recent
theory of graphops (graph operators), where families of fiber measures associated to graphops, plays a key role in this regard [1]. Our work is motivated directly by this theory, but as we have explained above, staying purely on the level of operator theory as in [20] leads to relatively strong requirements on the graphop, so a measuretheoretic viewpoint is a natural generalization/alternative.

Definition 3.12. Any measure-valued function in $\mathcal{B}\left(X, \mathcal{M}_{+}(X)\right)$ is a digraph measure (abbreviated as "DGM").

Definition 3.13. Let $\eta \in \mathcal{B}\left(X, \mathcal{M}_{+}(X)\right)$. We say $\eta$ is symmetric w.r.t. a reference measure $\mu_{X} \in \mathcal{P}(X)$ if $\mu_{X} \otimes \eta_{x} \in \mathcal{M}_{+}\left(X^{2}\right)$ is symmetric. A symmetric DGM is called a $G M$ for short, which is also called a graphop.

That a GM can be also viewed as a graphop [1], is due to Riesz representation theorem [1]. Yet, it turns out to be crucial from a technical perspective in the context of Vlasov equations, whether one works directly with measures or via operator-theoretic representations. Indeed, it is a known theme in PDEs that the choice of solution space is critical, so our setting can be viewed as another manifestation of this problem. Furthermore, we remark that the DGM slightly generalizes the notion of graphops to the asymmetric setting. Other notions in the literature [1] can be also analogously extended to digraph measures.
Definition 3.14. A DGM $\eta \in \mathcal{B}\left(X, \mathcal{M}_{+}(X)\right)$ is called a digraphon w.r.t. a reference measure $\mu_{X} \in \mathcal{P}(X)$ if $\mu_{X} \otimes \eta_{x} \in \mathcal{M}_{+, \text {abs }}\left(X^{2}\right)$. A symmetric digraphon is a graphon [1, Sec.8].
Remark 3.15. Let $W \in \mathrm{~L}^{1}\left(X^{2}, \mu_{X} \otimes \mu_{X}\right)$ be graphon. In [23], it is assumed that $W$ is continuous in the first variable. By symmetry of graphons, this implies that $W \in \mathcal{C}\left(X^{2}\right)$. Let $\mathrm{d} \eta_{x}(y)=W(x, y) \mathrm{d} \mu(y)$. Then it is easy to show that $x \mapsto \eta_{x}$ is continuous since

$$
\begin{aligned}
d_{\mathrm{BL}}\left(\eta_{x}, \eta_{x^{\prime}}\right) & =\sup _{f \in \mathcal{B} \mathcal{L}_{1}(X)} \int_{X} f \mathrm{~d}\left(\eta_{x}-\eta_{x^{\prime}}\right) \\
& =\sup _{f \in \mathcal{B} \mathcal{L}_{1}(X)} \int_{X} f(y)\left(W(x, y)-W\left(x^{\prime}, y\right)\right) \mathrm{d} \mu_{X}(y) \\
& \leq\left\|W(x, \cdot)-W\left(x^{\prime}, \cdot\right)\right\|_{\mathrm{L}^{1}\left(X, \mu_{X}\right)},
\end{aligned}
$$

as well as the fact that the uniform convergence due to continuity implies the $L^{1}$ convergence by Dominated Convergence Theorem. This means that our main results that follow assuming only continuity of DGMs does generalize the result assuming continuous graphons as in [23] or continuous graphops which can be approximated by graphons as in [20].

Let $\mathcal{D}(X):=\left\{\eta \in \mathcal{B}\left(X, \mathcal{M}_{+}(X)\right): \sup _{x \in X} \operatorname{supp} \eta_{x}<\infty\right\}$.
Definition 3.16. A DGM $\eta \in \mathcal{D}(X)$ is called a digraphing. A symmetric digraphing is a graphing [26, 1, Sec.9].

In terms of denseness of a graph, a digraphon is dense while a digraphing is sparse [1].

In the following, we provide several examples to show the diversity of DGMs in $\mathcal{C}\left(X, \mathcal{M}_{+}(X)\right)$, in terms of the denseness as well as heterogeneity of the graphs.


Figure 1. Example 3.17. The circle graphop $\eta$, when viewed as a measure on the product space $\mathbb{S}^{1} \times \mathbb{S}^{1}=\mathbb{T}^{2} \equiv\left[0,1\left[^{2}\right.\right.$, is a uniform measure over two disjoint circles (one thin and one thick) on $\mathbb{T}^{2}$.

Example 3.17 (Circle graphop). Let $X=\mathbb{S}^{1}$ be the unit circle, identified with $[0,1[$ by the mapping $x \mapsto \mathrm{e}^{2 \pi \mathrm{i} x}$. Define the circle graphop $\eta$ by

$$
\eta_{x}=\delta_{\langle x+1 / 4\rangle}+\delta_{\langle x-1 / 4\rangle}, \quad x \in X .
$$

By definition, the circle graphop is a graphing, and we can view it as an abstract graph $G=(X, E)$ with $(x, y) \in E$ if and only if $x \perp y$. See Figure 1 for its illustration. One can take $\eta$ as a uniform measure over two disjoint circles on $\mathbb{T}^{2}$.

Example 3.18. (i) Let $X=\mathbb{S}^{2}$. For every $x \in \mathbb{S}^{2}$, let $x^{\perp}:=\left\{y \in \mathbb{S}^{2}: y \perp x\right\}$ be the circle on $\mathbb{S}^{2}$ perpendicular to $x$ and $\eta_{x}=\left.\lambda\right|_{x^{\perp}}$ be the uniform measure over $x^{\perp}$. This definition yields a GM $\eta: x \mapsto \eta_{x}$ that can also be viewed as a graphop, called the spherical graphop [1]. This graphop is neither a graphing nor a graphon. See Figure 2(a).
(ii) Let $X=[0,1]$. For every $x \in X$, let
$A_{x}=\left[\frac{3}{2} x, 1-\frac{3}{2} x\right] \mathbb{1}_{[0,1 / 3[ }(x)+\{1 / 2\} \mathbb{1}_{[1 / 3,2 / 3]}(x)+\left[\frac{3}{2}(1-x), 1-\frac{3}{2}(1-x)\right] \mathbb{1}_{32 / 3,1]}(x)$,
and $\eta_{x}=\left.\lambda\right|_{A_{x}}$. Hence

$$
\eta_{x} \in\left\{\begin{array}{lll}
\mathcal{M}_{+, \text {abs }}(X), & \text { if } & x \in[0,1 / 3[\cup] 2 / 3,1], \\
\mathcal{D}(X), & \text { if } & x \in[1 / 3,2 / 3] .
\end{array}\right.
$$

Moreover, it is straightforward to verify that

$$
d_{\mathrm{BL}}\left(\eta_{x}, \eta_{y}\right) \leq d_{\mathrm{TV}}\left(\eta_{x}, \eta_{y}\right) \rightarrow 0, \quad \text { as }|x-y| \rightarrow 0,
$$

which implies $\eta \in \mathcal{C}\left(X ; \mathcal{M}_{+}(X)\right)$. This DGM $\eta$ is again neither dense nor sparse, but can be viewed as a measure-a linear combination of an absolutely continuous measure supported on $([0,1 / 3] \cup[2 / 3,1]) \times[0,1]$ and a singular measure supported on $[1 / 3,2 / 3] \times\{1 / 2\}$. See Figure 2(b).
(iii) Let $X=\mathbb{S}^{1}$. Let $C$ be the Cantor set on $[0,1]$. Let $F_{\zeta c}$ be the distribution function of the uniform measure $\zeta_{C}$ over C . For every $x \in X$, define a uniform measure $\eta_{x}$ over a Cantor-like set (see Figure 3) within $\left[x, x+\frac{3}{4}[\bmod 1 \subsetneq X\right.$
by its distribution function

$$
F_{\eta_{x}}(z)=F_{\zeta c}\left(\left\langle\frac{4}{3}(z-x)\right\rangle\right), \quad z \in\left[x, x+\frac{3}{4}[\bmod 1 .\right.
$$

For every $f \in \mathcal{B} \mathcal{L}_{1}(X)$, extend it to be a periodic function on $\mathbb{R}$, we have

$$
\begin{aligned}
\left|\int f \mathrm{~d}\left(\eta_{x}-\eta_{y}\right)\right|= & \left\lvert\, \int_{[x, x+3 / 4[\bmod 1} f(z) \mathrm{d} F_{\zeta_{c}}\left(\left\langle\frac{4}{3}(z-x)\right\rangle\right)\right. \\
& \left.-\int_{[y, y+3 / 4[\bmod 1} f(z) \mathrm{d} F_{\zeta_{c}}\left(\left\langle\frac{4}{3}(z-y)\right\rangle\right) \right\rvert\, \\
= & \int_{0}^{1}\left|f\left(x+\frac{3}{4} z\right)-f\left(y+\frac{3}{4} z\right)\right| \mathrm{d} F_{\zeta_{c}}(z) \\
\leq & \int_{0}^{1} d^{X}(x, y) \mathrm{d} F_{\zeta_{c}}(z)=d^{X}(x, y),
\end{aligned}
$$

where $d^{X}(x, y)=\min \{|x-y|, 1-|x-y|\}$ is the arc length between $x$ and $y$ on $X$. This shows that $x \mapsto \eta_{x}$ is continuous, by the supremum representation of the bounded Lipschitz metric. Hence $\eta \in \mathcal{C}\left(X ; \mathcal{M}_{+}(X)\right)$ is a DGM which can be regarded as a uniform measure over a curve of Hausdorff dimension $\left(1+\frac{\log 2}{\log 3}\right)$ on $\mathbb{T}^{2}$. Moreover, $\eta$ is a continuous (since $\zeta_{\mathrm{C}}$ is so) but not absolutely continuous measure on $\mathbb{T}^{2}$.

Figure 2. Illustration for Example 3.18(i)-(ii). (a): For every vertex $x$ on the sphere, $\eta_{x}$ is the uniform measure over the circle $x^{\perp}$. (b): the shaded region is the support of the absolutely continuous part of the measure $\eta$ in Example 3.18(ii) while the thick line between ( $1 / 3,1 / 2$ ) and $(2 / 3,1 / 2)$ is the support of its singular part.

Example 3.19. Let $\zeta_{\mathrm{C}}^{-1}$ be the inverse measure of $\zeta_{\mathrm{C}}$, i.e., the quantile function of $\zeta_{\mathrm{C}}^{-1}$ is $F_{\zeta_{\mathrm{c}}}$ [37]. Note that $\zeta_{\mathrm{C}}^{-1}$ is discrete [37]. In an analogous way as demonstrated in Example 3.18(i), one can construct the following measure-valued function:

$$
F_{\eta_{x}}(z)=F_{\zeta_{\mathrm{c}}^{-1}}\left(\left\langle\frac{4}{3}(z-x)\right\rangle\right), \quad x, z \in X .
$$

$$
x+\frac{1}{4}
$$



Figure 3. Illustration of Example 3.18(iii). Construction of a Cantorlike set on $[x+1 / 4, x+1[\bmod 1$.

Hence it is easy to verify that $\eta \in \mathcal{C}\left(X ; \mathcal{M}_{+}(X)\right)$ is a DGM which can be regarded as a singular measure supported on countably smooth curves on $\mathbb{T}^{2}$. Note that in contrast to Example 3.18(iii), $\eta$ is not a continuous measure (in the sense of its joint distribution function) on $\mathbb{T}^{2}$.

Remark 3.20. In general, the space of continuous functions $\mathcal{C}(X, Y)$ is not dense in the space of bounded functions $\mathcal{B}(X, Y)$ in the uniform metric. For instance, take $X=[0,1]$ and $Y=\mathbb{R}$. Let $f=\mathbb{1}_{X \backslash \mathbb{Q}}$. Then $f$ cannot be approximated by any continuous function in the supremum norm. Hence given any $\xi \in \mathcal{P}_{\text {abs }}(Y)$, let $x \mapsto \eta_{x}=f(x) \xi$. Then $\eta \in \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+, \text {abs }}(Y)\right)$. It is obvious that $\eta$ cannot be approximated by any sequence in $\mathcal{C}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)$. This gives us a clue that using the uniform bounded Lipschitz metric, one may not expect approximation of VE on a DGM of arbitrary weak regularity (see Section 5).

## 4. Vlasov equation on the DGMs

In this section, we establish well-posedness of weak solutions to the VE (2.4). To do this, we first study the equation of characteristics, namely (4.1) below. Then we construct a fixed point equation via the solution map of the equation of characteristics. Using Lipschitz properties of the flow of the equation of characteristics, we prove the existence of a unique solution to the fixed point equation by the Banach contraction mapping theorem. Then, by establishing the connection between solutions to the fixed point equation and weak solutions of the VE, we prove the well-posedness of the VE in an indirect way. This idea originally is due to Nuenzert [30] and we provide a generalization of his method incorporating DGMs and carefuly associated choices of function spaces.
4.1. Characteristic equation. In this subsection, we will establish the Lipschitz continuity and continuity of the Vlasov operator $V[\eta, \nu ., h]$ for the characteristic equation. Recall the characteristic equation: For every $x \in X$,

$$
\begin{equation*}
\frac{\partial}{\partial t} \phi(t, x)=V[\eta, \nu . h](t, x, \phi), \quad t \in[s, T], \quad \phi(s, x)=\phi_{s}(x), \quad \text { for } 0 \leq s<T \tag{4.1}
\end{equation*}
$$

where $V[\eta, \nu, h]$ is the Vlasov operator defined by

$$
V[\eta, \nu ., h](t, x, \phi)=\sum_{i=1}^{r} \int_{X} \int_{\mathbb{R}^{r_{2}}} g_{i}(t, \psi, \phi) \mathrm{d}\left(\nu_{t}\right)_{y}(\psi) \mathrm{d} \eta_{x}^{i}(y)+h(t, x, \phi),
$$

for $t \in \mathcal{T}, x \in X$, and $\phi \in \mathbb{R}^{r_{2}}$. We first establish properties of the Vlasov operator.
Proposition 4.1. Assume (A1)-(A5). Then $V[\eta, \nu, h](t, x, \phi)$ is
(i) continuous in $t$,

where $\mathcal{L}_{\mathcal{N}}\left(g_{i}\right)\left(\mathcal{L}_{\mathcal{N}}(h)\right.$, respectively) is the Lipschitz constant of $g_{i}$ ( $h$, respectively) restricted to $\mathcal{N}$. Additionally assume (A6) with the convex compact set $Y$, then $V[\eta, \nu, h](t, x, \phi)$ is
(iii) Lipschitz continuous in $h$ with Lipschitz constant 1:

If $\lim _{K \rightarrow \infty} \sum_{i=1}^{r} d_{\infty}\left(\eta^{i}, \eta^{K, i}\right)=0$, then for every $\xi . \in \mathcal{B}\left(\mathcal{T}, \mathcal{M}_{+}(Y)\right)$, $\lim _{K \rightarrow \infty} \int_{0}^{t} \int_{Y} \sup _{x \in X}\left|V[\eta, \nu ., h](\tau, x, \phi)-V\left[\eta^{K}, \nu ., h\right](\tau, x, \phi)\right| \mathrm{d} \xi_{\tau}(\phi) \mathrm{d} \tau=0, \quad \forall t \in \mathcal{T}$, provided $\nu . \in \mathcal{C}\left(\mathcal{T}, \mathcal{C}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$. holds.
The proof of Proposition 4.1 is provided in Appendix A.
Remark 4.2. The technical property in Proposition 4.1(v) will be used in the proof of Proposition 4.4(iv) below.
Theorem 4.3. Assume (A1)-(A5). Let $\phi_{0} \in \mathcal{B}\left(X ; \mathbb{R}^{r_{2}}\right)$. Then for every $x \in X$ and $t_{0} \in \mathcal{T}$, there exists a solution $\phi(t, x)$ to the IVP of (2.2) with $\phi\left(t_{0}, x\right)=\phi_{0}(x)$ for all $t \in\left(\tau_{x, t_{0}}^{-}, \tau_{x, t_{0}}^{+}\right) \subseteq \mathcal{T}$ with $\left(\tau_{x, t_{0}}^{-}, \tau_{x, t_{0}}^{+}\right) \ni t_{0}$ such that
(i) either (i-a) $\tau_{x, t_{0}}^{+}=T$ or (i-b) $\tau_{x, t_{0}}^{+}<T$ and $\lim _{t \uparrow \tau_{x, t_{0}}^{+}}|\phi(t, x)|=\infty$ holds;
(ii) either (ii-a) $\tau_{x, t_{0}}^{-}=0$ or (ii-b) $\tau_{x, t_{0}}^{-}>0$ and $\lim _{t \downarrow \tau_{x, t_{0}}^{-}}|\phi(t, x)|=\infty$ holds.

In addition, assume (A6) and $\nu$. is uniformly supported within $Y$, then $\tau_{x, t_{0}}^{+}=T$ for all $x \in X$, and there exists a family of transformations $\left\{\mathcal{S}_{t, s}^{x}[\eta, \nu ., h]\right\}_{t, s \in \mathcal{T}}$ on $Y$ such that

The proof of Theorem 4.3 is provided in Section 8.
For every $\alpha>0$, let $d_{\alpha}$ be the metric in Definition 3.10. Define the following operator: For $\nu . \in\left(\mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right), d_{\alpha}\right)$,

We will show there exists $\alpha>0$ such that $\mathcal{A}[\eta, h]$ is a contraction mapping and hence by Banach fixed point theorem, the fixed point equation

admits a unique solution. Beforehand, let us investigate properties of $\mathcal{A}$.
Proposition 4.4. Assume (A1)-(A6). Let $L_{1}$ and $L_{2}$ be given in Proposition 4.1. Then $\mathcal{A}[\eta, h]$ is
(i) is continuous in $t$ : For every $\nu . \in \mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$, we have $t \mapsto(\mathcal{A}[\eta, h] \nu)_{t} \in \mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right) . \quad$ In particular, if $\quad \nu . \in \mathcal{C}(\mathcal{T}$, $\left.\mathcal{C}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$, then $\mathcal{A}[\eta, h] \nu . \in \mathcal{C}\left(\mathcal{T}, \mathcal{C}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$. Moreover, the mass conservation law holds:

\leq & \mathrm{e}^{L_{1}\left(\nu_{.}^{2}\right) t} d_{\infty}\left(\nu_{0}^{1}, \nu_{0}^{2}\right)+L_{2}\left\|\nu_{.}^{1}\right\| \mathrm{e}^{L_{1}\left(\nu_{.}^{2}\right) t} \int_{0}^{t} d_{\infty}\left(\nu_{\tau}^{1}, \nu_{\tau}^{2}\right) \mathrm{e}^{-L_{1}\left(\nu_{.}^{2}\right) \tau} \mathrm{d} \tau .
\end{aligned}

(iii) Lipschitz continuous in $h$ : For all $t \in \mathcal{T}$, and $h_{1}, h_{2}$ both fulfilling (A3) with $h$ replaced by $h_{1}, h_{2}$, respectively,

Proposition 4.5. Assume (A1)-(A4) and (A6)-(A7). Let $\nu_{0} \in \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)$, and $L_{1}, L_{2}$, and $L_{3}$ be given in Proposition 4.4. Then there exists a unique solution $\nu . \in \mathcal{C}\left(\mathcal{T}, \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$ to the fixed point equation (4.2). Moreover, the solutions have continuous dependence on
(i) the initial conditions:

where $\nu^{i}$. is the solution to (4.2) with initial condition $\nu_{0}^{i}$ for $i=1,2$.
(ii) $h$ :

where $\nu_{.}^{i}$ is the solution to (4.2) with functions $h_{i}$ for $i=1,2$.
(iii) $\eta$ : Let $\left\{\eta^{K}\right\}_{K \in \mathbb{N}}=\left\{\left(\eta^{K, i}\right)_{1 \leq i \leq r}\right\}_{K \in \mathbb{N}} \subseteq \mathcal{B}\left(X, \mathcal{M}_{+}(Y)\right)$, for $i=1, \ldots$, r. If $\lim _{K \rightarrow \infty} \sum_{i=1}^{r} d_{\infty}\left(\eta^{i}, \eta^{K, i}\right)=0$, then

The proof of Proposition 4.5 is provided in Appendix C.
4.2. VE. In this subsection, we will use properties in the previous subsection to show well-posedness of VE (2.4).

First, let us define the weak solution to (2.4).
Definition 4.6. Let $Y$ be a compact positively invariant subset of (2.2) given in Theorem 4.3. We say $\rho: \mathcal{T} \times X \times Y \rightarrow \mathbb{R}_{\geq 0}$ is a uniformly weak solution to the IVP (2.4) if for every $x \in X$, the following two conditions are satisfied:
(i) Normalization. $\int_{X} \int_{Y} \rho(t, x, \phi) \mathrm{d} \phi \mathrm{d} x=1$, for all $t \in \mathcal{T}$.
(ii) Uniform weak continuity. $t \mapsto \int_{Y} f(\phi) \rho(t, x, \phi) \mathrm{d} \phi$ is continuous uniformly in $x \in X$, for every $f \in \mathcal{C}(Y)$.
(iii) Integral identity: For all test functions $w \in \mathcal{C}^{1}(\mathcal{T} \times Y)$ with $\operatorname{supp} w \subseteq[0, T[\times U$ and $U \subset \subset Y$, the equation below holds:

$$

\int_{0}^{T} \int_{Y} \rho(t, x, \phi)\left(\frac{\partial w(t, \phi)}{\partial t}+\widehat{V}[\eta, \rho(\cdot), h](t, x, \phi)\right. & \left.\cdot \nabla_{\phi} w(t, \phi)\right) \mathrm{d} \phi \mathrm{~d} t  \tag{4.3}\\

where $\operatorname{supp} w=\overline{\{(t, u) \in \mathcal{T} \times Y: w(t, u) \neq 0\}}$ is the support of $w$, and we recall

\widehat{V}[\eta, \rho(\cdot), h](t, x, \phi)=\sum_{i=1}^{r} \int_{X} \int_{Y} g_{i}(t, \psi, \phi) \rho(t, y, \phi) \mathrm{d} \psi \mathrm{~d} \eta_{x}^{i}(y)+h(t, x, \phi) .
$$

Remark 4.7. Definition 4.6 is well-posed, since from (4.3), by choosing suitable test functions one can show that

$$
\rho(t, \cdot) \in \mathrm{L}_{+}^{1}\left(X \times Y, \mu_{X} \otimes \mathfrak{m}\right), \quad \text { for all } t \in \mathcal{T},
$$

provided $\rho_{0} \in \mathrm{~L}_{+}^{1}\left(X \times Y, \mu_{X} \otimes \mathfrak{m}\right)$ and $\rho(t, \cdot)$ solves (4.3). Hence this definition of a uniformly weak solution can be slightly stronger than the weak solution defined in [30,23], since (4.3) is required to hold for every $x \in X$ but not just $\mu_{X}$-a.e. $x \in X$. This is because for every $t \in \mathcal{T}$, we regard $\rho(t, x, \phi)$ as densities of every point $\left(\nu_{t}\right)_{x}$ on the continuous curve $\left\{\left(\nu_{t}\right)_{x}\right\}_{x \in X}$, instead of the density of a probability in the space $\mathcal{P}(X \times Y)$.

Now we present the unique existence of solutions to the VE (2.4).

Theorem 4.8. Assume (A1)-(A4) and (A6). Assume $\rho_{0}(x, \phi)$ is continuous in $x \in X$ for $\mathfrak{m}$-a.e. $\phi \in Y$ such that $\rho_{0} \in \mathrm{~L}_{+}^{1}\left(X \times Y, \mu_{X} \otimes \mathfrak{m}\right)$, then there exists exists a unique uniformly weak solution $\rho(t, x, \phi)$ to the IVP of (2.4) with initial condition $\rho(0, x, \phi)=\rho_{0}(x, \phi), x \in X, \phi \in Y$.

The proof of Theorem 4.8 is provided in Section 8.

## 5. Approximation of time-dependent solutions of VE

In this section, we seek approximations of solutions of the VE in bounded Lipschitz distance by probability measures with finitely supported piecewise defined measures generated from solutions to discretized ODEs. More specifically, we construct approximation of the absolutely continuous solutions of (4.2) by finitely supported probabilities on $X \times Y$ on atoms $\left(x_{i}^{n}, \varphi_{i}^{n}(t)\right)$ with $\left(\varphi_{1}^{n}(t), \ldots, \varphi_{n}^{n}(t)\right)$ being the solution of the ODEs whose initial data are distributed asymptotically converging to the initial distribution of (4.2). In terms of measures, we seek for approximations by $\mathcal{D}(Y)$-valued step functions on $X$.

To state the approximation result, let us first recall several recent results on approximation of probability measures by deterministic empirical measures.

Proposition 5.1. [12, 37] Let $q \in \mathbb{N}$ and $\mathcal{P}\left(\mathbb{R}^{q}\right)$ be the space of all Borel probability measures on $\mathbb{R}^{q}$. Let $\eta \in \mathcal{P}\left(\mathbb{R}^{q}\right)$. Assume $\eta$ is compactly supported. Then there exists a uniformly bounded sequence $\left\{z_{j}^{n}\right\}_{j=1, \ldots, n ; n \in \mathbb{N}} \subseteq \mathbb{R}^{q}$ such that

$$
\lim _{n \rightarrow \infty} d_{\mathrm{BL}}\left(\eta^{n}, \eta\right)=0
$$

where $\eta^{n}=\frac{1}{n} \sum_{\ell=1}^{n} \delta_{z_{j}^{n}}$ is a deterministic empirical approximation of $\eta$.
We first provide two one-dimensional examples to illustrate how these empirical approximations are constructed, given a probability measure.
Example 5.2. Let $X=[0,1]$. Let $\eta \in \mathcal{C}\left(X ; \mathcal{M}_{+}(X)\right)$ be defined in Example 3.18(ii). Hence $\frac{1}{\eta_{x}(X)} \eta_{x} \in \mathcal{P}(X)$, for every $x \in X$. Note that

$$
\eta_{x}(X)=\left\{\begin{array}{lll}
1-3 x, & \text { if } & x \in[0,1 / 3[ \\
1, & \text { if } & x \in[1 / 3,2 / 3] \\
3 x-2, & \text { if } & x \in] 2 / 3,1]
\end{array}\right.
$$

For every $m \in \mathbb{N}$, let

$$
\begin{gathered}
x_{i}^{m}=\frac{i}{m+1}, \quad \text { for } \quad i=1, \ldots, m, \\
\eta_{x_{i}^{m}}^{m, n}= \begin{cases}\frac{1}{n} \sum_{j=1}^{n} \delta_{\frac{3}{2}} x_{i}^{m}+\frac{j}{n+1}\left(1-\frac{3}{2} x_{i}^{m}\right), & \text { for } \quad i=1, \ldots,\left\lfloor\frac{m+1}{3}\right\rfloor-1, \\
\delta_{1 / 2}, & \text { for } \quad i=\left\lfloor\frac{m+1}{3}\right\rfloor+1, \ldots,\left\lceil\frac{2(m+1)}{3}\right\rceil-1, \\
\frac{1}{n} \sum_{j=1}^{n} \delta_{\frac{3}{2}\left(1-x_{i}^{m}\right)+\frac{j}{n+1}\left(1-\frac{3}{2}\left(1-x_{i}^{m}\right)\right),} \text { for } \quad i=\left\lceil\frac{2(m+1)}{3}\right\rceil, \ldots, m .\end{cases}
\end{gathered}
$$

It is also straightforward to show that

\lim _{n \rightarrow \infty} d_{\mathrm{BL}}\left(\frac{1}{\eta_{x_{i}^{m}(X)}} \eta_{x_{i}^{m}}, \eta_{x_{i}^{m}}^{m, n}\right)=0, \quad \text { for } i=1, \ldots, m
$$

Indeed, $\eta_{x_{i}^{m}}^{m, n}$ are the best uniform $n$-approximation of $\frac{1}{\eta_{x_{i}^{m}(X)}} \eta_{x_{i}^{m}}$ with at most $n$ atoms [37].

Example 5.3. Let $X=\mathbb{S}^{1}$ and $\eta$ be defined in Example 3.18(iii). Moreover, for every $n \in \mathbb{N}$, let $\zeta^{n}:=\frac{1}{n} \sum_{i=1}^{n} \delta_{y_{i}^{n}}$ be the best uniform approximation of the Cantor measure $\zeta_{c}[37]$. Since $\left.\operatorname{supp} \zeta^{n} \subset\right] 0,1[$ and the distance on the circle is no greater than that on the real line, for every $x \in X$, one can show that

$$
\eta_{x}^{n}:=\frac{1}{n} \sum_{i=1}^{n} \delta_{\left\langle x+\frac{3}{4} y_{i}^{n}\right\rangle},
$$

is a uniform approximation of $\eta_{x}$ such that $\lim _{n \rightarrow \infty} d_{\mathrm{BL}}\left(\eta_{x}, \eta_{x}^{n}\right)=0$.
Lemma 5.4 (Partition of $X$ ). Assume (A1). Then there exists a sequence of pairwise disjoint partitions $\left\{A_{i}^{m}: i=1, \ldots, m\right\}_{m \in \mathbb{N}}$ of $X$ such that $X=\cup_{i=1}^{m} A_{i}^{m}$ for every $m \in \mathbb{N}$ and

$$
\lim _{m \rightarrow \infty} \max _{1 \leq i \leq m} \operatorname{Diam} A_{i}^{m}=0 .
$$

The proof of Lemma 5.4 is provided in Appendix D.
Lemma 5.5 (Approximation of the initial distribution). Assume (A1) and (A7). Let $\left\{A_{i}^{m}\right\}_{1 \leq i \leq m}$ be a partition of $X$ for $m \in \mathbb{N}$ satisfying

Let $x_{i}^{m} \in A_{i}^{m}$, for $i=1, \ldots, m, m \in \mathbb{N}$. Then there exists a sequence $\left\{\varphi_{(i-1) n+j}^{m, n}: i=\right.$ $1, \ldots, m, j=1, \ldots, n\}_{n, m \in \mathbb{N}} \subseteq Y$ such that

\lim _{m \rightarrow \infty} \lim _{n \rightarrow \infty} d_{\infty}\left(\nu_{0}^{m, n}, \nu_{0}\right)=0
$$

where $\nu_{0}^{m, n} \in \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)$ with

\left(\nu_{0}^{m, n}\right)_{x}:=\sum_{i=1}^{m} \mathbb{1}_{A_{i}^{m}}(x) \frac{a_{m, i}}{n} \sum_{j=1}^{n} \delta_{\varphi_{(i-1) n+j}^{m, n}}, \quad x \in X, \\
a_{m, i}= \begin{cases}\frac{\int_{A_{i}^{m}}\left(\nu_{0}\right)_{x}(Y) \mathrm{d} \mu_{X}(x)}{\mu_{X}\left(A_{i}^{m}\right)}, & \text { if } \quad \mu_{X}\left(A_{i}^{m}\right)>0, \\

The proof of Lemma 5.5 is provided in Appendix E.
Lemma 5.6 (Approximation of the DGM). Assume (A1) and (A4)'. For every $m \in$ $\mathbb{N}$, let $A_{i}^{m}$ and $x_{i}^{m}$ be defined in Lemma 5.5 for $i=1, \ldots, m, m \in \mathbb{N}$. Then for every $\ell=1, \ldots, r$, there exists a sequence $\left\{y_{(i-1) n+j}^{\ell, m, n}: i=1, \ldots, m, j=1, \ldots, n\right\}_{m, n \in \mathbb{N}} \subseteq Y$ such that

The proof of Lemma 5.6 is provided in Appendix F.
In what follows, we provide several concrete examples of the deterministic empirical approximation of DGMs with different vertex spaces together with their partitions. All these examples can be used in the applications in Section 6.

The example below gives a high dimensional $X$ with a reference measure $\mu_{X}$ supported on a lower dimensional curve.

Example 5.7. Let $X=\left\{\left(z_{1}, z_{2}\right) \in \mathbb{R}_{+}^{2}:|z| \leq 1\right\}$ be the triangle, and $\mu_{X}=$ $\left.\right|_{\left\{\left(x_{1}, x_{2}\right) \in X: x_{1}=x_{2}\right\}}$ be the uniform measure over the line segment from $(0,0)$ to $(1 / 2,1 / 2)$. Hence $\mu_{X}$ is singular to the Lebesgue measure $\mathfrak{m}$ on $X$. Let $\eta_{x}=\left.|x| \lambda\right|_{E_{x}}$, where $E_{x}=\left\{\left(z_{1}, z_{2}\right) \in X: z_{1} x_{2}=z_{2} x_{1}\right\}$. Hence $E_{x}$ is a line through $x$ provided $x \neq 0$, and $E_{0}=X$. It is easy to verify that $x \mapsto \eta_{x}$ is continuous. Since supp $\eta_{x}=\infty$ for all $x \in X \backslash\{0\}$ and $\eta_{0}=0$, and $\eta_{x} \perp \mu_{X}$ for all $x \in X \backslash E_{(1 / 2,1 / 2)}$ and $\eta_{x} \ll \mu_{X}$ for all $x \in E_{(1 / 2,1 / 2)} \backslash\{0\}$, we have that $\eta$ is neither a graphing nor a graphon. For $x \neq 0$, the uniform measure

over the equipartition of the line segment $E_{x}$ is the best uniform approximation of $\frac{1}{|x|} \eta_{x}$. For every $m \in \mathbb{N}$, we can take the uniform partition such that $A^{m}$ is no coarser than $A^{\lfloor\sqrt{m}\rfloor^{2}}$ and no finer than $A^{\left\lceil\left.\sqrt{m}\right|^{2}\right.}$ with $\left\{A_{i}^{m^{2}}\right\}_{1 \leq i \leq m^{2}}=\{\Delta((p / m, q / m),((p+$ $1) / k, q / k),(p / k,(q+1) / k))\}_{0 \leq p, q \leq m-1}$ of $X$, consisting of $m^{2}$ congruent triangles, where $\Delta(a, b, c)$ stands for the triangle with vertices $a, b, c$. See Figure 4. Hence we can take $x_{i}^{m}$ to be any point in $A_{i}^{m} \backslash\{0\}$ and

$$

In other words, $b_{m, i}$ is the $\ell_{1}$-norm of the barycenter of $A_{i}^{m}$ w.r.t. $\mu_{X}$, provided $A_{i}^{m}$ has a non-empty intersection with the line segment $E_{(1 / 2,1 / 2)}$, and $b_{m, i}$ is the $\ell_{1}$-norm of $x_{i}^{m}$ otherwise. Moreover, there are at most $\left(1+2\left\lfloor 2^{-1}\lceil\sqrt{m}\rceil\right\rfloor\right)$ triangles $A_{i}^{m}$ with a positive $\mu_{X}$-measure (a non-empty intersection with $E_{(1 / 2,1 / 2)}$ ).

Indeed, one can also take $X$ to be a discrete subset of the Euclidean space and the DGM is neither sparse not dense.
Example 5.8. Let $X=\{1 / n\}_{n \in \mathbb{N}} \cup\{0\} \subseteq \mathbb{R}$. Let $\mu_{X}=\sum_{i=2}^{\infty} 2^{-i+1} \delta_{1 / i}, \eta \in$ $\mathcal{B}\left(X, \mathcal{M}_{+}(X)\right)$ be such that $\eta_{x}=\left.x \lambda\right|_{\{y \in X: y \geq x\}}$ for $x \in X$, where for convention $0 \lambda_{X}=0$ denotes the trivial zero measure. Since $\sup _{x \in X} \# \operatorname{supp} \eta=\infty$ and $\operatorname{supp} \mu_{X} \subsetneq$ sup $\eta_{1}$, we have $\eta \in \mathcal{C}\left(X, \mathcal{M}_{+}(X)\right)$ is neither a digraphing nor a digraphon. Hence for every $m \in \mathbb{N}$, let $A_{i}^{m}=\{1 / i\}$ for $1 \leq i<m$ and $A_{m}^{m}=\{y \in X: y \leq 1 / m\}$. Then it is easily seen that $\max _{1 \leq i \leq m} \operatorname{Diam} A^{m}=1 / m \rightarrow 0$ as $m \rightarrow \infty$. Let $x_{i}^{m}=1 / i$ for $i=1, \ldots, m$. We have $\eta_{x_{i}^{m}}=\frac{x_{i}^{m}}{i} \sum_{k=1}^{i} \delta_{1 / k}$, for $i=1, \ldots, m$. Therefore, for all $n \geq m$,

Lemma 5.9 (Approximation of $h$ ). Assume (A3) and (A7).
For every $m \in \mathbb{N}$, let

The proof of Lemma 5.9 is provided in Appendix G.
Now we are ready to provide a discretization of the the VE on the DGM by a sequence of ODEs. From Lemmas 5.4-5.6, there exists

- a partition $\left\{A_{i}^{m}\right\}_{1 \leq i \leq m}$ of $X$ and points $x_{i}^{m} \in A_{i}^{m}$ for $i=1, \ldots, m$, for every $m \in \mathbb{N}$,
- a sequence $\left\{\varphi_{(i-1) n+j}^{m, n}: i=1, \ldots, m, j=1, \ldots, n\right\}_{n, m \in \mathbb{N}} \subseteq Y$ and $\left\{a_{m, i}: i=\right.$ $1, \ldots, m\}_{m \in \mathbb{N}} \subseteq \mathbb{R}_{+}$,
- a sequence $\left\{y_{(i-1) n+j}^{\ell, m, n}: i=1, \ldots, m, j=1, \ldots, n\right\}_{m, n \in \mathbb{N}} \subseteq Y$ and $\left\{b_{\ell, m, i}: i=\right.$ $1, \ldots, m\}_{m \in \mathbb{N}} \subseteq \mathbb{R}_{+}$, for $\ell=1, \ldots, r$,
such that

Proposition 5.10. Then there exists a unique solution $\phi^{m, n}(t)=\left(\phi_{(i-1) n+j}^{m, n}(t)\right)$ to (5.2), for $m, n \in \mathbb{N}$.

The proof of Proposition 5.10 is provided in Appendix H.
For $t \in \mathcal{T}$, let $\phi^{m, n}(t)=\left(\phi_{(i-1) n+j}^{m, n}(t)\right)$ be the solution to (5.2). Define

Let $\rho(t, x, \phi)$ be the uniformly weak solution to the VE (2.4) with initial condition $\rho_{0}$. Let $\nu . \in \mathcal{C}\left(\mathcal{T} ; \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{\text {abs }}(Y)\right)\right)$ be the measure-valued function defined in terms of the uniformly weak solution to (2.4):

Moreover, let $\nu_{0}^{m, n} \in \mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right), \eta^{\ell, m, n} \in$ $\mathcal{B}\left(X, \mathcal{M}_{+}(Y)\right)$, and $h^{m} \in \mathcal{C}\left(\mathcal{T} \times X \times Y, \mathbb{R}^{r_{2}}\right)$ be defined in (5.1), and $\nu_{.}^{m, n}$ be defined in (5.3). Then

The proof of Theorem 5.11 is provided in Section 8.
Remark 5.12. The uniform integrability condition $\sup _{x \in X}\left\|\rho_{0}(x, \cdot)\right\|_{\mathrm{L}^{1}(Y, \mathfrak{m})}<\infty$ means that the uniform measure $\nu_{0}$ lies in $\mathcal{B}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)$. Although the continuity as well as the uniform integrability of the initial density is technical, it does generalize the results in [23], see Remark 3.15.
Remark 5.13. The continuity condition for DGMs (A4) ${ }^{\prime}$ can be further relaxed to $(\mathbf{A} 4)^{\prime \prime} \eta=\left(\eta^{1}, \ldots, \eta^{r}\right) \in\left(\mathcal{B}\left(X, \mathcal{M}_{+}(X)\right)\right)^{r}$ such that $\cup_{i=1}^{r}\left\{z \in X: x \mapsto \eta_{x}^{i}\right.$ is discontinuous at $z\}$ is finite.

Then $X=\left(\cup_{j=1}^{K} X_{j}\right) \cup\left(\cup_{k=1}^{K^{\prime}} z_{k}\right)$ for some $K^{\prime} \leq K$, where the function $x \mapsto \eta_{x}^{i}$ is discontinuous at $x=z_{k}$, while is continuous confined to each subset $X_{j}$. Hence one can further take partitions of every $X_{j}$, and then choose an arbitrary point in each subset of the partition together with these discontinuity points $z_{k}$ to construct the approximation of DGMs and hence the ODE approximations.

## 6. Applications

In this section, we apply our main results to several models in biology. To save the Arabic numbers in the labels of assumptions, we point out that the labels of assumptions (together with $X, Y$ ) differ from subsection to subsection.
6.1. A multi-group epidemic model without demography. In this subsection, we apply our main results to an SIS epidemic model with heterogeneous group structure.

Assume
(H1) For $\left(u_{1}, u_{2}\right) \in \mathbb{R}_{+}^{2}$, let $\beta\left(t, u_{1}, u_{2}\right) \geq 0$ be in general the disease transmission function which may not respect mass-action kinetics, and $\beta\left(t, u_{1}, u_{2}\right)=0$ provided $u_{1} u_{2}=0$. Moreover, $\beta$ is continuous in $t$, and locally Lipschitz continuous in $u_{1}, u_{2}$ uniformly in $t$.
(H2) For $u \in \mathbb{R}_{+}$, let $\gamma(t, x, u) \geq 0$ be the recovery rate function, and for every $x \in X, \gamma(t, x, u)=0$ provided $u=0$. Moreover, $\gamma$ is continuous in $t$, and Lipschitz continuous in $u \in \mathbb{R}_{+}$uniformly in $t$, and continuous in $x$ uniformly in $u$.

For any fixed $N \in \mathbb{N}$, let

where $S_{x}$ and $I_{x}$ stand for the number of susceptible and infected individuals at location $x \in X$ (or interpreted as in the group with label $x$ ).

- a partition $\left\{A_{i}^{m}\right\}_{1 \leq i \leq m}$ of $X$ and points $x_{i}^{m} \in A_{i}^{m}$ for $i=1, \ldots, m$, for every $m \in \mathbb{N}$,
- a sequence $\left\{\varphi_{(i-1) n+j}^{m, n}: i=1, \ldots, m, j=1, \ldots, n\right\}_{n, m \in \mathbb{N}} \subseteq Y$ and $\left\{a_{m, i}: i=\right.$ $1, \ldots, m\}_{m \in \mathbb{N}} \subseteq \mathbb{R}_{+}$,
- a sequence $\left\{y_{(i-1) n+j}^{m, n}: i=1, \ldots, m, j=1, \ldots, n\right\}_{m, n \in \mathbb{N}} \subseteq Y$ and $\left\{b_{m, i}: i=\right.$ $1, \ldots, m\}_{m \in \mathbb{N}} \subseteq \mathbb{R}_{+}$,

6.2. A multi-group epidemic model with demography. In this subsection we will apply our main results to an SEIRS epidemic model with demography of heterogeneous group structure. Remark 6.6. - Analogous results can be derived for models describing interaction between an abundant prey and a rare predator with an Allee effect [25], by alternating the sign of $\theta$ in (6.12) to represent the self-activation (i.e., Allee effect) instead of the self-inhibition for the predator. In particular, application of our main results covers the graphon model proposed in [16], where (6.12) with $\int_{X} \int_{Y} W_{1}\left(\psi_{1}-\phi_{1}(t, x)\right) \mathrm{d}\left(\nu_{t}\right)_{y}(\psi) \mathrm{d} \eta_{x}^{1}(y)$ replaced by

- When $\sigma$ is negative, the system can be used to model sRNA pathways with heterogeneous structure [4], where it was shown that a convex compact positively invariant set can be constructed.
- The integro-differential equation (6.12) can be regarded as a generalization of the reaction diffusion Lotka-Volterra model.
6.4. Hegselmann-Krause opinion dynamics model. To model opinion dynamics of multi-agents, consider the Hegselmann-Krause model [22]:

## 7. Discussion and outlooks

The approach in this paper naturally extends to the setting on a compact Riemannian manifold, e.g., the torus $\mathbb{T}^{m}$ or sphere $\mathbb{S}^{m}$, which are typically used in the Kuramoto models of lower or higher order interactions [2], the swarm sphere model [31], as well as models for opinion dynamics [10].

Nevertheless, the compactness of the vertex space $X$ is technically crucial. Without this, there may exist no sequence of partitions of $X$ with the maximal diameters decreasing to zero. This property is indispensable for the topology induced by $d_{\infty}$, as the continuity may not be sufficient to ensure the pointwise convergence of the distances between the fiber measures $\eta_{x}$ and their (best) uniform discrete approximations. Nonetheless, such compactness can be sacrificed, e.g., by adding some other mild condition on the homogeneity as well as uniform boundedness in total variation norm of $\eta_{x}$ for large $x$.

Although we only allow finitely many DGMs for the IPS, one may further consider IPS on countably many DGMs. This may lead to a deeper understanding how complex the geometry of digraphs (in other words, the interactions among different particles) will change the dynamics of the IPS. One other crucial matter that may arise is that the union of underlying vertex spaces may be of infinite dimensional (no longer a set in a Euclidean space).

In addition, the same topic remains open when we lose continuity (up to a finite set of discontinuity points) of underlying DGMs as well as the initial measure of the VEs in the vertex variable. Such continuity conditions seem crucial due to the topology induced by the uniform bounded Lipschitz metric. Since allowing countably many discontinuity points means the mass of fiber measures $\eta_{x}$ for $x \in X$ may not be uniformly bounded. Hence the distance between the DGM $\eta$ (even still in $\mathcal{B}\left(X, \mathcal{M}_{+}(X)\right)$ ) and any finitely supported approximation $\left(\eta^{m, n}\right)$ can be uniformly away from zero. For instance, consider the DGM in Remark 3.20. This may indicate a nice weaker topology than the uniform weak topology given in this paper will be helpful in further generalizations. We will leave it for our future work.

## 8. Proofs of main results

### 8.1. Proof of Theorem 4.3.

Proof. By Proposition 4.1, the Picard-Lindelöf's iteration [35, Theorem 2.2] yields the unique existence of solutions $\phi(t, x)$ to (2.2); moreover, it is standard to extend the solution $\phi(t, x)$ to the maximal existence interval $\left(\tau_{x, t_{0}}^{-}, \tau_{x, t_{0}}^{+}\right) \cap \mathcal{T}$ for every $x \in X$ and $t_{0} \in \mathcal{T}$ satisfying the dichotomy in (i)-(ii).

The positive invariance of $Y$ follows directly from (A6), using Bony's condition [7] (see also [17, 32, 36]). This further yields that $\phi(t, x) \in Y$ for all $t \in\left[t_{0}, \tau_{x, t_{0}}^{+}\right) \cap \mathcal{T}$ and thus (i-b) is impossible. This shows (i-a) holds. Since $t_{0} \in \mathcal{T}$ is arbitrary, the solution maps $\left\{\mathcal{S}_{t, s}^{x}[\eta, \nu ., h]\right\}_{t, s \in \mathcal{T}}$ form a group on $Y$ such that

Hence by Proposition 4.4(v)-(vi), $\nu_{t} \in \mathcal{B}_{\mu_{X}, 1}\left(X ; \mathcal{M}_{+, \mathrm{abs}}(Y)\right)$ for every $t \in \mathcal{T}$. Let

Then by the uniqueness of solutions to the fixed point equation, we obtain the uniqueness of weak solutions to the IVP of (2.4).
Step I. We show $\rho(t, x, \phi)$ in (8.1) is a weak solution to (2.4). First, by Proposition 3.9(ii), $t \mapsto \rho(t, x, \phi)$ is uniformly weakly continuous. Moreover, by Proposition 4.4(v),

- Approximation of the VE. We prove the approximation result in four steps. Roughly, we first show $\nu^{m, n}$ is the solution to a fixed point equation. Then constructing solutions to two other auxiliary fixed point equations, using continuous dependence of solutions of the fixed point equation on $\eta$., $h$, as well as the initial measure, we show the approximation result by triangle inequalities.
Step I. $\nu^{m, n}$ defined in (5.3) is the solution to the fixed point equation associated with $\eta^{m, n}$ and $h^{m}$ :

$C=\sup _{m, n \in \mathbb{N}} \frac{1}{L_{3}\left(\widehat{\nu}^{m, n}, h\right)}\left\|\bar{\nu}^{m, n}\right\| \mathrm{e}^{\left.\mathcal{B L}(h) \mathrm{e}^{L_{1}\left(\widehat{\nu}^{m, n}\right) T} T \mathrm{e}^{\left(L_{1}\left(\widehat{\nu}^{m, n}\right)+L_{2}\left(\eta^{m, n}\right) \| \bar{\nu}^{m, n}\right.} \|\right) T}<\infty$.
Step IV. Since $\nu_{.^{m, n}}$ is the solution to the fixed point equation

$$
\nu_{\cdot}^{m, n}=\mathcal{A}\left[\eta^{m, n}, \nu_{.}^{m, n}, h^{m}\right] \nu_{.}^{m, n}
$$

with initial condition $\nu_{0}^{m, n}$, by Lemma 5.5 and Proposition 4.5(i),
$d_{\infty}\left(\nu_{t}^{m, n}, \bar{\nu}_{t}^{m, n}\right) \leq \mathrm{e}^{\left(L_{1}\left(\bar{\nu}^{m, n}\right)+L_{2}\left\|\nu_{.}^{m, n}\right\|\right) t} d_{\infty}\left(\nu_{0}^{m, n}, \nu_{0}\right) \rightarrow 0, \quad$ as $n \rightarrow \infty, m \rightarrow \infty$.
In sum, from (8.6)-(8.7), by triangle inequality it yields that

$$
\lim _{m \rightarrow \infty} \lim _{n \rightarrow \infty} d_{\infty}\left(\nu_{t}, \nu_{t}^{m, n}\right)=0 .
$$

## Appendix A. Proof of Proposition 4.1

Proof. Let $E_{\nu}$. be as in (A5). Then

& t \in \mathcal{T}, x \in X, \phi \in \mathbb{R}^{r_{2}} .
\end{aligned}
$$

We prove the properties of the Vlasov operator case by case. For $i=1, \ldots, r$, let $g_{i}=\left(g_{i, 1}, \ldots, g_{i, r_{2}}\right)$.
(i) $V[\eta, \nu, h](t, x, \phi)$ is continuous in $t \in \mathcal{T}$. It suffices to show that for all $i=1, \ldots, r$ and $j=1, \ldots, r_{2}, \int_{X} \int_{\mathbb{R}^{r_{2}}} g_{i, j}(t, \psi, \phi) \mathrm{d}\left(\nu_{t}\right)_{y}(\psi) \mathrm{d} \eta_{x}^{i}(y)$ is continuous in $t$. Take any sequence $\left(t_{k}\right)_{k} \subseteq \mathcal{T}$ converging to $t$. By (A5) and Proposition 3.9(ii), we have $\nu$. is weakly continuous on $\mathcal{T}$, and hence $\int_{\mathbb{R}^{r_{2}}} g_{i, j}(t, \psi, \phi)$ $\mathrm{d}\left(\nu_{t}\right)_{y}(\psi)$ is continuous in $t \in \mathcal{T}$, for every $y \in X$. Moreover, by (A5) and Proposition 3.9(ii) again,

$$
\begin{aligned}
\sup _{y \in X}\left|\int_{\mathbb{R}^{r_{2}}} g_{i, j}\left(t_{k}, \psi, \phi\right) \mathrm{d}\left(\nu_{t_{k}}\right)_{y}(\psi)\right| & =\sup _{y \in X}\left|\int_{E_{\nu}} g_{i, j}\left(t_{k}, \psi, \phi\right) \mathrm{d}\left(\nu_{t_{k}}\right)_{y}(\psi)\right| \\
& \leq\left\|g_{i}(\cdot, \phi)\right\|_{\infty} \sup _{\tau \in \mathcal{T}} \sup _{y \in X}\left(\nu_{\tau}\right)_{y}\left(\mathbb{R}^{r_{2}}\right)<\infty
\end{aligned}
$$

where by (A1)

$$
\left\|g_{i}(\cdot, \phi)\right\|_{\infty}=\sup _{\tau \in \mathcal{T}} \sup _{\psi \in E_{\nu .}}\left|g_{i}(\tau, \psi, \phi)\right|<\infty .
$$

Hence

$$
\int_{\mathbb{R}^{r_{2}}} g_{i, j}\left(t_{k}, \psi, \phi\right) \mathrm{d}\left(\nu_{t}\right)_{y}(\psi)
$$

is integrable w.r.t. $\eta_{x}$ since $\|\eta\|<\infty$ by (A1) and Proposition 3.6. By Dominated Convergence Theorem, we have
$\lim _{k \rightarrow \infty} \int_{X} \int_{\mathbb{R}^{r_{2}}} g_{i, j}\left(t_{k}, \psi, \phi\right) \mathrm{d}\left(\nu_{t}\right)_{y}(\psi) \mathrm{d} \eta_{x}^{i}(y)=\int_{X} \int_{\mathbb{R}^{r_{2}}} g_{i, j}(t, \psi, \phi) \mathrm{d}\left(\nu_{t}\right)_{y}(\psi) \mathrm{d} \eta_{x}^{i}(y)$.
(ii) We will show $V[\eta, \nu, h](t, x, \phi)$ is locally Lipschitz continuous in $\phi$, uniformly in $(t, x)$.

We first show that

G(t, x, \phi)=\sum_{i=1}^{r} \int_{X} \int_{E_{\nu .}} g_{i}(t, \psi, \phi) \mathrm{d}\left(\nu_{t}\right)_{y}(\psi) \mathrm{d} \eta_{x}^{i}(y)

is locally Lipschitz in $\phi$, uniformly in $(t, x)$. Since $E_{\nu}$. is compact, and $g_{i}$ are locally Lipschitz in $(\psi, \phi)$, uniformly in $t \in \mathcal{T}$, by finite covering theorem, for a neighborhood $\mathcal{N} \subseteq \mathbb{R}^{r_{2}}$ of $\phi, g_{i}(t, \psi, \phi)$ are locally Lipschitz in $\phi$ with Lipschitz constant $\mathcal{L}_{\mathcal{N}}\left(g_{i}\right)$, uniformly in $\psi \in E_{\nu}$, and $t \in \mathcal{T}$, where

\mathcal{L}_{\mathcal{N}}\left(g_{i}\right)=\sup _{t \in \mathcal{T}} \sup _{x \in X} \sup _{\psi \in E_{\nu},} \sup _{\substack{\phi_{1} \neq \phi_{2}, \phi_{1}, \phi_{2} \in \mathcal{N}}} \frac{\left|g_{i}\left(t, \psi, \phi_{1}\right)-g_{i}\left(t, \psi, \phi_{2}\right)\right|}{\left|\phi_{1}-\phi_{2}\right|}<\infty .
$$

This shows that for $\phi_{1}, \phi_{2} \in \mathcal{N}$,

$$
\begin{aligned}
\left|G\left(t, x, \phi_{1}\right)-G\left(t, x, \phi_{2}\right)\right| & \leq \sum_{i=1}^{r} \int_{X} \int_{E_{\nu .}}\left|g_{i}\left(t, \psi, \phi_{1}\right)-g_{i}\left(t, \psi, \phi_{2}\right)\right| \mathrm{d}\left(\nu_{t}\right)_{y}(\psi) \mathrm{d} \eta_{x}^{i}(y) \\
& \leq \sum_{i=1}^{r} \mathcal{L}_{\mathcal{N}}\left(g_{i}\right)\left|\phi_{1}-\phi_{2}\right|\left(\nu_{t}\right)_{y}\left(\mathbb{R}^{r_{2}}\right) \eta_{x}^{i}(X)
\end{aligned}
$$

$$
\leq\|\nu \cdot\| \sum_{i=1}^{r} \mathcal{L}_{\mathcal{N}}\left(g_{i}\right)\left\|\eta^{i}\right\|\left|\phi_{1}-\phi_{2}\right|
$$

where $\left\|\eta^{i}\right\|<\infty$ by Proposition 3.6(i) and $\|\nu\|<.\infty$ by (A5) and Proposition 3.9(ii).

Similarly, for $\phi_{1}, \phi_{2} \in \mathcal{N}$,

\left|h\left(t, x, \phi_{1}\right)-h\left(t, x, \phi_{2}\right)\right| \leq \mathcal{L}_{\mathcal{N}}(h)\left|\phi_{1}-\phi_{2}\right|,
$$

where

$$
\mathcal{L}_{\mathcal{N}}(h)=\sup _{t \in \mathcal{T}} \sup _{x \in X} \sup _{\substack{\phi_{1} \neq \phi_{2}, \phi_{1}, \phi_{2} \in \mathcal{N}}} \frac{\left|h\left(t, x, \phi_{1}\right)-h\left(t, x, \phi_{2}\right)\right|}{\left|\phi_{1}-\phi_{2}\right|}<\infty .
$$

Hence $V[\nu, \eta, h](t, x, \phi)$ is locally Lipschitz in $\phi$ uniformly $(t, x)$. Altogether it yields

\sup _{t \in \mathcal{T}} \sup _{x \in X}\left|V[\eta, \nu ., h]\left(t, x, \phi_{1}\right)-V[\eta, \nu ., h]\left(t, x, \phi_{2}\right)\right| \leq L_{1}(\nu .)\left|\phi_{1}-\phi_{2}\right|,
$$

where

$$
L_{1}\left(\nu_{.}\right):=\|\nu .\| \sum_{i=1}^{r} \mathcal{L}_{\mathcal{N}}\left(g_{i}\right)\left\|\eta^{i}\right\|+\mathcal{L}_{\mathcal{N}}(h)<\infty
$$

We assume (A6) for the rest. For all $t \in \mathcal{T}$ and $x \in X$, we can rewrite $V$ as

\begin{aligned}
V[\eta, \nu ., h](t, x, \phi)=\sum_{i=1}^{r} \int_{X} \int_{Y} g_{i}(t, \psi, \phi) \mathrm{d}\left(\nu_{t}\right)_{y}(\psi) \mathrm{d} \eta_{x}^{i}(y)+h(t, x, \phi) & \\
& t \in \mathcal{T}, x \in X, \phi \in Y
\end{aligned}
$$

Since $g_{i}$ and $h$ are local Lipschitz, again by finite covering theorem, when restricted to $Y$, they are globally bounded Lipschitz with

$$
\begin{gathered}
\mathcal{L}\left(g_{i}\right)=\sup _{t \in \mathcal{T}} \sup _{\substack{\left(\psi_{1}, \phi_{1}\right) \neq\left(\psi_{2}, \phi_{2}\right),\left(\psi_{1}, \phi_{1}\right),\left(\psi_{2}, \phi_{2}\right) \in Y^{2}}} \frac{\left|g_{i}\left(t, \psi_{1}, \phi_{1}\right)-g_{i}\left(t, \psi_{2}, \phi_{2}\right)\right|}{\left|\psi_{1}-\psi_{2}\right|+\left|\phi_{1}-\phi_{2}\right|}<\infty, \\
\mathcal{L}(h)=\sup _{t \in \mathcal{T}} \sup _{x \in X} \sup _{\substack{\phi_{1} \neq \phi_{2}, \phi_{1}, \phi_{2} \in Y}} \frac{\left|h\left(t, x, \phi_{1}\right)-h\left(t, x, \phi_{2}\right)\right|}{\left|\phi_{1}-\phi_{2}\right|}<\infty, \\
\left\|g_{i}\right\|_{\infty}=\sup _{t \in \mathcal{T}} \sup _{(\psi, \phi) \in Y^{2}}\left|g_{i}(t, \psi, \phi)\right|, \quad\|h\|_{\infty}=\sup _{t \in \mathbb{R}} \sup _{x \in X} \sup _{\phi \in Y}|h(t, x, \phi)|, \\
\mathcal{B} \mathcal{L}\left(g_{i}\right)=\left\|g_{i}\right\|_{\infty}+\mathcal{L}\left(g_{i}\right), \quad \mathcal{B L}(h)=\|h\|_{\infty}+\mathcal{L}(h)
\end{gathered}
$$

(iii) $V[\eta, \nu, h](t, x, \phi)$ is Lipschitz continuous in $h$, since

\left|V\left[\eta, \nu ., h_{1}\right](t, x, \phi)-V\left[\eta, \nu_{.}, h_{2}\right](t, x, \phi)\right|=\left|h_{1}(t, x, \phi)-h_{2}(t, x, \phi)\right|,

\sup _{t \in \mathcal{T}} \sup _{x \in X} \sup _{\phi \in Y}\left|V\left[\eta, \nu ., h_{1}\right](t, x, \phi)-V\left[\eta, \nu ., h_{2}\right](t, x, \phi)\right| \leq\left\|h_{1}-h_{2}\right\|_{\infty} .
$$

(iv) We will show $V[\eta, \nu ., h](t, x, \phi)$ is Lipschitz continuous in $\nu$ :

\sup _{x \in X} \sup _{\phi \in Y}\left|V\left[\nu_{.}^{1}\right](t, x, \phi)-V\left[\nu_{.}^{2}\right](t, x, \phi)\right| \leq L_{2} d_{\infty}\left(\nu_{t}^{1}, \nu_{t}^{2}\right), \tag{A.1}
\end{equation*}
$$

for some positive and finite constant $L_{2}$.
For all $x \in X$ and $\phi \in Y$,

$$
\begin{aligned}
& \left|V\left[\nu_{.}^{1}\right](t, x, \phi)-V\left[\nu_{.}^{2}\right](t, x, \phi)\right| \\
= & \left|\sum_{i=1}^{r} \int_{X \times Y} g_{i}(t, \psi, \phi) \mathrm{d}\left(\left(\nu_{t}^{1}\right)_{y}(\psi)-\left(\nu_{t}^{2}\right)_{y}(\psi)\right) \mathrm{d} \eta_{x}^{i}(y)\right| \\
\leq & \sum_{i=1}^{r}\left(\mathcal{B L}\left(g_{i}\right)+1\right) \int_{X}\left|\int_{Y} \frac{g_{i}(t, \psi, \phi)}{\mathcal{B} \mathcal{L}\left(g_{i}\right)+1} \mathrm{~d}\left(\left(\nu_{t}^{1}\right)_{y}(\psi)-\left(\nu_{t}^{2}\right)_{y}(\psi)\right)\right| \mathrm{d} \eta_{x}^{i}(y) \\
= & \sum_{i=1}^{r}\left(\mathcal{B L}\left(g_{i}\right)+1\right) \int_{X} \sum_{j=1}^{r_{2}}\left|\int_{Y} \frac{g_{i, j}(t, \psi, \phi)}{\mathcal{B} \mathcal{L}\left(g_{i}\right)+1} \mathrm{~d}\left(\left(\nu_{t}^{1}\right)_{y}(\psi)-\left(\nu_{t}^{2}\right)_{y}(\psi)\right)\right| \mathrm{d} \eta_{x}^{i}(y) \\
\leq & r_{2} \sum_{i=1}^{r}\left(\mathcal{B L}\left(g_{i}\right)+1\right) \int_{X} d_{\mathrm{BL}}\left(\left(\nu_{t}^{1}\right)_{y},\left(\nu_{t}^{2}\right)_{y}\right) \mathrm{d} \eta_{x}^{i}(y) \\
\leq & r_{2} \sum_{i=1}^{r}\left(\mathcal{B L}\left(g_{i}\right)+1\right) \eta_{x}^{i}(X) \sup _{y \in X} d_{\mathrm{BL}}\left(\left(\nu_{t}^{1}\right)_{y},\left(\nu_{t}^{2}\right)_{y}\right) \leq L_{3} d_{\infty}\left(\nu_{t}^{1}, \nu_{t}^{2}\right),
\end{aligned}
$$

where $L_{2}:=r_{2} \sum_{i=1}^{r}\left(\mathcal{B L}\left(g_{i}\right)+1\right)\left\|\eta^{i}\right\|<\infty$ by (A1). This shows (A.1) holds.
(v) Assume $\nu . \in \mathcal{C}\left(\mathcal{T}, \mathcal{C}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$. We will show $V[\eta, \nu, h](t, x, \phi)$ is continuous in $\eta$. Since $\nu . \in \mathcal{C}\left(\mathcal{T}, \mathcal{C}_{\mu_{X}, 1}\left(X, \mathcal{M}_{+}(Y)\right)\right)$, by Proposition 3.9, for every $t \in \mathcal{T},\left(\nu_{t}\right)_{x}$ is weakly continuous in $x$ : For every $f \in \mathcal{C}(Y), x \mapsto\left(\nu_{t}\right)_{x}(f)$ is continuous.

Let $\left(\eta^{K, i}\right)_{K} \subseteq \mathcal{B}\left(X, \mathcal{M}_{+}(Y)\right)$ for $i=1, \ldots, r$ such that

\lim _{K \rightarrow \infty} d_{\mathrm{BL}}\left(\eta^{K, i}, \eta^{i}\right)=0, \quad i=1, \ldots, r .
$$

The rest is to show that for every $\xi . \in \mathcal{B}\left(\mathcal{T}, \mathcal{M}_{+}(Y)\right)$,
$\lim _{K \rightarrow \infty} \int_{0}^{t} \int_{Y} \sup _{x \in X}\left|V[\eta, \nu, h](\tau, x, \phi)-V\left[\eta^{K}, \nu ., h\right](\tau, x, \phi)\right| \mathrm{d} \xi_{\tau}(\phi) \mathrm{d} \tau=0, \quad \forall t \in \mathcal{T}$.
Note that for every given $t \in \mathcal{T}$,

\begin{aligned}
& \left|V[\eta, \nu, h](t, x, \phi)-V\left[\eta^{K}, \nu, h\right](t, x, \phi)\right| \\

Proof. Let $u(t)=\int_{0}^{t} w(s)^{2} \mathrm{~d} s+b \int_{0}^{t} w(s) \mathrm{d} s+c$, for $t \in \mathcal{T}$. Then $u(t) \geq c$ for all $t \in \mathcal{T}$ since $w(t) \geq 0$. It follows from (I.2) that for all $t \in \mathcal{T}, w(t) \leq u(t)$ and

$$
\begin{equation*}
u^{\prime}(t) \leq a u(t)^{2}+b u(t) \tag{I.3}
\end{equation*}
$$

Let $v(t)=-u(t)^{-1}$. It is easy to verify that

$$
v^{\prime}(t) \leq a-b v(t), \quad t \in \mathcal{T}
$$

Using the auxiliary function $h(t)=\mathrm{e}^{b t} v(t)$, one can show that

$$
v(t) \leq \mathrm{e}^{-b t}\left(v(0)+\frac{a}{b}\left(\mathrm{e}^{b t}-1\right)\right)
$$

i.e.,

$$
-u(t)^{-1} \leq \mathrm{e}^{-b t}\left(-c^{-1}+\frac{a}{b}\left(\mathrm{e}^{b t}-1\right)\right)
$$

It then follows from (I.1) that

$$
w(t) \leq u(t) \leq \frac{b c \mathrm{e}^{b t}}{b+a c\left(1-\mathrm{e}^{b t}\right)}
$$
