# NEW SEMI-NORM OF SEMI-HILBERTIAN SPACE OPERATORS AND ITS APPLICATION

#### Abstract

In this paper, we introduce a new semi-norm of operators on a semi-Hilbertian space, which generalizes the A-numerical radius and Aoperator semi-norm. We study the basic properties of this semi-norm, including upper and lower bounds for it. As an application of this new semi-norm, we obtain upper bounds for the A-numerical radius of semi-Hilbertian space operators, which are sharper than the earlier ones.


## 1. Introduction

Let $\mathcal{B}(\mathcal{H})$ denote the $C^{*}$-algebra of all bounded linear operators on a complex Hilbert space $\mathcal{H}$ with usual inner product $\langle.,$.$\rangle and \|$.$\| be the corresponding$ norm on $\mathcal{H}$, induced by the usual inner product $\langle.,$.$\rangle . Throughout this paper, O$ is the zero operator on $\mathcal{H}$ and $I$ is the identity operator on $\mathcal{H}$. For $T \in \mathcal{B}(\mathcal{H})$, $R(T)$ and $N(T)$ denote the range space of $T$ and null space of $T$, respectively. We denote, the norm closure of $R(T)$ in $\mathcal{H}$ by $\overline{R(T)}$ and the orthogonal projection onto $\overline{R(T)}$ by $P_{T}$. Let $A$ be a self-adjoint operator in $\mathcal{B}(\mathcal{H})$. Then $A$ is called positive if $\langle A x, x\rangle \geq 0$ for all $x \in \mathcal{H}$. Let $\mathcal{B}(\mathcal{H})^{+}$denote the cone of all positive operators on $\mathcal{B}(\mathcal{H})$, i.e.,

$$
\mathcal{B}(\mathcal{H})^{+}=\{A \in \mathcal{B}(\mathcal{H}):\langle A x, x\rangle \geq 0 \forall x \in \mathcal{H}\} .
$$

Henceforth we reserve the symbol $A$ for a positive operator on $\mathcal{H}$, i.e., $A \in \mathcal{B}(\mathcal{H})^{+}$. A functional $\langle., .\rangle_{A}: \mathcal{H} \times \mathcal{H} \longrightarrow \mathbb{C}$ defined by $\langle x, y\rangle_{A}=\langle A x, y\rangle$ for all $x, y \in \mathcal{H}$, is a semi-inner product on $\mathcal{H}$ and correspondingly $\left(\mathcal{H},\langle., .\rangle_{A}\right)$ is a semi-inner product space. The semi-norm induced by the semi-inner product $\langle., .\rangle_{A}$ is denoted by $\|.\|_{A}$, i.e., $\|x\|_{A}=\sqrt{\langle x, x\rangle_{A}}=\left\|A^{1 / 2} x\right\|$ for all $x \in \mathcal{H}$. Clearly, $\|x\|_{A}=0$ if and only if $x \in N(A)$ and therefore, $\|\cdot\|_{A}$ is a norm if and only if $A$ is one-one. Also, the semi-normed space $\left(\mathcal{H},\|\cdot\|_{A}\right)$ is complete if $R(A)$ is closed in $\mathcal{H}$. For $T \in \mathcal{B}(\mathcal{H})$, the $A$-operator semi-norm of $T$ is given by

$$
\|T\|_{A}=\sup \left\{\frac{\|T x\|_{A}}{\|x\|_{A}}: x \in \overline{R(A)}, x \neq 0\right\} .
$$

Now, $\|T\|_{A}<\infty$ if there exists a constant $c>0$ such that $\|T x\|_{A} \leq c\|x\|_{A}$ for all $x \in \mathcal{H}$ and in this case, $T$ is called $A$-bounded operator. For $T \in \mathcal{B}(\mathcal{H})$,

[^0]$A$-minimum modulus of $T$, denoted by $m_{A}(T)$ and is defined by
$$
m_{A}(T)=\inf \left\{\frac{\|T x\|_{A}}{\|x\|_{A}}: x \in \overline{R(A)}, x \neq 0\right\}
$$

For $T \in \mathcal{B}(\mathcal{H})$, an operator $R \in \mathcal{B}(\mathcal{H})$ is an $A$-adjoint of $T$ if $\langle T x, y\rangle_{A}=\langle x, R y\rangle_{A}$ for every $x, y \in \mathcal{H}$. For any $T \in \mathcal{B}(\mathcal{H})$, the existence of an $A$-adjoint of $T$ is not guaranteed. In fact, an operator $T \in \mathcal{B}(\mathcal{H})$ may admit none, one or many $A$-adjoint. By Douglas Theorem ([12]) we have that for an operator $T \in \mathcal{B}(\mathcal{H})$ if $R\left(T^{*} A\right) \subseteq R(A)$, then $T$ admits an $A$-adjoint. Let $\mathcal{B}_{A}(\mathcal{H})$ denote the collection of all operators in $\mathcal{B}(\mathcal{H})$ which admit $A$-adjoint, i.e.,

$$
\mathcal{B}_{A}(\mathcal{H})=\left\{T \in \mathcal{B}(\mathcal{H}): R\left(T^{*} A\right) \subseteq R(A)\right\}
$$

For $T \in \mathcal{B}_{A}(\mathcal{H})$, the operator equation $A X=T^{*} A$ has a unique solution $T^{\sharp A}$, satisfying $R\left(T^{\sharp_{A}}\right) \subseteq \overline{R(A)}$. Here $T^{*}$ is the adjoint of $T$. Clearly, for $T \in \mathcal{B}_{A}(\mathcal{H})$, $A T^{\sharp A}=T^{*} A$. Note that $T^{\sharp A}=A^{\dagger} T^{*} A$, where $A^{\dagger}$ is the Moore-Penrose inverse of A, (see [16]). Again, by applying Douglas theorem, we have, $\mathcal{B}_{A^{1 / 2}}(\mathcal{H})$ is the set of all operators in $\mathcal{B}(\mathcal{H})$ which admit $A^{1 / 2}$ adjoint, i.e., $R\left(T^{*} A^{1 / 2}\right) \subseteq R\left(A^{1 / 2}\right)$. It is well-known that

$$
\mathcal{B}_{A^{1 / 2}}(\mathcal{H})=\left\{T \in \mathcal{B}(\mathcal{H}): \exists c>0 \text { such that }\|T x\|_{A} \leq c\|x\|_{A} \forall x \in \mathcal{H}\right\} .
$$

Therefore, the operators in $\mathcal{B}_{A^{1 / 2}}(\mathcal{H})$ are called $A$-bounded operators. Notice that $\mathcal{B}_{A}(\mathcal{H})$ and $\mathcal{B}_{A^{1 / 2}}(\mathcal{H})$ are sub-algebras of $\mathcal{B}(\mathcal{H})$. Moreover, $\mathcal{B}_{A}(\mathcal{H}) \subseteq \mathcal{B}_{A^{1 / 2}}(\mathcal{H}) \subseteq$ $\mathcal{B}(\mathcal{H})$ and these inclusions become equalities if $A$ is one-one and has closed range. An operator $T \in \mathcal{B}(\mathcal{H})$ is said to be $A$-self-adjoint if $A T$ is self-adjoint, i.e., $A T=T^{*} A$. If $T$ is A-self-adjoint, then $T \in \mathcal{B}_{A}(\mathcal{H})$ and in general, $T \neq T^{\sharp A}$. For $T \in \mathcal{B}_{A}(\mathcal{H}), T=T^{\sharp A}$ if and only if $T$ is $A$-self-adjoint and $R(T) \subseteq \overline{R(A)}$. For $T, S \in \mathcal{B}_{A}(\mathcal{H})$, we have $\left(\left(T^{\sharp_{A}}\right)^{\sharp_{A}}\right)^{\sharp_{A}}=T^{\sharp_{A}}$, $\left(T^{\sharp_{A}}\right)^{\sharp_{A}}=P_{A} T P_{A},(T S)^{\sharp_{A}}=$ $S^{\sharp_{A}} T^{\sharp_{A}}$. Also, for $T, S \in \mathcal{B}_{A^{1 / 2}}(\mathcal{H})$, we have $\|T S\|_{A} \leq\|T\|_{A}\|S\|_{A},\|T x\|_{A} \leq$ $\|T\|_{A}\|x\|_{A}$ for all $x$ in $\mathcal{H}$. Clearly, $T^{\sharp_{A}} T$ and $T T^{\sharp A}$ are $A$-self-adjoint operators and satisfy $\left\|T T^{\sharp A}\right\|_{A}=\left\|T^{\sharp} A\right\|_{A}=\left\|T^{\sharp A}\right\|_{A}^{2}=\|T\|_{A}^{2}$. For $T \in \mathcal{B}_{A^{1 / 2}}(\mathcal{H})$, the $A$ numerical range and the A-numerical radius of $T$, denoted by $W_{A}(T)$ and $w_{A}(T)$, are defined respectively as

$$
W_{A}(T)=\left\{\langle T x, x\rangle_{A}: x \in \mathcal{H},\|x\|_{A}=1\right\}
$$

and

$$
w_{A}(T)=\sup \left\{\left|\langle T x, x\rangle_{A}\right|: x \in \mathcal{H},\|x\|_{A}=1\right\} .
$$

Similar as the A-numerical radius, the A-Crawford number of $T \in \mathcal{B}_{A^{1 / 2}}(\mathcal{H})$, denoted as $c_{A}(T)$ and is defined as

$$
c_{A}(T)=\inf \left\{\left|\langle T x, x\rangle_{A}\right|: x \in \mathcal{H},\|x\|_{A}=1\right\}
$$

It is well known that the A-numerical radius and the A-operator semi-norm are equivalent semi-norm on $\mathcal{B}_{A^{1 / 2}}(\mathcal{H})$, satisfying that for every $T \in \mathcal{B}_{A^{1 / 2}}(\mathcal{H})$,

$$
\frac{1}{2}\|T\|_{A} \leq w_{A}(T) \leq\|T\|_{A}
$$

The numerical radius inequalities and the $A$-numerical radius inequalities have been studied by many mathematicians over the years, we refer the readers to see $[5,6,7,15,19]$ for some classical numerical radius inequalities and $[8,9,14,17,20]$
for some $A$-numerical radius inequalities. Motivated by the new norm [18], for each $\alpha \in[0,1]$, we introduce $A_{\alpha}$-semi-norm on $\mathcal{B}_{A^{1 / 2}}(\mathcal{H})$, defined as follows:

$$
\|T\|_{A_{\alpha}}=\sup \left\{\sqrt{\alpha\left|\langle T x, x\rangle_{A}\right|^{2}+(1-\alpha)\|T x\|_{A}^{2}}: x \in \mathcal{H},\|x\|_{A}=1\right\} .
$$

If $\alpha=1$, then $\|T\|_{A_{\alpha}}=w_{A}(T)$ and if $\alpha=0$, then $\|T\|_{A_{\alpha}}=\|T\|_{A}$. Considering $A=I$ we get, recently introduced the $\alpha$-norm on $\mathcal{B}(\mathcal{H})$, (see in [11, 18]).
In this article, we study the basic properties of this semi-norm. We also develope upper and lower bounds for $A_{\alpha}$-numerical radius. Applying these inequalities we obtain upper bounds for the $A$-numerical radius which improve and generalize the existing ones.

## 2. Main results

We begin this section with the following theorem, proof of which follows easily from the definition of $A_{\alpha}$-semi-norm.

Theorem 2.1. $\|.\|_{A_{\alpha}}$ defines a semi-norm on $\mathcal{B}_{A^{1 / 2}}(\mathcal{H})$. This semi-norm is equivalent to the $A$-numerical radius and the $A$-operator semi-norm, satisfying the following inequalities:
(i) $\quad w_{A}(T) \leq\|T\|_{A_{\alpha}} \leq \sqrt{(4-3 \alpha)} w_{A}(T)$,
(ii) $\quad \max \left\{\frac{1}{2}, \sqrt{1-\alpha}\right\}\|T\|_{A} \leq\|T\|_{A_{\alpha}} \leq\|T\|_{A}$.

Next we prove the following equivalent conditions.
Theorem 2.2. Let $T \in \mathcal{B}_{A^{1 / 2}}(\mathcal{H})$ and let $\alpha \neq 0,1$. Then the following conditions are equivalent:
(i) $\|T\|_{A_{\alpha}}=\sqrt{\alpha w_{A}^{2}(T)+(1-\alpha)\|T\|_{A}^{2}}$.
(ii) There exists a sequence $\left\{x_{n}\right\}$ in $\mathcal{H}$ with $\left\|x_{n}\right\|_{A}=1$ such that $\lim _{n \rightarrow \infty}\left\|T x_{n}\right\|_{A}$ $=\|T\|_{A}$ and $\lim _{n \rightarrow \infty}\left|\left\langle T x_{n}, x_{n}\right\rangle_{A}\right|=w_{A}(T)$.
Proof. (i) $\Longrightarrow$ (ii): Clearly from the definition of $\|T\|_{A_{\alpha}}$ it follows that there exists a sequence $\left\{x_{n}\right\}$ in $\mathcal{H}$ with $\left\|x_{n}\right\|_{A}=1$ such that

$$
\|T\|_{A_{\alpha}}=\lim _{n \rightarrow \infty} \sqrt{\alpha\left|\left\langle T x_{n}, x_{n}\right\rangle_{A}\right|^{2}+(1-\alpha)\left\|T x_{n}\right\|_{A}^{2}}
$$

Now, $\left\{\left|\left\langle T x_{n}, x_{n}\right\rangle_{A}\right|\right\}$ and $\left\{\left\|T x_{n}\right\|_{A}\right\}$ are both bounded sequences of real numbers and so there exists a subsequence $\left\{x_{n_{k}}\right\}$ of $\left\{x_{n}\right\}$ such that $\left\{\left|\left\langle T x_{n_{k}}, x_{n_{k}}\right\rangle_{A}\right|\right\}$ and $\left\{\left\|T x_{n_{k}}\right\|_{A}\right\}$ are convergent. Therefore, we get

$$
\begin{aligned}
\alpha w_{A}^{2}(T)+(1-\alpha)\|T\|_{A}^{2} & =\|T\|_{A_{\alpha}}^{2} \\
& =\lim _{k \rightarrow \infty}\left\{\alpha\left|\left\langle T x_{n_{k}}, x_{n_{k}}\right\rangle_{A}\right|^{2}+(1-\alpha)\left\|T x_{n_{k}}\right\|_{A}^{2}\right\} \\
& =\alpha \lim _{k \rightarrow \infty}\left|\left\langle T x_{n_{k}}, x_{n_{k}}\right\rangle_{A}\right|^{2}+(1-\alpha) \lim _{k \rightarrow \infty}\left\|T x_{n_{k}}\right\|_{A}^{2} \\
& \leq \alpha w_{A}^{2}(T)+(1-\alpha)\|T\|_{A}^{2} .
\end{aligned}
$$

This implies that $\lim _{k \rightarrow \infty}\left\|T x_{n_{k}}\right\|_{A}=\|T\|_{A}$ and $\lim _{k \rightarrow \infty}\left|\left\langle T x_{n_{k}}, x_{n_{k}}\right\rangle_{A}\right|=w_{A}(T)$.
(ii) $\Longrightarrow$ (i): From the definition of $A_{\alpha}$-semi-norm we have

$$
\begin{aligned}
\|T\|_{A_{\alpha}} & =\sup _{\|x\|_{A}=1} \sqrt{\alpha\left|\langle T x, x\rangle_{A}\right|^{2}+(1-\alpha)\|T x\|_{A}^{2}} \\
& \geq \lim _{n \rightarrow \infty} \sqrt{\alpha\left|\left\langle T x_{n}, x_{n}\right\rangle_{A}\right|^{2}+(1-\alpha)\left\|T x_{n}\right\|_{A}^{2}} \\
& =\sqrt{\alpha w_{A}^{2}(T)+(1-\alpha)\|T\|_{A}^{2}} .
\end{aligned}
$$

This completes the proof.
Next, we study an important basic property for the $A_{\alpha}$-semi-norm. First we recall that an operator $U \in \mathcal{B}_{A}(\mathcal{H})$ is said to be $A$-unitary if $\|U x\|_{A}=\left\|U^{\sharp_{A}} x\right\|_{A}=$ $\|x\|_{A}$, for all $x \in \mathcal{H}$. It was shown in [1] that an operator $U \in \mathcal{B}_{A}(\mathcal{H})$ is $A$-unitary if and only if $U^{\sharp_{A}} U=\left(U^{\sharp_{A}}\right)^{\sharp_{A}} U^{\sharp_{A}}=P_{A}$.

Theorem 2.3. If $T \in \mathcal{B}_{A}(\mathcal{H})$, then

$$
\left\|U T U^{\sharp A}\right\|_{A_{\alpha}}=\|T\|_{A_{\alpha}} \text { for every A-unitary operator } U \text {. }
$$

Proof. For $S \in \mathcal{B}_{A}(\mathcal{H})$, we consider a set $L_{S}$ as follows:

$$
L_{S}=\left\{\left(\sqrt{\alpha}\langle S x, x\rangle_{A}, \sqrt{1-\alpha}\|S x\|_{A}\right): x \in \mathcal{H},\|x\|_{A}=1\right\} .
$$

Let $(\lambda, \mu) \in L_{U T U^{\sharp}}$. Then there exists $x \in \mathcal{H}$ with $\|x\|_{A}=1$ such that $\lambda=\sqrt{\alpha}\left\langle U T U^{\sharp_{A}} x, x\right\rangle_{A}$ and $\mu=\sqrt{1-\alpha}\left\|U T U^{\sharp_{A}} x\right\|_{A}$. It is easy to verify that $\lambda=\sqrt{\alpha}\left\langle T U^{\sharp_{A}} x, U^{\sharp_{A}} x\right\rangle_{A}$ and $\mu=\sqrt{1-\alpha}\left\|T U^{\sharp_{A}} x\right\|_{A}$. Since $\left\|U^{\sharp_{A}} x\right\|_{A}=\|x\|_{A}$ for all $x \in \mathcal{H}$, so $(\lambda, \mu) \in L_{T}$. Therefore, we have $L_{U T U^{\sharp} A} \subseteq L_{T}$.
Now, let $(\beta, \gamma) \in L_{T}$. Then, there exist $x \in \mathcal{H}$ with $\|x\|_{A}=1$ such that $\beta=\sqrt{\alpha}\langle T x, x\rangle_{A}$ and $\gamma=\sqrt{1-\alpha}\|T x\|_{A}$, i.e., $\gamma=\sqrt{(1-\alpha)\langle U T x, U T x\rangle_{A}}$. Let $x=P_{A} x+y$ where $y \in N(A)$. Since $N(A)$ is invariant subspace under $T$, i.e., $T(N(A)) \subseteq N(A)$, so by using this argument we get,

$$
\beta=\sqrt{\alpha}\left\langle T P_{A} x, P_{A} x\right\rangle_{A} \text { and } \gamma=\sqrt{(1-\alpha)\left\langle U T P_{A} x, U T P_{A} x\right\rangle_{A}} .
$$

Since $U^{\sharp A} U=P_{A}$, so we have, $\beta=\sqrt{\alpha}\left\langle U T U^{\sharp_{A}} U x, U x\right\rangle_{A}$ and

$$
\left.\gamma=\sqrt{(1-\alpha)\left\langle U T U^{\sharp} A U x, U T U^{\sharp} A\right.} U x\right\rangle_{A}=\sqrt{1-\alpha}\left\|U T U^{\sharp}{ }_{A} U x\right\|_{A} .
$$

Now $\|U x\|_{A}=\|x\|_{A}$ for all $x \in \mathcal{H}$, so $(\beta, \gamma) \in L_{U T U^{\sharp} A}$. Therefore, we have $L_{T} \subseteq L_{U T U^{\sharp} A}$. Hence, we conclude that $L_{T}=L_{U T U^{\sharp} A}$. This completes the proof.

In the following theorem we obtain a lower bound for the $A_{\alpha}$-semi-norm.
Theorem 2.4. Let $T \in \mathcal{B}_{A}(\mathcal{H})$. Then

$$
\begin{array}{r}
\|T\|_{A_{\alpha}}^{2} \geq \max \left\{\alpha w_{A}^{2}(T)+(1-\alpha) c_{A}\left(T^{\sharp} T\right), \alpha c_{A}^{2}(T)+(1-\alpha)\|T\|_{A}^{2},\right. \\
\left.2 \sqrt{\alpha(1-\alpha)} w_{A}(T) \sqrt{c_{A}\left(T^{\sharp} A\right)}, 2 \sqrt{\alpha(1-\alpha)} c_{A}(T)\|T\|_{A}\right\} .
\end{array}
$$

Proof. Let $x \in \mathcal{H}$ with $\|x\|_{A}=1$. Then we get,

$$
\begin{aligned}
\|T\|_{A_{\alpha}}^{2} & \geq \alpha\left|\langle T x, x\rangle_{A}\right|^{2}+(1-\alpha)\|T x\|_{A}^{2} \\
& =\alpha\left|\langle T x, x\rangle_{A}\right|^{2}+(1-\alpha)\left\langle T^{\sharp} T x, x\right\rangle_{A} \\
& \geq \alpha\left|\langle T x, x\rangle_{A}\right|^{2}+(1-\alpha) c_{A}\left(T^{\sharp} T\right) .
\end{aligned}
$$

Taking supremum over all $x$ in $\mathcal{H}$ with $\|x\|_{A}=1$, we get that

$$
\begin{equation*}
\|T\|_{A_{\alpha}}^{2} \geq \alpha w_{A}^{2}(T)+(1-\alpha) c_{A}\left(T^{\sharp} T\right) . \tag{2.1}
\end{equation*}
$$

Proceeding similarly we also get

$$
\begin{equation*}
\|T\|_{A_{\alpha}}^{2} \geq \alpha c_{A}^{2}(T)+(1-\alpha)\|T\|_{A}^{2} . \tag{2.2}
\end{equation*}
$$

Now, we also have

$$
\begin{aligned}
\|T\|_{A_{\alpha}}^{2} & \geq \alpha\left|\langle T x, x\rangle_{A}\right|^{2}+(1-\alpha)\|T x\|_{A}^{2} \\
& \geq 2 \sqrt{\alpha(1-\alpha)}\left|\langle T x, x\rangle_{A}\right|\|T x\|_{A} \\
& \geq 2 \sqrt{\alpha(1-\alpha)}\left|\langle T x, x\rangle_{A}\right| \sqrt{c_{A}\left(T^{\sharp} T\right)} .
\end{aligned}
$$

Taking supremum over all $x$ in $\mathcal{H}$ with $\|x\|_{A}=1$, we get

$$
\begin{equation*}
\|T\|_{A_{\alpha}}^{2} \geq 2 \sqrt{\alpha(1-\alpha)} w_{A}(T) \sqrt{c_{A}\left(T^{\sharp} A T\right)} . \tag{2.3}
\end{equation*}
$$

Similarly,

$$
\begin{equation*}
\|T\|_{A_{\alpha}}^{2} \geq 2 \sqrt{\alpha(1-\alpha)} c_{A}(T)\|T\|_{A} \tag{2.4}
\end{equation*}
$$

Combining (2.1), (2.2), (2.3) and (2.4) we get our desired inequality.
Next, we obtain upper bounds for the $A_{\alpha}$-semi-norm of the product of two operators.
Theorem 2.5. Let $T, S \in \mathcal{B}_{A^{1 / 2}}(\mathcal{H})$ and $\alpha \neq 1$. Then

$$
\|T S\|_{A_{\alpha}} \leq \min \left\{\frac{2}{\sqrt{1-\alpha}}, \frac{1}{(1-\alpha)}, 4\right\}\|T\|_{A_{\alpha}}\|S\|_{A_{\alpha}}
$$

Proof. From the definition of $A_{\alpha}$-semi-norm we get,

$$
\begin{aligned}
\|T S\|_{A_{\alpha}}^{2} & =\sup _{\|x\|_{A}=1}\left\{\alpha\left|\langle T S x, x\rangle_{A}\right|^{2}+\beta\|T S x\|_{A}^{2}\right\} \\
& \leq \alpha w_{A}^{2}(T S)+(1-\alpha)\|T S\|_{A}^{2} \\
& \leq \alpha\|T S\|_{A}^{2}+(1-\alpha)\|T S\|_{A}^{2} \\
& \leq\|T\|_{A}^{2}\|S\|_{A}^{2} \\
& \leq 4 w_{A}^{2}(T)\|S\|_{A}^{2}, \text { as }\|T\|_{A} \leq 2 w_{A}(T) \\
& \leq 4 w_{A}^{2}(T)(1 /(1-\alpha))\|S\|_{A_{\alpha}}^{2}, \text { by Theorem } 2.1 \\
& \leq \frac{4}{1-\alpha}\|T\|_{A_{\alpha}}^{2}\|S\|_{A_{\alpha}}^{2}, \text { by Theorem 2.1. }
\end{aligned}
$$

Thus,

$$
\begin{equation*}
\|T S\|_{A_{\alpha}} \leq \sqrt{\frac{4}{1-\alpha}}\|T\|_{A_{\alpha}}\|S\|_{A_{\alpha}} \tag{2.5}
\end{equation*}
$$

Proceeding as above, and using $\sqrt{1-\alpha}\|T\|_{A} \leq\|T\|_{A_{\alpha}}$ and $\sqrt{1-\alpha}\|S\|_{A} \leq$ $\|S\|_{A_{\alpha}}$ we get,

$$
\begin{equation*}
\|T S\|_{A_{\alpha}} \leq \sqrt{\frac{1}{(1-\alpha)^{2}}}\|T\|_{A_{\alpha}}\|S\|_{A_{\alpha}} \tag{2.6}
\end{equation*}
$$

Finally, using $\|T\|_{A} \leq 2 w_{A}(T)$ and $\|S\|_{A} \leq 2 w_{A}(S)$, and by Theorem 2.1 we get,

$$
\begin{equation*}
\|T S\|_{A_{\alpha}} \leq 4\|T\|_{A_{\alpha}}\|S\|_{A_{\alpha}} \tag{2.7}
\end{equation*}
$$

Combining (2.5),(2.6) and (2.7) we get the required inequality.
To prove next inequality we need the following lemma.
Lemma 2.6. Let $T, S \in \mathcal{B}_{A}(\mathcal{H})$. Then the following inequalities hold:
(i) If $T S=S T$, then $w_{A}(T S) \leq 2 w_{A}(T) w_{A}(S)$.
(ii) If $(T S)^{\sharp_{A}}=T^{\sharp_{A}} S$, then $w_{A}(T S) \leq w_{A}(T)\|S\|_{A}$.

Proof. (i) Without loss of generality we assume that $w_{A}(T)=1$ and $w_{A}(S)=1$. Now, we have that

w_{A}(T S) & =w_{A}\left(\frac{1}{4}\left((T+S)^{2}-(T-S)^{2}\right)\right) \\
& \leq \frac{1}{4}\left(w_{A}\left((T+S)^{2}\right)+w_{A}\left((T-S)^{2}\right)\right) \\
& \leq \frac{1}{4}\left(w_{A}^{2}(T+S)+w_{A}^{2}(T-S)\right), \text { as } w_{A}\left(T^{n}\right) \leq w_{A}^{n}(T) \forall n \in \mathbb{N} \\
& \leq \frac{1}{4}\left(\left(w_{A}(T)+w_{A}(S)\right)^{2}+\left(w_{A}(T)+w_{A}(S)\right)^{2}\right) \\
& =2
\end{aligned}
$$

This completes the proof.
(ii) See in [20, Cor. 3.3].

Theorem 2.7. Let $T, S \in \mathcal{B}_{A}(\mathcal{H})$. Then the following inequalities hold:
(i) If $T S=S T$ and $\alpha \neq 1$, then

\|T S\|_{A_{\alpha}} \leq \sqrt{\left(4 \alpha+\frac{1}{1-\alpha}\right)}\|T\|_{A_{\alpha}}\|S\|_{A_{\alpha}}
$$

(ii) If $(T S)^{\sharp A}=T^{\sharp A} S$ and $\alpha \neq 1$, then

\|T S\|_{A_{\alpha}} \leq \sqrt{1+\alpha} \min \left\{2, \frac{1}{\sqrt{1-\alpha}}\right\}\|T\|_{A_{\alpha}}\|S\|_{A_{\alpha}} .
$$

Proof. (i) From the definition of $A_{\alpha}$-semi-norm we get,

\begin{aligned}
\|T S\|_{A_{\alpha}}^{2} & =\sup _{\|x\|_{A}=1}\left\{\alpha\left|\langle T S x, x\rangle_{A}\right|^{2}+(1-\alpha)\|T S x\|_{A}^{2}\right\} \\
& \leq \alpha w_{A}^{2}(T S)+(1-\alpha)\|T S\|_{A}^{2} \\
& \leq 4 \alpha w_{A}^{2}(T) w_{A}^{2}(S)+(1-\alpha)\|T\|_{A}^{2}\|S\|_{A}^{2}, \text { by Lemma 2.6(i) } \\
& \leq\left(4 \alpha+\frac{1}{1-\alpha}\right)\|T\|_{A_{\alpha}}^{2}\|S\|_{A_{\alpha}}^{2}, \text { by Theorem 2.1. }
\end{aligned}
$$

Therefore,

$$
\|T S\|_{A_{\alpha}} \leq \sqrt{\left(4 \alpha+\frac{1}{1-\alpha}\right)}\|T\|_{A_{\alpha}}\|S\|_{A_{\alpha}}
$$

(ii) Using the definition of $A_{\alpha}$-semi-norm we get,

\begin{aligned}
\|T S\|_{A_{\alpha}}^{2} & =\sup _{\|x\|_{A}=1}\left\{\alpha\left|\langle T S x, x\rangle_{A}\right|^{2}+(1-\alpha)\|T S x\|_{A}^{2}\right\} \\
& \leq \alpha w_{A}^{2}(T S)+(1-\alpha)\|T S\|_{A}^{2} \\
& \leq \alpha w_{A}^{2}(T)\|S\|_{A}^{2}+(1-\alpha)\|T\|_{A}^{2}\|S\|_{A}^{2}, \text { by Lemma 2.6(ii) } \\
& \leq \alpha\|T\|_{A_{\alpha}}^{2}\|S\|_{A}^{2}+\|T\|_{A_{\alpha}}^{2}\|S\|_{A}^{2}, \text { by Theorem 2.1 } \\
& =(\alpha+1)\|T\|_{A_{\alpha}}^{2}\|S\|_{A}^{2} \\
& \leq(\alpha+1) \min \left\{2, \frac{1}{\sqrt{1-\alpha}}\right\}\|T\|_{A_{\alpha}}^{2}\|S\|_{A_{\alpha}}^{2}, \text { by Theorem 2.1. }
\end{aligned}
$$

Therefore,

$$
\|T S\|_{A_{\alpha}} \leq \sqrt{(\alpha+1)} \min \left\{2, \frac{1}{\sqrt{1-\alpha}}\right\}\|T\|_{A_{\alpha}}\|S\|_{A_{\alpha}}
$$

Next we need the following two notations: For $T \in \mathcal{B}_{A}(\mathcal{H})$, let $\Re_{A}(T)=\frac{1}{2}(T+$ $\left.T^{\sharp A}\right)$ and $\Im_{A}(T)=\frac{1}{2 \mathrm{i}}\left(T-T^{\sharp_{A}}\right)$. Then, $T$ can be expressed as $T=\Re_{A}(T)+\mathrm{i} \Im_{\mathrm{A}}(\mathrm{T})$. By using this decomposition we prove the following inequalities.

Theorem 2.8. Let $T \in \mathcal{B}_{A}(\mathcal{H})$. Then the following inequalities hold :
(i) $\|T\|_{A_{\alpha}}^{2} \geq \max \left\{\frac{1}{2}\left\|\frac{\alpha}{4}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A}\right.$,

$$
\left.\frac{1}{3}\left\|\frac{\alpha}{2}\left(T^{\sharp A} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A}\right\},
$$

(ii) $\|T\|_{A_{\alpha}}^{2} \leq\left\|\frac{\alpha}{2}\left(T^{\sharp A} T+T T^{\sharp A}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A}$,
(iii) $w_{A}^{2}(T) \leq \min _{\alpha}\left\|\frac{\alpha}{2}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A} \leq \frac{1}{2}\left\|T^{\sharp_{A}} T+T T^{\sharp_{A}}\right\|_{A}$.

Proof. We observe that $\left(\Re_{A}\left(T^{\sharp_{A}}\right)\right)^{\sharp_{A}}=\Re_{A}\left(T^{\sharp_{A}}\right)$ and $\left(\Im_{A}\left(T^{\sharp_{A}}\right)\right)^{\sharp_{A}}=\Im_{A}\left(T^{\sharp_{A}}\right)$, and

$$
\Re_{A}^{2}\left(T^{\sharp A}\right)+\Im_{A}^{2}\left(T^{\sharp_{A}}\right)=\frac{T^{\sharp A}\left(T^{\sharp A}\right)^{\sharp_{A}}+\left(T^{\sharp_{A}}\right)^{\sharp_{A}} T^{\sharp_{A}}}{2}=\left(\frac{T^{\sharp_{A}} T+T T^{\sharp A}}{2}\right)^{\sharp_{A}} .
$$

Let us consider $x \in \mathcal{H}$ with $\|x\|_{A}=1$. Then, we have

$$
\begin{aligned}
\left|\langle T x, x\rangle_{A}\right|^{2} & =\left|\langle x, T x\rangle_{A}\right|^{2} \\
& =\left|\left\langle T^{\not{ }_{A} A} x, x\right\rangle_{A}\right|^{2} \\
& =\left|\left\langle\left(\Re_{A}\left(T^{\not A_{A}}\right)+i \Im_{A}\left(T^{\sharp A}\right)\right) x, x\right\rangle_{A}\right|^{2} \\
& =\left|\left\langle\Re_{A}\left(T^{\sharp_{A}}\right) x, x\right\rangle_{A}\right|^{2}+\left|\left\langle\Im_{A}\left(T^{\sharp A}\right) x, x\right\rangle_{A}\right|^{2} \\
& \geq \frac{1}{2}\left|\left\langle\left(\Re_{A}\left(T^{\sharp A}\right) \pm \Im_{A}\left(T^{\sharp A}\right)\right) x, x\right\rangle_{A}\right|^{2} .
\end{aligned}
$$

Taking supremum over all $x$ in $\mathcal{H}$ with $\|x\|_{A}=1$, we get that

$$
\begin{aligned}
& \sup _{\|x\|_{A}=1} \alpha\left|\langle T x, x\rangle_{A}\right|^{2} \\
& \geq \sup _{\|x\|_{A}=1} \frac{\alpha}{2}\left|\left\langle\left(\Re_{A}\left(T^{\sharp_{A}}\right) \pm \Im_{A}\left(T^{\sharp A}\right)\right) x, x\right\rangle_{A}\right|^{2} \\
& =\frac{\alpha}{2}\left\|\Re_{A}\left(T^{\not{ }_{A}}\right) \pm \Im_{A}\left(T^{\sharp A}\right)\right\|_{A}^{2} \\
& =\frac{\alpha}{2}\left\|\left(\Re_{A}\left(T^{\sharp}\right) \pm \Im_{A}\left(T^{\sharp A}\right)\right)^{2}\right\|_{A}, \text { since } \Re_{A}\left(T^{\sharp_{A}}\right) \pm \Im_{A}\left(T^{\sharp A}\right) \text { is A-self-adjoint } \\
& =\sup _{\|x\|_{A}=1}\left\langle\frac{\alpha}{2}\left(\Re_{A}\left(T^{\sharp A}\right) \pm \Im_{A}\left(T^{\sharp_{A}}\right)\right)^{2} x, x\right\rangle_{A} \\
& \geq \sup _{\|x\|_{A}=1}\left\langle\frac{\alpha}{4}\left(\left(\Re_{A}\left(T^{\sharp A}\right)+\Im_{A}\left(T^{\sharp A}\right)\right)^{2}+\left(\Re_{A}\left(T^{\sharp A}\right)-\Im_{A}\left(T^{\sharp A}\right)\right)^{2}\right) x, x\right\rangle_{A} \\
& \geq \sup _{\|x\|_{A}=1}\left\langle\frac{\alpha}{2}\left(\Re_{A}^{2}\left(T^{\sharp A}\right)+\Im_{A}^{2}\left(T^{\sharp_{A}}\right)^{2}\right) x, x\right\rangle_{A} .
\end{aligned}
$$

Hence,

$$
\|T\|_{A_{\alpha}}^{2} \geq \sup _{\|x\|_{A}=1}\left\langle\frac{\alpha}{2}\left(\Re_{A}^{2}\left(T^{\sharp}\right)+\Im_{A}^{2}\left(T^{\sharp}\right)\right) x, x\right\rangle_{A} .
$$

Also we have that,

$$
\|T\|_{A_{\alpha}}^{2} \geq \sup _{\|x\|_{A}=1}\left\langle(1-\alpha) T^{\not{ }_{A}} T x, x\right\rangle_{A} .
$$

Therefore,

$$
\begin{aligned}
2\|T\|_{A_{\alpha}}^{2} & \geq \sup _{\|x\|_{A}=1}\left\langle\left(\frac{\alpha}{2}\left(\Re_{A}^{2}\left(T^{\sharp_{A}}\right)+\Im_{A}^{2}\left(T^{\sharp A}\right)\right)+(1-\alpha) T^{\sharp A} T\right) x, x\right\rangle_{A} \\
& =\left\|\frac{\alpha}{2}\left(\Re_{A}^{2}\left(T^{\sharp A}\right)+\Im_{A}^{2}\left(T^{\sharp A}\right)\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A} \\
& =\left\|\frac{\alpha}{2}\left(\frac{T^{\sharp A} T+T T^{\sharp_{A}}}{2}\right)^{\sharp_{A}}+(1-\alpha)\left(T^{\sharp_{A}} T\right)^{\sharp_{A}}\right\|_{A} \\
& =\left\|\frac{\alpha}{4}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A} .
\end{aligned}
$$

Hence,

$$
\begin{equation*}
\|T\|_{A_{\alpha}}^{2} \geq \frac{1}{2}\left\|\frac{\alpha}{4}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp} T\right\|_{A} . \tag{2.8}
\end{equation*}
$$

Again, by using similar arguments as above, we have that

$$
\begin{aligned}
3\|T\|_{A_{\alpha}}^{2} & \geq \sup _{\|x\|_{A}=1}\left\langle\left(\alpha\left(\Re_{A}^{2}\left(T^{\sharp A}\right)+\Im_{A}^{2}\left(T^{\sharp A}\right)\right)+(1-\alpha) T^{\sharp A} T\right) x, x\right\rangle_{A} \\
& =\left\|\frac{\alpha}{2}\left(T^{\sharp_{A}} T+T T^{\sharp A}\right)+(1-\alpha) T^{\sharp A} T\right\|_{A} .
\end{aligned}
$$

Hence,

$$
\begin{equation*}
\|T\|_{A_{\alpha}}^{2} \geq \frac{1}{3}\left\|\frac{\alpha}{2}\left(T^{\sharp A} T+T T^{\sharp A}\right)+(1-\alpha) T^{\sharp A} T\right\|_{A} . \tag{2.9}
\end{equation*}
$$

Combining (2.8) and (2.9) we get the inequality (i). Now we prove the inequality (ii). We have

\begin{aligned}
\left|\langle T x, x\rangle_{A}\right|^{2} & =\left|\left\langle\Re_{A}\left(T^{\sharp A}\right) x, x\right\rangle_{A}\right|^{2}+\left|\left\langle\Im_{A}\left(T^{\sharp_{A}}\right) x, x\right\rangle_{A}\right|^{2} \\
& \leq\left\|\Re_{A}\left(T^{\sharp_{A}}\right) x\right\|_{A}^{2}+\left\|\Im_{A}\left(T^{\sharp_{A}}\right) x\right\|_{A}^{2} \\
& =\left\langle\Re_{A}^{2}\left(T^{\sharp_{A}}\right) x, x\right\rangle_{A}+\left\langle\Im_{A}^{2}\left(T^{\sharp A}\right) x, x\right\rangle_{A} \\
& =\left\langle\left(\Re_{A}^{2}\left(T^{\sharp_{A}}\right)+\Im_{A}^{2}\left(T^{\sharp_{A}}\right)\right) x, x\right\rangle_{A} .
\end{aligned}
$$

So,

$$
\begin{aligned}
& \alpha\left|\langle T x, x\rangle_{A}\right|^{2}+(1-\alpha)\|T x\|_{A}^{2} \\
& \leq\left\langle\alpha\left(\Re_{A}^{2}\left(T^{\sharp_{A}}\right)+\Im_{A}^{2}\left(T^{\sharp_{A}}\right)\right) x, x\right\rangle_{A}+\left\langle(1-\alpha) T^{\sharp_{A}} T x, x\right\rangle_{A} \\
& =\left\langle\left(\alpha\left(\Re_{A}^{2}\left(T^{\sharp_{A}}\right)+\Im_{A}^{2}\left(T^{\sharp_{A}}\right)\right)+(1-\alpha) T^{\sharp_{A}} T\right) x, x\right\rangle_{A} \\
& \leq\left\|\alpha\left(\Re_{A}^{2}\left(T^{\sharp_{A}}\right)+\Im_{A}^{2}\left(T^{\sharp_{A}}\right)\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A} \\
& =\left\|\alpha\left(\frac{T^{\sharp_{A}} T+T T^{\sharp_{A}}}{2}\right)^{\sharp_{A}}+(1-\alpha)\left(T^{\sharp_{A}} T\right)^{\sharp_{A}}\right\|_{A} \\
& =\left\|\frac{\alpha}{2}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A} .
\end{aligned}
$$

Therefore, by taking supremum over all $x \in \mathcal{H}$ with $\|x\|_{A}=1$, we get the inequality (ii). Now, using Theorem 2.1 in the inequality (ii), we get

$$
w_{A}^{2}(T) \leq\left\|\frac{\alpha}{2}\left(T^{\sharp A} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A} .
$$

This holds for all $\alpha$, so considering minimum over $\alpha$, we get that

$$
w_{A}^{2}(T) \leq \min _{\alpha}\left\|\frac{\alpha}{2}\left(T^{\sharp_{A}} T+T T^{\sharp A}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A} .
$$

This is the first inequality in (iii). The second inequality in (iii) follows from the case $\alpha=1$.
Remark 2.9. Zamani in [20, Theorem 2.10] proved that for $T \in \mathcal{B}_{A}(\mathcal{H})$,

$$
w_{A}^{2}(T) \leq \frac{1}{2}\left\|T T^{\sharp A}+T^{\sharp A} T\right\|_{A} .
$$

Clearly, the first inequality obtained in Theorem 2.8(iii) improves on [20, Theorem 2.10 ]. Here we consider an example to show proper improvement. Let $T=\left(\begin{array}{lll}0 & 0 & 0 \\ 2 & 0 & 0 \\ 0 & 1 & 0\end{array}\right)$ and $A=\left(\begin{array}{lll}1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & 2\end{array}\right)$. Then, simple calculations show that

\left\|\frac{\alpha}{2}\left(T^{\sharp A} T+T T^{\sharp A}\right)+(1-\alpha) T^{\sharp A} T\right\|_{A}=\frac{23}{8} \text { for } \alpha=\frac{7}{8}
$$

and

$$
\frac{1}{2}\left\|T^{\sharp} A+T T^{\sharp A}\right\|_{A}=3 .
$$

Hence, for the matrices $T$ and $A$,

$$
\min _{\alpha}\left\|\frac{\alpha}{2}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A}<\frac{1}{2}\left\|T^{\sharp_{A}} T+T T^{\sharp_{A}}\right\|_{A} .
$$

To prove next theorem first we recall the following lemma.
Lemma 2.10. ([10, Lemma 1]) Let $a, b, e \in \mathcal{H}$ with $\|e\|_{A}=1$. Then,

$$
\left|\langle a, e\rangle_{A}\langle e, b\rangle_{A}\right| \leq \frac{1}{2}\left(\left|\langle a, b\rangle_{A}\right|+\|a\|_{A}\|b\|_{A}\right)
$$

Theorem 2.11. Let $T \in \mathcal{B}_{A}(\mathcal{H})$. Then the following inequalities hold:

$$
\begin{aligned}
(i)\|T\|_{A_{\alpha}}^{2} & \leq \frac{\alpha}{2} w_{A}\left(T^{2}\right)+\left\|\frac{\alpha}{4}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp A} T\right\|_{A} \\
\text { (ii) } w_{A}^{2}(T) & \leq \min _{\alpha}\left\{\frac{\alpha}{2} w_{A}\left(T^{2}\right)+\left\|\frac{\alpha}{4}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A}\right\} \\
& \leq \frac{1}{2} w_{A}\left(T^{2}\right)+\frac{1}{4}\left\|T^{\sharp_{A}} T+T T^{\sharp_{A}}\right\|_{A} .
\end{aligned}
$$

Proof. Let $x \in \mathcal{H}$ with $\|x\|_{A}=1$. Taking $a=T x, b=T^{\sharp_{A}} x$ and $e=x$ in Lemma 2.10, and using the arithmetic-geometric mean inequality, we get

\begin{aligned}
\left|\langle T x, x\rangle_{A}\right|^{2} & \leq \frac{1}{2}\left(\left|\left\langle T^{2} x, x\right\rangle_{A}\right|+\|T x\|_{A}\left\|T^{\not{ }_{A}} x\right\|_{A}\right) \\
& \leq \frac{1}{2}\left|\left\langle T^{2} x, x\right\rangle_{A}\right|+\frac{1}{2}\left\langle T^{\sharp_{A}} T x, x\right\rangle_{A}^{1 / 2}\left\langle T T^{\sharp A} x, x\right\rangle_{A}^{1 / 2} \\
& \leq \frac{1}{2}\left|\left\langle T^{2} x, x\right\rangle_{A}\right|+\frac{1}{4}\left(\left\langle T^{\sharp A} T x, x\right\rangle_{A}+\left\langle T T^{\sharp} A, x\right\rangle_{A}\right) \\
& =\frac{1}{2}\left|\left\langle T^{2} x, x\right\rangle_{A}\right|+\frac{1}{4}\left\langle\left(T^{\sharp A} T+T T^{\sharp A}\right) x, x\right\rangle_{A} .
\end{aligned}
$$

Therefore,

$$
\begin{aligned}
& \alpha\left|\langle T x, x\rangle_{A}\right|^{2}+(1-\alpha)\|T x\|_{A}^{2} \\
& \leq \frac{\alpha}{2}\left|\left\langle T^{2} x, x\right\rangle_{A}\right|+\left\langle\left(\frac{\alpha}{4}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp A_{A}} T\right) x, x\right\rangle_{A} \\
& \leq \frac{\alpha}{2} w_{A}\left(T^{2}\right)+\left\|\frac{\alpha}{4}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A} .
\end{aligned}
$$

Taking supremum over all $x$ in $\mathcal{H}$ with $\|x\|_{A}=1$, we get

$$
\|T\|_{A_{\alpha}}^{2} \leq \frac{\alpha}{2} w_{A}\left(T^{2}\right)+\left\|\frac{\alpha}{4}\left(T^{\sharp_{A}} T+T T^{\sharp A}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A} .
$$

This is the inequality in (i). Now using Theorem 2.1 in (i), we get

$$
w_{A}^{2}(T) \leq \frac{\alpha}{2} w_{A}\left(T^{2}\right)+\left\|\frac{\alpha}{4}\left(T^{\sharp A} T+T T^{\sharp A}\right)+(1-\alpha) T^{\sharp A} T\right\|_{A},
$$

This holds for all $\alpha$, so taking infimum over all $\alpha$, we get the first inequality in (ii). The remaining inequality follows from the case $\alpha=1$.

It should be mentioned here that the inequality, $w_{A}^{2}(T) \leq \frac{1}{2} w_{A}\left(T^{2}\right)+\frac{1}{4} \| T^{\sharp A} T+$ $T T^{\sharp} A \|_{A}$ is known and it was given in [20, Th. 2.11]. Clearly, the first inequality in Theorem 2.11 (ii) is sharper than the above mentioned inequality. To show that the inequality in Theorem 2.11 (ii) is strictly sharper, we consider the following example.

Example 2.12. Let $T=\left(\begin{array}{lll}0 & 0 & 0 \\ 2 & 0 & 0 \\ 0 & 1 & 0\end{array}\right)$ and $A=\left(\begin{array}{lll}1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & 2\end{array}\right)$. Then, simple calculations show that

$$
\frac{\alpha}{2} w_{A}\left(T^{2}\right)+\left\|\frac{\alpha}{4}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp A} T\right\|_{A}=\frac{6 \sqrt{2}+20}{13} \approx 2.19117549033
$$

for $\alpha=\frac{12}{13}$ and

$$
\frac{1}{2} w_{A}\left(T^{2}\right)+\frac{1}{4}\left\|T^{\sharp} A+T T^{\sharp A}\right\|_{A}=\frac{3+\sqrt{2}}{2} \approx 2.20710678119 .
$$

Hence, for the matrices $T$ and $A$,

$$
\begin{aligned}
& \min _{\alpha}\left\{\frac{\alpha}{2} w_{A}\left(T^{2}\right)+\left\|\frac{\alpha}{4}\left(T^{\sharp_{A}} T+T T^{\sharp_{A}}\right)+(1-\alpha) T^{\sharp_{A}} T\right\|_{A}\right\} \\
< & \frac{1}{2} w_{A}\left(T^{2}\right)+\frac{1}{4}\left\|T^{\sharp} T+T T^{\sharp A}\right\|_{A} .
\end{aligned}
$$

Finally, we prove the following inequalities.
Theorem 2.13. Let $T \in \mathcal{B}_{A}(\mathcal{H})$. Then

$$
\begin{aligned}
& \text { (i) }\|T\|_{A_{\alpha}}^{2} \leq\left\|(1-\alpha) T^{\sharp A_{A}} T+\alpha T T^{\sharp A}\right\|_{A}, \\
& \text { (ii) } w_{A}^{2}(T) \leq \min _{\alpha}\left\|\alpha T^{\sharp} T+(1-\alpha) T T^{\sharp_{A}}\right\|_{A} .
\end{aligned}
$$

Proof. Let $x \in \mathcal{H}$ with $\|x\|_{A}=1$. Then we get that

$$
\begin{aligned}
\alpha\left|\langle T x, x\rangle_{A}\right|^{2}+(1-\alpha)\|T x\|_{A}^{2} & \leq(1-\alpha)\|T x\|_{A}^{2}+\alpha\left\|T^{\sharp_{A}} x\right\|_{A}^{2} \\
& =(1-\alpha)\langle T x, T x\rangle_{A}+\alpha\left\langle T^{\sharp_{A}} x, T^{\sharp A_{A}} x\right\rangle_{A} \\
& =(1-\alpha)\left\langle T^{\sharp_{A}} T x, x\right\rangle_{A}+\alpha\left\langle T T^{\sharp_{A}} x, x\right\rangle_{A} \\
& \leq\left\|(1-\alpha) T^{\sharp_{A}} T+\alpha T T^{\sharp_{A}}\right\|_{A} .
\end{aligned}
$$

Taking supremum over all $x$ in $\mathcal{H}$ with $\|x\|_{A}=1$, we get

$$
\|T\|_{A_{\alpha}}^{2} \leq\left\|(1-\alpha) T^{\sharp_{A}} T+\alpha T T^{\sharp_{A}}\right\|_{A},
$$

Now, by using Theorem 2.1 in (i) and considering minimum over $\alpha$, we get the inequality in (ii).

Here we note that the inequality, $w_{A}^{2}(T) \leq \min _{\mu \in[0,1]}\left\|\mu T^{\sharp_{A}} T+(1-\mu) T T^{\sharp}\right\|_{A}$, recently obtained in [4, Th. 1], is same as obtain in (ii) of Theorem 2.13.

We conclude that by applying the $A_{\alpha}$-semi-norm of operators in $\mathcal{B}_{A}(\mathcal{H})$ we always get the A-numerical radius inequalities of operators in $\mathcal{B}_{A}(\mathcal{H})$, which improve on the existing ones.
