# GROUND STATE NORMALIZED SOLUTION TO SCHÖDINGER SYSTEMS WITH GENERAL NONLINEARITIES AND POTENTIALS

Abstract. In present paper, we study the following Schrödinger systems

\begin{cases}-\Delta u_{1}+V_{1}(x) u_{1}+\lambda_{1} u_{1}=\partial_{1} G\left(u_{1}, u_{2}\right) & \text { in } \mathbb{R}^{N}, \\ -\Delta u_{2}+V_{2}(x) u_{2}+\lambda_{2} u_{2}=\partial_{2} G\left(u_{1}, u_{2}\right) & \text { in } \mathbb{R}^{N}, \\ 0<u_{1}, u_{2} \in H^{1}\left(\mathbb{R}^{N}\right), N \geq 1, \\ \int_{\mathbb{R}^{N}} u_{1}^{2} d x=a_{1}, \int_{\mathbb{R}^{N}} u_{2}^{2} d x=a_{2},\end{cases}

where the potentials $V_{\iota}(x)(\iota=1,2)$ are given functions and the nonlinearities $G\left(u_{1}, u_{2}\right)$ are considered of the form

Under some assumptions on $V_{\iota}(\iota=1,2)$ and the parameters, we can show the existence of ground state normalized solution $\left(\lambda_{1}, \lambda_{2} ; u_{1}, u_{2}\right) \in \mathbb{R}^{2} \times H^{1}\left(\mathbb{R}^{N}, \mathbb{R}^{2}\right)$ to the above mass sub-critical problem for any given $a_{1}>0, a_{2}>0$. Here our nonlinearities are general. The potentials $V_{1}(x)$ and $V_{2}(x)$ are also very general such that inf ess $\sigma\left(-\Delta+V_{\iota}\right)>-\infty$, which are allowed to be singular at some points.

## 1. Introduction

The time-dependent system of coupled nonlinear Schrödinger equations

appear in mean-field models for binary mixtures of Bose-Einstein condensates or models for binary mixtures of ultracold quantum gases of fermion atoms, such as Bose-Fermi mixtures and Fermi-Fermi mixtures, see $[1,2,15,29]$ and the references therein.

[^0]The ansatz $\Phi_{\iota}(x, t)=e^{i \lambda_{\iota} t} u_{\iota}(x), \iota=1,2$ for solitary wave solutions leads to the following elliptic system:

In (1.2), if $\lambda_{1}$ and $\lambda_{2}$ are given, we call it the fixed frequency problem. There are many mathematical theories and tools applied to study it. For example, one can apply the variational method to look for the critical points of the associated energy functional

On the other hand, one also can use the topological methods to deal with (1.2), such as the fixed point theory, bifurcation or the Lyapunov-Schmidt reduction. The fixed frequency problem has been widely investigated by many authors for the decades, and it is impossible to summarize it here since the related literature is huge.

An important and well-known feature of (1.1) is conservation of masses: the $L^{2}$-norms $\left\|\Phi_{1}(\cdot, t)\right\|_{2},\left\|\Phi_{2}(\cdot, t)\right\|_{2}$ of solutions are independent of $t \in \mathbb{R}$. Therefore a natural approach to find the solutions of (1.2) consists in finding critical points of the energy $J\left[u_{1}, u_{2}\right]$ under the the following masses constraint

Then the parameters $\lambda_{1}$ and $\lambda_{2}$ appear as Lagrange multipliers. We call the problem (1.2) with (1.3) the fixed mass problem, and a solution of (1.2) satisfying the prescribed mass constraint (1.3), we call it normalized solution.

System (1.2) with (1.3) can be seen as a counterpart of the following prescribed mass problem

\end{equation*}

The prescribed mass problem is a research hotspot recently. The readers may refer to [ $4,7,21,23,27,28,30,31,36,37,39]$ and the references therein.

Basing on the above results, we discover that even though a series of theories and tools related to fixed frequency problem have been developed, such as fixed point theory, bifurcation, the Lyapunov-Schmidt reduction, Nehari manifold method, mountain pass theory and many other linking theories, these theories and tools can not be used directly to the fixed mass problem. For the fixed mass problem, the normalization constraint (1.3) certainly brings too much trouble in mathematical treatment. Comparing to the fixed frequency problem, the fixed mass problem possesses the following technical difficulties when dealing with it:
(1) One can not use the usual Nehari manifold method since the frequency is unknown;
(2) The existence of bounded Palais-Smale sequences requires new arguments;
(3) The Lagrange multipliers have to be controlled;
(4) For the fixed frequency problem, usually a nontrivial weak limit is also a solution. However, for the fixed mass problem, a nontrivial weak limit may be not a solution since the constraint condition may be not satisfied.
(5) There is a number $\bar{p}=2+\frac{4}{N}$, called the mass critical exponent, affecting the geometry of the functional heavily.
Due to the importance of the normalized solutions to (1.2) with (1.3), many researchers have focused their attention on this problem and obtained some very meaningful results. Bartsch, Jeanjean, Soave [6] and Bartsch, Soave [8] considered the following system case

$$

with $\beta>0$ and $\beta<0$ respectively, they found solutions to (1.6) for specific range of $\beta$ depending on $a, b$. Later in [10], Bartsch, Zhong and Zou presented a new approach based on the fixed point index in cones, bifurcation theory and the continuation method, and obtained the existence of normalized solution for $\beta>0$ belonging to much better ranges, which is independent of the prescribed masses $a$ and $b$. For more results about (1.6), see also [9] and the references therein.

In [35], Shibata introduced a new rearrangement inequality. And then applied the rearrangement inequality to prove the convergence of any minimizing sequences for a minimizing problem of the form

and the function $G(s, t)$ satisfies various assumptions and is of mass sub-critical.
For the following important and much more general system

\begin{cases}-\Delta u+\lambda_{1} u=\mu_{1}|u|^{p-2} u+\beta r_{1}|u|^{r_{1}-2}|v|^{r_{2}} u & \text { in } \mathbb{R}^{N},  \tag{1.8}\\ -\Delta v+\lambda_{2} v=\mu_{2}|v|^{q-2} v+\beta r_{2}|u|^{r_{1}}|v|^{r_{2}-2} v & \text { in } \mathbb{R}^{N}, \\ \int_{\mathbb{R}^{N}} u^{2}=a, \int_{\mathbb{R}^{N}} v^{2}=b, & \end{cases}
$$

Gou and Jeanjean [17] proved the pre-compactness of the minimizing sequences up to translation for mass sub-critical problems. In [18], the authors also studied the mass supercritical case. Some mass mixed cases are also considered by Bartsch and Jeanjean [5]. Recently, Li and Zou [24] also studied (1.8) for $N=3,4$, and the nonlinearities are of mixed terms which involves Sobolev critical exponent. We also note that when $G(u, v):=\frac{\mu_{1}}{p}|u|^{p}+\frac{\mu_{2}}{q}|v|^{q}+$ $\beta|u|^{r_{1}}|v|^{r_{2}}$ involves linear coupled terms, it has its own difficulties in mathematical processing.

For the mass sub-critical case, we refer to Chen and Zou [12]. And for the mass mixed case, we refer to Chen, Zhong and Zou [13].

When the system involves potentials, it will become very complicated in mathematical processing. Let us consider the following system

as we know, the first result is given by Guo, Li, Wei and Zeng [19], where the authors considered the mass critical case. In [19], they assumed that $N=2, p_{1}=q_{1}=4, r_{1}=r_{2}=2$ and $0 \leq V_{i} \in C_{l o c}^{\alpha}\left(\mathbb{R}^{2}\right)(i=1,2)$ satisfies that for $i=1,2$,

and showed the existence of normalized solutions to (1.9) when $\mu_{1}, \nu_{1}, \beta$ are appropriately small positive constants. Recently, Ikoma and Miyamoto [22] gave a progress in this direction. They assumed that $V_{i} \in C\left(\mathbb{R}^{N}\right), V_{i}(x) \leq \lim _{|x| \rightarrow \infty} V_{i}(x)=: V_{i, \infty}(i=1,2)$ and discussed the compactness of any minimizing sequence and the existence of normalized solutions for the mass sub-critical case. However, Ikoma and Miyamoto only considered the case of $r_{1}=r_{2}$ and assumed that both $V_{1}(x)$ and $V_{2}(x)$ are bounded, or one of them is bounded and the other one is coercive. In particular, the potentials are bounded from below there.

Based on these observations, we shall study the existence of ground state normalized solution to systems with much more general potentials which are allowed to be singular at some points and also make contributions to get rid of the constraint that $r_{1}=r_{2}$. Precisely, we are concerned with the existence of real numbers $\lambda_{1}, \lambda_{2} \in \mathbb{R}$ and $u_{1}, u_{2} \in H^{1}\left(\mathbb{R}^{N}\right)$ that solve the following system:

$$

where

and $V_{1}(x), V_{2}(x)$ satisfy the following assumption:
(VH1) For $\iota=1,2, V_{\iota}(x) \leq 0$ in $\mathbb{R}^{N}$ and $\lim _{|x| \rightarrow \infty} V_{\iota}(x)=0$. Furthermore, there exist some $\sigma_{\iota} \in[0,1)$ and $\tau_{\iota} \geq 0$ such that

Remark 1.1. We note that for the bounded potentials $V_{\iota}(x) \leq 0$ with $-\tau_{\iota}:=\inf _{x \in \mathbb{R}^{N}} V_{\iota}(x)>$ $-\infty$, then $\|u\|_{V_{l}}^{2} \leq \tau_{\iota}\|u\|_{2}^{2}$, and thus (VH1) holds naturally. Another important application for unbounded potential is that $V_{\iota}(x)=-\frac{\kappa_{\iota}}{\left|x s^{\prime}\right\rangle}$ with $s_{\iota} \in(0,2), \kappa_{\iota}>0$ or $s_{\iota}=2, \kappa_{\iota} \in\left(0, \frac{(N-2)^{2}}{4}\right)$ for $N \geq 3$. In particular, the Coulomb potential is within our consideration, which is very important in physics. On the other hand, we emphasize that our argument is indeed valid for general $G$ of the form

with some suitable assumptions on $F\left(u_{1}, u_{2}\right)$ and $r_{1,1} \neq r_{2,1}$ is allowed.
Before stating our results, we give a definition.
Definition 1.2. For given $a_{1}>0, a_{2}>0$, a solution $\left(\lambda_{1}, \lambda_{2}, u_{1}, u_{2}\right)$ to (1.10) is called ground state normalized solution, or least energy normalized solution, if

Firstly, we are concerned with the radial potential case that
(VH2) $V_{\iota}(x)=V_{\iota}(|x|), \iota=1,2$ are non-decreasing functions with respect to $r=|x|$.
Our first main result is stated as following:
Theorem 1.3. Suppose that $(V H 1)-(V H 2)$ hold and $G(s, t)$ is given by (1.11). Then problem (1.10) has a ground state normalized solution $\left(\lambda_{1}, \lambda_{2}, u_{1}, u_{2}\right)$ with $\lambda_{1} \geq 0, \lambda_{2} \geq 0$ and $\left(u_{1}, u_{2}\right) \in \mathcal{H}^{\text {rad }}\left(\mathbb{R}^{N}\right)$, where $\mathcal{H}^{\text {rad }} \subset \mathcal{H}$ denotes the radial subspace.

When the potential $V_{\iota}(x)$ is not of radial, we can not work in the radial subspace as [5, 17], etc. In order to state our next main theorem, without loss of generality, we assume that

For the technical reason (see Remark 1.5 below), we require the following assumption in addition.

Here comes our another main theorem focused on the case that $V_{\iota}(x)$ is not necessary radial.
Theorem 1.4. Suppose that ( $V H 1$ ) holds and $G(s, t)$ is given by (1.11) satisfying (1.13) and (1.14). Then for any $a_{1}>0, a_{2}>0$, Problem (1.10) has a ground state normalized solution $\left(\lambda_{1}, \lambda_{2}, u_{1}, u_{2}\right)$ with $\lambda_{1}>0, \lambda_{2}>0,\left(u_{1}, u_{2}\right) \in \mathcal{H}$ and $u_{1}>0, u_{2}>0$ in $\mathbb{R}^{N}$.

Remark 1.5. For these Lagrange multipliers $\lambda_{1}$ and $\lambda_{2}$, from a physical point of view it represents the chemical potentials of standing waves. We point out that there are situations in the Bose-Einstein condensate theory that requires the chemical potentials are positive, see [26, 32]. By a well-known result own to Frank H. Clarke(see [14, Theorem 1]), we always have that $\lambda_{1} \geq 0$ and $\lambda_{2} \geq 0$, see also Proposition 3.7 in Section 3. When $V_{\iota}(x)$ is not of radial, to prove the strict binding inequality, we need a sharp decay estimation of the positive solution.

And that the positiveness of the Lagrange multipliers plays an crucial role. Hence, we need to exclude the case of $\lambda_{\iota}=0(\iota=1,2)$. Just because of this, we need to use the known Liouville type result. Observing that $\partial_{\iota} G\left(u_{1}, u_{2}\right) \geq 0$ in $\mathbb{R}^{N}, \iota=1,2$. So by the known Liouville type results, one can see that $\lambda_{\iota}>0$ provided $1 \leq N \leq 4$. From a mathematical point of view, it seems that $\lambda_{\iota}=0$ may happen for high dimension case without any other condition. However, if suppose $p_{1}, q_{1} \in\left(2,2+\frac{2}{N-2}\right]$ in addition to the assumptions, one can also exclude the case of $\lambda_{\iota}=0$, see for instance [20, Lemma A.2]. For our case, see Lemma 7.4 in Section 7.

For the mass sub-critical problem (1.10), it is easy to see that the corresponding functional is bounded from below on the masses constrained manifold (see Lemma 2.3), which admits us to apply the minimizing argument. But the compactness is not easy to show. Comparing with [22], our nonlinearities are more general and both $V_{1}(x)$ and $V_{2}(x)$ can be allowed to be singular at some points, which brings much more difficulties to us in mathematical processing. To obtain the compactness, we need to show the strict sub-additive inequality, which urges us to prove Proposition 6.5: If $\left(u_{1}, u_{2}\right) \neq(0,0)$ is a nonnegative solution to (5.1) and $\left(\omega_{1}, \omega_{2}\right) \neq(0,0)$ is a nonnegative solution to (5.9), then there exists some $\left(\phi_{1}, \phi_{2}\right) \in \mathcal{H}$ such that

$$
\begin{equation*}
\left(\left\|\phi_{1}\right\|_{2}^{2},\left\|\phi_{2}\right\|_{2}^{2}\right)=\left(\left\|u_{1}\right\|_{2}^{2}+\left\|\omega_{1}\right\|_{2}^{2},\left\|u_{2}\right\|_{2}^{2}+\left\|\omega_{2}\right\|_{2}^{2}\right) \text { and } J\left[\phi_{1}, \phi_{2}\right]<J\left[u_{1}, u_{2}\right]+I\left[\omega_{1}, \omega_{2}\right] . \tag{1.15}
\end{equation*}
$$

To get Proposition 6.5, we need a sharp decay estimations of the positive solutions to (5.1) and (5.9) (See Proposition 5.4). A better interaction estimation for the couples terms is also crucial, see Lemma 6.4. The general nonlinearities also make the calculations very complicated when we show the Proposition 6.5.

The paper is organized as follows. We collect and prove a few basic facts about the minimizing sequence related to (1.10) in Section 2. In Section 3, we shall prove some properties of $C_{a_{1}, a_{2}}$, such as the monotonicity, continuity and binding inequality. In Section 4, we shall focus on the radial case and prove Theorem 1.3 via the rearrangement argument. For the non-radial case, to establish the strict binding inequality, a better decay estimation of the positive solutions is necessary. So in Section 5, we shall give a sharp decay estimations of the positive solutions for the fixed frequency problem. Basing on these results, we can prove the strict binding inequality in Section 6 (see Proposition 6.5). Finally in Section 7, we apply the standard concentration compactness argument to prove Theorem 1.4.

Throughout the paper we use the notation $\|u\|_{p}$ to denote the $L^{p}$-norm, and simply write $\mathcal{H}=H^{1}\left(\mathbb{R}^{N}\right) \times H^{1}\left(\mathbb{R}^{N}\right)$. $\mathcal{H}^{\text {rad }}$ denotes the radial subspace. The notation $\rightharpoonup$ denotes weak convergence in $H^{1}\left(\mathbb{R}^{N}\right)$ or $\mathcal{H}$. Capital latter $C$ stands for positive constant which may depend on some parameters, whose precise value can change from line to line.

## 2. Some Preliminaries

In this section, we summarize several results that will be used in the rest discussion.
Lemma 2.1. Suppose that $G(s, t)$ is given by (1.11). Then for any $\varepsilon>0$, there exists some $C_{\varepsilon}>0$ such that

On the other hand, let $p \in\left(2,2+\frac{4}{N}\right)$, for any $\varepsilon>0$, there exists some $C_{\varepsilon}>0$ such that

It is easy to check that (2.1) holds by using (1.11).
Lemma 2.2. Suppose that (VH1) holds and $G(s, t)$ is given by (1.11). Let $\sigma:=\frac{1-\max \left\{\sigma_{1}, \sigma_{2}\right\}}{2}>$ 0 determined by (VH1). Then for any $\varepsilon>0$, there exists some $C_{\varepsilon}>0$ such that

& J\left[u_{1}, u_{2}\right] \geq \sigma\left(\left\|\nabla u_{1}\right\|_{2}^{2}+\left\|\nabla u_{2}\right\|_{2}^{2}\right)-C_{\varepsilon}\left(\left\|u_{1}\right\|_{2}^{2}+\left\|u_{2}\right\|_{2}^{2}\right) \\
& -\varepsilon\left(\left\|\nabla u_{1}\right\|_{2}^{2}\left\|u_{1}\right\|_{2}^{\frac{4}{N}}+\left\|\nabla u_{2}\right\|_{2}^{2}\left\|u_{2}\right\|_{2}^{\frac{4}{N}}\right), \quad \forall\left(u_{1}, u_{2}\right) \in \mathcal{H}
\end{aligned}
$$

Proof. By Lemma 2.1, we have that for any $\varepsilon>0$, there exists some $C_{\varepsilon}>0$ such that

\end{equation*}

So we have

\int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x \leq C_{\varepsilon}\left(\left\|u_{1}\right\|_{2}^{2}+\left\|u_{2}\right\|_{2}^{2}\right)+\varepsilon\left(\left\|u_{1}\right\|_{2+\frac{4}{N}}^{2+\frac{4}{N}}+\left\|u_{2}\right\|_{2+\frac{4}{N}}^{2+\frac{4}{N}}\right) \tag{2.4}
\end{equation*}
$$

By Gagliardo-Nirenberg inequality, there exists some $C(N)>0$ such that

\begin{equation*}
\|v\|_{2+\frac{4}{N}}^{2+\frac{4}{N}} \leq C(N)\|\nabla v\|_{2}^{2}\|v\|_{2}^{\frac{4}{N}}, \forall v \in H^{1}\left(\mathbb{R}^{N}\right) \tag{2.5}
\end{equation*}
$$

Under the assumption (VH1), we have that

\left\|\nabla u_{\iota}\right\|_{2}^{2}-\left\|u_{\iota}\right\|_{V_{\iota}}^{2} \geq\left(1-\sigma_{\iota}\right)\left\|\nabla u_{\iota}\right\|_{2}^{2}-\tau_{\iota}\left\|u_{\iota}\right\|_{2}^{2}, \iota=1,2 . \tag{2.6}
\end{equation*}
$$

So by $(2.4),(2.5),(2.6)$, we obtain that

J\left[u_{1}, u_{2}\right]= & \frac{1}{2} \sum_{\iota=1}^{2}\left(\left\|\nabla u_{\iota}\right\|_{2}^{2}-\left\|u_{\iota}\right\|_{V_{\iota}}^{2}\right)-\int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x \\
\geq & \frac{1}{2} \sum_{\iota=1}^{2}\left[\left(1-\sigma_{\iota}\right)\left\|\nabla u_{\iota}\right\|_{2}^{2}-\tau_{\iota}\left\|u_{\iota}\right\|_{2}^{2}\right]-\int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x \\
\geq & \frac{1}{2} \sum_{\iota=1}^{2}\left[\left(1-\sigma_{\iota}\right)\left\|\nabla u_{\iota}\right\|_{2}^{2}-\tau_{\iota}\left\|u_{\iota}\right\|_{2}^{2}\right]-C_{\varepsilon}\left(\left\|u_{1}\right\|_{2}^{2}+\left\|u_{2}\right\|_{2}^{2}\right) \\
& -\varepsilon\left(\left\|u_{1}\right\|_{2+\frac{4}{N}}^{2+\frac{4}{N}}+\left\|u_{2}\right\|_{2+\frac{4}{N}}^{2+\frac{4}{N}}\right) \\
\geq & \sigma\left(\left\|\nabla u_{1}\right\|_{2}^{2}+\left\|\nabla u_{2}\right\|_{2}^{2}\right)-\left(\frac{\tau_{1}}{2}+C_{\varepsilon}\right)\left\|u_{1}\right\|_{2}^{2}-\left(\frac{\tau_{2}}{2}+C_{\varepsilon}\right)\left\|u_{2}\right\|_{2}^{2} \\
& -\varepsilon C(N)\left(\left\|\nabla u_{1}\right\|_{2}^{2}\left\|u_{1}\right\|_{2}^{\frac{4}{N}}+\left\|\nabla u_{1}\right\|_{2}^{2}\left\|u_{1}\right\|_{2}^{\frac{4}{N}}\right)
\end{aligned}
$$

Replaced $\varepsilon C(N)$ by $\varepsilon$, and redefine $C_{\varepsilon}$, we finish the proof.
Lemma 2.3. Suppose that (VH1) holds and $G(s, t)$ is given by (1.11). For any $a_{1} \geq 0, a_{2} \geq 0$,

C_{a_{1}, a_{2}}:=\inf _{\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}} J\left[u_{1}, u_{2}\right]>-\infty
$$

Proof. By Lemma 2.2, for any $\varepsilon>0$, there exists some $C_{\varepsilon}>0$ such that

& J\left[u_{1}, u_{2}\right] \geq \sigma\left(\left\|\nabla u_{1}\right\|_{2}^{2}+\left\|\nabla u_{2}\right\|_{2}^{2}\right)-C_{\varepsilon}\left(\left\|u_{1}\right\|_{2}^{2}+\left\|u_{2}\right\|_{2}^{2}\right) \\
& -\varepsilon\left(\left\|\nabla u_{1}\right\|_{2}^{2}\left\|u_{1}\right\|_{2}^{\frac{4}{N}}+\left\|\nabla u_{2}\right\|_{2}^{2}\left\|u_{2}\right\|_{2}^{\frac{4}{N}}\right) .
\end{aligned}
$$

So for any $\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}$, we choose $\varepsilon>0$ small enough such that $\varepsilon a_{\iota}^{\frac{2}{N}}<\frac{\sigma}{2}, \iota=1,2$. For such a fixed $\varepsilon$, we have

$$

Hence,

C_{a_{1}, a_{2}}:=\inf _{\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}} J\left[u_{1}, u_{2}\right] \geq-C_{\varepsilon}\left(a_{1}+a_{2}\right)>-\infty .
$$

Lemma 2.4. Suppose that $(V H 1)$ holds and $G(s, t)$ is given by (1.11). Then any $L^{2}$-bounded sequence $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}$ with $\sup _{\vartheta \in \mathbb{N}} J\left[u_{1, \vartheta}, u_{2, \vartheta}\right]<\infty$ is also bounded in $\mathcal{H}$.

Proof. Let $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}$ be a $L^{2}$-bounded sequence, i.e., $\left\|u_{\iota, \vartheta}\right\|_{2}^{2} \leq M_{\iota}, \iota=1,2$. Suppose that $J\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \leq M_{3}, \forall \vartheta \in \mathbb{N}$. Recalling Lemma 2.2, for any $\varepsilon>0$, there exists some $C_{\varepsilon}>0$ such that

M_{3} \geq J\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \geq & \sigma\left(\left\|\nabla u_{1, \vartheta}\right\|_{2}^{2}+\left\|\nabla u_{2, \vartheta}\right\|_{2}^{2}\right)-C_{\varepsilon}\left(\left\|u_{1, \vartheta}\right\|_{2}^{2}+\left\|u_{2, \vartheta}\right\|_{2}^{2}\right) \\
& -\varepsilon\left(\left\|\nabla u_{1, \vartheta}\right\|_{2}^{2}\left\|u_{1, \vartheta}\right\|_{2}^{\frac{4}{N}}+\left\|\nabla u_{2, \vartheta}\right\|_{2}^{2}\left\|u_{2, \vartheta}\right\|_{2}^{\frac{4}{N}}\right) \\
\geq & \sigma\left(\left\|\nabla u_{1, \vartheta}\right\|_{2}^{2}+\left\|\nabla u_{2, \vartheta}\right\|_{2}^{2}\right)-C_{\varepsilon}\left(M_{1}+M_{2}\right) \\
& -\varepsilon\left(M_{1}^{\frac{2}{N}}\left\|\nabla u_{1, \vartheta}\right\|_{2}^{2}+M_{2}^{\frac{2}{N}}\left\|\nabla u_{2, \vartheta}\right\|_{2}^{2}\right) .
\end{aligned}
$$

We can take $\varepsilon>0$ small enough such that $\varepsilon M_{\iota}^{\frac{2}{N}}<\frac{1}{2} \sigma, \iota=1,2$. Then it follows that

and this implies that the sequence $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}_{\vartheta=1}^{\infty}$ is bounded in $\mathcal{H}$.

## Remark 2.5.

(i) Suppose that (VH1) holds and $G(s, t)$ is given by (1.11). For any given $a_{1}>$ $0, a_{2}>0$, by Lemma 2.3 and Ekeland's variational principle, the existence of PalaisSmale minimizing sequence is trivial. Furthermore, by Lemma 2.4, this Palais-Smale minimizing sequence is also bounded in $\mathcal{H}$. So the main difficulty of mass sub-critical problem is the compactness.
(ii) Define

$$
\begin{equation*}
I\left[u_{1}, u_{2}\right]:=\frac{1}{2} \sum_{\iota=1}^{2}\left\|\nabla u_{\iota}\right\|_{2}^{2}-\int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x, \forall\left(u_{1}, u_{2}\right) \in \mathcal{H} \tag{2.8}
\end{equation*}
$$

and

$$
\begin{equation*}
E_{a_{1}, a_{2}}:=\inf _{\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}} I\left[u_{1}, u_{2}\right] . \tag{2.9}
\end{equation*}
$$

It is equivalent to take $V_{1}(x) \equiv V_{2}(x) \equiv 0$ in $J\left[u_{1}, u_{2}\right]$ (which means that $\sigma_{\iota}=0, \tau_{\iota}=0$ and $\left.\sigma:=\frac{1-\max \left\{\sigma_{1}, \sigma_{2}\right\}}{2}=\frac{1}{2}\right)$. So we have a sequence of conclusions for $I\left[u_{1}, u_{2}\right]$ and $E_{a_{1}, a_{2}}$, as that in Lemmas 2.2-2.4.

## 3. SOME PROPERTIES OF $C_{a_{1}, a_{2}}$ AND $E_{a_{1}, a_{2}}$

In this section, we shall establish some basic properties of $C_{a_{1}, a_{2}}$ and $E_{a_{1}, a_{2}}$ including monotonicity, continuity and binding inequality.

Observing that $J\left[u_{1}, u_{2}\right]=I\left[u_{1}, u_{2}\right]-\frac{1}{2} \sum_{\iota=1}^{2}\left\|u_{\iota}\right\|_{V_{\iota}}^{2}$, so we have $C_{a_{1}, a_{2}} \leq E_{a_{1}, a_{2}}$. Recalling the fiber map

$$
\begin{equation*}
u(x) \mapsto(t \star u)(x):=t^{\frac{N}{2}} u(t x) \tag{3.1}
\end{equation*}
$$

for $(t, u) \in \mathbb{R}^{+} \times H^{1}\left(\mathbb{R}^{N}\right)$, which preserves the $L^{2}$-norm, we have the following result.
Lemma 3.1. Suppose that (VH1) holds and $G(s, t)$ is given by (1.11). For any $a_{1} \geq 0, a_{2} \geq 0$ and $\left(a_{1}, a_{2}\right) \neq(0,0)$, then $C_{a_{1}, a_{2}} \leq E_{a_{1}, a_{2}}<0$. In particular, if $E_{a_{1}, a_{2}}$ is attained, and $V_{\iota}(x) \not \equiv 0, \iota=1,2$, then $C_{a_{1}, a_{2}}<E_{a_{1}, a_{2}}<0$.

Proof. Letting $\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}$, we remark that $t \star\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}$ for any $t>0$. A direct computation shows that

\end{equation*}
$$

Noting that

G\left(t^{\frac{N}{2}} u_{1}, t^{\frac{N}{2}} u_{2}\right)=o(1) t^{N}\left(\left|u_{1}\right|^{2}+\left|u_{2}\right|^{2}\right), \text { as } t \rightarrow 0^{+}
$$

we have $\lim _{t \rightarrow 0^{+}} I\left[t \star\left(u_{1}, u_{2}\right)\right]=0$. On the other hand, for $t>0$ small enough, by (1.11), there exists some $\varepsilon_{0}>0$ such that

\frac{I\left[t \star\left(u_{1}, u_{2}\right)\right]}{t^{2}} & =\frac{1}{2} \sum_{\iota=1}^{2}\left\|\nabla u_{\iota}\right\|_{2}^{2}-t^{-N-2} \int_{\mathbb{R}^{N}} G\left(t^{\frac{N}{2}} u_{1}, t^{\frac{N}{2}} u_{2}\right) d x \\
& \leq \frac{1}{2} \sum_{\iota=1}^{2}\left\|\nabla u_{\iota}\right\|_{2}^{2}-\varepsilon_{0} t^{-N-2} \int_{\mathbb{R}^{N}} \frac{\mu_{1}}{p_{1}}\left|t^{\frac{N}{2}} u_{1}\right|^{p_{1}}+\frac{\nu_{1}}{q_{1}}\left|t^{\frac{N}{2}} u_{2}\right|^{q_{1}} d x \\
& =\frac{1}{2} \sum_{\iota=1}^{2}\left\|\nabla u_{\iota}\right\|_{2}^{2}-\varepsilon_{0} \frac{\mu_{1}}{p_{1}}\left\|u_{1}\right\|_{p_{1}}^{p_{1}} t^{\frac{N}{2} p_{1}-N-2}-\varepsilon_{0} \frac{\nu_{1}}{q_{1}}\left\|u_{2}\right\|_{q_{1}}^{q_{1}} t^{\frac{N}{2} q_{1}-N-2}
\end{aligned}
$$

Noting that $p_{1}, q_{1} \in\left(2,2+\frac{4}{N}\right)$, we have that $\frac{N}{2} p_{1}-N-2<0, \frac{N}{2} q_{1}-N-2<0$. By $\left(a_{1}, a_{2}\right) \neq(0,0)$, at least one of $\left\|u_{1}\right\|_{p_{1}}^{p_{1}}$ and $\left\|u_{2}\right\|_{q_{1}}^{q_{1}}$ is positive. Hence, there exists some $t_{0}>0$ such that

\frac{d}{d t} I\left[t \star\left(u_{1}, u_{2}\right)\right]<0, \forall t \in\left(0, t_{0}\right) \tag{3.3}
\end{equation*}
$$

which implies that $I\left[t \star\left(u_{1}, u_{2}\right)\right]<0 \forall t \in\left(0, t_{0}\right)$. Recalling that $J\left[u_{1}, u_{2}\right]=I\left[u_{1}, u_{2}\right]-$ $\frac{1}{2} \sum_{\iota=1}^{2}\left\|u_{\iota}\right\|_{V_{\iota}}^{2} \leq I\left[u_{1}, u_{2}\right]$, we have that

C_{a_{1}, a_{2}}:=\inf _{\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}} J\left[u_{1}, u_{2}\right] \leq E_{a_{1}, a_{2}}:=\inf _{\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}} I\left[u_{1}, u_{2}\right]<0
$$

In particular, if $E_{a_{1}, a_{2}}$ is attained, we can take $(0,0) \neq\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}$ with $u_{1} \geq 0, u_{2} \geq 0$ such that $I\left[u_{1}, u_{2}\right]=E_{a_{1}, a_{2}}$. A standard elliptic estimation shows the solution is of classical.

So by strong maximum principle, it is easy to see that at least one of $u_{1}$ and $u_{2}$ is positive in $\mathbb{R}^{N}$. Then by $V_{\iota}(x) \leq 0$ but $V_{\iota}(x) \not \equiv 0, \iota=1,2$, we obtain that

Lemma 3.2. For $\left(a_{1}, a_{2}\right),\left(b_{1}, b_{2}\right) \in \mathbb{R}_{+}^{2}$, we have

C_{a_{1}+b_{1}, a_{2}+b_{2}} \leq C_{a_{1}, a_{2}}+E_{b_{1}, b_{2}} \text { and } E_{a_{1}+b_{1}, a_{2}+b_{2}} \leq E_{a_{1}, a_{2}}+E_{b_{1}, b_{2}} .
$$

Proof. We only prove $C_{a_{1}+b_{1}, a_{2}+b_{2}} \leq C_{a_{1}, a_{2}}+E_{b_{1}, b_{2}}$, and $E_{a_{1}+b_{1}, a_{2}+b_{2}} \leq E_{a_{1}, a_{2}}+E_{b_{1}, b_{2}}$ can be proved by taking $V_{1}(x) \equiv V_{2}(x) \equiv 0$. If $\left(a_{1}, a_{2}\right)=(0,0)$ or $\left(b_{1}, b_{2}\right)=(0,0)$, it is trivial. Next, we suppose that $\left(a_{1}, a_{2}\right) \neq(0,0)$ and $\left(b_{1}, b_{2}\right) \neq(0,0)$. For any $\varepsilon>0$, by density, we can take some $\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}},\left(v_{1}, v_{2}\right) \in S_{b_{1}, b_{2}}$ with $u_{\iota}, v_{\iota} \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right), \iota=1,2$, such that

$$
C_{a_{1}, a_{2}} \leq J\left[u_{1}, u_{2}\right]<C_{a_{1}, a_{2}}+\frac{\varepsilon}{2} \text { and } E_{b_{1}, b_{2}} \leq I\left[v_{1}, v_{2}\right]<E_{b_{1}, b_{2}}+\frac{\varepsilon}{2} .
$$

Let $\left(v_{1, R}, v_{2, R}\right):=\left(v_{1}\left(\cdot-R \mathbf{e}_{\mathbf{1}}\right), v_{2}\left(\cdot-R \mathbf{e}_{\mathbf{1}}\right)\right)$. Take some $R_{0}>0$ large enough such that

$$
\left(\operatorname{supp} u_{1} \cup \operatorname{supp} u_{2}\right) \cap\left(\operatorname{supp} v_{1, R_{0}} \cup \operatorname{supp} v_{2, R_{0}}\right)=\emptyset .
$$

Then we have that ( $u_{1}+v_{1, R}, u_{2}+v_{2, R}$ ) $\in S_{a_{1}+b_{1}, a_{2}+b_{2}}, \forall R \geq R_{0}$, and

$$
\begin{aligned}
& J\left[u_{1}+v_{1, R}, u_{2}+v_{2, R}\right]=J\left[u_{1}, u_{2}\right]+J\left[v_{1, R}, v_{2, R}\right] \leq J\left[u_{1}, u_{2}\right]+I\left[v_{1, R}, v_{2, R}\right] \\
= & J\left[u_{1}, u_{2}\right]+I\left[v_{1}, v_{2}\right] \leq C_{a_{1}, a_{2}}+E_{b_{1}, b_{2}}+\varepsilon .
\end{aligned}
$$

By the arbitrary of $\varepsilon$, we obtain that $C_{a_{1}+b_{1}, a_{2}+b_{2}} \leq C_{a_{1}, a_{2}}+E_{b_{1}, b_{2}}$.
Corollary 3.3. For $\left(a_{1}, a_{2}\right),\left(b_{1}, b_{2}\right) \in \mathbb{R}_{+}^{2}$ with $\left(b_{1}, b_{2}\right) \neq(0,0)$, then $C_{a_{1}+b_{1}, a_{2}+b_{2}}<C_{a_{1}, a_{2}}$ and $E_{a_{1}+b_{1}, a_{2}+b_{2}}<E_{a_{1}, a_{2}}$.

Proof. Recalling Lemma 3.1, we have $E_{b_{1}, b_{2}}<0$ for $\left(b_{1}, b_{2}\right) \neq(0,0)$. Then by Lemma 3.2, one can see that $C_{a_{1}+b_{1}, a_{2}+b_{2}}<C_{a_{1}, a_{2}}$ and $E_{a_{1}+b_{1}, a_{2}+b_{2}}<E_{a_{1}, a_{2}}$.
Lemma 3.4. Suppose that (VH1) holds and $G(s, t)$ is given by (1.11). Let $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}$ be bounded in $\mathcal{H}$ with $\left(\left\|u_{1, \vartheta}\right\|_{2}^{2},\left\|u_{2, \vartheta}\right\|_{2}^{2}\right) \rightarrow\left(a_{1}, a_{2}\right) \in \mathbb{R}_{+}^{2}$. Then we have

$$
\begin{equation*}
\liminf _{\vartheta \rightarrow \infty} J\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \geq C_{a_{1}, a_{2}} \tag{3.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\liminf _{\vartheta \rightarrow \infty} I\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \geq E_{a_{1}, a_{2}} . \tag{3.5}
\end{equation*}
$$

Proof. We only prove (3.4). If $a_{1}=a_{2}=0$, then we have that $\left(u_{1, \vartheta}, u_{2, \vartheta}\right) \rightarrow(0,0)$ in $L^{2}\left(\mathbb{R}^{N}\right) \times L^{2}\left(\mathbb{R}^{N}\right)$. Since $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}$ is bounded in $\mathcal{H}$, by Gagliardo-Nirenberg inequality, one can see that $u_{\iota, \vartheta} \rightarrow 0$ in $L^{p}\left(\mathbb{R}^{N}\right)$ for $2 \leq p<2^{*}$ and $\iota=1,2$. Hence,

$$
\int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}, u_{2, \vartheta}\right) d x \rightarrow 0 \text { as } \vartheta \rightarrow \infty
$$

By (VH1), we obtain that

$$
\liminf _{\vartheta \rightarrow \infty} J\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \geq 0=C_{0,0} .
$$

If $a_{1}=0<a_{2}$, we have that $u_{1, \vartheta} \rightarrow 0$ in $L^{2}\left(\mathbb{R}^{N}\right)$. Then by Gagliardo-Nirenberg inequality again, $u_{1, \vartheta} \rightarrow 0$ in $L^{p}\left(\mathbb{R}^{N}\right)$ for $2 \leq p<2^{*}$. By mean value theorem, there exists some $0 \leq v_{1, \vartheta}(x) \leq u_{1, \vartheta}$ such that

$$
\begin{equation*}
\int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}, u_{2, \vartheta}\right) d x-\int_{\mathbb{R}^{N}} G\left(0, u_{2, \vartheta}\right) d x=\int_{\mathbb{R}^{N}} \partial_{1} G\left(v_{1, \theta}, u_{2, \vartheta}\right) u_{1, \vartheta} d x \rightarrow 0 \tag{3.6}
\end{equation*}
$$

Hence,

$$
\liminf _{\vartheta \rightarrow \infty} J\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \geq \liminf _{\vartheta \rightarrow \infty} J\left[0, u_{2, \vartheta}\right] .
$$

By $\left\|u_{2, \vartheta}\right\|_{2}^{2} \rightarrow a_{2}>0$, without loss of generality, we may assume that $\left\|u_{2, \vartheta}\right\|_{2}>0$ for all $\vartheta \in \mathbb{N}$. Let $v_{2, \vartheta}:=\frac{\sqrt{a_{2}}}{\left\|u_{2, \vartheta}\right\|_{2}} u_{2, \vartheta}, \forall \vartheta \in \mathbb{N}$. Then we have that

\left\|v_{2, \vartheta}\right\|_{2}^{2}=a_{2}, u_{2, \vartheta}=t_{\vartheta} v_{2, \vartheta} \text { with } t_{\vartheta} \rightarrow 1 \tag{3.7}
\end{equation*}
$$

Then we have

$$
\begin{equation*}
\left\|\nabla u_{2, \vartheta}\right\|_{2}^{2}-\left\|u_{2, \vartheta}\right\|_{V_{2}}^{2}=t_{\vartheta}^{2}\left[\left\|\nabla v_{2, \vartheta}\right\|_{2}^{2}-\left\|v_{2, \vartheta}\right\|_{V_{2}}^{2}\right]=(1+o(1))\left[\left\|\nabla v_{2, \vartheta}\right\|_{2}^{2}-\left\|v_{2, \vartheta}\right\|_{V_{2}}^{2}\right] \tag{3.8}
\end{equation*}
$$

and by mean value theorem, there exists some $\eta_{\vartheta}(x) \in\left[\min \left\{t_{\vartheta}, 1\right\}\right.$, $\left.\max \left\{t_{\vartheta}, 1\right\}\right]$ such that

$$
\begin{equation*}
\int_{\mathbb{R}^{N}} G\left(0, u_{2, \vartheta}\right) d x-\int_{\mathbb{R}^{N}} G\left(0, v_{2, \vartheta}\right) d x=\left(t_{\vartheta}-1\right) \int_{\mathbb{R}^{N}} \partial_{2} G\left(0, \eta_{\vartheta} v_{2, \vartheta}\right) v_{2, \vartheta} d x \rightarrow 0 \tag{3.9}
\end{equation*}
$$

Hence,

$$
\liminf _{\vartheta \rightarrow \infty} J\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \geq \liminf _{\vartheta \rightarrow \infty} J\left[0, v_{2, \vartheta}\right] \geq C_{0, a_{2}} .
$$

We remark that the case of $a_{1}>0=a_{2}$ can be proved similarly as above.
Finally, we consider the case of $a_{1}>0, a_{2}>0$. We let

$$
v_{\iota, \vartheta}=\frac{\sqrt{a_{\iota}}}{\left\|u_{\iota, \vartheta}\right\|_{2}} u_{\iota, \vartheta}, \quad \text { and } \quad t_{\iota, \vartheta}:=\frac{\left\|u_{\iota, \vartheta}\right\|_{2}}{\sqrt{a_{\iota}}}, \quad \iota=1,2 .
$$

Then we have that $u_{\iota, \vartheta}=t_{\iota, \vartheta} v_{\iota, \vartheta}$ with $\left\|v_{\iota, \vartheta}\right\|_{2}^{2}=a_{\iota}, \forall \vartheta \in \mathbb{N}$ and $t_{\iota, \vartheta}=1+o(1)$ as $\vartheta \rightarrow \infty$. Hence, similar to (3.8), for $\iota=1,2$, we also have

$$
\begin{equation*}
\left\|\nabla u_{\iota, \vartheta}\right\|_{2}^{2}-\left\|u_{\iota, \vartheta}\right\|_{V_{\iota}}^{2}=(1+o(1))\left[\left\|\nabla v_{\iota, \vartheta}\right\|_{2}^{2}-\left\|v_{\iota, \vartheta}\right\|_{V_{\iota}}^{2}\right] . \tag{3.10}
\end{equation*}
$$

On the other hand, there exist $\eta_{\iota, \vartheta}(x) \in\left[\min \left\{t_{\iota, \vartheta}, 1\right\}, \max \left\{t_{\iota, \vartheta}, 1\right\}\right]$ such that

$$
\begin{aligned}
\int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}, u_{2, \vartheta}\right) d x-\int_{\mathbb{R}^{N}} G\left(v_{1, \vartheta}, v_{2, \vartheta}\right) d x= & \int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}, u_{2, \vartheta}\right) d x-\int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}, v_{2, \vartheta}\right) d x \\
& +\int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}, v_{2, \vartheta}\right) d x-\int_{\mathbb{R}^{N}} G\left(v_{1, \vartheta}, v_{2, \vartheta}\right) d x \\
= & \left(t_{2, \vartheta}-1\right) \int_{\mathbb{R}^{N}} \partial_{2} G\left(u_{1, \vartheta}, \eta_{2, \vartheta} v_{2, \vartheta}\right) v_{2, \vartheta} d x \\
& +\left(t_{1, \vartheta}-1\right) \int_{\mathbb{R}^{N}} \partial_{2} G\left(\eta_{1, \vartheta} v_{1, \vartheta}, v_{2, \vartheta}\right) v_{1, \vartheta} d x \\
= & o(1) .
\end{aligned}
$$

We obtain that

$$
\liminf _{\vartheta \rightarrow \infty} J\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \geq \liminf _{\vartheta \rightarrow \infty} J\left[v_{1, \vartheta}, v_{2, \vartheta}\right] \geq C_{a_{1}, a_{2}}
$$

Corollary 3.5. Suppose that (VH1) holds and $G(s, t)$ is given by (1.11). Then $C_{a_{1}, a_{2}}$ and $E_{a_{1}, a_{2}}$ is continuous with respect to $\left(a_{1}, a_{2}\right) \in \mathbb{R}_{+}^{2}$.
Proof. We only prove the continuity of $C_{a_{1}, a_{2}}$. Let $\left(a_{1}, a_{2}\right) \in \mathbb{R}_{+}^{2}$. For any sequence $\left(a_{1, \vartheta}, a_{2, \vartheta}\right) \in\left(\mathbb{R}_{+}^{2}\right)$ with $\left(a_{1, \vartheta}, a_{2, \vartheta}\right) \rightarrow\left(a_{1}, a_{2}\right)$, we shall prove that

$$
\begin{equation*}
\lim _{\vartheta \rightarrow \infty} C_{a_{1, \vartheta}, a_{2, \vartheta}}=C_{a_{1}, a_{2}} \tag{3.11}
\end{equation*}
$$

Firstly, $\forall \varepsilon>0, \exists\left(u_{1, \vartheta}, u_{2, \vartheta}\right) \in S_{a_{1, \vartheta}, a_{2, \vartheta}}$ such that $C_{a_{1, \vartheta}, a_{2, \vartheta}} \leq J\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \leq C_{a_{1, \vartheta}, a_{2, \vartheta}}+\varepsilon$. Noting that $C_{a_{1, \vartheta}, a_{2, \vartheta}} \leq 0$, by Lemma 2.4, $\left(u_{1, \vartheta}, u_{2, \vartheta}\right)$ is bounded in $\mathcal{H}$. Then by Lemma 3.4, we have that

$$
\liminf _{\vartheta \rightarrow \infty} C_{a_{1, \vartheta}, a_{2, \vartheta}} \geq \liminf _{\vartheta \rightarrow \infty} J\left[u_{1, \vartheta}, u_{2, \vartheta}\right]-\varepsilon \geq C_{a_{1}, a_{2}}-\varepsilon
$$

By the arbitrary of $\varepsilon$, we obtain that

$$
\begin{equation*}
\liminf _{\vartheta \rightarrow \infty} C_{a_{1, \vartheta}, a_{2, \vartheta}} \geq C_{a_{1}, a_{2}} . \tag{3.12}
\end{equation*}
$$

If $a_{1}>0, a_{2}>0$, we put $t_{\iota, \vartheta}=\left(\frac{a_{\iota, \vartheta}}{a_{\iota}}\right)^{\frac{1}{2}}, \iota=1,2 . \forall \varepsilon>0, \exists\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}$ such that $J\left[u_{1}, u_{2}\right] \leq C_{a_{1}, a_{2}}+\varepsilon$. Then $\left(t_{1, \vartheta} u_{1}, t_{2, \vartheta} u_{2}\right) \in S_{a_{1, \vartheta}, a_{2, \vartheta}}$ and thus $C_{a_{1, \vartheta}, a_{2, \vartheta}} \leq J\left[t_{1, \vartheta} u_{1}, t_{2, \vartheta} u_{2}\right]$. Observing that $t_{\iota, \vartheta}=1+o(1), \iota=1,2$, we obtain that

$$
\limsup _{\vartheta \rightarrow \infty} C_{a_{1, \vartheta}, a_{2, \vartheta}} \leq \limsup _{\vartheta \rightarrow \infty} J\left[t_{1, \vartheta} u_{1}, t_{2, \vartheta} u_{2}\right]=J\left[u_{1}, u_{2}\right] \leq C_{a_{1}, a_{2}}+\varepsilon
$$

By the arbitrary of $\varepsilon$, we obtain that

$$
\begin{equation*}
\limsup _{\vartheta \rightarrow \infty} C_{a_{1, \vartheta}, a_{2, \vartheta}} \leq C_{a_{1}, a_{2}} . \tag{3.13}
\end{equation*}
$$

Therefore, by (3.12) and (3.13), we obtain that (3.11) holds.
If $a_{1}=a_{2}=0$, we have $C_{a_{1}, a_{2}}=0$. By Lemma 3.1, it is trivial that $\limsup _{\vartheta \rightarrow \infty} C_{a_{1, \vartheta}, a_{2, \vartheta}} \leq 0$, combing with (3.12), we see that the assertion (3.11) also holds.

If $a_{1}=0, a_{2}>0$. Let $t_{\vartheta}:=\left(\frac{a_{2, \vartheta}}{a_{2}}\right)^{\frac{1}{2}}$ and $\omega \in H^{1}\left(\mathbb{R}^{N}\right)$ such that $\|\omega\|_{2}^{2}=1$. For $\forall \varepsilon>0, \exists u_{2} \in H^{1}\left(\mathbb{R}^{N}\right)$ such that $\left\|u_{2}\right\|_{2}^{2}=a_{2}$ and $J\left[0, u_{2}\right] \leq C_{0, a_{2}}+\varepsilon$. Then we see that $\left(\sqrt{a_{1, \vartheta}} \omega, t_{\vartheta} u_{2}\right) \in S_{a_{1, \vartheta}, a_{2, \vartheta}}$, thus

$$
\begin{equation*}
C_{a_{1, \vartheta}, a_{2, \vartheta}} \leq J\left[\sqrt{a_{1, \vartheta}} \omega, t_{\vartheta} u_{2}\right] . \tag{3.14}
\end{equation*}
$$

Noting that $a_{1, \vartheta} \rightarrow 0$, we can prove that

$$
\begin{aligned}
\limsup _{\vartheta \rightarrow \infty} C_{a_{1, \vartheta}, a_{2, \vartheta}} & \leq \limsup _{\vartheta \rightarrow \infty} J\left[\sqrt{a_{1, \vartheta}} \omega, t_{\vartheta} u_{2}\right]=\limsup _{\vartheta \rightarrow \infty} J\left[0, t_{\vartheta} u_{2}\right] \\
& =J\left[0, u_{2}\right] \leq C_{0, a_{2}}+\varepsilon .
\end{aligned}
$$

Then by the arbitrary of $\varepsilon$ and (3.12), we also prove (3.11).
And the case of $a_{1}>0, a_{2}=0$ can be proved similarly.
Noting that $S_{a_{1}, a_{2}}$ is not weak closed, for this reason we introduce a new set

$$
\begin{equation*}
B_{a_{1}, a_{2}}:=\left\{\left(u_{1}, u_{2}\right) \in \mathcal{H}: \int_{\mathbb{R}^{N}} u_{\iota}^{2} d x \leq a_{\iota}, \iota=1,2\right\}, \forall\left(a_{1}, a_{2}\right) \in \mathbb{R}_{+}^{2} \tag{3.15}
\end{equation*}
$$

Then it is clear that $B_{a_{1}, a_{2}}$ is weak closed (compact). Define

$$
\begin{equation*}
D_{a_{1}, a_{2}}:=\inf _{u \in B_{a_{1}, a_{2}}} J\left[u_{1}, u_{2}\right] \text { and } F_{a_{1}, a_{2}}:=\inf _{\left(u_{1}, u_{2}\right) \in B a_{1}, a_{2}} I\left[u_{1}, u_{2}\right] . \tag{3.16}
\end{equation*}
$$

Lemma 3.6. For any $\left(a_{1}, a_{2}\right) \in \mathbb{R}_{+}^{2}$, we have that $C_{a_{1}, a_{2}}=D_{a_{1}, a_{2}}$ and $E_{a_{1}, a_{2}}=F_{a_{1}, a_{2}}$.
Proof. We only prove $C_{a_{1}, a_{2}}=D_{a_{1}, a_{2}}$. The case of $\left(a_{1}, a_{2}\right)=(0,0)$ is trivial. For $\left(a_{1}, a_{2}\right) \neq$ $(0,0)$, observing that $S_{a_{1}, a_{2}} \subset B_{a_{1}, a_{2}}$, we have that $D_{a_{1}, a_{2}} \leq C_{a_{1}, a_{2}}$. If $D_{a_{1}, a_{2}} \neq C_{a_{1}, a_{2}}$, then $D_{a_{1}, a_{2}}<C_{a_{1}, a_{2}}$. And thus there exists some $\left(u_{1}, u_{2}\right) \in B_{a_{1}, a_{2}}$ such that

$$
D_{a_{1}, a_{2}} \leq J\left[u_{1}, u_{2}\right]<C_{a_{1}, a_{2}} .
$$

It is clearly that $\left(u_{1}, u_{2}\right) \in B_{a_{1}, a_{2}} \backslash S_{a_{1}, a_{2}}$. Put $b_{\iota}:=\int_{\mathbb{R}^{N}} u_{\iota}^{2} d x, \iota=1,2$. Then $\left(u_{1}, u_{2}\right) \in S_{b_{1}, b_{2}}$. Furthermore, It is easy to see that $a_{\iota}-b_{\iota} \geq 0, \iota=1,2$ and $\left(a_{1}-b_{1}, a_{2}-b_{2}\right) \neq(0,0)$. Then it follows that

$$
C_{b_{1}, b_{2}}=\inf _{\left(v_{1}, v_{2}\right) \in S_{b_{1}, b_{2}}} J\left[v_{1}, v_{2}\right] \leq J\left[u_{1}, u_{2}\right]<C_{a_{1}, a_{2}},
$$

a contradiction to Corollary 3.3.
For the convenience to estimate the Lagrange multipliers, we prefer to give the following result directly without proof, which essentially own to Frank H. Clarke(see [14, Theorem 1]).

Proposition 3.7. If ( $u_{1}, u_{2}$ ) attains $D_{a_{1}, a_{2}}$, then there exists $\lambda_{\iota} \geq 0, \iota=1,2$ such that

$$
J^{\prime}\left[u_{1}, u_{2}\right]+\lambda_{1}\left(u_{1}, 0\right)+\lambda_{2}\left(0, u_{2}\right)=0 \text { in } \mathcal{H}^{*} .
$$

That is, $\left(u_{1}, u_{2}\right)$ solves equation (1.10) with $\lambda_{1}, \lambda_{2} \geq 0$. Furthermore, we have

$$
\lambda_{\iota}\left(\left\|u_{\iota}\right\|_{2}^{2}-a_{\iota}\right)=0, \quad \iota=1,2 .
$$

## 4. Radial potential case and Proof of Theorem 1.3

In this Section, we focus on the radial case and prove Theorem 1.3 via the rearrangement argument. Some properties relate to the rearrangement are provided first.

Remark 4.1. It is easy to see that for any fixed $s \in \mathbb{R}_{+}, \partial_{1} G(s, t)$ is increasing by $t \in \mathbb{R}_{+}$. Similarly, for any fixed $t \in \mathbb{R}_{+}, \partial_{2} G(s, t)$ is increasing by $s \in \mathbb{R}_{+}$under the assumption (1.11).

Lemma 4.2. Assume that $G(s, t)$ is given by (1.11). Let $u_{1}, u_{2}$ be nonnegative functions on $\mathbb{R}^{N}$, vanishing at infinity and let $u_{1}^{*}$ and $u_{2}^{*}$ be their symmetric-decreasing rearrangements. Then

$$
\begin{equation*}
\int_{\mathbb{R}^{N}} G\left(u_{1}^{*}, u_{2}^{*}\right) d x \geq \int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x \tag{4.1}
\end{equation*}
$$

Proof. Noting that $G(0,0)=0$, we have

$$
\begin{aligned}
& \int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x=\int_{\mathbb{R}^{N}}\left[G\left(u_{1}, u_{2}\right)-G\left(0, u_{2}\right)+G\left(0, u_{2}\right)-G(0,0)\right] d x \\
= & \int_{\mathbb{R}^{N}} d x \int_{0}^{u_{1}(x)} \partial_{1} G\left(s, u_{2}(x)\right) d s+\int_{\mathbb{R}^{N}} d x \int_{0}^{u_{2}(x)} \partial_{2} G(0, t) d t \\
= & \int_{\mathbb{R}^{N}} d x \int_{0}^{\infty} \partial_{1} G\left(s, u_{2}(x)\right) \chi_{\left\{x: u_{1}(x)>s\right\}}(x) d s \\
& +\int_{\mathbb{R}^{N}} d x \int_{0}^{\infty} \partial_{2} G(0, t) \chi_{\left\{x: u_{2}(x)>t\right\}}(x) d t \\
= & \int_{\mathbb{R}^{N}} d x \int_{0}^{\infty} \int_{0}^{\infty} \chi_{\left\{x: \partial_{1} G\left(s, u_{2}(x)\right)>r\right\}}(x) \chi_{\left\{x: u_{1}(x)>s\right\}}(x) d r d s
\end{aligned}
$$

$$
\begin{aligned}
& +\int_{\mathbb{R}^{N}} d x \int_{0}^{\infty} \partial_{2} G(0, t) \chi_{\left\{x: u_{2}(x)>t\right\}}(x) d t \\
= & \int_{0}^{\infty} \int_{0}^{\infty}\left|\left\{x: \partial_{1} G\left(s, u_{2}(x)\right)>r\right\} \cap\left\{x: u_{1}(x)>s\right\}\right| d r d s \\
& +\int_{0}^{\infty} \partial_{2} G(0, t)\left|\left\{x: u_{2}(x)>t\right\}\right| d t .
\end{aligned}
$$

For $r, s \in \mathbb{R}_{+}$, we put

t(r, s):= \begin{cases}\sup \left\{t: \partial_{1} G(s, t) \leq r\right\}, & \text { if }\left\{t: \partial_{1} G(s, t) \leq r\right\} \neq \emptyset  \tag{4.2}\\ -\infty & \text { if }\left\{t: \partial_{1} G(s, t) \leq r\right\}=\emptyset\end{cases}
$$

Then by Remark 4.1, we have that $\partial_{1} G\left(s, u_{2}(x)\right)>r$ if and only if $u_{2}(x)>t(r, s)$. So

\left|\left\{x: \partial_{1} G\left(s, u_{2}(x)\right)>r\right\} \cap\left\{x: u_{1}(x)>s\right\}\right|=\left|\left\{x: u_{2}(x)>t(r, s)\right\} \cap\left\{x: u_{1}(x)>s\right\}\right|, \tag{4.3}
\end{equation*}
$$

and thus

\int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x= & \int_{0}^{\infty} \int_{0}^{\infty}\left|\left\{x: u_{2}(x)>t(r, s)\right\} \cap\left\{x: u_{1}(x)>s\right\}\right| d r d s \\
& +\int_{0}^{\infty} \partial_{2} G(0, t)\left|\left\{x: u_{2}(x)>t\right\}\right| d t \tag{4.4}
\end{align*}
$$

Similarly, we have

\int_{\mathbb{R}^{N}} G\left(u_{1}^{*}, u_{2}^{*}\right) d x= & \int_{0}^{\infty} \int_{0}^{\infty}\left|\left\{x: u_{2}^{*}(x)>t(r, s)\right\} \cap\left\{x: u_{1}^{*}(x)>s\right\}\right| d r d s \\
& +\int_{0}^{\infty} \partial_{2} G(0, t)\left|\left\{x: u_{2}^{*}(x)>t\right\}\right| d t \tag{4.5}
\end{align*}
$$

Recalling the definition of symmetric-decreasing rearrangement, we have that $\forall t, s \geq 0$,

\left\{\begin{array}{l}
\left|\left\{x: u_{2}^{*}(x)>t\right\}\right|=\left|\left\{x: u_{2}(x)>t\right\}\right| \\
\left|\left\{x: u_{1}^{*}(x)>s\right\}\right|=\left|\left\{x: u_{1}(x)>s\right\}\right| \\
\left|\left\{x: u_{2}^{*}(x)>t(r, s)\right\}\right|=\left|\left\{x: u_{2}(x)>t(r, s)\right\}\right|
\end{array}\right.
$$

and thus

$$
\begin{aligned}
& \left|\left\{x: u_{2}^{*}(x)>t(r, s)\right\} \cap\left\{x: u_{1}^{*}(x)>s\right\}\right| \\
= & \min \left\{\left|\left\{x: u_{2}^{*}(x)>t(r, s)\right\}\right|,\left|\left\{x: u_{1}^{*}(x)>s\right\}\right|\right\} \\
= & \min \left\{\left|\left\{x: u_{2}(x)>t(r, s)\right\}\right|,\left|\left\{x: u_{1}(x)>s\right\}\right|\right\} \\
\geq & \left|\left\{x: u_{2}(x)>t(r, s)\right\} \cap\left\{x: u_{1}(x)>s\right\}\right| .
\end{aligned}
$$

Hence, one can see that

\int_{\mathbb{R}^{N}} G\left(u_{1}^{*}, u_{2}^{*}\right) d x \geq \int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x .
$$

We note that under the assumption of (VH2), $\left|V_{\iota}(x)\right|, \iota=1,2$ are symmetric decreasing functions, i.e.,

Then by the simplest rearrangement inequality (see [25, Theorem 3.4]), we have that

\end{equation*}
$$

Define

\begin{equation*}
C_{a_{1}, a_{2}}^{r a d}:=\inf _{\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}^{r a d}} J\left[u_{1}, u_{2}\right] \tag{4.7}
\end{equation*}
$$

and

$$
\begin{equation*}
D_{a_{1}, a_{2}}^{r a d}:=\inf _{\left(u_{1}, u_{2}\right) \in B_{a_{1}, a_{2}}^{r a d}} J\left[u_{1}, u_{2}\right] \tag{4.8}
\end{equation*}
$$

where $S_{a_{1}, a_{2}}^{r a d}:=S_{a_{1}, a_{2}} \cap \mathcal{H}^{r a d}, D_{a_{1}, a_{2}}^{r a d}:=B_{a_{1}, a_{2}} \cap \mathcal{H}^{r a d}$. Then we have the following result.
Lemma 4.3. Under the assumptions (VH2) and (1.11), we have that

C_{a_{1}, a_{2}}=C_{a_{1}, a_{2}}^{r a d}=D_{a_{1}, a_{2}}=D_{a_{1}, a_{2}}^{r a d}, \forall a_{1}>0, a_{2}>0
$$

Proof. It is only need to prove $C_{a_{1}, a_{2}}=C_{a_{1}, a_{2}}^{\text {rad }}$ due to Lemma 3.6. It is trivial that $C_{a_{1}, a_{2}}^{r a d} \geq C_{a_{1}, a_{2}}$ since $S_{a_{1}, a_{2}}^{r a d} \subset S_{a_{1}, a_{2}}$. On the other hand, for any $\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}$, we have $\left(u_{1}^{*}, u_{2}^{*}\right) \in S_{a_{1}, a_{2}}^{r a d}$. Recalling the Pólya-Szegö inequality, we have

Under the assumption (VH2), by Lemma 4.2, combining with the formulas (4.6) and (4.9), we have that

C_{a_{1}, a_{2}}^{r a d} \leq J\left[u_{1}^{*}, u_{2}^{*}\right] & =\frac{1}{2} \sum_{\iota=1}^{2}\left(\left\|\nabla u_{\iota}^{*}\right\|_{2}^{2}-\left\|u_{\iota}^{*}\right\|_{V_{\iota}}^{2}\right)-\int_{\mathbb{R}^{N}} G\left(u_{1}^{*}, u_{2}^{*}\right) d x \\
& \leq \frac{1}{2} \sum_{\iota=1}^{2}\left(\left\|\nabla u_{\iota}\right\|_{2}^{2}-\left\|u_{\iota}\right\|_{V_{\iota}}^{2}\right)-\int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x \\
& =J\left[u_{1}, u_{2}\right]
\end{aligned}
$$

By the arbitrary of $\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}$, we obtain the opposite inequality $C_{a_{1}, a_{2}}^{r a d} \leq C_{a_{1}, a_{2}}$. Hence,

$$

Now we are ready to prove our Theorem 1.3: Under the assumptions, by Lemma 4.3 and Remark 2.5-(i), there exists $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\} \subset \mathcal{H}^{r a d}$ such that $\left\|u_{\iota, \vartheta}\right\|_{2}^{2}=a_{\iota}, \iota=1,2, \forall \vartheta \in \mathbb{N}$ and

J\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \rightarrow C_{a_{1}, a_{2}}=D_{a_{1}, a_{2}} \text { as } \vartheta \rightarrow \infty
$$

Up to a subsequence, we assume that $\left(u_{1, \vartheta}, u_{2, \vartheta}\right) \rightharpoonup\left(u_{1}, u_{2}\right)$ in $\mathcal{H}$ and

$$
\left(u_{1, \vartheta}, u_{2, \vartheta}\right) \rightarrow\left(u_{1}, u_{2}\right) \text { in } L_{l o c}^{2}\left(\mathbb{R}^{N}\right) \times L_{l o c}^{2}\left(\mathbb{R}^{N}\right),\left(u_{1, \vartheta}, u_{2, \vartheta}\right) \rightarrow\left(u_{1}, u_{2}\right) \text { a.e. in } \mathbb{R}^{N}
$$

By the Brézis-Lieb lemma [11], we have

$$
\begin{equation*}
\int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}, u_{2, \vartheta}\right) d x=\int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x+\int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}-u_{1}, u_{2, \vartheta}-u_{2}\right) d x+o(1) \tag{4.10}
\end{equation*}
$$

Noting that the embedding $H^{1, \text { rad }}\left(\mathbb{R}^{N}\right) \hookrightarrow \hookrightarrow L^{q}\left(\mathbb{R}^{N}\right)$ is compact for $2<q<2^{*}$, provided $N \geq 2$. In particular, if $N=1$, we can take $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}$ as non-increasing functions of $|x|$. That is,

$$
u_{\iota, \vartheta}(x)=u_{\iota, \vartheta}^{*}(x), \iota=1,2, \forall \vartheta \in \mathbb{N} .
$$

Then up to a subsequence, we can also have that $u_{\iota, \vartheta} \rightarrow u_{\iota}$ in $L^{q}(\mathbb{R}), \forall 2<q \leq \infty, \iota=1,2$ (see [33, Proposition 1.7.1]). Essentially, it is due to the fact that

u_{\iota, \vartheta}(x)=u_{\iota, \vartheta}(|x|) \leq C\left\|u_{\iota, \vartheta}\right\|_{2}|x|^{-\frac{1}{2}} \rightarrow 0

as $|x| \rightarrow \infty$, uniformly in $\vartheta \in \mathbb{N}$ and $\iota=1,2$. So by Lemma 2.1, we have that

\lim _{\vartheta \rightarrow \infty} \int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}-u_{1}, u_{2, \vartheta}-u_{2}\right) d x=0 . \tag{4.11}

It follows from (4.10) and (4.11) that

\lim _{\vartheta \rightarrow \infty} \int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}, u_{2, \vartheta}\right) d x=\int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x . \tag{4.12}
\end{equation*}
$$

On the other hand, by the weak lower semi-continuity of norm and $\lim _{|x| \rightarrow \infty} V_{\iota}(x)=0$, one can prove that

\int_{\mathbb{R}^{N}}\left|\nabla u_{\iota}\right|^{2}+V_{\iota}(x)\left|u_{\iota}\right|^{2} d x \leq \liminf _{\vartheta \rightarrow \infty} \int_{\mathbb{R}^{N}}\left|\nabla u_{\iota, \vartheta}\right|^{2}+V_{\iota}(x)\left|u_{\iota, \vartheta}\right|^{2} d x, \iota=1,2 . \tag{4.13}
\end{equation*}
$$

Hence, by (4.12) and (4.13), we have that

\begin{equation*}
J\left[u_{1}, u_{2}\right] \leq \lim _{\vartheta \rightarrow \infty} J\left[u_{1, \vartheta}, u_{2, \vartheta}\right]=C_{a_{1}, a_{2}}=D_{a_{1}, a_{2}} . \tag{4.14}
\end{equation*}
$$

It is clear that $\left(u_{1}, u_{2}\right) \in B_{a_{1}, a_{2}}$. Put $b_{\iota}=\left\|u_{\iota}\right\|_{2}^{2}, \iota=1,2$, then $\left(u_{1}, u_{2}\right) \in S_{b_{1}, b_{2}}$ with $b_{1} \leq a_{1}, b_{2} \leq a_{2}$, and thus

D_{a_{1}, a_{2}} \leq C_{b_{1}, b_{2}} \leq J\left[u_{1}, u_{2}\right] \leq C_{a_{1}, a_{2}} .
$$

If $\left(u_{1}, u_{2}\right) \in B_{a_{1}, a_{2}} \backslash S_{a_{1}, a_{2}}$, we have $a_{\iota}-b_{\iota} \geq 0, \iota=1,2$ and $\left(a_{1}-b_{1}, a_{2}-b_{2}\right) \neq(0,0)$, then by Corollary 3.3, we have that $C_{b_{1}, b_{2}}>C_{a_{1}, a_{2}}$, a contradiction. Hence, we have that $\left(u_{1}, u_{2}\right) \in S_{a_{1}, a_{2}}$ with $J\left[u_{1}, u_{2}\right]=C_{a_{1}, a_{2}}$. Finally by Proposition $3.7, \lambda_{\iota} \geq 0(\iota=1,2)$, and we finish the proof of Theorem 1.3.

Corollary 4.4. For any $\left(a_{1}, a_{2}\right) \in \mathbb{R}_{+}^{2}, E_{a_{1}, a_{2}}$ is attained.
Proof. By taking $V_{\iota}(x) \equiv 0, \iota=1,2$, then it follows Theorem 1.3 that $E_{a_{1}, a_{2}}$ is attained by some nonnegative symmetric decreasing function of $|x|$.

## 5. The sharp decay estimation of positive solution

In this section, we shall give the sharp decay estimation of the positive solution for the fixed frequency problem

$$
\begin{cases}-\Delta u_{1}+V_{1}(x) u_{1}+\lambda_{1} u_{1}=\partial_{1} G\left(u_{1}, u_{2}\right) & \text { in } \mathbb{R}^{N}  \tag{5.1}\\ -\Delta u_{2}+V_{2}(x) u_{2}+\lambda_{2} u_{2}=\partial_{2} G\left(u_{1}, u_{2}\right) & \text { in } \mathbb{R}^{N},\end{cases}
$$

where $G(s, t)$ is given by (1.11) with the parameters satisfying (1.13) and $V_{1}, V_{2}$ are given potentials.

The following Lemma is due to Ikoma and Miyamoto [22, Lemma 3.3], which is a variant of [3, Proposition 1.2]

Lemma 5.1. (cf. [22]) Let $0 \leq f(x), g(x)$ satisfy $f, g \in C\left(\mathbb{R}^{N} \backslash\{0\}\right) \cap L^{1}\left(\mathbb{R}^{N}\right)$ and

$$
\lim _{|x| \rightarrow \infty}(1+|x|)^{\alpha} e^{\beta|x|} g(x)=c \in[0, \infty), f(x) \leq C e^{-\gamma|x|} \text { for each }|x| \geq 1
$$

for some $\alpha \geq 0,0 \leq \beta<\gamma$. Then
$\lim _{r \rightarrow \infty}(1+r)^{\alpha} e^{\beta r} \int_{\mathbb{R}^{N}} g(r \omega-y) f(y) d y=c \int_{\mathbb{R}^{N}} f(y) e^{\beta \omega \cdot y} d y$ unifromly with respect to $\omega \in \mathcal{S}^{N-1}$.
Corollary 5.2. Let $\lambda>0$ and $G_{\lambda}$ be the Green function of $-\Delta+\lambda$ in $\mathbb{R}^{N}$. Then for any $0<\nu<\lambda$ and $t>0$,

$$
\begin{equation*}
\lim _{r \rightarrow \infty}(1+r)^{t} e^{\nu r} \int_{\mathbb{R}^{N}} G_{\lambda}(r \omega-y)(1+|y|)^{-t} e^{-\nu|y|} d y=\int_{\mathbb{R}^{N}} G_{\lambda}(y) e^{\nu \omega \cdot y} d y>0 \tag{5.2}
\end{equation*}
$$

uniformly with respect to $\omega \in \mathcal{S}^{N-1}$.
Proof. For $\eta=\frac{\lambda-\nu}{2}>0$, we have $\nu+\eta=\frac{\lambda+\nu}{2}<\lambda$. By comparison principle, one can find some $C>0$ such that

$$
G_{\lambda}(x) \leq C e^{-(\nu+\eta)|x|} \text { for each }|x| \geq 1
$$

So we can put $g(x)=(1+|x|)^{-t} e^{-\nu|x|}, f(x)=G_{\lambda}(x)$. And then apply Lemma 5.1 with $\alpha=t, \beta=\nu$, one can see that (5.2) holds uniformly with respect to $\omega \in \mathcal{S}^{N-1}$. Here we use the property of convolution $[f \star g](r \omega)=[g \star f](r \omega)$ and note that $c=1$ in this application.

Lemma 5.3. Let $G(s, t)$ be given by (1.11) with the parameters satisfying (1.13). We simply write $\left(r_{1,1}, r_{2,1}\right)$ by $\left(r_{1}, r_{2}\right)$. Then there exists some $C>0$ such that

$$
\left\{\begin{array}{l}
\partial_{1} G(s, t) \geq C\left(s^{p_{1}-1}+s^{r_{1}-1} t^{r_{2}}\right)  \tag{5.3}\\
\partial_{2} G(s, t) \geq C\left(t^{q_{1}-1}+s^{r_{1}} t^{r_{2}-1}\right)
\end{array} \quad \text { for any }(s, t) \in \mathbb{R}_{+}^{2}\right.
$$

Furthermore, for any $M>0$, there exists $C_{M}>0$ such that

$$
\left\{\begin{array}{l}
\partial_{1} G(s, t) \leq C_{M}\left(s^{p_{1}-1}+s^{r_{1}-1}(s+t)^{r_{2}}\right)  \tag{5.4}\\
\partial_{2} G(s, t) \leq C_{M}\left(t^{q_{1}-1}+t^{r_{2}-1}(s+t)^{r_{1}}\right)
\end{array} \quad \text { for }(s, t) \in[0, M] \times[0, M]\right.
$$

Proof. It is trivial.
Basing on (5.3) and (5.4) with $p_{1}, q_{1}>2, r_{1}, r_{2}>1$, we can obtain the sharp decay estimation of the positive solution for the fixed frequency problem (5.1). Precisely, we have the following result.

Proposition 5.4. Suppose $G(s, t)$ satisfies (5.3) and (5.4) with $p_{1}, q_{1}>2, r_{1}, r_{2}>1$. Assume $V_{1}(x), V_{2}(x) \leq 0$ with $\lim _{|x| \rightarrow \infty} V_{\iota}(x)=0, \iota=1,2$. Let $\left(u_{1}, u_{2}\right) \in \mathcal{H}$ be a nonnegative solution of (5.1) with $\lambda_{1}>0, \lambda_{2}>0$, Then we have the following sharp decay estimations.
(i) Assume $u_{1} \not \equiv 0$. Put

$$
\bar{\lambda}_{1}:=\min \left\{\lambda_{1}, \frac{r_{2}^{2}}{\left(2-r_{1}\right)_{+}^{2}} \lambda_{2}\right\} .
$$

Then for any $0<\nu_{2}<\bar{\lambda}_{1}<\nu_{1}$, there exists $C_{\nu_{2}} \geq C_{\nu_{1}}>0$ such that

$$
\begin{equation*}
C_{\nu_{1}} e^{-\sqrt{\nu_{1}}|x|} \leq u_{1}(x) \leq C_{\nu_{2}} e^{-\sqrt{\nu_{2}}|x|} \text { in } \mathbb{R}^{N} \tag{5.5}
\end{equation*}
$$

In particular, if $\bar{\lambda}_{1}=\lambda_{1}$, the lower bound can be improved as that there exists some $c_{1}>0$ such that

$$
\begin{equation*}
c_{1}(1+|x|)^{-\frac{N-1}{2}} e^{-\sqrt{\lambda_{1}}|x|} \leq u_{1}(x) \text { in } \mathbb{R}^{N} \text {. } \tag{5.6}
\end{equation*}
$$

(ii) Assume $u_{2} \not \equiv 0$. Put

$$
\bar{\lambda}_{2}:=\min \left\{\lambda_{2}, \frac{r_{1}^{2}}{\left(2-r_{2}\right)_{+}^{2}} \lambda_{1}\right\} .
$$

Then for any $0<\nu_{2}<\bar{\lambda}_{2}<\nu_{1}$, there exists $C_{\nu_{2}} \geq C_{\nu_{1}}>0$ such that

$$
\begin{equation*}
C_{\nu_{1}} e^{-\sqrt{\nu_{1}}|x|} \leq u_{2}(x) \leq C_{\nu_{2}} e^{-\sqrt{\nu_{2}}|x|} \text { in } \mathbb{R}^{N} . \tag{5.7}
\end{equation*}
$$

In particular, if $\bar{\lambda}_{2}=\lambda_{2}$, the lower bound can be improved as that there exists some $c_{2}>0$ such that

$$
\begin{equation*}
c_{2}(1+|x|)^{-\frac{N-1}{2}} e^{-\sqrt{\lambda_{2}}|x|} \leq u_{2}(x) \text { in } \mathbb{R}^{N} . \tag{5.8}
\end{equation*}
$$

The proof of this proposition is long but necessary. In order to avoid readers getting lost in this complex proof detail, we tend to give its proof in the Appendix A.

Corollary 5.5. Suppose $G(s, t)$ satisfying (5.3) and (5.4) with $p_{1}, q_{1}>2, r_{1}, r_{2}>1$. Assume $V_{1}(x), V_{2}(x) \leq 0$ with $\lim _{|x| \rightarrow \infty} V_{\iota}(x)=0, \iota=1,2$. Let $0<\lambda_{1} \leq \lambda_{2}$. Suppose that $\left(u_{1}, u_{2}\right)$ is a nonnegative nontrivial solution to (5.1) and $\left(\omega_{1}, \omega_{2}\right)$ is a nonnegative nontrivial solution to

$$
\begin{cases}-\Delta \omega_{1}+\lambda_{1} \omega_{1}=\partial_{1} G\left(\omega_{1}, \omega_{2}\right) & \text { in } \mathbb{R}^{N},  \tag{5.9}\\ -\Delta \omega_{2}+\lambda_{2} \omega_{2}=\partial_{2} G\left(\omega_{1}, \omega_{2}\right) & \text { in } \mathbb{R}^{N} .\end{cases}
$$

Define

$$
\begin{equation*}
\omega_{\iota, R}(x):=\omega_{\iota}\left(x-R \mathbf{e}_{\mathbf{1}}\right), \iota=1,2 \tag{5.10}
\end{equation*}
$$

We have the following conclusions:
(i) If $u_{1} \neq 0$ and $\omega_{1} \neq 0$, then for any $\lambda \in\left(0, \lambda_{1}\right)$, we can find some $c>0$ independent of $\lambda$ and another $C_{\lambda}>0$ such that

\begin{equation*}
c(1+R)^{-\frac{N-1}{2}} e^{-\sqrt{\lambda_{1}} R} \leq \int_{\mathbb{R}^{N}} u_{1} \omega_{1, R} d x \leq C_{\lambda} e^{-\sqrt{\lambda} R} . \tag{5.11}
\end{equation*}
$$

Furthermore, if $\lambda_{1}=\lambda_{2}$, and $u_{2} \neq 0$ and $\omega_{2} \neq 0$, then (5.11) also holds for $\int_{\mathbb{R}^{N}} u_{2} \omega_{2, R} d x$. And if $\lambda_{1}<\lambda_{2}$, then we can find some $\theta_{1}>1$ and $C>0$ such that

\int_{\mathbb{R}^{N}} u_{2} \omega_{2, R} d x \leq C\left(\int_{\mathbb{R}^{N}} u_{1} \omega_{1, R} d x\right)^{\theta_{1}} . \tag{5.12}

(ii) Suppose $\bar{\lambda}_{2}=\lambda_{2}$. If $u_{2} \neq 0$ and $\omega_{2} \neq 0$, then for any $\lambda \in\left(0, \lambda_{2}\right)$, we can find some $c>0$ independent of $\lambda$ and another $C_{\lambda}>0$ such that

(iii) Suppose $\bar{\lambda}_{2}<\lambda_{2}$. If $u_{2} \neq 0$ and $\omega_{2} \neq 0$, then for any $0<\nu_{1}<\bar{\lambda}_{2}<\nu_{2}$, there exists $C_{\nu_{1}}, C_{\nu_{2}}>0$ such that

C_{\nu_{2}} e^{-\sqrt{\nu_{2}} R} \leq \int_{\mathbb{R}^{N}} u_{2} \omega_{2, R} d x \leq C_{\nu_{1}} e^{-\sqrt{\nu_{1}} R} . \tag{5.14}
\end{equation*}

(iv) If $u_{1} \neq 0, u_{2} \neq 0, \omega_{1} \neq 0$ and $\omega_{2} \neq 0$, then for any $\gamma_{1} \geq r_{1}, \gamma_{2} \geq r_{2}$ with $\eta \in\left(0, \min \left\{r_{1}-1, r_{2}-1\right\}\right)$, there exists some $\theta=\theta_{\gamma_{1}, \gamma_{2}, \eta} \in(1,2)$ such that

\left\{\begin{array}{l}
\int_{\mathbb{R}^{N}} u_{1}^{1+\eta} \omega_{1, R}^{\gamma_{1}-1-\eta} \omega_{2, R}^{\gamma_{2}}=o\left(\left(\int_{\mathbb{R}^{N}} u_{1} \omega_{1, R} d x\right)^{\theta}\right),  \tag{5.15}\\
\int_{\mathbb{R}^{N}} u_{2}^{1+\eta} \omega_{1, R}^{\gamma_{1}} \omega_{2, R}^{\gamma_{2}-1-\eta}=o\left(\left(\int_{\mathbb{R}^{N}} u_{1} \omega_{1, R} d x\right)^{\theta}\right) .
\end{array}\right.
$$

Proof. (i) When $\lambda_{1} \leq \lambda_{2}$, by Proposition 5.4, we see that $\bar{\lambda}_{1}=\lambda_{1}$. And then for any $\lambda \in\left(0, \lambda_{1}\right)$, we have

Then by Lemma 5.1, we have that

&=(1+R)^{\frac{N-1}{2}} e^{\sqrt{\lambda_{1}} R} \int_{\mathbb{R}^{N}} u_{1}\left(x+R \mathbf{e}_{\mathbf{1}}\right) \omega_{1}(x) d x \\
& \geq c^{2}(1+R)^{\frac{N-1}{2}} e^{\sqrt{\lambda_{1}} R} \\
& \times \int_{\mathbb{R}^{N}}\left(1+\left|x+R \mathbf{e}_{\mathbf{1}}\right|\right)^{-\frac{N-1}{2}} e^{-\sqrt{\lambda_{1}}\left|x+R \mathbf{e}_{1}\right|} e^{-\sqrt{\lambda_{1}+1}|x|} d x \\
& \rightarrow c^{2} \int_{\mathbb{R}^{N}} e^{-\sqrt{\lambda_{1}+1}|x|} e^{\sqrt{\lambda_{1}} \mathbf{e}_{1} \cdot y} d y>0 .
\end{aligned}
$$

Hence, the assertion of (5.11) holds.
Finally, if $\lambda_{1}<\lambda_{2}$, we can take $\varepsilon>0$ small such that $\lambda_{1}+3 \varepsilon<\bar{\lambda}_{2}$. Then, we have that

0 \leq u_{2}(x) \leq C e^{-\sqrt{\lambda_{1}+2 \varepsilon}|x|}, \omega_{2}(x) \leq C e^{-\sqrt{\lambda_{1}+3 \varepsilon}|x|} .
$$

Hence, Lemma 5.1 yields $\sigma_{2, R}=o\left(e^{-\sqrt{\lambda_{1}+\varepsilon} R}\right)$ as $R \rightarrow+\infty$. Thus, we can find some $\theta_{1}>1$ and $C>0$ such that (5.12) holds.
(ii) When $\bar{\lambda}_{2}=\lambda_{2}$, by Proposition $5.4,(5.13)$ can be proved as (5.11).
(iii) Suppose $\bar{\lambda}_{2}<\lambda_{2}$. Then for any $0<\nu_{1}<\bar{\lambda}_{2}<\nu_{2}$, we can find some $C, c>0$ such that

\lim _{|x| \rightarrow \infty} u_{2}(x) e^{\sqrt{\nu_{1}}|x|}=0, \omega_{2}(x) \leq C e^{-\sqrt{\frac{\nu_{1}+\bar{\lambda}_{2}}{2}}|x|} \text { in } \mathbb{R}^{N},
$$

and

$$
c e^{-\sqrt{\nu_{2}}|x|} \leq u_{2}(x), c e^{-\sqrt{\nu_{2}+1}|x|} \leq \omega_{2}(x) .
$$

We have that

$$
\lim _{R \rightarrow+\infty} e^{\sqrt{\nu_{1}} R} \int_{\mathbb{R}^{N}} u_{2} \omega_{2, R} d x=0
$$

and

$$
\begin{aligned}
e^{\sqrt{\nu_{2}} R} \int_{\mathbb{R}^{N}} u_{2} \omega_{2, R} d x & \geq c^{2} e^{\sqrt{\nu_{2}} R} \int_{\mathbb{R}^{N}} e^{-\sqrt{\nu_{2}}|x|} e^{-\sqrt{\nu_{2}+1}\left|x-R \mathbf{e}_{1}\right|} d x \\
& =c^{2} e^{\sqrt{\nu_{2}} R} \int_{\mathbb{R}^{N}} e^{-\sqrt{\nu_{2}}\left|x+R \mathbf{e}_{1}\right|} e^{-\sqrt{\nu_{2}+1}|x|} d x \\
& \rightarrow c^{2} \int_{\mathbb{R}^{N}} e^{-\sqrt{\nu_{2}+1}|x|} e^{-\sqrt{\nu_{2}} \mathbf{e}_{\mathbf{1}} \cdot x} d x>0 \text { as } R \rightarrow+\infty .
\end{aligned}
$$

Hence, there exists $C_{\nu_{1}}>0, C_{\nu_{2}}>0$ such that (5.14) holds.
(iv) Thanks to $1+\eta>1, \gamma_{1}-1-\eta+r_{2}>r_{2}>1$ and Proposition 5.4, we may find an $\eta_{1}>0$ such that

Therefore, exploiting Lemma 5.1, combining with the conclusion (i) above (see formula (5.11)), we can find some $\tilde{\theta}_{1} \in(1,2)$ such that

Similarly, we may find some $\tilde{\theta}_{2} \in(1,2)$ such that

Then we can take $\theta:=\min \left\{\tilde{\theta}_{1}, \tilde{\theta}_{2}\right\}$.
Remark 5.6. We emphasize that $V_{\iota}(x) \equiv 0$ is within our consideration in Proposition 5.4.

## 6. The strict binding inequality

In this Section, we shall prove the strict binding inequality associated with the functionals $J$ and $I$ basing on sharp decay estimations of the positive solutions for the fixed frequency problem (5.1) obtained in Section 5.

Lemma 6.1. (cf. [3, Lemma 2.1]) If $p>2$, there exists some $C_{p}>0$ such that for any $a, b \geq 0$,

$$
\begin{equation*}
(a+b)^{p} \geq a^{p}+b^{p}+p a^{p-1} b+p a b^{p-1}-C_{p} a^{\frac{p}{2}} b^{\frac{p}{2}} . \tag{6.1}
\end{equation*}
$$

In [22], Ikoma and Miyamoto gave the interaction estimation for the couples terms $\left(a_{1}+b_{1}\right)^{\gamma_{1}}\left(a_{2}+b_{2}\right)^{\gamma_{2}}$ with $\gamma_{1}=\gamma_{2}>1$. In present paper, we shall give the interaction estimation for the general couples terms $\left(a_{1}+b_{1}\right)^{\gamma_{1}}\left(a_{2}+b_{2}\right)^{\gamma_{2}}$, that $\gamma_{1} \neq \gamma_{2}$ is allowed.

Lemma 6.2. Let $\gamma_{1}>1, \gamma_{2}>1$. For any $0<\eta<\min \left\{\gamma_{1}, \gamma_{2}\right\}-1$, There exists some $C_{\gamma_{1}, \gamma_{2}, \eta}>0$ such that for any $(x, y) \in \mathbb{R}_{+}^{2}$,

$$
\begin{align*}
(1+x)^{\gamma_{1}}(1+y)^{\gamma_{2}} \geq & 1+x^{\gamma_{1}} y^{\gamma_{2}}+\gamma_{1} x+\gamma_{2} y \\
& -C_{\gamma_{1}, \gamma_{2}, \eta}\left(x^{\gamma_{1}-1-\eta} y^{\gamma_{2}}+x^{\gamma_{1}} y^{\gamma_{2}-1-\eta}\right) \tag{6.2}
\end{align*}
$$

Proof. Observing that for $\gamma>1$, one can see that

$$
\begin{cases}x^{\gamma-1}<\gamma, & \forall 0<x<\gamma^{\frac{1}{\gamma-1}}, \\ x^{\gamma-1}>\gamma, & \forall x>\gamma^{\frac{1}{\gamma-1}} .\end{cases}
$$

Then for any $(x, y) \in\left[0, \gamma_{1}^{\frac{1}{\gamma_{1}-1}}\right] \times\left[0, \gamma_{2}^{\frac{1}{\gamma_{2}-1}}\right]$, by Bernoulli inequality,

(1+x)^{\gamma_{1}}(1+y)^{\gamma_{2}} & \geq\left(1+\gamma_{1} x\right)\left(1+\gamma_{2} y\right) \\
& =1+\gamma_{1} x+\gamma_{2} y+\left(\gamma_{1} x\right) \cdot\left(\gamma_{2} y\right) \\
& \geq 1+\gamma_{1} x+\gamma_{2} y+x^{\gamma_{1}} y^{\gamma_{2}}
\end{aligned}
$$

the assertion (6.2) holds.
For $(x, y) \in\left(\gamma_{1}^{\frac{1}{\gamma_{1}-1}}, \infty\right) \times\left(\gamma_{2}^{\frac{1}{\gamma_{2}-1}}, \infty\right)$, we can take $C=C_{\gamma_{1}, \gamma_{2}, \eta}$ large enough such that

$$
\frac{2}{C}<\min \left\{\gamma_{1}^{\frac{\gamma_{1}-1-\eta}{\gamma_{1}-1}}, \gamma_{2}^{\frac{\gamma_{2}-1-\eta}{\gamma_{2}-1}}\right\}
$$

And then

$$
C\left(x^{\gamma_{1}-1-\eta} y^{\gamma_{2}}+x^{\gamma_{1}} y^{\gamma_{2}-1-\eta}\right) \geq 2 y^{\gamma_{2}}+2 x^{\gamma_{1}}>1+\gamma_{1} x+\gamma_{2} y .
$$

Since $(1+x)^{\gamma_{1}}(1+y)^{\gamma_{2}}>x^{\gamma_{1}} y^{\gamma_{2}}$, we have that

$$
(1+x)^{\gamma_{1}}(1+y)^{\gamma_{2}}>1+\gamma_{1} x+\gamma_{2} y+x^{\gamma_{1}} y^{\gamma_{2}}-C\left(x^{\gamma_{1}-1-\eta} y^{\gamma_{2}}+x^{\gamma_{1}} y^{\gamma_{2}-1-\eta}\right) .
$$

Hence the assertion (6.2) also holds.
For $y \in\left(\gamma_{2}^{\frac{1}{\gamma_{2}-1}},+\infty\right)$, by the mean value theorem, there exists some $z \in[y, y+1]$ such that

$$
(1+y)^{\gamma_{2}}-y^{\gamma_{2}}=\gamma_{2} z^{\gamma_{2}-1} \geq \gamma_{2} y^{\gamma_{2}-1}>\gamma_{2}^{2}>1
$$

which implies that $(1+y)^{\gamma_{2}}>1+y^{\gamma_{2}}$. So if $(x, y) \in\left[0, \gamma_{1}^{\frac{1}{\gamma_{1}-1}}\right] \times\left(\gamma_{2}^{\frac{1}{\gamma_{2}-1}},+\infty\right)$, we have

\begin{aligned}
(1+x)^{\gamma_{1}}(1+y)^{\gamma_{2}} & >\left(1+\gamma_{1} x\right) \cdot\left(1+y^{\gamma_{2}}\right) \\
& =1+\gamma_{1} x+\gamma_{1} x y^{\gamma_{2}}+y^{\gamma_{2}} \\
& \geq 1+\gamma_{1} x+x^{\gamma_{1}} y^{\gamma_{2}}+\gamma_{2} y .
\end{aligned}
$$

Hence, the assertion (6.2) also holds. The case of $(x, y) \in\left(\gamma_{1}^{\frac{1}{\gamma_{1}-1}},+\infty\right) \times\left[0, \gamma_{2}^{\frac{1}{\gamma_{2}-1}}\right]$ can be proved similarly.

Corollary 6.3. Let $\gamma_{1}>1, \gamma_{2}>1$. For any $0<\eta<\min \left\{\gamma_{1}, \gamma_{2}\right\}-1$, There exists some $C_{\gamma_{1}, \gamma_{2}, \eta}>0$ such that for any $a_{\iota}, b_{\iota} \geq 0, \iota=1,2$,

$$
\begin{align*}
\left(a_{1}+b_{1}\right)^{\gamma_{1}}\left(a_{2}+b_{2}\right)^{\gamma_{2}} \geq & a_{1}^{\gamma_{1}} a_{2}^{\gamma_{2}}+\gamma_{1} a_{1}^{\gamma_{1}-1} a_{2}^{\gamma_{2}} b_{1}+\gamma_{2} a_{1}^{\gamma_{1}} a_{2}^{\gamma_{2}-1} b_{2}+b_{1}^{\gamma_{1}} b_{2}^{\gamma_{2}} \\
& -C_{\gamma_{1}, \gamma_{2}, \eta}\left\{a_{1}^{1+\eta} b_{1}^{\gamma_{1}-1-\eta} b_{2}^{\gamma_{2}}+a_{2}^{1+\eta} b_{2}^{\gamma_{2}-1-\eta} b_{1}^{\gamma_{1}}\right\} . \tag{6.3}
\end{align*}
$$

Furthermore, if $a_{1}=0$ or $b_{1}=0$, we have that

$$
\begin{equation*}
\left(a_{1}+b_{1}\right)^{\gamma_{1}}\left(a_{2}+b_{2}\right)^{\gamma_{2}} \geq a_{1}^{\gamma_{1}} a_{2}^{\gamma_{2}}+\gamma_{1} a_{1}^{\gamma_{1}-1} a_{2}^{\gamma_{2}} b_{1}+\gamma_{2} a_{1}^{\gamma_{1}} a_{2}^{\gamma_{2}-1} b_{2}+b_{1}^{\gamma_{1}} b_{2}^{\gamma_{2}} . \tag{6.4}
\end{equation*}
$$

Proof. If $\left(a_{1}+b_{1}\right)=0$ or $\left(a_{2}+b_{2}\right)=0$, it is trivial. So we only need to consider the case of $\left(a_{1}+b_{1}\right)>0$ and $\left(a_{2}+b_{2}\right)>0$. Therefore, without loss of generality, we can assume that $a_{1}>0$ and $a_{2}>0$, since $a_{\iota}, b_{\iota} \geq 0, \iota=1,2$. By putting $x=\frac{b_{1}}{a_{1}}, y=\frac{b_{2}}{a_{2}}$ in (6.2), we can get the inequalities (6.3).

In particular, if $b_{1}=0$, then

and thus (6.4) holds. If $a_{1}=0$, by $b_{1}^{\gamma_{1}}\left(a_{2}+b_{2}\right)^{\gamma_{2}} \geq b_{1}^{\gamma_{1}} b_{2}^{\gamma_{2}}$, (6.4) also holds.
Put $a_{\iota}:=\left\|u_{\iota}\right\|_{2}^{2}, \quad b_{\iota}:=\left\|\omega_{\iota}\right\|_{2}^{2}$. Define

\omega_{\iota, R} & :=\omega_{\iota}\left(\cdot-R \mathbf{e}_{\mathbf{1}}\right), \quad \iota=1,2  \tag{6.5}\\
\sigma_{\iota, R} & :=\int_{\mathbb{R}^{N}} u_{\iota} \omega_{\iota, R} d x, \quad \iota=1,2 \tag{6.6}
\end{align*}

We remark that if $u_{\iota} \equiv 0$ or $\omega_{\iota} \equiv 0$, we have that $\sigma_{\iota, R} \equiv 0, \forall R \in \mathbb{R}_{+}$. If $u_{\iota} \not \equiv 0$ and $\omega_{\iota} \not \equiv 0$, by the strong maximum principle, it holds that $u_{\iota}(x)>0, \omega_{\iota}(x)>0$ in $\mathbb{R}^{N}$. And thus

\sigma_{\iota, R}>0 \text { and } \sigma_{\iota, R} \rightarrow 0 \text { as } R \rightarrow \infty . \tag{6.7}
\end{equation*}
$$

Let

$$
\begin{equation*}
\tau_{\iota, R}^{2}:=\frac{a_{\iota}+b_{\iota}}{a_{\iota}+b_{\iota}+2 \sigma_{\iota, R}}=1-\frac{2}{a_{\iota}+b_{\iota}} \sigma_{\iota, R}+O\left(\sigma_{\iota, R}^{2}\right) \tag{6.8}
\end{equation*}
$$

and $\tau_{\iota, R}=1$ if $\sigma_{\iota, R}=0$. Then one can see that

$$
\begin{equation*}
\tau_{\iota, R}=1-\frac{1}{a_{\iota}+b_{\iota}} \sigma_{\iota, R}+O\left(\sigma_{\iota, R}^{2}\right) \tag{6.9}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\|\tau_{\iota, R}\left(u_{\iota}+\omega_{\iota, R}\right)\right\|_{2}^{2}=a_{\iota}+b_{\iota}, \quad \iota=1,2 \tag{6.10}
\end{equation*}
$$

Lemma 6.4. Suppose that ( $V H 1$ ) holds and $G(s, t)$ is given by (1.11) with the parameters satisfying (1.13). Let $0<\lambda_{1} \leq \lambda_{2}$. Assume that $\left(u_{1}, u_{2}\right) \neq(0,0)$ is a nonnegative solution to (5.1) and $\left(\omega_{1}, \omega_{2}\right) \neq(0,0)$ is a nonnegative solution to (5.9). We have the following interaction estimation.
(i) For $i=1,2, \cdots, \ell$, there exists some $\theta\left(p_{i}\right) \in(1,2)$ such that

& -\frac{\mu_{i}}{p_{i}} \tau_{1, R}^{p_{i}} \int_{\mathbb{R}^{N}}\left(u_{1}+\omega_{1, R}\right)^{p_{i}} d x \\
\leq & -\frac{\mu_{i}}{p_{i}}\left[\int_{\mathbb{R}^{N}} u_{1}^{p_{i}}+\omega_{1, R}^{p_{i}} d x\right]-\mu_{i} \int_{\mathbb{R}^{N}}\left[u_{1}^{p_{i}-1} \omega_{1, R}+u_{1} \omega_{1, R}^{p_{i}-1}\right] d x \\
& +\frac{\mu_{i} \sigma_{1, R}}{a_{1}+b_{1}}\left[\int_{\mathbb{R}^{N}} u_{1}^{p_{i}}+\omega_{1, R}^{p_{i}} d x\right]+o\left(\sigma_{1, R}^{\theta\left(p_{i}\right)}\right) .
\end{aligned}
$$

(ii) For $j=1,2, \cdots, m$, there exists some $\theta\left(q_{j}\right) \in(1,2)$ such that

& -\frac{\nu_{j}}{q_{j}} \tau_{2, R}^{q_{j}} \int_{\mathbb{R}^{N}}\left(u_{2}+\omega_{2, R}\right)^{q_{j}} d x \\
\leq & -\frac{\nu_{j}}{q_{j}}\left[\int_{\mathbb{R}^{N}} u_{2}^{q_{j}}+\omega_{2, R}^{q_{j}} d x\right]-\nu_{j} \int_{\mathbb{R}^{N}}\left[u_{2}^{q_{j}-1} \omega_{2, R}+u_{2} \omega_{2, R}^{q_{j}-1}\right] d x \\
& +\frac{\nu_{j} \sigma_{2, R}}{a_{2}+b_{2}}\left[\int_{\mathbb{R}^{N}} u_{2}^{q_{j}}+\omega_{2, R}^{q_{j}} d x\right]+o\left(\sigma_{2, R}^{\theta\left(q_{j}\right)}\right) .
\end{aligned}
$$

(iii) If $\sigma_{1, R}>0$, for $k=1,2, \cdots, n$, there exists some $\theta=\theta\left(r_{1, k}, r_{2, k}\right) \in(1,2)$ such that

& +\frac{\beta_{k} r_{1, k}}{a_{1}+b_{1}} \sigma_{1, R} \int_{\mathbb{R}^{N}}\left[u_{1}^{r_{1, k}} u_{2}^{r_{2, k}}+\omega_{1, R}^{r_{1, k}} \omega_{2, R}^{r_{2, k}}\right] d x \\
& +\frac{\beta_{k} r_{2, k}}{a_{2}+b_{2}} \sigma_{2, R} \int_{\mathbb{R}^{N}}\left[u_{1}^{r_{1, k}} u_{2}^{r_{2, k}}+\omega_{1, R}^{r_{1, k}} \omega_{2, R}^{r_{2, k}}\right] d x+o\left(\sigma_{1, R}^{\theta}\right)

And if $\sigma_{1, R}=0$, for $k=1,2, \cdots, n$, there exists some $\theta=\theta\left(r_{1, k}, r_{2, k}\right) \in(1,2)$ such that

\leq & -\beta_{k} \int_{\mathbb{R}^{N}}\left[u_{1}^{r_{1, k}} u_{2}^{r_{2, k}}+r_{2, k} u_{1}^{r_{1, k}} u_{2}^{r_{2, k}-1} \omega_{2, R}+\omega_{1, R}^{r_{1, k}} \omega_{2, R}^{r_{2, k}}\right] d x \\
& +\frac{\beta_{k} r_{2, k}}{a_{2}+b_{2}} \sigma_{2, R} \int_{\mathbb{R}^{N}}\left[u_{1}^{r_{1, k}} u_{2}^{r_{2, k}}+\omega_{1, R}^{r_{1, k}} \omega_{2, R}^{r_{2, k}}\right] d x+o\left(\sigma_{2, R}^{\theta}\right) .

This lemma gives a good intersection estimation, which plays a crucial role in the proof of strict binding inequality. Its proof required a sequence of complicated calculations. We shall give the details in Appendix B. Basing on these estimations, we obtain the following strict binding inequality. The proof of the following proposition will be given in Appendix C.

Proposition 6.5. Suppose that ( $V H 1$ ) holds and $G(s, t)$ is given by (1.11) with the parameters satisfying (1.13). Let $0<\lambda_{1} \leq \lambda_{2}$. Suppose that $\left(u_{1}, u_{2}\right) \neq(0,0)$ is a nonnegative solution to (5.1) and $\left(\omega_{1}, \omega_{2}\right) \neq(0,0)$ is a nonnegative solution to (5.9). Then there exists some $\left(\phi_{1}, \phi_{2}\right) \in \mathcal{H}$ such that

\end{equation*}

## 7. Compactness analysis and Proof of Theorem 1.4

In this section, we shall apply the standard concentration compactness argument to prove Theorem 1.4.

Remark 7.1. We remark that for $a_{1}>0, a_{2}>0, S_{a_{1}, a_{2}}$ is a Hilbert manifold with codimension 2. And for any minimizing sequence $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}_{\vartheta=1}^{\infty} \subset S_{a_{1}, a_{2}}$, by Ekeland's variational principle for $J$ and $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}$ on $S_{a_{1}, a_{2}}$, there exist $\left\{\left(v_{1, \vartheta}, v_{2, \vartheta}\right)\right\} \subset S_{a_{1}, a_{2}}$ and $\left\{\lambda_{1, \vartheta}\right\},\left\{\lambda_{2, \vartheta}\right\} \subset \mathbb{R}$ such that

J^{\prime}\left[v_{1, \vartheta}, v_{2, \vartheta}\right]+\lambda_{1, \vartheta}\left(v_{1, \vartheta}, 0\right)+\lambda_{2, \vartheta}\left(0, v_{2, \vartheta}\right) \rightarrow 0 \text { strongly in } \mathcal{H}^{*} \text { as } \vartheta \rightarrow \infty .
$$

See also [22, Lemma 2.3].

For $a_{1}>0, a_{2}>0$. Let us take any minimizing sequence $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}_{\vartheta=1}^{\infty} \subset S_{a_{1}, a_{2}}$ for $C_{a_{1}, a_{2}}$. Since $J\left[u_{1}, u_{2}\right]=J\left[\left|u_{1}\right|,\left|u_{2}\right|\right],\left\{\left(\left|u_{1, \vartheta}\right|, \mid u_{2, \vartheta}\right) \mid\right\}_{\vartheta=1}^{\infty}$ is also a minimizing sequence. Hence, we may suppose that $\left\{u_{\iota, \vartheta}\right\}(\iota=1,2, \vartheta \in \mathbb{N})$ are nonnegative functions. By Remark 7.1, without loss of generality, we may suppose further that

Lemma 7.2. Suppose that ( $V H 1$ ) holds and $G(s, t)$ is given by (1.11). For any given $a_{1}>$ $0, a_{2}>0$, let $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}_{\vartheta=1}^{\infty} \subset S_{a_{1}, a_{2}}$ be a minimizing sequence such that $u_{\iota, \vartheta}, \iota=1,2, \vartheta \in \mathbb{N}$ are nonnegative functions and (7.1) holds, then $\left\{\left(\lambda_{1, \vartheta}, \lambda_{2, \vartheta}\right)\right\}$ is bounded.

Proof. Recalling that $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}$ are bounded in $\mathcal{H}$ (see Remark 2.5), by

Lemma 7.3. Under the assumptions of Lemma 7.2, let $Q^{N}:=[0,1]^{N}$. Then

Proof. We only prove the case of $\iota=1$. And the case of $\iota=2$ can be proved in a same way. Let us suppose

Lemma 7.4. Under the assumptions of Lemma 7.2, up to a subsequence, we assume that $\left(\lambda_{1, \vartheta}, \lambda_{2, \vartheta}\right) \rightarrow\left(\lambda_{1}, \lambda_{2}\right)$. If $N \geq 5$, we suppose further (1.13) and (1.14). Then $\lambda_{1}>0, \lambda_{2}>0$.
Proof. We only prove $\lambda_{1}>0$. From Lemma 7.3, we deduce that there exists $y_{\vartheta} \in \mathbb{R}^{N}$ such that $\liminf _{\vartheta \rightarrow \infty}\left\|\phi_{\vartheta}(x)\right\|_{L^{2}\left(Q^{N}\right)}=: \delta>0$, where $\phi_{\vartheta}(x):=u_{1, \vartheta}\left(x+y_{\vartheta}\right)$. Up to a subsequence, there exists some $0 \not \equiv \phi_{0}(x) \geq 0$ in $\mathbb{R}^{N}$ such that $\phi_{\vartheta}(x) \rightharpoonup \phi_{0}(x)$ in $H^{1}\left(\mathbb{R}^{N}\right)$. If $\lambda_{1} \leq 0$, we have that

\end{equation*}

By the strong maximum principle, $\phi_{0}>0$ in $\mathbb{R}^{N}$. However, if $1 \leq N \leq 4$, (7.5) implies that

a contradiction to [20, Lemma A.2]. If $N \geq 5$, by (1.14), we see that $p_{1}-1 \leq \frac{N}{N-2}$. Then follows by [34, Theorem 8.4] that (7.5) does not have any positive solution, also a contradiction. Hence, we prove that $\lambda_{1}>0$.

In the following, without loss of generality, we may assume that $0<\lambda_{1} \leq \lambda_{2},\left(u_{1, \vartheta}, u_{2, \vartheta}\right) \longrightarrow$ $\left(u_{1}, u_{2}\right)$ weakly in $\mathcal{H}$ and $\lambda_{\iota, \vartheta} \rightarrow \lambda_{\iota}, \iota=1,2$. Remark that $\left\|u_{\iota}\right\|_{2}^{2} \leq a_{\iota}, \iota=1,2$, and notice that

\left(u_{1, \vartheta}, u_{2, \vartheta}\right) \rightarrow\left(u_{1}, u_{2}\right) \text { strongly in } L^{2}\left(\mathbb{R}^{N}\right) \times L^{2}\left(\mathbb{R}^{N}\right)
$$

if $\left(\left\|u_{1}\right\|_{2}^{2},\left\|u_{2}\right\|_{2}^{2}\right)=\left(a_{1}, a_{2}\right)$. Recalling $\left\{\left(u_{1, \vartheta}, u_{2, \vartheta}\right)\right\}$ is bounded in $\mathcal{H}$, by the well known BrezisLieb Lemma and Gagliardo-Nirenberg inequality, one can prove that

\int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}, u_{2, \vartheta}\right) d x \rightarrow \int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x . \tag{7.7}

On the other hand, by $V_{\iota}(x) \rightarrow 0$ as $|x| \rightarrow \infty$ and the weak lower semicontinuity of norm, it follows that

& =\lim _{\vartheta \rightarrow \infty}\left\{\sum_{\iota=1}^{2}\left[\left\|\nabla u_{\iota, \vartheta}\right\|_{2}^{2}-\left\|u_{\iota, \vartheta}\right\|_{V_{\iota}}^{2}\right]-\int_{\mathbb{R}^{N}} G\left(u_{1, \vartheta}, u_{2, \vartheta}\right) d x\right\} \\
& \geq \sum_{\iota=1}^{2}\left[\left\|\nabla u_{\iota}\right\|_{2}^{2}-\left\|u_{\iota}\right\|_{V_{\iota}}^{2}\right]-\int_{\mathbb{R}^{N}} G\left(u_{1}, u_{2}\right) d x \\
& =J\left[u_{1}, u_{2}\right] \geq C_{a_{1}, a_{2}} .
\end{aligned}
$$

Therefore, $\left(u_{1, \vartheta}, u_{2, \vartheta}\right) \rightarrow\left(u_{1}, u_{2}\right)$ strongly in $\mathcal{H}$ and $J\left[u_{1}, u_{2}\right]=C_{a_{1}, a_{2}}$.
Proof of Theorem 1.4: It is sufficient to prove that $\left(\left\|u_{1}\right\|_{2}^{2},\left\|u_{2}\right\|_{2}^{2}\right)=\left(a_{1}, a_{2}\right)$. We argue by contradiction and suppose that

\left(\left\|u_{1}\right\|_{2}^{2},\left\|u_{2}\right\|_{2}^{2}\right)=:\left(b_{1}, b_{2}\right) \neq\left(a_{1}, a_{2}\right)
$$

Firstly we prove
Lemma 7.5. $\left(u_{1}, u_{2}\right) \neq(0,0)$ and $\left(b_{1}, b_{2}\right) \neq(0,0)$.
Proof. Suppose that $\left(u_{1}, u_{2}\right)=(0,0)$, then we also have $\left(b_{1}, b_{2}\right)=(0,0)$. Remark that $u_{\iota, \vartheta} \rightarrow 0$ in $L_{\text {loc }}^{p}\left(\mathbb{R}^{N}\right)$ for $2 \leq p<2^{*}$ and $\iota=1,2$. So by $V_{\iota}(x) \rightarrow 0$ as $|x| \rightarrow \infty$, one can prove that

\left\|u_{\iota, \vartheta}\right\|_{V_{\iota}}^{2} \rightarrow 0 \text { as } \vartheta \rightarrow \infty, \iota=1,2 .

a contradiction to Lemma 3.1 and Corollary 4.4.
Secondly we prove
Lemma 7.6. Let $Q^{N}:=[0,1]^{N}$. Then

Suppose that $\liminf _{\vartheta \rightarrow \infty} \sup _{y \in \mathbb{R}^{N}}\left[\left\|u_{1, \vartheta}-u_{1}\right\|_{L^{2}\left(Q^{N}+y\right)}+\left\|u_{2, \vartheta}-u_{2}\right\|_{L^{2}\left(Q^{N}+y\right)}\right]=0$. Then by [38, Lemma 1.21] again, we have that $u_{\iota, \vartheta} \rightarrow u_{\iota}$ strongly in $L^{p}\left(\mathbb{R}^{N}\right)$ for any $2<p<2^{*}$ and $\iota=1,2$. On the other hand, $V_{\iota}(x) \rightarrow 0$ as $|x| \rightarrow \infty$ and $u_{\iota, \vartheta} \rightarrow u_{\iota}$ in $L_{l o c}^{2}\left(\mathbb{R}^{N}\right)$ for $\iota=1,2$. Therefore,

C_{b_{1}, b_{2}} \leq J\left[u_{1}, u_{2}\right] \leq \liminf _{\vartheta \rightarrow \infty} J\left[u_{1, \vartheta}, u_{2, \vartheta}\right]=C_{a_{1}, a_{2}}, \tag{7.9}
\end{equation*}
$$

a contradiction to Corollary 3.3, due to the fact $(0,0) \neq\left(a_{1}-b_{1}, a_{2}-b_{2}\right) \in \mathbb{R}_{+}^{2}$.
Then by Lemma 7.6 , we may find $y_{\vartheta} \in \mathbb{R}^{N}$ such that $\left|y_{\vartheta}\right| \rightarrow \infty$ and up to a subsequence,

In particular, put $c_{\iota}:=\left\|\omega_{\iota}\right\|_{2}^{2}, \iota=1,2$. Then we have

\end{align*}

and

\lim _{\vartheta \rightarrow \infty} J\left[\omega_{1}\left(\cdot-y_{\vartheta}\right), \omega_{2}\left(\cdot-y_{\vartheta}\right)\right]=I\left[\omega_{1}, \omega_{2}\right] \geq E_{c_{1}, c_{2}} . \tag{7.15}
\end{equation*}
$$

Put $\delta_{\iota}:=\lim _{\vartheta \rightarrow \infty}\left\|u_{\iota, \vartheta}-u_{\iota}-\omega_{\iota}\left(\cdot-y_{\vartheta}\right)\right\|_{2}^{2}$, then by (7.11), we have

$$
\begin{equation*}
\delta_{\iota}=a_{\iota}-b_{\iota}-c_{\iota} \geq 0, \iota=1,2 . \tag{7.16}
\end{equation*}
$$

Since $u_{\iota, \vartheta}-u_{\iota}-\omega_{\iota}\left(\cdot-y_{\vartheta}\right) \rightarrow 0$ in $L_{l o c}^{p}\left(\mathbb{R}^{N}\right)$ for $2 \leq p<2^{*}$ and $V_{\iota}(x) \rightarrow 0$ as $|x| \rightarrow \infty$, we have that

$$
\begin{aligned}
& J\left[u_{1, \vartheta}-u_{1}-\omega_{1}\left(\cdot-y_{\vartheta}\right), u_{2, \vartheta}-u_{2}-\omega_{2}\left(\cdot-y_{\vartheta}\right)\right] \\
& -I\left[u_{1, \vartheta}-u_{1}-\omega_{1}\left(\cdot-y_{\vartheta}\right), u_{2, \vartheta}-u_{2}-\omega_{2}\left(\cdot-y_{\vartheta}\right)\right] \\
= & -\frac{1}{2} \sum_{\iota=1}^{2}\left\|u_{\iota, \vartheta}-u_{\iota}-\omega_{\iota}\left(\cdot-y_{\vartheta}\right)\right\|_{V_{\iota}}^{2} \rightarrow 0 .
\end{aligned}
$$

And then it follows Lemma 3.4 that

$$
\begin{align*}
& \liminf _{\vartheta \rightarrow \infty} J\left[u_{1, \vartheta}-u_{1}-\omega_{1}\left(\cdot-y_{\vartheta}\right), u_{2, \vartheta}-u_{2}-\omega_{2}\left(\cdot-y_{\vartheta}\right)\right] \\
= & \liminf _{\vartheta \rightarrow \infty} I\left[u_{1, \vartheta}-u_{1}-\omega_{1}\left(\cdot-y_{\vartheta}\right), u_{2, \vartheta}-u_{2}-\omega_{2}\left(\cdot-y_{\vartheta}\right)\right] \geq E_{\delta_{1}, \delta_{2}} \tag{7.17}
\end{align*}
$$

By the formulas (7.14)- (7.17), we have that

$$
\begin{align*}
C_{a_{1}, a_{2}}= & \lim _{\vartheta \rightarrow \infty} J\left[u_{1, \vartheta}, u_{2, \vartheta}\right] \\
= & \lim _{\vartheta \rightarrow \infty}\left\{J\left[u_{1}, u_{2}\right]+J\left[\omega_{1}\left(\cdot-y_{\vartheta}\right), \omega_{2}\left(\cdot-y_{\vartheta}\right)\right]\right. \\
& \left.\quad+J\left[u_{1, \vartheta}-u_{1}-\omega_{1}\left(\cdot-y_{\vartheta}\right), u_{2, \vartheta}-u_{2}-\omega_{2}\left(\cdot-y_{\vartheta}\right)\right]\right\}  \tag{7.18}\\
\geq & C_{b_{1}, b_{2}}+E_{c_{1}, c_{2}}+E_{\delta_{1}, \delta_{2}}
\end{align*}
$$

However, by Corollary 4.4, we may assume that $E_{c_{1}, c_{2}}$ and $E_{\delta_{1}, \delta_{2}}$ are attained by some nonnegative symmetry decreasing functions $\left(\phi_{1}, \phi_{2}\right)$ and $\left(\psi_{1}, \psi_{2}\right)$ respectively. We recall the coupled rearrangement of $u$ and $v$, which is introduced by M. Shibata [35]. Then one can see that

and

E_{c_{1}+\delta_{1}, c_{2}+\delta_{2}} \leq I\left[\phi_{1} \star \psi_{1}, \phi_{2} \star \psi_{2}\right]<I\left[\phi_{1}, \phi_{2}\right]+I\left[\psi_{1}, \psi_{2}\right]=E_{c_{1}, c_{2}}+E_{\delta_{1}, \delta_{2}}
$$

see [35, Theorem 2.4].
Therefore,

C_{b_{1}, b_{2}}+E_{c_{1}, c_{2}}+E_{\delta_{1}, \delta_{2}}>C_{b_{1}, b_{2}}+E_{c_{1}+\delta_{1}, c_{2}+\delta_{2}} \geq C_{b_{1}+c_{1}+\delta_{1}, b_{2}+c_{2}+\delta_{2}}=C_{a_{1}, a_{2}}
$$

a contradiction to (7.18). Hence, we prove that $\delta_{\iota}=0, \iota=1,2$. That is,

\left(a_{1}, a_{2}\right)=\left(b_{1}, b_{2}\right)+\left(c_{1}, c_{2}\right)
$$

Again by (7.15), (7.18) and

$$
C_{b_{1}, b_{2}}+E_{c_{1}, c_{2}} \geq C_{b_{1}+c_{1}, b_{2}+c_{2}}=C_{a_{1}, a_{2}}
$$

we see that

$$
J\left[u_{1}, u_{2}\right]=C_{b_{1}, b_{2}}, I\left[\omega_{1}, \omega_{2}\right]=E_{c_{1}, c_{2}} \quad \text { and } \quad C_{a_{1}, a_{2}}=C_{b_{1}, b_{2}}+E_{c_{1}, c_{2}}
$$

Now, we see that on the contrary hypothesis $\left(b_{1}, b_{2}\right) \neq\left(a_{1}, a_{2}\right)$, we obtain that $(0,0) \neq$ $\left(u_{1}, u_{2}\right),(0,0) \neq\left(\omega_{1}, \omega_{2}\right)$. Recalling (7.1), $\left|y_{\vartheta}\right| \rightarrow \infty$ and $V_{\iota}(x) \rightarrow 0$ as $|x| \rightarrow \infty$, we see that
$\left(u_{1}, u_{2}\right) \neq(0,0)$ is a nonnegative solution to (5.1) and $\left(\omega_{1}, \omega_{2}\right) \neq(0,0)$ is a nonnegative solution to (5.9). Then by Proposition 6.5, there exists some $\left(\phi_{1}, \phi_{2}\right) \in \mathcal{H}$ such that

$$
\left(\left\|\phi_{1}\right\|_{2}^{2},\left\|\phi_{2}\right\|_{2}^{2}\right)=\left(\left\|u_{1}\right\|_{2}^{2}+\left\|\omega_{1}\right\|_{2}^{2},\left\|u_{2}\right\|_{2}^{2}+\left\|\omega_{2}\right\|_{2}^{2}\right) \text { and } J\left[\phi_{1}, \phi_{2}\right]<J\left[u_{1}, u_{2}\right]+I\left[\omega_{1}, \omega_{2}\right] .
$$

We see that $\left(\phi_{1}, \phi_{2}\right) \in S_{a_{1}, a_{2}}$. On the other hand, by Lemma 7.7, we have $J\left[u_{1}, u_{2}\right]=C_{b_{1}, b_{2}}$ and $I\left[\omega_{1}, \omega_{2}\right]=E_{c_{1}, c_{2}}$. Hence,

$$
C_{a_{1}, a_{2}} \leq J\left[\phi_{1}, \phi_{2}\right]<J\left[u_{1}, u_{2}\right]+I\left[\omega_{1}, \omega_{2}\right]=C_{b_{1}, b_{2}}+E_{c_{1}, c_{2}},
$$

a contradiction to (7.13).
To sum up, we can prove that $\left(b_{1}, b_{2}\right)=\left(a_{1}, a_{2}\right)$ and $J\left[u_{1}, u_{2}\right]=C_{a_{1}, a_{2}}$.

## 8. Appendix A

In this appendix, we give the detailed proof of Proposition 5.4.
Without loss of generality, we assume that $0<\lambda_{1} \leq \lambda_{2}$. By $r_{1}, r_{2}>1$, we have that $\bar{\lambda}_{1}=\lambda_{1}$ and $\bar{\lambda}_{2}=\min \left\{\lambda_{2}, \frac{r_{1}^{2}}{\left(2-r_{2}\right)_{+}^{2}} \lambda_{1}\right\}$.
(i) Put $u(x):=u_{1}(x)+u_{2}(x)$, we have that

-\Delta u+\lambda_{1} u & =\partial_{1} G\left(u_{1}, u_{2}\right)+\partial_{2} G\left(u_{1}, u_{2}\right)-V_{1}(x) u_{1}-V_{2}(x) u_{2}+\left(\lambda_{1}-\lambda_{2}\right) u_{2} \\
& \leq \partial_{1} G\left(u_{1}, u_{2}\right)+\partial_{2} G\left(u_{1}, u_{2}\right)-V_{1}(x) u_{1}-V_{2}(x) u_{2} .
\end{aligned}
$$

It follows from $V_{1}(x), V_{2}(x) \leq 0$ that

$$
\begin{equation*}
-\Delta u+\left[\lambda_{1}+V_{1}(x)+V_{2}(x)\right] u \leq \partial_{1} G\left(u_{1}, u_{2}\right)+\partial_{2} G\left(u_{1}, u_{2}\right) \tag{A.1}
\end{equation*}
$$

We can take some $R_{1}>0$ large enough such that

$$
u(x):=u_{1}(x)+u_{2}(x)<1 \text { for }|x| \geq R_{1} .
$$

By (5.4), we have that

\begin{aligned}
\partial_{1} G\left(u_{1}, u_{2}\right)+\partial_{2} G\left(u_{1}, u_{2}\right) & \leq C_{1}\left(u_{1}^{p_{1}-1}+u_{1}^{r_{1}-1}\left(u_{1}+u_{2}\right)^{r_{2}}+u_{2}^{q_{1}-1}+u_{2}^{r_{2}-1}\left(u_{1}+u_{2}\right)^{r_{1}}\right) \\
& \leq C_{R_{1}} u^{p} \text { for }|x| \geq R_{1},
\end{aligned}
$$

where $p:=\min \left\{p_{1}-1, q_{1}-1, r_{1}+r_{2}-1\right\}>1$. Then by (A.1), we obtain that

\begin{equation*}
-\Delta u+\left[\lambda_{1}+V_{1}(x)+V_{2}(x)-C_{R_{1}} u^{p-1}\right] u \leq 0 \text { for }|x| \geq R_{1} . \tag{A.2}
\end{equation*}
$$

So for any $0<\nu_{2}<\lambda_{1}$, by $\lim _{|x| \rightarrow \infty} V_{\iota}(x)=0, \iota=1,2$, we can take some $R_{2}>R_{1}$ such that

\lambda_{1}+V_{1}(x)+V_{2}(x)-C_{R_{1}} u^{p-1}>\nu_{2} \text { for }|x| \geq R_{2}
$$

Hence, we have

\end{equation*}
$$

Then by the comparison principle, we have that $u(x) \leq C e^{-\sqrt{\nu_{2}}|x|}$ in $B_{R_{2}}^{c}$. Therefore, we can find some $C_{\nu_{2}}>0$ such that $u_{1}(x) \leq u(x) \leq C_{\nu_{2}} e^{-\sqrt{\nu_{2}}|x|}$ in $\mathbb{R}^{N}$.

On the other hand, by (5.3), we see that $\partial_{1} G\left(u_{1}, u_{2}\right) \geq 0$, and thus

$$

where $G_{\lambda_{1}}$ is the Green function for $-\Delta+\lambda_{1}$ in $\mathbb{R}^{N}$. It is known (see $[16,22]$ for instance) that

G_{\lambda_{1}} \in C\left(\mathbb{R}^{N} \backslash\{0\}\right) \cap L^{1}\left(\mathbb{R}^{N}\right), G_{\lambda_{1}}(x)>0 \text { in } \mathbb{R}^{N} \backslash\{0\},  \tag{A.4}\\
\lim _{|x| \rightarrow \infty} G_{\lambda_{1}}(x)|x|^{\frac{N-1}{2}} e^{\sqrt{\lambda_{1}}|x|}=\gamma_{0} \in(0, \infty) .
\end{array}\right.
$$

Using the comparison principle again, one can prove that

$$
c_{1}(1+|x|)^{-\frac{N-1}{2}} e^{-\sqrt{\lambda_{1}}|x|} \leq u_{1}(x) \text { for all } x \in \mathbb{R}^{N} \text { and some } c_{1}>0,
$$

and hence (5.6) holds. Noting that for any $\nu_{1}>\lambda_{1}$, it is trivial to find some $C_{\nu_{1}}>0$ such that

C_{\nu_{1}} e^{-\sqrt{\nu_{1}}|x|} \leq c_{1}(1+|x|)^{-\frac{N-1}{2}} e^{-\sqrt{\lambda_{1}}|x|} \text { in } \mathbb{R}^{N} .

Hence, for any $0<\nu_{2}<\lambda_{1}<\nu_{1}$, we can find some $C_{\nu_{1}}, C_{\nu_{2}}>0$ such that

C_{\nu_{1}} e^{-\sqrt{\nu_{1}}|x|} \leq u_{1}(x) \leq C_{\nu_{2}} e^{-\sqrt{\nu_{2}}|x|} \text { in } \mathbb{R}^{N} .

We note that $C_{\nu_{2}} \geq C_{\nu_{1}}$ is trivial by putting $x=0$. Hence, (5.5) holds and we finish the proof of $(i)$.
(ii) We note that (5.8) is trivial by the proof of (i). Next, we focus on the proof of (5.7). We divide the proof into different cases.

Case for $r_{2} \geq 2$ : In this case, we have that $\bar{\lambda}_{2}=\lambda_{2}$. Firstly, we take some $R_{1}>0$ large enough such that

$$

It follows that

-\Delta u_{2}+\left[\lambda_{2}+V_{2}(x)-C_{1} u_{2}^{q_{1}-2}-C_{1} u_{2}^{r_{2}-2}\left[u_{1}+u_{2}\right]^{r_{1}}\right] u_{2} \leq 0 \text { for }|x| \geq R_{1} . \tag{A.5}
\end{equation*}
$$

By $r_{2} \geq 2$, we have that

$$
\lim _{|x| \rightarrow \infty}\left[\lambda_{2}+V_{2}(x)-C_{1} u_{2}(x)^{q_{1}-2}-C_{1} u_{2}(x)^{r_{2}-2}\left[u_{1}(x)+u_{2}(x)\right]^{r_{1}}\right]=\lambda_{2} .
$$

So for any $0<\nu_{2}<\lambda_{2}$, by the comparison principle, we can find some $C_{\nu_{2}}>0$ such that

$$
u_{2}(x) \leq C_{\nu_{2}} e^{-\sqrt{\nu_{2}}|x|} \text { in } \mathbb{R}^{N} .
$$

And we note that the lower bound can be proved as (i). Hence, (5.7) holds for $r_{2} \geq 2$.
Case for $1<r_{2}<2$ : We firstly prove the upper bound of $u_{2}(x)$ in (5.7). Noting that we can find some $C>0$ such that

\partial_{2} G\left(u_{1}(x), u_{2}(x)\right) \leq C\left\{u_{2}(x)^{q_{1}-1}+u_{2}(x)^{r_{2}-1}\left[u_{1}(x)+u_{2}(x)\right]^{r_{1}}\right\} \text { in } \mathbb{R}^{N} .
$$

Put $f_{0}(x):=\partial_{2} G\left(u_{1}(x), u_{2}(x)\right)$. Observing that for any $\lambda \in\left(0, \lambda_{1}\right)$, there exists some $C_{\lambda}$ such that $u_{1}(x)+u_{2}(x) \leq C_{\lambda} e^{-\sqrt{\lambda}|x|}$ in $\mathbb{R}^{N}$. So we see that

f_{0}(x) \leq C_{\lambda}\left(e^{-\left(q_{1}-1\right) \sqrt{\lambda}|x|}+e^{-\left(r_{1}+r_{2}-1\right) \sqrt{\lambda}|x|}\right) .

Since both $q_{1}-1>1$ and $r_{1}+r_{2}-1>1$, we can take $\varepsilon \in\left(0, \frac{\lambda_{1}}{2}\right)$ small enough, such that

Noting that

-\Delta e^{-\sqrt{\nu}|x|}+\left(\lambda_{2}+V_{2}(x)\right) e^{-\sqrt{\nu}|x|}=\left(\lambda_{2}+V_{2}(x)-\nu-\frac{N-1}{|x|} \sqrt{\nu}\right) e^{-\sqrt{\nu}|x|} \tag{A.6}
\end{equation*}
$$

for any $\nu \in\left(0, \min \left\{\lambda_{2}, \xi_{1, \varepsilon}\right\}\right)$, one can find some $R_{\nu}>0$ large enough such that

$$
\begin{equation*}
\left(\lambda_{2}+V_{2}(x)-\nu-\frac{N-1}{|x|} \sqrt{\nu}\right) e^{-\sqrt{\nu}|x|} \geq f_{0}(x) \text { for }|x| \geq R_{\nu} . \tag{A.7}
\end{equation*}
$$

Then by the comparison principle again, one can prove that for any $\nu \in\left(0, \min \left\{\lambda_{2}, \xi_{1, \varepsilon}\right\}\right)$, there exists some $C_{\nu}>0$ such that

\begin{equation*}
u_{2}(x) \leq C_{\nu} e^{-\sqrt{\nu}|x|} \text { in } \mathbb{R}^{N} \tag{A.8}
\end{equation*}
$$

In particular, if $\xi_{1, \varepsilon}<\lambda_{2}$, one can improve the statement that

\begin{equation*}
u_{2}(x) \leq C_{\varepsilon} e^{-\sqrt{\xi_{1, \varepsilon}}|x|} \text { in } \mathbb{R}^{N} \tag{A.9}
\end{equation*}
$$

So if $\xi_{1, \varepsilon} \geq \lambda_{2}$, the upper bound of $u_{2}(x)$ in (5.7) holds. If $\xi_{1, \varepsilon}<\lambda_{2}$, noting that $\xi_{1, \varepsilon}>\lambda_{1}$, so by such argument, we can improve the decay of $u_{2}$ from $e^{-\sqrt{\lambda}|x|}$ with $\lambda \in\left(0, \lambda_{1}\right)$ to $e^{-\sqrt{\lambda}|x|}$ with $\lambda \in\left(0, \xi_{1, \varepsilon}\right)$. For each $\varepsilon \in\left(0, \frac{\lambda_{1}}{2}\right)$, we set

\end{equation*}

Suppose that $\xi_{n, \varepsilon}<\lambda_{2}$, then we have $f_{0}(x) \leq C_{n+1, \varepsilon} e^{-\sqrt{\xi_{n+1, \varepsilon}}|x|}$ in $\mathbb{R}^{N}$. Apply a similar argument as (A.6)-(A.9), one can prove that for any $\nu \in\left(0, \min \left\{\lambda_{2}, \xi_{n+1, \varepsilon}\right\}\right)$,

u_{2}(x) \leq C_{\nu} e^{-\sqrt{\nu}|x|} \text { in } \mathbb{R}^{N} . \tag{A.11}
\end{equation*}

In particular, if $\xi_{n+1, \varepsilon}<\lambda_{2}$,

u_{2}(x) \leq C_{\varepsilon} e^{-\sqrt{\xi_{n+1, \varepsilon}}|x|} \text { in } \mathbb{R}^{N} \tag{A.12}
\end{equation*}
$$

By solving the equation

r_{1} \sqrt{\lambda_{1}}+\left(r_{2}-1\right) \sqrt{t}=\sqrt{t}, \tag{A.13}
\end{equation*}
$$

we have that $t=\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}} \lambda_{1}$. So if $\lambda_{3}:=\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}} \lambda_{1}>\lambda_{2}$, we can take $\varepsilon_{0}>0$ small enough such that $\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}}\left(\lambda_{1}-\varepsilon_{0}\right)>\lambda_{2}$. Since $q_{1}-1>1$, we have that

\begin{equation*}
\sqrt{s}<\left(q_{1}-1\right) \sqrt{s} \text { for any } s>0 \tag{A.14}
\end{equation*}
$$

and

$$
\begin{equation*}
\sqrt{s}<r_{1} \sqrt{\lambda_{1}-\varepsilon_{0}}+\left(r_{2}-1\right) \sqrt{s} \text { iff } s<\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}}\left(\lambda_{1}-\varepsilon_{0}\right) . \tag{A.15}
\end{equation*}
$$

So if $\xi_{n, \varepsilon_{0}} \leq \lambda_{2}$ for all $n \in \mathbb{N}$, then by (A.10), (A.14) and (A.15), we see that $\left\{\xi_{n, \varepsilon_{0}}\right\}$ is an increasing sequence with upper bound $\lambda_{2}$. Let $n \rightarrow \infty$, we have that

\sqrt{\xi_{\infty, \varepsilon_{0}}}=r_{1} \sqrt{\lambda_{1}}+\left(r_{2}-1\right) \sqrt{\xi_{\infty, \varepsilon_{0}}},

which implies $\xi_{\infty, \varepsilon_{0}}=\lambda_{3} \leq \lambda_{2}$, a contradiction. Hence, there must exists some $n_{0} \in \mathbb{N}$ such that $\xi_{n_{0}, \varepsilon_{0}}>\lambda_{2}$. Therefore, for the case of $1<r_{2}<2$ with $\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}} \lambda_{1}>\lambda_{2}$, we have $\bar{\lambda}_{2}=\lambda_{2}$. And for any $0<\nu_{2}<\lambda_{2}$, we can find some $C_{\nu_{2}}>0$ such that $u_{2}(x) \leq C_{\nu_{2}} e^{-\sqrt{\nu_{2}}|x|}$ in $\mathbb{R}^{N}$. And we note that the lower bound can be proved as (i). Hence, (5.7) holds for $1<r_{2}<2$ with $\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}} \lambda_{1}>\lambda_{2}$.

Finally, we focus on the case of $1<r_{2}<2$ with $\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}} \lambda_{1} \leq \lambda_{2}$. In this case, we have $\lambda_{1}<\lambda_{2}$ and $\bar{\lambda}_{2}=\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}} \lambda_{1}$. We take $\xi_{1}$ satisfying that $\lambda_{1}<\xi_{1}<\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}} \lambda_{1} \leq \lambda_{2}$ and fix an $\varepsilon_{1} \in\left(0, \frac{\lambda_{1}}{2}\right)$ small enough such that

$$
\begin{equation*}
\lambda_{1}<\xi_{1}<\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}}\left(\lambda_{1}-\varepsilon_{1}\right) . \tag{A.16}
\end{equation*}
$$

We argue as above and define $\left\{\xi_{n, \varepsilon}\right\}$ inductively by (A.10) with $\xi_{1, \varepsilon}:=\xi_{1}-\varepsilon$ for $\varepsilon \in\left(0, \varepsilon_{1}\right)$. Then one can check that $\left\{\xi_{n, \varepsilon}\right\}_{n=1}^{\infty}$ is an increasing sequence such that

Hence, for any $\nu \in\left(0, \bar{\lambda}_{2}\right)$, we can take $\varepsilon_{0}>0$ small enough such that

which implies that there exists some $n_{0} \in \mathbb{N}$ such that $\min \left\{\xi_{n_{0}, \varepsilon_{0}}, \lambda_{2}\right\}=\xi_{n_{0}, \varepsilon_{0}}>\nu$. Then we can find some $C_{\nu}>0$ such that $u_{2}(x) \leq C_{\nu} e^{-\sqrt{\nu}|x|}$ in $\mathbb{R}^{N}$.

If $\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}} \lambda_{1} \geq \lambda_{2}$, we have $\bar{\lambda}_{2}=\lambda_{2}$, the lower bound can be proved as $(i)$. So we suppose that $\bar{\lambda}_{2}:=\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}} \lambda_{1}<\lambda_{2}$. We can prove the lower bound by a similar inductively way. Firstly, we note that for any $\nu>\lambda_{2}$, as in (i), one can find some $C_{\nu}>0$ such that

with $\alpha_{1}:=\left(r_{1}+r_{2}-1\right) \frac{N-1}{2}>0$. Recalling the Green function of $G_{\lambda_{2}}$, by

& \geq \int_{\mathbb{R}^{N}} G_{\lambda_{2}}(x-y) f_{0}(y) d y \\
& \geq \tilde{c}_{1} \int_{\mathbb{R}^{N}} G_{\lambda_{2}}(x-y)(1+|x|)^{-\alpha_{1}} e^{-\sqrt{\eta_{1} \mid}|y|} d y
\end{aligned}
$$

Then by Corollary 5.2, we have that

& \lim _{r \rightarrow \infty}(1+r)^{\alpha_{1}} e^{\sqrt{\eta_{1}} r} \int_{\mathbb{R}^{N}} G_{\lambda_{2}}(r \omega-y)(1+|x|)^{-\alpha_{1}} e^{-\sqrt{\eta_{1}}|y|} d y \\
= & \int_{\mathbb{R}^{N}} G_{\lambda_{2}}(y) e^{\sqrt{\eta_{1} \omega \cdot y}} d y>0 \text { uniformly with respect to } \omega \in \mathcal{S}^{N-1} .
\end{aligned}
$$

Hence, we can find some $c_{1}>0$ such that

u_{2}(x) \geq c_{1}(1+|x|)^{-\alpha_{1}} e^{-\sqrt{\eta_{1}}|x|} \text { in } \mathbb{R}^{N} . \tag{A.19}

If $\nu>\eta_{1}$, by (A.19), we can find some $C_{\nu}>0$ such that $u_{2}(x) \geq C_{\nu} e^{-\sqrt{\nu}|x|}$ in $\mathbb{R}^{N}$. If $\eta_{n} \geq \nu$, inductively, we define

If there exists some $n_{0} \in \mathbb{N}$ such that $\eta_{n_{0}}<\nu$, our assertion holds. Suppose that $\eta_{n} \geq \nu$ for all $n \in \mathbb{N}$, we have $\eta_{n}>\frac{r_{1}^{2}}{\left(2-r_{2}\right)^{2}} \lambda_{1}$ for all $n \in \mathbb{N}$. Observing that

we see that $\left\{\eta_{n}\right\}_{n=1}^{\infty}$ is an decreasing sequence. Thus, $\eta_{n} \leq \eta_{1}<\lambda_{2}$ holds for all $n \in \mathbb{N}$. Hence, Corollary 5.2 is applied for every step in the induction. Let $n \rightarrow \infty$, we obtain that

a contradiction to $\nu>\bar{\lambda}_{2}$. We complete the proof.

## 9. Appendix B

In this appendix, we give the proof of Lemma 6.4.

By proposition 5.4, for any $\nu<\sqrt{\lambda_{1}}$, there exists some $C_{\nu}>0$ such that

Then thanks to $\frac{p_{i}}{2}>1$ and $p_{i}-1>1$, we can find some $\varepsilon>0$ such that

It follows from (5.11) that $c(1+R)^{-\frac{N-1}{2}} e^{-\sqrt{\lambda_{1}} R} \leq \sigma_{1, R}$. So we can find some $\theta\left(p_{i}\right) \in(1,2)$ such that

## 10. Appendix C

In this appendix, we give the proof of Proposition 6.5.
For $\iota=1,2$, put $a_{\iota}:=\left\|u_{\iota}\right\|_{2}^{2}, b_{\iota}:=\left\|\omega_{\iota}\right\|_{2}^{2}$. Let $\omega_{\iota, R}:=\omega_{\iota}\left(\cdot-R \mathbf{e}_{\mathbf{1}}\right)$ and $\sigma_{\iota, R}:=\int_{\mathbb{R}^{N}} u_{\iota} \omega_{\iota, R} d x$. Let $\tau_{\iota, R}:=\sqrt{\frac{a_{\iota}+b_{\iota}}{a_{\iota}+b_{\iota}+2 \sigma_{\iota, R}}}$. For $\iota=1,2$, we have

& -\frac{\sigma_{\iota, R}}{a_{\iota}+b_{\iota}}\left\{\left(\left\|\nabla u_{\iota}\right\|_{2}^{2}+\left\|\nabla \omega_{\iota}\right\|_{2}^{2}\right)-\left(\left\|u_{\iota}\right\|_{V_{\iota}}^{2}+\left\|\omega_{\iota, R}\right\|_{V_{\iota}}^{2}\right)\right\}+O\left(\sigma_{\iota, R}^{2}\right) \\
& +O\left(\sigma_{\iota, R}\left(\left\langle\nabla u_{\iota}, \nabla \omega_{\iota, R}\right\rangle_{L^{2}}-\left\langle u_{\iota}, \omega_{\iota, R}\right\rangle_{V_{\iota}}\right)\right) \\
= & \frac{1}{2}\left\{\left(\left\|\nabla u_{\iota}\right\|_{2}^{2}+\left\|\nabla \omega_{\iota}\right\|_{2}^{2}+2\left\langle\nabla u_{\iota}, \nabla \omega_{\iota, R}\right\rangle_{L^{2}}\right)-\left(\left\|u_{\iota}\right\|_{V_{\iota}}^{2}+2\left\langle u_{\iota}, \omega_{\iota, R}\right\rangle_{V_{\iota}}\right)\right\} \\
& -\frac{\sigma_{\iota, R}}{a_{\iota}+b_{\iota}}\left\{\left(\left\|\nabla u_{\iota}\right\|_{2}^{2}+\left\|\nabla \omega_{\iota}\right\|_{2}^{2}\right)-\left\|u_{\iota}\right\|_{V_{\iota}}^{2}\right\}+O\left(\sigma_{\iota, R}^{2}\right) \\
& +O\left(\sigma_{\iota, R}\left(\left\langle\nabla u_{\iota}, \nabla \omega_{\iota, R}\right\rangle_{L^{2}}-\left\langle u_{\iota}, \omega_{\iota, R}\right\rangle_{V_{\iota}}\right)\right)-\left(\frac{1}{2}-\frac{\sigma_{\iota, R}}{a_{\iota}+b_{\iota}}\right)\left\|\omega_{\iota, R}\right\|_{V_{\iota}}^{2} .

\left\langle\nabla u_{2}, \nabla \omega_{2, R}\right\rangle_{L^{2}}-\left\langle u_{2}, \omega_{2, R}\right\rangle_{V_{2}}=-\lambda_{2} \sigma_{2, R}+\int_{\mathbb{R}^{N}} \partial_{2} G\left(u_{1}, u_{2}\right) \omega_{2, R} d x .

When $0<\lambda_{1} \leq \lambda_{2}$, due to $p_{i}-1>1, q_{j}-1>1, r_{1, k}+r_{2, k}-1>1$, apply a similar argument of Lemma 6.4, we can find some $\theta \in(1,2)$ such that if $\sigma_{1, R}>0$,

On the other hand, by $\sigma_{\iota, R} \rightarrow 0$ as $R \rightarrow \infty$, we consider $R>0$ large enough such that

Case 1: $\sigma_{1, R}=0, \sigma_{2, R}=0$ In this case, we have that $\tau_{1, R} \equiv \tau_{2, R} \equiv 1, \forall R>0$. Remark that either $u_{1}=\omega_{2}=0$ or $u_{2}=\omega_{1}=0$. We only prove the case of $u_{1}=\omega_{2}=0$. By

& +\frac{1}{2}\left[\left\|\nabla u_{2}\right\|_{2}^{2}-\left\|u_{2}\right\|_{V_{2}}^{2}\right]-\int_{\mathbb{R}^{N}} G\left(0, u_{2}\right) d x \\
< & \frac{1}{2}\left[\left\|\nabla u_{2}\right\|_{2}^{2}-\left\|u_{2}\right\|_{V_{2}}^{2}\right]-\int_{\mathbb{R}^{N}} G\left(0, u_{2}\right) d x \\

\begin{equation*}
\int_{\mathbb{R}^{N}} u_{2} \omega_{2, R}^{q_{1}-1} d x \geq C_{\nu_{2}} e^{-\sqrt{\nu_{2}} R} \tag{C.5}
\end{equation*}
$$

In particular, we can take $\nu_{2}=\bar{\lambda}_{2}+\frac{\eta_{1}}{2} \in\left(\bar{\lambda}_{2}, \bar{\lambda}_{2}+\eta_{1}\right)$. Then one can see that

$$
\begin{equation*}
\sigma_{2, R}^{\theta}\left(\int_{\mathbb{R}^{N}} u_{2} \omega_{2, R}^{q_{1}-1} d x\right)^{-1} \rightarrow 0 \text { as } R \rightarrow \infty \tag{C.6}
\end{equation*}
$$

which implies that

$$
-\sum_{j=1}^{m} \nu_{j} \int_{\mathbb{R}^{N}} u_{2} \omega_{2, R}^{q_{j}-1} d x+o\left(\sigma_{2, R}^{\theta}\right)<0 \text { for large } R
$$

Hence, for $R$ large enough, by (C.3) we have that

J\left[\tau_{1, R}\left(u_{1}+\omega_{1, R}\right), \tau_{2, R}\left(u_{2}+\omega_{2, R}\right)\right]<J\left[u_{1}, u_{2}\right]+I\left[\omega_{1}, \omega_{2}\right] .

The assertion (C.2) also holds.
Case 3: $\sigma_{1, R}>0$ In this case, we have that

& \left.-\frac{\sigma_{\iota, R}}{a_{\iota}+b_{\iota}}\left[\left(\left\|\nabla u_{\iota}\right\|_{2}^{2}+\left\|\nabla \omega_{\iota}\right\|_{2}^{2}\right)-\left\|u_{\iota}\right\|_{V_{\iota}}^{2}\right]\right\}+o\left(\sigma_{1, R}^{\theta}\right) .

Then combining with Lemma 6.4, we can find some common $\theta \in(1,2)$ such that

\leq & \sum_{\iota=1}^{2}\left\{\frac{1}{2}\left[\left\|\nabla u_{\iota}\right\|_{2}^{2}+\left\|\nabla \omega_{\iota}\right\|_{2}^{2}-\left\|u_{\iota}\right\|_{V_{\iota}}^{2}\right]-\lambda_{\iota} \sigma_{\iota, R}+\int_{\mathbb{R}^{N}} \partial_{\iota} G\left(u_{1}, u_{2}\right) \omega_{\iota, R} d x\right. \\
& \left.-\frac{\sigma_{\iota, R}}{a_{\iota}+b_{\iota}}\left[\left(\left\|\nabla u_{\iota}\right\|_{2}^{2}+\left\|\nabla \omega_{\iota}\right\|_{2}^{2}\right)-\left\|u_{\iota}\right\|_{V_{\iota}}^{2}\right]\right\}+o\left(\sigma_{1, R}^{\theta}\right) \\
& -\sum_{i=1}^{\ell} \frac{\mu_{i}}{p_{i}}\left[\int_{\mathbb{R}^{N}} u_{1}^{p_{i}}+\omega_{1, R}^{p_{i}} d x\right]-\sum_{i=1}^{\ell} \mu_{i} \int_{\mathbb{R}^{N}}\left[u_{1}^{p_{i}-1} \omega_{1, R}+u_{1} \omega_{1, R}^{p_{i}-1}\right] d x \\

= & -\sum_{i=1}^{\ell} \mu_{i} \int_{\mathbb{R}^{N}} u_{1} \omega_{1, R}^{p_{i}-1} d x-\sum_{j=1}^{m} \nu_{j} \int_{\mathbb{R}^{N}} u_{2} \omega_{2, R}^{q_{j}-1} d x+o\left(\sigma_{1, R}^{\theta}\right), \tag{C.7}
\end{align*}
$$

here we use the fact $o\left(\sigma_{2, R}^{\theta}\right)=o\left(\sigma_{1, R}^{\theta}\right)$ due to Corollary 5.5. Then applying a similar argument as the Case 2, we can prove that

\sigma_{1, R}^{\theta}\left(\int_{\mathbb{R}^{N}} u_{1} \omega_{1, R}^{p_{1}-1} d x\right)^{-1} \rightarrow 0 \text { as } R \rightarrow \infty . \tag{C.8}

Hence, by (C.7) and (C.8), for $R>0$ large enough, we have that

J\left[\tau_{1, R}\left(u_{1}+\omega_{1, R}\right), \tau_{2, R}\left(u_{2}+\omega_{2, R}\right)\right]<J\left[u_{1}, u_{2}\right]+I\left[\omega_{1}, \omega_{2}\right]
$$

The assertion (C.2) also holds.
