# NO EXTREMAL SQUARE-FREE WORDS OVER LARGE ALPHABETS

#### Abstract

A word is square-free if it does not contain any square (a word of the form $X X$ ), and is extremal square-free if it cannot be extended to a new square-free word by inserting a single letter at any position. Grytczuk, Kordulewski, and Niewiadomski proved that there exist infinitely many ternary extremal square-free words. We establish that there are no extremal square-free words over any alphabet of size at least 17 .


## 1. Introduction

A word is a finite sequence of letters over a finite alphabet. A factor of a word is a subword of it consisting of consecutive letters. A square is a nonempty word of the form $X X$ (examples: couscous, "hotshots", "murmur"). A word is square-free if it does not contain a square as factor (examples: "abracadabra", "bonobo", "squares"; non-examples: "entente", "referee", "tartar"). It is easy to check that there are no binary squarefree words of length more than 3. Thue showed in 1906 [9] that there are arbitrarily long ternary square-free words (see [1]). His work is considered to be the beginning of research in combinatorics on words [2].

Recently, Grytczuk, Kordulewski, and Niewiadomski 5] introduced the study of extremal square-free words.

Definition 1.1. An extension of a finite word $W$ is a word $W^{\prime}=W_{1} x W_{2}$, where $x$ is a single letter and $W_{1}, W_{2}$ are (possibly empty) words such that $W=W_{1} W_{2}$. An extremal square-free word $W$ is a square-free word such that none of its extensions is square-free.

The only binary extremal square-free words are 010 and 101. Via a delicate construction, Grytczuk et al. showed in [5] that there exist infinitely many ternary extremal square-free words. They and Pawlik also raised several open problems concerning larger alphabet sizes ([5], [6]), including nonexistence of extremal square-free words over an alphabet of size 4. Mol and Rampersad [7] then classified all possible lengths of extremal ternary square-free words.

Conjecture 1.2 ([5], [7]). There exists no extremal square-free word over a finite alphabet of size at least 4 .

[^0]To the authors' knowledge, Conjecture 1.2 is open for any finite alphabet. Using ideas of Ter-Saakov and Zhang in [8] and some new observations, our main result confirms their conjecture for alphabet size at least 17 .

Theorem 1.3. For any integer $k \geq 17$, there exists no extremal square-free word over an alphabet of size $k$.

Grytczuk, Kordulewski, and Niewiadomski also introduced the notion of nonchalant words. The sequence of nonchalant words $G_{i}$ is generated recursively by the following greedy procedure: $G_{0}$ is the empty word, and $G_{i+1}=G_{i}^{\prime} x G_{i}^{\prime \prime}$ is a square-free extension of $G_{i}$, where $G=G_{i}^{\prime} G_{i}^{\prime \prime}$ with $G_{i}^{\prime \prime}$ being the shortest possible suffix of $G_{i}$ and $x$ being the earliest possible letter such that $G_{i+1}$ is square-free. Theorem 1.3 partially affirmatively answers Conjecture 14 and 15 in [5] for nonchalant words. More discussions can be found in [6].

Corollary 1.4. For any integer $k \geq 17$, the sequence of nonchalant words over a fixed alphabet of size $k$ converges to an infinite word.

## 2. Proof of Theorem 1.3

For a word $W$ of length $n$, we number the alphabets in $X$ from left to right as letter $1,2, \ldots, n$. We refer to the space between a letter $i$ and a letter $i+1$ as gap $i$, and call the first and last gap 0 and $n$. For $0<a<b \leq n+1$, we define the factor $W[a, b)$ as the subword of $W$ consisting of letters $a, a+1, \ldots, b-1$.

Definition 2.1. Let $W$ be any word. Denote $W+{ }_{b} c$ as the word formed by inserting the letter $c$ at gap $b$. For positive integers $a, b$ with $a \leq b+1$, positive integer $\ell$ and a letter $c$, we say the quadruple $(a, \ell, b, c)$ is square-completing in $W$ if the factor $\left(W+{ }_{b} c\right)[a, a+\ell)$ and the factor $\left(W+_{b} c\right)[a+\ell, a+2 \ell)$ of $W+{ }_{b} c$ are the same word.

Define the sign of the quadruple to be 1 if $b \leq a+\ell-2$, and -1 if $b \geq a+\ell-1$. The sign tells us if the alphabet we inserted at gap $b$ lies in the factor $\left(W+{ }_{b} c\right)[a, a+\ell)$ or $\left(W+{ }_{b} c\right)[a+\ell, a+2 \ell)$.

Proposition 2.2. Let $W$ be a square-free word, and suppose ( $a, \ell, b, c$ ) and $\left(a^{\prime}, \ell^{\prime}, b^{\prime}, c^{\prime}\right)$ are square-completing quadruples in $W$ with the same sign. Then one of the following holds:
(1) one of $a, b, \ell$ differs by at least $\frac{1}{5} L-2$ from the corresponding $a^{\prime}, b^{\prime}, \ell^{\prime}$, where $L=$ $\max \left(\ell, \ell^{\prime}\right)$;
(2) $b=b^{\prime}$ and $c=c^{\prime}$.

Furthermore, if $\ell=\ell^{\prime}$, then one of the following holds
(1) $\left|a-a^{\prime}\right| \geq L-1$;
(2) $b=b^{\prime}$ and $c=c^{\prime}$.

Proof. Suppose the contrary, and neither (1) or (2) are satisfied. Then we have $\ell, \ell^{\prime} \in$ $[4 L / 5, L]$. By symmetry, we can assume without loss of generality that $\ell \leq \ell^{\prime}$, and the sign of both quadruples is 1 , that is $b \leq a+\ell-2$ and $b^{\prime} \leq a^{\prime}+\ell^{\prime}-2$.

We argue by cases. In Case 1 we assume $\ell^{\prime}-\ell \geq 1$, and in Case 2 we handle the scenario $\ell^{\prime}=\ell=L$. Each case is split into two subcases.

Case 1.1. $M=\max \left(b, b^{\prime}\right) \leq a+\frac{3 L}{5}$. Then, consider the word $W\left[M+1, M+1+\ell^{\prime}-\ell\right)$. We know that the factor $\left(W+_{b} c\right)[a, a+\ell)$ and the factor $\left(W+{ }_{b} c\right)[a+\ell, a+2 \ell)$ of $W$ are the same word. As $M+1>b$, we have

$$
W\left[M+1, M+1+\ell^{\prime}-\ell\right)=\left(W+{ }_{b} c\right)\left[M+2, M+2+\ell^{\prime}-\ell\right)
$$

On the other hand, we have

$$
M+2+\ell^{\prime}-\ell \leq a+\frac{3 L}{5}+2+\frac{L}{5} \leq a+\ell
$$

Therefore, $\left(W+{ }_{b} c\right)\left[M+2, M+2+\ell^{\prime}-\ell\right)$ is a factor of $\left(W+{ }_{b} c\right)[a, a+\ell)$, so it is equal to the corresponding factor of $\left(W+{ }_{b} c\right)[a+\ell, a+2 \ell)$. More precisely,

$$
\left(W+{ }_{b} c\right)\left[M+2, M+2+\ell^{\prime}-\ell\right)=\left(W+_{b} c\right)\left[M+2+\ell, M+2+\ell^{\prime}\right) .
$$

Thus we have

$$
W\left[M+1, M+1+\ell^{\prime}-\ell\right)=W\left[M+1+\ell, M+1+\ell^{\prime}\right) .
$$

Similarly, since

$$
a^{\prime}<M+1, M+2+\ell^{\prime}-\ell \leq a+\frac{4 L}{5}+2 \leq a^{\prime}+L=a^{\prime}+\ell^{\prime}
$$

we have $\left(W+_{b} c\right)\left[M+2, M+2+\ell^{\prime}-\ell\right)$ is a factor of $\left(W+_{b} c\right)\left[a^{\prime}, a^{\prime}+\ell^{\prime}\right)$, so we conclude that

$$
\left(W+{ }_{b} c\right)\left[M+2, M+2+\ell^{\prime}-\ell\right)=\left(W+{ }_{b} c\right)\left[M+2+\ell^{\prime}, M+2+2 \ell^{\prime}-\ell\right) .
$$

Thus we have

$$
W\left[M+1, M+1+\ell^{\prime}-\ell\right)=W\left[M+1+\ell^{\prime}, M+1+2 \ell^{\prime}-\ell\right) .
$$

But then we have

$$
W\left[M+1+\ell, M+1+\ell^{\prime}\right)=W\left[M+1+\ell^{\prime}, M+1+2 \ell^{\prime}-\ell\right)
$$

and we have found a square in $W$, which is a contradiction.

Case 1.2. $M=\max \left(b, b^{\prime}\right)>a+\frac{3 L}{5}$. In this case, as $\left|b-b^{\prime}\right| \leq \frac{L}{5}-2$, we have $\min \left(b, b^{\prime}\right)>$ $a+\frac{2 L}{5}+2$, and therefore $\min \left(b, b^{\prime}\right)>\max \left(a, a^{\prime}\right)+\frac{L}{5}+4$. Let $A=\max \left(a, a^{\prime}\right)$. Then we note that

$$
A+\ell^{\prime}-\ell \leq A+\frac{L}{5}-2<\min \left(b, b^{\prime}\right)
$$

So we conclude that

$$
W\left[A, A+\ell^{\prime}-\ell\right)=\left(W+{ }_{b} c\right)\left[A, A+\ell^{\prime}-\ell\right)
$$

and

$$
W\left[A, A+\ell^{\prime}-\ell\right)=\left(W+{ }_{b^{\prime}} c^{\prime}\right)\left[A, A+\ell^{\prime}-\ell\right) .
$$

As $\min \left(b, b^{\prime}\right) \leq b<a+\ell$, we have $\left(W+{ }_{b} c\right)\left[A, A+\ell^{\prime}-\ell\right)$ is a factor of $\left(W+{ }_{b} c\right)[a, a+\ell)$. So we conclude that

$$
\left(W+{ }_{b} c\right)\left[A, A+\ell^{\prime}-\ell\right)=\left(W+{ }_{b} c\right)\left[A+\ell, A+\ell^{\prime}\right)=W\left[A+\ell-1, A+\ell^{\prime}-1\right) .
$$

Similarly, because $\left(W+b_{b^{\prime}} c^{\prime}\right)\left[A, A+\ell^{\prime}-\ell\right)$ is a factor of $\left(W+b_{b^{\prime}} c^{\prime}\right)\left[a, a^{\prime}+\ell^{\prime}\right)$, and

$$
A+\ell^{\prime}-1 \geq a^{\prime}+\ell^{\prime}-1 \geq b^{\prime}+1
$$

we conclude that

$$
\left(W+b_{b^{\prime}} c^{\prime}\right)\left[A, A+\ell^{\prime}-\ell\right)=\left(W+b_{b^{\prime}} c^{\prime}\right)\left[A+\ell^{\prime}, A+2 \ell^{\prime}-\ell\right)=W\left[A+\ell^{\prime}-1, A+2 \ell^{\prime}-\ell-1\right) .
$$

Then

$$
W\left[A+\ell-1, A+\ell^{\prime}-1\right)=W\left[A+\ell^{\prime}-1, A+2 \ell^{\prime}-\ell-1\right)
$$

and we have found a square in $W$, which is a contradiction.
Case 2.1. $b \neq b^{\prime}$. Without loss of generality, let $b<b^{\prime}$. Recall our assumption that $\left|a-a^{\prime}\right|<L-1$. We do additional case work on whether $b^{\prime} \geq a^{\prime}$ or $b^{\prime}=a^{\prime}-1$, i.e. whether the inserted character at $b^{\prime}$ is at the start of the square in $W+b_{b^{\prime}} c^{\prime}$ or not.

First we handle the case $b^{\prime} \geq a^{\prime}$. We first note that it is impossible for $b=a+L-2$, as if so then we have
$W[a, a+L-1)=\left(W+{ }_{b} c\right)[a, a+L-1)=\left(W+{ }_{b} c\right)[a+L, a+2 L-1)=W\left[a+L-1, a_{2} L-2\right)$ and we have found a square in $W$, which is a contradiction. Hence, we have

$$
b \leq a+L-3
$$

Furthermore, by assumption we have

$$
a^{\prime} \leq a+L-2
$$

Therefore, if we let $i=\max \left(a^{\prime}, b+1\right)$, then by assumption we have $i+1 \leq a+L-1$, so

$$
W[i, i+1)=\left(W+{ }_{b} c\right)[i+1, i+2)=\left(W+_{b} c\right)[i+1+L, i+2+L)=W[i+L, i+1+L) .
$$

On the other hand, as $i \leq b^{\prime}$, we have

$$
W[i, i+1)=\left(W+{b^{\prime}}^{\prime}\right)[i, i+1)=\left(W++_{b^{\prime}} c^{\prime}\right)[i+L, i+1+L)=W[i-1+L, i+L) .
$$

Thus we conclude that

$$
W[i+L, i+1+L)=W[i-1+L, i+L) .
$$

So we have found a square in $L$, which is a contradiction.
Then we handle the case $b^{\prime}=a^{\prime}-1$. In this case, we have

$$
c^{\prime}=\left(W+_{b^{\prime}} c^{\prime}\right)\left[a^{\prime}, a^{\prime}+1\right)=\left(W+_{b^{\prime}} c^{\prime}\right)\left[a^{\prime}+L, a^{\prime}+L+1\right)=W\left[a^{\prime}+L-1, a^{\prime}+L\right) .
$$

Note that as $b^{\prime}>b$, we have $a^{\prime}+L-1>b$, so

$$
c^{\prime}=W\left[a^{\prime}+L-1, a^{\prime}+L\right)=\left(W+{ }_{b} c\right)\left[a^{\prime}+L, a^{\prime}+L+1\right) .
$$

As $a^{\prime}+L>b+L+1 \geq a+L$, and $a^{\prime}+L \leq a+2 L-1$, we find that $\left(W+{ }_{b} c\right)\left[a^{\prime}+L, a^{\prime}+L+1\right)$ is a letter in $\left(W+{ }_{b} c\right)[a+L, a+2 L-1)$. Therefore,

$$
c^{\prime}=\left(W+{ }_{b} c\right)\left[a^{\prime}+L, a^{\prime}+L+1\right)=\left(W+_{b} c\right)\left[a^{\prime}, a^{\prime}+1\right) .
$$

Since $a^{\prime}=b^{\prime}+1 \geq b+2$, we get

$$
c^{\prime}=\left(W+{ }_{b} c\right)\left[a^{\prime}, a^{\prime}+1\right)=W\left[a^{\prime}-1, a^{\prime}\right) .
$$

However, this implies that
$W\left[a^{\prime}-1, a^{\prime}+L-1\right)=\left(W+_{b^{\prime}} c^{\prime}\right)\left[a^{\prime}, a^{\prime}+L\right)=\left(W+_{b^{\prime}} c^{\prime}\right)\left[a^{\prime}+L, a^{\prime}+2 L\right)=W\left[a^{\prime}+L-1, a^{\prime}+2 L-1\right)$, so we have found a square in $W$, which is a contradiction.

Case 2.2. $b=b^{\prime}$. We know $\left(W+_{b} c\right)[b+1, b+2)=c$ and $\left(W+_{b} c\right)[a, a+L)=\left(W+_{b} c\right)[a+$ $L, a+2 L)$, so $\left(W+{ }_{b} c\right)[b+1+L, b+2+L)=c$. This implies

$$
W[b+L, b+1+L)=c .
$$

The exact same logic also gives $W[b+L, b+1+L)=c^{\prime}$. So $c=c^{\prime}$, which is a contradiction.
Corollary 2.3. Let $W$ be an $n$-letter square-free word $W$. Let $\mathcal{A}$ be a set of square-completing quadruples $(a, \ell, b, c)$ such that no two elements of $\mathcal{A}$ share the same $(b, c)$. For each $L \geq 2$, define

$$
\mathcal{A}_{L}=\mathcal{A} \cap\{(a, L, b, c): a, b \in \mathbb{Z}, c \text { any letter }\} .
$$

Then for any $L \geq 2$, we have

$$
\left|\mathcal{A}_{L}\right| \leq \frac{2 n}{L-1}
$$

Furthermore, for any $L \geq 300$, we have

$$
\sum_{\ell=L}^{2 L-1}\left|\mathcal{A}_{\ell}\right| \leq \frac{320 n}{L}
$$

Proof. To prove the first proposition for $L \geq 2$, note that for a given $\operatorname{sign} \epsilon \in\{-1,1\}$, and any two quadruples $(a, L, b, c)$ and $\left(a^{\prime}, L, b^{\prime}, c^{\prime}\right)$ in $\mathcal{A}_{L}$ with $\operatorname{sign} \epsilon$, by Proposition 2.2 we must
have $\left|a-a^{\prime}\right| \geq L-1$. Thus over all quadruples in $\mathcal{A}_{L}$ with sign $\epsilon$, the $a$ 's must be spaced at least $L$ apart, and must be in the range $[1, n-2 L+2]$. Therefore, there are at most

$$
\frac{n-2 L+2}{L-1}+1 \leq \frac{n}{L-1}
$$

such quadruples. Given there are two possible signs, the total number of quadruples is at most $\frac{2 n}{L-1}$.

To prove the second statement, we can divide the range $[1, n-2 L+2]$ into at most

$$
\frac{n-2 L+2}{L / 6}+1 \leq \frac{6 n}{L}
$$

intervals of length $\frac{L}{6}$. For each such interval $I=\left[x, x+\frac{L}{6}\right)$, define

$$
\mathcal{B}_{I}=\{(a, \ell, b, c):(a, \ell, b, c) \in \mathcal{A}, \ell \in[L, 7 L / 6), a \in I,(a, \ell, b, c) \text { has sign } 1\}
$$

Assume $(a, \ell, b, c)$ and $\left(a^{\prime}, \ell^{\prime}, b^{\prime}, c^{\prime}\right)$ are two distinct quadruples in $\mathcal{B}_{I}$. Note that

$$
\left|\ell-\ell^{\prime}\right| \leq \frac{L}{6}<\frac{L}{5}-2
$$

and

$$
\left|a-a^{\prime}\right| \leq \frac{L}{6}<\frac{L}{5}-2
$$

Thus by Proposition [2.2, we must have $b, b^{\prime}$ spaced at least $L / 5-2$ apart. Furthermore, for each quadruple $(a, \ell, b, c)$ in $\mathcal{B}_{I}$, the $b$ 's are restricted to the interval $\left[x-1, x+\left\lfloor\frac{4 L}{3}\right\rfloor\right)$ due to the quadruples having sign 1 . Thus the size of $\mathcal{B}_{I}$ is upper bounded by

$$
\frac{\left\lfloor\frac{4 L}{3}\right\rfloor+1}{\frac{L}{5}-2}+1
$$

For $L \geq 300$, we can verify that

$$
\frac{\left\lfloor\frac{4 L}{3}\right\rfloor+1}{\frac{L}{5}-2}+1<8
$$

which implies

$$
\left|\mathcal{B}_{I}\right| \leq 7
$$

Symmetrically, if we let

$$
\mathcal{C}_{I}=\{(a, \ell, b, c):(a, \ell, b, c) \in \mathcal{A}, \ell \in[L, 7 L / 6), a \in I,(a, \ell, b, c) \text { has sign - } 1\}
$$

then

$$
\left|\mathcal{C}_{I}\right| \leq 7 .
$$

Summing over all the intervals, we conclude that

$$
\sum_{L \leq \ell<7 L / 6}\left|\mathcal{A}_{\ell}\right|=\sum_{I}\left(\left|\mathcal{B}_{I}\right|+\left|\mathcal{C}_{I}\right|\right) \leq 14 \cdot \frac{6 n}{L}
$$

Analogously, we have for any non-negative integer $i$.

$$
\sum_{(7 / 6)^{i} L \leq \ell<(7 / 6)^{i+1} L}\left|\mathcal{A}_{\ell}\right| \leq \frac{7 \cdot 2 \cdot 6 n}{(7 / 6)^{i} L}
$$

Summing over $i \in\{0,1,2,3,4\}$, we obtain that

$$
\sum_{L \leq \ell<2 L}\left|\mathcal{A}_{\ell}\right| \leq \frac{320 n}{L}
$$

as desired.

Proof of Theorem 1.3. Let $W$ be any extremal square-free word on an alphabet of size $k$. Then for any gap $0 \leq b \leq n+1$ and any letter $c$ not equal to the two letters adjacent to gap $b$, there exists some $a$ and $\ell \geq 2$ such that $(a, \ell, b, c)$ is a square-completing quadruple in $W$. Let $\mathcal{A}$ be the set consisting of one such quadruple for each choice of $(b, c)$. On one hand, by construction we have

$$
|\mathcal{A}| \geq(k-2)(n+1)
$$

On the other hand, by Corollary 2.3, we have,

$$
\begin{aligned}
|\mathcal{A}| & =\sum_{\ell=2}^{\infty}\left|\mathcal{A}_{\ell}\right| \\
& =\sum_{\ell=2}^{319}\left|\mathcal{A}_{\ell}\right|+\sum_{j=0}^{\infty} \sum_{\ell \in\left[32 \cdot \cdot 2^{j}, 320 \cdot 2^{j+1}\right)}\left|\mathcal{A}_{\ell}\right| \\
& \leq \sum_{\ell=2}^{319} \frac{2 n}{\ell-1}+\sum_{j=0}^{\infty} \frac{320 n}{320 \cdot 2^{j}}<14.7 n .
\end{aligned}
$$

Thus we conclude that $k<17$, as desired.

Proof of Corollary 1.4. We have shown that the number of square-completing quadruples $(a, \ell, b, c)$ such that no two elements share the same $(b, c)$ in a square-free word $W$ of length $n$ is less than $14.7 n$. Thus, the number of ways to insert an alphabet into $W$ such that the result is no longer square-free is less than $16.7 n$. Therefore, if the alphabet size is at least 17 , then it is possible to insert a letter into the latter $\frac{16.7}{17}$ of any square-free word $W$ such that the result is square-free. So the prefix of $G_{i}$ will stabilize and the sequence converges to an infinite limit word.
