Inner automorphisms of presheaves of groups


Abstract

It has been proven by Schupp and Bergman that the inner automorphisms of groups can be characterized purely *categorically* as those group automorphisms that can be coherently extended along any outgoing homomorphism. One is thus motivated to define a notion of *(categorical) inner automorphism* in an arbitrary category, as an automorphism that can be coherently extended along any outgoing morphism, and the theory of such automorphisms forms part of the theory of *covariant isotropy*. In this paper, we prove that the categorical inner automorphisms in any category $\mathsf{Group}^{\mathcal{J}}$ of presheaves of groups can be characterized in terms of conjugation-theoretic inner automorphisms of the category \mathcal{J} . In fact, we deduce such a characterization from a much more general result characterizing the categorical inner automorphisms in any category \mathbb{T} .

1. Introduction

An automorphism $\alpha : G \xrightarrow{\sim} G$ of a group G is said to be *inner* if there is some element $s \in G$ with respect to which α is defined by conjugation, in the sense that $\alpha(g) = sgs^{-1}$ for any $g \in G$. In [1, Theorem 1], George Bergman proved that these inner automorphisms can be characterized purely *categorically*, without reference to group elements or conjugation, as the automorphisms that can be *coherently extended* along any morphisms out of their domains.¹ More precisely, he showed that an automorphism $\alpha : G \xrightarrow{\sim} G$ is inner if and only if one can define a group automorphism $\alpha_f : H \xrightarrow{\sim} H$ of the codomain of any group homomorphism $f : G \to H$ out of G in such a way that $\alpha_{id_G} = \alpha$ and the resulting family of automorphisms $(\alpha_f)_f$ is *coherent*. The latter condition means that if $f : G \to H$ and $f' : H \to K$ are any composable group homomorphisms out of G, then the following square must commute:



Such a family of automorphisms $(\alpha_f)_f$ is just a natural automorphism of the projection functor $G/\text{Group} \to \text{Group}$, which sends a morphism $f: G \to H$ to its codomain H. We refer to such a family of automorphisms as an *extended inner automorphism* of G. Bergman's result can therefore be restated as saying that a group automorphism $\alpha: G \xrightarrow{\sim} G$ is inner iff there is an extended inner automorphism $(\alpha_f)_f \in \mathcal{Z}(G)$ with $\alpha_{\text{id}_G} = \alpha$. These extended inner automorphisms form a group $\mathcal{Z}(G)$, which we call the *covariant isotropy group* of G.

We can now generalize these ideas from the category Group to an arbitrary category. For any category \mathbb{C} , one can define its *covariant isotropy group (functor)* $\mathcal{Z}_{\mathbb{C}} : \mathbb{C} \to \text{Group}$, which sends any object $C \in ob\mathbb{C}$ to the group of natural automorphisms of the projection functor $C/\mathbb{C} \to \mathbb{C}$. More concretely, if we define $\text{Dom}(C) := \{f \in \text{mor}(\mathbb{C}) : \text{dom}(f) = C\}$, then an element $\pi \in \mathcal{Z}_{\mathbb{C}}(C)$ is a Dom(C)-indexed family of automorphisms

$$\pi = \left(\pi_f : \operatorname{cod}(f) \xrightarrow{\sim} \operatorname{cod}(f)\right)_{f \in \operatorname{Dom}(C)}$$

with the property that if $f: C \to C'$ and $f': C' \to C''$ are any composable morphisms out of C, then $\pi_{f'\circ f} \circ f' = f' \circ \pi_f$ as in the commutative square above. Intuitively, an element $\pi \in \mathcal{Z}_{\mathbb{C}}(C)$ provides an automorphism $\pi_{id_{\mathcal{C}}}: C \xrightarrow{\sim} C$ that can be coherently or functorially *extended* along any morphism out of C. The covariant isotropy group of a category \mathbb{C} can therefore be regarded as encoding a notion of *inner* automorphism or conjugation for \mathbb{C} , abstracting from the initial case of $\mathbb{C} = \text{Group}$. Motivated by the considerations above, we may then refer to the elements of $\mathcal{Z}_{\mathbb{C}}(C)$ as the *extended inner automorphisms* of $C \in ob(\mathbb{C})$, while a (categorical) inner automorphism of C is an automorphism $f: C \xrightarrow{\sim} C$ for which there is some extended inner automorphism $\pi \in \mathcal{Z}_{\mathbb{C}}(C)$ with $\pi_{id_{\mathcal{C}}} = f$, i.e. a (categorical) inner automorphism is an automorphism that can be coherently extended along any outgoing morphism.²

In [3] and [4], the present author and his collaborators studied the covariant isotropy group of the category \mathbb{T} mod of models of any finitary quasi-equational theory \mathbb{T} in the sense of [5].³ We showed therein that the covariant isotropy group of a model M of a finitary quasi-equational theory \mathbb{T} can be logically or syntactically described in terms of the sort-indexed families in $\prod_C M \langle \mathsf{x}_C \rangle$ that are substitutionally invertible and commute generically with the operations of \mathbb{T} , where $M \langle \mathsf{x}_C \rangle$ is the \mathbb{T} -model obtained from M by freely adjoining a new element x_C of sort C. Using this logical or syntactic characterization of the covariant isotropy group of \mathbb{T} mod, we then provided explicit characterizations of the (extended) inner automorphisms in many prominent categories of mathematical interest, including the categories of (abelian) groups, (commutative) monoids, (commutative) rings with unit, lattices, racks and quandles (see also [6]), and strict monoidal categories.

In [4, 5.2] the authors also proved an explicit characterization of the covariant isotropy group of any presheaf category $\mathsf{Set}^{\mathcal{J}}$ on a small category \mathcal{J} , and showed that it is the constant functor $\mathsf{Set}^{\mathcal{J}} \to \mathsf{Group}$ with value $\mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})$, the group of natural automorphisms of the identity functor on \mathcal{J} . It is trivial to see that Set is the category of models of a finitary quasi-equational theory, namely the single-sorted theory with no operations and no axioms. It is the primary purpose of the present paper to extend the characterization of covariant isotropy for presheaf categories $\mathsf{Set}^{\mathcal{J}}$ to categories of the form $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$ for arbitrary quasiequational theories $\mathbb{T}^{.4}$ In other words, we will explicitly characterize the (extended) inner automorphisms in such functor categories $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$, and it will turn out that the (extended) inner automorphisms of a functor $F: \mathcal{J} \to \mathbb{T}\mathsf{mod}$ can be described in terms of the automorphism group $\mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})$ and the (extended) inner automorphisms of the component \mathbb{T} -models $F(i) \in \mathbb{T}\mathsf{mod}$ (for $i \in \mathsf{ob}\mathcal{J}$). From this general characterization, we will then extract an explicit characterization of the (extended) inner automorphisms in any category $\mathsf{Group}^{\mathcal{J}}$ of presheaves of groups. In particular, we will show that the (categorical) inner automorphisms of any functor $F: \mathcal{J} \to \mathsf{Group}$ can be characterized in terms of the automorphism group $\mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})$ and the conjugation-theoretic inner automorphisms of the component groups $F(i) \in \mathsf{Group}$.

We now provide a brief overview of the paper. In Section 2 we first review some background material from [5] on quasi-equational theories and their models, and we conclude by recalling the characterization of covariant isotropy for the categories of models of such theories that was proven in [4]. We then proceed in Section 3 to show that if \mathbb{T} is a quasi-equational theory and \mathcal{J} a small category, then the functor category $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$ can be axiomatized as the category of models of a quasi-equational theory $\mathbb{T}^{\mathcal{J}}$, and we then prove an explicit *logical* characterization of the covariant isotropy group of $\mathbb{T}^{\mathcal{J}}\mathsf{mod} \cong \mathbb{T}\mathsf{mod}^{\mathcal{J}}$. In Section 4 we deduce from these results a *categorical* characterization of the covariant isotropy group of $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$, and hence of the (extended) inner automorphisms of functors $\mathcal{J} \to \mathbb{T}\mathsf{mod}$. In the final Section 5, we deduce some important

special cases of our main results, and conclude by providing an explicit characterization of the (extended) inner automorphisms in any category $\mathsf{Group}^{\mathcal{J}}$ of presheaves of groups.

The content in this paper (especially from Section 3 onward) is largely based on the final chapter of the author's recent PhD thesis [7]; in the interest of brevity, we have therefore chosen to refer the reader to this source for many of the (technical) proofs.

2. Covariant isotropy of locally finitely presentable categories

In this section, we review the techniques developed in [4, 7] for computing the covariant isotropy group of the category of models of any finitary quasi-equational theory, equivalently the covariant isotropy group of any locally finitely presentable category. The initial material in this section borrows heavily from [5].

Definition 2.1. A (first-order) signature Σ is a pair of sets $\Sigma = (\Sigma_{\mathsf{Sort}}, \Sigma_{\mathsf{Fun}})$ such that Σ_{Sort} is the set of sorts and Σ_{Fun} is the set of function/operation symbols. Each element $f \in \Sigma_{\mathsf{Fun}}$ comes equipped with a pair $((A_1, \ldots, A_n), A)$, where $n \ge 0$ is a natural number and A, A_i are sorts for all $1 \le i \le n$, which we write as $f : A_1 \times \ldots \times A_n \to A$. In case n = 0, we write f : A.

Definition 2.2. Let Σ be a signature. For every sort $A \in \Sigma_{Sort}$, we assume that we have a countable set V_A of variables of sort A. We now define the set $\mathsf{Term}(\Sigma)$ of *terms* of Σ recursively as follows, while simultaneously defining the *sort* and the set $\mathsf{FV}(t)$ of *free variables* of a term $t \in \mathsf{Term}(\Sigma)$:

- If $A \in \Sigma_{\mathsf{Sort}}$ and $x \in V_A$, then $x \in \mathsf{Term}(\Sigma)$ is of sort A with $\mathsf{FV}(x) := \{x\}$.
- If $f: A_1 \times \ldots \times A_n \to A$ is a function symbol of Σ and $t_i \in \mathsf{Term}(\Sigma)$ with $t_i: A_i$ for each $1 \le i \le n$, then $f(t_1, \ldots, t_n) \in \mathsf{Term}(\Sigma)$ is of sort A, and $\mathsf{FV}(f(t_1, \ldots, t_n)) := \bigcup_{1 \le i \le n} \mathsf{FV}(t_i)$. In particular, if c is a constant symbol of sort A, then c is a term of sort A with $\mathsf{FV}(c) = \emptyset$.

If $t \in \text{Term}(\Sigma)$ and $\text{FV}(t) = \emptyset$, then we call t a *closed* term. If $t \in \text{Term}(\Sigma)$, then we write $t(\vec{x})$ to mean that $\text{FV}(t) \subseteq \vec{x}$.

Definition 2.3. Let Σ be a signature. We define the class $\mathsf{Horn}(\Sigma)$ of *Horn formulas* over Σ recursively as follows, while simultaneously defining the set $\mathsf{FV}(\varphi)$ of *free variables* of a formula $\varphi \in \mathsf{Horn}(\Sigma)$:

- If $t_1, t_2 \in \text{Term}(\Sigma)$ are terms of the same sort, then $t_1 = t_2 \in \text{Horn}(\Sigma)$, and $FV(t_1 = t_2) := FV(t_1) \cup FV(t_2)$.
- $\top \in \text{Horn}(\Sigma)$ (the empty conjunction), and $\mathsf{FV}(\top) := \emptyset$.
- If $\varphi_1, \varphi_2 \in \mathsf{Horn}(\Sigma)$, then $\varphi_1 \land \varphi_2 \in \mathsf{Horn}(\Sigma)$, and $\mathsf{FV}(\varphi_1 \land \varphi_2) := \mathsf{FV}(\varphi_1) \cup \mathsf{FV}(\varphi_2)$.

If $\varphi \in \text{Horn}(\Sigma)$ and $FV(\varphi) = \emptyset$, then we will refer to φ as a (Horn) sentence. If $\varphi \in \text{Horn}(\Sigma)$, then we will write $\varphi(\vec{x})$ to mean that $FV(\varphi) \subseteq \vec{x}$.

Definition 2.4. Let Σ be a signature. A *Horn sequent* over Σ is an expression of the form $\varphi \vdash^{\vec{x}} \psi$, where $\varphi, \psi \in \mathsf{Horn}(\Sigma)$ and $\mathsf{FV}(\varphi), \mathsf{FV}(\psi) \subseteq \vec{x}$ with \vec{x} finite. A *quasi-equational theory* \mathbb{T} is a set of Horn sequents over a signature Σ .

One can now set up a deduction system of *partial Horn logic* for quasi-equational theories, wherein certain Horn sequents are designated as logical axioms, and there are logical inference rules allowing one to deduce certain Horn sequents from other Horn sequents. We refer the reader to [5] for a list of all the specific logical axioms and inference rules of partial Horn logic. The main distinguishing feature of this deduction system is that equality of terms is *not* assumed to be reflexive, i.e. if $t(\vec{x})$ is a term over a given signature, then $\top \vdash^{\vec{x}} t(\vec{x}) = t(\vec{x})$ is *not* a logical axiom of partial Horn logic, unless t is a variable. In other words, if we abbreviate the equation t = t by $t \downarrow$ (read: t is defined), then unless t is a variable, the sequent $\top \vdash^{\vec{x}} t \downarrow$ is *not* a logical axiom of partial Horn logic. If \mathbb{T} is a quasi-equational theory over a signature Σ and $\varphi \vdash^{\vec{x}} \psi$ is a Horn sequent over Σ , then we say that the sequent $\varphi \vdash^{\vec{x}} \psi$ is *provable* in \mathbb{T} if there is a finite sequence of Horn sequents whose last member is $\varphi \vdash^{\vec{x}} \psi$, and each member of the sequence is either a logical axiom of partial Horn logic, an axiom of \mathbb{T} , or is obtained from previous elements of the sequence by an inference rule of partial Horn logic. We also say that \mathbb{T} proves the sequent $\varphi \vdash^{\vec{x}} \psi$, or that this sequent is a *theorem* of \mathbb{T} . If \mathbb{T} proves a Horn sequent of the form $\top \vdash^{\vec{x}} \varphi$.

We now review the set-theoretic semantics of partial Horn logic. We recall that if A and B are any sets, then a *partial function* $f : A \to B$ is a total function $f : \mathsf{dom}(f) \to B$ with $\mathsf{dom}(f) \subseteq A$.

Definition 2.5. Let Σ be a signature. A (set-based) partial Σ -structure M is given by a set M_A for each $A \in \Sigma_{\mathsf{Sort}}$ and a partial function $f^M : M_{A_1} \times \ldots \times M_{A_n} \to M_A$ for each function symbol $f : A_1 \times \ldots \times A_n \to A$ of Σ_{Fun} .

Definition 2.6. Let Σ be a signature, and let M and N be partial Σ -structures. A Σ -morphism $h: M \to N$ is a Σ_{Sort} -indexed sequence of total functions $h = (h_A: M_A \to N_A)_{A \in \Sigma_{\mathsf{Sort}}}$ such that for any function symbol $f: A_1 \times \ldots \times A_n \to A$ in Σ_{Fun} and any $(m_i)_i \in \prod_{1 \le i \le n} M_{A_i}$, if $(m_i)_i \in \mathsf{dom}(f^M)$, then $(h_{A_i}(m_i))_i \in \mathsf{dom}(f^N)$ and $h_A(f^M(m_1, \ldots, m_n)) = f^N(h_{A_1}(m_1), \ldots, h_{A_n}(m_n)) \in N_A$.

It is easy to verify that the (componentwise) composition of Σ -morphisms is a Σ -morphism, and that the sequence of identity functions $(id_A : M_A \to M_A)_A$ is a Σ -morphism $id_M : M \to M$ that is an identity for composition. So we can form the category P Σ Str of partial Σ -structures and Σ -morphisms.

Before we can define the notion of a (set-based) model of a quasi-equational theory, we must first define the interpretations of terms and Horn formulas in partial structures.

Definition 2.7. Let Σ be a signature. Let $t(x_1, \ldots, x_k) : A$ be an element of $\mathsf{Term}(\Sigma)$ with free variables among $x_i : A_i$ for $1 \leq i \leq k$. Let M be a partial Σ -structure. We define the *partial* function $t(x_1, \ldots, x_k)^M : \prod_{1 \leq i \leq k} M_{A_i} \to M_A$ by induction on the structure of t:

- If $t \equiv x_i : A_i$ for some $1 \leq i \leq k$, then we set $t^M := \pi_i : \prod_{1 \leq i \leq k} M_{A_i} \to M_{A_i}$, the (total) projection onto the *i*th factor.
- If $t \equiv f(t_1, \ldots, t_m) : B$ for some function symbol $f : B_1 \times \ldots \times B_m \to B$ of Σ with $t_j(x_1, \ldots, x_k) \in \text{Term}(\Sigma)$ and $t_j : B_j$ for each $1 \leq j \leq m$, we first set

$$\operatorname{dom}\left(t^{M}\right):=\left\{\vec{a}\in\bigcap_{1\leq j\leq m}\operatorname{dom}\left(t_{j}^{M}\right):\left(t_{j}^{M}(\vec{a})\right)_{j}\in\operatorname{dom}\left(f^{M}\right)\right\}$$

and for any $\vec{a} \in \mathsf{dom}(t^M)$ we set $t^M(\vec{a}) := f^M(t_1^M(\vec{a}), \ldots, t_m^M(\vec{a})) \in M_B$, which defines $t^M = f(t_1, \ldots, t_m)^M : \prod_{1 \le i \le k} M_{A_i} \to M_B$.

Definition 2.8. Let Σ be a signature, and let $\varphi(x_1, \ldots, x_k)$ be a Horn formula over Σ with free variables among $x_i : A_i$ for $1 \le i \le k$. Let M be a partial Σ -structure. We define $\varphi(x_1, \ldots, x_k)^M \subseteq \prod_{1 \le i \le k} M_{A_i}$ by induction on the structure of φ :

• If $\varphi \equiv t_1 = t_2$ for some terms t_1, t_2 of the same sort, then

$$\varphi^{M} = (t_{1} = t_{2})^{M} := \left\{ \vec{a} \in \operatorname{dom}\left(t_{1}^{M}\right) \cap \operatorname{dom}\left(t_{2}^{M}\right) : t_{1}^{M}(\vec{a}) = t_{2}^{M}(\vec{a}) \right\}.$$

- If $\varphi \equiv \top$, then $\top^M := \prod_{1 \leq i \leq k} M_{A_i}$.
- If $\varphi \equiv \varphi_1 \land \varphi_2$ for some $\varphi_1, \varphi_2 \in \mathsf{Horn}(\Sigma)$, then $(\varphi_1 \land \varphi_2)^M := \varphi_1^M \cap \varphi_2^M \subseteq \prod_{1 \le i \le k} M_{A_i}$.

Definition 2.9. Let Σ be a signature, let M be a partial Σ -structure, and let $\varphi(\vec{x}), \psi(\vec{x})$ be Horn formulas over Σ . Then M models or satisfies the Horn sequent $\varphi \vdash^{\vec{x}} \psi$ if $\varphi(\vec{x})^M \subseteq \psi(\vec{x})^M$.

Let \mathbb{T} be a quasi-equational theory over a signature Σ , and let M be a partial Σ -structure. Then M is a *model* of \mathbb{T} if M satisfies every axiom of \mathbb{T} .

For a quasi-equational theory \mathbb{T} over a signature Σ , we now let \mathbb{T} mod be the full subcategory of $\mathsf{P}\Sigma\mathsf{Str}$ on the models of \mathbb{T} .

In order to sketch the details of the Initial Model Theorem for quasi-equational theories (see [5, Theorem 22]), we first require the following definitions.

Definition 2.10. Let Σ be a signature and M a partial Σ -structure. For every sort A, let \sim_A be an equivalence relation on M_A . Then the Σ_{Sort} -indexed family of equivalence relations $(\sim_A)_A$ is a partial congruence on M if for every function symbol $f: A_1 \times \ldots \times A_n \to A$ in Σ_{Fun} and all $\vec{a}, \vec{b} \in \prod_{1 \leq i \leq n} M_{A_i}$, if $a_i \sim_{A_i} b_i$ for all $1 \leq i \leq n$, then $\vec{a} \in \mathsf{dom}(f^M)$ iff $\vec{b} \in \mathsf{dom}(f^M)$ and $\vec{a}, \vec{b} \in \mathsf{dom}(f^M) \Longrightarrow f^M(\vec{a}) \sim_A f^M(\vec{b})$.

We now have the following definition:

Definition 2.11. Let Σ be a signature and M a partial Σ -structure. Let $\sim = (\sim_A)_A$ be a partial congruence on M. We define the *partial quotient* Σ -structure M/\sim as follows:

- For every sort $A \in \Sigma$, we set $(M/\sim)_A := M_A/\sim_A$, the set of equivalence classes of M_A modulo the equivalence relation \sim_A .
- For any function symbol $f: A_1 \times \ldots \times A_n \to A$ we set

$$\operatorname{dom}\left(f^{M/\sim}\right) := \left\{ \left([a_i]\right)_i \in \prod_{1 \le i \le n} M_{A_i}/\sim_{A_i} : (a_i)_i \in \operatorname{dom}\left(f^M\right) \right\}.$$

Then for any $([a_i])_i \in \mathsf{dom}\left(f^{M/\sim}\right)$, we set $f^{M/\sim}\left([a_1],\ldots,[a_n]\right) := [f^M(a_1,\ldots,a_n)].$

Because ~ is a partial congruence on M, it easily follows that M/\sim is a well-defined partial Σ -structure.

We now sketch the details of the Initial Model Theorem from [5] that we will need for our purposes. First, given a quasi-equational theory \mathbb{T} over a signature Σ , we define a specific partial Σ -structure $M^{\mathbb{T}}$.

Definition 2.12. Let Σ be a signature. First, let $\mathsf{Term}^c(\Sigma) := \{t \in \mathsf{Term}(\Sigma) : \mathsf{FV}(t) = \emptyset\}$ be the set of *closed terms* of $\mathsf{Term}(\Sigma)$. For any $A \in \Sigma_{\mathsf{Sort}}$, let

$$\operatorname{\mathsf{Term}}^c(\Sigma)_A := \{t \in \operatorname{\mathsf{Term}}^c(\Sigma) : t \text{ is of sort } A\}$$

be the set of closed Σ -terms of sort A.

Now let \mathbb{T} be a quasi-equational theory over Σ . We define a partial Σ -structure $M^{\mathbb{T}}$ as follows:

- For any sort $A \in \Sigma$, we set $M_A^{\mathbb{T}} := \{t \in \mathsf{Term}^c(\Sigma)_A : \mathbb{T} \vdash t \downarrow\}.$
- For any function symbol $f: A_1 \times \ldots \times A_n \to A$ of Σ , we set

$$\operatorname{dom}\left(f^{M^{\mathbb{T}}}\right) := \left\{ \vec{t} \in \prod_{1 \leq i \leq n} M_{A_{i}}^{\mathbb{T}} : \mathbb{T} \vdash f\left(\vec{t}\right) \downarrow \right\},\$$

and if $\vec{t} \in \mathsf{dom}\left(f^{M^{\mathbb{T}}}\right)$, we set $f^{M^{\mathbb{T}}}\left(\vec{t}\right) := f\left(\vec{t}\right) \in M_{A}^{\mathbb{T}}$.

Now we define a partial congruence $\sim^{\mathbb{T}}$ on $M^{\mathbb{T}}$. For any sort $A \in \Sigma$, we set

$$\sim_A^{\mathbb{T}} := \left\{ (t_1, t_2) \in M_A^{\mathbb{T}} \times M_A^{\mathbb{T}} : \mathbb{T} \vdash t_1 = t_2 \right\}.$$

Using the rules of partial Horn logic, it is then straightforward to verify that $\sim^{\mathbb{T}}$ is in fact a partial congruence on $M^{\mathbb{T}}$. We now make the following definition:

Definition 2.13. Let \mathbb{T} be a quasi-equational theory over a signature Σ , and let $M^{\mathbb{T}}$ be the partial Σ -structure and $\sim^{\mathbb{T}}$ the partial congruence on $M^{\mathbb{T}}$ just defined. Applying Definition 2.11, we then define the following partial Σ -structure: $\mathsf{Free}(\mathbb{T}) := M^{\mathbb{T}}/\sim^{\mathbb{T}}$.

The following theorem is then proven in [5, Theorem 22]:

Theorem 2.14. Let \mathbb{T} be a quasi-equational theory over a signature Σ . Then the partial Σ -structure $\mathsf{Free}(\mathbb{T})$ is an *initial model* of \mathbb{T} , *i.e.* an *initial object of the category* $\mathbb{T}\mathsf{mod}$.

Remark 2.15. For concreteness, we give the explicit description of $Free(\mathbb{T})$ for a quasi-equational theory \mathbb{T} over a signature Σ .

• For any sort $A \in \Sigma$, we have

$$\operatorname{Free}(\mathbb{T})_A := M_A^{\mathbb{T}} / \sim_A^{\mathbb{T}} = \{ [t] : t \in \operatorname{Term}^c(\Sigma)_A \text{ and } \mathbb{T} \vdash t \downarrow \},\$$

where [t] is the $\sim_A^{\mathbb{T}}$ -congruence class of $t \in M_A^{\mathbb{T}}$ (so for any $s, t \in M_A^{\mathbb{T}}$, we have [s] = [t] iff $\mathbb{T} \vdash s = t$).

• If $f: A_1 \times \ldots \times A_n \to A$ is a function symbol of Σ , then

$$\mathsf{dom}\left(f^{\mathsf{Free}(\mathbb{T})}\right) = \left\{\left([t_i]\right)_i \in \prod_{1 \le i \le n} \mathsf{Free}(\mathbb{T})_{A_i} : \mathbb{T} \vdash f(t_1, \dots, t_n) \downarrow \right\},$$

and for any $([t_i])_i \in \mathsf{dom}(f^{\mathsf{Free}}(\mathbb{T}))$, we have $f^{\mathsf{Free}}(\mathbb{T})([t_1],\ldots,[t_n]) = [f(t_1,\ldots,t_n)].$

To review the main results of [7, Section 2.2] and [4], characterizing the covariant isotropy group of \mathbb{T} mod for a quasi-equational theory \mathbb{T} in logical terms, we first recall the following notions.

If $M \in \mathbb{T}$ mod for a quasi-equational theory \mathbb{T} over a signature Σ , then $\Sigma(M)$ is the diagram signature of M, which extends Σ by adding a new constant symbol $c_a : C$ for any sort $C \in \Sigma_{\mathsf{Sort}}$ and $a \in M_C$. The quasiequational theory $\mathbb{T}(M)$ over the signature $\Sigma(M)$ then extends \mathbb{T} by adding axioms expressing that each new constant c_a is defined, and that the function symbols of \mathbb{T} interact with these constants appropriately (for explicit details, see [7, Definition 2.2.3]). If $n \geq 1$ and $A_i \in \Sigma_{\mathsf{Sort}}$ for each $1 \leq i \leq n$, then $\Sigma(M, \mathsf{x}_1, \ldots, \mathsf{x}_n)$ is the signature that extends $\Sigma(M)$ by adding new pairwise distinct constant symbols $\mathsf{x}_i : A_i$ for all $1 \leq i \leq n$. The quasi-equational theory $\mathbb{T}(M, \mathsf{x}_1, \ldots, \mathsf{x}_n)$ over the signature $\Sigma(M, \mathsf{x}_1, \ldots, \mathsf{x}_n)$ then extends $\mathbb{T}(M)$ by adding axioms expressing that x_i is defined for each $1 \leq i \leq n$. Finally, if $C \in \Sigma_{\mathsf{Sort}}$, then $M \langle \mathsf{x}_C \rangle$ is defined to be the (Σ -reduct of) the initial model of $\mathbb{T}(M, \mathsf{x}_C)$, which therefore has the following explicit description (cf. Remark 2.15):

• For any $B \in \Sigma_{\mathsf{Sort}}$,

$$M \langle \mathsf{x}_C \rangle_B = \{ [t] : t \in \mathsf{Term}^c(\Sigma(M, \mathsf{x}_C))_B \land \mathbb{T}(M, \mathsf{x}_C) \vdash t \downarrow \}$$

• If $f: A_1 \times \ldots \times A_n \to A$ is a function symbol of Σ , then

$$\operatorname{dom}\left(f^{M\langle \mathsf{x}_C\rangle}\right) = \left\{ \left([t_i]\right)_i \in \prod_{1 \le i \le n} M \left\langle \mathsf{x}_C \right\rangle_{A_i} : \mathbb{T}(M, \mathsf{x}_C) \vdash f(t_1, \dots, t_n) \downarrow \right\},\$$

and for any $([t_i])_i \in \mathsf{dom}\left(f^{M\langle \mathsf{x}_C \rangle}\right)$ we have $f^{M\langle \mathsf{x}_C \rangle}\left([t_1], \dots, [t_n]\right) = [f(t_1, \dots, t_n)].$

We now recall [7, Definition 2.2.47] and [4, Definition 6]. The notion of syntactic substitution used in the following definition is the standard/expected one; see [7, Remark 2.2.21] for an explicit definition.

Definition 2.16. Let \mathbb{T} be a quasi-equational theory over a signature Σ , and let $M \in \mathbb{T}$ mod and $([s_C])_C \in \prod_{C \in \Sigma_{Sort}} M \langle \mathsf{x}_C \rangle_C$.

• If $f: A_1 \times \ldots \times A_n \to A$ is a function symbol of Σ , then $([s_C])_C$ commutes generically with f if the Horn sequent

$$f(\mathsf{x}_1,\ldots,\mathsf{x}_n) \downarrow \vdash s_A[f(\mathsf{x}_1,\ldots,\mathsf{x}_n)/\mathsf{x}_A] = f(s_{A_1}[\mathsf{x}_1/\mathsf{x}_{A_1}],\ldots,s_{A_n}[\mathsf{x}_n/\mathsf{x}_{A_n}])$$

is provable in $\mathbb{T}(M, \mathsf{x}_1, \ldots, \mathsf{x}_n)$.

• We say that $([s_C])_C$ is (substitutionally) invertible if for every $B \in \Sigma_{Sort}$ there is some $[s_B^{-1}] \in M \langle \mathsf{x}_B \rangle_B$ with

$$\left[s_B\left[s_B^{-1}/\mathsf{x}_B\right]\right] = \left[\mathsf{x}_B\right] = \left[s_B^{-1}\left[s_B/\mathsf{x}_B\right]\right] \in M \left<\mathsf{x}_B\right>_B,$$

i.e. with $\mathbb{T}(M, \mathsf{x}_B) \vdash s_B\left[s_B^{-1}/\mathsf{x}_B\right] = \mathsf{x}_B = s_B^{-1}[s_B/\mathsf{x}_B].$

• We say that $([s_C])_C$ reflects definedness if for every function symbol $f : A_1 \times \ldots \times A_n \to A$ in Σ , the sequent

$$f(s_{A_1}[\mathsf{x}_1/\mathsf{x}_{A_1}],\ldots,s_{A_n}[\mathsf{x}_n/\mathsf{x}_{A_n}])\downarrow \vdash f(\mathsf{x}_1,\ldots,\mathsf{x}_n)\downarrow$$

is provable in $\mathbb{T}(M, \mathsf{x}_1, \ldots, \mathsf{x}_n)$.

As in [7, Definition 2.2.36], we then have a functor $G_{\mathbb{T}}$: $\mathbb{T}mod \to \mathsf{Group}$, with $G_{\mathbb{T}}(M)$ for $M \in \mathbb{T}mod$ being the group of all elements $([s_C])_C \in \prod_{C \in \Sigma} M \langle \mathsf{x}_C \rangle_C$ that are substitutionally invertible and commute generically with and reflect definedness of every function symbol of Σ . The unit of this group is the element $([\mathsf{x}_C])_C$, the inverse of any element is obtained via the substitutional invertibility of each of its components (as in Definition 2.16), and if $([s_C])_C$, $([t_C])_C \in G_{\mathbb{T}}(M)$, then their product is obtained via substitution as $([s_C])_C \cdot ([t_C])_C := ([s_C [t_C/\mathsf{x}_C]])_C$. For more details, see [7, Propositions 2.2.35, 2.2.38]. From [7, Theorems 2.2.41, 2.2.53] and [4, Theorem 7] we then conclude that if \mathbb{T} is a quasi-equational theory, then

$$\mathcal{Z}_{\mathbb{T}\mathsf{mod}} \cong G_{\mathbb{T}} : \mathbb{T}\mathsf{mod} \to \mathsf{Group}$$

(In what follows, we will generally write $\mathcal{Z}_{\mathbb{T}}$ in place of $\mathcal{Z}_{\mathbb{T}\mathsf{mod}}$.) In other words, the covariant isotropy group of $M \in \mathbb{T}\mathsf{mod}$, i.e. its group of extended inner automorphisms, is isomorphic to the group of all elements of $([s_C])_C \in \prod_{C \in \Sigma} M \langle \mathsf{x}_C \rangle_C$ that are substitutionally invertible and commute generically with and reflect definedness of all operations of \mathbb{T} (naturally in M).

3. Logical characterization

For the remainder of this section, we fix a quasi-equational theory \mathbb{T} over a signature Σ , as well as a small index category \mathcal{J} . At a certain point (see Proposition 3.45) we will need to impose two modest assumptions on \mathbb{T} , but for the time being we can assume that \mathbb{T} is arbitrary. We first show that the functor category $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$ can be axiomatized as the category of models of a quasi-equational theory $\mathbb{T}^{\mathcal{J}}$, and then we explicitly characterize $G_{\mathbb{T}^{\mathcal{J}}} : \mathbb{T}^{\mathcal{J}}\mathsf{mod} \to \mathsf{Group}$, which will yield an explicit characterization of the covariant isotropy group $\mathcal{Z}_{\mathbb{T}\mathsf{mod}^{\mathcal{J}}} : \mathbb{T}\mathsf{mod}^{\mathcal{J}} \to \mathsf{Group}$ in Section 4.

We first define the signature $\Sigma^{\mathcal{J}}$ for the desired quasi-equational theory $\mathbb{T}^{\mathcal{J}}$. Since \mathcal{J} is small, we know that its classes $\mathsf{ob}\mathcal{J}$ and $\mathsf{mor}\mathcal{J}$ of objects and morphisms are both sets.

Definition 3.1. We define the signature $\Sigma^{\mathcal{J}}$ as follows:

• If $i \in \mathsf{ob}\mathcal{J}$ and $A \in \Sigma_{\mathsf{Sort}}$, let $A^i \notin \Sigma_{\mathsf{Sort}}$ be a new sort. Then we set

$$\Sigma_{\mathsf{Sort}}^{\mathcal{J}} := \left\{ A^i : i \in \mathsf{ob}\mathcal{J}, A \in \Sigma_{\mathsf{Sort}} \right\}.$$

• For any morphism $f: i \to j$ in \mathcal{J} and $A \in \Sigma_{\mathsf{Sort}}$, let $\alpha_f^A: A^i \to A^j$ be a new unary function symbol $\notin \Sigma_{\mathsf{Fun}}$. For any $i \in \mathsf{ob}\mathcal{J}$ and function symbol $g: A_1 \times \ldots \times A_n \to A$ in Σ_{Fun} , let $g^i: A_1^i \times \ldots \times A_n^i \to A^i$ be a new function symbol $\notin \Sigma_{\mathsf{Fun}}$. Then we set

$$\Sigma_{\mathsf{Fun}}^{\mathcal{J}} := \left\{ \alpha_f^A : f \in \mathsf{mor}\mathcal{J}, A \in \Sigma_{\mathsf{Sort}} \right\} \bigcup \left\{ g^i : g \in \Sigma_{\mathsf{Fun}}, i \in \mathsf{ob}\mathcal{J} \right\}.$$

Given a partial $\Sigma^{\mathcal{J}}$ -structure, we now show how to derive component Σ -structures from it, indexed by the objects of \mathcal{J} .

Definition 3.2. Let M be a partial $\Sigma^{\mathcal{J}}$ -structure and let $i \in \mathsf{ob}\mathcal{J}$. We define a partial Σ -structure M^i as follows: for any $A \in \Sigma_{\mathsf{Sort}}$, we set $M_A^i := M_{A^i}$, and for any function symbol $g : A_1 \times \ldots \times A_n \to A$ of Σ , we set $g^{M^i} := (g^i)^M : M_{A_1^i} \times \ldots \times M_{A_n^i} = M_{A_1^i}^i \times \ldots \times M_{A_n^i}^i \to M_A^i = M_{A^i}$.

From a morphism of $\Sigma^{\mathcal{J}}$ -structures we can also obtain morphisms of the component Σ -structures:

Definition 3.3. Let $h: M \to N$ be a $\Sigma^{\mathcal{J}}$ -morphism and let $i \in \mathsf{ob}\mathcal{J}$. Then we have a Σ -morphism $h^i: M^i \to N^i$ given by $h^i_A := h_{A^i}: M^i_A = M_{A^i} \to N_{A^i} = N^i_A$ for every $A \in \Sigma_{\mathsf{Sort}}$.

For any $i \in ob\mathcal{J}$, we now define an 'inclusion' signature morphism $\rho^i : \Sigma \to \Sigma^{\mathcal{J}}$. Recall from [5, Section 5] that a signature morphism $\rho : \Sigma_1 \to \Sigma_2$ from a signature Σ_1 to a signature Σ_2 assigns to each sort A of Σ_1 a sort $\rho(A)$ of Σ_2 and to each function symbol $g : A_1 \times \ldots \times A_n \to A$ of Σ_1 a function symbol $\rho(g) : \rho(A_1) \times \ldots \times \rho(A_n) \to \rho(A)$ of Σ_2 .

Definition 3.4. For any $i \in \text{ob}\mathcal{J}$, we define a signature morphism $\rho^i : \Sigma \to \Sigma^{\mathcal{J}}$ as follows: for any $A \in \Sigma_{\mathsf{Sort}}$, we set $\rho^i(A) := A^i \in \Sigma^{\mathcal{J}}_{\mathsf{Sort}}$, and for any function symbol $g : A_1 \times \ldots \times A_n \to A$ in Σ_{Fun} , we set $\rho^i(g) := g^i : A_1^i \times \ldots \times A_n^i \to A^i$.

We can now define the quasi-equational theory $\mathbb{T}^{\mathcal{J}}$ that will axiomatize $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$.

Definition 3.5. We define $\mathbb{T}^{\mathcal{J}}$ to be the quasi-equational theory over the signature $\Sigma^{\mathcal{J}}$ whose axioms are the following sequents:

- 1. For any $f: i \to j$ in mor \mathcal{J} and $A \in \Sigma_{\mathsf{Sort}}$, the axiom $\top \vdash^{x:A^i} \alpha_f^A(x) \downarrow$.
- 2. For any $i \in ob\mathcal{J}$ and $A \in \Sigma_{Sort}$, the axiom $\top \vdash^{x:A^i} \alpha^A_{id_i}(x) = x$.
- 3. For any $f: i \to j$ and $g: j \to k$ in mor \mathcal{J} and $A \in \Sigma_{\mathsf{Sort}}$, the axiom $\top \vdash^{x:A^i} \alpha_q^A \left(\alpha_f^A(x) \right) = \alpha_{q \circ f}^A(x)$.
- 4. For any $f: i \to j$ in mor \mathcal{J} and $g: A_1 \times \ldots \times A_n \to A$ in Σ_{Fun} , the axiom

$$g^{i}(\mathsf{x}_{1},\ldots,\mathsf{x}_{n})\downarrow \vdash^{\mathsf{x}_{1}:A_{1}^{i},\ldots,\mathsf{x}_{n}:A_{n}^{i}}\alpha_{f}^{A}\left(g^{i}(\mathsf{x}_{1},\ldots,\mathsf{x}_{n})\right) = g^{j}\left(\alpha_{f}^{A_{1}}(\mathsf{x}_{1}),\ldots,\alpha_{f}^{A_{n}}(\mathsf{x}_{n})\right).$$

5. For any $i \in \mathsf{ob}\mathcal{J}$ and any axiom $\varphi \vdash^{\vec{x}} \psi$ of \mathbb{T} , the axiom $\rho^i(\varphi) \vdash^{\rho^i(\vec{x})} \rho^i(\psi)$.

Remark 3.6. Recall from [5, Section 5] that if \mathbb{T}_1 and \mathbb{T}_2 are quasi-equational theories over respective signatures Σ_1 and Σ_2 , then a signature morphism $\rho : \Sigma_1 \to \Sigma_2$ is a *theory morphism* from \mathbb{T}_1 to \mathbb{T}_2 if the ρ -translation $\rho(\varphi) \vdash^{\rho(\vec{x})} \rho(\psi)$ of any axiom $\varphi \vdash^{\vec{x}} \psi$ of \mathbb{T}_1 is provable in \mathbb{T}_2 , which then entails that ρ preserves provability of sequents (see [7, Lemma 2.2.16]). A first easy property of $\mathbb{T}^{\mathcal{J}}$ is now that for any $i \in \mathsf{ob}\mathcal{J}$, the signature morphism $\rho^i : \Sigma \to \Sigma^{\mathcal{J}}$ of Definition 3.4 is also a *theory* morphism $\mathbb{T} \to \mathbb{T}^{\mathcal{J}}$, because $\mathbb{T}^{\mathcal{J}}$ includes the axioms in Definition 3.5.5.

To begin studying the models of $\mathbb{T}^{\mathcal{J}}$, we first make the following easy observation:

Lemma 3.7. If M is a partial $\Sigma^{\mathcal{J}}$ -structure with $M \models \mathbb{T}^{\mathcal{J}}$, then for any $i \in ob\mathcal{J}$, the partial Σ -structure M^i of Definition 3.2 is a model of \mathbb{T} .

Proof. Since $\rho^i : \mathbb{T} \to \mathbb{T}^{\mathcal{J}}$ is a theory morphism by Remark 3.6, it follows by [5, Proposition 28] that $U^i(M)$ is a model of \mathbb{T} , where $U^i : \mathbb{T}^{\mathcal{J}} \mod \to \mathbb{T}$ mod is the forgetful functor induced by the signature morphism ρ^i . However, it is trivial to observe that $U^i(M) = M^i$, so that M^i is indeed a model of \mathbb{T} .

We now have:

Proposition 3.8. There is an isomorphism of categories $\mathbb{T}^{\mathcal{J}} \mod \cong \mathbb{T} \mod^{\mathcal{J}}$.

Proof. We sketch the bijection between the objects of $\mathbb{T}^{\mathcal{J}}$ mod and $\mathbb{T} \operatorname{mod}^{\mathcal{J}}$ and refer the reader to [7, Proposition 5.1.8] for the remaining straightforward details. Given $M \in \mathbb{T}^{\mathcal{J}} \operatorname{mod}$, we must define a corresponding functor $F^M : \mathcal{J} \to \mathbb{T} \operatorname{mod}$. For any $i \in \operatorname{ob} \mathcal{J}$, we let $F^M(i)$ be the \mathbb{T} -model M^i of Lemma 3.7. For any morphism $f : i \to j$ of \mathcal{J} , we define the Σ-morphism $F^M(f) : M^i \to M^j$ as follows: for any $A \in \Sigma_{\mathsf{Sort}}$, we define $F^M(f)_A : M_A^i = M_{A^i} \to M_{A^j} \to M_A^j$ as $F^M(f)_A := \left(\alpha_f^A\right)^M$. Because of Axiom 3.5.1, it follows that each function $F^M(f)_A = \left(\alpha_f^A\right)^M$ is total (as needed). The functoriality of F^M follows from Axioms 3.5.2 and 3.5.3, and the fact that $F^M(f) : M^i \to M^j$ is a Σ-morphism follows from Axiom 3.5.4. This proves that $F^M : \mathcal{J} \to \mathbb{T}$ mod as follows: for any $A \in \Sigma_{\mathsf{Sort}}$ and $i \in \operatorname{ob} \mathcal{J}$, we set $M_{A^i}^F := F(i)_A$, for any morphism $f : i \to j$ in \mathcal{J} , we set $\left(\alpha_f^A\right)^{M^F} := F(f)_A$, and for any function symbol $g : A_1 \times \ldots \times A_n \to A$ of Σ , we set $(g^i)^{M^F} := g^{F(i)}$. The functoriality of F guarantees that M^F satisfies Axiom 3.5.4, and the fact that each F(f) is a Σ-morphism function symbol $g : A_1 \times \ldots \times A_n \to A$ of Σ , we set $(g^i)^{M^F} := g^{F(i)}$. The functoriality of F guarantees that M^F satisfies Axiom 3.5.4, and the fact that each F(i) is a Σ-morphism guarantees that M^F satisfies Axiom 3.5.4, and the fact that each F(i) is a Σ-morphism guarantees that M^F satisfies Axiom 3.5.4, and the fact that each F(i) is a Σ-morphism guarantees that M^F satisfies Axiom 3.5.4, and the fact that each F(i) is a T-model guarantees that M^F satisfies Axiom 3.5.5. So M^F is indeed a $\mathbb{T}^{\mathcal{J}}$ -model, and it is now straightforward to observe that the assignments $M \mapsto F^M$ and $F \mapsto M^F$ are mutually inverse.

Before we can start to characterize the covariant isotropy group of $\mathbb{T}^{\mathcal{J}}$, we first require the following purely group-theoretic fact, whose proof is a routine verification.

Lemma 3.9. Let $F : \mathcal{J} \to \text{Group}$ be a functor, and consider the product group $\prod_{i \in \mathsf{ob}, \mathcal{J}} F(i)$. Then

$$\left(\prod_{i\in\mathsf{ob}\mathcal{J}}F(i)\right)^F := \left\{(g_i)_i\in\prod_{i\in\mathsf{ob}\mathcal{J}}F(i)\,:\,F(f)(g_j)=g_k\;\forall f:j\to k\in\mathsf{mor}\mathcal{J}\right\}$$

is a subgroup of $\prod_{i \in ob \mathcal{J}} F(i)$. Furthermore, this assignment is the object part of a functor $\left(\prod_{i \in ob \mathcal{J}} (-)(i)\right)^{(-)} = \lim : \operatorname{Group}^{\mathcal{J}} \to \operatorname{Group}.$

We can now begin to characterize the covariant isotropy groups of models of $\mathbb{T}^{\mathcal{J}}$. If $M \in \mathbb{T}^{\mathcal{J}} \mod$, then by the proof of Proposition 3.8, there is a corresponding functor $F^M : \mathcal{J} \to \mathbb{T} \mod$. If $G_{\mathbb{T}} : \mathbb{T} \mod \to \text{Group}$ is the functor naturally isomorphic to the covariant isotropy group $\mathcal{Z}_{\mathbb{T}} : \mathbb{T} \mod \to \text{Group}$ by Section 2, then we obtain the composite functor $G_{\mathbb{T}} \circ F^M : \mathcal{J} \to \text{Group}$ with

$$\left(G_{\mathbb{T}} \circ F^{M}\right)(i) = G_{\mathbb{T}}\left(F^{M}(i)\right) = G_{\mathbb{T}}\left(M^{i}\right)$$

for every $i \in ob\mathcal{J}$. By Lemma 3.9, it then follows that $(\prod_i G_{\mathbb{T}}(M^i))^{G_{\mathbb{T}} \circ F^M}$ is a subgroup of $\prod_i G_{\mathbb{T}}(M^i)$, and hence in particular is a group. Let us denote this subgroup with the cleaner notation $(\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}}$.

Next, we will need to define a certain group $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$, where $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})$ is the group of natural automorphisms of the identity functor $\operatorname{Id}_{\mathcal{J}} : \mathcal{J} \to \mathcal{J}$. Its definition is somewhat subtle and unintuitive, so we ask the reader to bear with us until after we have defined it, at which point we will try to give some explanation for the technicalities in its definition.

For any $i \in ob\mathcal{J}$ and $B \in \Sigma_{Sort}$, we say that the diagram theory $\mathbb{T}(M^i)$ of the \mathbb{T} -model M^i is trivial for the sort B if $\mathbb{T}(M^i) \vdash^{y,y'} y = y'$ for distinct variables y, y' : B. Otherwise, we say that $\mathbb{T}(M^i)$ is non-trivial for the sort B. To say that $\mathbb{T}(M^i)$ is trivial for the sort B is equivalent to saying (by [7, Lemma 3.1.2]) that for any \mathbb{T} -model N for which there is a Σ -morphism $M^i \to N$, the carrier set N_B has at most one element. For any $B \in \Sigma_{Sort}$, we let \mathcal{J}_B^M be the full subcategory of \mathcal{J} on those objects $i \in ob\mathcal{J}$ for which $\mathbb{T}(M^i)$ is non-trivial for the sort B. We then let $\mathsf{Aut}(\mathsf{Id}_{\mathcal{J}_B^M})$ be the group of natural automorphisms of the identity functor $\mathsf{Id}_{\mathcal{J}_B^M} : \mathcal{J}_B^M \to \mathcal{J}_B^M$. We will need to consider a certain subgroup of $\prod_{B \in \Sigma_{\text{Sort}}} \operatorname{Aut}\left(\operatorname{Id}_{\mathcal{J}_B^M}\right)$, which we will call $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$. To define this subgroup, we first require the following definition:

Definition 3.10. Let $M \in \mathbb{T}^{\mathcal{J}} \mod$, let $g : A_1 \times \ldots \times A_n \to A$ be a function symbol of Σ with $n \ge 1$, and let $i \in \mathsf{ob}\mathcal{J}$. Then for any $1 \le m \le n$, we say that g^{M^i} is degenerate in position m if

$$\mathbb{T}\left(M^{i}\right)\vdash^{y_{1},\ldots,y_{n},z_{m}}g(y_{1},\ldots,y_{n})=g(y_{1},\ldots,y_{n})[z_{m}/y_{m}],$$

where y_1, \ldots, y_n, z_m are pairwise distinct variables of the appropriate sorts. Otherwise, if $\mathbb{T}(M^i)$ does not prove the above equation, we say that g^{M^i} is non-degenerate in position m.

Thus, to say that g^{M^i} is degenerate in position $1 \le m \le n$ is equivalent to saying (again by [7, Lemma 3.1.2]) that for any T-model N for which there is a Σ -morphism $M^i \to N$ and any elements $a_1 \in N_{A_1}, \ldots, a_m, b_m \in N_{A_m}, \ldots, a_n \in N_{A_n}$, we have $g^N(a_1, \ldots, a_m, \ldots, a_n) = g^N(a_1, \ldots, b_m, \ldots, a_n)$ (i.e. the value of g^N does not change when the *m*th coordinate of an input *n*-tuple changes). We can now define:

Definition 3.11. Let $M \in \mathbb{T}^{\mathcal{J}}$ mod. We denote an element of $\prod_{B \in \Sigma_{\mathsf{Sort}}} \mathsf{Aut}\left(\mathsf{Id}_{\mathcal{J}_B^M}\right)$ by $\psi = (\psi_B)_{B \in \Sigma}$, so that each ψ_B is a natural automorphism of $\mathsf{Id}_{\mathcal{J}_B^M}$, with components $\psi_B(i) : i \xrightarrow{\sim} i$ for each $i \in \mathsf{ob}\mathcal{J}_B^M$.

We define

$$\mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})^M \subseteq \prod_{B \in \Sigma_{\mathsf{Sort}}} \mathsf{Aut}\left(\mathsf{Id}_{\mathcal{J}^M_B}\right)$$

to consist of exactly those elements $\psi \in \prod_{B \in \Sigma_{\text{Sort}}} \operatorname{Aut} \left(\operatorname{Id}_{\mathcal{J}_B^M} \right)$ with the following property: if $g: A_1 \times \ldots \times A_n \to A$ is any function symbol of Σ with $n \geq 1$, then for any $i \in \operatorname{ob} \mathcal{J}$ and $1 \leq m \leq n$ for which g^{M^i} is non-degenerate in position m, we have $\psi_{A_m}(i) = \psi_A(i) : i \xrightarrow{\sim} i$. This property is well-defined, in the sense that if g^{M^i} is non-degenerate in position m, then it easily

This property is well-defined, in the sense that if g^{M^i} is non-degenerate in position m, then it easily follows that $\mathbb{T}(M^i)$ must be non-trivial for the sorts A and A_m , so that i must be an object of both \mathcal{J}_A^M and $\mathcal{J}_{A_m}^M$, and hence $\psi_A(i)$ and $\psi_{A_m}(i)$ are both well-defined morphisms of \mathcal{J} . It is then trivial to verify that $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$ is indeed a *subgroup* of $\prod_{B \in \Sigma_{\text{Sort}}} \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}_B^M})$, and hence is a group.

Our ultimate goal in this section is now to show for any quasi-equational theory \mathbb{T} (satisfying two mild conditions, see Proposition 3.45), any small index category \mathcal{J} , and any $M \in \mathbb{T}^{\mathcal{J}} \mod$ that

$$G_{\mathbb{T}^{\mathcal{J}}}(M) \cong \left(\prod_{i \in \mathcal{J}} G_{\mathbb{T}}\left(M^{i}\right)\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^{M},$$

naturally in M. Specifically, we will construct a group isomorphism

$$\beta_M : \left(\prod_{i \in \mathcal{J}} G_{\mathbb{T}}\left(M^i\right)\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M \xrightarrow{\sim} G_{\mathbb{T}^{\mathcal{J}}}(M)$$

for each $M \in \mathbb{T}^{\mathcal{J}} \operatorname{mod}$.

As promised, let us now attempt to give some explanation of the technicalities involved in the definition of $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$. First, let us discuss why for each sort $B \in \Sigma_{\operatorname{Sort}}$ we needed to consider the full subcategory \mathcal{J}_B^M of \mathcal{J} on those objects $i \in \operatorname{ob}\mathcal{J}$ for which $\mathbb{T}(M^i)$ is non-trivial for the sort B, rather than just the whole category \mathcal{J} . Essentially, the reason is that if we considered \mathcal{J} rather than \mathcal{J}_B^M , then the group homomorphism β_M that we will define in Proposition 3.19 will *not* be injective in general. Indeed, we show in detail on [7, Page 151] that if \mathbb{T} is the single-sorted algebraic theory of commutative unital rings, \mathcal{J} is any one-object category for which $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})$ is non-trivial, and $F : \mathcal{J} \to \mathbb{T} \operatorname{mod} = \operatorname{CRing}$ is the constant functor on the zero ring with corresponding $\mathbb{T}^{\mathcal{J}}$ -model M, then β_M will *not* be injective if we consider \mathcal{J} rather than \mathcal{J}_X^M (where X is the unique sort of \mathbb{T}). This will hopefully help to convince the reader that we need to define $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$ to be a subgroup of $\prod_{\mathcal{B}\in\Sigma_{\operatorname{Sort}}}\operatorname{Aut}\left(\operatorname{Id}_{\mathcal{J}_{\mathcal{B}}^M}\right)$ rather than $\prod_{\mathcal{B}\in\Sigma_{\operatorname{Sort}}}\operatorname{Aut}\left(\operatorname{Id}_{\mathcal{J}}\right)$. Now let us try to motivate why we cannot just define $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$ to be the full group $\prod_{\mathcal{B}\in\Sigma_{\operatorname{Sort}}}\operatorname{Aut}\left(\operatorname{Id}_{\mathcal{J}_{\mathcal{B}}^M}\right)$ (when \mathbb{T} is *multi*-sorted). A first vague intuition is that if $\psi = (\psi_B)_{B\in\Sigma} \in \prod_{\mathcal{B}\in\Sigma_{\operatorname{Sort}}}\operatorname{Aut}\left(\operatorname{Id}_{\mathcal{J}_{\mathcal{B}}^M}\right)$, then we need the distinct ψ_B 's to 'interact' properly, if there are (non-degenerate) function symbols in $\Sigma_{\operatorname{Fun}}$ that 'connect' distinct sorts. Indeed, we show in detail on [7, Page 152] that if \mathcal{J} is the one-object category corresponding to the group \mathbb{Z}_2 and \mathbb{T} is the quasi-equational theory with two sorts X and Y and one function symbol $f: X \to Y$ and the single axiom asserting that f is always defined, then there is a model M of $\mathbb{T}^{\mathcal{J}}$ for which the group homomorphism β_M defined in Proposition 3.19 will *not* land in $G_{\mathbb{T}^{\mathcal{J}}}(M)$, if we do not define $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$ as we do in Definition 3.11.

Now, towards constructing the group homomorphisms β_M in Proposition 3.19, we require the following technical definitions and lemmas.

Definition 3.12. Let $M \in \mathbb{T}^{\mathcal{J}} \mod i \in \mathsf{ob}\mathcal{J}$, and $C \in \Sigma_{\mathsf{Sort}}$. We define a signature morphism

$$\rho_{M^{i}}^{C}: \Sigma\left(M^{i}, \mathsf{x}_{C}\right) \to \Sigma^{\mathcal{J}}\left(M, \mathsf{x}_{C^{i}}\right)$$

as follows (where $x_C \notin \Sigma(M^i)$ and $x_{C^i} \notin \Sigma^{\mathcal{J}}(M)$ are new constants of sorts C and C^i , respectively):

- On $\Sigma \subseteq \Sigma(M^i, \mathsf{x}_C)$, we stipulate that $\rho_{M^i}^C$ agrees with $\rho^i : \Sigma \to \Sigma^{\mathcal{J}}$ (see Definition 3.4).
- If $s \in M_A^i = M_{A^i}$ for some $A \in \Sigma_{\mathsf{Sort}}$, then we set $\rho_{M^i}^C\left(c_{A,s}^{M^i}\right) := c_{A^i,s}^M \in \Sigma^{\mathcal{J}}\left(M, \mathsf{x}_{C^i}\right)$.

• We set
$$\rho_{M^i}^C(\mathsf{x}_C) := \mathsf{x}_{C^i} \in \Sigma^{\mathcal{J}}(M, \mathsf{x}_{C^i}).$$

We now have the following lemma, whose easy proof may be found in [7, Lemma 5.1.13]:

Lemma 3.13. For any $M \in \mathbb{T}^{\mathcal{J}} \mod i \in \mathsf{ob}\mathcal{J}$, and $C \in \Sigma_{\mathsf{Sort}}$, the signature morphism $\rho_{M^i}^C$ is a theory morphism $\rho_{M^i}^C : \mathbb{T}(M^i, \mathsf{x}_C) \to \mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{C^i})$.

The proof of the next lemma is immediate from the definitions:

Lemma 3.14. Let $M \in \mathbb{T}^{\mathcal{J}} \mod i \in \mathsf{ob}\mathcal{J}$, and $C \in \Sigma_{\mathsf{Sort}}$. For any $u, v \in \mathsf{Term}^c(\Sigma(M^i, \mathsf{x}_C))$ with v : C, we have $\rho_{M^i}^C(u[v/\mathsf{x}_C]) \equiv \rho_{M^i}^C(u) [\rho_{M^i}^C(v)/\mathsf{x}_{C^i}]$.

We will require the following signature morphisms indexed by the elements of $mor \mathcal{J}$:

Definition 3.15. Let $M \in \mathbb{T}^{\mathcal{J}} \mod f : i \to j \in \operatorname{mor} \mathcal{J}$, and $C \in \Sigma_{\mathsf{Sort}}$. We define a signature morphism

$$\sigma_f^C: \Sigma^{\mathcal{J}}(M, \mathsf{x}_{C^j}) \to \Sigma^{\mathcal{J}}(M, \mathsf{x}_{C^i})$$

as follows: on $\Sigma^{\mathcal{J}}(M)$ we define σ_f^C to be the inclusion into $\Sigma^{\mathcal{J}}(M, \mathsf{x}_{C^i})$, and we set $\sigma_f^C(\mathsf{x}_{C^j}) := \alpha_f^C(\mathsf{x}_{C^i}) : C^j$.

Since $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{C^{i}}) \vdash \alpha_{f}^{C}(\mathsf{x}_{C^{i}}) \downarrow$, we then easily obtain:

Lemma 3.16. For any $M \in \mathbb{T}^{\mathcal{J}} \mod f : i \to j \in \operatorname{mor} \mathcal{J}$, and $C \in \Sigma_{\mathsf{Sort}}$, the signature morphism σ_f^C is a theory morphism $\sigma_f^C : \mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{C^j}) \to \mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{C^i})$.

If $f: i \to j$ is a morphism in \mathcal{J} , let us write $f^M := F^M(f) : M^i \to M^j$ (see the proof of Proposition 3.8). Then we have

$$f^{M} = F^{M}(f) = \left(\left(\alpha_{f}^{A} \right)^{M} : M_{A}^{i} \to M_{A}^{j} \right)_{A \in \Sigma}$$

Recall that for any $C \in \Sigma_{\text{Sort}}$, the Σ -morphism $f^M : M^i \to M^j$ induces a canonical signature morphism $\rho_{f^M}^C : \Sigma(M^i, \mathsf{x}_C) \to \Sigma(M^j, \mathsf{x}_C)$ by [7, Definition 2.2.17] which is also a theory morphism $\mathbb{T}(M^i, \mathsf{x}_C) \to \mathbb{T}(M^j, \mathsf{x}_C)$ by [7, Lemma 2.2.18].

Definition 3.17. For any $M \in \mathbb{T}^{\mathcal{J}} \mod$, any morphism $f : i \to j$ in \mathcal{J} , and any $C \in \Sigma_{\text{Sort}}$, we define a signature morphism $\tau_f^C : \Sigma(M^i, \mathbf{x}_C) \to \Sigma^{\mathcal{J}}(M, \mathbf{x}_{C^i})$ as the composite

$$\Sigma\left(M^{i},\mathsf{x}_{C}\right) \xrightarrow{\rho_{f^{M}}^{C}} \Sigma(M^{j},\mathsf{x}_{C}) \xrightarrow{\rho_{M^{j}}^{C}} \Sigma^{\mathcal{J}}(M,\mathsf{x}_{C^{j}}) \xrightarrow{\sigma_{f}^{C}} \Sigma^{\mathcal{J}}(M,\mathsf{x}_{C^{i}}).$$

Explicitly, τ_f^C is defined as follows:

- When restricted to $\Sigma \subseteq \Sigma(M^i, \mathsf{x}_C), \tau_f^C$ agrees with $\rho^j : \Sigma \to \Sigma^{\mathcal{J}}$.
- For any $s \in M_A^i = M_{A^i}$ (for any $A \in \Sigma_{\mathsf{Sort}}$), we have $\tau_f^C\left(c_{A,s}^{M^i}\right) \equiv c_{A^j,\left(\alpha_f^A\right)^M(s)}^M$.
- We have $\tau_f^C(\mathbf{x}_C) \equiv \alpha_f^C(\mathbf{x}_{C^i})$.

We will then need the following technical lemma about the signature morphism τ_f^C , whose proof may be found in [7, Lemma 5.1.19]:

Lemma 3.18. Let $M \in \mathbb{T}^{\mathcal{J}} \mod$, let $f: i \to j$ be any morphism in \mathcal{J} , and let $C \in \Sigma_{\mathsf{Sort}}$. Then for any term $u \in \mathsf{Term}^c\left(\Sigma\left(M^i, \mathsf{x}_C\right)\right)$ with $\mathbb{T}\left(M^i, \mathsf{x}_C\right) \vdash u \downarrow$ and u: A, we have $\mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{C^i}\right) \vdash \tau_f^C(u) = \alpha_f^A\left(\rho_{M^i}^C(u)\right)$.

We can now prove:

Proposition 3.19. For any $M \in \mathbb{T}^{\mathcal{J}} \mod$, there is a group homomorphism

$$\beta_M : \left(\prod_{i \in \mathcal{J}} G_{\mathbb{T}}\left(M^i\right)\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M \to G_{\mathbb{T}^{\mathcal{J}}}(M).$$

Proof. Let $\gamma = (\gamma_i)_i \in (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}}$ and $\psi = (\psi_B)_{B \in \Sigma} \in \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$. We must define $\beta_M(\gamma, \psi) \in G_{\mathbb{T}^{\mathcal{J}}}(M)$, with $G_{\mathbb{T}^{\mathcal{J}}}(M)$ being the group of all $\Sigma^{\mathcal{J}}_{\mathsf{Sort}}$ -indexed sequences $([t_{C^i}])_{i,C} \in \prod_{i \in \mathcal{J}, C \in \Sigma} M \langle \mathsf{x}_{C^i} \rangle_{C^i}$ that are invertible, commute generically with all function symbols of $\Sigma^{\mathcal{J}}$, and reflect definedness. Each $t_{C^i} \in \operatorname{Term}^c (\Sigma^{\mathcal{J}}(M,\mathsf{x}_{C^i}))$ is a closed term of sort C^i with $\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{C^i}) \vdash t_{C^i} \downarrow$.

So let $i \in \mathsf{ob}\mathcal{J}$ and $C \in \Sigma_{\mathsf{Sort}}$, and let us define $\beta_M(\gamma, \psi)_{C^i} \in M \langle \mathsf{x}_{C^i} \rangle_{C^i}$. Since $\gamma_i \in G_{\mathbb{T}}(M^i)$, we know that $\gamma_i^C = [s_C^i] \in M^i \langle \mathsf{x}_C \rangle_C$. So $s_C^i \in \mathsf{Term}^c (\Sigma(M^i, \mathsf{x}_C))_C$ is a closed term of sort C with $\mathbb{T}(M^i, \mathsf{x}_C) \vdash s_C^i \downarrow$. Then $\rho_{M^i}^C(s_C^i) \in \mathsf{Term}^c (\Sigma^{\mathcal{J}}(M, \mathsf{x}_{C^i}))_{C^i}$ and $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{C^i}) \vdash \rho_{M^i}^C(s_C^i) \downarrow$, since $\rho_{M^i}^C : \mathbb{T}(M^i, \mathsf{x}_C) \to \mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{C^i})$ is a theory morphism by Lemma 3.13.

Suppose first that $\mathbb{T}(M^i)$ is *non-trivial* for the sort C. Then $i \in \mathsf{ob}\mathcal{J}_C^M$ and $\psi_C(i) : i \xrightarrow{\sim} i$ is an isomorphism in \mathcal{J} . So then $\alpha_{\psi_C(i)}^C : C^i \to C^i$ is a function symbol of $\Sigma^{\mathcal{J}}$ and $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{C^i}) \vdash \alpha_{\psi_C(i)}^C(\mathsf{x}_{C^i}) \downarrow$, and it then follows by [7, Lemma 2.2.24] that $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{C^i}) \vdash \rho_{M^i}^C(s_C^i) \left[\alpha_{\psi_C(i)}^C(\mathsf{x}_{C^i})/\mathsf{x}_{C^i}\right] \downarrow$. So then $\left[\rho_{M^i}^C(s_C^i) \left[\alpha_{\psi_C(i)}^C(\mathsf{x}_{C^i})/\mathsf{x}_{C^i}\right]\right] \in M \langle \mathsf{x}_{C^i} \rangle_{C^i}$, and we therefore set

$$\beta_M(\gamma,\psi)_{C^i} := \left[\rho_{M^i}^C\left(s_C^i\right)\left[\alpha_{\psi_C(i)}^C(\mathsf{x}_{C^i})/\mathsf{x}_{C^i}\right]\right] \in M \langle \mathsf{x}_{C^i} \rangle_{C^i}.$$

If $\mathbb{T}(M^i)$ is trivial for the sort C, then we simply set $\beta_M(\gamma, \psi)_{C^i} := [\mathsf{x}_{C^i}] \in M \langle \mathsf{x}_{C^i} \rangle_{C^i}$. It is then shown in the proof of [7, Proposition 5.1.20] that β_M is well-defined. We now prove in a series of claims that $\beta_M(\gamma, \psi) \in G_{\mathbb{T}^{\mathcal{J}}}(M)$.

Claim 3.20. $\beta_M(\gamma, \psi)$ is invertible.

Proof. Let $i \in \text{ob}\mathcal{J}$ and $C \in \Sigma_{\text{Sort}}$. The result is trivial to verify if $\mathbb{T}(M^i)$ is trivial for the sort C, so assume otherwise. Since $\gamma_i \in G_{\mathbb{T}}(M^i)$, there is some $\left[\left(s_C^i\right)^{-1}\right] \in M^i \langle \mathsf{x}_C \rangle_C$ with

$$\left[s_{C}^{i}\left[\left(s_{C}^{i}\right)^{-1}/\mathsf{x}_{C}\right]\right] = \left[\mathsf{x}_{C}\right] = \left[\left(s_{C}^{i}\right)^{-1}\left[s_{C}^{i}/\mathsf{x}_{C}\right]\right] \in M^{i}\langle\mathsf{x}_{C}\rangle_{C}$$

i.e.

$$\mathbb{T}\left(M^{i},\mathsf{x}_{C}\right) \vdash s_{C}^{i}\left[\left(s_{C}^{i}\right)^{-1}/\mathsf{x}_{C}\right] = \mathsf{x}_{C} = \left(s_{C}^{i}\right)^{-1}\left[s_{C}^{i}/\mathsf{x}_{C}\right].$$

Now consider $\rho_{M^{i}}^{C}\left(\left(s_{C}^{i}\right)^{-1}\right) \in \operatorname{Term}^{c}\left(\Sigma^{\mathcal{J}}\left(M,\mathsf{x}_{C^{i}}\right)\right)_{C^{i}}$: since $\mathbb{T}\left(M^{i},\mathsf{x}_{C}\right) \vdash \left(s_{C}^{i}\right)^{-1} \downarrow$, it follows from Lemma 3.13 that $\mathbb{T}^{\mathcal{J}}\left(M,\mathsf{x}_{C^{i}}\right) \vdash \rho_{M^{i}}^{C}\left(\left(s_{C}^{i}\right)^{-1}\right) \downarrow$. Then because $\alpha_{\psi_{C}(i)^{-1}}^{C}: C^{i} \to C^{i}$ is provably total in $\mathbb{T}^{\mathcal{J}}$, we obtain $\mathbb{T}^{\mathcal{J}}\left(M,\mathsf{x}_{C^{i}}\right) \vdash \alpha_{\psi_{C}(i)^{-1}}^{C}\left(\rho_{M^{i}}^{C}\left(\left(s_{C}^{i}\right)^{-1}\right)\right) \downarrow$, so that

$$\left[\alpha_{\psi_C(i)^{-1}}^C\left(\rho_{M^i}^C\left(\left(s_C^i\right)^{-1}\right)\right)\right] \in M \langle \mathsf{x}_{C^i} \rangle_{C^i}.$$

So we set

$$\beta_{M}(\gamma,\psi)_{C^{i}}^{-1} := \left[\alpha_{\psi_{C}(i)^{-1}}^{C} \left(\rho_{M^{i}}^{C} \left(\left(s_{C}^{i}\right)^{-1}\right)\right)\right],$$

and it is now straightforward to show (as in the proof of [7, Proposition 5.1.20]) that this is a substitutional inverse of $\beta_M(\gamma, \psi)_{C^i}$, which proves that $\beta_M(\gamma, \psi)$ is invertible.

Claim 3.21. $\beta_M(\gamma, \psi)$ commutes generically with all function symbols of $\Sigma^{\mathcal{J}}$.

Proof. First let $i \in \text{ob}\mathcal{J}$ and let $g: A_1 \times \ldots \times A_n \to A$ be a function symbol of Σ . We must show that $\beta_M(\gamma, \psi)$ commutes generically with the function symbol $g^i: A_1^i \times \ldots \times A_n^i \to A^i$ of $\Sigma^{\mathcal{J}}$. Assume without loss of generality that $\mathbb{T}(M^i)$ is non-trivial for each of the sorts A_1, \ldots, A_n, A ; if this is *not* the case, then the argument required is a simpler version of the one we are about to give.

We must show that the sequent

$$g^{i}\left(\mathsf{x}_{A_{1}^{i}},\ldots,\mathsf{x}_{A_{n}^{i}}\right)\downarrow \vdash \left\{\rho_{M^{i}}^{A}\left(s_{A}^{i}\right)\left[\alpha_{\psi_{A}(i)}^{A}(\mathsf{x}_{A^{i}})/\mathsf{x}_{A^{i}}\right]\right\}\left[g^{i}\left(\mathsf{x}_{A_{1}^{i}},\ldots,\mathsf{x}_{A_{n}^{i}}\right)/\mathsf{x}_{A^{i}}\right]$$
$$=g^{i}\left(\rho_{M^{i}}^{A_{1}}\left(s_{A_{1}}^{i}\right)\left[\alpha_{\psi_{A_{1}}(i)}^{A_{1}}\left(\mathsf{x}_{A_{1}^{i}}\right)/\mathsf{x}_{A_{1}^{i}}\right],\ldots,\rho_{M^{i}}^{A_{n}}\left(s_{A_{n}}^{i}\right)\left[\alpha_{\psi_{A_{n}}(i)}^{A_{n}}\left(\mathsf{x}_{A_{n}^{i}}\right)/\mathsf{x}_{A_{n}^{i}}\right]\right)$$

is provable in the theory $\mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{A_{1}^{i}}, \ldots, \mathsf{x}_{A_{n}^{i}}\right)$ (technically, we need to ensure that the indeterminates on the right side of the equation are pairwise distinct (see Definition 2.16), but we will ignore this subtlety here and elsewhere in the proof to increase readability). Since $\gamma_{i} \in G_{\mathbb{T}}\left(M^{i}\right)$, we know that the sequent

$$g(\mathsf{x}_{A_1},\ldots,\mathsf{x}_{A_n}) \downarrow \vdash s_A^i \left[g(\mathsf{x}_{A_1},\ldots,\mathsf{x}_{A_n}) / \mathsf{x}_A \right] = g\left(s_{A_1}^i,\ldots,s_{A_n}^i \right) \tag{*}$$

is provable in the theory $\mathbb{T}(M^i, \mathsf{x}_{A_1}, \dots, \mathsf{x}_{A_n})$. As in Definition 3.12 and Lemma 3.13, we can define a signature morphism $\rho_{M^i}^{\vec{A}}: \Sigma(M^i, \mathsf{x}_{A_1}, \dots, \mathsf{x}_{A_n}) \to \Sigma^{\mathcal{J}}(M, \mathsf{x}_{A_1^i}, \dots, \mathsf{x}_{A_n^i})$ that will be a theory morphism

$$\rho_{M^{i}}^{\vec{A}}:\mathbb{T}\left(M^{i},\mathsf{x}_{A_{1}},\ldots,\mathsf{x}_{A_{n}}\right)\to\mathbb{T}^{\mathcal{J}}\left(M,\mathsf{x}_{A_{1}^{i}},\ldots,\mathsf{x}_{A_{n}^{i}}\right);$$

on $\Sigma(M^i)$, we define $\rho_{M^i}^{\vec{A}}$ as in Definition 3.12, and for any $1 \leq j \leq n$ we set $\rho_{M^i}^{\vec{A}}(\mathsf{x}_{A_j}) := \mathsf{x}_{A_j^i}$ (here $\vec{A} = A_1, \ldots, A_n$). Then it is obvious that for any $1 \leq j \leq n$, the signature morphism $\rho_{M^i}^{\vec{A}}$ agrees with the signature morphism $\rho_{M^i}^{\vec{A}} : \Sigma(M^i, \mathsf{x}_{A_j}) \to \Sigma^{\mathcal{J}}(M, \mathsf{x}_{A_j^i})$ when restricted to $\Sigma(M^i, \mathsf{x}_{A_j})$, which implies that $\rho_{M^i}^{\vec{A}}(s_{A_j}^i) \equiv \rho_{M^i}^{A_j}(s_{A_j}^i)$ for all $1 \leq j \leq n$. Also (by Lemma 3.14), we have

$$\rho_{M^{i}}^{A}\left(s_{A}^{i}\right)\left[g^{i}\left(\mathsf{x}_{A_{1}^{i}},\ldots,\mathsf{x}_{A_{n}^{i}}\right)/\mathsf{x}_{A^{i}}\right]\equiv\rho_{M^{i}}^{\vec{A}}\left(s_{A}^{i}\left[g(\mathsf{x}_{A_{1}},\ldots,\mathsf{x}_{A_{n}})/\mathsf{x}_{A}\right]\right).$$

Now, since $\rho_{M^i}^{\vec{A}}$: $\mathbb{T}(M^i, \mathsf{x}_{A_1}, \dots, \mathsf{x}_{A_n}) \to \mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A_1^i}, \dots, \mathsf{x}_{A_n^i})$ is a theory morphism, it follows that the $\rho_{M^i}^{\vec{A}}$ -translation of the aforementioned sequent (*) provable in $\mathbb{T}(M^i, \mathsf{x}_{A_1}, \dots, \mathsf{x}_{A_n})$ will be provable in $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A_1^i}, \dots, \mathsf{x}_{A_n^i})$. In other words, the following sequent is provable in $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A_1^i}, \dots, \mathsf{x}_{A_n^i})$:

$$g^{i}\left(\mathsf{x}_{A_{1}^{i}},\ldots,\mathsf{x}_{A_{n}^{i}}\right)\downarrow \ \vdash \rho_{M^{i}}^{A}\left(s_{A}^{i}\right)\left[g^{i}\left(\mathsf{x}_{A_{1}^{i}},\ldots,\mathsf{x}_{A_{n}^{i}}\right)/\mathsf{x}_{A^{i}}\right] = g^{i}\left(\rho_{M^{i}}^{A_{1}}\left(s_{A_{1}}^{i}\right),\ldots,\rho_{M^{i}}^{A_{n}}\left(s_{A_{n}}^{i}\right)\right).$$

Now, let us reason in the theory $\mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{A_{1}^{i}}, \dots, \mathsf{x}_{A_{n}^{i}}\right) \cup \left\{\top \vdash g^{i}\left(\mathsf{x}_{A_{1}^{i}}, \dots, \mathsf{x}_{A_{n}^{i}}\right)\downarrow\right\}$ (referred to as the 'expanded theory' for the rest of this argument), one of whose theorems is therefore the preceding equation. By substituting $\alpha_{\psi_{A}(i)}^{A_{1}}\left(\mathsf{x}_{A_{1}^{i}}\right)$ for $\mathsf{x}_{A_{1}^{i}}, \dots, \alpha_{\psi_{A}(i)}^{A_{n}}\left(\mathsf{x}_{A_{n}^{i}}\right)$ for $\mathsf{x}_{A_{n}^{i}}$, the following equation is then provable in the expanded theory:

$$\rho_{M^{i}}^{A}\left(s_{A}^{i}\right)\left[g^{i}\left(\alpha_{\psi_{A}(i)}^{A_{1}}\left(\mathsf{x}_{A_{1}^{i}}\right),\ldots,\alpha_{\psi_{A}(i)}^{A_{n}}\left(\mathsf{x}_{A_{n}^{i}}\right)\right)/\mathsf{x}_{A^{i}}\right]$$

$$=g^{i}\left(\rho_{M^{i}}^{A_{1}}\left(s_{A_{1}}^{i}\right)\left[\alpha_{\psi_{A}(i)}^{A_{1}}\left(\mathsf{x}_{A_{1}^{i}}\right)/\mathsf{x}_{A_{1}^{i}}\right],\ldots,\rho_{M^{i}}^{A_{n}}\left(s_{A_{n}}^{i}\right)\left[\alpha_{\psi_{A}(i)}^{A_{n}}\left(\mathsf{x}_{A_{n}^{i}}\right)/\mathsf{x}_{A_{n}^{i}}\right]\right).$$

Since the expanded theory (because of Axiom 3.5.4) proves the equation

$$g^{i}\left(\alpha_{\psi_{A}(i)}^{A_{1}}\left(\mathsf{x}_{A_{1}^{i}}\right),\ldots,\alpha_{\psi_{A}(i)}^{A_{n}}\left(\mathsf{x}_{A_{n}^{i}}\right)\right)=\alpha_{\psi_{A}(i)}^{A}\left(g^{i}\left(\mathsf{x}_{A_{1}^{i}},\ldots,\mathsf{x}_{A_{n}^{i}}\right)\right),$$

it follows that the expanded theory proves the equation

$$\rho_{M^{i}}^{A}\left(s_{A}^{i}\right)\left[\alpha_{\psi_{A}(i)}^{A}\left(g^{i}\left(\mathsf{x}_{A_{1}^{i}},\ldots,\mathsf{x}_{A_{n}^{i}}\right)\right)/\mathsf{x}_{A^{i}}\right] = g^{i}\left(\rho_{M^{i}}^{A_{1}}\left(s_{A_{1}}^{i}\right)\left[\alpha_{\psi_{A}(i)}^{A_{1}}\left(\mathsf{x}_{A_{1}^{i}}\right)/\mathsf{x}_{A_{1}^{i}}\right],\ldots,\rho_{M^{i}}^{A_{n}}\left(s_{A_{n}}^{i}\right)\left[\alpha_{\psi_{A}(i)}^{A_{n}}\left(\mathsf{x}_{A_{n}^{i}}\right)/\mathsf{x}_{A_{n}^{i}}\right]\right)$$

i.e. the expanded theory proves the equation

$$\begin{pmatrix} \rho_{M^{i}}^{A}\left(s_{A}^{i}\right)\left[\alpha_{\psi_{A}\left(i\right)}^{A}\left(\mathsf{x}_{A^{i}}\right)/\mathsf{x}_{A^{i}}\right] \end{pmatrix}\left[g^{i}\left(\mathsf{x}_{A_{1}^{i}},\ldots,\mathsf{x}_{A_{n}^{i}}\right)/\mathsf{x}_{A^{i}}\right] \\ = g^{i}\left(\rho_{M^{i}}^{A_{1}}\left(s_{A_{1}}^{i}\right)\left[\alpha_{\psi_{A}\left(i\right)}^{A_{1}}\left(\mathsf{x}_{A_{1}^{i}}\right)/\mathsf{x}_{A_{1}^{i}}\right],\ldots,\rho_{M^{i}}^{A_{n}}\left(s_{A_{n}}^{i}\right)\left[\alpha_{\psi_{A}\left(i\right)}^{A_{n}}\left(\mathsf{x}_{A_{n}^{i}}\right)/\mathsf{x}_{A_{n}^{i}}\right]\right).$$

So to complete the argument, it remains to show (by the deduction theorem in [5, Theorem 10]) that the expanded theory proves the equation

$$g^{i}\left(\rho_{M^{i}}^{A_{1}}\left(s_{A_{1}}^{i}\right)\left[\alpha_{\psi_{A_{1}}(i)}^{A_{1}}\left(\mathsf{x}_{A_{1}^{i}}\right)/\mathsf{x}_{A_{1}^{i}}\right],\ldots,\rho_{M^{i}}^{A_{n}}\left(s_{A_{n}}^{i}\right)\left[\alpha_{\psi_{A_{n}}(i)}^{A_{n}}\left(\mathsf{x}_{A_{n}^{i}}\right)/\mathsf{x}_{A_{n}^{i}}\right]\right)$$
$$=g^{i}\left(\rho_{M^{i}}^{A_{1}}\left(s_{A_{1}}^{i}\right)\left[\alpha_{\psi_{A}(i)}^{A_{1}}\left(\mathsf{x}_{A_{1}^{i}}\right)/\mathsf{x}_{A_{1}^{i}}\right],\ldots,\rho_{M^{i}}^{A_{n}}\left(s_{A_{n}}^{i}\right)\left[\alpha_{\psi_{A}(i)}^{A_{n}}\left(\mathsf{x}_{A_{n}^{i}}\right)/\mathsf{x}_{A_{n}^{i}}\right]\right)$$

(the difference in the two terms being the ψ -subscripts). It suffices to show that for any position $1 \leq m \leq n$, we can 'swap' $\rho_{M^i}^{A_m}(s_{A_m}^i) \left[\alpha_{\psi_{A_m}(i)}^{A_m}(\mathbf{x}_{A_m^i}) \right]$ for $\rho_{M^i}^{A_m}(s_{A_m}^i) \left[\alpha_{\psi_A(i)}^{A_m}(\mathbf{x}_{A_m^i}) \right]$ within position m in g^i (modulo the expanded theory). If g^{M^i} is degenerate in position m, then this easily follows by the definition of 'degenerate' (see Definition 3.10): specifically, if $\mathbb{T}(M^i)$ proves the equation in Definition 3.10 for g, then it follows from Lemma 3.13 that $\mathbb{T}^{\mathcal{J}}(M)$ will prove the corresponding equation for g^i .

Otherwise, if g^{M^i} is non-degenerate in position m, then since $\psi \in \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$, it follows that $\psi_{A_m}(i) = \psi_A(i) : i \xrightarrow{\sim} i$, which again easily yields the desired result. This completes the proof that $\beta_M(\gamma, \psi)$ commutes generically with the function symbol g^i of $\Sigma^{\mathcal{J}}$.

Now let $B \in \Sigma_{\text{Sort}}$ and let $f : i \to j$ be an arbitrary morphism in \mathcal{J} . We must show that $\beta_M(\gamma, \psi)$ commutes generically with the function symbol $\alpha_f^B : B^i \to B^j$ of $\Sigma^{\mathcal{J}}$. Suppose first that both $\mathbb{T}(M^i)$ and $\mathbb{T}(M^j)$ are non-trivial for the sort B. Then we must show that the equation

$$\left\{\rho_{M^{j}}^{B}\left(s_{B}^{j}\right)\left[\alpha_{\psi_{B}\left(j\right)}^{B}\left(\mathsf{x}_{B^{j}}\right)/\mathsf{x}_{B^{j}}\right]\right\}\left[\alpha_{f}^{B}\left(\mathsf{x}_{B^{i}}\right)/\mathsf{x}_{B^{j}}\right] = \alpha_{f}^{B}\left(\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\left[\alpha_{\psi_{B}\left(i\right)}^{B}\left(\mathsf{x}_{B^{i}}\right)/\mathsf{x}_{B^{i}}\right]\right)$$

is provable in $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^{i}})$ (since α_{f}^{B} is provably total in $\mathbb{T}^{\mathcal{J}}$). Since $\gamma \in (\prod_{i} G_{\mathbb{T}}(M^{i}))^{\mathcal{J}}$, we know that $G_{\mathbb{T}}(F^{M}(f))(\gamma_{i}) = \gamma_{j}$, i.e.

$$G_{\mathbb{T}}\left(F^{M}(f)\right)\left(\left(\left[s_{C}^{i}\right]\right)_{C\in\Sigma}\right) = \left(\left[s_{C}^{j}\right]\right)_{C\in\Sigma}$$

Recalling our earlier convention that $f^M := F^M(f) : M^i \to M^j$, this equality means that

$$\left(\left[\rho_{f^{M}}^{C}\left(s_{C}^{i}\right)\right]\right)_{C\in\Sigma}=\left(\left[s_{C}^{j}\right]\right)_{C\in\Sigma}\in G_{\mathbb{T}}\left(M^{j}\right)$$

(see [7, Definition 2.2.36]). In particular, for our fixed sort B we have $\left[\rho_{f^M}^B\left(s_B^i\right)\right] = \left[s_B^j\right] \in M^j \langle \mathsf{x}_B \rangle_B$, which means that $\mathbb{T}\left(M^j, \mathsf{x}_B\right) \vdash \rho_{f^M}^B\left(s_B^i\right) = s_B^j$. Since $\rho_{M^j}^B : \mathbb{T}\left(M^j, \mathsf{x}_B\right) \to \mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{B^j}\right)$ is a theory morphism by Lemma 3.13, we then have

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{j}}) \vdash \rho^{B}_{M^{j}}\left(\rho^{B}_{f^{M}}\left(s^{i}_{B}\right)\right) = \rho^{B}_{M^{j}}\left(s^{j}_{B}\right).$$

And since $\sigma_f^B : \mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^j}) \to \mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^i})$ is a theory morphism by Lemma 3.16, we obtain

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash \sigma_{f}^{B}\left(\rho_{M^{j}}^{B}\left(\rho_{f^{M}}^{B}\left(s_{B}^{i}\right)\right)\right) = \sigma_{f}^{B}\left(\rho_{M^{j}}^{B}\left(s_{B}^{j}\right)\right),$$

i.e. (see Definition 3.17)

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash \tau_{f}^{B}\left(s_{B}^{i}\right) = \sigma_{f}^{B}\left(\rho_{M^{j}}^{B}\left(s_{B}^{j}\right)\right).$$

Also, since $\sigma_f^B : \Sigma^{\mathcal{J}}(M, \mathsf{x}_{B^j}) \to \Sigma^{\mathcal{J}}(M, \mathsf{x}_{B^i})$ is the identity except for the fact that $\sigma_f^B(\mathsf{x}_{B^j}) := \alpha_f^B(\mathsf{x}_{B^i})$, it easily follows that

$$\sigma_f^B\left(\rho_{M^j}^B\left(s_B^j\right)\right) \equiv \rho_{M^j}^B\left(s_B^j\right)\left[\alpha_f^B(\mathsf{x}_{B^i})/\mathsf{x}_{B^j}\right].$$

So we have

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash \tau_{f}^{B}\left(s_{B}^{i}\right) = \rho_{M^{j}}^{B}\left(s_{B}^{j}\right)\left[\alpha_{f}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{j}}\right].$$

Finally, since $\mathbb{T}(M^i, \mathsf{x}_B) \vdash s^i_B \downarrow$, it follows from Lemma 3.18 that

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash \tau_{f}^{B}\left(s_{B}^{i}\right) = \alpha_{f}^{B}\left(\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\right)$$

Combining this equation with the previous one, we then have

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash \rho^{B}_{M^{j}}\left(s^{j}_{B}\right) \left[\alpha^{B}_{f}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{j}}\right] = \alpha^{B}_{f}\left(\rho^{B}_{M^{i}}\left(s^{i}_{B}\right)\right).$$

Substituting $\alpha^B_{\psi_B(i)}(\mathsf{x}_{B^i})$ for x_{B^i} and applying [7, Lemma 2.2.24], $\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^i})$ then proves the equation

$$\rho_{M^{j}}^{B}\left(s_{B}^{j}\right)\left[\alpha_{f}^{B}\left(\alpha_{\psi_{B}(i)}^{B}(\mathsf{x}_{B^{i}})\right)/\mathsf{x}_{B^{j}}\right] = \alpha_{f}^{B}\left(\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\left[\alpha_{\psi_{B}(i)}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{i}}\right]\right).$$

So to complete the argument, it remains to prove that $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^{i}})$ proves the equation

$$\rho_{M^{j}}^{B}\left(s_{B}^{j}\right)\left[\alpha_{f}^{B}\left(\alpha_{\psi_{B}(i)}^{B}(\mathsf{x}_{B^{i}})\right)/\mathsf{x}_{B^{j}}\right] = \left\{\rho_{M^{j}}^{B}\left(s_{B}^{j}\right)\left[\alpha_{\psi_{B}(j)}^{B}(\mathsf{x}_{B^{j}})/\mathsf{x}_{B^{j}}\right]\right\}\left[\alpha_{f}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{j}}\right].$$

But the following sequence of equations is provable in $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^{i}})$, as desired:

$$\begin{cases} \rho_{M^{j}}^{B} \left(s_{B}^{j}\right) \left[\alpha_{\psi_{B}(j)}^{B} \left(\mathsf{x}_{B^{j}}\right) / \mathsf{x}_{B^{j}}\right] \right\} \left[\alpha_{f}^{B} \left(\mathsf{x}_{B^{i}}\right) / \mathsf{x}_{B^{j}}\right] \\ \equiv \rho_{M^{j}}^{B} \left(s_{B}^{j}\right) \left[\alpha_{\psi_{B}(j)}^{B} \left(\alpha_{f}^{B} \left(\mathsf{x}_{B^{i}}\right)\right) / \mathsf{x}_{B^{j}}\right] \\ = \rho_{M^{j}}^{B} \left(s_{B}^{j}\right) \left[\alpha_{\psi_{B}(j)\circ f}^{B} \left(\mathsf{x}_{B^{i}}\right) / \mathsf{x}_{B^{j}}\right] \\ = \rho_{M^{j}}^{B} \left(s_{B}^{j}\right) \left[\alpha_{f\circ\psi_{B}(i)}^{B} \left(\mathsf{x}_{B^{i}}\right) / \mathsf{x}_{B^{j}}\right] \\ = \rho_{M^{j}}^{B} \left(s_{B}^{j}\right) \left[\alpha_{f}^{B} \left(\alpha_{\psi_{B}(i)}^{B} \left(\mathsf{x}_{B^{i}}\right)\right) / \mathsf{x}_{B^{j}}\right]; \end{cases}$$

the second equality follows by Axiom 3.5.3, the third by naturality of $\psi_B \in \operatorname{Aut}\left(\operatorname{Id}_{\mathcal{J}_B^M}\right)$, and the last by Axiom 3.5.3 again.

Now suppose that $\mathbb{T}(M^i)$ is trivial for the sort B, which implies that $\mathbb{T}(M^i, \mathsf{x}_B)$ is also trivial for the sort B. Given the morphism $f: i \to j$, we have the induced Σ -morphism $f^M: M^i \to M^j$, which in turn induces the theory morphism $\rho_{f^M}^B: \mathbb{T}(M^i, \mathsf{x}_B) \to \mathbb{T}(M^j, \mathsf{x}_B)$, the existence of which implies that $\mathbb{T}(M^j, \mathsf{x}_B)$ is also trivial for the sort B. But by Lemma 3.13, it then easily follows that $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^j})$ is trivial for the sort B^j , and hence will prove all equations between terms of this sort, which clearly yields the desired result. And if $\mathbb{T}(M^j)$ is trivial for the sort B, then $\mathbb{T}(M^j, \mathsf{x}_B)$ is trivial for the sort B, which then also yields the desired result, as just explained. This completes the proof that $\beta_M(\gamma, \psi)$ commutes generically with α_f^B , which in turn completes the proof that $\beta_M(\gamma, \psi)$ commutes generically with all function symbols of $\Sigma^{\mathcal{J}}$.

Claim 3.22. $\beta_M(\gamma, \psi)$ reflects definedness.

Proof. This can be proven analogously to the previous claim; we refer the reader to [7, Claim 5.1.23] for the details. \Box

With the preceding claims, we have now proved that

$$\beta_M : \left(\prod_i G_{\mathbb{T}}\left(M^i\right)\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M \to G_{\mathbb{T}^{\mathcal{J}}}(M)$$

is a well-defined function. To complete the proof of Proposition 3.19, it remains to show that β_M preserves the group multiplication, which is not too difficult; we refer the reader to the proof of [7, Proposition 5.1.20] for this verification.

Our next step is to show that the group homomorphism β_M is *bijective*. To motivate our proof of this, let us assume for simplicity that \mathbb{T} has just one sort X, so that $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M = \operatorname{Aut}\left(\operatorname{Id}_{\mathcal{J}_X^M}\right)$ for any $M \in \mathbb{T}^{\mathcal{J}} \operatorname{mod}$. Assume also for simplicity that $M \in \mathbb{T}^{\mathcal{J}} \operatorname{mod}$ is such that each $M^i \in \mathbb{T} \operatorname{mod}$ for $i \in \operatorname{ob} \mathcal{J}$ is non-trivial for the unique sort X, so that $\operatorname{Aut}\left(\operatorname{Id}_{\mathcal{J}_X^M}\right) = \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})$ and the group homomorphism

$$\beta_M : \left(\prod_i G_{\mathbb{T}}\left(M^i\right)\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}}) \to G_{\mathbb{T}^{\mathcal{J}}}(M)$$

is defined as in the proof of Proposition 3.19 by

$$\left([s_i]_{i\in\mathsf{ob}\mathcal{J}},\psi\right)\mapsto\left(\left[\rho_{M^i}\left(s_i\right)\left[\alpha_{\psi(i)}(\mathsf{x}_i)/\mathsf{x}_i\right]\right]\right)_{i\in\mathsf{ob}\mathcal{J}},$$

where we have suppressed the subscripts and superscripts for the unique sort X of T. To show that this assignment is bijective, we will essentially reason as follows. First, we show in Lemma 3.25 that any closed term $u \in \operatorname{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_i)\right)$ for $i \in \operatorname{ob}\mathcal{J}$ has a 'normal form' u' in which all function symbols of $\Sigma^{\mathcal{J}}$ of the form α_f for $f \in \operatorname{mor}\mathcal{J}$ are 'pushed inside as far as possible', and we call any term in this normal form an α -restricted term. In Definition 3.27 we then show that we can take any α -restricted term $u \in$ $\operatorname{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_i)\right)$, replace any subterm in it of the form $\alpha_f(\mathsf{x}_i)$ by a new constant symbol $\mathsf{x}_f : X$, and thereby obtain an induced term $\theta(u)$ of the signature $\Sigma\left(M^i\right)$ augmented by these new constants x_f indexed by $\operatorname{mor}\mathcal{J}$. We then show in Proposition 3.28 that this process preserves the provability of equations in $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_i)$. In Definition 3.30 we also show that we can erase the various morphism subscripts from these new constants x_f to obtain from $\theta(u)$ a term $\theta^*(u)$ over the more familiar signature $\Sigma\left(M^i,\mathsf{x}\right)$, and we show in Lemma 3.32 that the mapping θ^* preserves the provability of a certain kind of sequent in $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_i)$, and in Lemma 3.33 that it preserves the provability of equations. After some further technical lemmas regarding θ and θ^* , we finally prove in Proposition 3.41 that β_M is injective. The idea behind this proof is roughly as follows: if $([s_i]_{i \in \mathsf{ob}\mathcal{J}, \psi)$ is an element of the domain of β_M for which $[\rho_{M^i}(s_i) [\alpha_{\psi(i)}(\mathsf{x}_i)/\mathsf{x}_i]] = [\mathsf{x}_i]$ holds in $M \langle \mathsf{x}_i \rangle_i$, i.e. for which $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_i) \vdash \rho_{M^i}(s_i) [\alpha_{\psi(i)}(\mathsf{x}_i)/\mathsf{x}_i] = \mathsf{x}_i$ for each $i \in \mathsf{ob}\mathcal{J}$, then we can essentially show using the aforementioned results that the equation $s_i [\mathsf{x}_{\psi(i)}/\mathsf{x}] = \mathsf{x}_{\mathsf{id}_i}$ is provable in the theory $\mathbb{T}(M^i)$ augmented by the new constants x_f for $f \in \mathsf{mor}\mathcal{J}$, which then (by Lemma 3.29) forces $\psi(i) = \mathsf{id}_i$ and thereby entails $\mathbb{T}(M^i,\mathsf{x}) \vdash s_i = \mathsf{x}$, as desired.

To prove in Proposition 3.45 that β_M is surjective, we need to impose two conditions on \mathbb{T} in Definitions 3.43 and 3.44. Given an arbitrary element $([s_i])_{i\in ob\mathcal{J}} \in G_{\mathbb{T}^{\mathcal{J}}}(M)$, we can assume without loss of generality that each s_i is in α -restricted normal form. We then apply θ^* to each s_i to obtain $[\theta^*(s_i)] \in M^i \langle x \rangle$ for each $i \in ob\mathcal{J}$, and we show using the aforementioned results that $([\theta^*(s_i)])_{i\in ob\mathcal{J}} \in (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}}$. To construct an appropriate natural automorphism $\psi : \mathsf{ld}_{\mathcal{J}} \xrightarrow{\sim} \mathsf{ld}_{\mathcal{J}}$, we use the two aforementioned assumptions on \mathbb{T} . The assumption of Definition 3.43 guarantees that each s_i can be assumed to have exactly *one* occurrence of x_i , and hence exactly one subterm of the form $\alpha_f(x_i)$ for an endomorphism $f : i \to i$, which we choose to be $\psi(i)$. We then show that ψ , so defined, is a natural automorphism of $\mathsf{ld}_{\mathcal{J}}$. Using the second assumption on \mathbb{T} in Definition 3.44, we then show that if \mathbb{T} is not single-sorted, then the various natural automorphisms $\psi_B : \mathsf{ld}_{\mathcal{J}_B^M} \xrightarrow{\sim} \mathsf{ld}_{\mathcal{J}_B^M}$ for $B \in \Sigma_{\mathsf{Sort}}$ are compatible with each other in the sense of Definition 3.11, so that $(\psi_B)_{B\in\Sigma} \in \mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})^M$. Let us now embark on providing the details.

For any category \mathbb{C} and object $C \in ob\mathbb{C}$, we let $\mathsf{Dom}(C)$ be the class of all morphisms in \mathbb{C} with domain C (which is certainly a set if \mathbb{C} is small).

Definition 3.23. If $M \in \mathbb{T}^{\mathcal{J}} \mod \text{and } u \in \operatorname{Term}^{c} \left(\Sigma^{\mathcal{J}} (M, \mathsf{x}_{A^{i}}) \right)$ for some $A \in \Sigma_{\mathsf{Sort}}$ and $i \in \mathsf{ob}\mathcal{J}$, then we say that u is α -restricted if the only subterms of u of the form $\alpha_{f}^{C}(v)$ are those with C = A and $v \equiv \mathsf{x}_{A^{i}}$ and $\mathsf{dom}(f) = i$.

In other words, the term $u \in \operatorname{Term}^{c} (\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}))$ is α -restricted if all ' α -subterms' of u have the form $\alpha_{f}^{A}(\mathsf{x}_{A^{i}})$ for some $f \in \mathsf{Dom}(i)$.

Essentially, an α -restricted term is a term in which all of the α -function symbols have been 'pushed inside as far as possible'. In order to prove that every (provably defined) term has an α -restricted equivalent, we require the following lemma, whose proof may be found in [7, Lemma 5.1.26]:

Lemma 3.24. Let $M \in \mathbb{T}^{\mathcal{J}} \mod and$ let $u \in \operatorname{Term}^{c} \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}) \right)$ be α -restricted, where $A \in \Sigma_{\mathsf{Sort}}$ and $i \in \mathsf{ob}\mathcal{J}$. If $u : C^{j}$ for some $j \in \mathsf{ob}\mathcal{J}$ and $C \in \Sigma_{\mathsf{Sort}}$, then for any morphism $f : j \to \mathsf{cod}(f)$ in \mathcal{J} , there is an α -restricted term $u^{f} \in \operatorname{Term}^{c} \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}) \right)$ with $u^{f} : C^{\mathsf{cod}(f)}$ and $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A^{i}})$ proves the sequent $u \downarrow \vdash \alpha_{f}^{C}(u) = u^{f}$.

With the help of Lemma 3.24 we can now show that any term has an α -restricted equivalent; the proof may be found in [7, Lemma 5.1.27]:

Lemma 3.25. If $M \in \mathbb{T}^{\mathcal{J}} \mod and \ u \in \operatorname{Term}^{c} \left(\Sigma^{\mathcal{J}} \left(M, \mathsf{x}_{A^{i}} \right) \right)$ for some $A \in \Sigma_{\mathsf{Sort}}$ and $i \in \mathsf{ob}\mathcal{J}$, then there is an α -restricted term $u' \in \operatorname{Term}^{c} \left(\Sigma^{\mathcal{J}} \left(M, \mathsf{x}_{A^{i}} \right) \right)$ of the same sort such that $\mathbb{T}^{\mathcal{J}} (M, \mathsf{x}_{A^{i}})$ proves the sequent $u \downarrow \vdash u = u'$.

It is trivial to verify (from the proof of Lemma 3.25) that if $u \in \operatorname{Term}^{c}(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}))$ is already α -restricted, then $u \equiv u'$. We now discuss the augmentation of the various signatures $\Sigma(M^{k})$ (for $M \in \mathbb{T}^{\mathcal{J}} \mod k \in \mathsf{ob}\mathcal{J}$) by new constants indexed by $\operatorname{mor}\mathcal{J}$:

Definition 3.26. Let $M \in \mathbb{T}^{\mathcal{J}} \mod$.

- For any $k \in ob\mathcal{J}$, let $Cod(k) := \{f \in mor\mathcal{J} : cod(f) = k\}$. For any $k \in ob\mathcal{J}$ and $B \in \Sigma_{Sort}$, let $\Sigma\left(M^k, \overline{\mathsf{x}^B_{Cod(k)}}\right)$ be the signature obtained from $\Sigma\left(M^k\right)$ by adding pairwise distinct new constant symbols $\mathsf{x}^B_f : B$ for every $f \in Cod(k)$.
- For any $k \in \mathsf{ob}\mathcal{J}$ and $B \in \Sigma_{\mathsf{Sort}}$, let $\mathbb{T}\left(M^k, \overline{\mathsf{x}^B_{\mathsf{Cod}(k)}}\right)$ be the quasi-equational theory over the signature $\Sigma\left(M^k, \overline{\mathsf{x}^B_{\mathsf{Cod}(k)}}\right)$ obtained from $\mathbb{T}\left(M^k\right)$ by adding the axioms $\top \vdash \mathsf{x}^B_f \downarrow$ for every $f \in \mathsf{Cod}(k)$. \Box

Definition 3.27. Let $M \in \mathbb{T}^{\mathcal{J}} \mod \text{and } A \in \Sigma_{\mathsf{Sort}} \text{ and } i \in \mathsf{ob}\mathcal{J}$, and let $\mathsf{Term}^c \left(\Sigma^{\mathcal{J}} (M, \mathsf{x}_{A^i}) \right)^*$ be the subset of $\mathsf{Term}^c \left(\Sigma^{\mathcal{J}} (M, \mathsf{x}_{A^i}) \right)$ consisting of the α -restricted terms. We define a map

$$\theta: \mathsf{Term}^{c}\left(\Sigma^{\mathcal{J}}\left(M, \mathsf{x}_{A^{i}}\right)\right)^{*} \to \bigcup_{k \in \mathsf{ob}\mathcal{J}} \mathsf{Term}^{c}\left(\Sigma\left(M^{k}, \overline{\mathsf{x}_{\mathsf{Cod}(k)}^{A}}\right)\right)$$

with the property that if $u : C^k$ for $k \in \mathsf{ob}\mathcal{J}$ and $C \in \Sigma_{\mathsf{Sort}}$, then $\theta(u) \in \mathsf{Term}^c\left(\Sigma\left(M^k, \overline{\mathsf{x}^A_{\mathsf{Cod}(k)}}\right)\right)$ with $\theta(u) : C$. We define θ by induction on the structure of $u \in \mathsf{Term}^c\left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i})\right)^*$:

- For any $f: i \to k$ in \mathcal{J} , we set $\theta(\mathsf{x}_{A^i}) := \mathsf{x}_{\mathsf{id}_i}^A : A$ and $\theta\left(\alpha_f^A(\mathsf{x}_{A^i})\right) := \mathsf{x}_f^A : A$ (note that $\alpha_f^A(\mathsf{x}_{A^i}) : A^k$ and $\mathsf{x}_f^A \in \mathsf{Term}^c\left(\Sigma\left(M^k, \overline{\mathsf{x}_{\mathsf{Cod}(k)}^A}\right)\right)$).
- For any $k \in \mathsf{ob}\mathcal{J}, C \in \Sigma_{\mathsf{Sort}}$, and $s \in M_{C^k} = M_C^k$, we set $\theta\left(c_{C^k,s}^M\right) := c_{C,s}^{M^k}$.
- For any $k \in \text{ob}\mathcal{J}$, any function symbol $g: C_1 \times \ldots \times C_n \to C$ in Σ , and any $u_1, \ldots, u_n \in \text{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i}) \right)^*$ with $u_\ell: C_\ell^k$ for all $1 \le \ell \le n$, we set $\theta \left(g^k(u_1, \ldots, u_n) \right) := g \left(\theta(u_1), \ldots, \theta(u_n) \right)$.

The idea behind the map θ is that it takes an α -restricted term t and replaces all of the subterms in t of the form $\alpha_f^A(\mathbf{x}_{A^i})$ by constant symbols \mathbf{x}_f^A . The next crucial result now states that θ preserves provability of equations; its proof may be found in [7, Proposition 5.1.29].

Proposition 3.28. Let $M \in \mathbb{T}^{\mathcal{J}} \mod and \ let \ s, t \in \operatorname{Term}^{c} \left(\Sigma^{\mathcal{J}} \left(M, \mathsf{x}_{A^{i}} \right) \right)^{*}$ for some $i \in \operatorname{ob} \mathcal{J}$ and $A \in \Sigma_{\operatorname{Sort}}$, with $s, t : C^{j}$ for some $C \in \Sigma_{\operatorname{Sort}}$ and $j \in \operatorname{ob} \mathcal{J}$. If $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A_{i}}) \vdash s = t$, then $\mathbb{T} \left(M^{j}, \overline{\mathsf{x}^{A}_{\operatorname{Cod}(j)}} \right) \vdash \theta(s) = \theta(t)$. \Box

We will also need the following technical lemma, whose proof may be found in [7, Lemma 5.1.31].

Lemma 3.29. Let $M \in \mathbb{T}^{\mathcal{J}} \mod and \ k \in ob \mathcal{J} and \ B \in \Sigma_{\mathsf{Sort}}$, and suppose that $u \in \mathsf{Term}^c \left(\Sigma \left(M^k, \overline{\mathsf{x}^B_{\mathsf{Cod}(k)}} \right) \right)$ is of sort B and $\mathbb{T} \left(M^k, \overline{\mathsf{x}^B_{\mathsf{Cod}(k)}} \right) \vdash u = \mathsf{x}^B_{\mathsf{id}_k}$. If $\mathbb{T} \left(M^k \right)$ is non-trivial for the sort B, then u contains at least one occurrence of $\mathsf{x}^B_{\mathsf{id}_k}$.

We will also need the following map θ^* , which essentially takes an α -restricted term t, applies θ to it, and then erases all of the morphism subscripts from the indeterminates of the form x_f^A in $\theta(t)$:

Definition 3.30. Let $M \in \mathbb{T}^{\mathcal{J}} \mod \text{and } A \in \Sigma_{\mathsf{Sort}} \text{ and } i \in \mathsf{ob}\mathcal{J}$. We define a map

$$\theta^*: \operatorname{\mathsf{Term}}^c \left(\Sigma^{\mathcal{J}} \left(M, \mathsf{x}_{A^i} \right) \right)^* \to \bigcup_{k \in \operatorname{ob} \mathcal{J}} \operatorname{\mathsf{Term}}^c \left(\Sigma \left(M^k, \mathsf{x}_A \right) \right)$$

with the property that if $u : C^k$ for $k \in ob\mathcal{J}$ and $C \in \Sigma_{Sort}$, then $\theta^*(u) \in \operatorname{Term}^c(\Sigma(M^k, \mathsf{x}_A))$ with $\theta^*(u) : C$. To define θ^* , we first define for each $k \in ob\mathcal{J}$ a signature morphism

$$\lambda_k : \Sigma\left(M^k, \overline{\mathsf{x}^A_{\mathsf{Cod}(k)}}\right) \to \Sigma\left(M^k, \mathsf{x}_A\right)$$

as follows: λ_k is the identity on $\Sigma(M^k)$, and $\lambda_k(\mathsf{x}_f^A) := \mathsf{x}_A$ for any $f \in \mathsf{Cod}(k)$. By a slight abuse of notation, we also denote the induced function on closed terms as

$$\lambda_k : \operatorname{Term}^c \left(\Sigma \left(M^k, \overline{\mathsf{x}^A_{\operatorname{\mathsf{Cod}}(k)}} \right) \right) \to \operatorname{Term}^c \left(\Sigma \left(M^k, \mathsf{x}_A \right) \right).$$

Finally, we set

$$\lambda := \bigcup_{k \in \mathsf{ob}\mathcal{J}} \lambda_k : \bigcup_{k \in \mathsf{ob}\mathcal{J}} \mathsf{Term}^c \left(\Sigma \left(M^k, \overline{\mathsf{x}^A_{\mathsf{Cod}(k)}} \right) \right) \to \bigcup_{k \in \mathsf{ob}\mathcal{J}} \mathsf{Term}^c \left(\Sigma \left(M^k, \mathsf{x}_A \right) \right),$$

and we then define θ^* to be the composite

$$\operatorname{Term}^{c}\left(\Sigma^{\mathcal{J}}\left(M,\mathsf{x}_{A^{i}}\right)\right)^{*} \xrightarrow{\theta} \bigcup_{k \in \operatorname{ob}\mathcal{J}} \operatorname{Term}^{c}\left(\Sigma\left(M^{k},\overline{\mathsf{x}_{\operatorname{Cod}(k)}^{A}}\right)\right) \xrightarrow{\lambda} \bigcup_{k \in \operatorname{ob}\mathcal{J}} \operatorname{Term}^{c}\left(\Sigma\left(M^{k},\mathsf{x}_{A}\right)\right),$$

and it is easy to see that θ^* indeed has the stated property.

Before showing that θ^* preserves the provability of a certain restricted kind of sequent, we require the following technical concepts.

Definition 3.31. Let $M \in \mathbb{T}^{\mathcal{J}} \mod$.

- If $u \in \operatorname{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i}) \right)^*$ for some $A \in \Sigma_{\mathsf{Sort}}$ and $i \in \mathsf{ob}\mathcal{J}$, then we say that u is *i*-local if for any subterm v of u, there is some sort $C \in \Sigma_{\mathsf{Sort}}$ such that $v : C^i$. In particular, if u is *i*-local, then $u : B^i$ for some sort B, and every α -subterm of u has the form $\alpha_f^A(\mathsf{x}_{A^i})$ for some endomorphism $f : i \to i$.
- Let $f: j \to i$ have codomain *i*. If $u \in \operatorname{Term}^{c} (\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}))^{*}$ is *i*-local, we define

$$u[f] \in \operatorname{\mathsf{Term}}^c \left(\Sigma^{\mathcal{J}} \left(M, \mathsf{x}_{A^j} \right) \right)^{\frac{1}{2}}$$

(note the change from x_{A^i} to x_{A^j}) to be the term of the same sort defined as follows:

- If $u \equiv \mathsf{x}_{A^i} : A^i$, then we set $u[f] := \alpha_f^A(\mathsf{x}_{A^j}) : A^i$.
- If $u \equiv \alpha_a^A(\mathsf{x}_{A^i}) : A^i$ for some $g : i \to i$ (since u is *i*-local), then we set $u[f] := \alpha_{a \circ f}^A(\mathsf{x}_{A^j}) : A^i$.
- If $u \equiv c_{B^i,s}^M : B^i$ for some $B \in \Sigma_{\mathsf{Sort}}$ and $s \in M_{B^i}$, then we set $u[f] := u : B^i$.
- If $u \equiv g^i(u_1, \ldots, u_n) : B^i$ for some function symbol $g : B_1 \times \ldots \times B_n \to B$ in Σ and *i*-local terms $u_1, \ldots, u_n \in \operatorname{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i})\right)^*$ with $u_\ell : B^i_\ell$ for each $1 \leq \ell \leq n$, then we set

$$u[f] := g^i \left(u_1[f], \dots, u_n[f] \right) : B^i$$

In general, u[f] will not be the same term as u^f from Lemma 3.24.

• If $u \in \text{Term} \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}) \right)^{*}$ is *i*-local with $u : B^{i}$ for some $B \in \Sigma_{\text{Sort}}$, then we say that *u* commutes generically with an endomorphism $f : i \to i$ if $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}) \vdash \alpha_{f}^{B}(u) = u[f]$.

For future reference, we note the following obvious result: if $u \in \operatorname{Term}^{c}(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}))$ is α -restricted and i-local and $f: i \to i$ is an endomorphism, then

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{A^{i}})\vdash u\downarrow\implies \mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{A^{i}})\vdash u[f]=u\left[\alpha_{f}^{A}(\mathsf{x}_{A^{i}})/\mathsf{x}_{A^{i}}\right].$$

We can now prove that θ^* preserves provability of a certain restricted kind of sequent; the proof may be found in [7, Lemma 5.1.34].

Lemma 3.32. Let $M \in \mathbb{T}^{\mathcal{J}}$ mod. Let $u, s, t \in \operatorname{Term}^{c} (\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}))^{*}$ for some $A \in \Sigma_{\mathsf{Sort}}$ and $i \in \mathsf{ob}\mathcal{J}$, with $u : C^{i}$ and $s, t : D^{i}$ for some $C, D \in \Sigma_{\mathsf{Sort}}$. Suppose that $u \equiv h^{i}(u_{1}, \ldots, u_{m})$ for some function symbol $h : C_{1} \times \ldots \times C_{m} \to C$ of Σ and *i*-local terms $u_{1}, \ldots, u_{m} \in \operatorname{Term}^{c} (\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}))^{*}$ with $u_{\ell} : C^{i}_{\ell}$ and $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}) \vdash u_{\ell} \downarrow$ for each $1 \leq \ell \leq m$, and assume that u_{ℓ} commutes generically with each endomorphism $f : i \to i$ in \mathcal{J} . If $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A^{i}})$ proves the sequent $u \downarrow \vdash s = t$, then $\mathbb{T}(M^{i}, \mathsf{x}_{A})$ proves the sequent $\theta^{*}(u) \downarrow \vdash \theta^{*}(s) = \theta^{*}(t)$.

We also have that θ^* preserves the provability of *equations*; the simple proof may be found in [7, Lemma 5.1.35].

Lemma 3.33. Let $M \in \mathbb{T}^{\mathcal{J}} \mod and A \in \Sigma_{\mathsf{Sort}}$ and $i \in \mathsf{ob}\mathcal{J}$. For any $s, t \in \mathsf{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i})\right)^*$ with $s, t : C^k$ for some $k \in \mathsf{ob}\mathcal{J}$ and $C \in \Sigma_{\mathsf{Sort}}$, if $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A^i})$ proves the sequent $\top \vdash s = t$, then $\mathbb{T}(M^k, \mathsf{x}_A)$ proves the sequent $\top \vdash \theta^*(s) = \theta^*(t)$.

The proofs of the following three lemmas may be found in [7, Lemmas 5.1.36, 5.1.37, 5.1.38].

Lemma 3.34. Let $M \in \mathbb{T}^{\mathcal{J}} \mod$, let $u \in \operatorname{Term}^{c} \left(\Sigma^{\mathcal{J}} (M, \mathsf{x}_{A^{i}}) \right)^{*}$ be *i*-local for some $i \in \operatorname{ob} \mathcal{J}$ and $A \in \Sigma_{\operatorname{Sort}}$, and let $f \in \operatorname{Cod}(i)$. Then $\theta^{*}(u) \equiv \theta^{*}(u[f]) \in \operatorname{Term}^{c} \left(\Sigma \left(M^{i}, \mathsf{x}_{A} \right) \right)$.

The following lemma says that θ^* interacts properly with substitution, provided that the term being substituted commutes generically with certain morphisms of \mathcal{J} :

Lemma 3.35. Let $M \in \mathbb{T}^{\mathcal{J}} \mod$, let $u, v \in \operatorname{Term}^{c} \left(\Sigma^{\mathcal{J}} (M, \mathsf{x}_{A^{i}}) \right)^{*}$ for some $A \in \Sigma_{\mathsf{Sort}}$ and $i \in \mathsf{ob}\mathcal{J}$ with $v : A^{i}$, and suppose that $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A^{i}}) \vdash u, v \downarrow$. Suppose also that u, v are *i*-local, and that v commutes generically with every endomorphism $f : i \to i$ in \mathcal{J} . Then

$$\mathbb{T}(M^{i},\mathsf{x}_{A}) \vdash \theta^{*}(u[v/\mathsf{x}_{A^{i}}]') = \theta^{*}(u)[\theta^{*}(v)/\mathsf{x}_{A}],$$

where $u[v|\mathbf{x}_{A^i}]'$ is the α -restricted variant of $u[v|\mathbf{x}_{A^i}]$ from Lemma 3.25.

We will need the following technical lemma to prove that each group homomorphism β_M is surjective:

Lemma 3.36. Let $M \in \mathbb{T}^{\mathcal{J}} \mod and A \in \Sigma_{\mathsf{Sort}} and i \in \mathsf{ob}\mathcal{J}$, and let $u \in \mathsf{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i}) \right)^*$ be an α -restricted, *i*-local term of sort B^i for some $B \in \Sigma_{\mathsf{Sort}}$ with $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{A^i}) \vdash u \downarrow$. Let $f : i \to \ell$ be an arbitrary morphism of \mathcal{J} with domain *i*. Then $\alpha_f^B(u)$ has an α -restricted variant $\alpha_f^B(u)'$ by Lemma 3.25, and $\alpha_f^B(u)' : B^\ell$, so that $\theta^* \left(\alpha_f^B(u)' \right) \in \mathsf{Term}^c \left(\Sigma \left(M^\ell, \mathsf{x}_A \right) \right)$. And $\theta^*(u) \in \mathsf{Term}^c \left(\Sigma \left(M^i, \mathsf{x}_A \right) \right)$, so that $\rho_{f^M}^A(\theta^*(u)) \in \mathsf{Term}^c \left(\Sigma \left(M^\ell, \mathsf{x}_A \right) \right)$, where $\rho_{f^M}^A : \mathbb{T} \left(M^i, \mathsf{x}_A \right) \to \mathbb{T} \left(M^\ell, \mathsf{x}_A \right)$ is the theory morphism induced by the Σ -morphism $f^M := F^M(f) : M^i \to M^\ell$. Then $\mathbb{T} \left(M^\ell, \mathsf{x}_A \right) \vdash \theta^* \left(\alpha_f^B(u)' \right) = \rho_{f^M}^A(\theta^*(u))$.

We will also require the following technical results regarding the map θ , whose proofs involve straightforward inductions on terms:

Lemma 3.37. Let $M \in \mathbb{T}^{\mathcal{J}} \mod and A \in \Sigma_{\mathsf{Sort}} and i \in \mathsf{ob}\mathcal{J}$, and let $v \in \mathsf{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i})\right)^*$ be of sort B^k for some $B \in \Sigma_{\mathsf{Sort}} and k \in \mathsf{ob}\mathcal{J}$. Fix an endomorphism $f : k \to k$ in \mathcal{J} . By Lemma 3.24, there is a term $v^f \in \mathsf{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i})\right)^*$ with $v^f : B^k$. Then $\theta(v), \theta\left(v^f\right) \in \mathsf{Term}^c \left(\Sigma\left(M^k, \mathsf{x}_{\mathsf{Cod}(k)}^A\right)\right)$, and for any $g \in \mathsf{Cod}(k), \mathsf{x}_g^A$ occurs in $\theta(v)$ iff $\mathsf{x}_{f \circ g}^A$ occurs in $\theta\left(v^f\right)$.

Lemma 3.38. Let $M \in \mathbb{T}^{\mathcal{J}} \mod$, let $u \in \operatorname{Term}^{c} \left(\Sigma^{\mathcal{J}} (M, \mathsf{x}_{B^{k}}) \right)$ for some $B \in \Sigma_{\mathsf{Sort}}$ and $k \in \mathsf{ob}\mathcal{J}$, and suppose that u is α -restricted and k-local. Then it is easy to see that every indeterminate in $\theta(u) \in \operatorname{Term} \left(\Sigma \left(M^{k}, \overline{\mathsf{x}^{B}_{\mathsf{Cod}(k)}} \right) \right)$ has the form x^{B}_{f} for some endomorphism $f : k \to k$.

Suppose that the indeterminates occurring in $\theta(u)$ are $\mathsf{x}_{f_1}^B, \ldots, \mathsf{x}_{f_n}^B$, with $f_1, \ldots, f_n : k \to k$. Then for any $v \in \mathsf{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i}) \right)^*$ for some $A \in \Sigma_{\mathsf{Sort}}$ and $i \in \mathsf{ob}\mathcal{J}$ with $v : B^k$, we know that $u[v/\mathsf{x}_{B^k}] \in \mathsf{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i}) \right)$ has an α -restricted variant $u[v/\mathsf{x}_{B^k}]' \in \mathsf{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i}) \right)^*$ by Lemma 3.25. We then have

$$\theta\left(u[v/\mathsf{x}_{B^k}]'\right) \equiv \theta(u)\left[\theta\left(v^{f_1}\right)/\mathsf{x}_{f_1}^B, \dots, \theta\left(v^{f_n}\right)/\mathsf{x}_{f_n}^B\right] \in \mathsf{Term}^c\left(\Sigma\left(M^k, \overline{\mathsf{x}_{\mathsf{Cod}(k)}^A}\right)\right)$$

(recall from Lemma 3.24 that, for each $1 \leq i \leq n$, $v^{f_i} \in \operatorname{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i}) \right)^*$ is a term of sort $B^{\operatorname{cod}(f_i)} = B^k$).

Finally, we require the following notion of ' α -free variant':

Definition 3.39. Let $M \in \mathbb{T}^{\mathcal{J}} \mod \text{and } A \in \Sigma_{\mathsf{Sort}} \text{ and } i \in \mathsf{ob}\mathcal{J}$. For any $u \in \mathsf{Term}^c \left(\Sigma^{\mathcal{J}} (M, \mathsf{x}_{A^i}) \right)^*$ that is *i*-local, we define a term

$$u^{-\alpha} \in \operatorname{Term}^{c}\left(\Sigma^{J}\left(M, \mathsf{x}_{A^{i}}\right)\right)^{2}$$

of the same sort, which we call the α -free variant of u:

• If $u \equiv \mathsf{x}_{A^i} : A^i$, then $u^{-\alpha} := u : A^i$.

- If $u \equiv \alpha_f^A(\mathsf{x}_{A^i}) : A^i$ for some endomorphism $f : i \to i$ (since u is *i*-local), then $u^{-\alpha} := \mathsf{x}_{A^i} : A^i$.
- If $u \equiv c_{B^i}^M : B^i$ for some $B \in \Sigma_{\mathsf{Sort}}$ and $s \in M_{B^i}$, then $u^{-\alpha} := u : B^i$.
- If $u \equiv g^i(u_1, \ldots, u_n) : B^i$ for some function symbol $g : B_1 \times \ldots \times B_n \to B$ of Σ and *i*-local terms $u_i \in \operatorname{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i}) \right)^*$ of sort B^i_j for each $1 \leq j \leq n$, then $u^{-\alpha} := g^i \left(u_1^{-\alpha}, \ldots, u_n^{-\alpha} \right) : B^i$.

Essentially, the α -free variant $u^{-\alpha}$ is obtained from u by 'erasing' all of the α -function symbols in u (and since u is *i*-local, it is possible to do this and obtain a well-defined term of the same sort). We then have the following technical lemma, whose proof is a straightforward induction on terms:

Lemma 3.40. Let $M \in \mathbb{T}^{\mathcal{J}} \mod$ and $A \in \Sigma_{\mathsf{Sort}}$ and $i \in \mathsf{ob}\mathcal{J}$. For any α -restricted and *i*-local $u \in \mathsf{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i})\right)^*$ we have $\rho_{M^i}^A(\theta^*(u)) \equiv u^{-\alpha}$, where $\rho_{M^i}^A : \Sigma(M^i, \mathsf{x}_A) \to \Sigma^{\mathcal{J}}(M, \mathsf{x}_{A^i})$ is the signature morphism from Definition 3.12.

We can now finally prove that the group homomorphism $\beta_M : \left(\prod_i G_{\mathbb{T}}(M^i)\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M \to G_{\mathbb{T}^{\mathcal{J}}}(M)$ is injective:

Proposition 3.41. For any $M \in \mathbb{T}^{\mathcal{J}} \mod$, the group homomorphism

$$\beta_M : \left(\prod_i G_{\mathbb{T}}\left(M^i\right)\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M \to G_{\mathbb{T}^{\mathcal{J}}}(M)$$

is injective.

Proof. Let $\gamma = (\gamma_i)_i \in (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}}$ with $\gamma_i = ([s_C^i])_{C \in \Sigma}$ for each $i \in \mathsf{ob}\mathcal{J}$, let $\psi \in \mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})^M$, and suppose that $\beta_M(\gamma, \psi) = ([\mathsf{x}_A])_{A \in \Sigma^{\mathcal{J}}}$, the unit element of the group $G_{\mathbb{T}^{\mathcal{J}}}(M)$. We must show that each γ_i is the unit of the group $G_{\mathbb{T}}(M^i)$, i.e. we must show that $\gamma_i = ([\mathsf{x}_C])_C$ for all $i \in \mathsf{ob}\mathcal{J}$, and we must also show that ψ is the unit element of $\mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})^M$. So fix $i \in \mathsf{ob}\mathcal{J}$ and $B \in \Sigma_{\mathsf{Sort}}$, and suppose first that $\mathbb{T}(M^i)$ is non-trivial for the sort B. The hypothesis implies in particular that $\beta_M(\gamma, \psi)_{B^i} = [\mathsf{x}_{B^i}]$, i.e. that

$$\left[\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\left[\alpha_{\psi_{B}(i)}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{i}}\right]\right] = [\mathsf{x}_{B^{i}}] \in M \langle \mathsf{x}_{B^{i}} \rangle_{B^{i}},$$

which means that

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash \rho^{B}_{M^{i}}\left(s^{i}_{B}\right) \left[\alpha^{B}_{\psi_{B}(i)}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{i}}\right] = \mathsf{x}_{B^{i}}.$$

We first show that $\psi_B(i) = \mathrm{id}_i$. Note that $\rho_{M^i}^B(s_B^i) \left[\alpha_{\psi_B(i)}^B(\mathsf{x}_{B^i}) / \mathsf{x}_{B^i} \right] \in \mathrm{Term} \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{B^i}) \right)$ is α -restricted (because $\rho_{M^i}^B(s_B^i)$ does not contain any α -function symbols). Then by Proposition 3.28, we obtain

$$\mathbb{T}\left(M^{i}, \overline{\mathsf{x}^{B}_{\mathsf{Cod}(i)}}\right) \vdash \theta\left(\rho^{B}_{M^{i}}\left(s^{i}_{B}\right)\left[\alpha^{B}_{\psi_{B}(i)}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{i}}\right]\right) = \theta(\mathsf{x}_{B^{i}}).$$

Now, it is trivial to see that the only indeterminate that occurs in $\theta\left(\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\right) \in \operatorname{Term}\left(\Sigma\left(M^{i}, \overline{\mathsf{x}_{\mathsf{Cod}(i)}^{B}}\right)\right)$ is $\mathsf{x}_{\mathsf{id}_{i}}^{B}$. Then since $\rho_{M^{i}}^{B}\left(s_{B}^{i}\right) \in \operatorname{Term}\left(\Sigma^{\mathcal{J}}\left(M, \mathsf{x}_{B^{i}}\right)\right)$ is also α -restricted and clearly *i*-local, and since $\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\left[\alpha_{\psi_{B}(i)}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{i}}\right]$ is α -restricted, it follows by Lemma 3.38 that

$$\theta\left(\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\left[\alpha_{\psi_{B}\left(i\right)}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{i}}\right]\right) \equiv \theta\left(\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\right)\left[\theta\left(\alpha_{\psi_{B}\left(i\right)}^{B}(\mathsf{x}_{B^{i}})^{\mathsf{id}_{i}}\right)/\mathsf{x}_{\mathsf{id}_{i}}^{B}\right]$$

and hence

$$\theta\left(\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\left[\alpha_{\psi_{B}\left(i\right)}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{i}}\right]\right) \equiv \theta\left(\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\right)\left[\mathsf{x}_{\psi_{B}\left(i\right)}^{B}/\mathsf{x}_{\mathsf{id}_{i}}^{B}\right],$$

because

$$\theta\left(\alpha^{B}_{\psi_{B}(i)}(\mathsf{x}_{B^{i}})^{\mathsf{id}_{i}}\right) \equiv \theta\left(\alpha^{B}_{\mathsf{id}_{i}\circ\psi_{B}(i)}(\mathsf{x}_{B^{i}})\right) \equiv \theta\left(\alpha^{B}_{\psi_{B}(i)}(\mathsf{x}_{B^{i}})\right) \equiv \mathsf{x}^{B}_{\psi_{B}(i)}$$

Also, it is easy to see that $\theta\left(\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\right) \equiv s_{B}^{i}\left[\mathsf{x}_{\mathsf{id}_{i}}^{B}/\mathsf{x}_{B}\right]$, and so we obtain

$$\theta\left(\rho_{M^{i}}^{B}\left(s_{B}^{i}\right)\left[\alpha_{\psi_{B}\left(i\right)}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{i}}\right]\right)\equiv s_{B}^{i}\left[\mathsf{x}_{\psi_{B}\left(i\right)}^{B}/\mathsf{x}_{B}\right].$$

Since $\theta(\mathbf{x}_{B^i}) \equiv \mathbf{x}_{\mathsf{id}_i}^B$, from the fact that

$$\mathbb{T}\left(M^{i}, \overline{\mathbf{x}^{B}_{\mathsf{Cod}(i)}}\right) \vdash \theta\left(\rho^{B}_{M^{i}}\left(s^{i}_{B}\right)\left[\alpha^{B}_{\psi_{B}(i)}(\mathbf{x}_{B^{i}})/\mathbf{x}_{B^{i}}\right]\right) = \theta(\mathbf{x}_{B^{i}})$$

we finally deduce that

$$\mathbb{T}\left(M^{i}, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^{B}}\right) \vdash s_{B}^{i}\left[\mathbf{x}_{\psi_{B}(i)}^{B} / \mathbf{x}_{B}\right] = \mathbf{x}_{\mathsf{id}_{i}}^{B}$$

Since $\mathbb{T}(M^i)$ is non-trivial for the sort B, it then follows from Lemma 3.29 that $\mathsf{x}^B_{\mathsf{id}_i}$ occurs in $s^i_B \left[\mathsf{x}^B_{\psi_B(i)}/\mathsf{x}_B\right]$, and moreover it follows by [7, Lemma 2.2.56] that x_B occurs in s^i_B , so that $\mathsf{x}^B_{\psi_B(i)}$ occurs in $s^i_B \left[\mathsf{x}^B_{\psi_B(i)}/\mathsf{x}_B\right]$. But this forces $\mathsf{x}^B_{\psi_B(i)} \equiv \mathsf{x}^B_{\mathsf{id}_i}$, because $\mathsf{x}^B_{\psi_B(i)}$ is the only indeterminate occurring in $s^i_B \left[\mathsf{x}^B_{\psi_B(i)}/\mathsf{x}_B\right]$, and hence we deduce $\psi_B(i) = \mathsf{id}_i$, as desired. So we may now infer that

$$\mathbb{T}\left(M^{i}, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^{B}}\right) \vdash s_{B}^{i}\left[\mathbf{x}_{\mathsf{id}_{i}}^{B} / \mathbf{x}_{B^{i}}\right] = \mathbf{x}_{\mathsf{id}_{i}}^{B}.$$

Since $\lambda_i : \mathbb{T}\left(M^i, \overline{\mathsf{x}^B_{\mathsf{Cod}(i)}}\right) \to \mathbb{T}\left(M^i, \mathsf{x}_B\right)$ is a theory morphism by the proof of Lemma 3.32, we then obtain

$$\mathbb{T}\left(M^{i},\mathsf{x}_{B}\right) \vdash \lambda_{i}\left(s_{B}^{i}\left[\mathsf{x}_{\mathsf{id}_{i}}^{B}/\mathsf{x}_{B^{i}}\right]\right) = \lambda_{i}\left(\mathsf{x}_{\mathsf{id}_{i}}^{B}\right).$$

Since λ_i is the identity except on the indeterminates of $\Sigma\left(M^i, \overline{\mathsf{x}^B_{\mathsf{Cod}(i)}}\right)$, it then follows that $\mathbb{T}\left(M^i, \mathsf{x}_B\right) \vdash s_B^i = \mathsf{x}_B$. This shows that if $\mathbb{T}\left(M^i\right)$ is non-trivial for the sort B, then $\gamma_i^B = [s_B^i] = [\mathsf{x}_B]$ and $\psi_B(i) = \mathsf{id}_i$, so that ψ_B is the identity natural automorphism of $\mathsf{Id}_{\mathcal{J}_B^M}$ and hence ψ is the unit element of $\mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})^M$.

It remains to show that if $\mathbb{T}(M^i)$ is *trivial* for the sort B, then $\gamma_i^B = [s_B^i] = [\mathsf{x}_B]$ in this case as well. But if $\mathbb{T}(M^i)$ is trivial for the sort B, then $\mathbb{T}(M^i, \mathsf{x}_B)$ is trivial for the sort B as well, which implies that $\mathbb{T}(M^i, \mathsf{x}_B) \vdash s_B^i = \mathsf{x}_B$, because $s_B^i, \mathsf{x}_B : B$. This completes the proof that each γ_i is the unit element of $G_{\mathbb{T}}(M^i)$, which completes the proof that β_M is injective.

Since we will need to impose two assumptions on \mathbb{T} in order to prove that each β_M is surjective, let us now record what we have proven so far:

Proposition 3.42. Let \mathbb{T} be an arbitrary quasi-equational theory and \mathcal{J} a small index category. Then for any $M \in \mathbb{T}$ mod, there is an injective group homomorphism $\beta_M : (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M \to G_{\mathbb{T}^{\mathcal{J}}}(M)$.

To prove that each β_M is surjective, we will need to assume that \mathbb{T} satisfies the conditions in the following two definitions:

Definition 3.43. Let \mathbb{T} be a quasi-equational theory over a signature Σ . We say that \mathbb{T} has singleindeterminate isotropy if for any $M \in \mathbb{T}$ mod and $([s_C])_{C \in \Sigma} \in G_{\mathbb{T}}(M)$ and $C \in \Sigma_{\text{Sort}}$, we can assume without loss of generality that s_C contains exactly one occurrence of \mathbf{x}_C .

In other words, \mathbb{T} has single-indeterminate isotropy if every component of every element of isotropy of every \mathbb{T} -model can be assumed to have exactly one occurrence of the indeterminate. This is not an *overly* restrictive condition, because (apart from the theories of racks and quandles, see [6]) every example theory considered in [3, Section 4], [7, Chapter 3], and [4] has single-indeterminate isotropy (in particular, the theory of groups does).

Definition 3.44. Let \mathbb{T} be a quasi-equational theory over a signature Σ . If $g: A_1 \times \ldots \times A_n \to A$ is a function symbol of Σ , then we say that g is *totally defined in* \mathbb{T} if \mathbb{T} proves the sequent $\top \vdash^{y_1,\ldots,y_n} g(y_1,\ldots,y_n) \downarrow$, where y_1,\ldots,y_n are pairwise distinct variables with $y_i: A_i$ for each $1 \leq i \leq n$.

We then say that \mathbb{T} has single-sorted non-total operations if for any function symbol $g: A_1 \times \ldots \times A_n \to A$ of Σ that is not totally defined in \mathbb{T} , we have $A_i = A$ for each $1 \leq i \leq n$.

Again, this is not an *overly* restrictive condition, because every example theory considered in the previous sources has single-sorted non-total operations (and in particular the theory of groups). In Remark 3.53 below, we will indicate how the failure of \mathbb{T} to satisfy the conditions in Definitions 3.43 and 3.44 can result in the failure of the surjectivity of β_M . We can now prove:

Proposition 3.45. Let \mathbb{T} be a quasi-equational theory with single-indeterminate isotropy and single-sorted non-total operations, and let \mathcal{J} be a small index category. For any $M \in \mathbb{T}^{\mathcal{J}} \mod$, the group homomorphism $\beta_M : (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M \to G_{\mathbb{T}^{\mathcal{J}}}(M)$ is surjective.

Proof. Let $([s_{C^i}])_{i \in ob\mathcal{J}, C \in \Sigma} \in G_{\mathbb{T}^{\mathcal{J}}}(M)$. So for any $i \in ob\mathcal{J}$ and $C \in \Sigma_{\mathsf{Sort}}$, we know that $s_{C^i} \in \mathsf{Term}^c (\Sigma^{\mathcal{J}}(M, \mathsf{x}_{C^i}))$ is a closed term of sort C^i with $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{C^i}) \vdash s_{C^i} \downarrow$. Moreover, the $\Sigma_{\mathsf{Sort}}^{\mathcal{J}}$ -indexed sequence $([s_{C^i}])_{i,C}$ is invertible, commutes generically with all function symbols of $\Sigma^{\mathcal{J}}$, and reflects definedness. By Lemma 3.25, we may assume without loss of generality that for each $i \in \mathsf{ob}\mathcal{J}$ and $C \in \Sigma_{\mathsf{Sort}}$, the term $s_{C^i} \in \mathsf{Term}^c (\Sigma^{\mathcal{J}}(M, \mathsf{x}_{C^i}))_{C^i}$ is α -restricted, i.e. $s_{C^i} \in \mathsf{Term}^c (\Sigma^{\mathcal{J}}(M, \mathsf{x}_{C^i}))^*$. Then for every $C \in \Sigma_{\mathsf{Sort}}$ and $i \in \mathsf{ob}\mathcal{J}$, it follows by Lemma 3.33 that $\theta^*(s_{C^i}) \in \mathsf{Term}^c (\Sigma(M^i, \mathsf{x}_C))_C$ and $\mathbb{T}(M^i, \mathsf{x}_C) \vdash \theta^*(s_{C^i}) \downarrow$, so that $[\theta^*(s_{C^i})] \in M^i \langle \mathsf{x}_C \rangle_C$. We now define $\gamma \in (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}}$. For any $i \in \mathsf{ob}\mathcal{J}$, we define

$$\gamma_i \in G_{\mathbb{T}}\left(M^i\right) \subseteq \prod_{C \in \Sigma} M^i \left< \mathsf{x}_C \right>_C$$

as follows: for any $C \in \Sigma_{\mathsf{Sort}}$, we set

$$\gamma_i^C := \left[\theta^*\left(s_{C^i}\right)\right] \in M^i \left< \mathsf{x}_C \right>_C$$

Our goal is now to show that $\gamma \in (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}}$, which we achieve via the following series of claims. Claim 3.46. For any $i \in ob\mathcal{J}$, γ_i is invertible.

Proof. Let $B \in \Sigma_{\text{Sort}}$. We must show that there is some $[t_B^i] \in M^i \langle \mathsf{x}_B \rangle_B$ with

$$\mathbb{T}\left(M^{i},\mathsf{x}_{B}\right) \vdash \theta^{*}\left(s_{B^{i}}\right)\left[t_{B}^{i}/\mathsf{x}_{B}\right] = \mathsf{x}_{B} = t_{B}^{i}\left[\theta^{*}\left(s_{B^{i}}\right)/\mathsf{x}_{B}\right]$$

Since $([s_{C^j}])_{j,C} \in G_{\mathbb{T}^J}(M)$, there is some $[s_{B^i}^{-1}] \in M \langle \mathsf{x}_{B^i} \rangle_{B^i}$ with

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash s_{B^{i}}\left[s_{B^{i}}^{-1}/\mathsf{x}_{B^{i}}\right] = \mathsf{x}_{B^{i}} = s_{B^{i}}^{-1}[s_{B^{i}}/\mathsf{x}_{B^{i}}].$$

Since $s_{B^i}^{-1} \in \operatorname{Term}^c \left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{B^i}) \right)_{B^i}$ and $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^i}) \vdash s_{B^i}^{-1} \downarrow$, we may assume without loss of generality that $s_{B^i}^{-1}$ is α -restricted by Lemma 3.25. So $\theta^* \left(s_{B^i}^{-1} \right) \in \operatorname{Term}^c \left(\Sigma \left(M^i, \mathsf{x}_B \right) \right)$ has the property that $\mathbb{T} \left(M^i, \mathsf{x}_B \right) \vdash \theta^* \left(s_{B^i}^{-1} \right) \downarrow$ by Lemma 3.33. Hence, we have $\left[\theta^* \left(s_{B^i}^{-1} \right) \right] \in M^i \langle \mathsf{x}_B \rangle_B$, so we set

$$\begin{bmatrix} t_B^i \end{bmatrix} := \begin{bmatrix} \theta^* \left(s_{B^i}^{-1} \right) \end{bmatrix}$$

Since $([s_{C^j}])_{j,C} \in G_{\mathbb{T}^{\mathcal{J}}}(M)$, it follows that $([s_{C^j}])_{j,C}$ commutes generically with the function symbol α_f^B : $B^i \to B^i$ for any endomorphism $f: i \to i$ in \mathcal{J} . In other words, for any endomorphism $f: i \to i \in \mathcal{J}$ we have

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash \alpha_{f}^{B}(s_{B^{i}}) = s_{B^{i}}\left[\alpha_{f}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{i}}\right] = s_{B^{i}}[f],$$

the latter equality being provable by the remark after Definition 3.31 (since s_{B^i} is *i*-local, because it is α -restricted and of sort B^i and only contains the indeterminate x_{B^i}). In the same way, we also have

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash \alpha_{f}^{B}\left(s_{B^{i}}^{-1}\right) = s_{B^{i}}^{-1}\left[\alpha_{f}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{i}}\right] = s_{B^{i}}^{-1}[f]$$

for any endomorphism $f: i \to i$ in \mathcal{J} . Since $s_{B^i}^{-1}$ is *i*-local, this means that $s_{B^i}^{-1}$ also commutes generically with every endomorphism $f: i \to i$. Then by Lemma 3.35 we obtain

$$\mathbb{T}\left(M^{i},\mathsf{x}_{B}\right) \vdash \theta^{*}\left(s_{B^{i}}\left[s_{B^{i}}^{-1}/\mathsf{x}_{B^{i}}\right]'\right) = \theta^{*}\left(s_{B^{i}}\right)\left[\theta^{*}\left(s_{B^{i}}^{-1}\right)/\mathsf{x}_{B}\right],\tag{*}$$

where $s_{B^i} \left[s_{B^i}^{-1} / \mathsf{x}_{B^i} \right]'$ is the α -restricted variant of $s_{B^i} \left[s_{B^i}^{-1} / \mathsf{x}_{B^i} \right]$ with

$$\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^{i}}) \vdash s_{B^{i}}\left[s_{B^{i}}^{-1}/\mathsf{x}_{B^{i}}\right] = s_{B^{i}}\left[s_{B^{i}}^{-1}/\mathsf{x}_{B^{i}}\right]'$$

by Lemma 3.25. From this latter equation and the defining property of $s_{B^i}^{-1}$ we obtain

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash s_{B^{i}} \left[s_{B^{i}}^{-1}/\mathsf{x}_{B^{i}} \right]' = \mathsf{x}_{B^{i}}.$$

By Lemma 3.33 we then obtain

$$\mathbb{T}\left(M^{i},\mathsf{x}_{B}\right)\vdash\theta^{*}\left(s_{B^{i}}\left[s_{B^{i}}^{-1}/\mathsf{x}_{B^{i}}\right]'\right)=\theta^{*}(\mathsf{x}_{B^{i}})\equiv\mathsf{x}_{B}$$

Combining this with (*), we finally have $\mathbb{T}(M^i, \mathsf{x}_B) \vdash \theta^*(s_{B^i}) \left[\theta^*(s_{B^i}^{-1})/\mathsf{x}_B\right] = \mathsf{x}_B$, as desired. The converse equality is proven analogously, which completes the proof that γ_i is invertible.

Claim 3.47. For any $i \in ob\mathcal{J}$, γ_i commutes generically with all function symbols of Σ .

Proof. Let $g: B_1 \times \ldots \times B_n \to B$ be a function symbol of Σ . We must show that the sequent

$$g(\mathsf{x}_{B_1},\ldots,\mathsf{x}_{B_n})\downarrow\vdash\theta^*(s_{B^i})\left[g(\mathsf{x}_{B_1},\ldots,\mathsf{x}_{B_n})/\mathsf{x}_B\right]=g\left(\theta^*\left(s_{B_1^i}\right),\ldots,\theta^*\left(s_{B_n^i}\right)\right)$$

is provable in the theory $\mathbb{T}(M^i, \mathsf{x}_{B_1}, \ldots, \mathsf{x}_{B_n})$ (as in the proof of Proposition 3.19, we technically need to ensure that the indeterminates on the right side of the above equation are pairwise distinct (see Definition 2.16), but we will ignore this subtlety here and elsewhere in the proof to increase readability). Since $([s_{C^j}])_{j,C} \in G_{\mathbb{T}^{\mathcal{J}}}(M)$, we know that $([s_{C^j}])_{j,C}$ commutes generically with the function symbol $g^i : B_1^i \times \ldots B_n^i \to B^i$ of $\Sigma^{\mathcal{J}}$, which means that the sequent

$$g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)\downarrow\vdash s_{B^{i}}\left[g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)/\mathsf{x}_{B^{i}}\right]=g^{i}\left(s_{B_{1}^{i}},\ldots,s_{B_{n}^{i}}\right)$$

is provable in the theory $\mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{B_{1}^{i}}, \dots, \mathsf{x}_{B_{n}^{i}}\right)$. Since the terms $s_{B_{1}^{i}}, \dots, s_{B_{n}^{i}}$ are all α -restricted, it easily follows that the terms $g^{i}\left(\mathsf{x}_{B_{1}^{i}}, \dots, \mathsf{x}_{B_{n}^{i}}\right)$ and $g^{i}\left(s_{B_{1}^{i}}, \dots, s_{B_{n}^{i}}\right)$ are α -restricted. By a simple extension of Lemma 3.25, there is an α -restricted variant $s_{B^{i}}\left[g^{i}\left(\mathsf{x}_{B_{1}^{i}}, \dots, \mathsf{x}_{B_{n}^{i}}\right)/\mathsf{x}_{B^{i}}\right]'$ of $s_{B^{i}}\left[g^{i}\left(\mathsf{x}_{B_{1}^{i}}, \dots, \mathsf{x}_{B_{n}^{i}}\right)/\mathsf{x}_{B^{i}}\right]$ such that the sequent

$$g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)\downarrow\vdash s_{B^{i}}\left[g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)/\mathsf{x}_{B^{i}}\right]=s_{B^{i}}\left[g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)/\mathsf{x}_{B^{i}}\right]'$$

is provable in $\mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{B_{1}^{i}}, \ldots, \mathsf{x}_{B_{n}^{i}}\right)$. For each $1 \leq m \leq n$, the indeterminate $\mathsf{x}_{B_{m}^{i}}$ is clearly *i*-local, we have $\mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{B_{1}^{i}}, \ldots, \mathsf{x}_{B_{n}^{i}}\right) \vdash \mathsf{x}_{B_{m}^{i}} \downarrow$, and for each endomorphism $f: i \to i$ in \mathcal{J} we have

$$\mathbb{T}^{\mathcal{J}}\left(M,\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)\vdash\alpha_{f}^{B_{m}}\left(\mathsf{x}_{B_{m}^{i}}\right)=\mathsf{x}_{B_{m}^{i}}[f],$$

which means that $x_{B_m^i}$ commutes generically with f. Then by a simple extension of Lemma 3.32 and the assumption that

$$g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)\downarrow\vdash s_{B^{i}}\left[g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)/\mathsf{x}_{B^{i}}\right]=g^{i}\left(s_{B_{1}^{i}},\ldots,s_{B_{n}^{i}}\right)$$

is provable in the theory $\mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{B_{1}^{i}}, \ldots, \mathsf{x}_{B_{n}^{i}}\right)$, we obtain that

$$g(\mathsf{x}_{B_1},\ldots,\mathsf{x}_{B_n})\downarrow\vdash\theta^*\left(s_{B^i}\left[g^i\left(\mathsf{x}_{B^i_1},\ldots,\mathsf{x}_{B^i_n}\right)/\mathsf{x}_{B^i}\right]'\right)=g\left(\theta^*\left(s_{B^i_1}\right),\ldots,\theta^*\left(s_{B^i_n}\right)\right)$$

is provable in the theory $\mathbb{T}(M^i, \mathsf{x}_{B_1}, \ldots, \mathsf{x}_{B_n})$. Now, we will be done if we can show that $\mathbb{T}(M^i, \mathsf{x}_{B_1}, \ldots, \mathsf{x}_{B_n})$ proves the sequent

$$g(\mathsf{x}_{B_1},\ldots,\mathsf{x}_{B_n})\downarrow\vdash\theta^*\left(s_{B^i}\left[g^i\left(\mathsf{x}_{B_1^i},\ldots,\mathsf{x}_{B_n^i}\right)/\mathsf{x}_{B^i}\right]'\right)=\theta^*\left(s_{B^i}\right)\left[g\left(\mathsf{x}_{B_1},\ldots,\mathsf{x}_{B_n}\right)/\mathsf{x}_{B}\right].$$

Since $\theta^*\left(g^i\left(\mathsf{x}_{B_1^i},\ldots,\mathsf{x}_{B_n^i}\right)\right) \equiv g(\mathsf{x}_{B_1},\ldots,\mathsf{x}_{B_n})$, it suffices by a simple extension of Lemma 3.35 to show that $g^i\left(\mathsf{x}_{B_1^i},\ldots,\mathsf{x}_{B_n^i}\right)$ commutes generically with every endomorphism $f:i \to i$ in \mathcal{J} , i.e. it suffices to show that the sequent

$$g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)\downarrow\vdash\alpha_{f}^{B}\left(g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)\right)=g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)[f],$$

i.e. the sequent

$$g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)\downarrow\vdash\alpha_{f}^{B}\left(g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)\right)=g^{i}\left(\alpha_{f}^{B_{1}}\left(\mathsf{x}_{B_{1}^{i}}\right),\ldots,\alpha_{f}^{B}\left(\mathsf{x}_{B_{n}^{i}}\right)\right)$$

is provable in the theory $\mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{B_{1}^{i}}, \ldots, \mathsf{x}_{B_{n}^{i}}\right)$ for each endomorphism $f: i \to i$ in \mathcal{J} , which is true by Axiom 3.5.4. This completes the proof that γ_{i} commutes generically with all function symbols of Σ .

Claim 3.48. For any $i \in ob\mathcal{J}$, γ_i reflects definedness.

Proof. Let the function symbol $g \in \Sigma$ be as above (with $n \ge 1$). We must show that the sequent

$$g\left(\theta^{*}\left(s_{B_{1}^{i}}\right),\ldots,\theta^{*}\left(s_{B_{n}^{i}}\right)\right)\downarrow\vdash g(\mathsf{x}_{B_{1}},\ldots,\mathsf{x}_{B_{n}})\downarrow$$

is provable in the theory $\mathbb{T}(M^i, \mathsf{x}_{B_1}, \ldots, \mathsf{x}_{B_n})$. Since $([s_{C^j}])_{j,C} \in G_{\mathbb{T}^J}(M)$, we know that $([s_{C^j}])_{j,C}$ reflects definedness, which implies that the sequent

$$g^{i}\left(s_{B_{1}^{i}},\ldots,s_{B_{n}^{i}}\right)\downarrow\vdash g^{i}\left(\mathsf{x}_{B_{1}^{i}},\ldots,\mathsf{x}_{B_{n}^{i}}\right)\downarrow$$

is provable in the theory $\mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{B_{1}^{i}}, \ldots, \mathsf{x}_{B_{n}^{i}}\right)$. As remarked above, the terms in the latter sequent are both α -restricted. For each $1 \leq m \leq n$, the term $s_{B_{m}^{i}}$ is *i*-local and satisfies $\mathbb{T}^{\mathcal{J}}\left(M, \mathsf{x}_{B_{1}^{i}}, \ldots, \mathsf{x}_{B_{n}^{i}}\right) \vdash s_{B_{m}^{i}} \downarrow$. The term $s_{B_{m}^{i}}$ also commutes generically with every endomorphism $f: i \to i$ in \mathcal{J} , because $([s_{C^{j}}])_{j,C} \in G_{\mathbb{T}^{\mathcal{J}}}(M)$ and thus commutes generically with the function symbol $\alpha_{f}^{B_{m}}: B_{m}^{i} \to B_{m}^{i}$. So by a simple extension of Lemma 3.32, it follows that $\mathbb{T}\left(M^{i}, \mathsf{x}_{B_{1}}, \ldots, \mathsf{x}_{B_{n}}\right)$ proves the sequent

$$\theta^*\left(g^i\left(s_{B_1^i},\ldots,s_{B_n^i}\right)\right)\downarrow\vdash\theta^*\left(g^i\left(\mathsf{x}_{B_1^i},\ldots,\mathsf{x}_{B_n^i}\right)\right)\downarrow$$

But this is the desired sequent by definition of θ^* .

So $\gamma \in \prod_i G_{\mathbb{T}}(M^i)$ by the previous three claims, and now we must show that $\gamma \in (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}}$. To show this, let $f: i \to k$ be an arbitrary morphism of \mathcal{J} . We must show that $G_{\mathbb{T}}(f^M)(\gamma_i) = \gamma_k$ (recall that $f^M := F^M(f): M^i \to M^k$). Unravelling the definitions, this means that we must show for any $B \in \Sigma_{\mathsf{Sort}}$ that

$$\left[\rho_{f^{M}}^{B}\left(\theta^{*}\left(s_{B^{i}}\right)\right)\right] = \left[\theta^{*}\left(s_{B^{k}}\right)\right]$$

holds in $M^k \langle \mathsf{x}_B \rangle_B$, i.e. that

$$\mathbb{T}\left(M^{k},\mathsf{x}_{B}\right)\vdash\rho_{f^{M}}^{B}\left(\theta^{*}\left(s_{B^{i}}\right)\right)=\theta^{*}\left(s_{B^{k}}\right),$$

where $\rho_{f^M}^B : \mathbb{T}(M^i, \mathsf{x}_B) \to \mathbb{T}(M^k, \mathsf{x}_B)$ is the theory morphism induced by the Σ -morphism $f^M : M^i \to M^k$ by [7, Definition 2.2.17].

Since $([s_{C^j}])_{j,C} \in G_{\mathbb{T}^{\mathcal{J}}}(M)$, we know that $([s_{C^j}])_{j,C}$ commutes generically with the function symbol $\alpha_f^B : B^i \to B^k$ of $\Sigma^{\mathcal{J}}$, which means that

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash s_{B^{k}} \left[\alpha_{f}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}} \right] = \alpha_{f}^{B} \left(s_{B^{i}} \right)$$

(since $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^i}) \vdash \alpha_f^B(\mathsf{x}_{B^i}) \downarrow$). By Lemma 3.25, there are α -restricted variants $s_{B^k}\left[\alpha_f^B(\mathsf{x}_{B^i})/\mathsf{x}_{B^k}\right]', \alpha_f^B(s_{B^i})' \in \mathsf{Term}^c\left(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{B^i})\right)$ of these terms. So we have

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash s_{B^{k}} \left[\alpha_{f}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}} \right]' = \alpha_{f}^{B} \left(s_{B^{i}} \right)'.$$

Then by Lemma 3.33 we obtain

$$\mathbb{T}\left(M^{k},\mathsf{x}_{B}\right)\vdash\theta^{*}\left(s_{B^{k}}\left[\alpha_{f}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}}\right]'\right)=\theta^{*}\left(\alpha_{f}^{B}\left(s_{B^{i}}\right)'\right),$$

since both of the arguments of θ^* are of sort B^k . By Lemma 3.34, since s_{B^k} is k-local and $f \in Cod(k)$, we have $\theta^*(s_{B^k}) \equiv \theta^*(s_{B^k}[f])$. We also have (by the observation following Definition 3.31)

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash s_{B^{k}}[f] = s_{B^{k}} \left[\alpha_{f}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}} \right],$$

and hence

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash s_{B^{k}}[f] = s_{B^{k}} \left[\alpha_{f}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}} \right]'.$$

Then by Lemma 3.33 we deduce

$$\mathbb{T}\left(M^{k},\mathsf{x}_{B}\right)\vdash\theta^{*}\left(s_{B^{k}}\right)\equiv\theta^{*}\left(s_{B^{k}}[f]\right)=\theta^{*}\left(s_{B^{k}}\left[\alpha_{f}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}}\right]'\right)=\theta^{*}\left(\alpha_{f}^{B}\left(s_{B^{i}}\right)'\right)$$

So to obtain our desired result, it suffices to show that

$$\mathbb{T}\left(M^{k},\mathsf{x}_{B}\right)\vdash\theta^{*}\left(\alpha_{f}^{B}\left(s_{B^{i}}\right)'\right)=\rho_{f^{M}}^{B}\left(\theta^{*}\left(s_{B^{i}}\right)\right);$$

but this is true by Lemma 3.36, given that s_{B^i} is α -restricted and *i*-local and $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^i}) \vdash s_{B^i} \downarrow$. This completes the proof that $\gamma \in (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}}$.

To complete the proof that β_M is surjective, we must now produce an element $\psi \in \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$ and then show that $\beta_M(\gamma, \psi) = ([s_{C^j}])_{j,C}$. So for every sort $B \in \Sigma$, we must construct a natural automorphism $\psi_B : \operatorname{Id}_{\mathcal{J}_B^M} \to \operatorname{Id}_{\mathcal{J}_B^M}$. Let *i* be any object of \mathcal{J}_B^M . Then by definition of \mathcal{J}_B^M , it follows that the theory $\mathbb{T}(M^i)$ is non-trivial for the sort *B*. We now wish to define an endomorphism $\psi_B(i) : i \to i$ (which will turn out to be an isomorphism).

We have shown that $\gamma_i := ([\theta^*(s_{C^i})])_{C \in \Sigma} \in G_{\mathbb{T}}(M^i)$. Then because \mathbb{T} has single-indeterminate isotropy, we can assume without loss of generality that $\theta^*(s_{B^i}) \in \operatorname{Term}^c(\Sigma(M^i, \mathsf{x}_B))_B$ has exactly one occurrence of the indeterminate x_B . From this, it then follows that $s_{B^i} \in \operatorname{Term}^c(\Sigma^{\mathcal{J}}(M, \mathsf{x}_{B^i}))_{B^i}$ has exactly one occurrence of the indeterminate x_{B^i} (because distinct occurrences of x_{B^i} in s_{B^i} correspond to distinct occurrences of x_B

in $\theta^*(s_{B^i})$). More precisely, because $\theta^*(s_{B^i})$ has exactly one occurrence of x_B , it follows that $\rho_{M^i}^B(\theta^*(s_{B^i}))$ has exactly one occurrence of x_{B^i} . But by Lemma 3.40 we know that $\rho_{M^i}^B(\theta^*(s_{B^i})) \equiv s_{B^i}^{-\alpha}$, and so the α -free variant $s_{B^i}^{-\alpha}$ of s_{B^i} has exactly one occurrence of x_{B^i} , which implies that s_{B^i} has exactly one occurrence of x_{B^i} .

Now consider $\theta(s_{B^i}) \in \operatorname{Term}^c\left(\Sigma\left(M^i, \overline{\mathsf{x}^B_{\mathsf{Cod}(i)}}\right)\right)$. Since s_{B^i} has exactly one occurrence of x_{B^i} , it follows that $\theta(s_{B^i})$ has exactly one indeterminate from $\Sigma\left(M^i, \overline{\mathsf{x}^B_{\mathsf{Cod}(i)}}\right)$, and moreover the subscript of this indeterminate will be an endomorphism of *i*. We thus define $\psi_B(i) : i \to i$ to be this endomorphism. In other words, we define $\psi_B(i) : i \to i$ so that $\mathsf{x}^B_{\psi_B(i)}$ is the unique indeterminate occurring in $\theta(s_{B^i})$. We now prove:

Claim 3.49. $\psi_B(i): i \to i$ is an isomorphism.

Proof. From the proof that $\gamma_i := ([\theta^*(s_{C^i})])_{C \in \Sigma} \in G_{\mathbb{T}}(M^i)$, it follows that $\gamma_i^{-1} = ([\theta^*(s_{C^i})])_{C \in \Sigma} \in G_{\mathbb{T}}(M^i)$. Then, as for s_{B^i} , it follows that $s_{B^i}^{-1}$ has exactly one occurrence of the indeterminate x_{B^i} , and so we define $\psi_B(i)^{-1} : i \to i$ from $\theta(s_{B^i}^{-1})$ in the same way that we defined $\psi_B(i)$ from $\theta(s_{B^i})$. We now need to verify that $\psi_B(i)$ and $\psi_B(i)^{-1}$ are in fact mutually inverse endomorphisms of i. First, we know that

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash s_{B^{i}}\left[s_{B^{i}}^{-1}/\mathsf{x}_{B^{i}}\right] = \mathsf{x}_{B^{i}} = s_{B^{i}}^{-1}\left[s_{B^{i}}/\mathsf{x}_{B^{i}}\right].$$

By Lemma 3.25, there is an α -restricted variant $s_{B^i} \left[s_{B^i}^{-1} / \mathsf{x}_{B^i} \right]'$ of $s_{B^i} \left[s_{B^i}^{-1} / \mathsf{x}_{B^i} \right]$, so we obtain $\mathbb{T}^{\mathcal{J}}(M, \mathsf{x}_{B^i}) \vdash s_{B^i} \left[s_{B^i}^{-1} / \mathsf{x}_{B^i} \right]' = \mathsf{x}_{B^i}$. Then by Proposition 3.28 we have

$$\mathbb{T}\left(M^{i}, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^{B}}\right) \vdash \theta\left(s_{B^{i}}\left[s_{B^{i}}^{-1}/\mathbf{x}_{B^{i}}\right]'\right) = \theta(\mathbf{x}_{B^{i}}) \equiv \mathbf{x}_{\mathsf{id}_{i}}^{B}$$

Since the unique indeterminate that $\theta(s_{B^i}) \in \operatorname{Term}^c\left(\Sigma\left(M^i, \overline{\mathsf{x}^B_{\mathsf{Cod}(i)}}\right)\right)$ contains is $\mathsf{x}^B_{\psi_B(i)}$, it follows by Lemma 3.38 that

$$\theta\left(s_{B^{i}}\left[s_{B^{i}}^{-1}/\mathsf{x}_{B^{i}}\right]'\right) \equiv \theta\left(s_{B^{i}}\right)\left[\theta\left(\left(s_{B^{i}}^{-1}\right)^{\psi_{B}(i)}\right)/\mathsf{x}_{\psi_{B}(i)}^{B}\right]$$

So then the unique indeterminate that occurs in $\theta\left(s_{B^i}\left[s_{B^i}^{-1}/\mathsf{x}_{B^i}\right]'\right)$ will be the unique indeterminate that occurs in $\theta\left(\left(s_{B^i}^{-1}\right)^{\psi_B(i)}\right)$. But since the unique indeterminate that occurs in $\theta\left(s_{B^i}^{-1}\right)$ is $\mathsf{x}_{\psi_B(i)\circ\psi_B(i)-1}^B$, it follows by Lemma 3.37 that the unique indeterminate that occurs in $\theta\left(\left(s_{B^i}^{-1}\right)^{\psi_B(i)}\right)$ is $\mathsf{x}_{\psi_B(i)\circ\psi_B(i)-1}^B$. In summary, the unique indeterminate that occurs in $\theta\left(s_{B^i}\left[s_{B^i}^{-1}/\mathsf{x}_{B^i}\right]'\right)$ is $\mathsf{x}_{\psi_B(i)\circ\psi_B(i)-1}^B$. In summary, the unique indeterminate that occurs in $\theta\left(s_{B^i}\left[s_{B^i}^{-1}/\mathsf{x}_{B^i}\right]'\right)$ is $\mathsf{x}_{\psi_B(i)\circ\psi_B(i)-1}^B$.

Now, since $\mathbb{T}(M^i)$ is non-trivial for the sort B and

$$\mathbb{T}\left(M^{i}, \overline{\mathsf{x}_{\mathsf{Cod}(i)}^{B}}\right) \vdash \theta\left(s_{B^{i}}\left[s_{B^{i}}^{-1}/\mathsf{x}_{B^{i}}\right]'\right) = \mathsf{x}_{\mathsf{id}_{i}}^{B},$$

it follows by Lemma 3.29 that $\mathsf{x}_{\mathsf{id}_i}^B$ occurs in $\theta\left(s_{B^i}\left[s_{B^i}^{-1}/\mathsf{x}_{B^i}\right]'\right)$. But then we must have $\mathsf{x}_{\psi_B(i)\circ\psi_B(i)^{-1}}^B \equiv \mathsf{x}_{\mathsf{id}_i}^B$, which forces $\psi_B(i) \circ \psi_B(i)^{-1} = \mathsf{id}_i$. The proof that $\psi_B(i)^{-1} \circ \psi_B(i) = \mathsf{id}_i$ is analogous, which completes the proof that $\psi_B(i) : i \to i$ is an isomorphism.

Next, we prove:

Claim 3.50. ψ_B is a natural automorphism of $\operatorname{Id}_{\mathcal{J}_D^M}$.

Proof. Let $i, k \in ob \mathcal{J}_B^M$, which means that the theories $\mathbb{T}(M^i)$ and $\mathbb{T}(M^k)$ are both non-trivial for the sort B, and let $h: i \to k$ be an arbitrary morphism of \mathcal{J} . We must show that $h \circ \psi_B(i) = \psi_B(k) \circ h: i \to k$. We know that $\alpha_h^B: B^i \to B^k$ is a function symbol of $\Sigma^{\mathcal{J}}$, so because $([s_{C^j}])_{j,C} \in G_{\mathbb{T}^{\mathcal{J}}}(M)$, it follows that $([s_{C^j}])_{j,C}$ commutes generically with this function symbol, which means that

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash \alpha_{h}^{B}\left(s_{B^{i}}\right) = s_{B^{k}}\left[\alpha_{h}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}}\right].$$

By Lemma 3.25, the righthand term in the above equation has an α -restricted variant $s_{B^k} \left[\alpha_h^B(\mathsf{x}_{B^i})/\mathsf{x}_{B^k} \right]'$, and by Lemma 3.24, since $s_{B^i} : B^i$ is α -restricted and $\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^i}) \vdash s_{B^i} \downarrow$, we know that $s_{B^i}^h : B^k$ is an α -restricted term with $\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^i}) \vdash \alpha_h^B(s_{B^i}) = s_{B^i}^h$. Altogether, we then have

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{B^{i}}) \vdash s_{B^{i}}^{h} = s_{B^{k}} \left[\alpha_{h}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}} \right]'$$

with both terms α -restricted. By Proposition 3.28, we then obtain

$$\mathbb{T}\left(M^{k}, \overline{\mathsf{x}_{\mathsf{Cod}(k)}^{B}}\right) \vdash \theta\left(s_{B^{i}}^{h}\right) = \theta\left(s_{B^{k}}\left[\alpha_{h}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}}\right]'\right).$$

Since the unique indeterminate that occurs in $\theta(s_{B^i})$ is $\mathsf{x}^B_{\psi_B(i)}$, it follows by Lemma 3.37 that the unique indeterminate that occurs in $\theta(s^h_{B^i})$ is $\mathsf{x}^B_{h\circ\psi_B(i)}$. Also, we know by Lemma 3.38 that

$$\theta\left(s_{B^{k}}\left[\alpha_{h}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}}\right]'\right) \equiv \theta\left(s_{B^{k}}\right)\left[\theta\left(\alpha_{h}^{B}(\mathsf{x}_{B^{i}})^{\psi_{B}(k)}\right)/\mathsf{x}_{\psi_{B}(k)}^{B}\right],$$

since $x_{\psi_B(k)}^B$ is the unique indeterminate that occurs in $\theta(s_{B^k})$. But (by the proof of Lemma 3.24) we have

$$\theta\left(\alpha_h^B(\mathsf{x}_{B^i})^{\psi_B(k)}\right) \equiv \theta\left(\alpha_{\psi_B(k)\circ h}^B(\mathsf{x}_{B^i})\right) \equiv \mathsf{x}_{\psi_B(k)\circ h}^B$$

which means that the unique indeterminate that occurs in $\theta \left(s_{B^k} \left[\alpha_h^B(\mathsf{x}_{B^i}) / \mathsf{x}_{B^k} \right]' \right)$ is $\mathsf{x}_{\psi_B(k) \circ h}^B$. Now, suppose towards a contradiction that $h \circ \psi_B(i) \neq \psi_B(k) \circ h$. Then we would have $\mathsf{x}_{h \circ \psi_B(i)}^B \not\equiv \mathsf{x}_{\psi_B(k) \circ h}^B$, since distinct morphisms with codomain k correspond to distinct indeterminates in $\Sigma \left(M^k, \overline{\mathsf{x}_{\mathsf{Cod}(k)}^B} \right)$. By the preceding discussion, it would then follow that in the equation

$$\mathbb{T}\left(M^{k}, \overline{\mathsf{x}_{\mathsf{Cod}(k)}^{B}}\right) \vdash \theta\left(s_{B^{i}}^{h}\right) = \theta\left(s_{B^{k}}\left[\alpha_{h}^{B}(\mathsf{x}_{B^{i}})/\mathsf{x}_{B^{k}}\right]'\right),$$

i.e.

$$\mathbb{T}\left(M^{k}, \overline{\mathsf{x}_{\mathsf{Cod}(k)}^{B}}\right) \vdash \theta\left(s_{B^{i}}^{h}\right) = \theta\left(s_{B^{k}}\right) \left[\mathsf{x}_{\psi_{B}(k)\circ h}^{B} / \mathsf{x}_{\psi_{B}(k)}^{B}\right]$$

the two terms have no indeterminates in common. From the previous line, we can infer

$$\mathbb{T}\left(M^{k},\mathsf{x}_{h\circ\psi_{B}(i)}^{B},\mathsf{x}_{\psi_{B}(k)\circ h}^{B}\right)\vdash\theta\left(s_{B^{i}}^{h}\right)=\theta\left(s_{B^{k}}\right)\left[\mathsf{x}_{\psi_{B}(k)\circ h}^{B}/\mathsf{x}_{\psi_{B}(k)}^{B}\right]$$

by [7, Lemma 5.1.30]. Now let y, y' be distinct variables of sort B. Then by [5, Theorem 10], we may conclude

$$\mathbb{T}\left(M^{k}\right) \vdash^{y,y'} \theta\left(s_{B^{i}}^{h}\right) \left[y/\mathsf{x}_{h\circ\psi_{B}(i)}^{B}\right] = \theta\left(s_{B^{k}}\right) \left[y'/\mathsf{x}_{\psi_{B}(k)}^{B}\right],\tag{*}$$

since the indeterminates $\mathsf{x}_{h\circ\psi_B(i)}^B, \mathsf{x}_{\psi_B(k)\circ h}^B : B$ are distinct. Now, in the proof of the claim that $\psi_B(k)$ is an isomorphism we showed that

$$\theta\left(s_{B^{k}}\left[s_{B^{k}}^{-1}/\mathsf{x}_{B^{k}}\right]'\right) \equiv \theta\left(s_{B^{k}}\right)\left[\theta\left(\left(s_{B^{k}}^{-1}\right)^{\psi_{B}(k)}\right)/\mathsf{x}_{\psi_{B}(k)}^{B}\right].$$

Hence, by substituting $\theta\left(\left(s_{B^k}^{-1}\right)^{\psi_B(k)}\right)$ for y' in (*), we obtain

$$\mathbb{T}\left(M^{k},\mathsf{x}_{\mathsf{id}_{k}}^{B}\right)\vdash^{y}\theta\left(s_{B^{i}}^{h}\right)\left[y/\mathsf{x}_{h\circ\psi_{B}\left(i\right)}^{B}\right]=\theta\left(s_{B^{k}}\right)\left[\theta\left(\left(s_{B^{k}}^{-1}\right)^{\psi_{B}\left(k\right)}\right)/\mathsf{x}_{\psi_{B}\left(k\right)}^{B}\right]\equiv\theta\left(s_{B^{k}}\left[s_{B^{k}}^{-1}/\mathsf{x}_{B^{k}}\right]'\right).$$

But we also know (from the same proof) that

$$\mathbb{T}\left(M^{k},\mathsf{x}_{\mathsf{id}_{k}}^{B}\right)\vdash\theta\left(s_{B^{k}}\left[s_{B^{k}}^{-1}/\mathsf{x}_{B^{k}}\right]'\right)=\mathsf{x}_{\mathsf{id}_{k}}^{B},$$

so we finally obtain

$$\mathbb{T}\left(M^{k}, \mathsf{x}^{B}_{\mathsf{id}_{k}}\right) \vdash^{y} \theta\left(s^{h}_{B^{i}}\right) \left[y/\mathsf{x}^{B}_{h \circ \psi_{B}\left(i\right)}\right] = \mathsf{x}^{B}_{\mathsf{id}_{k}}.$$

Since $\mathsf{x}_{\mathsf{id}_k}^B$ does not appear in $\theta\left(s_{B^i}^h\right)\left[y/\mathsf{x}_{h\circ\psi_B(i)}^B\right]$, it then follows from [5, Theorem 10] that if y': B is a variable distinct from y, then

$$\mathbb{T}\left(M^{k}\right)\vdash^{y,y'}\theta\left(s_{B^{i}}^{h}\right)\left[y/\mathsf{x}_{h\circ\psi_{B}\left(i\right)}^{B}\right]=y',$$

and y' does not appear in $\theta\left(s_{B^{i}}^{h}\right)\left[y/\mathsf{x}_{h\circ\psi_{B}(i)}^{B}\right]$. But then if y'': B is a variable distinct from both y and y', we also obtain

$$\mathbb{T}\left(M^{k}\right)\vdash^{y,y''}\theta\left(s_{B^{i}}^{h}\right)\left[y/\mathsf{x}_{h\circ\psi_{B}\left(i\right)}^{B}\right]=y''.$$

Finally, we deduce that $\mathbb{T}(M^k) \vdash^{y',y''} y' = y''$, which contradicts the assumption that $\mathbb{T}(M^k)$ is non-trivial for the sort B. So we must have $h \circ \psi_B(i) = \psi_B(k) \circ h$, as desired. This completes the argument that ψ_B is a natural automorphism of $\mathsf{Id}_{\mathcal{J}_B^M}$.

To complete the proof that $\psi \in \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$, we must also verify:

Claim 3.51. If $g : B_1 \times \ldots \times B_n \to B$ is a function symbol of Σ with $n \ge 1$, then for any $i \in ob\mathcal{J}$ and $1 \le m \le n$ such that g^{M^i} is non-degenerate in position m we have $\psi_{B_m}(i) = \psi_B(i) : i \to i$.

Proof. For simplicity, we will let $g : A \times B \to C$ be a binary function symbol of Σ with $A \neq B$, and let $i \in \mathsf{ob}\mathcal{J}$. Suppose that g^{M^i} is non-degenerate in position 1 (the argument for position 2 being analogous), which means that

$$\mathbb{T}(M^i) \not\vdash^{y_1, y'_1, y_2} g(y_1, y_2) = g(y'_1, y_2)$$

for pairwise distinct variables $y_1, y'_1 : A, y_2 : B$. Then (as remarked in the definition of $\operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$) this implies that $\mathbb{T}(M^i)$ is non-trivial for the sort C, so that $i \in \operatorname{ob}_{\mathcal{L}}^M$ and hence $\psi_A(i), \psi_C(i) : i \to i$ are defined. We must now show that $\psi_A(i) = \psi_C(i) : i \to i$. If g is not totally defined in \mathbb{T} , then the assumption that \mathbb{T} has single-sorted non-total operations implies that A = B = C, which obviously entails the desired result. So suppose that g is totally defined in \mathbb{T} . If the sorts A and C are identical, then the desired result trivially follows, so suppose that $A \neq C$. Suppose towards a contradiction that $\psi_A(i) \neq \psi_C(i) : i \to i$. Since $([s_{C^j}])_{j,C} \in G_{\mathbb{T}^{\mathcal{J}}}(M)$, it follows that $([s_{C^j}])_{j,C}$ commutes generically with the function symbol $g^i : A^i \times B^i \to C^i$ of $\Sigma^{\mathcal{J}}$. Since g is totally defined in \mathbb{T} , this entails that

$$\mathbb{T}^{\mathcal{J}}(M,\mathsf{x}_{A^{i}},\mathsf{x}_{B^{i}})\vdash g^{i}(s_{A^{i}},s_{B^{i}})=s_{C^{i}}\left[g^{i}(\mathsf{x}_{A^{i}},\mathsf{x}_{B^{i}})/\mathsf{x}_{C^{i}}\right].$$

Let $s_{C^i} \left[g^i(\mathsf{x}_{A^i}, \mathsf{x}_{B^i})/\mathsf{x}_{C^i} \right]'$ be the α -restricted variant of $s_{C^i} \left[g^i(\mathsf{x}_{A^i}, \mathsf{x}_{B^i})/\mathsf{x}_{C^i} \right]$ obtained from (a simple extension of) Lemma 3.25. Then by (simple extensions of) Lemma 3.25 and Proposition 3.28 and the definition of θ we have

$$\mathbb{T}\left(M^{i}, \overline{\mathsf{x}^{A}_{\mathsf{Cod}(i)}}, \overline{\mathsf{x}^{B}_{\mathsf{Cod}(i)}}\right) \vdash g\left(\theta(s_{A^{i}}), \theta\left(s_{B^{i}}\right)\right) = \theta\left(s_{C^{i}}[g^{i}(\mathsf{x}_{A^{i}}, \mathsf{x}_{B^{i}})/\mathsf{x}_{C^{i}}]'\right)$$

By a simple extension of Lemma 3.38, we have

$$\theta\left(s_{C^{i}}\left[g^{i}(\mathsf{x}_{A^{i}},\mathsf{x}_{B^{i}})/\mathsf{x}_{C^{i}}\right]'\right) \equiv \theta\left(s_{C^{i}}\right)\left[\theta\left(g^{i}(\mathsf{x}_{A^{i}},\mathsf{x}_{B^{i}})^{\psi_{C}(i)}\right)/\mathsf{x}_{\psi_{C}(i)}^{C}\right].$$

We also have (by a simple extension of Lemma 3.24)

$$\begin{aligned} \theta\left(g^{i}(\mathsf{x}_{A^{i}},\mathsf{x}_{B^{i}})^{\psi_{C}(i)}\right) &\equiv \theta\left(g^{i}\left(\mathsf{x}_{A^{i}}^{\psi_{C}(i)},\mathsf{x}_{B^{i}}^{\psi_{C}(i)}\right)\right) \\ &\equiv \theta\left(g^{i}\left(\alpha_{\psi_{C}(i)}^{A}(\mathsf{x}_{A^{i}}),\alpha_{\psi_{C}(i)}^{B}(\mathsf{x}_{B^{i}})\right)\right) \\ &\equiv g\left(\theta\left(\alpha_{\psi_{C}(i)}^{A}(\mathsf{x}_{A^{i}}),\theta(\alpha_{\psi_{C}(i)}^{B}(\mathsf{x}_{B^{i}})\right)\right) \\ &\equiv g\left(\mathsf{x}_{\psi_{C}(i)}^{A},\mathsf{x}_{\psi_{C}(i)}^{B}\right). \end{aligned}$$

From this, we obtain

$$\theta\left(s_{C^{i}}\left[g^{i}(\mathsf{x}_{A^{i}},\mathsf{x}_{B^{i}})/\mathsf{x}_{C^{i}}\right]'\right) \equiv \theta\left(s_{C^{i}}\right)\left[g\left(\mathsf{x}_{\psi_{C}(i)}^{A},\mathsf{x}_{\psi_{C}(i)}^{B}\right)/\mathsf{x}_{\psi_{C}(i)}^{C}\right].$$

Finally, we have

$$\mathbb{T}\left(M^{i}, \overline{\mathsf{x}^{A}_{\mathsf{Cod}(i)}}, \overline{\mathsf{x}^{B}_{\mathsf{Cod}(i)}}\right) \vdash g\left(\theta(s_{A^{i}}), \theta\left(s_{B^{i}}\right)\right) = \theta\left(s_{C^{i}}\right) \left[g\left(\mathsf{x}^{A}_{\psi_{C}(i)}, \mathsf{x}^{B}_{\psi_{C}(i)}\right) / \mathsf{x}^{C}_{\psi_{C}(i)}\right].$$

Now, we know that $\mathsf{x}^{A}_{\psi_{A}(i)}$ is the unique indeterminate occurring in $\theta(s_{A^{i}})$, and that $\mathsf{x}^{C}_{\psi_{C}(i)}$ is the unique indeterminate occurring in $\theta(s_{C^{i}})$. Because of our assumption that $\psi_{A}(i) \neq \psi_{C}(i)$, it follows that $\mathsf{x}^{A}_{\psi_{A}(i)} \not\equiv \mathsf{x}^{A}_{\psi_{C}(i)} \in \Sigma\left(M^{i}, \overline{\mathsf{x}^{A}_{\mathsf{Cod}(i)}}\right)$. For the remainder of the argument, we will assume that $\mathbb{T}\left(M^{i}\right)$ is non-trivial for the sort B as well, so that $i \in \mathsf{ob}\mathcal{J}^{M}_{B}$ and $\psi_{B}(i) : i \to i$ is defined, and we will also assume that $\psi_{B}(i) = \psi_{C}(i)$ (so that $\mathsf{x}^{B}_{\psi_{B}(i)} \equiv \mathsf{x}^{B}_{\psi_{C}(i)}$). Without these assumptions, the required argument is a simpler version of the one we are about to give.

So, in the above equation, we can substitute $\theta\left(\left(s_{A^{i}}^{-1}\right)^{\psi_{A}(i)}\right)$ for $\mathsf{x}_{\psi_{A}(i)}^{A}$ in the lefthand term, and $\theta\left(\left(s_{B^{i}}^{-1}\right)^{\psi_{B}(i)}\right)$ for $\mathsf{x}_{\psi_{B}(i)}^{B} \equiv \mathsf{x}_{\psi_{C}(i)}^{B}$ in both terms, and we obtain

$$\begin{split} \mathbb{T}\left(M^{i}, \overline{\mathsf{x}_{\mathsf{Cod}(i)}^{A}, \overline{\mathsf{x}_{\mathsf{Cod}(i)}^{B}}}\right) &\vdash g\left(\theta(s_{A^{i}})\left[\theta\left(\left(s_{A^{i}}^{-1}\right)^{\psi_{A}(i)}\right) / \mathsf{x}_{\psi_{A}(i)}^{A}\right], \theta\left(s_{B^{i}}\right)\left[\theta\left(\left(s_{B^{i}}^{-1}\right)^{\psi_{B}(i)}\right) / \mathsf{x}_{\psi_{B}(i)}^{B}\right]\right) \\ &= \theta\left(s_{C^{i}}\right)\left[g\left(\mathsf{x}_{\psi_{C}(i)}^{A}, \theta\left(\left(s_{B^{i}}^{-1}\right)^{\psi_{B}(i)}\right)\right) / \mathsf{x}_{\psi_{C}(i)}^{C}\right]\right] \end{split}$$

(note that $A \neq B$ implies $x_{\psi_A(i)}^A \not\equiv x_{\psi_B(i)}^B$). Earlier in the proof of the proposition, we saw that

$$\mathbb{T}\left(M^{i}, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^{A}}\right) \vdash \theta(s_{A^{i}}) \left[\theta\left(\left(s_{A^{i}}^{-1}\right)^{\psi_{A}(i)}\right) / \mathbf{x}_{\psi_{A}(i)}^{A}\right] = \mathbf{x}_{\mathsf{id}}^{A}$$

and

$$\mathbb{T}\left(M^{i}, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^{B}}\right) \vdash \theta\left(s_{B^{i}}\right) \left[\theta\left(\left(s_{B^{i}}^{-1}\right)^{\psi_{B}(i)}\right) / \mathbf{x}_{\psi_{B}(i)}^{B}\right] = \mathbf{x}_{\mathsf{id}_{i}}^{B}$$

so we obtain

$$\mathbb{T}\left(M^{i}, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^{A}}, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^{B}}\right) \vdash g\left(\mathbf{x}_{\mathsf{id}_{i}}^{A}, \mathbf{x}_{\mathsf{id}_{i}}^{B}\right) = \theta\left(s_{C^{i}}\right) \left[g\left(\mathbf{x}_{\psi_{C}(i)}^{A}, \theta\left(\left(s_{B^{i}}^{-1}\right)^{\psi_{B}(i)}\right)\right) / \mathbf{x}_{\psi_{C}(i)}^{C}\right].$$

We can also repeat the above argument to show that

$$\mathbb{E}\left(M^{i}, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^{A}}, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^{B}}, \mathbf{x}_{\mathsf{id}_{i}}^{A'}\right) \vdash g\left(\mathbf{x}_{\mathsf{id}_{i}}^{A'}, \mathbf{x}_{\mathsf{id}_{i}}^{B}\right) = \theta\left(s_{C^{i}}\right) \left[g\left(\mathbf{x}_{\psi_{C}(i)}^{A}, \theta\left(\left(s_{B^{i}}^{-1}\right)^{\psi_{B}(i)}\right)\right) / \mathbf{x}_{\psi_{C}(i)}^{C}\right],$$

where $\mathbf{x}_{\mathsf{id}_i}^{A'} \notin \Sigma\left(M^i, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^A, \overline{\mathbf{x}_{\mathsf{Cod}(i)}^B}}\right)$ is a new constant of sort A. So then we obtain

$$\mathbb{T}\left(M^{i}, \overline{\mathsf{x}^{A}_{\mathsf{Cod}(i)}}, \overline{\mathsf{x}^{B}_{\mathsf{Cod}(i)}}, \mathsf{x}^{A'}_{\mathsf{id}_{i}}\right) \vdash g\left(\mathsf{x}^{A}_{\mathsf{id}_{i}}, \mathsf{x}^{B}_{\mathsf{id}_{i}}\right) = g\left(\mathsf{x}^{A'}_{\mathsf{id}_{i}}, \mathsf{x}^{B}_{\mathsf{id}_{i}}\right).$$

By (a slight variation of) [7, Lemma 5.1.30], it then follows that

$$\mathbb{T}\left(M^{i},\mathsf{x}_{\mathsf{id}_{i}}^{A},\mathsf{x}_{\mathsf{id}_{i}}^{B},\mathsf{x}_{\mathsf{id}_{i}}^{A}'\right)\vdash g\left(\mathsf{x}_{\mathsf{id}_{i}}^{A},\mathsf{x}_{\mathsf{id}_{i}}^{B}\right)=g\left(\mathsf{x}_{\mathsf{id}_{i}}^{A'},\mathsf{x}_{\mathsf{id}_{i}}^{B}\right).$$

By [5, Theorem 10] again, it follows that if y, y' : A are distinct variables and z : B is a variable, then $\mathbb{T}(M^i) \vdash^{y,y',z} g(y,z) = g(y',z)$, which contradicts the assumption that g^{M^i} is non-degenerate in position 1. This contradiction implies that we must have $\psi_A(i) = \psi_C(i) : i \to i$, as desired.

Hence, we may finally conclude that $\psi \in \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$, and therefore $(\gamma, \psi) \in (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$. It now remains to show that $\beta_M(\gamma, \psi) = ([s_{C^j}])_{j,C} \in G_{\mathbb{T}^{\mathcal{J}}}(M)$, which is not too difficult; we refer the reader to the end of the proof of [7, Proposition 5.1.47] for the verification. One can now straightforwardly show as in [7, Definition 5.1.55] that the assignment

$$M \mapsto \left(\prod_{i} G_{\mathbb{T}}\left(M^{i}\right)\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^{M} = \operatorname{lim}\left(G_{\mathbb{T}} \circ F^{M}\right) \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^{M} \in \operatorname{Group}$$

(see Lemma 3.9) is functorial, i.e. that there is a canonical functor $G^*_{\mathbb{T}^{\mathcal{J}}} : \mathbb{T}^{\mathcal{J}} \mod \rightarrow \text{Group}$ with this action on objects. We therefore obtain the following theorem, whose proof may be found in [7, Theorem 5.1.56]:

Theorem 3.52. Let \mathbb{T} be a quasi-equational theory with single-indeterminate isotropy and single-sorted nontotal operations, and let \mathcal{J} be a small index category. Then the family $(\beta_M)_{M \in \mathbb{T}^{\mathcal{J}} \mod}$ of group isomorphisms is natural in M, i.e. we have a natural isomorphism $\beta : G_{\mathbb{T}^{\mathcal{J}}}^* \xrightarrow{\sim} G_{\mathbb{T}^{\mathcal{J}}} : \mathbb{T}^{\mathcal{J}} \mod \rightarrow \text{Group}.$

Remark 3.53. We used the assumption that \mathbb{T} has single-indeterminate isotropy in order to show in Proposition 3.45 that the injective group homomorphism

$$\beta_M : \left(\prod_i G_{\mathbb{T}}\left(M^i\right)\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M \to G_{\mathbb{T}^{\mathcal{J}}}(M)$$

is also surjective for each small category \mathcal{J} and $M \in \mathbb{T}$ mod. In [7, Remark 5.1.58] we provide an example of a theory \mathbb{T} without single-indeterminate isotropy, for which there is a small category \mathcal{J} and a model Mof $\mathbb{T}^{\mathcal{J}}$ for which β_M is not surjective. So Proposition 3.45 does not hold in general for theories without single-indeterminate isotropy.

We also used the assumption that \mathbb{T} has single-sorted non-total operations in order to show that β_M is surjective for each small category \mathcal{J} and $M \in \mathbb{T}$ mod. Specifically, given $([s_{C^j}])_{j,C} \in G_{\mathbb{T}^{\mathcal{J}}}(M)$ for $M \in \mathbb{T}^{\mathcal{J}}$ mod, we produced $(\gamma, \psi) \in (\prod_i G_{\mathbb{T}}(M^i))^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$ with $\beta_M(\gamma, \psi) = ([s_{C^j}])_{j,C}$, and we used the assumption that \mathbb{T} has single-sorted non-total operations to show that $\psi \in \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M$; more specifically, we used this assumption to show that if $g: A_1 \times \ldots \times A_n \to A$ is a function symbol of Σ with $n \geq 1$ and $i \in \operatorname{ob}\mathcal{J}$ and g^{M^i} is non-degenerate in position $1 \leq m \leq n$, then $\psi_{A_m}(i) = \psi_A(i) : i \xrightarrow{\sim} i$. In [7, Remark 5.1.59] we show that there is a theory \mathbb{T} without single-sorted non-total operations for which there is a small category \mathcal{J} and a model M of $\mathbb{T}^{\mathcal{J}}$ such that β_M is not surjective. So Proposition 3.45 does not hold in general for theories that have multi-sorted operations that are not totally defined.

4. Categorical characterization

In this section, we will deduce a categorical characterization of the covariant isotropy group $\mathcal{Z}_{\mathbb{T}\mathsf{mod}^{\mathcal{J}}}$ of $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$ from the logical characterization of $G_{\mathbb{T}^{\mathcal{J}}}$ given in the previous section. Unless otherwise stated, \mathbb{T} is an arbitrary quasi-equational theory and \mathcal{J} is an arbitrary small index category.

Recall that if $F : \mathcal{J} \to \mathbb{T}\mathsf{mod}$, then $\mathsf{Dom}(F)$ is the class of morphisms in $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$ with domain F.

Definition 4.1. Let $F : \mathcal{J} \to \mathbb{T}$ mod, and let $\pi = (\pi_{\mu} : \operatorname{cod}(\mu) \to \operatorname{cod}(\mu))_{\mu \in \operatorname{Dom}(F)}$ be a $\operatorname{Dom}(F)$ -indexed family of endomorphisms in \mathbb{T} mod^{\mathcal{J}}. For each $i \in \operatorname{ob}\mathcal{J}$, let

$$\phi^i = \left(\phi^i_g: \operatorname{cod}(g) \xrightarrow{\sim} \operatorname{cod}(g)\right)_{g \in \operatorname{Dom}(F(i))} \in \mathcal{Z}_{\mathbb{T}}(F(i)).$$

Finally, let $\psi = (\psi_B)_{B \in \Sigma} \in \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^{M^F}$ (where $M^F \in \mathbb{T}^{\mathcal{J}} \operatorname{mod}$ is the model of $\mathbb{T}^{\mathcal{J}}$ corresponding to the functor F as in Proposition 3.8).

We say that π is determined by $\psi \in \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^{M^F}$ and the family $(\phi^i)_{i \in \mathcal{J}} \in \prod_{i \in \mathcal{J}} \mathcal{Z}_{\mathbb{T}}(F(i))$ if the following holds for any morphism $\mu: F \to G$ in $\operatorname{Tmod}^{\mathcal{J}}$, any $B \in \Sigma_{\mathsf{Sort}}$, and any $k \in \mathsf{ob}\mathcal{J}$:

• If $k \notin \mathcal{J}_B^{M^F}$, i.e. if $\mathbb{T}(F(k))$ is trivial for the sort B, then $\pi_{\mu}(k)_B = \mathsf{id} : G(k)_B \to G(k)_B$.

• If $k \in \mathcal{J}_B^{M^F}$, i.e. if $\mathbb{T}(F(k))$ is non-trivial for the sort B, then

$$\pi_{\mu}(k)_{B} = G(\psi_{B}(k)) \circ \phi_{\mu(k)}^{k} : G(k)_{B} \to G(k)_{B}$$

(where $\mu(k) : F(k) \to G(k)$ is a Σ -morphism).

Note that in the corresponding [7, Definition 5.2.7], the last equation of Definition 4.1 instead has the form $\pi_{\mu}(k)_B = \left(\phi_{\mu(k)\circ F(\psi_B(k))}^k\right)_B \circ G(\psi_B(k))_B$, but this is equivalent to our equation because

$$\phi_{\mu(k)\circ F(\psi_B(k))}^k \circ G(\psi_B(k)) = \phi_{G(\psi_B(k))\circ\mu(k)}^k \circ G(\psi_B(k)) = G(\psi_B(k)) \circ \phi_{\mu(k)}^k$$

by naturality of $\mu: F \to G$ and the fact that $\phi^k \in \mathcal{Z}_{\mathbb{T}}(F(k))$.

Definition 4.2. Let $F : \mathcal{J} \to \mathbb{T}$ mod. For each $i \in ob\mathcal{J}$, let

$$\phi^i = \left(\phi^i_g: \operatorname{cod}(g) \xrightarrow{\sim} \operatorname{cod}(g)\right)_{g \in \operatorname{Dom}(F(i))} \in \mathcal{Z}_{\mathbb{T}}(F(i))$$

We say that the family $(\phi^i)_{i \in \mathcal{J}} \in \prod_{i \in \mathcal{J}} \mathcal{Z}_{\mathbb{T}}(F(i))$ is *compatible* if for every morphism $f : i \to j$ in \mathcal{J} and every $g \in \mathsf{Dom}(F(j))$ we have

$$\phi_g^j = \phi_{g \circ F(f)}^i : \operatorname{cod}(g) \xrightarrow{\sim} \operatorname{cod}(g).$$

In other words, we say that $(\phi^i)_{i \in \mathcal{J}}$ is compatible if $(\phi^i)_{i \in \mathcal{J}} \in \lim(\mathcal{Z}_{\mathbb{T}} \circ F) \in \text{Group}.$

We now have the following categorical characterization of the covariant isotropy group of $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$, where we write $\mathcal{Z}_{\mathbb{T}^{\mathcal{J}}}$ in place of $\mathcal{Z}_{\mathbb{T}\mathsf{mod}^{\mathcal{J}}}$; the proof may be found in [7, Corollary 5.2.9].

Corollary 4.3. Let \mathbb{T} be a quasi-equational theory with single-indeterminate isotropy and single-sorted nontotal operations, and let \mathcal{J} be a small index category. Let $F : \mathcal{J} \to \mathbb{T}mod$, and let

$$\pi = (\pi_{\mu} : \mathsf{cod}(\mu) \to \mathsf{cod}(\mu))_{\mu \in \mathsf{Dom}(F)}$$

be a Dom(F)-indexed family of endomorphisms in $\mathbb{T} \text{mod}^{\mathcal{J}}$. Then $\pi \in \mathcal{Z}_{\mathbb{T}^{\mathcal{J}}}(F)$ iff there is a (uniquely determined) compatible family $(\phi^i)_{i \in \mathcal{J}} \in \prod_{i \in \mathcal{J}} \mathcal{Z}_{\mathbb{T}}(F(i))$ and a (uniquely determined) element $\psi = (\psi_B)_{B \in \Sigma} \in \text{Aut}(\text{Id}_{\mathcal{J}})^{M^F}$ such that π is determined by ψ and $(\phi^i)_{i \in \mathcal{J}}$.

Before we give some specific applications of the general results that we have proven so far, we will first extract an important consequence of Theorem 3.52 that does *not* rely on the assumptions that \mathbb{T} has single-indeterminate isotropy and single-sorted non-total operations, but which only applies to index categories \mathcal{J} satisfying a certain condition. Namely, we have the following consequence of (the proof of) Theorem 3.52, whose relatively straightforward proof can be found in [7, Corollary 5.2.10]:

Corollary 4.4. Let \mathbb{T} be an arbitrary quasi-equational theory and \mathcal{J} a small index category. If $M \in \mathbb{T}^{\mathcal{J}} \mod \mathcal{J}_B^M$ has only trivial endomorphisms for each $B \in \Sigma_{\mathsf{Sort}}$, then

$$\beta_M : \left(\prod_i G_{\mathbb{T}}\left(M^i\right)\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})^M \to G_{\mathbb{T}^{\mathcal{J}}}(M)$$

is a group isomorphism and in fact $G_{\mathbb{T}^{\mathcal{J}}}(M) \cong \left(\prod_{i} G_{\mathbb{T}}\left(M^{i}\right)\right)^{\mathcal{J}} = \lim \left(G_{\mathbb{T}} \circ F^{M}\right).$

We also deduce the following categorical version of the previous corollary:

Corollary 4.5. Let \mathbb{T} be an arbitrary quasi-equational theory and \mathcal{J} a small index category with only trivial endomorphisms. Let $F : \mathcal{J} \to \mathbb{T}$ mod, and let $\pi = (\pi_{\mu} : \operatorname{cod}(\mu) \to \operatorname{cod}(\mu))_{\mu \in \operatorname{Dom}(F)}$ be a $\operatorname{Dom}(F)$ -indexed family of endomorphisms in \mathbb{T} mod^{\mathcal{J}}. Then $\pi \in \mathbb{Z}_{\mathbb{T}^{\mathcal{J}}}(F)$ iff there is a (uniquely determined) compatible family $(\phi^i)_{i \in \mathcal{J}} \in \prod_{i \in \mathcal{J}} \mathbb{Z}_{\mathbb{T}}(F(i))$ such that π is determined by $(\phi^i)_{i \in \mathcal{J}}$, in the sense that

$$\pi_{\mu}(k) = \phi_{\mu(k)}^k : G(k) \to G(k)$$

for every morphism $\mu: F \to G$ in $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$ and every $k \in \mathsf{ob}\mathcal{J}$.

5. Applications

In this final section, we provide some specific applications of the general results proven in the preceding sections; in particular, we will provide an explicit characterization of the covariant isotropy group of $\text{Group}^{\mathcal{J}}$ for any small category \mathcal{J} .

First, for an *arbitrary* quasi-equational theory \mathbb{T} , we deduce from Corollary 4.4 characterizations of the covariant isotropy group of $\mathbb{T}^{\mathcal{J}}$ for certain common index categories \mathcal{J} with only *trivial* endomorphisms:

Corollary 5.1. Let \mathbb{T} be an arbitrary quasi-equational theory.

- Let \mathcal{J} be any small discrete category. Then for any $M \in \mathbb{T}^{\mathcal{J}} \mod$, i.e. any family $(M^i)_{i \in \mathcal{J}}$ of \mathbb{T} -models, we have $\mathcal{Z}_{\mathbb{T}^{\mathcal{J}}}(M) \cong \prod_{i \in \mathcal{J}} \mathcal{Z}_{\mathbb{T}}(M^i)$.
- Let \mathcal{J} be the category with two objects i, j and two parallel morphisms $f, g : i \Rightarrow j$. Then for any $M \in \mathbb{T}^{\mathcal{J}} \mod i.e.$ any parallel pair $f^M, g^M : M^i \Rightarrow M^j$ in $\mathbb{T} \mod$, we have

$$\mathcal{Z}_{\mathbb{T}^{\mathcal{J}}}(M) \cong \mathsf{Eq}\left(\mathcal{Z}_{\mathbb{T}}\left(f^{M}\right), \mathcal{Z}_{\mathbb{T}}\left(g^{M}\right)\right) = \left\{\gamma^{i} \in \mathcal{Z}_{\mathbb{T}}\left(M^{i}\right) : \mathcal{Z}_{\mathbb{T}}\left(f^{M}\right)\left(\gamma^{i}\right) = \mathcal{Z}_{\mathbb{T}}\left(g^{M}\right)\left(\gamma^{i}\right)\right\},$$

the equalizer of the group homomorphisms $\mathcal{Z}_{\mathbb{T}}(f^M)$, $\mathcal{Z}_{\mathbb{T}}(g^M)$: $\mathcal{Z}_{\mathbb{T}}(M^i) \rightrightarrows \mathcal{Z}_{\mathbb{T}}(M^j)$.

Let J be the category with three objects i, j, k and two morphisms f: i → k and g: j → k. Then for any M ∈ T^Jmod, i.e. any cospan f^M: Mⁱ → M^k, g^M: M^j → M^k in Tmod, we have

$$\mathcal{Z}_{\mathbb{T}^{\mathcal{J}}}(M) \cong \mathcal{Z}_{\mathbb{T}}\left(M^{i}\right) \times_{\mathcal{Z}_{\mathbb{T}}(M^{k})} \mathcal{Z}_{\mathbb{T}}\left(M^{j}\right) = \left\{ \left(\gamma^{i}, \gamma^{j}\right) \in \mathcal{Z}_{\mathbb{T}}\left(M^{i}\right) \times \mathcal{Z}_{\mathbb{T}}\left(M^{j}\right) : \mathcal{Z}_{\mathbb{T}}\left(f^{M}\right)\left(\gamma^{i}\right) = \mathcal{Z}_{\mathbb{T}}\left(g^{M}\right)\left(\gamma^{j}\right) \right\}$$

the pullback of the group homomorphisms
$$\mathcal{Z}_{\mathbb{T}}(f^M): M^i \to M^k, \mathcal{Z}_{\mathbb{T}}(g^M): M^j \to M^k.$$

We now provide applications of our general results for quasi-equational theories \mathbb{T} with single-indeterminate isotropy and single-sorted non-total operations, for which we can consider arbitrary small index categories. In fact, for simplicity we will restrict ourselves to *single-sorted* quasi-equational theories \mathbb{T} (which automatically have single-sorted non-total operations) with the property that $\mathbb{T}(M)$ is non-trivial (for the unique sort of \mathbb{T}) for every $M \in \mathbb{T}$ mod. A very large number of single-sorted quasi-equational theories \mathbb{T} satisfy this latter property (including the theory of groups); indeed, if $M \in \mathbb{T}$ mod, then $\mathbb{T}(M)$ will be non-trivial as long as the \mathbb{T} -model $M \langle x \rangle$ obtained by freely adjoining an indeterminate element x to M has at least two elements, which is very often the case. One salient example of a single-sorted theory that does *not* satisfy this property is the theory of unital rings, because the zero ring has no outgoing ring homomorphism to any non-zero unital ring and hence has trivial diagram theory. But this situation seems quite uncommon in practice (and of course, we can always restrict attention to functors $F : \mathcal{J} \to \mathbb{T}$ mod for which each F(i) has non-trivial diagram theory).

So let \mathbb{T} be a single-sorted quasi-equational theory with single-indeterminate isotropy such that every $M \in \mathbb{T}$ mod has non-trivial diagram theory, and let \mathcal{J} be any small index category. For any $M \in \mathbb{T}^{\mathcal{J}}$ mod we then clearly have $\mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})^M = \mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})$, and hence we obtain the following simplification of earlier results:

Corollary 5.2. Let \mathbb{T} be any single-sorted quasi-equational theory with single-indeterminate isotropy such that every $M \in \mathbb{T}$ mod has non-trivial diagram theory, and let \mathcal{J} be any small index category.

- For any $M \in \mathbb{T}^{\mathcal{J}} \mod we have \mathcal{Z}_{\mathbb{T}^{\mathcal{J}}}(M) \cong \left(\prod_{i} \mathcal{Z}_{\mathbb{T}}(M^{i})\right)^{\mathcal{J}} \times \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}}), naturally in M.$
- Let $F : \mathcal{J} \to \mathbb{T}$ mod and let $\pi = (\pi_{\mu} : \operatorname{cod}(\mu) \to \operatorname{cod}(\mu))_{\mu \in \operatorname{Dom}(F)}$ be any $\operatorname{Dom}(F)$ -indexed family of endomorphisms in \mathbb{T} mod^{\mathcal{J}}. Then $\pi \in \mathcal{Z}_{\mathbb{T}^{\mathcal{J}}}(F)$ iff there is a (uniquely determined) compatible family $(\phi^i)_{i \in \mathcal{J}} \in \prod_{i \in \mathcal{J}} \mathcal{Z}_{\mathbb{T}}(F(i))$ and a (uniquely determined) element $\psi \in \operatorname{Aut}(\operatorname{Id}_{\mathcal{J}})$ such that π is determined by $(\phi^i)_{i \in \mathcal{J}}$ and ψ , in the sense that

$$\pi_{\mu}(k) = G(\psi(k)) \circ \phi_{\mu(k)}^{k} : G(k) \xrightarrow{\sim} G(k)$$

for every morphism $\mu: F \to G$ in $\mathbb{T}\mathsf{mod}^{\mathcal{J}}$ and every $k \in \mathsf{ob}\mathcal{J}$.

We note that Corollary 5.2 specializes to the characterization of covariant isotropy for presheaf categories $\mathsf{Set}^{\mathcal{J}}$ obtained in [4, Corollary 22]. Namely, if \mathbb{T} is the single-sorted theory with no operations and no axioms, so that $\mathbb{T}\mathsf{mod} = \mathsf{Set}$, then since \mathbb{T} has trivial and hence single-indeterminate isotropy (see [7, Corollary 3.1.6]) and clearly satisfies the other assumptions of Corollary 5.2, it follows that for any presheaf $F : \mathcal{J} \to \mathsf{Set}$ we have $\mathcal{Z}_{\mathsf{Set}^{\mathcal{J}}}(F) \cong \mathsf{Aut}(\mathsf{Id}_{\mathcal{J}})$, since $\mathcal{Z}_{\mathsf{Set}}(F(i))$ is trivial for each $i \in \mathsf{ob}\mathcal{J}$. This is precisely what is stated in [4, Corollary 22].

As promised, we now use Corollary 5.2 to provide an explicit characterization of the covariant isotropy group of $\operatorname{\mathsf{Group}}^{\mathcal{J}}$ for any small category \mathcal{J} . The quasi-equational theory \mathbb{T} of groups is single-sorted, has single-indeterminate isotropy (see [3, Example 4.1] or [7, Proposition 3.2.7]), and the diagram theory of any group is non-trivial (if G is any group, then the group $G\langle x \rangle$ is non-trivial). Now let $F: \mathcal{J} \to \operatorname{\mathsf{Group}}$ be any functor. Then for any $i \in \operatorname{ob}\mathcal{J}$ and any $\operatorname{\mathsf{Dom}}(F(i))$ -indexed family of group endomorphisms $\phi^i = \left(\phi^i_f: \operatorname{cod}(f) \to \operatorname{cod}(f)\right)_{f \in \operatorname{Dom}(F(i))}$, we have $\phi^i \in \mathcal{Z}_{\operatorname{\mathsf{Group}}}(F(i))$ iff there is a unique element $g_i \in F(i)$ such that for every outgoing group homomorphism $f: F(i) \to G$, the endomorphism $\phi^i_f: G \to G$ is the inner automorphism $\operatorname{inn}_{f(g_i)}$ induced by the element $f(g_i) \in G$ (see [1, Theorem 1] or [7, Corollary 3.2.8]). We then have:

Claim 5.3. A family $(\phi^i)_{i \in \mathcal{J}} \in \prod_{i \in \mathcal{J}} \mathcal{Z}_{\mathsf{Group}}(F(i))$ is compatible in the sense of Definition 4.2 iff $F(h)(g_i) = g_j$ for any morphism $h: i \to j$ in \mathcal{J} , i.e. iff $(g_i)_{i \in \mathcal{J}} \in \mathsf{lim} F$.

Proof. Suppose first that $(\phi^i)_{i \in \mathcal{J}} \in \prod_{i \in \mathcal{J}} \mathcal{Z}_{\mathsf{Group}}(F(i))$ is compatible, let $h: i \to j$ be a morphism of \mathcal{J} , and let us show $F(h)(g_i) = g_j$. We have the inclusion group homomorphism $\eta: F(j) \to F(j) \langle \mathsf{x} \rangle$, so by compatibility it follows that $\phi^j_{\eta} = \phi^i_{\eta \circ F(h)} : F(j) \langle \mathsf{x} \rangle \xrightarrow{\sim} F(j) \langle \mathsf{x} \rangle$, and hence $\mathsf{inn}_{\eta(g_j)} = \mathsf{inn}_{\eta(F(h)(g_i))} : F(j) \langle \mathsf{x} \rangle \xrightarrow{\sim} F(j) \langle \mathsf{x} \rangle$. We then obtain

$$g_j \mathsf{x} g_j^{-1} = \mathsf{inn}_{\eta(g_j)}(\mathsf{x}) = \mathsf{inn}_{\eta(F(h)(g_i))}(\mathsf{x}) = F(h)(g_i) \mathsf{x} F(h)(g_i)^{-1}$$

in $F(j) \langle \mathbf{x} \rangle$, which forces $F(h)(g_i) = g_j$, as desired. Conversely, if $(g_i)_{i \in \mathcal{J}} \in \lim F$ and $h: i \to j$ is a morphism of \mathcal{J} , then for any group homomorphism $f: F(j) \to G$ we have $\phi_f^j = \inf_{f \in F(h)} (g_i) = \phi_{f \in F(h)}^i$, as desired.

We now have the following application of Corollary 5.2:

Corollary 5.4. Let \mathcal{J} be any small index category.

- For any $F : \mathcal{J} \to \text{Group}^{\mathcal{J}}(F) \cong \lim F \times \text{Aut}(\text{Id}_{\mathcal{J}})$, naturally in F.
- Let $F : \mathcal{J} \to \text{Group}$ and let $\pi = (\pi_{\mu} : \text{cod}(\mu) \to \text{cod}(\mu))_{\mu \in \text{Dom}(F)}$ be any Dom(F)-indexed family of endomorphisms in $\text{Group}^{\mathcal{J}}$. Then $\pi \in \mathcal{Z}_{\text{Group}^{\mathcal{J}}}(F)$ iff there is a uniquely determined family $(g_i)_{i \in \mathcal{J}} \in$ lim F and a uniquely determined element $\psi \in \text{Aut}(\text{Id}_{\mathcal{J}})$ such that π is determined by ψ and $(g_i)_{i \in \mathcal{J}}$ in the sense that

$$\pi_{\mu}(k) = G(\psi(k)) \circ \operatorname{inn}_{\mu_{k}(g_{k})} : G(k) \xrightarrow{\sim} G(k)$$

for every morphism $\mu: F \to G$ in $\text{Group}^{\mathcal{J}}$ and every $k \in \text{ob}\mathcal{J}$.

• Thus, an automorphism $\pi : F \xrightarrow{\sim} F$ of $F : \mathcal{J} \to \text{Group}$ is inner iff there are $(g_i)_{i \in \mathcal{J}} \in \text{lim } F$ and $\psi \in \text{Aut}(\text{Id}_{\mathcal{J}})$ such that $\pi(k) = F(\psi(k)) \circ \text{inn}_{g_k} : F(k) \xrightarrow{\sim} F(k)$ for each $k \in \text{ob}\mathcal{J}$.

Proof. The first claim follows from the first claim of Corollary 5.2 because $(\prod_i \mathcal{Z}_{\mathbb{T}}(F(i)))^{\mathcal{J}} = \lim (\mathcal{Z}_{\mathsf{Group}} \circ F) \cong \lim F$, since $\mathcal{Z}_{\mathsf{Group}} \cong \mathsf{Id}$ by [1, Theorem 2]. The second claim follows from the second claim of Corollary 5.2 by the preceding observations (including Claim 5.3), and the last claim follows from the second and the definition of inner automorphisms in terms of $\mathcal{Z}_{\mathsf{Group}^{\mathcal{J}}}(F)$ (see the Introduction).

Thus, while Bergman's [1, Theorem 1] shows that the categorical inner automorphisms in Group are precisely the conjugation-theoretic inner automorphisms, our Corollary 5.4 shows that the categorical inner automorphisms in any category $\text{Group}^{\mathcal{J}}$ of presheaves of groups can be characterized in terms of the conjugation-theoretic inner automorphisms of the component groups, together with natural automorphisms of $\text{Id}_{\mathcal{J}}$.
