# HYPERCYCLICITY AND SUBSPACE HYPERCYCLICITY IN FINITE DIMENSION

ABSTRACT. This paper is motivated by the article of Bamerni, Kadets and Kiliçman [J. Math. Anal. Appl. 435 (2), 1812–1815 (2016)]. We consider the remaining problem which claims that if A is a dense subset of a finite dimensional space X, then there is a nontrivial subspace Mof X such that  $A \cap M$  is dense in M. We show that the above problem has a negative answer when  $X = \mathbb{K}^n$  ( $\mathbb{K} = \mathbb{R}$  or  $\mathbb{C}$ ) for every  $n \geq 2$ . However we answer positively the problem when the dense subset A is an orbit of an abelian semigroup of matrices on  $\mathbb{K}^n$ ,  $\mathbb{K}^n \neq \mathbb{R}^2$ .

## 1. Introduction

In [3, Theorem 2.1], Bamerni, Kadets and Kiliçman established that if A is a dense subset of a Banach space X, then there is a nontrivial closed subspace M of X such that  $A \cap M$  is dense in M. By a nontrivial subspace M of X, we mean that M is non-zero and distinct from X. We point out that Lemma 2.3 of [3] is not correct whenever X is of finite dimension (see Remark 2.8). We acknowledge here that the authors of [3] do not clearly meant X of infinite dimension. So Theorem 2.1 in finite dimension remains an open problem.

Problem 1. Is Theorem 2.1 of [3] true for X of finite dimension?

The above problem is also addressed for the action of abelian semigroups of matrices on  $X = \mathbb{K}^n$ ,  $\mathbb{K} = \mathbb{R}$  or  $\mathbb{C}$ .

Problem 2. Is Corollary 2.4 of [3] true for the action of abelian semigroups on  $\mathbb{K}^n$ ?

In the present paper, we show that Problem 1 does not hold in finite dimension, that is [3, Theorem 2.1] is not true for every finite dimensional space  $X = \mathbb{K}^n$ ,  $n \geq 2$ . On the other hand, with regard to the action of abelian semigroups on  $\mathbb{K}^n$ , we answer positively Problem 2 (see Section 3); we show that if G is an hypercyclic abelian semigroup of matrices on  $\mathbb{K}^n$ and  $\mathbb{K}^n \neq \mathbb{R}^2$ , then it is subspace-hypercyclic. If  $\mathbb{K}^n = \mathbb{R}^2$ , we construct a counterexample consisting of a parameter family of abelian semigroups

of matrices on  $\mathbb{R}^2$  which are hypercyclic, but not subspace-hypercyclic for every straight line in  $\mathbb{R}^2$  (see Example 4.1).

In the sequel,  $\mathbb{N}$  and  $\mathbb{Z}$  denote the sets of non-negative integers and integers, respectively,  $\mathbb{N} = \{0, 1, 2, ...\}$  while  $\mathbb{N}_0 = \mathbb{N} \setminus \{0\}$  denotes the set of positive integers. For a row vector  $v \in \mathbb{K}^n$ , we will be denoting by  $v^T$  the transpose of v. If  $v_1, \ldots, v_p \in \mathbb{K}^n$ ,  $p \ge 1$ , we denote by  $\operatorname{Vect}\{v_1, \ldots, v_p\}$  the vector subspace of  $\mathbb{K}^n$  generated by  $v_1, \ldots, v_p$ . A subset  $E \subset \mathbb{K}^n$  is called *dense* in  $\mathbb{K}^n$  if  $\overline{E} = \mathbb{K}^n$ , where  $\overline{E}$  denotes the closure of E. It is called *nowhere dense* if  $\overline{E}$  has empty interior.

## 2. Subspace hypercyclicity in finite dimension

The aim of this section is to prove the following theorem.

**Theorem 2.1** (The case  $X = \mathbb{R}^n$ ). Let  $n \in \mathbb{N}, n \geq 2$  and  $\alpha = (\alpha_1, \ldots, \alpha_n)$ , where  $\alpha_1, \ldots, \alpha_n$  are negative real numbers such that  $1, \alpha_1, \ldots, \alpha_n$  are linearly independent over  $\mathbb{Q}$ . Set  $A_{\alpha} = \mathbb{N}^n + \mathbb{N}[\alpha_1, \ldots, \alpha_n]^T$ . Then  $A_{\alpha}$  is dense in  $\mathbb{R}^n$  and for every nontrivial subspace M of  $\mathbb{R}^n$ ,  $A_{\alpha} \cap M$  is not dense in M.

For this, let recall the following multidimensional real version of Kronecker's theorem (see e.g. [8, Lemma 2.2]; see also [5, Theorem 442]).

**Lemma 2.2.** (Kronecker's Theorem [8, Lemma 2.2]) Let  $\alpha_1, \ldots, \alpha_n$  be negative real numbers such that  $1, \alpha_1, \ldots, \alpha_n$  are linearly independent over  $\mathbb{Q}$ . Then the set

 $\mathbb{N}^n + \mathbb{N}[\alpha_1, \dots, \alpha_n]^T := \left\{ [s_1, \dots, s_n]^T + s[\alpha_1, \dots, \alpha_n]^T : s, s_1, \dots, s_n \in \mathbb{N} \right\}$ is dense in  $\mathbb{R}^n$ .

**Lemma 2.3.** ([8, Lemma 2.1]) Let  $H = \mathbb{Z}u_1 + \cdots + \mathbb{Z}u_m$  with  $u_k \in \mathbb{R}^n$ ,  $k = 1, \ldots, m$ . If  $m \leq n$ , then H is nowhere dense in  $\mathbb{R}^n$ .

**Proof of Theorem 2.1.** First  $A_{\alpha}$  is dense in  $\mathbb{R}^n$  by Lemma 2.2. Now suppose that there is a nontrivial subspace M of  $\mathbb{R}^n$  of dimension r  $(1 \le r \le n-1)$  such that  $A_{\alpha} \cap M$  is dense in M. One can choose a basis  $\{v_1, v_2, \ldots, v_r\}$  of M so that

$$\begin{cases} v_1 &= [x_{1,1}, x_{2,1}, \dots, x_{n,1}]^T, \\ v_2 &= [0, x_{2,2}, \dots, x_{n,2}]^T, \\ \vdots \\ v_r &= [0, \dots, 0, x_{r,r}, \dots, x_{n,r}]^T \end{cases}$$

with  $x_{i,j} \in \mathbb{R}$ .

• First, we have  $x_{1,1} \neq 0$ . Indeed, for every  $u \in A_{\alpha} \cap M$ , there exist  $m, m_1, \ldots, m_n \in \mathbb{N}$  and  $\lambda_1, \ldots, \lambda_r \in \mathbb{R}$  such that

(1) 
$$u = [m_1, \dots, m_n]^T + m[\alpha_1, \dots, \alpha_n]^T = \lambda_1 v_1 + \dots + \lambda_r v_r.$$

The first coordinate in (1) gives that  $m_1 + m\alpha_1 = \lambda_1 x_{1,1}$ . If  $x_{1,1} = 0$ , then m = 0 and thus  $A_{\alpha} \cap M \subset \mathbb{N}^n \cap M$  which is clearly not dense in M, a contradiction.

We let  $I = \{i \in \{1, \dots, r\} : x_{i,i} = 0\}$ . Set

$$k = \begin{cases} \min(I) & \text{if } I \neq \emptyset \\ r+1 & \text{if } I = \emptyset \end{cases}$$

Obviously  $2 \le k \le r+1$ . Denote by

$$\begin{cases} v_1^{(k)} &= [x_{1,1}, x_{2,1}, \dots, x_{k,1}]^T, \\ v_2^{(k)} &= [0, x_{2,2}, \dots, x_{k,2}]^T, \\ \vdots \\ v_{k-1}^{(k)} &= [0, \dots, 0, x_{k-1,k-1}, x_{k,k-1}]^T. \end{cases}$$

Then  $v_1^{(k)}, v_2^{(k)}, \dots, v_{k-1}^{(k)}$  are linearly independent in  $\mathbb{R}^k$ . Set

- $A_{\alpha}^{(k)} = \mathbb{N}^k + \mathbb{N}[\alpha_1, \dots, \alpha_k]^T$
- $M^{(k)}$  be the subspace of  $\mathbb{R}^k$  generated by  $\{v_1^{(k)}, v_2^{(k)}, \dots, v_{k-1}^{(k)}\}$ .

Since  $A_{\alpha} \cap M$  is dense in M, so  $A_{\alpha}^{(k)} \cap M^{(k)}$  is dense in  $M^{(k)}$ . Then one can assume, by some elementary transformations of the  $v_i^{(k)}$ ,  $i = 1, \ldots, k-1$ , that  $M^{(k)}$  has a basis  $\{u_1, u_2, \ldots, u_{k-1}\}$ , where

$$\begin{cases} u_1 &= [1, 0, \dots, 0, y_1]^T, \\ u_2 &= [0, 1, 0, \dots, 0, y_2]^T, \\ \vdots \\ u_{k-1} &= [0, \dots, 0, 1, y_{k-1}]^T, \end{cases}$$

with  $y_i \in \mathbb{R}, i = 1, \ldots, k - 1$ .

Denote by

• 
$$\Omega = \left\{ u = [m_1, \dots, m_k]^T + m[\alpha_1, \dots, \alpha_k]^T \in A_{\alpha}^{(k)} \cap M^{(k)} : m \neq 0 \right\}.$$

Then  $\Omega$  is dense in  $M^{(k)}$ : Indeed, we have  $(A_{\alpha}^{(k)} \cap M^{(k)}) \setminus \Omega \subset \mathbb{N}^k \cap M^{(k)}$  which is nowhere dense in  $M^{(k)}$ . Since  $A_{\alpha}^{(k)} \cap M^{(k)}$  is dense in  $M^{(k)}$ , so  $\Omega$  is dense in  $M^{(k)}$ .

In the sequel, let  $u \in \Omega$  be fixed:

$$u = [m_1, \dots, m_k]^T + m[\alpha_1, \dots, \alpha_k]^T = \lambda_1 u_1 + \dots + \lambda_{k-1} u_{k-1},$$

where  $m, m_1, \ldots, m_k \in \mathbb{N}, m \neq 0$  and  $\lambda_1, \ldots, \lambda_{k-1} \in \mathbb{R}$ . Observe that for

every  $v \in \Omega$ :

$$v = [t_1, \dots, t_k]^T + t[\alpha_1, \dots, \alpha_k]^T = \delta_1 u_1 + \dots + \delta_{k-1} u_{k-1}$$

where  $\delta_1, \ldots, \delta_{k-1} \in \mathbb{R}$ ,  $t_1, \ldots, t_k, t \in \mathbb{N}$  with  $t \neq 0$ , we obtain for  $i = 1, \ldots, k-1$ :

$$\begin{cases} t_i + t\alpha_i &= \delta_i \\ m_i + m\alpha_i &= \lambda_i \\ mv - tu &= (mt_1 - tm_1)u_1 + \dots + (mt_{k-1} - tm_{k-1})u_{k-1} \end{cases}$$
  
We have  
(\*)  $m_k + m\alpha_k = (m_1 + m\alpha_1)y_1 + \dots + (m_{k-1} + m\alpha_{k-1})y_{k-1}.$ 

Moreover, the last row of mv - tu gives that

(\*\*)  $mt_k - tm_k = (mt_1 - tm_1)y_1 + \dots + (mt_{k-1} - tm_{k-1})y_{k-1}$ .

From (\*\*), we distinguish two cases:

Case 1:  $1, y_1, \ldots, y_{k-1}$  are linearly independent over  $\mathbb{Q}$ . In this case, for every  $v \in \Omega$ , we have from (\*\*),  $mt_i - tm_i = 0$  for  $i = 1, \ldots, k$ . Therefore mv = tu. It follows that  $m\Omega \subset \mathbb{N}u$  and thus by density  $M^{(k)} = \mathbb{N}u = \mathbb{R}u$ . A contradiction.

Case 2: 1,  $y_1, \ldots, y_{k-1}$  are not linearly independent over  $\mathbb{Q}$ . First, observe that  $y_1, \ldots, y_{k-1}$  are not all in  $\mathbb{Q}$ ; otherwise,  $y_1, \ldots, y_{k-1} \in \mathbb{Q}$ and then by (\*), m = 0. Therefore  $A_{\alpha}^{(k)} \cap M^{(k)} \subset \mathbb{N}^k \cap M^{(k)}$  and thus  $A_{\alpha}^{(k)} \cap M^{(k)}$  is not dense in  $M^{(k)}$ . A contradiction. Second, let j be the maximal number of the rationally independent numbers with 1 among  $y_1, \ldots, y_{k-1}$ . This means that there exist  $1 \leq i_1 < i_2 < \cdots < i_j \leq k-2$  such that:  $-\{1, y_{i_1}, \ldots, y_{i_j}\}$  is linearly independent over  $\mathbb{Q}$ , - for every  $p \in \{1, \ldots, k-1\} \setminus \{i_1, i_2, \ldots, i_j\}$ ,  $y_p = a_{0,p} + a_{1,p}y_{i_1} + \cdots + a_{j,p}y_{i_j}$ , for some  $a_{0,p}, a_{1,p}, \ldots, a_{j,p} \in \mathbb{Q}$ . Notice that  $1 \leq j \leq k-2$ .

We can assume, by permuting indices if necessary, that  $i_l = l, l = 1, ..., j$ . Then we have, for every p = j + 1, ..., k - 1,

$$(***)$$
  $y_p = a_{0,p} + a_{1,p}y_1 + \dots + a_{j,p}y_j$ , for some  $a_{0,p}, a_{1,p}, \dots, a_{j,p} \in \mathbb{Q}$

Now let  $v \in \Omega$ :  $v = [t_1, \ldots, t_k]^T + t[\alpha_1, \ldots, \alpha_k]^T$ , with  $t \neq 0$ . From (\*\*) and (\*\*\*), we have that

$$mt_{k} - tm_{k} = (mt_{1} - tm_{1})y_{1} + \dots + (mt_{k-1} - tm_{k-1})y_{k-1}$$

$$= (mt_{1} - tm_{1})y_{1} + \dots + (mt_{j} - tm_{j})y_{j}$$

$$+ \sum_{i=j+1}^{k-1} (mt_{i} - tm_{i})(a_{0,i} + a_{1,i}y_{1} + \dots + a_{j,i}y_{j})$$

$$= \sum_{i=j+1}^{k-1} (mt_{i} - tm_{i})a_{0,i} + ((mt_{1} - tm_{1}) + \sum_{i=j+1}^{k-1} (mt_{i} - tm_{i})a_{1,i})y_{1}$$

$$+ \dots + ((mt_{j} - tm_{j}) + \sum_{i=j+1}^{k-1} (mt_{i} - tm_{i})a_{j,i})y_{j}.$$

Since  $\{1, y_1, \ldots, y_j\}$  is linearly independent over  $\mathbb{Q}$ , we obtain that

$$\begin{cases} mt_k - tm_k &= \sum_{i=j+1}^{k-1} (mt_i - tm_i)a_{0,i}, \\ mt_s - tm_s + \sum_{i=j+1}^{k-1} (mt_i - tm_i)a_{s,i} &= 0, \text{ for all } s = 1, \dots, j \end{cases}$$

Therefore

$$mv - tu = \begin{pmatrix} mt_1 - tm_1 \\ mt_2 - tm_2 \\ \vdots \\ mt_{k-1} - tm_{k-1} \\ mt_k - tm_k \end{pmatrix} = \begin{pmatrix} -\sum_{i=j+1}^{k-1} (mt_i - tm_i)a_{1,i} \\ \vdots \\ -\sum_{i=j+1}^{k-1} (mt_i - tm_i)a_{j,i} \\ mt_{j+1} - tm_{j+1} \\ \vdots \\ mt_{k-1} - tm_{k-1} \\ \sum_{i=j+1}^{k-1} (mt_i - tm_i)a_{0,i} \end{pmatrix}$$

It follows that there exist  $w_1, w_2, \ldots, w_{k-j} \in \mathbb{R}^k$  such that

$$mv - tu = tw_1 + t_{j+1}w_2 + \dots + t_{k-1}w_{k-j}.$$

Hence

$$mv = t(w_1 + u) + t_{j+1}w_2 + \dots + t_{k-1}w_{k-j}.$$

We obtain that

$$m\Omega \subset \mathbb{N}(w_1+u) + \mathbb{N}w_2 + \dots + \mathbb{N}w_{k-j} \subset \operatorname{Vect}\{(w_1+u), w_2, \dots, w_{k-j}\}.$$

Since  $\Omega$  is dense in  $M^{(k)}$ , so dim $M^{(k)} = k - 1 \leq k - j$  and thus j = 1. It follows that  $M^{(k)} = \text{Vect}\{w_1 + u_0, w_2, \dots, w_{k-1}\}$  and thus

 $\mathbb{N}(w_1 + u_0) + \mathbb{N}w_2 + \cdots + \mathbb{N}w_{k-1}$  is dense in  $\mathbb{M}^{(k)}$ . A contradiction with Lemma 2.3. The proof of Theorem 2.1 is complete.

**Theorem 2.4** (The case  $X = \mathbb{C}^n$ ). Let  $n \in \mathbb{N}, n \geq 2$ ,  $\alpha = (\alpha_1, \ldots, \alpha_n)$ ,  $\beta = (\beta_1, \ldots, \beta_n)$ , where  $\alpha_1, \ldots, \alpha_n; \beta_1, \ldots, \beta_n$  are negative real numbers such that  $1, \alpha_1, \ldots, \alpha_n, \beta_1, \ldots, \beta_n$  are linearly independent over  $\mathbb{Q}$ . Set  $A_{\alpha,\beta} = \mathbb{N}^n + i\mathbb{N}^n + \mathbb{N}[\alpha_1 + i\beta_1, \ldots, \alpha_n + i\beta_n]^T$ . Then  $A_{\alpha,\beta}$  is dense in  $\mathbb{C}^n$ and for every nontrivial subspace M of  $\mathbb{C}^n, A_{\alpha,\beta} \cap M$  is not dense in M.

We use the following complex version of Kronecker's theorem.

**Lemma 2.5** (Kronecker's theorem: complex version). Let  $\alpha_1, \ldots, \alpha_n; \beta_1, \ldots, \beta_n$  be negative real numbers such that  $1, \alpha_1, \ldots, \alpha_n, \beta_1, \ldots, \beta_n$  are linearly independent over  $\mathbb{Q}$ . Then  $\mathbb{N}^n + i\mathbb{N}^n + \mathbb{N}[\alpha_1 + i\beta_1, \ldots, \alpha_n + i\beta_n]^T$  is dense in  $\mathbb{C}^n$ .

*Proof.* This results from Lemma 2.2 by identifying  $\mathbb{C}^n$  with  $\mathbb{R}^{2n}$  in the natural way.

Proof of Theorem 2.4. First  $A_{\alpha,\beta}$  is dense in  $\mathbb{C}^n$  by Lemma 2.5. Assume there is a nontrivial subspace M of  $\mathbb{C}^n$  such that  $A_{\alpha,\beta} \cap M$  is dense in M. Let  $M_1, M_2$  be two subspaces of  $\mathbb{R}^n$  such that  $M = M_1 + iM_2$ . By the isomorphism  $\phi : (x_1 + iy_1, \ldots, x_n + iy_n) \in \mathbb{C}^n \mapsto (x_1, y_1; \ldots; x_n, y_n) \in \mathbb{R}^{2n}$ , we have that  $\phi(A_{\alpha,\beta}) = \mathbb{N}^{2n} + \mathbb{N}[\alpha_1, \beta_1; \ldots; \alpha_n, \beta_n]^T$  and  $\phi(A_{\alpha,\beta} \cap M) = \phi(A_{\alpha,\beta}) \cap \phi(M) = A_{\mu} \cap (M_1 \times M_2)$ , where  $\mu = [\alpha_1, \beta_1; \ldots; \alpha_n, \beta_n]^T$ . Then  $A_{\mu} \cap (M_1 \times M_2)$  is dense in  $M_1 \times M_2$ ,  $(M_1 \times M_2$  is a nontrivial subspace of  $\mathbb{R}^{2n}$ ). This leads to a contradiction with Theorem 2.1.

We give in the two propositions below other dense subsets A of  $\mathbb{K}^2$  such that for every straight line  $\Delta$  in  $\mathbb{K}^2$ ,  $A \cap \Delta$  is not dense in  $\Delta$ .

**Proposition 2.6** (Counterexample in  $\mathbb{C}^2$ ). Let  $\theta_1, \theta_2 \in \mathbb{R}$  such that  $1, \theta_1, \theta_2$ are rationally independent and set  $A_2 = \{[r_1e^{2i\pi n_1\theta_1}, r_2e^{2i\pi n_2\theta_2}]^T : r_1, r_2 \in \mathbb{R}^*_+, n_1, n_2 \in \mathbb{N}\}$ . Then  $A_2$  is dense in  $\mathbb{C}^2$ , but  $A_2 \cap \Delta$  is not dense in  $\Delta$ , for every straight line  $\Delta$  in  $\mathbb{C}^2$ .

Proof. As  $1, \theta_1, \theta_2$  are rationally independent, then A is dense in  $\mathbb{C}^2$ . We let  $\Delta = \mathbb{C}u$ , where  $u = [a_1, a_2]^T \in \mathbb{C}^2 \setminus \{(0, 0)\}$ . Suppose that  $A_2 \cap \Delta$  is dense in  $\Delta$ . One can assume that  $a_1 a_2 \neq 0$  (since  $A_2 \cap \Delta = \emptyset$  whenever  $a_1 a_2 = 0$ ). We let  $\frac{a_2}{a_1} = \frac{|a_2|}{|a_1|} e^{2i\pi\theta}$ , where  $\theta \in \mathbb{R}$ . An element  $z \in A_2 \cap \Delta$  can be written as  $z = [r_1 e^{2i\pi n_1 \theta_1}, r_2 e^{2i\pi n_2 \theta_2}]^T = \lambda [a_1, a_2]^T$ , where  $\lambda \in \mathbb{C}$ . We have  $\frac{a_2}{a_1} = \frac{|a_2|}{|a_1|} e^{2i\pi(n_2\theta_2 - n_1\theta_1)} = \frac{|a_2|}{|a_1|} e^{2i\pi\theta}$ . Hence  $\theta = n_2\theta_2 - n_1\theta_1 + k$  for some  $k \in \mathbb{Z}$ . The triplet  $(n_1, n_2, k)$  is unique. Indeed, if  $(t_1, t_2, k')$  is another triplet such that  $\theta = t_2\theta_2 - t_1\theta_1 + k'$ , then  $(n_2 - t_2)\theta_2 - (n_1 - t_1)\theta_1 + (k - k') = 0$ . As  $1, \theta_1, \theta_2$  are rationally independent, then  $n_2 = t_2, n_1 = t_1, k = k'$ . Finally,  $A \cap \Delta = \mathbb{R}^*_+ v$ , where  $v = [e^{2i\pi n_1\theta_1}, \frac{|a_2|}{|a_1|} e^{2i\pi n_2\theta_2}]^T$  and  $n_1$  and  $n_2$  are fixed. Clearly  $A \cap \Delta$  is not dense in  $\Delta$ .

**Proposition 2.7** (Counterexample in  $\mathbb{R}^2$ ). Let  $B = \{re^{2i\pi\theta} : r \in \mathbb{R}^*_+, \theta \in [0, \frac{1}{2}[\cup([\frac{1}{2}, 1[\cap(\mathbb{R} \setminus \mathbb{Q}))]\})\}$ . Then B is dense in  $\mathbb{R}^2$ , but for every straight line through the origin  $\Delta$ , the intersection  $B \cap \Delta$ , is not dense in  $\Delta$ .

*Proof.* Indeed,  $B \cap \Delta$  is only a half line, and thus not dense in  $\Delta$ .

**Remark 2.8.** We shall show that Lemma 2.3 of [3] is not true if  $X = \mathbb{K}^n$ , for every  $n \ge 1$ . Fix an arbitrary (n-1)-dimensional subspace Y of X, and let  $A = X \setminus Y$ , which is dense in X. Let  $e \in X$  with d(e, Y) > 1, which exists  $(d(e, Y) = \inf_{y \in Y} ||e - y||$ , where || || denotes the euclidean norm in  $\mathbb{K}^n$ ). Then Lemma 2.3 of [3] claims that there is some  $a \in A$  such that  $d(e, \operatorname{Vect}\{Y, a\}) > 1$ , which is absurd since  $e \in \operatorname{Vect}\{Y, a\}$ .

# 3. Subspace hypercyclicity for abelian semigroups in finite dimensional space

In this section, we will show that the analogue of [3, Corollary 2.4] is true for the action of abelian semigroups on  $X = \mathbb{K}^n \neq \mathbb{R}^2$ . Let us begin by some definitions.

Let  $\mathcal{M}_n(\mathbb{K})$  be the set of all square matrices over  $\mathbb{K}$  of order  $n \geq 1$ . Let Gbe an abelian sub-semigroup of  $\mathcal{M}_n(\mathbb{K})$ . By a sub-semigroup of  $\mathcal{M}_n(\mathbb{K})$ , we mean a subset of  $\mathcal{M}_n(\mathbb{K})$  which is stable under multiplication and contains the identity matrix. For a vector  $v \in \mathbb{K}^n$ , we consider the *orbit* of G through  $v: G(v) = \{Av : A \in G\} \subset \mathbb{K}^n$ . A subset  $E \subset \mathbb{K}^n$  is called *G*-invariant if  $A(E) \subset E$  for every  $A \in G$ . The orbit  $G(v) \subset \mathbb{K}^n$  is called *dense* in  $\mathbb{K}^n$ if  $\overline{G(v)} = \mathbb{K}^n$ . We say that G is hypercyclic if there exists a vector  $v \in \mathbb{K}^n$ such that G(v) is dense in  $\mathbb{K}^n$ . In this case, v is called a hypercyclic vector for G. G is called subspace-hypercyclic for a non-zero subspace M of  $\mathbb{K}^n$ , if there exists  $x \in \mathbb{K}^n$  such that  $G(x) \cap M$  is dense in M. We state the main result of this section.

**Theorem 3.1.** Let G be an abelian semigroup of  $\mathcal{M}_n(\mathbb{K})$ ,  $n \geq 2$ . Assume that  $X = \mathbb{K}^n \neq \mathbb{R}^2$ . If G is hypercyclic, then it is subspace-hypercyclic for a nontrivial subspace of X.

**Remark 3.2.** Since [3, Theorem 2.1] does not work according to Theorem 2.1, so the statement and the proof of [6, Corollary 2.8] (which used [3, Theorem 2.1]) should be changed and replaced by Theorem 3.1.

Before the proof, we need to introduce the following notations and definitions. Let  $n \in \mathbb{N}_0$  be fixed. We denote by

-  $\mathcal{B}_0 = (e_1, \ldots, e_n)$  the canonical basis of  $\mathbb{K}^n$ .

-  $I_n$  the identity matrix on  $\mathbb{K}^n$ .

Case  $\mathbb{K} = \mathbb{C}$ :

Let  $n \in \mathbb{N}_0$  be fixed. Let  $r \in \mathbb{N}$ . By a partition of n, we mean a finite sequence of positive integers  $\eta = (n_1, \ldots, n_r)$  such that  $\sum_{i=1}^r n_i = n$ . Given a partition  $\eta = (n_1, \ldots, n_r)$ , we denote by:

•  $\mathbb{T}_m(\mathbb{C})$  is the set of all  $m \times m$  lower triangular matrices over  $\mathbb{C}$  with only one eigenvalue, for each  $m = 1, 2, \ldots, n$ 


•  $\mathcal{K}_{\eta}(\mathbb{C}) := \mathbb{T}_{n_1}(\mathbb{C}) \oplus \cdots \oplus \mathbb{T}_{n_r}(\mathbb{C}).$ In particular,  $\mathcal{K}_{\eta}(\mathbb{C}) = \mathbb{T}_{n}(\mathbb{C})$  and  $\eta = (n)$  if r = 1. •  $u_{\eta} = [e_{\eta,1}, \dots, e_{\eta,r}]^{T} \in \mathbb{C}^{n}$ , where  $e_{\eta,k} = [1, 0, \dots, 0]^{T} \in \mathbb{C}^{n_{k}}$ ,  $k = 1, \dots, r$ .

Case  $\mathbb{K} = \mathbb{R}$ :

Let  $n \in \mathbb{N}_0$  be fixed. Let  $r, s \in \mathbb{N}$ . By a partition of n, we mean a finite sequence of positive integers  $\eta = (n_1, \ldots, n_r; m_1, \ldots, m_s)$  such that  $\sum_{i=1}^{r} n_i + 2\sum_{j=1}^{s} m_j = n.$  In particular, we have  $r + 2s \le n$ .

•  $\mathbb{T}_m(\mathbb{R})$  is the set of all  $m \times m$  lower triangular matrices over  $\mathbb{R}$  with only one eigenvalue, for each  $m = 1, 2, \ldots, n$ 

•  $\mathbb{B}_m(\mathbb{R})$  is the set of matrices of  $M_{2m}(\mathbb{R})$  of the form



for each  $1 \le m \le \frac{n}{2}$ , where  $C, C_{i,j} \in \mathbb{S}, \ 2 \le i \le m, 1 \le j \le m-1$  and  $\mathbb{S}$  is the semigroup of matrices over  $\mathbb{R}$  of the form  $\begin{bmatrix} \alpha & -\beta \\ \beta & \alpha \end{bmatrix}$ . •  $\mathcal{K}_{\eta}(\mathbb{R}) := \mathbb{T}_{n_1}(\mathbb{R}) \oplus \cdots \oplus \mathbb{T}_{n_r}(\mathbb{R}) \oplus \mathbb{B}_{m_1}(\mathbb{R}) \oplus \cdots \oplus \mathbb{B}_{m_s}(\mathbb{R})$ . In particular:

- In particular:
- $-\mathcal{K}_{\eta}(\mathbb{R}) = \mathbb{T}_{n}(\mathbb{R}) \text{ and } \eta = (n) \text{ if } r = 1, s = 0.$
- $-\mathcal{K}_{\eta}(\mathbb{R}) = \mathbb{B}_m(\mathbb{R})$  and  $\eta = (m), n = 2m$  if r = 0, s = 1.
- $\begin{aligned} & -\mathcal{K}_{\eta}(\mathbb{R}) = \mathbb{B}_{m_{1}}(\mathbb{R}) \oplus \cdots \oplus \mathbb{B}_{m_{s}}(\mathbb{R}) \text{ and } \eta = (m_{1}, \dots, m_{s}) \text{ if } r = 0, \ s > 1. \\ & \bullet \ u_{\eta} = [e_{\eta,1}, \dots, e_{\eta,r}; f_{\eta,1}, \dots, f_{\eta,s}]^{T} \in \mathbb{R}^{n}, \text{ where for every } k = 1, \dots, r; \ l = 1, \dots, s, \ e_{\eta,k} = [1, 0, \dots, 0]^{T} \in \mathbb{R}^{n_{k}}, \ f_{\eta,l} = [1, 0, \dots, 0]^{T} \in \mathbb{R}^{2m_{l}}. \end{aligned}$

**Proposition 3.3.** ([2, Proposition 2.2], for  $\mathbb{K} = \mathbb{R}$ ; [1, Proposition 2.4], for  $\mathbb{K} = \mathbb{C}$ ) Let G be an abelian sub-semigroup of  $\mathcal{M}_n(\mathbb{K})$ . Then there exists a  $P \in \mathrm{GL}(n,\mathbb{K})$  such that  $P^{-1}GP$  is an abelian sub-semigroup of  $\mathcal{K}_{\eta}(\mathbb{K})$ , for some partition  $\eta$  of n.

**Theorem 3.4.** ([1, Theorem 1.1]; [2, Theorem 1.4]) Let G be an abelian subsemigroup of  $\mathcal{K}_n(\mathbb{K})$  for some partition  $\eta$  of n. The following are equivalent:

- (i) G is hypercyclic,
- (ii) The orbit  $G(u_n)$  is dense in  $\mathbb{K}^n$ .

**Proposition 3.5.** ([6, Lemma 2.10]) Let G be a finitely generated abelian sub-semigroup of  $\mathcal{M}_n(\mathbb{K})$ ,  $n \in \mathbb{N}_0$ . If G is subspace-hypercyclic for a nonzero subspace M of  $\mathbb{K}^n$ , then there exists  $y \in M$  such that  $G(y) \cap M$  is dense in M.

Proof of Theorem 3.1. Let  $x \in \mathbb{K}^n$  such that  $\overline{G(x)} = \mathbb{K}^n$ . One can assume that  $G \subset \mathcal{K}_{\eta}(\mathbb{K})$ , for some partition  $\eta$  of n. Indeed, following Proposition 3.3, there exists a  $P \in \mathrm{GL}(n, \mathbb{K})$  such that  $G' := P^{-1}GP \subset \mathcal{K}_{\eta}(\mathbb{K})$  for some partition  $\eta$  of n. It follows that  $\overline{G'(x')} = \mathbb{K}^n$ , where  $x' = P^{-1}(x) \in \mathbb{K}^n$ .

Case  $\mathbb{K} = \mathbb{C}$ . We let  $\eta = (n_1, \ldots, n_r)$ . We see that  $e_{n_1}$  is an eigenvector of every element of G. Set  $M := \mathbb{C}e_{n_1}$ . Then M is nontrivial and G-invariant. Let  $G_1 = \{A_1 : A = \operatorname{diag}(A_1, \ldots, A_r) \in G\} \subset \mathbb{T}_{n_1}(\mathbb{C})$  and let

 $\sigma(G_1) = \bigcup_{A \in G} \sigma(A_1)$ : the spectrum of  $G_1$  i.e. the set of eigenvalues of all elements  $A_1$  of  $G_1$ . As G is hypercyclic, then by Theorem 3.4,  $G(u_\eta)$  is dense in  $\mathbb{C}^n$  and so  $\sigma(G_1)$  is dense in  $\mathbb{C}$ . Therefore

$$\overline{G(e_{n_1}) \cap M} = \overline{G(e_{n_1})} = \overline{\{\lambda_1 e_{n_1} : \lambda_1 \in \sigma(G_1)\}} = \mathbb{C}e_{n_1} = M$$

In result, G is subspace-hypercyclic for M.

Case  $\mathbb{K} = \mathbb{R}$ . We let  $\eta = (n_1, \ldots, n_r; m_1, \ldots, m_s)$ . – If  $r \neq 0$ , then  $e_{n_1}$  is an eigenvector of every element of G. Set  $M := \mathbb{R}e_{n_1}$ . Then M is nontrivial and G-invariant. Let  $G_1^{(r)} = \{A_1 : A = \operatorname{diag}(A_1, \ldots, A_r; B_1, \ldots, B_s) \in G\} \subset \mathbb{T}_{n_1}(\mathbb{R})$  and let  $\sigma(G_1^{(r)}) = \bigcup_{A \in G} \sigma(A_1)$ : the spectrum of  $G_1^{(r)}$  i.e. the set of eigenvalues of all elements  $A_1$  of  $G_1^{(r)}$ . As G is hypercyclic, then by Theorem 3.4,  $G(u_\eta)$  is dense in  $\mathbb{R}^n$  and so  $\sigma(G_1^{(r)})$  is dense in  $\mathbb{R}$ . Therefore

$$\overline{G(e_{n_1}) \cap M} = \overline{G(e_{n_1})}$$
$$= \overline{\{\lambda e_{n_1} : \lambda \in \sigma(G_1^{(r)})\}}$$
$$= \mathbb{R}e_{n_1} = M.$$

In result, G is subspace-hypercyclic for M.

- If r = 0, then  $\eta = (m_1, \ldots, m_s)$ . Consider the plane

$$M = \{0\}^{2m_1 - 2} \times \mathbb{R}^2 \times \{0\}^{n - 2m_1} = \mathbb{R}e_{2m_1 - 1} + \mathbb{R}e_{2m_1}$$

Then M is G-invariant and distinct from  $\mathbb{R}^n$  whenever  $n \neq 2$ . We let  $G_1^{(s)} = \{B_1 : A = \operatorname{diag}(B_1, \ldots, B_s) \in G\}$  and  $S_1 = \{C_1 : B_1 \in G_1^{(s)}\}$ , where  $C_1 = \begin{bmatrix} \alpha_1 & -\beta_1 \\ \beta_1 & \alpha_1 \end{bmatrix}$  be the diagonal element of  $B_1$ . As G is hypercyclic, then  $\underline{G}(u_\eta)$  is dense in  $\mathbb{R}^n$ , where  $u_\eta = [f_{\eta,1}, \ldots, f_{\eta,s}]^T \in \mathbb{R}^n$ . This implies that  $\overline{\{[B_1f_{\eta,1}]^T : A \in G\}}$  is dense in  $\mathbb{R}^{2m_1}$  and so  $S_1([1,0]^T)$  is dense in  $\mathbb{R}^2$ . On

the other hand, we have that

$$\overline{G(e_{2m_1-1}) \cap M} = \overline{G(e_{2m_1-1})}$$
$$= \overline{\{0\}^{2m_1-2} \times S_1([1,0]^T) \times \{0\}^{n-2m_1}}$$
$$= \{0\}^{2m_1-2} \times \mathbb{R}^2 \times \{0\}^{n-2m_1} = M.$$

In result G is subspace-hypercyclic for M. This completes the proof.  $\Box$ 

# 4. The case: $X = \mathbb{R}^2$

Herewith an example of a parameter family of hypercyclic abelian semigroups on  $\mathbb{R}^2$  which are not subspace-hypercyclic for every straight line in  $\mathbb{R}^2$ .

**Example 4.1.** Let  $p, q \ge 2$  be two coprime numbers and  $\theta \in \mathbb{R}$  irrational. Let  $G_{\theta}$  be the abelian semigroup on  $\mathbb{R}^2$  generated by

$$B_1 = \begin{bmatrix} p & 0 \\ 0 & p \end{bmatrix}, B_2 = \begin{bmatrix} \frac{1}{q} & 0 \\ 0 & \frac{1}{q} \end{bmatrix} \text{ and } B_3 = \begin{bmatrix} \cos(\pi\theta) & -\sin(\pi\theta) \\ \sin(\pi\theta) & \cos(\pi\theta) \end{bmatrix}$$

Then  $G_{\theta}$  is hypercyclic but not subspace-hypercyclic for every straight line in  $\mathbb{R}^2$ .

Proof. By ([4, Corollary 4.2]), the set  $\{\frac{p^k}{q^m} : k, m \in \mathbb{N}\}$  is dense in  $\mathbb{R}_+$ . Since  $\theta$  is irrational, the set  $\{\frac{p^k}{q^m}e^{i\pi s\theta} : k, m, s \in \mathbb{N}\}$  is dense in  $\mathbb{C}$ . Therefore,  $G_{\theta}(e_1)$  is dense in  $\mathbb{R}^2$ . Let us prove that  $G_{\theta}$  is not subspace-hypercyclic for every straight line in  $\mathbb{R}^2$ . Let  $v = [x, y]^T \in \mathbb{R}^2 \setminus \{[0, 0]^T\}$ . We have

$$G_{\theta}(v) = \left\{ \left[ \frac{p^k}{q^m} \left( \cos(\pi s\theta)(x, y) + \sin(\pi s\theta)(-y, x) \right) \right]^T : k, m, s \in \mathbb{N} \right\}.$$

Since  $([x, y]^T, [-y, x]^T)$  is a basis of  $\mathbb{R}^2$ , so

$$G_{\theta}(v) \cap \mathbb{R}v = \left\{ \frac{p^k}{q^m} \cos(\pi s\theta)v : s\theta \in \mathbb{Z} : k, m, s \in \mathbb{N} \right\}$$
$$= \left\{ \frac{p^k}{q^m}v : k, m \in \mathbb{N} \right\} \subset \mathbb{R}_+ v$$

This proves that  $G_{\theta}$  is not subspace-hypercyclic for the straight line  $\mathbb{R}v$ since otherwise, by Proposition 3.5, there is  $z = \alpha v$ ,  $\alpha \in \mathbb{R}$  such that  $\overline{G_{\theta}(z) \cap \mathbb{R}v} = \mathbb{R}v$ . Thus  $\mathbb{R}v \subset \alpha \mathbb{R}_+ v$ , a contradiction.  $\Box$ 

### 5. An example in the non-abelian case

**Proposition 5.1.** There exists a Non-abelian semigroup of  $\mathcal{M}_n(\mathbb{K})$  which is hypercyclic and subspace-hypercyclic for a straight line.

*Proof.* In [7], Javaheri proves that there are two non-commuting matrices A and B on  $\mathbb{K}^n$  that generate a hypercyclic semigroup, where  $A = (a_{i,j})_{1 \le i,j \le n}$  is lower triangular and  $B = \operatorname{diag}(b_1, \ldots, b_n)$  is diagonal. The matrices A and B satisfy the condition:  $\left\{ \left(\frac{b_n}{b_1}\right)^k \left(\frac{a_{n,n}}{a_{1,1}}\right)^l : k, l \in \mathbb{N} \right\}$  is dense in  $\mathbb{K}$ . Let G be the semigroup generated by  $A, B, A' = \frac{1}{a_{1,1}}I_n$  and  $B' = \frac{1}{b_1}I_n$ . Clearly G is a hypercyclic non-abelian semigroup of  $\mathcal{M}_n(\mathbb{K})$ . Moreover  $e_n$  is a eigenvector of every element of G. We have

$$\left\{ (BB')^k (AA')^l e_n : k, l \in \mathbb{N} \right\} = \left\{ (\frac{b_n}{b_1})^k (\frac{a_{n,n}}{a_{1,1}})^l e_n : k, l \in \mathbb{N} \right\} \subset G(e_n)$$

It follows that  $G(e_n) \cap \mathbb{K}e_n = G(e_n)$  is dense in  $\mathbb{K}e_n$ . We conclude that G is subspace-hypercyclic for the straight line  $\mathbb{K}e_n$ .
