# HYPERCYCLICITY AND SUBSPACE HYPERCYCLICITY IN FINITE DIMENSION

#### Abstract

This paper is motivated by the article of Bamerni, Kadets and Kiliçman [J. Math. Anal. Appl. 435 (2), 1812-1815 (2016)]. We consider the remaining problem which claims that if $A$ is a dense subset of a finite dimensional space $X$, then there is a nontrivial subspace $M$ of $X$ such that $A \cap M$ is dense in $M$. We show that the above problem has a negative answer when $X=\mathbb{K}^{n}(\mathbb{K}=\mathbb{R}$ or $\mathbb{C})$ for every $n \geq 2$. However we answer positively the problem when the dense subset $A$ is an orbit of an abelian semigroup of matrices on $\mathbb{K}^{n}, \mathbb{K}^{n} \neq \mathbb{R}^{2}$.


## 1. Introduction

In [3, Theorem 2.1], Bamerni, Kadets and Kiliçman established that if $A$ is a dense subset of a Banach space $X$, then there is a nontrivial closed subspace $M$ of $X$ such that $A \cap M$ is dense in $M$. By a nontrivial subspace $M$ of $X$, we mean that $M$ is non-zero and distinct from $X$. We point out that Lemma 2.3 of [3] is not correct whenever $X$ is of finite dimension (see Remark (2.8). We acknowledge here that the authors of [3] do not clearly meant $X$ of infinite dimension. So Theorem 2.1 in finite dimension remains an open problem.

Problem 1. Is Theorem 2.1 of 3 true for $X$ of finite dimension?
The above problem is also addressed for the action of abelian semigroups of matrices on $X=\mathbb{K}^{n}, \mathbb{K}=\mathbb{R}$ or $\mathbb{C}$.

Problem 2. Is Corollary 2.4 of 3 true for the action of abelian semigroups on $\mathbb{K}^{n}$ ?

In the present paper, we show that Problem 1 does not hold in finite dimension, that is [3, Theorem 2.1] is not true for every finite dimensional space $X=\mathbb{K}^{n}, n \geq 2$. On the other hand, with regard to the action of abelian semigroups on $\mathbb{K}^{n}$, we answer positively Problem 2 (see Section 3); we show that if $G$ is an hypercyclic abelian semigroup of matrices on $\mathbb{K}^{n}$ and $\mathbb{K}^{n} \neq \mathbb{R}^{2}$, then it is subspace-hypercyclic. If $\mathbb{K}^{n}=\mathbb{R}^{2}$, we construct a counterexample consisting of a parameter family of abelian semigroups

[^0]of matrices on $\mathbb{R}^{2}$ which are hypercyclic, but not subspace-hypercyclic for every straight line in $\mathbb{R}^{2}$ (see Example 4.1).

In the sequel, $\mathbb{N}$ and $\mathbb{Z}$ denote the sets of non-negative integers and integers, respectively, $\mathbb{N}=\{0,1,2, \ldots\}$ while $\mathbb{N}_{0}=\mathbb{N} \backslash\{0\}$ denotes the set of positive integers. For a row vector $v \in \mathbb{K}^{n}$, we will be denoting by $v^{T}$ the transpose of $v$. If $v_{1}, \ldots, v_{p} \in \mathbb{K}^{n}, p \geq 1$, we denote by $\operatorname{Vect}\left\{v_{1}, \ldots, v_{p}\right\}$ the vector subspace of $\mathbb{K}^{n}$ generated by $v_{1}, \ldots, v_{p}$. A subset $E \subset \mathbb{K}^{n}$ is called dense in $\mathbb{K}^{n}$ if $\bar{E}=\mathbb{K}^{n}$, where $\bar{E}$ denotes the closure of $E$. It is called nowhere dense if $\bar{E}$ has empty interior.

## 2. Subspace hypercyclicity in finite dimension

The aim of this section is to prove the following theorem.
Theorem 2.1 (The case $\left.X=\mathbb{R}^{n}\right)$. Let $n \in \mathbb{N}, n \geq 2$ and $\alpha=\left(\alpha_{1}, \ldots, \alpha_{n}\right)$, where $\alpha_{1}, \ldots, \alpha_{n}$ are negative real numbers such that $1, \alpha_{1}, \ldots, \alpha_{n}$ are linearly independent over $\mathbb{Q}$. Set $A_{\alpha}=\mathbb{N}^{n}+\mathbb{N}\left[\alpha_{1}, \ldots, \alpha_{n}\right]^{T}$. Then $A_{\alpha}$ is dense in $\mathbb{R}^{n}$ and for every nontrivial subspace $M$ of $\mathbb{R}^{n}, A_{\alpha} \cap M$ is not dense in M.

For this, let recall the following multidimensional real version of Kronecker's theorem (see e.g. [8, Lemma 2.2]; see also [5, Theorem 442]).

Lemma 2.2. (Kronecker's Theorem [8, Lemma 2.2]) Let $\alpha_{1}, \ldots, \alpha_{n}$ be negative real numbers such that $1, \alpha_{1}, \ldots, \alpha_{n}$ are linearly independent over $\mathbb{Q}$. Then the set
$\mathbb{N}^{n}+\mathbb{N}\left[\alpha_{1}, \ldots, \alpha_{n}\right]^{T}:=\left\{\left[s_{1}, \ldots, s_{n}\right]^{T}+s\left[\alpha_{1}, \ldots, \alpha_{n}\right]^{T}: s, s_{1}, \ldots, s_{n} \in \mathbb{N}\right\}$
is dense in $\mathbb{R}^{n}$.
Lemma 2.3. (8, Lemma 2.1]) Let $H=\mathbb{Z} u_{1}+\cdots+\mathbb{Z} u_{m}$ with $u_{k} \in \mathbb{R}^{n}$, $k=1, \ldots, m$. If $m \leq n$, then $H$ is nowhere dense in $\mathbb{R}^{n}$.

Proof of Theorem 2.1. First $A_{\alpha}$ is dense in $\mathbb{R}^{n}$ by Lemma 2.2. Now suppose that there is a nontrivial subspace $M$ of $\mathbb{R}^{n}$ of dimension $r(1 \leq r \leq$ $n-1)$ such that $A_{\alpha} \cap M$ is dense in $M$. One can choose a basis $\left\{v_{1}, v_{2}, \ldots, v_{r}\right\}$ of $M$ so that

$$
\begin{cases}v_{1} & =\left[x_{1,1}, x_{2,1}, \ldots, x_{n, 1}\right]^{T} \\ v_{2} & =\left[0, x_{2,2}, \ldots, x_{n, 2}\right]^{T} \\ \vdots \\ v_{r} & =\left[0, \ldots, 0, x_{r, r}, \ldots, x_{n, r}\right]^{T}\end{cases}
$$

with $x_{i, j} \in \mathbb{R}$.

- First, we have $x_{1,1} \neq 0$. Indeed, for every $u \in A_{\alpha} \cap M$, there exist $m, m_{1}, \ldots, m_{n} \in \mathbb{N}$ and $\lambda_{1}, \ldots, \lambda_{r} \in \mathbb{R}$ such that

$$
\text { (1) } u=\left[m_{1}, \ldots, m_{n}\right]^{T}+m\left[\alpha_{1}, \ldots, \alpha_{n}\right]^{T}=\lambda_{1} v_{1}+\cdots+\lambda_{r} v_{r}
$$

The first coordinate in (1) gives that $m_{1}+m \alpha_{1}=\lambda_{1} x_{1,1}$. If $x_{1,1}=0$, then $m=0$ and thus $A_{\alpha} \cap M \subset \mathbb{N}^{n} \cap M$ which is clearly not dense in $M$, a contradiction.

We let $I=\left\{i \in\{1, \ldots, r\}: x_{i, i}=0\right\}$. Set

$$
k= \begin{cases}\min (I) & \text { if } I \neq \emptyset \\ r+1 & \text { if } I=\emptyset\end{cases}
$$

Obviously $2 \leq k \leq r+1$.
Denote by

$$
\begin{cases}v_{1}^{(k)} & =\left[x_{1,1}, x_{2,1}, \ldots, x_{k, 1}\right]^{T} \\ v_{2}^{(k)} & =\left[0, x_{2,2}, \ldots, x_{k, 2}\right]^{T} \\ \vdots \\ v_{k-1}^{(k)} & =\left[0, \ldots, 0, x_{k-1, k-1}, x_{k, k-1}\right]^{T}\end{cases}
$$

Then $v_{1}^{(k)}, v_{2}^{(k)}, \ldots, v_{k-1}^{(k)}$ are linearly independent in $\mathbb{R}^{k}$.
Set

- $A_{\alpha}^{(k)}=\mathbb{N}^{k}+\mathbb{N}\left[\alpha_{1}, \ldots, \alpha_{k}\right]^{T}$
- $M^{(k)}$ be the subspace of $\mathbb{R}^{k}$ generated by $\left\{v_{1}^{(k)}, v_{2}^{(k)}, \ldots, v_{k-1}^{(k)}\right\}$.

Since $A_{\alpha} \cap M$ is dense in $M$, so $A_{\alpha}^{(k)} \cap M^{(k)}$ is dense in $M^{(k)}$. Then one can assume, by some elementary transformations of the $v_{i}^{(k)}, i=1, \ldots, k-1$, that $M^{(k)}$ has a basis $\left\{u_{1}, u_{2}, \ldots, u_{k-1}\right\}$, where

$$
\begin{cases}u_{1} & =\left[1,0, \ldots, 0, y_{1}\right]^{T}, \\ u_{2} & =\left[0,1,0, \ldots, 0, y_{2}\right]^{T}, \\ \vdots & \\ u_{k-1} & =\left[0, \ldots, 0,1, y_{k-1}\right]^{T},\end{cases}
$$

with $y_{i} \in \mathbb{R}, i=1, \ldots, k-1$.
Denote by

- $\Omega=\left\{u=\left[m_{1}, \ldots, m_{k}\right]^{T}+m\left[\alpha_{1}, \ldots, \alpha_{k}\right]^{T} \in A_{\alpha}^{(k)} \cap M^{(k)}: m \neq 0\right\}$.

Then $\Omega$ is dense in $M^{(k)}$ :
Indeed, we have $\left(A_{\alpha}^{(k)} \cap \dot{M^{(k)}}\right) \backslash \Omega \subset \mathbb{N}^{k} \cap M^{(k)}$ which is nowhere dense in $M^{(k)}$. Since $A_{\alpha}^{(k)} \cap M^{(k)}$ is dense in $M^{(k)}$, so $\Omega$ is dense in $M^{(k)}$.

In the sequel, let $u \in \Omega$ be fixed:

$$
u=\left[m_{1}, \ldots, m_{k}\right]^{T}+m\left[\alpha_{1}, \ldots, \alpha_{k}\right]^{T}=\lambda_{1} u_{1}+\cdots+\lambda_{k-1} u_{k-1},
$$

where $m, m_{1}, \ldots, m_{k} \in \mathbb{N}, m \neq 0$ and $\lambda_{1}, \ldots, \lambda_{k-1} \in \mathbb{R}$. Observe that for
every $v \in \Omega$ :

$$
v=\left[t_{1}, \ldots, t_{k}\right]^{T}+t\left[\alpha_{1}, \ldots, \alpha_{k}\right]^{T}=\delta_{1} u_{1}+\cdots+\delta_{k-1} u_{k-1}
$$

where $\delta_{1}, \ldots, \delta_{k-1} \in \mathbb{R}, t_{1}, \ldots, t_{k}, t \in \mathbb{N}$ with $t \neq 0$, we obtain for $i=$ $1, \ldots, k-1$ :

$$
\begin{cases}t_{i}+t \alpha_{i} & =\delta_{i} \\ m_{i}+m \alpha_{i} & =\lambda_{i} \\ m v-t u & =\left(m t_{1}-t m_{1}\right) u_{1}+\cdots+\left(m t_{k-1}-t m_{k-1}\right) u_{k-1}\end{cases}
$$

We have

$$
(*) m_{k}+m \alpha_{k}=\left(m_{1}+m \alpha_{1}\right) y_{1}+\cdots+\left(m_{k-1}+m \alpha_{k-1}\right) y_{k-1}
$$

Moreover, the last row of $m v-t u$ gives that

$$
(* *) m t_{k}-t m_{k}=\left(m t_{1}-t m_{1}\right) y_{1}+\cdots+\left(m t_{k-1}-t m_{k-1}\right) y_{k-1}
$$

From $\left({ }^{* *}\right)$, we distinguish two cases:
Case 1: $1, y_{1}, \ldots, y_{k-1}$ are linearly independent over $\mathbb{Q}$. In this case, for every $v \in \Omega$, we have from $(* *), m t_{i}-t m_{i}=0$ for $i=1, \ldots, k$. Therefore $m v=t u$. It follows that $m \Omega \subset \mathbb{N} u$ and thus by density $M^{(k)}=\mathbb{N} u=\mathbb{R} u$. A contradiction.

Case 2: 1, $y_{1}, \ldots, y_{k-1}$ are not linearly independent over $\mathbb{Q}$.
First, observe that $y_{1}, \ldots, y_{k-1}$ are not all in $\mathbb{Q}$; otherwise, $y_{1}, \ldots, y_{k-1} \in \mathbb{Q}$ and then by $(*), m=0$. Therefore $A_{\alpha}^{(k)} \cap M^{(k)} \subset \mathbb{N}^{k} \cap M^{(k)}$ and thus $A_{\alpha}^{(k)} \cap M^{(k)}$ is not dense in $M^{(k)}$. A contradiction.
Second, let $j$ be the maximal number of the rationally independent numbers with 1 among $y_{1}, \ldots, y_{k-1}$. This means that there exist
$1 \leq i_{1}<i_{2}<\cdots<i_{j} \leq k-2$ such that:
$-\left\{1, y_{i_{1}}, \ldots, y_{i_{j}}\right\}$ is linearly independent over $\mathbb{Q}$,

- for every $p \in\{1, \ldots, k-1\} \backslash\left\{i_{1}, i_{2}, \ldots, i_{j}\right\}$,
$y_{p}=a_{0, p}+a_{1, p} y_{i_{1}}+\cdots+a_{j, p} y_{i_{j}}$, for some $a_{0, p}, a_{1, p}, \ldots, a_{j, p} \in \mathbb{Q}$.
Notice that $1 \leq j \leq k-2$.

We can assume, by permuting indices if necessary, that $i_{l}=l, l=1, \ldots, j$.
Then we have, for every $p=j+1, \ldots, k-1$,

$$
(* * *) y_{p}=a_{0, p}+a_{1, p} y_{1}+\cdots+a_{j, p} y_{j}, \text { for some } a_{0, p}, a_{1, p}, \ldots, a_{j, p} \in \mathbb{Q} .
$$

Now let $v \in \Omega: v=\left[t_{1}, \ldots, t_{k}\right]^{T}+t\left[\alpha_{1}, \ldots, \alpha_{k}\right]^{T}$, with $t \neq 0$.
From $(* *)$ and $(* * *)$, we have that

$$
\begin{aligned}
m t_{k}-t m_{k} & =\left(m t_{1}-t m_{1}\right) y_{1}+\cdots+\left(m t_{k-1}-t m_{k-1}\right) y_{k-1} \\
& =\left(m t_{1}-t m_{1}\right) y_{1}+\cdots+\left(m t_{j}-t m_{j}\right) y_{j} \\
& +\sum_{i=j+1}^{k-1}\left(m t_{i}-t m_{i}\right)\left(a_{0, i}+a_{1, i} y_{1}+\cdots+a_{j, i} y_{j}\right) \\
& =\sum_{i=j+1}^{k-1}\left(m t_{i}-t m_{i}\right) a_{0, i}+\left(\left(m t_{1}-t m_{1}\right)+\sum_{i=j+1}^{k-1}\left(m t_{i}-t m_{i}\right) a_{1, i}\right) y_{1} \\
& +\cdots+\left(\left(m t_{j}-t m_{j}\right)+\sum_{i=j+1}^{k-1}\left(m t_{i}-t m_{i}\right) a_{j, i}\right) y_{j}
\end{aligned}
$$

Since $\left\{1, y_{1}, \ldots, y_{j}\right\}$ is linearly independent over $\mathbb{Q}$, we obtain that

$$
\left\{\begin{aligned}
m t_{k}-t m_{k} & =\sum_{i=j+1}^{k-1}\left(m t_{i}-t m_{i}\right) a_{0, i} \\
m t_{s}-t m_{s}+\sum_{i=j+1}^{k-1}\left(m t_{i}-t m_{i}\right) a_{s, i} & =0, \text { for all } s=1, \ldots, j
\end{aligned}\right.
$$

Therefore

$$
m v-t u=\left(\begin{array}{c}
m t_{1}-t m_{1} \\
m t_{2}-t m_{2} \\
\vdots \\
m t_{k-1}-t m_{k-1} \\
m t_{k}-t m_{k}
\end{array}\right)=\left(\begin{array}{c}
-\sum_{i=j+1}^{k-1}\left(m t_{i}-t m_{i}\right) a_{1, i} \\
\vdots \\
-\sum_{i=j+1}^{k-1}\left(m t_{i}-t m_{i}\right) a_{j, i} \\
m t_{j+1}-t m_{j+1} \\
\vdots \\
m t_{k-1}-t m_{k-1} \\
\sum_{i=j+1}^{k-1}\left(m t_{i}-t m_{i}\right) a_{0, i}
\end{array}\right) .
$$

It follows that there exist $w_{1}, w_{2}, \ldots, w_{k-j} \in \mathbb{R}^{k}$ such that

$$
m v-t u=t w_{1}+t_{j+1} w_{2}+\cdots+t_{k-1} w_{k-j}
$$

Hence

$$
m v=t\left(w_{1}+u\right)+t_{j+1} w_{2}+\cdots+t_{k-1} w_{k-j}
$$

We obtain that

$$
m \Omega \subset \mathbb{N}\left(w_{1}+u\right)+\mathbb{N} w_{2}+\cdots+\mathbb{N} w_{k-j} \subset \operatorname{Vect}\left\{\left(w_{1}+u\right), w_{2}, \ldots, w_{k-j}\right\}
$$

Since $\Omega$ is dense in $M^{(k)}$, so $\operatorname{dim} M^{(k)}=k-1 \leq k-j$ and thus $j=1$. It follows that $M^{(k)}=\operatorname{Vect}\left\{w_{1}+u_{0}, w_{2}, \ldots, w_{k-1}\right\}$ and thus
$\mathbb{N}\left(w_{1}+u_{0}\right)+\mathbb{N} w_{2}+\cdots+\mathbb{N} w_{k-1}$ is dense in $\mathrm{M}^{(k)}$. A contradiction with Lemma 2.3. The proof of Theorem 2.1 is complete.

Theorem 2.4 (The case $\left.X=\mathbb{C}^{n}\right)$. Let $n \in \mathbb{N}, n \geq 2$, $\alpha=\left(\alpha_{1}, \ldots, \alpha_{n}\right)$, $\beta=\left(\beta_{1}, \ldots, \beta_{n}\right)$, where $\alpha_{1}, \ldots, \alpha_{n} ; \beta_{1}, \ldots, \beta_{n}$ are negative real numbers such that $1, \alpha_{1}, \ldots, \alpha_{n}, \beta_{1}, \ldots, \beta_{n}$ are linearly independent over $\mathbb{Q}$. Set $A_{\alpha, \beta}=\mathbb{N}^{n}+i \mathbb{N}^{n}+\mathbb{N}\left[\alpha_{1}+i \beta_{1}, \ldots, \alpha_{n}+i \beta_{n}\right]^{T}$. Then $A_{\alpha, \beta}$ is dense in $\mathbb{C}^{n}$ and for every nontrivial subspace $M$ of $\mathbb{C}^{n}, A_{\alpha, \beta} \cap M$ is not dense in $M$.

We use the following complex version of Kronecker's theorem.
Lemma 2.5 (Kronecker's theorem: complex version). Let $\alpha_{1}, \ldots, \alpha_{n} ; \beta_{1}$, $\ldots, \beta_{n}$ be negative real numbers such that $1, \alpha_{1}, \ldots, \alpha_{n}, \beta_{1}, \ldots, \beta_{n}$ are linearly independent over $\mathbb{Q}$. Then $\mathbb{N}^{n}+i \mathbb{N}^{n}+\mathbb{N}\left[\alpha_{1}+i \beta_{1}, \ldots, \alpha_{n}+i \beta_{n}\right]^{T}$ is dense in $\mathbb{C}^{n}$.

Proof. This results from Lemma 2.2 by identifying $\mathbb{C}^{n}$ with $\mathbb{R}^{2 n}$ in the natural way.

Proof of Theorem 2.4. First $A_{\alpha, \beta}$ is dense in $\mathbb{C}^{n}$ by Lemma 2.5. Assume there is a nontrivial subspace $M$ of $\mathbb{C}^{n}$ such that $A_{\alpha, \beta} \cap M$ is dense in $M$. Let $M_{1}, M_{2}$ be two subspaces of $\mathbb{R}^{n}$ such that $M=M_{1}+i M_{2}$. By the isomorphism $\phi:\left(x_{1}+i y_{1}, \ldots, x_{n}+i y_{n}\right) \in \mathbb{C}^{n} \mapsto\left(x_{1}, y_{1} ; \ldots ; x_{n}, y_{n}\right) \in \mathbb{R}^{2 n}$, we have that $\phi\left(A_{\alpha, \beta}\right)=\mathbb{N}^{2 n}+\mathbb{N}\left[\alpha_{1}, \beta_{1} ; \ldots ; \alpha_{n}, \beta_{n}\right]^{T}$ and $\phi\left(A_{\alpha, \beta} \cap M\right)=\phi\left(A_{\alpha, \beta}\right) \cap \phi(M)=A_{\mu} \cap\left(M_{1} \times M_{2}\right)$, where $\mu=\left[\alpha_{1}, \beta_{1} ; \ldots ; \alpha_{n}, \beta_{n}\right]^{T}$. Then $A_{\mu} \cap\left(M_{1} \times M_{2}\right)$ is dense in $M_{1} \times M_{2},\left(M_{1} \times M_{2}\right.$ is a nontrivial subspace of $\left.\mathbb{R}^{2 n}\right)$. This leads to a contradiction with Theorem 2.1.

We give in the two propositions below other dense subsets $A$ of $\mathbb{K}^{2}$ such that for every straight line $\Delta$ in $\mathbb{K}^{2}, A \cap \Delta$ is not dense in $\Delta$.
Proposition 2.6 (Counterexample in $\mathbb{C}^{2}$ ). Let $\theta_{1}, \theta_{2} \in \mathbb{R}$ such that $1, \theta_{1}, \theta_{2}$ are rationally independent and set $A_{2}=\left\{\left[r_{1} e^{2 i \pi n_{1} \theta_{1}}, r_{2} e^{2 i \pi n_{2} \theta_{2}}\right]^{T}: r_{1}, r_{2} \in\right.$ $\left.\mathbb{R}_{+}^{*}, n_{1}, n_{2} \in \mathbb{N}\right\}$. Then $A_{2}$ is dense in $\mathbb{C}^{2}$, but $A_{2} \cap \Delta$ is not dense in $\Delta$, for every straight line $\Delta$ in $\mathbb{C}^{2}$.
Proof. As $1, \theta_{1}, \theta_{2}$ are rationally independent, then $A$ is dense in $\mathbb{C}^{2}$. We let $\Delta=\mathbb{C} u$, where $u=\left[a_{1}, a_{2}\right]^{T} \in \mathbb{C}^{2} \backslash\{(0,0)\}$. Suppose that $A_{2} \cap \Delta$ is dense in $\Delta$. One can assume that $a_{1} a_{2} \neq 0$ (since $A_{2} \cap \Delta=\emptyset$ whenever $a_{1} a_{2}=0$ ). We let $\frac{a_{2}}{a_{1}}=\frac{\left|a_{2}\right|}{\left|a_{1}\right|} e^{2 i \pi \theta}$, where $\theta \in \mathbb{R}$. An element $z \in A_{2} \cap \Delta$ can be written as $z=\left[r_{1} e^{2 i \pi n_{1} \theta_{1}}, r_{2} e^{2 i \pi n_{2} \theta_{2}}\right]^{T}=\lambda\left[a_{1}, a_{2}\right]^{T}$, where $\lambda \in \mathbb{C}$. We have $\frac{a_{2}}{a_{1}}=\frac{\left|a_{2}\right|}{\left|a_{1}\right|} e^{2 i \pi\left(n_{2} \theta_{2}-n_{1} \theta_{1}\right)}=\frac{\left|a_{2}\right|}{\left|a_{1}\right|} e^{2 i \pi \theta}$. Hence $\theta=n_{2} \theta_{2}-n_{1} \theta_{1}+k$ for some $k \in \mathbb{Z}$. The triplet $\left(n_{1}, n_{2}, k\right)$ is unique. Indeed, if $\left(t_{1}, t_{2}, k^{\prime}\right)$ is another triplet such that $\theta=t_{2} \theta_{2}-t_{1} \theta_{1}+k^{\prime}$, then $\left(n_{2}-t_{2}\right) \theta_{2}-\left(n_{1}-t_{1}\right) \theta_{1}+\left(k-k^{\prime}\right)=0$. As $1, \theta_{1}, \theta_{2}$ are rationally independent, then $n_{2}=t_{2}, n_{1}=t_{1}, k=k^{\prime}$. Finally, $A \cap \Delta=\mathbb{R}_{+}^{*} v$, where $v=\left[e^{2 i \pi n_{1} \theta_{1}}, \frac{\left|a_{2}\right|}{\left|a_{1}\right|} e^{2 i \pi n_{2} \theta_{2}}\right]^{T}$ and $n_{1}$ and $n_{2}$ are fixed. Clearly $A \cap \Delta$ is not dense in $\Delta$.

Proposition 2.7 (Counterexample in $\mathbb{R}^{2}$ ). Let
$B=\left\{r e^{2 i \pi \theta}: r \in \mathbb{R}_{+}^{*}, \theta \in\left[0, \frac{1}{2}\left[\cup\left(\left[\frac{1}{2}, 1[\cap(\mathbb{R} \backslash \mathbb{Q}))\right\}\right.\right.\right.\right.$. Then $B$ is dense in $\mathbb{R}^{2}$, but for every straight line through the origin $\Delta$, the intersection $B \cap \Delta$, is not dense in $\Delta$.
Proof. Indeed, $B \cap \Delta$ is only a half line, and thus not dense in $\Delta$.

Remark 2.8. We shall show that Lemma 2.3 of [3] is not true if $X=\mathbb{K}^{n}$, for every $n \geq 1$. Fix an arbitrary $(n-1)$-dimensional subspace $Y$ of $X$, and let $A=X \backslash Y$, which is dense in $X$. Let $e \in X$ with $\mathrm{d}(e, Y)>1$, which exists $\left(d(e, Y)=\inf _{y \in Y}\|e-y\|\right.$, where $\|\|$ denotes the euclidean norm in $\left.\mathbb{K}^{n}\right)$. Then Lemma 2.3 of [3] claims that there is some $a \in A$ such that $d(e, \operatorname{Vect}\{Y, a\})>1$, which is absurd since $e \in \operatorname{Vect}\{Y, a\}$.

## 3. Subspace hypercyclicity for abelian semigroups in finite dimensional space

In this section, we will show that the analogue of [3, Corollary 2.4] is true for the action of abelian semigroups on $X=\mathbb{K}^{n} \neq \mathbb{R}^{2}$. Let us begin by some definitions.

Let $\mathcal{M}_{n}(\mathbb{K})$ be the set of all square matrices over $\mathbb{K}$ of order $n \geq 1$. Let $G$ be an abelian sub-semigroup of $\mathcal{M}_{n}(\mathbb{K})$. By a sub-semigroup of $\mathcal{M}_{n}(\mathbb{K})$, we mean a subset of $\mathcal{M}_{n}(\mathbb{K})$ which is stable under multiplication and contains the identity matrix. For a vector $v \in \mathbb{K}^{n}$, we consider the orbit of $G$ through $v: G(v)=\{A v: A \in G\} \subset \mathbb{K}^{n}$. A subset $E \subset \mathbb{K}^{n}$ is called $G$-invariant if $A(E) \subset E$ for every $A \in G$. The orbit $G(v) \subset \mathbb{K}^{n}$ is called dense in $\mathbb{K}^{n}$ if $\overline{G(v)}=\mathbb{K}^{n}$. We say that $G$ is hypercyclic if there exists a vector $v \in \mathbb{K}^{n}$ such that $G(v)$ is dense in $\mathbb{K}^{n}$. In this case, $v$ is called a hypercyclic vector for $G$. $G$ is called subspace-hypercyclic for a non-zero subspace $M$ of $\mathbb{K}^{n}$, if there exists $x \in \mathbb{K}^{n}$ such that $G(x) \cap M$ is dense in $M$. We state the main result of this section.

Theorem 3.1. Let $G$ be an abelian semigroup of $\mathcal{M}_{n}(\mathbb{K}), n \geq 2$. Assume that $X=\mathbb{K}^{n} \neq \mathbb{R}^{2}$. If $G$ is hypercyclic, then it is subspace-hypercyclic for a nontrivial subspace of $X$.

Remark 3.2. Since [3, Theorem 2.1] does not work according to Theorem 2.1) so the statement and the proof of [6, Corollary 2.8] (which used [3, Theorem 2.1]) should be changed and replaced by Theorem 3.1.

Before the proof, we need to introduce the following notations and definitions. Let $n \in \mathbb{N}_{0}$ be fixed. We denote by

- $\mathcal{B}_{0}=\left(e_{1}, \ldots, e_{n}\right)$ the canonical basis of $\mathbb{K}^{n}$.
- $I_{n}$ the identity matrix on $\mathbb{K}^{n}$.

Case $\mathbb{K}=\mathbb{C}$ :
Let $n \in \mathbb{N}_{0}$ be fixed. Let $r \in \mathbb{N}$. By a partition of $n$, we mean a finite sequence of positive integers $\eta=\left(n_{1}, \ldots, n_{r}\right)$ such that $\sum_{i=1}^{r} n_{i}=n$. Given a partition $\eta=\left(n_{1}, \ldots, n_{r}\right)$, we denote by:

- $\mathbb{T}_{m}(\mathbb{C})$ is the set of all $m \times m$ lower triangular matrices over $\mathbb{C}$ with only one eigenvalue, for each $m=1,2, \ldots, n$
- $\mathcal{K}_{\eta}(\mathbb{C}):=\mathbb{T}_{n_{1}}(\mathbb{C}) \oplus \cdots \oplus \mathbb{T}_{n_{r}}(\mathbb{C})$.

In particular, $\mathcal{K}_{\eta}(\mathbb{C})=\mathbb{T}_{n}(\mathbb{C})$ and $\eta=(n)$ if $r=1$.

- $u_{\eta}=\left[e_{\eta, 1}, \ldots, e_{\eta, r}\right]^{T} \in \mathbb{C}^{n}$, where $e_{\eta, k}=[1,0, \ldots, 0]^{T} \in \mathbb{C}^{n_{k}}, k=1, \ldots, r$.

Case $\mathbb{K}=\mathbb{R}$ :
Let $n \in \mathbb{N}_{0}$ be fixed. Let $r, s \in \mathbb{N}$. By a partition of $n$, we mean a finite sequence of positive integers $\eta=\left(n_{1}, \ldots, n_{r} ; m_{1}, \ldots, m_{s}\right)$ such that $\sum_{i=1}^{r} n_{i}+2 \sum_{j=1}^{s} m_{j}=n$. In particular, we have $r+2 s \leq n$.

- $\mathbb{T}_{m}(\mathbb{R})$ is the set of all $m \times m$ lower triangular matrices over $\mathbb{R}$ with only one eigenvalue, for each $m=1,2, \ldots, n$
- $\mathbb{B}_{m}(\mathbb{R})$ is the set of matrices of $M_{2 m}(\mathbb{R})$ of the form

$$
\left[\begin{array}{cccc}
C & & & 0 \\
C_{2,1} & C & & \\
\vdots & \ddots & \ddots & \\
C_{m, 1} & \ldots & C_{m, m-1} & C
\end{array}\right]
$$

for each $1 \leq m \leq \frac{n}{2}$, where $C, C_{i, j} \in \mathbb{S}, 2 \leq i \leq m, 1 \leq j \leq m-1$ and $\mathbb{S}$ is the semigroup of matrices over $\mathbb{R}$ of the form $\left[\begin{array}{cc}\alpha & -\beta \\ \beta & \alpha\end{array}\right]$.

- $\mathcal{K}_{\eta}(\mathbb{R}):=\mathbb{T}_{n_{1}}(\mathbb{R}) \oplus \cdots \oplus \mathbb{T}_{n_{r}}(\mathbb{R}) \oplus \mathbb{B}_{m_{1}}(\mathbb{R}) \oplus \cdots \oplus \mathbb{B}_{m_{s}}(\mathbb{R})$.

In particular:
$-\mathcal{K}_{\eta}(\mathbb{R})=\mathbb{T}_{n}(\mathbb{R})$ and $\eta=(n)$ if $r=1, s=0$.
$-\mathcal{K}_{\eta}(\mathbb{R})=\mathbb{B}_{m}(\mathbb{R})$ and $\eta=(m), n=2 m$ if $r=0, s=1$.
$-\mathcal{K}_{\eta}(\mathbb{R})=\mathbb{B}_{m_{1}}(\mathbb{R}) \oplus \cdots \oplus \mathbb{B}_{m_{s}}(\mathbb{R})$ and $\eta=\left(m_{1}, \ldots, m_{s}\right)$ if $r=0, s>1$.

- $u_{\eta}=\left[e_{\eta, 1}, \ldots, e_{\eta, r} ; f_{\eta, 1}, \ldots, f_{\eta, s}\right]^{T} \in \mathbb{R}^{n}$, where for every $k=1, \ldots, r ; l=$ $1, \ldots, s, e_{\eta, k}=[1,0, \ldots, 0]^{T} \in \mathbb{R}^{n_{k}}, f_{\eta, l}=[1,0, \ldots, 0]^{T} \in \mathbb{R}^{2 m_{l}}$.

Proposition 3.3. ([2, Proposition 2.2], for $\mathbb{K}=\mathbb{R}$; [1] Proposition 2.4], for $\mathbb{K}=\mathbb{C})$ Let $G$ be an abelian sub-semigroup of $\mathcal{M}_{n}(\mathbb{K})$. Then there exists a $P \in \mathrm{GL}(n, \mathbb{K})$ such that $P^{-1} G P$ is an abelian sub-semigroup of $\mathcal{K}_{\eta}(\mathbb{K})$, for some partition $\eta$ of $n$.
Theorem 3.4. ([1, Theorem 1.1]; [2, Theorem 1.4]) Let $G$ be an abelian subsemigroup of $\mathcal{K}_{\eta}(\mathbb{K})$ for some partition $\eta$ of $n$. The following are equivalent:
(i) $G$ is hypercyclic,
(ii) The orbit $\mathrm{G}\left(u_{\eta}\right)$ is dense in $\mathbb{K}^{n}$.

Proposition 3.5. ([6, Lemma 2.10]) Let $G$ be a finitely generated abelian sub-semigroup of $\mathcal{M}_{n}(\mathbb{K})$, $n \in \mathbb{N}_{0}$. If $G$ is subspace-hypercyclic for a nonzero subspace $M$ of $\mathbb{K}^{n}$, then there exists $y \in M$ such that $G(y) \cap M$ is dense in $M$.

Proof of Theorem 3.1. Let $x \in \mathbb{K}^{n}$ such that $\overline{G(x)}=\mathbb{K}^{n}$. One can assume that $G \subset \mathcal{K}_{\eta}(\mathbb{K})$, for some partition $\eta$ of $n$. Indeed, following Proposition 3.3, there exists a $P \in \operatorname{GL}(n, \mathbb{K})$ such that $G^{\prime}:=P^{-1} G P \subset \mathcal{K}_{\eta}(\mathbb{K})$ for some partition $\eta$ of $n$. It follows that $\overline{G^{\prime}\left(x^{\prime}\right)}=\mathbb{K}^{n}$, where $x^{\prime}=P^{-1}(x) \in \mathbb{K}^{n}$.

Case $\mathbb{K}=\mathbb{C}$. We let $\eta=\left(n_{1}, \ldots, n_{r}\right)$. We see that $e_{n_{1}}$ is an eigenvector of every element of $G$. Set $M:=\mathbb{C} e_{n_{1}}$. Then $M$ is nontrivial and $G$-invariant. Let $G_{1}=\left\{A_{1}: A=\operatorname{diag}\left(A_{1}, \ldots, A_{r}\right) \in G\right\} \subset \mathbb{T}_{n_{1}}(\mathbb{C})$ and let $\sigma\left(G_{1}\right)=\bigcup_{A \in G} \sigma\left(A_{1}\right)$ : the spectrum of $G_{1}$ i.e. the set of eigenvalues of all elements $A_{1}$ of $G_{1}$. As $G$ is hypercyclic, then by Theorem 3.4, $G\left(u_{\eta}\right)$ is dense in $\mathbb{C}^{n}$ and so $\sigma\left(G_{1}\right)$ is dense in $\mathbb{C}$. Therefore

$$
\overline{G\left(e_{n_{1}}\right) \cap M}=\overline{G\left(e_{n_{1}}\right)}=\overline{\left\{\lambda_{1} e_{n_{1}}: \lambda_{1} \in \sigma\left(G_{1}\right)\right\}}=\mathbb{C} e_{n_{1}}=M
$$

In result, $G$ is subspace-hypercyclic for $M$.
Case $\mathbb{K}=\mathbb{R}$. We let $\eta=\left(n_{1}, \ldots, n_{r} ; m_{1}, \ldots, m_{s}\right)$.

- If $r \neq 0$, then $e_{n_{1}}$ is an eigenvector of every element of $G$. Set
$M:=\mathbb{R} e_{n_{1}}$. Then $M$ is nontrivial and $G$-invariant. Let
$G_{1}^{(r)}=\left\{A_{1}: A=\operatorname{diag}\left(A_{1}, \ldots, A_{r} ; B_{1}, \ldots, B_{s}\right) \in G\right\} \subset \mathbb{T}_{n_{1}}(\mathbb{R})$ and let $\sigma\left(G_{1}^{(r)}\right)=\underset{A \in G}{\cup} \sigma\left(A_{1}\right)$ : the spectrum of $G_{1}^{(r)}$ i.e. the set of eigenvalues of all elements $A_{1}$ of $G_{1}^{(r)}$. As $G$ is hypercyclic, then by Theorem 3.4, $G\left(u_{\eta}\right)$ is dense in $\mathbb{R}^{n}$ and so $\sigma\left(G_{1}^{(r)}\right)$ is dense in $\mathbb{R}$. Therefore

$$
\begin{aligned}
\overline{G\left(e_{n_{1}}\right) \cap M} & =\overline{G\left(e_{n_{1}}\right)} \\
& =\overline{\left\{\lambda e_{n_{1}}: \lambda \in \sigma\left(G_{1}^{(r)}\right)\right\}} \\
& =\mathbb{R} e_{n_{1}}=M .
\end{aligned}
$$

In result, $G$ is subspace-hypercyclic for $M$.

- If $r=0$, then $\eta=\left(m_{1}, \ldots, m_{s}\right)$. Consider the plane

$$
M=\{0\}^{2 m_{1}-2} \times \mathbb{R}^{2} \times\{0\}^{n-2 m_{1}}=\mathbb{R} e_{2 m_{1}-1}+\mathbb{R} e_{2 m_{1}}
$$

Then $M$ is $G$-invariant and distinct from $\mathbb{R}^{n}$ whenever $n \neq 2$. We let $G_{1}^{(s)}=\left\{B_{1}: A=\operatorname{diag}\left(B_{1}, \ldots, B_{s}\right) \in G\right\}$ and $S_{1}=\left\{C_{1}: B_{1} \in G_{1}^{(s)}\right\}$, where $C_{1}=\left[\begin{array}{cc}\alpha_{1} & -\beta_{1} \\ \beta_{1} & \alpha_{1}\end{array}\right]$ be the diagonal element of $B_{1}$. As $G$ is hypercyclic, then $G\left(u_{\eta}\right)$ is dense in $\mathbb{R}^{n}$, where $u_{\eta}=\left[f_{\eta, 1}, \ldots, f_{\eta, s}\right]^{T} \in \mathbb{R}^{n}$. This implies that $\overline{\left\{\left[B_{1} f_{\eta, 1}\right]^{T}: A \in G\right\}}$ is dense in $\mathbb{R}^{2 m_{1}}$ and so $S_{1}\left([1,0]^{T}\right)$ is dense in $\mathbb{R}^{2}$. On
the other hand, we have that

$$
\begin{aligned}
\overline{G\left(e_{2 m_{1}-1}\right) \cap M} & =\overline{\overline{G\left(e_{2 m_{1}-1}\right)}} \\
& =\overline{\{0\}^{2 m_{1}-2} \times S_{1}\left([1,0]^{T}\right) \times\{0\}^{n-2 m_{1}}} \\
& =\{0\}^{2 m_{1}-2} \times \mathbb{R}^{2} \times\{0\}^{n-2 m_{1}}=M .
\end{aligned}
$$

In result $G$ is subspace-hypercyclic for $M$. This completes the proof.

## 4. The case: $X=\mathbb{R}^{2}$

Herewith an example of a parameter family of hypercyclic abelian semigroups on $\mathbb{R}^{2}$ which are not subspace-hypercyclic for every straight line in $\mathbb{R}^{2}$.

Example 4.1. Let $p, q \geq 2$ be two coprime numbers and $\theta \in \mathbb{R}$ irrational. Let $G_{\theta}$ be the abelian semigroup on $\mathbb{R}^{2}$ generated by

$$
B_{1}=\left[\begin{array}{ll}
p & 0 \\
0 & p
\end{array}\right], B_{2}=\left[\begin{array}{cc}
\frac{1}{q} & 0 \\
0 & \frac{1}{q}
\end{array}\right] \text { and } B_{3}=\left[\begin{array}{cc}
\cos (\pi \theta) & -\sin (\pi \theta) \\
\sin (\pi \theta) & \cos (\pi \theta)
\end{array}\right]
$$

Then $G_{\theta}$ is hypercyclic but not subspace-hypercyclic for every straight line in $\mathbb{R}^{2}$.

Proof. By ([4, Corollary 4.2]), the set $\left\{\frac{p^{k}}{q^{m}}: k, m \in \mathbb{N}\right\}$ is dense in $\mathbb{R}_{+}$. Since $\theta$ is irrational, the set $\left\{\frac{p^{k}}{q^{m}} e^{i \pi s \theta}: k, m, s \in \mathbb{N}\right\}$ is dense in $\mathbb{C}$. Therefore, $G_{\theta}\left(e_{1}\right)$ is dense in $\mathbb{R}^{2}$. Let us prove that $G_{\theta}$ is not subspace-hypercyclic for every straight line in $\mathbb{R}^{2}$. Let $v=[x, y]^{T} \in \mathbb{R}^{2} \backslash\left\{[0,0]^{T}\right\}$. We have

$$
G_{\theta}(v)=\left\{\left[\frac{p^{k}}{q^{m}}(\cos (\pi s \theta)(x, y)+\sin (\pi s \theta)(-y, x))\right]^{T}: k, m, s \in \mathbb{N}\right\} .
$$

Since $\left([x, y]^{T},[-y, x]^{T}\right)$ is a basis of $\mathbb{R}^{2}$, so

$$
\begin{aligned}
G_{\theta}(v) \cap \mathbb{R} v & =\left\{\frac{p^{k}}{q^{m}} \cos (\pi s \theta) v: s \theta \in \mathbb{Z}: k, m, s \in \mathbb{N}\right\} \\
& =\left\{\frac{p^{k}}{q^{m}} v: k, m \in \mathbb{N}\right\} \subset \mathbb{R}_{+} v
\end{aligned}
$$

This proves that $G_{\theta}$ is not subspace-hypercyclic for the straight line $\mathbb{R} v$ since otherwise, by Proposition [3.5, there is $z=\alpha v, \alpha \in \mathbb{R}$ such that $G_{\theta}(z) \cap \mathbb{R} v=\mathbb{R} v$. Thus $\mathbb{R} v \subset \alpha \mathbb{R}_{+} v$, a contradiction.

## 5. An example in the non-abelian case

Proposition 5.1. There exists a Non-abelian semigroup of $\mathcal{M}_{n}(\mathbb{K})$ which is hypercyclic and subspace-hypercyclic for a straight line.

Proof. In [7], Javaheri proves that there are two non-commuting matrices $A$ and $B$ on $\mathbb{K}^{n}$ that generate a hypercyclic semigroup, where $A=\left(a_{i, j}\right)_{1 \leq i, j \leq n}$ is lower triangular and $B=\operatorname{diag}\left(b_{1}, \ldots, b_{n}\right)$ is diagonal. The matrices $A$ and $B$ satisfy the condition: $\left\{\left(\frac{b_{n}}{b_{1}}\right)^{k}\left(\frac{a_{n, n}}{a_{1,1}}\right)^{l}: k, l \in \mathbb{N}\right\}$ is dense in $\mathbb{K}$. Let $G$ be the semigroup generated by $A, B, A^{\prime}=\frac{1}{a_{1,1}} I_{n}$ and $B^{\prime}=\frac{1}{b_{1}} I_{n}$. Clearly $G$ is a hypercyclic non-abelian semigroup of $\mathcal{M}_{n}(\mathbb{K})$. Moreover $e_{n}$ is a eigenvector of every element of $G$. We have

$$
\left\{\left(B B^{\prime}\right)^{k}\left(A A^{\prime}\right)^{l} e_{n}: k, l \in \mathbb{N}\right\}=\left\{\left(\frac{b_{n}}{b_{1}}\right)^{k}\left(\frac{a_{n, n}}{a_{1,1}}\right)^{l} e_{n}: k, l \in \mathbb{N}\right\} \subset G\left(e_{n}\right)
$$

It follows that $G\left(e_{n}\right) \cap \mathbb{K} e_{n}=G\left(e_{n}\right)$ is dense in $\mathbb{K} e_{n}$. We conclude that $G$ is subspace-hypercyclic for the straight line $\mathbb{K} e_{n}$.
