# The truncated EM method for stochastic differential delay equations with variable delay

#### Abstract

This paper mainly investigates the strong convergence and stability of the truncated Euler-Maruyama (EM) method for stochastic differential delay equations with variable delay whose coefficients can be growing super-linearly. By constructing appropriate truncated functions to control the super-linear growth of the original coefficients, we present a type of the truncated EM method for such SDDEs with variable delay, which is proposed to be approximated by the value taken at the nearest grid points on the left of the delayed argument. The strong convergence result (without order) of the method is established under the local Lipschitz plus generalized Khasminskii-type conditions and the optimal strong convergence order $1 / 2$ can be obtained if the global monotonicity with $U$ function and polynomial growth conditions are added to the assumptions. Moreover, the partially truncated EM method is proved to preserve the mean-square and $H_{\infty}$ stabilities of the true solutions. Compared with the known results on the truncated EM method for SDDEs, a better order of strong convergence is obtained under more relaxing conditions on the coefficients, and more refined technical estimates are developed so as to overcome the challenges arising due to variable delay. Lastly, some numerical examples are utilized to confirm the effectiveness of the theoretical results.


Keywords: Stochastic differential delay equations, truncated EM method, variable delay, strong convergence, stability.

## 1. Introduction

Stochastic differential delay equations (SDDEs) play a significant part in many application fields, such as economy, finance, automatic control and population dynamics (see, e.g., [1, 2, 3, 4]). In general, SDDEs rarely have explicit solutions available, and therefore one has to construct appropriate numerical schemes so as to approximate their solutions. Moreover, many important SDDE models often possess super-linear growth coefficients in practice, for example, stochastic delay Lotka-Volterra model arising in population dynamics of the form ([2])

[^0]where $B(t)$ is a Brownian motion and $\sigma=\left(\sigma_{i j}\right)_{d \times d}$ is a matrix representing the intensity of noise. If we apply the explicit Euler-Maruyama (EM) scheme to the model (1.1), it can be shown that this EM approximation may not converge to the true solution in the strong mean-square sense at 5 a finite time point (see, e.g.,[5]). As a result, this paper concerns the strong convergence analysis of numerical scheme for such SDDEs with super-linearly growing drift and diffusion coefficients.

When the delay term vanishes, the underlying SDDEs reduce to the usual stochastic differential equations (SDEs), numerical methods for which have been extensively investigated for the past decades under the global Lipschitz condition (e.g., [6], [7], [8]). In 2012, Hutzenthaler et al. - [9] firstly introduced an explicit method called the tamed EM method to solve SDEs with superlinearly growing drift coefficient and linearly growing diffusion coefficient. Since then, several explicit schemes have been proposed for SDEs whose coefficients can be growing super-linearly under the local Lipschitz condition, e.g., balanced EM method [10][11], truncated EM method [12, 13]. Recently, the attention of some researches was attracted to the strong convergence of explicit numerical methods for super-linear SDEs with delay, i.e., SDDEs. Motivated by the work of Mao [12, 13], Guo et al. [14] discussed the strong convergence of the truncated EM method for SDDEs under the local Lipschitz condition plus the generalized Khasminskii-type condition (2.3). In a subsequent paper, Gao et al. [15] took the delay and jumps into consideration, they extended convergence results from [14, 16] to the case of SDDEs with Poisson jumps. By using a different estimate for the difference between the original and the truncated coefficients, Fei et al. [17] relaxed the restrictive condition on the step size which is required to extremely small and thus improved the convergence results of [14]. Moreover, Song et al. [18] achieved a better convergence order than [14] and [17] by adopting the truncation techniques from [19] for such SDDEs. The applications of the partially truncated and modified truncated 5 EM methods for SDDEs can be found in [20, 21]. Other explicit numerical methods for superlinear SDDEs, say tamed EM, balanced EM, truncated Milstein, projected EM, are discussed in [22, 23, 24, 25, 26, 27].

In the preceding discussion, the focus of the interest is on the numerical method of SDEs with constant delay. In reality, delay can behave as a function of time, namely, variable delay. Mao and Sabanis [28] were the first authors to consider the strong convergence of numerical method for such SDDEs. In contrast to the constant delay, the main difficulty in the construction of the computational approach in case of SDDEs with variable delay is how to numerically approximate the values of the solution at the delayed instants. Mao and Sabanis proposed to use the approximate values at the nearest grid points on the left of the delayed arguments to estimate the variable ${ }_{35}$ delay, and they derived an upper bound for the difference of this approximation. Influenced by [28], several explicit and implicit variants of the EM method have been developed to study the convergence of the numerical solutions to stochastic equations with variable delay. For instance, we refer to [29] for the convergence in probability of EM method for highly nonlinear neutral stochastic differential equations with variable delay, and to [30] for the strong error analysis of EM method for SDEs with variable and distributed delays. Further, in [31], strong convergence rates are derived for the split-step theta method applied to stochastic age-dependent population equations with Markovian switching and variable delay.

Based on the above discussion, the objective of this work is to study the strong convergence (including the stability) of explicit numerical method of super-linear SDDEs with variable de4 lay. By constructing appropriate truncated functions to control the super-linear growth of the original coefficients, we introduce a type of the truncated EM method for such SDDEs with variable delay, which can be approximated by the value taken at the left endpoint of interval containing the delayed argument. We then show that the method is convergent in the sense of is denoted by $\mathbb{I}_{G}$. The scalar product of two vectors $X, Y \in \mathbb{R}^{d}$ is denoted by $\langle X, Y\rangle$ or $X^{T} Y$. The largest integer which is less or equal to a real number $a$ is denoted by $\lfloor a\rfloor$. In addition, we use $C$ to denote the generic constant that may change from place to place.

Let $\delta:[0,+\infty) \rightarrow[0, \tau]$ be the delay function which is Borel measurable. Consider the following SDDE of the form

with the initial data

where $f: \mathbb{R}^{d} \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ and $g: \mathbb{R}^{d} \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d \times m}$ are Borel-measurable functions. We introduce o the following assumptions:

Assumption 2.1 (Local Lipschitz Condition). For any $R>0$, there exists a constant $L_{R} d e$ pending on $R$ such that

for any $x_{1}, x_{2}, y_{1}, y_{2} \in \mathbb{R}^{d}$ with $\left|x_{1}\right| \vee\left|x_{2}\right| \vee\left|y_{2}\right| \vee\left|y_{2}\right| \leq R$.

Assumption 2.2 (Generalized Khasminskii-type Condition). There exist constants $K_{1}>0$, $K_{2} \geq 0, K_{3} \geq 0$ and $\beta>2$ such that

Assumption 2.3. Let $\delta:[0,+\infty) \rightarrow[0, \tau]$ is continuously differentiable and there is $\hat{\delta} \in[0,1)$ such that $\left|\frac{d \delta(t)}{d t}\right| \leq \hat{\delta}$, for any $t \geq 0$.

Lemma 2.4. Suppose that Assumption 2.1 2.2 and 2.3 hold with $K_{2}>\frac{K_{3}}{(1-\hat{\delta})} \geq 0$. Then for any given initial data (2.2), there is a unique global solution $X(t)$ to (2.1) on $t \in[-\tau,+\infty)$. Moreover, the solution $X(t)$ has the property that

The proof of this result can be found in Song et al. [33].

## 3. The truncated EM scheme for SDDEs with variable delay

We first choose a strictly increasing continuous functions $\mu: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$such that $\mu(R) \rightarrow \infty$ as $R \rightarrow \infty$ and

Denote by $\mu^{-1}$ the inverse function of $\mu$ and we see that $\mu^{-1}:[\mu(1), \infty) \rightarrow \mathbb{R}_{+}$is a strictly increasing continuous function. We then choose a constant $\hat{h} \geq 1 \vee \mu(1)$ and a strictly decreasing function $\varphi:(0,1] \rightarrow[\mu(1),+\infty)$ such that

For a given step size $\Delta \in(0,1]$, let us define a truncation mapping $\pi_{\Delta}: \mathbb{R}^{d} \rightarrow\left\{x \in \mathbb{R}^{d}:|x| \leq\right.$ $\left.\mu^{-1}(h(\Delta))\right\}$ by

when $x=0$, we set $x /|x|=0$. That is, $\pi_{\Delta}$ maps to itself if $|x| \leq \mu^{-1}(\varphi(\Delta))$ and to $\mu^{-1}(\varphi(\Delta)) x /|x|$ if $|x|>\mu^{-1}(\varphi(\Delta))$. Define the following truncated functions

From (3.1), (3.3) and (3.4), we have

\left|f_{\Delta}(x, y)\right| \vee\left|g_{\Delta}(x, y)\right| \leq \varphi(\Delta)\left(1+\left|\pi_{\Delta}(x)\right|+\left|\pi_{\Delta}(y)\right|\right) \leq \varphi(\Delta)(1+|x|+|y|), \forall x, y \in \mathbb{R}^{d} \tag{3.5}
\end{equation*}

which means that the truncated coefficients $f_{\Delta}$ and $g_{\Delta}$ grow at most linearly for a fixed step size $\Delta$, but $f$ and $g$ may not. The following lemma shows that these truncated coefficients can conserve the generalized Khasminskii-type condition for any $\Delta \in(0,1]$, the proof of the lemma is similar to that of Fei et al. [17, Lemma 3.2] and so is omitted.

Lemma 3.1. Let Assumptions hold with $K_{2} \geq K_{3} \geq 0$. Then for any $\Delta \in(0,1]$,

where $\hat{K}_{1}=2 K_{1}\left(1 \vee\left[1 / \mu^{-1}(\varphi(1))\right]\right)$.
Assume that step size $\Delta \in(0,1]$ is a fraction of $\tau$. Take $\Delta=\tau / M$ for some sufficiently large integer $M$. Define $t_{k}=k \Delta$ and $\delta_{k}=\lfloor\delta(k \Delta) / \Delta\rfloor$, for any integer $k \geq 0$. Then the boundedness of $\delta$ gives

Define $\kappa(t):=\lfloor t / \Delta\rfloor \Delta$, for any $t \geq-\tau$. The discrete-time truncated EM scheme is defined as follows:

where $\Delta B_{k}=B\left(t_{k+1}\right)-B\left(t_{k}\right)$. Define the continuous-time step approximations $Z_{1}(t)$ and $Z_{2}(t)$ by

where $\mathbb{I}$ is the indicator function. Define the continuous-time approximation $Y_{\Delta}(t)$ on $t \in[-\tau, \infty)$ by

Thus $Y_{\Delta}(t)$ is an Itô process on $t \geq 0$ with Itô differential

It is useful to know that for any $t \in\left[t_{k}, t_{k+1}\right)$ with $k \geq 0$,

as well as

which means that the $Y_{\Delta}(t)$ and $Z_{1}(t)$ coincide with the discrete solution at the grid points.
Remark 3.2. By (3.5), we see from (3.8) that for a given step size $\Delta \in(0,1]$, any $p \geq 2$ and any $k \geq 1$,

Moreover, this and (3.14) guarantee that for a given step size $\Delta \in(0,1]$ and any $p \geq 2$,

However, we cannot conclude that this bound is independent of $\Delta$. As a result of this observation, we need not apply stopping time arguments in the proof Lemma 4.3 due to the fact that for any $\Delta \in(0,1]$ and any $p \geq 2$,

Thus, for a given step size $\Delta \in(0,1]$ and any $p \geq 2$, by (3.5), we have

& \leq 3^{p}(h(\Delta))^{p}\|\xi\|^{p} \Delta^{0.5 p} \leq 3^{p}\|\xi\|^{p} \hat{h}^{p} \Delta^{p / 4} . \tag{3.19}

Thus, by induction, we can show that (3.15) holds. Moreover, rewrite (3.14) as

& \leq c_{p}(\varphi(\Delta))^{p}\left(\mathbb{E}\left|y_{k}\right|^{p}+\mathbb{E}\left|y_{k-\delta_{k}}\right|^{p}\right) \Delta^{0.5 p} \\
& \leq C_{p,\|\xi\| \mid, \hat{h}, \Delta}, \forall t \in\left[t_{k}, t_{k+1}\right), k \geq 0,
\end{aligned}

which gives (3.16)

## 4. Strong convergence

4.1. Strong convergence (without order) at time $T$

Lemma 4.1. For any $\Delta \in(0,1]$ and $p>0$,

${ }_{95}$ where $C$ is a positive constant independent of $\Delta$.
Proof. For any $p \geq 2$, by (3.5), we see from (3.14) that for any $t \geq 0$

& \leq C \mathbb{E}\left[\left|f_{\Delta}\left(Z_{1}(t), Z_{2}(t)\right)(t-\kappa(t))\right|^{p} \mid \mathcal{F}_{\kappa(t)}\right]+C \mathbb{E}\left[\left|g_{\Delta}\left(Z_{1}(t), Z_{2}(t)\right)(B(t)-B(\kappa(t)))\right|^{p} \mid \mathscr{F}_{\kappa(t)}\right] \\
& \leq C \Delta^{p}(\varphi(\Delta))^{p}\left(1+\left|Z_{1}(t)\right|^{p}+\left|Z_{2}(t)\right|^{p}\right)+C \Delta^{p / 2}(\varphi(\Delta))^{p}\left(1+\left|Z_{1}(t)\right|^{p}+\left|Z_{2}(t)\right|^{p}\right) \\
& \leq C \Delta^{p / 2}(\varphi(\Delta))^{p}\left(1+\left|Z_{1}(t)\right|^{p}+\left|Z_{2}(t)\right|^{p}\right),
\end{aligned}

this also holds for any $p \in(0,2)$ due to the Hölder inequality.

Lemma 4.2. Let Assumption 2.3 hold. For any $k \in\{0,1,2, \cdots\}$, let $k-\lfloor\delta(k \Delta) / \Delta\rfloor=u$, where $u \in\{-M,-M+1, \cdots, 0,1, \cdots, k\}$. Then

where \#S denotes the number of elements of the set $S$.
This lemma provides an upper bound for the maximal number of indices $k \in\{1,2, \cdots\}$ for which the expressions $k-\delta_{k}$ are equal, the proof can be found in Milošović [34, Lemma 3].

& \leq \mathbb{E}\left|y_{k \wedge \vartheta_{\Delta, R}}\right|^{2}+C \Delta+\hat{K}_{1} \mathbb{E}\left[\left(1+\left|y_{k}\right|^{2}+\left|y_{k-\delta_{k}}\right|^{2}\right)\right] \Delta+\hat{H}_{k} \\
& \leq \mathbb{E}\left|y_{k \wedge \vartheta_{\Delta, R}}\right|^{2}+C \Delta+\hat{H}_{k}, \forall k \geq 0, \tag{4.25}
\end{align*}
$$

where

\leq & \left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right) M \| \xi| |^{\beta}+\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right) \sum_{i=0}^{(k-1) \wedge\left(\vartheta_{\Delta, R}-1\right)}\left|\pi_{\Delta}\left(y_{i}\right)\right|^{\beta}, \forall k \geq 1 . \tag{4.27}

But we see from (4.30) than this estimate remains a "tail", namely, the second term on the right hand side of (4.30), and we have on other method to address $J^{\star}$ properly. However, if we take $\theta$ to be the grid point, then the "tail" vanishes. This motivates the above discrete proof in Lemma 4.5 .

The following theorem establish the strong convergence (without order) results of the truncated EM method.

In this theorem, $C_{R}$ denotes a positive constant depending on $R$ but independent of $\Delta$, its value may be different for different appearance. By Lemmas 2.4 and 4.3 , we get that

with the initial data $z(t)=\xi(t)$ on $t \in[-\tau, 0]$. By Assumption 2.1, we observe that $F_{R}(x, y)$ and $G_{R}(x, y)$ are globally Lipschitz continuous with the Lipschitz constant $L_{R}$. Hence, SDDE (4.33) has a unique global solution $z(t)$ on $t \geq-\tau$ satisfying

& =\mathbb{E}\left[\mid z\left(T \wedge\left(\hat{\theta}_{\Delta, R}-1\right)\right)-\bar{z}_{\Delta}\left(\left.T \wedge\left(\hat{\theta}_{\Delta, R}-1\right)\right|^{q}\right]\right. \\

### 4.2. Strong convergence order at time $T$

In this section, we mainly discuss the strong convergence order of the truncated EM method for (2.1). We need a stronger condition than (2.3).

Assumption 4.8. There is a pair of constants $p_{0}>2$ and $\bar{K}_{1}>0$ such that

\mathbb{E}\left|Y_{\Delta}(t-\delta(t))-Z_{2}(t)\right|^{p} \leq C \Delta^{(\varrho \wedge 0.5) p}, \forall t \geq 0, \tag{4.48}
\end{equation*}

where $C$ is a positive constant independent of $\Delta$.

Proof. Let $p \in\left[2, \frac{p_{0}}{1+l / 2}\right]$. For any $t \in\left[t_{k}, t_{k+1}\right)$ with $k \geq 0$, we see from (3.14] that

& +c_{p}\left|t-\delta(t)-\left(k-\delta_{k}\right) \Delta\right|^{0.5 p-1} \int_{\left(k-\delta_{k}\right) \Delta}^{t-\delta(t)} \mathbb{E}\left|g_{\Delta}\left(Z_{1}(s), Z_{2}(s)\right)\right|^{p} d s \\
\leq & C\left|t-\delta(t)-\left(k-\delta_{k}\right) \Delta\right|^{0.5 p} \\
\leq & C(\lfloor\hat{\delta}\rfloor+4)^{0.5 p} \Delta^{0.5 p} \tag{4.53}
\end{align*}
$$

where the Burkholder-Davis-Gundy inequality, (4.49) (4.50) and 4.52) have been used.
Case 2: If $t-\delta(t) \leq\left(k-\delta_{k}\right) \Delta \leq 0$ or $\left(k-\delta_{k}\right) \Delta \leq t-\delta(t) \leq 0$, by Assumption 4.4 and 4.52) we have

& \leq C\left((\lfloor\hat{\delta}\rfloor+4)^{\varrho p}+(\lfloor\hat{\delta}\rfloor+4)^{0.5 p}\right) \Delta^{(\varrho \wedge 0.5) p} . \tag{4.55}

Case 4: If $\left(k-\delta_{k}\right) \Delta \geq 0 \geq t-\delta(t)$, in a similar way as 4.55) was obtained, we also have

where $C$ is a positive constant independent of $\Delta$. In particular, let

Remark 4.15. If constant delay is considered in 2.1, then Theorem 4.14 reduces to Fei et al. [17] Theorem 3.6]. Comparing with the two theorems, we observe the following differences:

- Theorem 4.14 requires a slightly stronger condition on the parameters, namely, $p_{0} \geq 2+3 l$, while Fei et al. [17] Theorem 3.6] requires $p_{0}>2+l$;
- Theorem 4.14 allows a slightly weaker control function $\mu$ for truncation, namely, $\mu(r)=$ $\mathrm{Cr}^{l / 2}$, while Fei et al. [17] Theorem 3.6] allows $\mu(r)=\mathrm{Cr}^{1+l / 2}$;
- In Theorem 4.14 the truncated EM approximation $Y_{\Delta}(T)$ achieves a better order of $\mathcal{L}^{2}$ convergence which is $2 \varrho \wedge 1$, while in Fei et al. 17] Theorem 3.6] the corresponding convergence order is $2 \varrho \wedge(1-2 \varepsilon) \wedge 2 \varepsilon\left(p_{0}-l-2\right) /(2+l)$ for some $\varepsilon \in(0,1 / 4]$, which can be close to the rate of Theorem 4.14 but $p_{0}$ should be required to sufficiently large.

Remark 4.16. It is worth mentioning how our work compares with that of Cong et al. [32], who proved the strong convergence results of partially truncated EM method applied to the SDDEs with variable delay and Markovian switching. What differentiates our work from [32] are:

- We remove the restrictive condition (3.25) in [32] Theorem 3.12], i.e.,

which could force the step size to be so small that the truncated EM method would be inapplicable;

- We relax the grown constraint on the Khasminskii-type condition (2.13) in [32] Assumption 2.3], i.e.,

- We obtain the optimal order $1 / 2$ of strong convergence which is higher than that of Cong et al. [32] Theorem 3.12], i.e.,

& +\left(p_{1}-1\right)\left|g(X(s), X(s-\delta(s)))-g\left(Y_{\Delta}(s), Y_{\Delta}(s-\delta(s))\right)\right|^{2} \\
& +2\left\langle X(s)-Y_{\Delta}(s), f\left(Y_{\Delta}(s), Y_{\Delta}(s-\delta(s))\right)-f_{\Delta}\left(Z_{1}(s), Z_{2}(s)\right)\right\rangle \\
& \left.+\frac{p_{1}-1}{p_{1}-2}\left|g\left(Y_{\Delta}(s), Y_{\Delta}(s-\delta(s))\right)-g_{\Delta}\left(Z_{1}(s), Z_{2}(s)\right)\right|^{2}\right) d s \\
\leq & \Pi_{1}+\Pi_{2} \tag{4.64}
\end{align*}

& \leq C\left(\mathbb{E}\left|Y_{\Delta}(s)-Z_{1}(s)\right|^{2 p_{0} /\left(p_{0}-l\right)}+\mathbb{E}\left|Y_{\Delta}(s-\delta(s))-Z_{2}(s)\right|^{2 p_{0} /\left(p_{0}-l\right)}\right)^{\left(p_{0}-l\right) / p_{0}} \\

## 5. Mean-square and $\boldsymbol{H}_{\infty}$ stabilities

In this section, we mainly discuss the mean-square and $H_{\infty}$ stabilities of the truncated EM method for $\operatorname{SDDE}$ (2.1). Noting that the truncated functions $f_{\Delta}$ and $g_{\Delta}$ can preserve the Khasminskiitype condition (3.6, unfortunately they cannot preserve the stability condition. Thus, we can
only hope that the terms that work for the stability in the coefficients grows at most linearly, while for those that grow super-linearly, they have no stabilizing effect. In our truncated method for stability, we only use the truncation technique to the super-linear terms in the coefficients. Lemma 5.4 show that those partially truncated functions defined by 5.10 have the property of preserving the stability condition.

As a result, we assume that $f$ and $g$ can be decomposed as $f(x, y)=F_{1}(x, y)+F(x, y)$ and $g(x, y)=G_{1}(x, y)+G(x, y)$, where $F_{1}, F: \mathbb{R}^{d} \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ and $G_{1}, G: \mathbb{R}^{d} \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d \times m}$. Moreover, $F_{1}(0,0)=F(0,0)=G_{1}(0,0)=G(0,0)=0$, the coefficients $F_{1}, F, G_{1}, G$ satisfy the following conditions.

\epsilon_{\Delta^{\star}}=\frac{\lambda_{1}-\alpha_{1}-\frac{1}{4} \lambda_{2}-\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)\left(\alpha_{2}+\lambda_{2}\right)}{1+\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)}
$$

Then for any $\Delta \in\left(0, \Delta^{\star}\right)$, we have

$$
\begin{align*}
& H_{1}(1, \Delta)=\lambda_{1}-\alpha_{1}-\frac{1}{4} \lambda_{2}-\epsilon_{\Delta}-\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)\left(\lambda_{2}+\alpha_{2}+\epsilon_{\Delta}\right)>0  \tag{5.30}\\
& H_{1}(\bar{r}, \Delta)=-\frac{1-\bar{r}^{-\Delta}}{\Delta}<0 \text {, with }\left(\frac{\lambda_{1}-\alpha_{1}-\frac{1}{4} \lambda_{2}-\epsilon_{\Delta}}{\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)\left(\lambda_{2}+\alpha_{2}+\epsilon_{\Delta}\right)}\right)^{1 / \tau}>1 \tag{5.31}
\end{align*}
$$

and

$$
\begin{equation*}
\frac{d H_{1}(r, \Delta)}{d r}<0 . \tag{5.32}
\end{equation*}
$$

From (5.30), 5.31) and 5.32), there is a positive constant $r_{1}^{\star}=r_{1}^{\star}(\Delta) \in(1, \bar{r})$ such that $H_{1}\left(r_{1}^{\star}, \Delta\right)=0$. Let $r^{\star}=r^{\star}(\Delta)=r_{1}^{\star}(\Delta) \wedge r_{2}^{\star}$ with $r_{2}^{\star}=\left(\frac{\alpha_{3}}{\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right) \alpha_{4}}\right)^{1 / \tau}>1$, then for any $1<r<r^{\star}(\Delta)$, we have $H_{1}(r, \Delta)>0$ and $H_{2}(r)>0$, thus we conclude from (5.28) that

$$
r^{(k+1) \Delta} \mathbb{E}\left|y_{k+1}\right|^{2} \leq H_{0}(r, \Delta)<\infty, \quad \forall k \geq 0
$$

Therefore,

$$
\begin{equation*}
\limsup _{k \rightarrow \infty} \frac{\log \mathbb{E}\left|y_{k}\right|^{2}}{t_{k}} \leq-\log r . \tag{5.33}
\end{equation*}
$$

Bearing in mind that $r_{2}^{\star}=\mathrm{e}^{\gamma_{2}^{\star}}$ and setting $r=\mathrm{e}^{\gamma}, r_{1}^{\star}=\mathrm{e}^{\gamma_{1}}$, then (5.33) becomes 5.17). Finally, noticing that $\epsilon_{\Delta} \rightarrow 0$ and $\frac{1-\mathrm{e}^{-r_{1}^{\star} \Delta}}{\Delta} \rightarrow r_{1}^{\star}$ as $\Delta \rightarrow 0$, comparing (5.8) with (5.18), we obtain the assertion (5.19).
Finally, we begin to establish (5.20). By (5.23), we have

$$
\begin{align*}
\mathbb{E}\left|y_{k+1}\right|^{2} \leq & |\xi(0)|^{2}-\left(\lambda_{1}-\alpha_{1}-\frac{1}{4} \alpha_{2}-\epsilon_{\Delta}\right) \sum_{j=0}^{k} \mathbb{E}\left|y_{j}\right|^{2} \Delta+\left(\lambda_{2}+\alpha_{2}+\epsilon_{\Delta}\right) \sum_{j=0}^{k} \mathbb{E}\left|y_{j-\delta_{j}}\right|^{2} \Delta \\
& +\mathbb{E}\left[-\alpha_{3} \sum_{j=0}^{k}\left|\pi_{\Delta}\left(y_{j}\right)\right|^{\beta}+\alpha_{4} \sum_{j=0}^{k} \mid \pi_{\Delta}\left(y_{j-\delta_{j}}\right) \beta^{\beta}\right] \Delta, \forall k \geq 0, \tag{5.34}
\end{align*}
$$

While Lemma 4.2 gives that

$$
\begin{equation*}
\left.\sum_{j=0}^{k}\left|y_{j-\delta_{j}}\right|^{2} \leq\left(L(1-\hat{\delta})^{-1}\right\rfloor+1\right) M\|\xi\|^{2}+\sum_{j=0}^{k}\left|y_{j}\right|^{2} \tag{5.35}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{j=0}^{k} \mid \pi_{\Delta}\left(\left.y_{j-\delta_{j}}\right|^{\beta} \leq\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right) M\|\xi\|^{\beta}+\sum_{j=0}^{k}\left|\pi_{\Delta}\left(y_{j}\right)\right|^{\beta} .\right. \tag{5.36}
\end{equation*}
$$

Substituting (5.35) and (5.36) into (5.34, we obtain that for any $\Delta \in\left(0, \Delta^{\star}\right)$,

$$
\begin{align*}
0 \leq \mathbb{E}\left|y_{k+1}\right|^{2} \leq & \|\xi\|^{2}+\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right) \tau\left(\left(\lambda_{2}+\alpha_{2}+\epsilon_{\Delta}\right)\|\xi\|^{2}+\alpha_{4}\|\xi\|^{\beta}\right) \\
& -\left(\alpha_{3}-\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right) \alpha_{4}\right) \mathbb{E}\left[\sum_{j=0}^{k}\left|\pi_{\Delta}\left(y_{j}\right)\right|^{\beta}\right] \Delta \\
& -\left[\lambda_{1}-\alpha_{1}-\frac{1}{4} \alpha_{2}-\epsilon_{\Delta}-\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)\left(\lambda_{2}+\alpha_{2}+\epsilon_{\Delta}\right)\right] \sum_{j=0}^{k} \mathbb{E}\left|y_{j}\right|^{2} \Delta, \quad \forall k \geq 0, \tag{5.37}
\end{align*}
$$

which means

$$
\begin{equation*}
\sum_{j=0}^{k} \mathbb{E}\left|\pi_{\Delta}\left(y_{j}\right)\right|^{2} \Delta \leq \frac{\|\xi\|^{2}+\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right) \tau\left(\left(\lambda_{2}+\alpha_{2}+\epsilon_{\Delta}\right)\|\xi\|^{2}+\alpha_{4}\|\xi\|^{\beta}\right)}{\lambda_{1}-\alpha_{1}-\frac{1}{4} \alpha_{2}-\epsilon_{\Delta}-\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)\left(\lambda_{2}+\alpha_{2}+\epsilon_{\Delta}\right)}<\infty, \tag{5.38}
\end{equation*}
$$

holds for any $k \geq 0$. Letting $k \rightarrow \infty$ gives 5.20 . Thus, the proof is finished.

## 6. Numerical examples

Example 6.1. Consider a highly nonlinear scalar SDDE (see [17])

$$
\begin{equation*}
d X(t)=\left[-9 X^{3}(t)+|X(t-\delta(t))|^{3 / 2}\right] d t+X^{2}(t) d B(t), t \geq 0 \tag{6.1}
\end{equation*}
$$

with initial data $\{X(t):-\tau \leq t \leq 0\}=\xi \in C([-\tau, 0] ; \mathbb{R})$, where $B(t)$ is a one-dimensional Brownian motion. Assume that $\delta$ satisfies Assumption 2.3. Clearly, the coefficients

$$
\begin{equation*}
f(x, y)=-9 x^{3}+|y|^{3 / 2} \quad \text { and } \quad g(x, y)=x^{2}, \forall x, y \in \mathbb{R} \tag{6.2}
\end{equation*}
$$

are locally Lipschitz continuous. Moreover, if $p_{0}=18.5$, then

$$
\begin{align*}
& x f(x, y)+\frac{p_{0}-1}{2}=-9 x^{4}+x|y|^{3 / 2}+8.75 x^{4} \\
& \leq-9 x^{4}+8.75 x^{4}+0.25 x^{4}+0.75 y^{2}=0.75 y^{2} \tag{6.3}
\end{align*}
$$

which means that Assumption 4.8 is satisfied. For any $x_{1}, x_{2}, y_{1}, y_{2}, \in \mathbb{R}$, we have

$$
\begin{align*}
& \left(x_{1}-x_{2}\right)\left(f\left(x_{1}, y_{1}\right)-f\left(x_{2}, y_{2}\right)\right) \\
& \leq-4.5\left(x_{1}^{2}+x_{2}^{2}\right)\left|x_{1}-x_{2}\right|^{2}+0.5\left|x_{1}-x_{2}\right|^{2}+2.25\left|y_{1}-y_{2}\right|^{2}+2.25\left(y_{1}^{2}+y_{2}^{2}\right)\left|y_{1}-y_{2}\right|^{2} \tag{6.4}
\end{align*}
$$

and

$$
\begin{gather*}
\left|g\left(x_{1}, y_{1}\right)-g\left(x_{2}, y_{2}\right)\right|^{2}=\left|x_{1}^{2}-x_{2}^{2}\right|^{2} \leq 2\left(x_{1}^{2}+x_{2}^{2}\right)\left|x_{1}-x_{2}\right|^{2}  \tag{6.5}\\
26
\end{gather*}
$$

see [17. p. 2086]. Consequently,

$$
\begin{aligned}
& \quad\left(x_{1}-x_{2}\right)\left(f\left(x_{1}, y_{1}\right)-f\left(x_{2}, y_{2}\right)\right)+\frac{p_{1}-1}{2}\left|g\left(x_{1}, y_{1}\right)-g\left(x_{2}, y_{2}\right)\right|^{2} \\
& \quad \leq 0.5\left|x_{1}-x_{2}\right|^{2}+2.25\left|y_{1}-y_{2}\right|^{2}-\left(5.5-p_{1}\right)\left(x_{1}^{2}+x_{2}^{2}\right)\left|x_{1}-x_{2}\right|^{2}+1.125\left(y_{1}^{2}+y_{2}^{2}\right)\left|y_{1}-y_{2}\right|^{2} \\
& \text { If we set } p_{1}=3.25, \hat{\delta}=0.5 \text { and } U\left(x_{1}, x_{2}\right)=1.125\left(x_{1}^{2}+x_{2}^{2}\right)\left|x_{1}-x_{2}\right|^{2} \text {, then 6.6 becomes }
\end{aligned}
$$

$$
\begin{align*}
& \left(x_{1}-x_{2}\right)\left(f\left(x_{1}, y_{1}\right)-f\left(x_{2}, y_{2}\right)\right)+\frac{p_{1}-1}{2}\left|g\left(x_{1}, y_{1}\right)-g\left(x_{2}, y_{2}\right)\right|^{2} \\
& \leq 0.5\left|x_{1}-x_{2}\right|^{2}+2.25\left|y_{1}-y_{2}\right|^{2}-\frac{1}{1-\hat{\delta}} U\left(x_{1}, x_{2}\right)+U\left(y_{1}, y_{2}\right) . \tag{6.7}
\end{align*}
$$

Moreover, it is straightforward to show that (4.42) is satisfied with $l=4$. Thus, we have verified Assumption (4.12) with $p_{0} \geq 2+3$ l. From (6.2) and (3.1), we may set

$$
\begin{equation*}
\mu(R)=10 R^{2}, \forall R \geq 1 \text { and } \varphi(\Delta)=10 \Delta^{-1 / 4}, \forall \Delta \in(0,1] . \tag{6.8}
\end{equation*}
$$

Then, by Theorem 4.14 for any $\Delta \in(0,1]$ the truncated EM solution $Y_{\Delta}(t)$ will converge to the exact solution $X(t)$ in the sense that

$$
\begin{equation*}
\mathbb{E}\left|X(T)-Y_{\Delta}(T)\right|^{2} \leq C \Delta \quad \text { and } \quad \mathbb{E}\left|X(T)-Z_{1}(T)\right|^{2} \leq C \Delta, \forall T>0 \tag{6.9}
\end{equation*}
$$

However, if constant delay is considered in $\operatorname{SDDE}$ (6.1), we may also apply the truncated EM method from [17] to (6.1) by setting

$$
\begin{equation*}
\mu(R)=10 R^{3}, \forall R \geq 1 \quad \text { and } \varphi(\Delta)=10 \Delta^{-1 / 5}, \forall \Delta \in(0,1], \tag{6.10}
\end{equation*}
$$

due to

$$
\begin{equation*}
\sup _{|x| \vee|y| \leq R}(|f(x, y)| \vee|g(x, y)|) \leq 10 R^{3}, \forall R \geq 1 \tag{6.11}
\end{equation*}
$$

Thus according to [17. Corollary 3.7], for any $\Delta \in(0,1]$ the truncated EM solution will approximate the exact solution in the sense that

$$
\begin{equation*}
\mathbb{E}\left|X(T)-Y_{\Delta}(T)\right|^{2} \leq C \Delta^{3 / 5} \quad \text { and } \quad \mathbb{E}\left|X(T)-Z_{1}(T)\right|^{2} \leq C \Delta^{3 / 5}, \forall T>0, \tag{6.12}
\end{equation*}
$$

see [17 p. 2086]. Comparing (6.9) and (6.12], we conclude that our scheme establishes a better rate of convergence result than that of Fei et al. [17] under almost the same conditions. Set $\tau=1, \delta(t)=0.5-0.5 \sin (t)$ and $X(t)=2$ for any $t \in[-\tau, 0]$. Truncated EM solution with step size $\Delta=2^{-14}$ is taken as the replacement of the true solution. The root of mean-square errors with different step sizes $2^{-7}, 2^{-8}, \cdots 2^{-11}$ for 500 at time $T=10$ simulations is illustrated in Fig.
${ }_{175} \quad l(a)$. A least square fit of errors yields the strong convergence order 0.5134 and thus is close to the theoretical value 0.5.

Example 6.2. Let us consider the stochastic delay power logistic model (see e.g., [3] 2])

$$
\begin{equation*}
d X(t)=X(t)\left[a+b X(t-\delta(t))-X^{2}(t)\right] d t+c X(t) X(t-\delta(t)) d B(t), t \geq 0 \tag{6.13}
\end{equation*}
$$

with initial data $\{X(t):-\tau \leq t \leq 0\}=\xi \in C([-\tau, 0] ; \mathbb{R})$, where $B(t)$ is a one-dimensional Brownian motion and $a, b, c$ are all constants. Assume that $\xi$ satisfies Assumption 4.4 with $K_{4}=$ 2, $\varrho=0.5$ and $\delta$ satisfies Assumption 2.3. Set

$$
f(x, y)=F_{1}(x, y)+F(x, y) \quad \text { and } \quad g(x, y)=G_{1}(x, y)+G(x, y)
$$

where

$$
F_{1}(x, y)=a x, \quad G_{1}(x, y)=0, \quad F(x, y)=b x y-x^{2}, \quad G(x, y)=c x y,
$$

for any $x, y \in \mathbb{R}$. Clearly, Assumption 5.1 hold. Put $\theta=\infty$. Then

$$
2 x F_{1}(x, y)+(1+\theta)\left|G_{1}(x, y)\right|^{2}=2 a x^{2}
$$

and the elementary inequality yields that

$$
\begin{aligned}
& 2 x F(x, y)+\left(1+\theta^{-1}\right)|G(x, y)|^{2}=2 x\left(b x y-x^{3}\right)+(c x y)^{2} \\
& \leq 0.5 x^{4}+0.5(2 b y)^{2}-2 x^{4}+0.5 x^{4}+0.5\left(c^{2} y^{2}\right)^{2}=2 b^{2} y^{2}-x^{4}+0.5 c^{4} y^{4}
\end{aligned}
$$

Thus,

$$
\lambda_{1}=-2 a, \quad \lambda_{2}=0, \quad \alpha_{1}=0, \quad \alpha_{2}=2 b^{2}, \quad \alpha_{3}=1, \quad \alpha_{4}=0.5 c^{4}, \quad \beta=4
$$

If we let

$$
\begin{equation*}
0.5 c^{4}\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)<1 \quad \text { and } \quad-2 a>2 b^{2}\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right) \tag{6.14}
\end{equation*}
$$

which means that condition 5.9 is satisfied, then by Lemma 5.3 the exact solution $X(t)$ to SDDE 6.13) has the property that

$$
\begin{equation*}
\limsup _{t \rightarrow \infty} \frac{\log \mathbb{E}|X(t)|^{2}}{t} \leq-\left(\gamma^{\star} \wedge \frac{1}{\tau} \log \frac{1}{0.5 c^{4}\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)}\right), \tag{6.15}
\end{equation*}
$$

and $\int_{0}^{\infty} \mathbb{E}|X(t)|^{2} d t<\infty$, where $\gamma^{\star}>0$ is the unique root to the following equation

$$
\begin{equation*}
-2 a=\gamma^{\star}+2 b^{2}\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right) e^{\gamma^{\star} \tau} . \tag{6.16}
\end{equation*}
$$

On the other hand, take

$$
\begin{equation*}
\mu(R)=((|b|+1) \vee|c|) R^{2}, \forall R \geq 1 \quad \text { and } \quad \varphi(\Delta)=((|b|+1) \vee|c|) \Delta^{-1 / 4}, \forall \Delta \in(0,1] . \tag{6.17}
\end{equation*}
$$

We apply partially truncated EM scheme $\sqrt{3.8}$ with coefficients $f_{\Delta}$ and $g_{\Delta}$ given by (5.10) and we denote $\left\{y_{k}\right\}_{k \geq 0}$ by the discrete truncated EM approximation. According to Theorem 5.5] for any $\Delta \in\left(0, \Delta^{\star}\right)$ and any initial data, the truncated EM approximation $\left\{y_{k}\right\}_{k \geq 0}$ has the property that

$$
\begin{equation*}
\limsup _{k \rightarrow \infty} \frac{\log \mathbb{E}\left|y_{k}\right|^{2}}{t_{k}} \leq-\left(\gamma_{\Delta}^{\star} \wedge \frac{1}{\tau} \log \frac{1}{0.5 c^{4}\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)}\right) \tag{6.18}
\end{equation*}
$$

Table 1: $\epsilon_{\Delta}$ and $\gamma_{\Delta}^{\star}$ with different step sizes for solving 6.19

and $\sum_{k=0}^{\infty} \mathbb{E}\left|y_{k}\right|^{2} \Delta<\infty$, where $\gamma_{\Delta}^{\star}>0$ is the unique root to the following equation

$$
\begin{equation*}
-2 a=\frac{1-e^{-\gamma_{\Delta}^{\star} \Delta}}{\Delta}+\epsilon_{\Delta}+\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)\left(2 b^{2}+\epsilon_{\Delta}\right) e^{\gamma^{\star} \tau} . \tag{6.19}
\end{equation*}
$$

Numerically, if we set

$$
\hat{\delta}=0.05, \quad \tau=0.1, \quad a=-3, \quad b=1, \quad c=0.5, \quad \varphi(\Delta)=2 \Delta^{-1 / 4},
$$

then

$$
\left(\left\lfloor(1-\hat{\delta})^{-1}\right\rfloor+1\right)=2, \quad \gamma^{\star}=1.3992, \quad \bar{L}=5, \quad \bar{L}_{R}=\left(3 R^{2}+1\right), \quad \epsilon_{\Delta}=20 \Delta+32 \Delta^{1 / 2}
$$

and solving (5.16) gives $\Delta^{\star}=4.2308 \times 10^{-4}$. Computational results for $\epsilon_{\Delta}$ and $\gamma_{\Delta}^{\star}$ with different step sizes $\Delta$ are shown in Table 7 Fig illustrates a simple path of the truncated EM solution $Y_{\Delta}(t)$ with with step size $\Delta=10^{-4}$ and $\delta(t)=0.05-0.05 \sin (t)$.

## 7. Conclusion

In this paper, we mainly study the strong convergence and stability of truncated EM scheme for SDDEs with variable delay. The results show that our method has a better convergence order
than those of the existing literature on the truncated EM for SDDEs under more relaxing conditions. Numerical simulations are provided to show the effectiveness of the theoretical results. In by Lévy process where all the three coefficients can grow super-linearly .
