## Characterizations of weighted core inverse in rings with involution

#### Abstract

R\) is a unital ring with involution. We investigate the characterizations and representations of weighted core inverse of an element in $R$ by idempotents and units. For example, let $a \in R$ and $e \in R$ be an invertible Hermitian element, $n \geqslant 1$, then $a$ is $e$-core invertible if and only if there exists an element (or an idempotent) $p$ such that $(e p)^{*}=e p, p a=0$ and $a^{n}+p\left(\right.$ or $\left.a^{n}(1-p)+p\right)$ is invertible. As a consequence, let $e, f \in R$ be two invertible Hermitian elements, then $a$ is weighted-EP with respect to $(e, f)$ if and only if there exists an element (or an idempotent) $p$ such that $(e p)^{*}=e p,(f p)^{*}=f p$, $p a=a p=0$ and $a^{n}+p$ (or $\left.a^{n}(1-p)+p\right)$ is invertible. These results generalize and improve conclusions in [14.

## 1 Introduction

Let $R$ be a unital ring. An involution $*$ in $R$ is an anti-isomorphism of degree 2 in $R$, that is to say, $\left(a^{*}\right)^{*}=a,(a+b)^{*}=a^{*}+b^{*}$ and $(a b)^{*}=b^{*} a^{*}$ for all $a, b \in R$. An element $a \in R$ is Hermitian if and only if $a^{*}=a$. And $a \in R$ is called an idempotent if $a^{2}=a$. A Hermitian idempotent is said to be a projection.

Let $e, f \in R$ be two invertible Hermitian elements. We say that $a \in R$ has a weighted Moore-Penrose inverse with weights $e, f$ if there exists an $x$ satisfying the following four equations (see for example, [1] 3):

\text { (1) } a x a=a,(2) x a x=x,(3 e)(e a x)^{*}=a x,(4 f)(f x a)^{*}=x a \text {. }
$$

If such an $x$ exists, then it is called a weighted Moore-Penrose inverse of $a$, it is unique and denoted by $a_{e, f}^{\dagger}$. If $e=f=1$, then $a_{e, f}^{\dagger}=a^{\dagger}$ is the ordinary Moore-Penrose inverse of $a$. The sets of all Moore-Penrose invertible elements and weighted Moore-Penrose invertible elements with weights $e, f$ are denoted by the symbols $R^{\dagger}$ and $R_{e, f}^{\dagger}$, respectively.

If $x$ satisfies the equations (1) and (3e), then $x$ is called a $\{1,3 e\}$-inverse of $a$ and denoted by $a^{(1,3 e)}$, and a $\{1,4 f\}$-inverse of $a$ can be similarly defined. The symbols $a\{1,3 e\}$ and $a\{1,4 f\}$ denote the sets of all $\{1,3 e\}$-inverses and $\{1,4 f\}$-inverses of $a$, respectively. An element $a \in R$ is group invertible if there is an $x \in R$ satifying

$$
\text { (1) } a x a=a, \quad \text { (2) } x a x=x, \quad \text { (5) } a x=x a \text {. }
$$

Such an $x$ is the group inverse of $a$, and it is unique if it exists and denoted by $a^{\#}$. The sets of all group invertible, invertible, $\{1,3 e\}$-invertible and $\{1,4 f\}$-invertible elements in $R$ are denoted by the symbols $R^{\#}, R^{-1}, R^{(1,3 e)}$ and $R^{(1,4 f)}$, respectively.

Mosić et al. 44 give introduced the definitions of the $e$-core inverse and the $f$-dual core inverse, which extended the concepts of the core inverse and the dual core inverse

[^0](see [5-7]). The element $a \in R$ has a weighted core inverse with weight $e$ (or $e$-core inverse), if there exists $x \in R$ such that
$$
a x a=a, \quad x R=a R, \quad R x=R a^{*} e
$$

If such an $x$ exists, then it is called a $e$-core inverse of $a$, it is unique and denoted by $a^{e, \oplus}$. The element $a \in R$ has a weighted dual core inverse with weight $f$ (or $f$-dual core inverse), if there exists $x \in R$ such that

$$
a x a=a, \quad f x R=a^{*} R, \quad R x=R a
$$

If such an $x$ exists, then it is called a $f$-core inverse of $a$, it is unique and denoted by $a_{f, \oplus}$. If $e=1$ (resp., $f=1$ ), then $a^{e, 円}=a^{\oplus}$ (resp., $a_{f, \oplus}=a_{\oplus}$ ) is the ordinary core inverse (resp., dual core inverse) of $a$. The sets of all $e$-core invertible elements and $f$-dual core invertible elements in $R$ are denoted by the symbols $R^{e, \oplus}$ and $R_{f, \oplus}$, respectively. In addition, they defined that an element $a \in R$ is weighted-EP with respect to $(e, f)$ if $a \in R^{\#} \cap R_{e, f}^{\dagger}$ and $a^{\#}=a_{e, f}^{\dagger}$. When $e=f=1$, it is the ordinary EP element.

In this paper, we investigate the characterizations of $e$-core inverse, $f$-dual core inverse, right $e$-core inverse and weighted-EP with respect to $(e, f)$ in a ring with involution. These results will generalize and improve conclusions in [14.

We will also use the following notations: $a R=\{a x \mid x \in R\}, R a=\{x a \mid x \in R\}$, ${ }^{\circ} a=\{x \in R \mid x a=0\}, a^{\circ}=\{x \in R \mid a x=0\}$.

Some auxiliary lemmas and results are presented for the further reference.
Lemma 1.1. [8, Proposition 7] Let $a \in R . a \in R^{\#}$ if and only if $a=a^{2} x=y a^{2}$ for some $x, y \in R$. In this case, $a^{\#}=y a x=y^{2} a=a x^{2}$.

Lemma 1.2. [9, 10] Let $a, b \in R .1+a b$ is invertible if and only if $1+b a$ is invertible.
Lemma 1.3. [11, Proposition 2.1 and 2.2] Let $a \in R$ and let $e \in R$ be an invertible Hermitian element. We have the following results:
(i) $a$ is $\{1,3 e\}$-invertible if and only if $a \in R a^{*}$ ea. Moreover, if $a=x a^{*}$ ea for some $x \in R$, then $x^{*} e \in a\{1,3 e\}$;
(ii) $a$ is $\{1,4 f\}$-invertible if and only if $a \in a f^{1} a^{*} R$. Moreover, if $a=a f^{1} a^{*} y$ for some $y \in R$, then $f^{-1} y^{*} \in a\{1,4 f\}$.

Lemma 1.4. [4, Theorem 2.1 and 2.2] Let $a \in R$ and let $e, f \in R$ be two invertible Hermitian elements. Then
(I) The following statements are equivalent:
(i) $a \in R^{e, \oplus}$;
(ii) there exists $x \in R$ such that

$$
\text { (1) } a x a=a,(2) x a x=x,(3 e)(e a x)^{*}=e a x, \text { (6) } x a^{2}=a, \text { (7) } a x^{2}=x
$$

(iii) there exists $x \in R$ such that

$$
(3 e)(e a x)^{*}=e a x,(6) x a^{2}=a, \text { (7) } a x^{2}=x
$$

(iv) $a \in R^{\#} \cap R^{(1,3 e)}$.

In this case,

$$
a^{e, \oplus}=x=a^{\#} a a^{(1,3 e)} .
$$

(II) The following statements are equivalent:
(i) $a \in R_{f, \oplus}$;
(ii) there exists $x \in R$ such that

$$
\text { (1) } a x a=a \text {, (2) } x a x=x,(4 f)(f x a)^{*}=f x a \text {, (8) } a^{2} x=a \text {, (9) } x^{2} a=x \text {; }
$$

(iii) there exists $x \in R$ such that

$$
(4 f)(f x a)^{*}=f x a, \text { (8) } a^{2} x=a, \text { (9) } x^{2} a=x \text {; }
$$

(iv) $a \in R^{\#} \cap R^{(1,4 f)}$.

In this case,

$$
a_{f, \circledast}=x=a^{(1,4 f)} a a^{\#} .
$$

Lemma 1.5. [13] Let $a \in R$ and let $e \in R$ be an invertible Hermitian element, $n \geqslant 2$. Then the following statements are equivalent:
(i) $a \in R a^{*} e a \cap a^{n} R$;
(ii) $a \in R\left(a^{*}\right)^{n} e a$.

## 2 Main results

In this section, we present some new equivalent conditions for the existences of core inverses.

Theorem 2.1. Let $a \in R$ and let $e \in R$ be an invertible Hermitian element, $n \geqslant 2$. We have the following results:
(i) $a \in R^{e, 巴}$ if and only if $a \in R\left(a^{*}\right)^{n} e a \cap R a^{n}$. If $a=s\left(a^{*}\right)^{n}$ ea for some $s \in R$, then $a^{e, \oplus}=a^{n-1} s^{*} e$;
(ii) $a \in R_{f, \oplus}$ if and only if $a \in a f^{-1}\left(a^{*}\right)^{n} R \cap a^{n} R$. If $a=a f^{-1}\left(a^{*}\right)^{n} t$ for some $t \in R$, then $a_{f, \oplus}=f^{-1} t^{*} a^{n-1}$.
Proof. ( $i$ ). According to Lemma 1.1, it is easy to deduce that $a \in R^{\#}$ if and only if $a \in a^{n} R \cap R a^{n}$ for $n \geqslant 2$. From Lemma 1.5 we know that $a \in R\left(a^{*}\right)^{n} e a$ if and only if $a \in R a^{*} e a \cap a^{n} R$, thus

$$
\begin{aligned}
a \in R^{e, \oplus} & \stackrel{\text { Lemma 1.4) }}{\Longrightarrow} a \in R^{(1,3 e)} \cap R^{\#} \\
& \Longleftrightarrow \Longleftrightarrow \text { Lemma 1.3) } \\
& \Longleftrightarrow \in a^{*} e a \cap R^{\#} \\
& \Longleftrightarrow a \in R a^{*} e a \cap a^{n} R \cap R a^{n} \\
& \Longleftrightarrow a \in R\left(a^{*}\right)^{n} e a \cap R a^{n} .
\end{aligned}
$$

Next, we give the representation of $a^{e, \oplus}$. Since $a \in R\left(a^{*}\right)^{n} e a \cap R a^{n}$, there exists $s \in R$ such that $a=s\left(a^{*}\right)^{n} e a$. By Lemma 1.3, we have

$$
\left(s\left(a^{*}\right)^{n-1}\right)^{*} e=a^{n-1} s^{*} e \in a\{1,3 e\} .
$$

Using Lemma 1.4, we obtain

$$
a^{e, \oplus}=a^{\#} a a^{(1,3 e)}=a^{\#} a\left(a^{n-1} s^{*} e\right)=a^{n-1} s^{*} e .
$$

(ii). Similarly as (i).

From the above proof, it is easy to see that Theorem [2.1] is also true in a semigroup. Next we characterize the existence of $e$-core inverse by idempotents and units.

Theorem 2.2. Let $a \in R$ and let $e \in R$ be an invertible Hermitian element, $n \geqslant 1$ is a positive integer. The following statements are equivalent:
(i) $a \in R^{e, \oplus}$;
(ii) there exists a unique idempotent $p$ such that $(e p)^{*}=e p, p a=0, u=a^{n}+p \in R^{-1}$;
(iii) there exists an element $s$ such that $(e s)^{*}=e s, s a=0, v=a^{n}+s \in R^{-1}$;
(iv) there exists a unique idempotent $q$ such that $(e q)^{*}=e q, q a=0, w=a^{n}(1-q)+q \in$ $R^{-1}$;
(v) there exists an element $t$ such that $(e t)^{*}=e t, t a=0, z=a^{n}(1-t)+t \in R^{-1}$. In this case, when $n=1$,

$$
a^{e, \oplus}=u^{-1}(1-p)=v^{-1} a v^{-1}=(1-q) w^{-1}=z^{-1} a(1-t) z^{-1},
$$

when $n \geqslant 2$,

$$
a^{e, \oplus}=a^{n-1} u^{-1}=a^{n-1} v^{-1}=a^{n-1}(1-q) w^{-1}=a^{n-1}(1-t) z^{-1} .
$$

Proof. $(i) \Rightarrow(i i)$. Set $p=1-a a^{e, \oplus}$, we observe first that $p$ is an idempotent satisfying $(e p)^{*}=e p$ and $p a=0$. Next we show that $u=a^{n}+p=a^{n}+1-a a^{e, \oplus} \in R^{-1}$.

When $n=1$, it is easy to verify

$$
\left(a+1-a a^{e, \oplus}\right)\left(a^{e, \oplus}+1-a^{e, \oplus} a\right)=1=\left(a^{e, \oplus}+1-a^{e, \oplus} a\right)\left(a+1-a a^{e, \oplus}\right),
$$

thus $u=a+1-a a^{e,} \notin \in R^{-1}$.
When $n \geqslant 2$, we prove the invertibility of $u$ by induction on $n$. Since $1+a a^{e,} \not \Perp(a-1)=$ $a+1-a a^{e, \oplus} \in R^{-1}$, from Lemma 1.2 we obtain that $a^{2} a^{e, \oplus}+1-a a^{e, \oplus}=1+(a-1) a a^{e, \oplus} \in$
 that $n>2$ and $a^{n-1}+1-a a^{e, \oplus} \in R^{-1}$, then $a^{n}+1-a a^{e, \oplus}=\left(a^{2} a^{e, \oplus}+1-a a^{e, \oplus}\right)\left(a^{n-1}+\right.$ $\left.1-a a^{e, \oplus}\right)$ is invertible.

Finally, we prove the uniqueness of the idempotent $p$. It is necessary to show that ${ }^{\circ}\left(a^{n}\right)={ }^{\circ}(1-p)$. If $x a^{n}=0$, then

$$
0=x a^{n}=x(1-p) a^{n}=x(1-p)\left(a^{n}+p\right)
$$

Since $a^{n}+p \in R^{-1}$, we have $x(1-p)=0$. Conversely, if $y(1-p)=0$, then $y a^{n}=$ $y(1-p) a^{n}=0$. Thus ${ }^{\circ}\left(a^{n}\right)={ }^{\circ}(1-p)$. Assume that $p, p_{1}$ are both idempotents which satisfy the statement $(i i)$, then ${ }^{\circ}(1-p)={ }^{\circ}\left(a^{n}\right)={ }^{\circ}\left(1-p_{1}\right)$. By $p \in{ }^{\circ}(1-p)={ }^{\circ}\left(1-p_{1}\right)$, we obtain $p=p p_{1}$. Similarly, we can get $p_{1}=p_{1} p$ from $p_{1} \in^{\circ}\left(1-p_{1}\right)={ }^{\circ}(1-p)$. Then

$$
e p=(e p)^{*}=\left(e p p_{1}\right)^{*}=\left(e p e^{-1} e p_{1}\right)^{*}=\left(e p_{1}\right)^{*}\left(e^{-1}\right)^{*}(e p)^{*}=e p_{1} e^{-1} e p=e p_{1} p=e p_{1},
$$

thus $p=p_{1}$.
$(i i) \Rightarrow(i)$. Suppose that there exists a unique idempotent $p$ such that $(e p)^{*}=e p$, $p a=0, u=a^{n}+p \in R^{-1}$.

When $n=1$, set $x=u^{-1}(1-p)$. Now we prove that $x$ is the $e$-core inverse of $a$. Since $(1-p) u=a, u a^{2}=a$ and $p u=p$, we obtain

$$
\begin{gather*}
1-p=a u^{-1}  \tag{2.1}\\
a=u^{-1} a^{2} \tag{2.2}
\end{gather*}
$$

$$
\begin{equation*}
(1-p) u^{-1}=u^{-1}-p \tag{2.3}
\end{equation*}
$$

Therefore,

$$
\begin{gathered}
e a x=e a u^{-1}(1-p) \stackrel{2.1}{=} e(1-p)(1-p)=e-e p \text { is Hermitian, } \\
x a^{2}=u^{-1}(1-p) a^{2}=u^{-1} a^{2} \stackrel{\sqrt{2.2}}{=} a \\
a x^{2}=a u^{-1}(1-p) u^{-1}(1-p) \stackrel{(2.1}{=}(1-p) u^{-1}(1-p) \\
\stackrel{2.3}{=}\left(u^{-1}-p\right)(1-p)=u^{-1}(1-p)=x
\end{gathered}
$$

As a consequence, $a \in R^{e, \circledast}$ with $a^{e, \oplus}=u^{-1}(1-p)$ by Lemma 1.4.
When $n \geqslant 2$, from $u=a^{n}+p \in R^{-1}$ and $p^{*}=\left(e^{-1} e p\right)^{*}=e p e^{-1}$, we get $u^{*}=$ $\left(a^{*}\right)^{n}+e p e^{-1} \in R^{-1}$. Since $u a=a^{n+1}$ and $u^{*} e a=\left(a^{*}\right)^{n} e a$,

$$
a=u^{-1} a^{n+1} \in R a^{n}
$$

and

$$
a=\left(u^{*} e\right)^{-1}\left(a^{*}\right)^{n} e a \in R\left(a^{*}\right)^{n} e a
$$

Thus $a \in R\left(a^{*}\right)^{n} e a \cap R a^{n}$, and then $a \in R^{e, \oplus}$ and $a^{e, \oplus}=a^{n-1}(e u)^{-1} e=a^{n-1} u^{-1}$ by Theorem 2.1.
$(i i) \Rightarrow(i i i)$ is trivial.
$(i i i) \Rightarrow(i)$. Assume that there exists an element $s$ such that $(e s)^{*}=e s, s a=0$, $v=a^{n}+s \in R^{-1}$.

When $n=1$. Since $v=a^{n}+s \in R^{-1}$ and

$$
\begin{equation*}
s^{*}=\left(e^{-1} e s\right)^{*}=e s e^{-1} \tag{2.4}
\end{equation*}
$$

we get $v^{*}=a^{*}+e s e^{-1} \in R^{-1}$. From $v a=a^{2}$ and $v^{*} e a=a^{*} e a$ we obtain

$$
\begin{equation*}
a=v^{-1} a^{2} \in R a^{2} \tag{2.5}
\end{equation*}
$$

and

$$
\begin{equation*}
a=\left(v^{*} e\right)^{-1} a^{*} e a \in R a^{*} e a \tag{2.6}
\end{equation*}
$$

It remains to show that $a \in a^{2} R$. By Lemma 1.3, the equation (2.6) shows that $a \in R^{(1,3 e)}$ with $v^{-1} \in a\{1,3 e\}$. Hence

$$
\begin{equation*}
a=a a^{(1,3 e)} a=a v^{-1} a \tag{2.7}
\end{equation*}
$$

In addtion, $s v=s^{2}$ leads to $s=s^{2} v^{-1}$, thus

$$
\begin{gather*}
e s^{2} v^{-1}=e s=(e s)^{*}=\left(e s^{2} v^{-1}\right)^{*}=\left(v^{*}\right)^{-1} s^{*} e s \\
\stackrel{2.4}{=}\left(v^{*}\right)^{-1} e s e^{-1} e s=\left(v^{*}\right)^{-1} e s^{2} \tag{2.8}
\end{gather*}
$$

Moreover,

$$
\begin{align*}
e s v^{-2} & \stackrel{2.8}{=}\left[\left(v^{*}\right)^{-1} e s^{2}\right] v^{-2}=\left(v^{*}\right)^{-1}\left(e s^{2} v^{-1}\right) v^{-1}  \tag{2.9}\\
& \stackrel{2.8}{=}\left(v^{*}\right)^{-1}\left[\left(v^{*}\right)^{-1} e s^{2}\right] v^{-1}=\left(v^{*}\right)^{-2} e s^{2} v^{-1} \stackrel{2.8}{=}\left(v^{*}\right)^{-2} e s,
\end{align*}
$$

thus

$$
\begin{equation*}
e v^{-1}=e v v^{-2}=e(a+s) v^{-2}=e a v^{-2}+e s v^{-2} \stackrel{(2.9}{=} e a v^{-2}+\left(v^{*}\right)^{-2} e s . \tag{2.10}
\end{equation*}
$$

Therefore,

a \stackrel{\boxed{2.7}}{=} a v^{-1} a=a e^{-1}\left(e v^{-1}\right) a \stackrel{\sqrt{2.10}}{=} a e^{-1}\left[e a v^{-2}+\left(v^{*}\right)^{-2} e s\right] a=a^{2} v^{-2} a \in a^{2} R \tag{2.11}
\end{equation*}
$$

According to Lemma 1.1, equations (2.5) and (2.11) show that $a \in R^{\#}$ with $a^{\#}=v^{-2} a$. And from (2.6) and Lemma 1.4, $a \in R^{e, \oplus}$ with

$$
a^{e, \oplus}=a^{\#} a a^{(1,3 e)}=v^{-2} a a v^{-1} \stackrel{(2.5)}{=} v^{-1} a v^{-1} .
$$

When $n \geqslant 2$, from $v=a^{n}+s \in R^{-1}$ and $s^{*}=e s e^{-1}$, we get $v^{*}=\left(a^{*}\right)^{n}+e s e^{-1} \in R^{-1}$. Since $v a=a^{n+1}$ and $v^{*} e a=\left(a^{*}\right)^{n} e a$,

$$
a=v^{-1} a^{n+1} \in R a^{n}
$$

and

$$
a=\left(v^{*} e\right)^{-1}\left(a^{*}\right)^{n} e a \in R\left(a^{*}\right)^{n} e a .
$$

Thus $a \in R\left(a^{*}\right)^{n} e a \cap R a^{n}$, and then $a \in R^{e, \oplus}$ and $a^{e, \oplus}=a^{n-1}(e v)^{-1} e=a^{n-1} v^{-1}$ by Theorem 2.1,
$(i) \Rightarrow(i v)$. Set $q=1-a a^{e,} \not \otimes$, then $q$ is an idempotent satisfying $(e q)^{*}=e q$ and $q a=0$. Now we prove that $w=a^{n}(1-q)+q=a^{n+1} a^{e,} \not \Perp+1-a a^{e, \oplus} \in R^{-1}$.

When $n=1$, from the proof of $(i) \Rightarrow(i i)$ we know that $1+a a^{e,} \not\left((a-1)=a+1-a a^{e,} \notin \in\right.$ $R^{-1}$, thus $w=a^{2} a^{e, \oplus}+1-a a^{e, \oplus}=1+(a-1) a a^{e, \oplus} \in R^{-1}$ by the Lemma 1.2,

When $n \geqslant 2$, from the proof of $(i) \Rightarrow(i i)$ we know that $1+a a^{e,} \oplus\left(a^{n}-1\right)=a^{n}+1-$ $a a^{e, \oplus} \in R^{-1}$, thus $w=a^{n+1} a^{e, \oplus}+1-a a^{e, \oplus}=1+\left(a^{n}-1\right) a a^{e, \oplus} \in R^{-1}$ by the Lemma 1.2,

In the end, we prove the uniqueness of the idempotent $q$. It is necessary to show that ${ }^{\circ}\left(a^{n}\right)={ }^{\circ}(1-q)$. If $x a^{n}=0$, then

$$
0=x a^{n}(1-q)=x(1-q)\left[a^{n}(1-q)+q\right] .
$$

From $a^{n}(1-q)+q \in R^{-1}$ we have $x(1-q)=0$. Conversely, if $y(1-q)=0$, then $y a^{n}=y(1-q) a^{n}=0$. Hence ${ }^{\circ}\left(a^{n}\right)={ }^{\circ}(1-q)$. Suppose that $q, q_{1}$ are both idempotents which satisfy the statement (iv), then ${ }^{\circ}(1-q)={ }^{\circ}\left(a^{n}\right)={ }^{\circ}\left(1-q_{1}\right)$. From $q{ }^{\circ}(1-q)=$ ${ }^{\circ}\left(1-q_{1}\right)$ we obtain $q=q q_{1}$. Similarly, $q \in{ }^{\circ}\left(1-q_{1}\right)={ }^{\circ}(1-q)$ leads to $q_{1}=q_{1} q$. Then

$$
e q=(e q)^{*}=\left(e q q_{1}\right)^{*}=\left(e q e^{-1} e q_{1}\right)^{*}=\left(e q_{1}\right)^{*}\left(e^{-1}\right)^{*}(e q)^{*}=e q_{1} e^{-1} e q=e q_{1} q=e q_{1},
$$

thus $q=q_{1}$.
$(i v) \Rightarrow(i)$. Assume that there exists a unique idempotent $q$ such that $(e q)^{*}=e q$, $q a=0, w=a^{n}(1-q)+q \in R^{-1}$.

When $n=1$, let $x=(1-q) w^{-1}$. Now we show that $x$ is the $e$-core inverse of $a$. Since $(1-q) w=a(1-q)$ and $w a^{2}=a$, we get

$$
\begin{gather*}
1-q=a(1-q) w^{-1}  \tag{2.12}\\
a=w^{-1} a^{2} \tag{2.13}
\end{gather*}
$$

Therefore,

$$
\begin{gathered}
e a x=e a(1-q) w^{-1} \stackrel{2.12}{=} e(1-q)=e-e q \text { is Hermitian, } \\
x a^{2}=(1-q) w^{-1} a^{2} \stackrel{\sqrt{2.13}}{=}(1-q) a=a \\
a x^{2}=a(1-q) w^{-1}(1-q) w^{-1} \frac{2.12}{=}(1-q) w^{-1}=x
\end{gathered}
$$

As a consequence, $a \in R^{e, \oplus}$ with $a^{e, \oplus}=(1-q) w^{-1}$ by Lemma 1.4.
When $n \geqslant 2$, from $w=a^{n}(1-q)+q \in R^{-1}$ and $q^{*}=\left(e^{-1} e q\right)^{*}=e q e^{-1}$, we get $w^{*}=(1-p)^{*}\left(a^{*}\right)^{n}+e q e^{-1} \in R^{-1}$. Since $w a=a^{n+1}$ and $w^{*} e a=(1-q)^{*}\left(a^{*}\right)^{n} e a$,

$$
a=w^{-1} a^{n+1} \in R a^{n}
$$

and

$$
a=\left(w^{*} e\right)^{-1}(1-q)^{*}\left(a^{*}\right)^{n} e a \in R\left(a^{*}\right)^{n} e a
$$

Therefore, $a \in R\left(a^{*}\right)^{n} e a \cap R a^{n}$, and then $a \in R^{e, 巴}$ and $a^{e, 巴}=a^{n-1}(1-q)(e w)^{-1} e=$ $a^{n-1}(1-q) w^{-1}$ by Theorem 2.1.
$(i v) \Rightarrow(v)$ is trivial.
$(v) \Rightarrow(i)$. Assume that there exists an element $t$ such that $(e t)^{*}=e t, t a=0, z=$ $a^{n}(1-t)+t \in R^{-1}$.

When $n=1$. Since $z=a^{n}(1-t)+t \in R^{-1}$ and

$$
\begin{equation*}
t^{*}=\left(e^{-1} e t\right)^{*}=e t e^{-1} \tag{2.14}
\end{equation*}
$$

we get $z^{*}=(1-t)^{*} a^{*}+e s e^{-1} \in R^{-1}$. From $z a=a^{2}$ and $z^{*} e a=(1-t)^{*} a^{*} e a$ we obtain

a=z^{-1} a^{2} \in R a^{2} \tag{2.15}
\end{equation*}
$$

and

$$
\begin{equation*}
a=\left(z^{*} e\right)^{-1}(1-t)^{*} a^{*} e a \in R a^{*} e a \tag{2.16}
\end{equation*}
$$

It remains to show that $a \in a^{2} R$. By Lemma 1.3, the equation (2.16) shows that $a \in R^{(1,3 e)}$ with $(1-t) z^{-1} \in a\{1,3 e\}$. Hence

$$
\begin{equation*}
a=a a^{(1,3 e)} a=a(1-t) z^{-1} a \tag{2.17}
\end{equation*}
$$

In addtion, $t z=t^{2}$ leads to $t=t^{2} z^{-1}$, thus

$$
\begin{gather*}
e t^{2} z^{-1}=e t=(e t)^{*}=\left(e t^{2} z^{-1}\right)^{*}=\left(z^{*}\right)^{-1} t^{*} e t \\
\stackrel{2.14}{=}\left(z^{*}\right)^{-1} e t e^{-1} e t=\left(z^{*}\right)^{-1} e t^{2} . \tag{2.18}
\end{gather*}
$$

Moreover,

$$
\begin{align*}
e t z^{-2} & \stackrel{2.18}{=}\left[\left(z^{*}\right)^{-1} e t^{2}\right] z^{-2}=\left(z^{*}\right)^{-1}\left(e t^{2} z^{-1}\right) z^{-1}  \tag{2.19}\\
& \stackrel{2.18}{=}\left(z^{*}\right)^{-1}\left[\left(z^{*}\right)^{-1} e t^{2}\right] z^{-1}=\left(z^{*}\right)^{-2} e t^{2} z^{-1} \stackrel{2.18}{=}\left(z^{*}\right)^{-2} e t,
\end{align*}
$$

thus

$$
\begin{gather*}
e z^{-1}=e z z^{-2}=e[a(1-t)+t] z^{-2}=e a(1-t) z^{-2}+e t z^{-2} \\
\stackrel{(2.19}{=} e a(1-t) z^{-2}+\left(z^{*}\right)^{-2} e t . \tag{2.20}
\end{gather*}
$$

Therefore,

$$
\begin{align*}
& a \stackrel{2.17}{=} a(1-t) z^{-1} a=a(1-t) e^{-1}\left(e z^{-1}\right) a \\
& \stackrel{2.20}{=} a(1-t) e^{-1}\left[e a(1-t) z^{-2}+\left(z^{*}\right)^{-2} e t\right] a  \tag{2.21}\\
& \quad=a^{2}(1-t) z^{-2} a \in a^{2} R .
\end{align*}
$$

According to Lemma 1.1, equations (2.15) and (2.21) show that $a \in R^{\#}$ with $a^{\#}=z^{-2} a$. And from (2.16) and Lemma 1.4 deducing that $a \in R^{e, \oplus}$ with

$$
a^{e, \oplus}=a^{\#} a a^{(1,3 e)}=z^{-2} a a(1-t) z^{-1} \stackrel{\sqrt{2.15}}{=} z^{-1} a(1-t) z^{-1} .
$$

When $n \geqslant 2$, from $z=a^{n}(1-t)+t \in R^{-1}$ and $t^{*}=e t e^{-1}$ we get $z^{*}=(1-t)^{*}\left(a^{*}\right)^{n}+$ ete $e^{-1} \in R^{-1}$. Since $z a=a^{n+1}$ and $z^{*} e a=(1-t)^{*}\left(a^{*}\right)^{n} e a$,

$$
a=z^{-1} a^{n+1} \in R a^{n}
$$

and

$$
a=\left(z^{*} e\right)^{-1}(1-t)^{*}\left(a^{*}\right)^{n} e a \in R\left(a^{*}\right)^{n} e a .
$$

Thus $a \in R\left(a^{*}\right)^{n} e a \cap R a^{n}$, and then $a \in R^{e, \circledast}$ and $a^{e, \oplus}=a^{n-1}(1-t)(e v)^{-1} e=a^{n-1}(1-$ t) $v^{-1}$ by Theorem 2.1.

When $e=1$, we get the following result, which improves Theorem 3.3 and Theorem 3.4 in 14.

Corollary 2.3. Let $a \in R, n \geqslant 1$ is a positive integer. The following statements are equivalent:
(i) $a \in R^{\oplus}$;
(ii) there exists a unique projection $p$ such that $p a=0, u=a^{n}+p \in R^{-1}$;
(iii) there exists a Hermitian element $s$ such that sa=0, $v=a^{n}+s \in R^{-1}$;
(iv) there exists a unique projection $q$ such that $q a=0, w=a^{n}(1-q)+q \in R^{-1}$;
$(v)$ there exists a Hermitian element $t$ such that $t a=0, z=a^{n}(1-t)+t \in R^{-1}$. In this case, when $n=1$,

$$
a^{\oplus}=u^{-1}(1-p)=v^{-1} a v^{-1}=(1-q) w^{-1}=z^{-1} a(1-t) z^{-1}
$$

when $n \geqslant 2$,

$$
a^{\oplus}=a^{n-1} u^{-1}=a^{n-1} v^{-1}=a^{n-1}(1-q) w^{-1}=a^{n-1}(1-t) z^{-1}
$$

There is an analogous result for the $f$-dual core inverse of $a \in R$, we omit its proof.
Theorem 2.4. Let $a \in R$ and let $f \in R$ be an invertible Hermitian element, $n \geqslant 1$ is a positive integer. The following statements are equivalent:
(i) $a \in R_{f, \oplus}$;
(ii) there exists a unique idempotent $p$ such that $(f p)^{*}=f p, a p=0, u=a^{n}+p \in R^{-1}$;
(iii) there exists an element $s$ such that $(f s)^{*}=f s$, as $=0, v=a^{n}+s \in R^{-1}$;
(iv) there exists a unique idempotent $q$ such that $(f q)^{*}=f q, a q=0, w=(1-q) a^{n}+q \in$ $R^{-1}$;
$(v)$ there exists an element $t$ such that $(f t)^{*}=f t$, at $=0, z=(1-t) a^{n}+t \in R^{-1}$.
In this case, when $n=1$,

$$
a_{f, 巴}=(1-p) u^{-1}=v^{-1} a v^{-1}=w^{-1}(1-q)=z^{-1}(1-t) a z^{-1}
$$

when $n \geqslant 2$,

$$
a_{f, \notin}=u^{-1} a^{n-1}=v^{-1} a^{n-1}=(1-q) a^{n-1} w^{-1}=(1-t) a^{n-1} z^{-1}
$$

When $f=1$, we get the following result.
Corollary 2.5. Let $a \in R, n \geqslant 1$ is a positive integer. The following statements are equivalent:
(i) $a \in R_{\oplus}$;
(ii) there exists a unique projection $p$ such that ap $=0, u=a^{n}+p \in R^{-1}$;
(iii) there exists a Hermitian element $s$ such that as $=0, v=a^{n}+s \in R^{-1}$;
(iv) there exists a unique projection $q$ such that $a q=0, w=(1-q) a^{n}+q \in R^{-1}$;
(v) there exists a Hermitian element $t$ such that at $=0, z=(1-t) a^{n}+t \in R^{-1}$.

In this case, when $n=1$,

$$
a_{\#}=(1-p) u^{-1}=v^{-1} a v^{-1}=w^{-1}(1-q)=z^{-1}(1-t) a z^{-1}
$$

when $n \geqslant 2$,

$$
a_{\circledast}=u^{-1} a^{n-1}=v^{-1} a^{n-1}=(1-q) a^{n-1} w^{-1}=(1-t) a^{n-1} z^{-1}
$$

In the derivation of $(i)$ from (ii) of Theorem 2.2, when $n=1, a^{\boxplus}=u^{-1}(1-p)$. From the equation (2.1) (i.e., $1-p=a u^{-1}$ ) we know that $e(1-p)=e a u^{-1}$ is Hermitian, thus

$$
\begin{aligned}
a^{\oplus} & =u^{-1}(1-p)=u^{-1} a u^{-1}=u^{-1} e^{-1} e a u^{-1}=u^{-1} e^{-1}\left(e a u^{-1}\right)^{*} \\
& =\left(u^{*} e u\right)^{-1} a^{*} e=\left(a^{*} e a+e p\right)^{-1} a^{*} e
\end{aligned}
$$

Through this expression, we naturally want to know whether $a$ is $e$-core invertible or not when there is a unique idempotent $p$ such that $(e p)^{*}=e p, p a=0, a^{*} e a+e p \in R^{-1}$. However, it is not true. Here is a counterexample.

Example 2.6. Let $R$ be an infinite matrix ring over complex filed whose rows and columns are both finite, let conjugate transpose be the involution and $a=\sum_{i=1}^{\infty} e_{i+1, i}$. Then $a^{*} a=1$, $a a^{*}=\sum_{i=2}^{\infty} e_{i, i}$. Set $e=1, p=0$, then $p$ is an idempotent satisfying $(e p)^{*}=e p, p a=0$ and $a^{*} e a+e p=1 \in R^{-1}$. But $a$ is not group invertible, thus $a$ is not $e$-core invertible.

The above counterexample shows that even if there is a unique idempotent $p$ such that $(e p)^{*}=e p, p a=0$ and $a^{*} e a+e p \in R^{-1}, a$ is not necessary to be $e$-core invertible in general rings. However, it is true when we take $R$ as a Dedekind-finite ring which satisfies the property that $a b=1$ implies $b a=1$ for any $a, b \in R$. Let $R_{r}^{-1}$ and $R_{l}^{-1}$ denote all right invertible and left invertible elements in $R$, respectively. See the following result.

Theorem 2.7. Let $R$ be a Dedekind-finite ring and $a \in R, e \in R$ is an invertible Hermitian element. Then the following statements are equivalent:
(i) $a \in R^{e, \oplus}$;
(ii) there exists a unique idempotent $p$ such that $(e p)^{*}=e p, p a=0, a^{*} e a+e p \in R^{-1}$;
(iii) there exists a unique idempotent $p$ such that $(e p)^{*}=e p, p a=0, a^{*} e a+e p \in R_{r}^{-1}$;
(iv) there exists a unique idempotent $p$ such that $(e p)^{*}=e p, p a=0, a^{*} e a+e p \in R_{l}^{-1}$. In this case,

$$
a^{e, \oplus}=\left(a^{*} e a+e p\right)^{-1} a^{*} e .
$$

Proof. Since $a^{*} e a+e p$ is Hermitian, $a^{*} e a+e p$ is one-sided invertible if and only if it is invertible, hence the statements (ii), (iii) and (iv) are equivalent. It is sufficient to show that $(i) \Leftrightarrow(i i)$.
(i) $\Rightarrow$ (ii). Suppose that $a \in R^{e, \oplus}$ and let $p=1-a a^{e, \oplus}$, then $a+p \in R^{-1}$ by Theorem [2.2, Moreover, $e(a+p)=e a+e p \in R^{-1}$, so $(e a+e p)^{*}=a^{*} e+e p \in R^{-1}$. Therefore $a^{*} e a+e p=\left(a^{*} e+e p\right)(a+p)$ is invertible.
(ii) $\Rightarrow(i)$. Let $u=a+p, u^{*} e u=a^{*} e a+e p \in R^{-1}$. As $R$ is a Dedekind-finite ring, thus $u \in R^{-1}$, which guarantees $a \in R^{e, \oplus}$ and $a^{e, \oplus}=\left(a^{*} e a+e p\right)^{-1} a^{*} e$ by Theorem 2.2,

There is a dual result for the $f$-dual core inverse.
Theorem 2.8. Let $R$ be a Dedekind-finite ring and $a \in R, f \in R$ is an invertible Hermitian element. Then the following statements are equivalent:
(i) $a \in R^{e, \oplus ;}$
(ii) there exists a unique idempotent $q$ such that $(f q)^{*}=f q, a q=0, a f^{-1} a^{*}+q f^{-1} \in R^{-1}$; (iii) there exists a unique idempotent $q$ such that $(f q)^{*}=f q$, $a q=0, a f^{-1} a^{*}+e q f^{-1} \in$ $R_{r}^{-1}$;
(iv) there exists a unique idempotent $q$ such that $(f q)^{*}=f q, a q=0, a f^{-1} a^{*}+q f^{-1} \in R_{l}^{-1}$. In this case,

$$
a^{e, \oplus}=f^{-1} a^{*}\left(a f^{-1} a^{*}+q f^{-1}\right)^{-1} .
$$

Let $a \in R$ and $e, f \in R$ be two invertible Hermitian elements. Zhu and Wang 11] mentioned that $a \in R^{e, \oplus} \cap R_{f, \oplus}$ if and only if $a \in R^{\#} \cap R_{e, f}^{\dagger}$. Mosić et al. [4] mentioned that $a \in R$ is weighted-EP with respect to $(e, f)$ if and only if $a \in R^{e, \oplus} \cap R_{f, \nrightarrow}$ and $a^{e, \oplus}=a_{f, \circledast}$. By Theorem 2.2 and Theorem [2.4, we obtain the following theorem.

Theorem 2.9. Let $a \in R$ and $e, f \in R$ be two invertible Hermitian elements, $n \geqslant 1$ is a positive integer. The following conditions are equivalent:
(i) $a \in R$ is weighted-EP with respect to $(e, f)$;
(ii) there exists a unique idempotent $p$ such that $(e p)^{*}=e p,(f p)^{*}=f p, a p=p a=0$, $a^{n}+p \in R^{-1}$;
(iii) there exists an elements such that $(e s)^{*}=e s,(f s)^{*}=f s, a s=s a=0, a^{n}+s \in R^{-1}$.

Proof. $(i) \Rightarrow(i i)$. Suppose $a$ is weighted-EP with respect to $(e, f)$, so $a \in R_{e, f}^{\dagger} \cap R^{\#}$ and $a_{e, f}^{\dagger}=a^{\#}$. Let $p=1-a^{\#} a=1-a_{e, f}^{\dagger} a$, it is easily seen that $p$ is an idempotent satisfying $(e p)^{*}=e p,(f p)^{*}=f p, p a=a p=0$. Since

$$
\left(a^{n}+1-a^{\#} a\right)\left(\left(a^{\#}\right)^{n}+1-a^{\#} a\right)=1=\left(\left(a^{\#}\right)^{n}+1-a^{\#} a\right)\left(a^{n}+1-a^{\#} a\right),
$$

thus $a^{n}+1-a^{\#} a$ is invertible.
(ii) $\Rightarrow($ (iii) is trivial.
(iii) $\Rightarrow(i)$. According to Theorem 2.2 and Theorem [2.4] $a \in R^{e, \oplus} \cap R_{f, \oplus}$. It remains to show that $a^{e, \oplus}=a_{f, \oplus}$. Write $v=a^{n}+s$. When $n=1$, we have $a^{e, ~} \nsupseteq=v^{-1} a v^{-1}=a_{f, \oplus}$. When $n \geqslant 2, a^{e, \oplus}=a^{n-1} v^{-1}, a_{f, \oplus}=v^{-1} a^{n-1}$. From $p a=a p=0$, we obtain $a v=v a$, thus $a v^{-1}=v^{-1} a$. Therefore, $a^{e, \oplus}=a^{n-1} u^{-1}=u^{-1} a^{n-1}=a_{f, \oplus \text {. As }}$. A consequence, $a$ is weighted-EP with respect to $(e, f)$.
