# ASYMPTOTIC ESTIMATES OF HOLOMORPHIC SECTIONS ON BOHR-SOMMERFELD LAGRANGIAN SUBMANIFOLDS

#### Abstract

Let $M$ be a complex manifold and $L$ be a line bundle over $M$ with a Hermitian metric $h$ whose Chern form is a Kähler form $\omega$. Let $X \subset M$ be a Lagrangian submanifold of $(M, \omega)$. When $X$ satisfies the Bohr-Sommerfeld condition, we give an asymptotic estimate of the norm $|f|_{h^{k}}$ on $X$ for $f \in H^{0}\left(M, L^{k}\right)$.

## 1. Introduction

Throughout this paper $M$ will be a complex manifold of dimension $n$ with a complex structure $J \in \operatorname{End}(T M)$ and $L$ will be a positive line bundle over $M$ with a Hermitian metric $h$ such that the Chern form $\omega=c_{1}(L, h)$ associated to $h$ is a Kähler form. We denote by $\nabla$ the Chern connection of $(L, h)$. We consider the $k$-th tensor power $L^{k}$ of $L$. Let $f, g$ be sections of $L^{k}$. We denote by $\langle f, g\rangle_{h^{k}}$ the pointwise scalar product and define the integral product $(f, g)_{h^{k}}=\int_{M}\langle f, g\rangle_{h^{k}} \omega_{n}$ where $\omega_{n}=\omega^{n} / n$ !. We write $|f|_{h^{k}}^{2}=\langle f, f\rangle_{h^{k}}$ and $\|f\|_{h^{k}}^{2}=(f, f)_{h^{k}}$. Let $L^{2}\left(M, L^{k}\right)$ be the Hilbert space of square integrable sections of $L^{k}$. We define $H_{(2)}^{0}\left(M, L^{k}\right)=H^{0}\left(M, L^{k}\right) \cap L^{2}\left(M, L^{k}\right)$. The Bergman kernel $K_{k}(x, y)$ of $H_{(2)}^{0}\left(M, L^{k}\right)$ is the reproducing kernel for the Hilbert space $H_{(2)}^{0}\left(M, L^{k}\right)$, that is, $f(x)=(f(\cdot), K(x, \cdot))_{h^{k}}$ for any $f \in H_{(2)}^{0}\left(M, L^{k}\right)$ and $x \in M$. It is a well known property that the Bergman kernel function $B_{k}(x)=\left|K_{k}(x, x)\right|_{h^{k}}$ is characterized by

B_{k}(x)=\sup _{f \in H_{(2)}^{0}\left(M, L^{k}\right), f \neq 0} \frac{|f(x)|_{h^{k}}^{2}}{\|f\|_{h^{k}}^{2}} .
$$

The asymptotic behavior, as $k \rightarrow+\infty$ of the Bergman kernel function is studied in detail, and the asymptotic series expansion formula of $B_{k}(x)$ is proved when $M$ is projective (see [16], [4], [20]). Berndtsson [3] gave a simple proof for the leading order term

B_{k}(x) \sim k^{n} \quad(k \rightarrow+\infty) . \tag{1}
\end{equation*}

In this paper, we estimate holomorphic sections in $H_{(2)}^{0}\left(M, L^{k}\right)$ on a Bohr-Sommerfeld Lagrangian submanifold and provide an analogue result of (1).

Let $X \subset M$ be a Lagrangian submanifold of $(M, \omega)$, that is, $X$ is a real $n$-dimensional submanifold of $M$ such that $\iota^{*} \omega=0$. Here $\iota: X \rightarrow M$ is the inclusion map. Let $\nabla^{X}$ be the connection induced by $\nabla$ on $\iota^{*} L$. Then $\left(\iota^{*} L, \nabla^{X}\right)$ is flat since $\iota^{*} \omega=0$. We say that $\left(X, \nabla^{X}\right)$ satisfies the Bohr-Sommerfeld condition if there exists a non-vanishing smooth section $\zeta \in C^{\infty}\left(X, \iota^{*} L\right)$ satisfying $\nabla^{X} \zeta=0$ (cf. [14], [17]). Hence $\left(X, \nabla^{X}\right)$ satisfies the Bohr-Sommerfeld condition if and only if the holonomy of $\left(\iota^{*} L, \nabla^{X}\right)$ is trivial. If we take $\zeta$ as $|\zeta|_{h}=1$ on $X$, we call the data of $(X, \zeta)$ the Bohr-Sommerfeld Lagrangian
submanifold. We define $\operatorname{Vol}(X, \omega)$ by the integral of the Riemannian density induced by $\omega$ on $X$. Our first result is the following asymptotic estimate.

Theorem 1. Let $X \subset M$ be a Lagrangian submanifold of $(M, \omega)$. Assume that $\left(X, \nabla^{X}\right)$ satisfies the Bohr-Sommerfeld condition. Then

\begin{equation*}
\limsup _{k \rightarrow+\infty}\left(\frac{\operatorname{Vol}(X, \omega)}{(2 k)^{n / 2}} \sup _{f \in H_{(2)}^{0}\left(M, L^{k}\right), f \neq 0} \frac{\inf _{x \in X}|f(x)|_{h^{k}}^{2}}{\|f\|_{h^{k}}^{2}}\right) \leq 1 \tag{2}
\end{equation*}
$$

We do not assume $M$ is projective nor Stein in Theorem 1 . The next result shows that (2) is an optimal estimate in some cases. Let $A=\left\{a_{1}, a_{2}, \ldots, a_{N}\right\}$ be a finite sequence of points in $M \backslash X$ (possibly empty). We denote by $H_{(2), A}^{0}\left(M, L^{k}\right)$ the Hilbert space of holomorphic sections $f \in H_{(2)}^{0}\left(M, L^{k}\right)$ which has a zero at each point $a_{j}(j=1, \ldots, N)$. Here, if $a \in M$ occurs $l$ times in $A$, then $f$ vanishes to order $l-1$ at $a$.

Theorem 2. Let $X \subset M$ be a Lagrangian submanifold of $(M, \omega)$. Assume that ( $X, \nabla^{X}$ ) satisfies the Bohr-Sommerfeld condition. Let $A$ be a finite sequence of points in $M \backslash X$. We assume one of the following three conditions:
(i) $M$ is a projective manifold.
(ii) $M$ is a Stein manifold and the Ricci form $\operatorname{Ric}(\omega)$ of $\omega$ satisfies $\operatorname{Ric}(\omega) \geq-C \omega$ on $M$ for some $C>0$.
(iii) $M$ is a pseudoconvex domain in $\mathbb{C}^{n}$.

Then

$$
\begin{equation*}
\sup _{f \in H_{(2), A}^{0}\left(M, L^{k}\right), f \neq 0} \frac{\inf _{x \in X}|f(x)|_{h^{k}}^{2}}{\|f\|_{h^{k}}^{2}} \sim \frac{(2 k)^{n / 2}}{\operatorname{Vol}(X, \omega)} \quad(k \rightarrow+\infty) . \tag{3}
\end{equation*}
$$

One of our motivations for Theorem 2 is to study a quantitative version of the theorem due to [8] and [10].

Theorem 3. (Theorem 2.8 of [10]) Assume that $M$ is a projective manifold. Let $X \subset$ $M$ be a totally real submanifold and $\iota: X \rightarrow M$ be the inclusion map. The following are equivalent:
(a) $X$ is rationally convex.
(b) There exists a smooth Hodge form $\theta$ for $M$ such that $\iota^{*} \theta=0$.

Here the condition (a) means that $M \backslash X$ is equal to a union of positive divisors of $M$. Theorem [3 was first proved by [8] in the case of $M=\mathbb{C}^{n}$.

It would be an interesting problem whether the left hand side of (3) has the asymptotic series expansion. Bohr-Sommerfeld Lagrangian submanifolds and related asymptotic series expansion formulas are studied in symplectic settings (cf. [14]).

In the proof of Theorem 1, we use Demailly's Jensen-Lelong formula (cf. Chapter III of [7]) with a potential function which satisfies the complex Monge-Ampère equation outside $X$. There exists such a potential function if $X$ is a real-analytic manifold ([11). We note that similar computations appear in [2]. In Section 3, we reduce our situation to the real-analytic case.

We introduce some notation. We use the notation $f \lesssim g$ to mean that $|f| \leq c|g|$ for some positive number $c$ which does not depend on $k$. We write $f_{k}=O\left(k^{-\infty}\right)$ if $f_{k} \lesssim k^{-m}$ for any $m \in \mathbb{N}$. When $f\left(z_{1}, \ldots, z_{n}\right)$ is a function on an open set in $\mathbb{C}^{n}$, we
write $\left|\partial_{z} f\right|=\left(\left|\frac{\partial f}{\partial z_{1}}\right|^{2}+\ldots+\left|\frac{\partial f}{\partial z_{n}}\right|^{2}\right)^{1 / 2},\left|\bar{\partial}_{z} f\right|=\left(\left|\frac{\partial f}{\partial \bar{z}_{1}}\right|^{2}+\ldots+\left|\frac{\partial f}{\partial \bar{z}_{n}}\right|^{2}\right)^{1 / 2}$. When $\sigma$ is an $L^{k}$-valued form, we denote by $|\sigma|_{h^{k}, \omega}$ (resp. $\|\sigma\|_{h^{k}, \omega}$ ) the pointwise (resp. integral) norm of $\sigma$ induced by $\left(h^{k}, \omega\right)$.

## 2. Bohr-Sommerfeld condition

Let $X \subset M$ be a Lagrangian submanifold of $(M, \omega)$ and $\iota: X \rightarrow M$ be the inclusion map. We take a sufficiently small Stein tubular neighborhood $U \subset M$ of $X$. Since the de Rham cohomology class $\left[c_{1}(L, h)\right]$ vanishes on $U$, there exists $l \in \mathbb{N}$ such that $\left.L\right|_{U} ^{l}$ is a trivial holomorphic line bundle (cf. [10]). We introduce a basic property of the Bohr-Sommerfeld condition.

Proposition 1. The following conditions are equivalent.
(a) $\left(X, \nabla^{X}\right)$ satisfies the Bohr-Sommerfeld condition.
(b) There exists a non-vanishing smooth section $s \in C^{\infty}(U, L)$ which satisfies $\nabla s=$ 0 on $X$.
(c) For any $m \in \mathbb{N}$, there exists a non-vanishing smooth section $s \in C^{\infty}(U, L)$ such that $\log |s|_{h}^{2}=0$ to order one on $X$ and $\nabla^{\prime \prime} s=0$ to order $m$ on $X$.
(d) There exists a non-vanishing holomorphic section $s_{0} \in H^{0}(U, L)$ which satisfies $\int_{\gamma} d^{c} \log \left|s_{0}\right|_{h}^{2} \in 4 \pi \mathbb{Z}$ for any $\gamma \in H_{1}(X, \mathbb{Z})$.
Here $\nabla^{\prime \prime}$ is the $(0,1)$-part of $\nabla$ and $d^{c}$ is defined by $d^{c} f(v)=-d f(J v)$ for $v \in T M$.
Proof. Assume (a). There exists $\zeta \in C^{\infty}\left(X, \iota^{*} L\right)$ such that $\nabla^{X} \zeta=0$ and $|\zeta|_{h}=1$ on $X$. This implies that $\left.L\right|_{U}$ is a trivial smooth line bundle, and it is holomorphically trivial by the Oka principle. We take a non-vanishing holomorphic section $s_{0} \in H^{0}\left(U,\left.L\right|_{U}\right)$ and put $\varphi_{0}=-\log \left|s_{0}\right|_{h}^{2}$. For any $m \in \mathbb{N}$, a smooth function $\zeta / s_{0}$ on $X$ can be extended to a function $\xi \in C^{\infty}(U)$ with $\bar{\partial} \xi=0$ to order $m$ on $X$ by the Hörmander-Wermer Lemma (cf. [13], Proposition 5.55 of [5]). By taking $U$ sufficiently small, we may assume $\xi \neq 0$. Put $s=\xi s_{0}$. For $p \in X$, we have

\begin{equation*}
\nabla s(p)=\left(d \xi-\xi \partial \varphi_{0}\right) s_{0}(p)=\left(\partial \log \left(|\xi|^{2} e^{-\varphi_{0}}\right)\right) s(p)=\left(\partial \log |s|_{h}^{2}\right) s(p) \tag{4}
\end{equation*}
$$

Since $|s|_{h}(p)=|\zeta|_{h}(p)=1$ and $\nabla_{v} s=\nabla_{v}^{X} \zeta=0$ for any $v \in T X$, we have

$$
\left.\left.\left.\log |s|_{h}^{2}(p)=0,\left.\quad\langle\partial \log | s\right|_{h} ^{2}, v\right\rangle=\left.\frac{1}{2}\langle d \log | s\right|_{h} ^{2}, v\right\rangle+\left.\frac{\sqrt{-1}}{2}\left\langle d^{c} \log \right| s\right|_{h} ^{2}, v\right\rangle=0
$$

This shows $(a) \Rightarrow(c)$.
On the other hand, if $s \in C^{\infty}(U, L)$ satisfies the condition of (c) for $m \in \mathbb{N}$, it follows that $\nabla s=0$ on $X$ by (4) and $\left(X, \nabla^{X}\right)$ satisfies the Bohr-Sommerfeld condition. Hence (a), (b) and (c) are equivalent.

Now we prove $(a) \Rightarrow(d)$. We take $\varphi_{0}, \xi \in C^{\infty}(U)$ as above. Put $\tau=\log \xi: U \rightarrow$ $\mathbb{C} / 2 \pi \sqrt{-1} \mathbb{Z}$. We have $d \varphi_{0}(p)=2 d \operatorname{Re} \tau(p)$ for any $p \in X$ since $d \log |s|_{h}^{2}(p)=0$. This
implies $d^{c} \varphi_{0}(p)=2 d^{c} \operatorname{Re} \tau(p)=2 d \operatorname{Im} \tau(p)$ by the Cauchy-Riemann equation. Let $\gamma:[0,1] \rightarrow X$ be a smooth closed curve. Then

$$
\int_{\gamma} d^{c} \varphi_{0}=2 \int_{\gamma} d \operatorname{Im} \tau=2 \operatorname{Im} \tau(\gamma(1))-2 \operatorname{Im} \tau(\gamma(0)) \in 4 \pi \mathbb{Z}
$$

and (d) holds.
Conversely, we assume (d). Put $\varphi_{0}=-\log \left|s_{0}\right|_{h}^{2}$ and define smooth function $g$ on X by $g=\exp \left(\frac{1}{2} \varphi_{0}+\frac{\sqrt{-1}}{2} \int d^{c} \varphi_{0}\right)$. Using Hörmander-Wermer Lemma, we extend $g$ to a function $\tilde{g} \in C^{\infty}(U)$ with $\bar{\partial} \tilde{g}=0$ to order $m \in \mathbb{N}$ on $X$. Put $\tilde{g}=e^{G}$ locally. On $T X$, we have

$$
\begin{gathered}
d\left(2 \operatorname{Re} G-\varphi_{0}\right)=d\left(\varphi_{0}-\varphi_{0}\right)=0 \\
d^{c}\left(2 \operatorname{Re} G-\varphi_{0}\right)=2 d \operatorname{Im} G-d^{c} \varphi_{0}=d \int d^{c} \varphi_{0}-d^{c} \varphi_{0}=0
\end{gathered}
$$

This shows that $s=\tilde{g} s_{0} \in C^{\infty}(U, L)$ satisfies the condition of $(c)$.
Assume there exists a non-vanishing holomorphic section $s_{l, 0} \in H^{0}\left(U, L^{l}\right)$. Put $\varphi_{0}=$ $-\frac{1}{l} \log \left|s_{l, 0}\right|_{h}^{2}$. For any $\varepsilon>0$ and any $q \in \mathbb{N}$, there exists $\varphi_{0}^{\prime} \in C^{\infty}(U)$ and $l^{\prime} \in \mathbb{N}$ such that $\left|\varphi_{0}-\varphi_{0}^{\prime}\right|_{C^{q}}<\varepsilon$ on $U, \varphi_{0}=\varphi_{0}^{\prime}$ on $X, \iota^{*} d d^{c} \varphi_{0}^{\prime}=0$ and that $l^{\prime} \int_{\gamma} d^{c} \varphi_{0}^{\prime} \in 4 \pi \mathbb{Z}$ for any $\gamma \in H_{1}(X, \mathbb{Z})$ (see the proof of Lemma 3.2 of [8]). Hence we can approximate $h$ by a Hermitian metric $h^{\prime}$ such that the Chern connection associated to ( $l l^{\prime} L, l l^{\prime} h^{\prime}$ ) induces the connection which satisfies the Bohr-Sommerfeld condition on $X$.

## 3. Reduction to the Real-analytic case

Let $M$ be a complex manifold of dimension $n$. Let $X \subset M$ be a Lagrangian submanifold of $(M, \omega)$ such that $\left(X, \nabla^{X}\right)$ satisfies the Bohr-Sommerfeld condition. Let $U \subset M$ be a sufficiently small Stein tubular neighborhood of $X$. We take a non-vanishing section $s_{0} \in H^{0}(U, L)$ and put $\varphi_{0}=-\log \left|s_{0}\right|_{h}^{2}$. Take $m \in \mathbb{N}$ to be sufficiently large and take $s \in C^{\infty}(U, L)$ which satisfies the condition of (c) in Proposition 1, that is, one-jet of $\log |s|_{h}^{2}$ vanishes on $X$ and $\nabla^{\prime \prime} s=0$ to order $m$ on X. We write $s=\xi s_{0}$ for $\xi \in C^{\infty}(U)$. Put $\varphi=-\log |s|_{h}^{2}$. Let $f_{k} \in H_{(2)}^{0}\left(M, L^{k}\right)$ which satisfies $\left\|f_{k}\right\|_{h^{k}}=1$ and let $u_{k} \in C^{\infty}(U)$ such that $f_{k}=u_{k} s^{k}$ on $U$. By Whitney's theorem ([19]), there exists a real-analytic manifold $Y$ which is diffeomorphic to $X$. Let $N$ be a Stein complexification of $Y$ (see [9]). By shrinking $N$ and $U$ if necessary, there exists a diffeomorphism $\Phi: N \rightarrow U$ such that $\Phi(Y)=X$ and that the $m$-jet of $\bar{\partial} \Phi$ vanishes on $Y$ (cf. Proposition 5.55 of [5]). Put $\frac{1}{4 \pi} d d^{c}(\varphi \circ \Phi)=\omega^{\prime}$ and $\omega_{n}^{\prime}=\left(\omega^{\prime}\right)^{n} / n!$. We have $\omega^{\prime}=\frac{1}{4 \pi} \Phi^{*} d d^{c} \varphi=\Phi^{*} \omega$ on $Y$ and $Y$ is a Lagrangian submanifolds of $\left(N, \omega^{\prime}\right)$. We note that $\varphi \circ \Phi$ is a strictly plurisubharmonic function near $Y$. Let $d_{Y}(z)$ be the distance from $z \in N$ to $Y$ with respect to the Riemannian metric induced by $\omega^{\prime}$. Put $W_{k}=\left\{z \in N \left\lvert\, d_{Y}(z)<\frac{2 \log k}{\sqrt{k}}\right.\right\}$.
Lemma 1.

$$
\int_{W_{k}}\left|\bar{\partial}\left(u_{k} \circ \Phi\right)\right|_{\omega^{\prime}}^{2} e^{-k \varphi \circ \Phi} \omega_{n}^{\prime}=O\left(k^{-m+4}\right)
$$

Proof. Assume that $k \in \mathbb{N}$ is sufficiently large number. For simplicity we abuse notation and write $|\cdot|$ for the norm of a form. Because $\bar{\partial}\left(u_{k} \xi^{k}\right)=0$, we have $\bar{\partial} u_{k}=-k u_{k} \xi^{-1} \bar{\partial} \xi$. Then

$$
\left|\bar{\partial}\left(u_{k} \circ \Phi\right)\right|^{2} \lesssim\left|\partial u_{k}\right|^{2}|\bar{\partial} \Phi|^{2}+\left|\bar{\partial} u_{k}\right|^{2}|\bar{\partial} \Phi|^{2} \lesssim\left|\partial u_{k}\right|^{2}|\bar{\partial} \Phi|^{2}+k^{2}\left|u_{k} \bar{\partial} \xi\right|^{2}|\partial \Phi|^{2}
$$

It follows that

$$
k^{2} \int_{W_{k}}\left|u_{k} \bar{\partial} \xi\right|^{2}|\partial \Phi|^{2} e^{-k \varphi \circ \Phi} \omega_{n}^{\prime} \lesssim k^{2} \int_{\Phi\left(W_{k}\right)}\left|u_{k}\right|^{2}|\bar{\partial} \xi|^{2} e^{-k \varphi} \omega_{n}=O\left(\frac{(\log k)^{2 m}}{k^{m-2}}\right) .
$$

Let $\chi \in C^{\infty}(\mathbb{R})$ be a function such that $0 \leq \chi \leq 1, \chi=1$ on $(-\infty, 1 / 2]$ and that $\chi=0$ on $[1,+\infty)$. Put $\tilde{\chi}_{k}=\chi\left(\frac{\sqrt{k} d_{Y}}{4 \log k}\right)$. Then

$$
\int_{W_{k}}\left|\partial u_{k}\right|^{2}|\bar{\partial} \Phi|^{2} e^{-k \varphi \circ \Phi} \omega_{n}^{\prime} \leq \int \tilde{\chi}_{k}^{2}\left|\partial u_{k}\right|^{2}|\bar{\partial} \Phi|^{2} e^{-k \varphi \circ \Phi} \omega_{n}^{\prime}
$$

Denote by $I_{k}$ the right hand side of the above inequality. We have

$$
\begin{aligned}
I_{k} \lesssim & \int \tilde{\chi}_{k}^{2}|\bar{\partial} \Phi|^{2} e^{-k \varphi} \partial u_{k} \wedge \overline{\partial u_{k}} \wedge \omega^{n-1} \\
\lesssim & \int \tilde{\chi}_{k}^{2}|\bar{\partial} \Phi|^{2} e^{-k \varphi}\left|u_{k}\right|\left|\partial \bar{\partial} u_{k}\right| \omega_{n}+k \int \tilde{\chi}_{k}^{2}|\bar{\partial} \Phi|^{2} e^{-k \varphi}\left|u_{k}\right|\left|\partial u_{k}\right| \omega_{n} \\
& +\int\left|\partial\left(\left(\tilde{\chi}_{k}^{2}|\bar{\partial} \Phi|^{2}\right) \circ \Phi^{-1}\right)\right| e^{-k \varphi}\left|u_{k}\right|\left|\partial u_{k}\right| \omega_{n} \\
\lesssim & k\left(\int \tilde{\chi}_{k}^{2}|\bar{\partial} \Phi|^{2} e^{-k \varphi}\left|u_{k}\right|^{2} \omega_{n}+\int \tilde{\chi}_{k}^{2}|\bar{\partial} \Phi|^{2} e^{-k \varphi}\left|u_{k}\right|\left|\partial u_{k}\right| \omega_{n}\right. \\
& \left.+\int \tilde{\chi}_{k}|\bar{\partial} \Phi|^{2} e^{-k \varphi}\left|u_{k}\right|\left|\partial u_{k}\right| \omega_{n}\right)+\int \tilde{\chi}_{k}^{2}|\bar{\partial} \Phi||D \bar{\partial} \Phi| e^{-k \varphi}\left|u_{k}\right|\left|\partial u_{k}\right| \omega_{n}
\end{aligned}
$$

where $D$ is a differential operator of order one. We have

k \int \tilde{\chi}_{k}^{2}|\bar{\partial} \Phi|^{2} e^{-k \varphi}\left|u_{k}\right|^{2} \omega_{n}=O\left(\frac{(\log k)^{2 m}}{k^{m-1}}\right)
$$

Put $W_{k}^{\prime}=\left\{w \in N \left\lvert\, d_{Y}(w)<\frac{4 \log k}{\sqrt{k}}\right.\right\}$. The Cauchy-Schwarz inequality implies

& k \int \tilde{\chi}_{k}^{2}|\bar{\partial} \Phi|^{2} e^{-k \varphi}\left|u_{k}\right|\left|\partial u_{k}\right| \omega_{n} \leq k \int \tilde{\chi}_{k}|\bar{\partial} \Phi|^{2} e^{-k \varphi}\left|u_{k}\right|\left|\partial u_{k}\right| \omega_{n} \\
\leq & k\left(\int_{\Phi\left(W_{k}^{\prime}\right)}|\bar{\partial} \Phi|^{2}\left|u_{k}\right|^{2} e^{-k \varphi} \omega_{n}\right)^{1 / 2}\left(\int \tilde{\chi}_{k}^{2}\left|\partial u_{k}\right|^{2}|\bar{\partial} \Phi|^{2} e^{-k \varphi} \omega_{n}\right)^{1 / 2} \lesssim \frac{(\log k)^{m}}{k^{m / 2-1}} I_{k}^{1 / 2}
\end{aligned}
$$

and

$$
\begin{aligned}
\int \tilde{\chi}_{k}^{2}|\bar{\partial} \Phi||D \bar{\partial} \Phi|\left|u_{k}\right|\left|\partial u_{k}\right| e^{-k \varphi} \omega_{n} & \leq\left(\int \tilde{\chi}_{k}^{2}|D \bar{\partial} \Phi|^{2}\left|u_{k}\right|^{2} e^{-k \varphi} \omega_{n}\right)^{1 / 2}\left(\int \tilde{\chi}_{k}^{2}|\bar{\partial} \Phi|^{2}\left|\partial u_{k}\right|^{2} e^{-k \varphi} \omega_{n}\right)^{1 / 2} \\
& \lesssim \frac{(\log k)^{m-1}}{k^{m / 2-1 / 2}} I_{k}^{1 / 2}
\end{aligned}
$$

Hence there exists $c>0$ which does not depend on $k$ and

I_{k} \leq c\left(\frac{1}{k^{m-2}}+\frac{1}{k^{m / 2-2}} I_{k}^{1 / 2}\right) \leq c\left(\frac{1}{k^{m-2}}+\frac{2 c}{k^{m-4}}+\frac{1}{2 c} I_{k}\right) .
$$

We have $I_{k}=O\left(k^{-m+4}\right)$ and we complete the proof.
For sufficiently large $k \in \mathbb{N}, W_{k}$ is a Stein manifold. By regarding $u_{k} \circ \Phi$ as a $\left.\bigwedge^{n} T^{(1,0)} N\right|_{W_{k}}$-valued ( $n, 0$ )-form, there exists $v_{k} \in C^{\infty}\left(W_{k}\right)$ such that $\bar{\partial} v_{k}=\bar{\partial}\left(u_{k} \circ \Phi\right)$
and that $\int_{W_{k}}\left|v_{k}\right|^{2} e^{-k \varphi \circ \Phi} \omega_{n}^{\prime}=O\left(k^{-m+4}\right)$ (cf. [7]). Let $\beta_{k}=u_{k} \circ \Phi-v_{k}$. Then $\beta_{k}$ is a holomorphic function on $W_{k}$. If $m>4$, we have

Our next task is to estimate $\left|v_{k}\right|$ on $Y$. We first estimate $u_{k}$ near $X$.
Lemma 2. Let $r>0$ be a sufficiently small number. Let $c>0$ be a positive number which is larger than the $C^{1}$-norm of $\varphi_{0}$ on a neighborhood of $X$. Let $D$ be a differential operator of order one with bounded coefficients. Then there exists $\delta>0$ which does not depend on $r$ and the following estimates hold:
(i) $\sup _{\left\{z \in M, d_{X}(z)<\delta r\right\}}\left|u_{k}\right|^{2} e^{-k \varphi} \lesssim e^{c k r} / r^{2 n}$,
(ii) $\sup _{\left\{z \in M, d_{X}(z)<\delta r\right\}}\left|D u_{k}\right|^{2} e^{-k \varphi} \lesssim e^{4 c k r} / r^{2+2 n}+k^{2} e^{c k r} / r^{2 n}$.

Proof. We take open sets $\left\{V_{i}\right\}_{i=1}^{l},\left\{V_{i}^{\prime}\right\}_{i=1}^{l}\left(V_{i} \subset \subset V_{i}^{\prime}\right)$ in $M$ such that $X \subset \bigcup_{i=1}^{l} V_{i}$ and that there exists a holomorphic coordinate on $V_{i}^{\prime}$. Let $B_{i}(p, r) \subset V_{i}^{\prime}$ be the Euclidean ball of center $p \in V_{i}^{\prime}$ and radius $r$ in $V_{i}^{\prime}$. We may assume that $B_{i}(p, 2 r) \subset V_{i}^{\prime}$ for any $p \in X \cap V_{i}$ by taking $r$ sufficiently small. Let $p \in X \cap V_{i}$. Since $u_{k} \xi^{k}$ is a holomorphic function, the mean value inequality implies

$$

where $d \mu_{i, \text { Leb }}$ is the Lebesgue measure on $V_{i}^{\prime}$. Since $\sup _{B_{i}(p, r)}\left|D\left(u_{k} \xi^{k}\right)\right| \lesssim \frac{1}{r} \sup _{B_{i}(p, 2 r)}\left|u_{k} \xi^{k}\right|$, we have

\sup _{B_{i}(p, r)}\left|D\left(u_{k} \xi^{k}\right)\right|^{2} e^{-k \varphi_{0}} \lesssim \frac{e^{2 c k r}}{r^{2}} \sup _{B_{i}(p, 2 r)}\left|u_{k} \xi^{k}\right|^{2} e^{-k \varphi_{0}}
$$

Hence

\sup _{B_{i}(p, r)}\left|D u_{k}\right|^{2} e^{-k \varphi} \lesssim \frac{e^{2 c k r}}{r^{2}} \sup _{B_{i}(p, 2 r)}\left|u_{k}\right|^{2} e^{-k \varphi}+k^{2} \sup _{B_{i}(p, r)}\left|u_{k}\right|^{2} e^{-k \varphi} \lesssim \frac{e^{4 c k r}}{r^{2+2 n}}+\frac{k^{2} e^{c k r}}{r^{2 n}} .
$$

If we take $\delta$ sufficiently small, $\bigcup_{i=1}^{l} \bigcup_{p \in X \cap V_{i}} B_{i}(p, r)$ contains $\left\{z \in M \mid d_{X}(z)<\delta r\right\}$ for any sufficiently small $r$. This completes the proof of (i), (ii).
Lemma 3. We have

\left|v_{k}\right|^{2}=O\left(k^{2 n-2 m}\right)+O\left(k^{2 n-m+4}\right)
$$

uniformly on $Y$.
Proof. Let $q \in Y$ and $W_{q} \subset N$ be a sufficiently small neighborhood of $q$ and $\left(w_{1}, \ldots, w_{n}\right)$ be a holomorphic coordinate on $W_{q}$. Let $\delta>0$ be as in Lemma 2. Then there exists $\delta^{\prime}>0$ which does not depend on $q \in Y$ such that $\Phi\left(B\left(q, \delta^{\prime} r\right)\right) \subset\left\{z \in M \mid d_{X}(z)<\delta r\right\}$ for any $0<r \ll 1$. Here $B\left(q, \delta^{\prime} r\right)$ is the Euclidean ball of center $q$ and radius $\delta^{\prime} r$ in $W_{q}$. We take $r$ to be a positive number which depends only on $k$ such that $B\left(q, \delta^{\prime} r\right) \subset W_{k}=\left\{z \in N \left\lvert\, d_{Y}(z)<\frac{2 \log k}{\sqrt{k}}\right.\right\}$. Let $c^{\prime}>0$ be a positive number which is larger than the $C^{1}$-norm of $\varphi \circ \Phi$ on $W_{q}$. By Lemma 15.1.8 of [12], we have

\left|v_{k}(q)\right|^{2} & \lesssim\left(\delta^{\prime} r\right)^{2} \sup _{B\left(q, \delta^{\prime} r\right)}\left|\bar{\partial}_{w} v_{k}\right|^{2}+\frac{1}{\left(\delta^{\prime} r\right)^{2 n}} \int_{B\left(q, \delta^{\prime} r\right)}\left|v_{k}\right|^{2} d \mu_{\mathrm{Leb}} \\
& \lesssim r^{2} e^{c^{\prime} \delta^{\prime} k r} \sup _{B\left(q, \delta^{\prime} r\right)}\left|\bar{\partial}_{w} v_{k}\right|^{2} e^{-k \varphi o \Phi}+r^{-2 n} e^{c^{\prime} \delta^{\prime} k r} k^{-m+4}
\end{aligned}
$$

Let $\left(z_{1}, \ldots, z_{n}\right)$ be a holomorphic coordinate on a neighborhood of $\Phi(q)$. Then

$$
\left|\bar{\partial}_{w} v_{k}\right|=\left|\bar{\partial}_{w}\left(u_{k} \circ \Phi\right)\right| \leq\left|\partial_{z} u_{k}\right|\left|\bar{\partial}_{w} \Phi\right|+\left|\bar{\partial}_{z} u_{k}\right|\left|\partial_{w} \Phi\right| \lesssim\left|\partial_{z} u_{k}\right|\left|\bar{\partial}_{w} \Phi\right|+k\left|u_{k} \bar{\partial}_{z} \xi\right| .
$$

By Lemma 2, we have

\lesssim & r^{-2 n} e^{c^{\prime} \delta^{\prime} k r}\left(\left(e^{4 c k r}+r^{2} k^{2} e^{c k r}\right) \sup _{B\left(q, \delta^{\prime} r\right)}\left|\bar{\partial}_{w} \Phi\right|^{2}+r^{2} k^{2} e^{c k r} \sup _{B\left(q, \delta^{\prime} r\right)}\left|\bar{\partial}_{z} \xi\right|^{2}\right)+r^{-2 n} e^{c^{\prime} \delta^{\prime} k r} k^{-m+4} \\
\lesssim & r^{-2 n+2 m} e^{c^{\prime} \delta^{\prime} k r}\left(e^{4 c k r}+r^{2} k^{2} e^{c k r}\right)+r^{-2 n} e^{c^{\prime} \delta^{\prime} k r} k^{-m+4} .
\end{aligned}
$$

If we take $r=k^{-1}$, we have $B\left(q, \delta^{\prime} r\right) \subset W_{k}$ for sufficiently large $k$ and $\left|v_{k}(q)\right|^{2}=$ $O\left(k^{2 n-2 m}\right)+O\left(k^{2 n-m+4}\right)$. Since $Y$ is compact, the above estimates hold uniformly on $Y$.

## 4. Monge-Ampère equation and Demailly's Jensen-Lelong formula

We use the same notation as in Section 3, Since $N$ is Stein, we may assume that $N$ is a real-analytic submanifold in a higher dimensional Euclidean space. Then one can approximate $\varphi \circ \Phi$ by analytic functions in the $C^{l}$-norm for any $l \in \mathbb{N}$ on a neighborhood of $Y([18])$. Let $\varepsilon>0$ be a sufficiently small number. Let $\varphi_{\varepsilon}$ be a real analytic function on a neighborhood of $Y$ such that

\end{equation*}
$$

Let $d s^{2}$ be the real-analytic Riemannian metric on $Y$ induced by $\frac{1}{4 \pi} d d^{c} \varphi_{\varepsilon}$. By the fundamental result of Guillemin and Stenzel [11], there exists the real-analytic strictly plurisubharmonic function $\rho$ on a neighborhood of $Y$ such that $0 \leq \rho \leq 1, \rho^{-1}(0)=Y$, the Kähler form $\frac{1}{4 \pi} d d^{c} \rho$ induces the Riemannian metric $d s^{2}$ on $Y$ and that $\left(d d^{c} \sqrt{\rho}\right)^{n}=0$ outside $Y$. We note that $\rho$ depends on $\varepsilon>0$. By Shrinking $N$ if necessary, we may assume that $\rho$ is defined on $N$. Since $\rho$ is strictly plurisubharmonic and $\sqrt{\rho}$ is a solution of the Monge-Ampère equation, $\partial \bar{\partial} \sqrt{\rho}$ has $(n-1)$ positive eigenvalues and does not have negative eigenvalues on $N \backslash Y$. Because $\sqrt{\rho}$ attains its minimum at $Y$, we have that $\sqrt{\rho}$ is plurisubharmonic on $N$ (cf. Theorem 5.6 of [15]).

Put $\omega_{\rho}=\frac{1}{4 \pi} d d^{c} \rho$. Let $q \in Y$ and $W_{q} \subset N$ be a small open neighborhood of $q$. Let $x=\left(x_{1}, \ldots, x_{n}\right)$ be a smooth coordinate on $W_{q} \cap Y$ and $\left\{e_{1}, \ldots, e_{n}\right\}$ be an orthonormal basis of $T Y$ on $W_{q} \cap Y$ with respect to the Riemannian metric induced by $\omega_{\rho}$. Let $J_{N} \in \operatorname{End}(T N)$ be the complex structure of $N$. Then $\left(J_{N} e_{1}, \ldots, J_{N} e_{n}\right)$ induces a frame of the normal bundle $T N / T Y$ on $W_{q} \cap Y$. We have $\left\langle e_{1}, \ldots, e_{n}\right\rangle^{\perp}=\left\langle J_{N} e_{1}, \ldots, J_{N} e_{n}\right\rangle$. Let $(x, y)=\left(x_{1}, \ldots, x_{n}, y_{1}, \ldots, y_{n}\right)$ be the coordinate on $W_{q}$ associated to $\left(J_{N} e_{1}, \ldots, J_{N} e_{n}\right)$, that is, $\left(x_{1}, \ldots, x_{n}, 0, \ldots, 0\right)$ corresponds to a point in $W_{q} \cap Y$ and $\left(x_{1}, \ldots, x_{n}, y_{1}, \ldots, y_{n}\right)$ corresponds to $\exp _{(x, 0)}\left(y_{1} J_{N} e_{1}+\cdots+y_{n} J_{N} e_{n}\right) \in N$. Then $\rho(x, y)=2 \pi \sum_{i=1}^{n} y_{i}^{2}+O\left(|y|^{3}\right)$ on $W_{q}$. On the other hand, we have

$$
\varphi \circ \Phi(x, y)=\sum_{i=1}^{n} a_{i j}(x) y_{i} y_{j}+O\left(|y|^{3}\right)
$$

where $a_{i j}(x)=2 \pi \omega^{\prime}\left(\partial / \partial_{y_{i}}, J_{N} \partial / \partial_{y_{j}}\right)(x, 0)$. Here $\omega^{\prime}=\frac{1}{4 \pi} d d^{c} \varphi \circ \Phi$. By (6), there exist $c_{1}, c_{2}, c_{3}>0$ which do not depend on $k$ or $\varepsilon$ such that

\left(1-c_{1} \varepsilon\right) \varphi \circ \Phi \leq \rho \leq\left(1+c_{1} \varepsilon\right) \varphi \circ \Phi \tag{7}
\end{equation*}
$$

$$
\begin{gather*}
\left(1-c_{2} \varepsilon\right) \omega_{n}^{\prime} \leq \omega_{\rho, n} \leq\left(1+c_{2} \varepsilon\right) \omega_{n}^{\prime}  \tag{8}\\
\left(1-c_{3} \varepsilon\right) \operatorname{Vol}(X, \omega) \leq \operatorname{Vol}\left(Y, \omega_{\rho}\right) \leq\left(1+c_{3} \varepsilon\right) \operatorname{Vol}(X, \omega) \tag{9}
\end{gather*}
$$

on a neighborhood of $Y$. Here $\omega_{\rho, n}=\omega_{\rho}^{n} / n!$ and $\operatorname{Vol}\left(Y, \omega_{\rho}\right)$ is defined by the integral of the Riemannian density induced by $\omega_{\rho}$ on $Y$. We define $B_{\sqrt{\rho}}(r)=\{z \in N \mid \sqrt{\rho}(z) \leq r\}$, $S_{\sqrt{\rho}}(r)=\{z \in N \mid \sqrt{\rho}(z)=r\}$. For sufficiently large $k \in \mathbb{N}$, we have $B_{\sqrt{\rho}}\left(\frac{\sqrt{2 \pi} \log k}{\sqrt{k}}\right) \subset$ $W_{k}=\left\{z \in N \left\lvert\, d_{Y}(z)<\frac{2 \log k}{\sqrt{k}}\right.\right\}$. By Demailly's Jensen-Lelong formula (see [7]), we have

\begin{aligned}
\inf _{y \in Y}\left|\beta_{k}(y)\right|^{2} \int_{S_{\sqrt{\rho}}(r)} d^{c} \sqrt{\rho} \wedge\left(d d^{c} \sqrt{\rho}\right)^{n-1} & =\inf _{y \in Y}\left|\beta_{k}(y)\right|^{2} \int_{Y}\left(d d^{c} \sqrt{\rho}\right)^{n} \leq \int_{Y}\left|\beta_{k}\right|^{2}\left(d d^{c} \sqrt{\rho}\right)^{n} \\
& \leq \int_{S_{\sqrt{\rho}}(r)}\left|\beta_{k}\right|^{2} d^{c} \sqrt{\rho} \wedge\left(d d^{c} \sqrt{\rho}\right)^{n-1}
\end{aligned}
$$

for $0<r<\frac{\log k}{\sqrt{k}}$. Here $\left(d d^{c} \sqrt{\rho}\right)^{n}$ is the Monge-Ampère measure whose support is contained in $Y$ (see [1], [7]). Since $d^{c} \sqrt{\rho}=\rho^{-1 / 2} \frac{d^{c} \rho}{2}$ and $d d^{c} \sqrt{\rho}=\rho^{-1 / 2} \frac{d d^{c} \rho}{2}-\rho^{-3 / 2} \frac{d \rho \wedge d^{c} \rho}{4}$, we obtain

for any $b>0$. Thus,

& \inf _{y \in Y}\left|\beta_{k}(y)\right|^{2} \int_{B_{\sqrt{\rho}}\left(\frac{\sqrt{2 \pi} \log k}{\sqrt{k}}\right)} e^{-k b \rho} \rho^{-1} d \rho \wedge d^{c} \rho \wedge\left(d d^{c} \rho\right)^{n-1} \\
= & 2 \inf _{y \in Y}\left|\beta_{k}(y)\right|^{2} \int_{0}^{\frac{\sqrt{2 \pi} \log k}{\sqrt{k}}} d r \int_{S_{\sqrt{p}}(r)} e^{-k b \rho} \rho^{-1 / 2} d^{c} \rho \wedge\left(d d^{c} \rho\right)^{n-1} \\
\leq & 2 \int_{0}^{\frac{\sqrt{2 \pi} \log k}{\sqrt{k}}} d r \int_{S_{\sqrt{\rho}}(r)}\left|\beta_{k}\right|^{2} e^{-k b \rho} \rho^{-1 / 2} d^{c} \rho \wedge\left(d d^{c} \rho\right)^{n-1} \\
= & \int_{B_{\sqrt{\rho}}\left(\frac{\sqrt{2 \pi} \log k}{\sqrt{k}}\right)}\left|\beta_{k}\right|^{2} e^{-k b \rho} \rho^{-1} d \rho \wedge d^{c} \rho \wedge\left(d d^{c} \rho\right)^{n-1} .
\end{aligned}

Since $\left(d d^{c} \sqrt{\rho}\right)^{n}=0$, we have

Lemma 4.

$$

Proof. Let $\left\{q_{i}\right\}_{i=1}^{l} \subset Y$ and $W_{i} \subset N$ be a small neighborhood of $q_{i}$ such that $Y \subset$ $\bigcup_{i=1}^{l} W_{i}$ and that there exist non-negative smooth functions $\lambda_{i} \in C_{0}^{\infty}\left(W_{i}\right)$ which satisfy $\sum_{i=1}^{l} \lambda_{i}=1$ on a neighborhood of $Y$. We take a smooth coordinate $(x, y)$ on $W_{i}$ as in
the first part of this section. Since $\rho(x, y)=2 \pi \sum_{i=1}^{n} y_{i}^{2}+O\left(|y|^{3}\right)$, there exists $c_{4}>1$ which does not depend on $k$ and satisfies

\left\{z \in W_{q}| | y(z) \left\lvert\,<c_{4}^{-1} \frac{\log k}{\sqrt{k}}\right.\right\} \subset B_{\sqrt{\rho}}\left(\frac{\sqrt{2 \pi} \log k}{\sqrt{k}}\right) \subset\left\{z \in W_{q}| | y(z) \left\lvert\,<c_{4} \frac{\log k}{\sqrt{k}}\right.\right\}
$$

for sufficiently large $k$. We have

$$
\begin{aligned}
& \int_{|y|<c_{4}^{-1} \frac{\log k}{\sqrt{k}}} \lambda_{i} e^{-k b \rho} \omega_{\rho, n}=\int_{|y|<c_{4}^{-1} \frac{\log k}{\sqrt{k}}} \lambda_{i}(x, y) e^{-2 \pi b k|y|^{2}+k O\left(|y|^{3}\right)}(1+O(|y|)) d \mu_{Y} d y \\
= & \frac{1}{k^{n / 2}} \int_{|y|<c_{4}^{-1} \log k} \lambda_{i}\left(x, \frac{y}{\sqrt{k}}\right) e^{-2 \pi b|y|^{2}}\left(1+O\left(\frac{(\log k)^{3}}{\sqrt{k}}\right)\right) d \mu_{Y} d y
\end{aligned}
$$

where $d \mu_{Y}$ is the Riemannian density on $Y$ induced by $\omega_{\rho}$. Since

\int_{c_{4}^{-1} \log k \leq|y|<c_{4} \log k} \lambda_{i}(x, 0) e^{-2 \pi b|y|^{2}} d \mu_{Y} d y=O\left(k^{-\infty}\right)
$$

it follows that

\int_{B_{\sqrt{\rho}}\left(\frac{\sqrt{2 \pi} \log k}{\sqrt{k}}\right)} \lambda_{i} e^{-k b \rho} \omega_{\rho, n} & =\frac{1}{k^{n / 2}}\left(1+O\left(\frac{(\log k)^{3}}{\sqrt{k}}\right)\right) \int \lambda_{i}(x, 0) e^{-2 \pi b|y|^{2}} d \mu_{Y} d y+O\left(k^{-\infty}\right) \\
& =\frac{1}{(2 k b)^{n / 2}}\left(1+O\left(\frac{(\log k)^{3}}{\sqrt{k}}\right)\right) \int \lambda_{i}(x, 0) d \mu_{Y}+O\left(k^{-\infty}\right)
\end{aligned}
$$

Hence we obtain $\int_{B_{\sqrt{\rho}( }\left(\frac{\sqrt{2 \pi} \log k}{\sqrt{k}}\right)} e^{-k b \rho} \omega_{\rho, n}=\frac{1}{(2 k b)^{n / 2}}\left(1+O\left(\frac{(\log k)^{3}}{\sqrt{k}}\right)\right) \operatorname{Vol}\left(Y, \omega_{\rho}\right)$.
Now put $b=\frac{1}{1-c_{1} \varepsilon}$. By (5), (7) and (8), we have

$$
\limsup _{k \rightarrow+\infty} \int_{B_{\sqrt{\rho}}\left(\frac{\sqrt{2 \pi} \log k}{\sqrt{k}}\right)}\left|\beta_{k}\right|^{2} e^{-k b \rho} \omega_{\rho, n} \leq 1+c_{2} \varepsilon
$$

Then (9), (10) and Lemma 4 imply

$$
\limsup _{k \rightarrow \infty} \inf _{y \in Y}\left|\beta_{k}(y)\right|^{2} \frac{\operatorname{Vol}(X, \omega)}{(2 k)^{n / 2}} \leq \frac{1+c_{2} \varepsilon}{\left(1-c_{1} \varepsilon\right)^{n / 2}\left(1-c_{3} \varepsilon\right)}
$$

By Lemma 3, we have

$$
\begin{aligned}
\limsup _{k \rightarrow+\infty} \frac{\inf _{x \in X}\left|f_{k}(x)\right|_{h^{k}}^{2} \operatorname{Vol}(X, \omega)}{(2 k)^{n / 2}} & \leq \limsup _{k \rightarrow+\infty} \inf _{y \in Y}\left((1+\varepsilon)\left|\beta_{k}(y)\right|^{2}+\left(1+\frac{1}{\varepsilon}\right)\left|v_{k}(y)\right|^{2}\right) \frac{\operatorname{Vol}(X, \omega)}{(2 k)^{n / 2}} \\
& \leq \frac{(1+\varepsilon)\left(1+c_{2} \varepsilon\right)}{\left(1-c_{1} \varepsilon\right)^{n / 2}\left(1-c_{3} \varepsilon\right)}
\end{aligned}
$$

for sufficiently large $m$. This completes the proof of Theorem 1 since $\varepsilon$ is any positive number.

## 5. Estimate from below

Let $M$ be a complex manifold of dimension $n$. Let $X \subset M$ be a Lagrangian submanifold of $(M, \omega)$ such that $\left(X, \nabla^{X}\right)$ satisfies the Bohr-Sommerfeld condition. We take $U \subset M, m \in \mathbb{N}, s_{0} \in H^{0}(U, L), s \in C^{\infty}(U, L)$ and $\xi, \varphi_{0}, \varphi \in C^{\infty}(U)$ as in Section 3. Let $p \in X$ and $V \subset M$ be a small neighborhood of $p$. We take a smooth coordinate $x=\left(x_{1}, \ldots, x_{n}\right)$ on $V \cap X$ and take a local frame $\left(e_{1}, \ldots, e_{n}\right)$ of $T X$ on $V \cap X$. We take a local coordinate system $(x, y)=\left(x_{1}, \ldots, x_{n}, y_{1}, \ldots, y_{n}\right)$ as in the first part of Section 4 . Since $\omega=-\frac{\sqrt{-1}}{2 \pi} \partial \bar{\partial} \log \left|s_{0}\right|_{h}^{2}=\frac{1}{4 \pi} d d^{c} \varphi+O(|y|)$, we have $\varphi(x, y)=2 \pi \sum_{i=1}^{n} y_{i}^{2}+O\left(|y|^{3}\right)$. Let $d_{X}(z)$ be the distance from $z \in M$ to $X$. Let $\chi \in C^{\infty}(\mathbb{R})$ be a function such that $0 \leq \chi \leq 1, \chi=1$ on $(-\infty, 1 / 2]$ and that $\chi=0$ on $[1,+\infty)$. Define $\chi_{k}(z)=\chi\left(\frac{\sqrt{k} d_{X}(z)}{\log k}\right)$ for $z \in M$. Put $s_{k}=\chi_{k} s^{k} \in C^{\infty}\left(U, L^{k}\right)$ for $k \in \mathbb{N}$.

## Lemma 5.

$$
\left\|\nabla^{\prime \prime} s_{k}\right\|_{h^{k}, \omega}^{2}=O\left(k^{2-m}\right)
$$

Proof. Assume that $k \in \mathbb{N}$ is sufficiently large. We have

$$
\left|\nabla^{\prime \prime} s_{k}\right|_{h^{k}, \omega}^{2}=\left|\xi^{k} \bar{\partial} \chi_{k}+k \chi_{k} \xi^{k-1} \bar{\partial} \xi\right|_{\omega}^{2} e^{-k \varphi_{0}} \lesssim\left|\bar{\partial} \chi_{k}\right|_{\omega}^{2} e^{-k \varphi}+k^{2}\left|\chi_{k} \bar{\partial} \xi\right|_{\omega}^{2} e^{-k \varphi} .
$$

It follows that

$$
\begin{aligned}
& \int_{V}\left|\bar{\partial} \chi_{k}\right|_{\omega}^{2} e^{-k \varphi} \omega_{n} \lesssim\left(\frac{\sqrt{k}}{\log k}\right)^{2} \int_{\frac{\log k}{2 \sqrt{k}}<|y|<\frac{\log k}{\sqrt{k}},(x, y) \in V} e^{-2 k \pi|y|^{2}} d x d y \\
\lesssim & \left(\frac{\log k}{\sqrt{k}}\right)^{n-2} e^{-\pi(\log k)^{2} / 2}=O\left(k^{-\infty}\right)
\end{aligned}
$$

and

$$
k^{2} \int_{V}\left|\chi_{k} \bar{\partial} \xi\right|_{\omega}^{2} e^{-k \varphi} \omega_{n} \lesssim k^{2} \int_{|y|<\frac{\log k}{\sqrt{k}},(x, y) \in V}|y|^{2 m} e^{-2 k \pi|y|^{2}} d x d y=O\left(k^{2-m}\right)
$$

The last equality holds by the boundedness of $|\sqrt{k} y|^{2 m} e^{-\pi|\sqrt{k} y|^{2}}$. The lemma holds since $X$ is compact.

Let $A$ be a finite sequence of points in $M \backslash X$ (possibly empty). Assume that $A$ consists of $a_{1}, \ldots, a_{N} \in M \backslash X\left(a_{i} \neq a_{j}\right.$ if $\left.i \neq j\right)$ and $a_{i}$ occurs $l_{i}$ times in $A$. Let $U_{i} \subset M$ be a small neighborhood of $a_{i}$. We may assume that the support of $\chi_{k}$ does not intersect $U_{i}$ for any $i$ and $k$. Let $0 \leq \kappa_{i} \leq 1$ be a smooth function on $M$ such that the support of $\kappa_{i}$ is contained in $U_{i}$ and $\kappa_{i}=1$ on a neighborhood of $a_{i}$. Let $z=\left(z_{1}, \ldots, z_{n}\right)$ be a holomorphic coordinate on $U_{i}$ such that $a_{i}$ corresponds to the origin. Then we put $\tau_{i}(z)=\kappa_{i}(z)\left(n+l_{i}-1\right) \log |z|^{2}$. By taking $U_{i}$ small, we have $\tau_{i} \leq 0$. We define a singular Hermitian metric $h_{k}^{\prime}$ of $L^{k}$ by $h_{k}^{\prime}=h^{k} e^{-\sum_{i=1}^{N} \tau_{i}}$. The Chern form induced by $h_{k}^{\prime}$ is positive in the sense of currents if $k$ is sufficiently large. Lemma 5 shows that $\left\|\nabla^{\prime \prime} s_{k}\right\|_{h_{k}^{\prime}, \omega}^{2}=O\left(k^{2-m}\right)$.

Now we assume that $M$ satisfies one of the three conditions in Theorem 3. We regard $s_{k}$ as an $L^{k} \otimes \bigwedge^{n} T^{(1,0)} M$-valued ( $n, 0$ )-form. We show that there exists $t_{k} \in C^{\infty}\left(M, L^{k}\right)$ such that $\nabla^{\prime \prime} t_{k}=\nabla^{\prime \prime} s_{k}$ and $\left\|t_{k}\right\|_{h^{k}}^{2} \leq\left\|t_{k}\right\|_{h_{k}^{\prime}}^{2} \lesssim\left\|\nabla^{\prime \prime} s_{k}\right\|_{h_{k}^{\prime}, \omega}^{2}$ for sufficiently large $k$ (cf. [6], [7]). If $M$ is a pseudoconvex domain in $\mathbb{C}^{n}, \bigwedge^{n} T^{(1,0)}$ is trivial line bundle and there exists no problem. If $M$ is a projective (resp. Stein) manifold, we need to deal with
the difference of the Chern form of $L^{k}$ and $L^{k} \otimes \bigwedge^{n} T^{(1,0)} M$. However the compactness (resp. the condition $\operatorname{Ric}(\omega) \geq-C \omega$ ) gives the solution of $\bar{\partial}$-equation with the desired estimate for sufficiently large $k$. We define a holomorphic section $\alpha_{k}=s_{k}-t_{k}$. Since $\left\|\alpha_{k}\right\|_{h_{k}^{\prime}, \omega}^{2}<+\infty$, we have $\alpha_{k} \in H_{(2), A}^{0}\left(M, L^{k}\right)$.
Lemma 6. If $m>n / 2+2$, we have

$$
\left\|\alpha_{k}\right\|_{h^{k}}^{2} \sim \frac{\operatorname{Vol}(X, \omega)}{(2 k)^{n / 2}} \quad(k \rightarrow+\infty)
$$

Proof. For any $\varepsilon>0$, it follows that

$$
(1-\varepsilon)\left\|s_{k}\right\|_{h^{k}}^{2}+\left(1-\frac{1}{\varepsilon}\right)\left\|t_{k}\right\|_{h^{k}}^{2} \leq\left\|\alpha_{k}\right\|_{h^{k}}^{2} \leq(1+\varepsilon)\left\|s_{k}\right\|_{h^{k}}^{2}+\left(1+\frac{1}{\varepsilon}\right)\left\|t_{k}\right\|_{h^{k}}^{2}
$$

Hence it is enough to show $\left\|s_{k}\right\|_{h^{k}}^{2} \sim \frac{\operatorname{Vol}(X, \omega)}{(2 k)^{n / 2}}(k \rightarrow+\infty)$ and we can prove Lemma 6 by the same argument as in Lemma 4.

Lemma 7. We have

$$
\left|t_{k}\right|_{h^{k}}^{2}=O\left(k^{2+2 n-m}\right)
$$

uniformly on $X$.
Proof. Let $k \in \mathbb{N}$ be a sufficiently large number. Let $p \in X$ and $\left(V,\left(z_{1}, \ldots, z_{n}\right)\right)$ $(p \in V \subset M)$ be a holomorphic local coordinate system. Let $v_{k} \in C^{\infty}(V)$ such that $t_{k}=v_{k} \xi^{k} s_{0}^{k}$. By Lemma 15.1.8 of [12], we have

$$
\left|v_{k} \xi^{k}(p)\right|^{2} \lesssim k^{-2} \sup _{B\left(p, k^{-1}\right)}\left|\bar{\partial}_{z}\left(v_{k} \xi^{k}\right)\right|^{2}+k^{2 n} \int_{B\left(p, k^{-1}\right)}\left|v_{k} \xi^{k}\right|^{2} d \mu_{\mathrm{Leb}}
$$

Here $B(p, r)$ is the Euclidean ball of center $p$ and radius $r$, and $d \mu_{\text {Leb }}$ is the Lebesgue measure on $V$. We have $\bar{\partial}_{z}\left(v_{k} \xi^{k}\right)=\bar{\partial}_{z}\left(\chi_{k} \xi^{k}\right)$. Let $\eta=\sup _{B\left(p, k^{-1}\right)}\left|\varphi_{0}(p)-\varphi_{0}(z)\right|$. We have $\eta=O\left(k^{-1}\right)$. Then

$$
\begin{aligned}
\left|t_{k}(p)\right|_{h^{k}}^{2} & \lesssim k^{-2} e^{k \eta} \sup _{B\left(p, k^{-1}\right)}\left(\left|\bar{\partial} \chi_{k} \xi^{k}\right|^{2}+k^{2}\left|\chi_{k} \xi^{k-1} \bar{\partial} \xi\right|^{2}\right) e^{-k \varphi_{0}}+k^{2 n} e^{k \eta} \int_{B\left(p, k^{-1}\right)}\left|t_{k}\right|_{h^{k}}^{2} \omega_{n} \\
& \lesssim k^{-2} \sup _{B\left(p, k^{-1}\right)}\left(\left|\bar{\partial} \chi_{k}\right|^{2}+k^{2}\left|\chi_{k} \bar{\partial} \xi\right|^{2}\right) e^{-k \varphi}+O\left(k^{2+2 n-m}\right) .
\end{aligned}
$$

It follows that

$$
\begin{gathered}
k^{-2} \sup _{B\left(p, k^{-1}\right)}\left|\bar{\partial} \chi_{k}\right|^{2} e^{-k \varphi} \lesssim \frac{1}{k(\log k)^{2}} \sup _{B\left(p, k^{-1}\right)}\left|\chi^{\prime}\left(\frac{\sqrt{k} d_{X}}{\log k}\right)\right|^{2} e^{-k \pi\left(d_{X}\right)^{2}}=O\left(k^{-\infty}\right) \\
\left|\chi_{k} \bar{\partial} \xi\right|^{2} e^{-k \varphi} \lesssim \chi_{k}\left(d_{X}\right)^{2 m} e^{-k \pi\left(d_{X}\right)^{2}}=O\left(k^{-m}\right)
\end{gathered}
$$

Since $X$ is compact, the above estimates do not depend on $p$ and the lemma is proved.

If we take $m>2+2 n$, we have $\lim _{k \rightarrow+\infty}\left|\alpha_{k}\right|_{h^{k}}^{2}=1$ uniformly on $X$. Hence we obtain

$$
\liminf _{k \rightarrow+\infty}\left(\frac{\operatorname{Vol}(X, \omega)}{(2 k)^{n / 2}} \sup _{f \in H_{(2), A}^{0}\left(M, L^{k}\right), f \neq 0} \frac{\inf _{x \in X}|f(x)|_{h^{k}}^{2}}{\|f\|_{h^{k}}^{2}}\right) \geq 1
$$

This completes the proof of Theorem 2,
