# A convex dual variational formulation for non-convex optimization applied to a non-linear model of plates

#### Abstract

This article develops duality principles applicable to the non-linear Kirchhoff-Love model of plates. The results are obtained through standard tools of convex analysis, functional analysis, calculus of variations and duality theory. The main duality principle concerns a convex (in fact concave) dual variational formulation and related new optimality conditions for the model in question. Finally, in the last section we develop some global existence results for a similar model in elasticity.


## 1 Introduction

In this article, in a first step, we develop a new existence proof and a dual variational formulation for the Kirchhoff-Love thin plate model. Previous results on existence in mathematical elasticity and related models may be found in [7, 8, 9 .

At this point we refer to the exceptionally important article "A contribution to contact problems for a class of solids and structures" by W.R. Bielski and J.J. Telega, [2], published in 1985 , as the first one to successfully apply and generalize the convex analysis approach to a model in non-convex and non-linear mechanics.

The present work is, in some sense, a kind of extension of this previous work [2] and others such as [3], which greatly influenced and inspired my work and recent books [5, 6].

Here we highlight that such earlier results establish the complementary energy under the hypothesis of positive definiteness of the membrane force tensor at a critical point (please see [2, 3] for details).

We have obtained a dual variational formulation which allows the global optimal point in question not to be positive definite (for related results see F.S. Botelho [5]), but also not necessarily negative definite. The approach developed also includes sufficient conditions of optimality for the primal problem. It is worth mentioning that the standard tools of convex analysis used in this text may be found in [10, 5], for example.

At this point we start to describe the primal formulation.

Let $\Omega \subset \mathbb{R}^{2}$ be an open, bounded, connected set which represents the middle surface of a plate of thickness $h$. The boundary of $\Omega$, which is assumed to be regular (Lipschitzian), is denoted by $\partial \Omega$. The vectorial basis related to the cartesian system $\left\{x_{1}, x_{2}, x_{3}\right\}$ is denoted by $\left(\mathbf{a}_{\alpha}, \mathbf{a}_{3}\right)$, where $\alpha=1,2$ (in general Greek indices stand for 1 or 2 ), and where $\mathbf{a}_{3}$ is the vector normal to $\Omega$, whereas $\mathbf{a}_{1}$ and $\mathbf{a}_{2}$ are orthogonal vectors parallel to $\Omega$. Also, $\mathbf{n}$ is the outward normal to the plate surface.

The displacements will be denoted by

The Kirchhoff-Love relations are

Here $-h / 2 \leq x_{3} \leq h / 2$ so that we have $u=\left(u_{\alpha}, w\right) \in U$ where

It is worth emphasizing that the boundary conditions here specified refer to a clamped plate.
We define the operator $\Lambda: U \rightarrow Y \times Y$, where $Y=Y^{*}=L^{2}\left(\Omega ; \mathbb{R}^{2 \times 2}\right)$, by

are symmetric positive definite fourth order tensors. Here $\lambda^{h}>0$ and $\mu^{h}>0$ are the Lamé constants which depend on $h$ and $\left\{\delta_{\alpha \beta}\right\}$ is the Kronecker delta.

From now on, in an appropriate sense, we denote $\left\{\bar{H}_{\alpha \beta \lambda \mu}\right\}=\left\{H_{\alpha \beta \lambda \mu}\right\}^{-1}$ and $\left\{\bar{h}_{\alpha \beta \lambda \mu}\right\}=$ $\left\{h_{\alpha \beta \lambda \mu}\right\}^{-1}$.

Furthermore $\left\{N_{\alpha \beta}\right\}$ denote the membrane force tensor and $\left\{M_{\alpha \beta}\right\}$ the moment one. The plate stored energy, represented by $(G \circ \Lambda): U \rightarrow \mathbb{R}$ is expressed by

where $P, P_{1}, P_{2} \in L^{2}(\Omega)$ are external loads in the directions $\mathbf{a}_{3}, \mathbf{a}_{1}$ and $\mathbf{a}_{2}$ respectively. The potential energy, denoted by $J: U \rightarrow \mathbb{R}$ is expressed by:

Finally, we also emphasize from now on, as their meaning are clear, we may denote $L^{2}(\Omega)$ and $L^{2}\left(\Omega ; \mathbb{R}^{2 \times 2}\right)$ simply by $L^{2}$, and the respective norms by $\|\cdot\|_{2}$. Moreover derivatives are always understood in the distributional sense, $\mathbf{0}$ may denote the zero vector in appropriate Banach spaces and, the following and relating notations are used:

## 2 On the existence of a global minimizer

At this point we present an existence result concerning the Kirchhoff-Love plate model.
We start with the following two remarks.
Remark 2.1. Let $\left\{P_{\alpha}\right\} \in L^{\infty}\left(\Omega ; \mathbb{R}^{2}\right)$. We may easily obtain by appropriate Lebesgue integration $\left\{\tilde{T}_{\alpha \beta}\right\}$ symmetric and such that

Indeed, extending $\left\{P_{\alpha}\right\}$ to zero outside $\Omega$ if necessary, we may set

Thus, we may choose a $C>0$ sufficiently big, such that

So, for the kind of boundary conditions of the next theorem, we do NOT have any restriction for the $\left\{P_{\alpha}\right\}$ norm.

Summarizing, the next result is new and it is really a step forward concerning the previous one in Ciarlet [8] and the previous results in [6]. We emphasize this result and its proof through such a tensor $\left\{T_{\alpha \beta}\right\}$ are new, even though the final part of the proof is established through a standard procedure in the calculus of variations.

It is also worth mentioning in the concerning primal formulation we have included a term denoted by

This term, even in the case where the positive $\varepsilon_{\alpha} \in L^{2}(\Gamma)$ is of small magnitude, has an amazing structural stabling effect on the plate model in question and makes the primal energy functional bounded below. This feature makes viable the proof of this existence result for a more general set of boundary conditions. We highlight such a functional $J_{5}$ corresponds to adding a distribution of springs on the portion boundary $\Gamma_{t}$.

Finally, we also highlight the duality principles and concerning optimality conditions are established through new functionals. Similar results may be found in [5, 6]. Indeed the results here developed represent some advances concerning those presented in [5] in 2014 and in [6] of 2020.

Theorem 2.2. Let $\Omega \subset \mathbb{R}^{2}$ be an open, bounded, connected set with a Lipschitzian boundary denoted by $\partial \Omega=\Gamma$. Suppose $(G \circ \Lambda): U \rightarrow \mathbb{R}$ is defined by

From this, since $\left\{T_{\alpha \beta}\right\}$ is positive definite, clearly $J$ is bounded below.
Let $\left\{u_{n}\right\} \in U$ be a minimizing sequence for $J$. Thus there exists $\alpha_{1} \in \mathbb{R}$ such that

## 3 The duality principles

## 4 An auxiliary theoretical result in analysis

In this section we state and prove some theoretical results in analysis which will be used in the subsequent sections.

Theorem 4.1. Let $\Omega \subset \mathbb{R}^{3}$ be an open, bounded and connected set with a regular (Lipschitzian) boundary denoted by $\partial \Omega$.

Assume $\left\{u_{n}\right\} \subset W^{1,4}(\Omega)$ be such that

Proof. Since $W^{1,4}(\Omega)$ is reflexive, from the Kakutani and Sobolev Imbedding theorems, up to a not relabeled there exists $u_{0} \in W^{1,4}(\Omega)$ such that

\leq & \int_{\Omega}\left|\frac{\partial u_{n}}{\partial x_{j}}-\frac{\partial u_{0}}{\partial x_{j}}\right| d x\left\|\varphi-\varphi_{1}\right\|_{\infty} \\
& +\left|\left\langle u_{n}-u_{0}, \frac{\partial \varphi_{1}}{\partial x_{j}}\right\rangle_{L^{2}}\right| \\
\leq & 2 K_{1} \varepsilon+\varepsilon\left\|\frac{\partial \varphi_{1}}{\partial x_{j}}\right\|_{1} \\

= & \limsup _{r \rightarrow 0^{+}}\left(\limsup _{n \rightarrow \infty} \frac{\left|\int_{\partial B_{r}(x)}\left(u_{n}(y)-u_{0}(y)\right) \nu_{i} d S(y)\right|}{m\left(B_{r}(x)\right)}\right) \\
= & \limsup _{r \rightarrow 0^{+}}\left(\limsup _{n \rightarrow \infty} \frac{\left|\left(u_{n}(\tilde{y})-u_{0}(\tilde{y})\right) \int_{\partial B_{r}(x)} \nu_{i} d S(y)\right|}{m\left(B_{r}(x)\right)}\right) \\
\leq & \varepsilon \limsup _{r \rightarrow 0^{+}} \frac{\int_{\partial B_{r}(x)} r\left|\nu_{i}\right| d S(y)}{m\left(B_{r}(x)\right)} \\
\leq & K_{1} \varepsilon, \text { for almost all } x \in \Omega, \tag{37}

\leq & \left\|\frac{\partial u_{m}}{\partial x_{j}}-\frac{\partial u_{0}}{\partial x_{j}}\right\|_{4}^{3}\left\|\chi_{\Omega \backslash B_{n}}\right\|_{4}+\varepsilon^{3} m(\Omega) \\
\leq & \varepsilon+\varepsilon^{3} m(\Omega) . \tag{38}
\end{align*}

## 5 An existence result for a model in elasticity

In this section we present an existence result for a non-linear elasticity model.
Theorem 5.1. Let $\Omega \subset \mathbb{R}^{3}$ be an open, bounded and connected set with a regular (Lipschitzian) boundary denoted by $\partial \Omega$.

Consider the functional $J: U \rightarrow \mathbb{R}$ defined by

J(u)= & \frac{1}{2} \int_{\Omega} H_{i j k l}\left(\frac{u_{i, j}+u_{j, i}}{2}+\frac{u_{m, i} u_{m, j}}{2}\right)\left(\frac{u_{k, l}+u_{l, k}}{2}+\frac{u_{p, k} u_{p, l}}{2}\right) d x \\
& -\left\langle P_{i}, u_{i}\right\rangle_{L^{2}} \tag{39}
\end{align*}
$$

where $U=W_{0}^{1,4}\left(\Omega ; \mathbb{R}^{3}\right), P_{i} \in L^{\infty}(\Omega), \forall i \in\{1,2,3\}$.
Moreover, $\left\{H_{i j k l}\right\}$ is a fourth order constant tensor such that

H_{i j k l} t_{i j} t_{k l} \geq c_{0} t_{i j} t_{i j}, \forall \text { symmetric } t \in \mathbb{R}^{2 \times 2}
$$

and

H_{i j k l} t_{m i} t_{m j} t_{k p} t_{l p} \geq c_{1} \sum_{i, j=1}^{3} t_{i j}^{4}, \forall \text { symmetric } t \in \mathbb{R}^{2 \times 2},
$$

for some real constants $c_{0}>0, c_{1}>0$.
Under such hypotheses, there exists $u_{0} \in U$ such that

J\left(u_{0}\right)=\min _{u \in U} J(u)
$$

Proof. First observe that we may find a positive definite tensor $\left\{T_{i j}\right\} \subset L^{\infty}\left(\Omega ; \mathbb{R}^{2 \times 2}\right)$ such that

Hence, denoting

& =\frac{1}{2} \int_{\Omega} H_{i j k l} v_{i j}(u) v_{k l}(u) d x-\left\langle T_{i j}, \frac{u_{i, j}+u_{j, i}}{2}\right\rangle_{L^{2}} \\
& =\frac{1}{2} \int_{\Omega} H_{i j k l} v_{i j}(u) v_{k l}(u) d x-\left\langle T_{i j}, v_{i j}(u)-\frac{u_{m, i} u_{m, j}}{2}\right\rangle_{L^{2}} \\
& =\frac{1}{2} \int_{\Omega} H_{i j k l} v_{i j}(u) v_{k l}(u) d x-\left\langle T_{i j}, v_{i j}(u)\right\rangle_{L^{2}}+\left\langle T_{i j}, \frac{u_{m, i} u_{m, j}}{2}\right\rangle_{L^{2}}, \forall u \in U \tag{40}
\end{align*}
$$

From this and the hypotheses on $\left\{H_{i j k l}\right\}$ it is clear that $J$ is bounded below so that there exists $\alpha \in \mathbb{R}$ such that

Let $\left\{u_{n}\right\} \subset U$ be a minimizing sequence for $J$, that is, let such a sequence be such that

Also from the hypotheses on $\left\{H_{i j k l}\right\}$ and the Poincaré inequality, we have that there exists $K>0$ such that

From the auxiliary result in the last section, there exists $u_{0} \in C^{0}\left(\bar{\Omega} ; \mathbb{R}^{3}\right) \cap W^{1,4}\left(\Omega ; \mathbb{R}^{3}\right)$ such that, up to a not relabeled subsequence,

u_{n} \rightarrow u_{0}, \text { strongly in } W^{1,3}\left(\Omega: \mathbb{R}^{3}\right) .
$$

From such a latter result, up to a not relabeled subsequence, we may obtain

\frac{\left(u_{n}\right)_{i, j}+\left(u_{n}\right)_{j, i}}{2}+\frac{\left(u_{n}\right)_{m, i}\left(u_{n}\right)_{m, j}}{2} \rightharpoonup \frac{\left(u_{0}\right)_{i, j}+\left(u_{0}\right)_{j, i}}{2}+\frac{\left(u_{0}\right)_{m, i}\left(u_{0}\right)_{m, j}}{2}, \text { weakly in } L^{3 / 2}(\Omega) .
$$

Since $L^{3 / 2}(\Omega)$ is reflexive, from the convexity of $J$ in $v_{i j}(u)$ and since $\left\{T_{i j}\right\}$ is positive definite, we have that

$$
\alpha=\liminf _{n \rightarrow \infty} J\left(u_{n}\right) \geq J\left(u_{0}\right),
$$

so that

$$
J\left(u_{0}\right)=\min _{u \in U} J(u) .
$$

The proof is complete.

## 6 Another existence result for a model in elasticity

In this section we present another existence result for a similar (to the previous one) nonlinear elasticity model.

Theorem 6.1. Let $\Omega \subset \mathbb{R}^{3}$ be an open, bounded and connected set with a regular (Lipschitzian) boundary denoted by $\partial \Omega$.

Consider the functional $J: U \rightarrow \mathbb{R}$ defined by

$$
\begin{align*}
J(u)= & \frac{1}{2} \int_{\Omega} H_{i j k l}\left(\frac{u_{i, j}+u_{j, i}}{2}+\frac{u_{m, i} u_{m, j}}{2}\right)\left(\frac{u_{k, l}+u_{l, k}}{2}+\frac{u_{p, k} u_{p, l}}{2}\right) d x \\
& -\left\langle P_{i}, u_{i}\right\rangle_{L^{2}}-\left\langle P_{i}^{t}, u_{i}\right\rangle_{L^{2}\left(\Gamma_{t}\right)} \tag{41}
\end{align*}
$$

where

$$
\partial \Omega=\Gamma=\Gamma_{0} \cup \Gamma_{t},
$$

$$
\Gamma_{0} \cap \Gamma_{t}=\emptyset
$$

$m_{\Gamma}\left(\Gamma_{0}\right)>0, m_{\Gamma}\left(\Gamma_{t}\right)>0, P_{i} \in L^{\infty}(\Omega) \cap W^{1,2}(\Omega), P_{i}^{t} \in L^{\infty}\left(\Gamma_{t}\right), \forall i \in\{1,2,3\}$.
Moreover

$$
U=\left\{u \in W^{1,4}\left(\Omega ; \mathbb{R}^{3}\right): u=\hat{u}_{0} \text { on } \Gamma_{0}\right\},
$$

where we assume $\hat{u}_{0} \in W^{1,4}(\Omega)$.

Furthermore, $\left\{H_{i j k l}\right\}$ is a fourth order symmetric constant tensor such that

$$
H_{i j k l} t_{i j} t_{k l} \geq c_{0} t_{i j} t_{i j}, \forall \text { symmetric } t \in \mathbb{R}^{2 \times 2}
$$

and

$$
H_{i j k l} t_{m i} t_{m j} t_{k p} t_{l p} \geq c_{1} \sum_{i, j=1}^{3} t_{i j}^{4}, \forall \text { symmetric } t \in \mathbb{R}^{2 \times 2}
$$

for some real constants $c_{0}>0, c_{1}>0$.
Under such hypotheses, there exists $u_{0} \in U$ such that

$$
J\left(u_{0}\right)=\min _{u \in U} J(u)
$$

Proof. First observe that we may find a positive definite tensor $\left\{T_{i j}\right\} \subset L^{\infty}\left(\Omega ; \mathbb{R}^{2 \times 2}\right) \cap W^{1,2}\left(\Omega ; \mathbb{R}^{2 \times 2}\right)$ such that

$$
T_{i j, j}+P_{i}=0, \text { in } \Omega
$$

Hence, denoting

$$
v_{i j}(u)=\frac{u_{i, j}+u_{j, i}}{2}+\frac{u_{m, i} u_{m, j}}{2}
$$

we have

$$
\frac{u_{i, j}+u_{j, i}}{2}=v_{i j}(u)-\frac{u_{m, i} u_{m, j}}{2}
$$

so that, from this, the Gauss-Green formula and the Trace Theorem,

$$
\begin{align*}
J(u)= & \frac{1}{2} \int_{\Omega} H_{i j k l} v_{i j}(u) v_{k l}(u) d x+\left\langle T_{i j, j}, u_{i}\right\rangle_{L^{2}}-\left\langle P_{i}, u_{i}\right\rangle_{L^{2}}-\left\langle P_{i}^{t}, u_{i}\right\rangle_{L^{2}\left(\Gamma_{t}\right)} \\
= & \frac{1}{2} \int_{\Omega} H_{i j k l} v_{i j}(u) v_{k l}(u) d x-\left\langle T_{i j}, \frac{u_{i, j}+u_{j, i}}{2}\right\rangle_{L^{2}} \\
& +\left\langle u_{i}, T_{i j} \nu_{j}\right\rangle_{L^{2}\left(\Gamma_{t}\right)}+\left\langle\left(u_{0}\right)_{i}, T_{i j} \nu_{j}\right\rangle_{L^{2}\left(\Gamma_{0}\right)}-\left\langle P_{i}, u_{i}\right\rangle_{L^{2}}-\left\langle P_{i}^{t}, u_{i}\right\rangle_{L^{2}\left(\Gamma_{t}\right)} \\
= & \frac{1}{2} \int_{\Omega} H_{i j k l} v_{i j}(u) v_{k l}(u) d x-\left\langle T_{i j}, v_{i j}(u)-\frac{u_{m, i} u_{m, j}}{2}\right\rangle_{L^{2}} \\
& +\left\langle u_{i}, T_{i j} \nu_{j}\right\rangle_{L^{2}\left(\Gamma_{t}\right)}+\left\langle\left(\hat{u}_{0}\right)_{i}, T_{i j} \nu_{j}\right\rangle_{L^{2}\left(\Gamma_{0}\right)}-\left\langle P_{i}, u_{i}\right\rangle_{L^{2}}-\left\langle P_{i}^{t}, u_{i}\right\rangle_{L^{2}\left(\Gamma_{t}\right)} \\
\geq & \frac{1}{2} \int_{\Omega} H_{i j k l} v_{i j}(u) v_{k l}(u) d x-\left\langle T_{i j}, v_{i j}(u)\right\rangle_{L^{2}}+\left\langle T_{i j}, \frac{u_{m, i} u_{m, j}}{2}\right\rangle_{L^{2}} \\
& -K_{3} \sum_{i=1}^{3}\left\|u_{i}\right\|_{1,4}-K_{3}\left\|\hat{u}_{0}\right\|_{1,4}, \forall u \in U \tag{42}
\end{align*}
$$

for some appropriate $K_{3}>0$.
From this, the hypotheses on $\left\{H_{i j k l}\right\}$ and a Poincaré type inequality, since $\left\{T_{i j}\right\}$ is positive definite, it is clear that $J$ is bounded below so that there exists $\alpha \in \mathbb{R}$ such that

$$
\alpha=\inf _{u \in U} J(u)
$$

Let $\left\{u_{n}\right\} \subset U$ be a minimizing sequence for $J$, that is, let such a sequence be such that

$$
J\left(u_{n}\right) \rightarrow \alpha, \quad \text { as } n \rightarrow \infty
$$

Also from the hypotheses on $\left\{H_{i j k l}\right\}$ and a Poincaré type inequality, we have that there exists $K>0$ such that

$$
\left\|u_{n}\right\|_{1,4} \leq K, \forall n \in \mathbb{N} .
$$

From the auxiliary result in the last section, there exists $u_{0} \in C^{0}\left(\bar{\Omega} ; \mathbb{R}^{3}\right) \cap W^{1,4}\left(\Omega ; \mathbb{R}^{3}\right)$ such that, up to a not relabeled subsequence,

$$
u_{n} \rightarrow u_{0}, \text { strongly in } W^{1,3}\left(\Omega ; \mathbb{R}^{3}\right)
$$

From such a latter result, up to a not relabeled subsequence, we may obtain

$$
\frac{\left(u_{n}\right)_{i, j}+\left(u_{n}\right)_{j, i}}{2}+\frac{\left(u_{n}\right)_{m, i}\left(u_{n}\right)_{m, j}}{2} \rightharpoonup \frac{\left(u_{0}\right)_{i, j}+\left(u_{0}\right)_{j, i}}{2}+\frac{\left(u_{0}\right)_{m, i}\left(u_{0}\right)_{m, j}}{2}, \text { weakly in } L^{3 / 2}(\Omega) .
$$

Also from the continuity of the Trace operator we get

$$
u_{0}=\hat{u}_{0}, \text { on } \Gamma_{0},
$$

so that $u_{0} \in U$.
Since $L^{3 / 2}(\Omega)$ is reflexive, from the convexity of $J$ in $\left\{v_{i j}(u)\right\}$ and since $\left\{T_{i j}\right\}$ is positive definite, we have that

$$
\alpha=\liminf _{n \rightarrow \infty} J\left(u_{n}\right) \geq J\left(u_{0}\right),
$$

so that,

$$
J\left(u_{0}\right)=\min _{u \in U} J(u)
$$

The proof is complete.
