# DIFFERENTIABILITY PROPERTIES FOR BOUNDARY CONTROL OF FLUID-STRUCTURE INTERACTIONS OF LINEAR ELASTICITY WITH NAVIER-STOKES EQUATIONS WITH MIXED-BOUNDARY CONDITIONS IN A CHANNEL

#### MICHAEL HINTERMÜLLER AND AXEL KRÖNER

ABSTRACT. In this paper we consider a fluid-structure interaction problem given by the steady Navier Stokes equations coupled with linear elasticity taken from [Lasiecka, Szulc, and Zochoswki, Nonl. Anal.: Real World Appl., 44, 2018]. An elastic body surrounded by a liquid in a rectangular domain is deformed by the flow which can be controlled by the Dirichlet boundary condition at the inlet. On the walls along the channel homogeneous Dirichlet boundary conditions and on the outflow boundary do-nothing conditions are prescribed. We recall existence results for the nonlinear system from that reference and analyze the control to state mapping generalizing the results of [Wollner and Wick, J. Math. Fluid Mech., 21, 2019] to the setting of the nonlinear Navier-Stokes equation for the fluid and the situation of mixed boundary conditions in a domain with corners.

#### 1. Introduction

The paper deals with fluid-structure interaction (FSI) problems given by a fluid flow around an elastic body in a rectangular channel with fixed walls in two space dimensions. The elastic body deforms under the flow and is modelled by linear elasticity, for the fluid we consider the steady Navier-Stokes equation with Dirichlet condition at the inlet, no-slip condition on the wall, and do-nothing condition on the outlet. The configuration is taken from Lasiecka, Szulc, and Zochoswki [LSZ18] who analyze existence of solutions to this FSI problem and existence of an optimal inflow profile, considered as a boundary control, which minimizes the drag at the interface of the elastic body and the fluid. Let g denote the Dirichlet inflow boundary values and (u, w, p) be the solution of the FSI problem after transforming the variables for the fluid to a reference domain, that means u solves the elasticity equation, (w, p) is the solution of the Navier-Stokes equation and both equations are coupled via the traction force at the interface and via coefficients in the Navier-Stokes equation. We show that the control to state map of the FSI problem

$$(1.1) B_r(\mathcal{G}_{3/2}) \to X^p, \quad g \mapsto (u, w, p)$$

with ball  $B_r(\mathcal{G}_{3/2})$  around zero with radius r>0 in the space  $\mathcal{G}_{3/2}$  defined in (2.23) and  $X^p$ , p > 2, defined in (3.15) is continuously Fréchet differentiable for sufficiently small r. The differentiability is a crucial property to derive first-order optimality conditions which are usually the starting point for characterizing optimal controls and numerical schemes to solve such type of optimal control problems. While the formal derivation of these optimality conditions for similar settings has been considered, see below, we leave the rigorous derivation of optimality conditions for this specific case for future work. Difficulties in the analysis to derive Fréchet differentiability arise from the fact that (i) we consider the nonlinear Navier-Stokes equation, (ii) the problem is formulated in a polygonal domain, (iii) we have mixed Dirichlet-Neumann boundary conditions, and (iv) the analysis is considered in a higher regularity setting. Differentiability of FSI problems with respect to data has been considered for the Stokes equation with Dirichlet boundary conditions in smooth domains coupled with linear elasticity in Wick and Wollner [WW19]. There the differentiability is obtained by the implicit function theorem which we apply also here following their ideas. Therefore, the linearized Navier-Stokes operator needs to be an isomorphism in suitable spaces; hence, main parts of the paper deal with the derivation of regularity results for this equation. We proceed in three steps following the procedure in [LSZ18]: (i) Derivation of a lower regularity result for the velocity pressure pair in  $W^{1,2} \times L^2$  based on Lax-Milgram arguments, (ii) derivation of a higher regularity result in  $W^{2,2} \times W^{1,2}$  which uses estimates from [LSZ18] which relies on results from the Agmon, Douglis, and Nirenberg [ADN59] theory on ellitpic systems, (iii) higher p-integrability, namely  $W^{2,p} \times W^{1,p}$  on compact subsets using commutator analysis. For the analysis of linear elasticity we rely on classical theory.

We give an overview about related literature. On FSI problems: Galdi and Kyed [GK09] analyze existence of steady FSI problems in smooth domains. Wick and Wollner [WW19] derived as mentioned the differentiability of steady FSI problems with respect to the problem data in smooth domains. For an introduction to evolutionary FSI problems we refer to Kaltenbacher et al [KKL+18]; moreover, see, e.g., Gunzburger et al. [DGHL03, DGHL04], Grandmont and Maday [GM00], and Ignatova, Kukavica, Lasiecka, and Tuffaha [IKLT17].

On optimal control and FSI: In [LSZ18] boundary control of a FSI problem with stationary Navier-Stokes equation is considered. The authors show existence of a unque solution of the underlying equation under a smallness condition as well as of an optimal control. This paper extends Grandmot [Gra02] in the sense that the problem is considered in a domain with corners and with mixed boundary conditions are allowed. In the later reference an elastic body surrounds the fluid and an additional volume constraint is imposed while in the former paper the elastic body is surrounded by the fluid, furthermore, a radial unbounded cost is considered. Rigorously derived first order optimality conditions have been, to the best knowledge of the authors, not been stated yet for the problem under consideration. Numerics including formally derived optimality conditions are considered, e.g., in Richter and Wick [RW13] where optimal control and parameter estimation for stationary FSI problems are considered.

For control of evolutionary FSI problems see, e.g. Feiler, Meidner, and Vexler [FMV16] who consider linear FSI systems with coupled linear Stokes equation and wave equation and derive optimality conditions and Moubachir and Zolesio [MZ06] who derive for an optimal control problem for nonlinear time-dependent FSI problem necessary optimality conditions formally. Existence of optimal control for the problem of minimizing flow turbulence in the case of a nonlinear fluid-structure interaction models is considered in Bociu et al. [BCMT15].

Finally, we remark that differentiablity properties of shape optimization problems for fluid-structure interation has been considered in Haubner, Ulbrich, and Ulbrich [HUU20].

**Notation:** Throughout the paper we use the usual notation for Lebesgue and Sobolev spaces. For spaces of type  $W^{s,p}(\Omega)^2$  ( $W^{s,p}(\Omega)^{2\times 2}$  resp.) we often omit the dimension. We define the symbolic expression

For matrices  $B_1$  and  $B_2$  in  $\mathbb{R}^{2 \times 2}$  we denote the Frobenius product by  $A \cdot B := \sum_{i,j=1}^2 A_{ij} B_{ij}$ . Sometimes we write 0 for the zero map. The dependence of a function f on another function g is indicated by f[g] while the dependence on the spatial variable x by f(x) = f[g](x). We use the following notation for the Jacobian of the flow map  $\Phi$  as a function of u




Figure 1. Domain.

For functions f and e and operators D we write for the commutator [f, D]e := fDe + D(fe). The space of linear bounded mappings from Banach space  $X_1$  to Banach space  $X_2$  we denote by  $L(X_1, X_2)$ .

The ball of radius r > 0 around zero in a Banach space W we denote by  $B_r(W)$ . Finally, c > 0 denotes a generic constant and  $c_{\varepsilon} > 0$  a constant depending on  $\varepsilon > 0$ . The Euclidean norm in  $\mathbb{R}^d$  is denoted by  $\|\cdot\|$ .

Structure of the paper: In Section 2 we introduce the physical setting as well as the flow map and transformation rules between the physical and reference domain, in Section 3 we introduce the Navier-Stokes system, the elasticity system, and the fluid-structure interaction system and prove existence of solutions, in Section 4 we show existence and a priori estimates for the linearized system in higher Sobolev norms, and in Section 5 we show the differentiability of the control to state mapping for the FSI system. In the appendix we recall the transformation of the Navier-Stokes equation and its linearization to the reference domain.

#### 2. The domain

We recall the problem setting from Lasiecka et al. [LSZ18]. Let  $D \subset \mathbb{R}^n$ , n=2,3, be a bounded domain with piecewise regular boundary  $\partial D$  and straight corners as shown in Figure 1. Further, let  $\Omega_1$  and  $\Omega_2$  be subsets of D with  $\Omega_1$  being a doughnut-like domain with boundary  $\partial \Omega_1 := \Gamma_{\rm int} \cup \Gamma_1$ . The exterior boundary of  $\Omega_2$  is denoted by  $\Gamma_{\rm ext} := \Gamma_{\rm in} \cup \Gamma_{\rm wall} \cup \Gamma_{\rm out}$ . In  $\Omega_1$  we consider a problem of linear elasticity for an elastic body with u denoting the displacement field. In the exterior subdomain  $\Omega_2$  we consider a Navier-Stokes problem for the motion of a fluid with velocity field denoted by  $\tilde{w}$ .

We consider a parallel fluid flow in the channel D containing the elastic body in  $\Omega_1$  which deforms due to the influence of surface forces by the fluid. The original boundary  $\Gamma_{\rm int} = \Gamma_{\rm int}[0]$  of  $\Omega_1$  transforms itself into  $\Gamma_{\rm int}[u]$  with elastic displacement u on  $\Gamma_{\rm int}$ , more precisely

This leads to a new domain  $\Omega_2[u]$  with boundaries  $\Gamma_{\rm in}$ ,  $\Gamma_{\rm out}$ ,  $\Gamma_{\rm wall}$ , and  $\Gamma_{\rm int}[u]$ . Variables in the physical domain are denoted with a tilde, cf. Table 1. The outer normal to  $\Omega_2$  is denoted by  $n_x$  and the one to  $\Omega_2[u]$  by  $n_y$ . The outer normal to  $\Omega_1$  is denoted by  $n_1$ .

2.1. The flow map and some transformation rules. In this section we introduce the flow map and study the transformation between the physical and reference domain. At first, we recall some standard operators. The trace operator (cf. [EG04, Thm. B.54])

*Proof.* We refer, e.g., to Casas, Mateos, and Raymond [CMR09, Lem. A.2]. 

In the following we set  $\phi[\eta] := (\phi_1[\eta_1], \phi_2[\eta_2])^{\top}$  for  $\phi_i$  defined in (2.4). Throughout the paper let the integrability exponent p > 2.

**Definition 2.2** (Flow map). For  $u \in W^{2,p}(\Omega_1)$ , and  $\phi$  defined in (2.5) the flow map is given by

Here,  $\Phi[u](x)$  lifts the boundary trace  $u|_{\Gamma_{\rm int}} = \gamma_{\Gamma_{\rm int}} u \in W^{1-1/p,p}(\Gamma_{\rm int})$  from the interface  $\Gamma_{\rm int}$  into  $\Omega_2[u] = \Phi(\Omega_2)$ , in particular we have  $\Omega_2 = \Omega_2[0] = \Phi^{-1}(\Omega_2[u])$ . We define  $U^p := W^{2,p}(\Omega_1)$ .

From Grandmont [Gra02] we recall the following properties stated there for a three dimensional spatial setting.

Moreover, A satisfies a condition of uniform ellipticity over  $B_{r_1}(U^p)$ , i.e. there exists a constant  $\beta > 0$  such that

(2.12) 
$$A(u)(x) \ge \beta id$$
, for all  $u \in B_{r_1}(U^p)$ , and all  $x \in \Omega_2$ .

*Proof.* (i) The mapping K[u] belongs to  $W^{1,p}(\Omega_2)$  since  $W^{1,p}(\Omega_2)$  is an algebra for p>2 (see Lemma C.1 with p=q). As a composition of  $C^{\infty}$  mappings it is smooth. (ii) For the first statement we apply the same arguments as in (i). For the second, we use that

(2.13) 
$$\Phi(u) = \mathrm{id} + \mathcal{D}(\gamma_{\Gamma_{\mathrm{int}}}(u)) \in W^{2,p}(\Omega_2), \quad \forall u \in W^{2,p}(\Omega_1).$$

Choosing  $r_1$  such that

(2.14) 
$$||u||_{W^{2,p}(\Omega_s)} \le r_1 \quad \text{implies} \quad ||\nabla(\mathcal{D}(\gamma_{\Gamma_{\text{int}}} u))||_{W^{1,p}(\Omega_2)} < \frac{1}{c},$$

where c is the constant in Lemma C.1, then id +  $\nabla(\mathcal{D}(\Gamma_{\text{int}}(b)))$  in an invertible matrix in  $W^{1,p}(\Omega_s)$  and we get the result.

For the proof of (ii.a) and (ii.b) we refer to Grandmont [Gra02, Lem. 2].

(iii) We recall the ideas from [Gra02, Lem. 3]. Let  $b \in B_p$ . That  $A[u] \in W^{1,p}(\Omega_2)$  follows from point (ii). As for the regularity of A, it is sufficient to show that the mapping:

(2.15) 
$$W^{1,p}(\Omega_2) \to W^{1,p}(\Omega_2), \quad T \mapsto T^{-1}$$

is infinitely differentiable at any invertible matrix of  $W^{1,p}(\Omega_2)$ . This can be proven by standard arguments, see [Car67, Chap. I]. The condition of uniform ellipticity of A over  $B_{r_1}(U^p)$  derives from continuity and compactness arguments  $(W^{1,p}(\Omega_2))$  is compactly embedded in  $C(\bar{\Omega}_2)$ ).

For the estimate for the derivative we use the boundedness of A on the bounded set  $B_{r_1}(U^p)$ .

2.2. **Transformation of integrals.** We recall some properties on the transformation of integrals and derivatives under a reference map.

For function  $\tilde{\pi}$  on the physical domain  $\Omega_2[u]$  we define the transformed function on the reference domain  $\Omega_2 = \Phi[u]^{-1}(\Omega_2[u])$  (for given u) by

(2.16) 
$$\pi(x) := \tilde{\pi}(y), \quad y = \Phi[u](x)$$

which is well-defined by Lemma 2.3 (ii). Moreover, we denote the determinant of the gradient of the flow map by

(2.17) 
$$J(\cdot) := \det(D\Phi(\cdot)).$$

As a direct consequence we have  $A[u] = J[u]^{-1}K[u]^{\top}K[u]$ .

**Lemma 2.4.** Let  $u \in B_{r_1}(U^p)$  and  $\Phi$  be defined by Proposition 2.7. Then, the following relations hold:

(i) Volume elements transform as

(2.18) 
$$\int_{\Omega_2[u]} 1 \mathrm{d}y = \int_{\Omega_2} J(x) \mathrm{d}x,$$

(ii) Boundary elements transform with  $J_{\Gamma}[u] := ||K[u]n_x||$  as

(2.19) 
$$\int_{\Gamma_{out}[u]} 1 ds_y = \int_{\Gamma_{out}} J_{\Gamma}[u] ds_x.$$

(iii) The gradient transforms as

(2.20) 
$$\nabla \tilde{f}(y) = D\Phi^{\top} \nabla f(x) \quad iff \quad \nabla = \frac{1}{J} K \nabla.$$

(iv) For the outer normal  $n_y$  to  $\Omega_2[u]$  and  $n_x$  to  $\Omega_2$  we have

(2.21) 
$$n_y = \frac{D\Phi^{-\top} n_x}{\|D\Phi^{-\top} n_x\|} = \frac{K n_x}{\|K n_x\|},$$

$$(2.22) \qquad \int_{\Gamma_{int}[u]} \tilde{p}(y) n_y \mathrm{d}s_y = \int_{\Gamma_{int}} p(x) \frac{\mathrm{cof}(\nabla \phi[u]) n_x}{\|\mathrm{cof}(\nabla \phi[u]) n_x\|} \|\mathrm{cof}(\nabla \phi[u]) n_x\| n_x \mathrm{d}s_x.$$

*Proof.* We refer to [LSZ18, Appendix A.1].

2.3. Transformation of the Navier-Stokes equation. We consider the Navier-Stokes system in  $\mathbb{R}^2$  with viscosity  $\nu > 0$ . We define

$$(2.23) \mathcal{G}_{\mu} := \left\{ g \in W^{\mu,2}(\Gamma_{\mathrm{in}}) : g|_{\partial \Gamma_{\mathrm{in}}} = 0 \right\}, \quad \text{for } \mu \in \left\{ \frac{1}{2}, \frac{3}{2} \right\}.$$

Let  $\tilde{w} = (\tilde{w}_1, \tilde{w}_2)^{\top}$  the fluid velocity and  $\tilde{p}$  the pressure in the physical domain  $\Omega_2[u] = \Phi[u](\Omega_1)$  satisfying

(2.24) 
$$\begin{cases} -\nu \Delta_x \tilde{w}_1 + \tilde{w}^\top \nabla \tilde{w}_1 + (\nabla \tilde{p})_1 = 0 & \text{in } \Omega_2[u], \\ -\nu \Delta_x \tilde{w}_2 + \tilde{w}^\top \nabla \tilde{w}_2 + (\nabla \tilde{p})_2 = 0 & \text{in } \Omega_2[u], \\ \nabla^\top \tilde{w} = 0 & \text{in } \Omega_2[u], \\ w = g & \text{on } \Gamma_{\text{in}}, \\ \tilde{w} = 0 & \text{on } \Gamma_{\text{wall}} \cup \Gamma_{\text{int}}[u], \\ -\nu D\tilde{w} \cdot n_y + \tilde{p} \cdot n_y = 0 & \text{on } \Gamma_{\text{out}} \end{cases}$$

and given data  $g \in \mathcal{G}_{1/2}$ . Let  $\Gamma_{\text{bd}} := \Gamma_{\text{in}} \cup \Gamma_{\text{wall}} \cup \Gamma_{\text{out}}$ , and we have by (2.5)  $\Phi = \text{id}_x$  on  $\Gamma_{\text{bd}}$  such that for trial functions  $\tilde{\psi}_1$  and  $\tilde{\psi}_2$  vanishing on  $\Gamma_{\text{bd}}$  also the transformed

 $\psi_1$  and  $\psi_2$  vanish on  $\Gamma_{\rm bd}$ . The transformed strong form of the Navier-Stokes system in  $\Omega_2$  is given by (cf. [LSZ18, Appendix A.1]), see also Appendix A,

(2.25) 
$$\begin{cases} -\nu \nabla (A[u]\nabla w) + w(K[u]\nabla)w + K[u]\nabla p = 0 & \text{in } \Omega_2, \\ (K[u]\nabla)^\top w = 0 & \text{in } \Omega_2, \\ w = g & \text{on } \Gamma_{\text{in}}, \\ w = 0 & \text{on } \Gamma_{\text{wall}} \cup \Gamma_{\text{int}}, \\ -\nu (A[u]\nabla w) \cdot n_x + pK[u] \cdot n_x = 0 & \text{on } \Gamma_{\text{out}}. \end{cases}$$

Since  $\Phi = \mathrm{id}_x$  on  $\Gamma_{\mathrm{ext}}$  we have  $Kn_x = n_x$  on  $\Gamma_{\mathrm{out}}$ 

## 3. Existence of solutions for the considered systems

In this section we consider the nonlinear Navier-Stokes system, the linear elasticity system, as well as the fluid-structure interaction model.

# 3.1. The Navier-Stokes system. For m = 0, 1, 2 we introduce

 $(3.1) \quad \widehat{W}^{m,p}(\Omega_2) := \{ v \in W^{m,2}(\Omega_2) : v \in W^{m,p}(\widehat{\Omega}_2) \text{ for } \widehat{\Omega}_2 \subset \Omega_2 \text{ compact} \},$ and further the spaces,

$$(3.2) W^p := \widehat{W}^{2,p}(\Omega_2) \times \widehat{W}^{1,p}(\Omega_2), W := W^{2,2}(\Omega_2) \times W^{1,2}(\Omega_2).$$

For a given compact subset  $\widehat{\Omega}_2 \subset \Omega_2$  we write

For a given compact subset 
$$M_2 \subset M_2$$
 we write 
$$W_{w,\widehat{\Omega}_2} := W^{2,p}(\widehat{\Omega}_2) \cap W^{2,2}(\Omega_2), \quad W_{p,\widehat{\Omega}_2} := W^{1,p}(\widehat{\Omega}_2) \cap W^{1,2}(\Omega_2);$$

$$W_{\widehat{\Omega}_2}^p := W_{w,\widehat{\Omega}_2} \times W_{p,\widehat{\Omega}_2};$$

$$(3.3)$$

note the different meaning of p here as upper and lower index.

**Theorem 3.1.** One can choose r > 0,  $r_1 > 0$ , and  $r_2 > 0$  such that for all  $g \in B_r(\mathcal{G}_{3/2})$  and  $u \in B_{r_1}(U^p)$  there exists a unique solution (w,p) in  $B_{r_2}(W^p)$  of (2.25). Moreover, for any compact subset  $\widehat{\Omega}_2 \subset \Omega_2$  the solution  $(w,p) \in B_{r_2}(W_{\widehat{\Omega}_2}^p)$ depends continuously on g.

*Proof.* We follow closely ideas from [LSZ18]. We consider the fixed point equation

(3.4) 
$$\mathcal{N}_g \colon B_{r_1}(W_{\widehat{\Omega}_2}^p) \to B_{r_1}(W_{\widehat{\Omega}_2}^p), \quad (w, p) = \mathcal{N}_g(\bar{w}, \bar{p}),$$

where  $\mathcal{N}_g$  maps for given  $g \in B_r(\mathcal{G}_{3/2})$  the point  $(\bar{w}, \bar{p})$  to the solution (w, p) of

$$\begin{cases} -\nu\nabla(\nabla w) + \nabla p = -\nu\nabla(\nabla(-A[u] + \mathrm{id})\bar{w}) \\ -(\bar{w}(K[u] - \mathrm{id})\nabla)\bar{w} - (K[u] - \mathrm{id})\nabla\bar{p} & \text{in } \Omega_2, \\ \mathrm{div}\,w = -((K[u] - \mathrm{id})\nabla)^\top\bar{w} & \text{in } \Omega_2, \\ w = g & \text{on } \Gamma_{\mathrm{in}}, \\ w = 0 & \text{on } \Gamma_{\mathrm{wall}} \cup \Gamma_{\mathrm{int}}, \\ -\nu\partial_n w + p \cdot n_x = \nu(\partial_{A[u],n} - \partial_n)\bar{w} - \bar{p}(K[u] - \mathrm{id}) \cdot n_x & \text{on } \Gamma_{\mathrm{out}}. \end{cases}$$

Existence follows by Banach's fixed point theorem, see [LSZ18, (68),(85)], using smallness of the data g.

The continuous dependence on the data follows by the contraction property of  $\mathcal{N}_g$  and the continuous dependence of the iterates on g. 

**Hypothesis 3.2.** For given  $r_2 > 0$  let r > 0 and  $r_1 > 0$  be sufficiently small such that for all  $g \in B_r(\mathcal{G}_{3/2})$  and  $u \in B_{r_1}(U^p)$  the Navier-Stokes equation (2.25) has a unique solution (w, p) in  $B_{r_2}(W^p)$ .

3.2. The elasticity system and the traction force. We set  $B:=\{\zeta\in W^{2,p}(\Omega_1):\zeta|_{\Gamma_1}=0\}$  and define the Neumann harmonic extension

(3.6) 
$$N \colon W^{1-1/p,p}(\Gamma_{\rm int}) \to B, \quad v \mapsto u =: Nv,$$

with u be the solution of

(3.7) 
$$\begin{cases} -\operatorname{div}\sigma[u] = 0 & \text{in } \Omega_{1}, \\ \sigma[u] = \mathcal{A}\varepsilon[u] & \text{on } \Omega_{1}, \\ u = 0 & \text{on } \Gamma_{1}, \\ \sigma[u] \cdot n_{1} = v \cdot n_{1} & \text{on } \Gamma_{\text{int}} \end{cases}$$

with outer normal  $n_1$  to  $\Omega_1$  strain tensor  $\varepsilon(u) := \frac{1}{2}(\nabla u + \nabla u^{\top})$ , Piola Kirchhoff stress tensor components  $\sigma = \sigma_{ij}$ , i, j = 1, 2, 3, and the elasticity tensor  $\mathcal{A} = a_{ijkl}$ ,  $i, j, k, l = 1, 2, c_0 > 0$  with

(3.8) 
$$a_{ijkl}\xi_{kl}\xi_{ij} \ge c_0 \|\xi\|^2$$
,  $\forall \xi_{ij}$ ,  $\xi_{ij} = \xi_{ji}$ , (positive definiteness),

(3.9) 
$$a_{ijkl} = a_{klij} = a_{jikl}, \quad a_{ijkl} \in L^{\infty}(\Omega_1)$$
 (symmetry),

vector  $n_1$  is the unit outward normal along  $\Gamma_{\text{int}}$  pointing from  $\Omega_1$  to  $\Omega_2$ . We call u the displacement field and will also consider the system with inhomogeneous right hand side

(3.10) 
$$\begin{cases} -\operatorname{div} \sigma[u] = f_1 & \text{in } \Omega_1, \\ \sigma[u] = \mathcal{A}\varepsilon[u] & \text{on } \Omega_1, \\ u = 0 & \text{on } \Gamma_1, \\ \sigma[u] \cdot n_1 = v \cdot n_1 & \text{on } \Gamma_{\text{int}}. \end{cases}$$

**Theorem 3.3.** (i) For  $f_1 \in L^p(\Omega_1)$  and  $v \in W^{1-1/p,p}(\Gamma_{int})$  system (3.7) has a unique solution  $u \in W^{2,p}(\Omega_1)$ , i.e. the Neumann harmonic extension is well-defined and we have

$$(3.11) ||Nv||_{W^{2,p}(\Omega_1)} \le c \left( ||v||_{W^{1-1/p,p}(\Gamma_{int})} + ||f_1||_{L^p(\Omega_1)} \right).$$

(ii) Moreover,

$$(3.12) S: L^p(\Omega_1) \times W^{1-1/p,p}(\Gamma_{int}) \to W^{2,p}(\Omega), \quad (f_1, v) \mapsto u$$

is continuously differentiable.

*Proof.* (i) We refer to Ciarlet [Cia88, Thm. 6.3-6 and p. 298], note that  $\Gamma_{\rm int}$  has positive distance to  $\Gamma_{\rm wall} \cup \Gamma_{\rm out} \cup \Gamma_{\rm in}$ .

Next, we define the traction force on the interface  $\Gamma_{\rm int}$ .

**Definition 3.4** (Traction map). Let  $u \in W^{2,p}(\Omega_1)$ . The traction force is given by

(3.13) 
$$t: W^{2,p}(\Omega_1) \times W^{1,2}(\Omega_2) \to W^{1/2,2}(\Gamma_{\rm int}),$$
$$(u,p) \mapsto t[u,p] := p[u]K[u] \cdot n_x \text{ on } \Gamma_{\rm int}$$

with p[u] the pressure in the solution of the Navier-Stokes equation (2.25) and K[u] given by (1.4).

Since  $p \in W^{1,p}(\widehat{\Omega}_2)$  for compact subsets  $\widehat{\Omega}_2 \subset \Omega_2$  and K[u] in  $W^{1,p}(\Omega_2)$  with p > 2, we have  $pK[u] \in W^{1,p}(\widehat{\Omega}_2)$  and so  $(pK[u])|_{\Gamma_{\text{int}}} \in W^{1/2,2}(\Gamma_{\text{int}})$ . Note that on the interface  $\Gamma_{\text{int}}$  we have w = 0.

3.3. The fluid-structure interation system. For  $g \in B_r(\mathcal{G}_{3/2})$  and  $f_1 = 0$  we can state the fluid-structure interaction model given as

(3.14) 
$$\begin{cases} (2.25) \text{ together with } u = Nt(u, p) \text{ in } \Omega_1 \\ \text{with } N \text{ and } t \text{ defined in (3.6) and (3.13)}. \end{cases}$$

For  $\widehat{\Omega}_2 \subset \Omega_2$  compact we introduce for 2 the spaces

$$(3.15) X_1^p := U^p \times W_{\widehat{\Omega}_2}^p, \quad X_2^p := U^p \times W, \quad X^p := X_1^p \cap X_2^p.$$

**Theorem 3.5.** For any  $\tilde{r} > 0$  there exist an r > 0 such that for  $g \in B_r(\mathcal{G}_{3/2})$  problem (3.14) has a unique solution  $(u, w, p) \in B_{\tilde{r}}(X^p)$  which depends continuously on the data.

*Proof.* We refer to [LSZ18, Thm. 3.2]. The proof uses a fixed-point argument based on estimates which we already cited in the proof of Theorem 3.1.

#### 4. The linearized equations

In this section we analyze the linearized Navier-Stokes equation in the domain  $\Omega_2$  and derive regularity results for its solution using techniques from [LSZ18] which are applied there for the Navier-Stokes equation.

We introduce the spaces

(4.1) 
$$\mathcal{H} := \{ w \in W^{1,2}(\Omega_2)^2 : w = 0 \text{ on } \Gamma_{\text{in}} \cup \Gamma_{\text{int}} \cup \Gamma_{\text{wall}} \}$$

and recall the property that for p>2 we have  $W^{1,p}(\Omega_2)\subset L^q(\Omega_2),\ 1\leq q\leq\infty.$  Moreover, for  $u\in U^p$  and  $(v,w,y)\in\Pi^3_{i=1}W^{1,2}(\Omega_2)^2$  we define

(4.2) 
$$c[u](v, w, y) := ((v \cdot K[u])\nabla w, y)_{L^{2}(\Omega_{2})}.$$

**Lemma 4.1.** Let  $u \in U^p$  and  $(v, w, y) \in \Pi^3_{i=1} W^{1,2}(\Omega_2)^2$ , then (4.2) can be estimated as

$$(4.3) |c[u](v, w, y)| \le c(u) \|v\|_{W^{1,2}(\Omega_2)^{2\times 2}} \|w\|_{L^4(\Omega_2)^2} \|y\|_{L^4(\Omega_2)^2}.$$

*Proof.* By Sobolev's embedding we have  $\partial_j v_i \in L^2(\Omega_2)$  and the functions  $w_j$  and  $y_i$  belong to  $L^4(\Omega_2)$  and hence,

$$(4.4) \qquad \int_{\Omega_2} |v_j \partial_j w_i z_i| \, \mathrm{d}x \le \int_{\Omega_2} |\partial_j v_i|^2 \, \mathrm{d}x \int_{\Omega_2} |w_j|^4 \, \mathrm{d}x \int_{\Omega_2} |z_i|^4 \, \mathrm{d}x$$

and we conclude.  $\Box$ 

In the following we write c(v, w, y) for c[0](v, w, y) with 0 denoting the zero map.

(4.5) 
$$f \in L^2(\Omega_2), \quad f_2 \in L^2(\Omega_2), \quad f_3 \in W^{-1/2,2}(\Gamma_{\text{out}}), \quad \delta g \in \mathcal{G}_{1/2}.$$

Let  $(\hat{w}, \hat{p}) \in W^p$  solution of the Navier-Stokes equation (2.25) be given. We consider the linearized Navier-Stokes system around this point with inhomogeneous right hand side given by

$$\begin{cases} -\nu \Delta z_w + (\hat{w}\nabla)z_w + (z_w\nabla)\hat{w} + \nabla z_p = f & \text{in } \Omega_2, \\ -(\nabla_y)^\top z_w = f_2 & \text{in } \Omega_2, \\ z_w = \delta g & \text{on } \Gamma_{\text{in}}, \\ z_w = 0 & \text{on } \Gamma_{\text{wall}} \cup \Gamma_{\text{int}}, \\ -\nu \partial_n z_w + z_p \cdot n_x = f_3 & \text{on } \Gamma_{\text{out}}. \end{cases}$$

Let  $F: W^{1,2}(\Omega_2) \to \mathbb{R}$  be given by

(4.7) 
$$F(v) := \int_{\Omega} (f + f_2) \cdot v dx + \int_{\Gamma_{\text{out}}} f_3 \cdot v dy, \quad v \in W^{1,2}(\Omega_2),$$

and for  $\hat{w} \in \mathcal{H}$  we define  $b_{\hat{w}} \colon \mathcal{H} \times \mathcal{H} \to \mathbb{R}$ , by

$$(4.8) b_{\hat{w}}(w,v) := \nu \int_{\Omega} \nabla w \cdot \nabla v dx + c(\hat{w}, w, v) + c(w, \hat{w}, v).$$

To address the linearized terms a smallness condition on the velocity  $\hat{w}$  is made, see also de los Reyes and Yousept [dlRY09].

**Lemma 4.2.** For  $r_2 > 0$  sufficiently small we have

(4.9) 
$$b_{\hat{w}}(v,v) \ge c \|v\|_{W^{1,2}(\Omega_2)}^2 \text{ for all } v \in W^{1,2}(\Omega_2);$$

moreover, the bilinear form  $b_{\hat{w}}(\cdot,\cdot)$  is continuous.

*Proof.* By Lemma 4.1 there exists an  $\varepsilon > 0$  such that

$$(4.10) \qquad \nu(\nabla v, \nabla v) + c(v, \hat{w}, w) + c(\hat{w}, v, v)$$

$$\geq \|\nabla v\|_{L^{2}(\Omega_{2})}^{2} - \varepsilon \|v\|_{L^{2}(\Omega_{4})}^{2} - \varepsilon \|\nabla v\|_{L^{2}(\Omega_{2})} \|v\|_{L^{2}(\Omega_{4})}$$

$$\geq \frac{\nu}{2} \|v\|_{W^{1,2}(\Omega_{2})}.$$

The continuity follows again from Lemma 4.1 and Sobolev's embedding.

The weak formulation for (4.6) is given as follows: Find  $z_w \in \mathcal{H}$  solution of

(4.11) 
$$\begin{cases} b_{\hat{w}}(z_w, v) - \int_{\Omega_2} z_p \nabla v dx = F(v) & \text{for all } v \in \mathcal{H}, \\ \operatorname{div} z_w = f_2 \text{ in } \Omega_2, \qquad z_w = \delta g \text{ on } \Gamma_{\text{in}}. \end{cases}$$

**Theorem 4.3.** For  $\|\hat{w}\|_{W^{1,2}(\Omega_2)}$  sufficiently small system (4.6) (resp. (4.11)) has a unique solution  $(z_w, z_p) \in W^{1,2}(\Omega_2) \times L^2(\Omega_2)$  with

$$(4.12) ||z_w||_{W^{1,2}(\Omega_2)} + ||z_p||_{L^2(\Omega_2)} \le c ||f||_{W^{-1,2}(\Omega_2)} + c ||f_2||_{L^2(\Omega_2)} + c ||f_3||_{W^{-1/2,2}(\Gamma_{cort})} + c ||\delta g||_{W^{1/2,2}(\Gamma_{cort})}.$$

Note, that this lower regularity existence and the estimate follows by classical Lax-Milgram arguments, see [LSZ18, Step 1] and also [MR10, Theorem 11.1.2], together with Lemma 4.2.

**Hypothesis 4.4.** Let  $r_2 > 0$  be sufficiently small such that for  $\hat{w} \in B_{r_2}(\widehat{W}^{2,p}(\Omega_2))$ equation (4.6) has a unique solution  $(z_w, z_p) \in W^{1,2}(\Omega_2) \times L^2(\Omega_2)$ .

Note, that here we consider a higher norm than necessary with respect to Theorem 4.3. This is due to the fact that later we will also estimate higher norms of  $\hat{w}.$ 

4.2. The linearized state equation. Let  $(\hat{w}, \hat{p})$  be given solution of the Navier-Stokes equation (2.25). We consider the in this point linearized equation with inhomogeneous right hand sides chosen as in (4.5) given by

$$\begin{cases} -\nu\Delta(A[u]z_w) + \hat{w}(K[u]\nabla)z_w + z_w(K[u]\nabla)\hat{w} + K[u]\nabla z_p = f & \text{in } \Omega_2, \\ (K[u]\nabla)^\top z_w = f_2 & \text{in } \Omega_2, \\ z_w = \delta g & \text{on } \Gamma_{\text{in}}, \\ z_w = 0 & \text{on } \Gamma_{\text{wall}} \cup \Gamma_{\text{int}}, \\ -\nu\partial_{A[u],n}z_w + z_pK[u] \cdot n_x = f_3 & \text{on } \Gamma_{\text{out}}. \end{cases}$$

We follow the approach from [LSZ18] where the nonlinear Navier-Stokes equation is analyzed and ideas from Grandmont [Gra02]. We recall a technical result which follows by a Taylor argument.

for some  $s \ge 1$  and  $q \ge 2$ .

We follow ideas in [LSZ18, Prop. 4.2, Lem. 4.3, Lem 4.4, and Lem. 4.5] developed there for the Navier-Stokes equation to analyze the linearized equation in (4.13). We start with a preliminary consideration which is later used in (4.29).

this will allow to define a sequence  $((z_{w,n}, z_{p,n}))_{n \in \mathbb{N}}$  with  $(z_{w,0}, z_{p,0})$  equal to some  $(\bar{z}_w, \bar{z}_p) \in W^p$  which we further analyze in Section 4.5 to obtain existence of a solution for (4.13).

Remark 4.9. The authors in [LSZ18] refer here to the notion of ellipticity for systems introduced in Agmon, Douglis, and Nirenberg [ADN59], see also Maz'ya and Rossmann [MR10, Sec. 1.1.3], and Bouchev and Gunzburger [BG09, Appendix D]. Following Beneš and Kučera [BK16, Appendix] the regularity is established at first locally for boundary points on the Dirichlet boundary part, the Neumann boundary

part, and then for the two corners where the different types of boundary conditions meet (the less standard result), see [LSZ18, Appendix A.3]. With cut-off functions the solutions are localized and the estimates are derived using [BG09, Thm. D.1]. Using the compactness of  $\bar{\Omega}$  global regularity is achieved.

## 5. Differentiability

In this section we show the main result, the differentiability of the mapping which maps the infow profile g to the velocity-pressure-deformation triple (u, w, p) of the fluid-structure interation system. We follow in parts ideas from [WW19] where linear elasticity is coupled with the Stokes equation with Dirichlet boundary conditions in a smooth domain. In a first step we consider the differentiability of the data-to-solution map g to (w, p) for the Navier-Stokes system and in particular of the traction operator  $\tau$ .

We introduce two systems, which will appear to be the linearized systems with respect to inflow data g and with respect to perturbation u, namely

$$\begin{pmatrix} -\nu \nabla (A'[u]\delta u \nabla w) + w(K'[u]\delta u \nabla)w + K'[u]\delta u \nabla p \\ (K'[u]\delta u \nabla)^{\top}w \\ 0 \\ -\nu (A'[u]\delta u \nabla w) \cdot n_x + pK'[u]\delta u \cdot n_x \end{pmatrix}$$

and (5.2) can be written as

(5.15) 
$$D_{(w,p)}e(u, w, p, g)(\delta w_u, \delta p_u) = -D_u e(u, w, p, g)$$

or equivalently by (5.2). Since

$$(5.16) \qquad \begin{array}{l} -\nu\nabla(A'(\hat{u})\delta u\nabla\hat{w}) + \hat{w}K'[\hat{u}]\delta u\nabla\hat{w} + K'[\hat{u}]\delta u\nabla\hat{p} \in \widehat{W}^{0,p}(\Omega_{2}) \cap L^{2}(\Omega_{2}), \\ -\nu(A'[u]\delta u\nabla w) \cdot n_{x} + pK'[u]\delta \cdot n_{x} \in W^{1-1/p,2}(\Gamma_{\mathrm{int}}) \end{array}$$

for p > 2, the right hand side in (5.15) has the suitable regularity and we conclude again with Theorem 4.15.

(ii) Follows directly from (ia). Note, that here we use that in the interior we have higher p-integrability and that  $\Gamma_{\rm int}$  is bounded away from  $\Gamma_{\rm ext}$ .

**Lemma 5.3.** Let Hypothesis 3.2 and 4.16 be satisfied. For  $g \in B_r(\mathcal{G}_{3/2})$  and  $u \in B_{r_1}(U^p)$  and  $\mathcal{F}$  given in (5.9) we have for any  $\varepsilon > 0$ 

(5.17) 
$$\left\| \frac{\mathrm{d}}{\mathrm{d}u} \mathcal{F}(u,g) \right\|_{L_{F}} \leq \varepsilon,$$

with  $L_F:=L(W^{2,p}(\Omega_1),W^{1-1/p,p}(\Gamma_{int}))$  provided that r and  $r_1$  are sufficiently small.

*Proof.* We write

(5.18) 
$$\mathcal{F}(u,g) = \tau(u,\mathcal{N}(g,u)).$$

By Lemma 5.2 and applying the chain rule, we get for any direction  $\delta u \in W^{2,p}(\Omega_1)$  that

(5.19) 
$$\frac{\mathrm{d}}{\mathrm{d}u}\mathcal{F}(u,g)\delta u = \frac{\mathrm{d}}{\mathrm{d}u}\tau(u,\mathcal{N}(g,u))\delta u.$$

By Theorem 3.1 we can choose for  $\delta > 0$  the radii r > 0 and  $r_1 > 0$  sufficiently small such that  $p \in B_{\delta}(W_p)$ . Using the smoothness of the outer normal on the interface taking into account that  $\Gamma_{\rm int}$  is bounded away from  $\Gamma_{\rm ext}$  and recalling that p > n we have

(5.20)

$$\begin{split} \left\| \frac{\mathrm{d}}{\mathrm{d}u} \mathcal{F}(u,g) \delta u \right\|_{W^{1-1/p,p}(\Gamma_{\mathrm{int}})} &\leq \|z_{p,a} K[u]\|_{W^{1,p}(\widehat{\Omega}_{2})} + \|p_{a}[u] K'[u] \delta u\|_{W^{1,p}(\widehat{\Omega}_{2})} \\ &\leq \|z_{p,a}\|_{W^{1,p}(\widehat{\Omega}_{2})} \|K[u]\|_{W^{1,p}(\widehat{\Omega}_{2})} \\ &+ \|p_{a}\|_{W^{1,p}(\widehat{\Omega}_{2})} \|K'[u] \delta u\|_{W^{1,p}(\widehat{\Omega}_{2})} \end{split}$$

with  $\widehat{\Omega}_2 \subset \Omega_2$  a compact subset containing  $\Omega_1$ . Note, that in (5.20) we use higher p-integrability of  $p_a$  whose support is bounded away from the boundary. Now, using the estimate in Theorem 4.15 applied to (5.2), we have for any  $\gamma > 0$  and data sufficiently small that

$$(5.21) \quad \left\| \frac{\mathrm{d}}{\mathrm{d}u} \mathcal{F}(u,g) \delta u \right\|_{W^{1-1/p,p}(\Gamma_{\mathrm{int}})} \leq \gamma \left\| \delta u \right\|_{W^{2,p}(\widehat{\Omega}_{2})} \quad \leq c \gamma \left\| \delta u \right\|_{W^{2-1/p,p}(\Gamma_{\mathrm{int}})}$$
$$\leq c \gamma \left\| \delta u \right\|_{W^{2,p}(\Omega_{1})}$$

which shows the assertion.

We state the main differentiability result on the mapping of the data to the solution of the fluid-structure interation problem.

**Theorem 5.4.** Let r > 0 be sufficiently small. Then, the mapping

(5.22) 
$$\Pi \colon B_r(\mathcal{G}_{3/2}) \to X^p, \quad g \mapsto (u[g], w[g], p[g])$$

with (u[g], w[g], p[g]) solution of (3.14) is continuously differentiable.

Remark 5.5. Here, it is not necessary to assume Hypothesis 3.2, 4.4, or 4.16 explicitly, since by Theorem 3.5 the existence of a solution of the FSI problem is in ball of radius  $\tilde{r}$  which we can choose arbitrary small if r > 0 is chosen accordingly sufficiently small. This guarantees implicitly the existence of a solution to the Navier-Stokes equation making Hypothesis 3.2 redundant as well as a sufficiently

small bound on the velocity of the Navier-Stokes equation and the solution of the elasticity system making Hypothesis 4.16 and so also Hypothesis 4.4 redundant.

*Proof of Theorem 5.4* We follow ideas from [WW19]. Existence of a solution of the fluid-structure interaction problem follows by Theorem 3.5. We have  $(u, w, p) = \Pi(g)$  and

(5.23) 
$$u = S\left(f_1, \mathcal{F}(\mathcal{D}(\gamma_{\Gamma_{\text{int}}}u), g)\right)$$

with S defined in Theorem 3.3 and  $\mathcal{F}$  given in (5.9). Since (w, p) depends continuously differentiable on (u, g) by Lemma 5.2, it is sufficient to show differentiability of the mapping  $g \mapsto u$  given by the above fix point relation (5.23). We apply the implicit function theorem. We note that

(5.24) 
$$D_2S\bigg(f_1, \mathcal{F}(\mathcal{D}(\gamma_{\Gamma_{\mathrm{int}}}u), g)\bigg) \colon W^{1-1/p, p}(\Omega_2) \to W^{2, p}(\Omega_2)$$

corresponds to the solution operator for the elasticity problem (3.7), see Theorem 3.3 and is hence, bounded. For

$$(5.25) D_u \mathcal{F}(\mathcal{D}(\gamma_{\Gamma_{\rm int}} u), g)(\delta u) \colon W^{2,p}(\Omega_1) \to W^{1-1/p,p}(\Gamma_{\rm int})$$

we use that by Lemma 5.3 the norm  $||D_u\mathcal{F}||_{L_F}$  can be made arbitrarily small choosing r sufficiently small and taking the continuous dependence of the solution of the FSI problem on the data into account, see Theorem 3.5. Thus,  $\mathrm{id} - D_2 S \circ D_u \mathcal{F}$  is invertible. By the implicit function theorem we obtain the continuous differentiability of the mapping  $\Pi$ .

#### APPENDIX A. TRANSFORMATION OF THE NAVIER-STOKES EQUATION

Following [LSZ18] we state the strong and weak formulation of the Navier-Stokes equation in the physical and reference domain. We have for the velocity  $(\tilde{w}_1, \tilde{w}_2)$  and pressure  $\tilde{p}$  in the physical domain  $\Omega_2[u]$ 

$$(A.1) \begin{split} -\nu \Delta_x \tilde{w}_1 + \tilde{w}^\top \nabla \tilde{w}_1 + (\nabla \tilde{p})_1 &= 0 &\quad \text{in } \Omega_2[u], \\ -\nu \Delta_x \tilde{w}_2 + \tilde{w}^\top \nabla \tilde{w}_2 + (\nabla \tilde{p})_2 &= 0 &\quad \text{in } \Omega_2[u], \\ \text{div } \tilde{w} &= 0 &\quad \text{in } \Omega_2[u], \\ \tilde{w} &= \delta g &\quad \text{on } \Gamma_{\text{in}}, \\ \tilde{w} &= 0 &\quad \text{on } \Gamma_{\text{wall}} \cup \Gamma_{\text{int}}, \\ -\nu D\tilde{w} \cdot n_y + \tilde{p} \cdot n_y &= 0 &\quad \text{on } \Gamma_{\text{out}}. \end{split}$$

Transforming to a weak form by multiplying with a test function, integration over  $\Omega_2[u]$ , and apply integration by parts we obtain

$$(A.2) \qquad -\nu \int_{\Gamma_{\text{out}}} \tilde{\psi}_{1} \nabla \tilde{w}_{1} n_{y} ds_{y} + \nu \int_{\Omega_{2}[u]} (\nabla \tilde{\psi}_{1})^{\top} (\nabla \tilde{w}_{1}) dy$$

$$+ \int_{\Omega_{2}[u]} \tilde{\psi}_{1} (\tilde{w}^{\top} \nabla) \tilde{w}_{1} dy + \int_{\Gamma_{\text{out}}} \tilde{\psi}_{1} \tilde{p}(n_{y})_{1} ds_{y}$$

$$- \int_{\Omega_{2}[u]} \tilde{p}(\nabla \tilde{\psi}_{1})_{1} dy =: I_{1} + I_{2} + I_{3} + I_{4} + I_{5} = 0.$$

We have by (2.19), (2.20), and (2.21) on the do-nothing outflow boundary part

(A.3) 
$$I_{1} := -\nu \int_{\Gamma_{\text{out}}} \tilde{\psi}_{1} \nabla \tilde{w}_{1} n_{y} ds_{y}$$

$$= -\nu \int_{\Gamma_{\text{out}}} \psi_{1} (G[u]^{-1} \nabla w_{1})^{\top} \frac{K[u] n_{x}}{\|K[u] n_{x}\|} \|K[u] n_{x}\| ds_{x}$$

$$= -\nu \int_{\Gamma_{\text{out}}} \psi_{1} (\nabla w_{1})^{\top} \left(\frac{1}{J} K^{\top} K\right) n_{x} ds_{x}$$

$$= -\nu \int_{\Gamma_{\text{out}}} \psi_{1} (\nabla w_{1})^{\top} A n_{x} ds_{x}.$$

For the diffusion term we have using (2.20)

$$I_{2} := \nu \int_{\Omega_{2}[u]} (\nabla \tilde{\psi}_{1})^{\top} (\nabla \tilde{w}_{1}) dy$$

$$= \nu \int_{\Omega_{2}} (\frac{1}{J} K \nabla \psi_{1})^{\top} (\frac{1}{J} K \nabla w_{1}) J dy$$

$$= \nu \int_{\Omega_{2}} (\nabla \psi_{1})^{\top} A (\nabla w_{1}) dx$$

$$= \nu \int_{\Gamma_{\text{out}}} \psi_{1} (n_{x}^{\top} A \nabla w_{1}) ds_{x} - \nu \int_{\Omega_{2}} \psi_{1} \nabla^{\top} (A \nabla w_{1}) dx.$$

The convection term transforms using (2.20) as follows (A.5)

$$I_3 := \int_{\Omega_2[u]} \tilde{\psi}_1(\tilde{w}^\top \nabla) \tilde{w}_1 dy = \int_{\Omega_2} \psi_1 w^\top \frac{1}{J} K \nabla w_1 J dx = \int_{\Omega_2} \psi_1 w^\top K \nabla w_1 dx.$$

For the boundary pressure term we have by (2.19) and (2.21)

(A.6) 
$$I_4 := \int_{\Gamma_{\text{out}}} \tilde{\psi}_1 \tilde{p}(n_y)_1 ds_y$$

$$= \int_{\Gamma_{\text{out}}} \psi_1 \left( p \frac{K n_x}{\|K n_x\|} \right)_1 \|K n_x\| ds_x$$

$$= \int_{\Gamma_{\text{out}}} \psi_1 p(K n_x)_1 ds_x.$$

Finally, for the volume pressure term we have

$$I_{5} := -\int_{\Omega_{2}[u]} \tilde{p}(\nabla \tilde{\psi}_{1})_{1} dy$$

$$= -\int_{\Omega_{2}} p(K \nabla \psi_{1})_{1} dx$$

$$= -\int_{\Gamma_{\text{out}}} \psi_{1} p(K n_{x})_{1} ds_{x} + \int_{\Omega_{2}} \psi_{1} p \operatorname{div}_{x}(K p)_{1} dx,$$

where

(A.8) 
$$\operatorname{div}_{x}(Kp)_{1} := \partial_{x_{1}}(k_{11}p) + \partial_{x_{2}}(k_{12}p).$$

Summarizing we obtain the weak formulation

(A.9) 
$$-\nu \int_{\Gamma_{\text{out}}} \psi_1(\nabla w_1)^\top A n_x ds_x + \nu \int_{\Omega_2} (\nabla \psi_1)^\top A (\nabla w_1) dx$$

$$+ \int_{\Omega_2} \psi_1 w^\top K \nabla w_1 dx + \int_{\Gamma_{\text{out}}} \psi_1 p(K n_x)_1 ds_x + \int_{\Omega_2} \psi_1 \operatorname{div}_x(K p)_1 dx = 0$$

$$(A.10) \quad \nu \int_{\Omega_2} (\nabla \psi_1)^{\top} A(\nabla w_1) dx + \int_{\Omega_2} \psi_1 w^{\top} K \nabla w_1 dx + \int_{\Omega_2} \psi_1 \operatorname{div}_x (Kp)_1 dx = \int_{\Gamma_{\text{out}}} f_3 v ds + \int_{\Omega_2} f v dx$$

and equivalently in strong form

$$\begin{cases} -\nu\nabla(A[u]\nabla w) + w(K[u]\nabla)w + K[u]\nabla p = 0 & \text{in } \Omega_2, \\ \operatorname{div}_{K^\top(u)}w = 0 & \text{in } \Omega_2, \\ w = \delta g & \text{on } \Gamma_{\mathrm{in}}, \\ w = 0 & \text{on } \Gamma_{\mathrm{wall}} \cup \Gamma_{\mathrm{int}}, \\ -\nu\partial_{A[u],n}w + pK[u] \cdot n_x = 0 & \text{on } \Gamma_{\mathrm{out}}. \end{cases}$$

# APPENDIX B. TRANSFORMATION OF THE LINEARIZED NAVIER-STOKES EQUATION

For the velocity  $(\tilde{w}_1, \tilde{w}_2)$  and pressure  $\tilde{p}$  in the physical domain  $\Omega_2[u]$  we have

$$-\nu \Delta_x \tilde{z}_{w_1} + \hat{w}^\top \nabla \tilde{z}_{w_1} + \tilde{z}_w^\top \nabla \hat{w}_1 + (\nabla \tilde{z}_p)_1 = 0 \quad \text{in } \Omega_2[u],$$

$$-\nu \Delta_x \tilde{z}_{w_2} + \tilde{w}^\top \nabla \tilde{z}_{w_2} + \tilde{z}_w^\top \nabla \hat{w}_2 + (\nabla \tilde{z}_p)_2 = 0 \quad \text{in } \Omega_2[u],$$

$$\text{div } \tilde{z}_w = 0 \quad \text{in } \Omega_2[u],$$

$$\tilde{z}_w = \delta g \quad \text{on } \Gamma_{\text{in}},$$

$$\tilde{z}_w = 0 \quad \text{on } \Gamma_{\text{wall}} \cup \Gamma_{\text{int}},$$

$$-\nu \partial_n \tilde{z}_w + \tilde{z}_p \cdot n_y = 0 \quad \text{on } \Gamma_{\text{out}}.$$

All linear terms are transformed as for the Navier-Stokes equation. The first term of the linearized convection term transforms using (2.20) as follows

(B.2) 
$$\int_{\Omega_2[u]} \tilde{\psi}_1(\tilde{w}^\top \nabla) z_{\tilde{w}_1} dy = \int_{\Omega_2} \psi_1 w^\top \frac{1}{J} K \nabla z_{w_1} J dx = \int_{\Omega_2} \psi_1 w^\top K \nabla z_{w_1} dx$$

and the second one accordingly. That means we have for the transformed equation in strong form

$$\begin{cases} -\nu \nabla (A[u] \nabla z_w) + z_w (K[u] \nabla) \hat{w} + \hat{w} (K[u] \nabla) z_w + K[u] \nabla z_p = 0 & \text{in } \Omega_2, \\ \operatorname{div}_{K[u]^\top} z_w = 0 & \text{in } \Omega_2, \\ z_w = 0 & \text{on } \Gamma_{\text{in}}, \\ z_w = \delta g & \text{on } \Gamma_{\text{wall}} \cup \Gamma_{\text{int}}, \\ -\nu \partial_{A[u], n_x} z_w + z_p K[u] \cdot n_x = 0 & \text{on } \Gamma_{\text{out}}. \end{cases}$$

#### APPENDIX C. SOME PROPERTIES

**Lemma C.1** (Algebra property). Let  $\Omega \subset \mathbb{R}^2$  be open and bounded. Furthermore, let p and q be real with  $2 , <math>p \geq q \geq 1$ . Then, for  $v \in W^{1,p}(\Omega)$  and  $u \in W^{1,q}(\Omega)$ , the product uv belongs to  $W^{1,q}(\Omega)$ , and we have

(C.1) 
$$||uv||_{W^{1,q}(\Omega)} \le \Omega ||u||_{W^{1,p}(\Omega)} ||v||_{W^{1,q}(\Omega)} .$$

Proof Immediate.

With the embedding of Sobolev in Hölder spaces we have for p > 2

(C.2) 
$$W^{2,p}(\Omega_2) \subset C^{1,\beta}(\bar{\Omega}_2) \subset C^{0,1}(\bar{\Omega}_2)$$
 for some  $\beta > 0$ 

and so [Alt16, p. 338 and p. 325]

(C.3) 
$$||v||_{W^{1,\infty}(\Omega_2)} = ||v||_{C^{0,1}(\bar{\Omega}_2)} \le c ||v||_{W^{2,p}(\Omega_2)} \quad \text{for } v \in W^{2,p}(\Omega_2).$$

For  $w \in W^{1,2}(\Omega_2)^2$  and recalling K[u] we have the following calculus rules: (C.4)

$$\operatorname{div}(K[u]) = 0$$
 (Piola's identity),

$$\operatorname{div}_{\operatorname{id}-K[u]^\top} w = ((\operatorname{id}-K[u])\nabla)^\top w = \operatorname{div} w - K[u]^\top \cdot \nabla w = (\operatorname{id}-K[u]^\top) \cdot \nabla w.$$
