# EIGENVALUES OF THE STURM-LIOUVILLE PROBLEM WITH A FROZEN ARGUMENT ON TIME SCALES

#### Abstract

In this study, we consider a boundary value problem generated by the Sturm-Liouville problem with a frozen argument and with non-separated boundary conditions on a time scale. Firstly, we present some solutions and characteristic function of the problem on an arbitrary bounded time scale. Secondly, we prove some properties of eigenvalues and obtain a formulation for the eigenvalues-number on a finite time scale. Finally, we give an asymptotic formula for eigenvalues of the problem on another special time scale: $\mathbb{T}=$ $\left[\alpha, \delta_{1}\right] \cup\left[\delta_{2}, \beta\right]$.


## 1. Introduction

A Sturm-Liouville equation with a frozen argument has the form

$$
-y^{\prime \prime}(t)+q(t) y(a)=\lambda y(t),
$$

where $q(t)$ is the potential function, $a$ is the frozen argument and $\lambda$ is the complex spectral parameter. The spectral analysis of boundary value problems generated with this equation is studied in several publications [3], [11, [12, [20], [27] and references therein. This kind problems are related strongly to non-local boundary value problems and appear in various applications [4], 8, [25] and [32].

A Sturm-Liouville equation with a frozen argument on a time scale $\mathbb{T}$ can be given as

-y^{\Delta \Delta}(t)+q(t) y(a)=\lambda y^{\sigma}(t), t \in \mathbb{T}^{\kappa^{2}} \tag{1}
\end{equation*}
$$

where $y^{\Delta \Delta}$ and $\sigma$ denote the second order $\Delta$-derivative of $y$ and forward jump operator on $\mathbb{T}$, respectively, $q(t)$ is a real-valued continuous function, $a \in \mathbb{T}^{\kappa}:=$ $\mathbb{T} \backslash(\rho(\sup \mathbb{T}), \sup \mathbb{T}], y^{\sigma}(t)=y(\sigma(t))$ and $\mathbb{T}^{\kappa^{2}}=\left(\mathbb{T}^{\kappa}\right)^{\kappa}$.

Spectral properties the classical Sturm-Liouville problem on time scales were given in various publications (see e.g. [1], [2], [5], 66, [13]-[19], [21]-[24], [28]- 31$]$ and references therein). However, there is no any publication about the SturmLiouville equation with a frozen argument on a time scale.

In the present paper, we consider a boundary value problem which is generated by equation (1) and the following boundary conditions

U(y) & :=a_{11} y(\alpha)+a_{12} y^{\Delta}(\alpha)+a_{21} y(\beta)+a_{22} y^{\Delta}(\beta)  \tag{2}\\
V(y) & :=b_{11} y(\alpha)+b_{12} y^{\Delta}(\alpha)+b_{21} y(\beta)+b_{22} y^{\Delta}(\beta) \tag{3}
\end{align*}
$$

[^0]where $\alpha=\inf \mathbb{T}, \beta=\rho(\sup \mathbb{T}), \alpha \neq \beta$ and $a_{i j}, b_{i j} \in \mathbb{R}$ for $i, j=1,2$. We aim to give some properties of some solutions and eigenvalues of (1)-(3) for two different cases of $\mathbb{T}$

For the basic notation and terminology of time scales theory, we recommend to see [7], 9], 10] and [26].

## 2. Preliminaries

Let $S(t, \lambda)$ and $C(t, \lambda)$ be the solutions of (1) under the initial conditions

& S(a, \lambda)=0, S^{\Delta}(a, \lambda)=1  \tag{4}\\
& C(a, \lambda)=1, C^{\Delta}(a, \lambda)=0 \tag{5}
\end{align*}
$$

respectively. Clearly, $S(t, \lambda)$ and $C(t, \lambda)$ satisfy

S^{\Delta \Delta}(t, \lambda)+\lambda S^{\sigma}(t, \lambda) & =0 \\
C^{\Delta \Delta}(t, \lambda)+\lambda C^{\sigma}(t, \lambda) & =q(t)
\end{aligned}
$$

respectively and so these functions and their $\Delta$-derivatives are entire on $\lambda$ for each fixed $t$ (see [28]).
Lemma 1. Let $\varphi(t, \lambda)$ be the solution of (1) under the initial conditions $\varphi(a, \lambda)=$ $\delta_{1}, \varphi^{\Delta}(a, \lambda)=\delta_{2}$ for given numbers $\delta_{1}, \delta_{2}$. Then $\varphi(t, \lambda)=\delta_{1} C(t, \lambda)+\delta_{2} S(t, \lambda)$ is valid on $\mathbb{T}$.

Proof. It is clear that the function $y(t, \lambda)=\delta_{1} C(t, \lambda)+\delta_{2} S(t, \lambda)$ is the solution of the initial value problem

$$
\begin{aligned}
y^{\Delta \Delta}(t)+\lambda y^{\sigma}(t) & =q(t) \delta_{1} \\
y(a, \lambda) & =\delta_{1} \\
y^{\Delta}(a, \lambda) & =\delta_{2} .
\end{aligned}
$$

We obtain by taking into account uniqueness of the solution of an initial value problem that $y(t, \lambda)=\varphi(t, \lambda)$.

Consider the function

$$
\Delta(\lambda): \operatorname{det}\left(\begin{array}{cc}
U(C) & V(C)  \tag{6}\\
U(S) & V(S)
\end{array}\right)
$$

It is obvious $\Delta(\lambda)$ is also entire.
Theorem 1. The zeros of the function $\Delta(\lambda)$ coincide with the eigenvalues of the problem (1)-(3).

Proof. Let $\lambda_{0}$ be an eigenvalue and $y\left(t, \lambda_{0}\right)=\delta_{1} C\left(t, \lambda_{0}\right)+\delta_{2} S\left(t, \lambda_{0}\right)$ is the corresponding eigenfunction, then $y\left(t, \lambda_{0}\right)$ satisfies (2) and (3). Therefore,

$$
\begin{aligned}
& \delta_{1} U\left(C\left(t, \lambda_{0}\right)\right)+\delta_{2} U\left(S\left(t, \lambda_{0}\right)\right)=0 \\
& \delta_{1} V\left(C\left(t, \lambda_{0}\right)\right)+\delta_{2} V\left(S\left(t, \lambda_{0}\right)\right)=0
\end{aligned}
$$

It is obvious that $y\left(t, \lambda_{0}\right) \neq 0$ iff the coefficients-determinant of the above system vanishes, i.e., $\Delta\left(\lambda_{0}\right)=0$.

Since $\Delta(\lambda)$ is an entire function, eigenvalues of the problem (1)-(3) are discrete.

## 3. Eigenvalues of (1)-(3) on a finite time scale

Let $\mathbb{T}$ be a finite time scale such that there are $m$ (or $r$ ) many elements which are larger (or smaller) than $a$ in $\mathbb{T}$. Assume $m \geq 1, r \geq 0$ and $r+m \geq 2$. It is clear that the number of elements of $\mathbb{T}$ is $n=m+r+1$. We can write $\mathbb{T}$ as follows

$$
\mathbb{T}=\left\{\rho^{r}(a), \rho^{r-1}(a), \ldots, \rho^{2}(a), \rho(a), a, \sigma(a), \sigma^{2}(a), \ldots, \sigma^{m-1}(a), \sigma^{m}(a)\right\}
$$

where $\sigma^{j}=\sigma^{j-1} \circ \sigma, \rho^{j}=\rho^{j-1} \circ \rho$ for $j \geq 2, \rho^{r}(a)=\alpha$ and $\sigma^{m-1}(\alpha)=\beta$.

Lemma 2. i) If $r \geq 3$ and $m \geq 2$, the following equalities hold for all $\lambda$

& S(\alpha, \lambda)=(-1)^{r} \mu^{\rho}(a)\left[\mu^{\rho^{2}}(a) \mu^{\rho^{3}}(a) \ldots \mu^{\rho^{r}}(a)\right]^{2} \lambda^{r-1}+O\left(\lambda^{r-2}\right) \\
& S^{\sigma}(\alpha, \lambda)=(-1)^{r-1} \mu^{\rho}(a)\left[\mu^{\rho^{2}}(a) \mu^{\rho^{3}}(a) \ldots \mu^{\rho^{r-1}}(a)\right]^{2} \lambda^{r-2}+O\left(\lambda^{r-3}\right) \\
& S(\beta, \lambda)=S^{\sigma^{m-1}}(a, \lambda)=(-1)^{m}\left[\mu(a) \mu^{\sigma}(a) \ldots \mu^{\sigma^{m-3}}(a)\right]^{2} \lambda^{m-2} \mu^{\sigma^{m-2}}(a)+O\left(\lambda^{m-3}\right) \\
& S^{\sigma}(\beta, \lambda)=S^{\sigma^{m}}(a, \lambda)=(-1)^{m+1}\left[\mu(a) \mu^{\sigma}(a) \ldots \mu^{\sigma^{m-2}}(a)\right]^{2} \lambda^{m-1} \mu^{\sigma^{m-1}}(a)+O\left(\lambda^{m-2}\right) \\
& C(\alpha, \lambda)=(-1)^{r}\left[\mu^{\rho}(a) \mu^{\rho^{2}}(a) \ldots \mu^{\rho^{r}}(a)\right]^{2} \lambda^{r}+O\left(\lambda^{r-1}\right) \\
& C^{\sigma}(\alpha, \lambda)=(-1)^{r-1}\left[\mu^{\rho}(a) \mu^{\rho^{2}}(a) \ldots \mu^{\rho^{r-1}}(a)\right]^{2} \lambda^{r-1}+O\left(\lambda^{r-2}\right) \\
& C(\beta, \lambda)=C^{\sigma^{m-1}}(a, \lambda)=(-1)^{m} \mu(a)\left[\mu^{\sigma}(a) \mu^{\sigma^{2}}(a) \ldots \mu^{\sigma^{m-3}}(a)\right]^{2} \mu^{\sigma^{m-2}}(a) \lambda^{m-2}+ \\
& O\left(\lambda^{m-3}\right) \\
& C^{\sigma}(\beta, \lambda)=C^{\sigma^{m}}(a, \lambda)=(-1)^{m+1} \mu(a)\left[\mu^{\sigma}(a) \mu^{\sigma^{2}}(a) \ldots \mu^{\sigma^{m-2}}(a)\right]^{2} \mu^{\sigma^{m-1}}(a) \lambda^{m-1}+ \\
& O\left(\lambda^{m-2}\right),
\end{aligned}
$$

where $O\left(\lambda^{l}\right)$ denotes polynomials whose degrees are $l$.
ii) If $r \in\{0,1,2\}$ or $m \in\{0,1\}$, degrees of all above functions are vanish.

Proof. It is clear from $f^{\sigma}(t)=f(t)+\mu(t) f^{\Delta}(t)$ that $S^{\sigma}(a, \lambda)=\mu(a)$ and $C^{\sigma}(a, \lambda)=$ 1. On the other hand, since $S(t, \lambda)$ and $C(t, \lambda)$ satisfy (1) then the following equalities hold for each $t \in \mathbb{T}^{\kappa}$ and for all $\lambda$.

$$
\begin{align*}
S^{\sigma^{2}}(t, \lambda)= & \left(1+\frac{\mu(t)}{\mu^{\sigma}(t)}-\lambda \mu(t) \mu^{\sigma}(t)-\lambda \mu^{2}(t) \mu^{\sigma}(t)\right) S^{\sigma}(t, \lambda)  \tag{7}\\
& -\mu^{\sigma}(t) S(t, \lambda) \\
C^{\sigma^{2}}(t, \lambda)= & \left(-\mu(t) \mu^{\sigma}(t) \lambda+\frac{\mu(t)+\mu^{\sigma}(t)}{\mu(t)}\right) C^{\sigma}(t, \lambda)  \tag{8}\\
& +\mu(t) \mu^{\sigma}(t) q(t)
\end{align*}
$$

It can be calculated from (7) and (8) that

$$
\begin{align*}
(9) S^{\sigma^{j}}(a, \lambda)= & (-1)^{j+1}\left(\mu(a) \mu^{\sigma}(a) \ldots \mu^{\sigma^{j-2}}(a)\right)^{2} \mu^{\sigma^{j-1}}(a) \lambda^{j-1}  \tag{9}\\
& +O\left(\lambda^{j-2}\right) \\
(10) S^{\rho^{j}}(a, \lambda)= & (-1)^{j} \mu^{\rho}(a)\left(\mu^{\rho^{2}}(a) \mu^{\rho^{3}}(a) \ldots \mu^{\rho^{j}}(a)\right)^{2} \lambda^{j-1} \\
& +O\left(\lambda^{j-2}\right) \\
(11) C^{\sigma^{k}}(a, \lambda)= & (-1)^{k+1} \mu(a)\left(\mu^{\sigma}(a) \mu^{\sigma^{2}}(a) \ldots \mu^{\sigma^{k-2}}(a)\right)^{2} \mu^{\sigma^{k-1}}(a) \lambda^{k-1}  \tag{11}\\
& +O\left(\lambda^{k-2}\right) \\
(12) C^{\rho^{k}}(a, \lambda)= & (-1)^{k}\left(\mu^{\rho}(a) \mu^{\rho^{2}}(a) \ldots \mu^{\rho^{k}}(a)\right)^{2} \lambda^{k} \\
& +O\left(\lambda^{k-1}\right)
\end{align*}
$$

for $j=2,3, \ldots m$ and $k=2,3, \ldots, r$. Using (9)-(12) and taking into account $\alpha=$ $\rho^{r}(a)$ and $\beta=\sigma^{m-1}(\alpha)$ we have our desired relations.

Corollary 1. $\operatorname{deg} C(\alpha, \lambda) S^{\sigma}(\beta, \lambda)=\left\{\begin{array}{cc}r+m-1, & r>0 \text { and } m>1 \\ 1, & \text { the other cases }\end{array}\right.$,

Lemma 3. The following equlaties hold for all $\lambda \in \mathbb{C}$.

S^{\sigma}(\alpha, \lambda) C(\alpha, \lambda)-S(\alpha, \lambda) C^{\sigma}(\alpha, \lambda) & =A \lambda^{\delta}+O\left(\lambda^{\delta-1}\right) \\
S^{\sigma}(\beta, \lambda) C(\beta, \lambda)-S(\beta, \lambda) C^{\sigma}(\beta, \lambda) & =B \lambda^{\gamma}+O\left(\lambda^{\gamma-1}\right)
\end{aligned}
$$

where $A=(-1)^{r} \mu(\alpha) \mu^{\rho}(a)\left[\mu^{\rho^{2}}(a) \ldots \mu^{\rho^{r-1}}(a)\right]^{2} \mu^{\rho^{r}}(a) q(\alpha)$,
$B=(-1)^{m-1} \mu(\beta)\left[\mu(a) \mu^{\sigma}(a) \ldots \mu^{\sigma^{m-2}}(a)\right]^{2} q(\rho(\beta))$,
$\delta=\left\{\begin{array}{c}r-2, \quad r \geq 3 \\ 0, \quad r<3\end{array} \quad\right.$ and $\gamma=\left\{\begin{array}{c}m-2, \quad m \geq 3 \\ 0, \quad m<3 .\end{array}\right.$
Proof. Consider the function

$$
\begin{equation*}
\varphi(t, \lambda):=\frac{1}{\mu(t)}\left[S^{\sigma}(t, \lambda) C(t, \lambda)-S(t, \lambda) C^{\sigma}(t, \lambda)\right] \tag{13}
\end{equation*}
$$

It is clear that

$$
\varphi(t, \lambda):=\left[S^{\Delta}(t, \lambda) C(t, \lambda)-S(t, \lambda) C^{\Delta}(t, \lambda)\right]=W[C(t, \lambda), S(t, \lambda)]
$$

and it is the solution of initial value problem

$$
\begin{aligned}
\varphi^{\Delta}(t) & =-q(t) S^{\sigma}(t, \lambda) \\
\varphi(a) & =1
\end{aligned}
$$

Therefore, we can obtain the following relations

$$
\begin{align*}
\varphi^{\sigma}(t, \lambda) & =\varphi(t, \lambda)-\mu(t) q(t) S^{\sigma}(t, \lambda)  \tag{14}\\
\varphi^{\rho}(t, \lambda) & =\varphi(t, \lambda)+\mu^{\rho}(t) q(\rho(t)) S(t, \lambda) \tag{15}
\end{align*}
$$

By using (9), (10), (14) and (15), the proof is completed.

Corollary 2. i) $\operatorname{deg}\left(S^{\sigma}(\alpha, \lambda) C(\alpha, \lambda)-S(\alpha, \lambda) C^{\sigma}(\alpha, \lambda)\right)<\operatorname{deg} C(\alpha, \lambda) S^{\sigma}(\beta, \lambda)$,
ii) $\operatorname{deg}\left(S^{\sigma}(\beta, \lambda) C(\beta, \lambda)-S(\beta, \lambda) C^{\sigma}(\beta, \lambda)\right)<\operatorname{deg} C(\alpha, \lambda) S^{\sigma}(\beta, \lambda)$.

The next theorem gives the number of eigenvalues of the problem (1)-(3) on $\mathbb{T}$. Recall $n=m+r+1$ denotes the number of elements of $\mathbb{T}$ and put $A=$ $\left(\begin{array}{cc}a_{11} \mu(\alpha)-a_{12} & b_{11} \mu(\alpha)-b_{12} \\ a_{22} & b_{22}\end{array}\right)$.

Theorem 2. If $\operatorname{det} A \neq 0$, the problem (1)-(3) has exactly $n-2$ many eigenvalues with multiplications, otherwise the eigenvalues-number of (1)-(3) is least than $n-2$.

Proof. Since $\mathbb{T}$ is finite, $\Delta(\lambda)$ is a polinomial and its degree gives the number eigenvalues of the problem. It can be calculated from (6)-(14) that

\Delta(\lambda)= & \frac{1}{\mu(\alpha) \mu(\beta)} \operatorname{det}\left(\begin{array}{cc}
a_{11} \mu(\alpha)-a_{12} & b_{11} \mu(\alpha)-b_{12} \\
a_{22} & b_{22}
\end{array}\right) C(\alpha, \lambda) S^{\sigma}(\beta, \lambda)+ \\
& +\frac{1}{\mu(\alpha)} \operatorname{det}\left(\begin{array}{cc}
a_{11} & a_{12} \\
b_{11} & b_{12}
\end{array}\right)\left(S^{\sigma}(\alpha, \lambda) C(\alpha, \lambda)-S(\alpha, \lambda) C^{\sigma}(\alpha, \lambda)\right)+ \\
& +\frac{1}{\mu(\beta)} \operatorname{det}\left(\begin{array}{ll}
a_{21} & a_{22} \\
b_{21} & b_{22}
\end{array}\right)\left(S^{\sigma}(\beta, \lambda) C(\beta, \lambda)-S(\beta, \lambda) C^{\sigma}(\beta, \lambda)\right)+O\left(\lambda^{n+m-2}\right) .
\end{aligned}
$$

According to Corollary 1 and Corollary 2, if $\operatorname{det} A \neq 0, \operatorname{deg} \Delta(\lambda)=\operatorname{deg} C(\alpha, \lambda) S^{\sigma}(\beta, \lambda)=$ $m+r-1=n-2$.

Corollary 3. i) The eigenvalues-number of (1)-(3) depends only on the elementsnumber of $\mathbb{T}$ and the coefficients of the boundary conditions (2) and (3). On the other hand, it does not depend on $q(t)$ and a (neither value nor location of a on $\mathbb{T}$ ). ii) If $\operatorname{det} A \neq 0$, the eigenvalues-number of (1)-(3) and the elements-number of $\mathbb{T}$ determine uniquely each other.

Example 1 (Separated boundary conditions). Let us consider the time scale $\mathbb{T}=\{0,1,2, \ldots, n-1\}$ and the following boundary value problem which appears some applications.

$$
\begin{align*}
& -y^{\Delta \Delta}(t)+q(t) y(a)=\lambda y(t+1), t \in \mathbb{T}^{\kappa^{2}}=\{0,1, \ldots, n-3\}  \tag{16}\\
& y^{\Delta}(0)+h y(0)=0  \tag{17}\\
& y^{\Delta}(n-2)+H y(n-2)=0 \tag{18}
\end{align*}
$$

where $0 \leq a \leq n-2$ and $h, H \in \mathbb{R}$. According to Theorem 2, if $h \neq 1$, the eigenvalues-number of this problem is exactly $n-2$, otherwise less than $n-2$.

Now, we want to give a theorem which includes some informations about the eigenvalues of (16)-(18).

Theorem 3. Let $Q=Q_{1}+Q_{2}$,
$Q_{1}=\left(\begin{array}{cccccccccc}2-\frac{1}{1-h} & -1 & 0 & 0 & 0 & \ldots & 0 & 0 & 0 & 0 \\ -1 & 2 & -1 & 0 & 0 & \ldots & 0 & 0 & 0 & 0 \\ 0 & -1 & 2 & -1 & 0 & \ldots & 0 & 0 & 0 & 0 \\ . & . & . & . & . & . & . & . & . & . \\ . & . & . & . & . & . & . & . & . & . \\ . & . & . & . & . & . & . & . & . & . \\ 0 & 0 & 0 & 0 & 0 & -1 & 2 & -1 & 0 & 0 \\ 0 & 0 & 0 & 0 & 0 & 0 & -1 & 2 & -1 & 0 \\ 0 & 0 & 0 & 0 & 0 & 0 & 0 & -1 & 2 & -1 \\ 0 & 0 & 0 & 0 & 0 & 0 & 0 & 0 & -1 & 1-H\end{array}\right)_{(n-2) \times(n-2)}$ and $Q_{2}=\left(q_{i j}\right)_{(n-2) \times(n-2)}$, where $q_{i j}=\left\{\begin{array}{c}q(i-1), \quad j=a \\ 0, \quad j \neq a\end{array}\right.$ and $h \in \mathbb{R}-\{1\}$.

The problem (16)-(18) and the matrix $Q$ have the same eigenvalues.
Proof. Let $y(t)$ be an eigenfunction of (16)-(18). Since $y^{\Delta}(t)=y(t+1)-y(t)$ for $t \in \mathbb{T}^{\kappa}$ and $y^{\Delta \Delta}(t)=y(t+2)-2 y(t+1)+y(t)$ for $t \in \mathbb{T}^{\kappa^{2}}$, we can write (16)-(18) as follows

$$
\begin{align*}
y(t+2)-2 y(t+1)+y(t) & =q(t) y(a)-\lambda y(t+1), t \in \mathbb{T}^{\kappa^{2}}  \tag{19}\\
y(1) & =(h-1) y(0)  \tag{20}\\
y(n) & =(1-H) y(n-1) . \tag{21}
\end{align*}
$$

We obtain from (19)-(21) a linear system whose coefficients-matrix is $\lambda I-Q$. Therefore it is concluded that the boundary value problem (16)-(18) and the matrix $Q$ have the same eigenvalues.

Remark 1. The result in the Theorem 3 can be generalized easily to (1)-(3) on the general discrete time scale.

Remark 2. As is known, all eigenvalues of the classical Sturm-Liouville problem with separated boundary conditions on time scales are real and algebraicly simple [2]. However, the Sturm-Liouville problem with the frozen argument may have non-real or non-simple eigenvalues even if it is equipped with separated boundary conditions.

We end this section with two examples. The problem in the first example has non-real or non-simple eigenvalues, unlike, all eigenvalues of the latter problem are real and simple.

Example 2. Consider the following problem on $\mathbb{T}=\{0,1,2,3,4,5\}$.

$$
L_{1}:\left\{\begin{array}{c}
-y^{\Delta \Delta}(t)+q_{1}(t) y(3)=\lambda y^{\sigma}(t), t \in\{0,1,2,3\} \\
y^{\Delta}(0)+\frac{1}{2} y(0)=0 \\
y^{\Delta}(4)+y(4)=0
\end{array}\right.
$$

where $q_{1}(t)=\left\{\begin{array}{cc}-3 & t=0 \\ 10 & t=1 \\ -5 & t=2 \\ 1 & t=3\end{array}\right.$. According to Theorem 3, eigenvalues of $L_{1}$ coincide with eigenvalues of the matrix $Q_{1}=\left(\begin{array}{cccc}0 & -1 & -3 & 0 \\ -1 & 2 & 9 & 0 \\ 0 & -1 & -3 & -1 \\ 0 & 0 & 0 & 0\end{array}\right)$ and they are $\lambda_{1}=$ $\lambda_{2}=0, \lambda_{3}=-\frac{1}{2}+\frac{1}{2} i \sqrt{7}, \lambda_{4}=-\frac{1}{2}-\frac{1}{2} i \sqrt{7}$.
Example 3. Consider the following problem on $\mathbb{T}=\{0,1,2,3,4,5\}$.

$$
L_{2}:\left\{\begin{array}{c}
-y^{\Delta \Delta}(t)+q_{2}(t) y(4)=\lambda y^{\sigma}(t), t \in\{0,1,2,3\} \\
y^{\Delta}(0)=0 \\
y^{\Delta}(4)=0
\end{array}\right.
$$

where $q_{2}(t)=t$.
Clearly, eigenvalues of $L_{2}$ coincide with eigenvalues of $Q_{2}=\left(\begin{array}{cccc}1 & -1 & 0 & 0 \\ -1 & 2 & -1 & 1 \\ 0 & -1 & 2 & 1 \\ 0 & 0 & -1 & 4\end{array}\right)$
and they are $\lambda_{1}=2+\sqrt{3}, \lambda_{2}=2-\sqrt{3}, \lambda_{3}=3, \lambda_{4}=2$.

## 4. Eigenvalues of (1)-(3) on the time scale $\mathbb{T}=\left[\alpha, \delta_{1}\right] \cup\left[\delta_{2}, \beta\right]$

In this section, we investigate eigenvalues of the problem (1)-(3) on another special time scale: $\mathbb{T}=\left[\alpha, \delta_{1}\right] \cup\left[\delta_{2}, \beta\right]$, where $\alpha<a<\delta_{1}<\delta_{2}<\beta$. We assume that $a \in\left(\alpha, \delta_{1}\right)$. The similar results can be obtained in the case when $a \in\left(\delta_{2}, \beta\right)$.

The following relations are valid on $\left[\alpha, \delta_{1}\right]$ (see [11]).

$$
\begin{aligned}
S(t, \lambda) & =\frac{\sin \sqrt{\lambda}(t-a)}{\sqrt{\lambda}} \\
C(t, \lambda) & =\cos \sqrt{\lambda}(t-a)+\int_{a}^{t} \frac{\sin \sqrt{\lambda}(t-\xi)}{\sqrt{\lambda}} q(\xi) d \xi
\end{aligned}
$$

The following asymptotic relations for the solutions $S(t, \lambda)$ and $C(t, \lambda)$ can be proved by using a method similar to one in 29.
$S(t, \lambda)=\left\{\begin{array}{c}\frac{\sin \sqrt{\lambda}(t-a)}{\sqrt{\lambda}}, \quad t \in\left[\alpha, \delta_{1}\right], \\ \delta^{2} \sqrt{\lambda} \cos \sqrt{\lambda}\left(\delta_{1}-a\right) \sin \sqrt{\lambda}\left(\delta_{2}-t\right)+O(\exp |\tau|(\delta+a-t)), t \in\left[\delta_{2}, \beta\right],\end{array}\right.$
$S^{\Delta}(t, \lambda)=\left\{\begin{array}{c}\cos \sqrt{\lambda}(t-a), \quad t \in\left[\alpha, \delta_{1}\right), \\ -\delta^{2} \lambda \cos \sqrt{\lambda}\left(\delta_{1}-a\right) \cos \sqrt{\lambda}\left(\delta_{2}-t\right)+O(\sqrt{\lambda} \exp |\tau|(\delta+a-t)), t \in\left[\delta_{2}, \beta\right],\end{array}\right.$

$$
C(t, \lambda)=\left\{\begin{array}{c}
\cos \sqrt{\lambda}(t-a)+O\left(\frac{1}{\sqrt{\lambda}} \exp |\tau||t-a|\right), \quad t \in\left[\alpha, \delta_{1}\right],  \tag{24}\\
-\delta^{2} \lambda \sin \sqrt{\lambda}\left(\delta_{1}-a\right) \sin \sqrt{\lambda}\left(\delta_{2}-t\right)+O(\sqrt{\lambda} \exp |\tau|(\delta+a-t)), t \in\left[\delta_{2}, \beta\right],
\end{array}\right.
$$

$$
C^{\Delta}(t, \lambda)=\left\{\begin{array}{c}
-\sqrt{\lambda} \sin \sqrt{\lambda}(t-a)+O(\exp |\tau||t-a|), \quad t \in\left[\alpha, \delta_{1}\right),  \tag{25}\\
\delta^{2} \lambda^{3 / 2} \sin \sqrt{\lambda}\left(\delta_{1}-a\right) \cos \sqrt{\lambda}\left(\delta_{2}-t\right)+O(\lambda \exp |\tau|(\delta+a-t)), t \in\left[\delta_{2}, \beta\right],
\end{array}\right.
$$

where $\delta=\delta_{2}-\delta_{1}, \tau=\operatorname{Im} \sqrt{\lambda}$ and $O$ denotes Landau's symbol.

Lemma 4. The following equlaties hold for all $\lambda \in \mathbb{C}$ and $t \in \mathbb{T}$.

$$
C^{\Delta}(t, \lambda) S(t, \lambda)-C(t, \lambda) S^{\Delta}(t, \lambda)=O(\exp |\tau|(\beta-\alpha-\delta))
$$

Proof. It is clear the function

$$
\varphi(t, \lambda):=C^{\Delta}(t, \lambda) S(t, \lambda)-C(t, \lambda) S^{\Delta}(t, \lambda)
$$

satisfies initial value problem

$$
\begin{aligned}
\varphi^{\Delta}(t) & =q(t) S^{\sigma}(t, \lambda), t \in\left[\alpha, \delta_{1}\right] \\
\varphi(a) & =1
\end{aligned}
$$

and

$$
\begin{aligned}
\varphi^{\Delta}(t) & =q(t) S^{\sigma}(t, \lambda), t \in\left[\delta_{2}, \beta\right] \\
\varphi\left(\delta_{2}\right) & =\varphi\left(\delta_{1}\right)+\delta q\left(\delta_{1}\right) S\left(\delta_{2}, \lambda\right)
\end{aligned}
$$

Hence, we get proof by using (22).

Theorem 4. i) The problem (1)-(3) on $\mathbb{T}=\left[\alpha, \delta_{1}\right] \cup\left[\delta_{2}, \beta\right]$ has countable many eigenvalues such as $\left\{\lambda_{n}\right\}_{n \geq 0}$.
ii) The numbers $\left\{\lambda_{n}\right\}_{n \geq 0}$ are real for sufficiently large $n$.
iii) If $a_{22} b_{12}-a_{12} b_{22} \neq 0$ and $\beta-\delta_{2}=\delta_{1}-\alpha$, the following asymptotic formula holds for $n \rightarrow \infty$.

$$
\begin{equation*}
\sqrt{\lambda_{n}}=\frac{(n-1) \pi}{2\left(\beta-\delta_{2}\right)}+O\left(\frac{1}{n}\right) \tag{26}
\end{equation*}
$$

Proof. The proof of (i) is obvious, since $\Delta(\lambda)$ is entire on $\lambda$.
By calculating directly, we get

$$
\begin{aligned}
\Delta(\lambda)= & \operatorname{det}\left(\begin{array}{cc}
U(C) & V(C) \\
U(S) & V(S)
\end{array}\right) \\
= & \left(a_{22} b_{12}-a_{12} b_{22}\right)\left[C^{\Delta}(\beta, \lambda) S^{\Delta}(\alpha, \lambda)-C^{\Delta}(\alpha, \lambda) S^{\Delta}(\beta, \lambda)\right]+ \\
& +\left(a_{22} b_{21}-a_{21} b_{22}\right)\left[C^{\Delta}(\beta, \lambda) S(\beta, \lambda)-C(\beta, \lambda) S^{\Delta}(\beta, \lambda)\right]+ \\
& +\left(a_{12} b_{11}-a_{11} b_{12}\right)\left[C^{\Delta}(\alpha, \lambda) S(\alpha, \lambda)-C(\alpha, \lambda) S^{\Delta}(\alpha, \lambda)\right] \\
& +O(\lambda \exp |\tau|(\beta-\alpha-\delta)) .
\end{aligned}
$$

It follows from (22)-(25) and Lemma 4 that

$$
\begin{aligned}
\Delta(\lambda)= & \left(a_{22} b_{12}-a_{12} b_{22}\right) \delta^{2} \lambda^{3 / 2} \sin \sqrt{\lambda}\left(\delta_{1}-\alpha\right) \cos \sqrt{\lambda}\left(\beta-\delta_{2}\right) \\
& +O(\lambda \exp |\tau|(\beta-\alpha-\delta))
\end{aligned}
$$

is valid for $|\lambda| \rightarrow \infty$. Since $a_{22} b_{12}-a_{12} b_{22} \neq 0$ and $\beta-\delta_{2}=\delta_{1}-\alpha$, the numbers $\left\{\lambda_{n}\right\}_{n \geq 0}$ are roots of

$$
\begin{equation*}
\lambda^{2} \frac{\sin 2 \sqrt{\lambda}\left(\beta-\delta_{2}\right)}{\sqrt{\lambda}}+O\left(\lambda \exp 2|\tau|\left(\beta-\delta_{2}\right)\right)=0 \tag{27}
\end{equation*}
$$

Now, we consider the region

$$
G_{n}:=\left\{\lambda \in \mathbb{C}: \lambda=\rho^{2},|\rho|<\frac{n \pi}{2\left(\beta-\delta_{2}\right)}+\varepsilon\right\}
$$

where $\varepsilon$ is sufficiently small number. There exist some positive constants $C_{\varepsilon}$ such that, $\left|\lambda^{2} \frac{\sin 2 \sqrt{\lambda}\left(\beta-\delta_{2}\right)}{\sqrt{\lambda}}\right| \geq C_{\varepsilon}|\lambda|^{3 / 2} \exp 2|\tau|\left(\beta-\delta_{2}\right)$ for sufficiently large $\lambda \in \partial G_{n}$. Thus, we establish the proof of (ii). On the other hand by using Rouche's theorem to (27) on $G_{n}$, we can show clearly that (26) holds for sufficiently large $n$.

Remark 3. Since $\mu(\alpha)=0$ in the considered time scale, the term $a_{22} b_{12}-a_{12} b_{22}$ is not another than $\operatorname{det} A$ in section 3.
