# STABILISATION OF WAVES ON PRODUCT MANIFOLDS BY BOUNDARY STRIPS 

RUOYU P. T. WANG


#### Abstract

We show that a transversely geometrically controlling boundary damping strip is sufficient but not necessary for $t^{-1 / 2}$-decay of waves on product manifolds. We give a general scheme to turn resolvent estimates for impedance problems on cross-sections to wave decay on product manifolds.


## 1. Introduction

1.1. Main Results. Let $X$ be a compact smooth manifold with smooth boundary $\partial X$. Let $Y$ be a complete smooth manifold, not necessarily compact. Throughout the paper, compact manifolds means topologically compact ones with or without boundary. If $\partial Y \neq \emptyset$, we assume that the boundary condition on $\partial Y$ makes $\Delta_{y} \geq 0$ essentially self-adjoint on $L^{2}(Y)$. Let $\Gamma=\partial X \times Y$ and consider non-negative boundary damping functions $a, b \in L^{\infty}(\Gamma)$. We always impose an assumption:

Assumption 1.1. We assume there is non-negative $a_{0}(x) \in C^{0}(\partial X)$ and constant $c_{0}>0$ that $c_{0} \leq a(x, y) / a_{0}(x) \leq 1,0 \leq b(x, y) / a_{0}(x) \leq 1$ on $\Gamma$.
Definition 1.2 (Geometric Control Condition). We say $\Sigma \subset \partial X$ geometrically controls $X$, if there is $T>0$ that every unit-speed generalised geodesic hits $\Sigma$ non-diffractively in time $T$. This is the assumption of [BLR92, Theorem 5.5].

We consider the damped wave equation on the product manifold $\Omega=X \times Y$ :

\left(\partial_{n}+a(x, y) \partial_{t}+b(x, y)\right) u(t, x, y)=0, \text { on } \mathbb{R}_{t} \times \Gamma  \tag{1.2}\\
u(0, x, y)=u_{0}(x, y) \in H_{\partial}^{2}(\Omega), \partial_{t} u(0, x, y)=u_{1}(x, y) \in H_{\partial}^{1}(\Omega), \tag{1.3}
\end{gather*}
$$

where $H_{\partial}^{s}(\Omega)$ are the Sobolev spaces whose boundary condition on $X \times \partial Y$ is consistent with the chosen one on $\partial Y$. Define the energy of the solution by

E(u, t)=\frac{1}{2} \int_{\Omega}|\nabla u|^{2}+\left|\partial_{t} u\right|^{2} . \tag{1.4}
\end{equation*}

Theorem 1.3 (Transverse Geometric Control to Energy Decay). Assume $\left\{a_{0}(x)>\right.$ $0\} \subset \partial X$ geometrically controls $X$. Then there is $C>0$ such that

E(u, t)^{\frac{1}{2}} \leq C t^{-\frac{1}{2}}\left(\left\|u_{0}\right\|_{H^{2}(\Omega)}+\left\|u_{1}\right\|_{H^{1}(\Omega)}\right) \tag{1.5}
\end{equation*}
$$

either if $Y$ is compact, or if $0<c_{0} \leq b / a_{0}$ on $\Gamma$.

We give some examples in Figure 1. One could also refer to Figure 4 to 6 in [BLR92] for more interesting choices of $X$ and $a_{0}(x)$, for example, Ikawa's bowling balls or dogbone regions.

There have been some previous results on the decay of waves in cylindrical domains when the damping is uniformly positive on $\Gamma$ : the $t^{-\delta}$-decay for some $\delta>0$ was shown in [Phu08], and the $t^{-1 / 3}$-decay could be shown using the method in [Nis13]. In [Wan21] we showed the sharp $t^{-1 / 2}$-decay when $X$ is star-shaped. Theorem 1.3 removes such star-shaped assumption. See Remark 1.4(3). This is also the only boundary damping result we know when $Y$ is non-compact, along the local energy decay obtained in [Roy18].

When the damping could vanish on some part of $\Gamma$, the only result we know is an a priori $1 / \log (2+t)$-decay, given by the Carleman estimates in [LR97]. The $t^{-1 / 2}$-decay given in Theorem 1.3 is more optimal on product manifolds. See also the references within [Wan21].

Remark 1.4. (1) The rate is sharp when $a_{0}>0$ on $\partial X$ and $a_{0}$ is sufficiently Hölder-regular. See Proposition 4.4.
(2) The transverse geometric control is not necessary for the $t^{-1 / 2}$-rate. Let $X=[0,1]_{x}, Y=\mathbb{S}_{y}^{1} \times \mathbb{S}_{z}^{1}$ and $a(x)=1$. The damping region $\{a>0\}$ geometrically controls $[0,1]_{x}$ and hence one obtains $t^{-1 / 2}$-decay for waves on $X \times Y$ : this is the third figure in Figure 1. However, the problem is equivalent to that for $X^{\prime}=$ $[0,1]_{x} \times \mathbb{S}_{z}^{1}, Y^{\prime}=\mathbb{S}_{y}^{1}$ and $a(x, z)=1$. In $X^{\prime}$, the second figure of Figure 1, the damping region $\{a>0\}=\{1\}_{x} \times \mathbb{S}_{z}^{1}$ does not geometrically control $X^{\prime} \times Y^{\prime}$, however the waves on $X^{\prime} \times Y^{\prime}=X \times Y$ enjoys the $t^{-1 / 2}$-decay.
(3) When $X$ is a bounded domain in $\mathbb{R}^{d}$ with smooth boundary, and $a_{0}(x)>0$ on $\partial X$, we have the geometric control condition, due to [BSW16, Lemma 5.3].
(4) The smoothness of $X$ could possibly be weakened to some manifolds with corners where the generalised bicharacteristic flows are well-defined, or $C^{2}$-metric with $C^{3}$-boundary: see [Bur97]. As long as we still have the spectral resolution of $\Delta_{y}, Y$ could be any manifold. See also Corollary 1.7 for the case of $C^{1}$-boundary.

We also obtain a general scheme to turn the resolvent estimates for interior impedance problems on the cross-section $X$ into energy decay rates of waves with boundary damping on $\Omega=X \times Y$ :

Theorem 1.5 (Transverse Resolvent Estimate to Energy Decay). Assume there exist $\delta \geq 0, \mu_{0}>0, C>0$ such that uniformly for $|\mu| \geq \mu_{0}$ and any $f \in L^{2}(X), g \in$

$\sqrt{a_{0}} L^{2}(\partial X)$ and $u$ that

$$
\begin{gather*}
\left(\Delta-\mu^{2}\right) u=f, \text { on } X,  \tag{1.6}\\
i \partial_{n} u+a_{0} \mu u=g, \text { on } \partial X, \tag{1.7}
\end{gather*}
$$

we have

$$
\begin{equation*}
\|u\|_{L^{2}(X)}^{2}+\langle\mu\rangle^{-2}\|\nabla u\|_{L^{2}(X)}^{2} \leq C\langle\mu\rangle^{2 \delta}\|f\|_{L^{2}(X)}^{2}+C\langle\mu\rangle^{-2+\delta}\left\|g / \sqrt{a_{0}}\right\|_{L^{2}(\partial X)}^{2} . \tag{1.8}
\end{equation*}
$$

Then there is $C>0$ such that for the solution $u$ to the equation (1.1) to (1.3),

E(u, t)^{\frac{1}{2}} \leq C t^{-\frac{1}{2+\delta}}\left(\left\|u_{0}\right\|_{H^{2}(\Omega)}+\left\|u_{1}\right\|_{H^{1}(\Omega)}\right) \tag{1.9}
\end{equation*}
$$

either if $Y$ is compact, or if $0<c_{0} \leq b / a_{0}$ on $\Gamma$.
We present some immediate corollaries in cases where we do not have the geometric control condition on the cross-section $X$. Recall the Bunimovich stadium is a planar domain which is a union of a rectangle $R$ with two wings $W$ : see Figure 2, and [BHW07, Nis13]. We consider some damping $a_{0}(x)>0$ on $\overline{\partial W}$ which vanishes on most of $\partial R$. The geometric control is violated on the Bunimovich stadium $X$, however we have obtained polynomial decay rates.

Corollary 1.6. Let $X=R \cup W$ be the Bunimovich stadium, and $a_{0}(x)>0$ on $\overline{\partial W}$. Then we have

E(u, t)^{\frac{1}{2}} \leq C t^{-\frac{1}{4}}\left(\left\|u_{0}\right\|_{H^{2}(\Omega)}+\left\|u_{1}\right\|_{H^{1}(\Omega)}\right) \tag{1.10}
\end{equation*}
$$

for the equation (1.1) to (1.3), where $\Omega=X \times Y$, either if $Y$ is compact, or if $0<c_{0} \leq b / a_{0}$ on $\Gamma$.

Another case we consider is when the boundary of $X$ is merely $C^{1}$, rough enough to prohibit generalised bicharacteristics from being well-defined. See Figure 2 and [CV02].

Corollary 1.7. Let $X^{\sharp} \subset \mathbb{R}^{d}$ be a smooth bounded connected domain with a smooth boundary $\partial X^{\sharp}$, equipped with a smooth metric. Let $X \subset X^{\sharp}$ be a connected domain of the same dimension, with a $C^{1}$-boundary $\partial X$ and $\partial X \cap \partial X^{\sharp}=\emptyset$. Assume there is $T>0$ such that every geodesic in $X^{\sharp}$ hits $\partial X^{\sharp}$, not necessarily non-diffractively, within time $T$. Let $a_{0}(x)>0$ on $\partial X$ and we have

\begin{equation*}
E(u, t)^{\frac{1}{2}} \leq C t^{-\frac{1}{3}}\left(\left\|u_{0}\right\|_{H^{2}(\Omega)}+\left\|u_{1}\right\|_{H^{1}(\Omega)}\right) \tag{1.11}
\end{equation*}
$$

for the equation (1.1) to (1.3), where $\Omega=X \times Y$, either if $Y$ is compact, or if $0<c_{0} \leq b / a_{0}$ on $\Gamma$.
Remark 1.8. We can use the $D(\Delta)$-norm defined in Section 4, instead $H^{2}$-norm of $u_{0}$ in (1.5), (1.9), (1.10), (1.11). When $a, b \in C^{0,1 / 2+\delta}(\Gamma)$ for some $\delta>0$, those two norms are equivalent.

The paper is organised in the following manner: in Section 2 we deal with the Geometric Control Condition and resolvent estimates on $X$; in Section 3 we use the resolvent estimates on $X$ to derive those on $\Omega=X \times Y$; in Section 4 we set up the evolution problem and finish the proofs of the results.

## 2. Transverse Resolvent Down Through Zero Frequency

In this section, the inner products are defaulted to $L^{2}(X)$ or the $L^{2}$-space over the indicated space. We firstly show that the geometric control condition gives an high frequency estimate.
Lemma 2.1. (Geometric Control to High Frequency Estimate) Assume $\left\{a_{0}(x)>\right.$ $0\}$ geometrically controls $X$. Then there exists $C, \mu_{0}>0$ such that uniformly for any $|\mu|>\mu_{0}, f \in L^{2}(X), g \in \sqrt{a_{0}} L^{2}(\partial X)$, $u$ that

\begin{gather*}
\left(\Delta-\mu^{2}\right) u=f, \text { on } X  \tag{2.1}\\
i \partial_{n} u+a_{0} \mu u=g, \text { on } \partial X, \tag{2.2}
\end{gather*}
$$

we have

$$
\begin{equation*}
\|u\|_{L^{2}(X)}^{2}+\langle\mu\rangle^{-2}\|\nabla u\|_{L^{2}(X)} \leq C\langle\mu\rangle^{-2}\|f\|_{L^{2}(X)}^{2}+C\langle\mu\rangle^{-2}\left\|g / \sqrt{a_{0}}\right\|_{L^{2}(\partial X)}^{2} . \tag{2.3}
\end{equation*}
$$

In other words, we have the estimate (1.8) with $\delta=0$ for the equation (1.6) to (1.7).

Proof. The idea of the proof follows [BSW16, Theorem 1.8]. Consider $v_{\mu}$ being the unique solution to

v_{\mu}(t, x)=0, t<0 \tag{2.6}
\end{gather*}

where $\phi$ is smooth and compactly supported in $(0,1)$ with $\int \phi=1$. Pair (2.23) with $\partial_{t} v_{\mu}$ in $L^{2}(X)$ to see

$$
\begin{align*}
& \partial_{t}\left(\left\|\nabla v_{\mu}\right\|_{X}^{2}+\left\|\partial_{t} v_{\mu}\right\|_{X}^{2}\right)=-2\left\|\sqrt{a_{0}} \partial_{t} v_{\mu}\right\|_{\partial X}^{2}  \tag{2.7}\\
& +\operatorname{Re}\left(\left\langle G, \partial_{t} v_{\mu}\right\rangle_{\partial X}+\left\langle F, \partial_{t} v_{\mu}\right\rangle_{X}\right) \leq C\|F\|_{X}^{2}+C\left\|G / \sqrt{a_{0}}\right\|_{\partial X}^{2}+C\left\|\partial_{t} v_{\mu}\right\|_{X}^{2}
\end{align*}
$$

Apply the Grönwall's inequality to see, at $t=1$,

\left\|\nabla v_{\mu}\right\|_{X}^{2}+\left\|\partial_{t} v_{\mu}\right\|_{X}^{2} \leq C\|F\|_{[0,1] \times X}^{2}+C\left\|G / \sqrt{a_{0}}\right\|_{[0,1] \times \partial X}^{2} \tag{2.8}
\end{equation*}
$$

Since $\left\{a_{0}(x)>0\right\}$ geometrically controls $X$, by [BLR92, Theorem 5.5] we have the exponential decay for all $t>1$ :

\left\|\nabla v_{\mu}\right\|_{X}^{2}+\left\|\partial_{t} v_{\mu}\right\|_{X}^{2} \leq C e^{-c t}\left(\|f\|_{X}^{2}+\left\|g / \sqrt{a_{0}}\right\|_{\partial X}^{2}\right) \tag{2.9}
\end{equation*}
$$

where the constants do not depend on $\mu$. Inverse Fourier transform $t$ to $\tau$ to observe

$$
\begin{gather*}
\left(\Delta-\tau^{2}\right) \mathcal{F}^{-1} v_{\mu}=\hat{\phi}(\mu-\tau) f  \tag{2.10}\\
\left(i \partial_{n}+a_{0} \tau\right) \mathcal{F}^{-1} v_{\mu}=i \hat{\phi}(\mu-\tau) g \tag{2.11}
\end{gather*}
$$

Use $\left\|\mathcal{F}^{-1} v_{\mu}\right\|_{L^{2}(X)} \leq\left\|v_{\mu}\right\|_{L^{2}\left(\mathbb{R}_{t}, L^{2}(X)\right)}$ to deduce from (2.9)

\begin{equation*}
|\tau|\left\|\mathcal{F}^{-1} v_{\mu}\right\|_{X}+\left\|\nabla \mathcal{F}^{-1} v_{\mu}\right\|_{X} \leq C\left(\|f\|+\left\|g / \sqrt{a_{0}}\right\|\right) . \tag{2.12}
\end{equation*}
$$

for all $\tau \in \mathbb{R}$. Now let $\tau=\mu$ to see the solutions to (2.1) $u_{\mu}=\mathcal{F}^{-1} v_{\mu}$, and the desired estimate for $|\mu| \geq \mu_{0}>0$ uniformly.

We here use the unique continuation principles to fix the low frequencies.
Lemma 2.2 (All Frequency Estimate). Suppose $a_{0} \not \equiv 0$ on $\partial X$, and for the equation (1.6) to (1.7), we have the estimate (1.8) with $\delta \geq 0$, uniformly for all $|\mu| \geq \mu_{0}>0$. Then for another equation with $f \in L^{2}(X), g \in \sqrt{a_{0}} L^{2}(\partial X)$,

i \partial_{n} u+a_{0} \mu u+i a_{0} u=g, \text { on } \partial X \tag{2.14}
\end{gather*}
$$

uniformly for all $\mu \in \mathbb{R}$ we have

\begin{equation*}
\|u\|_{L^{2}(X)}^{2}+\langle\mu\rangle^{-2}\|\nabla u\|_{L^{2}(X)} \leq C\langle\mu\rangle^{2 \delta}\|f\|_{L^{2}(X)}^{2}+C\langle\mu\rangle^{-2+\delta}\left\|g / \sqrt{a_{0}}\right\|_{L^{2}(\partial X)}^{2} \tag{2.15}
\end{equation*}
$$

Note the perturbative term $i a_{0} u$ added to the boundary that makes (2.13) different from (1.6).
Proof. 1. We claim (2.15) holds for $|\mu| \geq \mu_{0}>0$. Firstly pair (2.13) with $u$ and take the imaginary part to see

Estimate

\left\|\sqrt{a_{0}} u\right\|_{\partial X}^{2} \leq C \epsilon^{-1} \mu^{-4+\delta}\|f\|^{2}+C \mu^{-2}\left\|g / \sqrt{a_{0}}\right\|_{\partial X}^{2}+\epsilon \mu^{2-\delta}\|u\|^{2} \tag{2.17}
\end{equation*}
$$

Rewrite the boundary condition (2.14) as $i \partial_{n} u+a_{0} \mu u=g-i a_{0} u$ and apply the resolvent estimate (1.8) to see

\|u\|_{L^{2}(X)}^{2}+\langle\mu\rangle^{-2}\|\nabla u\|_{L^{2}(X)} \leq C\langle\mu\rangle^{2 \delta}\|f\|_{L^{2}(X)}^{2}+C\langle\mu\rangle^{-2+\delta}\left\|\sqrt{a_{0}} u\right\|_{\partial X}^{2}  \tag{2.18}\\
+C\langle\mu\rangle^{-2+\delta}\left\|g / \sqrt{a_{0}}\right\|_{L^{2}(\partial X)}^{2} \leq C\left(\langle\mu\rangle^{2 \delta}+\langle\mu\rangle^{-6+2 \delta}\right)\|f\|_{L^{2}(X)}^{2} \\
+C\left(\langle\mu\rangle^{-2+\delta}+\langle\mu\rangle^{-4+\delta}\right)\left\|g / \sqrt{a_{0}}\right\|_{L^{2}(\partial X)}^{2}+\epsilon\|u\|^{2}
\end{array}
$$

Absorb the last term to observe the claim.
2. Assume there exists a sequence $\mu_{n} \rightarrow \mu$, for some $|\mu|<\mu_{0}$ such that (2.15) does not hold, that is, there are $\left\|u_{n}\right\|_{L^{2}}^{2}+\left\langle\mu_{n}\right\rangle^{-2}\|\nabla u\|^{2} \equiv 1$ and $f_{n}=o_{L^{2}}(1)$, $g_{n}=\sqrt{a_{0}} o_{L^{2}(\partial X)}(1)$ such that

$$
\begin{gather*}
\quad\left(\Delta-\mu_{n}^{2}\right) u_{n}=f_{n}, \text { on } X  \tag{2.19}\\
i \partial_{n} u_{n}+a_{0} \mu_{n} u_{n}+i a_{0} u_{n}=g_{n}, \text { on } \partial X . \tag{2.20}
\end{gather*}
$$

Note that this implies that $\left\|u_{n}\right\|$ uniformly bounded in $H^{1}$. Pair (2.19) with $u_{n}$ and take the real part to see $\left\|\nabla u_{n}\right\|=|\mu|\left\|u_{n}\right\|+o(1)$ and hence $\left\|u_{n}\right\|=(1+$ $\left.\mu^{2} /\langle\mu\rangle^{2}\right)^{-1}+o(1)$. Via a subsequence we have $u_{n} \rightarrow u \in H^{1}$ weakly in $H^{1}$. As $X$ is compact, $u_{n} \rightarrow u$ in $H^{3 / 4}$-norm and thus $u_{n} \rightarrow u$ in $L^{2}(\partial X)$-norm. Now for any $\phi \in H_{0}^{1}$ we have

\left\langle f_{n}, \phi\right\rangle=\left\langle\nabla u_{n}, \nabla \phi\right\rangle-\mu_{n}^{2}\left\langle u_{n}, \phi\right\rangle+\left\langle i g_{n}-i a_{0} \mu_{n} u_{n}+a_{0} u_{n}, \phi\right\rangle_{\partial X} \tag{2.21}
\end{equation*}
$$

Take $n \rightarrow \infty$ to see

$$
\begin{equation*}
\langle\nabla u, \nabla \phi\rangle-\mu^{2}\langle u, \phi\rangle+\left\langle a_{0} u, \phi\right\rangle_{\partial X}=0 \tag{2.22}
\end{equation*}
$$

Therefore $u \in H^{1}$ is the weak solution to

$$
\begin{align*}
\left(\Delta-\mu^{2}\right) u & =0, \text { on } X  \tag{2.23}\\
i \partial_{n} u+i a_{0} u & =0, \text { on } \partial X . \tag{2.24}
\end{align*}
$$

Pair (2.23) with $u$ and take the real part to see $\left\|\sqrt{a_{0}} u\right\|_{\partial X}=0$. Hence over $\left\{a_{0}>0\right\}$, $u=0$ and hence $\partial_{n} u=0$. This implies $u=0$ on $X$ via the classical unique continuation: see for example, [ARRV09, Theorem 1.9]. Thus $u_{n} \rightarrow 0$ weakly in $H^{1}$ and in $L^{2}$-norm, but this contradicts that $\left\|u_{n}\right\| \rightarrow\left(1+\mu^{2} /\langle\mu\rangle^{2}\right)^{-1}>0$.

We now show the main resolvent estimate in this section, for an overdamped interior impedance problem on $X$.

Proposition 2.3 (Transverse Resolvent Down Through Zero Frequency). Assume the resolvent estimate (1.8) of parameter $\delta \geq 0$ holds on $X$, and let $b_{0}(x) \in L^{\infty}(\partial X)$ be that $0 \leq b_{0} \leq a_{0}$ almost everywhere. Then for each $\lambda_{0}>0$, there exists $C>0$ such that uniformly for any $\mu, \lambda, f \in L^{2}(X), g \in \sqrt{a_{0}} L^{2}(\partial X)$, $u$ that

(\Delta-z) u=f, \text { on } X  \tag{2.25}\\
i \partial_{n} u+a_{0} \lambda u+i b_{0} u=g, \text { on } \partial X \tag{2.26}
\end{gather*}
$$

where $|\lambda| \geq \lambda_{0},-\infty<z \leq \lambda^{2}$, we have

\|u\|_{H^{1}(X)}^{2} \leq C\langle\lambda\rangle^{2+2 \delta}\|f\|_{L^{2}(X)}^{2}+C\langle\lambda\rangle^{\delta}\left\|g / \sqrt{a_{0}}\right\|_{L^{2}(\partial X)}^{2} \tag{2.27}
\end{equation*}
$$

If we assume $0<c_{0} \leq b_{0} / a_{0}$ on $\partial X$, we could take $\lambda_{0}=0$, that is, the same resolvent estimates hold for any $\lambda \in \mathbb{R}$.

Then for any $\lambda_{0}>0$, we have some $C>0$ independent of $\lambda, u, f, g$ such that for any $|\lambda| \geq \lambda_{0}$,

\|u\|_{H^{1}(\Omega)}^{2} \leq C\langle\lambda\rangle^{2+2 \delta}\|f\|_{H^{1}(\Omega)}^{2}+C\langle\lambda\rangle^{\delta}\left\|g / \sqrt{a_{0}}\right\|_{H^{1}(\Gamma)}^{2} \tag{3.28}
\end{equation*}
$$

For $|\lambda| \geq \lambda_{0}>0$ we have from (3.28) that

\lambda^{-2}\|\nabla u\|_{\Omega}^{2} \leq C\langle\lambda\rangle^{2 \delta}\|f\|_{H^{1}(\Omega)}^{2}+C\langle\lambda\rangle^{-2+\delta} C\left\|g / \sqrt{a_{0}}\right\|_{H^{1}(\Gamma)}^{2} \tag{3.29}
\end{equation*}
$$

and (3.11) concludes the proof of (3.6). Moreover when $c_{0} \leq b_{0} / a_{0}$ and for $\lambda$ bounded, (3.28) implies

With (3.29) we have (3.6) when $\lambda_{0}=0$.

## 4. Evolution and Energy Decay

Let $\Delta=\Delta_{x} \otimes \operatorname{Id}_{y}+\operatorname{Id}_{x} \otimes \Delta_{y}$, and the domain $D(\Delta)$ be that of the minimal closed extension of $\Delta: H_{\partial}^{2}(\Omega) \rightarrow L^{2}(\Omega)$, that is, the closure of $C^{\infty}(\Omega) \cap H_{\partial}^{1}(\Omega)$ in $H_{\partial}^{1}(\Omega)$ under the graph norm

\|u\|_{D(\Delta)}^{2}=\|u\|_{H^{1}(\Omega)}^{2}+\|\Delta u\|_{L^{2}(\Omega)}^{2} \tag{4.1}
\end{equation*}
$$

Let $\mathcal{H}=H_{\partial}^{1}(\Omega) \oplus L_{\partial}^{2}(\Omega)$. If $b \equiv 0$ on $\Gamma$, we further restrict $\mathcal{H}$ to the set of $(\tilde{u}, \tilde{v}) \in H_{\partial}^{1}(\Omega) \oplus L_{\partial}^{2}(\Omega)$ that

\int_{\Omega} \tilde{v}+\int_{\Gamma} a(x, y) \tilde{u}(x, y)=0 \tag{4.2}
\end{equation*}
$$

a codimension- 1 subspace of $H_{\partial}^{1} \oplus L_{\partial}^{2}$. Let the generator of our semigroup be

0 & \mathrm{Id}  \tag{4.3}\\
-\Delta & 0
\end{array}\right): D(A) \rightarrow \mathcal{H}
$$

and the domain is

\begin{equation*}
D(A)=\left\{(u, v) \in \mathcal{H}: A(u, v) \in \mathcal{H}, \partial_{n} u+a(x, y) v+b(x, y) u=0 \text { on } \Gamma\right\} \tag{4.4}
\end{equation*}
$$

which is equivalent to the set of all $(u, v) \in \mathcal{H}, u \in D(\Delta), v \in H_{\partial}^{1}(\Omega)$ and $\partial_{n} u+$ $a(x, y) v+b(x, y) u=0$ on $\Gamma$. Note $D(A)$ is dense in $\mathcal{H}$, and

\left\{(u, v) \in H_{\partial}^{2}(\Omega) \oplus H_{\partial}^{1}(\Omega): \partial_{n} u+a(x, y) v+b(x, y) u=0 \text { on } \Gamma\right\} \tag{4.5}
\end{equation*}

is dense in $D(A)$. Define the energy seminorm $E$ on $\mathcal{H}$ via

\|(u, v)\|_{E}^{2}=\|\nabla u\|_{L^{2}(\Omega)}^{2}+\|v\|_{L^{2}(\Omega)}^{2}+\|\sqrt{b} u\|_{L^{2}(\Gamma)}^{2} . \tag{4.6}
\end{equation*}

Lemma 4.1. $E$ is a norm on $\mathcal{H}$ and is equivalent to the $H^{1} \oplus L^{2}$-norm. $A$ is maximally dissipative with respect to the energy norm $E$ and generates a contraction semigroup $e^{t A}$ on $\mathcal{H}$.

Proof. See [Wan21, Proposition 3.1]. Note that via a direct computation we have

This demonstrates the dissipative nature of $A$.
Proposition 4.2. Assume the resolvent estimate (1.8) holds with parameter $\delta \geq 0$. Then $A$ has no purely imaginary spectrum, and there exists $C>0$ that for $\lambda \in \mathbb{R}$.

either if $Y$ is compact, or if $0<c_{0} \leq b / a_{0}$ on $\Gamma$.

Proof. 1. Fix some $\lambda_{0}>0$. Assume (4.8) is not true for $\left\{|\lambda| \geq \lambda_{0}\right\}$. Then there are $\left|\lambda_{n}\right| \geq \lambda_{0}$ and $\left(u_{n}, v_{n}\right) \in D(A)$ with

\end{equation*}

This can be reduced to

\Delta u_{n}-\lambda_{n}^{2} u_{n}=o_{L^{2}}\left(\left\langle\lambda_{n}\right\rangle^{-2-\delta}\right)+o_{H^{1}}\left(\left\langle\lambda_{n}\right\rangle^{-1-\delta}\right),  \tag{4.11}\\
v_{n}=-i \lambda_{n} u_{n}+o_{H^{1}}\left(\left\langle\lambda_{n}\right\rangle^{-2-\delta}\right) \tag{4.12}
\end{gather*}
$$

Now (4.7) implies

\left\|\sqrt{a} v_{n}\right\|_{\Gamma}^{2}=-\operatorname{Re}\left\langle\left(A+i \lambda_{n}\right)\left(u_{n}, v_{n}\right),\left(u_{n}, v_{n}\right)\right\rangle_{E}=o\left(\left\langle\lambda_{n}\right\rangle^{-2-\delta}\right) \tag{4.13}
\end{equation*}
$$

and

\left\|\sqrt{a} u_{n}\right\|_{\Gamma} \leq\left|\lambda_{n}\right|^{-1}\left(\left\|\sqrt{a} v_{n}\right\|_{\Gamma}+o\left(\left\langle\lambda_{n}\right\rangle^{-2-\delta}\right)\right)=o\left(\left\langle\lambda_{n}\right\rangle^{-2-\delta / 2}\right) \tag{4.14}
\end{equation*}
$$

Note this is the only place we used $\left|\lambda_{n}\right| \geq \lambda_{0}>0$. Pair (4.11) with $u_{n}$ and take the real part to see

\end{equation*}
$$

Use (4.4) to see

\Delta u_{n}-\lambda_{n}^{2} u_{n}=o_{L^{2}}\left(\left\langle\lambda_{n}\right\rangle^{-2-\delta}\right)+o_{H^{1}}\left(\left\langle\lambda_{n}\right\rangle^{-1-\delta}\right),  \tag{4.16}\\
i \partial_{n}+a \lambda_{n} u_{n}+i b u_{n}=a o_{H^{1 / 2}(\Gamma)}\left(\left\langle\lambda_{n}\right\rangle^{-2-\delta}\right) . \tag{4.17}
\end{gather*}
$$

By Assumption 1.1, we have $c_{0} \leq a / a_{0} \leq 1$ and
(4.18) $i \partial_{n} u_{n}+a_{0} \lambda_{n} u_{n}+i b_{0} u_{n}=\lambda_{n}\left(a-a_{0}\right) u_{n}-i\left(b-b_{0}\right) u_{n}+a o_{\Gamma}\left(\left\langle\lambda_{n}\right\rangle^{-2-\delta}\right)=g_{n}$, where $b_{0}(x)=\inf _{Y} b(x, y) \geq 0$. Note $a, b \leq a_{0}$ and use (4.14) to estimate

g_{n}=\sqrt{a_{0}} o_{L^{2}(\Gamma)}\left(\left\langle\lambda_{n}\right\rangle^{-1-\delta / 2}\right) . \tag{4.19}
\end{equation*}

Thus we have turned the quasimodes with boundary damping $a(x, y), b(x, y)$ into those with $a_{0}(x), b_{0}(x)$ :

i \partial_{n} u_{n}+a_{0} \lambda_{n} u_{n}+i b_{0} u_{n}=\sqrt{a_{0}} o_{\Gamma}\left(\left\langle\lambda_{n}\right\rangle^{-1-\delta / 2}\right)=\sqrt{a_{0}} g_{n}, \text { on } \Gamma  \tag{4.21}\\
f_{n}^{0}=o_{L^{2}}\left(\left\langle\lambda_{n}\right\rangle^{-2-\delta}\right), f_{n}^{1}=o_{H^{1}}\left(\left\langle\lambda_{n}\right\rangle^{-1-\delta}\right) . \tag{4.22}
\end{gather*}
$$

2. By the standard existence theorem, the problem

has a unique solution $w_{n} \in D(\Delta) \subset H_{\partial}^{1}(\Omega)$ : see [Wan21, Proposition 2.8, Proposition 4.2], [McL00, Theorem 4.11] for details. Apply the resolvent estimate (3.5) to see

\left\|w_{n}\right\|^{2} \leq C\left\langle\lambda_{n}\right\rangle^{2+2 \delta}\left\|f_{n}^{0}\right\|^{2}+C\left\langle\lambda_{n}\right\rangle^{\delta}\left\|g_{n}\right\|_{\Gamma}^{2}=o\left(\left\langle\lambda_{n}\right\rangle^{-2}\right) \tag{4.25}
\end{equation*}
$$

Meanwhile $u_{n}-w_{n}$ satisfies

\left(\Delta\left(u_{n}-w_{n}\right)-\lambda_{n}^{2}\left(u_{n}-w_{n}\right)\right) & =f_{n}^{1}  \tag{4.26}\\
\left(i \partial_{n}+a_{0} \lambda_{n}+i b_{0}\right)\left(u_{n}-w_{n}\right) & =0 \tag{4.27}
\end{align*}
$$

Apply (3.6) to see

\begin{equation*}
\left\|u_{n}-w_{n}\right\|^{2} \leq C\left\langle\lambda_{n}\right\rangle^{2 \delta}\left\|f_{n}^{1}\right\|_{H^{1}}^{2}=o\left(\left\langle\lambda_{n}\right\rangle^{-2}\right) \tag{4.28}
\end{equation*}
$$

Thus $\left\|u_{n}\right\|=o\left(\left\langle\lambda_{n}\right\rangle^{-1}\right)$. By (4.12) and (4.15) we have

\end{equation*}

which gives the desired contradiction for $|\lambda| \geq \lambda_{0}>0$.
3. When $Y$ is compact, we show $0 \notin \operatorname{Spec}(A)$. By the Rellich theorem we know $D(A) \hookrightarrow \mathcal{H}$ compactly. Furthermore $\operatorname{Id}-A$ is surjective from $D(A)$ to $\mathcal{H}$. Hence $\operatorname{Spec}(A)$ is discrete, and $0 \in \operatorname{Spec}(A)$ only if 0 is an eigenvalue. Indeed, if $A(u, v)=0$, we have $v=0$ and $\Delta u=0$ and then

\|(u, v)\|_{E}^{2}=\|\nabla u\|^{2}+\|v\|^{2}+\|\sqrt{b} u\|_{\Gamma}^{2}=0 \tag{4.30}

Therefore $(u, v)=0$ since $E$ is point-separating. Then $i\left(-2 \lambda_{0}, 2 \lambda_{0}\right)$ is disjoint from $\operatorname{Spec}(A)$ for some $\lambda_{0}>0$ and we have (4.8).
4. When $Y$ is non-compact and $c_{0} \leq b / a_{0}$ on $\Gamma$, we have

as $\left|\lambda_{n}\right| \rightarrow 0$ and this fixes (4.14) for all $\left|\lambda_{n}\right| \geq \lambda_{0}=0$. Moreover, in (4.21) we have $b_{0} \geq c_{0} a_{0}$ and the resolvent estimates (3.5) and (3.6) work for $\lambda_{0}=0$, that is, for all $\lambda$. This concludes the proof.

We cite [BT10, Theorem 2.4] to characterise the polynomial energy decay:
Theorem 4.3 (Borichev-Tomilov). Let $A$ be a maximal dissipative operator that generates a contraction $C^{0}$-semigroup in a Hilbert space $\mathcal{H}$ and assume that $i \mathbb{R} \cap$ $\operatorname{Spec}(A)$ is empty. Fix $k>0$, and the following are equivalent:
(1) There exists $C>0$ such that for any $|\lambda|>0$ one has

Proof of Theorem 1.5. The resolvent estimate (4.8) on the generator $A$ with Theorem 4.3 of Borichev and Tomilov implies

as claimed in Theorem 1.5.
Proof of Theorem 1.3. Lemma 2.1 implies that the geometric control implies the resolvent estimate (1.8) holds with parameter $\delta=0$. Invoke Theorem 1.5 to see the decay.

Proof of Corollary 1.6. Let $X$ be the Bunimovich stadium. Revisit [Nis13, Proposition 6$]$ to see for the equation (1.6) to (1.7) we have for $|\mu|>1$,

that is, the estimate (1.8) holds with parameter $\delta=2$. Invoke Theorem 1.5 to get the decay.

Proof of Corollary 1.7. Let $X, X^{\sharp}$ be described as in the statement. Invoke [CV02, Proposition 2.1] to see for the equation (1.6) to (1.7) we have for $|\mu| \geq \lambda_{0}>0$,

that is, the estimate (1.8) holds with parameter $\delta=1$. Invoke Theorem 1.5 to get the decay.

Proposition 4.4. Assume $a=a_{0} \in C^{1,1 / 2+\delta}(\partial X)$ for some $\delta>0, a_{0}(x)>0$ on $\partial X$ and $b \equiv 0$. Then there exist quasimodes $\left(\lambda_{n}, U_{n}\right),\left\|U_{n}\right\|_{\mathcal{H}} \equiv 1$ such that $\left\|\left(A-i \lambda_{n}\right) U_{n}\right\|_{\mathcal{H}}=\mathcal{O}\left(\left\langle\lambda_{n}\right\rangle^{-2}\right)$. This implies that the equation (1.1) to (1.3) cannot be stable at the rate $t^{-1 /(2-\epsilon)}$ for any $\epsilon>0$.

Remark 4.5. When $X=\mathbb{B}^{d}$ and $a(x)=1$, we constructed those quasimodes in [Wan21, Proposition 3.6, Proposition 4.5] using special functions.

Proof. 1. We begin by constructing a sequence of quasimodes on $X$. Fix an Dirichlet eigenfunction $w^{0}$ with respect to some eigenvalue $\mu^{2}$ where $\mu>0$, that is

Now note the Hölder regularity of $a$ implies $a$ is a Sobolev multiplier on $H^{3 / 2}(\partial X)$, and being uniformly away from 0 makes $1 / a$ one as well: also see [Wan21, Lemma 2.6] and the reference within. Consider an extension $w^{1} \in H^{2}(X)$ from the given boundary data:

Then $w_{\lambda}=w^{0}+\lambda^{-1} w^{1}$ forms a sequence of quasimodes on $X$ :

\end{gather*}

where $\left\|w_{\lambda}\right\|=1+\mathcal{O}\left(\lambda^{-1}\right)$.
2. Since $\Delta_{y}$ is unbounded on $L^{2}(Y)$, there exist $\lambda_{n}>\mu$ with $\lambda_{n} \rightarrow \infty$ and $v_{n} \in L^{2}(Y)$ such that

\end{equation*}
$$

In other words, $v_{n}$ 's are spectrally supported inside the spectral windows $\left[\sqrt{\lambda_{n}^{2}-\mu^{2}}-\right.$ $\left.\lambda_{n}^{-2}, \sqrt{\lambda_{n}^{2}-\mu^{2}}+\lambda_{n}^{-2}\right]$ that shrink and shift to the infinity. Note $\left|\rho^{2}-\left(\lambda_{n}^{2}-\mu^{2}\right)\right|=$ $\mathcal{O}\left(\lambda_{n}^{-1}\right)$ inside this spectral window and this implies

\left(\Delta_{y}-\left(\lambda_{n}^{2}-\mu^{2}\right)\right) v_{n}=\int_{\sqrt{\lambda_{n}^{2}-\mu^{2}}-\lambda_{n}^{-2}}^{\sqrt{\lambda_{n}^{2}-\mu^{2}}+\lambda_{n}^{-2}}\left(\rho^{2}-\left(\lambda_{n}^{2}-\mu^{2}\right)\right) d E_{\rho}\left(v_{n}\right)=\mathcal{O}_{L^{2}(Y)}\left(\lambda_{n}^{-1}\right) \tag{4.43}
\end{equation*}
$$

Now let $u_{n}=w_{\lambda_{n}}(x) v_{n}(y)$. We have

\begin{align*}
&\left(\Delta-\lambda_{n}^{2}\right) u_{n}=v_{n}\left(\Delta_{x}-\mu^{2}\right) w_{\lambda_{n}}+w_{\lambda_{n}}\left(\Delta_{y}-\left(\lambda_{n}^{2}-\mu^{2}\right)\right) v_{n}  \tag{4.44}\\
&=\lambda_{n}^{-1}\left(\Delta_{x}-\mu^{2}\right) w^{1}+w_{\lambda_{n}} \mathcal{O}_{L^{2}(Y)}\left(\lambda_{n}^{-1}\right)=\mathcal{O}_{L^{2}}\left(\lambda_{n}^{-1}\right)
\end{align*}
$$

where $\left\|u_{n}\right\|=1+\mathcal{O}\left(\lambda_{n}^{-1}\right)$. Pair (4.44) with $u_{n}$ and take the real part to see $\left\|\nabla u_{n}\right\|=\lambda_{n}+\mathcal{O}(1)$. Note $i \partial_{n} u_{n}+a_{0} \lambda_{n} u_{n}=0$ on $\Gamma$ and hence $\left(u_{n}, i \lambda_{n} u_{n}\right) \in \mathcal{H}$, and $\left\|\left(u_{n}, i \lambda_{n} u_{n}\right)\right\|_{\mathcal{H}}=\sqrt{2} \lambda_{n}+\mathcal{O}(1)$. Let $U_{n}=\left(u_{n}, i \lambda_{n} u_{n}\right) /\left\|\left(u_{n}, i \lambda_{n} u_{n}\right)\right\|_{\mathcal{H}}$. Then

$$
\begin{align*}
& \left(A-i \lambda_{n}\right) U_{n}=\left\|\left(u_{n}, i \lambda_{n} u_{n}\right)\right\|_{\mathcal{H}}^{-1}\left(A-i \lambda_{n}\right)\left(u_{n}, i \lambda_{n} u_{n}\right)  \tag{4.45}\\
& \quad=\mathcal{O}\left(\lambda_{n}^{-1}\right)\left(0,-\left(\Delta-\lambda_{n}^{2}\right) u_{n}\right)=\mathcal{O}\left(\lambda_{n}^{-2}\right)=o\left(\lambda_{n}^{-2+\epsilon}\right)
\end{align*}
$$

for any $\epsilon>0$. Invoke Theorem 4.3 to conclude the proof.
