

# A DIFFERENTIAL GRADED APPROACH TO THE SILTING THEOREM

**ABSTRACT.** A silting theorem was established by Buan and Zhou as a generalisation of the classical tilting theorem of Brenner and Butler. In this paper, we give an alternative proof of the theorem by using differential graded algebras.

## 1. INTRODUCTION

Let  $k$  be a field and  $A$  be a finite-dimensional  $k$ -algebra. Let  $T$  be a classical tilting module over  $A$  and put  $B = \text{End}_A(T)$ . Then there are two adjoint pairs of functors between the two categories of finite-dimensional modules

$$\begin{array}{ccc} \text{mod } A & & \text{mod } A \\ ? \otimes_B T \uparrow \downarrow \text{Hom}_A(T, ?) & & \text{Tor}_1^B(?, T) \uparrow \downarrow \text{Ext}_A^1(T, ?) \\ \text{mod } B & & \text{mod } B \end{array}$$

Put  $\mathcal{T}_T = \ker(\text{Ext}_A^1(T, ?))$ ,  $\mathcal{F}_T = \ker(\text{Hom}_A(T, ?))$ ,  $\mathcal{X}_T = \ker(? \otimes_B T)$  and  $\mathcal{Y}_T = \ker(\text{Tor}_1^B(?, T))$ . The classical tilting theorem of Brenner and Butler [10, 17] states that  $(\mathcal{T}_T, \mathcal{F}_T)$  is a torsion pair of  $\text{mod } A$ ,  $(\mathcal{X}_T, \mathcal{Y}_T)$  is a torsion pair of  $\text{mod } B$ , and the restrictions of the above four functors are equivalences

$$\begin{array}{ccc} \mathcal{T}_T & & \mathcal{F}_T \\ ? \otimes_B T \uparrow \downarrow \text{Hom}_A(T, ?) & & \text{Tor}_1^B(?, T) \uparrow \downarrow \text{Ext}_A^1(T, ?) \\ \mathcal{Y}_T & & \mathcal{X}_T \end{array}$$

Recently, Buan and Zhou generalised this theorem to a silting theorem in [13]. Precisely, let  $T$  be a 2-term silting complex in the bounded homotopy category  $K^b(\text{proj } A)$  of finitely generated projective  $A$ -modules. For example, any projective resolution of a classical tilting module is isomorphic to a 2-term silting complex in  $K^b(\text{proj } A)$ . Let  $\mathcal{D}^b(\text{mod } A)$  be the bounded derived category of  $\text{mod } A$ .

**Theorem 1.1** ([13, Theorem 1.1 and Corollary 2.5]). (a) *There is a torsion pair  $(\mathcal{T}_T, \mathcal{F}_T)$  of  $\text{mod } A$  and a torsion pair  $(\mathcal{X}_T, \mathcal{Y}_T)$  of  $\text{mod } B$  together with equivalences  $\text{Hom}_{\mathcal{D}^b(\text{mod } A)}(T, ?): \mathcal{T}_T \xrightarrow{\sim} \mathcal{Y}_T$  and  $\text{Hom}_{\mathcal{D}^b(\text{mod } A)}(T, \Sigma?): \mathcal{F}_T \xrightarrow{\sim} \mathcal{X}_T$ .*

(b) *There is a triangle in  $K^b(\mathbf{proj} A)$*

$$A \longrightarrow T' \xrightarrow{f} T'' \longrightarrow \Sigma A$$

*with  $T', T'' \in \mathbf{add} T$ . Let  $S$  be the mapping cone of*

$$\mathrm{Hom}_{K^b(\mathbf{proj} A)}(T, T') \xrightarrow{\mathrm{Hom}(T, f)} \mathrm{Hom}_{K^b(\mathbf{proj} A)}(T, T'').$$

(c)  *$S$  is a 2-term silting complex in  $K^b(\mathbf{proj} B)$ , where  $B = \mathbf{End}_{K^b(\mathbf{proj} A)}(T)$ .*

(d) *There is a surjective algebra homomorphism  $\pi: A \rightarrow \bar{A} := \mathbf{End}_{K^b(\mathbf{proj} B)}(S)$ .*

(e)  *$\pi$  is an isomorphism if and only if  $T$  is tilting.*

*Let  $\pi^*: \mathbf{mod} \bar{A} \hookrightarrow \mathbf{mod} A$  be the restriction functor.*

(f) *The functors  $\mathrm{Hom}_{\mathcal{D}^b(\mathbf{mod} A)}(T, ?)$  and  $\pi^* \mathrm{Hom}_{\mathcal{D}^b(\mathbf{mod} B)}(S, \Sigma ?)$  restrict to inverse equivalences between  $\mathcal{T}_T$  and  $\mathcal{T}_S$ .*

(g) *The functors  $\mathrm{Hom}_{\mathcal{D}^b(\mathbf{mod} A)}(T, \Sigma ?)$  and  $\pi^* \mathrm{Hom}_{\mathcal{D}^b(\mathbf{mod} B)}(S, ?)$  restrict to inverse equivalences between  $\mathcal{F}_T$  and  $\mathcal{F}_S$ .*

Part (a) of Theorem 1.1 has been generalised to the case when  $A$  is a ring and  $T$  is a 2-term large silting complex with  $\mathbf{mod}$  replaced by  $\mathbf{Mod}$  (the category of all modules), see [8, Section 4.3]. In this paper, we give an alternative proof of Theorem 1.1 by using differential graded (=dg) algebras. We establish the result in the following three settings (Section 4.4):

- (1) the category  $\mathbf{Mod} A$  of all modules, where  $A$  is a ring;
- (2) the category  $\mathbf{mod} A$  of modules which are finitely generated over the base ring  $k$ , which is noetherian;
- (3) the category  $\mathbf{fdmod} A$  of modules which are finite-dimensional over the base ring  $k$ , which is a field.

Note that (3) is a special case of (2). Let us briefly explain the idea. Let  $A$  be a ring and  $T$  be a 2-term silting complex in  $K^b(\mathbf{proj} A)$ . Part (a) of our result in Setting (1) is the same as [8, Corollary 4.3.3(b)(c)] and a similar idea as that used for its proof was used in [8, Section 4.3]. Consider the truncated dg endomorphism algebra  $\Gamma$  of  $T$  (the dg endomorphism algebra of  $T$ , truncated at degree 0), which is a non-positive dg algebra, and put  $B = H^0(\Gamma) = \mathbf{End}_{K^b(\mathbf{proj} A)}(T)$ . Then the derived Hom-functor associated with  $T$  is a triangle equivalence between the derived categories of  $A$  and  $\Gamma$ . Then (a) follows immediately, just as the classical tilting theorem of Brenner and Butler is a consequence of the derived equivalence between  $A$  and  $B$  together with the bijection between torsion pairs and intermediate  $t$ -structures (see [15, Chapter III, Theorem 3.2] and [7, Chapter I, Theorem 3.1]). The idea for proving (c) and (d) was already explained by Buan and Zhou in the paragraph after [13, Theorem 1.1]. Let us repeat here. Let  $p: \Gamma \rightarrow B = H^0(\Gamma)$  be the canonical projection. Then by [12, Proposition A.3], the induction functor  $p_*: \mathbf{per}(\Gamma) \rightarrow \mathbf{per}(B) \simeq K^b(\mathbf{proj} B)$  takes  $\Sigma A$  to a 2-term silting complex in  $K^b(\mathbf{proj} B)$ . This 2-term silting complex is exactly the complex  $S$  in (b) and the algebra homomorphism  $\pi: A \rightarrow \bar{A}$  in (d) is the one induced by the functor  $p_*$ . The results (f) and (g) follow from the adjunction

between  $p_*$  and the restriction functor  $p^*$ . Actually we first establish these results for non-positive dg algebras in Sections 4.2 and 4.3 and then specialise it to algebras in Section 4.4.

We also study the question when  $S$  is a tilting complex. We show that this is the case in the following three cases:

- $A$  is hereditary,
- $k$  is a field and  $A$  is a finite-dimensional symmetric  $k$ -algebra,
- $T$  is a left mutation of  $A$  or a right mutation of  $\Sigma A$ .

The paper is structured as follows. In Section 2 we recall the basics on silting objects,  $t$ -structures and derived categories of dg algebras, including  $t$ -structures induced by silting objects and restrictions of such  $t$ -structures to certain subcategories. In Section 3 we study specifically  $t$ -structures induced by 2-term silting objects. In Section 4 we prove the silting theorem. In Section 5 we study the question when  $S$  is a tilting complex.

*Notations and conventions.* For a ring  $A$ , let  $\mathbf{Mod} A$  denote the category of (right)  $A$ -modules, and  $\mathbf{mod} A$  denote its full subcategory of  $A$ -modules finite generated over  $k$  and  $\mathbf{proj} A$  denote its full subcategory of finitely generated projective modules, respectively. If  $k$  is a field and  $A$  is a  $k$ -algebra, we denote by  $\mathbf{fdmod} A$  the category of  $A$ -modules which are finite-dimensional over  $k$ . For an additive category  $\mathcal{A}$ , denote by  $K^b(\mathcal{A})$  the bounded homotopy category of  $\mathcal{A}$  and, if  $\mathcal{A}$  is abelian, by  $\mathcal{D}^b(\mathcal{A})$  the bounded derived category of  $\mathcal{A}$ . For a complex  $X$  and an integer  $i$ , denote by  $H^i(X)$  the  $i$ -th cohomology of  $X$ .

Let  $\mathcal{T}$  be a triangulated category with shift functor  $\Sigma$ . For two subcategories  $\mathcal{X}$  and  $\mathcal{Y}$  of  $\mathcal{T}$  we denote by  $\mathcal{X} * \mathcal{Y}$  the full subcategory of  $\mathcal{T}$  consisting of objects  $Z$  such that there is a triangle  $X \rightarrow Z \rightarrow Y \rightarrow \Sigma X$  with  $X \in \mathcal{X}$  and  $Y \in \mathcal{Y}$ .

Throughout let  $k$  be a commutative ring.

## 2. NON-POSITIVE DG ALGEBRAS

In this section, we recall some notions and results on  $t$ -structures, silting objects and derived categories of differential graded (=dg) algebras.

**2.1. Silting objects and  $t$ -structures.** Let  $\mathcal{T}$  be a triangulated category with shift functor  $\Sigma$ . For a subcategory or a set of objects  $\mathcal{S}$  of  $\mathcal{T}$ , we denote by  $\mathbf{thick}(\mathcal{S})$  the

*thick subcategory* of  $\mathcal{T}$  generated by  $\mathcal{S}$ , *i.e.* the smallest triangulated subcategory of  $\mathcal{T}$  which contains  $\mathcal{S}$  and which is closed under taking direct summands. In the following, we give the definitions of silting objects and  $t$ -structures. For more details we refer to [3, 25, 6].

**Definition 2.1.** An object  $M$  of  $\mathcal{T}$  is said to be

- (1) *presilting* if  $\mathrm{Hom}_{\mathcal{T}}(M, \Sigma^i M) = 0$  for all  $i > 0$ ;
- (2) *silting* if it is presilting and  $\mathcal{T} = \mathbf{thick}(M)$ ;
- (3) *tilting* if  $\mathrm{Hom}_{\mathcal{T}}(M, \Sigma^i M) = 0$  for  $i \neq 0$  and  $\mathcal{T} = \mathbf{thick}(M)$ .

The following result is [26, Theorem 5.5] (see also [20, Proposition 2.8]).

**Proposition 2.2.** *Let  $M$  be a silting object of  $\mathcal{T}$ . Then*

$$\mathcal{T} = \bigcup_{n \in \mathbb{N}} (\Sigma^{-n} \mathbf{add}(M) * \cdots * \Sigma^n \mathbf{add}(M)).$$

Let  $M$  be a silting object of  $\mathcal{T}$  and  $n$  be a positive integer. We say that a silting object  $N$  of  $\mathcal{T}$  is  $n$ -term with respect to  $M$  if  $N \in \mathbf{add}(M) * \cdots * \Sigma^{n-1} \mathbf{add}(M)$ . The following lemma is a reformulation of [2, Proposition 3.8]. One can adapt the proof of [19, Corollary 2.4] to give a direct proof.

**Lemma 2.3.** *Let  $M$  and  $N$  be silting objects of  $\mathcal{T}$ . Then  $N$  is  $n$ -term with respect to  $M$  if and only if  $\Sigma^{n-1} M$  is  $n$ -term with respect to  $N$ .*

Let  $A$  be a  $k$ -algebra. Then the free module  $A_A$  of rank 1 is a typical silting object of  $K^b(\mathbf{proj} A)$ . It is in fact a tilting object. We will call silting objects (respectively, tilting objects) of  $K^b(\mathbf{proj} A)$  *silting complexes* (respectively, *tilting complexes*), and a silting complex is said to be  $n$ -term if it has non-trivial components only in degrees  $-(n-1), \dots, -1, 0$ .

**Definition 2.4.** A  $t$ -structure on  $\mathcal{T}$  is a pair  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$  of strict (that is, closed under isomorphisms) and full subcategories of  $\mathcal{T}$  such that the following conditions are satisfied for  $\mathcal{T}^{\geq i} := \Sigma^{-i} \mathcal{T}^{\geq 0}$ ,  $\mathcal{T}^{\leq i} := \Sigma^{-i} \mathcal{T}^{\leq 0}$

- (1)  $\mathcal{T}^{\leq 0} \subseteq \mathcal{T}^{\leq 1}$  and  $\mathcal{T}^{\geq 1} \subseteq \mathcal{T}^{\geq 0}$ ;
- (2)  $\mathrm{Hom}_{\mathcal{T}}(X, Y) = 0$  for  $X \in \mathcal{T}^{\leq 0}$  and  $Y \in \mathcal{T}^{\geq 1}$ ;
- (3)  $\mathcal{T} = \mathcal{T}^{\leq 0} * \mathcal{T}^{\geq 1}$ .

The  $t$ -structure  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$  is said to be *bounded* if

$$\bigcup_{i \in \mathbb{Z}} \mathcal{T}^{\leq i} = \mathcal{T} = \bigcup_{i \in \mathbb{Z}} \mathcal{T}^{\geq i}.$$

The category  $\mathcal{A} = \mathcal{T}^{\leq 0} \cap \mathcal{T}^{\geq 0}$  is called the *heart* of the  $t$ -structure  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$  and it is an abelian category due to [6, Théorème 1.3.6]. For any  $Z \in \mathcal{T}$ , there is a triangle by the condition (3)

$$X \longrightarrow Z \longrightarrow Y \longrightarrow \Sigma X$$

with  $X \in \mathcal{T}^{\leq 0}$  and  $Y \in \mathcal{T}^{\geq 1}$ . Due to (1) and (2) this triangle is unique up to a unique isomorphism, so the correspondences  $Z \mapsto X$  and  $Z \mapsto Y$  extend to functors  $\sigma^{\leq 0}: \mathcal{T} \rightarrow \mathcal{T}^{\leq 0}$  and  $\sigma^{\geq 1}: \mathcal{T} \rightarrow \mathcal{T}^{\geq 1}$ , respectively, called the *truncation functors*. The functor  $\sigma^{\leq 0}$  is right adjoint to the inclusion  $\mathcal{T}^{\leq 0} \rightarrow \mathcal{T}$  and the functor  $\sigma^{\geq 1}$  is left adjoint to the inclusion  $\mathcal{T}^{\geq 1} \rightarrow \mathcal{T}$ . Moreover, the functor  $H^0 = \sigma^{\leq 0}\sigma^{\geq 0}: \mathcal{T} \rightarrow \mathcal{A}$  is a cohomological functor.

*Example 2.5.* Let  $\mathcal{A}$  be an abelian category. Then  $\mathcal{D}^b(\mathcal{A})$  has a  $t$ -structure  $(\mathcal{D}_{\text{std}}^{\leq 0}, \mathcal{D}_{\text{std}}^{\geq 0})$ , where

$$\begin{aligned}\mathcal{D}_{\text{std}}^{\leq 0} &= \{X \in \mathcal{D}^b(\mathcal{A}) \mid H^i(X) = 0 \ \forall i > 0\}, \\ \mathcal{D}_{\text{std}}^{\geq 0} &= \{X \in \mathcal{D}^b(\mathcal{A}) \mid H^i(X) = 0 \ \forall i < 0\}.\end{aligned}$$

This  $t$ -structure is bounded and is called the *standard  $t$ -structure* on  $\mathcal{D}^b(\mathcal{A})$ .

Let  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$  be a  $t$ -structure and  $n$  be a positive integer. A  $t$ -structure  $(\mathcal{T}'^{\leq 0}, \mathcal{T}'^{\geq 0})$  is said to be  *$n$ -intermediate* with respect to  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$  if  $\mathcal{T}^{\leq -n+1} \subseteq \mathcal{T}'^{\leq 0} \subseteq \mathcal{T}^{\leq 0}$ , or equivalently,  $\mathcal{T}^{\geq 0} \subseteq \mathcal{T}'^{\geq 0} \subseteq \mathcal{T}^{\geq -n+1}$ . In this case, the  $t$ -structure  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$  is bounded if and only if so is  $(\mathcal{T}'^{\leq 0}, \mathcal{T}'^{\geq 0})$ . When  $n = 2$ , we say *intermediate* instead of 2-intermediate. The following construction is due to Happel–Reiten–Smalø, see [16, Chapter 1, Proposition 2.1] and [11, Proposition 2.5].

**Construction 2.6.** Let  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$  be a bounded  $t$ -structure on  $\mathcal{T}$  with heart  $\mathcal{A}$  and let  $(\mathcal{T}, \mathcal{F})$  be a torsion pair on  $\mathcal{A}$ . Define two full subcategories of  $\mathcal{T}$  by

$$\begin{aligned}\mathcal{T}'^{\leq 0} &= \{X \in \mathcal{T} \mid H^i(X) = 0 \text{ for } i > 0, \text{ and } H^0(X) \in \mathcal{T}\}, \\ \mathcal{T}'^{\geq 0} &= \{X \in \mathcal{T} \mid H^i(X) = 0 \text{ for } i < -1, \text{ and } H^{-1}(X) \in \mathcal{F}\}.\end{aligned}$$

Then  $(\mathcal{T}'^{\leq 0}, \mathcal{T}'^{\geq 0})$  is a  $t$ -structure on  $\mathcal{T}$  with heart  $\mathcal{B} = (\Sigma\mathcal{F}) * \mathcal{T}$ , and  $(\Sigma\mathcal{F}, \mathcal{T})$  is a torsion pair of  $\mathcal{B}$ . It is clearly intermediate with respect to the given  $t$ -structure  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$ . It is called the *Happel–Reiten–Smalø tilt* of  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$  at the torsion pair  $(\mathcal{T}, \mathcal{F})$ .

**Proposition 2.7** ([7, Chapter I, Theorem 3.1], [28, Proposition 2.1]). *Let  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$  be a bounded  $t$ -structure on  $\mathcal{T}$  with heart  $\mathcal{A}$ . Then taking the HRS tilt defines a bijective map from the set of torsion pairs of  $\mathcal{A}$  to the set of intermediate  $t$ -structures on  $\mathcal{T}$  with respect to  $(\mathcal{T}^{\leq 0}, \mathcal{T}^{\geq 0})$ . Its inverse takes  $(\mathcal{T}'^{\leq 0}, \mathcal{T}'^{\geq 0})$  to  $(\mathcal{T}'^{\leq 0} \cap \mathcal{A}, \mathcal{T}'^{\geq 1} \cap \mathcal{A})$ .*

**2.2. Derived categories of dg algebras.** A *dg  $k$ -algebra*  $A$  is a graded  $k$ -algebra with a differential  $d$  which makes  $A$  a complex of  $k$ -modules such that the multiplication  $A \otimes_k A \rightarrow A$  is a chain map, *i.e.* the graded Leibniz rule holds:

$$d(ab) = d(a)b + (-1)^{|a|}ad(b),$$

where  $a$  and  $b$  are homogeneous elements of  $A$  and  $|a|$  denotes the degree of  $a$ . For two dg  $k$ -algebras  $A$  and  $B$ , a dg algebra homomorphism  $f: A \rightarrow B$  is a  $k$ -algebra homomorphism which is a chain map.

We follow [23, 24] to introduce the derived category of a dg algebra. Let  $A$  be a dg  $k$ -algebra. For two dg  $A$ -modules  $M$  and  $N$ , the morphism complex  $\mathcal{H}om_A(M, N)$  is the complex whose degree  $i$  component consists of the homogeneous  $A$ -module homomorphisms from  $M$  to  $N$  of degree  $i$ , and whose differential is given by

$$d(f) = d_N \circ f - (-1)^{|f|} f \circ d_M,$$

where  $f \in \mathcal{H}om_A(M, N)$  is homogeneous. We call  $\mathcal{E}nd_A(M) := \mathcal{H}om_A(M, M)$  the *dg endomorphism algebra* of  $M$ . Let  $\mathcal{C}_{dg}(A)$  be the dg category of dg  $A$ -modules: its objects are dg  $A$ -modules, and for dg  $A$ -modules  $M$  and  $N$  we have  $\mathbf{Hom}_{\mathcal{C}_{dg}(A)}(M, N) = \mathcal{H}om_A(M, N)$ . Let  $K(A) = H^0\mathcal{C}_{dg}(A)$  be the homotopy category of  $\mathcal{C}_{dg}(A)$ : its objects are dg  $A$ -modules, and for two dg  $A$ -modules  $M$  and  $N$  we have

$$\mathbf{Hom}_{K(A)}(M, N) := H^0 \mathbf{Hom}_{\mathcal{C}_{dg}(A)}(M, N) = H^0 \mathcal{H}om_A(M, N).$$

The *derived category*  $\mathcal{D}(A)$  of dg  $A$ -modules is defined as the triangle quotient of  $K(A)$  by the subcategory of acyclic dg  $A$ -modules. A dg  $A$ -module  $P$  is said to be  $\mathcal{K}$ -projective if  $\mathcal{H}om_A(P, M)$  is acyclic whenever  $M$  is an acyclic dg  $A$ -module. If  $P$  is a  $\mathcal{K}$ -projective dg  $A$ -module and  $M$  is any dg  $A$ -module, then

$$\mathbf{Hom}_{\mathcal{D}(A)}(P, \Sigma^i M) = \mathbf{Hom}_{K(A)}(P, \Sigma^i M) \quad (2.1)$$

for any  $i \in \mathbb{Z}$ . For example,  $A_A$  is  $\mathcal{K}$ -projective. Thus we have

$$\mathbf{Hom}_{\mathcal{D}(A)}(A, \Sigma^i M) = \mathbf{Hom}_{K(A)}(A, \Sigma^i M) = H^i(M). \quad (2.2)$$

In particular, by Auslander's projectivisation, there is a  $k$ -linear equivalence

$$H^0 = \mathbf{Hom}_{\mathcal{D}(A)}(A, ?) : \mathbf{add}_{\mathcal{D}(A)}(A_A) \rightarrow \mathbf{proj} H^0(A). \quad (2.3)$$

By [23, Theorem 3.1], for any dg  $A$ -module  $M$  there is a  $\mathcal{K}$ -projective dg module  $P_M$  together with a quasi-isomorphism  $P_M \rightarrow M$  of dg  $A$ -modules.

Denote by  $\mathcal{D}^b(A)$  the full subcategory of  $\mathcal{D}(A)$  whose objects are the dg  $A$ -modules with bounded total cohomology. Let  $\mathbf{per}(A) = \mathbf{thick}_{\mathcal{D}(A)}(A_A)$  be the thick subcategory of  $\mathcal{D}(A)$  generated by  $A_A$ . In the case  $A$  is a  $k$ -algebra (viewed as a dg  $k$ -algebra concentrated in degree 0), a dg  $A$ -module is exactly a complex of  $A$ -modules, we have  $\mathcal{D}(A) = \mathcal{D}(\mathbf{Mod} A)$ , and there are canonical equivalences  $K^b(\mathbf{proj} A) \simeq \mathbf{per}(A)$  and  $\mathcal{D}^b(\mathbf{Mod} A) \simeq \mathcal{D}^b(A)$ . The first restricted equivalence in the following lemma is well-known, since  $\mathbf{per}(A)$  is exactly the subcategory of  $\mathcal{D}(A)$  of compact objects ([23, Theorem 5.3]).

**Lemma 2.8.** *Let  $A$  and  $B$  be two dg  $k$ -algebras and  $F : \mathcal{D}(B) \rightarrow \mathcal{D}(A)$  be a triangle equivalence. Then  $F$  restricts to triangle equivalences  $\mathbf{per}(B) \rightarrow \mathbf{per}(A)$  and  $\mathcal{D}^b(B) \rightarrow \mathcal{D}^b(A)$ .*

*Proof.* We claim that

$$\mathcal{D}^b(A) = \{M \in \mathcal{D}(A) \mid \mathbf{Hom}_{\mathcal{D}(A)}(P, \Sigma^i M) = 0 \ \forall i \in \mathbb{Z} \text{ with } |i| \gg 0 \ \forall P \in \mathbf{per}(A)\}.$$

Then the equivalence on  $\mathcal{D}^b$  follows from that on  $\mathbf{per}$ . In the above claim the inclusion ‘ $\supseteq$ ’ is obvious by (2.2) since  $A_A \in \mathbf{per}(A)$ . For the inverse inclusion we apply dévissage. Let

$$\mathcal{S} = \{P \in \mathcal{D}(A) \mid \mathrm{Hom}_{\mathcal{D}(A)}(P, \Sigma^i M) = 0 \ \forall i \in \mathbb{Z} \text{ with } |i| \gg 0 \ \forall M \in \mathcal{D}^b(A)\}.$$

Again by (2.2) we have  $A_A \in \mathcal{S}$ . Moreover, it is easily seen that  $\mathcal{S}$  is closed under taking shifts, extensions and direct summands. Therefore  $\mathbf{per}(A) \subseteq \mathcal{S}$  and the inverse inclusion follows.  $\square$

**2.3. Derived equivalences.** Let  $A$  and  $B$  be two dg  $k$ -algebras and  $X$  be a dg  $B$ - $A$ -bimodule. Then there is an adjoint pair of triangle functors

$$\mathcal{D}(A) \xrightleftharpoons[\mathbb{R}\mathrm{Hom}_A(X, ?)]{? \otimes_B^{\mathbb{L}} X} \mathcal{D}(B).$$

Also there is a dg  $k$ -algebra homomorphism  $\rho: B \rightarrow \mathcal{E}nd_A(X)$ ,  $b \mapsto (x \mapsto bx)$ , which we call the *representation map* of  $X$ . The following is the one-object version of [23, Lemma 6.1 (a)].

**Lemma 2.9.** *Suppose that  $X_A$  is  $\mathcal{K}$ -projective over  $A^1$ . Then the derived tensor functor  $? \otimes_B^{\mathbb{L}} X: \mathcal{D}(B) \rightarrow \mathcal{D}(A)$  is fully faithful if and only if  $X_A$  is self-compact in  $\mathcal{D}(A)$  and  $\rho$  is a quasi-isomorphism; it is a triangle equivalence if and only if  $X_A$  is a compact generator of  $\mathcal{D}(A)$  (i.e.  $\mathrm{thick}_{\mathcal{D}(A)}(X_A) = \mathbf{per}(A)$ ) and  $\rho$  is a quasi-isomorphism.*

**Corollary 2.10.** *Let  $M$  be a  $\mathcal{K}$ -projective dg  $A$ -module which is a compact generator of  $\mathcal{D}(A)$ . Then  $? \otimes_{\mathcal{E}nd_A(M)}^{\mathbb{L}} M: \mathcal{D}(\mathcal{E}nd_A(M)) \rightarrow \mathcal{D}(A)$  is a triangle equivalence.*

*Proof.* This follows immediately from Lemma 2.9 because in this case the representation map is the identity map of  $\mathcal{E}nd_A(M)$ .  $\square$

The following is the one-object version of [23, Lemma 6.2 (b)].

**Lemma 2.11.** *Assume that  $X_A$  is  $\mathcal{K}$ -projective over  $A$ . If  $? \otimes_B^{\mathbb{L}} X: \mathcal{D}(B) \rightarrow \mathcal{D}(A)$  is a triangle equivalence, then there is a natural isomorphism of triangle functors  $\mathbb{R}\mathrm{Hom}_A(X, ?) \cong ? \otimes_A^{\mathbb{L}} X^{tr}$ , where  $X^{tr} = \mathcal{H}om_A(X, A)$ .*

Let  $A$  and  $B$  be two dg  $k$ -algebras and  $f: B \rightarrow A$  be a homomorphism of dg algebras. Then we can view  $A$  as a dg  $B$ - $A$ -bimodule via  $f$ , whose representation map is exactly  $f$ . There is the induction functor  $f_* = ? \otimes_B^{\mathbb{L}} A: \mathcal{D}(B) \rightarrow \mathcal{D}(A)$  and the restriction functor  $f^* = \mathbb{R}\mathrm{Hom}_A(A, ?): \mathcal{D}(A) \rightarrow \mathcal{D}(B)$ , which form an adjoint

---

<sup>1</sup>In [23, Lemma 6.1 (a) and Lemma 6.2], the assumption on  $X_A$  is to have the property (P) (i.e. to be cofibrant in the terminology of [24, Section 3.2]). But the proofs still work if we make the slightly weaker assumption that  $X_A$  is  $\mathcal{K}$ -projective.

pair of triangle functors. Moreover, the following diagram commutes

$$\begin{array}{ccc} \mathrm{add}_{\mathcal{D}(B)}(B_B) & \xrightarrow{H^0} & \mathrm{proj} H^0(B) \\ \downarrow f_* & & \downarrow (H^0 f)_* \\ \mathrm{add}_{\mathcal{D}(A)}(A_A) & \xrightarrow{H^0} & \mathrm{proj} H^0(A). \end{array} \quad (2.4)$$

**Corollary 2.12.**  *$f_*: \mathcal{D}(B) \rightarrow \mathcal{D}(A)$  is a triangle equivalence if and only if  $f$  is a quasi-isomorphism.*

*Proof.* This follows immediately from Lemma 2.9 because in this case the representation map is exactly  $f$ .  $\square$

**2.3.1. The truncated dg endomorphism algebra of a silting object.** A dg  $k$ -algebra is said to be *non-positive* if its components in positive degrees vanish. Such dg algebras are closely related to silting objects. Let  $A$  be a dg  $k$ -algebra and  $T$  be a silting object in  $\mathrm{per}(A)$ . For example,  $A_A$  is a silting object in  $\mathrm{per}(A)$  if  $A$  is non-positive. We assume further that  $T$  is a  $\mathcal{K}$ -projective dg  $A$ -module and construct a non-positive dg algebra from  $T$  as follows. Recall that the degree  $i$  component of  $\mathcal{E}nd_A(T) = \mathcal{H}om_A(T, T)$  consists of those  $A$ -linear maps from  $T$  to itself which are homogeneous maps of degree  $i$ . The differential of  $\mathcal{E}nd_A(T)$  takes a homogeneous map  $f$  of degree  $i$  to  $d_T \circ f - (-1)^i f \circ d_T$ . This differential and the composition of maps make  $\mathcal{E}nd_A(T)$  into a dg  $k$ -algebra. Since  $T$  is a silting object, it follows from (2.1) that  $\mathcal{E}nd_A(T)$  has cohomologies concentrated in non-positive degrees and  $H^0 \mathcal{E}nd_A(T) = \mathrm{End}_{\mathcal{D}(A)}(T)$ . Therefore  $B := \sigma^{\leq 0} \mathcal{E}nd_A(T)$  is a non-positive dg  $k$ -algebra and the embedding  $B \rightarrow \mathcal{E}nd_A(T)$  is a quasi-isomorphism of dg algebras, where  $\sigma^{\leq 0}$  is the standard truncation at degree 0. In this way  $T$  becomes a dg  $B$ - $A$ -bimodule with representation map the embedding  $B \rightarrow \mathcal{E}nd_A(T)$ , so by Lemma 2.9, the associated derived tensor functor  $? \otimes_B^{\mathbb{L}} T: \mathcal{D}(B) \rightarrow \mathcal{D}(A)$  is a triangle equivalence with quasi-inverse  $\mathbb{R}\mathrm{Hom}_A(T, ?) = \mathcal{H}om_A(T, ?): \mathcal{D}(A) \rightarrow \mathcal{D}(B)$ . We will call this dg algebra  $B$  the *truncated dg endomorphism algebra* of  $T$ .

We assume further that  $A$  is non-positive and that  $T$  is  $n$ -term, that is, it is  $n$ -term with respect to  $A_A$ . Let  $\tilde{S} = \mathcal{H}om_A(T, \Sigma^{n-1}A)$ . Then by Lemma 2.3,  $\Sigma^{n-1}A$  is a silting object of  $\mathrm{per}(A)$  which is  $n$ -term with respect to  $T$ , and hence  $\tilde{S}$  is an  $n$ -term silting object of  $\mathrm{per}(B)$ . Moreover,  $\tilde{S}$  is naturally a dg  $A$ - $B$ -bimodule, and by Lemma 2.11 we have isomorphisms of triangle equivalences:

$$\mathbb{R}\mathrm{Hom}_A(T, ?) \cong \Sigma^{1-n} (? \otimes_A^{\mathbb{L}} \tilde{S}) \text{ and } ? \otimes_B^{\mathbb{L}} T \cong \Sigma^{n-1} \mathbb{R}\mathrm{Hom}_B(\tilde{S}, ?).$$

**2.4. Non-positive dg algebras: silting  $t$ -structures.** Recall that a dg  $k$ -algebra  $A$  is said to be non-positive if the degree  $i$  component  $A^i$  vanishes for all  $i > 0$ . A  $k$ -algebra can be viewed as a non-positive dg  $k$ -algebra concentrated in degree 0.

Let  $A$  be a non-positive dg  $k$ -algebra. The canonical projection  $p: A \rightarrow H^0(A)$  is a homomorphism of dg algebras. We view a module over  $H^0(A)$  as a dg module over  $A$  via this homomorphism. This defines a natural functor  $\mathrm{Mod} H^0(A) \rightarrow \mathcal{D}(A)$ ,



which is fully faithful. We will identify  $\mathbf{Mod} H^0(A)$  with its essential image in  $\mathcal{D}(A)$ . Put

$$\begin{aligned}\mathcal{D}_{\text{std}}^{\leq 0} &= \{X \in \mathcal{D}(A) \mid H^i(X) = 0 \ \forall i > 0\}, \\ \mathcal{D}_{\text{std}}^{\geq 0} &= \{X \in \mathcal{D}(A) \mid H^i(X) = 0 \ \forall i < 0\}.\end{aligned}$$

**Lemma 2.13** ([4, Lemma 2.2 and Proposition 2.3]). *The pair  $(\mathcal{D}_{\text{std}}^{\leq 0}, \mathcal{D}_{\text{std}}^{\geq 0})$  is a  $t$ -structure on  $\mathcal{D}(A)$  and the functor  $H^0: \mathcal{D}(A) \rightarrow \mathbf{Mod} H^0(A)$  of taking the 0-th cohomology restricts to an equivalence from the heart to  $\mathbf{Mod} H^0(A)$ , with the embedding  $\mathbf{Mod} H^0(A) \rightarrow \mathcal{D}(A)$  as a quasi-inverse. The associated truncation functors are the standard truncations.*

Now let  $T$  be a silting object in  $\text{per}(A)$  and put

$$\begin{aligned}\mathcal{D}_T^{\leq 0} &= \{X \in \mathcal{D}(A) \mid \text{Hom}_{\mathcal{D}(A)}(T, \Sigma^i X) = 0 \ \forall i > 0\}, \\ \mathcal{D}_T^{\geq 0} &= \{X \in \mathcal{D}(A) \mid \text{Hom}_{\mathcal{D}(A)}(T, \Sigma^i X) = 0 \ \forall i < 0\}.\end{aligned}$$

Thanks to (2.2), we have  $\mathcal{D}_{\text{std}}^{\leq 0} = \mathcal{D}_A^{\leq 0}$  and  $\mathcal{D}_{\text{std}}^{\geq 0} = \mathcal{D}_A^{\geq 0}$ . The first part of the following lemma is a special case of [18, Theorem 1.3] (cf. also [7, Chapter III, Proposition 2.8] and [3, Corollary 4.7]). We include a direct proof.

**Lemma 2.14.** *The pair  $(\mathcal{D}_T^{\leq 0}, \mathcal{D}_T^{\geq 0})$  is a  $t$ -structure on  $\mathcal{D}(A)$  and the Hom-functor  $\text{Hom}_{\mathcal{D}(A)}(T, ?): \mathcal{D}(A) \rightarrow \mathbf{Mod} \text{End}_{\mathcal{D}(A)}(T)$  restricts to an equivalence from the heart to  $\mathbf{Mod} \text{End}_{\mathcal{D}(A)}(T)$ . Moreover, it is  $n$ -intermediate with respect to the standard  $t$ -structure if and only if  $T$  is  $n$ -term.*

*Proof.* Assume that  $T$  is  $\mathcal{K}$ -projective over  $A$ . Let  $B$  be the truncated dg endomorphism algebra of  $T$  and recall from Section 2.3.1 that the derived tensor functor  $? \otimes_B^{\mathbb{L}} T: \mathcal{D}(B) \rightarrow \mathcal{D}(A)$  is a triangle equivalence. It takes  $B$  to  $T$  and it takes the pair  $(\mathcal{D}_{\text{std}}^{\leq 0}(B), \mathcal{D}_{\text{std}}^{\geq 0}(B))$  to the pair  $(\mathcal{D}_T^{\leq 0}, \mathcal{D}_T^{\geq 0})$ . The former pair, by Lemma 2.13, is a  $t$ -structure on  $\mathcal{D}(B)$  such that  $H^0 = \text{Hom}_{\mathcal{D}(B)}(B, ?): \mathcal{D}(B) \rightarrow \mathbf{Mod} \text{End}_{\mathcal{D}(A)}(T)$  restricts to an equivalence from the heart to  $\mathbf{Mod} \text{End}_{\mathcal{D}(A)}(T)$ . The first statement follows immediately.

For the second statement, it suffices to show that if  $T$  is  $n$ -term but not  $(n-1)$ -term then  $(\mathcal{D}_T^{\leq 0}, \mathcal{D}_T^{\geq 0})$  is  $n$ -intermediate but not  $(n-1)$ -intermediate. Assume that  $T$  is  $n$ -term. Then by dévissage we have  $\mathcal{D}_{\text{std}}^{\leq -n+1} \subseteq \mathcal{D}_T^{\leq 0}$  and  $\mathcal{D}_T^{\geq 0} \supseteq \mathcal{D}_{\text{std}}^{\geq 0}$ . This shows that  $(\mathcal{D}_T^{\leq 0}, \mathcal{D}_T^{\geq 0})$  is  $n$ -intermediate. Assume further that  $T$  is not  $(n-1)$ -term. Then there is a triangle

$$T' \longrightarrow T \longrightarrow T'' \longrightarrow \Sigma T'$$

with  $T' \in \text{add}(A) * \cdots * \Sigma^{n-2} \text{add}(A)$  and  $0 \not\cong T'' \in \Sigma^{n-1} \text{add}(A)$ . Since  $H^0(\Sigma^{-n+1} T'')$  is a non-zero projective  $H^0(A)$ -module, there exists an  $H^0(A)$ -module  $Y$  such that  $\text{Hom}_{H^0(A)}(H^0(\Sigma^{-n+1} T''), Y) \neq 0$ . We let  $X = \Sigma^{n-2} Y$  and apply  $\text{Hom}_{\mathcal{D}(A)}(?, X)$  to

the above triangle. Inspection on the resulting long sequence shows that

$$\begin{aligned}\mathrm{Hom}_{\mathcal{D}(A)}(T, \Sigma X) &\cong \mathrm{Hom}_{\mathcal{D}(A)}(T'', \Sigma X) = \mathrm{Hom}_{\mathcal{D}(A)}(\Sigma^{-n+1}T'', Y) \\ &= \mathrm{Hom}_{H^0(A)}(H^0(\Sigma^{-n+1}T''), Y) \neq 0,\end{aligned}$$

so  $X \notin \mathcal{D}_T^{\leq 0}$ . This shows that  $\mathcal{D}_{\mathrm{std}}^{\leq -n+2} \not\subseteq \mathcal{D}_T^{\leq 0}$ , and hence  $(\mathcal{D}_T^{\leq 0}, \mathcal{D}_T^{\geq 0})$  is not  $(n-1)$ -intermediate.  $\square$

**2.5. Restriction of silting  $t$ -structures on subcategories.** Let  $A$  be a non-positive dg  $k$ -algebra. Let  $\mathcal{D}_{fg}(A)$  denote the full subcategory of  $\mathcal{D}(A)$  consisting of dg  $A$ -modules  $M$  such that  $H^*(M)$  is finitely generated over the base ring  $k$ . If  $k$  is a noetherian ring, this is a triangulated subcategory of  $\mathcal{D}(A)$ ; if further  $A$  is a  $k$ -algebra and is finitely generated over  $k$ , then there is a canonical triangle equivalence  $\mathcal{D}^b(\mathrm{mod} A) \rightarrow \mathcal{D}_{fg}(A)$ . When  $k$  is a field, let  $\mathcal{D}_{fd}(A)$  denote the full subcategory of  $\mathcal{D}(A)$  consisting of those dg  $A$ -modules with finite-dimensional total cohomology. So in this case  $\mathcal{D}_{fd}(A) = \mathcal{D}_{fg}(A)$ . If  $A$  is a finite-dimensional  $k$ -algebra over the field  $k$ , then there is a canonical triangle equivalence  $\mathcal{D}^b(\mathrm{fdmod} A) \rightarrow \mathcal{D}_{fd}(A)$ .

Let  $T$  be a silting object of  $\mathrm{per}(A)$ . Throughout this subsection we fix one of the following settings:

- (1)  $\mathbf{D} = \mathcal{D}^b$  and  $\mathcal{M} = \mathrm{Mod}$ ;
- (2)  $k$  is a noetherian ring,  $\mathbf{D} = \mathcal{D}_{fg}$  and  $\mathcal{M} = \mathrm{mod}$ ;
- (3)  $k$  is a field,  $\mathbf{D} = \mathcal{D}_{fd}$  and  $\mathcal{M} = \mathrm{fdmod}$ .

Note that (3) is a special case of (2). Put

$$\begin{aligned}\mathbf{D}_{\mathrm{std}}^{\leq 0} &= \mathbf{D}(A) \cap \mathcal{D}_{\mathrm{std}}^{\leq 0}, \quad \mathbf{D}_{\mathrm{std}}^{\geq 0} = \mathbf{D}(A) \cap \mathcal{D}_{\mathrm{std}}^{\geq 0}, \\ \mathbf{D}_T^{\leq 0} &= \mathbf{D}(A) \cap \mathcal{D}_T^{\leq 0}, \quad \mathbf{D}_T^{\geq 0} = \mathbf{D}(A) \cap \mathcal{D}_T^{\geq 0}.\end{aligned}$$

**Proposition 2.15.** (a) *Let  $B$  be another non-positive dg  $k$ -algebra. Then any triangle equivalence  $F: \mathcal{D}(B) \rightarrow \mathcal{D}(A)$  restricts to a triangle equivalence  $\mathbf{D}(B) \rightarrow \mathbf{D}(A)$ .*

(b) *The pair  $(\mathbf{D}_{\mathrm{std}}^{\leq 0}, \mathbf{D}_{\mathrm{std}}^{\geq 0})$  is a bounded  $t$ -structure on  $\mathbf{D}(A)$  and  $H^0: \mathbf{D}(A) \rightarrow \mathcal{M}_{H^0(A)}$ , the functor of taking the 0-th cohomology, restricts to an equivalence from the heart to  $\mathcal{M}_{H^0(A)}$ , with the embedding  $\mathcal{M}_{H^0(A)} \rightarrow \mathbf{D}(A)$  as a quasi-inverse. The associated truncation functors are the standard truncation functors.*

(c) *The pair  $(\mathbf{D}_T^{\leq 0}, \mathbf{D}_T^{\geq 0})$  is a bounded  $t$ -structure on  $\mathbf{D}(A)$  and the Hom-functor  $\mathrm{Hom}_{\mathcal{D}(A)}(T, ?): \mathbf{D}(A) \rightarrow \mathcal{M}_{\mathrm{End}_{\mathcal{D}(A)}(T)}$  restricts to an equivalence from the heart to  $\mathcal{M}_{\mathrm{End}_{\mathcal{D}(A)}(T)}$ . It is  $n$ -intermediate with respect to the standard  $t$ -structure if and only if  $T$  is  $n$ -term.*

*Proof.* (a) For the setting (1), this is contained in Lemma 2.8. For the setting (3), this is contained in [21, Lemma 3.1]. For the setting (2), we claim that  $\mathcal{D}_{fg}(A)$

admits the following intrinsic description

$$\mathcal{D}_{fg}(A) = \{X \in \mathcal{D}(A) \mid \bigoplus_{i \in \mathbb{Z}} \mathrm{Hom}_{\mathcal{D}(A)}(P, \Sigma^i X) \text{ is finitely generated over } k \\ \forall P \in \mathrm{per}(A)\}.$$

This follows by dévissage, similar to that used in the proof of Lemma 2.8. Then the desired result follows from the restriction of  $F$  on  $\mathrm{per}$  (Lemma 2.8).

(b) Since the standard truncation  $\sigma^{\leq 0}$  preserves cohomologies in non-positive degrees, it restricts to a functor  $\sigma^{\leq 0}: \mathbf{D}(A) \rightarrow \mathbf{D}(A)$ . It follows that the  $t$ -structure in Lemma 2.13 restricts to  $\mathbf{D}(A)$  and produces the  $t$ -structure  $(\mathbf{D}_{\mathrm{std}}^{\leq 0}, \mathbf{D}_{\mathrm{std}}^{\geq 0})$ . It is rather clear that this  $t$ -structure is bounded. We remark that in the setting (3) this statement is [22, Proposition 2.1(b)].

(c) Similar to Lemma 2.14.  $\square$

### 3. 2-TERM SILTING OBJECTS ON NON-POSITIVE DG ALGEBRAS

Let  $A$  be a non-positive dg  $k$ -algebra. Throughout this section we fix one of the following settings:

- (1)  $\mathbf{D} = \mathcal{D}^b$  and  $\mathcal{M} = \mathbf{Mod}$ ;
- (2)  $k$  is a noetherian ring,  $\mathbf{D} = \mathcal{D}_{fg}$  and  $\mathcal{M} = \mathbf{mod}$ ;
- (3)  $k$  is a field,  $\mathbf{D} = \mathcal{D}_{fd}$  and  $\mathcal{M} = \mathbf{fdmod}$ .

Put

$$\mathbf{D}_{\mathrm{std}}^{\leq 0} = \mathbf{D}(A) \cap \mathcal{D}_{\mathrm{std}}^{\leq 0}, \quad \mathbf{D}_{\mathrm{std}}^{\geq 0} = \mathbf{D}(A) \cap \mathcal{D}_{\mathrm{std}}^{\geq 0}.$$

By Proposition 2.15, the pair  $(\mathbf{D}_{\mathrm{std}}^{\leq 0}, \mathbf{D}_{\mathrm{std}}^{\geq 0})$  is a bounded  $t$ -structure on  $\mathbf{D}(A)$ . Let  $T$  be a 2-term silting object of  $\mathrm{per}(A)$ , which is  $\mathcal{K}$ -projective over  $A$ . Put

$$\mathbf{D}_T^{\leq 0} = \mathbf{D}(A) \cap \mathcal{D}_T^{\leq 0}, \quad \mathbf{D}_T^{\geq 0} = \mathbf{D}(A) \cap \mathcal{D}_T^{\geq 0}.$$

By Proposition 2.15, the pair  $(\mathbf{D}_T^{\leq 0}, \mathbf{D}_T^{\geq 0})$  is a bounded  $t$ -structure on  $\mathbf{D}(A)$ , which is intermediate with respect to  $(\mathbf{D}_{\mathrm{std}}^{\leq 0}, \mathbf{D}_{\mathrm{std}}^{\geq 0})$ .

Consider the full subcategories of  $\mathcal{M}_{H^0(A)}$  given by

$$\mathcal{T}_T = \{M \in \mathcal{M}_{H^0(A)} \mid \mathrm{Hom}_{\mathbf{D}(A)}(T, \Sigma M) = 0\}, \\ \mathcal{F}_T = \{N \in \mathcal{M}_{H^0(A)} \mid \mathrm{Hom}_{\mathbf{D}(A)}(T, N) = 0\}.$$

For  $M \in \mathcal{M}_{H^0(A)}$  we have  $\mathrm{Hom}_{\mathbf{D}(A)}(T, \Sigma^i M) = 0$  unless  $i = 0, 1$ , since  $T$  is 2-term. It follows that  $\mathcal{T}_T = \mathcal{M}_{H^0(A)} \cap \mathbf{D}_T^{\leq 0}$  and  $\mathcal{F}_T = \mathcal{M}_{H^0(A)} \cap \mathbf{D}_T^{\geq 1}$ . The following result is then a consequence of Proposition 2.7.

**Proposition 3.1.** *The pair  $(\mathcal{T}_T, \mathcal{F}_T)$  is a torsion pair of  $\mathcal{M}_{H^0(A)}$  and  $(\mathbf{D}_T^{\leq 0}, \mathbf{D}_T^{\geq 0})$  is the HRS tilt of the standard  $t$ -structure at this torsion pair.*

Set

$\text{tors}(\mathcal{M}_{H^0(A)})$  = the set of torsion pairs of  $\mathcal{M}_{H^0(A)}$ ,

$2\text{-silt}(A)$  = the set of equivalence classes of 2-term silting objects  $T$  in  $\text{per}(A)$ ,

$\text{int-t-str}(\mathbf{D}(A))$  = the set of intermediate bounded  $t$ -structures on  $\mathbf{D}(A)$  with respect to the standard  $t$ -structure  $(\mathbf{D}_{\text{std}}^{\leq 0}, \mathbf{D}_{\text{std}}^{\geq 0})$ .

Here two silting objects  $T$  and  $S$  of  $\text{per}(A)$  are said to be *equivalent* if  $\text{add}(T) = \text{add}(S)$ . Then by Proposition 3.1 we obtain the following commutative diagram:

$$\begin{array}{ccc} 2\text{-silt}(A) & \xrightarrow{\quad\quad\quad} & \text{int-t-str}(\mathbf{D}(A)) \\ & \searrow \quad \quad \swarrow & \\ & \text{tors}(\mathcal{M}_{H^0(A)}) & \end{array}$$

Recall that the canonical projection  $p: A \rightarrow H^0(A)$  is a homomorphism of dg algebras. Therefore we have the induction functor  $p_*: \mathcal{D}(A) \rightarrow \mathcal{D}(H^0(A))$  and the restriction functor  $p^*: \mathcal{D}(H^0(A)) \rightarrow \mathcal{D}(A)$ , which form an adjoint pair of triangle functors. They restrict to triangle functors  $p_*: \text{per}(A) \rightarrow \text{per}(H^0(A))$  and  $p^*: \mathbf{D}(H^0(A)) \rightarrow \mathbf{D}(A)$ . Moreover, restricted on  $\text{add}_{\text{per}(A)}(A_A)$  the induction functor  $p_*$  is isomorphic to the equivalence  $H^0: \text{add}_{\text{per}(A)}(A_A) \rightarrow \text{proj } H^0(A)$  (see (2.4)); restricted on  $\mathcal{M}_{H^0(A)}$  the restriction functor  $p^*$  is the identity functor, thus  $p^*$  is a realisation functor in the sense of [14, Section 2.2].

**Proposition 3.2.** (a) ([12, Proposition A.3]) *The induction functor  $p_*: \text{per}(A) \rightarrow \text{per}(H^0(A))$  induces a bijection between the sets of equivalence classes of 2-term silting objects.*

(b) *The restriction functor  $p^*: \mathbf{D}(H^0(A)) \rightarrow \mathbf{D}(A)$  induces a bijection between the sets of intermediate  $t$ -structures, which is compatible with the bijection in Proposition 2.7.*

*Proof.* (b) Recall that  $\mathcal{M}_{H^0(A)}$  embeds to both  $\mathbf{D}(H^0(A))$  and  $\mathbf{D}(A)$  as the heart of the standard  $t$ -structures and that the functor  $p^*$  is the identity functor on  $\mathcal{M}_{H^0(A)}$ . Let  $(\mathcal{C}^{\leq 0}, \mathcal{C}^{\geq 0})$  be an intermediate  $t$ -structure on  $\mathbf{D}(H^0(A))$ . By Proposition 2.7, there is a torsion pair  $(\mathcal{T}, \mathcal{F})$  of  $\mathcal{M}_{H^0(A)}$ , which, by Proposition 2.7 again, corresponds to an intermediate  $t$ -structure  $(\mathcal{D}^{\leq 0}, \mathcal{D}^{\geq 0})$  on  $\mathbf{D}(A)$ . The desired bijection is  $(\mathcal{C}^{\leq 0}, \mathcal{C}^{\geq 0}) \mapsto (\mathcal{D}^{\leq 0}, \mathcal{D}^{\geq 0})$ . Precisely, we have

$\mathcal{D}^{\leq 0}$  = the smallest full subcategory of  $\mathbf{D}(A)$  which contains  $p^*(\mathcal{C}^{\leq 0})$

and which is closed under extensions and direct summands,

$\mathcal{D}^{\geq 0}$  = the smallest full subcategory of  $\mathbf{D}(A)$  which contains  $p^*(\mathcal{C}^{\geq 0})$

and which is closed under extensions and direct summands.  $\square$

*Remark 3.3.* If  $T$  is a silting object of  $\mathbf{per}(A)$  which is not 2-term, then  $p_*(T)$  is in general not a silting object of  $\mathbf{per}(H^0(A))$ . For example, let  $Q$  be the graded quiver

$$1 \xrightarrow{\alpha} 2$$

with  $\alpha$  in degree  $-1$ . Denote by  $S_1$  and  $S_2$  the two simple modules concentrated in degree 0, corresponding to the vertices 1 and 2 respectively. Then  $H^0(A) = k \times k$ ,  $T = \Sigma^3 S_1 \oplus S_2$  is a silting object of  $\mathbf{per}(A)$  but  $p_*(T) = \Sigma^3 S_1 \oplus \Sigma^2 S_1 \oplus S_2$  is not a silting object of  $\mathbf{per}(H^0(A))$ .

We summarise the above results in a commutative diagram.

**Theorem 3.4.** *There is a commutative diagram:*

$$\begin{array}{ccc}
 2\text{-silt}(A) & \xrightarrow{\quad\quad\quad} & \text{int-t-str}(\mathbf{D}(A)) \\
 \downarrow & \searrow & \swarrow \\
 & \text{tors}(\mathcal{M}_{H^0(A)}) & \\
 \swarrow & \nearrow & \downarrow \\
 2\text{-silt}(H^0(A)) & \xrightarrow{\quad\quad\quad} & \text{int-t-str}(\mathbf{D}(H^0(A)))
 \end{array}$$

*Proof.* Since  $(p_*, p^*)$  is an adjoint pair, there is an isomorphism for any  $X \in \mathcal{D}(H^0(A))$

$$\text{Hom}_{\mathcal{D}(H^0(A))}(p_*(T), \Sigma^i X) \cong \text{Hom}_{\mathcal{D}(A)}(T, \Sigma^i p^*(X)),$$

which implies the commutativity of the left triangle. The commutativity of other triangles has been shown above.  $\square$

#### 4. THE SILTING THEOREM

In this section we will prove the silting theorem in the more general setting of non-positive dg algebras and then specialise it to algebras. Fix one of the following settings:

- (1)  $\mathbf{D} = \mathcal{D}^b$ ,  $\mathcal{M} = \mathbf{Mod}$ ;
- (2)  $k$  is a noetherian ring,  $\mathbf{D} = \mathcal{D}_{fg}$ ,  $\mathcal{M} = \mathbf{mod}$ ;
- (3)  $k$  is a field,  $\mathbf{D} = \mathcal{D}_{fd}$ ,  $\mathcal{M} = \mathbf{fdmod}$ .

**4.1. An abstract version.** Let  $\Lambda$  and  $\Gamma$  be non-positive dg  $k$ -algebras,  $A = H^0(\Lambda)$  and  $B = H^0(\Gamma)$ . Assume that there is an adjoint pair of triangle equivalences

$$\begin{array}{c}
 \mathcal{D}(\Lambda) \\
 \tilde{G} \uparrow \downarrow \tilde{F} \\
 \mathcal{D}(\Gamma)
 \end{array}$$

Then  $T = \tilde{G}(\Gamma)$  is a silting object of  $\mathbf{per}(\Lambda)$ . By Proposition 2.15, the above equivalences restrict to an adjoint pair of triangle equivalences

$$\begin{array}{c} \mathbf{D}(\Lambda) \\ \uparrow \downarrow \\ \mathbf{D}(\Gamma), \end{array}$$

and the equivalence  $\tilde{G}$  takes the standard  $t$ -structure on  $\mathbf{D}(\Gamma)$  to the  $t$ -structure  $(\mathbf{D}_T^{\leq 0}, \mathbf{D}_T^{\geq 0})$ .

In the rest of this subsection we assume that  $T$  is 2-term. Consider the functors

$$\begin{array}{ccc} \mathcal{M}_A & & \mathcal{M}_A \\ G=H^0 \circ \tilde{G} \uparrow \downarrow F=H^0 \circ \tilde{F} & & G'=H^{-1} \circ \tilde{G} \uparrow \downarrow F'=H^1 \circ \tilde{F} \\ \mathcal{M}_B, & & \mathcal{M}_B. \end{array}$$

In Section 3 we defined two subcategories  $\mathcal{T}_T$  and  $\mathcal{F}_T$  of  $\mathcal{M}_A$ . We have

$$\mathcal{T}_T = \{M \in \mathcal{M}_A \mid F'(M) = 0\}, \mathcal{F}_T = \{N \in \mathcal{M}_A \mid F(N) = 0\},$$

because

$$\begin{aligned} F &= H^0 \circ \tilde{F}|_{\mathcal{M}_A} = \mathbf{Hom}_{\mathcal{D}(\Gamma)}(\Gamma, \tilde{F}(?))|_{\mathcal{M}_A} \cong \mathbf{Hom}_{\mathcal{D}(\Lambda)}(T, ?)|_{\mathcal{M}_A} \\ F' &= H^1 \circ \tilde{F}|_{\mathcal{M}_A} = \mathbf{Hom}_{\mathcal{D}(\Gamma)}(\Gamma, \Sigma \tilde{F}(?))|_{\mathcal{M}_A} \cong \mathbf{Hom}_{\mathcal{D}(\Lambda)}(T, \Sigma ?)|_{\mathcal{M}_A}. \end{aligned}$$

As in [8] the adjoint pair  $(F, G)$  can also be described in terms of the  $A$ -module  $H^0(T)$ , which is a silting module over  $A$  by [5, Theorem 4.9] (and a support  $\tau$ -tilting module by [1, Theorem 3.2], if  $k$  is a field and  $A$  is a finite-dimensional  $k$ -algebra). Taking  $H^0$  yields an algebra homomorphism  $B = \mathbf{End}_{\mathcal{D}(\Lambda)}(T) \rightarrow \mathbf{End}_A(H^0(T))$ , which makes  $H^0(T)$  a  $B$ - $A$ -bimodule. Moreover, there are isomorphisms

$$F(M) \cong \mathbf{Hom}_{\mathcal{D}(\Lambda)}(T, M) \cong \mathbf{Hom}_{\mathcal{D}(\Lambda)}(H^0(T), M) \cong \mathbf{Hom}_A(H^0(T), M),$$

which are compatible with the  $B$ -actions. This establishes the first isomorphism below, and the second isomorphism is obtained by adjunction.

**Lemma 4.1.** *We have  $F \cong \mathbf{Hom}_A(H^0(T), ?)$  and  $G \cong ? \otimes_B H^0(T)$ .*

Put

$$\mathcal{X}_T = \{X \in \mathcal{M}_B \mid G(X) = 0\}, \mathcal{Y}_T = \{Y \in \mathcal{M}_B \mid G'(Y) = 0\}$$

**Theorem 4.2.** (a)  $(\mathcal{T}_T, \mathcal{F}_T)$  is a torsion pair of  $\mathcal{M}_A$ .

(b)  $(\mathcal{X}_T, \mathcal{Y}_T)$  is a torsion pair of  $\mathcal{M}_B$ .

(c) There are equivalences

$$\begin{array}{ccc} \mathcal{T}_T & & \mathcal{F}_T \\ G|_{\mathcal{Y}_T} \uparrow \downarrow F|_{\mathcal{T}_T} & & G'|_{\mathcal{X}_T} \uparrow \downarrow F'|_{\mathcal{F}_T} \\ \mathcal{Y}_T, & & \mathcal{X}_T, \end{array}$$

*Proof.* (a) This is the first statement of Proposition 3.1.

(c) For  $Y \in \mathcal{M}_B$ , we claim that the dg module  $\tilde{G}(Y)$  has cohomologies concentrated in degrees 0 and  $-1$ . Thus if  $Y \in \mathcal{Y}_T$ , then  $G(Y) \cong \tilde{G}(Y)$ . Similarly, for  $M \in \mathcal{T}_T$  we have  $F(M) \cong \tilde{F}(M)$ . It follows that  $F|_{\mathcal{T}_T}: \mathcal{T}_T \rightarrow \mathcal{Y}_T$  and  $G|_{\mathcal{Y}_T}: \mathcal{Y}_T \rightarrow \mathcal{T}_T$  are mutually quasi-inverse equivalences. The statement for  $F'$  and  $G'$  is proved similarly.

Now we prove the claim. By Lemma 2.3,  $\Sigma\Lambda$  is 2-term with respect to  $T$ , so there is a triangle

$$\Lambda \longrightarrow T' \longrightarrow T'' \longrightarrow \Sigma\Lambda$$

with  $T', T'' \in \text{add}(T)$ . Applying  $\text{Hom}_{\mathcal{D}(\Lambda)}(?, \tilde{G}(Y))$  to this triangle we obtain an exact sequence

$$\text{Hom}_{\mathcal{D}(\Lambda)}(T', \Sigma^i \tilde{G}(Y)) \longrightarrow H^i(\tilde{G}(Y)) \longrightarrow \text{Hom}_{\mathcal{D}(\Lambda)}(T'', \Sigma^{i+1} \tilde{G}(Y)).$$

But  $\text{Hom}_{\mathcal{D}(\Lambda)}(T', \Sigma^i \tilde{G}(Y)) \cong \text{Hom}_{\mathcal{D}(\Gamma)}(\tilde{F}(T'), \Sigma^i Y)$  vanishes unless  $i = 0$  since  $\tilde{F}(T') \in \text{add}(\Gamma)$ , and similarly  $\text{Hom}_{\mathcal{D}(\Lambda)}(T'', \Sigma^{i+1} \tilde{G}(Y))$  vanishes unless  $i = -1$ . The claim follows.

(b) By Proposition 3.1, the  $t$ -structure  $(\mathbf{D}_T^{\leq 0}, \mathbf{D}_T^{\geq 0})$  is the HRS tilt of the standard  $t$ -structure on  $\mathbf{D}(\Lambda)$  at the torsion pair  $(\mathcal{T}_T, \mathcal{F}_T)$ . Therefore  $(\Sigma\mathcal{F}_T, \mathcal{T}_T)$  is a torsion pair of its heart  $\mathcal{B}$ , by Construction 2.6. Moreover, the triangle equivalence  $\tilde{G}: \mathbf{D}(\Gamma) \rightarrow \mathbf{D}(\Lambda)$  takes the standard  $t$ -structure on  $\mathbf{D}(\Gamma)$  to  $(\mathbf{D}_T^{\leq 0}, \mathbf{D}_T^{\geq 0})$ , in particular, it restricts to an equivalence from  $\mathcal{M}_B$  to  $\mathcal{B}$ , and by the proof of (c), it takes the pair  $(\mathcal{X}_T, \mathcal{Y}_T)$  to  $(\Sigma\mathcal{F}_T, \mathcal{T}_T)$ . It follows that  $(\mathcal{X}_T, \mathcal{Y}_T)$  is a torsion pair of  $\mathcal{M}_B$ .  $\square$

**4.2. The first step.** Let  $\Lambda$  be a non-positive dg  $k$ -algebra,  $A = H^0(\Lambda)$ , and let  $T$  be a 2-term silting object in  $\text{per}(\Lambda)$  which is  $\mathcal{K}$ -projective,  $\Gamma$  the truncated dg endomorphism algebra of  $T$  (see Section 2.3.1), and  $B = H^0(\Gamma) = \text{End}_{\mathcal{D}(\Lambda)}(T)$ . Recall from Section 2.3.1 that there is an adjoint pair of triangle equivalences

$$\begin{array}{c} \mathcal{D}(\Lambda) \\ \uparrow \downarrow \text{?} \otimes_{\Gamma}^{\mathbb{L}} T \quad \mathbb{R}\text{Hom}_{\Lambda}(T, ?) \\ \mathcal{D}(\Gamma). \end{array}$$

Consider the functors

$$\begin{array}{ccc} \mathcal{M}_A & & \mathcal{M}_A \\ \uparrow \downarrow G = H^0(? \otimes_{\Gamma}^{\mathbb{L}} T) \quad F = H^0 \mathbb{R}\text{Hom}_{\Lambda}(T, ?) & & \uparrow \downarrow G' = H^{-1}(? \otimes_{\Gamma}^{\mathbb{L}} T) \quad F' = H^1 \mathbb{R}\text{Hom}_{\Lambda}(T, ?) \\ \mathcal{M}_B & & \mathcal{M}_B. \end{array}$$

and put

$$\begin{aligned} \mathcal{T}_T &= \{M \in \mathcal{M}_A \mid F'(M) = 0\}, \quad \mathcal{F}_T = \{N \in \mathcal{M}_A \mid F(N) = 0\}, \\ \mathcal{X}_T &= \{X \in \mathcal{M}_B \mid G(X) = 0\}, \quad \mathcal{Y}_T = \{Y \in \mathcal{M}_B \mid G'(Y) = 0\}. \end{aligned}$$

Applying Theorem 4.2 we obtain

- Theorem 4.3.** (a)  $(\mathcal{T}_T, \mathcal{F}_T)$  is a torsion pair of  $\mathcal{M}_A$ .  
 (b)  $(\mathcal{X}_T, \mathcal{Y}_T)$  is a torsion pair of  $\mathcal{M}_B$ .  
 (c) There are equivalences

$$\begin{array}{ccc} & \mathcal{T}_T & \\ G|_{\mathcal{Y}_T} \uparrow & & \downarrow F|_{\mathcal{T}_T} \\ & \mathcal{Y}_T & \end{array} \quad \begin{array}{ccc} & \mathcal{F}_T & \\ G'|_{\mathcal{X}_T} \uparrow & & \downarrow F'|_{\mathcal{F}_T} \\ & \mathcal{X}_T & \end{array}$$

Following Section 2.3.1, let  $\tilde{S} = \mathbb{R}\mathrm{Hom}_\Lambda(T, \Sigma\Lambda) = \mathcal{H}om_\Lambda(T, \Sigma\Lambda)$ , which is a 2-term silting object of  $\mathbf{per}(\Gamma)$ . Moreover,  $\tilde{S}$  is naturally a dg  $\Lambda$ - $\Gamma$ -bimodule, and there are isomorphisms of triangle equivalences:

$$\mathbb{R}\mathrm{Hom}_\Lambda(T, ?) \cong \Sigma^{-1}(? \otimes_\Lambda^{\mathbb{L}} \tilde{S}) \text{ and } ? \otimes_\Gamma^{\mathbb{L}} T \cong \Sigma \mathbb{R}\mathrm{Hom}_\Gamma(\tilde{S}, ?).$$

Consider

$$\begin{array}{ccc} & \mathcal{M}_B & \\ \Psi = H^0(? \otimes_\Lambda^{\mathbb{L}} \tilde{S}) \uparrow & & \downarrow \Phi = H^0 \mathbb{R}\mathrm{Hom}_\Gamma(\tilde{S}, ?) \\ & \mathcal{M}_A & \end{array} \quad \begin{array}{ccc} & \mathcal{M}_B & \\ \Psi' = H^{-1}(? \otimes_\Lambda^{\mathbb{L}} \tilde{S}) \uparrow & & \downarrow \Phi' = H^1 \mathbb{R}\mathrm{Hom}_\Gamma(\tilde{S}, ?) \\ & \mathcal{M}_A & \end{array}$$

Then by Theorem 4.2, there is a torsion pair  $(\mathcal{T}_{\tilde{S}}, \mathcal{F}_{\tilde{S}})$  of  $\mathcal{M}_B$  and a torsion pair  $(\mathcal{X}_{\tilde{S}}, \mathcal{Y}_{\tilde{S}})$  of  $\mathcal{M}_A$ , where

$$\begin{aligned} \mathcal{T}_{\tilde{S}} &= \{M \in \mathcal{M}_B \mid \Phi'(M) = 0\} = \{M \in \mathcal{M}_B \mid \mathbf{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, \Sigma M) = 0\}, \\ \mathcal{F}_{\tilde{S}} &= \{N \in \mathcal{M}_B \mid \Phi(N) = 0\} = \{N \in \mathcal{M}_B \mid \mathbf{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, N) = 0\}, \\ \mathcal{X}_{\tilde{S}} &= \{X \in \mathcal{M}_A \mid \Psi(X) = 0\}, \\ \mathcal{Y}_{\tilde{S}} &= \{Y \in \mathcal{M}_A \mid \Psi'(Y) = 0\}. \end{aligned}$$

The above isomorphisms of triangle functors imply isomorphisms

$$\Phi \cong G', \quad \Phi' \cong G, \quad \Psi \cong F', \quad \text{and} \quad \Psi' \cong F.$$

Therefore we have

- Theorem 4.4.** (a)  $(\mathcal{T}_{\tilde{S}}, \mathcal{F}_{\tilde{S}}) = (\mathcal{X}_T, \mathcal{Y}_T)$  and  $(\mathcal{X}_{\tilde{S}}, \mathcal{Y}_{\tilde{S}}) = (\mathcal{T}_T, \mathcal{F}_T)$ .  
 (b) The functors  $F' = \mathbf{Hom}_{\mathcal{D}(\Lambda)}(T, \Sigma?)$  and  $\Phi = \mathbf{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, ?)$  restrict to inverse equivalences between  $\mathcal{F}_T$  and  $\mathcal{T}_{\tilde{S}}$ .  
 (c) The functors  $F = \mathbf{Hom}_{\mathcal{D}(\Lambda)}(T, ?)$  and  $\Phi' = \mathbf{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, \Sigma?)$  restrict to inverse equivalences between  $\mathcal{T}_T$  and  $\mathcal{F}_{\tilde{S}}$ .

**4.3. The second step.** Keep the notation and assumptions as in the beginning of Section 4.2. Since  $\Sigma\Lambda$  is a 2-term silting object of  $\mathbf{per}(\Lambda)$  with respect to  $T$ , there is a triangle in  $\mathbf{per}(\Lambda)$ :

$$\Lambda \longrightarrow T' \xrightarrow{f} T'' \longrightarrow \Sigma\Lambda \tag{4.1}$$



with  $T', T'' \in \mathbf{add}_{\mathbf{per}(\Lambda)}(T)$ . By applying  $\mathbf{Hom}_{\mathbf{per}(\Lambda)}(T, ?)$ , we obtain a homomorphism of projective  $B$ -modules

$$\mathbf{Hom}_{\mathbf{per}(\Lambda)}(T, T') \xrightarrow{\mathbf{Hom}(T, f)} \mathbf{Hom}_{\mathbf{per}(\Lambda)}(T, T'').$$

Consider the canonical projection  $p: \Gamma \rightarrow B$ , which induces two triangle functors  $p_*: \mathbf{per}(\Gamma) \rightarrow \mathbf{per}(B) = K^b(\mathbf{proj} B)$  and  $p^*: \mathbf{D}(B) \rightarrow \mathbf{D}(\Gamma)$ . Recall that  $\tilde{S} = \mathbb{R}\mathbf{Hom}_{\Lambda}(T, \Sigma\Lambda)$  is a 2-term silting object of  $\mathbf{per}(\Gamma)$ . Let  $S = p_*(\tilde{S})$  and  $\bar{A} = \mathbf{End}_{\mathcal{D}(\mathbf{Mod} B)}(S)$ . The part (a) below says that the complex  $S$  is the same as the complex  $\mathbf{Q}$  in [13, Theorem 1.1].

**Theorem 4.5.** (a)  $S \cong \mathbf{Cone}(\mathbf{Hom}(T, f))$ ;  
 (b)  $S$  is a 2-term silting complex in  $K^b(\mathbf{proj} B)$ ;  
 (c) There is a surjective algebra homomorphism  $\pi: A \rightarrow \bar{A}$ . If  $T$  is tilting, then  $\pi$  is an isomorphism.

*Proof.* (a) Applying the triangle equivalence  $\mathbb{R}\mathbf{Hom}_{\Lambda}(T, ?)$  to the triangle (4.1), we obtain a triangle in  $\mathbf{per}(\Gamma)$ :

$$\mathbb{R}\mathbf{Hom}_{\Lambda}(T, \Lambda) \rightarrow \mathbb{R}\mathbf{Hom}_{\Lambda}(T, T') \xrightarrow{\mathbb{R}\mathbf{Hom}_{\Lambda}(T, f)} \mathbb{R}\mathbf{Hom}_{\Lambda}(T, T'') \rightarrow \tilde{S}.$$

Applying  $p_*$  we obtain a triangle in  $K^b(\mathbf{proj} B)$ :

$$\Sigma^{-1}S \rightarrow p_*\mathbb{R}\mathbf{Hom}_{\Lambda}(T, T') \xrightarrow{p_*\mathbb{R}\mathbf{Hom}_{\Lambda}(T, f)} p_*\mathbb{R}\mathbf{Hom}_{\Lambda}(T, T'') \rightarrow S.$$

Recall that restricted on  $\mathbf{add}_{\mathbf{per}(\Gamma)}(\Gamma_{\Gamma})$  the induction functor  $p_*$  is isomorphic to the equivalence  $H^0: \mathbf{add}_{\mathbf{per}(\Gamma)}(\Gamma_{\Gamma}) \rightarrow \mathbf{proj} B$ . Thus the above map  $p_*\mathbb{R}\mathbf{Hom}_{\Lambda}(T, f)$  is isomorphic to  $H^0\mathbb{R}\mathbf{Hom}_{\Lambda}(T, f) = \mathbf{Hom}(T, f)$ . This shows that  $S \cong \mathbf{Cone}(\mathbf{Hom}(T, f))$ .

- (b) This follows from Proposition 3.2(a).  
 (c) There is a chain of algebra homomorphisms

$$A = \mathbf{End}_{\mathbf{per}(\Lambda)}(\Lambda) \xrightarrow{\Sigma} \mathbf{End}_{\mathbf{per}(\Lambda)}(\Sigma\Lambda) \xrightarrow{\mathbb{R}\mathbf{Hom}_{\Lambda}(T, ?)} \mathbf{End}_{\mathbf{per}(\Gamma)}(\tilde{S}) \xrightarrow{p_*} \mathbf{End}_{K^b(\mathbf{proj} B)}(S) = \bar{A}.$$

We define  $\pi: A \rightarrow \bar{A}$  as the composition. The first two homomorphisms, induced by equivalences, are isomorphisms, and the third one, induced by  $p_*$ , is surjective with kernel the homomorphisms  $\tilde{S} \rightarrow \tilde{S}$  which factors through a morphism  $\Sigma P_1 \rightarrow P_2$  with  $P_1, P_2 \in \mathbf{add}_{\mathbf{per}(\Gamma)}(\Gamma)$ , by [12, Proposition A.5]. If  $T$  is a tilting complex, then  $\mathbf{Hom}_{\mathbf{per}(\Gamma)}(\Sigma\Gamma, \Gamma) \cong \mathbf{Hom}_{\mathbf{per}(\Lambda)}(\Sigma T, T) = 0$ , so the third homomorphism is also an isomorphism, so is  $\pi$ .  $\square$

Now let  $\bar{\Lambda}$  be the truncated dg endomorphism algebra of  $S$ . Then  $H^0(\bar{\Lambda}) = \bar{A}$ . Applying Section 4.2 to the 2-term silting object  $S$  of  $K^b(\mathbf{proj} B) \simeq \mathbf{per}(B)$ , we obtain

two adjoint pairs

$$\begin{array}{ccc} \mathcal{M}_B & & \mathcal{M}_B \\ \bar{\Psi}=H^0(? \otimes_{\bar{A}}^{\mathbb{L}} S) \uparrow \downarrow \bar{\Phi}=H^0 \mathbb{R} \mathrm{Hom}_B(S, ?) & & \bar{\Psi}'=H^{-1}(? \otimes_{\bar{A}}^{\mathbb{L}} S) \uparrow \downarrow \bar{\Phi}'=H^1 \mathbb{R} \mathrm{Hom}_B(S, ?) \\ \mathcal{M}_{\bar{A}}, & & \mathcal{M}_{\bar{A}}, \end{array}$$

There is a torsion pair  $(\mathcal{T}_S, \mathcal{F}_S)$  of  $\mathcal{M}_B$  and a torsion pair  $(\mathcal{X}_S, \mathcal{Y}_S)$  of  $\mathcal{M}_{\bar{A}}$  together with equivalences

$$\begin{array}{ccc} \mathcal{T}_S & & \mathcal{F}_S \\ \bar{\Psi}|_{\mathcal{Y}_S} \uparrow \downarrow \bar{\Phi}|_{\mathcal{T}_S} & & \bar{\Psi}'|_{\mathcal{X}_S} \uparrow \downarrow \bar{\Phi}'|_{\mathcal{F}_S} \\ \mathcal{Y}_S, & & \mathcal{X}_S, \end{array}$$

where

$$\begin{aligned} \mathcal{T}_S &= \{M \in \mathcal{M}_B \mid \bar{\Phi}'(M) = 0\}, \quad \mathcal{F}_S = \{N \in \mathcal{M}_B \mid \bar{\Phi}(N) = 0\}; \\ \mathcal{X}_S &= \{X \in \mathcal{M}_{\bar{A}} \mid \bar{\Psi}(X) = 0\}, \quad \mathcal{Y}_S = \{Y \in \mathcal{M}_{\bar{A}} \mid \bar{\Psi}'(Y) = 0\}. \end{aligned}$$

**Theorem 4.6.** (a)  $(\mathcal{T}_S, \mathcal{F}_S) = (\mathcal{X}_T, \mathcal{Y}_T)$ ;

(b) The functors  $F' = \mathrm{Hom}_{\mathcal{D}(\Lambda)}(T, \Sigma ?)$  and  $\pi^* \mathrm{Hom}_{\mathcal{D}(B)}(S, ?) = \pi^* \bar{\Phi}$  restrict to inverse equivalences between  $\mathcal{F}_T$  and  $\mathcal{T}_S$ .

(c) The functors  $F = \mathrm{Hom}_{\mathcal{D}(\Lambda)}(T, ?)$  and  $\pi^* \mathrm{Hom}_{\mathcal{D}(B)}(S, \Sigma ?) = \pi^* \bar{\Phi}'$  restrict to inverse equivalences between  $\mathcal{T}_T$  and  $\mathcal{F}_S$ .

(d)  $\pi^*(\mathcal{Y}_S) = \mathcal{F}_T$  and  $\pi^*(\mathcal{X}_S) = \mathcal{T}_T$ .

*Proof.* By Theorem 3.4 we have  $(\mathcal{T}_S, \mathcal{F}_S) = (\mathcal{T}_{\tilde{S}}, \mathcal{F}_{\tilde{S}})$ .

(a) This follows from Theorem 4.4(a).

(b) Since  $\mathcal{T}_{\tilde{S}} = \mathcal{T}_S$ , by Theorem 4.4(b) it suffices to prove that there is an isomorphism  $\bar{\Phi}|_{\mathcal{T}_S} \cong (\pi^* \bar{\Phi})|_{\mathcal{T}_S}$ , i.e.  $\mathrm{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, ?)|_{\mathcal{T}_S} \cong (\pi^* \mathrm{Hom}_{\mathcal{D}(B)}(S, ?))|_{\mathcal{T}_S}$ . For this, recall that  $p_*$  is left adjoint to  $p^*$ , and hence there is a commutative diagram for any  $a \in A$  and any  $M \in \mathcal{D}(B)$

$$\begin{array}{ccc} \mathrm{Hom}_{\mathcal{D}(B)}(S, M) & \xlongequal{\quad} & \mathrm{Hom}_{\mathcal{D}(B)}(p_*(\tilde{S}), M) \longrightarrow \mathrm{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, p^*(M)) \\ (p_* \mathbb{R} \mathrm{Hom}_{\Lambda}(T, \Sigma a))^* \downarrow & & (\mathbb{R} \mathrm{Hom}_{\Lambda}(T, \Sigma a))^* \downarrow \\ \mathrm{Hom}_{\mathcal{D}(B)}(S, M) & \xlongequal{\quad} & \mathrm{Hom}_{\mathcal{D}(B)}(p_*(\tilde{S}), M) \longrightarrow \mathrm{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, p^*(M)) \end{array}$$

where the two horizontal arrows are isomorphisms of  $k$ -modules. Going through the definition of the algebra homomorphism  $\pi$  in the proof of Theorem 4.5(c), we see that this exactly shows that  $\pi^* \mathrm{Hom}_{\mathcal{D}(B)}(S, M)$  and  $\mathrm{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, p^*(M))$  are isomorphic as  $A$ -modules. Since  $p^*|_{\mathcal{M}_B}$  is the identity functor, it follows that  $(\pi^* \mathrm{Hom}_{\mathcal{D}(B)}(S, ?))|_{\mathcal{T}_S} \cong \mathrm{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, ?)|_{\mathcal{T}_S}$ .

(c) Similar to (b).

(d) Because both  $\bar{\Phi}|_{\mathcal{T}_S}: \mathcal{T}_S \rightarrow \mathcal{Y}_S$  and  $(\pi^* \bar{\Phi})|_{\mathcal{T}_S}: \mathcal{T}_S \rightarrow \mathcal{F}_T$  are equivalences, we deduce that  $\pi^*$  restricts to an equivalence  $\mathcal{Y}_S \rightarrow \mathcal{F}_T$ , in particular,  $\pi^*(\mathcal{Y}_S) = \mathcal{F}_T$ . The other equality is proved similarly.  $\square$

**4.4. Special case:**  $\Lambda = A$ . Let  $A$  be a  $k$ -algebra,  $T$  a 2-term silting complex in  $K^b(\text{proj } A)$ ,  $\Gamma$  the truncated dg endomorphism algebra of  $T$ , and  $B = H^0(\Gamma) = \text{End}_{\mathcal{D}(A)}(T)$ . Fix one of the following settings:

- (1)  $\mathbf{D} = \mathcal{D}^b$ ,  $\mathcal{M} = \mathbf{Mod}$ ;
- (2)  $k$  is a noetherian ring,  $\mathbf{D} = \mathcal{D}_{fg}$ ,  $\mathcal{M} = \mathbf{mod}$ ;
- (3)  $k$  is a field,  $\mathbf{D} = \mathcal{D}_{fd}$ ,  $\mathcal{M} = \mathbf{fdmod}$ .

**Theorem 4.7.** (a) *There is a torsion pair  $(\mathcal{T}_T, \mathcal{F}_T)$  of  $\mathcal{M}_A$  and a torsion pair  $(\mathcal{X}_T, \mathcal{Y}_T)$  of  $\mathcal{M}_B$  together with natural equivalences  $\text{Hom}_{\mathcal{D}(A)}(T, ?): \mathcal{T}_T \xrightarrow{\cong} \mathcal{Y}_T$  and  $\text{Hom}_{\mathcal{D}(A)}(T, \Sigma?): \mathcal{F}_T \xrightarrow{\cong} \mathcal{X}_T$ .*  
 (b) *Let  $S \cong \text{Cone}(\text{Hom}(T, f))$ .*  
 (c)  *$S$  is a 2-term silting complex in  $K^b(\text{proj } B)$ .*  
 (d) *There is a surjective algebra homomorphism  $\pi: A \rightarrow \bar{A} = \text{End}_{K^b(\text{proj } B)}(S)$ .*  
 (e)  *$\pi$  is an isomorphism if and only if  $T$  is tilting.*  
 (f) *The functors  $\text{Hom}_{\mathcal{D}(A)}(T, ?)$  and  $\pi^* \text{Hom}_{\mathcal{D}(B)}(S, \Sigma?)$  restrict to inverse equivalences between  $\mathcal{T}_T$  and  $\mathcal{F}_S$ .*  
 (g) *The functors  $\text{Hom}_{\mathcal{D}(A)}(T, \Sigma?)$  and  $\pi^* \text{Hom}_{\mathcal{D}(B)}(S, ?)$  restrict to inverse equivalences between  $\mathcal{F}_T$  and  $\mathcal{T}_S$ .*  
 (h)  *$\mathcal{T}_S = \mathcal{X}_T$  and  $\mathcal{F}_S = \mathcal{Y}_T$ ;  $\pi^*(\mathcal{Y}_S) = \mathcal{F}_T$  and  $\pi^*(\mathcal{X}_S) = \mathcal{T}_T$ .*

*Proof.* We apply Theorems 4.5 and 4.6 in this special case. It remains to show that if  $\pi$  is an isomorphism then  $T$  is tilting. We do not have a proof different from the one given in the end of the proof of [13, Proposition 4.1].  $\square$

*Remark 4.8.* Let us show that  $\pi$  is exactly the map  $\Phi$  defined in [13, Proposition 4.1]. Then in the setting (3) the statements (a)–(g) form Theorem 1.1 and the second statement in (h) is exactly [13, Theorem 4.4].

Let  $a \in A = \text{End}_A(A)$ . According to [13, Section 4] there is a morphism of triangles in  $\text{per}(A)$

$$\begin{array}{ccccccc} A & \longrightarrow & T' & \xrightarrow{f} & T'' & \longrightarrow & \Sigma A \\ \downarrow a & & \downarrow b & & \downarrow c & & \downarrow \Sigma a \\ A & \longrightarrow & T' & \xrightarrow{f} & T'' & \longrightarrow & \Sigma A \end{array}$$

Thus  $\Sigma A \cong \text{Cone}(f)$  in  $K^b(\text{proj } A)$  and one checks by the construction of  $b$  and  $c$  that under this isomorphism  $\Sigma a \in \text{End}(\Sigma A)$  corresponds to  $(b, c)$ . Now applying  $p_* \mathbb{R}\text{Hom}_A(T, ?)$  we see that  $\pi$  is exactly the map  $\Phi$ .

**4.5. A partial generalisation to  $n$ -term silting.** When the third author gave a talk on Theorem 4.7 in USTC in early 2021, Yu Ye asked whether it can be generalised to the case when  $T$  is an  $n$ -term silting object. In this subsection we partially generalise Section 4.2. We do not know whether Section 4.3 can be easily generalised, because it is not known whether or not  $S$  is a silting object if  $T$  is not 2-term. Keep the notation and assumptions as in the beginning of Section 4.2 except that here we assume that  $T$  is  $n$ -term ( $n \geq 2$ ).

For  $0 \leq i \leq n-1$ , consider the functor

$$\begin{array}{ccc} & \mathcal{M}_A & \\ G^i = H^{-i}(\mathbb{?} \otimes_{\Gamma}^{\mathbb{L}} T) \uparrow & \downarrow & \downarrow F^i = H^i \mathbb{R} \mathrm{Hom}_{\Lambda}(T, \mathbb{?}) \\ & \mathcal{M}_B & \end{array}$$

and put

$$\begin{aligned} \mathcal{T}_T^i &= \{M \in \mathcal{M}_A \mid F^j(M) = 0 \ \forall j \neq i\}, \\ \mathcal{Y}_T^i &= \{Y \in \mathcal{M}_B \mid G^j(Y) = 0 \ \forall j \neq i\}. \end{aligned}$$

The following result was established in the literature as

- [27, Theorem 1.16], if we are in Setting (1) and if further  $A$  is a ring and  $T$  is a tilting  $A$ -module;
- [15, Chapter III, Theorem 3.2], if we are in Setting (3) and if further  $A$  is a finite-dimensional  $k$ -algebra and  $T$  is a tilting  $A$ -module;
- [9, Corollary 2.6], if we are in Setting (1) and if further  $A$  is a ring.

The proof is similar to that of Theorem 4.3(c).

**Theorem 4.9.** *For  $0 \leq i \leq n-1$ , there is an equivalence*

$$\begin{array}{ccc} & \mathcal{T}_T^i & \\ G^i|_{\mathcal{Y}_T^i} \uparrow & \downarrow & \downarrow F^i|_{\mathcal{T}_T^i} \\ & \mathcal{Y}_T^i & \end{array}$$

Following Section 2.3.1, let  $\tilde{S} = \mathbb{R} \mathrm{Hom}_{\Lambda}(T, \Sigma^{n-1} \Lambda) = \mathcal{H} \mathrm{om}_{\Lambda}(T, \Sigma^{n-1} \Lambda)$ , which is an  $n$ -term silting object of  $\mathbf{per}(\Gamma)$ . Moreover,  $\tilde{S}$  is naturally a dg  $\Lambda$ - $\Gamma$ -bimodule, and there are isomorphisms of triangle equivalences:

$$\mathbb{R} \mathrm{Hom}_{\Lambda}(T, \mathbb{?}) \cong \Sigma^{1-n}(\mathbb{?} \otimes_{\Lambda}^{\mathbb{L}} \tilde{S}) \text{ and } \mathbb{?} \otimes_{\Gamma}^{\mathbb{L}} T \cong \Sigma^{n-1} \mathbb{R} \mathrm{Hom}_{\Gamma}(\tilde{S}, \mathbb{?}).$$

For  $0 \leq i \leq n-1$ , consider the functor

$$\begin{array}{ccc} & \mathcal{M}_B & \\ \Psi^i = H^{-i}(\mathbb{?} \otimes_{\Lambda}^{\mathbb{L}} \tilde{S}) \uparrow & \downarrow & \downarrow \Phi^i = H^i \mathbb{R} \mathrm{Hom}_{\Gamma}(\tilde{S}, \mathbb{?}) \\ & \mathcal{M}_A & \end{array}$$

and put

$$\begin{aligned} \mathcal{T}_{\tilde{S}}^i &= \{M \in \mathcal{M}_B \mid \Phi^j(M) = \mathrm{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, \Sigma^j M) = 0 \ \forall j \neq i\}, \\ \mathcal{Y}_{\tilde{S}}^i &= \{Y \in \mathcal{M}_A \mid \Psi^j(Y) = 0 \ \forall j \neq i\}. \end{aligned}$$

The above isomorphisms of triangle equivalences imply

$$\Phi^i \cong G^{n-1-i}, \text{ and } \Psi^i \cong F^{n-1-i}.$$

Therefore we have

**Theorem 4.10.** (a)  $\mathcal{T}_{\tilde{S}}^i = \mathcal{Y}_T^{n-1-i}$  and  $\mathcal{Y}_{\tilde{S}}^i = \mathcal{T}_T^{n-1-i}$ .  
 (b) The functors  $F^i = \text{Hom}_{\mathcal{D}(\Lambda)}(T, \Sigma^i?)$  and  $\Phi^{n-1-i} = \text{Hom}_{\mathcal{D}(\Gamma)}(\tilde{S}, \Sigma^{n-1-i}?)$  restrict to inverse equivalences between  $\mathcal{T}_T^i$  and  $\mathcal{T}_{\tilde{S}}^{n-1-i}$ .

## 5. WHEN IS $S$ TILTING?

Let  $A$  be a  $k$ -algebra and  $T$  be a 2-term silting complex in  $K^b(\text{proj } A)$ . In Section 4.4, we constructed a 2-term silting complex  $S$ . Yu Zhou proposed the following question.

**Question 5.1.** *When is the 2-term silting complex  $S$  tilting?*

Because  $\Sigma A$  is a tilting complex, it follows that  $\tilde{S}$  is tilting in  $\text{per}(\Gamma)$ . If  $T$  is tilting, then  $\Gamma$  has cohomology concentrated in degree 0, so the projection  $p: \Gamma \rightarrow B$  is a quasi-isomorphism, and  $p_*: \mathcal{D}(\Gamma) \rightarrow \mathcal{D}(B)$  is a triangle equivalence. Therefore  $S$  is tilting. This recovers the second part of [13, Corollary 4.3].

**Corollary 5.2.** *If  $T$  is tilting, then  $S$  is tilting.*

But in general the answer to Question 5.1 is not known. In this section, we show that the answer is positive in certain special cases.

**Theorem 5.3.** *Keep the notation as above. Then  $S$  is tilting if one of the following conditions is satisfied:*

- (a)  $A$  is hereditary;
- (b)  $T$  is a left mutation of  $A$  or a right mutation of  $\Sigma A$ , whenever the mutation is defined;
- (c)  $k$  is a field and  $A$  is a finite-dimensional symmetric  $k$ -algebra.

To prove Theorem 5.3, we need the following lemmas. Clearly,  $S$  is tilting if and only if  $\text{Hom}_{K^b(\text{proj } B)}(S, \Sigma^{-1}S) = 0$ , because it is a 2-term silting complex. Recall that there is a triangle in  $K^b(\text{proj } A)$

$$A \longrightarrow T' \xrightarrow{f} T'' \longrightarrow \Sigma A$$

with  $T', T'' \in \text{add}_{K^b(\text{proj } A)}(T)$  and that  $S = \text{Cone}(\text{Hom}(T, f))$ . The following lemma, contained in the proof of [13, Corollary 4.3], gives a characterisation of the morphisms in  $\text{Hom}_{K^b(\text{proj } B)}(S, \Sigma^{-1}S)$ .

**Lemma 5.4.** *There is an isomorphism of  $k$ -modules*

$$\text{Hom}_{K^b(\text{proj } B)}(S, \Sigma^{-1}S) \cong \{g \in \text{Hom}_{K^b(\text{proj } A)}(T'', T') \mid gf = 0 = fg\}$$

Then we have a sufficient condition in terms of  $H^0(T')$ .

**Lemma 5.5.** *If  $\text{pd } H^0(T') \leq 1$ , then  $S$  is tilting.*

*Proof.* In view of Lemma 5.4, we only need to show that if  $g: T'' \rightarrow T'$  is a morphism such that  $fg = 0 = gf$ , then  $g = 0$ . The condition  $gf = 0$  implies that  $g$  factors through  $\Sigma A$ :

$$\begin{array}{ccccc} T' & \xrightarrow{f} & T'' & \longrightarrow & \Sigma A \\ & & \downarrow g & \nearrow f & \\ A & \longrightarrow & T' & \longrightarrow & T'' \end{array}$$

Since  $T' \in \mathbf{add}(T)$  is a 2-term complex, there is a triangle

$$\Sigma H^{-1}(T') \rightarrow T' \rightarrow H^0(T') \rightarrow \Sigma^2 H^{-1}(T').$$

It follows that  $\mathbf{pd} H^0(T') \leq 1$  if and only if  $H^{-1}(T') = 0$ . Thus by our assumption we have  $\mathbf{Hom}_{K^b(\mathbf{proj} A)}(\Sigma A, T') = H^{-1}(T') = 0$ . Therefore  $g = 0$ .  $\square$

*Proof of Theorem 5.3.* (a) If  $A$  is hereditary, then  $\mathbf{pd} H^0(T') \leq 1$ . So  $S$  is tilting by Lemma 5.5.

(b) If  $T$  is the left mutation of  $A$ , then  $T = T_e \oplus eA$ , where  $e$  is an idempotent of  $A$  such that  $\mathbf{add}(eA) \cap \mathbf{add}((1-e)A) = 0$ , and  $T_e$  is given by the following triangle

$$eA \rightarrow P \rightarrow T_e \rightarrow \Sigma(eA),$$

with the first morphism is a left  $\mathbf{add}((1-e)A)$ -approximation. Thus  $T' = P \oplus (1-e)A$ , which is a projective  $A$ -module. Then  $S$  is tilting by Lemma 5.5. The proof of the other statement is dual.

(c) If  $A$  is symmetric, then  $T$  is tilting, and hence  $S$  is tilting by Corollary 5.2.  $\square$

*Remark 5.6.* Yu Zhou pointed out that Theorem 5.3(a) can be proved using the corresponding torsion pairs. By [13, Lemma 5.5],  $T$  is splitting, *i.e.* the torsion pair  $(\mathcal{X}_T, \mathcal{Y}_T)$  splits, namely,  $(\mathcal{T}_S, \mathcal{F}_S)$  splits, *i.e.*  $S$  is separating. Then it is tilting by [13, Proposition 5.7].

In the following example none of the three conditions in Theorem 5.3 is satisfied but  $S$  is tilting.

*Example 5.7.* Let  $A$  be the algebra given by the quiver

$$1 \xleftarrow{\alpha} 2 \xleftarrow{\beta} 3$$

with relation  $\alpha\beta = 0$ . For a vertex  $i$ , let  $S_i$  and  $P_i$  denote the corresponding simple and projective module, respectively. Take the 2-term silting complex  $T = P_1 \oplus (P_2 \xrightarrow{\alpha} P_1) \oplus \Sigma P_3$  (the corresponding support  $\tau$ -tilting module is  $M = P_1 \oplus S_1$ ). Then the endomorphism algebra  $B = \mathbf{End}_{K^b(\mathbf{proj} A)}(T)$  is the path algebra of the quiver

$$a \xrightarrow{\gamma} b \quad c.$$

Then the 2-term silting complex  $S$  is  $\Sigma P_a \oplus (P_a \xrightarrow{\gamma} P_b) \oplus P_c$ . Direct computation shows that  $\mathbf{Hom}_{K^b(\mathbf{proj} B)}(S, \Sigma^{-1}S) = 0$ , thus  $S$  is tilting.
