# THE POSITIVE ENERGY CONJECTURE FOR A CLASS OF AHM METRICS ON $\mathbb{R}^{2} \times \mathbb{T}^{n-2}$

## 1. Introduction

In 4], Horowitz-Myers constructed so-called AdS solitons with toroidal topology

$$
-r^{2} d t^{2}+\frac{1}{\frac{r^{2}}{\ell^{2}}\left(1-\frac{\breve{r}_{n}^{n}}{r^{n}}\right)} d r^{2}+\frac{r^{2}}{\ell^{2}}\left(1-\frac{\breve{r}_{0}^{n}}{r^{n}}\right) d \xi^{2}+r^{2} \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}
$$

which are globally static vacuum $(n+1)$-dimensional spacetime with cosmological constant

$$
\Lambda=-\frac{n(n-1)}{2 \ell^{2}} .
$$

For convenience, we assume $\ell=1$ throughout the paper. These metrics are geodesically complete when

$$
r \in\left[\breve{r}_{0}, \infty\right), \quad \xi \in\left[0, \beta_{0}\right], \quad \phi^{i} \in\left[0, \lambda_{i}\right]
$$

for constants $\breve{r}_{0}>0, \lambda_{i}>0, i=3, \ldots, n$ and

$$
\begin{equation*}
\beta_{0}=\frac{4 \pi}{n \breve{r}_{0}} . \tag{1.1}
\end{equation*}
$$

The induced Riemannian metrics $g_{\mathrm{HM}}$ on the constant time slices

$$
\begin{equation*}
g_{\mathrm{HM}}=\frac{1}{r^{2}\left(1-\frac{\breve{r}_{0}^{n}}{r^{n}}\right)} d r^{2}+r^{2}\left(1-\frac{\breve{r}_{0}^{n}}{r^{n}}\right) d \xi^{2}+r^{2} \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2} \tag{1.2}
\end{equation*}
$$

are asymptotically locally hyperbolic (ALH) and are referred as HorowitzMyers metrics. Horowitz-Myers also verified that the Hawking-Horowitz mass of $g_{\mathrm{HM}}$ is negative and conjectured that, among all metrics which are asymptotic to $g_{\mathrm{HM}}$ with the same period $\beta_{0}$ for $\xi$ and with the scalar curvature

$$
\begin{equation*}
R \geq-n(n-1) \tag{1.3}
\end{equation*}
$$

$g_{\mathrm{HM}}$ is the unique metric with the least Hawking-Horowitz mass $[4$.

Throughout the paper, we misuse the notation and refer a function $f$ type $O\left(\frac{1}{r^{m}}\right)$ if for all $k \geq 0$, its $k$ th partial derivative with respect to $r$ satisfies

\partial_{r}^{k} f \sim \frac{1}{r^{m+k}}, \quad r \rightarrow \infty \tag{1.4}
\end{equation*}

Furthermore, a tensor is referred as type $O\left(\frac{1}{r^{m}}\right)$ if its components belong to $O\left(\frac{1}{r^{m}}\right)$ in coordinates $\left\{r, \xi, \phi^{i}\right\}$.

As both Schoen-Yau's method and Witten's method are hard to apply in this situation, there is less progress towards proof of the conjecture. In 2020, Barzegar-Chruściel-Hörzinger-Maliborski-Nguyen studied the following asymptotically Horowitz-Myers metrics on $\mathbb{R}^{2} \times \mathbb{T}^{n-2}$

g_{1}=e^{2 u(r)} d r^{2}+e^{2 v(r)} d \xi^{2}+e^{2 w(r)} \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}, \tag{1.5}
\end{equation*}
$$

where $u, v, w$ are functions of $r$ which satisfy

$$
\begin{align*}
& u(r)=-\ln r-\frac{1}{2} \ln \left(1-\frac{\breve{r}_{0}^{n}}{r^{n}}\right)+\frac{u_{n}}{r^{n}}+O\left(\frac{1}{r^{n+1}}\right), \\
& v(r)=\ln r+\frac{1}{2} \ln \left(1-\frac{\breve{r}_{0}^{n}}{r^{n}}\right)+\frac{v_{n}}{r^{n}}+O\left(\frac{1}{r^{n+1}}\right),  \tag{1.6}\\
& w(r)=\ln r+\frac{w_{n}}{r^{n}}+O\left(\frac{1}{r^{n+1}}\right),
\end{align*}
$$

for constants $u_{n}, v_{n}$ and $w_{n}$. The metric $g_{1}$ is asymptotic to $g_{\text {HM }}$ up to order $O\left(\frac{1}{r^{n}}\right)$. In [1] , they verified Horowitz-Myers conjecture for $g_{1}$ if its scalar curvature satisfies (1.3) with $\ell=1$.

Let $a$ be certain constant and $r_{+}$be the largest positive root of the equation

1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}=0
$$

where constant $r_{0}>0$. Denote

$$
\begin{equation*}
\beta=\frac{4 \pi}{r_{+}\left(n-1+\frac{r_{0}^{n}}{r_{+}^{n}}\right)} . \tag{1.7}
\end{equation*}
$$

In [5], we construct metrics of Horowitz-Myers type with the negative constant scalar curvature

$$
\begin{equation*}
\stackrel{\circ}{g}=\frac{1}{r^{2}\left(1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}\right)} d r^{2}+r^{2}\left(1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}\right) d \xi^{2}+r^{2} \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}, \tag{1.8}
\end{equation*}
$$

where

$$
r \in\left[r_{+}, \infty\right), \quad \xi \in[0, \beta], \quad \phi^{i} \in\left[0, \lambda_{i}\right] .
$$

This is a geodesically complete metric on $\mathbb{R}^{2} \times \mathbb{T}^{n-2}$ of constant scalar curvature $-n(n-1)$. And it is asymptotic to $g_{\mathrm{HM}}$ up to order $O\left(\frac{1}{r^{n-1}}\right)$ provided $\beta_{0}=\beta$. As $\stackrel{\circ}{g}$ decays weaker than $g_{1}$, we can not apply their positive energy
theorem to $\stackrel{\circ}{g}$ directly. However, we can still verify that the Horowitz-Myers conjecture holds for $\stackrel{\circ}{g}$ [5].

Now we study the following more general perturbation of Horowitz-Myers metrics on $\mathbb{R}^{2} \times \mathbb{T}^{n-2}$

g=e^{2 u(r)} d r^{2}+e^{2 v(r, \xi)} d \xi^{2}+r^{2}\left(\sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}+\hat{w}\left(r, \xi, \phi^{i}\right)\right), \tag{1.9}
\end{equation*}
$$

where

$$
\begin{align*}
u(r) & =-\ln r-\frac{1}{2} \ln \left(1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}\right)+\hat{u}(r), \\
v(r, \xi) & =\ln r+\frac{1}{2} \ln \left(1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}\right)+\hat{v}(r, \xi), \\
e^{\hat{u}(r)} & =1+\frac{u_{n-1}}{r^{n-1}}+\frac{u_{n}}{r^{n}}+O\left(\frac{1}{r^{n+1}}\right),  \tag{1.10}\\
e^{\hat{\imath}(r, \xi)} & =1+\frac{v_{n-1}(\xi)}{r^{n-1}}+\frac{v_{n}(\xi)}{r^{n}}+O\left(\frac{1}{r^{n+1}}\right), \\
\hat{w}\left(r, \xi, \phi^{i}\right) & =\frac{2 w_{n-1}\left(\xi, \phi^{i}\right)}{r^{n-1}}+\frac{2 w_{n}\left(\xi, \phi^{i}\right)}{r^{n}}+O\left(\frac{1}{r^{n+1}}\right),
\end{align*}
$$

and $u_{n-1}, u_{n}$ are real constants, $v_{n-1}(\xi), v_{n}(\xi)$ are smooth functions of $\xi$, $w_{n-1}\left(\xi, \phi^{i}\right)$ and $w_{n}\left(\xi, \phi^{i}\right)$ are 2-tensors on $\mathbb{T}^{n-2}$ which depend on $\xi, \phi^{i}$. The restriction of $g$ on $\mathbb{T}^{n-2}$ is denoted as

$$
\gamma=r^{2}\left(\sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}+\hat{w}\left(r, \xi, \phi^{i}\right)\right) .
$$

In this paper, we show that the Horowitz-Myers conjecture is true for the above AHM metrics.
Theorem 1.1. Let $n \geq 3$ and let $g$ be the smooth metric (1.9) on $\mathbb{R}^{2} \times \mathbb{T}^{n-2}$, which satisfies (1.10). Suppose the scalar curvature $R(g)$ of $g$ satisfies

\begin{equation*}
R(g)+n(n-1) \geq 0, \quad[R(g)+n(n-1)] r \in L^{1}\left(\mathbb{R}^{2} \times \mathbb{T}^{n-2}, g\right), \tag{1.11}
\end{equation*}
$$

and suppose

$$
\begin{equation*}
\beta_{0}=\beta \tag{1.12}
\end{equation*}
$$

If $n \geq 4$, we assume in addition that the scalar curvature $R(\gamma)$ of $\gamma$ satisfies

$$
\begin{equation*}
\int_{\mathbb{T}^{n-2}} R(\gamma) d \phi^{3} \cdots d \phi^{n} \leq 0 \tag{1.13}
\end{equation*}
$$

for all $r$ and $\xi$. Then the total energy

$$
E(g)-E\left(g_{H M}\right) \geq 0 .
$$

The equality holds if and only if $g$ is isometric to $g_{H M}$.
Remark 1.1. The assumption that (1.4) holds for all $k \geq 0$ is only for the sake of simplicity of notations appeared in the paper. Indeed, the proof of Theorem 1.1 needs only $k=0,1,2$.

Remark 1.2. Condition (1.13) is trivial when $n=3$, since in this case, $\gamma$ is a one dimensional metric with $R(\gamma) \equiv 0$. If $n=4$, then the Gauss-Bonnet theorem states that

\int_{\mathbb{T}^{2}} R(\gamma) d V_{\gamma}=0
$$

which can not implies (1.13).
Remark 1.3. In [1], the components of $\gamma$ are assumed to be independent of $\phi^{i}$ (e.g. (1.5)). In this case, $\gamma$ is a flat metric on $\mathbb{T}^{n-2}$ and (1.13) holds for all $n$.

The paper is organized as follows. In Section 2, we show that $g$ can be written as an asymptotically Poincaré-Einstein (APE) metric. Then the total energy can be computed in terms of the definitions of Wang [6] and Chruściel-Herzlich [2]. In Section 3, we prove the Horowitz-Myers conjecture for $g$.

## 2. APE METRICS

In this section, we show that $g$ is actually an APE metric. The boundary-at-infinity $\partial_{\infty} M$ of $\mathbb{R}^{2} \times \mathbb{T}^{n-2}$ is $\mathbb{T}^{n-1}$. Let $x$ be a special defining function for $\partial_{\infty} M$. That is, on a collar neighborhood of $\partial_{\infty} M$,
(1) $x \geq 0$ with $\{x=0\}=\partial_{\infty} M$,
(2) $|d x|_{x^{2} g} \equiv 1$.

On this collar neighborhood, the metric $g$ can be written in the form

$$
g=\frac{1}{x^{2}}\left(d x^{2} \oplus h_{x}\right), \quad \lim _{r \rightarrow \infty} x r=1
$$

where $h_{x}$ are the induced metrics of $x^{2} g$ on the constant $x$ slices,

$$
\frac{1}{x} d x=-\frac{e^{\hat{u}(r)}}{r \sqrt{1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}}} d r
$$

It follows that

$$
\begin{aligned}
\ln x= & -\int_{r_{+}}^{r} \frac{e^{\hat{u}(s)}}{s \sqrt{1+\frac{a}{s^{n-1}-\frac{r_{0}^{n}}{s^{n}}}} d s+C} \\
= & -\ln r-\int_{r_{+}}^{r}\left(\frac{u_{n-1}-\frac{1}{2} a}{s^{n}}+\frac{u_{n}+\frac{1}{2} r_{0}^{n}}{s^{n+1}}+O\left(s^{-n-2}\right)\right) d s \\
& +\ln r_{+}+C
\end{aligned}
$$

where

$$
C=-\ln r_{+}+\int_{r_{+}}^{\infty} \frac{1}{s}\left(\frac{e^{\hat{u}(s)}}{\sqrt{1+\frac{a}{s^{n-1}}-\frac{r_{0}^{n}}{s^{n}}}}-1\right) d s
$$

Therefore, we obtain

$$
r=x^{-1}+\frac{u_{n-1}-\frac{1}{2} a}{n-1} x^{n-2}+\frac{u_{n}+\frac{1}{2} r_{0}^{n}}{n} x^{n-1}+O\left(x^{n}\right)
$$

Putting this into (1.9) and applying the asymptotic conditions (1.10), we obtain

g= & \frac{1}{x^{2}}\left\{d x^{2}+d \xi^{2}+\sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}\right. \\
& +\frac{x^{n-1}}{n-1}\left[\left((n-2) a+2 u_{n-1}+2(n-1) v_{n-1}\right) d \xi^{2}\right. \\
& \left.+\left(2 u_{n-1}-a\right) \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}+2(n-1) w_{n-1}\right]  \tag{2.1}\\
& +\frac{x^{n}}{n}\left[\left(-(n-1) r_{0}^{n}+2 u_{n}+2 n v_{n}\right) d \xi^{2}\right. \\
& \left.\left.+\left(r_{0}^{n}+2 u_{n}\right) \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}+2 n w_{n}\right]+O\left(x^{n+1}\right)\right\}
\end{align*}
$$

Denote

$$
\begin{aligned}
h_{0}= & d \xi^{2}+\sum_{i=3}^{n}\left(d \phi^{i}\right)^{2} \\
\theta= & \left((n-2) a+2 u_{n-1}+2(n-1) v_{n-1}\right) d \xi^{2} \\
& +\left(2 u_{n-1}-a\right) \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}+2(n-1) w_{n-1} \\
\kappa= & \left(-(n-1) r_{0}^{n}+2 u_{n}+2 n v_{n}\right) d \xi^{2} \\
& +\left(r_{0}^{n}+2 u_{n}\right) \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}+2 n w_{n}
\end{aligned}
$$

The conformal infinity of $g$ is defined as the conformal class $\left[h_{0}\right.$ ] on $\partial_{\infty} M$ (cf. [3]). The mass aspect function, the total energy are defined as

\begin{align*}
\operatorname{tr}_{h_{0}} \kappa & =-r_{0}^{n}+2(n-1) u_{n}+2 n v_{n}+2 n \operatorname{tr}_{h_{0}} w_{n}  \tag{2.2}\\
E(g) & =\int_{\partial_{\infty} M} \operatorname{tr}_{h_{0}} \kappa d V_{h_{0}} \tag{2.3}
\end{align*}
$$

respectively [6, 2]. When $u_{n}=v_{n}=w_{n}=0$, we obtain

$$
E\left(g_{\mathrm{HM}}\right)=-\breve{r}_{0}^{n} \operatorname{Vol}\left(\partial_{\infty} M, h_{0}\right) .
$$

Therefore

$$
\begin{equation*}
E(g)-E\left(g_{\mathrm{HM}}\right)=\int_{\partial_{\infty} M}\left[\breve{r}_{0}^{n}-r_{0}^{n}+2(n-1) u_{n}+2 n v_{n}+2 n \operatorname{tr}_{h_{0}} w_{n}\right] d V_{h_{0}} . \tag{2.4}
\end{equation*}
$$

Now we express the scalar curvature $R(g)$ in some appropriate form. Denote

$$
W^{r}=\frac{1}{2} \operatorname{tr}_{\gamma}\left(\partial_{r} \gamma\right)=\frac{1}{2}\left(\partial_{r} \gamma_{i j}\right) \gamma^{i j}
$$

and let $\dot{W}^{r}$ be the trace-less part of $\partial_{r} \gamma$. It is straightforward that

$$
\begin{equation*}
\partial_{r} \gamma=\frac{2 W^{r}}{n-2} \gamma+\stackrel{\circ}{W}^{r} . \tag{2.5}
\end{equation*}
$$

By the asymptotic condition of $\gamma$, we obtain

W^{r}=\frac{n-2}{r}-\frac{(n-1) \operatorname{tr}_{h_{0}} w_{n-1}}{r^{n}}-\frac{n \operatorname{tr}_{h_{0}} w_{n}}{r^{n+1}}+O\left(r^{-n-2}\right) \tag{2.6}
\end{equation*}
$$

Similarly, denote

$$
W^{\xi}=\frac{1}{2} \operatorname{tr}_{\gamma}\left(\partial_{\xi} \gamma\right)=\frac{1}{2}\left(\partial_{\xi} \gamma_{i j}\right) \gamma^{i j}
$$

and let $\mathscr{W}^{\xi}$ be the trace-less part of $\partial_{\xi} \gamma$. We can also get

\partial_{\xi} \gamma=\frac{2 W^{\xi}}{n-2} \gamma+\dot{W}^{\xi} \tag{2.7}
\end{equation*}
$$

Set

\hat{W}^{r}=W^{r}-\frac{n-2}{r} \tag{2.8}
\end{equation*}
$$

Lemma 2.1. With the above notations, the scalar curvature $R(g)$ of $g$ is

$$
\begin{align*}
R(g)= & -2 e^{-u-v} \partial_{r}\left[e^{v-u}\left(\partial_{r} v+W^{r}\right)\right]-2 e^{-v} \partial_{\xi}\left(e^{-v} W^{\xi}\right) \\
& +R(\gamma)-2 e^{-2 u}\left[\frac{n-1}{2(n-2)}\left(W^{r}\right)^{2}+\frac{1}{8}\left|W^{r}\right|_{\gamma}^{2}\right]  \tag{2.9}\\
& -2 e^{-2 v}\left[\frac{n-1}{2(n-2)}\left(W^{\xi}\right)^{2}+\frac{1}{8}\left|W^{\xi}\right|_{\gamma}^{2}\right] .
\end{align*}
$$

Proof. For the following metrics

$$
N(s)^{2} d s^{2}+\eta, \quad \eta=\eta_{a b}\left(s, y^{1}, \cdots, y^{m}\right) d y^{a} d y^{b}
$$

it is well-known that their scalar curvature is

\begin{equation*}
R(\eta)-N^{-1}\left(N^{-1} \operatorname{tr}_{\eta} \eta^{\prime}\right)^{\prime}-\frac{1}{4 N^{2}}\left|\eta^{\prime}\right|_{\eta}^{2}-\frac{1}{4 N^{2}}\left(\operatorname{tr}_{\eta} \eta^{\prime}\right)^{2} \tag{2.10}
\end{equation*}
$$

where $R(\eta)$ is the scalar curvature of $\eta,{ }^{\prime}$ is the partial derivative with respect to $s$,

$$
\eta^{\prime}=\eta_{a b}^{\prime} d y^{a} d y^{b} .
$$

Now we apply formula (2.10) to the following part of $g$

\rho=e^{2 v} d \xi^{2}+\gamma,
$$

and obtain

R(\rho) & =R(\gamma)-e^{-v} \partial_{\xi}\left(e^{-v} \operatorname{tr}_{\gamma} \partial_{\xi} \gamma\right)-\frac{1}{4} e^{-2 v}\left|\partial_{\xi} \gamma\right|_{\gamma}^{2}-\frac{1}{4} e^{-2 v}\left(\operatorname{tr}_{\gamma} \partial_{\xi} \gamma\right)^{2} \\
& =R(\gamma)-2 e^{-v} \partial_{\xi}\left(e^{-v} W^{\xi}\right)-2 e^{-2 v}\left[\frac{n-1}{2(n-2)}\left(W^{\xi}\right)^{2}+\frac{1}{8}\left|W^{\circ}\right|_{\gamma}^{2}\right] .
\end{aligned}
$$

Next we apply (2.10) to the metric

$$
g=e^{2 u} d r^{2}+\rho
$$

and obtain

$$
R(g)=R(\rho)-e^{-u} \partial_{r}\left(e^{-u} \operatorname{tr}_{\rho} \partial_{r} \rho\right)-\frac{1}{4} e^{-2 u}\left|\partial_{r} \rho\right|_{\rho}^{2}-\frac{1}{4} e^{-2 u}\left(\operatorname{tr}_{\rho} \partial_{r} \rho\right)^{2} .
$$

Since

$$
\begin{aligned}
\partial_{r} \rho & =2\left(\partial_{r} v\right) e^{2 v} d \xi^{2}+\partial_{r} \gamma \\
\operatorname{tr}_{\rho} \partial_{r} \rho & =2\left(\partial_{r} v\right)+\operatorname{tr}_{\gamma} \partial_{r} \gamma=2\left(\partial_{r} v\right)+2 W^{r} \\
\left|\partial_{r} \rho\right|_{\rho}^{2} & =4\left(\partial_{r} v\right)^{2}+\left|\partial_{r} \gamma\right|_{\gamma}^{2}=4\left(\partial_{r} v\right)^{2}+\frac{4}{n-2}\left(W^{r}\right)^{2}+\left|\dot{W}^{r}\right|_{\gamma}^{2} .
\end{aligned}
$$

we obtain

$$
\begin{aligned}
R(g)= & R(\rho)-2 e^{-u} \partial_{r}\left[e^{-u}\left(\partial_{r} v+W^{r}\right)\right] \\
& -e^{-2 u}\left[2\left(\partial_{r} v\right)^{2}+\frac{n-1}{n-2}\left(W^{r}\right)^{2}+2 \partial_{r} v W^{r}+\frac{1}{4}\left|\dot{W}^{r}\right|_{\gamma}^{2}\right] \\
= & R(\rho)-2 e^{-u-v} \partial_{r}\left[e^{v-u}\left(\partial_{r} v+W^{r}\right)\right] \\
& -2 e^{-2 u}\left[\frac{n-1}{2(n-2)}\left(W^{r}\right)^{2}+\frac{1}{8}\left|W^{r}\right|_{\gamma}^{2}\right] .
\end{aligned}
$$

Therefore the lemma follows.
Q.E.D.

Proposition 2.1. For the metric (1.9), the condition

[R(g)+n(n-1)] r \in L^{1}\left(\mathbb{R}^{2} \times \mathbb{T}^{n-2}, g\right)
$$

holds if and only if

$$
\begin{equation*}
t r_{h_{0}} \theta=0 \Longleftrightarrow u_{n-1}+v_{n-1}+t r_{h_{0}} w_{n-1}=0 \tag{2.11}
\end{equation*}
$$

In this case,

R+n(n-1)=O\left(\frac{1}{r^{n+1}}\right) \tag{2.12}
\end{equation*}
$$

Proof. Note if all $\hat{u}, \hat{v}, \hat{W}^{r}, W^{\xi}, \stackrel{\circ}{W}^{r}$ and $\stackrel{\circ}{W}^{\xi}$ vanish, then $g$ reduces to

e^{-2 f} d r^{2}+e^{2 f} d \xi^{2}+r^{2} \sum_{i, j=3}^{n} \gamma_{i j}\left(\phi^{3}, \cdots, \phi^{n}\right) d \phi^{i} d \phi^{j}
$$

where

f=\ln r+\frac{1}{2} \ln \left(1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}\right)
$$

By (2.9), the scalar curvature of this metric is

Putting (1.10) and (2.8) into (2.9), we obtain

R(g)= & -n(n-1) e^{-2 \hat{u}}+2 e^{2 f-2 \hat{u}}\left[-\partial_{r}\left(\partial_{r} \hat{v}+\hat{W}^{r}\right)\right. \\
& -\partial_{r}(\hat{v}-\hat{u}+2 f+(n-1) \ln r) \cdot\left(\partial_{r} \hat{v}+\hat{W}^{r}\right) \\
& +\left(\frac{1}{r}-\partial_{r} f\right) \partial_{r} \hat{v}+\left(\partial_{r} f+\frac{n-2}{r}\right) \partial_{r} \hat{u} \\
& \left.-\frac{(n-1)}{2(n-2)}\left(\hat{W}^{r}\right)^{2}-\frac{1}{8}\left|\dot{W}^{r}\right|_{\gamma}^{2}\right] \\
& -2 e^{-v} \partial_{\xi}\left(e^{-v} W^{\xi}\right)+R(\gamma) \\
& -2 e^{-2 v}\left[\frac{n-1}{2(n-2)}\left(W^{\xi}\right)^{2}+\frac{1}{8}\left|\mathscr{W}^{\xi}\right|_{\gamma}^{2}\right] \\
= & -n(n-1)+\left(\operatorname{tr}_{h_{0}} \theta\right) r^{1-n}+O\left(r^{-n-1}\right)
\end{aligned}
$$

Here we use that

$$
R(\gamma)=O\left(r^{-n-1}\right)
$$

which could be confirmed by direct computation. Since

$$
\sqrt{\operatorname{det} g}=O\left(r^{n-2}\right)
$$

and

$$
\operatorname{tr}_{h_{0}} \theta=2(n-1)\left(v_{n-1}+u_{n-1}+\operatorname{tr}_{h_{0}} w_{n-1}\right)
$$

so the lemma follows.
Q.E.D.

By (2.1), we have

g=x^{-2} \bar{g}, \quad \bar{g}=d x^{2}+d \xi^{2}+\sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}+\frac{x^{n-1}}{n-1} \theta+O\left(x^{n}\right)
$$

We denote $\phi^{0}=x$ and $\phi^{1}=\xi$. Let $a, b$ and $c$ be indices ranging from 1 to $n$. Under the coordinates $\left\{\phi^{0}, \phi^{1}, \cdots, \phi^{n}\right\}$, it holds

\bar{g}_{00}=1, \quad \bar{g}_{0 a}=0, \quad \bar{g}_{a b}=\delta_{a b}+\frac{x^{n-1}}{n-1} \theta_{a b}+O\left(x^{n}\right)
$$

It is direct to show that the Christoffel symbols of $\bar{g}$ satisfy

\begin{aligned}
& \Gamma_{a b}^{c}=O\left(x^{n-1}\right) \\
& \Gamma_{a b}^{0}=-\frac{1}{2} x^{n-2} \theta_{a b}+O\left(x^{n-1}\right) \\
& \Gamma_{a 0}^{b}=\Gamma_{0 a}^{b}=\frac{1}{2} x^{n-2} \theta_{a b}+O\left(x^{2 n-3}\right)
\end{aligned}
$$

and the others vanish. So the Ricci curvature of $\bar{g}$ satisfies

$$
\begin{aligned}
& \bar{R}_{00}=-\frac{1}{2}(n-2) x^{n-3} \operatorname{tr}_{h_{0}} \theta+O\left(x^{2 n-4}\right), \\
& \bar{R}_{0 a}=O\left(x^{n-2}\right) \\
& \bar{R}_{a b}=O\left(x^{n-2}\right)
\end{aligned}
$$

Denote by Ric the Ricci curvature of $g$. Let

\Omega=\operatorname{Ric}+(n-1) g .
$$

By the formulas of conformal transformation of the Ricci and scalar curvatures, we finally obtain

\begin{aligned}
& \Omega\left(\partial_{x}, \partial_{x}\right)=-\frac{1}{2}(n-3) x^{n-3} \operatorname{tr}_{h_{0}} \theta+O\left(x^{n-2}\right) \\
& \Omega\left(\partial_{a}, \partial_{b}\right)=\frac{1}{2} x^{n-3}\left(\operatorname{tr}_{h_{0}} \theta\right) \delta_{a b}+O\left(x^{n-2}\right) \\
& \Omega\left(\partial_{x}, \partial_{a}\right)=O\left(x^{n-2}\right)
\end{aligned}
$$

Recall Definition 2.1 in [7] that the metric $g$ is asymptotically PoincaréEinstein (APE) if

$$
\lim _{x \rightarrow 0}|\Omega|_{g}=O\left(x^{n}\right)
$$

By Lemma 2.2 [7], $g$ is APE if and only if $\operatorname{tr}_{k_{0}} \theta=0$. (This can also be seen from the above computation.) Therefore we have
Proposition 2.2. For the metric (1.9), the condition

[R(g)+n(n-1)] r \in L^{1}\left(\mathbb{R}^{2} \times \mathbb{T}^{n-2}, g\right)
$$

holds if and only if $g$ is APE.
Finally, we study the consequence of smoothness of $g$ at $r=r_{+}$.
Proposition 2.3. If the metric $g$ is smooth at $r=r_{+}$, then

\hat{v}\left(r_{+}, \xi\right)=\hat{u}\left(r_{+}\right) \quad \text { for all } \xi . \tag{2.13}
\end{equation*}
$$

Proof. We follow the proof of Theorem II. 1 in 5 to construct a regular coordinate system around $r=r_{+}$. Set

A(r)=r^{2}\left(1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}\right)
$$

for $r>0$. Differentiating $A$ at $r=r_{+}$and using (1.7), we find

A^{\prime}\left(r_{+}\right)=\frac{4 \pi}{\beta}>0
$$

This implies that $A$ has a smooth inverse, which we denote by $B$, round $r_{+}$. Clearly $B(0)=r_{+}$. Now we can introduce new coordinates ( $\rho, \Xi$ ) given by

\rho=A^{\frac{1}{2}}(r), \quad \Xi=\frac{2 \pi \xi}{\beta}
$$

for $r_{+}<r<r_{+}+\varepsilon, 0 \leq \Xi<2 \pi$, with some $\varepsilon>0$. So $(\rho, \Xi)$ can be viewed as the standard polar coordinates around the origin in $\mathbb{R}^{2}$. Set

z^{1}=\rho \cos \Xi, \quad z^{2}=\rho \sin \Xi
$$

Obviously, $\left\{r=r_{+}\right\}=\left\{z^{1}=z^{2}=0\right\}$. It is shown in [5] that $\left(z^{1}, z^{2}, \phi^{3}, \cdots, \phi^{n}\right)$ is a regular coordinate system around $r=r_{+}$for $\stackrel{\circ}{g}$. Since $g$ is smooth, the components in this coordinate system are smooth around $\left(z^{1}, z^{2}\right)=(0,0)$. For our purpose, we only rewrite the following part

$$
g_{(0)}:=e^{2 \hat{u}(r)} A^{-1}(r) d r^{2}+e^{2 \hat{v}(r, \xi)} A(r) d \xi^{2}
$$

of $g$ in the new coordinate system. Since

A^{-1}(r) d r^{2}=\frac{4}{A^{\prime}(r)^{2}} d \rho^{2}, \quad A(r) d \xi^{2}=\frac{4 \rho^{2}}{A^{\prime}\left(r_{+}\right)^{2}} d \Xi^{2}
$$

we have

g_{(0)}=\frac{4 e^{2 \hat{u}(r)}}{A^{\prime}(r)^{2}} d \rho^{2}+\frac{4 e^{2 \hat{v}(r, \xi)}}{A^{\prime}\left(r_{+}\right)^{2}} \rho^{2} d \Xi^{2}=g_{(\rho)}+g_{(\Xi)}+g_{\mathbb{R}^{2}}
$$

where

$$
\begin{aligned}
g_{(\rho)} & =\left[\frac{4 e^{2 \hat{u}(r)}}{A^{\prime}(r)^{2}}-\frac{4 e^{2 \hat{u}\left(r_{+}\right)}}{A^{\prime}\left(r_{+}\right)^{2}}\right] d \rho^{2} \\
g_{(\Xi)} & =\frac{4 e^{2 \hat{u}\left(r_{+}\right)}}{A^{\prime}\left(r_{+}\right)^{2}}\left[e^{2\left(\hat{v}(r, \xi)-\hat{u}\left(r_{+}\right)\right)}-1\right] \rho^{2} d \Xi^{2} \\
g_{\mathbb{R}^{2}} & =\frac{4 e^{2 \hat{u}\left(r_{+}\right)}}{A^{\prime}\left(r_{+}\right)^{2}}\left(d \rho^{2}+\rho^{2} d \Xi^{2}\right)
\end{aligned}
$$

Since $\frac{4 e^{2 \hat{u}(r)}}{A^{\prime}(r)^{2}}$ is smooth near $r=r_{+}$, there exists a smooth function $\varphi(r)$ so that

$$
\frac{4 e^{2 \hat{u}(r)}}{A^{\prime}(r)^{2}}-\frac{4 e^{2 \hat{u}\left(r_{+}\right)}}{A^{\prime}\left(r_{+}\right)^{2}}=\left(r-r_{+}\right) \varphi(r)
$$

for $r$ near $r_{+}$. Note that

\left(r-r_{+}\right) \varphi(r)=\left[B\left(\rho^{2}\right)-B(0)\right](\varphi \circ B)\left(\rho^{2}\right)
$$

Since $B$ is smooth near 0 , there also exists a smooth function $\psi(\rho)$ such that

B\left(\rho^{2}\right)-B(0)=\rho^{2} \psi\left(\rho^{2}\right)
$$

So

$$
\begin{aligned}
g_{(\rho)} & =(\varphi \circ B)\left(\rho^{2}\right) \psi\left(\rho^{2}\right) \rho^{2} d \rho^{2} \\
& =((\varphi \circ B) \cdot \psi)\left(\left(z^{1}\right)^{2}+\left(z^{2}\right)^{2}\right)\left(z^{1} d z^{1}+z^{2} d z^{2}\right)^{2}
\end{aligned}
$$

This implies that $g_{(\rho)}$ is smooth around $\left(z^{1}, z^{2}\right)=(0,0)$. As a result, $g_{(\Xi)}$ is also smooth around $\left(z^{1}, z^{2}\right)=(0,0)$. However,

$$
\begin{aligned}
\rho^{2} d \Xi^{2} & =\left(d z^{1}\right)^{2}+\left(d z^{2}\right)^{2}-d \rho^{2} \\
& =\left(d z^{1}\right)^{2}+\left(d z^{2}\right)^{2}-\frac{1}{\rho^{2}}\left(z^{1} d z^{1}+z^{2} d z^{2}\right)^{2}
\end{aligned}
$$

is singular at $\left(z^{1}, z^{2}\right)=(0,0)$. So it must hold that

$$
\lim _{r \rightarrow r_{+}} \hat{v}(r, \xi)=\hat{u}\left(r_{+}\right)
$$

for all $\xi$. This proves (2.13).
Q.E.D.

## 3. Proof of the theorem

In this section, we adopt the idea in [1] to prove Theorem [1.1. We will replace $r$ by a new coordinate function $\tilde{r}$ to change $e^{2 u(r)} d r^{2}$ in (1.9) to $\tilde{r}^{-2}\left(1-\frac{\tilde{r}_{0}^{n}}{\tilde{r}^{n}}\right)^{-1} d \tilde{r}^{2}$.
Lemma 3.1. There exist a positive number $\tilde{r}_{0}$ and a smooth increasing function $r \mapsto \tilde{r}(r)$ from $\left[r_{+}, \infty\right)$ to $\left[\tilde{r}_{0}, \infty\right)$, with $\tilde{r}\left(r_{+}\right)=\tilde{r}_{0}$, such that

$$
\begin{equation*}
\frac{1}{\tilde{r} \sqrt{1-\frac{\tilde{r}_{0}^{n}}{\tilde{r}^{n}}}} d \tilde{r}=\frac{1}{r \sqrt{1+\frac{a}{r^{n-1}-\frac{r_{0}^{n}}{r^{n}}}}} e^{\hat{u}(r)} d r, \tag{3.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\tilde{r}(r)=r+\frac{a-2 u_{n-1}}{2(n-1)} r^{2-n}+\frac{\tilde{r}_{0}^{n}-r_{0}^{n}-2 u_{n}}{2 n} r^{1-n}+O\left(r^{-n}\right) . \tag{3.2}
\end{equation*}
$$

Proof. Define

$$
F(r)=\int_{1}^{r} \frac{1}{s \sqrt{1-\frac{1}{s^{n}}}} d s, \quad r \geq 1 .
$$

For large $r$, we have

F(r)=F_{0}+\ln r-\frac{1}{2 n} r^{-n}+O\left(r^{-n-1}\right), \tag{3.3}
\end{equation*}
$$

where

F_{0}=\int_{1}^{\infty} \frac{1}{s}\left(\frac{1}{\sqrt{1-\frac{1}{s^{n}}}}-1\right) d s
$$

Clearly, $F$ is a smooth increasing function. Define $\tilde{r}(r)$ on $\left[r_{+}, \infty\right)$ by

$$

F\left(\frac{\tilde{r}(r)}{\tilde{r}_{0}}\right)=\int_{r_{+}}^{r} \frac{e^{\hat{u}(s)}}{s \sqrt{1+\frac{a}{s^{n-1}-\frac{r_{0}^{n}}{s^{n}}}} d s . . . . . . . .} \tag{3.4}
\end{equation*}
$$

Here $\tilde{r}_{0}$ is a positive number to be specified later. The integral on the right hand side has the following asymptotic expansion as $r \rightarrow \infty$ :

C+\ln r+\frac{a-2 u_{n-1}}{2(n-1)} r^{1-n}-\frac{2 u_{n}+r_{0}^{n}}{2 n} r^{-n}+O\left(r^{-n-1}\right), \tag{3.5}
\end{equation*}

where

\begin{aligned}
C & =\lim _{r \rightarrow \infty}\left(\int_{r_{+}}^{r} \frac{1}{\left.s \sqrt{1+\frac{a}{s^{n-1}-\frac{r_{0}^{n}}{s^{n}}}} d s-\ln r\right)}\right. \\
& =-\ln r_{+}+\int_{r_{+}}^{\infty} \frac{1}{s}\left(\frac{1}{\sqrt{1+\frac{a}{s^{n-1}-\frac{r_{0}^{n}}{s^{n}}}}}-1\right) d s .
\end{aligned}
$$

Putting (3.3) and (3.5) into (3.4), we obtain

$$
\begin{aligned}
& F_{0}-\ln \tilde{r}_{0}+\ln \tilde{r}-\frac{\tilde{r}_{0}^{n}}{2 n} \tilde{r}^{-n}+O\left(\tilde{r}^{-n-1}\right) \\
& \quad=C+\ln r+\frac{a-2 u_{n-1}}{2(n-1)} r^{1-n}-\frac{2 u_{n}+r_{0}^{n}}{2 n} r^{-n}+O\left(r^{-n-1}\right) .
\end{aligned}
$$

Now we set

$$
\tilde{r}_{0}=e^{F_{0}-C} .
$$

The above equation implies the asymptotic expansion (3.2). The equation (3.1) follows directly by the definition of $\tilde{r}$.
Q.E.D.

With the function $\tilde{r}$, we rewrite the metric

g=e^{2 \tilde{u}(\tilde{r})} d \tilde{r}^{2}+e^{2 \tilde{v}(\tilde{r}, \xi)} d \xi^{2}+\tilde{r}^{2}\left(\sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}+\hat{\tilde{w}}\left(\tilde{r}, \xi, \phi^{i}\right)\right), \tag{3.6}
\end{equation*}
$$

where

$$
\begin{align*}
\tilde{u}(\tilde{r}) & =-\ln \tilde{r}-\frac{1}{2} \ln \left(1-\frac{\tilde{r}_{0}^{n}}{\tilde{r}^{n}}\right), \\
\tilde{v}(\tilde{r}, \xi) & =-\tilde{u}(\tilde{r})+\hat{\tilde{v}}(\tilde{r}, \xi), \\
e^{\hat{\tilde{v}}(\tilde{r}, \xi)} & =1+\frac{\tilde{v}_{n-1}(\xi)}{\tilde{r}^{n-1}}+\frac{\tilde{v}_{n}(\xi)}{\tilde{r}^{n}}+O\left(\frac{1}{\tilde{r}^{n+1}}\right),  \tag{3.7}\\
\hat{\tilde{w}}\left(\tilde{r}, \xi, \phi^{i}\right) & =\frac{2 \tilde{w}_{n-1}}{\tilde{r}^{n-1}}+\frac{2 \tilde{w}_{n}}{\tilde{r}^{n}}+O\left(\frac{1}{\tilde{r}^{n+1}}\right) .
\end{align*}
$$

By comparing (1.9) and (3.6), we have

$$
\begin{equation*}
\hat{\tilde{v}}=\hat{v}+\hat{u}-\ln \frac{d \tilde{r}}{d r} \tag{3.8}
\end{equation*}
$$

and

$$
\begin{equation*}
\hat{\tilde{w}}=\frac{r^{2}}{\tilde{r}^{2}} \hat{w}+\left(\frac{r^{2}}{\tilde{r}^{2}}-1\right) \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2} . \tag{3.9}
\end{equation*}
$$

In particular, we obtain

$$
\begin{align*}
\tilde{v}_{n-1} & =v_{n-1}+\frac{(n-2) a+2 u_{n-1}}{2(n-1)} \\
\tilde{v}_{n} & =v_{n}+\frac{(n-1)\left(\tilde{r}_{0}^{n}-r_{0}^{n}\right)+2 u_{n}}{2 n}, \\
\tilde{w}_{n-1} & =w_{n-1}+\frac{2 u_{n-1}-a}{2(n-1)} \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2}  \tag{3.10}\\
\tilde{w}_{n} & =w_{n}+\frac{-\left(\tilde{r}_{0}^{n}-r_{0}^{n}\right)+2 u_{n}}{2 n} \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2} .
\end{align*}
$$

As a result, (2.11) becomes

\end{equation*}

and (2.4) becomes

\end{equation*}
$$

Lemma 3.2. Under the above condition, it holds that

e^{\hat{\hat{v}}\left(\tilde{r}_{0}, \xi\right)}=\frac{\breve{r}_{0}}{\tilde{r}_{0}} \tag{3.13}
\end{equation*}
$$

for all $\xi$.
Proof. By (3.8) and (2.13), we have

\left(\frac{d \tilde{r}}{d r}\right)^{2}=\frac{\tilde{r}^{2}\left(1-\frac{\tilde{r}_{0}^{n}}{\tilde{r}^{n}}\right)}{r^{2}\left(1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}\right)} e^{2 \hat{u}(r)}
$$

it follows

$$
\left(\frac{d \tilde{r}}{d r}\right)^{2}\left(r_{+}\right)=\frac{\tilde{r}_{0}^{2}}{r_{+}^{2}} e^{2 \hat{u}\left(r_{+}\right)} \lim _{r \rightarrow r_{+}} \frac{1-\frac{\tilde{r}_{n}^{n}}{r^{n}}}{1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}}=\frac{n \tilde{r}_{0} e^{2 \hat{u}\left(r_{+}\right) \frac{d \tilde{r}}{d r}\left(r_{+}\right)}}{-\frac{(n-1) a}{r_{+}^{n-2}}+\frac{r_{n}^{n}}{r_{+}^{n-1}}} .
$$

Recalling that $r_{+}$is a root of $1+\frac{a}{r^{n-1}}-\frac{r_{0}^{n}}{r^{n}}=0$, this implies

\frac{d \tilde{r}}{d r}\left(r_{+}\right)=e^{2 \hat{u}\left(r_{+}\right)} \frac{n \tilde{r}_{0}}{r_{+}\left(n-1+\frac{1}{r_{+}^{n}}\right)} .
$$

By (1.12), we obtain

\frac{d \tilde{r}}{d r}\left(r_{+}\right)=e^{2 \hat{u}\left(r_{+}\right)} \frac{\tilde{r}_{0}}{\breve{r}_{0}}
$$

So the lemma follows.
Q.E.D.

## Now we are ready to prove Theorem 1.1.

Proof of Theorem 1.1. Denote $\tilde{W}^{r}$, $\hat{\tilde{W}}^{r}, \tilde{\tilde{W}}^{r}$ for (3.6) the analogous quantities $W^{r}, \hat{W}^{r}, W^{r}$ for (1.9). In the new coordinate function $\tilde{r}$, we have

& -2 e^{-\hat{\tilde{v}}-(n-1) \ln \tilde{r}} \partial_{\tilde{r}}\left[e^{-2 \tilde{u}+\hat{\tilde{v}}^{n}} \tilde{r}^{n-1}\left(\partial_{\tilde{r}} \hat{\tilde{v}}+\hat{\tilde{W}}^{r}\right)\right] \\
& -\frac{n \tilde{r}_{0}^{n}}{\tilde{r}^{n-1}} \partial_{\tilde{r}} \hat{\tilde{v}}-2 e^{2 \tilde{u}-\hat{v}} \partial_{\xi}\left(e^{-\hat{\tilde{v}}} \tilde{W}^{\xi}\right) \\
& -2 e^{-2 \tilde{u}}\left[\frac{n-1}{2(n-2)}\left(\hat{\tilde{W}}^{r}\right)^{2}+\frac{1}{8}\left|\tilde{W}^{r}\right|_{\gamma}^{2}\right] \\
& -2 e^{-2 \tilde{v}}\left[\frac{n-1}{2(n-2)}\left(\tilde{W}^{\xi}\right)^{2}+\frac{1}{8}\left|\tilde{\tilde{W}}^{\xi}\right|_{\gamma}^{2}\right] .
\end{aligned}
$$

This equality can be rewritten as

-2 \partial_{\tilde{r}}\left[e^{-2 \tilde{u}+\hat{\hat{v}}} \tilde{r}^{n-1}\left(\partial_{\tilde{r}} \hat{\tilde{v}}+\hat{\tilde{W}}^{r}\right)\right]= & n \tilde{r}_{0}^{n} \partial_{\tilde{r}}\left(e^{\hat{\hat{v}}}\right)+2 e^{2 \tilde{u}} \tilde{r}^{n-1} \partial_{\xi}\left(e^{-\hat{\hat{v}}} \tilde{W}^{\xi}\right)  \tag{3.14}\\
& -e^{\hat{\hat{v}}} \tilde{r}^{n-1} R(\gamma)+A
\end{align*}
$$

where

$$
\begin{aligned}
A= & e^{\hat{\hat{v}}} \tilde{r}^{n-1}[R(g)+n(n-1)] \\
& +2 e^{-2 \tilde{u}+\tilde{v}} \tilde{r}^{n-1}\left[\frac{n-1}{2(n-2)}\left(\hat{\tilde{W}}^{r}\right)^{2}+\frac{1}{8}\left|\tilde{W}^{r}\right|_{\gamma}^{2}\right] \\
& +2 e^{2 \tilde{u}-\hat{v}} \tilde{r}^{n-1}\left[\frac{n-1}{2(n-2)}\left(\tilde{W}^{\xi}\right)^{2}+\frac{1}{8}\left|\tilde{W}^{\xi}\right|_{\gamma}^{2}\right] \geq 0 .
\end{aligned}
$$

Integrating (3.14) on $\left[\tilde{r}_{0}, \infty\right)$, noting that $e^{-2 \tilde{u}}$ vanishes at $\tilde{r}=\tilde{r}_{0}$, and using (3.13), we obtain

$$
\begin{align*}
& \lim _{\tilde{r} \rightarrow \infty}-2 e^{-2 \tilde{u}+\hat{\tilde{v}}^{n-1}}\left(\partial_{\tilde{r}} \hat{\tilde{v}}+\hat{\tilde{W}}^{r}\right)=n \tilde{r}_{0}^{n}\left(1-\frac{\breve{r}_{0}}{\tilde{r}_{0}}\right) \\
& +\int_{\tilde{r}_{0}}^{\infty}\left[2 e^{2 \tilde{u}} \tilde{r}^{n-1} \partial_{\xi}\left(e^{-\hat{\tilde{v}}} \tilde{W}^{\xi}\right)-e^{\hat{\tilde{v}}} \tilde{r}^{n-1} R(\gamma)+A\right] d \tilde{r} . \tag{3.15}
\end{align*}
$$

Since

$$
\begin{aligned}
\hat{\tilde{W}}^{r} & =\frac{1}{2} \operatorname{tr}_{\gamma}\left(\partial_{\tilde{r}} \gamma\right)-\frac{n-2}{\tilde{r}} \\
& =-\frac{n-1}{\tilde{r}^{n}} \operatorname{tr}_{h_{0}} \tilde{w}_{n-1}-\frac{n}{\tilde{r}^{n+1}} \operatorname{tr}_{h_{0}} \tilde{w}_{n}+O\left(\tilde{r}^{-2-n}\right) .
\end{aligned}
$$

Combining this with (3.7) and (3.11), we obtain

$$
\begin{aligned}
\partial_{\tilde{r}} \hat{\tilde{v}}+\hat{\tilde{W}}^{r} & =-\frac{n-1}{\tilde{r}^{n}}\left(\tilde{v}_{n-1}+\operatorname{tr}_{h_{0}} \tilde{w}_{n-1}\right)-\frac{n}{\tilde{r}^{n+1}}\left(\tilde{v}_{n}+\operatorname{tr}_{h_{0}} \tilde{w}_{n}\right)+O\left(\tilde{r}^{-2-n}\right) \\
& =-\frac{n}{\tilde{r}^{n+1}}\left(\tilde{v}_{n}+\operatorname{tr}_{h_{0}} \tilde{w}_{n}\right)+O\left(\tilde{r}^{-2-n}\right),
\end{aligned}
$$

which implies

$$
\lim _{\tilde{r} \rightarrow \infty}-2 e^{-2 \tilde{u}+\hat{\tilde{v}}^{n-1}}\left(\partial_{\tilde{r}} \hat{\tilde{v}}+\hat{\tilde{W}}^{r}\right)=2 n\left(\tilde{v}_{n}+\operatorname{tr}_{h_{0}} \tilde{w}_{n}\right)
$$

Put this into (3.15), and then integrate over $\left(\partial_{\infty} M, h_{0}\right)$. Noting that the term containing $\partial_{\xi}\left(e^{-\hat{v}} \tilde{W}^{\xi}\right)$ cancels away after integrating over $\xi$, and recalling the assumption (1.13), we obtain

$$
\begin{aligned}
2 n \int_{\partial_{\infty} M}\left(\tilde{v}_{n}+\operatorname{tr}_{h_{0}} \tilde{w}_{n}\right) d V_{h_{0}} \geq & n \tilde{r}_{0}^{n}\left(1-\frac{\breve{r}_{0}}{\tilde{r}_{0}}\right) \operatorname{Vol}\left(\partial_{\infty} M, h_{0}\right) \\
& +\int_{\partial_{\infty} M} \int_{\tilde{r}_{0}}^{\infty} A d \tilde{r} d V_{h_{0}}
\end{aligned}
$$

Inserting this into (3.12), we obtain

$$
\begin{aligned}
E(g)-E\left(g_{\mathrm{HM}}\right) \geq & \tilde{r}_{0}^{n}\left[n-1+\left(\frac{\breve{r}_{0}}{\tilde{r}_{0}}\right)^{n}-n \frac{\breve{r}_{0}}{\tilde{r}_{0}}\right] \operatorname{Vol}\left(\partial_{\infty} M, h_{0}\right) \\
& +\int_{\partial_{\infty} M} \int_{\tilde{r}_{0}}^{\infty} A d \tilde{r} d V_{h_{0}} .
\end{aligned}
$$

It is easy to see that

$$
n-1+s^{n}-n s=(1-s)\left(n-1-s-\cdots-s^{n-1}\right) \geq 0
$$

for $s>0$, and the equality occurs if and only if $s=1$. Taking $s=\frac{\breve{r}_{0}}{\breve{r}_{0}}$, we obtain

$$
E(g)-E\left(g_{\mathrm{HM}}\right) \geq 0 .
$$

For the case of equality, we have

$$
\tilde{r}_{0}=\breve{r}_{0}, \quad A \equiv 0,
$$

which implies

$$
R+n(n-1)=0, \quad \hat{\tilde{W}}^{r}=\tilde{W}^{\xi}=0, \quad \tilde{\tilde{W}}^{r}=0, \quad \tilde{\tilde{W}}^{\xi}=0 .
$$

It follows that

$$
\tilde{W}^{r}=\frac{n-2}{\tilde{r}}+\hat{\tilde{W}}^{r}=\frac{n-2}{\tilde{r}} .
$$

Hence

$$
\partial_{r}\left(\tilde{\gamma}_{i j}\right)=\frac{2 \tilde{W}^{r}}{n-2} \tilde{\gamma}_{i j}+\tilde{W}^{r}=\frac{2}{\tilde{r}} \tilde{\gamma}_{i j} .
$$

Therefore

$$
\partial_{r}\left(\frac{1}{\tilde{r}^{2}} \tilde{\gamma}_{i j}\right)=0 .
$$

It implies that

$$
\frac{1}{\tilde{r}^{2}} \tilde{\gamma}_{i j}=\left.\frac{1}{\tilde{r}^{2}} \tilde{\gamma}_{i j}\right|_{\tilde{r}=\infty}=\delta_{i j}, \quad \gamma=\tilde{r}^{2} \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2} .
$$

Now we can simplify (3.14) and find that

$$
\partial_{\tilde{r}}^{2}\left(e^{\hat{\tilde{v}}}\right)+\frac{(n+1) \tilde{r}^{n}+\left(\frac{n}{2}-1\right) \tilde{r}_{0}^{n}}{\tilde{r}\left(\tilde{r}^{n}-\tilde{r}_{0}^{n}\right)} \cdot\left(\partial_{\tilde{r}} e^{\hat{\tilde{v}}}\right)^{2}=0 .
$$

Since

$$
e^{\hat{\hat{v}}\left(\tilde{r}_{0}, \xi\right)}=\frac{\breve{r}_{0}}{\tilde{r}_{0}}=1=\lim _{\tilde{r} \rightarrow \infty} e^{\hat{\hat{v}}(\tilde{r})}
$$

we can show $\hat{\tilde{v}} \equiv 0$ by the maximum principle. Finally, we obtain

$$
g=\frac{1}{\tilde{r}^{2}\left(1-\frac{\breve{r}_{n}^{n}}{\tilde{r}^{n}}\right)} d \tilde{r}^{2}+\tilde{r}^{2}\left(1-\frac{1}{\tilde{r}^{n}}\right) d \xi^{2}+\tilde{r}^{2} \sum_{i=3}^{n}\left(d \phi^{i}\right)^{2} .
$$

Thus $g$ is the Horowitz-Myers metric $g_{\mathrm{HM}}$.
Q.E.D.
