# A CHARACTERIZATION OF CONTINUOUS $q$-JACOBI, CHEBYSHEV OF THE FIRST KIND AND AL-SALAM CHIHARA POLYNOMIALS

#### Abstract

The purpose of this note is to characterize those orthogonal polynomials sequences $\left(P_{n}\right)_{n \geq 0}$ for which $$
\pi(x) \mathcal{D}_{q} P_{n}(x)=\left(a_{n} x+b_{n}\right) P_{n}(x)+c_{n} P_{n-1}(x), \quad n=0,1,2, \ldots,
$$ where $\mathcal{D}_{q}$ is the Askey-Wilson operator, $\pi$ is a polynomial of degree at most 2 , and $\left(a_{n}\right)_{n \geq 0},\left(b_{n}\right)_{n \geq 0}$ and $\left(c_{n}\right)_{n \geq 0}$ are sequences of complex numbers such that $c_{n} \neq 0$ for $n=1,2, \ldots$.


## 1. Introduction and main results

Let $\pi$ be a nonzero polynomial of degree at most 2 and consider three sequences of complex numbers $\left(a_{n}\right)_{n \geq 0},\left(b_{n}\right)_{n \geq 0}$ and $\left(c_{n}\right)_{n \geq 0}$. Al-Salam and Chihara 2 proved that the only orthogonal polynomial sequences (OPS), say $\left(P_{n}\right)_{n \geq 0}$, that satisfy

\pi(x) D P_{n}(x)=\left(a_{n} x+b_{n}\right) P_{n}(x)+c_{n} P_{n-1}(x) \tag{1.1}
\end{equation*}
$$

are those of Hermite, Laguerre, Jacobi, and Bessel. Here $D$ denotes the standard derivative with respect to $x$. Consider now (1.1) with $D$ replaced by the AskeyWilson operator,

\left(\mathcal{D}_{q} f\right)(x)=\frac{\breve{f}\left(q^{1 / 2} z\right)-\breve{f}\left(q^{-1 / 2} z\right)}{\breve{e}\left(q^{1 / 2} z\right)-\breve{e}\left(q^{-1 / 2} z\right)}, \quad z=e^{i \theta} \tag{1.2}
\end{equation*}
$$

where $\breve{f}(z)=f((z+1 / z) / 2)=f(\cos \theta)$ for each polynomial $f$ and $e(x)=x$. Here $0<q<1$ and $\theta$ is not necessarily a real number (see [6, p.300]). The following conjecture is the first part of [6, Conjecture 24.7.8], rewritten using the (2.1) below.

Conjecture 1.1. Let $\left(P_{n}\right)_{n \geq 0}$ be a monic OPS and $\pi$ be a polynomial of degree at most 2 which does not depend on $n$. If $\left(P_{n}\right)_{n \geq 0}$ satisfies

\pi(x) \mathcal{D}_{q} P_{n}(x)=\left(a_{n} x+b_{n}\right) P_{n}(x)+c_{n} P_{n-1}(x) \tag{1.3}
\end{equation*}
$$

then $\left(P_{n}\right)_{n \geq 0}$ are continuous $q$-Jacobi polynomials, Al-Salam-Chihara polynomials, or special or limiting cases of them.

[^0]Ismail himself proved that the continuous $q$-Jacobi polynomials indeed satisfy (1.3) for suitable polynomial $\pi$ and parameters $a_{n}, b_{n}$, and $c_{n}$ (cf. [6, Theorem 15.5.2]). Al-Salam [1] proved Conjecture 1.1 for $\pi(x)=1$ (see [5, Proposition 5.3.1] for an alternative proof of this result based on the approach developed in this note), by characterizing the Rogers $q$-Hermite polynomials, $P_{n}(x)=H_{n}(x \mid q)$, as the only OPS that fulfill $\mathcal{D}_{q} P_{n}=c_{n} P_{n-1}$ for $n=1,2, \ldots$ Recall that the monic continuous $q$-Jacobi polynomials, $\widehat{P}_{n}^{(a, b)}(x \mid q)$, depend on two real parameters $a$ and $b$, and they are characterized by the three-term recurrence relation

x \widehat{P}_{n}^{(a, b)}(x \mid q)= & \widehat{P}_{n+1}^{(a, b)}(x \mid q)+\frac{1}{2}\left(q^{(2 a+1) / 4}+q^{-(2 a-1) / 4}-y_{n}-z_{n}\right) \widehat{P}_{n}^{(a, b)}(x \mid q) \\
& +\frac{1}{4} y_{n-1} z_{n} \widehat{P}_{n-1}^{(a, b)}(x \mid q),
\end{aligned}
$$

$n=0,1, \ldots$, being

$$
\begin{aligned}
& y_{n}=\frac{\left(1-q^{n+a+1}\right)\left(1-q^{n+a+b+1}\right)\left(1+q^{n+(a+b+1) / 2}\right)\left(1+q^{n+(a+b+2) / 2}\right)}{q^{(2 a+1) / 4}\left(1-q^{2 n+a+b+1}\right)\left(1-q^{2 n+a+b+2}\right)} \\
& z_{n}=\frac{q^{(2 a+1) / 4}\left(1-q^{n}\right)\left(1-q^{n+b}\right)\left(1+q^{n+(a+b) / 2}\right)\left(1+q^{n+(a+b+1) / 2}\right)}{\left(1-q^{2 n+a+b}\right)\left(1-q^{2 n+a+b+1}\right)}
\end{aligned}
$$

while the monic Al-Salam-Chihara polynomials, $Q_{n}(x ; c, d \mid q)$, which also depend on two parameters $c$ and $d$, are characterized by

$$
\begin{aligned}
x Q_{n}(x ; c, d \mid q)= & Q_{n+1}(x ; c, d \mid q)+\frac{1}{2}(c+d) q^{n} Q_{n}(x ; c, d \mid q) \\
& +\frac{1}{4}\left(1-c d q^{n-1}\right)\left(1-q^{n}\right) Q_{n-1}(x ; c, d ; q),
\end{aligned}
$$

$n=0,1, \ldots$, provided we define $\widehat{P}_{-1}^{(a, b)}(x \mid q)=Q_{-1}(x ; c, d \mid q)=0$ (see e.g. [6]). Further, up to normalization, the Rogers $q$-Hermite polynomials are the special case $c=d=0$ of the Al-Salam-Chihara polynomials.

The following two theorems summarize the main results of this note and, together with Al-Salam's theorem, give positive answer to Conjecture 1.1
Theorem 1.2. The Al-Salam Chihara polynomials with nonzero parameters $c$ and $d$ such that $c / d=q^{ \pm 1 / 2}$ are the only OPS satisfying (1.3) for $\operatorname{deg} \pi=1$.

Theorem 1.3. The Chebyschev polynomials of the first kind and the continuous $q$-Jacobi polynomials are the only OPS satisfying (1.3) for $\operatorname{deg} \pi=2$.

The two previous theorems give more than a simple answer to Conjecture 1.1. In fact, we now know, for instance, that Al-Salam Chihara polynomials appear only when $\operatorname{deg} \pi=1$ and for $c / d=q^{ \pm 1 / 2}$, or that continuous $q$-Jacobi polynomials are exclusively related to the case $\operatorname{deg} \pi=2$, or that Chebyschev polynomials of the first type are the only "limiting case" that satisfy Conjecture 1.1.

Remark 1.4. Koornwinder [4, Section 4] gave a structure formula (and resulting lowering formula) for Askey-Wilson polynomials. Necessarily, because of Conjecture 1.1 settled in the present paper, the left-hand side in Koornwinder's formula has a more general form than in (1.3). With the usual parameters $a, b, c, d$ for AskeyWilson polynomials, substitution of $c=q^{1 / 2}, d=-q^{1 / 2}$ in these formulas gives similar formulas for continuous $q$-Jacobi polynomials with $q$ replaced by $q^{2}$ (see [4. Section 5]). In a personal communication Koornwinder pointed out to us that Ismail's and his formulas in the continuous q-Jacobi case are the same modulo polynomial multiples of the second order q-difference formula and the three-term recurrence relation for continuous q-Jacobi polynomials.

Since this work is an application of the theory developed in our previous paper [3], in the next sections, we suppose that the reader has [3] at hand and we shall use its notation, definitions, and results.

## 2. Preliminary Results

Taking $e^{i \theta}=q^{s}$ in (1.2), $\mathcal{D}_{q}$ reads

\mathcal{D}_{q} f(x(s))=\frac{f\left(x\left(s+\frac{1}{2}\right)\right)-f\left(x\left(s-\frac{1}{2}\right)\right)}{x\left(s+\frac{1}{2}\right)-x\left(s-\frac{1}{2}\right)}, \quad x(s)=\frac{1}{2}\left(q^{s}+q^{-s}\right)
$$

We define an operator $\mathcal{S}_{q}: \mathbb{R}[x] \rightarrow \mathbb{R}[x]$ by

$$
\mathcal{S}_{q} f(x(s))=\frac{f\left(x\left(s+\frac{1}{2}\right)\right)+f\left(x\left(s-\frac{1}{2}\right)\right)}{2}
$$

Hereafter, we denote $X=x(s)=\left(q^{s}+q^{-s}\right) / 2$ with $0<q<1$. Recall that a monic OPS $\left(P_{n}\right)_{n \geq 0}$ satisfies the following three term recurrence relation (TTRR):

X P_{n}(X)=P_{n+1}(X)+B_{n} P_{n}(X)+C_{n} P_{n-1}(X), \quad n=0,1,2, \ldots \tag{2.1}
\end{equation*}
$$

with $P_{-1}(X)=0$ and $B_{n} \in \mathbb{C}$ and $C_{n+1} \in \mathbb{C} \backslash\{0\}$ for each $n=0,1,2, \ldots$. We start by showing that all monic OPS, $\left(P_{n}\right)_{n \geq 0}$, satisfying (1.3) belongs to a well known class of OPS and then we prove that the coefficients of the associated TTRR satisfy a system of non linear equations that will be solved in the next section.

Lemma 2.1. Let $\mathbf{u} \in \mathcal{P}^{*}$ be a regular functional such that its corresponding monic OPS $\left(P_{n}\right)_{n \geq 0}$ satisfies (1.3) subject to the condition $c_{n} \neq 0$ for $n=1,2, \ldots$ Then $\mathbf{u}$ is $x$-classical; that is $\mathcal{D}_{q}(\phi \mathbf{u})=\mathcal{S}_{q}(\psi \mathbf{u})$ with $\operatorname{deg} \phi \leq 2$ and $\operatorname{deg} \psi \leq 1$. Moreover, $\psi$ and $\phi$ are polynomials given by

\psi(X)=X-B_{0}, \quad \phi(X)=(\mathfrak{a} X-\mathfrak{b})\left(X-B_{0}\right)-(\mathfrak{a}+\alpha) C_{1} \tag{2.2}
\end{equation*}

where

$$
\begin{equation*}
\mathfrak{a}=\frac{\left(a_{2} C_{2}+c_{2}\right) C_{1}}{\left(a_{1} C_{1}+c_{1}\right) C_{2}}-\alpha, \quad \mathfrak{b}=-B_{0}+(\mathfrak{a}+\alpha) B_{1}-\frac{b_{1}+a_{1} B_{1}}{c_{1}+a_{1} C_{1}} C_{1} \tag{2.3}
\end{equation*}
$$

(Here $B_{0}, B_{1}, C_{1}$, and $C_{2}$ are coefficients of the TTRR (2.1) satisfied by $\left(P_{n}\right)_{n \geq 0}$.)
Proof. Let $\left(\mathbf{a}_{n}\right)_{n \geq 0}$ be the dual basis associated to the monic OPS $\left(P_{n}\right)_{n \geq 0}$. We claim that

\mathcal{D}_{q}(\pi \mathbf{u})=R_{1} \mathbf{u}, \quad R_{1}(X)=-\frac{a_{1} C_{1}+c_{1}}{C_{1}}\left(X-B_{0}\right) \tag{2.4}
\end{equation*}
$$

with $a_{1} C_{1}+c_{1} \neq 0$. Indeed, using (1.3) and (2.1), we have

\left\langle\mathcal{D}_{q}\left(\pi \mathbf{a}_{0}\right), P_{j}\right\rangle=-\left\langle\mathbf{a}_{0}, \pi \mathcal{D}_{q} P_{j}\right\rangle=-a_{j} \delta_{0, j+1}-\left(a_{j} B_{j}+b_{j}\right) \delta_{0, j}-\left(c_{j}+a_{j} C_{j}\right) \delta_{1, j}
$$

for fixed $j \in \mathbb{N}_{0}$. Taking $n=0$ in (1.3), we find $a_{0}=b_{0}=0$, and since $\left\langle\mathbf{u}, P_{n}^{2}\right\rangle \mathbf{a}_{n}=$ $P_{n} \mathbf{u}$ and $C_{n+1}=\left\langle\mathbf{u}, P_{n+1}^{2}\right\rangle /\left\langle\mathbf{u}, P_{n}^{2}\right\rangle$, we obtain

$$
\mathcal{D}_{q}\left(\pi \mathbf{a}_{0}\right)=\sum_{j=0}^{\infty}\left\langle\mathcal{D}_{q}\left(\pi \mathbf{a}_{0}\right), P_{j}\right\rangle \mathbf{a}_{j}=-\left(c_{1}+a_{1} C_{1}\right) \mathbf{a}_{1}
$$

If $c_{1}+a_{1} C_{1}=0$, then $\mathbf{D}_{x}(\pi \mathbf{u})=0$, hence $0=\left\langle\mathcal{D}_{q}(\pi \mathbf{u}), f\right\rangle=-\left\langle\pi \mathbf{u}, \mathcal{D}_{q} f\right\rangle, \forall f \in \mathcal{P}$. This implies $\pi \mathbf{u}=\mathbf{0}$. But this is impossible, since $\pi \neq 0$ and $\mathbf{u}$ is regular. So
$c_{1}+a_{1} C_{1} \neq 0$. Hence (2.4) holds. Applying $\mathcal{D}_{q}$ to both sides of (2.1), and using [3, (2.28)], yields

\mathcal{S}_{q} P_{n}(X)=-\alpha X \mathcal{D}_{q} P_{n}(X)+\mathcal{D}_{q} P_{n+1}(X)+B_{n} \mathcal{D}_{q} P_{n}(X)+C_{n} \mathcal{D}_{q} P_{n-1}(X)
$$

Multiplying both sides of this equality by $\pi(X)$ and using (1.3) and (2.1), we obtain

\pi(X) \mathcal{S}_{q} P_{n}(X)=r_{n}^{[1]} P_{n+2}(X)+r_{n}^{[2]} P_{n+1}(X)+r_{n}^{[3]} P_{n}(X)+r_{n}^{[4]} P_{n-1}(X)+r_{n}^{[5]} P_{n-2}(X) \tag{2.5}
\end{equation*}
$$

for each $n=0,1,2, \ldots$, where

$$
\begin{aligned}
& r_{n}^{[1]}=a_{n+1}-\alpha a_{n}, \\
& r_{n}^{[2]}=g_{n+1}-\alpha g_{n}+a_{n}\left(B_{n}-\alpha B_{n+1}\right), \\
& r_{n}^{[3]}=s_{n+1}-\alpha s_{n}+g_{n}(1-\alpha) B_{n}+a_{n-1} C_{n}-\alpha a_{n} C_{n+1}, \\
& r_{n}^{[4]}=\left(g_{n-1}-\alpha g_{n}\right) C_{n}+s_{n}\left(B_{n}-\alpha B_{n-1}\right), \\
& r_{n}^{[5]}=C_{n} s_{n-1}-\alpha C_{n-1} s_{n},
\end{aligned}

and $g_{n}=b_{n}+a_{n} B_{n}, s_{n}=c_{n}+a_{n} C_{n}$. For a fixed $j \in \mathbb{N}_{0}$, using (2.5) we obtain

\left\langle\mathcal{S}_{q}\left(\pi \mathbf{a}_{0}\right), P_{j}\right\rangle=\left\langle\mathbf{a}_{0}, \pi \mathcal{S}_{q} P_{j}\right\rangle=r_{j}^{[1]} \delta_{0, j+2}+r_{j}^{[2]} \delta_{0, j+1}+r_{j}^{[3]} \delta_{0, j}+r_{j}^{[4]} \delta_{0, j-1}+r_{j}^{[5]} \delta_{0, j-2}
$$

Therefore,

\mathcal{S}_{q}\left(\pi \mathbf{a}_{0}\right)=\sum_{j=0}^{\infty}\left\langle\mathcal{S}_{q}\left(\pi \mathbf{a}_{0}\right), P_{j}\right\rangle \mathbf{a}_{j}=r_{0}^{[3]} \mathbf{a}_{0}+r_{1}^{[4]} \mathbf{a}_{1}+r_{2}^{[5]} \mathbf{a}_{2},
$$

and so

\mathcal{S}_{q}(\pi \mathbf{u})=R_{2} \mathbf{u}, \quad R_{2}(X)=r_{0}^{[3]}+\frac{r_{1}^{[4]}}{C_{1}} P_{1}(X)+\frac{r_{2}^{[5]}}{C_{2} C_{1}} P_{2}(X) \tag{2.6}
\end{equation*}
$$

Next, on the first hand, applying successively (2.6), 3, (2.47)] and (2.4), we obtain

\mathcal{D}_{q}\left(R_{2} \mathbf{u}\right)=\frac{2 \alpha^{2}-1}{\alpha} \mathcal{D}_{q}\left(R_{1} \mathbf{u}\right)+\frac{\mathrm{U}_{1}}{\alpha} \mathcal{D}_{q}\left(R_{1} \mathbf{u}\right) . \tag{2.7}
\end{equation*}

On the other hand, using [3, (2.34)] with $f=\mathrm{U}_{1}$, we obtain

\alpha \mathcal{D}_{q}\left(\mathrm{U}_{1} R_{1} \mathbf{u}\right)=\mathrm{U}_{1} \mathcal{D}_{q}\left(R_{1} \mathbf{u}\right)+\left(\alpha^{2}-1\right) \mathcal{S}_{q}\left(R_{1} \mathbf{u}\right)
$$

Thus, from (2.7) we obtain $\mathcal{D}_{q}\left(\left(R_{2}-\mathrm{U}_{1} R_{1}\right) \mathbf{u}\right)=\mathcal{S}_{q}\left(\alpha R_{1} \mathbf{u}\right)$. This leads us to define

\psi(X)=X-B_{0}, \quad \phi(X)=-\frac{C_{1}}{\alpha\left(c_{1}+a_{1} C_{1}\right)}\left(R_{2}(X)-\mathrm{U}_{1}(X) R_{1}(X)\right) .
$$

Clearly, $\operatorname{deg} \psi=1, \operatorname{deg} \phi \leq 2$ and $\mathcal{D}_{q}(\phi \mathbf{u})=\mathcal{S}_{q}(\psi \mathbf{u})$. Finally, since $a_{0}=0=b_{0}$, and setting (without lost of generality) $c_{0}=0$ and $C_{0}=0$, we have

& \phi^{\prime \prime}(0)=\frac{2\left(c_{2}+a_{2} C_{2}\right) C_{1}}{\left(c_{1}+a_{1} C_{1}\right) C_{2}}-2 \alpha, \phi^{\prime}(0)=(1-\mathfrak{a}) B_{0}-(\mathfrak{a}+\alpha) B_{1}+\frac{b_{1}+a_{1} B_{1}}{c_{1}+a_{1} C_{1}} C_{1} \\
& \phi(0)=-(\mathfrak{a}+\alpha) C_{1}-B_{0}\left(B_{0}-(\mathfrak{a}+\alpha) B_{1}+\frac{b_{1}+a_{1} B_{1}}{c_{1}+a_{1} C_{1}} C_{1}\right)
\end{aligned}
$$

and the proof is complete.
Lemma 2.2. Let $\left(P_{n}\right)_{n \geq 0}$ be a monic OPS satisfying (1.3). Then the coefficients $B_{n}$ and $C_{n}$ of the TTR $\bar{R}$ (2.1) satisfied by $\left(P_{n}\right)_{n \geq 0}$ fulfill the following system of
difference equations:

& r_{n}\left(B_{n}^{2}-2 \alpha B_{n} B_{n-1}+B_{n-1}^{2}\right) \\
& \quad=\left(r_{n+1}+r_{n+2}\right)\left(C_{n+1}-1 / 4\right)-2(1+\alpha) r_{n}\left(C_{n}-1 / 4\right) \\
& \quad+\left(r_{n-1}+r_{n-2}\right)\left(C_{n-1}-1 / 4\right)

& \left.+a_{n+1}-a_{n+2}\right) B_{n+1} C_{n+1}+\left(t_{n}+a_{n-1}-a_{n-2}\right) B_{n-1} C_{n} \\
& +\left[\left(2 a_{n}-a_{n+2}-a_{n-1}\right) C_{n+1}+\left(2 a_{n}-a_{n+1}-a_{n-2}\right) C_{n}\right. \\

In addition, the following relations hold:

& a_{n}=\gamma_{n}, \quad b_{n}=\left(a_{n}-a_{n-1}\right) \sum_{j=0}^{n-1} B_{j}+\pi^{\prime}(0) a_{n}, \quad \text { if } \operatorname{deg} \pi=2 . \tag{2.13}

Proof. Applying the operator $\mathcal{S}_{q}$ to both sides of (2.1) and using [3, (2.29)], we deduce $\mathrm{U}_{2}(X) \mathcal{D}_{q} P_{n}(X)+\alpha X \mathcal{S}_{q} P_{n}(X)=\mathcal{S}_{q} P_{n+1}(X)+B_{n} \mathcal{S}_{q} P_{n}(X)+C_{n} \mathcal{S}_{q} P_{n-1}(X)$. Multiplying both sides of this equality by $\pi(X)$ and then using successively [3, (2.25)] (for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ), (1.3), (2.5), and (2.1), we obtain a vanishing linear combination of the polynomials $P_{n+3}, P_{n+2}, \ldots, P_{n-3}$. Thus, setting $t_{n}=c_{n} / C_{n}$ for $n=1,2,3, \ldots$, after straightforward computations we obtain (2.8)
together with the following equations:

(2.12) is obtained in a similar way and this completes the proof.

For the next results of this section, we distinguish two cases according as deg $\pi=$ 1 or $\operatorname{deg} \pi=2$.
2.1. Case $\operatorname{deg} \pi=1$. In this case, (1.3) can be rewritten as

Since $k_{2} \neq 0$ and $0<q<1$, we obtain $\lim _{n \rightarrow \infty} q^{-n / 2} B_{n}=-K_{b} / k_{2}$ and consequently we have $K_{b}=0$ by applying limit of the same expression using [3, (4.4)] ( for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ). This implies that $B_{1}=t_{0} B_{0} / t_{2}$. If $B_{0}=0$, then we find $B_{1}=0$ which is in contradiction with the second equation in (2.22). Then (2.23) is proved. Note that, from (2.3) and using (2.21), we obtain

Thus using [3, (4.4)] (for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ) to evaluate the same sum, we have $t_{1} B_{0}\left(\mathfrak{a} \gamma_{2 n-2}+\alpha_{2 n-2}\right)=-t_{n}\left(\phi^{\prime}(0) \gamma_{n-1}-B_{0} \alpha_{n-1}\right)$. This gives the following equations:

It is easily seen that (2.32) implies $r_{0}=0=s_{0}$ as well as $B_{0}=0=\phi^{\prime}(0)$. Hence $B_{n}=0$ for $n=0,1,2, \ldots$ In addition, using (2.2), we obtain $\mathfrak{b}=0$. Next we apply [3, (4.5)] (for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ) to obtain

But using what is preceding, from (2.28) we have $k_{1}=$ $-k_{2}=-2 u$ and therefore $t_{n}=-2 \gamma_{n}$, which is in contradiction with the previous expression of $t_{n}$, which gives $\widehat{a} \neq 0$. The case $\widehat{b}=0$ can be treated similarly.

Assume now that $1+2 \mathfrak{a} u=0$. Since $\mathfrak{a}=-\alpha+\left(1+r_{2}\right) / r_{1}$, we obtain $\widehat{a}=$ $-u q^{-1 / 2} \neq 0$. On the other hand, we use [3, (4.4)] (for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ) to obtain

## 3. Proof of theorems 1.2 and 1.3

Proof of Theorem 1.2. Note that (2.20) is equivalent to $k_{1} k_{2}=0$. Suppose that $k_{1}=0$. By (2.21), we have $t_{n}=k_{2} q^{-n / 2}$, where $k_{2}=q^{1 / 2} c_{1} / C_{1}$. We claim that

Indeed, (2.9) reduces to $q^{-1 / 2} B_{n+2}+\left(1+q^{1 / 2}\right) B_{n+1}+q B_{n}=0, n=0,1,2, \ldots$ and so we find $B_{n}=v q^{n}+s q^{n / 2}$ for some $v, s \in \mathbb{C}$. Moreover, since $k_{1}=0$, from (2.25) we get $\mathfrak{a}=-1 /(2 u)$. Hence, by (2.2), $\phi(X)=-\left((X+2 \mathfrak{b} u)\left(X-B_{0}\right)+\right.$ $\left.2 u q^{-1 / 2} C_{1}\right) /(2 u)$ and $\psi(X)=X-B_{0}$. Therefore, using [3, (4.4)] (for $\mathfrak{c}_{3}=0$ and $\left.\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2\right)$, we obtain $B_{n}=q^{(2 n-1) / 2}\left(2 \alpha u \mathfrak{b}\left(q^{n}-1\right)+q^{1 / 2} B_{0}\right)$. Comparing the two previous expressions for $B_{n}$, we find $s=0=\mathfrak{b}$ and $v=B_{0}$. Hence using the first equation in (2.22), (3.1) follows. As consequence, taking $n=1$ in (3.1) and comparing the result with the expression for $B_{1}$ given by (2.22), we obtain

\left(q^{-1}+q^{-1 / 2}\right)\left(C_{n+1}-1 / 4\right)-2(1+\alpha)\left(C_{n}-1 / 4\right) & +\left(q+q^{1 / 2}\right)\left(C_{n-1}-1 / 4\right) \\
(3.8) & =(\alpha-1)(\alpha+1 / 2)(c+d)^{2} q^{2 n-1} \tag{3.8}
\end{align*}
$$

From $c^{2}+d^{2}=2 \alpha c d$, it is easy to see that $B_{n}$ and $C_{n+1}$, in (3.7), satisfy (3.8). (2.11) in this case ( $a_{n}=0$ for $n=0,1,2, \ldots$ ) reads as

$$
\begin{align*}
& 2(1-\alpha) b_{n} B_{n}^{2}+(1-2 \alpha)\left(c_{n}+c_{n+1}\right) B_{n}+c_{n+1} B_{n+1}+c_{n} B_{n-1} \\
& +\left(b_{n}-b_{n+2}\right)\left(C_{n+1}-1 / 4\right)+\left(b_{n}-b_{n-2}\right)\left(C_{n}-1 / 4\right)=0 \tag{3.9}
\end{align*}
$$

where $c_{n}=t_{n} C_{n}=k_{2} q^{-n / 2} C_{n}$ for $n=1,2, \ldots$. Similarly, one may check that (3.9) is also satisfied and, therefore, the system of equations (2.8)-(2.11) is fulfilled. By a similar argument, if $k_{2}=0$, we obtain (3.7) with $q$ replaced by $1 / q$ and $c^{2}+d^{2}-2 \alpha c d=0$ as solution of the system of difference equations (2.8)-(2.11). Thus

P_{n}(X)=Q_{n}(X ; c, d \mid q) \quad \text { or } \quad P_{n}(X)=Q_{n}\left(X ; c, d \mid q^{-1}\right), \quad n=0,1,2, \ldots \tag{3.10}
\end{equation*}

with $c^{2}+d^{2}-2 \alpha c d=0$, i.e. $c / d=q^{ \pm 1 / 2}$, and this is precisely the assertion of Theorem 1.2.

Proof of Theorem 1.3. Taking successively $n=1$ and $n=2$ in (2.26) using (2.1) and [3, (2.40)] (for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ) we obtain the following:

& B_{0}=b_{1}+r+s, \quad c_{1}=\left(B_{0}-r\right)\left(B_{0}-s\right)  \tag{3.11}\\
& b_{2}=(2 \alpha-1)\left(B_{0}+B_{1}\right)-2 \alpha(r+s)  \tag{3.12}\\
& r s\left(B_{0}+B_{1}\right)=c_{2} B_{0}-b_{2}\left(B_{0} B_{1}-C_{1}\right)  \tag{3.13}\\
& c_{2}=b_{2}\left(B_{0}+B_{1}\right)-2 \alpha\left(B_{0} B_{1}-C_{1}\right)+(r+s)\left(B_{0}+B_{1}\right)+2 \alpha r s \tag{3.14}
\end{align*}
$$

Solving (2.9) we find

\begin{equation*}
B_{n}=\frac{r_{0} r_{1} B_{0} q^{n / 2}+\widehat{K}_{b}\left(\widehat{a} q^{n}+\left(\widehat{b}-\widehat{a} q^{-1 / 2}\right) q^{n / 2}-\widehat{b} q^{-1 / 2}\right)}{\left(\widehat{a} q^{n}+\widehat{b}\right)\left(\widehat{a} q^{n+1}+\widehat{b}\right)} q^{(n+1) / 2} \tag{3.15}
\end{equation*}
$$

for $n=0,1,2, \ldots$, where $\widehat{K}_{b}=\left(r_{2} B_{1}-r_{0} B_{0}\right) /\left(1-q^{-1 / 2}\right)$. Since $\widehat{a} \widehat{b} \neq 0$ and $0<q<1$, then $\lim _{n \rightarrow \infty} q^{-n / 2} B_{n}=-\widehat{K}_{b} / \widehat{b}$. Evaluating this limit using [3, (4.4)] (for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ), we find $\widehat{K}_{b}=0$, because $1-2 \mathfrak{a} u \neq 0$. Hence (3.15) reduces to

\begin{equation*}
B_{n}=\frac{r_{0} r_{1} B_{0}}{r_{n} r_{n+1}}, \quad n=0,1,2, \ldots \tag{3.16}
\end{equation*}
$$

It is immediate that $S_{n}=\sum_{j=0}^{n-1} B_{j}=r_{1} B_{0} a_{n} / r_{n}$ for $n=0,1,2, \ldots$. Comparing this with the result obtained using [3, (4.4)] (for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ) we have

\begin{equation*}
\left(2 \mathfrak{a} u r_{1} q^{-1 / 2}+\widehat{b} q^{-1}\right) B_{0}=-2 \widehat{a} u \phi^{\prime}(0), \quad\left(2 \mathfrak{a} u r_{1} q^{1 / 2}-\widehat{a} q\right) B_{0}=-2 \widehat{b} u \phi^{\prime}(0) \tag{3.17}
\end{equation*}
$$

CASE 1. Suppose $\phi^{\prime}(0)=0$. From (3.17) we obtain $r_{1} B_{0}=0$. But from (2.4) we obtain $0 \neq c_{1}+a_{1} C_{1}=r_{1} C_{1}$, i.e. $r_{1} \neq 0$, and so $B_{0}=0$. (Conversely, if we assume $B_{0}=0$, by (2.30), we obtain $\phi^{\prime}(0)=0$.) Hence $B_{0}=0$ and $\mathfrak{b}=0$. From this, we use [3, (4.4)-(4.5)] (for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ) to obtain $B_{n}=0$ and

$$
\begin{equation*}
C_{n+1}=\frac{\left(1-q^{n+1}\right)\left(1-h q^{n-1}\right)\left(1+w q^{n}+h q^{2 n}\right)}{4\left(1-h q^{2 n-1}\right)\left(1-h q^{2 n+1}\right)} \tag{3.18}
\end{equation*}
$$

with $h=-(1+2 \mathfrak{a} u) /(1-2 \mathfrak{a} u)$ and $w=4 u\left(2(\mathfrak{a}+\alpha) C_{1}-\mathfrak{a}\right) /(2 \mathfrak{a} u-1)$. Now defining $\widehat{C}_{n}=C_{n}-1 / 4$, (2.10) reads as

\begin{equation*}
\left(r_{n+1}+r_{n+2}\right) \widehat{C}_{n+1}-2(1+\alpha) r_{n} \widehat{C}_{n}+\left(r_{n-1}+r_{n-2}\right) \widehat{C}_{n-1}=0 \tag{3.19}
\end{equation*}
$$

Therefore, we may write

\begin{equation*}
C_{n+1}=\frac{1}{4}+\frac{\widehat{\theta}_{0} \widehat{\theta}_{1} \widehat{C}_{1} q^{n / 2}+\widehat{K}_{c}\left(\widehat{r}_{0} q^{n}+\left(\widehat{r}_{1}-\widehat{r}_{0} q^{-1 / 2}\right) q^{n / 2}-\widehat{r}_{1} q^{-1 / 2}\right)}{\left(\widehat{r}_{0} q^{n}+\widehat{r}_{1}\right)\left(\widehat{r}_{0} q^{n+1}+\widehat{r}_{1}\right) q^{-(n+1) / 2}} \tag{3.20}
\end{equation*}
$$

for $n=2,3, \ldots$, for some complex numbers $\widehat{\theta}_{0}, \widehat{\theta}_{1}$ and $\widehat{K}_{c}$, where $\widehat{\theta}_{n}=r_{n}+r_{n+1}=$ $\widehat{r}_{0} q^{n / 2}+\widehat{r}_{1} q^{-n / 2}$. Taking into account (2.30) one may see that (3.18) and (3.20) are compatible if and only if either

$$
\begin{equation*}
C_{1}=1 / 4, \quad \widehat{K}_{c}=0, \quad \mathfrak{a}=\alpha\left(4 \alpha^{2}-3\right) /\left(4 \alpha^{2}-1\right) \tag{3.21}
\end{equation*}
$$

or

$$
\begin{equation*}
C_{1}=1 / 2, \quad \mathfrak{a}=\alpha, \quad \widehat{K}_{c}=0, \quad \widehat{\theta}_{0} \widehat{\theta}_{1}=0 \tag{3.22}
\end{equation*}
$$

In case of (3.21) holds, we get

B_{n}=0, \quad C_{n+1}=1 / 4, \quad n=0,1, \ldots
$$

This satisfies (2.8)-(2.11), taking into account that from (2.13) we have $a_{n}=\gamma_{n}$ and $b_{n}=-(r+s) \gamma_{n}$ for $n=0,1, \ldots$. From (3.11)-(3.14), we obtain $r+s=0$, $c_{1}=-r^{2}$ and $c_{2}=-\alpha\left(2 r^{2}-1 / 2\right)$. In addition, $r^{2}=\alpha^{2}$. In fact, this follows by comparing the expression of $\mathfrak{a}$ given in (3.21) and the one obtained from (2.3). So we now have $c_{1}=-\alpha^{2}$ and $c_{2}=-\alpha\left(2 \alpha^{2}-1 / 2\right)$. Next, with these expressions, $k_{1}$ and $k_{2}$ given in (2.28) become $k_{1}=-u(1+q)$ and $k_{2}=u\left(1+q^{-1}\right)$ and consequently $c_{n}=-\alpha \gamma_{n+1} / 2$ for $n=0,1, \ldots$. However taking $n=3$ in (2.26) and using the fact that $B_{n}=0$ and $r=-s$, we obtain

$$
\begin{equation*}
2\left(2 \alpha^{2}-1\right)\left(C_{1}+C_{2}\right)=\alpha^{2}-1+c_{3}+\left(4 \alpha^{2}-1\right) r^{2}, c_{3} C_{1}=\left(1-\alpha^{2}-C_{1}-C_{2}\right) r^{2} \tag{3.23}
\end{equation*}
$$

It is then clear that the obtained values of $C_{1}, C_{2}, c_{3}$ and $r^{2}$ do not satisfy (3.23).
For the case where conditions (3.22) meet, we obtain

$$
B_{n-1}=0, C_{1}=1 / 2, C_{n+1}=1 / 4, \quad n=1,2, \ldots
$$

Again this satisfies (2.8)-(2.11) taking into account that from (2.13) we have $a_{n}=\gamma_{n}$ and $b_{n}=-(r+s) \gamma_{n}$ for $n=0,1, \ldots$. From (3.11)-(3.14), we obtain $r+s=0$, $c_{1}=-r^{2}$ and $c_{2}=\alpha\left(1-2 r^{2}\right)$. In addition, from the expression of $\mathfrak{a}$ giving in (3.22), we write

$$
\alpha=\mathfrak{a}=\frac{\left(c_{2}+2 \alpha C_{2}\right) C_{1}}{\left(c_{1}+C_{1}\right) C_{2}}-\alpha=\alpha \frac{5-6 r^{2}}{1-2 r^{2}}
$$

Therefore $r^{2}=1$, and we have $c_{1}=-1$ and $c_{2}=-\alpha$. Hence $k_{1}$ and $k_{2}$ given in (2.28) become $k_{1}=-k_{2}=-2 u$ and, consequently, $t_{n}=-2 \gamma_{n}$ so that $c_{1}=-1$ and $c_{n}=-\gamma_{n} / 2$ for $n=1,2, \ldots$ We check at once that $C_{1}, C_{2}, c_{3}$ and $r^{2}$ satisfy (3.23). Hence $P_{n}(X)=\widehat{T}_{n}(X)$ for $n=0,1,2, \ldots$, where $\left(\widehat{T}_{n}\right)_{n \geq 0}$ is the monic Chebyschev polynomials of the first kind, and this is precisely the first assertion of Theorem 1.3 .

Case 2. Suppose $\phi^{\prime}(0) \neq 0$. (3.17), taking into account (2.30), implies $B_{0} \neq 0$. The converse is also true. Hence

$$
r_{1} B_{0}\left(\widehat{a} q^{1 / 2}-\widehat{b} q^{-1 / 2}\right) \neq 0
$$

Solving (3.17), we get

$$
\begin{equation*}
\mathfrak{a}=-\frac{1+(q \widehat{a} / \widehat{b})^{2}}{2 u\left(1-(q \widehat{a} / \widehat{b})^{2}\right)}, \quad B_{0}=2 u \phi^{\prime}(0) \frac{1-(q \widehat{a} / \widehat{b})}{1+(q \widehat{a} / \widehat{b})} \tag{3.24}
\end{equation*}
$$

Considering $\widehat{a}, \widehat{b}, B_{0}$ and $C_{1}$ as free parameters, let us define, without loss of generality, two complex numbers $a$ and $b$ such that $-q^{a / 2}$ and $q^{b / 2}$ are solutions of the following quadratic equation

Y^{2}+\frac{2 r_{1} B_{0} q^{1 / 4}}{\widehat{b}\left(1+q^{1 / 2}\right)} Y+\frac{\widehat{a}}{\widehat{b}}=0 \tag{3.25}
\end{equation*}
$$

Thus

$$
\begin{equation*}
q^{a / 2}-q^{b / 2}=\frac{2 r_{1} B_{0} q^{1 / 4}}{\widehat{b}\left(1+q^{1 / 2}\right)}, \quad q^{(a+b) / 2}=-\widehat{a} / \widehat{b} \tag{3.26}
\end{equation*}
$$

On the other hand, we have

$$
\begin{align*}
\left(q^{a / 2}, q^{b / 2}\right) \in & \left\{\left(\frac{\widehat{a}\left(1+q^{1 / 2}\right)}{r_{1} B_{0} q^{1 / 4}+\sqrt{\Delta}},-\frac{r_{1} B_{0} q^{1 / 4}+\sqrt{\Delta}}{\widehat{b}\left(1+q^{1 / 2}\right)}\right),\right.  \tag{3.27}\\
& \left.\left(\frac{\widehat{a}\left(1+q^{1 / 2}\right)}{r_{1} B_{0} q^{1 / 4}-\sqrt{\Delta}},-\frac{r_{1} B_{0} q^{1 / 4}-\sqrt{\Delta}}{\widehat{b}\left(1+q^{1 / 2}\right)}\right)\right\},
\end{align*}
$$

where $\Delta=q^{1 / 2} B_{0}^{2} r_{1}^{2}-\widehat{a} \widehat{b}\left(1+q^{1 / 2}\right)^{2}$. From (3.26), (3.24) and (2.2), we obtain

$$
\begin{aligned}
\mathfrak{a} & =-\frac{1+q^{a+b+2}}{2 u\left(1-q^{a+b+2}\right)}, \quad B_{0}=\frac{\left(1+q^{1 / 2}\right) q^{1 / 4}\left(q^{a / 2}-q^{b / 2}\right)}{2\left(1-q^{(a+b+2) / 2}\right)} \\
\mathfrak{b} & =\frac{q^{3 / 4}\left(q^{a / 2}-q^{b / 2}\right) q^{(a+b+2) / 2}}{2 u^{2}\left(q^{1 / 2}-1\right)\left(1-q^{a+b+2}\right)\left(1-q^{(a+b+2) / 2}\right)}
\end{aligned}
$$

Note that (2.29) can be written using (3.26) as

$$
\begin{equation*}
r_{n}=\widehat{b}\left(1-q^{n+(a+b) / 2}\right) q^{-n / 2}, \quad n=0,1,2, \ldots \tag{3.28}
\end{equation*}
$$

Therefore (3.16) becomes

$$
\begin{align*}
B_{n} & =q^{1 / 4}\left(1+q^{1 / 2}\right) \frac{\left(1-q^{(a+b) / 2}\right)\left(q^{a / 2}-q^{b / 2}\right) q^{n}}{2\left(1-q^{(2 n+a+b) / 2}\right)\left(1-q^{(2 n+a+b+2) / 2}\right)}  \tag{3.29}\\
& =\left(q^{(2 a+1) / 4}+q^{-(2 a+1) / 4}-y_{n}-z_{n}\right) / 2
\end{align*}
$$

Taking into account the above, (2.2) becomes

$$
\begin{aligned}
\phi(X)= & -\frac{1+q^{a+b+2}}{2 u\left(1-q^{a+b+2}\right)} X^{2}+q^{1 / 4}\left(1+q^{1 / 2}\right) \frac{\left(q^{a / 2}-q^{b / 2}\right)}{4 u\left(1+q^{(a+b+2) / 2}\right)} X \\
& +\frac{(1+\alpha) q^{(a+b+4) / 2}\left(q^{a / 2}-q^{b / 2}\right)^{2}}{2 u\left(1-q^{a+b+2}\right)\left(1-q^{(a+b+2) / 2}\right)^{2}}-q^{-1 / 2} \frac{1-q^{a+b+3}}{1-q^{a+b+2}} C_{1} \\
\psi(X)= & X-q^{1 / 4}\left(1+q^{1 / 2}\right) \frac{\left(q^{a / 2}-q^{b / 2}\right)}{2\left(1-q^{(a+b+2) / 2}\right)}
\end{aligned}
$$

Let $\mathbf{u}$ be the regular linear functional with respect to the monic OPS $\left(P_{n}\right)_{n \geq 0}$. By [3, (4.2)] (for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ), the regularity conditions for $\mathbf{u}$ are

$$
\left(1-q^{n+a+1}\right)\left(1-q^{n+b+1}\right)\left(1-q^{n+a+b+1}\right) C_{1} \neq 0, \quad n=0,1,2, \ldots
$$

Moreover, by [3, (4.4)-(4.5)] (for $\mathfrak{c}_{3}=0$ and $\mathfrak{c}_{1}=\mathfrak{c}_{2}=1 / 2$ ), we obtain the same expression for $B_{n}$ and

$$
C_{n+1}=\frac{K\left(1-q^{n+1}\right)\left(1-q^{n+a+b+1}\right)\left(1-q^{n+a+1}\right)\left(1-q^{n+b+1}\right)}{\left(1-q^{(2 n+a+b+1) / 2}\right)\left(1-q^{(2 n+a+b+2) / 2}\right)^{2}\left(1-q^{(2 n+a+b+3) / 2}\right)},
$$

where

$$
K=-\frac{q^{-1 / 2} u C_{1}\left(1-q^{(a+b+3) / 2}\right)\left(1-q^{(a+b+2) / 2}\right)^{2}}{\left(1-q^{a+1}\right)\left(1-q^{b+1}\right)\left(1+q^{(a+b+1) / 2}\right)}
$$

After tedious calculations, we can see that this expression for $C_{n+1}$ and (3.29) satisfy (2.10) if and only if

$$
C_{1}=\frac{(1-q)\left(1-q^{a+1}\right)\left(1-q^{b+1}\right)\left(1+q^{(a+b+1) / 2}\right)}{4\left(1-q^{(a+b+3) / 2}\right)\left(1-q^{(a+b+2) / 2}\right)^{2}}
$$

Alternatively, $C_{1}$ follows by taking $n=2$ in (2.10), using $C_{2}$ and $C_{3}$. Note that (2.10) holds for each $n=2,3, \ldots$. Consequently, we obtain
$C_{n+1}=\frac{\left(1-q^{n+1}\right)\left(1-q^{n+a+b+1}\right)\left(1-q^{n+a+1}\right)\left(1-q^{n+b+1}\right)}{4\left(1-q^{(2 n+a+b+1) / 2}\right)\left(1-q^{(2 n+a+b+2) / 2}\right)^{2}\left(1-q^{(2 n+a+b+3) / 2}\right)}=y_{n} z_{n+1} / 4$.
Taking into account that $c_{n}=t_{n} C_{n}$, (3.11)-(3.14) yields

$$
\begin{aligned}
& \widehat{b} q^{-1 / 2}\left(1-q^{(a+b+2) / 2}\right) C_{1}+(r+s) B_{0}-r s=B_{0}^{2}+C_{1} \\
& \begin{aligned}
& \widehat{b} q^{-1}\left(1-q^{(a+b+4) / 2}\right) B_{0} C_{2}-r s\left(B_{0}\right.\left.+B_{1}\right)+2 \alpha\left(B_{0} B_{1}-C_{1}\right)(r+s) \\
&=(2 \alpha-1)\left(\left(B_{0} B_{1}-C_{1}\right)\left(B_{0}+B_{1}\right)+B_{0} C_{2}\right), \\
& \widehat{b} q^{-1}\left(1-q^{(a+b+4) / 2}\right) C_{2}-2 \alpha r s+(2 \alpha-1)\left(r+s-B_{0}-B_{1}\right)\left(B_{0}+B_{1}\right) \\
&= 2 \alpha\left(C_{1}-B_{0} B_{1}\right)+(2 \alpha-1) C_{2}
\end{aligned}
\end{aligned}
$$

Solving firstly the above system for $\widehat{b}, r+s$ and $r s$, and secondly the obtained result for $r$ and $s$, we get $\widehat{b}=u q^{1 / 2}\left(1+q^{-(a+b+2) / 2}\right)$ and
$(r, s) \quad$ or $\quad(s, r) \in\left\{\left(\left(q^{(2 a+1) / 4}+q^{-(2 a+1) / 4}\right) / 2,-\left(q^{(2 b+1) / 4}+q^{-(2 b+1) / 4}\right)\right) / 2\right\}$.
So (3.28) becomes $r_{n}=u\left(1+q^{-(a+b+2) / 2}\right)\left(1-q^{n+(a+b) / 2}\right) q^{(1-n) / 2}$ and $t_{n}=u(1+$ $\left.q^{-(a+b+1) / 2}\right)\left(1-q^{n+(a+b+1) / 2}\right) q^{-n / 2}$. Using (3.29), (2.27) becomes

$$
\begin{equation*}
b_{n}=\left(q^{a / 2}-q^{b / 2}\right) \gamma_{n} \frac{\left(1+q^{n+a+b+1 / 2}\right)}{2\left(1-q^{n+(a+b) / 2}\right)} q^{-(2 a+2 b+1) / 4} \tag{3.31}
\end{equation*}
$$

for each $n=0,1,2, \ldots$. Also, since $c_{n}=t_{n} C_{n}$, we obtain

$$
\begin{equation*}
c_{n}=-\gamma_{n} \frac{\left(1-q^{n+a}\right)\left(1-q^{n+b}\right)\left(1-q^{n+a+b}\right)\left(1+q^{-(a+b+1) / 2}\right)}{4\left(1-q^{n+(a+b-1) / 2}\right)\left(1-q^{n+(a+b) / 2}\right)^{2}} \tag{3.32}
\end{equation*}
$$

for $n=0,1,2, \ldots$. Finally, again after tedious computations, from (3.29), (3.30), (3.31) and (3.32), we see that (2.11) holds. Hence (2.8)-(2.11) also hold. Note that (3.24) may also write as

$$
\mathfrak{a}=\frac{1+\left(q^{-1} \widehat{b} / \widehat{a}\right)^{2}}{2 u\left(1-\left(q^{-1} \widehat{b} / \widehat{a}\right)^{2}\right)}, \quad B_{0}=-2 u \phi^{\prime}(0) \frac{1-\left(q^{-1} \widehat{b} / \widehat{a}\right)}{1+\left(q^{-1} \widehat{b} / \widehat{a}\right)}
$$

Proceeding similarly with the same parameters $a$ and $b$ as defined in (3.27), we obtain the same results with $q$ replaced by $q^{-1}$. Thus

$$
P_{n}(X)=\widehat{P}_{n}^{(a, b)}(X \mid q) \quad \text { or } \quad P_{n}(X)=\widehat{P}_{n}^{(a, b)}\left(X \mid q^{-1}\right)
$$

where $\widehat{P}_{n}^{(a, b)}(\cdot \mid q)$ is the monic continuous $q$-Jacobi polynomial, and this is precisely the second assertion of Theorem 1.3
