# THE BUNDLE OF KMS STATE SPACES FOR FLOWS ON A UNITAL $C^{*}$-ALGEBRA

## 1. Introduction

The collection of KMS state spaces for a flow on a unital $C^{*}$-algebra can be thought of as a bundle of simplices over the real line. This may seem like a far-fetched analogy to other more established notions of bundles because the fibers of the bundle may be empty or they may all be mutually non-isomorphic, but we will show here that it is in fact a well-behaved and useful concept. Specifically, we use it to show that for any given unital separable infinite-dimensional simple AF algebra $A$ and for any configuration of KMS state spaces which occurs for a flow on a unital separable $C^{*}$-algebra and has the property that the simplex of 0-KMS states is affinely homeomorphic to the tracial state space of $A$, there is a flow on $A$ with the same configuration. In particular, it follows that for any given closed subset $F$ of real numbers containing 0 there are flows on $A$ whose KMS spectrum is $F$. This removes the lower boundedness condition which occurs in a recent work by the second author, Th3].

Since we deal with unital AF algebras, there are always 0-KMS states present. For flows on infinite $C^{*}$-algebras this is not the case, and in a joint work with Y. Sato we have shown that for any unital, nuclear, purely infinite, simple, separable $C^{*}$-algebra $A$ in the UCT class and with torsion-free $K_{1}$ group, and for any configuration of KMS state spaces which occurs for a flow on a unital separable $C^{*}$-algebra without trace states, there is also a flow on $A$ with the same configuration; see [EST]. In both cases we depend on results from the classification of simple $C^{*}$-algebras.

While the work in Th3] was based on ideas from [BEH] and [BEK1], in the present paper the underlying ideas are closer to those presented by Bratteli, Elliott and Kishimoto in [BEK2]. In particular, the idea of considering the configuration of KMS simplices as a bundle originates from BEK2].

## 2. Proper simplex bundles

Let $S$ be a second countable locally compact Hausdorff space and $\pi: S \rightarrow \mathbb{R}$ a continuous map. If the inverse image $\pi^{-1}(t)$, equipped with the relative topology inherited from $S$, is homeomorphic to a compact metrizable Choquet simplex for all $t \in \mathbb{R}$ we say that $(S, \pi)$ is a simplex bundle. We emphasize that $\pi$ need not be surjective, and we consider therefore also the empty set as a simplex. When $(S, \pi)$ is a simplex bundle we denote by $\mathcal{A}(S, \pi)$ the set of continuous functions $f: S \rightarrow \mathbb{R}$ with the property that the restriction $\left.f\right|_{\pi^{-1}(t)}$ of $f$ to $\pi^{-1}(t)$ is affine for all $t \in \mathbb{R}$.

Definition 2.1. (Compare BEK2].) A simplex bundle $(S, \pi)$ is a proper simplex bundle when
(1) $\pi$ is proper; that is $\pi^{-1}(K)$ is compact in $S$ when $K \subseteq \mathbb{R}$ is compact, and
(2) $\mathcal{A}(S, \pi)$ separate points on $S$; that is for all $x \neq y$ in $S$ there is an $f \in \mathcal{A}(S, \pi)$ such that $f(x) \neq f(y)$.

Two proper simplex bundles $(S, \pi)$ and ( $S^{\prime}, \pi^{\prime}$ ) are isomorphic when there is a homeomorphism $\phi: S \rightarrow S^{\prime}$ such that $\pi^{\prime} \circ \phi=\pi$ and $\phi$ : $\pi^{-1}(\beta) \rightarrow \pi^{\prime-1}(\beta)$ is affine for all $\beta \in \mathbb{R}$.
2.1. Proper simplex bundles from flows. In this paper all $C^{*}$ algebras are assumed to be separable and all traces and weights on a $C^{*}$-algebra are required to be non-zero, densely defined and lower semi-continuous. Let $A$ be a $C^{*}$-algebra and $\theta$ a flow on $A$. Let $\beta \in \mathbb{R}$. A $\beta$-KMS weight for $\theta$ is a weight $\omega$ on $A$ such that $\omega \circ \theta_{t}=\omega$ for all $t$, and

$$
\begin{equation*}
\omega\left(a^{*} a\right)=\omega\left(\theta_{-\frac{i \beta}{2}}(a) \theta_{-\frac{i \beta}{2}}(a)^{*}\right) \quad \forall a \in D\left(\theta_{-\frac{i \beta}{2}}\right) . \tag{2.1}
\end{equation*}
$$

In particular, a $0-\mathrm{KMS}$ weight for $\theta$ is a $\theta$-invariant trace. A bounded $\beta$ KMS weight is called a $\beta$-KMS functional and a $\beta$-KMS state when it is of norm one. For states alternative formulations of the KMS condition can be found in BR .

Assume that $A$ is unital. For each $\beta \in \mathbb{R}$ let $S_{\beta}^{\theta}$ be the (possibly empty) set of $\beta$-KMS states for $\theta$. Let $E(A)$ be the state space of $A$, a compact convex set in the weak* topology. Set

$$
S^{\theta}=\left\{(\omega, \beta) \in E(A) \times \mathbb{R}: \omega \in S_{\beta}^{\theta}\right\}
$$

and equip $S^{\theta}$ with the relative topology inherited from the product topology of $E(A) \times \mathbb{R}$. Since $S^{\theta}$ is a closed subset of $E(A) \times \mathbb{R}$ by Proposition 5.3.23 of [ BR ], it follows that $S^{\theta}$ is a second countable locally compact Hausdorff space. Denote by $\pi^{\theta}: S^{\theta} \rightarrow \mathbb{R}$ the projection
to the second coordinate. Since the inverse image $\pi^{\theta^{-1}}(\beta)$ is homeomorphic to $S_{\beta}^{\theta}$, which is a Choquet simplex by Theorem 5.3 .30 of $[\mathrm{BR}$, the pair $\left(S^{\theta}, \pi^{\theta}\right)$ is a simplex bundle. An obvious application of Proposition 5.3.23 of $\left[\mathrm{BR}\right.$ ], using the compactness of $E(A)$, shows that $\pi^{\theta}$ is proper. Note that every self-adjoint element $a \in A$ gives rise to an element $\hat{a} \in \mathcal{A}\left(S^{\theta}, \pi^{\theta}\right)$ such that $\hat{a}(\omega, \beta)=\omega(a)$. A continuous function $f: \mathbb{R} \rightarrow \mathbb{R}$ also gives rise to an element of $\mathcal{A}\left(S^{\theta}, \pi^{\theta}\right)$ :

$$
S^{\theta} \ni(\omega, \beta) \mapsto f(\beta) .
$$

It follows that $\mathcal{A}\left(S^{\theta}, \pi^{\theta}\right)$ separates the points of $S^{\theta}$, showing that ( $S^{\theta}, \pi^{\theta}$ ) is a proper simplex bundle, which we shall call the KMS bun$d l e$ of the flow. In general, $\pi^{\theta^{-1}}(0)$ is the set of $\theta$-invariant trace states and hence non-empty if and only if $A$ has trace states. When $A$ is AF it is the simplex of all trace states of $A$.

Remark 2.2. Let $(S, \pi)$ be a proper simplex bundle. Denote by $\mathcal{A}_{\mathbb{R}}(S, \pi)$ the subset of $\mathcal{A}(S, \pi)$ consisting of the elements that have a limit at infinity. This is a separable real Banach space (in the supremum norm) containing the constant function 1 , and its state space

$$
\begin{aligned}
& E\left(\mathcal{A}_{\mathbb{R}}(S, \pi)\right):= \\
& \left\{\omega \in \mathcal{A}_{\mathbb{R}}(S, \pi)^{*}:|\omega(f)| \leq \sup _{x \in S}|f(x)| \quad \forall f \in \mathcal{A}_{\mathbb{R}}(S, \pi), \omega(1)=1\right\}
\end{aligned}
$$

is a metrizable compact convex set in the weak* topology. For $x \in S$, let $\mathrm{ev}_{x} \in E\left(\mathcal{A}_{\mathbb{R}}(S, \pi)\right)$ denote evaluation at $x$. For each $\beta \in \mathbb{R}$, the set

$$
K_{\beta}:=\left\{\operatorname{ev}_{x}: x \in \pi^{-1}(\beta)\right\}
$$

is a closed convex subset of $E\left(\mathcal{A}_{\mathbb{R}}(S, \pi)\right)$. With $K=E\left(\mathcal{A}_{\mathbb{R}}(S, \pi)\right)$, the system $K_{\beta}, \beta \in \mathbb{R}$, has the properties required in Theorem 2.1 of BEK1. Thus, there is a unital, simple, separable, nuclear $C^{*}$-algebra A equipped with a $2 \pi$-periodic flow $\theta$ such that $\pi^{-1}(\beta)$ is affinely homeomorphic to the simplex of $\beta$-KMS states for all $\beta \in \mathbb{R}$. In the construction of $A$ in [BEK1] the algebra appears to depend on $(S, \pi)$ and on the many choices made in the process of its construction, but it was shown in [EST], based on the Kirchberg-Phillips classification result, that when $\pi^{-1}(0)$ is empty one can take $A$ to be any given separable, simple, nuclear, purely infinite $C^{*}$-algebra in the UCT class and with torsion free $K_{1}$ group. It follows from the main result we describe next that when $\pi^{-1}(0)$ is not empty one can take $A$ to be any infinite dimensional unital simple AF algebra whose tracial state space is affinely homeomorphic to $\pi^{-1}(0)$.

## 3. The main result and applications

Theorem 3.1. Let $(S, \pi)$ be a proper simplex bundle and let $A$ be a unital infinite-dimensional simple AF algebra with a tracial state space
affinely homeomorphic to $\pi^{-1}(0)$. There is a $2 \pi$-periodic flow on $A$ whose KMS bundle is isomorphic to $(S, \pi)$.

By definition the KMS spectrum of a flow $\theta$ on a unital $C^{*}$-algebra is the set of real numbers $\beta$ for which $\theta$ has a $\beta$-KMS state. When the KMS bundle of $\theta$ is isomorphic to a proper simplex bundle $(S, \pi)$, the KMS spectrum of $\theta$ is the range $\pi(S)$ of $\pi$.

To exhibit possible ways to work with proper simplex bundles and to illustrate how Theorem 3.1] can be applied let us use it to prove the following statement.

Corollary 3.2. Let $A$ be a unital infinite-dimensional simple AF algebra and let $F$ be a closed subset of real numbers containing 0 .

- There is a $2 \pi$-periodic flow on $A$ whose KMS spectrum is $F$ and such that there is a unique $\beta-K M S$ state for all $\beta \in F \backslash\{0\}$.
- There is a $2 \pi$-periodic flow $\theta$ on $A$ whose KMS spectrum is $F$ and such that $S_{\beta}^{\theta}$ is not affinely homeomorphic to $S_{\beta^{\prime}}^{\theta}$ when $\beta, \beta^{\prime} \in F \backslash\{0\}$ and $\beta \neq \beta^{\prime}$.

Proof. Given a proper simplex bundle $(S, \pi)$, set $S_{F}=\pi^{-1}(F)$ and denote by $\pi_{F}$ the restriction of $\pi$ to $\pi^{-1}(F)$. The pair ( $S_{F}, \pi_{F}$ ) is again a proper simplex bundle.

For the first item, let $T(A)$ be the tracial state space of $A$ and fix an element $\omega_{0} \in T(A)$. Let $S$ be the subset

$$
(T(A) \times\{0\}) \cup\left\{\left(\omega_{0}, t\right): t \in \mathbb{R} \backslash\{0\}\right\}
$$

of the topological product $T(A) \times \mathbb{R}$. Let $\pi: S \rightarrow \mathbb{R}$ be the canonical projection. Then $(S, \pi)$ is a proper simplex bundle such that $\pi^{-1}(\beta)=$ $\left\{\left(\omega_{0}, \beta\right)\right\}$ when $\beta \neq 0$ and such that $\pi^{-1}(0)$ is a copy of $T(A)$. The existence of the desired flow follows from Theorem 3.1 by applying it to the bundle ( $S_{F}, \pi_{F}$ ).

For the second item, note that the KMS bundle of the flow described in Theorem 1.1 of [Th2] is a proper simplex bundle ( $S^{\prime}, \pi^{\prime}$ ) such that $\pi^{\prime-1}(0)$ contains only one point, $\pi^{\prime}(S)=\mathbb{R}$ and such that $\pi^{\prime-1}(\beta)$ is not affinely homeomorphic to $\pi^{\prime-1}\left(\beta^{\prime}\right)$ when $\beta \neq \beta^{\prime}$. With $(S, \pi)$ the bundle defined above set

$$
S^{\prime \prime}=\left\{(x, y) \in S^{\prime} \times S: \pi^{\prime}(x)=\pi(y)\right\}
$$

Define $\pi^{\prime \prime}: S^{\prime \prime} \rightarrow \mathbb{R}$ by $\pi^{\prime \prime}(x, y)=\pi(y)$. Then $\left(S^{\prime \prime}, \pi^{\prime \prime}\right)$ is a proper simplex bundle and an application of Theorem 3.1, this time to $\left(S_{F}^{\prime \prime}, \pi_{F}^{\prime \prime}\right)$, gives the desired flow.

## 4. Proof of the main result

4.1. Tools. The following lemma is an immediate consequence of Lemma 3.1 of [Th3] and Theorem 2.4 of [Th1].

Lemma 4.1. Let $D$ be a $C^{*}$-algebra. Denote by $\rho \in \operatorname{Aut}(D)$ an automorphism of $D$ and let $q \in D$ a projection in $D$ which is ful in $D \rtimes_{\rho} \mathbb{Z}$. Let $\hat{\rho}$ denote the restriction to $q\left(D \rtimes_{\rho} \mathbb{Z}\right) q$ of the dual action on $D \rtimes_{\rho} \mathbb{Z}$ considered as a $2 \pi$-periodic flow. Let $P: D \rtimes_{\rho} \mathbb{Z} \rightarrow D$ denote the canon$i$ cal conditional expectation. For each $\beta \in \mathbb{R}$, the map $\left.\tau \mapsto \tau \circ P\right|_{q\left(D \rtimes_{\rho} \mathbb{Z}\right) q}$ is an affine homeomorphism from the set of traces $\tau$ on $D$ that satisfy

$$
\begin{equation*}
\tau \circ \rho=e^{-\beta} \tau \text { and } \tau(q)=1 \tag{4.1}
\end{equation*}
$$

onto the simplex of $\beta-K M S$ states for $\hat{\rho}$.
In this lemma the topology on the set of traces of $D$ with the properties (4.1) is given by pointwise convergence on elements from the corner $q D q$ of $D$.

When $D$ is an AF algebra it is well-known that the set of its traces can be identified, via the map $\tau \mapsto \tau_{*}$, with the set $\operatorname{Hom}^{+}\left(K_{0}(D), \mathbb{R}\right)$ of non-zero positive homomorphisms $\phi: K_{0}(D) \rightarrow \mathbb{R}$; a fact stated as Lemma 3.5 in [Th3]. In the setting of Lemma 4.1 this implies that when $D$ is an AF algebra the KMS spectrum and the structure of the KMS states for $\hat{\rho}$ can be determined directly from the pair ( $K_{0}(D), \rho_{*}$ ). To see how, we note that by Remark 3.3 in [LN] every $\beta$-KMS state $\tau$ for $\hat{\rho}$ on $q\left(D \rtimes_{\rho} \mathbb{Z}\right) q$ extends uniquely to a $\beta$-KMS weight $\hat{\tau}$ for the dual action. Since $D$ is the fixed point algebra for the dual action the restriction of $\hat{\tau}$ to $D$ is a trace on $D$, yielding a map

$$
\begin{equation*}
\tau \mapsto\left(\left.\hat{\tau}\right|_{D}\right)_{*} \tag{4.2}
\end{equation*}
$$

from the set of $\beta$-KMS states $\tau$ for $\hat{\rho}$ to $\operatorname{Hom}^{+}\left(K_{0}(D), \mathbb{R}\right)$. Therefore Lemma 4.1 has the following consequence.

Corollary 4.2. In the setting of Lemma 4.1 assume that $D$ is an $A F$ algebra. For each $\beta \in \mathbb{R}$ the map (4.2) is an affine homeomorphism from the set of $\beta$-KMS states for $\hat{\rho}$ on $q\left(D \rtimes_{\gamma} \mathbb{Z}\right) q$ onto the set of positive homomorphisms $\phi \in \operatorname{Hom}^{+}\left(K_{0}(D), \mathbb{R}\right)$ that satisfy

$$
\begin{equation*}
\phi \circ \rho_{*}=e^{-\beta} \phi \text { and } \phi([q])=1 . \tag{4.3}
\end{equation*}
$$

Here the topology on the elements from $\operatorname{Hom}^{+}\left(K_{0}(D), \mathbb{R}\right)$ with the properties (4.3) is given by pointwise convergence on $\left\{x \in K_{0}(D): 0 \leq\right.$ $x \leq[q]\}$.

Corollary 4.2 will be complemented by the following lemma which helps to control the Elliott invariant of $q\left(D \rtimes_{\gamma} \mathbb{Z}\right) q$, and to ensure that it is classified by it. It follows from Lemma 3.4 of [Th3], which is based on arguments from [Sa, MS1 and MS2].

[^1]Lemma 4.3. Let $D$ be a stable AF algebra such that $K_{0}(D)$ has large denominators ${ }^{2}$ For any order automorphism $\alpha \in \operatorname{Aut}\left(K_{0}(D)\right)$ of $K_{0}(D)$ there is an automorphism $\gamma \in \operatorname{Aut}(D)$ of $D$ such that
(a) $\gamma_{*}=\alpha$ on $K_{0}(D)$,
(b) the restriction map $\left.\mu \mapsto \mu\right|_{D}$ is a bijection from traces $\mu$ on $D \rtimes_{\gamma} \mathbb{Z}$ onto the $\gamma$-invariant traces on $D$, and
(c) $D \rtimes_{\gamma} \mathbb{Z}$ is $\mathcal{Z}$-stable; that is, $\left(D \rtimes_{\gamma} \mathbb{Z}\right) \otimes \mathcal{Z} \simeq D \rtimes_{\gamma} \mathbb{Z}$ where $\mathcal{Z}$ denotes the Jiang-Su algebra, [JS].

Given a proper simplex bundle $(S, \pi)$ and a closed subset $F \subseteq \mathbb{R}$ we denote by $\left(S_{F}, \pi_{F}\right)$ the proper simplex bundle with $S_{F}=\pi^{-1}(F)$ and $\pi_{F}$ is the restriction of $\pi$ to $S_{F}$. The following lemma relates $\mathcal{A}\left(S_{F}, \pi_{F}\right)$ to $\mathcal{A}(S, \pi)$ and it will be a crucial tool in the following.

Lemma 4.4. Let $(S, \pi)$ be a proper simplex bundle and $F \subseteq \mathbb{R}$ a closed subset.
(1) The map $\mathcal{A}(S, \pi) \rightarrow \mathcal{A}\left(S_{F}, \pi_{F}\right)$ given by restriction is surjective.
(2) Let $f_{1}, f_{2}, g_{1}, g_{2} \in \mathcal{A}(S, \pi)$ such that $f_{i}(x)<g_{j}(x)$ for all $x \in S$ and all $i, j \in\{1,2\}$. Assume that there is an element $h^{F} \in$ $\mathcal{A}\left(S_{F}, \pi_{F}\right)$ such that

$$
f_{i}(x)<h^{F}(x)<g_{j}(x) \quad \forall x \in S_{F}, \forall i, j \in\{1,2\} .
$$

There is an element $h \in \mathcal{A}(S, \pi)$ such that $h(y)=h^{F}(y)$ for all $y \in S_{F}$ and

$$
f_{i}(x)<h(x)<g_{j}(x) \quad \forall x \in S, \forall i, j \in\{1,2\} .
$$

Proof. (1) Let $h \in \mathcal{A}\left(S_{F}, \pi_{F}\right)$. For each $n \in \mathbb{N}$ the pair $\left(S_{[-n, n]}, \pi_{[-n, n]}\right)$ is a compact simplex bundle in the sense of [BEK2] and it follows from Lemma 2.2 in [BEK2] that there are elements $f_{n} \in \mathcal{A}\left(S_{[-n, n]}, \pi_{[-n, n]}\right)$ such that the restriction $\left.f_{n}\right|_{S_{F \cap[-n, n]}}$ of $f_{n}$ to $S_{F \cap[-n, n]}$ agrees with $\left.h\right|_{S_{F \cap[-n, n]}}$. For $n \in \mathbb{N}$ choose a continuous function $\chi_{n}: \mathbb{R} \rightarrow[0,1]$ such that $\chi_{n}(t)=1$ for $t \leq n-\frac{1}{2}$ and $\chi_{n}(t)=0$ for $t \geq n$. Define $f_{n}^{\prime}: S_{[-n, n]} \rightarrow \mathbb{R}$ recursively by

$$
f_{1}^{\prime}(x)=\left(1-\chi_{1}(|\pi(x)|)\right) f_{2}(x)+\chi_{1}(|\pi(x)|) f_{1}(x)
$$

and then $f_{n}^{\prime}$ for $n \geq 2$ such that $f_{n}^{\prime}(x)=f_{n-1}^{\prime}(x)$ when $x \in \pi^{-1}([-n+$ $1, n-1])$ and $f_{n}^{\prime}(x)=\left(1-\chi_{n}(|\pi(x)|)\right) f_{n+1}(x)+\chi_{n}(|\pi(x)|) f_{n}(x)$ when $x \in \pi^{-1}([n-1, n] \cup[-n,-n+1])$. Then $\left.f_{n}^{\prime}\right|_{S_{F \cap[-n, n]}}=\left.h\right|_{S_{F \cap[-n, n]}}$ and since $f_{n+1}^{\prime}$ extends $f_{n}^{\prime}$ for all $n$, there is an element $f \in \mathcal{A}(S, \pi)$ such that $\left.f\right|_{S_{[-n, n]}}=f_{n}^{\prime}$. This element $f$ extends $h$.

The assertion (2) follows in a similar way on using Lemma 2.3 in BEK2.

[^2]4.2. Dimension groups from proper simplex bundles. Given a Choquet simplex $\Delta$, as usual denote by Aff $\Delta$ the set of real-valued continuous and affine functions on $\Delta$. Fix a proper simplex bundle $(S, \pi)$ with $\pi^{-1}(0)$ non-empty. Let $H$ be a torsion free abelian group and $\theta: H \rightarrow \operatorname{Aff} \pi^{-1}(0)$ a homomorphism. We assume
(1) there is an element $u \in H$ such that $\theta(u)=1$, and
(2) $\theta(H)$ is dense in $\mathrm{Aff} \pi^{-1}(0)$.

Set

$$
H^{+}=\left\{h \in H: \theta(h)(x)>0 \quad \forall x \in \pi^{-1}(0)\right\} \cup\{0\} .
$$

Then $\left(H, H^{+}\right)$is a simple dimension group; see EHS.
It follows from (1) of Lemma4.4 that the map $r: \mathcal{A}(S, \pi) \rightarrow \mathrm{Aff} \pi^{-1}(0)$ given by restriction is surjective and we can therefore choose a linear map $L: \operatorname{Aff} \pi^{-1}(0) \rightarrow \mathcal{A}(\pi, S)$ such that $r \circ L=i d$. We arrange, as we can, that $L(1)=1$. Define $\hat{L}: \oplus_{\mathbb{Z}} H \rightarrow \mathcal{A}(S, \pi)$ by

$$
\hat{L}\left(\left(h_{n}\right)_{n \in \mathbb{Z}}\right)(x)=\sum_{n \in \mathbb{Z}} L\left(\theta\left(h_{n}\right)\right)(x) e^{n \pi(x)} .
$$

Let $\mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right]$ denote the $\mathbb{Q}$-linear span of the functions defined on $S \backslash \pi^{-1}(0)$ by

$$
\begin{equation*}
x \mapsto e^{n \pi(x)}\left(1-e^{-\pi(x)}\right)^{l} \tag{4.4}
\end{equation*}
$$

for some $n, l \in \mathbb{Z}$. For each $k \in \mathbb{N}$, choose continuous functions $\psi_{k}^{0}, \psi_{k}^{ \pm}$: $\mathbb{R} \rightarrow[0,1]$ such that

$$
\begin{aligned}
& \psi_{k}^{0}(t)=1,-\frac{1}{2 k} \leq t \leq \frac{1}{2 k}, \\
& \psi_{k}^{-}(t)=1, t \leq-\frac{1}{k}, \\
& \psi_{k}^{+}(t)=1, t \geq \frac{1}{k}, \text { and } \\
& \psi_{k}^{-}(t)+\psi_{k}^{0}(t)+\psi_{k}^{+}(t)=1 \text { for all } t \in \mathbb{R} .
\end{aligned}
$$

Consider the countable subgroup of $\mathcal{A}(S, \pi)$

$$
G_{k}:=\mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right] \psi_{k}^{-} \circ \pi+\hat{L}\left(\bigoplus_{\mathbb{Z}} H\right) \psi_{k}^{0} \circ \pi+\mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right] \psi_{k}^{+} \circ \pi .
$$

In what follows we denote the support of a real-valued function $f$ by $\operatorname{supp} f$. Let $\mathcal{A}_{00}(S, \pi)$ denote the set of elements $f$ from $\mathcal{A}(S, \pi)$ for which $\operatorname{supp} f$ is compact and contained in $S \backslash \pi^{-1}(0)$. Since the topology of $S$ is second countable we can choose a countable subgroup $G_{00}$ of $\mathcal{A}_{00}(S, \pi)$ with the following density property:

Property 4.5. For all $N \in \mathbb{N}$, all $\epsilon>0$ and all $f \in \mathcal{A}_{00}(S, \pi)$ with $\operatorname{supp} f \subseteq$ $\pi^{-1}(]-N, N[\backslash\{0\})$, there is $g \in G_{00}$ such that

$$
\sup _{x \in S}|f(x)-g(x)|<\epsilon
$$

and $\operatorname{supp} g \subseteq \pi^{-1}(]-N, N[\backslash\{0\})$.
When $f_{1} \in \hat{L}\left(\oplus_{\mathbb{Z}} H\right)$ and $f_{2}^{ \pm} \in \mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right]$ the difference between

$$
f_{2}^{-} \psi_{k}^{-} \circ \pi+f_{1} \psi_{k}^{0} \circ \pi+f_{2}^{+} \psi_{k}^{+} \circ \pi
$$

and

$$
f_{2}^{-} \psi_{k+1}^{-} \circ \pi+f_{1} \psi_{k+1}^{0} \circ \pi+f_{2}^{+} \psi_{k+1}^{+} \circ \pi
$$

is an element of $\mathcal{A}_{00}(S, \pi)$, and so by enlarging $G_{00}$ we can ensure that

$$
\begin{equation*}
G_{k}+G_{00} \subseteq G_{k+1}+G_{00} . \tag{4.5}
\end{equation*}
$$

Let $\alpha_{0} \in \operatorname{Aut} \mathcal{A}(S, \pi)$ be defined by

$$
\alpha_{0}(f)(x)=e^{-\pi(x)} f(x) .
$$

Since $\alpha_{0}\left(\mathcal{A}_{00}\right)=\mathcal{A}_{00}$ and since $\left(1-e^{-\pi}\right)^{-1} \mathcal{A}_{00}(S, \pi) \subseteq \mathcal{A}_{00}(S, \pi)$, we can enlarge $G_{00}$ further to achieve that

$$
\begin{equation*}
\alpha_{0}\left(G_{00}\right)=G_{00} \tag{4.6}
\end{equation*}
$$

and that

$$
\begin{equation*}
\left(\mathrm{id}-\alpha_{0}\right)\left(G_{00}\right)=G_{00} \tag{4.7}
\end{equation*}
$$

We define

$$
G=\bigcup_{k=1}^{\infty}\left(G_{k}+G_{00}\right)
$$

Let $\sigma \in \operatorname{Aut}\left(\oplus_{n \in \mathbb{Z}} H\right)$ denote the shift:

$$
\sigma\left(\left(h_{n}\right)_{n \in \mathbb{Z}}\right)=\left(h_{n+1}\right)_{n \in \mathbb{Z}} .
$$

Then $\alpha_{0} \circ \hat{L}=\hat{L} \circ \sigma$, which implies that $\alpha_{0}\left(G_{k}\right)=G_{k}$ and hence

$$
\alpha_{0}(G)=G .
$$

Set

$$
\mathcal{A}(S, \pi)^{+}=\{f \in \mathcal{A}(S, \pi): f(x)>0 \forall x \in S\} \cup\{0\}
$$

and

$$
G^{+}=G \cap \mathcal{A}(S, \pi)^{+} .
$$

Lemma 4.6. The pair $\left(G, G^{+}\right)$has the following properties.
(1) $G^{+} \cap\left(-G^{+}\right)=\{0\}$.
(2) $G=G^{+}-G^{+}$.
(3) $\left(G, G^{+}\right)$is unperforated, i.e., $n \in \mathbb{N} \backslash\{0\}, g \in G, n g \in G^{+} \Rightarrow g \in$ $G^{+}$.
(4) $\left(G, G^{+}\right)$has the strong Riesz interpolation property, i.e. if $f_{1}, f_{2}, g_{1}, g_{2} \in$ $G$ and $f_{i}<g_{j}$ in $G$ for all $i, j \in\{1,2\}$, then there is an element $h \in G$ such that

$$
f_{i}<h<g_{j}
$$

for all $i, j \in\{1,2\}$.
Proof. (1) and (3) are obvious. (2): Let $f \in G$. Then $f \in G_{k}+G_{00}$ for some $k \in \mathbb{N}$ and we can write

$$
f=h^{-} \psi_{k}^{-} \circ \pi+f_{0} \psi_{k}^{0} \circ \pi+h^{+} \psi_{k}^{0} \circ \pi+g
$$

where $h^{ \pm} \in \mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right], f_{0} \in \hat{L}\left(\oplus_{\mathbb{Z}} H\right)$ and $g \in G_{00}$. By definition of $\mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right]$ there are $n, m \in \mathbb{N}$ and $M>0$ such that

$$
\left.\left.h^{-}(x) \leq e^{-n \pi(x)} \quad \forall x \in \pi^{-1}(]-\infty,-M\right]\right),
$$

and

$$
h^{+}(x) \leq e^{m \pi(x)} \quad \forall x \in \pi^{-1}([M, \infty[) .
$$

Since $f_{0} \psi_{k}^{0} \circ \pi$ and $g$ are compactly supported there is $K \in \mathbb{N}$ such that $f(x)<g(x)$ for all $x \in S$, where

$$
g=K\left(e^{-n \pi} \psi_{k}^{-} \circ \pi+\psi_{k}^{0} \circ \pi+e^{m \pi} \psi_{k}^{+} \circ \pi\right) \in G^{+} .
$$

Note that $f=g-(g-f) \in G^{+}-G^{+}$.
(4): Since $\theta(H)$ has the Riesz interpolation property for the strict order by Lemma 3.1 in [EHS, there is $h_{0} \in \theta(H)$ such that $f_{i}(x)<$ $h_{0}(x)<g_{j}(x)$ for all $i, j$ and all $x \in \pi^{-1}(0)$. We claim that there are elements $h^{ \pm} \in \mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right]$ and $K^{ \pm} \in \mathbb{N}$ such that $f_{i}(x)<h^{-}(x)<g_{j}(x)$ when $\pi(x) \leq-K^{-}$and $f_{i}(x)<h^{+}(x)<g_{j}(x)$ when $\pi(x) \geq K^{+}$. To find $h^{+}$and $K^{+}$, note that we may assume that $\pi(S)$ contains arbitrarily large positive numbers; otherwise we take $K^{+}$larger that $\sup \pi(S)$ and $h^{+}=0$. By definition of $G$ there is $N \in \mathbb{N}$ so large that there are polynomials $p_{1}, p_{2}, q_{1}, q_{2}$ with rational coefficients such that

$$
\left(e^{\pi(x)}\left(e^{\pi(x)}-1\right)\right)^{N} f_{i}(x)=p_{i}\left(e^{\pi(x)}\right)
$$

and

$$
\left(e^{\pi(x)}\left(e^{\pi(x)}-1\right)\right)^{N} g_{j}(x)=q_{j}\left(e^{\pi(x)}\right)
$$

for all $i, j$ and all large $x$. Then $p_{i}(y)<q_{j}(y)$ for all large elements $y$ of $e^{\pi(S)}$ and it follows therefore from Lemma 4.7 that there is a polynomial $h^{\prime}$ with rational coefficients such that $p_{i}(x)<h^{\prime}(x)<q_{j}(x)$ for all $i, j$ and all large $x$. Set

$$
h^{+}(x)=\left(e^{\pi(x)}\left(e^{\pi(x)}-1\right)\right)^{-N} h^{\prime}\left(e^{\pi(x)}\right) .
$$

Then $h^{+} \in \mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right]$ and if $K^{+}$is large enough $f_{i}(x)<h^{+}(x)<g_{j}(x)$ for all $i, j$ and all $x \in \pi^{-1}\left(\left[K^{+}, \infty\right)\right)$. The pair $h^{-}, K^{-}$is constructed in a similar way: Multiply each of the functions from $\left\{f_{1}, f_{2}, g_{1}, g_{2}\right\}$ with the same function of the form

$$
\left(e^{-\pi}\right)^{N}\left(e^{-\pi}-1\right)^{N}
$$

to get them into the form $x \mapsto p\left(e^{-\pi(x)}\right)$ for $p$ a polynomial with rational coefficients and apply Lemma 4.7.

Having $h^{ \pm}$and $K^{ \pm}$we use the statement (2) of Lemma 4.4 to find $H \in \mathcal{A}(S, \pi)$ such that $H(x)=h^{-}(x)$ when $\pi(x) \leq-K^{-}, H(x)=h^{+}(x)$ when $\pi(x) \geq K^{+}, H(x)=h_{0}(x)$ when $x \in \pi^{-1}(0)$, and $f_{i}(x)<H(x)<$ $g_{j}(x)$ for all $x \in S$ and all $i, j$. Set

$$
H^{\prime}(x)=H \psi_{k}^{-} \circ \pi+L\left(h_{0}\right) \psi_{k}^{0} \circ \pi+H \psi_{k}^{+} \circ \pi .
$$

If $k$ is large enough we have

$$
f_{i}(x)<H^{\prime}(x)<g_{j}(x)
$$

for all $x \in S$ and all $i, j$. Set

$$
H^{\prime \prime}(x)=H^{\prime}(x)-L\left(h_{0}\right) \psi_{k}^{0} \circ \pi-h^{-} \psi_{k}^{-} \circ \pi-h^{+} \psi_{k}^{+} \circ \pi,
$$

and note that $\left.\sup H^{\prime \prime} \subseteq\right]-K^{-}, K^{+}\left[\backslash\{0\}\right.$. Set $K=\max \left\{K^{-}, K^{+}\right\}$and let $\delta>0$ be given, smaller than $g_{j}(x)-H^{\prime}(x)$ and $H^{\prime}(x)-f_{i}(x)$ for all $i, j$ and all $x \in \pi^{-1}([-K, K])$. By Property 4.5 there is an element $g^{\prime} \in G_{00}$ such that

$$
\operatorname{supp} g^{\prime} \subseteq \pi^{-1}(]-K, K[\backslash\{0\})
$$

and $\sup _{x \in S}\left|g^{\prime}(x)-H^{\prime \prime}(x)\right|<\frac{\delta}{2}$. Then

$$
h=g^{\prime}+L\left(h_{0}\right) \psi_{k}^{0} \circ \pi+h^{-} \psi_{k}^{-} \circ \pi+h^{+} \psi_{k}^{+} \circ \pi \in G
$$

and $f_{i}(x)<h(x)<g_{j}(x)$ for all $i, j$ and all $x \in S$.
Lemma 4.7. Let $p_{i}, q_{j}, i, j \in\{1,2\}$, be polynomials with rational coefficients. Assume that there is a sequence $\left\{x_{n}\right\}$ in $\mathbb{R}$ such that $\lim _{n \rightarrow \infty} x_{n}=$ $\infty$ and such that $p_{i}\left(x_{n}\right)<q_{j}\left(x_{n}\right)$ for all $i, j, n$. It follows that there is a polynomial $h$ with rational coefficients and a $K>0$ such that

$$
p_{i}(x)<h(x)<q_{j}(x)
$$

for all $i, j \in\{1,2\}$ and all $x \geq K$.
Proof. Since polynomials only have finitely many zeros there is a $K^{\prime}>0$ such that $p_{i}(x)<q_{j}(x)$ for all $i, j$ and all $x \geq K^{\prime}$. Write $q_{j}(x)=$ $a_{0, j}+a_{1, j} x+a_{2, j} x^{2}+\cdots+a_{N, j} x^{N}$ and $p_{i}(x)=b_{0, j}+b_{1, j} x+b_{2, j} x^{2}+\cdots+b_{N, j} x^{N}$ for some $N$ larger than the degree of any of the four given polynomials, and set

$$
\xi_{i}=\left(b_{N, i}, b_{N-1, i}, \cdots, b_{0, i}\right) \in \mathbb{Q}^{N+1}
$$

and

$$
\eta_{j}=\left(a_{N, j}, a_{N-1, j}, \cdots, a_{0, j}\right) \in \mathbb{Q}^{N+1} .
$$

Since $p_{i}(x)<q_{j}(x)$ for all large $x$, we have that $\xi_{i}<_{\text {lex }} \eta_{j}$ for all $i, j$ with respect to the lexicographic order <lex. Since $\mathbb{Q}^{N+1}$ is totally ordered in the lexicographic order there is an element $c=\left(c_{N}, c_{N-1}, c_{N-2}, \cdots, c_{0}\right) \in$ $\mathbb{Q}^{N+1}$ such that $\xi_{i}<_{l e x} c<_{l e x} \eta_{j}$ for all $i, j$. By changing $c_{0}$ by a small amount we can arrange that $c \notin\left\{\xi_{1}, \xi_{2}, \eta_{1}, \eta_{2}\right\}$. Then the polynomial

$$
h(x)=c_{0}+c_{1} x+c_{2} x^{2}+\cdots+c_{N} x^{N}
$$

will have the desired property.
Consider the subset $\Gamma$ of $\left(\oplus_{\mathbb{Z}} H\right) \oplus G$ consisting of the elements $(\xi, g) \in\left(\oplus_{\mathbb{Z}} H\right) \oplus G$ with the property that there is an $\epsilon>0$ such that

$$
\begin{equation*}
\hat{L}(\xi)(x)=g(x) \quad \forall x \in \pi^{-1}(]-\epsilon, \epsilon[) . \tag{4.8}
\end{equation*}
$$

$\Gamma$ is a subgroup of $\left(\oplus_{\mathbb{Z}} H\right) \oplus G$.
Lemma 4.8. The projection $\Gamma \rightarrow G$ is surjective.
Proof. Let $g \in G$. By definition of $G$ there is an element $\xi \in \oplus_{\mathbb{Z}} H$ and $k \in \mathbb{N}$ such that $g(x)=\hat{L}(\xi)$ on $\pi^{-1}(]-\frac{1}{2 k}, \frac{1}{2 k}[$.

Set

$$
\Gamma^{+}=\left\{(\xi, g) \in \Gamma: g \in G^{+} \backslash\{0\}\right\} \cup\{0\}
$$

By combining Lemma 4.8 and Lemma 4.6 above with Lemma 3.1 and Lemma 3.2 in EHS we conclude that $\left(\Gamma, \Gamma^{+}\right)$is a dimension group.

Given an element $h \in H$ we denote in the following by $h^{(0)}$ the element of $\oplus_{\mathbb{Z}} H$ defined by $\left(h^{(0)}\right)_{0}=h$ and $\left(h^{(0)}\right)_{n}=0$ when $n \neq 0$. Define $\Sigma: \oplus_{\mathbb{Z}} H \rightarrow H$ by

$$
\Sigma\left(\left(h_{n}\right)_{n \in \mathbb{Z}}\right)=\sum_{n \in \mathbb{Z}} h_{n} .
$$

Lemma 4.9. $\left(\Gamma, \Gamma^{+}\right)$has large denominators; that is for all $x \in \Gamma^{+}$and $m \in \mathbb{N}$ there is an element $y \in \Gamma^{+}$and an $n \in \mathbb{N}$ such that $m y \leq x \leq n y$.

Proof. Let $x=(\xi, g) \in \Gamma^{+} \backslash\{0\}$ and $m \in \mathbb{N}$ be given. Then $\Sigma(\xi) \in H^{+} \backslash\{0\}$ and since $H$ has large denominators by [Ni], there is an element $b \in H^{+}$ such that $m b<\Sigma(\xi)<n b$ for some $n \in \mathbb{N}, n>m+2$. Since $L(\theta(\Sigma(\xi)))$ agrees with $g$ on $\pi^{-1}(0)$, there is a compact neighborhood $U$ of 0 such that

$$
m L(\theta(b))(x)<g(x)<n L(\theta(b))(x)
$$

for all $x \in \pi^{-1}(U)$. There is also a $K \in \mathbb{N}$ such that $\left.U \subseteq\right]-K, K[$ and functions $f^{ \pm} \in \mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right]$ such that $g(x)=f^{-}(x), x \leq-K$, and $g(x)=f^{+}(x), x \geq K$. It follows from (2) of Lemma 4.4 that there is an element $a \in \mathcal{A}(S, \pi)$ such that

$$
\begin{aligned}
& \frac{1}{n} g(x)<a(x)<\frac{1}{m} g(x) \quad \forall x \in S, \\
& a(x)=L(\theta(b))(x) \text { for all } x \in \pi^{-1}(U), \\
& a(x)=\frac{1}{m_{m}+1} f^{-}(x) \text { for } x \leq-K, \text { and } \\
& a(x)=\frac{1}{m+1} f^{+}(x) \text { for all } x \geq K .
\end{aligned}
$$

Choose $k \in \mathbb{N}$ so large that $\left[-\frac{1}{k}, \frac{1}{k}\right] \subseteq U$ and note that

$$
a(x)=L(\theta(b))(x) \psi_{k}^{0} \circ \pi(x)+a(x) \psi_{k}^{+} \circ \pi(x)+a(x) \psi_{k}^{-} \circ \pi(x) .
$$

Then the function

$$
a^{\prime}:=a-L(\theta(b)) \psi_{k}^{0} \circ \pi-\frac{1}{m+1} f^{+} \psi_{k}^{+} \circ \pi-\frac{1}{m+1} f^{-} \psi_{k}^{-} \circ \pi
$$

is supported in $]-K, K\left[\backslash\{0\}\right.$. Let $\delta>0$ be smaller than $\frac{1}{m} g(x)-a(x)$ and $a(x)-\frac{1}{n} g(x)$ for all $x \in \pi^{-1}([-K, K])$. By Property 4.5 we can find $c \in G_{00}$ such that $\left.\operatorname{supp} c \subseteq\right]-K, K\left[\backslash\{0\}\right.$ and $\left|c(x)-a^{\prime}(x)\right|<\delta$ for all $x \in S$. Then

$$
g^{\prime}:=c+L(\theta(b)) \psi_{k}^{0} \circ \pi+\frac{1}{m+1} f^{+} \psi_{k}^{+} \circ \pi+\frac{1}{m+1} f^{-} \psi_{k}^{-} \circ \pi \in G
$$

and $m g^{\prime}(x)<g(x)<n g^{\prime}(x)$ for all $x \in S$. It follows that $y=\left(b^{(0)}, g\right) \in$ $\Gamma^{+}$has the desired property.

Since $\hat{L} \circ \sigma=\alpha_{0} \circ \hat{L}$ we can define $\alpha \in \operatorname{Aut} \Gamma$ by

$$
\alpha=\sigma \oplus \alpha_{0}
$$

Lemma 4.10. The only order ideals $I$ in $\Gamma$ such that $\alpha(I)=I$ are $I=\{0\}$ and $I=\Gamma$.

Proof. Recall that an order ideal $I$ in $\Gamma$ is a subgroup such that
(a) $I=I \cap \Gamma^{+}-I \cap \Gamma^{+}$, and
(b) when $0 \leq y \leq x$ in $\Gamma$ and $x \in I$, then $y \in I$.

Let $I$ be a non-zero order ideal such that $\alpha(I)=I$. Since $I \cap \Gamma^{+} \neq\{0\}$ there is an element $g \in G^{+} \backslash\{0\}$ and an element $\xi \in \oplus_{n \in \mathbb{Z}} H$ such that $(\xi, g) \in I$. Set $h=\Sigma(\xi)$. By definition of $G^{+} \backslash\{0\}$ there are natural numbers $n, m, k, K \in \mathbb{N}$ such that the function

$$
g^{\prime}=L(\theta(h)) \psi_{k}^{0} \circ \pi+e^{n \pi} \psi_{k}^{-} \circ \pi+e^{-m \pi} \psi_{k}^{+} \circ \pi
$$

has the property that

$$
0<g^{\prime}(x)<K g(x) \quad \forall x \in S .
$$

It follows that $\left(h^{(0)}, g^{\prime}\right) \in I \cap \Gamma^{+}$. Note that

$$
\alpha_{0}^{l}\left(g^{\prime}\right)=e^{-l \pi} L(\theta(h)) \psi_{k}^{0} \circ \pi+e^{(n-l) \pi} \psi_{k}^{-} \circ \pi+e^{-(m+l) \pi} \psi_{k}^{+} \circ \pi
$$

for all $l \in \mathbb{Z}$. Consider an arbitrary element $\left(\xi^{\prime}, f\right) \in \Gamma^{+} \backslash\{0\}$. We can then find $l_{1}, l_{2} \in \mathbb{Z}$ and $M \in \mathbb{N}$ such that

$$
f(x)<M\left(\alpha_{0}^{l_{1}}\left(g^{\prime}\right)(x)+\alpha_{0}^{l_{2}}\left(g^{\prime}\right)(x)\right) \quad \forall x \in S .
$$

Since

$$
\alpha^{l_{1}}\left(\left(h^{(0)}, g^{\prime}\right)\right)+\alpha^{l_{2}}\left(\left(h^{(0)}, g^{\prime}\right)\right) \in I \cap \Gamma^{+},
$$

it follows that $\left(\xi^{\prime}, f\right) \in I$ and we conclude therefore that $I=\Gamma$.
4.3. Some homomorphisms $\Gamma \rightarrow \mathbb{R}$. Note that the constant function 1 is in $G$ and that, with $v:=\left(u^{(0)}, 1\right), v \in \Gamma^{+}$. Let $\beta \in \mathbb{R}$ and $\omega \in \pi^{-1}(\beta)$. As in Remark 2.2 we denote in the sequel by $\mathcal{A}_{\mathbb{R}}(S, \pi)$ the real Banach space consisting of the elements of $\mathcal{A}(S, \pi)$ that have a limit at infinity.
Lemma 4.11. Let $f \in \mathcal{A}_{\mathbb{R}}(S, \pi)$ and let $\epsilon>0$ be given. There is an element $g \in G$ such that $\sup _{x \in S}|f(x)-g(x)| \leq \epsilon$.

Proof. An initial approximation gives us an element $f_{1} \in \mathcal{A}(S, \pi)$ which is compactly supported and a real number $r \in \mathbb{R}$ such that

$$
\sup _{x \in S}\left|f(x)-f_{1}(x)-r\right| \leq \frac{\epsilon}{2} .
$$

Let $q \in \mathbb{Q}$ such that $|q-r|<\frac{\epsilon}{6}$ and choose an element $h \in H$ such that $\left|\theta(h)(y)-f_{1}(y)-r\right|<\frac{\epsilon}{6}$ for all $y \in \pi^{-1}(0)$. There is a $k \in \mathbb{N}$ such that $\left|L(\theta(h))(x)-f_{1}(x)-r\right|<\frac{\epsilon}{6}$ for all $x \in \pi^{-1}\left(\left[-\frac{1}{k}, \frac{1}{k}\right]\right)$. Since $f_{1} \psi_{k}^{+} \circ \pi+f_{1} \psi_{k}^{-} \circ \pi$ is compactly supported in $S \backslash \pi^{-1}(0)$ it follows from Property 4.5 that there is an element $g^{\prime} \in G_{00}$ such that

$$
\sup _{x \in S}\left|g^{\prime}(x)-f_{1}(x) \psi_{k}^{+} \circ \pi(x)-f_{1}(x) \psi_{k}^{-} \circ \pi(x)\right| \leq \frac{\epsilon}{6}
$$

Then

$$
g=L(\theta(h)) \psi_{k}^{0} \circ \pi+q \psi_{k}^{+} \circ \pi+q \psi_{k}^{-} \circ \pi+g^{\prime} \in G
$$

is an element with the desired property.
Let $\beta \in \mathbb{R}$. For each $\omega \in \pi^{-1}(\beta)$, define $\omega_{\beta}: \Gamma \rightarrow \mathbb{R}$ by

$$
\omega_{\beta}(\xi, g)=g(\omega) .
$$

Then $\omega_{\beta}\left(\Gamma^{+}\right) \subseteq[0, \infty), \omega_{\beta}(v)=1$, and $\omega_{\beta} \circ \alpha=e^{-\beta} \omega_{\beta}$.
Lemma 4.12. Let $\phi: \Gamma \rightarrow \mathbb{R}$ be a positive homomorphism with the properties that $\phi(v)=1$ and $\phi \circ \alpha=s \phi$ for some $s>0$. Set $\beta=-\log s$. There is an element $\omega \in \pi^{-1}(\beta)$ such that $\phi=\omega_{\beta}$.

Proof. The projection $p: \Gamma \rightarrow G$ is surjective by Lemma 4.8. Assume that $(\xi, g) \in \Gamma$ and $p(\xi, g)=g=0$. Since $\left(\Gamma, \Gamma^{+}\right)$has large denominators by Lemma 4.9 there is for each $n \in \mathbb{N}$ an element $\left(\xi_{n}, g_{n}\right) \in \Gamma^{+}$and a natural number $k_{n}$ such that $n\left(\xi_{n}, g_{n}\right) \leq v \leq k_{n}\left(\xi_{n}, g_{n}\right)$. Then $\pm(\xi, g) \leq$ $\left(\xi_{n}, g_{n}\right)$ in $\Gamma$ and hence $\pm \phi(\xi, g) \leq \phi\left(\xi_{n}, g_{n}\right) \leq \frac{1}{n}$. It follows that $\phi(\xi, g)=$ 0 and we conclude that there is a homomorphism $\phi^{\prime}: G \rightarrow \mathbb{R}$ such that $\phi^{\prime} \circ p=\phi$. Let $g \in G$ and assume that $g(x) \geq 0$ for all $x \in S$, and let $n \in \mathbb{N}$. There is $h_{n} \in H^{+}$such that $0<\theta\left(h_{n}\right)<\frac{1}{n}$, and then also a natural number $k \in \mathbb{N}$ such that $0<L\left(\theta\left(h_{n}\right)\right)(x) \psi_{k}^{0} \circ \pi(x)+\frac{1}{2 n} \psi_{k}^{+}(\pi(x))+$ $\frac{1}{2 n} \psi_{k}^{-}(\pi(x))<\frac{1}{n}$ for all $x \in S$. Then

$$
g_{n}^{\prime}:=L\left(\theta\left(h_{n}\right)\right) \psi_{k}^{0} \circ \pi+\frac{1}{2 n} \psi_{k}^{-} \circ \pi+\frac{1}{2 n} \psi_{k}^{+} \circ \pi \in G^{+}
$$

and $0 \leq n\left(h_{n}^{(0)}, g_{n}^{\prime}\right) \leq v$ in $\Gamma$. Hence $0 \leq \phi^{\prime}\left(g_{n}^{\prime}\right) \leq \frac{1}{n}$. Let $\xi \in \oplus_{n \in \mathbb{Z}} H$ be an element such that $(\xi, g) \in \Gamma$. Then $\left(h_{n}^{(0)}+\xi, g_{n}^{\prime}+g\right) \in \Gamma^{+}$and hence $0 \leq \phi^{\prime}\left(g_{n}^{\prime}+g\right) \leq \phi^{\prime}(g)+\frac{1}{n}$. Letting $n$ tend to infinity we find that $\phi^{\prime}(g) \geq 0$, proving that $\phi^{\prime}$ is positive on $G$. Let $g \in G$ and $n, m \in \mathbb{N}$ satisfy $|g(x)|<\frac{n}{m}$ for all $x \in S$. Then $-n<m g(x)<n$ for all $x \in S$ and since $\phi^{\prime}(1)=1$ this leads to the conclusion that $\left|\phi^{\prime}(g)\right| \leq \frac{n}{m}$. Combined with Lemma 4.11 it follows from the last estimate that $\phi^{\prime}$ extends by continuity to a linear map $\phi^{\prime}: \mathcal{A}_{\mathbb{R}}(S, \pi) \rightarrow \mathbb{R}$ such that $\left|\phi^{\prime}(f)\right| \leq$ $\sup _{x \in S}|f(x)|$. Using a Hahn-Banach theorem we extend $\phi^{\prime}$ in a normpreserving way to the space of all continuous real-valued functions on $S$ with a limit at infinity. Since $\phi^{\prime}(1)=1$ the extension is positive. It follows that there is a bounded Borel measure $m$ on $S$ such that

$$
\phi^{\prime}(f)=\int_{S} f(x) \mathrm{d} m
$$

for all $f \in \mathcal{A}_{0}(S, \pi)$, where $\mathcal{A}_{0}(S, \pi)$ denotes the space of elements in $\mathcal{A}_{\mathbb{R}}(S, \pi)$ that vanish at infinity. Let $C_{c}(\mathbb{R})$ denote the set of continuous real-valued compactly supported functions on $\mathbb{R}$ and note that $C_{c}(\mathbb{R})$ is mapped into $\mathcal{A}_{0}(S, \pi)$ by the formula $F \mapsto F \circ \pi$. Since $\phi \circ \alpha=s \phi$ by assumption it follows that the measure $m \circ \pi^{-1}$ on $\mathbb{R}$ satisfies

$$
\int_{\mathbb{R}} e^{-t} F(t) \mathrm{d} m \circ \pi^{-1}(t)=s \int_{\mathbb{R}} F(t) \mathrm{d} m \circ \pi^{-1}(t) \quad \forall F \in C_{c}(\mathbb{R}) .
$$

It follows that $m \circ \pi^{-1}$ is concentrated at the point $\beta=-\log s$ and hence that $m$ is concentrated on $\pi^{-1}(\beta)$. We can therefore define a linear functional $\phi^{\prime \prime}: \operatorname{Aff} \pi^{-1}(\beta) \rightarrow \mathbb{R}$ by

$$
\phi^{\prime \prime}(f)=\phi^{\prime}(\hat{f})=\int_{S} \hat{f}(x) \mathrm{d} m(x)
$$

where $\hat{f} \in \mathcal{A}_{0}(S, \pi)$ is any element with $\left.\hat{f}\right|_{\pi^{-1}(\beta)}=f$, which exists by (1) in Lemma 4.4. If $f \geq 0$ it follows from (2) of Lemma 4.4 that $\hat{f}$ can be chosen such that $\hat{f} \geq-\epsilon$ for any $\epsilon>0$ and we see therefore that $\phi^{\prime \prime}$ is a positive linear functional. Since every state of $\operatorname{Aff} \pi^{-1}(\beta)$ is given by evaluation at a point in $\pi^{-1}(\beta)$ it follows in this way that there is an $\omega \in \pi^{-1}(\beta)$ and a number $\lambda \geq 0$ such that

$$
\begin{equation*}
\phi^{\prime}(g)=\lambda g(\omega) \tag{4.9}
\end{equation*}
$$

for all $g \in \mathcal{A}_{0}(S, \pi)$. In particular, this conclusion holds for all $g \in$ $G \cap \mathcal{A}_{0}(S, \pi)$. A general element $f \in G$ can be write as a sum

$$
f=f_{-}+f_{0}+f_{+},
$$

where $f_{ \pm}, f_{0} \in G, f_{0}$ has compact support and there are natural numbers $n_{ \pm} \in \mathbb{N}$ such that $e^{n_{-} \pi} f_{-} \in \mathcal{A}_{0}(S, \pi)$ and $e^{-n_{+} \pi} f_{+} \in \mathcal{A}_{0}(S, \pi)$. Then $\phi^{\prime}\left(f_{0}\right)=\lambda f_{0}(\omega)$,

$$
\begin{aligned}
& \phi^{\prime}\left(f_{-}\right)=\phi^{\prime}\left(\alpha^{n_{-}}\left(e^{n_{-} \pi} f_{-}\right)\right)=s^{n_{-}} \phi^{\prime}\left(e^{n_{-} \pi} f_{-}\right) \\
& =s^{n_{-}} \lambda e^{n_{-} \pi(\omega)} f_{-}(\omega)=\lambda f_{-}(\omega),
\end{aligned}
$$

and similarly, $\phi^{\prime}\left(f_{+}\right)=\lambda f_{+}(\omega)$. It follows that $\phi(f)=\lambda f(\omega)$. Inserting $f=1$ we find that $\lambda=1$ and the proof is complete.
4.4. Application of the Pimsner-Voiculescu exact sequence.

Let $B$ be a stable AF algebra with $\left(K_{0}(B), K_{0}(B)^{+}\right)=\left(\Gamma, \Gamma^{+}\right)$and let $\gamma$ be an automorphism of $B$ such that $\gamma_{*}=\alpha$; see E1].

Additional properties 4.13. By Lemma 4.3 we can arrange that $\gamma$ has the following additional properties:
(A) The restriction map $\left.\mu \mapsto \mu\right|_{B}$ is a bijection from traces $\mu$ on $B \rtimes_{\gamma} \mathbb{Z}$ onto the $\gamma$-invariant traces on $B$, and
(B) $B \rtimes_{\gamma} \mathbb{Z}$ is $\mathcal{Z}$-stable; that is $\left(B \rtimes_{\gamma} \mathbb{Z}\right) \otimes \mathcal{Z} \simeq B \rtimes_{\gamma} \mathbb{Z}$ where $\mathcal{Z}$ denotes the Jiang-Su algebra, JS.

Set

$$
C=B \rtimes_{\gamma} \mathbb{Z} .
$$

It follows from Lemma 4.10 and [E1] that $B$ is $\gamma$-simple and hence from [E2] (see also Ki1]) that $C$ is simple. It follows from the PimsnerVoiculescu exact sequence, [PV], that we can identify $K_{0}(C)$, as a group, with the quotient

$$
\Gamma /(\mathrm{id}-\alpha)(\Gamma),
$$

in such a way that the map $\iota_{*}: K_{0}(B) \rightarrow K_{0}(C)$ induced by the inclusion $\iota: B \rightarrow C$ becomes the quotient map

$$
q: \Gamma \rightarrow \Gamma /(\mathrm{id}-\alpha)(\Gamma) .
$$

Define $S_{0}: \Gamma \rightarrow H$ such that

$$
S_{0}(\xi, g)=\Sigma(\xi)
$$

Lemma 4.14. $\operatorname{ker} S_{0}=(\mathrm{id}-\alpha)(\Gamma)$.
Proof. Since $(\mathrm{id}-\alpha)(\Gamma)=(\mathrm{id}-\sigma) \oplus\left(\mathrm{id}-\alpha_{0}\right)$ and $\Sigma \circ(\mathrm{id}-\sigma)=0$, we find that $(\operatorname{id}-\alpha)(\Gamma) \subseteq \operatorname{ker} S_{0}$. Let $(\xi, g) \in \Gamma$, and assume that $S_{0}(\xi, g)=$ $\Sigma(\xi)=0$. By Lemma 4.6 of [Th3] there is an element $\xi^{\prime} \in \oplus_{\mathbb{Z}} H$ such that $(\mathrm{id}-\sigma)\left(\xi^{\prime}\right)=\xi$. By the definition of $\Gamma$ there is $\epsilon>0$ such that $\hat{L}(\xi)$ and $g$ agree on $\pi^{-1}(]-\epsilon, \epsilon[)$, and so when $k \geq \epsilon^{-1}$ we have

$$
g=\hat{L}(\xi) \psi_{k}^{0} \circ \pi+h^{-} \psi_{k}^{-} \circ \pi+h^{+} \psi_{k}^{+} \circ \pi+g_{0}
$$

for some $h^{ \pm} \in \mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right]$ and some $g_{0} \in G_{00}$. By the definition of $\mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right]$ there are elements $f^{ \pm} \in \mathbb{Q}\left[e^{-\pi}, 1-e^{-\pi}\right]$ such that $h^{ \pm}=\left(\mathrm{id}-\alpha_{0}\right)\left(f^{ \pm}\right)$and by (4.7) there is an element $g^{\prime} \in G_{00}$ such that $g_{0}=\left(\mathrm{id}-\alpha_{0}\right)\left(g^{\prime}\right)$. Define

$$
g^{\prime \prime}:=\hat{L}\left(\xi^{\prime}\right) \psi_{k}^{0} \circ \pi+f^{-} \psi_{k}^{-} \circ \pi+f^{+} \psi_{k}^{+} \circ \pi+g^{\prime} \in G .
$$

Since

$$
\left(\mathrm{id}-\alpha_{0}\right)\left(\hat{L}\left(\xi^{\prime}\right) \psi_{k}^{0} \circ \pi\right)=\hat{L}\left((\operatorname{id}-\sigma)\left(\xi^{\prime}\right)\right) \psi_{k}^{0} \circ \pi=\hat{L}(\xi) \psi_{k}^{0} \circ \pi,
$$

it follows that $g=\left(\mathrm{id}-\alpha_{0}\right)\left(g^{\prime \prime}\right)$ and hence that $(\xi, g)=(\mathrm{id}-\alpha)\left(\xi^{\prime}, g^{\prime \prime}\right)$.

It follows from Lemma 4.14 that $S_{0}$ induces an isomorphism

$$
S: K_{0}(C)=\Gamma /(\operatorname{id}-\alpha)(\Gamma) \rightarrow H
$$

such that $S \circ q=S_{0}$.
Lemma 4.15. $S\left(K_{0}(C)^{+}\right)=H^{+}$.
Proof. Let $h \in H^{+} \backslash\{0\}$. There is then a $k$ so big that $L(\theta(h))(x)>0$ for all $x \in \pi^{-1}\left(\left[-\frac{1}{k}, \frac{1}{k}\right]\right)$. Define

$$
g:=L(\theta(h)) \psi_{k}^{0} \circ \pi+\psi_{k}^{-} \circ \pi+\psi_{k}^{+} \circ \pi \in G_{k} .
$$

Then $\left(h^{(0)}, g\right) \in \Gamma^{+}, q\left(\left(h^{(0)}, g\right)\right) \in K_{0}(C)^{+}$, and $S\left(q\left(\left(h^{(0)}, g\right)\right)\right)=h$. Hence, $S\left(K_{0}(C)^{+}\right) \supseteq H^{+}$. Consider an element $x \in K_{0}(C)^{+} \backslash\{0\}$ and write $x=q(\xi, g)$ for some $(\xi, g) \in \Gamma$. Let $\omega \in \pi^{-1}(0)$. Since $\omega_{0} \circ \alpha=\omega_{0}$, there is a $\gamma$-invariant trace $\tau_{\omega}$ on $B$ such that $\tau_{\omega_{*}}=\omega_{0}$; see Lemma 3.5 in Th3. Denote by $P: C \rightarrow B$ the canonical conditional expectation and note that $\tau_{\omega} \circ P$ is a trace on $C$. Since $x \in K_{0}(C)^{+} \backslash\{0\}$ and $C$ is simple it follows that

$$
\left(\tau_{\omega} \circ P\right)_{*}(x)>0 .
$$

Since $\left(\tau_{\omega} \circ P\right)_{\star}(x)=\Sigma(\xi)(\omega)$, and $\omega \in \pi^{-1}(0)$ was arbitrary, it follows that $S(x)=\Sigma(\xi) \in H^{+} \backslash\{0\}$. Hence, $S\left(K_{0}(C)^{+}\right) \subseteq H^{+}$.

Lemma 4.16. $K_{1}(C)=0$.
Proof. To establish this from the Pimsner-Voiculescu exact sequence, [PV], we must show that id $-\alpha$ is injective. Let $(\xi, g) \in \Gamma$ and assume that $\alpha(\xi, g)=(\xi, g)$. Then $\sigma(\xi)=\xi$, implying that $\xi=0$ and hence that $\left.g\right|_{\pi^{-1}(0)}=0$. Since $\left(1-e^{-\pi(x)}\right) g(x)=0$ for all $x \in S$, it follows that $g=0$.

Let $e \in B$ be a projection such that $[e]=v$ in $K_{0}(B)=\Gamma$. Since $e C e$ is stably isomorphic to $C$ by $[\mathrm{B}]$ it follows that $\left(K_{0}(e C e), K_{0}(e C e)^{+}\right)=$ $\left(K_{0}(C), K_{0}(C)^{+}\right)$.

### 4.5. Completing the proof of Theorem 3.1 via classification

 theory. Let $(S, \pi)$ and $A$ be as in Theorem 3.1. With $H=K_{0}(A)$ and the assumed identification of the tracial state space $T(A)$ of $A$ with $\pi^{-1}(0)$ we get the homomorphism $\theta: H \rightarrow \operatorname{Aff} \pi^{-1}(0)$ from the canonical map $K_{0}(A) \rightarrow \operatorname{Aff} T(A)$. It follows from Theorem 4.11 in [GH] that $\theta\left(K_{0}(A)\right)$ is dense in $\operatorname{Aff} \pi^{-1}(0)$ and that$$
K_{0}(A)^{+}=\left\{h \in K_{0}(A): \theta(h)(x)>0 \forall x \in \pi^{-1}(0)\right\} \cup\{0\} .
$$

We can therefore apply the preceding with $H=K_{0}(A), H^{+}=K_{0}(A)^{+}$ and $u=[1]$.

Let $\tau$ be a trace state on $e C e$. Then $\tau_{*} \circ S^{-1}: H \rightarrow \mathbb{R}$ is a positive homomorphism such that $\tau_{*} \circ S^{-1}(u)=\tau_{*}(q(v))=\tau(e)=1$, and there is therefore a unique trace state $\tau^{\prime}$ on $A$ such that

$$
\tau_{*}^{\prime}=\tau_{*} \circ S^{-1}
$$

on $K_{0}(A)=H$.
Lemma 4.17. The map $\tau \rightarrow \tau^{\prime}$ is an affine homeomorphism from $T(e C e)$ onto $T(A)$.

Proof. The map is clearly affine. To show that it is continuous, assume that $\left\{\tau_{n}\right\}$ is a convergent sequence in $T(e C e)$ and let $\tau=\lim _{n \rightarrow \infty} \tau_{n}$. Then $\lim _{n \rightarrow \infty} \tau_{n *} \circ S^{-1}(h)=\tau_{*} \circ S^{-1}(h)$ for all $h \in H$. Since $A$ is AF this implies that $\lim _{n \rightarrow \infty} \tau_{n}^{\prime}=\tau^{\prime}$ in $T(A)$. To see that the map is surjective, let $\tau \in T(A)$. Then $\tau_{*}: H \rightarrow \mathbb{R}$ is given by evaluation at a point $\omega \in \pi^{-1}(0)$, and $\tau_{1}=\tau_{\omega} \circ P$ is a trace state on $e C e$ such that $\tau_{1}^{\prime}=\tau$. To see that the map is also injective, consider $\tau_{1}, \tau_{2} \in T(e C e)$. If $\tau_{1}^{\prime}=\tau_{2}^{\prime}$, it follows that $\tau_{1 *}=\tau_{2 *}$. Since $\tau_{1 *} \circ \iota_{*}=\tau_{2 *} \circ \iota_{*}$ and $B$ is AF it follows that $\left.\tau_{1}\right|_{B}=\left.\tau_{2}\right|_{B}$. Thanks to (A) from Additional properties 4.13 this implies that $\tau_{1}=\tau_{2}$.

Lemma 4.18. $e C e$ is *-isomorphic to $A$.
Proof. Since $A$ is AF the $K_{1}$ group of $A$ is trivial, and by Lemma 4.16 the same is true for $e C e$ since $e C e$ is stably isomorphic to $C$. The affine homeomorphism $\tau \rightarrow \tau^{\prime}$ of Lemma 4.17 is compatible with the isomorphism of ordered groups $S: K_{0}(e C e) \rightarrow K_{0}(A)$ from Lemma
4.15 in the sense that $\tau^{\prime}{ }_{*} \circ S=\tau_{*}$, resulting in an isomorphism from the Elliott invariant of $e C e$ onto that of $A$. Both algebras, $A$ and $e C e$, are separable, simple, unital, nuclear and in the UCT class. It is well known that all infinite-dimensional unital simple AF algebras are approximately divisible and hence $\mathcal{Z}$-absorbing by Theorem 2.3 of TW]; in particular, $A$ is $\mathcal{Z}$-absorbing. Since $C$ is $\mathcal{Z}$-absorbing thanks to (B) in Additional properties 4.13, it follows from Corollary 3.2 of TW] that $e C e$ is $\mathcal{Z}$-absorbing. Therefore $e C e$ is isomorphic to $A$ by Corollary D of [CETWW, which in turn is based on [GLN1], [GLN2], [EGLN] and TWW]. (In the case where $A$ is a UHF algebra there is an alternative route through the literature to the same effect. See Remark 4.12 in [Th3].)

We consider the dual action on $C=B \rtimes_{\gamma} \mathbb{Z}$ as a $2 \pi$-periodic flow and we denote by $\theta$ the restriction of this flow to $e C e$.
Lemma 4.19. The KMS bundle $\left(S^{\theta}, \pi^{\theta}\right)$ of $\theta$ is isomorphic to $(S, \pi)$.
Proof. Let $(\omega, \beta) \in S^{\theta}$. By Corollary 4.2, $\left(\left.\hat{\omega}\right|_{B}\right)_{*}$ is a positive homomorphism $\Gamma \rightarrow \mathbb{R}$ such that $\left(\left.\hat{\omega}\right|_{B}\right)_{*}(v)=1$ and $\left(\left.\hat{\omega}\right|_{B}\right)_{*} \circ \alpha=e^{-\beta}\left(\left.\hat{\omega}\right|_{B}\right)_{*}$. By Lemma 4.12, there is $\mu \in \pi^{-1}(\beta)$ such that $\left(\left.\hat{\omega}\right|_{B}\right)_{*}(\xi, g)=g(\mu)$ for all $(\xi, g) \in \Gamma$. $\mu$ is unique since $G$ separates the points of $S$ by Lemma 4.11. We define $\Phi: S^{\theta} \rightarrow S$ by $\Phi(\omega, \beta)=\mu$. By combining Lemma 4.12 and Corollary 4.2 we conclude that $\Phi$ restricts to an affine bijection from $\pi^{\theta^{-1}}(\beta)$ onto $\pi^{-1}(\beta)$ for every $\beta \in \mathbb{R}$. It follows in particular that $\Phi$ is surjective. If $\left(\omega_{i}, \beta_{i}\right) \in S^{\theta}, i=1,2$, are such that $\Phi\left(\left(\omega_{1}, \beta_{1}\right)\right)=$ $\Phi\left(\left(\omega_{2}, \beta_{2}\right)\right)$, it follows that $\beta_{1}=\pi\left(\Phi\left(\left(\omega_{1}, \beta_{1}\right)\right)\right)=\pi\left(\Phi\left(\left(\omega_{2}, \beta_{2}\right)\right)\right)=\beta_{2}$ and hence that $\left(\omega_{1}, \beta_{1}\right)=\left(\omega_{2}, \beta_{2}\right)$. Thus, $\Phi$ is a bijection. Since $\pi \circ \Phi=\pi^{\theta}$, and $\pi$ and $\pi^{\theta}$ are both proper maps, it suffices to show that $\Phi^{-1}$ is continuous. Let therefore $\left\{\omega^{n}\right\}$ be a sequence in $S$ such that $\lim _{n \rightarrow \infty} \omega^{n}=\omega$ in $S$. Set $\beta_{n}=\pi\left(\omega^{n}\right)$ and note that $\lim _{n \rightarrow \infty} \beta_{n}=\beta$, where $\beta=\pi(\omega)$. It follows that $\lim _{n \rightarrow \infty} \omega_{\beta_{n}}^{n}(x)=\omega_{\beta}(x)$ for all $x \in \Gamma$. Let $\tau^{n}$ and $\tau$ be the traces on $B$ determined by the conditions that $\tau^{n}{ }_{*}=\omega_{\beta_{n}}^{n}$ and $\tau_{*}=\omega_{\beta}$. Then $\Phi^{-1}\left(\omega^{n}\right)=\left(\left.\tau^{n} \circ P\right|_{e C e}, \beta_{n}\right)$ and $\Phi^{-1}(\omega)=\left(\left.\tau \circ P\right|_{e C e}, \beta\right)$. It suffices therefore to show that $\lim _{n \rightarrow \infty} \tau^{n} \circ P($ exe $)=\tau \circ P($ exe $)$ for all $x \in C$. Since $\tau^{n} \circ P(e)=\tau \circ P(e)=1$, it suffices to check for $x$ in a dense subset of $C$. If $w$ is the canonical unitary in the multiplier algebra of $C$ coming from the construction of $C$ as a crossed product, it suffices to show that $\lim _{n \rightarrow \infty} \tau^{n} \circ P\left(e b w^{k} e\right)=\tau \circ P\left(e b w^{k} e\right)$ for all $k \in \mathbb{Z}$ and all $b \in B$. Since $P\left(e b w^{k} e\right)=0$ when $k \neq 0$ it suffices to consider the case $k=0$; that is, it suffices to show that $\lim _{n \rightarrow \infty} \tau^{n}(e b e)=\tau(e b e)$. By approximating ebe by a linear combination of projections from $e B e$ it suffices to show that $\lim _{n \rightarrow \infty} \tau^{n}(p)=\tau(p)$ when $p$ is a projection in $e B e$. This holds because

$$
\lim _{n \rightarrow \infty} \tau^{n}(p)=\lim _{n \rightarrow \infty} \omega_{\beta_{n}}^{n}([p])=\omega_{\beta}([p])=\tau(p)
$$

The proof of Theorem 3.1 is complete.
