# BV right-continuous solutions of second-order differential inclusions governed by maximal monotone operators

#### Abstract

This paper concerns existence of right-continuous with bounded variation solutions of a perturbed second-order differential inclusion governed by time and state-dependent maximal monotone operators.


Keywords: Bounded variation, differential measure, Lipschitz mapping, maximal monotone operator, pseudodistance, right-continuous, second-order.

## 1 Introduction

Let $I=[0, T](T>0)$ and $\mathcal{H}$ a separable Hilbert space. Consider, for each $(t, x) \in I \times \mathcal{H}$, a maximal monotone operator of $\mathcal{H} ; A(t, x)$, for which the set-valued map $t \mapsto A(t, x)$ is rightcontinuous with bounded variation (BVRC) w.r.t the time $t$, and Lipschitz continuous w.r.t the state variable $x$, in the sense that there exists a function $\rho: I \rightarrow[0, \infty[$, which is rightcontinuous on $[0, T[$, and a nonnegative real number $\gamma$ such that for $0 \leq s \leq t \leq T, x, y \in \mathcal{H}$,

\operatorname{dis}(A(t, x), A(s, y)) \leq d \rho(] s, t])+\gamma\|x-y\|=\rho(t)-\rho(s)+\gamma\|x-y\| \text {, }
$$

where $\operatorname{dis}(\cdot, \cdot)$ is the pseudo-distance between maximal monotone operators introduced by Vladimirov [49]; see relation (2.8), and $f: I \times \mathcal{H} \times \mathcal{H} \longrightarrow \mathcal{H}$ a Carathéodory mapping satisfying a linear growth condition.

Let $\lambda$ be the Lebesgue measure on $I$ and $d \rho$ the Stieljes-measure associated with $\rho$. We set $\nu:=\lambda+d \rho$ and $\frac{d \lambda}{d \nu}$ the density of $\lambda$ w.r.t $\nu$.

[^0]In this paper, we are mainly interested by the existence of BVRC mappings $u, v: I \longrightarrow \mathcal{H}$ satisfying

This work constitutes an extension to the second-order of few results dealing with first-order BVRC time-dependent maximal monotone operators differential inclusions, established in [9, 16, 31].

For some investigations on first-order differential inclusions governed by time-dependent and time and state dependent maximal monotone operators, where the variation of these operators is absolutely continuous or continuous with bounded variation; we refer for instance to [12, 13, 14, 15, 20, 24, 30, 31, 32, 41, 45, 48, 49]. Concerning the second order, we refer to the recent works [28, 43].

It is well known that the normal cone to closed and convex sets is a maximal monotone operator, so differential inclusions governed by this normal cone, called "sweeping processes" ([34, 35, 33]) are particular cases of the evolutions with general maximal monotone operators. Existence of BVRC solutions to the first-order sweeping process was discussed in many interesting papers; we cite for instance [1, 5, 18, 19, 27, 29, 36, 39, 46, 47]. However, to the best of our knowledge, there are no results for the BVRC second-order sweeping process in comparison with the vast literature concerning absolutely continuous and continuous with bounded variation solutions; see [2, 3, 4, 6, 7, 8, 10, 11, 21, 22, 25, 26, ,39, 40, 44].

The paper is organized as follows. In section 2 , we give notations and recall the needed preliminary results. In section 3 , we prove the existence of right-continuous with bounded variation solutions to the evolution problem $\left(P_{f}\right)$ when $t \mapsto A(t, \cdot)$ is BVRC and the perturbation $f: I \times \mathcal{H} \times \mathcal{H} \longrightarrow \mathcal{H}$ is measurable on $I$ and Lipshitz-continuous on $\mathcal{H} \times \mathcal{H}$.

## 2 Notations and Preliminaries

Throughout the paper, we will denote by $\langle\cdot, \cdot\rangle$ the inner product of $\mathcal{H},\|\cdot\|$ the associated norm and $r \bar{B}_{\mathcal{H}}$ the closed ball of center 0 and radius $r>0$. We will denote by $\mathcal{B}(I)$ the Borel $\sigma$-algebra on $I$. The identity mapping of $\mathcal{H}$ will be denoted by $I d_{\mathcal{H}}$. For a subset $K$ of $\mathcal{H}$, $\overline{c o}(K)$ will be the closed convex hull of $K$, which is characterized by:

If $\mu$ is a positive measure on $I$, we will denote by $L^{p}(I, \mathcal{H} ; \mu) p \in[1,+\infty[$, the Banach space of classes of $p$ - $\mu$-integrable mappings, equipped with its classical norm $\|\cdot\|_{p}$.

The following results concern definitions and some properties of functions with bounded variation and general vector measures, taken from references [33, 36, 37, 38].

Let $u: I \longrightarrow \mathcal{H}$. The variation of $u$ in $I$ is the nonnegative extended real number

\operatorname{var}(u ; I):=\sup \sum_{k=1}^{n}\left\|u\left(t_{k}\right)-u\left(t_{k-1}\right)\right\| \tag{2.2}
\end{equation*}

where the supremum is taken in $[0,+\infty]$ w.r.t all the finite sequences $t_{0}<t_{1}<\cdots<t_{n}$ of points of $I$ ( $n$ is arbitrary). The function $u$ is said with bounded variation (BV) if and only if $\operatorname{var}(u ; I)<+\infty$. In this case we have

\lim _{s \uparrow t}\|u(t)-u(s)\|=\lim _{s \uparrow t} \operatorname{var}(u ;[s, t]) .
$$

Now, let $\mu$ be a positive Radon measure on $I$ and $\hat{\mu}$ be an $\mathcal{H}$-valued measure on $I$ admitting a density $\frac{d \hat{\mu}}{d \mu} \in L_{l o c}^{1}(I, \mathcal{H} ; \mu)$. Then for $d \mu$-almost every $t \in I$, we have

\frac{d \hat{\mu}}{d \mu}(t)=\lim _{\varepsilon \downarrow 0} \frac{d \hat{\mu}([t, t+\varepsilon])}{d \mu([t, t+\varepsilon])}=\lim _{\varepsilon \downarrow 0} \frac{d \hat{\mu}([t-\varepsilon, t])}{d \mu([t-\varepsilon, t])} \tag{2.3}
\end{equation*}

The measure $\hat{\mu}$ is absolutely continuous w.r.t $\mu$ if and only if $\hat{\mu}=\frac{d \hat{\mu}}{d \mu} \mu$, i.e., $\frac{d \hat{\mu}}{d \mu}$ is a density of $\hat{\mu}$ w.r.t $\mu$. In this case a mapping $u: I \longrightarrow \mathcal{H}$ is $\hat{\mu}$-integrable if and only if the mapping $t \mapsto u(t) \frac{d \hat{\mu}}{d \mu}(t)$ is $\mu$-integrable, and we have

\int_{I} u(t) d \hat{\mu}(t)=\int_{I} u(t) \frac{d \hat{\mu}}{d \mu}(t) d \mu(t) \tag{2.4}
\end{equation*}

If $u: I \longrightarrow \mathcal{H}$ is BVRC and $d u$ is its differential measure, then we have

$$
\begin{equation*}
u(t)=u(s)+\int_{] s, t]} d u \quad \forall s, t \in I(s \leq t) \tag{2.5}
\end{equation*}
$$

Conversely, if there exists $v \in L^{1}(I, \mathcal{H} ; \mu)$ such that $u(t)=u(0)+\int_{] 0, t]} v d \mu$ for all $t \in I$, then $u$ is BVRC and $d u=v d \mu$, that is $v$ is a density of the vector measure $d u$ w.r.t the measure $\mu$. So that by (2.3), we get

v(t)=\frac{d u}{d \mu}(t)=\lim _{\varepsilon \downarrow 0} \frac{d u([t, t+\varepsilon])}{d \mu([t, t+\varepsilon])}=\lim _{\varepsilon \downarrow 0} \frac{d u([t-\varepsilon, t])}{d \mu([t-\varepsilon, t])} \tag{2.6}
\end{equation*}

If $\mu(\{t\})>0$, this last relation shows that

v(t)=\frac{d u}{d \mu}(t)=\frac{d u(\{t\})}{d \mu(\{t\})} \quad \text { and } \quad \frac{d \lambda}{d \mu}(t)=0 \tag{2.7}
\end{equation*}

Next, we give definition and some properties of maximal monotone operators. We refer the reader to [17, 23, 50] for more details.

Let $A: \mathcal{H} \rightrightarrows \mathcal{H}$ be a set-valued map. We denote by $D(A)$ and $G r(A)$ its domain and graph. We say that the operator $A$ is monotone, if $\left\langle y_{1}-y_{2}, x_{1}-x_{2}\right\rangle \geq 0$ for all $\left(x_{i}, y_{i}\right) \in G r(A)$ $(i=1,2)$, and we say that $A$ is a maximal monotone operator of $\mathcal{H}$, if it is monotone and its graph could not be contained strictly in the graph of any other monotone operator.

If $A$ is a maximal monotone operator of $\mathcal{H}$, then for every $x \in D(A), A(x)$ is nonempty closed and convex. We denote the projection of the origin on the set $A(x)$ by $A^{0}(x)$.

For $\eta>0$, we denote by $J_{\eta}^{A}=\left(I d_{\mathcal{H}}+\eta A\right)^{-1}$ the resolvent of $A$. It is well-known that this operator is single-valued and defined on all of $\mathcal{H}$, furthermore $J_{\eta}^{A}(x) \in D(A)$, for all $x \in \mathcal{H}$.

Let $A: D(A) \subset \mathcal{H} \rightrightarrows \mathcal{H}$ and $B: D(B) \subset \mathcal{H} \rightrightarrows \mathcal{H}$ be two maximal monotone operators. Then, $\operatorname{dis}(A, B)$ is the Vladimirov's pseudo-distance between $A$ and $B$, defined as follows

\operatorname{dis}(A, B)=\sup \left\{\frac{\left\langle y-y^{\prime}, x^{\prime}-x\right\rangle}{1+\|y\|+\left\|y^{\prime}\right\|}:(x, y) \in G r(A),\left(x^{\prime}, y^{\prime}\right) \in G r(B)\right\} \tag{2.8}
\end{equation*}
$$

The following lemmas are needed for our proof. We refer to 31 for their proofs.
Lemma 2.1 Let $A$ be a maximal monotone operator of $\mathcal{H}$. If $x \in \overline{D(A)}$ and $y \in \mathcal{H}$ are such that

\left\langle A^{0}(z)-y, z-x\right\rangle \geq 0 \quad \forall z \in D(A)
$$

then $x \in D(A)$ and $y \in A(x)$.
Lemma 2.2 Let $A_{n}(n \in \mathbb{N})$ and $A$ be maximal monotone operators of $\mathcal{H}$ such that $\operatorname{dis}\left(A_{n}, A\right) \rightarrow$ 0. Suppose also that $x_{n} \in D\left(A_{n}\right)$ with $x_{n} \rightarrow x$ and $y_{n} \in A_{n}\left(x_{n}\right)$ with $y_{n} \rightarrow y$ weakly for some $x, y \in E$. Then $x \in D(A)$ and $y \in A(x)$.

Lemma 2.3 Let $A$ and $B$ be maximal monotone operators of $\mathcal{H}$. Then 1) for $\eta>0$ and $x \in D(A)$

\left\|x-J_{\eta}^{B}(x)\right\| \leq \eta\left\|A^{0}(x)\right\|+\operatorname{dis}(A, B)+\sqrt{\eta\left(1+\left\|A^{0}(x)\right\|\right) \operatorname{dis}(A, B)}
$$

2) For $\eta>0$ and $x, x^{\prime} \in E$

$$
\left\|J_{\eta}^{A}(x)-J_{\eta}^{A}\left(x^{\prime}\right)\right\| \leq\left\|x-x^{\prime}\right\|
$$

Lemma 2.4 Let $A_{n}(n \in \mathbb{N})$ and $A$ be maximal monotone operators of $\mathcal{H}$ such that $\operatorname{dis}\left(A_{n}, A\right) \rightarrow$ 0 and $\left\|A_{n}^{0}(x)\right\| \leq c(1+\|x\|)$ for some $c>0$, all $n \in \mathbb{N}$ and $x \in D\left(A_{n}\right)$. Then for every $z \in D(A)$ there exists a sequence $\left(\zeta_{n}\right)$ such that

\zeta_{n} \in D\left(A_{n}\right), \quad \zeta_{n} \rightarrow z \text { and } A_{n}^{0}\left(\zeta_{n}\right) \rightarrow A^{0}(z)
$$

We end this section by the following discrete Gronwall's lemma.
Lemma 2.5 Let $\left(\alpha_{i}\right),\left(\beta_{i}\right),\left(\gamma_{i}\right)$ and $\left(a_{i}\right)$ be sequences of nonnegative real numbers such that $a_{i+1} \leq \alpha_{i}+\beta_{i}\left(a_{0}+a_{1}+\cdots+a_{i-1}\right)+\left(1+\gamma_{i}\right) a_{i}$ for $i \in \mathbb{N}$. Then

$$
a_{j} \leq\left(a_{0}+\sum_{k=0}^{j-1} \alpha_{k}\right) \exp \left(\sum_{k=0}^{j-1}\left(k \beta_{k}+\gamma_{k}\right)\right) \text { for } j \in \mathbb{N}^{*}
$$

We will establish our main result under the following hypotheses.
$\left(H_{1}\right)$ There exist a function $\rho: I \longrightarrow[0,+\infty[$, which is right-continuous on $[0, T[$ and nondecreasing with $\rho(0)=0$ and $\rho(T)<+\infty$, and nonnegative constant $\gamma$ such that

\operatorname{dis}(A(t, x), A(s, y)) \leq d \rho(] s, t])+\gamma\|x-y\| \frac{d \lambda}{d \nu}(s) \text { for } 0 \leq s \leq t \leq T, x, y \in \mathcal{H}
$$

and since $\frac{d \lambda}{d \nu}(s) \leq 1,\left(H_{1}\right)$ implies that

\operatorname{dis}(A(t, x), A(s, y)) \leq d \rho(] s, t])+\gamma\|x-y\| \text { for } 0 \leq s \leq t \leq T, x, y \in \mathcal{H}
$$

$\left(H_{2}\right)$ There exists a nonnegative real constant $c$ such that

$$
\left\|A^{0}(t, x) y\right\| \leq c(1+\|x\|+\|y\|) \text { for } t \in I, x \in \mathcal{H}, y \in D(A(t, x))
$$

$\left(H_{3}\right)$ For any bounded subset $E$ of $\mathcal{H}, D(A(I \times E))$ is relatively ball-compact, i.e., its intersection with any closed ball of $\mathcal{H}$ is relatively compact.
$\left(H_{4}\right) t \mapsto f(t, \cdot, \cdot)$ is $\mathcal{B}(I)$-measurable.
$\left(H_{5}\right)$ There is a nonnegative function $k \in L^{1}(I, \mathbb{R} ; \lambda)$ such that

\left\|f(t, x, y)-f\left(t, x^{\prime}, y^{\prime}\right)\right\| \leq k(t)\left(\left\|x-x^{\prime}\right\|+\left\|y-y^{\prime}\right\|\right) \quad \forall t \in I, \forall(x, y),\left(x^{\prime}, y^{\prime}\right) \in \mathcal{H} \times \mathcal{H}
$$

$\left(H_{6}\right)$ There exists a nonnegative real constant $m$ such that

$$
\|f(t, x, y)\| \leq m(1+\|x\|+\|y\|) \quad \forall(t, x, y) \in I \times \mathcal{H} \times \mathcal{H}
$$

## 3 Main result

Now we are able to state our main theorem.
Theorem 3.1 Let for every $(t, x) \in I \times \mathcal{H}, A(t, x): D(A(t, x)) \subset \mathcal{H} \rightrightarrows \mathcal{H}$ be a maximal monotone operator satisfying $\left(H_{1}\right),\left(H_{2}\right)$ and $\left(H_{3}\right)$. Let $f: I \times \mathcal{H} \times \mathcal{H} \longrightarrow \mathcal{H}$ such that $\left(H_{4}\right)$, $\left(H_{5}\right)$ and $\left(H_{6}\right)$ are satisfied. Then for any $\left(u_{0}, v_{0}\right) \in \mathcal{H} \times D\left(A\left(0, u_{0}\right)\right)$, there exists a BVRC solution $(u, v): I \longrightarrow \mathcal{H} \times \mathcal{H}$ to problem $\left(P_{f}\right)$.

Proof. Following Castaing et al [27], we can choose a sequence $\left.\left.\left(\varepsilon_{n}\right)_{n \geq 1} \subset\right] 0,1\right]$ such that $\varepsilon_{n} \downarrow 0$ and a partition $0=t_{0}^{n}<t_{1}^{n}<\cdots<t_{q_{n}}^{n}=T$ of $I$ (with $\lim _{n \rightarrow \infty} q_{n}=+\infty$ ), for which we have

\begin{equation*}
\left.\left.\left.\left.\nu(] t_{i}^{n}, t_{i+1}^{n}\right]\right)=\left|t_{i+1}^{n}-t_{i}^{n}\right|+d \rho(] t_{i}^{n}, t_{i+1}^{n}\right]\right) \leq \varepsilon_{n} \quad \text { for } i=0, \cdots, q_{n}-1 \tag{3.1}
\end{equation*}
$$

we can take, for example, $\varepsilon_{n}=\frac{T}{q_{n}}$. For each $i \in\left\{0, \cdots, q_{n}-1\right\}$, put $\left.\left.I_{i}^{n}=\right] t_{i}^{n}, t_{i+1}^{n}\right]$,

\left.\left.\left.\left.\delta_{i+1}^{n}=d \rho( \rceil t_{i}^{n}, t_{i+1}^{n}\right]\right), \quad \eta_{i+1}^{n}=t_{i+1}^{n}-t_{i}^{n}, \quad \beta_{i+1}^{n}=\nu(] t_{i}^{n}, t_{i+1}^{n}\right]\right) \tag{3.2}
\end{equation*}

For every $n \in \mathbb{N}$, put $u_{0}^{n}=u_{0}, v_{0}^{n}=v_{0} \in D\left(A\left(0, u_{0}\right)\right)$, and let us define by induction, sequences $\left(v_{i}^{n}\right)_{0 \leq i \leq q_{n}-1},\left(u_{i}^{n}\right)_{0 \leq i \leq q_{n}-1}$ such that

v_{i+1}^{n}=J_{i+1}^{n}\left(v_{i}^{n}-\int_{t_{i}^{n}}^{t_{i+1}^{n}} f\left(s, u_{i}^{n}, v_{i}^{n}\right) d \lambda(s)\right) \tag{3.3}

where $J_{i+1}^{n}:=J_{\beta_{i+1}^{n}}^{A\left(t_{i+1}^{n}, u_{i}^{n}\right)}=\left(I d_{\mathcal{H}}+\beta_{i+1}^{n} A\left(t_{i+1}^{n}, u_{i}^{n}\right)\right)^{-1}$, and

u_{i+1}^{n}=u_{i}^{n}+\beta_{i+1}^{n} v_{i+1}^{n} . \tag{3.4}

From the properties of the resolvent, we have that $v_{i+1}^{n} \in D\left(A\left(t_{i+1}^{n}, u_{i}^{n}\right)\right)$ and

-\frac{1}{\beta_{i+1}^{n}}\left(v_{i+1}^{n}-v_{i}^{n}+\int_{t_{i}^{n}}^{t_{i+1}^{n}} f\left(s, u_{i}^{n}, v_{i}^{n}\right) d \lambda(s)\right) \in A\left(t_{i+1}^{n}, u_{i}^{n}\right) v_{i+1}^{n} \tag{3.5}
\end{equation*}

For $t \in\left[t_{i}^{n}, t_{i+1}^{n}\left[, i=0, \cdots, q_{n}-1\right.\right.$, set

\begin{gather*}
v_{n}(t)=v_{i}^{n}+\frac{\left.\left.\nu( \rceil t_{i}^{n}, t\right]\right)}{\left.\left.\nu( \rceil t_{i}^{n}, t_{i+1}^{n}\right]\right)}\left(v_{i+1}^{n}-v_{i}^{n}+\int_{t_{i}^{n}}^{t_{i+1}^{n}} f\left(s, u_{i}^{n}, v_{i}^{n}\right) d \lambda(s)\right)-\int_{t_{i}^{n}}^{t} f\left(s, u_{i}^{n}, v_{i}^{n}\right) d \lambda(s)  \tag{3.6}\\
u_{n}(t)=u_{i}^{n}+\frac{\left.\left.\nu( \rceil t_{i}^{n}, t\right]\right)}{\left.\left.\nu( \rceil t_{i}^{n}, t_{i+1}^{n}\right]\right)}\left(u_{i+1}^{n}-u_{i}^{n}\right) \tag{3.7}
\end{gather*}

and $v_{n}(T)=v_{q_{n}}^{n}, u_{n}(T)=u_{q_{n}}^{n}$. So that $v_{n}\left(t_{i}^{n}\right)=v_{i}^{n}, u_{n}\left(t_{i}^{n}\right)=u_{i}^{n}$ and $v_{n}, u_{n}$ are BVRC mappings on $I$.

Step 1. We prove in this step that the sequences $\left(v_{n}\right),\left(u_{n}\right)$ are bounded in norm and in variation.
Using Lemma 2.3, we have from (3.3), $\left(H_{1}\right),\left(H_{2}\right)$ and $\left(H_{6}\right)$, for $i=0,1, \cdots, q_{n}-1$ (keeping in mind that $\sqrt{a b} \leq \frac{a}{2}+b$ for nonnegative real numbers $a, b$ )

& \leq \int_{t_{i}^{n}}^{t_{i+1}^{n}}\left\|f\left(s, u_{i}^{n}, v_{i}^{n}\right)\right\| d \lambda(s)+\beta_{i+1}^{n}\left\|A^{0}\left(t_{i}^{n}, u_{i-1}^{n}\right) v_{i}^{n}\right\|+\operatorname{dis}\left(A\left(t_{i+1}^{n}, u_{i}^{n}\right), A\left(t_{i}^{n}, u_{i-1}^{n}\right)\right) \\
& +\sqrt{\beta_{i+1}^{n}\left(1+\left\|A^{0}\left(t_{i}^{n}, u_{i-1}^{n}\right) v_{i}^{n}\right\|\right) \operatorname{dis}\left(A\left(t_{i+1}^{n}, u_{i}^{n}\right), A\left(t_{i}^{n}, u_{i-1}^{n}\right)\right)} \\
& \leq m\left(1+\left\|u_{i}^{n}\right\|+\left\|v_{i}^{n}\right\|\right) \beta_{i+1}^{n}+\left(1+c\left(1+\left\|u_{i-1}^{n}\right\|+\left\|v_{i}^{n}\right\|\right)\right) \beta_{i+1}^{n}+\gamma\left\|u_{i}^{n}-u_{i-1}^{n}\right\| \\

\leq & k(t)\left(\left\|u_{n}\left(\phi_{n}(t)\right)-u(t)\right\|+\left\|v_{n}\left(\phi_{n}(t)\right)-v_{n}(t)\right\|+\left\|v_{n}(t)-v(t)\right\|\right) \frac{d \lambda}{d \nu}(t) \\
\leq & \left.\left.k(t)\left(\left\|u_{n}\left(\phi_{n}(t)\right)-u(t)\right\|+M_{5} \nu(] \phi_{n}(t), t\right]\right)+\left\|v_{n}(t)-v(t)\right\|\right) \frac{d \lambda}{d \nu}(t),
\end{aligned}
$$

whence by the convergence of $\left(v_{n}(t)\right)$ to $v(t)$ and relations (2.7), (3.26), it results that for all $t \in I$,

$$
\begin{equation*}
f\left(t, u_{n}\left(\phi_{n}(t)\right), v_{n}\left(\phi_{n}(t)\right)\right) \frac{d \lambda}{d \nu}(t) \longrightarrow f(t, u(t), v(t)) \frac{d \lambda}{d \nu}(t) \quad \text { as } n \rightarrow \infty \tag{3.29}
\end{equation*}
$$

Now, to prove that $(u, v)$ is a solution to our considered problem, we will use Lemma 2.1. Since $v(t) \in D(A(t, u(t)))$ for all $t \in I$, we have to show that for $\nu$-almost every fixed $t \in I$ and for any $z \in D(A(t, u(t)))$

$$
\left\langle A^{0}(t, u(t)) z+\frac{d v}{d \nu}(t)+f(t, u(t), v(t)) \frac{d \lambda}{d \nu}(t), z-v(t)\right\rangle \geq 0
$$

Indeed, let $t \in I$. By $\left(H_{2}\right)$, using Lemma 2.4, we can ensure the existence of a sequence $\left(\zeta_{n}\right)_{n}$, such that

$$
\begin{equation*}
\zeta_{n} \in D\left(A\left(\theta_{n}(t), u_{n}\left(\phi_{n}(t)\right)\right)\right), \quad \zeta_{n} \longrightarrow z \text { and } A^{0}\left(\theta_{n}(t), u_{n}\left(\phi_{n}(t)\right)\right) \zeta_{n} \longrightarrow A^{0}(t, u(t)) z \tag{3.30}
\end{equation*}
$$

Since $A\left(\theta_{n}(t), u_{n}\left(\phi_{n}(t)\right)\right)$ is monotone, using (3.18), we have for each $n \in \mathbb{N}$ and $t \in I \backslash J_{n}$,

$$
\begin{equation*}
\left\langle v_{n}\left(\theta_{n}(t)\right)-\zeta_{n}, \frac{d v_{n}}{d \nu}(t)+f\left(t, u_{n}\left(\phi_{n}(t)\right), v_{n}\left(\phi_{n}(t)\right)\right) \frac{d \lambda}{d \nu}(t)+A^{0}\left(\theta_{n}(t), u_{n}\left(\phi_{n}(t)\right)\right) \zeta_{n}\right\rangle \leq 0 \tag{3.31}
\end{equation*}
$$

Next, let $t \in I \backslash\left(J \cup J^{\prime} \cup\left(\bigcup_{n} J_{n}\right)\right)$. From (3.28), we have

$$
\left\langle\frac{d v}{d \nu}(t), v(t)-z\right\rangle \leq \limsup _{n \rightarrow \infty}\left\langle\frac{d v_{n}}{d \nu}(t), v(t)-z\right\rangle
$$

and since from (3.17) and (3.31), we have for each $n \in \mathbb{N}$,

$$
\begin{aligned}
& \left\langle\frac{d v_{n}}{d \nu}(t), v(t)-z\right\rangle \leq\left\langle\frac{d v_{n}}{d \nu}(t), v(t)-v_{n}\left(\theta_{n}(t)\right)\right\rangle+\left\langle\frac{d v_{n}}{d \nu}(t), v_{n}\left(\theta_{n}(t)\right)-\zeta_{n}\right\rangle+\left\langle\frac{d v_{n}}{d \nu}(t), \zeta_{n}-z\right\rangle \\
\leq & M_{5}\left(\left\|v(t)-v_{n}\left(\theta_{n}(t)\right)\right\|+\left\|\zeta_{n}-z\right\|\right)+\left\langle\frac{d v_{n}}{d \nu}(t), v_{n}\left(\theta_{n}(t)\right)-\zeta_{n}\right\rangle \\
\leq & M_{5}\left(\left\|v(t)-v_{n}\left(\theta_{n}(t)\right)\right\|+\left\|\zeta_{n}-z\right\|\right) \\
+ & \left\langle f\left(t, u_{n}\left(\phi_{n}(t)\right), v_{n}\left(\phi_{n}(t)\right)\right) \frac{d \lambda}{d \nu}(t)+A^{0}\left(\theta_{n}(t), u_{n}\left(\phi_{n}(t)\right)\right) \zeta_{n}, \zeta_{n}-v_{n}\left(\theta_{n}(t)\right)\right\rangle
\end{aligned}
$$

we conclude, using (3.23), (3.29) and (3.30) that

$$
\begin{equation*}
\left\langle\frac{d v}{d \nu}(t), v(t)-z\right\rangle \leq\left\langle f(t, u(t), v(t)) \frac{d \lambda}{d \nu}(t)+A^{0}(t, u(t)) z, z-v(t)\right\rangle \tag{3.32}
\end{equation*}
$$

which, with the fact that $v(t) \in D(A(t, u(t))), u(0)=u_{0}, v(0)=v_{0}$ and (3.25), means that $(u, v)$ is a BVRC solution to our problem $\left(P_{f}\right)$.

Remark 3.1 If the operators depend only on the time and satisfy the following hypotheses: $\left(H_{1}^{\prime}\right)$ There exists a function $\rho: I \longrightarrow[0,+\infty[$, which is right-continuous on $[0, T[$ and nondecreasing with $\rho(0)=0$ and $\rho(T)<+\infty$ such that

$$
\operatorname{dis}(A(t), A(s)) \leq d \rho(] s, t]) \text { for } 0 \leq s \leq t \leq T
$$

$\left(H_{2}^{\prime}\right)$ There exists a nonnegative real constant $c$ such that

$$
\left\|A^{0}(t) x\right\| \leq c(1+\|x\|) \text { for } t \in I, x \in D(A(t))
$$

$\left(H_{3}^{\prime}\right)$ For any $t \in I, D(A(t))$ is relatively ball-compact. Our theorem reads as

Corollary 3.1 Let for every $t \in I, A(t): D(A(t)) \subset \mathcal{H} \rightrightarrows \mathcal{H}$ be a maximal monotone operator satisfying $\left(H_{1}^{\prime}\right),\left(H_{2}^{\prime}\right)$ and $\left(H_{3}^{\prime}\right)$. Let $f: I \times \mathcal{H} \times \mathcal{H} \longrightarrow \mathcal{H}$ such that $\left(H_{4}\right),\left(H_{5}\right)$ and $\left(H_{6}\right)$ are satisfied. Then for any $\left(u_{0}, v_{0}\right) \in \mathcal{H} \times D(A(0))$, there exists a $B V R C$ solution $(u, v): I \longrightarrow \mathcal{H} \times \mathcal{H}$ to the problem

$$
\left\{\begin{array}{l}
u(0)=u_{0}, v(0)=v_{0} \in D(A(0)) \\
v(t) \in D(A(t)) \quad \forall t \in I \\
\frac{d u}{d \nu}(t)=v(t) \quad d \nu-a . e . t \in I \\
-\frac{d v}{d \nu}(t) \in A(t) v(t)+f(t, u(t), v(t)) \frac{d \lambda}{d \nu}(t) \quad d \nu-\text { a.e. } t \in I
\end{array}\right.
$$

Remark 3.2 In particular, if we consider $A(t, x)=N_{C(t, x)}$, the normal cone, in the sense of convex analysis, to the closed convex set $C(t, x)$, then under the following hypotheses:
$\left(H_{1}^{\prime \prime}\right)$ There exists a function $\rho: I \longrightarrow[0,+\infty[$, which is right-continuous on $[0, T[$ and nondecreasing with $\rho(0)=0$ and $\rho(T)<+\infty$ and a nonnegative real constant $\gamma$ such that

$$
\left.\left.\left|d_{C(t, x)}(z)-d_{C(s, y)}(z)\right| \leq d \rho(] s, t\right]\right)+\gamma\|x-y\| \frac{d \lambda}{d \nu}(s) \text { for } 0 \leq s \leq t \leq T, x, y, z \in \mathcal{H}
$$

$\left(H_{2}^{\prime \prime}\right)$ For any bounded subset $E$ of $\mathcal{H}, C(I \times E)$ is relatively ball-compact.
We can derive the following corollary.
Corollary 3.2 Let $C: I \times \mathcal{H} \rightrightarrows \mathcal{H}$ be a set-valued map with nonempty, closed and convex values satisfying $\left(H_{1}^{\prime \prime}\right)$ and $\left(H_{2}^{\prime \prime}\right)$. Let $f: I \times \mathcal{H} \times \mathcal{H} \longrightarrow \mathcal{H}$ such that $\left(H_{4}\right)$, $\left(H_{5}\right)$ and $\left(H_{6}\right)$ are satisfied. Then for any $\left(u_{0}, v_{0}\right) \in \mathcal{H} \times C\left(0, u_{0}\right)$, there exists a $B V R C$ solution $(u, v): I \longrightarrow \mathcal{H} \times \mathcal{H}$ to the problem

$$
\left\{\begin{array}{l}
u(0)=u_{0}, v(0)=v_{0} \\
v(t) \in C(t, u(t)) \quad \forall t \in I \\
\frac{d u}{d \nu}(t)=v(t) \quad d \nu-a . e . t \in I \\
-\frac{d v}{d \nu}(t) \in N_{C(t, u(t))}(v(t))+f(t, u(t), v(t)) \frac{d \lambda}{d \nu}(t) \quad d \nu-\text { a.e. } t \in I
\end{array}\right.
$$
