# Conductive homogeneity of compact metric spaces and construction of $p$-energy

#### Abstract

In the ordinary theory of Sobolev spaces on domains of $\mathbb{R}^{n}$, the $p$ energy is defined as the integral of $|\nabla f|^{p}$. In this paper, we try to construct a $p$-energy on compact metric spaces as a scaling limit of discrete $p$-energies on a series of graphs approximating the original space. In conclusion, we propose a notion called conductive homogeneity under which one can construct a reasonable $p$-energy if $p$ is greater than the Ahlfors regular conformal dimension of the space. In particular, if $p=2$, then we construct a local regular Dirichlet form and show that the heat kernel associated with the Dirichlet form satisfies upper and lower sub-Gaussian type heat kernel estimates. As examples of conductively homogeneous spaces, we present new classes of square-based self-similar sets and rationally ramified Sierpinski crosses, where no diffusions were constructed before.

## 1 Introduction

The main objective of this paper is to generalize the following elementary fact. Let $I=[0,1]$. Define

$$
\mathcal{E}_{p}^{n}(f)=\sum_{i=1}^{2^{n}}\left|f\left(\frac{i-1}{2^{n}}\right)-f\left(\frac{i}{2^{n}}\right)\right|^{p}
$$

for $n \geq 1$ and $f: I \rightarrow \mathbb{R}$. If $f$ is smooth or more generally $f \in W^{1, p}(I)$, which is the $(1, p)$-Sobolev space, then

$$
\left(2^{p-1}\right)^{n} \mathcal{E}_{p}^{n}(f) \rightarrow \int_{0}^{1}|\nabla f|^{p} d x
$$

as $n \rightarrow \infty$, where $\nabla f$ is the derivative of $f$.
Our naive question is what is a counterpart of this in the case of metric spaces. More precisely, our general strategy of the study is:
(1) To fix an adequate sequence of discrete graphs $\left\{\left(T_{n}, E_{n}^{*}\right)\right\}_{n \geq 1}$, where $T_{n}$
is a discrete approximation of the original metric space $(X, d)$ and $E_{n}^{*}$ is the collection of edges, i.e. pairs of points in $T_{n}$. For a function $f: T_{n} \rightarrow \mathbb{R}$, define

$$
\mathcal{E}_{p}^{n}(f)=\frac{1}{2} \sum_{(x, y) \in E_{n}^{*}}|f(x)-f(y)|^{p}
$$

which is called the $p$-energy of the function $f$.
(2) To find a proper scaling constant $\sigma$ such that the space of functions

$$
\left\{f: X \rightarrow \mathbb{R} \mid \sigma^{n} \mathcal{E}_{p}^{n}\left(P_{n} f\right) \text { is "convergent" as } n \rightarrow \infty\right\}
$$

where $P_{n} f$ is a suitable discrete approximation of $f$, is rich enough to be a "Sobolev" space in some sense. From our perspective, we do not care about the existence of a derivative $\nabla f$ but pursue the convergence of $\sigma^{n} \mathcal{E}_{p}^{n}\left(P_{n} f\right)$.

Actually, in the case $p=2$, this strategy was employed to construct Dirichlet forms inducing diffusion processes on self-similar sets like the Sierpinski gasket and the Sierpinski carpet. (See Figure 4.) For the sake of simplicity, we confine ourselves to non-finitely ramified self-similar sets. (This excludes post critically finite self-similar sets represented by the Sierpinski gasket.) Barlow and Bass constructed the Brownian motions on (generalized) Sierpinski carpets in [1, 2, 3, 4, 5, 6, as scaling limits of the Brownian motions on regions approximating Sierpinski carpets. Later Kusuoka and Zhou employed the above strategy for $p=2$ and directly constructed the Dirichlet form inducing the Brownian motion on the planar Sierpinski carpet in 36. Note that all these works were done in the last century. Although more than 20 years have passed, no essential progress has been made on the construction of diffusion processes/Dirichlet forms on nonfinitely ramified self-similar sets. In particular, no diffusion was constructed on square-based non-finitely ramified self-similar sets like those in Figure 1 . The right-hand one is an example of rationally ramified Sierpinski crosses treated in Section 13 . It has two different contraction ratios. The left-hand one is an example having no symmetry of the square. As a by-product of our results in this paper, we will construct non-trivial self-similar local regular Dirichlet forms on classes of square-based self-similar sets including those in Figure 1 See Sections 11, 12, and 13 for details.

From the viewpoint of construction of Sobolev spaces on metric spaces, there have already been established theories based on upper gradients, which correspond to local Lipschitz constants of Lipschitz functions. Compared with our strategy above, this direction is to seek a counterpart of $\nabla f$ instead of the convergence of $\sigma^{n} \mathcal{E}_{p}^{n}\left(P_{n} f\right)$ like us. The pioneering works of this theory are Hajłasz [22], Cheeger [15] and Shanmugalingam [40]. One can find a panoramic view of this theory in [23]. Recent studies by Kajino and Murugan in [27] and [26], however, have suggested that they may not cover all the interesting cases. So far examples in question are higher dimensional Sierpinski gaskets, the Vicsek set, and the planar Sierpinski carpet. What they have shown in [27] and [26] is that the Brownian motions on those examples will not have the Gaussian heat kernel estimate under any time change by a pair $(d, \mu)$, where a metric $d$ is quasisymmetric to the Euclidean metric $d_{E}$ and a measure $\mu$ has

the volume doubling property with respect to $d_{E}$. On the other hand, under the established theory, the heat kernel associated with a (1,2)-Sobolev space satisfying a (2,2)-Poincaré inequality should satisfy the Gaussian estimate due to the results in [20, 39] and [42]. Thus, the Dirichlet forms associated with the Brownian motions on the above-mentioned self-similar sets can hardly be one of $(1,2)$-Sobolev spaces based on upper gradients. Note that, in these cases, there exist plenty of rectifiable curves with respect to (the restriction of) the Euclidean metrics, which are even quasiconvex. Partly motivated by such a situation, we will try to provide an alternative theory of function spaces, which may be called Sobolev spaces or else, on metric spaces, and to construct natural diffusion processes at the same time.

Getting straight to the conclusion, we propose a condition called $p$-conductive homogeneity and show that under this condition, the strategy consisting of (1) and (2) succeeds for $p>\operatorname{dim}_{A R}(K, d)$, where $\operatorname{dim}_{A R}(K, d)$ is the Ahlfors regular conformal dimension of a compact metric space $(K, d)$. One can see a more precise and detailed exposition in what follows. The definition of the Ahlfors regular conformal dimension of $(K, d)$ is

$$
\begin{align*}
& \operatorname{dim}_{A R}(K, d)=\inf \{\alpha \mid \text { there exist a metric } \rho \text { on } K \text { which is } \\
& \text { quasisymmetric to } d \text { and a Borel regular measure } \mu \\
& \text { which is } \alpha \text {-Ahlfors regular with respect to } \rho .\} \tag{1.1}
\end{align*}
$$

In the direction of our study, Shimizu has done pioneering work for the case of the planar Sierpinski carpet, PSC for short, in the very recent paper 41]. Extending Kusuoka-Zhou's method, he has constructed a $p$-energy and the corresponding $p$-energy measure for $p>\operatorname{dim}_{A R}\left(\mathrm{PSC}, d_{E}\right)$, and done detailed analysis of those objects. In particular, he has shown that the collection of functions with finite $p$-energies is a Banach space that is reflexive and separable. His proof of reflexivity and separability can be easily extended to our general case as well. See Theorem 6.22 for details.

Our framework on metric spaces is the theory of partitions introduced in [34]. Let $(K, d)$ be a compact metric space. We always suppose that $(K, d)$ is

connected in this paper. Roughly speaking, a partition of $K$ is a sequence of successive divisions of $K$ by some of its compact subsets. The idea is illustrated in Figure 2, Let $T_{0}=\{\phi\}$ and set $K_{\phi}=K$. Starting from $K$, we first divide $K$ into finite number of children $K_{w}$ for $w \in T_{1}$, i.e.

$$
K=\bigcup_{w \in T_{1}} K_{w}
$$

$T_{1}$ is thought of as the collection of its children of $T_{0}$ and denoted by $S(\phi)$. Then we repeat this process of division, i.e. each $w \in T_{1}$ has a collection of its children, $S(w)$, such that

$$
K_{w}=\bigcup_{v \in S(w)} K_{v}
$$

Define $T_{2}$ as the disjoint union of the $S(w)$ 's for $w \in T_{1}$. So repeating this process inductively, we have $\left\{T_{n}\right\}_{n \geq 0}$ where each $w \in T_{n}$ has the collection of its children $S(w) \subseteq T_{n+1}$. Set

$$
T=\bigcup_{n \geq 0} T_{n}
$$

With several requirements described in Section 2, the family $\left\{K_{w}\right\}_{w \in T}$ is called a partition of $K$.

For each $n \geq 1, T_{n}$ has a natural graph structure associated with a given partition $\left\{K_{w}\right\}_{w \in T}$. Namely, if

$$
E_{n}^{*}=\left\{(u, v) \mid u, v \in T_{n}, K_{u} \cap K_{v} \neq \emptyset\right\}
$$

then $\left(T_{n}, E_{n}^{*}\right)$ is a connected graph, which is illustrated in Figure 3. To avoid technical complexity, we are going to explain our results under Assumption 2.15 hereafter in the introduction. In fact, if $(K, d)$ is $\alpha$-Ahlfors regular for some $\alpha$

and the metric $d$ is 1 -adapted in the sense of 34, then Assumption 2.15 holds. So our setting should be broad enough.

For $A \subseteq T_{n}$, we define the $p$-energy of a function on $A$ by

$$
\mathcal{E}_{p, A}^{n}(f)=\frac{1}{2} \sum_{\substack{u, v \in A \\(u, v) \in E_{n}^{*}}}|f(u)-f(v)|^{p} .
$$

To carry out our strategy, we introduce two key characteristic quantities which are conductance and neighbor disparity constants. For $A_{1}, A_{2}, A \subseteq T_{n}$ with $A_{1}, A_{2} \subseteq A$ and $A_{1} \cap A_{2}=\emptyset$, define the $p$-conductance between $A_{1}$ and $A_{2}$ in $A$ at the level $m$ by

$$
\mathcal{E}_{p, m}\left(A_{1}, A_{2}, A\right)=\inf \left\{\mathcal{E}_{p, A}^{n+m}(f)\left|f: S^{m}(A) \rightarrow \mathbb{R}, f\right|_{S^{m}\left(A_{1}\right)} \equiv 1,\left.f\right|_{S^{m}\left(A_{2}\right)} \equiv 0\right\},
$$

where $S^{m}(A) \subseteq T_{n+m}$ is the collection of the descendants in the $m$-th generation from $A$.
Remark. Attaching a resistor of resistance 1 to each edge $(u, v) \in E_{n+m}^{*}$, we may consider the graph $\left(T_{n+m}, E_{n+m}^{*}\right)$ as an electric network. In this respect, the reciprocal of $\mathcal{E}_{2, m}\left(A_{1}, A_{2}, A\right)$ is the effective resistance between $A_{1}$ and $A_{2}$ within $A$ and hence $\mathcal{E}_{2, m}\left(A_{1}, A_{2}, A\right)$ corresponds to the effective conductance. Such an analogy has been often used in the study of random walks. See [18 for a classical reference. In potential theory, the quantity $\mathcal{E}_{2, m}\left(A_{1}, A_{2}, A\right)$ is called "capacity" as well.

In particular, for $w \in T_{n}$, define

$$
\mathcal{E}_{p, m}(w)=\mathcal{E}_{p, m}\left(\{w\}, \Gamma_{1}(w)^{c}, T_{n}\right),
$$

where $\Gamma_{1}(w)$ is the collection of neighbors of $w$ in $T_{n}$ given by

$$
\Gamma_{1}(w)=\left\{v \mid v \in T_{n},(w, v) \in E_{n}^{*}\right\} .
$$

The value $\mathcal{E}_{p, m}(w)$ represents the $p$-conductance between $w$ and the complement of its neighborhood $\Gamma_{1}(w)$ in the $m$-th generation from $w$. In 34, it was shown that

$$
\begin{equation*}
\limsup _{m \rightarrow \infty}\left(\sup _{w \in T} \mathcal{E}_{p, m}(w)^{\frac{1}{m}}\right)<1 \text { if and only if } p>\operatorname{dim}_{A R}(K, d) \tag{1.2}
\end{equation*}
$$

The other one, the neighbor disparity constant, is defined as

$$
\sigma_{p, m, n}=\sup _{(w, v) \in E_{n}^{*}}\left(\sup _{f: S^{m}(w, v) \rightarrow \mathbb{R}} \frac{\left|(f)_{S^{m}(w)}-(f)_{S^{m}(v)}\right|^{p}}{\mathcal{E}_{p, S^{m}(w, v)}^{n+m}(f)}\right),
$$

where $S^{m}(w, v)=S^{m}(w) \cup S^{m}(v)$ and $(f)_{S^{m}(w)}$ is the average of $f$ on $S^{m}(w)$ under a suitable measure $\mu$. For the case $p=2$, this constant was introduced in 36. The neighbor disparity constant controls the difference of means of a function on neighboring cells via the $p$-energy.

And now, $p$-conductive homogeneity, which is the principal notion of this paper, is defined as follows.

Definition 1.1. ( $K, d$ ) is said to be $p$-conductively homogeneous if and only if there exists $c>0$ such that

$$
\sup _{w \in T} \mathcal{E}_{p, m}(w) \sup _{n \geq 1} \sigma_{p, m, n} \leq c
$$

for any $m \geq 1$.
At a glance, it does not quite look like "homogeneity". The following theorem, however, gives the legitimacy of the name.

Theorem 1.2 (Theorem8.1). $(K, d)$ is $p$-conductively homogeneous if and only if there exist $\sigma>0$ and $c_{1}, c_{2}>0$ such that

$$
c_{1} \sigma^{-m} \leq \mathcal{E}_{p, m}(w) \leq c_{2} \sigma^{-m}
$$

for any $w \in T \backslash\{\phi\}$ and $m \geq 1$ and

$$
c_{1} \sigma^{m} \leq \sigma_{p, m, n} \leq c_{2} \sigma^{m}
$$

for any $m, n \geq 1$.
The next natural question is how the conductive homogeneity is related to construction of a p-energy. The answer is the next theorem which follows by combining Theorems 6.5, 6.21, 6.23 and Lemma 8.5 .

Theorem 1.3. Suppose $p>\operatorname{dim}_{A R}(K, d)$ and $(K, d)$ is $p$-conductively homogeneous. Let $C(K)$ be the collection of continuous functions on $K$. Define

$$
\mathcal{N}_{p}(f)=\left(\sup _{m \geq 0} \sigma^{m} \mathcal{E}_{p}^{m}\left(P_{m} f\right)\right)^{\frac{1}{p}}
$$

for $f \in L^{p}(K, \mu)$, where

$$
\left(P_{m} f\right)(w)=\frac{1}{\mu\left(K_{w}\right)} \int_{K_{w}} f(x) \mu(d x)
$$

and

$$
\mathcal{W}^{p}=\left\{f \mid f \in L^{p}(K, \mu), \mathcal{N}_{p}(f)<\infty\right\} .
$$

Then $\mathcal{N}_{p}(f)=0$ if and only if $f$ is constant on $K, \mathcal{N}_{p}$ is a semi-norm of $\mathcal{W}^{p},\left(\mathcal{W}^{p},\|\cdot\|_{p, \mu}+\mathcal{N}_{p}(\cdot)\right)$ is a Banach space and $\mathcal{W}^{p}$ is a dense subset of $\left(C(K),\|\cdot\|_{\infty}\right)$. Moreover, there exists $\widehat{\mathcal{E}}_{p}: \mathcal{W}^{p} \rightarrow[0, \infty)$ such that $\widehat{\mathcal{E}}_{p}^{\frac{1}{p}}$ is a semi-norm of $\mathcal{W}^{p}$ which is equivalent to $\mathcal{N}_{p}(\cdot), \widehat{\mathcal{E}}_{p}$ satisfies the Markov property and there exist $\tau>0$ and $c_{1}, c_{2}>0$ such that

$$
c_{1} d(x, y)^{\tau} \leq \sup _{\substack{f \in \mathcal{W}^{p} \\ \mathcal{\mathcal { E }}_{p}(f) \neq 0}} \frac{|f(x)-f(y)|^{p}}{\widehat{\mathcal{E}}_{p}(f)} \leq c_{2} d(x, y)^{\tau}
$$

for any $x, y \in K$. In particular, for $p=2$, one can choose $\left(\widehat{\mathcal{E}}_{2}, \mathcal{W}^{2}\right)$ as a local regular Dirichlet form on $L^{2}(K, \mu)$.

Note that by 1.2 , the condition $p>\operatorname{dim}_{A R}(K, d)$ implies $\sigma>1$. An explicit description of the constant $\tau$ is given in Lemma 8.5. In addition, we show a sub-Gaussian type heat kernel estimate for the diffusion process induced by the Dirichlet form $\left(\widehat{\mathcal{E}}_{2}, \mathcal{W}^{2}\right)$ in Theorem 8.6. Moreover, if $(K, d)$ is a self-similar set with rationally related contraction ratios, then a self-similar $p$-energy which is equivalent to $\mathcal{N}_{p}$ will be constructed in Section 9 .

Another important question is how to show conductive homogeneity. The following theorem provides an equivalent and useful condition for this purpose.

Theorem 1.4 (Theorem 8.4). Suppose that $p>\operatorname{dim}_{A R}(K, d)$. (K,d) is $p$ conductively homogeneous if and only if, for any $k \geq 1$, there exists $c(k)>0$ such that

$$
\begin{equation*}
\sup _{z \in T} \mathcal{E}_{p, m}(z) \leq c(k) \mathcal{E}_{p, m}\left(u, v, S^{k}(w)\right) \tag{1.3}
\end{equation*}
$$

for any $m \geq 1, w \in T$ and $u, v \in S^{k}(w)$ with $u \neq v$.
The condition (1.3), which is the same as 8.4 in Theorem 8.4, is a relative of the "Knight move" condition in [36] described in the terminology of random walks, although the word "Knight move" does not make sense from the appearance of (1.3) any longer. The original "Knight move" in [1 was the name of an argument based on the symmetry of the Sierpinski carpet to show a probabilistic counterpart of (1.3). With certain symmetries of the space, it is possible to show the condition (1.3) by the method of combinatorial modulus in [11]. Applying Theorem 1.4, we are going to show the conductive homogeneity for examples like those in Figure 1 in Sections 12 and 13.

Besides applications, Theorem 1.4 has a remarkable theoretical consequence; conductive homogeneity is determined only by conductance constants and independent of the neighbor disparity constants if $p>\operatorname{dim}_{A R}(K, d)$. This is the reason conductive homogeneity is called "conductive" homogeneity.

The major methodological backgrounds of this paper are Kusuoka-Zhou's arguments in [36] and combinatorial moduli of path families on graphs introduced in [11. On many occasions, we will extend Kusuoka-Zhou's results to compact metric spaces and to general values of $p$. On such occasions, we will put a reference to the original result by Kusuoka and Zhou right behind the number of the propositions and lemmas like "Lemma 5.2 ([36, (2.12) lemma])". Beyond Kusuoka-Zhou's arguments, the notion of combinatorial modulus will play a crucial role on several occasions. The most important one is in the proof of a sub-multiplicative inequality of conductance constants, Corollary 4.4 Moreover, by Lemma C.4, one can compare moduli of different graphs and this lemma is indispensable for showing (1.3) in Sections 11 and 13.

Regrettably, we do not have much for the case $p \leq \operatorname{dim}_{A R}(K, d)$. In Section 7. we will construct a function space $\mathcal{W}^{p}$ and a semi-norm $\widehat{\mathcal{E}}_{p}$ on $\mathcal{W}^{p}$ under $p$-conductive homogeneity for $p \in\left[1, \operatorname{dim}_{A R}(K, d)\right]$. In this case, however, $\mathcal{W}^{p}$ is given as a subspace of $L^{p}(K, \mu)$ and we do not know whether $\mathcal{W}^{p} \cap C(K)$ is dense in $\left(C(K),\|\cdot\|_{\infty}\right)$ or not. This is due to the lack of an elliptic Harnack principle of $p$-harmonic functions on the corresponding graphs. In the case $p=2$, using the coupling method, Barlow and Bass conquered this difficulty for higher dimensional Sierpinski carpets in [5] and [6]. We have little idea what is an analytic counterpart of the coupling method at this moment. It is a big open problem for future work. In particular, it is interesting to know whether the following naive conjecture is true or not.

Conjecture. $\mathcal{W}^{p} \subseteq C(K)$ if and only if $p>\operatorname{dim}_{A R}(K, d)$.
Now we briefly explain what happens in the cases of familiar examples.

1. Unit (hyper)cube $[-1,1]^{n}$ : In this case, for any $p>n$,

$$
\mathcal{W}^{p}=W^{1, p}\left([-1,1]^{n}\right)
$$

and there exists $c>0$ such that

$$
c \widehat{\mathcal{E}}_{p}(f) \leq \int_{[-1,1]^{n}}|\nabla f|^{p} d x \leq c^{-1} \widehat{\mathcal{E}}_{p}(f)
$$

for any $f \in W^{1, p}\left([-1,1]^{n}\right)$. See Example 12.7 for details. Even if $p \in[1, n]$, the above results should be true but we do not have any proof for now.
2. von Koch curve (Figure 4): The von Koch curve does not contain any rectifiable curve, so that the approaches using upper gradients do not work from the beginning. However, our theory does not distinguish metric spaces which are snowflake equivalent, i.e. two metric spaces $\left(X, d_{X}\right)$ and $\left(Y, d_{Y}\right)$ are snowflake equivalent if there exist a homeomorphism $\varphi: X \rightarrow Y, c_{1}, c_{2}>0$ and $\alpha>0$ such that

$$
c_{1} d_{X}\left(x_{1}, x_{2}\right)^{\alpha} \leq d_{Y}\left(\varphi\left(x_{1}\right), \varphi\left(x_{2}\right)\right) \leq c_{2} d_{X}\left(x_{1}, x_{2}\right)^{\alpha}
$$

for any $x_{1}, x_{2} \in X$. Since the von Koch curve is snowflake equivalent to the unit interval $[0,1]$, we see that $\mathcal{W}^{p}$ for the von Koch curve equals $W^{1, p}([0,1])$ for any $p>1$.
3. Planar Sierpinski carpet (Figure 4): As is mentioned above, this is one of the original motivations of this paper and it is expected that our space $\mathcal{W}^{p}$ is quite different from what one may get from the upper gradient approaches. By Theorem 11.5, the planar Sierpinski carpet $K$ is shown to be $p$-conductive homogeneous for any $p>\operatorname{dim}_{A R}\left(K, d_{*}\right)$, where $d_{*}$ is the restriction of the Euclidean metric. Moreover, let $\alpha_{H}=\frac{\log 8}{\log 3}$ and let $\beta_{p}=\frac{\log 8 \sigma}{\log 3}$, where $\sigma$ is the exponent appearing in Theorem 1.2. Then by [41, Theorem 2.19], we have a fractional Korevaar-Shoen type expression of $\mathcal{W}^{p}$ as follows:

\mathcal{W}^{p}=\left\{f \mid f \in L^{p}(K, \mu), \limsup _{r \downarrow 0} \int_{K} \frac{1}{r^{\alpha_{H}}} \int_{B_{d_{*}}(x, r)} \frac{|f(x)-f(y)|^{p}}{r^{\beta_{p}}} d x d y<\infty\right\}
$$

Furthermore it is shown in 41] that $\beta_{p}>p$. This fact implies that $\mathcal{W}^{p}$ should not coincide with any of the spaces obtained by approaches using upper gradients. 4. Sierpinski gasket (Figure 4): Let $K$ be the standard Sierpinski gasket and let $d_{*}$ be the restriction of the Euclidean metric. Since $K$ is one of nested fractals and $\operatorname{dim}_{A R}\left(K, d_{*}\right)=1$, Theorem 14.12 yields that $K$ is $p$-conductively homogeneous for any $p>1$. Arguments analogous to those in [41, Section 5.3] give the same fractional Korevaar-Shoen type expression of $\mathcal{W}^{p}$ as the planar Sierpinski carpet. In this case, $\alpha_{H}=\frac{\log 3}{\log 2}$ and $\beta_{p}=\frac{\log 3 \sigma}{\log 2}$. We expect that $\beta_{p}>p$ for any $p>1$. In fact, due to [8, we know $\beta_{2}=\frac{\log 5}{\log 2}>2$. Moreover, $\beta_{p} / p$ is monotonically decreasing by [34, Lemma 4.7.3]. So at least for $p \in(1,2]$, $\beta_{p}>p$ and the space $\mathcal{W}^{p}$ does not seem to be obtained by the upper gradient approaches. However in this case, if we replace the Euclidean metric with the harmonic geodesic metric and the Hausdorff measure with the Kusuoka measure, then the heat kernel associated with the new pair of the metric and the measure has the Gaussian estimate. See 30 for details. Consequently, the Cheeger theory [15] is now in place for $\mathcal{W}^{2}$ at least. On the other hand, the replacement of the metric and the measure causes a change of the partition and, consequently, a change of the associated function space $\mathcal{W}^{P}$. So, we expect that $\mathcal{W}^{p}$ associated with the new pair may coincide with those obtained from the approaches based on upper gradients but we have no proof so far.

Before the conclusion of the introduction, we mention two related works. The first one is [10], where the authors constructed another type of "Sobolev
spaces" $\dot{A}_{p}(X)$ on a compact metric space $(Z, d)$ from its hyperbolic fillings $X$. The method is to construct a discretization $P f$ on $X$ of $f \in L^{1}(Z)$, and to consider the weak $\ell^{p}$-norm of the gradient of $P f$. Their space $\dot{A}^{p}(Z)$ seems closely related to our space $\mathcal{W}^{p}$ but we merely know that $\mathcal{W}^{p} \subseteq \dot{A}_{p}(X)$ under suitable assumptions at this point. The second one is [24], where the authors constructed a $p$-energy on Sierpinski gasket type self-similar sets by extending the notion of harmonic structures in the case of $p=2$ for post critically finite self-similar sets. Their $p$-energy should be equivalent to ours, although they did not show the completeness of the domain of their $p$-energy. Despite the fact that their method can work only for finitely ramified self-similar sets even if $p=2$, their work is the first pioneering study to construct a $p$-energy by renormalizing discrete counterparts.

The organization of this paper is as follows. In Section2, we review the basics of partitions of compact metric spaces and then give a framework of this paper including standing assumptions, Assumptions 2.6, 2.7, 2.10 and 2.12 In the end, we present Assumption 2.15, which is stronger than the combination of all the assumptions above but more concise. In Section 3, we introduce the notion of conductance constant which is one of two principal quantities of this paper and we show the existence of a partition of unity associated with the conductance constant. In Section 4 we introduce the notion of combinatorial moduli of path families on graphs and show a sub-multiplicative inequality for conductance constants using them. In Section 5, we introduce the other principal quantity, the neighbor disparity constant and show its relation with the conductance constant and a sub-multiplicative inequality of them. In Section 6. we construct our function space $\mathcal{W}^{p}$ and the p-energy $\widehat{\mathcal{E}}_{p}$ under Assumption 6.2 and show Theorem 1.3 . At the same time, we propose a condition called $p$-conducive homogeneity and show, in Section 8, that the condition $p>\operatorname{dim}_{A R}(K, d)$ and $p$ conductive homogeneity imply Assumption 6.2. In Section 7, we see what we can do for $p \leq \operatorname{dim}_{A R}(K, d)$. In Section 8, we show Theorem 8.1 ( $=$ Theorem 1.2 and Theorem 8.4 ( $=$ Theorem 1.4). Moreover, in Theorem 8.6, we give a subGaussian type heat kernel estimate for the diffusion process induced by the Dirichlet form $\left(\mathcal{E}, \mathcal{W}^{2}\right)$ given in Section 6. In Section 9, we construct a selfsimilar $p$-energy for self-similar sets with rationally related contraction ratios. In Section 10 , we give a sufficient condition for the conductive homogeneity for selfsimilar sets. Section 11 is devoted to a class of self-similar sets called subsystems of cubic tiling, for which conductive homogeneity is shown through Theorem 8.4 This class includes the Sierpinski carpets, the Menger curve, and the higher dimensional hypercubes. In Section 12, we present examples of subsystems of cubic tiling having the conductive homogeneity. Also, Section 13 is devoted to showing conductive homogeneity of rationally ramified Sierpinski crosses. In Sections 15, 16 and 17, we give a proof of Theorem 8.4. In Section 18, we show the conductance, Poincaré and the neighbor disparity constants are uniformly bounded from below and above. We will briefly discuss the modification of the graph structure in Section 19. Finally, in Section 20, we gather open problems and future directions of research. Appendices give basic facts used in this paper.

## 2 Framework

In this section, we are going to make our framework of this paper clear. It is based on the notion of partitions of compact metric spaces parametrized by rooted trees, which was introduced in [34. Roughly speaking, a partition is successive divisions of a given space like the binary division of the unit interval. See [34] for examples. Since this notion is relatively new and unfamiliar to most of the readers, we will give a minimal but detailed account of its definition.

To start with, we present the basics of graphs and trees.
Definition 2.1. Let $T$ be a countable set and let $\mathcal{A}: T \times T \rightarrow\{0,1\}$ which satisfies $\mathcal{A}(w, v)=\mathcal{A}(v, w)$ and $\mathcal{A}(w, w)=0$ for any $w, v \in T$. We call the pair $(T, \mathcal{A})$ a (non-directed) graph with the vertices $T$ and the adjacency matrix $\mathcal{A}$. An element $(u, v) \in T \times T$ is called an edge of $(T, \mathcal{A})$ if and only if $\mathcal{A}(u, v)=1$. We often identify the adjacency matrix $\mathcal{A}$ with the collection of edges $\{(u, v) \mid u, v \in T, \mathcal{A}(u, v)=1\}$.
(1) A graph $(T, \mathcal{A})$ is called locally finite if $\#(\{v \mid \mathcal{A}(w, v)=1\})<\infty$ for any $w \in T$, where $\#(A)$ is the number of elements of a set $A$.
(2) For $w_{0}, \ldots, w_{n} \in T,\left(w_{0}, w_{1}, \ldots, w_{n}\right)$ is called a path between $w_{0}$ and $w_{n}$ if $\mathcal{A}\left(w_{i}, w_{i+1}\right)=1$ for any $i=0,1, \ldots n-1$. A path $\left(w_{0}, w_{1}, \ldots, w_{n}\right)$ is called simple if and only if $w_{i} \neq w_{j}$ for any $i, j$ with $0 \leq i<j \leq n$ and $|i-j|<n$.
(3) $(T, \mathcal{A})$ is called a tree if and only if there exists a unique simple path between $w$ and $v$ for any $w, v \in T$ with $w \neq v$. For a tree $(T, \mathcal{A})$, the unique simple path between two vertices $w$ and $v$ is called the geodesic between $w$ and $v$ and denoted by $\overline{w v}$. We write $u \in \overline{w v}$ if $\overline{w v}=\left(w_{0}, w_{1}, \ldots, w_{n}\right)$ and $u=w_{i}$ for some $i$.

Next, we define fundamental notions on trees.
Definition 2.2. Let $(T, \mathcal{A})$ be a tree and let $\phi \in T$. The triple $(T, \mathcal{A}, \phi)$ is called a rooted tree with a root (or a reference point, see 44] e.g.) $\phi$.
(1) Define $\pi: T \rightarrow T$ by

\pi(w)= \begin{cases}w_{n-1} & \text { if } w \neq \phi \text { and } \overline{\phi w}=\left(w_{0}, w_{1}, \ldots, w_{n-1}, w_{n}\right) \\ \phi & \text { if } w=\phi\end{cases}

and, for $w \in T$, set

S(w)=\{v \mid \pi(v)=w\} \backslash\{w\} .
$$

An element $v \in S(w)$ is thought of as a child of $w$. Moreover, for any $k \geq 1$, we define $S^{k}(w)$ inductively as

$$
S^{k+1}(w)=\bigcup_{v \in S(w)} S^{k}(v)
$$

which is the collection of descendants in the $k$-th generation from $w$.
(2) For $w \in T$ and $m \geq 0$, we define

$$
|w|=\min \left\{n \mid n \geq 0, \pi^{n}(w)=\phi\right\} \quad \text { and } \quad T_{m}=\{w|w \in T,|w|=m\}
$$

(3) For any $w \in T$, define

$$
T(w)=\left\{v \mid \text { there exists } n \geq 0 \text { such that } \pi^{n}(v)=w\right\}
$$

which is the collection of all the descendants of $w$.
(4) Define

$$
\Sigma=\left\{(w(i))_{i \geq 0} \mid w(i) \in T_{i} \text { and } w(i)=\pi(w(i+1)) \text { for any } i \geq 0\right\}
$$

For $\omega=(\omega(i))_{i \geq 0} \in \Sigma$, set $[\omega]_{m}=\omega(m)$ for $m \geq 0$. An element $(w(i))_{i \geq 0} \in \Sigma$ is called a geodesic ray starting from $\phi$ in [44].

Remark. In [34, we have used $(T)_{n}$ and $T_{w}$ in place of $T_{n}$ and $T(w)$ respectively.
Throughout this paper, $T$ is a countably infinite set and $(T, \mathcal{A})$ is a locally finite tree satisfying $\#(\{v \mid(w, v) \in \mathcal{A}\}) \geq 2$ for any $w \in T$.

Next, we define partitions.
Definition 2.3 (Partition). Let $(K, \mathcal{O})$ be a compact metrizable topological space having no isolated point, where $\mathcal{O}$ is the collection of open sets.
(1) A collection of non-empty compact subsets $\left\{K_{w}\right\}_{w \in T}$ is called a partition of $K$ parametrized by $(T, \mathcal{A}, \phi)$ if and only if it satisfies the following conditions
(P1) and (P2).
(P1) $K_{\phi}=K$ and for any $w \in T, K_{w}$ has no isolated point and

$$
K_{w}=\bigcup_{v \in S(w)} K_{v} .
$$

(P2) For any $\omega \in \Sigma, \cap_{m \geq 0} K_{[\omega]_{m}}$ is a single point.

Originally in [34], we did not assume that $K$ is connected to include spaces like the Cantor set. In this paper, however, we will only deal with connected spaces. In such cases, the assumption that $K$ has no isolated point is always satisfied unless $K$ is a single point.
As an illustrative example of partitions, we present the case of the unit square $[-1,1]^{2}$ as a self-similar set. This is an example of the general construction of partitions associated with self-similar sets discussed in Section 9 .

Example 2.4 (the unit square). Let $K=[-1,1]^{2}$ and let $S=\{1,2,3,4\}$. Set $p_{1}=[-1,-1], p_{2}=[1,-1], p_{3}=[1,1]$ and $p_{4}=[-1,1]$. For $i \in S$, define $f_{i}(x)=\frac{1}{2}\left(x-p_{i}\right)+p_{i}$ for any $x \in \mathbb{R}^{2}$. Then it is obvious that

$$
K=\bigcup_{i \in S} f_{i}(K)
$$

This is the expression of the unit square as the self-similar set with respect to the collection of contractions $\left\{f_{i}\right\}_{i \in S}$. Let

In particular let $T_{0}=\{\phi\}$. Moreover define $T=\cup_{m \geq 0} T_{m}$ and define $\pi: T \rightarrow T$ by

\pi\left(i_{1} \ldots i_{n} i_{n+1}\right)=i_{1} \ldots i_{n}
$$

for any $i_{1} \ldots i_{n} i_{n+1} \in T_{n+1}$ for $n \geq 1$ and $\pi(\phi)=\phi$. Define $\mathcal{A}(w, v)$ for $w, v \in T$ as $\mathcal{A}(w, v)=1$ if $\pi(w)=v$ or $\pi(v)=w$ except for $(w, v)=(\phi, \phi)$. Then $(T, \mathcal{A}, \phi)$ is a rooted tree. For $w=w_{1} \ldots w_{n} \in T_{n}$, define

$$
f_{w}=f_{w_{1}} \circ \ldots \circ f_{w_{n}} \quad \text { and } \quad K_{w}=f_{w}(K)
$$

Then $\left\{K_{w}\right\}_{w \in T}$ is a partition of $K$ parametrized by $(T, \mathcal{A}, \phi)$. See Figure 5 .
The following definition is a collection of notions concerning partitions.
Definition 2.5. Let $\left\{K_{w}\right\}_{w \in T}$ be a partition of $K$ parametrized by $(T, \mathcal{A}, \phi)$. (1) Define $O_{w}$ and $B_{w}$ for $w \in T$ by

If $O_{w} \neq \emptyset$ for any $w \in T$, then the partition $K$ is called minimal.
(2) For any $A \subseteq T_{n}$ and $w \in A$, define $\Gamma_{M}^{A}(w) \subseteq T_{n}$ as

\Gamma_{M}^{A}(w) & =\{u \mid u \in A, \text { there exist } u(0), \ldots, u(M) \in A \text { such that } \\
u(0) & \left.=w, u(M)=u \text { and } K_{u(i)} \cap K_{u(i+1)} \neq \emptyset \text { for any } i=0, \ldots, M-1\right\} .
\end{aligned}
$$

For simplicity, for $w \in T_{n}$, we write $\Gamma_{M}(w)=\Gamma_{M}^{T_{n}}(w)$.
(3) $\left\{K_{w}\right\}_{w \in T}$ is called uniformly finite if and only if

$$

If a partition is minimal, then $O_{w}$ is actually the interior of $K_{w}$ and $B_{w}$ is the topological boundary of $K_{w}$. See [34, Proposition 2.2.3] for details.

In the case of the unit square in Example 2.4. $K_{w}$ is a square and $O_{w}$ (resp. $B_{w}$ ) is the interior (resp. the boundary) of $K_{w}$. Therefore, it is minimal. Moreover,

$$
\sup _{w \in T} \#\left(\Gamma_{1}(w)\right) \leq 8
$$

so that it is uniformly finite.
Now we give the first part of our framework in this paper.
Assumption 2.6. $T$ is a countably infinite set, $\phi \in T$, and $(T, \mathcal{A})$ is a locally finite tree satisfying $\#(\{w \mid(w, v) \in \mathcal{A}\}) \geq 2$ for any $w \in T$. $(K, \mathcal{O})$ is a compact connected metrizable space. $\left\{K_{w}\right\}_{w \in T}$ is a partition of $K$ parametrized by $(T, \mathcal{A}, \phi)$ that is minimal, and uniformly finite.
(1) For any $w \in T, K_{w}$ is connected.
(2) There exist $M_{*}$ and $k_{*} \in \mathbb{N}$ such that

$$
\begin{equation*}
\pi^{k_{*}}\left(\Gamma_{M_{*}+1}(w)\right) \subseteq \Gamma_{M_{*}}\left(\pi^{k_{*}}(w)\right) \tag{2.1}
\end{equation*}

for any $w \in T$.
(3) There exists $M_{0} \geq M_{*}$ such that

\Gamma_{M_{*}}(u) \cap S^{k}(w) \subseteq \Gamma_{M_{0}}^{S^{k}(w)}(u) \tag{2.2}
\end{equation*}

for any $w \in T, k \geq 1$ and $u \in S^{k}(w)$.
See Figure 6 for an illustrative exposition of Assumption 2.6 in the case of the unit square.
Remark. As is explicitly mentioned in Proposition 2.16. Assumption 2.6.(2) is always satisfied under mild additional assumptions.
Remark. If $M_{*}=1$, then we have $\Gamma_{M_{*}}(w) \cap A=\Gamma_{M_{*}}^{A}(w)$ for any $w$ and $A$. So in this case, by choosing $M_{0}=M_{*}=1$, Assumption 2.6(3) is always satisfied.

Throughout this paper, we set

Then, for any $m \in \mathbb{N}$,

Under Assumption 2.6 tition $\left\{K_{w}\right\}_{w \in T^{\left(k_{*}\right)}}$, where $T^{\left(k_{*}\right)}=\cup_{i \geq 0} T_{i k_{*}}$, the constant $k_{*}$ can be regarded as 1. So doing such replacement, we will adopt the following assumption.

Assumption 2.7. The constant $k_{*}$ appearing in 2.1 is 1 .
For a given partition $\left\{K_{w}\right\}_{w \in T}$, we always associate the following graph structure $E_{n}^{*}$ on $T_{n}$.

Proposition 2.8. For $n \geq 0$, define

$$
E_{n}^{*}=\left\{(w, v) \mid w, v \in T_{n}, w \neq v, K_{w} \cap K_{v} \neq \emptyset\right\}
$$

Then $\left(T_{n}, E_{n}^{*}\right)$ is a non-directed graph. Under Assumption 2.6, $\left(T_{n}, E_{n}^{*}\right)$ is connected for any $n \geq 0$, and

\Gamma_{1}(w)=\left\{v \mid v \in T_{n},(w, v) \in E_{n}^{*}\right\}
$$

for any $n \geq 0$ and $w \in T_{n}$.
Remark. In [34], $E_{n}^{*}$ is denoted by $J_{1, n}^{h}$.
Definition 2.9. For $w \in T_{n}$, define

$$
\begin{aligned}
& \partial S^{m}(w)=\left\{v \mid v \in S^{m}(w), \text { there exists } v^{\prime}\right. \in T_{n+m} \\
&\text { such that } \left.\left(v, v^{\prime}\right) \in E_{n+m}^{*} \text { and } \pi^{m}\left(v^{\prime}\right) \neq w .\right\}
\end{aligned}
$$

The set $\partial S^{m}(w)$ is a kind of a boundary of $S^{m}(w)$. In fact, it is easy to see

$$
\partial S^{m}(w)=\left\{v \mid v \in S^{m}(w), K_{v} \cap B_{w} \neq \emptyset\right\}
$$

where $B_{w}$ is the topological boundary of $K_{w}$ as is mentioned above. So the next assumption means that the boundary is not the whole space.

Assumption 2.10. There exists $m_{0} \geq 1$ such that $S^{m}(w) \backslash \partial S^{m}(w) \neq \emptyset$ for any $w \in T$ and $m \geq m_{0}$.

In Figure 7. we have an illustrative exposition of Assumption 2.10 in the case of the unit square.

Definition 2.11. For $w \in T, M \geq 1$ and $k \geq 1$, define

Remark. $B_{1, k}(w)=\partial S^{k}(w)$.
The final assumption is an assumption on a measure on $K$.
Assumption 2.12. $\mu$ is a Borel regular probability measure on $K$ satisfying

for any $w \in T$. There exists $\gamma \in(0,1)$ such that

for any $w \in T$. This property is called "super-exponential" in 34]. Moreover, there exists $\kappa>0$ such that if $w, v \in T,|w|=|v|$ and $(w, v) \in E_{|w|}^{*}$, then

The condition (2.6) corresponds to the gentleness of the measure $\mu$ introduced in [34. Indeed, if $\mu$ has the volume doubling property, then this condition is satisfied. See Proposition 2.16 and its proof below for an exact statement.

Lemma 2.13. Under Assumptions 2.6, 2.10 and 2.12,
(1) $\mu$ is exponential, i.e. $\mu$ satisfies (2.5) and there exist $m_{1} \geq 1$ and $\gamma_{1} \in(0,1)$ such that $\mu\left(K_{v}\right) \leq \gamma_{1} \mu\left(K_{w}\right)$ for any $w \in T$ and $v \in S^{m_{1}}(w)$.
(2)

$$
\sup _{w \in T} \#(S(w))<\infty .
$$

Throughout this paper, we set

Proof. (1) In fact, we set $m_{1}=m_{0}$. For any $w$ with $|w| \geq 1$ and $m \geq 0$, we see that $\partial S^{m}(w) \neq \emptyset$ because $K$ is connected. Hence by Assumption 2.10
$\#\left(S^{m_{0}}(w)\right) \geq 2$ for any $w \in T$. Let $v \in S^{m_{1}}(w)$. Then there exists $u \in S^{m_{1}}(w)$ with $v \neq u$. By 2.5,

\end{equation*}
$$

for any $w \in T, n \geq 0$ and $m \geq M m_{0}$.
Proof. By Assumption 2.10, we can inductively choose $v_{i} \in S^{i m_{0}}(w)$ for $i \geq 1$ such that $v_{i+1} \in S^{m_{0}}\left(v_{i}\right) \backslash \partial S^{m_{0}}\left(v_{i}\right)$ for any $i \geq 1$. At the same time, we see $v_{i} \notin$ $B_{i, i m_{0}}(w)$. If $m_{0} i<k \leq m_{0}(i+1)$, then $v \notin B_{i, k}(w)$ for $v=\pi^{m_{0}(i+1)-k}\left(v_{i+1}\right)$. So the first part of the claim has been verified. Now if $v \in S^{m}(w) \backslash B_{M, m}(w)$, then

\mu\left(\bigcup_{v \in S^{n}\left(S^{m}(w) \backslash B_{M, m}(w)\right)} K_{v}\right) \geq \mu\left(K_{v}\right) \geq \gamma^{m_{0} M} \mu\left(K_{w}\right)
$$

by Assumption 2.12 .
Until now, we have not considered any metric of $(K, \mathcal{O})$, which was merely assumed to be compact and metrizable. The introduction of a metric having suitable properties enables us to integrate the above assumptions into the following one.

Assumption 2.15. $T$ is a countably infinite set, $\phi \in T$, and $(T, \mathcal{A})$ is a locally finite tree satisfying $\#(\{w \mid(w, v) \in \mathcal{A}\}) \geq 2$ for any $w \in T$. $(K, d)$ is a compact connected metric space and $\operatorname{diam}(K, d)=1$, where $\operatorname{diam}(A, d)=$ $\sup _{x, y \in A} d(x, y)$ for a subset $A \subseteq B .\left\{K_{w}\right\}_{w \in T}$ is a partition of $K$ parametrized by $(T, \mathcal{A}, \phi)$ that is minimal and uniformly finite.
(1) For any $w \in T, K_{w}$ is connected.
(2) There exist $M_{*} \geq 1$ and $r \in(0,1)$ such that the following properties (2A), (2B), and (2C) hold;
(2A) Define $h_{r}: T \rightarrow(0,1]$ as $h_{r}(w)=r^{|w|}$. Then there exist $c_{1}, c_{2}>0$ such that

c_{1} h_{r}(w) \leq \operatorname{diam}\left(K_{w}, d\right) \leq c_{2} h_{r}(w)
$$

for any $w \in T$.
(2B) For $x \in K$ and $n \geq 1$, define

$$
U_{M}(x: n)=\bigcup_{\substack{w \in T_{n} \\ x \in K_{w}}} \bigcup_{v \in \Gamma_{M}(w)} K_{v}
$$

(See Figure 7 for examples of $U_{1}(\cdot: 2)$ in the case of the unit square.) Then there exist $c_{1}, c_{2}>0$ such that

$$
B_{d}\left(x, c_{1} r^{n}\right) \subseteq U_{M_{*}}(x: n) \subseteq B_{d}\left(x, c_{2} r^{n}\right)
$$

for any $n \geq 1$ and $x \in K$, where $B_{d}(x, r)=\{y \mid d(x, y)<r\}$.
(2C) There exist $c>0$ such that, for any $n \geq 1$ and $w \in T_{n}$, there exists $x \in K_{w}$ such that

$$
K_{w} \supseteq B_{d}\left(x, c r^{n}\right) .
$$

(3) $\mu$ is a Borel regular probability measure on $K$ that is exponential and has the volume doubling property with respect to the metric $d$. Furthermore, $\mu$ satisfies (2.4) for any $w \in T$.
(4) There exists $M_{0}$ such that 2.2 holds for any $w \in T, k \geq 1$ and $u \in S^{k}(w)$.
(5) For any $w \in T, \pi\left(\Gamma_{M_{*}+1}(w)\right) \subseteq \Gamma_{M_{*}}(\pi(w))$.

Remark. In the terminology of [34, the condition (2A) corresponds to the biLipschitz equivalence of $d$ and $h_{r}$, the condition (2B) says that the metric $d$ is $M_{*}$-adapted to $h_{r}$ and (2C) together with (2B) says the metric $d$ is thick. The combination of (2A), (2B) and (2C) is equivalent to that of (BF1) and (BF2) in [34, Section 4.3].
Remark. Modifying the original partition $\left\{K_{w}\right\}_{w \in T}$, we always obtain Assumption 2.15 (5) from Assumption $2.15(1),(2),(3)$ and (4). Namely, by Proposition 2.16, we have $k_{*}$ satisfying (2.1) under Assumption 2.15-(1), (2), (3) and (4). So, replacing the original partition $\left\{K_{w}\right\}_{w \in T}$ with $\left\{K_{w}\right\}_{w \in T^{\left(k_{*}\right)}}$, we may suppose $k_{*}=1$.

Proposition 2.16. Assumption 2.15(1), (2), (3) and (4) suffice Assumptions 2.6, 2.10 and 2.12.

Proof. About Assumption 2.6. (1) and (3) are included in Assumption 2.15 Since $d$ is $M_{*}$-adapted, [34, Proposition 4.4.4] shows the existence of $k_{*}$ required in Assumption 2.6.(2). By (2C) and (2B), there exists $m_{0} \geq 1$ such that

$$
K_{w} \supseteq B_{d}\left(x, c r^{n}\right) \supseteq U_{M_{*}}\left(x: n+m_{0}\right)
$$

for any $n \geq 1$ and $w \in T_{n}$, where the point $x \in K_{w}$ is chosen as in (2C). So if $v \in T_{n+m_{0}}$ and $x \in K_{v}$, then $K_{v} \subseteq B_{d}\left(x, c r^{n}\right)$ and hence $K_{v} \cap B_{w}=\emptyset$. Therefore Assumption 2.10 is satisfied. (2.4) is included in Assumption 2.15 and (2.5) follows from the fact that $\mu$ is exponential. Finally, 2.6 is a consequence of the volume doubling property by [34, Theorem 3.3.4].

Under Assumption 2.15, we may suppose further properties of the metric $d$ and the measure $\mu$. Namely, if $\alpha>\operatorname{dim}_{A R}(K, d)$, then by $(1.1)$, there exist an $\alpha$-Ahlfors regular metric $d_{*}$ which is quasisymmetric to $d$ and a Borel regular measure $\nu$ which is $\alpha$-Ahlfors regular with respect to $d_{*}$, i.e. there exist $c_{1}, c_{2}>0$ such that

$$
\begin{equation*}
c_{1} r^{\alpha} \leq \nu\left(B_{d_{*}}(x, r)\right) \leq c_{2} r^{\alpha} \tag{2.9}
\end{equation*}
$$

for any $x \in K$ and $r \in(0,2 \operatorname{diam}(K, d)]$. Replacing $d$ and $\mu$ by $d_{*}$ and $\nu$ respectively, we may assume that $d$ is $\alpha$-Ahlfors regular. Note that if $\mu$ is $\alpha$ Ahlfors regular with respect to $d$, then $\alpha$ is the Hausdorff dimension of $(K, d)$.

## 3 Conductance constant

Hereafter in this paper, we always presume Assumptions 2.6, 2.7, 2.10 and 2.12
In this section, we introduce the conductance constant $\mathcal{E}_{M, p, m}(w, A)$ and show the existence of a partition of unity whose $p$-energies are estimated by conductance constants from above. In the next section, using the method of combinatorial modulus, we will establish a sub-multiplicative inequality of conductance constants.

To begin with, we define $p$-energies of functions on graphs $\left(T_{n}, E_{n}^{*}\right)$ and the associated $p$-conductances between subsets.
Notation. Let $A$ be a set. Set

\ell(A)=\{f \mid f: A \rightarrow \mathbb{R}\} \tag{3.1}
\end{equation*}
$$

Definition 3.1. (1) Let $A \subseteq T_{n}$. For $f \in \ell(A)$, define $\mathcal{E}_{p, A}^{n}(u)$ by

$$
\mathcal{E}_{p, A}^{n}(f)=\frac{1}{2} \sum_{u, v \in A,(u, v) \in E_{n}^{*}}|f(u)-f(v)|^{p}
$$

(2) Let $A \subseteq T_{n}$ and let $A_{1}, A_{2} \subseteq A$. Define

$$
\mathcal{E}_{p, m}\left(A_{1}, A_{2}, A\right)=\inf \left\{\mathcal{E}_{p, S^{m}(A)}^{n+m}(f)\left|f \in \ell\left(S^{m}(A)\right), f\right|_{S^{m}\left(A_{1}\right)} \equiv 1,\left.f\right|_{S^{m}\left(A_{2}\right)} \equiv 0\right\}
$$

(3) Let $A \subseteq T_{n}$. For $w \in A$, define

$$
\mathcal{E}_{M, p, m}(w, A)=\mathcal{E}_{p, m}\left(\{w\}, A \backslash \Gamma_{M}^{A}(w), A\right),
$$

which is called the $p$-conductance constant of $w$ in $A$ at level $m$.
For simplicity, we often denote a set consisting of a single point, $\{w\}$, by $w$. For example, if $A_{1}$ and $A_{2}$ are single points $u$ and $v$ respectively, we sometimes write $\mathcal{E}_{p, m}(u, v, A)$ instead of $\mathcal{E}_{p, m}(\{u\},\{v\}, A)$.

Lemma 3.2.

$$
\mathcal{E}_{M_{0}, p, m}\left(u, S^{k}(w)\right) \leq \mathcal{E}_{M_{*}, p, m}\left(u, T_{|w|+k}\right)
$$

for any $w \in T, k \geq 0$ and $u \in S^{k}(w)$.

Proof. This follows from the assumption (2.2).
Remark. In case $M_{*}=1$, we always have $\Gamma_{1}^{A}(w)=\Gamma_{1}(w) \cap A$. Hence even without 2.2 ,

$$
\mathcal{E}_{1, p, m}\left(w, S^{k}(w)\right) \leq \mathcal{E}_{1, p, m}\left(w, T_{|w|+k}\right)
$$

for any $w \in T, k \geq 0$ and $u \in S^{k}(w)$.
The following lemma shows the existence of a partition of unity.
Lemma 3.3. Let $p \geq 1$ and let $A \subseteq T_{n}$. For any $w \in A$, there exists $\varphi_{w}$ : $S^{m}(A) \rightarrow[0,1]$ such that

\sum_{w \in A} \varphi_{w} \equiv 1,\left.\quad \varphi_{w}\right|_{S^{m}(w)} \geq\left(L_{*}\right)^{-M},\left.\quad \varphi_{w}\right|_{S^{m}(A) \backslash S^{m}\left(\Gamma_{M}^{A}(w)\right)} \equiv 0
$$

and

$$
\mathcal{E}_{p, S^{m}(A)}^{n+m}\left(\varphi_{w}\right) \leq\left(\left(L_{*}\right)^{2 M+1}+1\right)^{p} \max _{w^{\prime} \in \Gamma_{2 M+1}^{A}(w)} \mathcal{E}_{M, p, m}\left(w^{\prime}, A\right)
$$

Proof. Let $h_{w} \in \ell\left(S^{m}(A)\right)$ satisfy $\left.h_{w}\right|_{S^{m}(w)} \equiv 1,\left.h_{w}\right|_{S^{m}(A) \backslash S^{m}\left(\Gamma_{M}^{A}(w)\right)} \equiv 0$ and $\mathcal{E}_{M, p, m}(w, A)=\mathcal{E}_{p, S^{m}(A)}^{n+m}\left(h_{w}\right)$. Define $h \in \ell\left(S^{m}(A)\right)$ as

$$
h(v)=\sum_{w \in A} h_{w}(v)
$$

for any $v \in S^{m}(A)$. Note that $1 \leq h(v) \leq\left(L_{*}\right)^{M}$. Set $\varphi_{w}=h_{w} / h$ and $E_{n+m}(w)=E_{n+m}^{*} \cap S^{m}\left(\Gamma_{M+1}^{A}(w)\right)^{2}$. It follows that $\varphi_{w}(u)=\varphi_{w}(v)=0$ for any $(u, v) \notin E_{n+m}(w)$. Let $(u, v) \in E_{n+m}(w)$. Then $h_{w}(v)\left(h_{w^{\prime}}(v)-h_{w^{\prime}}(u)\right)=0$ for any $w^{\prime} \notin \Gamma_{2 M+1}^{A}(w)$. Hence

$$
\begin{array}{r}
\left|\varphi_{w}(u)-\varphi_{w}(v)\right|=\left|\frac{1}{h(u) h(v)}\left(h(v)\left(h_{w}(u)-h_{w}(v)\right)+h_{w}(v)(h(v)-h(u))\right)\right| \\
\leq\left|h_{w}(u)-h_{w}(v)\right|+\sum_{w^{\prime} \in \Gamma_{2 M+1}^{A}(w)}\left|h_{w^{\prime}}(u)-h_{w^{\prime}}(v)\right|
\end{array}
$$

Set $C=\left(L_{*}\right)^{2 M+1}+1$. Then the last inequality yields

$$
\begin{aligned}
& \mathcal{E}_{p}^{n+m}\left(\varphi_{w}\right)= \frac{1}{2} \sum_{(u, v) \in E_{n+m}(w)}\left|\varphi_{w}(u)-\varphi_{w}(v)\right|^{p} \\
& \leq \frac{C^{p-1}}{2} \sum_{(u, v) \in E_{n+m}(w)}\left(\left|h_{w}(u)-h_{w}(v)\right|^{p}+\sum_{w^{\prime} \in \Gamma_{2 M+1}^{A}(w)}\left|h_{w^{\prime}}(u)-h_{w^{\prime}}(v)\right|^{p}\right) \\
& \leq C^{p-1}\left(\mathcal{E}_{p, S^{m}(A)}^{n+m}\left(h_{w}\right)+\sum_{w^{\prime} \in \Gamma_{2 M+1}^{A}(w)} \mathcal{E}_{p, S^{m}(A)}^{n+m}\left(h_{w^{\prime}}\right)\right) \\
& \leq C^{p} \max _{w^{\prime} \in \Gamma_{2 M+1}^{A}(w)} \mathcal{E}_{M, p, m}\left(w^{\prime}, A\right) .
\end{aligned}
$$

In particular, in the case $A=T_{n}$, the associated partition of unity defined below will be used to show the regularity of the $p$-energy constructed in Section 6.

Definition 3.4. For $w \in T$, define $h_{M, w, m}^{*} \in \ell\left(T_{|w|+m}\right)$ as the unique function $h$ satisfying $\left.h\right|_{S^{m}(w)}=1,\left.h\right|_{T_{|w|+m} \backslash S^{m}\left(\Gamma_{M}(w)\right)}=0$ and

$$
\mathcal{E}_{p}^{|w|+m}(h)=\mathcal{E}_{M, p, m}\left(w, T_{|w|}\right) .
$$

Moreover, define $\varphi_{M, w, m}^{*} \in \ell\left(T_{|w|+m}\right)$ by

$$
\varphi_{M, w, m}^{*}=\frac{h_{M, w, m}^{*}}{\sum_{v \in T_{|w|}} h_{M, v, m}^{*}}
$$

By the proof of Lemma 3.3

$$
\mathcal{E}_{p}^{n+m}\left(\varphi_{M, w, m}^{*}\right) \leq\left(\left(L_{*}\right)^{2 M+1}+1\right)^{p} \max _{v \in T_{n}} \mathcal{E}_{M, p, m}\left(v, T_{n}\right)
$$

for any $w \in T_{n}$.

## 4 Combinatorial modulus

Another principal tool of this paper is the notion of combinatorial modulus of a path family of a graph introduced in [11. The general theory is briefly reviewed in Appendix C. In this section, we introduce the notion of the $p$-modulus of paths between two sets and show a sub-multiplicative inequality for them.
Definition 4.1. (1) Define

E_{M, m}^{*}=\left\{(w, v) \mid w, v \in T_{m}, v \in \Gamma_{M}(w)\right\}
$$

Note that $E_{m}^{*}=E_{1, m}^{*}$. Moreover, define

\theta_{m}(w, v)=\min \left\{M \mid v \in \Gamma_{M}(w)\right\}
$$

for $w, v \in T_{m} . \theta_{m}(w, v)$ is the graph distance of the graph $\left(T_{m}, E_{m}^{*}\right)$.
(2) Let $A \subseteq T_{n}$ and let $A_{1}, A_{2} \subseteq A$. For $k \geq 0$, define

$$
\begin{gather*}
\mathcal{C}_{m}^{(M)}\left(A_{1}, A_{2}, A\right)=\left\{(v(1), \ldots, v(l)) \mid v(i) \in S^{m}(A) \text { for any } i=1, \ldots, l,\right. \\
\text { there exist } v(0) \in S^{m}\left(A_{1}\right) \text { and } v(l+1) \in S^{m}\left(A_{2}\right) \\
\left.\quad \text { such that }(v(i), v(i+1)) \in E_{M, n+m}^{*} \text { for any } i=0, \ldots, l .\right\}, \\
\mathcal{A}_{m}^{(M)}\left(A_{1}, A_{2}, A\right)=\left\{f \mid f: T_{n+m} \rightarrow[0, \infty)\right. \\
\left.\sum_{i=1}^{l} f(w(i)) \geq 1 \text { for any }(w(1), \ldots, w(l)) \in \mathcal{C}_{m}^{(M)}\left(A_{1}, A_{2}, A\right)\right\} \tag{4.1}
\end{gather*}
$$

and

$$
\begin{equation*}
\mathcal{M}_{p, m}^{(M)}\left(A_{1}, A_{2}, A\right)=\inf _{f \in \mathcal{A}_{m}^{(M)}\left(A_{1}, A_{2}, A\right)} \sum_{u \in T_{n+m}} f(u)^{p} . \tag{4.2}
\end{equation*}
$$

(3) For $w \in T_{n}$, define

$$
\mathcal{C}_{N, m}^{(M)}(w)=\mathcal{C}_{m}^{(M)}\left(\{w\}, \Gamma_{N}(w)^{c}, T_{n}\right), \mathcal{A}_{N, m}^{(M)}(w)=\mathcal{A}_{m}^{(M)}\left(\{w\}, \Gamma_{N}(w)^{c}, T_{n}\right)
$$

and

$$
\mathcal{M}_{N, p, m}^{(M)}(w)=\mathcal{M}_{p, m}^{(M)}\left(\{w\}, \Gamma_{N}(w)^{c}, T_{n}\right)
$$

The quantity $\mathcal{M}_{p, m}^{(M)}\left(A_{1}, A_{2}, A\right)$ is called the $p$-modulus of the family of paths between $A_{1}$ and $A_{2}$ inside $A$.
Remark. In 4.1 and 4.2, the domain of $f$ is $T_{n+m}$. However, since we only use $f(u)$ for $u \in S^{m}(A)$ in (4.1) and the sum in (4.2) becomes smaller by setting $f(u)=0$ for $u \in T_{n+m} \backslash S^{m}(A)$, we may think of the domain of $f$ as $S^{m}(A)$.

As is the case of conductances, if $A_{1}$ and $A_{2}$ consist of single points $u$ and $v$ respectively, then we write $\mathcal{C}_{m}^{(M)}(u, v, A), \mathcal{A}_{m}^{(M)}(u, v, A)$ and $\mathcal{M}_{p, m}^{(M)}(u, v, A)$ instead of $\mathcal{C}_{m}^{(M)}(\{u\},\{v\}, A), \mathcal{A}_{m}^{(M)}(\{u\},\{v\}, A)$ and $\mathcal{M}_{p, m}^{(M)}(\{u\},\{v\}, A)$ respectively.

By 34, Proposition 4.8.4], we have the following simple relation between $\mathcal{E}_{p, m}\left(A_{1}, A_{2}, A\right)$ and $\mathcal{M}_{p, m}^{(1)}\left(A_{1}, A_{2}, A\right)$. Consequently, to know $\mathcal{M}_{p, m}^{(1)}\left(A_{1}, A_{2}, A\right)$ is essential to know $\mathcal{E}_{p, m}\left(A_{1}, A_{2}, A\right)$.

Lemma 4.2. Let $A \subseteq T_{n}$ and let $A_{1}, A_{2} \subseteq A$ with $A_{1} \cap A_{2}=\emptyset$. Then for any $m \geq 1$ and $p>0$,

$$
\begin{equation*}
\frac{1}{L_{*}} \mathcal{E}_{p, m}\left(A_{1}, A_{2}, A\right) \leq \mathcal{M}_{p, m}^{(1)}\left(A_{1}, A_{2}, A\right) \leq 2 \max \left\{1,\left(L_{*}\right)^{p-1}\right\} \mathcal{E}_{p, m}\left(A_{1}, A_{2}, A\right) \tag{4.3}
\end{equation*}
$$

The following theorem is the main result of this section.
Theorem 4.3 (Sub-multiplicative inequality). Let $k_{0}, L, M \in \mathbb{N}$. Suppose that $\pi^{k_{0}}\left(\Gamma_{L+1}(u)\right) \subseteq \Gamma_{M}\left(\pi^{k_{0}}(u)\right)$ for any $u \in T$. Then

$$
\mathcal{M}_{M, p, k+l}^{(1)}(w) \leq \llbracket 4.3 \mathcal{M}_{M, p, k}^{(1)}(w) \max _{v \in S^{k}\left(\Gamma_{M}(w)\right)} \mathcal{M}_{L, p, l}^{(1)}(v)
$$

for any $l \in \mathbb{N}, k \geq k_{0}, w \in T$ and $p>0$, where 4.3 depends only $p, L_{*}$ and $L$.
Remark. If $\pi^{k_{0}}\left(\Gamma_{L+1}(u)\right) \subseteq \Gamma_{M}\left(\pi^{k_{0}}(u)\right)$, then $\pi^{k}\left(\Gamma_{L+1}(u)\right) \subseteq \Gamma_{M}\left(\pi^{k}(u)\right)$ for any $k \geq k_{0}$.

Similar sub-multiplicative inequalities for moduli of curve families have been shown in [11, Proposition 3.6], [14, Lemma 3.8] and [34, Lemma 4.9.3].

By Assumption 2.7, the assumption $\pi^{k_{0}}\left(\Gamma_{L+1}(u)\right) \subseteq \Gamma_{M}\left(\pi^{k_{0}}(u)\right)$ is satisfied with $M=L=M_{*}$ and $k_{0}=1$. This fact along with Lemma 4.2 shows the following sub-multiplicative inequality of conductance constants.

Corollary 4.4. For any $n, k, l \geq 1, w \in T_{n}$ and $p \geq 1$.
where the constant $4.4=44.4\left(p, L_{*}, M_{*}\right)$ depends only on $p, L_{*}$ and $M_{*}$.
The rest of this section is devoted to a proof of Theorem4.3.
Lemma 4.5. Let $A \subseteq T_{n}$ and let $A_{1}, A_{2} \subseteq A$ with $A_{1} \cap A_{2}=\emptyset$. Assume that $\Gamma_{M}(u) \cap S^{m}(A)$ is connected for any $u \in S^{m}(A)$. Then

$$
\mathcal{M}_{p, m}^{(1)}\left(A_{1}, A_{2}, A\right) \leq M_{p, m}^{(M)}\left(A_{1}, A_{2}, A\right) \leq\left(L_{*}\right)^{(p+1) M} \mathcal{M}_{p, m}^{(1)}\left(A_{1}, A_{2}, A\right)
$$

Proof. By definition,

\mathcal{C}_{m}^{(M)}\left(A_{1}, A_{2}, A\right) \supseteq \mathcal{C}_{m}^{(1)}\left(A_{1}, A_{2}, A\right) \text { and } \mathcal{A}_{m}^{(M)}\left(A_{1}, A_{2}, A\right) \subseteq \mathcal{A}_{m}^{(1)}\left(A_{1}, A_{2}, A\right)
$$

This shows

$$
\mathcal{M}_{p, m}^{(1)}\left(A_{1}, A_{2}, A\right) \leq M_{p, m}^{(M)}\left(A_{1}, A_{2}, A\right)
$$

Define

$$
H_{u}=\Gamma_{M}(u)
$$

for any $u \in(T)_{n+m}$. Then

$$
\#\left(H_{u}\right) \leq\left(L_{*}\right)^{M} \quad \text { and } \quad \#\left(\left\{v \mid u \in H_{v}\right\}\right) \leq\left(L_{*}\right)^{M}
$$

Let $(u(1), \ldots, u(l)) \in \mathcal{C}_{m}^{(M)}\left(A_{1}, A_{2}, A\right)$. Then there exist $u(0) \in S^{m}\left(A_{1}\right) \cap$ $\Gamma_{M}(u(1))$ and $u(l+1) \in S^{m}\left(A_{2}\right) \cap \Gamma_{M}(u(l))$. Since $u(0)$ and $u(1)$ is connected by a chain in $\Gamma_{M}(u(1))$ and $u(i)$ and $u(i+1)$ is connected by a chain in $\Gamma_{M}(u(i))$ for $i=1, \ldots, l$, we have a chain belonging to $\mathcal{C}_{m}^{(1)}\left(A_{1}, A_{2}, A\right)$ and contained in $\cup_{i=1, \ldots, n} H_{u(i)}$. Thus Lemma C. 4 shows

$$
\mathcal{M}_{p, m}^{(M)}\left(A_{1}, A_{2}, A\right) \leq\left(L_{*}\right)^{(p+1) M} \mathcal{M}_{p, m}^{(1)}\left(A_{1}, A_{2}, A\right)
$$

Proof of Theorem 4.3. Let $f \in \mathcal{A}_{M, k}^{(L+1)}(w)$ and let $g_{v} \in \mathcal{A}_{L, l}^{(1)}(v)$ for any $v \in$ $(T)_{|w|+k}$. Define $h:(T)_{|w|+k+l} \rightarrow[0, \infty)$ by

$$
h(u)=\max \left\{f(v) g_{v}(u) \mid v \in \Gamma_{L}\left(\pi^{l}(u)\right) \cap S^{k}\left(\Gamma_{M}(w)\right)\right\} \chi_{S^{k+l}\left(\Gamma_{M}(w)\right)}(u) .
$$

Claim 1. $h \in \mathcal{A}_{M, k+l}^{(1)}(w)$.
Proof of Claim 1: Let $(u(1), \ldots, u(m)) \in \mathcal{C}_{M, k+l}^{(1)}(w)$. There exist $u(0) \in$ $S^{k+l}(w)$ and $u(m+1) \in(T)_{|w|+k+l} \backslash S^{k+l}\left(\Gamma_{M}(w)\right)$ such that $u(0) \in \Gamma_{1}(u(1))$ and $u(m+1) \in \Gamma_{1}(u(m))$. Set $v(i)=\pi^{l}(u(i))$ for $i=0, \ldots, m+1$. Let $v_{*}(0)=v(0)$ and let $i_{0}=0$. Define $n_{*}, v_{*}(n)$ and $i_{n}$ for $i=1, \ldots, n_{*}$ inductively as follows: If

$$
\max \left\{j \mid i_{n} \leq j \leq m, v(j) \in \Gamma_{L}\left(v_{*}(n)\right)\right\}=m
$$

then $n=n_{*}$. If

$$
\max \left\{j \mid i_{n} \leq j \leq m, v(j) \in \Gamma_{L}\left(v_{*}(n)\right)\right\}<m
$$

then define

$$
i_{n+1}=\max \left\{j \mid i_{n} \leq j \leq m, v(j) \in \Gamma_{L}\left(v_{*}(n)\right)\right\}+1 \quad \text { and } \quad v_{*}(n+1)=v\left(i_{n+1}\right)
$$

The fact that $\pi^{k}\left(\Gamma_{L+1}\left(v_{*}(0)\right)\right) \subseteq \Gamma_{M}\left(\pi^{k}(v(0))\right)$ implies $n_{*} \geq 1$. Since $v\left(i_{n+1}-\right.$ 1) $\in \Gamma_{L}\left(v_{*}(n)\right)$, we have $v_{*}(n+1) \in \Gamma_{L+1}\left(v_{*}(n)\right)$. Hence $\left(v_{*}(1), \ldots, v_{*}\left(n_{*}\right)\right) \in$ $\mathcal{C}_{M, k}^{(L+1)}(w)$. Moreover, since $v_{*}(n-1) \notin \Gamma_{L}\left(v_{*}(n)\right)$ for $n=1, \ldots, n_{*}$, there exist $j_{n}$ and $m_{n}$ such that $i_{n-1}<j_{n} \leq m_{n}<i_{n}$ and $\left(u\left(j_{n}\right), \ldots, u\left(m_{n}\right)\right) \in \mathcal{C}_{L, l}^{(1)}\left(v_{*}(n)\right)$. Since $g_{v_{*}(n)} \in \mathcal{A}_{L, l}^{(1)}\left(v_{*}(n)\right)$, we have

$$
\sum_{i=j_{n}}^{m_{n}} h(u(i)) \geq \sum_{i=j_{n}}^{m_{n}} f\left(v_{*}(n)\right) g_{v_{*}(n)}(u(i)) \geq f\left(v_{*}(n)\right)
$$

This and the fact that $\left(v_{*}(1), \ldots, v_{*}\left(n_{*}\right)\right) \in \mathcal{C}_{M, k}^{(L+1)}(w)$ yield

$$
\sum_{i=1}^{m} h(u(i)) \geq \sum_{j=1}^{n_{*}} f\left(v_{*}(j)\right) \geq 1
$$

Thus Claim 1 has been verified.
Set $C_{0}=\max \left\{\left(L_{*}\right)^{L(p-1)}, 1\right\}$. Then by Lemma A.1, for $u \in S^{k+l}\left(\Gamma_{M}(w)\right)$,

$$
\begin{aligned}
& h(u)^{p} \leq\left(\sum_{v \in \Gamma_{L}\left(\pi^{l}(u)\right) \cap S^{k}\left(\Gamma_{M}(w)\right)} f(v) g_{v}(u)\right)^{p} \\
& \leq C_{0} \sum_{v \in \Gamma_{L}\left(\pi^{l}(u)\right) \cap S^{k}\left(\Gamma_{M}(w)\right)} f(v)^{p} g_{v}(u)^{p} .
\end{aligned}
$$

The above inequality and Claim 1 yield

$$
\mathcal{M}_{M, p, k+l}^{(1)}(w) \leq \sum_{u \in S^{k+l}\left(\Gamma_{M}(w)\right)} h(u)^{p} \leq C_{0} \sum_{v \in S^{k}\left(\Gamma_{M}(w)\right)} \sum_{u \in(T)_{|w|+k+l}} f(v)^{p} g_{v}(u)^{p}
$$

Taking infimum over $g_{v} \in \mathcal{A}_{L, l}^{(1)}(v)$ and $f \in \mathcal{A}_{M, k}^{(L+1)}(w)$, we have

$$
\begin{aligned}
\mathcal{M}_{M, p, k+l}^{(1)}(w) & \leq C \sum_{v \in S^{k}\left(\Gamma_{M}(w)\right)} f(v)^{p} \mathcal{M}_{L, p, l}^{(1)}(v) \\
& \leq C_{0} \sum_{v \in(T)_{|w|+k}} f(v)^{p} \max _{v \in S^{k}\left(\Gamma_{M}(w)\right)} \mathcal{M}_{L, p, l}^{(1)}(v) \\
& \leq C_{0} \mathcal{M}_{M, p, k}^{(L+1)}(w) \max _{v \in S^{k}\left(\Gamma_{M}(w)\right)} \mathcal{M}_{L, p, l}^{(1)}(v)
\end{aligned}
$$

Finally, applying Lemma 4.5, we have the desired inequality.

## 5 Neighbor disparity constant $\sigma_{p, m}(w, v)$

Another important constant in this paper is $\sigma_{p, m}(u, v)$, which is called the neighbor disparity constant. Neighbor disparity constant controls the difference between means of a function on two neighboring cells via the p-energy of the function. For $p=2, \sigma_{2, m}$ was introduced in [36] for the case of self-similar sets.
Notation. For $A \subseteq T_{n}$ and $f \in \ell(A)$, define

$$
(f)_{A}=\frac{1}{\sum_{v \in A} \mu\left(K_{w}\right)} \sum_{v \in A} f(w) \mu\left(K_{w}\right)
$$

Definition 5.1. For $p \geq 1, n \geq 1, m \geq 0$ and $(w, v) \in E_{n}^{*}$, define

$$
\sigma_{p, m}(w, v)=\sup _{f \in \ell\left(S^{m}(w) \cup S^{m}(v)\right)} \frac{\left|(f)_{S^{m}(w)}-(f)_{S^{m}(v)}\right|^{p}}{\mathcal{E}_{p, S^{m}(w) \cup S^{m}(v)}^{n+m}(f)}
$$

which is called the $p$-neighbor disparity constant of $(w, v)$ at level $m$. Moreover, define

$$
\sigma_{p, m, n}=\sup _{(w, v) \in E_{n}^{*}} \sigma_{p, m}(w, v) \quad \text { and } \quad \sigma_{p, m}=\sup _{n \geq 1} \sigma_{p, m, n}
$$

Remark. By Theorem 18.10 and Assumption $2.12, \sigma_{p, m, n}$ and $\sigma_{p, m}$ are finite.
One of the advantages of neighbor disparity constants is their compatibility with the integral projection $P_{n, m}$ from $\ell\left(T_{n+m}\right)$ to $\ell\left(T_{n}\right)$ as follows.

Lemma 5.2 ([36, (2.12) Lemma]). Let $p \geq 1$ and let $A \subseteq T_{n}$. Define $P_{n, m}$ : $\ell\left(S^{m}(A)\right) \rightarrow \ell(A)$ by

$$
\left(P_{n, m} f\right)(w)=(f)_{S^{m}(w)}
$$

for any $f \in \ell\left(S^{m}(A)\right)$ and $w \in A$. Then

$$
\mathcal{E}_{p, A}^{n}\left(P_{n, m} f\right) \leq L_{*} \max _{w, v \in A,(w, v) \in E_{n}^{*}} \sigma_{p, m}(w, v) \mathcal{E}_{p, S^{m}(A)}^{n+m}(f) .
$$

In particular, if $A_{1}, A_{2} \subseteq A$, then

$$
\begin{equation*}
\mathcal{E}_{p, 0}\left(A_{1}, A_{2}, A\right) \leq L_{*} \max _{w, v \in A,(w, v) \in E_{n}^{*}} \sigma_{p, m}(w, v) \mathcal{E}_{p, m}\left(A_{1}, A_{2}, A\right) \tag{5.1}
\end{equation*}
$$

for any $m \geq 0$.
Proof.

$$
\begin{aligned}
\mathcal{E}_{p, A}^{n}\left(P_{n, m}(f)\right)= & \frac{1}{2} \sum_{(w, v) \in E_{n}^{*}, w, v \in A}\left|(f)_{S^{m}(w)}-(f)_{S^{m}(v)}\right|^{p} \\
\leq & \frac{1}{2} \sum_{(w, v) \in E_{n}^{*}, w, v \in A} \sigma_{p, m}(w, v) \mathcal{E}_{p, S^{m}(w) \cup S^{m}(v)}^{n+m}(f) \\
& \leq L_{*} \max _{w, v \in A,(w, v) \in E_{n}^{*}} \sigma_{p, m}(w, v) \mathcal{E}_{p, S^{m}(A)}^{n+m}(f)
\end{aligned}
$$

Choose $f$ such that $\left.f\right|_{A_{1}} \equiv 1,\left.f\right|_{A_{0}} \equiv 0$ and $\mathcal{E}_{p, m}\left(A_{1}, A_{2}, A\right)=\mathcal{E}_{p, S^{m}(A)}^{n+m}(f)$. Then

$$
\mathcal{E}_{p, 0}\left(A_{1}, A_{2}, A\right) \leq \mathcal{E}_{p, A}^{n}\left(P_{n, m} f\right)
$$

So we have (5.1).
The first application of the above lemma is the following relation between conductance and neighbor disparity constants.

Lemma 5.3. Let $p \geq 1$ and let $A \subseteq T_{n}$. For any $m, l \geq 0$ and $v \in A$,

$$
\begin{equation*}
\mathcal{E}_{M, p, m}(v, A) \leq L_{*} \sigma_{p, l, n+m} \mathcal{E}_{M, p, m+l}(v, A) \tag{5.2}
\end{equation*}
$$

In particular, there exists 55.3, depending only on $M, p$ and $L_{*}$, such that if $A \neq \Gamma_{M}^{A}(v)$, then

$$
\begin{equation*}
\mathscr{5 . 3}\left(\mathcal{E}_{M, p, l}(v, A)\right)^{-1} \leq \sigma_{p, l, n} \tag{5.3}
\end{equation*}
$$

for any $n \geq 1$ and $l \geq 0$.
Proof. 5.2 is a special case of 5.1. To obtain (5.3), letting $m=0$ in 5.2, we have

$$
\mathcal{E}_{M, p, 0}(v, A) \leq L_{*} \sigma_{p, l, n} \mathcal{E}_{M, p, l}(v, A)
$$

By Theorem 18.3

$$
\begin{equation*}
\underline{c}_{\mathcal{E}}\left(L_{*},\left(L_{*}\right)^{M-1}, p\right) \leq \mathcal{E}_{M, p, 0}(v, A) . \tag{5.4}
\end{equation*}
$$

This immediately implies (5.3).
Another important consequence of Lemma 5.2 is a sub-multiplicative inequality of neighbor disparity constants.

Lemma 5.4 ([36, (2.13) Prop.-(3)]). Let $p \geq 1$.

$$
\sigma_{p, n+m, k} \leq\left(L_{*}\right)^{2} \sigma_{p, n, k} \sigma_{p, m, k+n}
$$

for any $n, m, k \in \mathbb{N}$.
Proof. Let $(w, v) \in E_{k}^{*}$. By Lemma 5.2 for any $f \in \ell\left(T_{k+n+m}\right)$,

$$
\begin{aligned}
&\left|(f)_{S^{n+m}(w)}-(f)_{S^{n+m}(v)}\right|^{p}= \mathcal{E}_{p,\{w, v\}}^{k}\left(P_{k, n}\left(P_{k+n, m} f\right)\right) \\
& \leq L_{*} \sigma_{p, n, k} \mathcal{E}_{p, S^{n}(w) \cup S^{n}(v)}^{k+n}\left(P_{k+n, m} f\right) \\
& \leq\left(L_{*}\right)^{2} \sigma_{p, n, k} \sigma_{p, m, k+n} \mathcal{E}_{p, S^{m+n}(w) \cup S^{n+m}(v)}^{n+m+k}(f)
\end{aligned}
$$

This implies

$$
\sigma_{p, n+m}(w, v) \leq\left(L_{*}\right)^{2} \sigma_{p, n, k} \sigma_{p, m, k+n}
$$

In the rest of this section, we study an estimate of the difference $f(u)-f(v)$ for $f: T_{n} \rightarrow \mathbb{R}$ and $u, v \in T$ by means of the $p$-energy $\mathcal{E}_{p}^{n}(f)$ and neighbor disparity constants.

Lemma 5.5. Let $w \in T$ and let $m \geq 1$. For any $f \in \ell\left(S^{m}(w)\right)$ and $u \in S(w)$,

$$
\left|(f)_{S^{m}(w)}-(f)_{S^{m-1}(u)}\right| \leq N_{*}\left(\sigma_{p, m-1,|w|+1}\right)^{\frac{1}{p}} \mathcal{E}_{p,, S^{m}(w)}^{|w|+m}(f)^{\frac{1}{p}}
$$

Proof. For any $v \in S(w)$, there exist $v_{0}, v_{1}, \ldots, v_{k} \in S(w)$ such that $k \leq N_{*}$, $v_{0}=v, v_{k}=u$ and $\left(v_{i}, v_{i+1}\right) \in E_{|w|+1}^{*}$ for any $i=0, \ldots, k-1$. Hence

$$
\begin{aligned}
& \left|(f)_{S^{m-1}(v)}-(f)_{S^{m-1}(u)}\right| \leq \sum_{i=1}^{k-1}\left|(f)_{S^{m-1}\left(v_{i}\right)}-(f)_{S^{m-1}\left(v_{i+1}\right)}\right| \\
& \leq N_{*}\left(\sigma_{p, m-1,|w|+1}\right)^{\frac{1}{p}} \mathcal{E}_{p, S^{m}(w)}^{|w|+m}(f)^{\frac{1}{p}}
\end{aligned}
$$

Combining this with

$$
(f)_{S^{m}(w)}-(f)_{S^{m-1}(u)}=\frac{1}{\mu(w)} \sum_{v \in S(w)}\left((f)_{S^{m-1}(v)}-(f)_{S^{m-1}(u)}\right) \mu(v)
$$

we obtain the desired inequality.
Lemma 5.6. Let $w \in T$ and let $n \geq m$. If $u, v \in S^{n}(w)$ and $\pi^{n-m}(u) \in$ $\Gamma_{k}\left(\pi^{n-m}(v)\right)$ for $k \geq 0$, then

$$
\begin{align*}
& |f(u)-f(v)| \leq \\
& \quad\left(2\left(N_{*}\right)^{2} \sum_{i=1}^{n-m}\left(\sigma_{p, n-m-i,|w|+m+i}\right)^{\frac{1}{p}}+k\left(\sigma_{p, n-m,|w|+m}\right)^{\frac{1}{p}}\right) \mathcal{E}_{p, S^{n}(w)}^{|w|+n}(f)^{\frac{1}{p}} \tag{5.5}
\end{align*}
$$

for any $f \in \ell\left(S^{n}(w)\right)$.
Proof. Set $v(i)=\pi^{n-m-i}(v)$ for $i=0, \ldots, n-m$. Then by Lemma 5.5.

$$
\begin{align*}
\left|f(v)-(f)_{S^{n-m}(v(0))}\right| \leq & \sum_{i=1}^{n-m}\left|(f)_{S^{n-m-i}(v(i))}-(f)_{S^{n-m-i+1}(v(i-1))}\right| \\
& \leq\left(N_{*}\right)^{2} \sum_{i=1}^{n-m}\left(\sigma_{p, n-m-i,|w|+m+i}\right)^{\frac{1}{p}} \mathcal{E}_{p, S^{n}(w)}^{|w|+n}(f)^{\frac{1}{p}} \tag{5.6}
\end{align*}
$$

The same inequality holds if we replace $v$ by $u$. Since $v(0) \in \Gamma_{k}(u(0))$, there exist $w(0), \ldots, w(l) \in \Gamma_{k}(u(0))$ such that $l \leq k, w(0)=u(0), w(l)=v(0)$ and $(w(i), w(i-1)) \in E_{|w|+m}^{*}$ for $i=1, \ldots, l$. Then

$$
\begin{align*}
&\left|(f)_{S^{n-m}(u(0))}-(f)_{S^{n-m}(v(0))}\right| \leq \sum_{i=1}^{l}\left|(f)_{S^{n-m}(w(i))}-(f)_{S^{n-m}(w(i-1))}\right| \\
& \leq k\left(\sigma_{p, n-m,|w|+m}\right)^{\frac{1}{p}} \mathcal{E}_{p, S^{n}(w)}^{|w|+n}(f)^{\frac{1}{p}} \tag{5.7}
\end{align*}
$$

By (5.6) and (5.7), we have (5.5).

## 6 Construction of $p$-energy: $p>\operatorname{dim}_{A R}(K, d)$

In this section, we are going to construct a $p$-energy on $K$ as a scaling limit of the discrete counterparts $\mathcal{E}_{p}^{n}$ 's step by step under Assumption 6.2, which consists of the following two requirements (6.1) and (6.2):
(6.1) Neighbor disparity constants and (conductance constants) ${ }^{-1}$ have the same asymptotic behavior,
(6.2) Conductance constants have exponential decay.

Under these assumptions, the $p$-energy $\widehat{\mathcal{E}}_{p}$ is constructed in Theorem 6.21 . Furthermore, in the case $p=2$, we construct a local regular Dirichlet form in Theorem 6.23.

The question when Assumption 6.2 is fulfilled will be addressed in Section 8 ,
As in the previous sections, we continue to suppose that Assumptions 2.6 2.7, 2.10 and 2.12 hold. Moreover, throughout this section, we fix $p \geq 1$.

Definition 6.1. For $M \geq 1, m \geq 0$ and $n \geq 1$, define

$$
\mathcal{E}_{M, p, m, n}=\max _{v \in T_{n}} \mathcal{E}_{M, p, m}\left(v, T_{n}\right)
$$

Remark. Theorem 18.3 shows that $\mathcal{E}_{M, p, m, n}$ is finite.
Assumption 6.2. There exist $c_{1}, c_{2}>0$ and $\alpha \in(0,1)$ such that

$$
\begin{equation*}
c_{1} \leq \mathcal{E}_{M_{*}, p, m, n} \sigma_{p, m, n} \leq c_{2} \tag{6.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathcal{E}_{M_{*}, p, m, n} \leq c_{2} \alpha^{m} \tag{6.2}
\end{equation*}
$$

for any $m \geq 0, n \geq 1$.
By 34, Theorems 4.7.6 and 4.9.1], we have the following characterization of the condition 6.2 under Assumption 2.15.
Proposition 6.3. Under Assumption 2.15, (6.2) holds if and only if

$$
p>\operatorname{dim}_{A R}(K, d)
$$

Note that since $K$ is assumed to be connected, we have $\operatorname{dim}_{A R}(K, d) \geq 1$, so that $p>1$.

In the following definition, we introduce the principal notion of this paper called conductive homogeneity. Due to Theorem 6.5, conductive homogeneity yields 6.1.

Definition 6.4 (Conductive Homogeneity). Define

$$
\mathcal{E}_{M, p, m}=\sup _{w \in T,|w| \geq 1} \mathcal{E}_{M, p, m}\left(w, T_{|w|}\right)
$$

A compact metric space $K$ (with a partition $\left\{K_{w}\right\}_{w \in T}$ and a measure $\mu$ ) is said to be $p$-conductively homogeneous if and only if

$$
\begin{equation*}
\sup _{m \geq 0} \sigma_{p, m} \mathcal{E}_{M_{*}, p, m}<\infty \tag{6.3}
\end{equation*}
$$

Remark. As in the case of $\mathcal{E}_{M, p, m, n}, \mathcal{E}_{M, p, m}$ is always finite due to Theorem 18.3
Theorem 6.5. If $K$ is p-conductively homogeneous, then (6.1) holds.
A proof of Theorem 6.5 will be provided in Section 8 .
Under conductive homogeneity, it will be shown in Theorem 8.1 that there exist $c_{1}, c_{2}>0$ and $\sigma>0$ such that

$$
c_{1} \sigma^{m} \leq \sigma_{p, m, n} \leq c_{2} \sigma^{m}
$$

and

$$
c_{1} \sigma^{-m} \leq \mathcal{E}_{M_{*}, p, m}\left(v, T_{n}\right) \leq c_{2} \sigma^{-m}
$$

for any $m \geq 1, n \geq 0$ and $v \in T_{n}$. This is why we have given the name "homogeneity" to this notion.

Now we start to construct a $p$-energy under Assumption 6.2. An immediate consequence of Assumption 6.2 is the following multiplicative property of $\sigma_{p, m, n}$.

Lemma 6.6. There exist $c_{1}, c_{2}>0$ such that

$$
c_{1} \sigma_{p, m, n+k} \sigma_{p, n, k} \leq \sigma_{p, n+m, k} \leq c_{2} \sigma_{p, m, n+k} \sigma_{p, n, k}
$$

for any $k \geq 1$, and $m, n \geq 0$.
Proof. By (4.4), we have

$$
\mathcal{E}_{M_{*}, p, n+m, k} \leq c \mathcal{E}_{M_{*}, p, m, n+k} \mathcal{E}_{M_{*}, p, n, k}
$$

This along with 6.1) show

$$
c_{1} \sigma_{p, m, n+k} \sigma_{p, n, k} \leq \sigma_{p, n+m, k}
$$

The other half of the desired inequality follows from Lemma 5.4 .
Next, we study some geometry associated with the partition $\left\{K_{w}\right\}_{w \in T}$.
Definition 6.7. Let $L \geq 1$. Define
$n_{L}(x, y)=\max \left\{n \mid\right.$ there exist $w, v \in T_{n}$ such that

$$
\left.x \in K_{w}, y \in K_{v} \text { and } v \in \Gamma_{L}(w)\right\}
$$

Furthermore, fix $r \in(0,1)$ and define

$$
\begin{equation*}
\delta_{L}(x, y)=r^{n_{L}(x, y)} \tag{6.4}
\end{equation*}
$$

Recall that $h_{r}: T \rightarrow(0,1]$ is given as $h_{r}(w)=r^{|w|}$. Since $\Lambda_{s}^{h_{r}}=T_{n}$ if $r^{n-1}>s \geq r^{n}$, where

$$
\Lambda_{s}^{h_{r}}=\left\{w \mid w \in T, h_{r}(\pi(w))>s \geq h_{r}(w)\right\}
$$

$\delta_{L}$ is nothing but $\delta_{L}^{h_{r}}$ defined in [34, Definition 2.3.8].
By [34, Proposition 2.3.7] and the discussions in its proof, we have the following fact.

Proposition 6.8. Suppose that $d$ is a metric on $K$ giving the original topology $\mathcal{O}$ of $K$. Let $L \geq 1$. There exists a monotonically non-decreasing function $\eta_{L}:[0,1] \rightarrow[0,1]$ satisfying $\lim _{t \downarrow} \eta_{L}(t)=0$ and

\delta_{L}(x, y) \leq \eta_{L}(d(x, y))
$$

for any $x, y \in K$.
Proof. Define

$$
\Lambda_{s, 0}^{h_{r}}(x)=\left\{v \mid v \in \Lambda_{s}^{h_{r}}, x \in K_{v}\right\}, U_{0}^{h_{r}}(x, s)=\bigcup_{v \in \Lambda_{s, 0}^{h_{r}}(x)} K_{v}
$$

and

$$
U_{1}^{h_{r}}(x, s)=\bigcup_{y \in U_{0}^{h_{r}}(x, s)} U_{0}^{h_{r}}(y, s)
$$

for $s \in(0,1]$ and $x \in K$. First we show that for any $\epsilon>0$, there exists $\gamma_{\epsilon}>0$ such that $\delta_{L}(x, y) \leq \epsilon$ whenever $d(x, y) \leq \gamma_{\epsilon}$. If this is not the case, then there exist $\epsilon_{0}>0,\left\{x_{n}\right\}_{n \geq 1}$ and $\left\{y_{n}\right\}_{n \geq 1}$ such that $d\left(x_{n}, y_{n}\right) \leq \frac{1}{n}$ and $\delta_{L}\left(x_{n}, y_{n}\right)>\epsilon_{0}$. Since $K$ is compact, choosing an adequate subsequence $\left\{n_{k}\right\}_{k \rightarrow \infty}$, we see that there exists $x \in K$ such that $x_{n_{k}} \rightarrow x$ and $y_{n_{k}} \rightarrow x$ for $k \rightarrow \infty$. By 34, Proposition 2.3.7], $U_{0}^{h_{r}}\left(x, \epsilon_{0} / 2\right)$ is a neighborhood of $x$. Hence both $x_{n_{k}}$ and $y_{n_{k}}$ belong to $U_{0}^{h_{r}}\left(x, \epsilon_{0} / 2\right)$ for sufficiently large $k$. So, there exist $w, v \in \Lambda_{\epsilon_{0} / 2,0}^{h_{r}}(x)$ such that $x_{n_{k}} \in K_{w}$ and $y_{n_{k}} \in K_{v}$. Since $x \in K_{w} \cap K_{v}$, we see that $y \in$ $U_{1}^{h_{r}}\left(x, \epsilon_{0} / 2\right)$, so that $\delta_{L}\left(x_{n_{k}}, y_{n_{k}}\right) \leq \epsilon_{0} / 2$. This contradicts the assumption that $\delta_{L}\left(x_{n}, y_{n}\right) \geq \epsilon_{0}$. Thus our claim at the beginning of this proof is verified. Note that with a modification if necessary, we may assume that $\gamma_{\epsilon}$ is monotonically non-decreasing as a function of $\epsilon$ and $\lim _{\epsilon \downarrow 0} \gamma_{\epsilon}=0$. Define

\eta_{L}(t)=\inf \left\{\epsilon \mid \epsilon>0, t \leq \gamma_{\epsilon}\right\}
$$

Now it is routine to see that $\eta$ is the desired function.
Let $T_{n}=\{w(1), \ldots, w(l)\}$, where $l=\#\left(T_{n}\right)$. Inductively we define $\widetilde{K}_{w}$ by

and

\widetilde{K}_{w(k+1)}=K_{w(k+1)} \backslash\left(\bigcup_{i=1, \ldots, k} \widetilde{K}_{w(i)}\right)

Note that 2.4 implies that $\mu\left(B_{w}\right)=0$ for any $w \in T_{n}$ and hence we have

\widetilde{K}_{w} \supseteq O_{w} \quad \text { and } \quad \mu\left(K_{w} \backslash \widetilde{K}_{w}\right)=0
$$

for any $w \in T_{n}$. The latter equality is due to 2.4 . Now define $J_{n}: \ell\left(T_{n}\right) \rightarrow \mathbb{R}^{K}$ by

J_{n} f=\sum_{w \in T_{n}} f(w) \chi_{\widetilde{K}_{w}} \tag{6.5}
\end{equation*}
$$

Since $\widetilde{K}_{w}$ is a Borel set, $J_{n} f$ is $\mu$-measurable for any $f \in \ell\left(T_{n}\right)$. The definitions of $\widetilde{K}_{w}$ and $J_{n}$ depend on an enumeration of $T_{n}$ but $J_{n} f$ stays the same in the $\mu$-a.e. sense regardless of an enumeration.

Define

$$
\begin{equation*}
\widetilde{\mathcal{E}}_{p}^{m}(f)=\sigma_{p, m-1,1} \mathcal{E}_{p}^{m}(f) \tag{6.6}
\end{equation*}
$$

The next lemma yields the control of the difference of values of $J_{n} f$ through $\widetilde{\mathcal{E}}_{p}^{n}(f)$.
Lemma 6.9. Suppose that Assumption 6.2 holds. There exists $C>0$ such that for any $n \geq 1, f \in \ell\left(T_{n}\right)$ and $x, y \in K$,

$$
\begin{equation*}
\left|\left(J_{n} f\right)(x)-\left(J_{n} f\right)(y)\right| \leq C \alpha^{\frac{m}{p}} \widetilde{\mathcal{E}}_{p}^{n}(f)^{\frac{1}{p}} \tag{6.7}
\end{equation*}
$$

where $m=\min \left\{n_{L}(x, y), n\right\}$.
Proof. Let $m=\min \left\{n_{L}(x, y), n\right\}$. Then there exist $w, w^{\prime} \in T_{m}, v \in S^{n-m}(w)$ and $u \in S^{n-m}\left(w^{\prime}\right)$ such that $x \in K_{v}, y \in K_{u},\left(J_{n} f\right)(x)=f(v),\left(J_{n} f\right)(y)=f(u)$ and $w^{\prime} \in \Gamma_{L+2}(w)$. By 5.5,

\begin{equation*}
|f(u)-f(v)| \leq c \sum_{i=0}^{n-m}\left(\sigma_{p, n-m-i, m+i}\right)^{\frac{1}{p}} \mathcal{E}_{p}^{n}(f)^{\frac{1}{p}}, \tag{6.8}
\end{equation*}
$$

where $c=\max \left\{2\left(N_{*}\right)^{2}, L_{*}(L+2)\right\}$. Lemma 6.6 shows that

c_{1} \sigma_{p, m+i-1,1} \sigma_{p, n-m-i, m+i} \leq \sigma_{p, n-1,1}
$$

Combining this with Assumption 6.2, we obtain

\sigma_{p, n-m-i, m+i} \leq c_{3} \alpha^{m+i} \sigma_{p, n-1,1}
$$

Using (6.8), we see

$$

By this lemma, the boundedness of $\widetilde{\mathcal{E}}_{p}^{n}\left(f_{n}\right)$ gives a kind of equi-continuity to the family $\left\{f_{n}\right\}_{n \geq 1}$ and hence an analogue of Arzelà-Ascoli theorem, which we present in Appendix $D$, shows the existence of a uniform limit as follows.
Lemma 6.10. Suppose that Assumption 6.2 holds. Define $\tau=\frac{\log \alpha}{\log r}$. Let $f_{n} \in \ell\left(T_{n}\right)$ for any $n \geq 1$. If

then there exist a subsequence $\left\{n_{k}\right\}_{k \geq 1}$ and $f \in C(K)$ such that $\left\{J_{n_{k}} f_{n_{k}}\right\}$ converges uniformly to $f$ as $k \rightarrow \infty, \widetilde{\mathcal{E}}_{p}^{n_{k}}\left(f_{n_{k}}\right)$ is convergent as $k \rightarrow \infty$ and

$$
\begin{equation*}
|f(x)-f(y)|^{p} \leq C \eta_{L}(d(x, y))^{\tau} \lim _{k \rightarrow \infty} \widetilde{\mathcal{E}}_{p}^{n_{k}}\left(f_{n_{k}}\right) \tag{6.9}
\end{equation*}
$$

where $\eta_{L}$ was introduced in Proposition 6.8.

Proof. Set $C_{*}=\sup _{n \geq 1} \widetilde{\mathcal{E}}_{p}^{n}\left(f_{n}\right)$. By Lemma 6.9, if $n \geq n_{L}(x, y)$, then

\left|J_{n} f_{n}(x)-J_{n} f_{n}(y)\right| \leq C \alpha^{\frac{n_{L}(x, y)}{p}}\left(C_{*}\right)^{\frac{1}{p}} \leq C \eta_{L}(d(x, y))^{\frac{\tau}{p}}\left(C_{*}\right)^{\frac{1}{p}} \tag{6.10}
\end{equation*}
$$

In case $n<n_{L}(x, y)$, then there exist $w, w^{\prime} \in T_{n}$ such that $x \in K_{w}, J_{n} f_{n}(x)=$ $f(w), y \in K_{w^{\prime}}, J_{n} f_{n}\left(w^{\prime}\right)=f\left(w^{\prime}\right)$ and $w^{\prime} \in \Gamma_{L+2}(w)$. So there exists an $E_{n}^{*}$-path $(w(0), \ldots, w(L+2))$ satisfying $w(0)=w$ and $w^{\prime}=w(L+2)$. By Lemma A.1.

$$
\left|f(w)-f\left(w^{\prime}\right)\right|^{p} \leq(L+2)^{p-1} \sum_{i=0}^{L+1}|f(w(i))-f(w(i+1))|^{p} \leq(L+2)^{p-1} \mathcal{E}_{p}^{n}\left(f_{n}\right)
$$

On the other hand, since $\widetilde{\mathcal{E}}_{p}^{n}\left(f_{n}\right) \leq C_{*}$, Assumption 6.2 implies

$$
\mathcal{E}_{p}^{n}\left(f_{n}\right) \leq\left(\sigma_{p, n-1,1}\right)^{-1} C_{*} \leq c_{2} \mathcal{E}_{M_{*}, p, n-1,1} C_{*} \leq\left(c_{2}\right)^{2} \alpha^{n-1} C_{*} .
$$

Thus we have

$$
\begin{equation*}
\left|J_{n} f_{n}(x)-J_{n} f_{n}(y)\right| \leq c \alpha^{\frac{n}{p}}\left(C_{*}\right)^{\frac{1}{p}} . \tag{6.11}
\end{equation*}
$$

Making use of 6.10 and 6.11, we see that

\left|J_{n} f_{n}(x)-J_{n} f_{n}(y)\right| \leq C \eta_{L}(d(x, y))^{\frac{\tau}{p}}\left(C_{*}\right)^{\frac{1}{p}}+c \alpha^{\frac{n}{p}}\left(C_{*}\right)^{\frac{1}{p}}
$$

for any $x, y \in K$. Applying Lemma D. 1 with $X=K, Y=\mathbb{R}, u_{i}=J_{i} f_{i}$, we obtain the desired result.

Definition 6.11. Define $P_{n}: L^{1}(K, \mu) \rightarrow \ell\left(T_{n}\right)$ by

\left(P_{n} f\right)(w)=\frac{1}{\mu(w)} \int_{K_{w}} f d \mu
$$

for any $n, m \geq 1$. For $f \in \ell\left(T_{k}\right)$, we define

P_{n} f=P_{n} J_{k} f
$$

The next lemma is one of the keys to the construction of a p-energy. A counterpart of this fact has already been used in Kusuoka-Zhou's construction of Dirichlet forms on self-similar sets in [36].

Lemma 6.12. Under Assumption 6.2, there exists $C>0$ such that for any $n, m \geq 1$ and $f \in L^{1}(K, \mu) \cup\left(\cup_{k \geq 1} \ell\left(T_{k}\right)\right)$,

\begin{equation*}
C \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right) \leq \widetilde{\mathcal{E}}_{p}^{n+m}\left(P_{n+m} f\right) \tag{6.12}
\end{equation*}
$$

In particular,

$$
\begin{equation*}
C \sup _{n \geq 0} \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right) \leq \liminf _{n \rightarrow \infty} \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right) \leq \limsup _{n \rightarrow \infty} \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right) \leq \sup _{n \geq 0} \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right) \tag{6.13}
\end{equation*}
$$

for any $f \in L^{1}(K, \mu)$.

Remark. This lemma holds without (6.2).
Proof. By Lemma 5.2 ,

\mathcal{E}_{p}^{n}\left(P_{n} f\right) \leq L_{*} \sigma_{p, m, n} \mathcal{E}_{p}^{n+m}\left(P_{n+m} f\right)
$$

Hence

\frac{1}{\sigma_{p, n-1,1}} \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right) \leq L_{*} \frac{\sigma_{p, m, n}}{\sigma_{p, n+m-1,1}} \widetilde{\mathcal{E}}_{p}^{n+m}\left(P_{n+m} f\right)
$$

By Lemma 6.6, we have 6.12).
By virtue of the last lemma, we have a proper definition of the domain $\mathcal{W}^{p}$ of a $p$-energy given in Theorem 6.21 and its semi-norm $\mathcal{N}_{p}$.

Lemma 6.13. Define

\mathcal{W}^{p}=\left\{f \mid f \in L^{p}(K, \mu), \sup _{n \geq 1} \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right)<+\infty\right\}
$$

and

\mathcal{N}_{p}(f)=\sup _{n \geq 1} \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right)^{\frac{1}{p}}
$$

for $f \in \mathcal{W}^{p}$. Then $\mathcal{W}^{p}$ is a normed linear space with norm $\|\cdot\|_{p, \mu}+\mathcal{N}_{p}(\cdot)$, where $\|\cdot\|_{p, \mu}$ is the $L^{p}$-norm. Moreover, for any $f \in \mathcal{W}^{p}$, there exists $f_{*} \in C(K)$ such that $f(x)=f_{*}(x)$ for $\mu$-a.e. $x \in K$. In this way, $\mathcal{W}^{p}$ is regarded as a subset of $C(K)$ and

$$
\begin{equation*}
|f(x)-f(y)|^{p} \leq C \eta_{L}(d(x, y))^{\tau} \mathcal{N}_{p}(f)^{p} \tag{6.14}
\end{equation*}
$$

for any $f \in \mathcal{W}^{p}$ and $x, y \in K$, where $\eta_{L}$ was introduced in Proposition 6.8. In particular, $\mathcal{N}_{p}(f)=0$ if and only if $f$ is constant on $K$.

If no confusion may occur, we write $\|\cdot\|_{p}$ in place of $\|\cdot\|_{p, \mu}$ hereafter.
In fact, $\left(\mathcal{W}^{p},\|\cdot\|_{p}+\mathcal{N}_{p}(\cdot)\right)$ turns out to be a Banach space in Lemma 6.16
Proof. Note that

$$
\begin{equation*}
\widetilde{\mathcal{E}}_{p}^{n}(f+g)^{\frac{1}{p}} \leq \widetilde{\mathcal{E}}_{p}^{n}(f)^{\frac{1}{p}}+\widetilde{\mathcal{E}}_{p}^{n}(g)^{\frac{1}{p}} \tag{6.15}
\end{equation*}
$$

and so $\widetilde{\mathcal{E}}_{p}^{n}(\cdot)^{\frac{1}{p}}$ is a semi-norm. This implies that $\mathcal{N}_{p}(\cdot)$ is a semi-norm of $\mathcal{W}^{p}$.
For $f \in \mathcal{W}^{p}$, by Lemma 6.10, there exist $\left\{n_{k}\right\}_{k \geq 1}$ and $f_{*} \in C(K)$ such that

as $k \rightarrow \infty$ and

\left|f_{*}(x)-f_{*}(y)\right|^{p} \leq C \eta_{L}(d(x, y))^{\tau} \limsup _{n \rightarrow \infty} \mathcal{E}_{p}^{n}\left(P_{n} f\right)
$$

Since $\int_{K_{w}} P_{n_{k}} f d \mu \rightarrow \int_{K_{w}} f_{*} d \mu$ as $k \rightarrow \infty$, it follows that $\int_{K_{w}} f d \mu=\int_{K_{w}} f_{*} d \mu$ for any $w \in T$. Hence $f=f_{*}$ for $\mu$-a.e. $x \in K$. Thus we identify $f_{*}$ with $f$ and so $f \in C(K)$. Moreover, 6.14 holds for any $x, y \in K$. By 6.14, $\mathcal{N}_{p}(f)=0$ if and only if $f$ is constant on $K$.

We now examine the properties of the normed space $\left(\mathcal{W}^{p},\|\cdot\|_{p}+\mathcal{N}_{p}(\cdot)\right)$. The intermediate goals are to show its completeness (Lemma 6.16) and that it is dense in $C(K)$ with respect to the supremum norm (Lemma 6.19).

Lemma 6.14. Suppose that Assumption 6.2 holds. The identity map $I:\left(\mathcal{W}^{p}, \| \cdot\right.$ $\left.\|_{p}+\mathcal{N}_{p}(\cdot)\right) \rightarrow\left(C(K),\|\cdot\|_{\infty}\right)$ is continuous.

Proof. Let $\left\{f_{n}\right\}_{n \geq 1}$ be a Cauchy sequence in $\left(\mathcal{W}^{p},\|\cdot\|_{p}+\mathcal{N}_{p}(\cdot)\right)$. Fix $x_{0} \in K$ and set $g_{n}(x)=\bar{f}_{n}(x)-f_{n}\left(x_{0}\right)$. Then

$$
\begin{aligned}
&\left|g_{n}(x)-g_{m}(x)\right|=\mid\left(f_{n}(x)-f_{m}(x)\right)-\left(f_{n}\left(x_{0}\right)-f_{m}\left(x_{0}\right) \mid\right. \\
& \leq C \eta_{L}\left(d\left(x, x_{0}\right)\right)^{\frac{\tau}{p}} \mathcal{N}_{p}\left(f_{n}-f_{m}\right)
\end{aligned}
$$

for any $x \in K$ and $n, m \geq 1$. Thus $\left\{g_{n}\right\}_{n \geq 1}$ is a Cauchy sequence in $C(K)$ with the norm $\|\cdot\|_{\infty}$, so that there exists $g \in C(K)$ such that $\left\|g-g_{n}\right\|_{\infty} \rightarrow 0$ as $n \rightarrow \infty$. On the other hand, since $\left\{f_{n}\right\}_{n \geq 1}$ is a Cauchy sequence of $L^{p}(X, \mu)$, there exists $f \in L^{p}(X, \mu)$ such that $\left\|f_{n}-f\right\|_{p} \rightarrow 0$ as $n \rightarrow \infty$. Thus $f_{n}\left(x_{0}\right)=$ $f_{n}-g_{n}$ converges as $n \rightarrow \infty$ in $L^{p}(K, \mu)$. Let $c$ be its limit. Then $f=g+c$ in $L^{p}(K, \mu)$. Therefore, $f \in C(K)$ and $\left\|f_{n}-f\right\|_{\infty} \rightarrow 0$ as $n \rightarrow \infty$.

Define $\overline{\mathcal{W}}^{p}$ as the completion of $\left(\mathcal{W}^{p},\|\cdot\|_{p}+\mathcal{N}_{p}(\cdot)\right)$. Then the map $I$ is extended to a continuous map from $\overline{\mathcal{W}}_{p} \rightarrow C(K)$, which is denoted by $I$ as well for simplicity.

Lemma 6.15 (Closability). Suppose that Assumption 6.2 holds. The extended map $I: \overline{\mathcal{W}}^{p} \rightarrow C(K)$ is injective. In particular, $\overline{\mathcal{W}}^{p}$ is identified with a subspace of $C(K)$.

Proof. Let $\left\{f_{n}\right\}_{n \geq 1}$ be a Cauchy sequence in $\left(\mathcal{W}^{p},\|\cdot\|_{p}+\mathcal{N}_{p}(\cdot)\right)$. Suppose $\lim _{n \rightarrow \infty}\left\|f_{n}\right\|_{\infty}=0$. Note that

$$
\widetilde{\mathcal{E}}_{p}^{k}\left(P_{k} f_{n}-P_{k} f_{m}\right) \leq \sup _{l \geq 1} \widetilde{\mathcal{E}}_{p}^{l}\left(P_{l} f_{n}-P_{l} f_{m}\right)=\mathcal{N}_{p}\left(f_{n}-f_{m}\right)^{p}
$$

for any $k, n, m \geq 1$. Hence, for any $\epsilon>0$, there exists $N \in \mathbb{N}$ such that

$$
\widetilde{\mathcal{E}}_{p}^{k}\left(P_{k} f_{n}-P_{k} f_{m}\right) \leq \epsilon
$$

for any $n, m \geq N$ and $k \geq 1$. As $\left\|f_{m}\right\|_{\infty} \rightarrow 0$ as $m \rightarrow \infty$, we see that

$$
\widetilde{\mathcal{E}}_{p}^{k}\left(P_{k} f_{n}\right) \leq \epsilon
$$

for any $n \geq N$ and $k \geq 1$ and hence $\mathcal{N}_{p}\left(f_{n}\right)^{p} \leq \epsilon$ for any $n \geq N$. Therefore, $\mathcal{N}_{p}\left(f_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$, so that $f_{n} \rightarrow 0$ in $\mathcal{W}^{p}$ as $n \rightarrow \infty$.

Lemma 6.16. Suppose that Assumption 6.2 holds.

$$
\overline{\mathcal{W}}^{p}=\mathcal{W}^{p}
$$

Proof. Let $\left\{f_{n}\right\}_{n \geq 1}$ be a Cauchy sequence of $\mathcal{W}^{p}$ and let $f$ be its limit in $\overline{\mathcal{W}^{p}}$. It follows that $\left\|f-f_{n}\right\|_{\infty} \rightarrow 0$ as $n \rightarrow \infty$. Using the same argument as in the proof of Lemma 6.15, we see that for sufficiently large $n$,

for any $k \geq 1$. Since

\widetilde{\mathcal{E}}_{p}^{k}\left(P_{k} f\right)^{\frac{1}{p}} \leq \widetilde{\mathcal{E}}_{p}^{k}\left(P_{k} f-P_{k} f_{n}\right)^{\frac{1}{p}}+\widetilde{\mathcal{E}}_{p}^{k}\left(P_{k} f_{n}\right)^{\frac{1}{p}}
$$

it follows that $\sup _{k \geq 1} \widetilde{\mathcal{E}}_{p}^{k}\left(P_{k} f\right)<\infty$ and hence $f \in \mathcal{W}^{p}$.
Lemma 6.17. Suppose that Assumption 6.2 holds.
(1) Let $\left\{n_{k}\right\}_{k \geq 1}$ be a monotonically increasing sequence of $\mathbb{N}$. Suppose that $f_{n_{k}} \in \ell\left(T_{n_{k}}\right)$ for any $k \geq 1$, that $\sup _{k \geq 1} \widetilde{\mathcal{E}}_{p}^{n_{k}}\left(f_{n_{k}}\right)<\infty$ and that there exists $f \in C(K)$ such that $\left\|J_{n_{k}} f_{n_{k}}-f\right\|_{\infty} \rightarrow 0$ as $n \rightarrow \infty$. Then $f \in \mathcal{W}^{p}$.
(2) Let $f, g \in \mathcal{W}^{p}$. Then $f \cdot g \in \mathcal{W}^{p}$.

Proof. (1) Set $C_{1}=\sup _{k \geq 1} \widetilde{\mathcal{E}}_{p}^{n_{k}}\left(f_{n_{k}}\right)$. By 6.12), if $n \leq n_{l}$, then

$$
C \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f_{n_{l}}\right) \leq \widetilde{\mathcal{E}}_{p}^{n_{l}}\left(f_{n_{l}}\right) \leq C_{1} .
$$

Letting $l \rightarrow \infty$, we obtain

$$
C \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right) \leq C_{1}
$$

for any $k \geq 1$. This implies $f \in \mathcal{W}^{p}$.
(2) For any $\varphi, \psi \in \ell\left(T_{n}\right)$,

$$
\begin{aligned}
& \mathcal{E}_{p}^{n}(\varphi \cdot \psi)=\frac{1}{2} \sum_{(w, v) \in E_{n}^{*}}|\varphi(w) \psi(w)-\varphi(v) \psi(v)|^{p} \\
& \leq 2^{p-1} \frac{1}{2} \sum_{(w, v) \in E_{n}^{*}}\left(|\varphi(w)|^{p}|\psi(w)-\psi(v)|^{p}+|\varphi(w)-\varphi(v)|^{p}|\psi(v)|^{p}\right) \\
& \leq 2^{p-1}\left(\|\varphi\|_{\infty} \mathcal{E}_{p}^{n}(\varphi)+\|\psi\|_{\infty} \mathcal{E}_{p}^{n}(\psi)\right) .
\end{aligned}
$$

Hence if $h_{n}=P_{n} f \cdot P_{n} g$, then

\widetilde{\mathcal{E}}_{p}^{n}\left(h_{n}\right) \leq 2^{p-1}\left(\|f\|_{\infty} \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right)+\|g\|_{\infty} \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} g\right)\right) .
$$

Since $f, g \in \mathcal{W}_{p}$, we see that $\sup _{n \geq 1} \widetilde{\mathcal{E}}_{p}^{n}\left(h_{n}\right)<\infty$. Moreover, $\left\|J_{n} h_{n}-f g\right\|_{\infty} \rightarrow 0$ as $n \rightarrow \infty$. Using (1), we conclude that $f g \in \mathcal{W}^{p}$.

Lemma 6.18. Suppose that Assumption 6.2 holds. There exist a monotonically increasing sequence $\left\{m_{j}\right\}_{j \in \mathbb{N}}$ and $h_{M_{*}, w}^{*}, \varphi_{M_{*}, w}^{*} \in \mathcal{W}^{p}$ for $w \in T$ such that (a) For any $w \in T$,
$\lim _{j \rightarrow \infty}\left\|J_{m_{j}} h_{M_{*}, w, m_{j}-|w|}^{*}-h_{M_{*}, w}^{*}\right\|_{\infty}=\lim _{j \rightarrow \infty}\left\|J_{m_{j}} \varphi_{M_{*}, w, m_{j}-|w|}^{*}-\varphi_{M_{*}, w}^{*}\right\|_{\infty}=0$,
where $h_{M_{*}, w, m}^{*}$ and $\varphi_{M_{*}, w, m}^{*}$ are defined in Definition 3.4. For negative vales of $m$, we formally define $h_{M_{*}, w, k-|w|}^{*}=P_{k} h_{M_{*}, w, 0}^{*}$ and $\varphi_{M_{*}, w, k-|w|}^{*}=P_{k} \varphi_{M_{*}, w, 0}^{*}$ for $k=0,1, \ldots,|w|$.
(b) $\left\{\widetilde{\mathcal{E}}_{p}^{m_{j}}\left(h_{M_{*}, w, m_{j}-|w|}^{*}\right)\right\}_{j \geq 1}$ and $\left\{\widetilde{\mathcal{E}}_{p}^{m_{j}}\left(\varphi_{M_{*}, w, m_{j}-|w|}^{*}\right)\right\}_{j \geq 1}$ converge as $j \rightarrow \infty$, (c) Set $U_{M}(w)=\cup_{v \in \Gamma_{M}(w)} K_{w}$. For any $w \in T, h_{M_{*}, w}^{*}: K \rightarrow[0,1]$ and

$$
h_{M_{*}, w}(x)= \begin{cases}1 & \text { if } x \in K_{w} \\ 0 & \text { if } x \notin U_{M_{*}}(w) .\end{cases}
$$

(d) For any $w \in T, \varphi_{M_{*}, w}^{*}: K \rightarrow[0,1], \operatorname{supp}\left(\varphi_{M_{*}, w}^{*}\right) \subseteq U_{M_{*}}(w)$, and

$$
\varphi_{M_{*}, w}^{*}(x) \geq\left(L_{*}\right)^{-M_{*}}
$$

for any $x \in K_{w}$. Moreover, for any $n \geq 1$,

$$
\sum_{w \in T_{n}} \varphi_{M_{*}, w}^{*} \equiv 1
$$

(e) For any $w \in T$ and $x \in K$,

$$
\varphi_{M_{*}, w}^{*}(x)=\frac{h_{M_{*}, w}^{*}(x)}{\sum_{v \in T_{|w|}} h_{M_{*}, v}^{*}(x)}
$$

Note that $\left\{\varphi_{M_{*}, w}^{*}\right\}_{w \in T_{n}}$ is a partition of unity subordinate to the covering $\left\{U_{M_{*}}(w)\right\}_{w \in T_{n}}$.

Proof. For ease of notation, write $\varphi_{w, m}^{*}=\varphi_{M_{*}, w, m}^{*}$ and $h_{w, m}^{*}=h_{M_{*}, w, m}^{*}$. By Lemma 3.3, 6.1) and Lemma 6.6, we see that

& \leq C \sigma_{p,|w|+m-1,1} \sigma_{p, m,|w|}^{-1} \leq C^{\prime} \sigma_{p,|w|-1,1}
\end{aligned}

for any $w \in T$ and $m \geq 0$. Similarly,

\widetilde{\mathcal{E}}_{p}^{|w|+m}\left(h_{w, m}^{*}\right) \leq C^{\prime} \sigma_{p,|w|-1,1}
$$

Hence Lemma 6.10 shows that, for each $w$, there exists $\left\{n_{k}\right\}_{k \rightarrow \infty}$ such that $\left\{J_{|w|+n_{k}} h_{w, n_{k}}^{*}\right\}_{k \geq 1}$ (resp. $\left\{J_{\left||w|+m_{j}\right.} \varphi_{w, n_{k}}^{*}\right\}_{k \geq 1}$ ) converges uniformly as $k \rightarrow \infty$. Let $h_{w}^{*}\left(\operatorname{resp} . \varphi_{w}^{*}\right)$ be its limit. Lemma 6.17(1) implies that $h_{w}^{*} \in \mathcal{W}^{p}$ and $\varphi_{w}^{*} \in \mathcal{W}^{p}$. By the diagonal argument, we choose $\left\{m_{j}\right\}_{j \geq 1}$ such that (a) and (b) hold. The statements (c), (d) and (e) are straightforward from the properties of $h_{w, m}^{*}$ and $\varphi_{w, m}^{*}$.

Lemma 6.19. Suppose that Assumption 6.2 holds. Then $\mathcal{W}^{p}$ is dense in $(C(K),\|\cdot\| \infty)$.

Proof. Choose $x_{w} \in K_{w}$ for each $w \in T$. For $f \in C(K)$, define

f_{n}=\sum_{w \in T_{n}} f\left(x_{w}\right) \varphi_{M_{*}, w}^{*}
$$

Then by Lemma 6.18, it follows that $\left\|f_{n}-f\right\|_{\infty} \rightarrow 0$ as $n \rightarrow \infty$. Hence $\mathcal{W}^{p}$ is dense in $C(K)$.

Definition 6.20. For $f \in L^{P}(K, \mu)$, define $\bar{f}$ by

\bar{f}(x)= \begin{cases}1 & \text { if } f(x) \geq 1 \\ f(x) & \text { if } 0<f(x)<1 \\ 0 & \text { if } f(x) \leq 0\end{cases}
$$

for $x \in K$.
Now we construct the $p$-energy $\widehat{\mathcal{E}}_{p}$ as a $\Gamma$-cluster point of $\widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} \cdot\right)$. The use of $\Gamma$-convergence in construction of Dirichlet forms on self-similar sets has been around for some time. See [21] and [13] for example.

Theorem 6.21. Suppose that Assumption 6.2 holds. Then there exist $\widehat{\mathcal{E}}_{p}$ : $\mathcal{W}^{p} \rightarrow[0, \infty)$, and $c>0$ such that
(a) $\left(\widehat{\mathcal{E}}_{p}\right)^{\frac{1}{p}}$ is a semi-norm on $\mathcal{W}^{p}$ and

$$
\begin{equation*}
c \mathcal{N}_{p}(f) \leq \widehat{\mathcal{E}}_{p}(f)^{\frac{1}{p}} \leq \mathcal{N}_{p}(f) \tag{6.16}
\end{equation*}
$$

for any $f \in \mathcal{W}^{p}$.
(b) For any $f \in \mathcal{W}^{p}, \bar{f} \in \mathcal{W}^{p}$ and

$$
\widehat{\mathcal{E}}_{p}(\bar{f}) \leq \widehat{\mathcal{E}}_{p}(f)
$$

(c) For any $f \in \mathcal{W}^{p}$,

$$
|f(x)-f(y)|^{p} \leq c \eta_{L}(d(x, y))^{\tau} \widehat{\mathcal{E}}_{p}(f)
$$

In particular, for $p=2,\left(\widehat{\mathcal{E}}_{2}, \mathcal{W}^{2}\right)$ is a regular Dirichlet form on $L^{2}(K, \mu)$ and the associated non-negative self-adjoint operator has compact resolvent.

The property (c) in the above theorem is called the Markov property.
Theorem 6.22 (Shimizu 41]). Suppose that Assumption 6.2 holds. Then the Banach space $\left(\mathcal{W}^{p},\|\cdot\|_{p}+\widehat{\mathcal{E}}_{p}(\cdot)\right)$ is reflexive and separable.

Remark. In 41, the reflexivity and separability are shown in the case of the planar Sierpinski carpet. His method, however, can easily be extended to our general case and one has the above theorem.

Proof of Theorem 6.21. Define $\widehat{\mathcal{E}}_{p}^{n}: L^{p}(K, \mu) \rightarrow[0, \infty)$ by $\widehat{\mathcal{E}}_{p}^{n}(f)=\widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right)$ for $f \in L^{p}(K, \mu)$. Then by [12, Proposition 2.14], there exists a $\Gamma$-convergent subsequence $\left\{\widehat{\mathcal{E}}_{p}^{n_{k}}\right\}_{k \geq 1}$. Define $\widehat{\mathcal{E}}_{p}$ as its limit. Let $f \in \mathcal{W}^{p}$. Then

$$
\widehat{\mathcal{E}}_{p}(f) \leq \liminf _{k \rightarrow \infty} \widehat{\mathcal{E}}_{p}^{n_{k}}(f) \leq \sup _{n \geq 1} \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right)=\mathcal{N}_{p}(f)^{p}
$$

Let $\left\{f_{n_{k}}\right\}_{k \geq 1}$ be a recovering sequence for $f$, i.e. $\left\|f-f_{n_{k}}\right\|_{p} \rightarrow 0$ as $k \rightarrow \infty$ and $\lim _{k \rightarrow \infty} \widehat{\mathcal{E}}_{p}^{n_{k}}\left(f_{n_{k}}\right)=\mathcal{E}_{p}(f)$. By 6.12), if $n_{k} \geq n$, then

$$
C \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f_{n_{k}}\right) \leq \widetilde{\mathcal{E}}_{p}^{n_{k}}\left(P_{n_{k}} f_{n_{k}}\right)=\widehat{\mathcal{E}}_{p}^{n_{k}}\left(f_{n_{k}}\right) .
$$

Letting $k \rightarrow \infty$, we obtain

$$
C \widetilde{\mathcal{E}}_{p}^{n}\left(P_{n} f\right) \leq \widehat{\mathcal{E}}_{p}(f)
$$

so that

$$
C \mathcal{N}_{p}(f)^{p} \leq \widehat{\mathcal{E}}_{p}(f)
$$

The semi-norm property of $\widehat{\mathcal{E}}_{p}(\cdot)^{\frac{1}{p}}$ is straightforward from basic properties of $\Gamma$-convergence.

Next we show that $\widehat{\mathcal{E}}_{p}(\bar{f}) \leq \widehat{\mathcal{E}}_{p}(f)$ for any $f \in \mathcal{W}^{p}$. Define

\begin{equation*}
Q_{n} f=\sum_{w \in T_{n}}\left(P_{n} f\right)(w) \chi_{K_{w}} . \tag{6.17}
\end{equation*}
$$

Then

$$
\begin{aligned}
\int_{K}\left|f(y)-Q_{n} f(y)\right|^{p} \mu(d y) & \leq \sum_{w \in T_{n}} \int_{K_{w}}\left(\frac{1}{\mu(w)} \int_{K_{w}}|f(y)-f(x)| \mu(d x)\right)^{p} \mu(d y) \\
& \leq \sum_{w \in T_{n}} \frac{1}{\mu(w)} \int_{K_{w} \times K_{w}}|f(y)-f(x)|^{p} \mu(d x) \mu(d y)
\end{aligned}
$$

This shows that if $f \in C(K)$, then $\left\|f-Q_{n} f\right\|_{p} \rightarrow 0$ as $n \rightarrow \infty$. Let $\left\{f_{n_{k}}\right\}_{k \geq 1}$ be a recovering sequence for $f$. Since

$$
\begin{aligned}
\left\|\bar{f}-\overline{Q_{n} g}\right\|_{p} & \leq\left\|\bar{f}-\overline{Q_{n} f}\right\|_{p}+\left\|\overline{Q_{n} f}-\overline{Q_{n} g}\right\|_{p} \\
& \leq\left\|f-Q_{n} f\right\|_{p}+\left\|Q_{n} f-Q_{n} g\right\|_{P} \leq\left\|f-Q_{n} f\right\|_{p}+\|f-g\|_{p},
\end{aligned}
$$

it follows that $\left\|\bar{f}-\overline{Q_{n_{k}} f_{n_{k}}}\right\|_{p} \rightarrow 0$ as $n \rightarrow \infty$. Then

$$
\begin{aligned}
\mathcal{E}_{p}(\bar{f}) \leq \liminf _{k \rightarrow \infty} \widehat{\mathcal{E}}_{p}^{n_{k}}\left(\overline{Q_{n_{k}} f_{n_{k}}}\right) & =\liminf _{k \rightarrow \infty} \widetilde{\mathcal{E}}_{p}^{n_{k}}\left(\overline{P_{n_{k}} f_{n_{k}}}\right) \\
\leq & \liminf _{k \rightarrow \infty} \widetilde{\mathcal{E}}_{p}^{n_{k}}\left(P_{n_{k}} f_{n_{k}}\right)=\lim _{k \rightarrow \infty} \widehat{\mathcal{E}}_{p}^{n_{k}}\left(f_{n_{k}}\right)=\mathcal{E}_{p}(f) .
\end{aligned}
$$

Finally for $p=2$, since a $\Gamma$-limit of quadratic forms is a quadratic form, we see that $\left(\widehat{\mathcal{E}}_{2}, \mathcal{W}^{2}\right)$ is a regular Dirichlet form on $L^{2}(K, \mu)$. Since the identity map from $\left(\mathcal{W}^{2},\|\cdot\|_{2}+\mathcal{N}_{p}(\cdot)\right)$ to $\left(C(K),\|\cdot\|_{\infty}\right)$ is a compact operator, by [17, Exercise 4.2 ], the non-negative self-adjoint operator associated with $\left(\mathcal{E}_{2}, \mathcal{W}^{p}\right)$ has compact resolvent.

For the case $p=2$, due to the above theorem, $\mathcal{W}^{2}$ is separable. Hence, we may replace $\Gamma$-convergence with point-wise convergence as seen in the following theorem. This enables us to obtain the local property of our Dirichlet form, which turns out to be a resistance form as well.

Theorem 6.23. Suppose that Assumption 6.2 holds for $p=2$. Then there exists a sub-sequence $\left\{m_{k}\right\}_{k \geq 1}$ such that $\left\{\mathcal{E}_{2}^{m_{k}}\left(P_{m_{k}} f, P_{m_{k}} g\right)\right\}_{k \geq 1}$ converges as $k \rightarrow \infty$ for any $f, g \in \mathcal{W}^{2}$. Furthermore, define $\mathcal{E}(f, g)$ as its limit. Then $\left(\mathcal{E}, \mathcal{W}^{2}\right)$ is a local regular Dirichlet form on $L^{2}(K, \mu)$, and there exist $c_{1}, c_{2}, c_{3}>0$ such that

$$
\begin{equation*}
c_{1} \mathcal{N}_{2}(f) \leq \mathcal{E}(f, f)^{\frac{1}{2}} \leq c_{2} \mathcal{N}_{2}(f) \tag{6.18}
\end{equation*}
$$

and

$$
\begin{equation*}
|f(x)-f(y)|^{2} \leq c_{3} \eta_{L}(d(x, y))^{\tau} \mathcal{E}(f, f) \tag{6.19}
\end{equation*}
$$

for any $f \in \mathcal{W}^{2}$ and $x, y \in K$. In particular, $\left(\mathcal{E}, \mathcal{W}^{2}\right)$ is a resistance form on $K$ and the associated resistance metric $R$ gives the original topology $\mathcal{O}$ of $K$.

Proof. Existence of $\left\{m_{k}\right\}_{k \geq 1}$ : By Lemma 6.21, the non-negative self-adjoint operator $H$ associated with the regular Dirichlet form $\left(\widehat{\mathcal{E}}_{2}, \mathcal{W}^{2}\right)$ has compact resolvent. Hence there exist a complete orthonormal basis $\left\{\varphi_{i}\right\}_{i \geq 1}$ of $L^{2}(K, \mu)$ and $\left\{\lambda_{i}\right\}_{i \geq 1} \subseteq[0, \infty)$ such that

H \varphi_{i}=\lambda_{i} \varphi_{i} \quad \text { and } \quad \lambda_{i} \leq \lambda_{i+1}
$$

for any $i \geq 1$ and $\lim _{i \rightarrow \infty} \lambda_{i}=\infty$. Note that $\left\{\frac{\varphi_{i}}{\sqrt{1+\lambda_{i}}}\right\}_{i \geq 1}$ is a complete orthonormal system of $\left(\mathcal{W}^{2},(\cdot, \cdot)_{2, \mu}+\widehat{\mathcal{E}}_{p}(\cdot, \cdot)\right)$. Hence setting

$$
\mathcal{F}=\left\{a_{i_{1}} \psi_{i_{1}}+\cdots+a_{i_{m}} \psi_{i_{m}} \mid m \geq 1, i_{1}, \ldots, i_{m} \geq 1, a_{i_{1}}, \ldots, a_{i_{m}} \in \mathbb{Q}\right\}
$$

we see that $\mathcal{F}$ is a dense subset of $\mathcal{W}^{p}$. For any $f, g \in \mathcal{F}$, since

$$
\left|\widetilde{\mathcal{E}}_{2}^{n}\left(P_{n} f, P_{n} g\right)\right| \leq \widetilde{\mathcal{E}}_{2}^{n}\left(P_{n} f\right)^{\frac{1}{2}} \widetilde{\mathcal{E}}_{2}^{n}\left(P_{n} g\right)^{\frac{1}{2}} \leq \mathcal{N}_{2}(f) \mathcal{N}_{2}(g)
$$

some sub-sequence of $\left\{\widetilde{\mathcal{E}}_{2}^{n}\left(P_{n} f, P_{n} g\right)\right\}_{n \geq 1}$ is convergent. Since $\mathcal{F} \times \mathcal{F}$ is countable, the standard diagonal argument shows the existence of a sub-sequence $\left\{m_{k}\right\}_{k \geq 1}$ such that $\widetilde{\mathcal{E}}_{2}^{m_{k}}\left(P_{m_{k}} f, P_{m_{k}} g\right)$ converges as $k \rightarrow \infty$ for any $f, g \in$ $\mathcal{F}$. Define $\mathcal{E}_{2}(f, g)$ as its limit. For $f, g \in \mathcal{W}^{2}$, choose $\left\{f_{i}\right\}_{i \geq 1} \subseteq \mathcal{F}$ and $\left\{g_{i}\right\}_{i \geq 1} \in \mathcal{F}$ such that $f_{i} \rightarrow f$ and $g_{i} \rightarrow g$ as $i \rightarrow \infty$ in $\mathcal{W}^{2}$. Write $\widetilde{\mathcal{E}}_{k}(u, v)=$ $\widetilde{\mathcal{E}}_{2}^{m_{k}}\left(P_{m_{k}} u, P_{m_{k}} v\right)$ for ease of notation. Then

$$
\begin{aligned}
& \left|\widetilde{\mathcal{E}}_{k}(f, g)-\widetilde{\mathcal{E}}_{l}(f, g)\right| \leq\left|\widetilde{\mathcal{E}}_{k}(f, g)-\widetilde{\mathcal{E}}_{k}\left(f_{i}, g\right)\right|+\left|\widetilde{\mathcal{E}}_{k}\left(f_{i}, g\right)-\widetilde{\mathcal{E}}_{k}\left(f_{i}, g_{i}\right)\right| \\
& \quad+\left|\widetilde{\mathcal{E}}_{k}\left(f_{i} . g_{i}\right)-\widetilde{\mathcal{E}}_{l}\left(f_{i}, g_{i}\right)\right|+\left|\widetilde{\mathcal{E}}_{l}\left(f_{i}, g_{i}\right)-\widetilde{\mathcal{E}}_{l}\left(f_{i}, g\right)\right|+\left|\widetilde{\mathcal{E}}_{l}\left(f_{i}, g\right)-\widetilde{\mathcal{E}}_{l}(f, g)\right| \\
& \quad \leq\left|\widetilde{\mathcal{E}}_{k}\left(f_{i}, g_{i}\right)-\widetilde{\mathcal{E}}_{l}\left(f_{i}, g_{i}\right)\right|+2 \mathcal{N}_{2}\left(f_{i}\right) \mathcal{N}_{2}\left(g-g_{i}\right)+2 \mathcal{N}_{2}\left(f-f_{i}\right) \mathcal{N}_{2}(g) .
\end{aligned}
$$

This shows that $\left\{\widetilde{\mathcal{E}}_{k}(f, g)\right\}_{k \geq 1}$ is convergent as $k \rightarrow \infty$. 6.18) is straightforward. Strongly local property: Let $f, g \in \mathcal{W}^{p}$. Assume that there exists an open
set $U \subseteq K$ such that $\operatorname{supp}(f) \subseteq U$ and $\left.g\right|_{U}$ is a constant. Then for sufficiently large $k, \widetilde{\mathcal{E}}_{k}(f, g)=0$, so that $\mathcal{E}(f, g)=0$.
Markov property: By (6.16) and (6.18),

0 \leq \mathcal{E}(f, f) \leq \widehat{\mathcal{E}}_{2}(f, f)
$$

for any $f \in \mathcal{W}^{2}$. Since $\left(\widehat{\mathcal{E}}_{2}, \mathcal{W}^{2}\right)$ is a regular Dirichlet form, by [16, Theorem 2.4.2], we see that $\mathcal{E}(f, g)=0$ whenever $f, g \in \mathcal{W}^{2}$ and $f(x) g(x)=0$ for $\mu$-a.e. $x \in K$. Now by the same argument as in the proof of [7, Theorem 2.1], we have the Markov property.
Resistance form: Among the conditions for a resistance form in 32, Definition 3.1], (RF1), (RF2), (RF3) and (RF5) are immediate from what we have already shown. (RF4) is deduced from (6.19). In fact, 6.19 yields that

R(x, y) \leq c \eta_{L}(d(x, y))^{\tau}
$$

for any $x, y \in K$. Assume that $R\left(x_{n}, x\right) \rightarrow 0$ as $n \rightarrow \infty$ and $\overline{\lim }_{n \rightarrow \infty} d\left(x, x_{n}\right)>$ 0 . Note that the collection of

$$
U_{L}^{h_{r}}\left(x, r^{n}\right)=\bigcup_{w \in T_{n}: x \in K_{w}}\left(\bigcup_{v \in \Gamma_{L}(w)} K_{v}\right)
$$

for $n \geq 1$ is a fundamental system of neighborhoods of $x$ by 34, Proposition 2.3.9]. Therefore there exist $n \geq 1$ and $\left\{x_{m_{k}}\right\}_{k \geq 1}$ such that $x_{m_{k}} \notin$ $U_{L}^{h_{r}}\left(x, r^{n}\right)$ for any $k \geq 1$. Choose $w \in T_{n}$ such that $x \in K_{w}$. Then $x_{m_{k}}$ belongs to $K_{v}$ for some $v \in \Gamma_{L}(w)^{c}$. So, $h_{L, w}^{*}(x)=1$ and $h_{L, w}^{*}\left(x_{m_{k}}\right)=0$. Hence

$$
R\left(x_{m_{k}}, x\right) \geq \frac{1}{\mathcal{E}\left(h_{L, w}^{*}\right)}
$$

for any $k \geq 1$. This contradicts the fact that $R\left(x, x_{m_{k}}\right) \rightarrow 0$ as $k \rightarrow \infty$. Thus we have shown $d\left(x_{n}, x\right) \rightarrow 0$ as $n \rightarrow \infty$. Hence the topology induced by the resistance metric $R$ is the same as the original topology $\mathcal{O}$.

## 7 Construction of $p$-energy: $p \leq \operatorname{dim}_{A R}(K, d)$

In this section, we will consider how much we can salvage the results in the previous section if $p \leq \operatorname{dim}_{A R}(K, d)$. Honestly, what we will have in this section is far from satisfactory mainly because we have no proof of the conjecture saying that $\mathcal{W}^{P} \cap C(K)$ is dense in $C(K)$ with respect to the supremum norm. In spite of this, we present what we have now for future study.

Throughout this section, we assume (6.1). Then, Lemma 6.12 still holds. Replacing $\left(C(K),\|\cdot\|_{\infty}\right)$ by $\left(L^{p}(K, \mu),\|\cdot\|_{p}\right)$ in the statements and proofs of Lemma 6.15 and 6.16, we have the following statement.

Lemma 7.1. $\mathcal{W}^{p}$ is a Banach space with the norm $\|\cdot\|_{p}+\mathcal{N}_{p}(\cdot)$.

Lemma 7.2. Let $p>1$. If $\left\{f_{n}\right\}_{n \geq 1}$ is a bounded sequence in the Banach space $\mathcal{W}^{p}$, then there exist $\left\{n_{k}\right\}_{k \geq 1}$ and $f \in \mathcal{W}^{p}$ such that $f$ is the weak limit of $\left\{f_{n_{k}}\right\}_{k \geq 1}$ in $L^{p}(K, \mu)$,

$$
\|f\|_{p} \leq \sup _{n \geq 1}\left\|f_{n}\right\|_{p} \quad \text { and } \quad \mathcal{N}_{p}(f) \leq \sup _{n \geq 1} \mathcal{N}_{p}\left(f_{n}\right)
$$

Proof. Since $L^{p}(K, \mu)$ is reflexive, $\left\{f_{n}\right\}$ has a weakly convergent sub-sequence $\left\{f_{n_{k}}\right\}_{k \geq 1}$. (See [45, Section V.2].) Let $f \in L^{p}(K, \mu)$ be its weak limit. Since the map $f \rightarrow\left(P_{m} f\right)(w)$ is continuous, we see that $P_{m} f_{n_{k}} \rightarrow P_{m} f$ as $k \rightarrow \infty$ and hence

$$
\widetilde{\mathcal{E}}_{p}^{m}\left(P_{m} f\right)=\lim _{k \rightarrow \infty} \widetilde{\mathcal{E}}_{p}^{m}\left(P_{m} f_{n_{k}}\right) \leq \sup _{k \geq 1} \mathcal{N}_{p}\left(f_{n_{k}}\right)^{\frac{1}{p}}
$$

Lemma 7.3. Let $p>1$. Suppose that $f_{n} \in \ell\left(T_{n}\right)$ for any $n \geq 1$ and that

$$
\sup _{n \geq 1}\left\|J_{n} f_{n}\right\|_{p}<\infty \quad \text { and } \quad \sup _{n \geq 1} \widetilde{\mathcal{E}}_{p}^{n}\left(f_{n}\right)<\infty
$$

Then there exist a subsequence $\left\{n_{k}\right\}_{k \geq 1}$ and $f \in \mathcal{W}^{p}$ such that $f$ is the weak limit of $\left\{J_{n_{k}} f_{n_{k}}\right\}_{k \geq 1}$ in $L^{p}(K, \mu)$ and

$$
\|f\|_{p} \leq \sup _{n \geq 1}\left\|J_{n} f_{n}\right\|_{p} \quad \text { and } \quad C \mathcal{N}_{p}(f)^{p} \leq \sup _{n \geq 1} \widetilde{\mathcal{E}}_{p}^{n}\left(f_{n}\right)
$$

Proof. Since $L^{p}(K, \mu)$ is reflexive, $\left\{J_{n} f_{n}\right\}$ has a weak convergent sub-sequence $\left\{J_{n_{k}} f_{n_{k}}\right\}_{k \geq 1}$. (See [45, Section V.2].) Let $f \in L^{p}(K, \mu)$ be its weak limit. By Lemma 6.12, if $n_{k} \geq m$, then

$$
C \widetilde{\mathcal{E}}_{p}^{m}\left(P_{m} J_{n_{k}} f_{n_{k}}\right) \leq \widetilde{\mathcal{E}}_{p}^{n_{k}}\left(P_{n_{k}} J_{n_{k}} f_{n_{k}}\right)=\widetilde{\mathcal{E}}_{p}^{n_{k}}\left(f_{n_{k}}\right) \leq \sup _{n \geq 1} \widetilde{\mathcal{E}}_{p}^{n}\left(f_{n}\right)
$$

Letting $k \rightarrow \infty$, we see

$$
C \widetilde{\mathcal{E}}_{p}^{m}\left(P_{m} f\right) \leq \sup _{n \geq 1} \widetilde{\mathcal{E}}_{p}^{n}\left(f_{n}\right)
$$

for any $m \geq 1$. Thus $f \in \mathcal{W}^{p}$ and $C \mathcal{N}_{p}(f)^{p} \leq \sup _{n \geq 1} \widetilde{\mathcal{E}}_{p}^{n}\left(f_{n}\right)$.
Using this lemma, we have a counterpart of Lemma 6.18 as follows.
Lemma 7.4. There exist $\left\{h_{w}^{*}\right\}_{w \in T}$ and $\left\{\varphi_{w}^{*}\right\}_{w \in T} \subseteq \mathcal{W}^{p}$ such that
(a) Set $U_{M_{*}}(w)=\cup_{v \in \Gamma_{M_{*}}(w)} K_{v}$. For any $w \in T, h_{w}^{*}: K \rightarrow[0,1]$ and

$$
h_{w}^{*}(x)= \begin{cases}1 & \text { if } x \in K_{w} \\ 0 & \text { if } x \notin U_{M_{*}}(w) .\end{cases}
$$

(b) For any $w \in T, \varphi_{w}^{*}: K \rightarrow[0,1], \operatorname{supp}\left(\varphi_{w}^{*}\right) \subseteq U(w)$, and

$$
\varphi_{w}^{*}(x) \geq\left(L_{*}\right)^{-M_{*}}
$$

for any $x \in K_{w}$. Moreover, for any $n \geq 1$,

$$
\sum_{w \in T_{n}} \varphi_{w}^{*} \equiv 1
$$

(c) For any $w \in T$ and $x \in K$,

$$
\varphi_{w}^{*}(x)=\frac{h_{w}^{*}(x)}{\sum_{v \in T_{|w|}} h_{v}^{*}(x)}
$$

By the above lemma,
Lemma 7.5. $\mathcal{W}^{p}$ is dense in $L^{p}(K, \mu)$.
Finally, we have the following result on the construction of a $p$-energy.
Lemma 7.6. There exist $\widehat{\mathcal{E}}_{p}: \mathcal{W}^{p} \rightarrow[0, \infty)$ and $c_{1}, c_{2}>0$ such that $\widehat{\mathcal{E}}_{p}^{\frac{1}{p}}$ is a semi-norm,

$$
c_{1} \mathcal{N}_{p}(f)^{p} \leq \widehat{\mathcal{E}}_{p}(f) \leq c_{2} \mathcal{N}_{p}(f)^{p} \quad \text { and } \quad \widehat{\mathcal{E}}_{p}(\bar{f}) \leq \widehat{\mathcal{E}}_{p}(f)
$$

for any $f \in \mathcal{W}^{p}$. In particular, for $p=2,\left(\widehat{\mathcal{E}}_{2}, \mathcal{W}^{2}\right)$ is a Dirichlet form on $L^{2}(K, \mu)$.

## 8 Conductive homogeneity

In this section, we study the notion of conductive homogeneity, namely, its consequence and how one can show it.

Throughout this section, we suppose that Assumptions 2.6, 2.7, 2.10 and 2.12 hold.

The first theorem explains the reason why it is called "homogeneity".
Theorem 8.1. $K$ is p-conductively homogeneous if and only if there exist $c_{1}, c_{2}>0$ and $\sigma>0$ such that

$$
\begin{equation*}
c_{1} \sigma^{-m} \leq \mathcal{E}_{M_{*}, p, m}\left(v, T_{n}\right) \leq c_{2} \sigma^{-m}, \tag{8.1}
\end{equation*}
$$

and

$$
c_{1} \sigma^{m} \leq \sigma_{p, m, n} \leq c_{2} \sigma^{m}
$$

for any $m \geq 0, n \geq 1$ and $v \in T_{n}$.
An immediate corollary of this theorem is Theorem 6.5 .
Corollary 8.2 (Theorem 6.5). If $K$ is $p$-conductively homogeneous, then 6.1) holds.

Proof of Theorem 8.1. Assume that $K$ is $p$-conductively homogeneous. Then by (5.3), there exists $c_{1}>0$ such that

$$
c_{1} \leq \sigma_{p, m} \mathcal{E}_{M_{*}, p, m}
$$

Also by Lemma 5.4, there exists $c_{2}>0$ such that

$$
\begin{equation*}
\sigma_{p, m+n} \leq c_{2} \sigma_{p, m} \sigma_{p, n} \tag{8.2}
\end{equation*}
$$

for any $n, m \geq 0$. Moreover by (4.4), there exists $c_{3}>0$ such that

\mathcal{E}_{M_{*}, p, m+n} \leq c_{3} \mathcal{E}_{M_{*}, p, m} \mathcal{E}_{M_{*}, p, n}
$$

for any $n, m \geq 0$. These inequalities along with (6.3) shows that there exist $c_{4}, c_{5}>0$ such that

$$
c_{4} \sigma_{p, m} \sigma_{p, n} \leq \sigma_{p, m+n} \leq c_{5} \sigma_{p, m} \sigma_{p, n}
$$

and

$$
c_{4} \leq \sigma_{p, m} \mathcal{E}_{M_{*}, p, m} \leq c_{5}
$$

for any $m, n \geq 0$. From these, there exist $c_{6}, c_{7}>0$ and $\sigma>0$ such that

$$
c_{6} \sigma^{m} \leq \sigma_{p, m} \leq c_{7} \sigma^{m} \quad \text { and } \quad c_{6} \sigma^{m} \leq\left(\mathcal{E}_{M_{*}, p, m}\right)^{-1} \leq c_{7} \sigma^{m}
$$

for any $m \geq 0$. Hence for any $w \in T$ and $n \geq 1$,

$$
c_{6} \sigma^{m} \leq\left(\mathcal{E}_{p, m}\right)^{-1} \leq\left(\mathcal{E}_{M_{*}, p, m}\left(w, T_{n}\right)\right)^{-1} \quad \text { and } \quad \sigma_{p, m, n} \leq c_{7} \sigma^{m}
$$

Making use of (5.3), we see that there exists $c_{8}>0$ such that

$$
c_{6} \sigma^{m} \leq\left(\mathcal{E}_{M_{*}, p, m}\left(w, T_{n}\right)\right)^{-1} \leq c_{8} \sigma_{p, m, n} \leq c_{8} c_{7} \sigma^{m}
$$

for any $m \geq 0, n \geq 1$ and $w \in T_{n}$.
The converse direction is straightforward.
Next we show another consequence of conductive homogeneity. For simplicity, we set $\mathcal{E}_{p, m}\left(u, v, S^{k}(w)\right)=\mathcal{E}_{p, m}\left(\{u\},\{v\}, S^{k}(w)\right)$. (In other words, we deliberately confuse $u$ with $\{u\}$.)
Lemma 8.3. If $K$ is $p$-conductively homogeneous, then there exists $8.3>0$, depending only on $p, L_{*}, N_{*}, M_{*}, k$, such that

$$
\mathcal{E}_{M_{*}, p, m} \leq \sqrt{8.3)^{2}} \mathcal{E}_{p, m}\left(u, v, S^{k}(w)\right)
$$

for any $m \geq 0, w \in T$ and $u, v \in S^{k}(w)$ with $u \neq v$.
Proof. By (5.1), we see that

$$
\mathcal{E}_{p, 0}\left(u, v, S^{k}(w)\right) \leq L_{*} \sigma_{p, m} \mathcal{E}_{p, m}\left(u, v, S^{k}(w)\right)
$$

Using Theorem 18.3 it follows that

$$
\underline{c}_{\mathcal{E}}\left(L_{*},\left(N_{*}\right)^{k}, p\right) \leq \mathcal{E}_{p, 0}\left(u, v, S^{k}(w)\right) \leq L_{*} \sigma_{p, m} \mathcal{E}_{p, m}\left(u, v, S^{k}(w)\right)
$$

Now Theorem 8.1 suffices.

When $p>\operatorname{dim}_{A R}(K, d)$, the converse direction of the above lemma is actually true.

Theorem 8.4. Assume that there exist $c>0$ and $\alpha \in(0,1)$ such that

$$
\begin{equation*}
\mathcal{E}_{M_{*}, p, m} \leq c \alpha^{m} \tag{8.3}
\end{equation*}
$$

for any $m \geq 0$. Then $K$ is $p$-conductively homogeneous if and only if for any $k \geq 1$, there exists $c(k)>0$ such that

$$
\begin{equation*}
\mathcal{E}_{M_{*}, p, m} \leq c(k) \mathcal{E}_{p, m}\left(u, v, S^{k}(w)\right) \tag{8.4}
\end{equation*}
$$

for any $m \geq 0, w \in T$ and $u, v \in S^{k}(w)$ with $u \neq v$. In particular, under Assumption 2.15, if $p>\operatorname{dim}_{A R}(K, d)$, then whether $K$ is $p$-conductively homogeneous or not is independent of neighbor disparity constants.

The last part of the theorem justifies the name "conductive" homogeneity.
The condition (8.3) is the same as $\sqrt{6.22}$. Recall that, by Proposition 6.3 , (8.3) holds if and only if $p>\operatorname{dim}_{A R}(K, d)$ under Assumption 2.15

The condition (8.4) is an analytic relative of the "Knight move" condition described in probabilistic terminologies in (36]. The name "Knight move" originated from the epoch-making paper [1 where Barlow and Bass constructed the Brownian motion on the Sierpinski carpet.

The proof of the "only if" part of the above theorem is Lemma 8.3. A proof of the "if" part will be given in Sections 15, 16 and 17 .

In Sections 11,12 and 13, we are going to give examples for which one can show $p$-conductive homogeneity by Theorem 8.4.

In the rest of this section, we study asymptotic behaviors of the heat kernel associated with the diffusion process induced by the Dirichlet form $\left(\mathcal{E}, \mathcal{W}^{2}\right)$ under Assumption 2.15. The next lemma shows that the associated resistance metric is bi-Lipschitz equivalent to a power of the original metric.

Lemma 8.5. Suppose that Assumption 2.15 holds, $p>\operatorname{dim}_{A R}(K, d)$ and $K$ is $p$-conductively homogeneous. Let $\sigma$ be the same as in Theorem 8.1 and set $\tau_{p}=-\frac{\log \sigma}{\log r}$. Then there exist $c_{1}, c_{2}>0$ such that

$$
\begin{equation*}
c_{1} d(x, y)^{\tau_{p}} \leq \sup _{f \in \mathcal{W}^{p}, \widehat{\mathcal{E}}_{p}(f) \neq 0} \frac{|f(x)-f(y)|^{p}}{\widehat{\mathcal{E}}_{p}(f)} \leq c_{2} d(x, y)^{\tau_{p}} \tag{8.5}
\end{equation*}
$$

for any $x, y \in K$. In particular, if $2>\operatorname{dim}_{A R}(K, d)$, then

$$
\begin{equation*}
c_{1} d(x, y)^{\tau_{2}} \leq R(x, y) \leq c_{2} d(x, y)^{\tau_{2}} \tag{8.6}
\end{equation*}
$$

for any $x, y \in K$, where $R(x, y)$ is the resistance metric associated with the resistance form $\left(\mathcal{E}, \mathcal{W}^{2}\right)$.

Proof. Since $\mathcal{E}_{p}^{m}\left(h_{M_{*}, w, m-|w|}^{*}\right)=\mathcal{E}_{M_{*}, p, m-|w|}\left(w, T_{|w|}\right)$, we have

$$
c_{1} \sigma^{-m+|w|} \leq \mathcal{E}_{p}^{m}\left(h_{M_{*}, w, m-|w|}^{*}\right) \leq c_{2} \sigma^{-m+|w|} .
$$

by (8.1). This shows

$$
c_{1} \sigma^{|w|} \leq \widehat{\mathcal{E}}_{p}\left(h_{M_{*}, w}^{*}\right) \leq c_{2} \sigma^{|w|} .
$$

Note that $d$ is $M_{*^{-}}$adapted to $h_{r}$ by Assumption 2.15. Hence by [34, (2.4.1)],

$$
\begin{equation*}
c_{1} d(x, y) \leq \delta_{M_{*}}(x, y) \leq c_{2} d(x, y) \tag{8.7}
\end{equation*}
$$

for any $x, y \in K$. Choose $n=n_{M_{*}}(x, y)+1$. Let $w \in T_{n}$ satisfying $x \in K_{w}$. Since $n>n_{M_{*}}(x, y)$, it follows that if $v \in T_{n}$ and $y \in K_{v}$, then $v \notin \Gamma_{M_{*}}(w)$. Hence $h_{M_{*}, w}^{*}(x)=1$ and $h_{M_{*}, w}^{*}(y)=0$. Therefore (6.4 and 8.7) yield

$$
\begin{aligned}
& \sup _{f \in \mathcal{W}^{p}, \widehat{\mathcal{E}}_{p}(f) \neq 0} \frac{|f(x)-f(y)|^{p}}{\widehat{\mathcal{E}}_{p}(f)} \geq \frac{1}{\widehat{\mathcal{E}}_{p}\left(h_{M_{*}, w}^{*}\right)} \\
& \geq c\left(\sigma_{p}\right)^{-n} \geq c^{\prime} r^{n_{M_{*}}(x, y) \tau_{p}} \geq c^{\prime \prime} d(x, y)^{\tau_{p}}
\end{aligned}
$$

On the other hand in this case, $\eta_{M_{*}}(t)=t$ by 8.7). Hence Theorem 6.21 (c) implies the other side of the desired inequality.

Due to the general theory of resistance forms in [32], once we have 8.6), it is straightforward to obtain asymptotic estimates of the heat kernel.

Theorem 8.6. Suppose that Assumption 2.15 holds, $2>\operatorname{dim}_{A R}(K, d)$ and $K$ is 2 -conductively homogeneous. Set $\tau_{*}=\tau_{2}$. Then there exists a jointly continuous hear kernel $p_{\mu}(t, x, y)$ on $(0, \infty) \times K \times K$ associated with the diffusion process induced by the local regular Dirichlet form $\left(\mathcal{E}, \mathcal{W}^{2}\right)$ on $L^{2}(K, \mu)$. Moreover (1) There exist $\beta \geq 2$, a metric $\rho$, which is quasisymmetric to $d$, and constants $c_{1}, c_{2}, c_{3}, c_{4}>0$ such that

$$
\begin{equation*}
p_{\mu}(t, x, y) \leq \frac{c_{1}}{\mu\left(B_{\rho}\left(x, t^{\frac{1}{\beta}}\right)\right)} \exp \left(-c_{2}\left(\frac{\rho(x, y)^{\beta}}{t}\right)^{\frac{1}{\beta-1}}\right) \tag{8.8}
\end{equation*}
$$

for any $(t, x, y) \in(0, \infty) \times K \times K$ and

$$
\begin{equation*}
\frac{c_{3}}{\mu\left(B_{\rho}\left(x, t^{\frac{1}{\beta}}\right)\right)} \leq p_{\mu}(t, x, y) \tag{8.9}
\end{equation*}
$$

for any $y \in B_{\rho}\left(x, c_{4} t^{\frac{1}{\beta}}\right)$.
(2) Suppose that $\mu$ is $\alpha_{H}$-Ahlfors regular with respect to the metric d. Set $\beta_{*}=$ $\tau_{*}+\alpha_{H}$. Then $\beta_{*} \geq 2$ and there exist $c_{7}, c_{8}, c_{9}, c_{10}>0$ such that

$$
\begin{equation*}
p_{\mu}(t, x, y) \leq c_{6} t^{-\frac{\alpha_{H}}{\beta_{*}}} \exp \left(-c_{7}\left(\frac{d(x, y)^{\beta_{*}}}{t}\right)^{\frac{1}{\beta_{*}-1}}\right) \tag{8.10}
\end{equation*}
$$

for any $(t, x, y) \in(0, \infty) \times K \times K$ and

$$
\begin{equation*}
c_{9} t^{-\frac{\alpha_{H}}{\beta_{*}}} \leq p_{\mu}(t, x, y) \tag{8.11}
\end{equation*}
$$

for any $y \in B_{d}\left(x, c_{10} t^{\frac{\alpha_{H}}{\beta_{*}}}\right)$. In addition, suppose that $d$ has the chain condition, i.e. for any $x, y \in K$ and $n \in \mathbb{N}$, there exist $x_{0}, \ldots, x_{n} \in K$ such that $x_{0}=$ $x, x_{n}=y$ and $d\left(x_{i}, x_{i+1}\right) \leq C d(x, y) / n$, where the constant $C>0$ is independent of $x, y$ and $n$. Then there exist $c_{11}, c_{12}>0$ such that

$$
\begin{equation*}
c_{11} t^{-\frac{\alpha_{H}}{\beta_{*}}} \exp \left(-c_{12}\left(\frac{d(x, y)^{\beta_{*}}}{t}\right)^{\frac{1}{\beta_{*}-1}}\right) \leq p_{\mu}(t, x, y) . \tag{8.12}
\end{equation*}
$$

The exponent $\alpha_{H}$ above is in fact the Hausdorff dimension of $(K, d)$. The exponents $\beta$ and $\beta_{*}$ are called the walk dimensions.

Proof. We make use of [32, Theorems 15.10 and 15.11]. Since $\mu$ has the volume doubling property with respect to $d$, (8.6) shows that $\mu$ has the volume doubling property with respect to $R$ as well. Since $K$ is connected, $(K, R)$ is uniformly perfect. Moreover, since $\left(\mathcal{E}, \mathcal{W}^{2}\right)$ has the local property, the annulus comparable condition (ACC) holds by [32, Proposition 7.6]. Thus, the condition (C1) of [32, Theorem 15.11] is verified and so is the condition (C3) of [32, Theorem 15.11]. Using [32, Theorem 15.11], we have 8.8). Consequently, by [32, Theorem 15.10], we see 8.9 . Thus we have shown the first part of the statement. The fact that $\beta \geq 2$, which is beyond the reach of [32, Theorem 15.10], is due to [25]. See also [33, Theorem 22.2].

About the second part, assuming $\alpha_{H}$-Ahlfors regularity, i.e. 2.9), we see that

h_{d}(x, s)=s^{\tau_{*}+\alpha_{H}}=s^{\beta_{*}}
$$

where $h_{d}(x, s)$ is defined as

h_{d}(x, s)=\sup _{y \in B_{d}(x, s)} R(x, y) \cdot \mu\left(B_{d}(x, s)\right) .
$$

Hence following the flow of exposition of [32, Theorem 15.10], we have

$$
g(s)=s^{\beta_{*}} \quad \text { and } \quad \Phi(s)=s^{\beta_{*}-1}
$$

where $g$ and $\Phi$ appear in the statement of [32, Theorem 15.10]. Consequently, by [32, Theorem 15.10], we obtain (8.10), 8.11) and 8.12). The fact that $\beta_{*} \geq 2$ can be shown in the same way as we did for $\beta$ above.

## 9 Self-similar sets and self-similarity of energy

In this section, we consider the case where $K$ is a self-similar set with rationally related contraction ratios and construct self-similar energies under conductive homogeneity. Throughout this section, we fix a self-similar structure $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$. The notion of the self-similar structure was introduced to give a purely topological description of self-similar sets. See [29, Section 1.3] for details.

Definition 9.1. Let $K$ be a compact metrizable space, let $S$ be a finite set, and let $\left\{f_{s}\right\}_{s \in S}$ be a family of continuous injective maps from $K$ to itself.
(1) The triple ( $K, S,\left\{f_{s}\right\}_{s \in S}$ ) is called a self-similar structure if there exists a continuous surjective map $\chi: S^{\mathbb{N}} \rightarrow K$ such that

$$
\begin{equation*}
\chi\left(s_{1} s_{2} \ldots\right)=f_{s_{1}}\left(\chi\left(s_{2} s_{3} \ldots\right)\right) \tag{9.1}
\end{equation*}
$$

for any $s_{1} s_{2} \ldots \in S^{\mathbb{N}}$, where $S^{\mathbb{N}}$ is equipped with the product topology.
(2) Define $W_{*}=\cup_{n \geq 0} S^{n}$, where $S^{0}=\{\phi\}$. We use $w_{1} \ldots w_{n}$ to denote $\left(w_{1}, w_{2}, \ldots, w_{n}\right) \in S^{n}$. For $w_{1} \ldots w_{n} \in S^{n}$, set

$$
f_{w}=f_{w_{1}} \circ \ldots \circ f_{w_{n}} \quad \text { and } \quad K_{w}=f_{w}(K)
$$

In particular, $f_{\phi}$ is an identity map and $K_{\phi}=K$.
By [29, Proposition 3.3], if $\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ is a self-similar structure, $\chi$ : $S^{\mathbb{N}} \rightarrow K$ is uniquely given by

$$
\left\{\chi\left(s_{1} s_{2} \ldots\right)\right\}=\bigcap_{m \geq 0} K_{s_{1} \ldots s_{m}}
$$

for any $s_{1} s_{2} \ldots \in S^{\mathbb{N}}$.
Typically, an example of self-similar structures is given by a self-similar set with respect to a family of contractions. Let $(X, d)$ be a complete metric spaces and let $\left\{f_{i}\right\}_{i=1, \ldots, N}$ be a family of contractions of $(X, d)$, i.e. $f_{i}: X \rightarrow X$ and

$$
\sup _{x, y \in X, x \neq y} \frac{d\left(f_{i}(x), f_{i}(y)\right)}{d(x, y)}<1
$$

for any $i \in\{1, \ldots, N\}$. Then there exists a unique non-empty compact subset $K$ of $X$ satisfying

$$
\begin{equation*}
K=\bigcup_{i=1}^{N} f_{i}(K) \tag{9.2}
\end{equation*}
$$

See [29, Theorem 1.1.4] for example. The set $K$ is called a self-similar set with respect to $\left\{f_{i}\right\}_{i=1, \ldots, N}$. By [29, Theorem 1.2.3], if $S=\{1, \ldots, N\}$, then $\left(K, S,\left\{f_{i}\right\}_{i \in S}\right)$ is a self-similar structure.

Let $r \in(0,1)$ and let $j_{s} \in \mathbb{N}$ for $s \in S$. Define

$$
\begin{equation*}
j(w)=\sum_{i=1}^{m} j_{w_{i}} \quad \text { and } \quad g(w)=r^{j(w)} \tag{9.3}
\end{equation*}
$$

for $w=w_{1} \ldots w_{m} \in S^{m}$. (In particular, $j(\phi)=0$ and $g(\phi)=1$.) Define $\tilde{\pi}\left(w_{1} \ldots w_{m}\right)=w_{1} \ldots w_{m-1}$ for $w=w_{1} \ldots w_{m} \in S^{m}$ and

$$
\begin{equation*}
\Lambda_{r^{n}}^{g}=\left\{w \mid w=w_{1} \ldots w_{m} \in W_{*}, g(\tilde{\pi}(w))>r^{n} \geq g(w)\right\} \tag{9.4}
\end{equation*}
$$

Note that $\Lambda_{r^{n}}^{g} \cap \Lambda_{r^{n+1}}^{g}$ can be non-empty. (See Section 13 for example.) So to distinguish $w \in \Lambda_{r^{n}}^{g}$ and $w \in \Lambda_{r^{n+1}}^{g}$, we set

$$
T_{n}=\left\{(n, w) \mid w \in \Lambda_{r^{n}}\right\}
$$

and define $T=\cup_{n \geq 0} T_{n}$. There is a natural map $\iota: T \rightarrow W_{*}$ given by $\iota(n, w)=$ $w$. Define

$$
\mathcal{A}=\{((n, v),(n+1, w)) \mid n \geq 0, v=w \text { or } v=\tilde{\pi}(w)\}
$$

Then $(T, \mathcal{A}, \phi)$ is a rooted tree and $\left\{K_{w}\right\}_{w \in T}$ is a partition of $K$ parametrized by $(T, \mathcal{A}, \phi)$.

Next, define $\alpha_{H}$ to be the unique number satisfying

$$
\sum_{s \in S} r^{j_{s} \alpha_{H}}=1
$$

and let $\mu$ be the self-similar measure on $K$ with weight $\left\{r^{j_{s} \alpha_{H}}\right\}_{s \in S}$.
In the rest of this section, we presume the following assumption.
Assumption 9.2. There exists a metric $d$ on $K$ giving the original topology of $K$ and Assumption 2.15 holds with the metric $d$.

Under this assumption, in particular, due to Assumption 2.15 (3), there exist $c_{1}, c_{2}>0$ such that

$$
c_{1} r^{j(w)} \leq \operatorname{diam}\left(K_{w}, d\right) \leq c_{2} r^{j(w)}
$$

for any $w \in T$. This enable us to regard the contraction ratio of $f_{s}$ as $r^{j_{s}}$. From this fact, we say that the contraction ratios of $\left\{f_{s}\right\}_{s \in S}$ are rationally related.

Under our assumptions, let $\sigma$ be the same constant as in Theorem8.1. In this case, $\mu$ is $\alpha_{H}$-Ahlfors regular with respect to the metric $d$ and $\alpha_{H}$ coincides with the Hausdorff dimension of $(K, d)$. Note that even if we replace the definition (6.6) of $\widetilde{\mathcal{E}}_{p}^{m}(u)$ by

$$
\begin{equation*}
\widetilde{\mathcal{E}}_{p}^{m}(u)=\sigma^{m} \mathcal{E}_{p}^{m}(u) \tag{9.5}
\end{equation*}
$$

all the arguments in Section 6 work and the results are unchanged. Our goal of this section is the next theorem.

Theorem 9.3. Suppose that $p>\operatorname{dim}_{A R}(K, d)$ and that $K$ is $p$-conductively homogeneous.
(1) For any $w \in W_{*}$ and $f \in \mathcal{W}^{p}$,

$$
f \circ f_{w} \in \mathcal{W}^{p}
$$

(2) There exists $\mathcal{E}_{p}: \mathcal{W}^{p} \rightarrow[0, \infty)$ satisfying
(a) $\left(\mathcal{E}_{p}\right)^{\frac{1}{p}}$ is a semi-norm on $\mathcal{W}^{p}$ and there exist $c_{1}, c_{2}>0$ such that

$$
\begin{equation*}
c_{1} \mathcal{N}_{p}(f) \leq \mathcal{E}_{p}(f)^{\frac{1}{p}} \leq c_{2} \mathcal{N}_{p}(f) \tag{9.6}
\end{equation*}
$$

and

$$
c_{1} d(x, y)^{\tau_{p}} \leq \sup _{f \in \mathcal{W}^{2}, \mathcal{E}_{p}(f) \neq 0} \frac{|f(x)-f(y)|^{p}}{\mathcal{E}_{p}(f)} \leq c_{2} d(x, y)^{\tau_{p}}
$$

for any $f \in \mathcal{W}^{p}$ and $x, y \in K$.
(b) For any $f \in \mathcal{W}^{p}, \bar{f} \in \mathcal{W}^{p}$ and

$$
\mathcal{E}_{p}(\bar{f}) \leq \mathcal{E}_{p}(f)
$$

(c) For any $f \in \mathcal{W}^{p}$,

$$
\mathcal{E}_{p}(f)=\sum_{s \in S} \sigma^{j_{s}} \mathcal{E}_{p}\left(f \circ f_{s}\right)
$$

In particular, for $p=2,\left(\mathcal{E}_{2}, \mathcal{W}^{2}\right)$ is a local regular Dirichlet form on $L^{2}(K, \mu)$.
Proof. Define

$$
\begin{aligned}
& \mathcal{U}=\left\{A(\cdot) \mid A(\cdot) \text { is a semi-norm on } \mathcal{W}^{p}, \text { there exist } c_{1}, c_{2}>0\right. \text { such that } \\
& \left.\qquad c_{1} \mathcal{N}_{p}(f) \leq A(f) \leq c_{2} \mathcal{N}_{p}(f) \text { for any } f \in \mathcal{W}^{p}\right\}
\end{aligned}
$$

For $A_{1}, A_{2} \in \mathcal{U}$, we write $A_{1} \leq A_{2}$ if and only if $A_{1}(f) \leq A_{2}(f)$ for any $f \in \mathcal{W}^{p}$. We give $\mathcal{U}$ the point-wise convergence topology, i.e. $\left\{A_{n}\right\}_{n \geq 1} \subseteq \mathcal{U}$ is convergent to $A \in \mathcal{U}$ as $n \rightarrow \infty$ if and only if $A_{n}(f) \rightarrow A(f)$ as $n \rightarrow \infty$ for any $f \in \mathcal{W}^{p}$. Then due to the separability of $\mathcal{W}^{p}$ described in Theorem $6.22, \mathcal{U}$ is an ordered topological cone in the sense of [28].

Let $w \in W_{*}$. For any $v=v_{1} \ldots v_{k} \in \Lambda_{r^{n-j(w)}}$, since

$$
g\left(w v_{1} \ldots v_{k-1}\right)=g(w) g\left(v_{1} \ldots v_{k-1}\right)>g(w) r^{n-j(w)}=r^{n} \geq g(w v)
$$

it follows that $w v \in \Lambda_{r^{n}}$. This shows that $\left\{(n, w v) \mid v \in \Lambda_{r^{n-j(w)}}\right\} \subseteq T_{n}$. In fact, $T_{n}=\cup_{w \in S^{m}}\left\{(n, w v) \mid v \in \Lambda_{r^{n-j(w)}}\right\}$, which is a disjoint union. This yields

$$
\sum_{w \in S^{m}} \mathcal{E}_{p}^{n-j(w)}\left(P_{n-j(w)}\left(f \circ f_{w}\right)\right) \leq \mathcal{E}_{p}^{n}\left(P_{n} f\right)
$$

for any $f \in L^{p}(K, \mu)$. Therefore,

$$
\sum_{w \in S^{m}} \sigma^{j(w)} \widehat{\mathcal{E}}^{n-j(w)}\left(f \circ f_{w}\right) \leq \widehat{\mathcal{E}}_{p}^{n}(f)
$$

This inequality implies that $\sigma^{j(w)} \sup _{n \geq j(w)} \widehat{\mathcal{E}}^{n-j(w)}\left(f \circ f_{w}\right) \leq \mathcal{N}_{p}(f)^{p}<\infty$ for any $f \in \mathcal{W}^{p}$, so that $f \circ f_{w} \in \mathcal{W}^{p}$. Thus we have verified the statement (1). Again by the above inequality,

$$
\begin{align*}
& c \sum_{w \in S^{m}} \sigma^{j(w)} \mathcal{N}_{p}\left(f \circ f_{w}\right)^{p} \leq \sum_{w \in S^{m}} \sigma^{j(w)} \underline{\lim }_{n \rightarrow \infty} \widehat{\mathcal{E}}^{n-j(w)}\left(f \circ f_{w}\right) \\
& \leq \sup _{n \geq 0} \widehat{\mathcal{E}}_{p}^{n}(f)=\mathcal{N}_{p}(f)^{p} \tag{9.7}
\end{align*}
$$

Note that

$$
\sum_{(n, v) \in T_{n}} \sigma^{j(v)} \widehat{\mathcal{E}}_{p}^{k-j(v)}\left(f \circ f_{v}\right) \leq \sum_{w \in S^{m}} \sigma^{j(w)} \widehat{\mathcal{E}}^{n+k-j(w)}\left(f \circ f_{w}\right)
$$

By (6.13), taking lim in the left-hand side and sup in the right-hand side, we see that

$$
\begin{equation*}
c \sum_{(n, v) \in T_{n}} \sigma^{j(v)} \mathcal{N}_{p}\left(f \circ f_{v}\right)^{p} \leq \sum_{w \in S^{m}} \sigma^{j(w)} \mathcal{N}_{p}\left(f \circ f_{w}\right)^{p} . \tag{9.8}
\end{equation*}
$$

On the other hand, for any $(n, v) \in T_{n}$ and $x \in K_{v}$, the self-similarity of $\mu$ and (8.5) show

$$
\begin{aligned}
& \left|\left(P_{n} f\right)(v)-f(x)\right| \leq \int_{K}\left|f \circ f_{v}(y)-f \circ f_{v}\left(x_{0}\right)\right| \mu(d y) \\
& \quad \leq c \int_{K} d\left(x_{0}, y\right)^{\frac{\tau_{*}}{p}} \mu(d y) \mathcal{N}_{p}\left(f \circ f_{v}\right) \leq c^{\prime} \mathcal{N}_{p}\left(f \circ f_{v}\right),
\end{aligned}
$$

where $x_{0}=\left(f_{v}\right)^{-1}(x)$. Hence if $((n, v),(n, u)) \in E_{n}^{*}$, then

$$
\left|\left(P_{n} f\right)(v)-\left(P_{n} f\right)(u)\right| \leq c^{\prime}\left(\mathcal{N}_{p}\left(f \circ f_{v}\right)+\mathcal{N}_{p}\left(f \circ f_{w}\right)\right)
$$

This along with (9.8) yields

$$
\begin{aligned}
& \widehat{\mathcal{E}}_{p}^{n}(f)=\frac{\sigma^{n}}{2} \sum_{((n, v),(n, u)) \in E_{n}^{*}}\left|\left(P_{n} f\right)(v)-\left(P_{n} f\right)(u)\right|^{p} \\
& \leq C \sum_{(n, v) \in T_{n}} \sigma^{j(w)} \mathcal{N}_{p}\left(f \circ f_{v}\right)^{p} \leq C^{\prime} \sum_{w \in S^{m}} \sigma^{j(w)} \mathcal{N}_{p}\left(f \circ f_{w}\right)^{p} .
\end{aligned}
$$

Taking sup in the right-hand side, we have

$$
\begin{equation*}
\mathcal{N}_{p}(f)^{p} \leq C^{\prime} \sum_{w \in S^{m}} \sigma^{j(w)} \mathcal{N}_{p}\left(f \circ f_{w}\right)^{p} \tag{9.9}
\end{equation*}
$$

Now for $A \in \mathcal{U}$, define $\mathcal{F}(A)$ by

$$
\mathcal{F}(A)(f)=\left(\sum_{s \in S} \sigma^{j_{s}} A\left(f \circ f_{s}\right)^{p}\right)^{\frac{1}{p}}
$$

For any $A \in \mathcal{U}$, since $A \leq c_{2} \mathcal{N}_{p}$, 9.7) implies

$$
\mathcal{F}(A) \leq c_{2} \mathcal{F}\left(\mathcal{N}_{p}\right) \leq c^{\prime} \mathcal{N}_{p}
$$

On the other hand, the fact $c_{1} \mathcal{N}_{p} \leq A$ and (9.9) yield

$$
\mathcal{F}(A) \geq c_{1} \mathcal{F}\left(\mathcal{N}_{p}\right) \geq c^{\prime \prime} \mathcal{N}_{p}
$$

Thus $\mathcal{F}(A) \in \mathcal{U}$ and $\mathcal{F}: \mathcal{U} \rightarrow \mathcal{U}$. It is easy to see that $\mathcal{U}$ is continuous and $\mathcal{F}(A+B) \leq \mathcal{F}(A)+\mathcal{F}(B)$. Combining (9.7) and (9.9), we see that there exist $C_{1}, C_{2}>0$ such that

$$
c_{1} \mathcal{N}_{p} \leq \mathcal{F}^{j}\left(\mathcal{N}_{p}\right) \leq c_{2} \mathcal{N}_{p}
$$

for any $j \geq 1$. So, by [28, Theorem 1.5], there exists $\mathcal{E}_{*} \in \mathcal{U}$ such that $\mathcal{F}\left(\mathcal{E}_{*}\right)=$ $\mathcal{E}_{*}$. Define

$$
\mathcal{U}_{M}=\left\{A \mid A \in \mathcal{U}, A(\bar{f}) \leq A(f) \text { for any } f \in \mathcal{W}^{p}\right\}
$$

Then $\widehat{\mathcal{E}}_{p} \in \mathcal{U}_{M}$ and $\mathcal{U}_{M}$ is a closed subset of $\mathcal{U}$. Hence by [28, Corollary 1.6], we see there exists $\mathcal{E}^{\prime} \in \mathcal{U}_{M}$ such that $\mathcal{F}\left(\mathcal{E}^{\prime}\right)=\mathcal{E}^{\prime}$. Letting $\mathcal{E}=\left(\mathcal{E}^{\prime}\right)^{p}$, we have the desired $\mathcal{E}$. In the case $p=2$, define

$$
\mathcal{U}_{D F}=\{A \mid A \in \mathcal{U}, A \text { satisfies the parallelogram law, }
$$

the resulting quadratic form has both Markov and local property\}.
Then $\mathcal{U}_{D F}$ is a closed subspace of $\mathcal{U}$ and Theorem 6.23 ensures that $\mathcal{U}_{D F} \neq \emptyset$. So again by [28, Corollary 1.6], we have the desired local regular Dirichlet form.

## 10 Conductive homogeneity of self-similar sets

In this section, we present a sufficient condition for conductive homogeneity of self-similar sets. The idea is originated from [11, where the authors used symmetries of the spaces to show the combinatorial Loewner property of the Sierpinski carpet and the Menger curve, also known as the Menger sponge. Our sufficient condition, Theorem 10.2 , will be used in Sections 11 and 14

In this section, we assume that $\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ is a self-similar structure and adopt the setting in Section 9. For simplicity, we also assume that $j_{s}=1$ for any $s \in S$, so that $g(w)=r^{|w|}$ and $T_{m}=S^{m}$.

Definition 10.1. (1) For any $e=(w, v) \in E_{m}^{*}$, define

$$
X(e)=\left(f_{w}\right)^{-1}\left(f_{w}(K) \cap f_{v}(K)\right)
$$

and $\varphi_{e}: X(e) \rightarrow X\left(e^{r}\right)$ by $\left.\left(f_{v}\right)^{-1} \circ f_{w}\right|_{X(e)}$, where $e^{r}=(v, w)$ for $e=(w, v)$. Furthermore, define

$$
\mathcal{I T}(K, T)=\left\{\left(X(e), X\left(e^{r}\right), \varphi_{e}\right) \mid m \geq 1, e \in E_{m}^{*}\right\}
$$

An element of $\mathcal{I} \mathcal{T}(K, T)$ is called an intersection type of $(K, T)$.
(2) A homeomorphism $g: K \rightarrow K$ is said to be a symmetry of $(K, T)$ if there exists $g^{*}: T \rightarrow T$ such that $\left|g^{*}(w)\right|=|w|$ and $g\left(K_{w}\right)=K_{g^{*}(w)}$ for any $w \in T$. Define $\mathcal{G}_{(K, T)}$ as the collection of symmetries of $(K, T)$.
(3) For any $n \geq 0$, define $\psi_{n}: \cup_{m \geq 0} T_{n+m} \rightarrow T$ by $\psi_{n}(v)=u$ if $v \in T_{n+m}$ and $v=\pi^{m}(v) u$.
Remark. The notion of intersection types and the set $\mathcal{I T}(K, T)$ were introduced in 31.

Note that $\psi_{n}\left(T_{n+m}\right)=T_{m}$ and $\left(f_{\pi^{m}(v)}\right)^{-1}\left(K_{v}\right)=K_{\psi_{n}(v)}$ for any $v \in T_{n+m}$.
Notation. For $A \subseteq T$, set

$$
\begin{equation*}
K(A)=\bigcup_{v \in A} K_{v} \tag{10.10}
\end{equation*}
$$

Theorem 10.2. Suppose that there exist a finite subset $\mathcal{I} \subseteq \mathcal{I} \mathcal{T}(K, T)$ and finite subgroups $\mathcal{G}_{0}$ and $\mathcal{G}_{1}$ of $\mathcal{G}_{(K, T)}$ satisfying the following properties (a), (b) and (c):
(a) $\left(T_{m}, E_{m}^{\mathcal{I}}\right)$ is connected for any $m \geq 1$, where

$$
E_{m}^{\mathcal{I}}=\left\{e \mid e \in E_{m}^{*},\left(X(e), X\left(e^{r}\right), \varphi_{e}\right) \in \mathcal{I}\right\}
$$

(b) For any $(X, Y, \varphi) \in \mathcal{I}$ and $x \in X$, there exists $g \in \mathcal{G}_{0}$ such that $g(x)=\varphi(x)$.
(c) For any $n \geq 1, w \in T_{n}$ and $\mathbf{p} \in \mathcal{C}_{M, m}^{(1)}(w)$, there exists $\mathcal{U}_{\mathbf{p}} \subseteq \cup_{g \in \mathcal{G}_{1}} g^{*}\left(\psi_{n}(\mathbf{p})\right)$ such that $K\left(\mathcal{U}_{p}\right)$ is connected and $g\left(K\left(\mathcal{U}_{p}\right)\right) \cap X \neq \emptyset$ for any $(X, Y, \varphi) \in \mathcal{I}$ and $g \in \mathcal{G}_{0}$.
Then for any $p \geq 1, n, k \geq 1, m \geq 1, u_{*}, v_{*} \in T_{k}$, and $w \in T_{n}$,

$$
\begin{equation*}
\mathcal{M}_{M, p, m}^{(1)}(w) \leq\left(L_{*}\right)^{M} \#\left(\mathcal{G}_{1}\right)^{p+1} \#\left(T_{k}\right)^{p} \mathcal{M}_{p, m}^{(1)}\left(u_{*}, v_{*}, T_{k}\right) \tag{10.11}
\end{equation*}
$$

Furthermore, if Assumption 9.2 holds with $M_{*}=M$, then $K$ is p-conductively homogeneous for any $p>\operatorname{dim}_{A R}(K, d)$.

Remark. Strictly, a path $\mathbf{p}=(w(1), \ldots, w(k))$ of a graph is not a subset of vertices but a sequence of them. However, we use $\mathbf{p}$ to denote a subset $\{w(1), \ldots, w(k)\}$ if no confusion may occur. For example, in the expression $\psi_{n}(\mathbf{p})$ above, we regard $\mathbf{p}$ as a subset of $T_{n+m}$.

Proof. For $u \in S^{m}\left(\Gamma_{1}(w)\right)$, define $H_{u} \subseteq T_{k+m}$ by

$$
H_{u}=\left\{v g^{*}\left(\psi_{n}(u)\right) \mid g \in \mathcal{G}_{1}, v \in T_{k}\right\}
$$

Then $\#\left(H_{u}\right) \leq \#\left(T_{k}\right) \#\left(\mathcal{G}_{1}\right)$ for any $u \in S^{m}\left(\Gamma_{1}(w)\right)$ and $\#\left(\left\{u \mid v \in H_{u}\right\}\right) \leq$ $\#\left(\Gamma_{M}(w)\right) \#\left(\mathcal{G}_{1}\right)$ for any $v \in T_{k+m}$.

Now, since $\left(T_{k}, E_{k}^{\mathcal{I}}\right)$ is connected, there exists $(w(0), w(1), \ldots, w(l), w(l+$ $1)) \in\left(T_{k}\right)^{l+2}$ such that $w(0)=u_{*}, w(l+1)=v_{*},(w(i), w(i+1)) \in E_{k}^{\mathcal{I}}$ for any $i=0,1, \ldots, l$. Set $e_{i}=(w(i), w(i+1))$. Then $\left(X\left(e_{i}\right), X\left(e_{i}\right)^{r}, \varphi_{e_{i}}\right) \in \mathcal{I}$.
Claim: There exist $\mathcal{A}_{i} \subseteq T_{m}, x_{i} \in K$ and $g_{i}, h_{i} \in \mathcal{G}_{0}$ for $i=1,2, \ldots, l$ such that (i) $\mathcal{A}_{i}=\left(h_{i}\right)^{*}\left(\mathcal{U}_{\mathbf{p}}\right)$ and $K\left(\mathcal{A}_{i}\right) \cap X\left(e_{i}\right) \neq \emptyset$,
(ii) $x_{i} \in K\left(\mathcal{A}_{i}\right) \cap X\left(e_{i}\right)$ and $g_{i}\left(x_{i}\right)=\varphi_{e_{i}}\left(x_{i}\right)$,
and
(iii) $\mathcal{A}_{i+1}=\left(g_{i}\right)^{*}\left(\mathcal{A}_{i}\right)$.

Proof of Claim: For $i=1$, let $h_{1}$ be the identity map. Then $\mathcal{A}_{1}=\mathcal{U}_{\mathbf{p}}$. Since $K\left(\mathcal{A}_{1}\right) \cap X\left(e_{1}\right) \neq \emptyset$ by (c), we may choose $x_{1} \in K\left(\mathcal{A}_{1}\right) \cap X\left(e_{1}\right)$. By (b), there exists $g_{1} \in \mathcal{G}_{0}$ such that $g_{1}\left(x_{1}\right)=\varphi_{e_{1}}\left(x_{1}\right)$.

Assume that we have the desired objects for $i \in\{1, \ldots, l-1\}$. Letting $h_{i+1}=g_{i} \circ h_{i} \in \mathcal{G}_{0}$ and $\mathcal{A}_{i+1}=\left(g_{i}\right)^{*}\left(\mathcal{A}_{i}\right)$, we obtain

$$
\mathcal{A}_{i+1}=\left(g_{i}\right)^{*}\left(h_{i}\right)^{*}\left(\mathcal{U}_{\mathbf{p}}\right)=\left(h_{i+1}\right)^{*}\left(\mathcal{U}_{\mathbf{p}}\right)
$$

Using (c), we see that $K\left(\mathcal{A}_{i+1}\right) \cap X\left(e_{i+1}\right) \neq \emptyset$. Choose $x_{i+1} \in K\left(\mathcal{A}_{i+1}\right) \cap$ $X\left(e_{i+1}\right)$. By (b), there exists $g_{i+1} \in \mathcal{G}$ such that $g_{i+1}\left(x_{i+1}\right)=\varphi_{e_{i+1}}\left(x_{i+1}\right)$.
Thus by induction, the claim has been proven.

Now, by (c), $X\left(e_{0}\right) \cap K\left(\mathcal{A}_{1}\right) \neq \emptyset$. This implies

$$
\begin{equation*}
f_{w(1)}\left(K\left(\mathcal{A}_{1}\right)\right) \cap K_{w(0)} \neq \emptyset \tag{10.12}
\end{equation*}
$$

Next, Claim-(ii) yields $f_{w(i+1)}\left(g_{i}\left(x_{i}\right)\right)=f_{w(i)}\left(x_{i}\right)$. Moreover, since $g_{i}\left(x_{i}\right) \in$ $K\left(\left(g_{i}\right)^{*}\left(\mathcal{A}_{i}\right)\right)=K\left(\mathcal{A}_{i+1}\right)$, we have

$$
\begin{equation*}
f_{w(i)}\left(K\left(\mathcal{A}_{i}\right)\right) \cap f_{w(i+1)}\left(K\left(\mathcal{A}_{i+1}\right)\right) \neq \emptyset \tag{10.13}
\end{equation*}
$$

for $i=1, \ldots, l$. Since $\mathcal{A}_{i}=\left(h_{i}\right)^{*}\left(\mathcal{U}_{\mathbf{p}}\right) \subseteq \cup_{g \in \mathcal{G}_{1}} g^{*}\left(\psi_{n}(\mathbf{p})\right)$, it follows that $\cup_{i=1}^{l} w(i) \mathcal{A}_{i} \subseteq \cup_{u \in \mathbf{p}} H_{u}$. Note that $K\left(\cup_{i=1}^{l} w(i) \mathcal{A}_{i}\right)=\cup_{i=1}^{l} f_{w(i)}\left(\mathcal{A}_{i}\right)$. By 10.13 . and 10.11), we see that $K\left(\cup_{i=1}^{l} w(i) \mathcal{A}_{i}\right)$ is connected and intersects with $K_{w(0)}$. Thus there exists $\mathbf{p}_{0} \in \mathcal{C}_{m}^{(1)}\left(u_{*}, v_{*}, T_{k}\right)$ included in $\cup_{i=1}^{l} w(i) \mathcal{A}_{i} \subseteq \cup_{u \in \mathbf{p}} H_{u}$. Consequently, Lemma C.4 shows 10.11). The conductive homogeneity follows from Lemma 4.2 and Theorem 8.4.

## 11 Subsystems of (hyper)cubic tiling

In this section, we present three classes of hypercube-based self-similar sets as examples of conductively homogeneous spaces. The first one given in Theorem 11.5 includes generalized Sierpinski carpets studied in the series of papers [1, 2, 3, 4, 5, 6] by Barlow and Bass, the Menger curves (also known as the Menger sponge), and the hypercubes $[-1,1]^{L}$ for $L \geq 1$. Unlike those examples, however, our examples also contain self-similar sets with fewer, or even no, symmetries of a hypercube. See Section 12, where we present examples of self-similar sets having conductive homogeneity.

We start with basic notations on the hypercube $[-1,1]^{L}$ and its symmetry group.

Definition 11.1. Let $L \in \mathbb{N}$ and let $C_{*}^{L}=[-1,1]^{L}$. Moreover let $\mathbb{B}_{L}$ be the $L$-dimensional hyperoctahedral group, that is,

$$
\mathbb{B}_{L}=\left\{g \mid g \in O(L), g\left(C_{*}^{L}\right)=C_{*}^{L}\right\}
$$

where $O(L)$ is the collection of orthogonal transformations of $\mathbb{R}^{L}$. Define

$$
B_{j, i}=\left\{\left(x_{1}, \ldots, x_{L}\right) \mid\left(x_{1}, \ldots, x_{I}\right) \in[-1,1]^{L}, x_{j}=i\right\}
$$

for $j=\{1, \ldots, L\}$ and $i \in\{-1.0,1\}$. Then the boundary of $[-1,1]^{L}$ consists of $\left\{B_{j, i}\right\}_{j \in\{1, \ldots, L\}, i \in\{1,-1\}}$. For $s=\left(s_{1}, \ldots, s_{L}\right) \in\{1, \ldots, N\}^{L}$, define

$$
C_{s}^{L, N}=\prod_{i=1}^{L}\left[\frac{2 s_{i}-2-N}{N}, \frac{2 s_{i}-N}{N}\right]
$$

and

$$
c_{s}^{L, N}=\left(\frac{2 s_{1}-1-N}{N}, \ldots, \frac{2 s_{L}-1-N}{N}\right)
$$

If no confusion may occur, we use $C_{*}, C_{s}$ and $c_{s}$ instead of $C_{*}^{L}, C_{s}^{L, N}$ and $c_{s}^{L, N}$ respectively hereafter.

In the course of this section, we are going to deal with particular elements of $\mathbb{B}_{L}$.

Definition 11.2. Define $R_{j} \in \mathbb{B}_{L}$ as the reflection in the hyperplane $B_{j, 0}$ for $j=\{1, \ldots, L\}$. Furthermore, define $R_{j_{1}, j_{2}}^{i}$ as the reflection in the hyperplane

$$
\mathcal{H}_{j_{1}, j_{2}}^{i}=\left\{\left(x_{1}, \ldots, x_{L}\right) \mid x_{j_{1}}=i x_{j_{2}}\right\}
$$

for $j_{1}, j_{2} \in\{1, \ldots, L\}$ with $j_{1} \neq j_{2}$ and $i \in\{1,-1\}$.
In the next definition, we introduce key notions of this section.
Throughout this section, we fix $L \geq 1$ and $N \geq 2$.
Definition 11.3. (1) A self-similar structure $\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ is called a subsystem of $L$-dimensional hypercubic tiling, or a subsystem of cubic tiling for short, if $K \subseteq C_{*}, S \subseteq\{1, \ldots, N\}^{L}$ and, for any $s \in S, f_{s}$ is a restriction of a similitude from $\mathbb{R}^{L}$ to itself satisfying $f_{s}\left(C_{*}\right)=C_{s}$, i.e. there exists $\Phi_{s} \in \mathbb{B}_{L}$ such that

$$
\begin{equation*}
f_{s}(x)=\frac{1}{N} \Phi_{s} x+c_{s} \tag{11.1}
\end{equation*}
$$

for any $x \in \mathbb{R}^{L}$. A subsystem of cubic tiling $\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ is called nondegenerate if $K \cap B_{j, i} \neq \emptyset$ for any $j \in\{1, \ldots, L\}$ and $i \in\{1,-1\}$.
(2) A continuous map $\varphi: C_{*} \rightarrow C_{*}$ is called an $N$-folding map if and only if, for any $s \in\{1, \ldots, N\}^{L}$, there exists $A_{s} \in \mathbb{B}_{L}$ such that

$$
\begin{equation*}
\varphi(x)=N A_{s}\left(x-c_{s}\right) \tag{11.2}
\end{equation*}
$$

for any $x \in C_{s}$. If no confusion may occur, we omit $N$ in the expression of an " $N$-folding" map and say a "folding map" for simplicity.
(3) Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling. We use the framework of Section 9 to define $(T, \mathcal{A}, \phi)$ with $r=\frac{1}{N}$ and $j_{s}=1$ for any $s \in S$. In this case, $T_{n}=S^{n}$ for any $n \geq 1$. Define a graph $\left(T_{n}, E_{n}^{\ell}\right)$ by

$$
\begin{aligned}
E_{n}^{\ell}=\left\{(w, v) \mid w, v \in T_{n}, w \neq v,\right. & f_{w}\left(C_{*}\right) \cap f_{v}\left(C_{*}\right)=f_{w}\left(B_{j, i}\right) \\
& \quad \text { for some } j \in\{1, \ldots, L\} \text { and } i \in\{1,-1\}\} .
\end{aligned}
$$

$\mathcal{L}$ is said to be strongly connected if and only if $\left(T_{n}, E_{n}^{\ell}\right)$ is connected for any $n \geq 1$.
(4) Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling. $\mathcal{L}$ is called locally symmetric if and only if $K_{w} \cup K_{v}$ is invariant under the reflection in the hyperplane including $f_{w}\left(C_{*}\right) \cap f_{v}\left(C_{*}\right)$ for any $n \geq 1$ and $(w, v) \in E_{n}^{\ell}$.

Remark. Let $\mathcal{L}$ be a subsystem of cubic tiling which is non-degenerate and locally symmetric. Then $E_{n}^{\ell} \subseteq E_{n}^{*}$ by the following arguments. Assume that $(w, v) \in E_{n}^{\ell}$. Set

$$
\begin{equation*}
\ell_{w, v}=f_{w}\left(C_{*}\right) \cap f_{v}\left(C_{*}\right) \tag{11.3}
\end{equation*}
$$

By non-degeneracy, $K_{w} \cap \ell_{w, v} \neq \emptyset$ and by local symmetry, $K_{w} \cap \ell_{w, v}=K_{v} \cap$ $\ell_{w, v} \neq \emptyset$. Hence $(w, v) \in E_{n}^{*}$. Note that even if $(w, v) \in T_{n}$ and $f_{w}\left(C_{*}\right) \cap$ $f_{v}\left(C_{*}\right) \neq \emptyset$, it may happen that $K_{w} \cap K_{v}=\emptyset$.

By properties of cubic tiling, it is easy to see that Assumption 2.15 holds. In summary, we have the next proposition. Recall that the edges of $T_{n}$ is given not by $E_{n}^{\ell}$ but by $E_{n}^{*}$ as it has always been in the previous sections.

Proposition 11.4. Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling. Then $\left\{K_{w}\right\}_{w \in T}$ is a partition of $K$ parametrized by the tree $(T, \mathcal{A}, \phi)$. Let $d_{*}$ be the restriction of the Euclidean metric on $K$ and let $\mu$ be the self-similar measure satisfying $\mu\left(K_{w}\right)=(\#(S))^{-|w|}$ for any $w \in T$. Then Assumption 2.15 is satisfied with $d=d_{*}, r=\frac{1}{N}, M_{*}=1, M_{0}=1, N_{*}=\#(S)$ and $L_{*} \leq 3^{L}-1$. In this case, $\mu$ is $\alpha_{H}$-Ahlfors regular with respect to $d_{*}$, where $\alpha_{H}=\frac{\log \#(S)}{\log N}$.

The exponent $\alpha_{H}$ coincides with the Hausdorff dimension of $\left(K, d_{*}\right)$. Note that $\#(S) \leq N^{L}$. Since $\#(S)=N^{L}$ implies $K=C_{*}$, we see that $\alpha_{H}<L$ unless $K=C_{*}$.

The following theorems are the main results of this section.
Theorem 11.5. Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling. Assume that $\mathcal{L}$ is non-degenerate, locally symmetric, and strongly connected. Moreover, suppose that the following condition (SDR) is satisfied:
(SDR) For any $j_{1}, j_{2} \in\{1, \ldots, L\}$ with $j_{1} \neq j_{2}$, there exists $i \in\{1,-1\}$ such that $R_{j_{1}, j_{2}}^{i} \in \mathcal{G}_{(K, T)}$.
Then $K$ is $p$-conductively homogeneous for any $p>\operatorname{dim}_{A R}\left(K, d_{*}\right)$.
The name (SDR) represents "symmetric with respect to diagonal reflections" as $R_{j_{1}, j_{2}}^{i}$ is the reflection in the diagonal hyperplane $\mathcal{H}_{j_{1}, j_{2}}^{i}$. For generalized Sierpinski carpets, the Menger curve and the hypercube, it follows that $\mathcal{G}_{(K, T)}=\mathbb{B}_{L}$ and the condition ( SDR ) is satisfied. However, $\mathcal{G}_{(K, T)}$ does not necessarily coincide with $\mathbb{B}_{L}$ to satisfy (SDR). For example, the group generated by $\left\{R_{j_{1}, j_{2}}^{1} \mid j_{1}, j_{2} \in\{1, \ldots, L\}, j_{1} \neq j_{2}\right\}$ is (isomorphic to) the symmetric group of order $L, \mathcal{S}_{L}$, that is a proper subgroup of $\mathbb{B}_{L}$, and if $\mathcal{S}_{L} \subseteq \mathcal{G}_{(K, T)}$, then the condition (SDR) is satisfied. See Example 12.6

In the case $L=2$, the advantage of being planar gives another two classes having conductive homogeneity.

Theorem 11.6. Let $L=2$ and let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of 2 dimensional cubic tiling. Assume that $\mathcal{L}$ is non-degenerate, locally symmetric, and strongly connected. Moreover, assume one of the following two conditions (RS) or (NS).
(RS) $\Theta_{\pi / 2} \in \mathcal{G}_{(K, T)}$, where $\Theta_{\pi / 2}$ is the rotation by $\pi / 2$ around $(0,0)$.
(NS) For each $i, j \in\{1, \ldots, N\}$, there exist $i_{1}, j_{1} \in\{1, \ldots, N-1\}$ such that

$$
\left\{\left(i_{1}, j\right),\left(i_{1}+1, j\right),\left(i, j_{1}\right),\left(i, j_{1}+1\right)\right\} \cap S=\emptyset
$$

Then $K$ is $p$-conductively homogeneous for any $p>\operatorname{dim}_{A R}\left(K, d_{*}\right)$.

The expressions (RS) and (NS) represent "rotational symmetry" and "no symmetry" respectively.

At a glance at definitions, it may look difficult to verify the conditions like "non-degenerate", "strongly continuous", and "locally symmetric". In the course of discussion, however, we will show useful criteria concerning only the first iteration $\left\{f_{s}\left(C_{*}\right)\right\}_{s \in S}$ to check those conditions.

Proofs of the above theorems will be given later in this section after necessary preparations. The main idea of the proof is to construct a family of paths required in the condition (c) of Theorem 10.2 by using local symmetry and an additional geometric condition (SDR), (RS) or (NS). Such an idea was used in 11 and can be traced back to the "Knight move" argument by Barlow-Bass [1]. In those previous works, however, the full $\mathbb{B}_{L}$-symmetry of the space was required but we find that weaker (or even no) symmetry is good enough under the presence of local symmetry.

Now we start to study the conditions "non-degenerate", "strong continuous", and "locally symmetric". First, we study the nature of folding maps, which turns out to be closely related to the local symmetry.

Lemma 11.7. Let $\varphi: C_{*} \rightarrow C_{*}$ be a folding map characterized as 11.2). Then for any $s, t \in\{1, \ldots, N\}^{L}$,

$$
A_{s}=A_{t} R_{j} \quad \text { if } C_{s} \cap C_{t}=\frac{1}{N} B_{j, i}+c_{s} \text { for some } i \in\{1,-1\}
$$

Proof. Assume that $C_{s} \cap C_{t}=\frac{1}{N} B_{j, i}+c_{s}$. Then $C_{s} \cap C_{t}=\frac{1}{N} B_{j,-i}+c_{t}$ as well and $x-c_{t}=R_{j}\left(x-c_{s}\right)$ for any $x \in C_{s} \cap C_{t}$. On the other hand, as $\varphi$ is a folding map, we see that

$$
N A_{s}\left(x-c_{s}\right)=N A_{t}\left(x-c_{t}\right)
$$

for any $x \in C_{s} \cap C_{t}$. Hence $A_{s}\left(x-c_{s}\right)=A_{t} R_{j}\left(x-c_{s}\right)$ for any $x \in C_{s} \cap C_{t}$. This immediately implies $A_{s}=A_{t} R_{j}$.

Note that $R_{j_{1}} R_{j_{2}}=R_{j_{2}} R_{j_{1}}$ for any $j_{1}, j_{2} \in\{1, \ldots, L\}$. So, by the above lemma, we can determine all the folding maps as follows.

Lemma 11.8. Fix $s^{*}=\left(s_{1}^{*}, \ldots, s_{L}^{*}\right) \in\{1, \ldots, N\}^{L}$. For $A \in \mathbb{B}_{L}$, define $\varphi_{s^{*}, A}$ : $C_{*} \rightarrow C_{*}$ by

$$
\varphi_{s^{*}, A}(x)=N A \prod_{j=1}^{L}\left(R_{j}\right)^{\left|s_{j}^{*}-s_{j}\right|}\left(x-c_{(i, j)}^{N}\right)
$$

for any $x \in C_{\left(s_{1}, \ldots, s_{L}\right)}$. Then $\varphi_{s_{0}, A}$ is a folding map. Moreover, $\left\{\varphi_{s^{*}, A} \mid A \in \mathbb{B}_{L}\right\}$ is the totality of folding maps for any $s^{*} \in\{1, \ldots, N\}^{L}$.

Examples of folding maps in the case of $L=2$ are given in Figure 8. In each example, $s^{*}=(1,1)$ and $A=I$. The element of $\mathbb{B}_{2}$ in each square indicates the corresponding $A\left(R_{1}\right)^{\left|s_{1}-s_{1}^{*}\right|}\left(R_{2}\right)^{\left|s_{2}-s_{2}^{*}\right|}$.

Notation. Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling. Set

$$
K^{(m)}=\bigcup_{w \in T_{m}} f_{w}\left(C_{*}\right) .
$$

Due to the next lemma, one can easily determine non-degeneracy of $K$ by examining $K^{(1)}$.
Lemma 11.9. Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling. Then $\mathcal{L}$ is non-degenerate if and only if $K^{(1)} \cap B_{j, i} \neq \emptyset$ for any $j \in\{1, \ldots, L\}$ and $i \in\{1,-1\}$.
Proof. Since $K \subseteq K^{(1)}$, the "only if" part is obvious. Assume that $K^{(1)} \cap B_{j, i} \neq$ $\emptyset$ for any $j \in\{1, \ldots, L\}$ and $i \in\{1,-1\}$. We are going to show that $K^{(k)} \cap B_{j, i} \neq$ $\emptyset$ for any $j \in\{1, \ldots, L\}, i \in\{1,-1\}$, and $k \in\{1, \ldots, n\}$ by induction on $n$. Assume that the claim holds for $n$. Let $w \in T_{n}$ satisfying $f_{w}\left(C_{*}\right) \cap B_{j, i} \neq \emptyset$. Since $\left(f_{w}\right)^{-1}\left(f_{w}\left(C_{*}\right) \cap B_{j, i}\right)=B_{j_{1}, i_{1}}$ for some $j_{1} \in\{1, \ldots, L\}$ and $i_{1} \in\{1,-1\}$, there exists $s \in T_{1}$ such that $f_{s}\left(C_{*}\right) \cap\left(f_{w}\right)^{-1}\left(f_{w}\left(C_{*}\right) \cap B_{j, i}\right) \neq \emptyset$. This implies that $f_{w s}\left(C_{*}\right) \cap B_{j, i} \neq \emptyset$. Thus we have shown the desired statement for $n+1$. Now by induction, $K^{(k)} \cap B_{j, i} \neq \emptyset$ for any $j \in\{1, \ldots, L\}, i \in\{1,-1\}$. Since $K^{(n)}$ is monotonically decreasing and $K=\cap_{n \geq 1} K^{(n)}$, it follows that $K \cap B_{j, i} \neq \emptyset$ for any $j \in\{1, \ldots, L\}$ and $i \in\{1,-1\}$.

The locally symmetric property can also be determined by the first step of the iteration as follows.
Lemma 11.10. Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling. Then $\mathcal{L}$ is locally symmetric if and only if $K_{s} \cup K_{t}$ is invariant under the reflection in $\ell_{s, t}$ for any $(s, t) \in E_{1}^{\ell}$.

Proof. The "only if" part is obvious. We show the following statement by induction on $n \geq 1$.
For any $k \in\{1, \ldots, n\}$, and $(w, v) \in E_{k}^{\ell}, K_{w} \cup K_{v}$ is invariant under the reflection in $\ell_{w, v}$.
The case $n=1$ is exactly the assumption of the lemma. Suppose that the statement holds for $n$. Let $(w, v) \in E_{n+1}^{\ell}$. In case $\pi^{n}(w)=\pi^{n}(v)$, let $s=\pi^{n}(w)$. Then $w=s w^{\prime}$ and $v=s v^{\prime}$ for some $w^{\prime}, v^{\prime} \in T_{n}$. Since $f_{w}\left(C_{*}\right)=f_{s}\left(f_{w^{\prime}}\left(C_{*}\right)\right)$ and $f_{v}\left(C_{*}\right)=f_{s}\left(f_{v^{\prime}}\left(C_{*}\right)\right)$, we see $\ell_{w^{\prime}, v^{\prime}} \in E_{n}^{\ell}$. By induction hypothesis, $K_{w^{\prime}} \cap K_{v^{\prime}}$ is invariant under the reflection in $\ell_{w^{\prime}, v^{\prime}}$. Applying $f_{s}$, we see that $K_{w} \cup K_{v}$ is invariant under the reflection in $\ell_{w, v}$. In case $\pi^{n}(w) \neq \pi^{n}(v)$, let $s=\pi^{n}(w)$ and let $t=\pi^{n}(v)$. Since $\ell_{w, v} \subseteq \ell_{s, t}=f_{s}\left(B_{j, i}\right)$ for some $j \in\{1, \ldots, L\}$ and $i \in\{1,-1\}$, we obtain $(s, t) \in E_{1}^{\ell}$. So, $K_{s} \cup K_{t}$ is invariant under the reflection in $\ell_{s, t}$. Denoting this reflection by $R$, we see that $R$ coincides with the reflection in $\ell_{w, v}$. Since $R\left(f_{w}\left(C_{*}\right)\right)=f_{v}\left(C_{*}\right)$, it follows that $R\left(K_{w}\right)=R\left(K_{s} \cap f_{w}\left(C_{*}\right)\right)=$ $K_{t} \cap f_{v}\left(C_{*}\right)=K_{v}$. So we have verified the statement for $n+1$. Thus by induction, we have the desired result.

Next, we consider the strongly connectedness.
Lemma 11.11. Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a locally symmetric subsystem of cubic tiling. If $\mathcal{L}$ is non-degenerate and $\left(T_{1}, E_{1}^{\ell}\right)$ is connected, then $\mathcal{L}$ is strongly connected.

Proof. By the non-degeneracy, we see that $K^{(n)} \cap B_{j, i} \neq \emptyset$ for any $j \in\{1, \ldots, L\}$ and $i \in\{1,-1\}$.

We are going to show that $\left(T_{k}, E_{k}^{\ell}\right)$ is connected for any $k \in\{1, \ldots, n\}$ by induction on $n \geq 1$. Assume that $w, v \in T_{n+1}$. If $\pi^{n}(w)=\pi^{n}(v)$, then there exist $w^{\prime}, v^{\prime} \in T_{n}$ such that $w=s w^{\prime}$ and $v=s v^{\prime}$, where $s=\pi^{n}(w)$. Since $w^{\prime}$ and $v^{\prime}$ are connected by an $E_{n}^{\ell}$-path, $w$ and $v$ are connected by an $E_{n+1}^{\ell}$-path. In case $\pi^{n}(w) \neq \pi^{n}(v)$, let $s=\pi^{n}(w)$ and let $t=\pi^{n}(v)$. Then $w=s w^{\prime}$ and $v=t v^{\prime}$ for some $w^{\prime}, v^{\prime} \in T_{n}$. Since $\left(T_{1}, E_{1}^{\ell}\right)$ is connected, there exists an $E_{1}^{\ell}$ path $(s(0), \ldots, s(m))$ such that $s(0)=s, s(m)=t$ and $(s(i), s(i+1)) \in E_{1}^{\ell}$ for any $i=0, \ldots, m-1$. For each $i=0, \ldots, m-1$, since $\cup_{w^{\prime} \in T_{n}} f_{w^{\prime}}\left(C_{*}\right) \cap$ $B_{j, i} \neq \emptyset$ for any $j=\{1, \ldots, L\}$ and $i \in\{1,-1\}$, there exists $u(i) \in T_{n}$ such that $f_{s(i) u(i)}\left(C_{*}\right) \cap \ell_{s(i), s(i+1)} \neq \emptyset$. Since $\mathcal{L}$ is locally symmetric, there exists $v(i) \in T_{n}$ such that $f_{s(i+1) v(i)}\left(C_{*}\right)$ is the image of $f_{s(i) u(i)}\left(C_{*}\right)$ by the reflection in $\ell_{s(i), s(i+1)}$. Define $v(-1)=w^{\prime}$ and $u(m)=v^{\prime}$. Then $w=s(0) v(-1)$ and $v=s(m) u(m)$. Since $\left(T_{n}, E_{n}^{\ell}\right)$ is connected, $v(i-1)$ and $u(i)$ are connected by an $E_{n}^{\ell}$-path for any $i=0, \ldots, m-1$. Adding $s(i)$ at the top, we obtain an $E_{n+1}^{\ell}$-path between $s(i) v(i-1)$ and $s(i) u(i)$. Combining all these $E_{n+1}^{\ell}$-paths, we obtain an $E_{n+1}^{\ell}$-path between $w$ and $v$. Thus $\left(T_{n+1}, E_{n+1}^{\ell}\right)$ is connected. By induction, we see that $\mathcal{L}$ is strongly connected.

Lemma 11.12. Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling. Assume that $K \cap \operatorname{int}\left(C_{*}\right) \neq \emptyset$. For any $s \in\left\{1, \ldots, N^{m}\right\}^{L}$, if $K \cap \operatorname{int}\left(C_{s}^{L, N^{m}}\right) \neq \emptyset$, then there exists $w \in T_{m}$ such that $f_{w}\left(C_{*}\right)=C_{s}^{L, N^{m}}$.

Proof. Suppose that $f_{w}\left(C_{*}\right) \neq C_{s}^{L, N^{m}}$ for all $w \in T_{m}$. Then $f_{w}\left(C_{*}\right) \cap C_{s}^{L, N^{m}}$ is included in the boundary of $C_{s}^{L, N^{m}}$ and hence $f_{w}\left(C_{*}\right) \cap \operatorname{int}\left(C_{s}^{L, N^{m}}\right)=\emptyset$. So,

$$
K^{(m)} \cap \operatorname{int}\left(C_{s}^{L, N^{m}}\right)=\bigcup_{w \in T_{m}}\left(f_{w}\left(C_{*}\right) \cap \operatorname{int}\left(C_{s}^{L, N^{m}}\right)\right)=\emptyset
$$

Since $K \subseteq K^{(m)}$, it follows that $K \cap \operatorname{int}\left(C_{s}^{L, N^{m}}\right)=\emptyset$.
The following relation between a folding map and a subsystem of cubic tiling will be used to characterize local symmetry.
Lemma 11.13. Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling. Assume that $K \cap \operatorname{int}\left(C_{*}\right) \neq \emptyset$. Let $\varphi$ be a folding map. Then the following four statements are equivalent:
(a) $\varphi(K)=K$.
(b) $\varphi \circ f_{s}\left(K^{(m)}\right)=K^{(m)}$ for any $s \in S$ and $m \geq 0$.
(c) $\varphi \circ f_{s}(K)=K$ for any $s \in S$.
(d) $\varphi\left(K^{(m+1)}\right)=K^{(m)}$ for any $m \geq 0$.

Proof. (a) $\Rightarrow$ (b): Let $s \in S$. Then $\varphi \circ f_{s}(K) \subseteq K$. For any $w \in T_{m}$, there exists $\tau=\left(\tau_{1}, \ldots, \tau_{L}\right) \in\left\{1, \ldots, N^{m}\right\}^{L}$ such that $\varphi \circ f_{s}\left(f_{w}\left(C_{*}\right)\right)=C_{\tau}^{L, N^{m}}$. Now

$$
K \supseteq \varphi \circ f_{s}\left(f_{w}\left(K \cap \operatorname{int}\left(C_{*}\right)\right)\right)=\varphi \circ f_{s} \circ f_{w}(K) \cap \operatorname{int}\left(C_{\tau}^{L, N^{m}}\right)
$$

Since $K \cap \operatorname{int}\left(C_{*}\right) \neq \emptyset$, this implies $K \cap \operatorname{int}\left(C_{\tau}^{L, N^{m}}\right) \neq \emptyset$. Lemma 11.12 shows that $\varphi \circ f_{s}\left(f_{w}\left(C_{*}\right)\right)=C_{\tau}^{L, N^{m}} \subseteq K^{(m)}$, so that

$$
\varphi \circ f_{s}\left(K^{(m)}\right)=\bigcup_{w \in T_{m}} \varphi \circ f_{s}\left(f_{w}\left(C_{*}\right)\right) \subseteq K^{(m)}
$$

Note that $\varphi \circ f_{s} \in \mathbb{B}_{L}$ preserves the Lesbegue measure of a set. Hence we see $\varphi \circ f_{s}\left(K^{(m)}\right)=K^{(m)}$.
$(\mathrm{b}) \Rightarrow(\mathrm{c}):$ Since $\cap_{m \geq 0} K^{(m)}=K$,

$$
\varphi \circ f_{s}(K)=\varphi \circ f_{s}\left(\bigcap_{m \geq 0} K^{(m)}\right)=\bigcap_{m \geq 0} K^{(m)}=K
$$

$(\mathrm{c}) \Rightarrow(\mathrm{a})$ : Since $K=\cup_{s \in S} f_{s}(K)$,

$$
\varphi(K)=\varphi\left(\bigcup_{s \in S} f_{s}(K)\right)=K
$$

$(\mathrm{b}) \Rightarrow(\mathrm{d}): \quad$ Since $\cup_{s \in S} f_{s}\left(K^{(m)}\right)=K^{(m+1)}$,

$$
\varphi\left(K^{(m+1)}\right)=\varphi\left(\bigcup_{s \in S} f_{s}\left(K^{(m)}\right)\right)=K^{(m)}
$$

(d) $\Rightarrow(\mathrm{a}):$ Since $\cap_{m \geq 0} K^{(m)}=K$,

$$
\varphi(K)=\varphi\left(\bigcap_{m \geq 0} K^{(m+1)}\right)=\bigcap_{m \geq 0} K^{(m)}=K
$$

The next theorem tells that a locally symmetric subsystem of cubic tiling is almost an inverse of a folding map.

Theorem 11.14. Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling.
(1) If $\mathcal{L}$ is strongly connected and locally symmetric, then there exists a folding map satisfying

$$
\begin{equation*}
\varphi^{n} \circ f_{w}\left(K^{(m)}\right)=K^{(m)} \tag{11.4}
\end{equation*}
$$

for any $n \geq 1, m \geq 0$ and $w \in T_{n}$. In particular,

$$
\varphi^{n}\left(K^{(n+m)}\right)=K^{(m)}
$$

for any $n \geq 1, m \geq 0$ and

$$
\varphi^{n}(K)=K
$$

for any $n \geq 1$. Furthermore, define $F_{s}: C_{*} \rightarrow C_{s}$ by $F_{s}=\left(\left.\varphi\right|_{C_{s}}\right)^{-1}$ for each $s \in S$. Then

$$
K=\bigcup_{s \in S} F_{s}(K)
$$

and $\left(K, S,\left\{F_{s}\right\}_{s \in S}\right)$ is a self-similar structure.
(2) Suppose that $K \cap \operatorname{int}\left(C_{*}\right) \neq \emptyset$. If there exists a folding map $\varphi$ such that $\varphi(K)=K$, then $\mathcal{L}$ is locally symmetric.
Proof. (1) Fix $s \in S$. Recall that there exists $\Phi_{s} \in \mathbb{B}_{L}$ such that

$$
f_{s}(x)=\frac{1}{N} \Phi_{s} x+c_{s}
$$

for any $x \in C_{*}$. Set $A_{s}=\left(\Phi_{s}\right)^{-1}$ and define $\varphi=\varphi_{s_{0}, A_{s}}$. Since $\varphi \circ f_{s}=I$, it follows that $\varphi^{n} \circ\left(f_{s}\right)^{n}=I$ for any $n \geq 1$. Thus letting $s_{n}=\underset{n}{s s \ldots s} \underset{n}{ }$-times , we see that $\varphi^{n} \circ f_{s_{n}}(K)=K$. Choose $\tau=\left(\tau_{1}, \ldots, \tau_{L}\right) \in\left\{1, \ldots, N^{n}\right\}^{L}$ such that $C_{\tau}^{L, N^{n}}=f_{s_{n}}\left(C_{*}\right)$. Let $w \in T_{n}$. Choose $\xi=\left(\xi_{1}, \ldots, \xi_{L}\right) \in\left\{1, \ldots, N^{n}\right\}^{L}$ such that $C_{\xi}^{L, N^{n}}=f_{w}\left(C_{*}\right)$. Since $\mathcal{L}$ is strongly connected, there exists an $E_{n}^{\ell}$-path $(w(0), \ldots, w(m))$ between $s_{n}$ and $w$. Following this path and applying the reflections in $\ell_{w(i), w(i+1)}$, we see that

$$
K_{w}-c_{\xi}^{L, N^{n}}=R\left(K_{s_{n}}-c_{\tau}^{L, N^{n}}\right),
$$

where $R=\prod_{j=1}^{L}\left(R_{j}\right)^{\left|\tau_{j}-\xi_{j}\right|}$. Note that $\varphi^{n}$ is an $N^{n}$-folding map. For any $\gamma \in\left\{1, \ldots, N^{n}\right\}^{L}$, there exists $A_{\gamma} \in \mathbb{B}_{L}$ such that

$$
\varphi^{n}(x)=N^{n} A_{\gamma}\left(x-c_{\gamma}^{L, N^{n}}\right)
$$

for any $x \in C_{\gamma}^{L, N^{n}}$. Applying Lemma 11.8 to $\varphi^{n}$, we see that

$$
\begin{aligned}
\varphi^{n} \circ f_{w}(K)=\varphi^{n}\left(K_{w}\right)=N^{n} A_{\xi}( & \left.K_{w}-c_{\xi}^{L, N^{n}}\right) \\
& =N^{n} A_{\tau} R R\left(K_{s_{n}}-c_{\tau}^{L, N^{n}}\right)=\varphi^{n}\left(K_{s_{n}}\right)=K
\end{aligned}
$$

Hence

$$
\varphi^{n} \circ f_{w}(K)=K
$$

for any $n \geq 1$ and $w \in T_{n}$. Since $K \subseteq K^{(m)}$, it follows that $\varphi^{n} \circ f_{w}\left(K^{(m)}\right) \supseteq K$. Note that $\varphi^{n} \circ f_{w}\left(K^{(m)}\right)=\cup_{\gamma \in B} C_{\gamma}^{L, N^{n}}$ for some subset $B \subseteq\left\{1, \ldots, N^{n}\right\}^{L}$ and $K^{(m)}$ is the minimal of such unions containing $K$. This shows $\varphi^{n} \circ f_{w}\left(K^{(m)}\right) \supseteq$ $K^{(m)}$. Since $\varphi^{n} \circ f_{w}$ preserves the Lebesgue measure of a set, we conclude that $\varphi^{n} \circ f_{w}\left(K^{(m)}\right)=K^{(m)}$. Since $K^{(m+n)}=\cup_{w \in T_{n}} f_{w}\left(K^{(m)}\right)$, we obtain $\varphi^{n}\left(K^{(n+m)}\right)=K^{(m)}$. Note that $K=\cup_{w \in T_{n}} f_{w}(K)$. Hence $\varphi^{n}(K)=K$. Moreover, if $\varphi(x)=N A_{s}\left(x-c_{s}\right)$ for $x \in C_{s}$, then by Lemma 11.13-(c), we have $K=N A_{s}\left(K_{s}-c_{s}\right)$. This implies $K_{s}=\frac{1}{N}\left(A_{s}\right)^{-1} K+c_{s}$. Hence letting $F_{s}(x)=\frac{1}{N}\left(A_{s}\right)^{-1} x+c_{s}$, we see $K=\cup_{s \in S} F_{s}(K)$.
(2) Suppose that $(s, t) \in E_{1}^{\ell}$. Then by Lemma 11.8 , there exist $A_{s} \in \mathbb{B}_{L}$ and $j \in\{1, \ldots, L\}$ such that

$$
\varphi(x)=N A_{s}\left(x-c_{s}\right)
$$

for any $x \in C_{s}$ and

$$
\varphi(x)=N A_{s} R_{j}\left(x-c_{t}\right)
$$

for any $x \in C_{t}$. Since $\varphi \circ f_{s}(K)=K$ and $\varphi \circ f_{t}(K)=K$ by Lemma 11.13, it follows that

$$
K_{s}-c_{s}=\frac{1}{N}\left(A_{s}\right)^{-1} K \quad \text { and } \quad K_{t}-c_{t}=\frac{1}{N} R_{j}\left(A_{s}\right)^{-1} K
$$

Therefore,

$$
R\left(K_{s}-c_{s}\right)=R \frac{1}{N}\left(A_{s}\right)^{-1} K=K_{t}-c_{t}
$$

so that $K_{t} \cup K_{s}$ is invariant under the reflection in $\ell_{s, t}$. Thus Lemma 11.10 shows that $\mathcal{L}$ is locally symmetric.

By (2) of the above theorem, we immediately have the following sufficient condition for the local symmetry.

Corollary 11.15. Let $S \subseteq\{1, \ldots, N\}^{L}$. Assume that $B_{j, i} \cap\left(\cup_{s \in S} C_{s}\right) \neq \emptyset$ for any $j \in\{1, \ldots, L\}$ and $i \in\{1,-1\}$. Let $\varphi$ be an $N$-folding map. Define

$$
f_{s}=\left(\left.\varphi\right|_{C_{s}}\right)^{-1}
$$

for any $s \in S$. Let $K$ be the unique non-empty compact set satisfying

$$
K=\bigcup_{s \in S} f_{s}(K)
$$

Then, $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ is non-degenerate and locally symmetric.
Proof. Since $B_{i, i} \cap\left(\cup_{s \in S} C_{s}\right) \neq \emptyset$ for any $j \in\{1, \ldots, L\}$ and $i \in\{1,-1\}$, Lemma 11.9 shows that $\mathcal{L}$ is non-degenerate and hence $K \cap \operatorname{int}\left(C_{*}\right) \neq \emptyset$. Moreover it is immediate to see that $\varphi(K)=K$. Now Theorem 11.14 (2) suffices.

Note that by Theorem 11.14 (1), any subsystem of cubic tiling that is locally symmetric and strongly continuous is given by an inverse of a folding map described in Corollary 11.15 .

Now we are ready to give a proof of Theorem 11.5 .
Proof of Theorem 11.5. By Theorem 11.14, we may assume that $\mathcal{L}$ is given by an inverse of a folding map described in Corollary 11.15 without loss of generality. Note that

$$
\begin{equation*}
\left(\left.\varphi^{m}\right|_{f_{w}\left(C_{*}\right)}\right)^{-1}=f_{w} \tag{11.5}
\end{equation*}
$$

for any $m \geq 1$ and $w \in T_{m}$. For any $m \geq 1$ and $e=(w, v) \in E_{m}^{\ell}$, by 11.5,

$$
\left.\varphi^{m}\right|_{f_{w}\left(C_{*}\right) \cap f_{v}\left(C_{*}\right)}=\left.\left(f_{w}\right)^{-1}\right|_{f_{w}\left(C_{*}\right) \cap f_{v}\left(C_{*}\right)}=\left.\left(f_{v}\right)^{-1}\right|_{f_{w}\left(C_{*}\right) \cap f_{v}\left(C_{*}\right)}
$$

Hence $X(e)=X\left(e^{r}\right)$ and $\varphi_{e}=I$, where $I$ is the identity map. Now let

$$
\mathcal{I}=\left\{\left(X(e), X\left(e^{r}\right), \varphi_{e}\right) \mid e \in \cup_{m \geq 1} E_{m}^{\ell}\right\}
$$

and set $\mathcal{G}_{0}=\{I\}$ and $\mathcal{G}_{1}=\mathcal{G}_{(K, T)} \cap \mathbb{B}_{L}$. We are going to make use of Theorem 10.2 . The condition (a) of Theorem 10.2 follows because $\mathcal{L}$ is strongly connected. Since $\varphi_{e}=I$ for any $e \in \cup_{m \geq 1} E_{m}^{\ell}$, the condition (b) of Theorem 10.2 is obvious.

Now it only remains to show the condition (c) of Theorem 10.2. Let $w \in T_{n}$. Suppose that $f_{w}\left(C_{*}\right)=\prod_{i=1}^{L}\left[\alpha_{i}, \alpha_{i}+2 / N^{n}\right]$. Then every path $\mathbf{p} \in \mathcal{C}_{1, m}^{(1)}(w)$ contains a path between hyperplanes

$$
\left\{\left(x_{1}, \ldots, x_{L}\right) \mid x_{j}=\alpha_{j}\right\} \quad \text { and } \quad\left\{\left(x_{1}, \ldots, x_{L}\right) \mid x_{j}=\alpha_{j}-2 / N^{n}\right\}
$$

or

$$
\left\{\left(x_{1}, \ldots, x_{L}\right) \mid x_{j}=\alpha_{j}+2 / N^{n}\right\} \quad \text { and } \quad\left\{\left(x_{1}, \ldots, x_{L}\right) \mid x_{j}=\alpha_{j}+4 / N^{n}\right\}
$$

for some $j \in\{1, \ldots, L\}$. This implies that there exists $j_{*} \in\{1, \ldots, L\}$ such that $\varphi^{n}(K(\mathbf{p})) \cap B_{j_{*}, i} \neq \emptyset$ for any $i \in\{1,-1\}$. Note that $\varphi^{m}(K(\mathbf{p}))=K\left(\psi_{n}(\mathbf{p})\right)$. Hence there exists a path $\mathbf{p}_{j_{*}} \subseteq \psi_{n}(\mathbf{p})$ between $B_{j_{*},-1}$ and $B_{j_{*}, 1}$. By the condition (SDR), for any $j_{1} \neq j_{*}$, there exists $i_{*} \in\{1,-1\}$ such that $R_{j_{*}, j_{1}}^{i_{*}} \in$ $\mathcal{G}_{(K, T)}$. Set $\mathbf{p}_{j_{1}}=\left(R_{j_{*}, j_{1}}^{i_{*}}\right)^{*}\left(\mathbf{p}_{j_{*}}\right)$. Then $K\left(\mathbf{p}_{j_{1}}\right) \cap B_{j_{1}, i} \neq \emptyset$ for any $i \in\{1,-1\}$. Moreover $K\left(\mathbf{p}_{j_{*}}\right)$ and $K\left(\mathbf{p}_{j_{1}}\right)$ intersects at $H_{j_{*}, j_{1}}^{i_{*}}$. Thus set $\mathbf{p}_{*}=\cup_{k=1}^{L} \mathbf{p}_{k}$. Then $\mathbf{p}_{*}$ is connected and $K\left(\mathbf{p}_{*}\right) \cap B_{k, i} \cap K \neq \emptyset$ for any $k \in\{1, \ldots, L\}$ and $i \in\{1,-1\}$. Moreover, $\mathbf{p}_{*} \subseteq \cup_{g \in \mathcal{G}_{(K, T)} \cap \mathbb{B}_{L} g^{*}\left(\psi_{n}(\mathbf{p})\right) \text {. Thus we have verified the condition (c) }}$ of Theorem 10.2 .

Proof of Theorem 11.6 . The arguments are the same as in the proof of Theorem 11.5 except the deduction of the condition (c) of Theorem 10.2 .

In the case of (RS), to construct $\mathbf{p}_{j_{1}}$ from $\mathbf{p}_{j_{*}}$, we use $\Theta_{\pi / 2}$ in place of $R_{j_{*}, j_{1}}^{i_{*}}$. Then the advantage of being planar yields $K\left(\mathbf{p}_{j_{*}}\right) \cap K\left(\mathbf{p}_{j}\right) \neq \emptyset$. The rest is the same as in the proof of Theorem 10.2 .

Next assume (NS). Let $w \in T_{n}$ and let $\mathbf{p}=(w(1), \ldots, w(k)) \in \mathcal{C}_{M, m}^{(1)}(w)$ with $M=4 N-3$. Note that

$$
\#\left(\left\{\pi^{m}(w(1)), \ldots, \pi^{m}(w(k))\right\}\right) \geq M
$$

We are going to show that

$$
\begin{equation*}
K\left(\psi_{n}(\mathbf{p})\right) \cap B_{j, i} \neq \emptyset \tag{11.6}
\end{equation*}
$$

for any $j \in\{1,2\}$ and $i \in\{1,-1\}$. Suppose $K\left(\psi_{n}(\mathbf{p})\right) \cap B_{1,1}=\emptyset$. Since $\varphi^{-n}\left(B_{1,1}\right)$ forms vertical lines at intervals of $\frac{2}{N^{n}}$, we see that $K(\mathbf{p})$ is contained in the interior of a vertical strip $\cup_{j=1, \ldots, N^{n}} C_{\left(i_{*}, j\right)}^{2, N^{n}} \cup C_{\left(i_{*}+1, j\right)}^{2, N^{n}}$, which is denoted by $Z_{i_{*}}$, for some $i_{*}$. Let $C_{1}, \ldots, C_{l}$ be the collection of connected components of

$$
\left(\bigcup_{w \in T_{n}} f_{w}(Q)\right) \cap Z_{i_{*}}
$$

and set

$$
D_{i}=\left\{v \mid v \in T_{n}, f_{v}\left(C_{*}\right) \subseteq C_{i}\right\}
$$

for $i=1, \ldots, l$. Then by (NS), we see that

$$
\#\left(D_{i}\right) \leq 2(2 N-2)
$$

Note that $\cup_{i=1}^{k} f_{\pi^{m}(w(i))}\left(C_{*}\right) \subset C_{i_{*}}$ for some $i_{*}$. Hence

$$
4 N-4 \geq \#\left(D_{i_{*}}\right) \geq \#\left(\left\{\pi^{m}(w(i)) \mid i=1, \ldots, k\right\}\right) \geq M=4 N-3
$$

This contradiction shows 11.6). Thus setting $\mathcal{U}_{p}=\psi_{n}(\mathbf{p})$, we have the condition (c) of Theorem 10.2

To conclude this section, we present a useful criterion to determine whether $g \in \mathbb{B}_{L}$ is a symmetry of $(K, T)$ or not.

Lemma 11.16. Let $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ be a subsystem of cubic tiling. Assume that $\mathcal{L}$ is non-degenerate, locally symmetric and strongly connected. Let $\varphi$ be the folding map satisfying the condition of Theorem 11.14(1). Then for $g \in \mathbb{B}_{L}$, if there exists a map $g_{*}: S \rightarrow S$ such that, for any $s \in S, g\left(C_{s}\right)=C_{g_{*}(s)}$ and $A_{g_{*}(s)} g\left(A_{s}\right)^{-1}=g^{k}$ for some $k \geq 0$, then $g \in \mathcal{G}_{(K, T)}$.

Recall that $A_{s} \in \mathbb{B}_{2}$ is given in Definition 11.3 (2).
Proof. We are going to show that $g\left(K^{(n)}\right)=K^{(n)}$ for any $n \geq 1$ by induction. For $n=1$, Since $g\left(C_{s}\right)=C_{g_{*}(s)}$, it follows $g\left(K^{(1)}\right)=K^{(1)}$. Next assume that $g\left(K^{(n)}\right)=K^{(n)}$. Then by Theorem 11.14 $\varphi \circ f_{s}\left(K^{(n)}\right)=K^{(n)}$, so that $A_{s} \Phi_{s}\left(K^{(n)}\right)=K^{(n)}$. Hence

$$
f_{s}\left(K^{(n)}\right)=\frac{1}{N}\left(A_{s}\right)^{-1}\left(K^{(n)}\right)+c_{s}
$$

Set $t=g_{*}(s)$. Then

$$
\begin{aligned}
g\left(f_{s}\left(K^{(n)}\right)\right)=\frac{1}{N} g\left(A_{s}\right)^{-1}\left(K^{(n)}\right)+c_{t} & =\frac{1}{N}\left(A_{t}\right)^{-1} A_{t} g\left(A_{s}\right)^{-1}\left(K^{(n)}\right)+c_{t} \\
& =\frac{1}{N}\left(A_{t}\right)^{-1} g^{k}\left(K^{(n)}\right)+c_{t}=f_{t}\left(K^{(n)}\right)
\end{aligned}
$$

Since $K^{(n+1)}=\cup_{s \in S} f_{s}\left(K^{(n)}\right)$, this yields $g\left(K^{(n+1)}\right)=K^{(n+1)}$. Thus using induction, we see that $g\left(K^{(n)}\right)=K^{(n)}$ for any $n \geq 1$. Since $\cap_{n \geq 1} K^{(n)}=K$, we obtain $g(K)=K$. Now, since $g\left(K^{(n)}\right)=K^{(n)}$, it follows that, for any $w \in T_{n}$, there exists $v \in T_{n}$ such that $g\left(f_{w}\left(C_{*}\right)\right)=f_{v}\left(C_{*}\right)$. Set $v=g_{*}(w)$. Then $g_{*}: T_{n} \rightarrow T_{n}$. Since $g\left(f_{w}\left(C_{*}\right)\right)=f_{g_{*}(v)}\left(C_{*}\right)$ and $g\left(K_{w}\right) \subseteq K$, we see that

$$
g\left(K_{w}\right) \subseteq g\left(f_{w}\left(C_{*}\right)\right) \cap K=f_{g_{*}(w)}\left(C_{*}\right) \cap K=K_{g_{*}(w)}
$$

Using $g^{-1}$ in place of $g$ in the arguments above, we obtain $g^{-1}\left(K_{g_{*}(w)}\right) \subseteq K_{w}$ as well. Thus we have shown $g\left(K_{w}\right)=K_{g_{*}(w)}$, so that $g \in \mathcal{G}_{(K, T)}$.

## 12 Examples: subsystems of (hyper)cubic tiling

In this section, we present examples of subsystems of cubic tiling having conductive homogeneity.

We begin with planar examples where $\operatorname{dim}_{A R}\left(K, d_{*}\right) \leq \operatorname{dim}_{H}\left(K, d_{*}\right)<2$, so that they are 2-conductively homogeneous and have self-similar local regular Dirichlet forms constructed in Theorem 9.3 .

Example 12.1 (Chipped Sierpinski carpet). Let $L=2$ and let $N=3$. Let $S$ be the set of squares in the right figure of Figure 9 where one of $R_{1}, R_{2}$ or $I$ is written. The corresponding $f_{s}$ is given by

$$
f_{s}(x)=\frac{1}{N} \Phi_{s} x+c_{s}^{3}
$$

where $\Phi_{s} \in \mathbb{B}_{2}$ is indicated in Figure 9 . Note that if the upper-left square belonged to $S$ as well, then $K$ would be the Sierpinski carpet. Lemma 11.9 and Corollary 11.15 show that $\mathcal{L}$ is non-degenerate and locally symmetric respectively. Then using Lemma 11.11 we see that $\mathcal{L}$ is strongly connected. Finally Lemma 11.16 shows that $R_{1,2}^{-1} \in \mathcal{G}_{(K, T)}$, so that (SDR) is satisfied. Thus we have confirmed all the assumptions in Theorem 11.5 Note that $K \cap \partial C_{*}$ has two different ingredients, the line segment, and the Cantor set. The lack of a rotational symmetry enables such a phenomenon. Another unique feature is the "countably ramified" property, that is, after removing a certain countable set, every remaining point becomes a connected component. In this example, since there are enough number of straight lines inside $K,\left(K, d_{*}\right)$ has the chain condition and hence the heat kernel associated with $\left(\mathcal{E}, \mathcal{W}^{2}\right)$ satisfies 8.10) and 8.12).

Example 12.2. Let $L=2$ and let $N=4$. As in Example 12.1, $S$ and $\left\{\Phi_{s}\right\}_{s \in S}$ are indicated in the right figure of Figure 10. It is easy to see that the corresponding self-similar structure is non-degenerate, locally symmetric, and strongly connected in the same way as Example 12.1. Moreover, Lemma 11.16 shows that $R_{1,2}^{1} \in \mathcal{G}_{(K, T)}$, so that (SDR) is satisfied. Thus we have confirmed all the assumptions of Theorem 11.5 . Unlike the chipped Sierpinski carpet, this example is not "countably ramified". In this example, like the chipped Sierpinski carpet, $K$ contains enough straight lines. This implies that $\left(K, d_{*}\right)$ has the chain condition, so that the heat kernel associated with $\left(\mathcal{E}, \mathcal{W}^{2}\right)$ satisfies 8.10) and 8.12

Example 12.3 (Moulin/Pinwheel). Let $L=2$ and let $N=5$. As in the above examples, $S$ and $\left\{\Phi_{s}\right\}_{s \in S}$ are indicated in the right figure of Figure 11 . The assumptions of Theorem 11.6 are verified in exactly the same way as before including (RS), i.e. $\Theta_{\pi / 2} \in \mathcal{G}_{(K, T)}$. In this example, unlike previous ones, ( $K, d_{*}$ ) does not have the chain condition and hence we have 8.10 and 8.11).

The next two examples satisfy (NS).

Example 12.4. Let $L=2$ and let $N=6$. As in the previous examples, $S$ and $\left\{\Phi_{s}\right\}_{s \in S}$ are indicated in the right figure of Figure 12 . In the same manner as before, we verify local symmetry, non-degeneracy and strongly connectedness. The condition (NS) is immediate from the right figure of Figure 12, We have $\#(S)=23$, so that $\operatorname{dim}_{H}\left(K, d_{*}\right)=\log 23 / \log 6$. Obviously there is no $\mathbb{B}_{2^{-}}$ symmetry.

Example 12.5. Let $L=2$ and let $N=7$. As in the previous examples, $S$ and $\left\{\Phi_{s}\right\}_{s \in S}$ are indicated in the right figure of Figure 13 . In the same manner as before, we verify local symmetry, non-degeneracy and strongly connectedness. The condition (NS) is immediate from the right figure of Figure 13. In this example $\#(S)=30$, so that $\operatorname{dim}_{H}\left(K, d_{*}\right)=\log 30 / \log 7$. Note that

$$
\operatorname{dim}_{H}\left(K \cap R_{2,1}\right)=\frac{\log 5}{\log 7} \text { while } \operatorname{dim}_{H}\left(K \cap R_{2,-1}\right)=\frac{\log 4}{\log 7}
$$

In the following examples, we may choose an arbitrary $L \geq 2$.
Example 12.6. Let $S=\{1, \ldots, N\}^{L} \backslash\left\{s_{*}\right\}$, where $s_{*}=(1, \ldots, 1)$. Also let $\varphi=\varphi_{s_{*}, I}$, i.e. $\varphi$ is a folding map given by

$$
\varphi(x)=N A_{s}\left(x-c_{s}\right)
$$

for any $s=\left(s_{1}, \ldots, s_{L}\right) \in\{1, \ldots, N\}^{L}$ and $x \in Q_{s}$, where $A_{s}=\prod_{j=1}^{L}\left(R_{j}\right)^{\left|s_{i}-1\right|}$. Note that $\left(A_{s}\right)^{-1}=A_{s}$. Define

$$
f_{s}(x)=\frac{1}{N} A_{s} x+c_{s}
$$

and let $K$ be the unique non-empty compact set satisfying

$$
K=\bigcup_{s \in S} f_{s}(K)
$$

Then $\mathcal{L}=\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ is a self-similar structure. By Corollary 11.15, $\mathcal{L}$ is non-degenerate and locally symmetric. Moreover, Lemma 11.11 shows that $\mathcal{L}$ is strongly connected. Additionally, using Lemma 11.16, we see that $R_{j_{1}, j_{2}}^{1} \in$ $\mathcal{G}_{(K, T)}$ for any $j_{1}, j_{2} \in\{1, \ldots, L\}$ with $j_{1} \neq j_{2}$. In fact, $\mathcal{G}_{(K, T)}$ is generated by $\left\{R_{j_{1}, j_{2}}^{1} \mid j_{1}, j_{2} \in\{1, \ldots, L\}, j_{1} \neq j_{2}\right\}$ and it is isomorphic to the symmetric group of order $L$. Hence by Theorem 11.5, $K$ is $p$-conductively homogeneous for any $p>\operatorname{dim}_{A R}\left(K, d_{*}\right)$. Note that $\mathcal{G}_{(K, T)}$ is a proper subgroup of $\mathbb{B}_{L}$ in this case.

Example 12.7 (Hypercube). Let $S=\{1, \ldots, N\}^{L}$ and let $f_{s}(x)=\frac{1}{N} x+c_{s}$ for any $s \in S$ and $x \in[-1,1]^{L}$. Set $K=[-1,1]^{L}$. Then $\left(K, S,\left\{f_{s}\right\}_{s \in S}\right)$ is a self-similar structure. Obviously, $\mathcal{L}$ is non-degenerate, strongly connected and locally symmetric. Moreover, $\mathcal{G}_{(K, T)}=\mathbb{B}_{L}$. By Theorem $11.5 K$ is $p$ conductively homogeneous for any $p>L$. In fact, for any $p>L$, we see that $W^{1, p}(K)=\mathcal{W}^{p}$ and there exist $c>0$ such that

$$
\begin{equation*}
c \mathcal{E}_{p}(f) \leq \int_{K}|\nabla f|^{p} d x \leq c^{-1} \mathcal{E}_{p}(f) \tag{12.1}
\end{equation*}
$$

for any $f \in W^{1, p}(K)$, where $\mathcal{E}_{p}$ is the self-similar $p$-energy constructed in Section 9 . The rest of this example is devoted to showing these facts. Choose $A=\{w(1), w(2), w(3)\} \subseteq T_{n}$ such that $K_{w(1)}, K_{w(2)}$ and $K_{w(3)}$ are three consecutive cubes in $x_{1}$-direction, i.e. $K_{w(1)} \cap K_{w(2)}=f_{w(1)}\left(B_{1,1}\right)=f_{w(2)}\left(B_{1,-1}\right)$ and $K_{w(2)} \cap K_{w(3)}=f_{w(2)}\left(B_{1,1}\right)=f_{w(3)}\left(B_{1,-1}\right)$. Let $A_{1}=\{w(1)\}$ and let $A_{2}=\{w(3)\}$. Then, the function attaining the infimum in the definition of
$\mathcal{E}_{p, m}\left(A_{1}, A_{2}, A\right)$ depends only on the first variable $x_{1}$ and is a piecewise linear function in the direction of $x_{1}$. Consequently, we see that

$$
\mathcal{E}_{p, m}^{\ell}\left(A_{1}, A_{2}, A\right) \geq 2^{m(L-p)-1}
$$

On the other hand, the comparison of moduli shows

$$
\mathcal{M}_{p, m}^{(1)}\left(A_{1}, A_{2}, A\right) \leq \mathcal{M}_{1, p, m}^{(1)}(w)
$$

for any $w \in T$. Therefore, there exists $c_{2}>0$ such that

$$
c_{2} 2^{m(L-p)} \leq \mathcal{E}_{1, p, m}\left(w, T_{|w|}\right)
$$

for any $m \geq 1$ and $w \in T$.
Now, for $f: K \rightarrow \mathbb{R}$, we define $\tilde{f}_{m}: T_{m} \rightarrow T$ by $\tilde{f}_{m}(w)=f\left(f_{w}(0)\right)$. Then there exists $c>0$ such that

$$
\begin{equation*}
2^{m(p-L)} \mathcal{E}_{p, T_{m}}\left(\tilde{f}_{m}\right) \rightarrow c \int_{K}|\nabla f|^{p} d x \tag{12.2}
\end{equation*}
$$

as $m \rightarrow \infty$ for any $f \in C^{\infty}(K)$. This shows that there exists $c_{3}>0$ such that $\mathcal{E}_{1, p, m}\left(w, T_{|w|}\right) \leq c_{3} 2^{m(L-p)}$ for any $w \in T$. Thus the scaling exponent of $\sigma$ appearing in 8.1 is $2^{L-p}$. Combining this fact and arguments analogous to those in [41, Section 5.3], we have the following Korevaar-Shoen type expression of $\mathcal{W}^{p}$ :

$$
\mathcal{W}^{p}=\left\{f \mid f \in L^{p}(K, d x), \limsup _{r \downarrow 0} \int_{K} \frac{1}{r^{L}} \int_{B_{d_{*}}(x, r)} \frac{|f(x)-f(y)|^{p}}{r^{p}} d y d x<\infty\right\} .
$$

This expressing enable us to identify $\mathcal{W}^{p}$ with $W^{1, p}(K)$. By $(12.2)$, we see that (12.1) holds for any $f \in C^{\infty}(K)$. Since $C^{\infty}(K)$ is dense in $W^{1, p}(K)$, 12.1) holds for any $f \in \mathcal{W}^{p}$.

## 13 Rationally ramified Sierpinski crosses

In this section, we present another class of conductively homogeneous spaces called rationally ramified Sierpinski crosses. This example is a planar squarebased self-similar set as those in the last section but the sizes of the squares constituting it are not one but two. See Figure 14. Consequently, although it has full $\mathbb{B}_{2}$-symmetry, we should make a little more complicated discussion than that of the previous section to show the conductive homogeneity.

The family of Sierpinski crosses was introduced in [31, Example 1.7.5].
Definition 13.1. Let $r_{1}, r_{2} \in(0,1)$ satisfying $2 r_{1}+r_{2}=1$ and $r_{1} \geq r_{2}$. Let $p_{1}=(-1,-1), p_{2}=(0,-1), p_{3}=(1,-1), p_{4}=(1,0), p_{5}=(1,1), p_{6}=(0,1)$, $p_{7}=(-1,1)$ and $p_{8}=(-1,0)$. Set $S=\{1, \ldots, 8\}$. For $s \in S$, define $F_{s}: C_{*} \rightarrow$ $C_{*}$ as

$$
F_{s}(x)= \begin{cases}r_{1}\left(x-p_{s}\right)+p_{s} & \text { if } s \text { is odd } \\ r_{2}\left(x-p_{s}\right)+p_{s} & \text { if } s \text { is even }\end{cases}
$$

The self-similar set $K$ with respect to the family of contractions $\left\{F_{s}\right\}_{s \in S}$ is called the $\left(r_{1}\right)$-Sierpinski cross. Define $\ell_{L}=\{-1\} \times[-1,1], \ell_{R}=\{1\} \times[-1,1]$, $\ell_{B}=[-1,1] \times\{-1\}$, and $\ell_{T}=[-1,1] \times\{1\}$, where the symbols, $\mathrm{L}, \mathrm{R}, \mathrm{B}$, and T correspond to left, right, bottom, and top respectively.

In this section, we will show that if an $\left(r_{1}\right)$-Sierpinski cross $K$ is rationally ramified, then it is $p$-conductively homogeneous for any $p>\operatorname{dim}_{A R}\left(K, d_{*}\right)$. Roughly speaking an $\left(r_{1}\right)$-Sierpinski cross is rationally ramified if $\cup_{v \in \Gamma_{1}(w)} K_{v}$, which represents the local geometry around $w \in T$, has finite types of variety up to the isometries when $w \in T$ varies. See 31 for the exact definition. In fact, in [31, Proposition 1.7.6], it is shown that an $\left(r_{1}\right)$-Sierpinski cross is rationally ramified if and only if $1-r_{1}=\left(r_{1}\right)^{m}$ for some $m \geq 2$. For simplicity of arguments, we confine ourselves to the case $m=2$ hereafter in this section. The generalization to other values of $m$ is a little complicated but the essential idea is the same.

In the case $m=2$, the value of $r_{1}$ equals $\sqrt{2}-1$. Set $\rho_{*}=\sqrt{2}-1$. Our main object of study is now the $\rho_{*}$-Sierpinski cross. We take advantage of the framework of Section 9 with $r=\rho_{*}$ and

$$
j_{s}= \begin{cases}1 & \text { if } s \text { is odd } \\ 2 & \text { if } s \text { is even }\end{cases}
$$

to define $(T, \mathcal{A}, \phi)$ and the associated partition of $K$. In this case, $g(w)$ is the contraction ratio of the $\operatorname{map} F_{w}=F_{w_{1}} \circ \ldots \circ F_{w_{m}}$ for $w=w_{1} \ldots w_{m} \in S^{m}$. Note that $g(w)=\left(\rho_{*}\right)^{n}$ or $\left(\rho_{*}\right)^{n+1}$ for any $(n, w) \in T_{n}$. For example $\Lambda_{\rho_{*}}^{g}=S$ and

$$
\Lambda_{\left(\rho_{*}\right)^{2}}^{g}=\{1 s, 3 s, 5 s, 7 s \mid s \in S, s: \text { even }\} \cup\{1 s, 3 s, 5 s, 7 s \mid s \in S, s: \text { odd }\}
$$

$\cup\{2,4,6,8\}$.

Note that $g(1 s)=\left(\rho_{*}\right)^{3}$ if $s$ is even and $g(1 s)=\left(\rho_{*}\right)^{2}$ if $s$ is odd. Moreover, $\Lambda_{\rho_{*}}^{g} \cap \Lambda_{\left(\rho_{*}\right)^{2}}^{g} \neq \emptyset$ in this case. Let $d_{*}$ be the restriction of the Euclidean metric to $K$. Let $h_{\rho_{*}}(n, w)=\left(\rho_{*}\right)^{n}$ for $(n, w) \in T_{w}$. It is straightforward to see that $d_{*}$ is 1 -adapted to the weight function $h_{\rho_{*}}$, i.e. Assumption 2.15 -(2B) holds with $M_{*}=1$.

For simplicity, to denote an element in $T_{n}$, we use $w$ in place of $(n, w)$ hereafter as long as no confusion may occur.

The Hausdorff dimension of ( $K, d_{*}$ ) is given by the unique number $\alpha_{H}$ satisfying

$$
4\left(\rho_{*}\right)^{2 \alpha_{H}}+4\left(\rho_{*}\right)^{\alpha_{H}}=1 .
$$

Consequently, we see that

$$
\alpha_{H}=1+\frac{\log 2}{\log (1+\sqrt{2})} .
$$

Let $\mu$ be the self-similar measure with weight $\left(\mu_{i}\right)_{i \in S}$, where

$$
\mu_{i}= \begin{cases}\left(\rho_{*}\right)^{\alpha_{H}} & \text { if } i \text { is odd } \\ \left(\rho_{*}\right)^{2 \alpha_{H}} & \text { if } i \text { is even } .\end{cases}
$$

Then $\mu$ is the normalized $\alpha_{H}$-dimensional Hausdorff measure and is $\alpha_{H}$-Ahlfors regular with respect to $d_{*}$. After those observations, it is easy to see that Assumption 2.15 is satisfied with $M_{*}=M_{0}=1, N_{*}=8$. Moreover we see that $L_{*} \leq 8$.

The main result of this section is as follows.
Theorem 13.2. For any $p>0, n, m, k \geq 1, w \in T_{n}$ and $u, v \in T_{k}$,

$$
\mathcal{M}_{1, p, m}^{(1)}(w) \leq 8(24)^{p+1} \#\left(T_{k+1}\right)^{p} \mathcal{M}_{p, m}^{(1)}\left(u, v, T_{k}\right) .
$$

An immediate consequence of the above theorem is the conductive homogeneity of the Sierpinski cross.

Corollary 13.3. The $\rho_{*}$-Sierpinski cross $K$ is $p$-conductively homogeneous for any $p>\operatorname{dim}_{A R}\left(K, d_{*}\right)$. Moreover, there exists a self-similar $p$-energy $\mathcal{E}_{p}$ on $\mathcal{W}^{p}$. In particular, there exists a local regular Dirichlet form $\left(\mathcal{E}, \mathcal{W}^{2}\right)$ on $L^{2}(K, \mu)$ whose associated heat kernel satisfies (8.10) and 8.12).

Note that due to the two different values of $j_{s}$, the self-similarity of the $p$-energy $\mathcal{E}_{p}$ is given as

$$
\mathcal{E}_{p}(f)=\sigma \sum_{s: \text { odd }} \mathcal{E}_{p}\left(f \circ F_{s}\right)+\sigma^{2} \sum_{s: \text { even }} \mathcal{E}_{p}\left(f \circ F_{s}\right)
$$

for any $f \in \mathcal{W}^{p}$.

Proof of Corollary 13.3. By 4.3), it follows that

$$
\mathcal{E}_{1, p, m}\left(w, T_{n}\right) \leq c_{p} \#\left(T_{k+1}\right)^{p} \mathcal{E}_{p, m}\left(u, v, T_{k}\right)
$$

for any $n, m, k \geq 1, w \in T_{n}$ and $u, v \in T_{k}$. Moreover since $p>\operatorname{dim}_{A R}\left(K, d_{*}\right)$, there exist $c>0$ and $\alpha \in(0,1)$ such that

$$
\mathcal{E}_{1, p, m} \leq c \alpha^{m}
$$

for any $m \geq 1$. Thus we have obtained (8.3) and (8.4), so that $K$ is $p$ conductively homogeneous by Theorem 8.4. In particular, since $\alpha_{H}<2, K$ is 2 -conductively homogeneous and we have $\left(\mathcal{E}, \mathcal{W}^{2}\right)$. Since $\left(K, d_{*}\right)$ has the chain condition, we have 8.10 and 8.12 by Theorem 8.6

To show Theorem 13.2 , we need to prepare several notions.
Definition 13.4. (1) Set

$$
U=\{(2,13),(2,31),(4,35),(4,53),(6,57),(6,75),(8,17),(8,71)\}
$$

For $(i, j k) \in U$, define $R_{i, j k}: K_{i} \rightarrow K_{j k}$ as the reflection in the line segment $K_{i} \cap K_{j k}$. Moreover, define $R_{i, j k}^{*}(w)$ for $w \in T(i) \cup T(j k)$ as the unique $v \in$ $T(i) \cup T(j k)$ satisfying $R_{i, j k}\left(K_{w}\right)=K_{v} . R_{i, j k}^{*}$ is a map from $T(i) \cup T(j k)$ to itself.
(2) For $g \in \mathbb{B}_{2}$, define $g^{*}: T \rightarrow T$ by

$$
g^{*}(w)=v
$$

where $v$ is the the unique $v \in T$ satisfying $g\left(K_{w}\right)=K_{v}$. Note that $\left.g^{*}\right|_{T_{n}}: T_{n} \rightarrow$ $T_{n}$.
(3) For $w \in T$, if $w \notin T(2) \cup T(4) \cup T(6) \cup T(8)$, then define

$$
\mathcal{H}_{w}=\left\{g^{*}(v) \mid g \in \mathbb{B}_{2}\right\}
$$

Otherwise if $w \in T(i)$ for $i=2,4,6,8$, then define

$$
\mathcal{H}_{w}=\left\{g^{*}(v) \mid g \in \mathbb{B}_{2}\right\} \cup\left\{g_{*}\left(R_{i, j k}^{*}(v)\right) \mid g \in \mathbb{B}_{2},(i, j k) \in U\right\} .
$$

Note that $\#\left(\mathcal{H}_{w}\right) \leq 24$ for any $w \in T_{n}$.
By the construction of $T_{n}$, we see that $g(w)=\left(\rho_{*}\right)^{n}$ or $g(w)=\left(\rho_{*}\right)^{n+1}$ for any $w \in T_{n}^{n}$. In fact, we immediately obtain the following lemma.

Lemma 13.5. Set

T_{n}^{n}=\left\{w \mid w \in T_{n}, g(w)=\left(\rho_{*}\right)^{n}\right\} \quad \text { and } \quad T_{n}^{n+1}=\left\{w \mid w \in T_{n}, g(w)=\left(\rho_{*}\right)^{n+1}\right\}
$$

(1) For any $w \in T_{n}^{n}$, wv $\in T_{n+m}$ if and only if $v \in T_{m}$.
(2) For any $w \in T_{n}^{n+1}, w v \in T_{n+m}$ if and only if $v \in T_{m-1}$.
(3) $w \in T_{n+1}^{n+1}$ if and only if $w \in T_{n}^{n+1}$ or $w=\tau j$ for some $\tau \in T_{n}^{n}$ and $j \in\{1,3,5,7\}$.
(4) $w \in T_{n+1}^{n+2}$ if and only if $w=\tau j$ for some $\tau \in T_{n}^{n}$ and $j \in\{2,4,6,8\}$.

Definition 13.6. (1) Define $\psi_{n, m}^{*}: S^{m}\left(T_{n}^{n}\right) \rightarrow T_{m}$ by

$$
\psi_{n, m}^{*}(w v)=v
$$

for $w \in T_{n}^{n}$ and $v \in T_{m}$.
(2) For $w \in T$, define $\mathcal{H}_{w}^{0} \subseteq T$ by

$$
\mathcal{H}_{w}^{0}= \begin{cases}\left\{w, R_{i, j k}^{*}(w)\right\} & \text { if } w \in T(j k) \text { for some }(i, j k) \in U \\ \{w\} & \text { otherwise }\end{cases}
$$

For $w \in T_{n+1}^{n+1}$ and $u \in T$, define

$$
\mathcal{H}_{w u}^{n}= \begin{cases}\left\{\tau v \mid v \in \mathcal{H}_{j u}^{0}\right\} & \text { if } w=\tau j \text { for some } \tau \in T_{n}^{n} \text { and } j \in\{1,3,5,7\} \\ \{w u\} & \text { if } w \in T_{n}^{n+1}\end{cases}
$$

(3) Define

$$
\begin{equation*}
K_{\%}=\bigcup_{s \in S, K_{s} \cap \ell_{\%} \neq \emptyset} K_{s} \tag{13.1}
\end{equation*}
$$

for $\% \in\{T, B, R, L\}$. For example, $K_{B}=K_{1} \cup K_{2} \cup K_{3}$.
Note that if $w \in T_{n}$, then $\mathcal{H}_{w}^{0} \in T_{n}$ and that if $w \in T_{n+1}^{n+1}$ and $u \in T_{m-1}$, then $\mathcal{H}_{w u}^{n} \subseteq T_{n+m}$.
Lemma 13.7. Assume that there exists a path $\mathbf{p}=(w(1), \ldots, w(l))$ of $T_{m-1}$ contained in $K_{L}$ such that $K_{w(1)} \cap \ell_{B} \neq \emptyset, K_{w(l)} \cap \ell_{T} \neq \emptyset$, and $\mathbf{p}$ is $R_{2}^{*}$-invariant. Set

$$
\mathcal{H}_{u}^{*}=\bigcup_{w \in T_{k+1}^{k+1}} \bigcup_{v \in \mathcal{H}_{u}} \mathcal{H}_{w v}^{k+1}
$$

for $u \in T_{m-1}$. Then for any $u_{1}, u_{2} \in T_{k}$, there exists $\mathbf{p}_{0} \in \mathcal{C}_{m}^{(1)}\left(\left\{u_{1}\right\},\left\{u_{2}\right\}, T_{k}\right)$ such that

$$
\begin{equation*}
\mathbf{p}_{0} \subseteq \bigcup_{i=1}^{l} \mathcal{H}_{w(i)}^{*} \tag{13.2}
\end{equation*}
$$

Remark. Strictly, $\mathbf{p}_{0}$ is not a subset but a sequence of points. However, in (13.2), we use $\mathbf{p}_{0}$ to denote a subset consisting of the points in the sequence. We use such abuse of notations if no confusion may occur.

Proof. Set

$$
Y=\mathbf{p} \cup \Theta_{\pi / 2}^{*}(\mathbf{p}) \cup \Theta_{\pi}^{*}(\mathbf{p}) \cup \Theta_{3 \pi / 2}^{*}(\mathbf{p})
$$

Then $Y=g^{*}(Y)$ for any $g \in \mathbb{B}_{2}$. Let

$$
\mathcal{H}^{*}(Y)=\bigcup_{w \in T_{k+1}^{k+1}} \bigcup_{v \in Y} \mathcal{H}_{w v}^{k+1}
$$

See Figure 15 for an illustration of $\mathbf{p}, Y$ and a part of $\mathcal{H}^{*}(Y)$. It follows that $K\left(\mathcal{H}^{*}(Y)\right)$ is a connected set intersecting $K_{u}$ for any $u \in T_{k}$. Therefore, we can choose a path $\mathbf{p}_{0}$ connecting $K_{u_{1}}$ and $K_{u_{2}}$ from $\mathcal{H}^{*}(Y)$. since $\left.\mathcal{H}^{( } Y\right) \subseteq$ $\cup_{i=1}^{l} \mathcal{H}_{w(i)}^{*}$, we have the desired statement.


$$
\tau \in T_{k}^{k}, v \in T_{k}^{k+1} \cap T_{k+1}^{k+1}, \tau 1, \tau 3, \tau 5, \tau 7 \in T_{k+1}^{k+1}
$$

Proof of Theorem 13.2. Let $w \in T_{n}$ and let $u_{1}, u_{2} \in T_{k}$. For any $\mathbf{p} \in \mathcal{C}_{1, m}^{(1)}(w)$, set

$$
\mathcal{H}_{m-1}(\mathbf{p})=\bigcup_{u \in \psi_{n+1, m-1}^{*}\left(\mathbf{p} \cap S^{m-1}\left(T_{n+1}^{n+1}\right)\right)} \mathcal{H}_{u} .
$$

Then $\mathcal{H}_{m-1}(\mathbf{p}) \subseteq T_{m-1}$ and $g^{*}\left(\mathcal{H}_{m-1}(\mathbf{p})\right)=\mathcal{H}_{m-1}(\mathbf{p})$ for any $g \in \mathbb{B}_{2}$.
Claim 1 There exists a path $\mathbf{p}^{*}$ contained in $\mathcal{H}_{m-1}(\mathbf{p})$ such that one of the following four statements is true:
(a) $K\left(\mathbf{p}^{*}\right) \cap \ell_{B} \neq \emptyset$ and $K\left(\mathbf{p}^{*}\right) \cap K_{T} \neq \emptyset$,
(b) $K\left(\mathbf{p}^{*}\right) \cap \ell_{T} \neq \emptyset$ and $K\left(\mathbf{p}^{*}\right) \cap K_{B} \neq \emptyset$,
(c) $K\left(\mathbf{p}^{*}\right) \cap \ell_{L} \neq \emptyset$ and $K\left(\mathbf{p}^{*}\right) \cap K_{R} \neq \emptyset$,
(d) $K\left(\mathbf{p}^{*}\right) \cap \ell_{R} \neq \emptyset$ and $K\left(\mathbf{p}^{*}\right) \cap K_{L} \neq \emptyset$.

Proof of Claim 1: Let $F_{w}\left(C_{*}\right)=[a, a+h] \times[b, b+h]$, where $h=\left(\rho_{*}\right)^{n}$ if $w \in T_{n}^{n}$ and $h=\left(\rho_{*}\right)^{n+1}$ if $w \in T_{n}^{n+1}$. Define

$$
A_{w, \gamma}=[a-\gamma, a+h+\gamma] \times[b-\gamma, b+h+\gamma]
$$

and $\widetilde{A}_{w}=K \cap\left(A_{w,\left(\rho_{*}\right)^{n+1}} \backslash A_{w,\left(\rho_{*}\right)^{n+2}}\right)$. Two typical examples of $\widetilde{A}_{w}$ is illustrated in Figure 16. Since $K_{w(1)} \cap K_{w} \neq \emptyset$ and $K_{w(l)} \cap A_{w,\left(\rho_{*}\right)^{n+1}}=\emptyset$, a part of $\mathbf{p}$ contained in $\widetilde{A}_{w}$ connects $\left\{\left(a-\left(\rho_{*}\right)^{n+1}, y\right) \mid y \in[-1,1]\right\}$ and $\left\{\left(a-\left(\rho_{*}\right)^{n+2}, y\right) \mid y \in[-1,1]\right\}$, $\left\{\left(a+h, y+\left(\rho_{*}\right)^{n+2}\right) \mid y \in[-1,1]\right\}$ and $\left\{\left(a+h+\left(\rho_{*}\right)^{n+1}, y\right) \mid y \in[-1,1]\right\}$, $\left\{\left(x, b-\left(\rho_{*}\right)^{n+1}\right) \mid x \in[-1,1]\right\}$ and $\left\{\left(x, b-\left(\rho_{*}\right)^{n+2}\right) \mid x \in[-1,1]\right\}$,
or
$\left\{\left(x, b+h+\left(\rho_{*}\right)^{n+2}\right) \mid x \in[-1,1]\right\}$ and $\left.\left\{x, b+h+\left(\rho_{*}\right)^{n+1}\right) \mid x \in[-1,1]\right\}$.
According to the four possibilities above, we have (a), (b), (c) or (d), where the exact correspondence depends on $w$.

Hereafter we assume the case (a) in Claim 1 in the course of discussion. Other cases may be treated exactly in the same manner. In the following claims, we

are going to modify the initial path $\mathbf{p}^{*}$ step by step. This process of modification is illustrated in Figure 17.
Claim $2 \mathbf{p}^{*} \cup R_{2}^{*}\left(\mathbf{p}^{*}\right)$ contains an $R_{2}$-symmetric path $\mathbf{p}_{1}=\left(v(0), \ldots, v\left(l_{1}\right)\right)$ between $\ell_{B}$ and $\ell_{T}$, i.e. $K_{v(0)} \cap \ell_{B} \neq \emptyset, R_{2}^{*}(v(i))=v\left(l_{1}-i\right)$ for $i=1, \ldots, l_{1}$.
Proof of Claim 2: Let $p_{*}=(w(1), \ldots, w(l))$. By (a), $K\left(\mathbf{p}^{*}\right)$ intersects with the line segment $[-1,1] \times\{0\}$. Set $i_{*}=\min \{i \mid w(i) \cap[-1,1] \times\{0\} \neq \emptyset\}$. Then connecting $\left(w(1), \ldots, w\left(i_{*}\right)\right)$ and its image by $R_{2}^{*}$, we obtain a desired path.
Claim $3 R_{1}^{*}\left(\mathbf{p}_{1}\right) \cup \mathbf{p}_{1}$ contains an $R_{2}$-symmetric path $\mathbf{p}_{2}$ such that $K\left(\mathbf{p}_{2}\right) \subseteq$ $[-1,0] \times[-1,1]$.
Proof of Claim 3: If $\mathbf{p}_{1}$ or $R_{1}^{*}\left(\mathbf{p}_{1}\right)$ is contained in the left half of $C_{*}$, then choose $\mathbf{p}_{1}$ or $R_{1}^{*}\left(\mathbf{p}_{1}\right)$ accordingly as our path. Otherwise, applying $R_{1}$ to $K\left(\mathbf{p}_{1}\right) \cap[0,1] \times$ $[-1,1]$, we obtain a desired path.
Claim 4 Set $\mathcal{H}_{\mathbf{p}^{*}}=\cup_{u \in \mathbf{p}^{*}} \mathcal{H}_{u}$. Then there exists an $R_{2}^{*}$-symmetric path $\mathbf{p}_{3} \subseteq$ $\mathcal{H}_{\mathbf{p}^{*}}$ contained in $K_{L}$ such that $K\left(\mathbf{p}_{3}\right) \cap \ell_{T} \neq \emptyset$ and $K\left(\mathbf{p}_{3}\right) \cap \ell_{B} \neq \emptyset$.
Proof of Claim 4: If $K\left(\mathbf{p}_{2}\right) \subseteq K_{L}$, then we set $\mathbf{p}_{2}=\mathbf{p}_{3}$. Otherwise, use $R_{2,13}^{*}$ (resp. $R_{6,75}^{*}$ ) to reflect the part $K\left(\mathbf{p}_{2}\right) \cap K_{2}$ (resp. $K\left(\mathbf{p}_{2}\right) \cap K_{6}$ ) into $K_{13}$ (resp. $K_{75}$ ). Then we obtain a desired path.
Now we have a path $p_{3}$ satisfying all the assumptions of Lemma 13.7. Applying Lemma 13.7 with $\mathbf{p}=\mathbf{p}_{3}$, we obtain a path $\mathbf{p}_{0} \in \mathcal{C}_{m}^{(1)}\left(\left\{u_{1}\right\},\left\{u_{2}\right\}, T_{k}\right)$. For $u \in S^{m}\left(\bar{\Gamma}_{1}(w)\right)$, define

Then it follows that

Since $\#\left(\mathcal{H}_{u}\right) \leq 24$ and $\#\left(\Gamma_{1}(w)\right) \leq 8$,

$$
\#\left(H_{w}\right) \leq 48 \#\left(T_{k+1}\right) \quad \text { and } \quad \#\left(\left\{v \mid u \in H_{v}\right\}\right) \leq 24 \cdot 8
$$

So, Lemma C. 4 suffices.

## 14 Nested fractals

In this section, we show conductive homogeneity of a class of self-similar sets, called strongly symmetric self-similar sets, that are highly symmetric and finitely ramified. This class is a natural extension of nested fractals introduced by Lindstrøm 37, where Brownian motions were constructed on them. In [29, Section 3.8], Lindsrøm's results were extended to strongly symmetric self-similar sets. Typical examples of strongly symmetric self-similar sets are the Sierpinski gasket, the pentakun ("Kun" means "Mr." in Japanese), and the snowflake, whose definitions are given below.

Let $\rho \in(0,1)$ and let $S$ be a finite subset of $\mathbb{R}^{L}$ for some $L \in \mathbb{N}$. For each $q \in S$, let $f_{q}: \mathbb{R}^{L} \rightarrow \mathbb{R}^{L}$ be a $\rho$-similitude whose fixed point is $q$, i.e. there exists $U_{q} \in O(L)$ such that

$$
f_{q}(x)=\rho U_{q}(x-q)+q
$$

for any $x \in \mathbb{R}^{L}$. Let $K$ be the self-similar set with respect to the family of contractions $\left\{f_{q}\right\}_{q \in S}$. Then the triple $\left(K, S,\left\{f_{q}\right\}_{q \in S}\right)$ is a self-similar structure as is explained in Section 9 .
Assumption 14.1. (1) If $p, q \in S$ and $p \neq q$, then $p \notin f_{q}(K)$.
(2) There exists $U \subseteq S$ such that

$$
\bigcup_{\substack{q_{1}, q_{2} \in S \\ q_{1} \neq q_{2}}} f_{q_{1}}^{-1}\left(f_{q_{1}}(K) \cap f_{q_{2}}(K)\right)=U
$$

(3) $K$ is connected.

For purpose of normalization, we assume

$$
\sum_{q \in U} q=0
$$

hereafter.
Proposition 14.2. Under Assumption 14.1. $\left(K, S,\left\{f_{q}\right\}_{q \in S}\right)$ is a p.c.f. selfsimilar structure with

$$
\begin{equation*}
V_{0}=U \tag{14.1}
\end{equation*}
$$

Moreover, define $\left\{V_{m}\right\}_{m \geq 1}$ inductively by

$$
V_{m+1}=\bigcup_{i \in S} f_{i}\left(V_{m}\right)
$$

Then

$$
\begin{equation*}
V_{m} \subseteq V_{m+1} \tag{14.2}
\end{equation*}
$$

for any $m \geq 0$.
The definitions of p.c.f. self-similar structures and $V_{0}$ along with the proof of 14.1 is given in Appendix E, (14.2) is due to [29, Lemma 1.3.11].
For the self-similar structure $\left(K, S,\left\{f_{q}\right\}_{q \in S}\right)$, we adopt the framework in Section 9 with $r=\rho$ and $j_{q}=1$ for any $q \in S$. In this case,

$$
T_{m}=S^{m}=\left\{w_{1} \ldots w_{m} \mid w_{i} \in S \text { for any } i=1, \ldots, m\right\}
$$

Then we see that

$$
V_{0}=\bigcup_{e \in E_{1}^{*}} X(e)
$$

Moreover, by [29, Proposition 1,3,5-(2)], it follows that

$$
\begin{equation*}
K_{w} \cap K_{v}=f_{w}\left(V_{0}\right) \cap f_{v}\left(V_{0}\right) \subseteq V_{m} \tag{14.3}
\end{equation*}
$$

for any $w, v \in T_{m}$ with $w \neq v$. This implies that

$$
\begin{equation*}
V_{0}=\bigcup_{(X, Y, \varphi) \in \mathcal{I} \mathcal{T}(K, T)} X \tag{14.4}
\end{equation*}
$$

Let $\alpha_{H}=-\log N / \log \rho$. Note that $N \rho^{\alpha_{H}}=1$. Let $\mu$ be the self-similar measure with weight $\left(\rho^{\alpha_{H}}, \ldots, \rho^{\alpha_{H}}\right)$. Basic properties of $\mu$ is given in Appendix E. Also, let $d_{*}$ be the restriction of the Euclidean metric to $K$.

The following assumption is an equivalent condition of Assumption 2.15 (2B) when $d$ is the (restriction of) Euclidean metric. Essentially the same assumptions have been around from time to time for almost 30 years. See 35 , Assumption 2.2] and [38, Assumption (P)]. The assumption is believed to be true for nested fractals but we have no proof so far. In [38, it was shown that this assumption is true if $U_{q}$ is the same for any $q \in S$. In Appendix E, we show this assumption is true if $U_{q}$ is the identity map for any $q \in V_{0}$.

Assumption 14.3. There exists $c>0$ such that $d\left(K_{w}, K_{v}\right) \geq c \rho^{|w|}$ for any $n \geq 1$, and $(w, v) \in E_{n}^{*}$, where $d(A, B)=\inf _{x \in A, y \in B}|x-y|$ for subsets $A, B \subseteq$ $\mathbb{R}^{L}$.

Proposition 14.4. Under Assumptions 14.1 and 14.3 , Assumption 2.15 is satisfied with $d=d_{*}, r=\rho$, and $M_{*}=M_{0}=1$.

The above proposition is proven in Appendix E.
Definition 14.5. (1) Let $m_{*}=\#\left\{|x-y| \mid x, y \in V_{0}, x \neq y\right\}$, where $|x|$ is the Euclidean length of $x \in \mathbb{R}^{L}$. Define

$$
l_{0}=\min \left\{|x-y| \mid x, y \in V_{0}, x \neq y\right\}
$$

Moreover, define $l_{i}$ for $i=0,1, \ldots m_{*}-1$ inductively by

$$
l_{i+1}=\min \left\{|x-y|\left|x, y \in V_{0}, x \neq y,|x-y|>l_{i}\right\}\right.
$$

(2) A sequence $\left(x_{i}\right)_{i=1, \ldots k} \subseteq V_{m}$ is called an $m$-walk if there exists $w(i) \in T_{m}$ such that $x_{i}, x_{i+1} \in f_{w(i)}\left(V_{0}\right)$ for any $i=1, \ldots, k-1$.
(3) A 0-walk $\left(x_{i}\right)_{i=1, \ldots, k}$ is called a strict 0 -walk (between $x_{1}$ and $x_{k}$ ) if $\mid x_{i}-$ $x_{i+1} \mid=l_{0}$ for any $i=1, \ldots, k-1$.
(4) Define

$$
\mathcal{G}=\left\{g \mid g \in O(L), g\left(V_{0}\right)=V_{0}\right.
$$

there exists $g *: T \rightarrow T$ such that $g\left(f_{w}\left(V_{0}\right)\right)=f_{g^{*}(w)}\left(V_{0}\right)$ for any $w \in T$. $\}$
(5) For any $x, y \in \mathbb{R}^{L}$ with $x \neq y$, define

$$
H_{x y}=\left\{z\left|z \in \mathbb{R}^{L},|x-z|=|y-z| \cdot\right\}\right.
$$

( $H_{x y}$ is the hyperplane bisecting the line segment $x y$.) Also let $g_{x y}: \mathbb{R}^{L} \rightarrow \mathbb{R}^{L}$ be reflection in $H_{x y}$.

Definition 14.6. $\left(K, S,\left\{f_{q}\right\}_{q \in S}\right)$ is said to be strongly symmetric if Assumption 14.1 is satisfied and there exists a finite subgroup $\mathcal{G}_{*}$ of $\mathcal{G}$ such that the following properties hold:
(1) For any $x, y \in V_{0}$ with $x \neq y$, there exists a strict 0 -walk between $x$ and $y$.
(2) If $x, y, z \in V_{0}$ and $|x-y|=|x-z|$, then there exists $g \in \mathcal{G}_{*}$ such that $g(x)=x$ and $g(y)=z$.
(3) For any $i=1, \ldots, m_{*}-2$, there exist $x, y$ and $z \in V_{0}$ such that $|x-y|=l_{i}$, $|x-z|=l_{i+1}$ and $g_{y z} \in \mathcal{G}_{*}$.
(4) $V_{0}$ is $\mathcal{G}_{*}$-transitive, i.e. for any $x, y \in V_{0}$, there exists $g \in \mathcal{G}_{*}$ such that $g(x)=y$.
Remark. By Definition 14.6 (4), $\left|q_{1}\right|=\left|q_{2}\right|$ for any $q_{1}, q_{2} \in V_{0}$.
Definition 14.7. A self-similar structure $\left(K, S,\left\{f_{q}\right\}_{q \in S}\right)$ is called a nested fractal if Assumption 14.1 holds and $g_{x y} \in \mathcal{G}$ for any $x, y \in V_{0}$ with $x \neq y$.

By [29, Proposition 3.8.7], we have the following proposition.
Proposition 14.8. A nested fractal is strongly symmetric.
We give three examples of strongly symmetric self-similar sets. Note that Assumption 14.3 is satisfied for all the three examples because of Lemma E.5 The first two are nested fractals.

Example 14.9. [Pentakun: Figure 18 Let $S=\left\{p_{1}, \ldots, p_{5}\right\}$ be a collection of vertices of a regular pentagon satisfying $\sum_{i=1}^{5} p_{i}=0$ and let $\rho=\frac{3-\sqrt{5}}{2}$. Then the associated self-similar set $K$, called pentakun, is strongly symmetric. (See 29, Example 3.8.11].) In this case $\mathcal{G}=\mathcal{G}_{*}=D_{5}$, which is the group of symmetries of a regular pentagon, and $V_{0}=\left\{p_{1}, \ldots, p_{5}\right\}$.

Example 14.10. [Snowflake: Figure 19 Let $\left\{p_{1}, \ldots, p_{6}\right\}$ be a collection of vertices of a regular hexagon satisfying $\sum_{i=1}^{6} p_{i}=0$ and let $S=\left\{p_{1}, \ldots, p_{7}, 0\right\}$. Furthermore let $\rho=\frac{1}{3}$. Then the associated self-similar set, called snowflake, is strongly symmetric. (See [29, Example 3.8.12].) In this case $\mathcal{G}=\mathcal{G}_{*}=D_{6}$, which is the group of symmetries of a regular hexagon and $V_{0}=\left\{p_{1}, \ldots, p_{6}\right\}$.

The last example is not a nested fractal.
Example 14.11. Let

$$
S=\{-1,0,1\}^{3} \cup\left\{-\frac{1}{2}, \frac{1}{2}\right\}^{3}, U=\{1,-1\}^{3}
$$

and $\rho=1 / 5$. Note that $U$ is the collection of vertices of the cube $[-1,1]^{3}$ and

$$
f_{q}\left([-1,1]^{3}\right)=\left[\frac{4 q_{1}-1}{5}, \frac{4 q_{1}+1}{5}\right] \times\left[\frac{4 q_{2}-1}{5}, \frac{4 q_{2}+1}{5}\right] \times\left[\frac{4 q_{3}-1}{5}, \frac{4 q_{3}+1}{5}\right] .
$$

for any $q=\left(q_{1}, q_{2}, q_{3}\right) \in S$. It is straight forward to see that the associated self-similar set is strongly symmetric with $V_{0}=U$ and $\mathcal{G}=\mathcal{G}_{*}=\mathbb{B}_{3}$. This self-similar set is not a nested fractal because $g_{x y} \notin \mathcal{G}$ if $x=(-1,-1,-1)$ and $y=(1,1,1)$.

Using Theorem 10.2, we have the following theorem.

Theorem 14.12. Suppose that $\left(K, S,\left\{f_{i}\right\}_{i \in S}\right)$ is strongly symmetric and that Assumption 14.3 holds. Then $\left(K, d_{*}\right)$ is $p$-conductively homogeneous for any $p>\operatorname{dim}_{A R}\left(K, d_{*}\right)$.

As for $\operatorname{dim}_{A R}\left(K, d_{*}\right)$, it was shown in [43] that $\operatorname{dim}_{A R}\left(K, d_{*}\right)=1$ if $\left(K, d_{*}\right)$ is the Sierpinski gasket. In general, we have the following fact.

Proposition 14.13. Suppose that $\left(K, S,\left\{f_{i}\right\}_{i \in S}\right)$ is strongly symmetric and that Assumption 14.3 holds. Then $\operatorname{dim}_{A R}\left(K, d_{*}\right)<2$.
Proof. For $m \geq 0$, define $\widetilde{E}_{m}=\left\{\left(f_{w}(x), f_{w}(y)\right) \mid w \in T_{m}, x, y \in V_{0}, x \neq y\right\}$. Then $\left\{\left(V_{m}, \widetilde{E}_{m}\right)\right\}_{m \geq 0}$ is a proper system of horizontal networks in the sense of [34, Definition 4.6.5]. Define

$$
\begin{array}{r}
\mathcal{L}_{s}\left(V_{0}\right)=\left\{\left(D_{x y}\right)_{x, y \in V_{0}} \mid \text { there exists }\left(D_{0}, \ldots, D_{m_{*}-1}\right) \in[0, \infty)^{m_{*}}\right. \text { such that } \\
\left.D_{0}=1, D_{x y}=D_{i} \text { if }|x-y|=l_{i}, \text { and } \sum_{y \in V_{0}} D_{x y}=0 \text { for any } x \in V_{0} .\right\}
\end{array}
$$

In particular, let $D^{1} \in \mathcal{L}_{s}\left(V_{0}\right)$ satisfy $\left(D^{1}\right)_{x y}=1$ for any $x, y \in V_{0}$ with $x \neq y$. For $D=\left(D_{x y}\right)_{x, y \in V_{0}} \in \mathcal{L}_{s}\left(V_{0}\right)$, define

$$
\mathcal{E}_{2, m}^{D}(f)=\frac{1}{2} \sum_{w \in T_{m}, x, y \in V_{0}} D_{x y}\left(f\left(f_{w}(x)\right)-f\left(f_{w}(y)\right)\right)^{2}
$$

for $f \in \ell\left(V_{m}\right)$ and
$\mathcal{E}_{2, m, w}^{D}=\inf \left\{\mathcal{E}_{2, n+m}^{D}(f)\left|f \in \ell\left(V_{n+m}\right), f\right|_{V_{n+m} \cap K_{w}}=1,\left.f\right|_{V_{n+m} \cap\left(\cup_{v \notin \Gamma_{1}(w)} K_{v}\right)}=0\right\}$
for any $w \in T_{n}$. Then by [29, Theorem 3.8.10 and Corollary 3.1.9], there exist $D_{*} \in \mathcal{L}_{s}\left(V_{0}\right)$ and $\sigma>1$ such that $\left(D_{*},\left(\sigma^{-1}, \ldots, \sigma^{-1}\right)\right)$ is a harmonic structure, that is, for any $f \in \ell\left(V_{m}\right)$,

$$
\sigma^{m} \mathcal{E}_{2, m}^{D_{*}}(f)=\min \left\{\sigma^{m+1} \mathcal{E}_{2, m+1}^{D_{*}}(g)\left|g \in \ell\left(V_{m+1}\right), g\right|_{V_{m}}=f\right\}
$$

This implies that there exist $c_{1}, c_{2}>0$ and $k \geq 1$ such that

$$
c_{1} \sigma^{-m} \leq \sup _{w \in T \backslash T_{k}} \mathcal{E}_{2, m, w}^{D_{*}} \leq c_{2} \sigma^{-m}
$$

On the other hand, there exist $c_{3}, c_{4}>0$ such that

$$
c_{3} \mathcal{E}_{2, m}^{D_{*}^{*}}(f) \leq \mathcal{E}_{2, m}^{D^{1}}(f) \leq c_{4} E_{2, m}^{D_{*}}(f)
$$

for any $m \geq 0$ and $f \in \ell\left(V_{m}\right)$. Thus we see that $\sup _{w \in T} \mathcal{E}_{2, m, w}^{D_{1}} \leq C \sigma^{-m}$ for any $m \geq 0$. Therefore, by [34, Theorems 4.6.9 and 4.9.1], it follows that $\operatorname{dim}_{A R}\left(K, d_{*}\right)<2$.

The rest of this section is devoted to proving Theorem 14.12 . We suppose that $\left(K, S,\left\{f_{i}\right\}_{i \in S}\right)$ is strongly symmetric hereafter in this section. By [29, Proposition 3.8.19], we have the following theorem.

Lemma 14.14. If $\left(K, S,\left\{f_{i}\right\}_{i \in S}\right)$ is strongly symmetric, then $g\left(K_{w}\right)=K_{g^{*}(w)}$ for any $g \in \mathcal{G}$ and $w \in T$. In particular, $\mathcal{G} \subseteq \mathcal{G}_{(K, T)}$.

Lemma 14.15. If ( $K, S,\left\{f_{i}\right\}_{i \in S}$ ) is strongly symmetric, $x_{1}, x_{2}, y_{1}, y_{2} \in V_{0}$ and $\left|x_{1}-x_{2}\right|=\left|y_{1}-y_{2}\right|$, then there exists $g \in \mathcal{G}_{*}$ such that $g\left(x_{1}\right)=y_{1}$ and $g\left(x_{2}\right)=y_{2}$.

Proof. By Definition 14.6 (4), there exists $g_{1} \in \mathcal{G}$ such that $g_{1}\left(x_{1}\right)=y_{1}$. Let $g_{1}\left(x_{2}\right)=z$. Then $\left|y_{1}-y_{2}\right|=\left|y_{1}-z\right|$. Hence by Definition 14.6f(2), there exists $g_{2} \in \mathcal{G}$ such that $g_{2}\left(y_{1}\right)=y_{1}$ and $g_{2}(z)=y_{2}$. Thus letting $g=g_{2} \circ g_{1}$, we see that $g\left(x_{1}\right)=g_{2}\left(y_{1}\right)=y_{1}$ and $g\left(x_{2}\right)=g_{2}(z)=y_{2}$.

Definition 14.16. A path $(w(1), \ldots, w(k))$ of $\left(T_{m}, E_{m}^{*}\right)$ is said to connect $x \in$ $K$ and $y \in K$ if $x \in K_{w(1)}$ and $y \in K_{w(k)}$.

Lemma 14.17. Let $\mathbf{p}$ be a path of $\left(T_{m}, E_{m}^{*}\right)$ connecting $x_{1} \in V_{0}$ and $x_{2} \in V_{0}$. Suppose $\left|x_{1}-x_{2}\right|=l_{i}$ for some $i=1, \ldots, m_{*}-1$. Then there exist a path $\mathbf{p}_{1}$ of $\left(T_{m}, E_{m}^{*}\right), x \in V_{0}$ and $y \in V_{0}$ such that $\mathbf{p}_{1}$ connects $x$ and $y, \mathbf{p}_{1} \subseteq \cup_{g \in \mathcal{G}_{*}} g^{*}(\mathbf{p})$ and $|x-y|=l_{i-1}$.

Notation. For a path $\mathbf{p}=(w(1), \ldots, w(k))$ and $g \in \mathcal{G}$, set

$$
g^{*}(\mathbf{p})=\left(g^{*}(w(1)), \ldots, g^{*}(w(k))\right) .
$$

Proof. By Definition 14.6 (2), there exist $x, y, z \in V_{0}$ such that $|x-y|=l_{i-1}$, $|x-z|=l_{i}$ and $g_{y z} \in \mathcal{G}_{*}$. Also, Lemma 14.15 shows that there exists $h \in \mathcal{G}_{*}$ such that $h\left(x_{1}\right)=x$ and $h\left(x_{2}\right)=z$. Since $|x-y|<|x-z|, x$ and $z$ belong to different sides of $H_{y z}$. Hence the path $h^{*}(\mathbf{p})$ intersects with $H_{y z}$. Therefore, $h^{*}(\mathbf{p})$ and $\left(g_{y z}\right)^{*} \circ h^{*}(\mathbf{p})$ has an intersection at $H_{y z}$. Since $\left(g_{y z}\right)^{*} \circ h^{*}(\mathbf{p})$ connects $g_{y z}(x)$ and $y=g_{y z}(z)$, we can extract a path $\mathbf{p}_{1}$ from $h^{*}(\mathbf{p}) \cup\left(g_{y z}\right)^{*} \circ h^{*}(\mathbf{p})$ connecting $x$ and $y$, and included in $\cup_{g \in \mathcal{G}_{*}} g^{*}(\mathbf{p})$. Since $|x-y|=l_{i-1}, \mathbf{p}_{1}$ is a desired path.

Lemma 14.18. Let $\mathbf{p}$ be a path of $\left(T_{m}, E_{m}^{*}\right)$ connecting two distinct points in $V_{0}$. Then for any $x, y \in V_{0}$, there exists a path $\mathbf{p}^{\prime}$ of $\left(T_{m}, E_{m}^{*}\right)$ connecting $x$ and $y$ such that $\mathbf{p}^{\prime} \subseteq \cup_{g \in \mathcal{G}_{*}} g^{*}(\mathbf{p})$.

Proof. Using Lemma 14.17 inductively, we see that there exists a path $\mathbf{p}_{0}$ of $\left(T_{m}, E_{m}^{*}\right)$ connecting two distinct points $z_{1}$ and $z_{2}$ in $V_{0}$ such that $\left|z_{1}-z_{2}\right|=$ $l_{0}$ and $\mathbf{p}_{0} \subseteq \cup_{g \in \mathcal{G}_{*}} g^{*}(\mathbf{p})$. By Definition 14.6 (1), there exists a strict 0 -walk $\left(x_{1}, \ldots, x_{j_{0}}\right)$ satisfying $x_{1}=x$ and $x_{j_{0}}=y$. By Lemma 14.15, for any $j=$ $1, \ldots, j_{0}-1$, there exists $g_{j} \in \mathcal{G}_{*}$ such that $g_{j}\left(z_{1}\right)=x_{j}$ and $g_{j}\left(z_{2}\right)=x_{j+1}$. Concatenating $\left(g_{1}\right)^{*}\left(\mathbf{p}_{0}\right), \ldots,\left(g_{j_{0}-2}\right)^{*}\left(\mathbf{p}_{0}\right)$ and $\left(g_{j_{0}-1}\right)^{*}\left(\mathbf{p}_{0}\right)$, we obtain a desired path connecting $x$ and $y$.

Proof of Theorem 14.12. We are going to use Theorem 10.2. Let $\mathcal{I}=\mathcal{I T}(K, T)$ and let $\mathcal{G}_{0}=\mathcal{G}_{1}=\mathcal{G}_{*}$. By $(14.4)$ and the fact that $\mathcal{I}=\mathcal{I} \mathcal{T}(K, T)$, we see that $E_{m}^{\mathcal{I}}=E_{m}^{*}$. Hence the condition (a) of Theorem 10.2 is satisfied. The condition (b) is also satisfied due to the fact that $\mathcal{G}_{*}$ is transition on $V_{0}$.

Let $w \in T_{n}$, let $u, v \in T_{k}$ and let $\mathbf{p} \in \mathcal{C}_{1, m}^{(1)}(w)$. Then $\mathbf{p}$ contains a path connecting two distinct points in $\cup_{w^{\prime} \in T_{n}} f_{w^{\prime}}\left(V_{0}\right)$. Thus $\psi_{n}(\mathbf{p})$ contains a path between two distinct points in $V_{0}$. By Lemma 14.18, for any $x, y \in V_{0}$, there exists a path $\mathbf{p}_{x y} \subseteq \cup_{g \in \mathcal{G}_{*}} g^{*}\left(\psi_{n}(\mathbf{p})\right)$ connecting $x$ and $y$. Set $\mathcal{U}_{\mathbf{p}}=\cup_{x, y \in V_{0}} \mathbf{p}_{x y}$. Then since $K\left(\mathcal{U}_{\mathbf{p}}\right) \supseteq V_{0}$, it follows that $g\left(K\left(\mathcal{U}_{\varphi}\right)\right) \supseteq V_{0}$ for any $g \in \mathcal{G}_{*}$. Moreover, $K\left(\mathcal{U}_{\mathbf{p}}\right)$ is connected and $\mathcal{U}_{\mathbf{p}} \subseteq \cup_{g \in \mathcal{G}_{*}} g^{*}\left(\psi_{n}(\mathbf{p})\right)$. Thus we have verified the condition (c) of Theorem 10.2. Now, Theorem 10.2 suffices.

## 15 Conductance and Poincaré constants

From this section, we start preparations for a proof of Theorem 8.4. To begin with, we will introduce Poincaré constants and study a relationship between Poincaré and conductance constants in this section.

The next lemma concerns an extension of functions on $T_{n}$ to those on $T_{n+m}$ by means of the partition of unity $\left\{\varphi_{w}\right\}_{w \in T_{n}}$ given in Lemma 3.3.

Lemma 15.1 ([36, (2.8) Lemma]). Let $p \geq 1$, let $A \subseteq T_{n}$ and let $\left\{\varphi_{w}\right\}_{w \in A}$ be the partition of unity given in Lemma 3.3. Define $\hat{I}_{A, m}: \ell(A) \rightarrow \ell\left(S^{m}(A)\right)$ by

$$
\left(\hat{I}_{A, m} f\right)(u)=\sum_{w \in A} f(w) \varphi_{w}(u)
$$

Then
where the constant $\mathbb{1 5 . 1}=q_{15.1}\left(p, L_{*}, M\right)$ depends only on $p, L_{*}$ and $M$.
Proof. Let $\left(a_{k}(u, v)\right)_{u, v \in T_{k}}$ be the adjacency matrix of $\left(T_{k}, E_{k}^{*}\right)$. Set $\tilde{f}=\hat{I}_{A, m} f$. Then

$$
\begin{equation*}
\mathcal{E}_{p}^{n+m}(\tilde{f})=\frac{1}{2} \sum_{w \in A} \sum_{v \in S^{m}(w)} \sum_{u \in S^{m}\left(\Gamma_{1}^{A}(w)\right)} a_{n+m}(u, v)|\tilde{f}(u)-\tilde{f}(v)|^{p} \tag{15.1}
\end{equation*}
$$

Suppose $v \in S^{m}(w), u \in S^{m}\left(\Gamma_{1}^{A}(w)\right)$ and $(u, v) \in E_{n+m}^{*}$. Then $\varphi_{w^{\prime}}(u)=$ $\varphi_{w^{\prime}}(v)=0$ for any $w^{\prime} \notin \Gamma_{M+1}^{A}(w)$. Hence

$$
\sum_{w^{\prime} \in \Gamma_{M+1}^{A}(w)} \varphi_{w^{\prime}}(u)=\sum_{w^{\prime} \in \Gamma_{M+1}^{A}(w)} \varphi_{w^{\prime}}(v)=1 .
$$

Using this, we see

$$
\begin{aligned}
& \tilde{f}(u)-\tilde{f}(v)=\sum_{w^{\prime} \in \Gamma_{M+1}^{A}(w)} f\left(w^{\prime}\right)\left(\varphi_{w^{\prime}}(u)-\varphi_{w^{\prime}}(v)\right) \\
&=\sum_{w^{\prime} \in \Gamma_{M+1}^{A}(w)}\left(f\left(w^{\prime}\right)-f(w)\right)\left(\varphi_{w^{\prime}}(u)-\varphi_{w^{\prime}}(v)\right) .
\end{aligned}
$$

Let $q \geq 1$ be the conjugate of $p$, i.e. $\frac{1}{p}+\frac{1}{q}=1$. Then by Lemma A. 2

$$
\begin{aligned}
|\tilde{f}(u)-\tilde{f}(v)|^{p} & \leq \sum_{w^{\prime} \in \Gamma_{M+1}^{A}(w)}\left|f\left(w^{\prime}\right)-f(w)\right|^{p}\left(\sum_{w^{\prime} \in \Gamma_{M+1}^{A}(w)}\left|\varphi_{w^{\prime}}(u)-\varphi_{w^{\prime}}(v)\right|^{q}\right)^{p / q} \\
& \leq C_{1} \sum_{w^{\prime} \in \Gamma_{M+1}^{A}(w)}\left|f\left(w^{\prime}\right)-f(w)\right|^{p} \sum_{w^{\prime} \in \Gamma_{M+1}^{A}(w)}\left|\varphi_{w^{\prime}}(u)-\varphi_{w^{\prime}}(v)\right|^{p}
\end{aligned}
$$

where $C_{1}=\max \left\{1,\left(L_{*}\right)^{(M+1)(p-2)}\right\}$. If $w \in A$ and $w^{\prime} \in \Gamma_{M+1}^{A}(w)$, then there exist $w(0), \ldots, w(M+1) \in A$ such that $w(0)=w, w(M+1)=w^{\prime},(w(j), w(j+$ $1)) \in E_{n}^{*}$ for any $j=0, \ldots, M$. Then

$$
\left|f\left(w^{\prime}\right)-f(w)\right|^{p} \leq(M+1)^{p-1} \sum_{j=0}^{M}|f(w(j))-f(w(j+1))|^{p}
$$

Since $\#\left(\Gamma_{M+1}^{A}(w)\right) \leq\left(L_{*}\right)^{M+1}$, it follows that

$$
\sum_{w^{\prime} \in \Gamma_{M}^{A}(w)}\left|f\left(w^{\prime}\right)-f(w)\right|^{p} \leq C_{2} \sum_{w^{\prime}, w^{\prime \prime} \in \Gamma_{M}^{A}(w),\left(w^{\prime}, w^{\prime \prime}\right) \in E_{n}^{*}}\left|f\left(w^{\prime}\right)-f\left(w^{\prime \prime}\right)\right|^{p}
$$

where $C_{2}=(M+1)^{p-1}\left(L_{*}\right)^{M}$. On the other hand,

$$
\begin{aligned}
\sum_{v \in S^{m}(w)} \sum_{u \in S^{m}\left(\Gamma_{1}^{A}(w)\right)} a_{n+m}(u, v) \sum_{w^{\prime} \in \Gamma_{M+1}^{A}(w)}\left|\varphi_{w^{\prime}}(u)-\varphi_{w^{\prime}}(v)\right|^{p} \\
\leq 2 \sum_{w^{\prime} \in \Gamma_{M+1}^{A}(w)} \mathcal{E}_{p, S^{m}(A)}^{n+m}\left(\varphi_{w^{\prime}}, \varphi_{w^{\prime}}\right) \leq 2\left(L_{*}\right)^{M+1} \max _{w^{\prime} \in A} \mathcal{E}_{p, S^{m}(A)}^{n+m}\left(\varphi_{w^{\prime}}\right)
\end{aligned}
$$

Hence, by 15.1,

$$
\begin{aligned}
& \mathcal{E}_{p, S^{m}(A)}^{m+n}(\tilde{f}) \leq C_{1} C_{2}\left(L_{*}\right)^{M+1} \max _{w \in A} \mathcal{E}_{p, S^{m}(A)}^{n+m}\left(\varphi_{w}\right) \times \\
& \sum_{w \in A}\left(\sum_{w^{\prime}, w^{\prime \prime} \in \Gamma_{M+1}^{A}(w),\left(w^{\prime}, w^{\prime \prime}\right) \in E_{n}^{*}}\left|f\left(w^{\prime}\right)-f\left(w^{\prime \prime}\right)\right|^{p}\right) \\
& \quad \leq C_{1} C_{2}\left(L_{*}\right)^{2(M+1)} \max _{w \in A} \mathcal{E}_{p, S^{m}(A)}^{n+m}\left(\varphi_{w}\right) \mathcal{E}_{p, A}^{n}(f) .
\end{aligned}
$$

So, Lemma 3.3 suffices.
There is another simple way of extension of functions on $T_{n}$ to those on $T_{n+k}$.
Lemma 15.2. Let $p \geq 1$ and let $A \subseteq T_{n}$. Define $\widetilde{I}_{A, k}: \ell(A) \rightarrow \ell\left(S^{k}(A)\right)$ by

$$
\widetilde{I}_{A, k} f=\sum_{w \in A} f(w) \chi_{S^{k}(w)}
$$

Then

$$
\mathcal{E}_{p, S^{k}(A)}^{n+k}\left(\widetilde{I}_{A, k} f\right) \leq \max _{w \in A} \#\left(\partial S^{k}(w)\right) \mathcal{E}_{p, A}^{n}(f)
$$

Proof. Let $\hat{f}=\widetilde{I}_{A, k} f$. Then $\hat{f}(u)=\hat{f}(v)$ if $\pi^{k}(u)=\pi^{k}(v)$. So if $(u, v) \in E_{n+k}^{*}$ and $\hat{f}(u) \neq \hat{f}(v)$, then $\left(\pi^{k}(u), \pi^{k}(v)\right) \in E_{n}^{*}$. Fix $\left(w, w^{\prime}\right) \in E_{n}^{*}$. Then

$$
\#\left\{(u, v) \mid(u, v) \in E_{n+k}, \pi^{k}(u)=w, \pi^{k}(v)=w^{\prime}\right\} \leq \#\left(\partial S^{k}(w)\right)
$$

This immediately implies the desired statement.
Combining two previous extensions, we have the following estimate.
Lemma 15.3 (36, (2.9) Lemma]). Let $p \geq 1$ and let $A \subseteq T_{n}$. Then, there exists $I_{A, k, m}: \ell(A) \rightarrow \ell\left(S^{k+m}(A)\right)$ such that for any $f \in \ell(A)$,

$$
\begin{align*}
& \mathcal{E}_{p, S^{k+m}(A)}^{n+k+m}\left(I_{A, k, m} f\right) \\
& \leq \llbracket 15.3 \max _{w \in A} \#\left(\partial S^{k}(w)\right) \max _{v \in S^{k}(A)} \mathcal{E}_{M, p, m}\left(v, S^{k}(A)\right) \mathcal{E}_{p, A}^{n}(f) \tag{15.2}
\end{align*}
$$

where the constant $q 15.3=q_{15.3}\left(p, L_{*}, M\right)$ depends only on $p, L_{*}$ and $M$, and

$$
\begin{equation*}
\left(I_{A, k, m} f\right)(u)=f(w) \tag{15.3}
\end{equation*}
$$

for any $w \in A$ and $u \in S^{m}\left(S^{k}(w) \backslash B_{M, k}(w)\right)$.
Proof. Define $I=\hat{I}_{S^{k}(A), m} \circ \widetilde{I}_{A, k}$. Combining Lemmas 15.1 and 15.2 , we immediately obtain 15.2). Let $u \in S^{m+k}(A)$. Set $v=\pi^{m}(u)$ and $w=\pi^{k}(w)$. If $\Gamma_{M}^{S^{k}(A)}(v) \subseteq S^{k}(w)$, then

$$
\begin{aligned}
&(I f)(u)= \sum_{v^{\prime} \in S^{k}(A)} f\left(\pi^{k}\left(v^{\prime}\right)\right) \varphi_{v^{\prime}}(u)= \\
& \sum_{v^{\prime} \in \Gamma_{M}^{S^{k}(A)}(v)} f\left(\pi^{k}\left(v^{\prime}\right)\right) \varphi_{v^{\prime}}(u) \\
&=\sum_{v^{\prime} \in \Gamma_{M}^{S^{k}(A)}(v)} f(w) \varphi_{v^{\prime}}(u)=f(w) .
\end{aligned}
$$

If $v \in S^{k}(w) \backslash B_{M, k}(w)$, then $\Gamma_{M}^{S^{k}(A)}(v) \subseteq \Gamma_{M}(v) \subseteq S^{k}(w)$. So the above equality suffices for 15.3).

Next we introduce $p$-Poincaré constants. In fact, there are two kinds of Poincaré constants $\lambda_{p, m}(A)$ and $\widetilde{\lambda}_{p, m}(A)$ but they are almost the same in view of (15.4).

Definition 15.4. Define $\mu(w)=\mu\left(K_{w}\right)$ for $w \in T$. For $A \subseteq T_{n}$, define $\mu(A)=$ $\sum_{w \in A} \mu(w)$ and $\mu_{A}: A \rightarrow[0, \infty)$ by

$$
\mu_{A}(w)=\frac{\mu(w)}{\mu(A)}
$$

for $w \in A$. For $f \in \ell(A)$, define

$$
(f)_{A}=\sum_{u \in A} f(u) \mu_{A}(u)
$$

and

$$
\|f\|_{p, \mu_{A}}=\left(\sum_{u \in A}|f(u)|^{p} \mu_{A}(u)\right)^{\frac{1}{p}} .
$$

Moreover, define

$$
\lambda_{p, m}(A)=\sup _{f \in \ell\left(S^{m}(A)\right)} \frac{\inf _{c \in \mathbb{R}}\left(\left\|f-c \chi_{S^{m}(A)}\right\|_{p, \mu_{S^{m}(A)}}\right)^{p}}{\mathcal{E}_{p, S^{m}(A)}^{n+m}(f)}
$$

and

$$
\tilde{\lambda}_{p, m}(A)=\sup _{f \in \ell\left(S^{m}(A)\right)} \frac{\left(\left\|f-(f)_{S^{m}(A)}\right\|_{p, \mu_{S^{m}}(A)}\right)^{p}}{\mathcal{E}_{p, S^{m}(A)}^{n+m}(f)} .
$$

Remark. By Lemma B.2 it follows that

$$
\begin{equation*}
\left(\frac{1}{2}\right)^{p} \widetilde{\lambda}_{p, m}(A) \leq \lambda_{p, m}(A) \leq \tilde{\lambda}_{p, m}(A) \tag{15.4}
\end{equation*}
$$

Using the previous lemmas, we have a relation between Poincaré and conductance constants as follows.

Lemma 15.5 ([36, (2.10) Prop.]). Let $p \geq 1$ and let $A \subseteq T_{n}$. For any $m \geq 1$ and $k \geq M m_{0}$,

$$
\max _{w \in A} \#\left(\partial S^{k}(w)\right) \max _{v \in S^{k}(A)} \mathcal{E}_{M, p, m}\left(v, S^{k}(A)\right) \lambda_{p, k+m}(A) \geq q_{15.5} \lambda_{p, 0}(A)
$$

where the constant $15.5={ }^{15.5}\left(\gamma, m_{0}, p, L_{*}, M\right)$ depends only on $\gamma, m_{0}, p, L_{*}$ and $M$.

Proof. Choose $f_{0} \in \ell(A)$ such that $\mathcal{E}_{p, A}^{n}\left(f_{0}\right)=1$ and

$$
\left(\min _{c \in \mathbb{R}}\left\|f_{0}-c \chi_{A}\right\|_{p, \mu_{A}}\right)^{p}=\lambda_{p, 0}(A)
$$

Letting $f=I_{A, k, m} f_{0}$, by Lemma 15.3 , we see that

$$
\begin{equation*}
\mathcal{E}_{p, S^{m+k}(A)}^{n+k+m}(f) \leq \max _{w \in A} \#\left(\partial S^{k}(w)\right) \max _{v \in S^{k}(A)} \mathcal{E}_{M, p, m}\left(v, S^{k}(A)\right) \tag{15.5}
\end{equation*}
$$

On the other hand, by 15.3 and 2.8 ,

$$
\begin{aligned}
& \frac{1}{\mu(A)} \sum_{v \in S^{k+m}(A)}|f(v)-c|^{p} \mu(v)=\frac{1}{\mu(A)} \sum_{w \in A} \sum_{v \in S^{m}\left(S^{k}(w)\right)}|f(v)-c|^{p} \mu(v) \\
& \geq \frac{1}{\mu(A)} \sum_{w \in A} \sum_{v \in S^{m}\left(S^{k}(w) \backslash B_{M, k}(w)\right)}\left|f_{0}(w)-c\right|^{p} \mu(v) \\
& \geq \gamma^{m_{0} M} \frac{1}{\mu(A)} \sum_{w \in A}\left|f_{0}(w)-c\right|^{p} \mu(w) \geq \gamma^{m_{0} M} \lambda_{p, 0}(A)
\end{aligned}
$$

This and 15.5 yield the desired inequality.

## 16 Relations of constants

In this section, we will establish relations between conductance, neighbor disparity, and Poincaré constants towards a proof of Theorem 8.4

Definition 16.1. For $w \in T$ and $n \geq 0$, define

$$
\xi_{n}(w)=\max _{v \in S^{n}(w)} \frac{\mu(v)}{\mu(w)}
$$

First, we consider a relation between Poincaré and neighbor disparity constants.

Lemma 16.2 ([36, (2.13) Prop.-(1)]). Let $p \geq 1$. For any $w \in T$ and $n, m \geq 1$,

$$
\widetilde{\lambda}_{p, n+m}(w) \leq 2^{p-1}\left(\xi_{n}(w) \max _{v \in S^{n}(w)} \widetilde{\lambda}_{p, m}(v)+L_{*} \widetilde{\lambda}_{p, n}(w) \sigma_{p, m, n+|w|}\right) .
$$

Proof. By Theorem A.3, for any $f \in \ell\left(S^{n+m}(w)\right)$,

$$
\begin{aligned}
& \frac{1}{\mu(w)} \sum_{u \in S^{n+m}(w)}\left|f(u)-(f)_{S^{n+m}(w)}\right|^{p} \mu(v) \\
\leq & \frac{C_{p}}{\mu(w)} \sum_{v \in S^{n}(w)} \sum_{u \in S^{m}(v)}\left(\left|f(u)-(f)_{S^{m}(v)}\right|^{p}+\left|(f)_{S^{m}(v)}-(f)_{S^{n+m}(w)}\right|^{p}\right) \mu(u),
\end{aligned}
$$

where $C_{p}=2^{p-1}$ for $p \neq 2$ and $C_{2}=1$. Examining the first half of the above inequality, we obtain

$$
\begin{aligned}
& \frac{1}{\mu(w)} \sum_{v \in S^{n}(w)} \sum_{u \in S^{m}(v)}\left|f(u)-(f)_{S^{m}(v)}\right|^{p} \mu(u) \\
& \leq \sum_{v \in S^{n}(w)} \frac{\mu(v)}{\mu(w)} \widetilde{\lambda}_{p, m}(v) \mathcal{E}_{p, S^{m}(v)}^{|w|+n+m}(f) \leq \xi_{n}(w) \max _{v \in S^{n}(w)} \widetilde{\lambda}_{p, m}(v) \mathcal{E}_{p, S^{n+m}(w)}^{|w|+n+m}(f) .
\end{aligned}
$$

For the other half, by Lemma 5.2 ,

$$
\begin{aligned}
& \frac{1}{\mu(w)} \sum_{v \in S^{n}(w)} \sum_{u \in S^{m}(v)}\left|(f)_{S^{m}(v)}-(f)_{S^{n+m}(w)}\right|^{p} \mu(u) \\
& \left.=\sum_{v \in S^{n}(w)} \frac{\mu(v)}{\mu(w)} \right\rvert\,\left(P_{n+|w|, m} f\right)(v)-\left(P_{n+|w|, m} f\right)_{\left.S^{n}(w)\right|^{p}} \\
& \leq \widetilde{\lambda}_{p, n}(w) \mathcal{E}_{p, S^{n}(w)}^{|w|+n}\left(P_{n+|w|, m} f\right) \\
& \quad \leq L_{*} \widetilde{\lambda}_{p, n}(w) \max _{v, v^{\prime} \in S^{n}(w),\left(v, v^{\prime}\right) \in E_{n+|w|}^{*}} \sigma_{p, m}\left(v, v^{\prime}\right) \mathcal{E}_{p, S^{n+m}(w)}^{n+m+|w|}(f) .
\end{aligned}
$$

Combining all, we see

$$
\begin{aligned}
& \widetilde{\lambda}_{p, n+m}(w) \\
\leq & C_{p}\left(\xi_{n}(w) \max _{v \in S^{n}(w)} \widetilde{\lambda}_{p, m}(v)+L_{*} \tilde{\lambda}_{p, n}(w) \max _{v, v^{\prime} \in S^{n}(w),\left(v, v^{\prime}\right) \in E_{n+|w|}^{*}} \sigma_{p, m}\left(v, v^{\prime}\right)\right) .
\end{aligned}
$$

Definition 16.3. Define

$$
\bar{\lambda}_{p, m}=\sup _{w \in T} \widetilde{\lambda}_{p, m}(w)
$$

By Theorem 18.7. $\bar{\lambda}_{p, m}$ is finite for any $m \geq 1$.
Making use of Lemma 16.2 , we have the following inequality.
Lemma 16.4. Define

$$
\xi_{n}=\sup _{w \in T} \xi_{n}(w)
$$

Then

$$
\begin{equation*}
\bar{\lambda}_{p, n+m} \leq 2^{p-1}\left(\xi_{n} \bar{\lambda}_{p, m}+L_{*} \bar{\lambda}_{p, n} \sigma_{p, m}\right) \tag{16.1}
\end{equation*}
$$

for any $n, m \geq 1$.
Remark. By Lemma 2.13, $\mu$ is exponential, so that there exist $\xi \in(0,1)$ and $c>0$ such that

$$
\xi_{n} \leq c \xi^{n}
$$

for any $n \geq 1$.
Next, we examine the relationship between the conductance and Poincaré constants.

Lemma 16.5. For any $w \in T, l, m \geq 1$ and $k \geq m_{0} M_{0}$,

$$
\begin{equation*}
\bar{D}_{k} \mathcal{E}_{M_{*}, p, m,|w|+k+l} \tilde{\lambda}_{p, k+m+l}(w) \geq q \overline{16.5} \widetilde{\lambda}_{p, l}(w) \tag{16.2}
\end{equation*}
$$

where $\bar{D}_{k}=\max _{v \in T \backslash\{\phi\}} \#\left(\partial S^{k}(v)\right)$ and the constant $\underset{16.5}{ }=2^{-p}$ G.2.2 depends only on $\gamma, m_{0}, p, L_{*}$ and $M_{0}$. In particular,

$$
\begin{equation*}
\bar{D}_{k} \mathcal{E}_{M_{*}, p, m} \bar{\lambda}_{p, k+m+l} \geq q 16.5 \bar{\lambda}_{p, l} \tag{16.3}
\end{equation*}
$$

Proof. Applying Lemma 15.5 with $M=M_{0}$ and $A=S^{l}(w)$, we obtain

$$
\bar{D}_{k} \max _{v \in S^{k+l}(w)} \mathcal{E}_{M_{0}, p, m}\left(v, S^{k+l}(w)\right) \lambda_{p, k+m}\left(S^{l}(w)\right) \geq q_{15.5} \lambda_{p, 0}\left(S^{l}(w)\right)
$$

Lemma 3.2 shows

$$
\mathcal{E}_{M_{0}, p, m}\left(v, S^{k+l}(w)\right) \leq \mathcal{E}_{M_{*}, p, m}\left(v, T_{|w|+k+l}\right) \leq \mathcal{E}_{M_{*}, p, m,|w|+k+l}
$$

Moreover, $\lambda_{p, k+m}\left(S^{l}(w)\right)=\lambda_{p, k+m+l}(w)$ and $\lambda_{p, 0}\left(S^{l}(w)\right)=\lambda_{p, l}(w)$ by definition. So letting $q_{16.5}=2^{-p}{ }_{\text {C3.2 }}$, we obtain 16.2 .

The next theorem is one of the main results of this section.
Theorem 16.6. Assume that $p>1$. If either

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \xi_{n} \mathcal{E}_{p, n-m_{0} M_{0}}=0 \tag{16.4}
\end{equation*}
$$

or

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \xi_{n} \bar{D}_{n-1}=0 \tag{16.5}
\end{equation*}
$$

then there exists $C>0$ such that

$$
\begin{align*}
\bar{\lambda}_{p, m} & \leq C \sigma_{p, m}  \tag{16.6}\\
\bar{\lambda}_{p, m+n} & \leq C \bar{\lambda}_{p, n} \sigma_{p, m} \tag{16.7}
\end{align*}
$$

and

$$
\begin{equation*}
\left(\mathcal{E}_{M_{*}, p, n}\right)^{-1} \bar{\lambda}_{p, m} \leq C \bar{\lambda}_{p, m+n} \tag{16.8}
\end{equation*}
$$

for any $n, m \geq 1$.
Remark. 16.7) corresponds to [36, (2.4)] and 16.8) corresponds to [36, (2.3)].
Unlike (16.4), 16.5 does not depend on $p$. So, once 16.5 holds, then we have $(16.6),(16.7)$ and $(16.8)$ for any $p>1$. See Proposition 16.7 after the proof for more discussion on 16.5 .
Proof. For ease of notation, we write $\bar{\lambda}_{m}=\bar{\lambda}_{p, m}, \sigma_{m}=\sigma_{p, m}$ and $\mathcal{E}_{M_{*}, p, m}=\mathcal{E}_{m}$. By 16.3), if $n>k \geq m_{0} M_{0}$, then

$$
\begin{equation*}
\bar{D}_{k} \mathcal{E}_{n-k} \bar{\lambda}_{n+m} \geq \underline{16.5} \bar{\lambda}_{m} \tag{16.9}
\end{equation*}
$$

This and 16.1) show

$$
\begin{equation*}
\bar{\lambda}_{n+m} \leq 2^{p-1}\left(\left(q_{16.5}\right)^{-1} \bar{D}_{k} \mathcal{E}_{n-k} \xi_{n} \bar{\lambda}_{m}+L_{*} \bar{\lambda}_{n} \sigma_{m}\right) \tag{16.10}
\end{equation*}
$$

Suppose that $\sqrt{16.4}$ holds. Let $k=m_{0} M_{0}$. Then there exists $n_{0}$ such that, for any $n \geq n_{0}$,

$$
2^{p-1}\left(q_{16.5}\right)^{-1} \bar{D}_{m_{0} M_{0}} \mathcal{E}_{n-m_{0} M_{0}} \xi_{n} \leq \frac{1}{2}
$$

and hence by 16.10 ,

$$
\begin{equation*}
\bar{\lambda}_{n+m} \leq 2^{p} L_{*} \bar{\lambda}_{n} \sigma_{m} \tag{16.11}
\end{equation*}
$$

Next suppose that 16.5 holds. Then there exists $n_{0}$ such that, for any $n \geq n_{0}$,

$$
2^{p-1}\left(q_{16.5}\right)^{-1} \bar{D}_{n-1} \mathcal{E}_{1} \xi_{n} \leq \frac{1}{2}
$$

so that we have $\sqrt{16.11}$ as well. Thus we have seen that if either $\sqrt{16.4}$ ) or 16.5 ) holds, then there exists $n_{0}$ such that 16.11 holds for any $n \geq n_{0}$.

Now, let $n_{*}=\max \left\{m_{0} M_{0}+1, n_{0}\right\}$. Then by 16.9 and 16.11 ,

$$
q 1 \overline{16.5}\left(\bar{D}_{m_{0} M_{0}}\right)^{-1}\left(\mathcal{E}_{p, n_{*}-m_{0} M_{0}}\right)^{-1} \bar{\lambda}_{m} \leq \bar{\lambda}_{n_{*}+m} \leq 2^{p} L_{*} \bar{\lambda}_{n_{*}} \sigma_{m}
$$

for any $m \geq 1$. This immediately implies (16.6). Using this and (8.2), we have

$$
\bar{\lambda}_{m+n} \leq \sigma_{m+n} \leq C \sigma_{m} \sigma_{n}
$$

Therefore, for any $m \geq 1$ and $n \in\left\{1, \ldots, n_{0}\right\}$,

$$
\frac{\bar{\lambda}_{m+n}}{\bar{\lambda}_{n} \sigma_{p, m}} \leq C \frac{\sigma_{n}}{\bar{\lambda}_{n}} \leq C \max _{n=1, \ldots, n_{0}} \frac{\sigma_{n}}{\bar{\lambda}_{n}}
$$

So we have verified 16.7 for any $n, m \geq 1$. Letting $k=m_{0} M_{0}$ in 16.3 and using 16.7), we obtain (16.8) as well.

The following proposition gives a geometric sufficient condition for 16.5.
Proposition 16.7. Suppose that Assumption 2.15 holds. Assume that $\mu$ is $\alpha_{H}{ }^{-}$ Ahlfors regular with respect to the metric d. If there exist $\tilde{\alpha}<\alpha_{H}$ and $c>0$ such that

$$
\#\left(\partial S^{m}(w)\right) \leq c r^{-m \tilde{\alpha}}
$$

for any $w \in T$ and $m \geq 0$, then 16.5 holds.
Under the assumptions of Proposition 16.7, $\alpha_{H}=\operatorname{dim}_{H}(K, d)$, which is the Hausdorff dimension of $(K, d)$, while $\operatorname{dim}_{H}\left(B_{w}, d\right) \leq \tilde{\alpha}$ for any $w \in T$. So, roughly speaking, Proposition 16.7 says that if

$$
\operatorname{dim}_{H}(K, d)>\sup _{w \in T} \operatorname{dim}_{H}\left(B_{w}, d\right)
$$

then 16.5 is satisfied. By this proposition, one can verify 16.5 for generalized Sierpinski carpets for example.

Proof. By [34, Theorem 3.1.21], there exist $c_{1}, c_{2}>0$ such that

$$
c_{1} r^{\alpha_{H}|w|} \leq \mu\left(K_{w}\right) \leq c_{2} r^{\alpha_{H}|w|}
$$

for any $w \in T$. Hence $\xi_{n} \leq c r^{\alpha_{H} n}$, while $\bar{D}_{n} \leq r^{-\tilde{\alpha} n}$.
To conclude this section, we present a lemma providing a control of the difference of a function on $T_{n}$ through $\mathcal{E}_{p}^{n}(f)$ and the Poincaré constant.

Lemma 16.8. For any $w \in T, n \geq m \geq 1, f \in \ell\left(S^{n}(w)\right)$, and $u, v \in S^{n}(w)$, if $\pi^{n-m}(u)=\pi^{n-m}(v)$, then

$$
|f(u)-f(v)| \leq 2 \gamma^{-\frac{1}{p}} \mathcal{E}_{p, S^{n}(w)}^{n+|w|}(f)^{\frac{1}{p}} \sum_{i=1}^{n-m}\left(\bar{\lambda}_{p, i}\right)^{\frac{1}{p}}
$$

Proof. Let $u \in S^{n}(w)$. Set $S_{i}(u)=S^{i}\left(\pi^{i}(u)\right)$ for $u \in S^{n}(w)$ and $i=0,1, \ldots, n$. By Lemma B. 3 and (2.5), for any $k=1, \ldots, n$,

$$
\begin{aligned}
\left|f(u)-(f)_{S_{k}(u)}\right| \leq \sum_{i=1}^{k} \mid(f)_{S_{i-1}(u)}- & (f)_{S_{i}(u)} \mid \\
\leq \sum_{i=1}^{k}\left(\frac{\mu\left(\pi^{i}(u)\right)}{\mu\left(\pi^{i-1}(u)\right)}\right)^{\frac{1}{p}} & \left(\widetilde{\lambda}_{s, p, i}\left(\pi^{i}(u)\right) \mathcal{E}_{p, S_{i}(u)}^{n+w}(f)\right)^{\frac{1}{p}} \\
& \leq \gamma^{-\frac{1}{p}} \mathcal{E}_{p, S^{n}(w)}^{n+|w|}(f)^{\frac{1}{p}} \sum_{i=1}^{k}\left(\widetilde{\lambda}_{p, i}\left(\pi^{i}(u)\right)\right)^{\frac{1}{p}}
\end{aligned}
$$

Hence

$$
\begin{aligned}
|f(u)-f(v)| & \leq\left|f(u)-(f)_{S_{n-m}(u)}\right|+\left|(f)_{S_{n-m}(v)}-f(v)\right| \\
& \leq \gamma^{-\frac{1}{p}} \mathcal{E}_{p, S^{n}(w)}^{n+|w|}(f)^{\frac{1}{p}}\left(\sum_{i=1}^{n-m}\left(\left(\widetilde{\lambda}_{p, i}\left(\pi^{i}(v)\right)\right)^{\frac{1}{p}}+\left(\widetilde{\lambda}_{p, i}\left(\pi^{i}(w)\right)\right)^{\frac{1}{p}}\right)\right)
\end{aligned}
$$

## 17 Proof of Theorem 8.4

Finally, we are going to give a proof of the "if" part of Theorem 8.4 Recall that by (8.3), there exist $c>0$ and $\alpha \in(0,1)$ such that

$$
\mathcal{E}_{M_{*}, p, m} \leq c \alpha^{m}
$$

for any $m \geq 0$. Then since $\xi_{n} \leq 1$, the condition (16.4) is satisfied and hence (16.6), 16.7) and (16.8) turn out to be true.

Lemma 17.1. Set $\rho=\alpha^{\frac{1}{p}}$. There exists $C>0$ such that for any $w \in T, k, m \geq$ 1 with $m \geq k$ and $f \in \ell\left(S^{m}(w)\right)$, if $u, v \in S^{m}(w)$ and $\pi^{m-k}(u)=\pi^{m-k}(v)$, then

$$
\begin{equation*}
|f(u)-f(v)| \leq C \rho^{k}\left(\bar{\lambda}_{p, m}\right)^{\frac{1}{p}} \mathcal{E}_{p, S^{m}(w)}^{|w|+m}(f)^{\frac{1}{p}} \tag{17.1}
\end{equation*}
$$

Proof. By 16.8,

$$
\begin{equation*}
\bar{\lambda}_{p, i} \leq C \bar{\lambda}_{p, m} \mathcal{E}_{p, m-i} \leq C \bar{\lambda}_{p, m} \rho^{p(m-i)} \tag{17.2}
\end{equation*}
$$

Using this and applying Lemma 16.8, we have

$$
|f(u)-f(v)| \leq C \mathcal{E}_{p, S^{m}(w)}^{|w|+m}(f)^{\frac{1}{p}} \sum_{i=1}^{m-k}\left(\bar{\lambda}_{p, i}\right)^{\frac{1}{p}} \leq C \mathcal{E}_{p, S^{m}(w)}^{|w|+m}(f)^{\frac{1}{p}}\left(\bar{\lambda}_{p, m}\right)^{\frac{1}{p}} \sum_{i=k}^{m-1} \rho^{i}
$$

Lemma 17.2. There exist $n_{*} \geq 1$ and $m_{*} \geq n_{*}$ such that if $m \geq m_{*}$, then there exist $w \in T$ and $f \in \ell\left(S^{m}(w)\right)$ such that

$$
\min _{u \in S^{m-n_{*}}\left(y_{1}\right)} f(u)-\max _{u \in S^{m-n_{*}}\left(y_{2}\right)} f(u) \geq \frac{1}{8}
$$

for some $y_{1}, y_{2} \in S^{n_{*}}(w)$ and

$$
\mathcal{E}_{p, S^{m}(w)}^{|w|+m}(f) \leq \frac{2}{\sigma_{p, m}}
$$

Proof. Choose $\left(w_{1}, w_{2}\right) \in T \times T$ with $\left|w_{1}\right|=\left|w_{2}\right|$ such that $\left(w_{1}, w_{2}\right) \in E_{\left|w_{1}\right|}^{*}$, $\sigma_{p, m}\left(w_{1}, w_{2}\right) \geq \frac{1}{2} \sigma_{p, m}$ and choose $f \in \ell\left(S^{m}\left(w_{1}\right) \cup S^{m}\left(w_{2}\right)\right)$ such that $(f)_{S^{m}\left(w_{1}\right)}-$ $(f)_{S^{m}\left(w_{2}\right)}=1$ and

$$
\begin{equation*}
\mathcal{E}_{p, S^{m}\left(w_{1}\right) \cup S^{m}\left(w_{2}\right)}^{\left|w_{1}\right|+m}(f)=\frac{1}{\sigma_{p, m}\left(w_{1}, w_{2}\right)} . \tag{17.3}
\end{equation*}
$$

Claim 1: There exists $c_{1}>0$, which is independent of $m, w_{1}$ and $w_{2}$, such that if $u_{1}, u_{2} \in S^{m}\left(w_{1}\right) \cup S^{m}\left(w_{2}\right)$ and $\left(u_{1}, u_{2}\right) \in E_{\left|w_{1}\right|+m}^{*}$, then

$$
\begin{equation*}
\left|f\left(u_{1}\right)-f\left(u_{2}\right)\right| \leq c_{1} \rho^{m} \tag{17.4}
\end{equation*}
$$

Proof of Claim 1: By $16.6,(17.2$ and 17.3 , we have

$$
\begin{aligned}
&\left|f\left(u_{1}\right)-f\left(u_{2}\right)\right|^{p} \leq \mathcal{E}_{p, S^{m}\left(w_{1}\right) \cup S^{m}\left(w_{2}\right)}^{\left|w_{1}\right|+m}(f)=\frac{1}{\sigma_{p, m}\left(w_{1}, w_{2}\right)} \\
& \leq \frac{2}{\sigma_{p, m}} \leq \frac{C}{\bar{\lambda}_{p, m}} \leq C \rho^{p m}
\end{aligned}
$$

Claim 2: There exists $c_{2}>0$, which is independent of $m, w_{1}$ and $w_{2}$, such that if $u_{1}, u_{2} \in S^{m}\left(w_{1}\right) \cup S^{m}\left(w_{2}\right)$ and $\pi^{m-k}\left(u_{1}\right)=\pi^{m-k}\left(u_{2}\right)$ for $1 \leq k \leq m$, then

$$
\left|f\left(u_{1}\right)-f\left(u_{2}\right)\right| \leq c_{2} \rho^{k}
$$

Proof of Claim 2: It follows that $u_{1}, u_{2} \in S^{m}\left(w_{i}\right)$ for $i=1$ or 2. Using Lemma 17.1, we obtain

$$
\begin{aligned}
\left|f\left(u_{1}\right)-f\left(u_{2}\right)\right| & \leq C \rho^{k}\left(\bar{\lambda}_{p, m}\right)^{\frac{1}{p}} \mathcal{E}_{p, S^{m}\left(w_{i}\right)}^{|w|+m}(f)^{\frac{1}{p}} \\
\leq & C \rho^{k}\left(\bar{\lambda}_{p, m}\right)^{\frac{1}{p}} \mathcal{E}_{\left.p, S^{m}\left(w_{1}\right) \cup S^{m}\left(w_{2}\right)\right)}^{|w|+m}(f)^{\frac{1}{p}} \leq C \rho^{k}\left(\bar{\lambda}_{p, m}\right)^{\frac{1}{p}}\left(\sigma_{p, m}\right)^{-\frac{1}{p}} .
\end{aligned}
$$

Now (16.6) immediately shows the claim.
Define

$$
n_{*}=\inf \left\{n \mid n \in \mathbb{N}, 1 \geq 16 c_{2} \rho^{n}\right\} \text { and } m_{*}=\max \left\{n_{*}, \inf \left\{m \mid m \in \mathbb{N}, 1 \geq 2 c_{1} \rho^{m}\right\}\right\}
$$

Hereafter we assume that $m \geq m_{*}$.
Claim 3: For $i=1$ or 2 , there exist $u_{1}, u_{2} \in S^{m}\left(w_{i}\right)$ such that $u_{2} \in \partial S^{m}\left(w_{i}\right)$ and

$$
\left|f\left(u_{1}\right)-f\left(u_{2}\right)\right| \geq \frac{1}{4}
$$

Proof of Claim 3: Choose $v_{11}, v_{12} \in S^{m}\left(w_{1}\right)$ and $v_{21}, v_{22} \in S^{m}\left(w_{2}\right)$ such that $f\left(v_{11}\right) \geq(f)_{S^{m}\left(w_{1}\right)}, f\left(v_{22}\right) \leq(f)_{S^{m}\left(w_{2}\right)}$ and $\left(v_{12}, v_{21}\right) \in E_{\left|w_{1}\right|+m}^{*}$. Since

$$
f\left(v_{11}\right)-f\left(v_{12}\right)+f\left(v_{12}\right)-f\left(v_{21}\right)+f\left(v_{21}\right)-f\left(v_{22}\right)=f\left(v_{11}\right)-f\left(v_{22}\right) \geq 1,
$$

(17.4) shows that, for either $i=1$ or 2 ,

$$
\left|f\left(v_{i 1}\right)-f\left(v_{i 2}\right)\right| \geq \frac{1}{2}\left(1-c_{1} \rho^{m}\right) \geq \frac{1}{4}
$$

Letting $u_{1}=v_{i 1}$ and $u_{2}=v_{i 2}$, we have the claim.
Let $w=w_{i}$ where $i$ is chosen in Claim 3. Exchanging $f$ by $-f$ if necessary, we see that there exists $u_{1} \in S^{m}(w)$ and $u_{2} \in \partial S^{m}(w)$ such that

f\left(u_{1}\right)-f\left(u_{2}\right) \geq \frac{1}{4}
$$

Set $y_{i}=\pi^{m-n_{*}}\left(u_{i}\right)$ for $i=1,2$. Note that $y_{i} \in S^{n_{*}}(w)$. By Claim 2,

\min _{u \in S^{m-n_{*}}\left(y_{1}\right)} f(u)-\max _{u \in S^{m-n_{*}}\left(y_{2}\right)} f(u) \geq \frac{1}{4}-2 c_{2} \rho^{n_{*}} \geq \frac{1}{8} \tag{17.5}
\end{equation*}
$$

Proof of Theorem 8.4. Let $m \geq m_{*}$. Then there exist $w \in T$ and $f \in S^{m}(w)$ satisfying the conclusions of Lemma 17.2. Set $c_{0}=\max _{u \in S^{m-n_{*}}\left(y_{2}\right)} f(u)$. Define

$$
h(v)= \begin{cases}1 & \text { if } 8\left(f(v)-c_{0}\right) \geq 1 \\ 8\left(f(v)-c_{0}\right) & \text { if } 0<8\left(f(v)-c_{0}\right)<1 \\ 0 & \text { if } 8\left(f(v)-c_{0}\right)<0\end{cases}
$$

for any $v \in S^{m}(w)$. Then $\left.h\right|_{S^{n_{*}}\left(y_{1}\right)} \equiv 1,\left.h\right|_{S^{n_{*}}\left(y_{2}\right)} \equiv 0$ and

$$
\mathcal{E}_{p, m-n_{*}}\left(y_{1}, y_{2}, S^{n_{*}}(w)\right) \leq \mathcal{E}_{p, S^{m}(w)}^{|w|+m}(h) \leq 8^{p} \mathcal{E}_{p, S^{m}(w)}^{|w|+m} \leq \frac{2^{3 p+1}}{\sigma_{p, m}}
$$

By (8.4),

$$
\mathcal{E}_{M_{*}, p, m-n_{*}} \leq c\left(n_{*}\right) \mathcal{E}_{p, m-n_{*}}\left(y_{1}, y_{2}, S^{n_{*}}(w)\right) \leq \frac{c\left(n_{*}\right) 2^{3 p+1}}{\sigma_{p, m}}
$$

Making use of the sub-multiplicative property of $\mathcal{E}_{M_{*}, p, n}$, we have

$$
\mathcal{E}_{M_{*}, p, m} \leq C \mathcal{E}_{M_{*}, p, n_{*}} \mathcal{E}_{M_{*}, p, m-n_{*}}
$$

Finally, the last two inequalities show

$$
\mathcal{E}_{M_{*}, p, m} \sigma_{p, m} \leq C \mathcal{E}_{M_{*}, p, n_{*}} c\left(n_{*}\right) 2^{3 p+1}
$$

for any $m \geq m_{*}$, where the right-hand side is independent of $m$. Thus $K$ is $p$-conductively homogeneous.

## 18 Uniformity of constants

In this section, we study the uniformity of conductance, Poincaré and neighbor disparity constants with respect to the structure of graphs.

Definition 18.1. (1) A pair ( $V, E$ ) is called a (non-directed) graph if and only if $V$ is a countable set and $E \subseteq V \times V$ such that $(u, v) \in V$ if and only if $(v, u) \in V$. For a graph $(V, E), V$ is called the vertices and $E$ is called the edges.
(2) Let $(V, E)$ and $\left(V^{\prime}, E^{\prime}\right)$ be graphs. A bijective map $\iota: V \rightarrow V^{\prime}$ is called an isomorphism between $(V, E)$ and ( $V^{\prime}, E^{\prime}$ ) if and only if " $(w, v) \in E$ " is equivalent to " $(\iota(w), \iota(v)) \in E^{\prime \prime}$ " for any $u, v \in V$.
(3) Let $(V, E)$ be a graph. For $p>0$ and $f \in \ell(V)$, define $\mathcal{E}_{P}^{(V, E)}(f) \in[0, \infty]$ by

$$
\mathcal{E}_{p}^{(V, E)}(f)=\frac{1}{2} \sum_{(u, v) \in E}|f(u)-f(v)|^{p} .
$$

(4) Let $(V, E)$ be a graph and let $A, B \subseteq V$ with $A \cap B=\emptyset$. Define

$$
\mathcal{E}_{p}^{(V, E)}(A, B)=\inf \left\{\mathcal{E}_{p}^{(V, E)}(f)|f \in \ell(V), f|_{A} \equiv 1,\left.f\right|_{B} \equiv 0\right\}
$$

In this section, we always identify isomorphic graphs.
First, we study the uniformity of conductance constants.
Definition 18.2. For $L, N \geq 1$, define

$$
\begin{aligned}
& \mathcal{G}_{\mathcal{E}}(L, N)=\{(V, E) \mid(V, E) \text { is a connected graph, } \\
& \qquad V=\{\mathbf{t}, \mathbf{b}\} \cup V_{*}, \text { where the union is a disjoint union and } \mathbf{t} \neq \mathbf{b}, \\
& \left.\quad 1 \leq \#\left(V_{*}\right) \leq L N, \#(\{v \mid v \in E,(w, v) \in E\}) \leq L \text { for any } w \in V_{*}\right\} .
\end{aligned}
$$

Since $\mathcal{G}_{\mathcal{E}}(L, N)$ is a finite set up to graph isomorphisms, we have the following theorem.

Theorem 18.3. For any $L, N \geq 1$ and $p>0$,

$$
0<\inf _{(V, E) \in \mathcal{G}_{\mathcal{E}}(L, N)} \mathcal{E}_{p}^{(V, E)}(\{\mathbf{t}\},\{\mathbf{b}\}) \leq \sup _{(V, E) \in \mathcal{G}_{\mathcal{E}}(L, N)} \mathcal{E}_{p}^{(V, E)}(\{\mathbf{t}\},\{\mathbf{b}\})<\infty
$$

Definition 18.4. Define

$$
\underline{c}_{\mathcal{E}}(L, N, p)=\inf _{(V, E) \in \mathcal{G}_{\mathcal{E}}(L, N)} \mathcal{E}_{p}^{(V, E)}(\{\mathbf{t}\},\{\mathbf{b}\})
$$

and

$$
\bar{c}_{\mathcal{E}}(L, N, p)=\sup _{(V, E) \in \mathcal{G}_{\mathcal{E}}(L, N)} \mathcal{E}_{p}^{(V, E)}(\{\mathbf{t}\},\{\mathbf{b}\})
$$

Next we consider Poincaré constants.

Definition 18.5. For $L \geq 1$ and $N \geq 2$, define

$$
\begin{aligned}
\mathcal{G}(L, N)= & \{(V, E) \mid(V, E) \text { is a connected graph, } \\
& 2 \leq \#(V) \leq N, \#(\{v \mid v \in V,(w, v) \in E,\}) \leq L \text { for any } w \in V\} .
\end{aligned}
$$

For a connected graph $(V, E)$, define

$$
\mathcal{P}(V, E)=\left\{\mu \mid \mu \in V \rightarrow[0,1], \sum_{v \in V} \mu(v)=1\right\}
$$

For $\mu \in \mathcal{P}(V, E)$, define

$$
(f)_{\mu}=\sum_{v \in V} f(v) \mu(v)
$$

for $f \in \ell(V)$ and

$$
\widetilde{\lambda}_{p, \mu}^{(V, E)}=\sup _{f \in \ell(V)} \frac{\sum_{v \in V}\left|f-(f)_{\mu}\right|^{p} \mu(v)}{\mathcal{E}_{p}^{(V, E)}(f)}
$$

for $p>0$.
Lemma 18.6. Let $(V, E)$ be a connected finite graph. Then for any $p \geq 1$,

$$
0<\inf _{\mu \in \mathcal{P}(V, E)} \widetilde{\lambda}_{p, \mu}^{(V, E)} \leq \sup _{\mu \in \mathcal{P}(V, E)} \widetilde{\lambda}_{p, \mu}^{(V, E)}<\infty
$$

Proof. Write $\mathcal{E}_{p}=\mathcal{E}_{p}^{(V, E)}$. For any $p \geq 1$,

$$
\left|(f)_{\mu}\right|+\mathcal{E}_{p}(f)^{\frac{1}{p}}
$$

is a norm on $\ell(V)$. Therefore if

$$
\mathcal{F}_{\mu}=\left\{f \mid f \in \ell(V), \mathcal{E}_{p}(f)=1,(f)_{\mu}=0\right\}
$$

then $\mathcal{F}_{\mu}$ is a compact subset of $\ell(V)$. Fix $\mu_{*} \in \mathcal{P}(V, E)$ and set $\mathcal{F}=\mathcal{F}_{\mu_{*}}$. For any $f \in \ell(V)$ with $\mathcal{E}_{p}(f) \neq 0$, define $f_{*}=\mathcal{E}_{p}(f)^{-\frac{1}{p}}\left(f-(f)_{\mu_{*}}\right)$. Then $f_{*} \in \mathcal{F}$ and

$$
\frac{\sum_{v \in V}\left|f(v)-(f)_{\mu}\right|^{p} \mu(v)}{\mathcal{E}_{p}(f)}=\sum_{v \in V}\left|f_{*}(v)-\left(f_{*}\right)_{\mu}\right|^{p} \mu(v)
$$

Hence letting $F\left(\mu, f_{*}\right)=\sum_{v \in V}\left|f_{*}(v)-\left(f_{*}\right)_{\mu}\right|^{p} \mu(v)$, we see that

$$
\widetilde{\lambda}_{p, \mu}^{(V, E)}=\sup _{f_{*} \in \mathcal{F}} F\left(\mu, f_{*}\right)
$$

Since $\mathcal{P}(V, E) \times \mathcal{F}$ is compact and $F\left(\mu, f_{*}\right)$ is continuous on $\mathcal{P}(V, E) \times \mathcal{F}$, it follows that

$$
\begin{aligned}
0<\inf _{\mu \in \mathcal{P}(V, E), f_{*} \in \mathcal{F}} F\left(\mu, f_{*}\right) & \leq \inf _{\mu \in \mathcal{P}} \widetilde{\lambda}_{p, \mu}^{(V, E)} \\
& \leq \sup _{\mu \in \mathcal{P}(V, E)} \lambda_{p, \mu}^{(V, E)}<\sup _{\mu \in \mathcal{P}(V, E), f_{*} \in \mathcal{F}} F\left(\mu, f_{*}\right)<\infty
\end{aligned}
$$

Since $\mathcal{G}(L, N)$ is a finite set, the above lemma implies the following theorem.
Theorem 18.7. For $p \geq 1$,

$$
0<\inf _{(V, E) \in \mathcal{G}(L, N), \mu \in \mathcal{P}(V, E)} \tilde{\lambda}_{p, \mu}^{(V, E)} \leq \sup _{(V, E) \in \mathcal{G}(L, N), \mu \in \mathcal{P}(V, E)} \tilde{\lambda}_{p, \mu}^{(V, E)}<\infty
$$

Definition 18.8. Define

$$
\underline{c}_{\lambda}(p, L, N)=\inf _{(V, E) \in \mathcal{G}(L, N), \mu \in \mathcal{P}(V, E)} \widetilde{\lambda}_{p, \mu}^{(V, E)}
$$

and

$$
\bar{c}_{\lambda}(p, L, N)=\sup _{(V, E) \in \mathcal{G}(L, N), \mu \in \mathcal{P}(V, E)} \tilde{\lambda}_{p, \mu}^{(V, E)}
$$

Finally, we study neighbor disparity constants.
Definition 18.9. Define

$$
\begin{aligned}
\mathcal{G}_{\sigma}(L, N)=\left\{\left(V, E, V_{1}, V_{2}\right) \mid(V, E) \in \mathcal{G}(L, N), V_{1}, V_{2}\right. & \subseteq V, V_{1} \neq \emptyset, V_{2}=\emptyset \\
V & \left.=V_{1} \cup V_{2}, V_{1} \cap V_{2} \neq \emptyset\right\}
\end{aligned}
$$

Let $(V, E)$ be a graph and let $\mu \in \mathcal{P}(V, E)$. For $U \subseteq V$ and $f \in \ell(V)$, define

$$
\mu(U)=\sum_{v \in U} \mu(v) \quad \text { and } \quad(f)_{U, \mu}=\frac{1}{\mu(U)} \sum_{v \in U} f(v) \mu(v)
$$

if $\mu(U)>0$. For $\left(V, E, V_{1}, V_{2}\right) \in \mathcal{G}_{\sigma}(L, N), \mu \in \mathcal{P}(V, E)$ and $p \geq 1$, define

$$
\sigma_{p, \mu}^{(V, E)}\left(V_{1}, V_{2}\right)=\sup _{f \in \ell(V), \mathcal{E}_{p}^{(V, E)}(f) \neq 0} \frac{\left|(f)_{V_{1}, \mu}-(f)_{V_{2}, \mu}\right|^{p}}{\mathcal{E}_{p}^{(V, E)}(f)},
$$

and

$$
\mathcal{P}\left(V, E, V_{1}, V_{2}, \kappa\right)=\left\{\mu \mid \mu \in \mathcal{P}(V, E), \mu\left(V_{1}\right) \geq \kappa \mu\left(V_{2}\right) \text { and } \mu\left(V_{2}\right) \geq \kappa \mu\left(V_{1}\right)\right\} .
$$

for $\kappa \in(0,1]$.
Theorem 18.10. For any $p \geq 1, L, N \geq 1$ and $\kappa \in(0,1]$,

$$
\begin{aligned}
& 0<\inf \left\{\sigma_{p, \mu}^{G}\left(V_{1}, V_{2}\right) \mid\left(G, V_{1}, V_{2}\right) \in \mathcal{G}_{\sigma}(L, N), \mu \in \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right)\right\} \leq \\
& \quad \sup \left\{\sigma_{p, \mu}^{G}\left(V_{1}, V_{2}\right) \mid\left(G, V_{1}, V_{2}\right) \in \mathcal{G}_{\sigma}(L, N), \mu \in \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right)\right\}<\infty
\end{aligned}
$$

Proof. First fix $\left(G, V_{1}, V_{2}\right) \in \mathcal{G}_{\sigma}(L, N)$ and fix $\mu_{*} \in \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right)$. Define $\mathcal{F}$ as in the proof of Lemma 18.6 . For any $f \in \ell(V)$, setting $f_{*}=\mathcal{E}_{p}(f)^{-\frac{1}{p}}\left(f-(f)_{\mu_{*}}\right)$, we see that $f_{*} \in \mathcal{F}$ and

$$
\frac{\left|(f)_{V_{1}, \mu}-(f)_{V_{2}, \mu}\right|^{p}}{\mathcal{E}_{p}(f)}=\left|\left(f_{*}\right)_{V_{1}, \mu}-\left(f_{*}\right)_{V_{2}, \mu}\right|^{p}
$$

for any $\mu \in \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right)$. Let $F: \mathcal{F} \times \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right) \rightarrow \mathbb{R}$ by $F(f)=$ $\left|(f)_{V_{1}, \mu}-(f)_{V_{2}, \mu}\right|$. Since $F$ is continuous and $\mathcal{F} \times \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right)$ is compact,

$$
\begin{aligned}
0<\inf _{\mu \in \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right), f \in \mathcal{F}} F(f, \mu) \leq & \inf _{\mu \in \mathcal{P}\left(G, V_{1}, V_{2}\right)} \sigma_{p, \mu}^{G}\left(V_{1}, V_{2}\right) \\
& \leq \sup _{\mu \in \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right), f \in \mathcal{F}} F(f, \mu)=\sup _{\mu \in \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right)} \sigma_{p, \mu}^{G}\left(V_{1}, V_{2}\right)<\infty
\end{aligned}
$$

Now the desired statement follows by the fact that $\mathcal{G}_{\sigma}(L, N)$ is a finite set up to graph isomorphisms.

Definition 18.11. Define

$$
\underline{c}_{\sigma}(L, N, \kappa)=\inf \left\{\sigma_{p, \mu}^{G}\left(V_{1}, V_{2}\right) \mid\left(G, V_{1}, V_{2}\right) \in \mathcal{G}_{\sigma}(L, N), \mu \in \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right)\right\}
$$

and

$$
\bar{c}_{\sigma}(L, N, \kappa)=\sup \left\{\sigma_{p, \mu}^{G}\left(V_{1}, V_{2}\right) \mid\left(G, V_{1}, V_{2}\right) \in \mathcal{G}_{\sigma}(L, N), \mu \in \mathcal{P}\left(G, V_{1}, V_{2}, \kappa\right)\right\}

## 19 Modification of the structure of a graph

In the original work of Kusuoka-Zhou [36], they used a subgraph of $\left(T_{n}, E_{n}^{*}\right)$ to define their version of $\mathcal{E}_{2}^{m}$ in the case of the Sierpinski carpet. Namely, in our terminology, their subgraph is

$$
E_{n}^{1}=\left\{(u, v) \mid(u, v) \in E_{1}^{*}, \operatorname{dim}_{H}\left(K_{v} \cap K_{u}\right)=1\right\}
$$

and their energy is

$$
\mathcal{E}_{p}^{1, n}(f)=\frac{1}{2} \sum_{(u, v) \in E_{n}^{1}}|f(u)-f(v)|^{p}
$$

for $f \in \ell\left(T_{n}\right)$. (They only consider the case $p=2$.) Our theory in this paper works well if we replace our energy $\mathcal{E}_{p}^{n}$ with Kusuoka-Zhou's energy $\mathcal{E}_{p}^{1, n}$ because they are uniformly equivalent, i.e. there exist $c_{1}, c_{2}>0$ such that

$$
c_{2} \mathcal{E}_{p}^{n}(f) \leq \mathcal{E}_{p}^{1, n}(f) \leq c_{2} \mathcal{E}_{p}^{n}(f)
$$

for any $n \geq 1$ and $f \in \ell\left(T_{n}\right)$. More generally, if we replace our graph $\left(T_{n}, E_{n}^{*}\right)$ with a subgraph $\left(T_{n}, E_{n}\right)$ satisfying the conditions (A) and (B) below, all the results in this paper remain true except for changes in the constants.

The conditions (A) and (B) are;
(A) $G_{n}=\left(T_{n}, E_{n}\right)$ is a connected graph for each $n$ having the following properties:
(i) If $(w, v) \in E_{n}$, then $K_{w} \cap K_{v} \neq \emptyset$.
(ii) If $(w, v) \in E_{n}$ for $n \geq 1$, then $\pi(w)=\pi(v)$ or $(\pi(w), \pi(v)) \in E_{n-1}$.
(iii) If $(w, v) \in E_{n}$ for $n \geq 1$, then there exist $w_{1} \in S(w)$ and $v_{1} \in S(v)$ such that $\left(w_{1}, w_{2}\right) \in E_{n+1}$.
(iv) For any $n \geq 0$ and $w, v \in T_{n}$ with $K_{w} \cap K_{v} \neq \emptyset$, there exist $w(0), \ldots, w(k) \in$ $\Gamma_{1}(w)$ satisfying $w(0)=w, w(k)=v$ and $(w(i), w(i+1)) \in E_{n}$ for any $i=$ $0, \ldots, k-1$.
(B) For any $w \in T$, the graphs $\left(S^{n}(w), E_{n+|w|}^{S^{n}(w)}\right.$ ) associated with the partition $T(w)$ of $K_{w}$ satisfies the counterparts of conditions (i), (ii), (iii) and (iv) of (3).

Naturally, the graph $\left(T_{n}, E_{n}^{*}\right)$ satisfied the conditions (A) and (B).

## 20 Open problems

In the final section, we gather some of open problems and future directions of research.

1. Regularity of $\mathcal{W}^{p}$ for $p \in\left[1, \operatorname{dim}_{A R}(K, d)\right]$; As we have already mentioned, it is not known whether or not $C(K) \cap W^{p}$ is dense in $\mathcal{W}^{p}$ for $p \in\left[1, \operatorname{dim}_{A R}(K, d)\right]$. The first step should be to establish an elliptic Harnack principle for $p$-harmonic functions on approximating graphs and/or the limiting object $\left(\mathcal{W}^{p}, \widehat{\mathcal{E}}_{p}(\cdot)+\|\right.$. $\left.\|_{p, \mu}\right)$. Even in the case of $p=2$, this problem is open except for the case of generalized Sierpinski carpets. The conjecture presented in the introduction is closely related to this problem as well.
2. Construction of $p$-form and $p$-Laplacian: In this paper, we have constructed a $p$-energy $\widehat{\mathcal{E}}_{p}(f)$ but not a $p$-form $\widehat{\mathcal{E}}_{p}(f, g)$. On a graph $G=(V, E)$, if we define

$$
\mathcal{E}_{p}(f, g)=-\sum_{x \in V}\left(\Delta_{p} f\right)(x) g(x)
$$

for $f, g \in \ell(V)$, where $\Delta_{p}$ is the $p$-Laplacian defined by

$$
\begin{aligned}
\Phi_{p}(t) & = \begin{cases}|t|^{p-2} t & \text { if } t \neq 0 \\
0 & \text { if } t=0,\end{cases} \\
\left(\Delta_{p} f\right)(x) & =\sum_{y \in V,(x, y) \in E} \Phi_{p}(f(y)-f(x)),
\end{aligned}
$$

then it follows that

$$
\mathcal{E}_{p}(f)=\frac{1}{2} \sum_{(x, y) \in E}|f(x)-f(y)|^{p}=\mathcal{E}_{p}(f, f)
$$

As a natural counterpart, we expect to have a $p$-form $\widehat{\mathcal{E}}_{p}(f, g)$ which is linear in $g$, satisfies $\widehat{\mathcal{E}}_{p}(f)=\widehat{\mathcal{E}}_{p}(f, f)$ for any $f \in \mathcal{W}^{p}$, and has an expression such as

$$
\mathcal{E}_{p}(f, g)=-\int_{K}\left(\Delta_{p} f\right)(x) g(x) \mu(d x)
$$

3. $p$-energy measure: In the case $p=2$, there is the notion of energy measures associated with a strongly local regular Dirichlet form $(\mathcal{E}, \mathcal{F})$, where $\mathcal{E}$ is the
form and $\mathcal{F}$ is the domain. Roughly speaking, the energy measure $\mu_{f}$ associated with $f \in \mathcal{F}$ is a positive Radon measure satisfying

$$
\int_{X} u(x) d \mu_{f}(d x)=2 \mathcal{E}(u f, f)-\mathcal{E}\left(f^{2}, u\right)
$$

for any $u \in \mathcal{F} \cap C_{0}(X)$. See [19] for details. So, what is a counterpart of this in the case of $\widehat{\mathcal{E}}^{p}$ ? Is there any natural measure $\mu_{f}$ for $f \in \mathcal{W}^{p}$ such that

$$
\int_{K} d \mu_{f}(d x)=\widehat{\mathcal{E}}_{p}(f) ?
$$

For $\mathbb{R}^{n}$, the answer is yes and $\mu_{f}=|\nabla f|^{p} d x$. For the planar Sierpinski carpet, this problem has already been studied in 41. However, we know almost nothing beyond those examples.
4. Fractional Korevaar-Shoen type expression: As we have already mentioned, a fractional Korevaar-Shoen type expression of $\mathcal{W}^{p}$ has already shown in 41 in the case of the planar Sierpinski carpet. Namely, we have

$$
\mathcal{W}^{p}=\left\{f \mid f \in L^{p}(K, \mu), \limsup _{r \downarrow 0} \int_{K} \frac{1}{r^{\alpha_{H}}} \int_{B_{d_{*}}(x, r)} \frac{|f(x)-f(y)|^{p}}{r^{\beta_{p}}} d x d y<\infty\right\} .
$$

and it is shown in 41 that $\beta_{p}>p$ for any $p>1$. How about other cases? Suppose that Assumption 2.15 holds and $\mu$ is $\alpha_{H}$-Ahlfors regular with respect to the metric $d$. Then we expect that $\beta_{p}=\alpha_{H}+\tau_{p}$ and we know $\alpha_{H}+\tau_{p} \geq p$ by [34, (4.6.14)]. Now our questions are:

- Do we have a fractional Korevaar-Shoen type expression as above?
- When does $\beta_{p}>p$ hold? (Apparently, if $K=[-1,1]^{L}$, then $\beta_{p}=p$.)

Related question is
If $\beta_{p}=p$, then does $\mathcal{W}^{p}$ coincide with any of the Sobolev type spaces given by approaches using upper gradients?
5. Without local symmetry: In Sections 11, 12, 13 and 14 , we have shown the conductive homogeneity of self-similar sets having local symmetry, which helped us to extend a path from one piece of $K_{w}$ to neighbors by the reflection in its boundaries. However, the local symmetry does not seem indispensable for having conductive homogeneity. Intuitively the essence should be the balance of conductances in different directions, for example, the vertical and the horizontal directions for square-based self-similar sets. Unfortunately, we have not had any example without local symmetry yet except for finitely ramified cases.

## A Basic inequalities

The next two lemmas can be deduced from the Hölder inequality.

Lemma A.1. For $p \in(0, \infty)$,

\left|\sum_{i=1}^{n} a_{i}\right|^{p} \leq \max \left\{1, n^{p-1}\right\} \sum_{i=1}^{n}\left|a_{i}\right|^{p}
$$

for any $n \geq 1$ and $a_{1}, \ldots, a_{n} \in \mathbb{R}$.
Lemma A.2. Let $p, q \in[1, \infty]$ satisfying $\frac{1}{p}+\frac{1}{q}=1$. Then for any $n \in \mathbb{N}$ and $a_{1}, \ldots, a_{n} \in \mathbb{R}$,

$$
\left(\sum_{i=1}^{n}\left|a_{i}\right|^{q}\right)^{1 / q} \leq \max \left\{1, n^{(p-2) / p}\right\}\left(\sum_{i=1}^{n}\left|a_{i}\right|^{p}\right)^{1 / p}
$$

The following fact implies the comparison (15.4) of two types of Poincaré constants, $\lambda_{p, m}$ and $\widetilde{\lambda}_{p, m}$.

Theorem A. 3 ([9, Lemma 4.17]). Let $\mu$ be a finite measure on a set $X$. Then for any $f \in L^{p}(X, \mu)$ and $c \in \mathbb{R}$,

$$
\|f-c\|_{p, \mu} \geq \frac{1}{2}| | f-(f)_{\mu} \|_{p, \mu}
$$

where $\|\cdot\|_{p, \mu}$ is the $L^{p}$-norm with respect to $\mu$ and $(f)_{\mu}=\mu(X)^{-1} \int_{X} f d \mu$.
The following lemma is a discrete version of the above theorem.
Corollary A.4. Let $\left(\mu_{i}\right)_{i=1, \ldots, n} \in(0,1)^{n}$ with $\sum_{i=1}^{n} \mu_{i}=1$. Then

$$
\sum_{i=1}^{n}\left|x-a_{i}\right|^{p} \mu_{i} \geq\left(\frac{1}{2}\right)^{p} \sum_{i=1}^{n}\left|\sum_{j=1}^{n} \mu_{j} a_{j}-a_{i}\right|^{p} \mu_{i}
$$

for any $x, a_{1}, \ldots, a_{n} \in \mathbb{R}$.

## B Basic facts on $p$-energy

Let $G=(V, E)$ be a finite graph. For $A \subseteq V$, set $E_{A}=\{(x, y) \mid x, y \in A,(w, y) \in$ $E\}$ and $G_{A}=\left(A, E_{A}\right)$.
Definition B.1. Let $\mu: V \rightarrow(0, \infty)$ and let $A \subseteq V$. Define $\operatorname{supp}(\mu)=\{x \mid x \in$ $V, \mu(x)>0\}$. Let $p>0$. For $u \in \ell(V)$, define

$$
\begin{aligned}
\mathcal{E}_{p}^{G}(u) & =\frac{1}{2} \sum_{(x, y) \in E}|u(x)-u(y)|^{p} \\
\|u\|_{p, \mu} & =\left(\sum_{x \in V}|u(x)|^{p} \mu(x)\right)^{1 / p} \\
(u)_{\mu} & =\frac{1}{\sum_{y \in V} \mu(y)} \sum_{x \in V} \mu(x) u(x)
\end{aligned}
$$

and

$$
\lambda_{p, \mu}^{G}=\sup _{u \in \ell(V), u \neq 0} \frac{\left(\min _{c \in \mathbb{R}}\left\|u-c \chi_{V}\right\|_{p, \mu}\right)^{p}}{\mathcal{E}_{p}^{G}(u)}
$$

where $\chi_{V} \in \ell(V)$ is the characteristic function of the set $V$.
For $A \subseteq U$, set

$$
\mathcal{E}_{p}^{A}=\mathcal{E}_{p}^{G_{A}} \quad \text { and } \quad \lambda_{p, \mu}^{A}=\lambda_{p,\left.\mu\right|_{A}}^{G_{A}} .
$$

Lemma B.2. Define

$$
\widetilde{\lambda}_{p, \mu}^{G}=\sup _{u \in \ell(V), u \neq 0} \frac{\left(\left\|u-(u)_{\mu} \chi_{V}\right\|_{p, \mu}\right)^{p}}{\mathcal{E}_{p}^{G}(u)}
$$

Then

$$
\left(\frac{1}{2}\right)^{p} \widetilde{\lambda}_{p, \mu}^{G} \leq \lambda_{p, \mu}^{G} \leq \widetilde{\lambda}_{p, \mu}^{G}
$$

Proof. By Corollary A. 4
$\sum_{x \in V}\left|u(x)-(u)_{\mu}\right|^{p} \mu(x) \geq \min _{c \in \mathbb{R}} \sum_{x \in V}|u(x)-c|^{p} \mu(x) \geq\left(\frac{1}{2}\right)^{p} \sum_{x \in V}\left|u(x)-(u)_{\mu}\right|^{p} \mu(x)$.

Lemma B. 3 ([36, (1.5) Prop.-(2)]). Let $p \in[1, \infty)$ and let $\mu: V \rightarrow(0, \infty)$. Assume that $A \subseteq B \subseteq V$. Then for any $u \in \ell(B)$,

\left|(u)_{A}-(u)_{B}\right| \leq \frac{1}{\mu(A)^{\frac{1}{p}}}\left(\widetilde{\lambda}_{p, \mu}^{B} \mathcal{E}_{p}^{B}(u)\right)^{\frac{1}{p}}
$$

Proof. By the Hölder inequality,

$$
\left|(u)_{A}-(u)_{B}\right| \leq \frac{1}{\mu(A)} \int_{B} \chi_{A}\left|u-(u)_{B}\right| d \mu \leq \frac{1}{\mu(A)^{\frac{1}{p}}}\left(\int_{B}\left|u-(u)_{B}\right|^{p} d \mu\right)^{\frac{1}{p}}
$$

## C Useful facts on combinatorial modulus

In this appendix, we have useful facts on combinatorial modulus. In particular, the last lemma, Lemma C. 4 , is a result on the comparison of moduli in two different graphs. This lemma plays a key role on several occasions in this paper.

Let $V$ be a countable set and let $\mathcal{P}(V)$ be the power set of $V$. For $\rho: V \rightarrow$ $[0, \infty)$ and $A \subseteq V$, define

$$
L_{\rho}(A)=\sum_{x \in A} \rho(x)
$$

For $\mathcal{U} \subseteq \mathcal{P}(V)$, define

$$
\mathcal{A}(\mathcal{U})=\left\{\rho \mid \rho: V \rightarrow[0, \infty), L_{\rho}(A) \geq 1 \text { for any } A \in \mathcal{U}\right\}
$$

Moreover for $\rho: V \rightarrow[0, \infty)$, define

$$
M_{p}(\rho)=\sum_{x \in V} \rho(x)^{p}
$$

and

$$
\operatorname{Mod}_{p}(\mathcal{U})=\inf _{\rho \in \mathcal{A}(\mathcal{U})} M_{p}(\rho) .
$$

Note that if $\mathcal{U}=\emptyset$, then $\mathcal{A}(\mathcal{U})=[0, \infty)^{V}$ and $\operatorname{Mod}_{p}(\mathcal{U})=0$.
Lemma C.1. Assume that $\mathcal{U}$ consists of finite sets. Then there exists $\rho_{*} \in \mathcal{A}(\mathcal{U})$ such that

$$
\operatorname{Mod}_{p}(\mathcal{U})=M_{p}\left(\rho_{*}\right)
$$

Proof. Choose $\left\{\rho_{i}\right\}_{i \geq 1} \subseteq \mathcal{A}(\mathcal{U})$ such that $M_{p}\left(\rho_{i}\right) \rightarrow \operatorname{Mod}_{p}(\mathcal{U})$ as $i \rightarrow \infty$. Since $V$ is countable, there exists a subsequence $\left\{\rho_{n_{j}}\right\}_{j \geq 1}$ such that, for any $v \in V$, $\rho_{n_{j}}(v)$ is convergent as $j \rightarrow \infty$. Set $\rho_{*}(p)=\lim _{j \rightarrow \infty} \rho_{n_{j}}(p)$. For any $A \in \mathcal{U}$, since $A$ is a finite set, it follows that $L_{\rho_{*}}(A) \geq 1$. Hence $\rho_{*} \in \mathcal{A}(\mathcal{U})$. For any $\epsilon>0$, there exists a finite set $X_{\epsilon}$ such that $\sum_{v \in X_{\epsilon}} \rho_{*}(v)^{p} \geq M_{p}\left(\rho_{*}\right)-\epsilon$. As

$$
\operatorname{Mod}_{p}(\mathcal{U})=\lim _{j \rightarrow \infty} M_{p}\left(\rho_{n_{j}}\right) \geq \lim _{j \rightarrow \infty} \sum_{v \in X_{\epsilon}} \rho_{n_{j}}(v)^{p}
$$

we obtain $\operatorname{Mod}_{p}(\mathcal{U}) \geq M_{p}\left(\rho_{*}\right)-\epsilon$ for any $\epsilon>0$. Hence $\operatorname{Mod}_{p}(\mathcal{U}) \geq M_{p}\left(\rho_{*}\right)$. On the other hand, since $\rho_{*} \in \mathcal{A}(\mathcal{U})$, we see $M_{p}\left(\rho_{*}\right) \geq \operatorname{Mod}_{p}(\mathcal{U})$. Therefore $M_{p}\left(\rho_{*}\right)=\operatorname{Mod}_{p}(\mathcal{U})$.

Lemma C.2. Assume that $\mathcal{U}$ consists of finite sets. For $v \in V$, define $\mathcal{U}_{v}=$ $\{A \mid A \in \mathcal{U}, v \in A\}$. Then

$$
\rho_{*}(v)^{p} \leq \operatorname{Mod}_{p}\left(\mathcal{U}_{v}\right)
$$

for any $\rho_{*} \in \mathcal{A}(\mathcal{U})$ with $M_{p}\left(\rho_{*}\right)=\operatorname{Mod}_{p}(\mathcal{U})$. In particular, if $\mathcal{U}_{v}=\emptyset$, then $\rho_{*}(v)=0$.

Proof. Suppose that $\rho_{*} \in \mathcal{A}(\mathcal{U})$ and $M_{p}\left(\rho_{*}\right)=\operatorname{Mod}_{p}(\mathcal{U})$. Assume that $\mathcal{U}_{v}=\emptyset$ and $\rho_{*}(v)>0$. Define $\rho_{*}^{\prime}$ by

$$
\rho_{*}^{\prime}(u)= \begin{cases}\rho_{*}(u) & \text { if } u \neq v \\ 0 & \text { if } u=v\end{cases}
$$

Then $\rho_{*}^{\prime} \in \mathcal{A}(\mathcal{U})$ and $M_{p}\left(\rho_{*}^{\prime}\right)<M_{p}\left(\rho_{*}\right)$. This contradicts the fact that $M_{p}\left(\rho_{*}\right)=$ $\operatorname{Mod}_{p}(\mathcal{U})$. Thus if $\mathcal{U}_{v}=\emptyset$, then $\rho_{*}(v)=0$. Next assume that $\mathcal{U}_{v} \neq \emptyset$. Let $\rho_{v} \in \mathcal{A}\left(\mathcal{U}_{v}\right)$ with $M_{p}\left(\rho_{v}\right)=\operatorname{Mod}_{p}\left(\mathcal{U}_{v}\right)$. Note that such a $\rho_{v}$ does exist by Lemma C.1. Define

$$
\tilde{\rho}(u)= \begin{cases}\max \left\{\rho_{*}(u), \rho_{v}(u)\right\} & \text { if } u \neq v \\ \rho_{v}(v) & \text { if } u=v\end{cases}
$$

Let $A \in \mathcal{U}$. If $v \notin A$, then $\tilde{\rho} \geq \rho_{*}$ on $A$, so that $\tilde{\rho} \in \mathcal{A}(A)$. If $v \in A$, then $\tilde{\rho} \geq \rho_{v}$ on $A$ and hence $\tilde{\rho} \in \mathcal{A}(A)$. Thus we see that $\tilde{\rho} \in \mathcal{A}(\mathcal{U})$. Therefore,
$\operatorname{Mod}_{p}(\mathcal{U}) \leq M_{p}(\tilde{\rho}) \leq \sum_{u \neq v} \rho_{*}(u)^{p}+\sum_{u \in V} \rho_{v}(u)^{p}=\operatorname{Mod}_{p}(\mathcal{U})-\rho_{*}(v)^{p}+\operatorname{Mod}_{p}\left(\mathcal{U}_{v}\right)$.

Define $\ell_{+}(V)=\{f \mid f: V \rightarrow[0, \infty)\}$.
Lemma C.3. Let $V_{1}$ and $V_{2}$ be finite sets. Let $\mathcal{U}_{i} \subseteq \mathcal{P}\left(V_{i}\right)$ for $i=1,2$. If there exist maps $\xi: \mathcal{U}_{2} \rightarrow \mathcal{U}_{1}, F: \ell_{+}\left(V_{1}\right) \rightarrow \ell_{+}\left(V_{2}\right)$ and constants $C_{1}, C_{2}>0$ such that

$$
C_{1} L_{F(\rho)}(\gamma) \geq L_{\rho}(\xi(\gamma)) \quad \text { and } \quad M_{p}(F(\rho)) \leq C_{2} M_{p}(\rho)
$$

for any $\rho \in \ell_{+}\left(V_{1}\right)$ and $\gamma \in \mathcal{U}_{2}$, then

$$
\operatorname{Mod}_{p}\left(\mathcal{U}_{2}\right) \leq\left(C_{1}\right)^{p} C_{2} \operatorname{Mod}_{p}\left(\mathcal{U}_{1}\right)
$$

for any $p>0$.
Proof. Note that $C_{1} F(\rho) \in \mathcal{A}\left(\mathcal{U}_{2}\right)$ for any $\rho \in \mathcal{A}\left(\mathcal{U}_{1}\right)$. Hence if $F^{\prime}(\rho)=C_{1} F(\rho)$, then

$$
\begin{aligned}
\operatorname{Mod}_{p}\left(\mathcal{U}_{2}\right)=\min _{\rho \in \mathcal{A}\left(\mathcal{U}_{2}\right)} M_{p}(\rho) & \leq \min _{\rho \in \mathcal{A}\left(\mathcal{U}_{1}\right)} M_{p}\left(F^{\prime}(\rho)\right) \\
& \leq\left(C_{1}\right)^{P} C_{2} \min _{\rho \in \mathcal{A}\left(\mathcal{U}_{1}\right)} M_{p}(\rho)=\left(C_{1}\right)^{P} C_{2} \operatorname{Mod}_{p}\left(\mathcal{U}_{1}\right) .
\end{aligned}
$$

Lemma C.4. Let $V_{1}$ and $V_{2}$ be countable sets and let $\mathcal{U}_{i} \subseteq \mathcal{P}\left(V_{i}\right)$ for $i=1,2$. Assume that $H_{v} \subseteq V_{1}$ and $\#\left(H_{v}\right)<\infty$ for any $v \in V_{2}$. Furthermore, assume that, for any $B \in \mathcal{U}_{2}$, there exists $A \in \mathcal{U}_{1}$ such that $A \subseteq \cup_{v \in B} H_{v}$. Then

$$
\operatorname{Mod}_{p}\left(\mathcal{U}_{2}\right) \leq \sup _{v \in V_{2}} \#\left(H_{v}\right)^{p} \sup _{u \in V_{1}} \#\left(\left\{v \mid v \in V_{2}, u \in H_{v}\right\}\right) \operatorname{Mod}_{p}\left(\mathcal{U}_{1}\right)
$$

for any $p>0$.
Proof. For $\rho: V_{1} \rightarrow \mathbb{R}$, define

$$
F(\rho)(v)=\max _{u \in H_{v}} \rho(u)
$$

for any $v \in V_{2}$. Then $F: \ell_{+}\left(V_{1}\right) \rightarrow \ell_{+}\left(V_{2}\right)$ and

$$
\begin{aligned}
M_{p}(F(\rho))=\sum_{v \in V_{2}} \max _{u \in H_{v}} \rho(u)^{p} \leq \sum_{v \in V_{2}} & \sum_{u \in H_{v}} \rho(u)^{p} \\
& \leq \sup _{u \in V_{1}} \#\left(\left\{v \mid v \in V_{2}, u \in H_{v}\right\}\right) M_{p}(\rho) .
\end{aligned}
$$

On the other hand, for $B \in \mathcal{U}_{2}$, choose $\xi(B) \in \mathcal{U}_{1}$ such that $\xi(B) \subseteq \cup_{v \in B} H_{v}$. Then for any $\rho \in \ell_{+}\left(V_{1}\right)$ and $B \in \mathcal{U}_{2}$,

$$
\begin{aligned}
& \sup _{u \in V_{2}} \#\left(H_{u}\right) L_{B}(F(\rho)) \geq \sum_{u \in B} \#\left(H_{u}\right) F(\rho)(u) \geq \sum_{u \in B} \sum_{v \in H_{u}} \rho(v) \\
&=\sum_{v \in \cup_{u \in B} H_{u}} \#\left(\left\{u \mid v \in H_{u}\right\}\right) \rho(v) \geq \sum_{v \in \xi(B)} \rho(v)=L_{\xi(B)}(\rho) .
\end{aligned}
$$

Hence by Lemma C.3, we have the desired conclusion.

## D An Arzelà-Ascoli theorem for discontinuous functions

The following lemma is a version of Arzelà-Ascoli theorem showing the existence of a uniformly convergent subsequence of a sequence of functions. The difference between the original version and the current one is that it can handle a sequence of discontinuous functions.

Lemma D. 1 (Extension of Arzelà-Ascoli). Let $\left(X, d_{X}\right)$ be a totally bounded metric space and let $\left(Y, d_{Y}\right)$ be a metric space. Let $u_{i}: X \rightarrow Y$ for any $i \geq 1$. Assume that there exist a monotonically increasing function $\eta:[0, \infty) \rightarrow[0, \infty)$ and a sequence $\left\{\delta_{i}\right\}_{i \geq 1} \in[0, \infty)$ such that $\eta(t) \rightarrow 0$ as $t \downarrow 0, \delta_{i} \rightarrow 0$ as $i \rightarrow \infty$ and

$$
\begin{equation*}
d_{Y}\left(u_{i}\left(x_{1}\right), u_{i}\left(x_{2}\right)\right) \leq \eta\left(d_{X}\left(x_{1}, x_{2}\right)\right)+\delta_{i} \tag{D.1}
\end{equation*}
$$

for any $i \geq 1$ and $x_{1}, x_{2} \in X$. If $\overline{\cup_{i \geq 1} u_{i}(X)}$ is compact, then there exists a subsequence $\left\{u_{n_{j}}\right\}_{j \geq 1}$ such that $\left\{u_{n_{j}}\right\}_{j \geq 1}$ converges uniformly to a continuous function $u: X \rightarrow Y$ as $j \rightarrow \infty$ satisfying $d_{Y}\left(u\left(x_{1}\right), u\left(x_{2}\right)\right) \leq \eta\left(d_{X}\left(x_{1}, x_{2}\right)\right)$ for any $x_{1}, x_{2} \in X$.

Proof. Since $X$ is totally bounded, there exists a countable subset $A \subseteq X$ which is dense in $X$ and contains a finite $\tau$-net $A_{\tau}$ of $X$ for any $\tau>0$. Let $K=\overline{\bigcup_{i \geq 1} u_{i}(X)}$. Since $K$ is compact and $\left\{u_{i}(x)\right\}_{i \geq 1} \subseteq K$ is bounded for any $x \in A$, there exists a subsequence $\left\{u_{m_{k}}(x)\right\}_{k \geq 1}$ converging as $k \rightarrow \infty$. By the standard diagonal argument, we may find a subsequence $\left\{u_{n_{j}}\right\}_{j \geq 1}$ such that $\left\{u_{n_{j}}(x)\right\}_{j \geq 1}$ converges as $j \rightarrow \infty$ for any $x \in A$. Set $v_{j}=u_{n_{j}}$ and $\alpha_{j}=\delta_{n_{j}}$. Define $v(x)=\lim _{j \rightarrow \infty} v(x)$ for any $x \in A$. By (D.1),

$$
d_{Y}\left(v_{j}\left(x_{1}\right), v_{j}\left(x_{2}\right)\right) \leq \eta\left(d_{X}\left(x_{1}, x_{2}\right)\right)+\alpha_{j}
$$

for any $x_{1}, x_{2} \in A$. Letting $j \rightarrow \infty$, we see that

$$
\begin{equation*}
d_{Y}\left(v\left(x_{1}\right), v\left(x_{2}\right)\right) \leq \eta\left(d_{X}\left(x_{1}, x_{2}\right)\right) \tag{D.2}
\end{equation*}
$$

for any $x_{1}, x_{2} \in A$. Since $A$ is dense in $X, v$ is extended to a continuous function on $X$ satisfying (D.2) for any $x_{1}, x_{2} \in X$. Fix $\epsilon>0$. Choose $\tau>0$ such that
$\eta(\tau)<\epsilon / 3$. Since the $\tau$-net $A_{\tau}$ is a finite set, there exists $k_{0}$ such that if $k \geq k_{0}$, then $\alpha_{k}<\epsilon / 3$ and $d_{Y}\left(v(z), v_{k}(z)\right)<\epsilon$ for any $z \in A_{\tau}$. Let $x \in X$ and choose $z \in A_{\tau}$ such that $d_{X}(x, z)<\tau$. If $k \geq k_{0}$, then

$$
\begin{aligned}
& d_{Y}\left(v_{k}(x), v(x)\right) \leq d_{Y}\left(v_{k}(x), v_{k}(z)\right)+d_{Y}\left(v_{k}(z), v(z)\right)+d_{Y}(v(z), v(x)) \\
& \leq 2 \eta\left(d_{X}(x, z)\right)+\alpha_{k}+d_{Y}\left(v_{k}(z), v(z)\right)<2 \epsilon .
\end{aligned}
$$

Thus $\left\{v_{j}\right\}_{j \geq 1}$ converges uniformly to $v$ as $j \rightarrow \infty$.

## E Geometric properties of strongly symmetric self-similar sets

In this appendix, we will give proofs of claims on topological and geometric properties of self-similar sets treated in Section 14. Namely we will give proofs of Propositions 14.2 and 14.4 . First we recall the setting of Section 14 . Let $S$ be a finite subset of $\mathbb{R}^{L}$ and let $\rho \in(0,1)$. Let $U_{q} \in O(L)$ for any $q \in S$. Define $f_{q}: \mathbb{R}^{L} \rightarrow \mathbb{R}^{L}$ by

$$
f_{q}(x)=\rho U_{q}(x-q)+q
$$

for $x \in \mathbb{R}^{L}$. Let $K$ be the self-similar set with respect to $\left\{f_{q}\right\}_{q \in S}$, i.e. $K$ is the unique non-empty compact set $K$ satisfying

$$
K=\bigcup_{q \in S} f_{q}(K)
$$

The triple $\left(K, S,\left\{f_{q}\right\}_{q \in S}\right)$ is know to be a self-similar structure defined in Definition 9.1 and the map $\chi: S^{\mathbb{N}} \rightarrow K$ is given by

$$
\left\{\chi\left(q_{1} q_{2} \ldots\right)\right\}=\bigcap_{m \geq 0} f_{q_{1} \ldots q_{m}}(K)
$$

as we have seen in Section 9
Definition E.1. (1) Define $\widetilde{\sigma}: S^{\mathbb{N}} \rightarrow S^{\mathbb{N}}$ by $\widetilde{\sigma}\left(q_{1} q_{2} \ldots\right)=q_{2} q_{3} \ldots$ for $q_{1} q_{2} \ldots \in$ $S^{\mathbb{N}}$.
(2) Define

$$
C_{K}=\bigcup_{i \neq j \in S} K_{i} \cap K_{j}, \quad \mathcal{C}=\chi^{-1}\left(C_{K}\right), \quad \mathcal{P}=\bigcup_{k \geq 1} \tilde{\sigma}^{k}(\mathcal{C})
$$

and $V_{0}=\chi(\mathcal{P}) . \mathcal{C}$ and $\mathcal{P}$ are called the critical set and the post critical set of ( $K, S,\left\{f_{q}\right\}_{q \in S}$ ) respectively. A self-similar structure $\left(K, S,\left\{f_{q}\right\}_{q \in S}\right)$ is said to be post critically finite (p.c.f. for short) if $\mathcal{P}$ is a finite set.

By [29, Theorem 1.2.3], we have the following proposition.
Proposition E.2. The map $\chi$ is continuous and surjective. Moreover,

$$
\begin{equation*}
\chi\left(q_{1} q_{2} \ldots\right)=f_{q_{1}}\left(\chi\left(\widetilde{\sigma}\left(q_{1} q_{2} \ldots\right)\right)\right) \tag{E.1}
\end{equation*}
$$

for any $q_{1} q_{2} \ldots \in S^{\mathbb{N}}$.

In this appendix, we suppose that Assumption 14.1 holds.
The next lemma gives a proof of Proposition 14.2 .
Lemma E.3. Under Assumption 14.1, we have
(1) For any $i=1, \ldots, N, \chi^{-1}(q)=\bar{q}$, where $\bar{q}=q q q \ldots \in S^{\mathbb{N}}$.
(2) $\mathcal{P}=\{\bar{q} \mid q \in U\}$. In particular, a self-similar structure $\left(K, S,\left\{f_{q}\right\}_{q \in S}\right)$ is post critically finite and $V_{0}=U$.

Proof. (1) Suppose $\chi\left(\tau_{1} \tau_{2} \ldots\right)=q$. Then by (E.1),

$$
q=\chi\left(\tau_{1} \tau_{2} \ldots\right)=f_{\tau_{1}}\left(\chi\left(\tau_{2} \tau_{3} \ldots\right)\right) \in K_{\tau_{1}}
$$

By Assumption 14.1.(1), it follows that $\tau_{1}=q$. Since $f_{q}$ is invertible, we see that $\chi\left(\tau_{2} \tau_{3} \ldots\right)=q$. Using the same argument as above, we see that $\tau_{2}=q$ as well. Thus we deduce that $\tau_{k}=q$ for any $k \in \mathbb{N}$ inductively.
(2) Suppose that $\chi\left(\tau_{1} \tau_{2} \ldots\right) \in f_{\tau_{1}}(K) \cap f_{q}(K)$ for some $q \neq \tau_{1}$. By E.1), it follows that $\chi\left(\tau_{1} \tau_{2} \ldots\right)=f_{\tau_{1}}\left(\chi\left(\tau_{2} \tau_{3} \ldots\right)\right)$. Hence by Assumption 14.1-(2),

$$
\chi\left(\tau_{2} \tau_{3} \ldots\right) \in\left(f_{\tau_{1}}\right)^{-1}\left(f_{\tau_{1}}(K) \cap f_{q}(K)\right) \subseteq U
$$

Thus $\tau_{2} \tau_{3} \ldots=\overline{q^{\prime}}$ for some $q^{\prime} \in U$. Therefore, $\mathcal{P} \subseteq U$.
Conversely, again by Assumption $14.1(2)$, for any $q \in U$, there exist $p_{1}, p_{2} \in S$ with $p_{1} \neq p_{2}$ such that $\chi\left(p_{1} \bar{q}\right) \in f_{p_{1}}(K) \cap f_{p_{2}}(K)$. This shows that $p_{1} \bar{q} \in \mathcal{C}$ and hence $\bar{q} \in \mathcal{P}$.

In the next two lemmas, we are going to show a sufficient condition for Assumption 14.3 .

Lemma E.4. Suppose that Assumption 14.1 holds and that $U_{q}$ is the identity map for any $q \in V_{0}$. Let $q=f_{p_{1}}\left(q_{1}\right)=f_{p_{2}}\left(q_{2}\right)$ for some $p_{1}, p_{2} \in S$ with $p_{1} \neq p_{2}$ and $q_{1}, q_{2} \in V_{0}$. Then there exists $\gamma=\gamma\left(p_{1}, p_{2}, q_{1}, q_{2}\right)>0$ such that

$$
d\left(\overline{K_{p_{1}} \backslash K_{p_{1}\left(q_{1}\right)^{m-1}}}, K_{p_{2}}\right) \geq \gamma \rho^{m}
$$

for any $m \geq 1$, where $d(A, B)=\inf _{x \in A, y \in B}|x-y|$ and $(q)^{k}=\underset{k-\text {-times }}{q \ldots q} \in T_{k}$.
In the following proof, we assume that

$$
\#\left(f_{p_{1}}(K) \cap f_{p_{2}}(K)\right) \leq 1
$$

to avoid a non-essential complication of arguments. Without this assumption, the lemma is still true with a technical modification of the proof.

Proof. Set $c_{m}=\inf \left\{d\left(K_{w}, K_{v}\right) \mid w, v \in T_{m}, K_{w} \cap K_{v}=\emptyset\right\}$. Define

$$
X_{m}=\overline{K_{p_{1}} \backslash K_{p_{1}\left(q_{1}\right)^{m-1}}} \text { and } Y_{m}=\overline{K_{p_{1} q_{1}} \backslash K_{p_{1}\left(q_{1}\right)^{m-1}}}
$$

for $m \geq 1$. Then $X_{m}=Y_{m} \cup\left(\cup_{q \neq q_{1}} K_{p_{1} q}\right)$ and $K_{p_{2}}=K_{p_{2} q_{2}} \cup\left(\cup_{q \neq q_{2}} K_{p_{2} q}\right)$. This implies that

$$
d\left(X_{m}, K_{p_{2}}\right) \geq \min \left\{d\left(Y_{m}, K_{p_{2} q_{2}}\right), c_{2}\right\}
$$

On the other hand, letting $f(x)=\rho(x-q)+q$, we see that $Y_{m} \cup K_{p_{2} q_{2}}=$ $f\left(X_{m-1} \cup K_{p_{2}}\right)$. This yields $d\left(Y_{m}, K_{p_{2} q_{2}}\right)=\rho d\left(X_{m-1}, K_{p_{2}}\right)$. Consequently, we have

$$
d\left(X_{m}, K_{p_{2}}\right) \geq \min \left\{\rho d\left(X_{m-1}, K_{p_{2}}\right), c_{2}\right\}
$$

Now inductive argument suffices.
Lemma E.5. Suppose that Assumption 14.1 holds and that $U_{q}$ is the identity map for any $q \in V_{0}$. Then Assumption 14.3 holds.

Remark. According to the notation in the proof of Lemma E.4 this lemma claims $c_{m} \geq c \rho^{m}$ for any $m \geq 1$.

Proof. Suppose that $w, v \in T_{m}$ and $K_{w} \cap K_{v}=\emptyset$. Let $w=w_{1} \ldots w_{m}$ and let $v=v_{1} \ldots v_{m}$. In case $w_{1}=w_{2}$, then

$$
d\left(K_{w}, K_{v}\right)=\rho d\left(K_{w_{2} \ldots w_{m}}, K_{v_{2} \ldots v_{m}}\right) \geq c_{m-1} \rho^{m}
$$

Otherwise, assume that $w_{1} \neq v_{1}$. If $K_{w_{1}} \cap K_{v_{1}}=\emptyset$, then $d\left(K_{w}, K_{v}\right) \geq c_{1}$. So, the remaining possibility is that $w_{1}=v_{1}$ and $K_{w_{1}} \cap K_{v_{1}} \neq \emptyset$. In this case let $q=K_{w_{1}} \cap K_{v_{1}}$. Then $q=f_{w_{1}}\left(p_{j_{1}}\right)=f_{w_{2}}\left(p_{j_{2}}\right)$ for some $j_{1}, j_{2} \in\{1, \ldots, L\}$. By Lemma E.4 it follows that

$$
d\left(K_{w}, K_{v}\right) \geq \bar{\gamma} \rho^{m}
$$

where $\bar{\gamma}=\min \left\{\gamma\left(p_{1}, p_{2}, q_{1}, q_{2}\right) \mid p_{1}, p_{2} \in S, q_{1}, q_{2} \in V_{0}, f_{p_{2}}\left(q_{1}\right)=f_{p_{1}}\left(q_{2}\right)\right\}$. Combining all the cases, we see that

$$
c_{m} \geq \min \left\{c_{m-1}, \gamma, c_{1} \rho^{-m}\right\} \geq \min \left\{c_{1}, \gamma\right\}
$$

for any $m \geq 1$.
Now we start showing Proposition 14.4 that is, Assumption 2.15 hold under Assumptions 14.1 and 14.3 .

Lemma E.6. Under Assumptions 14.1 and 14.3 , Assumption 2.15-(2) holds with $r=\rho, M_{*}=1$, and $d=d_{*}$, where $d_{*}$ is the restriction of the Euclidean metric.

Proof. The condition (2A) is obvious. Set

$$
\Gamma_{1, n}(x)=\bigcup_{\substack{w \in T_{n} \\ x \in K_{w}}} \Gamma_{1}(w)
$$

for $x \in K$ and $n \geq 1$. Then for any $v \in T_{n} \backslash \Gamma_{1, n}(x)$, there exists $w \in T_{n}$ such that $x \in K_{w}$ and $K_{w} \cap K_{v}=\emptyset$. By Lemma E.5, we see that $d\left(K_{w}, x\right) \geq c \rho^{n}$ and hence $B_{d_{*}}\left(x, c r^{n}\right) \cap K_{v}=\emptyset$. Thus we have

$$
\begin{equation*}
B_{d_{*}}\left(x, c \rho^{n}\right) \subseteq U_{1}(x: n) . \tag{E.2}
\end{equation*}
$$

On the other hand, by (2A), there exists $c^{\prime}>0$ such that $\operatorname{diam}\left(K_{w}, d_{*}\right) \leq c^{\prime} \rho^{|w|}$ for any $w \in T$. This implies

$$
\begin{equation*}
U_{1}(x: n) \subseteq B_{d_{*}}\left(x, 3 c^{\prime} \rho^{n}\right) \tag{E.3}
\end{equation*}
$$

So we have (2B). Choose $x_{0} \in K \backslash V_{0}$ and choose $m_{0} \in \mathbb{N}$ such that $2 \rho^{m_{0}}<$ $d\left(x_{0}, V_{0}\right)$. Let $w \in T_{n}$ and let $u \in \Gamma_{1, m_{0}+n}\left(f_{w}\left(x_{0}\right)\right)$. Suppose that $u \in T(v)$ for some $v \in T_{n}$ with $v \neq w$. Since $u \in \Gamma_{1, m_{0}+n}\left(f_{w}\left(x_{0}\right)\right)$, there exists $u_{0} \in T_{n+m_{0}}$ such that $f_{w}\left(x_{0}\right) \in K_{u_{0}}$ and $K_{u_{0}} \cap K_{u} \neq \emptyset$. Let $y \in K_{u}$. Since $K$ is connected (and hence arcwise connected by [29, Theorem 1.6.2]), there exists a continuous curve $\zeta:[0,1] \rightarrow K_{u_{0}} \cup K_{u}$ such that $\zeta(0)=x$ and $\zeta(1)=y$. Note that $x \in K_{w}$ and $y \in K_{v}$. By (14.3), the curve $\zeta$ intersects with $f_{w}\left(V_{0}\right)$. Therefore, $\left(K_{u} \cup K_{u_{0}}\right) \cap f_{w}\left(V_{0}\right) \neq \emptyset$. However, since $\operatorname{diam}\left(K_{u}, d_{*}\right)=\operatorname{diam}\left(K_{u_{0}}, d_{*}\right)=$ $\rho^{m_{0}+n}$, it follows

$$
d\left(f_{w}\left(x_{0}\right), K_{u} \cup K_{u_{0}}\right) \leq 2 \rho^{m_{0}+n}<d\left(f_{w}\left(x_{0}\right), f_{w}\left(V_{0}\right)\right)
$$

so that $\left(K_{u_{0}} \cup K_{u}\right) \cap f_{w}\left(V_{0}\right)=\emptyset$. This contradiction shows that $u \in T(w)$ and hence $U_{1}\left(f_{w}\left(x_{0}\right): m_{0}+n\right) \subseteq K_{w}$. By (E.2), we see that

$$
B_{d_{*}}\left(f_{w}\left(x_{0}\right), c \rho^{m_{0}+n}\right) \subseteq U_{1}\left(f_{w}\left(x_{0}\right): m_{0}+n\right) \subseteq K_{w}
$$

This shows (2C).
Next set $\alpha_{H}=-\log N / \log \rho$. Note that $\rho^{\alpha_{H}}=N^{-1}$. Let $\mu$ be the selfsimilar measure on $K$ with weight $\left(\rho^{\alpha_{H}}, \ldots, \rho^{\alpha_{H}}\right)$. By [31, Theorem 1.2.7], we see that $\mu\left(K_{w}\right)=\rho^{|w|}$ for any $w \in T$ and consequently $\mu(\{x\})=0$ for any $x \in K_{w}$. These facts show that $\mu$ satisfies Assumption 2.12. Moreover, we have the following proposition.

Proposition E.7. Under Assumptions 14.1 and 14.3. there exist $c_{1}, c_{2}>0$ such that

$$
\begin{equation*}
c_{1} s^{\alpha_{H}} \leq \mu\left(B_{d_{*}}(x, s)\right) \leq c_{1} s^{\alpha_{H}} \tag{E.4}
\end{equation*}
$$

for any $s \in[0,1]$. In particular, $\mu$ is $\alpha_{H}$-Ahlfors regular with respect to $d_{*}$ and the Hausdorff dimension of $\left(K, d_{*}\right)$ equals $\alpha_{H}$.

Proof. By E.3, for any $x \in K$ and $n \geq 1$, if $w \in \Gamma_{1, n}(x)$, then

$$
\begin{equation*}
\left(\rho^{n}\right)^{\alpha_{H}}=\mu\left(K_{w}\right) \leq \mu\left(B_{d_{*}}\left(x, 3 c^{\prime} \rho^{n}\right)\right. \tag{E.5}
\end{equation*}
$$

On the other hand, by [31, Proposition 1.6.11], there exists $J_{*} \in \mathbb{N}$ such that

$$
\begin{equation*}
\#\left(\Gamma_{1, n}(x)\right) \leq J_{*} \tag{E.6}
\end{equation*}
$$

for any $x \in T$ and $n \geq 0$. (Note that $\Lambda_{\rho^{n}, x}^{1}$ defined in [31, Definition 1.3.3] equals $\Gamma_{1, n}(x)$.) Therefore by (E.2),

$$
\begin{equation*}
\mu\left(B_{d_{*}}\left(x, c \rho^{n}\right)\right) \leq \sum_{v \in \Gamma_{1, n}(x)} \mu\left(K_{v}\right) \leq J_{*}\left(\rho^{n}\right)^{\alpha_{H}} \tag{E.7}
\end{equation*}
$$

Combining (E.5) and (E.7), we obtain (E.4).

The following proposition is immediately deduced from the previous propositions and lemmas. Note that $\Gamma_{1}(w) \subseteq \Gamma_{1, n}(x)$ for any $w \in T$ and $x \in K_{w}$. Hence by (E.6), we see that the partition $\left\{K_{w}\right\}_{w \in T}$ is uniformly finite.

Proposition E.8. [Proposition 14.4 Under Assumptions 14.1 and 14.3 , Assumption 2.15 holds with $r=\rho, \bar{d}=d_{*}$ and $M_{*}=M_{0}=1$.

The fact that $M_{0}=1$ is due to the second remark after Assumption 2.6.
